Two held over bribery charges in Kamrup

GUWAHATI, April 22: Directorate of Vigilance and Anti-Corruption (DVAC), Assam on Monday apprehended lot mandal for allegedly demanding bribe for the Marjari related works, said an official statement.

The lot mandal identified as Anup Kumar Choudhury posted at the office of circle officer, Nagarbera Revenue Circle in Kamrup district. "A complaint was received at this DVAC alleging that Anup Kumar Choudhury, lot mandal of office of the Circle Officer, Nagarbera Revenue Circle of Kamrup district in conspiracy with Hajarst Ali, gaon pradhan of Khameri gaon, had demanded ₹ 15,000 as bribe from the complainant for Marjari related works," the statement added.

The statement further claimed that unwilling to pay the bribe, the complainant approached this Directorate for taking necessary legal action against the abovementioned public servants.

#### More than 2,000 criminal cases against MPs, MLAs decided in 2023: SC told

NEW DELHI, April 22: Special courts for trial of criminal cases related to Members of Parliament and Members of Legislative Assembly decided more than 2,000 cases in 2023, the Supreme Court has been in-

In an affidavit filed by senior advocate Vijay Hansaria, who has been appointed amicus curiae in a PIL seeking expeditious disposal of criminal cases against MPs/MLAs, said that more directions are needed for speedy adjudication of pending trials and their investigation under strict monitoring by the respective high courts, as there are around 501 candidates with criminal cases who are contesting the Lok Sabha elections in the first two phases.

Referring to a report of NGO 'Association of Democratic Reforms for the Lok Sabha elections 2024 Phase I and Phase II,' Hansaria, assisted by advocate Sneha Kalita, said that out of 2,810 candidates (Phase I - 1618 candidates and Phase II - 1192 candidates), 501 (18 per cent) candidates have criminal cases against them, out of which, 327 (12 PC) (*CONTD. ## Third phase of polls in Assam: Five withdraw nominations 47 candidates in fray for four LS seats

GUWAHATI, April 22: Altogether 47 candidates are in the fray for the four Lok Sabha constituencies that will go to polls in the third and final phase in Assam on May 7, an official statement said on Mon-

Five candidates -- three in Kokrajhar and two in Dhubri -withdrew their nominations on the last day, it said.

Among the 47 candidates, highest number of 14 will be contesting from Barpeta seat, followed by 13 in Dhubri, 12 in Kokrajhar and eight in Guwa-

Altogether 52 valid nominations were filed for the four seats of third phase, out of five withdrew their papers.

In the Guwahati constituency, BJP's Bijuli Kalita Medhi is expected to be locked in a direct fight with Congress' Mira Borthakur Goswami, with the saffron party looking to re-

#### Narendra Modi has eliminated terrorism from country: HM

RAIPUR, April 22: Union home minister Amit Shah on Monday asserted the Narendra Modi government has eliminated terrorism from the country as he issued a stern warning to Naxalites in Chhattisgarh, asking them to surrender or else they will be rooted out from the state in two years

He said in the last four months alone, 90 Naxalites were neutralised in Chhattisgarh under the BJP government, comments coming after 29 Maoists were gunned down by security forces in an encounter in Kanker, which is part of the Bastar region, on April 16.

Addressing an election rally in Kanker town, around 150km away from the encounter site, four days ahead of the second round of Lok Sabha polls, Shah took on the Congress and asked party MP Rahul Gandhi to explain what four generations of his family have done for the

## 'More power, direct funding of TTAADC by Centre; key issues of tripartite agreement'

Motha president Bijoy Kumar Hrangkhawl on Monday said direct funding of the TTAADC by the Centre and giving more powers to the tribal council are the key main issues of the tripartite agreement signed by the party with the central and state government.

Tipra Motha, which was the main opposition party after the Tripura Assembly election 2023, signed an agreement with the Centre and the state government in March 2023 after a series of discussions with Ministry of Home Affairs officials.

Days after signing the agreement, Tipra Motha joined the BJPled government in Tripura.

"Direct funding of the Tripura Tribal Areas Autonomous District Council (TTAADC) by the Centre and empowerment of the autonomous district council are among the major points in the agreement inked with the Centre," Hrangkhawl told PTI.

The direct funding to the autonomous council (TTAADC) by the Centre is a long pending demand of political parties, he said.

"We want the tribal council to have its own police organization to be headed by Additional DGP or IGP rank officer, land rights so that the TTAADC could issue pattas to the people as part of empowerment



process," he said.

"If we implement these issues in accordance with the agreement, the indigenous people will notice something good is going to happen for them," he said.

Hrangkhawl said the Motha will insist that the Centre announce a joint working group to take forward the tripartite agreement after the Lok Sabha election.

"We wish Tipra Motha chief Pradyot Kishore Manikya Debbarma be made chairman of the proposed joint working group comprising representatives from the Centre and the state government to meet the aspirations of the indigenous people", he said.

Asked why Tipra Motha chose BJP as an ally, he said, "We believe only the Union government could address our problem - constitucan address our problems. The double-engine government also attracted Tipra Motha."

To a query on the difference between the accord signed by Tripura National Volunteers (TNV) an outlawed group with the Centre in 1988 and the present one, Hrangkhawl said the TNV accord was signed following an intense arms struggle while the tripartite agreement (CONTD. ON PAGE-2)

NEW DELHI, April 22: Nalin Prabhat, a 1992-batch IPS officer, on Monday took charge as the new director general (DG) of federal counter-terrorism and counter-hijack commando force NSG.

Prabhat, 55, was handed over the traditional baton of the 'black cats' force by IPS officer Daljit Singh Chawdhary at the National Security Guard (NSG) headquarters here.

Chawdhary had been handling the additional charge of the NSG DG since March.

The new DG is a three-time police gallantry medal winner and has headed the specialised anti-Naxal police force 'Greyhounds' of Andhra Pradesh, his cadre state.

He is the 25th DG of the NSG, which was raised in 1984 as a federal counter-terrorist force to undertional guarantee for the rights of indigenous people. ## Sustained growth of 7 pc feasible for India: RBI MPC member Shashanka Bhide

NEW DELHI, April 22: Sustaining the economic growth momentum of 7 per cent in 2024-25 and beyond is feasible on the back of favorable monsoon, higher farm productivity and improved global trade, RBI Monetary Policy Committee (MPC) member Shashanka Bhide said on Monday.

During 2023-24, the economy is likely to record a growth rate of near 8 per cent on account of good performance of manufacturing and infrastructure sectors.

"(India's economic) Growth in the current year is likely to be supported by agriculture with a favourable monsoon and improved global trade. Sustaining the growth momentum of 7 per cent seems feasible," he told PTI.

Bhide further said that in the long-term, the need for productivity improvements will remain the key factor to achieve food price stability. Asked what are some of the headwinds he is wary of, Bhide said one area of concern is the global environment

"The slow pace of recovery in global demand on one hand and supply chain disruptions on the other hand... if the ongoing geopolitical conflicts are not resolved

weather events on output," he said. Recently, the International Monetary Fund (IMF) raised India's growth projection to 6.8 per cent for 2024 from its January forecast of 6.5 per cent citing bullish domestic demand conditions and a rising working-age population.

The Asian Development Bank (ADB) also raised India's GDP growth forecast for the current fiscal to 7 per cent from 6.7 per cent earlier, saying the robust growth will be driven by public and private sector investment demand and gradual improvement in consumer demand.

Asked what is the long-term solution for high food prices, Bhide noted that one aspect of high food inflation in the recent years has been the impact of weather conditions on the perishable commodities such as vegetables.

According to him, although such price spikes may be short-term, their impact is significant.

As many have pointed out, Bhide said processing and preservation of commodities that help in their storage would be a part of the solution in the longer term, just as the supply-side measures that help raise crop resistance to adverse

weather. While noting that the investments in market infrastructure, modernisation of markets for agricultural commodities to help improve supply response to changing demand conditions would also reduce the excessive price spikes, he said. "In the long-term, the need for productivity improvements will remain the key factor to achieve food price stability.

The eminent economist observed that inflation has remained above the policy target for several countries. "There are also differences in the growth conditions, with some countries experiencing significant slowdown while some experiencing reasonable positive momentum," he said, adding that the priority towards bringing down inflation rate to the target appears to be keeping the monetary policies restrictive.

RBI Governor Shaktikanta Das has recently said the baseline projections show inflation moderating to 4.5 per cent in 2024-25 from 5.4 per cent in 2023-24 and 6.7 per cent in 2022-23. (PTI)

He was referring to the previous Congress rule and the alleged involvement of former CM Baghel in the Mahadev betting app scam. Highlighting the state BJP government's success in tacking Naxal insurgency after assuming office in December, Shah pointed out that in the last four months, 90 Naxalites were neutralised in the state. While 123 Naxalites were arrested, 250 others surrendered (during this period), he added.

Under Modi's leadership, Naxalism has been eliminated from states like Andhra Pradesh, Telangana, Bihar, Jharkhand and Madhya Pradesh, the Home Minister said. "Elect Modi ji for a third term and the menace (of Naxalism) will be rooted out from Chhattsigarh in two years," he asserted. "As long as there is Naxalism, tribal brothers and sisters will not have access to electricity, schools, ration shops and hospitals. I would like to tell them (Naxalites) to surrender, otherwise the result of the fight is certain. We will finish them. We will root out them from Chhattisgarh," he said. The Home Minister hit out at the Congress, saying the grand old party believes minorities have the first right over the country's resources, while the BJP firmly feels this right belongs to the poor, adivasis, Dalits and backwards. Recently, the Congress party got offended when the PM spoke about its manifesto and asked why it wanted to conduct a survey of properties of all citizens, the senior BJP leader said.

"I want to ask the Congress whether its manifesto mentions a survey or not? Rahul baba should make it clear. Their PM Manmohan Singh had said (in 2006) the minority has first right over the resources not adivasis and Dalits. But we say the poor, adivasi, Dalit and backward have first right to over the resources of the country. They (Congress) have eyes on 'math' (monastic institution), mandir and properties of everyone and where this money will go?" he added. Taking a dig at the opposition INDIA bloc over the clash that occurred during its Ranchi rally in Jharkhand, Shah said if they can't keep their own house in order, then how will they maintain unity in the country?

"Elect Modi ji for a third time and the country will become the third largest economy in the world," he emphasised. Shah noted that after being in a tent for 500 years, Ram Lala celebrated his birthday on Ram Navami on April 17 in the grand temple at Ayodhya inaugurated in January. "Ever since the Ram temple was demolished, crores of people have sacrificed their lives. Many people were martyred with the hope Ram Lala would be installed in his temple one day, but for years, the Congress kept on raising questions over Ram Lala's birthplace.

"After Modi ji became PM for a second term, he laid the foundation stone (in 2020) of Ram Mandir (in Ayodhya) and then presided over its (idol) consecration ceremony," Shah said. The former BJP president lashed out at the Congress for not attending the consecration ceremony. "Congress leaders were invited but they did not attend the consecration ceremony just for vote-bank politics," he said.

Shah maintained the Modi government is committed to the development of Chhattisgarh, where the BJP came to power in December 2023 after a five-year Congress rule. "During the Sonia-Manmohan government (2004-2014 UPA rule), only ₹77,000 crore was given to Chhattisgarh, but Modi ji has given ₹3,20,000 crore in the last ten years. Besides, funds were given for construction of roads, airports and laying railway lines,' the BJP leader noted. Shah said Modi has resolved to make India a developed nation by 2047, and tribals. Later, in the same trap operation, Choudhury was also apprehended for demanding the bribe and accepting it through the gaon pradhan, in conspiracy with him. "In this connection, a case has been registered in ACB Police Station," the statement concluded.

#### More than 2,000 criminal

are serious criminal cases (punishable with imprisonment of 5 years and more).

"The same was the position in 2019 Lok Sabha elections in which out of 7928 candidates, 1500 candidates 19%) had criminal cases, out of which 1070 candidates (13%) were serious criminal cases. However, out of 514 elected members of 17th Lok Sabha (2019-2024), 225 members (44%) had criminal cases against them.

"Thus, the candidates with criminal cases have won more seats than candidates without criminal cases. In is context, it is necessary that this court may pass further orders for expeditious disposal of pending trial and investigation under strict monitoring by the respective high courts," the affidavit said.

Hansaria, who is assisting the court in the PIL filed by Ashwini Upadhyay for speedy disposal of cases against the lawmakers, said, "It may be noted that in view of the direction issued by this court in the present proceedings, the steps taken by the respective high courts, and expeditious hearing by the special court MP/MLA, more than 2000 cases have been decided in the year 2023. However, a large number of cases are pending, and many of them are for a long period." He gave a tabular chart based on the information received from different high courts, under which as on January 1, 2023 there were 4,697 criminal cases against the lawmakers and 2,018 cases were decided last year. The affidavit said 1,746 fresh criminal cases were filed in 2023 against the MPs/MLAs and therefore total of 4,474 cases remain pending as on January 1, 2024.

The maximum, 766 cases out of 1,300, as on January 1, 2023 were adjudicated by the special courts in Uttar Pradesh. Delhi, which had 105 cases at the start of last year, disposed of 103 cases by December 31, 2023.

Some of the big states, like Maharashtra, decided 232 cases out of 476 cases against MPs/MLAs as on January , 2023, West Bengal 13 out of 26, Gujarat 30 out of 48, Karnataka 150 out of 226, Kerala 132 out of 370, and Bihar decided 171 cases out of 525 cases. Hansaria said though a number of cases are decided, a large number of cases are still pending trial for a long period. "It is thus necessary that the High Court may call for a report from the presiding officers of the Special Court MP/MLA of all those cases which are pending for 3 or more years with reason for long pendency along with a copy of the order sheet of last one year.

"It may be clarified that only a copy of the order sheet is to be sent and not the entire case file so that the trial is not affected. The High Court may thereafter, pass appropriate orders on micro examination of each case with a positive direction that a trial may be completed within one year," he said.

He sought direction from the apex court for creating a model website on the pattern of National Judicial Data Grid for uploading of real time information on the progress of the trial of cases against lawmakers.(PTI)

#### Ather energy CEO observes rising preference for premium vehicles

Moreover, Mehta stressed that this shift is not exclusive to metropolitan hubs like Bangalore, Delhi, or Mumbai but is reflective of a nationwide phenomenon. Consumers in Tier-2 and Tier-3 cities are also exhibiting similar aspirations and purchas-

ing behaviors, highlighting a broader societal trend towards prioritizing quality and premium features in their purchases. This shift underscores the imperative for companies to adapt their strategies to align with the evolving preferences of Indian con Mehta's remarks serve as a

clarion call for businesses to focus on catering to the needs of a consumer base increasingly inclined towards premium offerings. By doing so, companies can position themselves strategically to capitalize on the burgeoning opportunities emerging from this market shift, ensuring sustained growth and relevance in the dynamic landscape of India's two-wheeler sector.

## Asian shares shrug off Wall St blues as China leaves lending rate unchanged

BANGKOK, April 22: Markets in Asia apart from Shanghai's were broadly higher Monday, shrugging off the blues on Wall Street after big technology stocks logged their worst week since the COVID crash in 2020.

Oil prices fell while US futures advanced.

Hong Kong's Hang Seng led the region, gaining 1.8 per cent to 16,516.63. But the Shanghai Composite index shed 0.4 per cent to 3,051.76 after the People's Bank of China kept its 1-year and 5-year loan prime rates unchanged.

Tokyo's Nikkei 225 added 1 per cent to 37,438.61 and the yen weakened further. The US dollar rose to 154.76 ven from 154.59 yen, trading at levels not seen since

The Kospi in South Korea jumped 1.3 per cent to 2,626.55. Australia's S&P/ASX 200 surged 0.9 per cent to 7,638.30.

On Friday, the S&P 500 dropped 0.9 per cent to close out its third straight losing week. It ended at 4,967.23, which is 5.5 per cent below its record set late last month.

That's its longest such streak since September, before it broke into a romp that sent it to a string of records this year. The Dow Jones Industrial Average rose 0.6 per cent to 37,986.40, and the Nasdag composite fell 2 per cent to 15.282.01. The market's worst performers included several stocks that had been its biggest stars.



Super Micro Computer lost more than a fifth of its value, dropping 23.1 per cent. The company, which sells server and storage systems used in AI and other computing, had soared nearly 227 per cent for the year coming into the day.

Nvidia, another stock that has surged to dizzying heights due to Wall Street's frenzy around artificial-intelligence technology, also gave up some of its big recent gains. It slumped 10 per cent and was the heaviest single weight on the S&P 500, by far, because of its huge size.

Tech stocks in the S&P 500 broadly lost 7.3 per cent this week for their worst performance since March 2020 as some global giants reported discouraging trends. ASML, a Dutch company that's a major supplier to the semiconductor industry, reported weaker-thanexpected orders for the start of 2024, for example.

The larger threat was a dawning, dispiriting acknowledgement sweeping Wall Street that interest rates may likely stay high for longer. Top Fed officials said this week that they could hold interest rates at their high level for a while. That's a letdown for traders after the Fed had signalled earlier that three cuts to interest rates could be possible this year.

High rates hurt prices for all kinds of investments. Some of the hardest hit tend to be those seen as the most expensive and which make investors wait the longest for big growth, which can make tech stocks vulnerable.

Fed officials are adamant that they want to see additional proof inflation is heading down toward their 2 per cent target before lowering the Fed's main interest rate, which is at its highest level since Because interest rates look un-

likely to offer much help in the near term, companies are under even more pressure to deliver growth in profits.

Netflix sank 9.1 per cent despite reporting stronger profits for the latest quarter than expected. Analysts called it a mostly solid performance, but the streaming giant disappointed some investors by saying it will stop giving updates on its subscriber numbers every three months, beginning next year.

Helping to limit the market's losses was American Express, which rose 6.2 per cent. It reported stronger profit for the latest quarter than analysts expected. Fifth Third Bancorp rose 5.9 per cent after it likewise topped expectations.

In the oil market, US benchmark crude oil shed 92 cents to USD 81.30 per barrel in electronic trading on the New York Mercantile Exchange. It gained 12 cents on Friday, to USD 82.22 per barrel.

A barrel of Brent crude gave up 95 cents to USD 86.35 per barrel. On Friday, it pulled back to USD 87.29 after briefly leaping above USD 90 overnight on worries about fighting in the Middle East. Iranian troops fired air defences at a major air base and a nuclear site during an apparent Israeli drone attack, raising worries in the market. But crude prices pared their gains as traders questioned how Iran would respond. (AP)

With the withdrawal of three candidates from the Kokrajhar Lok Sabha,1 2 candidates are in fray for the Kokrajhar Lok Sabha constituency, the elections to which will be held on May 7.

Earlier, 16 candidates had filed nominations for the Kokrajhar Lok Sabha constituency. Meanwhile, sitting MP Naba Kumar Sarania's candidature was rejected by the returning officer due to invalid ST caste certificate.

#### TMC in Assam elections

n the lead-up to the Assam elections, the Trinamool Congress (TMC) under the leadership of West Bengal Chief Minister Ma-Lmata Banerjee had embarked on an ambitious campaign to challenge the dominance of the Bharatiya Janata Party (BJP) in the state. However, recent developments have highlighted the uphill battle the TMC faces in making significant inroads. Despite highprofile rallies and efforts to project itself as a credible alternative to the BJP, the TMC suffered a setback with the resignation of two prominent leaders in Hailakandi district. ### Maryam Nawaz has set the right tone for improving India-Pak relations

ost a tumultuous national election in Pakistan, a diplomatic overture from this western neighbour towards India was being awaited. And now that it has come, even though from an unlikely quarter, it is welcome.

For even though it is not from the Pak foreign minister, the source of its issuance is certainly the power behind the throne. An olive branch was extended towards India when Maryam Nawaz, chief minister of Punjab spoke to about 3000 Sikh pilgrims at Kartarpur Sahib

recently. As she invoked the cultural and linguistic commonalities on both sides of the border that exists between India and Pakistan, the message ought to have travelled far beyond the ears of the men and women who had gathered at a place of worship they had heard much about. Indeed it was more for the knowledge and information of the mandarins of the Ministry of external affairs in New Delhi...

For it emanated right from the lips of Maryam Nawaz. She is not only the chief minister of Punjab, but also the heir apparent of three time Pakistan prime minister, and Pakistan Muslim League (Nawaz) chief Nawaz Sharif.

The Punjab chief minister speaking of friendship with India, religious tolerance and celebrating Eid, Holi and Baisakhi together is a leader of substance. Her pedigree apart, she heads Pakistan's largest province and much of this country's political, cultural and military elite is Punjabi.

So Maryam is ideally suited to speak for her country. Hard economic and geo-political realities which Pakistan faces lies behind her words. She has made her appeal at a most opportune moment for Pakistan, Rawalpindi and Islamabad are faced with increasingly restive borders with Afghanistan and Iran. The Pak army too is looking for stability in the eastern front. A less than belligerent India will be only too welcome by the force which calls the shots in Pakistan.

In this backdrop, Maryam's words should be marked. In fact, her appeal should not be dismissed as emotional outpourings. A look at the stumbling blocks in the bilateral ties reveals abrogation of Article 370, has been Pakistan's source of objection on the Kashmir issue. It will get India nowhere by shouting from the rooftops that the 'abrogation" is an internal matter and Pakistan has no business to discuss about it.

It was part and parcel of Pakistan's foreign policy to raise read tangle in the Kashmir issue. Even if it has got it nowhere except some rabble rousing, come elections. The present government has not acquired enough traction to dissociate from it. President Asif Ali Zardari, Prime Minister Shehbaz Sharif and the Army (not quite on this order) have voiced similar sentiments on Kashmir.

Terrorism for India and Kashmir for Pakistan remain both sides' core concerns. Some quiet back channel diplomacy is the need of the hour. It may restore trade relations, perhaps a low-hanging diplomatic fruit but a break through all the same. An example may be cited that way back in 2014, Pakistan showed interest in importing power from India. It came in the wake of the then Pakistan prime minister's visit. the previous year. Of late, Pakistan's Foreign Minister Muhammad Ishaq Dar said "Pakistan businessmen want trade with India".

The nay sayers with long memories may point out that the power deal was scuppered by the Pak army though GAIL was receptive to the idea of supplying gas across Wagha border. A rejoinder may be issued stating that back channel diplomacy has led to 2021 cease fire along the Line of Control which has mostly held.

More than 75 years have gone by after Punjab was divided in 1947. Despite Partition and ears being fought between two countries, many on both sides of the border continue to feel the bond. Common culture and identity constitute Punjabiyat. India is going through its parliamentary elections. Meanwhile, no stone should be left unturned to lay the ground to move the needle forward thereafter. (IPA Service)

## In the second phase on April 26, BJP to meet bigger challenges than first

n the middle of campaign for second phase of Lok Sabha Lelection 2024 scheduled for April 26, a considerable rise in political heat is felt in 13 states where 87 Lok Sabha constituencies are going to poll. The reason being, higher stake for BJP due to INDIA bloc's mounting challenge to their candidates in almost all constituencies. The comparative ease of PM Narendra Modi during the first phase of election campaign, seems to have already disappeared.

Altogether 102 constituencies of 21 states and UTs were scheduled to go to poll on April 19, of which high stake constituencies for BJP were 5 in Assam, 4 in Bihar, 1 in Chhattisgarh, 1 in Jammu and Kashmir, 6 in Madhya Pradesh, 5 in Maharashtra, 12 in Rajasthan, 1 in Tripura, 8 in Uttar Pradesh, and 3 in West Bengal. These are altogether 46 out of which BJP found itself in very close contest in about 20 seats with the INDIA bloc can-

On the basis of the election campaigns in the first and second phase, a pattern has clearly emerged. Closer the possibility of contest, higher the stakes for BJP and INDIA bloc, and larger the number of phases of elections. There seems to be clear link between the number of phases of election in a state, and the corresponding stakes of the BJP. Thus there were only 10 states out of 21 states and UTs in the first phase where BJP had higher stakes.

All these 10 states – Assam, Bihar, Chhattisgarh, Jammu & Kashmir, Madhya Pradesh, Maharashtra, Rajasthan, Tripura, Utter Pradesh, and West Bengal – and in Karnataka, BJP will have even higher stakes than in the first phase. BJP's stakes are most high in Assam, Bihar, Chhattisgarh, Madhya Pradesh, Maharashtra, Uttar Pradesh and West Bengal where there would be elections even in the third phase on May 7, for which last date of fining nominations is April 19, the day on which first

Assam is a high-stake state for BJP where elections for 14 seats are scheduled in first three phases. Five seats will go to poll in the first phase, another 5 in the second phase, and the rest 4 in the third phase. Since INC had established its upper hand in one of the seats in the first phase, and offering closer contests in another two. BJP's stakes have become higher in the second phase of election in Darang-Udalguri, Diphu, Karimganj, Silchar, and Nagaon. There seems to be three cornered contests in all these seats. In Darang-Udalguri, contest is among BJP, INC, Bodoland People's Front (BPF). In Diphu, the contest in among BJP, INC, and Autonomous State Demand Committee (ASDC).

In Karimganj and Nagaon, contest is amon BJP, INC and DEGREE OF THOUGHT nandgaon, AIUDF. By: Dr. Gyan Pathak Silchar, contest is

among BJP, INC, and TMC. Contests are closer than expected in all seats, and hence outcomes are more uncertain. BJP had won Karimganj seat in 2019 by a margin of only 38,389 votes, and the runner up was AIUDF. BJP had also won Silchar by 81,596 votes and runner up was INC candidate. INC seems to have upper hand in even Nagaon. Since Darang-Udalguri and Diphu, are new constituencies as per the delimitation order of 2023, the respective strengths of political parties are untested, however, in both the constituencies INC is lately gaining strength.

In the Hindi heartland state Bihar, remains one of the toughest states for BJP and NDA where elections are scheduled in all seven phases. NDA seems to have gained upper hand in the first phase, but situation becomes tough in the second phase, since INDIA bloc candidates are stronger.

The five seats going to poll in second phase are Kishanganj, Katihar, Purnia, Bhagalpur and Banka. 2019 while JD(U) had won Katihar by a margin of only 57,203 defeating INC candidate. JD(U) had also won Purnia by defeating INC, and Bhagalpur and Banka by defeating RJD candidates. Since JD(U) had first raised hopes among backward classes by getting Castes Census conducted against the will of the BJP, and now backtracking by joining hands with the BJP, OBC voters have become apprehensive against NDA

Now INDIA bloc (INC and RJD) is pitching on Caste Census and respective share of reservation according to their population. OBCs are gravitating towards INDIA bloc candidates, reports indicate.

Chhattisgarh is another Hindi heartland state where three constituencies – Raj-

Mahasamund,

and Kanker - are scheduled election in second phase. BJP had won Kanker by only 6,914 votes in 2019, and Mahasamund by 90,511 votes defeating INC candidates, that too in the height of Pulwama wave. BJP had also won Rajnandgaon seats by 1,11,966 votes.

The recent Vidhan Sabha election 2023 has shown a 5.17 per cent decline of BJP's vote share which came down to only 46.27 per cent as against 42.23 per cent of INC. In one-on-one fight with INC candidates, all these three constituencies are witnessing closer contests making outcome uncertain.

Chhattisgarh is a difficult state for BJP and elections would be held here in three phases, 7 in the last phase. In the first phase, INC seemed to have an upper hand in lone seat Bastar which was scheduled for poll on April 19.

Madhya Pradesh is the third Hindi heartland state, where 6 constituencies are scheduled to poll. These are - Tikamgarh, Damoh, Hoshangabad and Betul. The state

Due to rejection of nomination of SP candidate in Khajuraho seat, which went to the party as per seat sharing with Congress, AIFB is contesting as part of INDIA bloc. All these seats were won by BJP in 2019, and the party seems to have upper hand this time too, but INDIA bloc is still contesting with great zeal.

Rajasthan is fourth Hindi heartland state where 13 seats are going to polls in the second phase which would conclude the election in the state, since 12 were scheduled for poll in the first phase. This is a state where there is very close contest, since difference of share of votes between BJP and INC was only 2.06 per cent in Vidhan Sabha election 2023.

BJP's vote share had come down by 17.38 per cent compared to 2019 election, and hence the state presents a great challenge to the

NDA had won all 25 seats from the state, BJP 24 and RLP 1. RLP has already deserted BJP. NDA is thus running a very high risk of losing several seats in the state. The constituencies scheduled for poll in the state are - Tonk-Sawai Madhopur, Ajmer, Pali, Jodhpur, Barmer, Jalor, Udaipur, Banswara, Chittorgarh, Rajsamand, Bhilwara,

Kota, and Jhalawar-Baran. Another key state having high risk for BJP is Uttar Pradesh, where elections are scheduled in 7 phases. Eight constituencies of Western Uttar Pradesh will be going to poll in the second phase. These are Amroha, Meerut, Baghpat, Ghaziabad, Gautam Buddha Nagar, Bulandshahr, Aligarh and Mathura. INDIA bloc is giving tough fight to BJP in Amroha, Meerut, Baghpat which BJP may find tough to retain. BJP candidates are finding tough challenges in all 26 constituencies in Western Uttar Pradesh though the state BJP leadership is exuding confidence about winning most of the seats. The Congress and SP workers at base level have been opdefeat the BJP candidates.

Karnataka and Kerala are the two states in South India, going to poll in second phase. All the seats 20 seats in Kerala would poll in this phase, where BJP and NDA may not be even be able to open their account. As for Karnataka, half of the Karnataka's 28 seats would poll. BJP has very high stakes since the party had won 25 seats in 2019. BJP and JD(S) are contesting together against the ruling INC in the

BJP is running a very high risk of losing Gulbarga, Koppal, Bellary, while in Chikkodi, Bagalkot, Raichur, Bidar, Haveri, and Devangere the party is facing great challenge in retaining them. Only in Belgaum, Bijapur, Dharwad, Uttar Kannada, and Shimoga, BJP seems to have an edge. BJP had won all these 14 seats in 2019, which seems to be in great trouble this

West Bengal remains most contentious state for BJP, since TMC has been offering them tough fight. Darjeeling, Raiganj, and Balurghat. Will go to polls in the second has. If BJP found it difficult in retaining its Cooch Behar seat in the first phase, it is finding same difficulty in Raiganj and Balurghat. BJP had won Raiganj in 2019 with a margin of only 60,574 and Balurghat by a margin of only 33,293 votes. In Darjeeling, the BJP candidate is facing a party rebel, present MLA of an assembly under the Lok Sabha constituency. This rebel candidate is popular. There is every possibility that he would cut into the votes of the official BJP candi-

BJP will thus have very tough week ahead before second phase of election on April 26. INDIA bloc seems to have an edge in this phase also, as it had an edge in the first phase chiefly on account of South Indian states – in the first phase it was Tamil Nadu, and in the second phase these are Karnataka and Ker-

## Climate finance landscape: Challenges, commitments, and paths forward

The intertwining of the climate crisis with financial turmoil has become glaringly apparent. The brunt of this crisis falls heavily upon developing nations, small island states, and the least developed countries, despite their minimal contribution to the issue. These regions face recurrent onslaughts of climate-induced disasters, a stark consequence of the affluent nations' historical carbon emissions.

More than ten years ago, several affluent nations pledged to generate \$100 billion annually by 2020. This funding was designated to assist developing nations in financing climate action, transitioning away from fossil fuels, and safeguarding their populations against escalating climate-related catastrophes. This commitment was made within the framework of the United Nations Framework Convention on Climate Change (UNFCCC). To date, the objective remains unmet as the collective efforts have fallen short of the target. In 2021, developed nations provided and mobilized a total of \$89.6 billion in climate finance for developing countries, marking a 7.6% uptick from the previous year, as outlined in the OECD's sixth assessment report issued recently.

As time progresses, the repercussions of climate inaction have surged dramatically. Projections indicate that escalating temperatures, intensified rainfall, and more frequent extreme weather events will lead to an annual destruction worth \$38 trillion by mid-century. Additionally, a recent study published in the journal Nature highlights that by 2049, the world could face a staggering 19% permanent average income loss globally due to these climate impacts. Disparities in income reduction are expected, with the United States and Europe facing an approximate 11% decrease, while Africa and South Asia may experience a significantly higher reduction of 22%,

according to the report's findings. In recent decades, the sovereign debt of low and middle-

income nations has soared, climbing to a staggering US\$ 3 trillion. Alarmingly, 93% of the 63 countries identified as most vulnerable to climate change find themselves either in a state of debt distress or at risk of it.

As the International Monetary Fund (IMF) and World Bank convene for their spring meetings in Washington, DC, mounting pressure is evident for the restructuring of debt owed by developing nations. A report released by the Debt Relief for Green and Inclusive Recovery project underscores the urgency, revealing that 47 emerging and developing countries confront the prospect of insolvency within the next five years if they intensify their efforts toward climate and development objectives.

Simon Stiell, the executive secretary of UNFCCC, hi lights the immense challenge governments face in prioritizing investments in renewables or climate resilience amidst depleted treasury resources. With debt servicing surpassing health expenditures, the inability to acquire new loans, and the looming threat of poverty, the situation is dire. Experts assert that this sovereign debt crisis impedes the ability of the global south to embark on a just transition to a greener economy, emphasizing the urgent need for trillions of dollars in funding. The upcoming U.N. climate summit scheduled for November in Baku, Azerbaijan, marks a pivotal moment for nations to unite and establish a New and Collective Quantified Goal on Climate Finance (NCOG). This financial commitment holds paramount importance as the climate pledges of numerous developing countries hinge on its provision. According to recent UN analysis, these conditional promises, known as Nationally Determined Contributions (NDC), could significantly influence the trajectory of global warming, potentially making the difference between a 2.4°C and 2.2°C increase by the century's end.

Acknowledging the glaring insufficiency of the \$100 billion benchmark, India has urged developed nations to step up

and commit a minimum of \$1 trillion annually to support developing countries as part of the negotiations for the NCQG on climate finance. These discussions are currently underway at a pivotal UNFCCC meeting in Colombia this month. India's proposal outlines a timeframe of 10 years, with distinct annual mobilization targets for each five-year period, aligning with the cycles of updating the Nationally Determined Contributions

Climate finance can originate from either direct contributions between countries or via intermediaries such as major international financial institutions (IFIs), including multilateral development banks (MDBs) like the Asian Development Bank or the European Investment Bank. Notably, around 40% of the climate finance disbursed by developed nations has been channeled through these multilateral institutions.

Over the years, international financial institutions (IFIs) have faced criticism for falling short in addressing the magnitude of global challenges. Calls for reform of these entities have intensified, aiming to align the distributed funds more closely with climate aspirations, especially in developing nations. A recent G20 report proposed that multilateral development banks (MDBs) could substantially boost their lending by "several hundreds of billions of dollars" in the foreseeable future. Additionally, experts advocate for the alignment of MDB activities with the Paris Agreement, emphasizing the need for these institutions to gradually divest from fossil fuel infrastructure investments. The Climate Policy Initiative's recent report, "Global Landscape of Climate Finance 2023," suggests that although challenging, closing the climate funding gap is theoretically feasible. This is particularly evident when considering the vast sums allocated to global military spending, estimated at \$2.2 trillion in 2022, or the substantial \$11.7 trillion in emergency fiscal measures announced worldwide in 2020 in response to the COVID-19 pandemic. ## Bangladesh makes decisive moves against Kuki-Chin ARMED struggle

he Bangladesh government has garnered significant experience in countering insurgency activities in the Chattogram Hill Tracts (CHT). Through operations like 'Operation Dabanal' the Bangladesh Armed Forces have effectively neutralized separatist armed groups. After the peace treaty, to date, 'Operation Uttaron' has aimed to uphold law and order and improve the living standards of the Jumma people. With over two decades of such operations, the resurgence of another insurgency movement in that particular region would be a daydream if not wild dream. The Kuki Chin community, rooted in the Sino-Tibetan Bawm origin, comprises members of the same tribes who are known by different names and live in close proximity to the borders of Bangladesh, Myanmar, and India.

Their pursuit of autonomy and cultural recognition is historically grounded. Initiatives such as the Chin Hills Regulation of 1896 in Burma and agreements like the Panglong Conference Agreement of 1947 and the Mizoram Peace Accord of 1986 aimed to recognize the unique identity and autonomy of the Kuki-Chin community but remain unfulfilled. The ZO Reunification Organization's advocacy for reunifying Kuki-Chin and Mizo tribes underscores the challenges faced by displaced individuals across these regions.

The emergence of Kuki-Chin armed groups has introduced further complexity to the geopolitical landscape in this region. Global powers exploit internal grievances

and regional conflict dynamics with Kuki-Chin groups to achieve their geostrategic interests. Western powers have a keen interest in the mineral-rich "Golden Triangle" famed for this hilly range. The United States has expressed solidarity with Muslims in Arakan for an independent state. Furthermore, Christian missionaries contribute to demographic shifts in CHT and Mizoram by converting local indigenous populations to Christianity, potentially leading to demands for a Christian majority state, like the way it happened

Meanwhile, China employs a 'Positive Diplomacy' approach to counter the USA's 'China Containment Policy' in the Indo-Pacific region. China is exploiting the US allies and exposing USA not as a trustworthy partner to undermine US influence. China's success in the Middle East challenges US allies in Asia, compelling India, a close ally of the USA, to navigate strained situations as it finds itself almost surrounded by China's allies. India is compelled to remain a neutral nation, not tilted too much towards the US.

In the end, the Kuki-Chin are fighting against the Indian government, demanding autonomy in Myanmar, and exerting soft pressure on the government of Bangladesh Therefore, it is quite understandable which external actors are behind the Kuki-Chin National Front. The Bangladesh Armed Forces have gained global recognition for their peace-building and peace-enforcing efforts under the UN umbrella. It is crucial to recognize the Kuki-Chin movement as an political threat. Relying solely on military action is unlikely to yield fruitful results and may instead entrap security forces in the intentions of insurgents. This challenge requires a multifaceted approach, encompassing diplomatic efforts, political initiatives, and military strategies, to effectively mitigate the escalation of such extremist activities.Compared to the neighbouring states in the region, Bangladesh faces relatively lesser threats from this community. Therefore, the government's diplomatic endeavours need to be intensified to ensure the safety and security of the Kuki-Chin community within the country. It is imperative for our diplomatic efforts to ensure that no other nation provides patronage, harbours, or funds Kuki-Chin terrorist groups.

The executive and legislative administrations in Chattogram need to forge close collaborations with the less developed indigenous tribes in their respective areas. They can propose special development projects to the government, where Bangladesh Army can extend its capabilities to play a pivotal role in implementing those initiatives. Reports indicate that the Bangladesh Army's Engineering Corps is actively enhancing communication systems in the region.

To further bolster development efforts, the government should seek increased funding from foreign investment partners, focusing on areas such as education, communication, and tourism. This approach will create more job opportunities for locals, contributing to socio-economic uplift.

Local administration and security forces must instil confidence within the less devel-

oped indigenous tribes. Continuation of military operations to apprehend wrongdoers is essential. However, given the complexity of military operations in CHT due to limited intelligence, a comprehensive and intelligencedriven approach, in tandem with political manoeuvre, can yield positive outcomes. Collaboration between Bangladesh's intelligence agencies and their counterparts in neighbouring countries is imperative to counter this political threat. The Kuki-Chin National Front (KNF) has conveyed their demand to Prime Minister Sheikh Hasina, clearly stating that they don't seek independence but autonomy. Thus, it's a purely political movement, not a separatist one. Therefore, the government and state machinery must handle the situation with utmost care to prevent it from escalating into a separatist movement.

Efforts should be led by political leaders to integrate Kuki-Chin people into mainstream national politics, thereby abandoning armed conflict. It is also necessary to ensure that no local politician has the opportunity to exploit Kuki-Chin terrorist groups for mere political gain. Only criminals and terrorists should be dealt with using extreme force. Drawing upon its expertise in peacekeeping and counterinsurgency operations, the Bangladesh Army should adopt a multifaceted approach, combining military action with diplomatic engagement and fostering political dialogue with aggrieved ethnic groups. Regional leaders must act decisively to prevent destabilization of regional stability before it escalates further. (IPA Service)

# Mine but not really mine: Why 'owning' digital items doesn't feel the same

ur possessions - the things we view as 'mine" - play an important role in our lives. Beyond their functionality, they can serve as poignant reminders of cherished memories. They can symbolise not only who we are, but also who we used to be, and who we aspire to become

From faded photo albums to treasured jewellery passed down through generations, each possession has a tale to tell. But how do our relationships with our possessions differ when they only exist digitally?

Our music, films, books and photographs are increasingly accessed via digital platforms rather than stored on our shelves. Do these digital items really feel like "mine" in the same way that physical possessions do? And can they bepersonally meaningful?

I interviewed 25 people multiple times over seven years. tracing their evolving relationships with their digital possessions. My research found that people often experience a weaker sense of ownership over their digital possessions and perceive them as less meaningful than their physical counterparts

Woven through my participants' stories were narratives of disappointment - their digital possessions frequently failed to meet their expectations. Here are three key ways these possessions can disappoint us:

#### 1. Restrictions

We develop a sense of ownership over objects by exerting control over them, whether through simple tasks like cleaning our car and organising our bookshelves, or more intentional customisation. However, unexpected restrictions can reduce our sense of control over our digital possessions.

My participants encountered restrictions on how digital items could be customised and displayed, and on whether items could be passed on to or shared with their loved ones. For instance, while musiclover Eve could freely arrange her vinyl records, her digital music organisation was restricted by iTunes' display op-

My digital music is ... kind of mine, kind of not [...] I don't feel ownership to the same extent as my records. I

stamp on the collection in the same way, everything's just automated and generic. iTunes organises it, not me. So, it doesn't feel as personal ... it doesn't feel mine in the same

The rigid structure imposed by the platform left Eve feeling frustrated, and diminished her sense of ownership.

**Instability** 

Possessions are often valued for their enduring nature, which allows them to serve as repositories of memories and

My participants often assumed that their digital possessions would mirror the stability of their tangible possessions. However, companies frequently retain the power to modify or delete digital items, rendering our digital possessions unstable

For instance, David became frustrated when the covers of his Kindle ebooks were unexpectedly replaced with new versions reflecting recent TV or film adaptations: How do you stop Kindle from updating the covers? They don't need you to give them access, because they gave themselves access to all of your possessions the second you signed up ... and if they can change the covers, it makes you worry about what else they're able to do, whether one day they'll just disappear altogether.

David is right to be concerned. Amazon famously came under fire for remotely deleting copies of ebooks from users' Kindle devices. More recently, in December 2023, PlayStation users were shocked to learn of the company's plans to delete purchased TV shows from their libraries, though the move was later reversed due to backlash.

Such incidents highlight the instability of digital possessions, leaving users wary of forming deep attachments.

Invisibility Participants vearned for the types of serendipitous encounters prompted by their physical possessions, lamenting their digital possessions' inability to evoke unexpected moments of reminiscence. Their digital content was often largely invisible when not in use – hidden within devices and easily for-

Alice observed that the physical books on her shelves them to prompt the unexpected unexpectedly caught her eye, moments of reminiscence that evoking fond memories. In people miss in the digital contrast, her ebooks lacked realm. (Courtesy: Scroll.in)

visibility and were therefore unable to remind her of the important moments they were associated with:

They're just not "there" like my other books are. They're, like, in the depths of my Kindle, hidden away ... They don't remind you they're there in the same way that [physical] books do. When I've finished a book on the Kindle, it's just archived and discarded, and I doubt that I'd look at it again.

Alice refused to let the memories associated with her favourite stories fade. Instead, whenever an ebook developed special significance, she purchased a physical copy to display prominently on her bookshelves, where it could attract her attention and prompt unexpected nostalgia.

**Avoiding disappointment** My research revealed that digital possessions often fail to provide the control, stability and visibility that we have come to expect from our possessions. This can prompt us to lower our expectations, to avoid future disappointment.

My participants frequently resolved that digital products would never be truly "mine" and couldn't develop the personal significance of their physical counterparts. Many consciously distanced themselves from these items, avoiding strong attachments. Others, like Alice, turned to physical items to replace or complement their digital possessions. This may explain, in part, the resurgence of analogue formats, such as vinyl records.

However, while our digital possessions often fall short, many of us yearn to establish a deeper sense of ownership over these items and to forge more meaningful connections with them. Through thoughtful design, companies can transform digital possessions from sources of disappointment to sources of delight. For instance, limiting unnecessary updates can increase stability, making us less anxious about becom-

ing attached to digital items. Facilitating the types of transfers consumers are accustomed to in the offline realm (for instance, allowing users to pass on a finished ebook to a friend) can enhance users' sense of control. And giving digital objects greater visibility through enduring displays and push notifications can enable

## How can parents safely introduce their children to news and current affairs?

Thile much attention has been drawn to the detrimental impact of violent video games on children's developing brains, there has been relatively little discussion regarding the negative effects of news and current affair programs children are exposed to.

When people consume news and current affairs, it's hard to escape tragic events, from natural disasters, acts of terrorism, and events that include loss of human life. But do we stop to consider what distressing media is doing to our kids?

How children are impacted

Research undertaken by the Audience Research Department of the Netherlands Broadcasting Corporation found young children who are exposed to news and current affair programs can be impacted so much that they start viewing the world as a scarier place. Research was undertaken through random telephone interviews with 537 Dutch children, with 48.2% of respondents stating they a fear reaction to watching adult news.

The study found children aged between 7-12 were most afraid of interpersonal violence and natural disasters such as fires, accidents and other disasters. Researchers from the study even found children's symptoms are like a trauma response including intruding thoughts (memories that pop into a child's head, nightmares, repeated discussion around events), avoidance (refusal to talk about news events, or to participate in school activities) and changes to arousal and reactivity (increased irritability and anger outbursts, difficulties in concentrating).

Even subtle exposure needs to be monitored Even when children are playing in the background, if adults have the news on, children can be listening in.

Children under the age of seven might not understand the content, which can cause confusion, therefore raising worry and anxiety. This is because children under the age of seven do not have the brain function to mentally manipulate information, and can't see things from another point of view. Older teens, meanwhile, generally gain much of their news content from the internet and social media, meaning some parents are not aware of how much, or what, they are exposed to. However, due to their age, they are able to have a greater understanding of different perspectives.

Getting the balance right According to psychological therapist Annie Gurton, different age groups require different strategies when it comes to consuming news and

current affairs: 1. children under the age of seven may perceive televised events as live occurrences, leading them to believe traumatic incidents are recurring when they see repeated broadcasts. They are likely to be greatly disturbed by images depicting suffering,

crying, or violence 2. between 7-12, children tend to grasp that news reports convey events that have already taken place. They are increasingly capable of empathising with victims, and may get anxious about the safety of themselves and their family when encountering distressing stories

3. teenagers aged 13 and older tend to exhibit heightened emotional responses to distressing events, often experiencing fear and deep concern for their and their family's safety. They may project such events into the future and worry about potential risks.

However, they are also capable of reasoning and understanding statistical explanations, which can provide reassurance and alleviate their anxieties.

There is no magic timeframe for parents to introduce their children to news and current affairs, however it is important that we consider not just the age, but the maturity and understanding levels of the individual child.

However, we do know it's important for children to take a break from the coverage. Setting a viewing limit of 30-60 minutes before encouraging children to get up and do something else is impor-

A perfect opportunity to support children to know more about the world, without exposing them to the potential downside of the news, is to teach them about why you need to censor their

This can help teach children to regulate their emotions, by expressing themselves when they see things that are upsetting. This might include empathising with young children under the age of seven by saying something like: "I know you really want to watch the news, but some media can report events that are not safe for you to hear.'

For an older child, it could be: "I am happy for you to watch the 'good news' stories but other events that are televised we need to watch together." The Raising Children Network has some fantastic tips for parents of school-age children when it comes to distressing news events:

1. turn off and take a break – this might mean allowing families 30 minutes to catch up on the main headlines, but then getting up and doing

2. age-appropriate information – children will cope better if they have age-appropriate information given to them. For example, during fire season, you might talk to your children about how due to the extreme heat, the ground gets very dry, resulting in an increase of fires. This is why we have total fire ban days to reduce that risk.

3. talk to your children - explain, at an age-appropriate level, what they have watched and allow for open communication about what has happened Allow them to ask questions and reflect

4. monitor your children's reactions to the news - ask them how they're feeling and share how you're feeling.

A great first step into the world of news and current affairs for children is programs like the ABC's "Behind The News", as parents and kids can watch together and discuss afterwards. (Courtesy: The

## Medical myths: All about allergies looked at the prevalence of food

n brief, an allergy is an unusual or exaggerated immune response triggered by a particular substance. Symptoms often include itchy eyes, wheezing, and sneezing. For many people, allergic reactions are uncomfortable and unpleasant, but they can be life threatening for others.

According to estimates from the Centers for Disease Control and Prevention (CDC), up to 60 million people in the United States experience allergies each

The World Health Organization (WHO) estimates that around 20% of people worldwide have an allergic condition.

One of the most common allergies - hay fever - affected an estimated 19.2 million adults in the U.S. during 2018, and this figure is likely to rise.

'Allergies are currently on the rise in the U.S.," explained Dr. Omid Mehdizadeh, an otolaryngologist and laryngologist at Providence Saint John's Health Center in Santa Monica, CA.

He told Medical News Today that "scientists believe the increasing prevalence of environmental allergies is due to changing weather patterns and increasing pollen blooms in the

Considering their prevalence, understanding and dismissing the myths associated with allergies is an important task. Here, we tackle 11 such myths.

#### 1. Allergies only develop in

One persistent myth is that once you reach adulthood, you don't develop any more allergies. This is untrue.

MALE, April 22: Maldives President Mohamed Muizzu's party won 71 seats and secured a "super majority" in parliamentary elections, preliminary results suggested on Monday, a victory seen as a strong endorsement of his pro-Beijing foreign policy, as both India and China closely watched the outcome of the polls in the archipelago nation.

Muizzu-led People's National Congress (PNC) won 68 out of 93 seats in Sunday's polls and its coalition partners Maldives National Party (MNP) and Maldives Development Alliance (MDA) won one and two seats, respectively, which is more than twothirds of the Parliament, landing the party an easy supermajority with the power to amend the Constitution.

Local media, which has described his party's win as a "supermajority", said the PNC is set to celebrate its landslide victory here on an artificial beach on Monday

Maldivian Democratic Party (MDP), led by former president Ibrahim Mohamed Solih, who is seen as a pro-India leader, held 65 seats in the previous parliament but won only 15 seats this time, Mihaaru, a news website, reported.

China leanings, has said that he wants to reduce India's influence in his country.

In the 2019 elections, the thenruling MDP won a super majority in Parliament, with 64 seats while the then-opposition PPM-PNC coalition won just eight.

The Democrats, as well as Adhaalath Party, failed to win any seats at all.

A total of 368 candidates were in the fray, including 130 independent candidates, 10 candidates from Jumhoory Party (JP), 39 from The Democrats, Maldives Development Alliance (MDA) 4, Adhaalath Party (AP) 4, and Maldives National Party (MNP) 2 nominees in the parliamentary election in Maldives, which has a strategic location in the Indian Ocean.

Fathimath Saudha from the ruling PNC won the Faafu Nilandhoo constituency, Asma Rasheed from the PNC won the Maafannu Medhu constituency, and Anara Naeem, an independent candidate,



Saudha is a family member of Muizzu. Asma and Anara have previously served as MPs in the 18th People's Majlis.

With about 75 per cent of the eligible voters casting their ballots, Sunday's election saw a recordlow voter turnout, provisional results suggested.

A total of 284,663 people were eligible to vote, but only 215,860 exercised their franchise.

The turnout was 81.32 per cent in the 2019 parliamentary elections, with 215,053 out of 264,446 eligible voters coming to vote.

Advisor to the President Abdul Raheem Abdulla said the results showed that Maldivians did not want the country to be driven into political unrest again. Raheem said the reason for

PNC's super majority in Parliament was the solid policies put forth by Muizzu. Raheem, who won the Fonad-

hoo constituency seat, said his win showed that Maldivians had paved the path for Muizzu to fulfil the targets of his presidency.

"The people have proved that they will not leave the country forsquabbles, and challenges," he

Raheem said Maldivians had learned over the past five months that President Muizzu is a leader who will not forget the pledges he

"The people have immense trust in President Muizzu," he said. Regarding MDP's loss, Raheem said the party failed to show tangi-

ble results despite winning the presidency twice.

Meanwhile, main opposition MDP in a statement said despite their loss in Sunday's parliamentary election, they will remain steadfast in their role of holding the government accountable and ensuring that democratic principles are upheld.

Congratulating the winning candidates, the party called on them to uphold democratic values and work for the people's benefit.

"As one of the key responsibilities of parliamentarians is to hold the government accountable, this party is confident that all who won [yesterday's] election will work to do so without hesitation," the statement read.

ISLAMABAD, April 22: The ruling Pakistan Muslim League-Nawaz (PML-N) got the lion's share in the key by-elections by winning at least two National and 10 provincial assembly seats, according to the unofficial results on Monday.

By-elections were held on Sunday on 21 National and provincial assembly seats amidst tight security and suspension of cellular and internet services in specific districts of Punjab and Balochistan to maintain law and order.

Two seats each of the National Assembly in Punjab and Khyber-Pakhtunkhwa and one seat in Sindh, while twelve seats of the Punjab Assembly and two each of Khyber-Pakhtunkhwa Balochistan assemblies were up for grabs.

Major political parties including the PML-N, the Pakistan Tehreeke-Insaf (PTI)-backed Sunni Ittehad Council (SIC) and the Pakistan Peoples Party (PPP) participated in the by-polls. However, Jamiat

Ulema-e-Islam Fazl of Maulana Fazlur Rehman boycotted the

The Election Committee of Pakistan (ECP) has yet to issue the final results but private media channels shared the outcome based on the results of individual polling stations

According to the Dunya News channel, the PML-N won two National Assembly seats while one each was grabbed by PPP, SIC and porter of the PML-N was killed after a clash with PTI voters in the Narowal area of Punjab. However, overall law and order was kept

under control. Earlier, the general elections were held across the country on February 8 to elect representatives for the National Assembly and four provincial assemblies. But polls were cancelled for one National Assembly, two Punjab Assembly and one seat of Khyber-Pakhtunkhwa Assembly respec-

In Punjab, NA-132 (Kasur) and NA-119 (Lahore) were vacated by Prime Minister Shehbaz Sharif and Chief Minister Maryam Nawaz, while Shehbaz also gave up two of his provincial assembly seats in Lahore. He, however, retained his NA-123 seat in the National Assembly.

Apart from these leaders, candidates who had won more than one seat opted for a chosen seat after the elections, leaving the Election Commission of Pakistan to organise by-elections on 21 seats, including five National and 16 provincial assembly seats.

A day earlier, the federal government announced that cellular services would remain temporarily suspended in specific districts of Punjab and Balochistan during the by-elections. The request for the suspension was made by the ECP.

The Pakistan Telecommunication Authority (PTA) issued a statement, saying that the decision has been taken to safeguard the integrity and security of the electoral process.

Elaborate security measures have been taken by the authorities to control the law and order situation, with the deployment of regular army troops to maintain peace during the day-long process of byelections.

The Punjab government had also asked the federal government to suspend mobile internet services in the province's 13 districts and tehsils on April 21 to maintain law

Prime Minister Rishi Sunak on Monday announced that the first flight with illegal migrants will take off for Rwanda in 10 to 12 weeks "come what may" and claimed that all the preparation has been made for the process once the long-delayed legislation passes through Parliament.

Stressing that he would not be giving out "sensitive operational detail" during a Downing Street briefing, the British Indian leader revealed that chartered commercial flights have been booked, an airfield has been identified and hundreds of escort officials trained to fly out the first set of migrants to Kigali while their asylum claims

are processed.

The press conference came as the government said Parliament will be sitting overnight on Monday for as long as it takes for the controversial Safety of Rwanda Bill to pass through all its stages to become law. The bill, which seeks to prevent legal challenges by declaring Rwanda a safe country in law, has faced hurdles due to the House of Lords demanding amendments - something Sunak blamed on the Opposition Labour Party.

"No ifs, no buts, these flights are going to Rwanda," Sunak told reporters.

"The first flight will leave in 10 to 12 weeks. Of course, that is later than we wanted but we have always been clear that processing will take time and if Labour peers had not spent weeks holding up the Bill in the House of Lords to try to block these flights altogether we would have begun this process

"I can confirm that we have put an airfield on standby, booked commercial charter planes for specific slots and we have 500 highly trained individuals ready to escort illegal migrants all the way to Rwanda with 300 more trained in the coming weeks. We are ready. Plans are in place. And these flights will go come what may. No foreign court will stop us from getting flights off," Sunak added.

After the first flight takes off, Sunak said he expects a "steady rhythm" of such journeys over the course of the following months to meet his pledge for the policy to act as a deterrent and "stop the boats" of illegal migrants landing on the country's shores.

"The priority is being able to deliver a regular rhythm, a drum beat of multiple flights a month over the summer and beyond because that is how you build a systematic deterrent and that is how you will stop the boats," said Sunak.

Asked if the UK would consider leaving the European Convention on Human Rights (ECHR) if the European court attempts to block such flights, Sunak did not rule out the possibility: "Now is the time for the flights to go and I am not going to let a foreign court, given all of that, block us from getting flights up and this deterrent up and run-

The press conference followed his meeting with the government's Illegal Migration Operations Committee, which is to operationalise the government's flagship policy of cracking down on illegal migration ahead of a general election expected in the second half of the

# on joint efforts to eradicate terrorism months after tit-for-tat air strikes

ISLAMABAD, April 22: Prime Minister Shehbaz Sharif and Iranian President Ebrahim Raisi Monday agreed on joint efforts to eradicate terrorism as they discussed ways to promote cooperation between their countries, months after the two neighbours carried out tit-for-tat air strikes against alleged terrorist hideouts on rival lands.

Raisi, the first head of state of any country to visit Pakistan after the February 8 general elections, was welcomed by PM Sharif at the Prime Minister House where the Iranian leader inspected the Guard of Honour. During their talks, President Raisi and Prime Minister Sharif agreed on joint efforts to eradicate terrorism, state-run Radio Pakistan reported. It added that the two leaders also held discussions to increase trade and communication links between their countries. Addressing a joint press conference, Iranian President Raisi said that the existing bilateral trade volume was "not acceptable" and added that Iran and Pakistan have decided to increase the trade volume to USD 10 billion. "We are committed to strengthening relations at high levels....Economic and trade volume between Iran and Pakistan is not acceptable. We have decided as a first step to increase trade volume between our two countries to \$10bn," Raisi said.

On his part, Sharif called for strengthening Pak-Iran ties despite challenges. "We have to keep this relationship strong despite the challenges we both face," he said. Sharif said he had detailed discussions with President Raisi on "religious, cultural, diplomatic, investment, and security matters" during their meeting. He described Raisi as an "ocean of political intelligence and wisdom", and said Iran would progress further under his leadership. "Pakistan and Iran can prosper and our borders can see progress," Sharif said, expressing hope that the shared border can adapt for trade and business.

He expressed hope for the relationship between the neighbours to be "firm and stable", noting that today was an opportunity to "make this friendship a happy and prosper-

Prime Minister Sharif and President Raisi planted a tree on the lawn of the Prime Minister House as the world marked Earth Day on Monday. Sharif was quoted as saving that the entire nation welcomed the Iranian president's visit while Raisi expressed gratitude to the premier for the warm welcome accorded to him, Radio Pakistan reported. Raisi, who arrived in Pakistan on a threeday official visit to promote cooperation, was accorded a warm welcome at the Islamabad Airport and was received by Housing Minister Mian Riaz Hussain Pirzada and Pakistan's Ambassador to Iran Mudassir Tipu, the Ministry of Foreign Affairs posted on social media platform X. The Iranian president is accompanied by his spouse and a high-level delegation comprising the foreign minister and other members of the Cabinet and senior officials, the Ministry of Foreign Affairs said. Soon after Raisi's arrival, Foreign Minister Ishaq Dar called on the Iranian president in Islamabad, where they discussed bilateral relations as well as regional and global developments, Radio

Pakistan reported. Raisi and Dar "emphasised the importance of enhanced efforts to further consolidate bilateral relations in diverse fields", it said, adding that they also "affirmed commitment to peace and constructive dialogue for resolving regional challenges". President Raisi has an extensive programme in Pakistan and is scheduled to meet President Asif Ali Zardari, Senate Chairman Yusuf Raza Gilani and Speaker of the National Assembly Ayaz Sadiq. (PTI)

JERUSALEM, April 22: Israel's Military Intelligence chief Major General Aharon Haliva resigned on Monday, taking responsibility for his unit's failures during the unprecedented October 7 Hamas attacks on the Jewish state. Haliva is the first General of the Israeli army's general staff to leave his position due to the failures that led to the massive attack by the Palestinian militant organisation Hamas and the subsequent war in Gaza.

In his resignation letter written in Hebrew, Haliva said, "The Intelligence Division did not live up to the task we were entrusted with. Throughout my duties, I knew that alongside authority comes heavy responsibility."

The General said he would like to "take responsibility" for what happened on October 7 and promised to do his best to complete as many of the war's goals as possible.

Haliva also called for the establishment of a state investigative committee, "that can probe and find out in a thorough, in-depth, comprehensive and precise manner all the factors and circumstances that led to the difficult events". At the same time. Haliva in the letter expressed his high appreciation for the performance of the Military Intelligence Directorate's personnel in the war.

Confirming Haliva's resignation, the Israel Defence Forces (IDF) in a statement said, "In a decision with the Chief of Staff and with the approval of the Minister of Defence, Major General Aharon Haliva will conclude his role and retire from the IDF after appointing a successor through an orderly and professional process.'

'The Chief of Staff thanked Major General Aharon Haliva for his service over 38 years in the IDF, during which he contributed significantly as a fighter and com-

mander for the security of the state," it said.

Meanwhile, reacting to the MI Chief's resignation, Opposition Yesh Atid Party member, Vladimir Beliak, in a post on X demanded the immediate resignation of Prime Minister Benjamin Netanyahu. "The IDF Intelligence Directorate head was wise to re-

sign. A state inquiry committee must be established without delay. The Prime Minister must resign immediately, regardless of the establishment of a state inquiry commit-

While several senior officials have accepted responsibility for the failures of October 7 in which about 1,200 Israelis were killed in the terror attack launched by Hamas in Israeli territory and close to 250 people taken hostages, Netanyahu has evaded responsibility, often avoiding a direct answer to such questions raised by scribes. Quoting a survey by Israel Democracy Institute, The Times of Israel newspaper in a report on Monday said that 62 per cent of Israelis, both Jewish and Arab, believe it is time for those responsible for the failures of October 7 to resign from their positions. Technology and intelligence, two of the strong pillars of the Israeli security apparatus, collapsed in the crucial test on October 7 and many around the globe have questioned the much-publicised image enjoyed by the Jewish state in these two fields, the report said. (PTI)

## Wet wipes containing plastic to be banned from sale in UK

LONDON, April 22: Wet wipes containing plastic will be banned from being sold in the UK following legislation to be tabled in Parliament soon, the British government announced on Monday, as the world marked as Earth

UK Environment Secretary Steve Barclay said the Department for Environment, Food and Rural Affairs (DEFRA) will table the legislation for England before Parliament's summer recess in July.

The devolved regions of Northern Ireland, Scotland and Wales are expected to follow on with their legislation later in the year to make it a UK-wide ban as part of an aligned approach.

"Wet wipes containing plastic are polluting our waterways and causing microplastics to enter the environment," said Barclay. "Defra will introduce legislation

before the summer recess to crack down on this unnecessary source of pollution, following our successful single-use carrier bag



charge and ban on microbeads in personal care products... Plasticfree wet wipes are readily available, and several retailers have already stopped selling wet wipes containing plastic," he said.

The minister said it was part of "step change" needed to protect the country's waterways from pol-

"The ban builds on a raft of actions already taken to protect our waterways and hold water companies accountable – including accel-

company fines back into the environment and quadrupling the number of inspections of water

company sites," he added. According to DEFRA's Beach Litter Monitoring Data for 2015-2020, an average of 20 wet wipes were found per 100 metres of beach surveyed across the UK.

Once in the water environment, wet wipes containing plastic can accumulate biological and chemical pollutants, increasing the risk

of harm to the animals and humans who encounter them.

Banning them is expected to reduce plastic and microplastic pollution and reduce the volume of microplastics entering wastewater treatment sites when wrongly flushed.

The ban follows a public consultation on the issue, which showed overwhelming support for such a

The law will be introduced via secondary legislation under the UK's Environmental Protection Act 1990, with 95 per cent of respondents agreeing or strongly

agreeing with the proposals. An 18-month transition period will start from when legislation is passed to allow businesses time to prepare. Following consultation with industry, the ban will not include the manufacture of these products, in line with other recent

## Re-poll concludes at 11 polling booths in Manipur peacefully with 81.60% voter turnout

IMPHAL, April 22: Re-polling in 11 voting stations for Inner Manipur Parliamentary constituency spread across Imphal East and Imphal West districts concluded peacefully on Monday.

The re-polls which were conducted under tight security measures registered a high voter turnout of 81.60%, according to the office of the chief electoral officer (CEO) Manipur.

The Election Commission of India (ECI) had ordered for re-polls at these 11 polling stations on Saturday after the Electronic Voting Machines (EVMs) were damaged by mob violence and vitiated to such an extent that the results of the poll there cannot be ascertained.

The polling stations where the voting held today are Sajeb (A), Khurai Thongam Leikai, Bamon Kampu (North-A), Bamon Kampu (North-B), Bamon Kampu (South West). Bamon Kampu (South East), Khongman Zone-V (A), Irioshemba, Iroishemba Mamang

From the first hour of the voting, voters were seen in queues in most of the polling stations waiting for their turn to cast their vote. # Heavy rains to lash Arunachal, Assam and Meghalaya till April 26

GUWAHATI, April 22: All the states in the northeast are expected to get heavy rains and thunderstorms in the next five days.

erate amounts of rain or snow are expected in most parts of Arunachal, Assam, Meghalaya, Nagaland, Manipur, Mizoram and Tripura from Monday to Thursday (April 22-25).

The spell is expected to clear out after this, only affecting a few areas of these states (excluding Arunachal) from Friday to Saturday (April 26-27).

The IMD has also forecast thunderstorms with lightning and gusty winds to affect the seven states during this forecast period.

The IMD has issued a warning of heavy rains with a possibility of thunderstorms over some sections of Assam and Meghalaya on Monday, Tuesday and Friday, and over Arunachal till Friday (April 22-26).

## Illegal infiltration of Bangladeshis challenge in Tripura: BSF official

#### In 2023 influx of Rohingya illegal migrants and Bangladesh nationals has increased in the state



AGARTALA, April 22: Crossborder crimes, especially illegal infiltration, have emerged as the biggest challenge for the BSF in guarding the India-Bangladesh border in Tripura, a top official said on

Monday. He said altogether 1,018 illegal infiltrators were detained while crossing the international border in the last one-and-a-half years.

"Cross-border crimes, smug-

gling of contraband items and infiltration have emerged as the biggest challenge for the troops to guard the 856 km borderline with Bangladesh," BSF IG, Tripura frontier, Patel Pijush Purusottam Das, said at a press conference.

"During 2023, the influx of Rohingya illegal migrants and Bangladesh nationals has increased in the state. They are using the northeastern state as a corridor to reach different destinations in India. A well-established network of touts exist across the border which facilitate illegal migration," Das said.

A special operation was launched by NIA with the active assistance of BSF in November and December last year and 29 agents involved in illegal migration were arrested for their alleged involvement in human trafficking, he said. "Prominent infiltration routes

have been identified. This has considerably reduced the influx," he

The IG said the BSF has taken initiatives to complete the fencing

work on the border and deploy technological solutions.

"Currently, the Single Row Fence (SRF) work is in progress at eight gaps in stretches. The BSF has also taken initiatives at the local level to plug the nullah and culvert gaps to prevent illegal activities," he said.

The paramilitary force has also installed smart surveillance systems to enhance the border domination in most smuggling and infiltration-prone areas, the IG

Claiming that the BSF maintains good relations with its Bangladesh counterpart BGB, Das said six pending development projects were settled at the DG-level talks and out of which three projects are from the northeastern state.

"During 2023 concurrence from BGB regarding the construction of SRF on 11 patches in the Indian territory within 150 meters of international border, six fencing gaps have been removed so far and the process is on for the remaining unfenced spots," he added. (PTI)

GUWAHATI, April 22: Many Manipur police who were assigned for election duties staged a demonstration at Imphal on Monday and refused to resume their duties in Tamenglong district which will go to the elections for the Outer Manipur Parliamentary constituency reserved for scheduled tribes on April 26.

These striking police personnel in the Meitei community fear for their lives to render their election duties in the Tamenglong district as at their best individual/personnel they have to pass the Kangpokpi district predominantly inhabited by the Kukis. The ongoing communal vio-

lence between the Kukis and Meiteis cost the lives of over 222 individuals including 9 policemen The Manipur government has is-

sued an order for 260 police personnel for election duties in Tamenglong of which 197 belong to the Meitei community.

On Monday, these 197 police personnel assigned for election duties staged a demonstration in front of the Ghanapriya Women's College, Imphal refusing to report to the concerned officials.

Police personnel tasked with the election duties in Tamenglong said. We are not refusing our bounden duties. We are requesting the officials concerned to allot the election duties at the less vulnerable district/locations.'

For the second phase of elections, Manipur will go to the poll on April 26 in 13 assembly segments of eight districts located in the border areas of this strife state.

The first phase of elections for the Inner Manipur Lok Sabha seat and Outer Manipur LS seat in 47 assembly segments was held on April 19 with 72 per cent voting.

For the Outer seat, a total of four candidates - Indian National Congress, Naga People's Front, and two independents are in the electoral frays.

# Modi makes 'redistribution of wealth' charge against Congress again

Minister Narendra Modi on Monday accused the Congress again of planning to redistribute people's property if it is voted to power, but stopped short of saying that the wealth would go to Muslims.

Addressing an election rally in western Uttar Pradesh's Aligarh, a constituency with a sizeable Muslim population, Modi accused the opposition Congress and the Samajwadi Party of following a policy of "appeasement" and vet doing nothing to uplift the socioeconomic condition of the community. In contrast, he cited the enactment of a law against instant triple talaq and an increase in the Haj quota as moves during the BJP government's term to help the community.

On Sunday, the prime minister had triggered a political row by claiming that the Congress manifesto promised "redistribution" of wealth after conducting a survey.

Citing former prime minister Manmohan Singh's 2006 remark on Muslims having the "first claim" on the country's resources, Modi said in Rajasthan's Banswara that the Congress was set to hand over the wealth of others to "infiltrators" and "those who have more

#### 'No civilised nation decides citizenship on basis of religion

KANNUR (KERALA), April 22: Kerala Chief Minister Pinarayi Vijayan said on Monday that no civilised nation in the world has made religion the basis of citizenship, and the BJP-led union government's contentious Citizenship Amendment Law is against the secular values of the

When everyone came forward protesting against the CAA and to safeguard secularism, the Congress did not raise any significant protest against the BJP government's move, he alleged.

As Lok Sabha polls are just four days away in the state, Vijayan was addressing an election meeting in Mattannur, in this northern district.

"No civilised nation has decided citizenship on the basis of religion. No country divides refugees on the lines of their religion," Vijayan said. India is making religion the basis of deciding citizenship. It is destroy-

ing secular values, he charged. While several national leaders, including those from Communist par-

ties, were arrested for protesting against the CAA in New Delhi years ago, no Congress leaders were among them, Vijayan alleged. The CM accused the 18 Congress-

led UDF MPs from the state of attending a feast hosted by the party president on the day when the national capital had witnessed the fiercest agitation against the CAA.

Vijayan further asked why the Congress, which is claimed to be a secular party, cannot oppose the RSS agenda being implemented in the country. (PTI)

### Oppn leaders slam Modi's 'redistribution of wealth' remark

**NEW DELHI, April 22:** Opposition leaders on Monday slammed Prime Minister Narendra Modi for his comments made at an elections rally in Rajasthan, with some leaders also appealing to people to reach out to the

Election Commission of India. In a post on X, Communist Party of India (Marxist) General Secretary Sitaram Yechury said while the prime minister's remarks are atrocious, the silence of the Election Commission is worse. "This is atrocious! The silence of the Election Commission is more atrocious!! Modi's inflammatory speech is a gross violation of the Model Code of Conduct and Supreme Court pronouncements on Hate Speech," Yechury said.

"Merits strictest action and contempt of Court." he said.

The CPI (M) leader hoped the Supreme Court will take note of the incident and initiate action.

"Hope the Supreme Court takes suo motu cognisance of this incendiary speech and issues Modi a contempt of Court notice followed by strictest punishment," he said.

Party sources said that a petition signed by "concerned citizens," will be sent to the Election Commission later in the day. Trinamool Congress leader Saket Gokhale also appealed to the people to write to the Election

Commission over Modi's remarks. In a post on X, the TMC Rajya Sabha MP shared the email id of the Chief Election Commissioner, and urged people to write to him, stating that the poll panel does not listen to the Opposition. "Election Commission ignores the Opposition and has kept giving a free pass to Modi and the BJP. During elections, the EC is not accountable to political parties. But - they're accountable to the people of India," Gokhale said. (PTI)



In Aligarh Monday, Modi repeated the point about redistribution of wealth, saying he wanted to "alert" people about the "intentions" of the Congress and the opposition INDIA bloc.

"The Congress "shahzade" (prince) says if his government comes, they will investigate who earns how much and how much property they have. Not only this, he further says the government will take over the property and redistribute it. This is what their election manifesto is saying," he claimed, referring to Rahul

"Just think, our mothers and daughters have gold. This is 'stridhan' (women's property). It is considered sacred, even the law protects it. But now they are eyeing a change in law and snatching the property of our mothers and sisters," he said.

"These people have their eyes on their 'manglasutras'," Modi added, accusing the opposition of trying to "steal" the gold women possessed. He claimed that the opposition planned to conduct a survey of the property owned by salaried people. "If you own two homes, it will snatch one - the

"This is Maoist thinking... this is communist thinking. By doing this they have ruined so many countries. Now the Congress and the INDI Alliance want to implement the same policy in India," the

prime minister said. But, unlike in the Rajasthan speech that triggered the opposition charge of "hate speech", Modi stopped short of saying that the wealth will be distributed among Muslims. He also did not refer to Manmohan Singh's statement made nearly two decade back.

He said the Congress and the SP followed a policy of "appeasement" without doing anything for the social and economic progress of Muslims, and also referred to the Pasmanda Muslims - the backward sections among the community. "The lives of a number of daughters were ruined due to triple talaq. We made a law against it and made the future of the daughters secure," he said.

Attacking the opposition, he said the 'parivarwadi' people have created empires by "looting" people and not giving anything to the poor from their "immense wealth".

"Now their eyes have fallen on the property of people of the country. The Congress considers it as

their birthright to loot people's wealth," he charged.

The PM said the people of Aligarh had put a lock on dynastic politics, corruption and the appeasement practised by the two 'shahzade". The reference was to Congress leader Rahul Gandhi and Samajwadi Party president Akhilesh Yadav, who are fighting the Lok Sabha elections as allies.

He referred to law and order in Uttar Pradesh and the security situation on the country's borders earlier when "our brave sons were martyred every day".

"Today all this has stopped. Earlier, terrorists used to explode bombs, serial blasts took place. Even Ayodhya and Kashi were not spared. Bomb blasts used to happen every day in big cities, now there has been a full stop on serial bomb attacks," he said.

"What we did in 10 years is just a trailer, we have to do a lot of work," he said.

The prime minister said he will work constantly for the country. "Modi is born for 'mehnat' (hard work), not 'mauj' (enjoyment)."

RAIGANJ, April 22: West Bengal Chief Minister Mamata Banerjee on Monday termed as "illegal" the Calcutta High Court order cancelling all appointments made through a 2016 teacher recruitment test, and said her government will challenge the verdict.

Banerjee, while addressing an election rally at Raiganj in North Bengal, also accused BJP leaders of influencing certain judicial decisions

"The court verdict cancelling all recruitments is illegal. We stand by those who lost jobs. We will ensure you get justice, and challenge the order in a higher court," she said.

The Calcutta High Court on Monday ordered the cancellation of all appointments made through the recruitment process of the State Level Selection Test-2016 (SLST) in West Bengal government-sponsored and aided schools, declaring it "null and void".

Later, addressing another rally at Karandighi, Banerjee asserted, "It is not mandatory to accept all verdicts. We will challenge the order in the Supreme Court. This order was passed as per the BJP's instructions amid the elections."

Accusing the saffron party of manipulating the judicial system, Baneriee said: "It has turned the courts into their extended party offices. If the BJP files a PIL, prompt action is taken and people are sent to jail. No action is initiated when

In an apparent reference to former Calcutta High Court judge Abhijit Gangopadhyay joining the BJP after resigning, Banerjee commented, "The connection is evident and visible to all.'

#### **Court directs AIIMS to constitute** medical board to examine Arvind Kejriwal

NEW DELHI, April 22: A Delhi court on Monday directed the AIIMS to constitute a medical board to examine Chief Minister Arvind Keiriwal to determine whether he needs insulin to control his blood sugar levels and said the home-cooked food that the politician was consuming was different from the diet chart prepared by his doctor.

Special Judge for CBI and ED cases Kaveri Baweja passed the order while declining Kejriwal's plea for video consultation with his doctor in the presence of his wife.

Kejriwal had alleged he was not being administered insulin in jail leading to "alarming" rise in his blood sugar levels.

The ED had claimed on Friday the AAP leader was consuming sugar-laden food like mangoes and sweets on a regular basis to create grounds for medical bail. Kejriwal responded sharply, accusing the central anti-money laundering agency of acting "petty" and "politicising" what he ate.

The court on Monday ordered all necessary medical treatment to be provided to Kejriwal, arrested in a money laundering case linked to the alleged Delhi excise scam.

endocrinologist/diabetologist to examine Kejriwal. The board will decide whether he should be administered insulin and also take a call on the diet and exercise plan he needs to follow, the court said. It said there shall be no deviations from the diet plan prescribed by the medical board.

In its order, the court said the detailed list of food he consumes "categorically shows that the food items which are being provided as home cooked food, are quite different from the diet prescribed by his own doctor". The court also responded to a nonchalant re-

mark by Keiriwal's lawyer that "Aam aadmi aam nahi khayega to kya mushroom khayega". The judge said mushrooms had been prescribed by Kejriwal's own doctor, whereas there was no specific recommendation for eating mangoes. "This court is also unable to fathom as to why

the family of the applicant has been sending various articles against his medically prescribed diet i.e. mango, sweets, aloo puri etc.," the judge said. The court said it was apparent that the jail authorities have a well-developed infrastructure for providing requisite health care to the inmates.

the submissions that the applicant cannot be treated differently from other inmates as laws/jail manual must apply equally to all," the judge said.

"This court also finds itself in agreement with

She said though it shall continue to be the primary duty of Tihar Jail authorities, "who are stated to be fully equipped to take care of the health of the Applicant", to ensure that all requisite medical treatment is provided to him in jail, in the event of any requirement for specialised consultation, "the Jail Authorities shall consult the Medical Board to be constituted by Director, All India Institute of Medical Sciences (AIIMS), comprising of a Senior Endocrinologist/ Diabetologist".

"The said Medical Board is further requested to prescribe a diet and exercise plan, if required, for the Applicant considering his medical requirements and relevant data regarding his vital statistics. The Medical Board may, as and when required, also physically examine the Applicant in Jail," the judge said.

The judge asked the medical board to submit its report to the court at the earliest specifying as to whether Kejriwal required insulin to control his blood sugar levels. (PTI)

## INSV Tarini with women officers returns home after 2 months

NEW DELHI, April 22: Indian Naval Sailing Vessel Tarini carrying two women officers has returned home triumphant after undertaking a "historic transoceanic expedition" that lasted nearly two months during which they faced challenges posed by heavy winds and rough seas.

#### Mangrove pitta bird population rises in Odisha's Bhitarkanika

KENDRAPARA (ODISHA), April 22: Officials have reported an increase in the population of mangrove pitta birds during the latest bird census at Bhitarkanika National Park in Odisha's Kendrapara district. Forest officials on Sunday released the mangrove pitta bird census report, which pegged their population at 218. This marks an increase of 39 compared to the previous census.

Forest officials had sighted 179 mangrove pitta birds in 2023 during the first census of the species in Bhitarkanika

The census was carried out on Saturday by around 80 forest personnel under the supervision of the forest range officers of Dangamala, Rajnagar, Mahakalapada, Gahirmatha, and Kujang forest ranges of the park.

The mangrove pitta are colourful birds which have a black head with brown crown, white throat, greenish upper parts, buff under-parts and reddish vent area. It feeds on crustaceans, mollusks and insects, said Subhadarshani Pradhan, a mangrove pitta researcher.

This non-migratory resident bird, scientifically known as Pitta megarhyncha, thrives in Bhitarkanika, with its breeding season spanning from April to August. The abundance of fish and the distance from human habitation make Bhitarkanika an ideal breeding ground for these colourful birds, he added.

Twelve members of different royal families in Odisha are contesting the Lok Sabha and Assembly elections seeking votes of commoners.

Elections to the 21 Lok Sabha constituencies in Odisha and 147 Assembly segments will be held simultaneously in the state from May 13 to June 1.

The ruling Biju Janata Dal had fielded eight members from royal families followed by BJP three and Congress one.

Ten members of the royal families are contesting Odisha Assembly elections while two are in the fray for Lok Sabha polls.

The BJD has fielded 28-year-old Sulakshana Geetanjali Devi, granddaughter of veteran leader late A N Singhdeo of Dharakote as its candidate for the Sanakhemundi assembly constituency.

A law degree-holder, Geetanjali is the fifth member of the Dharakote royal family to contest assembly election. Her grandfather A N Singhdeo was elected from the Surada constituency four times -1967, 1971, 1977 and 1995 - as an MLA and in 1989 as the MP of Aska Lok Sabha constituency.

Her grandmother Shanti Devi and father Kishor Chandra Singhdeo had also been elected from the seat in the 1990 and 2004 elections respectively.

Her mother Nandini Devi had won from Sanakhemundi seat in



2014. This time, Geetanjali will contest against Congress's sitting MLA Ramesh Chandra Jena in the May 20 election.

"I have been inspired by my grandfather, mother and father to join in the politics to serve the people. I thanked the chief minister for giving me the opportunity to serve the people of the constituency," said Geetanjali, who is the chairperson of the panchayat samiti of

The BJD has also fielded Chinmayananda Srirup Deb, son of Usha Devi, royal scion of Chikiti to contest from Chikiti Assembly segment.

## EC go ahead given to deal with issue: Centre to SC on financial aid for Karnataka drought

NEW DELHI, April 22: The Centre on Monday told the Supreme Court that the Election Commission has given clearance to it to deal with the issue raised by Karnataka regarding financial assistance for drought man-

A bench of Justices B R Gavai and Sandeep Mehta was hearing a plea filed by the Karnataka government seeking a direction to the Centre to release financial assistance from the National Disaster Response Fund (NDRF) to the state for drought man-

'The Election Commission has cleared the government to deal with this question. I think it will be done expeditiously," Attorney General R Venkataramani, appearing for the Centre, told the bench.

He told the bench that the matter could be taken up next week.

"This should all be done amicably...we are having a federal structure," the bench observed, while adjourning the matter.

While hearing the plea on April 8, the apex court had observed let there not be a "contest" between the Union and the state.

The Attorney General and Solicitor General Tushar Mehta, who were appearing for the Centre, had told the bench they would seek instructions in the matter.

The petition has also sought to declare that the Centre's action in not releasing the financial assistance for drought arrangement as per the NDRF is "ex-facie violative" of the fundamental rights of the people of the state guaranteed under Articles 14 and 21 of the Constitution.

It said the state is reeling under "severe drought", affecting the lives of its people and for the Kharif 2023 season, which starts in June and ends in September, a total of 223 out of 236 taluks are declared as drought-affected. The plea said 196 taluks are categorised as severely affected and the remaining 27 as moderately af-

"Cumulatively for kharif 2023 season, the agriculture and horticulture crop loss have been reported in more than 48 lakh hectares with the estimated loss (cost of cultivation) of ₹ 35,162 crore," the plea, filed through advocate D L Chidananda, said. It said the assistance sought from the Centre under the NDRF is ₹ 18.171.44 crore.

**NEW DELHI, April 22:** A court here has acquitted three persons who were accused of running an organised crime syndicate and charged under stringent provisions of the Maharashtra Control of Organised Crime Act (MCOCA), saying the Delhi Police's case was "founded on a wrong assumption".

The court observed that the confession statements of the accused, which are admissible as evidence under MCOCA, did not help the prosecution's case, nor did it prove the charges

a case against Satender alias Baba, Ajeet and Rahul, who were accused of running an organised crime syndicate, which included collecting intelligence, conveying threats and using vi-

The gang led by Baba, which was involved in heinous crimes like attempt to murder, dacoity, robbery, criminal intimidation and illegal arms possession, had established such a notorious image that people were terrified, merely when their names were

port, the three accused were prosecuted based on the charge sheets filed against them earlier in previous cases.

of continued unlawful activity," the court said. In its order passed earlier this month, it said the prosecution's stand did not meet the legal requirements for invoking MCOCA and the Delhi Police's case was "founded on a wrong assump-

"Even otherwise, as per evidence on the record, except for the evidence in the form of confessional statements of the accused persons, there is no incriminating evidence for their in-

volvement in the unlawful activity," the court said. It noted that at the time of recording their confessional statements, the magistrate concerned had asked each accused whether they made the statements, to which they replied in the negative and said that they were illiterate and police had obtained their signature on some unknown documents.

"They signed such documents out of fear because they were threatened by police to be implicated in cases. This scenario shows that all the accused persons literally disowned the claim of the police that they had voluntarily made confessional statements before the respective officers of the rank of deputy commissioners of police (DCPs)," the court said.

It said the trio were produced before the magistrate on the same day when they made the statements.

"It is difficult to presume that a person having volunteered to make a confessional statement about crimes committed by him, would deny having made such statement with the passage

"The voluntariness of such a person cannot be so fragile to vanish in such a short time, that too when as per record being in police custody such accused persons did not have access to anyone else except the police officials, who could influence them otherwise," it added.

The court concluded that as the confessional statements did not appear voluntarily, they were not "credible pieces of evi-

"They (confessional statements) cannot be relied upon to say that accused persons were members of a crime syndicate and were involved in organised crime," it said. The court said that though a confession was admissible as

evidence under MCOCA provisions, according to judicial precedents, such statements for becoming the basis of conviction had to be "voluntary, truthful and reliable" "I find that the prosecution has wrongly concluded that accused persons indulged in committing organised crime. The al-

leged confessional statements of the accused persons also do not help the prosecution to cure the defect (in the case) or to prove the charges," the judge said.

"I find that accused persons are entitled to acquittal in this case and hence, they are acquitted of the charges levelled," he added. The Gokalpuri police station had registered a case under MCOCA sections against the accused based on the approval granted by the then joint commissioner of police, east Delhi

## 'Covert': Former RAW, ISI chiefs come together for sequel of bestselling 'The Spy Chronicles'

**NEW DELHI, April 22:** After the success of "The Spy Chronicles", AS Dulat and Asad Durrani -- the ex-spy chiefs of India and Pakistan -- have now joined hands for its sequel "Covert: The Psychology of War and Peace", which they cowrote with psychiatrist Neil K Ag-

The book, scheduled to release on April 29, takes the reader right into the head of the two spymasters as it delves into their personal and professional trajectories that moulded them in the early years. It is published by Harper Collins

In what was billed as a one-ofits-kind book, the two former spy chiefs in "The Spy Chronicles: RAW, ISI and the Illusion of Peace", released in 2018, touched upon some thorny issues between the neighbouring countries, including terrorism, particularly the 2008

Mumbai attack, Kashmir and the influence of intelligence agencies.

"In 2021, Sundeep Waslekar's offer to get General Durrani and me to join in a discussion on 'The Spy Chronicles', moderated by Neil K. Aggarwal, led to this book on 'The Psychology of War and Peace', which has virtually turned out to be Part 2 of 'The Spy Chron-

... I have known and engaged with General Saheb for some years now, but it has been a fascinating interaction with Neil. One can lie to the world, but not to oneself -and to a psychiatrist, even less!" Dulat said in a statement.

Moderated by Aggarwal, the discussion in the book turns to the domain of international relations, exploring why the governments of India and Pakistan collaborate in certain areas, but not in others. What emerges is a forthright,

honest appraisal of the peacebuilding process between the two nations that appear inherently hostile to each other but share so much in terms of history and cultural identity, informed the publishers.

"The Spy Chronicles' itself was like a bolt from the blue: two former intelligence chiefs from chronically hostile countries, joining hands and banging heads to make some sense of our bilateral madness, was nothing short of a potential train wreck. And when Dr Aggarwal got us together to compose this book and pampered us as peace psychologists, it must have been an irony of history,"

added Durrani. The dialogues in "Covert" reveal a deep camaraderie between Dulat and Durrani, who have headed the intelligence operations for their respective countries. But more importantly it claims to provide deep insights into the shadowy world of negotiation and subterfuge.

According to the publishers, it is

an "eye-opener" and a "must-read" for anyone invested in peace and amity in South Asia.

"Circumstances have prevented Dulat and Gen Durrani from meeting in person for years. But aided by the technology of video conferencing, in 'Covert' they speak to a masterful interlocutor, Neil K. Aggarwal, about India, about Pakistan, about what holds the two nations together and what tears them apart, and the psychology behind it all," said Udayan Mitra, ex-

ecutive publisher, HarperCollins. While Durrani has also written "Honour Among Spies" (2020), Dulat's previously authored books include "Kashmir: The Vajpayee Years" (2015) and "A Life in the Shadows" (2022). (PTI)

# Trolled for his son's name 'Jehangir', Chinmay Mandlekar says he won't play Shivaji Maharaj's role



PUNE. April 22: Trolled over his son's name. "Jehangir", noted Marathi actor Chinmay Mandlekar has announced he would not play the character of Chhatrapati Shivaji Maharaj as his family is being mentally harassed on social media.

Mandlekar said his son is 11-year-old but trolling over his name started only recently.

The actor and his wife Neha claimed they have been subjected to mental harassment over their son's

"My wife Neha had talked about the trolling of our family over our son's name yesterday through a social media post. After clarifying the views over the name, the trolling and comments did not decrease. In Fact, the bad comments have increased and the trollers are now raising doubts over them and as a person, this is annoying me (sic)," Mandlekar stated on social

The actor said he was open to criticism about his work as an actor but trolls have no right to comment on his personal life.

Mandlekar also said he had clarified why he named his son"Jehangir" multiple times on social media. Jehangir was the fourth Mughal emperor, who ruled from 1605 till his death in 1627.

"The tone of the trolling is that I have played the character of Chhatrapati Shivaji Maharaj in multiple movies and still the name of my son is Jahangir. My son was born in 2013 and today he is 11 years old. I did not face the trolling then. It is happening now," the actor said.

Mandlekar has written, directed or acted in successful plays such as "Bechaki" and "Sukhanshi Bhandto Aamhi". He had essayed the character of Chhatrapati Shivaji in Marathi movies "Farzand", "Pawankhind", "Subhedar" and "Sher Shivraj".

He had also starred in Marathi movies - "Zenda". "Morya or Gajaar: Journey of the Soul", and also played supporting roles in Hindi films including "Tere Bin Laden" and "Shanghai".

Mandlekar said he was appreciated a lot for playing

the role of the Maratha king.
"But because of that role, if my family is being harassed, I announce here with great humility that I will not play that character. This decision has saddened me. The role was an expression of my devotion and love for Chhatrapati Shivaji Maharaj," he stated. Hitting back at trolls, the actor wondered whether they will change the name of the iconic Jehangir Art Gallery in Mumbai.

"The Government of India conferred Bharat Ratna on Jehangir Ratanji Dadabhoy Tata. Do we think about his name when we use the products and services by his company Tata," he said. (PTI)

"He's sort of a devil-on-the-shoulder character, the antagonist who's with you all the way through. He's like a good-time guy in a bad world. He doesn't want to have to face reality," h

People who successfully play classically heroic roles are "very talented actors", added Harington. My heart goes out to people playing heroes. They're f\*\*\*\*\* hard to play and to make interesting. It is more fascinating as an actor, I think, to empathise with someone deeply faulted and wrong, to try and find your way into why they are doing these things.

(Playing) a guy who is doing all the right things and is driven by being good, it's harder to do that... But at the moment, I just find it more interesting looking for the f\*\*\*\*-up people, he said.



# The future is here: Accolades pour in for Gukesh after historic win

NEW DELHI, April 22: People from all walks of life, including the chess community, went into a frenzy as they hailed India's D Gukesh as a potential "future world champion" after he etched his name in the history books by winning the prestigious Candidates tournament in Toronto.

Gukesh drew with American Hikaru Nakamura in the final round to not only win the prestigious tournament but also become the youngest ever challenger to the world title at 17.

Five-time world champion and the only other Indian to win the Candidates, the legendary Viswanathan Anand was one of the first people to congratulate the teenager.

"Congratulations to @DGukesh for becoming the youngest challenger. The @WacaChess family is so proud of what you have done. I'm personally very proud of how you played and handled tough situations. Enjoy the moment," Anand

#### Seventh-round loss gave me energy, motivation to aim for title: Gukesh

**NEW DELHI, April 22:** For most athletes victory is usually the biggest motivator but not for history-making teen Indian Grandmaster D Gukesh, who said he got the "energy" to become the youngest Candidates chess champion thanks to his seventh-round loss to Iran's Firouzja Alireza.

The 17-year-old from Chennai, whose father is an ENT surgeon and mother a microbiologist, drew his 14th and final round game against American Hikaru Nakamura to win the prestigious tournament and become the youngest challenger for the world championship title.

He will take on China's Ding Liren in that match later this year.

"I was feeling really good from the start but after my seventh round loss against Alireza, I was really upset. It was a painful loss. But the next day I had a rest day and was feeling my absolute best," Gukesh told PTI videos in a zoom interview from Toronto

"The loss kind of provided me with the energy and motivation. After the loss I really felt that if I continue doing the right thing, and I am in the right mental state then I can really go for the wins," he

Gukesh became only the second Indian after five-time world champion Viswanathan Anand to win the Candidates. In the process, he bettered a 40-year-old record by the great Garry Kasparov, who became the youngest to challenge for the world title in 1984 at the age of 22.

Reflecting on how the tournament went for him, the world's third youngest Grandmaster said, "The focus from the beginning of the tournament was to trust the process, to be in the right mindset and play the right chess.

"I think throughout the tournament, I managed to do that well and consider myself fortunate enough to have the results go my way."

On how he felt after winning the title and becoming the youngest challenger for World Championship title, Gukesh said "It was a beautiful moment, I was so happy and relieved to have officially made it. I was just super happy.

The Indian needed the last game between Ian Nepomniachtchi of Russia and top-seeded American Fabiano Caruana to end in a draw and this is exactly how things panned out.

Had any of these two players won, the tournament would have needed a tie-break as Gukesh and the winner would have ended up in ioint lead.

"I was trying to prepare for the tie-break, Me and my trainer were discussing for the tie-break beforehand but soon after we started discussing we got to know that there will be no need for it," Gukesh said.

On what will be his plan for the world title match, the dates and venue for which are yet to be decided, he said: "I did not have much time to think about the World Championship final after winning the (Candidates) tournament. (PTI)

## Chennai's chess nursery: The learning ground for Gukesh, Praggnanandhaa

CHENNAI, April 22: Even a casual stroll around the city will help visitors collect crumbs of Chennai's flourishing romance with chess - Napier Bridge decked up as a chess board, murals on the walls of many buildings or advertisements of coaching centres.

But Velammal Institutions is the catalysing force behind this chess revolution in the city.

It is the nursery where GMs D Gukesh, who on Monday won the Candidates to become the youngest-ever challenger for world title, and R Praggnanandhaa learned the intricacies of the sport.

"Chess has always been a part of the city's culture and the decision to make chess a part of the curriculum has really helped it to boom. Of course, they also have a champion like Anand to look up to, S Velayan, the chess co-coordinator at the Velammal, said.

"Since most of the children coming here have a genuine interest in chess, we don't have to push them. They combine studies and chess well, and, in fact, the students who play chess have done even better in their studies too,' Velavan added.

What he refers to here is the '7 to 17 programme' introduced in schools by former Tamil Nadu Chief Minister J Jayalalithaa in 2013, coinciding with that year's World Chess Championship between Viswanathan Anand and Magnus Carlsen held in the city.

Their dedicated approach has produced matching results too as Velammal Institutions won the World School Chess championship for five successive years and both Gukesh and Praggnanandhaa too were part of their squad in 2021.



It's not surprising then to see that several Grand Masters have come out of this school since 2005 - SP Sethuraman, Leon Mendonca, K Priyadharshan, B Adhiban, Vishnu Prasanna, Visakh NR, Vignesh NR, M Karthikeyan, C Aravindh, Karthik Venkataraman, V Pranay, S Bharath, Ariun Kalyan, P Karthikeyan, N Srinath while women GMs are Varshini S, daughter of Velavan, Vaishali R, sister of Praggnanandhaa, R Rakshitta, B Savitha Shri.

"What we do here is to ensure that the children play regularly in tournaments so that they don't break away from the sport for a longer duration. It will not be good for their growth (as players) and they need to play at all junior levels like under-11, under-15 or under-17," Velavan said.

"It keeps them mentally prepared for tougher competitions in their way and they will not be in awe of their opponents or a competitive atmosphere," he notes.

But the challenge for them is just beginning as more children are trying to enroll into the school to make a career out of chess.

Velavan said the Velammal Institutions are trying to bring in more

coaches from outside to cater to the needs of a larger pool of players, and arrange more modern facilities and chess literature available for the aspirants. Chennai's surge as the chess

capital of the country has not one bit amazed the fraternity, and AICF vice-president DP Anantha traces the journey back to the 1970s. "Along with Bengaluru, Chennai (then Madras) had the most pri-

vately owned chess institutions in the country. I still remember how the Tal Chess Club in Chennai used to conduct annual events and some big names like Manuel Aaron used to play in them. "It was prestigious to win the event because even some local


players used to upset fancied players. They have kept that tradition very diligently," says Anantha. The Tal club, which was started with the backing of the erstwhile

Soviet Union, now no longer operates but institutions such as Velammal have ensured that the city will not go through a chess degrowth. Currently, more than 60 recognised chess academies run in

Starc, however, managed to

With five wins from seven matches at the halfway mark, the second placed KKR look a transformed side under mentor and two-time title winning former captain Gautam Gambhir.

Gambhir, who last represented the side in 2017, returned to his former franchise as a team mentor, relinquishing the same position at Lucknow Super Giants this season.

Mysore said Gambhir has

added a lot of "weight" to the

# Behind Gukesh's Candidates success lies tale of his parents' sacrifices

CHENNAI, April 22: Young Indian Grandmaster D Gukesh may be grabbing headlines after his historic win at the Candidates but away from the spotlight lies the stories of sacrifice by his parents, who had to put careers on hold, dig into their savings and also turn to crowd-funding to

fuel his dream. The 17-year-old won the Candidates Chess Tournament in Toronto on Monday to become the youngest ever challenger to the world title, bettering a record created by the legendary Garry Kasparov 40 years ago.

Gukesh also was without a sponsor and had to manage his finances through prize money and crowd-funding but despite all that he went on to overtake idol Viswanathan Anand as India's no.1 last year.

Prasanna was impressed at how quickly Gukesh scaled the heights of success, attributing his achievements to his obsession with the sport and insatiable desire to learn and improve.

"It's an incredible performance from him. To get to this level, you need a lot of things to work right, and it's a huge achievement. He already has a small place in history," Prasanna said. "His focus and complete ob-

session with the game, besides also trying to get better. He is always thinking much more than anybody about how to get even better -- his biggest defining quality.'

After learning to play the sport at the age of seven, Gukesh came under Prasanna's tutelage in 2017. "We met in 2017, and as soon as we started to work together, he began scoring the IM norms and so on. And then. things started to happen so fast and quickly that within two years

"We continued to train intensely before COVID hit. During that period, we used to train at Vishwanathan Anand's academy and utilise the ample time that we had. He went up to 2,640 in rating before coming down to 2,610. Even last year, he went up to 2,750 and came down to

"His previous big breakthrough was getting that Olympiad gold, and now, he has bettered it by not just qualifying for the Candidates, but even winning it. Marvellous achieve-

Among the players he beat in Candidates was the young R Praggnanandhaa. Both youngsters have idolised the legendary Viswanathan Anand.

# Grandmaster Gukesh wins Candidates Chess Tournament



TORONTO, April 22: India's 17year-old Grandmaster D Gukesh scripted history by winning the Candidates Chess Tournament here to become the youngest ever challenger to the world title, bettering a record created by the legendary Garry Kasparov 40 years ago.

Gukesh played out an easy draw with American Hikaru Nakamura in the 14th and final round to finish with nine out of a possible 14 points in the tournament that is held to decide the challenger to the world champion.

The triumph entitles Gukesh a clash against reigning world champion Ding Liren of China in the last quarter of the year.

The Chennai-based teen bettered Kasparov's record by quite a distance as the Russian great was 22 when he qualified in 1984 to clash with compatriot Anatoly Karpov.

"So relieved and so happy. I was following this crazy game (between Fabio Caruana and Ian Nepomniachtchi), and then I went for a walk with my second (Gregorz Gazevsky), I think that helped," Gukesh said after winning. Gukesh also won a cash award of 88,500 Euros (approx Rs 78.5 lakh). The total prize fund of the Candidates was 5,00,000 Euros. He became only the second Indian after the great Viswanathan Anand to win the prestigious tournament. Five-time world champion Anand's triumph came in 2014.

"Congratulations to @DGukesh for becoming the youngest challenger. The @WacaChess family is so proud of what you have done . I'm personally very proud of how you played and handled tough situations. Enjoy the moment," Anand posted on 'X' to congratulate the youngster, who like him, also hails from Chennai.

Needing at least a draw, Gukesh gave nothing away to Nakamura, a clear signal that the teenager is ready for the big stage and is going to be the next biggest star in the chess world.

The black pieces did not matter much as Nakamura was at sea in the Queen's Gambit Accepted and did not find any ways to pursue playing for an advantage.

Gukesh won a pawn and Nakamura had to find the path to equality in the ensuing rook and Bishop's opposite coloured endgame. The game lasted till move 71 but the result was never all eyes were on the match between American Caruana and Russia's Nepomniachtchi.

...those 15 minutes were probably the most stressful of this entire tournament, I was watching the commentary for sometime and then me and Gajevsky (his trainer) went for a walk and then my father came running," Gukesh revealed.

"Obviously the support system is huge, coming to my team I would not like to take their names but they know how grateful I am to them," he said.

The American outplayed Nepomniachtchi right from the opening and enjoyed a nearly winning position for several moves.

Things were far from over though, Caruana built his position all over again and was close to winning a second time when again his clock deceived him and he failed to find the correct continuation. The resulting position was a drawn queen and pawns endgame where Caruana kept pressing to no won, the tournament would have needed a tie-break as Gukesh and the winner would have ended up in ioint lead.

Caruana, Nepomniachtchi and Nakamura all ended on an identical 8.5 points for the shared second place while Indian Grandmaster R Praggnanandhaa ended fifth on seven points defeating Nijat Abasov of Azerbaijan.

Vidit Gujrathi played out a quick draw with Firouzja Alireza of France in the final round to end on the sixth spot with six points in all.

Alireza finished seventh on five oints while Abasov ended last on 3.5 points in all. Gukesh has been making waves

for a while now after becoming the third youngest in chess history to earn the Grandmaster title at the age of 12. He later became the youngest to achieve an ELO rating of 2750. The youngster's father Rajnikanth, who is an ENT surgeon but has stopped his practice to nurture Gukesh's chess dreams, accompanied him to the tournament. His mother Padma is a microbiologist. Last year, Gukesh won a silver medal at the Hangzhou Asian Games. (PTI)
