Thunderstorm claims 4 lives in state

GUWAHATI, April 1: Four persons were killed and nearly 53,000 people affected as a thunderstorm wreaked havoc in the state, officials said on

A four-year-old child died and two persons went missing after a boat capsized in the Brahmaputra in South Salmara-Mankachar district on Sunday night, while one each died in Cachar, West Karbi Anglong and Udalguri in storm and lightning related accidents.

Union home minister Amit Shah spoke to chief minister Himanta Biswa Sarma over the phone to enquire about the situation in the state and assured him of all assistance.

The storm accompanied by a downpour lashed several parts of the state on Sunday evening, uprooting trees and electric poles and damaging houses, Assam State Disaster Management Authority (ASDMA) CEO Gyanendra Dev Tripathi said.

"A country boat sank at 5 pm yesterday at Nepurer Alga village while heading to Nepurer Alga ghat from Sishumara ghat. A child's body was recovered by locals and two people are missing," he told PTI.

The deceased has been identified as Samin Mondal (4), while Kobat Ali Mondal (56) and Is-



mail Ali (8) are missing, Tripathi said. "An SDRF team started a search operation this morning and deep divers from Dhubri and Goalpara districts also joined them. An NDRF team is

en-route to the site to assist in the rescue efforts."

Kejriwal called AAP national treasurer confused: ED

NEW DELHI, April 1: Delhi chief minister Arvind Kejriwal called his party's national treasurer 'confused' when he was confronted with his statement on issues related to the affairs of the Aam Aadmi Party (AAP), the Enforcement Directorate claimed before a court on Monday.

The special Prevention of Money Laundering Act (PMLA) court of Judge Kaveri Baweja sent the 55-year-old Kejriwal, also the national convener of the AAP, to judicial custody till April 15 in connection with the money laundering probe linked to alleged irregularities in the Delhi excise policy for 2021-22, which was later scrapped. He was brought to Tihar jail and will be lodged in jail number 2.

The ED also alleged that Kejriwal, during his questioning, said AAP communication in-charge Vijay Nair "did not report to him" but to his cabinet colleagues Atishi and Saurabh Bharadwaj and that

ited". Nair was arrested in this case by the ED.

The federal agency charged Kejriwal, in its application filed while seeking his judicial custody, of being "evasive", giving "misleading replies" and "concealing information" during his questioning in the remand period after his arrest on March 21.

It has earlier called him the "kingpin and key conspirator" of the alleged scam.

The AAP and its leaders have repeatedly denied the charges of wrongdoing, with Kejriwal alleging that the case was built by the BJP-led Centre to create a "smokescreen" that the AAP is a corrupt

China releases 30 more names for places in Arunachal Pradesh

BEIJING, April 1: China has released a fourth list of 30 new names of various places in Arunachal Pradesh amid Beijing's steppedup assertions in recent weeks to re-emphasise its claim over the Indian state.

India has been rejecting China renaming places in Arunachal Pradesh, asserting that the state is an integral part of the country and assigning "invented" names does not alter this re-

The Chinese Ministry of Civil Affairs released the fourth list of standardised geographical names in Zangnan, the Chinese name for Arunachal Pradesh which Beijing claims as part of south Tibet, state-run Global Times reported on Sunday.

The official website of the ministry posted

30 additional names for the region. Set to take effect from May 1, the implementation measures stipulate in Article 13 that "place names in foreign languages that may harm China's territorial claims and sovereignty rights shall not be directly quoted or translated

without authorisation," the report said. The Chinese Civil Affairs Ministry released the first list of the standardised names of six places in Zangnan was released in 2017, while

the second list of 15 places was issued in 2021 followed by another list with names for 11 places in 2023.

The recent statements by China to reassert its claims over the state started with Beijing lodging a diplomatic protest with India over Prime Minister Narendra Modi's visit to Arunachal Pradesh, where he dedicated to the nation the Sela Tunnel built at an altitude of 13,000 feet in Arunachal Pradesh.

The tunnel will provide all-weather connectivity to strategically located Tawang and is expected to ensure better movement of troops along the frontier region.

India set to experience extreme heat during April-June, with central, western peninsular parts bearing the brunt Increasing heat unlikely to impact wheat crop, says IMD

NEW DELHI, April 1: The increase in temperatures will not have any impact on the harvest-ready wheat crop, the Indian Meteorological Department (IMD) said on Monday.

India is set to experience extreme heat during the April-June period, with the central and the western peninsular parts expected to face the worst impact, IMD director general Mrutyunjay Mo-

hapatra said during a press conference. The Met office said maximum temperatures are very likely to be above normal by 2-3 degrees Celsius over many parts of north India and the east and the west coasts, and near normal over the rest of the country, during the wheat harvesting period.

However, there is no heat wave warning for wheat producing states, except Madhya Pradesh, the IMD chief

"Temperatures are around 37-40 degrees Celsius in Madhya Pradesh at present and are likely to go up to 42 degrees next week. Since 90 per cent of



the wheat harvesting in the state is over, there will be no effect," he said, citing data from the Union Ministry of Agri-

culture and Farmers Welfare. Even if temperatures go above 35 degrees Celsius, there will be no impact in Punjab, Haryana and Uttar Pradesh,

India produced 110.55 million tons of wheat during 2022-23. Of this, Uttar Pradesh accounted for 30.40 per cent, Madhya Pradesh 20.56 per cent, Punjab 15.18 per cent, Haryana 9.89 per cent and Rajasthan 9.62 per cent.

pacted the wheat crop in India in 2022, with production declining to 107.7 million tons from 109.59 million tons in 2021. This prompted the country, the world's second-largest wheat producer, to ban exports.

The wheat crop is sown in October, and harvesting in most parts begins around April.

The IMD reported that 80-85 per cent of the wheat crop was sown either early or timely between October 25 and November 30, with climate-resilient varieties planted over 70 per cent of the

This year, wheat production is expected to be around 112-114 million tons. Government data shows that the country's wheat production increased from 99.87 million tonnes in 2017-18 to 110.55 million tonnes in 2022-23, and the area under wheat cultivation rose from 29.67 million hectares to 31.78 million hectares during the period. Local shopkeepers and markets attributed the price rise of potatoes to the upcoming Lok Sabha elections. PM says growth should be RBI's top most priority next decade, with trust and stability

MUMBAI, April 1: The Reserve Bank has to accord "top-most priority" to growth and at the same time focus on trust and stability, Prime Minister Narendra Modi said on Monday

Addressing the inauguration of the event commemorating 90 years of the Reserve Bank of India (RBI) here, Modi said the next decade is as important for attaining the goal of developed India as it is for the RBI, which will complete 100 years of existence in 2035.

Modi said as per the "mantra" of the central bank, "The RBI should make fast growth its top-most priority, along with focusing on trust and stability.

Since 2016, keeping inflation under check has become the primary goal of the RBI. Often, there are voices who have pitched for additional attention to growth through measures like rate cuts.



The comments come days ahead of the first monetary policy review of the new fiscal year.

Modi said the "reflection" of double-digit inflation rate was not visible in the financial policies earlier, and claimed credit for giving the RBI the rights to take decisions to curb inflation.

The six-member monetary policy committee (MPC) has also done some very good work on its mandate over the years, Modi said.

The government's efforts, including delivering on fiscal consolidation and active price monitoring, also helped in the cooling of inflation, he added.

Modi said inflation is at a "moderate level", despite the Covid pandemic or the challenges posed by wars in various countries.

India followed a path where it took care of both financial prudence concerns and also the requirements of the common man during the pandemic, he said.

At a time when many countries of the world are still struggling to come out of the shocks suffered during the pandemic, the Indian economy is creating new records,

He said balancing inflation control and growth is a unique need for every developing country and urged everybody to study the right monetary tools to wrestle with this challenge

The PM said the RBI can create a model and play a leadership role that will help the broader Global South. (PTI)

Huts, schools, shops, Anganwadi centres and other institutions have been damaged across the state, while scores of vehicles were damaged when trees fell on them.

An official said that hundreds of visitors were stranded inside Garbhanga Reserve Forest near Guwahati till the early hours as the entire road was blocked by uprooted trees. "The SDRF and district administration carried out rescue operations till around 3 am and cleared the road. Hundreds of people were visiting the forest as it was a Sunday," he said. People faced a harrowing time in reaching their destinations with many roads blocked till this morning by uprooted trees and electric poles. Besides Sarma, Shah spoke to the chief ministers of West Bengal and Manipur in the wake of severe losses suffered by the three states due to the storm and assured them of all possible help from the Centre. Shah also appealed to the BJP workers in the three states to provide every possible help to the affected people during this hour of distress.

Sarma said, "His assurance of full support and assistance for relief and rehabilitation on behalf of the Indian government is deeply appreciated." The chief minister's office said on X that Sarma was constantly monitoring the impact caused by heavy rains and storm, while the State Emergency Operation Centre was coordinating round the clock with all the district administrations. The storm also caused damage to the terminal building of the Guwahati airport, forcing the authority to halt operations for some time and divert six flights to other destinations. (PTI)

Kejriwal called AAP

(practising CA and former president of Institute of Chartered Accountants of India) in his statement has revealed that it is the national convenor Sh Arvind Kejriwal who appoints the state election in-charge/prabhari," it said. "State prabhari is supposed to manage all election campaign related matters. In case of Goa elections Sh Durgesh Pathak (AAP MLA) was chosen. However, Sh Arvind Kejriwal states that it is the PAC (Political Affairs Committee) which decided the state election in-charge," it said.

The ED claimed that Kejriwal first told it that N D Gupta, also a Rajya Sabha member of the AAP, is an "active member of the party and is a member of the PAC and has knowledge of the party functioning but when confronted with the statement of Sh N D Gupta wherein he (Gupta) reveals that the national convenor takes such decisions, Sh Arvind Kejriwal calls the National Treasurer confused".

The agency has alleged earlier that Nair, on behalf of AAP leaders, has received kickbacks to the tune of ₹

100 crore from the 'south group' liquor lobby that allegedly involves BRS leader K Kavitha and others. It had also claimed that Nair "arranged a video call through facetime (a video calling facility on iPhone) on his phone for Sameer (Mahandru) and Sh Arvind Kejriwal, where Sh Arvind said to Sh Sameer that, Vijay is his boy and that Sh Sameer should trust him and carry on with him".

Sameer Mahandru, a liquor businessman, was arrested in this case by the ED. The ED said it asked Kejriwal why Vijay Nair was staying in the bungalow of a cabinet minister (Kailash Gahlot) and worked at the CM's camp office but he claimed "unawareness" about the persons who worked at his camp office. The agency said Kejriwal was shown "evidence" about more than 10 meetings that Nair had with other co-accused named in this case like liquor manufacturers, wholesalers, retailers and even "middlemen" like Dinesh Arora and Abhishek Boinpally and was asked under what authority was he attending these meetings?

It said Kejriwal "evaded" the question by saying he was unaware about these persons. The ED said the CM again claimed ignorance when he was shown various "evidence" of ₹ 45 crore worth hawala transfers to Goa, which the agency has claimed was meant for the party's poll campaign in the state. It asked the court not to release Kejriwal as he was "highly influential and there was every likelihood that he would "influence the witnesses and tamper with the evidence".

The excise case pertains to alleged corruption and money laundering in formulating and executing the Delhi government's now-scrapped excise policy for 2021-22. Delhi Lieutenant Governor V K Saxena recommended a CBI probe into the alleged irregularities in the formulation and implementation of the liquor policy. Subsequently, the ED registered a case under the PMLA. (PTI)

Cong leaders 'a call

asked if more Congress leaders are in queue to join the ruling party as several leaders and workers from the opposition party have joined BJP over the last few weeks. Asked about two women Congress MLAs Nandita Das and Sibamoni Bora, who are campaigning for the party candidates, Sarma suggested their willingness to switch sides but noted the limitations on calling everyone.

On state Congress chief Bhupen Kumar Borah reportedly filing a defamation case against him, Sarma said he has been saying only good things about the opposition leader. "Case is filed when defamation happens. But here, I have said he can be the chief minister. I am giving him an elevated position. How can that be defamatory?" Sarma questioned back. He also reiterated his assertion that Borah will join the BJP by early next year.

On the issue of opposition parties fielding candidates against each other despite initial collaboration, Sarma remained unfazed, attributing the electorate's focus solely on Prime Minister Narendra Modi's leadership

"The only factor in this election is Modi ji. Everyone wants to make him the PM again. The result will be same even if all the opposition parties come together," he said, exuding confidence of the BJP-led alliance sweeping the elections in the state as well as the entire country.

Highlighting development efforts in Majuli, Sarma outlined plans for infrastructure projects, including bridges and a hospital combining allopathic, naturopathic, and ayurvedic treatments. (PTI)

it was not that easy. We raised this issue strongly before Russia, be it our Ambassador in Moscow or our external affairs secretary meeting the Russian Ambassador in New Delhi," said the external affairs minister. He said India's stand is very clear on this issue. "This is totally wrong. An Indian must never serve in some other country's army. If any middlemen are involved in hiring Indians, then it is the responsibility of Russia to stop them. We are trying to bring back nearly 23 to 24 Indians who are still there," Jaishankar added.

Responding to Ladakh-based climate activist Sonam Wangchuk's allegation that China has encroached upon Indian territory, Jaishankar said the Indian Army knows what to do in such situations.

"Every activist has his own thoughts. See, you all know that our Army is already deployed there to stop any attempt of infiltration along the Line of Actual Control. The Army knows what they are supposed to do," he said. Queried on the progress made in signing a Free Trade Agreement with the European Union (EU), he said negotiations are underway because India is also keen to sign the pact so that the country's textile industry gets a levelplaying field in Europe. On the issue of Indian baby girl Ariha Shah, who has been in the custody of German authorities since 2021 when she was just seven months old, Jaishankar said efforts are on to bring her back.

He also said, "We are trying to see that her custody is given to an Indian couple if not her parents". "We have been raising this issue with the German government for some time. I have also met with the parents of the girl. However, since the matter is in court there, it will take some time. Some progress has been made so far. Our embassy officials met her and tried to familiarise her with Indian culture," Jaishakar added. (PTI)

No coercive action against

At the outset, Mehta said, "To balance the equity. The petitioner is a political party. Based upon the 2016 judgement, which is under challenge, we have raised the demand of ₹ 1700 crore. Since the election is going on we would not like any problem to arise for any party and therefore, till the matter is heard after the election, we will not take any action for recovery of ₹1700 crore.

He said that the impugned judgement of the Delhi high court is of March 23, 2016, and based upon the parameters set by it, a tax demand was raised against the party in 2021. "They were given an option to pay 20 per cent of that demand but they did not avail. Thereafter, nothing was paid. Therefore in 2024, we recovered ₹ 135 crore of 2021 demand and based upon the same parameters, now we have issued a demand of ₹ 1700 crore approximately." Mehta submitted He added that the I-T department has a lot to say on the merit of the issue and they would like to file a reply

to the main petition filed against the high court's verdict. Justice Nagarathna asked Mehta whether the demand notices were the subject matter of the petition. Mehta replied, "No, that is not the subject matter of the petition." Elaborating on the sequence of events,

Mehta said in 2016, the high court gave the judgement and laid down parameters. "Based upon that we (I-T department) have raised the demand of ₹ 135 crore and it is recovered. Now, based upon that very parameter which has been laid down by the high court in 2016, in different proceedings for different reasons, which I am not going into because that will muddy the water, but I have much to say, we have raised the demand of ₹ 1700 crore," he said. (PTI)

Modi backing lawyers letter about 'vested interest group' betrays a sinister plot

n an unprecedented move, over 600 lawyers penned a letter to the Chief Justice of India, raising alarms about a 'vested interest group' allegedly attempting to influence the judiciary's decisions, particularly in cases involving political figures and corruption. This letter has garnered significant attention, not least because of the Prime Minister's endorsement, which he framed as a critique of the opposition's tactics, labelling it as 'vintage Congress culture'

The letter, dated March 26, accuses this unnamed group of employing tactics that threaten the democratic fabric and the trust placed in judicial processes. The signatories, which include eminent advocates like Harish Salve and Manan Kumar Mishra, express deep concern over the propagation of false narratives aimed at discrediting the judiciary and undermining public confidence in the courts. The Prime Minister's support of the letter on social media adds an intriguing twist to the whole issue. While Modi has ostensibly used it to attack Congress, it may be part of a subtle game to shape public opinion in favour of the ruling party. And in many ways, the development is a reflection of the increasingly fraught relationship between the judiciary and the executive in

The letter as well as the Prime Minister's subsequent endorsement have sparked a debate on the independence of the judiciary and the role of the executive in safeguarding or undermining this principle. The opposition has countered the Prime Minister's support for the letter, accusing him of attempting to 'give legal guarantee to corruption.' The timing of the letter is also significant, coming as it does amidst a back-

drop of several high-profile judgments and ongoing cases that have implications. The political lawyers' letter alleges 'bench fixing', disrespectful comparisons of domestic courts to those in lawless regimes, and direct attacks on judges' honour. These are serious charges that, if true, could have far-reaching consequences for the rule of law in India. The Prime Minister's backing

of the letter has been interpreted by some as an attempt to discredit verdicts in cases that may not go in favour of the government. By framing the narrative around a 'vested interest group' trying to influence the judiciary, the ruling party can potentially discredit unfavourable judgments as being influenced by this group, rather than as independent decisions of the court. The letter and the Prime Minister's response must be viewed in the broader context of attempts to hijack public opinion. The ruling party has been using various means to shape public discourse in its favour, from influencing media narratives to the use of social media for political propaganda. The endorsement of the letter by the Prime Minister can be seen as part of this larger strategy to control the narrative and reinforce the government's position.

The implications of this episode are profound. It raises questions about the integrity of the judicial process and the independence of the judiciary, which are cornerstones of a functioning democracy. It also highlights the challenges faced by the judiciary in maintaining its autonomy in the face of political pressure. The support of the Prime Minister for the letter could be seen as an endorsement of the judiciary when it aligns with the government's views, but it also raises concerns about the potential for executive

The development no doubt

points to attempts being made on the sly to influence judicial decisions in important cases. This was clearly seen in action when the constitutional bench was handling the electoral bond case in which the government suffered a series of setbacks. The government and its supporters tried everything in the book, and outside of it, to prevent details from coming out ahead of the elections so as to save further embarrassment to the ruling party.

First, senior Supreme Court advocate Adish C Aggarwala, who is also the president of the Supreme Court Bar Association (SCBA) and the All India Bar Association (AIBA), caused consternation when he wrote to Chief Justice D Y Chandrachud urging him to suo motu review the Supreme Court's direction that the poll panel shall publish the information shared by the State Bank of India on its official website in the electoral bonds case on the ground that the abrupt disclosures will have an adverse impact on the donors. A couple of days prior to that he had written to President Droupadi Murmu urging her to seek presidential reference of the apex court judgement in the electoral bonds scheme case and not to give effect to it unless the top court has reheard the matter. The Supreme Court Bar Association, however, distanced itself from Aggarwala's demand, saying

his conduct was not authorised. This has also to be seen in the context of major industries associations Federation of Indian Chambers of Commerce and Industry (FICCI), Associated Chambers of Commerce and Industry of India (ASSOCHAM) and Confederation of Indian Industry (CII), seeking to defer the disclosure of electoral bond unique identification numbers, pointing to an orchestrated campaign against the truth coming out in the electoral bond case. Integrating paratransit to address India's The era of the silenced urban transport concerns

ncreasing urbanisation has altered travel patterns and increased trans-Learn Learn Enhanced mobility needs have led to an explosion of two- and four-wheelers, exacerbating urban transport and environmental challenges. Despite government initiatives to develop public transport systems, insufficient capital investments and persistent infrastructural deficits in most cities have widened the gap between transport planning and execution. Consequently, only a few large cities benefit from extensive transport systems, while people in smaller cities and towns grapple with limited or no public transport options.

Such dichotomy has catalysed the emergence of paratransit or Intermediate Public Transport (IPT) services in urban India. Privately owned and informally operated, they offer shared mobility typically facilitated by three-wheeled auto rickshaws with a capacity of three to six passengers per vehicle. Paratransit services, encompassing both point-to-point (P2P) and shuttle services between fixed origins and destinations, constitute a significant portion of shared trips, especially with increasing app-based 'shared mobility' solutions offered by companies like Ola, Uber, and many more. These apps aggregate shared vehicles, including motorcycles, taxis, three-wheelers, and twowheelers, to serve rental as well as on-demand mobility needs.

Paratransit scenarios in Indian cities Paratransit vehicles in India include for-hire light motor vehicles (LMVs), taxis, and two-wheelers. According to the Ministry of Road Transport and Highways (MoRTH) data, LMVs, taxis, and two-wheelers for hire accounted for 26 percent, 12 percent, and 1 percent of the 25.89 billion vehicles registered in 2019. While three-seaters constitute 67 percentage of the total LMVs, four-to-six-seaters constitute nearly 33 percent respectively.

Additionally, registered taxis such as motor cabs, maxi cabs, or other variants also serve paratransit needs. Ola and Uber offer shared and rental cab, autorickshaw, two-wheeler, and taxi services across more than 75 Tier 1 and II cities in India. Other companies such as Meru, BluSmart, Quick Ride, and Lyft also provide shared and rental cab services nationwide. Established in 2006, Meru

operates in 24 cities, while BluSmart, Policy interventions to integrate founded in 2019, operates in 10 cities. Quick Ride serves nine Tier I cities in India, and Lyft, which was launched in 2021, operates exclusively in West Ben-

Rapido commenced operations in 2015, offering bike and taxi services in 100 cities and auto rickshaws in 26 cities. Another significant player, Jugnoo, has provided cab and auto rickshaw services in 50 cities since 2014.

While the average modal share of paratransit services is 25 percent of the total motorised trips, it exceeds the use of public transport by ninefold in most smaller- and medium-sized Indian cities. This trend indicates the significant dependence of city dwellers on paratransit services as a convenient mode of trans-

Challenges to paratransit

The paratransit system in India primarily encompasses three principal stakeholders: users, paratransit operators (comprising auto rickshaw drivers and shared mobility service providers), and the government. Auto-rickshaw drivers face many challenges, including internal competition, meagre monthly earnings, non-revenue-generating kilometres, elevated maintenance expenses, obligatory payments to traffic authorities for operational purposes, exposure to environmental pollutants, and the deficiency of fundamental infrastructure, including designated stands and parking facilities.

Conversely, shared mobility providers encounter obstacles such as operational deficits, lack of comprehensive policy frameworks and regulatory guidelines, inadequate supporting infrastructure such as designated pick-up and drop-off locations, and societal preference towards private transportation modes. They are also often accused of unprofessional driver behaviour, fare overcharges, safety deficiencies, subpar travel experiences, prolonged wait times during peak hours and reliance on cash transactions, among

The government, as a key stakeholder, also grapples with concerns regarding paratransit services, including heightened competition vis-à-vis the formal transit system, resultant declines in transit ridership, exacerbated traffic congestion, resistance from union entities towards policy enforcement and escalated levels paratransit systems

Paratransit services have been a contentious topic of sustainable urban transportation in metropolitan areas. As feeders or complementing formal transportation networks, these services have spurred debates regarding their efficacy. Notably, Tier I and II cities of India, where formal transit systems were introduced at later stages, witness a conflict of interest between paratransit services and formal transportation modes—paratransit services are often found competing with, rather than complementing the extant formal public transport system. Regardless, paratransit systems play a pivotal role in developing economies like India, facilitating the realisation of sustainable and integrated multimodal transport systems within urban landscapes.

The current situation underscores the urgent need for a comprehensive policy and regulatory framework to govern paratransit services effectively across Indian cities. Present policy formulation concerning auto-rickshaws exhibits shortcomings, failing to adequately consider the needs of the drivers who provide a valuable and cost-effective transportation service. The absence of coordination and communication among diverse governmental bodies and stakeholders involved in regulating and managing paratransit services impedes effective policy implementation.

The National Urban Transport Policy emphasises the integration of diverse urban transportation modes. Still, it fails to delineate strategies for integrating paratransit services with formal transit systems, which are critical to addressing first and last-mile connectivity gaps within urban transit networks. Achieving seamless operational, informational, institutional and fare integration between these systems necessitates heightened at-

Moreover, the quality of paratransit services suffers from a lack of formal training and skill development initiatives, hindering service excellence. Enhancing the professionalism and service quality of paratransit operators through comprehensive skills development and training initiatives is imperative for the successful execution of policies aimed at fostering sustainable and efficient urban transportation systems across cities. A robust monitoring and evaluation framework is essential to facilitate timely adjustments and enhancements, fostering effective policy interventions. The absence of comprehensive data on policy impact contributes to a lack of accountability and ability to make well-informed future policy decisions.

Implementing institutional frameworks, such as Public Transport Authorities (PTAs), emerges as imperative for ensuring cohesive governance and regulation across diverse mobility modes in urban India. A Public Transport Authority (PTA) or a Public Transport Council (PTC) assumes responsibility for pivotal policy determinations, including service standards spanning various transportation modalities.

It formulates a comprehensive multimodal public transport blueprint tailored to the city's needs. The PTA/PTC is tasked with issuing contracts to operators, mandating that services are aligned with pre-defined service schedules and mutually agreed terms of remuneration. Such a structured approach will foster efficiency and accountability within the public transport sector, enhancing of urban mobility standards.

Furthermore, the prevailing regulations for shared mobility solutions position them as contenders to the established auto-rickshaw services. Consequently, the regulatory frameworks such as 'Aggregator Rules' and 'Taxi Regulation' of various municipalities put permit limitations and minimum fare regulations in place to mitigate competition with alternative shared modes. Conversely, the 'Taxi Guideline' delineated by the Ministry of Road Transport and Highways (MoRTH) advocate for a more inclusive approach, framing shared mobility as a component of the solution rather than a contributor to congestion issues.

Cities must consider shared mobility services as on-demand solutions capable of diminishing reliance on personal vehicular transportation rather than direct competitors to public transit. Models like 'Mobility as a Service (MaaS)' implemented in cities such as Vienna and Helsinki exemplify effective integration of 'new mobility' solutions with formal public transport networks. cademic freedom has become a central issue of concern in India. Many have blamed the illiberal political climate in the country and the quality of individual institutions in question for the decline in academic freedom. While all of these are important factors, the question of academic freedom is complex and cannot be easily answered.

Not many have, nevertheless, noticed the V-Dem Academic Freedom Index (AFI) published in 2023 in which India is ranked in the bottom 20-30% category below countries such as Libya, Pakistan, Ethiopia, Chad, Bhutan, Ukraine, and Palestine. In the 2024 report published a few days ago, India is further pushed to the 10-20 % category placed between Rwanda and South Sudan.

The situation is so dire that even the reputed institutions do not fully comprehend, practice, and respect academic freedom as a fundamental right. Faculty members can get fired for reasons as silly as publishing a critical piece, supporting a cause, clothing in certain ways and even smoking! So, what explains

Medieval India and Europe India and the West historically

had two distinct traditions of education. Colonial experience, however, changed the way India learned and taught.

India had a number of great universities, many of them centuries older than any in the West. Some of them, such as Nalanda and Taxila, attracted scholars from across the globe. India had its share of brilliant rational and materialistic thinkers, mathematicians, scientists, and geographers.

After this glorious era, the Indian system of higher education began to decline into mindless ritual and repetition. It became regimented along the lines of caste and a strict code of conduct came into place that opposed the spread of enlightenment. The notorious edicts in Manusmriti and other ancient texts embody this decay.

As a result, education merely enabled a person to become the guarantor and maintainer of tradition and not its challenger, disruptor, or reformer. It emphasised rote learning and ritual while discouraging creativity. It routinely punished students for questioning authority and ritual. Critical thought was suppressed as feudal allegiance was constantly demanded.

The West, on the other hand, followed, with steadfast astuteness, the ancient Greek tradition of education. It was largely secular and focused on the individual rather than communities. Massive events such as the French Revolution made sure that education shaped the public by enhancing enlightenment and reason. While this was in no way perfect, the freedom to think and publish was cherished and promoted. The separation of church and state led to more secular and rational thought.

Modern higher education in India

The persistent nature of the ancient Indian tradition insisted that children take up their parents' professions. Even those educated in the West came back to settle in India, keeping the ancient rules of privilege intact. Education was either a means to achieve 'a dream job' or a choice of the parents.

It was rarely a process of enlightenment. Even in modern India, everyone expected students to follow their parents' footsteps. An engineer's child becoming an engineer, a professor's child becoming a professor, and a doctor's child becoming a doctor was still the norm. There were no laurels for unsettling the apple cart in India.

Modern India witnessed attempts from progressive sections to educate people from all quarters of society – people from lower-castes. workers, women, rural folk which yielded mixed results.

The modern democratic state, with a constitution that promised equal rights to all, aspired to usher in a revolution. Dr. B.R. Ambedkar recognised early on that political democracy hinges upon social democracy and that social democracy is closely linked to equal opportunities for all – including the opportunity to study. Whatever little has been achieved today is a result of this effort.

Modern science evolved with the strength of values such as falsifiability, objectivity, proof, and, finally, the concept of peer review. Whatever is not supported by proof is not acceptable. Similarly, concepts like equality, fraternity, freedom, rights, rule of law, aesthetics, and many more complex ideas came to define the humanities and social sciences scholarship.

What exactly are the institutions of higher education and how are they different from other institutions such as a home, village, city, neighbourhood and residential societies? Universities could very well belong to what the French philosopher Michel Foucault elaborated as heterotopia pr the 'other places'. Universities are where new ideas are tested and that testing requires encouragement and a collaborative atmosphere. What one cannot discuss at home or in society, one must be able to discuss at the university.

Institutions like like Jawaharlal Nehru University (JNU) and visionaries who founded aspirational universities such as Rabindranath Tagore (Visva Bharati), Jamsetji Tata (IISc), and Sir Syed Ahmed Khan (Aligarh Muslim University) were attempting to create enlightened spaces. Nevertheless, the spirit of academic freedom and free inquiry has petered out gradually. Most other universities, however,

had no such ambitions. Some of them have been wary of imbibing the harder part of the idea of a university. Others were simply unaware that the idea of a university was a far deeper one than they had initially imagined and no number of glittering edifices would be able to capture it. Yet others were there for purposes unrelated to enlightenment in the first place.

All of these led to an atmosphere of scepticism and fear among academics who constantly worried about the implications of their work and indulged in self-censorship. A large number of them have been weak and vulnerable. This nagging fear of retribution led to silence marking the times, what I call the 'era of the silenced academic'. This situation is even more alarming in the private universities where no job security is assured. Interestingly, it was all very much in line with what a traditional Indian family taught its kids: "be a good child and never question your

The era of the silenced academic augmented the process of anti-enlightenment skilling in disciplines not limited to engineering, medicine, and information technology. A large number of coaching institutes and ed-tech businesses followed. All that mindless drilling took a heavy toll on the mental health of students and ultimately paved the way for a society where independent thought is penalised.

In the process, the idea of a university changed too. A university has become a place where the government in power is venerated by sycophants. The word 'critical' though widely used as in 'critical theory', aroused suspicion. The last decade under the current regime, which is opposed to criticism of any kind, streamlined the process that was already underway. A vicious government, lack of occupational freedoms and securities, and deep socio-cultural intolerance have all contributed to the frozen silence of the Indian academic.

The way forward

India must think of a system that defines the rights, tenure, duties, and privileges of academics and make its academic pillar as strong as the judicial, executive, and the legislative ones. The 1915 Declaration of Principles – a document that proclaimed the principles regarding freedom of speech and tenure - by the American Association of University Professors is one such example. This document remains the Magna Carta for the western academic system.

If India wants to produce some excellent universities and aspires to become a genuine Vishwa Guru, a teacher of the world, it should strengthen its academic pillar. The government and the academic bureaucracy should enable this process wholeheartedly instead of getting insecure about academics critiquing the system. They should realize that critical thought is a product of great value and nothing else can compensate for it. Constant governmental intervention in the everyday life of universities must stop.

More importantly, ensuring job security and regular, decent payment for academics across different kinds of institutions - public, private and institutions where the two work in partnership – is a necessary and unavoidable first step. Legal protection must be ensured to make this work.

Ad hoc exploitation of teachers and temporary appointments must give way to regularised positions. Academic appointments must be made fair and academic institutions should be better regulated to make sure that a fair and open internal system is always maintained.

It is high time India turns an ancient, regimented nightmare into an inclusive, rational, and democratic dream. The era of the silenced academic must end, and the time has come for the academics to fearlessly express their views. (Courtesy: The Wire)

An avocado a day may improve diet quality, researchers suggest habits may overlook the importance of nutritional di-

n the United States, many adults have poor diet quality and do not meet key dietary recommendations provided by the Dietary Guidelines for Americans. With poor diet quality being the leading risk factor for cardiometabolic diseases, this increases the risk for chronic health conditions that are among the leading causes of death.

Finding ways to improve diet quality in the general population is crucial for promoting better health out-

Now, a recent study from Penn State University analyzed the impact of a food-based intervention daily avocado intake - on diet quality and cardiometabolic risk.

The findings, published in Current Developments in Nutrition, revealed that consuming one avocado daily for 26 weeks improved adherence to the Dietary Guidelines for Americans among adults with abdominal obesity. However, the changes in diet quality did not directly influence cardiometabolic disease risk factors

What happens if you eat an avocado every day? In this 26-week, multi-center, randomized controlled trial, researchers studied 1,008 participants aged 25 and older with abdominal obesity and typically low avocado intake.

Participants were divided into two groups. One group was provided with a daily supply of one avocado (approximately 168 grams) and received guidance on how to include it in their daily diet. The other (control) group was asked to maintain their usual dietary habits, limiting their avocado consumption to two or fewer per month, and received no dietary counselling.

Diet quality was evaluated through unannounced 24-hour recalls at various intervals during the study, and scored with the Healthy Eating Index-2015 (HEI-2015) to measure adherence to dietary guidelines.

As per the USDA's classification, this clinical trial considered avocado servings — one-half cup chopped or approximately 75 grams — as part of the total vegetable component in the HEI-2015 scores.

The participants' cardiometabolic disease risk factors, including visceral fat volume, liver fat fraction. C-reactive protein, metabolic syndrome criteria, body weight, body mass index (BMI), insulin, VLDL cholesterol, and the total cholesterol to HDL cholesterol ratio, were also monitored to understand the effects of daily avocado consumption on these factors.

Daily avocado consumption linked to improved

During the study, researchers found that individuals who consumed avocados daily showed a "potentially clinically relevant" increase of 4.74 points in their HEI-2015 scores compared to the control group that consumed their regular diet.

This improvement was mainly attributed to an increase in total vegetable intake and a more favourable ratio of unsaturated to saturated fats, both of which were directly related to daily avocado consumption.

In comparison to the control group, individuals who consumed avocados daily did not show any significant difference in their intake of saturated or polyunsaturated fats.

However, their consumption of monounsaturated fatty acids (MUFAs) increased by 13 grams per day, which was almost equivalent to the MUFA content of the avocados provided to them (17 grams).

Despite an overall increased adherence to the dietary guidelines with daily avocado consumption, these dietary improvements did not lead to significant changes in cardiometabolic disease risk factors over the 26-week period, the study authors found. Effects of diet quality on cardiometabolic

Studies have consistently shown that enhancing the quality of the diet over time leads to a lower risk of cardiometabolic diseases and mortality.

The authors of the present study proposed two explanations for why their findings did not align with the scientific consensus on diet quality and disease

First, the intervention period of 26 weeks may have been too short to change these risk factors sig-

Second, the study participants' initial diet scores were poor and slightly below average. So, despite a notable improvement in diet quality, the follow-up diet scores still received an "F," the lowest grade.

Therefore, it is unlikely that the overall diet quality was high enough to have a significant impact on cardiometabolic risk factors.

According to Alyssa Simpson, registered dietitian and owner of Nutrition Resolution, not involved in the study, further limitations arose from the study's non-blinded design; potential biases associated with self-reported dietary intake, and restricted generaliz-

Avocado consumption may lead to healthier food choices

Considering the methodology and avocados' nutritional composition, it's not surprising that avocado consumption was found to enhance diet quality scores, especially in terms of total vegetable and fatty acid components.

"Avocados are rich in monounsaturated fats, fiber, essential nutrients, and phytochemicals that are beneficial for health." shared Claire Rifkin, a registered dietitian not involved in the study.

Perhaps more interestingly, participants following the avocado-enriched diet exhibited reductions in their consumption of sodium, refined grains, and added sugars compared with those who continued their regular eating patterns.

These changes suggest avocados may have partially replaced foods containing sodium, added sugars, and refined grains in the diet.

Simpson explained that this substitution effect "promotes an overall improvement in diet quality by increasing nutrient-dense foods rich in healthy fats and fiber while decreasing the intake of less nutritious, processed foods."

In the present study, however, avocado consumption had no effect on the participants' saturated fat intake. Additionally, avocados replaced small amounts of total protein, seafood, and plant protein components in the diet, the impacts of which were

aiding in diabetes prevention and management,

These effects can be attributed to the high monounsaturated fat and dietary fiber content in avocados. In general, most adults can benefit from including avocados in their daily diet in moderation.

However, Simpson expressed: "[Promoting] avo-

Israeli troops withdraw from Shifa Hospital, Gaza's largest, after 2-week raid

DEIR AL-BALAH, April 1: The Israeli military withdrew from Gaza's largest hospital early on Monday after a two-week raid, leaving behind several bodies and a vast swath of destruction, according to Palestinian residents.

The military has described the raid on Shifa Hospital as one of the most successful operations of the nearly six-month war. It says it killed scores of Hamas and other militants, including senior operatives, and that it seized weapons and valuable intelligence. It confirmed forces had withdrawn Monday.

The U.N. health agency said several patients died and dozens were put at risk during the raid, which brought even further destruction to a hospital that had already largely ceased to function. Days of heavy fighting showed that Hamas can still put up resistance even in one of the hardest-hit areas of Gaza.

Mohammed Mahdi, who was among hundreds of Palestinians who returned to the area, described a scene of "total destruction." He said several buildings had been burned down and that he had counted six bodies in the area, including two in the hospital courtyard

Video footage circulating online showed heavily damaged and charred buildings, mounds of dirt that had been churned up by bulldozers and patients on stretchers in darkened corridors.

Another resident, Yahia Abu Auf, said there were still patients, medical workers and displaced people sheltering inside the medical compound after several patients



had been taken to the nearby Ahli Hospital. He said army bulldozers had plowed over a makeshift cemetery in Shifa's courtyard. "The situation is indescribable," he said. "The occupation destroyed all sense of life

Israel has accused Hamas of using hospitals for military purposes and has raided several medical facilities. It says it launched the raid on Shifa after Hamas and

other militants had regrouped there. Health officials in Gaza deny those allegations. Critics accuse the army of recklessly endangering civilians and of decimating a health sector already overwhelmed with war-wounded. Palestinians say Israeli troops forcibly evacuated homes near Shifa Hospital in downtown Gaza City and forced hundreds of residents to march

At least 21 patients have died since the raid began, World Health Organization Director-General Tedros Adhanom Ghebrevesus posted late on Sunday on X, formerly

inside the compound, including four children and 28 critical patients. He also said there were no diapers, urine bags or water to clean wounds, and that many patients suffered from infected wounds and dehy-

The military had previously raided Shifa, Gaza's largest hospital, in November, after saying Hamas maintained an elaborate command and control center inside and beneath the compound. It revealed a tunnel running beneath the hospital that led to a few rooms, as well as weapons it said it had confiscated from inside medical buildings, but nothing on the scale of what it had alleged prior to the raid.

The war began on Oct. 7, when Hamasled militants stormed into southern Israel, killing some 1,200 people, mostly civilians, and taking around 250 people hostage. Israel responded with an air, land and sea offensive that has killed at least 32,782 Palestinians, according to Gaza's Health

The ministry does not distinguish between civilians and combatants in its count but savs women and children have made up around two-thirds of those killed.

The Israeli military says it has killed over 13,000 Hamas fighters, and blames the civilian death toll on Palestinian militants because they fight in dense residential

The war has displaced most of the territory's population and driven a third of its residents to the brink of famine. Northern Gaza, where Shifa is located, has suffered vast destruction and has been largely isolated since October, leading to widespread

hunger. Israel said late last year that it had largely dismantled Hamas in northern Gaza and withdrew thousands of troops. But it has battled militants there on a number of occasions since then, and the two weeks of heavy fighting around Shifa highlighted the staying power of the armed groups.

Israeli Prime Minister Benjamin Netanyahu has vowed to keep up the offensive until Hamas is destroyed and all of the hostages are freed. He says Israel will soon expand ground operations to the southern city of Rafah, where some 1.4 million people — more than half of Gaza's population have sought refuge.

But he faces mounting pressure from Israelis who blame him for the security failures of Oct. 7 and from some families of the hostages who blame him for the failure to reach a deal despite several weeks of talks mediated by the United States, Qatar and Egypt.

Hamas and other militants are still believed to be holding some 100 hostages and the remains of 30 others, after freeing most of the rest during a cease-fire last November in exchange for the release of Palestinians imprisoned by Israel.

Tens of thousands of Israelis thronged central Jerusalem on Sunday in the largest anti-government protest since the country went to war in October. Deep divisions over Netanayahu's leadership long predate the war, which still enjoys strong public

Pak court suspends 14-year jail term of Imran Khan and his wife in Toshakhana corruption case

ISLAMABAD, April 1: In a major relief to jailed former Pakistan prime minister Imran Khan, a high court on Monday suspended the 14-year sentence given to him and his wife Bushra Bibi in

the Toshakhana corruption case. The two were sentenced to 14 years in jail each by an accountability court on January 31 for alleged corruption in state gifts they got from the state depository, days before the general elections.

They challenged the conviction in the Islamabad High Court where a twomember bench headed by IHC Chief Justice Farooq Aamer heard the case.

On Monday, the Islamabad High Court (IHC) gave

temporary relief to the couple in the case by suspending their sentences and granting them bail in the case.

However, the court announced that their appeals against the conviction would be heard after the Eid festival next

But Khan may not be released as he is convicted in other cases and cannot be released until absolved from charges in other cases. Similarly, Bushra is also convicted in another case and may not be released after her sentence has been sus-

71-year-old former cricketer-turnedpolitician is accused of retaining expensive state gifts they received during his tenure as Pakistan's premier.

Under the rules governing Toshakhana - a Persian word meaning "treasure house" - government officials can keep gifts by paying a price for them but first the gift should be deposited. Khan and his wife either failed to deposit

the gift or got it for a low price by allegedly using their

> The conviction of Khan in the Toshakhana case had come a day after he was awarded 10 years in jail in the cipher case on January 30. Earlier, he was

also convicted in a different Toshakhana case in August 2023, leading to his arrest.

The latest conviction was based on the charges of misusing his authority as prime minister to retain gifts he or his spouse got during his tenure. It was filed by the National Accountability Bureau.

The previous Toshakhana graft case was filed by the Election Commission of Pakistan in the charges of hiring the sale of state gifts.

Khan so far has been convicted in four different cases since losing power in April 2022. He has got bail in both Toshakhana cases. (PTI)

Bodies of 5 Chinese killed in suicide bombing in NW Pak flown to China

ISLAMABAD, April 1: The bodies of five Chinese nationals who were killed last week in a suicide bombing in northwestern Pakistan were flown to Beijing on a special plane, Pakistani officials and state media said on Monday.

The bodies were sent to Beijing overnight from a military air base in the garrison city of Rawalpindi. The development came a week after the Chinese,

along with their Pakistani driver, were killed when the suicide bomber rammed his explosive-laden car into their vehicle in the volatile northwest as they were heading to Pakistan's biggest hydropower project, Dasu Dam, where they worked

On Monday, Prime Minister Shehbaz Sharif was also visiting Dasu Dam to meet with Chinese engineers and workers. Pakistani officials will brief Sharif on the project's progress.

Chinese and Pakistani investigators are conducting separate probes into the attack, which drew nationwide condemnation. China has also asked Pakistan to ensure the protection of its nationals working in various parts of Pakistan on projects in the China-Pakistan Economic Corridor, Authorities say the Chinese bombing victims were heading to the project site amid tight security.

Other Chinese working on CPEC-related projects have faced similar attacks in recent years. In July 2021, at least 13 people, including nine Chinese nationals, were killed when a suicide bomber detonated explosives in his vehicle near a bus carrying Chinese and Pakistani engineers and laborers, prompting Chinese companies to temporarily suspend work. (AP)

US military says it destroyed Houthi drones over the Red Sea and in Yemen

CAIRO, April 1: The U.S. military said Sunday its forces destroyed one unmanned aerial vehicle in a Houthi rebel-held area of war-ravaged Yemen and another over a crucial shipping route in the Red Sea. It was the latest development in months of tension between the Iran-backed rebels and the

The drones, which were destroyed on Saturday morning, posed a threat to U.S. and coalition forces and merchant vessels in the region, said the U.S. Central Command.

It said that one done was destroyed over the Red Sea, while the second was destroyed on the ground as it was prepared to launch.

"These actions are necessary to protect our forces, ensure freedom of navigation, and make international waters safer and more secure for U.S., coalition, and merchant vessels," CENT-COM said. There was no comment from the Houthi rebels, which control much of Yemen's

The rebels launched a campaign of drone and missile attacks on shipping in the Red Sea in November. They have also fired missiles toward Israel, although those have largely fallen short or been intercepted.

The rebels have described their campaign as an effort to pressure Israel to end its war on Hamas in the Gaza Strip. The ships targeted by the Houthis, however, largely have had little or no connection to Israel, the U.S. or other nations involved in the war.

The Houthis have kept up their campaign of at-

Earlier this month, CENTCOM said its forces also destroyed four unmanned aerial vehicles in Houthi-controlled areas of Yemen. It also said Houthis fired four anti-ship ballistic missiles toward the Red Sea, but no injuries or damages were reported by U.S., coalition or commercial ships.

The escalation in the Red Sea and the Israel-Hamas war in Gaza impacted the U.N.-led efforts to relaunch political talks to end Yemen's yearslong conflict, according to the U.N. envoy for Yemen. Hans Grundberg told the U.N. Security Council in mid-March that he had hoped to reach an agreement on a nationwide cease-fire in Yemen by the Muslim holy month of Ramadan, which

He warned that Yemen could be propelled back into war, saying that "the longer the escalatory environment (in the region) continues, the more challenging Yemen's mediation space will be-

The war between the Houthis and pro-government forces backed by a coalition of Gulf Arab states has raged since 2014, when the Houthis swept down from the mountains, seized much of northern Yemen and the country's capital, Sanaa, and forced the internationally recognized government to flee into exile to Saudi Arabia.

Since then, more than 150,000 people have been killed by the violence and 3 million have been displaced.

Fighting has decreased markedly in Yemen since a truce in April 2022, but there are still

WASHINGTON, April 1: Describing the collapse of Francis Scott Key bridge last week as America's "national economic catastrophe", Maryland Governor Wes Moore has said the removal of the wreckage of the bridge and the cargo ship that was mainly manned by an Indian crew is a complex and time-consuming op-

The 2.6km-long, four-lane bridge over the Patapsco River in Baltimore came crashing down after Dali, a 984-foot cargo ship bound for Sri Lanka, collided against it in the early hours of Tuesday.

There were eight workers on the bridge at the time. Two survived, two bodies have been found, and four more men are presumed dead. The 22 crew members from India who have remained on the ship, named the Dali, since the disaster, the New York Times reported.

"This is not a Baltimore catastrophe, not a Maryland catastrophe. This is a national economic catastrophe." Moore told CNN in an interview on Sunday

Moore said this port is one of the busiest, most active ports in the country. "So, this is not just going



to have an impact on Maryland. This is going to impact the farmers in Kentucky. This is going to impact the auto dealer in Ohio. This is going to impact the restaurant owner in Tennessee," he said.

"Whether you're talking about all those various industries, the Port of Baltimore is the largest in the country for all of those things. So, the reason that we need people to move on a bipartisan basis and move on a fast basis is not because we need vou to do Marvland a favour. Maryland needs no favours. We need to make sure that we're moving quickly to get the American economy going again; because the Port of Baltimore is instrumental in our larger economic growth," he said. "This is not just about Maryland's economy. This is something that is impacting the naport for new cars, for heavy trucks, for agricultural equipment. So, this is impacting people all over the country," Moore told MSNBC in another interview. Appearing on Sunday morning talk shows, Moore said that one of the largest cranes, which has the capacity of lifting 1,000 tonnes, had arrived to remove the wreckage of the bridge and the cargo ship that was mainly manned by all Indian crew.

The crane has begun to "cut up the remnants of the bridge that we can then prepare for removal. The complicated nature of this is, we have a ship that is nearly the size of the Eiffel Tower that is now stuck within the channel that has the Key Bridge sitting on top of it," Moore told CNN.

"We can't underestimate how difficult this task is. This is unprecedented where you have a ship that is almost the size of the Eiffel Tower that is stuck in the channel. That has the Key Bridge, which is 3,000 to 4,000 tonnes of steel that is sitting on top of it. This is a remarkably complex operation. And so frankly, our entire focus, all of our time, has been focused on that and nothing else," he told MSNBC. (PTI)

Pak witnessed 245 terror attacks, counter-terror operations in first quarter of 2024: Think tank report

ISLAMABAD, April 1: Pakistan witnessed as many as 245 incidents of terror attacks and counter-terror operations during the first quarter of 2024, resulting in 432 fatalities and 370 injuries among civilians, security personnel and rebels, according to a think tank report.

Khyber Pakhtunkhwa (KP) and Balochistan provinces, both bordering Afghanistan, accounted for over 92 per cent of all fatalities and 86 per cent of attacks (including incidents of terrorism and security forces operations) during this period. Individually, the former suffered 51 per cent and the latter 41 per cent of all fatalities in the first quarter of 2024, according to the security report issued by the Centre for Research and Security Studies (CRSS).

The data indicates that the remaining regions were relatively peaceful, suffering less than 8 per cent of all fatalities. Interestingly, militant organisations claimed responsibility for less than 20 per cent of the total casualties attributed to terrorism in the first quarter of 2024. A new militant group named Jabhat Ansar al-Mahdi Khorasan (JAMK), affiliated with the Gul Bahadur group, has emerged.

In addition to the casualties of terrorism and counterterrorism, there were 64 incidents of sabotage in the country targeting properties of the government, politicians, and private and security properties.

In the first quarter, Balochistan recorded a staggering 96 per cent surge in violence, with fatalities jumping to 178 from 91 in the last quarter of 2023. Sindh saw a nearly 47 per cent rise in violence, though the number of fatalities was very low. However, the regions of KP, Punjab, and Gilgit-Baltistan (GB) recorded encouraging decreases in violence by 24 per cent, 85 per cent, and 65 per cent, respectively.

Despite a notable decrease in violence observed in GB during the period under review, the GB home minister issued a terror threat alert on March 31, 2024, on the possibility of attacks by the banned Tehreek-i-Taliban Pakistan (TTP). The alert came following a suicide attack on a convoy of Chinese engineers in the Shangla district of KP who were working on the Dasu Dam project, resulting in the deaths of five Chinese nationals and a local driver. It's worth noting that last year, GB suffered the highest number of fatalities in a decade, with 17 lives lost, the report stated.

In the first quarter of the current year, civilians and security forces personnel suffered over 65 per cent (281) of all fatalities in nearly 200 terror attacks, compared to outlaws suffering only 35 per cent (151) in



around 48 counter-terror operations. The attacks on security officials and civilians outnumbered the security operations conducted against the outlaws by almost fourfold. Civilians suffered 154 fatalities (36 per cent), which is more than any other category of victims.

Compared to the last quarter of 2023, the fatalities of civilians and security officials combined surged by 17 per cent, whereas the fatalities of outlaws, militants, and insurgents combined decreased by almost 15 per cent in the first quarter of 2024. Surprisingly, certain terrorist outfits, such as the banned Tehreek-i-Jihad Pakistan (TJP), Lashkar-i-Islami (LI), and Lashkar-i-Jhangvi (LeJ), which were highly active the previous year, have abstained from claiming any acts of terrorism this quarter. Only the Tehrik-i-Taliban Pakistan (TTP) and the militant Islamic State group, or Daesh, have claimed responsibility for some attacks.

The banned insurgent groups, Balochistan Liberation Army, Baloch Liberation Front, Baloch Raaji Ajoi Sangar, and Sindhudesh Revolutionary Army, claimed responsibility for 18 attacks (three times more than the claims of the militant groups) in the first quarter, causing 42 fatalities and 40 injuries. The prime targets of the insurgent groups were the security and government installations, including Gwadar Port Complex, Mach Jail, and Turbat Naval Base.

In the first quarter, eight incidents of sectarian violence were reported, impacting all religious communities, including Muslims and non-Muslims alike. Among the non-Muslim communities, Ahmadis endured the highest casualties (9), while three fatalities occurred among Shias due to violence. Additionally, a Sunni was also targeted in an act of violence, according to the report.

On Sunday, unidentified armed men opened indiscriminate fire on a Pakistan Army bomb disposal team near the port city of Gwadar, killing two soldiers and injuring four others. (PTI)

Prez Yoon vows not to back down in the face of doctors' strike over medical school plan

SEOUL, April 1: South Korea's president vowed on Monday not to back down in the face of vehement protests by doctors seeking to derail his plan to drastically increase medical school admissions, as he called their walkouts "an illegal collective action" that poses "a grave threat to our society.

About 12,000 medical interns and residents in South Korea have been on strike for six weeks, causing hundreds of cancelled surgeries and other treatments at university hospi-


In support of their action, many senior doctors at their teaching schools have also submitted resignations though they haven't stopped treating patients.

Officials say they want to raise the yearly medical school cap by 2,000 from the current 3,058 to create more doctors to deal with the country's rapidly aging population.

Doctors counter that schools can't handle such an abrupt increase in students and that it would eventually hurt the country's medical services. But critics say doctors, one of the best-paid professions in South Korea, are simply worried that the supply of more doctors would result in lower future incomes.

Public surveys show that a majority of South Koreans support the government's push to create more doctors. But observers say many people are increasingly fed up with the protracted confrontation between the government and doctors, threatening to deal a blow to governing party candidates ahead of next week's parliamentary elections.

Korea's doctor-to-patient ratio — 2.1 physicians per 1,000 people — is far below the average of 3.7 in the developed world. (AP)



SKM banking on welfare measures to win elections for second consecutive term in Sikkim

GANGTOK, April 1: The Sikkim Krantikari Morcha (SKM) led by Chief Minister Prem Singh Tamang is banking on the welfare measures taken by its government in the last five years to win Assembly elections for the second consecutive term in the Himalayan

Elections to the 32-member Sikkim Assembly and the lone Lok Sabha seat in the state will be held on April 19.

The SKM is banking on welfare measures like free LPG cylinder to all households every quarter, Rs 40,000 annual cash transfer to the women head of family under 'Aamaa Yojana', extra increment to indigenous people in state government service for raising an additional child, an assistant to take care of infants for one year and regularisation of service of 27,000 temporary government employees among others.

"We have fulfilled all the promises we had made in 2019," Tamang said at a rally and urged the people of Sikkim to vote his party to power for a second term to make the Himalayan state a developed and prosperous one.

The SKM which was formed in 2013 had won 10 seats in the 32member Assembly in the 2014 elections. In the 2019 Assembly elections, it won 17 seats and wrested power from the Sikkim Democratic Front which ruled the state for 25 years.

SKM supremo Tamang is contesting from two assembly seats -Rhenock and Soreng-Chakung. His wife Krishna Kimari Rai is contesting from the Namchi-Singhithang assembly seat.

The SKM is fighting the assembly elections alone as the BJP decided to break the alliance with it.

The BJP is contesting the elections in all the 32 seats independ-

The opposition SDF and the newly-formed Citizen Action Party (CAP) have been critical of the Tamang government for "failing" to provide reservation in assembly seats to the tribal Limboo and Tamang communities despite its good equation with the central government.

"With the chief minister himself being a Tamang, he should have made serious efforts to convince the central government to legislate on giving reserved assembly seats to the two tribal communities of Sikkim," an SDF leader said.

The opposition parties are also angry with the SKM for "failing" to address the issue of the tribal status of 12 left-out communities of Sikkim despite making a prom-

The opposition had also criticised the SKM for remaining a mute spectator to the dilution of article 371(F) of the constitution which protects old laws of Sikkim and provides special status to the Himalayan state after its merger with India in 1974.

The expansion of the definition of the Sikkimese people by a Supreme Court order to include descendants of old settlers along with indigenous communities for entitlement to avail income tax exemption had created a storm in Sikkim with all opposition parties protesting the decision and demanding a rollback.

However, the Sikkim Chief Minister weathered the storm by getting the order modified through an application moved by the central government in the apex court.

with the outlawed group National Liberation Front of Tripura (NLFT) in 2019, Bodo Accord and Bru agreement in 2019 and resolving the boundary dispute between Assam and Arunachal Pradesh, he said. "The prime minister believes that the coun-

try will not prosper if the Northeast is not developed. Since peace is the precondition for development, the Modi government has worked hard to bring peace to the region by singing 12 accords with various organisations. Today, peace prevails not only in Tripura but also in the entire region," he said at an election rally in Karbook in Gomati district.

Saha said that the Bru Accord resolved the 23-year-old problem of the internally dis-

placed people. "The Bru people were leading a miserable life in relief camps but no government could provide a solution... it was the Modi government that ended the problem by signing an agreement in 2020. Now, they are settled in 12 locations in Tripura and the Centre has provided Rs 600 crore for their rehabilitation," he



Claiming that the Act East policy has led to fast-track infrastructure building in the region, the chief minister said, "These measures have brought peace and development in the northeastern states.'

Taking a dig at the opposition, he said, They had tried to forge an alliance with the Tipra Motha before the elections but failed. Tipra Motha, having realised that only Modiji can provide solutions to problems, has joined the BJP government. Now, the opposition in Tripura means only the unholy alliance between the CPI (M) and Congress.

Remembering the remarkable life and legacy of a distinguished soldier from Mizoram

His saga of valour traces back to the crucible of World War-II, where his bravery shone brightly amidst the chaos of battle.

NEW DELHI, April 1: The Congress on Monday hit out at Prime Minister Narendra Modi over his remarks on the electoral bonds issue, claiming that while the corruption of his government had been known for a while the setback is that there are now "hard numbers to prove

Prime Minister Modi on Sunday rejected the suggestion that the electoral bond issue caused a setback to his government, saying no system is perfect and any shortcoming could be improved upon.

In an interview with Thanthi TV, he also said those who are "dancing" over the matter will repent it.

Congress general secretary Jairam Ramesh attacked Modi over his remarks and charged, "Every single day the prime minister scales new heights of hypocrisy and plumbs new depths of dishonesty".

"The prime minister has fully lied to the nation in his latest interview to a Tamil television channel. He claims that 'where funds have come from, how they are being used' is only known due to the Electoral Bond Scheme instituted by him," Ramesh said and put forward "relevant facts".

"The Electoral Bond Scheme was designed to be fully anonymous. In other words, Modi wanted to hide from the public the details of 'where funds have come from (to political parties), and how they are being used," he alleged.

For six years, between 2018 and 2024, not a single detail of which party got funds from which donor was revealed to the public, Ramesh said in a post on

In 2024, the Supreme Court intervened to reject the electoral bond scheme as unconstitutional. Up until the last day in court, the Modi government tried to defend the anonymity of the scheme, the Congress leader

Finally, the Supreme Court demanded that the SBI publish the details of who donated to which party, he noted.



"Still, the remote-controlled SBI lied to the court, saying it did not collect this information. Then, it requested three months' time to collate the data, conveniently seeking an extension until after the election. It was only the Supreme Court's strong

intervention that forced the SBI to release the data publicly within days," Ramesh said. He alleged that the SBI was

lying in the Supreme Court when it demanded a threemonth extension to match donor data with the political parties.

"It took our team five lines of Python code and less than fifteen seconds to match each donor with the political party they donated to," he said.

'As for the PM's question of 'what have I done that I should face a setback (due to Electoral Bonds)?' Mr. Modi, the data has revealed your party and Government's monumental corruption," Ramesh alleged.

He claimed that "₹ 4 lakh crores worth of contracts, projects, and environmental clearances can be linked to thousands of crores in electoral bond donations made by corporate donors to your party. The Government of India has been reduced to a supermarket - 'Chanda Do, Dhanda Lo'.'

"At least 40 ED/IT/CBI raids on firms have been followed by hefty electoral bond donations by these firms to the BJP. The prime minister and his cronies have been engaged in a systematic 'hafta vasuli'," Ramesh alleged.

"The corruption of the Modi Sarkar has been known for a

while now; the setback is that there are now hard numbers to prove it. Unfortunately, we can expect the prime minister to continue his full-time job of lying to the Indian people to cover it up," the Congress leader said

In his interview, Modi said, "Tell me what have we done that I should see it as a setback? I firmly believe that those dancing over it (bond details) and taking pride in it are going to re-

The prime minister said it is due to the electoral bond system put in by his government that the sources of funding and its beneficiaries could be found out. If a trail is available today, it is because of the presence of bonds, he said, asking if any agency can tell about the sources of funding and their beneficiaries for the polls before 2014, the year he came to

Oppn cites 2015 RTI reply, jabs govt over 'change in stance' on Katchatheevu island

NEW DELHI, April 1: Hitting back at the Centre over the Katchatheevu island issue, opposition leaders on Monday cited a 2015 RTI reply, which stated that the agreements in 1974 and 1976 did not involve either acquiring or ceding of territory belonging to India, and asked whether the "change" in Modi government's stance was for "election politics". The opposition's response came after External Affairs Minister S Jaishankar on Monday claimed that prime ministers from the Congress displayed indifference about Katchatheevu island and gave away Indian fishermen's rights despite legal views to the contrary.

Jaishankar's remarks at a press conference were made a day after Prime Minister Narendra Modi cited a media report to assert that new facts reveal that the Congress "callously" gave away Katchatheevu island to Sri Lanka.

Senior Congress leader P Chidambaram hit out at the government over the issue.

"Tit for tat is old. Tweet for Tweet is the new weapon. Will Foreign Minister Mr. Jaishankar please refer to the RTI reply dated 27-1-2015...The Reply justified the circumstances under which India acknowledged that a small island belonged to Sri Lanka," Chidambaram said.

Why is the Foreign Minister and his ministry doing a somersault now, he asked.

"How quickly can people change colours. From a suave liberal Foreign Service officer to a smart Foreign Secretary to a mouthpiece of the RSS-BJP, life and times of Mr Jaishankar will be recorded in the annals of acrobatic sports," Chidambaram said

"It is true that fishermen were detained in the last 50 years. Likewise, India has detained many Sri Lankan fishermen. Every government has negotiated with Sri Lanka and freed our fishermen," the former home minister said.

"This has happened when Mr Jaishankar was a foreign service officer and when he was Foreign Secretary and when he is Foreign Minister. What has changed for Mr Jaishankar to launch a tirade against the Congress and DMK?" he said.

Were not fishermen detained by Sri Lanka when Atal Bihari Vajpayee was PM and the BJP was in power and in alliance with different political parties of Tamil Nadu, he asked.

"Were not fishermen detained by Sri Lanka when Mr Modi was in power since 2014?" he said. In a post on X, Shiv Sena (UBT) leader Priyanka Chaturvedi shared an RTI response from the ministry of external affairs in 2015 which said Katchatheevu Island lies on the Sri Lanka side of the India-Sri Lanka International Maritime Boundary Line, that was delineated by the 1974 Agreement demarcating it in the Palk Straits and a subsequent 1976 Agreement demarcating it in the Gulf of Mannar and Bay of Bengal. Rahul Gandhi has no right to talk about democracy, his grandmother imposed Emergency: Amit Shah

JODHPUR, April 1: Congress leader Rahul Gandhi has no right to talk about democracy now as his grandmother and former prime minister Indira Gandhi put lakhs of people in jail and banned political parties during the Emergency, Union Home Minister Amit Shah said on Monday.

He hit back at INDIA bloc parties over their 'Loktantra Bachoa' (save democracy) rally at Delhi's Ramlila Maidan on Sunday, saying "no matter how many parties you gather, only Modi is going to come" as prime minister post-elections.

The one who commits corruption will go behind the bars, the home minister asserted at his election rally in Jodhpur.

The people of the country are ready to make Narendra Modi the prime minister for a third time, he said, adding India will become the third largest economy during his next term.

Shah's reaction came a day after top INDIA bloc leaders exhorted the people to defeat the BJP to save democracy and the Constitution and alleged that the opposition has been deprived of a level-playing field in the Lok Sabha elections due to the government's "dictatorial" actions.

Rahul Gandhi had accused Prime Minister Narendra Modi of trying to do "match-fixing" in the Lok Sabha polls and warned that if the BJP wins the election through this endeavour and "changes" the Constitution, then the whole country would be

Pappu Yadav says he will file nomination papers from Purnea



PATNA, April 1: Former MP Rajesh Ranjan alias Pappu Yadav on Monday said he will file his nomination papers for Purnea in Bihar later this week, and urged RJD president Lalu Prasad to forego the Lok Sabha seat for ally Congress.

Yadav, who joined the Congress less than a fortnight ago, made the announcement on X, a day before Bima Bharti, the RJD candidate. was likely to file her nomination from the seat.

Yadav, who has merged his Jan Adhikar Party with the Congress, wrote "people from across the country, hailing from Purnea, want to join me during filing of nomination papers. For their convenience, proposed date has been deferred, from June 2 to June 4".

Neither the RJD, which has been distributing tickets, nor the Congress has formally declared candidates for any of the 40 seats in

However, a seat-sharing formula was announced only after filing of nomination papers for the four seats going to polls in first phase

Purnea, according to the formula made public several days after Bima Bharti, a JD(U) turncoat, announced having received the RJD ticket from Lalu Prasad, was predictably among the 26 seats claimed by the party.

The seat-sharing plan came as a huge setback to Yadav, who had been for months running a campaign 'Pranam Purnea', seeking to rebrand himself in the constituency he had represented thrice in the Yadav, who had earlier hoped

that the Congress would back him for a "friendly fight" in Purnea, added in his post on X: "I once again urge RJD chief Lalu Prasad to review his decision on Purnea and give it up for the Congress, in larger interests of the coalition".

Sources in the state unit of the Congress said they were not aware whether Yadav was throwing his hat in the ring with the high command's approval, but if he was doing so of his own accord, disciplinary action would follow. (PTI)

MYSURU/MANDYA (KAR-NATAKA), April 1: Amid speculations about leadership change, Karnataka chief minister Siddaramaiah on Monday asked the people of his Varuna assembly segment to give the Congress candidate a lead of at least 60,000 votes in the upcoming Lok Sabha polls, to ensure that he remains in the post.

In Mandya, deputy chief minister and state Congress President D K Shivakumar, who has made no secret about his Chief Ministerial ambitions, told the people that the desire with which they supported the party in the assembly poll in May last year, keeping him in mind, "will not turn out to be false."

The statements gain significance amid persistent rumours about leadership change in the ruling Congress in the state after Lok Sabha polls or mid-way of the current assembly's tenure.

"In 2019 (Lok Sabha polls) Dhruvanarayan (Congress candidate) lost by a margin of only 1,817 votes.... This time in the Assembly you made me win by giving a lead of 48,000 votes (in Varuna). Will you give the same lead or more now? (Our candidate should win) with a lead of at least 60,000 votes," Siddara-



maiah said.

Addressing a public meeting, he said: "In Varuna you know me, as well as (H C) Mahadevappa (minister). I'm your representative, (my son) Yathindra is a former MLA from here (Varuna). When we are all there there should be a lead of at least 60,000 votes.

"If you make (Congress candidate) victorious by a lead of 60,000 votes, I will be happy. No one will be able to touch me. Should I remain (as Chief Min-

ister) or not? So I request you with folded hands...I will come back to thank you after winning," he added.

Siddarmaiah's Varuna assembly segment comes under Chamarajanagar Lok Sabha constituency, from where minister Mahadevappa's son Sunil Bose is the Congress candidate.

Meanwhile, asking voters to support Congress in the Vokkaliga bastion of Mandya. Shivakumar said: "I want to tell you that, keeping me in mind,

you gave more seats (in assembly polls to Congress) in Mandya district. Your desire will not turn out to be false. You need not worry.'

He said Congress has given tickets to eight Vokkaligas in the Lok Sabha polls.

Openly expressing his ministerial aspirations ahead of assembly polls, Shivakumar had asked Vokkaliga community, to which he belongs, not to lose out an opportunity with him as the party's state unit president, while pointing out that S M Krishna was the last Vokkaliga to lead the party in the polls and then went on to become the CM

Gadkari vows to eliminate petrol, diesel vehicles in India, bats for lower tax for hybrid cars

NAGPUR, April 1: As part of his ambition to make India a green economy, Union minister Nitin Gadkari wants to slash GST on hybrid vehicles and has vowed to rid the country entirely of the over 36 crore petrol and diesel vehicles.

"One hundred per cent," Gadkari, the Union Minister for Road Transport and Highways, said when asked whether it is possible for India to get rid of petrol and diesel cars altogether.

"It is difficult but not impossible. This is my vision," Gadkari said in an inter-

He said India spends Rs 16 lakh crore on fuel imports. This money will be used for improving the life of farmers, villages will be prosperous and the youth will get employment, the minister said.

Gadkari did not give any timeline to meet this ambitious target which even proponents of green energy believe is mind bogglingly difficult.

The proposal to reduce GST on hybrid



vehicles to five per cent and to 12 per cent for flex engines has been sent to the Finance ministry which is considering the requisition, Gadkari said.

The minister said he firmly believes the country can end fuel import by promoting the use of biofuels.

Environmental activists welcomed

Gadkari's vision for increasing green mobility, but also struck a word of caution by flagging the use of fossil fuels in the production of electricity.

"In India, we are still heavily dependent on a fossil fuel-based energy system to power electric cars, and this needs to be changed. There is urgent need to ensure 100 per cent renewable energy alongside electric vehicles to tackle the climate crisis," Avinash Chanchal, a campaigner for Greenpeace India, told PTI.

Gadkari said he has been pitching for alternative fuels since 2004 and is confident things will change in the coming five to seven years.

"I cannot give you a date and year for this transformation to take place as it is very difficult. This is difficult but not impossible," Gadkari asserted.

He said he firmly believes that given the speed with which electric vehicles are being introduced, the coming era will be of alternative and biofuels and this dream will come true.

Gadkari said auto companies such as Bajaj, TVS and Hero are also planning to manufacture motorcycles using flex engines and auto rickshaws using similar

technology too were on the way. "I roam around in a car that runs on hydrogen. You can see electric cars in every other household. People who used to say this was impossible, have changed their views now and started believing in what I have been saying for the last 20

years," the minister said. "Tatas and Ashok Leyland have introduced trucks that run on hydrogen. There are trucks that run on LNG/CNG. There are 350 factories across the country of bio-CNG," he

"Definitely, a revolution is taking place. The fuel imports will end and this country will become self-reliant -Atmanirbhar Bharat. I strongly believe in this," Gadkari said. (PTI)

The plea came up for hearing before a bench of justices Surya Kant and K V Viswanathan on Monday. Solicitor General Tushar Mehta, appearing for Haryana, referred to a paragraph from the high court's order and said this will demoralise

JALPAIGURI (WB), April 1: The death toll due to a storm that wreaked havoc in parts of Jalpaiguri district in northern West Bengal has risen to five, chief minister Mamata Baneriee has said.

Over 100 people were injured while several hutments and houses were damaged, trees uprooted and electric poles came crashing down as strong winds accompanied by hail struck most parts of the district headquarters town and many areas of neighbouring Mainaguri on Sunday

The chief minister, who rushed to the district late on Sunday night, assured the people of all help from the administration.

"So far, we have reports of the death of five people. The number of injured is quite high. I met the injured and the family members of those who died in the storm. The state administration will do everything to help the affected families,

When asked about providing compensation, Banerjee said, "As the model code of conduct is in place, I can't say anything about it. You have to talk to the district administration.

The CM on Sunday night visited those injured and undergoing treatment at the hospital. She also spoke to the family members of those killed in the storm and assured them of all sorts of assis-

"This is a disaster, an emergency situation. I have visited the families of those who have been killed and also those who are undergoing treatment at the hospital. I will thank the administration for their prompt action in the rescue operation. We are beside the people and will take care of their treatment and rebuilding the houses," Banerjee said, adding that the rescue operation is over.

Banerjee, accompanied by TMC party leaders, went to Jalpaiguri

Medical College and Hospital and on her way also spoke to those in the relief camps in other parts of the districts through video call.

Wild elephant kills man in Kerala; fifth life lost in three months

PATHANAMTHITTA (KERALA), April 1: A 53-year-old man was attacked and killed by a wild elephant when he tried to chase away the animal that strayed into the surroundings of his house on the forest fringes in Thulappally here in the early hours of Monday, police said.

This is the fifth death caused by wild elephants in Kerala in the past three months. Biju, a local auto driver, came out of his

house along with his wife, hearing the trumpets of an elephant outside. The animal grabbed him using its trunk and threw him to the ground twice, Biju's wife Daisy, who witnessed the terrible incident, said later.

The same elephant had strayed into the area and wreaked havoc here the other day, she said. The animal was seen trying to uproot a coconut tree in the surrounding area and it moved towards him fast after trumpeting multiple times, she said.

The woman said she stepped back and moved to the house premises seeing the charged jumbo. "We went out together, hearing the sounds of the elephant near our home in the early hours. The first time, we came back home together. But he went to the road near the house again as the

Leopard barges into house in Delhi's Wazirabad, 5 injured

NEW DELHI, April 1: At least five people were injured in an attack by a leopard which strayed into a village in north Delhi's Wazirabad on Monday morning, triggering panic among the locals,

The leopard was later rescued, Delhi Fire Service chief Atul Garg said. According to officials, the leopard had jumped from the terrace of a house in Jagatpur village early in the morning and barged into the next building where it was locked in a room. Videos on social media showed the leopard being chased by some people and others running in panic.

According to the Delhi Fire Service, information about the incident was received around 6.20 am and two fire tenders were sent to the spot. "With the help of the locals, the officials locked the leopard in a room. The injured were sent to a hospital," Delhi Fire Service (DFS) chief Atul Garg

A resident said the leopard was first spotted around 4.30 am and a PCR call was made at 5.15 am. It tried to attack over a dozen people and injured some of them, he said. Deputy Commissioner of Police (north) M K Meena said a call about the leopard entering a house was received from Jagatpur village, following which the local police reached the spot and forest department officials were in-

cording to the FIR.

Police said that five people were injured in the leopard attack and three of them have been identified as Mahender, Akash and Rampal.

mal maximum temperatures are likely over most parts of the country in April, with a high probability over central south India. Normal to below-normal maxi-

mum temperatures are likely over some parts of the western Himalayan region and northeastern states in April, the IMD said.

Above-normal heatwave days are likely over many areas in central India and the adjoining areas of the northern plains and south India in April, it said.

"Two to eight days of heat wave are expected in these regions against a normal of one to three days," Mohapatra said. Gujarat, Maharashtra, north

Karnataka, Odisha, west Madhya Pradesh and Andhra Pradesh are predicted to experience the worst mpact of heat waves in April.

The IMD said the country is "most likely" to gauge normal rainfall (88-112 per cent of the long-period average of 39.2 mm) in April.

"Normal to above-normal rainfall is likely over most parts of the northwest, and some parts of central and north peninsular India. Below-normal rainfall is likely over the east and the west coasts, parts of east, northeast and south peninsular India," Mo-

Elevated temperatures pose significant risks, especially for vulnerable populations such as the elderly, children and those with pre-existing health conditions as they are more susceptible to heat-related illnesses such as heat exhaustion and heatstroke, the IMD said.

the three previous matches. In fact, Maxwell's off-spin was not even employed in their last match against the Knight Riders. To make matters worse, they don't have many reliable choices in the dugout too.

Rahul under scanner

On the other hand, the Super Giants have their own set of worries as the fitness of regular captain Rahul, who came in as an Impact Sub in their 21-run win over Punjab Kings, will be closely monitored.

Will the LSG continue to use Rahul as an impact player with Nicholas Pooran wearing the captain's armband or will he return to his normal three-in-one role of skipper, batter and wicketkeeper? We will have to wait for the answer.

With the completion of her event, Chanu has fulfilled the criteria for the Paris Olympics, which is participating in two compulsory events and three other qualifiers.

The 2017 world champion is currently ranked second in the women's 49kg Olympic Qualification Ranking (OQR) behind China's Jian HuiHua.

The official announcement for the qualification will come after the conclusion of the World Cup when the OQR will be updated. The top 10 lifters from each weight class will qualify for the Paris Olympics.

Chanu, who last competed at the Asian Games in September where she suffered a hip tendonitis injury, was not at her best, but was able to make five clean lifts. Her lifts in the snatch and clean and jerk sections were nowhere close to her personal best efforts.

The 29-year-old has a personal best of 88kg in snatch while she had lifted the then world record of 119kg in clean and jerk at the Asian Championships in 2021.

But given that she is coming off an injury and rehab, Chanu still has time to peak in July and her progress looks good.

Indians are a long shot in candidates: Viswanathan Anand

NEW DELHI, April 1: Giving prominence to experience over youthful exuberance, five-time world champion Viswanathan Anand feels the three Indian participants remain far from winning the Candidates chess title, saying they "should first settle into the tourna-

The tournament, which will determine the challenger for the next World Championship, will be held in Toronto from April 3-22.

The immensely talented R Praggnanandhaa, D Gukesh and Vidit Gujrathi are the three Indians competing in the meet's open category. "The Indians are a long shot. If

they can keep the tournament going that's good enough. If a late opportunity presents itself, they can grab it. They should first settle into the tournament and try to play good games. Let the big decisions come later," said Anand in a webcast published on a popular chess portal. The Indian stalwart was referring to those who have played at this level before. And it is only the first time that all the three have qualified and Anand singled out Gujrathi as someone who could fit on both sides - being experienced as well as a debutante.

The opinion is not much divided among the world elite as Anand also felt, like many others, that Fabiano Caruana and Hikaru Nakamura of the United States are the clear favourites while terming Ian Nepomniachtchi of Russia and Alireja Firouza of France as the unpredictable players of the tourna-

According to Grandmaster N Srinath, one of the country's top trainers, Praggnanandhaa has the best chance among Indians but picked Fabiano Caruana of United



States as the clear favourite for the title. Just a few days ahead of the elite event world number one and former world champion Magnus Carlsen said both Caruana and Nakamura have "excellent

Carlsen thought that Nepomn not have any great result to boot.

Despite that, according to Carlsen, "Ian has enough pedigree to be among the top contender."

The winner of the Candidates will qualify to challenge Ding Liren of China in the next World Championship match. Among Indians, Carlsen singled out Praggnanandhaa as the player to watch


