SC orders status Sonowal asks ULFA(I) to come for talks quo at Doloo tea estate in Cachar NEW DELHI, April 8: The Supreme Court on Monday directed the state government to maintain the status quo at the Doloo tea estate in the Cachar district of the state, where a Greenfield airport is proposed to be constructed. A bench of Chief Justice D Y

Chandrachud and justices J B Pardiwala and Manoj Misra questioned the state government for clearing the shrubs in the tea garden without an environment impact assessment report. The top court also issued notices to the Centre, ministry of environ-

ment and forests, the state government and others on a plea filed by Tapas Guha and others.

Advocate Prashant Bhushan, appearing for the petitioners, submitted that the National Green Tribunal (NGT) erred in decision and even for the grant of site clearance and in-principle approvals, environmental clearance is necessary. The NGT on January 25 had dismissed the plea by Guha and others on the ground that environmental impact assessment report is awaited and the environmental

If there is peace, there will be development and progress: Union Minister TINSUKIA, April 8: Union minister Sarbananda Sonowal, BJP's nominee for Dibrugarh Lok Sabha constituency, on Monday urged ULFA(Independent) to come for talks and resolve all issues through discussions.

He lost the seat to Congress candidate in 2009 and shifted to Lakhimpur in 2014 from where he won and went on to become a minister of state in the first cabinet of Modi.

He became Assam chief minister in 2016 and after he was succeeded by the current incumbent Himanta Biswa Sarma, he went on to become a Rajya Sabha member in 2021.

Sonowal replaced sitting BJP MP and Union minister Rameswar Teli as the party's Dibrugarh contestant.

He is locked in a triangular contest, the other two being Assam Jatiya Parishad's Lurinjyoti Gogoi as the United Opposition Forum nominee and the Aam Aadmi Party's contender, Manoj Dhanowar. (PTI)

NCERT warns against pirated textbooks, flags factually incorrect content

NEW DELHI, April 8: The National Council of Educational Research and Training (NCERT) on Monday issued a warning against pirated school textbooks, flagging possibilities of factually incorrect content.

It also warned against copyright infringement of its educational materials, cautioning the public against unauthorised printing and commercial sale of NCERT school textbooks

"A few unscrupulous publishers were printing NCERT school textbooks available on its website under their own name, without obtaining permission from the NCERT. Anyone found publishing NCERT textbooks, either in whole or in part, for commercial sale or using NCERT textbook content in their publications without obtaining explicit

copyright permission, will face legal repercussions under the Copyright Act of 1957," a senior council official said

"The general public is requested to kindly stay away from such textbooks or workbooks as their content may be factually incorrect as well as against the basic philosophy of NCF (National Curriculum Framework for School Education) 2023. We also urge individuals who come across such pirated textbooks or workbooks to immediately report it to the council," the official added. The NCERT last week announced that textbooks for Class 3 will be available by the last week of April and for Class 6 by mid-May. It had said that 1.21 crore copies of the 2023-2024 editions of textbooks for classes 1, 2, 7, 8, 10 and 12 have been released nationwide. (PTI)

### Shah to campaign in Assam today

GUWAHATI, April 8: Union home minister Amit Shah will visit the state on Tuesday to campaign for the Lok Sabha Elections. He is scheduled to address a public meeting at Chukuli Bhoria in Lakhimpur constituency in the afternoon, BJP party sources said here.

Lakhimpur is also held by the BJP. with incumbent MP Pradan Baruah seeking a third successive term as he is pitted against Congress candidate Uday Shankar Hazarika. Shah will then take part in a road show from Chaliha Nagar to Thana Chariali in Tinsukia town in the evening, they said.

Tinsukia town comes under Dibrugarh seat, from where Union minister Sarbananda Sonowal is contesting as the BJP candidate.

Sonowal is locked in a triangular fight with United Opposition Forum, Assam, nominee Lurinjyoti Gogoi and Aam Aadmi Party candidate Manoj Dhanowar. (PTI)

## *Right to live before right to vote, peace* before polls: People in relief camps

IMPHAL, April 8: "Why should I vote to elect a representative of a place which is no longer mine ... elections mean nothing to us," says a distraught Nobi, who lost her home 11 months ago to ethnic violence in Manipur and is living in a relief camp.

The 42-year-old is not alone as "right to live before right to vote" and "peace before polls" was the common refrain of many who have not been able to return home due to recurrent clashes and lingering hostilities between the warring ethnic groups in the northeastern state.

The state has traditionally seen a very high voter turnout with more than 82 per cent polling recorded in the 2019 elections. But the eth-

UCC already incorporated in Indian **Constitution: ASDC secretary**

DIPHU, April 8: Secretary of Autonomous State Demand Committee (ASDC), Daniel Teron said the Uniform Civil Code (UCC) was incorporated when the Constitution of India was framed by the constituent assembly and now the BJP wanted to implement what is already there in the Constitution.

Interacting with the media at the ASDC Central Committee office on Monday, Teron said, "Most people of Karbi Anglong and Dima Hasao are unaware of Article 44 of the Indian Constitution. It was in 1949 that it was incorporated in the Constitution by the constituent assembly. Now it would be wrong to say that Article 44, which provides for Uniform Civil Code (UCC) in the country, is the handiwork of the BJP. Actually, the BJP wanted to implement this portion of the Constitution all over India."

Teron said that on March 12 the ASDC delegation met chief minister, Himanta Biswa Sarma and requested him to keep Karbi Anglong and Dima Hasao outside the purview of the UCC as in 1935 these areas were partially excluded areas. The delegation has also told the CM to keep the districts outside the



purview of the Citizenship Amendment Act.

Teron said, "When we met the CM demanding to exclude Karbi Anglong and Dima Hasao from the purview of UCC, he agreed. He told us that when the bill will be taken up in the Parliament he will have a discussion with Union home minister, Amit Shah to exclude the two hill districts from the purview of UCC." ## Sensex, Nifty hit fresh peaks on firm global cues, foreign fund inflows

MUMBAI, April 8: Benchmark equity indices Sensex and Nifty reached their fresh record highs on Monday, amid optimism in global markets and foreign fund inflows. Buying in index major Reliance Industries also fuelled the rally in equities.

The 30-share BSE Sensex jumped 494.28 points or 0.67 per cent to settle at a new closing peak of 74,742.50. During the day, it zoomed 621.08 points or 0.83 per cent to reach a record intra-day high of 74,869.30.

The NSE Nifty climbed 152.60 points or 0.68 per cent to 22,666.30. During the day, it jumped 183.6 points or 0.81 per cent to hit a lifetime high of 22,697.30. From the Sensex basket, Maruti, Mahindra & Mahindra. NTPC, JSW Steel, Larsen & Toubro, Reliance Industries, Axis Bank, and Power Grid were the major gainers.

### Rupee settles on flat note at 83.31 against US dollar

MUMBAI, April 8: The rupee settled on a flat note on Monday at 83.31 (provisional) against the US dollar, as the support from positive domestic equities was negated by the strength of the American currency in the overseas market.

Forex traders said investor sentiments got a boost as crude oil prices retreated from their elevated levels, but the strength of the American currency in the overseas market weighed on the local unit and restricted the uptick

At the interbank foreign exchange market, the local unit opened at 83.27 against the greenback. The unit hit an intra-day high of 83.23 and a low of 83.33. The local unit finally settled at 83.31 (provisional) against the dollar, unchanged from its previous close. On Friday, the rupee appreciated 8 paise to close at 83.31 against the US dollar as the Reserve Bank of India (RBI) kept the benchmark interest rate unchanged at 6.5 per cent for the seventh time in a row. that nothing goes wrong. "Rahul comes without that kind of briefing. And he, directly or indirectly, intentionally or unintentionally, ends up humiliating the local people and that creates a problem," he added. Giving an example, Sarma said Gandhi raised the issues of caste census and Manipur violence in Assam although "none of these topics have any relevance here".

"Assam is a casteless society and people do not believe in casteism. If suddenly someone comes here and talks about caste census, nobody will accept that. Caste census may be relevant in states like Bihar and Uttar Pradesh, but not in Assam," he said.

"When you come to Assam and go on speaking about Manipur, people feel disconnected because Manipur and Assam are two different states," Sarma said. He said neither Manipur has any impact on Assam nor has Assam any impact on Manipur.

"But many people coming to Assam started asking questions about Manipur. That means they came without briefing. Every time, Rahul comes to Assam without taking a briefing of Assam and that's the problem," Sarma said

When asked if it was the fault of Assam Congress for not briefing Gandhi properly, Sarma, who was once a member of the opposition party, chose to blame the Wayanad MP, calling him as an "impatient" person. "Getting an audience for the briefing is the problem. You have to give time, you have to have patience. He (Gandhi) is an impatient person. You need a lot of patience to understand the culture, anthropology and geography. So, you have to give at least two hours before you come to a state," the BJP leader said.

The 'Bharat Jodo Nyay Yatra' passed through Assam from January 18 to 25, during which Gandhi had locked horns with Sarma, terming him "the most corrupt CM of India". The eight-day journey remained very eventful witnessing high-voltage drama, accusations from both sides, clashes and multiple FIRs at different police stations. Sarma, in several election campaign meetings in the last one month, claimed that all Congress leaders, including the party's state chief Bhupen Kumar Borah will join the BJP in the coming days.

Asked if he made this statement on the basis of facts or if it was just political rhetoric, the BJP leader said, Today, if you go to the Congress headquarters or any district office, you will see empty chairs and empty rooms. Because in the last three months, most of the Congress people I know have joined the BJP." "Now, there are hardly 30-40 state leaders in the Congress. I think that after Lok Sabha elections, all other leaders will join the BJP." he said.

In recent times, several hundred Congress members and leaders have joined the BJP across Assam. Dissatisfaction grew after the opposition party published the names of the nominees for the general elections. Voting in 14 Lok Sabha seats in Assam will take place in three phases on April 19, 26 and May 7. When asked specifically about his claim of Borah joining the ruling party early next year, Sarma said, "What I have said is that every Congressman will join the BJP in due course of time. Almost everybody, who has filed defamation cases or has spoken against us on the floor of the assembly, has joined us. I don't think Bhupen Borah will be an exception.

Taking strong objection to the statement, Borah has already filed a Rs 10-crore defamation suit against Sarma, claiming that various statements made by the BJP leader have damaged his public image and the party.

The chief minister had also stated that some will be left in the Congress and will never join the saffron party. Regarding his statement, Sarma, without naming anyone, said, "There are two to three leaders in Assam whose fathers were former chief ministers. Also, there may be somebody who is very deeply connected (to Congress) and cannot come or we also would not want to take." "Every political party has a negative list. ## Biden administration announces USD 6.6 billion to ensure leading-edge microchips are built in the US

WILMINGTON, April 8: The Biden administration pledged on Monday to provide up to USD 6.6 billion so that a Taiwanese semiconductor giant can expand the facilities it is already building in Arizona and better ensure that the most-advanced microchips are produced domestically for the first time. Commerce Secretary Gina Raimondo said the funding for Taiwan Semiconductor Manufacturing Co. means the company can expand on its existing plans for two facilities in Phoenix and add a third, newly announced production hub.

"These are the chips that underpin all artificial intelligence, and they are the chips that are the necessary components for the technologies that we need to underpin our economy," Raimondo said on a call with reporters, adding that they were vital to the "21st century military and national security apparatus." The funding is tied to a sweeping 2022 law that President Joe Biden has celebrated and which is designed to revive US semiconductor manufacturing. Known as the CHIPS and Science Act, the USD 280 billion package is aimed at sharpening the US edge in military technology and manufacturing while minimizing the kinds of supply disruptions that occurred in



2021, after the start of the coronavirus pandemic, when a shortage of chips stalled factory assembly lines and fuelled inflation.

The Biden administration has promised tens of billions of dollars to support construction of US chip foundries and reduce reliance on Asian suppliers, which Washington sees as a security weakness.

"Semiconductors – those tiny chips smaller than the tip of your finger - power everything from smartphones to cars to satellites and weapons systems," Biden said in a statement. "TSMC's renewed commitment to the United States, and its investment in Arizona rep-

resent a broader story for semiconductor manufacturing that's made in America and with the strong support of America's leading technology firms to build the products we rely on every day.'

Taiwan Semiconductor Manufacturing produces nearly all of the leading-edge microchips in the world and plans to eventually do so in the US. It began construction of its first facility in Phoenix in 2021, and started work on a second hub last year, with the company increasing its total investment in both projects to USD 40 billion. The third facility should be producing microchips by the end of the

decade and will see the company's commitment increase to a total of USD 65 billion, Raimondo said. The investments would put the US on track to produce roughly 20 per cent of the world's leadingedge chips by 2030, and Raimondo said they should help create 6,000 manufacturing jobs and 20,000 construction jobs, as well as thousands of new positions more indirectly tied to assorted suppliers in chip-related industries tied to Arizona projects. The potential incentives announced Monday include USD 50 million to help train the workforce in Arizona to be better equipped to work in the new facilities. Additionally, approximately USD 5 billion of proposed loans would be available through the CHIPS and Science Act. "TSMC's commitment to manufacture leadingedge chips in Arizona marks a new chapter for America's semiconductor industry," Lael Brainard, director of the White House National Economic Council, told reporters. The announcement came as US Treasury Secretary Janet Yellen is travelling in China. Senior administration officials were asked on the call with reporters if the Biden administration gave China a head's up on the coming investment, given the delicate geopolitics surrounding Taiwan.

Right to live before right

Lok Sabha seats in Manipur will be held in two phases on April 19 and 26. While Inner Manipur and some segments of Outer Manipur will vote in the first phase on April 19, the remaining segments of Outer Manipur will vote in Phase 2 on April 26.

According to officials, more than 50,000 people are living in camps following the unrest. They question the timing of the Lok Sabha elections and say the idea of organising voting in relief camps is nothing but a gimmick as the real issues remain unaddressed. PTI visited four relief camps in the Imphal Valley where the displaced people expressed discontent with the poll process.

Eighteen-year-old Dima, who finished her schooling under the shadow of the conflict, said she has no idea what she is going to do next. "How can I plan studying further in such a situation? And why should I waste my first vote at a time when I feel elections should not be conducted ... I won't," she told PTI.

Living in a relief camp set up in the Government Dance College auditorium in Imphal's Peace Compound, Dima spends her day teaching primary school children who have begun going to a nearby government school.

The Election Commission has announced that the displaced population will have the opportunity to cast their votes from relief camps.

KH Khamba (45), who used to run his transport business in the Kuki-dominated area of Moreh, a town near the Indian-Myanmar border that is 120 kilometres from his relief camp, says, "There had to be some resolution for the current situation before elections were conducted." "What did the people we vote for in past do for us? Yes, we are being kept in camps, food is being given but is that all that is needed to live?" he says. "We left amid the violence and got to know later that my vehicles as well as my house are no longer there as everything has been burnt." Asked whether he will cast his vote, Khamba said, "We are still consulting among ourselves but one thing is sure that we are not happy about the timing of elections in the state.'

Thirty-year-old Melody helps out in cooking meals at the camp and also tries to learn incense making to earn a livelihood.

"If the government can conduct elections during such a time, I am sure they can find ways to bring peace and address the concerns of people. Everything that we had built over the years got burnt and now we are supposed to start our lives from scratch and we should also vote? "Bringing up my two children at a relief camp is not the life I had imagined for myself," she said.

According to Election Commission officials, over 24,000 people living in the relief camps have been found eligible to vote and 94 special polling stations are being set up for the purpose. Posters of political parties, mega rallies and visible movement of leaders -- the traditional elements of campaigning -- are conspicuously missing in the strife-torn state.

The only visible hint of elections is the hoardings put up by local election authorities, urging citizens to exercise their franchise. Major party figures have refrained from visiting the conflict-ridden state to canvass for votes or make electoral pledges.

The Election Commission is conducting various activities to sensitise the voters. "Special teams have been formed to deal with these voters with empathy and we have also started voter awareness activities. The activities are being designed keeping in mind the sentiments of the displaced people, who have lost the comfort of being in their homes, and there is some level of frustration and negativity," chief electoral officer, Pradeep Kumar Jha told PTI.( PTI)

## **Only one citizenship application filed** under CAA in Assam: Himanta

CM asserts minimal impact of CAA, takes swipe at anti-CAA protests

HT Bureau GUWAHATI, April 8: GUWAHATI, April 8: Chief minister Himanta Biswa Sarma on Monday took a jibe at those protesting against the Citizenship Amendment Act (CAA) and asserted that only one person has applied for citizenship under CAA rules in the state to date.

Sarma has been campaigning for BJP candidates in different constituencies since the election dates were announced by the Election Commission of India (ECI).

He said, "It has been a month since the central government notified the rules to apply for citizenship under CAA, and an online portal for it was also launched. But only one person from Assam has applied for citizenship under the provisions of CAA. The person belongs to the Barak Valley region."

Launching a sharp attack on anti-CAA protesters,

the chief minister said, "A section of people tried to make citizens fearful by claiming that lakhs of people would get citizenship under CAA. Now those must be held accountable before the public.'

The chief minister also argued that in Bengali-dominated areas in the state, CAA does not have any impact on the ground.

"You can take the Sonari assembly constituency. Many Bengali-speaking people are residing here. But no one has applied for citizenship under the new rules," he added.

Sarma also mentioned, "I have been saying for many days that the applications for citizenship under CAA would be few.'

Notably, All Assam Students' Union (AASU) and several other organisations have protested in the state soon after the rules of CAA were notified by the Union government last month.

TEZPUR, April 8: Directives have been issued to Gana Suraksha Party candidate Rinku Roy and Independent candidate Pradip Bhandari, contesting from 11-Sonitpur HPC for the upcoming general election to Lok Sabha 2024, by the district commissioner of Sonitpur cum returning officer of 11-Sonitpur HPC on Sunday. According to the letter, both contesting candidates failed to produce the Election Expenditure Registers (day-to-day register, cash register, and bank register) before the expenditure observer/assistant ex-

penditure observer for inspection on April 6, 2024. Therefore, they are directed to produce the mentioned documents by April 9, 2024, for inspection by the expenditure observer. It is further stated that failing to comply will lead to the presumption that they have failed to maintain a day-to-day account of election expenditure as required under Section 77 of the RP Act 1951, resulting in the cancellation of permissions for public rallies and campaigning with immediate effect. Moreover, legal action will be initiated against the contesting candidates as per provisions.

"Students should be job creators who can contribute to the upliftment of the nation," he added. The Governor expressed his delight at being part of the first convocation ceremony of RTU, stating that it is a historic day for Rabindranath Tagore University. The Governor described convocation as the biggest festival for students, as they are conferred with the degrees for which they have toiled hard for years. He emphasised the vital contribution of parents and teachers, stating that it needs to be remembered and



cherished always. The Governor further remarked that the name of the university, honouring the legendary poet Rabindranath Tagore, makes it a more special and revered place. "Now, it is the responsibility of the students to maintain the honour and respect of Rabindranath Tagore University," he said.

The Governor further lauded the efforts of Prime Minister Narendra Modi. He said under PM Modi's visionary leadership, India is prospering rapidly in all sectors. He also praised chief minister Himanta Biswa Sarma for his optimistic and bold decisions for the all-round development of Assam, especially in the education sector. Dr Virendra M Tiwari, director of CSIR-North East Institute of Science and Technology (CSIR-NEIST), Jorhat, graced the occasion as the chief guest. While speaking on the occasion, he highlighted the fundamental principles of Tagore's educational philosophy. He expressed a strong conviction that Rabindranath Tagore University, Hojai, will be the torchbearer of the fecund legacy, spirit, and motto of modern education envisioned by Rabindranath Tagore and will blend well to

complement the New Education Policy. Speaking on the special occasion, vice chancellor Prof Amalendu Chakrabarty said it is a great pleasure and honour for all of us. Rabindranath Tagore University is a prime example in front of us as a budding educational institution for higher education, which has developed rapidly with consistent success and performance by our teachers and student fraternity. He said the location of the university serves an important purpose of socio-cultural solidarity among us. He noted that Assam is a mini-India filled with a mixed population from diverse cultures, and so is Hojai, a mini Assam, which brings together people from various cultures and innumerable social spaces. It is noteworthy that a total of 1124 students were conferred degrees in the first convocation ceremony of RTU, out of which 950 students completed graduation and 184 students completed post-graduation. Notably, 569 students registered their names to attend the convocation, out of which 118 students completed post-graduation from the Arts stream and 56 students completed post-graduation from the Science stream. Additionally, 472 students of Arts, 272 students of Science, and 206 students of Commerce completed gradua-

tion. On the other hand, two students who excelled in post-graduation (2023) at the university were awarded gold medals and degrees.

Nashima Yesmin of the Chemistry department was awarded the Radhika Ranjan Chakraborty Memorial Gold Medal, and Puja Chanda of the Bengali department was awarded the Basanti Chakraborty Memorial Gold Medal. Simultaneously, a student with disability, Neha Das, who had completed her graduation from the department of English in 2019, was also conferred with a degree. At the outset, the ceremony began with the singing of the national anthem and the university Song. Following that, Tilak Chandra Kalita, Registrar (I/c) of RTU, delivered the welcome speech. The convocation ceremony concluded with the singing of the national anthem and the state song of Assam, 'O Mur Apunar Dekh'. It is worth mentioning here that on July 11, 1964, Hojai College was established in Hojai, which has been a beacon of education for more than half a century. Then, on October 16, 2017, Hojai College was upgraded to Rabindranath Tagore University, and the first vice chancellor, Prof Amalendu Chakrabarty, joined the institution in the year 2019.

Flying squad officer killed

According to sources, Jayanta Kro, an assistant engineer of Kathiatoli Development Block currently appointed as an officer of a flying squad team for the upcoming Lok Sabha polls in the district, lost his life in the accident near Hanhchora Boraligaon village under Samaguri PS while on duty early on Monday morning. The incident occurred when a TATA Maxximo car carrying the deceased and his team collided with a parked truck near Hanhchora Boraligaon village.

Jayanta Kro and his teammates, identified as Dipankar Das, Mojidul Islam, and a camera person, were promptly rescued by local Samaguri police and transported to a Nagaonbased local hospital in critical condition. Sadly, Jayanta Kro was declared brought dead by the on-duty doctor.

Historically, the Northern Tamil regions were renowned for their exceptional productivity in supplying top-quality seafood for export.

However, the relentless pursuit of shrimps, blue swimming crab, and cuttlefish by Indian bottom trawlers has drastically altered the landscape. This exploitation has led to an estimated annual loss of around US\$ 750 million to Sri Lanka, impacting approximately 50,000 fisher families.

According to a study referenced in a research paper submitted to the Sir John Kotelawala Defense University, it was found that in 2016, an estimated 1000-1500 mechanized trawlers frequented the waters of the Palk Strait, Palk Bay, and Gulf of Mannar, operating three days a week. During these trips, they managed to harvest around 1900 tons of shrimps and 4000 tons of demersal fish.

Before the invasion of Indian trawlers, Northern Sri Lankan Tamil fishermen were accustomed to earning three times the amount they currently make, with their daily income ranging between just LKR 600 to 800.

Fishermen from the Sinhalese community in South Sri Lanka engage in fishing expeditions in Indian waters, albeit not in the Palk Strait and Palk Bay. Their ventures extend to the deeper expanses of the Bay of Bengal and the Arabian Sea, facilitated by multiday boats.

Occasionally, they encounter interception for fishing in Indian territories but are typically released afterward. (The writer can be reached at dipakkurmiglpltd@gmail. com)

A top leader once quipped: "Congress Shivji ka baarat hai" (Congress is like marriage party of Lord Shiva), meaning a gathering of all kinds of ideological adher-

ents. Ever since Rahul started forming a significant grip on the party apparatus, giving it a left-of-centre and pro-social justice re-emphasis, a significant number of Congress leaders deserted the party and stood in queue before Modi and Amit Shah's doors for entry into the BJP. Undeniably, these so-called leaders are only interested in their share of the power pie and living off the illgotten fruits of neoliberal corporatism; they simply cannot

Gandhi and party president Mallikarjun Kharge to give a new shape and dimension to the party has betrayed fears within the entrenched second-tier leadership within Congress, itself a product of the liberalization and privatization era. It would be wrong to describe Sharma's action as irresponsible. It reflected his strong class identity and commitment. It would not be wrong to infer that the class of such upper caste leaders nursing strong feudal trait would not like Congress to win the 2024 Lok Sabha election. Termination of status quoist and right of centre politics would harm their class interest. Count the faces that left Congress and joined BJP. Most of them shifted their allegiance because Congress could not be taken for granted anymore to fulfil their narrow class interest

Leaders like Sharma, Ghulam Nabi and others realise that Congress with its old approach could not aspire to regain its space in Indian politics. **Considerations: NavIC 2.0** 

NavIC currently comprises a constellation of 10 satellites (nine satellites IRNSS-1A to IRNSS 1I and the latest launched NVS-01 as the tenth satellite), with only five currently operational, positioned in geostationary and geosynchronous orbits. This indigenous system provides precise, dependable, and secure Positioning, Navigation, and Timing (PNT) services within India and its neighbouring region, spanning up to 1500 km from its borders.

The genesis of the Indian Regional Navigation Satellite System (IRNSS) can be traced back to 1999; however, it was during the Kargil conflict that the strategic necessity for an independent satellite navigation system became apparent. Primarily, the constellation was intended for strategic services to ensure selfreliance in times of need whereas, the civilian services were spin-off accrued out of the same space and ground segment infrastructure.

It offers two distinct applications: Standard Positioning Services (SPS) for civilian purposes and Restricted Services (RS) for strategic functions. Since the launch of its first satellite, IRNSS 1A on 1 July 2013 till the launch of the last first generation satellite IRNSS-11 on 12 April 2018, NavIC has been operating on L5 and S frequency bands and the foreign-origin rubidium atomic clocks which were sourced from Israel.

The constellation comprising the first generation series suffered inherent drawbacks in terms of signal penetration, range, infrastructural and design compatibility, cost-effectiveness, interoperability and stability of precise clock timing—three out of seven atomic clocks had

The recent launch of the first of second generation satellite NVS-01, also known as IRNSS-1J and the 10th satellite of the IRNSS constellation, marks a significant advancement. It introduces the L1 frequency band for civil mobile usage, enhancing the capabilities of the NavIC system.

The NVS-01 satellite incorporates a state-of-the-art atomic clock, developed indigenously to replace the previous Israeli rubidium clock. Alongside improved encryption systems, this satellite ensures superior accuracy, enhanced signal resilience, and optimal performance in challenging environments like urban canyons and dense foliage. Strategic self-sustenance

Presently, NavIC functions with only five fully operational satellites (including the recently launched NVS-01) to provide the bare minimum navigation signal in the service area. In 2024, IRNSS-1B and 1C are likely to complete their designed lifespan thereby creating a criticality for immediate replacement launches. Thus, the replacement cycle continues to barely sustain the constellation of satellites which provide essential signals with moderate accuracy.

The essence of introducing NavIC 2.0 is to graduate from the current state of sustenance flux to an overarching effective global strategic PNT solution. Therefore, it is to be understood in totality that a fully functional constellation with designed 11 satellites enhances the accuracy and seamless data flow within the limited service region but, expansion of the coverage area to achieve global access is highly inevitable for military op-

erations If not today, probably in half a decade, we would be stranded at the current operational crossroads once again, trying to stitch previous gaps. Strengthening the traditional practice of simply maintaining the constellation, which was primarily for technical demonstration purposes at the time of launch, may not be a wise strategy for achieving operational success.

With India emerging as a global power, the need for the expansion of indigenous PNT services across the planet has become a mandatory requirement, especially for disaster management and Out of Area Contingency operations (OOAC).

The enhanced applications of NavIC 2.0 will not only provide an edge to the military utility of NavIC 2.0 but also establish India commercially at par with the global major four-the US, China, Russia, and Europe. The actions must commence on various strategic facets as discussed, to ensure the usage of global NavIC services by 2028.

Space segment: Replacement of the extant satellites owing to ageing and malfunctioning is desired by 2025 and the launch of an additional 12 satellites in MEO by 2028 (to be enhanced subsequently to 24 or more by 2035). Responsibility should be assigned to the Headquarters of the Integrated Defence Staff (HQ IDS) for defence usage planning and New Space India Limited (NSIL)/ ISRO/ private space sector in conjunction with DRDO for execution.

Ground segment and functional units: A high-speed secure and tailor-made network for strategic control centres, timing facilities, integrity monitoring stations and two-way ranging stations needs to be evolved alongside the space segment by 2025. Standardised military grade fully secure user modules specific to the service/ organisation must be evolved and put in use before the expansion of the constellation.

Services: Other than the vital one-way position, navigation, timing and targeting services provided by NavIC, messaging broadcast services and two-way transmission are essential to fully exploit the indigenous constellation for national security. Conclusion

NavIC 2.0 represents a paradigm shift, propelling India from regional navigation to a global one. The innate strategic considerations for reinforcing space and ground segments for security applications have given rise to a much-needed proactive shaping of NavIC 2.0.

The strategic roadmap outlined ensures the evolution of NavIC 2.0 with enhanced features, global coverage, and military precision.

As India prepares to replace old satellites, launch new ones, and develop a robust ground segment, NavIC 2.0 is poised to secure India's place among global majors in PNT services. holesterol is a waxy substance that travels through the bloodstream as a part of two lipoproteins: low-density lipoprotein (LDL) and high-density lipoprotein (HDL).

People sometimes refer to LDL cholesterol as "bad" cholesterol because it causes fatty deposits to build up in the blood vessels. These deposits can block blood flow and cause heart attacks or strokes.

HDL, or "good," cholesterol helps remove cholesterol from the body through the liver. High HDL cholesterol levels can reduce the risk of heart problems and strokes.

This article lists foods people can incorporate into their diet to improve their cholesterol levels. It also looks into which foods to avoid.

Foods to eat

Below are a range of foods that may help lower holesterol as part of a varied diet. Eggplant

Eggplant is high in dietary fiber with 1-cup containing 2.4 grams (g). As the American Heart Association (AHA)Trusted Source notes, fiber helps improve blood cholesterol levels. It also reduces the risk of developing:

• heart disease • stroke

• obesity

• type 2 diabetes

Okra

Okra, or lady's fingers, is a warm-season vegetable that people cultivate worldwide. Researchers have found that a gel in okra called mucilage can help lower cholesterol by binding to it during digestion. This helps cholesterol leave the body through stool. Apples

A small 2019 study found that among 40 participants with mildly high cholesterol, eating two apbles a day reduced both total and LDL cholesterol levels. It also lowered levels of triglycerides, a type of fat that enters the bloodstream after a meal. One apple can contain 3–7 g of dietary fiber, de-

pending on its size. In addition, apples contain compounds called polyphenols, which may also have a positive effect on cholesterol levels. Avocado

Avocados are rich in heart-healthy nutrients. A 2015 study concluded that eating one avocado a day as part of a moderate fat, cholesterol-lowering diet can improve cardiovascular disease risk, specifically by lowering LDL cholesterol without owering HDL cholesterol.

One cup of avocado contains 14.7 g of monounsaturated fats, which can reduce LDL cholesterol levels and lower the risk of heart disease and strokes.

Fish

significant 4.76 milligrams per deciliter. Overall, the researchers concluded that soy pro-

tein can reduce LDL cholesterol by around 3-4% in adults, cementing its place in a heart-healthy, cholesterol-lowering diet.

Dark chocolate

Cocoa, which is in dark chocolate, contains flavonoids, a group of compounds in many fruits and vegetables. Their antioxidant and anti-inflammatory properties can benefit health in various ways

In a 2015 randomized trial, participants drank a beverage containing cocoa flavanol twice daily for 1 month. By the end of the trial, their LDL cholesterol levels and blood pressure had decreased, and their HDL cholesterol levels had increased. However, people should eat dark chocolate

products in moderation, as they can be high in saturated fats and sugar. Lentils

Lentils are rich in fiber, containing 7.8 g per half-cup portion. Fiber can prevent the body from absorbing cholesterol into the bloodstream.

A small 2015 study that included 39 participants who had type 2 diabetes and overweight or obesity demonstrated the positive effects of eating lentil sprouts on cholesterol levels.

Garlic People can use garlic in many dishes and it has many health benefits. For example, researchers have found that garlic can help regulate serum cholesterol levels. A 2015 meta-analysis also determined that garlic can also help reduce blood pressure.

However, these reviews involved garlic supplements — it would be difficult to include enough garlic in the diet to have a noticeable effect on cholesterol levels.

Green tea

Antioxidants called catechins in certain teas, such as green tea, can benefit health. A 2020 review found that green tea consumption significantly improved cholesterol levels, reducing both total and LDL cholesterol levels without lowering HDL cholesterol levels. The researchers call for further studies to confirm their findings

#### Extra virgin olive oil

Extra virgin olive oil features regularly in the heart-healthy Mediterranean diet. One of its many uses is as a cooking oil.

Substituting saturated fat with monounsaturated fat, found in extra virgin olive oil, might help reduce LDL levels.

Moreover, extra virgin olive oil has antioxidant and anti-inflammatory properties that can be beneficial to cardiovascular and overall health.

n April 3, 1968, standing before a crowded church, the Rev. Martin Luther King Jr. painted his vision for justice. "I've seen the Promised Land," he said. "I may not get there with you. But I want you to know tonight that we, as a people, will get to the Promised Land.

King's prophetic words express the virtue of hope amid hardship. He was not optimistic that he would reach the "Promised Land," yet he was hopeful about the ultimate goal.

One of the most common tools to measure optimism asks people how much they agree with statements such as, "In uncertain times, I usually expect the best." Those who strongly agree are regarded as highly opti-

Many of our interviewees anchored their hope in their Christian faith, as did King. King often referenced St Paul, one of the first Christian writers, who wrote, "Suffering produces endurance, endurance produces character, and character produces hope. Now this hope does not disappoint us."

Hope, in other words, plays the long game: enduring suffering with integrity. Like King's, it manifests in hardship and is refined in adversity. Hope enables communities to march for justice and democracy even while tasting the danger of dictatorship, apartheid or oligarchy. Hope knows it may take another generation to reach the Promised Land, but it acts today to bend the moral arc toward iustice (Courtesy:

Omega-3 fats, such as eicosapentaenoic acid (EPA), are essential polyunsaturated fats found in fish such as salmon, mackerel, and sardines, with well-documented anti-inflammatory and heart health benefits.

Oats significantly improved blood cholesterol levels over a period of 4 weeks in a small 2017 study. The team found that the participants' LDL cholesterol levels fell by 11.6% in 28 days.

Other research from 2019Trusted Source confirms that the soluble fiber in oats lowers LDL cholesterol levels and can improve cardiovascular risk as part of a heart-healthy diet.

A person can add oats to their diet by eating porridge or oat-based cereal for breakfast.

Barley Barley is a healthy grain rich in vitamins and minerals and high in fiber.

A 2020 paper found that a soluble fiber — betaglucan — reduces LDL cholesterol by trapping bile acids and limiting how much cholesterol the body absorbs during digestion.

The body uses cholesterol to produce bile acids, replacing trapped ones, which leads to an overall reduction in cholesterol levels.

The beta-glucan in barley also has a positive effect on the gut microbiome and blood sugar control, further benefiting heart health.

Nuts

Nuts are a good source of unsaturated fats, which can help lower LDL cholesterol levels, especially when they replace saturated fats in the diet.

Nuts are also rich in fiber, which helps keep the body from absorbing cholesterol and promotes its excretion.

All nuts are suitable for a heart-healthy, cholesterol-lowering diet, including:

Soybeans and soy products, such as tofu, soy milk, and soy yogurt, are suitable for a cholesterol-lowering diet.

A 2019 analysis of 46 investigations into the effects of soy on LDL cholesterol found that a median intake of 25 g of soy protein per day over 6 weeks lowered LDL cholesterol by a clinically

other nutrients. One cup of boiled kale contains 4.7 g of fiber.

A 2016 review demonstrated the link between fiber intake and a reduction in blood fat levels and blood pressure. Including more fiber in the diet can help lower levels of total cholesterol and LDL cholesterol.

Kale is also very rich in antioxidants, which are good for the heart and help reduce inflammation. Foods to avoid

The AHA recommends reducing the amount of saturated and trans fats in the diet to lower cholesterol and heart disease risk.

To reduce levels of LDL cholesterol, limit the intake of the following foods which contain high levels of saturated and trans fats:

• fatty meat, such as lamb and pork

- lard and shortening
- butter and cream
- palm oil
- cakes and donuts
- pastries
- · potato chips
- fried foods
- full fat dairy products

#### What reduces cholesterol quickly?

According to the AHA, the fastest way to lower cholesterol through dietary intervention is to reduce intake of saturated fats and heavily processed foods while increasing fiber intake.

#### How do you lower cholesterol naturally?

The best way to reduce cholesterol is to eat a diet rich in high fiber, whole fruits and vegetables, whole grains, and healthy fats.

Lifestyle and diet changes can reduce cholesterol levels quickly. These include:

• limiting saturated fats from the diet

- increasing physical activity levels
- reducing alcohol intake
- quitting smoking, if necessary

Are bananas good for cholesterol? Bananas are rich in soluble fiber and potassium. Both of these can have a positive effect on increasing digestive transit time, lowering cholesterol, and reducing blood pressure, when eaten as part of a healthy diet.

Will drinking a lot of water lower cholesterol? While ensuring adequate hydration is essential to overall health, cholesterol is not a water-soluble

fat, and drinking large amounts of water will not lower cholesterol.

#### Summarv

Maintaining low LDL cholesterol levels is important, as it decreases the risk of heart disease and stroke. A person can do this by following a healthy diet that includes high fiber fruits and vegetables, whole grains, nuts, fatty fish, unprocessed soy, and the occasional dark chocolate treat.

## Russia Foreign Min Lavrov visits Beijing to emphasize ties with strongest political ally



**BEIJING, April 8:** Russian Foreign Minister Sergey Lavrov arrived in Beijing on Monday to display the strength of ties with close diplomati-China cally amid Moscow's grinding war against Ukraine. The two continent-

sized authoritarian states, increasingly in dispute with democracies, seek to

gain influence in Africa, the Middle East and South America. China has backed Russia's claim that President Vladimir Putin launched his assault in 2022 because of Western provocations, without producing any solid evidence.

Russian state news agency Tass said the ministers would "discuss the situation in Ukraine and the Asia-Pacific region, issues of bilateral cooperation and interaction in the international arena," quoting Russian Foreign Ministry spokesperson Maria Zakharova. Lavrov is expected to meet with his Chinese counterpart Wang Yi, who has visited Russia during the conflict and maintained China's line of not dubbing the Russian war in Ukraine an invasion.

China has at times taken an equally combative tone against the U.S. and its allies. China and Russia have held joint military drills, and are seen as seeking to supplant democracies with dictatorships in areas where they wield influence. Despite its clear backing of Russia in the Ukraine war, China's foreign ministry spokeswoman Mao Ning told reporters Monday that "China has an objective and fair position on the Ukraine issue.

"We have been actively promoting peace talks and political solutions. China is not a creator or party to the Ukraine crisis, and we have not and will not do anything to profit from it," Mao told reporters at a daily briefing. China has also said it wasn't providing Russia with arms or military assistance, although it has maintained robust economic connections with Moscow, alongside India and other countries.

'We have always controlled the export of dual-use items in accordance with the law." Mao said, referring to industrial items that can be used for both industrial or military purposes, such as drones.

"The relevant country should not smear or attack the normal relations between China and Russia," Mao said. "The relevant country" was a reference to the U.S., Russia and China's chief geopolitical rival.

In a phone call last week with Chinese leader Xi Jinping, U.S. President Joseph Biden pressed China over its defense relationship with Russia, which is seeking to rebuild its industrial base as it continues its invasion of Ukraine. And he called on Beijing to wield its influence over North Korea to rein in the isolated and erratic nuclear power.

Adding to the tension between the two countries, U.S. lawmakers generated new legislation that would ban TikTok, the popular social media application, if its China-based owner ByteDance doesn't sell its stakes in the platform within six months of the bill's enactment.

Lawmakers are concerned Chinese authorities could force ByteDance to hand over data on the 170 million Americans who use TikTok. All Chinese firms, especially those in the social media sphere, are obligated to hand over user data to the government. (AP)

## Motorcycle bomb kills 2 people and wounds 5 in Pak's restive southwest

QUETTA, April 8: A motorcycle bomb killed two people and wounded five in Pakistan's southwest, a police official said on Sunday

It's the latest unrest to hit Baluchistan province, where militants have tried to target a naval facility and a government building in recent weeks.

Nobody immediately claimed responsibility for Sunday's blast

Deputy Commissioner Muhammad Arif Zarkon said a woman and two police officers were among the wounded.

For years, Baluchistan has been the scene of a low-level insurgency by groups demanding independence from the central government in Islamabad.

Although the government says it has quelled the insurgency, violence in the province has per-

#### **DEIR AL-BALAH, April** 8: Streams of Palestinians filed into the southern Gaza city of Khan Younis on Monday to salvage what they could from the vast destruction left in the wake of Israel's offensive, a day after the Israeli military announced it was withdrawing troops from the area. Many came back to the Gaza Strip's second-largest

city to find their former hometown unrecognizable. With scores of buildings destroyed or damaged, piles of rubble now sit where apartments and businesses once did. Streets have been bulldozed. Schools and hospitals were damaged by the

fighting. Israel sent troops to Khan Younis in December, part of its blistering ground offensive that came in response to a Hamas-led attack on Oct. 7 into southern Israel. Israeli authorities say 1,200 people, mostly civilians, were killed and roughly 250 people taken hostage. The war, now in its seventh month, has

and children, according to local health authorities, displaced most of the territory's 2.3 million people and left vast swaths of the beleaguered Gaza Strip uninhab-"Many areas, itable. especially the city center, have become unfit for life," said Mahmoud Abdel-Ghani, who fled Khan Younis in December when Israel began its ground invasion of the city. "I found that my house and my neighbours houses turned to rubble."

Israel's withdrawal of troops from Khan Younis signaled the end of a key phase in its war against Hamas and brought Israeli troop levels in the tiny coastal enclave to one of the lowest since the war began.

Israel said the city was a major Hamas stronghold and says its operation over the past few months killed thousands of militants and inflicted heavy damage to a vast network of tunnels used by Hamas to move weapons and fighters. ## South Korea launches its 2<sup>nd</sup> military spy satellite amid animosities with North Korea

**SEOUL, April 8:** South Korea has launched its second military spy satellite into space, days after North Korea reaffirmed its plan to launch multiple reconnaissance satellites this year

The Koreas each launched their first spy satellites last year - North Korea in November and South Korea in December - amid heightened animosities. They said their satellites would boost their

abilities to monitor each other and enhance their own missile attack capabilities. South Korea's second spy satellite was launched from the Kennedy Space Center in Florida on Sunday

South Korea's Defense Ministry said in a statement that the satellite was successfully separated from a rocket. It said it will check whether satellites by 2025. South Korea's first spy satellite launch on Dec. 1 was made from California's Vandenberg Space Force Base

South Korea in 2022 became the world's 10th nation to successfully launch a satellite with its own technology by using a homegrown rocket to place what it called a "performance observation satellite" in orbit. But experts say it's economical to use

KYIV, April 8: A senior Ukrainian official has denied Russian accusations that his country's army fired exploding drones at Europe's largest nuclear power plant, which the Kremlin's forces have been occupying and running in southern Ukraine since shortly after the war began more than two years ago.

Andrii Yusov, the spokesperson for Ukraine's military intelligence agency suggested there had been no attack, saying Russian forces routinely fabricate strikes on the Zaporizhzhia Nuclear Power Plant. However, the strikes on this occasion were confirmed by U.N.'s atomic watchdog agency, though it didn't attribute responsibility for the attack to either side.

The plant has repeatedly been caught in the crossfire since Russia launched its full-scale invasion of Ukraine in February

## US will push China to change a policy threatening American jobs, Treasury Secretary Yellen says

BEIJING, April 8: The Biden administration will push China to change an industrial policy that poses a threat to U.S. jobs, Treasury Secretary Janet Yellen said on Monday after wrapping up four days of talks with Chinese officials.

She also said in Beijing they had "difficult conversations" about national security, including American concerns that Chinese companies are supporting Russia in its war in Ukraine.

But the focus of her trip was industrial policy, and what the U.S. and Europe describe as manufacturing overcapacity in China. Wealthy nations fear a wave of low-priced Chinese exports that will overwhelm factories at home. Yellen cited the manufacturing of electric vehicles and their batteries as well as solar energy equipment — sectors that the U.S. administration is trying to promote domestically as areas where Chinese government subsidies have driven rapid expansion of production.

China is now simply too large for the rest of the world to absorb this enormous capacity. Actions taken by the PRC today can shift world prices," she said, using the acronym for China's official name, the People's Republic of China. "And when the global market is flooded by artificially cheap Chinese products, the viability of American and other foreign firms is put into question.

She said the U.S. would host Chinese counterparts for their fourth economic and financial working groups meetings next week "where these issues will be discussed at length." Last September, the U.S. and China formed working groups in an effort to ease tensions and deepen ties between the two nations. The upcoming discussions will coincide with the IMF and World Bank Spring Meetings.

It's unclear how China will respond to such calls. European officials have repeatedly raised the issue on visits to China with no sign



of any change on the Chinese side. Moreover, one of leader Xi Jinping's major goals is to build the nation into a major power so it doesn't feel compelled to bend to outside pressure

## **SLanka Freedom Party set to face** long legal battle in factional clash

COLOMBO, April 8: The Sri Lanka Freedom Party (SLFP) is set to get into a long legal battle this election year with separate factions trying to gain control of it as Nimal Siripala de Silva, an incumbent minister, was on Monday appointed the party's acting chairman in place of former president Maithripala Sirisena.

SLPP is one of the major and most well-known political parties in Sri Lanka which has ruled the island nation for many years.

"Today we took important decisions to carry out party functions without interruptions. The central committee meeting decided to elect an acting chair," Duminda Dissanayake, the party's national organiser, told the media.

Last week, Sirisena was clamped with a restraining order as the leader of the party after he dropped from party posts de Silva and two others, who are also ministers in President Ranil Wickremesinghe's government.

The trio has already obtained the court's interim orders suspending the action of Srisena, the 72-year-old former prime minister.

Following the restraining order on Sirisena, the police on Saturday shut the party headquarters after the Sirisena faction complained about the rival camp for allegedly stealing party files.

Sirisena after the court sanction against him accused former president Chandrika Kumaratunga of being behind the move to remove him as the leader.

The 78-year-old Kumaratunga was present at Monday morning's meeting which appointed de Silva as the acting chair.

The Sirisena faction told the media that Monday morning's purported central committee meeting was illegal.

The SLFP, which contested the last parliamentary election held in 2020 under the SLPP banner, has 14 members in the 225-member Assembly.

Some of them are members of the Wickremesinghe government. Sirisena claimed the trio defied the party whip, requiring them to remain in opposition.

The SLFP split comes as political parties are gearing up to face a presidential election in the last quarter of this year, with the next parliamentary polls falling due by mid-next year. (PTI)



NEW DELHI, April 8: The Congress complained to the Election Commission (EC) on Monday against Prime Minister Narendra Modi's remarks targeting the party and comparing its Lok Sabha poll manifesto with that of the Muslim League.

NEW DELHI, April 8: The Enforcement Directorate on Monday questioned Delhi Chief Minister Arvind Kejriwal's personal assistant Bibhav Kumar and AAP MLA Durgesh Pathak in the excise policylinked money laundering case, officials said. Their statement is being recorded under the provisions of the Prevention of Money Laundering Act (PMLA), they said.

Both of them have been questioned in this case earlier too by the ED. Sources said Kumar's questioning was essential in connection with the engagements of Kejriwal. The 55year-old CM, also the national convenor of the AAP, was arrested by the ED in this case last month. He is currently lodged in the Tihar Jail under judicial custody

The agency had alleged in its earlier charge sheets that at least 36 accused, including former Delhi deputy chief minister Manish Sisodia and Kumar, "destroyed, used or changed" 170 phones to conceal evidence of "kickbacks" worth thousands of crores of rupees in the alleged scam. The IMEI (International Mobile Equipment Identity) of Bibhav's mobile number is stated to have been changed four times between September 2021 and July 2022, according to

the ED charge sheet filed before a local court last year.

Pathak, the 35-year-old AAP MLA from Rajinder Nagar constituency, is understood to have been called by the agency for questioning in connection with the party's 2021-22 poll campaign for the Goa assembly polls. The ED has alleged that Rs 45 crore "kickbacks", out of the Rs 100 crore 'bribe" provided by the 'South Group', were used by the AAP for

this campaign. The agency has claimed that cash payments were made to individuals involved in campaign activities, managed by AAP members like Vijay Nair and Pathak

The agency informed the court that it has recorded the statements of various persons engaged in the election campaign related activities of the AAP during the Goa elections and it was found that "cash payments were made to them for work like survey workers, area managers, assembly managers etc."

NEW DELHI, April 8: The Congress and the National Conference on Monday announced contesting the Lok Sabha polls in Jammu and Kashmir, and Ladakh in alliance, with each fielding candidates in three seats.

At a joint press conference here, National Conference leader Omar Abdullah said the Congress would contest in Udhampur, Jammu and Ladakh Lok Sabha seats while the National Conference would field candidates in Anantnag, Srinagar and Baramulla.

"I want to formally announce that the National Conference and Congress will jointly contest the elections in Jammu and Kashmir and Ladakh with three candidates for each of the two parties," Abdullah said,

"The National Conference will support Congress candidates in Udhampur, Jammu and Ladakh seats. The INDIA bloc with contest the polls to help fulfil the aspirations of people of Jammu and Kashmir, and Ladakh and truly represent them in Parliament." he said

India helping five nations develop early warning systems, says IMD chief

NEW DELHI, April 8: India is helping Nepal, Maldives, Sri Lanka, Bangladesh and Mauritius develop early warning systems to reduce the loss of life and property due to extreme weather events, IMD chief Mrutyunjay Mohapatra has said.

In a conversation with PTI editors, the India Meteorological Department (IMD) director general said India will play the role of a big brother and a peer advisor to Nepal, Maldives, Sri Lanka, Bangladesh and Mauritius in the efforts to guard against the impact of extreme weather events.

India's efforts are part of the 'Early Warnings for All' initiative announced by the United Nations in 2022 to ensure that everyone is protected from hazardous weather, water or climate events through lifesaving early warning systems by the end of 2027.

Mohapatra said India is helping five of the 30 countries identified across the world for the first phase of the initiative of establishing early warning systems.

"Fifty per cent of the countries do not have an early warning system. The poor countries, least developed countries, and small island nations, for example, Maldives and Seychelles, do not have the capacity to provide early warning about extreme weather events. Therefore, people are dying and losing a lot of prop-erty because of disasters," he said.

These countries need financial and technical support to augment their meteorological observations.



Financial support will be provided through publicprivate partnerships and countries like India have pledged to provide technical support, he added.

"We will help these five countries set up meteorological observatories, allow them access to our nu-

merical models, create a decision support system, and computing power," Mohapatra said.

The IMD will provide forecasts and warnings and ministries of communication of the respective nations have been roped in to help develop a system for data

exchange and warning dissemination, Mohapatra said. According to a report released by the World Meteorological Organization (WMO) in December, 101 countries (52 per cent) now have multi-hazard early warning systems.

The WMO's findings show a concerning trend as disasters increased over five times between 1970 and 2019. Water-related disasters became the most common globally, with tropical cyclones causing the most harm to people and economies.

From 1970 to 2021, the world witnessed nearly 12,000 weather, climate or water-related disasters, resulting in more than two million deaths and economic losses of USD 4.3 trillion.

According to official reports, around 41,789 people died annually from disasters between 2015 and 2022. And the number of people affected by disasters has been rising, with more than 130 million affected globally every year.

In Asia, from 2013 to 2022, more than 146,000 people lost their lives due to disasters and over 911 million were directly affected. Economic damages in 2022 alone were over USD 36 billion, mostly due to flooding and storms.

It is projected that by 2030, the world could face 560 medium- to large-scale disasters each year. Climate change not only makes disasters more likely but also harder to respond to those, the WMO had said. (PTI)

# Kannur's country bomb blast sparks political controversy ahead of Lok Sabha polls

THIRUVANANTHAPURAM, April 8: With the Lok Sabha polls just weeks away, the recent country bomb blast in northern Kannur that killed a person and injured three others who were allegedly making the crude explosive has triggered a political quarrel in Kerala.

The opposition Congress has accused activists of the ruling CPI(M) of direct involvement in bomb-making, while the Marxist party has denied the charges and distanced itself from the allegations and the persons who were injured in the blast.

Leader of Opposition in the State Assembly V D Satheesan alleged on Monday that the person responsible for making the bomb, who was killed in the blast, was affiliated with the ruling party. Those who were injured in the explosion, which took place at Panur in Kannur district on Friday, and those who had taken them to the hospital were also CPI(M) workers, he said.

"Those who went for the funeral of the deceased person were also activists of the CPI(M). Then how can the ruling party evade responsibility for making the bomb?" Satheesan asked while talking to reporters here.

Asking whether the bomb was made to kill the activists of the Congress-led UDF, he also accused Chief Minister Pinarayi Vijayan, who holds the home portfolio, of promoting criminals.

"The chief minister is the one who encourages all criminals in the state. Then he says that they will win the Lok Sabha polls. The LDF will not win even a single seat," the LoP remarked.

Meanwhile, Vijayan assured the public that he would take stringent action, beyond politics, against those involved in bomb making but defended the CPI(M) in the ongoing row.

He also justified the visit of the party's local leaders to the house of Sheril, a resident of Kaivelikkal who had succumbed to blast injuries, saying they did not do anything "prohibited". While speaking to reporters at Adoor in



Pathanamthitta, Vijayan said the making of CPI(M).

bombs cannot be accepted at any cost. "There is no need to make bombs in our state. Legal actions have already been taken in this regard. There is no need to see things politically. It (bomb-making) was a crime, and we have taken action against those involved in it," he said.

While replying to a question, the CM further said he does not think that visiting the house of a deceased person is a "prohibited act" and said consoling the family members was not at all a wrong thing.

CPI(M) State Secretary M V Govindan also defended the party in the bomb blast incident and said it had no role in it.

The party's stand is that there should be no conflict anywhere, he said, and claimed that the CPI(M) is viewing even the attacks against it with self-restraint.

NEW DELHI, April 8: Cases will be registered against the chief secretary and the health secretary over the shortage of medicines in Delhi government hospitals and dispensaries, Health Minister Saurabh Bharadwaj on Monday said in the assembly.

The issues of medicine shortage in Delhi government hospitals and dispensaries and the stoppage of free diagnostic tests at mohalla clinics by "some officers concerned" were raised by AAP MLA Rajendra Pal Gautam through a calling attention motion under Rule 54

Bharadwaj submitted two reports, including one from the chief secretary and the health secretary, saying they gave in writing that medicines were available in hosptials and mohalla clinics and those unavailable were substituted.

The other report was based on the feedback of MLAs, news reports and his own inquiries, the minister said

He alleged that the Central Procurement Agency (CPA) tender of 2023 was not finalised despite the availability of bids under a "premeditated conspiracy". Medicines for government hospitals, dispensaries and mohalla clinics are procured through the CPA, he said.

The health minister said the issues of medicine shortage and stopping of tests at mohalla clinics came to light in January. He wrote to the chief secretary for details and action on February 12, and again on March 4 and March 18 but nothing happened.

There are alternative methods of medicine procurement through local purchase or contract rate purchase by the hospitals but the medical superintendents and the medical directors informed in meetings held on March 1 and March 11 that it was made "impossible" due to circulars issued by the

Health department, said the minister "So, it was a pre-planned conspiracy to stop medicine supplies by obstructing the CPA tender. What will (Chief Minister) Arvind Kejriwal or Saurabh Bharadwaj do if medicines itself are not available at the hospitals and dispensaries?" he said in the House.

Training his guns at Delhi Lt Governor VK Saxena, Bharadwaj said he wrote to him repeatedly and pointed out that the chief secretary and the health secretary were "misleading me and the Delhi

government" by "hiding" the shortage of medicines and sought action against them but no action was taken.

Lakhs of people depend on government hospitals, dispensaries and mohalla clinics for medicines, including those for serious ailments, Bharadwaj said and sought to know from the House if criminal prosecution should not be initiated if someone dies or falls gravely ill due to a lack of medicines.

"We will not sit quietly, we will register cases. I will register a case against the chief secretary and the health secretary for this. We will not let it go like this," said the health minister.

Several AAP MLAs, including Gautam, Sanjeev Jha, Rakhi Birla and Mahender Goel raised the issue of unavailability of medicines in hospitals and mohalla clinics. (PTI)

## Sub-metre optical satellite assembled, tested in India deployed into space: TASL

NEW DELHI. April 8: Tata Advanced Svstems Limited on Monday announced the "successful deployment" into space of its sub-metre optical satellite that was assembled and tested in India.

SpaceX's Falcon 9 rocket launched TSAT-1A satellite from the Kennedy Space Center. Florida, in the US on Sunday (April 7), Tata Advanced Systems Limited (TASL) said in a statement.

"TSAT-1A will deliver high-resolution optical satellite images with increased collection capacity, dynamic range, and low-latency delivery through its multispectral and hyperspectral capabilities," the company said

A wholly owned subsidiary of Tata Sons, TASL is a significant player for aerospace

TASL. India's leading private sector player for aerospace and defence solutions, and Satellogic Inc, a leader in sub-metre resolution Earth Observation data collection, "today announced the successful deployment into space of TASL's TSAT-1A satellite aboard the Bandwagon-1 mission, which SpaceX's Falcon 9 rocket", the statement said.

TSAT-1A was assembled in TASL's Assembly, Integration and Testing (AIT) plant at its Vemagal facility in Karnataka, it said. This achievement follows the collaboration agreement signed between TASL and Satellogic in November, leveraging Satellogic's expertise to develop and integrate an advanced Earth Observation satellite in India

and TASL's capability to undertake complex system integration, it added.

"This milestone shows TASL's commitment to the space sector. This is a first step. Our partnership with Satellogic has enabled us to deliver an assembled and tested in India, best-in-class, sub-metre optical satellite which was launched by SpaceX. ## AI, power purchase deals to help Delhi discoms meet **Be prepared for 'black swan' events, expect** expected summer peak demand of over 8000 MW the unexpected: Army Chief to force

BSES discoms are geared up to ensure reliable power supply to meet the power needs of around 50 lakh consumers of the company

NEW DELHI, April 8: The use of latest technologies such as artificial intelligence and long-term power purchase agreements with other states are among the steps taken by discoms to meet the national capital's high power demand this summer, officials said on Monday.

With high temperatures projected for the season, Delhi's peak power demand is expected to cross 8,000 MW for the first time, reaching up to 8,200 MW, according to State Load Dispatch Centre data.

The officials said the city's previous high was 7,695 MW in 2022 and last year's peak power demand was 7.438 MW

The peak power demand in the areas covered by BSES Rajdhani Power Limited's (BRPL) -- South and West Delhi -- which were 3,250 MW and 3,389 MW in the summers of 2023 and 2022 respectively, are expected to reach around 3,679 MW this summer, a BSES spokesperson said

The other BSES discom BYPL recorded the peaks of 1,670 MW and



1,752 MW during the summers of 2023 and 2022 respectively, in its distribution areas of Central and East months, he said

Delhi. This year it is expected to reach 1,857 MW, he said. The BSES discoms are geared up to ensure reliable power supply to meet the power needs of around 50 lakh consumers of the company, said the company spokesperson.

These arrangements include around 2,100 MW of green power

that will play an important role in meeting the demand in summer

Besides, long-term power purchase agreements and banking arrangements with other states and deployment of latest technologies such as artificial intelligence and machine learning to predict power demand will be used, he added.

The BSES has made power banking arrangements with many states,

from where its two discoms in the national capital will get upto 670 MW of power, the spokesperson said. A Tata Power Delhi Distribution Limited (TPDDL) spokesperson said that Delhi's summer peak power demand is expected to surge above 8,000 MW and the company expects its own peak demand to scale up to 2,351 MW this season.

Last summer, TPDDL saw a peak power demand of 2,218 MW in August 2023, she said.

"The peak load of the national capital is projected to reach 8,000 MW in late June or early July amid anticipation of scorching temperatures this year," she said.

"As we approach the summer season, we anticipate the peak demand to reach approximately 2,351 MW within our jurisdiction and we are well-prepared to meet this demand,' said Ganesh Srinivasan, chief executive officer of the discom.

"Our proactive approach includes rigorous safety measures and maintenance initiatives across our distribution network," Srinivasan said. (PTI)

NEW DELHI, April 8: Army Chief Gen Manoj Pande on Monday called upon the force to be always prepared for 'black swan' events and "expect the unexpected" even as he identified technology as the new area for strategic competition among nations.

In an address at the Defence Services Staff College in Wellington, Gen Pande highlighted the weaponisation of technology, especially its extension across various domains - from information to supply chains.

The Army Chief emphasised the importance of cross-functional synergy among the three services to effectively assess threats, articulate strategies, identify capabilities, formulate policies, achieve preparedness, and respond appropriately within the national security framework.

He further delved into the expansion of warfare into new domains, including space, cyber, electromagnetic spectrum and information technology, sources in the Army headquarters here said

Gen Pande noted the rapid technological advancement in kinetic war instruments, saying it has made the battlefield increasingly complex, contested, and lethal.

The Chief of Army Staff urged the officers to be always prepared for 'black swan' events and "expect the unexpected".

A black swan event is a high-impact event that is difficult to predict.

The Army Chief pointed out the emergence of new trendlines triggered by this rapid change, underscoring how disruptive technologies are reshaping conventional combat force ratios.

Highlighting India's ascent on the global stage, Gen

Pande stressed the growing need to safeguard India's national interests across expanding strategic horizons. The Army Chief called for strategic balance, underscoring the necessity for India to be strong and selfreliant in defence capabilities.

He also shed light on the Indian Army's ongoing "transformative initiatives", particularly emphasising the forces' approach in making 2024 the "year of technology absorption".

He highlighted the key areas of focus in the process and said it includes aligning and synergizing technology at strategic, operational, and tactical levels within existing systems.

Under the new initiative, mapping futuristic and emerging technologies as drivers of military technology is a priority, he said, adding strengthening the defence technology ecosystem to maintain a lead in the military technology curve is another focus area.

The Army Chief said the force is ensuring that acquisition and procurement facilitates the seamless induction of technology and it fosters "techno warriors and commanders".

Gen Pande was addressing the faculty and officers of the 79th Staff Course, including 36 officers from friendly foreign nations.


His address covered critical topics such as national security, the geostrategic landscape and emerging trends, and the Indian Army's transformational initiatives.

**NEW DELHI**, April 8: There is a uni- out to watch a film without stars only versality to women's experiences across classes and a lot of it goes unrepresented in cinema, says director Kiran Rao who has attempted to tell a story of self-discovery through two brides in her critical hit "Laapataa Ladies"

The film, which had its world premiere at the 2023 Toronto International Film Festival, released in India to glowing reviews on March 1 and is still enjoying a run in theatres.

Rao, who promoted her second directorial effort across tier-one cities and small towns, said the women she met have probably not experienced being under the veil, but they could still identify with the issues explored in the movie, set in rural India in the year 2001. "There's some sort of universality in a woman's experience across classes and a lot of that goes unacknowledged, unseen or unrepresented in cinema," the filmmaker told PTI in an interview.

"Hearing the response to the film, I realised that it's possible to change the status quo with very small interventions and reclaim some space for ourselves, even within the setup that we, maybe, cannot change. That has been nice to hear from women," she said.

"Laapataa Ladies" is a satirical drama revolving around two young brides, Phool and Jaya, who get swapped during their journey to their in-laws' but the comedy of errors, propelled by the long veil, ends up being an empowering journey for both. The hope, post the movie's theatrical run, is to take it to the nooks and crannies of the country where a story like this may make a difference. Rao said.

"I'm still basking in the love that I'm getting and hoping that more people go and watch it if they have not seen it yet. Going forward, we want to collaborate with organisations that work with communities on gender and women's issues. "I have put a word out to people I

on the basis of the trailer," she added.

There have been some lessons along the way as well for the filmmaker, whose last release was her debut "Dhobi Ghat" in 2011

"You need a multi-pronged marketing campaign to reach people across the country because we have a diverse audience. There are some things that I would do differently when I make my next one," she said.

Film promotions can be hectic but Rao was able to find some moments of quiet by taking detours and spending time with her parents in Bengaluru.

"It's been crazy but in between promotional trips, I went to Bengaluru, I could spend a night with my parents. The director said she also managed to have "little expeditions" on her own while travelling from one city to another to promote "Laapataa Ladies", which she backed via her Kindling Pictures alongside Aamir Khan Productions, the company run by former actor husband. Rao, who worked as an assistant director on films such as "Lagaan" and 'Monsoon Wedding" and produced "Taare Zameen Par" and "Peepli

The filmmaker, best known for the 2018 blockbuster hit "Badhaai Ho", has teamed up with Devgn for the upcoming period sports drama which explores the golden years of Indian football in the early 1950s and 60s under coach Syed Abdul Rahim.

Sharma praised Devgn, who plays the role of Rahim in the film, for his commitment to "Maidaan".

"If a superstar has agreed to do a film, it's an advantage as the mounting of a film will become bigger. You'll be able to shoot the way you want to, and if the su-

perstar is ready to give you everything while making the film, then it's icing on the cake.

"When Ajay Devgn used to enter the sets, he used to keep the Ajay Devgn persona outside, and enter like Syed Abdul Rahim, his character. He came prepped on sets with his dialogues. Not once he said, 'The trousers are loose, how am I looking?' He would be like, 'Tell me what you want me to do, I'll do it'. He is a director's actor," the director told PTI in an interview here.

Sharma said there are three ingredients essential for a sportsbased film: knowledge about the sport, correct team, and getting the emotion right.

"For me, the story was not about football but about Syed Abdul Rahim, who brought glory to

"He didn't capture Tiger Hill but he won the Asian Games," he said about Rahim under whose stewardship, the India national football team won gold medals in Asian Games of 1951 and 1962.

A section of social media users have drawn parallels between "Maidaan" and the 2007 hit "Chak De! India", which followed a former hockey player who attempts to redeem himself by coaching and eventually, leading the Indian national women's hockey team to a win.

According to Sharma, the two films are different from one another "The difference between 'Chak

De! India' and 'Maidaan' is that while it was a fictional story, this is a true story. If you talk about the dream of a man who is trying to

bring glory to India through sports, that emotion is the same. But everyone will have the same emotion, it is there in '83' as well.

"The emotion is same, but the story and style are different. This story is different from 'Chak De! India' because the sports are different, however emotion wise it is the same, but the emotional journey of this person is different, the story is different. "Maidaan" faced many chal-

lenges during its making, including the multiple delays owing to the COVID-19 pandemic and cyclone Tauktae, and Sharma said these crises were beyond his control. (PTI)

On Friday, nine EC members had pasted a signed notice at the IOA office premises here, asking 'unauthorised persons" not to enter

its headquarters. The notice, which Usha termed as "arbitrary", was directed at two recently appointed officials.

A majority of EC members had earlier claimed that they had signed a suspension order declaring Raghuram Iyer's appointment as IOA CEO in January as null and void. The EC members also claimed that they had "terminated" Ajay Narang from the post of executive assistant to IOA president. Usha acknowledged the receipt of the termination letter served to Narang by the EC members but re-

jected it as "absolute nullity". "It is disheartening to see that we are still not able to work as a team and each of your acts is an attempt to sideline me," Usha said in her response sent to the revolting EC members.

"I am left with no option but to remind you all that the day-today administrative functions including hiring and firing of staff

is not the job of the Executive Council. As the EC, we should be using our powers and right for much more important aspects of taking the IOA to heights," she said.

NEW DELHI, April 8: South African fast bowler Lizaad Williams was on Monday roped in by Delhi Capitals as a replacement for batter Harry Brook in the ongoing Indian Premier League after the Englishman withdrew from the tournament to grieve his grandmother's death.

Since making his international debut in 2021, the 30-year-old Williams has represented South Africa in two Tests, four ODIs and 11 T20 Internationals. He has joined Delhi Capitals at his base price of Rs 50 lakh.

"Lizaad Williams, the South African fast bowler, has been signed by the Delhi Capitals as a replacement for England's Harry Brook for the remainder of the Indian Premier League (IPL) 2024," the franchise said in a statement. Brook, who was signed by Delhi Capitals for ₹ 4 crore, withdrew from the league after his grandmother died in February.

"I was so excited to be picked by Delhi Capitals and was so looking forward to joining up with everyone. Whilst I don't think I should need to share my personal reasons behind this decision, I know there will be many asking why. So I do want to share this,' he had shared on his social media page after withdrawing.

'I lost my grandmother last month -- she was a rock to me and I spent a huge amount of my childhood in her home; my attitude to life and love for cricket was shaped by her and my late grandfather," the 25-year-old wrote.

In his inaugural IPL season last year, when he turned up for Sunrisers Hyderabad, Brook set the stage on fire with a 55-ball hundred against Kolkata Knight Riders only to end on an underwhelming note.

In all, he managed only 190 runs in 11 matches after the franchise paid ₹ 13.25 crore to acquire his services. Brook had also pulled out of England's recent five-Test series in India after being part of the pre-tour training camp in the UAE. (PTI)

**Dean Burmester** wins LIV Golf after Sergio Garcia"s



## Madrid, reinvigorated by the signing of Jude Bellingham last summer Real Madrid will be out for revenge against Man City in the Champions League

MANCHESTER, April 8: The all-time kings of Europe take on the current holders in the standout tie of the Champions League quarterfinals.

For the third year running Madrid and City meet in a match-up in which the winner has gone on to lift the trophy in the past two seasons. And it would be difficult to look beyond either team going on to continue that streak this time around.

City is still in contention for back-toback trebles after winning the Premier League title, Champions League and FA Cup last year.

Madrid, reinvigorated by the signing of Jude Bellingham last summer, is eight points clear at the top of the Spanish league and aiming for a record-extending 15th European Cup title.

The Spanish giant also has a point to prove after being routed 4-0 by City in the second leg of last year's semifinals.

Then it was City who had a score to settle, having suffered a late collapse at the Bernabeu to crash out in the semifinals in 2022.

Manager Pep Guardiola will likely know how motivated Madrid will be to exact revenge — just as his players were last year — and that adds a subplot to a

tie that is already heavy on intrigue. Elsewhere, Paris Saint-Germain versus Barcelona is another clash of heavyweights, with Kylian Mbappe aiming to finally lead the French champions to European club soccer's elite trophy before walking away at the end of the season.

Premier League title-chasing Arsenal takes on a Bayern Munich team that is limping towards the end of a miserable campaign in the German league, while Atletico Madrid faces Borussia Dortmund

Bellingham has struck 20 goals in 32 games this season, including four in the Champions League. Vinícius Júnior is peaking just in time to face City with five goals in his last three appearances. Brahim Díaz provides a spark off the bench. And Rodyrgo ended a six-week scoring drought in Madrid's last game, a 2-0 win over Athletic Bilbao, to keep it on course for winning the domestic league title.

Madrid is on a 27-game unbeaten run at its Santiago Bernabeu Stadium across all competitions dating back to last April. City has found its scoring form over



the past week after hitting four goals in each of its games against Aston Villa and Crystal Palace to stay on the heels of title rivals Liverpool and Arsenal. **ENRIQUE REUNION** 

After a difficult start to his coaching

with Mbappe's bitter contract saga, Luis Enrique has steadily won over fans and the French media - even if it meant dropping Mbappe or taking him off in games. Enrique won the treble as Barcelona coach in 2015 with Lionel Messi in his

team and is still in contention to do the

same at PSG with Mbappe.

Losing has become a distant memory for PSG, which is undefeated in 27 matches since a loss away to AC Milan in November during the Champions League group stage. But playing a rested Barcelona side could be the toughest test of the season

Xavi Hernández attempted to shock his team into getting its act together by saying he would quit at the end of the season, something that has coincided with a certain improvement.

Barcelona has gone unbeaten in 11 straight games since Xavi said in late January that he was renouncing the final year of his contract.

Robert Lewandowski, teenager Lamine Yamal and Raphinha are all playing well of late, but the midfield is a big question mark due to injury concerns. TUCHEL TROUBLE

Bayern Coach Thomas Tuchel wants to end a "frustrating" season, and his tenure, on a high with a trip to Wembley for the Champions League final. But its preparation for Arsenal could hardly have been worse after its latest defeat, this time to Heidenheim on Saturday after leading 2-0.

"There's still the goal of going to

Wembley," Tuchel said Friday. "Everything is being put toward this target. It can't happen that we ease off even 1% in our conviction or in our ambition."

The mood at Arsenal is very different with Mikel Arteta's team looking better equipped to last the course in the race for the title this year after a late collapse last season.

The Champions League run feels like an unexpected bonus, but victory against Bayern will strengthen belief that a trophy double could be on.

#### **ATLETICO SLUMP**

Atletico has slumped in recent weeks, with six losses and only four wins in its last 12 games overall, as it missed the goals and creativity of Antoine Griezmann. The France forward is now back playing and will be looking for his first goal since Jan. 18.

Diego Simeone's side was enjoying a 25-game unbeaten run at its Metropolitano Stadium until Barcelona delivered a 3-0 rout at Atletico on March 27.

Dortmund has generally saved its best for the Champions League this season. It isn't a Bundesliga contender this year, but wins over Newcastle. AC Milan and most recently PSV Eindhoven have shown it means business in Europe. (AP)
