Campaign ends for five Lok Sabha seats going to polls in 1st phase



GUWAHATI, April 17: Campaigning for the first phase of polls to five Lok Sabha constituencies in Assam scheduled on April 19 ended on Wednesday.

The battle of the ballots in this phase will decide the fate of 35 candidates including two Rajya Sabha MPs, three Lok Sabha MPs and an MLA. The five constituencies going to the polls in this phase are Dibrugarh, Jorhat, Kaziranga, Sonitpur and Lakhimpur.

The prominent candidates in the fray are Union minister Sarbananda Sonowal, who is contesting from Dibrugarh, and Lok Sabha's deputy leader of the opposition Gaurav Gogoi, who has been fielded by the Congress from Jorhat. Prime Minister Narendra Modi held a roadshow in Guwahati on Tuesday and addressed an election rally at Nalbari under Barpeta constituency on Wednesday, both going to polls in the third phase, but party sources claimed that it will have an impact on the first phase elections as well.

candidates in the fray for the five Lok Sabha constituencies in Assam going to the polls on April 19, fifteen are 'crorepati' with the richest being independent woman candidate Diluwara Begum Chowdhury from the Kaziranga seat.

The five Lok Sabha constituencies going to the polls on April 19 are Jorhat, Kaziranga, Dibrugarh, Sonitpur and Lakhimpur.

Five BJP candidates, three of Congress, two of Aam Aadmi Party (AAP), one each of the All India Trinamool Congress (AITC) and Bharatiya Gana Parishad (BGP) and three independents have assets over ₹ one crore, according to the affidavits filed by candidates.

The average assets of AAP candidates are the highest at ₹ six crore, followed by the BJP candidates at over ₹ four crore, the Congress at ₹ three crore, the AITC and the BGP

'Will repeal NRC, CAA if INDIA bloc voted to power'

SILCHAR, April 17: Alleging that the BJP has made the entire country a "detention camp", West Bengal chief minister Mamata Banerjee on Wednesday said the CAA and NRC will be scrapped if the opposition INDIA bloc forms government at the Centre.

Addressing an election rally here in support of four TMC candidates in Assam, she alleged that there will be no democracy and elections if Prime Minister Narendra Modi returns to power for the third consecutive term

"They (BJP) made the entire country a detention camp. This election is very dangerous. I have never seen such a dangerous elec-

tion in my life," Banerjee said. She claimed that her Assam counterpart Himanta Biswa Sarma filed a number of police cases while she was agitating in West Bengal supporting Bengali people

"What was my fault? Will you jail me, kill me or put me in a dention camp? When 17 lakh Bengali Assamese were excluded out of 19 lakh excluded from NRC, I was there to agitate for the people,' Banerjee said. She asserted that her party TMC loves all religions and does not want people to be divided on religious lines.

"If the INDIA bloc wins, there will not be the National Register of Citizens (NRC), Citizenship Amendment Act (CAA) and Uniform Civil Code. We will repeal all discriminatory laws.

"If Modi wins again, there won't be democracy and there won't be any election. The entire country will be sold off," Banerjee said at the rally. She appealed to people to vote for all four Trinamool Congress candidates in Assam in the Lok Sabha polls and announced that her party would contest all 126 assembly seats in 2026. "This is just a trailer and the final is yet to come. I will come again to play the final," Banerjee added.

India's population was recorded at 121 crore during the last census

India's population estimated at 144 crore, 24 pc in 0-14 age bracket: UNFPA report

NEW DELHI, April 17: India's reached 144 crore, with 24 per cent in the 0-14 age bracket, according to a recent report by the UNFPA.

The United Nations Population Fund's (UNFPA) State of World Population - 2024 report -- "Interwoven Lives, Threads of Hope: Ending Inequalities in Sexual and Reproductive Health and Rights" -revealed that India's population is

estimated to double in 77 years. India leads globally with an estimated population of 144.17 crore, followed by China at 142.5 crore, according to the report.

India's population was recorded at 121 crore during the last census, conducted in 2011.

The report further detailed that an estimated 24 per cent of India's population is aged 0-14 while 17 per



cent is within the 10-19 age range. The segment aged 10-24 is estimated to constitute 26 per cent, with the 15-64 age group making up 68 per cent. Additionally, 7 per cent of Îndia's population is aged 65 years

and above, with men having a life expectancy of 71 years and women 74 years. The report has found that 30 years of progress in sexual and reproductive health has mostly ignored the most marginalised com-

According to the report, the child marriage percentage in India was at 23 between 2006-2023.

The report noted that maternal deaths in India have fallen considerably, accounting for 8 per cent of all such fatalities worldwide. "India's success is often attributed to improved access to affordable, quality maternal health services as well as efforts to address the impact of gender discrimination on health outcomes," the report said.

However, the report noted that India continues to see dramatic inequities in maternal death risk.

Quoting a report on "Estimates and Correlates of District-Level Maternal Mortality Ratio in India" by PLOS Global Public Health, the UNFPA said recent research into India's (CONTD. ON PAGE-2)

Modi govt failed people of Northeast on every front: Cong NEW DELHI, April 17: The Con-

gress on Wednesday alleged that incidents like Manipur violence and "Chinese incursions" prove that the Modi government has "failed" the people of the Northeast.

Congress general secretary Jairam Ramesh also claimed that there has been a "chronic underutilisation of Northeast funds" and the region's forests are under threat.

"The Modi Sarkar has failed the people of the Northeast on every front," he alleged in a post on X.

"Violence in Manipur, chronic underutilisation of Northeast funds, forests under threat, Chinese incursions in Arunachal Pradesh and languishing Naga peace talks," he said. Ramesh said that just four days

after the PM claimed that "timely intervention by Centre saved Manipur," fresh violence in Imphal district claimed two more lives. "Although it has been dropped from the news cycle, the 'civil war'-

like situation in Manipur continues

to persist. It has been more than 10 months since the conflict erupted, and contrary to what the PM would have us believe, lasting peace is still nowhere in sight," he said.

He pointed out that more than 200 people have been killed, more than 60,000 displaced, in Manipur and thousands of weapons have been stolen from the state police.

"BSF soldiers have been shot at, policemen have been killed, and mobs have stormed into and burned down Government offices. On March 11, Khwata Khunou, the last Meitei village in Manipur to have

withstood the violence was burned to the ground," he said.

In late March, several Kuki youths and women decided to boycott elections to the Outer Manipur Lok Sabha constituency to protest the system's failure in ensuring their "protection, dignity, and rights," the Congress leader said

Ramesh alleged that chief minister Biren Singh ignored repeated calls to step down and was now violating the model code of conduct by giving speeches at purportedly non-political" meetings to address the prevailing situation.

Since May 3 last year, when large-scale violence broke out in Manipur, the Prime Minister has not visited the state even once, he said.

"He (Modi) has not even given an appointment to, or taken a call from, the Chief Ministers, MLAs, or any other political representatives of the state. "In fact, he has barely even acknowledged (CONTD. ON PAGE-2)

Indian economy projected to grow 6.5 per cent in 2024: UNCTAD

UNITED NATIONS, April 17: India's economy is projected to grow by 6.5 per cent in 2024, according to a report by the UN which noted that multinationals extending their manufacturing processes into the country to diversify their supply chains will have a positive impact on Indian exports.

UN Trade and Development (UNCTAD) in its report released on Tuesday said that India grew by 6.7 per cent in 2023 and is expected to expand by 6.5 per cent in 2024, continuing to be the fastestgrowing major economy in the

"The expansion in 2023 was driven by strong public investment outlays as well as the vitality of the services sector which benefited from robust local demand for consumer services and firm external demand for the country's business services exports," the report said, adding that these factors are expected to continue to support growth in India in 2024.

The report also noted the increasing focus by multinationals on India as a manufacturing base as they diversify their supply chains, a reference to China.

"In the outlook, an increasing trend of multinationals extending their manufacturing processes into India to diversify their supply chains will also have a positive impact on Indian exports, while moderating commodity prices will be beneficial to the country's import

"This positive dynamic is now being squandered. Policy discussions continue to centre on inflation, conveying confidence that anticipated monetary easing will heal the world's economic woes. Meanwhile, the pressing challenges of trade disruptions, climate change, low growth, under-investment and inequalities are growing more serious," it said.

The report said that China's economy, projected to grow 4.9 per cent in 2024, has been facing some headwinds such as external uncertainties, a troublesome housing market, an under-performing labour market and subdued con-

The UNCTAD report comes even as the International Monetary Fund said in its latest edition of the World Economic Outlook released on Tuesday that growth in India is projected to remain strong at 6.8 per cent in 2024 and 6.5 per cent in 2025, with the robustness reflecting continuing strength in domestic demand and a rising working-age population. Punjab chief minister Bhagwant Mann and Delhi minister Atishi campaigned and held roadshows in both seats. Chief minister Himanta Biswa Sarma led the BJP campaign in these five constituencies highlighting the party's achievements during its las ten years of rule at the Centre. The opposition alliance also depended on state leaders and civil society for campaign with the candidates going all out to woo the electorate.

The issues highlighted by the ruling party during the campaign were mostly confined to claims of all-round development, particularly in the North East, peace in the region, employment opportunities, facilities for women, students, tea garden workers, among others. In Jorhat, Lok Sabha's deputy leader of the opposition Gaurav Gogoi is locked in a direct contest with sitting BJP MP Topon Gogoi with a keen fight likely on the cards. Gogoi had to shift his constituency to Jorhat from the earlier Kaliabor, which has been renamed as Kaziranga following delimitation last year.

In Kaziranga, BJP's Rajya Sabha MP Kamakhya Prasad Tasa is locked in a direct contest with former Congress MLA Roselina Tirkey, with both candidates being from tea workers' community. Kaziranga has the highest number of eleven candidates in the fray. In Sonitpur, there are eight contestants with a triangular contest likely between BJP MLA Ranjit Dutta, Congress candidate Prem Lal Ganju and AAP's Rishiraj Kaundinya.

In Lakhimpur with nine contestants, sitting BJP MP Pradan Baruah is locked in a direct contest with Uday Shankar Hazarika of Congress. In the first phase, a total of 86,68,239 electorate including 43,93,512 women voters will exercise their franchise in 10,001 polling booths. (PTI)

The election rally was attended by MP Horensing Bey, BJP candidate Amarsing Tisso, deputy speaker of the Assam Legislative Assembly Dr Numal Momin, executive member (EM) of KAAC Richard Tokbi, BJP-EKADC president Roland Killing, and several other party leaders.

Earlier, the CEM attended an election rally at Borpathar under the Deopani MAC constituency. Meanwhile, the vice president of the Karbi Anglong District Congress Committee (KADCC), Roton Engti, attacked the BJP over electoral bonds, terming it the biggest scam in India. The attack on the BJP intensified as campaigning reached its peak for the second phase of the Lok Sabha elections for the 6 Diphu (ST) Parliamentary Constituency in Assam, with voting scheduled for April 26. The Congress has fielded former MLA Joyram Engleng as their candidate

During a press conference held on Tuesday at the KADCC office, the vice president stated, "The BJP government introduced electoral bonds with the intention of corrupting public funds. Through electoral bonds, the BJP has amassed a significant amount of money. It's one of the biggest scams in the country.

Engti criticised Modi for freezing all Congress bank accounts, causing inconvenience to the party during the electioneering process. Taking aim at Ronghang, the KADCC vice president criticised the economic situation in the CEM Ronghang-led KAAC, highlighting delays in contractor payments and the disappearance of contractors due to lack of contract works. Engti also pointed out economic imbalances among the common people, citing the presence of sand, egg, and coal syndicates in Karbi Anglong. Engti also accused the All Party Hills Leaders Conference (APHLC) and ASDC of acting as BJP agents to divide voters along communal lines. Urging voters, Engti emphasised the importance of rejecting the BJP to safeguard democracy in India.

They (BJP) will try to scare us, lure us with money," Banerjee said.

She also listed out several beneficiary schemes being implemented in West Bengal and said that similar programmes will be rolled out in Assam as well if TMC comes to power. Ridiculing BJP's target of winning 400 Lok Sabha seats, Banerjee said: "First you try 200 seats... I believe they will be defeated pathetically." (PTI)

"In the meantime, Rahul Gandhi has visited the state twice to understand the situation and extend solidarity to the people of Manipur," Ramesh said. He also alleged that the Modi government has all along its 10-year rule allocated big budgets to the Northeast and then chronically underutilised them.

"Since 2014, the Modi government has utilised the full budget of DoNER only twice. While the UPA consistently utilised ~90% of the budget, the Modi Government's utilisation regularly falls to just 60%," he said. In FY23, the DoNER budget was ₹2,755 crore, however, in June 2023, a Controller General of Accounts report

revealed that the Ministry had utilised only ₹989 crore, just 35.9 per cent of the allocated budget, Ramesh said. The Congress leader said that soon after the clearing of the contentious Forest (Conservation) Amendment Act (FCA) by the Parliament in August 2023 without substantive debate, both Nagaland and Mizoram assemblies passed resolutions against the implementation of the Act.

"It was met with sharp criticism because it drastically weakens safeguards against the over-exploitation of forest resources, and strips tribal communities of their Constitutional rights," he argued. In 1996, the Supreme Court clarified that the definition of "forest land" under the FCA extends beyond areas that have been officially recorded as forest by the government, Ramesh said.

"This was considered a historic victory for environmentalists. The amended FCA aims to nullify this historic ruling, stating that its provisions will only apply to forests that have been declared or notified as a forest, and forests recorded in government records on or after October 25, 1980," he said. Upholding Electoral Integrity

n the wake of recent deliberations by the Supreme Court regarding the integrity of India's electoral process, the nation finds itself at a critical juncture where the reliability of Electronic Voting Machines (EVMs) is being scrutinized against the backdrop of historical challenges associated with traditional ballot papers. The Supreme Court, in its observations, acknowledged the potential for human manipulation of EVMs while expressing reservations about reverting to the use of ballot papers, citing the vast scale and complexity of India's electoral landscape. Indeed, memories of past electoral malpractices, including booth-capturing and ballot-stuffing, serve as stark reminders of the vulnerabilities inherent in paperbased voting systems. Despite concerns raised regarding the trustworthiness of EVMs, the court underscored the indispensable role these machines play in ensuring the fairness and efficiency of elections, particularly in a nation as populous and diverse as India. While acknowledging the imperfections of EVMs, the court emphasized the need to repose trust and faith in the electoral process, cautioning against efforts to undermine the system based on unsubstantiated claims. However, trust in the Election Commission remains less than absolute. The question arises- should we await new, more trustworthy technology, perhaps even imbuing EVMs with Artificial Intelligence to enhance their reliability? This discourse highlights the delicate balance between innovation and the imperative of safeguarding electoral integrity.

The issue of Voter Verified Paper Audit Trail (VVPAT) slips, raised by petitioners seeking greater transparency in the electoral process, also received attention. While the court appeared reluctant to mandate 100 percent counting of VVPAT slips, it underscored the Election Commission's responsibility to conduct free and fair elections, with the Model Code of Conduct serving as a powerful tool to safeguard electoral integrity. The Commission's ability to deliver secure, violence-free elections is its own guarantee, distinct from any claims of credit by the Modi government, which may inevitably seek to bask in any success. Critics of the current electoral system point to concerns over the transparency of EVMs, citing the lack of visibility into the source code of the chips as a source of suspicion. However, the Election Commission maintains that, absent unauthorized human intervention, EVMs are capable of yielding accurate results. In considering the merits of various arguments, it is essential to recognize the unique challenges and complexities of India's electoral process. Comparisons to European countries, such as Germany, while informative, must be tempered with an understanding of India's distinct demographic and logistical realities. As the nation prepares for the upcoming general elections, it is imperative that stakeholders across the political spectrum demonstrate a commitment to upholding the integrity of the electoral process. This entails not only ensuring the reliability of voting technology but also fostering trust and confidence

Moving forward, efforts to enhance the transparency and accountability of the electoral process must be pursued in a manner that balances the need for innovation with the imperative of safeguarding against electoral malpractice. While technological advancements, such as Artificial Intelligence, hold promise for improving voting systems, they must be implemented judiciously and with due consideration for the unique challenges facing India's electoral democracy. Can BJP win all the 25 seats of North-East?

The north-eastern region of India, where the sun's rays first reach, is ready to deliver its verdict in the upcoming Lok Sabha elections. The Bharatiya Janata Party (BJP) is aiming to win 370 seats in these elections, including all 25 seats from the Northeast. Looking back at the 2019 Lok Sabha elections, the BJP had secured significant victories in the Northeast, and the party is confident of maintaining its hold this time as

This confidence stems from Prime Minister Narendra Modi's belief that the people of the Northeast will not forget the development initiatives his government has undertaken in the region. Additionally, Home Minister Amit Shah, like PM Modi, has played a crucial role in establishing lasting peace in the Northeast through various peace accords. Due to robust internal security measures, there have been no major violent incidents reported across the region, with the exception of Manipur, where the Home Ministry is actively working towards a concrete solu-

India's Northeast comprises the eight border states of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, and Tripura. The region accounts for 25 seats in the 543 seat-Lok Sabha, the lower house of the Indian Parliament. States in the region will vote on April 19 and 26 and May

Assam holds the highest number with 14 seats. In the 2019 Lok Sabha elections, the NDA secured 21 out of the 25 seats.

The BJP aims to surpass this figure in the upcoming elections.

Assam Chief Minister Hi-

manta Biswa Sarma of the BJP, who is convener of the North East Democratic Alliance, a BJPled bloc in the Northeast, claims that the NDA would win 22 seats across the region in the upcoming general elections.

Discussions with political functionaries from different parties revealed that the BJP and its allies have an edge in 20 constituencies. The contest in the remaining five is expected to be

In Assam, which has the highest number of seats (14) among all the northeastern states, the ruling BJP has fielded candidates in 11 constituencies and its allies the Asom Gana Parishad (AGP) and the United People's Party Liberal (UPPL) - will contest from the remaining three. In 2019, the BJP won 9 seats from Assam. The UPPL and AGP failed to secure victories from

their allocated constituencies.

So far, the INDIA alliance has not shown any significant interest or investment in the northstates. Mamata Banerjee's TMC and Sharad Pawar's NCP had made independent attempts to gain a foothold in the region during the previous elections, but this time, their efforts seem to be absent. This is primarily because Sharad Pawar is currently engaged in a battle with his nephew to maintain control over his party and political existence. Similarly, Mamata Banerjee is facing challenges at home due to allegations of corruption and communal dis-

The trust placed in the BJP by the people of the Northeast stems from the active focus on development and peace initiatives under-

taken by PM Modi and Home Minister Amit Shah over the past decade.

Although Manipur has only 2 Lok Sabha seats, resolving the ongoing tribal conflict there is crucial for the government. Home Minister Amit Shah has been making continuous efforts in this regard. In his recent meeting in Shillong,

Amit Shah said that the last 10 years under the leadership of Prime Minister Narendra Modi have been the most significant for the development of the Northeast in the 75 years since independence. These 10 years under the leadership of Modi, not only the distance from Northeast to Delhi and the rest of India has reduced due to the creation of infrastructure, but the difference of hearts has also reduced.

The Northeast, which was struggling with various ethnic, linguistic, border and extremist groups' related problems, has also got the beginning of a fresh and durable era of peace in these It goes without saying that if

India's hurried EV expansion plan is unsustainable and lacks logic

t a time when the countries such as the United States, Japan and South Korea are going slow on electric vehicles (EVs) for various reasons, it is difficult to understand why India is going gaga over its utility, substantially raising the EV production and sales targets in the next five years. India does not even produce the key strategic mineral, lithium, required to manufacture batteries for EVs. Although the country has almost a dozen lithium battery manufacturers for EVs, the country is nearly 80 percent dependent on China, India's No.1 foe across all its borders, for the supply of lithium and lithium-ion. Such a heavy reliance on China for a strategic raw material such as lithium to make EV batteries could put India's new age vehicles manufacturing plan at risk if the current tensions between the two countries persists or even es-

India must tie-up with other lithium producing countries for the import of the mineral before embarking on a major expansion plan for EVs. Other than China, Australia and Chile are two key producers of lithium. In fact, Australia is the world's largest producer of lithium. Chile comes next. A bulk of Australia's lithium export goes to China, itself sitting over the world's third largest lithium de-

posits. Australia would rather have a diversified market its lithium exports, including India. than sending the mineral

mostly to China and the US. Argentina and Brazil are the two other major producers of lithium although their combined output would be only around 14 percent of Australia's mined lithium. Other critical raw materials used in Li-ion batteries include graphite, cobalt and manganese.

According to India's Heavy Industries Ministry secretary Karman Rizvi, the country aims to become a global leader in EV sales by 2030 with the new-age non-emission vehicles accounting for 30 percent of all automotive sales. However, Rizvi does not provide much information about the government's plan to meet the growing demand for lithium to manufacture EV batteries in India on a sustainable basis. Going by the country's automobile sales record per 1,000 of its population, India is way behind the countries such as the US, Japan, New Zealand, Australia, Poland, Italy, the UK, France, Germany, Canada, China, and Poland. In

2020, the number of registered vehicles in use per 1,000 inhabitants was 869 in New Zealand.

At 24 per 1,000 people, India's car penetration ratio compares poorly with the world average of 314 in 2022, according to the World Road Statistics by the International Road Federation and Crisil Market Intelligence & An-

Last year, the number of registered vehicles sold in India was 41,00,258, recording an impressive 8.3 percent growth over 2022, when the industry was reeling under the shortage of semiconductors. It is true that the demand for vehicles powered by traditional fuels is shifting towards alternative fuels. The sales of petrol-run vehicles dropped from 86 percent in 2020 to 76 percent in 2023.

While much less pollutant EVs are most welcome in India, the country must prepare itself to commercially as well as strategically sustain such a change. To make the EV expansion policy sustainable, the country must widen its lithium import network to drastically cut the import of the key component of EV battery production from China until it is able to exploit its own new-found lithium deposits. India's hostile neighbour is not only exporting lithium but also a large range of electric vehicles to India.

Presently, China is home to over 50 percent of the world's

EVs. close proximity to raw materials used in manufacturing EV batteries has helped the country's large presglobal EV market. The

EV industry is being heavily pushed by the Chinese government offering various incentives to tackle operational hurdles, leading to innovation of core technologies. Last year, EVs made up 31 percent of all car sales in China. Now, China has targeted India for expansion of its

global EV market. Lately, BYD Co., China's top automobile maker, launched its third electric car in India. It introduced a premium electric sedan, Seal, with price starting at Rs.41 lakh. In 2023, Guangdong-based BYD sold 1,877 cars in India, a 314 percent jump over the previ-

ous year. The future of the global EV market is still not very clear. The automobile industry in many parts of the world is studying the sustainability of the product if and when the market booms up. Its repair and maintenance cost could be quite high. Lately, the US media has been critical about the Biden administration's campaign to replace internal combustion vehicles (ICVs) with EVs to reduce carbon emission. It is said that EVs will have a "miniscule" climate impact.

According to the American Enterprise Institute's Benjamin Zycher, the US Environmental Protection Agency's own assumptions project that the new regulations such as favouring a switchover to EVs from ICVs will mitigate global warming by 0.023 degrees Celsius by 2100.

The standard deviation of the Earth's surface temperature record is 0.11 degrees Celsius, "that effect would not be detectable." Another interesting observation is that each half-ton battery for "clean" vehicles will require digging and processing 50 to 250 tons of earth for copper, nickel, aluminium, graphite and lithium, the prices of which will increase (consequently raising the vehicle prices) when the easy accessed supplies decrease. The International Energy Agency (IEA) points out that hundreds of huge new mines will be required, each taking a decade or more to open.

India must consider all these aspects before jumping into the EV bandwagon. It would be wrong to ignore the market size of the global automotive industry which was valued a t US\$3,565 trillion in 2023. The market size is expected to grow at a CAGR of 6.77 percent between 2023 and 2033, when it is projected to reach \$6.861 trillion.

A global thrust for EVs will substantially raise the demand and prices of critical minerals such as lithium, nickel, copper and graphite as raw materials to produce batteries with lasting power. India must develop its lithium supply chain through various means, including leveraging private and public industries to sustain its future sectoral growth and to fix strategic vulnerabilities.

Last year, India's Ministry of Mines released a list of 'critical minerals' which 'are essential for economic development and national security' and whose 'lack of availability' or 'concentration of extraction or processing in a few locations may lead to the disruption of supply chains. Lithium is categorised as a 'strategic' mineral, placing it at the top priority

Fortunately, recent discoveries of lithium reserves in Jammu & Kashmir, Jharkhand and Rajasthan have attracted the attention of both the government and private players on mining the mineral. The next government should make a comprehensive assessment of the situation and formulate an EV manufacturing policy in consultation of the industry. Until then, EV imports should attract punitive taxes and non-tariff restrictions. The concerns of the domestic automobile manufacturers need the full government attention. (IPA Service)

How Guwahati became the second-most polluted city in the world

t has been about seven years since Milin Dutta, a 54-year-old Trans man, moved back to his hometown Guwahati from the United States. Earlier, when he used to come home for vacations, he would always get a cold and a dust allergy, he recalled. It took a few years for Dutta to realise he had asthma and it got worse in Guwahati. "I used to get asthma attacks and had to take medication for it," he said.

While Dutta's health is better than before, he said that earlier he would go out for walks around his neighbourhood, but nowadays he no longer feels like it. "The entire city is full of dust and garbage. You don't enjoy walking here anymore," Dutta, who is the founder of Guwahati-based not-for-profit Anaajoree, said.

Dutta's worries are corroborated by the latest 2023 World Air Quality Report by IQAir-a Swiss air quality monitoring group – which has ranked Guwahati as the second-most polluted city in the world.

According to the report, Guwahati recorded an average annual PM 2.5 concentration of 105.4 microgram per cubic metre of air ($\mu g/m^3$), more than 20 times the World Health Organization's (WHO) recommended level of 5 µg/m³. India's own standard is higher at 40 μg/m³. PM 2.5-fine particulate matter 30 times finer than human hair - can enter the bloodstream leading to severe health issues.

IndiaSpend previously reported that if India were to meet the WHO air quality standards, it could potentially extend the average lifespan of its citizens by four years.

The report by IQAir placed Begusarai in Bihar as the first- and Delhi as the third-most polluted cities in the world. Besides, it ranked India as the third most polluted country in the world after Bangladesh and Pakistan. IndiaSpend spoke to environmentalists and experts who noted that irrespective of the Swiss air quality report, Guwahati's pollution levels are on a higher side.

Swiss air quality report

Anumita Roychowdhury, executive director, research and advocacy at the Centre for Science and Environment in New Delhi, said that the Swiss air quality data for Guwahati are a bit on the higher side than the data she was able to access from the Central Pollution Control Board.

Roychowdhury added that if the Swiss air quality report has combined Byrnihat - an industrial town in Meghalaya state on the border with Assam – it is quite possible to have a high average annual PM 2.5 concentration of 105.4 for Guwahati. We reached out to IQAir for clarity on this, and we will update the story when we receive a response.

In fact, Byrnihat was declared as the most polluted city in India during February in a dataset released by the Centre for Research on Energy and Clean Air (CREA). "We don't know what method the Swiss air quality monitoring group has used. I have no way of verifying whether they have combined Byrnihat or are they attributing this number only to Guwahati city," Roychowdhury explained.

But she noted that whether the Swiss air quality report is accurate or not, is not the key point. "Key point is that in Guwahati, the overall pollution levels are on the rise. Guwahati has certain geographical disadvantages: It is more like a valley surrounded by hills and in that kind of geography, there is often the tendency for the pollution concentration to be higher because the trapping bit happens, especially during winters," she said.

Rahul Mahanta, associate professor at Cotton University's department of physics in Guwahati, reiterated Roychowdhury's point. He said that PM 2.5 is "basically because of black carbon, and Guwahati has had a high PM 2.5 for a while now. During the winter months, condi-

The moisture stays, a lid forms due to cold air that flows from the hills, and particles remain suspended in the air," Mahanta said.

IndiaSpend contacted Arup Kumar Misra, chairman of the Pollution Control Board of Assam. He said, "The air quality in Assam and more specifically, Guwahati, generally drops during the winter and pre-monsoon period due to lack of rainfall."

He added that Guwahati, being the largest city in the entire northeastern region, is also the main economic hub and has been going through a lot of infrastructural development. IndiaSpend also reached out to the Guwahati Municipal Corporation for comment. We will update the story if we receive a response.

According to Roychowdhury, the main sources of air pollution are vehicles, open burning of waste, and construction activities. Apart from these, she said, in dumping grounds where methane emission happens from the rotting waste, if that catches a spontaneous fire, it tends to emit continuous toxic gases. She added that small and medium scale industrial units could also be a contributor.

Currently, the Guwahati Municipal Corporation dumps the city's daily waste at Belortol in Paschim Boragaon village of Guwahati. The site is in close proximity to Deepor Beel – a freshwater wetland -listed as Assam's only

According to Shirshendu Sekhar Das, founder of Guwahati-based environmental conservation organisation The Midway Journey, "the dump site has been on fire for the last one month now. Due to high temperatures of the food and plastic waste, the harmful gases get ignited on their own. There is no fire extinguisher, it looks like it has been normalised.'

Parmod Kalita, a local conservationist, warned that the impact of the dumpsite near a Ramsar site is dangerous. "The plants in a wetland absorb almost 50% carbon dioxide, even more effectively than forests, so wetlands play a huge role in keeping the air quality intact of not just the nearby areas but perhaps the entire city. Deepor beel has been providing free ecosystem services and we don't understand its importance.'

Smoke and pollutants from the dumping ground have been posing a threat to the ecology of the wetland, which is also home to migratory birds, and several other flora and fauna. Arshel Akhter, an advocate for sustainable urban transportation, road safety and climate action, and also the co-founder of Pedal for Change in Guwahati, believes that a surplus of vehicles is a major contributor to air pollution in the city.

"While there are other private constructions going on, we are witnessing more flyover-related construction work. We are making flyovers to accommodate more cars. It creates a phenomenon called 'induced demand' where people go on to buy more cars. Flyovers do not solve congestion. Road dust is mainly due to vehicles," Akhter said.

According to the 1971 census, the population of Guwahati metropolitan area was just under 300,000 and in 2011, when India conducted its last census, it was estimated to be about 1 million. Anwaruddin Choudhury, a Guwahatibased environmentalist, said: "With the increase in population, the number of vehicles has also increased, which is causing pollution," he said, adding that other reasons are dust from the construction sites and garbage burning, including

Over the years, several trees have also been cut down in the city. In 2023, the National Green Tribunal had taken suo motu cognisance of the allegations regarding the cutting of around 2,000 trees for a road expansion project between Guwahati and Goalpara in Assam. "Deforestation also has an impact on pollution - a lot of trees are being cut here and there for road widening projects. But some old trees could have been saved," Choudhury said.

Health impact According to Hyderabad-based Vishnun Rao Veerapaneni, consultant at the SWASA hospital on lung diseases for both children and adults, air pollution is a big threat to the entire human population particularly in big cities.

"It affects all age groups. Outdoor pollution is mainly due to dust particles," he said, adding that this PM 2.5 concentration which is rising in the Indian cities is especially dangerous because "it's a big threat to all the organs, not only lungs but also heart, brain, and every cell of the

This pollution is indirectly promoting the viral infections to contract. People who are exposed to pollution are easily getting targeted because lung linings are already damaged; therefore, viruses can enter easily into the lungs. Pollution and viral diseases go hand in hand,' Veerapaneni, who is also part of Doctors for

He added that PM 2.5 is "a kind of soot" "The soot penetrates into the interiors of the lungs and reaches every cell of the body. It also indirectly causes strokes and heart attacks. It precipitates kidney problems.

Focusing on solutions

The Indian government's National Clean Air Programme has identified 131 cities across the country as non-attainment cities, which means these cities have a higher pollution level and they are unable to meet the clean air standards. Guwahati is already among the 131 non-attainment cities and has been mandated to prepare and implement a clean air action plan.

The non-attainment cities are also mandated to prepare their emission inventory and conduct a source apportionment study to find out the key sources of pollution in the city and how much each of these sources are contributing to the overall pollution concentration.

However, a more accurate source for the pollution in Guwahati will be found out when the source apportionment study is completed. Currently, the study is being carried out by the Pollution Control Board of Assam along with the Indian Institute of Technology Guwahati, Misra

Misra, the chairman of the Pollution Control Board of Assam, also said that the implementation of the city action plan under the National Clean Air Programme is ongoing. The major stake-holding departments include the transport, public works (road), Guwahati municipal corporation, PCBA, industries, forest, traffic.

"The city action plan is based on specified six sources, which are construction and demolition activities, vehicular emission, road dust, industrial pollution, waste dumping, and burning and use of domestic fuel," Misra said.

Roychowdhury of the Centre for Science and Environment pointed out that in order to control vehicular pollution, public transport and electric vehicles need to be scaled up, and the emissions

from the vehicles need to be monitored. For waste management, she said, the municipality needs to ensure that the waste is collected from each and every household, and should be segregated as dry and wet waste. "The wet waste should be composted and not burnt, and the dry waste should be recycled; that's how you can minimise the need to take the waste and dump it in the dumping ground," Roychowdhury explained. Das of Midway Journey said that "the municipality has taken some initiatives, as we are improving our waste collection services, but we must also ensure that the waste is collected in a segregated manner,

which we have failed to do. Roychowdhury said that construction and demolition wastes need to be recycled. "The pollution control board has to ensure that [for] all these flyovers and road construction that is happening, they are adopting adequate dust control measures," she added. According to Akhter, "We need more monitoring stations, better transportation planning, more trees and a robust

waste management system." It is necessary, Roychowdhury pointed out, that the state pollution control board and the government ensure that the clean city action plan gets implemented with "absolute stringency". (Courtesy: Scroll.in)

Hokkaido, Japan's 'Garden of the Gods', is warming

apporo, the main city of Japan's second-largest island of Hokkaido, recorded 26 degrees Celsius on April 15, 2024, an oflargest island of Hokkaido, recorded 26 degrees Celsius on April 15, 2024, an official of the Japanese Meteorological Agency

Record-keeping of temperatures began in 1877. April 15, 2024 is the earliest time in the year that Sapporo, a city famous for its snow and ice sights, has recorded this temperature which the JMA classifies as a 'summer day', AFP added. It is a far cry from 2008, when Hokkaido played host to the G8 summit. An analysis brought about by the World-Wide Fund for Nature-Japan had then noted that the mean temperature in August, Hokkaido's hottest month, was 21°C:

Hokkaido's climate is sub-arctic, with an annual average temperature of 8°C and an average annual precipitation of 1,150 mm. At Asahikawa, in central Hokkaido, the mean temperature in January, the coldest month, is -9°C. The mean temperature in August, its hottest month, is 21°C, but because of climate change, these statistics will likely change soon.

The April 15 temperature has now vindicated WWF-Japan's warning. It also means that Hokkaido, long considered Japan's last wild frontier, will no longer be the 'Garden of the Gods' as it was known to be, by the Ainu, Japan's indigenous people.

The Japanese archipelago, which stretches from the Ryukyuan islands (including Okinawa) near Taiwan to Hokkaido near Russianadministered Sakhalin, is warming up.

A study last year noted that "In Japan, the temperature increased by 1.28°C/100 years from 1898 to 2021 (JMA 2021), and the three recent years, 2019-2021, are the warmest since 1898. În urban areas, a much larger temperature rise has been observed because of the urban heat island." Perhaps the biggest impact is being seen in Hokkaido, which borders the Sea of Okhotsk near the Russian Far East.

The Japan Times, in an article last year, noted that "In a high global emissions scenario, a 5 degrees Celsius average temperature rise by the end of this century would mean more intense squalls and less snowfall, while warmer seas around the island (Hokkaido) would disrupt the migratory patterns of fish."

The Asahi Shimbun reported a study by Hokkaido University researchers this March that sea ice "in the Sea of Okhotsk is not only dwindling in terms of coverage area, but has also lost 30 percent of its thickness across a span of 30 years".

"If things continue on the same course, the researchers predict there will be times in the future when no ice floes will reach Hokkaido's coast," the newspaper added.

hotspot for tourism including winter resorts and winter sport areas — warms, it will also have an impact on the Ainu, who already have been a marginalised people in Japan since coming into contact with ethnic Japanese (Yamato people) 400 years ago.

"The Ainu are the indigenous people of Hokkaido and are believed to have outnumbered the Japanese until about 1800," WWF-Japan noted in 2008. The Ainu were largely a hunter-gatherer people. After the Japanese subdued them militarily and incorporated Hokkaido into Japan, the Ainu were and still are subject to racism from mainstream Japanese society.

The Ainu were recognised as an indigenous people of Japan in 2019. The Japan Times highlighted a 2020 landmark lawsuit brought about "by the Raporo Ainu Nation to claim their traditional Indigenous rights to catch the prized fish comes as estimated salmon stocks hover at around half of what they were just two decades ago, with rapidly warming waters in the Sea of Okhotsk and northern Pacific potentially upending migration patterns".

And while Japan faces its own problems with a rapidly shrinking population, the Sapporo temperature shows that climate change's grip on the archipelago, including its last wilderness, is tightening fast. (Courtesy: Down To Earth)

How changing climate could impact India's renewables journey

ndia is turning to renewable energy to reduce its dependence on fossil fuels. This transition is considered necessary to reduce the amount of carbon emitted into the atmosphere, exacerbates climate which change. However, even renewable energy production is expected to be impacted by the already changing climate.

A study by the Indian Institute of Tropical Meteorology (IITM) in Pune found that changes in temperature, wind patterns, and rainfall can impact the productivity of solar and wind plants.

Energy from solar and wind are key to India's plan to reduce its dependence on fossil fuels for its energy needs.

The Union government aims for 50% of energy to be produced by non-fossil fuels by 2030, and looks to increase it to 100% by 2070. These plans will have to consider how climate change will impact the efficiency of wind and solar energy, the IITM study found.

"In the next five decades, there is a likelihood of solar radiation getting affected," said P. Mukhopadhyay, a scientist at IITM, Pune. "And to some extent by the wind as well."

Talking about the method of analysis and how they reached this conclusion, Mukhopadhyay said. "Whatever analysis has been done is mostly based on statistics. You get a time series of data. You get, say, 50 years of data, and then we apply all the necessary advanced statistics. Trend analysis, significance tests,

and so on ' Mukhopadhyay explained that solar radiation can be affected by factors such as wind speeds and cloud cover. According to him, being able to predict these factors through weather forecasts will allow the energy industry to estimate how much energy they will be able to generate more accurately. "This forecast decides what will be the energy generation in the coming 24 hours and so on," he said, "IITM will try to improve this weather prediction more and more so that the uncertainty that is there in weather prediction for the wind and solar sector will be reduced.'

The study predicts that seasonal and annual wind speed is likely to decrease over North India and increase across South India. On the other hand, solar radiation is estimated to decrease over the next 50 years during all

Solar radiance projected to decrease across India

The study by IITM Pune used climate models such as Coordinated Regional Climate Downscaling Experiment (CORDEX), Coupled Model Intercomparison Project phase 5 (CMIP5) and CMIP6 to understand climate projections for various parts of the country over five decades. These models are also used by the United Nations to predict the different ways in which climate change may impact the planet in the future. The IITM study used these models to predict climate change's potential impact on renewable energy.

The researchers have examined historical simulation data spanning the past 55 years to forecast the performance of renewable energy sources over the following 55 years.

"Solar radiance is likely to decrease across most solar farming regions in India throughout all seasons. It also indicates that the southern and northwest regions may experience higher wind speeds during winter and mon-

soon months, when wind potential is typically at its peak," said Mukhopadhyay.

Further, the research highlights notable changes in annual solar radiance, with decreases expected in the foothills of the Himalayas and central India.

Given the projected decrease in future wind and solar potential, Mukhopadhyay advocated for an increased investment in research and development of solar and wind energy technologies. He emphasised the necessity for an expanded and more efficient network of wind and solar farms to boost renewable energy produc-

Moreover, the study underscores the importance of maintaining real-time data on changing climate conditions and their impact on energy systems to inform decision-making. This research holds significance for solar and wind energy developers and investors, particularly as the Indian government aims to increase its renewable energy share and achieve a net-zero target by 2070, as outlined in its updated Nationally Determined Contributions (NDCs) submitted to the United Nations Framework Convention on Climate Change (UN-

The Maharashtra model

Different states are contributing to this goal in different ways. About 95% of India's installed wind power capacity is located in six states - Andhra Pradesh, Gujarat, Karnataka, Maharashtra, Rajasthan and Tamil Nadu.

Notably, solar power projects are also being established all over the country. One of the top performing states in terms of utilisation of solar energy is Maharashtra. The state has an installed solar capacity of over 1,800 MW and a rooftop solar capacity of close to 230 MW. Maharashtra has the fourth highest rooftop solar power generation capacity in the country.

Maharashtra has seen a major increase in solar power capacity in recent years, primarily through an increasing number of solar parks, rooftop installations and solar energy regulations that support the use of solar technology by both residential and commercial consumers.

In order to better understand the impact of climate change on people who partially or completely rely on solar and wind installations for their livelihood. Maharashtra presents a fairer picture owing to its mass adoption of solar and wind projects in recent

The state has achieved considerable success in harnessing clean and sustainable energy sources in 2022-2023. With 512.83 MW of wind power, 4722.90 MW of solar power, 2640.69 MW of biofuels, and 381.08 MW of small hydro capacity, the state now ranks among the top states in terms of installed renewable energy capacity totalling 13.14 GW.

The Climate Group (CG) is an international non-profit that works on climate action through global campaigns like RE 100, which motivates corporations to undertake RE100 commitments. Under RE100, several corporations have committed a 100% shift to renewable electricity by 2030.

"Extreme weather or climate change events such as cyclones impact solar plants. They will impact power distribution. Once a cyclone impacts a solar plant or power distribution, the on-grid solar plants, which is 80% of the market, will not be able to evacuate their power. So that is the one major challenge," said Saswat Sourav Panda, CG's programme manager, while talking about the impact of climate change on sources of renewable energy

"Also, because of the high heat conditions, with more heat the output of the solar plants decreases. For example, if any year is hotter than average, there will be a larger dip in the output of solar plants. This is because solar panels typically generate electricity more efficiently at cooler temperatures," Panda added.

"Along with that heat, another climate problem that happens is the formation of clouds. When there is excess accumulation of clouds, spikes will be there. Highs and lows in power generation will happen. Excessive highs and lows in solar plants or wind plants will create a lot of fluctuations in the power output, which will definitely impact the grid stability."

He further underlined that these are some "technical problems" that are bound to happen because of climate change. "Due to pollution, how will solar plants get affected? Because additional dust is there, to match the generation we have to clean it. That means we are consuming more

Impact on agriculture

These effects of climate change on renewable energy are expected to be felt across various sectors. Agriculture is predicted to be adversely affected too.

Maharashtra introduced scheme in June 2017 to install solar projects near agriculturedominated sub-stations that resulted in higher dependency of farmers on solar panels or other such projects.

The Mukhyamantri Saur Krushi Vahini Yojana was introduced in June 2017, wherein decentralised solar projects of capacity 2-10 MW were installed within a 5-km radius of agriculture-dominated sub-stations.

The scheme was later reframed as Mukhymantri Saur Krushi Vahini Yojana 2.0 (MSKVY 2.0), with the target of 30% feeder solarisation by 2025 through the implementation of 7,000 MW decentralised solar projects in fasttrack mode, thus giving day-time electricity supply to farmers.

During this reporter's visit to Satara village in Maharashtra, local farmers spoke about the challenges that they have faced before and after installing solar panels. Although renewable energy has made their life better, it has also added new problems.

For instance, dust gather in solar panels due to pollution. So regular cleaning is essential to keep them working for which more water is required.

"Where we live, everyone's livelihood depends on farming," said Savitra, a farmer based in Maharashtra's Satara district. "There are no employment opportunities here; everyone has to go to cities. Rainfall is erratic. There are a lot of water problems.

Savitra and her husband had saved some money to build a well for water. However, the expenses of diesel to run the generator would have drained them financially. So they have turned to solar.

"With no access to electricity, our farming activities were limited to only till March," Savitra said, "However, since we installed solar panels, we can now farm all year-round." She got her solar panel installed through Agri Vijay under the EMI financing scheme, a social enterprise that supplies renewable energy products to farmers and rural households.

With a green energy target of 21,100 megawatts by 2020, Maharashtra has set up a transmission corridor to supply green power. In 2017, the decision to provide 12-hour power supply to farmers during the daytime was

Risk versus reward

Experts argue that Maharashtra's policy to set up an alternate green energy corridor puts its farmers at risk if the green energy solution doesn't go as planned.

"Maharashtra is a good example because they have gone with the policy of literally setting up an alternate green energy corridor that is completely powered by solar or wind and using that corridor to assure farmers of a certain amount of solar power in the daytime. Now, if this doesn't go as planned, then obviously farmers are the ones who will be most affected," said Prasanna Singh, editor at Saur Energy Interna-

The introduction of renewable energy has not only improved the lives of farmers but others too. The energy produced from the alternate sources plays a crucial role in supporting education, hospitals, and day-to-day amenities in rural areas.

"In the rural areas that we've worked in, thousands of students who were unable to study have benefited [due to solar]. Untimely deaths of women have been prevented, because solar installations in hospitals ensure that emergency machinery stays operational during power outages. Household chores have become easier for everyone.

Thousands of farmers, women, and children have experienced transformation in their lives," said Sharmila Ghosh, founder of Green Energy Foundation on the positive changes brought in by renewable energy.

Ghosh emphasised on the need to include renewable energy sources into daily living as a whole. She has recommended that the government should make solar panel installation a requirement for homeowners in order to encourage Indians to set aside money specifically for solar energy and to accelerate the nation's transition to green energy. She does, however, support logical and rational exceptions in this

Ghosh said, "Every human, every woman, every child has to see themselves as an ambassador of climate. Schools ought to have a section dedicated to teaching students about leading energy-efficient and climate-friendly lives. My cycle is solar powered. We ought to drive an electric vehicle. All we need to do is put in deliberate efforts such as these."

With India's increasing dependence on wind and solar for its energy needs, the effects of climate change can't be ignored. The IITM's findings suggest that there might be ways to reduce the impacts of a changing climate on these sources of energy. According to Mukhopadhyay, we can invest in research and development to produce high-efficiency solar cells.

Even if solar radiation decreases by 5%, these high-efficiency solar cells can generate the equivalent unit of power. He has also suggested that the hub height of windmills can be increased so that even if wind intensity decreases significantly. the windmills can still generate the equivalent amount of energy.

It is noteworthy that studies like the one conducted by Mukhopadhyay give us an early warning to be able to make changes that will prepare us for the future. (Courtesy: The Wire)

Russian missiles slam into a Ukraine city and kill 13 people as the war approaches a critical stage

Russian missiles slammed into a downtown area of the northern Ukrainian city of Chernihiv on Wednesday, hitting an eight-floor apartment building and killing at least 13 people, authorities said.

At least 61 people, including two children, were wounded in the morning attack, Ukrainian emergency services said. Chernihiv lies about 150 kilometers (90 miles) north of the capital, Kviv. near the border with Russia and Belarus, and has a population of around 250,000 people.

The latest Russian bombardment came as the war stretched into its third year and approached what could be a critical juncture as a lack of further military support from Ukraine's Western partners increasingly leaves it at the mercy of the Kremlin's bigger forces.

BANGKOK, April 17: Myanmar's jailed former leader Aung San Suu Kyi has been moved from prison to house arrest as a health measure due to a heat wave, the military government said. On Wednesday it also granted amnesty for over 3,000 prisoners to mark this week's traditional New Year

Suu Kyi, 78, and Win Myint, the 72-year-old former president of her ousted government, were among the elderly and infirm prisoners moved from out of prison because of the severe heat, the military's spokesperson, Maj. Gen. General Zaw Min Tun, told foreign media representatives late Tuesday. The move has not yet been publicly announced

Suu Kyi's transfer comes as the Army has been suffering a string of major defeats in its fight against pro-democracy resistance fighters and their allies in ethnic minority guerrilla forces.

The nationwide conflict began after the Army ousted the elected government in February 2021, imprisoned Suu Kyi and began suppressing nonviolent protests that sought a return to democratic rule.

Suu Kyi has been serving a 27-year prison term on a variety of criminal convictions in a speciallybuilt wing of the main prison in the capital Naypyitaw, where Myanmar's meteorological department said temperatures reached 39 degrees Celsius (102.2 degrees Fahrenheit) on Tuesday afternoon. Win Myint was serving an eight-year prison sentence in Taungoo in Myanmar's Bago region.

Suu Kyi's supporters and independent analysts say the charges were fabricated in an attempt to discredit her and legitimize the military's seizure of

The military had claimed that her National League for Democracy Party used widespread electoral fraud to win a landslide victory in the 2020 general election, an allegation independent observers found unconvincing.

According to the Assistance Association for Political Prisoners, an independent group that monitors casualties and arrests, more than 20,351 people arrested on political charges since the 2021 army takeover are still in detention, most of whom have not received criminal convictions.

Suu Kyi's health has reportedly deteriorated in prison. In September last year, reports emerged that she was suffering from symptoms of low blood pressure including dizziness and loss of appetite, but had been denied treatment at qualified facilities outside the prison system. Those reports could not be independently con-

firmed, but her younger son Kim Aris said in interviews that he had heard that his mother has been extremely ill and has been suffering from gum problems and was unable to eat. Aris, who lives in England, urged that Myanmar's

military government be pressured to free his mother and other political prisoners.

News about Suu Kyi is tightly controlled by the military government, and even her lawyers are banned by a gag order from talking to the media about her cases.

Her legal team has faced several hurdles, including being unable to meet with her to receive her instructions since they last saw her in person in December 2022. (AP)

Aung San Suu Kyi has been UK PM Sunak tells Israel's Netanyahu to exercise restraint in wake of Iran's missile attacks

LONDON, April 17: British Prime Minister Rishi Sunak has called on his Israeli counterpart Benjamin Netanyahu to exercise restraint and let "calm heads" prevail in the wake of Iran's missile attacks as his Foreign Secretary David Cameron landed in Tel Aviv for talks on Wednesday.

In a phone call, Sunak reiterated the UK's "steadfast support" for regional stability and told the Israeli leader that Iran had miscalculated its move, being isolated on the global stage as a result.

Netanyahu is said to have thanked Britain for its "rapid and robust" support in the face of Iran's unprecedented direct attack on Israel on Saturday.

"The Prime Minister [Sunak] said Iran had badly miscalculated and was increasingly iso-



lated on the global stage, with the G7 coordinating a diplomatic response," Downing Street said in a readout of the call on Tuesday evening.

"He stressed that significant escalation was in no one's interest and would only deepen insecurity in the Middle East. This was a moment for calm heads to prevail," the statement

On the ongoing Israel-Hamas

Netanyahu that he remained gravely concerned about the deepening humanitarian crisis.

"The UK wanted to see a massive step change in aid access to flood Gaza with vital supplies, including Israel opening up new aid routes as quickly as possible. The Prime Minister said it was deeply disappointing that Hamas blocked a deal at the weekend that would have saved Palestinian lives and secured the safe release of hostages," Downing Street added.

With calls for sanctions on Iran, Italy seeks G7 message of restraint as ministers meet in Capri



ROME, April 17: Group of Seven foreign ministers are meeting on the Italian resort island of Capri, with calls for new sanctions against Iran over its attack against Israel and more aid to Ukraine to fight Russia's war topping the agenda.

Under Italy's rotating stewardship, the G7 leaders are expected to issue a united call for Israel to exercise restraint after Iran's unprecedented weekend attack involving hundreds of drones, ballistic missiles and cruise missiles fired toward the Jewish

Italian Foreign Minister Antonio Tajani said he had spoken to his Israeli counterpart, Israel Katz, on Tuesday and urged Israel to not only de-escalate any reaction to Iran's attack but to stave off a planned offensive into the southern Gaza city of Rafah.

"I reiterated this message and I believe that on the occasion of the G7 foreign ministers in Capri, tomorrow and Friday morning, a similar message will be sent," Tajani told state-run RAI. With Israel's war in Gaza in its sixth month, Tehran's attack added a new element of urgency to the three-day meeting of foreign ministers from Britain, Canada, France, Germany, Italy, Japan and the United States. German Foreign Minister Annalena Baerbock called for new sanctions against Tehran and was making a last-minute visit to Israel before arriving on Capri

later Wednesday. "We will discuss how a further escalation with more and more violence can be prevented," she said. "Because what matters now is to put a stop to Iran without encouraging further escalation.'

Germany, a staunch ally of Israel, has been among the chorus of European and US leaders urging Israel to de-escalate tensions and not retaliate for Tehran's at-

tack, which was largely repelled thanks to US and allied help.

British Foreign Secretary David Cameron said he would push for "coordinated sanctions against Iran" at the meeting. He argued that Tehran was orchestrating "so much of the malign activity in this region" from Hamas in Gaza, to Hezbollah in southern Lebanon to the Houthi rebels in Yemen who are behind attacks on shipping in the Red

"They need to be given a clear and unequivocal message by the G-7 and I hope that will happen," Cameron told broadcasters during a visit to Israel.

Russia's two-year war in Ukraine is also high on the agenda, with Ukrainian Foreign Minister Dmytro Kuleba and NATO Secretary General Jens Stoltenberg invited to the Capri meeting on Thursday as guests. Kuleba is expected to repeat his country's need for essential military support, including artillery, ammunition, and air defense systems to bolster its capacity as Russia pushes along the front

The United States and several European countries are discussing proposals to use the profits generated from billions of euros of frozen Russian assets to help provide weapons and other funds for Ukraine, proposals that have gathered steam as US efforts to get new funds for weapons have stalled in Congress. At the European Union level, EU leaders are to discuss the proposal at a summit Wednesday in Brussels. EU foreign policy chief Josep Borrell, meanwhile, is expected in Capri.

The 27-nation EU is holding around 200 billion euros (USD 217 billion) in Russian central bank assets, most of it frozen in Belgium, in retaliation for Moscow's war against Ukraine.

Copenhagen fights the last pockets of a fire that destroyed a 400-year-old landmark

COPENHAGEN, April 17: Danish firefighters were still at work extinguishing the last pockets of a fire that destroyed a 400-year-old Copenhagen landmark a day after the blaze began. "This is sad, so sad," said Mikkel Jensen, a 44-year-old civil servant, as he looked up at the twisted scaffolding still clinging to the ruins of the city's Old Stock Exchange.

Morten Langager, manager of the Danish Chamber of Commerce, which was headquartered in the Old Stock Exchange and owned the building, said the building, built in 1615 and known for its green copper roof and distinctive 56-meter (184-foot) spire in the shape of four intertwined dragon tails, should "rise again."

His boss, Chamber head Brian Mikkelsen, said Tuesday that "no matter what, we will rebuild Boersen" and that the board had backed

No decision has yet been made about who will reconstruct the building, which would cost millions, if not billions of kroner (dollars). A cautious estimate said it could take up to 10 years. Many in Denmark compared Tuesdav's fire to the April 2019 blaze at Notre Dame that destroyed the 800-year-old cathedral's spire. Its restoration is slated for completion this year.

The extent of the damage, caused by flames and the tons of water poured to extinguish them, was still unknown.

"A lot has disappeared in the fire," Tim Ole Simonsen of the Greater Copenhagen Fire Department said of the building. "The stability of external walls is threatened by the fact that the wooden structure that was holding them is gone." Up to 40 shipping containers, filled with concrete, will be put around the remaining outer walls to stabilise it, the fire department said.

Police hadn't vet been able to enter the building to begin investigating the cause of the fire, said Brian Belling, a Copenhagen police officer in charge of the investigation. The blaze is believed to have started on the building's roof during renovations on Tuesday morning.

"It can take a long time to find the cause of a fire," Belling said.

When the fire engulfed the building on Tuesday, passers-by, Chamber of Commerce staff, police officers and members of an army unit that had been sent to help raced inside the building to save its treasures.

Mikkelsen, who was one of the employees who ran in, told public broadcaster DR that the building had made a plan for what to save in a "worst case" scenario. When it was too dangerous for people to go up to the first floor, firefighters with breathing gear were sent in to retrieve priceless items, he said, adding that many of the building's most valuable contents, which included priceless paintings and other works of art, had been saved.

The Chamber of Commerce said that among the saved items was a huge painting titled, "From Copenhagen Stock Exchange," completed in 1895 by Danish artist P.S. Krøyer.

An hour after the first reports of fire, it rapidly engulfed the spire and sent it crashing onto the building, which was shrouded by scaffolding, and onto the street behind. Huge billows of smoke rose over downtown

Copenhagen and could be seen from southern Sweden, which is separated from the Danish capital by a narrow waterway. Ambulances were at the scene but there were no reports of casualties. Smoke damage closed ministries located in the street behind the Old Stock Exchange, which remained shut Wednesday as employees were told to work from home because of a strong smell of smoke in the build-

The buildings must be thoroughly cleaned and their ventilation systems must be checked and perhaps replaced before ministry staff can return, said Rasmus Brandt Lassen, head of the Danish Building and Property Agency.

"We have told them that they should expect to work at home for the rest of the week," Brandt Lassen said. The exchange is considered a leading exam-

ple of the Dutch Renaissance style in Denmark. The Chamber of Commerce moved into the building after Copenhagen's stock exchange left in 1974.

Its dragon spire was one of the many of topping the city's churches and castles, which have earned Copenhagen its nickname as "the city of spires." Others copper-covered belfries include the serpentine spire of Our Saviour's Church, those of the downtown Renaissance Rosenborg Castle, and the tower of the Christiansborg Palace which houses the Danish parliament.

A main road running past the Old Stock Exchange remained closed on Wednesday.(AP)

DUBAI, April 17: The desert nation of the United Arab Emirates attempted to dry out on Wednesday from the heaviest rain ever recorded there after a deluge flooded out Dubai International Airport, disrupting travel through the world's busiest airfield for international

The state-run WAM news agency called the rain on Tuesday "a historic weather event" that surpassed "anything documented since the start of data collection in 1949." That's before the discovery of crude oil in this energy-rich nation, then part of a British protectorate known as the Trucial States.

Rain also fell in Bahrain, Oman, Qatar and Saudi Arabia. However, the rains were acute across the UAE. One reason may have been "cloud seeding," in which small planes flown by the government go through clouds burning special salt flares. Those flares can increase precip-

Several reports quoted meteorologists at the National Center for Meteorology as saying they flew six or seven cloud-seeding flights before the rains. The center did not immediately respond to questions Wednesday, though flight-tracking data analyzed by The Associated Press showed one aircraft affiliated with the UAE's cloud-



seeding efforts flew around the country Sunday. The UAE, which heavily relies on energy-hungry desalination plants to provide water, conducts cloud seeding in part to increase its dwindling, limited

The rains began late Monday, soaking the sands and roadways of Dubai with some 20 millimeters (0.79 inches) of rain, according to meteorological data collected at Dubai International Airport. The storms intensified around 9 am local Tuesday and continued throughout the day, dumping more rain and hail onto the overwhelmed city.

By the end of Tuesday, more than 142 millimeters

An average year sees 94.7 millimeters (3.73 inches) of rain at Dubai International Airport, a hub for the longhaul carrier Emirates.

At the airport, standing water lapped on taxiways as aircraft landed. Arrivals were halted Tuesday night, and passengers struggled to reach terminals through the floodwater covering surrounding roads.

One couple, who spoke to the AP on condition of anonymity to speak freely in a country with strict laws that criminalize critical speech, called the situation at the airport "absolute carnage."

"You cannot get a taxi. There's people sleeping in the Metro station. There's people sleeping in the airport,'

the man said Wednesday. They ended up getting a taxi to near their home some 30 kilometers (18 miles) away, but floodwater on the road stopped them. A bystander helped them over a highway barrier with their carry-on luggage, the bottles of gin they picked up from duty-free clinking away.

Dubai International Airport acknowledged Wednesday morning that the flooding had left "limited transportation options" and affected flights as aircraft crews couldn't reach the airfield. (AP)

Has PM adopted 'bluff and rule' policy for Tripura, asks Cong

NEW DELHI, April 17: The Congress on Wednesday alleged that there is "rampant political violence" in BJP-ruled Tripura and questioned Prime Minister Narendra Modi's "silence" on the issue.

Congress general secretary Jairam Ramesh attacked the prime minister ahead of his Lok Sabha poll rally in Agartala, asking whether he has adopted a "bluff and rule" policy for Tripura.

"Today's questions for the PM as he heads to Tripura: Does the PM approve of the BJP's rampant political violence in Tripura? Has the PM adopted a bluff and rule policy for Tripura as well?" Ramesh asked in a post on X. What is the prime minister's vision to eradicate child malnutrition in Tripura, he asked.

"Jumla details follow: On April 2nd, a Congress publicity vehicle was forcefully seized by a group of BJP associates. According to eyeheld on June 2, while that of the witnesses, the driver was coerced into a nearby jungle at Brinda Chowmuhani where the assailants completely ransacked the vehicle and set fire to all its posters, flags and banners," Ramesh alleged in 14 candidates are contesting on the lone Lok Sabha seat in Sikkim.

Sadly, this is just the latest in a

string of political violence committed by the BJP since coming to power in 2018 in Tripura, he claimed. Ramesh said reports suggest that about 25 opposition party workers have been "murdered" in the last six years. In 2021 alone, Tripura reported 64 cases of political violence, in which 136 people were injured, he said.

"The BJP's actions strike at the heart of our democratic values. Is the PM doing anything at all to ensure that the perpetrators face the consequences for their actions? Is his silence a tacit approval of this violence?" Ramesh asked.

In their manifesto for the 2023

assembly elections in Tripura, the BJP made vague promises to Tripura's tribal communities on the issue of Greater Tipraland, he said.

The manifesto stated that they would take steps for granting "legislative, more executive and administrative powers to the tribal council", he pointed out.

Noting that the Centre signed a "Tripartite Agreement" with the state government and the Tipra Motha in 2024, Ramesh said the agreement made a deliberately vague promise to "amicably resolve all issues of indigenous people" in a "time-bound manner."

"This 'Tripartite Agreement',

more of an eyewash than a substantive document, cleared the way for Tipra Motha to join the NDA (BJPled National Democratic Alliance), but achieved little else for Tripura's tribal peoples. A month later, it is still unclear what the BJP's stance is on the tribal people's demand for greater autonomy," he said.

Is this lack of clarity deliberate and an extension of the "bluff and rule" strategy the BJP has employed in Nagaland and elsewhere in the Northeast, he asked. "The NFHS-5 (National Family

Health Survey) data reveals a significant issue with child nutrition in Tripura. There has been an increase in stunting, wasting and underweight children. In the four years between NFHS-4 (2015-16) and NFHS-5 (2019-2021), the percentage of stunted children increased from 24 per cent to 32 per cent. Since NFHS-4, the proportion of kids who are underweight (26 per cent) or wasted (18 per cent) has not improved," he claimed. The BJP government that came to power in 2018 appears to have achieved very little on this front, the Congress general secre-

tary said. (PTI)

Campaign ends for Tripura West LS seat, by-poll to assembly constituency



AGARTALA, April 17: The campaign for Tripura West Lok Sabha constituency and Ramnagar Assembly constituency by-poll ended at 5 pm on Wednesday.

All preparations including security arrangements have been made for the polling to be held on April 19, an election department official said.

Rallies, public meetings and roadshows marked the twoweek long high decibel campaign with Prime Minister Narendra Modi, Union home minister Amit Shah and Congeneral secretary Priyanka Gandhi adding glamour to it.

Although nine candidates are in the fray in Tripura West Lok Sabha constituency, the battle will be mainly between BJP candidate Biplab Kumar Deb and state Congress president Asish Kumar Saha.

A total of 14.61 lakh voters are eligible to exercise their franchise. Of them, 7.33 lakh are male while the number of female voters is 7.28 lakh.

In the Ramnagar Assembly by-election, the battle line has been drawn between BJP candidate, Agartala Mayor Dipak Majumer, and former CPI(M) MLA Ratan Das. Altogether 54,669 electors

will be eligible to decide the fate of the two candidates.

Driver injured along Imphal-Jiribam section

IMPHAL, April 17: A driver was injured after he was hit by bullets fired by armed miscreants towards Imphal-bound oil tankers and loaded trucks along Imphal-Jiribam section of NH-37 in Tamenglong district on Tuesday, damaging some oil tankers including a bullet tanker (bulk LPG carrier). Hours after the attack, panic buyers stormed at petrol retail outlets across the valley districts to fill up their vehicle fuel tanks fearing closure of the outlets. Reports said that the armed miscreants attacked the Imphal-bound vehicles escorted by CRPF personnel at a place between Tollen Kuki village and Keimai under Tousem police station of Tamenglong district today, around 10 am.

The driver sustained bullet injuries on one of his legs, the reports said. Security forces immediately rushed them to a hospital in Jiribam district. Their condition of the driver was stated to be out of danger. Four oil tankers loaded with petrol and diesel and a bullet tanker were damaged after the bullets fired by the armed miscreants hit, causing leakage of the vehicle fuels and LPG.

The reports also said that the tankers escorted by a convoy of the CRPF were heading to Imphal along with trucks loaded with essential commodities from Jiribam today morning.

While heading toward Imphal, the armed miscreants opened fire several rounds of shots targeting the tyres and tanks hitting four oil tankers and a bullet tanker by the bullets, the reports added. (NNN)

Congress hopes anti-incumbency factors to work in Tripura West LS seat

AGARTALA, April 17: Former Tripura CM and BJP nominee Biplab Kumar Deb is banking on the development and welfare schemes of the government to win the Tripura West Lok Sabha constituency while his opponent Asis Kumar Sabha of Congress is hopeful that the anti-incumbency factor will help him win the elections.

Deb, who built a solid BJP organisational base in the northeastern state and led the saffron party to form its first government in Tripura in 2018 ending the 25year-old CPI(M) rule in the state, is hopeful of winning the seat by a huge margin as the BJP government has taken several welfare measures and infrastructure projects in the state.

The Tripura West parliamentary constituency, an unreserved seat comprises of 30 Assembly segments and has a considerable number of ST and minority voters apart from Bengali voters.

Minority voters are key in at least nine Assembly segments while tribal voters appear to be a factor in five non-ST Assembly

Pratima Bhoumik had won the Tripura West Lok Sabha seat in 2019 by over 3 lakh votes by defeating Congress nominee Subal Bhowmik

A lot has changed in the political



landscape of the constituency since the 2019 Lok Sabha election as Subal Bhowmik has joined the BJP and is now the saffron party's state vice president and the CPI(M) has now teamed up with the Congress to take on the saffron party.

BJP state general secretary Amit Rakshit claimed that Deb's winning margin will be more than the margin of Pratima Bhoumik in 2019.

"In the 2019 Lok Sabha election, our candidate won by a margin of more than 3 lakh votes and this time it may cross the margin because of Modi's magic and popularity of former Chief Minister (Biplab Kumar Deb) among women and youths," he said.

"The BJP is seeking votes for development and welfare of the poor and lower middle class. It is

a fact, that Modi ji has rolled out enormous welfare schemes -PMAY, Jal Se Nal, Ayushman Bharat, Ujjawala Yojana and free rice. Besides, the state has got six national highways and better rail connectivity. Therefore, the advantage will go to the BJP's side in the elections," said Sanjib Deb, a sen-

ior journalist. He, however, said unemployment appears to be a major factor in the parliamentary election.

"There is no doubt an anti-in-

cumbency wave is sweeping Tripura. The people are angry over the growing unemployment, price rise, rise in medicine prices, drug addiction over the past few years. But, the BJP which is mainly depending on welfare schemes is likely to navigate the anti-incumbency factor by using its strong organisational set-up," Sekhar Dutta, a poll strategist told PTI.

When asked about the Congress party candidate's prospect (in Tripura West) Lok Sabha seat, senior Congress MLA Sudip Roy Barman alleged that people are angry with the Modi government's rule over the past 10 years and will give a fitting reply in the elections.

"If 80 per cent of voting remains free, fair and peaceful, the Congress will win the Lok Sabha seat. We urge the Election Commission of India (ECI) to ensure a conducive atmosphere for peaceful and fair election," Roy Barman

Campaigning for LS, assembly polls in Arunachal Pradesh ends

ITANAGAR, April 17: Campaigning for the April 19 simultaneous polls in Arunachal Pradesh came to end on Wednesday evening, setting the stage to elect two Lok Sabha MPs and 50 lawmakers for the state assem-

While defence minister Rajnath Singh addressed a public rally at Namsai to seek votes for Arunachal East Lok Sabha candidate Tapir Gao, party's president JP Nadda addressed a rally at Doimukh near here, seeking support from people for the western parliamentary constituency's candidate Kiren Rijiju.

Assam chief minister Himanta Biswa Sarma and his cabinet colleague Ashok Singhal had addressed several meetings in the state for BJP.

Though the opposition Congress had announced names of several star campaigners, nobody turned up for campaigning. NPP president and Meghalaya chief minister Conrad Sangma addressed two election rallies at Longding and Basar.

This time, the parties also campaigned through social media platforms and door-to-door visits. The ruling BJP in the northeastern state has already

opened its account by securing 10 seats in the 60member assembly, unopposed.

The prominent figures who won without a contest are chief minister Pema Khandu from Mukto seat, deputy chief minister Chowna Mein from Chowkham, Techi Kaso (Itanagar), Jikke Tako (Tali), Nyato Dukam (Taliha), Mutchu Mithi (Roing) and Dasanglu Pul from Hayuliang assembly seat.

Three newcomers who won unopposed are Dongru Siongju from Bomdila seat, Ratu Techi (Sagalee) and Hage Appa from Ziro-Hapoli constituency.

The BJP had fielded 60 candidates in all the assembly seats while opposition Congress put 19 nominees, National People's Party (NPP) contested 20 seats, Nationalist Congress Party (NCP) in 14, People's Party of Arunachal in 11,

Arunachal Democratic Party (ADP) in four seats and Lok Jana Shakti Party in one seat. There are also 14 independent candidates in the fray.



In Arunachal West Parliamentary seat, eight candidates are in the fray including Earth Sciences Minister Kiren Rijiju and Arunachal Pradesh Congress Committee (APCC) president Nabam Tuki.

Altogether six candidates are vying for the Arunachal East Parliamentary seat including sitting MP Tapir Gao and APCC vice-president Bosiram Siram. BJP won both the Lok Sabha seats in the 2019 elections. In the assembly, the BJP bagged 41 seats, JD (U) won seven, NPP five, the Congress secured four seats, the PPA won one seat and two Independent candidates also emerged victorious.

An estimated 8,92,694 voters including 4,54,256 women will decide the fate of 133 candidates contesting in the assembly polls and 14 in the two Lok Sabha seats. A total of 11,130 polling officials have been deployed while 6,874 EVMs will be used in 2,226 polling booths. Polling is scheduled to be held from

Elaborate security arrangements have been made to conduct peaceful polling with the deployment of 80 companies of central armed police forces (CAPF) including, IRBn and state police forces to manage law and order, Chief Electoral Officer (CEO) Pawan

Kumar Sain informed. Counting of votes for assembly elections will be held on June 2, while that of Lok Sabha polls would be done on June 4. (PTI)

BJP eyes hat-trick as Congress mounts challenge in Udhampur and Jammu

'It is a tough battle for the Union Minister this time, considering the popularity of Congress candidate Lal Singh among voters in the constituency'

JAMMU, April 17: The BJP has gone full-throttle with a high-voltage campaign, while the Congress seems to have adopted a subdued approach as the parties gear up for a three-cornered contest -- scheduled on April 19 and 26 -- in the Udhampur and Jammu constituen-

In both the 2014 and 2019 Lok Sabha elections, the ruling BJP secured the Udhampur and Jammu seats with Union Minister Dr Jitendra Singh and Jugal Kishore emerging triumphant, respectively.

Now, seeking a hat-trick of wins in the two constituencies, the saffron party is vigorously working to fortify its support base. It, however, faces stiff competition from the Congress, which has nominated two-time MP Lal Singh in Udhampur and its working president Raman Bhalla in Jammu.

Campaigning for the first phase draws to a close on Wednesday.

The BJP's campaign in Jammu and Kashmir included rallies by top party leaders, such as Prime Minister Narendra Modi, Uttar Pradesh Chief Minister Yogi Adityanath, Defence Minister Ra-

jnath Singh, Home Minister Amit Shah, Union Minister Anurag Thakur, and senior leader Syed Shahnawaz Hussain.

In contrast, the Congress had only former deputy chief minister of Rajasthan Sachin Pilot and actor-turned-politician Raj Babbar addressing two rallies in the region since the announcement of the

The BJP is banking on the 'Modi factor' and its promises delivered, including the abrogation of Article 370, the passage of the Uniform Civil Code (UCC) Bill, and the construction of the Ram Temple in Ayodhya, along with various welfare schemes and infrastructure

projects, to bolster its narrative of

development. Modi, while campaigning for Dr Jitendra Singh in Udhampur on April 12, said that assembly elections will be soon held in Jammu and Kashmir and the statehood will

The Congress, on the other hand, is focusing on the issues of unemployment and safeguarding

secularism besides restoration of statehood.

The grand old party is being backed by the National Conference (NC) with former chief ministers of the erstwhile-state of Jammu and Kashmir Dr Farooq Abdullah and his son Omar Abdullah campaigning for the INDIA bloc candidates Lal Singh in Udhampur and Raman Bhalla in Jammu.

"Your vote will have a bearing for the next five years, so you have to choose wisely. Don't allow votes to get divided," Omar had said in Doda.

Pilot, who campaigned for Congress candidates in R S Pura and Kathua on April 16, criticised the saffron party for allegedly destroying the state, saying, "Under the rule of the Lieutenant Governor, outsiders are encroaching on lands. Lands that are being cultivated are being snatched from the people and given to outsiders.'

Lal Singh is expected to give a tough battle to BJP's candidate and Union Minister Dr Jitendra Singh in the Udhampur Lok Sabha constituency, which was once a Con-

His campaign has focused on the "identity" of J&K, which he alleges has been eroded by the BJP government at the Centre. He has been vocal in attacking the Modi government, accusing it of "destroying J&K during its 10 years of misrule. Lal Singh was

CHANDIGARH, April 17: Farmers under the banner of the Samyukta Kisan Morcha (Non-Political) and Kisan Mazdoor Morcha on Wednesday squatted on a rail track in Patiala district near the Puniab and Harvana border, demanding release of three farmers who had been arrested by the Haryana Police.

Many trains were diverted because of the farmers' blockade at Shambhu Railway Station, railway authorities said.

KMM leader Sarwan Singh Pandher said the Haryana administration had given them an assurance that the arrested farmers

would be released by April 16. "When our farmers were not released, we decided to squat on the rail track," Pandher said.

Though the Punjab Police had erected barricades to prevent protesters from heading towards the rail track, farmers forced their way and sat on the track.

The SKM (Non-Political) and the KMM are spearheading the 'Delhi Chalo' march by farmers to press the government to accept their demands which includes that the Centre should give a legal guarantee of Minimum Support Price (MSP) for crops.

The farmers have been staying put at the Shambhu and Khanauri border points between Punjab and Haryana since February 13 when their march was stopped by the security forces. (PTI)

Environment, climate change gain prominence in manifestos but experts question follow-through

NEW DELHI, April 17: From a few lines two decades ago to multiple full pages, Lok Sabha election manifestos of two primary national parties in India - the BJP and the Congress - reflect rising concerns over climate change and environmental degradation.

While policy experts have welcomed the increased attention to these issues, they, however, say many promises have proved to be "symbolic" considering the "contradictory" approach governments have taken in certain matters, including forest and wildlife conservation.

Election manifestos represent the political standing of parties and are often discussed, debated, and compared during elections. From international policy to jobs, health, and education, these address a range of issues and help the electorate make an effective

The BJP, which released its 69-

page election manifesto last Saturday, has dedicated three pages to environment and climate issues under the section "Modi Ki Guarantee for Sustainable Bharat", coming a long way from just a paragraph on "environment" in the 1999 Lok Sabha elections.

The word "climate change" did not even figure in the 1999 and 2004 manifestos of the BJP, currently the world's largest political The Congress has allotted two

pages for environment, climate, disaster management, and water and sanitation-related issues in its 2024 election manifesto. A review of its previous Lok

Sabha election manifestos shows

a strong emphasis on climate

change and environmental sustainability issues. A 2022 study by the Centre for Policy Research noted that the Congress has consistently emphasized climate change and envi-

ronmental sustainability over the last three elections and has discussed specific steps for environmental protection, like green budgeting and the creation of an independent authority to work on

According to the study, while the BJP dedicates about 11 per cent of its manifesto to environmental issues, left-leaning parties generally highlight water conservation, dedicating around 12 per cent of their content to environmental protection and sustainabil-

Key commitments in the BJP's latest manifesto include achieving net-zero emissions by 2070, transitioning to non-fossil fuel energy sources, improving river health, achieving national air quality standards in 60 cities, expanding tree cover, and boosting disaster resilience.

Experts, however, have expressed concerns regarding the lack of specific steps in their manifesto to address environmental challenges.

Change our dept if you can't improve work conditions: Women train drivers

NEW DELHI, April 17: Women train drivers have urged the Railway Board to either improve their "pitiable" working conditions or allow them to shift to other departments.

A group of female loco pilots, who are members of the All India Railwaymen Federation, recently gave a representation to the Railway Board chairperson Jaya Varma Sinha, highlighting their plight and demanding "a one-time cadre change" option.

Lack of toilet facilities in engines, inability to change menstruation pads, mandatory provision to get out of the engine to attend to any technical glitch even at night and no pick-up and dropoff facility for late-night duties are some of the problems cited by the women train drivers. Currently, over 1500 women are working as loco pilots and assistant loco pilots in various railway zones across the country and they have been raising their issues with the Railway Board through various railway unions and federations.

"The Railways is coming up with new locos with washroom facilities but it will take ages to replace the old ones with the new ones," a woman loco

In 2018, during an interaction with various senior railway officials, the



She said, "It was mentioned in the 'Record Note of Discussion' that a one-time option may be given to the lady staff in Engineering, Loco Pilot and Guard category for change of category". "However, no action was taken after that. So we demand that you change our jobs if you cannot improve pitiable work conditions," she said.

All India Railwaymen Federation general secretary Shiva Gopal Mishra supported the demands of the women

we don't need to use a toilet and this causes various diseases. Male loco pilots also face problems but the condition of females is miserable," she said.

Female loco pilots say besides loco conversion, there are many other areas where the Railways can improve amenities in the interest of female loco pilots. For instance, there should be facilities for pick-up and drop for latenight shifts. According to railway norms, if any chain pulling happens or a technical glitch occurs during train operation, the loco pilot has to get down and attend to the problem.

"This norm must be amended. If a chain pulling happens in the middle of the night in any secluded area, how can a woman loco pilot get down and fix it? "Railways norms violate various other statutory provisions for female workers offered in other sectors," claimed a female loco pilot, who recently suffered injuries when she came out of the engine to attend to a techni-

She added, "On one hand, the Railway is taking pride in launching modern and new age trains like Vande Bharat but on the other hand, in many running rooms and lobbies, there are no separate washroom facilities for

The action came ahead of the first phase of polling in Chhattisgarh scheduled on April 19.

Those killed included Shankar Rao and Lalita, both divisional committee members of the outlawed CPI

on their heads, police said.

Various division committees of Maoists handle different tasks. The north Bastar division committee handles illegal "levy collection" (extortion from contractors and other people) and logistical supply network, the official

"The encounter on Tuesday has inflicted a heavy blow to the north Bastar division committee. However, there is a lot more left to be done to completely eliminate it and we are heading in the right direction," he said.

The process to identity the killed Naxalites was underway. So far, Shankar Rao and Lalita have been identified. he said, adding that 15 women were among the killed

Prima facie, it seems most of the killed Naxalites belonged to Partapur area committee, he said.

Asked about security arrangements for the Bastar Lok Sabha constituency where polling will be held on April 19, the IG said during the last year's assembly elections, Naxalites tried to indulge in violent activities but proper security arrangements foiled their bids.

"Even at this time of general elections, we have made adequate security arrangements with the available resources and we hope that elections in Bastar and Kanker (scheduled on April 26) will be conducted peacefully,'

ISRO to continue lunar mission until an Indian lands on Moon: Somanath

AHMEDABAD, April 17: The Indian Space Research Organisation will continue its Chandrayaan series of lunar probes until an astronaut from the country lands on the Moon, said ISRO Chairman S Somanath on Wednesday.

Last August, the premier space agency's Chandrayaan-3 spacecraft made a soft landing on the south pole of the lunar surface, making India the first country to achieve the feat.

"Chandrayaan 3 has done very well. Data has been collected and scientific publication has just started. Now, we want to continue the Chandrayaan series till an Indian lands on the Moon. Before that, we have to master many technologies, such as going there and coming back. That we are trying to do in the next mission," he told reporters on the sidelines of an

Somnath was in Ahmedabad as the chief guest of a programme organised by the Astronautical Society of India.

About India's first-ever human space flight mission, Gaganyaan, Somanath said ISRO will carry out an uncrewed mission, a test vehicle flight mission and an airdrop test this year.

The airdrop test will happen on April 24. Then two more uncrewed missions will happen next year and then the manned mission, if everything goes well, by the end of next year," the ISRO chairman said.

The Gaganyaan project envisages the demonstration of human spaceflight capability by launching a crew of 3 members to an orbit of 400 km for a 3-day mission and bringing them back safely to Earth, by landing in Indian

On ISRO's newly developed Carbon-Carbon (C-C) nozzle for rocket engines, he said it will improve payload capacity for being lightweight and it will be installed in the Polar Satellite Launch Vehicle or PSLV.

"This is the technology we wanted to develop over the past many years. Now we have mastered it, built it and then tested it in the engine. It's a Carbon-Carbon nozzle. It gives us a weight advantage in comparison to metal and it also allows us to operate at higher temperatures. Reduction in weight improves the efficiency of engine and payload capacity. We are going to put it in PSLV," he said.

In a release on April 16, ISRO announced that it had achieved a breakthrough in rocket engine technology with the development of a lightweight C-C nozzle for rocket engines, enhancing payload capacity. (PTI)


HC raps Maharashtra govt for denying compensation over nurse's Covid death, calls it 'insensitive'

Tribal paintings adorn polling booths in Odisha's Gajapati

BERHAMPUR (ODISHA), **April 17:** In a bid to promote the elections as a festival of democracy among tribal people, the Gajapati district administration has adorned polling booths with idital, a unique painting of the Souras, a particularly vulnerable tribal group (PVTG) in Odisha.

"When people to go polling booths on May 13 to cast their votes, they will find their own painting in polling stations," a senior official said.

Saura and Lanjia Soura communities traditionally embellish their homes and villages with murals during festivals and ceremonies, including marriages.

Polling booths have been primarily set up in schools in PVTG-inhabited areas. Additionally, the administration has also roped Soura people to create awareness about voting through the tribal language.

This initiative is part of the SVEEP (Systematic Voters' Education and Electoral Participation) programme aimed at attracting voters to booths and increasing the turnout, an official said. "The aim of setting up ethnic booths is to attract tribals, who seldom exercise their franchise and remain busy with their routine work, to vote", said Birendra Kumar Das, additional district magistrate-cum-returning officer, Mohana assembly segment in the district.

Most of the Soura and its subgroup Lanjia Soura people live in Mohana and Gumma blocks of Gajapati district. Their population is over 33,000 (Soura-18,600 and Soura-14,670), spread over two assembly segments - Mohana, reserved for the Scheduled Caste, and Paralakhemundi under Berhampur Lok Sabha constituency.

"The administration has decided to set up 33 ethnic booths, which will be managed by the polling personnel of tribal communities," he said.

Meanwhile, a team of officers is raising awareness in remote villages to enhance voter turnout.

Army chief Gen Pande inaugurates state-of-the-art IT lab at Uzbek Academy of Armed Forces

NEW DELHI, April 17: Indian Army Chief Gen Manoj Pande on Wednesday inaugurated a stateof-the-art IT laboratory facility that also boasts a cutting-edge cybersecurity lab at the Uzbek Academy of Armed Forces during his ongoing visit to Uzbekistan, sources said.

The development signifies a milestone in defence cooperation between the two nations, following a commitment made during the Defence Ministers' meeting in September 2018, Indian Army sources said.

Gen Pande is visiting Uzbekistan from April 15-18 to explore new avenues of bilateral military collaboration.

He is scheduled to hold wide-ranging talks with the top military brass of the Central Asian nation besides visiting a number of defence establishments, the defence ministry had earlier



In a significant step toward strengthening bilateral ties between India and Uzbekistan, Gen Pande inaugurated a high-tech IT laboratory at the Uzbek Academy of Armed Forces, the

The laboratory is equipped with state-of-theart technology, including nine rooms that house

two lecture halls, a cutting-edge cybersecurity lab, a hardware programming lab, an object-oriented programming lab, a web programming lab, a server room, a multimedia room, and a virtual reality room, they said.

Additional facilities include videoconferencing terminals, interactive panels, networking devices, and an assortment of computing equipment comprising a large number of high-end PCs, workstations and laptops, alongside essential peripherals such as printers, cameras, scanners, and storage

The request to establish an IT lab was initially made during the Defence Ministers' meeting in September 2018, and the project gained momentum with the approval in 2019, funded through the Ministry of External Affairs' Aid to Eurasia initiative, the army sources added.

It has been learnt that the bids exceeded the en-

visaged budget of ₹ 6.5 crore. As a result, ₹ 8.5 crore was allotted for the project. An Indian company won the contract and made the lab fully operational well in time, they said.

This collaborative initiative is not just a "leap in technological advancement" for Uzbekistan's defence academy but also a bridge "reinforcing the expanding partnership" between the two nations, promising a future of cooperation in defence and technology, a source said.

The establishment of the IT lab is expected to enrich the training resources available to the Uzbek armed forces and foster a deeper understanding and cooperation between India and Uzbekistan in the years to come, they said.

The defence ministry on Monday described the Army chief's visit to Uzbekistan as a "significant step" in bolstering defence cooperation between the two countries. (PTI)

Unseasonal rains claim 10 lives in Marathwada in a week



CHHATRAPATI SAMBHAJINA-**GAR, April 17:** Unseasonal rains have claimed the lives of 10 persons and 150 animals in Marathwada region of Maharashtra in a week's time since April 9, a primary survey report prepared by the state revenue department said.

The Marathwada region comprises eight districts - Chhatrapati Sambhajinagar, Jalna, Beed, Parbhani, Latur, Nanded, Dharashiv and Hingoli. The report said that spells of unseasonal rains lashed parts of Marathwada since April 9, causing loss of human and animal lives. The rainfall and hailstorms also damaged over 450 houses in 481 villages across the region. Crops standing on over 5,256.86 hectares of land belonging to 9,127 farmers were affected by unseasonal rains and hailstorms, it said. "Since April 9, unseasonal rains and hailstorms claimed the lives of 10 people, while as many others were injured. The highest number of three deaths occurred in Beed, followed by two each in Chhatrapati Sambhajinagar, Parbhani and Latur districts. while one death was reported in Hingoli," the report added.

As many as 152 animals, including 117 milch animals, lost their lives in

the unseasonal rains, it said. These showers also caused largescale damage to irrigated land, 700.60 hectares of non-irrigated land, 3,231.20 hectares of orchards, and fruit crops spread over 1,325.06 hectares. Beed district witnessed the maximum loss with 1,693.80 hectares of land, the report said. (PTI)

"At the other extreme is India at the bottom of the list with deteriorating air quality, rapidly rising greenhouse gas emissions, groundwater depletion, drying up and polluted rivers and water bodies, and mountains of waste everywhere," the statement said.

The civil society organisations said many crucial laws protecting India's environment and natural ecosystems such as the Forest Conservation Act and the Environment Impact Assessment Notification have been "weakened" in the last few years at a time when the country is grappling with worsen-

ing impacts of climate change. The country's pristine forests, rivers, mountains and deserts are being exploited for coal, critical minerals, mega-infrastructure and dam projects, they said.

The groups said that India is facing a huge water crisis with 70 per cent of the country's groundwater

aquifers having dried up and the rate of recharge being less than 10 per cent.

India was declared the thirdmost polluted country in 2023 according to a report released by Swiss air quality monitoring body, IQ Air, falling from eighth position in 2022. Out of the 50 most polluted cities in the world, 42 cities are now in India.

They asked political leaders to include community and civil society in the decision-making process pertaining to all local and national development works, and ensure that no diversion of forest and agricultural land takes place without gram sabha's consent.

Section 144 imposed in Sonitpur

TEZPUR, April 17: The Sonitpur district administration has issued prohibitory orders under section 144 of Cr.P.C., restricting assembly of five or more persons in any public places, unlawful assemblies and prohibition on holding of public meeting for a period of 48 hours from 5 pm on Wednesday till the closure of polling activities in the district.

Presence of political functionaries, party workers, procession functionaries and campaign functionaries etc. in the constituency, who have been brought from outside the constituency for campaigning and non-voters of the constituency, inflammatory or communal or racist or caste or class inclined speeches, slogans, display of such messages through banners, posters, wall writing, circulation of leaflets, handout etc. which may result in intimidation or influence upon electors, canvass for votes or exhibiting any notice or sign related to election, including wearable like caps, shawl etc. with political party's name, symbol, slogan etc. within the polling station on the day of polling have been prohibited.

The order also restricts the canvassing for votes, display of campaign related poster or banner, persuading any elector not to vote for a particular candidate, persuading any elector not to vote at the election, using or operating any apparatus for amplifying or reproducing the human voice, such as megaphone or a loudspeaker within 100 meters of a polling station, shouting or otherwise acting in a disorderly manner and use of loudspeakers during the next 48 hours. However, the order does not restrict house-to-house visits in connection with

PM skipped Upper Assam as he is afraid of facing tea garden workers: Pawan Khera

SIVASAGAR, April 17: Ahead of Prime Minister Narendra Modi's election rally in Nalbari on Wednesday, senior Congress leader Pawan Khera claimed that the PM skipped upper Assam where polls are due in the first phase as he was "afraid" of facing tea garden workers for "not fulfilling" promises.

Stating that Congress leader Rahul Gandhi's 'Nyay Yatra' was not permitted in Guwahati in view of commuters' problems, Khera criticised Modi for holding a roadshow through the busy Guwahati-Shillong Road on Tuesday evening, claiming that it created problems for all, from patients to office-goers since the morning.

Addressing a press conference here, Khera said, "We don't know why the Prime Minister is not coming to upper Assam. He is going to Nalbari where elections are in the third phase. Gujrathi meets Nepomniachtchi in the next round followed by Praggnanandhaa and these two matches will probably set the tone of the tournament and might just be pivotal to deciding the next world championship challenger.

For Gukesh, the clash with Caruana is going to be crucial as the Indian has white pieces. If he is able to press for advantage, the onus will be on Caruana to prove his detractors wrong.

The Italian-turned-American is competing in his sixth Candidates tournament in a row but has only won it once.

Gukesh will probably train his eyes on beating the lowest-



provided he gets past Caruana unscathed.

Set to play against the Azerbaijani with black, Gukesh will surely go all-out for a victory even as Abasov has been super solid with his white pieces.



India's T20 WC Squad: No fresh faces likely; Shivam vs Rinku, Gill vs Jaiswal shootout possible

NEW DELHI, April 17: The national selection committee is unlikely to blood any rookie IPL performer during the upcoming T20 World Cup in the Americas but a couple of tried-and-tested faces might have to brace up for disappointment when the squad is finalised by the end of this month.

With the ICC making it mandatory to announce the provisional 15-member squad by May 1 cut-off date, Ajit Agarkar and his colleagues have some straightforward choices to make if every member of the team is fit.

"There would not be any experimentation or left-field selections. All those who have played for India and have done well consistently in T20 Internationals and the IPL will be rewarded," a BCCI source told PTI on conditions of anonymity.

It is understood that one among Shubman Gill and Yashasvi Jaiswal might miss out but in case both proven performers are selected in the final 15, then only one among two finishers -- Kolkata Knight Riders' Rinku Singh and Chennai Super Kings' Shivam Dube -- will get the

The other close call could be for the second wicketkeeper's slot where Sanju Samson has competition from Jitesh



Sharma, KL Rahul and Ishan Kishan. Rahul and Kishan bat at the top of the order, and they haven't tried batting in the middle order in this IPL so far, which makes it difficult for the selectors to analyse their impact down the order. Although Hardik Pandya's bowling fit-

ness remains a concern, there is no immediate doubt on his selection. Much like him, Virat Kohli's inclusion is also a for-

The other automatic selections are skipper Rohit Sharma, Suryakumar Yadav, pace spearhead Jasprit Bumrah, Yadav. These 10 names, if fit, will definitely be on the flight across the Atlantic. It is understood that Siraj is being rested by RCB as he has been playing constantly and needed workload manage-

In the choice between Gill and Jaiswal, the former has scored more runs but in case of Jaiswal, who has been a big find for Indian cricket, the selection committee might not give up easily on him merely for a few low IPL scores.

Also, being the only left-hander in inside the top four is a novelty and in a largely unidimensional top order.

However, if Gill piles up enough runs, it will be a difficult choice unless the selectors accommodate both and drop one among Shivam and Rinku from the 15.

The reserve spinner's slot could also be a three-way battle between Axar Patel, a handy batter apart from being an accurate left-arm spinner, Yuzvendra Chahal, who is yet to play a single T20 World Cup match in his nine-year international career, and Ravi Bishnoi, who plays for Lucknow Super Giants.

While Chahal is head and shoulders above the other two in terms of bowling

Ravindra Jadeja, Rishabh Pant, Arshdeep Singh, Mohammed Siraj and Kuldeep portant squads leaves a big question mark about his inclusion showpiece in June.

A former international player, who is also a broadcaster, gave an interesting in-

"The 'Impact Player' rule, which is basically a glorified '12-a-side' cricket contest has been good for IPL viewership but detrimental for Indian cricket. It has killed the concept of all-rounder and hence a half-fit Hardik Pandya also has premium value because he can bowl," he

"Think about it, if there was no Impact Player rule, could MS Dhoni (not Ruturaj Gaikwad) as CSK 'skipper' afford to not bowl Dube? Selectors don't know about Dube's bowling form.

"Similarly, a guy like Rahul Tewatia is no longer in contention despite being a good finisher, who also used to be a handy leg-break bowler. He doesn't bowl now as he is an 'Impact Player'. Who is it hurting? The national team," he pointed

The likes of Riyan Parag, Mayank Yadav, Abhishek Sharma, and Harshit Rana have all performed well but it is understood that the selection committee would like to follow the process of easing

them in via bilateral cricket instead of putting them to test in a high-stakes World T20 game.

There are two white-ball series against Zimbabwe and Sri Lanka and these young men would be in line for their India debuts at that time. Nitish Reddy, who is a seam bowling all-rounder and was part of India Emerging side that toured Sri Lanka last year, could also follow the same path.

Faltering Punjab Kings, **Mumbai Indians** desperate to resurrect IPL campaign



MULLANPUR, April 17: Punjab Kings and Mumbai Indians will be desperate to resurrect their faltering campaigns in the Indian Premier League when the two bottom-rung teams face-off here on Thursday.

Only a few decimal points separate the two teams after six matches each with Punjab's marginally better Net Run Rate of -0.218 keeping them at the seventh spot in the IPL points table, one

above Mumbai Indians (-0.234). Both Punjab and Mumbai have lost four matches each and are coming off defeats in their respective last outings, which mean pressure will be high on both the camps to get their act together.

For Punjab, the challenge of getting the best out of their top order has compounded with regular skipper Dhawan being sidelined for 'seven to 10 days' due to a shoulder injury.

The only bright spot for PBKS this season has been resolute displays from their unsung Indian players Shashank Singh and Ashutosh Sharma, who both bat lower in the order and have had to make up for the shortcomings at the top more than once.

The form of Prabhsimran Singh — 119 runs in six matches at 19.83 — is a concern and the same can be said for India wicketkeeper-batter Jitesh Sharma. With selection for the World Cup squad on the horizon, Jitesh, who has managed a mere 106 runs in six outings at 17.66, would be under the pump

PBKS will have to find more support for their overseas bowling duo of Sam Curran (126 runs and 8 wickets) and Kagiso Rabada (9). The Indian pair of Arshdeep Singh (9) and Harshal Patel (7) have both been easy targets for batters.

Mumbai Indians would know they have enough firepower in the camp to turn the tide but a collective effort on a consistent basis is the need of the hour.

Two wins at home against Delhi Capitals and Royal Challengers Bengaluru did end their threematch losing run, but a loss to Chennai Super Kings despite Rohit Sharma's century meant the fivetime winners have forced them to go back to the drawing board.

It starts with Hardik Pandya's form and role in the side. The allrounder has looked to share responsibility in bowling department but his economy rate of 12 is alarming. On the same parameter, Gerald Coetzee (9) and uncapped Akash Madhwal (4) have given away more than 10 runs an over.

With the bat, Pandya has not provided any consolidation while batting first or finished matches in the latter half.

At the same time, Pandya has faced hostile environments at various stadiums in all the games he has played so far this season, something that could have an adverse impact on a player.

Rohit and Ishan Kishan's form thus become crucial for Mumbai Indians, for whom Suryakumar Yadav has produced mixed results. Teams:

KOLKATA, April 17: Jos Buttler has seen "crazy things" happen in the IPL and he drew inspiration from the likes of Virat Kohli and Mahendra Singh Dhoni to singlehandedly pull off the highest run chase in the tournament's history here.

Buttler smashed an unbeaten 107 off 60 balls as Rajasthan Royals came back from the dead to beat Kolkata Knight Riders by two wickets on Tuesday night. Fittingly, Buttler hit the winning The Englishman was

struggling to even walk towards the end but didn't give up. Chasing a record 224, Royals were 121 for six in the 13th over. "Keep believing, that

KOLKATA, April 17: Sunil Narine opening for Kolkata Knight Riders in this IPL has proved to be a masterstroke and credit for the West Indian's move up the order should go to team mentor Gautam Gambhir, reckons Rinku Singh.

Narine smashed his maiden T20 hundred on Tuesday, a 56-ball 109 against Rajasthan Royals. His form at the top this season has been nothing short of remarkable considering he aggregated just 154 runs over the past three seasons while batting lower down the order.

As an opener this season, he has already collected 276 runs in six games. After scoring a memorable hundred at the Eden Gardens, Narine gave due credit to former captain Gambhir for making him open for the first time since 2017. In the post-match interaction, Rinku echoed Narine's words.

"You can see the way Narine is batting this

time. In every match, he's making runs, opening the batting and that was his (Gambhir's) idea only," Rinku said.

Narine was unleashed as an opener under Gambhir's captaincy in 2017 when he smashed IPL's fastest fifty in 15 balls, a record that was gradually improved by KL Rahul (14), Pat Cummins (14) and Yashasvi Jaiswal (13).

Narine also has a 13-ball 50 for Comilla Victorians in the Bangladesh Premier League in their match against Chattogram Challengers in

Earlier he would just swivel his bat, but this time Narine is seen batting with skill and poise as his stroke-making in the arc has vastly improved. Asked about the transformation, Rinku said: "Nothing much has changed. It's the result of his sheer hard work at the nets.

"I've just noticed one change -- he's more pa-

tient now. Earlier he used to swing his bat to every ball, now he has restrained himself and playing according to the merit of the ball. He is batting thoughtfully and wisely.

But Narine's century went in vain as Jos Buttler (107 not out; 60b) showed his masterclass to single-handedly steer Rajasthan Royals to an eight-wicket win in the final ball of the match.

"It happens sometimes but it won't impact much. Our team is doing very well. We are not thinking much (about the loss). Credit to RR they did well. Also, you need a bit of luck in your favour. It was there day. Buttler innings was the turning point. Full credit goes to him," Rinku said.

With the KKR top-order going strong this time, the finisher Rinku, who was KKR's leading rungetter in IPL 2023 with 474 runs at 59.25, is not getting much opportunities. (PTI)

KOLKATA, April 17: West Indies captain Rovman Powell says efforts are on to convince the in-form Sunil Narine to come out of international retirement for this year's

T20 World Cup but the Kolkata Knight Riders star has so far "blocked everyone" who has tried to talk to him.

Narine, who will turn 36 next month, last played for the West Indies in a T20 International in August 2019 before retiring from international cricket in November last year to focus on franchise T20 leagues around the

But owing to his sensational form with both bat and ball this IPL season, attempts have been made to convince Narine to reverse his decision for the T20 World Cup in the Caribbean and the USA in June.

"For the last 12 months, I've been whispering in his ears, he's blocked out everyone. Asked (Kieron) Pollard, (Dwayne) Bravo, (Nicolas) Pooran, hopefully before they select the team, they can crack his code," Powell said his IPL team Rajasthan Royals notched up a thrilling two-wicket win over Narine's KKR in a record IPL chase of 224.

Narine, who has been a key member of KKR since 2012, struck 109 from 56 balls to set the tone for their imposing 223/6. He is also KKR's frontline spinner and

their leading run-getter this season. With the

rate of 6.87. "It was a very good innings to watch.

Sunil has done extremely well for KKR this season at the top. He's my fellow West Indian and hopefully he can continue doing

"As a West Indian, it's always nice to see your compatriots do well in the IPL," Powell later said at the post-match press conference.

While Rajasthan opener Jos Buttler anchored Royals chase with an unbeaten 107, Powell played a key cameo of 26 from 13 balls (1x4, 3x6).

It came at a time when runs started to dry up, and the 30-year-old Jamaican set the tone, smashing Narine for a four and successive sixes in the 17th over that yielded 16

"I started trying to hit, taking down Sunil as their main bowler and giving the guys that belief that if Sunil Narine can go for runs, then anybody can go for runs and that fuel right through the group," Powell said of the bowler who had not conceded a boundary at the Eden Gardens this season before last

"I told Jos that, 'just relax, I will try to hit

a few sixes' because he was trying to hit the ball and he wasn't connecting. So I will go and try to hit a few sixes and after, if I get out, then you would take on the mantle of trying to score those big sixes.',"he added.

The Windies skipper felt such impactful innings hardly get any mention in today's era of "data and technology"

"In T20 cricket, a lot of persons don't get credit for playing impactful innings. A lot of technology is there that gives data as to innings that guys play, but not a lot of data or technology is there to pick up the impact," he rued.

Buttler overcame a foot injury to be fit in

time for Tuesday's game. "At one point, we thought he would miss more than one game. But the support staff and physio did a lot of work with him, and he only missed one game.

"I've seen 'Universe Boss Chris Gayle' score some really fantastic hundreds and this is definitely in the top five to be honest.

"This is one of the better games to chase, to be on the winning side in a chase of 220 in a T20 game, with a ramp-up crowd, at Eden Gardens leave a special feeling in your mouth," he signed off. (PTI)
