

#### **Will support any** non-BJP govt at Centre unconditionally'

GUWAHATI, April 23: The AIUDF on Tuesday asserted that after the first phase of Lok Sabha elections, it is sensing that the BJP will not be able to retain power, and vowed to extend unconditional support to any non-BJP government at the Centre.

The Badruddin Ajmal-led party released its election manifesto for the Lok Sabha polls, reaffirming its opposition to Citizenship (Amendment) Act and Uniform Civil Code.

Addressing a press conference after releasing the party's elec-tion manifesto, AIUDF legislator Hafiz Rafiqul Islam said, "After the first phase of polling, we are sensing that the BJP will not retain power. We want a non-BJP government in Delhi and we will support it unconditionally."

The party, in its manifesto, said it will pressurise the new government at the Centre to declare recurring Assam floods a national calamity, work for land rights of dwellers of riverine islands and called for equitable development of Barak Valley at par with Brahmaputra Valley. It has fielded its candidates in Dhubri, Nagaon (CONTD. ON PAGE-2)

Himanta pins Rijiju's remark, says no land available GUWAHATI, April 23: The Central government has not discussed anything over the relocation of Chakma and Hajong refugees in Assam, chief minister Himanta Biswa Sarma claimed on Tuesday. His statement comes following Union minister Kiren Rijiju's remarks that there have been talks to relocate these refugees from Arunachal Pradesh to Assam after

the implementation of the Citizenship (Åmendment) Act (CAA). "I don't know what Rijiju has said, but the government of India has not discussed these matters with us. Rijiju might have perhaps said something in view of the political situation in Arunachal

Pradesh," Sarma told reporters on the sidelines of a poll campaign meeting. The CM also maintained that there is no land available to resettle the refugees and added, "No one from Chakma or Hajong communities has met me nor has the government of India discussed it with me. I will speak with Rijiju about the matter after the elections.

Sarma said Assamese people residing in Arunachal Pradesh, numbering about 6,000-7,000, will be given permanent resident certificates by the Assam government. Rijiju, who is seeking re-election to the Lok Sabha from Arunachal Pradesh, had claimed at

Mainstream media blacking out Cong, party using ASDC accuses APHLC of silence social network to connect with people: Shrinate on voter list deletion issue



GUWAHATI, April 23: Congress spokesperson Supriya Shrinate claimed that social media has helped her party to connect with people as mainstream media is "blacking out" the grand old party.

Respecting India's diversity, the party has been creating content in as many regional languages as possireach out to the masses, she said, "The strategy is simple. We mirror exactly what we do on the ground. I don't think social media and politics are two divorced things, they are complimentary to each other."

She said Congress's social media strategy is based broadly on four points "to come out with only the truth and not indulge in fake news, to be fast in reaching out, to keep the narrative decent and related to the issues on the ground, and create the content depending on the platform and audience, with videos taking a priority." Issues are chosen as per the region as relevance varies from place to place, with the party focussing on creating content in as many regional languages as possible, Shrinate claimed.

"We try and do a lot of stuff in vernacular languages. It comes from our deep appreciation of India's diversity," she said, adding "The essence here is that we represent the values we stand for and that we don't believe in imperialism of language or thought," Shrinate added. "Our leadership has a lot of visibility across social media, he (Rahul Gandhi) understands social media well, he speaks to them (people), he does a video from the car and this is relatable these are advantageous for us," Shrinate maintained. On trolls used to discredit rival parties and leaders, she said, "Trolls are a menace. I wish our polity was mature, our political discourse was mature." Shrinate maintained that when taking over her responsibilities in the party's social media cell, she had decided to keep it a place for 'meaningful engagement and has held on to her end (CONTD. NEW DELHI, April 23: Asia heat wave. continued to bear the brunt of

weather, climate and water-related hazards in 2023, making it the world's most disaster-hit region, according to a new report by the World Meteorological Organization.

Floods and storms led to the highest number of reported casualties and economic losses, and the impact of heat waves intensified, said the World Meteorological Organization's (WMO) State of the Climate in Asia - 2023 report.

According to the report, seasurface temperatures in the northwest Pacific Ocean hit record highs, and even the Arctic Ocean experienced a marine

"Many countries in the region experienced their hottest year on record in 2023, along with a barrage of extreme conditions, from droughts and heat waves to floods and storms. Climate change exacerbated the frequency and severity of such events, profoundly impacting societies, economies, and, most importantly, human lives and the environment that we live in," said WMO secretary-general celeste Saulo.

# Ban on MDH, Everest masala India seeks details from food regulators of Singapore, Hong Kong

NEW DELHI, April 23: India, the world's largest producer, consumer and exporter of spices, has sought details from food safety regulators of Singapore and Hong Kong, which has banned certain spices of Indian brands MDH and Everest due to quality concerns.

The commerce ministry has also directed Indian embassies in both Singapore and Hong Kong to send a detailed report on the matter.

The ministry has also sought details from the Indian firms -- MDH and Everest, whose products have been banned for allegedly containing pesticide 'ethylene oxide' beyond permissible limits.

"Details have been sought from the companies. Root cause of the rejection and corrective actions will be determined along with the exporters concerned," a commerce

and Karimganj seats that are going to polls in the second phase on April 26. "We are against the CAA (Citizenship Amendment Act). Assam Accord, which has been accepted by all sections of people of the state, is in force here and the CAA practically negates it. We are fighting the CAA in the Supreme Court as well," Islam said. The party also highlighted its opposition to the NDA government's support for Uniform Civil Code (UCC), he said. "All communities, religions have their own personal laws, customs and the Constitution allows it. Through the UCC, the BJP wants to impose its thoughts. We will never accept that," the MLA added. Islam exuded confidence that the AIUDF will win all the three constituencies it is contesting, pointing out that it had three MPs in the Lok Sabha in 2014, which came down to one in 2019, with Ajmal representing Dhubri. He maintained that the focus of the party's manifesto was comprehensive development of all sections, particularly the religious minorities, and various under-represented communities.

Alleging that the BJP government has been acting in a discriminatory manner against Muslims, he said, "Muslims are not been given land pattas (documents) even though we are citizens and have equal rights. We will conduct survey of land in char (riverine island) areas and give pattas there."

He said AIUDF will also push for similar surveys in non-char areas and allotment of land to landless local communities. Islam also accused the government of discriminating against Bengali-dominated Barak Valley, which has a substantial Muslim population, in southern Assam. "There should be equitable development of Barak and Brahmaputra valleys. The kind of communication network and industrialisation is happening in Brahmaputra Valley should happen in Barak Valley as well," he said.

Barak Valley comprises of three districts of Cachar, Hailakandi and Karimganj, with Silchar being the largest city in the valley. A majority of the state's population, however, live in Brahmaputra Valley and major cities and economic and cultural hubs, including Guwahati, Bongaigaon, Jorhat, Tezpur, Dibrugarh, Sivasagar and Tinsukia, are located in this region. It is populated by Assamese people, both Hindus and Muslims, Bengalispeaking Muslims and Hindus, Bodos, tea tribes and various other communities.

He said the AIUDF will pressurise the new central government to declare the state's flood and erosion problems as "national calamity" and work for permanent solution to these issues. The party's manifesto also highlights its emphasis on issues of tea garden workers, quality education for all and women security, among others, he added. (PTI)

people are in one party in the morning and join another party in the evening and then they criticise your leader and say things left and right. Some of them are favoured with tickets also. "This is a very disturbing trend and people should avoid it. People should work at parties and prove their credentials. If anybody wants to change parties, one should resign from the post given by that party and then only join another party. One can understand making accusations, but what is happening is not accusing but abusing," Naidu said.

He said another unhealthy trend is that people are making promises left and right, without considering where the money will come from, as there is no money. People should also question parties which were clueless on resources, but made empty promises to acquire power, he said.

"Political parties must come out with a manifesto and secondly, should come out with schemes supported by the financial health of the state and third, how they are going to mobilise resources and then spend whatever they want to," the former vice president said. He wondered how it was possible to give everything for free as "money does not come from trees". But then some of the leaders and parties are making promises left and right even when the financial health of the state is weak, he observed. Naidu said even when the financial burden of lakhs of crores of rupees is there on states, everything is being promised for free.

"I am against freebies. I am in favour of two things -- education and health should be given free. Make education and health free, you can avoid all others. They are not doing that," he lamented.

"This sort of promises and freebies should be discouraged and political parties should question how you are going to mobilise resources. Manifesto and resource mobilisation and financial health of the state should be presented to the people," he said. Deploring the steep decline in standards of public life, the former vice president said people were increasingly abusing their political rivals and using vulgar language, rather than indulging in healthy criticism. He described this as an unfortunate development and appealed to the voters to reject such candidates who use vulgar language and are known to be openly corrupt.

Parties should present alternative policies instead of accusing others, he said. Narrating his recent meeting with a religious saint who migrated from Andhra Pradesh to Tamil Nadu, he said though he had Muslim origins he sang Ram bhajans every morning. Observing that culture is a way of living and religion is a way of worship, he said, "Rama is a cultural embodiment of the state, he is not a religious person. Rama is an ideal human being, a great ruler, a great father, and a great son, who led an ideal human life. We must lead a life like him and try to follow his ideals." Naidu said he has maintained high values in politics and recalled how he strove to maintain the dignity and decorum of the Rajya Sabha as its chairman. He advised parliamentarians to debate, discuss, and decide and not disrupt the proceedings of the House. MPs rushing into the Well of the House was not a sign of a healthy democracy, the former Rajya Sabha chairman said.

Naidu reminisced that the highlight of his tenure as Presiding Officer of the Upper House was the introduction and enactment of the Bill on the abrogation of Article 370. "The results are there for all to see. Today, Kashmir is a haven of peace attracting tourists and investment," Naidu remarked. The former Vice President of India observed that the country is on the rise and that several major western powers could not digest this extraordinary growth of our nation. India's development trajectory is unstoppable, he said. "But at the same time, they cannot gnore India and they have to maintain a relationship with India. India can never be ignored in the present situation. "We are the world's largest democracy and we must make efforts to make it the healthiest and ideal democracy, for that all political parties must ensure this," he noted. (PTI)

UP RERA Chairman Sanjay Bhoosreddy took strong objection to the fourth complaint and imposed a cost of ₹ 5,000 on him, according to an official statement. "UP RERA is continuously imparting justice to the large number of allottees who have filed complaints with it, instances of some allottees filing repeated complaints in the same matter and thus misusing the process of law, are also surfacing," it said. The chairman of the NCR bench of UP RERA noticed that the "allottee had not approached RERA with clean hands, that he was misusing the process of law and wasting the precious time of the Bench".

According to the regulator, the first complaint was for possession of the unit and payment of interest for delay. The authority had directed the promoter to provide him possession with registered sub-lease deed and pay the interest for delay istered sub-lease deed and also paid approximately ₹ 2.68 lakh as interest for the delay, it said.

The allottee then filed a second complaint seeking similar relief. That petition was dismissed by the authority on the ground that the matter had been decided previously and relief provided had also accrued to him. "But the allottee filed third complaint before the Adjudicating Officer of RERA seeking compensation. The Adjudicating Officer decided this complaint with order of payment of compensation of ₹50,000. So this allottee had got every relief permissible under RERA fairly and quickly," it said.

However, the allottee filed the fourth complaint seeking relief, which along with the grounds thereof had been considered and adjudicated by the Adjudicating Officer in the order passed earlier. "As if repeated filing of the complaint in the same matter besides having got the admissible relief was not enough, this allottee was also found indulging in inappropriate conduct during the hearing of the case through video conferencing," the UP RERA said. "His conduct was contrary to the rulings of the Supreme Court which has been continuously holding that a litigant must approach the court with clean hands and must not be allowed to misuse the process of law and wasting the time of the court," it added. (PTI)

meteorological hazards struck Asia in 2023, with floods and storms accounting for over 80 per cent of incidents, resulting in more than 2,000 fatalities and affecting nine million people. The annual mean near-surface temperature over Asia in 2023 was the second highest on record, 0.91 degrees Celsius above the 1991-2020 average and 1.87 degrees above the 1961-1990 average. Japan and Kazakhstan each had record warm years.

In India, severe heat waves in April and June resulted in about 110 reported fatalities due to heatstroke. A major and prolonged heat wave affected much of southeast Asia in April and May, extending as far west as Bangladesh and eastern India, and north to southern China, with record-breaking temperatures.

Parts of the Turan Lowland (Turkmenistan, Uzbekistan, Kazakhstan), the Hindu Kush (Afghanistan, Pakistan), the Himalavas, around the Ganges and lower course of the Brahmaputra rivers (India and Bangladesh), the Arakan Mountains (Myanmar) and the lower course of the Mekong river reported below-normal precipitation

Southwest China suffered from a drought, with below-normal precipitation levels nearly every month of 2023, and the rain associated with the Indian summer monsoon was below average.

In June, July and August, several floods and storm events resulted in more than 600 reported deaths across India, Pakistan and Nepal. Heavy rainfall led to flooding in Saudi Arabia, the UAE and Yemen.

In August and early September, the far eastern part of the Russian Federation suffered catastrophic flooding in one of the largest disasters in recent decades, affecting about 40,000 hectares of rural land.

The High-Mountain Asia region is the high-elevation area centered on the Tibetan Plateau and contains the largest volume of ice outside of the polar regions, with glaciers covering an area of around 1,00,000 square kilometres. Over the last several decades, most of these glaciers have been retreating, and at an accelerating rate.

Twenty out of the 22 observed glaciers in the High-Mountain Asia region showed continued mass loss. Recordbreaking high temperatures and dry conditions in the east Himalayas and most of the Tien Shan exacerbated mass loss for most glaciers. During the 2022-2023 period, Urumqi Glacier No 1 in eastern Tien Shan recorded its second highest negative mass balance since measurements began in 1959.

The WMO said warming of the upper-ocean (0-700 metres) is particularly strong in the north-western Arabian Sea, the Philippine Sea and the seas east of Japan, more than three times faster than the global average.

Marine heat waves -- prolonged periods of extreme heat that affect the ocean -- occurred in a large area of the Arctic Ocean, eastern Arabian Sea and the northern Pacific, and lasted three to five months. (PTI)

GUWAHATI, April 23: Congress spokesperson Supriya Shrinate said the party is exploring legal remedies as the Election Commission is not acting on the complaint against Prime Minister Narendra Modi for his "redistribution of wealth" remarks

Shrinate said institutions like the EC need to have complete faith of the people and they should work to restore that trust if it is shaken.

"Prime Minister Narendra Modi made hate speeches in Rajasthan. My colleagues met the EC on Monday and we have pressed charges against him. As they are not acting upon our complaint, we are looking at legal remedies," she told PTI. The Congress on Monday moved the EC seeking "appropriate action" against Modi for his 'redistribution of wealth' remarks at a poll rally in Rajasthan, alleg-

ing that the comments were "divisive", "malicious" and targeted a particular religious community. On Sunday, the Prime Minister

had triggered a political row by claiming that the Congress manifesto promised "redistribution" of wealth after conducting a survey. "We hope that it will be a free

and fair election. But we see little evidence of that," Shrinate said, asserting that the less said about the EC's actions against the BJP, the better.

On the proper functioning of EVMs, Shrinate said, "Even if one person says his or her vote didn't go where it was intended, it is the responsibility of institutions like the EC to restore people's faith." She pointed out that opposition parties have been pressing for 100 per cent VVPAT counting, but the EC has not accepted it. (PTI)

On not accepting khazana for non-registered land, Swargiary said it was to ensure that the government does not validate the occupation of the land without proper verification.

"We cannot allow occupation of government land without due verification of claim over it. If we accept revenue from such occupied land, it will be confirming their right over it. We will verify the occupancy of all such land in due course and then pursue the issue accordingly," he added. (PTI)

he election festival in India has started yet again and with the first phase of the mammoth exercise starting off on 19 April, the political pundits are wondering once again, how the Indian Muslims are going to vote.

If we analyse the election results of the last two general elections, then we realise that at the national level, in the past two national elections Indian Muslims at many places voted strategically, yet a party with just 35% of the vote emerged victorious. However, it should not dis-

This means that if the margins had been reversed, it would have taken its tally down to 263. Of these 40 narrow victories, 11 were versus the Congress party, and six against the Bahujan Samaj Party, Samajwadi Party and Biju Janata Dal. Four were versus the Trinamool Congress, two versus the Rashtriya Lok Dal, and one each against the All India United Democratic Front, Jharkhand Mukti Morcha, Janata Dal (Secular) and an Independent.

Moreover, fourteen of these narrow seat victories were in the crucial state of Uttar Pradesh. Machlishahar in U.P. has the dubious distinction of electing a BJP candidate by just 181 votes in the last elections. Overall, of its 303 seats, BJP won by less than one lakh votes on 77 seats. In view of these facts, firstly, it should be the strategy of the secular political parties and particularly of the Muslim leaders to focus on these crucial seats

The era of candidates' personally visiting voters' homes and engaging in conversations over tea, even after a five-year hiatus, has given way to a more technologically advanced approach.

In the 2014 election, social media played a pivotal role. However, the advent of AI and the potential use of deepfake videos in India's 2024 elections have imparted a new dimension. These videos, capable of blurring the lines between truth and falsehood have the potential to significantly impact the trust and integrity of the electoral process.

time false videos and parodies were used in political campaigning. Parties like BJP, Congress, AAP, DMK, and AIADMK use AI technology to engage with their supporters. For example, the BJP uses AI to translate PM Modi's speeches into eight regional languages. However, some campaigners misuse AI-generated videos, including deepfakes, to spread misinformation. These videos are targeted at the 18-25 age groups and are being shared on platforms like WhatsApp.

used AI in last year's state elections, the first Minister has already issued warnings to social media companies, instilling confidence in the audience about the security and integrity of the electoral process.

The Election Commission must issue clear guidelines to regulate AI-generated information for the 2024 Lok Sabha elections. These guidelines should address ethical AI use in campaigns and voter data analysis. Strict rules are necessary to maintain the integrity of the electoral process, protect voters' rights, and ensure fairness and transparency. With-

In 2019 the share of percentage had gone up by 8 percent on the previous mandate. Modi had used the Pulwama massacre of 40 soldiers and projected it as an attack on Indian nationalism to win the election. Indeed, it was shocking how a sitting Prime Minister could exploit the gruesome incident to arouse passion for pure electoral gains.

Five years since, the Indian voters have come see through the 2019 game. Hence, Modi's latest attempts to evoke nationalism have failed to yield the desired result. The increasing distrust towards Modi in the Indian people could also be made out from the fact that more people have voted this time than they had voted in 2014 to install Modi as the prime minister. Is the new percentage a reflection of a resolute determination to bring in a new face replacing Modi?

There's little trust in EVMs. Voters nurse the feeling that even if they push the button for some other political party, eventually it would go to the BJP tally. This has resulted in democratic disenchantment, thinking it is futile to take pains to go to the polling booth and cast one's vote.

Usually, the Lok Sabha elections are held during the hot and humid summer. This time too it is not exception. However, voters beat the heat and come out to register the democratic mandate. Blaming the hot summer for the 4 per cent people drop in phase one polling percentage is a poor excuse to hide the poor response and peoples' anger against Modi.

The first phase of voting in Lok Sabha elections usually sets the tone for subsequent phases. In 2019, phase 1 recorded the highest turnout, at 69.5 per cent. Similarly, the first phase of the nine-phase 2014 parliamentary polls was among the highest, at around 69 per cent. The vote percentage has sharply declined, that too in the backdrop of Modi projecting his so-called achievements and concern for the poor. Decline of the percentage of votes implies that people have refrained from endorsing his claims.

In the Assembly elections, voter turnouts have been high. In panchayat polls, it even reaches 95 percent. But in Lok Sabha elections, it went down to around 62 per cent. A senior EC official admits: "summer is not the sole factor." In Bihar, too, the State Electoral Officer H R Srinivas said: "We cannot narrow it down to one factor. There could be some latent reasons.<sup>3</sup>

Was Modi unaware of the change in the mood of the people? For him, the basic issues, such as unemployment, poverty and inflation, did not matter. Though economists challenged the narrative of NITI Aayog on joblessness and poverty, PM Modi never bothered to take them seriously. His repeated shielding of the scam-tainted corporates and accepting all the anti-people corrupt politicians into the BJP-NDA fold has been disliked by the people, in popular parlance derided as "BJP washing machine". Regrettably, Modi continues to blame the Nehru-Gandhi family and Congress as the patrons of the corrupt politicians

The RSS and BJP had claimed that demolition of

scholarships for the underprivileged and minorities are being discontinued.

In the first phase of polling in 2019, the turnout was around 70 per cent. But this time the overall voter turnout in 102 constituencies in 21 states and Union Territories was recorded at 62.37 per cent till 9 pm, with the highest percentage in Tripura at 80.17 per cent. The downturn was around 7 per cent. In 2019, the voting percentage shift to 70 percent was only due to the active participation of the youths.

An insight into the present averseness would make it clear that they are no more willing to be treated as mere ballots, numerical voters by Modi, who trampled on both the education system as well as caused unprecedented 45-year-high unemployment crisis.

The worst victims of Modi's discrimination have been the Dalit and Muslim students and youths. Modi must do some introspection why are the youngest eligible voters remain hesitant to exercise their franchise? Election Commission has called upon the young people to get registered as voters. But ironically, only 38 per cent of the voters between the age of 18 and 19 have registered for the 2024 elections across the country.

It is usually said that participation in elections is a key freedom. Non-participation in the electoral process will create trouble as democracy will not realise its potential. Ironically, these young voters are witness to the trampling of democracy and its ethos by the RSS and BJP government led by Modi.

There is the need for sounding a word of caution at this stage. Modi is not the person to accept defeat lying down. Still six rounds are left and he would certainly like to mould the electoral proceedings in his favour. There is little doubt that he would go to any extent to subvert and rig the election.

Already, PM has turned the pitch divisive while addressing an election rally in Rajasthan, saying: "if the Congress comes to power, it would redistribute wealth of people to Muslims". To justify himself, he cited former PM Manmohan Singh's remark that the minority community had the first claim on the country's resources. Modi said: "This urban-naxal mindset, my mothers and sisters, they will not even leave your 'Mangalsutra'. They can go to that level."

In fact, Dr. Singh had said that the poor, OBCs, people from weaker section and minorities would have the first claim. Modi must know that Muslims are not only the minorities. There are Sikh, Christian, Parsis and others. Congress spokesperson Pawan Khera has also challenged Modi to withdraw his remark on Congress manifesto.

Modi had said: "The Congress manifesto says they will calculate the gold with mothers and sisters, get information about it and then distribute that property. They will distribute it to whom - Manmohan Singh's government had said that Muslims have the first right on the country's assets."Expectedly, Modi was trying to ignite communal passions, with an ever compliant Election Commission looking away. (IPA Service)

In Tamil Nadu, the DMK and AIADMK parties used recordings of their deceased leaders for voter support in this election. One video shows Asaduddin Owaisi, the leader of the AIMIM party, singing Hindu devotional songs. Regional leaders like Akhilesh Yadav, Naveen Patnaik, and Mamata Banerjee also applied similar tools to influence voters.

The use of AI for malicious purposes is a significant concern. With advanced AI, it has become possible to impersonate anyone, including voters or candidates, which can lead to identity theft and manipulation of the electoral process. This underscores the need for clear regulations to ensure a fair and transparent electoral process, making the audience more aware of the potential risks and the importance of addressing them, fostering a sense of vigilance.

The use of AI in political campaigns raises valid concerns about privacy and the potential for unfair competition and misinformation. Governments must take the lead in regulating AI use to promote fairness. The IT *ice*)

t is irrefutable fact that women are not getting their dues in India, though we have been hearing PM Narendra Modi's big talks of women welfare under his premiership. Now in a bid to attract women voters he has assuring a new chapter in rise of women power in his third term.

In all BJP's election campaigns, it is being claimed that there is a wave of women-led development. All the claims are deceptive since these conceal the reality. For example, they claimed women empowerment through MGNREGS and said that 56 per cent of participants in the scheme were women in FY23. It should be noted, that MGNREGS is a rural employment guarantee scheme under which people ask for work when they are not getting remunerative jobs anywhere else, and accept the meagre minimum wage fixed by the Union Government.

The lowest minimum Rs 221 was being paid in some states. Due to election, some increases have been announced by Modi government and now the minimum is only ₹237.

Therefore, this can't be termed as empowerment of workforce, but only a minimum help to make their poverty little tolerable. As for women are concerned their high level of asking for MGNREGS work, it is due to they are getting less work elsewhere compared to males.

One of the claims was that between 2015-2022, over 59 lakh women have been trained under the PM Kaushal Vikas Yojna (PMKVY) and 12.51 lakh women candidates gained employment. This is pittance, on account of total population of women in the country which is over 70 crore.

Many more claims are being made about women's welfare, and now BJP manifesto has included Modi's Guarantee for women which included - Expansion Lakhpati Didi self-help initiative for rural women; integrating women self-help groups into the service sector and enhance their market access; developing women hostels and crèches to boost their participation in the workforce, building more toilets for women in public places; expanding health services focused on prevention and reduction of breast cancer, cervical cancer; implementing the Nari Shakti Vandan Adhiniyam to ensure higher representation for women in Parliament and state legislatures; and expanding Shakti desks in police stations and strengthen emergency response systems.

It has been claimed that there is a wave of women led-development in the country under PM Narendra Modi, and it was claimed that female labour force participation was increased from 23.3 per cent in 2017-18 to 37 per cent in 2022-23. PM Modi claims all sorts of things under "Sashakt Nari - Vikasit Bharat" programme, quoting the increased female participation rate in 2022-23.

Such claims conceal the reality that India's female labour force participation ment of the country.

Let us see an example of Accredited Social Health Activists (ASHA). They are key essential workers but several international reports had criticised India that does not even care for these key workers, and not even recognise as key workers.

The latest reference has been made by World Employment and Social Outlook (WESO) 2023 of the International Labour Organisation (ILO) and recorded their plight. It should be noted that the WHO in 2022 had awarded ASHA the title of Global Health Leaders, but India not even recognised them as employees. The WESO 2023 has said that the plight of ASHAs is of particular concern.

ASHAs perform important roles and have positive impact on communities and localities. Wherever they work, immunization rates are higher and mortality rates declines. During the COVID-19 pandemic, ASHA workers raised awareness about the virus and safety protocols, tracked positive cases and assisted with vaccinations in addition to their usual responsibilities of providing maternal care, immunization for children and community healthcare. It was due to this in 2022 WHO awarded them the title of Global Health Leaders.

It should be shocking to know that ASHAs were not given status of workers, though they are appointed and trained by National Rural Health Mission. Workers are selected among women in the community, aged 25-45, with completed secondary studies.

WESO 2023 made a sad commentary that even though ASHAs were appointed by the government they were not recognised as employees and were only paid "incentives" that were linked to achieving certain targets.

Following protests by these workers several states introduced a fixed wage component and the central government also increased the incentives that it contributes.

WESO 2023 said that many of the ASHAs reported that they sometimes paid for transportation costs of the patients they bring to hospitals. So even the little money they made, a share of that sometimes spent on job-related costs, the report said.

Furthermore, the report said, ASHA workers reported that they received their payments with delays. They face other occupational challenges besides low and delayed payments. One of them is a heavy work-load.

Asha workers have been agitating across the country, but Modi government is yet to give them status of "Workers" with full benefits as per law. As recent as in February 2024. which according to the World Health Organization is "any sexual act, attempt to obtain a sexual act, or other act directed against a person's sexuality using coercion, by any person regardless of their relationship to the victim, in any setting. It includes rape, defined as the physically forced or otherwise coerced penetration of the vulva or anus with a penis, other body part or object, attempted rape, unwanted sexual touching and other non-contact forms.

According to a report published in 2019, every 16 minutes, a woman encounters sexual violence in India with a national average of 4.9 per 100000 population. This suggests a severe state of sexual violence against women in India, requiring an urgent analysis of the root causes

#### Reasons behind the sexual violence against women in India:

1. Patriarchal nature of Indian Society: Patriarchy is a social norm that believes in a social hierarchy of men over women. Patriarchal values for centuries have immensely motivated the Indian social society that women are inferior to men and hence men are protectors of women and women should abide by them. society often pursues violence against women only if it is done by unknown men.

However, the reality is contrasting. NCRB report suggests, that most of the violence against women is committed by near relatives or most of the time by their husbands. The inherent nature of patriarchy kills 50000 infant girls and fetuses in their prenatal stage each year, believing that women are the burden of the family and if they grow up they are required to give them marriage and dowry.

Otherwise looking, if a male is born, he will generate income for the family. The very nexus of patriarchal understanding of society made it possible that women are only a sexual asset and they are not entitled to go outside and should only raise babies inside the home and should work at home only.

2. Caste structure: One of the major underrated reasons behind the sexual violence committed against women is the caste system. Oftentimes, people from the dominant caste group attack women of lower caste groups with a preoccupation to teach them a lesson that they are inferior and should remain within the confined diktas of the caste system.

The infamous 2020 Hatras Gang rape case is one such case, where a perpetrator from the upper caste targets the women of other groups to teach a lesson to the entire lower caste community. NFHS data suggests that sexual violence against the STs at 7.8%, SCs at 7.3%, OBCs at 5.4 and General at 4.5%

3. Poor economic conditions of women: The GBV is fundamentally associated with the income of the family. It is being reported that women from economically stable families face a lower rate of sexual or GBV against women compared to poor families.

Women in high-income families are mostly associated with some kind of work and are economically self-depended unlike the women from poor families where women are assigned to housework and male members are entitled to earn for the family.

lence against women:

There have been various initiatives or laws by the Government of India to reduce the number of sexual violence against women. Following are some laws that are intended to reduce sexual violence against women in India:

1. Section 498Å of the Indian Penal Code: The section provides 'Whoever, being the husband or the relative of the husband of a woman, subjects such woman to cruelty shall be punished with imprisonment for a term which may extend to three years and shall also be liable to fine'. The word cruelty refers to the conduct of the husband which forces the wife to take any path of suicide or self-harm or forces women to meet any unlawful demand of any property or value assets.

2. Protection of Women from Domestic Violence Act, 2005: This section was incorporated into the Indian legal system in 1983. It provides safety and protection to the wife or female live-in-partner from the violence of their husband and their live-in-male-partner and gives legal remedies. The act is not only limited to the wife but also extends to the children of the family.

3. Prevention of sexual harassment at workplaces: Following the guidelines of the Vishaka judgement, the Government of India in 2013 introduced the POSH act to prevent sexual harassment at workplaces. The act aims to create a safe and conducive work environment for women and to give protection against sexual harassment.

The act defines the 'workplace' and went ahead to include space beyond traditional of-

ganisations across sectors even non-traditional work places (for example, telecommuting) and places visited by employees for work. To ensure that women are safe in their workplaces, the act provides the composition of an

Complaints Committee' to act on the prevention of sexual harassment.

Apart from the above laws, there have been other laws that also deal with the protection of women from gender-based and sexual violence. e.g. IPC Section 376, 363-373,303,304B, 354, 509,Sati Prevention Act, 1987, Dowry Prohibition Act, 1961 and Indecent Representation of Women (Prohibition) Act 1986 etc.

Challenges and Gaps in the implementation of these laws:

As mentioned previously, the Government of India with a good intention introduced these laws to eradicate sexual, gender-based violence against women. However, there have been lapses in implementing these laws on the ground. Some of the major problems that challenge the implementations are as follows: 1. Lack of proper implementation framework: No wonder the Central Government has introduced laws like Srction498 and PWDVA act but when it comes to implementation, it is up to the state subject and here the problem arises. State police departments lack trained police officers who can investigate and gather evidence for sexual violence. Further, according to a report by the Washington Post, India has the lowest number of

Similarly, when it comes to the implementation of of 'Internal Complaints Committee' in offices of the concerned organization, many organizations don't create such a committee. It is required to ensure that every organization implements the provisions to eradicate sexual violence.

2. Lack of awareness: Laws are the first step to eradicating ills from society and of course, laws like Section 498A, POSH Act and the Protection of Women from Domestic Violence Act do the same. It creates a fear of imprisonment among the perpetrators and forbids them to do violence against women.

However, different reports highlight that the masses in India are still unaware of the rights and legal remedies that these laws provide. Therefore, it is required to spread awareness about the laws for the prevention of sexual violence against women.

3. Lengthy court procedure: Oftentimes, when cases are filed against gender-based, sexual violence, it takes a longer period of time to give justice to victims. Sometimes, judges are patriarchal and biased and they propose a compromise between the parties instead of delivering justice to the victim.

The conviction rate of rapists is very law that it stands at 25%. Further, India has only 15 judges against a 1 million population compared to China with 159 judges. Additionally, there is no special court system to address sexual and gender-based cases.

There are other gaps as well when addressing sexual violence. The non-reporting of cases by victims, and inadequate financial and

manpower support from legal and administrasystems made it complex for victims to get justice.

Measures to address genderbased sexual violence against women:

1. Sensitisation of the issue is the need of the hour. Often a times perpetrators unknowingly assault women for sexual

interests believing women with Western dresses are open for sexual interections. Further families with patriarchal norms constrained women to not report to the police to prevent the loss of honour in society. With sensitization of the issues number of the sexual violence could be reduced.

2. Education and awareness could reduce the GBV against women. It's a common belief that sexual violence is only committed by uneducated men but the reality is different. Often a time sexual violence against women occurs at workplaces where male seniors commit sexual assault against their women counterparts. Therefore, educating people through introducing gender sensitization in schools and colleges could reduce the numbers.

They often lack basic evidence-gathering skills and most of the times denies writing FIRs.

As written above India lacks the required number of female police officers in police departments and trained police officers, It is time to relook into the particular domain of interventions like an increase of dedicated female police to report sexual violence and reforms to introduce special court systems to deal with sexual violence to reduce the burden from the general courts. # Russian strike on Kharkiv's TV tower is part of an intimidation campaign, Zelenskyy says

KYIV, April 23: Ukrainian President Volodymyr Zelenskyy said a Russian missile strike that smashed a television tower in Kharkiv was part of the Kremlin's ongoing effort to intimidate Ukraine's second-largest city, which in recent weeks has come under increasingly frequent attack. The strike sought to "make the terror visible to the whole city and to try to limit Kharkiy's connection and access to information," Zelenskyy said in a Monday evening address.

The northeastern Kharkiv region straddles the approximately 1,000-km (600-mile) front line where Ukrainian and Russian forces have been locked in battle for more than two years since Moscow's full-scale invasion of Ukraine. The front line has changed little during a war of attrition, focused mostly on artillery, drones and trenches

Since late March, Russia has stepped up the pressure on Kharkiv, apparently aiming to exploit Ukraine's shortage of air defense systems. It has pounded the local power grid and hit apartment blocks. On Monday, a Russian Kh-59 missile struck Kharkiv's 250-metre (820-foot) -high TV tower, breaking it roughly in half and halting transmissions. A Washington think tank said Russia may be eyeing a ground assault on Kharkiv.

"The Kremlin is conducting a concerted air and information operation to destroy Kharkiv City, convince Ukrainians to flee, and internally displace millions of Ukrainians ahead of a possible future Russian offensive operation against the city or elsewhere in Ukraine." the Institute for the Study of War said in an assessment.

The expected arrival in Ukraine in coming weeks of new military aid from its Western partners possibly has prompted Russia to escalate its



attacks before the help arrives, the ISW said, adding that trying to capture Kharkiv would be "a significant challenge" for the Kremlin's forces.

Instead, the Russian military command "may attempt to destroy Kharkiv City with air, missile, and drone strikes and prompt a large-scale internal displacement of Ukrainian civilians," it said.

The US Senate was returning to Washington on Tuesday to vote on \$61 billion in war aid to Ukraine after months of delays. Zelensky said US President Joe Biden assured him the aid would include long-range and artillery capabilities.

"Four priorities are key: defense of the sky, modern artillery, long-range capacity, and to ensure that packages of American aid arrive as soon as possible," Zelenskyy said.

Also Tuesday, Britain pledged 500 million pounds (\$620 million, 580 million euros) in new military supplies for Ukraine, including 400 vehicles, 60 boats, 1,600 munitions and 4 million rounds of ammunition.

The shipment will also include British Storm Shadow long-range missiles, which have a range of about 150 miles (240 km) and have proven effective at hitting Russian targets, the British government said. British Prime Minister Rishi Sunak spoke with Zelenskyy on Tuesday morning to confirm the new assistance. He was due to announce the aid later Tuesday during a visit to Warsaw where he was meeting with Polish Prime Minister Donald Tusk and NATO Secretary General Jens Stoltenberg. Less cheering news came from the European Union, however. EU countries that have Patriot air defence systems gave no clear sign Monday that they might be willing to send them to Ukraine, which is desperately seeking at least seven of the missile batteries.

Ukraine's army is also heavily outnumbered in the fight, and expanding the country's mobilisation has been a delicate issue. Ukrainian Foreign Minister Dmytro Kuleba on Tuesday signalled that authorities plan to clamp down on young men of conscription age who have moved abroad, with details of the specific measures to be made public soon. "Staying abroad does not relieve a citizen of his or her duties to the homeland," Kuleba said on the social media platform X.

Meanwhile, Russia launched 16 Shahed drones and two Iskander-M ballistic missiles over Ukraine's southern and central regions, the Ukrainian air force said Tuesday morning. It said all but one of the drones were intercepted.

In Odesa, a residential building was hit during the overnight attack, injuring nine people, regional Governor Oleh Kiper said on Telegram on Tuesday. Among those injured were two infants and two children aged nine and 12, Kiper said.

## UK pledges \$620 million in 2 Malaysian military helicopters new military aid for Ukraine

WARSAW, April 23: The U.K. on Tuesday pledged an additional \$620 million in new military supplies for Ukraine, including long-range missiles and four millions rounds of ammunition, at a time when Ukraine is struggling to hold off advancing Russian forces on the eastern front line of the war, now in its third year.

British Prime Minister Rishi Sunak spoke with Ukraine's President Volodymyr Zelenskyy on Tuesday morning to confirm the assistance and "assure him of the U.K.'s steadfast support for Ukraine's defense against Rusbrutal and expansionist sia's ambitions," Sunak's office said.

Sunak was traveling to Warsaw later Tuesday to meet with Polish Prime Minister Donald Tusk and NATO Secretary General Jens Stoltenberg for talks about further aid for Ukraine.

Ahead of the visit the U.K. government said Sunak would announce 500 million pounds (\$620 million, 580 million euros) in new British military supplies, including 400 vehicles, 60 boats, 1,600 munitions and 4 million rounds of ammunition. The shipment will inmissiles, which have a range of some 150 miles and have proved effective at hitting Russian targets.

"President Zelenskyy thanked the Prime Minister for the U.K.'s continued support, saying the new military assistance would make a material difference to ordinary Ukrainians fighting on the front line to defend their country," Downing Street said.

The announcement comes three days after the U.S. House of Representatives approved \$61 billion in aid for Ukraine, as American lawmakers raced to deliver a fresh round of U.S. support to the wartorn ally

However, Downing Street did not indicate whether the aid would be immediately available for delivery. Zelenskyy has repeatedly pleaded for greater international assistance, warning that his country will lose the war without it. Ammunition shortages linked to the aid holdup over the past six months

have led Ukrainian military commanders to ration shells, a disadvantage that Russia seized on this year — taking the city of Avdiivka and currently inching towards the town of Chasiv Yar, also in

KUALA LUMPUR, April 23: Two Malaysian military helicopters collided midair and crashed during a training session on Tues-

day, killing all 10 people on board, the navy said. The helicopters were rehearsing at a naval base in northern Perak state for the navy's 90th anniversary celebration next month when the accident occurred, the navy said in a brief statement.

"All victims were confirmed dead on site," it said, adding that the remains have been sent to the hospital to be identified.

A video circulating on social media showed several helicopters flying low in a formation. One of the aircraft veered sideways and clipped the rotor of another helicopter, causing both to plunge and crash. A local police officer who declined to be named because he isn't authorised to speak to the media confirmed that the video footage is genuine. The choppers were mangled beyond recognition. Rescue workers sifted through the debris to find the bodies. The victims included three women and seven men, police said.

Prime Minister Anwar Ibrahim said the nation mourned over the "heart and soul-wrenching tragedy" and that the navy will immediately carry out an investigation to determine what caused the accident. Seven crew members were aboard the AW139 maritime operation helicopter, the navy said. That aircraft is produced by AgustaWestland, which is a subsidiary of the Italian defense contractor Leonardo. Three other crew members were on a Fennec lightweight helicopter, manufactured by European multinational defense conglomerate Airbus. Local media reported that the AW139 crashed at a sports complex at the naval base, while the

# Tensions between Beijing and Washington are the biggest worry for US companies in China, report says

BEIJING, April 23: Simmering tensions between Beijing and Washington remain the top worry for American companies operating in China, according to a report by the American Chamber of Commerce in China released Tuesday.

The survey of US companies said inconsistent and unclear policies and enforcement, rising labour costs and data security issues were other top concerns. It also said that, despite the insistence of Chinese leaders that Beijing welcomes foreign businesses, many still are hindered from free competition.

"The Chinese government has stated that it encourages foreign direct investment, but many of our members continue to encounter barriers to investment and operations including policies that discriminate against them and public relations campaigns that create suspicion of foreigners," the report said.

The report welcomed an improvement in relations in 2023 that was capped by summit meetings of Chinese leader Xi Jinping and President Joe Biden, but said the US presidential election in November was "looming large" over the future business environment.

More recently, US Treasury Secretary Janet Yellen visited Beijing, where she raised concerns that potential overcapacity in Chinese industries — such as electric vehicles, steel making and solar panels - might crowd out US and other foreign manufacturers.

"We recognise that there are significant areas of contention in the US-China relationship, many of which have no easy or short-term prospects for resolution," it said.

The report said the Chamber saw high-level exchanges and communication between the two sides as a top priority. American companies operating in China saw improved profits last year, though slightly less than half expect to be profitable in 2024. Still, many members of the American Chamber said they were more optimistic about growth of China's own economy.

Among its many recommendations the report urged China to create and implement "transparent and practical economic policies which treat domestic and foreign entities equally."Referring to concerns over the risk of



being caught up in accusations they have violated China's national security, it also appealed to China's leaders to clarify and narrow the scope of the country's anti-espionage law to prevent it from interfering with normal business operations.

Such requests follow repeated raids on foreign companies that Chinese authorities say were conducted on national security grounds. The report also had recommendations for the US side, including providing clear visa policies for Chinese students to show they will be welcomed. Similarly, American students should be encouraged to study in China, the report said.

It also called on US officials to avoid resorting to unilateral controls that may be ineffective and fail to meet goals for national security and foreign policy. Washington should engage with Chinese companies to allow them to address export control concerns such as military use of civilian technologies before the companies are subjected to sanctions, it said.

The 617-page bilingual report provided hundreds of recommendations spanning a wide variety of industries, from sports and online streaming to occupational safety issues and rural traffic management.

American companies generally are not planning to move supply chains out of China given how large and important it is as a market of 1.4 billion people. But their willingness to increase investments there and make it their strategic focus has been decreasing as its advantages diminish, the report said. (AP)

#### German EU lawmaker's aide is arrested on suspicion of spying for China

BERLIN, April 23: A man who works for a German lawmaker in the European Parliament has been arrested on suspicion of spying for China, German prosecutors said on Tuesday.

The detention came less than 24 hours after three people were arrested for spying for China in a separate German case. The suspect, identified only as Jian G in line with German privacy rules, was arrested Monday in the eastern German city of Dresden, federal prosecutors said in a statement. They said that he has worked for a German lawmaker in the European Union's legislature since 2019.

The statement didn't specify which lawmaker employed him, but German news agency dpa reported, citing unidentified security sources, that he works for Maximilian Krah of the far-right party Alternative for Germany. Other German media also aters and air linked the suspect to Krah, who is the space around party's top candidate in the European Parliament election in early June. MALE, April 23: Armed with a 'super majority' in the parliamentary polls, Maldives President Mohamed Muizzu has said the international community will now understand where the Maldi-

vians stand, especially on the issue of sovereignty and freedom.

The pro-China Maldivian president's statement came at a celebratory event on Monday, a day after the People's National Congress (PNC), led by him, won 68

## Human rights groups condemn UK plan to send asylum-seekers to Rwanda after Parliament backs new law

LONDON, April 23: Britain's plans to send some asylum-seekers to Rwanda were swiftly condemned by international humanitarian organisations after Parliament approved legislation allowing the deportation flights to begin later this year.

Both the UN refugee agency and the Council of Europe on Tuesday called for the UK to rethink its plans because of concerns that the legislation undermines human rights protections and fears that it will damage international cooperation on tackling the global migrant crisis

"The new legislation marks a further step away from the UK's long tradition of providing refuge to those in need, in breach of the Refugee Convention." UN High Commissioner for Refugees Filippo Grandi said in a statement. "Protecting refugees requires all countries – not just those neighbouring crisis zones - to uphold their obligations."

The statement came just hours after Britain's House of Lords dropped its at-



tempts to amend the legislation, paving the way for it to become law. On Monday, Prime Minister Rishi Sunak said deportation flights to Rwanda would begin in 10-12 weeks.

Michael O'Flaherty, the Council of Europe's commissioner for human rights, criticised the legislation for preventing asylum-seekers from asking the courts to intervene when they are threatened with being sent back to the countries they are fleeing.

"The adoption of the Safety of Rwanda (Asylum and Immigration) Bill by the UK Parliament raises major issues about the human rights of asylum

seekers and the rule of law more generally," O'Flaherty said in a statement. "The United Kingdom government should refrain from removing people under the Rwanda policy and reverse the bill's effective infringement of judicial independence.'

The reaction came as French media reported that at least five people died Tuesday when a boat carrying about 100 or more migrants got into trouble while trying to cross the English Channel.

Sunak's government says its deportation plans will help stop the tide of people entering Britain illegally because migrants won't make the risky crossing in leaky inflatable boats if they know there is a chance they will be sent on one-way ticket to Rwanda.

Small boat crossings are a potent political issue in Britain, where they are seen as evidence of the government's failure to control immigration

Sunak has made his plan to "stop the boats" a key campaign promise with his

Conservative Party trailing badly in opinion polls ahead of a general election later this year.

The number of migrants arriving in Britain on small boats soared to 45,774 in 2022 from just 299 four years earlier as people fleeing war, famine and economic hardship paid criminal gangs thousands of pounds to ferry them

across the channel. Small boat arrivals dropped to 29,437 last year as the government cracked down on people smugglers and reached an agreement to return Albanians to their home country. Former Prime Minister Boris John-

son first proposed the Rwanda plan more than two years ago, when he reached an agreement with the East African nation to accept some asylumseekers in return for millions of pounds (dollars) in aid. Implementation has been held up by a series of court challenges and opposition from migrant advocates who say it violates international law. (AP)

#### SEOUL, April 23: A South Korean man has been sentenced to 14 months in prison for killing 76 cats in one of the country's most gruesome cases of animal cruelty in recent

years. The man, who is in his 20s, was convicted of violating South Korea's animal protecedly tion law last week, the Changwon District Court in southeastern South Korea said on Tuesday. The court did not identify the man.

The man went on a catkilling spree between December 2022 and September 2023 due to a deep hatred of the animal that he began harboring after other cats scratched his car, according to a court verdict seen by The Associated Press

the extension of ST privileges to the majority Meiteis. Furthermore, the US state department report on human rights evaluation highlighted 'attacks' on

minorities, journalists and dissentng voices across India. The US state department report also alleged that there were "numerous instances" where the government and its supporters purportedly exerted pressure or the government to harassment. In its assessment, the US further asserted that "religious minorities" in India have reported instances of discrimination, including calls for violence and the dissemination of misinformation.

Senior US official Robert S Gilchrist emphasizes the importance of upholding human rights obligations, urging the Indian government to engage with civil society representatives and address their concerns effectively.

"We strongly encourage, urge India to uphold its human rights obligations and commitments," stated Robert S Gilchrist, senior official from the US bureau of democracy, human rights and labour.

Gilchrist added: "We also regularly meet with civil society representatives both in the US and India to hear their perspectives, and those sorts of perspectives inform the human rights report, and we encourage the government of India to consult and meet regularly with civil society organisations represubjected media outlets critical of senting a diversity of people.'

The trade body has announced that all shops and business establishments will remain closed from April 26 onwards until the grievances of the business community in Dimapur city of Nagaland are addressed.

The DCCI alleged that NPGs have resorted to various tactics to extort from the business community, including bringing their own Maximum Retail Price (MRP) sticker machines to implicate shop owners and planting illegal substances in shops to tarnish their reputations. The DCCI claims that NPGs then summon



shopkeepers, penalize them with hefty fines. and confiscate CCTV/DVR installations to conceal their actions.

Expressing frustration over "harassment by NPGs", the DCCI highlighted a recent incident where a businessman was brutally assaulted money The trade body laments that the hostile busi-

ness environment in Dimapur city of Nagaland led many businesses to relocate to neighbouring towns in Assam where operating costs are lower.

The DCCI called on the Nagaland government and law enforcement agencies to intervene promptly to protect the business community from further harm, emphasizing that the situation cannot be ignored any longer.

It also advised business owners not to entertain any calls or summons from NPGs without the DCCI's knowledge and urges them to refrain from storing customers' belongings for safety reasons.

DCCI further appealed to civil society organizations and the public to support the indefinite shutter down call.

# Kejriwal given insulin in Tihar after spike in sugar level; AAP gives credit to Lord Hanuman



NEW DELHI, April 23: Delhi Chief Minister Arvind Kejriwal was administered a "low dose" of insulin after his blood sugar level spiked, officials of Tihar jail said on Tuesday, with the AAP commenting that it was because of the blessings of Lord Hanuman.

Tuesday is being celebrated as Hanuman Janmotsav, the Lord's birthday.

According to a Tihar official, Kejriwal was given two units of low dose insulin on Monday evening on the advice of the AIIMS doctors.

His blood sugar level reading was found to be 217 around 7 pm, following which the doctors at the Tihar looking after him decided to give him the insulin dose, the official said.

The AIIMS specialists, during a video conference with the chief minister on April 20, had advised the Tihar doctors that insulin could be given to him if his sugar level crosses a certain level, he added.

Delhi Cabinet minister Saurabh Bharadwaj participated in an event in his constituency to celebrate Hanuman Jayanti. A person dressed as Lord Hanuman was carrying vials of insulin with Bharadwaj carrying a mace ('gadaa') as they travelled in the area atop a vehicle. Vials of insulin were stuck on the mace.

"Hanumanji has given insulin to his devotee Arvind Kejriwal. The court passed the order, the jail denied, but due to Hanumanji, Kejriwal got the insulin. We pray for his good health, long life, and may he soon be released," he told PTI Videos.

Earlier in the day, Bharadwaj alleged that the officials were deliberately not giving insulin to Kejriwal.

"Today it became clear that the chief minister was right. He needed insulin but the officials under the BJP-led Centre were de-

liberately not treating him. Tell me BJP people! If there was no need for insulin, why are they giving it now? Because the whole world is cursing them," he said in a post on X in Hindi

Kejriwal's wife Sunita Kejriwal visited the temple to offer prayers on the occasion of Hanuman Javanti

"May Hanuman Baba give wisdom and prosperity to all. May Hanuman Baba take away everyone's trouble and mine too. I will come back with sir (Kejriwal) soon," she told reporters.

AAP Rajya Sabha MP Sanjay Singh echoed similar views and said it was due to the blessings of Lord Hanuman that the chief minister was given insulin after nearly 23 days of being lodged in jail. He alleged ill-treatment with the party's national convener.

"It is due to the blessings of Lord Hanuman that Kejriwal was given insulin after 23 days. We had been saying that he needs to be given insulin but he was given insulin only now. The people of Delhi were worried about him but their struggle bore fruit," Singh said



KANNUR (KERALA), April 23: Kerala Chief Minister Pinarayi Vijayan on Tuesday said the INDIA bloc was not a front, but a system of opposition political parties that has come up as a platform against the ruling BJP at the Centre. "According to the incriminating evidence, Bharath Reddy mobilised approximately ₹ 42 crore in cash over a few months, just before the assembly elections, utilising the funds for unlawful transactions," the ED had claimed.

The agency, sources told PTI, recently wrote to the EC stating that out of the ₹ 42.07 crore fund, a "significant portion" was allocated for cash distribution to voters and other election-related expenses, including alleged payments made for securing party tickets.

It shared details with the Commission stating that documents seized during the searches show a "detailed account of cash collection for distribution to voters in exchange for their votes, implicating Nara Bharath Reddy in a scheme aimed at influencing voters during the 2023 Karnataka legislative assembly elections.

An email sent to Nara Bharath Reddy did not elicit a response on these charges made against him. The ED informed the poll panel claiming that the 34-year-old MLA has "failed to disclose his election-related expenditure to the Election Commission and failed to account for the source of the substantial funds expended during the elections.' The agency has sought action against the legislator from the poll panel, saying these alleged actions constitute a "violation" of the Representation of the People Act, including bribery, corrupt practices, and failure to disclose election expenses.

The agency said it recovered handwritten records of cash transactions during the February raids at a total of 14 premises in the two states which indicate disbursements orchestrated by Reddy and his brother-in-law, Rajvardhan Reddy, during the 2023 elections. It has claimed in its communication to the EC that the personal assistant of Nara Bharath Reddy "admitted" to drafting these documents as per his instructions.

The ED's searches were part of a money laundering case filed against the MLA, an alleged linked person Surya Narayana Reddy and others after taking cognisance of an FIR filed by the Gandhi Nagar police station to probe charges of illegal granite mining and some land deals by allegedly misusing general power of attorney (GPA). # Karnataka, Gujarat lead India's clean energy transition race: Report

NEW DELHI, April 23: Karnataka and Gujarat continue to lead the race to clean energy transition, but states like Jharkhand, Bihar, West Bengal and Uttar Pradesh need to step up efforts, according to a new report released on Tuesday.

The joint report by research organisation, Institute for Energy Economics and Financial Analysis (IEEFA), and clean energy think tank Ember evaluates the clean electricity transition preparedness at the sub-national level.

The report's authors said Karnataka and Gujarat continue their strong performance across dimensions, effectively integrating renewable energy sources into their power sectors, making strong strides in decarbonisation.

But states like Jharkhand, Bihar, West Bengal and Uttar Pradesh need to improve. While these states are in the early stages of their transition, they now need to focus on increasing renewable energy deployment, enhancing short term market participation and

strengthening their distribution companies.

The report launch coincides with a spell of intense heat wave sweeping parts of India, leading to the Ministry of Power preparing for a projected peak power demand of 260 gigawatts. Harsh summers also offer the chance to utilise more clean energy like solar power. Although, this requires preparedness of states to transition to clean sources of electricity.

"Cyclical weather conditions coupled with faster economic activity is pushing India's peak electricity demand higher every year. While the central government is taking steps to integrate more renewable energy into the grid, states, too, need to be prepared to do so. Gauging sub-national progress now requires constant monitoring of several parameters at the state level. A purely national overview can often overshadow subtle intricacies at the state level, which may stymie the country's electricity transition," the report's contributing author, Vibhuti Garg,



Director, South Asia, IEEFA, said. national-level While the progress towards electricity transition is progressing well, it is far more uneven at the state level. "Some states have developed progressive steps, such as boosting decentralised renewable energy deployment, promoting solar pumps for agricultural needs, and enhancing storage solutions to ensure more renewable energy in their electricity systems. But, the

transition to clean electricity is still in its infancy in many states.

"These states should look to accelerate efforts to access benefits of a transition to clean electricity and to ensure they are not left too far behind the better-performing states," the report's contributing author, Aditya Lolla, Asia Programme Director, Ember, said.

One of the striking findings from the analysis for the 2024 report is that several states are ex-

hibiting preparedness to embrace electricity transition. They perform well in the "Readiness and Performance of the Power Ecosystem" and "Market Enablers" dimensions but need to improve in the "Decarbonisation" dimension.

"Delhi's power system is wellprepared for decarbonisation, while Odisha has robust market enablers to support decarbonisation in the power sector. However, their actual decarbonisation progress so far does not match their strengths in these aspects, highlighting the importance of performing well in both dimensions to effectively achieve decarbonisation goals," co-author Neshwin Rodrigues, Electricity Policy Analyst, Ember, said.

The report also notes that statelevel decarbonisation can be further accelerated by strengthening the power ecosystem and having right enablers. Some states that are decarbonising well also lack the right market enablers, others struggle with the readiness of their power ecosystems.

Kerala, Haryana, Andhra Pradesh, Punjab and Maharashtra all exhibited considerable progress in certain aspects but also lower performance in other aspects. For example, Kerala and Punjab need to improve when it comes to market enablers for decarbonisation, while Andhra Pradesh and Maharashtra need to focus on the readiness of their power ecosystems, according to co-author Tanya Rana, Energy Analyst, IEEFA.

"Despite achieving relative success in decarbonising the sector thus far. states must address deficiencies in readiness and market enablers to sustain their momentum," says Saloni Sachdeva Michael, Energy Specialist, India Clean Energy Transition, IEEFA. The report recognises the considerable efforts that states are making towards transitioning to clean electricity and recommends some key steps to accelerate the pace of transition. 'We recommend the strength-

ening of state-level regulatory

ecosystems. This not only ensures compliance but also promotes growth, data tracking and monitoring, and a conducive environment for business," Michael said.

"India has formulated many central and state-level policy schemes to reinforce its goal of energy independence by supporting various reforms and regulatory interventions across the value chain. However, actual implementation has not been adequate and transparent," she added.

The report also calls for a need to shift focus from national-level to state-level studies to understand the nuances of the electricity transition in India fully.

"Each state faces unique challenges in decarbonising its power system, necessitating tailored policy interventions. By tracking decarbonisation progress, assessing the power system's readiness for transition, and monitoring the advancement of market enablers, state-specific challenges and potential interventions can be better understood," Rodrigues said. # School jobs scam: HC asks Bengal to decide on granting sanction to prosecute accused by May 2



KOLKATA, April 23: The Calcutta High Court on Tuesday directed the West Bengal chief secretary to decide by May 2 on grant of sanction for prosecution of former public servants arrested by CBI in the 2016 school jobs case, which saw the cancellation of over 25,500 appointments the day before.

A division bench said that in the event the chief secretary fails to comply with this order, the court will be constrained to initiate appropriate proceedings against him.

Another division bench of the high court on Monday cancelled 25,753 appointments of teaching and non-teaching staff in West Bengal government-sponsored and -aided schools, declaring null and void the recruitment process of the State Level Selection Test (SLST) 2016 by the School Service Commis-

Noting that the application by CBI for sanction of prosecution of these persons has been pending since 2022, a division bench presided by Justice Joymalya Bagchi directed the chief secretary to decide on sanction of prosecution of the accused persons, who were arrested two years back, by May two.

Maintaining that grant of sanction is a step ping stone to the commencement of trial, the court said that it is the requirement of law that the sanctioning authority ought to take a prompt decision in the matter.

"While taking a decision, he should not be overawed or influenced by the position, authority or power of the accused persons and take an independent decision on the matter," the division bench, also comprising Justice Gaurang Kanth, said.

The court made the order during the hearing of bail prayers by the accused persons, who include Partha Chatterjee, a former education minister of the state.

Stating that they have been in custody for almost two years but the case could not progress due to absence of sanction for prosecution of some of the then public servants, their lawyers prayed that they be released on bail owing to the delay.

The CBI had stated before the court during the previous hearing of the matter that the governor of West Bengal had granted sanction to prosecute Chatterjee.

The division bench was hearing the bail prayers of Chatterjee, former secretary of West Bengal School Service Commission Ashok Saha, ex-SSC chairman Subires Bhattacharyya and former chairman of SSC's advisory committee Santi Prasad Sinha, who are in custody for about two years in connection with the case.

The court questioned whether these accused persons are so important that they can stall the sanction process for one and half years

The bench on April 9 also expressed its displeasure over the delay in grant of sanction and directed the chief secretary to take a decision by April 23.

On Monday, a division bench presided by Justice Debasgsu Basak, in its judgement on the school jobs matters had noted the delay in granting sanction for prosecution of the accused persons.

The bench had said that it was refraining from issuing any directions to the chief secretary in this regard since a coordinate bench had issued orders for the expeditious disposal of the application for sanction. (PTI)

India fourth largest military spender globally in 2023: SIPRI report

'World military expenditure increased for the ninth consecutive year in 2023, reaching a total of USD 2443 billion'

NEW DELHI, April 23: India was the fourth largest military spender globally in 2023 with an expenditure of USD 83.6 billion, behind the US, China and Russia, according to a report by an independent international think-tank.

The report by Stockholm International Peace Research Institute (SIPRI) shared on its website in April also said the "rise" in global military spending last year can be attributed "primarily to the ongoing war in Ukraine and escalating geopolitical tensions in Asia and Oceania and the Middle East".

The military expenditure went up in all five geographical regions, with major spending increases recorded in Europe, Asia and Oceania and the Middle East, it said. The report comes amid ongoing conflicts in various parts of the world such as the ones involving Israel-Hamas, Iran-Israel, Russian-Ukraine besides volatility in the Red Sea region.

"World military expenditure increased for the ninth consecutive year in 2023, reaching a total of USD 2443 billion. The 6.8 per cent increase in 2023 was the steepest year-on-year rise since 2009 and pushed global spending to the highest level SIPRI has ever recorded," accordng to the report.

The world military burden -- defined as military spending as a percentage of global gross domestic product (GDP) -increased to 2.3 per cent in 2023. Average military expenditure as a share of government expenditure rose by 0.4 percentage points to 6.9 per cent in 2023 and world military spending per person was the highest since 1990 at USD 306, it added. With military expenditure of USD 83.6



billion in 2023, India was the "fourth largest spender globally'

Indian spending was up by 4.2 per cent from 2022 and by 44 per cent from 2014. The increase in India's military spending was "mainly a result of growing personnel and operations costs" which made up almost 80 per cent of the total military budget in 2023, the SIPRI report claimed. "This aligns with the government's pri-

ority to strengthen the operational readiness of the armed forces amid ongoing tensions with China and Pakistan. In comparison, capital outlays to fund military procurement remained relatively stable at around 22 per cent of the budget in 2023," it said. A total of 75 per cent of these outlays went towards equipments produced domestically, which was the highest level ever and up from 68 per cent in the previous year. The continued shift towards domestic procurement reflects India's goal of becoming self-reliant in arms development and production, the think-tank said in its repot fact

sheet shared on its website. The Indian Army has maintained that deployment of its troops and other elements along the LAC is "extremely robust" and "balanced"

The eastern Ladakh border standoff erupted on May 5, 2020, following a violent clash in the Pangong Lake area. The ties between India and China nose-dived significantly following the clash in the Galwan Valley in June 2020 that marked the most serious military conflict between the two sides in decades.

SIPRI is an independent international institute dedicated to research into conflict, armaments, arms control and disarmament. Established in 1966, it provides data, analysis and recommendations based on open sources to policymakers,

researchers, media and the interested public.

The Stockholm-based think-tank monitors developments in military expenditure worldwide and maintains the most comprehensive, consistent and extensive publicly available data source on military expenditure, according to its online portal. The US military spending was USD 916 billion in 2023, which was 2.3 per cent more than in 2022 and 9.9 per cent more than in 2014, the report said.

The US remained by far the largest spender in the world, allocating 3.1 times more to the military than the second largest spender China. "The biggest percentage increase among all US military spending categories in 2023 was for 'research, development, test and evaluation (RDT&E)".

The Stockholm-based think-tank also said in its report that Ukraine was the "eighth largest spender" in 2023 after a spending surge of 51 per cent to reach USD 64.8 billion. This gave Ukraine "a military burden of 37 per cent and represented 58 per cent of total government spending'

"Ukraine's military spending in 2023 was 59 per cent the size of Russia's. However, Ukraine also received at least USD 35 billion in military aid during the year, including USD 25.4 billion from the US. Combined, this aid and Ukraine's own military spending were equivalent to about 91 per cent of Russian spending,' the report claimed.

According to the report, Russia's military spending increased by 24 per cent to an estimated USD 109 billion in 2023. (PTI)

NEW DELHI, April 23: The University Grants Commission has warned the public against fake online programmes with abbreviations similar to recognised degree nomenclature, officials said, flagging a particu-

lar "10-dav MBA" course. "Some individuals or organisations are offering online programmes and courses with abbreviated forms similar to the higher education system's recognised degree programmes. One such programme to which the attention of the commission has been drawn is a '10 Days MBA'," University Grants Commission (UGC) Secretary Manish Joshi said.

"The nomenclature of a degree, including its abbreviated form, duration and entry qualification, is specified by the UGC, with the previous approval of the central government, through the publication of a notification in the official gazette," he added.

The UGC secretary clarified that only a university, established or incorporated by or under a central act, provincial act or state act, or an institution deemed to be a university or an institution specifically empowered by an act of Parliament, has the right to confer a degree

"Higher education institutions are also required to obtain approval from the UGC to offer any online degree programme in terms of the UGC regulations. A list of recognised HEIs (higher education institutions) to offer online programmes and of permitted online programmesis available on deb.ugc.ac.in," Joshi said.

"Stakeholders are, therefore, advised to ascertain the validity of an online programme before applying or taking admission to any online programme," he said. #### Women train drivers raise safety concern as SERA, Blue Origin join hands to send Jhansi division asks them to do night shift ordinary citizens on space mission

NEW DELHI, April 23: More than 100 women train drivers have raised concern for their safety and highlighted lack of facilities after the Jhansi Rail Division recently issued an order directing them to do all work shifts "on a par with male drivers"

Before this direction, female drivers were assigned train duty in such a way that they used to either complete their trip and come home or reach the destination station before 10 at night and rest in 'running rooms'. The latest order by the Jhansi division was issued on April 16 this year.

A section of the women drivers have sent a written complaint to the divisional railway manager (DRM), Jhansi, in this regard.

"Now as per the new direction. we have been asked to be ready for work round-the-clock. We have requested the Divisional Railway Manager (DRM) to reconsider the decision. We will face a huge safety issue as the Railways doesn't provide any additional facilities to female drivers," a woman driver said.

When contacted, a senior railway official from the Jhansi division said the decision was taken due to intense work pressure.

'Till a few years ago, there were about a dozen girls in our division but now their numbers have gone up to over 100. As trains run round-the-clock, we can't ask their male counterparts to compensate for their absence all the time. This increases work pressure on male drivers which is not good for safe train operations," the official said. He added, "I fully admit that fe-

males have a lot of challenges driving trains late at night but we cannot offer facilities in the want of any guideline from the Railway Board. I think the Board should come out with a comprehensive guideline in this regard."

Female drivers said that Jhansi rail yard is deserted in the late evening and it is not safe for them to visit late at night to board the engine

"I request the chairperson of the Railway Board to visit the Yard once and see how safe it is at night. Being a woman, I hope she understands our problem," another female loco pilot said.

Sanjay Pandhi, the working president of the Indian Railway Loco Runningmen Organisation, while supporting the cause of the female drivers, said, "Railway authorities are violating the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act while issuing such an order. According to the Act, the employer is duty bound to ensure safe working conditions for all

women workers. However, female loco pilots don't get pick-up and drop facilities. Female drivers also said that the official order doesn't talk about any pick-up and drop facilities for late night work.

"This April 16 order is causing huge stress and depression for many drivers which is not safe for train operations either. We are not shying away from our jobs but at least the Railways should ensure basic facilities for our safety and convenience," the female driver said.

Recently, women train drivers urged the Railway Board to either improve their "pitiable" working conditions or allow them to shift to other departments. A group of female loco pilots,

who are members of the All India Railwaymen Federation, recently gave a representation to the Railway Board chairperson Jaya Varma Sinha, highlighting their plight and demanding "a one-time

cadre change" option. Lack of toilet facilities in engines, inability to change menstruation pads, mandatory provision to get out of the engine to attend to

any technical glitch even at night and no pick-up and drop facility for late-night duties are some of the problems cited by the women train drivers. (PTI)

NEW DELHI, April 23: USbased Space Exploration and Research Agency (SERA) on Tuesday announced a partnership with Blue Origin to develop a human spaceflight programme for citizens of nations historically lacked access to space.

The programme, which seeks to provide the opportunity for common citizens from around the world to become astronauts, will have its inaugural flight on a future New Shepard mission, Blue Origin's space tourism initiative.

All six seats on the flight have been reserved for the partnership with SERA.

"Nearly 150 countries have never had an astronaut. We created this programme to change this," said Joshua Skurla, Co-founder of SERA

Skurla said Brazilian civil engineer Victor Hespanha, who was selected at random from the SERA community, became the second Brazilian national to travel to space in 2022 onboard Blue Origin's fifth crewed flight.

"Victor's flight showed us how one person can inspire and excite an entire nation about the potential of space and we want to repeat that on a much larger scale," Skurla said.

"Our future life in space must


I owe my life and career to Spider-Man. So the simple answer is yes. I'll always want to do more," he told Deadline.

# **INDIAN EARTHQUAKE IN TORONTO** Gukesh's win tectonic shift in world chess order: Kasparov



NEW DELHI, April 23: It's "the Indian earthquake in Toronto", said Russian chess legend Garry Kasparov as he lauded teen Grandmaster D Gukesh for becoming the youngest ever challenger for the world title, a triumph which marks the "shifting tectonic plates" in the game's global order.

The 17-year-old Gukesh bettered the record created by none the Chinese champion Ding

other than Kasparov 40 years ago. The Russian was 22 when he qualified in 1984 to clash with compatriot Anatoly Karpov, making him the youngest challenger of that time.

"Congratulations! The Indian earthquake in Toronto is the culmination of the shifting tectonic plates in the chess world as the 17 year old Gukesh D will face pion.

Liren for the highest title," wrote Kasparov on 'X', obliquely referring to the Russian domination of the past.

Gukesh played out an easy draw with American Hikaru Nakamura in the 14th and final round to finish with nine out of a possible 14 points in the tournament that is held to decide the challenger to the world cham-

The triumph entitles Gukesh a clash against reigning world champion Ding Liren of China in the last quarter of the year.

India's five-time world champion Viswanathan Anand has spawned a chess culture in India and the country is reaping the rewards of the Grandmaster's sucwith thousands of cess youngsters, mostly in their teens, taking up chess.

Kasparov acknowledged Anand's contribution to Indian chess, saying, "The 'children' of Vishy Anand are on the loose!"

Kasparov was responding to a congratulatory tweet by Grand Chess Tour following Gukesh's success here.

"Congratulations to Gukesh D for his victory in the FIDE Candidates, securing his place as a challenger in the World Championship Match! We eagerly anticipate his participation in our grand chess tour events!," wrote Grand Chess Tour on 'X'.

In another social media post Kasparov highlighted the shift in power centre of chess, saying, "Look at the names of many of the top junior players in the USA and England to see that the Chinese and Indian diaspora are just as passionate to achieve at chess.

The Kasparov Chess Foundation has watched this wave rise and Gukesh's success will raise it further," Kasparov, the undisputed world champion from 1985 till 1993, wrote on 'X'.

Kasparov, following a dispute with the international chess federation (FIDE) set up a rival organisation, the Professional Chess Association. He was ranked world No. 1 for a record 255 months overall, from 1984 until his retirement from regular competitive chess in 2005. (PTI)

# Serie A title, second star and derby: Inter takes it all with win over Milan

MILAN, April 23: Winning the derby ended up being the cherry on top of a special night for Inter Milan.

Holding off AC Milan 2-1 on Monday clinched for Inter the Serie A title that had been sign-posted for weeks, and earned a coveted second star on its jersey for winning a 20th Italian league title, breaking a tie with its fierce city rival.

"I told the guys, We find ourselves in a situation that's never happened before," Inter captain Lautaro Martínez said. "We needed to take advantage of this opportunity, because look around, the entire stadium is ours now."

Not even the pouring rain could dampen the spirits of the Nerazzurri and their fans. Francesco Acerbi and Marcus Thuram scored and, although Fikayo Tomori's late goal for AC Milan threatened to delay the celebrations. Inter held on for the win that stretched its lead to an insurmountable 17 points over second-placed Milan, with five rounds remaining.

At the final whistle, a beaming Lautaro and teammate Federico Dimarco climbed onto the top of the goal frame at San Siro. Flares and fireworks were set off in the stands, and the Inter players danced raucously in front of their fans. A banner was unfurled saying in Italian: "Repeat it to the Madonnina, who are the champions and who the crybabies.'

The Madonnina is the statue on top of Milan cathedral that overlooks the city, and which the derby is named after.

After winning eight other trophies, Simone Inzaghi claimed his first league title as a coach.

"Winning the league with five matches left — more or less won with nine matches left, today making it mathematically certain — in a derby, with Milan the home team, that is something that will remain with us," Inzaghi said.

"Everyone gave their very valuable contribution so that we could reach goals like this."

# permitted to compete in national trials despite not meeting criteria

NEW DELHI, April 23: The national shooting federation, which is fighting a court battle to uphold its selection criteria in the ongoing trials for Paris Olympics, seems to have bent the rules for one marksman recently, allowing him to participate despite lower-than-requisite scores.

Trap marksman Karan missed the National Rifles Association of India's (NRAI) criteria for shotgun selection trials by two points but was allowed to compete, while several others, who shot identical scores during last year's National Championships, were not considered.

A letter issued by NRAI in November announcing "Selection Trials as per Shotgun Selection Criteria 2024 & Olympic Selection Criteria 2024 for Shotgun event" states that shooters with a score of 110 in senior men's trap during the 66th National Championship (October-November, 2023) were eligible for the exercise held between December, 2023 and March 2024.

Karan, an Army marksman, shot 108 in the National Championships but his was the only recommendation accepted by the NRAI, while the same exception was not made for a dozen more shooters, who shot identical scores.

The shooter competed in a series of four selection trials and is currently ranked 15th, thus failing to make the national squad.

Karan, representing Services Sports Control Board, was the first to be eliminated in the trap finals at the National Games in Goa, finishing sixth.

The NRAI, ironically, is locked in a legal battle with some Olympic aspirants in the Delhi High Court, where it is insisting that no more than top five shooters in rifle and pistol would be allowed in the ongoing trials. The process has come under criticism from no less than former national coach and legendary pistol shooter Jaspal Rana, who has said that the federation is not following interna-

tional norms. Asked why the trials were not opened for marksmen who shot identical scores at the Nationals, Bhatia said, "I think we allowed him under a special criteria because of his previous scores."

Bhatia added that giving an exception in trials didn't mean he was selected in the national squad for international competitions like the World Cups and World Championships. (PTI)

# Winning Worlds in Olympic category was huge, feel stronger in 75kg: Lovlina

NEW DELHI, April 23: CWG mixed doubles champion Sreeja Akula on Tuesday became the topranked Indian woman table tennis player after rising to career-high rank of 38 in latest ITTF Chart, replacing Manika Batra. Sreeja climbed a spot while Manika who had been India's number one TT player for a while now, slipped two places to 39 in the latest update.

The 25-year-old Sreeja has enjoyed a good run this year, winning the WTT Feeder Corpus Christi and WTT Feeder Beirut titles in January and March respectively besides reaching the quarterfinal of the WTT Star Contender in Goa.

Sreeja had won the mixed doubles gold medal at the 2022 Commonwealth Games alongside veteran Sharath Kamal.

Yashaswini Ghorpade and Archana Kamath held on to their 99th and 100th spot in the rankings. Sharath continues to be the topranked male player, occupying the 37 spot in the rankings while G Sathiyan and Manav Thakar have interchanged places to be 60th and 61st respectively.

NEW DELHI, April 23: Lovlina Borgohain is aware that fierce competition awaits her at the Paris Olympics but the ace Indian boxer is quietly confident of snaring a second successive Games medal, having found considerable success in her new category, which is also closer to her natural body weight. Following her bronze medalwinning feat at the Tokyo

Olympics, Borgohain endured a tumultuous period when she made early exits from the World Championships and Commonwealth Games.

She eventually moved up to 75kg as her original 69kg category was scrapped from the Paris program.

Since then, the ace Indian boxer has claimed gold at the 2022 Asian Championship and the 2023 World Championships, along with a silver medal at the Asian Games last year.

"My performance overall after changing the weight has been good. Winning the World Championship in the Olympic category was huge. I had to control weight before (for 69kg) but now I am set



One of the reasons for her good run in the higher weight class is that the Assam boxer, who weighs between 70kg to 75kg even out of competition, doesn't have to shed much before a tournament, a painstaking process that may also sometimes lead to loss of strength.

"Yes, the opponents (in 75kg) are strong but I fit well in this category. I am more comfortable in this category than 69kg because I can eat properly, so the energy level is high. I feel stronger and I am able to train better, with

While the three-time world medallist is working on her power, she counts agility and speed as one of her strengths.

"I am tall for a 69kg category boxer and I had to control my weight. When I had to control weight I had to stop eating, I didn't feel that strong then. But in 75kg, I feel stronger. The speed which I already had helps."

Having competed in a few marquee tournaments in the 75kg weight class, Borgohain now has a fair idea of the pugilists she will encounter in Paris. She also tweaked her strategy during the recent one-week camp on Turkey.

"I have changed my technique a bit. I can't say what but it has helped me. Earlier I had a more defensive game but now I go ahead and attack," she said.

As the pressure mounts ahead of the Games, Borgohain said she derives strength from praying and meditating.

NEW DELHI, April 23: South Africa and Gujarat Titans' middle-order batter David Miller doesn't expect too many high-scoring matches in the upcoming T20 World Cup in the Americas as he feels the pitches there will be on the slower side.

Favourable conditions and the muchdebated 'Impact Player' rule have helped batters rule the roost in the ongoing IPL, with teams such as Sunrisers Hyderabad piling up scores in excess of 260 on three occasions.

But Miller feels it won't be the same in the T20 World Cup, to be held in the United States and West Indies from June 2.

"It would be hard to say whether the World Cup will produce high-scoring games because the conditions will be very different. The Caribbean might be on the slower side compared to Indian wickets. It's all about assessing the conditions on the day and playing accordingly," Miller
