### Himanta offers temple sops to Bihar voters

MUZAFFARPUR/SIWAN (BIHAR), May 18: Chief Minister Himanta Biswa Sarma on Saturday said grand temples would be built in Varanasi and Mathura and the Uniform Civil Code would be implemented if the NDA returns to power by winning over 400 Lok Sabha seats.

He said the NDA, under the leadership of Prime Minister Narendra Modi, will ensure that Pakistan occupied Kashmir, which is an integral part of India, returns to the country.

Addressing election rallies in Muzaffarpur and Siwan Lok Sabha seats, Sarma said, "We will implement UCC, build a temple on Krishna Janmabhoomi premises in Mathura and establish Kashi Vishwanath temple in place of Gyanvapi Mosque in Varanasi, besides ensuring that PoK returns to India, after winning over 400 seats.

Hitting out at the Congress and its allies, Sarma said, "Rahul Gandhi and Lalu Prasad did not attend the consecration of Ram Mandir. They want to send Ram Lalla back to the tent. We must not let this happen." He labeled Congress and RJD as "biggest enemies of OBCs" for allegedly trying to introduce religion-based reservations in the country.

"Religion-based reservations should be given to Muslims in Pakistan, not India. Lalu Prasad should go to Pakistan to give reservations to Muslims. The NDA will not allow this at any cost.

"The new India of Modi ji does not need madarssa... we need modern schools and colleges that will pro-



duce doctors and engineers... not maulvis from madarssa," he said

Asserting that Rahul Gandhi can "never become PM", Sarma said, "He can contest elections in Pakistan and become its PM. He and his party are indulging in politics of appeasement."

'The corrupt Congress-RJD alliance is trying its best to stall development of Bihar... they indulge in fulfilling their own interests whenever they get an opportunity. The NDA is breaking their nexus," he said. While BJP's Raj Bhushan Nishad is contesting from Muzaffarpur, Vijay Lakshmi Devi Kushwaha is contesting as NDA nominee from Siwan.

Muzafarpur will go to polls on May 20, while elections will be held in Siwan on May 25. (PTI)

GUWAHATI, May 18: Two persons were killed and two others injured on Saturday after being hit by a speeding train in Assam's Kamrup Metropolitan district, police said.

### Pakistan, IMF to hold talks on fresh bailout package

ISLAMABAD, May 18: Pakistan, seeking a fresh USD 6 billion to USD 8 billion loan package from the IMF, will hold talks with officials from the Washington-based lender to discuss the terms of the fresh bailout for the cash-strapped country, according to a media report on Saturday.

An IMF support team has reached Pakistan to hold talks regarding its request for a fresh bailout package under the Extended Fund Facility (EFF).

Pakistan has made a formal request for a fresh bailout package of USD 6 to USD 8 billion under the EFF with the possibility to be augmented through climate finance. If successful, it would be the 24th IMF bailout programme for the country.

"Right now, a mission team led by Nathan Porter, our Mission Chief, is meeting with the authorities this week to discuss the next phase of our engagement with Pakistan," International Monetary Funds Communication Director Julie Kozack said on Thursday.

IMFs Resident Representative for Pakistan Esther Perez Ruiz said a team, led by Porter, would meet Pakistani authorities "to discuss the next phase of engagement". She had further said that the aim of the negotiations was to "lay the foundation for better governance and stronger, more inclusive, and resilient economic growth that will benefit all Pakistanis", Geo News reported.

The team is expected to stay in the country for more

than 10 days and would receive data from different departments and would also discuss the upcoming budget for the fiscal year 2025 with the Ministry of Finance officials, Geo News reported quoting sources. Last Tuesday, Pakistan and the IMF started negotiations for a fresh bailout package to address the cashstrapped countrys fiscal challenges and implement crucial reforms, media reports said.

Last month, Pakistan completed a short-term USD 3 billion programme with the IMF, which bailed the country out of any default.

It was unclear whether the IMF mission would end with a formal staff-level agreement for the next bailout package, according to The Express Tribune newspaper. The duration, instrument, and size of the next IMF programme were open to discussion, the report said, quoting sources.

Pakistan narrowly averted default last summer, and the economy has stabilised after the completion of the last IMF programme, with inflation coming down to around 17 per cent in April from a record high of 38 per cent last May.

The country is still dealing with a high fiscal shortfall, and while the external account deficit has been controlled through import control mechanisms, it has come at the expense of stagnating growth, which is expected to be around two per cent this year compared to negative growth last year. (PTI)

The data showed that the investment in mutual funds almost trebled to Rs 1.79 lakh crore in 2022-23 in three years from Rs 64,084 crore in 2020-21. The household investment in shares and debentures almost doubled to Rs 2.06 lakh crore in 2022-23 from Rs 1.07 lakh crore in three years from 2020-21.

Finance Minister Nirmala Sitharaman had earlier this week cautioned against an unchecked explosion in retail F&O trading saying it may potentially create problems in household finances. Household finances have made a generational shift. We want to

The Congress, he said, would not tire of taking credit for exposing the AAP government's scams but its Delhi leaders were forced by the Gandhi family to join hands with the city's ruling party.

Keeping up his attack on the opposition alliance for its alleged pro-Muslim politics, Modi said the Congress had joined hands with those advocating for "vote jihad" for its vote bank during the 2014 elections. It was agreed that they would vote for the Congress, and its government in turn handed over the country's properties to the Waqf Board, he said. These properties were spread across prime locations where a yard of land costs many lakh of rupees, Modi said, claiming that the opportunist opposition alliance can incite violence for its appeasement politics. Prime Minister Modi blamed them (opposition) for the 2020 Delhi riots following the enactment of the Citizenship (Amendment) Act, and noted that many people, mostly Dalits, who were persecuted in neighbouring countries were recently granted citizenship under the law. The opposition alliance supports reservation on religious ground, restoration of Article 370 and abolition of India's nuclear bombs, he claimed. (PTI)

### Why Modi has 'broken'

After this betrayal, farmers' organisations were forced to take the streets once again to make their voices heard," he said. "Instead of listening to them, the Modi sarkar lathi-charged and tear-gassed them. Last year, Haryana's farmers struggled due to unseasonal rains and storms that caused widespread crop damage. Why has the Modi sarkar continued to ignore their plight?" he asked. The Congress leader claimed that the party's Nyay Patra has promised a legal guarantee for MSP, according to recommendations of the Swaminathan Commission, as well as farm loan waivers and the payment of crop insurance within 30 days.

"What is the BJP's vision to ensure that Harvana's farmers can make a stable, decent living?" Ramesh asked. He also alleged that Modi has once again failed India's daughters. Rather than punishing party MP Singh for "his heinous crimes" against India's women wrestlers, the BJP rewarded him with a ticket for his son Karan Bhushan Singh from the Kaiserganj Lok Sabha seat, he charged. "This has come as a slap in the face to all of India's daughters who put their careers at stake and slept on the streets for days, through sun and rain, in their fight for justice," the Congress general secretary said. "It has become clear that in 'Modi ka Parivar', Nari Shakti is just a slogan that is projected while the parivar (family) shelters perpetrators of sexual violence, be it Prajwal Revanna or Brij Bhushan Sharan Singh. Will women ever be safe in Modi's India? Will the prime minister's hunger for power always be more important than the safety of India's and Haryana's daughters?" he asked.

Ramesh also alleged that under BJP rule, Haryana has become notorious for violence and discrimination against the Scheduled Caste community. From being prohibited from using village hand-pumps to outright violence and sexual assault, Dalits have faced constant threats to their dignity and safety in the state, he claimed.

"When victims of these crimes approach the courts for justice, they are socially boycotted by dominant castes. Why is it that Scheduled Castes have to increasingly fear for their safety in BJP-ruled states? Does Prime Minister Modi feel no shame for the countless atrocities that Dalits have endured under his watch?" he asked, urging Modi to break his silence on these issues. Modi will on Saturday address poll rallies in Haryana's Ambala and Sonipat as part of his poll campaign. (PTI)

Led by AASU assistant secretary Samiran Phukan, district president Manas Pratim Baruah, and district secretary Dipankar Saikia, the protesters voiced their concerns, demanding strict monitoring by authorities and alleging the use of substandard materials in the construction. Executive Magistrate Sugata Siddhartha Goswami and executive engineer Anupam Hazarika assured the demonstrators of swift action against any negligent company officials. Despite the AASU unit submitting a memorandum to the district commissioner on April 30, they claim to have received no response from the authorities.

The project, allocated to SGCCL-Shiva JV Company at a cost of Rs 121.09 crore, commenced on March 11, 2022, with a contractual end date of April 18, 2024. However, with the completion period having elapsed by over a month, less than half of the work has been completed. Concerns have been raised over the apparent lack of technical staff and essential equipment by the contractor company, including Paver Finisher Hydrostatic with Sensor Control, Pneumatic Tyred Rollers, Vibratory Rollers, Motor Grader, and Bitumen Emulsion Pressure Distributor. Additionally, the footpath cum drainage works along the B.C. road have been criticised for their haphazard execution.

Moreover, the incomplete minor bridge near Hanchora and the controversial removal of the rotary at Station Chariali by vested interests have further compounded the frustrations of the citizens, detracting from their longstanding aspiration for a rotary junction.

## Media relations: Its role and everything to know

edia involves not just publications, but Akashvani, Doordarshan & other private electronic channels. When an organisation or government is 'in the news', the objective of press relations may be simply to ensure that what is published is favourable or at least accurate. But for promotional purposes, the problem is more often to stimulate media interest in publishing information about specific subjects.

'Mass Media' includes Doordarshan, Akashvani, Private electronic channels, Newspaper, and large circulation magazines, as well as many more specialised publications. One's press relation work will be with the press itself, often the business press in particular.

In every industrialised country there are dozens, hundreds or even thousands of business publications, serving virtually every industry, trade or profession. The people who read these publications are seeking information useful to them in their jobs or business. A single reader often is directly responsible for, or influences, very sizeable purposes.

Because trade and industrial publications are so specialised, their circulations are smaller. choose the right ones, trade and industrial journals regularly publish news and other information that general publication would not consider. If we are trying to reach trade, we also find out several different publications to reach the right people at various levels and in different kinds of operations. One way to identify the right business publication for our purposes is to ask people who fit into the business categories you are trying to reach which publication they read.

Although the business press can be our most promising publicity channel, it is rarely adequate as the sole medium for a publicity campaign, trade magazines do not reach everyone in every trade; small shop owners. for example, do not read them and top executives often read general business publications in preference to many of the specialised journals serving their industries. Moreover, if we are promoting consumer goods, in many cases obviously would want to reach consumers, not

just the trade. Daily newspapers, can achieve greater audience coverage than business journals. Newspapers also have a degree of selectivity which can be very useful, particularly in terms of geographical coverage. Newspapers usually serve individual cities or rural and sub-urban areas

Consumer magazines are another medium, one should not overlook. Women's magazines, for example, often carry articles and news items on products in the food, clothing and home furnishing areas. Travel articles are another favourite subject.

The essence of good press relations is of understanding what kind of material publications and other media want, and then supplying it to the extent possible. In all probability these will be a smaller group of publications that will be especially im-

portant for you. Study these publications more carefully. Do they publish articles about specific companies or products? What seems to interest them about products? Are they interested in foreign statistics and trends, in personalities? Do they publish feature articles about whole industries, including those of foreign countries? Do their articles seem to be based on reporting (by their own staff or by outsiders) or on press releases? How is the publication divided up according to subject matter? Do they use photographs and if so of what subjects, and how do they treat

them

it will pay to go a step further and get to know some of the editors and reporters. An even better reason for de-

veloping personal relations with appropriate journalists is they will thereby get to know us. Editors of good publications do not decide what to print on the basis of friendship or in return for hospitality; their livelihood depends on publishing material their readers want. However, if an editor knows

us and has been impressed with us as a serious source of useful information, he might well pause a bit longer over a press release coming from our organisation. To engage in press relations

on personal level successfully, one must bring two particularly important qualities to the job: Knowledge and honesty. Be candid with journalists. If

we have information which we are really not free to reveal, say so frankly and do not attempt to avoid the fact with evasive

replies. Do not deny a story that is correct. Make a point of becoming a source of useful information for reporters. Be scrupulous about being fair with reporters. If we have a piece of news, release it simultaneously to all journals.

The most common and practical way of disseminating a news-story is by sending it to the news media in the form of a press release. Publications rely heavily on press releases, sometimes like 80% or 90% of the press releases received by the better publications are almost immediately thrown into the

wastepaper basket. The main reason so many press releases are rejected is

what they contain is no news at all or no news of interest and that are badly prepared. Preparations of press releases should be entrusted to a professional publicity man.

magazines most important to us, tain news. Concentrate on preparing releases that interests of a limited number of publications which are especially important to us, rather than to send out generalised releases indiscriminately

A daily newspaper, for example, might run a short story about the visit of a high-level trade delegation but it would not be interested in the arrival of an individual businessman or the signing of a single agency agreement

For some trade magazines, printable 'news' may be nothing more than an announcement about availability of a news supplier, a large sale, a change in prices, the appointment of a news agency or sales manager or the launching of a new promotion campaign. Whether the publication is general or specialised, the one thing it will insist on is hard facts. Vogue generalities won't do.

One technique in developing successful press releases is to give some background and interpretation to the immediate news.

The way a press release is written and set up can determine whether or not it is used by the publication. Top the release with brief head line that identifies the subject and, if possible, gives the gist of the story. Then summarise the entire story, with all the vital details, in the first short paragraph; what happened, or will happen: the names of the organisation or firm, the people and the products involved, date and time if relevant, the place.

Also suggest in this lead paragraph the significance of the news. Then with simple sentences and brief paragraphs, fill out the story. Use facts and factual comparisons to impress. If possible, keep the story on one page

Always indicate where and from whom the editor can get additional information. Include also the telephone number. Physical presentation is also im-

portant, observing the following points:-

(1) Use paper with a headline especially printed for your press releases. The name of your organisation should also be prominent. The paper should be full typing-page size. The long 'A4' or full scape size is best.

(2) Use only one side of the sheet

system is used, copies should be clean and legible.

(4) Double scape, with wide margins on either side.

(5) Always place the date of story at the top.

(6) No underlining.

(7) Indent all paragraphs except the first. (8) No full stops between ini-

tials. (9) Use quotations sparingly.

(10) If the story runs over, put 'MORE' at the bottom of each pages

(11) At the end of story indicate source for information (name, telephone, telex, cable address, post address, email address).

Photographs can make a story, or at least give it more prominence and interest. In fact, a good news picture published with a suitable caption can be of more publicity value than 1000word story.

So consider sending photographs with press release when appropriate. Typical subjects include news products, events at a trade show, people in the news, a visiting mission. It is important to identify and caption pictures properly. Photographs should never be

clipped or stapled to their captions or to the accompanying release. Photographs are expensive to prepare and mail. You can reduce wastage by not sending them with release; instead indicate on the release that they are available. However, publications are more likely to use photographs when they arrive with the release.

Aim to reduce as much as possible the waste involved in sending releases to inappropriate publications. To minimize wastage, develop mailing lists according to subject matter. It is always better to address releases (3) Whatever reproduction to specific individuals on publications.

> In some countries there are public relations wire services. For an annual fee, they will transmit your releases by telex directly to publications. This is especially convenient for general releases, and can save a lot of work and even postage and preparation costs. Critically a public relations agency, to take over all the work associated with preparing and mailing out press releases.

Of necessity, disseminating press releases will be your primary means of communicating with the press. However, when the circumstances are right. staging a press conference or reception is likely to produce

more published material Basically a press conference is a meeting of reporters at which they receive news. Refreshments may or may not be served. A reception is a more elaborate affair, a meal may be served and the programmes include several events, such as talks, a film showing, and the presentation of an exhibit. The distinction is mainly one of the degrees. Press receptions are sometimes put on with nothing more specific in mind than to create goodwill with the press. At best this is a questionable use of funds.

From the publicity point of view, staging press gatherings can be more effective than merely dispatching press releases. But you have to offer journalists a reason to take the time to come to a press event. terest to the publication involved, and not merely news that could have been sent in a press release. The people whom the journalists are called to meet should be willing and able to answer questions. A press reception should be a standard part of publicity for trade missions and exhibitions.

The programme for a press conference can be quite simple, a brief introduction by the host. a prepared announcement or statement by the main speaker (or speakers), question period, and perhaps a fairly brief referencing, the period during which the reporters can chat informally with the speakers. Always remember that reporters are busy. Start promptly, and keep talks fairly brief.

You should brief the speakers and other participants on the purpose, the programme, which publications are expected to be represented, their interest and the likely direction of questions.

The timing of press meet can affect the resulting coverage. You will have the best chance of drawing the journalists you want if you stage the affair during business hours (including the lunch hour) and perhaps upto one hour later.

For the morning newspapers, the best time of day is around mid-day, and for the weekly and monthly journals, late afternoon. It is best to keep press reception for the press and not to invite others as well.

Invitations should be extended to individual journalists, not simply to their publications. Be sure to include the following information on the invitations: (a) The host, (b) Purpose, (c) Day and date, time and place, (d) The nature of the hospitality, (e) Signify, as with 'RSVP' that you would like a reply, and the name, telephone number and address, to be used for replying. # Namghar: Lifeline of Assamese society

The Namghar is the only public place in rural Assamese society, where a person gets the first opportunity to present him or her in public. It is just like the first rehearsal house for generating human resources. Namghar basically grooms people in their respective fields from culture, spirituality, to political leadership in the early period of life. It has the shadow of tribal houses-Dekachang, Morang Ghar etc. So naturally it has inherited the functions of the said tribal houses

#### Village Panchayat:

The introduction of the "Panchayati raj" system is also unable to take over the role of Namghar in total. It may be because of its non political permanent institutional nature. The disputes and discordances among villagers are much better settled in Namghar than any other else. **Rural club:** 

The Namghar is the only venue in rural areas of Assam, where people acquaint themselves with each other in a cordial manner. Nowadays many libraries are also constructed adjacent to the Namghar. Even many indoor games are also played in extended shed of Namghar. The Assamese Namghar serves as in all aspects -auditorium, playground, religious discourse, political meeting, trial court etc.

#### Spiritual guardianship:

The most important and effective feature of Namphar is its spirituality. The power of Namghar originates from common religious beliefs or weakness to spirituality or religion. It is like a church in medieval Europe. The Namghar enjoys the status of an unquestioned judge among the innocent people because of its religious tag. So sometimes its judgment authority is more than that of government approved legal institution

Expansion of Namghar and

No kingdom of Assam had ruled the entire Assam. But Saint Sankardeva reached and preached everywhere. During the long lifespan, Mahapurush Sankardeva was wandering and frequently changed his locations. Sankardeva earned the wrath of respective monarchs for initiation of new religious order. His main foe or enemy remained among the kingdoms of Kachari, Ahom and Koch.

Sankardeva started his religious preaching from Borduwa and Alipukhuri. The family of Sankardeva was independent landlord. But the powerful Kachari was their neighbour. Once quarrel erupted between them. Sankardeva was compelled to move from middle Assam to Ahom kingdom via Singori and Routa (approximately in 1516/1517).

Finally, settled in Gangmou (1527) Sankardeva stayed there almost five years and wrote Ankiya naat "Patni Prasad". The position of Ahom kingdom was destabilized for the attack of Koch monarch Biswa Singha. Again Mahapurush migrated to Dhuwahat, presently within Majuli area. Sankardeva at Dhuwahat somehow expressed himself as mass preacher. He converted many people to "Ek Sarana" and a vast group of his religious sect successfully emerged. This had rung alarm bell for the priestly Brahmins. The Brahmins started to antagonized Sankardeva and wrong message reached against him in the ears of Ahom monarchs. Hostility arose unabated. The most remarkable event of his stay in Dhuwahat is meeting of another great saint Mad-

havdeva. Koch king Nara Narayan rose to the throne (1540). Sankardeva got comfortable royal patronage there. Even king Nara Narayan became follower. Mahapurush his Sankardeva finally settled in Patbaushi of Tantikuchi (Barpeta). But



frequented Koch Bihar and his residing place Bheladonga.

The most formative period of Sankardeva started after his migration to Koch kingdom of lower Assam. The most of his prominent Ankiya Naats, devotional songs -Borgeet were created in Patbaushi. Moreover Patbaushi or Koch Bihar are the revered place that established Sankardeva as religious icon. The disciples from various ethnic backgrounds are converted to "Ek Sarana". They're – Damodordeva (Brahmin), Govinda (Garo), Jayaram (Bhutia), Murari (Koch), Chand Sai (Muslim) etc. **Overview:** 

We can conclude from the above discussion that the subjects of Koch kingdom are ardently or easily converted to Sankari cult (Bhakti). This is only apparently true .The dominant socio-cultural ethos of Assam originated from tribal society. Even the first aryanized dynasty-the Varman were of Mleccha origin. The people of Assam are arvanized through assimilation only. Not by birth

The people of western Assam are more aryanized than that of eastern part. Because the western part of Assam is easily connected to mainland Indian Territory. The Bhakti

movement of Sankardeva is as such revolt against aryanized casteism. The parochial attitude of Brahmanism never cordially embrace casteless Bhakti cult. It became inimical

to their existence. So the seeds of Satra and Namghar definitely germinated under Koch kingdom, but grown with fruits in Ahom kingdom. The rulers can inculcate a faith in their subjects to a limited extent only. The subjects of Ahom kingdom never endorsed the animosity between Sankardeva and their monarchy. The tribal people of upper Assam under Ahom Empire are not totally acquainted with the casteism or professional classification.

So they wholeheartedly accepted Namghar or Satra centric religion of Sankardeva. This is one of the prime reasons for unhindered expansion of Namghar within Ahom kingdom. The flow was so intense that the preacher of classless society, the Kala Sanghati Satra got dominant foothold in upper Assam only

Later, Shaktism of Bengal posed a conflicting environment. The Moamoria rebellion is a product of that conflict which immensely contributed to the fall of Ahom dynasty. On the other hand the rulers of Koch Bihar are more akin to the

rulers or culture of western and northern part of India (Undivided Bengal, Delhi etc.) More than hundred Satras are

created in undivided greater Kamrupa until the second decade of the nineteenth century. These are flourished basing on the ideal of Barpeta Satra. But the Assamese Namghar

couldn't become mass culture in Kamrupa. The Ahom's administrative system was conducive to formative Assamese society. The pedestal strata of Assam peo-

ple were built in Ahom kingdom. Namghar is born out of that. The small kingdoms under Koch Empire also couldn't develop Bhakti cult very deeply. The Darrangi kingdom originally established under Koch Empire. Even Darrang was subordinate kingdom under Ahom for nearly hundred years. But the influence of Bhakti religion in socio-cultural life of Darrang was not conspicuous.

Gradually the Koch kings after Nara Narayan and Lakshmi Narayan, disconnected their ties with the Brahmaputra valley. Their close affinity with Delhi based Mughals and British alienate the people of Brahmaputra valley. The culture of Bengal overshadowed the Assamese customs. Where is there room for Namghari culture? The peaceful co-existence of many 'shakti peethas" like Kamakhya hadn't obstructed the rise of Bhakti movement. But the North Indian and Bengal influence are shaking the very essence of Assamese culture.

After many upheavals Satra, Namghar remain as pillars of Assamese society. The people of Assam should be careful enough to comprehend the differences between Namghars and temples. Nowadays some structures of Namghar look similar to that of temples. The "Monikut" or the facade of some Namghars are built in temple shape polluting Assamese indigenous architecture. If it continues, it will be like aryanized hegemonic interference of North India. **Changes in Namghar** 

The Namghar is an institution created about five hundred fifty years ago. Naturally it won't remain intact. Change is inevitable with time. The religious rites and rituals

are also changed in all institutions. But the influence of religion in Namghar is paramount. It has been observed that the basic spirituality of Namghar hasn't been changed. The various cultural programmes are held in Namghar, but generally with religious undertones. The power of Namghar as village panchavat or mediator is on decaying. Now qualified people expect to be tried depending on circumstantial evidence for all the disputes. The morality of Namghar matters less in serious cases. The transition of feudalism to democracy resulted in acquiring personal freedom. Even common people are involved in politics for voting rights. This wasn't

the same in colonial era. The beginning of industrial revolution ended the agrarian economy. The commodity products occupy the economic set up of a society. These are done under direct political administration or government. So government and relevant modern institution like judiciary, police are slowly replacing the age-old social authority of Namghar. The voting, evidence, democratic majority are not adjustable with socio-religious institution. The basic architectural look of

the Namghar remains the same. But for non availability of indigenous materials-bamboo, straw, timber, cane, the original scenario of Namghar disappeared. Now all the above mentioned materials are replaced by concrete. So the look and design are also changed. The masons are mostly outsiders. They can't distinguish the differences between the Namghar and temple. So the triangular roof, facade, monikut, extended shed are sometimes resemble Hindu temples. Detailed parts of Namghar in

#### brief:

The inner premises of Namghar are divided into nine parts with meaningful significance. The eastern part near "Monikut" where

"Guru Asana" is kept is regarded as the first room or "Head". Serially towards the west, the Second one is "Heart".

Third one is "Stomach"

- Fourth one is "Navel"
- Fifth one is "Thigh" Sixth one is "Feet"

The second, third and fourth parts are used generally for congregational purposes. The remaining two sections fifth and sixth remain vacant or utilized to receive devotees and guests.

Moreover the entire Namghar is demarcated into three imaginary divisions. The "Head" is called Archana Sthana. The "Heart" and "Stomach" are called Bandana Sthana. The area from fourth to sixth is called Padasevana Sthana where devotees sit for prayer.

**Roofing:** As stated earlier some Vaishnava scholars consider the structure of Namghar as the feet of Lord Vishnu. The shape starts from the hip of Lord. The roof should be as the back of an elephant. According to Vaishnavite scholars, the Namghar should have three roofs. One on the top and others are east and west side connected to the top.

The head or horn of this elephant is the Monikut. The tail starts from the top; the triangular skin on the top is the thigh and hip. The rest of the area has two stomachs. There should not be division on the roof for the porch. The sloping roof is revered as female roof. The Namghar is considered - "Nature". This "Nature" covers inner "Male". The combined "Nature -Male" (Prakriti and Purush) is creator of the world-Almighty.

# Ukraine's divisive mobilization law comes into force as a new Russian push strains front-line troops

KYIV, May 18: A divisive mobilization law in Ukraine came into force on Saturday, as Kyiv struggles to boost troop numbers after Russia launched a new offensive that some fear could close in on Ukraine's second-largest city.

The legislation, which was watered down from its original draft, will make it easier to identify every conscript in the country. It also provides incentives to soldiers, such as cash bonuses or money toward buying a house or car, that some analysts say Ukraine cannot afford.

Lawmakers dragged their feet for months and only passed the law in mid-April, a week after Ukraine lowered the age for men who can be drafted from 27 to 25.

The measures reflect the growing strain that more than two years of war with Russia has had on Ukraine's forces, who are trying to hold the front lines in fighting that has

Moscow denies deliberately targeting civilians, but thousands have died or suffered injuries in the more than 27 After weeks of probing, months of fighting. The US last week an-

nounced a new USD 400 million package of military aid for Ukraine, and President Joe Biden has promised that he would rush badly needed weaponry to the country to help it stave off Russian ad-

trickle into the front line according to Ukrainian military commanders, who said it will take at least two months before supplies meet Kyiv's needs to hold the line.

Thousands of Ukrainians have fled the country to avoid the draft since Russia's all-out invasion in February 2022, some risking their lives as they tried to swim across a river separating Ukraine from neighbouring Romania and Hungary.

Late on Friday, Ukraine's border service said that at least 30 people have died trying to cross the Tisza River since the full scale-invasion. Romanian border guards days earlier retrieved the nearnaked, disfigured body of a man that appeared to have

been floating in the Tisza for days, and is the 30th known casualty, the Ukrainian agency said in an online statement. It said the man has not yet been identified. (AP)

### Flash floods due to unusually heavy seasonal rains kill at least 68 in Afghanistan

ISLAMABAD, May 18: Flash floods from heavy seasonal rains have killed at least 68 people in Afghanistan, Taliban officials said on Saturday, adding the death toll was based on preliminary reports.

Afghanistan has been witnessing unusually heavy seasonal rains.

In the hard-hit western province of Ghor, 50 people were reported dead, said Abdul Wahid Hamas, spokesman for the provincial governor. He also said the province has suffered significant financial losses after thousands of homes and properties were damaged and hundreds of hectares of agricultural land destroyed following Friday's floods, including the capital city Feroz Koh

Meanwhile, 18 people in the northern province of Farayab were killed and two others injured on Friday, according to Esmatullah Moradi, the provincial governor's spokesman. Damages to property and land were reported across four districts and over 300 animals were killed, he added

The UN food agency posted on social media platform X, saying Ghor was the most affected by the floods where 2500 families were impacted. WFP assessment teams are on the ground to deploy assistance, the post said.

The Taliban's government chief spokesman mourned "the loss of our fellow Afghans," and urged "responsible authorities ... to provide all necessary support to alleviate the suffering," in a post on X. He also called on "our benevolent donors" to help and humanitarian organisations to provide the affected communities with aid. Last week, WFP said the exceptionally heavy rains in Afghanistan have killed more than 300 people and destroyed thousands of houses, mostly in the northern province of Baghlan, which bore the brunt of floods on May 10th. Survivors have been left with no home, no land, and no source of livelihood, the World Food Organisation said. Most of Baghlan is "inaccessible by trucks," said WFP, adding that it is resorting to every alternative it can think of to deliver food to the survivors. (AP)

### Yemen's Houthi rebels claim shooting down US MQ-9 Reaper drone as footage shows wreckage

DUBAI, May 18: Yemen's Houthi rebels on Friday claimed to have shot down an American drone, hours after footage circulated online of what appeared to be the wreckage of an MQ-9 Reaper drone.

Early on Saturday, a vessel also came under attack in the Red Sea. The two incidents likely represent just the latest attacks by the Houthis as they press their campaign over the Israel-Hamas war in the Gaza Strip.

Houthi military spokesman Brig. Gen. Yahya Saree claimed that rebels shot down the Reaper on Thursday with a surface-to-air missile. He described the drone

as "carrying out hostile actions" in Yemen's Marib province, which remains held by allies of Yemen's exiled, internationally recognised government.

The Houthis later released footage they claimed showed the surface-to-air-missile being launched at night, along with night-vision footage of the missile hitting


the drone. A man, whose voice had been digitally altered to apparently prevent identification, chanted the Houthi slogan: "God is the greatest; death to America; death to Israel; curse the Jews; victory to Islam.'

Online video showed wreckage resembling the pieces of the Reaper on the ground, as well as footage of that wreckage on fire. The US military did not respond to a request for comment from The Associated Press over the Houthi claim.

While the rebels have made claims about attacks that turned out later not to be true, they have a history of shooting down US drones and have been armed by their main benefactor, Iran, with weapons capable of high-altitude attack. Since the Houthis seized the country's north and its capital, Sanaa, in 2014, the US military has previously lost at least five drones to the rebels.

Reapers, which cost around USD 30 million apiece, can fly at altitudes up to 50,000 feet and have an endurance of up to 24 hours before needing to land.

The drone shootdown comes as the Houthis launch attacks on shipping in the Red Sea and Gulf of Aden, demanding Israel ends the war in Gaza, which has killed more than 34,000 Palestinians there. The war



launched more than 50 attacks on shipping, seized one vessel and sunk another since November, according to the US Maritime Administration. Early Saturday, the

British military's United Kingdom Maritime Trade Operations centre said a ship came under attack off the coast of Yemen's port city of Hodeida.

The captain "has confirmed sustaining slight damage after being struck by an unknown object on his port quarter," the UKMTO said. 'The vessel and crew are safe and continuing to its next port of call.

The private security firm Ambrey said it believed the vessel struck was a Panama-flagged crude oil tanker. Radio traffic suggested the ship was "hit by a missile and that there was a fire in the steering gear flat," Ambrey said. (AP)

PARIS, May 18: French security forces reported another death on Saturday in armed clashes in the French Pacific territory of New Caledonia, the sixth fatality in a nearly a week of violent unrest scorching the archipelago whose indigenous population has long sought independ-

Opponents say the measure will benefit pro-France politicians in New Caledonia and further marginalize indigenous Kanak people. They once suffered from strict segregation policies and widespread discrimination.

Sri Lankan Tamils observe 15<sup>th</sup>

COLOMBO, May 18: Sri Lanka on Saturday marked the 15th anniversary of the end of the armed separatist campaign with Tamils holding a series of events throughout the former conflict zone in the north and east regions to remember

their dear ones killed in the clashes. However, in many areas, police and the government troops were accused of attempting to disrupt the memorial events.

The Liberation Tigers of Tamil Eelam (LTTE) had run a military campaign for a separate Tamil homeland in the northern and eastern provinces of the island nation for nearly 30 years before its collapse in 2009. On May 18, 2009, Sri Lankan army declared victory with the discovery of the body of the dreaded

LTTE leader Velupillai Prabakaran. Agnes Callamard, the Secretary General of the Amnesty International, visited the final battle site at Mullaivaikkal in the north-eastern Mullaithivu district to attend the commemoration.

"Today's anniversary is a grim reminder of the collective failure of the Sri Lankan authorities and the international community to deliver justice to the many victims of Sri Lanka's three decade-long internal armed conflict," Callamard said.

She said the UN investigations have found credible evidence of crimes committed by both sides to the conflict - "yet there has been little by the way of an independent or impartial national inquiry."

were accused of attempting to disrupt the memorials leading to the day's event in different parts. The troops maintained that in the guise of remembering the 'conflict dead', permission cannot be given for the events that celebrate the LTTE, a banned organisation

The troops came under fire for arresting several Tamils, including women, for organising memorials. In Colombo, police thwarted an attempt to disrupt a ceremony commemorating those killed in conflict. One person was arrested as he argued with police saying he was against the LTTE being commemorated, police said. Meanwhile, the government's celebration of the victory in the war is to take place on Sunday with the participation of Prime Minister Dinesh Gunawardena at the war memorial near parliament here.

The defence ministry has announced promotions to over 3,100 sailor and ,300 soldiers to mark the victory over the LTTE ending the separatist campaign. (PTI)

John Barnett, 62, of Louisiana, was found dead March 9, and police had said earlier that his injuries were self-inflicted.

Barnett was a longtime Boeing employee and worked as a quality-control manager before he retired in 2017. In the years after that, he shared his concerns with journalists.

Barnett said he saw discarded metal shavings near wiring for the flight controls that could have cut the wiring and caused a catastrophe.

He also noted problems with up to a quarter of the oxygen systems on Boeing's 787 planes.

"Information and records reviewed during the investigation uncovered Mr Barnett's longstanding mental health challenges, which had intensified in connection with ongoing legal proceedings related to his whistleblower case," police said in a statement.

Barnett was in Charleston answering questions for depositions for his whistleblower complaint, and a hearing on the matter was scheduled for June.

"John was deeply concerned about the safety of the aircraft and flying public, and had identified some serious defects that he felt were not adequately addressed," Barnett's brother, Rodney, said in a family statement shortly after his death.

"He said that Boeing had a culture of concealment and was putting profits over safety."

Boeing said in a statement, "We are saddened by Mr Barnett's passing, and our thoughts continue to be with his family and friends." (AP)

GUWAHATI, May 18: The Shillong medical college in Meghalaya is expected to become operational by September 2025, and the Tura Medical College by 2026-2027, according to state health minister Ampareen Lyngdoh.

This announcement followed a review meeting chaired by Meghalaya chief minister Conrad Sangma on Friday (May 17), foahead of schedule and progressing rapidly. If all goes well, the college should be functional by

September 2025.' She emphasized the need to expedite various technical aspects, such as faculty building, service rules for doctors, and aligning with models for teaching and non-teaching staff.

The Meghalaya health minister highlighted the importance of building a qualified faculty and updating service rules to allow doctors to function as educators. The National Medical Commission (NMC) still needs to inspect the proposed Shillong Medical College, and affiliation issues are being addressed. "We are considering affiliation with the Captain Williamson Sangma State University instead of NEHU due to delays," she noted. Regarding the proposed medical college at USTM in Ri Bhoi district of Meghalaya, Lyngdoh mentioned significant progress on the PA Sangma International Hospital, a public-private partnership (PPP) model. "The technical signing of MoUs and other arrangements are underway.

### Shah visited Kashmir to direct BJP, its proxies, on defeating National Conference: Omar Abdullah

SRINAGAR, May 18: Union Home Minister Amit Shah visited Kashmir to issue directions to the administration, the BJP and its "proxies" on defeating the National Conference, party leader Omar Abdullah alleged on Saturday. Shah on Friday wrapped up his brief visit to the Kashmir Valley during which he interacted with several delegations, including local Sikhs, Paharis, and those from the BJP, officials said.

Though his visit in the midst of Lok Sabha elections led to speculation of his meetings with some Kashmir-based mainstream political leaders, there was no official word on the minister,s engagements before he left the Valley.

"We have not been able to understand yet what the aim of the (home minister's) visit was because the BJP has not fielded candidates here. First, there was a rumour that he had come for a security review meeting but no meeting took place," Abdullah told reporters in the Magam area of Central Kashmir's Budgam district. The area is a part of the Baramulla constituency, which the National Conference vice-president is contesting.

Abdullah claimed Shah's visit was aimed at giving "directions to the administration, BJP and its 'B', 'C'. 'D' and 'E' teams on how to defeat the National Conference". The BJP has not fielded its candidates for the three Lok Sabha seats in Kashmir but unofficially extended support to some of the new political parties formed after

#### the abrogation of Article 370. Abdullah, a former chief minister of the erstwhile Jammu and Kashmir state, has been targeting the People's Conference, Apni Party, Democratic Progressive Azad Party and the People's Democratic Party throughout his campaign, calling them BJP's "proxy parties'

These parties have come together to defeat the National Conference on the directions of the BJP, he said. "But, by the grace of God, people are with us and we will prove that on June 4."

"Don't you think it is strange that the person who used to claim till yesterday that he will win the elections, his aim has now changed. Today, the People,s Conference does not talk of winning the elections, it talks about defeating Omar Abdullah. This tells you that all these parties follow the BJP's instructions. Their only target is the National Conference,' Abdullah said.

Asked about claims that the National Conference won elections in the Valley because of vote boycotts, Abdullah said the rival parties will now claim that the increase in voter turnout also

favours his party. "...our opponents had to find an excuse for that (electoral losses). They used to say the National Conference benefited from the boycott but now they will say that since the voting percentage increased, it also benefits the National Conference. ### Modi's, dhakad, govt brought down wall of Article 370: Modi in Ambala

AMBALA, May 18: Prime Minister Narendra Modi sharpened his attack on the Congress on Saturday and said it was his "dhakad" (strong) government that brought down the wall of Article 370 and as a result, Kashmir is now moving ahead on the path of development.

Modi said the history of the Congress has been of betraying India,s forces and soldiers as he referred to the "Jeep scandal", the "first scam' during the grand old party,s rule.

"Could a weak government have changed the situation in Jammu and Kashmir?" Modi asked the gathering, addressing his first Lok Sabha poll rally in Haryana.

Referring to Haryana contributing a sizable number of soldiers in the armed forces, he said when the Congress was in power, mothers in Haryana were a worried lot thinking about their children,s safety.

"Have such things stopped now or not?" he asked the audience that responded with a loud "ves"

"Modi,s dhakad (strong and decisive) government brought down the wall of Article 370 and Kashmir is now moving ahead on the path of development," the prime minister said. In August 2019, the Bharatiya Janata Party-led Centre abrogated the provisions of Article 370 of the Constitution that had bestowed special rights on Jammu and Kashmir and bifurcated the erstwhile state into Union territories.

Modi said only 17 days are left for June 4, when the Lok Sabha poll results will be announced.

The Congress and its partners in the Indian National Developmental Inclusive Alliance (INDIÂ) have drawn a blank in the first four phases of polling, he claimed.

Patriotism runs in the veins of Haryana, Modi said, adding that the "state understands anti-national forces. Therefore, each house in Haryana is saying -- phir ek baar" and the crowd responded, saying "Modi sarkar"

"When there is a dhakad government in the country, the enemy thinks 100 times before doing anything," the prime minister said.

He said Pakistan, which earlier had bombs in its hands, now has a "bheekh ka katora" (begging bowl) in its hands.

"When there is a dhakad sarkar, the enemy is terrified," Modi said. Voting for the 10 Lok Sabha seats

in Haryana will be held in the sixth phase of the seven-phase election on May 25.

Among those present at the rally were former Haryana chief minister and the BJP's Lok Sabha poll candidate from Karnal, Manohar Lal Khattar, the party,s Ambala and Kuand Naveen Jindal.

### Prajwal Revanna's videos: D K Shivakumar, ministers rubbish BJP leader's claim

BENGALURU, May 18: Karnataka Deputy Chief Minister D K Shivakumar and other state ministers on Saturday rubbished allegations about their role in the circulation of pen drives containing explicit videos involving Hassan MP Prajwal Revanna.

BJP leader and advocate G Devaraje Gowda, who is in custody after being arrested in a sexual abuse case and is also facing charges of video leak, on Friday alleged that Shivakumar and four other ministers are behind the circulation of the pen drives and was being fixed in false cases as he did

not agree to be part of their plan. He has even alleged that he was offered Rs 100 crore by Shivakumar to "bring a bad name" to the BJP and Prime Minister Narendra Modi, and to tarnish the image of JD(S)leader H D Kumaraswamy in Prajwal Revanna's obscene video case. of four ministers -- N Chaluvarayaswamy, Krishna Byre Gowda, Priyank Kharge and another minister -- was formed to handle this, with an intention to bring bad name to BJP, PM Modi and Kumaraswamy

He said Shivakumar had asked him to say that Kumaraswamy is behind the distribution of pen drives. but as he did not agree to it, he is being fixed in false cases.

Minister Priyank Kharge said Gowda has alleged that three responsible ministers in the state government were part of a team and that there was a conspiracy. "We will discuss whatever legal course, we will take it.

"Devaraje Gowda might be doing this to defame Shivakumar and Siddaramaiah. If he had a Rs 100 crore offer, he should have told Amit Shah (Union Home Minister) and get it investigated. Claims have been made that he (Gowda) was sent Rs 5 crore as advance at a club, let them get CCTV footage and see who were all there," Kharge said. MUMBAI, May 18: Congress chief Mallikarjun Kharge and other INDIA bloc leaders on Saturday slammed Prime Minister Narendra Modi over his claim that the opposition alliance would bulldoze the Ayodhya Ram temple if voted to power, and said they were committed to protecting the religious freedom of all citizens and ensuring that the country runs as per the Constitution.

Kharge, Shiv Sena (UBT) president Uddhav Thackeray, NCP (SP) chief Sharad Pawar jointly addressed a press conference in Mumbai on the last day of the campaigning for the final phase of the Lok Sabha polls in the state on May 20. These leaders responded to questions on PM Modi's charge that the opposition bloc will bulldoze the Ram temple, dilute quota for SC, ST and OBC categories and also restore Article 370

if voted to power. Kharge accused PM Modi of inciting people over the issues "that the Congress will never do". Thackeray said the INDIA bloc, s government will complete the construction of the Ram temple in Ayodhya, while Pawar said it will be the duty of their government to protect not just temples, but the places of worship of all religions. Kharge also said reservation as enshrined in

the Constitution will stay. "We have never used a bulldozer on anyone. Modi has the habit of lying and inciting people about things which Congress will never do or which are impossible to be implemented," he said.

To a question on his party's stand on Article 370, Kharge said, "I am not answerable to Modi. We will implement what we have promised in our manifesto.

"Our government enacted the Food Security Act and it is bound to implement it. The Congress has now said that we will give 10 kg free ration." he said.

Pawar said the previous government had taken the decision of the Food Security Act, but now Modi is taking credit for providing 5 kg free ration.

Stifling heat in northwest India to continue for another five days

NEW DELHI, May 18: The extreme heat scorching large parts of northwest India will continue for another five days, with Delhi, Haryana, Punjab, Rajasthan and Uttar Pradesh predicted to bear the maximum impact.

A brutal heat wave swept swathes of north India on Friday, with the maximum temperature soaring to a scorching 47.4 degrees Celsius in southwest Delhi's Naiafgarh, the highest this season in the country so far.

The India Meteorological Department (IMD) on Saturday predicted a severe heat wave over the plains of northwest India during the next five days and a heat wave over the east and central regions during the next three days.

The Met office also issued a red warning for Delhi, Haryana, Punjab and west Rajasthan, stressing the need for "extreme care for vulnerable people". It issued an orange alert for east Rajasthan, Uttar Pradesh and Bihar and emphasised "high health concern" for vulnerable people, including infants, the elderly and those with chronic diseases.

The Met office said high humidity could add to people,s inconvenience in Goa and sub-Himalayan West Bengal.

The IMD also said warm night conditions are likely in Uttar Pradesh, Bihar and west Rajasthan over the next two-three days. High night temperatures are considered dangerous because the body doesn't get a chance to cool down.

Increasing nighttime heat is more common in cities because of the urban heat island effect, in which metro areas are significantly hotter than their surroundings.

In view of the general elections in India, experts have warned of an



increased likelihood of heat-related illnesses in people exposed to the sun for prolonged periods or

engaging in heavy work. Researchers at Climate Central, a US-based group of climate scientists, said 543 million (54.3 crore) people in India will experience at

least one day of extreme heat during May 18-21.

has made this intense heat much temperatures make this event particularly alarming," said Andrew Pershing, vice-president for science at Climate Central. Heat waves can be deadly, with the elderly and children particularly at risk of heat exhaustion and heatstroke.

According to the World Health Organization, more than 1,66,000 (1.66 lakh) people died as a result of heat waves between 1998 and 2017.

Extreme temperatures can also impact economies. People are less productive during hot weather, even if they work indoors, while children struggle to learn in extreme heat. A 2022 study said extreme heat resulted in labour productivity loss of USD 2.1 trillion equivalent in 2017.

On Friday, maximum temperatures surged to 47.4 degrees Celsius in Najafgarh and 47.1 in Haryana's Sirsa.

According to India Meteorological Data (IMD) data till 7:30 pm,

Najafgarh was the warmest place highest-ever April day temperain the country. Before this, Kalaikunda in the

Gangetic West Bengal region had recorded a high of 47.2 degrees Celsius on April 30.

The threshold for a heat wave is met when the maximum temperature of a weather station reaches at least 40 degrees Celsius in the plains, 37 degrees in the coastal areas, and 30 degrees in the hilly regions, and the departure from normal is at least 4.5 notches. A severe heat wave is declared

if the departure from normal exceeds 6.4 notches. April witnessed record-smash-

ing maximum temperatures in east, northeast, and southern peninsular India, prompting health warnings from government agencies and a few states to suspend in-person classes in schools. Several places recorded their

tures, with the mercury soaring to 47 degrees Celsius.

At least two people died in Kerala due to suspected heatstroke during this period.

On Wednesday, a group of leading climate scientists said similar heat waves could occur once every 30 years, and these have already become about 45 times more likely due to climate change.

The scientists from the World Weather Attribution group emphasised that heat waves intensified by climate change are making life much tougher for people living in poverty across Asia.

The IMD had earlier warned of extreme heat in India during the April-June period, coinciding with the seven-phase Lok Sabha elections that end on June 1. (PTI)


# Of strawberry shakes, drives and four newspapers a day: Ruskin Bond turns 90

LANDOUR (UTTARAKHAND), May 18: Old writers never die, they simply go out of print, says India's storyteller through the decades Ruskin Bond as he turns 90 on Sunday, adding with his famed self-deprecating wit that 99 per cent of his tribe are forgotten in the long run. The companionship of his adopted family, drives on the serpentine Landour-Mussoorie route, frothy strawberry milk shakes, shelves filled with books to read and a handy notepad to write down his daily musings... they were and are just a few of his favourite things.

Spending most of his days at his picturesque home Ivy Cottage in the quiet cantonment town of Landour, a short drive from the noisier Mussoorie, the twin towns' most famous resident shows little signs of ageing. High blood pressure and dwindling eyesight aside, his childlike enthusiasm is intact as he discusses life, old age, writing, food and everything in between.

"Ninety-nine per cent of writers are forgotten in the long run. We are writing for posterity but nobody remembers us afterwards... I am happy if my family remembers me and a few readers get some pleasure out of my writing but it is very easy for a writer to disappear, to go out of print," Bond told PTI in a rare interview at his home, often breaking into laughter at his own answers.

The ace raconteur makes light of his celebrity status and of being India's favourite children's author with more than 500 titles, including short



stories, essays and novellas, since his debut novel "The Room on the Roof" in 1956.

"They say 'old soldiers never die, they simply fade away'. Even old writers never die, they simply go out of print," Bond laughed.

His latest "Hold on To Your Dreams", published by Penguin Random House India (PRHI), offers a unique glimpse into Bond's personal space and everyday life -memories of his boyhood, his friends, lost love, moments of joy, anguish, triumphs and tragedies. He became a writer almost by accident

Bond said didn't aspire to become one, at least initially. His first two ambitions, and he failed miserably at both, were to become an actor or a tap dancer.

"I wanted to be an actor, that never happened. I wanted to be a tap

dancer, never had the figure for it. Then I realised I could write. I was a great bookworm. I grew up on books. Then I thought this is the best thing to do. Nothing better than a book, then why not write a few. Join

the brigade of authors, so I did." At 90. Bond continues to be a voracious reader with his nose either in the books or newspapers -- quite literally -- due to his poor eyesight. "I am a newspaper addict. In fact, I get irritated when I don't get my newspaper early in the day. I read four newspapers a day. Books, I finish two-three of them a week easily. I read biographies, history, if it is interesting, crime thrillers for entertainment, and read classics... I have a fairly wide range of interest in books," he added.

Born to British parents Edith Clarke and Aubrey Bond in 1934 in Kasauli, Bond was only four years old when his mother separated from his father and married an Indian. Though Bond's custody was handed to his father, he soon relocated to his grandmother's house in Dehradun after his father lost his life to jaundice.

Bond grew up in Jamnagar, Shimla, New Delhi, and Dehradun. He finally made Landour his home in 1963

The quiet mountain town has for years been attracting fans hoping to have a glimpse of the star author sipping tea at the famous Chaar Dukaan, a string of four shops somewhere on a winding road, or grab a fleeting look at him through the window of his bright yellow room.

In fact, when Bond's grandson Sidharth created his Instagram account, which in no time amassed over two lakh followers. Bond jokingly said, "I hope they all don't turn up here together one day". "Lots of people come, knocking at

the door, ringing the bell, wanting to meet me. Now, how can I spend all day meeting them? Still, I meet people sometimes when I can," said

Bond was a regular at book signing sessions in Mussoori's Cambridge Book Depot. Those visits have be-

Akademi Award for English writing in 1992, the Padma Shri in 1999, the

Padma Bhushan in 2014 and the Sahitya Akademi Fellowship in 2021.

Having lived all his life in India, barring the four years that he spent in the Channel Islands and London. Bond, who has always identified himself as an Indian and nothing else, admits that even now some people take him for a foreigner in the country

Ever the storyteller, he recalls with humour a visit to Odisha's Konark Sun temple

"They wanted to charge me extra because they said I was a foreigner. They charge extra from foreigners for entry. I said 'I am not a foreigner, I am an Indian', but then to avoid an argument I paid extra. And behind me came a sardar ji, he had a British passport but they let him in. He wasn't charged extra because he didn't look like a foreigner," he laughed. Bond said he leads a happy and content life and doesn't think twice in indulging in things he likes, be it slurping his favourite strawberry milk shakes or going on shorts drives with his grandchildren.

Bond also scrupulously follows his doctor's advice. He gave up on his favourite tipple vodka but isn't a teetotaller and "chota, chota whiskey pegs" is his current favourite. "The doctor tells me to cut down on

salt as well. But I can't give up pickle. This morning only I had haldi pickle on bread toast. Very nice," said Bond, whose favourite all time delicacy is Kashmiri style 'mutton kofta curry'. (PTI)

India, UK review implementation of 10-year roadmap

hensive review of the India-UK 'Roadmap 2030' was undertaken during Foreign Secretary Vinay Kwatra's two-day visit to London, the Ministry of External Affairs

(MEA) said on Saturday. The two sides also agreed to further strengthen bilateral cooperation in areas of trade, defence and security, science and technology and people-to-people exchanges.

The foreign secretary visited the UK from May 16 to 17 to attend the 16th round of Foreign Office Consultations (FOC) between the two sides. In 2021. India and the UK adopted a 10-year roadmap to expand ties in the key areas of trade and economy, defence and security, climate change and people-to-people connections among others.

At the FOC, the foreign secretary held talks with Sir Philip Barton, the permanent under-secretary at the UK's Foreign, Commonwealth and Development Office (FCDO).

Kwatra also held meetings with Minister of State (Foreign Office) Lord Tariq Ahmad, MoS for Defence Procurement James Cartlidge, NSA Sir Tim Barrow, Home Office Permanent Secretary Matthew Rvcroft, Chief Trade Negotiator Crawford Falconer and Senior Foreign Policy Advisor to the UK prime minister, John Bew.

The MEA said both sides discussed the entire gamut of bilateral relations and regional and global issues of mutual interest.

"The foreign secretary and permanent under-secretary undertook a detailed review of the Roadmap

"Welcoming good progress across all pillars, they underscored their interest to raise the level of ambition and agreed to further strengthen bilateral cooperation including in trade and economic, defence and security, science and technology, people-to-people ties and mobility, energy, and climate change, as well as health," the MEA said in a statement.

It said India and the UK share a comprehensive strategic partnership which has been strengthened across all domains through regular highlevel political exchanges and meetings of bilateral institutional mechanisms.

The India-UK relationship was elevated to the comprehensive strategic partnership in May 2021.

The two sides are currently negotiating a free trade agreement. Both sides are also keen to expand cooperation in the maritime sphere.

In June 2021, the UK posted a liaison officer at the Indian Navy's Information Fusion Centre (IFC) that has emerged as a key hub in tracking movements of ships and other developments in the Indian Ocean region.

The UK joined a select group of countries such as the US, Australia. Japan and France to depute officials at the Gurugram-based facility.

The Indian Navy established the IFC-IOR in 2018 to effectively keep track of the shipping traffic as well as other critical developments in the region under a collaborative framework with like-minded countries. (PTI)

"I would appeal to voters, especially the transgenders, to vote for employment, safety and education and elect good people who could work for development and welfare of the people," she said.

"I was born as a male but identified myself as a woman. My identity is that of a transgender woman, we are unisex and not eunuchs," she told PTI, adding that they are not accepted in society as people consider them eunuchs and maintain dis-

The situation is still better in south India as compared to the north, and there is a need to spread awareness for social acceptability for transgenders, who have the right to live a life of their choice, she said. She also blamed the police for not registering their complaints against high handedness

Thakur, who earlier worked at an NGO in Delhi, advocates for lessons on transgenders in educational curriculum on the lines of countries like Canada, which provides for the right to an educational environment free from discrimination and harassment and use of bathrooms that correspond with their gender identity.

NEW DELHI, May 18: India on Saturday asked its students in Bishkek to stay indoors after the Kyrgyz capital city reported fights between some locals and foreigners. The Indian embassy in the Central Asian country said it is in touch with the Indian students and the situation is "calm" now.

The mission asked Indian students in the city to stay indoors. External Affairs Minister S Jaishankar advised the Indian students to stay in regular touch with the Indian embassy.

"Monitoring the welfare of Indian students in Bishkek. Situation is reportedly calm now. Strongly advise students to stay in regular touch with the Embassy," he said in a post on X.

The Indian embassy said, "We

are in touch with our students. The situation is presently calm but students are advised to stay indoors for the moment and get in touch with the Embassy in case of any issue.

Police in riot gear were de-ployed in part of Kyrgyzstan's capital overnight as large crowds gathered in anger over an alleged fight between local and foreign people, The Times of Central Asia reported.

NEW DELHI, May 18: More than 50 lakh large farmland trees vanished between 2018 and 2022 in India, partly due to altered cultivation practices, revealing a "concerning trajectory," new research published in the journal Nature Sustainability has found.

Researchers said that "an observable trend was emerging" wherein agroforestry systems are being replaced with paddy rice fields, even as a certain loss rate could be found to be natural

Large and mature trees within these agroforestry fields are removed, and trees are now being cultivated within separate block plantations typically with lower ecological value, they said. Block plantations, usually involving fewer species of trees, were found to have increased in numbers which some villagers from Telangana, Haryana, Maharashtra and other states confirmed via interviews.

The team including researchers from the University of Copenhagen, Denmark, explained that the decision to remove trees is often driven by perceived low benefits of the trees, coucarbon dioxide from the air. pled with concerns that their shading effect, including that of Neem trees, may adversely affect crop yields.

Boosting crop yields also contributed to the expansion of paddy rice fields, further facilitated by water supply which was augmented by the establishment of new boreholes, the authors said.

"This finding is particularly unsettling given the current emphasis on agroforestry as an essential natural climate solution, playing a crucial role in both climate change adaptation and mitigation strategies, as well as for

### POCSO court convicts 2 for raping 14-year-old girl, burning her in coal furnace

JAIPUR, May 18: A POCSO court in Rajasthan's Bhilwara district on Saturday convicted two men of gang raping and killing a 14-year-old girl by throwing her in a coal furnace in August last year. The court also acquitted seven other accused who were accused of destroying evidence. Special Public Prosecutor Mahaveer Singh Kishnawat said that the court will pronounce punishment on Monday. He said that an appeal against the acquittal would be made. The incident had become a political issue with the BJP, which was in opposition at that time, targeting the then Congress government over crime against women. "The court today held Kalu and Kanha guilty of gang-raping and killing the girl. Seven people, three women and four men, who were accused of destroying evidence, were acquitted," Kishnawat said.

A 14-year-old girl was murdered and she was thrown in a coal furnace in the Kotri police station area in August last year, police said.

Kotri now falls in the newly created Shahpura district. Police had arrested the two accused, who were from the Kalbelia tribe and were involved in making coal in furnaces there, in connection with the incident, they said. The girl went missing while she had gone to graze cattle on August 2 last year. The two accused gang-raped and threw her into a coal furnace in the night, police said. After the gang rape, assuming that the victim had died, the accused threw her in the furnace. However, the forensic report showed that the girl was alive when she was thrown. She died due to burn injuries, they said. (PTI)

### Lok Sabha, 2025 assembly polls will unveil Bihar's political landscape: Book

NEW DELHI, May 18: Bihar has been the only state in the Hindi heartland where the BJP hasn't ever been able to secure a majority on its own but the 2024 Lok Sabha and the assembly elections next year will unveil the political landscape of the state, says a new book.

In "Broken Promises: Caste, Crime and Politics in Bihar", Mrityunjay Sharma tells the story of Bihar's plunge into an abyss of crime, corruption and economic ruin during the tumultuous decade of the 1990s, often referred to as the 'jungle raj' years.


Sharma traces the post-Independence socio-politics of Bihar and the momentous events leading up to the '90s the unravelling of long-standing Congress governments, the rise of OBC assertion with Lohiaite politics, the JP movement that put the spotlight on young leaders like Lalu Yadav and Nitish Kumar, Karpoori Thakur's reservation formula, the rise of Naxal movements and the entry of socialist governments

The author says Bihar is the only state in the Hindi heartland where the BJP hasn't ever been able to secure a majority on its own.

"While in Uttar Pradesh, which at many levels seems similar to Bihar, the BJP has been able to secure decisive mandates in successive elections. The Hindu consolidation that seems to work well in Uttar Pradesh seems to bow down to caste considerations in Bihar," he says.

He argues that the current uncertainty surrounding Nitish's future leaves Bihar at a crucial political crossroads.

"The 2024 general elections and 2025 state elections will unveil the political landscape of Bihar, a region that has never succumbed to political complacency," Sharma says.



According to him, Nitish has long been twisting and tossing to find a comfortable footing in Bihar and national politics and his political challenges seemed no less than his administrative challenges.

He says Nitish strongly believed in the political dictum that you have to be in power first to be able to do anything good

"It may be the inclination to this principle that led him to concentrate power in himself and thus avoid any dangers to his party and government," the author claims.

In a state where every regional party associated itself with a particular caste, such as the RJD with Yadavs, the LJP with Paswans, and the JMM with adivasis, Nitish took all possible measures not to be perceived as a Kurmi-centric party, the book, published by Westland, says. Even later, the new party entrants in Bihar politics such

as the RLSP (Rashtriya Lok Samta Party), the VIP (Vikassheel Insaan Party) and the HAM (Hindustani Awam Morcha) would identify themselves with the specific castes of Kushwaha, Mallah and Musahar respectively, it says. Sharma also writes that Nitish slowly reined in the influence of strong personalities within the party, thus reduc-

wrote.

ing the scope for multiple power centres. 'Unlike its predecessors, the JD(U) never suffered a split and was hardly affected when even significant names such as its Samata Party-founding partner George Fernandes or JD(U)- founding leader Sharad Yadav were shunted out.

"Nitish became both the president of the party as well as the leader of house legislators. Ironically, in this case, he followed all other regional parties in making the JD(U) an individual-centric party. He also made sure that the individual was him," he adds.

The author says that coalitions have rarely had such longevity as has been seen in Bihar.

"Coalitions are delicately balanced partnerships and depend on a number of factors, such as the relative strengths of parties, overlap and contrast in messaging and vote banks, the electoral advantages of going alone versus as a coalition, and personal equations between senior leaders of the coalition," he writes.

Sharma says the period from 1990-2005 was a long and tragic one in the recent history of Bihar.

"Ironically, tragedies often make for the most compelling stories. My book is a humble attempt to give the unfamiliar reader a chance to understand what it actually meant to live through the 'jungle raj' years of Bihar and how it pushed Bihar forever into the realm of irredeemable ignominy," he says. (PTI)



### Pieces of mosaic come together gradually: George Miller on 'Furiosa: A Mad Max Saga' whether a story that was a continuous of the story of the story



**NEW DELHI, May 18:** It is hard to predict how a film will turn out while stepping into the story but one hopes that it means something to the audience, says filmmaker George Miller ahead of the global release of "Furiosa: A Mad Max Saga".

Starring Anya Taylor-Joy and Chris Hemsworth, the film continues Miller's dystopian "Mad Max" franchise and tells the origin story of Furiosa, a character he introduced through Charlize Theron in his 2015 blockbuster "Mad Max: Fury Road".

"You can't anticipate the end result. You can theorise about what you want it to be, but as you go through the process, gradually, the pieces of the mosaic come together, and you end up with the film that you hope means something to an audience," Miller told PTI in an interview.

Taylor-Joy has stepped in for Theron in the new movie, which had its world premiere at the Cannes Film Festival on Wednesday and received a standing ovation of over seven minutes. The film will release globally on May 23. Considered one of the most original and genre-bending directors today, the 79-year-old Australia-born filmmaker said with "Fury Road", he wanted to make a story that was a continuous chase and also picks up all the backstories of the Mel Gibson-starrer past three movies -- "Mad Max" in 1979, "Mad Max 2" in 1981 and 1985's "Mad Max Beyond Thunderdome". Miller, also known for "Babe", animated film "Happy Feet" and "Three Thousand Years of Longing", said he de-

cided to reboot the franchise in 2015 because "the tools of filmmaking are quite different in the digital age". "I thought you could do things that you could never do

in the past," he said, adding that he wanted to make something where conflict was human because "most stories are allegorical and somehow interact with the zeitgeist".

"In this case, it was five wives, who basically, as has often happened in history, are the breeding stock of a tyrannical guy, Immortan Joe, (who's) sitting on top of the dominance hierarchy with all the wealth of the wasteland. The most important currency is water and looking for heirs. It's a story told over and over again in all cultures throughout history," he said.

The filmmaker said Furiosa was born out of an idea of a female saviour who would rescue these five wives from Immortan Joe.

"If it was a male warrior taking them away, that's a completely different story than if it's a female. So that's what gave rise to Furiosa. Then, we had to go to her backstory. Where is she taking them? She's taking them to the place that was once her home, a place called Green Place of Many Mothers..."

The new film will show Furiosa's childhood and how she is snatched from her home at a young age and battles to go back.

Miller said both "Fury Road" and "Furiosa" play out differently because his action is always rooted in the storytelling. "The idea is not a game where you're trying to top yourself. You always go back to the unfolding of the story, the dynamics of the story, and that will tell you the best way to render each of one of the sequences or events. So it's not saying, 'Oh, let's do another action movie and let's top the action that we're doing.' It's always story driven.' While "Fury Road" had long set pieces with action play ing out in real time, "Furiosa" has sequences that take place over 18 years from when she's a 10-year-old taken away from home until she becomes Furiosa, a road warrior. "It's got a different rhythm. If it was music, a symphony, it would have different structures as this one does. It's always the story that defines what you're going to do.' Stories of conflict between Theron and her "Fury Road" co-star Tom Hardy are part of movie lore now with both the actors later acknowledging the tension and even Miller has spoken about it in interviews. 


their last IPL match of the season. Langer cited immense pressure and workload that comes along being an India coach, while adding that it has not been too long since he held a similar role with Australia.

BENGALURU, May 18: Echoing India skipper Rohit Sharma's sentiments, star batter Virat Kohli has criticised the Impact Player substitution rule and said it is "disrupting the balance" of the game.

The mid-innings substitution rule, adopted in the previous edition of the IPL, has sparked a row with Rohit expressing his displeasure in a podcast last month. Now, Kohli has urged for a rethink of the

rule.

"I agree with Rohit. Entertainment is one aspect of the game but there is no balance,' Kohli said on Jio Cinema.

"I think it has disrupted the balance and a lot of people are feeling this way, not just me," he said.

Rohit in the podcast had said, "I'm not a big fan... It's going to hold back allrounders. Cricket is played by 11, not 12 (players).'

it where bowlers think they will concede four or a six on every ball.

"Not every team has a Bumrah (Jasprit) or the mystery of Rashid Khan," he said.

"I am telling you, with one extra batter there is a reason I am playing with 200-plus strike rate in the powerplays. I know there is a batsman waiting at No. 8 as well.

"We are playing a high level of cricket and it should not be that dominant in my opinion. There is a beauty about having an equal balance between bat and ball," Kohli added.

BCCI secretary Jay Shah has said that the Impact Player rule is a "test case", implemented to give two Indian players opportunity in a game.

He has also indicated that they would talk to the stakeholders for using it in future editions of the IPL.

"I am sure Jay (Shah) bhai has mentioned it already that they will review it and I am sure that they will come to a conclusion which brings the game into balance," said Kohli

"As a batsman, I can say this rule is good but the match should be exciting. Only fours and sixes are not exciting in cricket. Exciting is that you can defend 160 as well," Kohli said. (PTI)
