### Road accident

CHAPAR: In a harrowing turn of events, a tragic road accident unfolded in Salkocha, Chapar on Tuesday, claiming the life of one man and leaving another critically injured. The incident unfolded as both individuals were homeward bound after exercising their civic duty of casting votes in the ongoing election. Unfortunately, fate took a cruel twist as they traversed the road, with an overspeeding four-wheeler colliding with them with devastating force. The victim, identified as Velu Nath, tragically succumbed to his injuries at the scene, while the other individual sustained severe wounds, necessitating urgent medical attention. Swift action was taken, and the injured party was promptly transferred to Kokrajhar for medical treatment.

### Voter collapses

CHIRANG: In a tragic incident in Assam's Chirang on Tuesday, a voter named Hussain Ali, aged 38, died at Polling Booth No. 35 Dangaigaon LP School within the Kokrajhar Lok Sabha constituency while casting his vote. Eyewitnesses reported a sudden onset of illness that led him to collapse and die on the spot. The exact cause of death remains undetermined, with locals suspecting a cardiac arrest.

# Over 74% polling in state; percentage to go up Nearly 1,000 components of EVM sets replaced in Assam during 3<sup>rd</sup> phase polling

GUWAHATI, May 7: Over 74 per cent of the 81.49 lakh voters exercised their franchise till 5 pm on Tuesday in four Lok Sabha constituencies in the third and final phase of elections in Assam, an official said.

Issue No. 117

Dhubri recorded the highest polling percentage at 79.70, followed by Barpeta at 76.20, Kokrajhar at 74.24 and Guwahati at 67.68 per cent, the lowest.

Overall voter turnout recorded till 5 pm in the four Lok Sabha seats was 74.86 per cent, the official said.

The turnout was expected to rise as people, who entered the polling stations before 5 pm, the closing time for voting, will be allowed to exercise their franchise.

There are 47 candidates in the fray in the final phase of Lok Sabha elections in the state.

Altogether 81,49,091 voters, including 40,48,436 women and 111 belonging to the third gender, are eligible to exercise their franchise

in 9,516 polling stations. Voting, which began at 7 pm,

# Modi govt neglected MP's Adivasi communities: Cong

NEW DELHI, May 7: The Congress accused the BJP-led Centre on Tuesday of "neglecting" the Adivasi communities of Madhya Pradesh and alleged that the saffron party's allocation for Adivasis in the central budget has consistently fallen short of the 8.2-per cent target set by the NITI Aayog

Congress general secretary Jairam Ramesh posed questions to Prime Minister Narendra Modi ahead of the latter's rallies in Madhya Pradesh.

"Why has the BJP failed to improve rail connectivity in MP's tribal districts? Why are Adivasis unwelcome in 'Modi ka Parivar'? Why does the Modi sarkar continue to neglect migrant workers?" Ramesh asked on X. Elaborating on what he said were "jumla (rhetoric) details", the Congress leader said even after being in power for 10 years, the Modi government has "failed" to complete the Dahod-Indore and Chhota Udaipur-Dhar railway lines.

"These railway lines were sanctioned by the UPA government but ten years later, construction has not even begun. Better rail connectivity would bring prosperity to the relatively isolated tribal-dominated districts of Dhar and Jabhua in Madhya Pradesh but successive BJP governments in the state and at the Centre have neglected this project," he alleged. Can the prime minister provide an explanation for the delay of more

than 10 years in these crucial railway projects, he asked.

"Is it attributable to his general callousness towards the Adivasi community?" Ramesh asked

He also alleged that the Modi government has not just "neglected MP's Adivasi communities, they have actively terrorised them"

"The BJP's allocation for Adivasis in the central budget has consistently fallen short of the 8.2 per cent target set by the NITI Aayog in 2017. Their poll promise to allocate ₹ 3 lakh crore for tribal welfare in Madhya Pradesh remains unfulfilled," the former Union minister said. "After the PM's rally in Jhabua, BJP workers were seen (CONTD. HT Bureau DIPHU, May 7: In response to disturbing reports of children allegedly being abused while working as domestic help in distant districts, Avijit Kro, member of the Autonomous Council (MAC) of Chinthong, has issued a stern warning against the practice.

Expressing grave concern over the welfare of children from remote areas of West Karbi Anglong, Kro emphasised the need to halt the exploitation immediately.

"Effective immediately, I am issuing a strict warning to cease the practice of sending children to Nagaon, Roha, or Guwahati for domestic work. Any involvement in this exploitative system, be it by agents, parents, or families, will face severe consequences," Kro asserted

Highlighting the plight of these vulnerable children, Kro urged parents to refrain from sending their



wards to work as domestic helpers elsewhere. He also pledged to ensure that minors from the Chinthong constituency would not be permitted to be taken away for such purposes.

The motivation behind this distressing trend lies in the financial struggles of families, who often resort to sending their children to

work in exchange for the promise of education. However, this pursuit of education frequently leads to harrowing experiences, with many children falling victim to abuse at the hands of their employers. Tragically, Kro cited recent fatalities as a result of this exploitation.

"In April 2021, Sumila Ronghangpi from Kudam Ronghang village lost her life at the hands of her employers in Roha, Nagaon district. Similarly, on May 3, Rahul Rongpi met a similar fate while

working in Roha. These are just a few recorded instances, with countless others going undocumented," Kro lamented. Kro stressed the urgency of col-

lective action involving all stakeholders, including parents and support from the Karbi Anglong Autonomous Council (KAAC), to address this pervasive issue. He

trend in domestic equities and strong dollar demand. Forex traders said elevated significant foreign fund outflows in the international market dented investors' sentiments.

At the interbank foreign exchange market, the local unit opened at 83.48 against the greenback. The unit hit an intra-day high of 83.47 and a low of 83.52 against the greenback.

The domestic unit finally settled at 83.51 (provisional) against the dollar, 1 paisa higher than its previous close. On Monday, the rupee settled 7 paise lower at 83.52 against the US dollar.

The Indian rupee traded almost flat on weak domestic markets and positive US Dollar. FII outflows also weighed on the rupee, said Anuj Choudhary Research Analyst, Sharekhan by BNP Paribas.

However, a soft tone in crude oil prices cushioned the downside. The US Dollar gained on weak Asian currencies after the Australian Dollar fell amid a lesshawkish-than-expected tone of the Reserve Bank of

Australia (RBA).

**Rupee settles higher by 1 paisa** 

"We expect the rupee to trade with a slight negative bias on weak domestic markets and positive dollar amid geopolitical tensions in the Middle East.

"However, softness in crude oil prices and positive European and Asian markets may support the rupee at lower levels. Any intervention by the Reserve Bank of India (RBI) may also support the domestic currency. USDINR spot price is expected to trade in a range of ₹ 83.30 to ₹ 83.75," Choudhary added.

Brent crude futures, the global oil benchmark, fell 0.10 per cent to USD 83.25 per barrel.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was at 105.26, higher by 0.20 per cent.

On the domestic equity market front, Sensex declined 383.69 points, or 0.52 per cent, to settle at 73,511.85 points. The Nifty fell 140.20 points, or 0.62 per cent, to close at 22,302.50 points.

Foreign Institutional Investors (FIIs) were net sellers in the capital markets on Monday, as they offloaded shares worth ₹ 2,168.75 crore, according to exchange data. (PTI)

# INOX Air Products to set up 190-tonne green hydrogen project in Rajasthan

New Delhi, May 7: INOX Air Products on Tuesday said it will set up its first green hydrogen project with an annual capacity of 190 tonnes at Chittorgarh in Rajasthan.

The clean energy will be supplied to Asahi India Glass Limited (AIS) under a 20-year offtake agreement, the company said in a statement.

"This will be India's first-ever green hydrogen plant for the float glass industry. The plant will have a capacity to generate up to 190 tonne green hydrogen per annum through the electrolysis process,"

it said. The project will be powered by solar energy. INOX aims to commission the project by July 2024.

The project is expected to reduce carbon emissions by around 1,250 metric tonnes (MT) annually and 25,000 MT over the 20-year period.

Siddharth Jain, Managing Director of INOX Air Products, stated, "We are proud to begin our green hydrogen journey as we partner AIS for their Chittorgarh facility, and giving shape to our first green hydrogen plant. Under the leader-

ship of PM Modi, our country has laid tremendous focus on green economy, supported by a comprehensive National Green Hydrogen Mission, and an ambition to make India net-zero by 2070."

The company did not disclose any financial details related to the roject.

Mumbai-based INOX Air Products is the largest manufacturer of industrial and medical gases in India. It has a manufacturing capacity of 3,400 tonnes per day (TPD) of liquid gases delivered from 47 operating locations. (PTI)

Meanwhile, a total of 965 Electronic Voting Machine (EVM) components -- control units, VVPATs and ballot units -- were replaced due to malfunctioning in the third and last phase of polling across the four Lok Sabha seats in Assam on Tuesday, officials said. In several cases, the components were replaced as the complete EVM set, while it was changed in parts in most of the cases after snags were detected, a senior official of the Election Department told PTI on condition of anonymity.

Several of these glitches were noticed during the mock polling, which started 90 minutes before the commencement of the actual voting, and those machines were replaced accordingly, he added.

An EVM has three components -- Control Unit (CU), Voter Verifiable Paper Audit Trail (VVPAT) and Ballot Unit (BU). "In the four constituencies, 259 CUs, 447 VVPATs and 259 BUs were replaced in total from different machines," the official said. Out of these, 147 CUs, 210 VVPATs and 147 BUs were replaced during the mock poll after they malfunctioned, the official said. "During the actual poll, 112 CUs, 237 VVPATs and 112 BUs were changed. After replacing the machines, the polling continued smoothly," he added. 

### Lawyer arrested for fraud in Jorhat HT Correspondent

JORHAT, May 7: A lawyer has been arrested by the police on charges of fraudulently producing an order in the name of the member of the Motor Accidents Claims Tribunal (MACT), Jorhat, awarding compensation to an accident victim's next of kin.

Khound alleged that Gogoi fraudulently made an order of paying ₹ 10.29 lakh in the name of MACT member, who is also the district and sessions judge.

After the victim failed to get the compensation amount and the matter came to the notice of the court of the district and sessions judge, the complaint was lodged against the lawyer at the Jorhat Police Station. It may be mentioned that the court order of judicial remand is yet to be passed till the filing of this report.



Northeast Frontier Railway (NFR) is continuously registering a steady growth in freight unload-



year. The NFR has transported goods like FCI rice, sugar, salt, edible oil, food grains, fertilizer, cement, coal, vegetables, auto, tank and other items during the month and unloaded them in different goods sheds within its jurisdiction.

During the month of April, a total of 540 rakes of freight carrying trains were unloaded in the state out of which 335 were loaded with essential commodities. 25 rakes in Tripura, 18 rakes in Nagaland, nine rakes in Arunachal Pradesh, three rakes in Manipur and five rakes in Mizoram were unloaded during the month. 

To tide over the situation, the Tripura government has already imposed restrictions on the sale of fuel as stock continues to remain low.

"Goods train services have not been restored despite allout efforts by the NFR. We will take up the issue at the

highest level," Tripura Transport Secretary UK Chakma told PTI. The NFR, which had earlier assured of restoration of services by May 7, however, failed to meet the deadline and sought three more

NFR CPRO Sabyasachi Dey said, "Over 300 workers have been engaged in restoration work at Jatinga for the past few days. There is no disruption in passenger train services but good train services have been affected due to derailment of a goods train on April 26. We have sought time to restore the service at the earliest.'

With the supply of foodgrains affected due to the disruption in goods train services, Tripura Additional Secretary for Food and Civil Supplies, Nirmal Adhikari, on Monday held a meeting with the representatives of Tripura Merchants' Association (TMA) and Tripura Wholesale Grocery Merchants' Association (TWGMA) to review the situation.

"There is no need to panic as the state has food stock for around a month. The meeting was aimed at reviewing the situation in the wake of disruption in goods train services to the state. of 65 heath centres in the district, 50 health centres have already been declared tobacco-free. He added that five villages under the district have also been declared tobacco-free.

Yanthan said counselling is also being given to clients to quit the use of tobacco products and added that pharmacological supports are given to them.

Chairing the meeting, Wokha SDO (C) Nuhuta Tunyi SDO (C) asked all the stakeholders to put in concentrated efforts to achieve the targets of the various activities under the NTCP to reduce the use of tobacco.

He also asked the officials to undertake intensive awareness camand sensitisation paigns programmes to create awareness among the public about the harmful effects of tobacco consumption.

## Over 30,000 Myanmarese taking shelter in Mizoram HT Bureau

GUWAHATI, May 7: Officials in Mizoram reported the arrival of approximately 50 additional refugees from Myanmar, bringing the total number of Myanmarese seeking shelter in the Northeast state to 34,332, as disclosed on Monday (May 06).

According to a government official in Mizoram, the recent arrivals, including 10 women, fled Paletwa in Myanmar's Chin region and sought refuge in Hruitezawl village in Mizoram's Lawngtlai district over the past few days to avoid forced recruitment into the ranks of the Arakan Army (AA) militant group. Originating from Rakhine in Myanmar, the Arakan Army stands as the largest armed ethnic faction in the country, actively recruiting individuals from the Chin region to bolster their resistance against the national military.

"Young individuals in Myanmar who resist compulsory recruitment by the Arakan Army are seeking sanctuary in Mizoram," stated the official.

Before this recent influx, 34,282 Myanmarese migrants had sought refuge in Mizoram's 11 districts in stages following the military coup in Iyanmar on February 1, 2021.

Presently, a total of 34,332 Myanmarese nationals, including 10,900 women and 13,310 children, are residing in relief camps in Mizoram, while others are lodging with relatives or renting accommodations. In addition to the Myanmarese refugees, approximately 10,000 individuals, comprising men, women, and children, found refuge in Mizoram after ethnic violence erupted in neighbouring Manipur in May of the previous year.

Xenophobia refers to the fear, dislike, or prejudice against people from other countries or cultures. It involves displaying hostility or discrimination towards individuals based on their foreign nationality or perceived foreignness.

Biden made these comments during a campaign fundraising event in Washington, primarily attended by Asian-Americans. It is noteworthy that these remarks followed his recent hosting of Japanese Prime Minister Fumio Kishida during a state visit to the White House. The Japantimes, a news publication in Tokyo, also covered Biden's comments, noting that Japan is gradually opening its doors to more immigrants due to its aging and shrinking population. In December 2023, the number of foreign residents in Japan reached a record high, accounting for approximately 2.7 percent of the total population



# Women voters will play a decisive role in bringing BJP tally in Karnataka BJP is not likely to bag any seat ally's candidate who was accused

The crucial third phase of Lok Sabha election is most likely to bring more seats in the BJP's bag compared to the first and second phase of elections, but it is not bringing any cheer on PM Narendra Modi's face. Conversely, the struggle of the BJP in retaining its seat, and there is every likelihood of losing many of them, has made PM Narendra Modi ever more concerned, since it enhances the challenge of making up the losses in the first three phases in the last four phases of election much more difficult.

With election of 94 Lok Sabha constituency in the third phase, election would be completed on 283 seats out of the total 543 in the country, leaving only 260 seats for the next four phases of election. In the fourth phase of election scheduled on May 13, another 96 constituencies are scheduled for polling.

PM Narendra Modi had given a call for 370 seats for the BJP and 400+ seats for the NDA, which at the end of the third phase seems to be unattainable. Moreover, BJP has performed badly in the first two phases and this trend will continue in the third phase on May7.

Barring Gujarat, BJP's electoral performance does not seem to reach PM Modi's expectations In Assam Himanta Biswa Sarma tried his best, but BJP does not seem to increase its tally. At best the party can maintain only status quo. In the entire northeast, the party is all set to fail in retaining its tally compared to the 2019 election.

Bihar is going to have election in 7 phases, and by the third phase election to the 14 seats, does not enthuse the BJP. Chiefly because of the bad performance of its allies JD(U) and LJP (RV), which were contesting more seats in the first three phases. The election on 14 seats reveals that Congress-RJD-Left combine in the state giving tough electoral battle, and that is likely to continue even in the next four phases.

NDA tally may reach about 8 seats. The situations in the other Hindi heartland states of Chhattisgarh, Madhya Pradesh, Rajasthan, and Uttar Pradesh have also turned difficult for the BJP. It triggered PM Narendra Modi unleashing his vitriolic communal campaign centred around SC, ST, OBCs and Muslims all for targeting Congress and INDIA bloc and deriving benefit from the communal polarization of Hindus in his favour.

Model Code of Conduct has clearly been violated lately, which might be a result of his despair. He is clearly seen swinging between hope and despair, on moment it seems best of times, and on the next seems to be worst of times for his electoral fortune.

With completion of election in Chhattisgarh and Rajasthan by third phase, uncertainly looms large for the BJP's prospect due to very close contests between the BJP and Congress in almost half of the seats, and many of them BJP is running a risk to lose. As far as Uttar Pradesh is concerned, unity within Samajwadi party, and among its support base have been seen unprecedentedly at very high level.

Having seen the contests in the 26 constituency by the third phase. BJP is running the risk of losing over half a dozen seats. It means it would be very difficult for the BJP to retain its 62 seats the party had won in 2019 Lok Sabha election. It has made the challenge for PM Modi and CM Adityanath Yogi very difficult in the next three phases of election in the state for 54 other seats. The realization of the dream of winning 75 seats from the state may just remain a dream, as the first three phases of election have already shown.

Uttar Pradesh, Haryana, and West Bengal are all set to be a nightmare for the BJP, despite the party's claim of championing the Naari Shakti. The nightmare has started from the Karnataka, where PM Narendra Modi and the entire BJP machinery campaigned for their

of molesting women. It has created the third phase election in Karnataka very tough for the BJP candidates who have become defensive, after losing their face. In Uttar Pradesh, the party has given ticket to the son of the accused molester of wrestler women. It would likely to impact women's voting pattern not only in Uttar Pradesh but also in Haryana, since the victims were of Haryana state. Then again there is West Bengal where Modi government is silent on molestation charges against their Governor while BJP has been raising Sandeshkhali women's molestation case in which a BJP leader was reported saying that Sandeshkhali allegations were false to defame TMC during election campaigns.

Thus, political outcome in the four states will depend on how women take the allegations against BJP as supporters of women molesters. It is despite the fact that PM Modi has warned Hindu women that their "Mangalsutras" are at risks of being taken away by Congress and INDIA bloc if they come to power, and would be handed over the "Muslims".

Maharashtra remains politically complex even in the third phase, where BJP by and large depends on the performance of its allies - the splinter groups of Shiv Sena (Shinde) and NCP (Ajit Pawar). Uncertainty has put PM Modi on the tenterhooks.

PM Modi's concerns have increased on account of the party's running the risk of losing its two dozen seats in the third phase itself, on which INDIA bloc allies have lately offering very tough electoral battle. BJP will have to win at least 150 out of 260 in the next four phases to reach the magic mark of 272 to form government on its own, which is of course a very challenging situation. Major states in the next for phase are Andhra Pradesh, Telangana, Punjab, Odisha, West Bengal, and Bihar, where the party's predicaments are numerous. (IPA Service)

while the Act promises representation for women, it cannot guarantee the decision-making power being held by them. Based on the experiences of the reservation of women in local government, there have been cases where Sarpanch Pati had taken on the role of Sarpanch instead of the female representatives. Moreover, women leaders at the helm have not been able to ensure women safety as witnessed in recent cases of sexual harassment emerging from a state ruled by a female chief minister.

The challenges ahead could impede the Act's success, nevertheless on the other hand,

having more women in posi tions of power in politics can lead to increased focus on women's issues in policymaking and implementation.

Despite concerns and flaws, the implementation of women's reservations in political leadership positions is crucial at the present moment.

The World Economic Forum (WEF), 2023 reports that it would require 131 years for the world to eliminate the gender gap. However, implementing affirmative actions such as reservations in politics could potentially accelerate this process.

Women's empowerment must extend to politics

Empowering women requires multiple key steps:

· Building capability is crucial, as highlighted by Nobel laureate Amartya Sen, through promoting gender equity in education.

• It is essential to raise political awareness among women regarding their political rights. Raising awareness among males about the importance of gender equality in society, including students through school curriculum.

• There was a time when emphasising on women's education, the first Prime Minister Pt Jawaharlal Nehru stated that educating a woman educates an entire family. It is now critical to apply this concept to the political realm.

• Empowering women politically can lead to securing social justice for marginalised women and ultimately strengthening democracy.

In the general elections, the "very healthy sign" of Indian democracy for women's representation as stated by the Chief Election Commissioner will be put to a litmus test. revitalize the skin

omen who exercise consistently in midlife have health-related better quality of life.

That's according to research published today in the journal PLOS Medicine in which researchers reported that women in their 40s and 50s who consistently adhered to physical activity guidelines had better physical functioning than their peers who didn't consistently exercise.

"Combined with existing evidence, this study contributes to growing evidence of the benefits of maintaining or adopting an active lifestyle in mid-age," the study authors said in a press statement.

"An important public health message is that being active for as many years as possible, even if women start to meet physical activity guidelines in their mid-50s, could have important health benefits in terms of physical health, especially in physical functioning." they added.

#### Details from the study on midlife women and exercise

The researchers from Australia examined data from more than 11,000 women beginning in 1996. The women were born between 1946 and 1951, meaning they were 47 to 52 years of age when the study began.

The participants were categorized into those who met the physical activity guidelinesTrusted Source from the World Health Organization consistently over a 15year period, those who initially did not meet the guidelines but began to meet them at the age of 55, 60 or 65, and those who never met the guidelines.

The quality of life related to the health of the women was assessed using a physical health composite score. This was derived from a survey that asked 36 questions about functional health and wellbeing

The researchers reported that women who met the physical activity guidelines as well as those who first began meeting these guidelines when they were 55 had a 3 point higher physical health composite score than women who didn't meet the guidelines.

The study authors said that "women should be active throughout mid-age, ideally increasing activity levels to meet the guidelines by age 55, to gain the most benefits for physical health in later life.

### How much exercise do you need?

The World Health Organization recommends adults should engage in 150 to 300 minutes of moderate intensity aerobic physical activity everv week.

Alternatively, it is recommended adults should do at least 75 to 150 minutes of vigorous intensity aerobic physical activity or an equivalent combination of activity of both moderate and vigorous intensity.

Adults should also engage in muscle strengthening activity two or more days each week.

'We have very good evidence that physical activity is one of the best things women can do to keep themselves healthy throughout their lifespan. It doesn't do us any good to live for many years if we are unable to do all the things we need and want to do to enjoy that time. Movement maintains good joint mobility and muscle strength, improves circulation, in-

creases bone density, and helps prevent major diseases," said Dr. Nicole Yedlinsky, a family medicine and sports medicine physician at The University of Kansas Health System who was not involved in the study.

"When we think about longevity, we don't just want to live longer, we also want to live well," Yedlinsky told Medical News Today. "Quality of life is extraordinarily important. Exercise is fundamentally important to all our body systems: our heart, lungs, brain, gut, joints, bones. and muscles. Regular physical activity is the key piece to minimizing the physiologic decline that normally comes with aging."

Easing in to an exercise routine The researchers found that women who began meeting exercise guidelines at age 55 still received the same benefits as their peers who had been consistently exercising prior to that.

Experts say midlife women, particularly those who are menopausal, should slowly ease in when beginning an exercise routine.

"All the symptoms of menopause can impede a woman's ability to workout. Irregular periods make it hard to know when the best time of day is to work out. Hot flashes and night sweats make the thought of working out and breaking a sweat less desirable. Emotional upheaval including depression and anxiety also prevents trips to the gym or putting on your tennis shoes. Heart palpitations also scare menopausal women from doing any activity that increases the heart rate," said Dr. Sherry Ross, an OB/GYN and women's health expert at Providence Saint John's Health Center

If you have any type of bone loss, especially osteoporosis, associated with aging and menopause, I would avoid exercises that may increase the risk of falling or create instability."

### The challenges of exercising in midlife

While the benefits of physical activity are well established, the study authors note that for many women in this age group life transitions such as marriage, having children, children leaving the family home, retirement, and bereavement can influence activity level. However, experts say it is important that midlife women take the time to prioritize their own

health and quality of life by engaging in regular movement. 'The benefits of consistent exercise in quality of life become more clear when looking at the four functional benefits of many exercises; strength, stamina, flexibility and balance. The loss of any of these four types of physical capacity are hallmarks of physical

infirmity and erosion of quality of life. For people looking forward to enjoying extended work or recreational activities as they age, loss of strength, stamina, flexibility and balance limit the scope of life and are predictors of loss of independent living capacity in older age," said Dr. Charlie Porter, a cardio-oncologist at The University of Kansas Health System who was not involved in the study.

"'Middle aged' women are facing many demands from others and get little encouragement from anyone to take time for their own emotional and physical benefit," Porter told Medical News Today. "This study provides encouragement for women in this stage of life to look at physical exercise for themselves as a way of sustaining and maintaining their own long term health and physical capacity. Applying such ingredients can actually nourish and revitalize the skin powerfully, while others, like tulsi, neem, fenugreek, cinnamon, sandalwood and turmeric have antiseptic, healing and soothing properties.

### Here are a few home-made packs for refreshing and revitalizing the skin:

Make a cold infusion of Hibiscus flowers, by allowing them to stand overnight in cold water. in a ratio of one to six. Next morning crush the flowers. Strain and keep the water. Mix the flowers with 3 teaspoons oats, 2 drops tea tree oil and add the water to mix into a paste. This hibiscus pack helps to cleanse, refresh and tone the skin, adding a glow. Apply on the face and wash off after 20 to 30 minutes.

Take honey and yogurt and add a few tablespoons of red wine. Apply this on the face and leave it on for 20 minutes. Rinse with plain water. This softens and moisturizes the skin, removes tan and also adds a glow.

Avocado pulp can be mixed with aloe vera gel and applied on the face to nourish and moisturize the skin. Wash off with plain water after 20 minutes. Fresh and raw avocado should be used. Avocado contains about 20 vitamins and minerals. It is rich in antioxidants, which help to delay visible signs of skin ageing.

Mix cucumber and ripe papaya pulp with curd and two teaspoons oats. Lemon juice can also be added. Apply on face and neck. Wash it off after half an hour. Helps to remove tan and brighten the skin.

For oily skin, soak one tablespoon moong dal in water for a few hours. Make a paste and add one tablespoon tomato pulp. Apply on face with a light massage. Wash off with water after 20 minutes. Reduces oiliness and brightens the skin.

Take two teaspoons choker (wheat bran), one teaspoon each ground almonds, honey, curd and egg white or rose water. Mix together and apply on the face, avoiding lips and area around eyes. Wash off after 30 minutes.

Allow marigold flowers to stand in warm water overnight. Add yogurt and sandalwood paste and mix together to make a smooth paste. Apply on the face, avoiding the lips and area around eyes.

Wash it off after 20 minutes. Marigold has a soothing and germicidal effect on skin irritation and eruptions. It may be used to control pimples and rashes. It has an astringent effect, reducing oiliness and closing the pores. It is ideal for normal to oily and combination skin.

For dry skin, add red wine to aloe vera gel and dried milk powder. Apply on the face and wash it off after 20 minutes.

Add a few strands of saffron to warm milk and wheat bran (choker). Let it stand for a couple of hours. Then apply it on the face, using cotton wool. It is said to lighten skin colour over a period of time. Mix together three teaspoons cocoa powder and 2 teaspoons oats with egg white and one teaspoon each honey and curd. Adjust the ingredients, so that it is a thick paste, which does not drip. If it is too thin, add more cocoa powder. To make it thinner, add more curd or milk.

# Putin begins his fifth term as president, more in control of Russia than ever

MOSCOW, May 7: Vladimir Putin began his fifth term on Tuesday as Russian leader at a glittering Kremlin inauguration, setting out on another six years in office after destroying his political opponents, launching a devastating war in Ukraine and concentrating all power in his hands.

Ât the ceremony inside the gilded Grand Kremlin Palace, Putin placed his hand on the Russian Constitution and vowed to defend it as a crowd of hand-picked dignitaries looked on. "We are a united and great people and together we will overcome all obstacles, realize all our plans, together we will win," Putin said after being sworn in.

Since succeeding President Boris Yeltsin in the waning hours of 1999, Putin has transformed Russia from a country emerging from economic collapse to a pariah state that threatens global security. Following the 2022 invasion of Ukraine that has become Europe's biggest conflict since World War II, Russia has been heavily sanctioned by the West and is turning to other regimes like China, Iran and North Korea for support.

Already in office for nearly a quarter-century and the longest-serving Kremlin leader since Josef Stalin, Putin's new term doesn't expire until 2030, when he will be constitutionally eligible to run again.

In a heavily choreographed performance,



Putin was pictured in his office looking at his papers before walking along the Kremlin's long corridors, pausing at one point to look at a painting, on the way to his inauguration. His guard of honor waited in the sleet and

rain for hours, in temperatures hovering just above freezing, while Putin headed to the Grand Kremlin Palace in a car. Putin used the first moments of his

fifth term to thank the "heroes" of his war in Ukraine and to rail against the West.

Russia "does not refuse dialogue with Western states," he said. Rather, he said, "the choice is theirs: do they intend to continue trying to contain Russia, continue the policy of aggression, continuous pressure on our country for years, or look for a path to cooperation and peace.'

The Russian leader was greeted with applause when he entered the hall with more than 2,500 people who, his spokesperson Dmitry Peskov said, had been invited to the ceremony. They included senior members of the Russian government as well as celebrities including American actor Steven Seagal.

A French diplomat confirmed the French ambassador attended the inauguration. The diplomat spoke on condition of anonymously because they were not authorized to speak publicly. U.S. Ambassador to Russia Lynne Tracy did not attend and Russian state news agency Tass reported she was out of the country. The question now is what the 71year-old Putin will do over the course of another six years in the Kremlin, both at home and abroad. Russian forces are gaining ground in Ukraine, deploying scorched-earth tactics as Kyiv grapples with shortages of men and ammunition. Both sides are taking heavy casualties.

Ukraine has brought the battle to Russian soil through drone and missile attacks, especially in border regions. In a speech in February, Putin vowed to fulfill Moscow's goals in Ukraine, and do what is needed to "defend our sovereignty and security of our citizens." Shortly after his orchestrated reelection in March, Putin suggested that a confrontation between NATO and Russia is possible, and he declared he wanted to carve out a buffer zone in Ukraine to protect his country from

At home, Putin's popularity is closely tied to improving living standards for ordinary Russians.Putin on Tuesday once again promised Russians a prosperous future, but since the invasion of Ukraine, many have seen their cost of living go up.

Putin began his term in 2018 by promising to get Russia into the top five global economies, vowing it should be "modern and dynamic." Instead, Russia's economy has pivoted to a war footing, and authorities are spending record amounts on defense.

Analysts say now that Putin has secured another six years in power, the government could take the unpopular steps of raising taxes to fund the war and pressure more men to join the military. At the start of a new term, the Russian government is routinely dissolved so that Putin can name a new prime minister and Cabinet.

One key area to watch is the Defense Ministry. Last year, Defense Minister Sergei Shoigu came under pressure over his conduct of the war, with mercenary leader Yevgeny Prigozhin launching withering criticism against him for shortages of ammunition for his private contractors fighting in Ukraine. Prigozhin's brief uprising in June against the Defense Ministry represented the biggest threat to Putin's rule (AP)

# Israeli forces seize Rafah border crossing in Gaza, putting cease-fire talks on knife's edge

CAIRO, May 7: Israeli tanks seized control of Gaza's vital Rafah border crossing on Tuesday as Israel brushed off urgent warnings from close allies and moved into the southern city even as cease-fire negotiations with Hamas remained on a knife's edge.

The foray came after hours of whiplash in the Israel-Hamas war, with the militant group on Monday saying it accepted an Egyptian-Qatari mediated cease-fire proposal. Israel, however, insisted the deal did not meet its core demands. The high-stakes diplomatic moves and military brinkmanship left a glimmer of hope alive - if only barely - for an accord that could bring at least a pause in the 7-month-old war that has devastated the Gaza Strip.

The Israeli incursion overnight appeared to be short of the fullfledged offensive into Rafah that Israel has planned, and it was not immediately known if it would be expanded. The looming operation has raised global alarm over the fate of around 1.3 million Palestinians crammed into the city - and threatened to widen a rift between Israel and its main backer, the United States, U.S. President Joe Biden warned Israeli Prime Minister Benjamin Netanyahu again on Monday against launching an invasion of the city after Israel ordered 100,000 Palestinians to evacuate

Jens Laerke, a spokesman for the U.N. humanitarian affairs office known as OCHA, said Israeli authorities have denied it access to the Rafah crossing. He warned that disruption at Rafah could break the fragile aid operation, saying all the fuel keeping the humanitarian work moving comes through the crossing. "It will plunge this crisis into unprecedented levels of need, including the very real possibility of a famine." he said. The Israeli military "is ignoring all warnings about what this could mean for civilians and for the humanitarian operation across the Gaza Strip."

The military also carried out a flurry of strikes and bombardment across Rafah overnight, killing at least 23 Palestinians, including at least six women and five children, according to hospital records seen by The Associated Press. The Israeli military claimed it seized the Rafah crossing after receiving intelligence it was "being used for terrorist purposes.

The military did not provide evidence to immediately support the assertion, though it said Hamas fighters near the crossing launched a mortar attack that killed four Israeli troops and wounded others Kerem Shalom near Sunday.(AP)

## Two killed, 21 injured in knife attack at hospital in China

BEIJING, May 7: At least two people were killed and 21 others injured in a knife attack at a hospital on Tuesday in China's Yunnan Province, local authorities said, in the latest incident of mass stabbing in the country. The attack took place at around 11:30 am when a man assaulted people with a knife at a local hospital in Zhenxiong County, the county's public security bureau said. The injured are being treated in the hospital, and the case is under investigation, the state-run Xinhua news agency reported.

It is not yet known whether police have subdued the suspect, the Hong Kong-based South China Morning Post reported. China, where private gun ownership is illegal for most civilians, has faced a spate of mass knife attacks in public places in recent years.

In August last year, two people were killed and seven others injured after a man with a history of mental illness attacked people with a knife in a residential district in also Yunnan. In July of that year, six people, including three children, were killed in a stabbing at a kindergarten in the

## Nepal's ruling coalition party splits

KATHMANDU, May 7: The Janata Samajbadi Party-Nepal (JSP-N), one of the coalition partners in Prime Minister Pushpa Kamal Dahal Prachanda-led government, has split after a majority of its lawmakers and over two dozen central committee members applied for a new party at the Election Commission.

A faction of the JSP-N led by the party's federal council chair Ashok Rai registered the application for a new party while the party's chair Deputy Prime Minister Upendra Yadav, who is also minister for health and population, is on a trip abroad.

Pradip Yadav, a lawmaker of the JSP-N, said that 29 central committee members and seven lawmakers have jointly applied to form a new party.

Of the party's 12 House of Representatives members, seven -Rai, Sushila Sherstha, Pradip Yadav, Nawal Kishor Sah, Ranju Kumari Jha, Birendra Mahato and Hasina Khan - have supported the new party named 'Janata Samajbadi Party' (without the 'Nepal' of the mother party).

The Election Commission on Monday officially recognised the Ashok Rai-led Janata Samajbadi Party (JSP) as a new political party.

Party insiders said that Rai registered the new party at the advice of Prime Minister Prachanda to counter Yadav, whose relations with the ruling alliance have soured lately. There are reports Yaday was trying to ally with the opposition Nepali Congress and the ruling party alliance CPN-Unified Socialist-led by Madhav Kumar Nepal after NC President Sher Bahadur Deuba reportedly offered the Prime Minister's post to Yadav to topple the Prachanda-led government.

However, the ruling coalition consisting of the CPN-UML led by K P Sharma Oli and the CPN (Maoist Center) has managed to maintain a narrow majority in the Parliament with the latest political developments.

THE HAGUE, May 7: Police arrested about 125 activists as they broke up a pro-Palestinian demonstration camp at the University of Amsterdam early on Tuesday, as protests that have roiled campuses in the United States spread into Europe.

Police in the Dutch capital said in a statement on the social media platform X that their action was "necessary to restore order" after protests turned violent. There were no immediate reports of injuries.

Video from the scene aired by national broadcaster NOS showed police using a mechanical digger to push down barricades and officers wielding batons and shields moving in to end the demonstration, beating some of the protesters and pulling down tents.

Protesters formed barricades from wooden pallets and bicycles. NOS reported. Scores of demonstrators occupied small island at the university on Monday, urging Amsterdam universities to break academic ties with Israel because of its offensive in Gaza in the aftermath of the deadly Oct. 7 attacks by Hamas militants in southern Israel.

There have also been demonstrations in recent days at campuses in France and the United Kingdom. Photos from the Amsterdam campus Tuesday morning showed tents, banners and food along with piles of cobblestones that had been pulled up from the street.

Before police moved in, scuffles broke out Monday night between two rival groups of activists. Police said in a statement that they cleared the makeshift camp after the protesters refused repeated orders to leave.

BELGRADE, May 7: Chinese leader Xi Jinping's visit to European ally Serbia on Tuesday falls on a symbolic date: the 25th anniversary of the bombing of the Chinese Embassy in Belgrade during NATO's air war over Kosovo.

"The Chinese people value peace but will never allow historical tragedies to happen again," Xi added. The Western military alliance had launched the air war in March that year to force then Serbian strongman Slobodan Milosevic to end a brutal onslaught against ethnic Albanian rebels in Kosovo

The U.S. at the time apologized and said the embassy bombing was a mistake that happened due to faulty intelligence. The intended target. Washington said, was the headquarters of a Serbian state arms exporter located on the same

street, a few blocks away. "Imagine that somebody would, even by accident, strike an American Embassy somewhere around the world. The reaction would be immediate," said Sven Biscop, a professor of European foreign and security policy at the Ghent University and Egmont Institute.

Barnsdall area were damaged, the Oklahoma Highway Patrol reported, and the state Department of Health reported a nursing home was damaged and patients were being evacuated. A natural gas leak and numerous road closings due to debris also were reported, according to Osage

Czech Republic's top court rules that surgery is not required to officially change gender

PRAGUE, May 7: The Czech Republic's highest court on Tuesday ruled to dismiss part of a law requiring people to undergo gender-affirmation surgery, including sterilization, in order to officially change their gender.

The Constitutional Court said the requirements are "unconstitutional" and "in conflict with the fundamental right of trans people to have protected their physical integrity and personal autonomy in connection with their human dignity.

Only two of the court's 15 judges opposed the verdict, which cannot be appealed. Lawmakers must change the affected sections of the law by the middle of next year.

The court ruled at the request of a person who was seeking a gender change. The authorities refused to register him as a man because he had not undergone surgery.

"It is important for the people of the country to know that the BJPled NDA already has 400-plus seats in Parliament. We used this number to scrap Article 370 (which provided special status to Jammu and Kashmir)," the PM said.

"Modi wants 400 seats so that the Congress won't bring back Article 370 to spoil the game, Modi wants 400 seats so that the Congress won't put a Babri lock on the Ram temple in Ayodhya," he said. The PM said that about 14 days

# Kejriwal fails to get immediate relief from SC in money laundering case

NEW DELHI, May 7: Delhi chief minister Arvind Kejriwal failed to get any relief from the Supreme Court on Tuesday, with a twojudge bench rising without pronouncing an order on granting him interim bail to enable him to campaign in the Lok Sabha elections.

Kejriwal has been accused of money laundering in a case linked to the alleged Delhi excise scam. A bench of Justices Sanjiv Khanna and Dipankar Datta, which reserved its order on grant of interim bail earlier during the day and said it will be pronounced at 2 p.m., rose without delivering its verdict.

The bench reserved its decision after hearing the arguments put forth by senior advocate Abhishek Singhvi and Additional Solicitor General S V Raju, who appeared for Kejriwal and the Enforcement Directorate, respectively.

Solicitor General Tushar Mehta, who also appeared for the probe agency, staunchly opposed showing any leniency to Kejriwal on account of the Lok Sabha polls and said

granting interim bail to the Aam Aadmi Party (AAP) national convenor would amount to creating a separate class for politicians.

The bench has divided the hearing on Kejriwal's petition against his arrest into two parts. His main petition challenges his arrest by the ED and seeks it to be declared as illegal, while the second aspect pertains to grant of interim bail keeping in mind the ongoing Lok Sabha polls. The court has reserved the order on the issue of grant of interim bail. Before rising for the day, the bench indicated that tomorrow the judges will be sitting in different combinations, and if the hearing on matters listed for Wednesday gets completed and the judges have time in hand, they would resume hearing Kejriwal's plea against his arrest by the ED.

"If not tomorrow, then we may take up the matter on Thursday. If not on Thursday, then we will be taking up this matter next week," said Justice Khanna, without specifying any

time frame for pronouncement of verdict on the issue of interim bail.

Meanwhile, a Delhi court extended Kejriwal's judicial custody in the money laundering case till May 20.

Kejriwal was arrested on March 21 and is currently lodged in Tihar Jail under judicial custody. Prasad spoke to PTI-Video here after his remarks on reservation benefits for the minority community earlier in the day kicked up a storm and drew flak from Prime Minister Narendra Modi

"Should not Muslims too get reservations (aarakshan to milna chahiye na Muslamanon ko", was Prasad's terse reply to journalists when they asked him about allegations by Modi and other BJP leaders that the RJD and its allies like the Congress wanted to extend quota benefits to the minority community, depriving OBCs, Dalits and tribals of their due.

The RJD supremo's remark came under attack from Modi at a rally in Madhya Pradesh where he tore into the former chief minister of Bihar, whom he did not mention by name.

"A person who has serving sentences for

cause of poor health, has said just a few hours ago that reservations should be given to Muslims. The gentlemen is revered by the Congress. Just look at their brazenness", Modi said at the rally.

He also alleged "what they imply is that not just a portion, but the entire quotas should be given away to Muslims", adding that this was because of "politics of appeasement" practiced by INDIA bloc.

Reacting to the PM's outbursts, Prasad said in his typical style, "I am senior to Narendra Modi (in politics). He does not know many things that I know. It was during my reign Mandal Commission recommendations were implemented (in Bihar)".

"There are hundreds of social groups which got reservations as per the Mandal Commission report. But it was done not on the basis of religion. In the Constitution, there is no provision for reservations on religious basis", Prasad told PTI video.

He also alleged "Narendra Modi and his party want to scrap the Constitution and do away with reservations. This is proven by the fact that the previous BJP government headed by late Atal Bihari Vajpayee had set up a commission to review the Constitution". (PTI)

NEW DELHI, May 7: Terming the alleged recruitment scam in West Bengal "systemic fraud", the Supreme Court on Tuesday said authorities were dutybound to maintain the digitised records pertaining to the appointment of 25,753 teachers and non-teaching staff. A bench comprising Chief Justice D Y Chandrachud and Justices J B Pardiwala and Manoi Misra was hearing a batch of petitions challenging the Calcutta High Court's April 22 decision that invalidated the appointment of 25,753 teachers and non-teaching staff in staterun and state-aided schools of West Bengal.

"The public job is so scarce.... Nothing remains if the faith of the public goes. This is systemic fraud. Public jobs are extremely scarce today and are looked at for social mobility. What remains in the system if their appointments are also maligned? People will lose faith, how do you countenance this?" the CJI asked the lawyers representing the state government. The bench said the state government has nothing to show that the data was maintained by its authorities and asked about its availability. "Either you have the data or you do not have it.... You were duty-bound to maintain the documents in digitised form. Now, it is obvious that there is no data. You are unaware of the fact that your service provider has engaged another agency. You had to maintain supervisory control," the bench told the state government's lawyers. (PTI)

## Telangana CM violated poll code, defer Rythu Bharosa payment: EC

NEW DELHI, May 7: The Election Commission on Tuesday directed the Telangana government to defer payments under the Rythu Bharosa scheme till Lok Sabha polls are held in the state on May 13, saying chief minister Revanth Reddy violated the model code of conduct by referring

to the payouts in his public speeches. In a letter to the Telangana chief electoral officer, the Commission said Reddy had violated the model code of conduct by publicly speaking about the ensuing disbursement under the scheme on or before May 9. Elections to all 17 Lok Sabha seats in Telangana will be held in the

fourth phase on May 13. "In the above premise and clear violation of Model Code of Conduct by Revanth Reddy, President Telangana Pradesh Congress Committee and star campaigner and Chief Minister, the Commission has directed that disbursement of balance instalment under the Rythu Bharosa scheme for Rabi season of 2023 will be effected only after completion of

poll in the state of Telangana on

13.05.2024," the Commission said. It also expressed concern over attempts to politicise the ongoing scheme during the elections and held that such actions were deemed as attempts to influence voters and disturb the level playing field.

The commission noted that similar directives were issued for the Rayathu Bandhu scheme during the Telangana assembly elections in 2023 on the condition that no new beneficiaries will be added to the scheme and the disbursement of instalments will be done without any publicity. The commission had asked the the Telangana government to make payments through bank transfers and that no public function or political functionary will be involved in the process. The scheme has been renamed as Rythu Bharosa by the Congress government in Telangana.

The EC noted that a minister of the erstwhile BRS government too had violated the model code of conduct by attempting to take credit for the scheme's disbursement during the election period. (PTI)

# West Nile fever in Kerala: State govt orders all districts to be vigilant

THIRUVANANTHAPURAM, May 7: The Kerala government on Tuesday said that West Nile fever cases have been reported from Thrissur, Malappuram and Kozhikode districts of the state.

State Health Minister Veena George, in a statement, confirmed that cases of the viral infection have been reported in the state and that all the districts have been asked to be vigilant.

As part of the vigil against the viral fever, spread by the Culex species of mosquitoes, the Minister has ordered that steps be taken for mosquito control by destroying their breeding grounds, the statement said.

The minister said that there was no need to be concerned, but requested anyone showing signs of fever or other symptoms of the West Nile infection to seek treatment immediately

The main symptoms of West Nile infection are headache, fever, muscle aches, dizziness and loss of memory, but most patients do not experience these, she said

Some people experience symptoms like fever, headache, vomiting and itching and in one per cent of the cases, it can lead to brain damage resulting in unconsciousness and sometimes death, the minister's statement said.

But the death rate is relatively low compared to Japanese encephalitis which shows similar symptoms and is more dangerous.



It said that instructions to begin pre-monsoon cleaning activities were already given in a high-level meeting held last week and now the District Medical Officers (DMOs) have been directed to further intensify the same.

As there is no medicine or vaccine available against West Nile virus, symptomatic treatment and prevention are key, the minister said.

As part of the preventive measures, she suggested wearing clothing that completely covers the body, use of mosquito nets and repellants and keeping one's home and surroundings clean.

Earlier in the day, Kozhikode district health officials confirmed reports of five cases of West Nile fever there. The infected persons, which included children, are all

fine now and back at their homes with no new cases reported from the areas they live in, an official of the Kozhikode district surveillance team said.

He also said that presently there was one person who is suspected of suffering from the vector-borne infection and is undergoing treatment.

The official said that the samples of those who exhibited symptoms of the disease and had undergone treatment were sent to the National Institute of Virology in Pune as a routine exercise.

"The results came back now and indicated that they were suffering from West Nile fever. They are all better now," he said

The West Nile fever is spread by the Culex species of mosquitoes. It was first detected in 1937 in Uganda.

The fever was first detected in Kerala in 2011 and a sixyear-old boy from Malappuram died due to the fever in 2019.

Thereafter, in May 2022, a 47-year-old man died of the fever in Thrissur district.

# <u>Rohit will lead India in the next month's 20-team global showpiece</u> 'Fatigued' Rohit needs break to freshen up ahead of T20I World Cup: Michael Clarke

MUMBAI, May 7: Former Australia captain Michael Clarke does not read much into Rohit Sharma's string of poor scores, but suggests that the "fatigued" Indian skipper take a break to freshen up ahead of the T20I World Cup. Rohit, who will lead India in the next month's 20-team global showpiece, has four single-digit scores in his last five outings for his franchise Mumbai Indians in the ongoing IPL.

The 37-year-old has had a busy season this year with an intense five-Test series preceding the IPL for Mumbai Indians, who are all but eliminated from the race to the playoffs this year. "Rohit, being the wise judge of his own performances, will undoubtedly be disappointed, especially considering his strong start. In my view, he might be feeling a bit fatigued as well," Clarke told Star Sports.

"A break to freshen up could do wonders for him, but as the Indian captain and a key player for Mumbai Indians, you're not getting a break. He's going to have to

find form," Clarke continued. Rohit played as an impact substitute in their match against Kolkata Knight Riders last week. raising some concerns for the In-

dian camp However, he played a full game against Sunrisers Hyderabad three days later. Clarke said it is only a matter

of time before Rohit gets back to his usual elements as a batter. "He was in a great mood. He's

happy, which is a really good sign. He doesn't seem to be struggling with his timing; it's just a matter of getting out," he said. "With someone like Rohit, it's only a matter of time before he finds his form again. Hopefully, he stresses less and focuses on his
