# Kejriwal gets 21-day interim respite Apex court bars Delhi CM from visiting office, signing files • AAP's LS poll campaign receives a boost

NEW DELHI, May 10: In a big relief to embattled Delhi chief minister Arvind Kejriwal, the Supreme Court on Friday granted him interim bail in a money laundering case at the peak of the election season but barred him from visiting his office or the Delhi secretariat and signing official files unless absolutely necessary for obtaining the lieutenant governor's approval.

Setting him free for 21 days to campaign for the remaining phases of the Lok Sabha elections after 50 days of custody in the money laundering case linked to the alleged Delhi excise scam, the court said he shall surrender on June 2, a day after the last phase of the sevenphase poll gets over.

The fourth phase of polling will be held on May 13.

A wave of jubilation swept across the INDIA bloc parties as the news spread like wildfire, with his AAP terming it a "triumph of

The court did not concur with his contention that interim bail to the AAP national convenor for campaigning would be like giving "premium of placing the politicians in a benefic position compared to ordinary citizens of this country".

"While examining the question of grant of interim bail/release, the courts always take into consideration the peculiarities associated with the person in question and the surrounding circumstances. In fact, to ignore the same would be iniquitous and wrong," the bench said, adding that the Lok Sabha elections are the "most significant and an important event this year".

The bench said no doubt, serious accusations have been made, but Keiriwal has not been convicted yet, does not have any criminal antecedents and is "not a threat to the society". It noted that more importantly, the legality and validity of his arrest (CONTD. ON PAGE-2)

LONDON, May 10: The British economy bounced back strongly in the first three months of the year, bringing to an end to what economists termed a "technical recession", official figures showed Friday. The Office for National Statistics said the economy grew by 0.6 per

cent in the first quarter from the previous three-month period, with broadbased strength across the crucial services sector in particular. The increase was higher than the 0.4 per cent predicted by economists and the strongest since the fourth quarter of 2021 when the economy was

itself was under challenge before the top court which is yet to finally pronounce its verdict on it.

"The factual situation cannot be compared with harvesting crops or pleading to look after business affairs. In this background, once the matter is subjudice and the questions relating to legality of arrest are under consideration, a more holistic and libertarian view is justified, in the background that the 18th Lok Sabha General Elections are being held," the bench said. Ruling that Kejriwal's case is "not an exception", the bench said power to grant interim bail is commonly exercised in a number of cases and interim bail is granted keeping in mind the facts of each case. "For the aforesaid reasons, we direct that the appellant – Arvind Kejriwal will be released on interim bail in connection with case... till June 1, 2024, that is, he will surrender on June 2, 2024 on the following terms and conditions...," the bench said, adding, "he shall not visit the office of the Chief Minister and the Delhi secretariat".

"He (Kejriwal) shall be bound by the statement made on his behalf that he shall not sign official files unless it is required and necessary for obtaining clearance/approval of the Lieutenant Governor of Delhi," the court said. Kejriwal will not make any comment with regard to his role in the case and will not interact with any of the witnesses or have access to any official files connected with the case, the bench directed

The top court said the ongoing Lok Sabha elections has prompted the consideration of interim bail to Kejriwal as at this stage, it is not possible for the court to either conclude the arguments or finally pronounce the verdict

on his plea challenging his arrest. "As the appeal is pending before us, we do not think it would be proper for us to direct the appellant - Arvind Kejriwal to approach the trial court for interim bail/release. This may not be apt in view of the legal issues and

contentions that are under examination and consideration before us," it said. "Between 650-700 million voters out of an electorate of about 970 million will cast their votes to elect the

#### **BJP's stronghold** in North East states

The recently concluded Lok Sabha elections in the northeastern states have underscored the Bharatiya Janata Party's (BJP) continued dominance in the region. Despite initial concerns over potential unrest, the polling process unfolded smoothly across the eight states, with only minor incidents reported, primarily in Manipur. This overall tranquillity has been met with relief both within BJP circles and among central authorities in Delhi. The BJP's success in the region can be attributed to several factors. Moreover, the BJP's stance against what it perceives as "Muslim appeasement" has remained a contentious issue, fuelling debates over communal politics. Despite criticisms, the BJP's unwavering stance seems to have found favor with a significant portion of the electorate, contributing to its electoral gains. Crucially, the BJP's efforts to address security concerns and engage with separatist groups have bolstered its standing in the region. Agreements with organizations like the UNLF and ongoing peace dialogues with insurgent groups signal a commitment to stability, a factor not lost on voters. Looking ahead, the BJP remains optimistic about its prospects in the Northeast.

Minor setbacks notwithstanding, the party's commitment to development, security, and inclusive governance continues to resonate with voters, ensuring its continued dominance in the Northeast. The BJP's performance in the Northeastern states reaffirms its status as a formidable political force in the region. As the dust settles on the electoral process, the party's focus on governance and engagement remains steadfast, setting the stage for continued success in the years to come. #### ceasefire amidst short-lived celebrations By: James M Dorsey

This week's Gazan shortbe, highlights what is at stake in the seven-month-old war and Israel's refusal to end the carnage. Thousands poured into Gazan streets within minutes of Hamas advising it had accepted a Qatar and Egyptian ceasefire proposal.

"We have shown the world that we survived this war as Palestinians. We stood our ground on our land. We survived 212 days of attacks and devastation by the world's most advanced weapons. We did not leave. We survived on our own with no help from outside," said Ahmad, a young Gazan, one of the thousands celebrating in the streets of Rafah Hamas' acceptance of a ceasefire with Israel.

The celebrations were shortlived. They dissipated 90 minutes later as Israel made clear its rejection of the proposal.

"The Hamas proposal is far from meeting Israel's core demands," Israeli Prime Minister Binyamin Netanyahu's office said in a statement.

Not to be painted as the party pooper, the statement added that Israel would "dispatch a ranking delegation to Egypt in an effort to maximize the possibility of reaching an agreement on terms acceptable to Israel.'

Netanyahu is going through the motions as he lays the groundwork for what could be a final major offensive in the southern Gazan enclave of Rafah against Hamas that could determine his chances of political survival. Rafah is Netanyahu's desperate attempt at achieving war goals he has failed to realise in seven months of unrelenting military operations at an unspeakable cost to innocent Palestinians.

These goals include the destruction of Hamas, symbolised by the elimination of its military force; the killing or capture of its top leadership; the release of the remaining Hamas-held hostages kidnapped by the group during its October 7 attack on Israel: and ensuring that Gaza will be longer serve as a launching pad for Palestinian re-

Hamas continues to play whack-a-mole with Israel despite having suffered severe lived celebration of a losses. The group's Gaza-based ceasefire that was not to leadership remains intact and in control, and roughly half of the 250 people initially kidnapped by Hamas were freed as a result of a one-week ceasefire in November, not because of Israeli military action.

Moreover, Israel believes that Hamas' leadership, including Yahya Sinwar, Israel's most wanted man, is hiding in tunnels under Rafah shielded by the remaining hostages.

Even so, Netanyahu is living politically on borrowed time, irrespective of whether he succeeds in Gaza or not. Israeli opinion polls suggest that Netanyahu and his ultra-nationalist, ultra-conservative coalition partners would lose the next

Hundreds of angry protesters in Tel Aviv and Jerusalem denounced the government's rejection of the ceasefire proposal. They called on Netanyahu to prioritise the release of Hamasheld hostages by accepting the

Instead, Israeli forces on Tuesday took control of the Rafah side of the Gaza-Egyptian border and closed the border crossing crucial to the flow of desperately needed humanitarian supplies in the Strip as Israeli tanks pushed into the city of Rafah itself.

Netanyahu's rejection of the deal while going through the motions of negotiations and his impending Rafah offensive, at best, buys him time.

Even so, by accepting a ceasefire, Hamas threw a curveball at Netanyahu as well as the Biden administration. The acceptance put the shoe

on. Netanyahu's foot and the administration on the spot. The Biden administration has repeatedly publicly opposed a massive military operation in Rafah, home to more than a million Palestinians displaced by the

The irony is that Hamas offered Netanyahu and the administration a way out by leaking details of the ceasefire and prisoner exchange proposal it had accepted that made clear that it



was not a deal Israel would accept. At the same time, it allowed Hamas to project itself as engaging constructively in ne-

The leaks suggested, against all evidence from Jerusalem, that Israel would agree to a permanent rather than a temporary ceasefire, an end to the war, and a complete Israeli withdrawal

They also inferred that US President Joe Biden had accepted Hamas' demand that the United States would guarantee implementation of the deal.

The essential aim of the deal is a permanent ceasefire and full withdrawal" of Israeli forces from Gaza, senior Hamas negotiator Khali al Hayaa told Al Jazeera. "We did what we are supposed to do. The onus is on the mediators and the international community," Al-Hayya added

Hamas' acceptance of a ceasefire proposal it knew Israel would reject raises the tantalising question of whether Netanyahu may not be the only one allegedly wanting to prolong the war for personal political gain. The same could be true for his nemesis, Sinwar, even if one can also wonder why he would agree to a deal that gives license to Israel's effort to destroy Hamas by agreeing to a postceasefire continuation of the

Nevertheless, the short-lived Gazan celebrations and the fact that a ceasefire means to Gazans more than just an end to the death, destitution, and destruction in the Strip suggests that it could create a reckoning not only for Netanyahu but also for Sinwar.

Gazans want to extract a price for the suffering inflicted upon them. The devastation of their lives has not dampened Palestinian national aspirations, even if they are desperate for immediate relief. Even so. Sinwar and Hamas are feeling the heat of growing criticism of the group for provoking the Israeli assault that has devastated Gaza and reduced its 2.3 million inhabitants to destitution.

In late March, Hamas felt compelled to issue a lengthy statement apologising to Gazans for their suffering, despite 52 per cent of Gazans favouring a return to post-war Hamas rule as opposed to the West Bankbased, internationally recognised Palestine Authority, an Arab peacekeeping force, the United Nations, or Israel.

It's a choice between what Palestinians perceive as bad alternatives. It also opts, against all odds, for the party most vigorous in defending Palestinian rights and aspirations.

Prominent Israeli columnist Anschel Pfeffer argued that "it is looking increasingly unlikely that Hamas' chief in Gaza and the man who calls the shots on any deal, Yahya Sinwar, is prepared to agree to any compromise that Prime Minister Benjamin Netanyahu can accept. Both men are determined to emerge with a perception of victory in their grasp – but there doesn't appear to be any framework in which the two can have that."

Even so, Pfeffer noted, "Israelis and Gazans aren't stupid. Most of them have conceded that they have lost too much for there to be any notion of 'victory' in this war. But as long as their fates are controlled by two men who insist on being the victor at any cost, this war is going to continue." (IPA Service)

The final draft drops the language that would put Palestine "on equal footing with member states." And to address Chinese and Russian concerns, it would decide "on an exceptional basis and without setting a precedent" to adopt the rights and privileges in the

#### Iranians vote in parliamentary runoff election after hard-liners dominate initial balloting TEHRAN, May 10: Iranians voted

on Friday in a runoff election for the remaining seats in the country's parliament after hard-line politicians dominated March balloting.

People in 22 constituencies across the country will elect 45 representatives from a pool of 90 candidates, 15 of whom are considered moderate.

In the capital, Tehran, 16 representatives will be chosen from 32 candidates, all hard-liners. Final results are expected on Monday, though counts in smaller constituencies are likely before that.

Iran's parliament plays a secondary role in governing the country. Supreme Leader Ayatollah Ali Khamenei has the final say in all important state matters.

State TV showed Khamenei voting on Friday immediately after the polls opened. He urged people to vote and said the runoff election was as important as the main one. In the March election, hard-liners

won 200 out of 245 seats, with more moderate candidates taking the other A total of 25 million ballots were

#### **Putin reappoints his prime** minister, a technocrat who has kept a low political profile

MOSCOW, May 10: Russian President Vladimir Putin reappointed Mikhail Mishustin as the country's prime minister on Friday, a widely anticipated move to keep on a technocrat who has maintained a low political profile.

Mishustin and other technocrats in the Cabinet have been credited with maintaining a relatively stable economic performance despite bruising Western sanctions for Russia's role in Ukraine. Most other Cabinet members are expected to keep their jobs, though the fate of Defence Minister Sergei Shoigu appeared uncertain.

In line with Russian law, Mishustin, 58, who held the job for the past four years, submitted his Cabinet's resignation on Tuesday when Putin began his fifth presidential term at a glittering Kremlin inauguration.

Mishustin, the former head of Russia's tax service, steered clear of political statements and avoided media interviews during his previous tenure. The speaker of the parliament's lower house, Vyacheslav Volodin, announced that Putin submitted Mishustin's candidacy to the State Duma, which will hold a session later Friday to consider it.

Under the constitutional changes approved in 2020, the lower house approves the candidacy of the prime minister, who then submits Cabinet members for approval. The changes were ostensibly meant to grant parliament broader power, but the procedure is widely seen as pro forma given Kremlin control over the body.

Most Cabinet members are expected to keep their jobs, but it was



not clear if Shoigu, the defence minister, would be among them after last month's arrest of his top associate, Timur Ivanov. Ivanov, who served as deputy defence minister in charge of massive military construction projects, was arrested on bribery charges and was ordered to stay in custody pending official investigation.

The arrest of Ivanov was widely interpreted as an attack on Shoigu and a possible precursor of his dismissal despite his close personal ties with Putin. Shoigu was broadly criticised for Russian military's setbacks in the early stage of the fighting in

He faced scathing attacks from mercenary chief Yevgeny Prigozhin, who marched on Moscow nearly a year ago to demand the ouster of Shoigu and the chief of the General Staff, Gen. Valery Gerasimov.

After Prigozhin's death in a suspicious plane crash two months after the rebellion — widely seen as the Kremlin's revenge — Shoigu appeared to shore up his position. But Ivanov's arrest, interpreted by many as part of Kremlin's political infighting, again exposed Shoigu's vulnera-

#### India votes in favour of UNGA resolution supporting Palestine's bid to become full UN member

**UNITED NATIONS, May 10:** India on Friday voted in favour of a draft UN General Assembly resolution that said Palestine is qualified and should be admitted as full member of the United Nations and recommended that the Security Council "reconsider" the matter "favourably".

The 193-member General Assembly met in the morning for an emergency special session where the Arab Group resolution 'Admission of new Members to the United Nations', in support of the State of Palestine's full membership in the UN, was presented by the United Arab Emirates, as Chair of the Arab Group in May.

The resolution got 143 votes in favour, including by India, nine against and 25 abstentions. The UNGA hall broke into an applause after the vote was cast.

The resolution determined that "the State of Palestine is qualified for membership in the United Nations" in accordance with Article 4 of the Charter of the United Nations and "should therefore be admitted to membership in the United Nations".

It recommended that the Security Council "reconsider the matter favourably, in the light of this determination"

India was the first non-Arab State to recognise the Palestine Liberation Organisation as the sole and legitimate representative of the Palestinian people in 1974. India was also one of the first countries to recognise the State of Palestine in 1988 and in 1996, Delhi opened its Representative Office to the Palestine Authority in Gaza, which was later shifted to Ramallah in 2003.

Earlier this month, India's Permanent Representative to the UN



Ambassador Ruchira Kamboj had said that while Palestine's application for membership at the UN was not approved by the Security Council because of the veto in the UNSC, "I would like to state here at the very outset that in keeping with India's long-standing position, we hope that this would be reconsidered in due course and that Palestine's endeavour to become a member of the United Nations will get endorsed".

An annex to the resolution said that the additional rights and privileges of participation of the State of Palestine will be effective as of the 79th session of the General Assembly that begins in Septem-

These include the right to be seated among member states in alphabetical order; the right to make statements on behalf of a group, including among representatives of major groups; the right of members of the delegation of the State of Palestine to be elected as officers in the plenary and the Main Committees of the General Assembly and the right to full and effective participation in UN conferences and international conferences and meetings convened under the auspices of the General

Palestine, in its capacity as an observer state, does not have the right to vote in the General Assembly or to put forward its candidature to UN organs.

In April, Palestine had sent a letter to UN Secretary-General Antonio Guterres requesting that its application for full UN membership be considered again. For a state to be granted full UN membership, its application must be approved both by the Security Council and the General Assembly, where a two-thirds majority of the members present and voting is required for the state to be admitted as a full member.

Last month, the US had vetoed a resolution in the Security Council on the Palestinian bid to be granted full membership of the United Nations. The 15-nation Council had voted on a draft resolution that would have recommended to the 193-member UN General Assembly "that the State of Palestine be admitted to membership in the United Nations".

The resolution got 12 votes in its favour, with Switzerland and the UK abstaining and the US casting its veto. To be adopted, the draft resolution required at least nine Council members voting in its favour, with no vetoes by any of its five permanent members -China, France, Russia, United Kingdom and United States.

Currently, Palestine is a "nonmember observer state" at the UN, a status granted to it by the General Assembly in 2012. This status allows Palestine to participate in proceedings of the world body but it cannot vote on resolutions. The only other non-member observer state at the UN is the Holy See, representing the Vati-

#### Prince Harry, Meghan arrive in Nigeria to champion the Invictus Games and meet with wounded soldiers

ABUJA, May 10: Prince Harry and his wife, Meghan, arrived in Nigeria on Friday to champion the Invictus Games, which he founded to aid the rehabilitation of wounded and sick service members and veterans, among them Nigerian soldiers fighting a 14-year war against Islamic extremists.

The couple, visiting the West African nation for the first time on the invitation of its military, arrived in the capital, Abuja, early in the morning, according to defence spokesman Brig. Gen. Tukur Gusau.

Harry and Meghan will be meeting with wounded soldiers and their families in what Nigerian officials have said is a show of support to improve the soldiers' morale and wellbeing. "This engagement with Invictus is giving us the opportunity for the recovery of our soldiers," Abidemi Marquis, the director of sports at Nigeria's Defense Headquarters, told reporters on Thursday.

Harry served in Afghanistan as an Apache helicopter copilot gunner, after which he founded the Invictus Games in 2014 to offer wounded veterans and servicemembers the challenge of competing in sports events similar to the Paralympics. Nigeria was among the nations that participated in

last year's edition of the games. During their stay, they will attend basketball and volleyball matches and will meet with local non-governmental organizations in Abuja and Lagos that are receiving support from them. Meghan will also co-host an event on women in leadership with Ngozi Okonjo-Iweala, Director Gen-

#### Imran Khan's wife Bushra Bibi's right to life violated in sub-jail: Pak high court

ISLAMABAD, May 10: A Pakistani high court has concluded that the state transgressed the right to life of former premier Imran Khan's wife Bushra Bibi by confining her at her private residence designated as a sub-jail and depriving her of interaction with other prisoners, a media report said on Friday.

On Wednesday, the Islamabad High Court (IHC) ordered the former first lady's transfer to the high-security Adiala Jail in Rawalpindi, where her 71-yearold husband Khan has been jailed. Bushra Bibi, 49, had been incarcerated at Bani Gala, the Pakistan Tehreek-e-Insaf (PTI) party founder's mansion in the suburbs of Islamabad, after conviction in two cases, while Khan was kept at the Adiala Jail.

On Thursday, the IHC issued a 15-page written order in which it said that the state has not just made the sentence of simple imprisonment harsher and heavier but has also violated Bushra Bibi's right to life guaranteed under Article 9 of the Constitution, The Express Tribune newspaper reported.

The mere fact that the room where the petitioner [Bushra Bibi was confined in the subjail [was] guarded by a prison ward [did] not mean that the petitioner [was] not in isolation," it said. Asserting that it has the power and responsibility to intervene and protect the prisoner against inter alia harsher restraints and heavier severities



handed out to Bushra Bibi had already been suspended. It also noted that a seven-year

sentence given to her in another case was simple imprisonment.

"By keeping her in isolation at the sub-jail and depriving her of interaction with other prisoners, the state has not just made the sentence of simple imprisonment harsher and heavier but has also transgressed the petitioner's right to life guaranteed under Article 9 of the Constitution," it

The court noted that the entire Bani Gala was declared a subjail, implying that the property could not be freely accessed by either Bushra Bibi's or her husband's children or family memunless specifically permitted by the superintendent or the court.

"In other words, the impugned notification dated 31.01.2024 [of Islamabad commissioner] has had the effect of requisitioning the said property in its entirety. The said property

is admittedly in the use of government officials who have been assigned [its] responsibility of internal and external security," it said. There was nothing on the record to show that the property owner's consent was obtained before the notification's issuance, it said.

"In this way, the state deprived the owner of Khan House of his fundamental right enshrined in Article 24 of the Constitution and [remained] under an obligation to adequately compensate him for such depriva-

In its order on Wednesday, the court announced the notification to declare Bani Gala, a sub-jail, "null and void. Bushra Bibi was arrested on January 31 this year after an Islamabad accountability court sentenced her and Khan to 14 years in jail in the Toshakhana corruption case.

While their sentences in the Toshakhana corruption case were suspended by the IHC, Bushra Bibi remains in custody in the 'un-Islamic' marriage case. while Khan also remains incarcerated in other cases. (PTI)

#### Heavy fighting in Gaza's Rafah keeps aid crossings closed, sends 100,000 civilians fleeing RAFAH, May 10: Heavy fighting between

Israeli troops and Palestinian militants on the outskirts of the southern Gaza city of Rafah has left crucial nearby aid crossings inaccessible and caused over 100,000 people to flee north, a United Nations official said on Fri-

Israel's plans for a full-scale invasion of Rafah appear to be on hold for now, with the United States deeply opposed and stepping up pressure by threatening to withhold arms. But even the more limited incursion launched earlier this week threatens to worsen Gaza's humanitarian catastrophe. Heavy fighting was also underway in northern Gaza, where Hamas appeared to have once again regrouped in an area where Israel has already launched punishing assaults.

Over a million Palestinians have fled to Rafah to escape fighting elsewhere, with many packed into UN-run shelters or squalid tent camps. The city on the border with Egypt is also a crucial hub for bringing in food, medicine, fuel and other goods.

The UN's Office for the Coordination of Humanitarian Affairs, known as OCHA, says about 110,000 people have fled Rafah and that food and fuel supplies in the city are critically low.Georgios Petropoulos, an OCHA official working in Rafah, said the two main crossings near the city remain closed, cutting off supplies and preventing medical evacuations and the movement of humanitarian staff.

"Urgent request for declaring the unprecedented... hailstorm with strong winds on May 5, as a natural disaster and grant for immediate relief of minimum ₹ 200 crore for the affected people of Manipur in a time bound manner," state Congress president K Meghachandra said in a letter to Prime Minister

The people have not experienced a natural disaster of such magnitude in the history of the state, he said. Addressing a press conference near the residence of an affected family in Imphal West district,

Meghachandra asked why the state government has

not pressured the Centre on the issue. "The amount sanctioned by the state government is not sufficient to cover the losses of the people" he said, alleging that the state government has not apprised the Centre of the situation.

DIMAPUR, May 10: The Dimapur police on Friday alerted the public on money-snatching gangs/cliques and revealed their modus operandi.

The alert was issued following numerous complaints reported across police stations of commissionerate districts of Dimapur such rip off by the money-snatching gangs operating in around Dimapur and neighbouring states.

The Dimapur DCP (crime), in a release, said investigation into such frequently reported cases has unraveled the modus operandi of this currency snaffle syndicate. The release said surveillance and observation revealed that one or two gang members go inside the banks posing as customers and scan for potential

Then they zero down attention to lone, elderly, vulnerable customers making withdrawals. Thereafter, the selected target is shadowed and information passed on to gang members deployed outside the bank. Once the cash withdrawal is completed and the customer leaves the bank, outside gang members are signaled and alerted.

The gang members then distract and divert attention of the target costumer by secretly spraying colouring /itchy chemicals, or deliberately dropping of cash notes/wallets and informing the victim that their cloth-



When the target is temporarily distracted by such attention diversion techniques, another gang member quietly snatches the cash or personal belongings and disappears. The release said the initial investigation has indicated that these are inter-state gangs mostly based in neighbouring districts of Assam.

It added that all available CCTV footages have been examined and efforts are on to identify the persons involved. The Dimapur police released the captured images of the suspects and urged to share information with them on the identity and other details of the suspects in the interest of investigation.

On the incidents in Sandeshkhali in North 24 Parganas district, where allegations of sexual abuse against TMC leaders have been made. Shah aid it is a matter of shame that "Mamata Banerjee, despite being a woman chief minister, tried to protect the culprits"

"In Sandeshkhali, TMC leaders tortured hundreds of our sisters based on religion. Mamata Didi was not ready to arrest the criminals of Sandeshkhali. Even after the high court's order, the investigation was not done, so the high court handed over the probe to the CBI," he said

Shah also said, "Whoever has atrocities committed Sandeshkhali, even if he hides in the underworld, we will find him and put him in prison? The BJP will punish these culprits."

His comments come a day after multiple purported videos of Sandeshkhali women, shared by the TMC, claimed that a local saffron party leader made those women sign blank papers which were later filled up as complaints of sexual as-

#### **Upward trajectory of India-US** ties not impacted at all: EAM Jaishankar on Pannun case



NEW DELHI, May 10: The upward trajectory of India-US relations has not been impacted at all by allegations of an Indian link to a foiled assassination plot, External Affairs Minister S Jaishankar has said.

In November, the US charged an Indian national of conspiring to murder Sikh separatist Gurpatwant Singh Pannun in New York.

In an exclusive interview to PTI late Thursday, Jaishankar said the fundamentals of India-US ties are very robust and the allegations have not impacted the relations.

"The United States brought to our attention certain information in good faith because we also believe some of it has implications for our own system," he said.

"We are investigating it. But I do not think the fundamental course of the upward trajectory of India-US is impacted by this at all," the external affairs minister said in the freewheeling conversation at PTI's head-

Days after Washington alleged the Indian link to the plot, India instituted a high-level inquiry committee to look into the inputs received from the US in the case.

Pannun, wanted in India on terror charges, holds dual citizenship of the US and Canada.

Last month, The Washington Post named an Indian official for allegedly plotting to assassinate Pannun. Days later, India said the report made "unwarranted and unsubstantiated" imputations on a serious matter and that investigation into the case was underway.

Listing various areas of cooperation, Jaishankar said, "I think, today, we have such a strong strategic convergence with the United States."

In his remarks, he cited driving the international economy, diversifying production, creating new supply chains, ensuring peace and stability and collaboration in the domain of high-technology as shining examples of India-US ties.

"I think the India-US account is a very, very solid one," he said.

Jaishankar also said there was a problem in the relationship in the

"There was a kind of left-wing ideology in this country which said let us not do too much with the US. It goes back to the Nehruvian-Krishna Menon time period. I think it went all the way till 2014," he said.

"Maybe Atal ji's (Atal Bihari Vajpayee) government was an exception, but otherwise pretty much there were self-imposed constraints in our dealing with the US," he said.

Jaishankar said Prime Minister Narendra Modi does not share those

"PM Modi doesn't share those and we have seen actually a much more robust, much more wholehearted relationship with the US which is actually showing results on the ground," he added.

The minister also highlighted the assertive approach in India's foreign policy under the prime minister's eadership.

"When we look at an issue, we look at it from the point of view of Indian national interest. And if that Indian national interest means taking pressure, offending other countries or pushing back, we are prepared to do it," he said.

"We are, for example, very, very focused on trying to get UN Security Council membership. This was not the case earlier. In fact, there was a time when, you know, the position of our government was that first let them accommodate China and then our turn will come," he said.

"So, we are very clear, Bharat comes first.'

Jaishankar said the Modi government is also very focused on issues relating to national security.

"Not only positioning wise, but in terms of friends and partners who will contribute to our national security and also in terms of the border infrastructure where there has been quite a remarkable transformation,

"The quality of the infrastructure today allows us to deploy troops on the LAC (Line of Actual Control) in a manner which we could not have done earlier," he said.

The Modi government is also very focused on getting for the country the resources, the best practices, the technologies that it believes are important for national development, according to the minister.

"We are also much more conscious of our culture, civilization, heritage, traditions than previous governments. We project it much

Compared with historical data, the bulletin highlights that the current live storage is only 79 per cent of last year's levels and 92 per cent of the 10-year average for the corresponding period.

The storage during the current year is lower than that of the corresponding period last year in all of the country while it is below the average storage of the last 10 years during the corresponding period in northern, eastern southern and western

The southern region, encompassing Andhra Pradesh, Telangana, Karnataka, Kerala, and Tamil Nadu, has a total live storage capacity of 53.334 BCM. According to the reservoir storage bulletin dated May 9, the available live storage in these reservoirs is 7.921 BCM, constituting only 15 per cent of their total capacity. In comparison, last year's storage during the corresponding period was 27 per cent, and the

10-year average was 21 per cent of

the live storage capacity. The northern region, which comprises Himachal Pradesh, Punjab, and Rajasthan, has 10 reservoirs under CWC monitoring with a total live storage capacity of 19,663 BCM. The bulletin reports the current live storage available in these reservoirs at 5.759

BCM, representing 29 per cent of

the total live storage capacity. During the corresponding period last year, the storage was 37 per cent, and the 10-year average was 33 per cent of the live storage capacity.

Similarly, the eastern region, including Assam, Jharkhand, galand, and Bihar, has 23 reservoirs with a total live storage capacity of 20.430 BCM. The live storage available in these reservoirs currently stands at 6.952 BCM, which is 34 per cent of the total live storage capacity. In contrast, last year's storage

during the corresponding period was 31 per cent, while the 10-year average was 34.2 per cent of the live storage capacity.

The western region, covering Gujarat and Maharashtra, has a total live storage capacity of 37.130 BCM. As per the reservoir storage bulletin, the available live storage in these reservoirs is 10.339 BCM, which is 28 per cent of the total live storage capacity.

Compared with last year's storage during the corresponding period (34 per cent) and the 10-year average (29 per cent), the current year's storage is notably lower.

Lastly, the central region, comprising Uttar Pradesh, Uttarakhand, Madhya Pradesh, and Chhattisgarh, has 26 reservoirs under CWC monitoring with a total live storage capacity of 48.227 BCM. The live storage available in these reservoirs is reported at 16.687 BCM, representing 35 per cent of the total live storage capacity.

filed an interim application in its 2019 PIL seeking directions to the poll panel that "scanned legible copies of Form 17C Part-I (Account of Votes Recorded)" of all polling stations be uploaded immediately after the "Direct the Election Commission to provide tabu-

lated polling station-wise data in absolute figures of the number of votes polled as recorded in Form 17C Part- I after each phase of polling in the on-going 2024 Lok Sabha elections and also a tabulation of constituency-wise figures of voter turnout in absolute numbers in the on-going 2024 Lok Sabha elections," the NGO said. It said that the plea was filed to ensure that the democratic process is not subverted by elec-

"The voter turn-out data for the first two phases of the ongoing 2024 Lok Sabha elections published by ECI on April 30 has been published after 11 days of the first phase of polling held on April 19 and 4 days after second phase of polling held on April 26.

"The data as published by the ECI in its press release dated April 30, 2024 shows a sharp increase (by about 5-6%) as compared to the initial percentages announced by ECI as of 7 pm on the day of polling," the plea said. The petition said the "inordinate" delay in the release of final voter turnout data, coupled with the unusually high revision of over 5 per cent in the poll panel's press note of April 30, 2024 has raised concerns and public suspicion regarding the correctness of the

## Shut down coaching centres that violate safety norms: HC directs MCD, DDA

NEW DELHI, May 10: The Delhi High Court on Friday directed the MCD and the DDA to shut down forthwith the coaching centres operating in violation of the fire safety norms.

A bench headed by Justice Yashwant Varma, which had earlier ordered inspection of coaching centres in Mukherjee Nagar by a team of lawyers, also asked the authorities to re-locate electrical equipment installed outside their premises which may be potentially dangerous to the public.

The order came on a batch of petitions on the operation of coaching centres in the area, including a case the high court had registered on its own after taking cognisance of an incident of fire that broke out at one of them in June 2023.

Amicus curiae Gautam Narayan told the court that the inspection, which was carried out on two occasions in April, revealed that a few coaching centres that the Municipal Corporation of Delhi (MCD) claimed had shut down were still functioning under a new management or name.

Narayan said these premises were in non-compliance with the fire safety requirements, and in one instance, an electrical board was found installed at the very entrance, blocking the way in case of a fire.

The court pulled up the MCD for failing to take note of such coaching centres in spite of its earlier direction to close down institutes which are in violation of fire safety norms, and directed it to immediately take action against them.

"Someone is wanting to play games? You are trying to nitpick. The direction was to shut it down. Don't say anything now. You shut it down. The amicus is doing the job which the MCD should be

"In light of apparent violation of sealing directions issued by us, we direct the MCD/DDA (Delhi Development Authority) to take action forthwith and premises are sealed," the bench ordered.

The high court had earlier said "fire safety is a must" and all coaching centres must either comply with their statutory requirements under the Delhi Master Plan, 2021 and other applicable regulations or face closure.

On Friday, the court also clarified that the "character" of a building for the purposes of its identification as an educational building and the applicability of the fire safety norms has to be determined by its "use", and asked the MCD, DDA and The Delhi Fire Service (DFS) to undertake a fresh survey to identify non-compliant coaching centres within four weeks.

On a prima facie evaluation, the court finds that it is the expression "used for" in Unified Building Bye Laws which would be determinative of character as an educational building and therefore in case of buildings which may be falling in other general category but are used for school, coaching etc with over 20 students, it is the norms of educational buildings that will get attracted, it said.

Last year, the high court had registered a case on its own after taking suo motu cognisance of a fire incident at a coaching centre in Mukherjee Nagar in June during which students were seen climbing down the building using ropes. (PTI)

Kanoon Mitra' can be accessible through two ways - a weblink (https://mediafiles.botpress.cloud/69e1bc77-1c9b-4d0b-aaca1238d73c5751/webchat/bot.html) and a QR-code. Both the platforms will direct the user to the chatbot, where any citizen can ask questions directly related to three new criminal laws through text messages."

Director General of Police, Andaman and Nicobar Islands, Devesh Chandra Srivastava commended all the officers involved in this project and said, "The adoption of this chatbot is an effort to harness the potential of artificial intelligence in delivering efficient and accessible services to the public.'

"In the last four months we have conducted campaigns to make people aware of these three new criminal laws in all the three districts - South Andaman, North and Middle Andaman and Nicobar district," the DGP said.

All police personnel are being given extensive training to ensure a smooth and seamless transition to the new criminal laws. The aim is to give multiple training sessions to all the staff of ANI Police in the coming months and cover all the personnel of the police department before the July 1 deadline.

#### AI Express operations slowly 27 emails, 10 banks accounts: Mystery of improving; expects normalcy missing Taarak Mehta actor Sodhi deepens in next two days: Official

NEW DELHI, May 10: The operations of Air India Express slowly started improving on Friday as more cabin crew members are joining back for duty, after significant flight disruptions caused by cabin crew strike that has been called off. The strike by a section of the cabin crew since Tuesday night that resulted in the cancellation of more than 170 flights was called off on Thursday evening and the airline also withdrew termination letters issued to 25 striking cabin crew. The Tata Group airline, which operates around 380 flights daily, has curtailed operations in the wake of the strike and the official on Friday said, normalcy is expected in the next two days.

Cabin crew who were on strike are joining back and the airline is extending support to them in getting the fitness certificate, which is required to resume duty, the official added. The official also said that most international flights are in the evening time and the operations on that front are expected to be better from Friday onwards with the availability of more cabin crew. On average, the airline operates 120 international flights and 260 domestic

services daily while there are fewer flights on some days. Faced with cabin crew shortage, Air India Express on Thursday cancelled 85 flights or around 23 per cent of its total daily capacity.

After the strike was called off on Thursday, the airline had said it will help to swiftly restore flight schedule and also apologised to passengers who were impacted by the flight disruptions. Many cabin crew members had reported sick to protest against alleged mismanagement at the airline and lack of equality in treatment of staff. Air India Express -- which is in the process of completing the merger of AIX Connect, formerly AirAsia India, with it-

NEW DELHI, May 10: The mystery of missing actor Gurucharan Singh, who played Roshan Singh Sodhi's character in TV serial Mehta Ka Ooltah Chashmah', has become deeper as the Delhi Police has found that the actor was using 27 separate email accounts in the fear of being "surveillanced" by someone

According to a police officer, who is privy to the investigation, the actor was having a suspicion of being "surveillanced" for which he would

often change his email accounts. The 51-year-old actor was supposed to board a flight from here to Mumbai on April 22 evening but never reached his destination. His father, who lives in Palam, informed the local police after his phone was

found to be unreachable. A police officer said a case under section 365 (kidnapping or abducting with intent to convey out of India or secretly confine person) of the IPC was registered at Palam police

station on April 26. A police team has been tasked to trace his location from the mobile phone which he was carrying, a police officer said.

The officer said Singh's mobile phone is switched off since 9.22 pm on April 22. On the basis of a CCTV footage, his last location was tracked to Dabri in southwest Delhi where he reached in an e-rickshaw, hired from

near IGI airport. The actor used to carry two mobile phones. But he left one of them at his home in Delhi. He made the last call to his friend, who was supposed to pick him at the Mumbai airport, another officer said.

The police teams have scanned his financial transactions from his bank accounts and credit cards. They show that the last transaction was of Rs 14,000, which he withdrew from one of his bank accounts on the day he went missing.

The police officer said Singh's financial condition was not sound, as he had several loans and dues on

At least a dozen police teams, including the Crime Branch and Special Cell, are working to locate him, the officer said.

Another officer said Singh is a follower of a sect for which he used to visit a meditation centre in Delhi's Chattarpur. The police have taken the statements of the sect's followers

who are known to him. The officer further said the actor had once showed his interest in going to the Himalayas for meditation. The teams of Delhi Police have taken the statements of over 50 people in Delhi and Mumbai.

The police teams have also visited some states like Haryana, Punjab and Uttarakhand to get any lead in connection with the case, the officer

Himalayas may soon be part of NCERT textbooks NEW DELHI, May 10: India's strides in research on the Arctic, Antarctica and the Himalayas may soon figure in school textbooks, with the Union Ministry of Earth Sciences reaching out to the NCERT to include the latest develop-

ments in its curriculum. Ministry of Earth Sciences Secretary M Ravichandran said the National Council for Educational Research and Training (NCERT) has constituted a committee to bring out the importance of research in these areas in school text-

"We wrote a letter to them ... they (NCERT) have recently constituted a committee for bringing out importance of the Antarctica expedition, Arctic and also the Himalayas and some other aspects, including climate change. They are working on it," Ravichandran said during an interaction with PTI editors

The Antarctica expedition finds mention in NCERT textbooks but the content hasn't been updated for a long time. There is very limited mention of the ongoing research in the Arctic and the Himalayan regions, too.

In a rationalisation exercise post



Covid-19, the NCERT dropped topics such as climate change, monsoon and greenhouse effect from textbooks, trig gering a controversy.

The council later clarified that the subjects had been dropped to reduce curriculum load in view of the pandemic and added that the topics would be restored with the release of books based

on the new curriculum framework. These books are currently being worked on and will be available for all classes by 2026.

The Union Ministry of Earth Sciences is hosting the 46th meeting of the ATCM, the highest governing body for Antarctica, and the 26th CEP meeting.

The crucial meets will be held in Kochi from May 20-30 where countries engaged in research in the southern polar region will share the outcome of their scientific pursuits and future plans.


India has two active research stations -- Maitri and Bharti -- in Antarctica. The first research station, Dakshin Gangotri, set up in 1983, had to be abandoned after it sank in the snow.

Thamban Meloth, director of the National Centre for Polar and Ocean Research (NCPOR), said several students involved in the research have been to Antarctica in recent years.

"We have not taken any high school students so far but several senior students involved in the research have been to Antarctica," he said in response to a

Asked about possibilities of introducing a programme such as Students on Ice for Indian school students, Meloth said, "It is not logistically feasible. It costs around Rs 1 crore to send a single person to Antarctica ... there are lot of other logistical issues too when it comes to

high school students. The Students on Ice programme is run by Canadian educator and environmentalist Geoff Green, under which high school students from across the globe, accompanied by educators and scientists, get an opportunity travel to Antarctica and the Arctic. (PTI)

The engine uses the earth-storable bipropellant combinations of Nitrogen Tetroxide as oxidiser and Mono Methyl Hydrazine as fuel in pressure-fed mode. It was developed by ISRO's Liquid Propulsion Systems Centre (LPSC).

LPSC redesigned the engine making it amenable to the Design for Additive Manufacturing (DfAM) concept thereby gaining considerable advantages

The Laser Powder Bed Fusion technique employed has brought down the number of parts from 14 to a single-piece, and eliminated 19 weld joints, saving significantly on the raw material usage per engine (13.7 kg of metal powder compared to the 565 kg of forgings and sheets for conventional manufacturing process) and reduced 60 per cent in the overall production time, the ISRO release





## NADAL SHOWS HE'S NOT QUITE READY FOR RETIREMENT IN A COMEBACK WIN AT THE ITALIAN OPEN

ROME, May 10: For a brief stretch on Thursday, Rafael Nadal looked every bit of a weary 37-year-old player nearing retirement. Struggling to produce pace off both sides with his groundstrokes, committing an uncharacteristically high number of unforced errors and unable to stay in rallies, Nadal dropped the first set of his firstround match at the Italian Open against Belgian qualifier Zizou

Then the fist-pumping, virtually-unbeatable-on-clay, 22-time Grand Slam champion version of Nadal emerged and the Spaniard rallied for a 4-6, 6-3, 6-4 victory before an adoring crowd in what will likely be his

final tournament at the Foro Ital-

Nadal was playing only his 10th match this year after missing nearly all of 2023 with a hip injury that required surgery. He's hoping to be competitive one last time at the French Open, where he is the record 14-time champion. "That was not my best match. I was practicing better than how I played today, without a doubt. But I found a way to win," Nadal said. "My game is more unpredictable than before. I didn't play much tennis for the last two years. So I'm up and down, on and off, but I think I can do it much better than what I did today."

Rome, where he is a record

10-time champion, is Nadal's last big warmup tournament before Roland Garros starts on May 26.

Nadal noted that after overcoming his hip and abdominal issues, the time has come "to prove myself if I am able to push my body to the limit that I need to push to feel myself ready for what's coming.

"I am not talking only about Roland Garros. I am talking about the next match. I need to lose this fear," Nadal said. "Matches like today help. Some moments I was moving faster. Some moments not. I need to get used to that, to take that risk. ... I feel more ready to try it than before." During his 70th win in

the Italian capital, the Campo Centrale crowd serenaded Nadal with chants of: "Ole, Ole, Ole, Na-dal, Na-dal.'

"I've always been emotional to play here, these kind of events are the most important events in my tennis career," Nadal said. "The crowd has been always amazing with me, supporting me since the beginning of my tennis career. So I'm super excited to be able to play one more time here." Nadal was coming off a straight-set loss to 31st-ranked Jiri Lehecka in the fourth round of the Madrid Open. But he has never lost consecutive matches on clay in his entire career and now that impressive statistic remains intact during what he has indicated is his final season on tour. Nadal got out to a strong start, unleashing a 95 mph (153 kph) forehand winner en route to an early break and a 3-1 lead in the first set. But he gave the break right back in the next game when he missed three weak groundstrokes into the net.

Then at 4-4, Nadal doublefaulted twice and was broken again to give the 108th-ranked Bergs a 5-4 lead and a chance to serve out the set.

In the first set, Nadal committed 16 unforced errors to Bergs' 10. During the first game of the second set, the match was briefly suspended when a spectator in the stands required medical treatment. That allowed

Nadal to chat with Carlos Moya, his coach.

After the 10-minute suspension of play, Nadal raced out to a 3-0 lead in the second set as he upped the power on his shots and became more aggressive.

During the third set, Nadal managed to win a point after he fell to the red clay, quickly getting up to resume the rally and then producing a delicate dropshot winner. Then he blasted a forehand cross-court winner to break for a 3-1 lead and unleashed a double-clutch fist pump. There were more fist pumps when Nadal rallied from 0-40 on his serve to hold for a 4-2 lead in the third.

Nadal's mother and sister sit-

ting behind the court shouted encouragement and his 1-year-old son was also court-side — sit-

ting on the lap of Nadal's father. The Nadal family can now look forward to a second-round matchup with seventh-seeded Hubert Hurkacz. Top-ranked Novak Djokovic is on the opposite side of the draw, while second-ranked Jannik Sinner and third-ranked Carlos Alcaraz both withdrew because of injuries.

In other matches, Serbian qualifier Hamad Medjedovic beat Alexei Popyrin 6-3, 6-2; Thiago Seboth Wild defeated French qualifier Gregoire Barrere 6-4, 6-2; and Dominik Koepfer eliminated Andrea Vavassori 6-4, 6-3. (AP)

bronze medallist said he had only demanded an explanation from the officials as on one of the two previous occasions, they (NADA officials) had come with expired kits while during other time, they appeared with only one testing kit as opposed to the mandatory three. Bajrang, one of the country's most successful wrestlers, was suspended by National Anti-Doping Agency (NADA) on April 23 after being served a whereabouts failure notice on April 18. On Thursday, wrestling's world governing body UWW also suspended him till the end of this year following NADA's decision to hand him a provisional suspension for refusing to undergo a dope test on March 10 in Sonepat. "This is to doping control. On 10 March 2024, when I was approached by alleged doping control officials, I merely reminded them that the last two times they came to collect my sample, they had gotten expired kits once," wrote Bajrang on 'X' on Friday.

...and on the other instance, they had approached me with a single testing kit as opposed to the three testing kits," added Bajrang, who has been at the forefront of a protracted agitation against former Wrestling Federation of India chief Brij Bhushan Sharan Singh.

The grappler, who competes in the 65 kg category, said he had sought an answer from the Dope Control Officers (DCO) on March 10 on why NADA was not responding to his queries regarding two previous lapses, but he got no explanation. "I then sought an answer from them (DCOs) as the NADA did not provide an answer to any of my communications demanding an explanation

that I would give my sample upon receiving such explanation from them. "Not only did the doping control officials refuse to provide an explanation, they did not provide me any proof on this instance of them carrying proper equipment and merely left from the venue where I was at, claiming it to be a refusal from my end," added Bajrang.

Bajrang added that contrary to reports that he left the venue immediately, he was present for almost one hour after the dope control officials had approached him for the sample.

"I continued to be at the venue as I had another bout scheduled for 3/4 position. After my semifinal bout, I met the SAI (Sports Authority of India) doctor at the venue for treatment regarding a knee injury suffered during the semifinals of the Wrestling Trials. "I only left the venue about an hour after the alleged doping control officials approached me, contrary to how it has been portrayed that I left immediately,' added Bajrang.

He also alleged that the DCOs clarify that, I have at no stage re- had not followed the norms fused to give my sample for which mandated them to stay till such time a wrestler submits his medical report to the competi tion manager. "The dope controlling officer should have accompanied me till I submitted my medical report to the competition manager as per protocol, rather than leaving in a hurry in middle of the trials, to record my refusal. "Even if this incident is treated as refusal, the fact that it was due to NADA using expired kits and not providing an explanation for using them, or giving me comfort, that they had not carried expired kits again, should be considered as a compelling justification.

"I took such a stance solely because of the NADAs actions in the past, which, in the absence an explanation, could continue a dangerous trend of the use of expired kits or non-compliance with doping control protocol. "It is my moral obligation towards the wrestling community and particularly the younger wrestlers, that I exercised here,' he added. (PTI)

# Hardik's ego-driven, chest-out style of leadership doesn't look genuine: De Villiers

JOHANNESBURG (SOUTH chise because the core group was AFRICA), May 10: Hardik Pandya's "ego-driven, chest out" style of captaincy doesn't seem to look genuine and experienced teammates aren't exactly buying his false bravado, feels former South Africa skipper AB de Villiers. Pandya's first stint as Mumbai Indians skipper replacing the highly successful Rohit Sharma turned into a nightmare as the five-time champion franchise

failed to reach the play-offs. Worse, the MI fans didn't like team's decision with Pandya being greeted with boos in every single game. "The captaincy style of Hardik Pandya is quite bravado. It's ego-driven in a way, chest out," De Villiers said on his YouTube channel.

An IPL legend himself, De Villiers observed that Pandya's trying to unsuccessfully fake it.

"I don't think how he walks on the field is always genuine, but he has decided that is his way of captaincy. Almost like MS (Dhoni). Cool, calm, collective, always got your chest out.'

Pandya had led a young Gujarat Titans team to back-to-back IPL finals winning the inaugural edition. De Villiers opined that the style which flopped in Mumbai Indians worked in an earlier franmuch vounger.

"When you play with a lot of experienced players, guys who have been around for ages, they don't buy into that. It worked at GT, where it was a younger team. Sometimes, inexperienced players love to follow that kind of leadership." Giving some captaincy advice to Pandya by remembering his playing days under Graeme Smith, de Villiers stated that the

all-rounder needed to get out of his "bravado" or put confidence mentality. "I remember Graeme Smith. He was there for All needed to do as a youngster was to follow. Now, there's a Rohit (Sharma), there's a (Jasprit)

"They go like, 'All we need you to be is calm. Give us a bit of input on how to win matches. We don't need the bravado'.

However, the South African also clarified that he was not targeting Pandya and that he loved to watch him play.

"I'm not having a go at Hardik. I love watching him play. I love him putting out his chest because I was like that. I believed that as a batter sometimes, you've got to fake it to make it," he concluded.

## No longer vintage but Kohli is still quite remarkable: Tom Moody

Virat Kohli is not without his limitations but the star Indian batter has made up for them with his commitment to training, feels former Australian all-rounder Tom Moody. Armed with his powerful slog-sweep, Kohli has been able to counter the spinners in the middle overs, and on Thursday after blazing his way to a 47-ball 92, the 35year-old effected the key run-out of Shashank Singh with a superb direct hit from deep mid-wicket against Punjab Kings.

"It's quite remarkable, especially considering he's not the same as the vintage Virat Kohli, but he's also not 21 anymore; he's 30. So, that's brilliant what he's done there," Moody said on 'Star Sports Cricket Live'. "Running in from the deep, throwing himself to the ground, and managing to make the

**DHARAMSALA**, May 10: throw from that position is no easy feat. That's something we've definitely taken into consideration. It's truly extraordinary," he said.

The knock took Kohli's season total to 634 at an average of 70.44 from 12 matches with Chennai Super Kings skipper Ruturaj Gaikwad at a distant second (541 from 11 matches).

Emphasising his agility and contribution with the bat despite his age, Moody said: "He's not just a fielder; he's also contributed with the bat, scoring 92 runs and spending considerable time out in the middle. "Despite the physical exertion, he's always running around in the field like no one else. In the middle of the innings of that second innings he still managed to display the focus, enthusiasm, fitness, and agility required to execute a run-out like that." The

expert commentator further noted that while Kohli may not train as intensely as before, he still focuses on improving his performance through training. "We talk about the sweep slog, how he's brought that back out against spin, and hasn't that been a really effective weapon for him in those middle overs," he added.

"That decision lies with Ajit Agarkar, even when these two players (Ishan Kishan and Shreyas Iver) who did not play domestic (cricket), the decision to drop them (from the central contracts list) was

"My role is just to implement. And we have got new players (in place), like Sanju (Samson). Nobody is indispensable," he added.

Shah reiterated the Board's position that Indian players will have to prioritise domestic cricket.

In the days leading up to the contract snub, Shah had stated before the third Test between India and England in February this year that he would completely back the added. (PTI)

"Now, in IPL we are seeing scores like 240, 250 regularly. The main reasons are good batting wickets and the grounds are also not big in India. In the last game between Delhi Capitals and Rajasthan (Royals), 26 sixes were hit in a 40-over game, which is almost one six every over. "That's how this game has gone and that's

how the players have started approaching the game. The Impact Player rule, where every team has the possibility of adding another batsman, has also added another dimension to it," he detailed. Ganguly said the bowlers need to upskill

themselves to counter the ruthless march of batters in T20s, and cited the example of pacer Jasprit Bumrah. Amidst the general ruins of bowlers,

Bumrah stood tall, grabbing 18 wickets from 12 matches and his economy rate of 6.20 is the best among regular bowlers.

"The bowlers need to be really more skillful, we have some skillful bowlers around,

to be more successful. Look at Bumrah, Axar Patel, Kuldeep Yadav, all of them bowl superbly in all formats of the game and in

"I don't believe in formats. I believe in skills. These are exemplary players who will thrive in all formats," he noted.

Does he think the power-hitting will take the elegance and artistry away, making cricket robotic?

"Not at all. Demands of different formats are different. Everything evolves, sports is not an exception. You will still see elegance and artistry in Test cricket. Test matches will always be Test matches.

"Look, quality players will be successful in all formats of the game. Look at Virat Kohli...the best players will adjust to all formats," he added.

Recently, Dinesh Karthik had expressed his desire to return to the Indian side in the context of the T20 World Cup, but Ganguly said the selectors made the right choice by selecting Rishabh Pant and Sanju Samson as wicketkeeper batters.

"Dinesh played well but there are better players than Dinesh. I don't think you can leave Sanju or Rishabh out. There are better players than Dinesh Karthik at the moment,' said Ganguly.

Ganguly also refrained from commenting on the "public reprimand" given to Lucknow Super Giants skipper KL Rahul by the team owner Sanjeev Goenka.

"It is not fair for me to make a comment based on a TV grab. I don't know what Sanjeev had spoken to Rahul. So, I leave it at that," he said. (PTI)
