# Shifting of 600 families starts amid tight security

GUWAHATI, May 21: The state government is carrying out a drive to shift nearly 600 families, displaced by an eviction drive two years ago, from their temporary settlement at Gorukhuti in Darrang district, a senior official said on

The affected families, however, claimed that 620 houses have already been destroyed at two locations of Gorukhuti and the exercise is still underway.

Darrang district commissioner, Munindra Nath Ngatey told PTI that the families are "not evicted but being shifted" to a new place from Sipajhar revenue circle to 'char' (riverine islands) areas of nearby Dalgaon revenue circle.

"During the eviction drive of 2021, around 2,300 families were displaced and they started living in temporary houses in some other areas of Gorukhuti. We have been telling them to shift to other places designated by the administration

Around 1,200-1,400 houses mostly belonging to Bengalispeaking Muslims, were razed to the ground on September 20 and 23 of 2021 in Dhalpur I, II and III villages of Gorukhuti, leaving over 7,000 people homeless.

Two persons were killed in police firing and over 20 people were injured, including policemen, during the massive eviction drive at Gorukhuti, where the Assam government initiated a multi-dimensional agriculture project. Asked if these people face threat of eviction from the new places also sometime in future, Ngatey said: "Nobody is going to evict them. Those places are presently non-cadastral villages, (CONTD. ## US unable to assist in probing Iranian President's chopper crash due to 'logistical reasons'

**WASHINGTON, May 21:** The was not able to provide any help. Iranian government has requested the US to assist in probing the deadly helicopter crash that killed President Ebrahim Raisi, his foreign minister, and six others but Washington won't assist Tehran largely due to "logistical reasons", according to a senior American diplomat

Raisi, 63, a possible successor for Iran's supreme leader, the 85year-old Ayatollah Ali Khamenei, his foreign minister Hossein Amir-Abdollahian, and six others were found dead on Monday hours after their helicopter crashed in fog, leaving the Islamic Republic without two key leaders as extraordinary tensions grip the wider Middle East.

US state department spokesperson, Matthew Miller at a press briefing on Monday said the US when asked for assistance by the Iranian government made it clear that it was ready to offer assistance, as it would do in response to any request by a foreign govern-

"I'm not going to get into the details, but we were asked by the Iranian government for assistance. We said that we would be willing to assist. It's something that we would do with respect to any government in this situation. Ulti-mately, largely for logistical reasons, we weren't able to provide that assistance," Miller told re-

In response to a question on the United States extending official condolences and participating in a moment of silence for Raisi at the UN Security Council, Miller said the US had been quite clear that Raisi was a "brutal participant" in the repression of the Iranian people for nearly four decades but Washington regretted any loss of life in a helicopter crash like incident.

"We regret any loss of life. We don't want to see anyone die in a helicopter crash. But that doesn't change the reality of his record both as a judge and as the president of Iran and the fact that he has blood on (CONTD. ON PAGE-2)

MAHARAJGANJ/MOTIHARI, May 21: Prime Minister Narendra Modi on Tuesday dubbed the INDIA bloc as a "congregation of scamsters" that was communal, casteist and dynastic to a "severe" degree, 'cent per cent'

Modi launched the blistering attack at rallies in Mahrajganj and Purvi Champaran Lok Sabha constituencies in Bihar, where he also predicted a big blow for the opposition alliance that stood for corruption, appeasement politics and "perverted anti-Sanatan mindset", on June 4 when Lok Sabha poll results will be out.

The PM, who is seeking a third consecutive term in office, also underscored that he shall be bequeathing no "viraasat (inheritance)" since he considered the people of the country as his only "waaris (successors)". He also charged the RJD-Congress combine, which formerly ruled Bihar, with having brought disrepute to "the land which gave birth to first president



NEW DELHI, May 21: Union minister Ajay Bhatt said Tuesday the strength of a country resides not only in its military might but also in its ability to adapt to changing circumstances and leverage its cultural heritage as a source of power. The minister of state for defence was addressing an event at the National Museum here to mark the culmination of Project Udbhav, which aims to promote indigenous discourse in the Army by integrating India's ancient strategic acumen into a contemporary military domain with a focus on making the force "future-ready". The project is a collaboration of the Indian Army and Delhi-based think-tank United Service Institution of India (USI).

Praising the Army and USI, Bhatt said, "The aim of this project envisioned by USI is to find invaluable in-

sights into our strategic culture by finding ancient texts and oral traditions... The geopolitical landscape is continuously evolving and it is necessary for our armed

forces to be adaptive and innovative in their thinking." In his address, the minister also praised the ancient Indian philosophy of 'Vasudhaiva Kutumbakam', which was part of the tagline used by India during its year-long presidency of the G20.

"The ancient principle of 'Vasudhaiva Kutambakam'... has transcended cultural boundaries and become a guiding light in international diplomacy," Bhatt said. The Union minister said that in the last decade, the government of India has started a significant journey towards promoting indigenisation initiatives in various areas. From health to manufacturing and from basic infrastructure to defence, solid efforts have been made for a strong national commitment towards indigenisation, he added. ## 'Silent demise' of rangelands threatens climate, survival of billions worldwide: UN report

Report attributes degradation of natural pastures, other rangelands to overuse, misuse, climate change

NEW DELHI, May 21: Up to 50 vast open areas suitable for grazing livestock - are estimated to be degraded, posing a severe threat to food supply and survival of billions of people, the UN warned in a new report on Tuesday.

Launched in Ulaanbaatar in Mongolia, the UN Convention to Combat Desertification's (UNCCD) 'Global Land Outlook Thematic Report' attributed the degradation of the immense natural pastures and other rangelands to overuse, misuse, and climate change

The degradation is driven largely by conversion of pastures to cropland and other land use changes due to population growth and urban expansion, rapidly rising food and fuel demands, excessive grazing, abandonment (end of maintenance by



pastoralists), and policies that incentivize overexploitation.

'When we cut down a forest, when we see a 100-year-old tree fall, it rightly evokes an emotional

response in many of us. The conversion of ancient rangelands, on the other hand, happens in 'silence' and generates little public reaction,' said UNCCD Executive Secretary

sive landscapes and the pastoralists and livestock breeders who depend on them, are usually under-appreciated,' Thiaw said.

Pastoralist communities are frequently overlooked, lack a voice in policy-making that directly affects their livelihoods, are marginalised, and are even often seen as outsiders in their own lands, he added.

Covering 54 per cent of all land, the rangelands include savannas, shrublands, wetlands, tundra and deserts. Altogether, these lands account for one sixth of global food production and represent nearly one third of the planet's carbon reservoir. Two billion people - smallscale herders, ranchers and farmers, often poor and marginalized - depend on healthy rangelands worldwide. (CONTD. ON PAGE-2)

# India likely to grow by 7.5 pc in Q1, says article in RBI Bulletin

the first quarter of the current financial year, driven by rising aggregate demand and non-food spending in the rural economy, according to an article in the RBI's May Bulletin released on Tuesday.

The Indian economy has demonstrated marked resilience in the face of geopolitical headwinds impacting the supply chain, said an article on the state of the economy published in the May Bulletin.

"According to the economic activity index (EAI), activity rebounded in April, and early estimates suggest that GDP growth for Q1:2024-25 is likely to remain close to 7.5 per cent," it said.

The economic activity index (EAI) was constructed by extracting the common trend underlying twenty-seven high-frequency indicators of economic activity, using a Dynamic Factor Model.

EAI was scaled to 100 in February 2020 and 0 in April 2020, the worst affected month due to mobility restrictions.

Meanwhile, the government will be releasing the quarterly GDP estimates for January-March, 2024 (Q4 2023-24), and provisional estimates of National Income for the

year 2023-24 on May 31.

The Indian economy grew 8.2 ner cent in the June quarter, 8.1 per cent in the September quarter and 8.4 per cent in the December quarter of 2023-24.

The article noted that high-frequency indicators point towards sustained momentum in domestic demand conditions in April 2024.

Toll collections increased by 8.6 per cent (y-o-y) in April 2024. Automobile sales increased by 25.4 per cent (y-o-y) in April 2024, led by strong growth in the two-wheelers and three-wheelers segment, while passenger vehicles recorded the highest-ever monthly sales.

"There is a growing optimism that India is on the cusp of a longawaited economic take-off. Recent back of robust demand for home and personal care products.

In many West African countries, livestock production employs 80 per cent of the population. In Central Asia and Mongolia 60 per cent of the land area is used as grazing rangelands, with livestock herding supporting nearly one third of the region's population, the UNCCD said.

Ironically, the report underlined that efforts to increase food security and productivity by converting rangelands to crop production in mostly arid regions have resulted in degraded land and lowered agricultural yields. It called out 'weak and ineffective governance', 'poorly implemented policies and regulations', and 'the lack

of investment in rangeland communities and sustainable production models' for undermining rangelands. Rangelands occupy about 121 million hectares in India and a large part (around 100 million hectares) of these is considered underutilized. This includes degraded forest lands, land unsuitable for crop production, ravines, and

The report highlighted that around 120 million hectares of land in India is degraded due to water erosion (82

million hectares), wind erosion (12 million hectares), chemical contamination (25 million hectares), and physical degradation (1 million hectares).

Crop losses due to water erosion in India alone are estimated to be USD 3.5 billion.

Committed to achieving its targets on land degradation neutrality (LDN) and ecosystem restoration, Indian has launched or reinvigorated several LDN-related programmes, including the National Afforestation Programme, Green India Mission,

and Watershed Development Component. Together, these programmes are expected to help restore 26 million hectares. 'Although grasslands are considered threatened ecosystems in India, they have been virtually overlooked in environmental conservation and ecosystem restoration policies in favour of forestry-based interventions, which

includes converting natural grasslands into plantation forests or other uses,' the UN report said. Less than five per cent of India's grasslands fall within protected areas, and the total grassland area declined

from 18 to 12 million hectares between 2005 and 2015, it said. Fortunately, there is a gradual shift towards recognition of the social-ecological role of rangelands and pastoralism, and India has recently taken a more encouraging approach, the report's authors noted. (PTI)

GUWAHATI, May 21: Oil India Limited (OIL), the youngest Maharatna Central Public Sector Enterprise (CPSE) of the Government of India, announced its financial results for FY 2023-24 during its 554th Board of Directors meeting held on May 20, 2024. The company achieved its highest-ever combined oil and gas production (O+OEG) of 6.54 million metric tonnes of oil equivalent (MMTOE), leading to record-breaking earnings before interest, taxes, depreciation, and amortization (EBIDTA) of ₹11,643.30 crore for the fiscal year.

In Q4 FY24, Oil India achieved its highest-ever profit after tax (PAT) at ₹2,028.83 crore, marking a 13.45% increase compared to Q4 FY23. However, the annual PAT for FY 2023-24 decreased to ₹5,551.85 crore from ₹6,810.40 crore in FY 2022-23, due to provisions for statutory compliances.

The company reported a 6% year-overyear increase in crude oil production for Q4 FY24, with a total annual increase of 5.76% to 3.359 million metric tonnes (MMT) compared to 3.176 MMT in FY23. ## India, US working together to bridge digital divide between West & global South: Ex-WH official

WASHINGTON, May 21: India and the US are working together to bridge the digital divide between the West and the Global South, a former senior White House official has said, underlining that the two nations were helping shape the framework for the "responsible and safe" use of Artificial Intelligence to benefit

their societies Participating in a panel discussion on "Strategic Synergies: India-US Technology Cooperation" on Monday as part of the Motwani Jadeja US-India Dialogue Series, Lisa Curtis, a former White House officer from the Trump Administration, said that the two countries are cooperating to advance the use of AI in cyber defence

and in protecting critical infrastructure. "We're working together to bridge the digital divide between the West and the global South," said Curtis, who served as the South Asia point person for former president Donald Trump.

"I think India's leadership at the G20 last year, especially on digital public infrastructure, demonstrated this critical role that India will play in this endeavour," she said at the event organised by the Hudson Institute think-tank.



"Together, we are helping shape the framework for the responsible and safe use of AI," she said. "This is because our two countries share technology values that emphasise both a culture of innovation, but also rules that place human life and human dignity and progress at the centre of our AI research and development,"

She added that both nations want to harness the power of AI to benefit "our societies and reduce the chances for the malign use of AI". At the same time, she said that it is hard to imagine that a continued close Russia-India defence relationship would not impact US-India defence

"I think India is confident that it can segment its relations with Russia and the United States and that it could put up firewalls that would safeguard US technology," she said. "But I think the US will remain cautious and reluctant to link its secure networks to Indian platforms and share sensitive defence information when India is still heavily reliant on Russian platforms," Curtis said. She added that the US-India technology cooperation in a potential

future Trump administration could continue. "The momentum we saw a flourishing of the US-India relationship during the previous Trump administration. We saw very good ties between the leadership between Prime Minister (Narendra) Modi and President Trump when he

was president," she said. "I would fully expect that these two leaders would pick up the relationship where it left off, were we to see a second Trump administration," she said, ahead of the US presidential elections in November. (PTI)

Tea workers demand timely wages in protests

DIBRUGARH, May 21: Under the banner of the Assam Chah Mazdoor Sangha (ACMS), hundreds of tea garden workers of Basmati Tea Estate staged a cease-work protest on Tuesday, demanding the payment of wages that have been pending for the last three months.

The tea garden workers, holding placards and banners, protested in front of the office of the tea estate, located at Lahowal in Dibrugarh.

Nabin Chandra Keot, Dibrugarh district ACMS secretary and central vice president, stated, "Today, the workers of Basmati Tea Estate ceased their work and staged a protest demanding regularisation of their wages. They have not received their wages for the last couple of months and are having a tough time running their families. The protest program was organised under the banner of ACMS.'

"The workers work for eight hours a day, but if they don't get their payment on time, they face problems running their families. They have also not received their rations for the last two months. We urge the management to clear all their dues," Keot added.

An agitated worker said, "The garden management didn't pay attention to our demand. We have not received our payment for the last three months, and due to that, we are facing serious problems. The management assured us that from next month the problem would be sorted out, but nothing has changed

"If our problems are not solved within a few days, we will intensify our movement," he said.

The agitated workers burned effigies of Prime Minister Narendra Modi, chief minister Himanta Biswa Sarma, Labour minister Saniav Kisan, and Andrew Yule management in a display of their frustration and anger.

Our Jorhat correspondent adds: The workers of Hoolungooree Tea Estate in Mariani, under the Titabar civil subdivision of Jorhat district, staged a sit-in demonstration within the garden campus on Tuesday, demanding the fulfillment of several critical needs. The protest, led by the Assam Chah Mazdoor Sangha (ACMS), highlighted the urgent requirements for timely payment of wages, provision of rations, and proper health

Holding banners and placards, the tea estate workers voiced their demands for the timely implementation of the Plantation Labour Act by the garden authorities. The protestors alleged that Andrew Yule Company, which owns ten gardens in Assam and employs about 20,000 permanent workers along

with numerous temporary workers, has been negligent in implementing the Act, leading to widespread suffering among the workforce.

The demonstrators shouted slogans to press for their demands and cautioned that if the company failed to address their grievances, they would escalate their agitation with a series of protest programs. The workers, united in their cause, marched in a procession to the demonstration spot, reinforcing their solidarity and determination.

The Hoolungooree Tea Estate is owned by Andrew Yule Tea Company Ltd, which is now under scrutiny for its handling of worker rights and benefits.

#### Iran faces uncertain future

he sudden death of Iranian President Ebrahim Raisi in a plane crash has thrown the Islamic Republic into a state of political uncertainty. Raisi's demise exacerbates the ongoing power struggle among Iran's hardline factions, each vying for influence in the eventual succession of the aging Ayatollah Ali Khamenei as Supreme Leader, Despite Raisi's absence, experts maintain that Iran's strategic policies, particularly regarding its stance toward the United States and Israel, will remain unchanged. Hamidreza Azizi, an Iranian academic and visiting fellow at the German Institute for International and Security Affairs, asserts that Iran's foreign policy decisions are firmly in the hands of Khamenei and the Islamic Revolutionary Guard Corps (IRGC). Azizi emphasizes that Raisi's death, while significant in domestic politics, will not fundamentally alter Iran's strategic direction. The Supreme Leader and the IRGC will continue to steer Iran's foreign policy, maintaining a rigid stance towards the US and its regional adversaries. Raisi's death also disrupts the anticipated succession plans within Iran's leadership. Mehran Haghirian, director of regional initiatives for the Bourse and Bazaar Foundation, notes that Raisi was expected to serve as president until Khamenei's death, positioning him as a likely suc-

The upcoming presidential election in July, already burdened by historically low voter turnout, now faces even greater challenges. With only 8% of eligible voters in Tehran participating in the recent parliamentary elections, mobilizing the electorate for the presidential race appears increasingly difficult. Raisi was seen as one of three potential candidates to succeed Khamenei. Initially perceived as a puppet controlled by hardliners, his 2021 presidential victory was secured by disqualifying moderate opponents. Following Khamenei's rejection of his son Mojtaba's candidacy, Raisi emerged as a frontrunner for the Supreme Leader role. His unexpected death leaves the leadership with a shortage of charismatic figures capable of filling his shoes. Alireza Arafi, another contender for Supreme Leader, is currently focused on becoming chairman of the Assembly of Experts, the body responsible for selecting the next Supreme Leader. However, Arafi lacks the charisma and widespread support necessary to succeed as president. This leaves a significant gap in the leadership landscape, with no clear candidate ready to assume Raisi's role.

Vali Nasr, a former US State Department advisor and current professor at Johns Hopkins University, underscores the importance of this leadership contest. Nasr highlights the years it took to establish Raisi as a potential Supreme Leader through his presidency. The absence of a clear successor comparable to Raisi adds to the uncertainty and intensifies the ongoing debate about Khamenei's eventual replacement. The IRGC and hardline factions are now tasked with quickly identifying and rallying behind a new candidate. However, this process is likely to deepen existing divisions. The absence of a consensus candidate with the necessary charisma and preparation further complicates Iran's political landscape. As the July election approaches, the nation faces the daunting task of navigating this transitional period without a clear leader. While Iran's strategic policies are expected to remain consistent, Raisi's death leaves a significant void in the country's leadership. The ensuing power struggle among hardline factions, coupled with the challenge of low voter turnout, places Iran at a critical juncture. The search for a new leader capable of unifying the nation and maintaining stability will be pivotal in shaping Iran's future trajectory.

### Freeing Julian Assange is a struggle for justice, journalism and peace

rudges of British Court must decide if Julian Assange would enjoy the same rights as a US citizen if tried in the United States.

It's an ironic question. The persecution of the WikiLeaks founder has rested from the beginning on US exceptionalism that rules do not apply to the United States as they apply to other countries - and extraterritoriality, that US law somehow applies to non-US citizens' conduct thousands of miles away from the US. Both apply too to the crimes Assange is being tormented for exposing.

The US can murder citizens of other countries by the hundred in drone strikes, without due process or even much in the way of diplomatic upset.

It can launch illegal war after illegal war, its soldiers can laugh as they gun down unarmed civilians from helicopters, it can loftily decline to recognise the authority of bodies like the International Criminal Court (while publicly welcoming indictments of other countries' officials before that court): but still it claims to police a "rules-based international order" under supposed threat from its rivals.

This is about journalism: as New York Times executive editor Dean Baquet has stated, it sets a frightening precedent when a iournalist can be accused of espionage for publishing classified material that was handed to him. Assange did not leak the information: he was never in the US government's employ. The Assange case warns reporters everywhere that publicising the crimes of the powerful could result in years be-

But it is also about empire. It is about proving that the reach of Washington is global, that you don't have to be in the US or from

the US for it to punish you. British politicians have cringed before US demands because of our country's vassal status in that empire. It has often been observed that the US-Britain extradition treaty is unequal, with the

extradited here than vice versa. But the Assange case has taken that to extremes: evidence of US wrongdoing can pile up without it making any difference to the extradition case.

As campaigner John Rees has written, "In the course of the court hearings it has become public knowledge that a lead witness for the prosecution lied, that Assange and his lawyers were spied on by the CIA, and that the CIA discussed at the highest levels plans to abduct or assassinate Assange. In any normal trial any one of these, let alone all of them, would have had the case dismissed.

But Britain can't dismiss the case. Tony Blair assured US president George W Bush when the invasion of Iraq was first mooted that Britain would be "with you, whatever": a decision he stuck to in the face of overwhelming opposition from the British public.

He was with Bush in what was termed the "project for a new American century." The project that dictated the wars now dictates the punishment Assange faces for showing the world, in intimate detail, how horrific they were, from the "collateral murder" video to the logs recording the hundreds of civilians killed by our bombs in Afghanistan.

Now the US and Britain want to militarise for still greater wars, in "multiple theatres including Russia, China, Iran and North Korea," according to Defence Secretary Grant Shapps. To do it they must maintain the myth that the West are the good guys.

Which means ensuring there are no more embarrassing exposés of the bloody lawlessness of the "rules-based international order" they claim to uphold. Assange, by this logic, must be punished.

For us, that makes his freedom all the more important. This is about justice for Julian Assange, and it is about defending the freedom of the press, but more crucially still it is about understanding the horrific reality of war, so we can stop the wars of the future. (IPA Service)

Continuing the legacy of his predecessor, Hassan Rouhani, Raisi upheld the "Look to the East" policy, prioritizing closer ties with China. This approach was pursued diligently by Raisi

In return, Beijing extended an economic lifeline to Iran by importing Iranian oil and facilitat-

ing a diplomatic accord between

Iran and Saudi Arabia in March

2023. During Raisi's presidency, Iran persisted as a staunch ally and financier of anti-US and anti-Western conflicts. The

country supplied combat drones to Russia for the war in Ukraine and provided arms to various regional proxies throughout the Middle East.

Since the outbreak of the Gaza war on October 7, 2023, Iran, under the leadership of Khamenei and Raisi, has carefully balanced supporting its regional proxies in their efforts against Israel and the United States, while steering clear of direct conflict with these conventionally superior adversaries.

The equilibrium was briefly shattered in April when, for the first time in history, the Islamic Republic launched a direct assault on Israel using drones and missiles. This unprecedented action was a response to an attack on Iran's consulate in Damascus.

Although Raisi doesn't directly handle foreign policy, he has been a staunch ally of the Iranian regime in its efforts to detach from the established international order. He has actively supported forging alliances with tility towards the West.

When the helicopter crashed, Raisi and his colleagues were on their way back from a dam inauguration ceremony in neighboring Azerbaijan. This event was likely an attempt by Iran to improve relations with Azerbaijan, despite Iran's previous ambiguous, if not adversarial, stance during the Nagorno-Karabakh conflict, which concluded with a decisive Azerbaijani victory in late 2023.

Supreme Leader Khamenei found in Raisi a steadfast loyalist, a trusted insider of the regime, and a potential successor with a long-standing commitment to the cause.

According to the Iranian constitution, if a president dies, the first vice president assumes the role of interim president. In this scenario, Mohammad Mokhber ould step into this interim role. Mokhber shares many political traits with Raisi and has played a significant role in Iran's negotiations for weapons deals with

Additionally, Iran must conduct presidential elections within 50 days of a president's death. The supreme leader's endorsement for the next president and potential successor is yet to be determined. It's highly likely that conservatives in Tehran will persist in rallying together, considering the internal and external pressures confronting them.

On the domestic front, this may manifest as increased state repression and manipulation of

## Why do some mothers kill their own children?

The whole country is still reeling under the shock of the Suchana Seth case. Seth, a highly educated, financially independent and empowered young mother killed her own small son, reportedly first drugging him to put him to sleep, and then suffocating him. The child was only four years

But this should not have been as shocking as it is now because we already are aware of the Sheena Bora case of a young woman in love having been diabolically and cold-bloodedly murdered allegedly by her own high-flying, glamorous and affluent mother Indrani Mukherjea. Neither of these women subscribe to the commonly held theories of why mothers kill their children.

Why do mothers kill their children at all? One reason forwarded is poverty where the mother kills her kids, and then herself, because life becomes unbearable. She is convinced that she cannot save her kids from poverty.

The other reason is domestic violence where the mother and her children are the victims. She kills her children so that they do not fall victim to more abuse. This is also known as altruistic killing in order to 'protect' the children from violence.

The third reason is that a kid dies accidentally when the mother physically beats the kid up. Her intention was not to kill child dies. This mainly happens in middle-class and upper middle-class urban families where the pressure on the child to achieve, in any field chosen by the mother, is too high. The mother remains unhappy when the child fails to live up to her aspirations.

The fourth, and most dangerous, reason is when there is serious marital trouble between the husband and the wife, and the child becomes a victim. This is what fits into the Suchana Seth case.

She was desperate not to allow her husband to meet their little son, when they were going through a divorce. She reportedly disobeyed the court orders to permit her husband visiting

When the husband approached the court and got the sanction, she still did not take the son to the appointed place to meet his father and ultimately, first drugged him to sleep and then smothered him to death. This is also known as murder resulting from spousal revenge.

For Indrani Mukherjea, the trigger was perhaps mainly pushed through greed for wealth which her daughter was refusing to part with.

Mythological stories are replete with mothers who have killed their own children. The first mythological character that comes to mind is Goddess Ganga who killed her seven children. She drowned her newborn babies immediately after the birth, one after the other.

After the eighth child's birth, her husband could not resist questioning her cruel act. The husband was oath-bound never to question her: otherwise. Ganga would leave him, but he had to this time. Ganga said that the children were famed sages, and she freed them from their pathetic mortal lives.

But because she couldn't save the eighth one from his destiny, she had to leave him and go. Ganga is a ferocious river and can never be tamed or questioned, and her husband broke the fundamental rule.

A 37-year-old Australian mother in Cairns, Queensland was arrested on suspicion of having killed eight kids between two and 14 years of age. Seven of these were her own.

The children were found by the local police when they went in response to a report from her 20-year-old son, about an injured woman but found much

The children were stabbed and the woman herself had bloodied wounds on her body. The mother was suspected to have been suffering from Münchausen Syndrome by Proxy (MSBP)

Münchausen's Syndrome is named after Baron Von Münchausen (1720-1791). People with Münchausen Syndrome have an uncontrolled need to exaggerate health complaints, falsify tests and/or inflict illnesses on themselves directly.

In Münchausen Syndrome by Proxy perpetrators fulfil their need for positive attention by

hurting their own child, thereby imposing the sick role onto their child, by proxy. In 1977, Roy Meadow, then professor of paediatrics at the University of Leeds, England, discovered the extraordinary behaviour of two mothers and labelled this Münchausen Syndrome by Proxy.

Professor Meadow said that one of the two mothers had poisoned her toddler with excessive quantities of salt, while the other had introduced her own blood into her baby's urine

MSBP is a lesser-known, lesser-written-about and lesser discussed issue of psychological health where the child is the victim of his/her mother's insane mental state who otherwise appears and behaves 'normally.' Mark Gado in his serialised article 'Mothers who Kill' in 'Crime Library' describes in detail some of the most notorious mothers in the history of crime.

Among them are Susan Smith, Andrea Yates, Sally Clark, Angela Cannings, Maxine Robinson and the most no-

torious of them all, Marybeth Tinning. It took 14 years and nine tiny corpses to finally take action against Tinning in 2011.

Tinning was charged with the murder of only one child, Tami Lynne. By that time, she was already 68 but was due for parole two years later.

Is India an exception? According to papers in the 'Indian Journal of Psychiatry', MSBP is present among Indian mothers but is manifest in different ways. In one case, a 12-yearold girl of 'low IQ' was brought to the psychiatry ward by her parents because dead house flies were coming out of her

The girl's ears were plugged with cotton wool which the mother had removed. The mother refused to leave the girl's side during examination and hospitalisation. When the doctors persuaded her to go home, the flies stopped coming out of the girl's ears.

The doctors organised a family meeting and the mother finally confessed that she had actually introduced dead flies

into her child's ear. The mother had been treated for generalised anxiety disorder and for dissociative disorder in the past.

In another case, when the mother of an infant brought in for a foamy discharge from the scalp was questioned by doctors, she confessed to applying baby shampoo on the scalp of her child and fabricating it for the doctor.

This is explained by a medical theory which mentions Sudden Infant Death Syndrome or SIDS. When sudden and completely asymptomatic death occurs in a new-born or infant, when every kind of post-death reasonings are exhausted, the death is labelled as SIDS.

The SIDS deaths only occur while the baby is in the crib. A baby does not die from SIDS in its mother's arms. In fact, picking up a baby is the only known way to prevent a sudden infant death.

But in many of these SIDS deaths of infants, doctors have expressed suspicion about the mother's hand in the death. However, it could not be proved for lack of concrete evidence, and also because the role of the mother is entirely sanctified by history, society, literature, cinema and family.

In some rare cases, the new mother becomes so psychologically depressed that the only relief she thinks she can get is by killing the infant. This is a severe case of depression and needs urgent medical attention to keep the new mother from doing it again.

SIDS was originally referred to as "cot death" because the infant was normally discovered in its bed or crib. However, since SIDS is a cause of death by exclusion and we still don't know what causes it.

Julie Gregory, a survivor of MSBP, in 'Sickened: The Memoir of a Munchausen' by Proxy Childhood (2003) lucidly sets out the story of her traumatic childhood spent under the supervision and 'care' of an insane mother and grandmother.

From early childhood, Gregory was continuously Xrayed, medicated, and operated on—in the vain pursuit of an illness created in her mother's mind.

The Mother Goddess in Hindu mythology is worshipped more as a mother than as a goddess. So, when a human female kills her own offspring, she is deemed to destroy this ideology of motherhood completely.

As Indians, we revere the mother in real life, history, literature and so on. It is impossible for us to accept that a mother can kill her own child. It is a patriarchal construct that sanctifies motherhood and places it on a pedestal ideologically higher than fatherhood.

That is why we are completely shocked by the criminal conduct of Suchana Seth and Indrani Mukherjea, who have effectively destroyed the pedestal called 'motherhood', built so carefully and cautiously by patriarchy. (Courtesy: Te

## Regularly eating avocado linked to lower diabetes risk in women

Tew research published in the Journal of the Academy of Nutrition and Dietetics suggests a potential association between avocado consumption and diabetes risk among Mexican adults. Diabetes is the second leading cause of death in Mexico, affecting around 15.2% of adults (12.8 million).

To investigate the relationship between avocado consumption and diabetes risk, researchers studied mostly self-reported dietary habits and diabetes diagnosis information from survey responses of a portion of the Mexican population. The majority of these respondents were classified as having overweight or obesity.

The results showed that women who consumed avocados were less likely to develop diabetes than those who did not eat them. This connection, however, was not observed in men.

#### Studying avocado consumption and diabetes

This study analyzed data on Mexican adults aged 20 and older from the Mexican National Survey of Health and Nutrition (ENSANUT) years 2012, 2016, and 2018. After excluding specific individuals, such as those who were pregnant or breastfeeding, and those with missing or unreliable data regarding diabetes and avocado intake, the final sample included 25,640 participants.

Approximately 59% were female, and more than 60% had abdominal obesity.

In the surveys, dietary information was assessed using a 7-day food-frequency questionnaire to determine avocado consumption habits, and participants were strictly classified as avocado consumers (consuming any amount of avocado) or non-consumers. The presence of diabetes was primarily identified through self-reported diagnoses, with a portion of the participants using clinical measures of blood sugar levels to confirm

The participants also self-reported demographic and cardiometabolic risk factors such as age, sex, socioeconomic level, education, body mass index (BMI), abdominal obesity, healthy eating index (HEI-2015) score, calorie intake, lifestyle habits, and pre-existing conditions.

However, trained personnel measured the participants' weight, height, and waist circumference. Upon gathering the survey data, the researchers analyzed it using descriptive statistics and logistic regression models to investigate the link between avocado consumption and diabetes risk among the adult population in Mexico.

#### Eating avocado tied to lower diabetes risk in women

Among the participants, about 45% reported consuming avocados, with average daily intakes of 34.7 grams (g) for men and 29.8 g for women.

Those who ate avocados generally had higher levels of education and belonged to a higher socioeconomic class than those who did not consume avocados. Additionally, over three-quarters of avocado consumers resided in urban areas. Across both genders, avocado eaters also

tended to have slightly higher scores on the healthy eating index, indicating a somewhat more nutritious diet overall.

These findings suggest that individuals who consumed avocados likely had greater access to and resources for healthier food options. It is important to note, however, that the study's adjusted models considered and accounted for these factors. In women, avocado consumers showed a 22% and 29% lower risk of developing diabetes in unadjusted and adjusted models, respectively. However, this protective effect of avocado consumption was not observed in men.

This relationship remained consistent when laboratory-confirmed diabetes diagnoses were used instead of self-reported diagnoses

How might avocados contribute to lower di-Medical News Today spoke with Avantika War-

ing, MD, a board-certified physician in endocrinology, diabetes, and metabolism, and chief medical officer at 9amHealth, not involved in the study, about how avocados may reduce diabetes risk among women.

Waring explained:

There are a few potential ways that avocado consumption could lower risk of diabetes in women, including the presence of antioxidants which can reduce inflammation and cellular damage that would otherwise increase the risk of conditions like diabetes. Avocados, being high in fat and fiber, also have a low glycemic index, and therefore don't promote spikes in glucose and the resulting rise in insulin levels that are metabolically unfavorable."

She pointed out, though, that these mechanisms are speculative, and suggested that the high fiber and healthy fats in avocados could also promote fullness, subsequently decreasing the intake of less nutritious foods.

Thomas M. Holland, MD, MS, physician-scientist at the RUSH Institute for Healthy Aging, Rush University System for Health, not involved in the study, similarly highlighted that avocados, rich in "insulin-sensitizing nutrients," could potentially stabilize the diabetic disease process.

"However, it remains a challenge to precisely determine why the association was observed only in women and not in men," he said.

He proposed that various factors might influence the disease course in women, including sex differences in diabetes that are related to hormonal changes across the lifespan, genetic and environmental factors, and psychosocial stressors that uniquely impact women's diabetes risk.

Waring concurred, emphasizing the significant hormonal shifts women experience during key life stages. "During pregnancy, women become more insulin resistant for example, and during menopause as estrogen levels drop, body fat patterns change in women that can result in a higher risk of diabetes," she said.

Ultimately, it is unclear what caused the sex differences in avocado consumption's impact on diabetes risk in this study, highlighting the need for further research on sex-specific dietary interventions and personalized nutrition recommenda-

#### Should we eat more avocados to lower risk of diabetes?

Eliza Whitaker, MS, RDN, a registered dietitian and medical nutrition advisor at Dietitian Insights, who was not involved in the study, noted the study's major limitation in broadly categorizing avocado consumers, making it hard to determine the beneficial amount of avocado intake.

She mentioned that lumping occasional and frequent avocado consumers together complicates understanding the precise impact on diabetes risk.

As far as we can tell, based on current science, she said: "Avocados may be associated with a lower risk of diabetes, but avocados alone aren't enough to reduce that risk. We have to look at the diet as a whole when it comes to reducing the risk of developing diabetes.

Waring echoed this sentiment, suggesting the study supports the consumption of unprocessed, heart-healthy foods, including fruits and vegetables, for better metabolic health but doesn't result in specific dietary guidance regarding avocado consumption.

Overall, "maintaining a healthy lifestyle, with diet being one component, enhances an individual's ability to take control of their disease process," Holland added, emphasizing a holistic approach to disease prevention.

Although the study cannot be used to draw definitive conclusions about avocado consumption and diabetes risk, Holland suggested the associations it reveals still carry significant weight. Regarding whether individuals should incorporate avocados to reduce diabetes risk, Holland concluded:

"Considering the abundance and diversity of nutrients found in avocados, there is compelling evidence that incorporating them into a healthier diet, such as the DASH diet, Mediterranean diet, or MIND diet, is strongly recommended for diabetes management." (Courtesy: Medical News

DUBAI, May 21: Mourners in black began gathering on Tuesday for days of funerals and processions for Iran's late president, foreign minister and others killed in a helicopter crash, a governmentled series of ceremonies aimed at both honoring the dead and projecting strength in an unsettled Middle East.

For Iran's Shiite theocracy, mass demonstrations have been crucial since millions thronged the streets of Tehran to welcome Grand Ayatollah Ruhollah Khomeini in 1979 during the Islamic Revolution, and also attended his funeral 10 years later. An estimated 1 million turned out in 2020 for processions for the late Revolutionary Guard Gen. Qassem Soleimani, who was slain in a U.S. drone

Whether President Ebrahim Raisi, Foreign Minister Hossein Amirabdollahian and others draw the same crowd remains in question, particularly as Raisi died in a helicopter crash, won his office in the lowest-turnout presidential election in the country's history and presided over sweeping crackdowns on all dissent. Prosecutors already have warned people over showing any public signs of celebrating his death and a heavy security force presence has been seen on the streets of Tehran since the crash.

But Raisi, 63, had been discussed as a possible successor for Iran's supreme leader, the 85-yearold Ayatollah Ali Khamenei. His death now throws that selection into question, particularly as there is no heir-apparent cleric for the presidency ahead of planned June 28 elections.

"Raisi's death comes at a moment when the Islamist regime is consolidated," wrote Alex Vatanka, an Iran expert at the Middle East Institute. "In short, there will be no power vacuum in Tehran; nonetheless, post-Khamenei Iran suddenly looks far less predictable than it did just a few days ago." A procession Tuesday morning led by a semitruck carrying the caskets of the dead slowly moved through the narrow streets of downtown



Tabriz, the closest major city near the site of the crash Sunday.

Thousands in black slowly walked beside the coffins, some throwing flowers up to them as an emcee wept through a loudspeaker for men he described as martyrs.. On Wednesday, a funeral presided over by Khamenei will then turn into a

guard at the airport. They will go on to the holy Shiite seminary city of Qom before returning to the Iranian capital.

It remains unclear what international presence that funeral will draw, as Raisi faced U.S. sanctions for his part in mass executions in 1988 and for abuses targeting protesters and dissidents while leading the country's judiciary. Iran under Raisi also shipped bomb-carrying drones to Russia to be used in its war on Ukraine.

"I don't feel comfortable sending condolences while Iran is sending drones that are used against civilians in Ukraine," wrote Lithuanian Foreign Minister Gabrielius Landsbergis on the social platform X. United Kingdom Security Minister Tom Tugendhat echoed that in his own message on X: 'President Raisi's regime has murdered thousands at home, and targeted people here in Britain and across Europe. I will not mourn him."

On Thursday, Raisi's hometown of Birjand will see a procession, followed by a funeral and burial at the Imam Reza shrine in the holy city of Mashhad, the only imam of the Shiite's faith buried in Iran. That shrine has long been a center for pilgrims and sees millions visit each year. Over the centuries, its grounds have served as the final burial site for heroes in Persian history. It's an incredibly high, rare honor in the faith. Iranian President Mohammad-Ali Rajai, the only other president to die in office when he was killed in a 1981 bombing, was buried in Tehran.

Iran's theocracy declared five days of mourning, encouraging people to attend the public mourning sessions. Typically, government employees and schoolchildren attend such events en masse, while others take part out of patriotism, curiosity or to witness historic events.

Across Iran, its rural population often more closely embraces the Shiite faith and the government. However, Tehran has long held a far different view of Raisi and his government's policies as mass protests have roiled the capital for years. (AP)

## Israel tries to contain fallout over ICC warrant requests after allies voice support for the move

JERUSALEM, May 21: Israel's foreign minister was headed to France on Tuesday in a bid to contain the fallout from the decision by the prosecutor of the world court to request arrest warrants for Israeli and Hamas leaders, a move supported by several European countries, including key ally France.

France, as well as Belgium and Slovenia, each said Monday they backed the move by International Criminal Court prosecutor Karim Khan, who accused Israeli Prime Minister Benjamin Netanyahu, his Defence Minister Yoav Gallant, and three Hamas leaders — Yahya Sinwar, Mohammed Deif and Ismail Haniyeh — of war crimes and crimes against humanity in the Gaza Strip and Israel.

Their support exposes divisions in the West's approach to Israel and deepens the country's global isolation over its conduct in the war in Gaza.

More than 35,000 Palestinians have been killed according to the Health Ministry in Gaza, which does not distinguish between noncombatants and fighters in its count. The war has sparked a humanitarian crisis that has displaced much of the coastal parts of it to starvation, which Khan said Israel used as a "method of warfare."

The war between began on October 7, following Hamas' deadly attack, when the militants from Gaza crossed into Israel and killed some 1,200 people, mostly civilians, and took 250 hostage. Khan accused Hamas' leaders of crimes against humanity, including extermination, murder and sexual violence.

Since the war began, violence has also flared in the occupied West Bank. Israel captured the West Bank in the 1967 Mideast war, along with east Jerusalem, which it later annexed, and the Gaza Strip, which it withdrew troops and settlers from in 2005. The Palestinians seek those territories as part of their future independent state, hopes for which have been dimmed since the war

### Sri Lanka launches probe after 4 Lankan nationals with IS links arrested in India: Report

COLOMBO, May 21: Sri Lanka has launched an investigation to obtain information on four of its citizens with links to the banned Islamic State. who were arrested in India when on an alleged mission to carry out terror activities in the country, a media report said on Tuesday.

Acting on a tip-off, the Gujarat Anti-Terrorist Squad (ATS) on Sunday apprehended four Sri Lankan nationals at the Sardar Vallabhai Patel airport in Ahmedabad after they travelled from Colombo via Chennai.

The men travelled to India to carry out terror activities at the behest of the banned terror outfit Islamic State (IS) and are members of IS radicalised by a leader from Sri Lanka who is living in Pakistan, according to the Indian police.

Sri Lanka's state intelligence has asked for further information from its Indian counterpart to verify the background of the suspects and probe their links to the IS, the Daily Mirror newspaper

Sri Lankan authorities will "immediately investigate" to take further action once the information is obtained, the newspaper said, citing sources.

Public Security Minister Tiran Alles and Inspector-General of Police (IGP) Deshabandu Tennakoon said they were taking these reports seriously and closely monitoring the develop-

Alles and Tennakoon said they would initiate discussions with Indian authorities to gather detailed information about the suspects and their activities, the report said.

"We are working in close coordination with our Indian counterparts to ensure that all necessary measures are taken to address any potential threat," Alles was quoted as saving. The accused, Mohammad Nusrat (35), Moham-

mad Faarukh (35), Mohammad Nafran (27) and Mohammad Rasdeen (43), informed investigators that they were earlier associated with the banned Sri Lankan radical militant outfit, National Thowheeth Jamath (NJT), and joined IS after getting in touch with Pakistani handler Abu Bakr Al Bagdadi, said Gujarat Director General of Police

The ATS team recovered three Pakistan-made pistols and 20 cartridges lying abandoned at a location in the city's Nana Chiloda area based on geo-coordinates and photographs found on the mobile phone seized from the accused, Sahay said, adding that the men were allegedly directed by their Pakistani handler to collect these.

They got in touch with Abu (the IS leader in Pakistan) in February this year and remained in contact with him through social media and were completely radicalised by the ideology," he said.

Their leader ordered them to carry out terrorist activities in India, to which they agreed, and even showed readiness to carry out suicide bombings, Sahay said. The men were paid Rs 4 lakh in Sri Lankan currency to carry out the activities, he said. The mobile phones recovered from the accused had photographs and documents showing their association with IS, and an IS flag was also recovered from their bag, and two such flags were recovered from the abandoned parcel containing weapons, the official said.

The men were instructed to leave these flags at the site of their terror activities, he said.

Interrogations revealed that Abu had informed the accused about the weapons hidden at the given location in Ahmedabad for their use, he said. The pistols carried star marks, and cartridges

## Amnesty chief criticises military trial of civilians in Pak; urges govt to uphold international obligations

KARACHI, May 21: Military courts in Pakistan should not try more than 100 people for their alleged role in attacks on army installations during the riots that followed former premier Imran Khan's arrest on May 9 last year, Amnesty International chief has said, urging the government to uphold its international obligations. The Universal Declaration of Human Rights and the International Covenant on Civil and Political Rights clearly state that civilians should not be tried by military courts, Amnesty International's Secretary Gen-

eral Dr Agnes Callamard said. The Amnesty chief, who is on her first regional visit to South Asia, was on Tuesday quoted by Dawn News as saying that although military trials for civilians are a "no-no" under international law, "sadly it has happened throughout Pakistan's political history... [and] is not a novelty". Callamard, emphasising the principles of transparency, due process and judicial independence, urged Pakistan to uphold its international obligations and safeguard constitutional guarantees ensuring the right to a fair trial.

"The use of military courts is threatening the constitutionality of what's happening right now," she said. Regarding the ban on X (formerly Twitter) in Pakistan, Callamard said Amnesty was quite alarmed by the shrinking space for freedom of expression in the country. Calling the ban "disproportionate, unnecessary and against international law", Callamard said it was particularly bad for individuals unable to access Virtual Private Networks (VPNs). "Everything is being targeted, the means of expres-

sion and the people who are expressing themselves. This includes journalists.' "The space for free speech in Pakistan is shrinking," Callamard said, noting that criticism of state institu-

tions did not constitute a crime under international law. "Pakistan should do the opposite of what it is doing right now," she said. Her statement came amidst the decision by Pakistan to conduct the trial of more than 100 civilians for their alleged role in attacks on army installations during the riots that followed jailed former premier Imran Khan's arrest on May 9 last year.

According to the Pakistani Army, 102 accused have been arrested for their alleged involvement in the attacks on key military establishments, including the General Headquarters in Rawalpindi, the Corps Commander's House in Lahore, Pakistan Air Force Base Mianwali, and an office of the Inter-Services Intelligence (ISI) in Faisalabad, have been handed over to the military authorities for trial. (PTI)

## World leaders plan new agreement on AI at virtual summit co-hosted by South Korea, UK dustry leaders and heads of interna-

**SEOUL, May 21:** World leaders are expected to adopt a new agreement on artificial intelligence when they gather virtually on Tuesday to discuss AI's potential risks but also ways to promote its benefits and innovation. The AI Seoul Summit is a follow-up to November's inaugural AI Safety Summit at Bletchley Park in the United Kingdom, where participating countries agreed to work together to contain the potentially "catastrophic" risks posed by galloping advances in AI.

The two-day meeting -- cohosted by the South Korean and UK governments -- also comes as major tech companies like Meta, OpenAI and Google roll out the latest versions of their AI models.

On Tuesday evening, South Korean President Yoon Suk Yeol and British Prime Minister Rishi Sunak are to meet other world leaders, intional organisations for a virtual conference. The online summit will be followed by an in-person meeting of digital ministers, experts and others on Wednesday, according to organisers.

"It is just six months since world leaders met at Bletchley, but even in this short space of time, the landscape of AI has changed

dramatically," Yoon and Sunak said in a joint article published in South Korea's JoongAng Ilbo newspaper and the UK's online inews site on Monday. "The pace of change will only continue to accelerate, so our work must accelerate too." While

the UK meeting centred on AI safety issues, the agenda for this week's gathering was expanded to also include "innovation and inclusivity," Wang Yun-jong, a deputy director of national security in

China doesn't plan to participate in the virtual summit though it will send a representative to Wednesday's in-person meeting, the South Korean presidential office said. China took part in the UK summit.

Notably, the northeastern state had faced a severe fuel crisis after the derailment of a goods train in Assam's Jatinga.

Disruption of traffic movement on the Assam-Agartala highway, considered a lifeline for Tripura, and through the rail links connecting the neighbouring state due to landslides during the monsoon season is common.

"In view of the recent disruption in the railway network in Assam's Jatinga, we are working



on alternative arrangements to ensure a seamless supply of fuel and goods via Bangladesh. The Agartala-Gangasagar (Bangladesh) rail tracks will be ready for goods transportation in the next six months to one year. Once the route is opened for goods movement, we can bring fuel and goods Kolkata directly via Bangladesh," transport minister

Sushanta Chowdhury said at a

press conference on Monday. Chief minister Manik Saha has recently said that the rail service between Agartala and Gangasagar will be made operational shortly.

Chowdhury said the Indian Oil Corporation Ltd (IOCL) has been working to build a large fuel depot in Sepahijala district's Sekerkote for fuel storage



## 9,662 people living with HIV in three Nagaland districts

HT Bureau GUWAHATI, May 21: Nodal Officer of Integrated Health Campaign, Nagaland State AIDS Control Society (NSACS) and deputy director of Sexually transmitted infections, Dr Zaiwang said

pur. Chumoukedima, and Niuland have an estimated 9,662 people living with HIV. However, the actual number of PLHIVs could be significantly

higher due to underreporting and social stigma. He was speaking during the launch of Integrated Health Campaign in Dimapur.

Comparing to India's HIV prevalence rate of 0.22 percent, the officer noted that Nagaland's rate is alarmingly higher at 1.61 percent, making it second highest in the country after Mizoram. Dr Zaiwang reported that out of the estimated 9,662 PLHIV, only 3,034 are receiving antiretroviral therapy, ART as of March 2024. This leaves 6,628 individuals without

treatment, highlighting urgent need for increased outreach and support services.

The campaign data also detailed targeted interventions for high-risk groups, including injecting drug users, female injecting drug users, men who have sex with men, trans-

gender individuals, female sex workers, truckers, and migrants. EAC Dimapur Imlijungla urged various stakeholders to work

together to ensure that these programs are effective and sustainable. Imlijungla stressed on early screening and prevention, adding that health issues among pregnant women was high. From April 2023 to March 2024, a total of 48 thousand 777 individuals were tested for HIV across Nagaland, with 960 testing positive. Among these, 919 were general clients, and 41 were antenatal care clients, indicating a significant number of HIV cases among pregnant women.

Addressing two election rallies in Sambalpur where the BJP has fielded Union Minister Dharmendra Pradhan, Shah said this time lotus, the party's symbol, will bloom in Odisha.

"After the fifth phase of polls, the NDA has already bagged 310 seats. We will secure 400 plus seats after the sixth and seventh rounds of polls," Shah claimed.

Alleging that Odisha has been ruled by a "handful of officers", Shah said this election will end the ongoing "babu raj" in the state. He alleged that the tribals of Keonjhar get no benefit even though most of the mines and mineral reserves of the country are located in Keonjhar district.

Claiming that Modi has ensured that there is no terrorism across the country, the Union Home minister said: "PoK (Pakistan occupied Kashmir) was with India and it would remain with us. India would take PoK." He criticised the Congress and its leaders who are reportedly frightened over Pakistan possessing an atom bomb. "Modi has given a befitting reply to Pakistan's terror activities and he does not fear such threat of nuclear bomb," Shah said.

Coming down heavily on the previous Congress government, Shah said: "Congress has done nothing for tribals. Former prime minister Atal Bihari Vajpayee had formed a separate ministry for tribal affairs while Narendra Modi as the PM has worked to eliminate Naxalism in Odisha, Andhra Pradesh and Telangana.'

Shah said PM Modi has constituted DMF (district mineral foundation) and given crores of rupees for the development of the tribal region.

"The budgetary allocation for tribal affairs has been enhanced to Rs 1.25 lakh crore during Modi government from Rs 25,000 crore given during the previous

SAMBALPUR/KEONJHAR (ODISHA), May 21: UPA regime," Shah said, adding that the BJP government has set up 740 Ekalabya Schools where one lakh students have been studying. He said about 40,000 teachers were appointed in these schools.

Shah said kendu leaf pluckers will get bonus and proper price on their minor forest produce. He also announced setting up a 500-bed hospital in Keonjhar and also another 500-bed hospital and medical college in Sambalpur. He said PF (provident fund) provision will be made for Kendu leaf workers.

Shah also accused the BJD government of insulting Odisha's pride, language, culture and tradition.

"BJP will give a young, energetic, hardworking and dynamic Odia 'Bhumiputra' (son of the soil) as chief minister if voted to power in the state," he told the gathering. He said the new BJP government will provide jobs to two lakh people in a span of one-and-halfa-year. Shah said: "Naveen Babu is forcing 'Babu shahi' (officers rule) on Odisha, and is assaulting the pride and dignity of the Odia people. He is throttling the culture and pride of the state.

Shah urged the people to elect a BJP government in the state to ensure speedy development and preservation of their rich culture. "A Bhumiputra will rule the land of 'Utkala Bhumi' and not a Tamil babu if people vote for BJP," he said.

PRAYAGRAJ (UP), May 21: Prime Minister Narendra Modi on Tuesday called the opposition Congress and the Samajwadi Party "antidevelopment", and said both parties have competed in the appearement of their vote bank.

"What used to happen (at Kumbh) during the time of SP-Congress? There used to be stampedes. People used to die... SP-Congress were more concerned about their vote bank than Kumbh," he said.

"They were afraid that if they were seen doing too much for Kumbh, their vote bank might get offended. There was a competition of appeasement between SP and Congress," Modi

said, addressing a rally in the region known for the Kumbh Mela and the 'Triveni Sangam'.

"This election of 2024 will decide the direction in which the Triveni of India's future will flow," the Prime Minister added.

Drawing a parallel between the spirit of Allahabad and that of today's India, he said, "Big countries tell me that they also need India's digital technology. India is raising its voice in the world. When India hosts the G20, the whole world is surprised. This is the nature of Prayagraj, people here are neither subdued by anyone nor do they live in fear of anyone.'

The prime minister alleged that the members

of the opposition INDIA block cannot digest the praise the country is getting abroad.

"The SP, Congress and INDI alliance members cannot digest the praise of India. The Congress' 'shahzade' goes abroad to abuse India. ## INDIA bloc inching closer to victory with each poll phase: CM Kejriwal

**NEW DELHI, May 21:** Chief Minister Arvind Kejriwal on Tuesday accused Union Home Minister Amit Shah of referring to the people of Delhi as "Pakistanis" and asserted that they are his family and should not be abused.

Addressing a virtual press conference, Kejriwal said with the completion of each phase of the Lok Sabha polls, it is becoming clearer that the Narendra Modi government is on its way out and the INDIA bloc is coming to power on June 4. He said the INDIA bloc will give a stable government to the country.

On Monday, Union Home Minister Amit Shah and Uttar Pradesh Yogi Adityanath addressed public meetings in South Delhi and East Delhi parliamentary constituencies respectively. Kejriwal alleged the number of people who attended Amit Shah's rally was less than 500.

"He said the supporters of the Aam Aadmi Party (AAP) are Pakistanis. I want to ask him that the people of Delhi have formed the government by giving us 62 seats (and) 56 per cent vote share. Are the people of Delhi Pakistanis?

"The people of Punjab have formed the gov-

ernment by giving us 92 out of 117 seats. Are the people of Punjab Pakistanis? The people of Gujarat gave us 14 per cent votes. Are the people of Gujarat also Pakistanis? The people of Goa gave us love (and) trust. Are the people of Goa also Pakistanis?" Kejriwal questioned.

He also said the AAP's panch, sarpanch, municipal mayors and councillors were elected in many parts of the country in the panchayat and municipal elections

"Are all the people of this country Pakistanis? What are you saying?" said the Delhi chief minister. Keiriwal's reaction came in response to a statement made by Shah during his rally a day earlier while seeking votes for his party's candidate in the South Delhi constituency, Ramvir Singh Bidhuri.

"Kejriwal and Rahul (Gandhi) have no support in India. Their supporters are in Pakistan," the home minister had said.

The AAP national convener said, "The Prime Minister has chosen you as his successor. You have become so arrogant about this that you started abusing people (and) threatening them."

Kejriwal, who is out on interim bail till June 1, has been alleging that Prime Minister Narendra Modi will retire next year after turning 75 and will appoint Shah as the prime minister if the NDA comes to power for the third time.

"You have not even become the PM yet and you have become so arrogant. For your information, let me tell you that you are not becoming the PM because the people are not forming the BJP government on June 4. The BJP is leaving

"Control your ego a little and do not abuse the public. Your enmity is with me (so) you can abuse me. But if you abuse the people of the country, no one is going to tolerate it," said Kejriwal. Delhi BJP chief Virendra Sachdeva said Kejriwal is raising question over Union minister Amit Shah's rally.

#### 1 killed, 3 injured in post-poll violonco in Rihar's Caran VIUIEIICE III DIIIAI 5 SALAII

SARAN (BIHAR), May 21: One person was killed and three others injured in post-poll violence in Bihar's Saran district on Tuesday morning, police said. The incident happened in the Bada Telma area near Bhikhari Thakur Chowk, they said.

An altercation broke out between two groups, said to be supporters of the BJP and RJD, over allegations of irregularities during polling that happened on Monday in the area, amid which shots One person was killed on the spot, and three oth-

ers were injured, a police officer said. The deceased was identified as Chandan Yadav (25), he added

"The injured persons were admitted to the nearest hospital. Later, two of them were sent to Patna for better treatment," Superintendent of Police Gaurav Mangla said.

"A case has been registered and an investigation is underway. Three persons have been arrested in connection with today's incident," he said. Internet was also suspended in the district to prevent a flare-up, he added.

#### one, but then you destroyed Over 30 flamingos killed after being hit by aircraft in Mumbai; environment activists seek probe

MUMBAI, May 21: More than 30 flamingos were killed after allegedly being hit by an aircraft in Mumbai, police said on Tuesday, as environmental activists demanded a probe into it by the DGCA and claimed urban planners had ignored warnings about such disasters. So far, carcasses of 32 flamingos have

been recovered from Ghatkopar area, the police said. The birds were hit by the aircraft be-

fore it landed here on Monday night, a

police official said. Various calls were received from people about the dead birds spotted at some places in Ghatkopar, said Pawan Sharma, founder of the Resqink Association for Wildlife Welfare (RAWW) and honorary wildlife warden with the

forest department. The forest department's mangrove cell along with the RAWW teams during a search operation found 29 dead flamingos in the area on Monday night, he said.

Three more carcasses were found dead on Tuesday, he said.

Stray dogs scavenged a few birds after they fell on the ground and some of the animal body parts were also spotted by locals, Sharma said.

The carcasses were sent for an au-

topsy and would later be disposed of as per the protocols, he said. The Wildlife Conflict Mitigation and Management Plan needs to to reviewed and revised by the airport authorities based on proper evaluation of the situation in coordination with the forest de-

RAWW secretary and zoologist Chinmay Joshi said. NatConnect Foundation director B N Kumar in a release said he has sent an email to the Directorate General of Civil Aviation (DGCA), and sought a highlevel probe to ascertain how the Emirates aircraft hit the birds and whether the pilot could not notice the flock on

"We are sad to say that it was a disaster waiting to happen," said the foundation working for environmental causes.



"Had any passenger been affected due to the bird hit, it would have made global headlines, but the death of 40 flamingos does not seem to bother the authorities, urban planners in particu-

lar," Kumar said. The flamingos were apparently on their return from Mumbai to Gujarat and their death is a warning to human beings of the impending disasters, Bombay Natural History Society (BNHS) researcher Mrugank Prabhu said.

Nearly a lakh flamingos keep flying to the Thane Creek Flamingo Sanctuary, which is a Ramsar site, NatConnect

The NGO, which along with other environment-focused organisations has been conducting a series of campaigns to save Mumbai's biodiversity, wetlands and mangroves, cautioned that the upcoming international airport in neighbouring Navi Mumbai could also be prone to such incidents.

This is because the wetlands and the flamingo abodes in Navi Mumbai are being systematically buried despite warnings from organisations such as BNHS, it said in the release.

The birds, if they miss their traditional destinations, could land at the Navi Mumbai airport site which has mudflats along the Panvel Creek, it said.

As part of the wildlife mitigation measures for the Atal Setu, the state government had planned bird sanctuaries at Sewri-Mahul, NRI-TS Chankaya and Panje-Dongari wetlands and other places, the release claimed.

"The Atal Setu is operational but we have not heard anything about protecting the wetlands," Kumar said.

NatConnect said the upcoming Navi Mumbai airport has committed in its Environment Impact Assessment (EIA) report that the wetlands as outlined by BNHS would be preserved.

The EIA, submitted for renewal of the environmental clearance (EC) for the Navi Mumbai airport, has also said that a golf course, planned on the NRI wetlands, was cancelled.

"This gave us the hope that wetlands would be preserved, yet the systematic destruction of water bodies is on," Nat-Connect said.

These birds have a right to their habitats, of which the Mumbai Creek and its satellite wetlands are a crucial cog in the wheel, Kharghar-based Nareshchandra Singh said.

"We need to carefully maintain the ecological and environmental balance at and around these habitats, otherwise expect such incidents," Singh said.

Sandip Sareen of the Navi Mumbai Environmental Preservation Society said the incident is heart-wrenching. (PTI)

# Lost 10 members of my family in this tragedy, can never forget it: Chhattisgarh accident survivor

man, who survived the accident in Chhattisgarh's Kabirdham that claimed 19 lives including that of his wife, said he managed to jump out of the mini goods carrier in time thinking the driver would gain control over it, but as the latter also leapt out of the vehicle it led to the tragedy.

Recounting the horrifying incident that occurred on Monday afternoon, Jodhiram Dhurve said he will never be able to forget the accident as he has lost 10 mem-

A total of 15 women, one man and three girls, all tribals, were killed and three others injured when the mini goods vehicle (a pick-up van) ferrying a group of tendu leaves collectors plunged into a valley on Banjari Ghat under Kukdur police station area.

Of the deceased, 17 were residents of Semarha village, two others were from nearby villages

Talking to PTI on Tuesday in Semarha, Dhurve said, "We had been using the same vehicle for the last three days, but nobody knew the fate would be otherwise on Monday.'

"Like any other day, around 36 people left from Semarha at around 4 am on Monday in the mini goods vehicle to pluck tendu leaves in Bahpani area, around 25 km away. After completing the work, they gathered near the goods vehicle at around 12.30 pm and had our lunch



and then left for Semarha around 1.20

"The bundles of tendu leaves were kept on the cargo bed on the rear side of the goods vehicle and women were sitting over the bundles. I was sitting next to the driver in his cabin. When the vehicle was descending in Banjari Ghat, the driver asked people to jump off from the moving vehicle citing that brakes had

"I then told the driver to turn the vehicle toward the rock as it will help in stopping the vehicle. I shouted to the occupants to jump off the vehicle following which some of the men did so. After the person sitting beside me jumped off

Dhurve said.

"We heard screams and cries and those who had managed to jump out of the vehicle rushed towards them. My wife and other women were lying on the road. We offered them water to drink," he said.

Dhurve said he lifted his wife, Dhanbai (52), with the help of others and brought her under a tree. Two anganwadi workers arrived there and people who were passing by called an ambulance. Forty-five arrived at the place, he said.

"My wife had suffered injuries on her head, but was conscious and talking to me," he said, adding that the ambulance took the injured persons, including his wife, to Kukdur hospital.

"I informed my elder son, who was in the village, about the incident over the phone, following which he reached the hospital. After her preliminary treatment there, when my wife was being shifted to Kabridham district hospital in Kawardha, she succumbed on the way," he added.

Rijiju also announced India's plans to build a new research station Maitri-II to strengthen capabilities to conduct vital research, particularly in connection with the instability of the East Antarctic Ice Sheet.

Voicing concern over the increase in the number of tourists in Antarctica, M Ravichandran, Secretary, Ministry of Earth Sciences, said it was the collective resolve of the ATCM to ensure that all activities, including research and tourism, were conducted in a manner that preserve its ecological integrity for future generations.

"India is honoured to lead this crucial initiative at the 46th ATCM that is expected to bring a series of actionable recommendations to be incorporated into the broader framework of the Antarctic Treaty System,' said Ravichandran, the head of the Indian delegation.

He said regulating tourism in Antarctica has been on the agenda since 1966 and a dedicated working group for the purpose has been formulated for the first time at the 46th ATCM hosted by India. (PTI)

#### 290 cases of Covid-19 variant KP.2, 34 cases of KP.1 detected in India: INSACOG

NEW DELHI, May 21: As many as 290 cases of KP.2 and 34 cases of KP.1, both sublineages of COVID-19 that are responsible for surge in cases in Singapore, have been found in India, according to official data.

However, a source in the Union health ministry told PTI that they are all sub variants of JN1 and there is no associated increase in hospitalization and severe cases.

"So there is no reason for concern or panic. The mutations will keep happening at a rapid pace and this is the natural behaviour of viruses like SARS-CoV2," the source said.

The source further said that the INSACOG surveillance is sensitive and is able to pick up the emergence of any new variant and samples are also picked from hospitals in a structured manner to detect any change in the severity of disease due to virus.

Data compiled by the Indian SARS-CoV-2 Genomics Consortium (INSACOG) showed that 34 cases of KP.1 have been found across seven states and UTs with 23 cases registered from West Bengal.

The other states are Goa (1), Gujarat (2), Haryana (1), Maharashtra (4) Rajasthan (2) and Uttarakhand (1).

As many as 290 cases of KP.2 have been registered with Maharashtra reporting the highest number at 148, according to the data. The other states and Union territories are

Delhi (1), Goa (12), Gujarat (23), Haryana (3), Karnataka (4), Madhya Pradesh (1), Odisha (17), Rajasthan (21), Uttar Pradesh (8), Uttarakhand (16) and West Bengal (36). Singapore is seeing a new COVID-19 wave

## Create joint culture: CDS Gen Chauhan to armed forces as govt looks at rolling out theatre commands

NEW DELHI, May 21: The proposed theatre commands will lay the foundation for catapulting the armed forces into the next orbit of military preparedness and war fighting, Chief of Defence Staff Gen Anil Chauhan said on Tues-

His comments came as India looks at implementing the ambitious and longawaited theaterisation plan.

In an address at an event, the Chief of Defence Staff Chief also called upon the three services to create a joint culture as they move towards forming 'joint operational structures".

He said the theatre commands will not be an end state but the beginning of the next set of reforms.

The integrated theatre commands will lead to many reforms like single to multi domain operations, fusing space and cyber space into traditional domains, digitisation of battlefield information and visualisation, net centric to data centric among others, he said.

Developing joint culture in the armed forces would be "jointness 2.0" which is the way forward, the Chief of Defence Staff said delivering the Maj Gen Samir Sinha Memorial Lecture.

He said "jointness 1.0" was about



better bonhomie and consensus among the services, and as there were no major differences, there is an impetus to move towards the next level which is "jointness 2.0".

Acknowledging the distinct culture of all the three services, Gen Chauhan underscored that there was a need to create a fourth culture in the services. "We must be able to distill the best

of each service, and incorporate the highest common factor, rather than settle for the least common denominator,"

said the Chief of Defence Staff. He mentioned various initiatives of

symbology that were being processed towards fostering the joint culture, including tri-services participation in national events.

Under the theaterisation model, the government seeks to integrate the capabilities of the army, air force and navy and optimally utilise their resources for wars and operations.

According to the theaterisation plan, each of the theatre commands will have

#### units of the Army, the Navy and the Air Force and all of them will work as a single entity looking after security challenges in a specified geographical ter-

At present, the Army, Navy and the Air Force have separate commands. The theatre commands are being planned to integrate the capabilities of

the three services and to ensure optimal utilisation of their resources. In his address, the Chief of Defence Staff termed jointness and integration

as pre-requisites to the creation of functional integrated theatre commands, and explained the significance of such

"The creation of such commands will separate the 'operational' functions from the Raise-Train-Sustain (RTS) and other administrative functions, and will allow greater focus of the operational commander to matters of security," he said.

Stressing that the reforms in the Indian defence ecosystem are a necessity, Gen Chauhan said, nation states across the globe are facing a new set of challenges, and current flux in world order is forcing them to review their security

#### Debt ridden farmer died by suicide in Karnataka

BELAGAVI (KARNATAKA), May 21: A 55-year-old farmer died by suicide after allegedly being harassed by a woman money-lender over repayment of ₹ 1.50 lakh loan amount taken from her, police said on Tues-

The incident occurred in Islampura village of Hukkeri taluk in Belagavi district, they

According to police, the farmer - Raju Khotagi- allegedly consumed poison on Sunday and was rushed to a hospital where he was admitted. Unfortunately, he died a day

Preliminary enquiry has suggested that the farmer had taken ₹ 1.50 lakh loan from 60year-old Siddavva Bayyanavara of the same village some six months ago after he allegedly suffered losses owing to severe drought. On May 18, the woman had summoned Raju and his family to her house. She asked them to pay back the loan amount immediately, a senior police officer said.

Apparently, the accused woman had taken the loan money from someone else and was allegedly putting pressure on Raju to return the amount. The farmer, however, sought some more time to repay the amount. He tried to arrange the money but when he failed to do so, he was allegedly insulted by the lender,

## Not involved in personal views arising due to miscommunication: Bharat Sevashram on monks' row

KOLKATA, May 21: The Bharat Sevashram Sangha on Tuesday attempted to bury the hatchet over the monks' row following controversial remarks by West Bengal Chief Minister Mamata Banerjee, with the monastic order contending that it is not involved in "personal views arising due to miscommu-

A monk from the order's Murshidabad district had sent a legal notice to Banerjee over her comments about certain socio-religious organisations in the state acting at the behest of the BJP.

Prime Minister Narendra Modi on Monday accused the CM of "acting under pressure of Islamic extremists" and held her responsible for "instigating violence" against monks "to appease the TMC's vote bank". Baneriee, on her part, had clarified that her subject of criticisms were certain individual monks belonging to the orders who "were working under instructions of the BJP" and not against any institution

"There may be some personal views and opinions arising due to miscommunication, but the Bharat



Sevashram Sangha is not involved in it. As a philanthropic institution, we are not against anyone," its principal secretary Biswatmananda Maharaj, also known as Dilip Maharaj, told PTI.

He also hailed both the Centre and the state government for their endeavours to promote activities of "Mamata Banerjee has always been supportive,"

Sources in the Sangha said that after Banerjee softened her stance on Monday, the organisation did not find any reason to continue dragging the controversy. Last week, while speaking at a public meeting at

Goghat in Arambag, the chief minister had claimed, "Some monks of the Ramakrishna Mission and Bharat Sevashram Sangha are working under the influence of BJP leaders in Delhi." Banerjee named Swami Pradiptananda, better

known as Kartik Maharaj, a senior monk with the Sangha working from its Beldanga establishment in Murshidabad, and alleged that he did not allow TMC poll agents to sit inside a polling station in Rejinagar when the Baharampur seat went to polls on May 13.

Kartik Maharaj responded by sending a legal notice to the chief minister and demanded a public apology from her.

Besides offering her clarification, Banerjee had on Monday stuck to her guns, saying the monk "garnered support for the BJP" while propagating spiritualism endorsed by the Sangha. "I have no issues if you do that. But, you should do it by wearing the BJP's badge, not as a monk," she had said.

Meanwhile, on early Sunday, unidentified miscreants reportedly threatened monks and other employees at gunpoint at the Ramakrishna Mission premises in Jalpaiguri district.

Condemning the attack, the PM accused the TMC regime of unleashing a reign of terror on monks to appease its vote bank. Addressing an election rally in Jhargram on Mon-

day, Modi had claimed that Banerjee was "issuing threats" against the monks of the Ramakrishna Mission and Bharat Sevashram Sangha, emboldening 'TMC goons to attack" the ashram.

"ISKCON, Ramakrishna Mission and Bharat Sevashram Sangha are known for service and morality, but today the chief minister of Bengal is openly threatening them. This is being done to appease the vote bank. As the CM herself is threatening the monks, TMC goons now dare to attack Ramakrishna Mission," he had said. (PTI)

## Scientists call for more screening, awareness on inherited defects in anaemic patients in India

**NEW DELHI, May 21:** Researchers have uncovered inherited iron metabolism defects in anaemic patients in India, suggesting the need for "active screening and awareness of such rare diseases" in the

'This research is particularly important at this time to help reduce the burden of rare inherited defects in our country, devise strategies to identify the target at risk population for screening, and provide options for novel therapeutics or timely stem cell transplant," said Amita Trehan, a lead researcher of the study led by the Postgraduate Institute of Medical Education and Research (PGIMER), Chandigarh.

Anaemia resulting from iron deficiency in the body is the most common cause of the disease globally. Other forms of anaemia include those arising out of vitamin deficiency and sickle cell.

However, the condition is underdiagnosed due to lack of awareness or methodical screening, according to the study.

Possible symptoms of anaemia are fa-

tigue, dizziness, pale skin and headaches. 'In India, iron deficiency anaemia affects 30-40 per cent of children aged 2-5 years. With such high frequency, clinicians in out-



patient departments, especially in periphcytic hypochromic anaemia upfront witheral healthcare facilities, end up prescribing out systematic evaluation of a basic iron oral iron to any child suffering from microprofile," said the lead authors Trehan, Pra-

teek Bhatia, and Pankaj Sharma from the Pediatric Haematology Oncology Unit, Microcytic hypochromic anaemia refers

to the condition in which the red blood cells are smaller than usual and show reduced "When the response to this treatment is

suboptimal or absent, they (clinicians) are unsure how to proceed. In addition, they are puzzled when they encounter a case with anaemia and abnormal iron profile suggestive of iron overload without secondary evidence of hemolytic disease or hemoglobinopathy on screening," said the lead authors of the study, which was published in The Journal of Molecular Diag-

For the study, the researchers shortlisted nearly 300 anaemia cases from 2019 to 2022 after an initial screening. After excluding patients diagnosed with conditions such as inflammation and chronic bleeding, the team included 41 cases of suspected iron metabolism defects in their analysis.

"The systematic evaluation of anaemia cases from our high iron deficient endemic population, based on clinical criteria and basic and advanced genomic tests, helped us uncover an inherited iron defect in 41 per cent of the cases, suggesting the need for active screening and awareness for such rare diseases in our population," said Bha-

The authors explained that the iron metabolism defects, potentially causing anaemia, can be of two types -- sideroblastic or nonsideroblastic. While the sideroblastic defects result

when iron is abnormally used during the production of RBCs, the nonsideroblastic ones can block iron being utilised within the cells, they said. The next stage of analysis involved ge-

nomic analysis, which helped the researchers identify both these kinds of iron metabolism defects in the 41-case cohort. The authors said they were "surprised"

to find many of the rare sideroblastic defects in the cohort presenting either in late childhood or adulthood or being undiag-

They were also "surprised" to find a different novel yet recurrent mutation in SLC25A38 gene in unrelated patients from the northern part of the country, suggesting an ethnically diverse population in the Indian subcontinent. (PTI)

Scarlett Johansson accuses OpenAI of making ChatGPT voice similar to her

LOS ANGELES, May 21: Hollywood actor Scarlett Johansson has accused OpenAI of ripping off her voice for the new ChatGPT AI named "Sky", even though she had declined the company's offer. The artificial intelligence company on Monday announced that it has decided to "pause" the Sky feature after questions were raised over the voice feature.

"We've heard questions about how we chose the voices in ChatGPT, especially Sky. We are working to pause the use of Sky while we address them," the

company posted on its official X page. In a statement to American news outlet Variety, Johansson said she was contacted by OpenAI CEO Sam Altman in September 2023 about the company hiring her to provide the voice for Chat-GPT 4.0 but she declined the offer for

"personal reasons". "When I heard the released demo, I was shocked, angered and in disbelief that Mr. Altman would pursue a voice that sounded so eerily similar to mine that my closest friends and news outlets could not tell the difference," Johansson said. "Mr Altman even insinuated that the similarity was intentional, tweeting a single word 'her'

a reference to the film in which I voiced a chat system, Samantha, who forms an intimate relationship with a human," she added.

On Monday, OpenAI also posted a blog post in which the company said that Sky's voice was not an imitation of Johansson, but belonged to a different professional actress.

"We believe that AI voices should not deliberately mimic a celebrity's distinctive voice—Sky's voice is not an imitation of Scarlett Johansson but belongs to a different professional actress using her own natural speaking voice.

"To protect their privacy, we cannot share the names of our voice talents," the company posted.

Johansson, 39, also revealed that Altman contacted her agent two days prior to the release of ChatGPT 4.0 demo and urged her to reconsider the decision.

Two days before the demo was released, Mr Altman contacted my agent, asking me to reconsider. Before we could connect, the system was out there. As a result of their actions, I was forced to hire legal counsel, who wrote two letters to Mr Altman and OpenAI, setting out what they had done and asking them to detail the exact process by which they created the 'Sky' voice. Consequently, OpenAI reluctantly

agreed to take down the 'Sky' voice," she said in the statement.

"In a time when we are all grappling with deepfakes and the protection of our own likeness, our own work, our own identities, I believe these are questions that deserve absolute clarity.

"I look forward to resolution in the form of transparency and the passage of appropriate legislation to help ensure that individual rights are protected," she wrote. When asked for a comment over the matter, Altman, in another statement, reiterated that the voice used by the company for Sky belonged to a different actor and had nothing to do with Johansson. Slot was confirmed on Monday after he signed a long-term contract with the six-time European Cup winner and 19-time English champion. He will follow in the footsteps of an Anfield icon in Klopp, who ended Liverpool's 30-year wait for the English title in 2020 and won a full set of major trophies in his time at the Merseyside club.

Slot comes in with a winning record of his own after leading Feyenoord to the Dutch title last year and following that with the Dutch Cup this season.

He will formally take up his role on June 1 and his contract runs through to 2027, a person with knowledge of the deal told The Associated Press. The person spoke on the condition of anonymity because the details of the contract have not been made public. Slot's appointment was expected for some time, as the 45-year-old Dutchman said he was in talks with Liverpool in April and announced he would be Klopp's successor last week.

## Vennam fourth in Nadal returns to Roland Garros to practice amid doubts over his fitness

PARIS, May 21: Rafael Nadal returned to Roland Garros on Monday to practice and try to figure out whether to compete at the French Open, a tournament he has won a record 14 times.

The 37-year-old Spaniard showed up late in the afternoon with his coach, Carlos Moya, and a couple of sparring partners at Court Philippe Chatrier, which was open to the public.

About 6,000 fans were there at the French Open's main stadium, cheering loudly as Nadal stepped onto the court. After the practice, which lasted about an hour and a half, Nadal signed several autographs before disappearing through a doorway and into a tunnel that leads toward the locker rooms.

The training session gave Nadal a chance to reacquaint himself with the red clay at Roland Garros — he hasn't played a match there in two years — and test his fitness.

The tournament begins on Sunday and it remains uncertain if Nadal will enter.

He is still regaining his match readiness after missing nearly all of 2023 with a hip injury that required surgery, and much of this season because of problems with a hip muscle and an abdominal muscle. ## Bayer Leverkusen's two steps from soccer immortality start in Europa League final against Atalanta



**DUBLIN, May 21:** Bayer Leverkusen is two games from European soccer immortality. The new champion of Germany has two cup finals in four days starting Wednesday in the Europa League against Atalanta — to complete a previously unthinkable unbeaten season in domestic and continental competi-

On Saturday, Leverkusen will be heavily favored to win the German cup final against a Kaiserslautern team that finished 13th in the second division, not so far from falling into relegation playoffs.

Alonso twice won the Champions League as an elegant midfielder, with Liverpool and then Real Madrid, who will play Borussia Dortmund for this season's Champions League title. That June 1 final at Wembley Stadium is between two teams involved in the failed Super League breakaway in 2021 -Madrid driving it forward, Dortmund declining its invitation.

Bayer Leverkusen and Atalanta were nowhere close to being invited to the breakaway three years ago and today represent soccer projects that won respect from neutral fans across Europe.

Both are based in provincial cities, each with more than 100 years of history, reaching surprise peaks. Before this season, they had only ever won three trophies: Atalanta's Italian cup in 1963 and Leverkusen's 1988 UEFA Cup – the forerunner of the Europa League - and Germany cup in 1993.

While Leverkusen once lost a Champions League final, to Madrid in 2002, and Atalanta was minutes away from a semifinals place in 2020, neither has felt entitled to European success.

Their modest stadiums in Leverkusen and Bergamo add up to a combined capacity of about 51,000 that could fit into the Dublin venue, formerly Lansdowne Road, that will host them Wednesday. For a showpiece European final, the official limit is 48,000.

Leverkusen and Atalanta do not figure in UEFA research of the top-50 earnings list of European clubs for total matchday income from ticket and hospitality

Two well-run clubs, relying on smart transfer dealings — albeit underwritten, respectively, by pharmaceutical giant Bayer and Boston Celtics co-owner Steve Pagliuca — had combined total revenues last year that added up to about the same \$500 million as Manchester City's player wage bill alone.

Yet both Leverkusen and Atalanta, under coach Gian Piero Gasperini since 2016, play easy-on-theeye soccer in attack and team-first defense.

'They play one against one on the whole pitch,' Schick said of Atalanta. "Wherever you move, you have one defender behind you so they don't leave you the space to breathe.'

Atalanta has been a refreshing force under Gasperini and already has a place in the Champions League next season. In any normal year they would be popular first-time European title winners. What Leverkusen has done is not normal, though, and a legend could be just days from being created. (AP)

### In professional sport, nobody gives you a discount for age: Dhoni

NEW DELHI, May 21: Nearing 43, Mahendra Singh Dhoni's sixhitting ability and fitness remains as good as anyone and the former India skipper says he has no option but to keep working hard and stay fit since "nobody gives you a discount for age". Dhoni, who handed Chennai Super Kings' captaincy to Ruturaj Gaikwad at the start of the 2024 IPL season, played all 14 league stage games, batted way down the order and yet made a huge impact.

The World Cup-winning captain scored 161 runs at an incredible strike rate of 220.55, forcing many to believe that he can play for two more years in the IPL.

The iconic cricketer admitted that it is tough for him to perform after he comes straight to the IPL without playing any cricket prior to the league.

"The toughest thing is, I am not playing cricket throughout the year. So I have to be fit. Once I come, you are competing against youngsters who are fit and playing international cricket. Professional sport is not easy, nobody gives you a discount for age," Dhoni said in a video that is doing the rounds on social media.

"If you want to play, you have to be as fit as the other guy. Age does not really give that grace to you. So, eating habits, a bit of training and all those things are there. Social media, thankfully, I am not on social media, so there's less distraction," Dhoni said in the video posted by Dubai Eye 103.8 YouTube channel.

For the legendary cricketer from Jharkhand, things like farming, riding bikes and vintage cars work as stress buster for him.

"Once I quit international cricket. I wanted to spend a bit more time with my family. But, at that same time, to be mentally ac-



tive, to have that passion to stay focussed — for me, I love farming, for me it is the motorbikes, I have started getting into vintage cars.

"These things de-stress me. If am stressed, I would maybe go to the garage, spend a couple of hours over there and I will just be fine, I would come back," he said.

"I have always felt growing up with a pet, whether it is a cat or a dog... I prefer dogs though. They have unconditional love towards you. I have said this in a previous interview, even if I lose a game and come back, my dog greets me the same way

He has been a much admired leader at CSK and Dhoni said that "we need to earn that respect of the people you're leading"

'You cannot command or demand respect. You need to earn it. I may have a position in an institution, and yes, that position needs to be respected. But me as an individual sitting on the chair, I need to earn that respect.

"I cannot just say 'respect me'! If you have the respect of the people around you, they give 10 to 15 percent more.

"India is slightly different. People talk about being professional.

Yes, we Indians are professional, but our emotional connect is stronger. I feel as an Indian, my strength is the emotional connect.

While he is not a big fan of social media, Dhoni would prefer Instagram over X to avoid controversy. "I prefer Instagram over Twitter (X). I believe that nothing good has happened over Twitter, you know, especially in India, there's always a controversy. Somebody will write something and it turns into a controversy.

"I was like why do I need to be there? It used to be 140 characters. You cannot elaborate. Imagine me putting something over there and then it is left to the people to read it. And they just interpret what they want to interpret.

"So I'm like, no, no, that's not really for me. Instagram, still I like because I could put up my picture or video or something and just leave it. That is also changing now. So I still prefer Instagram, but I'm not very active because less distractions are better." (PTI)

#### WFI exempts Olympic quota winners from trials but will assess them in Hungary

NEW DELHI, May 21: The Wrestling Federation of India (WFI) on Tuesday decided to exempt all six Olympic quota winners from selection trials but their form and fitness will be assessed at the upcoming Ranking Series event and the subsequent training camp in Hungary.

The WFI said the decision to not hold trials has been taken under peculiar circumstances and should not be used as a precedent in future.

The WFI also made it clear that if any wrestler is found to be lacking in fitness, the federation would consider a replacement through trials before July 8, the deadline for sending entries. India have got six quotas for the Paris Games where Aman Sehrawat (57kg) will be the lone male wrestler in fray from the country. Vinesh Phogat (50kg), Antim Panghal (53kg), Anshu Malik (57kg), Nisha Dahiya (68kg) and Reetika Hooda (76kg) are the women wrestlers who have qualified.

The wrestlers had requested the WFI not to hold trials, arguing that it could lead to injuries and the selection committee, led by President Sanjay Singh, accepted the plea.

"We discussed the issue and both chief coaches were also of the view that trials could lead to injuries and impact India's medal chances. So we have decided not to hold trials," Sanjay Sngh told PTI after the meeting.

The quota winners will compete in a UWW Ranking Series in Budapest from June 6-9 and will also participate in a training camp after the conclusion of the tournament from June 10-21. "We have to ensure that no wrestler carries any injury into the Olympics. So, instead of trials, the Indian coaches will assess the quota winners at the Ranking Series event and at the following training camp in Budapest. (PTI)
