GUWAHATI, May 27: Several districts of Assam are on high alert in the wake of forecast for heavy to extremely heavy rainfall from Monday under the impact of Cyclone Remal, which made landfall in neighbouring West Bengal and Bangladesh.

The administration has urged people to maintain safety measures, and set up helpline numbers in case of emergency.

The Northeast Frontier Railway. in a release, said 42 trains have been cancelled for two days from Monday.

Several parts of Assam, including Guwahati, received rainfall since late Sunday evening, bringing down soaring mercury levels in the state.

No reports of damage due to the impact of the cyclone have been received yet, official sources said. "Cyclone Remal can bring in-

PATKURA/KAKATPUR (ODISHA), May 27: Chief Minister Himanta Biswa Sarma on Monday claimed that a BJP government will take oath in Odisha on June 10.

Lok Sabha and Assembly elections are being held simultaneously in Odisha.

"As per my prediction, we (BJP) have got almost a majority in the first three phases of assembly election in Odisha. Only very few seats are left to form a government and that will be filled up on June 1," he said while addressing election rallies at Patkura and Kakatpur.

Three phases of polling for the Assembly and Lok Sabha elections in the state is over. The fourth and final phase will be held on June 1 for six Lok Sabha constituencies and 42 Assembly segments.

"I would like to say one thing the BJP government will take oath on June 10. We have to send Pandian (BJD leader V K Pandian) back to

BJP govt will take oath in Odisha on June 10: Himanta Tamil Nadu on June 11," he said. If the state gets a good government then Odisha can become the number one state in the country.

"Today, the youth of Odisha are migrating to other states due to unemployment. On the other hand, one lakh government posts are lying vacant in the state and the Odia youth are not being employed in ocal industries", Sarma said.

He claimed after the BJP government is formed in Odisha, the one lakh vacant posts will be filled up within a year.

The natural resources of Odisha are being transferred to outsiders, he alleged. Public funds allegedly misused for BJP leaders' Vietnam trip: Ji Kathar

DIPHU, May 27: The president of the All Party Hills Leaders Conference (APHLC), JI Kathar, has stirred controversy with claims that a trip undertaken by BJP leaders of Karbi Anglong to Vietnam cost a staggering ₹ 14 crore, allegedly drawn from public funds.

In a press conference held at his residence, Kathar accused the Karbi Anglong Autonomous Council (KAAC) of funding the trip with money from the Panchayat and Rural Department (P&RD), igniting outrage over the purported misuse of government resources.

"It is unfortunate that the KAAC has not been able to fulfill its financial obligations, such as paying the bills of petty tribal contractors and ensuring salaries for teachers and employees of certain departments. Yet, they saw fit to allocate ₹ 14 crore from the public exchequer for a lavish trip to Vietnam," he alleged.



NEW DELHI, May 27: Technology will be a key enabler for the new criminal laws that come into effect July 1 as summons will be issued by SMS, 90 per cent witnesses will appear through video calls and courts will issue orders within three years of filing of an FIR, Union home minister Amit Shah has said.

"I can tell you with confidence that after three years, our criminal justice system will be the most modern criminal justice system in the world," he told PTI in an interview over the weekend.

Piloted by the home minister himself, the newly enacted criminal laws -- the Bharatiya Nyaya Sanhita, the Bharatiya Nagarik Suraksha Sanhita and the Bharatiya Sakshya Act will come into effect from July 1. replacing the colonial-era In-

Modi govt reshaped Budget in 10 years, reforms LIC Q4 net profit rises 2 pc to ₹ 13,763 cr NEW DELHI, May 27: Insurance During the entire financial year measured by First Year Premium to continue to make India developed nation: FM behemoth LIC on Monday posted a marginal 2 per cent increase in net profit at ₹ 13,763 crore in the fourth quarter ended March 2024

NEW DELHI, May 27: Finance Minister Nirmala Sitharaman on Monday said the Modi government has reshaped the Union budget in the last 10 years from a mere record of expenditure to a strategic blueprint for equitable distribution, and stressed that the pace of reforms will continue to make India a developed nation.

Sitharaman said the government will continue to maximise the value and impact of hard-earned taxpayer money, ensuring it is put to the best possible use for the benefit of all. The minister said the Modi government has prioritised transparency in its budgeting practices and numbers. Countries with transparent budgets are often viewed favourably by international bodies such as the IMF and the World Bank. This can lead to improved global trust.

"This starkly contrasts the @IN-CIndia-led UPA government's repetitive practice of hiding the deficits through off-budget borrowings and issuance of 'Oil Bonds', which somewhat covertly shifted the fiscal burden to future generations. Under UPA, standard fiscal practices were routinely changed to make Budget numbers look favourable," Sitharaman said in a post on X.



She said the last decade has witnessed a substantial improvement in the sanctity and credibility of the Union Budget, leaving past constraints and archaic practices behind. "Our government has reshaped the budget from a mere record of expenditures into a strategic blueprint for equitable development. We make judicious & efficient use of every rupee collected from our taxpayers and give them a transparent picture of public finances," Sitharaman said.

The minister said the government has taken various reforms to strengthen and bring transparency to the budgetary process and practices. Since FY 2017-18, the budget presentation has been shifted to 1st February instead of the last working day in February. It effectively advanced the expenditure cycle by two months, she said. Sitharaman further said reform in government expenditure by bringing in Treasury Single Account (TSA) for the 'just-in-time' release of funds to autonomous bodies has lowered the borrowing costs for the Centre. "TSA has resulted in savings of more than ₹ 15,000 crores to date," she said.

Sitharaman said the Union government administers 108 Centrally Sponsored Schemes (CSS)

through state and UT governments, with a budget of approximately ₹5.01 lakh crore for FY 2024-25 and ₹ 4.76 lakh crore for FY 2023-24. Previously, it was challenging to ascertain the timeliness and amount of funds released to the implementing agencies under a CSS and to determine whether the funds were from the Centre or the state.

However, with the implementation of Single Nodal Agency (SNA), under which each state has to identify and designate a Single Nodal Agency (SNA) for every CSS, there have been savings of about ₹ 10,592 crore from 2021-22 to date. Sitharaman said the Union budgets under the Modi government are characterised by fiscal prudence, transparency, and inclusiveness, ensuring investments in social development and infrastructure. The Modi government, the minister said, is committed to harnessing cutting-edge technology, enhancing transparency, and pursuing ongoing reforms to lay a strong foundation for a Viksit Bharat

"We will continue to maximise the value and impact of hardearned taxpaver money, ensuring it is put to the best possible use for the benefit of all," she said. (PTI)

The income from renewal premiums in the reporting period rose to ₹77,368 crore compared to ₹ 76,009 crore a year ago.

ended March 2024, the insurer earned a profit of ₹ 40,676 crore as compared to ₹ 36,397 crore in the previous fiscal. The total premium income for year ended March 2024 was ₹ 4,75,070 crore as compared to ₹ 4,74,005 crore in the year

ended March 2023. A total of 2,03,92,973 policies were sold in the individual segment in FY24 as compared to 2,04,28,937 policies sold previous fiscal. The board recommended a final dividend of ₹ 6 per share for 2023-24 subject to approval of shareholders, LIC Chairman Siddhartha Mohanty said.

Earlier, during the year an interim dividend of ₹4 was declared and paid to shareholders of the corporation. Therefore, he said, the total of interim and recommended final dividend aggregates to ₹ 10 per share. In terms of market share Income (FYPI) (as per IRDAI), LIC continues to be the market leader by market share in Indian life insurance business with overall market share of 58.87 per cent.

Commenting on financial numbers, Mohanty said, "We have more than doubled our share of non-par business within our individual business. Now we intend to focus our strategic interventions to maximize our market share across categories. At the same time, our sharp focus on various parameters which create superior value for all stakeholders shall continue, as demonstrated.'

There are key initiatives related to distribution channel and digital transformation underway, he said, adding topline growth trajectory will be back in focus during the current financial year. (PTI)

the India Meteorological Department has warned of extremely heavy rainfall over Assam along with other northeastern states on Monday and Tuesday. A red alert for extremely heavy rainfall has been issued in Chirang, Goalpara, Baksa, Dima Hasao, Cachar, Hailakandi and Karimganj districts, and an orange alert for Dhubri, South Salmara, Bongaigaon, Bajali, Tamulpur, Barpeta, Nalbari, Morigaon, Nagaon, Hojai and West Karbi Anglong in Assam.

Squally winds of 40-50 kmph gusting to 60 kmph are likely over South Assam and Meghalaya on Monday, the weather office said. The ASDMA has ramped up preparations along with other departments, agencies and district administrations to face any eventuality arising out of heavy rainfall and severe winds due to 'Remal'. the release said. NDRF teams have been deployed in Cachar, Bongaigaon and Dibrugarh, while personnel of Fire and Emergency Services are also on standby, officials said. The ASDMA has also recommended regulation of plying of boats if needed in the mainstream of Brahmaputra river on Monday and Tuesday. The Guwahati Municipal Corporation (GMC) has ensured the desiltation of major river channels like Bharalu, Bahini, Basistha, Mora Bharalu and Lakhimijan along with other major drains.

Meanwhile, "anticipatory evacuation of vulnerable populations from landslide-prone areas in Guwahati, Kamrup, Dima Hasao, Cachar, Karimganj, Hailakandi, Karbi Anglong and West Karbi Anglong districts may also be considered", the ASDMA release said. (PTI)

in the jail and has not been able to regain even after his release and renewing his earlier lifestyle to the extent possible, it said. "In the meantime, recent test reports confirm that the Appellant has also developed an unusually high blood glucose level as well as high ketone levels in urine, which indicate that in addition to increased blood sugar level, the appellant may have also developed kidney related complications and kidney damage," it said. Referring to his recent health check up at his residence by a senior physician of a private hospital, the plea said the doctor took note of Kejriwal's health complications and increased risk indicators and prescribed a host of full body tests, which are necessary to be carried out before he surrenders. "It is important to note that unexplained weight loss which a person is not able to regain along with the other symptoms ..., can have a host of causes, including some potentially life threatening ones. "It is on account of this that a senior physician from Max Hospital upon a detailed clinical examination of the appellant at his home on May 25, 2024 has directed a host of tests including but not limited to tests such as whole body PET-CT to rule out any malignancies and Holter Monitor Test, where the appellant will be required to wear a Holter monitor for a few days while going about his daily activities to identify any irregularities in his heart functioning," the plea said. The PET-CT scan shows detailed pictures of organs and tissues. These tests are to be done in a particular sequence and would require about five-seven days, it said, adding "sudden and unexplained weight loss, coupled with high ketone levels could be indicative of kidney damage, serious cardiac ailments and even cancer"

Early detection of these ailments is essential for preventing further progress of the disease and associated life risk and Kejriwal needed to undergo these tests, otherwise his life is at "high risk", it said. While setting him free for campaigning in the remaining phases of the Lok Sabha elections after 50 days of custody in the case, the court on May 10 had barred him from visiting his office or the Delhi secretariat, and signing official files unless absolutely necessary for obtaining the lieutenant governor's approval. While imposing a strong of bail conditions on Kejriwal, the apex court had directed him to furnish bail bonds of ₹ 50,000 with one surety of the like amount to the satisfaction of the jail superintendent. A bench of justices Sanjiv Khanna and Dipankar Datta had rejected the argument of the Enforcement Directorate (ED) counsel that enlarging Kejriwal on interim bail to campaign in the elections will be without a precedent.

Later on May 17, the top court reserved its verdict on the main plea of Kejriwal seeking to declare his arrest as illegal. The Delhi High Court, on March 21, had refused to grant him protection from arrest on his petition challenging summonses issued to him. The ED arrested Kejriwal shortly after that. The ED, on October 30, had sent first summons to Kejriwal in the money laundering case for appearance on November 2. Several summons were also issued subsequently. The matter relates to the alleged corruption and money laundering in the formulation and execution of the Delhi government's now-scrapped excise policy for 2021-22. (PTI)

Rupee falls 4 paise to close at 83.14 against US dollar

MUMBAI, May 27: The rupee pared its initial gains and settled for the day lower by 4 paise at 83.14 (provisional) against the US dollar on Monday, mirroring the benchmark indices that erased their gains and ended the day off their recordhigh levels. Forex traders said the rupee settled in a narrow range as the weakness of the American currency in the overseas market supported the rupee, while elevated crude oil prices in the international market restricted the upmove. At the interbank foreign exchange, the local unit opened at 83.08, then touched an intra-day high of 83.05 but soon pared the gains and settled for the day lower by 4 paise at 83.14 (provisional) against the American currency. On Friday, the rupee rallied for the fourth consecutive trading session and settled with a sharp gain of 19 paise at 83.10 against the US dollar.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading at 104.67, lower by 0.05 per cent. Brent crude futures, the global oil benchmark, advanced 0.47 per cent to USD 82.51 per barrel. "We expect the rupee to trade with a positive bias on positive domestic equities and expectations of fresh foreign inflows. However, a strong US dollar and a recovery in crude oil prices may cap sharp upside," Anuj Choudhary – Research Analyst at Sharekhan by BNP Paribas said. US markets will remain closed on Monday on Memorial Day holiday. Investors may remain cautious ahead of core PCE price index data later this week. USD-INR spot price is expected to trade in a range of ₹ 82.80 to ₹ 83.30, Choudhary added. On the domestic macroeconomic front, India's forex reserves jumped USD 4.549 billion to a new all-time high of USD 648.7 billion for the week ended May 17, the Reserve Bank said on Friday. This is the third consecutive week of increase in the overall kitty, which had increased by USD 2.561 billion to USD 644.151 billion in the previous reporting week ended May 17.(PTI) MUMBAI, May 27: Sensex scaled the 76,000 level for the first time while Nifty hit a new lifetime peak before closing marginally down on Monday as investors booked profits at record levels amid high volatility ahead of the results of Lok Sabha polls. The 30share BSE Sensex closed lower by 19.89 points or 0.03 per cent lower at 75,390.50. Intra-day, the barometer climbed 599.29 points or 0.79 per cent to an all-time peak of 76,009.68 following gains in select banking, financial and IT shares. However, investors preferred to book profits at record levels and the index declined around 835 points from the day's high to hit a

low of 75,175.27. Broader Nifty of the NSE declined by 24.65 points or 0.11 per cent, to end at 22,932.45. The 50issue barometer rose by 153.7 points or 0.66 per cent to hit a new lifetime high of 23,110.80 during the day. However, it tanked around 240 points at the fag-end due to selling in oil, energy and FMCG shares.

Index heavyweight Reliance Industries declined nearly 1 per cent, dragging the benchmark indices Retail Research, HDFC Securities. into the negative. Selling in FMCG giant ITC also eroded gains. Equity benchmarks were on a record-breaking rally for the third straight day ahead of the results of Lok Sabha polls and a rally in global markers. The results of the ongoing general elections will be declared on June 4.

Gold, silver prices rebound on strong global cues amid escalating tensions in Middle East

NEW DELHI, May 27: Gold and silver prices rebounded sharply on Monday after falling for three straight sessions, with the precious metal jumping ₹ 220 to ₹ 72,820 per 10 grams in the national capital, tracking a strong trend in the overseas market due to escalating tensions in the Middle East.

Gold had closed at ₹ 72,600 per 10 grams in the previous session on Friday, according to HDFC Securities. Silver prices also bounced ₹ 1,050 to ₹ 92,850 per kg. In the previous session, it had finished at ₹91,800 per kg.

'Spot gold prices (24 carats) in the Delhi markets are trading at ₹ 72,820 per 10 grams, up by ₹ 220 against the previous close," Saumil Gandhi, Senior Analyst, Commodities at HDFC Securities, said.

In the overseas markets, spot gold at Comex was trading at USD 2,344 per ounce, up USD 9 from the previous close.

Gold resumed trading on a positive note, supported by soft US



dollar, and geopolitical tensions in kets are closed on Monday. the Middle East increased after Israel carried out airstrikes in Rafah, leading to an increase in safehaven demand for the yellow metal, Gandhi said.

Additionally, silver also traded higher at USD 30.75 per ounce. "Gold prices are stuck in a range, as the US and the UK mar-

"However, volatility is expected to remain high as focus will be on inflation numbers from Germany, Eurozone, and the US due later in the week and could give some clues on the rate cuts by European Central Bank (ECB) and the US Federal Reserve," Pranav Mer, VP of Research (Commodity & Currency) at BlinkX and JM Financial Services, said.

Meanwhile, in the futures trade on the Multi Commodity Exchange (MCX), gold bounced ₹ 462 to trade at ₹ 71,718 per 10 grams. The most-traded June contract of gold hit an intra-day high of ₹ 71,741 per 10 grams.

Further, silver contracts for July delivery were also trading higher by ₹ 1,527, or 1.69 per cent, to ₹ 92,075 per kg on the exchange.

According to market experts, gold prices recovered some of the losses from last week, rising slightly to USD 2,346.60 in Asian trading on Monday.

Traders will also take more cues from the first reading of US GDP for the first quarter on Thursday and the Personal Consumption Expenditures (PCE) price index data, due on Friday which will further provide more direction on the precious metal prices, experts said.

The stronger-than-expected data might boost the greenback and weigh on the gold prices. (PTI)

Xi-Putin pact: A shift beyond Ukraine

he latest agreement between Xi Jinping and Vladimir Putin signals a significant shift in global geopolitics, aimed more at curbing US hegemony than resolving the Ukraine conflict. Contrary to the publicized intention of promoting a peaceful settlement in Ukraine, the pact lacks concrete steps or a timeline for resolution. Instead, it emphasizes strengthening China-Russia defence cooperation, poised to counter potential US-led NATO actions. Ukraine, ravaged by ongoing conflict, faces an uphill battle against Russia despite support from the US, UK, and other NATO allies. As the war drags on, the likelihood of Ukraine's surrender grows, especially without substantial on-ground military support. China's backing of Russia in the event of a direct NATO assault and Russia's support for China's ambitions in the Pacific, including Taiwan, highlights the broader strategic aims of the agreement. The biggest beneficiary of the Ukraine conflict thus far has been the US arms industry. Recently, the US Senate approved \$95 billion in aid, targeting Ukraine, Israel, and Taiwan. This aid package, predominantly allocated to Ukraine, underscores the US strategy of countering Russian and Chinese influences. As the US ramps up weapon supplies to Ukraine, the Xi-Putin alliance complicates the already volatile situation.

In their joint statement, Xi and Putin criticized the US for its Cold War mentality and bloc confrontation approach, accusing it of destabilizing global security. They condemned the seizure of foreign assets, directly referencing US-led initiatives to redirect profits from frozen Russian assets to aid Ukraine. The statement called for a political settlement of the Ukraine crisis, opposing prolonged conflict. However, achieving such a resolution requires negotiations, a step uncertain under current US policy. China's support is crucial for Russia as it intensifies its offensive in Ukraine. Xi's broader objectives include expanding China's trade and military influence, positioning Beijing as an equal partner to Moscow. China, now the top buyer of Russian oil and a major exporter to Russia, strengthens its economic ties amid the conflict. The new military alliance bolsters their combined military capabilities, presenting a formidable challenge to US dominance. For India, this Sino-Russian pact presents significant strategic concerns. India, a major importer of Russian defense equipment, faces increased complexity in its geopolitical landscape due to its border tensions with China. The burgeoning Beijing-Moscow military partnership disrupts India's strategic positioning, pushing it closer to Western al-liances. As a key member of the Shanghai Cooperation Organisation (SCO) and the Quadrilateral Security Dialogue (Quad), India must navigate these shifting dynamics carefully.

The Quad, comprising India, Australia, Japan, and the US focuses on Indo-Pacific security and cooperation. The Sino-Russian defense alliance forces India to balance its commitments between Eurasia and the Indo-Pacific, necessitating a recalibration of its diplomatic and strategic priorities. In essence, the Xi-Putin agreement is a calculated move to counter US influence globally. It strengthens their military partnership and aligns their strategic goals, particularly in response to US actions in Ukraine and Taiwan. For the US, this poses a significant challenge. India, caught in the crossfire of these geopolitical shifts, faces a delicate balancing act. Its longstanding ties with Russia, juxtaposed with growing tensions with China and partnerships in the Quad, require a nuanced approach to maintain its strategic autonomy and regional stability. The Xi-Putin pact underscores a new era of geopolitical realignments, with China and Russia presenting a united front against US hegemony.

Rohingya's repression continues unabated in Myanmar

The UN High Commissioner for Human Rights has reported of receiving frightening and disturbing reports from northern Rakhine state in Myanmar of the impacts of the conflict on civilian lives and property

Liz Throssell, spokesperson for the UN High Commissioner for Human Rights, said on Friday 24 May in a briefing to journalists in Geneva, that "Some of the most serious allegations concern incidents of killing of Rohingya civilians and the burning of their property, has been received by the UN", notingthat tens of thousands of civilians have been displaced in recent days by fighting in Buthidaung and Maungdaw townships. She said that the information gathered in testimony from victims, eyewitnesses, satellite images, and online video and pictures over the last week indicate, "Buthidaung town has been largely burned.'

"We have received information indicating that the burning started on May 17, two days after the military had retreated from the town and the Arakan Army claimed to have taken full control," she said. Speaking in Bangkok, James

Rodehaver, head of Myanmar Team, Office of the High Commissioner for Human Rights, said his team had spoken to many sources on the ground and reviewed numerous materials, many of which "were deemed to be credible."

"Our offices are corroborating information further, particularly in establishing who were the perpetrators of the burning. One survivor described seeing dozens of Latest reports from Myanmar, speak of new atrocities and crimes being committed in a concerted campaign of violence and destruction by Myanmar's military against the largely Muslim Rohingya people in northern Rakhine state


dead bodies as he fled the town. Another survivor said that he was among a group of displaced persons numbering in the tens of thousands, who attempted to move outside of the town to safety but were blocked by the Arakan Army,'

Rodehaver said, pointing Asad Mirza out that the Arakan Army

had abused survivors and extorted money from them as they fled the town.

Earlier history The latest fighting comes in the context of a civil war in Myanmar that began after the army ousted the elected government of Aung San Suu Kyi, leading to an armed resistance opposing military rule. The pro-democracy fighters are allied with several of the ethnic minority groups that have been fighting for greater autonomy for decades, and have well-trained military forces.

The Arakan Army is an armed ethnic group fighting as part of an alliance against the Myanmar military. The AA says it is fighting for more autonomy for the ethnic Rakhine population in the state, which is also home to an esti-

Myanmar. The Rohingya were the targets

of a brutal counterinsurgency campaign incorporating rape and murder that saw an estimated 740,000 flee to neighbouring Bangladesh as their villages were burned down by government troops in 2017.

Rohingya have lived in Myanmar for generations, but they are widely regarded by many in the country's Buddhist majority, including members of the Rakhine minority, as having illegally migrated from Bangladesh. The Rohingya face a great amount of prejudice and are generally denied citizenship and other basic rights.

Latest incidents

In the weeks leading up to the burning of Buthidaung, the Myanmar team of the UN human

rights offices has documented renewed attacks on Rohingya civilians by both the Arakan Army and by the military in northern Rakhine state, including many by aerial strikes and drones.

He said his office also has received reports of shooting at unarmed fleeing villagers, multiple disappearances and burnings of homes, and has confirmed four cases of beheadings

Rodehaver said the military has been actively targeting the Rohingya for years and has "actively enforced draconian and discriminatory restrictions affecting all aspects of their lives."

'It is one of the reasons why the Rohingya, whenever they were asked to leave Buthidaung ethnic and other villages, have been very reluctant to move because they have needed special permission to move outside of their township of residence. They also have

nowhere else to go. "They, of course, have learned very hard lessons in 2017, knowing that whenever movement starts, it usually ends with them leaving their homes, never to see them again," he said.

The Myanmar junta, which has been at war with its people for decades, recently has suffered many defeats. One consequence is young men have been conscripted from the Rohingya to fight its battles, by promising them many benefits, such as more food rations for their families and a promise of citizenship. Rodehaver calls that an insidious ploy by military leaders. Tom Andrews, the UN special

rapporteur on the human rights situation in Myanmar, warned Thursday of "ominous signs of another Rohingya bloodbath in Rakhine state" if the international community were to continue to turn a blind eye and fail to take action to save the lives of thousands of Rohingya.

"Once again, the world seems to be failing a desperate people in their hour of peril, while a hatedriven unnatural disaster unfolds in real time in Myanmar's Rakhine state," he said.

Mirroring that assessment, UN human rights chief Volker Turk is calling for "an immediate end to the violence, and for all civilians to be protected without any distinction based on identity. "Prompt and unhindered humanitarian relief must be allowed to flow, and all parties must comply fully and unconditionally with international law," he said.

More than a million Rohingva have taken shelter in neighbouring Bangladesh after fleeing Rakhine, including hundreds of thousands in 2017 during an earlier crackdown by the military that is now the subject of a United Nations genocide court case.

What perplexes one here is the ominous silence of the so-called Muslim states against the Myanmar's junta, for targeting the Rohingyas

Even the Muslim organisations like the OIC have not moved bevond passing resolutions against the massacre of Rohingyas, and have refrained from taking any firm action at the ground level to force the junta to put a stop to these inhuman massacres. vou see". This is one side. This was how T N Seshan, arguably, the Chief Election Commissioner who made the Election Commission of India an admired institution, used to describe himself. Then he would add "whilst I sit on this chair I have a job to do and I'll do it to the best of my ability. Wild horses can't stop me". No wonder he was fondly called "Bulldog Seshan". It was a moniker he revelled in.

Alas, the Commission of today behaves like a very different animal. It is more obedient to the centre than a watchdog. if vou want to extend the analogy. It seems to have forgotten the need for fairness and transparency. It is no longer determined to do its job even in the teeth of fierce resistance. Instead it seeks the easy way out.

A month has lapsed since Prime Minister Narendra Modi's Banswara speech-in fact, in seven days from now voting will be concluded - but the commission has barely acted in response to a accusation of the PM blatantly breaching the model code as well as Representation of people Act.. ICC's decision on arrest warrant against Netanyahu exposes double standard of West

The International Criminal Court (ICC) and its chief prosecutor Karim Khan, a Pakistani-British member of Ahmadiyya community, with deep-rooted connections with Buckingham Palace and UK's intelligence establishments are hitting headlines in international media in the recent days. Criticizing ICC, in a recent statement on his 'X' handle. John Bolton. the former National Security Advisor to President Donald Trump, expressed his anger and strong criticism at ICC for its attempts of issuing an arrest warrant against Israeli Prime Minister Benjamin Netanyahu and members of Hamas.

Ambassador Bolton denounced the ICC's actions as 'illegitimate', particularly in the context of an ongoing war. He urged the United States to take decisive measures, both through Congress and the White House, to condemn the ICC and impose sanctions in support of Israel.

President Joe Biden echoed Bolton's sentiments, labelling the ICC's attempt to arrest Netanyahu as 'outrageous'. A group of Republican senators, led by Senator Tom Cotton, also voiced their disapproval, warning ICC chief prosecutor Karim Khan against pursuing arrest warrants for Israeli officials in connection with the Gaza conflict. These statements and actions highlight a clear pattern of support for Israel while simultaneously questioning the legitimacy and motivations of the ICC.

While some people may agree with Bolton, it is hard to overlook the apparent double standards at play. When the ICC issued an arrest warrant against Russian President Vladimir Putin, there was widespread celebration among US policymakers and their European allies. Putin was

accused of crimes related to his actions in Ukraine, which were seen as efforts to protect Russian sovereignty. Yet, these same leaders are now condemning the ICC for targeting Netanyahu. This inconsistency in reactions raises significant questions about the principles and motivations guiding these leaders.

The hypocrisy becomes even more apparent when considering the actions of various American presidents. The United States has a long history of military interventions in countries like Libya and Iraq, often resulting in significant human rights violations. Despite these actions, the ICC has largely remained silent. This silence raises questions about the ICC's impartiality and the true motivations behind its actions. Is the ICC selectively targeting certain leaders while ignoring the transgressions of others, especially those from powerful nations like the United States? The current push to issue warrants against Netanyahu and leaders of Hamas originates from Karim Khan, the ICC's chief prosecutor. Khan, a Pakistani-born British lawyer and member of the Ahmadiyya community, has faced accusations of bias. Some view him as an anti-Semite, while others in Israel saw his election as a positive development, considering him pragmatic." However, pro-Palestinian media have accused him of favouring Israel and actively seeking to convict Hamas. This mixed perception of Khan further complicates the narrative and highlights the complex dynamics at play within the ICC.

The ICC itself has a troubled history, marred by scandals and controversies. In 2015, a significant scandal involving the court came to light. An investigation by the European Investigative Collaboration

(EIC) revealed questionable practices and the dubious morality of Luis Moreno Ocampo, the ICC's first prosecutor. These findings severely undermined the ICC's credibility and highlighted the political games that often surround international justice. The former chief prosecutor of ICC, Fatou Bensouda, also faced controversy. She has been mired in scandal. Accusations against ICC judges have further damaged the court's reputation, with reports highlighting issues with their morality, integrity, and independence. These controversies have cast a long shadow over the ICC's ability to function as a fair and impartial institution

In September 2020, the US government took a decisive step by imposing sanctions on Bensouda and another senior ICC official, Phakiso Mochochoko. Secretary of State Mike Pompeo announced visa restrictions for individuals involved in the ICC's efforts to investigate US personnel. This move sent a clear message of the US's disapproval of the ICC's actions and highlighted the tension between the court and powerful nations.German broadcaster Deutsche Welle has described Karim Khan as a controversial figure. The Russian Foreign Ministry has also criticized the ICC, arguing that its actions violate international law. According to the ministry, the ICC's issuance of warrants against officials from non-party states to the Rome Statute, like Russia, is unlawful. This criticism underscores the complex legal and political challenges the ICC faces in executing its mandate. The Russian Foreign Ministry further stated that the ICC has deviated from its original objectives and principles of international law. This deviation, along with procedural shortcomings and political factors, has led to a loss of legitimacy and

authority in the eyes of many in the international community.

The totality of violations of international law committed by the ICC and its Prosecutor suggests a persistent and probably irreversible loss of credibility.

In another development, the US Department of State recently designated former Bangladeshi army official General Aziz Ahmed for "significant corruption". The designation cited Ahmed's interference in public processes and involvement in helping his brother evade accountability for criminal activity in Bangladesh. Ahmed was also accused of accepting bribes and improperly awarding military contracts for personal gain. This designation has further complicated the narrative of international justice and the role of powerful nations in shaping it.An Al Jazeera journalist claimed on Facebook post that this US action was a result of an investigative report by the network. The report alleged that Bangladesh had purchased Israeli spyware, although it provided no credible evidence of corruption or money laundering by General Ahmed. Bangladesh authorities have denied purchasing surveillance equipment from Israel, raising further questions about the validity of Al Jazeera's claims.

The US sanctions against Genera Aziz Ahmed raises significant questions. If the sanctions are related to the purchase of Israeli surveillance equipment, why would the US, an ally of Israel, impose such measures? If not, why is Al Jazeera linking the sanctions to its investigative report? Al Jazeera's hostility towards Israel and its allies is well-known, and its claims seem misleading and unfounded. This situation highlights the complex interplay of media, international politics, and justice. (IPA Service)

Family member in distress or an AI voice clone? The rise of a disturbing new cyber crime scam

rinda, a resident of Noida, was jolted by a frantic afternoon call from her son, or so it appeared. The voice, trembling with urgency, pleaded for a swift transfer of ₹ 60,000 through the Unified Payments Interface, or UPI, claiming he was under threat and urgently needed money.

The urgency in the voice and a distant command in the background painted a vivid picture of the crisis. Yet, something felt amiss when the voice called her "mummy" instead of the usual "mom". Her concern deepened when she heard what sounded like her sobbing child on the phone, making the situation seem alarmingly real.

Driven by fear, she transferred the money, only to discover later that it was indeed a scam. Her son was never on the phone; their voice had been convincingly cloned using sophisticated software.

In recent weeks, the Delhi-National Capital Region has seen a rise in such cases of voice cloning fraud, highlighting a disturbing trend in cybercrime.

AI voice clone scams

The use of Artificial Intelligence to clone voices for scams is increasing, with cybercriminals in India leveraging this technology for extortion. In Delhi alone, cybercrime cases surged to 685 in 2022, up from 345 in 2021 and 166 in 2020, according to data from the National Crime Records Bureau.

Many Indians are found to be particularly susceptible to scams of this nature, with a McAfee survey revealing that 66% of respondents from India would likely react to voice or phone calls seeking urgent financial help, particularly if the caller seemed to be a close relative like a parent (46%), spouse (34%), or child (12%). The survey highlighted that the

most convincing pretexts used by scammers included being robbed (70%), involved in a car crash (69%), losing a phone or wallet (65%), or requiring funds during overseas travel (62%). The report also highlighted that 86% of Indians tend to share their voice data online or through voice messages at least once a week, enhancing the effectiveness of these tools.

This new wave of cybercrimes causes both psychological and financial damage. According to a Future Crime Research Foundation report, online financial fraud accounted for a staggering 77.41% of all cybercrime cases reported from January 2020 to June 2023.


A study highlighted that nearly 50% of the cybercrime cases reported were linked to UPI and internet banking, indicating the high vulnerability of these digital transaction methods to fraudulent activities.

Explaining the deceptive strategies employed by scammers, Prateek Waghre, Executive Director at the Internet Freedom Foundation, said, "Although these cloning tools have their limitations, scammers compensate by instilling a sense of urgency to overshadow these imperfections.

To a large extent, the entire cybercrime scene hasn't been well mapped out in India. Voice cloning scams can target individuals in new ways, not just as an unknown third party pretending to be a government agent. For example, now, individuals might receive calls from voices resembling those of their parents, bosses, children, or friends, asking for money or information. This complexity makes detection particularly challenging.

How are voice clones made?

Voice cloning technology has advanced to the point where it only needs a few seconds of someone's voice to accurately replicate it. According to McAfee, even those with minimal experience can use this tech-



nology to create a voice clone that matches the original voice with about 85% accuracy.

Romit Barua, Machine Learning Engineer and Researcher from UC Berkeley explains that voice cloning involves leveraging advancements in audio signal processing and neural network technologies to replicate a person's voice.

There are two particularly relevant forms of voice cloning, Text-To-Speech (TTS) and Voice Conversion. Text-To-Speech is a technology that converts written text into spoken words using synthetic voice. Voice conversion, on the other hand, changes the characteristics of a voice in existing audio to sound like another person while preserving the original speech content.

'Voice cloning involves using technology to analyse a short recording of someone's voice and then using that analysis to generate new speech that sounds like the original speaker. This process leverages computer algorithms to capture the unique characteristics of the voice, such as tone, pitch, and rhythm.

Once the system understands these elements, it can replicate them to create new speech content, making it sound as though the original person is saying something entirely new. It's

akin to creating a digital voice twin that can speak on behalf of the original person", explained Barua.

Once a scammer finds an audio clip of an individual, they can simply use an online service capable of mimicking that voice with high accuracy, though some nuances may be missed. Many such platforms exist, including Murf, Resemble, and Speechify, which typically offer subscriptions

ranging from \$15 for basic access to \$100 for advanced features, along with a trial period at no cost. **Common patterns and tactics**

Family Member in Crisis Scam: One prevalent use of voice cloning in scams is to trick people into believing that someone close to them is in immediate danger or distress, urgently needing financial assistance. By mimicking the voice of someone close to the victim, scammers create believable scenarios of emergencies like accidents or legal issues. The emotional turmoil and supposed urgency impair the victim's clarity of thought. This often prompts hasty actions without verifying the situation's authenticity. Kidnapping Scams: Voice cloning

technology has given a new edge to kidnapping scams, allowing criminals to mimic the voice of a supposed hostage, often a family member, to extort money or coerce victims into re-

vealing sensitive information. The convincing nature of the cloned voice can instil enough fear and urgency to make people comply with the scammer's demands, thus fueling such fraudulent schemes.

'The scenarios we've seen reported share common elements with traditional scams, such as urgent demands that put the recipient in a difficult situation. The key difference now lies in the delivery method," Waghre noted.

Waghre continued, highlighting another critical aspect, "A significant concern is how scammers obtain detailed personal information, such as the victim's relationships and the voices of their close contacts. In some cases, the voice may not be clear, sounding close enough to be convincing, while in others, victims report the voice sounding exactly like their relative or friend, raising questions about how scammers access such detailed personal information to create these convincing voice clones.

Adding to this concern, Waghre also shed light on a broader issue within the digital landscape - cybersecurity attacks that exploit human psychology, known as social engineering. These attacks are particularly insidious because they manipulate individuals into voluntarily surrendering confidential data.

"Scammers are becoming adept at understanding human behaviour and leveraging emotional triggers such as fear, urgency, or empathy to deceive their targets into sharing personal or financial information," he explained.

This method of exploitation underscores the importance of not just technological safeguards, but also heightened awareness and education about these psychological tactics among internet users. By staying informed about the common signs of such manipulative strategies, people can better protect themselves from inadvertently becoming victims of cyber fraud.

Protective strategies

Verification is the key: When faced with unexpected requests, particularly those involving urgent financial transactions or sensitive information, it's crucial to verify the authenticity of the communication through another channel. "For example, if the caller appears to be your father, consider calling him back on his known number to confirm. While this may seem straightforward in theory, it can be admittedly challenging in practice, particularly during high-pressure situations where scammers manipulate emotions. You may not immediately think to request the caller to hang up while you verify their identity," suggested Waghre.

Hence, another crucial point arises. Stay calm and content: "Scammers often rely on inducing panic and emotional distress to cloud judgment and prompt immediate action," explains Barua. If you receive a call claiming a loved one is in crisis, try to remain calm and composed. Take a moment to gather pertinent details, pose probing inquiries, and firmly request alternate methods of verifying the caller's identity

Enable the caller ID: Make sure to activate the caller ID feature on your smartphone at all times. This feature provides notifications about incoming calls, including the caller's identity and location. Moreover, it can also distinguish between calls from telemarketers and potential scams.

Establish code words: Another recommendation from Waghre is to create code words within your family. These unique phrases can be used to verify the caller's identity, providing additional security against scams. 'While these measures might seem like something out of a spy film, they are among the few strategies individuals have to counter such sophisticated scams, recognising the difficulty of dealing with them at the individual level," emphasises Waghre. stronomers have discovered a potentially habitable exoplanet about 40 light-years away from Earth one of the closest ones so far. The exciting discovery of Gliese 12 b was detailed in a new study published in journal Monthly Notices of the Royal Astronomical Society.

According to the study, the exoplanet's average surface temperature is 42 degrees Celsius, which is lower than the majority of the 5,000 or so exoplanets discovered thus far. Its size is comparable to Venus and is slightly smaller than Earth.

Gliese 12 b. however, is warmer than the Earth's average surface temperature of 15°C. Still, the researchers argue for more investigation of the exoplanet, including its atmosphere, which is essential for habitable conditions.

"We have found the nearest, transiting, temperate, Earth-size world located to date," said Masayuki Kuzuhara, a project assistant professor at the Astrobiology Center in Tokyo, who co-led a research team with Akihiko Fukui, a project assistant professor at the University of Tokyo, said in a statement.

"Investigating Earth-sized planets is important as we continue forwards to try and infer the number of true-Earth analogues, to cement how we understand our own place in the Universe," Larissa Palethorpe, a PhD student from the University of Edinburgh, told Down To Earth.

National Aeronautics and Administration's Space (NASA) Transiting Exoplanet Survey Satellite (TESS) had earlier identified Gliese 12 b as a possible planet candidate.

The team used observations from TESS and the European Space Agency's CHaracterising ExOPlanet Satellite CHEOPS to validate Gliese 12

The scientists discovered that Gliese 12 b orbits Gliese 12, a M dwarf star (a type of lowmass star), every 12.8 days.

roughly the size of Earth and are most likely rocky.

Of these planets, three fall within the habitable zone. The habitable zone is the distance from a star at which liquid water can exist on the surfaces of planets orbiting it.

Furthermore, the star is metal-poor, which suggests that it may have weaker magnetic fields and more volcanism than Earth. Because the host star has low magnetic activity, the researchers believe that Gliese 12 b may have an atmosphere.

There's a possibility the exoplanet could have an atmosphere similar to Earth, but it could be a different type too, according to the team.

Further analysis could also reveal if Gliese 12 b is habitable. "We tend to define habitability in terms of liquid water, rather than where humanity would be able to maintain life. So while this temperature would be a bit on the hot side for humans to live comfortably. it doesn't necessarily mean other forms of life wouldn't be able to thrive in these conditions," Palethorpe explained.

It could also shed light on the evolution of Earth and Venus and why they appear so differ-

Earth retained its water, whereas Venus' runaway greenhouse effect caused it to escape. Researchers might be able to spot signatures of whether the exoplanet is witnessing a runaway greenhouse effect. If they find no water in the future, it could indicate that such a process has already occurred, like on Venus.

Gliese 12 b, according to the paper, is a potential target for NASA's James Webb Space Telescope (JWST) as it can detect atmospheric features of planets.

The team hasn't currently submitted a JWST proposal for this target yet. For now, they are trying to calculate its mass, bulk density, and radius estimates to understand the exoplanet's internal structure. (Courtesy: Down To Earth)

Middle class people are neither 'poor' nor 'rich' but have 'good' jobs

Notwithstanding the inequalities in income-wealth accumulation that persist (and continue) to grow across households and groups in India, still, from the Banerjee-Duflo study, it seems clear that the middle class pursues what

is conventionally known as a better "quality of life" (they are not poor and realise their limits to not being—or capable of being—rich either); with better health care for the family and more expensive education for the children, as well as more and better housing, more expensive eatables,

and more entertainment, tobacco, and alcohol. Despite the middle class's reputation for thrift, some "frivolous" consumption is as middle class as a commitment to education or health care. No wonder Bajpayee's refined

tastes-in food, entertainment, and champagne-can last while he can safely relate to a perceived 'middle class' category lifestyle.

The middle class also lives distinctly healthier lives than the poor. In Duflo-Banerjee's study, the so-called categorised 'middle class' population goes to the doctor more often and spends more per visit. They are also much more likely to have access to running water, latrines, and electricity. As far as children's education is concerned, they spend much more per child, partly on more years of schooling and partly on better quality.

They also argue: "Nothing seems more mid-

The middle class (as observable in urban areas) also have fewer children and spends much more on the education and health of these children as well as on their own health. It is interesting to speculate whether this has something to do with the kind of jobs they have—or if there is a time endowment crisis they face.

Perhaps the sense of control over the future that one gets from knowing that there will be an income coming in every month, and not just the income itself, is what allows the middle class to focus on building their own careers and those of their children.

The reason why this matters is indeed close to what leads us to the idea of a "good job"—an argument this author also expanded on here (in a discussion on Rodrik's productivism framework to India's jobless growth problem).

A good job for an aspiring middle class citizen is a steady, well-paid job; a job that allows one the mental space needed to do all those things the middle class does well.

This is an idea that many development economists have often resisted on the grounds that good jobs may be expensive jobs, and expensive jobs might mean fewer jobs. But if good jobs mean that children grow up in an environment where they can make the most of their talents, one might start to think that it may all be worth it.

Unfortunately, a vanishing middle class in India (with increasing lower-income and higher-income groups) is similarly evident in the deep regression-decline of 'good' jobs available across sectors, underscoring the rise of unemployment-underemployment, especially amongst the aspiring, educated youth (who otherwise remain the root source of a developing nation's 'future' growing middle class).

Incumbent Lithuanian president reelected in landslide win over PM

COPENHAGEN, May 27: Lithuanian President Gitanas Nauseda secured a second five-year term as Lithuanian president in a landslide victory over Prime Minister Ingrida Šimonyte.

Preliminary figures by the Lithuania's Central Electoral Commission showed that Nauseda won 74.5 per cent of the votes and Šimonyte 24.1 per cent.

The 60-year-old Nauseda is a moderate conservative and has been a strong backer of Ukraine, a position shared across most of the political spectrum.

During his time in office, Lithuania has also given refuge to many who have fled an authoritarian crackdown in neighbouring Belarus and increased repression in Russia.

"Lithuania's independence and freedom is like a fragile vessel that we must cherish, protect and prevent from cracking,' Nauseda said Sunday night after the ballots had been counted, the Baltic News Service reported.

Speaking of the Baltic country's allies, the United States, Germany, Poland, among others, he added that, "We have a very similar position on fundamental issues, like support for Ukraine, the attitude towards the Russian threat.'

Nauseda, a former banker, entered politics with his successful presidential run in 2019. He and Simonyte won the first round but failed to muster the 50 per cent of the votes needed to win the presidency outright. The election came at a time as Russian

US lawmakers pledge support for Taiwan and its new president after China's military drills

TAIPEI, May 27: A US congressional delegation met Taiwan's new leader on Monday in a show of support days after China held drills around the self-governing island in response to his inauguration.

Rep. Andy Barr, the co-chair of the Taiwan caucus in the US Congress, said the United States is fully committed to supporting Taiwan militarily, diplomatically and economically.

'There should be no doubt, there should be no scepticism in the United States, Taiwan or anywhere in the world, of American resolve to maintain the status quo and peace in the Taiwan Strait," the Republican from Kentucky said at a news conference in the capital, Taipei, after the delegation met Taiwan President Lai Ching-te.

China regards Taiwan as a renegade province that must come under its control, by force if necessary. The US, like most countries, does not have formal diplomatic ties with Taiwan but is bound by its own laws to provide the island with the means to defend itself.

The Chinese government expressed strong



opposition to the congressional visit, saying it undermined China-US relations and peace and stability in the Taiwan Strait, referring to the waterway between China and Taiwan.

The lawmakers' visit "ran against the political commitment of the US government to maintain only unofficial relations with Taiwan, sending a seriously wrong signal to the separatist force of Taiwan independence," Foreign Ministry Spokesperson Mao Ning said in Beijing.

Lai, who took office one week ago, is expected to continue the policies of Tsai Ing-wen, his predecessor from the same Democratic Progressive Party. The new foreign minister, Lin Chia-lung, noted the recent Chinese drills and called the American delegation's visit "an important gesture of solidarity" at a critical time. The delegation included four Republicans and two Democrats and was led by Rep. Michael McCaul, the chair of the House Foreign Affairs Committee. Last year, China sanctioned the Texas Republican after he visited Taiwan in April

"America is and always will be a reliable partner, and no amount of coercion or intimidation will slow down or stop the routine visits by the Congress to Taiwan," he said.

McCaul cited congressional approval last month of a military aid bill for Ukraine, Israel and Taiwan. China firmly opposes the US arming Taiwan, Mao said.

The other delegation members were Republicans Young Kim from California and Joe Wilson from South Carolina and Democrats Jimmy Panetta from California and Chrissy Houlahan from Pennsylvania. (AP)

North Korea plans to launch a rocket soon,

COLOMBO, May 27: Sri Lankan President Ranil Wickremesinghe will certainly contest the presidential poll to seek reelection and will announce his candidacy in the next two weeks. a senior government minister said on Monday.

Harin Fernando, the Tourism minister and a close ally of Wickremesinghe, said. "I can say with certainty that the President will contest." The island nation's Elections Commission earlier this month said the presidential election would be conducted between September 17 and October 16.

The ruling Sri Lanka People's Front, commonly known by its Sinhalese name Sri Lanka Podujana Peramuna (SLPP), which has the current parliamentary majority, had pressed Wickremesinghe to hold the parliamentary election ahead of the presidential poll.

Wickremesinghe, 75, is vet to announce his candidacy despite declarations by two other main opposition leaders: Sajith Premadasa the main opposition leader, and the Marxist JVP leader Anura Kumara Dissanayake.

Fernando said Wickremesinghe would announce his candidature within the next two weeks.

Wickremesinghe, from the arch-rival party United National Party (UNP), succeeded SLPP-elected president Gotabaya Rajapaksa to become president for the rest of Rajapaksa's term when the latter was ousted, after the island nation declared first international default, during street protests which lasted between April and July of 2022. Rajapaksa gave in to calls for his resignation due to his inability to handle the unprecedented economic crisis.

Some of the SLPP members have turned into Wickremesinghe supporters while the party also saw other members split as well to form other political entities. (PTI)

Bangladesh PM Hasina reiterates commitment to execute verdicts against arch-rival Khalida Zia's son likely carrying its second military spy satellite

DHAKA, May 27: Bangladesh Prime Minister Sheikh Hasina has reiterated her government's firm determination to bring back her arch-rival Khaleda Zia's son Tarique Rahman from London and execute the court verdict against him.

Rahman, the Bangladesh Nationalist Party (BNP) President who has helmed the largest opposition party since the 2018 jailing of his mother, two-time Prime Minister Khaleda Zia, has been in London since his conviction six years ago in absentia. The court ruled that he masterminded a deadly grenade attack on a campaign rally attended by Hasina and was sentenced to life imprisonment. Rahman, 56, insists the charge is politically fabricated.

"Those who will carry out arson attacks and burn people must not be spared. Whichever the big brother they maintain and whatever they do, we will not spare them, it's

clear. Our actions will continue against those who will cause damage to people," Hasina, 76, said.

SEOUL, May 27: North Korea announced plans to launch a rocket apparently carrying its second military spy satellite during an eight-day period starting Monday, drawing quick, strong rebukes from neighbours South Korea and Japan.

The notification of the planned launch, banned under UN resolutions, came as South Korean President Yoon Suk Yeol and Japanese Prime Minister Fumio Kishida met Chinese Premier Li Qiang in Seoul for their first trilateral meeting in more than four years.

Japan's coast guard said it was notified by North Korea about its planned launch of a "satellite rocket", with a warning of caution in the waters between the Korean Peninsula and China and east of the main Philippine island of Luzon beginning Monday through midnight June 3.

North Korea provides Japan with its launch information because Japan's coast guard coordinates and distributes maritime safety information in East Asia. North Korea's planned launch is thought to be an attempt to put its second military spy satellite into orbit. South Korea's military said Friday it detected signs of suspected preparations to launch a spy satellite at North Korea's main Tongchangri launch facility in the northwest

The UN bans North Korea from conducting any satellite launches, viewing them as covers for testing long-range missile technology. North Korea has steadfastly maintained it has the right to launch satellites and test missiles. It says spy satellites will allow it to better monitor the US and South Korea's moves and enhance the precision strike capability of its nuclear-ca-



pable missiles.

"Any launch (by North Korea) using ballistic missile technology would directly violate UN Security Council resolutions and undermine peace and security of the region and the world." Yoon said at the start of the meeting with Kishida and Li. "If North Korea presses ahead with its launch despite the international warning, I think the international community must sternly deal with it." Kishida said he strongly urges North Korea to cancel the launch. China is a North Korean ally, and Li didn't mention the North Korean satellite. In phone talks earlier Monday, senior diplomats from Japan, South Korea and the United States agreed to call on North Korea to abandon the launch. South Korea's Unification Ministry, which deals with North Korea, separately called a satellite launch by the North "a provocation that seriously threatens our and regional security"

Later Monday, South Korea mobilised 20 fighter jets for a drill meant to demonstrate its resolve to punish North Korea in the event of provocation, according to South Korea's military. Japanese officials said their missile interceptors remain ready to shoot down any debris from a North Korean rocket if it falls on Japanese territory. (AP)

Cyclone Remal: Tripura sounds red alert in two districts

AGARTALA, May 27: The India Meteorological Department (IMD) has issued a red alert in two districts - Sepahijala and Gumati - in view of the possible impact of cyclone Remal, an official said on Monday.

An orange alert has also been sounded in the remaining six districts of the northeastern state which is likely to witness heavy rain and gusty winds as a result of the cyclone.

"A red alert has been sounded in Sepahijala and Gumati districts in anticipation of heavy to very heavy rainfall during the day while an orange alert has been sounded in the remaining six districts of the state", Director of Indian Meteorological department, Agartala, Partha Roy told PTI.

Meanwhile, heavy rain lashed Tripura on Monday under the influence of cyclonic storm Remal while 11 flights were cancelled from Agartala airport due to bad weather, officials said.

"Tripura received average rainfall of 40.73 mm on Monday with West Tripura district recording the highest of 59.50 mm. There is no

report of any substantial damage or loss of life from any district except uprooting of trees and block-ade of roads," said an official of the Revenue department.

"Altogether 11 flights to and from MBB Airport here have been cancelled on Monday due to cyclone Remal. One Agartala-Delhi flight was diverted to Guwahati airport because the wind speed was more than the normal range," MBB airport director K C Meena told PTI.

"The Northeast Frontier Railways had cancelled a few trains for Monday and Tuesday on account of the cyclonic storm, but today it restored all its service taking into account of overall improvement in the situation," said a

Transport department official. Chief minister Manik Saha urged people to remain vigilant. "The state may witness moderate to heavy rainfall due to the cyclonic storm. The state and the district administrations are ready

to tackle the situation. I appeal to the people to remain in the highest degree of alertness during the period," the CM said in a Facebook

"Rainfall was reported from various parts of the state. We are ready to meet any eventuality," an official of the state Disaster Management Authority said.

Earlier, South, Dhalai, Khowai, and West districts had been brought under 'red alert' (implying 'take action') but now they are under 'orange alert' ('be prepared for action').

"Thunderstorm is very likely to occur over six districts due to the cyclone. Light to moderate rain and thunderstorm with lightning accompanied by gusty wind speed reaching 30-40 kmph is very likely to occur at many places over South, Gumati, Sepahijala, Dhalai and Khowai districts," Roy said.

The northeastern state is unlikely to be severely affected by the cyclonic storm as it made landfall in coastal areas of West Bengal and Bangladesh which is far away, he said. (PTI)



SHILLONG, May 27: The Hynniewtrep Youth Council (HYC) has requested the intervention of the Meghalaya director general of police (DGP), Idashisha Nongrang into the problem of drug menace in the state. Submitting a memorandum to

Nongrang on Monday, HYC president Roy Kupar Synrem said the state police department should strengthen the drug supply reduction strategy.

"We would like to suggest that the police department should adopt a proper and more stringent strategy to reduce the supply of drugs in the state. We would also like to suggest that the state police, the Border Security Force and the custom and central excise should conduct joint operations and share information on drugs by pooling in resources to effectively tackle the menace of drugs in the state as frequently as possible. They should also rope in the village authorities in this effort. Regular checking should be conducted more frequently at the entry points of the state," he said.

Synrem said that the Narcotic Drugs and Psychotropic Substances Act, 1985, provides for stringent provisions for offences related to drugs abuse and trafficking. Despite the fact that major offences under the Act are non-bailable, it has been observed that in several cases the drug offenders secure acquittal on technical grounds. A large number of offenders in such cases are acquitted due to non-compliance of mandatory provisions and the prescribed procedure.

"The acquittals in serious offences particularly in NDPS cases create a sense of insecurity in the society and undermine the faith of the common man in the administration of the

criminal justice system. Hence, it is incumbent upon the investigating agencies/prosecutors to be wellversed in the compliances of mandatory provisions and the prescribed procedures and to discharge their assigned duties in a professional manner in order to achieve the desired objective of the law," he said adding, "Therefore, to accomplish the purpose and objective of the Act and to ensure conviction of offenders in NDPS cases, the enforcement agencies of the state are expected to know and adhere to the provisions of the Act during investigation and also ensure vigorous follow up during the

prosecution stage." Also emphasizing the need to create awareness on the provision of receiving stolen property, the HYC president said, "Section 317 of The Bharatiya Nyaya Sanhita, 2023 (Repealing the Indian Penal Code. 1860), which shall come into force on July 1, 2024 provides for the provisions relating 'receiving or retaining' any stolen property.

During our interactions with the 'drug users' as well as their family members, we have come across many cases where the users in order to get money for buying drugs are forced to commit theft even from their homes or family members. These stolen properties are then sold at take away prices to some persons.

"So in order to create awareness about this particular provision of law and to create a deterrent effect so as selling and buying of stolen properties, especially by drugs users, are not easy. NEW DELHI, May 27: The Congress on Monday paid rich tributes to India's first prime minister Jawaharlal Nehru on his death anniversary with party chief Mallikarjun Kharge saying the country's history is incomplete without the incomparable contribution of "the architect of modern India".

Kharge and former Congress president Sonia Gandhi also paid floral tributes to the former prime minister at his memorial 'Shantivan' here.

In a post in Hindi on X, Kharge said the history of India is incomplete without the incomparable contribution of Pandit Jawaharlal Nehru, the architect of modern India, who took India forward in scientific, economic, industrial and various fields.

Nehru was a dedicated guardian of democracy and our source of inspiration, he said.

"Our humble tribute to "Hind ke Jawahar" on his death anniversary," Kharge said.

The Congress president quoted Nehru as saying that the protection of the country, progress of the country, and unity of the country is the national religion of all of us. "We may follow different reli-

INDIA govt to scrap Agnipath scheme, send ₹8,500 to women's accounts each month: Rahul

BAKHTIYARPUR/PALIGANJ (BIHAR), May 27: Congress leader Rahul Gandhi on Monday claimed that the INDIA bloc, if voted to power, would scrap the Agnipath scheme of recruitment in defence services and deposit ₹ 8,500 to every woman's account in each month

Addressing back-to-back election rallies in favour of Mahagathbandhan nominees in Bihar, he asserted that Narendra Modi will not be able to become the prime minister again, since there is a clear wave in favour of the INDIA bloc across the country.

"When the INDIA block will form the government, the Agnipath scheme will be withdrawn," Gandhi said at Bakhtiyarpur.

The scheme, announced by the Narendra Modi government in 2022, envisages recruiting young soldiers, called 'Agniveers' after appointment, on a contractual basis for four years and retiring 75 per cent of them without certain benefits enjoyed by those who were not employed under this programme.

He said, "The INDIA bloc, if voted to power, will throw the Agnipath scheme into the dustbin. Modi Ji has turned soldiers into labourers. The Centre has made two categories in the Army -- Agniveer and the others. If an Agniveer gets injured or martyred, he will neither get a martyr status nor compensation... Why is this disrimination?"

After the formation of the INDIA block government at the Centre, Gandhi said, "From July, ₹ 8,500 will be deposited in women's accounts every month. This will change the financial condition of every family.

Taking a jibe at the prime minister's 'sent by God' comment, the Congress leader remarked in jest, "After June 4, if ED asks Modi about corruption, he will say I don't know anything...I was sent by God'.'



Gandhi claimed that Modi has created 22 billionaires. while the INDIA bloc government would create crores of millionaires

He accused PM Modi of waiving loans worth Rs 16 lakh crore of his "billionaire friends", and said the country will never forgive him for this.

The former Congress president alleged that Modi snatched money from the poor and gave it to corporates who invested it in foreign countries.

"This election is to save the country, save the constitution, save democracy and save reservation for the poor," he said at another rally in Paliganj.

The Congress leader also claimed that the government formed by the INDIA bloc after the elections would open all closed industries and fill up 30 lakh job vacancies.

CHANDIGARH, May 27: AAP national convener Arvind Kejriwal on Monday accused Union Home Minister Amit Shah of threatening to topple the Bhagwant Mann government in Punjab after the Lok Sabha polls to claim that the country is under dictatorship.

Union Minister Shah at a poll rally in Ludhiana on Sunday asked people to ensure victory of the BJP's Lok Sabha candidates in Punjab and said that "the Bhagwant Mann government will not last long after the BJP's victory"

On Monday, Kejriwal, while addressing a gathering of traders in Amritsar, said, "Have you heard Amit Shah's statement? He gave a threat. Initially, he abused Punjabis a lot. He issued a threat that after June 4, the Punjab government will be toppled. Bhagwant Mann will no longer remain the chief minister after June 4."

"We have 92 seats (MLAs). How can you topple (government)? There is a dictatorship (in the country)," Kejriwal said and alleged that the BJP leaders were openly saying that they would threaten the legisla-

NEW DELHI, May 27: Congress president Mallikarjun Kharge on Monday hit out at the Modi government on the state of the economy, exports and the rising trade deficit besides the 'Make in India' programme and accused him of practising "fake" nationalism by making China its biggest trade partner.

"Narendra Modi ji speaks about Mangalsutra, Mutton, Machhali, Mughal and Mujra, but does not talk about 'Make in India'? Why Modi ji does not utter a single word on the economy in his numerous election speeches? The answer lies in his Government's abject failure,"

Kharge said in a post on X. "The 'Make in India' programme has flopped, the PLI Scheme floundered and exports are in a free fall,'

he alleged. Drawing a parallel between the Congress-led UPA and 10 years of the BJP-led NDA government, he said the manufacturing growth (at constant 2015 USD) during the Congress-UPA rule from 2004 to 2014 was 7.85 per cent while that during the Modi's NDA rule from 2014 to 2022 was 6.0 per cent.

India's trade deficit under Modi increased by a record 194.19 per cent, he said, adding that during the Congress-UPA rule from 2013-14. it was ₹ 8.1 lakh crore while during the Modi-NDA rule from 2023-24, it was ₹ 23.83 lakh crore.

"Modi ji says he may not have been born 'biological', but the 'logical' thing to do is to 'vote BJP out' and 'vote for INDIA'," Kharge said ahead of the last phase of polling on June 1.

Meanwhile, in another post, Congress leader P Chidambaram targeted the government on the state of the Indian Railways where the poor passengers have to face the brunt.

BENGALURU, May 27: Exactly a month after he left the country, Hassan MP Prajwal Revanna, who is facing charges of sexually abusing several women, has said he will appear before the Special Investigation Team (SIT), probing the cases

J&K records highest voter turnout in 35 yrs; CEC says assembly polls to be held there soon

NEW DELHI, May 27: The Election Commission on Monday said the voter turnout in Jammu and Kashmir this time was the highest in a Lok Sabha election in the last 35 years with the Kashmir Valley witnessing a "massive" 30 percentage point jump in poll participation compared to 2019.

Chief Election Commissioner Rajiv Kumar said this achievement sits on a 25 per cent increase in the number of contesting candidates since 2019. "This active participation is a huge positive for the assembly elections to be held soon so that the

democratic process continues to thrive in the Union Territory," he said.

The poll panel also said the combined voter turnout at the polling stations for the entire Union Territory with five Lok Sabha seats was 58.46 per cent. On Saturday, CEC Kumar told PTI Videos that encouraged by the voter turnout in Jammu and

Kashmir in this Lok Sabha polls, the Election Commission will "very soon" initiate the process of conducting the assembly polls in the Union Territory. The voter turnout of 50.86 per cent from the three parliamentary constituencies in the Kashmir Valley echoes the faith of the people in the democratic process, the Election Commission said, adding the poll participation percentage witnessed a 30-point jump from the 2019 general elections where it was 19.16 per cent.

The three seats in the Valley -- Srinagar, Baramulla and Anantnag-Rajouri -- recorded a voter turnout of 38.49 per cent, 59.1 per cent and 54.84 per cent, respectively, all of which have been the highest in the last three decades.

The other two seats in the Union Territory -- Udhampur and Jammu -- which fall in the Jammu region, recorded 68.27 per cent and 72.22 per cent

voter turnout respectively, it said.

The Election Commission said that an increasing number of young people have asserted their faith and embraced democracy in a big way.

Another interesting perspective is the people in the age group of 18-59 years who constitute over 80 per cent of the electorate in each of the five Lok Sabha seats of the Union Territory, it underlined.

The high poll percentage in the 2024 Lok Sabha polls is reflective of their faith in democracy, which is a positive and heartening development, the poll panel stressed. Whenever an assembly election is held in Jammu and Kashmir, it will be the first since the August 2019 abrogation of Article 370 of the Constitution and the bifurcation of Jammu and Kashmir into two Union Territories with the other being Ladakh which has one Lok Sabha seat and no provision for a legislative assembly. (PTI)

India's rain-fed agri areas likely to receive above-normal monsoon rain this year

NEW DELHI, May 27: India's core monsoon zone covering most of the rain-fed agriculture areas in the country are predicted to receive above-normal rainfall this season, the India Meteorological Department (IMD) said on Thursday.

Below-normal monsoon rainfall is expected in northeast India, normal in northwest, and above-normal in central and south peninsular regions of the country, Director General of IMD Mrutyunjay Mohapatra said at a virtual press conference.

Last month, the IMD said the country could see above-normal rainfall in the four-month monsoon season (June to September) with cumulative rainfall estimated at 106 per cent of the long-period average of 87 cm.

"India's monsoon core zone comprising most of the rain-fed agriculture areas are likely to receive abovenormal rainfall (more than 106 per cent of the long period average)," Mohapatra said.

Madhya Pradesh, Rajasthan, Maharashtra, Odisha, Chhattisgarh, Madhya Pradesh, Uttar Pradesh and West Bengal form the country's core monsoon zone where agriculture is primarily rain-fed.

The IMD director general said the country is likely to experience normal rainfall (92-108 per cent of the long period average of 166.9 mm) in June.

"Barring a few parts of southern peninsular India, normal to above-normal maximum temperatures are expected in the country in June," the senior meteorologist said, adding that conditions are favourable for monsoon



onset over Kerala in the next five days. With the crippling heat testing power grids and triggering droughtlike conditions in parts of the country, a prediction of above-normal monsoonal rainfall comes as a huge relief for the nation

However, normal cumulative rainfall does not guarantee uniform temporal and spatial distribution of rain across the country, with climate change further increasing the variability of the rain-bearing system.

Climate scientists say the number of rainy days is declining while heavy rain events (more rain over a short period) are increasing, leading to frequent droughts and floods. The monsoon is critical for India's agricultural landscape, with 52 per cent of the net cultivated area relying on it. It is also crucial for replenishing reservoirs critical for drinking water, apart from power generation across the country.

According to the Central Water Commission, water

->

storage in 150 major reservoirs in India dropped to just 24 per cent of their live storage last week, exacerbating water shortages in many states and significantly affecting hydropower generation.

June and July are considered the most important monsoon months for agriculture because most of the sowing for the Kharif crop takes place during this period.

El Nino conditions are prevailing at present, and La Nina may set in by August-September, scientists say. While El Nino -- periodic warming of surface waters in the central Pacific Ocean -- is associated with weaker monsoon winds and drier conditions in India, La Nina -- the antithesis of El Nino -- leads to plentiful rainfall during the monsoon.

Data from the 1951-2023 period shows India experienced above-normal rainfall in the monsoon season on all nine occasions when La Nina followed an El Nino event. The country gauged above-normal or normal monsoon in 20 out of the 22 La Nina years.

The IMD is also anticipating the development of a positive Indian Ocean Dipole (IOD) or cooler-than-normal Indian Ocean in the east compared to the west, which helps bring rain to several states in southern India. The IOD is currently 'neutral' and is expected to turn positive by August.

Another factor is below-normal snow cover in the northern hemisphere and Eurasia. Historically, there has been an "inverse relationship" between the levels of snow here and the monsoon. (PTI)

NEW DELHI, May 27: Home Minister Amit Shah believes the influence of black money will increase during the ongoing Lok Sabha elections following the Supreme Court's decision to scrap the electoral bond scheme, and suggested all stakeholders will have to deliberate and decide on an alternative. If the impact of black money rises, then an alternative should be found, he said, adding that it is for Parliament to debate and decide on any other mechanism for funding to political parties. He told PTI in an interview on Saturday that the electoral bond scheme, which allowed donors to fund political parties anonymously by purchasing bonds from the SBI, was scrapped at a crucial time. The Supreme Court had struck down the scheme in February, a month before the Lok Sabha elections were announced. Replying to a question on the issue, he said, "I believe and this is my guess that it will increase the influence of black money in elections and politics. When political parties submit their account for this fiscal vear, then how much money is by cash donation and how much is through cheque will be known." (PTI)

PORSCHE CAR CRASH 'Juvenile's blood sample changed to show no trace of alcohol'; 2 doctors held

PUNE, May 27: Pune Police investigating the Porsche car crash case on Monday said the blood samples of the juvenile driver were thrown into a dustbin and replaced with another person's samples which showed no traces of alcohol and arrested two doctors of the state-run Sassoon General Hospital.

Another person was also arrested for his alleged links with Dr Ajay Taware, head of the Sassoon Hospital's Forensic Medicine department and Dr Shrihari Halnor, the chief medical officer of the state-run hospital.

"The juvenile's father had called the doctor and offered him allurements to replace the blood samples," Pune Police Commissioner Amitesh Kumar said at a press conference here on Monday.

As the juvenile's blood samples were replaced, the report which was received on Sunday from the hospital showed no traces of alcohol, he said.

Two IT professionals were killed after their motorcycle was hit by a speeding Porsche allegedly driven by the minor boy in the early hours of May 19 in Kalyani Nagar area of Pune city. The police claim the teenager was drunk at the time of the accident.

In separate developments, a court allowed the police to take custody of Vishal Agarwal, the realtor father of the 17-year-old involved in the car crash, from the Yerwada Central Jail in connection with the case of kidnapping and wrongful confinement of his driver.

A team of representatives from Porsche reached the Yerwada police station on Monday to conduct a technical inspection of the luxury car involved in the crash, an official said.

"Dr Ajay Taware and Dr Shrihari Halnor have been arrested. The investigation revealed that the blood samples of the juvenile were replaced with some other person's samples and this was done on the direction of Dr Taware," said Amitesh Kumar

On the instructions of Dr Taware, the juvenile's blood samples were thrown into a dustbin and replaced with the blood samples of another person, he said.

"The investigation also revealed that it was the juvenile's father who had called Dr Ajay Taware and offered him allurements to replace the blood samples," Kumar said

Another police official from the crime branch told PTI that the juvenile's father made multiple calls to Dr Taware.

Kumar said the manipulation of the blood sample came to light after another sample of the juvenile taken for DNA sampling was sent to another hospital.

"The report of the other hospital revealed the juvenile's blood report at the Sassoon Hospital was manipulated as the DNA of (blood samples of) both the reports did not match," he said.

He said a probe is underway to find out whose blood samples were collected to replace those of the juvenile and CCTV footage of the Sassoon Hospital was recovered.

The police commissioner also said that Indian Penal sections 201 (causing disappearance of evidence of offence), 120 B (criminal conspiracy) and other relevant sections have been added to the case in which the juvenile has been booked.

"We have made the juvenile's father co-accused in the present case," he said.

A police officer said the court allowed the police to take custody of Vishal Agarwal from the

KOLKATA, May 27: One person died and two others were injured in Kolkata following heavy rain triggered by Cyclone Remal that pummelled the coasts of West Bengal and neighbouring Bangladesh with devastating wind speeds, officials said on Monday.

A man died of his injuries when a wall collapsed due to relentless downpour on Sunday at the Bibir Bagan area of Entally in central Kolkata, a state disaster management official said.

Two others suffered injuries in Maniktala area after the cyclone struck, though the exact cause is yet to be known, he said. Kolkata recorded 150-mm rainfall in 24 hours till 8.30 am, while neighbouring Salt Lake received 110-mm rain during the period. Tarakeswar in Hooghly received the highest amount of rainfall in south Bengal at 300 mm, the Met office said

Vehicular traffic movement was disrupted in several pockets of Kolkata since Monday morning, the first working day of the week, as trees lay uprooted and streets overflowed with water on account of the incessant rain the cyclonic system brought over the city.

Reports of uprooting of trees were received from Southern Avenue, Lake Place, Chetla, D L Khan Road, Dufferin

Road, Ballygunge Road, New Alipore, Behala, Jadavpur, Golpark, Hatibagan, Jagat Mukherjee Park and College Street, as well as the city's adjoining Salt Lake area, the officials said.

Around 68 trees were uprooted in Kolkata, and another 75 in nearby Salt Lake and Rajarhat area

"Water-logging was reported from various places including Southern Avenue, Lake View Road, Pratapaditya Road, Tollygunge Phari, Alipore and Central Av-

enue, resulting in traffic diversion." a senior officer of Kolkata Traffic Police said. Flight services from the Kolkata airport also resumed on Monday morning after being suspended for 21 hours in view of the cyclone, a senior Airports Authority of India (AAI) official said.

Metro Railway services in the north-south corridor were disrupted in parts for fourand-a-half hours on Monday morning. The services continued in a truncated manner between Dakshineswar-Girish Park stations and Kavi Subhash-Mahanayak Uttam Kumar stations (Tollygunj-New Garia) from 7:51 am to 12 pm, a Metro Railway spokesperson said.

The disruption occurred due to waterlogging on tracks in between Park Street and Esplanade stations

Normal services over the entire stretch of Dakshineswar-New Garia (Kavi Subhas), called the 'Blue Line', resumed from 12:05 pm, the official said.

Kolkata Mayor Firhad Hakim said the municipal corporation was trying to address the situation on war footing.

"The situation is not that worse compared to what it was when Cyclone Amphan hit. The trees are being removed to make way for traffic. The drainage pumps are also operating at full strength," Hakim told PTI.

Salt Lake Mayor Krishna Chakraborty

said the uprooted trees have been removed and roads are clear for traffic movement.

The Syama Prasad Mookerjee Port in Kolkata, which suspended all cargo and container handling operations in the wake of Cyclone Remal, began returning to normal on Monday and ship navigation is expected to commence in the evening, a top official said.

"There was no major impact of the cyclone on the port infrastructure in both Kolkata and Haldia docks except for some uprooted trees causing disruptions. The port will begin operations from 2 pm onwards, and navigation of ships is also expected to resume from the evening,' Chairman Rathendra Raman told PTI.

The port had halted operations from 6 pm on May 26 to 6 am on May 27 in view of the cyclone.

Meanwhile, Governor C V Ananda Bose said in a message issued by the Raj Bhavan: "We are all greatly relieved that no reported casualty is there. Cyclone Remal is weakening. The people of Bengal are able to brave it with courage. We are keeping a watch on the situation. If there is any need, Raj Bhavan's doors are open for all.

Bose has also constituted a task force at the Raj Bhavan. (PTI)

Game zone fire: Gujarat HC raps Rajkot civic body, says it doesn't have faith in state machinery



AHMEDABAD, May 27: The Gujarat High Court on Monday said it does not have faith in the state machinery "which gets into action only after innocent lives are lost", as it pulled up the Rajkot civic body over the purported lapses in functioning of the game zone facility where a massive fire killed 27 persons. A special bench of Justices Biren Vaishnav and Devan Desai asked whether the civic body sat over the fire safety orders passed earlier on a PIL for 18 months

The HC was hearing a suo motu PIL on the TRP game zone fire tragedy which occurred on May 25. A day earlier, the HC termed the incident a prima facie "man-made disaster".

The bench asked whether the civic body had turned a blind eve to such a big structure coming up in its vicinity after its lawyer submitted that the TRP Game Zone had not asked for requisite permissions. The bench noted that all commissioners of the Rajkot municipal corporation from the time the TRP game zone was set up in 2021 till the time of this incident (on May 25) "should be held accountable for the tragedy that occurred," and directed them to furnish separate affidavits. On Monday, a counsel pointed out the state government will have to come forward to hold a person accountable, and this calls for drastic steps. "Who will take such drastic steps? Honestly speaking, we do not have faith in the state machinery now. Four years after orders of this court, directing them, after their assurance, this is the sixth incident that has happened. They only want lives to be lost and then trigger the machinery," the bench said. To the RMC counsel's submission that the game zone had not applied for requisite permissions, the HC asked whether the civic body was blind to such a big structure having come up under its jurisdiction.

corporation first recognised the existence of the game zone. "Till then you were completely ignorant of such a structure in the vicinity? Were you not aware of the orders of this court for fire safety (passed) in a PIL? What were you doing then? There are media reports that your municipal commissioner went there at the time of the inauguration. We can't take judicial notice of that fact? For 18 months, what did the corporation do? Sat over it?" the bench asked.

The court noted the game zone was conceptualised in 2021 and continued to operate till May 5, 2024, for over a period of three years, admitted without a fire NOC or any other requisite permissions. On May 9, 2024, the corporation wrote to the owners to furnish fire NOC, it stated in the order. The question is "inaction of the authorities in even inspecting the site in light of the regulations," it said and questioned why the civic body didn't inquire about the legality of the structures for 3 years since June 2021.

"On the date when the incident occurred, the game zone did not have NOCs or structural stability certificate, and it was merrily going on in front of the corporation," the bench stated.

Owners of the TRP Game Zone created a fabricated steel frame structure with the boundaries of steel patras, the HC said. It did not have a fire NOC and structural stability certificate, and was asked to provide the same in order to get the benefit of regularisation, the court noted.

"The facts itself are eloquent, therefore, to indicate that the game zone at Rajkot was conceptualised, set up and continued to operate under the very nose of the corporation's officials with-

Fire deaths up by 30pc till May as compared to 2023: Official data NEW DELHI, May 27: Fire has taken 55 lives and inhospital has no fire NOC and has not even proper fire com-

jured more than 300 people in the national capital so far this year, according to the official data revealed on Monday. According to the data by Delhi Fire Services (DFS), 16 people were killed in fire in January, another 16 in February, 12 in March, four in April, and seven till May 26. Fire incidents led to 51 injuries in January, 42 in Febru-

ary, 62 in March, 78 in April, and 71 till May 26. From January 1 to May 26, the DFS received 8,912 fire-

related calls. According to the data, 36 people had lost their lives during the same period in 2023.

"The number of fire calls increased to 32.26 per cent this year. According to the data, a total 6,436 calls related to the fire were received from January 1 to May 26, last year, but this year the number has gone up by more than 32 per cent with 8,912 fire related calls during the same period," an official of the Delhi Fire Services said.

"Last year 36 people had lost their lives, this year total 55 people have so far lost their lives," the official added. On Sunday, six newborn died after a massive fire broke

out at a private children's hospital in east Delhi's Vivek Vihar. The blaze broke out at the Baby Care New Born Hospital at around 11.30 pm on Saturday and soon spread to two other adjacent buildings.

Sixteen fire tenders were pressed into service to douse the blaze and a massive rescue operation was launched. Of the 13 children taken out from the hospital, six were declared dead. Police had said that one child had already died before the fire broke out.

On February 15, 11 people died in an explosion and subsequent blaze in a paint factory at Dayalpur market in outer Delhi's Alipur. Four people were injured in the incident. The charred bodies of the 11 victims, one of them a woman, were recovered from the factory, which doubled as a chemical godown.

The fire, which was preceded by a blast, had spread to nearby buildings, including a drug rehabilitation centre and eight shops.

In another incident in February, an 83-year-old woman died and her granddaughter sustained injuries after they jumped off the fourth floor of a residential building in southwest Delhi's Dwarka when a fire broke out in their apartment. (PTI)

Studies link widely used diabetes, weight-loss meds with increased risk of stomach paralysis

NEW DELHI, May 27: Popular diabetes and weight loss medications like Ozempic and Wegovy have been linked with an increased risk of developing stomach paralysis, new studies have found.

Stomach paralysis, also know as gastroparesis, weakens the stomach muscles, leading to food sitting in the main digestive organ for long.

We govy is approved by the US Food and Drug Administration (FDA) for weight management, while Ozempic is an approved medication helping patients with type 2 diabetes manage blood sugar levels.

However, Ozempic is sometimes prescribed for weight loss, even though it is not FDA-approved for this purpose. Both Wegovy and Ozempic are injections containing the protein semaglutide, which is similar to the hormone glucagon-like peptide-1 (GLP-1).

Released in the body in response to meal intake, GLP-1's main actions include promoting the production of insulin.

While these anti-diabetic and weight loss medications, known as GLP-1 receptor agonists or GLP-1 analogues, are known to cause gastrointestinal (GI) side effects such as nausea, vomiting and diarrhoea, new studies shows less common ones such as stomach paralysis (gastroparesis), ileus and acute pancreatitis to be occurring as well.

The studies were presented at Digestive Disease Week 2024, a conference conducted from May 18-21 in Washington DC. US.

One of these studies conducted by researchers, including those from the University of Kansas, identified 1.85 lakh patients with diabetes or obesity who were prescribed GLP-1 analogues between December 1, 2021, and November 30, 2022.

About 0.53 per cent of the patients were found to develop gastroparesis, with the research team estimating that the risk of having the condition increased by 66 per cent.

Cholecystitis (inflammation of the gall bladder) was observed in 0.55 per cent



of the patients, with the risk of developing the condition estimated to increase by 28 per cent.

The study's authors also found that 0.04 per cent of the GLP-1 analog-pre-

scribed patients developed drug-induced pancreatitis, and estimated the risk of experiencing the condition to go up by more than 350 per cent. They also found that 9 per cent of the

patients had a significantly higher incidence of nausea and vomiting, while 7.5 per cent of them showed a higher incidence of gastro-oesophageal reflux disease (GERD), a condition in which the stomach contents move up the food pipe, or the oesophagus.

The results showed that "the use of GLP-1 agonists in patients with diabetes mellitus and obesity is associated with GI side effects, including nausea, vomiting, gastroparesis, GERD, esophagitis, drug-induced pancreatitis, cholecystitis and need for upper-endoscopy," the authors wrote in the study, currently available as an abstract.

The second study assessed the risk of gastroparesis in patients with type 2 diabetes treated with GLP-1 receptor agonists (RA). More than 3.36 lakh patients were included in each of the two cohorts -- one receiving the medication and the other not.

"Patients with T2D prescribed GLP-1 RAs had an increased risk of GP at 6, 9, 12, 18 and at 24 months. The odds ratio for gastroparesis significantly increased

after 6 months through 24 months after controlling for different risk factors," the authors, including those from Cleveland Clinic, Ohio, wrote in the abstract of the study. Both the studies used data from the multi-institutional database, TriNetX.

The third study, conducted by researchers at Mayo Clinic Minnesota, assessed the impact of GLP-1 RA on GI symptoms. Data of nearly 80,000 pa-

14,660, or 18 per cent, of these patients of the 14,660 patients underwent gastric emptying scintigraphy (GES), which helps in assessing the stomach's ability to empty.

The team found that about a third of this group experienced gastroparesis.

"These real-world data suggest that GI symptoms are prevalent in those treated with GLP-1 RA," the authors wrote in the study's abstract. (*PTI*)

Best year yet for Indian filmmakers with three wins at Cannes 2024

CANNES, May 27: It was a triple feat for Indian talent at the 2024 Cannes Film Festival with Payal Kapadia's "All We Imagine As Light", "Sunflowers Were the First Ones to Know" by FTII student Chidananda S Naik, and Anasuya Sengupta of "The Shameless" fame winning major awards in each of the three competitive sections of the prestigious gala.

The 77th edition of Cannes, which concluded on Saturday, was undoubtedly the best year for the country which found space at the fest through eight Indian, or India-themed, films.

Kapadia, an alumna of the Film & Television Institute of India (FTII), charted history by becoming the first Indian filmmaker to win the Grand Prix award for "All We Imagine as Light".

"Thank you, Cannes Film Festival for having our film here. Please don't wait 30 years to have another Indian film." she said in her speech.

The movie earned the honour, the second-most prestigious prize of the gala after the Palme d'Or, which went to American director Sean Baker for 'Anora'

"All We Imagine as Light", a Malayalam-Hindi feature starring Kani Kusruti, Divya Prabha and Chhaya Kadam, revolves around three women in Mumbai who go on a road trip to a beach town. Kapadia's movie, her feature directorial debut, is the first Indian film in 30 years and first ever by an Indian female director to be showcased in main competition, last being Shaji N Karun's "Swaham" (1994).

Light" will win an award became almost certain when it received glowing reviews following its premiere, with some international critics describing it as a "portrait of urban connection" and "poetic meditation" as well as comparing Kapadia's work to that of masters like Satyajit Ray and Wong Kar Wai. Her 2017 short film "Afternoon Clouds" opened at Cannes under Cinefondation category, dedicated to supporting the next generation of talented filmmakMalayalam star Tovino Thomas.

That's not all. Production designer Sengupta, who starred in a key featuring role in Bulgarian director Konstantin Bojanov's "The Shameless", became the first Indian to win the best actress prize in Un Certain Regard. "The Shameless" explores a dark world of exploitation and misery in which two sex workers forge a bond.

Sengupta dedicated her win "to the queer community and other marginalised communities"

"You don't have to be queer to fight for equality, you don't have to be colonised to know that colonising is pathetic — we just need to be decent human beings," she said. Actor Tillotama Shome shared Sengupta's speech on Instagram.

FROM BARNAWA VILLAGE TO CANNES: DESIGNER NANCY TYAGI IS TOAST OF FASHION WORLD

NEW DELHI, May 27: Who is Nancy Tyagi? That is suddenly an oftasked question -- and not just in the world of high fashion -- with the young woman who stitched her own clothes and modelled them too in the Cannes film festival the new toast of the glamour world for her dramatic rise to fame.

The famed red carpet at the French Riviera town is a far cry from the streets of her village Barnawa in Uttar Pradesh and the 23-year-old has seen her Instagram following jump from seven lakh to two million in just a matter of days. Trending on social media and making headlines in the mainstream press, Tyagi has the likes of actor Sonam Kapoor asking her to design for them.

Cannes almost didn't happen, said Tyagi, who came to Delhi in 2020 to prepare for the civil services but couldn't go through with it because of financial constraints.

Invited as a fashion influencer, she was initially just too scared and refused to go.

"But my team convinced me and when I went there, it felt like it was the best decision of my life. Even until I was in the car by the red carpet, I was scared. But as soon as I stepped out, I felt totally different," Tyagi told PTI in an interview.

"I gave many poses. They went viral and the audience loved it. I am very grateful for them. I don't have words to thank them for their love and support. I felt very nice, and also that I was one of the influencers who were in Cannes is amazing. And I'm happy that our country is progressing," said the young designer who turned heads

at the recently concluded 77th edition of the film festival.

Overwhelmed by the attention, she said she now wants to make a costume for Kapoor. The actor, known for her versatile fashion choices, praised Tyagi's Cannes outfits and even shared an Instagram story asking when she would make an ensemble for her.

"Sonam Kapoor first posted my video in her Instagram story and later she also loved both of my Cannes looks, but she loved the saree look the most. She asked me to make her an outfit too in her Instagram story. It's a huge thing for me that a fashion diva like her has asked me. I will definitely make an outfit for her in the future," Tyagi said.

Till a week ago, not many had heard of Nancy Tyagi. Then she grabbed the attention of shutterbugs with her outfits, competing for attention with the who's who of the global showbiz and glamour world. And there is seemingly no looking back.

Besides her followers on her Instagram account, which is filled with her impressive DIY skills videos and clips of creating outfits from scratch, she also has a million followers on YouTube.

For her Cannes foray, Tyagi designed four garments, which took her two months to put together. She created her first look, a beautiful 20 kg pink gown with frills and made with 1,000 metres of fabric, in 30 days. In the month that followed, she made the other three.

"For my first Cannes look, I thought of making the outfit in orange or black. I dropped the idea to make it in black because all the photographers

there wear black and it would seem that I am one of them. And for orange. I thought it won't look good in summers.

"But I didn't know that it would be cold in France. So I chose the colour pink and I looked like a doll in it. And (her younger brother) Manu also told me to choose pink. I made four outfits which took me two months to make. I worked on the first look, the pink gown, single-handed and it took me one month... It was difficult," she said. From setbacks to success: Shreyas Iyer's journey to IPL victory

KOLKATA, May 27: When Shrevas Iver recreated Lionel Messi's famous World Cup celebration after lifting the IPL Trophy as Kolkata Knight Riders captain in Chennai, it was nothing short of an Argentina moment for the embattled Indian cricketer at an individual level.

His central contract torn up a few weeks before the IPL besides a recurring back injury threatening to derail him. Iver faced numerous challenges at the start of the year. He finally found a deep sense of

triumph and vindication in this victory, much like Messi did after exorcising the ghosts of losing the 2014 final and winning the trophy for his country after a 36-yearwait. For the two-time IPL champions, the wait lasted 10 years as Iyer sang a redemption song following a topsy-turvy start to the vear. Little wonder then that he chose to imitate the man who knows all about rising from setbacks. So, Iyer, with the trophy in his hands, took a playful walk to-

wards his teammates, quite similar to what Messi did after the final against France in Doha, and handed the big prize to them.

"I am hearing a lot about Gautam Gambhir, who has created a magnificent culture in the KKR team. But this guy (Iyer), I don't think he is getting enough credit. Shreyas Iyer needs some credit," said the legendary Ian Bishop on Sunday as KKR defeated Sunrisers Hyderabad by eight wickets in a completely one-sided final to win their third IPL title.

KKR may have got most of their runs from openers Sunil Narine and Phil Salt, but they played as a team and managed to come out winners in a dominant season, topping the table with two rounds to spare, and enduring just three losses in between.

"It is hard to express how we are feeling right now. The wait was so long. We played like invincibles throughout the season. There is so much to cherish right now," said Iver.

It was a special feeling for his

childhood and Mumbai coach Pravin Amre, who first tested his character by promoting Iyer to No.3 from No.7 in his maiden Ranji season in 2014-15.

Iver returned with 153, his maiden first-class hundred in their match against Bengal at Eden Gardens in December 2014.

"I challenged him in his entire career (in Mumbai)...I knew how strong-willed he's and it was my job as a coach to challenge him. He always liked to take the challenge in a good stride. he is a good team man. In the last world cup, he scored 530 runs," Amre said.

"I always told him you just do whatever is in your hands, let the other people do their job, you just remain focus on what's in your hands," added Amre who first took him under his wings at the Shivaji Park Gymkhana.

By leading KKR into final, Iyer achieved the rare of feat of playing the summit clash as captain of two different franchises in the IPL. The KKR skipper missed the last season because of a back injury that required a surgery in London last year. He made a comeback in the Asia Cup and went on to become India's third leading run-getter after Virat Kohli and Rohit Sharma in the last year's ODI World Cup.

The year didn't start well for him though as he had a difficult outing in the home Test series against England and looked patchy scoring 140 runs in the first two matches before being left out for the final three Tests.

It was learnt that he developed the recurring back problem, even though he was cleared by the Board medical staff. Iver then became the centre of a controversy when he missed the Ranji Trophy for his home state Mumbai and went on to attend KKR's pre-season camp.

Iver, however, returned to play for Mumbai in the semifinal and final against Vidarbha where he scored a resolute 95 in the second innings of their 42nd Ranji triumph. (PTI)

MELBOURNE, May 27: Australia is facing shortage of players and might be forced to use support staff as substitute fielders in the warm-up games of next month's T20 World Cup due to the low turnaround time between the IPL and the global showpiece. Australia are set to play two warm-up games against Namibia on Wednesday and the West Indies on Friday in Trinidad but they might have as few as eight players available for the two matches since most of them will take a break following their stint in the IPL playoffs.

"We're going to be undermanned. But it is a practice game. The guys who need to play

will play as much as they can and we'll figure it out from there," captain Mitchell Marsh, who himself is not certain to play against Namibia as he is recovering from a hamstring injury, told cricket.com.au.

The IPL finals between Kolkata Knight Riders and Sunrisers Hyderabad concluded on Sunday night and three players -- Travis Head, Pat Cummins and player of the match Mitchell Starc -- were part of the two teams. Besides the trio, Cameron Green and Glenn Maxwell, who were part of the Royal Challengers Bengaluru, will only link up with the World Cup squad by the end of the week in Barbados,

while Marcus Stoinis, who played for Lucknow Super Giants, is expected to arrive in Trinidad only after the Namibia practice match.

Travelling reserves Jake Fraser-McGurk and Matt Short too are set to join after Australia's first match of the tournament proper which is against Oman on June 5. "It's important to be flexible. Guys who have been at the IPL have been playing a lot of cricket. We prioritised giving them a couple of days at home to see their families, refresh, and play the long game for this tournament," Marsh said.

The Americans have surely one reason to follow the event. Their team, mainly made up of players from South Asian and Caribbean heritage, will be making its World Cup debut.

Venu Pisike, head of USA Cricket, reckons the ICC event will bring much-needed awareness around the game but eventually, it is the lure of taking part in the 2028 Olympics that will draw masses to the sport.

"So far, cricket is predominantly an expats' game, but with the marketing and promotion activities during the World Cup,

there is some momentum and the World Cup will definitely boost the opportunities to expand the game in the USA," said Pisike. "Definitely, the World Cup is

bringing a lot of awareness and then the opportunity for cricket to be in the Olympics, that will definitely attract the community because the US is a huge sports country.

"Olympics is the prime area where all the sports bodies are focusing on since cricket is going to Olympics, that will actually give more opportunities to expand the sport between the World Cup and the Olympics," added Pisike.

The USA squad picked for the tournament makes up for a bunch of semi-professionals who rely on full-time jobs to run their families. That will have to change if the sport is to appeal to a broader audience in America, believes India-born USA squad member Nisarg Patel.

"Ultimately what needs to change in the USA is that an American kid in a high school needs to see a future in the game. There are so many sports in America, the country is built on Olympic medals. (PTI)



CHENNAI, May 27: Former Australia batter Matthew Hayden has termed Mitchell Starc's outstanding away-swinger to Abhishek Sharma in the IPL final as the "ball of the IPL" while describing Sunil Narine as the "best player" for triumphant Kolkata Knight Riders.

Shreyas Iyer's rampant KKR, who were unstoppable throughout the 17th edition of the IPL, crushed Sunrisers Hyderabad in the summit clash by eight wickets to add a third trophy to their cabinet on Sunday.

The moment that ball bowled to Abhishek Sharma came out of Mitchell Starc's hands, it was game over. It was destined to be the best ball of the IPL — an absolute peach at a time when it was so important," Hayden told Star Sports Cricket Live.

Former England batter Kevin Pietersen said Starc's ability to get his wrist position right towards the end of IPL and cranking up extra pace along with Narine's all-round ability bolstered KKR.

"Mitchell Starc was averaging around 136-137 kmph during the majority of the season. But in the last two weeks he has gone above 140 kmph and that is his average. He is bowling fast," Pietersen said.

"We never saw him swing the ball for the first seven, (or) maybe even eight weeks of this tournament. (But) in the last few weeks, he has got his wrist in a good place and started to swing the ball back," he added.

Pietersen was lavish in praise of Narine, saying that the KKR veteran gave his critics a perfect reply. "I was one of the most vocal crit-

ics at the start of the tournament saying I didn't like Sunil Narine at the top of the order, due to his inconsistency. He would typically hit a six and then get out, disrupting the momentum," Pietersen said.

"However, this season he has been consistent. He has thought like a batter, batted like a batter and got the runs of a batter. He has averaged more than many batters and his strike rate has been phenomenal. He has played both sides of the wicket exceptionally well."

"We don't need to say much about his bowling — he is an outand-out superstar. His ability to change his action and still produce such impressive numbers is quite something. He is the heart and soul

of this outfit," Pietersen said. Former India batter Ambati Rayudu, meanwhile, credited KKR captain Iyer, coaching staff as well as the team's domestic talent for

coming together. "Shreyas Iyer has been tremendous in terms of leading KKR, and we should give him a lot of credit. He was not in the best of forms with the bat, but still, the way he has led the team, the way he has used his resources, is commendable,"

SRH were hammered by eight wickets after putting just 113 runs on the board. KKR overhauled the target in just over 10 overs to claim their third IPL trophy on Sunday night.

"We were not going to change our brand or approach. We wanted to be aggressive but also smart and work the situations through," Helmot said in the post-match press conference

"Our plan certainly wasn't to get bowled out for 113 in the 18th over. We played in a really positive way, but a few good deliveries (from KKR bowlers) early on put us on the back foot. Unfortunately, it was one of those days," he added.

Batting first, the SRH top-order failed to get going, with the three batters getting dismissed for single figures. Big-hitting opener Travis Head fell for his third duck in four matches, dismissed by left-arm pacer Vaibhav Arora.

"Travis is experienced in playing left-arm pace. We have had games where both he and Abhishek (Sharma) have scored runs," the Australian said.

"Obviously, we couldn't get as much (support) from the middle order as we would have liked, but it was a fairly good ball to get rid of him (Head)," he added.

Hailing KKR's performance this season, Helmot said the Shreyas Iyer-led franchise displayed an aggressive mentality throughout the season.

"We have got to give credit to KKR. They have had a great season, winning 79 per cent of their games and playing an aggressive brand with the bat, ball and on the field. But, we will come (back) hard next season," he continued. (PTI)

"I don't know the schedule exactly but I have thoroughly enjoyed and hope to be back next year and hopefully, seen in purple and gold again.'

Starc, like many others, agreed that the Impact Player rule led to tall scores in the IPL and the World T20 won't witness insane totals like 270. He said he foresees more help for spinners from







Knight Riders, was magnificent in the business end of the tournament. He ended up with 17 wickets, including five in the two knock-out games, to engineer a dominant title triumph for the Shah Rukh Khan-owned team.

To a query from PTI as to how he would take it up from here after his best year in franchise cricket, Starc hinted that T20s could gain prominence in his roster.

"For the last nine years, I certainly prioritised Australian cricket. I have pulled out often to have a chance to give my body a break and spend some time away from cricket with my wife as well, so that's certainly been where my head has been for last nine years," Starc said after his match-winning 2/14 in the IPL final against Sunrisers Hyderabad.

"Moving forward, I am certainly close to the end of my career than the start. One format may be dropped off as there is long time till next World Cup and whether that format drops off or not, that will open doors for a lot of franchise cricket," the 'King of Swing' said.

He mentioned that this year's IPL will help him in preparing for the T20 World Cup in West Indies starting June 1.

worn-out tracks.

"T20 is not as physically demanding as Test cricket and it's been warm, humid, so that plays a part but that's fine. It would be cooler there in the West Indies than here," he said when asked how his body is holding up after two months of IPL.

"There's the Impact Player Rule here and that's not the case in the World Cup and after that you have to put a team that's more balanced and you rely more on all-rounders. You can't have your batting all-rounder coming in at No. 9, like they do in IPL.

"I don't think the runs would be that much, I don't think 270 can be scored... Wickets may play a part as we have seen highscoring matches here and wickets won't be same in West Indies. "They might turn and will be a bit more tired, and towards end

of tournament, they might pose more of a threat staying low and hope bowlers come into play more than they have come through in IPL," he said.

During the first phase where he was trying to find rhythm, Starc copped a lot of criticism and it wasn't surprising that his multi-crore price tag was an issue. He doesn't think much of that.

"You don't need extra motivation. I am here as an overseas international. It's not like for that last night (Qualifier 1) or this final that I have been brought over here. (PTI)

Shah also congratulated KKR for their title triumph.


