

82.11 lakh electorate to seal fate of 47 candidates in Assam during Lok Sabha polls

Third phase of LS polls for 4 Assam constituencies today
All eyes on Guwahati battle

GUWAHATI, May 6: The political fate of 47 candidates in four Lok Sabha seats will be decided on Tuesday when the third and final phase of the elections in the state will be held.

Polling will begin at 7 am and conclude at 5 pm in the four constituencies - Kokrajhar (ST), Dhubri, Barpeta and Guwahati.

All eyes will be on the prestigious Guwahati seat where both BJP and Congress have put up woman nominees - Bijuli Kalita Medhi and Mira Borthakur Goswami - respectively.

The other prominent candidates are AIUDF chief Badruddin Ajmal who is seeking re-election for the fourth successive term from Dhubri, Congress MLA Rakibul Hussain, eight time Asom Gana Parishad legislator Phanibhushan Choudhury and CPI(M) MLA Manoranjan Talukdar.

Barpeta has the highest of 14



candidates and Guwahati the lowest of eight in the fray while six women are contesting in the final phase. The BJP has put up only one candidate in this phase for the Guwahati seat, while its alliance partners AGP are contesting in two - Dhubri and Barpeta - and the are contesting in two each.

UPPL in Kokrajhar. The Congress and the Voters Party International (VPI) are fighting in all four seats, while the BPF. the Trinamool Congress, Bharatiya Gana Parishad, SUCI(C) and Republican Party of India (Athawale)

The AIUDF, CPI(M), Gana Suraksha Party, Hindu Samaj Party, Asom Jana Morcha, National Road Map Party of India, Rashtriya Ulema Council, Ekam Sanatan Bharat Dal and Bahujan Maha Party are contesting in one seat each while 16 independents are also in the fray

A total electorate of 82.11 lakh including 41.27 men, 40.84 women and 112 belonging to the third gender will be eligible to exercise their franchise in 9,516 polling stations

Polling will be held amid tight security with 60 companies of security forces deployed across the five constituencies.

In Guwahati, held by the BJP, a direct contest is on the cards between BJP's Bijuli Kalita Medhi and Congress candidate Mira Borthakur Goswami, both debutants in Lok Sabha polls. The contest in (CONTD. ON PAGE-2)

GUWAHATI, May 6: Items worth ₹ 210 crore have been seized in Assam where the last phase of polling will be held on Tuesday, a senior official said.

Addressing a press conference on Monday, chief electoral officer Anurag Goel said cash, liquor, drug and other goods were seized by var-

ious agencies during the elections. "The total cash seized so far during the three-phase polling in Assam stood at ₹ 19.1 crore. Various agencies seized nearly 8.26 lakh litres of liquor, valued at more than ₹ 31.8 crore." he said

Drugs worth ₹ 129.5 crore were also seized during the period under review, he added.

Besides, ₹ 28.8 crore worth of precious metals were seized, Goel said. A total of 502 Flying Squads, 452 Static Surveillance Teams and 🜌

93 Quick Response Teams were deployed, and 440 checkpoints and 178 inter-state nakas were created, he said. Goel said a total of 81,49,091 people, including 41,00,544 men, 40,48,436 women and 111 persons of third gender, will vote in the third phase of polling on Tuesday. Among them 1,529 are centenarians and 2,10,177 are first-time voters, he added.

A total of 47 candidates, including six women, are in the frav in the four constituencies -- Guwahati, Barpeta, Dhubri and Kokrajhar (ST).

There will be a total of 9,516 polling stations, including 300 critical ones, the CEO said.

"We will have 1,474 urban and 8,042 rural booths. Out of the total booths, 326 will be managed by women and 14 by persons with disabilities (PwD). There will also be 84 model polling stations," he said.

Around 45,000 polling officials and an equal number of security personnel have been engaged during the third phase of polling, Goel said. A total of 221 complaints over violations of the Model Code of Conduct (MCC) were lodged in the three phases in the state.

"Out of the total complaints, 219 have been resolved and only two are pending. There were 12 major complaints," he said.

Goel further said that out of 18,202 licensed arms in the state, 15,315 were deposited. Besides, 32 illegal weapons were seized along with 85 cartridges. Assam has a total of 14 Lok Sabha seats, with voting for 10 seats taking place on April 19 and April 26. (PTI)

The BJP will also get the support of the minority community as they have understood that only its government can provide them security and jobs, Medhi claimed in an interview with PTI.

Medhi is locked in a direct contest with Congress candidate Mira Borthakur Goswami in the constituency which has been represented by women since 2009.

"Our party's main agenda is to empower women, to bring them to the frontline economically, culturally, socially and politically," she



said. The women electorate will come out in large numbers to vote for the BJP since they have been benefitted from the schemes initiated by the governments, she claimed. Minority women, in particular, are "extending full support to us because they are aware of the fact that if anybody can provide them security and safety, work for their uplift, it is the BJP government at the Centre and the state," Medhi as-

serted. People are happy with the development work that has taken place in the state during the last 10 years and they want Modi to be the prime minister for the third time, she claimed. "The consecration of the Ram Temple had a very good impact on the people," the 45-yearold BJP candidate said.

"Members of the minority community, too, have come out in large numbers to attend our meetings in different parts of the constituency and they have extended full support to us," Medhi added.

The BJP dropped sitting party MP Queen Ojah and gave ticket to Medhi who is a party Vice President and a former head of the party's women wing. Her Congress rival Mira Borthakur Goswami has claimed that Medhi is seeking votes so that (CONTD. ON PAGE-2)

Delhi LG V K Saxena recommends NIA probe against Kejriwal

NEW DELHI, May 6: Delhi Lt Governor V K Saxena has recommended an NIA probe against chief minister Arvind Kejriwal for allegedly receiving political funding from the banned terrorist organisation 'Sikhs for Justice', Raj Niwas sources said on Monday.

AAP alleged that the recommendation is "yet another conspiracy' against Kejriwal at the behest of the BJP.

In a letter to the Union Home secretary, the lt governor's secretariat said Saxena had received a complaint that the Kejriwal-led AAP allegedly received USD 16 million funding from extremist Khalistani groups for facilitating the release of Devendra Pal Bhullar.

Bhullar, who is in Amritsar Central Jail, was convicted in connection with the killing of nine people in a bomb blast in 1993 in Delhi. He was sentenced to death by a designated TADA court on August 25, 2001 and is undergoing life im prisonment after the Supreme Court commuted his death sentence. "The electronic evidences adduced by the complainant requires investigation including forensic examination, Saxena has said in the letter according to sources. The complaint is made against a chief minister and relates to political funding received from a banned terrorist organisation, the letter stated. The move comes a day ahead of the Supreme Court considering granting Kejrwal interim bail in view of the ongoing Lok Sabha elections. The AAP chief, who is in Tihar jail, was arrested on March 21 by the Enforcement Directorate in connection with an excise policy linked money laundering case. The complaint refers to a video released by Khalistani terrorist Gurpatwant Singh Pannun, where he alleged that the Kejriwal-led AAP received USD 16 million from Khalistani groups between 2014 and 2022, sources said. Addressing an election rally in favour of senior BJP leader and Union Minister of State for Home Affairs Nityanand Rai, in Bihar's Samastipur district, Shah said, "The latest recovery of Rs 30 crore and more from the house of a minister in Jharkhand proves INDIA bloc leaders are corrupt.'

He also said, "If they come to power, there will be a complete 'jungle raj' in the country as well as in Bihar.

Notably, the Enforcement Directorate on Monday claimed to have recovered a huge amount of "unaccounted" cash during searches at the premises of a domestic help allegedly linked to the secretary of Jharkhand minister Alamgir Alam.

"Who will be the PM of the INDIA bloc? Will Sharad Pawar be the prime minister? Will Mamata Banerjee become (the PM) or MK Stalin or Uddhav Thackeray? I will take another name. Please don't laugh. Can Rahul baba become the PM?" Shah said. He also alleged that leaders of the RJD and the Congress did not attend the consecration ceremony of the

Ayodhya Ram temple because of vote bank politics. RJD's Lalu Prasad and Congress always opposed the construction of Ram temple in Ayodhya, he claimed.

Shah also said Congress has always opposed reservation to backward classes.

NEW DELHI, May 6: The Congress on Monday targeted the Modi government on Chinese transgressions, and asked whether it has "surrendered" thousands of square kilometres in Depsang and Demchok to China or is it still trying to return to the status quo ante before May 5, 2020.

The BPF is the principal opposition, having ruled the BTR for 17 years since its formation in 2003 until being ousted from power in 2020 by the present regime.

Doloo greenfield airport



NEW DELHI, May 6: The Supreme Court on Monday restrained authorities from carrying out any activity at the Doloo tea estate in Assam's Cachar district where a greenfield airport is proposed to be constructed.

Noting that over 41 lakh tea bushes have been uprooted, a bench

headed by Chief Justice D Y Chandrachud said the authorities in the present case have acted in violation of the Environment Impact Assessment Notification, 2006 by carrying out extensive clearance at the site without any environmental approval.

The top court also criticised the

National Green Tribunal for "complete abdication of its duty" and said it was the first and foremost duty of the tribunal to verify the authenticity of the grievance of the petitioners before dismissing their plea. "We hold that there was complete abdication of duty by the National Green Tribunal. As an expert body, which has been formed under statute enacted by the Parliament in the interest of preservation of environment, it was first and foremost duty of tribunal to verify the authenticity of the grievance of appellants and instead it just dismissed the OA (original application) saying no environmental clearance has been issued.

"From the material placed on record, we are of the view that authorities in the present case have acted in violation of the EIA notification by carrying out extensive clearance at the site in absence of environmental clearance," the

Absolute number of voters correct way to analyse: Report

Concerns on low voter turnout a 'myth'

MUMBAI, May 6: Terming concerns on low voter turnout in the first two phases of 2024 general elections a "myth", an economist at the country's largest lender SBI has said comparing the absolute number of votes cast is a better way to analyse the turnout.

Soumya Kanti Ghosh, the group chief economic adviser at SBI, said there has been 0.4 per cent increase in the absolute number of votes cast in the first two phases.

"The unending debates propagated around supposedly low voter turnout in the first two phases of the General Elections 2024 is a myth. A better measure of votes cast is the absolute number of voters." he said in a report.

The Election Commission has been working to increase the voting percentage in the remaining phases of the polls.

Ghosh, who is also a part time member of the 16th Finance Commission, said the voting is about 3.1 percentage points below the trend observed in the last general elections of 2019, but was quick to add that the numbers can "swell"



in the remaining 5 phases of polls and there will be a "J-shaped"

growth "During 2019, the voting pattern showed a declining trend over the 7 phases, starting at 69.4 per cent and finishing at 61.7 per cent. In 2024, we believe a reverse phenomenon could be underway, with voting percentage poised for a marked improvement going by the absolute numbers of voting exer- lowed by Assam and Maharashtra.

A granular analysis of constituencies shows that the absolute number of votes cast increased by more than 1 lakh in 85 constituencies, whereas in 25 constituencies, there was a status quo. Hence, 60 per cent constituencies exhibited either increase or no marked difference, it said

The Lok Sabha elections are being held in seven phases and the polling for the third phase is due on Tuesday

"We also believe the scorching summer and sweeping heat waves might have played a spoilsport for a certain percentage of voters," it said.

Meanwhile, it also said that 17th Lok Sabha was the most efficient ever as per its model, and 2023 was the most efficient year for the Parliament in terms of bills passed, at par with 1955.

The years of 1976 (the emergency year with major opposition political leadership in abeyance) and 2020 (the disruptions brought in by the pandemic) have been excluded for the rankings purpose, it said. (PTI)

India's service activity growth in April among fastest in 14 years: PMI

NEW DELHI, May 6: India's services sector growth eased slightly in April but growth of new business and output remained sharp and among the fastest in 14 years amid favourable economic conditions and strong demand, a monthly survey said on Monday. The seasonally adjusted HSBC India Services Busi-

ness Activity Index fell from 61.2 in March to 60.8 in April, highlighting one of the strongest growth rates seen in just under 14 years.

Survey members attributed the latest upturn in output to favourable economic conditions, demand strength and rising intakes of new work.

In the Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

"India's service activity rose at a slightly softer pace in April, backed by a further rise in new orders, with a notable strength in domestic demand," said Pranjul Bhandari, Chief India Economist at HSBC.

In addition to buoyant domestic demand, firms noted new business gains from several parts of the world, which collectively underpinned the secondquickest upturn in international sales since the series started in September 2014. (PTI)

The sitting independent Kokrajhar

MP Naba Kumar Sarania, representing the seat reserved for Scheduled Tribes since 2014, had filed his nomination papers which was rejected following the striking down of his Scheduled Tribe (ST) status.

Assam chief electoral officer Anurag Goel said that all arrangements have been completed for conducting the polls in a free, fair, safe and peaceful manner.

In the first phase of polls held on April 19, 78.25 per cent of the electorate exercised their franchise to decide the fate of 35 candidates for the Kaziranga, Jorhat, Dibrugarh, Sonitpur and Lakhimpur constituencies.

In the second phase held on April 26, 81.17 per cent of the voters cast their votes to decide the fate of 61 candidates for Karimganj, Silchar(SC), Diphu (ST), Nagaon and Darrang-Udalguri. In the outgoing Lok Sabha, BJP held nine seats, Congress three, AIUDF and an independent one each from the state. (PTI) INDIA bloc leaders echoing

Modi while analysing the ongoing Lok Sabha elections, Rajya Sabha MP Trivedi said while elections are being held in India he is building public opinion in another country. The Congress leader has also referred to the Valley as India-administered-Kashmir, he alleged. Tharoor, however, later clarified saying he does not agree with that usage and has never used such a term in any of his writings or statements anywhere, ever. "It has been interpolated by the editors of the newspaper that my syndicated column appeared in. I disavow such language unequivocally, but have no control over what foreign newspaper editors do," he said in a post on X.

Attacking opposition leaders, Trivedi said one INDIA bloc leader is giving "cover fire" to Pakistan on the Mumbai terror attack, another is speaking about its nuclear weapon while somebody is describing the martyrdom of a solider as a poll stunt. Modi had said that the Congress manifesto carried Muslim League's imprints, he noted, adding that every word spoken by its leaders echoed Pakistan's stand. The Left parties want the country's nuclear stockpiles removed, he said.

All these developments are not merely a coincidence but a deliberate and dangerous experiment, Trivedi said. "In whose hands these leaders are playing," he asked, telling people to be wary of "traitors" hiding within the country. Various kinds of powers outside are attempting to halt the rise of a proud and confident India, he said.

At the press conference, the BJP leader also took a swipe at Rahul Gandhi over the recovery of a huge amount of cash from the house of a domestic help allegedly linked to the secretary of Jharkhand minister and Congress leader Alamgir Alam. He said Gandhi speaks about doing an economic survey and dividing the country's wealth and the Enforcement Directorate's raid has shown the way assets are being divided in Jharkhand when so much of money, between Rs 20 crore and 30 crore, is with the help of a minister's PA.

After looking at so much amount of money, nothing is left to explain, he added. (PTI)

Empowering women, PM's

Modi can become the PM again and not for what she can do for the people of the constituency. Medhi said, 'My opponent does not have to tell me what I have to highlight about my constituency. I was the deputy mayor of Guwahati and I know very well about the problems and how to resolve those."

She said that the BJP government in the state has already taken several measures to address the problems of water logging and traffic while land documents were provided to the people. Medhi claimed that 80 per cent of the work to solve the flood problem in Guwahati has been done but, since population is increasing day by day, continuous work is needed in this regard.

"People have realized that if there is any government that will address their problem, it is Narendra Modi's government at the Centre and Himanta Biswa Sarma's in the state. In several places, they have even given written support and assurance that they are with the BJP," she added. The party enjoys overwhelming support in the urban areas, while this time people in the rural areas too will vote for the BJP, she claimed.

"Development is already taking place during the last ten years and in Assam since 2016. Vast changes have taken place but we are committed to take this journey of development further ahead," Medhi asserted. (PTI)

Rupee falls 5 paise to close at 83.50 against US dollar

MUMBAI, May 6: The rupee pared its initial gains and settled for the day 5 paise lower at 83.50 (provisional) against the US dollar on Monday, weighed down by elevated crude oil prices. Forex traders said a weak trend in domestic equities also dented investor sentiments.

At the interbank foreign exchange, the local unit opened at 83.43, then touched an intra-day high of 83.42 and a low of 83.50 against the greenback. The rupee finally settled at 83.50 (provisional) against dollar, registering a fall of 5 paise over its previous close. On Friday, the rupee inched up 1 paisa to settle at 83.45 against the US dollar. Forex traders said US dollar demand from importers and a recovery in crude oil prices weighed on the rupee.

"We expect the rupee to trade with a slight positive bias on the rise in risk appetite in global markets. However, any recovery in crude oil prices may cap sharp upside. Any renewed geopolitical tensions in the Middle East may also weigh on rupee at higher levels," said Anuj Choudhary, research analyst, Sharekhan by BNP Paribas.

MUMBAI, May 6: Benchmark Sensex closed almost flat in a range-bound trade on Monday as investors booked profits in index heavyweights amid high valuation concerns.

The 30-share BSE Sensex edged up 17.39 points or 0.02 per cent to settle at 73,895.54. The barometer hit a high of 74,359.69 and a low of 73,786.29.

The broader NSE Nifty declined 33.15 points or 0.15 per cent to close at 22,442.70.

From the Sensex basket, Kotak Mahindra Bank jumped 5 per cent after the company reported a 25 per cent growth in its March quarter net profit at ₹ 5,302 crore, limited by a drop in the core income due to narrow interest margins.

Tata Consultancy Services, Hindustan Unilever, Mahindra & Mahindra, Sun Pharma, Tech Mahindra and IndusInd Bank were among the other major gainers. Titan tanked 7 per cent after its March quarter earnings failed to cheer investors.

State Bank of India, NTPC, Power Grid, Bajaj Finance and Larsen & Toubro were the other laggards. The domestic indices traded in a range-bound man-

ner, said Vinod Nair, Head of Research, Geojit Financial Services.

"The broader indices also witnessed major selling pressure due to valuation concerns and profit-booking," he added.

"Today, the benchmark indices witnessed lacklustre activity - the Nifty ends 33 points lower while the Sensex was up by 17 points," said Shrikant Chouhan, Head Equity Research, Kotak Securities.

In the broader market, the BSE smallcap gauge declined 1.06 per cent, midcap index dipped 0.95 per cent. Consumer durables tanked 3.85 per cent. servpower (1.26 per cent), industrials (0.80 per cent) and

Peace, development in focus

but for the general voters the prevailing peace has emerged as a major factor. "Bomb blasts, firings, kidnappings, bandhs were the order of the day. From communal and ethnic clashes to counter-insurgency operations, we have seen it all. It has only been the last few years that we have seen sustained peace," Arjit Das (named changed on request), a local entrepreneur said.

From having to give up his first car to the bank against unpaid instalments as business was bleak at the turn of the century, Das now owns two vehicles and operates several more under his travel agency. Newton Narzary, who runs a hotel near Raimona National Park and also drives a tourist gypsy, shares Das' sentiment.

"It used to be only uncertainty and fear, no matter to which community you belonged to. Let alone tourists, we locals feared to move out alone after dusk. But we have a bustling business now," he said. Most maintain that the return of peace has been possible with the signing of 2020 pact by the Central and the state governments with different Bodo groups, including NDFB, and surrender of almost all major militant groups active in BTR.

While people are thankful for return of peace, issues of 'inequal development' and 'more rights' of the Bodo community are also likely to play on the minds of the non-Bodo voters. In the constituency of nearly 15 lakh voters, Bodos form about 5 lakh of the electorate, while the rest are non-Bodo communities, including different ST groups, religious minorities and general category people.

"Naba Sarania had won by playing the 'non-Bodo card', but he did nothing in 10 years. We won't fall for such gimmicks again, but we will definitely look for someone who will give equal voice to all of us," Pramod Sharma, a retired government official of Basugaon, said. "The first step towards development has been taken with sustained peace. We are now hoping that whoever wins will take it forward," an optimistic Prasenjit, who works in a private firm, added, summing up the aspiration of peace and development of the voters. (PTI)

BSNL to launch 4G services across India in August Using indigenous technology

MR-73687/20 NEW DELHI, May 6: State-owned BSNL will start rolling out 4G services across the country from August, using completely indigenous technology in line with the government's "Atmanirbhar" policy, according to official sources. BSNL officials claimed to have recorded peak speed of 40-45 megabit per second on the 4G network which has been rolled out in the premium spectrum band of 700 megahertz (Mhz) as well as in 2,100 Mhz band during the pilot phase.

The company has rolled out 4G services in Punjab using indigenously developed technology by IT company TCS and state-run telecom research organisation C-DoT-led consortium and onboarded around 8 lakh subscribers. "The 4G core developed by C-DoT is performing very well in the BSNL network in Punjab. It was installed in July last year. It takes 12 month to prove the success of such complex technology but the C-DoT core has stabilised within 10 months. BSNL will launch atmanirbhar 4G technology across the country in August," a senior government official, who did not wish to be named, told PTI.

The core network is a collection of network hardware, devices, and software that provides fundamental services in a telecommunication network. Telecom regulator Trai in a recent paper explained core as part of a network that offers the functionality of aggregation, call control, switching, authentication, charging, gateway functionality, etc.

TCS, Tejas Networks and government-owned ITI have bagged orders worth about ₹ 19,000 crore from BSNL for deploying 4G network which is upgradable to 5G. In a recent earnings call, Tejas Networks Executive Director and chief operating officer Arnob Roy said BSNL's mobile network is getting deployed across zones. He said that wherever the C-DOT core is not available on the BSNL network, the equipment is getting integrated to the existing core. "When the C-DOT core gets deployed in those circles, in those zones, they will get parented to the C-DOT core as well. Tejas Networks Limited." (PTI)

also comprising Justices J B Pardiwala and Manoj Misra, said. The apex court said the decision where the airport should be is a matter of policy but when the law prescribes specific norms for carrying out activities requiring environmental clearance, the provision of law has to be complied with.

"We direct that no activity shall be carried out in breach of the EIA notification, 2006," the bench said after perusing the report filed by the secretary of the District Legal Services Authority of Cachar. Solicitor General Tushar Mehta, appearing for the Assam government, opposed the locus standi of the petitioners and said action should be taken against them. The top court was hearing an appeal filed by Tapas Guha and others against a National Green Tribunal (NGT) order rejecting their plea against the construction of the proposed airport on "specious ground" that it was premature. The plea had sought a direction to cease further action related to the construction of the airport till a comprehensive Environmental Impact Assessment (EIA) is conducted.

The top court had on April 8 directed the Assam government to maintain status quo at the Doloo tea estate. On January 25, the NGT had dismissed the plea by Guha and others on the ground that the EIA report was awaited and environmental clearance for the project had not been granted.

"Counsel for the applicants has drawn our attention to the Government of India, Ministry of Civil Aviation, notification dated May 16, 2008, particularly column under the head 'Environment Clearances' and submits that even for grant of Site Clearance and In-principle approvals, Environmental Clearance is necessary which can only be done once the EIA assessment study is done. "In our opinion, mere inclusion of a clause under the head 'Environment Clearances' in a form of the said notification does not deem the same to be mandatory for purposes of EIA assessment study," the NGT had said.

The plea in the NGT had sought a direction to cease further action at the Doloo tea estate till a comprehensive EIA has been conducted and to restore the estate to its original condition as of May 12, 2022 by replanting uprooted tea bushes, felled shade trees and rectify the damage caused to the landscape and ecosystem.

The Airports Authority of India has submitted an application under the Greenfield Airports (GFA) Policy, 2008 to the Ministry of Civil Aviation (MoCA) for grant of site clearance for developing the airport. 12 female candidates contesting Lok Sabha elections from state Assam LS polls: Decline in women

candidates but female voters outnumber men

GUWAHATI, May 6: Despite the state having more women voters, only 12 female candidates are contesting the 2024 Lok Sabha elections, down from the previous count of 14.

These 12 women candidates are competing in seven out of the 14 Lok Sabha constituencies in the state.

Assam has a total electorate of 2,45,72,144 with 1,23,39,241 women voters and 1,23,25,293 male voters.

This declining trend in women candidates has been continuing since the 2014 polls when there were 16 female aspirants.

The ruling BJP has fielded one woman candidate, Bijuli Kalita Medhi, for the prestigious Guwahati seat, while the opposition Congress has nominated Mira Borthakur Goswami in Guwahati and Roselina Tirkey in Kaziranga.

Among the smaller parties, Gana Suraksha Party has given tickets to two women while Hindu Samai Party, Gana Sangram Parishad, SUCI(C) and Voters Party have given to one each and there are three independents in the fray.

Kaziranga leads with three women candidates, followed by two each in Guwahati and Kokrajhar (ST), and one each in Sonitpur, Darrang-Udalguri, Nagaon, Barpeta, and Dhubri. In the first phase polls, there were four women candidates, two in the second and six in the third and final phase to be held on May 7.

The number of women candi-



dates representing the state in the Lok Sabha so far has been only 18 since the first general elections in the country and this too has been declining with two candidates in 2014 to one in 2019.

There has been, however, a remarkable increase in the participation of women voters in the polling process, registering 79.92 per cent voting in the first two phases for which elections were held on April 19 and 26.

In the first phase of polls held in five constituencies of Upper Assam, women recorded a higher voter turnout of 78.81 per cent as against male voters 77.69 per cent.

In the second phase, also in five seats, women registered 85.55 per cent of votes as against 84.41 per cent by men. Congress candidate from Guwa-

hati Mira Borthakur Goswami pointed out that while her party gave tickets to two women, the BJP, which passed the Women Reservation Bill in Parliament, gave ticket to only one in the North East.

"The BJP government treats women as a vote bank and has instilled fear in them that if they do not vote for BJP or attend election meetings, then their names will be deleted from schemes," she alleged.

Goswami said she is committed to help women participate in the decision-making process and will work for their 'economic safeguard and security'. Goswami, who is locked in a direct contest with another woman candidate Bijuli Kalita Medhi of the BJP, said though the Guwahati seat is not reserved for women, but since 2009 it has been represented by them.

Medhi, on the other hand, claimed that no previous government has focused on women as the BJP during the last ten years by giving them various benefits, including the 'Orunodoi' scheme of giving a monthly amount of Rs

1,250 to women and encouraging entrepreneurship by providing them funds to become 'Lakhpati Baideos' (Lakhpati Elder Sisters).

She pointed out that the BJP enjoys overwhelming support in the urban areas and this time, women in the rural areas are also very happy as they have benefitted immensely from the various schemes initiated by the BJP governments at both the Centre and in the state.

A women activist pointed out that the Women's Reservation Bill was passed in Parliament last September but in the first general elections held since its 'historic scripting', none of the major political parties made an effort to give tickets to women candidates anywhere close to the 33 per cent mark

She said it is indeed a very heartening sight to find long queues of women, including first-time voters and the elderly, outside polling stations, dressed in their best colourful attires, and often outnumbering men in separate queues, but it would have been equally important to see more women candidates in the fray

Prior to the polls, a group of women's organisations in the state had prepared a manifesto for women, highlighting the specific issues to be included in the policies of the next government, but most parties have ignored these and concentrated mostly on doling out usual sops for women, without any concrete measures for their actual economic, social and political empowerment. Road mishap claims life at Rupahi weekly market

HT Correspondent NAGAON, May 6: In a tragic road mishap, a school student died on the spot while two others were seriously injured at the Rupahi weekly market in Nagaon on Monday.

According to sources, the incident took place when a speeding dumper bearing the registration number 'AS 25 EC 8723' mowed down the deceased along with his two schoolmates. The dumper also collided with a motorcycle bearing the registration number 'AS 01 AL 1637'.

The deceased student has been identified as Mahmood Zaman, a resident of the Gunanori village. The injured students have been identified as Ekramul Haque of Gunabori village and Iftikhar Ahmed of Gereki village under Rupahihat Police Station. Soon after the incident the Rupahihat police rushed to the spot and immediately sent the injured students to the Nagaon Medical College Hospital for treatment.

Meanwhile, the body of the deceased was sent to the Nagaon BP Civil Hospital for post mortem.

Police have already seized the dumper and motorcycle and are investigating the matter.

1 dead in accident at Sootea

The incident occurred on May 4 when the victim, Naseed Ali, who had been driving a truck bearing the registration number 'AS 01 GC 1779', rammed his vehicle into the under-construction Ghiladhari bridge on National Highway 15 in Sootea.

Naseed Ali who hailed from Udalguri, died on the spot.

On the other hand, a truck heading from Tezpur towards Biswanath Chariali fell into the Ghiladhari river after it hit the huge railings of the concrete bridge. Grievances of non-Bodo voters over land rights, ST status hold key in Assam's Kokrajhar LS seat

KOKRAJHAR, May 6: The brewing discontent over the absence of land rights and Scheduled Tribe (ST) status among non-Bodo voters could significantly sway the outcome in the Kokrajhar Lok Sabha constituency, situated within Assam's Bodoland Territorial Region.

Despite being represented by Naba Kumar Sarania of the Gana Suraksha Party, the first non-Bodo MP from Kokrajhar, for two consecutive terms, these unmet demands of non-Bodo voters may affect his party's poll fortune in the elections.

Sarania's nomination was rejected this time due to the cancellation of his ST status by the state government, a decision upheld by the Gauhati High Court.

His Gana Suraksha Party (GSP) fielded Binita Deka as an alternative arrangement.

The Trinamool Congress (TMC) is vying to capitalise on absence of a 'strong' GSP candidate by projecting itself as the 'alternative', though the ruling force in BTR, United People's Party Liberal (UPPL), and chief opposition Bodoland People's Front (BPF) asserted that they enjoy the support of all sections of voters.

The Kokrajhar constituency, reserved for Scheduled Tribe (ST), will go to polls on May 7.

'Two-time MP Naba Sarania had played the 'non-Bodo card' to win elections. We don't want such political divisions as we all want to live as Assamese. But since we are living in the Sixth Schedule area, we are at times left with no option but to follow such divisive sentiments," said Amrit Narayan Patgiri, a retired vice-principal of Basugaon Higher Secondary School.

He maintained that the non-Bodo people had rallied behind Sarania in the last two Lok Sabha elections as he had promised land rights and ST status for Koch-Rajbongshis and Adivasi communities but said that "the MP failed to keep any of his assurances".

Lokenath Barman, a former school teacher, claimed that Sarania was taking advantage of a leadership void among the non-Bodo community.

The Bodo community is politically conscious and their leaders have fought for their rights. Though we have a substantial population of non-Bodo communities like Koch-Rajbongshis and Adivasis, there is a lack of political awareness and coordination among leaders," he said.

Barman said that one of the reasons for Koch-Rajbongshis and Adivasis not getting ST status in the state could be that the Scheduled Tribe tag would make them eligible to contest polls in reserved category constituencies like Kokrajhar.

Patgiri and Barman are among many non-Bodo people who expressed disappointment over their unmet demands.

Even though he is not in the fray, Sarania was actively campaigning for the party's candidate and claimed that it would be a hat-trick for the GSP.

n the relentless pursuit of sustainable energy solutions, the global spotlight has shifted to the Lithium Triangle, encompassing Argentina, Bolivia, and Chile. Nestled within the vast Andean landscapes lies the world's largest lithium reserves, housed beneath the shimmering expanse of the Salar de Uyuni. This strategic reservoir of lithium, a fundamental component of lithium-ion batteries, serves as the linchpin for powering the technological innovations defining our era. SC decision on Hindu marriage praiseworthy

B y delivering a major deci-sion on Hindu marriage, the Supreme Court has not only confirmed rites, rituals and traditional customs of Hindu marriage, but has also accepted them as necessary from the legal point of view. Today, when the sanctity, social acceptance and efficacy of Hindu marriage is getting undervalued due to so-called modern life under influence of western culture, there was a dire need to reinforce it.

Those who consider marriage ceremonies just as a registration need to be wary. They have to understand the underlying meaning of taking seven rounds around the altar; without these seven rounds, Hindu customs and wedding ceremonies will not be valid in the eyes of the law. The latest decision of the Supreme Court on Hindu marriage is welcome, and its long-term consequences will be pleasant for society. This decision will reinforce Hindu culture and traditions. The institution of family will get strengthened.

While rendering this decision related to Hindu marriage, the Supreme Court said that marriage is not an occasion just for 'singing and dancing', 'drinking and eating' or for demanding dowry and gifts by exerting undue pressure. Hindu marriage is not a commercial transaction. It is a serious basic cultural and family event which is celebrated to create a relationship between a man and a woman who attain the status of husband and wife for a good family in the future. It is a basic unit of the Indian Hindu social system, which has a strong cultural and religious dimension.

In fact, the Supreme Court has made it clear that Hindu marriage cannot be recognized without taking seven rounds around the altar, that is, the rules and provisions made in the Hindu Marriage Act will have to be followed strictly for solemnizing the marriage. In this way, the Court in its decision has clarified the legal requirements of solemnizing a Hindu marriage under the Hindu Marriage Act 1955.

According to the Act, a Hindu marriage shall be solemnized according to traditional rites, rituals and ceremonies of either party. The ceremonies include Saptapadi (the taking of seven steps jointly around the sacred fire by the bride and groom both); the marriage becomes complete and binding when they take the seventh step together. Overall, Hindu marriage is an institution, a ritual and the marriage is not a commercial transaction.

that Lalit Garg stressed proper rites like Saptapadi (seven rounds around the sacred fire) and associated rituals and ceremonies are necessary for the validity of a Hindu marriage. In case of later disputes between husband and wife, it is

solemnizing of the marriage cere-This effort of the Supreme Court to explain the value of the seven rounds and the ceremony related to it will not only strengthen the institution of Hindu marriage, but will also reinforce the values that are getting blurred in the storm of modernity. There is no doubt that the basic importance of marriage ceremony has reduced in the modern times as compared to the earlier times;

now marriage has become just a show, compulsion or compromise

for many Justice B Nagarathna in her relevant and useful judgment has rightly said that Hindu marriage is a sacrament, which should be given status of an institution of great value in the Indian society. A marriage without traditional rites or rituals like seven rounds around the sacred fire will not be considered a Hindu marriage as per Section 7 of the Hindu Marriage Act. For this reason, the Court has urged young men and women to think deeply about the institution of marriage before entering into it; and to consider how sacred they said institution is in Indian society

The question is why did the Supreme Court need to stress upon Hindu marriage and strengthen Hindu values? In fact, many cases have

> ing the rituals and traditional customs related to Hindu marriage, and every time the court has been presenting its view on the matters related to the institution of marriage with alertness, foresight and prudence.

The Lucknow bench of the Alnecessary to present proof of the lahabad High Court recently held that as per the Hindu Marriage Act, the ceremony of Kanyadaan is not necessary to solemnize a Hindu marriage. The importance of Saptapadi was also shown in that decision. In the decision of a family court of Madhya Pradesh, it was explained to the woman's side that applying vermilion is a religious duty of a married Hindu woman

> A similar attempt at persuasion is reflected in the latest decision of the Supreme Court. Overall, the message of the court is that the

basic meaning of marriage should be understood, while avoiding unnecessary pomp and show. There is now a need for more clarity regarding Hindu marriage and especially to emphasize Hindu rituals and culture; because the family institution continues to exist in India, the reason for this is Hindu values and traditions. In this way, the Court in its decision has clarified the legal requirements and sanctity of Hindu marriage under the Hindu Marriage Act 1955.

Hindu marriage is an ideal tradition and culture. In Hindu religion, marriage is considered one of the sixteen sacraments; Marriage or Vivaah, hence its literal meaning is to bear special responsibility. The marriage ceremony is commonly known as Hindu marriage. In other religions, marriage is a kind of contract between husband and wife which can be brocourt's ken under special circumstances, but Hindu marriage is a relationship between husband and wife for many births which cannot be broken under any circumstances. By taking seven rounds of sacred fire and keeping the Pole Star as witness, the two bodies, mind

and soul get tied in a sacred bond. It is also a union of two families. In Hindu marriage, there is more spiritual relationship between husband and wife than physical relationship and this relationship is considered extremely sacred. Hindu marriage not only con-

tains family, social and cultural significance, but it also has deep spiritual significance. Hinduism has prescribed four purusharthas (four basic pursuits of life), i.e. Dharma, Artha, Kama and Moksha. The purpose of the marriage

ceremony is to complete the effort of 'Kama' and then gradually move towards 'Moksha'

Many important things in the life of a man and woman are associated with marriage; for example, love between man and woman, their relationship, children, their parents, various happy events falling in course of their life, social status and prosperity.

In Hindu society, a married woman is viewed with utmost respect. The sight of a woman with kumkum-sindoor on her forehead, wearing a mangalsutra around her neck, green bangles, toe rings and a six or nine-yard saree automatically generates respect for her in the mind of an observer.

Of the seven Hindu marriage vows, there are at least three where the couple promises to take care of their elders. The fifth promise is to have children and take care of them.

In recent years, many anomalies and distortions have been added to the Hindu marriage tradition and culture in India. With the introduction of dating culture. the prevalence of love marriage has increased. Potential brides and grooms prefer to choose life partners on their own. Today's romantic relationships are not actually marriage, but a new practice, which has the opposite effect of disintegrating the family institution.

Along with marriage, the practice of pre-wedding has also become the carrier of many distortions, big grand events and hotel culture has also blurred the sanctity of marriage. Widespread use of alcohol and other drugs at events has also become a cause of accidents. Due to which cracks are seen appearing in marriage bonds even before it takes place. Regular workers' real wages declined by one percent every year

egular workers' real wages have been declining by one per cent every been deciming by one per com-year under Prime Minister Narendra Modi's regime. However, BJP's election manifesto and Modi's guarantees have left this issue untouched, and used the word "wages" only twice, while giving the guarantee of periodic review of national floor wages. There is no guarantee of protection from declining real wages.

International Labour Organisation (ILO) and the Instituted for Human Development (IHD) has calculated in their recently published study that over the decade until 2022, the average monthly real earnings of salaried workers in India declined by 1 per cent every year (CAGR) since 2012. Regular monthly real wage in 2012 was ₹ 12,100 which came down to ₹ 11,155 in 2019, and ₹ 10,925 in 2022. The decline was 1.2 per cent yearly upto 2019, and then along with only a small increase in real wages for casual workers in India, indicates

that the quality of employment generation was poor between 2000 and 2022. The average real monthly earnings for both youths and adults engaged in regular salaried work and self-employment remained nearly stable or declined between 2012 and 2022, whereas the average real wages of those involved in casual work had a small increase. This trend underscores a high incidence of low earnings and lowpaying employment among youths in the labour market. There was annual growth in real monthly earnings for youths in regular employment, of 0.4 per cent, between 2012 and 2022, while average earnings for adults experienced a negative annual growth, at -1.6 per cent, over the same period.

Likewise, average real earnings in selfemployment for both youths and adults showed negative growth, at -0.7 per cent and -0.4 per cent annually. But monthly

The gender gap was very wide in 2023, when male youth casual workers earned ₹ 5345. Regular male workers were earning ₹ 7913 in 2023, which was less than female youths. Self-employed males were earning ₹ 7082 per month in 2023.

Modi government can't deny this data since these data are taken from government data only, including the Periodical Labour Force Surveys (PLFS). "While wages of casual labourers maintained a modest upward trend during 2012-22, real wages of regular workers either remained stagnant or declined.

Self-employed real earnings also declined after 2019. Overall, wages have remained low. As much as 62 percent of the unskilled casual agriculture workers and 70 per cent of such workers in the construction sector at the all-India level did not receive the prescribed daily minimum wages in 2022," the India Employment Report 2024 has stated

It is in this backdrop BJP's manifesto has attracted sharp criticism from Central Trade Unions. CITU president K Hemalata has pointed out that Modi's Guarantee does not even talk about minimum wages for workers, and even the guarantee of floor level wages given is not enough. The said that floor level wages to be periodically increased, but as we know the BJP government have increased it from ₹ 176 to ₹ 178 between 2017 and 2019.

The manifesto even does not talk about scrapping of the four labour codes, for which the entire trade unions have been demanding. It means if BJP will return to power, it would be implementing the labour codes and the labour rules, and would attack on the basic rights of the workers.

BJP manifesto has nothing for women workers, scheme workers, not even recognition as worker to scheme workers and their minimum wages and gratuity as Supreme Court has ruled. On the whole the BJP's manifesto has left workers out. Workers have therefore been campaigning against BJP and PM Narendra Modi in the elections, fearing that if PM and BJP return for the third term they would implement the labour codes which they fear may bring economic slavery for them, and would be compelled to accept lower wages on which their working poverty would increase further. They fear that PM Modi would implement the codes in the name of labour reform in favour of corporate sector and ease of doing business for them at the cost of workforce. Informal workers, who constitute over 90 per cent of the total workforce, fear that they would suffer the most if it happens. (IPA Service)

he Tories are imploding. That is the story of local election results following the polls to the councils throughout Britain, hundreds of Conservative seats lost, and gains for Labour, the Liberal Democrats and the Greens.

Keir Starmer savs Rishi Sunak should take the hint and call a general election. Pressure should be put on the Tories to do so, though many of their MPs may be keen to postpone, while they can, the reckoning they so richly deserve.

It's traditional to talk of failing prime ministers as "lame ducks." Sunak has more than once been compared to one, and there is no shortage of Tories saying the government has lost its sense of purpose. Unfortunately that isn't true. The Conservatives may be headed for disaster but they retain a big parliamentary majority, and they're using it. Repressive legislation has barely let up since 2019, as citizens' rights to protest, strikes and free speech are ripped up.

More may be on its way: the unelected advisers on extremism and political violence have been lobbying for bans on protest outside Parliament, MPs' offices and council chambers, and for tougher crackdowns on Palestine solidarity and non-conforming media. Time may be running low, but as we saw with passage of the disgraceful Rwanda deportations law, the government is not above fast-tracking highly controversial legislation. Even now a Bill to criminalise homelessness, as cruel as it is absurd, is making its way through the Commons

So the Tories need to be stopped, and the sooner the better. The longer they are in office the worse things will get. The case to do so is not weakened by the reality that Starmer's Labour is on board with most Tory policy. Labour has been marching right in the wake of the Tories.

Its commitment to retain Tory anti-protest laws, its hints that it might even keep the Rwanda deportations, underline the need to stop the Tories passing yet more reactionary legislation Labour

would simply keep. The attacks on British democracy are cross-party,

and Starmer plays a key role in them, but he will find it easier to avoid reversing Tory laws than to pass new ones. So "Tories out!" remains a rallying cry across the left. We should also note where

Labour has done badly: particularly in areas with high Muslim populations. The loss of Oldham council is a case in point. We will not know till tomorrow who has won the West Midlands mayoralty. but Labour has been briefing the BBC it expects a loss with a "senior party source" putting a typical imperialist, indeed racist, spin on

losing votes to a Palestine solidarity candidate: "It's the Middle East, not the West Midlands, that will have won [Tory] Andy Street the mayoralty. Once again Hamas are the real villains."

The anonymous briefing oozes contempt for voters protesting at Labour complicity in genocide. But the lesson is that Palestine matters, and should encourage the No Ceasefire, No Vote movement to demand more from Labour representatives if they wish to avoid challenges

Finally, Britain's mass media tend to treat local elections as omens, which experts pick over to predict general election outcomes, rather than of significance in themselves. That reflects the loss of real authority by councils, their lack of financial autonomy and limited ability to make a difference on the ground.

But we face devastating cuts to local services in coming months, in every corner of the country: and local government needs to start fighting back for the communities it represents. We have seen too many sorry examples of cuts, punitive attacks on the poorest and even union-busting from Labour councils to imagine electing them means winning the battle.

A mass, grassroots movement to see off cuts and force the hand of councils and government alike, much like that being planned in Birmingham by the Brum, Rise Up! alliance of unions and campaigns, needs to start taking shape. (IPA Service)

0.7 per cent as of 2022. In 2023, the average monthly real wage for adults further declined to \gtrless 10.790.

Similarly, the average monthly real earnings of self-employed individuals declined annually by 0.8 per cent, from 7,017 rupees in 2019 to 6,843 rupees in 2022. In 2023, earnings of self-employed have marginally increased to ₹ 7,060. The average real monthly earnings of casual workers increased by 2.4 per cent annually, from 3,701 rupees in 2012 to 4,364 rupees in 2019, and by 2.6 per cent annually, to 4,712 rupees in 2022. However their earnings have declined to ₹4671 in 2023.

The declining real earnings of regular salaried workers and the self-employed, earnings in casual work grew at an annual rate of 2.6 per cent for youths and 2.4 per cent for adults over the same period.

There was a gender gap in real earnings for youths in casual work, but it narrowed over the years. Female youths' real earnings and wages in self-employment and casual work declined, 'while male youths' real earnings in self-employment increased marginally and real wages in casual work remained stable.

The real earnings for regular salaried workers declined for both men and women between 2022 and 2023. Female youth casual workers' real earning declined from ₹ 3374 monthly in 2022 to ₹ 3,017 per month in 2023, regular workers' from ₹ 9,281 to ₹

In 2022, regular workers earned an average of 19,010 rupees per month, followed self-employed individuals earning 11,973 rupees and casual workers earning 8,267 rupees. As against ₹ 20,033 per month earning for male regular workers, self-employed male workers earned ₹ 13,386 and casual male workers earned ₹ 9,086 only. For female workers these figures were ₹ 15,398, ₹ 5,424, and ₹ 5.548 respectively. The gender gap in the average monthly earnings was thus well pronounced, which has widened in the case of earnings for casual work and self-employment.

As a crucial player in the region, the United States has unequivocally stated its position-a dedication to nurturing enhanced collaboration and stability that transcends historical rifts and ideological differences. This commitment signals a pivotal step towards fostering a more harmonious and secure future for all involved.

Central to this equation is the evolving relationship between the United States and Saudi Arabia-a relationship marked by a convergence of interests and a shared vision for the future. xperts often highlight social - media and harsh economic times as key reasons why young people are getting unhappier. And while those factors are important, I would like to emphasise another.

Younger generations have less freedom and independence than previous generations did. The area where children are allowed to range unsupervised outside has shrunk by 90% since the 1970s.

Parents increasingly organise entertainment – ranging from play dates and sports and music classes to family cinema trips – for their children, rather than letting them come up with it themselves. Perhaps this can help explain recent reports that many teenagers today choose to be holed up in their bedrooms.

The lack of childhood freedom isn't just a result of parental control. Societal expectations and school policies also have huge influences.

It is important to note that constraints to freedom often stem from well-meaning intentions, such as safety concerns (location tracking, for example) or cultural norms. Understandably, nobody wants to be the parent who lets their kid take (perceived) risks if others don't. But there are risks to over-protecting children too. It can inadvertently hinder their psychological development.

Emotional, social cognitive effects Psychologist Jean Piaget emphasised the importance of exploration and experimentation in cognitive development in the 1950s. He noted that children construct their understanding of the world through active engagement with their environment. By restricting children's freedom to explore and take age-appropriate risks, we deprive them of opportunities for intellectual curiosity and innovation.

A lack of independence can undermine young people's sense of agency and control over their lives. And research in psychology consistently demonstrates that when people, young or old, feel powerless and constrained by external forces, such as parental supervision or societal expectations, it can lead to frustration, helplessness and low self-esteem.

Moreover, the absence of autonomy limits young people's opportunities for self-discovery, creativity and personal growth. When children are constantly guided and supervised, they miss out on the invaluable experiences of problemsolving, decision-making and learning from mistakes.

The decline in independence can have

velopment. Children may get love, support and attention within the family unit. But spending too much time with parents may lead to difficulties getting on with peers, who don't provide the same unconditional love and support.

Indeed, when children are constantly surrounded by adults and structured activities, they may struggle to develop meaningful relationships, assertiveness and resilience. Research highlights the importance of peer interactions in shaping social competence and emotional intelligence. After all, parents may not require you to empathise with them, but friends will.

By orchestrating play dates and entertainment, parents may therefore inadvertently limit their children's ability to navigate social dynamics. This will include learning empathy and developing interpersonal skills independently.

It will also set an expectation that children will come to internalise the idea that "parents will do things so I don't

> gagement. Humans need to be engaged in activities that challenge and absorb our attention, leading to feelings of fulfilment and happiness. When children are constantly enter-

tained and supervised, they may struggle to find activities that naturally capture their interest and provide a sense of purpose and enjoyment.

This is important. In defining happiness, positive psychology emphasises both the emotional aspect, such as experiencing positive emotions, and the cognitive aspect, which involves a sense of overall satisfaction with one's life, including meaning and purpose.

Research has shown that parenting that supports autonomy, encouraging children to make their own decisions and take responsibility for their actions, is linked to better psychological wellbeing in adolescents. Conversely, excessive parental control is associated with higher levels of emotional distress and lower

levels of life satisfaction among adolescents.

The school environment also plays a significant role. Zero-tolerance policies. strict disciplinary measures and standardised testing are commonplace. But overly strict and punitive disciplinary practices are associated with decreased intrinsic motivation and academic engagement among students.

Recent developments in response to safety concerns, such as increased surveillance and monitoring within schools, further intrude upon students' autonomy and independence. Metal detectors, security cameras and random searches ultimately create an atmosphere of surveillance and control.

Age-appropriate freedom

Evidence supports the idea that freedom and independence is crucial for the happiness and wellbeing of young people

There are ways to let your children have age-appropriate freedoms. A fiveyear-old, for example, can be allowed

> and encouraged to butter their own toast, make their bed, or play on their own in the garden. А 10-

year-old, meanwhile, should be able to

be responsible for their homework and keep their space tidy. And when children reach the age of 15, you can encourage them to cook a family meal, do laundry and arrange travel to school, clubs or friends' houses independently rather than be chauffeured by their parents.

It can also be useful to decline to provide entertainment from time to time, letting them work something out on their own. Children are wonderfully creative and if there is nothing to do, they will often think of something eventually. This could even apply to play dates. It is OK to invite a child's friend over with no specific entertainment in mind.

Moving forward, it is essential to promote environments that foster autonomy, self-expression and independent learning, both at home and in educational institutions, to support the development and happiness of young people. (Courtesy: Scroll.in)



This article reviews natural remedies that may help treat a cough. It is important to remember that the Food and Drug Administration (FDA) does not monitor herbs and supplements, so people who use them may be at risk of using low quality products with impurities.

People who want to try natural remedies to treat their cough should consider researching sources and brands. Additionally. some herbs and supplements can interfere with medications, which may result in unwanted side effects. It is best to consult a doctor before taking supplements.

12 natural cough remedies

People use a range of natural remedies to treat a persistent cough. While they may help some people, it is important to note that some of the following remedies have limited evidence to support their use.

This means a person may or may not find that the remedies work for them.

1. Honev

According to research, honey may relieve a cough. In a 2021 review of studies, researchers looked at the effect of using honey to treat coughs in upper respiratory infections.

The researchers found that honey was superior to usual care, both in suppressing the cough and in helping prevent the need for antibiotics.

In another study, researchers compared honey with dextromethorphan, a common cough suppressant.

The researchers found that both honey and dextromethorphan worked to suppress coughs. They noted that honey scored slightly higher in one trial and on par with dextromethorphan in another. A person can use this remedy by swallowing a spoonful of honey or adding it to a hot drink, such as an herbal tea.

2. Ginger

Ginger may ease a dry or asthmatic cough, as it has anti-incoughs. A study from 2015 examined 10 different natural products used in traditional Asian medicines, including ginger.

The researchers found that ginger and other remedies, including honey, have played a continued role in traditional medicine.

While a long history of use can have valuable implications for a treatment's effectiveness, the researchers noted that their study may provide future researchers with a place to start when examining natural solutions to coughs. People often add ginger to

dishes or drink it in tea. However, in some cases, ginger tea can cause stomach upset or heart-

3. Hot fluids

While current research is lacking, an older study from 2008Trusted Source showed that drinking liquids at room temperature may alleviate a cough, runny nose, and sneezing.

However, people with additional cold or flu symptoms may benefit from warming up their beverages. The same study reports that hot beverages alleviate even more symptoms, including a sore throat, chills, and fatigue.

The symptom relief was immediate and remained for a continued period after finishing the hot beverage. Hot beverages that may be comforting include:

- clear broths
- herbal teas · decaffeinated black tea
- warm water
- · warm fruit juices
- 4. Steam

A wet cough, which is one that produces mucus or phlegm, may improve with steam. To try this method, a person should take a hot shower or bath and allow the bathroom to fill with steam. They should stay in this steam for a few minutes until symptoms subside. They can drink a glass of water afterward to cool down and prevent dehydration.

Alternatively, people can make a steam bowl. A person can do this by:

• filling a large bowl with hot water

• adding herbs or essential oils, such as eucalyptus or rosemary,

which traps the steam so the person can breathe it in

• breathing in the steam for about 10–15 minutes

A person may find steaming helpful when done one to two times per day. While many believe steam will help with cough and other symptoms, not all evidence supports this. For example, a 2017 study looking at the use virus. of steam for common cold symptoms found that it did not noticegargle by: ably improve a person's symptoms. into a cup of warm water until it

5. Marshmallow root

Marshmallow root is an herb with a long history of use as a treatment for coughs and sore throats. The herb can ease irritation resulting from coughing because of its high mucilage content. Mucilage is a thick, gluey substance that coats the

throat. One older, small study found that an herbal cough syrup containing marshmallow root, along

with thyme and ivy, effectively relieved coughs resulting from common colds and respiratory tract infections.

After 12 days of taking the syrup, 90% of the participants rated its effectiveness as good or very good. In a 2020 in vitro study, researchers also noted the coating effect of marshmallow root extract. They found that the root ex-

tract has antioxidative and antiinflammatory properties and provided similar relief to diclofenac, a nonsteroidal anti-inflammatory medication.

Marshmallow root is also available as a dried herb or a bagged tea. A person should add hot water to either and then drink it immediately or allow it to cool first. The longer the marshmallow root steeps in the water, the more mucilage will be in the drink.

Side effects can include stomach upset, but it may be possible to counter this by drinking extra

11. N-acetylcysteine (NAC) NAC is a supplement that comes from the amino acid Lcysteine. Taking a daily dose may lessen the frequency and severity of a wet cough by reducing mucus in the airways.

A meta-analysis of 13 studies suggests that NAC can significantly and consistently reduce symptoms in people with chronic bronchitis.

Chronic bronchitis is a prolonged inflammation of the airways that causes mucus buildup, a cough, and other symptoms.

The researchers suggest a daily dose of 600 milligrams (mg) of NAC for people without airway obstruction and up to 1,200 mg where there is an obstruction.

NAC can have severe side effects, including hives, swelling, fever, and difficulty breathing. Anyone considering this approach should speak with a doctor first.

12. Probiotics

Probiotics do not directly relieve a cough, but they may boost the immune system by balancing

the bacteria in the gut. A healthy immune system can help to fight off infections that may be causing the cough.

One type of probiotic, a bacteria called Lactobacillus, provides a modest benefit in helping prevent the common cold, according to an older study published in 2013.

Another meta-analysis published in 2016 found that taking probiotics helped reduce the number of times children came down with respiratory tract infections, which could indirectly reduce coughing. Supplements containing Lac-

tobacillus and other probiotics are available at health and drug stores.

Israeli army tells Palestinians to evacuate parts of Rafah ahead of an expected assault

JERUSALEM, May 6: The Israeli army on Monday ordered tens of thousands of people in the southern city of Rafah in the Gaza Strip to begin evacuating, signaling that a long-promised ground invasion could be imminent.

The announcement complicated last-ditch efforts by international mediators, including the director of the CIA, to broker a cease-fire. Hamas and Qatar, a key mediator, have warned that an invasion of Rafah could derail the talks

Israel has described Rafah as the last significant Hamas stronghold after seven months of war, and its leaders have repeatedly said they need to carry out a ground invasion to defeat the Islamic militant group.

Lt. Col. Nadav Shoshani, an army spokesman, said some 100,000 people were being ordered to move to a nearby Israel-declared humanitarian zone called Muwasi. He said Israel was preparing a "limited scope operation" and would not say whether this was the beginning of a broader invasion of the city. But last October following the unprecedented Oct. 7 attack on southern Israel by Hamas, Israel did not formally announce the launch of a ground invasion that continues to this day.

The move comes a day after Hamas militants carried out a deadly rocket attack from the Rafah area that killed three Israeli soldiers.

Shoshani said Israel published a map of the evacuation area, and that orders were being issued through air-dropped leaflets, text messages and radio broadcasts. He said Israel has expanded humanitarian aid into Muwasi, including field hospitals, tents, food and water.

it would act with "extreme force" against militants, and urged the population to evactance uate immediately for their safety.

Israel's plan to invade Rafah has raised global alarm because of the potential for harm to more than a million Palestinian civilians sheltering there.

About 1.4 million Palestinians - more than half of Gaza's population - are jammed into the town and its surroundings. Most of them fled their homes elsewhere in the territory to escape Israel's onslaught and now face another wrenching move, or the danger of facing the brunt of a new assault. They live in densely packed tent camps, overflowing U.N. shelters or crowded apartments, and are dependent on international aid for food, with sanitation systems and medical facilities infrastructure crippled.

The U.N. agency that has helped millions of Palestinians in Gaza and the West Bank for decade, known as UNRWA, warned Monday of devastating consequences of a Rafah offensive, including more civilian suffering and deaths. The agency said it would not leave but stay in Rafah as long as possi-

ble to continue providing lifesaving assis-

The United States, Israel's closest ally, has repeatedly urged Israel not to carry out the invasion, saying it does not have a credible plan to protect civilians

But even as the U.S., Egypt and Qatar have pushed for a cease-fire agreement, Prime Minister Benjamin Netanyahu repeated last week that the military would move on the town "with or without a deal" to achieve its goal of destroying the Hamas militant group.

On Monday, Netanyahu accused Hamas of "torpedoing" the hostage deal and not budging from its "extreme demands" while vowing to stop the militants from retaking control of Gaza.

On Sunday, Defense Minister Yoav Gallant claimed Hamas wasn't serious about a deal and warned of "a powerful operation in the very near future in Rafah." His comments came after Hamas attacked Israel's main crossing point Sunday for delivering assistance, killing three soldiers.

Shoshani would not say whether the up-

coming Rafah operation is a response to Sunday's killing. He said the incident would have no effect on the amounts of badly needed aid entering Gaza because other crossing points remain operational.

He wouldn't comment, however, on U.S. warnings not to invade and wasn't clear on whether the evacuation was coordinated with Egypt. Egypt, a strategic partner of Israel, has said that an Israeli military seizure of the Gaza-Egypt border — which is supposed to be demilitarized — or any move to push Palestinians into Egypt would threaten its four-decade-old peace agreement with Israel. In Rafah, people received flyers Monday

morning in Arabic detailing which neighborhood blocks needed to leave and where humanitarian zones had expanded to. The flyers said that aid services would spread from Deir al Balah in the north to the center of Khan Younis city in the middle of the Gaza Strip.

Palestinians in Rafah said people gathered to discuss their options after receiving the flyers. Most said they did not want to move alone and preferred to travel in groups.

"So many people here are displaced and now they have to move again, but no one will stay here it's not safe," Nidal Alzaanin told The Associated Press by phone.

Alzaanin, a father of five, works for an international aid group and was displaced to Rafah from Beit Hanoun in the north at the start of the war. He said people are concerned since Israeli troops shot at Palestinians as they moved during previous evacuation orders

Alzaanin said he has packed his documents and bags but will wait 24 hours to see what others do before relocating. He said he has a friend in Khan Younis whom he hopes can pitch a tent for his family. (AP)

Russia announces nuclear weapon drills after angry exchange with senior Western officials

KYIV, May 6: Russia plans to hold drills simulating the use of tactical nuclear weapons, the Defense Ministry announced on Monday, days after the Kremlin reacted angrily to comments by senior Western officials about the war in Ukraine.

The drills are in response to "provocative statements and threats of certain Western officials regarding the Russian Federation," the Defense Ministry said in a statement.

It was the first time that Russia has publicly announced drills involving tactical nuclear weapons, though its strategic nuclear forces regularly hold exercises. Tactical nuclear weapons have a lower yield compared to massive warheads that arm intercontinental ballistic missiles intended to obliterate entire cities

The announcement appeared to be a warning to Ukraine's Western allies about becoming more deeply involved in the more than two-year war. Some of Ukraine's Western partners have previously expressed concern about stoking the war amid fears it could spill beyond Ukraine and into a conflict between NATO and Russia.

French President Emmanuel Macron repeated last week that he doesn't exclude sending troops to Ukraine, and U.K. Foreign Secretary David Cameron said Kyiv's forces will be able to use British long-range weapons to strike targets inside Russia.

The Kremlin branded those comments as dangerous, heightening tension between Russia and NATO.

The war already has placed significant strain on relations between Moscow and the West. Tactical nuclear weapons include

air bombs, warheads for shortrange missiles and artillery munitions and are meant for use on the battlefield.

The ministry said the exercise is intended to "increase the readiness of non-strategic nuclear forces to fulfill combat tasks" and will be held on President Vladimir Putin's orders. The maneuvers will involve missile units of the Southern Military District along with the air force and the navy, it said.

Meanwhile, Ukrainian drones hit two vehicles Monday in Russia's Belgorod region, killing six people and injuring 35 others, including two children, local authorities said, in an area frequently struck by Kyiv's forces in recent months.

One of the vehicles was a minibus that was carrying farm workers, Belgorod Gov. Vyacheslav Gladkov said.

No other details were immediately available, and it was not possible to independently confirm the report from the border region.

While Ukraine's army is largely pinned down on the 1,000-kilometer (600-mile) front line due to a shortage of troops and ammunition after more than two years of fighting, it has used its long-range firepower to hit targets deep inside Russia. The apparent aim is to disrupt Russia's war logistics system by hitting oil refineries and depots, and unnerve the Russian border regions. (AP)

Rafael Mariano Grossi already has warned Tehran has enough uranium enriched to near-weaponsgrade levels to make "several" nuclear bombs if it chose to do so. He has acknowledged the agency can't guarantee that none of Iran's centrifuges may have been peeled away for clandestine enrichment.

Panama's new president-elect, José Raúl Mulino, was a late entry in the race



PANAMA CITY, May 6: José Raúl Mulino said he was practically retired from politics just over six months ago. Now, he'll be Panama's president for the next five years.

Standing before a pack of supporters Sunday night, Mulino said: "I never imagined this."

In a historic and tumultuous election, preliminary results put Mulino on top to lead the normally sleepy Central American nation through a moment of political tension, historic migration and a struggling economy.

The 64-year-old lawyer, whose last position in politics was as minister of security in then President Ricardo Martinelli's 2009-2014 administration, was initially tapped by the popular former leader to be his running mate after Martinelli's wife declined. But then Martinelli was disqualified from running after he was sentenced to more than 10 years in prison for a money laundering conviction. Mulino took his place, and ended up winning Sunday's presidential election with 35% of the vote and a nine-point lead over his nearest opponent after dodging constitutional challenges to his own candidacy.

The president-elect got there with strong support from Martinelli, arguably the most important tool in Mulino's campaign as he rode the fiery ex-leader's popularity to victory.

charisma, the economic boom seen under his ally pushed many voters to support Mulino at a time that Panama's economy has lagged.

The former president, who has been sheltering in the Nicaraguan Embassy since February after receiving political asylum, said his trust for Mulino dates back 30 years.

"Mulino seems a little tough, but he is a good guy, serious, and is the only one prepared to take on this great challenge and knows how the economy works to lift the country," Martinelli said in a video broadcast to supporters at Mulino's campaign close.

A maritime law attorney who graduated from Tulane University in New Orleans, Mulino became known as a private business leader who took part in a civil movement against the dictatorship of Gen. Manuel Antonio Noriega, who was ousted by an American invasion on Dec. 20, 1989.

He acted as vice minister of foreign affairs in the 1989-1994 administration of President Guillermo Endara, who took office after the fall of Noriega and the end of the Panamanian military regime. Mulino later remained in charge of the country's international policy in the last part

of that administration. Mulino remained active in politics and more than a decade later backed Martinelli in the election that the supermarket magnate won in 2009. Mulino was appointed minister of the interior and justice, later taking the reins of the public security office.

Danish King Frederik and his Australian-born wife visit Sweden on their first official trip abroad

COPENHAGEN, May 6: Denmark's King Frederik X arrived in Stockholm on Monday with his Australian-born wife Queen Mary, as they begin their first official visit abroad as new Danish monarchs. The 55-year-old Frederik was proclaimed king on Jan. 14 after his 83-yearold mother, Queen Margrethe II, who was Europe's longest-reigning monarch, abdicated.

In the Swedish capital, Frederik and Mary were first greeted by Crown Princess Victoria and her husband Prince Daniel, who boarded the Danish royal yacht Dannebrog. They then took the gilded Swedish Royal Barge to shore and were welcomed there by King Carl XVI Gustaf, Sweden's longest-reigning monarch, and German-Brazilian-born Queen Silvia. The welcome also included a cannon salute and music by Sweden's



Roval Guards, lined up on the quay at the foot of the Swedish royal palace.

Relations between the two royal houses are close. Frederik's grandmother, Queen Ingrid who died in 2000, was a Swedish princess. The May 6-7 visit includes meetings with Swedish Prime Minister Ulf Kirstersson and the speaker of the Swedish Parliament. A visit to a military facility is also scheduled.

Danish government members also ac-

companied the royals, among them Defense Minister Troels Lund Poulsen and Foreign Minister Lars Løkke Rasmussen. Danish monarchs, whose roles are cer-

emonial, traditionally travel to other Scandinavian countries first. Although Frederik had a solo visit to Poland in January, it was planned before his mother's surprise New Year's Eve abdication.

Later this month, Frederik and Mary will travel to Oslo, where they will be greeted by King Harald V and Queen Sonja. Frederik's mother was t he first Danish monarch to voluntarily relinquish the throne in nearly 900 years, causing the Nordic nation to experience its first royal succession in more than a half century. International Space Station, marking what could be a momentous and long-awaited victory for the beleaguered Boeing programme. The scheduled lift-off is set for 22:34 local time on Monday) "We are all here because we are all ready. Williams as saying The mission has been delayed for several years because of setbacks in the spacecraft's development.

and Starliner flying regularly — is one for which the US space agency has long waited. "Design and development is hard — particularly with a human space vehicle," said Mark Nappi, vice president and Starliner programme manager at Boeing, during a Thursday news briefing. "There's a number of things

Chad holds presidential election after years of military rule N'DJAMENA, May 6: Voters in Chad headed to the

polls on Monday to cast their ballot in a long delayed presidential election that is set to end three years of military rule under interim president, Mahamat Deby Itno.

Deby Itno seized power after his father who ran the country for more than three decades was killed fighting rebels in 2021. Last year, the government announced it was extending the 18-month transition for two more years, which provoked protests across the country

There are 10 candidates on the ballot, including a woman. Analysts say Deby Itno is expected to emerge among the front runners. The main opposition figure Yaya Dillo, the current president's cousin, was killed in February in circumstances that remain unclear. "For years now, we've had to cope with the high cost of living, without any solution," said Adoumadji Jean, a teacher at a state secondary school in Moyen-Chari province, in an interview with The Associated Press. "We want a change this year through this election", he added.

Along with high food prices partly caused by the war in Ukraine, Chad has absorbed a wave of over half a million refugees from neighboring Sudan, and is dealing with a threat from the Boko Haram insurgency spilling over from its southwestern border with Nigeria. Boko Haram launched an insurgency more than a decade ago against Western education and seeks to establish Islamic law in Nigeria's northeast. The insurgency has spread to West African neighbors including Cameroon, Niger and Chad.

In March, an attack the government blamed on Boko Haram killed 7 soldiers, reviving fears of violence in the Lake Chad area after a period of peace following a successful operation launched in 2020 by the Chadian army to destroy the extremist group's bases there. Schools, mosques and churches reopened and humanitarian organizations returned.

Human rights groups have called for an investigation in to the killing of Chad's main opposition figure, Dillo. The government has said Dillo was killed during an attack on the the National State Security Agency by his group, known as The Socialist Party Without Borders. But a photo of Dillo showed he was killed by a single bullet wound to the head.

Human Rights Watch said the killing raised serious concerns about the environment for the election.

"With his most significant opponents either coopted or eliminated, and critical electoral institutions stacked with his supporters, Déby Itno's victory is all but certain," wrote Michelle Gavin for the Council of Foreign Relations, a Washington DC based think tank. (AP)

Tripura to plant five lakh saplings to increase forest coverage: Forest minister

Tripura police find breakthrough 483 houses affected due to storm in Meghalaya in BRS club sec murder case

GUWAHATI, May 6: Tripura Police have arrested a 22-yearold woman in connection with the murder of Durga Prasanna Deb (alias Viki Deb), secretary of the prominent Bharat Ratna Sangha club.

The arrested woman has been identified as Sushmita Sarkar. Her arrest follows the arrest of Pradyut Dhar Chowdhury, 65. Deb was shot dead at point-blank range inside his car on April 30 near Shalbagan.

Police suspect the killing is linked to a dispute between rival

groups within the club.

Deb's body was taken to a private hospital mortuary. Sarkar and Chowdhury were both remanded to police custody for further investigation.

The police suspect the masked assailant approached Deb's car, demanded he lower the window, and then fired three shots at close range

The Tripura West District Superintendent of Police, Kiran Kumar, suggested the murder stemmed from an existing enmity between local factions of the club.

People throng stores to buy metal roofing sheets in Manipur

Incessant rain leads to replacement of existing roofing

IMPHAL, May 6: Barely a day after unprecedented heavy hailstorm caused widespread destruction of roofs, people queued up at hardware stores to buy metal roofing sheets.

Manipur witnessed widespread devastation as a powerful storm and fierce hailstorm accompanied by heavy rain caused widespread destruction, leaving roofs of dwelling houses and other structures with perforated roofs, needing immediate replacement.

With the affected people rushing, besides having a briskly business, the hardware shops dealing with tin sheets across Imphal and its outskirts faced stock exhaustion.

Similar situations were witnessed in almost all the markets across the regions affected by the natural fury.

The scenes at the hardware stores where the staff have to deal with the customers even by issuing tokens so that they could deal with them on a first come first serve basis.

The system made it easier for the staff to deal with the customers. However, the customers were apprehensive of stock exhaustion before their turn as they would need the roofing sheet urgently.

The scenes at the hardware stores have also drawn the attention of the



many organisations if the dealers hike the prices of the roofing materials taking advantage of the sudden raise in the demands.

Members of some organisations visited and checked the store for both price hike and stock positions. They also appealed to the dealers not to take advantage of the prevailing grim situation. In the meantime, the Manipur gov-

ernment has authorized the deputy commissioners of each district to monitor the prices of the roofing materials including CGI sheets to ensure availability at reasonable rates.

Following the order of the consumer affairs, food and public distribution (CAF&PD), the deputy commissioner of Imphal West district today issued a set of regulations which came into ef-

fect with immediate effect for a week. In the order, the DC said that the steps were being taken up considering the urgent need for proper rationalization of all the available roofing materials in the district and also ensuring that it reaches to all the genuinely affected family members.

As per the regulations, all whole-sellers, retailers and shops by any nomenclature shall remain open on all days including holidays and Sunday.

The stock position, brand, thickness and prices shall be affixed outside their shop/establishment for general awareness. A copy of the same shall have to be made available to the DC, Imphal West through DSO, CAF and PD.

The rates of April 30, 2024 (or lower rates, wherever possible) shall be used as the market rate/price of the material.

No bulk purchase/buying, including by private parties, shall be allowed in any of the centre/shops/establishments.

All sales shall be only for the hailstorm affected families and details of the sales to be indicated in the records of the establishment.

The order further stated that the district supply officer of the CAF & PD and representative of district SP shall monitor the entire operation of the shop/establishment in the district. (NNN)





BJD govt will expire on June 4: PM Modi in Odisha Taking a reference to the cash Taking a re

PUR (ODISHA), May 6: Prime Minister Narendra Modi on Monday called himself "son of Lord Jagannath" and asserted that the expiry date of a BJD government in Odisha is June 4, the day the assembly election results will be announced. Addressing his first election rally in the state, Modi urged people to give a chance to the BJP to make Odisha the number one state in the country.

In an apparent dig at BJD president and Chief Minister Naveen Patnaik, the prime minister said, "Odisha needs a CM who understands Odia language and culture."

"The BJP will form a double-engine government here after the ongoing elections. The expiry date of the BJD government is June 4. 2024," Modi said at the Berhampur rally.

Addressing another rally in Nabarangpur, the tribal heartland of Odisha, the prime minister claimed that his government has been working for the welfare of indigenous people.

"You have seen the track record of ten years of Modi's leadership. Modi increased the budget for tribal welfare by five times than the earlier allocation," the PM said at the Nabaragpur rally.

Taking a reference seizure in Jharkhand, the prime minister also claimed, "Modi is being criticised for stopping corruption and loot".

Notably, the Enforcement Directorate on Monday claimed to have recovered a huge amount of "unaccounted" cash during searches at the premises of a domestic help allegedly linked to the secretary of Jharkhand minister Alamgir Alam. Modi said that his government at

the Centre has set up 'Eklavya Model Residential' schools in tribal areas and the number of such schools has crossed 400, he said.

"People belonging to ST, SC and OBC categories comprise seven per cent of his ministry," he said. PM Modi also claimed that Odisha has not benefitted from the Ayushman Bharat Yojana as the "BJD government did not implement" it in the state.

The Centre gave Rs 10,000 crore under the 'Jal Jeevan Mission' scheme to Odisha but the "BJD dispensation could not spend the money properly", he said, adding that Paddy farmers in Chhattisgarh get MSP of Rs 3,100 per quintal, but those in Odisha receive Rs 2.100.

He also accused the BJD government of "not allowing schemes



made by Modi to be implemented in Odisha'

The prime minister claimed that the people of Odisha have strength and passion, but the BJD government did not give them the right opportunities. 'You have given 50 years to

Congress and 25 years to BJD. Just give five years to the BJP. We will make Odisha the number one state in the country," Modi said at the rally. He also said, "We released a vi-

sionary manifesto for Odisha promising jobs for youths and women and health facilities for senior citizens. BJP fulfils what it says.

The assembly and Lok Sabha elections in Odisha will be held simultaneously.

"I have come here to invite you to the swearing-in ceremony of BJP's CM on June 10. On that day, we will implement the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana, which the Naveen Patnaik government has been resisting. This son of Lord Jagannath will take care of all senior citizens under this scheme," Modi said.

Responding to Modi's claim, senior BJD leader and Naveen Patnaik's close aide VK Pandian said, "Patnaik would take oath as the chief minister of Odisha for the sixth consecutive time between

11.30 am to 1.30 pm on June 9." PM Modi, however, said Odisha would get "new energy and new leadership after the assembly elections"

"A person, who lives, understands and takes pride in Odia culture and tradition, can help resolve the problems of Odisha at a faster pace...," the PM said.

It is alleged that BJD chief Naveen Patnaik does not have command over the Odia language. Odisha has fertile land, mineral

resources, and sea coasts, but people are still poor, Modi claimed. The prime minister also said

Odisha lags behind in every development parameter despite having huge resources like mineral wealth, and a vast coastline.

"Who is responsible for Odisha's backwardness? Why are the people of resource-rich Odisha still poor? The answer is rampant loot by Congress, which ruled the state for 50 years, and then the BJD for the next 25 years. The BJD is sinking, while the Congress is a spent force and the BJP is the only ray of hope for the people," he said

The prime minister also said that the BJP has given the country's highest post to a daughter of Odisha. (PTI)

He alleged that the law and order is deteriorating in Punjab and underlined that the ongoing disruptions are denying the BJP candidates their right to campaign.

"It remains the responsibility of the Punjab Electoral Office, the state administrative and the police apparatus to ensure the BJP candidates have unhindered access to every part to exert their democratic right to campaign," he said.

However, he added, dozens of incidents in the recent past and the latest incident in Patiala, where a farmer died falling on his own on a road during the campaign of BJP candidate (from Patiala) Preneet Kaur, need immediate attention.

The apprehension of "collusion" of the political parties including the AAP, the SAD and the Congress in scripting such "disruptions" for the BJP candidates looms large, Jakhar said.

The state machinery, he added, cannot act as a "conduit" to facilitate such obstructions.

Jakhar said these parties are clearly "rattled" by the increasing footprints of the BJP in Punjab.

He further said, "We would also like to bring to your notice the recent statement of Punjab Advocate General Gurminder Singh before the Supreme Court where he flagged security issues in the state underlining the threat perception that exists.

"He cited the case of the murder of singer-turned-politician Sidhu Moosewala who was killed days after his security cover was downgraded and publicized. He also made a reference to an RPG attack.

TMC asks CEC to 'urgently furnish' seat-wise voter turnout figures for first 2 LS poll phases

NEW DELHI, May 6: The Trinamool Congress on Monday urged Chief Election Commissioner Rajiv Kumar to "urgently furnish" the constituency-wise voter turnout in absolute numbers for the first two phases of Lok Sabha polls and also sought an explanation over the "delay" in releasing the figures.

Amid the opposition's allegations of delay by the Election Commission in sharing voter turnout data, the poll body last Friday asserted that boothwise data of "actual number of votes polled" is available with the candidates soon after the voting ends. In a letter addressed to the CEC, the Trinamool Congress said the poll panel released the voter turnout percentage for the first two phases "belatedly" on April 30, but the report had no information about the total figure of eligible electors and the number of actual votes cast.

"This is a paradigm shift from the previous voter turnout report(s) from past election(s), where the ECI provided a detailed report in this regard," the TMC said. The party claimed the report also exhibits notable discrepancies and inconsistencies in the percentages that were initially given. For the first phase, the voter turnout percentage was shown to be 60 on April 19. Later the combined voter turnout report on April 30 records the percentage of votes cast in phase one as 66.14 per cent, the TMC said. The party said the 11-day delay in releasing the final voter turnout percentages of phase one and a "significant 5.75 per cent surge in phase one voter participation being reported almost four days after the conclusion of phase two without any proper explanation sparks a serious concern and doubt in the minds of the electorate". It said that under Rule 49S of the Conduct of Elections Rules, 1961, the presiding officer shall prepare an account of votes recorded in Form 17C and furnish it to every polling agent in which the actual number of electors, number of people voted and the total number of votes recorded in EVMs. In the letter to the chief election commissioner, the TMC mentioned certain polling stations where the presiding officer "omitted" the provision for giving the number of voters who physically came to cast their votes as per the 'Register for Voters'. The TMC said "discrepancies" in Form 17C are "indicative of the rampant disregard and lackadaisical attitude with which the ECI is proceed-

ing to conduct the ensuing elections". "It also suggests the possibility of similar occurrences in other booths, which raises serious concerns about the accuracy of voter turnout percentages reported and published by the ECI. The ECI's failure to address such discrepancies would undermine the public trust in the electoral process," they said.

The TMC demanded that the ECI publish the total number of registered electors in each seat, the total number of voters physically turned up as per the 'Register for Voters', and the number of voters as per the EVM, for all constituencies which had gone to polls in phases one and two.

"Urgently furnish the Parliamentary constituency-wise precise voter turnout figures for phases one and two of the ensuing general elections to Lok Sabha, 2024, along with an explanation and clarification for the delay in releasing the voter turnout report dated 30.04.2024, without disclosing/revealing the details of the total number of voter turnout (in figures) and the total number of eligible electors for the said phases," it said. The party also sought that a detailed report should be published after the completion of polling in each of the upcoming phases.

"Publication of precise numerical data of voter turnout is essential to ensure transparency in the electoral process and is the only medium through which the common citizens can access such information. Such publication would also eliminate the possibility of any form of manipulation of official records and foster public confidence in the entire polling process," the TMC said.

The Election Commission officially shared the turnout figure on April 30. According to it, a voter turnout of 66.14 per cent was recorded in phase one and 66.71 per cent in phase two of the ongoing Lok Sabha polls.

The Congress, CPI-M and TMC had questioned the EC over the delay in announcing the final voter turnout figures for the first two phases of the Lok Sabha polls, 11 days after the first round of polling on April 19. The opposition parties are also demanding that the absolute number of voters be made public. (PTI)

NEW DELHI, May 6: Stepping up attack on the BJP over sexual abuse allegations against JD(S) leader Prajwal Revanna in Karnataka, the Congress of Monday alleged that the Modi government has "always protected" those who commit crimes against women.

Former All India Mahila Congress chief Netta D'Souza said the BJP has only given slogans such as 'Beti Bachao, Beti Padhao', but the reality is there before the people of the country. "Be it the brave women wrestlers or daughters like Ankita Bhandari, the prime minister did not try to provide justice to any daughter. The BJP government has always protected those who commit crimes against women," she alleged at a press conference at the AICC headquarters here.

"The women of the country are very angry on the issue of Prajwal Revanna. Women are forced to think that the real character of the person. who was under the protection of Modi ji inside Parliament for the last 5 years, has been revealed to the country," she said.

"If someone else had done the same thing then Modi ji would have been saying all over the country --'Look, we have caught the criminal to protect our daughters'," D'Souza said. "But now when it comes to his favourite person, his attitude is in front of the entire country," she said. While the Congress has been attacking the BJP over the allegations of sexual abuse against leaders of its ally JD(S), the BJP has blamed the Congress government in Karnataka for the "delayed" action against the accused and said it would push for the full might of law against the accused. D'Souza said PM Modi had shared the stage with Prajwal Revanna, who is seeking re-election from Hassan Lok Sabha seat, and sought votes for him.

"If Modi is there, then it is possible for Prajwal Revanna to flee abroad. If Modi is there, then it was possible for Prajwal Revanna to sit in Parliament. But today Narendra Modi, Amit Shah and Smriti Irani are silent," she said. (PTI)

NEW DELHI, May 6: As many as 181 academicians, including vice chancellors and former VCs, have accused Congress leader Rahul Gandhi of spreading "falsehood" regarding the appointment process for university heads and sought lawful action against him. In an open letter, they said the Congress leader has alleged that vice chancellors are appointed solely on the basis of affiliation with some organisation rather than merit as they slammed his claims. The process by which VCs are

The selection has been completely based on academic and administrative prowess and with a vision to take universities ahead, they said.

Though they did not quote Gandhi's specific claims, the Congress leader has in the past alleged that affiliations with the Hindutva organisation RSS is often the guiding factor in appointments to academia. Among the signatories to the letter are Vinay Pathak, VC, CSJM University, Kanpur, Bhagwati Prakash

Delhi HC asks cops to explain steps for safe evacuation of school kids on receipt of bomb threats



from the schools since the primary responsibility for evacuating will be on the schools and on the authorities".

The court said the affidavits, to be filed within 10 days, must also have information about various relevant circulars issued by the Delhi government from time to time. The Delhi Police shall also indicate the action they have taken to

investigate the hoax bomb threat calls received by schools, Justice Prasad said, and listed the matter for further hearing on May 20.

The high court was hearing a petition expressing concern about bomb threats to schools in the recent past. Petitioner Arpit Bhargava, a lawyer, moved the court in 2023 in the wake of a hoax bomb threat to Delhi Public School (DPS) on Mathura Road here.

During the hearing, advocate Beenashaw Soni, appearing for the petitioner, mentioned the recent bomb threat email received by around 200 schools in the Delhi-NCR area which later turned out to

She submitted there were only 18 bomb detection and disposal squads with the city police and wanted to know how they possibly could reach 200 schools as was the case recently.

"This time everyone was affected as every household has a kid. Schools gave a call to parents to

come from their offices and pick up their children. The parents are traumatised and insecure. Are we waiting for a bomb to explode to bring these measures in line? It is like sending children to a war zone,' she argued.

Delhi government standing counsel Santosh Kumar Tripathi, who was also representing the Delhi Police, submitted that deployment of constabulary in each and every school with modern equipment was not possible.

Police have issued SOP and all private schools have been informed about it. The SOP includes disaster management practices and also explains bomb threat situations.

After going through the SOPs, the court said they were general in nature and did not pertain to bomb threats to schools.

"There are certain institutions which require special treatment, for example hospitals where patients are finding it difficult to come out and schools where there are children right from nursery to 12th standard

"What is it that you have done to ensure that children studying in schools are evacuated? Do you have any special kind of SOP to handle such a kind of problem or not?" the court asked.

It asked which authority would be alerted first and which would be the first to respond in the event of such a threat.

"What is the time period that you are giving to yourself from the time of receipt of bomb threat to actual action taken?" the court asked. Tripathi told the court it would not take more than 5 minutes.

On being asked about how many times mock drills have been conducted in schools, the government counsel said the exercise is conducted every three months.

The claim was disputed by the petitioner as also the judge who said, "I don't think the information or the instruction is correct."

The Director of Education, who was present during the hearing, said the department issues instructions to schools to conduct mock drills quarterly after which they send action taken reports.

The Directorate of Education (DoE), in a recent status report, said it has "zero-tolerance policy" in matters of safety in schools and its officials are doing their best to ensure effective implementation of the guidelines for dealing with disasters, including bomb threats. (PTI)

NEW DELHI, May 6: The Delhi High Court on Monday asked the city police to give details of the steps taken to ensure safe evacuation of school children in case of a bomb threat with least dependency on parents and without causing any

panic The high court directed the Delhi Police and the Delhi government to file affidavits giving data on the number of schools in each zone, the nodal authority in each zone which will be responsible for taking action in case of receipt of a threat, the time required for taking action on receipt of a bomb threat, and the number of mock drills that have been conducted under supervision of police and other departments.

Ashoka University students ask VC to cut CISCE results: Pass percentage in Class 10, 12 ties with Israel's Tel Aviv University board exams rises; merit lists discontinued

NEW DELHI, May 6: Students at Ashoka University have joined the chorus of protests against the ongoing war in Gaza and have urged the vicechancellor to end all academic and recollaborations search with Israel-based Tel Aviv University.

Ashoka University student government, an elected student body, said in a letter to the vice chancellor that the university's collaboration with institutions involved in human rights violations undermines its commitment to justice and human rights.

"We are deeply concerned about the ongoing genocide in Palestine in which at least 34,596 Palestinians have lost their lives and 77,816 have been injured due to the Israeli war on Gaza. As the Israeli military's brutality persists...students across universities are now actively calling on their institutions to boycott Israeli universities and exchange programmes, to have open dialogue about the war on Gaza

"The spirit and the results of ongoing protests in the universities in the form of encampments -- embarked on by the students of Columbia University -- are live examples," the students body said in the letter.

The students claimed that Ashoka University, based in Haryana's Sonipat, has research partnerships with Tel



Aviv University, ongoing faculty visits for teaching, student mobility (outbound and inbound), research collaboration, short-term study opportunities as well as joint programmes.

"In light of the evidence presented regarding Tel Aviv University's actions, we urge our institution to sever all ties with Tel Aviv University until tangible steps are taken to address the

"Tel Aviv University's close ties with the Israeli military and its support for the occupation of Palestinian territories raise serious ethical questions. The university's collaboration with institutions involved in human rights violations undermines our commitment to justice and human rights. "This includes Tel Aviv's ties with

Israeli weapons manufacturers like Elbit Systems. Professors from Tel Aviv University have been involved

in drafting the IOF's code of ethics, providing legal defense to IOF members for war crimes and drafting doctrines that dictate military operations,"

the students' body alleged. The student government's petition also mentioned the Boycott, Divestment and Sanctions (BDS) movement, which calls for the boycott of companies accused of being complicit in the war on Gaza.

It further said that all Palestinian universities had been demolished by the Israeli forces, Tel Aviv University "continue to exist to stifle conversation around the Palestinian people and to prevent Palestinian scholarly work" and that the institution allegedly receives funding and benefits from tieups with weapons manufacturers and Israeli intelligence agencies, such as Shin Bet and Mossad The petition said that Tel Aviv Uni-

versity has a responsibility to uphold the principles of academic freedom, social justice and human rights. "By maintaining ties with a univer-

sity linked to systematic human rights abuses, Ashoka University is complicit in these violations," it said, adding that with the international community raising concerns over the war, Ashoka University should demonstrate its commitment to ethical conduct and human rights. (PTI)

age of 97.53 per cent in class 12 exams while the pass percentage of girls stood at 98.92 per cent," CISCE Chief Executive and Secretary Joseph Emmanuel said.

"We have discontinued the practice of issuing merit lists for board exams from this year. The move is aimed at avoiding unhealthy competition among students," he added.

The CBSE had last year stopped the practice of announcing merit lists for the both these board classes.

In Class 10, the western region recorded the highest pass percentage (99.91) followed by the southern region (99.88). Southern region has the highest percentage of girls (49.52) who had appeared in the Class 10 examination.

In Class 12, the Southern region recorded the highest pass percentage (99.53)

Gujarat HC acquits ex-BJP MP, 6 others in RTI activist Amit Jethwa murder case

AHMEDABAD, May 6: The Gujarat High Court on Monday allowed the appeals of former BJP MP Dinu Solanki and six others against their conviction by a CBI court in the case of

Observing that the trial court conducted proceedings with a "predetermined notion of conviction," a division bench of Justices AS Supehia and Vimal K Vyas quashed the CBI court's order sentencing Solanki and the six others to life imprisonment. Jethwa was shot dead outside the high court premises here on July 20, 2010.

Solanki and six others were sentenced to life imprisonment by the CBI court in 2019 and ordered to pay a fine of Rs 15 lakh in the case of murder and criminal conspiracy.

The high court had later suspended the life sentences of Dinu Solanki and his nephew Shiva Solanki, who was also convicted in the case.

"We reiterate that the entire investigation right from the inception of the offence appears to be perfunctory and prejudiced. The prosecution has failed to secure the confidence of the witnesses," the HC bench said in its order. The trial court on a "preconceived notion of



conviction has analysed the evidence divorced from statutes and legal precedence," it said.

The HC said the trial court was duty-bound to apply the law as written, "not as per its instinct

"Resultantly the common judgment on order of conviction dated July 11, 2019 passed by the special judge, CBI court...whereby the accused have been convicted for the offence under section 302 (murder) and section 120 (B) (criminal conspiracy) and 201 (causing disappearance of evidence) of Indian Penal Code (IPC) and are sentenced is quashed and set aside," the HC order said

Jethwa was shot dead outside the Gujarat High Court on July 20, 2010 after he tried to expose illegal mining activities allegedly involving Dinu Solanki by seeking information under the Right to Information (RTI) Act.

An FIR was then lodged against two unidentified assailants and the investigation was transferred to the state police's Criminal Investigation Department (CID), which later filed a chargesheet.

In September 2012, the high court handed over the investigation to the Central Bureau of Investigation. The CBI arrested Dinu Solanki in November 2013. On July 11, 2019, Dinu Solanki and his nephew were convicted in the case of Jethwa's murder.

The high court in September 2021 suspended Dinu Solanki's sentence pending his appeal against conviction by the CBI court.

Last year, the HC also suspended the life sentence of his nephew Shiva Solanki and granted him bail pending hearing of his appeal against his conviction by the CBI court. (PTI)

Bombay HC stays notification giving conditional exemption from 25 pc RTE quota to pvt unaided schools

MUMBAI, May 6: The Bombay High Court on Monday stayed a notification issued by the Maha-

rashtra government that exempted private unaided schools from admitting students under Right to Ed-

ucation (RTE) quota if there is a government-run school within a 1 kilometre radius

A division bench of Chief Justice D K Upadhyaya and Justice Arif Doctor said the issue concerned "overwhelming public interest" and that the impugned notification, issued on February 9, contravened provisions of Right of Children to Free and Compulsory Education Act 2009, also known as RTE.

Under the RTE Act, 25 per cent seats at the entry point - Class 1 or pre-primary section - in private unaided schools should be reserved for children from economically weaker and disadvantaged sections. These students get free education free, while the government reimburses their tuition fees to schools

The notification, however, exempted private unaided schools within 1 kilometre radius of a government-run or aided school from reserving 25 per cent seats for economically weaker and disadvantaged children.

The bench on Monday noted

that such a notification would hamper free education being provided to children. "Any subordinate legislation cannot be made in contravention of

the principal Act; even otherwise by appending impugned proviso to the RTE Act," the court said.

The bench said the notification was "prima facie" ultra vires to the Constitution and stayed it until further orders.

The court was hearing a bunch of petitions challenging the notification. As per the petitioners, the notification was unconstitutional and contrary to RTE Act, which entitles children from weaker section and disadvantaged section to free education.

Additional government pleader Jyoti Chavan said the notification applied only to those unaided private schools situated in areas where there is a government or aided school.

The HC has kept the matter for further hearing on Tuesday. (PTI)

Klopp keeps the drama going to the end as Liverpool beats Spurs 4-2



LIVERPOOL, May 6: The the sideline with Mohamed smile is back on Jurgen Klopp's face — even if his Liverpool players seem intent on testing his nerves right to the end.

The Premier League title may be all but beyond the Merseyside club. but that doesn't mean the drama is over for Klopp, who will step down at the end of the season.

Last week he was arguing on walk for Klopp's team.

Salah as Liverpool effectively dropped out of the title race. And while Salah opened the scoring in a 4-2 win against Tottenham at Anfield on Sunday, it was Harvey Elliott who appeared to bring the broadest smile to Klopp's face with a wonderful long-range goal in what looked like being a cake-

"What a goal," the Liverpool manager said. "In the game you only see it flying in and I thought, That was a good shot.' The goal I saw afterwards, there was not a lot of space left or right. It went exactly where it should be be. Top goal." Elliott's strike, after goals

from Salah, Andy Robertson and Cody Gakpo, fired Liverpool into a 4-0 lead before the

game had even reached the hour mark. What followed was the unlikeliest of fightbacks from Spurs that might have made this another frustrating day in what has ultimately been a disappointing finale for Klopp at the end of nearly nine trophy-filled years.

Goals from Richarlison and Son Heung-min made it a much closer contest than it had ever

looked like being. And it needed two outstanding saves from Alisson, a goal-line clearance from Joe Gomez and a VAR call to prevent it from being closer still.

"It's a little bit of a mirror of the season. Really, really, really, good until we were really rubbish and then, we were okay again," Klopp said.

A nervy finish didn't stop the home fans from beckoning Klopp to produce his trademark post-match triple fist pump to the crowd after his penultimate home game in charge, with Feyenoord coach Arne Slot set to take over next season.

Mathematically, at least, it is not over for third-place Liverpool, which sits five points adrift of leader Arsenal with two games remaining. But, in reality, a late-season slump has killed Klopp's hopes of walking away with a second Premier League crown of his reign.

His team had been heavily rebuilt over the past two seasons and was not expected to contend at the top so soon. But this season at one point offered Liverpool the hope of a quadruple of trophies. Now it feels like it is ending on an underwhelming note.

Still, Klopp, who delivered the English League Cup in February, will walk away from a team that is on the up and leave his successor with plenty of young talent to work with.

Hrádecký sets record for foreign goalkeeper with 292 Bundesliga appearances

erkusen's Lukáš Hrádecký set a record for a foreign goalkeeper in the Bundesliga on Sunday by making his 292nd appearance. The 34-year-old Finnish keeper played in Leverkusen's 5-1 win at his former club Eintracht Frankfurt, breaking the record previously held by Borussia Mönchengladbach and Bayern Munich goalkeeper Yann Sommer of Switzerland.

FRANKFURT, May 6: Bayer Lev- matchday papers before the game and I saw it there today," Hrádecký told broadcaster DAZN afterward. "It fills me full of pride and honor that I can play in such a lovely country and league, and for two fantastic clubs.

Hrádecký joined Frankfurt in 2015 and went on to make 101 appearances for the club before switching to Leverkusen in 2018. Sunday's game was his 191st league appearance for Leverkusen.

It was also the first time he had won

Roma draws 1-1 against Juventus; Milan ultras protest during 3-3 draw with Genoa - (A)

MILAN, May 6: Roma at-tempted to bounce back from European disappointment but could only draw 1-1 against Juventus in Serie A on Sunday in a result that did little to help its hopes of qualifying for next season's Champions League.

Bremer canceled out Romelu Lukaku's first goal from open play against Juventus. Both teams also hit the woodwork as Juve's winless run continued.

Third-place Juventus, which is winless in its last five matches, is six points ahead of fifth-place Roma with three rounds remaining. The top five in Serie A qualify for the Champions League after Italy earned an extra spot in next season's competition.

Roma is just three points above sixth-place Atalanta, which has also played two matches fewer. Roma was looking to recover from a 2-0 loss to Bayer Leverkusen in the first leg of the Europa League semifinals on Thursday, and started positively with Rasmus Kristensen's header coming off the crossbar in the

11th minute The capital side took the lead just four minutes later in somewhat chaotic circumstances. Paulo Dybala pulled the ball back from the byline and Bryan Cristante's shot was blocked by Juventus defender Federico Gatti on the line but went straight to Lukaku for the tap in.

It was his first goal against Juventus from open play after netting from the spot against the Bianconeri for Inter.

Juve leveled in the 31st minute when Federico Chiesa whipped in a cross from the right and Bremer

headed it in at the back post. Chiesa came close to firing his team in front right at the start of the second half but his effort went off the right post and across the face of goal.

AC Milan's hardcore fans protested during the team's 3-3 draw against Genoa. There was a strange atmosphere

at San Siro as the Milan ultras —

who also unveiled banners calling for more ambition, communication and a clear transfer strategy - remained silent during the match and left 10 minutes before the final whistle.

Milan was leading 3-2 by then, after recovering from Mateo Retegui's early penalty, but conceded a comical third goal as Morten Thorsby's cross ricocheted off Retegui and home defenders Fikayo Tomori and Malick Thiaw. It went down as an own-goal by Thiaw.

It was a sixth straight match without a win for Milan, which nevertheless is second and mathematically assured of Champions League soccer next season.

Hellas Verona boosted its chances of Serie A survival with a 2-1 win over Fiorentina as fellow strugglers Empoli and Frosinone played out a disappointing 0-0 draw. All three teams had been locked on 31 points ahead of the weekend, just two points above the relegation zone.

Verona was helped by Fiorentina coach Vincenzo Italiano opting to rotate his team ahead of the second leg of the Europa Conference League semifinal on Wednesday. Fiorentina beat Club Brugge 3-2 in the first leg last week.

And the visitors gifted Verona the opener Sunday in the 13th minute when, in a mix-up with Fiorentina defender Luca Ranieri, goalkeeper Oliver Christensen failed to gather an innocuously seeming long ball and instead brought down Tijjani Noslin. Darko Lazovic converted the resulting penalty.

Gaetano Castrovilli, who had earlier hit the post, leveled shortly before halftime for his first goal since returning recently from a knee injury that had sidelined him for almost a year.

Verona restored its lead in the 59th when Nikola Milenkovic could only send Darko Lazovic's cross as far as Noslin, who thumped it into the roof of the

4x400m relay teams qualify for Paris Olympics

NASSAU (BAHAMAS), May **6:** The Indian men's and women's 4x400m relay teams qualified for Paris Olympics after finishing second in their respective secondround heats at the World Athletics Relays here on Monday.

In the women's competition, the quartet of Rupal Chaudhary, M R Poovamma, Jyothika Sri Dandi and Subha Venkatesan clocked 3 minutes and 29.35 seconds to finish second behind Jamaica (3:28.54) in heat number one to book a Paris Games ticket.

Later, the men's squad of Muhammed Anas Yahiya, Muhammed Ajmal, Arokia Rajiv and Amoj Jacob finished with a collective timing of 3 minutes and 3.23 seconds to also finish second in their heat, behind USA (2:59.95).

The top two teams in each of the three heats in the second round were to qualify for the Olympics to be held from July 26 to August 11. It was a sort of a surprise that the women's 4x400m team qualified for the Olympics as the focus was more on the men's 4x400m team which has broken Asian record in back-to-back global events -- Tokyo Olympics and 2023 World Championships -- as well as winning 2023 Asian Games gold.

The Indian women's team had finished fifth in the first-round qualifying heat on Sunday with a time of 3 minutes and 29.74 seconds.

The men's team had failed to finish in the first-round qualifying heat after second leg runner Rajesh Ramesh pulled out midway due to cramps. Arokia Rajiv took the place of Ramesh in the team and he ran the third leg after Anas and Ajmal.

The Indian men's 4x400m team was on third position when anchor-leg runner Jacob took the baton from Arokia but the Delhi

boy ran a fantastic race to overtake his Mexican opponent and finish second. It was not about the timing but more about Olympics qualification for the Indian men's team which ran 3:00.25 at the Tokyo Olympics for the then Asian record before bettering it during the 2023 World Championships with yet another Asian record of 2:59.05. Monday's timing was well below the team's best. India had even given a mighty scare to formidable USA during the heat race at the 2023 Budapest World

Championships before settling for the second place.

Meanwhile, India pulled out of the mixed 4x400m relay second round heat races on Monday as Ramesh was not available after suffering muscle cramps while running the men's 4x400m first round heat on Sunday.

Ramesh had run both the mixed 4x400m and men's 4x400m races on Sunday. India had featured in mixed 4x400m relay in the Tokyo Olympics where the event made its debut.

The Indian women's 4x400m relay team will be returning to Olympics after missing out in Tokyo Games. The Paris participation will be the eighth time for the Indian women's 4x400m team, the first being in 1984 Games.

For the men's 4x400m, this will be the fourth time India will be taking part in the Olympics, the first being in the 2000 Sydney Games.

With this, India now have at least 19 Paris-bound track and field athletes and the list includes defending javelin throw champion Neeraj Chopra among others.

The athletics events at the Games will begin on August 1. A total of 70 teams have quali-

fied for relay events at the Paris Olympics following two days of thrilling action at the World Athletics Relays Bahamas. (PTI)

T20 World Cup in the Americas has received a terror threat, Trinidad's Prime Minister Dr Keith Rowley has revealed even as the ICC asserted that a "comprehensive and robust security plan" is in place to "mitigate any risks" to the showpiece beginning June 1.

The tournament -- featuring 20 teams, including India -- is scattered across nine venues, six of them in the West Indies.

As of now, the threat, according to media reports, is specific to the West Indies, which aside from some preliminary matches. will be hosting the entire Super 8 stage along with the semifinals

"Unfortunately, the threat of terrorism in its many and varied expressions is an ever-present danger in the world of the 21st century," Rowley was quoted as saying by 'Trinidad Daily Express' here.

Rowley did not name any organisation but reports here stated that the Islamic State made the threat through its propaganda channel.

The ICC responded to the development with a statement assuring preparedness.

"Safety and security of everyone at the event is our number one priority and we have a comprehensive and robust security

plan in place," a spokesperson of the global body said in a state- and regional levels have rement issued to PTI.

César Luis Menotti, coach who led Argentina to its first World Cup title in 1978, dies at 85

BUENOS AIRES, May 6: the works of Latin American César Luis Menotti, the charismatic coach who led Argentina to its first World Cup title in 1978, has died, the Argentine Football Association said Sunday. He was 85.

"Goodbye, dear Flaco!" the association's statement added, using Menotti's nickname which means "the thin one.' The association did not give a

cause of death. Local media reports said Menotti was admitted to a clinic in March with severe anemia. He reportedly under-

went surgery for phlebitis in April and subsequently returned home. Passion for soccer and a sharp ability to explain its mechanics

were Menotti's hallmark characteristics as a trainer, and he was considered one of the most emblematic and influential coaches in Argentine soccer. Menotti was a political ac-

tivist and an affiliate member of the Argentine Communist Party, a boxing fan and an admirer of tated to qualify as the best

writers Mario Benedetti, Gabriel García Márquez, Jorge Luis Borges, Mario Sábato and Joan Manuel Serrat, among others.

"Once I was interviewed by Borges, and when I asked him if it bothered him that I smoked. he told me: What intoxicates me is not the cigarette, but the stupid conversations," Menotti recalled in one of his last interviews.

"So, I asked about everything but not about soccer, because I know about soccer!" he added.

He launched his career as a player for Rosario Central (1960-1963 and 1967), then went to Racing Club (1964) and Boca Juniors (1965-1966), all Argentine clubs. Menotti played for the New York Generals in the U.S. (1967), followed by Brazil's Santos (1968) and Italy's Juventus (1969-1970).

At Santos, he played alongside Pelé, whom he never hesi-

player among legends.

Menotti coached Argentina's national team between 1974 and 1983. He was convinced the side did not get the recognition it deserved when it won the World Cup in 1978 because the country was ruled by a military junta responsible for widespread human rights violations. His detractors would often recall a photo in which Menotti,

after the World Cup victory, shook hands with Jorge Rafael Videla, head of the military

junta. On the eve of the World Cup, Menotti left a 17-year-old Maradona off the squad — a decision the coach later said soured their relations for years. Menotti coached Mexico's national team in 1991-1992. He also led Barcelona (1983-1984),

where he had Maradona on his squad; Atletico Madrid (1987-88); Uruguay's Penarol (1990-91); Italy's Sampdoria (1997) and Mexico's Tecos (2007) his last coaching job.

For years, Menotti often had a cigarette hanging between his lips, but he mostly quit the habit in 2011 following a three-day hospitalization stemming from his tobacco addiction.

He also was known for wearing hair long but neat. He said he didn't rely on hairdressers. "I cut my own hair. I take the scissors, I cut the ends.

Menotti began leaving his hair long in the early 1970s.

"One day I said to myself: I won't cut my hair until we lose'. And we went 10 games undefeated, so it all started as a oke," he said.

In his later years, Menotti said he didn't fear death. "It's the only thing I'm sure of. I don't know anyone who hasn't died at some point," he said in 2014.' (AP)

Rublev praises doctors after winning Madrid Open for the 1st time

MADRID, May 6: Despite sleepless nights struggling with a fever, Andrey Rublev found a way to fight back and win the Madrid Open for the first time.

Rublev was feeling sick all week but rallied to beat Felix Auger-Aliassime in three sets on Sunday and clinch his second Masters 1000 title.

Rublev won 4-6, 7-5, 7-5 after Auger-Aliassime double-faulted on the last point of the final at the clav-court tournament in the Spanish capital.

"I would say this is the most proud title of my career," Rublev said. "I was almost dead every day. I was not sleeping at night. The last three, four days I didn't sleep."

Rublev gave "full credit to the doctors," who were "doing some tricky things" just to make sure he could play.

"I have no words," the eighthranked Rublev said. "If you knew what I had been through in the past nine days you would not imagine that I would be able to win a title."

The 26-year-old Russian won his first Masters 1000 title at Monte Carlo last year. Auger-Aliassime was playing in his first final at this level.

Rublev entered Madrid on a four-match losing streak after early exits at Indian Wells, Miami, Monte Carlo and Barcelona. One of his victories in Madrid came in the quarterfinals against homecrowd favorite Carlos Alcaraz.

He now has 16 career titles, and two this season after Hong Kong in January. He had arrived with a 5-1 record against Auger-Aliassime, including a win in their sole matchup on clay. (AP)
