

# Home Secretary hands over certificates to 14 people $\bullet$ A historic day, says Shah

NEW DELHI, May 15: The first set of citizenship certificates under the Citizenship (Amendment) Act was issued Wednesday here to 14 people, nearly two months after rules under the contentious law were notified to grant Indian nationality to persecuted non-Muslim migrants from three neighbouring countries.

Union home minister Amit Shah termed it a "historic day", saying the decades-long wait of those who faced religious persecution in Pakistan, Bangladesh and Afghanistan is over.

Home Secretary Ajay Kumar Bhalla handed over the certificates to the 14 people after their applications were processed online through a designated portal, an official spokesperson said.

This comes in the midst of the general elections which started on April 19. The last phase of polling will be held on June 1 while the

14 applicants and highlighted the salient features of the Citizenship (Amendment) Rules, 2024. Secretary Posts, director of the Intelligence Bureau, registrar General of India and senior officers were also present during the interactive session when the certificates were issued.

Home Minister Shah said the Hindu, Sikh, Buddhist, Jain, Parsi and Christian brothers and sisters who fled religious persecution in the three countries have started getting Indian citizenship and Prime Minister Narendra Modi has fulfilled the promise made at the time of the country's independence. "I express my gratitude to Modiji for giving justice and rights to these people who suffered for decades. I also assure all my refugee brothers and sisters that the Modi (CONTD. ON PAGE-2)

# 'PoK will be merged with India if BJP gets over 400 seats in LS' Himanta campaigns in J'khand, hopeful of UCC execution

RAMGARH/GIRIDIH, May 15: Chief Minister Himanta Biswa Sarma on Wednesday claimed that Pakistan-occupied Kashmir will be "merged with India" if BJP gets more than 400 seats in the Lok Sabha polls. Addressing an election rally in Jharkhand's Ramgarh for Hazaribag candidate Manish Jaiswal, he said the BJP needed to get over 400 seats to implement the Uniform Civil Code (UCC) across the country.

"PoK will be merged with India if BJP gets over 400 seats in Lok Sabha polls. BJP needs over 400 seats to build the 'Shri Krishna Janmabhoomi' temple and 'Gyanvapi temple', and implement the Uniform Civil Code (UCC), just like when it crossed the 300-seat mark in 2019, it built the Ram Temple in Ayodhya. It also ensured the abrogation of Article 370 from Jammu & Kashmir, and implemented the CAA," Sarma said.

"Like Assam, infiltrators from Bangladesh are changing the demography of Jharkhand, while the JMM and Congress are indulging in their appeasement," he alleged.

He said "infiltrators" have occupied land in 12 districts of Assam, and in Jharkhand, they have started the same by marrying local tribal women.

"If this continues, they will change Jharkhand's de-



mography too," he claimed.

Sarma said the situation has become such that "infiltrators" were trying to become original inhabitants. He attacked the JMM-led alliance in the state, alleging that corruption had peaked during its rule.

Over Rs 350 crore in cash has been recovered from premises linked to a Congress MP. Over Rs 35 crore has been seized from the domestic help of a personal secretary attached to a state minister. The report by the Geneva-based Internal Displacement Monitoring Centre (IDMC) termed it the highest number of displacements triggered by conflict and violence in India since 2018.

On May 3, 2023, a 'Tribal Solidarity March' was organised in Manipur's hill districts to protest against the Meitei community's demand for Scheduled Tribe (ST) status. The march led to ethnic clashes between the Meitei and the Kuki communities, ultimately claiming more than 200 lives.

'The crippling heat made it extremely difficult to stand near the gas stove' Climate crisis made crippling April heatwave in South Asia 45 times more likely: Scientists

NEW DELHI, May 15: Annu Mishra kept her modest food stall shut as temperatures in Odisha's Bhubaneswar remained above 40 degrees Celsius for 17 consecutive days in April. This streak was the longest since 1969, severely impacting health and livelihoods.

'The crippling heat made it extremely difficult to stand near the gas stove," said 51-year-old Mishra, noting that the only time her food stall remained shut for such a long duration was after Cyclone Fani in 2019.

Similar heatwayes could occur once every 30 years and they have already become about 45 times more likely due to climate change, leading climate scientists said on Wednesday, citing historical weather data.



The team of scientists, called the World Weather Attribution (WWA) El Nino and the increasing concengroup, emphasized that heatwaves tration of heat-trapping greenhouse intensified by climate change are gases in the atmosphere, millions of making life much tougher for peopeople in South Asia endured brutal ple living in poverty across Asia. heat in April.

Record-smashing maximum temperatures were logged in parts of India, prompting health warnings from government agencies and some states to suspend in-person classes in schools.

The oppressive heat also shattered temperature records in the Philippines, Bangladesh, Indonesia, Malaysia, and Myanmar.

In West Asia, including Syria, Lebanon, Israel, Palestine, and Jordan, April heatwaves with temperatures above 40 degrees Celsius have become more frequent due to climate change.

The world experienced the warmest April ever and the eleventh consecutive month of record-high temperatures, the World Meteorological Organization (WMO) said on Friday. (CONTD. ON PAGE-2)

# **India asks Iran to release nearly** 40 Indian seafarers from custody

# **Biden imposes heavy import tariffs on Chinese imports**

WASHINGTON, May 15: US President Joe Biden has imposed heavy tariffs on Chinese electric vehicles, batteries, steel, solar cells, and aluminium, saying it would ensure that American workers are not held back by unfair trade practices.

These include a 100 per cent tariff on electric vehicles, a 50 per cent tariff on semiconductors, and a 25 per cent tariff each on electric vehicle batteries from China.

In his address to the nation from the Rose Garden of the White House, Biden said America can continue to buy any kind of car they want, "but we're never going to allow China to unfairly control the market for these cars. Period."

"I want fair competition with China, not conflict. We are in a stronger position to win that economic competition of the 21st century against China than anyone else because we're investing in America again," he said. Biden alleged that for years, the Chinese government has poured state money into Chinese companies across a whole range of industries: steel and aluminium, semiconductors, electric vehicles, solar panels, and even critical health equipment, like gloves and masks.

China heavily subsidised all these products, pushing Chinese companies to produce far more than the rest of the world could absorb. Then dumping the excess products onto the market at unfairly low prices, driving other manufacturers around the world



out of business, he said.

The prices are unfairly low because Chinese companies don't need to worry about profit because the Chinese government subsidised them and subsidised them heavily. The Chinese also rely on other anti-competitive tactics, like forcing American companies to transfer their technology to do business in China, he said.

Biden said the new tariffs announced by him in key sectors of the economy are going to ensure that US workers are not held back by unfair trade practices.

American companies, he said, are investing tens of billions of dollars in electric vehicles and their batteries. "Our partners around the world are making similar investments. They also want a supply chain for electric vehicles that isn't dominated by unfair trade practices from China," he said. Biden also slammed his prede-

cessor Donald Trump on his China policy. "My predecessor promised to increase American exports and boost manufacturing. But he didn't either. He failed. He signed a trade deal with China. They were supposed to buy USD 200 billion more in American goods. Instead, China imports from America barely budged," he alleged.

"And now, Trump and his MAGA Republicans want acrossthe-board tariffs on all imports from all countries, if reelected. Well, that would drive up costs for families on an average of USD 1,500 per year each year. He simply doesn't get it," he said.

At a White House news conference, US Trade Representative Katherine Tie said the previous administration's trade deal with China failed to increase American exports or boost manufacturing. In fact, China's exports in some crit-

actually increased, Tie said. "In response, President Biden signed a memorandum directing me to increase tariffs on critical manufacturing and mining sectors, including steel and aluminium, semiconductors, electric vehicles, batteries, solar cells, and certain critical minerals," she said. The increased tariffs are expected to cover approximately USD 18 billion of trade. The president also directed a process to request excluding certain production machinery from the tariffs to permit solar and clean manufacturers to purchase equipment while diversifying their suppliers.

Next week, she is expecting to issue a public notice that conveys the specific tariff lines, tariff rates, and timing for the proposed increases along with the details of the machinery exclusions process. "This strong action by the pres-

ident is strategic. As he has said, we do not seek to constrain China's economic development, but we will insist on fair competition and defend American workers from the PRC's unfair practices.

Today's direction by the president defends American workers and businesses from the PRCs artificially cheap products, whether EVs or steel or critical minerals or semiconductors," Tie said.

She also emphasised that the US continues to consult with its partners and allies who face similar threats from the Chinese unfair trade practices and are also voicing their concern with those unfair

# Sensex snaps 3-day winning run on selling in HDFC Bank, RIL

MUMBAI, May 15: Snapping its three-day winning run, benchmark Sensex declined by 117 points in a volatile trade on Wednesday due to selling in index heavyweight shares like HDFC Bank, Reliance Industries and TCS. The 30-share BSE Sensex declined by 117.58 points or 0.16 per cent to settle at 72,987.03. During the day, it lost 281.95 points or 0.38 per cent to 72,822.66. The broader Nifty dipped 17.30 points or 0.08 per cent to close at 22,200.55. The index oscillated between a high of 22,297.55 and a low of 22,151.75 in day trade. From the Sensex pack, Tata Motors, Asian Paints, HDFC Bank, JSW Steel, Hindustan Unilever, Nestle and Titan were the major laggards.

In contrast, Bharti Airtel, Power Grid, NTPC, Mahindra & Mahindra, Larsen & Toubro and HCL Technologies were among the major gainers.

"The market witnessed a sideways movement throughout the day as the emotions of investors were impacted by the election-led jitters. FIIs continued to remain in the selling mode; however, domestic investors were largely concentrated on stock-specific picks," said Vinod Nair, Head of Research, Geojit Financial Services. In the broader market, the smallcap gauge climbed 0.96 per cent and the midcap index

went up by 0.60 per cent. Among the indices, FMCG lost 0.75 per cent. Auto (0.31 per cent), bankex (0.17 per cent) and financial services (0.07 per cent) also declined. Capital goods rallied 2.13 per cent, followed by utilities (1.27 per cent), realty (1.11 per cent), services (1.08 per cent) and energy (0.95 per cent).

"Following three days of rebound, the markets took a pause and closed nearly unchanged. Initially, there was an uptick, but pressure from certain heavyweights pushed the Nifty lower, leading to a range-bound movement until the end of the session," Ajit Mishra SVP, Research, Religare Broking Ltd. The wholesale inflation rose to a 13-month high of 1.26 per cent in April fuelled by rising prices of food articles, especially vegetables, amid expectations of RBI holding interest rates in the policy review next month. "Nifty snapped a three-day winning streak on Wednesday, giving up early gains and ending marginally in the red. Global equities headed for a fresh record after a tech-led rally in the US, amid optimism that Wednesday's key US inflation report won't weaken the case for Federal Reserve interest-rate cuts," said Deepak Jasani, Head of Retail Research, HDFC Securities. government will give citizenship to all of them through the CAA," he said on X in Hindi. "Modi's guarantee...the guarantee of fulfilling promises." The CAA rules envisage the manner of application form, procedure for processing applications by the District Level Committee (DLC), scrutiny and grant of citizenship by State Level Empowered Committee (SLEC). "In pursuance of these rules, applications have been received from persons belonging to Hindu, Sikh, Jain, Buddhist, Parsi and Christian communities from Pakistan, Bangladesh and Afghanistan who have entered into India up to December 31, 2014 on account of persecution on grounds of religion or fear of such persecution," the spokesperson said. The DLCs chaired by senior superintendents of Post or superintendents of Post as designated officers, on successful verification of documents, have administered the oath of allegiance to the applicants. After processing as per rules, the DLCs have forwarded the applications to SLEC headed by director (Census Operation). Processing of applications is completely done hrough the online portal. The empowered committee, Delhi, headed by director (Census Operation), Delhi, after due scrutiny, has decided to grant citizenship to 14 applicants. Accordingly, the director (Census operation) granted certificates to these applicants, the spokesperson said. The passing of the CAA in 2019 sparked protests in different parts of the country with agitators terming it "discriminatory". Over a hundred people lost their lives during the anti-CAA protests or police action in various parts of the country. Union home minister Amit Shah has been maintaining that no one can stop the implementation of the CAA as it is the law of the land. He accused the opposition of misleading the people on the issue. (PTI)

# *PM's active role, personal monitoring responsible* for infrastructure sector turnaround, says FM

NEW DELHI, May 15: Prime Minister Narendra Modi's active role and personal monitoring are responsible for the turnaround of the infrastructure sector, which suffered due to policy paralysis during the UPA regime, Finance Minister Nirmala Sitharaman said on Wednesday.

In a contrast to the previous regime, the current government under the leadership of Modi has spearheaded a shift towards prioritising infrastructure development and capital expenditure with an aim to bolster the Indian economy.

Taking a dig at the Congress-led UPA regime from 2004-2014, she said, "@INCIndia-led UPA (2004-14) wasted India's economic growth potential and left it among the 'Fragile Five' economies without focusing on effective infrastructure development. Under UPA, almost all aspects of India's economic needs were mismanaged or ignored.'

The UPA government's noticeable and deliberate neglect of infrastructure creation not only denied India much-needed roads, railways, power, etc, but it also compromised India's long-term economic potential, she said in a post on X.

"The UPA government's term was replete with examples of decision stasis. Cost overruns, stalled projects and lack of timely approvals were common between 2004-14," she said.

However, she said, "Prime Minister Modi's active role has made the infrastructure turnaround possible. The PM has personally monitored the progress of projects, even those launched earlier,

through the PRAGATI platform. "This led to the successful completion of long-delayed projects. Through 43 PRAGATI meetings, PM Modi has reviewed projects worth Rs 17.36 lakh crore.'

Pointing out that infrastructure spending not only boosts GDP growth through its multiplier effects on consumption and investment, but also improves the long-term efficiency of the economy by reducing logistical constraints, she said, adding that an NIPFP study points out that every rupee directed towards capital expenditure in India increases economic output by Rs 4.8

The share of capex in total expenditure dropped sharply under the UPA from 23 per cent in 2003-04 to an average of 12 per cent between 2005 and 2014, she said.

"It is also unwise to expect that @INCIndia would have learnt from their mistakes. INCIndia returns to their neglect of Capex and infrastructure. The 2024 Budget presented by the Congress government in Karnataka slashed the share of capital expenditure in total spending by 28 per cent," she said. Imagine the opportunity cost lost due to Congress not investing adequately in capital expenditure,

Sitharaman said. "Our government significantly increased the outlay for capex. As a proportion of total expenditure, capex rose to over 21 per cent in 2023-24, compared to just 12 per cent in 2013-14," she said.

Since 2014, the Modi government has allocated a total of Rs 43.53 lakh crore in Gross Budgetary Support (GBS) capital expenditure, an increase of 3.72 times



compared to 2004-14.

Giving details of various segments, Sitharaman said, 3.74 lakh km of rural roads have been built under the PM Gram Sadak Yojana in the last 10 years, almost double of 3.81 lakh km of rural roads built till 2014. Over 99 per cent of rural

habitations are now linked with rural roads. Since 2014, there has been a 500 per cent increase in road transport

and highway budget allocation, she added. National Highway (NH) network has expanded 60 per cent

from 91,287 km in 2014 to 1,46,145 km by 2023; compared to only 39 per cent expansion from 65,569 km to 91,287 km between 2004-14. Under PM Modi, Indian Rail-

ways has ushered in an era of modernisation with modern stations, modern trains, modern facilities

and modern technology. In 2023-24, she said, allocation for Railways' capex increased to Rs 2.43 lakh crore. It is a 30-times

increase over 2004-05, and 8 times over 2013-14. On the power sector, she said, India has transformed from being

power-deficient to power-sufficient by adding 193 GW of gener-

ation capacity (249 GW to 442 GW). Investments in upgrades, grid modernisation, and smart technologies are being done to help reduce power outages, voltage fluctuations, and disruptions. she said.

As of November 2023, she said, the availability of power in rural areas increased from 12 hours in 2015 to 20.6 hours, and in urban areas, it rose to 23.8 hours 100 per cent rural electrification was achieved in 2018.

Since 2014, the Metro network has expanded around four times, from 248 km of operational lines in five cities to 939 km in 20 cities, she said.

As the first of the eight RRTS corridors, she said, the Delhi-Meerut stretch will be completed by June 2025.

With regard to aviation sector, "India's aviation network has doubled with the construction of 83 new airports since 2014. Operational airports rose from 74 in 2014 to 157 in 2024. The passenger traffic has increased from 169 MPPA (Million Passengers Per Annum) in 2014 to 376 MPPA in 2024." The Modi government has actively engaged in improving India's maritime sector to promote the blue economy.

A 10-year blueprint 'Maritime India Vision 2030 (MIV 2030)' was released to boost the maritime ecosystem.

Besides, she said, FDI norms were relaxed to attract investments in port development and operations. Up to 100 per cent of FDI was allowed for port and harbour construction and maintenance projects. (PTI)

India had withdrawn its officials from the embassy after the Taliban seized power in August 2021 following concerns over their security. (PTI)

## Climate crisis made crippling

Another WMO report published in April said Asia experienced maximum disasters in the world in 2023, with extreme weather, climate, and water-related hazards affecting over nine million people in the region

As global average temperatures have risen by 1.2 degrees Celsius compared to the cooler pre-industrial climate, scientists predict that West Asia is expected to experience similar heatwaves about once every 10 years. If warming reaches 2 degrees Celsius, similar heatwayes will occur about once every five years.

Heatwaves can be deadly, with the elderly and children particularly at risk of heat exhaustion and heatstroke. According to the World Health Organization, more than 1,66,000 people died as a result of heatwaves between 1998 and 2017. Extreme temperatures can also impact economies. People are less productive during hot weather, even if they work indoors, while children struggle to learn in extreme heat. A study in 2022 said extreme heat resulted in labour productivity loss of USD 2.1 trillion equivalent in 2017. In Bhubaneswar, Mishra suffered a loss of ₹ 20,000 due to keeping her food stall, the only source of income for her family, shut during the prolonged heat wave spell (16 days), the longest since April 2016. "Other street vendors were allowed to sell their produce and articles between 6 am and 10 am in the morning and 6 pm and 10 pm in the evening, resulting in massive losses for them. Many suffered heatstrokes," Mishra, who is also a member of the local street hawkers' association, said. Experts suggest that the population aged above 65 and below 15 needs special attention in terms of preparedness to reduce the impact of extreme heat on health. "Cities in India need to identify vulnerable populations expeditiously and prepare heat action plans accordingly," said Vishwas Chitale, senior program lead at the Council on Energy Environment and Water. The WWA emphasized that some countries, such as India, have comprehensive heat action plans in place. Yet, to protect some of the most vulnerable people, these plans must be expanded with mandatory regulations, such as workplace interventions for all workers to address heat stress. (PTI)

## India asks Iran to release

along side two other nationals, were taken away by Iranian authorities on April 24 and their whereabouts are still unknown. Iran is yet to give consular access to the Indian seafarers of the ship and the Indian Embassy in Tehran is in regular touch with Iranian authorities, the sources said.

Another ship, Global Cherylyn, was seized on December 11, 2023 at Bandar Abbas with 20 Indian crew members and one Bangladeshi. Consular access to the crew was given on March 12, 2024. The vessel was seized on charges of "fuel smuggling". The issue was raised with the Iranian Embassy and authorities in Tehran.

According to the latest update, the release orders of the seafarers have been signed by a local court but final release depends on the approval of a court in Tehran. Another vessel, Margol, was seized on January 22, 2024. It has currently one Indian, the vessel's captain Sujeet Singh. So far, consular access has not been given. The vessel was seized on charges of "fuel smuggling". The ship's 12 Indian crew were already released and they reached Delhi on February 14, 2024. A penalty of ₹ 20 crore was imposed on the captain by the Iranian authorities. Shipping company RPSL is in touch with the Iranian authorities and they have assured the release of the captain by this month. Merchant ship MSC Aries was seized on April 13, 2024 by Iran for its alleged links with Israel. There were 17 Indian crew. External Affairs minister S Jaishankar spoke to his Iranian counterpart on April 14 for the release of Indian crew members. (PTI)

## US scrutiny on **Chabahar Port deal**

# India's submarine challenges in the Indian Ocean region

ecent developments concerning submarines in the Indian Ocean Region (IOR) hold considerable importance for Indian security strategists in the near and medium future. This matter demands prioritization by the incoming government set to take office in June.

In late April, the Pakistan navy marked a milestone with the launch ceremony of its first Hangor-class submarine at the Wuchang shipbuilding group's Shuangliu base in Wuhan, China. This submarine, an export version based on the Chinese PLA Navy's Type 039A/041 Yuan class, is slated for induction into the Pakistan navy by 2028. Notably, it boasts air-independent propulsion (AIP), offering a substantial increase in underwater endurance compared to conventional diesel-electric submarines. This advancement is poised to significantly bolster Pakistan's sea-denial capability in the Indian Ocean Region

(IOR). Despite the Indian Navy's recognition

table push towards achieving self-reliance, or atmanirbharta, in the defense sector to mitigate import dependency. However, the execution of this initiative has not met expectations. Under the concept of 'strategic partnership' projects, four significant platforms have been designated for collaboration between Indian entities and foreign manufacturers. These include AIP-enabled submarines, along with fighter aircraft,

helicopters, and armored vehicles. The Project 75(I) submarine agreement is anticipated to hover around \$5 billion (roughly ₹ 44,000 crore), signifying a considerable investment. Over the last three years, two foreign manufacturers, one German and the other Spanish, have been pinpointed, marking the commencement of the final evaluation phase. The German conglomerate TKMS (Thyssenkrupp Marine Systems) has forged a partnership with the public sector unit Mazagon Docks Ltd (MDL), a collaboration that enjoys robust backing from the German government.

Another competitive partnership in con

quisitions paint a less-than-encouraging picture. The acquisition of Rafale fighter aircraft from France serves as a notable example. The suddenness of the final decision and the opacity surrounding technology transfer did little to further India's quest for self-reliance.

While numerous factors come into play beyond just technological and commercial considerations when finalizing decisions on major military platforms, a brief assessment reveals a checkered history in the indigenous development of India's submarine program. In the mid-1980s, India procured its first HDW-Type 209 conventional submarine from West Germany with the aim of establishing an indigenous submarine production line at MDL.

However, this endeavor was marred by a bribery scandal, which also implicated the Bofors artillery gun deal with Sweden. Consequently, the Rajiv Gandhi government abruptly terminated the entire submarine acquisition program, dealing a significant blow to indigenous efforts and resulting in substantial fiscal losses. The subsequent Project 75(I) with France for the Scorpene-class submarines faced challenges, including cost escalations, delays, and disagreements regarding the extent of technology transfer. In the realm of underwater maritime propulsion, AIP technology holds a unique position, with its expertise even scarcer than that of nuclear propulsion. While India has successfully entered the exclusive group of nations capable of nuclear propulsion design and manufacturing, with assistance from Russia, AIP technol ogy still eludes its grasp. The indigenous

AIP project undertaken by the Defence Research and Development Organisation is currently underway and shows promising progress, with hopes for successful certification in the near future.

At present, Germany holds the top position globally in AIP technology. India faces the challenge of balancing its immediate tactical needs, such as the urgent induction of AIP-equipped submarines into the Navy, with the overarching strategic goal of bolstering indigenous AIP design and manufacturing capabilities for the long term.

Navigating this endeavor poses significant challenges, as expertise in underwater technology is closely guarded, with collaboration opportunities being scarce. The collaboration between China and Pakistan on the Hangor-class submarine exemplifies strategic cooperation between the two nations dating back to the 1970s. This partnership has posed challenges to Indian interests, highlighting the complexities of regional dynamics.

China, the biggest producer of steel in the world is impacting global economy

reing by far the largest owner of steelmaking ca-B pacity in the world and what automatically fol-lows the biggest producer, consumer and exporter of the ferrous metal, China will perforce leave a significant impact on the global working of the industry in all situations. According to the OECD Steel Committee, the world steel capacity rose 57m tonnes in 2023, marking the sharpest increase in a decade to 2.498bn tonnes. Accurate capacity data about China may not be available since there are producers in the unorganized sector whose operation is enveloped in obfuscation. But even then a safe guess is the world's second largest economy had steelmaking capacity of around 1.35bn tonnes by the end of 2023.

Armed with capacity of this order, China for the fourth straight year produced over 1bn tonnes of steel last year, almost identical to 2022 when global production remained unchanged at 1.888bn tonnes. In the face of slowing down of the economy manifest particularly in the construction sector taking toll of domestic steel demand. Chinese steelmakers turned aggressive in selling their products in the world market. Exports rose a robust 36.2m tonne year on year to 90.3m tonnes in 2023, a level not seen since 2016. In the past in 2015, China exported a record volume of 110m tonnes, a sharp rise from 91.3m tonnes the year before.

Besides dip in domestic demand. Chinese exports got a shot from tight international supply and competitive prices. Such large exports are inevitably disrupting international trade in the commodity and causing trade frictions. It will be recalled that there was a raft of antidumping measures by import afflicted countries in the wake of 2015 aggressive sales pitch by China.

Steelmakers around the world, including the ones in India, as a result, became wary of China. The leviathan that China's steel industry is will be producing over a billion tonnes in the next few years despite poor local demand to be left with no alternative but to offload much of surplus output in the world market with disturbing economic and political consequences for export tar-

geted countries. Remember, steel, in spite of all the advances in technology, remains a highly labour intensive operation.

In the meantime, Chinese exports are undergoing structural changes with the focus gradually shifting to high value-added products. For example, 14m tonne of hot rolled coils in the first nine months up to September last year far exceeded that of whole of the record year 2015. The phenomenon is having disturbing consequences for steelmakers in advanced economies such as Japan. Despite being the world's largest exporter, China also is an importer of steel products. Imports of 7.64m tonnes in 2023 marked a decline of 27.6 per cent over the previous year.

December average price of imports at \$1,569.6 a tonne gives an idea of the kind of steel the country is still required to import. Tata Steel MD and CEO TV Narendran expresses concern that if Chinese steel product exports remain at last year's level then that could bring pressure on "world steel prices impacting producer margins." At the same time, he talks about a more balanced Chinese approach to production and demand. Expectations are that Beijing moves to infuse life to property and infrastructure sectors will improve demand growth prospects for the metal.

Besides exerting pressure on prices, high volumes of Chinese exports, according to Narendran, have environment damaging impact as these leave in their trail "significant carbon emissions." He wonders if China exports of the current order are not at variance with the declared Beijing objective of progressively reducing carbon emissions. Premium available in the world market over domestic prices is one consideration for China to be a big exporter. But Narendran says: "There perhaps will be a bit more stability in China going forward, with potential production cuts or reduced exports due to because the prices they are exporting are not sustainable."

Chinese deceleration in steel production every month since December 2023 proves Narendran right. In the meantime, concerns about Indian imports of finished steel staying ahead of exports are leading local producers to seek intervention of New Delhi by way of safeguard measures against import surges in 2023-24. India with imports rising 38.1% to 8.3m tonnes in the past financial year turned into a net buyer of foreign origin steel, as its exports of finished steel were up 11.5% to .5m tonnes.

Indian producers are not comfortable that imports grew at that rate. In spite of this, New Delhi will not be rushed into building new barriers to imports in view of the continuing strong domestic demand. Indian use of steel rose an impressive 13% to a multi-year high 136m tonnes in 2023-24, the only country where demand continues to race ahead like that buoyed by focus on infrastructure and construction development. Automotive steel demand was also strong.

In contrast, Chinese steel demand is set to fall again this year. Narendran thinks gradual shift to investmentled growth from consumption-led growth in India is fuelling demand buoyancy for the metal. He and his peers in the steel industry in India are encouraged by budgetary allocation for the infrastructure sector going up by up to 30 per cent every year. At the same time, railways and gas pipeline development continue to receive significant investment. Thus, according to Narendran, "surge in activity across multiple steel-consuming sectors in India is a pointer to annual steel consumption growth expectation of at least 8 per cent." As the world noticed in China in better times in the past, steel demand in India "will be ahead of GDP growth rate, which typically hovers here around 7-7.5 per cent," says Narendran

Considerations of economies of scale and new capacity that keeps on coming on stream will be constraints to ration production. Even then, S&P Global Commodity Insights says the challenge of addressing global oversupply and weak profit margins (the phenomenon is universal) will see China steel production slowing by 0.5 per cent this year. Mysteel China, however, pegs the country's expected production squeeze at 0.3 per cent. In forecasts of this nature what is to be considered is whether Beijing will introduce additional stimulus measures to support the economy, which in turn could stimulate demand for steel. any parts of Asia including India wit-**V** nessed record-breaking temperatures and heatwaves in April this year. Now, a preliminary study released on May 15 shows that climate change made these heat waves more frequent, and more extreme.

As per the 'rapid study' by scientists associated with World Weather Attribution (WWA), a collective that studies the impact of climate change on extreme weather events worldwide, the heatwaves that swept across Asia were made more likely by climate change. Climate change also made the likelihood of such a heatwave occurring across south Asia - including India -45 times more likely and 0.85 degrees Celsius hotter than it would otherwise be, their report found.

Mercury rising across Asia Summer temperatures have been breaking records across the world. This April was the 11th consecutive month being the warmest for the respective month of the year, as per Europe's Copernicus Climate Change Service press release on May 7.

In India too, it has been no different: March-April 2022 was one of the hottest months in

more than a century in parts of India. The heat waves that parts of northern and northwestern India witnessed in April 2023 claimed several lives, apart from affecting crops, livestock and livelihoods. Looking at temperature data, scientists associated with WWA found that climate change - caused by human activity such as the burning of fossil fuels that release greenhouse gases into the atmosphere made the 2023 heat waves around 30 times more likely in

India and Bangladesh. On April 1 this year, the India Meteorological Department (IMD) warned that many parts of India would witness not just a hot but an abnormally hot summer. The IMD had also cautioned that the number of heat wave days that many regions witness would also be higher than usual.

And as the month unfolded, reports came in of heat waves across the country. Many parts of eastern India witnessed the hottest April on record, per reports. Several other countries in Asia – from Lebanon to Vietnam and Cambodia - too witnessed the impacts of heat waves.

Impacts of the El Niño

The team also studied the impacts of the El Niño Southern Oscillation (ENSO), a complex climate pattern influenced by fluctuating sea surface temperatures and atmospheric changes in the tropical Pacific Ocean, on the occurrence of the heatwave over south Asia. The ENSO can cause what are called El Niño years (usually characterised by weak monsoons and reduced rainfall in many regions including most of south Asia), neutral conditions and La Niña years (which are often cooler and wetter).

Though the past year has been an El Niño year, which means that temperatures can be higher and rains lesser, the impacts of climate change far overshadowed those that would be seen in a normal El Niño year.

While results of the study are not peer-reviewed yet, all such studies by the WWA are later peer-reviewed and there have not been any changes in the numbers, said Otto during the virtual press conference.

"All heat waves occurring today are made more hot, more frequent and intense due to climate change," Otto said. "So it is right to say that there is a climate change component in a heatwave if it occurs today."

While some countries – such as India – have heat action plans in place, there's more than needs to be done, per the report. Different sections of people are more vulnerable to the impacts of heat waves, and heat plans need to cover all vulnerable sections, with plans comprising "mandatory regulations such as workplace interventions for all workers to address heat stress, such as scheduled rest breaks, fixed work hours, and restshade-rehydrate programs", the report noted. These regulations are not yet part of worker protection guidelines in the affected regions, it said.

But...it's not over yet

India's tryst with heat waves this year, however, isn't over yet, even as its elections still continue.

While the IMD has predicted that the much-awaited south west monsoon is very likely to advance into the South Andaman Sea and some parts of southeast Bay of Bengal and Nicobar Islands by around May 19, heat waves are predicted across some parts of the country. As per a press release by the India Meteorological Department on May 14, northwestern India will witness a fresh heatwave from May 16 onward.

Severe heat wave conditions are "very likely" in parts of West Rajasthan on May 17 and 18, as well as in isolated pockets of Punjab and south Haryana on May 18, the release said. Heat wave conditions are likely to occur in some parts of the Konkan coast on May 14 and 15, and over West Rajasthan from May 15-18. Uttar Pradesh, Punjab, southern Haryana and Bihar will also likely witness a heat wave from May 16-18, as will northern Madhya Pradesh and eastern Rajasthan in the two days to follow.

# Dust devils in Mumbai, Delhi caused by merging wind systems

umbai on May 13 and Delhi on May 10, separated by 1,500 Km, experienced dust storms with extremely high wind speeds. Both the events occurred due to powerful storm systems that were fuelled by fierce external winds.

While two people were killed in Delhi and 23 were injured, 14 people were killed when a billboard collapsed in Mumbai.

There are multiple factors responsible for the formation of dust storms. "The prerequisite factor for the formation of any storm is heating of the land. Usually, heating of 4-5 days is needed for convection to form which develops into a storm," KJ Ramesh, former directorgeneral of India Meteorological Department (IMD), told Down To Earth (DTE).

"Once the storm forms, it is sometimes piloted by cold and dry downdraft winds that are downward facing and energetic, also aided by gravity. These winds can get very strong when they travel over hot surfaces caused by heating during summers," said Ramesh.

They precede the actual rainfall and

southwest direction towards Kalyan and Thane due to the prevailing winds,' Rushikesh Agre, an independent weather forecaster from Pune, told DTE.

The easterly winds were dominant over the normal westerly winds which flow in from the sea, according to Agre. Agre tracked the storm and said the storm system expanded and intensified around Badlapur due to a merger with another storm which was not expected.

"I was taken by surprise by the sudden intensification, as the wind speed recorded at Badlapur was around 107 kilometres per hour and the usual humidity of the region was lacking. It was quite dry at the time when the storm happened," said Agre. There were quite a few places that recorded wind speeds more than 100 km / hr. The last time Mumbai experienced an intense dust storm was in January 2022.

For Delhi, this was the first dust storm of the season. Dust storms are common events during the summer season for the city and the rest of north and northwest India, but the intensity of the winds was higher than normal this time.

The observatory at Delhi airport recorded a peak wind gust of 92.7 km / hr, according to independent weather forecaster Navdeep Dahiya on the social media platform X (formerly Twitter). The normal wind speeds during these dust storms are around 40-50 km / hr. During the record-breaking dust storms in 2018, which affected many northern. central and eastern states of India, wind speeds as high as 130 km / hr were fall and rainfall in the Himalayas.

DTE had reported that the intense and unusual dust storms that killed 423 people and injured 785 were caused by increased western disturbances, heating of northwestern India and the rapid warming of the Arctic region.

The further intensification of the winds that was witnessed in Mumbai and Delhi could also be because of the tunnelling effect caused by winds flowing in cities in valleys between high built up areas, according to Ramesh. In the case of Mumbai, the Western Ghats surrounding the region could have further enhanced the winds. "Tunnelling effect may increase wind speeds by up to 40 per cent during these dust storms," said Ramesh.

On May 10, there were two cyclonic circulations, one over Iran and the other over northwest Rajasthan, according to IMD. The weather agency predicted that these would induce dust storms over Uttar Pradesh, Haryana, Chandigarh and Delhi between May 10 and May 13 and over Rajasthan during May 10-11.

A cyclonic circulation is a swirl of winds in the lower levels of the atmosphere (troposphere), which is generally responsible for inducing storm systems

On May 13, IMD highlighted that a cvclonic circulation was lying over south-interior Karnataka region and a trough (an extended low pressure area) was existing between the circulation and northwest Madhya Pradesh. This could have had an influence on the dust storm in Mumbai. There were also other factors at play in both places. "An anticyclone is present over the Arabian sea. Winds, thus, become northerly which also became a favourable condition for the dust storm," said Rushikesh Agre.

"Anticyclones over the Arabian Sea and Bay of Bengal with their clockwise winds are bringing winds on shore all across India right now. These have been causing thunder / dust / hail storms, sometimes with rainfall, in many states in the west, south and east," said Ramesh.

"More of the winds over Delhi are coming from over upper Pakistan but the winds over Mumbai are sweeping in from the Middle East and lower Pakistan," Raghu Murtugudde, professor of climate studies at Indian Institute of Technology, Bombay and emeritus professor at University of Maryland, told DTE.

## **How climate** change is shaping democracy

That effect could the changing climate have on democracy? As India's 18th general election proceeds during the scorching summer, experts are concerned that heat waves and extreme temperature events could leave their mark on the democratic exercise. This is already a growing body of research on how climate events have shaped democratic institutions and nations.

In 1970, for instance, researchers say that the devastation left by Cyclone Bhola played a key role in triggering the formation of Bangladesh. The ineffective response of the Pakistan government to the devastation that left between 300,00 and 500,00 people dead,

emerge, climate change-induced extreme events may hurt the electoral process.

At the most basic level, the heat makes it difficult for parties to mobilise crowds at rallies. That was driven home on April 16 last year when 14 people died of heat stroke during at a state-supported event in Navi Mumbai.

Several concerns have emerged. How will candidates reach out to voters to convey their message in extreme temperature conditions? Are political parties and the Election Commission concerned about parties holding rallies and conventions in the heat? What about the heat mitigation strategy for security personnel and officers working to secure a fair election? Are the voting centres designed to be heat waveproof? Are election organising institutions providing water, cooling and medical facilities? Could heatwayes affect voter turnout? Heatwaves can have a delayed effect on political participation, according to a study led by University of Kent's Amrit Amirapu. It found that during state legislative assembly polls between 2009 and 2017 in some places in Western India, higher turnouts were observed because citizens turned out in large numbers to vote out incumbents who had failed to provide sufficient mitigation and adaptation support during a previous year's heatwave. However, in general, citizens avoided voting when temperatures were oppressive - especially if they were affluent urban resident. This year, for instance, the drop in voter turnout in the second phase of the election in Kerala to 71% from 77.8% was attributed to the high temperatures. A related concern is that many places across the country face power cuts during the summer. Are the authorities equipped to ensure that citizens exercise their right to vote in a safe, cool environment? It is essential for the Election Commission to make the process easier for voters by disseminating accurate risk alerts at the polling station level. The commission should start collecting data about how heat could possibly harm the health of citizens to help it prepare for future elections effectively. It is clear that if efforts to mitigate the effects of climate change are to be successful, it is essential for democracy to flourish. David W Orr argues in his book Democracy in a Hotter Time: Climate Change and Democratic Transformation that as citizens look to mitigate the effects of climate change. demanding for instance that thermal power plants be phased out, a people-centric transition to a post-fossil fuel future requires a functional democracy at all levels. # Strategic dynamics in a melting Arctic

The Arctic region is rapidly becoming a focal point of global geopolitics, propelled by the melting of sea ice due to climate change, which presents both opportunities and challenges. As the Arctic ice recedes, previously inaccessible resources such as oil, gas, and minerals become available, tempting major powers like the United States (US) and Russia, to exploit them. However, this exploitation comes at a cost—accelerated climate change due to increased greenhouse gas emissions. The long-term consequences of losing the protection offered by the Arctic sea ice would mean that the Earth would experience catastrophic global warming.

Analysing the dynamic of the Arctic from a strategic decision-making perspective underscores the imperative of maintaining the balance between cooperative efforts to safeguard the Arctic from the impacts of climate change and the individual pursuit of new resource opportunities arising from the melting sea ice. Rationality dictates that for the global commons to survive, all states should converge towards collective action for the long-term preservation of the Arctic.

To understand the dynamic, we must identify the key Arctic players. Firstly, there are the members of the Arctic Council-the primary intergovernmental forum on the Arctic, consisting of the US, Russia, Norway, Finland, Sweden, Denmark, Canada, and Iceland. Then, there are the emerging Arctic statesmembers of the Global South who have taken an increased interest in Arctic policy.

These are China, which is interested in gaining access to the Arctic's resources and has declared itself to be a "near-Arctic" state, and India, which is concerned about the scientifically-established connection between the loss of the Arctic sea ice and the increasing instability of India's monsoons.

Currently, much of the Arctic Council's work has been suspended as a result of the Western boycott of Russia due to its invasion of Ukraine. This divide is further exacerbated by the accession of Sweden and Finland to NATO, creating a "West and the rest" dynamic at the Arctic Council. All Arctic Council members have a rational interest in avoiding a further escalation of Arctic tensions to avoid spillover from the Ukraine conflict.

For Russia, pouring troops and resources into accessing Arctic bases and minerals creates a new flank that needs to be defended against NATO. Militarising an already volatile region, which in turn accelerates the loss of sea ice, will compromise Russia's ability to conduct the war in Ukraine, given it is already under pressure to break the grinding stalemate. Russia also lacks the capacity to access the Arctic's resources by itself, having been forced to turn to China and India for assistance in obtaining icebreakers to open shipping lanes in the Northern Sea Route.

Creating a scramble for resources in the Arctic will, therefore, place Russia at a competitive disadvantage to its Arctic peers who are not facing extensive trade sanctions and can acquire Arctic equipment without problems. On the other hand, working to protect the Arctic, even in a limited capacity, restores some of Russia's legitimacy on the world stage. While it cannot offset continued aggression in Ukraine, it would provide a rational foundation for Russia to be seen once again as a partner in Arctic governance.

For the remaining Arctic states, cooperation on Arctic climate protection diffuses tension in the region caused by the Ukraine war, which mitigates the current lack of defence capacity the US and NATO has in the Arctic. Cooperation also opens up new opportunities to work with emerging Arctic states like India, through the development of new initiatives on Arctic science. This is seen as strengthening the West's connection to India and towards opening new avenues for partnership to help counter Chinese influence.

More selfishly, the loss of Arctic permafrost due to climate change caused by human activity will release vast amounts of greenhouse gas emissions into the atmosphere. This would force the Global North to escalate its reduction in greenhouse gas emissions, as well as require further compensation to the Global South for loss and damage caused by the worsening impact of climate change. Protecting the Arctic slows down the rate at which the Western members of the Arctic Council would need to make the necessary cuts in emissions, buying them more time to phase out fossil fuels. There may be some concerns about cooperating with Russia even in a limited scientific capacity.

However, the cooperation between the US and Russia during the Cold War on space science in the 1970s shows that there is precedent for big powers coming together in the common interest of humanity even amidst a wider context of divided geopolitics. This scientific cooperation was crucial to the later development of the International Space Station.

The same form of cooperation today would be in the self-interest of Western Arctic states who can expand their Arctic scientific capacities while retaining their wider detachment from Russia.

We must also consider the possibilities from the perspective of emerging Arctic states such as China and India. For China, accessing resources in the Arctic as part of its "Polar Silk Road" initiative will increase existing tensions within the West regarding the disproportionate influence China is exerting on the global economy

On the other hand, working with current Arctic states would demonstrate China to be a credible leader in climate mitigation, without it having a major impact on China's economy. China can also strengthen and enhance its research capabilities in the Arctic by cooperating with Arctic states on science, which can open new sustainable opportunities for it within Arctic governance and policy. Arctic cooperation would therefore enhance China's claim to be a "near-Arctic" state.

For India, the rational interest in Arctic climate protection is even more clear-cut. Working with Arctic states on Arctic climate measures bolsters India's claim as the leader of the Global South, while also granting it a new role in Arctic governance.

More directly, it prevents further damage to the monsoons from the teleconnection to the loss of sea ice. The stability of the monsoons is critical to preserving India's agricultural sector, which ensures that it stays on track to become the third-largest economy in the world by 2030.

India also has first-class expertise in Arctic science and technology, having recently launched its first Arctic winter expedition in 2023. Using this expertise in climate research and monitoring would further strengthen India's role in the Arctic.

Ultimately, the outcome hinges on collective action to preserve the Arctic sea ice. While resource exploitation may offer short-term gains, the long-term consequences for the planet and each state's rational self-interest outweigh them. Therefore, prioritizing science-led cooperation to monitor and protect Arctic sea ice is paramount for ensuring a sustainable future for the region and the planet as a whole.

In conclusion, Arctic geopolitics necessitates collective climate action. A unified approach to climate protection can enable Arctic stakeholders to navigate these complexities and secure a sustainable future for the region and the planet. (Courtesy: ORF)

KYIV, May 15: Ukrainian President Volodymyr Zelenskyy postponed all his upcoming foreign trips as Ukraine's army battled to contain a front-line push by the Kremlin's forces, as US Secretary of State Antony Blinken on Wednesday visited a drone manufacturing facility in Kyiv on the second day of a visit meant to reassure Ukrainians of continuing American support.

Zelenskyy cancelled all foreign visits "that were planned for the coming days," his office said Wednesday on Telegram. The head of state instructed his team to reschedule the visits.

"We are grateful to our partners for understanding," the announcement said. Zelenskyy had been expected to visit Spain, and perhaps Portugal, later this week. No reason was given for his decision, but Ukraine is having a hard time fending off the latest Russian assault. Blinken also toured a grain transshipment facility and a bionics factory, praising Ukrainian innovation and ingenuity in the face of wartime difficulties.

"Ukraine has had to adapt and adjust to this and it's done so remarkably," Blinken said of grain exports now being taken by rail after traditional shipping routes were interrupted by Russia's fullscale invasion, which began on February 24, 2022.

**Russia says it downed 10 US-supplied missiles**

KYIV, May 15: Russia's Defence Ministry said that air defences shot down 10 US-supplied Ukrainian missiles targeting the Crimean Peninsula early on Wednesday, as US Secretary of State Antony Blinken spent a second day visiting Kyiv, and Ukraine's army battled to contain a front-line push by the Kremlin's forces.

The ATACMS long-range ballistic missiles were destroyed over the Black Sea, the ministry said. The US included the Army Tactical Missile System, known as ATACMS, in a military aid package in March.

The Ukrainian attack came as Russian troops pressed their offensive in northeast Ukraine's Kharkiv region that began last week, marking the most significant border incursion since the full-scale invasion began and forcing almost 8,000 local people to flee their homes.

Together with Moscow's weekslong effort to build on its recent gains in the eastern Donetsk region, the more than two-year war has entered a critical stage for Ukraine's depleted army.

Against that grim backdrop, with thousands of Ukrainian troops locked in fierce battles in towns and villages, Blinken on Tuesday pledged unceasing US support for the country, during and beyond the war. He also tried to lift spirits in Kyiv, performing on guitar with a band at a city bar and eating pizza at a veteranrun restaurant. Russia is opening new fronts in order to stretch Ukraine's army, which is short of ammunition and manpower, along the about 1,000-kilometre front line, hoping defences will crumble. Russian artillery and sabotage raids have also been menacing Ukraine's northern Chernihiv and Sumy regions.

Ukrainian President Volodymyr Zelenskyy said in his nightly video address Tuesday that the army has sent reinforcements to the Kharkiv and Donetsk re-

gions. "It is too early to draw conclusions, but the situation is under control," he said. Even so, Zelenskyy cancelled a planned trip to Spain later this week, according to the Spanish government. It gave no reason for the cancellation.

The pace of Russia's advance in the Kharkiv border region, where it launched an offensive late last week and has made significant progress, has slowed, the Institute for the Study of War said late Tuesday.

The Washington-based think tank said Moscow's main aim there is to create a "buffer zone" that will prevent Ukrainian cross-border strikes on Russia's Belgorod region. Blinken on Wednesday visited a drone manufacturer on the outskirts of Kyiv and toured a grain transshipment facility where Ukrainian grain is loaded into containers for export by rail.

Blinken praised the ingenuity of the process, which local companies adopted after traditional shipping routes were interrupted by Russia's full-scale invasion, which began on February 24, 2022.

"Ukraine has had to adapt and adjust to this and it's done so remarkably," Blinken said.

Meanwhile, Russian air defences shot down several Ukrainian missiles over the Black Sea and near the Belbek air base, Sevastopol Gov. Mikhail Razvozhayev said. Sevastopol is where the Russian Black Sea Fleet is headquartered.

The fragments of downed missiles fell into residential areas but caused no casualties, Razvozhayev said. Russian air defences also shot down nine Ukrainian drones, two Vilha rockets, two anti-radar HARM missiles and two Hammer guided bombs over the Belgorod region early Wednesday, the Defence Ministry said. Two people were injured in the village of Dubovoye when a Ukranian rocket set their house ablaze, according to Belgorod Gov. Vyacheslav Glad-

kov. The military said five other Ukrainian drones were downed over the Kursk region and three drones were shot down over the Bryansk region.

The Defence Ministry also said that another Ukrainian drone was downed over the Tatarstan region. Tatarstan is located more than 1,000 kilometres east of the border with Ukraine.

Vasily Golubev, the governor of the Rostov region, said two drones attacked a fuel depot. He said there were no casualties or fire.

Ukraine has launched a steady series of drone attacks on oil refineries and fuel depots across Russia over the past months, causing significant damage. (AP)

ISLAMABAD, May 15: An accountability court in Pakistan on Wednesday adjourned the hearing of the 190 million pounds corruption case against Imran Khan till Friday, citing "security concerns" at the high-security Adiala prison where the former prime minister is currently imprisoned, media reports said.

The 71-year-old Pakistan Tehreek-e-Insaf (PTI) founder has been lodged at the high-security Adiala Jail in Rawalpindi since August last year.

The Islamabad accountability court accepted the request of the Adiala Jail's superintendent to adjourn the hearing of the case against Khan due to 'security concerns', The Express Tribune newspaper reported. The court adjourned the hearing till May 17, it said.

In his request, the jail official cited reports received by the Punjab Home Department of the threat alerts on prisons in Puniab by banned organisations.

the official said that criminals involved in serious crimes, including high-profile political entities, are also incarcerated there. Security threats were also received for the Mianwali, Dera Ghazi Khan, Rawalpindi (Adiala) and Attock jails, said the request.

Following the reports, security was increased in and around the prison, and a mock exercise was also conducted by security forces there.

Surrounding areas were also being combed by security personnel, the paper said. On Tuesday, the Punjab Home Department imposed a ban on meeting of relatives and others with all prisoners in the Adiala Jail for three days owing to security concerns, the Dawn newspaper reported. A ban on providing any items to prisoners was also imposed.

PARIS, May 15: At least two people were killed and three were seriously injured overnight in the French Pacific territory of New Caledonia, French media reported Wednesday, as President Emmanuel Macron convened a meeting of top ministers to discuss the spiralling violence.

It was the third day of violent unrest over a constitutional reform pushed by Paris that has roiled the archipelago, which has long sought independence.

The special defence and security council meeting called by Macron on Wednesday typically brings together a limited group of officials, including Prime Minister Gabriel Attal and the ministers for defence, interior, economy and foreign affairs.

# Consultative mechanism helps enhance mutual cooperation between Nepal and India: FM Shreshtha

KATHMANDU, May 15: A consultative mechanism has been established between Nepal and India to facilitate cooperation in various areas of bilateral relations, Deputy Prime Minister and Foreign Minister Narayan Kaji Shrestha has said, asserting that such mechanisms have enhanced mutual cooperation and partnership.

"Cross-border connectivity is being expanded to facilitate trade and transit. We need to further expand and improve this network," Shreshtha was quoted as saying by the Himalayan Times newspaper on Wednesday.

Addressing the third series of lectures - themed 'Nepal-India Relations: Prospects and Pathways' here on Tuesday, Shreshtha said that a consultative mechanism has been established to facilitate cooperation in various areas of bilateral relations. Such mechanisms have enhanced mutual cooperation and partnership, he added.

Invoking the longstanding history of mutual friendship and cooperation between Nepal-

India that include geographical proximity; religious, cultural and linguistic relations; economic engagement and intensely flourished people-to-people relations, Shreshtha said that there are some bilateral issues that need to be resolved through dialogue and diplomatic channels.

"...there are some bilateral issues historically left behind that need to be resolved through dialogue and diplomatic channels based on historical facts and in accordance with the spirit of (being) good neighbours," Shreshtha said.

The exchange of high-level visits has

helped strengthen the relations and enhance partnership in many fields, he said.

"This will pave the way for taking Nepal-India relations to a new height, for which the Government of Nepal is committed," the Deputy Prime Minister said

Envisaging a "wider scope" for cooperation in various areas of mutual benefits, he said a partnership in the energy sector is important.

"Proper utilisation of Nepal's immense potential of hydropower generation can transform the development landscape of our region with clean energy.

Pointing that there is a lot of scope for cooperation between Nepal and India in the field of information technology, the Foreign Minister stressed the need to expand bilateral cooperation in the field of education, sci-

ence and techiology. Stating that Nepal's development and economic prosperity would also serve the interests of its neighbours, he said a peaceful

neighbourhood was Nepal's desire. The event was organised by the Ministry of Foreign Affairs in honour of former ambassador and former foreign secretary Prof Yadunath Khanal here. Khanal had served the nation as foreign secretary for two terms and ambassador to China, India and the United States. Nepal shares a border of over 1,850 km with five Indian states - Sikkim, West Bengal, Bihar, Uttar Pradesh and Uttarakhand. Land-locked Nepal relies heavily on India for the transportation of goods and services. (PTI)

## Thai prime minister promises investigation after activist died in detention

BANGKOK, May 15: Thailand's prime minister on Wednesday offered his condolences to the family of a young activist who died in detention after a monthslong hunger strike, amid a public debate on the country's justice system.

Netiporn "Bung" Sanesangkhom, 28, died on Tuesday after suffering cardiac arrest while she was being detained at Bangkok's Central Women's Correctional Institution on charges that included defaming the monarchy. She had been on a hunger strike to protest the revocation of her bail in January. Her death has prompted calls for reviewing a judicial process that allows people accused of politically-motivated, nonviolent offenses to be held for extended periods ahead of trial.

Prime Minister Srettha Thavisin told reporters that Netiporn's death was a loss that

no one wanted, and said he has ordered the Justice Ministry to investigate. Officials from the Corrections Department

said during a press conference on Wednesday that while Netiporn appeared fatigued following her prolonged hunger strike, she had been well and there was no sign that she would develop such critical conditions, and that they had done everything to try to save her life.

They also said the activist had already resumed eating, but refused to take other supplements that could help her body take nutrients better after fasting for so long. They declined to speculate on the possible cause of death until the autopsy results are released. An autopsy was carried out on Wednesday morning and the initial results are expected on Thursday, said Netiporn's lawyer Kritsadang Nutcharat. But Kritsadang told re-

porters that he doesn't believe the Corrections Department's version of events.

"She died in your arms. If she had been well, she wouldn't have died," he said, adding that the public should focus on the fact that Netiporn died while being detained, not whether she had been eating.

Netiporn was a member of the activist group Thaluwang, loosely translated as "breaking through the palace." Its members are known for aggressive campaigns demanding reform of the monarchy and abolition of the law that makes it illegal to defame members of the royal family.

Until recent years, criticism of Thailand's monarchy was taboo, and insulting or defaming key royal family members remains punishable by up to 15 years in prison under a law usually referred to as Article 112 of Thailand's Criminal Code. (AP)

On Tuesday, the French Interior Ministr sent police reinforcements to New Caledonia, which long served as a prison colony and now hosts a French military base. Four mobile gendarmerie squadrons are being deploved as reinforcements, including 15 gendarmes from an elite intervention unit. French broadcaster BFM reported that two people had been killed and three gravely injured in the unrest overnight.

French authorities in the territory said more than 130 people have been arrested since Monday in the violence that has raged across the archipelago, with decades of tensions between indigenous Kanaks seeking independence and descendants of colonisers who want to remain part of France.

Clashes between police and protesters have continued in and around the capital. Nouméa, despite a curfew and ban on gatherings.

Schools have been closed "until further notice" and the main airport, La Tontoura, "remains closed to commercial flights."

The territory's top French official, High Commissioner Louis Le Franc, warned that if calm is not restored, there will be "many deaths" in the Nouméa metropolitan area, where protests over the voting rights turned violent on Tuesday. (AP)

## Young South Koreans are increasingly drawn to Buddhism via social media-savvy influencers

SEOUL, May 15: A South Korean deejay dressed as a Buddhist monk bounced up and down on stage while playing electronic music and shouting: "This too shall pass!" The performance brought cheers from a crowd of thousands at an annual lanternlighting festival over the weekend to celebrate the Buddha's birthday.

Religious belief in South Korea has been on the decline for years. In 2021, just 22% of South Koreans in their 20s identified as religious, compared to 45% in 2004, according to a Gallup poll. But that might be changing as social media fuels an uptick in interest in Buddhism among young people.

The festival DJ, Youn Sung Ho, is a significant contributor to this trend. Youn, who is also a comedian, said he has received much support from the younger generations, especially Millennials and Gen Z, for his Buddhist monk alter ego, whom he calls NewJeansNim.

Youn said he created the persona last year when he was deejaying at the lantern-lighting ceremony. "I wasn't NewJeansNim at the time. I was the comedian Youn Sung Ho. It

#### **MSCW** chairperson to be appointed soon: M'laya minister

Also holding the IT policy of the country accountable, the minister said, "There are a number of lacunae in the IT policy being followed in this country, which is why people have free access to a number of sites, which actually encourage the trend of disrespecting women, abusing them and physically attacking them." SHILLONG, May 15: Meghalaya social welfare minister, Paul Lyngdoh has emphasized the need to detect and stop the supply of drug and other narcotic substances at the entry points to Meghalaya.

"I have pointed out to the deputy chief minister in-charge Home (police) that we need to increase our policing at the entry points. 70% of the narcotics that come to Meghalaya come from East Jaintia Hills district and policing in that district has to be strengthened," Lyngdoh told reporters. "But again that will only happen when the current recruitment to the police where about 3000 more personnel will be joining the police force and 500 volunteers of the home guards will also be employed. It is only when those things happen that we can actually effectively curtail the efficacy of the drug network," he said. He said that Meghalaya has one of the lowest police to civilian ratios in the entire country. Stating that the government had already declared a war against drugs, Lyngdoh said

that the fact that there has been more detention, more cases being unearthed and more of the violators being brought to book shows the efficacy of the government and of the various interventions that the government has announced. **IMPHAL, May 15:** Civil Society Coalition for Human Rights in Manipur and the United Nations (CSCHR) has strongly reacted to a recent statement of International Commission of Jurists (ICJ) regarding the deportation of 77 Myanmar nationals which the later termed it a forced deportation.

To date, there have been no instances of forcibly deporting any of the refugees or immigrants who entered Indian territory in Manipur.

Neither the government nor civil society organizations have any intention of mistreating these unfortunate people who fled their homes to save their lives. CSCHR convener Phulindro Konsam wrote a letter to the ICJ while giving a detailed account of the situation in Manipur pertaining to the immi-

# **Muslims divided over CAA narrative in Matua bastion**

Schism within Muslim community in Bongaon is palpable, mirroring the broader national discourse surrounding CAA

BONGAON (WB), May 15: In the Matua stronghold of Bongaon, considered the cradle of the citizenship movement that shaped the CAA, there's a diverse array of beliefs, aspirations, and divisions within the Muslim community.

The Matuas, a Hindu refugee community originally from East Bengal (now Bangladesh), has long been a dominant force in Bongaon's socio-political landscape. With their roots deeply entrenched in the struggle for citizenship rights, the CAA represents a beacon of hope, promising a pathway to citizenship for persecuted Hindu minorities from neighbouring countries like Pakistan, Bangladesh, and Afghanistan.

The Indo-Bangla border region, characterised by lush fields and tight-knit communities, is currently experiencing a notable split as political parties adopt contrasting positions on contentious issues, with apprehensions of NRC looming large. Juxtaposed against this narrative, Bongaon's Muslim population faces uncertainty regarding the CAA, adding to their challenges.

While some see it (CAA) as a compassionate Act to help persecuted minorities, others regard it as a means of discrimination, worsening already existing socio-religious



tensions

"What is the need for CAA when all of us are citizens here. How come we can cast our votes and have all necessary documents," said 62-year-old Amirul Mondal of Mallickpur village along the Indo-Bangla border in Bongaon.

Mintu Rahman, a weathered farmer with hands calloused from years of toil, voiced the fears of many. "Why target Muslims," he questioned, "When their roots run deep into the soil of this motherland? It is discriminatory that in CAA. Muslims have been omitted. All religions should have been allowed under the Act," he said.

The schism within Muslim community in Bongaon is palpable, mirroring the broader national

discourse surrounding CAA. On one end of the spectrum are those who vehemently oppose the Act, viewing it as an assault on the

secular fabric of the nation. They argue that the CAA, by explicitly excluding Muslims, contravenes the principles of equality enshrined in the Constitution, thereby marginalising an already vulnerable community.

Conversely, there are Muslims in Bongaon who, albeit reluctantly, express tacit support for CAA. Their rationale stems from a prag-

matic assessment of the socio-political landscape, where aligning with the dominant narrative might offer a semblance of security and accept-

"CAA is for persecuted minorities from neighbouring countries. The Act is about giving citizenship and not taking it away. Muslims like us who have been living here for generations are citizens of this country," Amirul Dafadar told PTI.

Amirul, BJP's booth president of Sayestnagar in Bongaon, has been tediously reaching out to every Muslim households in his area trying to apprise people about the "negative campaign" going on over CAA

"It is the TMC which is instigating the Muslims against the CAA. They are misguiding them," he said.

Moidul Sheikh echoed similar sentiments, emphasising that as long as their identity and citizenship remained unquestioned, people from the community should not worry about the Citizenship Amendment Act (CAA) as much as they did about the NRC in Assam. "If our rights and status are se-

cure, there is no need for undue concern regarding the CAA. We are opposed to NRC but not against CAA." he said. However, this support is often ac-

companied by a sense of apprehension, as they grapple with the moral implications of endorsing a policy that appears to "disenfranchise their community".

"Many people say that we are going against our community but it is not about opposing or supporting anything. It is about a humane approach," Moidul Sheikh said.

The recent enactment of the CAA has sparked fears of a potential NRC exercise that could leave many in the Muslim community vulnerable to statelessness.

With the implementation of the CAA, there is a looming fear that the NRC might follow suit, subjecting us to scrutiny and uncertainty about our citizenship status," Bapan Sheikh said, echoing the sentiments of many in Bongaon.

A large section of Muslim residents fear that they may face similar challenges in proving their citizenship, especially considering the lack of documentation.

"As Muslims are persecuted minorities, they have all their documents in place. They are very thorough about their documentation. In Assam also, we had witnessed a similar situation where more Hindus got omitted than Muslims," political analyst Maidul Islam said. (PTI)

#### Congress wanted to allocate 15 pc of budget to minorities, says PM Modi at poll rally

NASHIK. May 15: Prime Minister Narendra Modi on Wednesday alleged the Congress during its previous rule wanted to allocate 15 per cent of the government budget for minorities and vowed not to allow splitting of budget or reservation in jobs and education on the basis of religion. Addressing an election rally at Pimpalgaon Baswant in north Maharashtra's Nashik district in support of Mahayuti candidates -- Union minister Bharati Pawar (BJP) and Hemant Godse (Shiv Sena) -- the PM said splitting budget on religious lines was dangerous. The BJP's star campaigner maintained Dr Babasaheb Ambedkar, the chief architect of the Constitution, was firmly against religion-based reservation in jobs and education. Modi claimed the Congress, when in power at the Centre, had drawn up plans to allocate 15 per cent of the total budget to minorities. "When I was the chief minister (of Gujarat), the Congress had brought up this proposal. The BJP opposed this move strongly and hence it could not be implemented. But the Congress wants to bring this proposal again." he told the gathering. The PM asserted Ambedkar was against religion-based quota, but the Congress wants to take away reservation rights of SCs/STs/OBCs and give them to Muslims. "Modi is the chowkidar (watchman) of rights of deprived sections of society and will never let the Congress take away their rights," the BJP stalwart declared. Modi said the ongoing Lok Sabha polls are about electing a prime minister who takes strong decisions for the country. In the last 10 years, the PM said, his government has provided free ration, water, electricity, houses and gas connections irrespective of religion. "Welfare schemes are made for every one," he maintained. Without naming NCP (SP) president Sharad Pawar, Modi said, "An INDI alliance leader from Maharashtra knows the Congress is losing badly (in elections). So, he has suggested that small parties merge with the Congress so that it at least stands as an opposition party.

## **PoK is part of** India, we will take it: Shah

SERAMPORE (WB), May 15: Union Home Minister Amit Shah on Wednesday referred to protests in Pakistan-occupied Kashmir and said "PoK is part of India and we will take it". Addressing a rally in Serampore, Shah said while peace has returned to once trouble-torn Kashmir after abrogation of Article 370 in 2019, Pakistan-occupied Kashmir "now echoes with slogans of Azadi and protests.

"After the abrogation of Article 370 by the government in 2019 peace has returned to Kashmir. But now we witness protests in Pakistan-occupied Kashmir. Earlier slogans of Azadi were heard here, now the same slogans are heard in PoK. Earlier stones were pelted here, now stones are pelted in PoK," he said.

Hitting out at Congress leaders for not supporting the demand of taking over PoK, Shah said, "Congress leaders like Mani Shankar Aiyar say it should not be done as they have an atom bomb. But let me say this Pakistan-occupied Kashmir is part of India and we will take it."

LUCKNOW (UP), May 15: Congress president Mallikarjun Kharge announced Wednesday that if the INDIA bloc is voted to power, it will double the quantity of free rations provided by the BJP government to the poor.He referred to the Modi govern ment scheme providing five kilograms of ration to the poor every month and said, "The Congress brought the Food Security Act, you did nothing." "You are giving five kg, if INDIA bloc government is formed, we will give 10 kg of ration to the poor," Kharge said, addressing a joint press conference here with Samajwadi Party chief Akhilesh Yadav. "I am saying this with guarantee because we have already done it in states, including Telangana and Karnataka," he added. In a campaign speech recently, Congress leader Priyanka Gandhi Vadra had pitched for more employment opportunities for youngsters, saying the Modi government's scheme to provide free ration to the poor every month was not a solution. "This will not build your future, this won't make you self-reliant," she had said. BJP leaders, including Prime Minister Narendra Modi, list the government's free ration scheme in every political rally. The party has even mentioned in its manifesto that it will continue the scheme till 2029 after coming to power. (PTI)

# Himachal: Poll officers traverse tough terrains to make each vote count

SHIMLA, May 15: Each vote counts, and the truism is not lost on the polling officers, some of whom take the long precarious road to bring democracy to the far-flung and frugally populated areas, such as Bara Bhangal of Himachal Pradesh, which has all of 63 voters.

The journey involves trekking for two days on a perilous mountain path, braving several landslide-prone stretches, and avoiding falling into the imperious Ravi River, which flanks the road.

Located in Kangra district, Bara Bhangal has little to offer in way of comfort in everyday life, and conducting elections should not be an exception.

Just so any weather caprice does not thwart the polling, the election office sends two teams via two different routes to Bara Bhangal - one team is airdropped in the area in Baijnath and the other treks for two days on foot.

Another area which tests the mettle of polling officers is Sat Kuthera of Fatehpur, where it takes a 5.5 km boat ride to



reach the polling station. Dr Surjit Saroch, a polling officer who was part of a team in the 2019 Lok

The team, which included porters and mules, walked for two days on the hazardous narrow footpath with a bellowing Ravi River flowing beneath and shooting stones rolling down from the hilltop, Saroch recalled.

Rakesh Chandel, the polling officer who supervised the assembly polls in Bara Bhangal in 2022, said he felt he had left the world behind when he reached the area.

"With solar panels being the only mode of electricity and no communication devices except the satellite phone given to the polling officer, we felt we were cut off from the rest of the world," he said.

"We were fortunate to be airdropped to Bara Bhangal but flying across the Dhauladhar mountain range amid clouds and against strong winds was a nerve-racking experience," he added.

Poll officer Rajesh Kumar recalled that there was no light and they had to carry inverters/generators on a boat to Sat Kuthera, which has around 100 vot-

"There was no school there and we stayed at a temple and came back the third day," Kumar, one of the members of the polling party which conducted voting in the area in the 2022 assembly polls, said.

The 63 voters of Bara Bhangal have been given the option to vote in the area or at a polling station in Bir.

Reaching Bara Bhangal will not be easy this year considering the landslides and washing away of bridges last monsoon.

According to state Chief Electoral Officer Maneesh Garg, parts of Lahaul and Spiti and Kinnaur, Pangi and Bharmaur in Chamba, and Dodra Kwar in Shimla district remain cut off due to snowfall, which takes place throughout May, and this is one of the reasons the polling in the state is being held in the last phase on June 1.

In 2019, the voting for Lok Sabha polls was held in the last phase on May 19. *(PTI)*

# **Rajasthan mine collapse: Chief vigilance** officer of Hindustan Copper dies, 14 rescued

JAIPUR, May 15: Hindustan Copper Limited's Chief Vigilance Officer Upendra Kumar Pandey died after a lift collapsed at a mine in Rajasthan's Neem Ka Thana, police said on Wednesday.

Fourteen others were pulled out and sent to a hospital in Jaipur in a rescue operation that lasted several hours following the accident Tuesday night.

An HCL vigilance team from Kolkata and others were being lowered down a shaft in a "cage" Tuesday night when its cable snapped, trapping them at a depth of 1,875 feet, police said.

Additional Director General (ADG) of Rajasthan Police Anil Paliwal said the rescue team recovered the body of Chief Vigilance Officer Pandey from the mine.

A vigilance team of 15 personnel of HCL, a Central government enterprise, had gone down the mine for an inspection and while returning, the cable of the cage broke, police said, adding the rescue team pulled out the personnel in multiple rounds on Wednesday.

In a statement, the HCL said, "An accident occurred at Kolihan copper mine of Khetri Copper Complex (a unit of HCL), Khetrinagar, Rajasthan at around 7.30



pm on May 14."

It further said that in the accident, one person died and 14 others suffered serious injuries. The company is taking all steps to bring normalcy and resume operations at the mine. In Delhi, Mines Secretary V L

Kantha Rao said an inquiry will be ordered in the incident. "I had been in the same lift a few months back. It was all good...we will get an enquiry done and find out what happened," Rao told re-

Earlier, police said the SDRF control room received information about the incident at around 10 pm on Tuesday following which a rescue team was rushed from Jaipur. SDRF team commander Ravi Verma along with nine jawans and the rescue team of HCL reached the injured with the help of another lift.

They gave first aid to the seriously injured and brought them from -72 metre level to zero metre level (sea

level) with the help of a trolley, police said. The injured were taken out to the base at plus 64 metre level with the help of an improvised stretcher, a pulley and a rescue rope.

Thereafter, the injured were taken out from the base by mine vehicles and sent to the hospital, police said, adding three people were taken out in the first round, five in the second round, and the remaining seven including Pandey were taken out in the third round.

Pandey had taken charge of the CVO of HCL in June last year.

The 14 personnel who were rescued are Khetri Copper Complex unit head GD Gupta, Kolihan Mine Deputy General Manager AK Sharma, Senior Manager Vidyut Vinod Singh Shekhawat, Assistant Deputy General Manager AK Bera, Chief Manager (Mine)Arnaya Bhandari, Assistant Deputy General Manager Yashoraj Meena, Assistant Deputy General Manager (Vigilance) Vanendu Bhandari, Photographer Vikas Pareek. Senior Manager Research Niranjan Sahu, Security Officer Karan Singh, Manager Preetam Singh, Senior Manager Mine Ramesh Narayan Singh, Harsi Ram and Bhagirath.

SC slams Uttarakhand for 'lackadaisical' approach in controlling forest fires, calls chief secretary

NEW DELHI, May 15: Slamming the Uttarakhand government for its "lackadaisical" approach in controlling forest fires, the Supreme Court on Wednesday directed the state's chief secretary to personally present himself before it on May 17 to give explanation, including on utilisation of funds and vacancies in forest department. Terming it a "very sorry state of affairs", the apex

court said the state was just trying to find some excuse or the other. A bench headed by Justice B R Gavai directed that the

staff and vehicles of the forest departments of states shall not be requisitioned for election purposes or any other purposes like the 'Char Dham Yatra'.

'We are at pains to say that the approach of state of Uttarakhand in controlling the fires is, to say the least, lackadaisical. Though action plans have been prepared and finalised, no steps are being taken for implementation of the same," said the bench, also comprising Justices SVN Bhatti and Sandeep Mehta.

The top court was hearing a plea on raging forest fires in Uttarakhand. The bench said when funds from the Compensatory Afforestation Fund Management and Planning Authority (CAMPA) were available and also sanctioned by the central authority, it saw no reason as to why only ₹ 3.41 crore out of the ₹ 9.12 crore was utilised for forest related activity in Uttarakhand in 2023-24. The bench observed it also saw no reason as to why the balance amount was not utilised for forestry.

"Another issue that needs to be addressed is with regard to huge vacancies in the forest department of the State of Uttarakhand," it said.

The bench noted that one of the grievances raised by the state was regarding failure of timely disbursement of the national disaster management fund or state disaster management fund.

"We fail to understand as to how state could have grievance with regard to the disbursal of state disaster management fund in as much as it is within the domain of the state to disburse the said funds," it said.

"It is further pertinent to note that at one hand, the state contends that the resources, that is, manpower and vehicles are not available, and on the other hand, keeps large number of vacancies...," the bench observed.

It said taking into consideration the importance of controlling forest fires in Uttarakhand, the apex court had requested Additional Solicitor General (ASG) Aishwarya Bhati to take instructions with regard to disbursement of funds for financial year 2023-2024.

The bench said in so far as CAMPA funds are concerned, it has been submitted that these funds are lying with the state and it was for the state to release them for works undertaken by the forest department.

It noted that as far as exemption of field officials of the forest department from election duty, Char Dham yatra and other related activities was concerned, the Election Commission by various orders has already exempted its staff and vehicles from elections and allied purposes. "Be that as it may, we direct that in all the states, the forest staffs as well as the forest vehicles shall not be requisitioned for election purposes or any other purposes like 'Char Dham Yatra'," the bench said.

It also directed the Centre to explain its position with regard to timely disbursement of the national disaster management fund and funds under centrally sponsored schemes

"We direct the chief secretary of state of Uttarakhand to personally remain present in this court on May 17...,' it said. The bench said the chief secretary shall explain as to why CAMPA fund of only ₹ 3.4 crore was released for financial year 2023-24 when the Centre had sanctioned ₹ 9.12 crore.

"It shall also be explained as to whether the said fund is being utilised for some other purposes which are not related to forest activities," it said. (PTI)

## J&K High Court modifies interim order to pave way for stalled key police projects

JAMMU, May 15: The High Court of Jammu and Kashmir and Ladakh has paved the way for the construction of key police projects involving national security matters, modifying an interim order passed in March last year.

The interim order had stalled important police projects such as the construction of a battalion headquarters in Kishtwar and an anti-corruption bureau office in Udhampur.

"The court is of the opinion that to buttonhole the project is in nobody's interest but is only antithetical to public interest...the project, in question, relates to larger public interest, more so, when the question of national security is involved," Justice Wasim Sadiq Nargal said in his 12-page order passed last week.

The court said the respondents had "misinterpreted the staying of the communication as a stay on the entire tender process".

The bench said was hearing an application filed by Senior Additional Advocate General Monika Kohli on behalf of the government, seeking vacation of the interim order passed by the high court on March 1, 2023 on a petition filed by a contractor.

The contractor had moved the court over a communication issued on February 20, 2023 stating that the progress executed by the petitioner's firm was less than ₹ 10.5 crore and requested that all the related correspondence made earlier be treated as 'null and void'. This resulted in withdrawal of all the earlier certificates

#### Woman stabbed to death over rejection of love proposal in K'taka new lease of life to three ill soldiers

HUBBALLI (KARNATAKA), May 15: Just weeks after college student Neha Hiremath was stabbed to death by her former classmate, a 21-year-old woman was murdered inside her house by an acquaintance here for allegedly rejecting her love proposal on Wednesday.

Vishwa alias Girish Sawant, 23, knocked on the door of Anjali Ambigera's residence at Veerapur Oni area here at around 5.45 am. When she opened the door, Girish stabbed her to death with a knife and fled the place, a senior police officer said, adding that her sister was a witness to the brutal murder. A case of murder under Section 302 of the Indian Penal Code has been registered against the accused, police said, adding that teams have been formed to nab him.

Neha Hiremath, 23, was stabbed to death by her former classmate Favaz Khodunaik

inside her college campus in Hubballi on April 18. "Girish was harassing my sister Anjali for sometime now. He expressed his love to her but my sister declined. He even pressured my sister to go with him to Mysuru. He had also threatened her that she will meet the same fate as that of Neha Hiremath," Anjali's sister Yashodha told reporters here. "When we informed police about his threats, they didn't pursue it seriously and today see, my sister is dead," she said. Anjali's family and local residents staged a protest here demanding strict action against the accused. Later, the police reached the spot and dispersed them, assuring them that justice will be delivered.

Anjali's father Mohan said that around seven months ago she had told them that Girish was harassing her. "I had warned him (Girish). But today morning, unfortunately my daughter was murdered by this same person. The accused has to be punished," he said. No girl should be in the situation that Anjali has been in, her family said, and demanded strict action against the accused who is still at large.

Meanwhile, Congress Councillor Niranjan Hiremath -- father of Neha -- met the deceased's family and slammed the state government over the "deteriorating" law and order situation in north Karnataka and also sought suspension of Police Commissioner of Hubballi-Dharwad Renuka Sukumar for alleged "failure'

(*PTI*) CHANDIGARH, May 15: Three critically ill soldiers have got a new lease of life, thanks to the family of a retired subedar which took the decision to donate his organs after he was declared brain dead following a brain stroke. After the subedar's death on Tuesday, the harvested organs were airlifted by the Indian Air Force to Army's Research and Referral Hospital in Delhi.

The organ retrieval and transplant team of Army's Command Hospital, Chandimandir performed a multi-organ harvest procedure on the 70-year-old subedar, a resident of Palampur in Himachal Pradesh, according to an official statement here on Wednesday. He had served for 30 years in the Jammu and Kashmir Rifles of Indian Army, it said.

"He was declared brain dead in the ICU due to brain stroke. The next of kin of the deceased decided to donate the liver, kidneys and cornea, which has given a new lease of life to three soldiers, who were critically ill," the statement added.

The transplant team carried out an overnight marathon operation Tuesday night for the retrieval of organs from the deceased. The organs were transported it via a green corridor to Army Hospital (Research and Referral), Delhi Cantonment within one hour, the release said.

The transplant team was led by Brigadier Anui Sharma, Professor and Head of surgical team and Chief Transplant Coordinator, Colonel Anurag Garg. (PTI)

## PEC condemns murder of UP journalist, Over a fifth of excess deaths linked to heatwaves demands punishment to perpetrators over past 30 years occurred in India: Study



**HT Correspondent** GENEVA, May 15: Press Emblem Campaign (PEC), the global safety and media rights body, strongly condemns the murder of Ashutosh Srivastava, an Indian journalist based in Uttar Pradesh, on 13 May 2024 and demands a fair probe to identify and punish the perpetrators under the law of the land. Ashutosh (45), who hails from Jaunpur locality, was associated with nationalist news channel Sudarshan News and he was targeted by miscreants on the outskirts of the city. He was sent to a nearby hospital but the attending doctors declared him dead. Soon

after he received threats for a series of reports on illegal cow slaughtering incidents, Ashutosh even urged the local police for protection, but in vain.

"Ashutosh Srivastava is the 46th victim among journalists killed since 1 January this year. We urge the Uttar Pradesh government led by hardliner Hindu nationalist Yogi Adityanath to investigate the murder and book the culprits for legal punishment. PEC also extends the local scribe's body named Jaunpur Patrakar Sangh in its fight for justice to the victim," said Blaise Lempen, president of PEC (https://pressem-

blem.ch/pec-news.shtml), adding that the local media organisations have demanded the government in Lucknow to offer Rs 5 million to the bereaved family.

PEC's south Asia representative Nava Thakuria revealed that five journo-casualties have been reported this year where Pakistan lost three scribes (Maulana Mohammad Siddique Mengal, Jam Saghir Ahmed Lar and Tahira Nosheen Rana) along with one (Ko Myat Thu Tun) in Myanmar. Last year India witnessed the killing of journalists namely Shashikant Warishe, Abdur Rauf Alamgir and Vimal Kumar Yadav.

NEW DELHI, May 15: More than 1.53 lakh deaths a year were associated with heatwaves around the world, with over a fifth of these deaths - the greatest share - coming from India, according to new research looking at data over 30 years since 1990.

India was followed by China and Russia, with each experiencing roughly 14 per cent and 8 per cent of these heatwave-linked excess deaths, respectively.

The study, led by Monash University, Australia, found that heatwave-linked excess deaths accounted for about a third of all heat-related deaths and 1 per cent of total deaths globally.

Researchers also found that of the overall 1.53 lakh excess deaths occurring every summer, close to half came from Asia and more than 30 per cent from Europe.

Further, the largest estimated death rates (deaths per population) were seen in regions with dry climates and lower-middle incomes. The findings are published in PLoS Medicine.

"During the warm seasons from 1990 to 2019, heatwave-related

across 43 countries.

Comparing the decade up to 2019 with that up to 1999, the duration of heat waves each year was found to have extended from 13.4 to 13.7 days on average around the world, with average ambient temperature warming by 0.35 degrees

The researchers said that while previous studies have quantified

excess deaths due to heatwaves locally, they have not compared these estimates across the globe over a prolonged duration.

"Heatwayes are associated with substantial mortality burden that varies spatiotemporally (with space and time) over the globe in the past 30 years," the authors wrote.

The findings show that government actions taken to enhance health sector adaptation and resilience can have potential benefits, the authors said.

They called for a "comprehensive approach" tackling not only immediate health risks during heatwaves but also implementing long-term strategies to minimise vulnerability and inequalities across communities.

"The strategies include climate change mitigation policy, heat action plans (e.g., heat early warning system), urban planning and green structure, social support program, healthcare and public health services, education awareness, and community engagement and participation," the authors wrote. # Is it time to worry about another trial, or start preparing for Olympics, asks Aman Sehrawat

NEW DELHI, May 15: Aman Sehrawat, the lone male Indian wrestler to have qualified for Paris Olympics, finds it annoying that instead of shifting his focus on preparing for the Games, he still has to worry about cutting his weight to prepare for another round of trials.

The 20-year-old Under-23 world champion saved India the blushes by securing a berth in men's freestyle 57kg for the Games at the recent World Qualifiers in Istanbul. In 11 other weight categories where the country's male wrestlers competed, India drew a blank as none of them could qualify.

"So many times I have cut my weight. How many times I have to do it? It causes a lot of

weakness. I don't understand do I think of now winning trials again or start preparing for Olympics. I think the work I need to put for a good preparation will be affected if I am asked to go through the trials again," Aman told PTI in an interview.

"By the time trials are finished, Olympics will be almost there, so when do we start preparations? In my opinion trials should not be held," said Aman, whose natural body weight is 62kg.

Aman, who is Asian Games bronze medallist and Asian Championships title winner, is confident that he will be in reckoning for a medal at the Games

"I see myself in top-3 in the world. Russia and Albania are strong and it will be close with them, others I can manage," he said. Aman had lost to Albania's Zelimkhan Abakarov in the 2023 World Championship where Serbia's Steven Andria Micici had emerged champion. Zavur Uguev, the two-time world champion from Russia is also a strong wrestler, who had defeated Ravi Dahiya in the Tokyo Games gold medal match. Most probably Aman will have to beat Ravi Dahiya when the Wrestling Federation

of India (WFI) holds trials. Ravi, and the other top-3 wrestlers in men's 57kg category at the last trials held in Sonepat, will have to compete



against each other and the winner among them will fight it out with quota winner Aman.

"I would have already left for Russia for training if not for these trials. It is better that I

train abroad with good wrestlers. I think I have done enough training in India and now it's time to train and spar with my competitors.

"That will prepare me well

for Olympics. I will get a fair idea about my rivals," said Aman, who joined the Chhatarsal Stadium at the age of 10 and has been making a steady progress.

Aman argues that it's not just weight-cut that troubles wrestlers. "Recovery is also very important. Trials, weightcut and recovery will eat up a lot of time before Olympics if trials are held again," he said. Aman also understands the weight of expectations. He is considered the next big thing in Indian wrestling and he is aware of that.

"I hear a lot of things about me. People have expectations now from me. I felt very bad helps in practice," said Aman. when I could not qualify at the (PTI)

HYDERABAD, May 15: Masters of their own fate right now despite being erratic, Sunrisers Hyderabad will hope their destructive batting line-up delivers when they take on Gujarat Titans in pursuit of a playoffs berth in the Indian Premier League here on Thursday.

Another win will be enough for Sunrisers to seal a playoff berth as they need only one point to ensure qualification.

But the Pat Cummins-led side will also want to challenge for the top two spots, which is a possibility considering they have one more game after this match and a healthy net run rate of +0.406. SRH have 14 points from 12 matches and can reach a maximum of 18 points, which may be enough to ensure a top-two finish if other results go their way.

Not only are the Sunrisers players well-rested ahead of the clash against GT as they got a week off, their morale will also be sky high after notching yet another record-breaking win against Lucknow Super Giants on May 8.

If the bowlers did a commendable job to restrict LSG to a blow-par score, the opening duo of Travis Head and Abhishek Sharma made a mockery of the hosts by chasing down 166 in just 9.4 overs to notch a 10-wicket win at home.

SRH have made a habit of securing unbelievable victories throughout the season but they have also suffered sizeable defeats, including against GT (by 7 wickets) earlier in the competition.

The boom or bust approach by the bat-

NEW DELHI, May 15: Sunrisers Hyderabad's South African import Aidem Markram believes Abhishek Sharma's destructive IPL form would fetch him an India cap in the not so distant future.


Sharma, who is striking at over 200 in the ongoing edition, has 401 runs in 12 matches. He and Australian Travis Head make for an explosive opening pair and most recently chased down over 160 runs in a less 10 overs against Lucknow Super Giants. Markram, who is the captain of the South African team, described the duo as "brothers of destruction" in an interview to PTI Videos.

"Abhi (Abhishek) has made massive strides this season. He was showing some really positive signs in the previous seasons and what he's achieved so far this season puts him in good stead for hope-fully representing India one day," Markram said of the 23-year-old left-hander. "He's got a very calm and level head on his shoulders and he'll take everything in his stride. But my fingers are certainly crossed for him to go to higher honours," he added.

Joining the debate surrounding the impact player rule, Markram said that the addition of an extra batter in the line-up has allowed teams to adopt a more aggressive approach.

'Naturally, when you have that extra batter in your batting line-up, you feel more freedom as a player. And obviously from the start of the innings, the openers feel that extra bit of freedom as well," he

"But definitely someone like Bhuvi leading from the front, as he's done for many, many years, has been excellent for you," he added. Markram hasn't had the best of seasons so far and has managed 199 runs from nine matches so far. The 30-year-old said he is happy with the effort he is putting into his game.

"I'm still feeling really good. IPL is a tough beast to crack and you as a player have to appreciate that. It's all for good reasons. For me, it's spending lots of time working on my game, working hard off the field as well.

# Pakistan has mental block when it comes to playing India in WC: Misbah

NEW DELHI, May 15: Former Pakistan captain Misbah-ul-Haq believes his country will find it difficult to edge past India when the two sides clash in next month's T20 World Cup as there seems to be a "mental block" when it comes to playing the arch-rivals in ICC events. India and Pakistan will clash on June 9 in New York in arguably the most awaited league stage match of the T20 World Cup that begins on June 1 in the Americas. India have lost to Pakistan just once (in 2021) in seven T20 World Cup matches.

'You call it Pakistan's jinx or mental block when it comes to playing India in World Cups. Pakistan will need to do a lot because this is a very skilled Indian team with a powerful bowling line-up and two good spinners," Misbah said on 'Star Sports Press Room' on Wednesday.

"India has quality fast bowlers in (Jasprit) Bumrah, (Mohammed) Siraj and Hardik (Pandya). The Indian cricket team's quality has risen many folds. It will be difficult to break, mental attitude matters a lot and Australia handles the mental side the best way.

"There is no pressure of excess baggage with Australia, and it needs to been seen how both India and Pakistan handle that pressure."

Misbah said Virat Kohli, who has played some memorable knocks against his country, will once again be a major threat even though there has been considerable chatter surrounding his strike rate in the ongoing IPL.

"Kohli is going to be a big factor. He has damaged Pakistan many a times. He



enjoys supremacy over Pakistan mentally. He takes motivation from big occasions and not pressure," he said.

"The Virat Kohli effect will definitely be there. He is a top-class cricketer. He is one player who can win you matches, strike rates don't matter. Good players take motivation from those voices or criticism.

Misbah still hasn't forgotten the ill-executed scoop shot in the inaugural T20 World Cup final against India in 2007.

With Pakistan needing just six runs to win from the last four balls, Misbah attempted that shot over fine leg which was caught by S Sreesanth as Pakistan crumbled to 152, chasing a target of 157, handing India the trophy.

But Misbah said that tournament was responsible for the rapid growth of T20 cricket.

"In 2007 T20 World Cup, all teams were not so serious. India handed captaincy to a young (Mahendra Singh) Dhoni. But the final between India and Pakistan, the greatest rivalry in the history of cricket. The hype that T20 got after that World Cup is immense. "The way T20 cricket flourished, I

feel whatever we achieved and the current players are now plying their trade in different leagues and IPL is something great," he said.

Speaking on the same platform, former India off-spinner Harbhajan Singh said Rohit Sharma can emulate Dhoni's 2007 feat, provided the team fires collectively in the Americas.

"Rohit sharma alone can't win the cup, it is about we and not me. The more we play like 'we', you can achieve anything," he said. Harbhajan also said the long and tiring IPL will definitely have an impact of Indian players' performance and advised Rohit and Co. to consider the World Cup as an extended part of the cash-rich league.

"IPL is a tiring tournament, travel is very tiring. The players will be physically and mentally a bit tired but they need to look at it is an extended part of IPL. "There is nothing bigger than World Cup, you need to give your best, you have to be switched on the given day. You have to bowl well, bat well and field well," he said.

"Winning a world cup is not going to be easy, you have to be mentally strong." Harbhajan, however, refused to speculate on the pitches being prepared for the World Cup.

"Pitches nobody knows, how long they will last. Practice matches will give an idea about team combinations.

Former India pacer S Sreesanth added: "Two spinners is our strength. Hardik (Pandya) as third seamer, and two fast bowlers. India has a very strong batting line-up." (PTI)
