AIZAWL, May 29: The death toll in multiple landslides in Mizoram's Aizawl district mounted to 29 after four more bodies were recovered from various places, a police officer said on Wednesday.

Seven people are still missing and rescuers presume that they are trapped under the debris at different locations following landslides and incessant rain in the aftermath of cyclone Remal on Tuesday, he said.

A total of 25 bodies, including 14 from a stone quarry collapse site, were recovered till May 28 night. After four more bodies were found since late Tues-

day night, the toll in a stone quarry collapse site at Methum has risen to 15 and that at Hlimen to five, Aizawl superintendent of police Rahool Alwal said.

Three bodies were found at Aizawl's Salem Veng locality, two each at Falkawn and Aibawk villages and one each at Lungsei and Kelsih villages on Tuesday, he said. Of the 29 victims, 23 are Mizoram residents, five people are from Jharkhand and one from Assam's Silchar town, according to Alwal. Among the deceased are a four-year-old boy and a six-year-old girl.

Aizawl deputy commissioner Nazuk Kumar said that search and rescue operations are still on and will continue till all missing persons are found.

She said that teams of the National Disaster Response Force (NDRF), State Disaster Response Force (SDRF), police and fire department have been deployed in the search and rescue operations. The state capital was cut off for several hours from the rest of the country on Tuesday due to a landslide on National Highway-6 at Hunthar in the western part of the town.

In Aizawl town, cemeteries at Republic Veng, Kanan Veng and Kulikawn were damaged by the landslides. Officials said that the state capital witnessed no rain since morning on Wednesday. The Mizoram government ordered the closure of all offices and PSU units except those departments involved with disaster management and essential services on Wednesday in view of the inclement weather warning issued by the IMD. General administration department commissioner and secretary K Lalthawmmawia in an order also advised the private sector offices to adopt 'work from home' mode as far as possible.

Mizoram chief minister Lalduhoma announced ₹4 lakh ex-gratia for the families of those killed in the calamities. He said that his government has earmarked ₹15 crore to tackle the disaster. More than 150 houses have been destroyed, dozens of trees and electric poles were uprooted, several roads were blocked and over 50 dwelling units were submerged across Mizoram in rain and landslides, officials said. # Extend all possible assistance on war footing, DCs directed

Himanta reviews post-Remal situation in Assam • Cyclonic storm claims 4 lives

NEW DELHI, May 29: Chief Minister Himanta Biswa Sarma on Wednesday reviewed the situation arising in his state in the wake of heavy rains and landslides that took place after the landfall of cyclone Remal, officials said.

Sarma, who was in the national capital, held a video conference with top officials of the state government and cyclone-affected districts, and instructed all concerned to be on alert to respond to exigencies at the quickest possible time in view of India Meteorological Department (IMD) forecast of heavy to very heavy rainfall. The chief minister directed district authorities to leave no stone unturned to reach out to the affected people and extend all possible help and assistance.

So far, four people have died and 18 others have been injured in Assam due to heavy rains and storms in the aftermath of the cyclone that left a trail of destruction

The chief minister asked the chief secretary and other officials to make a proper assessment of the full and partial damage to infrastructure and properties caused by cyclone Remal, the official said. # 191 BJP, 143 Cong LS poll candidates face criminal cases: ADR

NEW DELHI, May 29: Out of the 440 BJP candidates contesting the Lok Sabha polls, 191 have declared criminal cases in their election affidavits, according to an analysis by a poll rights body.

For the Congress, out of its 327 candidates, 143, or 44 per cent, have declared criminal cases, the Association for Democratic Reforms (ADR) said in a report based on data compiled from the affidavits on the Election Commission's website. The cases, it said, include those related to murder, attempted murder, crimes against women and hate speech.

The ADR said the data obtained from the poll panel's website reveals that a "significant portion of candidates contesting in the elections have self-declared criminal cases against them".

GUWAHATI: Severe flooding has engulfed several regions of

Assam following the release of water from dams managed by the North Eastern Electric Power Corporation Limited (NEEPCO). In response to incessant rains and strong winds, NEEPCO opened the gates of the Karbi Langpi Hydro Electric Project and the Khandong dam, causing the Kopili and Borpani rivers to overflow. Specifically, five gates of the Karbi Langpi Hydroelectric Project and seven gates of the Khandong dam were opened, leading to the Borpani River swelling beyond its capacity. This sudden influx of water has resulted in substantial damage and disruption across the affected areas. The floodwaters have washed away the wooden bridge at Ramani Field on the Borpani River, cutting off a crucial traffic route for residents of Kachua Simaluguri. Several villages, including Kachua, Madhabpara, Juripar, Longjap, and Padumoni, are now submerged under water.

# **EU** announces Euro 250,000 for victims of severe weather in Manipur

NEW DELHI, May 29: The European Union (EU) on Wednesday announced a financial aid of Euro 250,000 (over Rs 22.6 million) to help people hit by a hailstorm and heavy rain in the northeastern state of Manipur in early May.

The EU said the aid will be delivered by its humanitarian partner ADRA (Adventist Development and Relief Agency) and it will benefit more than 1,500 most vulnerable families. "The European Union has made available Euro 250,000 in response to the recent hailstorm and heavy rain that hit India's northeastern state of Manipur in early May," the EU said in a statement. It said humanitarian aid will provide crucial assistance to those

most affected in some of the worsthit areas. The EU said priority will be accorded to the distribution of food and emergency shelter kits to help affected people whose livelihoods and houses have been damaged by the storm.

"This will help communities to cope with the impact of the storm on their livelihood and to restore their houses," it said. On May 5, a severe hailstorm struck large swathes of Manipur, causing extensive damage to over 48,000 houses, a number of infrastructure and agricultural lands and crops across 16 districts.

# Adhikari, Tapas Roy stalled: Cong to PM NEW DELHI, May 29: The Congress on Wednesday

asked Prime Minister Narendra Modi whether he was withholding ₹ 7,000 crore of paddy procurement funds to West Bengal and if the CBI case against Suvendu Adhikari has got "washed away" in the BJP's washing machine

Congress general secretary Jairam Ramesh also asked if the prime minister prioritised his PR over vaccines and funds under the National Health Mission.

"Today's questions for the outgoing PM's West Bengal visit: Is the outgoing PM withholding ₹ 7,000 crore of ration funds so that his face is plastered on ration shops?

Did Suvendu Adhikari's CBI case get washed away in BJP's washing machine? Does the PM prioritise his PR over vaccines for India's children?" he asked in a post on X. He posed the questions on a day the prime minister is campaigning in West Bengal for the last phase of elections on June 1.

"In an incredibly petty move, the Centre has been withholding National Food Security Act funds from West Bengal for not displaying the outgoing PM's face on ration shops. In an attempt to coerce the state government into displaying sign boards and flexes featuring the outgoing PM's photos, the Centre has withheld



₹7,000 crore of paddy procurement funds," Ramesh charged. He said this could seriously hinder the state's paddy procurement and the availability of rice for the public distribution system.

"Why has the outgoing PM so callously neglected the health and wellbeing of the people of West Bengal? Is his publicity more important than people's daily food?" the Congress leader asked. He said in April 2017, the CBI filed an FIR against then TMC MP Adhikari in connection with the Narada scam.

In April 2019, the CBI sought sanction from the Lok Sabha speaker to prosecute him and in December 2020, Adhikari joined the BJP, and the CBI never received the Lok Sabha (CONTD. ON PAGE-2)

NEW DELHI, May 29: There has been an increase of 104 per cent in the number of political parties contesting Lok Sabha elections from 2009 to 2024, according to an analysis by poll rights body ADR. According to the analysis, 751 political parties are participating in 2024 as compared to 677 who participated in 2019, 464 in 2014, and 368 in 2009

This surge represents a staggering 104% increase from 2009 to 2024. The Association for Democratic Reforms (ADR) and National Election Watch have conducted a comprehensive analysis of the self-sworn affidavits of 8,337 candidates vying for seats in the upcoming Lok Sabha 2024

MUMBAI, May 29: Benchmark equity indices Sensex and Nifty declined nearly 1 per cent on Wednesday, continuing their losing streak for the fourth day running amid profit-taking by cautious investors ahead of the results of the Lok Sabha polls and weak global trends.

The 30-share BSE Sensex declined 667.55 points or 0.89 per cent to settle at 74,502.90. The index declined below the 75,000 mark to hit the day's low of 74,454.55, plunging 715.9 points or 0.95 per cent. The BSE benchmark hit its all-time peak of 76,009.68 on May 27.

The NSE Nifty dropped 183.45 points or 0.80 per cent to 22,704.70 amid high volatility. The 50-share barometer hit its lifetime high of 23,110.80 on Monday.

Rupee falls 21 paise to close at 83.39 against US dollar

MUMBAI, May 29: The rupee settled 21 paise lower at 83.39 (provisional) against the US dollar on Wednesday, tracking a negative trend in domestic equities and elevated crude oil prices.

Forex traders said dollar demand from importers and oil marketing companies (OMCs) also weighed on the rupee.

However, foreign inflows in the bond markets ahead of inclusion on India's government bonds in global bond index cushioned the downside. At the interbank foreign exchange market, the local unit opened at

83.22 and finally settled for the day at 83.39 (provisional), down 21 paise from its previous close. On Tuesday, the rupee pared initial gains to settle 5 paise lower at 83.18

against the US dollar. "We expect the rupee to trade with a slight negative bias on month-end dollar demand from OMCs and importers to meet their obligations. Risk aversion in global markets and a strong US dollar may further pressurize the rupee," said Anuj Choudhary, Research Analyst at Sharekhan by BNP Paribas.

However, fresh foreign inflows in FPIs and bond markets may support the rupee at lower levels. Traders may take cues from Richmond manufacturing index and speeches from US Fed officials. Investors may remain cautious ahead of core PCE price index data later this week, Choudhary added.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading at 104.67, higher 0.05 per cent, on hawkish Fed speak and upbeat economic data from the US.

Brent crude futures, the global oil benchmark, rose 0.78 per cent to USD 84.88 per barrel. On the domestic equity market, the 30-share BSE Sensex declined 667.55 points, or 0.89 per cent, to close at 74,502.90 points. The broader NSE Nifty fell 183.45 points, or 0.8 per cent, to close at 22,704.70 points. Continuing its winning run for the third straight session, silver soared ₹1,150 to ₹ 97,100 per kg. It had closed at ₹ 95,950 per kg on Tuesday. In the futures trade, silver also hit a lifetime peak of ₹ 96,493 per kg on the Multi Commodity Exchange (MCX) on Wednesday. Meanwhile, the gold prices climbed ₹ 250 to ₹ 73,200 per 10 grams in the national capital. In the previous session, the precious metal prices had settled at ₹ 72,950 per 10 grams. The medical community has criticised this attempt by the BJP to "saffronise" medical centres, and the state government has refused to implement it, he said.

This comes after the Centre has already blocked state funds to MGNREGA and a Central housing scheme. # S&P ups India's outlook to positive, raises hope for rating upgrade in 2 years

NEW DELHI, May 29: Giving thumbs up to the economic management of the Modi government, S&P Global Ratings after a gap of 14 years upgraded India's sovereign rating outlook to positive from stable on robust growth, improved quality of public spending in last 5 years and expectation of broad continuity in reforms and fiscal policies.

S&P, however, retained India's sovereign rating at the lowest investment grade of 'BBB-'.

In a statement on Wednesday, the US-based agency said India's rating can be upgraded in the next 24 months if the country adopts a cautious fiscal and monetary policy that reduces the government's elevated debt and interest burden while bolstering economic resilience.

S&P's rating commentary comes within a week of RBI's record ₹ 2.10 lakh crore dividend transfer to the government. The funds may be used to cut the Centre's fiscal deficit.

"India outlook revised to positive on robust growth and rising quality of Government spend; BBB- long-term and 'A-3' short-term unsolicited foreign and local currency sovereign credit ratings affirmed," S&P said.

Sovereign rating is a tool to measure the risk level of a country's investing environment and shows investors the ability of a country to repay its debts. In 2010, S&P had upped the outlook to stable from negative.

The ratings are looked at by investors as a barometer of the country's creditworthiness and has impact on borrowing costs. "Our positive outlook on India is predicated on its robust economic growth, pronounced improvement in the quality of government spending, and political commitment to fiscal consolidation. We believe these factors are coalescing to benefit credit metrics," S&P said. It said the composition of



government spending has been transformed, with an increasing share going to infrastructure. This will ease bottlenecks to put the country on a higher growth trajectory. S&P said India's robust economic expansion is having a constructive impact on its credit metrics.

"We expect sound economic fundamentals to underpin the growth momentum over the next two to three years. Regardless of the election outcome, we expect broad continuity in economic reforms and fiscal policies," S&P said. The positive outlook reflects S&P's view that continued policy stability, deepening economic reforms, and high infrastructure investment will sustain long-term growth prospects.

"That, along with cautious fiscal and monetary policy that diminishes the government's elevated debt and interest burden while bolstering economic resilience, could lead to a higher rating over the next 24 months," S&P said.

The Indian economy has staged a "remarkable comeback" from the COVID-19 pandemic, S&P said, adding it forecasts India's real GDP growth at 6.8 per cent this year, which compares favourably with emerging market peers amid a broad global slowdown.

The agency estimates real GDP growth in the past three years to have averaged 8.1 per cent

annually, the highest in the Asia-Pacific region. It expects these growth dynamics to continue to play out in the medium term, with GDP expanding close to 7 per cent annually over the next three years which will have a moderating effect on the ratio of government debt to GDP despite still wide fiscal deficits.

S&P said the quality of government spending has improved in the past four to five years and public investment and consumer momentum will underpin solid growth prospects over the next three to four years.

The Modi administration has increasingly shifted budget allocation to infrastructure spending. Capital expenditure is scheduled to increase to ₹ 11 lakh crore, or about 3.4 per cent of GDP in fiscal 2025. This is almost 4.5x from a decade before. S&P believes that the improvements in infrastructure and connectivity in India will remove chokepoints, which are hindering long-term economic growth.

India's weak fiscal settings had always been the most vulnerable part of its sovereign ratings profile. All three major global rating agencies -S&P, Fitch and Moody's -- have accorded the lowest investment grade rating to India.

S&P said with economic recovery now well on track, the government is again able to depict a more concrete (albeit gradual) path to fiscal consolidation. S&P projects general government (Centre + states) deficit of 7.9 per cent of GDP in fiscal 2025, which will slowly decline to 6.8 per cent by fiscal 2028.

"Irrespective of the June 2024 general election results, we expect the incoming government to carry on economic reforms to support the growth vigor, continued infrastructure investment drive, and commitment to fiscal consolidation," S&P said. (PTI)





# Women spearhead effort to install solar fence amidst HEC

HT Bureau GUWAHATI, May 29: "This singlestrand solar-powered fence that now shields our village and residences from wild elephants has given us a new lease of life and a whiff of prosperity after a prolonged period of mental agony and threat to our very existence. This fence is nothing less than the lifeline for villagers here," said Kingish Koch, a mother of two young daughters and a leading woman in remote Besorkona Kochpara hamlet in Goalpara district.

The innocuous-looking wire held horizontally high above the ground by posts of tree stems has brought smiles back to the faces of residents of the remote village.

The women of the villages used to be severely affected by an unrelenting traumatic atmosphere because of the raging human-elephant conflict (HEC) phenomenon gripping the residents. They were compelled to finish household chores, including cooking dinner, by sunset as no one knew what would befall them once the herd of wild elephants happened to enter the village after dusk.

Hell used to break loose on this village inhabited by the indigenous Koch community and located about 12 kilometers away from the sub-division headquarters at Lakhipur in Goalpara district when wild elephants entered the



village at nightfall, raiding household after household in search of food.

As the menfolk got busy trying to chase the elephants away, if possible, the women had to gather their children and the elderly in the household and run for safety, if any.

"Some of the women of the village like Kingis Koch, Nilima Koch, Menoka Koch, Pimila Koch took the lead along with the male counterparts of the villages in installing this low-cost solar fence under the guidance of Aaranyak's technical team led by Anjan Baruah. These women villagers, numbering about 18, even carried heavy tree-stem posts on their shoulders to help install the fence," said a grateful

Dr Bibhuti Prasad Lahkar, the head scientist of the elephant research and conservation division of Aaranvak.

Biodiversity conservation organisation Aaranyak, with support from USFWS and Goalpara Territorial Division of state Forest department, installed a 2.5 km long single-strand solar fence in April this year to protect Besorkona and No 1 Pukhuripara villages as part of its sustained efforts for mitigation of HEC and facilitation of coexstence. The length of the fence around Besorkona hamlet is 1.6 km.

"The low-cost solar fencing, which we now call our lifeline, not only protects our lives and homes but has empowered all the women in the village

who now carry on with their vocations of choice besides the routine household chores without any fear. We can now work freely in our horticulture homesteads and weave clothes, look after the children's health and education, thereby contributing substantially towards the improvement of household economic conditions," said Kingis Koch.

Another leading village woman, Nilima Koch, said the women of the village who used to spend sleepless nights in a raging HEC situation could very well realise how our life would be changed for the better by this solar fence and hence we worked along with our menfolk to help install the solar fence.

"It has been such a peaceful life for us since the installation of the solar fence in April this year as if we got our life back. We can now eat, sleep, and work at peace. The women in the villages have started laughing once again, their health too has improved and trauma has gone. When the woman laughs the entire family laughs," said Menoka Koch with a radiant smile.

The religious and cultural activities in the village have also resumed in the right spirit as the hub of these activities, the village Kali Temple, has now been made out of reach for wild elephants because of the solar fence.

## The Battle for India's Future

s the elections near their conclusion, the political landscape is abuzz with speculations and strategies from both the ruling NDA and the opposition INDI-Alliance. Central to the opposition's campaign is the vision of an India without Narendra Modi at the helm, with the INDI-Alliance aspiring to usher in a new era reminiscent of the Nehru years. Congress leader Shashi Tharoor has emerged as a prominent voice within the INDI-Alliance, echoing Rahul Gandhi's aggressive stance. Tharoor confidently predicts the alliance's victory, suggesting they will overturn recent amendments to the anti-terror law UAPA and remove religious references in the citizenship law. These promises resonate particularly in Kerala, contrasting with sentiments in Himachal Pradesh, where voters prefer the UAPA unchanged. Tharoor's potential rise to a Union ministerial position underscores the internal dynamics of the INDI-Alliance, where his policy positions have become focal points. His advocacy for resuming trade with Pakistan and revising the UAPA has sparked significant debate. Tharoor's considerable Muslim support base likely influences his stance, especially in light of cases like that of Sidheeq Kappan, charged under the UAPA.

The prospect of a Tharoor-led policy shift has supporters of the INDI-Alliance hopeful, anticipating significant changes if they seize power. The June 4 results will be decisive in determining whether Modi continues as Prime Minister and if Tharoor's vision for the UAPA comes to fruition. The BJP's supporters, however, remain confident in Modi's enduring appeal. The opposition is banking on an "undercurrent" of support for the INDI-Alliance, contrasting the Modi wave some observers detected in West Bengal on May 28. Despite extensive campaigning by Modi, Amit Shah, and BJP President JP Nadda, who have repeatedly proclaimed "abki baar 400 paar," predicting the exact outcome remains challenging. Commerce Minister Piyush Goyal echoed this optimism while campaigning in Varanasi, Modi's constituency. After much speculation, the INDI-Alliance has projected that it will secure "above 300" seats, confidently asserting that Modi will no longer be Prime Minister by the afternoon of June 4. Modi, the most polarizing figure in the INDI-Alliance circles, appears to relish the attention. His campaign has generated intense interest, with predictions ranging from a minimal BJP presence to an overwhelming victory.

The exit polls on June 1 will provide preliminary insights, followed by a crucial INDI-Alliance meeting to strategize for a potential post-Modi India. West Bengal Chief Minister Mamata Banerjee's decision to skip the meeting called by Congress President Mallikarjun Kharge highlights ongoing tensions within the INDI-Alliance. Banerjee's paranoia regarding Congress reflects the fragile unity of the alliance, which may struggle to remain cohesive if tasked with forming a coalition government post-elections. The disunity within the INDI-Alliance is a significant hurdle, raising questions about its ability to govern effectively if victorious. Tharoor's proposed UAPA reforms have introduced some optimism, but the alliance's stability remains uncertain. Meanwhile, the BJP's talk of a third and fourth term for Modi, alongside his rhetoric on corruption, continues to resonate with his base, causing concern among INDI-Alliance supporters. Modi's potential victory could exacerbate existing tensions on issues like reservations for SC/ST/OBC and the contentious topic of Muslim reservations. Additionally, policies like the legal MSP and the Agniveer scheme have been flagged by the INDI-Alliance as areas of concern. The June 4 results will reveal whether Modi's influence remains unchallenged or if the INDI-Alliance will manage to steer India in a new direction.

The Wire initially claimed a drastic dip of 19.4 crore voters in the first five phases of polling compared to the 2019 elections. However, this claim was based on a flawed comparison that misled the public regarding electoral participation trends.

Misleading comparisons and arithmetic errors: The Wire's original report erroneously compared the total number of registered voters in the first five phases of the 2019 elections with the actual voter turnout in the first five phases of the 2024 elections This incorrect comparison suggested a decline from 70 crore votes in 2019 to 50.7 crore in 2024. However, the accurate figure for the 2019 turnout was 48.5 crore, making The Wire's analysis fundamentally flawed from the beginning.

Once the errors were identified, The Wire revised its article, claiming a dip of 1.8 crore voters in the first phase of the 2024 elections. Despite this correction, the revised analysis also contained significant errors. The Wire inaccurately reported a decrease in voter turnout when, in reality, the number of votes cast in the first phase increased from 9,13,79,409 in 2019 to 11,00,52,103 in 2024. This mistake resulted from a basic arithmetic error: the incorrect subtraction of the 2024 figures from those of 2019, leading to a negative result misinterpreted as a dip

Inaccurate phase-wise comparisons: The fundamental issue with The Wire's approach lies in the phase-wise comparison of voter turnout between different election years. Such comparisons are inherently flawed because the constituencies included in each phase vary significantly between elections. For instance, Andhra Pradesh voted in the first phase in 2019 but in the fourth phase in 2024.

Similarly, Tamil Nadu, which voted in the first phase in 2024. participated in the second phase in 2019. These variations in conrespective of the phase in which they voted. This method, while more complex, ensures a true comparison of voter behavior and trends.

The correct approach to data analysis: A more accurate approach involves comparing the total voter turnout in the same constituencies from the first phase of the 2024 elections with the corresponding constituencies from 2019. For example, in 2019, 11,00,90,908 votes were cast out of 15,75,36,275 eligible voters in these constituencies. In 2024, 11,00,52,103 votes were cast out of 16.63.86.344 eligible voters. This shows a slight decrease of 38,805 voters, not the significant dip The Wire reported.

Moreover, the case of Outer Manipur, which was split into two phases in 2024, further complicates direct comparisons. If one were to combine the votes from both phases for Outer Manipur, the analysis would show a different turnout trend. In 2019, Outer Manipur voted in a single phase, whereas in 2024, it was divided, affecting the overall turnout numbers when aggregated differently.

**Implications and conclusion:** The Wire's errors, whether due to misunderstanding or intentional misrepresentation, highlight the critical importance of accurate data analysis and responsible journalism. Inaccurate reporting, especially in the context of elections, can have significant consequences, including undermining public trust in the electoral process and spreading misinfor-

mation. While errors in complex data analysis can occur, repeated and significant mistakes suggest a deeper issue that needs addressing. Journalism, particularly in the digital age, carries a responsibility to ensure the accuracy and reliability of information disseminated to the public. The Wire's case serves as a cautionary tale, emphasizing the need for rigorous data verification and methodological transparency to uphold the standards of responsible journalism

silver prices reaching an alltime high of ₹ 90,000 a kg on May 17. In fact, although silver has got more industrial usage from the makers of electric vehicles and photovoltaic solar panels, gold and silver prices tend to move similarly.

A reason for gold continuing its upward trajectory is the newfound interest in gold by the central banks around the world. In particular, central banks from China, Russia, India, and Turkey are stacking up gold reserves. A continuing high inflation rates in the US and the Eurozone - along with a probable weakening impact of high inflation on the US\$ and the Euro - have also contributed to the rising prices of these precious commodities.

For example, inflation rate in the UK has reached a record high of 11.1% in October 2022, with an overall price increase of 22% over the past three years. For the years 2022 and 2024, the average rate of inflation in the US was 8% and 4.1%, respectively, much higher than their benchmark level of 2%. According to the World Gold Council (WGC), demand for gold rose 18 % in 2022, taking

the world's gold demand to 4,741 tonnes, the highest for any year since 2011. Gold demand fell 5 % in 2023 bringing the demand to 4,448 tonnes which was still robust considering the fact that the 2022 demand followed the pandemic year. The last time demand for gold

reached such levels was when uncertainty about the future of the dollar spiked in the aftermath of the 2008 US financial crisis.

Latest available figures from the first quarter of 2024, suggest that the demand for gold continues to rise. Economies such as China, Russia, France, Japan, and UK have turned out to be net sellers of the US treasury notes, and are buying gold. Another reason for the increase in gold prices in India is

the rise in gold imports. Imports

side factors, depreciation of Indian rupee played a spoilsport. The rupee has depreciated 0.4 % against the US dollar since the start of the calendar year 2024. Through the previous financial year, 2023-24, it depreciated 1.5 %. Naturally, a depreciating rupee adds to price of gold in India.

In addition to the uncertain global landscape, which is marked by conflicts such as war, a major factor could be the accelerated pace of de-dollarisation.

The argument is that China, the second largest economy after the US, is increasingly convincing the world's largest suppliers of energy, including Russia, Saudi Arabia, Iran, and Venezuela to trade in Chinese Yuan. This, according to the commentators, will usher in the demise of the 'petrodollar.' It would then be a matter of time before the US economy crumbles, they argue

In the early 1970s, during the Yom Kippur war, the Organisation of the Petroleum Exporting Countries (OPEC), of which Saudi Arabia is a member, implemented an oil embargo. The price of oil per barrel went up from \$3 in 1973 to \$12 in 1974, and the OPEC member countries earned dollops of money. The then American President, Richard Nixon struck a deal with Saudi Arabia ensuring that all oil deals across the world would take place in US dollars. Other oil producing nations in the OPEC joined Saudi Arabia, depositing a large portion of their money in the US banks, thus marking the beginning of 'petrodollar'. In the world of flexible exchange rates, the US dollar became the most soughtafter currency

Fast forward, in 2024, China and Russia are now trying to break this US hegemony. Other emerging market economies such as Brazil, India, Iran, and off late France, have now agreed to trade in their own currency. Back home, in February, the

originally comprising Brazil, Russia, India, China and South Africa - met in Durban, South Africa to discuss new global reserve assets instead of the US Dollar.

Russia is already trading energy with India and China in Indian Rupee and Chinese Yuan, respectively. Saudi Aramco is building a \$10 billion oil refinery in China (transaction happening in Chinese Yuan). France and China finalized the first ever deal on 65,000 tonnes of liquefied natural gas in Yuan. In fact, something similar happened during early part of 1970s. Prior to 1971, value of the US dollar was tied with the gold reserves. This meant that the dollar could be exchanged for gold at a fixed rate. However, because of economic pressures such as inflation and the costs of the war in Vietnam, the US government printed more money than what it had in gold reserves to back it up. "Petrodollar" came as a respite and President Nixon abandoned the "gold standard"

However, in spite of de-dollarisation and new found love for gold and silvers in recent times, the US economy is showing no sign of weakness. Interestingly, considering the last two years, Yuan continued to depreciate against dollar.

Given that China and the US are each other's largest trading partners; it is expected that a higher bout of inflation in the US will make the Yuan appreciate. But that did not happen as the Chinese are yet to catch-up with the US in terms of productivity, and that something is not going to fall anytime soon.

The US chip embargo on China is a testimony to the fact that the US government wants to keep its economy ahead. China has a long way to go before it can catch up with the US. As per ILO estimates in 2024, China is producing an output of US\$ 23,866 per worker, much below America's average of US\$ 1,30,942 per worker. (IPA Service)

The strategic decisions made by the Congress party, such as reducing the number of contested constituencies, highlight the depth and complexity of Indian politics. Each move is a calculated step towards a larger goal.

As the sixth phase of the Lok Sabha polls concluded on Saturday, the Congress claimed the BJP's fate is "all but sealed," with the INDIA bloc having already crossed the halfway mark of 272 seats and is on course for a total of over 350 seats.

The INDIA Alliance, a significant player in Indian politics, was formed by 26 Opposition parties last year to fight Modi unitedly. However, if the BJP returns to power, the alliance may face a significant challenge. Some partners. such as the Trinamool Congress and the AAP, have not fully aligned with the Congress in Lok Sabha polls, weakening INDIA bloc's position. A BJP victory could lead to re-evaluating the INDIA Alliance's strategy, with some partners choosing to distance from the present INDIA bloc.

Though not aligned with any coalition, these leaders have significant political influence and have helped the BJP in the past when the ruling party needed them. Their potential role in the post-election scenario could significantly shape the political landscape.

The Uddhav Thackeray faction of the Shiv Sena and the Sharad Pawar-led NCP may also reassess the situation if INDIA bloc fares badly. Delhi Chief Minister Keiriwal is ambitious and eyeing the prime ministership.

He will remain in opposition. Kejriwal predicted that if Modi wins again on June 4, he will put Uddhav Thackeray, Sharad Pawar, Rahul Gandhi, and Mallikarjun Kharge in jail. He would also be sent back to jail. Kejriwal has taken a tough anti-BJP position and he has to stick to it for the political future of AAP.

The June 4 election results will show how the post poll scenario impacts the INDIA alliance, splintering or strengthening it. They will also indicate whether the BJP will become more arrogant with a hat trick under its belt. A third consecutive BJP win could embolden the party, to pursue its Hindutva programme with more vigour. (IPA Service)

# Cyclone Remal devastates Growing excess global steel capacity has disturbing implications for environment Northeastern India

ay 2024 will go down in history as one of the most devastating months for the northeastern states of India due to the catastrophic impact of Cyclone Remal. This powerful cyclonic storm, which originated in the Bay of Bengal, unleashed its fury across vast swaths of Assam, Arunachal Pradesh, Nagaland, and neighboring regions, leaving a trail of destruction in its wake.

#### Assam bears the brunt

ot only does growing big volumes of excess global steel capacity unsettle the market but the phenomenon has disturbing implications for the environment. OECD says: "Back-of-theenvelope calculations will show ... reduction in global excess capacity by approximately one-third would lead to a reduction in emissions... in the range of 2 to 14 per cent and also much healthier business conditions for steel producers.' Alas, the pressure of overcapacity will become even more intense in the future.

According to OECD, in the face of demand growth being clouded by economic headwinds, global steel capacity is to see significant rise in three years to 2026, "with 46m tonne addition underway and an additional 78m tonnes in the planning stage.

In case global steel production remains at around last year's level, then with new capacity coming on stream, use of capacity will continue to shrink. OECD says: "World steel production as a share of capacity fell from 78.9 per cent in 2021 to 74.5 per cent in 2022." What it also ominously says this level of capacity use is 'not in line with a healthy and financial viable industry.

Alongside growing capacity within the country compromising the principle of capacity swap, Chinese steel groups are making significant investment in building mills (some wholesale shifting of plants included) in Asia, ASEAN in particular and Africa. Chinese investment in ASEAN works out to 81 per cent of the region's total capacity expansion.

Chinese aggressiveness in building capacity in Asia and Africa is evidenced by its cross-broader investments accounting for 65.1 per cent of such investments by all countries. But such Chinese moves are not necessarily a blessing for countries targeted for steel capacity creation.

For, China is installing by way of wholesale transfer of old induction furnaces, which are environment polluting and products made there from are of inferior quality in ASEAN, inviting criticism of host nations

China in fact is facing double whammy for its steel related activities. Besides the above, the country is responsible for causing disruptions in south-east Asian market for its unbridled export of steel products,

bons steel projects based on "new innovative technologies" are being set up in different countries.

In the meantime, as the economy everywhere is gaining in sophistication and sectors from defence to aerospace to automobile to railway require growing volumes of stainless steel, its use distinction with carbon steel is getting blurred in many ways. Stainless steel, an alloy of iron, highly resistant to rusting and corrosion, is also replacing carbon steel in construction in coastal areas.

Like in carbon steel, China and India are the two leading producers of stainless steel and the former in particular though has the burden of overcapacity remains engaged in commissioning new capacity. China presently has stainless steel capacity of around 50m tonnes and capacity utilisation of 70 per cent. Despite this, the country is to bring on stream fresh capacity of 7m tonnes this year. Moreover, a further 6m tonne is in planning stage.

No doubt, such capacity build-up is based on hope that once the world economy has overcome headwinds, stainless steel demand will rise and with that better capacity use.

After all, the new areas of application of stainless steel such as alternative energy, ethanol, hydrogen production and water storage and distribution hold great promise. The consulting group GlobalData Plc says in a report that the industry's global revenue at \$195bn in 2022 will grow at a compound annual growth rate (CAGR) of 5.5 per cent through 2030.

China lifted 2023 stainless steel production by 12.6 per cent to 36m tonnes. Exports, however, were down to 4.14m tonnes from 4.551m tonnes in 2022. Imports decelerations were sharp to 2.07m onnes from 3.285m tonnes.

Chinese spurt in stainless steel production is to be seen in the context of output falling in Europe and the US in response to demand fall. This will also explain setback in Chinese exports to the US and the EU. Exports would have suffered more had it not been for 94 per cent rise in Chinese despatches to Russia since 2020.

India, which is the second largest user of stainless steel, is seeing an 8 per cent CAGR over the past one decade and the forecast is per capita consumption of the metal will rise to nearly 12 kg by 2047 from the present 2.5 kg.

Situated 4,545 metres above sea level, it is one of 21 such lakes in Nepal classified as critically dangerous: a glacial lake outburst flood, or GLOF, here would have a catastrophic impact on downstream human settlements like Naa and Beding, where people move to harsh winter during months, and on vital infrastructure.

What is a GLOF?

A Glacial Lake Outburst Flood (GLOF) is a sudden release of water from a lake formed by meltwater from a mountain glacier, which is held back by ice or a moraine (rocks and sediment carried along by the glacier).

These floods can be prompted by an earthquake, avalanche or the accumulation of too much meltwater. GLOFs are often extremely destructive, and are a growing threat in the Himalayan watershed.

When asked about the 72-year-old risk. the Sherpa says: "I don't know what should be done to prevent that. Maybe people in the higher-up know that." In fact, Tsho Rolpa and the Everest region's Imja are the only two glacial lakes in Nepal that have a risk mitigation plan. Funded by the World Bank, the Nepali government and international partners, the two-year project was completed in June 2000.

To mitigate the risks, Shrestha says regular inspections are a must: "Digital cameras could be installed, linked with the telemetry system to get real-time visual information of the lake and surrounding [areas]." The downstream communities should also be "periodically made aware of the possible risk", he adds.

Government action

Dialogue Earth consulted Dinkar Kayastha, the senior divisional hydrologist at the Department of Hydrology and Meteorology. He says the government has identified four that pose the highest GLOF risk: Thulagi in the

Gandaki Basin, and Lower Barun, Lumding and Hongu in the Koshi Basin. "Now we are working to get funding from the Green Climate Fund, so that we can lower the water levels of these lakes, too," Kayastha says. The government has sent a proposal worth \$36.1 million to the fund and "negotiations are ongoing."

The authorities are also exploring whether this funding could be used to upgrade weather-monitoring stations. This work would likely include installing automated equipment, as well as repairing or installing early warning systems at Tsho Rolpa. "Our budget estimates are ready, but we are still unsure who will be willing to

often circumventing clearly laid down fair trade rules.

Since south-east Asia happens to be a significantly large export destination for Chinese steel and exporters are taking too much liberty, it is not unexpected that Thailand, Indonesia and Vietnam are rising in protest against their shenanigans. In view of growing India focus on infrastructure, housing and manufacturing, well over a century experience of steelmaking, anticipated demand growth for the metal and plentiful availability of raw materials, particularly iron ore; it is only natural that the country will be hooked to rapid capacity growth. JSW Steel is to build a 13.2m tonne greenfield mill at coastal Paradip in Odisha at an investment of Rs 650bn (\$7.8bn).

Arcelor Mittal Nippon Steel too has received major clearances to set up a 7m tonne mill at Jagatsinhpur in the same state at an investment of \$4.68 bn. Such greenfield projects apart, all the major groups, including Tata Steel, JSPL and government owned SAIL have major brownfield capacity expansion programmes.

Tata Steel, which has a major production footprint in Europe, will focus on brownfield capacity expansion in India following its some strategic acquisitions there. Elaborating on the company's growth strategy, Narendran says: "Basically, we want to increase capacity in India where we have been making the metal for over a century.

We have already around 21m tonnes here and soon it will be 26m tonnes as Kalinganagar mill capacity expansion to 8m tonnes from 3m tonnes is nearing completion. We are concretising a few more plans to take our India capacity to 40m tonnes by 2030.

SAIL, which has five integrated mills, will lift capacity by 15m tonnes to 35m tonnes in the first phase. "Whatever happens to steel will leave an impact on raw materials such as iron ore, coal, manganese ore and chrome ore. So when you are building new steel capacity, you have to think of corresponding step up of supply of steelmaking ingredients," says RK Sharma, director general of Federation of Indian Mineral Industries.

Not only will the industry be engaged in building new capacity but investments will be made simultaneously to go up in product value chain. While India is seeing most capacity addition through blast furnacebasic oxygen furnace (BF-BOF) route like in the rest of Asia, other regions of the world are building capacity using electric arc furnaces (EAFs), promoting circular economy. OECD says around 65 low-car-

Jindal Stainless managing director Abhyuday Jindal says: "India will be in the forefront of growth as we anticipate demand to scale up to 20m tonnes by 2037 from 4m tonnes last year.

While this demand growth will be supported by traditional use sectors such as transport, construction and consumer durables, more and more of the metal will find application in aerospace, defence and water management."

But why has stainless steel become the 'optimal" material choice? Jindal says: Being completely recyclable and produced through scrap route, stainless steel is more than eco-friendly. It is best cost option on life cycle costing basis.'

Steelmaking is highly energy intensive and carbon intensive. A major concern for policymakers of countries where steel is made on some scale is how to make production processes less carbon intensive. Steel's environment harming problem is because of its high dependence on metallurgical coal primarily used as a reducing agent for extraction of iron from ore and also to provide carbon content needed in steel.

International Energy Agency says that for steel to be on the pathway to net zero emissions by 2050 will require perfection of technology for replacement of coal by hydrogen and carbon capture. Making steel through EAFs by recycling scrap will also help in controlling emissions.

Several Chinese government departments want the share of EAFs in total steel production to become 20 per cent by 2030. In fact, as old, polluting and unviable mills are pulled down to make room for new capacity; EAFs are built in their place in China. Since 2017, the country is annually commissioning 110m tonnes of EAF capacity as part of capacity swap campaign. But disappointingly, EAF capacity use has remained low at about 60 per cent.

In any case, the world steel industry has since 1900 recycled over 25bn tonnes of steel and in the process cut iron ore consumption by around 33bn tonnes and coal use by 16bn tonnes. The industry's energy efficiency is also on ascendance: producing one tonne of steel now requires 40 per cent of the 1960 energy level.

An environment friendly development is the commitment by growing numbers of industry constituents to use energy produced from renewable sources as a substitute for fossil fuels based energy. Alas, the industry's energy requirements are so large that fossil fuels will continue to figure prominently is generating power for steel mills. (IPA Service)

# Netanyahu frequently makes claims of antisemitism. Critics say he's deflecting from his own problems

TEL AVIV, May 29: After the International Criminal Court's top prosecutor sought arrest warrants for Israeli Prime Minister Benjamin Netanyahu, his defense minister and top Hamas officials, the Israeli leader accused him of being one of "the great antisemites in modern times.'

As protests roiled college campuses across the United States over the Gaza war, Netanyahu said they were awash with "antisemitic mobs."

These are just two of the many instances during the war in which Netanyahu has accused critics of Israel or his policies of antisemitism, using fiery rhetoric to compare them to the Jewish people's worst persecutors. But his detractors say he is overusing the label to further his political agenda and try to stifle even legitimate criticism, and that doing so risks diluting the term's meaning at a time when antisemitism is surging worldwide.

"Not every criticism against Israel is antisemitic," said Tom Segev, an Israeli historian. "The moment you say it is antisemitic hate ... you take away all legitimacy from the criticism and try to crush the debate.'

There has been a spike in antisemitic incidents since Hamas attacked Israel on Oct. 7, according

to researchers. And many Jews in North America and Europe have said they feel unsafe, citing threats to Jewish schools and synagogues and the pro-Palestinian campus demonstrations in the U.S., although organizers deny that antisemitism drives the protests.

The war has reignited the long debate about the definition of antisemitism and whether any criticism of Israel — from its military's killing of thousands of Palestinian children to questions over Israel's very right to exist - amounts to anti-Jewish hate speech

Netanyahu, the son of a scholar of medieval Jewish persecution, has long used the travails of the Jewish people to color his political rhetoric. And he certainly isn't the first world leader accused of using national trauma to advance political goals.

Netanyahu's supporters say he is honestly worried for the safety of Jews around the world. But his accusations of antisemitism come as he has repeatedly sidestepped accountability for not preventing Hamas' Oct. 7 attack. Hamas killed roughly 1,200 people and took 250 hostage, which many in Israel's defense establishment acknowl-



edge they shoulder the blame for.

Netanyahu has continued to face criticism at home and abroad throughout the war, which has killed 35,000 Palestinians, according to the Gaza Health Ministry, which doesn't distinguish between fighters and noncombatants. The fighting has sparked a humanitarian catastrophe, and ICC Prosecutor Karim Khan has accused Netanyahu and his defense minister of using starvation as a "method of warfare," among other crimes. Segev, the historian, acknowledged there is a

rise in "violent hate" toward Israel and, speaking

from Vienna, said he wasn't sure if speaking Hebrew in public was safe. But he said Netanyahu has long used Jewish crises to his political benefit, including invoking the Jewish people's deepest trauma, the Holocaust, to further his goals.

At the height of the campus protests, Netanyahu released a video statement condemning their "unconscionable" antisemitism and comparing the mushrooming encampments on college greens to Nazi Germany of the 1930s.

"What's happening in America's college campuses is horrific," he said.

In response to Khan seeking the arrest warrants, he said the ICC prosecutor was "callously pouring gasoline on the fires of antisemitism that are raging across the world," comparing him to German judges who approved of the Nazis' race laws against Jews. Netanyahu has compared accusations that Israel's war is causing starvation in Gaza or that the war is genocidal to blood libels - unfounded centuries-old accusations that Jews sacrificed Christian children and used their blood to make unleavened bread for Passover.

"These false accusations are not levelled against us because of the things we do, but because of the

simple fact that we exist," he said at a ceremony marking Israel's Holocaust Remembrance Day earlier this month.

Netanyahu previously made repeated allusions to the Holocaust while trying to galvanize the world against Iran's nuclear program.

Israeli leaders and the country's media also made such comparisons about Oct. 7, describing the Hamas attackers as Nazis, comparing their rampage to the historic violence inflicted on Eastern European Jews, and referring to the images of Jewish victims' burned bodies as a Shoah — the Hebrew word for Holocaust.

Israelis have been jarred by the global rise in antisemitism, and many view the swell of criticism against Israel as part of the rise. They see hypocrisy in the world's intense focus on Israel's war with Hamas while other conflicts get much less attention.

Moshe Klughaft, a former advisor to Netanvahu. said he believes the Israeli leader is genuinely concerned over rising antisemitism. "It is his duty to condemn antisemitism as prime minister of Israel and as head of a country that sees itself as responsible for world Jewry," he said.(AP)

# Israeli strikes kill at least 37 Palestinians, most in tents, near Gaza's Rafah as offensive expands

DEIR AL-BALAH, May 29: Israeli shelling and airstrikes killed at least 37 people, most of them sheltering in tents, outside the southern Gaza city of Rafah overnight and on Tuesday - pummeling the same area where strikes triggered a deadly fire days earlier in a camp for displaced Palestinians - according to witnesses, emergency workers and hospital officials. The tent camp inferno has drawn widespread international outrage, including from some of Israel's closest allies, over the military's expanding offensive into Rafah. And in a sign of Israel's growing isolation on the world stage, Spain, Norway and Ireland formally recognized a Palestinian state on Tuesday.

The Israeli military suggested Sunday's blaze in the tent camp may have been caused by secondary explosions, possibly from Palestinian militants' weapons. The results of Israel's initial probe into the fire were issued Tuesday, with military spokesman Rear Adm. Daniel Hagari saying the cause of the fire was still under investigation but that the Israeli munitions used — targeting what the army said was a position with two senior Hamas militants — were too small to be the source.

The strike or the subsequent fire could also have ignited fuel, cooking gas canisters or other materials in the camp. The blaze killed 45 Palestinians, according to Gaza health officials' count. Israeli Prime Minister Benjamin Netanyahu said the fire was the result of a "tragic mishap." Israel's assault on Rafah, launched May 6, spurred more than 1 million people to flee the city, the U.N. agency helping Palestinian refugees said Tuesday. Most were already displaced multiple times in the nearly eight-month war between Israel and Hamas. Families are now scattered across makeshift

tent camps and other war-ravaged areas.

The strikes over the past few days have hit areas west of Rafah, where the military had not ordered civilians to evacuate. Israeli ground troops and tanks have been operating in eastern Rafah, in central parts of the city, and along the Gaza-Egypt border. Shelling late Monday and early Tuesday hit Rafah's western Tel al-Sultan district, killing at least 16 people, the Palestinian Civil Defense and the Palestinian Red Crescent said. Seven of the dead were in tents next to a U.N. facility about about 200 meters (yards) from the site of Sunday's fire.

"It was a night of horror," said Abdel-Rahman Abu Ismail, a Palestinian from Gaza City who has been sheltering in Tel al-Sultan since December. He said he heard "constant sounds" of explosions overnight and into Tuesday, with fighter jets and drones flying above.

He said it reminded him of the Israeli invasion of his neighborhood of Shijaiyah in Gaza City, where Israel launched a heavy bombing campaign before sending in ground forces in late 2023. "We saw this before," he said.

The United States and other allies of Israel have warned against a full-fledged offensive in the city, with the Biden administration saying

this would cross a "red line" and refusing to provide offensive arms for such an undertaking. On Tuesday, U.S. State Department spokesman Matthew Miller gave no indication the administration sees Israel as crossing any of the red lines for Rafah, saying the offensive is still on a "far different" scale than assaults on other population centers in Gaza.

The International Court of Justice ordered Israel to halt its Rafah offensive last week as part of South Africa's case accusing Israel of committing genocide against the Palestinians in Gaza. A proposed U.N. Security Council resolution demanding a halt to the fighting in Rafah was being circulated by Algeria on Tuesday, with plans to potentially bring it to a vote this week. The U.S. has vetoed multiple Gaza cease-fire resolutions.

On Tuesday afternoon, an Israeli drone strike hit tents near a field hospital by the Mediterranean coast west of Rafah, killing at least 21 people, including 13 women, Gaza's Health Ministry said.

A witness, Ahmed Nassar, said his four cousins and some of their husbands and children were killed in the strike and a number of tents were destroyed or damaged. Most of those living there had fled from the same neighborhood in Gaza City earlier in the war.

"They have nothing to do with anything," he said. Netanyahu has vowed to press ahead in Rafah, saying Israeli forces must enter the city to dismantle Hamas and return hostages taken in the Oct. 7 attack that triggered the war. # South Africans begin voting in an election seen as their country's most important in 30 years

JOHANNESBURG, May 29: South Africans began voting on Wednesday in an election seen as their country's most important in 30 years, and one that could put their young democracy in unknown territory.

At stake is the three-decade dominance of the African National Congress party, which led South Africa out of apartheid's brutal white minority rule in 1994. It is now the target of a new generation of discontent in a country of 62 million people - half of whom are estimated to be living in poverty

Africa's most advanced economy has some of the world's deepest socioeconomic problems, including one of the worst unemployment rates at 32%

The lingering inequality, with poverty and joblessness disproportionately affecting the Black majority, threatens to unseat the party that promised to end it by bringing down apartheid under the slogan of a better life for all.

After winning six successive national elections, several polls have the ANC's support at less than 50% ahead of this one, an unprecedented drop. It might lose its majority in Parliament for the first time, although it's widely expected to hold the most seats.

Support has been fading. The ANC won 57.5% of the vote in the last national election in 2019, its worst result to date

South African President Cyril Ramaphosa, the leader of the ANC, has promised to "do better." The ANC has asked for more time and patience. Any change in the ANC's hold on power could be monumental for South



Africa. If it does lose its majority, the ANC will likely face the prospect of having to form a coalition with others to stay in government and keep Ramaphosa as president. The ANC having to co-govern has never happened before.

South Africans vote for parties, not directly for their president. The parties then get seats in Parliament according to their share of the vote and those lawmakers elect the president after the election. The ANC has always had a

majority in Parliament since 1994. The election will be held on one day across South Africa's nine provinces, with nearly 28 million people registered to vote at more than 23,000 polling stations. Final results are expected by Sunday.

Ramaphosa was due to cast his vote in the morning at a primary school in the Johannesburg township of Soweto, where he was born and which was once the epicenter of the resistance to apartheid.

There, Samuel Ratshalingwa was among the first few people in line in the chill of South Africa's early winter. "I take voting as something serious because as communities, it is difficult to complain about services when you have not voted," he said.

"Our main issue here in our community is the lack of jobs. We have to use the vote to make our voices heard about this problem."

The opposition to the ANC in this election is fierce, but fragmented. The two biggest opposition parties, the Democratic Alliance and the Economic Freedom Fighters, are not predicted to increase their vote by anything near enough to overtake the ANC.

Instead, disgruntled South Africans are moving to an array of opposition parties; more than 50 will contest the national election, many of them new. One is led by South Africa's former President Jacob Zuma, who has turned against his former ANC allies. Zuma has been disqualified from standing as a candidate for Parliament but his party is still contesting and is the wildcard. He was due to vote in a rural part of his home KwaZulu-Natal province.

The ANC says it is confident of retaining its majority. Ramaphosa has pointed out how South Africa is a far better country now than under apartheid, when Black people were barred from voting, weren't allowed to move around freely, had to live in certain areas and were oppressed in every way. (PTI)

COPENHAGEN, May 29: The Swedish government said on Wednesday that it will donate military aid to Ukraine worth 13 billion kronor (\$1.23 billion) in the largest help package Sweden has so far donated.

"It consists of equipment that is at the top of Ukraine's priority list," Deputy Prime Minister Ebba Busch said. It included air defense, artillery ammunition and armored vehicles.

Sweden's Defense Minister Pål Jonsson reiterated that the country has ruled out for now sending any Swedish-built JAS 39 Gripen jets to Ukraine, saying the focus on the Ukrainian side is on implementing the F-16 program.

Several countries have said they want to donate F-16 fighter jets. On Tuesday, Belgium pledged 30 F-16 iets to Ukraine. Jonsson said Sweden "is still working on possibly being able to contribute with the Gripen system later."

COVID-19, Prayuth Bejraguna, a spokesperson for the Office of the Attornev General, said at a news conference.

The attorney general's office scheduled a new appointment for Thaksin's indictment on June 18, Prayuth said, adding that Thaksin will also be indicted for violating the Computer Crime Act.

The law on defaming the monarchy, an offense known as lese majeste, is punishable by three to 15 years in prison. It is controversial not only because critics consider it harsh, but also because they charge it is used for political purposes to punish government critics. Thaksin was ousted by a military

coup in 2006. His opponents then had accused him of disrespecting King Bhumibol Adulyadej, who died in 2016. Thaksin's ouster set off years of struggle between his supporters and his opponents, who were generally staunch royalists.

The political polarization led to unprecedented public debate about the monarchy's role, which sharpened when student-led

protests for greater democracy took the the streets in 2020.

Thaksin had been in self-imposed exile since 2008, but returned to Thailand in August last year to begin

serving an eight-year sentence on charges related to corruption and abuse of power. He was released on parole in February from the hospital in Bangkok where he spent six months serving time for corruption-related offenses.

On his return, he was moved almost immediately from prison to the hospital on grounds of ill health, and about a week after that King Maha Vajiralongkorn reduced his sentence to a single year. (AP)

Do you feel that those who have come to power through Form 47s have anything to offer? Holding talks with them would be fruitless," he said. Khan's Pakistan Tehreek-e-Insaf (PTI) party believes that the Shehbaz Sharifled government stole its mandate in the February polls and the results were changed in Form 47s to benefit the Pakistan Muslim League-Nawaz (PML-N) and the Pakistan Peoples Party (PPP).

"Those who want to unite and struggle for the restoration and supremacy of the Constitution should do that. But talks should only be held with those who can offer something and bring something credible to the table,' Alvi said.

### 14 killed in landslide, eight missing as stone quarry houses collapse between Melthum and Hlimen in Mizoram Hundreds reel under Mizoram: Rescue operations on to find missing victims of landslides flood waters in Manipur



AIZWAL, May 29: A day after 25 bodies were recovered from debris caused by massive landslides due to incessant rain across Mizoram, rescue operations continued on Wednesday to locate missing persons, an official report said.

According to the morning bulletin of the Mizoram State Disaster Management Authority (MSDMA), rescue operations began early morning to find the missing people at several locations, including the site of an abandoned stone quarry where several houses collapsed on Tuesday morning.

Several people went missing in landslides, mostly in the state capital region, which was cut off from the rest of the country for several hours and bore the brunt of the natural calamities

In a massive landslide, at least 14 people, including two minors, were killed and

around eight others were missing as stone quarry houses collapsed in an area between Melthum and Hlimen on the southern outskirts of the Aizawl town.

"Search and rescue operations are in progress. Authorities have deployed 25 personnel from 3rd MAP, 22 personnel from 1st MAP and 10 personnel from 5th IR battalion at the site," MSDMA said in the report.

It stated that several houses and worker camps caved in due to the impact of the landslide, burying at least 22 people beneath the debris. Among the deceased are a fouryear-old boy and a six-year-old girl.

"The weather is so far comfortable with no rain since morning. We hope to continue the operations without any hindrance by nature although it is cloudy now," an official of the MSDMA told PTI. Aizawl's Deputy Commissioner Nazuk

Kumar said on Tuesday that the search operations will continue till the entire site is cleared.

At nearby Hlimen of Aizawl district, where five people were recovered and four others are still missing, the authorities continued the rescue operations in search of the people, the morning bulletin said.

A building in Aizawl's Salem Veng caved in due to a landslide, following which three persons went missing and their bodies were recovered later on Tuesday

One person each died in Falkawn, Lungsei and Kelsih of Aizawl district when landslides buried their houses.

The MSDMA also stated that eight members of a family inside a house were swept away by a heavy landslide at Chawnpui in Aizawl district.

NFR provides assistance to stranded passengers

The state capital was cut off for the whole

day on Tuesday from the rest of the country due to landslides on National Highway-6 at Hunthar and NH-54 at Bungbangla. The road blockades were cleared in the evening and the traffic movement was restored, the officials said.

In Aizawl town, some cemeteries at Republic Veng, Kanan Veng and Kulikawn have also been swept away by landslides, and over 200 graves were damaged.

According to the India Meteorological Department's regional centre in Guwahati, light to moderate rain is very likely to occur at most places over Mizoram on Wednesday, while thunderstorms and lightning with gusty wind reaching up to 30-40 kmph speed are very likely to occur at isolated places in the hill state.

The Mizoram government has ordered the closure of all offices and PSU units on Wednesday in view of the inclement weather warning issued by the IMD on cyclone 'Remal', except those departments involved with disaster management and essential services.

General Administration Department Commissioner and Secretary K Lalthawmmawia in the order also advised the private sector entities to adopt 'work from home' mode as far as possible in view of the weather warning. Mizoram Chief Minister Lalduhoma announced Rs 4 lakh ex-gratia for the families of those killed in the stone quarry collapse and calamities caused by rain in other parts of the state.

He said the government has earmarked Rs 15 crore to tackle disasters triggered by rain, which occurred as an aftereffect of cyclone 'Remal'.

More than 150 houses have been destroyed, dozens of trees and electric poles were uprooted, several roads were blocked and over 50 dwelling units were submerged across Mizoram in a trail of destruction left by the after effect of cyclone 'Remal'. (PTI)

IMPHAL, May 29: Incessant rains have disrupted normal life across Manipur as hundreds of people have been affected by floods in Manipur's Imphal Valley, an official said on Wednesday.

The overflowing Imphal River has inundated several areas, with water entering hundreds of houses, affecting several thousands, who

have been forced to take shelter at nearby community halls, he said. "Due to incessant rainfall, the riverbank has been breached near Keirang, Khabam and Lairiyengbam Leikai areas in Imphal East district and water gushed into several areas, inundating hundreds of

houses." he said Several areas in Heingang and Khurai assembly constituencies in Imphal East district have been badly affected, with floodwater at chest level in many parts.

Over 4,000 people may have been affected by the flood, though exact figures are unavailable at the moment

Chief Minister N Biren Singh said, "Due to breach in riverbank in several areas, many people and livestock have been affected. All authorities concerned, including state government officials, security and NDRF personnel and local volunteers, are working tirelessly to provide assistance to the affected people. Those stranded are being relocated to safe areas by

boats. Floods were reported from across the state, with the hill districts being the most affected. Imphal-Jiribam section of NH-37, the second lifeline of the people of Manipur has also been cut off after the bailey bridge on Irang River at Taobam village in Noney district collapsed amid mudslides at various places along the stretch of the highway. The bridge was a vital structure on NH 37 connecting Imphal and Silchar.

Strong water current triggered by heavy downpour led to the col-lapse of the bailey bridge in the afternoon on Tuesday.

The collapse of the bridge occurred at a time rescuers were engaged in clearing the debris at various places along the highway

A loaded truck was also swept into the gorge by a heavy mudslide along the same highway near K Sinam village of Kangpokpi district on Tuesday around 9.30 am.

Fortunately, no casualty was reported. Many vehicles remain stranded on both sides, waiting for excavators to clear the debris.

In Senapati district, many rivers and streams were overflowing and flood waters entered several localities of the district.

The continuous heavy downpour also severely affected other hill districts including Churachandpur, Ukhrul, Tamenglong, Pherzawl, Chandel, Kangpokpi

The heavy downpour accompanied by gusty wind also caused widespread damages to the houses and other structures across Tamenglong district, the reports said. Roofs of several houses were swept away by the gusty wind.

There were reports of overflow of smaller rivers across the valley districts amid flooding of low lying areas due to water logging.

The water logging also created traffic chaos on the streets across the capital city including those situated by the Regional Institute of Medical Sciences and the Jawaharlal Nehru Institute of Medical Sciences.

Meanwhile, the Manipur government through the district administrations had issued an advisory to the general public on Tuesday to remain alert and take necessary precautions to avoid the loss of life and property in view of the severe cyclonic storm Remal.

The advisories stated the severe cyclonic storm Remal may be accompanied by rain and squally wind gusting up to 55 kmph over the state starting from May 26.

The Indian Meteorological Department had issued an orange alert for the entire state of Manipur.

One of the public advisory issued by Imphal East deputy commissioner advised the general public to stay informed and keep themselves updated with the latest weather forecasts and warnings issued by local, state, and national authorities.

The advisory directed the public to ignore rumors, keep their doors and windows shut and secure loose objects. They are also to prepare an emergency kit with essential items such as non -perishable foods, water, torchlights, first aid supplies, medicines, etc. for safety and survival. Children and elderly have been asked to stay indoors and not venture out until absolutely necessary.

The state government has asked the people to postpone agriculture and other related activities during the inclement weather. They are to call on emergency helpline numbers for any query or assistance. (With inputs from PTI, NNN)

HT Correspondent DIMAPUR, May 29: A team of re-searchers at the Nagaland University has developed a novel and environmentfriendly method for producing bromographene, a modified form of grapheme, for eco-friendly chemical processes in industrial applications.

The research team was led by Dipak Sinha from the department of chemistry of the Nagaland University, Dinesh Rangappa from the department of applied sciences (nanotechnology) at the Visvesvaraya Technological University and their PhD student Suraj Kumar, Peter Ki, public relation officer of the Nagaland University said.

Kumar is a recipient of the INSPIRE fellowship sponsored by the Department of Science and Technology under the Union ministry of science and technology. The research team introduced the new

method for preparing bromographene and their work has earned them a German utility model IPR.

Their method used a safer brominating agent called tetrabutylammonium tribromide to convert reduced graphene oxide into bromographene. This process was completed in just one hour, the fastest time reported so far, and it avoided the need for harsh conditions, making it much safer and more environmentfriendly.

The new approach not only speeds up the production process, but also has one of the highest reported bromine contents, making it useful for further chemical modifications that can lead to new advancements in electronics, composites, and other high-tech materials.

By focusing on creating safer and faster production methods, the researchers from the university made a sustainable innovation in material science,

promising a future where high-performance materials can be produced without compromising safety or the environment.

Graphene, a two-dimensional wonder material, gained global fame in 2010 when Sir Andre Geim and Sir Konstantin Novoselov from the University of Manchester were awarded the Nobel Prize for its discovery. It is celebrated for its potential to transform industries such as electronics, drug delivery, touch screens, paints, energy storage and water purification.

The magic of graphene lies in its exceptional strength and outstanding electrical and thermal conductivity. However, its practical use is often hindered by its poor solubility in common solvents. This limitation is overcome by bromographene, a modified form of grapheme that enhances its chemical reactivity and versatility, a statement from the Nagaland University stated.

SRINAGAR, May 29: Election authorities in Kashmir have registered an FIR against former chief minister and PDP president Mehbooba Mufti for allegedly violating the Model Code of Conduct, officials said on Wednesday.

The FIR has been registered against Mehbooba for violating Section 144 after she and her party workers held a protest sit-in in the Bijbehara area of south Kashmir's Anantnag district, the officials said. The PDP president termed the registration of the FIR against her as "amusing".

"We will complain. He can meditate, but it cannot be aired on television," she said, claiming that this will amount to "violation of the MCC." "Does anyone have to get cameras for doing meditation?" she asked, claiming that it was a way of canvassing during the silence period between the end of campaign and the poll date.

According to BJP leaders, Modi will meditate from May 30 evening to June evening at Dhyana Mandapam, the place where Vivekananda — a spiritual icon admired by Modi - is believed to have had a divine vision about 'Bharat Mata'. Speaking at an election meeting on the same ground where the PM held a rally on Tuesday in favour of Jadavpur constituency's BJP candidate, the Trinamool Congress chief claimed that Modi goes into meditation for 48 hours before the final phase of polling in every election.

The Prime Minister had undertaken a similar meditation exercise in a Kedarnath cave after the 2019 election campaign.

"If they (BJP) return to power this time, there won't be any political party, elections, independence, religion, humanity or culture," she said.

The TMC supremo sought to dismiss Modi's claim that the BJP will achieve the best results in Bengal this election, asserting, "This means they have lost; they will get rosogolla (zero) in Bengal."

MAHARAJGANJ/BALLIA (UP), May 29: Home Minister Amit Shah on Wednesday slammed the Samajwadi Party over "power shortages" during its term in Uttar Pradesh, and said the supply was uninterrupted during Ramzan but not on Janmashtami.

Addressing poll rallies in the state, Shah said this Lok Sabha election presents a choice between those who constructed the Ram temple and those who opened fire at Ram bhakts. The home minister addressed four rallies -first at Maharajganj, then Deoria, Ballia and Robertsgani -- canvassing for BJP and NDA candidates who are in the frav in the last and the seventh phase of Lok Sabha polls on June

Speaking at his rally in Ballia -- where the BJP denied a ticket to sitting MP Virendra Singh Mast in favour of former prime minister Chandra Shekhar's son Neeraj Shekhar --Shah launched a broadside against Akhilesh Yadav-led Samajwadi Party, alleging mafia used to harass people during its rule.

"When the BJP came to power, Yogi Adityanath was made chief minister and he fixed the mafias," Shah said.

Uttar Pradesh also faced electricity woes during the SP government, he said.

"There was power supply only for threefour hours. There was uninterrupted supply during Ramzan but not on Janmashtami. (Ramzan me toh puri aati thi, magar Janmashtami ke din nhin aati thi. After the BJP come to power, our Chief Minister Yogi Adityanath ensured 18-hour power supply," She said.

At his poll meeting in Deoria in support of BJP candidate Shashank Mani Tripathi, Shah accused the opposition of stalling the construction of the Ram Mandir for over 70 years and said the temple could only be built because of Prime Minister Narendra Modi

"This election is between those who constructed the Ram temple and those who opened fire on Ram bhakts," he said, referring to the firing at kar sevaks in 1990 when the late Mulayam Singh Yadav was the chief minister of Uttar Pradesh.

At his Maharajganj rally also, Shah took a jibe at INDIA bloc allies Samajwadi Party and the Congress, saying they have already decided to blame Electronic Voting Machines for their defeat in the Lok Sabha polls.

"The counting is on June 4. In the afternoon the two 'shehzade' (Rahul Gandhi and Akhilesh Yadav) will hold a press conference and say we lost the election because EVM was defective," he said. (*PTI*)

Accusing the BJP of embarking on a slander campaign against the TMC, Banerjee claimed that her party has had to fight against Central Bureau of Investigation (CBI), Enforcement Directorate (ED) and Income Tax (IT).

The Chief Minister said the CBI has sent a notice to TMC MLA from Canning Purba, Saokat Molla, to appear before it on Wednesday itself.

"Amid the elections, the CBI has asked Saukat to come and meet its officials," she said.

# Free ration leaving people with more food than they can consume: Rajnath Food inflation in the country is the lowest in the world at 2.91 per cent

KARAKAT (BIHAR), May

29: Defence minister Rajnath Singh on Wednesday claimed that under the free ration scheme, people were getting more foodgrains than they could consume and they ended up selling the surplus in the market.

The former BJP president, who was addressing an election rally in Karakat Lok Sabha constituency of Bihar, also, cited figures to assert that the food inflation rate in the country was "the lowest in the world" and expressed dismay over allegations of price rise.

"Are you not getting five kilogrammes of foodgrains each? I know if there are four members in a family, each is getting a supply of 5 kg and those who are not able to consume it, sell off the surplus," Singh said with a chuckle, breaking into the local dialect Bhojpuri.

Claiming that the central



government has not done a favour to people by providing them with welfare measures like toilets and pucca houses, he said BJP people are in politics with the spirit of service. "There is so much hullabaloo around price rise. I would like to tell you that food inflation in

the country is the lowest in the

world at 2.91 per cent. In the US, it is 7.79 per cent, 19 per cent in France, 8.5 per cent in Australia, 48 per cent in Pakistan and 21 per cent in Sri Lanka," he said.

The defence minister challenged the Congress and its Bihar ally RJD, to counter him on these facts.

"If there is a mistake, I will admit it since I have never tried to cheat people in my political career," said Singh.

In his nearly 30-minute-long speech, the senior BJP leader mocked the Congress, claiming that it will soon be extinct like dinosaurs, and likened the RJD to a lantern, the party's poll symbol, of which the flame had grown unsteady since "the oil was running dry".

Singh also showered encomiums on Prime Minister Narendra Modi, claiming that India was no longer looked down upon as a weak country under

"Pakistan does not dare to send terrorists any more ... Russia and Ukraine agreed to halt their war to enable safe return of our students stranded there," he said. The former union home minister also lauded the government for scrapping Article 370 and bringing a law

against triple talaq. "We do not accept any practice that hurts the honour of our sisters and daughters. We act

without caring about votes," he said. Singh also said after the elections, people should look forward to greater welfare measures from the Modi government, and remarked: "People from all social segments, if

they are more than 70 years of age, will be made eligible for free medical treatment under Ayushman scheme. You never know, Modi may approve it in the first cabinet meeting itself". Turning towards Upendra

Kushwaha, the Rashtriya Lok Morcha president who is the NDA candidate from Karakat, Singh said, "I am glad that you have been allotted the gas cylinder as the poll symbol because Modi is going to distribute more gas cylinders in his upcoming tenure". (PTI)

# TMC issuing false caste certificates to Muslims: Modi

KAKDWIP (WB), May 29: Prime Minister Narendra Modi on Wednesday alleged that the Trinamool Congress government in West Bengal was giving away the rights of "original" OBCs to Muslims by issuing "false caste certificates".

# Delhi records its highest ever temperature Mungeshpur bakes at 52.3 deg C

NEW DELHI, May 29: Delhi's Mungeshpur area Wednesday logged a maximum of 52.3 degrees Celsius, the highest ever temperature recorded in the city, officials said. On Tuesday, the weather station in the northwest Delhi locality recorded 49.9 degrees Celsius.

A day later, the temperature rose further with the weather station recording a maximum temperature of 52.3 degrees Celsius at 4.14 pm, according to the website.

An IMD official told PTI. this is the highest ever maximum temperature recorded so far in Delhi.

Explaining the reason behind the rising mercury, IMD regional head Kuldeep Srivastava said the city's outskirts are the first areas to be hit by hot winds from Rajasthan.

"Parts of Delhi are particularly susceptible to the early arrival of these hot winds, worsening the already severe weather. Areas like Mungeshpur, Narela and Najafgarh are the first to experience the full force of these hot winds," he said.

Mahesh Palawat, the vice president of Meteorology and Climate Change at Skymet Weather, said, "In open areas with vacant land,



there is increased radiation. Direct sunlight and lack of shade make these regions exceptionally hot."

"When wind blows from the west, it affects these areas first. As they are on the outskirts, temperatures rise rapidly," Palawat added. Open areas and barren land are contributing to higher temperatures due to increased radiation, said

# Delhi breaches power demand of 8,300-MW first time ever

NEW DELHI, May 29: Delhi's peak power demand reached the all-time high of 8,302 MW on Wednesday afternoon as the city logged its highest-ever temperature of 52.3 degrees Celsius at the Mungeshpur weather station.

Officials said this is the first time in the city's history that the power demand has breached the 8300-MW mark and the mercury crossed 52 degrees Celsius.

Power distribution companies had estimated the demand to peak at 8,200 MW this summer, but according to the State Load Dispatch Centre, Delhi, it clocked 8,302 MW at 15:36:32 hours on Wednesday.

The previous peak power demand was recorded just a week ago, when it touched 8,000 MW on May 22.

The city has been braving a prolonged spell of heatwave conditions with the maximum day temperatures in many parts including Najafgarh, Mungeshpur and Narela touching almost 50 degrees Celsius.

Delhi's demand usually peaks during Juneend and early July, a trend that was broken last year when it peaked in August, according to discom officials.

A discom official said, "Air conditioning can contribute to 30-50 per cent of a household or commercial establishment's yearly energy expense.'

With the peak demand reaching 8302 MW mark on Wednesday, it was the 12th day in a row when it has crossed the 7000-MW mark.

Until previous year, the all-time high peak

KOCHI, May 29: BJP leader Shone George has filed an application in the Kerala High Court, alleging that Chief Minister Pinarayi Vijayan's daughter's now defunct company Exalogic "parked" huge sums in an account in Abu Dhabi and that Canadian company SNC Lavalin routed funds to the USA through it. Vijayan is accused of being part of

the alleged corruption in awarding a contract to Canadian firm SNC Lavalin when he was Kerala Power Minister in 1996, which had allegedly caused loss to the state exchequer.

Vijayan and two others were discharged in the case by a special court in Thiruvananthapuram in 2013, a verdict upheld by the Kerala High Court in 2017 when the CBI filed an appeal against the discharge.

The agency then filed an appeal in the Supreme Court against the high court's order and the matter is still pending before the apex court.

The application by Shone George, a lawyer and son of veteran politician PC George, has been moved as part of his plea in the HC seeking an investigation into Vijayan's daughter Veena T's company under the Companies Act and ac-

tion against it by the Serious Fraud Investigation Office (SFIO).

Later, the Centre had told the high court that a probe under the Companies Act had been initiated and the SFIO was also looking into the mat-

In his application, George has claimed that according to "reliable information" received from a person working abroad, a huge trail of money "emanating from the transactions" under investigation by the SFIO "were parked by the culprits in an account

maintained with the Abu Dhabi Commercial Bank in the UAE in the name of Exalogic Consulting"

He has further claimed that the said account "was operated by Veena T and one Suneesh M during the year 2016 to 2019 and huge funds from SNC Lavalin and PricewaterhouseCoopers (PWC) were routed through the said account to various accounts maintained in banks in the USA".

George had filed the plea seeking the SFIO probe into Veena's firm Exalogic following the controversy which erupted in Kerala after a Malayalam daily reported last year that Kochi-based mining company CMRL had paid a total of ₹ 1.72 crore to the chief minister's daughter between 2017 and 2020.

The news report cited the ruling of an interim board for settlement and said that CMRL previously had an agreement with Veena's IT firm for consultancy and software support services.

It also alleged that although no service was rendered by her firm, the amount was paid on a monthly basis "due to her relationship with a prominent person". (PTI)

# India successfully test-fires Rudra airto-surface missile

NEW DELHI, May 29: India on Wednesday successfully test-fired a Rudra air-to-surface missile from a Su-30 fighter jet of the Indian Air Force (IAF) off the coast of Odisha. The defence ministry said the flight-testing of the RudraM-II mis-

sile met all the trial objectives. RudraM-II is an indigenously-de-

veloped solid-propelled air-launched missile system meant for air-to-surface role to neutralise several types of enemy assets.

A number of state-of-the-art indigenous technologies developed by various DRDO (Defence Research and Development Organisation) laboratories have been incorporated in the missile system.

"The DRDO successfully flighttested the RudraM-II air-to-surface missile from Su-30 MK-I platform of the Indian Air Force off the coast of Odisha at around 1130 hours on May 29," the ministry said.

"The flight-test met all the trial objectives, validating the propulsion system and control and guidance algorithm," it said.

The ministry said the performance the missile has been validated

power demand of city was 7695 MW, recorded on June 29, 2022, discom officials said.

Last year's peak power demand was 7,438 MW. A BSES spokesperson said BRPL and BYPL discoms successfully met as the city's power demand on Wednesday.

He said around 2,100 MW of green power will play an important role in powering Delhi as its demand rises in the summer months this year. The BSES discoms invested substantial resources to strengthen the network and undertook extensive preventive checks like thermo scanning to help identify potential hot-spots and take remedial measures to prevent any snags, he said.

The fact that the Delhi's power distribution network has been able to sustain this prolonged high demand for power shows its robustness, discom officials said.

A Tata Power Delhi Distribution Limited (TPDDL) spokesperson said that the persistent heat wave across North India is leading to a sharp demand surge for electricity in the national capital. (PTI)

# HC agrees to hear on Friday Kejriwal aide Bibhav Kumar's plea Arrest in Maliwal assault case

NEW DELHI, May 29: The Delhi High Court will hear on Friday a plea by Chief Minister Arvind Kejriwal's close aide Bibhav Kumar against his arrest for allegedly assaulting AAP Rajya Sabha MP Swati Maliwal earlier this month.

The petition was mentioned for urgent listing before a bench of Acting Chief Justice Manmohan and Justice Manmeet PS Arora which agreed to hear it on May 31

Kumar, in his plea mentioned by advocate Rajat Bhardwaj, sought his arrest to be declared illegal, in gross violation of the provisions of Section 41A of the Code of Criminal Procedure, and against the mandate of law.

He also sought appropriate compensation for his "illegal" arrest and initiation of departmental action against the "erring" officials who were behind the decision to arrest him.

On Monday, Kumar's bail plea was dismissed by

a sessions court, which said there appeared no "premeditation" by Maliwal in lodging the FIR against him and that her allegations could not be "swiped away"

Maliwal has alleged that Kumar assaulted her at the chief minister's official residence on May 13. Kumar was arrested on May 18 and he was sent to police custody for five days the same day by a magisterial court, which observed that his anticipatory bail plea had become infructuous because of his arrest.

Last Friday, he was sent to four-day judicial custody.

The FIR against Kumar was registered on May 16 under various Indian Penal Code (IPC) provisions, including those related to criminal intimidation, assault or criminal force on a woman with the intent to disrobe, and attempt to commit culpable homicide. (PTI)

# Northeast likely by Thursday Kerala has been receiving heavy rains for the past few days

Monsoon onset over Kerala,

NEW DELHI, May 29: Spurred on by Cyclone Remal, southwest monsoon is expected to hit the Kerala coast and parts of northeast by Thursday, a day ahead of the date forecast by the weather office.

"Conditions continue to become favourable for the onset of the southwest monsoon over Kerala during the next 24 hours." the India Meteorological Department said on Wednesday. On May 15, the weather office had announced the onset of monsoon over Kerala by May 31.

Weather scientists said that Cyclone Remal, which ripped through West Bengal and Bangladesh on Sunday, had pulled the monsoonal flow to the Bay of Bengal, which could be one of the reasons for early onset over the north-east.

Kerala has been receiving heavy rains for the past few days resulting in a surplus May rainfall, the weather office data showed.

The normal monsoon onset date for Arunachal Pradesh, Tripura, Nagaland, Meghalaya, Mizoram, Manipur, and Assam is June 5. The conditions also continue to become favourable for further advance of Southwest Monsoon into some more parts of South Arabian Sea, remaining parts of Maldives, Comorin, Lakshadweep, southwest and central



Bay of Bengal, northeast Bay of Bengal and some parts of Northeastern states during the same period," the IMD said.

The IMD declares onset of monsoon over Kerala if anytime after May 10 over 14 stations there and neighbouring areas receive 2.5 mm or more rainfall for two consecutive days, the Outgoing Longwave Radiation (OLR) is low, and the direction of the winds is south-westerly.

Monsoon is critical for India's agricultural landscape, with 52 per cent of the net cultivated

area relying on it. It is also crucial for replenishing reservoirs critical for drinking water, apart from power generation across the country.

June and July are considered the most important monsoon months for agriculture because most of the sowing for the Kharif crop takes place during this period.

El Nino conditions are prevailing at present, and La Nina may set in by August-September, scientists say.

El Nino - the periodic warming of surface waters in the central Pacific Ocean - is associated with weaker monsoon winds and drier conditions in India. La Nina - the antithesis of El Nino- leads to plentiful rainfall during the monsoon season.

The IMD is also anticipating the development of a positive Indian Ocean Dipole (IOD) or cooler-than-normal Indian Ocean in the east compared to the west, which helps bring rain to several states in southern India.

The IOD is currently 'neutral' and is expected to turn positive by August.

Another factor is the below-normal snow cover in the northern hemisphere and Eurasia. Historically, there has been an "inverse relationship" between the levels of snow here and the monsoon. (*PTI*)

# WANTED TO SHOW THE REALITY OF PUNJAB THROUGH 'JAGGI': DIRECTOR ANMOL SIDHU

**NEW DELHI, May 29:** Punjab of Hindi films is different from reality, says "Jaggi" filmmaker Anmol Sidhu, who believes native storytellers need to step up and present the true picture of the state.

Sidhu's "Jaggi" has been hailed by critics as an incisive take on the hyper and toxic masculine culture among the youth of Punjab. The film, which won awards in the Indian Film Festival of Los Angeles and Inaugural Cinevesture International Festival, is now screening on streaming platform MUBI.

"You will see the reality of Punjab in Chandigarh, in the Panjab University. And then you come to the rural areas where you see a different Punjab. Bollywood makes films about Punjab where people are dancing in fields. You will have comedy scenes and that makes you think that Punjab is like that.

"In fact, my family members often ask me why don't I make films like Bollywood. But my attempt with 'Jaggi' was to show the reality of Punjab," Sidhu told PTI in an interview.

There has been an influx of stories that have started to offer a more nuanced portrayal, often addressing social issues such as drug problem and socio-political issues in the state with movies such as "Udta Punjab", "Meel Patthar" and OTT shows like "Kohrra" and "Tabbar". Sidhu has an interesting take on this as he believes that the makers of these films and shows are not actually from Punjab.

"It is not the people of Punjab that are making films about the state. It is people from outside who have found out different stories of the state. 'Kohrra' is a good show but it is not made by someone who comes from Punjab.

"There are only a handful of storytellers from Punjab like Gurvinder sir or Jatinder Mauhar, who are trying to show something different. I believe filmmakers from Punjab should make cinema that reflects the reality of the state. Even actors from Punjab, they still don't get work that they deserve," he added.

Ramnish Chaudhary, who plays the lead role of Jaggi, said he never imagined that the film will have such a journey. "I didn't even anticipated it going to any film festival... We created the character together. I surrendered myself to Anmol's vision," Chaudhary said.

"Jaggi" marks the feature directorial debut of Sidhu, who earlier made the short film "The Last Tree" in 2020.

The film, crafted with a hands-on approach, addresses issues of toxic masculinity and challenges stereotypical depictions of Punjabi machismo, chronicling the distressing story of its titular character.



Navigating between the past and present experiences of the central character, the film first delves into the severe bullying and repeated sexual assault that Jaggi faces in his school in rural Punjab. It then shifts focus to the present with Jaggi on the verge of getting engaged and how his past experiences still haunt him.

With the movie, Sidhu said the aim was to highlight the issues of sexual repression and the severe gender segregation prevalent in his community.

"Honestly, I was not aware of terms like hyper masculinity when I made the film. When I was writing the film, my

understanding of life in Punjab was simple that a girl and a boy can't meet in private. And because of this, young people have a lot of frustration."

What happens in the case of extreme sexual frustration is what Sidhu has tried to show in "Jaggi".

"It is all about the frustration in young men and how they take it out on small kids or those who are weak. I imagined how a person's life would be affected if such a thing happens to him?"

Sidhu believes the easy access to adult videos as well as the songs and movies coming out of Punjab have contributed to the problem of sexual frustration among the youth.

"Right now, the kind of songs that are coming out of Punjab, they have a really bad influence over the public. Everyone wants to follow the singers and do stuff like them."

"Jaggi" is made in a DIY fashion. "There was no proper financing that we received for this film. The producer used to give us his salary, which was ₹10,000, that he would receive at the end of the month. And that helped us a lot, for travel and food. Things happened slowly over time. The camera that I used, I had taken from my friends," he said.

We learnt on the job and did everything, including dubbing and editing, on our own," he added.

With the film becoming available on MUBI, Sidhu believes he can now move forward in life.

"I feel the journey is now coming to an end. We started on this movie in March 2020... After the film was made, we faced difficulties in showcasing it. For about a year, it didn't go to any film festivals... I used to feel that if it is not screened anywhere, then what will happen to it?

"But I believe that every film comes with a journey. This film had its own journey and finally it is coming to MUBI." (PTI)

# Djokovic begins his bid for a 25<sup>th</sup> Grand Slam title


PARIS, May 29: Ignore the straight-set score: Novak Djokovic was not quite at his impervious best in the first round of the French Open, and his 6-4, 7-6 (3), 6-4 win over Pierre-Hugues Herbert was not enough to alter the defending champion's "low expectations" at this tournament.

"I don't want to get too excited," Djokovic said. "I thought it was a good performance for me. Solid. Of course, I could have done better, I think, on return games, but also credit to him for serving very well, for changing things up.'

It's been a rougher-than-usual season so far for Djokovic, and while there were some signs of breaking out of his 2024 funk during the course of the contest at Court Philippe Chatrier, he still has room for improvement as he attempts to become the first player in tennis history to claim 25 Grand Slam singles trophies. There's no doubt he cares about such things.

"Grand Slams are the ones that are basically getting me up from the bed every day. Knowing that I have to hit the practice courts, I always think about what I can do in Grand Slams," he said. "So here I am. Hopefully I can have another deep

run." That's what Herbert expected to see. "I knew, from the beginning," Herbert said, "that I'm going to have in front of me the Novak of the Grand Slams. ... It's just the intensity of concentration.



Djokovic is a three-time title winner at Roland Garros who needs to return to the final to retain his No. 1 ranking. But he arrived in Paris without having done that at any tournament this year. He is 0-3 in semifinals —

including a loss last week at the lower-tier Geneva Open on red clay — and this victory across 2 1/2 hours only served to make his overall record 15-6. So when he spoke at a news

MADRID, May 29: Carlo Ancelotti is going into his eighth Champions League final, having won all but one of them.

He is the most successful coach in the competition thanks to four titles. He also lifted two European trophies as a player. There is no lack of experience for the veteran Italian manager. But there is still plenty of anxiety and fear for Ancelotti ahead of yet another big game. "It's the same as it was the first time," the 64-year-old Ancelotti said as Real Madrid entered the final week of preparations ahead of Saturday's final against Borussia Dortmund in London. "First there is the joy of being here, then the concerns will come and the fear will come," he said. "But before they come we have to enjoy this week and I'm going to enjoy it. The cold sweat will arrive Saturday afternoon, it's normal, I'm already prepared for it. And this team gives me a lot of confidence, I see them focused on the match, they are in Champions

(League) mode." Ancelotti won the Champions League with Madrid in 2022 and 2014, and with AC Milan in 2003 and 2007. He lost the 2005 edition with AC Milan in a final in a penalty shootout against Liverpool after squandering a 3-0 lead.

His European triumphs as a player came with Milan in 1989 and 1990. He was also in the squad with Roma when it reached the 1984 final but he sat out injured. Ancelotti said he will stick to his routine before the final at Wembley Stadium.

"I'm a bit superstitious but it's very normal. I was told that it's bad luck not to be superstitious," he said. "I like to eat broccoli, salmon and pasta, and that's what I'll eat.

Then I'll have an hour's nap, if I'm able to. And then I'll start thinking about the match. Before the talk with the players, my heart will start to rise to 110 or 120 beats. It'll stay up there until the start of the game, and when it starts it will go back to its normal rhythm.'

Ancelotti said some of his most memorable Champions League highlights are linked to his time with Madrid, including the incredible run in 2022, when it had to rally several times to make it to the final. He also mentioned the late comeback in the semifinal against Bayern Munich a few weeks ago, when Joselu scored in the 88th minute and in stoppage time.

Ancelotti said this season was especially difficult because of the long list of injuries to some of the team's key players, including serious knee problems to Thibaut Courtois, Éder Militão and David Alaba. Also missing time because of injuries were Vinícius Júnior, Jude Bellingham, Eduardo Ca-Aurélien mavinga and Tchouaméni. "Attitude and commitment have been the key to overcoming all the problems we've had," Ancelotti said. "That's what allowed us to have a fantastic season." Madrid, which also won the Spanish league and the Spanish Super Cup, is trying to win its sixth European Cup in 10 seasons, matching a feat the club also achieved from 1955-65.

Ancelotti said he prides himself more about the way he has managed his locker rooms than his teams' tactics over the years.

"Personal relationships are more important than professional relationships," he said. "I'm not a psychologist but I'm experienced as I've worked for many years in locker rooms." (AP)

# Last Dance: Final chance for Kohli, Rohit to give India a World Cup after 13 years

BENGALURU, May 29: It's tough to find two cricketers who are so different from each other yet so closely intertwined by the same thread of fate as Virat Kohli and Rohit Sharma.

Rohit's initiation into top-flight cricket came at the idyllic Belfast in 2007 and Kohli's a year later at the more conventional Dambulla. Another intriguing chapter of this journey toegther will potentially come to an end next month in the stunning Caribbean Isles.

The next T20 World Cup is in 2026, to be jointly hosted by India and Sri Lanka, but Rohit would be touching 40 then and Kohli would be 38. The 50-over version is a further one year away.

It's hard to see them playing in any of those, considering the increasingly strike-rate oriented nature of the game.

So, both Rohit and Kohli will want to leave the stage with the winner's medal around their neck next month. Should they achieve that, it would be their second each after the 2007 T20 World Cup (Rohit) and the 2011 50-over showpiece (Kohli).

And it will be a perfect send off for two players who have had an immeasurable impact on India's white-ball fortunes in the last 17 years.

However, the Kohli-Rohit story is not one of bromance.

It's based more on mutual respect and the awareness that they should not step into each other's

Kohli has talked about the ad-

miration he has had for Rohit since the very beginning of their careers.

"I was filled with curiosity about a player. People kept on saying – 'This is one player who is rising rapidly'. I used to wonder that even though I am a young player, no one talks about me, then who is this player.

"But when he (Rohit) stepped out to bat, I was all quiet. It was amazing to watch him play. In fact, I haven't seen a player time the ball better than him," Kohli had said in 'Breakfast With Champions'.

Contrasting in nature, their batting has been high art for the masses to which they added a dash of modernity later.

Of the two, Kohli is the more all-format batter, who has adapted more fluently with the changing face of the game.

He has scored in every corner of the cricketing world in a show of consistency that was rarely witnessed after the halcyon days of Sachin Tendulkar.

While Rohit built his own edifices in white-ball formats, the Mumbai-man remained a reluctant visitor in Test cricket's elite corridors for the better part of his career

A move up to the opener's role helped Rohit unshackle himself a bit in Tests in the later part of his career.

But for now, Kohli and Rohit will have to lean on their vast experience in T20 cricket to fuel India's run in the World Cup.



# India bids to host Gukesh-Liren World Chess Championship match

and that would surely give them **NEW DELHI**, May 29: India has submitted its bid to host the muchanticipated World Chess Championship clash between teen sensation D Gukesh and defending champion Ding Liren of China in November-December this year. The 17-year-old Gukesh became the youngest ever challenger for the world title by winning the Candidates Tournament last month. He will face Liren between November 20 to December 15 in Chennai if the All India Chess Federation (AICF) manages to claim the hosting rights. "We have received the bid from India," Chess' global governing body FIDE CEO Emil Sutovsky told PTI.

As of now, FIDE hasn't received any other bids but the deadline to enter the race is May 31. It is learnt that Singapore is expected to compete

If AICF wins the bid, it will have to shell out close to ₹71 crore. The basic criteria outlined by FIDE for a prospective bidder for the 2024 edition is a budget of ₹ 8.5 million (₹ 71 crore approx) and a facilitation fee of USD 1.1 million (₹ 9 crore) for the global body.

The duration of the tournament is 25 days and approval of regulations will be completed by July 1. The total prize money awarded by FIDE would be around USD 2.5 million (₹ 20 crore plus) after the fund was increased from the USD two million (₹ 17 crore) in 2023.

Gukesh's historic achievement at the Candidates has spurred a renewed wave of interest in chess. The Chennai-based teen, who has been mentored by five-time world champion Viswanathan Anand, bettered Russian legend Garry Kasparov's 40-year-old record to become the youngest Candidates champion. The Russian great was 20 when he qualified in 1984 to clash with compatriot Anatoly Karpov.

India last hosted the prestigious showpiece back in 2000 when Viswanathan Anand claimed the first of his five world titles by winning the event played in a tournament format with 100 players. Anand defeated Alexei Shirov in the final. (PTI)


