

Amit Shah's doctored video: Telangana CM seeks more time

Modi, Home Minister resorted to a vengeful attitude: Revanth Reddy

NEW DELHI, May 1: Telangana chief minister A Revanth Reddy has sought more time to appear before the IFSO unit of Delhi Police that is probing the case of a doctored video of home minister Amit Shah's speech, a senior police official said on Wednesday.

Reddy's lawyer appeared before the Delhi Police on Wednesday after summonses were issued against the Telangana Congress chief and four members of the Pradesh Congress Committee for allegedly posting the video on X.

They were asked to join the investigation on Wednesday at 10:30 am. The official, who requested anonymity, said that Reddy has sought more time to appear before the Intelligence Fusion and Strategic Operations (IFSO) unit of the Special Cell that is probing the case. Reddy's lawyer Saumya Gupta told reporters here that the



handle through which the video was shared did not belong to Reddy. "That account is not owned by the Telangana CM," Gupta said after meeting the Delhi Police's investigating officer at the IFSO office in Dwarka.

The summonses were issued to

Congress Committee (TPCC) members - Shiva Kumar Ambala. Asma Tasleem, Satish Manne and Naveen Pettem - under sections 91 and 160 of the Code of Criminal

Procedure (CrPC). According to police sources, if a person is served notice under section 160/91 of the CrPC, the person can either make a physical appearance before the IO or send a legal representative.

Addressing an election rally in Nizamabad Lok Sabha constituency in Telangana on Wednesday, Reddy said a case has been registered against him in Delhi based on the complaint of the Union Home Ministry.

"I questioned the BJP. When I did that, PM Narendra Modi and Home Minister Amit Shah resorted to a vengeful attitude and registered a case against me in Delhi," he alleged. The notices had been handed over by teams of Delhi Police's Special Cell to the Chief Minister's Office and at the Congress office at Gandhi Bhavan in Hyderabad on Monday.

"You come to my state and threaten the CM, but the people of Telangana won't be scared....

LUCKNOW (UP), May 1: Congress MP Rajeev Shukla on Wednesday said it has become clear from the last two phases of voting in the Lok Sabha elections that "the BJP has been cleared from the South and halved in the North".

Addressing a a press conference at the state Congress headquarters here, Shukla said it has become clear from the last two phases of voting that there is a "strong undercurrent against the Modi govern-

The Rajya Sabha MP said Prime Minister Narendra Modi "himself does not use the slogan of 400 paar in his speeches". "Forget about crossing 400, Modi ji has now stopped even talking about Modi's guarantee and the truth is that he has again come back to his old talk of Hindu-Muslim," he added.

Shukla said it is unfortunate that national level leaders of the BJP are also spreading lies about the Congress' manifesto 'Nyaya Patra'. "These people have completely destroyed purity and dignity in politics. The BJP has also forgotten the legacy of Atal Bihari Vajpayee," he



said. Escalating his attack on the Modi government, Shukla said today's BJP says that whatever happened in this country happened only after 2014. This Lucknow city was also built after 2014. All the development of this country has happened after 2014. The truth is that all former prime ministers have contributed to the development of the country, he added.

The Congress leader said that we had principled disagreements with

former prime minister Atal Bihari Vajpayee, but today the BJP does not even take the names of its own leaders like Vajpayee and Murli Manohar Joshi nor is their photo visible anywhere in the campaign.

Shukla said the BJP is neglecting its workers and distributing tickets to imported leaders.

Tripura govt imposes restriction on sale of petrol, diesel

AGARTALA, May 1: The Tripura government has imposed restrictions on sale of petrol and diesel from Wednesday as the fuel stock in the northeastern state has come down due to disruption of goods train movement, an official said.

Goods train movement to Tripura was hit by a massive landslide in Assam's Jatinga. Passenger train movement started on April 26 after restoration work. However, train service through Jatinga still remains closed during the night.

"In view of the supply constraint of petrol and diesel due to disruption in goods train movement to the state, it has been decided to impose restriction on sale of fuel – petrol and diesel in the state from May 1 until further order", said additional secretary of food and civil supplies department, Nirmal Adhikari.

'Two-wheelers and three-wheelers would get petrol amounting to Rs 200 per day while four-wheelers it would be Rs 500 per day," said the order issued by the Food and Civil Supplies department.

Fuel pumps have been told to sell only 60 litres of diesel to a bus per day, while for minibuses it is 40 litres and for autorickshaws and three-wheelers it is 15 litres per day, it said. When contacted, Chief PRO of NFR Sabyasachi De said the railway track was badly affected due to landslides at Jatinga in Assam's Dima Hasao district recently. "After restoration (CONTD. ON PAGE-2)

Cong-MNF coalition to run Lai autonomous council in Mizroam

AIZAWL, May 1: After a prolonged political deadlock in Mizoram's Lai Autonomous District Council (LADC), officials on Wednesday announced the formation of a Congress-MNF coalition administration to run the 25-mem-

LADC is one of the three autonomous district councils constituted under the Sixth Schedule of the constitution for Lai people in the southern part of the state with Lawngtlai as its headquarters.

Officials said 12 MNF members have joined forces with the lone Congress member, C Lalmuanthanga, to form the United Legislature Party (ULP). This newly formed coalition has presented its claim to Governor Hari Babu Kamphampati to run the council.

Lalmuanthanga is expected to become the chief executive member (CEM) of the council, officials added. Previously led by the MNF, the LADC was placed under governor's rule in March following the resignation of CEM V. Zirsanga in a graft case conviction.

In February, the special court (Prevention of Corruption Act) in Aizawl had sentenced Zirsanga to four years imprisonment and imposed a fine of ₹ 4 lakh for misappropriating ₹ 1.33 crore during his stint as an executive member of the

Soon after that, eight MNF members defected from the party and tied up with the opposition and submitted a complaint to the governor expressing lack of confidence in the Zirsanga-led council.

Following the CEM's resignation, one of the eight MNF members returned to Zirsanga's camp thus making a situation where no single party could garner the magic number to run the council as both the ruling and opposition camps had 12 (CONTD. ON PAGE-2)

TMC attacks Adhir over 'better to vote for BJP' remark

NEW DELHI/ KOLKATA, May 1: The TMC on Wednesday accused Congress leader Adhir Ranjan Chowdhury of being the "B-team" of the BJP after a purported video, where he allegedly stated that voting for the BJP is better than voting for the TMC, went viral, prompting a denial from the Congress, claiming the

video was "doctored" An eight-second video clip of Chowdhury's speech during an election rally in West Bengal's Murshidabad was shared by the TMC, where the sitting Congress MP and candidate from West Bengal's Baharampur was seen saying "It's better to vote for the BJP than to vote for the TMC."

However, the authenticity of the clip could not be verified by PTI. Responding to the clip, the West Bengal Congress unit termed it as doctored and officially complained to the EC, seeking intervention and appropriate penal action.

Commenting on the purported remarks, Congress leader Jairam Ramesh said the goal of his party is to bring down the numbers of the BJP in West Bengal and that the TMC is part of the INDIA bloc. Earlier in the day, the TMC, upset with Chowdhury's continual criticism and holding him responsible for the breakdown of seat-

sharing discussions with Congress in the state, labelled him as "anti-Bengal.

In a post on X, the TMC said after acting as the "eyes and ears of BJP in Bengal," Chowdhury has now been promoted to be the "voice of the BJP in Bengal."

"Listen to how the B-Team member is openly asking people to vote for the BJP - a party that refused to release Bengal's rightful dues and deprived our people of their rights. Only a Bangla-Birodhi can campaign for the BJP, which has repeatedly insulted Bengal's icons," the TMC said.

"On May 13, people of Baharampur will give a befitting response to this betrayal!" it added.

TMC Rajya Sabha MP Saket Gokhale also attacked the Congress leader over the remarks.

"Finally from the B-team horse's mouth! Congress Bengal chief Adhir Ranjan Chowdhury publicly asks people in his rally to vote for the BJP and not the TMC. While Mamata Banerjee fights against the full might of Modi+Central Agencies machinery, Bengal Congress is openly asking votes for the BJP," he said in a post on X. GST revenues hit record ₹ 2.10 lakh cr in April on strong eco momentum

and Services Tax collections grew 12.4 per cent to a record high of ₹ 2.10 lakh crore in April, aided by strong economic momentum and increased domestic transactions and imports, the finance ministry said on Wednesday.

The GST collections have breached the ₹ 2 lakh crore mark for the first time in April this year, it said in a statement.

"The Gross Goods and Services Tax (GST) collections hit a record high in April 2024 at ₹ 2.10 lakh crore. This represents a significant 12.4 per cent year-on-year growth, driven by a strong increase in domestic transactions (up 13.4 per cent) and imports (up 8.3 per cent)," the ministry said.

The GST revenue, which is basically taxes on goods sold and services rendered, was more than ₹ 1.78 lakh crore last month, while it stood at ₹ 1.87 lakh crore in April 2023.

Minister Nirmala Finance Sitharaman in a post on X (formerly Twitter) lauded the efforts of tax officers for achieving the mile-

"GST collection crosses ₹ 2 lakh crore benchmark, thanks to the strong momentum in the economy and efficient tax collections," she said.

Tax experts said robust GST revenues in April reflect a buoyant economy, self-compliance by businesses, timely audit and scrutiny, besides enforcement measures taken by the department. The increased collections also raise ex-



pectations of ushering in the next wave of GST reforms.

In April this year, the mop-up under Central GST (CGST) pool stood at ₹43,846 crore, while State GST (SGST) collection reached ₹ 53,538 crore and Integrated GST (IGST) ₹ 99,623 crore, including ₹ 37,826 crore collected through levies on imported goods.

The total cess collection was ₹ 13,260 crore, including ₹ 1,008 crore collected on imported goods. Out of the IGST collection, ₹

50.307 crore was settled towards CGST and ₹ 41,600 crore towards SGST. This translates to a total revenue of ₹ 94,153 crore for CGST and ₹ 95,138 crore for SGST in April 2024 after regular

said significant GST collection increases have been observed across all major producing and consuming states, indicating that it is widespread and not restricted to a few industrial pockets.

Considering the inflation at 5 per cent and GDP growth of 7 per cent, there has been an average buovancy of 1 per cent on an average per annum over the last seven years, Jalan said

Sanjay Chhabria, Senior Director, Indirect Tax at Nexdigm, said the significant rise in domestic transactions can be attributed to consumer spending being focused on beating the summer heat, with purchases like air-conditioners, beverages, as well as increased travel during long vacations from schools and colleges. ATF price hiked marginally, commercial LPG rate reduced by ₹ 19 per cylinder

NEW DELHI, May 1: Jet fuel or ATF price on Wednesday was hiked by a marginal 0.7 per cent while rates of commercial LPG used by establishments such as hotels and restaurants was cut by ₹ 19 per cylinder in line with international prices. Aviation turbine fuel (ATF) price was hiked by ₹ 749.25 per kilolitre, or 0.7 per cent, to ₹ 101,642.88 per kl in the national capital, according to a price notification of state-owned fuel retailers. The increase reverses the marginal 0.5 per cent cut effected on April 1. Rates in Mumbai on Wednesday were increased to ₹ 95,173.70 per kl from ₹ 94,466.41. Prices differ from state to state depending on the incidence of local taxes. Alongside, oil firms also cut the price of commercial

LPG by ₹ 19 to ₹ 1,745.50 for a 19-kg cylinder. This is the second monthly reduction in rates. Prices were on April 1 reduced by ₹30.5 per 19-kg cylinder. Rates of the cooking gas used in domestic households, however, remained unchanged at ₹803 per 14.2-kg cylinder. April 1 was the first reduction in commercial LPG prices since January. Rates had gone up ₹ 14 per cylinder on February 1 and ₹ 25.5 on March 1. State-owned Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL) revise prices of ATF and cooking gas on 1st of every month based on the average price of benchmark international fuel and foreign exchange rate. consolidates the unit of family and solidifies the spirit of fraternity within various communities. "We deprecate the practice of young men and women seeking to acquire the status of being a husband and a wife to each other and therefore purportedly being married, in the absence of a valid marriage ceremony under the provisions of the (Hindu Marriage) Act such as in the instant case where the marriage between the parties was to take place later," the bench said

In its April 19 order, the bench said where a Hindu marriage is not performed in accordance with the applicable rites or ceremonies such as 'saptapadi' (taking seven steps by the groom and the bride jointly before the sacred fire), the marriage will not be construed as a Hindu marriage.

We further observe that a Hindu marriage is a sacrament and has a sacred character. In the context of saptapadi in a Hindu marriage, according to Rig Veda, after completing the seventh step (saptapadi) the bridegroom says to his bride, 'With seven steps we have become friends (sakha). May I attain to friendship with thee; may I not be separated from thy friendship'. A wife is considered to be half of oneself (ardhangini) but to be accepted with an identity of her own and to be a co-equal partner in the marriage," it said.

In Hindu Law, marriage is a sacrament or a 'samskara' and it is the foundation for a new family, the bench noted, and said, "There is nothing like a "better-half" in a marriage but the spouses are equal halves in a marriage." Observing that with the passage of centuries and the enactment of the Act, monogamy is the only legally approved form of relationship between a husband and a wife.

"The (Hindu Marriage) Act has categorically discarded polyandry and polygamy and all other such types of relationships. The intent of the Parliament is also that there should be only one form of marriage having varied rites and customs and rituals," it noted. The bench said after the Act came into force on May 18, 1955, it had codified the law relating to marriage among Hindus and it encompasses not only Hindus as such but Lingayats, Brahmos, Aryasamajists, Buddhists, Jains and Sikhs also who can enter into a valid Hindu marriage coming within the expansive connotation of the word Hindu. "Unless the parties have undergone such ceremony, there would be no Hindu marriage according to Section 7 of the (Hindu Marriage) Act and a mere issuance of a certificate by an entity in the absence of the requisite ceremonies having been performed, would neither confirm any marital status to the parties nor establish a marriage under Hindu law," it said.

The top court highlighted that the advantage of marriage registration is that it facilitates proof of factum of wedding in a disputed case but if there has been no marriage in accordance with Section 7 of Hindu Marriage Act, "the registration would not confer legitimacy to the marriage". It noted that under the Special Marriage Act, 1954, a man and a woman can acquire the status of being a husband and a wife as per the provisions of the said Act.

"The Special Marriage Act, 1954 is not restricted to Hindus. Any man and woman irrespective of their race, caste or creed can acquire the status of being a husband and a wife under the provisions of the Special Marriage Act, 1954 but under the provisions of the Act (Hindu Marriage Act, 1955), there should not only be compliance of the conditions as prescribed under Section 5 of the said Act but also the couple must solemnise a marriage in accordance with Section 7 of the Act," it said. Exercising its plenary powers under Article 142 of the Constitution, the apex court declared the estranged couple were not married in accordance with the law and held the marriage certificate issued to them in absence of valid ceremony under the Hindu Marriage Act as null and void. It also quashed their divorce proceedings and a dowry case lodged against the husband and his family members. (PTI)

Enlightened leadership needed to resolve north-south divide on distribution of tax pool: Subbarao

NEW DELHI, May 1: Former RBI Governor Duvvuri Subbarao has opined that only enlightened leadership at Centre and state levels can resolve the complex northsouth divide in deciding on the distribution of the tax pool among states, saying it is beyond the remit of the Finance Commission.

Subbarao, who held various positions including the finance secretary of Andhra Pradesh and Union finance secretary, and wrote extensively on issues in fiscal federalism in his new book titled 'Just A Mercenary?: Notes from My Life and Career' further said that horizontal sharing of the divisible pool of taxes has always been a contentious issue but will be even more so in this round.

"This (north-south divide in deciding on the distribution of the tax pool among states) is a complex political challenge beyond the remit of the Finance Commission.

"Resolving it will demand enlightened leadership at central and state levels that can look beyond politics and build a consensus around an optimal way forward," he told PTI.

He pointed out that for every rupee they contribute to the centre's taxes, richer states like Tamil Nadu and Maharashtra get back less than a rupee while poorer states like Bihar and Jharkhand receive more than a rupee.

"Such cross subsidization of poorer states by richer ones is inevitable in a large and diverse country like ours and has, in fact, been an accepted principle," Subbarao said.

The 16th Finance Commission (16th FC) has been set up and the debate of economically and socially better-off southern and western states 'subsidising' the northern and eastern states has



"As you say, there is already an emerging north-south divide on the economy front. The question is, are we hitting the limits of such cross subsidization?," he asked.

According to Subbarao, many headline numbers suggest that the southern states are doing better in terms of infrastructure, private investment, social indicators and rule of law which has put them on a virtuous cycle of growth and prosperity and widened the north-south

"Given their urge to move up faster, how much more of cross subsidization will the southern states countenance? And for how much longer?," he wondered.

While noting that the looming delimitation that is due in 2026 based on updated population data, Subbarao said over the last few decades, population growth rates in the southern states have declined more sharply than in the

"If as a consequence, the southern states lose their relative share of parliament seats, they will face the double whammy of reduced political clout combined with an open-ended commitment to cross

subsidization," he said.

Subbarao was finance secretary (2007-08) before taking over as the governor of the RBI for five years on September 5, 2008, a few days before the breakout of the Lehman Brothers crisis. Lehman Brothers crashed into bankruptcy on September 16, making it the biggest corporate failure in history.

Asked to comment on criticism that he did not buy up dollars when there were huge inflows during 2010-11, and instead allowed the rupee to appreciate, Subbarao said that was a deliberate decision informed by several considerations.

"Holding reserves is not costless, especially as our reserves are built from borrowed resources.' Subbarao said, adding, RBI intervention in the market shifts the burden of adjustment from one segment of the economy to an-

He further explained that the stated policy of the Reserve Bank is to intervene in the market only to prevent volatility in the exchange rate.

"Juxtapose my alleged inaction against that policy. "As I saw it, there was no volatility in the exchange rate dur-

ing 2010-11 to justify intervention. I felt obliged to walk the talk," he

Subbarao noted that if the Reserve Bank were to step in every time the exchange rate moved, they would happily outsource their external management to the Re-

serve Bank. "That would be a costly moral

hazard," he said. Subbarao was at the helm of RBI during the taper tantrums in 2012-13 when the rupee crashed by 20 per cent peak to trough.

Referring to Prime Minister Narendra Modi's speech at the 90th anniversary celebrations of the RBI, Subbarao said, to make the rupee more internationally acceptable, the central bank should become less interventionist, besides fulfilling other conditions.

Responding to a question on freebies, Subbarao said in a poor country where millions struggle to make a decent livelihood, transfer payments to the most vulnerable segments are necessary, indeed even mandatory.

"But that has to be within limits especially as these freebies are financed by borrowing," he pointed

On the other hand, Subbarao said, competitive populism like what is unfolding -- political parties outdoing each other in wooing voters with freebies -- is fiscally

"I believe all political parties are guilty of this and trying to apportion blame will be a wrong start," he said.

Former RBI governor emphasised that there is a strong case for the central government that comes into office post elections to issue a white paper explaining to the larger public in plain language the costs and benefits of freebies. (PTI)

Rift between RSS and Modi

n a surprising turn of events, the longstanding alliance between Prime Minister Narendra Modi and the Rashtriya Swayamse-■ vak Sangh (RSS) has reached a critical juncture, potentially jeopardizing the BJP's electoral fortunes in the upcoming 2024 polls. The rift, fueled by grievances over Modi's leadership style and policy decisions, has led senior RSS leaders to distance themselves from endorsing Modi as the prime ministerial candidate for a third term, even if the BJP secures a majority. Recent revelations from a high-level meeting of RSS leaders shed light on growing discontent within the organization, citing concerns over Modi's autocratic tendencies and disregard for the interests of RSS cadres and volunteers. The refusal of RSS cadres to actively participate in the electoral process underscores the severity of the rift and the challenges ahead for the ruling party. Failure to reconcile with the RSS and respond to the concerns of marginalized communities could prove costly for the party in 2024.

The party's inability to articulate a coherent vision for inclusive growth and social justice further compounds its credibility crisis. Modi-Shah want to get back lost support base via communal rhetoric

rith voters remaining lukewarm to Narendra Modi's "Abki Par 400 Paar" campaign slogan, the prime minister's chief lieutenant, Union home minister Amit Shah has started reaching out tothe smaller parties, apart from the official NDA allies, to help Modi form the government for a third consecutive time. Shah has conveyed it to his state. leaders and chief ministers of the BJP ruled states to ensure that the voters come out in large numbers to prop up the voting percentage of the ruling party at the cen-

The decline of the polling percentage during the two earlier phases, especially in the second phase which witnessed a staggering 8 per cent decline in votes polled in comparison to 2019 across the country, has unnerved Modi and Shah. With around 1 crore voters, out of total 16 crores, staying away from voting, the BJP leadership is haunted by the fear that the third phase of polling would be a virtual repetition of the earlier two phases.

The third phase of the elections will be held on May 7 in 94 Lok Sabha constituencies in 12 states. In this phase, states which are crucial for BJP are Bihar (5 seats), Chhattisgarh (7 seats), Gujarat (26 seats), Karnataka (14 seats), Madhya Pradesh (8 seats), Maharashtra (11 seats), Uttar Pradesh (10 seats) and West Bengal (4 seats). SC, ST and OBC voters are dominant in these constituencies.

Incidentally, all the seats in Bihar and Uttar Pradesh going to polls in the third phase have high density of backward and EB castes. The caste structure could be understood from the popular saying: "Rome Pope ka, Madhepura Gope ka [What Rome is for Pope, Madhepura is for Yadavs]". Besides Madhepura, the other four poll-bracing constituencies are Jhanjharpur, Supaul, Araria, and Khagaria. These areas have been traditionally

In the ten constituencies in Uttar Pradesh that go to poll in the third phase, OBCs, including Yadavs, Lodhs, and Kachhi/ Shakya/ Murao communities, are the dominant castes and exert high level of influence as decisive polling factors. Besides, the Muslims are the most potent force demographically.

The 10 Lok Sabha constituencies scheduled for polls in this phase include Sambhal, Hathras, Agra, Fatehpur Sikri, Firozabad, Mainpuri, Etah, Budaun, Aonla, and Bareilly. Notably, the first two phases comprised eight seats each.

tial two phases. In these areas, the Yadav-Muslim equation is quite strong. Incidentally, the Dalits and EBCs have suffered extreme form of upper caste repression. In earlier elections, the BJP managed to win quite convincingly. But the scenario has changed this time. BJP had won seven out of the 10 seats in 2014 and eight in 2019. Jharkhand constituencies will have election in the fourth phase.

US worried at the possibility of harming former PM Imran Khan in prison

Lical situation in Pakistan have raised questions about the safety of the former Prime Minister Imran Khan presently lodged in prison..According to several sources familiar with the matter who spoke to The Intercept, the Senate Majority Leader emphasized to Pakistan's ambassador in Washington that ensuring the safety of jailed former Prime Minister Imran Khan is a top concern for the United States.

Late last month, Senate Majority Leader Schumer, a leading Democrat in Congress, issued a warning to Pakistan. This followed vigorous campaigning by the Pakistani diaspora, who are worried that the Pakistani military might harm Khan, the former prime minister removed from of-

Mohammad Munir Khan, a Pakistani American political activist, told The Intercept, "Chuck Schumer's discussion with the ambassador about Imran Khan's safety is a positive step." He added that the Pakistani American diaspora has been disappointed with Washington's inability to address and hold Pakistan's influential figures accountable for obvious human rights abuses and undermining core democratic principles.

Imran Khan, who is widely regarded as Pakistan's most popular politician, is currently in jail on corruption charges that many view as politically motivated. He was ousted from power in April 2022 through a no-confidence vote believed to be engineered by Pakistan's influential military and supported by the U.S. Since then, his party, Pakistan Tehreek-e-Insaf (PTI), has been subjected to severe crackdowns, sparking global concern and condemnation from human rights organiza-

The worries about Imran Khan's safety that led to Senator Schumer's conversation with Pakistani Ambassador Masood Khan stem from increasing fears that the military might respond to Khan's enduring popularity by endangering his life while he is in prison. According to The Intercept, Schumer's office chose not

Senator Schumer, who has many Pakistani American constituents (or Voters) in New York, reached out as a new government in the South Asian country tries to secure its position despite public unhappiness with a February election that many say was fraud-

Besides banning the PTI party, Pakistan heavily cracked down before the February election. Despite a high voter turnout that hinted at an advantage for PTIaligned candidates, allegations of widespread fraud were overlooked. Supported by the Pakistani military, a coalition of parties managed to establish a government under Shehbaz Sharif following the election.

The international community, with the U.S. included, observed irregularities in the voting process, and there were believable claims of vote rigging and blatant fraud during the election.

Rep. Greg Casar, a Democrat from Texas, told The Intercept in March that there was clear evidence, acknowledged by the State Department, of issues with the election. At that time, Casar and other lawmakers had urged President Joe Biden not to recognize the government. However, the U.S. ambassador to Pakistan had already congratulated Sharif in early March.

Foreign policy experts in Washington have expressed concerns that the Biden administration's strategy might compromise democratic values for the sake of security. Matt Duss, executive vice president of the Center for International Policy, stated, "It seems like the administration is prioritizing its security ties with a foreign government over important issues such as democratic backsliding and human rights."

Imran Khan is reportedly facing harsh conditions in a Rawalpindi prison. Last month, his right to receive visitors was suddenly halted for two weeks, leading his supporters to worry about his well-being while in detention. Earlier this month, one of Khan's lawyers reported that his personal doctor was denied access to see him in jail. Addition-

> Schumer's conversation with the Pakistani ambassador might influence the military's decisionmaking regarding dealing with Khan. "Having a senior Democrat who has sway in the Biden administration issue a warning is quite meaningful," noted Adam Weinstein, the deputy director of the Middle East program at the Quincy Institute. He added that he doesn't think the military would go as far as to kill Khan in prison.

> It would be a drastic measure, but the military harming or even killing an ousted leader, including someone as prominent as Khan, aligns with a pattern seen in Pakistan's history. Over the past few decades, numerous Pakistani leaders have met violent ends after clashing with the military. Some of these deaths have occurred under unclear circumstances, while others, like former Prime Minister Zulfikar Ali Bhutto, were executed by military rulers after being removed from power.

> Today, despite being officially governed by civilians, Pakistan's military is widely recognized as the dominant political force in the country. Currently under the leadership of Munir, the military's ongoing conflicts with Khan and his party have been a central political narrative in the country for more than a year.

> Pakistani activists in the U.S. believe that America's ties with Pakistan provide a means to prevent Imran Khan from being harmed in prison. Mohammad

The U.S. has had a significant influence on Pakistan's internal politics, particularly in recent years, and played a key role in Khan's removal from power.

In August 2023, The Intercept released a classified Pakistani diplomatic cable that had been at the heart of political controversy. Previously, the details of the cable were not public. The document revealed that U.S. State Department officials had exerted significant pressure on the Pakistani government, leading to Khan's removal from power.

The cable revealed that Assistant Secretary of State Donald Lu, who oversees South Asian affairs at the State Department, warned the Pakistani ambassador in Washington that US-Pakistan relations would suffer greatly if Khan staved in power.

According to the Pakistani cable, Lu mentioned, "If the noconfidence vote against the Prime Minister is successful, Washington will forgive everything.

Following Khan's ouster, the US has closely collaborated with Pakistan's new military-supported government. Reports from The Intercept indicate that Pakistan supplied weapons to Ukraine as part of a deal where the US facilitated a favourable loan package from the International Monetary Fund. Before his imprisonment,

As the only one testifying, Lu refuted claims of his involvement in a "regime change" in Pakistan. This was in response to accusations made by Khan and reported by The Intercept regarding his role and the contents of the diplomatic cable. Regarding the election, Lu acknowledged concerns about the conduct of the voting but did not specify any potential consequences for the alleged vote rigging.


"Our ambassador and embassy have taken actions," Lu remarked, hinting at the U.S.'s congratulatory message to Pakistan's new prime minister. He quickly followed up by stating, "In every interaction with this government, we emphasize the need for accountability regarding election irregularities." At the hearing, Rep. Brad Sherman, a Democrat from California, expressed concern about Khan's safety while in detention. Sherman suggested that Lu should personally visit Khan in prison, a proposal that received applause from the predominantly Pakistani audience present.

"Protecting leaders, no matter their political views, is crucial," stated Atif Khan, a Pakistani American diaspora activist. He praised Congressman Brad Sherman for promoting accountability and safety, urging the U.S. Ambassador to meet with former Prime Minister Imran Khan and ensure his welfare.

As Khan's situation remains uncertain, members of Congress have cautioned that ongoing U.S. backing for a government viewed as illegitimate by many Pakistanis could damage not only Pakistan but also the U.S. standing in

ue to adverse human behaviour, earth's temperature is on rise and the resulting climate change has now become a threat to every aspect of human life, as well as to water bodies and rivers. The dangerous impacts of climate change are being felt at alarming levels on total water storage in major reservoirs and river basins, including the Ganga, Indus and Brahmaputra, which could lead to serious water consequences for people. The latest figures of the Central Water Commission show the seriousness of this increasing water crisis in India. The latest figures show an alarming decline in the levels of reservoirs across the country.

According to the report dated April 25, 2024, the water available in major reservoirs in the country has declined by thirty to thirty-five percent in proportion to their earlier storage capacity, which is a big decline compared to recent years. This point towards a drought-like situation; the root of which is said to be the effect of the El Nino phenomenon and lack of rainfall. Life cannot be imagined without water.

Apart from human-beings and animals, water is also essential for all forms of agriculture, vegetation and most industrial production processes. But today India is standing under the shadow of a serious water crisis. Unplanned industrialization, increasing pollution, shrinking deserts and glaciers, falling water level of rivers, lack of rainfall, environmental destruction, insensitivity towards rampant exploitation and misuse of natural resources are leading India to an impending major water crisis.

Water levels in 150 major reservoirs across India are currently at 31 per cent, with South India being the most affected region, with 42 reservoirs currently at only 17 per cent of the total capacity. This marks the lowest water potential observed in various regions of India. The situation is worrying in other areas too, with reservoir capacity at 34 per cent in the west and 32.5 per cent in the north.

However, the situation in eastern and central India is better; they have 40.6 percent and 40

per cent of the active capacity of their reservoirs respectively. Rainfall last year was deficient, especially in South India. The 2023 monsoon was uneventful as it was an El Nino year, which was also – a climate pattern that typically causes hot and dry conditions in the region. This has created a lot of anxiety.

Currently, irrigation is also being affected, and there are growing concerns about the impact on drinking water availability and hydropower generation across the country. Looking ahead, more heat is expected in the coming months, indicating that a major water crisis is going to emerge in the coming

This reduction in water storage has occurred due to lack of adequate rainfall for a long period. Due to which, drought-like and unsafe conditions have arisen in many areas. Due to which various crops are being adversely affected. One reason for this is that even today half of the cultivable land in the country is dependent on monsoon rains. In such a situation. the future of agriculture completely depends on the vagaries of monsoon.

In fact, due to continuously increasing heat the water level is shrinking rapidly. Due to its serious consequences, water shortage has become serious in states like Andhra Pradesh, Karnataka and Tamil Nadu. The country's IT

hub Bengaluru is facing a severe water crisis, which is not only affecting agricultural activities, but everyday life is also being badly af-

In such a situation, to deal with any impending crisis, there is a need to intensify water conserefforts from homes to all agricultural practices and industrial

works. There is also an urgent need for major investment in water infrastructure and management systems to improve water storage and distribution efficiency. Along with this, there is a need to promote traditional techniques of water conservation. Also, there is a need to run public awareness campaigns to motivate the common people to promote judicious use of this valuable resource of nature.

By conserving water and ensuring adequate availability, we can improve the environment

and also solve the problem of climate change. You may wonder how much water a human being uses in his lifetime, but does he try to save that much water? Climate change has led to 134 percent increase in flood events since 2000, and percent increase in drought duration.

Water is a basic requirement for the existence of life on earth. Water consumption has increased exponentially with the increase in population, but the amount of clean water on Earth is decreasing. Climate change and rising earth's temperature have made this problem a serious crisis. Like in many parts of the world, India is also threatened by an impending water crisis.

About 18 percent of the global population lives in India, but only four percent of the water resources are available to us. The efforts that have been made since ancient times to deal with the problem of water crisis in India are expected to be adopted on a large scale and to bring about a water conservation revolution.

Rivers, which have been the source of pure water for centuries, are getting polluted, now climate change is having a detrimental effect on them. Microplastics are global travellers of pollution In times of climate change, 'agritech' steps in to

n an era marked by technological advancements and rapid industrialisation, humanity's dependence on plastic has surged, leading to an insidious consequence: The proliferation of microplastics. These tiny particles, measuring less than 5 millimetres, have stealthily infiltrated every corner of our planet, from the depths of the ocean to the heights of the atmosphere.

Microplastics originate from a range of sources, including the breakdown of larger plastic debris and the shedding of synthetic fibres from clothing and textiles. Additionally, microbeads used in personal care products and industrial abrasives contribute to the abundance of these particles in the environ-

Despite their minute size, microplastics pack a significant punch, posing substantial risks to marine life, soil health, and potentially human well-being. Understanding the journey of these microscopic pollutants through our environment is crucial not only for comprehending the for devising effective strategies to combat their prolifer-

The global journey of microplastics Microplastics embark on a global journey, propelled by atmospheric and aquatic currents that crisscross the planet. Rainfall, surface run-off, and ocean circulation serve as conduits, carrying microplastics from terrestrial environments to aquatic habitats and vice

But their journey doesn't end there; wind, acting as nature's courier, transports lighter microplastics to the furthest reaches of the globe,

depositing them in remote areas such as glacier zones and high mountains. However, microplastics aren't confined to the air and water alone. The pedosphere, or soil, also plays a crucial role in their transport. Agricultural practices, including

the use of plastic mulches and sewage sludge as fertilizers, introduce microplastics into the soil, where they interact with a myriad of organisms undergo intricate processes of dispersion.

Impact on hydrosphere, pedosphere and atmosphere

The hydrosphere emerges as the primary sink for microplastics, with human activities such as tourism and wastewater discharge contributing to their accumulation. These tiny pollutants, carried by ocean currents and rainfall, find their way into aquatic ecosystems, where they can either settle in sediments or remain suspended in the water column.

Horizontal distribution,

governed by water circulation and wind currents, dictates the movement of microplastics within aquatic environments. Meanwhile, vertical distribution involves processes such as turbulent mixing and biological interactions, leading to the accumulation of microplastics in sediments and deep-sea habitats. Studies have shown that approximately 7 million microplastic items are released into aquatic habitats daily via wastewater treatment plant

effluents. Furthermore, 70 per cent of microplastics present in the hydrosphere are stored in aquatic sediments, highlighting the significant role of sediments as a sink for these pollutants

While much attention has been focused on microplastics in water bodies, the pedosphere remains an often-overlooked sink for these pollutants. Domestic and agricultural activities contribute to the contamination of soil with microplastics, with plastic litter breaking down to release these tiny particles into the environ-

Plastic mulches, fertilisers, and sewage sludge introduce microplastics into the soil, where they interact with soil organisms and undergo complex processes of dispersion and accumulation. Bioturbation, driven by soil-dwelling organisms like earthworms and arthropods, plays a significant role in the vertical mixing of microplastics within soil profiles, ultimately influencing their fate and persistterrestrial ence in

environments. Data from European farms indicate an annual deposition of approximately 50,000 tonnes of microplastics into the soil. Additionally, over two decades, the concentration of plastic mulch in China's agricultural fields has increased fourfold, resulting in a corresponding increase in microplastic contamination in the soil.

As microplastics traverse the environment, the atmosphere emerges as a crucial conduit, carrying these pollutants across vast distances before depositing them back onto the Earth's surface. Wind currents and precipitation govern the distribution and deposition of atmospheric microplastics, with remote areas such as the Arctic receiving

inputs from distant sources.

Atmospheric deposition of microplastics poses emerging concerns for human health, with recent studies highlighting the presence of these pollutants in surgical masks and their potential for inhalation. Furthermore, atmospheric deposition of microplastics contributes to the contamination of terrestrial and aquatic environments, completing the cycle of microplastic pollution. In urban cities like Paris and Hamburg, daily atmospheric deposition rates of microplastics can reach up to 120 microplastics per square metre (MP/m²) and 275 MP/m², respectively.

Furthermore, coastal areas with stronger wind currents, such as Yantai in China, experience even higher atmospheric deposition rates, with values reaching up to 602 MP/m² per day.

The fate and transport of microplastics in the environment represent a complex interplay of natural processes and human activities. Addressing this pervasive threat requires a multifaceted approach, encompassing interdisciplinary research. legislative measures, and public awareness campaigns.

By understanding the pathways through which microplastics traverse the environment, we can develop effective strategies to mitigate their impact and safeguard the health of our planet for future generations. (Courtesy: Down To Earth)

reduce food loss, increase Indian farm incomes

magine you are a tomato farmer who faced drought, which has resulted in a low yield and poor quality of crop. The tomatoes need to be individually harvested and the labour cost to harvest them is high. The combined cost of storage and transportation is more than the value of the produce in the market. What would you do?

At this stage, some farmers decide to throw away the produce and accept their loss, instead of transporting it and losing more money. This food loss, not only has economic implications for the farmer, but also affects the environment as the land, water and energy (agricultural inputs) used to produce the food that is discarded, are also wasted. Second, it also leads to emissions. The UN Food and Agriculture Organization states that food loss and waste contribute up to 10% of global greenhouse gas emissions.

There are also other forms of post-harvest losses that occur during storage and transportation. Extreme weather events such as heatwaves, cyclones or flooding, intensified by climate change, also contribute to post-harvest losses. Sometimes, the supply exceeds the demand and in perishable goods that can't be stored for long, it again leads to a loss.

The 2019 State of Food and Agriculture report by the Food and Agriculture Organization notes that about 14% of the world's food, which is worth around \$400 billion every year, gets lost between harvest and the stores. Post-harvest agricultural technologies. (agritech) aim to solve these issues by reducing food loss and also increasing farmers' incomes.

Increasing shelf-life

"Farmers need post-harvest technologies for both preservation and also processing, to make the produce market-ready and add value to earn an additional income," shares Nidhi Pant, co-founder of S4S Technologies, an agritech startup. The startup provides solar-powered dehydrators to women farmers, to help them increase the shelf-life of agricultural produce.

"In India we have been sun drying food for preservation, traditionally. However, direct sun drying results in the heat spreading unevenly and it takes about six to seven days to thoroughly dry the produce. In this process, it is susceptible to fungus growth and other environmental challenges. However, solar dehydrators can do this in six to eight hours. The colour, texture, aroma can be matched with the industry requirements and it is more hygienic and the nutrition is retained," explains Pant.

With its major operations in Maharashtra, S4S Technologies has reached 2,000 women farmers who use dehydrators to remove the moisture content and reduce post-harvest losses. The women also receive cutting and processing tools to help them package and sell the produce to large food agencies, restaurants and cloud kitchens and even export them to Southeast Asia. "We've been able to save 60,000 tonnes of pro-

duce annually," Pant shares. Dehydration is not the only way to increase the shelf-life of agricultural produce. There are also coldstorage chambers which help store perishables and grains. India has 8,653 cold storages as of February 2024, which aim to minimise post-harvest losses. However, there's more to reducing losses than increasing the number of cold storage warehouses, says Karthik Jayaraman, Founder, WayCool, an agritech startup in the supply chain space.

WayCool avoids repetitive handling of the produce and minimises the storage wherever possible, by procuring from the smallholder farmers. The startup leverages artificial intelligence and machine learning to precisely calculate the demand.

'We have a network of collection and distribution centres. Using our demand-forecasting tools, we communicate to our collection centres, the exact quantity of vegetables needed. These collection centres then start procuring from the farmers. The target price is also algorithmically determined. The farmers are therefore able to plan better and it prevents the produce from rotting in the field," explains Jayaraman.

While cold storage technologies help reduce the losses, we need to look at minimising the "food miles" (the distance between the place where food is grown or made and the place where it is eaten), opines

"At WayCool, we have reduced losses by about 6% with ventilated and well-managed cold storages alone. But cold storage technologies have been primarily developed for the West, where it is predominantly temperate. The grocery outlets are also air conditioned. However, India is a tropical country and we need to cool the product from 42 degrees Celsius to say 2-6 degrees Celsius. You need maximum cold temperatures during peak summer. So, apart from cold storage chambers we also need to aim for shorter supply chains," he explains.

When in transit, WayCool also takes precautions about the aeration in the vehicles. "We're constantly experimenting here because too much aeration will lead to moisture loss. The vehicles should have the right kind of ventilation. We also have a standard operating procedure to stack different vegetables. For example, tomatoes must not get crushed because when it gets transported to a high humidity area, it could lead to a fungal attack if not stacked properly, Jayaraman adds.

Streamlining supply chain

There's also a crucial challenge to tackle within the supply chain – lack of transparency about the quality of produce and the price. To fix this, agritech startup started conducting quality checks of the produce at the farm level. When the produce is graded immediately after harvest, it helps fix the price according to the quality. The farmers can then confirm if they are getting a fair price, with an app developed by DeHaat which shows the market price for each crop.

"When we're able to assess the quality of the produce at each farm and make sure the produce is of a good grade and is pesticide-free, the price is fixed based on the output and we are able to maintain transparency in the supply chain. This benefits both the retailer and the farmer," shares Amrendra Singh, co-founder of DeHaat. For the farmers there's also an assured purchase which minimises agricultural losses,

DeHaat aims to build the ecosystem and solutions around the farmer. "In India we majorly have smallholder farmers who need support at the post-harvest stage. And all innovations need to have the last-mile connectivity for the farmers, and local partnerships at the panchayat or village-level definitely help," Singh

According to Hemendra Mathur, Co-Founder, ThinkAg, a non-profit working to accelerate the adoption of innovation in agriculture, large food processing companies and restaurants wanting to go net-zero could be good for the supply chain.

He elaborates, "Food companies and farmers don't interact enough, although they are part of the same supply chain. To be more climate-resilient or reduce carbon emissions in food products, it is important to establish traceability. The companies who have set net-zero goals will want to know how the farmer has produced the crop and the carbon footprint, to claim they are sustainable. Their inclination to directly work with farmers will improve." Mathur is also optimistic that in the coming years, the customers will start demanding products that are sustainably produced.

Post-harvest technology

India's food security challenges also impact the world. It is the ninth-largest exporter of agricultural products in the world but is yet to become a reliable supplier as it announces sudden overseas bans for agricultural shipments, due to shortages.

'There is huge potential for investments in the postharvest sector," shares Mathur. He opines that state governments can immensely support agritech startups. "More than the financial support or subsidies, the agritech startups are looking to work with Krishi Vigyan Kendras, state agricultural universities and state governments to receive access to data and test pilots. More public-private collaborations will be benefi-

The Central Institute of Post-Harvest Engineering and Technology by the Indian Council of Agricultural Research has developed technologies such as mobile cool chambers for short duration storage and transportation of fish for retail marketing, fruit graders to grade all spherical commodities and reduce handling the produce, an evaporatively cooled structure to store fruits and vegetables at a moderate low temperature, and more. Last year the government also tried gamma ray irradiation on onions, to impair the ability of onions to sprout, thereby increasing their shelf life.

Many of these technologies, however, have not reached all the farmers equally. They need to be scaled up to become accessible and financially viable to all farmers

"Some farmers have multiple smart apps and many have started using drones for pesticide spraying. But it has to move from early adopters to mainstreaming agritech solutions; this chasm has to be crossed, shares Jayaraman, who returns to reducing food miles. "What if you could grow the right variety of crop locally? We need to support the farmers with proper varieties, to avoid post-harvest losses," he adds.

"We need to rely on biotechnology," concurs Singh. "Every year we hear from the farmers that the weather is much worse and much less predictable than the previous year. There's no choice but for everyone to adapt to the changing climate. We need climate-resilient crop varieties and precision-farming tools to do this and we need to improve the soil quality," he adds. 'Asia is world's most Disaster-hit region': Breaking down new climate report

Asia is warming faster than the global average. The warming trend has nearly doubled since the 1961–1990 period." This is what the World Meteorological Organization's (WMO) State of the Climate in Asia 2023 report, published on Tuesday, 23 April, says

The report also states that Asia was the "world's most disaster-hit region" due to climate events in 2023. As many as 79 hydrometeorological hazard events were reported in Asia the same year.

Over 2,000 people died due to these climate disasters, and close to nine million people were affected. The Quint breaks down the key findings of the report for you.

Key findings of the report

The WMO, in the 2023 report, found: · Heatwaves became more severe in

Speaking to The Quint about the report, Dr Vishwas Chitale, Senior Programme Lead, Council on Energy, Environment & Water (CEEW), said, "The report underscores a worrying trend we're seeing across Asia. These extreme climate events like floods, cyclones and heatwaves, if not met with proper preparedness and policies, have the potential to cause loss of life and economic hardship. This vulnerability highlights the urgent need for a multi-pronged approach to rapidly accelerating climate change." Zooming in on India

Highlighting the reality of climate change in India, the report stated that: · Severe heat waves from April-June

led to at least 110 deaths in the country. • Even as rains in the summer-monsoon were below average in India, floods and storms from July-August "resulted in more than 600 reported deaths across

India, Pakistan, and Nepal. · As many as six tropical cyclones occurred in the Indian subcontinent, causing widespread destruction across regions.

• The sea level rise in Bay of Bengal in 2023 was the second-highest in the region, "30 percent above the global aver-

• The rise in temperatures most affected the northern and eastern regions of India.

The WMO further added, "In India, Yemen, and Pakistan, floods were the natural hazard event which caused the greatest number of fatalities.

The Quint had reported in June 2023 that close to 68 people in Uttar Pradesh's Ballia and 53 people in Deoria succumbed to heat-related deaths. In October the same year, the South Lhonak Glacial Lake in Sikkim had burst, which led to the Teesta river flooding and wreaking havoc across four districts in the state – killing more than 40, and causing significant economic loss.

Dr Chitale said, "Research shows the need for strengthening critical infrastructure - healthcare, transportation, and power grids - through climate-proofing measures. Upgrading standards and building codes with the changing climate in mind is essential. Additionally, we cannot ignore the rising heat stress in our cities.

What next?

After the report was released, WMO Secretary-General Celeste Saulo said, "Many countries in the region experienced their hottest year on record in 2023, along with a barrage of extreme conditions, from droughts and heatwaves to floods and storms. Climate change exacerbated the frequency and severity of such events.

Armida Salsiah Alisjahbana, Executive Secretary of the Economic and Social Commission for Asia and the Pacific (ESCAP), an organisation that was also involved in bringing out the report, emphasised on how "vulnerable countries were disproportionately impacted," like Bangladesh and Myanmar that were hit by cyclone Mocha.

The researchers suggest, "There is an urgent need to advance efforts and provide more tailored support and services to address strategies and interventions to effectively mitigate rising disaster risks." (Courtesy: The Quint)

Blinken urges Israel and Hamas to move ahead with a cease-fire deal and says 'the time is now'

TEL AVIV, May 1: U.S. Secretary of State Antony Blinken was meeting with Israeli leaders on Wednesday in his push for a cease-fire deal between Israel and Hamas, saying "the time is now" for an agreement that would free hostages and bring a pause in the nearly seven months of war in Gaza.

He said Hamas would bear the blame for any failure to get a deal off the ground.

Blinken is on his seventh visit to the region since the war erupted in October in his bid to secure what's been an elusive deal between Israel and Hamas that could avert an Israeli incursion into the southern Gaza city of Rafah, where hundreds of thousands of Palestinians are sheltering.

The current round of talks appears to be serious, but the sides remain far apart on one key issue - whether the war should end as part of an emerging

"We are determined to get a ceasefire that brings the hostages home and to get it now, and the only reason that that wouldn't be achieved is because of Hamas," Blinken told Israel's ceremonial President Isaac Herzog at a meeting in Tel Aviv.

'There is a proposal on the table, and as we've said, no delays, no excuses. The time is now," he said.

Pak to block mobile sim cards of over half a million people over non-compliance

ISLAMABAD, May 1: Authorities in Pakistan have decided to block the mobile phone SIM cards of over half a million tax defaulters as part of the drive to take action against tax

The Federal Board of Revenue (FBR) in an Income Tax General Order (ITGO) said the mobile SIMs of 506,671 individuals, who failed to file their tax returns for 2023, will stay blocked until restored by the FBR or the Commissioner Inland Revenue having authority over the

It ordered the Pakistan Telecommunication Authority (PTA) and all telecom providers to immediately implement the Income Tax General Order (ITGO) no 01 of 2024 to block their SIMs and file a compliance report by May 15, Dawn News reported. An official source said the FBR has identified 2.4 million potential taxpayers who did not exist on the tax rolls. Notices were subsequently issued to these individuals

The FBR has selected over 0.5 million individuals out of the 2.4 million for SIM blockade based on one criterion: they must have declared taxable income in one of the past three years and these individuals did not file their returns for tax year 2023.

According to the Active Taxpayers List (ATL), the FBR received 4.2 million taxpayers until March 1, 2024, as against 3.8 million returns received during the same period of last year. This shows a marginal increase during the period under review. In tax year 2022, FBR received a total of 5.9 million income tax re-

According to the FBR official, SIMs will be automatically restored for persons who file tax returns for 2023. Every Monday, FBR updates its ATL listings.

Every Tuesday, the names of persons who appear on the ATL list will be identified and submitted to the PTA and telecom companies for restoration. The officer emphasised that there would be no separate restoration procedures, and the entire process would be completed auto-

Police clear pro-Palestinian protesters from Columbia University's Hamilton Hall

Palestinian demonstration that paralyzed Columbia University ended in dramatic fashion late on Tuesday, with police carrying riot shields swarming the Ivy League campus, bursting into an administration building protesters took over the previous night and making dozens of arrests.

Meanwhile, clashes broke out overnight between dueling groups at the encampment at the University of California, Los Angeles. Some were armed with large sticks and beat others with them. Security was tightened Tuesday at the campus after officials said there were "physical altercations" between factions of protesters.

A statement released by a Columbia spokesperson said New York City officers entered the campus after the university requested help. A tent encampment on the school's grounds to protest the Israel-Hamas war was cleared, along with Hamilton Hall where a stream of officers used a ladder to climb through a second-floor window. Protesters seized the hall about 20 hours earlier.

Highway collapse in China's southern Guangdong province leaves at least 19 dead

BEIJING, May 1: A section of a highway collapsed early on Wednesday in southern China leaving at least 19 people dead, local officials said, after the area had experienced heavy rain in recent days.

Eighteen cars fell down a slope after a 17.9-metre- (58.7-foot) long section of the highway collapsed, according to a statement from authorities in Meizhou city in Guangdong province. The incident occurred around 2 a.m.

Witnesses told local media they heard a loud noise and saw a hole open up several meters wide behind them after driving past the section of the road just before it collapsed.

Video and photos in local media showed smoke and fire at the scene, with highway rails slanting downward into the flames.

Blackened cars could also be seen on the slope leading down from the highway.

SAN FRANCISCO, May 1: The US Justice Department's double-barrelled antitrust attack on Google's dominant search and Apple's trendsetting iPhone is reviving memories of the epic battle that hobbled Microsoft before it roared back to yet again become the world's most valuable company.

The parallels to the Justice Department's landmark antitrust case in 1998 could provide a window into the potential breakthroughs that could be unleashed if regulators succeed in their attempts to crack down on Google and Apple.

Federal lawyers have even gone as far as to assert Google and Apple may never have created so many popular products or become as powerful as they are now if Microsoft hadn't been reined in a quarter century ago.

In closing arguments of a Washington, DC, trial that began last September, regulators Thursday will apply the finishing touches to a case alleging Google has turned its search engine into an illegal monopoly that stifles competition and innovation. The Apple case, which was only filed a month ago, is still years away



from its resolution. Although regulators have lodged separate complaints against Google and Apple, the two cases are shadowed by Microsoft's legal saga that began when both those were mere specks on the technology landscape.

When they went after Google in October 2020, regulators compared the lucrative deals that the company cut with Apple to lock its search engine into the iPhone and Safari web browser to the same tactics Microsoft deployed in its personal computer software to block competition.

And in the antitrust lawsuits that they filed against Apple last month, the Justice Department pointed back to complaints that company co-founder Steve Jobs had raised in 1998 against Microsoft's "dirty tactics" while urging regulators to take steps to force the PC software maker "to play fair"

And that is what the Justice Department did in an antitrust case against Microsoft that caused massive distractions that opened the door for Google's search engine to become the internet's main gateway. It also culminated in a series of con-

cessions that paved the way for Apple to extend the reach of its iTunes music store that increased the popularity of the iPod that spawned the iPhone. The Microsoft case "created new opportunities for innovation in areas that would become critical to the success of Apple's consumer devices and the com-

pany itself", the Justice Department

crowed in the lawsuit that casts the

iPhone as an illegal monopoly. After years of mostly fruitless attempts to compete against Google's search engine and the iPhone under the leadership of Steve Ballmer, Microsoft began to regain its stride when Satya Nadella be-

Earlier this year, Microsoft's market value hit USD 3 trillion for the first time, surpassing Apple as the world's most valuable company while taking the early lead in artificial intelligence technology

that's expected to reshape the world. It's an odd juxtaposition that has thrust regulators into battling two companies they helped create when they caged a colossus now angling to seize the mantle in technology's next frontier.

But it's also a tableau that antitrust experts cite as evidence that the system is working to unlock more robust competition that hatches innovations. And then those breakthroughs sometimes serve as the building blocks for new monopolies that must eventually be challenged by regulators, even as fallen empires like Microsoft can still find ways to reinvent themselves.

"It's not about an agenda about trying to pursue and destroy companies, it's about trying to restore competition in a market," said Rebecca Haw Allensworth, a Vanderbilt University law professor who focuses on antitrust law issues. (AP)

Australian PM Albanese vows new funding to help women escape domestic violence after homicides rise

MELBOURNE, May 1: Australian Prime Minister Anthony Albanese announced new funding on Wednesday to help women escape domestic violence and a crackdown on misogynistic online content in reaction to an uptick in homicides committed by current and former male partners that he described as a national crisis.

Albanese said his government would invest 925 million Australian dollars (USD 599 million) over five years to financially support women and children escaping vio-

ures to tackle factors that it says exacerbate violence against women, such as violent online pornography and misogynist content targeting children and young people. The measures would include legislation to

The government also proposed new meas-

ban deepfake pornography and more funding for an Australian regulator to pilot age-assurance technologies to protect children from harmful online content. "This is, indeed, a national crisis and it's a

national challenge and we're facing this with a spirit of national unity," Albanese told reporters after a meeting with state and local

Tens of thousands protested in cities around Australia over the weekend to draw attention to the deaths of 27 women so far this year, allegedly caused by acts of genderbased violence. The death toll had reached at least 28 women by Wednesday.

The government leaders will meet again in three months to discuss progress. "I'm satisfied it's a further step forward,"

Albanese told reporters. "Can we be satisfied when a woman's los-

ing her life on average every four days? Of course not," the prime minister said. "I'll be satisfied when we eliminate this as

an issue, when we're not talking about this as an issue, when women are not feeling as though they have to mobilise in rallies," he The Australian Institute of Criminology reported that in the 12 months through June

2023, 34 Australian women were killed by an intimate partner. That is the latest complete fiscal year for which the institute has data and represented a 31 per cent increase in victims from the same 12-month period a vear earlier when 26 women died.

AIZAWL, May 1: A total of 108 people died of tuberculosis in Mizoram last year, officials said on Wednesday.

Blood samples of 17,432 people were tested last year, and of them, 2,272 were found suffering from TB, they said.

Of the 2,272 patients, 164 were diagnosed with multi-drug resistant tuberculosis (MDR-TB), they said, adding that 86 per cent of the patients were successfully treated, while 108 people died.

Between January and March this year, a total of 595 people have been diagnosed with TB, out of the 3,761 samples tested. Of them, 38 were diagnosed with MDR-

TB and 57 people were found suffering from both TB and HIV-AIDS, officials said. Of the patients, 6 per cent are diabetic, 33 per cent use tobacco and 16 per cent are alcoholic, they said.

So far this year, the Aizawl district reported the highest number of TB cases at 433, followed by Kolasib district (46) and Lunglei district (34).

West Mizoram's Mamit district recorded the least TB cases at five.

Only 187 people in the state have registered to adopt TB patients or donate for them through the 'Nikshay' platform under the PM TB Mukt Bharat Abhiyan.

The initiative was launched by President Droupadi Murmu in September 2022, aiming to augment community involvement in meeting India's commitment to end TB by 2025 ahead of the global target

GUWAHATI, May 1: Acting tough on violations of the model code of conduct (MCC), the Election Commission of India (ECI) has suspended 27 state government employees across various departments for alleged violations of the MCC.

According to the office of the chief electoral officer Puneet Agarwal, decisive action was taken against the employees for their negligence of election-related duties.

In a letter directed to the higher authorities of the respective departments, Agarwal stressed the importance of taking such disciplinary action against the suspended employees within their departments. The letter of the CEO highlighted the significance of maintaining electoral integrity and adhering to prescribed protocols during the electoral process.

According to reports, Agarwal specified that any department seeking to lift the temporary suspension of its employees must first obtain consent from the ECI.

This process requires coordination through the Chief Election Officer's office in the state.

Mizo group to protest Centre's decision to fence Indo-Myanmar border

HT Bureau GUWAHATI, May 1: A Mizo group representing the Chin-Kuki-Mizo-Zomi tribes of India, Bangladesh and Myanmar on Tuesday said that it will stage peaceful rallies along the Mizoram-Myanmar border on May 16 to protest against the Centre's decision to fence the Indo-Myanmar border and scrap the Free Movement Regime (FMR).

The Aizawl based- Zo Re-unification Organisation (ZORO), which seeks the reunification of all Zo people and bring them under one administrative unit, on Tuesday held a meeting and expressed strong exception to the Centre's decision to fence the 1,643-km-long Indo-Myanmar border particularly Mizoram side (510 km) of the international border, the organisation secretary Ramdinliana Renthlei said.

The meeting observed the Centre's decision to fence the Indo-Myanmar border and abolish the FMR as an attempt to di-

vide and oppress the Zo ethnic tribes living in both India and Myanmar, he said.

Renthlei said that the meeting decided to organise peaceful rallies at two locations in Zokhawthar and Vaphai villages in east Mizoram's Champhai district on the Indo-Myanmar border on May 16. The organisation also appealed to the Mizo or Zo communities living in both Mizoram and Myanmar to take part in the proposed rallies to protest the Centre's decision to fence the Indo-Myanmar border and scrap the FMR, he said. GUWAHATI, May 1: A fast track court in Manipur awarded 25-year rigorous imprisonment to a 61-year-old tribal for sexually assaulting two minor girls under Section 6 of the Protection of Children from Sexual Offences (POCSO) Act, 2012.

Binny Ngangom, the Special Judge Fast Track Special Court of Ukhrul district, Manipur on Tuesday convicted K Ramyo Shimrei (61) of Lunghar Village in Ukhrul district for 25 years of rigorous imprisonment for raping two minors during a period from July 27, 2018, to August 2, 2018. The incidents happened in the Ukhrul district, according to the dossier of the court.

He said the other wish of Manatma Gandhi was that Congress be disbanded after Independence.

"Mahatma Gandhi had said the Congress should be disbanded after Independence. The people of the country are going to fulfil this wish of Mahatma Gandhi and the Congress is going to be wiped out from the politics of the country," he said. BJP candidate Harsh Malhotra, who was accompanied by Uttarakhand Chief Minister Pushkar Singh Dhami, also filed his nomination papers after an "impressive" procession. Dhami too exuded confidence that the "huge" gathering in support of Malhotra indicated that the people were going to elect him from the seat. BENGALURU, May 1: Karnataka chief minister Siddaramaiah on Wednesday said Hassan MP Prajwal Revanna, who is facing allegations of sexually abusing several women, used his diplomatic passport to travel abroad, and urged Prime Minister Narendra Modi to take swift action to cancel it.

In a letter to Modi, he also asked the PM to take other steps such as using diplomatic and police channels of the Government of India as well as international police agenciesto ensure the swift return of the "absconding" member of parliament to face the full force of the law.

The 33-year-old Prajwal Revanna is the son of H D Deve Gowda's elder son H D Revanna, who is an MLA and a former minister Prajwal is the BJP-JD(S) alliance's candidate from

Hassan, which went to the polls on Friday. Explicit video clips allegedly of Prajwal Revanna sex-

ually abusing several women had started making the rounds in Hassan in recent days, following which the state government constituted a SIT to investigate the crime allegedly involving the MP.

"According to reports, sensing the impending police case and arrest, the accused Member of Parliament and NDA candidate for Lok Sabha Prajwal Revanna has fled the country and travelled abroad on April 27 itself. It is learnt from reports that he is travelling abroad on his diplomatic passport," Siddaramaiah said.

He said that while the SIT is working round the clock to investigate the allegations of crimes against several women by Prajwal Revanna, getting him back to the country is of utmost importance so that he faces investigation and trial as per the law of the land.

"In this regard, this is to urge you kindly to move the Ministries of External Affairs and Home Affairs to take swift action to cancel the diplomatic passport of Prajwal Revanna and to take such other steps using diplomatic and police channels of the Government of India as well as international police agencies to ensure the swift return of the absconding Member of Parliament to face the full force of law," the CM said in the letter.

The SIT of Karnataka will provide all the necessary details and fulfil all the legal formalities required in this regard, he added.

JD(S) on Tuesday suspended Prajwal Revanna from the party following the allegations.

Stating that there is a serious case of alleged sexual exploitation of innumerable women by Prajwal Revanna, Siddaramaiah said the allegations that the MP and NDA candidate for Hassan Lok Sabha is facing are "horrific and shameful" and these have shaken the conscience of the country.

"Our Government has constituted a Special Investigation Team (SIT), on April 28, under the Criminal Investigation Department (CID) and investigation has begun in right earnest. Constitution of the SIT was done as soon as the true nature of the alleged crimes against several women emerged and the victims came forward to file complaints against Prajwal Revanna and an FIR was lodged on April 28," he added. Talking to reporters after the meeting, Kumar said, "We are fighting against the dictatorship that is prevailing in the country. We will together save democracy and Constitution." He responded, "We are not only fighting on seats in Delhi but the INDIA bloc parties are fighting on all 543 seats. We are united. It is not a question of making someone a prime minister, an MP or forming the government of one party." He asserted that the elections are a "fight for the self-respect" of the people of Delhi.

BJP put lives at stake for extorting political donations from vaccine manufacturer: Akhilesh

LUCKNOW, May 1: Amid a controversy over the "side effects" of Covishield vaccine, Samajwadi Party chief Akhilesh Yadav on Wednesday accused the BJP of putting the lives of people at stake for "extorting political donations" from a vaccine manufacturer.

Demanding a high-level judicial probe into it, Yadav said allowing such lethal medicines amounts to a "conspiracy to murder someone" and those responsible should be prosecuted

"Around 80 crore Indians have been given the Covishield vaccine, which is two doses per person, and the company that made its original formula has said that it causes a risk of heart attack," Yadav said in a post on X.

"Those who have lost their loved ones due to the side effects of the vaccine or who feared the ill effects of the vaccine, their doubts and fears have now been proven right," the former Uttar Pradesh chief minister said.

Those who play with the lives of the people will not be forgiven, he

UK-headquartered pharma giant AstraZeneca has admitted that in "very rare cases", its Covid-19 vaccine, which is known as Vaxzevria in Europe and Cov-



ishield in India, can cause a blood clot-related side effect but the causal link is unknown, according to court papers being quoted in the UK media

In India, the AstraZeneca vaccine was manufactured by the Serum Institute of India.

Attacking the BJP, the SP chief further said, "The ruling party has put the lives of the public at stake by collecting political donations from the vaccine manufacturing

"Neither the law, nor the public

should be a judicial inquiry at the highest level in this matter," Yadav

SP leaders had made similar allegations on Tuesday, saying the BJP took "commission" from the manufacturer of the Covid vaccine, which they said was "forcibly" administered to people.

Uttar Pradesh Congress chief Ajay Rai had also attacked Prime Minister Narendra Modi over the issue. "Is this Modi's guarantee?" he had asked.

SP national general secretary will ever forgive them. There Shivpal Yadav had said, "It has

now been exposed that they have taken commission in vaccines too. Low quality vaccines and medicines were given to the people." Dimple Yadav, wife of SP chief

Akhilesh Yadav, said people were "forcibly" administered Covid vaccines in the country. "A donation of Rs 200-300 crore

was taken (by the BJP) and they (company) were given permission to market the vaccine. People were forcibly administered vaccines. No where in the world vaccines were administered forcibly," Dimple said, adding that corruption in vaccine manufacturing has now come to the fore.

Akhilesh Yadav, while the country was under the impact of COVID-19 pandemic, had said that he would not take the "BJP's vaccine", and that when his government comes to power, everyone would be vaccinated for free.

The Daily Telegraph reported that in a legal document submitted to the High Court in London in February for a group action brought by 51 claimants, AstraZeneca admitted that the vaccine developed with the University of Oxford to protect against COVID-19 may cause Thrombosis with Thrombocytopenia Syndrome (TTS) in "very rare cases". (PTI)

NC candidate and former minister Mian Altaf Ahmed took also took a potshot at the ECI and claimed he had not seen such an example of the deferring of polls in the history of elections.

'There is no example in history that elections have been deferred. I have never heard such an example that elections were postponed due to a mere landslide. This has happened for the first time. It is an undemocratic step," Altaf told reporters here.

He alleged people's anger against

"There is no justification for such a step. The seat carved out after delimitation by joining people of Anantnag with Rajouri-Poonch belt is injustice and cruelty. People have already felt it. They are unhappy over it. It is just an excuse," he added. The elections to the redrawn Anantnag-Rajouri Lok Sabha seat, which was slated to go to polls on May 7, were postponed to May 25 by the Election Commission.

This comes after several leaders, including Jammu and Kashmir BJP unit chief Ravinder Raina, Jammu and Kashmir Apni Party chief Altaf Bukhari, People's Conference leader Imran Ansari, and others, had approached the Election Commission requesting the rescheduling of polls to the seat due to adverse weather conditions.

The Election Commission had asked the Jammu and Kashmir administration to immediately submit a detailed report on road conditions, weather, and accessibility to the region, which covers parts of south Kashmir and areas in Poonch and Rajouri in the Jammu region.

The official notification said that the polls will be held on May 25.

Global plastics treaty: Modest progress in Ottawa leaves civil society disappointed

NEW DELHI, May 1: The fourth round of United Nations negotiations for an international treaty to end plastic pollution in Ottawa, Canada, ended on Tuesday with modest progress, leaving ambitious states and much of the civil society disappointed.

With the decision ignoring a discussion on the central role of plastics production in fueling the climate, biodiversity and pollution crises, they said the Ottawa negotiation caved into the interests of the fossil fuel and petrochemical industry.

Countries decided to move forward with intersessional work -expert meetings between the official sessions of the Intergovernmental Negotiating Committee (INC) -- on the financial mechanism, plastic products, chemicals of concern in plastic products, product design, reusability and

recyclability. We came to Ottawa to advance the text and with the hope that members would agree on the intersessional work required to make even greater progress ahead of INC-5. We leave Ottawa having achieved both goals and a clear path to landing an ambitious deal in Busan ahead of us," said Inger Andersen, Executive Director of the UN Environment Programme (UNEP).

"The work, however, is far from over. The plastic pollution crisis continues to engulf the world and we have just a few months left before the end-ofyear deadline, agreed upon in ibility to achieve maximum am-

"This compromise diminishes the ambition of this process as it ignores the central role of plastics production in fueling the climate, biodiversity and pollution crises. This is not only an utter disappointment, but also a missed opportunity to tackle the root causes

comprehensively," it said. The fourth session of the INC to advance a plastics treaty saw countries adopt a "weak program of formal intersessional work". Despite a handful of countries taking a stand to keep ambitious proposals alive, most countries accepted a "compromise that played into the hands of petrostates and industry influences", a statement from the Centre for International Environmental Law (CIEL) said.

A CIEL analysis released during INC-4 found that nearly 200 fossil fuel and chemical industry lobbyists registered for the negotiations, including at least sixteen on country delegations.

"From the beginning of negotiations, we have known that we need to cut plastic production to adopt a treaty that lives up to the promise envisioned at UNEA two years ago. In Ottawa, we saw many countries rightly assert that it is important for the treaty to address the production of primary plastic polymers," says David Azoulay, Director of Environmental Health at the Center for International Environmental Law (CIEL). Northern plains, central India to have high number of heat wave days in May: IMD

maximum temperatures are likely over most parts of the country in May and a significantly high number of heat wave days expected over the northern plains, central region, and adjoining areas of peninsular India, said IMD chief Mrutyunjay Mohapatra on Wednesday.

A prolonged and intense spell of heat wave scorched swathes of east, northeast, and southern peninsular India in April, prompting health warnings from government agencies and some states to suspend in-person classes in schools.

Five active Western Disturbances led to rain, thunderstorm, and hailstorms over north and central India at regular intervals in April, preventing heat waves, the India Meteorological Department's director general told a press conference.

IMD data shows that the heat waves in April this year were far worse than in 2023, the warmest year on record so far. This trend is likely to continue in May, with around eight to 11 heat wave days predicted over south Rajasthan, west Madhya Pradesh, Vidarbha, Marathwada, and Gujarat regions, Mo-

The remaining parts of Rajasthan, east Madhya Pradesh, Punjab, Haryana, Chandigarh, Delhi, Uttar Pradesh, and some parts of Chhattis-



garh, interior Odisha, Gangetic West Bengal, Jharkhand, Bihar, north interior Karnataka, and Telangana may record five-seven heat wave days in the month, he said.

Normally, the northern plains, central India, and adjoining areas of peninsular India experience around three days of heat waves in May.

Above normal maximum temperatures are likely over most parts of the country in May, except for most parts of northeast India, some parts of northwest and central India, and adjoining areas of northeast peninsular India mum temperatures are likely, the IMD said. Above normal minimum temperatures are likely over most parts of the country except the northeast and some areas of northwest India, Indo-

Chhattisgarh encounter:

Task Force (STF) jawan involved in Tuesday's encounter on the border of Narayanpur and Kanker districts of Chhattisgarh fought off not just Naxalites, but also a wild bear that attacked him.

Constable Mangal Mandavi sustained bite injuries on his leg in the face-off with the wild animal, police said. He was shifted to Narayanpur in a helicopter on Wednesday morning and admitted to the district hospital, they said, adding that his condition is normal.

Ten Naxalites, including three women, were killed in the encounter that occurred in the forest between Tekmeta and Kakur villages in Abhujmad area, a Naxalite stronghold, on Tuesday when a joint team of the STF and the District Reserve Guard. both units of the state police, was out on an anti-Naxal operation.

Talking to PTI, Mandavi said, during the exchange of fire, he and his colleagues were busy in action in the forest, surrounded by bamboo trees, when suddenly three bears came there from behind.

Sensing the presence of wild animals, his colleagues managed to charged towards him and caught hold of his leg when he tried to hide

among bamboo trees, he said. The bear bit his legs, following which Mandavi retaliated with a stick, prompting the bear to escape.

Though Mandavi sustained injuries on his leg, he continued to fight against Naxalites.

He was shifted to Tekmeta, where he was administered preliminary treatment and he was airlifted to Narayanpur this morning, he said.

Police officials said, security personnel were asked to take extra precautions during their patrolling in the forest as they are not just fighting Naxalites, they also had to keep themselves safe from wild animals.

Two of the 10 killed cadres were prima facie identified as Joganna and Vinay alias Ashok, who were active as divisional committee members of Maoists, police had said.

This was a second major blow to the Naxalites within 15 days. The site of Tuesday's encounter was 30 km south of Kalper village in Kanker where 29 Naxalites were killed in a gunfight with security forces on April 16, said a senior police official. (PTI)

Al cannot replace doctors, says IMA chief

NEW DELHI, May 1: Artificial intelligence cannot replace doctors though this technology can assist medical practitioners, IMA chief Dr R V Asokan has said. During an interaction with PTI editors, he said the medical profession has always been the first to embrace technology but it cannot supersede the connection between a patient and a doctor. "Nobody can replace a doctor. As long as the patient is vulnerable and is in a situation where he is so helpless that no science can treat him, only that touch, that hope, that eye contact, that assurance of a doctor can work," he said.

artificial intelligence, telemedicine and robotic surgery will greatly enhance the medical field but "I think the doctor will always be there".

Asokan asserted that newer technologies like

"We believe that the art of medicine is bigger than the science of medicine," he said.

Commenting on the violent attack on doctors and the need for a centralised law, he said unfortunately such instances of doctors are becoming a part of the culture.

"It has become part of the culture. It is because of the high expectations and the unmet needs... There is a law protecting the airline staff. We are asking the government that if the airline staff are so special for the country, then please give us some protection also," he said.

Asokan further said around 23 states have passed laws to deal with violence against doctors but these, he said, were ineffective on the ground. He went on to say that amendments to the Epi-

demic Diseases Act, were useful. "You wanted the doctors to be protected during the corona pandemic and not on ordinary times. that also looks funny," he said.

Over punishment of doctors for medical negligence, the IMA chief said that no doctor is criminally culpable

"We may be answerable on the law of torts or the civil law. A crime is defined as having an intent. If there is no intent then there is no crime. If it's a murder, then its a different thing. Otherwise during the process of treatment if there is a death there is no criminal intention. You cannot accuse the doctor of a criminal intention. Something might have gone wrong. Civil law is adequate to handle that situation," he said.

Responding to a question on whether the IMA was concerned over the allegations about pharma companies influencing doctors in prescribing their respective brands and bribing them with gifts and junkets disguised as conferences. Asokan said medical professionals have to follow the etiquette that has been prescribed.

The Professional Conduct, Etiquette and Ethics) Regulations, 2002 of the Medical Council of India is certainly applicable, he said. (PTI)

NEW DELHI/NOIDA, May 1: At least 100 schools in the Delhi-NCR area received bomb threats through emails on Wednesday leading to chaos and widespread alarm but "nothing objectionable" was found, officials said, requesting people not to panic.

The schools were evacuated after local police were informed about the threat emails. According to Delhi Fire Service (DFS), at least 97 calls from different schools have been received till 12 noon on Wednesday. All the calls are being attended diligently, an officer said.

Multiple private schools in Noida and Greater Noida also received the bomb threat. The Ministry of Home Affairs said it appears to be a hoax threat and that there was no need to panic.

Delhi Police said it has conducted a thorough check of all schools that received the bomb threat but found nothing.

"Some schools of Delhi received emails regarding bomb threats. Delhi Police has conducted thorough check of all such schools as per protocol," Delhi Police said

"Nothing objectionable has been found. It appears that these calls seem to be hoax. We request the public not to panic and maintain

According to Delhi police officials, the

email is suspected to have been sent from one source to schools in Delhi and adjoining Noida and Greater Noida. Sources said the content of the mail to every school is the same. The Union Home Ministry termed the bomb threat as a "hoax" and asked people not to panic. Police and security agencies are taking necessary steps as per protocol, the ministry said.

There is no need to panic. Mails appear to be hoax. Delhi Police and security agencies are taking necessary steps as per protocol," a home ministry official said.

Noida Police said all such schools that received the emails were thoroughly checked and the bomb threat was found to be a hoax, Additional Commissioner of Police (law and order) Shivhari Meena said.

"This morning a threatening email was received by a chain of schools after which police teams responded to the situation immediately," Additional CP Meena said. "All such schools that received the threats

were thoroughly checked and sanitised. At no place any such thing (threat) has come to light and it is proved that the email was sent to trigger a rumour," he said.

Reacting to the development, Delhi Lt Governor VK Saxena wrote on X that he spoke to the police commissioner and sought a detailed report into the bomb

threats at schools in Delhi-NCR. "Directed Delhi Police to carry out a thor-

ough search in school premises, identify the culprits and ensure there are no lapses," he said, requesting parents not to panic and cooperate with the administration in ensuring safety of schools and the children.

"The miscreants and culprits will not be spared," he added.

Delhi Education Minister Atishi also requested parents not to panic and wrote on X, "Some schools have received bomb threats this morning. Students have been evacuated and those premises are being searched by Delhi Police. So far nothing has been found in any of the schools.

'We are in constant touch with the police and the schools. Would request parents and citizens not to panic. School authorities will be in touch with parents wherever needed," Atishi said. Visuals from Mayur Vihar's Mother's Mary school showed concerned parents assembling outside the school to pick their children.

The school administration was seen making announcements on the microphone while parents rushed to collect their wards.

"I dropped my child 10-15 minutes ago. Then I received a call from the school to take my child back due to some emergency," Vijay Kumar, a parent, said. (PTI)

THIRUVANANTHAPURAM, May 1: Kerala police said on Wednesday that the memory card of the CCTV camera on the KSRTC bus, which was a vital evidence in the ongoing rift between the Thiruvananthapuram Mayor Arya Raiendran and the driver, is missing.

A team of police personnel from the Cantonment station here examined the superfast bus parked at the KSRTC depot here but failed to retrieve the memory card which was expected to be vital proof in the raging row.

The mayor and her family on Saturday night got into a heated argument with the KSRTC bus driver after blocking the vehicle at Palayam junction. The mayor alleged that the driver made sexually suggestive gestures at them.

She claimed that the driver was rash and negligent, and they intervened after the bus was about to hit their car from

The driver, HL Yadhu, however, had rejected the allegations levelled by her. "A 64 GB memory card with the recorded visuals should have been there on the bus. There are three cameras inside the superfast bus. But the memory card is missing," a police officer told the

However, the driver said the camera had been operational throughout the journey and was working even after the controversial incident. He also expressed doubt that some-

one might have removed it. "I have expected that there are chances for the visuals to be destroyed.

nomically developing countries in terms of carbon dioxide (CO2) emissions from aviation, a new research has found. Calculating "nearly real-time"

aviation emissions using global flight data, researchers found that overall, the US, China and Great Britain were the topmost contributors, with 22 per cent, 14 per cent and roughly four per cent share.

However, among the economically developing countries, India was found to be the third biggest contributor with close to three per cent share in global CO2 emissions from aviation, following China at 14 per cent and the United Arab Emirates (UAE) at more than three per cent. The research team at the Norwegian University of Science and Technology also found that India's share in global CO2 emissions from domestic aviation was the third highest at 1.5 per cent.

"The countries with the highest absolute domestic aviation CO2 emissions (global percentage share in total CO2 aviation emissions in parentheses) are the USA (13.4 per

cent), China (8.9 per cent), India (1.5 per cent), Russia (1.2 per cent), and Japan (1.1 per cent), the authors wrote.

The findings were published in the journal 'Environmental Research Letters'.

For their analysis, the researchers used the model, called AviTeam, which computes the fuel burnt for individual flights for the entire envelope based on a given trajectory When the 1992 United Nations

Framework Convention on Climate Change treaty was signed, high-income countries were required to report their aviation-related emissions. However, the lowand middle-income countries, including China and India, were not required to report these emissions,

even though they could voluntarily

The researchers said the model is the first to provide information for the 45 lesser-developed countries that have never inventoried their greenhouse gas emissions from aviation.

"Our work fills the reporting gaps, so that this can inform policy and hopefully improve future ne-

Klenner, a PhD candidate at the Norwegian University of Science and Technology.

"Now, we have a much clearer picture of aviation emissions per country, including previously unreported emissions, which tells you something about how we can go about reducing them," said coauthor Helene Muri, a research professor at the university.

The abillity to calculate nearly real-time aviation emissions could also provide an important tool as the industry makes changes to decarbonise, according to co-author Anders Hammer Stromman, a professor at the Norwegian University of Science and Technology.

"I think it very nicely illustrates the potential in this type of work, where we have previously relied on statistical offices and reporting loops that can take a year or more to get this kind of information," he

"This model allows us to do instant emissions modelling - we can calculate the emissions from global aviation as it happens," said Stromman. (PTI)



NEW YORK, May 1: A breakout moment in Hollywood can happen at any age and stage. This summer at the movies, there are plenty of talents to discover, from the formerly incarcerated man whose story inspired the film he stars in to the "It" bully whose childhood dream of playing an ape in a

Clarence Maclin didn't know he had knack for acting until he was in prison, where he found the Rehabilitation Through the Arts Program and an appreciation for Shakespeare. His experience provided the inspiration for 'Sing Sing," where he plays himself in a cast that includes Oscar nominees Colman Domingo and Paul Raci as well as a group of formerly incarcerated

"It almost was overwhelming when I had to go back and put the greens on again and go back into that mindset of being in prison," Maclin, 58, said. "However the purpose of what we were doing outweighed the apprehen-

After working on the idea for years, he loved being on set and said there

were "no butterflies" when it came to acting in front of the camera. Domingo, he said, helped him appreciate the nuance that the camera can capture. Iranian-French artist Marjane Satrapi wins Spanish Asturias award for communication

A breakout film from last fall's Toronto Film Festival, more than a few "Sing Sing" reviews have called Maclin's performance starmaking. He's read them and still can't believe it. But mostly, he's excited to take the film on the road and get the message out.

'I've made a lot of mistakes in my life, but luckily I got an opportunity to redirect and try to correct some of those," said Maclin, who was incarcerated for more than 15 years for armed robbery. "I would like to be able to show this in every prison in the country and do a question and answer. Sometimes a little bit of hope is all you need."

"Sing Sing" opens in limited release on July 12 and an expansion will follow in August.

Nobody comes out of "Stranger Things" anonymously, but Joseph Quinn, who played Hellfire Club leader Eddie Munson, was a little surprised by the attention. On vacation with friends on a small island in Italy, one looky-loo in the morning multiplied into a big crowd by the end of the day. Still,

not everyone knew who he was. "The manager of the hotel was like 'who are

you'?" Quinn recalled, laughing. But mainly it's led to life-changing opportunities for the 30-year-old British actor who is starring alongside Oscar-winner Lupita Nyong'o in "A Quiet Place: Day One " (June 28) and later this year will be sharing the screen with Denzel Washington and Paul Mescal in "Gladiator II" (Nov. 22). He's also been tapped to help restart the Fantastic Four franchise in the Marvel Cinematic Universe as the Human Torch.

"When you go and you see ancient Rome and you see Denzel Washington inhabit it and watch Ridley Scott make a film, those things have a profound change in you," Quinn said. "It expands your idea of what's possible.'

But first up is the highly anticipated "Quiet Place" prequel, which focuses on a new pair of characters in New York on that first day of the in-

"The whole experience was great fun," Quinn said. "I learned a lot from Lupita and the way to conduct oneself in an environment like that. She's punctual, brave, fearless and knows exactly what she wants and what she doesn't want.'

UK audiences can also see him soon in the independent film "Hoard."

Abbey Lee remembers being in New Mexico when she got an email from her agent saying that Kevin Costner wanted to send her a script and speak with her. The idea that Costner even knew who she was, she said, was shocking.

The project was "Horizon: An American Saga," his Civil War era epic about the Westward expansion in America that Warner Bros. is releasing in two parts this summer (June 28 and Aug. 16). Her character, Marigold, is a woman without a family or a home who is fighting for a better life.

"She uses sex work as a means to survive," Lee, 36, said. "Like everyone in this film, she's somewhat broken and worn down but she's also a very hopeful person and a very resilient woman with a strong will to live."

The Australia native worked as a model for years before she had a few big acting breakthroughs, notably in "Mad Max: Fury Road." Modeling gave her opportunities to travel, and get a paycheck, but it always felt like a job, she said.

"My passion is the craft of acting," she said. "You get to utilize not just your body, but your brain and your heart and your emotional capacity. And you keep changing and growing: Each role shifts your perspective on the world and your life."

Filming "Horizon," Lee fell in love with riding horses and was overwhelmed by not just the beauty of Utah but also the scope of the film.

"It's such an epic piece," she said. Izaac Wang had been on some big films before "Didi," including "Good Boys" and "Clifford the Big Red Dog," but it wasn't until he looked at his schedule that he realized just how big of a commitment a leading role was.

"I was like 'wait, I'm working every day'?" Wang laughed. "My mom was like, 'Yeah, you're working every day.

In "Didi" he plays a 13-year-old Taiwanese American boy on the summer before high school in the Bay Area in 2008. The film was one of the big discoveries of the Sundance Film Festival, winning the audience award and a special jury award for its ensemble. It's getting a theatrical release from Focus Features on July 26.

Wang was born in Minnesota, moved to Los Angeles with his family when he was 3 and started acting around age 8. While he's thought about giving it up in the past, "Didi" was a turning point because it was such a fun experience. He's considering studying theater in college too.

"I love acting in general because I get to be a goofy, silly, imaginative guy," he said. "I play with my stuffed animals still. I'm 16-years-old, I still do it."

Unlike the other actors on this list, audiences will not see Owen Teague's face on the big screen. Well, not exactly. He's the star of "Kingdom of the Planet of the Apes," a new film set many years after Caesar's reign when the apes have become the dominant species. He plays an ape named Noa.

"I've wanted to play a performance capture ape since I was a little kid," Teague said. "This was one of those auditions where I was like 'God, I'd give anything to do this movie.'

The 25-year-old from Tampa, Florida, got his first big break on the television series "Bloodline," which led to playing one of the bullies in "It" and Julia Louis-Dreyfus' son in "You Hurt My Feelings 'among other credits. Teague said he worried early on that he was only playing "bad guys." Villains are fun, he said, but he wanted the chance to do every-

For this movie, he went to ape school and worked closely with a movement coach so that it would feel second-nature by the time they started filming. His character, Noa, is the sheltered son of their clan's leader who has to go on an eye-opening journey to

save his family. "There's a lot of pressure on him to live up to his father's expectations." Teague said. "There's this part of him that wants to know what's out there."

And he recommends seeing it on the big screen: "It's one of the most astounding things I've ever

Nadal gets emotional after a loss in his last Madrid Open appearance

MADRID, May 1: Rafael Nadal had to pause for a few moments, visibly emotional, while addressing the crowd after his loss in the fourth round at the Madrid Open. As chants of "Rafa, Rafa, Rafa" echoed around, the five-time champion in Madrid made a farewell speech following a 7-5, 6-4 loss Tuesday to the 31st-ranked Jiri Lehecka.

It was likely his last official match at the tournament in the Spanish capital.

"This is a difficult day when it arrives, but it's a reality. My body and my life had been sending me signs for some time," Nadal said. "I was able to say goodbye playing on this court, one of the most emotional ones for me. Madrid at times has been more important to me than a Grand Slam. The memories here will stay with me forever."

After the match, tournament organizers unfurled five banners for each of Nadal's titles in Madrid - 2005, 10, '13, 14 and '17. They also showed a video of his highlights, as his wife and sister shed tears in

"It's been a gift what you've done for me during the 21 years that I've played



here," said the 37-year-old Nadal, a winner of 22 Grand Slam singles titles. "All I can say is thank you.'

Nadal had not lost to a player ranked outside the top 20 on clay since falling to Pablo Cuevas in 2016 at Rio de Janeiro.

The World Cup in Antalya,

Turkey in June is the final qualifying event for the Paris Olympics.

However, if the Indian men's team is unable to make the cut there, it is still in prime position to qualify for the Olympics owing to the rankings. The top-two ranked team in the world get direct entry for the Games. India are ranked second so far behind Korea.

Dhiraj was also a part of the silver-winning men's team at the Asian Games last year.

Gujarat Titan's fate in IPL to decide when will Kirsten begin Pakistan assignment

LAHORE, May 1: Gary Kirsten, Pakistan's new head coach in the white-ball formats, could join the national squad directly in Ireland if his IPL team Gujarat Titans does not qualify for the Play-offs stage of the popular T20 League.

A Pakistan Cricket Board (PCB) official said Kirsten, while signing the contract, had made his commitment with the IPL franchise for this season very clear. Kirsten is associated with Gujarat Titans as batting coach and mentor.

The official added that in case Gujarat make the IPL playoffs, then Kirsten will join the team in England for the last two T20 internationals.

"If Gujarat don't qualify for the play-offs which will become clear by around May 16 or 17, or perhaps before that Kirsten will then join the Pakistan team directly in Ireland before series against England," the official said.

The IPL playoffs are from May 21 to 24 with the title clash scheduled for May 26.

Pakistan's four-match T20 series in England is scheduled to be held from May 22-30 before the teams reach USA for the World T20 Cup.

The PCB recently hired Kirsten on a two-year contract and there are high hopes that the South African will make the team more productive.

Having worked between 2008 and 2012 with the Indian team that won the 2011 World Cup, Kirsten only agreed to sign the contract with the PCB after he was assured there would be no interference in his work and the players he backed for continuity would be supported by the selectors.

"Kirsten made it clear to the PCB Chief, Mohsin Naqvi that he believes in first assessing a player and once he is convinced he is match-winning material for the team he likes to back him completely even if the player (s) go through a rough patch," the source

NEW YORK, May 1: The drop-in pitches prepared for the upcoming T20 World Cup are being transported from Florida to New York in semi-trailer trucks for installation at Nassau County International Cricket Stadium, the ICC Among other matches, the venue will also

host the marquee India-Pakistan group stage fixture on June 9. Ten drop-in pitches have been prepared in

Florida since late December, employing proprietary techniques honed over a decade at Adelaide Oval, the ICC said in a press release.

The development of the pitches has been undertaken by Adelaide Oval Turf Solutions, led by renowned Adelaide Oval head curator Damian Hough. "The pitches, cultivated with native Tahoma

31 Bermuda grass, have been meticulously nurtured in Florida by Adelaide Oval Turf Solutions and US-based sports turf experts LandTek Group, undergoing continuous care and maintenance over the past three months."

Four pitches will be set up at the Nassau stadium, with an additional six designated for neighbouring practice facilities.



remain in New York to assist local grounds crews in pitch maintenance throughout the tournament to ensure world-class pitches.

The drop-in square – the type used around the world including at Adelaide Oval and Eden Park - has been curated in Florida and transported by road to New York via a convoy of more than 20 semi-trailer trucks.

The outfield was laid last week by LandTek who have worked with the New York Yankees and New York Mets as well as Inter Miami CF on their stadium and training fields.

ICC Head of Events Chris Tetlev said: "The installation of these pitches is one of the final pieces in a project that is unprecedented in international cricket. "We have taken a considered and well-

planned approach to this project, using the very best in the business in Damian Hough to ensure we have the best possible playing surface for eight World Cup matches in New York."

The tournament will be held from June 2-29 in the USA and West Indies.

Adelaide Oval head curator, Damian Hough said: "We are excited to see the arrival of the pitches here in New York. Florida proved to be the ideal nursery for the pitches with good weather, and working alongside great partners like LandTek has been fantastic and everything is coming together as it should."

The matches in New York will take place at a state-of-the-art 34,000-seat modular stadium located at Eisenhower Park in Nassau County, east of Manhattan.

Nine teams will feature in New York including India, Pakistan, Sri Lanka, Canada, Ireland, Bangladesh, South Africa, the Netherlands, and the USA, with the first match taking place on June 3 between 2014 champions Sri Lanka and South Africa. (PTI)

I want to be on that flight to Paris, says Krishan Pathak

BENGALURU, May 1: Krishan Pathak finds himself in a bizarre situation. He will have to battle it out with his friend and mentor PR Sreejesh for the lone goalkeeper's slot in India's hockey squad for the Paris

In Olympics, a country can carry only a 16-member squad as against 18 players in other tournaments, and that restriction often forces the coach to sacrifice one goalkeeper to include another player in a different po-

It happened in the Tokyo Olympics as Sreejesh did the custodian's duty during India's bronze-winning run, while Pathak watched the action from the gallery. But this time, Pathak is not ready to give up the slot without a fight.

"The coach hasn't told us the team composition for the Olympics. My aim is to be ready 100 percent when the call comes. There is a healthy competition going on within the squad to earn a place in the Olympics-bound team.

"Every player feels that he can be part of that squad. I am no different, and I want to be on that flight to Paris," Pathak told PTI during the team's training camp at the SAI centre here.

Pathak shares a deep connection with Sreejesh. In fact, the veteran was India's goalkeeping coach during the 2016 junior World Cup, where Pathak showcased his talent to a broader world for the first time.

The 27-year-old insisted that the competition for an Olympic berth has not affected their personal equa-"It's dream for me to work with and play alongside

Sree bhai. We are very comfortable with each other.

We share a lot of information, especially when one of us commits mistakes. We point that out to each other. "Whenever I commit a mistake, he will come and tell me what went wrong and how to rectify it. Similarly, I will do that when Sree bhai makes a mistake. We have a great bonding between us – on and off the field," detailed Pathak.



The immediate assignment in front of him is the FIH Pro-League matches, starting at Antwerp, Belgium from May 22.

India will face some top-flight teams like Germany and Belgium in that tournament. Pathak wanted to assert his claim for an Olympic berth through some strong outings in the Pro-League.

"We've played eight Pro-League matches in Ranchi and Rourkela. Now, we have some more Pro-League matches coming up ahead of the Olympics. We will meet some of those teams in the Olympics too. That familiarity will help us.

"As a goalkeeper, I will look to source as much knowledge from the Pro-League matches about our possible opponents in the Olympics," he added.

tional team coach Craig Fulton, saying that the South African is helping the players to achieve their optimum potential ahead of the quadrennial showpiece.

"When he spots a weakness, he starts working on it immediately. He hates wasting time. When we went to Australia recently, our attack and defence were not working as we lost the series 0-5.

"It was a very difficult phase. I don't know how I survived that period as it put a lot of pressure on me. There was a certain loneliness inside me then as suddenly I was without my parents, even though my brother and uncle supported me a lot," he said.

Pathak said his single-minded dedication for hockey too played a big part in him getting out of that dark space. "Eventually, it was up to me to get out of that phase.

Hockey saved me during that time as I channelised all my thoughts towards the sport, so that I could forget all those bad moments. "I keep reminding myself about those days of strug-

gle, so that I remain focused on life and sport," he

His hard work eventually came to a fruition in the Hangzhou Asian Games when he stood on the podium with a gold medal around his neck

But even on that grand day, Pathak had a cavernous cut inside his heart.

"It was the proudest moment in my life. The only regret was that my parents were not there to see the moment as I always wanted to show them my

"I really miss my mom and dad. But I am sure that they are proud of me wherever they are," he choked with emotion.

Pathak also recently achieved the feat of completing 100 international matches for India, and he feels that it is the time to climb to the next level.

"It's a proud achievement for me after a topsy-turvy journey. I never thought of achieving it as I come from a family which has no hockey background. After playing so many matches, I am finding more about my own game now.

"I feel that now I am better at handling pressure and giving tips to the team from the goalkeeper's position. I am hoping to build on that in future," he signed off. (PTI)
