# Modi govt ministers get going



NEW DELHI, June 11: Signalling both change and continuity, India's new government, headed by Prime Minister Narendra Modi for a third consecutive term, got into work gear on Tuesday with cabinet ministers and ministers of state filing into their respective offices to assume charge.

A day after the much anticipated portfolios were announced and two days after Modi and 71 ministers were sworn in at a grand ceremony in Rashtrapati Bhavan, there were flowers and felicitations aplenty in the corridors of power. Some said it with prayers and a few slogans were heard too. NDA 3.0 'took office' a week after election results threw up a majority for the alliance with 293 seats, above the halfway mark of 272, with the BJP getting 240.

In a seamless transition from the previous government to the present one, the four big frontline portfolios stay the same -- Amit Shah for home, S Jaishankar for external affairs, Nirmala Sitharaman for finance and Rajnath Singh for

# NEET sanctity hit, says SC; seeks Centre, NTA response on plea for fresh exam

NEW DELHI, June 11: Observing that the sanctity of NEET-UG, 2024 has been affected, the Supreme Court on Tuesday sought responses from the Centre and the National Testing Agency (NTA) on a plea seeking holding of a fresh examination on grounds of alleged question paper leak and other malpractices.

The top court, however, refused to stay the counselling of successful candidates for admissions to MBBS, BDS and other courses. Taking note of the allegations, a vacation bench of Justice Vikram Nath and Justice Ahsanuddin Amanullah said what the NTA was supposed to do was sacrosanct. "Sanctity (of the exam) has been affected, so we need answers," he said.

Besides the Centre and the NTA, which conducts NEET-UG, the bench also issued notices to the Bihar government. There were allegations of malpractice in holding the exam in the state.

"How much time do you want ... Immediately on the re-opening? Otherwise, the counselling will start," the bench said. It tagged the plea filed by Shivangi Mishra and nine other MBBS aspirants with a pending petition and asked the NTA to file the response in the meantime. The top court will resume regular hearings from July 8 after the summer vacation which commenced on May 20 comes to an end.

NEET-UG, 2024, was held on May 5 and results were declared on June 4. It was expected to be declared on June 14. The National Eligibility-cum-Entrance Test-Undergraduate (NEET-UG) examination is conducted by the National Testing Agency (NTA) for admissions to MBBS, BDS, AYUSH and other related courses in



government and private institutions across the country. Issue notice. In the meantime, the response will be filed by the National Testing Agency," the bench said. It, however, did not agree to the submission of lawyer Mathews J Nedumpara, appearing for the students, that the counselling of students be stayed in the meantime.

"Let the counselling start, we are not stopping the counselling... We will not stop the counselling. If you argue further, we will dismiss this (the plea)," the bench told the advocate.

It took note of the submission that the fresh plea be tagged with a similar petition filed earlier on which a bench headed by CJI DY Chanrdarchud had issued notices to the Centre and the NTA on May 17 and that the plea was already listed on July 8. The court granted the prayer. (CONTD. ON PAGE-2)

# Junmoni Devi Khaund's Kooki to be released in India, Nepal on June 28

JORHAT, June 11: Junmoni Devi Khaund, producer of the Hindi film Kooki, on Tuesday announced that the movie would be released in India and Nepal on June 28.

Kooki is a Hindi film from the state, which premiered at the Cannes Film Festival, 2024 on May 21. The film narrates the story of a 16-year-old gang-rape survivor and the trauma she endures. The film has been directed by Pranab J Deka.

Addressing a meet at the Jorhat Press Club here on Tuesday, Khaund said that it was very encouraging that distributors from Nepal had approached her for distribution rights and that discussions were on with

distributors from UK, USA, Morocco, France and Monaco for a release two weeks after the June 28 release in India and Nepal. "After the Cannes screening there was a lot of positive feedback about the movie, from producers, distributors, actors and others who had watched it in the market segment of the Cannes Film Festival, with many of them saying that the trauma of a gang raped 16 year old girl and how she picks up the threads of her life, is a universal theme which can be widely related to."

"I am a lawyer and have come across several such cases. The police catch the criminals, file charge sheets, lawyers fight the cases, if we win we are happy, but nobody really cares what happens to the girl

after that. How does she survive? Through the film we have tried to depict not just the struggles and sufferings of a rape survivor, but also attempted to provide a positive solution," Khaund said.

She further said that the stories of the victims had moved her to create a rough outline for the making of a movie, and story board was formed with the director Pranab J Deka and others, some of who came from Mumbai.

Khaund further said that they had made the movie in Hindi so that it catered to a wider audience and was not limited to the regional level. "It is time that movies made in the state compete with those made in Bollywood and (CONTD. ON PAGE-2)

# Sensex, Nifty settle almost flat amid volatile trade

MUMBAI, June 11: Benchmark equity indices Sensex and Nifty ended almost flat on Tuesday after a record-breaking rally as investors preferred to remain on the sidelines awaiting further triggers.

After trading in the positive territory for the most part of the session, the 30-share BSE Sensex declined 33.49 points or 0.04 per cent to settle at 76,456.59 due to fag-end selling. During the day, it jumped 370.45 points or 0.48 per cent to 76,860.53. In a volatile trade, the NSE Nifty ended marginally up by 5.65 points or 0.02 per cent to 23,264.85.

Sensex and Nifty hit their alltime high levels in the early trade on Monday.

"After a notable rebound, the domestic market has stabilised, awaiting further triggers. With the resolution of uncertainties in government formation, attention has shifted back to global and domestic indicators. Concerns have risen regarding potential US rate cuts following last week's strong US job data, leading to an increase in US bond yields.

"However, FIIs have been net buyers lately. Investors are now gearing up for this week's policy decisions from the US Fed and the BoJ, as well as key inflation data from the US and India, seeking insights into the trajectory of rate cuts," Vinod Nair, Head of Research, Geojit Financial Services,



said. Among the 30 Sensex companies, Kotak Mahindra Bank, Asian Paints, Reliance Industries, ITC, Sun Pharma, ICICI Bank, Axis Bank and JSW Steel were the major laggards.

On the other hand, Larsen & Toubro, Tata Motors, Maruti, NTPC, Mahindra & Mahindra and UltraTech Cement were among the gainers.

NEW DELHI, June 11: RSS pracharak and Haryana's former chief minister Manohar Lal Khattar on Tuesday took charge as union power minister in the Modi 3.0 government.

Khattar has replaced R K Singh who lost election from Arrah in Bihar.

After assuming charge of the ministry earlier in the morning, Khattar met heads of public sector undertakings in the power sector and other top brass of his ministry to understand the dynamics of the sector.

However, he did not offer any comments to media persons about the key challenges and his plan of action for at least next 100 days in the power sector.

As a power minister, Khattar will have to deal with various issues including high power demand and coal supply issues faced by electricity producers across the country.

The power demand has already touched an all-time high of 250 GW in May this year. Earlier, the ministry had projected that peak power demand was estimated to touch 260 GW during this summer.

Many power plants have been maintaining coal stock at lower than normative levels.

Khattar would have to work in close coordination with the ministries of coal as well as railways to ensure adequate supply of the dry fuel at all power stations across the country.

Coal-based thermal power still serves the base load to the national grid, despite having over 190 GW of renewable energy including large hydro (25 MW or above). Khattar defeated Divyanshu Budhiraja of the Congress in Karnal constituency during the latest general election. In 2014, Khattar became an MLA for the first time and took over as Chief Minister of Haryana. In March 2024, he was replaced by his confidante Nayab Singh Saini.

Manohar Lal Khattar takes charge as Power Minister His family settled at Nindana, a village in Haryana's Rohtak district. He was born in Nindana in 1954.

> In 2014, when the BJP formed the government in Haryana on its own for the first time, Khattar became the state's first non-Jat chief minister in nearly two

decades, fracturing Jats' longstanding domination in the state's politics. During his first stint as chief minister, Khattar came

under criticism over his handling of the February 2016 Jat quota stir, which saw large-scale violence and arson in several parts of the state.

The stir was followed by a flurry of violent incidents which claimed many lives in 2017, when Dera Sacha Sauda chief Gurmeet Ram Rahim Singh was convicted by a court in Panchkula in a rape case. For his second stint as CM, which lasted four-and-a-half years, the BJP had to take support of JJP after it fell short of majority in 2019 assembly polls. Khattar's second stint also saw his government face criticism over farmers' stir against now-repealed farm laws.

During his two stints as chief minister, Khattar was credited with the decision to introduce pre-qualification conditions for the candidates contesting panchavat elections and ensuring transparent recruitment. He also introduced the 'Parivar Pehchan Patra' scheme, under which the Haryana government issues every family a unique family identity.

Khattar was also credited for maintaining cordial relations with ally Jannayak Janta Party. However, JJP's tie-up with BJP ended after Khattar was removed from Haryana CM's post.

On the party's move to bring in Nayab Saini as CM in March, Khattar had said that the move was not sudden and that it was he who had suggested Saini's name to Modi more than a year ago.

"The reality is when I had served as the chief minister for eight to eight-and-a-half years, I myself told Prime Minister Narendra Modi that in any person's life if he hands over the baton to anyone on his own will, there cannot be a matter of greater happiness. I had said this to him about myself more than a year ago," Khattar had said.

major attempt to rid the country of TB by 2025, the Health Department launched the Adult BCG Vaccination Programme at a meeting presided over by district commissioner Aditya Vikram Yadav on Tuesday. The event was attended by the state consultant on TB Eradication Mission. Dr Gautam Buragohain, state immunisation officer, Dr Sabita Das, state cold chain officer, BK Choudhury, immunisation project officer, Dr Minakshi Buragohain, joint director of Health, Dr Saurabh Gogoi, district immunisation officer, Dr Arundhati Bora Hazarika, and other Health Department officials. DC Sivasagar, while inaugurating the programme, assured the Health Department of full cooperation from the administration for successful implementation.

The programme has been launched in two high-prevalence districts of the state, Sivasagar and Lakhimpur.

#### **District commissioner** investigates paddy procurement issues HT Correspondent

MANGALDAI, June 11: On Tuesday, district commissioner Munindra Nath Ngate visited Kharupetia to learn in detail about the sale of paddy from paddy-producing farmers and traders. On this occasion, the farmers also complained about the illegal activities being carried out from time to time by some officers of the Food and Public Supply Department. The farmers informed the district commissioner that currently, government agencies are not buying Boro paddy, and in the future, the paddy that will be purchased by the agencies will need to be of high quality. They expressed concern about who will buy the paddy if the agencies do not purchase it. The farmers and traders requested the district commissioner to facilitate the sale of paddy in the open market at a reasonable price without any departmental oppression.

The district commissioner, along with the additional commissioner. departmental officials, agriculture department officials, and the incharge of the paddy purchasing center, inspected every point in the paddy market. While speaking to the media, the district commissioner stated that a report will be sent to the chief secretary of the state, and action will be taken based on the instructions received from the chief secretary. Although the district commissioner did not explicitly criticise the Food and Public Distribution Department, he indirectly expressed his displeasure with their operations and showed silent approval in favour of the farmers. It is noteworthy that, with the aim of doubling the income of farmers, the BJP government set the minimum price for many agricultural commodities, including paddy. In this effort, the minimum support price of paddy was set at ₹ 2183, and various government agencies were engaged in purchasing paddy. These agencies are also ensuring timely purchase and transferring money to the farmers' bank accounts within 48 hours.



Providing details of the programme on Monday, Dr Saurov Kumar Gogoi, the joint director of Health and FW Department, stated that the BCG vaccination would be administered to people above 18 vears since the BCG vaccine administered to babies is effective only until that age. Priority will be

given to people with diabetes and tobacco consumers as they are more susceptible to TB infection. Dr Gogoi expressed confidence that the new programme would eliminate the disease by 2025, as envisioned by Prime Minister Narendra Modi.

Dr Dwijen Koch, district TB of-

ficer, Sivasagar, mentioned that a total of 152,783 registered TB patients in the district will be brought to seven designated vaccination camps in Kalugaon, Gaurisagar, Morabazar, Kheluwa, Demow, Gelekey, and Wood Urban Centre for vaccination and distribution of beneficiary kits provided by the government. Dr Koch highlighted that despite the best efforts through centrally orchestrated programmes like DoT (Directly Observed Therapy), the disease has spread due to affected individuals' lack of awareness. Many beneficiaries discontinue the medication once they feel better, leading to drug-resistant TB. Dr Koch assured that the BCG (Bacillus Calmette-Guerin) vaccine, first administered to humans in 1921, is safe for all.

The meeting was also attended by Dr Sadhan Borah, sub-divisional health officer, Nazira, Jyotismita Saikia, PPM coordinator, Anjuma Changmai, district community mobiliser, and Anjushree Phukan, district media coordinator.

# Guwahati to host rally for Global Fatty Liver Day

HT Bureau GUWAHATI, June 11: Recognising the seriousness of fatty liver disease and aligning with

the Global Liver Institute, the North East Digestive and Liver Foundation in Guwahati is organising 'Global Fatty Liver Day' on June 13 to raise greater awareness and promote prevention of this silent disease. To mark this occasion, a rally titled 'Run For Your Liver' for greater awareness and prevention of fatty liver is set to be organised on June 13, 2024, from Latasil Playground to Nehru Stadium, Guwahati, at 6:00 am.

Dr BD Goswami, secretary of the North East Digestive and Liver Foundation in Guwahati, informed about the disease, stating, "Global Fatty Liver Day is a public education campaign inaugurated in June 2018 to enhance awareness and emphasise the pressing nature of fatty liver disease, particularly its advanced stages, which impact a staggering 115 million individuals worldwide. Fatty liver disease, and its more advanced form, remain a concealed global epidemic. An estimated 357 million people will be affected by 2030. As symptoms of fatty liver disease are often not overt, it is often under-diagnosed and under-reported. Unchecked, fatty liver disease may lead to cirrhosis, liver cancer, and liver transplant."

Dr Amitava Goswami, senior gastroenterologist in Guwahati, in his address, informed, There are two main types of fatty liver diseasemetabolic dysfunction-associated steatotic liver disease (MASLD) and alcohol-related fatty liver disease (ALD). MASLD, formerly known as nonalcoholic fatty liver disease (NAFLD), is very common in the US, affecting 1 in 3 adults.

While ALD is less common, affecting about 5 percent of people living in the US, and is caused by drinking alcohol."

With ALD and MASLD, there are usually no symptoms. Some people may have signs such as tiredness or pain in the upper right side of the belly where the liver is. If you have MASH or get cirrhosis, you may experience symptoms such as a swollen belly, enlarged blood vessels underneath your skin, larger-than-normal breasts in men, red palms, skin and eyes that appear yellowish due to a condition called jaundice, nausea, weight loss, loss of appetite, tiredness, or mental confusion.

Sharing about the complications of this disease, Dr Amritangsu Borkakoti, gastroenterologist, and hepatologist said, "The main complication of all these conditions is cirrhosis. As your liver tries to stop the inflammation that comes with these conditions, it creates areas of scars. As inflammation spreads, so do the scars, and eventually, your liver can't do its job. That can result in fluid buildup in your belly, swollen veins in your esophagus that can burst and bleed, confusion and drowsiness, an overactive spleen, liver cancer, liver failure, etc.'

If your liver has little or moderate scarring, it shouldn't affect your lifespan. But if you have cirrhosis, it could affect how long you live. If FLD cirrhosis is diagnosed early, you could live another 10 to 15 years. If it is diagnosed late or you have complications, like swelling or fluid in your belly or bleeding in the gut, your life expectancy could be 3 to 5 years unless you get a liver transplant.

Emphasising the importance of lifestyle changes, Dr Utpal Jyoti Deka, gastroenterologist, and hepatologist informed, "One should exercise more. Try to be active for at least 30 minutes a day on most days of the week. If you're trying to lose weight, you might find that it helps to exercise more than this. But if you don't already exercise regularly, get your doctor's approval first and start slowly.

"Get your cholesterol down. Eat a healthy plant-based diet, exercise, and take your medications. This will get – and keep – your cholesterol and your triglyceride levels where they need to be. Manage your diabetes. Check your blood sugar. and take medications as your doctor prescribes," shared Dr Hitesh Kalita, gastroenterologist, and hepatologist.

For MASLD and MASH, it boils down to making good choices - eat healthy food. Choose a plant-based diet with lots of fruits, vegetables, whole grains, and healthy fats. Stay at a healthy weight. Lose weight if you need to. If your weight is healthy, work to maintain it by choosing a healthy diet and exercising. Make exercise a part of your daily routine. Talk to your doctor first if you haven't been active in a while, a PR stated.

#### Govt grapples with Khalistani MP amid Reasi terror attack

The central government finds itself in a difficult position following the election of Sikh separatist Amritpal Singh from Punjab's Khadoor Sahib constituency. Currently held in Dibrugarh Central Jail in Assam, Singh's future remains uncertain as the government deliberates over whether to release him on interim bail or take other actions. The unexpected victory of Amritpal Singh has caught the government off guard. Neither the Union Home Ministry nor the Central Election Commission anticipated a pro-Khalistani winning a parliamentary seat. A prompt official response might have quelled the political speculation, but the government's silence speaks volumes. Top BJP policymakers, preoccupied with forming the new NDA coalition in New Delhi, had little time to address this unforeseen challenge. Simultaneously, the new NDA government is facing serious security concerns. The terrorist attack in Reasi district, coinciding with Prime Minister Narendra Modi's swearing-in, underscores the persistent instability along the Line of Control. The attack, targeting Hindu pilgrims, is widely attributed to Pakistanbased terrorist organizations testing the resolve of Modi's administration.

The BJP, now holding 240 seats after the 2024 Lok Sabha elections, down from 303, faces a significantly altered political landscape. This reduction in seats may impact the government's ability to respond decisively to such provocations. The Reasi attack presents a unique challenge, demanding a strategic and measured response from the Modi administration. Internationally, the new NDA government is under scrutiny from various quarters, including Pakistan, China, the US, and the EU. The Congress party has condemned the Reasi incident, but questions persist about the efficacy of abrogating Article 370, which ended the special status of Jammu and Kashmir. # Need kinder laws for street-vendors navigating urban environment

The economic liberalisation of the 1990s brought with it malls and shopping arcades. However, the timeless allure of traditional marketplaces, deeply ingrained in the collective consciousness of Indian society, persists. A significant part of that allure is individuals who earn a living vending goods, spices, vegetables, clothing, toys and more from movable wooden carts or from pavements, commonly known as 'street-vendors' or 'hawkers' in India.

Their numbers and presence are so visible that no individual residing in or having visited India could claim to have not seen them at work on the busy on of private business, these businesses can add to the comfort and convenience of the general public if properly regulated.

Therefore, the right to carry on such trade could not be denied on the ground that the streets are meant exclusively for passing. In light of the huge influx of people in metropolitan cities in search of livelihood and negligible scope for expansion of roads, the court aptly observed that there was a marked difference between the hullabaloo around vendors occupying spaces and the noise (or lack, thereof) around the ever-increasing vehicular population.

While there is no restriction on the purchase of hicles despite choked roads, the State machinery has always attempted to regulate (more often, curb) such vending. Therefore, moving away from such one-way regulation, it is imperative that the regulation is made so as to harmonise both sets of rights, i.e., the right of commuters to move freely and use roads without impediments under Article 19(1)(d) & the vendors' right to business under Article 19(1)(g).

stitutes 'adjoining areas' in a vending zone provides a loophole for corrupt officials to exploit, perpetuating intimidation and further harassment.

Further, Section 16 of the SV Act 2014 places an unfair burden on such vendors to maintain civic amenities, apart from ensuring that the public property in the vending zone remains in good condition. Although it is incumbent on all residents to ensure

no destruction or damage is caused to public property or civic amenities, the responsibility of maintaining such amenities rests with civic officials. Therefore, such a responsibility cannot be thrust

upon poor individuals trying to make ends meet. Lastly, Section 27 issues a directive stating that no vendor that carries on activities in accordance

streets of a bazaar in urban India. With the burgeoning populations in Tier-I and Tier-II cities the number of street vendors has correspondingly surged to approximately four crores.

An abrupt surge in numbers brings with it several concerns pertaining to the housing capacity of urban spaces, traffic disruptions and related security challenges. Lately, civic authorities in densely populated metropolitan cities, such as Mumbai and Bengaluru. and upcoming metropolises such as Gurugram have intensified raids and eviction drives against streetvendors.

The iconic Banjara Market, a makeshift handicraft market in Gurugram, has been a victim of recurring demolition and eviction drives over the last couple of years, with its inhabitants (predominantly from the Gadiya Lohar community) living in constant fear of being rendered homeless every couple of months.

At the same time, the Municipal Corporation of Delhi (MCD) has recently announced a survey of an estimated five lakh street-vendors in Delhi. The survey was done to ensure arrangements can be made for these street-vendors to set up their shops with dignity at designated locations.

But different state governments have adopted measures that are poles apart in their attempts to deal with the issue. Naturally, it becomes important to understand India's legal framework regarding street-vendors' rights in order to better implement robust safeguards, fostering a business-friendly and rights-based environment for such hawkers, in consonance with principles enshrined under Articles 14, 19(1)(g), 38(2), and 41 of the Constitution of India.

The Supreme Court in Maharashtra Ekta Hawkers Union versus Municipal Corporation of Greater Mumbai provides a broader definition to the term 'street-vendor' as encompassing those persons offering goods for sale to the public at large without a permanent structure or place for such activities, whether stationary on pavements or mobile with pushcarts or baskets on their heads.

Through such an expansive definition, the diverse and dynamic nature of street-vending was recognised, highlighting the adaptability and resourceful ness of vendors navigating urban environments. These vendors have now become integral to the urban economy, serving as crucial links in its supply chain and providing affordable and convenient services to a significant portion of the urban population.

Despite such widespread dependency, these street-vendors have continued to receive raw treatment from the State machinery with ongoing harassment and regular targeting by civic officials. Often, the harassment is a result of the continuous tussles between the vendors' right to conduct business on the roads and the commuters' right to use such roads freely. In an endeavour to strike a balance between these two sets of rights, the Supreme Court in Sodan Singh versus New Delhi Municipal Committee held that though public streets are meant for use by the general public and not laid to facilitate the carrying

In this context, the Street Vendors (Protection of Livelihood & Regulation of Street Vending) Act, 2014 (hereinafter 'SV Act 2014') was enacted with the intent of curbing harassment and victimisation that vendors are often subjected to by local authorities as well as ensuring a regulated manner of vending at designated places.

The Supreme Court was apt in observing that acts of destroying vendors' goods and belongings regularly only prove that "the minions in the administration had not yet understood the meaning of 'dignity' as is enshrined in the Preamble of the Constitution".

While various provisions and the implementation/non-implementation of the SV Act 2014 are of concern, Section 12(2) in particular pertains to the designation of 'no-vending zones' within urban areas by the appropriate government, wherein no individual shall be allowed to carry out vending activities. Unfortunately, such zones are often designated arbitrarily by local authorities, without any or proper consultation with street vending asso-

ciations or aspiring licence-holders. Consequently, many bustling areas of business for street vendors are unjustly marked as 'no-vending zones', necessitating either costly relocations or bribery to sustain operations at the same location or close by.

Moreover, there is a huge disparity between the colossal number of applicants and the number of licences actually issued. To be fair. Section 5 enumerates certain conditions for the issuance of vending licences and certificates.

It requires that every street vendor submit an undertaking that: (1) Such vending shall be carried on by themselves or through any of their family members only. (2) No transfer or renting out of such vending certificate or transfer shall take place. (3) The concerned applicant does not have any other means of livelihood.

Although almost all applicants submit such an undertaking, verifying whether such conditions are being truly met or not is too lofty, even for a highly efficient civic authority.

Practically, there is no possible way of ensuring that such vending is indeed being carried on by the applicants themselves or their family members alone or if the same has been transferred to a third person or whether such vending is their only means of livelihood either.

In addition, Section 15 of the SV Act 2014 mandates vendors to uphold cleanliness and maintain public hygiene in vending zones and adjoining areas, and is susceptible to frequent misuse. The lack of clarity and demarcation of what con-

with the scheme laid out in the SV Act 2014 shall be subjected to harassment by any person, police or other authorities. However, there are no penal provisions that apply in case a person, police personnel or civic official does engage in such harassment, which has become increasingly routine of late.

On the other hand. Section 28 lays down penal provisions with respect to vendors in case they act in contravention of the terms and conditions of the SV Act 2014.

Addressing these multi-faceted challenges, therefore, becomes crucial to safeguarding livelihoods and street vendors' rights without compromising on fostering an inclusive urban development with equitable opportunities for them.

Needless to say, certain basic facilities must be accorded to street vendors in order for them to survive in a dignified manner. Awareness workshops, in collaboration with civil society stakeholders. ought to be conducted so as to ensure that street vendors are aware of their rights and responsibilities under the Act and enacted rules that vary across states.

A significant first step would be a large-scale registration drive to be conducted in different cities, as any policy decision meant to benefit such vendors ought to be firmly rooted in statistics and data-driven sets.

The recently-launched Prime Minster Street Vendors' Atmanirbhar Nidhi Scheme (PM SVANidhi Scheme) under the Ministry of Housing and Urban Affairs, can provide a solid base for the same with ±65 lakh vendors already on-board for disbursement of collateral-free micro-credit loans valued at over Rs. 8,600 crore, an incentive measure that has the potential to create a positive impact on the living conditions of street vendors with easier credit access. At the same time, it must also be understood that merely drafting appropriate laws would inevitably fall short of addressing many challenges faced by street vendors.

These must be accompanied by social interventions that directly target the underlying issues and grievances, affecting the authorities as well as the street vendors themselves.

A concerted effort must be made to implement provisions outlined in Section 32 of the SV Act 2014, particularly capacity-building initiatives, and education and training programmes.

In this vein, measures such as sensitisation training for civic and police officials to enhance their understanding of street vendors' rights, sensitive and uniform eviction policies with relocation provisions, fair opportunities for hearing before eviction Orders are passed, and clear, time-bound process to designate vending zones can significantly enhance prospects and mitigate conflicts.

By embracing these proactive measures, stakeholders can collectively work towards ameliorating the socio-economic conditions of street vendors on a broader scale, fostering inclusivity and sustainable urban development. (IPA Service)

At certain junctures, the electorate has momentarily strayed from the path of secularism, only to swiftly recognize its misstep and reject the fusion of religion and politics at the polls. During the 2024 general elections, the BJP predominantly focused on religious and emotive issues, sidelining critical concerns affecting the broader public, such as inflation, unemployment, farmer grievances, and the challenges faced by the underprivileged. The BJP, rooted in the principles of Hindutva, viewed the construction of the Ram temple in Ayodhya as a pivotal national endeavor, anticipating it would secure them a resounding electoral victory. Despite past instances where the electorate leaned towards the Hindutva narrative, this time, even though Hindus form a significant majority, they did not sway to it, displaying a discerning approach toward political agendas.

The BJP's loss in Faizabad, encompassing Ayodhya, serves as a striking rebuke to the party's Hindutva-driven aspirations of transforming India into a Hindu-centric nation.

Despite extensive propaganda surrounding the Ram temple, rallying cries to elect the purported facilitator of Lord Ram, and the widespread display of saffron flags adorned with his image, Narendra Modi and his party fell short of their envisioned 370-seat victory. The electorate's verdict has underscored the fallibility of even the most seemingly invincible figures. While Modi, once hailed as an unrivaled leader without equal, has clinched reelection from Varanasi, the narrow victory margin belies his considerable popularity and dominance. The electorate's decision unmistakably rebukes Modi, as the election centered more on his persona than the party's platform. In line with the nation's sentiment, Modi should have gracefully conceded the prime ministerial position. However, such a move requires the moral compass of an ethical leader or statesman, qualities he lacks.

With Modi set to assume office as Prime Minister of India once more, the road ahead promises to be arduous. Like cowards facing repeated demise, narcissists and authoritarian figures endure countless trials when confronted. Modi and his party lack an outright majority in the Lok Sabha, relying instead on coalition partners within the National Democratic Alliance, notably the Telugu Desam Party and Janata Dal (United) led by Chandrababu Naidu and Nitish Kumar, respectively.

Naidu and Nitish Kumar, both seasoned politicians renowned for their adept administrative skills, pose a formidable challenge to Modi's traditional autocratic style. Having wielded significant influence over the central cabinet for a decade, Modi's unilateral decision-making may face resistance. Their presence, whether within the cabinet or through influential party representatives, ensures a more collaborative approach, where decisions are made collectively rather than unilaterally.

Reports suggest that both NDA allies are pushing for significant concessions, potentially including prime ministerial roles for their respective parties. Should the BJP accede to these demands, ministers appointed from these parties may not unquestioningly comply with Modi's directives. Instead, their allegiances may lie more strongly with their own leaders rather than with Modi, a departure from the typical loyalty displayed by BJP cabinet members. This dynamic could render Modi a figurehead prime minister, with Nitish and Naidu effectively wielding control.

Modi's accustomed practice of self-promotion through government-funded advertisements will likely face constraints in his new term. No longer will he wield unchecked authority to claim credit for every government initiative. With accountability to the significant NDA partners, TDP and JDU, Modi's autonomy will be curbed. Consequently, BJP ministers may feel emboldened to voice dissenting opinions during cabinet deliberations. During parliamentary sessions, a robust Opposition will provide a stark contrast to the relatively subdued environment witnessed during Modi's earlier terms as Leader of the House. This heightened presence of dissenting voices will likely curtail the ruling party's ability to engage in disruptive antics or jeer at Opposition members.

There's speculation that the Speaker of the Lok Sabha might hail from the TDP or JDU, presenting a departure from the perceived partisanship observed during Om Birla's tenure as Speaker in the previous Lok Sabha.

In his third term as prime minister, Modi will helm a potentially precarious government, despite the numerical advantage of the NDA. Historical tensions between the BJP and leaders like Naidu and Nitish suggest underlying discord within the alliance. Given the slightest pretext, Naidu and Nitish may swiftly sever ties with the coalition and align with other political entities to safeguard their hold on power. Considering these circumstances, it wouldn't be unexpected to witness a more tempered version of Modi. Even in the wilderness, the mightiest of creatures resort to consuming vegetation. the season of excessive sweating and body odour. With the heat and humidity rising every day, being sweaty and smelly is a big fear for many people. Body odour is a common concern for both men and women as our bodies start sweating in response to hot and humid weather conditions. However strong body odour can negatively affect your quality of life, making you feels embarrassed, self-conscious, and even ashamed. Body odour, although it can be embarrassing and uncomfortable, is a completely natural part of being human. Our body produces approximately 1 litre of sweat a day.

Sweating plays an important role in maintaining the body temperature. Higher temperatures signal the body to release sweat as a cooling mechanism. As perspiration evaporates, it cools your body temperature.

Sweating by itself doesn't cause body odour as human sweat is odourless. Sweat that comes from apocrine glands, which are found in your armpits, public region, and groin, is high in fats and other compounds that produce odour as they're broken down by the bacteria on your

skin. As you sweat, these bacteria break down proteins in vour sweat into acids. producing those unmistakable, pungent smells. Excessive sweating which

known as hyperhidrosis could be caused due to stress, physical exercise, emotional excitement, diet, hygiene standards, heredity hormonal imbalance and high temperature.

#### Here are natural, chemicalfree ways to manage body odour:

Bathing and scrubbing help to clear away germs, dirt and odour. All parts of the body must be washed well, especially the neck, armpits and feet. These are the areas where germs accumulate and cause odour. Adding cologne to the bath water leaves the body fragrant. Colognes also have a cooling effect. Shower gels and body shampoos, containing natural ingredients, like sandalwood, rose and khus have

a cooling and refreshing effect. They are not only natural coolants but have germicidal and antiseptic benefits. Wear cotton underwear and clothes during the humid season. Porous materials help sweat to evaporate. Loose, light clothing is much more appropriate and comfortable during summer. Daily changes of clothing is, of course, a must. The use of antiperspirants and deodorants does help. Most deodorants are also antiperspirants. A spray, rather than the roll-on deodorants may be more

mild deodorant, as strong builtin antiperspirants can cause skin irritation or sensitive reactions. It is always better to try them out on a small area. on the inner arm, first. If the skin tingles or burns for more than a minute, you should not use it. Some people find the use of talcum powders quite adequate. They absorb perspiration and maintain freshness for some time.

The climate also plays a part in choosing the right perfume. In hot and humid conditions, it is better to go for light, lemony and fresh fragrances, rather than heavy ones. The effect of perfumes intensifies in hot and humid weather. A heavy perfume can be quite overpowering. Lemon, rose, lavender or sandalwood are light and refreshing during hot weather.

Be generous with the use of colognes, even splashing them on. Colognes and Eau de Toilette constitute mainly water, or a mixture of alcohol and water. with only 2 to 5 % perfume. They are lighter and leave a light lingering fragrance.

Colognes can be added to bath water. Or, add eau de cologne to a mug of water and use it as a last rinse. It has a cooling effect

> Bicarbonate of soda (baking soda) helps to prevent body odour. Make a paste of baking soda and water and apply under the arms. You can also add lemon juice to this paste. Leave on for ten min-

You can also add one teaspoon

of alum to your bath water. Crush some mint leaves and add them too.

Rose water can always be added generously to bath water. It is a natural coolant and also fragrant

Add 2 drops of Tea Tree Oil to two tablespoons of water or rose water. Apply this under the arms with cotton wool.

To remove odour from the hair, add the juice of a lemon and half a cup of rose water to a mug of water and use as a last rinse. For excessive perspiration (which can result in body odour), Ayurveda gives some dietary restion Sip "nimbu paani." Sip ginger tea before and after your meals. Chop fresh ginger root finely and mix with a pinch of salt. Chew a little of this before your meal. Sipping warm water with your meal may also help. A light diet and fewer spices are advised. ecently, the National Crime Records Bureau (NCRB) released a troubling insight painting a grim picture of women's safety in India. The latest annual report has revealed a distressing surge of 4% in crimes against women in India throughout 2022. The report further detailed a substantial escalation in reported crimes against women, soaring from 3,71,503 cases in 2020 to 4,45,256 cases in 2022. Compared to 2021's 4,28,278 cases, the 2022 statistics marked a troubling increase.

The stark reality depicted by the above data highlights the relentless surge in crimes against women in India. This not only casts a shadow of fear over women's safety in public spaces but also severely constrains their freedom of movement.

The prevalent threat looms ominously, infiltrating every aspect of their lives, from their ability to pursue education and employment to their basic right to leisure

Moreover, this atmosphere of insecurity severely affects women's capacity to react effectively in times of crisis. perpetuating a cycle of vulnerability and distress.

In 2020, Youth Ki Awaaz and the Observer Research Foundation conducted a survey titled "Women on the move" over ten months before and during the pandemic, with participation from 4,262 women across 140 Indian cities. The survey was primarily conducted to understand Indian women's experiences better using public transport and the impact of safety concerns on their mobility choices.

56% of urban Indian women say that



they were sexually harassed in public transport, but only 2% of them reported

The survey "Women on the move" highlights the alarming prevalence of sexual harassment against urban Indian women in public transport, with a staggering 56% reporting such incidents at some point in their lives.

Despite this prevalent issue, only 2% of these cases were officially reported. Of the 56%, 33% took action themselves, while 33% did not find it safe to take any action, 26% chose to ignore the situation, and 6% sought help from other passengers. This indicates a profound lack of trust in the authorities' ability to handle such matters sensitively and effectively.

While women defending themselves in challenging situations is truly commendable. It is equally important to recognize that women should not bear the sole responsibility of fighting for their safety and the authorities should be there for women in adverse circumstances.

Women not having trust in the authorities and handling harassment on their own might not always work and must not always be relied upon as a

sole means of protection. In many cases, situations involving harassment or violence can escalate quickly, making it difficult for individuals to react appropriately or effectively defend themselves, especially if they are caught off guard or outnumbered by assailants.

Furthermore, relying only on self-defense places the burden of safety solely on the victim, rather than addressing the root causes of harassment and violence or holding perpetrators accountable for their actions.

To encourage more women to report harassment cases, law enforcement must prioritize building trust and offering support to survivors and have a victim-centered approach which means the needs and preferences of survivors are prioritized throughout the reporting and investigation process

The survey also revealed that 30% of women stated congestion (crowd) was the cause for feeling unsafe while using public transport, while 18% women felt the most unsafe at the interchanges (bus stops, train platforms, traffic lights) etc. At the same time about 72% of the

women did not even know the emergency contact numbers for transport

services. This statistic is crucial because it highlights specific areas of concern for women's safety while using public transport.

What can be the way forward

Hence, as stated in the above survey, to make public transportation safer for women, the government can:

· Increase accessibility and approachability of surveillance and monitoring authorities in public transport to address women's safety concerns. Sensitise bus drivers, conductors, and transport authorities to create a safer environment.

• Install CCTVs in key transport junctions to address the lack of surveillance, as cited by 46% of women. This proactive measure can deter perpetrators and provide crucial evidence in case of incidents, enhancing women's confidence in using public transport.

• Improve visibility and accessibility of emergency contact numbers for transport services, as 72% of respondents were unaware of them. Display advertisements warning against harassment alongside emergency numbers and helpdesk information to empower women with essential resources while traveling

• Additionally, ensure clear display of route, fare, and timing information to enhance transparency and reduce misinformation, contributing to women's safety and confidence in using public transport.

• In conclusion, the survey highlights the urgent need for concrete measures to address sexual harassment in public transport. With only 2% of incidents reported, there's a clear imperative to improve safety measures and empower women to feel secure while commuting. (Courtesy: Youth Ki Awaaz)

Femicide: Many countries are making the killing of women a specific crime – here's why it's needed

n average of five women or girls are killed every hour by someone in their own family. according to UN data. And often their murders are intrinsically linked to them being women. Some countries are now passing laws to specifically criminalise femicide – an extreme manifestation of gender-based violence.

The first documented use of the term "femicide" was in an



While no agreed definition of the phenomenon exists,

femicide is broadly defined as the killing of a woman or girl because of her gender. This might be as a result of intimate partner violence or killing in the name of "honour", for example. Since the UN adopted reso-

lution 68/191 in 2013, calling for nations to take action against gender-related killing of women and girls, many high-income countries have

highest form of punishment life imprisonment. Croatia is the most recent country to adopt a dedicated femicide law, making it a standalone offence punishable with a prison sentence of ten years or more. Latin America and the

Caribbean have some of the highest rates of hate killings of girls and women. In response, 18 of the 33 countries in the region have created new legislation classifying femicide as

a distinct hate crime. Costa Rica became the first country to pass a law making femicide a legally defined crime in 2007. A man who murders his wife or partner can be punished with between 20 and 35 years in prison. There are also specific punishments against physical abuse and restriction of movement, in which a partner manipulates

the judge can consider the ity of femicide as an extreme form of gender-based violence but to increase efforts to better respond to it.

One of the main problems is the misclassification of numbers. In many cases, only gender-related killings perpetrated by an intimate partner or family member are counted as femicides.

This leads to under-reporting and invisibility of femicide that happens as part of harmful practices such as female genital mutilation, hate crimes linked to sexual orientation, killing of indigenous women or connections with gangs and other forms of or-


ganised crime. Costa Rica has sought to address this problem by signing into law an extended definition of femicide, which includes femicides perpetuated by those based on a relationship of trust, friendship, authority or power. This is to make it possible to punish crimes against women even if there is no "romantic" relationship between the perpetrator and the victim. Today, Costa Rica has a lower rate of femicide compared with its neighbours. Guatemala, El Salvador and Mexico.

While the social and political circumstances of countries around the world may differ, there are several lessons in combating femicide that are universal.

The term "feminicide" also carries political connotations. In Latin America it is used to refer to a lack of responsiveness from governments in relation to the killings of women and girls.

The idea of femicide emphasises state culpability and inadequate responses to this gender-based violence. This is particularly noteworthy as the rape and murder of women and girls are commonly used as abominable tools of conflict - this has recently been in evidence in Ukraine, for exam-

1801 book by Irish writer John Corry called A Satirical View of London at the Commencement of the Nineteenth Century where it was used to refer to the killing of a woman. The term was brought back in the 1970s by Diana E.H. Russell. a specialist in violence against women, who worked to highlight the magnitude of male violence and discrimination introduced femicide laws.

In 2022, Cyprus integrated femicide into the criminal code as a distinct crime and rendered gender-related killings an aggravating factor when imposing sentences. That same year, femicide was introduced in Malta's criminal code. It can now be considered a motivation of the crime of homicide, and in such cases,

#### Laws are not enough

# Why don't we talk about violence against women in their home?

he recent days have been especially harrowing for the women of our country. The tales of rape that usually hog the headlines have given way to stories of bodies dismembered and disposed of by lovers and partners.

Voices are being raised against interfaith marriages, live-in relationships, working women who are independent or live alone, families that do not know their daughters' friends or fail to support them when they seek escape from brutal surroundings. We are being warned that we can expect a horrible end if we disregard parental advice, insist on a career, have our own home, choose our partner, consort with a person from a different religion or live with a man without going through the formality of a marriage.

What is missing from the debate is the root cause of such horrors-the pervasive domestic violence that women of all classes, incomes, religions and education levels experience throughout their lives in relationships within and outside marriage, often with the full knowledge of families, friends and neighbours.

In India, as in other countries, there are laws to shield us all from violence. Several sections of the Indian Penal Code (IPC) meticulously list out various types of physical and mental assault culminating in culpable homicide that are punishable.

For serious forms of assault (like those which leave recognisable marks on the victim) formal complaints are not necessary; police officers have the authority and obligation to take cog-

criminal. However, no Station House Officer of an Indian police station does this automatically when he learns about assaults on women, even when there is unmistakable evidence.

To compel the police to do its duty, two additional clauses were added to the IPC to punish those who cause "dowry deaths". Section 498A is meant for husbands and their relatives, who cruelly injure their wives, harass them for property or drive them to suicide. And Section 304B defines and penalises "dowry deaths": a death caused by demands for dowry is punishable with minimum jail time of at least seven years extendable to imprisonment for life.

But, these provisions apply only to dead and injured wives subjected to violence by husbands or relatives of husbands in the first seven years of marriage for demands relating to property. Such distinctions exclude relationships outside marriage and attacks that take place for other sadistic reasons or beyond the arbitrary limit of seven years; they do not also apply to cruelty within natal families.

Since Indian police stations ignore general IPC clauses when women are assaulted, where do battered women turn for relief from violence?

The legal system has also effectively neutralised the special provisions. The numbers relating to "dowry death" put out by the National and State Crime Records Bureau (NCRB and SCRBs) are patently false. Most women badly injured or killed by husbands and their families are burn victims. Those who commit the crimes rely on the police to conceal them as "kitchen accidents", so that they appear in the tally of "unnatural deaths," but need never be investigated or taken to court.

On the rare occasions that the special provisions were invoked over the many years since the new laws were enacted, hardly anyone has ever been convicted under 498A. The section has today been deliberately devalued. so that it can be used only to trouble innocents (since the section shifts the burden of proof from the prosecution to the accused), shore up statistics and grease the palms of officials.

While listening to the testimonies of ten women who had suffered extensive burns from such violent attacks, I noted that Bangalore city police had scored a perfect ten-not one case had resulted in conviction or punishment of the criminals. Let us face facts: then-Indian women have nowhere to go for protection from violent men.

What is ironic is the predictable public and media reaction to the latest horrors. As usual, the women sufferers, their families and friends, are being blamed for gullibility and inaction. Lawyers, social workers, activists and concerned citizens who are already familiar with such stories have been struggling for decades with indifferent doctors, hostile policemen. brusque prosecutors and insensitive judges

The minimum time for disposal of a case is seven years and conviction rates are deplorable. The criminal justice system is crying out for radical reform, but that's a larger question. It is only realistic to realise that such reform will not come in response to the demands of powerless women's groups, whose tribulations, however well-publicised, do not create political

ripples. We are most troubled by the knowl-

edge that the battered women in the news today had sought help to release themselves from their tormentors, but could not be rescued. They are now being castigated for their dependence on violent criminals. Like rats in a trap, they found no escape door nor a world to escape to.

Must we then wait till the society to which we all belong changes its attitudes and norms? Friends, neighbours and activists in whom such women confide run from pillar to post struggling to help them find a way out of their agonies.

In their innocence, they turn to that magic solution-"the women's help line" run by the same police, who exclude women from legal reliefs. A call for help never results in an FIR and case registration under the IPC, which is what police are paid for.

The buck passes routinely to untrained policewomen, who send the complainant back to the same violent home with gratuitous advice. It is selfevident that counselling and police work are incompatible and must never be tacked together. Yet, this is the only relief offered by women's help lines. Even though, much more is possible from government agencies themselves

Unfortunately, almost nothing is being done on creating awareness and publicity, which are the key to a change in attitudes and behavior. In the past, the government has successfully used wall paintings, hoardings, posters, radio and TV slots to push the message of family planning. Environmental protection and restrictions on popular fireworks displays are also

being promoted by these methods.

A publicity blitz against domestic violence is long overdue to bring the ugly secret into the open. If the practice of using assaults to settle domestic disagreements is shamed and made "uncool", we can instill fear into criminals and confidence in victims. Greater knowledge of the perils underlying relationships and the ways out of them can also help to save lives. Awareness sessions on the topic are essential for girls in high schools and colleges, who are the most vulnerable, just as we already have courses in sex education and training to sensitise children about inappropriate adult behavior. To this must be added information on where to seek help in moments of crisis.

Reform of the police and the criminal justice system will not happen overnight. Some of the initiatives recently begun by the Punjab government (like discouraging the display and use of arms) give hope that change in police attitudes is possible. Even heroic efforts by committed lawyers and social workers have not transformed the police and judiciary into a system responsive to women's complaints. There is, however, one light of hope in the general gloom. Protection Officers appointed under the Protection of Women from Domestic Violence Act of 2005 (enacted through the efforts of lawyers and activists like Indira Jaisingh and Flavia Agnes) do provide relief to a broader range of battered women than the IPC does through counselling, protection orders, legal assistance and escape to shelter homes.

This is the most effective escape route available today but few know

about it as it is not publicised. Far more money should be put into the program to cover the country with services that women in trouble can seek. Shelter homes must be increased exponentially to welcome women and their children, who are often fleeing without funds or the ability and confidence to run their own lives.

Above all, the program must be strengthened by adding a career counsellor who can guide every runaway towards a self reliant and confident future. Repeated domestic violence is prevalent precisely because perpetrators know that victims cannot escape from them, with children to care for and without money or skills to stand on their own feet. When effective methods of fleeing attacks within the home are available and criminals are formally called out for violent behavior, we can deter and reduce domestic violence.

It's a matter of shame that the Central Women's Commission and State Womens' Commissions have consistently ignored their responsibilities in pushing through the programs that can support battered women and break their cycle of dependency. The AAP government in Delhi and its Women's Commission have done nothing to tackle this difficult subject.

They do not need police powers to provide publicity and awareness, to augment the number of Protection Officers and shelter homes and strengthen them with career counsellors or launch schemes to support assaulted and friendless women. What explains the continued indifference of all governments to measures that can bring down violence against women? (Courtesy: The Citizen)

**BLANTYRE, June 11:** Malawi's vice president, Saulos Chilima, was among 10 people killed when a small military plane crashed in a mountainous region in the north of the country, the president said on Tuesday. Chilima was 51.

President Lazarus Chakwera announced in a live address on state television that the wreckage of the plane had been located after a search of more than a day in thick forests and hilly terrain near the northern city of Mzuzu. Chakwera said there were no survivors of the crash.

Former first lady Shanil Dzimbiri, the ex-wife of former President Bakili Muluzi, was also on the plane, the president had said. There were seven passengers and three military crew members onboard.

Office spokesman Jeremy Laurence expressed concerns about possible violations of rules of proportionality, distinction and pre-

caution by the Israeli forces in Saturday's raid at the urban Nuseirat refugee camp. Palestinian health officials sav at least 274 Palestinians, including dozens of women and children, were killed in the operation.

Laurence said Palestinian armed groups who are holding hostages in densely populated areas are putting the lives of nearby civilians and the hostages at "added risks" from the hostilities.

"All these actions by both parties may amount to war crimes," he told a regular U.N. briefing in Geneva. "It was catastrophic, the way

DHAKA, June 11: Lieutenant General Waker-Uz-Zaman was on Tuesday named Bangladesh's next Army chief for a three-year term and will assume charge on June 23, the Defence Ministry said.

Lt Gen Zaman, 58, would concurrently be upgraded to the rank of a four-star general on the day he assumed charge.

"Lieutenant General Waker-Uz-Zaman has been appointed as the Army Chief with promotion as (fourstar) General . . . for three years from the afternoon of June 23," the Defence Ministry said in a statement.

He would succeed General SM Shafiuddin Ahmed after the end of the latter's three-year tenure.

Commissioned as an Infantry Corps officer in 1985, Zaman is now the Bangladesh Army's incumbent Chief of General Staff (CGS).

Under his position as the CGS, Zaman will oversee military operations, military intelligence, United Nations peacekeeping affairs, and budget, alongside other military-related issues.

During his more than three and a half decades of illustrious career. Zaman has an enormous experience in holding key command, staff and instructional appointments, according to the Defence Ministry's Inter Service Public Relations Department (ISPR).

He commanded an infantry battalion, the only independent infantry brigade of the Bangladesh Army, and an infantry division.

As head of the Armed Forces Division, he was directly involved with UN Peacekeeping Affairs of the Bangladesh Armed Forces. He was also nominated as a Gender Champion and Gender Advocate of Bangladesh for UN Peacekeeping Affairs.

By his appointment as principal staff officer, he also headed the Bangladesh National Authority for Chemical Weapons Convention as chairman.

His key staff appointments include staff officer at an infantry brigade, School of Infantry and Tactics and Army headquarters while he was an instructor at the School of Infantry and Tactics, Non-commissioned Officers' Academy and Bangladesh Institute of Peace Support Operations Training.

He is an alumnus of the Bangladesh Defence Services Command and Staff College and Joint Services Command and Staff College of the United Kingdom. (PTI)

Ukrainian military unit with a checkered past KYIV, June 11: The US has removed restrictions on the transfer of American weapons and training to a high-profile Ukrainian military unit with a checkered past, the State Department The move will help the Azov Brigade, among Ukraine's most effective and popular fighting units, move beyond its reputation as a far-right movement, a perception its commanders have been trying to dispel as Russian propaganda. The State Department applied the Leahy vetting process to the Azov Brigade, which has

been absorbed into Ukraine's National Guard as the combat ability of Azov, but most importantly, contribute to the preservation of the lives

Up until the State Department's decision, a provision in the US appropriations law prohibited the Azov from sending fighters to Western military exercises or access weapons bought with American funds. Lifting the ban will likely bolster the brigade's fighting capacity at a difficult time during the war against Russia's invasion. Ukraine suffers from persistent ammunition and personnel shortages.

In the years since Russia's full-scale invasion in February 2022, the brigade has tried to recast its public image away from the controversy surrounding its ultranationalist origins to that of an

effective and skilful fighting force.

Azov soldiers played a key part in the defence of Mariupol, holding out in a siege and low on ammunition for weeks at the southern port city's steel mill despite devastating attacks from Russian forces.

In Ukraine they are hailed as heroes, remembered for defence of the sprawling plant that became a symbol of Ukrainian tenacity in the war against Russia, and people take to the streets for weekly rallies calling for the release of hundreds of Azov POWs who remain in Russian captivity for two years now.

Moscow has repeatedly portrayed the Azov as a Nazi group and accused it of atrocities, but has publicly given no evidence. In 2022, Russia's top court officially designated Azov a terrorist group.

The brigade grew out of a group called the Azov Battalion, formed in 2014 as one of many volunteer brigades created to fight Russiabacked separatists in eastern Ukraine. The battalion drew its initial fighters from far-right circles. While its current members reject accusations of extremism and any ties with far-right movements, the Kremlin has seized on the regiment's origins to cast Russia's invasion as a battle against Nazi influence in Ukraine. # **4 US college instructors** teaching at Chinese university are attacked at a public park

**BEIJING, June 11:** Four instructors from Iowa's Cornell College teaching at Beihua University in northeastern China were attacked in a public park, reportedly with a knife, officials at the US school and the State Department said.

A Chinese Foreign Ministry spokesperson said on Tuesday that the injured were rushed to a hospital for treatment, and that none was in critical condition. Police believe Monday's attack was an isolated incident, based on a preliminary assessment, and the investigation is ongoing, ministry spokesperson Lin Jian said at a daily briefing.

Cornell College President Jonathan Brand said in a statement that the instructors were attacked while in the park with a faculty member from Beihua, which is in an outlying part of the industrial city of Jilin. Monday was a public holiday in China

The State Department said in a statement it was aware of reports of a stabbing and was monitoring the situation. The attack happened as both Beijing and Washington are seeking to expand people-to-people exchanges to help bolster relations amid tensions over trade and such international issues as Taiwan, the South China Sea and the war in Ukraine

An Iowa state lawmaker posted a statement on Instagram saying his brother, David Zabner, had been wounded during a stabbing attack in Jilin. Rep. Adam Zabner described his brother as a doctoral student at Tufts University who was in China under the Cornell-Beihua relationship.

"I spoke to David a few minutes ago, he is recovering from his injuries and doing well," Adam Zabner wrote, adding that his brother was grateful for the care he received at a hospital.

News of the incident was suppressed in China, where the government maintains control on information about anything considered sensitive. News media outlets had not reported it. Some social media accounts posted foreign media reports about the attack, but a hashtag about it was blocked on a popular portal and photos and video of the incident were quickly taken down.

Cornell spokesperson Jen Visser said in an email that the college was still gathering information about what happened.

Visser said the private college in Mount Vernon, Iowa, partners with Bei-hua University. A college news release from 2018, when the program started, says Beihua provides funding for Cornell professors to travel to China to teach a portion of courses in computer science, mathematics and physics over a two-week period.

According to a 2020 post on Beihua's website, the Chinese university uses American teaching methods and resources to give engineering students an international perspective and Englishlanguage ability.

About one-third of the core courses in the programme use US textbooks and are taught by American professors, according to the post. Students can apply to study for two years of their four-year education at Cornell College and receive degrees from both institutions.

Chinese President Xi Jinping has unveiled a plan to invite 50,000 young Americans to China in the next five years, though Chinese diplomats say a travel advisory by the US State Department has discouraged Americans from visiting China.

Citing arbitrary detentions as well as exit bans that could prevent Americans from leaving the country, the State Department has issued a Level 3 travel advisory - the second-highest warning level - for mainland China. It urges Americans to "reconsider travel" to China.

Some American universities have suspended their China programs due to the travel advisory.

Lin, the Foreign Ministry spokesperson, said China has taken effective measures to protect the safety of foreigners. "We believe that the isolated incident will not disrupt normal cultural and people-to-people exchanges between the two countries," he said. (AP)

# SKorean troops fired warning shots after NKorean soldiers briefly crossed land border

SEOUL, June 11: South Korean soldiers fired warning shots after North Korean troops briefly violated the tense border earlier this week, South Korea's military said on Tuesday, as the rivals are embroiled in Cold Warstyle campaigns like balloon launches and propaganda broadcasts.

Bloodshed and violent confrontations have occasionally occurred at the Koreas' heavily fortified border, called the Demilitarized Zone

While Sunday's incident happened amid simmering tensions between the two Koreas, observers say it won't likely develop into another source of animosity as South Korea believes the North Koreans didn't deliberately commit the border intrusion and North Korea also didn't return fire.

At 12:30 p.m. on Sunday, some North Korean soldiers who were engaged in unspecified work on the northern side of the border crossed the military demarcation line that bisects the two countries, South Korea's Joint

The statue was stolen from a temple in Tamil Nadu Oxford University to return stolen 500-year-old bronze idol to India

LONDON, June 11: The UK's prestigious Oxford University has agreed to return a 500-yearold bronze idol of a saint believed to be stolen from a temple in Tamil Nadu to India.

"On 11 March 2024, the Council of the University of Oxford supported a claim from the Indian High Commission for the return of a 16th-century bronze sculpture of Saint Tirumankai Alvar from the Ashmolean Museum. This decision will now be submitted to the Charity Commission for approval," said a statement from the university's Ashmolean Museum.

The 60 cm-tall statue of Saint Tirumankai Alvar was acquired by the Ashmolean Museum at the University of Oxford from Sotheby's auction house in 1967 from the collection of a collector named Dr J R Belmont (1886-1981). The museum says that it was alerted to the origins of the

An estimated 2 million mines are peppered inside and near the border, which is also guarded by barbed wire fences, tank traps and combat troops on both sides. It's a legacy of the 1950-53 Korean War, which ended with an armistice, not a peace treaty.

On Sunday, South Korea resumed anti-Pyongyang propaganda broadcasts from its border loudspeakers in response to the North's recent launches of balloons carrying manure and rubbish across the border. South Korea said North Korea has installed its own border loudspeakers in response but hasn't turned them on vet.

North Korea has said its balloon campaign was in response to South Korean activists' launches of their own balloons to drop propaganda leaflets critical of leader Kim Jong Un's authoritarian rule, USB sticks with Kpop songs and South Korean drama shows, and other items in North Korea.

North Korea is extremely sensitive to any outside criticism of its political system as most of its 26 million people have no official access to foreign news. On Sunday night, Kim's sister and senior official, Kim Yo Jong, warned of "a new response" if South Korea continued its loudspeaker broadcasts and refused to stop civilian leafletting campaigns.

The tit-for-tat over speakers and balloons both Cold War-style psychological warfare have deepened tensions between the Koreas as talks over the North's nuclear ambitions have remained stalled for years. (AP)

# A migrant boat sank off the coast of Yemen, leaving at least 49 dead and 140 missing, UN agency says

CAIRO, June 11: A boat carrying migrants sank off the coast of Yemen, leaving at least 49 dead and 140 missing, the U.N.'s International Organization for Migration said on Tuesday.

The boat was carrying some 260 Somalis and Ethiopians from the northern coast of Somalia on the 320-kilometer (200-mile) journey across the Gulf of Aden when sank Monday off Yemen's southern coast, the IOM said in a statement.

It said search efforts were continuing and so far 71 had been rescued. Among the dead were 31 women and six children, it said.

Yemen is a major route for migrants from the East Africa and the Horn of Africa trying to reach Gulf countries for work.

Despite a nearly decadelong civil war in Yemen, the number of migrants arriving annually tripled from 2021 to 2023, soaring from about 27,000 to over 90,000, the IOM said last month. Around 380,000 migrants are currently in Yemen, according to the agency.

To reach Yemen, migrants are taken by smugglers on often dangerous, overcrowded boats across the Red Sea or Gulf of Aden.

In April, at least 62 people died in two shipwrecks off the coast of Djibouti as they tried to reach Yemen.

The IOM said at least 1,860 people have died or disappeared along the route, including 480 who drowned.

Monday's sinking "is another reminder of the urgent need to work together to address urgent migration challenges and ensure the safety and security of migrants along migration routes," said IOM spokesperson Mohammedali Abunajela. (AP)

# UCC part of our agenda: Meghwal

NEW DELHI, June 11: Union Law Minister Arjun Ram Meghwal on Tuesday said the implementation of a uniform civil code was part of the government's agenda. He also said a solution will be found on the issue of memorandum of procedure -- a set of documents on the

appointment, elevation and transfer of high court and Supreme Court judges -- pending finalisation. He also rejected suggestions that there was a conflict between the executive and the judiciary.

Meghwal on Tuesday assumed charge as the minister of state (independent charge) for the ministry of law and justice. He held the same portfolio in the previous Modi

government too. Responding to a question on key vacancies in his ministry, he said wherever there are vacancies, be it the Supreme Court, high court or our ministry or the subordinate courts, we will try to fill them at the earliest.

On the issue of simultaneous polls, he said the committee under former president Ram Nath Kovind has submitted its report and we will inform about it later.

He noted the law commission is also working on the subject.

Before the law panel could submit its report, its chairperson Justice (Retd.) Ritu Raj Awasthi moved to Lokpal as a member

Responding to a question on the uniform civil code, he said that it was part of the government's agenda.

The uniform civil code has remained a part of the ruling BJP's successive manifestos.

Responding to a query on memorandum of procedure, Meghwal said it is pending and the government has written to the SC collegium on it. "I believe that we will certainly find a solution to it," he said.

Addressing the issues of vacancies in the higher judiciary and pending cases, and finalising the Memorandum of Procedure are the key challenges before Meghwal.

According to data shared by the government with Parliament, over five crore cases are pending across courts -- the lower courts, the 25 high courts and the Supreme Court.

There are various reasons for the rising pendency but one of the key reasons is vacancies in the judiciary.

As on June 1, while there are two vacancies in the top court, the posts of 345 judges are vacant in the high courts.

While the sanctioned strength of the apex court is 34, the 25 high courts have a combined sanctioned strength of 1,114. Another key issue which Meghwal will have to handle is the finalisation of the memorandum of procedure (MoP).

Seeking to replace the Collegium system of appointments of judges of the Supreme Court and the high courts with a more transparent appointment mechanism, the government had brought into operation the Constitution (99th Amendment) Act, 2014 and the National Judicial Appointments Commission Act, 2014 effective April 13, 2015. The new law was passed by the Parliament with near unanimity.

However, both the Acts were challenged in the Supreme Court which in October, 2015 declared the Acts as unconstitutional and void.

The Collegium system as existing prior to the enforcement of the two Acts was declared to be operative.

The top court issued an order on supplementing the MoP, saying the government may finalise the document supplementing it in consultation with the chief justice of India.

It was laid down that the chief justice of India will take a decision based on the unanimous view of the Collegium comprising four senior-most judges.

Despite a series of back and forth between the government and the top court, the MoP's finalisation remains pending. (PTI)

#### Jailed J'khand minister **Alamgir Alam resigns** from state cabinet

RANCHI, June 11: Jharkhand minister Alamgir Alam, who is in jail in connection with a money laundering case, has resigned from the state cabinet and also as the leader of the Congress Legislature Party (CLP), an official said on Tuesday.

In a letter to Chief Minister Champai Soren from Birsa Munda Central Jail, Ranchi, Alam tendered his resignation as a cabinet minister, he said.

Alam, in another letter to AICC chief Mallikarjun Kharge, said, "I hereby submit my resignation from the post of leader of Congress Legislature Party, Jharkhand. I shall remain grateful to the party leadership for providing me an opportunity to work and serve as CLP leader."

The Enforcement Directorate had on May 15 arrested the Congress leader in a money laundering case, days after about Rs 32 crore cash was seized from premises linked to his aide.

The opposition BJP in the state last week demanded the removal of Alam from the Champai Soren cabi-

A BJP spokesperson alleged, "The JMM-led alliance's corruption saga has been exposed before the nation. Alam is accused of a huge tender scam where he and his coterie fixed tenders in lieu of favours. He had crossed all limits of political decency by not resigning ... NEW DELHI, June 11: The Lok Sabha poll results have come as a reality check for "overconfident" BJP workers and many of its leaders as they were happy in their "bubble" and enjoying the glow of Prime Minister Narendra Modi's aura but not listening to the voices on the streets, an RSS-linked magazine has said.

An article in the latest issue of 'Organiser" magazine also noted that though the Rashtriya Swayamsevak Sangh (RSS) is not a "field force" of the BJP, the party leaders and workers did not reach out to its 'swayamsevaks' (volunteers) seeking their cooperation in electoral work.

Neglect of older dedicated workers who worked without the urge for recognition by the new age social media-aided selfie powered activists was also evident in the poll results, it said.

'Results of 2024 general elections have come as a reality check for overconfident BJP karyakartas and many leaders. They did not realise that Prime Minister Narendra Modiji's call of 400 plus (seats) was a target for them and a dare to the Opposition," Ratan Sharda, a life-long member of the RSS, noted in the article



Sharda noted that the idea that Modi was fighting on all 543 Lok Sabha seats had "a limited value". "This idea became self-defeating when the candidates were changed, imposed at the cost of local leaders and defectors given

more importance. Sacrificing even well performing parliamentarians to accommodate late comers hurt.It is estimated that around 25 percent of candidates were seasonal migrants," he said. "This happened despite the shocking experience of 30 per cent rebels in the last Himachal Pradesh elections that resulted in defeat of the BJP. Local issues, track record of the candidate does matter, one can see.Disinterest of local BJP workers was due to this factor too," he added. Sharda, who has authored many books on the RSS, also flagged "unnecessary politicking" as one of the many reasons behind the BJP's underperformance in the Lok Sabha polls. "Maharashtra is a prime example of unnecessary politicking and avoidable manipulations. NCP faction led by Ajit Pawar joined BJP though BJP and split SS (Shiv Sena) had a comfortable majority. Sharad Pawar would have faded away in two-three years as NCP would have lost energy with infighting between cousins," he said. "Why was this ill-advised step taken? BJP supporters were hurt because they had fought against this Congress ideology for years and were persecuted.In a single stroke, BJP reduced its brand value. After years of struggle to become numero uno in Maharashtra, it became just another political party without any difference," he added. The BJP fared poorly in

nine seats compared to the 2019 tally of 23 constituencies out of the total 48.

The Shiv Sena led by Shinde faction bagged seven seats and Ajit Pawar-led NCP just one. Without naming any leader, Sharda said the induction of Congressmen into the BJP, who had "actively promoted" the bogey of saffron terror and persecuted Hindus and also called 26/11 'RSS ki sazish' and branded RSS as a terrorist organisation, showed the BJP "in poor light" and also hurt the RSS sympathisers "immensely".

On the question of whether the RSS worked for the BJP in this election or not, Sharda said, "Let me say bluntly, RSS is not a field force of BJP.In fact, BJP, the biggest party in the world, has its own karvakartas".

He said routine electoral work of reaching out to voters, explaining the party's agenda, distributing literature and voter cards are the responsibility of the party.

"The RSS has been raising awareness among the people about issues that impact them and the nation. Except during the 1973-1977 period, RSS has not taken part directly in politics," he said.

"This time, too, it was officiall

#### People of Ayodhya corrected temple politics Modi govt will continue to balance development and environment protection: Bhupender Yadav by defeating BJP candidate Sharad Pawar

NEW DELHI, June 11: The Modi government will continue to balance development with environmental protection and conservation. Bhupender Yadav said on Tuesday after taking over as Union Environment minister.

Yadav's role as Environment minister will be crucial as India proposes to host the international climate talks (COP33) in 2028. If accepted, it would be the next major global conference in India after the G20 Summit last year.

Listing the major achievements of the Modi-led government, which enters its third consecutive term, he said, "India met the quantitative and qualitative targets set under its Nationally Determined Contributions (NDCs) - the national climate plan to achieve Paris Agreement goals - nine years ahead of schedule.

"Our achievements in emission reduction and the renewable energy sector are significant milestones of the Modi government over the past decade," Yadav told reporters.



The minister, who also expressed satisfaction with the progress of the cheetah project, said Prime Minister Modi launched Mission Life at COP26 in Glasgow to promote mindful consumption of resources and called upon people to plant one tree each in the name of their mother to address rising tempera-

tures, desertification, and biodiver-

sity challenges. "Both planting trees and protecting them are important," he said. He said that India marked 50

years of Project Tiger and 30 years of Project Elephant last year and initiated the MISHTI programme to protect mangrove ecosystems.

According to Yadav, India has implemented crucial reforms in the environment sector and launched several key initiatives such as the International Solar Alliance, Coalition for Disaster Resilience and Infrastructure and International Big Cat Alliance.

India achieved two quantifiable targets under its first NDCs -- reducing GDP emissions intensity by 33 to 35 per cent by 2030 from 2005 levels, and achieving 40 per cent installed power capacity from non-fossil fuels by 2030. Both were ahead of schedule.

The country now aims to reduce emissions intensity of GDP by 45 per cent by 2030 from 2005 levels and achieve 50 per cent cumulative electric power installed capacity from non-fossil fuel-based energy resources by 2030.

It has also committed to becoming a net-zero economy by 2070.

Kirtivardhan Singh, the BJP MP from Gonda and a first-time minister in the Modi government, has been appointed Union minister of

state for Environment.

Yadav, who took over as Environment minister from Prakash Javadekar in the second Modi government in July 2021, defended India's dependence on coal at international climate talks in Glasgow and Dubai. He previously served as the Union Labour and Employment minister, a portfolio now allotted to Mansukh Mandaviya.

Under Yadav's leadership in the Environment ministry, India's climate actions were rated the fourth strongest in an annual performance index released by Germanwatch in 2023, an improvement of one place from the year before.

His accomplishments also include a ban on identified single-use plastic items, and an increase in Ramsar sites – wetlands of international importance - in India.

The country made significant amendments to forest, wildlife, and environmental laws during his previous term, some of which drew criticism from opposition parties and environmentalists. (PTI)

# DU modifies teacher recruitment criteria

NEW DELHI, June 11: The Delhi University has modified its eligibility criteria for the recruitment of assistant professors in colleges, introducing an additional layer of "presentation".

The move has drawn flak from the teachers' community which has demanded a rollback.

The varsity has raised its minimum eligibility from the earlier 50 to 55 points with a relaxation of five points for SC/ST/PwD candidates in its recently notified Standard Operating Procedure (SOP) for teacher recruitment.

As per the new rules, the process for the final selection of candidates will be conducted in two stages assessment through presentation and interview with the selection committee.

The presentation will be assessed based on several factors, including "humility, passion and zeal for teaching," the notification read. Candidates will also be asked to write an essay on the day of the presentation for the assessment of their writing skills, the June 3 notification said.

The varsity has also made changes in the weightage given to different components used in the assessment of the candidates.

"Objective parameters such as academic record, experience and research performance have been clubbed together for 20 points in the 100 points marker while subjective parameters have been given high weightage making the assessment highly arbitrary," Maya John, a member of the varsity's Academic Council. said.

The faculty member, who called the change arbitrary and the rationale behind it unclear, said the new SOP must be opposed as it will restrict the number of applicants.

"Far from a coincidence, the new DU guidelines have surfaced in the light of growing criticism regarding the quality of ongoing interviews and the resulting displacement of many long-serving ad hoc teachers," she added.

Abha Dev Habib, the secretary of the Democratic Teachers' Front, demanded the SOP be rolled back, saving no new criteria for selection should be introduced when the selection process is underway.

"The SOP issued is against the interests of serving teachers as it reduces the number of candidates who can appear before the Selection Com ees. Appointm

# Fire at Park Street restaurant in Kolkata, no one injured

KOLKATA, June 11: A major fire broke out in a restaurant in the Park Street area of central Kolkata on Tuesday, triggering panic among local people, an official said.

No casualty was reported in the incident, he said.

At least nine fire tenders were pressed into service to douse the blaze, which was first spotted around 10.50 am, the official said, adding that a disaster management team was also deployed.

The fire broke out at the restaurant adjacent to a multi-storied building on Park Street. Thick smoke and flames were seen billowing from the higher floors of the structure, a part of which was covered with tin sheets that got destroyed. People from nearby residential buildings and offices came out on the street in fear.

Firefighters managed to bring the blaze under control, and they are still working as the cooling-off process is underway, Fire and Emergency Services Minister Sujit Bose said.

The cause of the fire will be ascertained after a forensic investigation, he said, adding that the authorities will examine whether the restaurant owner had followed safety regulations or not.

Asked about the part of the structure built with tin sheets, Bose said the fire services department doesn't have any say in it. (PTI)

### Sule inspects rain-hit areas of Pune, slams govt over neglect of infrastructure



PUNE, June 11: NCP (Sharadchandra Pawar) MP Supriya Sule on Tuesday visited areas of the city that had faced waterlogging and other rain-related problems last week, and claimed that the government was not responsive enough.

The Baramati MP visited Model Colony, Sinhgad Road, Wadgaon and Katraj localities. The city was lashed by torrential rains on Saturday evening with Shivajinagar area receiving more than 100 mm of rain between 5.30 pm to 8.30 pm.

Speaking to reporters, Sule said the city was facing multiple crises including rising crime, but the administration's response was inadequate. "On the one hand, crime is increasing, drug-related crimes are taking place, and on the other hand there is a complete collapse of administration and infrastructure," she claimed.

Pune was part of the Union government's Smart City project but rainwater was entering people's houses due to encroachments, Sule said, demanding action against encroachments on water bodies.

"Pune residents pay their taxes and now they are asking for accountability over the collapse of infrastructure," the NCP (SP) MP said, adding that she was going to meet the municipal commissioner and discuss these issues. "Someone has to speak, as everybody is busy breaking up political parties and families. Now that they have got less seats in the Lok Sabha (compared to the last time), they will be busy increasing the count. They have time to increase their count but not for the people who vote for them," Sule said, taking a swipe at the BJP and ruling Mahayuti alliance in Maharashtra.

The BJP was in power in the civic body (before the term of its general body ended and an administrator was appointed), she noted. (PTI)

### Two minor siblings raped, blackmailed for six months; 2 held

NOIDA, June 11: Two minor siblings were allegedly raped and blackmailed for money for over six months by two men in Greater Noida, police said on Tuesday.

The two accused -- Rahul (23) and Suraj (25) -- were arrested on Monday, a day after the girls' father approached the local Beta 2 police station with a complaint leading to the registration of an FIR in the case, they said. The two men had raped the siblings and videographed the acts, they said. pect the Pakistani terrorists are hiding in the mountainous terrains of Rajouri and Reasi and have intensified combing operations in the region. They are taking directions from Pakistan's ISI through secured communication, the sources said. There are reports that four terror-

ists including a local overground worker were involved in the attack which was carried out on the directions of Lashkar-e-Taiba commander Abu Hamza, they said.

# Climate change-fuelled extreme weather events cost at least USD 41 bn globally since COP28

NEW DELHI, June 11: As millions of people in India grapple with blistering heat intensified by climate change, a new report has said extreme weather events have caused over USD 41 billion in damages globally since the international climate talks in Dubai (COP28) in December last year.

The report by the UK-based NGO Christian Aid said four extreme weather events in the past six months -- all scientifically shown to have been made more likely and/or more intense by climate change -killed over 2,500 people.

The non-profit organisation said insufficient progress has been made since COP28 in the UAE to move away from fossil fuels or to support lower-income countries in coping with climate disasters.

As the second week of mid-vear climate talks in Bonn began on Monday, it said these numbers demonstrate that the costs of the climate crisis are already being felt.

"Rich countries, responsible for the lion's share of the greenhouse gases that are heating the atmosphere and fuelling extreme events, should recognise their historic responsibility and increase their funding to the Loss and Damage Fund to help other countries cope with and recover from extreme weather," Christian Aid said.

Delegates at the UN climate negotiations in Dubai in December agreed on a new loss and damage fund to address the impacts of climate change disproportionately affecting poor communities in the Global South

The USD 41 billion in damages is an underestimate, according to the charity. Only insured losses are typically reported, and many of the worst disasters have occurred in countries where few people or businesses have insurance, the report said. The human cost of disasters is also not fully captured in these figures, it added

According to the report, floods that killed at least 169 people in Brazil and caused at least USD 7 billion in economic damages were



made twice as likely by climate change

In South and Southwest Asia, flooding that killed at least 214 people and caused USD 850 million in insured damages in the UAE alone was also made more likely by climate change, it said.

Simultaneous heatwaves in West, South, and Southeast Asia killed over 1,500 people in Myanmar alone, with heat deaths notoriously underreported, the report said. The report said the heatwave is expected

to slow growth and increase inflation, and in Southeast Asia, it would have been completely impossible without climate change. In South and West Asia, it was made five and 45 times more likely, respectively, and also hotter. Flooding from cyclones in East Africa killed 559 people and was made about twice as likely and also more intense by climate change, it said.

"We cannot heal the burns caused by the climate crisis while we are still throwing fossil fuels on the fire," Mariana Paoli, Christian Aid's Global Advocacy Lead, who is from Brazil, said

"We need rich countries, who are largely responsible for causing the climate crisis, to massively scale up funding for climate action. They need to show real creativity and political will, and tax polluters and the super-rich to finance genuine climate action. We need to cancel historic debt owed to rich countries by poor ones, and instead ensure that money is used to improve climate equity, helping everyone to be safer from

climate disasters," Paoli said. The report mentioned that countries in 2015 agreed to limit global average temperature rise to "well below" 2 degrees Celsius and "preferably" to 1.5 degrees Celsius to prevent further worsening of climate impacts, such as droughts, extreme rain, floods, sea level rise, cyclones, heatwayes etc.

According to the Intergovernmental Panel on Climate Change, a group of leading climate scientists, the world needs to reduce greenhouse gas emissions by at least 43 per cent by 2030 (compared to 2019 levels) and at least 60 per cent by 2035 to limit warming to 1.5 degrees Celsius.

Earth's global surface temperature has already increased by around 1.15 degrees Celsius compared to the average in 1850-1900 due to the rapidly increasing concentration of greenhouse gases -- primarily carbon dioxide and methane -- in the atmosphere. Developing nations argue they cannot be expected to reduce CO2 emissions faster if developed

countries -- historically responsible for climate change -- do not provide enhanced financial support.

An agreement on New Collective Ouantified Goal (NCOG) or a new climate finance goal will be the key issue at the United Nations climate conference (COP29) in Baku, Azerbaijan, in November. (PTI)

NEW DELHI, June 11: Women's pistol ace Manu Bhaker was the only one to be picked in two individual events after her excellent run of form in selection trials as the national shooting federation on Tuesday announced a 15-member Indian rifle and pistol team for the Paris Olympics.

The team was finalised during a selection meeting held virtually. The squad has eight rifle shooters and seven in pistol discipline.

The selectors decided to give precedence to trial results, shutting the door on the likes of world champion Rudrankksh Patil, who has been pleading to be considered despite underwhelming scores in his pet 10m air rifle event as he had won the quota.

In shooting, quotas are won by countries and not individual athletes.

All the team members, along with the coaches and support staff, are currently in a camp in Volmerange-Les-Mines, France, mainly aimed at "acclimatisation and hard-training" before they come back home for a two-week break.

The shotgun squad will be announced after the ISSF World Cup in Lonato, Italy, competitions in which start from Wednesday and go on till June 18. The Paris Games will be held from July 26 to August 11.

Indian shooters managed to secure a record 21 of the 24 possible quotas, including a full allocation of eight each in rifle and pistol events.

This is India's best-ever quota haul in shooting at any edition of the Olympics, eclipsing the 15 from Tokyo Games.

This means the athlete who clinched the quota can be replaced by another, leading up to the Games on the basis of scores in the selection trials conducted by the national federation.

Sharing his thoughts, National Rifle Association of India's (NRAI) senior vice president Kalikesh Narayan Singh Deo, said, "The selection committee met and deliberated at length. After deliberating at length, we feel we have selected the best team on current form as per merit and sticking to the policy.

"We are confident that everything has been put

in place for the team to deliver. Given our depth in rifle and pistol, some very good shooters are not part of the squad. However, they will have a chance to make a comeback. We wish the squad all the very best.'

Deo is right as the performance of the shooters in the trials underlined India's depth and bench strength in rifle and pistol shooting but that is no guarantee for a rich haul at the Olympics.

For proof, one can go back to the Tokyo and Rio Games, where India fielded 12 and 15-member teams and returned empty-handed on both occasions. On behalf of the federation, Deo thanked the Government of India, the Sports Ministry, and the Sports of Authority of India, who have "guided and supported us in every step of the preparations."

Besides all 16 possible shots at a medal, in eight individual rifle and pistol events, India will also have a record five starts across the four individual shotgun events. Additionally, India will also field five mixed teams, two each in rifle and pistol and one in shotgun. (PTI)
