Death toll stands at six •NFR cancels several trains to Barak Valley

State's flood scene grim, 57 seats today, PM Modi in fray over 2 lakh affected

GUWAHATI, May 31: The state's flood situation remained grim on Friday with over two lakh people affected in nine districts, following incessant rainfall in the aftermath of cyclone Remal, officials said.

Altogether six people died in the flood, rain and storms in the state since May 28, they said.

Nagaon, Karimganj, Hailakandi, West Karbi Anglong, Cachar, Hojai, Golaghat, Karbi Angling and Dima Hasao districts were severely affected.

Meanwhile, Union home minister Amit Shah on Friday spoke to chief minister Himanta Biswa Sarma over the phone to enquire about the flood situation in the

VARANASI/CHANDIGARH, May 31: 57 seats across seven states and the Union territory of Chandigarh will go to polls in the seventh and final phase of Lok Sabha elections on Saturday that include Varanasi, from where Prime Minister Narendra Modi is seeking a third consecutive term.

Polling is scheduled in all 13 seats of Punjab and four of Himachal Pradesh, 13 constituencies in Uttar Pradesh, nine in West Bengal, eight in Bihar, six in Odisha and three seats in Jharkhand besides Chandigarh. Polling for the remaining 42 assembly constituencies of Odisha and bypolls to six assembly seats in Himachal Pradesh will also take place simultaneously.

Other prominent candidates among the total 904 contestants in fray are Union minister Anurag Thakur, Mamata Banerjee's nephew Abhishek Banerjee, Lalu



Flood waters pose threat for stock of state's flood situation local residents in Karbi Anglong



HT Bureau **DIPHU, May 31:** Flood waters are still posing a danger to human life particularly to villagers living close to the embankment of Kopili River in West Karbi Anglong district.

Kopili and Bithung Renthama Member of Autonomous Council (MAC) constituencies are the worst affected in West Karbi Anglong. 351 families in Bithung Rengthama MAC constituency and 61 families in Kopili MAC constituency have been affected by flood. Rations like rice, dal and edible oil were being provided to affected families.

Informing the media this morning at his official

bungalow the Chief Executive Member (CEM) of Karbi Anglong Autonomous Council (KAAC), Tuliram Ronghang said he has directed the land and revenue department and officials of KAAC to take a joint survey of affected families in the flood.

CEM said, "The worst affected is my constituency Bithung Rengma and Kopili. So far 351 families in my constituency and 61 families in Kopili have been affected by the floods. We are providing immediate relief measures to the affected families. Each family is being provided with 10 kgs rice, 1 kg dal, 1 litre edible oil and 1 kg. salt."

He also informed that executive members (EMs) of KAAC, MACs and principal secretary of KAAC are involved in the joint survey.

Ronghang further said that the state water resource department has sanctioned a special financial package of 100 crores to check erosion by protecting the embankment of the Kopili River in Bithung and Kopili MAC constituency. Work has already begun, though it has been halted temporarily and will resume after

KAAC CEM refutes allegations Canopy bridges to facilitate easy movement of arboreal species from one part of the railway track to the other inside the wildlife sanctuary of violating MCC NFR to install canopy bridges in

DIPHU, May 31: Chief Executive Member (CEM) of Karbi Anglong Autonomous Council (KAAC), Tuliram Ronghang has refuted the allegation brought by All Party Hills Leaders Conference (APHLC) president and APHLC backed independent candidate, JI Kathar that the BJP has violated the model code of conduct by withdrawing ₹ 14 crores from the panchayat and rural development department for a tour to Vietnam.

After the conclusion of the second phase of elections in 6 – Diphu (ST) parliamentary constituency on April 26, the KAAC team comprising of the chief executive member, executive member (EMs), member of autonomous council (MACs), KAAC officials and BJP party members had gone for a tour to Vietnam. It was an eight day tour from May 13 to 20.

Clarifying on the issue, the CEM said, "Every year budget allocation is made in the agriculture, forest and tourism department for a study tour to different places and countries to know about how agriculture and tourism are developed. This year also I have sanctioned ₹ 3 crores for a study tour. The first group went to Vietnam to know about the agricultural revolution taking place there and how tourism is being promoted. The whole expenditure has not crossed more than ₹ 1.5 crores. The second group will go now." "How can Kathar say KAAC has withdrawn ₹ 14 crores for Vietnam tour. He knows nothing about KAAC,"

Hollongapar Gibbon Sanctuary GUWAHATI, May 31: The Northeast Frontier Railways (NFR) will install canopy bridges over railway tracks inside the Hollongapar Gibbon

Sanctuary in Jorhat district to facilitate

the movement of the endangered Hol-

lock Gibbon

Railway tracks pass through the wildlife sanctuary, which at times obstruct in the movement of these highly arboreal species. The NFR in consultation with the state forest department, Wildlife Institute of India and all stakeholders will soon be installing canopy bridges at several identified points of the sanctuary to ensure the easy movement of the apes from one part of the railway track to the other.

"Wherever railway tracks pass through forest area or sanctuaries, the



railway authorities take necessary steps are taken to prevent mishaps. Canopy bridges will soon be installed at strategic points over railway tracks in the Hollongapar Gibbon Sanctuary

for the easy and safe movement of arboreal species inhabiting it," said a senior railway official.

The state forest department has already submitted its design with estimates for installation of such canopy bridges over the railway tracks. The design was prepared by the Wildlife Institute of India in consultation with NFR, which has already deposited the estimated amount in February this

The ends of these canopy bridges as well as the knots will be secured and clamped using appropriate and highgrade fastening materials and techniques. As a fail-safe mechanism, safety nets will be installed below the main twin-rope bridge to save the species from accidentally falling off it. The canopy rope bridges will be installed in such a way that over the long-term lianas and creepers will be guided along them in such a manner as to help them creep and form part of a hybrid (or semi-artificial) design centred around them.

Modi Govt turned around banking sector, over ₹10 lakh cr bad loans recovered in 10 years: FM

NEW DELHI, May 31: Finance minister Nirmala Sitharaman on Friday said the Modi government has turned around the banking sector through various reforms and improved governance which has led to banks recovering more than Rs 10 lakh crore from bad loans between 2014 and 2023.

She said the Enforcement Directorate has investigated around 1,105 bank fraud cases, which resulted in the attachment of Rs 64,920 crore worth of proceeds of crime. As of December 2023, assets amounting to Rs 15,183 crore have been restituted to the Public Sector Banks (PSBs).

"Recently, India's banking sector achieved a significant milestone by recording its highest-ever net profit, crossing Rs 3 lakh crore. The banking sector turned around due to PM Shri @narendramodi's strong and decisive leadership. Our government atoned for the UPA's sins in the banking sector through comprehensive and long-term reforms," Sitharaman said in a post

She said there has been no leniency in recovering bad loans, especially from large defaulters, under the Modi government and the process is ongoing.

with the highest of 19,646 in Hojai, followed by 12,110 in Cachar, 2,060 in Hailakandi and 1,613 in Karimganj. Life came to a standstill in the three districts of Barak Valley and Dima Hasao, while intermittent rainfall and thunderstorms were reported from other affected districts on Thursday, officials said.

In Karimganj, Cachar, and Hailakandi districts, the Barak river and its tributaries Longai, Kushiara, Singla, and Katakhal were flowing above the danger level at several locations, maintaining a rising trend while four embankments were damaged in Karimganj. In Barak Valley's Silchar town, which had witnessed a devastating flood in 2022, several areas have been affected by waterlogging which led to snarl traffic movement.

Life has been hit due to relentless rain in Dima Hasao district, severely impacting road connectivity throughout the district. The Haflong-Silchar road has been completely cut off after a stretch was washed away near Harangajao, while the Haflong-Harangajao route has been blocked by multiple landslides.

Train services, cancelled or short-terminated due to landslides along the Haflong-Badarpur rail route, are yet to be restored, the officials said.

The railway station in Silchar's Tarapur locality, situated close to the river, has been engulfed by the rising waters, disrupting railway operations significantly. According to a spokesperson from the North East Frontier Railway, services to and from Silchar, a crucial hub in Barak Valley, have either been cancelled or short-terminated. The Silchar-Guwahati Express and the corresponding train from Guwahati along with the Silchar-Rangiya Express and the corresponding train from Rangiya will remain cancelled on Friday and Saturday.

Six more trains will remain cancelled on Friday due to high-water level and speed restriction between Jugijan and Jamunamukh of Lumding division, he said. These include Guwahati-Mariani BG Express, Guwahati-Lumding Special, Guwahati-Ledo Intercity Express and its corresponding train from Ledo, Dibrugarh-Guwahati Nagaland Express and Shokhuvi-Naharlagun Donyi Polo Express.

The southwest monsoon has entered Assam and other parts of the Northeast region ahead of its scheduled time due to the effect of cyclone Remal, according to the Indian Meteorological Department.

The Indian Meteorological Department has warned of heavy rainfall and thunderstorms in Goalpara, Bongaigaon, Sonitpur, Biswanath, Dibrugarh, Karimganj, Cachar, Hailakandi, Dima Hasao, Dhubri and South Salmara districts in the next two days. (PTI)

Final phase of Lok Sabha polls in

According to Election Commission guidelines, television channels and news outlets will be able to run exit poll data and its results on June 1 after 6.30 pm.

The EC said polling parties have been dispatched along with machines and poll materials to their respective polling stations. At the 1.09 lakh polling stations, basic facilities including ample shade, drinking water, ramps, and toilets are being provided to ensure that polling takes place in a comfortable and secure environment, it said. The poll panel has also directed CEOs and state machineries to take adequate measures to manage the adverse impact of hot weather or rainfall wherever predicted.

The commission called upon voters to turn out in greater numbers and vote with responsibility and pride. The turnout in the first six phases was 66.14 per cent, 66.71, 65.68, 69.16, 62.2 and 63.36 per cent respectively. The campaigning for the last phase which ended Thursday evening saw BJP leaders led by Modi accusing

the Congress and the INDIA alliance of being corrupt, anti-Hindu and engaging in loot, appeasement and dynastic politics. The Opposition parties have been claiming that the BJP is anti-farmer, anti-youth and will change and scrap the Constitution if they win the elections.

On Thursday evening, Modi headed to Kanyakumari where he is meditating till June 1 at the site associated with Swami Vivekananda. Modi had 206 public outreach programmes, including rallies and roadshows, since the Election Commission announced the Lok Sabha election schedule on March 16.

The parliamentary seats where polling will take place in Uttar Pradesh are Maharajganj, Gorakhpur, Kushinagar, Deoria, Bansgaon (SC), Ghosi, Salempur, Ballia, Ghazipur, Chandauli, Varanasi, Mirzapur and Robertsganj (SC), spread across 11 districts.

Uttar Pradesh is a seeing a direct contest between the BJP-led NDA and the coalition of INDIA bloc members Samajwadi Party and Congress.

From Chandauli, Maharajganj and Mirzapur, Union ministers Mahendra Nath Pandey, Pankaj Chaudhary and Anupriya Patel respectively are contesting. Late Mukhtar Ansari's brother Afzal Ansari is in the fray from Ghazipur and former prime minister Chandrashekhar's son Neeraj Shekhar is contesting from Ballia.

In Varanasi, those contesting against Modi are Ajay Rai (Congress), Ather Jamal Lari (BSP), Kolisetty Shiva Kumar (Yuga Thulasi Party), Gagan Prakash Yadav, (Apna Dal, Kameravadi), and independents Dinesh Kumar Yadav and Sanjay Kumar Tiwari.

The polls in South Bengal, a traditional TMC stronghold, will test the party's dominance amid an 'old versus new' power struggle, with the national spotlight on Sandeshkhali in Basirhat due to allegations of atrocities on women and land grabs

The seventh phase will cover Dum Dum, Barasat, Basirhat, Jayanagar, Mathurapur, Diamond Harbour, Jadavpur, Kolkata Dakshin, and Kolkata Uttar, where the TMC secured victories in the 2019 elections.

TMC heavyweight Abhishek Banerjee, considered the party's de facto number two, is contesting from Diamond Harbour. Banerjee's performance in this seat, which the TMC touts as a 'model constituency', will be closely watched as the opposition attempts to paint it as a 'laboratory of violence'. The two-time MP faces CPI (M)'s Pratikur Rahaman and BJP's Abhijit Das in a three-way contest.

The minority-dominated Basirhat Lok Sabha seat, and specifically the Sandeshkhali segment, is a microcosm of the broader electoral battle as it garnered national attention due to allegations of atrocities on women and land grabs by local TMC leaders. The BJP has capitalised on these issues by nominating Rekha Patra, a prominent local protestor, against TMC veteran Haji Nurul Islam. The CPI (M) has fielded former MLA Nirapada Sardar, making this a three-cornered contest.

In Punjab, prominent candidates in the fray are four-time MP Preneet Kaur, former chief minister Charanjit Singh Channi, three-time MP Harsimrat Kaur Badal and Ravneet Singh Bittu.

The BJP and Shiromani Akali Dal are contesting the polls on their own for the first time since 1996 while two INDIA bloc parties - the Congress and AAP - have fielded their own candidates.

The prestige of Ranaut and Himachal Pradesh minister Vikramaditya Singh, the heir of the erstwhile Rampur royal family and son of six-time former chief minister Virbhadra Singh, is at stake in Mandi.(PTI)

Another problem in Karimganj could be the movement of election officials who need to bring the signed result copy to the CEO's office here for submission in person at the Election Commission's office by June 6,

"For that, we have held discussions with neighbouring Meghalaya officials. We also made arrangements for our officials to walk through the landslide areas, if needed, to bring the papers on time," he added.

With a number of incumbent MLAs in the fray in the Lok Sabha polls in the state, the CEO was asked whether re-election, required if the legislators win the Parliamentary elections, will be conducted in the newly-drawn

'We have asked the EC about it. It is still not clear whether re-election will be as per new constituencies," Goel replied.

Reforming India's Political and Social fissures

he 2024 Lok Sabha election campaign has revealed deep fissures within India's political and social fabric. The opposition's grievances about ECI's partiality, highlighted by delayed and inconsistent polling data, have raised serious concerns about the integrity of the electoral process. Furthermore, the use of stringent laws to detain opposition leaders and financial crackdowns on opposition parties suggest a climate of political intimidation that threatens the democratic process. The similarity between the election campaign of 2019 and 2024 is the focus of PM Narendra Modi on jingoism in relation to Pakistan and on Muslim terror modules, so as to inject a sense of fear of a national security threat among the majority Hindu community to unite them to vote for BJP. It worked in 2019, and BJP could win an unprecedented 303 seats. Only the result on June 4 will show if this strategy worked this time. National security did not emerge an issue, though the Prime Minister Narendra Modi repeatedly mentioned that the opposition INDIA bloc has conspired to take away the properties of Hindus, and reservation of STs, SCs, and OBCs to give them to Muslims. It was a direct violation of the Model Code of Conduct since it was nothing but instigating Hindus against the Opposition and the Muslims, - instigating one section of the population against the

Opposition INDIA bloc has raised the issue before the Election Commission of India (ECI), which brought the issue of falling credibility of the ECI, and a suspicion that ECI has compromised its independence to the ruling establishment. The issue of providing timely polling data, which was delayed for several days, and the final data was much higher than the initial data released on the polling day, giving rise to a suspicion of data manipulation. These are some of the serious matters in relation to conducting free and fair elections by the ECI. The apparent threat to democracy was brought into focus by the opposition, several of whose leaders were put behind bars under draconian PMLA for money laundering and corruption Opposition cried foul and raised the issue before the court and made it an issue during the election campaigns. One can't deny the fact that the Centre has unleashed central investigating agencies against the political parties and their leaders during the election. The Supreme Court of India has even given relief in the form of interim bail to AAP supremo Arvind Kejriwal to campaign for election, who was arrested by the Enforcement directorate after the announcement of election by ECI. The Department of Income Tax even blocked the account of the chief opposition political party Congress, which is leading the opposition INDIA bloc.

There are some of the incidents suggesting perils in democracy, the threat to the Constitution of India. During the election campaign several BJP leaders said that they need more than 400 seats to change the Constitution of India, though BJP leadership said that they don't have any such plan. The clarification was not believed by the people, since the RSS-BJP clan has all along been working on Hindutva line and they have a dream to make India a Hindu Nation, as against the present socialist, secular, and federal republic. The BJP leadership has been talking about "One nation One election", "One nation, one civil code", and so on. PM Modi's functional behaviour implies "One Nation, One Party, One Leader" the opposition allege. Former Prime Minister Manmohan Singh has even appealed to the voters that it was their last chance to save democracy and the Constitution from the clutches of a despotic leader PM Narendra Modi, who delivered such hate speeches that no other prime minister earlier had said. Hate speeches remains It is a serious threat to Indian society's secular fabric. Whichever government takes oath after June 4 results, it should address such important issues to avoid the peril that the country is facing.

Although PM Narendra Modi held the mega road show and addressed the meeting the day he filed his nomination in Varanasi but all the top leaders of NDA and BJP visited the VIP constituency and campaigned. Challenges to democracy: An analysis of India's 2024 Lok Sabha election

wo key aspects stand out in the 2024 Lok Sabha elec-tion, marking it as a significant event. Firstly, the election outcome, and secondly, the electoral process itself, are both set to profoundly influence the political landscape for years. The incumbent government entered the campaign with high confidence, anticipating an unchallenged third term.

Some officials even speculated about surpassing the 400-seat mark in Parliament, which would grant them a substantial mandate to potentially pursue constitutional amendments. The government's optimism was bolstered by several advantages: substantial media influence, freezing the main opposition party's bank accounts, arresting two Chief Ministers on longstanding charges, and a significant resource gap favoring the government over its competitors. These factors combined to create a strong expectation of an easy and decisive victory for the ruling party.

As the election progressed into its third phase, a remarkable trend emerged: there was no discernible wave in favor of the government. Many voters, including the government's core constituencies in Uttar Pradesh (UP), apunenthusiastic and reluctant to vote. Even in strongholds like Bareilly and Unnao, BJP workers struggled to mobilize their core supporters. Although Prime Minister Narendra Modi and UP Chief Minister Yogi Adityanath were spoken of positively, there was widespread disrepresentatives who had failed to fulfill their promises.

This low voter turnout poses a significant challenge for the BJP. Notably, in 115 constituencies, or 27% of the total, fewer people voted compared to the 2019 election, not just in percentage terms but in absolute numbers. Commentators like Sushant Singh have noted that this phenomenon is almost unparalleled in India's electoral history

Voters were deeply concerned about rising prices, the impact of the Agniveer scheme, and, most importantly, the persistent lack of jobs. Unlike the 2019 election, which saw a decisive impact from the Pulwama attack, no such po-

larizing event

DEGREE OF THOUGHT has occurred this time. Further-Dipak Kurmi more, the BJP's position is weakened by the loss of most of its coalition allies, particularly in key states like Maharashtra. The party enters the polls with few formal pre-poll alliances, a factor that could signif-

icantly count against it. Predicting election outcomes is notoriously tricky and has often led to the downfall of seasoned analysts. However, it appears evident that the BJP's ambitions of surpassing its 2019 majority are now out of reach. The party is likely to struggle even to secure a majority on its own. It's important to remember that the BJP's majority in 2019 was only 31 seats, though their subsequent dominance created the illusion of a much larger mandate. Having already secured its heartland regions, the BJP faces significant

challenges in expanding into the southern and eastern parts of India, where it has traditionally

had limited appeal. Should the BJP secure a third term, it will likely be part of a coalition, which would restrict its ability to freely pursue its Hindu nationalist agenda. This would hinder its long-term goals of transforming the political and social landscape. An even greater setback would be a term in opposition, though this would not entirely extinguish its ambitions for long-term change.

The integrity of the electoral process in India has always been a challenge, with political parties constantly trying to manipulate procedures to

their advantage.

However, the

2024 election has seen a disturbing escalation in both traditional and modern malpractices. Alongside longstanding issues like booth capturing and voter intimidation, new tactics such as overspending, disinformation campaigns, and communal rhetoric have become

Reports from M Rajshekar, particularly his analysis in The Wire titled "Decoding: 28 Reasons for the Shrinking Credibility of the Electoral Process," highlight the extent of these malprac-Instances of rival candidates being coerced to withdraw, booths being captured, and voters facing intimidation have become distressingly common.

In some constituencies like Surat and Indore, opposition candates uncontested.

Moreover, archaic practices like suppressing the votes of marginalized communities have resurfaced. In Sambhal, Muslim voters were subjected to lathi charges, while Dalits in Kaushambi faced assaults for not supporting the BJP. Instances of voter suppression, such as names missing from electoral lists, further undermined the democratic process. In Khajuri, North East Delhi, many long-time voters found their names inexplicably deleted from the voter list, leading to disenfranchisement.

Even during the act of voting, manipulation persisted. In Fatehpur, Uttar Pradesh, a voter was forced to cast her ballot for the BJP despite expressing her preference for the Samajwadi Party symbol. Similarly, in Bhubaneshwar, Odisha, a polling officer repeatedly directed voters to vote for the BJP, only stopping when confronted by a vigilant voter.

These alarming incidents underscore the urgent need for electoral reform and vigilance to safeguard the democratic princi-

ples of free and fair elections. While it's challenging to precisely quantify the extent of electoral malpractices, collectively they suggest a notable bias in favor of the BJP. In the 2019 election, the BJP secured numerous seats with narrow margins, indicating their advantage in closely contested races. This pattern implies that only significant margins of victory can dislodge the BJP

from winning positions. However, the more concerning issue is the erosion of fair practice norms. In the Chandigarh mayoral election, for instance, a BJPaffiliated returning officer was caught defacing ballot papers to ensure the victory of the BJP candidate. Despite this blatant violation, the Punjab and Haryana High Court initially declined to intervene, prompting the case to escalate to the Supreme Court. The Supreme Court's swift intervention and subsequent overturning of the election result underscored the severity of the situation, with the Chief Justice condemning the incident as a "mockery of democracy" and recommending the prosecution of

What's alarming is not just the audacity of the vote-rigging but the lack of accountability from the BJP itself, despite clear evidence of wrongdoing. The integrity of the voting process is essential in giving voice to all participants, particularly the marginalized and vulnerable. It serves as a collective expression of individual choice and acts as a check on the power of the state and those who control it.

Preserving the integrity of the electoral process is crucial for ensuring democratic principles. As the saying goes, "When government fears the people, there is liberty. When the people fear the government, there is tyranny." Upholding fair electoral practices is essential for fostering a democratic society where citizens feel empowered and the powerful are held accountable. Coalition of black trade unionists maps strategy for 2024 and beyond

Staying neutral means staying silent. It means risking the rights of workers and the civil rights of all. It means the continuation of unemployment and poor wages while the powerful continue to get richer." That's the warning from Fred Redmond, Secretary-Treasurer of the AFL-CIO and the highest-ranking Black trade unionist in the country.

Redmond was speaking to over 1,200 Black, Latino/a, Asian, Arab, Indigenous, and white delegates and guests at the 53rd International Convention of the Coalition of Black Trade Unionists (CBTU) that filled the Houston Marriott Marquis Hotel convention center on Thursday

morning. Founded in 1972, the CBTU has been a driving force for trade union militancy and diversity and has been holding the labour movement accountable since its inception.

The theme of this year's convention is "Never Back, Always Forward: Hate Cannot Erase Us." With the 2024 elections looming, setting up a re-run between President Joe Biden and former twice-impeached president and fascist Donald Trump, the convention brought into stark relief the high stakes facing the working class and the trade union movement.

"Whether we like it or not, this election comes down to us: Black people and the labour movement,' Redmond continued. The upcoming election determines "the future of this country and the future of our labour movement.' What's at stake in the 2024 election, according to Redmond, is the continued ability for the working class to fight for "worker's rights, voting rights, civil rights, healthcare, water rights, the right to live and have a good-paying union

"We have an opportunity to continue to build towards a Third Reconstruction...or usher in the second Confederacy," a CBTU Region 7 delegate and member of the UAW told People's World. "Yes, Joe Biden isn't the best president we've ever had, but let's not get amnesia about what Trump was about when he was presi-

That this year's conven-

tion was held in Texas, a state that Republicans have turned into a bastion of right-wing and anti-immigrant, anti-labour, and antifervour, women significant. Rick Levy, President of the Texas State AFL-CIO told delegates, oppression!' "We need to proclaim our

Texas" to hear. The message: Despite defunding of schools, the criminalization of abortion, the rollbacks of voting rights, and the fascistic assault on immigrants, Texas is also home to the "boldest union fighters who struggle every single day for justice

and equality. "We gotta be honest about the reaction that is so severe," said Levy. In Texas, the effort to outlaw diversity, equity, and inclusion (DEI) policies in public institutions is "absolute madness," he said. "Since when does equality make you an enemy of the State?" Levy pointed out how this ultra-right assault is "installed and promoted by corporate America. They are scared of united workers fighting for economic justice. They are

scared of democracy.' Claude Cummings, Jr., who was recently elected to head the Communication Workers of America (CWA), making him the first Black president of that union, emphasized the importance of educating and mobilizing the labour movement in response to Project 2025-the fascist agenda proposed by the farright Heritage Foundation.

The doomsday plan seeks to undermine and eliminate the hard-won democratic gains of working people throughout the course of the country's history in favour of white supremacy, company unions. "Christian" nationalism, and a loss of basic democ-Cummings called on

CWA and CBTU to fight to "protect democracy and protect our unions." He declared in no uncertain terms, "We will defend our unions!" The president of the Labour Council for Latin American Advancement (LCLAA), Evelyn DeJesus, also the first Latina Executive Vice President of the American Federation of Teachers (AFT), spoke about the unity needed between all working-class people to defend our hard-won rights and fight towards a new, more just society.

For DeJesus, the collective power of the working class is the driving force for all of our country's social progress. "Racial unity is our strength," she said, "and we need this unity to dismantle all systems of

The main report delivered by Rev. Terrence L. Melvin, International President of CBTU, was met with lively cheers from the audience. "We are not here to pacify our oppressors,' he stated. "We are here to uplift our families and our communities!'

"The union movement is on fire!" shouted Melvin. "It is rooted in the new militancy in workers who are saying, 'We ain't taking this shit no more!" Black workers are front and center in the current resurgence of organized labour, and they are increasingly being elected to positions of leadership in the trade union movement. "Black folks are kicking some ass!" Melvin remarked to a round of applause from the delegates.

Turning to the issue of peace, Melvin said, "Our hearts flinch for every child shot in Gaza" just like "our hearts flinch for every police killing in America." said Melvin. The ceasefire sentiment among convention delegates was expressed in the form of peace and solidarity buttons, ceasefire stickers, keffivehs, and bracelets in the colours of the Palestinian

It was clear that CBTU, and the delegates of the convention more broadly, were not entirely pleased with the Biden administration's first four years. They mentioned a dearth of movement on police accountability and reform, the support for the genocide against Palestinians, slow-motion on voting rights legislation, and a lack of political mobilization against the Jan. 6th coup-plotters.

However, "MAGA is democracy's grave digger" and "Project 2025 is the billionaires' plan to enshrine white supremacy and turn our country into an apartheid state," asserted Melvin. "The MAGA cult has democracy on life support and we say, hell nahwe ain't standing for that!' "We need to bury MAGA and defend our hard-earned gains. This is a game of inches...not a game of perfection. The stakes are just too high." (IPA Service)

Political pressure from all sides puts Jordan King in a hopeless situation

ordan's King Abdullah is caught between a rock and a hard place. Hamas **J** and its regional supporters, as well as Israeli politicians and vigilantes, are pressuring King Abdullah from both ends of the political spectrum. Iranian-backed Syrian and Iraqi militants seek to draw the kingdom, in which Palestinians account for at least 50 per cent of the population, into the Gaza war. Hamas, the Muslim Brotherhood, and Iran want to turn Jordan into a regional flashpoint and funnel for weapons for Palestinian militants on the West Bank. "The Iranians have instructions to recruit Jordanians and penetrate the Jordan arena through agents. Their recruitment efforts span all segments of society," said Saud Al Sharafat, a former senior Jordanian intelligence official.

In support of Hamas, Iranian-backed Iraqi groups in January attacked a US military base, killing three American soldiers and wounding at least 34 others. Iran was quick to rein in the militias after the United States retaliated with a series of airstrikes. At the other end of the political spectrum, vigilante Israeli settlers have attacked Jordanian humanitarian truck convoys as they traversed the West Bank en route to Gaza.

At the same time, Israeli politicians, with far-right National Security Minister Itamar Ben Gvir in the lead, complicate King Abdullah's life with provocative visits to the Jordanian-administered Temple Mount or Haram ash-Sharif, Islam's third holiest site. Jordan is Haram ash-Sharif's custodian. King Abdullah has put himself in the firing line by intercepting Iranian drones traversing Jordanian airspace in the Islamic Republic's massive April 19 drone and missile attack on Israel and cracking down in March and April on pro-Palestinian demonstrations. He defended the downing of Iranian drones violating Jordanian airspace as an act of self-defence, insisting "Jordan will not be a battlefield for any party." Even so, King Abdullah, dependent on US military and economic support, may not have had a

choice but to take down the drones. Critics posted concocted images on social media of the king wrapped in an Israeli flag or donning an Israeli military uniform with comments such as "traitor" and "Western puppet." The crackdown and assistance in Israel's defence have drowned out the fact that Jordan is the only Arab country to have withdrawn its ambassador to Israel and consistently sends aid to Gaza. Jordan is one of five Arab countries that maintain diplomatic relations with Israel. Meanwhile, Jordanian sources assert the Muslim Brotherhood organised the protests.

With an unemployment rate of approximately 22 per cent and nearly half of young people unable to find a job, officials feared that the pro-Palestinian demonstrations could morph into social and economic protests. Long a close US ally, King Abdullah's predicament highlights the Gaza war's potential to further destabilise the Middle East. Jordan's geography doesn't help with the West Bank on its Western border, Syria in the north, and Iraq in the east.

The pressure on King Abdullah comes as politics could spark paradigm shifts in several key Middle Eastern states, including Israel and Iraq. King Abdullah likely

sees benefit in Binyamin Netanyahu's space to manoeuvre narrowing as a result of mounting Israeli public pressure to free Hamas-held hostages by ending the Gaza war and international courts acting to force Israel to halt its offensive in Gaza and hold the prime minister and Defence Minister Yoav Gallant accountable for its war conduct. Hamas's recent rocket attack on Tel Aviv will probably offer Netanyahu a brief relief, if at all.

King Abdullah may also see mileage in popular Iraqi Shia cleric Moqtada Al Sadr's decision to re-enter politics and compete in next year's elections in a move that would challenge the pro-Iranian Coordination Framework, the backbone of Prime Minister Mohammed Shia al-Sudani's government. For now, King Abdullah's crackdown on mass pro-Palestinian protests has reduced domestic pressures, even if widespread anger continues to bubble at the surface.

Even so, Jordan sources said earlier this month that security services had foiled a suspected Iranian-led plot to smuggle weapons into the kingdom to help King Abdullah's opponents carry out acts of sabotage. The sources said an Iranianbacked Syrian militia had sent the weapons to Jordanian Palestinian members of the Muslim Brotherhood with links to Hamas, a Brotherhood affiliate.

In March, Israel's Shin Bet domestic security agency said it had foiled attempts by Iran to smuggle large amounts of advanced weapons into the West Bank. Shin Bet said the smuggling was organized by Unit 4000, the intelligence unit of the Special Operations Division of the Islamic Revolutionary Guards Corps, and the Special Operations Unit 18840 of the Guards' Quds Force in Syria. The agency said Munir Makdah, a senior Lebanonbased official of Palestinian President Mahmoud Abbas' Al Fatah movement, was involved in the foiled smuggle.

In response to the most recent plot, Hamas insisted it had "no ties to any acts targeting Jordan." A Jordanian Muslim Brotherhood official said its arrested members had acted independently. Even so, Hamas leaders have repeatedly called on Jordanians since the Gaza war erupted in October to step up to the plate.

Senior Doha-based Hamas official Khaled Mishaal, who survived an Israeli assassination attempt in Amman in 1997, told a women's gathering in Jordan in a video address that "Jordan is a beloved country, and it is the closest to Palestine, so its men and women are expected to take more supportive roles than any other people towards the land of resistance and resilience." Iranian-backed Iraqi militants asserted in April that they stood ready to arm 12,000 fighters of the Islamic Resistance in Jordan that would open a new front against Israel. Abu Ali al-Askari, a Kataib Hezbollah security official, suggested the offer was inspired by Hamas and Palestinian Islamic Jihad's assessment that all Jordanian militants needed was access to weapons.

There is no evidence of an Islamic fighting force in tightly controlled Jordan despite mounting public anger, a limited number of border incidents, and the efforts by Hamas, the Muslim Brotherhood, and Iranian-backed groups. Donald Trump becomes first former US president to be convicted of felony

INGTON, May 31: Donald Trump has become the first former US president to be convicted of a felony after a grand jury in New York found him guilty on 34 counts of falsifying business records to cover up a payment to silence a porn star ahead of the 2016 presidential election, mounting his legal challenges amidst his bid to return to the White House in

In a historic verdict, a panel of 12 Manhattan jurors on Thursday said they unanimously agreed that Trump, 77, falsified business records to conceal a USD 130,000 hush money payment to adult film star Stormy Daniels to influence the 2016 contest.

The decision came after about a day and a half of deliberations. The conviction does not prevent Trump from standing in November's election, but

Houthi rebels say at least 16 killed, 35 others wounded in joint US-British airstrikes in Yemen

DUBAI, May 31: Joint British-US airstrikes targeting Yemen's Houthi rebels killed at least 16 people and wounded 35 others, the rebels said on Friday, the highest publicly acknowledged death toll by the rebels from the multiple rounds of strikes carried out over their attacks on shipping.

Three US officials, speaking on condition of anonymity to describe a then-ongoing attack, described the strikes on Thursday as hitting a wide range of underground facilities, missile launchers, command and control sites, a Houthi vessel and other

They called it a response to a recent surge in attacks by the Iran-backed militia group on ships in the Red Sea and Gulf of Aden over the Israel-Hamas war.

The U.S. F/A-18 fighter jets involved in the strikes launched from the USS Dwight D. Eisenhower aircraft carrier in the Red Sea, officials said. Other US warships in the region also participated.

But the Houthis focused Friday morning on just one of the strikes, which they said struck a building housing Hodeida Radio and civilian homes in the port city on the Red Sea. Their Al Masirah satellite news channel aired images of one bloodied man being carried down stairs and others in the hospital, receiving aid.

The Houthis described all those killed and hurt in Hodeida as civilians, something The Associated Press could not immediately confirm. The rebel force that's held Yemen's capital, Sanaa, since 2014 includes fighters who often are not in uniform.

Pak PM to visit China next week to 'jointly draw a blueprint' for bilateral growth, launch 2nd phase of CPEC

ISLAMABAD/BEIJING, May 31: Pakistan Prime Minister Shehbaz Sharif will embark on a five-day visit to China on Tuesday during which he will hold talks with Chinese President Xi Jinping and 'jointly draw a blueprint" to strengthen bilateral ties further, as the all-weather allies seek to upgrade cooperation under the multi-billion dollar China-Pakistan Economic Corridor.

Sharif will be in China from June 4 to 8 on the invitation of Chinese President Xi Jinping, Pakistan's Foreign Office spokesperson Mumtaz Zahra Baloch said at her weekly briefing in Islamabad on Friday. The visit aims to increase cooperation under the China-Pakistan Economic Corridor (CPEC) project, as the two sides look forward to launching the project's second phase. The CPEC was launched a decade ago, and several energy and infrastructure

projects had already been completed. During his visit to China, Prime Minister Sharif will hold talks with President Xi and "jointly draw a blueprint" for the growth of China-Pakistan relations, Chinese Foreign Ministry spokesperson Mao Ning said in Beijing. This will be Sharif's first visit to China after he took over as prime minister for the second term after his Pakistan Muslim League-Nawaz (PML-N) party-led coalition government

During his visit, Sharif will also hold indepth exchanges with Premier Li Qiang and other officials on China-Pakistan relations and issues of mutual interest, Mao

"China and Pakistan are all-weather

The meeting behind closed doors between Austin and Chinese Defense Minister Dong Jun was the first in person between the top defense officials since contacts between the American and Chinese militaries broke down in 2022 after then-US House Speaker Nancy Pelosi visited Taiwan, infuriating

South Africa heading for 'coalition country' as partial election results have ANC falling under 50%

JOHANNESBURG, May 31: South Africa was heading closer to the reality of a national coalition government for the first time on Friday as partial election results put the ruling African Nation Congress well short of a majority.

With more than half of votes counted across the country's nine provinces, the ANC had received just under 42% of the national vote, according to the early results as counting continued. That represented a huge drop from the 57.5% it received in the last national election in 2019, although the final results from Wednesday's election have not yet been declared.

The commission that runs the election said those would be announced by Sunday, although they could come sooner.

The count from more than 12,000 of the 23,000 polling stations raised the strong possibility that the ANC would need a coalition partner to form a government and reelect President Cyril Ramaphosa for a second and final term. The frenzied negotiations were likely set to start behind closed doors.

The ANC was still leading the count and had the most votes by some way, as expected, with the main opposition Democratic Alliance on around 24%. The ANC is widely expected to still be the biggest party and to have the most seats in Parliament The ANC has had a clear ma-

jority for all 30 years of South Africa's democracy since the party swept to power in a 1994 election which officially ended the apartheid system of white minority rule, leading Nelson Mandela to become the country's first Black president. It has been the dominant political force and its slipping below 50% would be a momentous change for Africa's most advanced economy

The ANC's support has steadily declined from a high of nearly 70% of the vote 20 years ago as South Africa grapples with deep socioeconomic problems, including widespread poverty and now one of the worst unemployment rates in the world at 32%. Poverty and unemployment disproportionately affect South Africa's Black majority that make up 80% of the population and were the core of

While the inequalities of apartheid were always going to be hard to solve, the ANC has also been blamed by many for failures in basic government services, numerous government corruption scandals and most recently an electricity crisis that led to rolling blackouts across the country of 62

the ANC's support over the years.

Sexual abuse allegations: Prajwal Revanna arrested by SIT

BENGALURU, May 31: Prajwal Revanna, the suspended JD(S) MP facing sexual abuse allegations, was arrested on Friday upon his return from Germany, a month after he left the country in the wake of explicit videos of his alleged actions doing the rounds in Karnataka's Hassan.

In a clear messaging by the SIT probing the allegations, a team of women police personnel 'welcomed' Praiwal Revanna upon his arrival here, as they were deputed to execute a warrant and take him to the CID office for interrogatrion.

After evading summons and staying out of the country for a little over a month, the 33 year-old grandson of JD(S) supremo and former Prime Minister HD Deve Gowda landed here past midnight from Germany's Munich, only to be arrested by the Special Investigation Team (SIT) minutes later and whisked away for questioning.

The NDA Lok Sabha candidate from Hassan, facing allegations of sexually abusing several women, was arrested after completing the due process, and further legal procedures will follow, Karnataka Home Minister G Parameshwara said. Prajwal's advocate said the former was extending full cooperation to the SIT probe and cautioned against any media trial in

"Prajwal Revanna landed around 12.40-12:50 am from Germany's Munich. As there was an



arrest warrant against him, SIT accordingly arrested him and took him into custody and further legal procedures they will follow today," Parameshwara said

Speaking to reporters here, he said, "...naturally he should have cooperated to the arrest. His immigration papers were cleared and he was brought out (of airport). As he had a diplomatic passport, things happened easily. After completing all the due process, he was arrested," he added.

Asked if the government will appeal to more victims to come forward following his arrest, Parameshwara said, "We have already said, those who have faced trouble from him to come forward and give complaints to SIT and police, and we will provide them all kind

of protection. We will have to wait and see further developments."

The SIT, sending out a message, deputed an all-woman police team to execute the warrant against Pra-

Soon after he alighted from the plane from Munich, he was received by women in Khaki, sources in the SIT said.

During the procedure of executing the arrest warrant, he was flanked by the women police personnel who were led by two IPS officers, Suman D Pennekar and Seema Latkar. He was then taken in a jeep in which only women police were present. They took him to the CID office.

"It was a conscious call to send women officers to arrest Prajwal, sending home a message that the

JD(S) leader exploited his seat and power as an MP with women. The same women have authority to arrest him through all legal proceedings," a source in the SIT said.

There was also a symbolic message to the alleged victims that women officers were not afraid of anyone, the source added.

The MP was later taken for medical examination under tight security. Escorted by female police officials, he was taken to Bowring and Lady Curzon Hospital here.

The SIT is also contemplating a potency test on Prajwal. A potency test is done to ascertain if a rape accused is capable of committing sexual assault on victims.

Meanwhile, Prajwal's advocate, Arun G, met him here.

"I went to speak to him. He has told to the media that he has come forward to cooperate with the investigation. So he has requested that there be no media trial. Let there be no negative campaign unnecessarily," Arun said.

Speaking to reporters after meeting Prajwal, he said the Hassan MP is before the SIT to give the fullest cooperation.

"Prajwal said -- I have come forward, the whole purpose of me coming to Bengaluru or before SIT is that I have to stand by my words. I have come forward. I will give the fullest cooperation -- these are his words," he added.

The advocate said he had explained to Prajwal about how the

Prajwal had on May 29 filed an anticipatory bail plea at the Principal City and Sessions Court for Elected Representatives, which issued a notice to the SIT to file objections before posting the hearing

In the first case registered against him at the Holenarasipura Town police station in Hassan on April 28, Prajwal is accused of sexually harassing a 47-year-old former maid. He is listed as accused number two, while his father and Holenarasipura MLA, H D Revanna, is accused number one.

Prajwal has been so far booked in three cases of sexual assault. There are also charges of rape against him.

The Ministry of External Affairs (MEA) has served a show-cause notice to Prajwal asking why his diplomatic passport should not be cancelled as sought by the Karnataka government in view of allegations of sexual abuse against

Deve Gowda had recently issued 'stern warning' to Prajwal, asking him to return to the country and face probe into the sexual abuse allegations, while asserting there will be no interference from him or other family members into the en-

The JD(S) supremo had reiterated that his grandson should be given the harshest punishment under the law

Delhi seeks SC direction to Haryana to release water flowing in from Himachal to crisis-hit capital



NEW DELHI, May 31: The Aam Aadmi Party-led Delhi government on Friday moved the Supreme Court seeking a direction to Haryana to release surplus water provided by Himachal Pradesh to the parched national capital for urgent mitigation of its water woes

compounded by scorching heat. The plea, filed by Delhi's Water Minister Atishi, has made the Centre, BJP-governed Haryana and Congress-ruled Himachal Pradesh parties to the petition and said access to water is essential for survival and one of the basic human rights.

"Access to water is one of the basic human rights of an individual. Not only is water essential for sustenance, but access to water also forms an essential component of the guarantee of dignity and a quality of life guaranteed under Article 21 of the Constitution.

"The current water crisis, which may only get worse olates the right to a dignified and quality life of the people of the NCT of Delhi, who are unable to access even adequate clean drinking water," the plea said.

It, according to sources, has sought a direction to the Haryana government "for immediate and continuous release of water at the Wazirabad barrage, including but not limited to the full surplus water provided by the Respondent No. 2 (Himachal Pradesh) for the National Capital Territory of Delhi, in order to mitigate the water crises in the NCT of

The city government said it was constrained to file the plea on account of acute shortage of water being faced by the citizens due to the ongoing severe heat conditions in north India, particularly Delhi.

'The record-high temperatures and heat wave in Delhi, which has resulted in maximum temperature rising up to around 50 degrees Celsius at some places, have caused an extraordinary and excessive surge in water demand in the city. As a result, the national capital is dealing with a water shortage which has led to frequent supply cuts in many parts of the NCT, and has disrupted the daily life of the ordinary residents,"

The AAP government said it has taken all measures to ensure "optimisation, rationing and targeted" supply of water, yet, the shortage remains acute and "it is clear, by all indicators, that the NCT of Delhi is in dire need of additional water".

It said all treatment plants in the national capital are treating and supplying the water being sent, and to address the present crisis, it is necessary to augment water supply.

The city government said it has sought the direction as a one-time measure and not filed the plea for resolving any outstanding inter-state water dispute.

"The Petitioner is praying for the said relief of release of surplus water only as a stop-gap arrangement to remedy the current crisis till such time the monsoon season arrives and the temperature of the city goes down....thereby reverting the situation to normal," it

Without prejudice to the inter-federal rights of Delhi, especially as a lower riparian state to shared water resources, the plea is filed only because of the unprecedented surge in temperature, which has triggered a surge in the demand for water, it said.

"Such excessive and unanticipated demand has precipitated an emergency in the form of a full-fledged water and sanitation crisis and has necessitated an emergent solution," the plea said. In order to deal with the demand in summer months,

the Delhi government has devised a solution under achal Pradesh has agreed to share its s plus water with Delhi, the petition said. Since Himachal Pradesh does not share boundary with Delhi, the surplus water released by it has to be

transported through the existing water channels in Haryana and released to Delhi at the Wazirabad barrage, it said, adding "Therefore, Haryana's facilitation and cooperation, which is not being provided as on date, is imperative." "It is also necessary to point out that, presently, the

water levels in the Sonia Vihar and Bhagirathi barrages, which constitute the other primary sources of water for the NCT of Delhi, are operating at their optimum level and meet the stipulated standards, therefore, any increase in water supply can only be considered at the Wazirabad barrage," it said.

During the day, chief minister Arvind Kejriwal urged the BJP to ask its governments in Haryana and Uttar Pradesh to provide water to the national capital for a month to ease the situation.

The national capital has been facing a severe water shortage and Water Minister Atishi has accused Haryana of not releasing Delhi's share of water. (PTI) the Congress general secretary said at a press con-

Will surrender tomorrow: Kejriwal

NEW DELHI, May 31: Delhi Chief Minister Arvind Kejriwal said on Friday that he will be surrendering on June 2 and, in an emotional appeal, asked the people to take care of his old and ailing parents after he is gone.

"I will leave my house around 3 pm (on Sunday) to surrender. It is possible that this time they will torture me more, but I will not bow down," he said. He assured the people of Delhi that all the facilities available to them will continue even in his absence. "You take care of yourself, I worry a lot about you in jail. If you are happy, your Kejriwal will also be happy. "I will not be among you, of course, but you don't worry, all your work will continue... And after returning, I will also start giving Rs 1000 every month to every mother and sister," he said in a virtual press conference.

Making an appeal to the Delhiites who stood by him in difficult times to look after his aged and ailing parents, he said he has always fulfilled his duty as a son "of your family".

"Today I want to ask something from you for my family. My parents are very old, my mother is very ill. I will worry a lot about her in jail.

Take care of my parents after I am gone, pray for them, pray to God. Prayers have great power. If you pray for my mother daily, she will definitely remain healthy," he said. Kejriwal said his wife Sunita is very strong and has supported him in every difficult phase of life.

"When difficult times come, the whole family comes together, you all have supported me a lot in difficult times. It is because of your prayers that I am alive today and your blessings will protect me in the future too. In the end, I just want to say that if God wishes, your son will come back very

He assured the people that all facilities available to them, including 24-hour free electricity and women's bus travel, will continue.

The Aam Aadmi Party (AAP) national convener was granted interim bail by the Supreme Court till June 1 for the Lok Sabha election campaigning. After being released from the Tihar jail here, Keiriwal visited Uttar Pradesh, Punjab, Delhi and Maharashtra for campaigning

"We are all fighting dictatorship together... If something happens to me while saving the country, if I even lose my life, do not be sad," Kejriwal said. I will go back to the Tihar jail day after tomorrow. I do not know how many days these people will keep me in the jail this time. But my spirits are

"I am proud that I am going to jail to save the country from dictatorship. They tried to break me in many ways, tried to bow me down and tried to silence me. But they did not succeed," the chief minister said. The AAP supremo alleged that when he was in the jail recently, he was "tortured" in many ways. He said his medicines were stopped.

"I have been a serious diabetic (patient) for 20 years. For the last 10 years, I have been getting insulin injections daily. I get injections in my stomach four times every day," he said, alleging that in the jail, his insulin injections were stopped for many days. He said his sugar levels reached 300, 325 (mg/dL). If the sugar remains so high for so many days, the kidney and liver get damaged, he added. "I don't know what these people wanted and why did they do this," he said.

Talking about the unexplained weight loss during his incarceration, the AAP supremo said during his 50-day stay in the jail, he lost six kg of weight.

"When I went to jail, my weight was 70 kg. Today it is 64 kg. Even after being released from jail, my weight is not increasing," he said.

Kejriwal said the doctors are saying that this can also be a sign of some major disease in his body. The ketone level in his urine has also increased considerably and many tests need to be done, he

Delhi BJP chief Virendra Sachdeva hit back at Kejriwal and said he has a "disease of lying".

"Delhi CM (Arvind Kejriwal) has said that he has a serious disease. I agree with what he has said. He has a disease of lying," he said.

Sachdeva said Kejriwal did the election campaigning. However, when now the time has come for him to go to jail, he is reminding everyone of his diseases, the BJP leader added. (PTI)

Bhangore's Indian Secular Front (ISF) MLA Nawsad Siddique, however, dismissed the allegations and said that the TMC workers hurled bombs at ISF supporters but their own party men were injured in the incident. Bhangore under Jadavpur Lok Sabha constituency will go to polls in the last phase on Saturday.

Avian influenza: Centre asks states to be vigilant

Isolation wards/beds at dedicated hospitals may be required to handle any suspect case of Avian Influenza if confirmation among birds occurs

NEW DELHI, May 31: The Centre has asked all states to be vigilant for any unusual deaths amongst the domestic birds and poultry, and share the information with the Animal Husbandry Department immediately so that public health action can be initiated as per the national action plan for Avian in-

A joint advisory issued on May 25 by the National Centre for Disease Control (NCDC) and Department of Animal Husbandry and Dairying stated that in 2024, four states -- Andhra Pradesh (Nellore), Maharashtra (Nagpur), Kerala (Alappuzha, Kottayam, and Pathanamthitta districts), and Jharkhand (Ranchi) -- have already reported outbreaks of Avian influenza in poultry.

"Given that Avian Influenza (H5N1) infection is highly pathogenic and has the potential to be transmitted to humans, it is imperative to take all necessary measures to minimize and prevent the spread of this infection," the joint advisory

The Avian Influenza virus (bird flu virus) is normally maintained in circulation in nature among mainly migratory birds and is known to cause outbreaks among domesticated poultry birds probably due to spill over events when migratory birds come in contact with poultry, The H5N1 is the main Avian in-

fluenza virus that has caused multiple outbreaks among poultry globally. Both types of viruses (HPAI and LPAI) may occasionally affect other mammalian species, including humans. Human infections are primarily

acquired through direct contact with infected poultry or contaminated environments, the joint advi-

Although there have been sporadic reports in humans and outbreaks among domestic and wild birds, since March 2024, there is a global concern over Avian influenza outbreaks in cattle from multiple states in the US that have resulted in one reported human case of H5N1, the joint advisory



from India in poultry have been reported since 2006 and have been jointly investigated by the Animal Husbandry and Health Departments (IDSP, NCDC).

The states and Union Territories have been advised to orient all the health care workers/private practitioners on case definitions, signs and symptoms of Avian influenza.

deaths amongst the domestic birds/poultry in your state, and if observed, please share the information immediately with the Department of Animal Husbandry so that public health action can be initiated as per the national action plan for Avian Influenza," the joint advi-

sory said.

The states have been advised to

strengthen biosecurity measures in all poultry establishments, zoos, poultry markets, etc. after conducting a thorough assessment.

"Comprehensive biosecurity assessments on all poultry farms are recommended. Access to farms should be restricted and stringent hygiene protocols, including the use of disinfectant footbaths and protective clothing, should be enforced. Measures to prevent contact between wild birds and domestic poultry should be implemented," it

The states have been asked to enhance information, education and communication tools among the general public regarding preventive measures such as minimizing the handling of dead or sick birds with bare hands and without adequate respiratory protection and following food safety measures while consuming products of animal origin

Besides, they have been asked to be prepared for all preventive measures like stockpiling of an adequate number of antiviral drugs

Isolation wards/beds at dedicated hospitals may be required to handle any suspect case of Avian Influenza if confirmation among birds occurs in your state, the joint

advisory stated.

(Oseltamivir), PPE, masks etc.

It also called for enhanced surveillance (in wet markets, abattoirs, poultry farm workers etc.) as well as expanded surveillance (in sewage samples, water bodies, crows etc.) for Avian Influenza in collaboration with National Centre for Disease Control (NCDC), Indian Council of Medical Research (ICMR) and Department of Animal husbandry and Dairying (DAHD). It emphasised on timely sharing of information besides underlined the need for strict compliance with the SARI surveillance guidelines of the Ministry of Health and Family Welfare by all states and its moni-

toring at senior level. For the states where there is an active outbreak of Avian Influenza, the joint advisory advised some additional measures.

They have been asked to collect

samples from cullers and surveillance workers (considered as 'atrisk' groups) on the 5th and 10th days following sanitization operations for H5N1 testing.

The joint advisory has stressed on conducting surveillance for suspected human cases and providing health check-ups for cullers and poultry workers, with a duration of 10 days and stated that recommended measures for chemoprophylaxis, management, and use of personal protective equipment (PPE) should be implemented.

It also advised following the SOPs for collecting and transporting samples from suspected cases to designated laboratories.

"A coordinated response involving experts from veterinary services, health departments, wildlife and forest departments, local authorities and other relevant stakeholders is required in all Avian Influenza outbreaks. Regular meetings should be conducted to share information, assess the situation and adjust strategies accordingly," the joint advisory said. (PTI)

Nishant Dev books Paris Olympics ticket

BANGKOK, May 31: Nishant Dev (71kg) became the first Indian male pugilist to secure a Paris Games quota when he reached the semifinals of the Boxing Olympic qualifiers here on Friday.

The world championships bronze medalist, who had narrowly missed on an Olympic berth in the previous qualifiers, earned the quota after defeating Vasile Cebotari of Moldova 5-0 in the quarterfinal which was a battle of the southpaws.

It is India's fourth quota place with women boxers Nikhat Zareen (50kg), Preet Pawar (54kg) and Lovlina Borgohain (75kg) having already secured their passage to Paris.
The 71kg weight class had five

quotas on offer.

Dev, who has been dominant all tournament, was off to a flyer, landing sharp, accurate punches. The Indian was more composed and used his punches judiciously.

In the second round, Cebotari landed a couple of blows and Dev looked a bit out of breath but the Indian continued to hit accurate shots. In the last three minutes, both boxers looked spent but Dev continued to land punches at will. Cebotari earned a point deduction for his punch to Dev when the Indian was down on the canvas.

Earlier, India's quest for booking a quota in the women's 60kg ended with Ankushita Boro 2-3 defeat against Agnes Alexiusson of Sweden in the quarterfinals.

The 23-year-old Boro fought hard but her Swedish opponent, a former European Games bronze medallist, dug into her reservoir of experience to pip the Indian.

Boro, a former youth world champion, was slow off the blocks, but managed to adapt toward the end of the first round, using straight jabs effectively. It was enough to convinced one judge. Down 1-4, Boro made a blistering start, using the combination of left jab and right cross.

NEW YORK, May 31: There will be the usual favourites, the mavericks, the chokers and also the unpredictable minnows -- the script is familiar for a World Cup but the scale would be unprecedented when the T20 showpiece, featuring a record 20 teams, spearheads cricket's audacious charge into the American market starting

While India would be eager to shed the baggage of near-misses, Australia would like to add another chapter to their tale of domination. For the likes of Pakistan and West Indies, the primary target would be to keep in check their tendency to implode at the most inopportune time.

Defending champions England and South Africa too will be a force to reckon with, especially the latter. Given the presence of match-winners like Heinrich Klaasen, David Miller, Quinton de Kock and Kagiso Rabada, the Proteas seem primed to get rid of the chokers' tag.

It will be a ground-breaking event not just because of the sheer size of the draw but also for the fact that it officially marks cricket's big-ticket entry into the USA, which will host 16 of the 55 matches to

The remaining 39 games will be held in the West Indies, including the Super 8 stage, the semifinals and the final on June 29. Besides the obvious favourites on paper, the likes of Afghanistan can also never be counted out to upset the apple

cart at the most unexpected time.

There are plots within plots that will unfold in the course of next one month. And perhaps one of the most intriguing would be the one involving India, a team that looks so destined for an ICC trophy but has somehow managed to fall short after the 2013 Champions Trophy triumph. Rohit Sharma's reputation as captain will definitely be on the line this time. Considering the unparalleled resources and depth that the sport's powerhouse has, most experts find it difficult to pinpoint India's trophy drought at the word stage over the past decade.

Rohit's predecessor Virat Kohli ended his tenure as the most successful Test captain but a global trophy eluded him.

Now Rohit is carrying that baggage of not winning a world title with India finishing runner-up in two ICC events over the past 12 months, including the juggernaut-ending loss to Australia in the ODI World Cup final at home.

Their outdated approach in the previous two T20 World Cups cost them dearly but they are unlikely to repeat those mistakes in the Americas. The recently-concluded IPL showed

bound pistol and rifle marksmen would like to use this last competitive outing to gauge their preparations for the Olympics.

The issue of personal coaches had become a major point of contention. The shooters felt that there was little "flexi-

bility" being given to them vis-a-vis personal coaches at the national camp. Though the issue seems to have been sorted for now, many personal coaches would not have accompanied their wards as the federation's decision came on the day the shooters were leaving for Mu-

With several shooters having displaced the original Paris quota winners in the national squad following a series of four Olympic Selection Trials (OST), the federation would also be keen to see how they perform in the World Cup. Someone like rookie Army man Sandeep shooting contingent. (PTI)

Singh coming out of nowhere to top the national trials and push former world champion and Paris quota winner Rudrankksh Patil out of Olympic contention has put the federations in a fix.
