

Downstream areas flooded after Kandong Dam releases water

DONGKAMUKAM, June 17: Several areas in Karbi Anglong were flooded after NEEPCO opened the sluice gates of the Kandong Dam on the Kopili river on Monday.

Incessant rains for the past week in the district had compelled the officials of NEEPCO to release the excess water, thereby causing immense plight to the people living in the downstream areas.

The most affected MAC (Member of Autonomous Council) areas are Bithung Rengthama, Rongkhang and parts of Kopili MAC constituencies in West Karbi Anglong

Families residing in the downstream areas were directed to move towards safer places. Many of them have either taken shelter in makeshift tents on the embankment or have moved to the homes of their relatives and friends. On Monday the Dongkamukam Tumpreng Hojai road was flooded and commuters could travel on the road only after 10 am when the water level gradually began to recede. Flood waters reportedly also overflowed the road at Komorakatta Issue No. 158

9 dead, 41 hurt in Bengal train mishap; probe begins

Goods train rams into stationary Kanchanjunga Express Documents show goods train driver not at fault • Ex-gratia announced

GUWAHATI, June 17: At least nine people -- seven passengers and two railway staff -- were killed and 41 injured after a goods train rammed into the Sealdah-bound Kanchanjunga Express from behind in West Bengal's Darjeeling district on Monday.

Among the deceased were the pilot of the goods train and the guard of the passenger train, an NF

Railway press statement said. The injured have been shifted to North Bengal Medical College and Hospital for treatment.

Some local reports attributed to senior West Bengal Police officials put the casualty count at 15.

The toll could rise, as multiple agencies of the state and Centre were simultaneously working on war footing along with locals to rescue passengers who could still be trapped inside, sources said.

As a result of the accident, four coaches from rear side of the Kanchanjungha Express and 5 wagons of the container carrying train got



ments of both Up and Down lines. However, debris on the Up Line was cleared at 17:40 hrs. Work for speedy restoration of the Down Line is also in progress, the press statement added.

In a post on X, Prime Minister Narendra Modi said the "railway accident in West Bengal is saddening. Condolences to those who lost their loved ones".

Himanta condoles loss of lives in WB train accident

GUWAHATI, June 17: Chief Minister Himanta Biswa Sarma condoled the death of those killed in the collision between a goods train and the Kanchanjunga Express in West Bengal on Monday and assured of all possible help.

Sarma said that his heart went out to the families of those who lost their lives in the accident.

"The tragic train collision between the Kanchenjunga Express and a goods train is extremely unfortunate," he posted on 'X'.

Amit Shah reviews security situation in restive Manipur



NEW DELHI, June 17: Union home minister Amit Shah on Monday reviewed the security situation in ethnic violence-hit Manipur amidst reports of fresh incidents of trouble in the northeastern state.

At the high-level meeting, Shah was given a detailed briefing on the prevailing situation in the state by top security officials, sources said. The home minister took stock of the situation in Manipur a day after the state's Governor Anusuiya Uikey had called on him here. It is believed that Uikey apprised him about the law and order situation

There were reports of fresh violence in capital Imphal and Jiribam recently. The Centre is said to be worried over the violence spreading to new areas like Jiribam,

which has been by and large peaceful in the last one year, the sources

During the meeting, Manipur government representatives said that adequate forces were deployed in the areas where fresh violence

were reported, they said. Security advisor to the Manipur government Kuldiep Singh, DGP Rajiv Singh and chief secretary Vineet Joshi attended the meeting on behalf of the state government.

Gaurav Gogoi asks EC to release data 'Each MLA should pay own electricity bill', on EVMs found faulty in LS polls



NEW DELHI, June 17: Congress leader Gaurav Gogoi on Monday asked the Election Commission to put out data on how many EVMs were found faulty throughout the Lok Sabha polls.

Gogoi, who won the just concluded Lok Sabha elections from the state's Jorhat seat by defeating his nearest BJP rival by a margin of over 1.44 lakh votes, said he can confidently say that these machines have shown inaccurate results.

Gogoi's statement came a day after a fresh political row erupted over EVM tampering claims with Congress leader Rahul Gandhi and other opposition leaders citing a media report that alleged that a relative of the Shiv Sena candidate in Mumbai North West Lok Sabha constituency was found using a mobile phone "connected" to an electronic voting machine during the counting of votes on June 4.

In a post on 'X', Gogoi said before treating the Electronic Voting Machines (EVMs) as infallible, the Election Commission of India should put out data on how many EVMs were found faulty throughout the elections. He said the ECI should answer how many machines showed the wrong time, date, votes registered during the general elections and how many EVMs had their components replaced - counting unit, ballot unit and how many EVMs were found faulty during the mock poll. "Having contested the elections, I can confidently say that these machines have shown inaccurate results. I hope the Election Commission puts out the above data because the public have the right to know," he said. GUWAHATI, June 17: BJP MLA Prashanta Phukan has welcomed the decision of the government to end VIP culture in the state and ministers, senior government officials will have to pay the bills of their electricity consumption at their residences.

Phukan asserted on Monday that prepaid electric meters should be installed at the houses of each legislator and all MLAs in the state will take of their power expenses. The BJP MLA claimed that in 2007, he raised this issue in the assembly, however, no decision was taken at

Phukan also heaped praises for Chief Minister Himanta Biswa Sarma for taking this decision and he mentioned that it will benefit the general public.

Notably, Sarma on Sunday declared that the government has decided to stop paying senior government officials' power bills, including those of the ministers, ending the VIP culture in the state.

He said that as on July 1, each state minister will pay their own electricity bills. Senior government of-

ficials, including those working at the state secretariat, would also have to pay the power bills on their own.
The Chief Minister said, "We have already told the senior state government officials that they will no longer receive free electricity if they remain at the

> According to him, the state government will have to take less burden and the power department can stop hiking the electricity tariffs of the general public. Sarma said that he will start paying his

house's electrical bills on July 1 and that the required instructions have already been sent. "No Chief Minister in Assam has paid power bills on their own in the last 75 years since India gained independence; instead, the state government was taking the burden of paying their power bills. I was also re-

ceiving these freebies for the last three years until recently I came to know about this," he said. Sarma claimed that he quickly gave the order to in-

stall power meters in the Chief Minister's residence after learning that the bills had been paid from a specific state government fund.

Sikkim: Around 50 tourists rescued from Lachung, moved to Mangan town

GANGTOK, June 17: Around 50 tourists were rescued from North Sikkim's Lachung on Monday and moved to Mangan town, the Border Roads Organisation (BRO) said. The rescue operation, however, had to be halted due to inclement weather, and the remaining tourists would be moved on Tuesday, it said.

The rescue operation began after the BRO restored connectivity between Chungthang and Mangan via the recently built bridge at Toong over the Teesta river.

"The BRO in close coordination of NDRF is leading the mammoth evacuation operation," a statement said. Incessant rains since June 12 wreaked havoc in Mangan, causing multiple landslides, and severing connectivity to most parts of the district. Due to the blockage of various roads at several locations around 1,200-1,500 tourists got stranded in Lachung town, officials said. The situation became grave after the collapse of the newly constructed suspension bridge at Sanklang as it was the main connection to North Sikkim and Dzongu, they said.

"Responding to the natural disaster by overcoming severe weather conditions and heavy rainfall in the region, the BRO launched restoration efforts by mobilizing huge manpower and machinery to restore connectivity to North Sikkim at the earliest," the statement (CONTD. ON PAGE-2)

The Mother and Child Hospital wing is being constructed at a cost of Rs. 375 crores and comprises of eight floors, excluding the basement and the ground floor and with a total building area of 56,840 square meters.

The chief minister chaired a meeting attended by senior officials of the state health department and GMCH authorities during which matters related to filling up of vacant faculty positions, recruitment of staff, capacity expansion and various other issues of the medical college and hospital were

discussed. Addressing the media, Sarma said that the purpose of his visit was to look into the progress being made regarding the construction front of the upcoming Mother and Child Hospital wing and get a firsthand idea of its floor-plan. He said, "The need for a wing

dedicated entirely to maternal and pediatric care had been long felt owing to the increasing number of patients visiting GMCH for treatment. Once the Mother and Child Hospital becomes functional, it will contribute greatly towards enhancing the capacity and efficiency of GMCHin dealing with such medical cases. Around 70 per cent of the construction works of the hospital have been completed and that the remaining 30 per cent is likely to be finished on or before April next year."

The State Cancer Institute and the Cardiothoracic and Neuroscience Centre of GMCH have been contributing immensely in making modern healthcare services affordable and accessible to all, the chief minister said while emphasizing the importance of a robust public healthcare delivery system in the state. Sullivan review implementation of iCET

'Bharat', 'India' to be used interchangeably in textbooks: NCERT chief

NEW DELHI, June 17: "Bharat" and "India" will be used interchangeably in NCERT textbooks as is the case in the country's Constitution, National Council of Educational Research and Training Director Dinesh Prasad Saklani has

The comments assume significance in the wake of a high-level panel working on the social science curriculum recommending that "India" should be replaced with "Bharat" in school textbooks for all classes.

In an interaction with PTI editors at the agency's headquarters here, the NCERT chief said both the words will be used in the books and the council has no aversion to

either "Bharat" or "India". "It is interchangeable....our position is what our Constitution says and we uphold that. We can use Bharat, we can use India, what is the problem? We are not in that debate. Wherever it suits we will use India, wherever it suits we will use Bharat. We have no aversion to either India or Bharat," he said. "You can see both being used in

our textbooks already and that will continue in new textbooks. This is a useless debate," Saklani said. A high-level committee for social sciences, constituted by the

NCERT to revise the school curriculum, had last year recommended that "India" should be replaced with "Bharat" in the textbooks for all classes.

Committee chairperson C I Isaac, who was heading the panel, had said they have suggested replacing the name "India" with 'Bharat" in the textbooks, introducing "classical history", instead of "ancient history" in the curriculum, and including the Indian Knowledge System (IKS) in the syllabus for all subjects. Gold, silver import surges 210 pc in 2023-24 from UAE; need duty revision in FTA: GTRI

NEW DELHI, June 17: India's gold and silver imports from its free trade agreement (FTA) partner UAE have skyrocketed 210 per cent to USD 10.7 billion in 2023-24 and there is a need to potentially revise the concessional customs duty rates under the pact to mitigate the arbitrage driving this surge, a report said on Mon-

Economic think tank Global Trade Research Initiative (GTRI) said this sharp rise in gold and silver imports is primarily driven by import duty concessions granted by India to the UAE under the India-UAE Comprehensive Economic Partnership Agreement (CEPA).

India allows 7 per cent tariffs or customs duty concessions on import of unlimited quantities of silver and a 1 per cent concession on 160 metric tonnes of gold. CEPA was signed in February 2022 and implemented in May 2022.

Additionally, India facilitates gold and silver imports by allowing private firms to import from the UAE through the India International Bullion Exchange (IIBX) in Gift City. Previously, only authorised agencies could handle such imports, the report said.

"While India's total imports from the UAE fell 9.8 per cent from USD 53.2 billion in FY23 to USD 48 billion in FY24, imports of gold and silver skyrocketed 210 per cent, from USD 3.5 billion to USD 10.7 billion," it said.

"Import of all remaining products fell 25 per cent, from USD 49.7 billion in FY23 to USD 37.3 billion in FY24," it said.

Extreme heat melts diesel demand, sales drop 4 pc in June

NEW DELHI, June 17: India's diesel demand slumped in June as extreme heat conditions in parts of the country curtailed travel, preliminary data of state-owned firms showed on Monday.

Fuel sales, which traditionally surge during elections, have defied the trend this year, falling month after month. And the decline has now extended even after the end of the general elections.

Petrol sales of three state-owned firms, which control 90 per cent of the fuel market, at 1.42 million tonnes in the first half of June was almost the same as 1.41 million tonnes of fuel consumed in the same period last year. Month-onmonth consumption dropped 4.6 per cent. Diesel sales dropped 3.9 per cent to 3.95 million tonnes during June 1 to 15 when compared with the year-ago period. The demand for the nation's most consumed fuel had fallen 2.3 per cent in April and 2.7 per cent in March. In May it fell 1.1 per cent. Besides electioneering, the summer harvest season as also the scorching summer that increases the demand for air conditioning in cars, should have led to a rise in fuel consumption. However, this year has defied

"High import duties in India on gold, silver, and jewellery at 15 per cent are at the root of the problem. Consider lowering tariffs to 5 per cent. This will cut large-scale smuggling and other misuse," Sri-

Trade in gold, silver, and diamonds has been prone to misuse due to their low volume but high value and high import duties in

Low tariff imports of gold, silver only benefit few importers who keep all profits arising through tariff arbitrage and never pass it to consumers, he said.

Srivastava suggested the government implement certain measures to help India balance its trade policies, protect domestic revenue, and ensure fair competition in the import of precious metals and jew-

It suggested reassessing and potentially revising the concessional duty rates under CEPA to mitigate imports of gold and silver. "At least, implement yearly import quotas (tariff rate quotas) for silver, similar to those for gold, to control the volume of imports and prevent revenue loss," it said, adding that India should rigorously verify the claimed value addition by Dubai-based refiners in gold and silver imports to ensure compliance with CEPA rules of origin.

It also asked to tighten regulations around the India International Bullion Exchange (IIBX) at Gift City to control the volume and nature of precious metal imports and the exchange should not allow country-based exemptions.

As increased imports contribute to a higher current account deficit and since gold and silver act more like financial instruments than regular trade items, India should avoid including them in any FTA.

"India has granted tariff concessions for these items in many FTAs and under the DFTP (duty-free tariff preference) scheme, so a comprehensive review is needed.

India announced the scheme for

duty free/preferential market access on about 98.2 per cent of India's tariff lines (or product categories).

Further, the report stated that silver imports from the UAE increased multifold to USD 1.74 billion in 2023-24 from a meagre USD 29.2 million in 2022-23 due to India charging an 8 per cent duty under the CEPA versus a 15 per cent duty from other countries.

"The large 7 per cent tariff arbitrage resulted in a loss of revenue for India of ₹ 1,010 crore in FY24. Revenue loss will increase as India has committed to make tariffs zero on unlimited quantities of silver from the UAE within next 8 years," it added.

It said this trade is unusual because the UAE just imports large silver and gold bars, melt and convert these into silver grains and unwrought gold for exports.

"A check with global refiners will show that value addition in such process is much less than 1 per cent as opposed to 3 per cent required under the FTA," it said.

On gold bars, the report said India agreed to import 200 metric tons of gold annually from the UAE with a 1 per cent tariff concession and due to this gold imports rose 147.6 per cent from USD 3 billion in FY23 to USD 7.6 billion in FY24, causing India to lose ₹ 635 crore in revenue in

Similarly, India's jewellery imports have increased 187.6 per cent from USD 1.1 billion in FY23 to USD 3.3 billion in FY24, whereas these imports from the UAE have increased 290 per cent from USD 347 million in FY23 to USD 1.35 the arbitrage driving the surge in LDCs (least developed countries) billion in the last fiscal. A woman in Noida has claimed she has found a centipede inside an ice cream tub she ordered through an instant delivery app, said food safety officials, who have launched a probe into the matter.

In a post on X on June 15, the woman, who identified herself as Deepa Devi, shared a picture showing the insect inside the ice cream tub.

Gujarat Cooperative Milk Marketing Federation (GCMMF), which markets dairy products under Amul brand, regretted the inconvenience caused to the woman customer in Noida.

Noida's food safety department has launched a probe into this matter. In a statement, Amul said it immediately responded to the complaint on social media. "We deeply regret the inconvenience caused to her

because of this incident," the statement said. Amul said its team was trying to contact the customer continuously and was allowed to meet after 9:30 pm on the same day (June 15).

"During our meeting with the customer, we had requested the customer to provide the said ice cream tub for investigation, unfortunately, the customer refused to hand over the same

"Unless the complaint pack is retrieved from the customer it would be difficult for us to investigate the matter and hence comment specifically on the issue which involves pack and supply chain integrity as well," Amul said.

During the interaction, the customer was informed

minor injuries, Vaishnaw posted on X. Vaishnaw informed that the Commissioner of Railway Safety (CRS) has started a probe into the cause of the accident. Vaishnaw added that measures will be taken to prevent a recurrence of the circumstances that led to the accident.

According to preliminary information received from railway officials, the passenger train was stationary on the tracks when the goods train rammed into it from behind. While two rear compartments of the Kanchaniunga Express were immediately thrown off the tracks under the severe impact, another bogie was seen precariously hanging mid-air with the engine of the goods train tucked underneath. Inclement weather in the region posed an additional challenge to the rescue operations, the officials said.

The accident triggered haunting memories of the Coromandel Express disaster near Bahanaga Bazar in Odisha a year ago, which killed nearly 300 people and injured over a 1,000 others. The 13174 Kanchanjunga Express was bound for Sealdah from Agartala when the accident occurred around 9 am, the railway official said.

No Fault of goods train: The goods train that rammed into the Kanchanjunga Express between Ranipatra Railway Station and Chattar Hat Junction in West Bengal on Monday was allowed to cross all red signals as the automatic signalling had "failed", internal documents show.

The document, a written authority called TA 912, was issued to the driver of the goods train by the station master of Ranipatra, authorising him to cross all red signals, a railway source said. "Automatic Signalling has failed and you are hereby authorized to pass all automatic signals between RNI (Ranipatra Railway Station) and CAT (Chattar Hat Junction)," says the authority letter. "The TA 912 is issued when there is no obstruction or any train on the line in the section, and it authorises the driver to cross red or caution signals. It is a matter of investigation why the station master did that. He might have been under the impression that the previous train crossed the station section and entered into another section," the railway source explained.

According to the source, the automatic signalling system between RNI and CAT was defective since 5.50 am Monday. Il-fated train restarts journey: Railway officials, meanwhile, confirmed that the ill-fated Kanchanjunga Express has begun its journey to Kolkata with passengers in the unaffected coaches. "The train has started from the accident site around 12.40 pm and is expected to reach Sealdah at 8 pm," Kaushik Mitra, CPRO, Eastern Railway, told reporters. Long-distance train services from north Bengal and the northeastern part of the country were affected due to the accident. Eastern Railway officials in Kolkata said route diversions of several long-distance trains were being made through the Siliguri-Bagdogra-Aluabari zone instead of their usual route, as the tracks remained blocked at the accident site.

Among the trains diverted were the Guwahati-Saraighat Express, Guwahati-Bengaluru Express, NJP-Howrah Vande Bharat, Kamrup Express and Uttarbanga Express, the officials said. West Bengal government officials said additional bus services were being introduced from the region on an emergency basis to transport the affected commuters. BJP MP from Darjeeling Raju Bista was among the leaders who rushed to the spot to oversee rescue operations. A passenger from Agartala, who was in coach number S6 of the Kanchanjunga Express, said he felt sudden jerk and the compartment screeched to a halt. He also claimed that the relief and rescue operations were delayed. "My wife, child and I somehow managed to come out of the mangled coach. We are currently stranded... The rescue operations also started quite late," the passenger told a television channel. (With inputs

"But Indian EVMs are custom designed, secure and isolated from any network or media - No connectivity, no Bluetooth, wifi, Internet. ie there is no way in. Factory-programmed controllers that cannot be reprogrammed," Chandrasekhar said in a post on X. "Electronic voting machines can be architected and built right as India has done. We would be happy to run a tutorial Elon," the BJP leader added. (PTI)

Busting five myths about eco-friendly eating SINGAPORE, June 17: Choos-

ing food that is both healthy and good for the planet can be confusing. Here are five myths to avoid to help you make better choices. "Organic beef", "GMO-free" and "100 per cent natural" are just some of the countless claims designed to attract the eyes of eco-conscious consumers in the supermarket.

Yet while people are increasingly willing to spend more on these labels, there is often not enough consideration of how much these features actually contribute to a food's environmental sustainability. It's understandable why consumers are confused. Determining the environmental impact of different food products is highly complex — influenced by how much resources and energy they consume, greenhouse gases they emit, the way they impact the biodiversity of the area where they are produced, how and how far they are transported to market, and the amount and type of waste they create. Despite this, the basic characteristics of a diet that would benefit both human health and the planet are clear. At least half of our daily calorie intake should come from fruits, vegetables, wholegrains, legumes, nuts, and seeds while significantly limiting red meat and energy-dense, nutrient-poor foods such as sugar and refined grains.

Unfortunately, typical Western diets are far from this ideal and many economic, political, and societal factors contribute to this discrepancy, making it a difficult



issue to address.

However, tackling the psychological barriers that prevent the public from consuming more sustainably can help improve their behaviour. The first step towards doing this is addressing the significant lack of knowledge consumers have about what makes a food choice eco-friendly.

Here are five common food myths that need to be busted: Myth 1: "Meat's eco-footprint

is exaggerated" Animal husbandry is one of the most environmentally-damaging activities in food production due to its high greenhouse gas emissions, extensive resource use, and the pollution it causes.

Consequently, the most impactful change a person can make to reduce their dietary ecological footprint is to limit animal-based foods, particularly beef. Many people underestimate the environmental impact of meat, eggs, and dairy and doubt the environmental benefits of substituting them with plant-based alternatives.

Additionally, there is a widespread but mistaken belief that reducing car and plane travel, conserving electricity, recycling, and avoiding plastic are more significant to one's climate footprint than reducing animal-based food consumption.

Myth 2: "Organic and local always equals sustainable"

People often assumes that organic and local production is the gold standard for sustainability as it can reduce chemical use and lower transportation emissions. However, this perspective re-

guires more nuance. For example, organic tomatoes grown in open fields can have higher environmental impacts due to increased fuel and machinery use.

Similarly, locally grown tomatoes, especially in heated greenhouses, can be less sustainable

Naidu returns revives Amaravati dream

he political landscape of Andhra Pradesh is once again in flux with the fate of Amaravati hanging in the balance. Chief Minister Chandrababu Naidu has embarked on a mission to develop Amaravati as the state's capital, a task he has five years to accomplish amidst the unpredictable nature of electoral politics. The previous tenure of Jagan Mohan Reddy had stalled Amaravati's development, favouring a three-capital proposal, which left the farmers of the region in prolonged protest. Now, with Naidu back in power, the Amaravati dream has been revived, but the clock is ticking. Amaravati's journey to becoming the capital city began with the acquisition of 33,000 acres of farmland from 29 villages under Naidu's earlier administration. The plan, designed with input from Singapore, envisioned a grand capital for Andhra Pradesh. However, Jagan Mohan Reddy's tenure saw a dramatic shift with his proposal to distribute the administrative, judicial, and legislative functions across Visakhapatnam, Kurnool, and Amaravati respectively. This move led to a 1,631-day protest by Amaravati's farmers, demanding the original plan be upheld.

The change in government has once again altered the trajectory. Naidu's return has brought hope to the farmers, who have dismantled their protest camps and are optimistic about Amaravati becoming the sole capital. Naidu's commitment was evident during his swearing-in ceremony, where he reiterated that Amaravati would be the one and only capital, although Visakhapatnam and Kurnool will still see significant development. This decision has broader implications, notably for Prime Minister Narendra Modi and the BJP. The TDP, BJP, and Pawan Kalyan's Jana Sena are aligned in supporting Amaravati's capital status. This alliance, which had laid the foundation stone for Amaravati back in 2015, hinges on the successful realization of this vision. Modi's government has a vested interest in the success of Amaravati, as it symbolizes the promises made to the state and the fulfillment of developmental goals that could influence voter sen-

The BJP-led NDA coalition is not without its challenges. Modi's leadership has faced setbacks in other states like Maharashtra and Uttar Pradesh, highlighting the volatility of political fortunes. Ensuring the development of Amaravati could bolster Modi's image and provide a tangible success story for the coalition. However, the pressure is on both Modi and Naidu to deliver. Failure to do so could have significant political repercussions, potentially affecting their hold on power in upcoming elections. The stakes are high. For Naidu, transforming Amaravati into a thriving capital city within five years is not just a promise to the farmers but a political imperative. For Modi, supporting this project aligns with his broader developmental agenda and could strengthen his coalition's standing. The intertwining of their political fates with the fate of Amaravati underscores the critical nature of this venture. The development of Amaravati as the capital city of Andhra Pradesh is a litmus test for both Chief Minister Chandrababu Naidu and Prime Minister Narendra Modi. The next five years will be crucial in determining whether Amaravati's promise can be realised and if the political fortunes of Naidu and Modi will flourish or falter. The electorate has shown that continuity is never guaranteed, making the successful development of Amaravati a significant factor in the political stability and legacy of both leaders.

By far the biggest takeaway from the 2024 general elections for India is that the ruling coalition will no longer be able to amend the Constitution and convert the country from a secular State to a Hindu Rashtra. During the election campaign, the Prime Minister of India memorably said, "Ram is my idea of India." The people of India have denied him the opportunity to see his dream come true through an amendment to the Constitution.

Lallu Singh, the Bharatiya Janata Party (BJP) candidate from Faizabad (Ayodhya), who made a remark that his party wanted 400 seats to amend the Constitution or introduce a new one, lost the election.

The present coalition government of the National Democratic Alliance (NDA), will also not be able to amend the Constitution by deleting Article 16, which gives reservations in public employment to socially and economically backward classes.

The core of the Constitution will remain protected. The people of India have not just exercised their franchise, what we saw was the closest thing to a referendum on the basic features of the Constitution

The question looming large in people's minds was whether we will remain a secular nation or become a nation governed by Sanatan Dharma.

India has chosen to retain the core of the Constitution, which is secular, democratic and republican. Those who wanted to replace the system of governance with their version of "Ram Rajya" have been defeated.

Those who wanted to set up the norm of 'cultural nationalism', whatever that means, above the Constitution in the name of decolonisation of the country, have lost the unjust ideological

The Constitution is the end product of the aspirations of India's Independence movement and to deny the legitimacy of the Constitution in the name of decolonisation was an attempt to deny the sacrifices of the freedom fighters and those who led India to Independence.

torate. The Constitution is not a colonial document, far from it; it makes a break with obscurantism and entranced hierarchies and inequalities constructed by Brah-

Tradition and convention demands that law officers of the government of India resign even if they are to be continued by the incoming government. So far, we have not seen the Attorney General for India or the Solicitor General of India or the Additional Solicitors resign. This was required to be done by them.

In the recent past, we have seen the critical role of law officers of the government of India in courts eroded by their inability to take an independent stand from the government they repre-

They seem to have forgotten that they do not take instructions from the government but advise the government. In my wish list, I would like to see this happen.

We are entitled to ask who will be the Attorney General for India, who will be the Solicitor General of India and who will be the other law officers of the incoming government. At the very least, they must not be people who deny the legitimacy of the Constitution of India and its basic features.

It has been famously said that when there is a strong government, the judiciary is weak. In recent years, we have witnessed ebb in the confidence people vest in the judiciary. Petitioners in jail have chosen to withdraw their petitions for bail rather than have them heard by certain judges known for their proclivity to

deny bail. Another recent trend, and an unfortunate one that cannot be trivialised, is the surge in criticism against the judiciary, bookmarked by the rising number of memes calling out the judiciary for its inability to uphold the fundamental rights of the people and toeing the government line in all major challenges to governmental action or legislation.

Only time will tell if the judiciary can regain its independent voice. For all our sakes, let us hope it does sooner than later. At present, there are two va-

cancies in the Supreme Court.

September 1 this year, when Justice Hima Kohli demits office. Thus, there are a total of three vacancies in the Supreme Court to be filled up before the current Chief Justice of India (CJI) Dr D. Y. Chandrachud retires on No-

vember 10 this year. We need to keep a watch on who will be appointed to these vacancies sooner or later. Can we hope to see those committed to the ideology of the Preamble to the Constitution be appointed, or will there be more Victoria Gowris alluding to two of India's minorities as "White Terror" and "Green Terror".

Who really decides who becomes a judge of the Supreme Court of India? In theory it is the collegium, we know, but why are candidates recommended by the collegium not being appointed.

Finally, let us look at the critical cases pending in the Supreme Court for decision:

• The validity of the Places of Worship (Special Provisions) Act, 1991 is pending before the Supreme Court. This case is of foremost importance since it is linked to the secularism of our country. The fate of litigation arising from the Gyanvapi mosque and the Krishna Janmabhoomi-ShahiIdgah case depends upon what the court will rule on the validity of Places of Worship

• The challenge to the validity of the Citizenship (Amendment) Act (CAA), 2019 is yet another crucial case. This case will de-

• The Supreme Court is yet to hear a challenge to the Chief Election Commissioner and Other Election Commissioners (Appointment, Conditions of Service, and Term of Office) Act, 2023, which excludes the CJI from the committee to appoint the Chief Election Commissioner and Election Commissioners.

• The validity of the Prevention Money Laundering Act, 2002 (PMLA) and also the correctness of the judgment in Vijay Madanlal Choudhary versus Union of India, in which a threejudge Bench upheld contentious provisions of the PMLA, likely

The law has been challenged on the ground that no illegal immigrants who entered Indian Territory after 1947 should be granted cit-

• The judgment of a sevenjudge Bench on the question whether the Aligarh Muslim University is a minority institution is also awaited. This case is directly linked to the interpretation of Article 30 of the Constitution, which confers the right on minorities to establish and administer educational institutions of their choice.

• The judgment on the power of state governments to sub-classify based on relative backwardness within the Scheduled Castes

(SC) and Scheduled Tribes (ST) is also awaited. It is likely to impact whether backward among the SCs/STs including de-notified tribes and Vimukta Jatis can be granted separate quotas within the SCs/STs quotas.

• The Supreme Court is yet to rule on the validity of Section 124A of the IPC, which provides for the offence of sedition.

All these laws entail violations of the right to life and liberty as guaranteed in the Constitution In addition, the challenge to the CAA goes to the very root of granting citizenship based on reigion alone.

We have seen very often that governments try to achieve through courts what they cannot achieve politically or on the floor of the legislature. At this point, it is not possible to see which way the court will lean or how it will

read the message of the elections. What kind of litigation is likely to reach the court after elections? We are likely to see petitions being filed by losing candidates challenging elections including on the ground that the winning candidate had campaigned on the basis of religion.

Finally, on a happy note, the pre-general elections period saw another election, the election of the president of the Supreme Court Bar Association (SCBA).

Senior counsel Kapil Sibal won by a majority of 1,070 votes. This appears to indicate that he has bridged the divide between the right and liberal constituencies at the Bar. This, by itself, is a healthy trend as it stopped the sharp polarisations we have seen at the Bar in the recent past

Since 2014, the ruling party has adopted a strategy to get things done through surrogates by filing petitions in courts to achieve a political aim. Hopefully, this trend will become a thing of the past.

One also hopes to see the SCBA at the forefront for undoing the damage that has been inflicted on civil liberties in this country in the last decade.

The journey must begin with a demand that the three new criminal laws are not implemented until there is a judicial audit of the implications of these laws for the citizens of India and access to

Increasing incidents of question paper leaks **NEET's inequities: A disrupted** cause stress and anxiety among students

candidates as well as their families are shattered. Such incidents shatter our collective dream and morale of building an advanced, prosperous, well-educated and strong nation and society. This creates a permanent feeling of dissatisfaction and disappointment towards the system among the youth, the influence of the government is reduced and the common people are disillusioned with the system. For the youth, competitive exams not only become a question of a bright future but sometimes of existence as well. Along with this, the credibility of the government is in danger. Many times, the involvement of big coaching centres and operators is also found in the matter of leaking the question paper. Cheating is becoming a nationwide business today, which has many beneficiaries and shareholders. The suspicious role or collusion of politicians to officials, question paper makers to coordinators, exam conducting institutions and commissions to exam centres cannot be denied.

Frequent incidents of question paper leaks have become a significant concern in India's education system. For example, more than 70 cases of question paper leaks were reported in 2023 alone, affecting various competitive exams including BCS, medical entrance exams. and state recruitment exams. These leaks have caused extreme stress and anxiety among students, hampering their preparation and confidence levels. Manual handling and security lapses are the major reasons for question paper leaks. The traditional method of printing and distributing question papers involves multiple touchpoints where security can be compromised. For example: In 2020, a manual handling mistake led to a critical error during the Bihar Public Service Commission exams. Criminal gangs involved in organized crime take advantage of the vulnerabilities in the examination system to reap increasing economic benefits. For example: In Rajasthan, a gang that leaked question papers of several exams was busted, earning crores of illegal revenue.

Technical vulnerabilities indicate that poorly secured digital systems

can be hacked, leading to electronic tem. Today we need advanced security protocols to prevent question paper leaks. It is important to use tamperproof tracking and secure transport facilities for physical users. For example: The Central Board of Secondary Education (CBSE) has started using database digital resources, which are accessible only to authorized personnel on exam re-Using blockchain technology for

secure question paper management and distribution can be beneficial. For example: EduBlock uses ProBlock to ensure that the question paper is securely encrypted and decrypted only at the exam centre, significantly reducing the risk of leaks. A strict legal framework can enforce harsh penalties for individuals and organs involved in the leak. For example: The Public Examination (Prevention of Unfair Deaths) Bill, 2024, proposes harsh penalties including imprisonment and heavy fines. Regular training and strict accountability for examination staff can also be a measure. For example: Conducting regular audits and implementing monitoring systems to detect and prevent threats. Question paper leaks have a psychological impact on students. It leads to increased stress and anx-

iety among students. The inconvenience and irregularity caused by question paper leaks significantly increase stress and anxiety among students, affecting their mental well-being and exam performance. Students who have orked hard may feel that their achievements have been undermined, leading to a loss of confidence in the education system and their ability. Repeated incidents of paper leaks can depress students, leaving them disillusioned about their prospects and the value of merit-based success. After several leaks of state-level entrance exams in Bihar, many students began to feel disheartened and lost faith in the fairness of the education sys-

> are the need of the hour to reduce this psychological impact on students. Providing psychological support and counselling to students affected by the leak is imperative. For example: Setting up helplines and counselling centres to help students deal with stress and anxiety during exam time. Maintain regular communication about the efforts made to prevent leaks in future. Informing students and consumers about improved security measures and free schemes to rebuild trust. Rescheduling exams quickly with strong security measures is very beneficial to reduce the spread of illness from alternative exam schedules. Arranging localised question papers and adequate exam dates to avoid prolonged stress for students. Frequent incidents of question paper leaks undermine the reality of competitive exams and cause a lot of stress for students.

> Since the problem of question paper leak is becoming uncontrolled, it should be the first and foremost responsibility of the governments of various states including the Centre to not let the incidents of question paper leak recur and take strict action against the culprits. Along with this, they should make such arrangements on a priority basis, so that there is no scope for question paper leaks. It is difficult to understand why it is difficult to make such a system in this age of information technology. Unfortunately, there is no way to solve many problems in the education sector. One of these is the problem of question paper leaks. There is hardly any state where the matter of question paper leaks of some competitive or regular examination does not remain in the headlines.

The Supreme Court's vacation Bench has issued Testing Agency (NTA) and the Central Government in response to pleas for a new NEET-UG 2024 examination, following allegations of a paper leak. The Bench emphasized the need for answers, stating, "The sanctity has been affected, and we need answers." Once again, this incident highlights that NEET may not be the most reliable method for evaluating stu-

Allegations of a paper leak have surfaced, suggesting some candidates might have received an unfair advantage. This has raised significant concerns about the test's integrity. Additionally, numerous students experienced technical issues, including poor network connectivity, at several centers, causing disruptions during the

An unexpectedly high number of candidates have achieved top scores, with 67 individuals scoring a perfect 720 and each attaining a 99.997129 percentile. Notably, six of these high scorers were from the same center, which has sparked suspicion. Additionally, the decision to award grace marks to approximately 1,560 candidates due to lost time has faced criticism, especially since the NTA did not reveal the formula used, despite the Supreme Court's 2018 ruling. The NTA stated that these candidates were compensated with grace marks.

NEET serves as a distinctive admission system for medical courses in India, requiring all aspiring students to pass this exam. The concept of a common entrance test was introduced by Murli Manohar Joshi during his tenure as the HRD Minister in the NDA government. This idea received some validation in the Supreme Court's judgment in the TMA Pai Foundation vs. State of Karnataka case in 2002.

NEET was introduced by the Medical Council of India (MCI) in 2010. However, in

2013, a three-judge majority in the Christian Medical College Vellore Association vs Union didates, compounded by transof India case invalidated lation errors in the question widespread criticism for being anti-student and potentially lowering medical education standards. Secondly, multiple tests would allow students to apply to specific institutions of their choice, offering more control over their admissions. However, with centralized NEET counseling, students may be placed in colleges they do not wish to at-

The NEET paper leak has impacted over 2.3 million canpaper. Additionally, fails to assess essential qualities for future doctors, such as compassion, empathy, and a passion for serving humanity. Moreover, relying on a single test is not an adequate measure. Global best practices consider qualifying exam marks, extracurricular activities, and the statement of purpose, providing a more holistic evalua-

NEET is often regarded as the best option by our judges and government because they believe it promotes merit. However, is there a true consensus on what merit actually means? British sociologist Michael Dunlop Young's book The Rise of the Meritocracy (1958) introduced the concept of 'meritocracy,' which requires competition and equal opportu-

> nity. Yet, can the NTA and judges genuinely believe that the complex notion of merit can quately measured

by a single test? When NEET and similar admission exams fail to meet this fundamental criterion, the competition is neither fair nor just, and equal opportunity becomes an illusion. Many Western scholars argue that common admission tests cannot assess essential learning abilities such as imagination, curiosity, and motivation. NEET undeniably has a class element, as evidenced by the Justice AK Rajan Committee, which uncovered clear signs of elitism. The Justice Rajan report on NEET's impact in Tamil Nadu provided substantial support for arguments against a single test. Among the 86,342 people surveyed by the panel, the majority opposed NEET. The introduction of NEET has reduced diversity in Tamil medical institutions, with the percentage of students from rural areas decreasing from 61.45%

Likewise, the proportion of candidates from government schools has decreased from 1.12% to 0.6%. Meanwhile, the dominance of Englishmedium students in medical education has intensified, rising from 85.12% to 98.01%. Economically disadvantaged students have also seen a decline, dropping from 47.42% to 41.05%. Additionally, there has been a decrease in firstgeneration learners. If similar committees are established in other states, comparable findings may emerge. In 2021, the Tamil Nadu Assembly passed a law opposing NEET, but it was returned by the Governor in 2022. Upon resubmission, the Governor has referred the bill to the President, who is un-

likely to give approval. Furthermore, the existence of a single national test like NEET has led to significant financial gains for commercial coaching institutes. These institutes, predominantly located in urban areas, pose a disadvantage to economically disadvantaged students from rural backgrounds or those educated in vernacular mediums. Another issue is the substantial disparity in syllabus content between CBSE and state boards. Testing unequal candidates through a single test like NEET undermines the princi-

ple of equality. It is crucial to redefine our understanding of merit in a way that embraces inclusivity and diversity within society. Merit should not become a tool for exclusion. Chief Justice DY Chandrachud aptly emphasized that the Constitution's transformative vision should not be overshadowed by misconceptions surrounding merit. The assessment of merit should align with its contribution to societal welfare. What foods are high in protein? Is India becoming the largest digital

nating foods high in protein has many benefits, including muscle building and feeling fuller after eating. Although eating lots of protein may be beneficial, eating a balanced diet is essential to staying healthy. Protein is an essential nutrient that is important in many bodily functions. It provides the building blocks for cells and helps to maintain muscle mass.

Most healthy adults need to consume at least 0.8 grams (g) of protein per kilogram of body weight (or 0.36 g per pound of body weight). However, an individual's protein goals may vary depending on physical activity level and medical history.

High protein foods

4. Tuna

Tuna is an excellent and widely available source of protein. It is also a great source of heart healthy unsaturated fatty acids.

One can (107 g) of tuna contains around 20.3 g of protein.

Canned tuna is a helpful pantry staple to keep on hand. It is shelfstable and relatively affordable compared to many other animal protein sources. A person can add tuna to salads, sandwiches, and snacks.

5. Bison

Bison meat is another excellent source of protein. Bison is lean meat, offering less fat per serving than beef. Bison is becoming more available, and some people use it as a substitute for beef. One 3 oz (85 g) of bison contains around 21.6 g of protein.

Lean pork is a good source of protein. Pork roasts and tenderloin are good choices for meals.

People should avoid processed pork products such as bacon because they are higher in saturated fat and sodium. One 4 oz (113 g) serving of pork contains around 19.1 g of protein.

right next to the tofu. 22. Spirulina

Spirulina is a bacteria that grows in both fresh and salt waters. It offers a variety of nutrients and protein from a small amount of its powdered form. One cup (112 g) of spirulina contains around 64.4 g of protein.

A person can add powdered spirulina to smoothies, salads, soups, and baked goods. Spirulina is also available in tablet form as a dietary supplement.

People can use hemp seeds in salads as a substitute for croutons. Hemp seeds offer about 9.48 g of protein per 3 tablespoons (30 g). They are fairly easy to find in most grocery stores but can be expensive.

24. Sun-dried tomatoes

Sun-dried tomatoes are an excellent addition to many dishes and are widely available. They offer protein, as well as additional nutrients and fiber.

One cup (54 g) of sun-dried tomatoes contains about 7.61 g of protein, though a person is unlikely to eat this many sun-dried tomatoes in a single meal or

snack. 25. Guava

With technological advancements in the last few decades, the medium of such participation is undergoing a notable change. Now, popular slogans are preceded by a hashtag, platforms like X (previously Twitter) have become the new 'nukkad' for citizens' issues, and social movements are accompanied by social media campaigns. so does how it is regulated. Earlier, section 144 was used to contain the public order. It is now functionally impossible without an internet shutdown.

Censorship once seemed enough to suppress speech, public communication, or the spread of information among citizens. However, new laws are being formed to regulate content on social media and OTT platforms. These questions indicate that a new saga of deliberative democracy and regulation has begun.

As technology permeates not only socio-economic but also political life, it becomes increasingly vital to grasp the concept of citizenship in the digital world. While the socio-economic dimension of digital citizenship is often discussed through issues like the digital divide, digital literacy, competition laws, and online welfare schemes, the political sphere remains the least explored. Understanding digital citizenship is not just about being aware of our rights and responsibilities online, but also about actively participating in shaping the digital landscape.

Like Mike Ribble (Nine Elements of Digital Citizenship), writers have defined digital citizenship as "norms of appropriate, responsible behaviour regarding technological use".

While it is important to recognize the duties of a citizen in an online world, it is also equally important to recognize their rights, especially in terms of political participation. However, the digital sphere also poses unique challenges, such as the spread of fake news and the potential for online harassment, which need to be addressed in any discussion of digital citizenship.

What future beholds?

The question is how democratic participation can be ensured in digital politics, especially in a country like India.

The future of digital citizenship in India hinges on the technology policy framework that is being developed. The impact of these legislations will lay the foundation of the country's digital sphere and determine how citizens can participate in the online world. The right to participate in the daily affairs of the state, deliberate upon the pressing issues, and voice one's concerns and opinions form the basic structure of citizenship in a democratic

Pets bring infinite joy and companionship to our lives – but there are also downsides

wning a pet can be a roller coaster. There are the highs, like when your dog greets you with a full-body wiggle when you return home, or when your cat purrs loudly as you cuddle next to one another. Then there are the lows, like stressful trips to urgent care, waking up to that unpleasant vomiting noise, or making the difficult choice to say goodbye because of medical problems or even intractable

behavioral issues. For those pet-owners who are struggling, it's beneficial to their mental health to acknowledge that pets can create stress and that some animals are more work than others. Research has shown that both cats and dogs can have equally positive impacts on mental

health. Pets may be helpful at reducing stress, anxiety and feelings of being overwhelmed, including in children. Pet ownership has also been shown to improve well-being by instilling people with a sense of purpose and responsibility. As a licensed clinical social worker. animal lover and proud dog mom, I have both professionally and personally seen the mental health impacts of hav-

ing animal companions. Media stories commonly cover the positives of pet ownership. But the hardships and downsides of owning a pet are not discussed as often. For instance, while there are many positive aspects to pet ownership, some research is showing that pets may lead to exacerbated mental health concerns or even

sleep issues. Whether you're adopting or shopping, pets can bring a full range of emotions into our lives. Research has even shown that pets may benefit non-pet

owners around them as well. Pets enrich lives

A pet owner may easily be able to tick off an infinite number of positive effects their fuzzy companion has had on their

life. Research backs them up. Pets can provide constant companionship for individuals and families. This particularly true for older adults. There was an uptick in adoptions of pets during the early days of the Covid-19 pandemic. Many people benefited from pets during periods of stay-at-home

mandates and quarantines. Research shows that dogs can reduce loneliness in their owners. In fact, being accompanied by a dog may even make you seem more approachable.

Pets, especially dogs, may help improve one's ability to socialise and feel connected with others, as well as increasing the prospects for social interactions. People may bond over the experience of having pets, socialize at the dog park, or even meet up at the local cat café.

Animals and pets have also been used to assist in detecting the onset symptoms of medical episodes, including seizures. Animal-assisted therapy and pet therapy have shown promise in im-

proving symptom management and overall quality of life in a number of conditions, including trauma and stressor-related disorders, anxiety disorders, eating disorders, autism, traumatic brain injuries, neurological disorders and

Inherent stressors Despite the many positive impacts of pet ownership, it also can have negative impacts. For example, one survey found that 47% of Americans felt separation

anxiety when leaving their dogs at The survey also found that 41% of pet owners declined social invitations because they did not want to leave their dog at home, and that 70% of pet owners would prefer to work remotely so they could stay at home with their pet. Pet owners have also identified feeling anxious about their pet getting sick or running away, or the risk that they

might harm the animal unintentionally. Stress from pet ownership is common. There's the stress of house-training and making sure the pet is getting enough enrichment – both physically and mentally. Then there are the challenges associated with vet appointments and navigating illness, as well as financial stressors and finding pet sitters.

Another element of pet ownership that people often don't talk about is the stress, and often shame, that owners with reactive dogs experience from walking their dog, having people over to the house or having their dog around

Finally, there's the reality that our pet companions live shorter lives than we do, leading to end-of-life planning, expensive treatments for older-age ailments, and, of course, the grief that will be felt from the loss of a pet. For some people, the loss of a pet may feel worse than human loss. People may judge or criticize pet

owners for an "overblown" grief reaction. The common experience of invalidation and lack of acknowledgment related to grief around pet loss – similar to the grief felt from divorce and miscarriage – is categorised as disenfranchised grief. This term refers to grief that is not acknowledged, validated or

accepted socially. Strings attached

Pet owners, especially post-pandemic, have reported high levels of guilt related to leaving their pets at home while at work or social events.

Some of this guilt may be related to concerns about providing insufficient attention to the pet or about the pet's health. This guilt has even been shown to be similar to the feeling human parents have concerning their human chil-

As someone who adores their dog, I can relate to the guilt of leaving him alone. To complicate things, my dog has joint issues, anxiety and discoid lupus, a type of lupus that affects the skin on his nose. He can also be reactive. All of these aspects require me to provide extra care. When friends invalidate my worries and guilt, it can feel isolating and shaming.

And I'm not alone in these feelings. Overall, when there is a lack of consideration for the complex feelings pet owners experience, the invalidation and disenfranchised feelings can lead to depression, anxiety, feelings of being iso-

lated and worsened quality of life. Finding support

The human-animal bond is unique, with humans receiving unconditional love and full acceptance from their animal companion. When society can honour and respect this bond through validation, patience and compassion, it not only helps pet owners but also the

clinicians who treat the animals. Employers can be supportive by continuing to provide remote and hybrid work options, flexibility in scheduling and opportunities for employees to feel validated and receive support. If a loved one is experiencing guilt around leaving their dog at home or a friend is having anxiety about their cat's health, instead of minimizing their experience, try talking to them and asking how best to sup-

port them through their distress. Another support tool is encouraging pet owners to practice self-compassion and mindfulness, being present and focusing on the time they do have with

Pets can bring infinite joy and companionship to our lives, whether that's through pet ownership, fostering, volunteering or engaging in animal-assisted therapy.

It remains important, however, to acknowledge the stressors and difficulties pet owners face. After all, the ups and downs of pet ownership, just like the ups and downs of the human experience, are what make life and relationships that much more meaningful. (Courtesy: Scroll.in)

Israeli officials say Netanyahu has dissolved the War Cabinet after key partner bolted govt

Prime Minister Benjamin Netanyahu dissolved the influential War Cabinet tasked with steering the war in Gaza, Israeli officials said Monday, a move that comes days after a key member of the body bolted the government over frustrations surrounding the Israeli leader's handling of the war.

The move was widely expected following the departure of Benny Gantz, a centrist former military chief, earlier this month. Gantz's absence from the government makes Netanyahu more dependent on his ultranationalist allies to govern and the dissolution of the War Cabinet underlines that shift as the eight-month-long war in Gaza drags on.

The officials, who spoke on condition of anonymity because they were not authorized to discuss the change with the media, said that going forward Netanyahu would hold smaller forums with some of his

That includes his security Cabinet, where far-right governing partners who oppose cease-fire deals and have voiced support for reoccupying Gaza, are mem-

Chinese premier agrees with Australia to 'properly manage' differences

MELBOURNE, June 17: Chinese Premier Li Qiang said he agreed with Australian Prime Minister Anthony Albanese on Monday to properly manage their nations' differences as they emerge from a hostile era in which minister-tominister contacts were banned and trade barriers cost Australian exporters up to 20 billion Australian dollars (USD 13 billion) a year.

Li, Albanese and senior ministers of both administrations met at Parliament House to discuss thorny issues, including lingering trade barriers, conflict between their militaries in international waters and China's desire to invest in critical

Li, China's most senior leader after President Xi Jinping, arrived in the South Australian state capital of Adelaide on Saturday and the national capital of Canberra late Sunday in the first visit to the country by a Chinese premier in seven years. Li told reporters after Monday's meeting that the bilateral relationship was "on the right track of steady improvement and development.'

We ... had a candid exchange of views on some differences and disagreements and agreed to properly manage them in a manner befitting our comprehensive strategic partnership," Li said through an interpreter.

Albanese, who in November last year became the first Australian prime minister to visit China since 2016, described

the discussions as "constructive."

"Australia advocates that we should all work together to promote a regional balance where no country dominates and no country is dominated," Albanese said.

"I've made it clear as nations with different histories, political systems and values, we will cooperate with China where we can, disagree where we must and engage in the national interest," the Australian leader added.

Their relations have improved markedly since Albanese's center-left Labor Party was elected in 2022 following nine years of conservative government in Australia.

Most of the official and unofficial trade barriers Beijing introduced in 2020 on coal, cotton, wine, barley and wood have been lifted since Albanese was elected. Beijing had banned minister-tominister contacts as it froze out the pre-Australian diplomatically.

Agriculture Minister Murray Watt said before the meeting that he would raise the issue of China's ban on Australian rock lobsters and exports from

two beef processing plants. "The mere fact that we have the first visit by a Chinese premier, the secondmost powerful person in China, ... since 2017 is an enormous opportunity to continue that dialogue, to continue stabilizing our relationship and address some of the outstanding issues," Watt said.

Li was served lobster at a business lunch with winemakers on Sunday and wagvu beef at a state lunch Monday. news media reported. Li planned to underscore China's interest in buying a bigger stake in Australia's critical minerals sector, which is essential to the global transition to renewable energy sources, by visiting a Chinese-controlled lithium processing plant in Western Australia state Tuesday

Li visited New Zealand before Australia and is scheduled to stop in Malaysia late Tuesday before returning to China.

Australia shares US concerns over China's global dominance in critical minerals and control over supply chains in the renewable energy sector.

Citing Australia's national interests, Treasurer Jim Chalmers recently ordered five Chinese-linked companies to divest their shares in the rare earth mining company Northern Minerals. (AP)

EU leaders are gathering to discuss nominees for the bloc's top jobs after an election shakeup

BRUSSELS, June 17: The 27 leaders of the European Union gather in Brussels on Monday evening to take stock of recent European election results and begin the fraught process of dividing up the bloc's top jobs, but they will be playing their usual political game with a deck of reshuffled cards.

The June 6-9 elections saw the European Parliament shift to the right and dealt major blows to pro-European governing parties in Paris and Berlin. The Franco-German motor that usually propels EU politics along was weakened, and new dynamics could be on show at the informal dinner.

Under the EU's complicated division of powers, the presidents and prime ministers get to nominate the next head of the bloc's powerful executive branch, the European Commission, which is responsible for drawing up EU policy on everything from climate to the colossal shared

Under the EU's treaties, their choice should take into account the results of the election.

German conservative Ursula von der Leyen looks likely to stay on as president for another five years after a strong showing for her centre-right European People's Party parliamentary group.

In an interview with Germany's Welt TV on Saturday, Chancellor Olaf Scholz said, "It is clear after the results of the elections that everything indicates that there can

von der Leyen." He said he believes the top job nominations could be agreed "quickly".

Von der Leven, at the helm of the EU since 2019, led a huge drive during the pandemic to secure billions of COVID-19 vaccine doses, set up a historic post-pandemic economic recovery fund and, from 2022, drummed up support for Ukraine in its war with Russia and extended a hand to Kyiv to join the bloc.

But nothing is guaranteed. Von der Leyen's presidential style has at times riled her commission colleagues, and she is deeply unpopular in some corners of the EU Parliament, where she will need the support of 361 of the 720 lawmakers to

are that of European Council president, held by Belgian centrist Charles Michel, and EU foreign policy chief, occupied by Josep Borrell of Spain from the centre-left. The council president's job is to broker deals between the 27 member states, while the top diplomat represents the EU on the world stage.

In Brussels, names for the big posts have circulated for months. Former Portuguese Socialist Prime Minister António Costa is frequently mentioned to become counpresident. Estonian Prime Minister Kaja Kallas, well known for her tough line on Russia, has been floated as the bloc's potential top diplomat.

French President Emmanual Macron said the aim Monday is "to

try to have a quick consensus. But perhaps we need to wait until June 27-28," when the leaders meet again in Brussels for a formal EU summit.

"I don't want to preempt things," Macron said on Saturday. "These discussions are happening with 27 of us, so we have advanced, several of us have called each other, and I think it's possible. I think it's possible in the days to come, or in the week to come.

Von der Leyen's own path to power in 2019 shows that the tussle over EU top jobs can be unpredictable. Then a German defense minister somewhat tainted by scandal in her ministry, von der Leven was a relative unknown in Brussels when her name was raised by leaders in closed-door discussions. (AP)

China blames Philippines for a ship collision in the South China Sea, which Manila says is deceptive



TAIPEI, June 17: A Chinese vessel and a Philippine supply ship collided near the disputed Spratly Islands in the South China Sea on Monday, China's coast guard said, in the latest flare-up of escalating territorial disputes that have sparked alarm.

The coast guard said a Philippine supply ship entered waters near the Second Thomas Shoal. a submerged reef in the Spratly Islands that's part of territory claimed by several nations. The Philippine military called the Chinese coast guard's report "deceptive and misleading"

The Chinese coast guard said in a statement on the social media platform WeChat the Philippine supply ship "ignored China's repeated solemn warnings ... and dangerously approached a Chinese vessel in normal navigation in an unprofessional manner, resulting in a

collision" "The Philippines is entirely responsible for this," it added. In Manila, the Philippine military said it would "not discuss operational details on the legal humanitarian rotation and resupply mission at Ayungin Shoal, which is well within our exclusive economic zone".

It used the Philippine name for the shoal, where Filipino navy personnel have transported food, medicine and other supplies to a long-grounded warship that has served as Manila's territorial outpost.

"We will not dignify the deceptive and misleading claims of the China coast guard," military spokesperson Col. Xerxes Trinidad said. "The main issue remains to be the illegal presence and actions of Chinese vessels within the Philippines' exclusive economic zone, which infringes on our sovereignty and sovereign rights."

tions of the CCG are escalating tensions in the region," Trinidad said. The Philippines says the shoal, which lies less than 200 nautical miles (370 kilometers) from its coast, falls within its internationally recognized exclusive economic zone and often cites a 2016 international arbitration ruling that invalidated China's expansive claims in the South China Sea based on historical grounds.

Several incidents have happened in recent months near the shoal, where the Philippines maintains an outpost aboard the BRP Sierra Madre, which had been encrusted with rust since it was deliberately grounded in 1999 but remains an actively commissioned military vessel. meaning an attack on it could be considered by the Philippines as an act of war.

China has increasingly become assertive in pressing its claim to virtually the entire South China Sea, which has led to a rising number of direct conflicts with other countries in the region, most notably the Philippines and Vietnam. A new law by China, which took effect Saturday, authorises its coast guard to seize foreign ships "that illegally enter China's territorial waters" and to detain foreign crews for up to 60 days.

The law renewed a reference to 2021 legislation that says China's coast guard can fire upon foreign ships if necessary. At least three coastal governments with claims to the waters - the Philippines, Vietnam and Taiwan - have said they would not recognise the law.

The territorial disputes have strained relations and sparked fears the conflict could bring China and the United States, a longtime treaty ally of the Philippines, into a military con-

Pak govt vows clampdown

on 'anti-state' social media

ISLAMABAD, June 17: Urging jailed former Pakistan prime minister Imran Khan's party to quit its "anti-state activities and propaganda", the government has warned that it would clamp down on those involved in running anti-state smear campaigns on social media in a bid to damage the country's ties with friendly nations.

Addressing a press conference on Sunday, legal affairs spokesperson Ageel Malik said there was no precedent to Pakistan Tehreek-e-Insaf's (PTI) "enmity as it was perpetrating anti-Pakistan legislation in foreign countries", the Geo News

'Pakistan is an independent country and does not take dictation from any nation. We want friendly relations with all nations. However, a concentrated smear campaign against Pakistan in foreign countries that started after the 2022 vote of no confidence which mounted the anti-Pakistan propaganda," he said. Malik alleged that PTI has hired lobbyists and PR firms to promote anti-Pakistan campaigns abroad and warned that the government would clamp down on those involved in running anti-state campaigns on social media in a bid to damage Pakistan's ties with friendly countries.

The spokesperson urged PTI to quit its "anti-state activities and propaganda" and hold dialogue with the government on political issues to mull over solutions instead of damaging the nation's interest at global forums, the report said. Malik claimed, "All anti-Pakistan legislation is done on the behest of PTI and overseas Pakistani diaspora who have strong affiliation with this party are being misused for this clandestine motive of PTI."

Khan-led PTI has questioned the outcome of the February 8 general elections in Pakistan, alleging that its mandate from the people was "stolen" by the Pakistan Muslim League-Nawaz party, Pakistan Peoples Party and its allies, who formed a coalition government to keep the former prime minister out of power.

Citing examples, he said in May 2023, 65 American congressmen wrote a letter to the US Secretary of Defence to prioritise the promotion of the protection of human rights and democracy in Pakistan. Again in November 2023, 11 congressmen wrote a letter to the US Secretary of State "to sus-

MOSCOW, June 17: The espionage trial in Russia of Wall Street Journal reporter Evan Gershkovich will begin on June 26 and will be held behind closed doors, a statement from the court that will hear the case

Gershkovich, a US citizen, has been behind bars since his March 2023 arrest and faces 20 years in prison if convicted.

The trial is to be held in the Sverdlovsky Regional Court in Yekaterinburg, Russia's fourthlargest city, where he was arrested. Gershkovich has since been held in Moscow's Lefortovo prison, about 1,400 kilome-

ters (870 miles) to the west. The court said trial will be closed to the public, as is usual in espionage cases.

Gershkovich, 32, is accused of "gathering secret information" on orders from the CIA about Uralvagonzavod, a facility that produces and repairs military equipment, the Prosecutor General's office said last week in the first details of the accusations against him.

The reporter, his employer and the US government have denied the allegations, and Washington designated him as

wrongfully detained. Russia's Federal Security Service alleged that Gershkovich was acting on US orders to collect state secrets but provided no evidence to back up the accusations.

"Evan has done nothing



wrong. He should never have been arrested in the first place. Journalism is not a crime," US State Department spokesman Matthew Miller said last week. "The charges against him are false. And the Russian government knows that they're false. He should be released immediately." The Biden administration has sought to negotiate Gershkovich's release, but Russia's Foreign Ministry said Moscow would consider a prisoner swap

only after a trial verdict. Uralvagonzavod, a state tank and railroad car factory in the city of Nizhny Tagil, about 100 kilometers (60 miles) north of Yekaterinburg, became known in 2011-12 as a bedrock of support for President Vladimir Putin.

Plant foreman Igor Kholmanskih appeared on Putin's annual phone-in program in December 2011 and denounced mass protests occurring in Moscow at the time as a threat to "stability." proposing that he and his colleagues travel to the Russian

rest. A week later, Putin appointed Kholmanskikh to be his envoy in the region.

Putin has said he believes a deal could be reached to free Gershkovich, hinting he would be open to swapping him for a Russian national imprisoned in Germany. That appeared to be Vadim Krasikov, who is serving a life sentence for the 2019 killing in Berlin of a Georgian citizen of Chechen descent.

Asked by The Associated Press about Gershkovich, Putin said the US is "taking energetic steps" to secure his release. He told international news agencies at an economic forum in St. Petersburg in early June that any such releases "aren't decided via mass media" but through a "discreet, calm and professional approach."

"And they certainly should be decided only on the basis of reciprocity," he added, in an allusion to a potential prisoner swap. Gershkovich was the first US journalist taken into custody on espionage charges since eign journalists in Russia, even though the country had enacted increasingly repressive laws on freedom of speech after sending troops into Ukraine. Consensus prevailed on LS Speaker's choice since Independence

NEW DELHI, June 17: If the opposition forces an election to the post of Speaker of the Lok Sabha next week, it would be the first such instance in the history of Independent India as the presiding officer has always been chosen by a consensus.

Elections to the post of the Speaker of the Central Legislative Assembly, as Parliament was called in the pre-independence days, were held for the first time on August 24, 1925 when Swarajist Party nominee Vitthalbhai J Patel won the coveted post against T Rangachariar.

Patel, the first non-official member to be elected as the Speaker, won the maiden election with a narrow margin of two votes. Patel had polled 58 votes against 56 garnered by Rangachariar.

Buoved by its increased strength in the Lok Sabha, the opposition INDIA bloc is now aggressively demanding the post of the Deputy Speaker, which by convention is held by a member of an opposition

"We will force a contest for the post of Lok Sabha Speaker if the government does not agree to have an opposition leader as Deputy Speaker," a senior Congress leader

The first session of the 18th Lok Sabha will begin on June 24 during which new members of the Lower House will take oath and the

The INDIA bloc won 233 seats in the Lok Sabha elections, while the BJP-led NDA won 293 seats to retain power for the third consecutive term. The Telugu Desam Party (TDP) with 16 seats and Janata Dal (U) with 12 seats are the biggest allies of the BJP which won 240 seats.

The opposition bloc is also egging on BJP ally TDP to insist on the post of the Lok Sabha Speaker or face gradual disintegration of the party. "We have the experience that the BJP betrays the people who support it," Shiv Sena (UBT) leader Sanjay

Raut said in Mumbai on Sunday. The JD(U) has declared support Speaker, while the TDP is understood to have favoured a consensus candidate for the coveted post.

The post of the Speaker of the Central Legislative Assembly has witnessed a contest on six occasions between 1925 and 1946.

Vitthalbhai Patel was re-elected to the post unanimously on January 20, 1927 after the completion of his first term. Patel quit the post on April 28, 1930 following a call for Civil Disobedience by Mahatma Gandhi. Sir Muhammad Yakub (78 votes) won the Speaker's election against Nand Lal (22 votes) on July 9, 1930.

Yakub stayed in the post for one session, the last of the third Assembly. In the fourth Assembly, Sir

the Speaker's election against Hari Singh Gour who got 36 votes. Rahimtoola resigned on health grounds on March 7, 1933 and was succeeded by Shanmukham Chetty on March 14, 1933 as the unanimous

Sir Abdur Rahim was elected as the Speaker of the Fifth Assembly on January 24, 1935. Rahim had polled 70 votes against T A K Sherwani, who could muster the support of 62

Rahim held the high office for more than 10 years as the tenure of the fifth Legislative Assembly was extended from time to time on account of the contemplated constitutional changes and later due to the World War II.

The last contest for the post of the Legislative Assembly Speaker was held on January 24, 1946 when Congress leader G V Mavalankar won the election against Cowasjee Jehangir by a margin of three votes. Mavalankar polled 66 votes against 63 by Jehangir.

Mavalankar was subsequently appointed as the Speaker of the Constituent Assembly and the Provisional Parliament that came into being after the Constitution came into force on January 26, 1950.

Mavalankar continued to be the Speaker of the Provisional Parliament till April 17, 1952 when the Lok Sabha and the Rajya Sabha were constituted after the first general elections.

Since Independence, Lok Sabha Speakers have been chosen by consensus, and only M A Ayyangar, G S Dhillon, Balram Jakhar and G M C Balayogi have been re-elected to the coveted posts in the subsequent Lok

Ayyangar, the first Deputy Speaker of the Lok Sabha, was chosen as the Speaker following the death of Mavalankar in 1956. He won the 1957 general elections and was chosen as the Speaker of the second Lok Sabha.

Dhillon was chosen as the Speaker of the fourth Lok Sabha after the resignation of incumbent N Sanjeeva Reddy in 1969. Dhillon was also chosen as the Speaker of the fifth Lok Sabha in 1971 and continued in office till December 1, 1975, when he quit during the Emer-

Jakhar was Speaker of the seventh and the eighth Lok Sabhas and holds the distinction of being the only presiding officer to complete two full

Balayogi was chosen as the Speaker of the 12th Lok Sabha, which had a tenure of 19 months. He was also chosen as the Speaker of the 13th Lok Sabha on October 22, 1999, till his death in a chopper crash on March 3, 2002. (PTI)

NCERT working as RSS arm, assaulting Constitution: Jairam Ramesh

NEW DELHI, June 17: Amid the row over revision of NCERT textbooks, Congress leader Jairam Ramesh on Monday alleged that the institution has been functioning as an RSS affiliate since 2014 and is mounting an assault on the Constitu-

In a post on X, Ramesh said the National Testing Agency has blamed the NCERT for the 'grace marks' fiasco in NEET 2024.

That is only drawing attention away from the NTA's own abject failures, he alleged

"However it is true that the NCERT is no longer a professional institution. It has been functioning as an RSS affiliate since 2014. It has just been revealed that its revised Class XI political science textbook criticises the idea of secularism as well as what it considers policies of political parties in this regard.

"NCERT's objective is to produce textbooks, not political pamphlets and propaganda," the Congress leader

"NCERT is mounting an assault on our country's Constitution in whose Preamble secularism features explicitly as a foundational pillar of the Indian republic. Various Supreme Court judgments have clearly held secularism to be an essential part of the basic structure of the Constitution," he said.

Ramesh said the NCERT needs to remind itself that it is the National Council for Educational Research and Training, "not the Nagpur or Narendra Council for Educational Research

"All of its textbooks are now of dubious quality vastly different from those that shaped me in school," the Congress general secretary alleged. TMC leader Saket Gokhale also hit out at the NCERT, saying, "Shameless NDA 1.0 Government" is hiding

'inconvenient facts" from students. "By this logic, why teach kids about other 'violent depressing

things' like the World War?" he said. "Are BJP and Modi ashamed of their history as criminals and rioters? Why hide the truth from students?" Gokhale asked

Rejecting accusations of saffronisation of school curriculum, the NCERT director has said that references to Gujarat riots and Babri masjid demolition were modified in school textbooks because teaching about riots "can create violent and depressed citizens."

In an interaction with PTI editors, National Council of Educational Research and Training (NCERT) director Dinesh Prasad Saklani said the tweaks in textbooks are part of annual revision and should not be a subject of hue and cry.

Saklani said, "Why should we teach about riots in school textbooks? We want to create positive citizens not violent and depressed individu-

He added, "Should we teach our students in a manner that they become offensive, create hatred in society or become victim of hatred? Is that education's purpose? Should we teach about riots to such young chil-

CID for inquiry in POCSO case

BENGALURU, June 17: Former Karnataka Chief Minister B S Yediyurappa on Monday appeared before the Criminal Investigation Department (CID) for an inquiry in connection with a POCSO case registered against him.

The Karnataka High Court on Friday restrained the CID from arresting the veteran BJP leader in connection with the March 14 case.

According to police, Yediyurappa has been booked under the Protection of Children from Sexual Offences (POCSO) Act, 2012, and Section 354 A (Sexual harassment) of the Indian Penal Code (IPC) based on a complaint by the mother of a 17-year-old girl who alleged that he molested her daughter during a meeting on February two this year, at his residence in Dollars Colony here.

Yediyurappa has denied the charge, and said "people would teach a lesson to those indulging in conspiracies against him.'

The victim's brother had filed a petition in the court last week alleging that though the case was registered nearly three months ago, no progress has been made in the investigation. The petitioner prayed that Yediyurappa should be arrested and interrogated.

After the Sadashivanagar police registered the case in March, the Karnataka Director General of Police Alok Mohan had issued an order transferring it to the CID for further investigation.

The 54-year-old woman, who had leveled the charge against Yediyurappa, died at a private hospital nere last month, due to lung cancer

In April, the CID collected the voice sample of Yediyurappa after summoning him to the office. (PTI)

Ensure complete transparency of EVMs or abolish them: Rahul Gandhi to EC

NEW DELHI, June 17: Raising questions on the reliability of EVMs, Congress leader Rahul Gandhi on Monday asked the Election Commission to ensure complete transparency of the machines and processes or abolish them. The demand came a day after the Congress leader had alleged that the electronic voting machine is a "black box" and nobody is allowed to scrutinise them while further alleging that serious concerns are being raised about transparency in our electoral process.

"When democratic institutions are captured, the only safeguard lies in electoral processes that are transparent to the public," Gandhi said in a post on X. "EVM is currently a black box. EC must either ensure complete transparency of the machines and processes or abolish them, the former Congress president also said. "How many machines showed the wrong

time, date, votes registered? How many EVMs had their components replaced - counting unit? ballot unit? How many EVMs were found faulty during the mock poll," he asked. "Having contested the elections. I can confidently say that these machines have shown inaccurate results. I hope the Election Commission puts out the above data because the public have the right to know," Gogoi also said in a post on X.

A fresh political slugfest has erupted over EVM tampering claims with Gandhi and other was found using a mobile phone "connected" to an electronic voting machine during the counting of votes on June 4.

However, Vandana Suryavanshi, the returning officer of the constituency, dismissed the report in 'Mid-Day' newspaper as "false news" and said a defamation notice has been issued to the publication. She asserted the EVM is a standalone system, not programmable and has no wireless communication capabilities.

The BJP hit out at the opposition leaders over the issue and demanded that the Election Commission should prosecute all those who "amplified the lie" by sharing the news report. Questioning the reliability of EVMs, Gandhi and others had on Sunday also quoted a post by Elon Musk, chairman of social media platform X and CEO of Tesla, in which he talked about eliminating EVMs and claimed the risk of hacking was "too high".

"We should eliminate electronic voting machines. The risk of being hacked by humans or AI, while small, is still too high," Musk said while responding to a a post by US politician Robert F Kennedy Jr alleging Puerto Rico's primary elections experienced "hundreds of voting irregularities related to electronic voting machines".

Congress' ally and Samajwadi Party chief Akhilesh Yadav also questioned the credibility of EVMs and demanded that all future elections should be conducted through ballot

Congress in Kerala apologises to Christians over controversial social media post

Congress in Kerala on Monday tendered an apology to the Christian community a day after one of its social media posts taking a dig at Prime Minister Narendra Modi over his recent meeting with

Pope Francis triggered a political row in the state. The party also withdrew the post from its official X handle. In a fresh post on its X handle, the state unit of the grand old party said it tendered an unconditional apology to the Christian faithful if its earlier post had caused any "emotional or psychological distress" to them.

In the explanatory post, the party further said the people in the state clearly know that it is not the tradition of the Indian National Congress to insult and disparage any religion, religious priests or idols. The party said no Congress worker would even entertain the remotest thought of insulting the Pope, whom Christians around the world con-

However, the party is not hesitant to mock PM Narendra Modi, who insults the faithful of the country by calling himself God, the post said.

In that way, people would understand the communal minds of BJP state chief K Surendran and others to portray the Congress' attempt to mock Modi's "shameless political games" as an insult to the Pope, it said.

Hitting out at Surendran and other BJP leaders who triggered a row over the issue, the Congress further said their attempt was to "downgrade" the Christians as a group of people who have no selfrespect and are the ones who spread communal venom as soon as they inject it.

"If there is any genuine love for the Christian community, then Modi and his cohorts, who remained silent when their churches were burned

Monitoring shows snow levels are almost a fifth below normal across the region this year Water shortages feared as snow persistence in Hindu Kush Himalaya hits record low



NEW DELHI, June 17: The Hindu Kush Himalaya is experiencing significantly lower snow persistence this year, raising serious concern over water security for downstream communities, according to a new re-

Leading experts from the International Centre for Integrated Mountain Development (ICIMOD), a Nepal-based intergovernmental organisation, have urged water management officials to initiate drought management strategies and preemptive emergency water supply meas-

The Hindu Kush Himalaya (HKH) region heavily depends on the cryosphere -- frozen water on the Earth's surface, including snow, permafrost, and ice from glaciers, lakes and rivers. This frozen water is a critical source of freshwater for around 240 million (24 crore) people living in the HKH region and has far-reaching benefits for around 1.65 billion (165 crore) people down-

Snowmelt accounts for around 23 per cent of the total water flow of 12 major river basins originating in the

HKH. However, its contribution varies from river to river, representing 74 per cent of the Amu Darya's flow, 77 per cent of the Helmand's flow, and 40 per cent of the Indus'

Monitoring shows snow levels are almost a fifth below normal across the region this year, with the most dramatic declines in the west, where its contribution to water supply is the Snow persistence dropped 17 per

cent below normal in the Ganga basin and 14.6 per cent below normal in the Brahmaputra basin, said the Snow Update Report - 2024, released on Monday.

The Helmand river basin shows the most significant drop in snow persistence at 31.8 per cent below normal. Its previous lowest level was in 2018, with a 42 per cent reduction.

The Indus basin has fallen to 23.3 per cent below normal, the lowest level in 22 years. The previous lowest year for this basin was 2018, with a 9.4 per cent shortfall. The Mekong basin had the smallest variation from normal, with snow persistence around 1 per cent below normal.

malaya, with 13 of the past 22 years registering lower-than-normal seasonal snow persistence," said ICI-MOD cryosphere specialist Sher Muhammad, who is also author of the report. "This is a wake-up call for researchers, policymakers and downstream communities. Lower snow

"We have seen a pattern of de-

creasing amounts and persistence of

snow across the Hindu Kush Hi-

accumulation and fluctuating snow levels pose a serious increased risk of water shortages, particularly this year," he said. Miriam Jackson, ICIMOD's senior cryosphere specialist, said agencies must take proactive steps to

address possible drought situations, especially in early summer. "Plans must be updated to accommodate water stress, and communities need to be notified of the risks.'

"Beyond that, it's clear that governments and people in this region need urgent support to adapt to changes in snow patterns that carbon emissions have already locked in. G20 countries need to cut emissions faster than ever before to prevent even more changes that could prove disastrous to major population centres and industries reliant on snowmelt in the mountains," she

The experts said promoting rainwater harvesting and establishing local water committees may help mitigate the immediate impacts of below-normal snowfall on the water supply in the HKH region.

However, to ensure long-term resilience to climate change, countries sharing trans-boundary rivers must collaborate to update their water management laws. Such actions are crucial to addressing water shortages in south Asia, which relies on snowmelt, they said. (PTI)

Delhi water crisis BJP-made: AAP's Sanjay Singh

NEW DELHI, June 17: AAP Rajya Sabha MP Sanjay Singh on Monday alleged that the water crisis in Delhi was orchestrated by the Bharatiya Janata Party. Addressing a press conference, Singh accused the saffron party of hatching a conspiracy against the residents of the national capital.

Raising red flags over the proposed project, Congress general secretary and former Union environment minister Jairam Ramesh said all clearances given to the ₹ 72,000-crore project should be suspended immediately and an impartial review of it conducted, including by the parliamentary committees concerned.

"The Union government's proposed ₹ 72,000-crore 'Mega Infra Project' in Great Nicobar Island is a grave threat to Great Nicobar Island's tribal communities and natural ecosystem. The project, initiated in March 2021 at the instance of the NITI Aayog, shows numerous red flags," Ramesh said in a statement,

which he also posted on X. "The Congress demands an immediate suspension of all clearances and conduct of a thorough impartial review of the proposed project, includ-

ing by the parliamentary committees concerned," he said. He claimed that the environment, forests and climate change ministry has given an "inprinciple" clearance for diverting 13.075 hectares of forest land, "This area is about 15 per cent of the island's land mass and constitutes one of the country's largest forest diversions in a nationally and globally unique rainforest ecosystem," the Congress leader said.

Proposed infra project in Great Nicobar poses

Compensatory afforestation for the loss of this unique rainforest ecosystem has been planned in the state of Haryana, thousands of kilometres away and in a vastly different ecological zone, Ramesh claimed.

"The coastline where the port and the project is proposed to come up is an earthquake prone zone, and saw a permanent subsidence of about 15 feet during the tsunami of December 2004. Locating such a massive project here puts investment, infrastructure, people, and the ecology in harm's way," he said in the statement. "The project poses a direct threat

to the wellbeing and survival of the

Shompen, an indigenous community

classified as a particularly vulnerable

tribal group (PVTG). Thirty-nine experts from across the world have warned the administration that the project poses the threat of genocide to the Shompen," Ramesh said.

"The administration has compromised on due process in its rush to get approval -- The administration did not adequately consult the Tribal Council of the Islands, as is legally required. The Tribal Council of Great Nicobar Island has in fact expressed objections to the project, claiming that authorities had earlier 'rushed them' into signing a 'No Objection' letter based on misleading information -- and that the No Objection letter has since been revoked." he claimed.

The administration has "ignored" the island's Shompen Policy, notified by the Union tribal affairs ministry, which requires authorities to prioritise the tribe's welfare when considering "large scale development proposals" the Congress leader said.

He also claimed that the adminis-

tration appears to have skipped the legally mandated consultation with the Scheduled Tribes Commission, required by Article 338 (9) of the Constitution. (PTI)

NEW DELHI, June 17: Nine nu-US, Russia, France, China, India and Pakistan, continued to modernise their nuclear arsenals and several of them deployed new nuclear-capable weapon systems in 2023, a Swedish think-tank said on

In its analysis, the Stockholm International Peace Research Institute (SIPRI) said China's nuclear arsenal increased from 410 warheads in January 2023 to 500 in January 2024, and it is expected to keep

The report said some 2,100 of the deployed warheads were kept in a state of high operational alert on ballistic missiles, and nearly all of them belonged to Russia or the US.

However, for the first time China is believed to have some warheads on high operational alert, it said.

The SIPRI said nine nucleararmed states -- the US, Russia, the UK, France, China, India, Pakistan, North Korea and Israel -- continued to modernise their nuclear arsenals and several deployed new nucleararmed or nuclear-capable weapon systems in 2023.

Of the total global inventory of an estimated 12,121 warheads in January 2024, about 9,585 were in military stockpiles for potential use, it said.

An estimated 3,904 of those warheads were deployed with missiles and aircraft -- 60 more than in January 2023 -- and the rest were in central storage, it said.

"Around 2,100 of the deployed warheads were kept in a state of high operational alert on ballistic missiles. Nearly all of these warheads belonged to Russia or the US, but for the first time China is believed to have some warheads on high operational alert," the report

According to the think-tank, India, Pakistan and North Korea are all pursuing the capability to deploy multiple warheads on ballistic missiles, something Russia, France, the UK, the US and more recently

China already have. This would enable a rapid potential increase in deployed warheads, as well as the possibility for nuclear-armed countries to threaten the destruction of significantly

cent of all nuclear weapons. The sizes of their respective military stockpiles seem to have remained relatively stable in 2023, although Russia is estimated to have deployed around 36 more warheads with operational forces than in January 2023, it said.

Transparency regarding nuclear forces has declined in both countries in the wake of Russia's fullscale invasion of Ukraine in February 2022, and debates around nuclear-sharing arrangements have increased in saliency, it added.

The report put India's 'stored' nuclear warheads at 172 in January this year while the number for Pakistan was 170

India slightly expanded its nuclear arsenal in 2023, it said, adding that both India and Pakistan continued to develop new types of nuclear delivery systems in 2023.

"While Pakistan remains the main focus of India's nuclear deterrent, India appears to be placing growing emphasis on longer-range weapons, including those capable of reaching targets throughout China," the report said.

It said depending on how it decides to structure its forces, China could potentially have at least as many intercontinental ballistic missiles (ICBMs) as either Russia or the US by the turn of the decade.

At the same time, the report said China's stockpile of nuclear warheads is still expected to remain much smaller than the stockpiles of either of Russia and the US.

"China is expanding its nuclear arsenal faster than any other country," said Hans M Kristensen, Associate Senior Fellow with SIPRI's Weapons of Mass Destruction Programme and Director of the Nuclear Information Project at the Federation of American Scientists

"But in nearly all of the nucleararmed states there are either plans or a significant push to increase nuclear forces." Kristensen said. (PTI)

CHAIBASA, June 17: At least four Maoists, including a woman, were killed in an encounter with security forces in Jharkhand's West Singhbhum district on Monday, officials said. The encounter broke out around 5 am near Lipunga area under Gua police station limit, around 200-km from Jharkhand's capital Ranchi, they said.

"Four Maoists were killed in the gunfight, while two have been arrested," Jharkhand Police spokesperson and IG (Operations), Amol V Homkar, told PTI.

Homkar said that one INSAS rifle, two SLRs, three rifles (.303) and one (9mm) pistol were recovered during the search operation.

Later briefing media persons, he said that the killed Maoists were identified from the primary sources as zonal commander Kande Honhaga, a resident of Thalkobad in Chaibasa and he was carrying a bounty on his head, sub-zonal commander Singrai alias Manoj, a resident of Jaigur police station area in Chhattisgarh, area commander Surva alias Munda Devgam and a woman cadre Junga Purty alias Marla. Man kills daughter for wanting to marry outside of caste in Delhi

NEW DELHI, June 17: A man allegedly slit his daughter's throat and dumped her body here on a farm in Rohini's Kanjhawala area for wanting to marry a man from another case against the wishes of the family, police said on Monday.

The woman was found lying in a pool of blood with multiple stab wounds in a farmland in Chandpur village in Kanjhawla on Sunday, they said. Deputy Commissioner of Police (Rohini) Guriqbal Singh Sidhu said the 46-year-old accused has been arrested. He said police received a call about the incident at

8.53 pm on Sunday. Sidhu said a police team immediately reached the spot and found a woman with deep injuries in her neck and abdomen. She was shifted to a hospital where doctors declared her brought dead.

In view of the sensitivity case, multiple police teams were formed for the case. CCTV footage of the area was analysed, he said.

Police traced the registration number of the cab that was used by the father-daughter duo. On the basis of technical evidence, police identified the woman and found that the man was her father, another police officer said.

The father was picked up by a police team on Monday morning and he confessed to the crime. He told police that he had picked up his daughter from his son's home in Narela on Sunday evening, the officer said. According to police, the man hired a cab to go to their house in Prem Nagar but he had a fight with her daughter over an issue on the way. They asked the driver to drop them in Kanjhawala, which is when he allegedly took her to the farm, slit her throat and stabbed her multiple times, leaving her dead on the spot, the officer said. Cleaning up Delhi's air requires uncomfortable decisions involving rich people: Sunita Narain

NEW DELHI, June 17: Cleaning up Delhi's air requires "uncomfortable and inconvenient" decisions, and it cannot be achieved by being nice to everyone, particularly the affluent residents who significantly contribute to the problem, leading environmentalist Sunita Narain has said.

In an interaction with PTI editors, Narain said although central and state governments have taken several steps to control air pollution in Delhi, including banning coal and introducing BSVI fuel, erratic weather patterns due to climate change and the inadequate speed of addressing the crisis continue to exacerbate the problem.

Narain, the Director General of the Centre for Science and Environment, said the episodic burning of crop residue by farmers in winter is not the primary concern. Instead, the persistent and major sources of pollution within the city, including transport and industries, are more worrisome.

"My only request for the new government is to take some uncomfortable, inconvenient decisions to move ahead on air pollution. We will never clean up the air of Delhi by being nice to everybody, particularly the rich of Delhi," she said.

Narain, who was part of the Supreme Court-appointed Environment Pollution (Prevention and Control) Authority, also urged the new government at the Centre to bring natural gas under the GST regime, arguing that the current triple taxation on gas makes it unaffordable compared to dirty coal. This change would make clean gas a more viable option, she said.

"My biggest request for the next government... The easiest thing we can do to reduce pollution in Delhi is to bring it under GST," Narain said.

She stressed the need for reducing vehicular pollution by enhancing public trans-

Source apportionment studies conducted in the past show that transport accounts for 17.9 per cent to 39.2 per cent of Delhi's PM2.5 pollution, while industries' contribution ranges from 2.3 per cent to 28.9 per

"Delhi has taken several steps to control air pollution. It is the only city in the country to ban coal use, which is a major achievement. Delhi shut down its last coalbased power plant and transitioned to gas for power generation. The government introduced BSVI fuel and imposed a congestion charge on trucks entering Delhi. The construction of a peripheral expressway now allows trucks to bypass the city,' Narain said.

Efforts have also been made to incentivise the use of natural gas. In Delhi, there is zero VAT on gas, and natural gas is now

readily available in industrial areas across the city. These initiatives have collectively led to a year-over-year reduction in pollution levels, she said.

However, Narain said, there are two major factors that continue to exacerbate the problem -- worsening weather conditions, which are beyond human control, and the inadequate speed of tackling the crisis.

This winter, for instance, northwest India. including Delhi, did not experience rain. The lack of rainfall is due to changes in the Arctic jet stream affecting western disturbances, which are becoming more erratic and shifting northwards, she explained.

This has led to less snow in the hills and less rain in Delhi, resulting in higher pollution levels, Narain said. "Secondly, after all the actions taken up

to 2021, we are not taking actions at the speed required by the crisis that is happening," she said. The environmentalist said the last major

bus fleet expansion occurred during Sheila

Dikshit's tenure as Delhi chief minister,

around the time of the Commonwealth

Since then, many buses have not been replaced, leading to a decline in bus ridership, she said and added that the bus system needs to be integrated with metro systems and parking facilities to be effective. (PTI)



FUNDAMENTALISM DOESN'T BELONG TO ANY ONE RELIGION: KONKONA SEN SHARMA



MUMBAI, June 17: Actor-filmmaker Konkona Sen Sharma on Sunday said fundamentalism is "its own beast" and doesn't belong to any religion in particular.

She was speaking at the launch of cinematographer Nusrat F Jafri's book This Land We Call Home, published by Penguin Random House. The event was also attended by writer-filmmaker Varun Grover and Svetlana Naudiyal, programming director, APAC, MUBI.

Asked what national incidents from their formative years influenced their thoughts on country and society, Sen Sharma said for her it was the demolition of the Babri Masjid in Ayodhya, Uttar Pradesh when she was a teenager.

The actor, daughter of veteran filmmaker Aparna Sen, said her mother made her write a report in Bengali and English on the 1992 incident. "For me, it is Babri Masjid (demolition), December 6, 1992... One of the chief things that came across from that (report) was that our fundamentalism doesn't belong to any one religion. It's its own beast. Because of that, it was easy to trace other

events from there.

"That was the first time I was actually so conscious about a political event. Before that, I think (it was) '84 and all (anti-Sikh riots). We were young, so we don't remember some stories that one has heard. And, these are not taught in schools. These are conversations which are highly charged even within families and family friends," Sen Sharma said during the Q&A session moderated by Naudiyal here.

Jafri, known for lensing Hansal Mehta's Shahid and the Zakir Khan-starrer series Chacha Vidhayak Hain Humare, also echoed Sharma's sentiments on

the Babri Masjid demolition.

The cinematographer said she was 12 at the time and grew up in Lucknow, which has a fair repre-

sentation of Muslims.

"Muslims and Christians were always a minority even in Lucknow where there's a good representation of Muslims and Christians. But even then, we had a good coexistence. It was Babri Masjid which started these, like Konkona (said), very charged, heated, passionate discussions even among stu-

dents.

"These were discussions where children were listening to their parents with each family's ideology coming in... We just went in for one or two months of curfew. We were off from school but the conversations had started. As a preteen, I was aware was an important event," Jafri added. For Grover, it was in the late 1990s when he heard about an incident of a Ganesha idol "drinking milk" in Delhi. Even as a student, the writer said he found it hard to believe that so many people could fell for "a simple sight standard trick"

fall for "a simple sixth standard trick".

"For me, that was the day which told me that we are a nation of negative scientific temperament...

That gave me a reality check about how to navigate

the world and society.

"For a nation obsessed with engineering, sciences and being the knowledge centre of the world...And then saying, okay, it is something divine... But it shaped me in a very particular way (about) how to deal with the world," said the writer, who studied civil engineering at the Indian Institute of Technology (BHU) Varanasi. (PTI)

The Sri Lankan middle order were brilliant with veteran Angelo Mathews (30 off 15 balls) and skipper Hasaranga (20 off 10 balls) shored up the scoring rate but it was left-hander Charith Asalanka's 21-ball-46 that was the real difference in their innings. Asalanka smashed five sixes as Sri Lanka crossed the 200-run mark.

There were blank faces at the international airport when one asked about the location of his last resting place which is literally a stone's throw from that facility.

"There is no doubt about Marshall's greatness but as they say 'out of sight can be out of mind'. The current generation was not even born when he was winning games for the West Indies in the



"The money and the eyeballs were not as much as they are now. I am sure the modern day cricketers won't be forgotten that easily," said Kevin, a local who is a

self-proclaimed fan of the game. Besides Marshall, Barbados has produced many greats of the game including Sir Garfield Sobers and

Joel Garner. Marshall played his last Test in 1991 to end up with as many as 376 wickets at an exceptional average of 20.94.

MARSHALL FORGOTTEN IN HOMELANI

The right-arm pacer's legend grew during his county stint for Hampshire who named the road leading to the stadium after the West Indian. He was diagnosed with cancer in 1999 and succumbed to it within months.

"About the captaincy – when I had left it (after ODI World Cup), I thought that I shouldn't be doing it now, that's why I left it and I announced it myself. Then when they gave it back to me, it was the decision

Babar was visibly miffed at being repeatedly probed about his future as a leader and told the assembled media that one person cannot be blamed for team losses. "...everyone is sad. As a team, we did not

play. I told you that we did not lose this be-

cause of one person," he told a probing "We are losing as a team. I am not saying



out that because of the captain, I cannot play

this because of one person. You are pointing in every player's place. There are 11 players

to apply, follow and finish things. We have to settle down and accept that we didn't play well as a team."

Imad Wasim, in a media interaction, had spoken how Pakistan is not changing its archaic style at a time when the world order in the shortest format had undergone a sea

Babar partially agreed with Imad's asser-

"I think eight-nine players are the same who have been playing for four years. They should not fear. All of them are the same players. They are being backed. They are being given opportunities," he said.

Batting is an area of concern he admitted. "You need to assess the conditions, what's the demand here. If you follow that then - tell me how many matches have been played here and there's been outstanding

"There's been a struggle, but you need to be proactive about what's required here. I think it's about game awareness and common sense, which is what is required here."

Critical of US wickets Babar joined the chorus of criticism against the standard of pitches in the tournament's USA leg, which concluded on Saturday. While drop-in pitches in New York copped a lot of flak, inadequate covers for the full ground in Florida also didn't go

down well with teams. "I was expecting someone to ask this question (on US tracks). As far as pitches are concerned...In New York, you saw that the game was played on toss. I think the timing was a little too early.

"Because when you win a toss, every second team opted to bowl. And bowlers got help...you didn't have the idea of bounce because there was no consistent bounce. Sometimes the ball went too high, sometimes it stayed down." (PTI)

GROS ISLET (SAINT VINCENT), June 17: Sri Lanka captain Wanindu Hasaranga believes they've extensively discussed their repeated mistakes in big tournaments and now it's time to shift their focus towards rectifying those faults, following the ignominy of another group league exit.

Hasaranga termed his team's 83run win against the Netherlands as something that came "too late" after losing their games against South Africa and Bangladesh in the group stage of the T20 World Cup.

"After every tournament, we gather around and discuss that we committed several mistakes. As a team, we should decide if we have to rectify those mistakes. I think we have not rectified our mistakes yet. "As a captain, I feel very sorry

The leg-spinner felt that it was the batting that led the team down.

"When we think of the bowing battalion, we are on the top in this tournament as well. Unfortunately, I know our batting wasn't good enough as we expected and that's why we had to get out of this tournament this early," the skipper put the blame squarely on batters.

Hasaranga, however, didn't want to read too much into social media

and it is not acceptable," he said. "The wicket is not the issue. This was a wicket where you can score 140-150 runs,

maybe which we could not do. So, it is definitely a reason for us to worry," he said. Despite managing scores close to

130, the team has emerged triumphant in three games and its only defeat so far has come against South Africa.

Shanto emphasised the importance of getting a good start from his batters.

"Of course, it is a reason for me to worry. I don't think it is a good thing for the team to bat like this because the start is very important. We are not getting the start, and the lower-order batsmen are not finishing it well," he pointed out.

"But we have to come out of this and think about how to come out of this. And we do plan and think about this all the time. Still, this mistake is happening again
