

### Interest rates not impeding growth, monetary policy to focus on lowering inflation: Das

MUMBAI, June 25: Reserve Bank Governor Shaktikanta Das on Tuesday asserted that the high interest rates are not impeding growth, and made it clear that the monetary policy will "unambiguously" focus on getting down inflation going forward.

The country is at the threshold of a "major structural shift" in its growth trajectory and is moving towards a path where 8 per cent real GDP growth can be sustained on a yearly basis, Das said addressing an event by Bombay Chamber of Commerce and Industry here. "Normally if growth is well sustained, if you've good growth, then it is a clear sign that your monetary policy and your interest rates are not acting as an impediment to growth," Das said.

Addressing the debate on the sacrifices to growth because of the elevated interest rates, Das said all such concerns are misplaced and the growth momentum is continuing month on month. He said RBI's nowcasting team is projecting a GDP growth number at 7.4 per cent for the June quarter, which is higher than the central bank's own estimate of 7.3 per cent, and added that he is confident of the economy growing at the RBI estimated 7.2 per cent for FY25

"A good growth outlook gives us the necessary

space to unambiguously focus on inflation," he added. Das used the analogy of chess to underline the focus on the inflation moderation going ahead and made it clear that one wrong move can distract and get us offtrack now. A single adverse weather event can take inflation back to over 5 per cent, he said, stressing on

the focus that is required. He said the inflation has come down by 3.1 percentage points to 4.7 per cent currently from a high of 7.8 per cent in 2022 "primarily" due to the monetary policy actions. Connecting lower inflation with growth aspirations, he said a lower level of price rise can en-

sure sustainable growth "High inflation makes the economy uncompetitive, makes the economy an unfavourable destination for both domestic as well as foreign investments, above all, a high inflation would mean lowering the purchasing power of the people especially the poor people,"

Das said after three years of growth getting a push from the government expenditure, there is "clear evidence" of private capital expenditure picking up and pointed to sectors associated with infrastructure like cement and steel witnessing the highest interest. (PTI)

On Tuesday, as the Congress nominated eight-term member Kodikunnil Suresh for the Lok Sabha Speaker's post, Parliamentary Affairs Minister Kiren Rijiju appealed to the opposition to reconsider its decision. According to pre-qualified bidder details released by the Department of Telecommunications, Bharti Airtel has submitted the earnest money deposit (EMD) of ₹ 1,050 crore and Vodafone Idea (VIL) of ₹ 300 crore. Telecom industry body Cellular Operators' Association of India Director General SP Kochhar said the 5G auctions will catalyze the rapid rollout of 5G services across the country, leading to enhanced coverage and vastly improved connectivity.

"By bridging the digital divide, the 5G spectrum auctions will ensure that even the most remote areas of our country gain access to high-speed internet, thereby fostering greater economic opportunities and social advancement.

# Attack on army camp in Assam: NIA files charge sheet against four

NEW DELHI, June 25: The National Investigation Agency (NIA) on Tuesday charge sheeted four accused, including a cadre of Myanmar-based banned terror outfit ULFA-I, involved in a conspiracy to target army camps in the state as part of an anti-India agenda.

Two motorcycle-borne cadres of the proscribed outfit had lobbed grenades at the military station in Lichubari in Jorhat district on December 14 last year as part of a bigger conspiracy to target army establishments across the northeastern state, a statement issued by

# Lok Sabha braces for Speaker's election after 1976

While elections to the Speaker's post were common before Independence, the position of the presiding officer of the Lok Sabha has witnessed contests only thrice in Independent India – in 1952, 1967

In 1952, Congress member G V Mavalankar was elected as the Lok Sabha Speaker. Mavalankar polled 394 votes against opponent Shantaram More, who managed to garner 55 votes.

In 1967, Tenneti Viswanatham contested the election for Lok Sabha Speaker against Congress

# Assam Police fully prepared to implement new criminal laws: DGP

GUWAHATI, June 25: Assam police is fully prepared to implement the new criminal laws that will replace the colonial-era legislation starting next month, a top official said on Tuesday.

# CBI files case against four in bank fraud case



design and development of a miniaturised satellite capable of carrying electro-optical, infrared, synthetic aperture radar and hyperspectral payloads up to 150 kg," the defence ministry said in a statement.



The 150th iDEX contract was signed in December 2022, and within a span of 18 months, the 350th contract has been signed, it said.

The contract was exchanged between Additional Secretary (Defence

Production) and CEO, Defence Innovation Organisation (DIO), Anurag Bajpai, and founder and CEO of SpacePixxel Technologies Awais Ahmed Nadeem Alduri in the presence of Defence Secretary Giridhar Aratary officials of the ministry.

SpacePixxel has been actively working to build and launch high-resolution hyperspectral imaging satellites to provide detailed earth observation data, the statement said.

### Modi-RSS power struggle

The Bharatiya Janata Party (BJP) is facing a significant internal conflict as Prime Minister Narendra Modi's power struggle with the Rashtriya Swayamsevak Sangh (RSS) intensifies over the choice of the new party president. In its century-long history, the RSS has never experienced such an existential crisis. While past confrontations, like the 2003 clash with the Vishwa Hindu Parishad over the Ayodhya temple, were resolved without much fanfare, the current crisis is marked by egos and authoritarian dynamics. The discord between Modi and the RSS, particularly its chief Mohan Bhagwat, has been brewing for several years. RSS general secretary Dattatreya Hosabale's criticism of Modi's governance style since taking office in 2021 highlighted the growing rift. However, Bhagwat's reluctance to confront Modi directly has only emboldened the Prime Minister. Modi's centralization of power and his insistence on dictating the Sangh Parivar's functioning have strained relations with RSS leaders. His electoral strategies, including the "Modi's Guarantee" and "Abki baar 400 ke paar" slogans, have further deepened the skepticism within the RSS. A significant point of contention is Modi's reliance on turncoat MPs who have defected from other parties, particularly the Congress. Out of 240 elected BJP candidates, 132 are such turncoats, loyal to Modi rather than the RSS. This strategic move has ensured Modi's dominance but has alienated the RSS, which opposed their candidacies. The RSS's discomfort was further amplified when BJP President J.P. Nadda asserted that the party no longer needed the RSS's support, indicating a clear shift in the party's power dynamics.

Modi's attempts to install a loyalist as the new BJP president, sidelining the RSS's preferences, have intensified the conflict. The RSS is reportedly considering Sanjay Joshi or Vinod Tawade for the position, with Joshi known for his strained relations with Modi, while Tawade maintains amicable ties with both factions. Meanwhile, Modi and Amit Shah are pushing to extend Nadda's presidency until after crucial state elections in Maharashtra, Haryana, and Jharkhand, aiming to solidify Modi's control. This internal BJP turmoil has broader implications for the RSS's mission of transforming India into a Hindu Rashtra. While the RSS needs a BJP government for its ideological goals, it is increasingly wary of Modi's autocratic behavior. Modi's projection as the supreme leader of Hindutva, driven by a circle of Gujarati businessmen and industrialists since his tenure as Guiarat's Chief Minister, has fueled his ambitions. His systematic campaign against Muslims and the aggressive promotion of Hindutva are seen as tactics to consolidate his power and render the RSS irrelevant. The RSS's internal critique of Bhagwat's ambiguous stance towards Modi reflects a deeper organizational crisis. Bhagwat's failure to explicitly name Modi in his criticisms has led to dissatisfaction among RSS leaders, who see this as a

Despite Modi's contributions to popularizing Hindutva and expanding the BJP's base, his authoritarian style and disregard for RSS's traditional role have created a profound schism. As Modi maneuvers to maintain his grip on power by possibly relaunching "Operation Lotus" to induct more defectors and secure a single-party rule, the RSS faces a crucial decision. Will it acquiesce to Modi's supremacy, or will it assert its foundational principles and reclaim its influence within the BJP? The outcome of this power struggle will shape the future of both the BJP and the broader Hindutva movement in India.

# The implications of Hekani Jakhalu's ULB election campaign rhetoric

Manipulating, threatening, coercing voters is not just a crime; it is a deliberate

Nagaland will conduct the Urban Local Bodies (ULB) elections in three Municipal Councils and 36 Town Councils on June 26. This will be the firstever municipal election in the state with a 33% reservation for women, marking a significant step towards gender inclusivity in local governance. However, the election campaigns have already sparked controversy, particularly the speeches delivered by Hekani Jakhalu Kense, a member of the Nagaland Legislative Assembly. These campaigns have illuminated the current state of Nagaland politics and its trajectory, raising critical concerns about the nature of political discourse and the health of democratic processes in the state.

Jakhalu's speeches (which have been heavily viraled in social media) have displayed a tone of authority and manipulation, potentially polarizing the electorate. Her assertion, "Moi Dimapur 3 lah MLA ase etu karne I am saying it in Public - there is no space for non-NDPP Members taikhan bhi hoi member toh ase hoilebi that's politics," exemplifies favoritism and a lack

The persistent emphasis on "Jagah nai" (there's no space) for non-NDPP candidates, in an election overseen by the State Commission under Article 243 ZA, reveals a combative stance and a misunderstanding of legal boundaries-no MLA has the authority to decide electoral participation.

Furthermore, Jakhalu's directive, "Government ko teh jai ase, Party kon tu Government teh jai ase tateh hi jai kene vote mari dibi," urging voters to support the ruling NDPP-BJP alliance, contradicts Article 326, which guarantees adult suffrage without political coercion.

Her rhetoric potentially violates Sections 123 (3) and 125 of the Representation of the People Act, 1951, which prohibit promoting enmity between classes in connection with elections. Also, the statement is likely to attract provisions under section 171C of Indian Penal Code, 1860. # Afghan Taliban leaders meeting with United Ambubachi Mela: A unique celebration of divine fertility Nations on June 30 has high significance

The Afghan Taliban leaders will join a two-day United Nations meeting about Afghanistan on June 30. They had missed the last two meetings. Their attendance shows progress and suggests that the global community may discover improved methods to engage with the unoffi cial leaders in Kabul. The main goal of the third round of talks is to boost international involvement with Afghanistan in a more organized and unified way, according to UN Secretary-General Antonio Guterres.

In consonance with Kabul's agreement, chief Taliban spokesperson Zabihullah Mujahid told the Afghan media that the Taliban government had found the agenda of the forthcoming talks helpful for Afghanistan; so, there would be no preconditions this time around. Mujahid told Tolo News, as quoted by AL-MONITOR, "We'll announce who's in the delegation later. We believe this will benefit Afghanistan.'

Taliban Foreign Ministry spokesman Abdul Qahar Balkhi, however, later retorted that any alteration to the agenda or participation would be grounds for reconsideration.

Afghan Taliban skipped earlier conferences: Since the Taliban took power in 2021; Afghanistan's new government has not been recognized by any other country. The international community is struggling to find a way to engage with the Taliban constructively without encouraging its ex-

treme elements. In May 2023, Guterres started the first Doha conference to boost engagement and provide humanitarian aid to Afghanistan, without inviting the Taliban. ^The Taliban chose not to attend the second meeting in February, which included special represen-

Qatar and the Taliban: Qatar, despite being a small country in the Gulf Cooperation Council, has taken on the challenging role of engaging with the Taliban. It is providing a venue for the Taliban to negotiate with global powers. The effort has really paid off, as Doha has strengthened its diplomatic reputation—both regionally and globally—by acting as a bridge between Afghanistan and other countries.

Guido Steinberg, a researcher and senior associate at the German Institute for International and Security Affairs, says Qatar has been acting as a mediator in regional politics for nearly 20 years. According to a report by Al-Monior, Oatar's main goal in doing this is to strengthen its position in the region. Although the second UN conference did not achieve any results because the Taliban did not attend, the UN and other important parties are urging the Taliban to join the next meeting. Qatar, as host, is thought to have been crucial in convincing them to participate.

The relationship between Doha and the Afghan Taliban is not new. Back in 2013, Qatar let the Taliban open a political office in its capital, Doha, and began acting as a mediator. Qatar not only helped organize the US-Taliban talks that resulted in the 2020 Doha Agreement, but also assisted in evacuating foreign troops and civilians from Afghanistan in 2021 when the Taliban took control and the US had to withdraw

after 20 years. Due to a UN visa ban and the fact that they cannot have an ambassador represent Afghanistan at the UN General Assembly, the Taliban now rely on their office in Doha to communicate and negotiate with other

Valle spoke about whether Qatar's actions had made the Taliban more confident and accepted as a governing body by involving them in the negotiations. He said that Qatar followed a slow, long-term approach, and that was showing results, adding that the fact that the Taliban as taking part in the third UN meet in Doha supported this trend. If Qatar keeps using the same strategy,

the Afghan Taliban will likely become more involved in economic, political and, possibly, even diplomatic relations over time, Valle believes.

Meanwhile, since the Taliban government has faced criticism from women's rights groups, there is significant pressure from various civil society organizations to prioritize women's rights and ensure Afghan women are included in the third UN conference in Doha. Last week marked 1,000 days since the Taliban banned education for girls over age 12, despite a global outrage. UNICEF had termed this a "sad and sobering milestone". One thousand days away from school means a loss of 3 billion learning hours for Afghan girls, it

Later, the Taliban expanded the ban to include universities, preventing many Afghan women from finishing their degrees. After gaining control, they also made women leave their jobs, except for those in the health sector. Additionally, women are not allowed to appear on TV, or visit parks, or go anywhere outside without a male

In his latest report, Richard Bennett, the UN's special expert on Afghan human rights, urged that the Taliban be held responsible for their actions against women and girls. He said the Taliban had given birth to a system that discriminated against women and girls, segregates them and excluded them. The Taliban refuse to change their policies on women and girls, sticking to a strict, extreme, Shariah interpretation of religion and local culture. They argue that calls to lift the ban are interfering in Afghanistan's internal matters.

Oatar has raised similar concerns, notes Ayad. In a recent UN statement, Qatar's representative underscored the growing problems in Afghanistan, such as the worsening humanitarian and economic situations, poor living conditions and severe human rights issues. They particularly highlighted the challenges faced by women and girls, including their basic freedom and right to education and work. (IPA Service)

The festival centers around the belief that the presiding goddess of the Kamakhya Temple, Devi Kamakhya, undergoes her annual menstrual cycle during this time. This unique concept sets Ambubachi Mela apart from many other Hindu festivals and provides insight into the region's rich cultural and spiritual her-

The Kamakhya temple and its significance: The Kamakhya Temple, perched atop the Nilachal Hills in western Guwahati, is one of the most revered Shakti shrines in India. What makes this temple particularly special is that there is no traditional idol of the goddess.

Instead, Devi Kamakhya is worshipped in the form of a yoni-like stone over which a natural spring flows. This symbolism is deeply tied to the temple's focus on fertility and the creative power of the feminine. According to Hindu

# "No amount of coffee can keep me awake": Impact of long COVID on women

omen's health has often been marginalized in medical research and healthcare practices, historically. For many years, clinical studies primarily focused on male participants, leading to a significant gap in understanding and addressing the unique health needs of women. This oversight has resulted in delayed diagnoses, inadequate treatment protocols, and a general lack of awareness about conditions that disproportionately or exclusively affect women. The repercussions of this neglect are evident in various health outcomes, including the management of chronic illnesses, reproductive health, and more recently, the differentiated impact of conditions like long COVID.

A recent study has revealed that women with long COVID exhibit a broader range of symptoms compared to men. Long Covid, or post-acute sequelae of SARS-CoV-2 infection (PASC), is a condition where symptoms persist for weeks or months after recovering from the acute phase of COVID-19. Common symptoms include fatigue, shortness of breath, cognitive issues ("brain fog"), muscle and joint pain, and sleep dis-

The exact cause is unclear, but it may involve ongoing inflammation and immune system issues. It can affect people of all ages, even those with mild initial infections. This finding is crucial for understanding the gender-specific impacts of long COVID and addressing the unique challenges faced by women in their daily lives, workplaces, and educational environments.

Let's dive deeper; The study analyzed data from thousands of long COVID patients and discovered that women reported a wider variety of symptoms than their male counterparts. These symptoms include chronic fatigue, brain fog, sleep disturbances, joint pain, heart palpitations, and anxiety, among others. While both men and women suffer from long COVID, the multiplicity and intensity of symptoms in women appear more pronounced.

My friend's mother, who was a teacher for over 15 years, has quit her job because she feels "too weak and flushed during the day" to continue working. She retired early, explaining, "It was a task to keep up with the students as I would constantly feel drained. Checking answer sheets, attending back-toback lectures, and the general job stress became too hard to cope with." Since contracting Covid, she has been falling sick constantly and finds life difficult overall. Now, she stays at home and holds a passion for gardening.

These array of symptoms that women experience can significantly disrupt daily routines and activities. Chronic fatigue and brain fog hinder their ability to perform household tasks, manage family responsibilities, and engage in social activities. Sleep disturbances can lead to further exhaustion and decreased cognitive function, worsening the struggle to maintain a normal lifestyle. Joint pain and heart palpitations can limit physical activity, reducing overall mobility and independence.

Women with long COVID face substantial challenges in the workplace as well. The symptoms can impede their productivity and reliability, making it difficult to meet job expectations. Chronic fatigue and cognitive impairments affect their ability to focus, remember details, and make decisions, which are crucial for most job functions. The workplace is already skewed against women, with persistent gender biases, wage gaps, and underrepresentation in leadership roles creating a challenging environment. Long COVID adds another layer of difficulty, worsening these existing inequalities and making it even harder for women to navigate their professional lives.

This situation necessitates negotiations with employers for accommodations such as flexible work hours, remote work options, and extended sick leave. However, workplaces are often dismissive of women's health concerns, frequently undermining the seriousness of their symptoms and the need for appropriate accommodations. This dismissive attitude can make it particularly challenging for women with long COVID to secure the necessary support, further complicating their ability to manage their health while meeting job expectations.

Physical symptoms of long COVID, such as chronic fatigue, pain, and breathlessness, can significantly impact the mental health of women. Studies have shown that persistent physical health issues are closely linked with increased rates of anxiety, depression, and emotional distress. For instance, a study published in The Lancet reported that patients with long COVID frequently experience psychological symptoms, including post-traumatic stress disorder (PTSD), as a

result of their ongoing health struggles. This psychological burden is often compounded by the frustration and helplessness of dealing with unpredictable and debilitating physical symptoms, further worsening mental health issues. The interplay between physical and mental health challenges creates a vicious cycle that can be particularly severe for women, who may already face additional stressors related to gender-based disparities in healthcare and societal expec-

My friend, who is a UPSC aspirant, is suffering from long Covid, which has significantly affected her mental health. She constantly struggles with brain fog and fatigue which is making it difficult to retain information like she used to. Preparing for such a competitive exam has become a major challenge. She says, "No amount of coffee can keep me awake for more than a couple of hours. I've started taking some vitamin supplements, which have helped with the weakness a bit, but I'm still far from how

I used to be and it's disheartening".

For women pursuing education, long COVID symptoms can derail their academic progress. Brain fog and fatigue make it hard to concentrate during lectures, complete assignments, or prepare for exams. Sleep disturbances can lead to inconsistent attendance and participation. The necessity for extended deadlines or medical leave may arise, requiring negotiations with educational institutions. However, the variability in institutional support can result in uneven academic experiences and potential delays in educational attainment. This inconsistency arises because not all educational institutions have standardized policies or sufficient resources to accommodate students with

Some may offer flexible deadlines, remote learning options, and mental health support, while others may lack such provisions, leaving students to navigate their challenges with minimal assistance. This disparity can lead to significant setbacks for students, such as falling behind in coursework, struggling to keep up with peers, and even facing the possibility of extended graduation time-

Additionally, the stress of managing a chronic illness without adequate institutional support can worsen both physical and mental health issues, further hindering academic performance. For women, who often shoulder additional responsibilities and face unique societal pressures, these challenges are even more pronounced, potentially affecting their long-term career prospects and financial stability

A significant issue that worsens long COVID is the lack of discussion about nutrition and diet, which are crucial for managing chronic illnesses. According to a YKA survey on nutrition, 64.2% of respondents reported that diet and nutrition were not discussed with them when they were between 10-19 years of age. Among those who did receive this information, only 26.68% received it from their parents or caregivers.

This lack of early nutritional education leaves many women ill-equipped to manage their long COVID symptoms effectively through dietary adjustments. Understanding the importance of nutrition could help alleviate some of the symptoms and improve overall health, but the absence of such discussions hinders this potential benefit.

The broader range of symptoms experienced by women highlights the need for gender-specific healthcare approaches. Women may require more comprehensive and multidisciplinary care strategies to manage their symptoms effectively. Additionally, healthcare providers need to be aware of the gender differences in symptom presentation to avoid misdiagnosis or underdiagnosis of long COVID in women.

What can be done?

Supporting women with long COVID requires a multifaceted approach, beginning with raising awareness and education. Employers and educational institutions need to be informed about the gender-specific impacts of long COVID to promote an environment of understanding and support. These gender-specific impacts include a broader range of symptoms that women tend to experience more intensely, such as chronic fatigue, brain fog, sleep disturbances, joint pain, heart palpitations, and anxiety.

Women may also face additional societal and familial pressures, such as caregiving responsibilities, which can compound the difficulties of managing long COVID. By recognizing the unique challenges that women face, these entities can better accommodate their needs, helping them balance

their health and responsibilities effectively. Implementing flexible work and study policies is another critical measure. Such policies allow women to manage their symptoms without compromising their professional or academic responsibilities. Flexible hours, remote work options, and lenient deadlines can significantly alleviate the pressures that worsens long COVID symptoms, promoting a healthier and more productive lifestyle.

Access to comprehensive healthcare services tailored to women's specific needs is essential for effective symptom management. Healthcare providers should offer personalized care plans that address the physical, mental, and emotional aspects of long COVID. Ensuring that women have access to these resources can lead to better health

outcomes and an improved quality of life. NIH in their initiative stated how specialized long COVID clinics should be established. Creating dedicated clinics that offer a multidisciplinary approach can help manage the diverse symptoms associated with long COVID. The study suggests that there should be efficient collaboration between primary care providers, pulmonologists, cardiologists, neurologists, and mental health professionals for the treatment of diverse long COVID symptoms.

According to a study, there should be an increased awareness among healthcare providers as educating healthcare providers about the prevalence and impact of long COVID in women will ensure timely recognition and treatment. Additionally, providing women with resources and information about long COVID will also help them to advocate for their health needs.

The findings of the study underscore the complex and multifaceted challenges women with long COVID face. Addressing these challenges requires a concerted effort from healthcare providers, employers, educational institutions, and policymakers. By recognizing the broader range of symptoms in women and implementing supportive measures, we can better assist women in managing long COVID and maintaining their quality of life. # Like Penelope Bridgerton, some 18th-century women wrote satirical periodicals to get back at society

n the world of Bridgerton, everyone reads the scandalous columns of Lady Whistledown. That Lady Whistedown's acid pen belongs to none other than the everpolite Penelope Bridgerton proved a shocking twist, but not one without historical precedent. The history of 18th-cen-

tury print is littered with striking instances in which women, like Bridgerton, used cheap print – such as magazines and periodicals - to deliver stunning satirical blows to the maledominated status quo. They also used them to signal solidarity to the women living quietly and politely within society.

Eliza Haywood

Eliza Haywood (1693-1756) was such a woman. Haywood's best-known novella. Fantomina (1725). tells the story of a young lady who falls for a dashing gallant who, unfortudoesn't like sleeping with the same woman twice. Our heroine therefore adopts a series of disguises so she can sleep with him again and again.

in which a young woman gratifies her sexual appetites without sacrificing her reputation, Fantomina asks why it is that we ex-"constancy" women but not in men.

Ultimately, our heroine

falls pregnant and is sent to live out her days in a convent abroad. The apparent lesson is that vice is vice, even if nobody knows about it. For this reason, the tale could be circulated as a work of conduct literature: a genre designed to teach readers, usually women, how to behave. Along the way, however, Haywood has stealthily foregrounded a serious double standard for her

readers. Haywood was not alone in smuggling subversive content into conduct books. In 1753, Jane Collier published An Essay on the Art of Ingeniously Tormenting, a guide designed to teach women how to torment their husbands. As Collier explains, a true tormentor does not kill their enemy, but instead "wastes them by degrees" over as long a period as possible by teasing, nagging and embarrassing them. "The

"and later slays". From 1741 to 1746,

Haywood ran a monthly periodical called The Female Spectator, which courted an audience of female readers. This was a practice the Jonathan Swift disparagingly called "fair sexing": appealing to a second-hand readership of women who might inherit the paper when their husbands had finished with it. Proudly presenting itself as a magazine by women and for women, however, Havwood self-consciously carved out a space to celebrate female readers and campaign for female edu-

Haywood followed The Female Spectator with The Parrot (1746), a periodical written from the perspective of a green parrot. By the time we meet Haywood's parrot, he has lived for decades and has been owned by hundreds of different people from across the globe. This has left him with a sour view of humanity, whom he considers far too keen to judge a person's qualities on their external appearances.

Often disregarded as a "pretty prattler" who can

understanding and appreciated primarily as an object, if not ignored entirely, the parrot feels a keen solidarity with the women he observes. He concedes that women are by no means perfect, but that they do what they must to survive in a world ruled by men, concluding that "whatever faults [women] are guilty

There have always been women, she writes, who could be found "shaking off the yoke of fashion", who "ventured to think justly, and speak with propriety", and who are "not ashamed of being more learned than the idle man of fashion". These women existed in history, Lennox assures her readers, they just need to be 'found'

We would do well to remember Lennox's appeal to broaden our historical assumptions and remember that progressive values are not merely a phenomenon of our own time. Bridgerton uses fantasy to present us with a vision of the 18th century that appeals to our modern sensibilities and aligns with our commitment to social justice. But reading 18th-century women writers like Haywood and Lennox reveals that we don't need fantasy to find these values

Simply soak a clean cloth in cold water, wring out the excess, flammation and soothe irritated skin. Rubbing ice cubes over the rashes 2-3 times daily has a great soothing effect. (do not leave packs on longer than 20 minutes per hour). Alternatively, a cold water bath would reduce the intensity of prickly heat.

5. Apply sandalwood

Sandalwood paste/powder is an old-age remedy for reducing prickly heat, due to its analgesic and anti-inflammatory properties. Make sandalwood paste in rose water/water and apply it on the heat rash-affected areas, let it dry and then rinse with cold water. Never use sandalwood talc or any talcum powder to treat prickly heat, it is not advisable medically

6. If your child is suffering from prickly heat then Put your child in a cool environ-

ment, give your child cool baths, Loosen your child's diaper if it rubs against the rash area. Don't put the steroid cream under the diaper. Dress your child in breathable clothing, such as cotton. Cover your child with as few layers of clothing as possible. (The author is an international

# Israeli SC says ultra-Orthodox men must serve in military



JERUSALEM, June 25: Israel's Supreme Court on Tuesday ruled unanimously that the military must begin drafting ultra-Orthodox men for military service, a decision that could lead to the collapse of Prime Minister Benjamin Netanyahu's governing coalition as Israel continues to wage war in Gaza.

The court ruled that in the absence of a law that distinguishes between Jewish seminary students and other draftees, Israel's compulsory military service system applies to the ultra-Orthodox like any other citizens.

Under longstanding arrangements, ultra-Orthodox men have been exempt from the draft, which is compulsory for most Jewish men and women. These exemptions have long been a source of anger among the secular public, a divide that has widened during the eightmonth-old war, as the military has called up tens of thousands of soldiers and says it needs all the manpower it can get. Over 600 soldiers have been killed.

Politically powerful ultra-Orthodox parties, key partners in Netanyahu's governing coalition, oppose any change in the current system. If the exemptions are ended, they could bolt the coalition, causing the government to collapse and leading to new elections.

During arguments, government lawyers told the court that forcing ultra-Orthodox men to enlist would "tear Israeli society apart." The court decision comes at a sensitive time, as the war in Gaza drags on into its ninth month and the number of dead soldiers continues to mount. The court found that the state was carrying out "invalid selective enforcement, which

represents a serious violation of the rule of law, and the principle according to which all individuals are equal before the law." It did not say how many ultra-

Orthodox should be drafted.

The court also ruled that state subsidies for seminaries where exempted ultra-Orthodox men study should remain suspended. The court temporarily froze the seminary budgets earlier this year. In a post on the social media platform X, cabinet minister Yitzhak Goldknopf, who heads one of the ultra-Orthodox parties in the coalition, called the ruling "very unfortunate and disappointing." He did not say whether his party would bolt the government.

'The state of Israel was established in order to be a home for the Jewish people whose Torah is the bedrock of its existence. The Holy Torah will prevail," he wrote.

The ultra-Orthodox see their full-time religious study as their part in protecting the state of Israel. Many fear that greater contact with secular society through the military will distance adherents from strict observance of the faith.

Ultra-Orthodox men attend special seminaries that focus on religious studies, with little attention on secular topics like math, English or science. Critics have said they are ill-prepared to serve in the military or enter the secular work force. Religious women generally receive blanket exemptions that are not as controversial, in part because women are not expected to serve in combat units.

The ruling now sets the stage for growing friction within the coalition between those who support drafting more ultra-Or-

the idea. Ultra-Orthodox lawmakers are likely to face intense pressure from religious leaders and their constituents and may have to choose whether remaining in the government is worthwhile for them.

Shuki Friedman, vice-president of the Jewish People Policy Institute, a Jerusalem think tank said the ultra-Orthodox "understand that they don't have a better political alternative, but at same time their public is saying why did we vote for you?"

The exemptions have faced years of legal challenges and a string of court decisions has found the system unjust. But Israeli leaders, under pressure from ultra-Orthodox parties, have repeatedly stalled.

It remains unclear whether Netanyahu will be able to do so again. Netanyahu's coalition is buoyed by two ultra-Orthodox parties who oppose increasing enlistment for their constituents. The long-serving Israeli leader has tried to adhere to the court's rulings while also scrambling to preserve his coalition. But with a slim majority of 64 seats in the 120member parliament, he's often beholden to the pet issues of smaller parties.

Netanyahu has been promoting a bill tabled by a previous government in 2022 that sought to address the issue of ultra-Orthodox enlistment. But critics say that bill was crafted before the war and doesn't do enough to address a pressing manpower shortfall as the army seeks to maintain its forces in the Gaza Strip while also preparing for potential war with the Lebanese Hezbollah group, which has been fighting with Israel since the war in Gaza erupted last October. With its high birthrate. the ultra-Orthodox community is the fastest-growing segment of the population, at about 4 per cent annually. Each year, roughly 13,000 ultra-Orthodox males reach the conscription age of 18, but less than 10 per cent enlist, according to the Israeli parliament's State Control

SEOUL. June 25: South Korea threatened on Tuesday to restart anti-Pyongyang frontline propaganda broadcasts in the latest bout of Cold War-style campaigns between the rivals after North Korea resumed its trash-carrying balloon launches. On Monday night, North Korea floated huge balloons carrying plastic bags of rubbish across the border in its fifth such campaign since late May - an apparent response to South Korean activists flying political leaflets via balloons.

In a Tuesday speech marking a Korean War anniversary, South Korean President Yoon Suk Yeol called North Korea's balloon activities "a despicable and irrational provocation." He said South Korea will maintain a firm military readiness to repel any provocations by North Korea.

Later Tuesday, Yoon boarded a visiting US aircraft carrier docked at a southeastern port and told American and South Korean troops there that the two countries' alliance is the world's greatest and can defeat any enemy. Yoon became the first sitting South Korean president to board a US aircraft carrier since 1994.

South Korea's military said North Korea floated about 350 balloons in its latest campaign, and about 100 of them eventually landed in South Korean soil, mostly in Seoul and nearby areas. Seoul is about 40-50 kilometres away from the border. The military said the trash carried by the North Korean balloons were mostly papers and that no hazardous items were found.

In its earlier balloon launches. North Korea dropped manure, cigarette butts and waste batteries along with cloth scraps and waste papers in various parts of South Korea. No major damage was reported. In response, South Korea redeployed gigantic loudspeakers June 9 along the border for the first time in six years and briefly resumed anti-North Korean propaganda broadcasts. (AP)

"This is the result of a long, long process which has been going on for some time. It has been a tough battle, but the focus now is on Julian being reunited with his family, Hrafnsson told the PA news agency. "The most important thing is that Julian is free and he is finally able to enjoy the big blue sky."

In a statement posted on the social media platform X, WikiLeaks said Assange boarded a plane and departed Monday after leaving the British prison where he has spent the last five years. WikiLeaks applauded the announcement of the deal, saying it was grateful for "all who stood by us, fought for us, and remained utterly committed in the fight for his freedom.

Albanese told Parliament that an Australian envoy had flown with Assange from London.

"Regardless of the views that people have about Assange's activities, the case has dragged on for too long," Albanese said. "There's nothing to be gained by his continued incarceration and we want him brought home to Australia." (AP)

### Domestic workers in Jorhat demand minimum wage

JORHAT, June 25: Grihakarmi Adhikar Suraksha Samiti (the body of household and domestic workers, Jorhat, on Monday staged a demonstration in front of the Assistant Labour Commissioner (ALC) office, here seeking fulfillment of several demands, which included fixing of minimum wages, timely payment of the wages and a weekly off day.

The protesters stated that a large number of household workers were employed by the people in their houses daily to carry out all kinds of household chores and they (workers) have to toil very hard without any break in a week. Stating that the household workers were one of the most neglected lot, the protesters pointed out

they were paid meagre amount as there was no minimum amount fixed for their wages and no law, rules of the Government to grant them legitimate rights.

Alleging that the workers did not have any job security as they were often abruptly fired by their employers and also not paid their wages on time many-a-occasions, the protesters further alleged of illtreatment meted to them by many employers. The workers later submitted a memorandum to the ALC seeking fulfilment of their demands by the Government by attending to their grievances mentioned above. They also sought setting up of a cell at the ALC office here to receive complaints regarding problems faced by them at their work places to get early redressal.

# Om Birla is NDA's pick for LS Speaker

Oppn forces election by fielding K Suresh

NEW DELHI, June 25: The ruling BJP-led NDA on Tuesday maintained its streak of continuity in its third term by fielding previous Lok Sabha Speaker Om Birla for the crucial parliamentary position again, but its bid for a consensus was thwarted by the opposition which forced an election by nominating Kodikunnil Suresh as its candidate.

opposition's lastminute decision to go for a rare contest came after senior BJP leaders did not agree to its precondition that the INDIA bloc must be offered the post of Deputy Speaker in lieu of supporting Birla, who is the clear favourites in case of an election.

A brief interaction involving Congress leader K C Venugopal and DMK's T R Baalu from the opposition side and Union ministers Rajnath Singh, Amit Shah and J P Nadda, who is also the BJP president, at Singh's office in Parliament to evolve a consensus ended in acrimony as both sides stuck to their posi-

Both opposition leaders walked out, with Venugopal accusing the government of not following the "convention" of an opposition candidate for the Deputy Speaker's position and announcing the decision to field a candidate against Birla.

Union ministers Piyush Goyal of the BJP and Lalan Singh of the JD(U) accused the opposition of resorting to pressure politics and putting forth preconditions despite senior ministers' assurance that its demand will be considered when the time to pick the Deputy Speaker comes.

"There can be no pressure politics," Union minister and JD(U) leader Lalan Singh told reporters, while Goyal said democracy cannot be run on preconditions.

The scheduled day for picking the Speaker is Wednesday and if an election occurs, it will be only the third time in Lok Sabha's history, official sources said.

With the NDA having 293 MPs in its kitty and the INDIA bloc 233, numbers clearly favour Birla in Lok Sabha, which currently has 542 members after Rahul Gandhi resigned from one of the two seats he was elected from. At least three independent members also support the

BJP sources claimed that the Congress has been the main aggressor on the issue and some other INDIA bloc members are not very keen on

If Birla, the BJP MP from Kota, is elected, it will be fifth time that a Speaker would serve beyond the tenure of one Lok Sabha. Though Congress leader Balram Jakhar is the only presiding officer to have served two complete terms extending seventh and

A third-term MP, Birla is also a three-term former Rajasthan MLA and has risen through the ranks in the BJP. Suresh, his rival for the Speaker's post, is a eighthterm MP from Kerala and hails from a Dalit community.

If a division of votes takes place in Lok Sabha on Wednesday, then paper slips will be used as the electronic system is not operational yet in the new Lok Sabha where members are still in the process of being allocated their seats.

Seasoned BJP leader Rajnath Singh had taken the lead in reaching out to opposition parties over the issue as Birla emerged as the NDA's consensus choice and met its senior leaders, including Prime Minister Narendra Modi.

Suresh said it is not about winning or losing, but about a convention that Speaker will be of ruling party and deputy speaker from the opposition.

"Last two Lok Sabhas, they denied us deputy speaker's post because they said you are not recognised as the opposition. Now we are recognised as the opposition, (and) deputy speaker post is our right. But they are not ready to give us. Till 11.50, we were waiting for reply from government's side but they did not give any reply," he told re-

Congress general secretary Jairam Ramesh said this has come barely 24 hours after the prime minister advocated consensus in running the country.

"Convention has been that the Speaker is elected unanimously and the deputy speaker's post goes to the opposition," Ramesh said.

He accused Prime Minister Modi of breaking this tradi-

"It is actually no surprise. He has still not woken up to the reality of the 2024 poll verdict which was a PPM defeat for him--personal, political and moral," he posted on

Sources said more than 10 sets of nominations (called notices for motion) were filed in support of Birla's candidature, including from Prime Minister Modi, Union ministers Shah, Singh and Nadda, and members of BJP allies like TDP, JD(U), JD(S) and LJP (R).

Three sets of nominations were filed in support of Suresh.

Known of its knack of springing surprises, the BJP leadership chose to stick to Birla in line with its decision to retains its old hands in key positions.

Though the Speaker is independent of political and executive control, realpolitik considerations are often the driving force behind the choice for the Chair which is the nerve centre of Parlia-

# Atishi's indefinite hunger strike over water scarcity ends with her hospitalisation

NEW DELHI, June 25: Delhi Water Minister Atishi's indefinite hunger strike to demand water for the national capital amid its ongoing scarcity came to an end after she was hospitalised due to her worsening health conditions in the early hours of Tuesday. Atishi, who holds multiple portfolios in the Delhi government, was admitted to the emergency ICU at the Lok Nayak Hospital, and her condition is stable now. Delhi BJP president Virendra Sachdeva wished her good health and happiness, even as he said, "She should stop misleading the public." Giving an update on Atishi's health, the hospital's Medical Director Dr Suresh Kumar said her condition is stable but she is in ICU.

"She was advised hospitalisation last evening after her sugar levels declined and the presence of ketones was detected in her urine. She had declined hospitalisation. However, at midnight, as her condition deteriorated and she was drowsy, she was admitted. She is currently stable and in the ICU. Her blood tests are being done," the senior doctor said.

The doctor said she is being given water and is on intravenous therapy. Her sugar levels had declined to 36mg/dL.

Explaining the consequences of the sharp decline, Kumar said if a person's sugar level goes below 50 mg/dL, it can have serious consequences

"Brain cells need glucose and if glucose does not reach them, it causes drowsiness and unconsciousness. If not given medical attention on time, a patient can go into a hypoglycemic coma. The fall in blood sugar levels can also lead to multiple organ failure. Hypoglycemia is a medical emergency for brain cells and other organs if not addressed in time," he added.

The normal sugar levels in the blood should be between 70 mg/dL and 100 mg/dL. Atishi had begun her hunger strike on June 21. AAP Rajya Sabha MP Sanjay Singh said the minister ended her indefinite fast after she was hospitalised.

At a press conference here, Singh said Atishi's health deteriorated after being on fast for nearly five days and she was admitted to the LNJP Hospital around 3.45 am.

Atishi is now admitted to the ICU and tests are being conducted, so the indefinite hunger strike has been stopped, he

### Bihar govt cancels ₹ 826 crore-contracts awarded during 'Mahagathbandhan' regime

PATNA, June 25: The NDA government in Bihar has cancelled 350 contracts worth ₹ 826 crore, which were awarded during the previous 'Mahagathbandhan' dispensation in the state for supplying drinking water in rural areas, a minister said on Tuesday.

The decision to cancel the contracts was taken after an inquiry by the Public Health Engineering Department revealed that there were "irregularities in the process of selecting contractors", he said.

"During the previous grand alliance regime in the state, many contracts were awarded by the department. An inquiry by the department revealed that due process was not followed in awarding 350 contracts hir Kumar Jain said the trial court worth ₹826 crore. These were related to the failed to appreciate the material rural water supply, including the installation placed before it by the Enforcement of hand pumps and mini water supply sys-Directorate and did not apply its tems," PHED Minister Niraj Kumar Singh mind while deciding the AAP told PTI.

The department has handed over the preliminary inquiry report to the competent authority in the state government for a thorough probe, he said.

"I recently called a meeting of senior officials of the department after getting the report, and later the cancellation order was issued," he said, adding that strict action would be taken against those who would be found guilty.

RJD leader Lalit Yadav was the PHE minister during the previous grand alliance government in the state.

court order at a press conference, Delhi cabinet minister Saurabh Altogether 1,160 contracts worth ₹ 4,600 crore of the PHE department were awarded Bharadwaj said the AAP's legal team will decide the future course by the previous government in 17 months,

The previous 'Mahagathbandhan' government in the state had executed several people-friendly projects and taken major decisions like employment to 7-8 lakh youths and providing social security to the economically and socially weaker sections of the so-

The NDA partners are also "scared" of the impact of the welfare initiatives taken by the previous government, which benefitted lakhs of people in the state, he claimed. "RJD is not scared of any probe...let

them (the NDA government) do whatever they want to," he added. The PHE department is responsible for

# WHO urges member countries in Southeast Asia

# to take steps to eliminate illicit tobacco trade NEW DELHI, June 25: The World

Health Organization on Tuesday called on member countries in the Southeast Asia Region to take effective steps to track, trace and eliminate illicit trade of tobacco products and control unrecorded alcohol.

It cautioned that all forms of tobacco and alcohol, legal or illegal, are harmful to health.

"Effective control of illicit tobacco trade and unrecorded alcohol is a challenging and daunting task but now is the time to prudently make our decisions and choose the best way forward," World Health Organization (WHO) Regional Director Saima Wazed urged in her opening remarks at a regional workshop in New Delhi to address the challenges of illicit tobacco trade and unrecorded alcohol.

"As a first step, all our remaining member states should become parties to the WHO FCTC (Framework Convention on Tobacco Control) protocol to eliminate illicit trade in tobacco products," she said.

India and Sri Lanka from the WHO's Southeast Asia Region are parties to the WHO FCTC protocol so far.

Wazed also called on member countries to devote optimal resources to develop, implement and sustain effective track-and-trace mechanisms for tobacco products.



Progress in combating illicit trade has been slow in the region, with appropriate policies and tools either not in place or not optimally implemented, she said.

Experience from many countries shows illicit trade can be successfully addressed, even when tobacco taxes and prices are raised. This results in increased tax revenues while simultaneously reducing tobacco use, Wazed said.

"It is essential to compile existing and generate new regional evidence to enable policymakers to make better-informed and more effective policy decisions to monitor and combat illicit tobacco trade and unrecorded alcohol," she added.

An estimated 25 per cent of global alcohol consumption is unrecorded. This is usually of a lower price and appeals

to consumers from low socioeconomic status and people with underlying alcohol use disorders. It is often irregularly labelled and frequently contains unknown ethanol percentages and potentially toxic compounds. It is a complex interplay of these factors that make unrecorded alcohol potentially more harmful than regulated alcohol, the regional director said.

Unrecorded alcohol consumption is associated with disproportionate harm that goes beyond toxicity. Online sale of unrecorded alcohol, which circumvents alcohol availability regulations, is an emerging challenge, she said.

Wazed added tobacco use is a significant risk factor for cardiovascular and respiratory diseases, more than 20 different types of cancer, and many other debilitating health conditions. Excessive alcohol consumption has several negative health consequences. It is a risk factor for mental disorders, communicable and noncommunicable diseases, premature mortality, injury, and domestic violence. In addition to the valuable lives lost, both tobacco and alcohol have substantial economic and societal costs.

The workshop is exploring integrating "quitlines" for tobacco, alcohol and substance use, besides global best practices to monitor and combat illicit tobacco trade and unrecorded alcohol consumption. (PTI)

# Part of me was panicked: Irene Taylor on directing 'I Am: Celine Dion' documentary

NEW DELHI, June 25: Oscar nominee Irene Taylor says she "panicked" a bit when she was asked to make a documentary on a celebrity as popular as Celine Dion, but she agreed to come on board after she got to know the singer personally.

"I Am: Celine Dion", a 1.42 hour-long documentary, is a moving portrait about the era-defining musician braving a rare autoimmune neurological disorder called the Stiff-Person Syndrome . It started streaming on Prime Video from Tuesday.

The filmmaker said it wasn't until she developed a fondness for Dion that she decided to direct the film. Taylor is best known for Academy Award-nominated "The Final Inch", about the global effort to eradicate polio, and "Hear and Now", a documentary memoir following her deaf parents as they receive a complex implant surgery.

"Part of me was panicked because I had never made a film about a celebrity before. I had never had a really strong motivation to do that. I thought 'What am I going to do?

Just go on tour with her? Is that interesting? I don't really know'.

"But, I knew I really liked her because I had got to know her and I got the sense that she would be authentic with me. So, I agreed to get on board and make the film," Taylor told PTI in an interview.

According to the makers, "I Am: Celine Dion" is a raw and honest behind-the-scenes look at the iconic superstar's struggle with the life-altering illness which has affected

Dion, the voice behind powerful ballads "My Heart Will Go On", "That's The Way It Is", "The Power of Love", and "I'm Alive", was already unwell when she started filming for the documentary. And this was something the singer and her management team shared with Taylor just before they started

"Shortly before we started filming, her management and Celine herself confided in me that she was ill. They didn't know what the problem was but they were in the

process of getting to the bottom of it. "When I was told that it had become much

more clear that I'm not going to go on tour with her. I might, but if I do, she'll be sick. The film is not just about the illness, it's about many other things. But I knew that would give me focus," she added.

Something shifted in the Las Vegas-based singer when she announced her diagnosis in a social media post in December 2022, the director recalled.

In a tearful video on Instagram, Dion had told fans and followers that she was suffering from SPS and cancelled her European tour set for February 2023. "I saw something shift in Celine when she made that Instagram post that came out... a year and a half ago. When we were shooting the film, there is what I call the before Instagram post era and after Instagram post era," Taylor added.

The 56-year-old singer, the filmmaker said, made the revelation on social media because she was "consumed with guilt of lying". (PTI)

# Jai Mehta on video of Nagarjuna's security pushing fan: Celebs should be less self-obsessed



NEW DELHI, June 25: Eminent personalities need to start being a little less self obsessed and a little more giving, said filmmaker Jai Mehta, reacting to the viral video of Telugu superstar Nagarjuna's bodyguard pushing a differentlyabled fan at an airport. On Sunday, the video started doing rounds on social media. It showed the actor walking out of an airport accompanied by his security detail and his "Kubera" co-star Dhanush.

The fan, apparently a cafe staff, tried to come close to Nagarjuna but was pushed by his bodyguard, making him stumble and almost fall. The bodyguard, however, helped him up. Nagarjuna later apologised for the incident, saying he was unaware about what had happened. "This just came to my notice ... this shouldn't have happened!! I apologise to the gentleman and will take necessary precautions that it will not happen in the future!!" Nagarjuna wrote on Sunday as he shared the video on his X account. Jai Mehta, son of filmmaker Hansal Mehta, posted a lengthy note on X on Monday and said the security detail of celebrities need to be sensitised about treating fans in a respectful manner.

'The security guards ought to be educated on how to control a crowd better and more respectfully. Celebrities/ Politicians/ Sportsmen need to start being a little less self obsessed and a little more giving.

"Don't get me wrong here. I love this actor that he didn't even bother to look at the person that walked into him and didn't even bother to look back the person that got shoved away from him by his security guard!" Jai Mehta posted.

The reason for the mammoth success of actors is "respect, adulation and admiration" they receive from "inconsequential" people, he added.

The director, known for his work on series "Lootere" and "Scam 1992: The Harshad Mehta Story", then talked about his brother Pallava, who has Down's syndrome and is a big fan of Bollywood superstars Shah Rukh Khan and Salman Khan. "What would really break my heart is... if I ever took my younger brother to an industry film screening with me, and by chance at this event his two idols were present. I wouldn't want my brother's innocence and lack of understanding to get him pushed/ flung by anybody that way. No matter who they are," he said.

... I guess I'll just need to teach the handicapped kid to keep his head down and his mouth shut instead of teaching an educated person with a sound state of mind to be a little more aware and gentle," he added.

Hansal Mehta shared his son's post on X and said Pallava is also a "fan" of Nagarjuna. "I'd requested through his brother, his close friends at various times that meeting the star would mean the world to him. And it would be my gift to my boy. When his eyes were operated the first person he recognised in the newspaper was that star," he said. However, there was no response from the actor's team, the filmmaker revealed.

"I gave up. Now over the years Pallu's cognitive abilities have declined. And this will have no meaning even if it has to happen," he added.(PTI)

# Spain beat Albania 1-0 at Euro 2024 to finish perfect group stage

DUESSELDORF (GER-MANY), June 25: Spain changed almost its entire lineup and still kept up its victorious start to the European Championship with a 1-0 win over Albania, which was eliminated.

With his team already assured of winning Group B, coach Luis de la Fuente changed 10 of his starters and Spain won all three group games at a Euros for the first time since 2008, when it went on to win the tournament.

A 13th-minute goal from Ferran Torres and goalkeeper David Raya's stoppage-time save from Armando Broja ensured Spain completed the group stage without conceding a goal. "Every player is ready to play in this first 11 and that's key. Anyone can decide a game for you and players coming off the bench are very important as well," Torres, who made his first start of Euro 2024, said through a translator. "I will try to make things difficult for my coach so that he will have to play me."

Torres scored with a deflection off the post from Dani OImo's pass, and put his fingers to his ears in his goal celebration. He said the gesture meant he was listening to the fans, not blocking anything out. "I don't have anything to prove out there," Torres added.

Italy was the second qualifier from Group B after drawing with Croatia 1-1.

Albania needed at least a draw to have any hope of qualifying for the knockout stages for the first time, even as one of the best third-place teams. The



Albania's failure to beat Spain meant England. France and the Netherlands were all assured of qualifying for the knockout stages, regardless of what happens in their last group games.

All of those teams were on four points from two games and would qualify at least as one of the best third-placed teams.

Spain got the job done, but this 1-0 win was far less convincing than the victory by the same margin over Italy in its last game. Defender Aymeric from Raya. Laporte was the only player to start both.

Luka Modric's second-half strike looked like sending Croatia through as the Group B runnerup, but Zaccagni swept a brilliant shot inside the far post in the eighth minute of added time to cap a furious finale from the defending champions. Croatia coach Zlatko Dalic

Italy needed a point to progress, while Croatia realistically needed a win to stay in the tournament. The Croatians have two points from their three games and were at the mercy of other results to see if it's enough to scrape through as one of the best third-place finishers.

Dalic made no mention of waiting. He already believes his side is out.

Italy will face Switzerland in the round of 16 on Saturday in Berlin's Olympiastadion, where the final is on July 14.

"We were a bit soft at times in the game, we didn't produce our best football," Italy coach Luciano Spalletti said. "When you can afford to draw the game, that's how it goes, you know a draw is enough, you are a bit more timid."

But Spalletti bristled at a question asking if he was concerned about his team trailing going into stoppage time.

"Worries and concerns are part and parcel of this job," the Italy coach said. "We did what we needed to do."

Modric scored 33 seconds after having a penalty saved by Italy goalkeeper Gianluigi Donnarumma to become the oldest goal-scorer ever at the tournament. Modric, at 38 years, 289 days on Monday, broke the record held by Ivica Vastic, who was 38 years, 257 days, when he scored for Austria against Poland at Euro 2008. (AP)

# Test cricket at very low point in West Indies, I see mass exodus of players to US: Sarwan

G E O R G E T O W N (GUYANA), June Ramnaresh Sarwan, one of the most prolific batters to have played for the West Indies, is leading a comfortable life after retirement but when one talks him to him about the health of Test cricket in the region, he paints a grim picture, fearful of a talent exodus to the USA.

The unexpected growth of T20 cricket and players' preference for the shortest format has put red-ball cricket on the backburner. First-class teams play as little as five games per season, which Sarwan thinks should be increased to at least 10.

Speaking to PTI, the 44-yearold also lamented the lack of cricket facilities in the region. He featured in 87 Tests and 181 ODIs aggregating more than 10,000 runs across formats and played alongside fellow Guyanese Shivnarine Chanderpaul and the great Brian Lara for the better part of his career.

"Yeah well Test cricket is at a very low point to be honest.

playing again in the Caribbean, I don't think it's sufficient to develop our players but I also think there is this major threat of T20 cricket where a lot of people are showing interest in the shortest format," he said. "I think one of the biggest

challenges we've had is facilities in the region. I think the cricket board has been working on it. So we'll see what happens," he added. Sarwan has nothing against

"So you might find a lot of people jumping ship in terms of coming to the US and start participating in T20 and of course try and see if they could find a way in terms of becoming legal in the US and then start hopefully pushing the play in the US," said Sarwan, who also spends a lot of time in the US.

The former West Indies captain has lot on his plate. He runs a couple of restaurants in Georgetown, one being an Italian-American joint and the other serves Thai and Indian fusion food.

Talking more about Tests, Sarwan, who was known for his sound technique and wrist work, said an immediate solution is not

"I don't think it's something that can be done only in the Caribbean. I think the ICC probably would have to intervene to put a limit in terms of how many T20 tournaments are being played around the world.

"Of course you want to have the best players available for all

those leagues and of course you also want to be able to represent the countries. So I think it's a major challenge in terms of saying what is the ideal scenario. At some point in time, the ICC probably would have to intervene which I really don't see happening in the near future," said Sar-Has the pride of playing for

West Indies diminished in the era of T20 leagues? "I don't want to say it's dimin-

ished. But probably because of the shorter format of the game, it has taken a lot of players' attention. So, they probably would have worked more in the shorter format rather than the longer for-

"We all know what Test cricket requires. We just don't call it Test cricket because of the term test cricket, right? It's been over five days and of course the test is usual in every aspect you could possibly think of.

'That is one of the reasons, like said, the guys have probably lost their focus on the longer format," Sarwan reasoned. (PTI)

GROS ISLET (ST LUCIA), June 25: He fell short of a potentially record-shattering hundred, but milestones "don't matter" to India skipper Rohit Sharma, whose sole aim while batting is to "put bowlers under pressure" by hitting them all over the field.

Rohit's 92-run knock that came off 41 deliveries steered India to a 24-run win over former champions Australia in their final Super 8 outing of the ongoing T20 World Cup on Monday. The record for the fastest T20 World Cup hundred belongs to West Indian swashbuckler Chris Gayle, who pulled it off in 47 deliveries in the 2016 edition.

Expectedly adjudged player of the match for the memorable effort, which was punctuated by eight sixes and seven fours, the 37year-old said his focus was only on maintaining the "tempo" of the match. India will take on England in the second semifinal on June 27.

"It was a good wicket, and you want to try and back yourself to play those kinds of shots. I've been trying to do that for a few years now, and I'm glad it came off today. The fifties and hundreds

# Warner makes low-key exit from international cricket after Afghans beat Bangladesh in T20 WC

KINGSTOWN, June 25: Australia batting great David Warner's 15-year-long international career, dotted with glorious achievements and controversies in equal measure, has come to an anti-climactic end after Afghanistan beat Bangladesh, eliminating the former champions from the T20 World Cup at the Super Eight phase.

Australia, the 2021 champions, finished at third place in the Super 8s Group 1 table with just two points -- from the win against Bangladesh. They had suffered a shocking loss to Afghanistan and a humbling defeat to India.

The 37-year-old Warner, who made his international debut in January 2009 in a T20I match, thus made a low-key exit from international cricket with Australia's 24-run loss to India on June 24 at Gros Islet being his last

There was no guard of honour or standing ovation, befitting one of Australia's all-time great batters. He made six runs off six balls in the match, edging Arshdeep Singh as Suryakumar Yadav took a low catch. He walked off the pitch with his head down, not knowing whether that was his last game.

Warner's retirement has been gradual. He played his final ODI match in the World Cup final win over India in November 2023 and his last Test against Pakistan in January. He has long signalled that this T20 World Cup would be his final tournament.

He retires as Australia's highest scorer and seventh-most prolific batter in the world in T20 format with 3,277 runs from 110 matches, at an average of 33.43 and strike rate of 142.47. He scored one hundred and 28 fifties in the shortest format.

From 112 Tests, he has scored 8,786 runs at an average of 44.59 with 26 hundreds and 37 fifties between 2011 and 2024.

He also scored 6,932 runs from 161 ODI matches at an average of 45.30 with the help

of 22 centuries and 33 half centuries.

Warner, who has 49 centuries across formats and close to 19,000 runs in international cricket, had acknowledged that his name will forever be linked to the sandpaper gate scandal that took place at Newlands, Cape Town during a Test match against South Africa in 2018.

Warner's involvement in the scandal in the Newlands Test, when Cameron Bancroft used sandpaper to scuff the ball earned him a oneyear ban, the same punishment as that of thethen skipper Steven Smith. Warner was also banned for life from taking any leadership role in the Australian cricket setup.

"I think it's going to be inevitable that when people talk about me in 20 or 30 years' time, there will always be that sandpaper scandal,' he said last week at North Sound ahead of Australia's Super 8 clash against Bangladesh.

"But for me, if they're real cricket tragics and they love cricket, (as well as) my closest supporters, they will always see me as that cricketer - someone who tried to change the

were below MER level. Agarwalla achieved MERs four times --67.936 per cent (Wiesbaden, May 2024).
