Reading the operative part of the majority verdict, the CJI said the 1989 verdict of the apex court's seven-judge Constitution bench, which had held that royalty is tax, is incorrect.

"Royalty is not within the nature of tax as it is a contractual consideration paid by the lessee for the

mining lease. Both royalty and dead rent do not fulfil the characteristics of tax. The judgement in India Cements (1989 verdict) holding royalty to be a tax is overruled," the CJI said.

Royalties are payments that the user party makes to the owner of an intellectual property or real property asset.

Under Entry 49, states have the power to levy taxes on lands and buildings, while Entry 50 allows states to impose taxes on mineral rights subject to any limitations imposed by Parliament by law relating to mineral development.

The CJI said the Mines and Minerals (Development and Regulation) Act (MMDRA), 1957 does not limit the states from imposing taxes on mines and mineral development. "There is no specific provision in the MMDR Act imposing limitations on the taxing powers of the State. Royalty under MMDRA

bench said, adding "States have legislative competence to tax mines, minerals and mineral bearing land." At the outset, the CJI said the bench has delivered two separate verdicts and Justice B V Nagarathna has given dissenting

Reading out her verdict, Justice Nagarathna said the states do not have the legislative competence to levy taxes on mines and minerals bearing lands. The bench decided the hugely contentious issue of whether the royalty payable on minerals is a tax under the MMDRA, and if only the Centre is vested with the power to levy such exaction or states also have the authority to impose levies on mineral bearing land in their territory.

Urged central govt to enact MoS clauses to empower KAAC: Tuliram on his Delhi visit

DIPHU, July 25: Karbi Anglong Autonomous Council (KAAC) chief Tuliram Ronghang stated on Thursday that he has been in New Delhi for the past four to five days, pursuing the central government for the enactment of various clauses from Memorandum of Settlement (MoS) 1 and 2 to empower the current KAAC.

Ronghang made these remarks while addressing media personnel at his official residence in Diphu.

He informed that in 2011, the now-disbanded armed group

United People's Democratic Solidarity (UPDS) signed an MoS with the Central government to secure direct funding for development and to enhance KAAC's authority. Additionally, in 2021, six disbanded armed organizations also signed an MoS with the state and central governments to bolster development and improve political, social, and cultural safeguards for scheduled tribes communities under KAAC's jurisdiction.

"We were in New Delhi to urge the central government to include MoS 1 and 2 clauses in the 165th constitutional amendment, thereby enabling direct funding, enhanced development, and better protection for scheduled tribes under KAAC," added the CEM.

"Since the Memorandum of Understanding (MoU) signed by ASDC with the Central government in 1995, KAAC has gained oversight of 30 departments. Implementing MoS 1 and 2 could potentially bring an additional 54 departments under KAAC's jurisdiction, encompassing both legislative and executive powers," he elaborated.

Addressing misconceptions about Article 280 of the Constitution of India, the CEM clarified that it pertains to the funding framework of the Central government, not the establishment of Panchayati Raj, as alleged by some opposi-

Sarma claimed that the number of pending cases in Assam has significantly decreased, from 95,994 in 2021 to 18,286 cases in 2024.As per Sarma, each investigating officer now has fewer cases to handle. 52 cases were filed against each investigating officer in the police department in 2021; by June 2024 that number has come down to just 7.39 cases. The significant decrease in the average cases that each officer handles has been commended by the Chief Minister. "Due to our modernisation efforts, the average number of cases, an Investigating Officer of @assampolice look after has significantly come down, reducing their burden and improving quality of investigation," Sarma



wrote on micro-blogging site X.

This has resulted in a drastic reduction in case pendency, benefiting a large section of society, he said. Over the past three years, the chief minister has implemented various measures aimed at transforming the state police force as a whole. Assam implemented the Body Mass Index (BMI) calculation for all policemen last year in an effort to increase the fitness of the police force. Sarma has previously ordered that any police officer discovered to be drunk will be dismissed from the job immediately. "Police should always act responsibly to ensure that the public is at ease when visiting police stations," he had said.

Markets extend losses for 5th session: metal, bank stocks major drag

MUMBAI, July 25: Equity market benchmark indices Sensex and Nifty stayed on the back foot for the fifth straight session on Thursday as investors offloaded metal, banking and finance stocks amid a lacklustre trend in global markets.

Heavy foreign fund outflows after a hike in securities transaction tax and short-term capital gains tax also impacted markets' sentiment negatively, traders said.

However, strong buying in oil & stocks, energy and auto shares helped the indices offset some losses, they added.

After a sharp fall in intra-day trade, the 30-share BSE Sensex managed to recover some of the lost ground to settle 109.08 points or 0.14 per cent lower at 80,039.80, as a sharp rally in Tata Motors and Larsen & Toubro restricted its fall. During the day, it tanked 671 points or 0.83 per cent to 79,477,83

Shares of Larsen & Toubro ended nearly 3 per cent higher after the company posted a 12 per cent rise in consolidated profit after tax (PAT) in the June quarter.

Tata Motors jumped nearly 6 per cent. The NSE Nifty dipped 7.40 points or 0.03 per cent to 24,406.10. Intra-day, it tumbled 202.7 points or 0.83 per cent to 24,210.80.

In five days, the BSE benchmark has tumbled 1,303.66 points or 1.60 per cent, while the Nifty declined 394.75 points or 1.59 per

Rupee falls 1 paisa to close at alltime low of 83.72 against US dollar

MUMBAI, July 25: The rupee fell 1 paisa to close at an all-time low of 83.72 (provisional) against the US dollar on Thursday, dragged down by demand for the American currency in the overseas market and significant foreign fund outflows.

Forex traders said the fall in domestic unit came on the heels of a significant downturn in the Indian equity markets, sparked by the government's decision to hike the tax rate on capital gains.

At the interbank foreign exchange market, the local unit opened at 83.72 and touched an intra-day high of 83.66 and a low of 83.72 against the dollar during the session.

It finally settled at an all-time low level of 83.72 (provisional) against the American currency, down 1 paisa from its previous

On Wednesday, the rupee depreciated 2 paise to hit its all-time closing low of 83.71 against the US dollar.

The local unit appreciated slightly during the intra-day trade on supposed intervention by the Reserve Bank of India (RBI) and overall weakness in crude oil prices, said Anuj Choudhary, Research Analyst at Sharekhan by BNP Paribas.

"We expect the rupee to trade with a slight negative bias on weak global markets and fresh FII outflows. However, weak US dollar and declining crude oil prices may support the rupee at lower levels. intervention by the Reserve Bank may also support the rupee,"

Choudhary added. The government's decision to hike the tax rate on capital gains

dampened market sentiment, exerting immense pressure on the rupee and the equity market.

JB Pardiwala, Manoj Misra, Ujjal Bhuyan, Satish Chandra Sharma and Augustine George Masih. The nineudge bench of the apex court began hearing the complex matter on February 27 because of two apparently conflicting constitution bench decisions on the issue.

The case has its roots in a dispute between India Cement Ltd and the Tamil Nadu government. India Cement secured a mining lease in Tamil Nadu and was paying royalty to the state government.

The state government then imposed a cess in addition to royalty on India Cement, which moved the Madras High Court against the measure, contending that a cess on royalty meant a tax on royalty which was beyond the remit of the state legislature. The TN government argued the cess was by way of land revenue and on mineral rights, which it was empowered to impose. A 7-judge bench had decided in favour of India Cement in 1989. It had ruled the Centre was the primary authority under the MMDRA.

It held that states can collect royalty under the MMDRA but cannot impose further tax on mining and mineral development. ".....royalty is a tax, and as such a cess on royalty being a tax on royalty, is beyond the competence of the State Legislature...," the top court had held.

However, in 2004, a five-judge constitution bench, while hearing another dispute over imposition of cess on land and mining activities between the state of West Bengal and Kesoram Industries Ltd held there was a typographical error in the 1989 verdict and that royalty was not a tax. It said the phrase "royalty is a tax" should nstead be read as "cess on royalty is a tax" and that the 1989 judgement held that royalty is not a tax.

Over 80 more petitions were filed in the Supreme Court over the years, and since the India Cement matter was dealt with by a seven-judge bench, the matter was referred to a nine-judge bench to decide whether royalty is a type of tax or there was an error in the India Cement case judgement.

While States' defended their right to impose tax on land and mineral activity during the 8-day long hearing, the Centre, mining companies and public sector undertakings had contested the contentions, saying only Parliament can impose taxes on minerals by virtue of the MMDRA and states are completely denuded of the power to levy any taxes on mines and minerals.

Urged central govt to enact

Ronghang also clarified that one MoS clause aligns with the Sixth Schedule of the Constitution of India, mandating the establishment of Traditional Village Development Councils (TVDCs) in tribal areas with populations of 500 to 1000, and Village Development Committees (VDCs) in non-tribal areas with populations of 3000 to 5000, aimed at fostering development. Meanwhile, in support of the CEM's assertions, the BJP East Karbi Anglong District Committee (EKADC)

convened a press conference at the BJP-EKADC office, where Bijoy Teron, president of Minority Morcha, West Karbi Anglong, emphasised that Article 280 enables TVDCs to receive funds from the Central government. Teron criticised JI Kathar, president of the All Party Hills Leaders Conference (APHLC), alleging that he abandoned negotiations during the Joint Action Committee for Autonomous State (JACAS) talks with the Central

BJP spokesperson Selawar Bey accused Kathar of opposing the 125th constitutional amendment without fully understanding the concept of an Autonomous State. Bey accused Kathar of misrepresenting the Sixth Schedule to the public. BJP-EKADC media incharge Bidyasing Rongpi highlighted that the 125th constitutional amendment aims to strengthen KAAC's authority. He criticised Kursing Timung, organising secretary of APHLC, for opposing the amendment without understanding its implications.

Another BJP spokesperson, Laichan Engleng, quoted Kathar as saying, "If funds are allocated through Article 280, it will reduce the Sixth Scheduled Autonomous Councils to mere Panchayati Raj institutions," which Engleng disputed, urging Kathar not to obstruct progress.

Google recently decided to cut the pricing of Google Maps platform for developers by up to 70 per cent from August 1, just weeks after Ola Founder and CEO Bhavish Aggarwal openly nudged Indian developers to shun Google Maps and offered them sweeteners like one-year free access to Ola

Emphasising its focus on the market, Google Maps on Thursday said India is at the centre of its innovation, and that it "can't wait to build the future of Maps right here". India is the first country to get EV charging stations feature for two-wheelers on Google Maps, and senior company officials said it will look at replicating features like this and others, with tweaks where necessary, for use in other markets, as well.

Replying to a question on the timing of Google Maps' price cuts - coming right after an offensive from Ola - Google Maps senior executives said that while "it's tempting to think that way, but we actually do not focus on competi-

"We're very focused on making sure we're serving our user base and our partner community, which is our developer partners. And to be honest, we timed it with our IO Connect event in Bengaluru," Miriam Daniel, VP and GM, Google Maps said at a briefing.

"We're excited to continue our journey of innovation, and build the future of Google Maps right here in India," a blogpost by Daniel and Lalitha Ramani, GM, Google Maps, India, read.

Stating that navigating narrow or congested roads in unfamiliar areas can be a challenge for fourwheeler drivers, Google Maps announced it is introducing a new feature for users in India designed to reduce the use of narrow roads when driving four-wheelers.

This means four-wheeler drivers can enjoy a less stressful driving experience, and it also benefits bikers, pedestrians and other commuters who can now use these narrow roads more safely and

confidently, it added. Google Maps is starting to roll out this feature on Android devices this week in eight cities - Hyderabad, Bengaluru, Chennai, Coim-Indore, Bhubaneswar and Guwahati, and has promised to bring the feature

to iOS and more cities soon. Another new feature on Google Maps is call-out flyovers along the recommended route. This feature helps users anticipate upcoming flyovers and prepare ahead of time to get onto the flyover.

KOKRAJHAR, July 25: In a shocking incident, two members of a family were murdered in Kokrajhar town early Thursday

According to local sources, Mithun Saha alias Manas Saha allegedly killed his wife, Rishika Mallik (36), and his mother-in-law, Kalpana Mallik (57), with a sharp weapon. The incident occurred at their residence in Shanti Nagar, Ward No 3, around 5:30 a.m.

Assam flood situation improves, 66,267 still affected in 9 districts



GUWAHATI, July 25: Assam's flood situation improved on Thursmajor rivers receding and the number of people affected by the deluge declining to 66,267 in nine districts, an official bulletin said.

There was no loss of human lives reported during the day with the toll due to flood, landslides, storms and lightning remaining at 114, the Assam Disaster Management Authority's (ASDMA) bulletin said.

The number of affected people declined to 66,267 from Wednesday's estimate of 69,671 in 10 districts, it said.

Morigaon, Dhemaji, Hojai, Dibrugarh, Sivasagar, Nagaon, Golaghat, Goalpara and Jorhat are now on the list of flood-hit districts.

The number of affected revenue circles remains at 21 and the count of villages under floodwater declined to 184 from the previous

Nagaon is the most severely affected district with a flood-hit population of 55,711, followed by Golaghat with 4,874 and Dhemaji with 3,850, the bulletin said. Floodwater inundated 4,076.4 hectares of crop area, declining from the previous day's 4,202 hectares.

Currently, 1,953 people are in 24 relief camps, while an additional 2,298 people received assistance through distribution centres, it said.

River Brahmaputra's tributaries Dikhou and Disang are flowing above the danger mark at Sivasagar and Nanglamuraghat respectively.

During the day, floodwater washed away 22 animals, damaged 13 houses, and breached two embankments. Assam has experienced two waves of flood so far this year, affecting all 35 districts.

The first wave took place between May 28 and June 13, while the ongoing second one began on

Meeting on business development & transportation solutions held

GUWAHATI, July 25: As part of its initiative to further boost the local economy, NF Railway regularly holds meetings and interactions with traders and business communities. The railway has established Business Development Units (BDUs) across all five divisions and at the zonal headquarters level to increase freight transportation volume. These BDUs frequently engage with trade and industry players to identify new traffic for rail movement. Railways, being a faster and more cost-effective mode of transport compared to roadways, aim to enhance the local economy by opening up larger markets nationwide.

On Wednesday, the divisional railway manager, along with senior officials of the Lumding division, conducted a meeting with traders in Lumding. Thirty-three traders participated, discussing issues such as truck shortages, labour availability, placement of goods-loaded railway rakes. conditions at the goods yard, and concerns regarding penal demurrage and wharfage charges for delayed clearance of goods wagons.

BJP's North Bengal merger proposal

he West Bengal unit of the Bharatiya Janata Party (BJP) seems adept at making self-damaging moves. The latest in this series is Balurghat MP and Union Minister of State for Education, Sukanta Majumdar, who has sparked controversy by urging Prime Minister Narendra Modi to merge North Bengal with the North East. Majumdar, who is also the outgoing state BJP chief, is not the first senior BJP leader to propose splitting West Bengal. In 2021, Alipurduar MP John Barla called for creating a separate state or Union Territory out of West Bengal. More recently, BJP Rajya Sabha MP Ananta Maharaj has advocated for a separate state or Union Territory of Coochbehar, claiming that a verbal commitment has been made and it is only a matter of time before this becomes reality. Barla's proposal was swiftly dismissed by Union Home Minister Amit Shah, and it appeared to vanish without further discussion. However, Majumdar's recent demand has gained support from Ananta Maharaj, leader of the Greater Coochbehar People's Movement. Yet, the silence from both Prime Minister Modi and Home Minister Shah on this proposal suggests a lack of endorsement at the highest levels.

Majumdar's assertion that North Bengal shares many similarities with the North East overlooks the historical trauma associated with the partition for many residents of North Bengal. This move seems to alienate BJP's own supporters, potentially driving them towards the Trinamool Congress (TMC). TMC leaders, including Rajya Sabha member Sukhendu Sekhar Roy, have quickly accused the BJP of promoting secessionism—a grave charge in a state still haunted by the memories of Partition and its aftermath. In the recent 2024 Lok Sabha elections, the BJP's tally of MPs from West Bengal fell from 18 to 12, reflecting a decline in their electoral appeal. This decline cannot be solely attributed to alleged TMC muscle flexing, especially given the presence of central forces during elections. The reality is that BJP leaders were noticeably absent when their activists needed support against alleged attacks by TMC-backed goons post the 2019 Lok Sabha and 2021 Assembly elections. This sudden concern for the people of North Bengal is viewed with suspicion, especially given the BJP's electoral setbacks in the state. Prime Minister Modi had confidently predicted the BJP's best-ever performance in West Bengal, a prediction that did not materialize. As the state BJP chief, Majumdar shares responsibility for this outcome, and his proposal for separate statehood may be seen as an attempt to deflect blame.

The BJP's electoral strategy in North Bengal, which involved playing on fears of Bangladeshi infiltrators, has only deepened the divide. Majumdar's call for merging North Bengal with the North East has reignited painful memories of Partition among residents, further alienating potential voters. The BJP's apparent disregard for the sensitivities of North Bengal's residents reveals a disconnect between party leadership and the electorate. By pushing for such divisive proposals, leaders like Maiumdar and Maharaj risk undermining their own party's standing in the state. The TMC's swift condemnation of these proposals as secessionist highlights the political risk the BJP faces. Ultimately, the call for merging North Bengal with the North East may be less about genuine regional alignment and more about distracting from the BJP's electoral missteps. As Majumdar's tenure as state BJP chief comes under scrutiny, this proposal might be a last-ditch effort to shift focus from the party's faltering fortunes in

official recognition of Pakistani intrusions into the Kargil sector, the Indian Army's 15 Corps conducted a wargame. During this exercise, a Brigade Commander, assuming the role of Force Commander Northern Area (FCNA) the adversarial formation across the Line of Control (LoC) in Pakistan-occupied Kashmir (PoK) - outlined a conflict scenario that strikingly mirrored the real events that would soon unfold.

The role of the 'enemy commander' was played by Maj Gen Mohinder Puri, who was then the General Officer Commanding of the 8 Mountain Division and would later be promoted to Lt Gen.

According to those who were familiar with the wargame, the military leadership at the time was predominantly focused on counter-insurgency operations. This narrow focus hindered a comprehensive evaluation of the situation and resulted in flawed assessments. At the onset of the Kargil conflict, the Corps Commander himself believed that only 35-40 militants were involved and expected them to move further into the Val-

For years, wargames at different levels had frequently examined the pofor Pakistani intrusions across the LoC. Despite this, Pakistan was able to clandestinely seize key heights overlooking the Srinagar-Leh National Highway. This was widely regarded as an intelligence failure, or by some, a failure to correctly interpret and act on the available information that had sur-

fended by a full division, which included three brigades, was reduced to just one brigade - the 121 (Independent) Brigade stationed in Kargil, creating significant vulnerabilities. These weaknesses were taken advantage of by then-Pakistani army chief Pervez Musharraf, who maintained tight control over information regarding his operations within his own ranks. The absence of any broad-scale indications from the Pakistani military establishregarding imminent operation further contradicted the intrusion reports emerging from the

northern sector. At the onset of the conflict, operational challenges quickly emerged, including insufficient intelligence and equipment. commanders reported issues such as fragmented troop deployments and a mismatched assortment of frontline units. Supplies were delivered through man packs and mule loads, complicating logistics.

Terrain limitations restricted the deployment of artillery in certain areas, increasingly becoming a

A high-powered committee of four members, led by strategic analyst K. Subrahmanyam (the father of S. Jaishankar, the Minister of External Affairs), was formed to evaluate the conflict. The committee concluded that Pakistan's aggression was entirely unexpected. While the possibility of infiltration by armed irregulars was deemed plausible, the notion of a full-scale intrusion and occupation of territory by Pakistani troops was not anticipated. The committee identi-

fied several deficiencies in the Indian intelligence system and called for major structural reforms within the security establishment. It noted that, although there were no specific signs of an imminent large-scale attack in the Kargil sector - such as major logistical or communication upgrades, a substantial buildup of forces, or forward deployments there were numerous fragments of intelligence concerning activities within the FCNA region.

Many of these fragments suggested that Kargil was focal point of Pakistani interest, a concern underscored by a notable rise in cross-LoC shelling in

Twenty-five years later, there has been a dramatic shift in the strategic landscape and threat perception in the northern sector. This period has also seen significant changes within the armed forces, including high-level structural reorganization, enhanced capabilities, and strategic force redeployments. As with any conflict, the

Kargil war revealed numerous lessons, some of which have been acted upon while others remain mired in bureaucratic delays and superficial responses. In the aftermath of the conflict, several key changes were made, including the establishment of the Integrated Defence Staff Headquarters to address inter-service coordi-

The long-awaited position of Chief of Defence Staff was finally instituted in January 2020. Intelligence capabilities were significantly enhanced with the creation of the Defence Intelligence Agency and the National Technical Research Organisation. Additionally, new formations such as the Strategic Forces Command and the Andaman and Nicobar Command, incorporating elements from all three Services, were established to bolster operational readiness.

"A great deal has changed over the past two decades," remarks Lt Gen YK Joshi (retd), who commanded a battalion during the conflict and later served as the General Officer Commanding-in-Chief of Northern Command. "The 170-km stretch that was once patrolled by just a brigade with significant gaps is now defended by an entire division. The 8 Divisions, Mountain which was temporarily deployed to Kargil during the conflict, has now been sta-

tioned there permanently." "The region is now securely defended, and I don't foresee a repeat of the Kargil-like situation," he continues. "Additionally, given Pakistan's current internal issues and struggling economy, it lacks the capacity for such operations." He also high-

lights that advancements in technology and force multipliers - such as drones, UAV optical devices, and continuous surveillance equipment - have been integrated. Infrastructure improvements have been made, with all forward posts now accessible via tracks and supported by a

robust logistics network. As the nation observes conflict's Jayanti,' several unresolved issues remain. Key among them are whether the war could have been conducted differently to achieve similar results with fewer casualties, the need for declassifying documents to enhance transparency, and the necessity for a thorough analysis and discussion of the roles played by senior commanders.

Wars operate on three levels: tactical, involving sub-units and battalions; operational. brigades, divisions, and corps level; and strategic, encompassing political leadership and government agencies. "In the Kargil conflict, the commendable efforts and sacrifices of young officers and soldiers have been widely recognized and celebrated,' notes a senior serving officer. "However, there has been limited discussion on the contributions and management roles of the Generals and higher defense authorities.

Lt Gen DS Hooda (retd), former General Officer Commanding-in-Chief of Northern Command, acknowledges that intrusions of the scale seen in 1999 are unlikely to recur. However, he points out that one of the key recommendations made after the conflict was the development of a national security doctrine, which remains unpublished to this day.

He notes, "The crucial integration and coordination between the Services and the Ministry of Defence remains unresolved. The necessary level of cooperation between ministry officials and military officers is still lacking, and the tri-service theatre commands are only partially points out that the recommendation for a 'one border, one force' approach has not been fully realized. Currently, the Army and the Indo-Tibetan Border Police are operationally deployed along the Line of Actual Control but report to separate ministries. In contrast, on the Line of Control, the Border Security Force is co-deployed with the Army and operates under its command.

Experts reflect that the Kargil conflict was Pakistan's effort to counterbalance the setback it faced in Siachen and was also part of its broader strategy in Kashmir. Today, along with Siachen, the active Line of Actual Control (LAC) following the 2020 standoff with China remains a significant concern for India. To the immediate north of Siachen lies the Shaksgam Valley, which Pakistan ceded to China and where extensive infrastructure development has been observed. Further east, the Depsang Plains continue to be a volatile region.

The presence of Chinese troops in Pakistan-occupied Kashmir (PoK) adds to the growing concerns. Any potential collusion between China and Pakistan along the northern borders could have significant repercussions. As Lt Gen Hooda emphasizes, "We must remain vigilant regarding this challenge."

In 2020, troops stationed in the counter-insurgency grid across Jammu and Kashmir, as well as other areas were reassigned to the Line of Actual Control (LAC), while the post-Kargil enhanced posture on the Line of Control (LoC) was maintained. The focus of the Northern Command has since shifted primarily to the LAC.

During the Kargil conflict, China stayed silent, primarily due to its limited infrastructure along the Line of Actual Control (LAC), which has since undergone significant development. Previously, it was assumed that if conflict erupted with China, Pakistan might offer support, whereas if the conflict was with Pakistan, China would likely remain neutral. Nirmala Sitharaman's coalition versus federal, political versus economic budget

inance Minister Nirmala Sitharaman stepped with a resolute demeanour, a symbolic gesture marking the unveiling of what many had anticipated as a transformative federal budget for the fiscal year 2024-25. Yet, what unfolded before the nation on July 23 was not a conventional economic blueprint but rather a delicate coalition budget, meticulously crafted to appease disparate political alliances. In a strategic manoeuvre reflecting the exigencies of governing with a precarious mandate, Sitharaman presented what could be characterised as a political budget; a document attuned more to the exigencies of coalition politics than the traditional imperatives of economic stewardship.

And the most miserable part is that she was not even feeling embarrassed that her gamesmanship would be seen as blatant aberration to the otherwise solemn act of budget making.

Against the backdrop of a minority BJP government shored up by the regional powers of Bihar and Andhra Pradesh, the budget's contours bore the indelible fingerprints of compromise and accommodation, where numbers often dictate policy more than principles or prudence. The omission of expected measures to curb inflation underscored the delicate balance required to satisfy regional allies without jeopardizing broader economic stability - a deft tightrope walk that reflected the intricacies of coalition governance in contemporary India.

Central to Sitharaman's address was a purported emphasis on employment generation - a perennial concern exacerbated by the economic aftershocks that BJP's electoral setbacks brought to the fore in the party's post-poll deliberations. Yet, conspicuous by their absence were concrete, target-specific proposals to substantiate this overarching commitment. The absence of a robust roadmap for job creation and a dearth of substantive measures capable of translating lofty rhetoric into tangible outcomes for the millions grappling with underemployment and ioblessness were too obvious to be missed.

The budget's pivot towards a political calculus over a purely economic one was underscored by the interplay of fiscal priorities tailored to assuage the exigencies of the regional partners. Nitish Kumar

and Chandrababu Naidu, pivotal to the BJP's tenuous grip on power, loomed large in the budgetary deliberations, their strategic imperatives often trumping the universal demands of economic prudence. The contours of resource allocation bore the imprimatur of these regional satraps, foregrounding the pragmatic exigencies of coalition governance over the idealism of unfettered economic steward-

Sitharaman's overtures towards inclusive growth resonated with the imperatives of political expediency, yet brought out the inherent contradictions that bedevilled this purported commitment. The absence of tangible measures to curb inflation - a central bugbear for the common man grappling with escalating costs of essentials - underscored the discordant notes between politics and economics. It laid bare the tension between short-term political imperatives and the demands of sustainable economic stewardship - a dissonance that threatened to undermine the government's broader credibility on matters of fiscal prudence as well as the dictates of constitutional propriety in the formulation of Union

Nirmala Sitharaman's 2024-25 budget is bound to stir a storm of criticism and disappointment, particularly from states traditionally at odds with the ruling BJP-led coalition. In a departure from the federalist ethos that typically underpins India's budgetary allocations, her fiscal blueprint appeared to diss equitable distribution of resources, leaving opposition-ruled states like Kerala, Tamil Nadu and Karnataka conspicuously absent from significant mentions or substantive allocations.

The absence of any meaningful acknowledgment or allocation for states governed by opposition parties underscored a glaring departure from the federalist principles enshrined in India's constitutional framework. Historically, India's budgetary process has sought to balance the fiscal needs and priorities of diverse states, irrespective of political affiliations, in adherence to the principle of cooperative federalism. However, Sitharaman's budgetary strategy appeared to tilt decisively towards placating coalition

For opposition-ruled states, the budget's marginalization translated into more than just fiscal neglect; it symbolized a systemic disenfranchisement and a disregard for the diverse economic imperatives that characterize the federal structure. States like Kerala and Tamil Nadu, known for their robust economic contributions and distinctive developmental challenges, found themselves relegated to the periphery of fiscal discourse, their pressing needs overshadowed by the imperatives of coalition politics.

In Kerala, known for its emphasis on social welfare and human development indices, the budget's neglect resonated deeply. The absence of targeted allocations for critical sectors like healthcare, education, and infrastructure underscored a disconnect between the Centre's fiscal priorities and the pressing realities on the ground. With an economy heavily reliant on sectors like tourism and remittances, Kerala's exclusion from substantive budgetary provisions represented a missed opportunity to bolster resilience and foster sustainable growth in the face of evolving global challenges.

Similarly, Tamil Nadu - with its formidable industrial base and significant contributions to India's GDP - found itself sidelined. The state's developmental aspirations, particularly in sectors like manufacturing, agriculture, and urban infrastructure, were relegated to the margins, overshadowed by the exigencies of political accommodation elsewhere. The lack of targetted investments to catalyse job creation, enhance industrial competitiveness, and bolster agricultural resilience underscored a myopic fiscal approach that prioritized short-term political gains over long-term economic sustainability.

In Karnataka, another state governed by an opposition party, the echoes of discontent were palpable. Despite its status as a key economic hub and technological powerhouse, Karnataka's aspirations for infrastructure development, digital innovation, and sustainable urbanization did not find place in the budgetary discourse.

The repercussions of Sitharaman's budgetary strategy extends beyond mere fiscal allocations; they will reverberate through the corridors of state governance, sparking outcry and apprehension among opposition leaders and policymakers. The perceived neglect of opposition-ruled states threatens to deepen existing fault lines and amplify regional grievances, potentially undermining the collaborative spirit essential for India's developmental trajectory. S President Joe Biden's decision to step aside as the Democratic nominee in this year's presidential election certainly had a sense of inevitability about it.

Yet, it is still unprecedented in the modern era for a sitting president to drop out of a presidential race this late in the process. We are really in uncharted waters for American politics.

So, how where does the race go from here – and what does it mean for both the Democrats and Donald Trump, the Republican nominee?

Will Democrats now unite behind Kamala Harris?

Biden has endorsed his vice president, Kamala Harris, as the nominee, which I believe he was always going to do.

Not anointing Harris as his successor would have been politically unthinkable for Biden simply because it would have undermined his own decision-making when he chose her to be his running mate before the 2020 election.

His endorsement will also have a big impact on the decision-making of the Democratic Party as a whole. Anybody who challenges Harris now might well be taking on the establishment of the party. And the party would be wary of increasing perceptions of disunity at this point.

So, it certainly seems the Democrats will unite behind her as the candidate.

That said, it's not out of the realm of possibility that she could be challenged by another presidential hopeful. This may well depend on her performance – and the broader reactions to her – in the next couple of days.

Potential rivals will have political ambitions of their own – we can't discount that.

are so disliked by the American population, Harris (and her running mate) could represent a huge opportunity for the Democrats.

A key strength of Harris is on the

A key strength of Harris is on the critical issue of reproductive rights. She has owned this issue in the campaign so far because Biden has difficulty with abortion politically as a devout Catholic – and we saw how he struggled with the messaging on this issue in the debate.

It's entirely possible it will be a hugely mobilising factor in this year's election, as it was in the 2022 midterm elections.

As such, Harris would have a significant advantage in persuading the Democratic base to turn out to vote on that issue, in addition to other voters.

How would this change the calcu-

lations for Trump?
Assuming Harris does become the nominee, Trump's pick of JD Vance as his vice-presidential running mate may turn out to have been a mistake. Like much of the movement that supports Trump, Vance is virulently antiabortion and committed to further regulations on reproductive rights.

This could be a significant vulnerability for Trump, who doesn't perform as well with women voters compared

And it seems the Trump campaign knows this, which is why it has been campaigning against Harris even before it was clear Biden was going to drop out.

The attacks on Harris from the right have been very brazen in their misogyny and racism.

For example, the New York Post published a column earlier this month saying Harris would be the country's first "DEI president", referring to diversity, equity and inclusion. This is a way of dismissing anybody who's not white and not a man as not being worthy of the position they've earned.

Trump rose to national prominence prosecuting the same kind of racist campaign against the presidency of Barack Obama.

I think we can expect there to be a push for the Trump campaign not to go down that road any further. But we've seen in the past how Trump completely ignores that kind of conventional wisdom, and just how much that incites his base.

This remains a dangerous and unpredictable era in American politics. There are no rules for what happens next. (*Courtesy: The Quint*)

Despite Gaza war crimes, India's ties with key Israeli military firms continue

n April 5, the United Nations Human Rights Council adopted a resolution urging an arms embargo on Israel and calling on countries to "cease the sale, transfer and diversion of arms, munitions and other military equipment to Israel." India abstained from voting in favour of this resolution.

The resolution came just two weeks after the publication of "Anatomy of a Genocide," a report by Francesca Albanese, the UN Special Rapporteur on Palestine, that gave the world evidentiary details on how Israel has committed genocide in Gaza.

This report reaffirms the January preliminary ruling of the International Court of Justice that found that "some of the acts and omissions" committed by Israel during its attacks on Gaza "appear to be capable of falling within the provisions of the [Genocide] Convention"

But if you turn to India, it would seem that for both the government and the private sector, it's business as usual with Israel and its military companies.

DRDO and Israel Aerospace Industries

Just this March, Israeli stateowned Israel Aerospace Industries (IAI) launched its very own, wholly-owned company called Aerospace Services India (ASI) in New Delhi at the end of March.

Danny Lauber, its Chief Executive, said that ASI is the only authorised original equipment manufacturer for India's Medium-Range Surface-To-Air Missile (MRSAM) system. It will provide components, maintenance, repair and support

The MRSAM system was developed jointly by IAI and the Defence Research and Development Organisation (DRDO), starting in 2017 through a \$1.6 billion contract. At the time, which IAI had said in a press release at the time was Israel's "largest defence contract" in the country's history.

Also this March, Stockholm International Peace Research Institute (SIPRI) that tracks international arms transfers, published its 2023 factsheet that listed India as the top arms importer in the world. Not only that, India was Israel's top recipient for arms exports, receiving 37% of its total exports.

Adani Enterprises Limited, Elbit Systems and SK Group

Meanwhile, the export of more than 20 Hermes 900 drones to Israel by Adani-Elbit Advanced Systems was widely reported in February this year.

Adani Enterprises Limited (AEL) entered into a joint venture (JV) with Israel's Elbit Systems in 2016 through its subsidiary Adani Defence and Aerospace Limited to develop drones. Two years later, Adani-Elbit Systems opened its manufacturing unit in Hyderabad, from where these drones were exported to Israel.

Four years later, AEL, through its subsidiary Ordefence Systems, entered into a JV with another Israeli arms company called Israel Weapons Industries (IWI), through buying majority stake in PLR Systems.

IWI manufactures firearms for the Israeli Defence Forces (IDF) and is a subsidiary of the SK Group, owned by businessman Samy Katsav, once the point person supplying Israeli arms to the Shah of Iran.

"PLR" used to stand for Punj Lloyd Raksha Systems, IWI's initial partner, but was changed to "Precise, Lethal, Reliable" after the Adani acquisition. PLR Systems manufactures small arms such as assault rifles, machine guns and grenade launchers and markets itself as India's "first private sector arms manufacturer."

Bharat Forge, Astra Microwave and Rafael Advanced Defence Systems

The Hermes 900 exports hap-

pened alongside Israel's Rafael Advanced Defence Systems promoting its defence and communications systems at the Aero India

Conference this year in Bangalore. Like IAI, Rafael Systems is also

owned by the state of Israel.
Rafael entered into a JV with
Kalyani Strategic Systems, which
is owned by Bharat Forge, back in
2015. This JV established Kalyani
Rafael Advanced Systems Pvt. Ltd.
(KRAS) and it became India's first
privately-owned missile manufacturing company.

In August last year, the Indian defence ministry gave KRAS a Rs 287 crore or \$34 million contract to produce missile systems.

What's the harm?: Weapons in Gaza

It has been widely reported that Israeli defence companies test their weapons on Palestinians, before selling these to international customers and the Israeli government. The words they use are "battletested" or "combat-proven."

IAI's subsidiary Elta Systems, along with the IDF and Israel's Defence Research & Development Directorate, are testing unmanned D9 bulldozers, called "The Panda", in Gaza, according to Israeli news website Haaretz.

The D9 bulldozers have been "extensively" used against Gaza in the past for "large-scale demolitions," according to Who Profits Research Center that sheds light on the businesses behind Israel's occupation of Palestinian and Syrian lands. But amidst the Gaza war, Israel started "adapting" these bulldozers to become autonomous; this technology was co-developed by IAI's Elta Systems.

One of IAI's most well-known weapons is the Heron TP drone, also known as the killer drone. Two of these, already deployed in Israel but owned by Germany, were loaned by the latter to the former and "instantly put to use against the Palestinians," according to an application submitted by the Republic of Nicaragua to the International Court of Justice against Germany on March 1 of

Nicaragua claims that Germany has contributed to committing genocide in Gaza. The loaned Heron TP drones were cited as one of the weapons used to enable it. The ICJ said on April 30 that it was turning down Nicaragua's request for provisional measures against Germany but reiterated that countries selling arms must be mindful of their obligations under the

Genocide Convention. Alongside this, Elbit's Iron Sting, also called Steel Sting, is a "precision-guided" mortar bomb that can go through concrete walls. It was "presented" at this February's Singapore Air Show. According to the company, it was put through a "pre-operational test" in 2021 during Israel's 11-day attack that it called "Operation Guardian of the Walls" which killed around 256 Palestinians, including 67 children. It is now being tested more widely in the "battlefield" and according to Elbit "customers around the globe are keenly observing [it's] performance.

Investigate is a global database that lists companies that are profiting from and supporting state violence, including against Palestinians. It reported that Elbit has manufactured white phosphorus munitions, as mentioned in its 2012 annual financial report that it submitted to the US Securities and Exchange Commission.

It hasn't mentioned it in subsequent reports. White phosphorus causes severe burns "often down to the skin", according to the Human Rights Watch, which confirmed its use by the Israeli military against civilians in the current war in Gaza. This reporter could not independently verify if the white phosphorus currently being used is manufactured by Elbit Systems.

manufactured by Elbit Systems.
On April 1, seven aid workers from the nonprofit World Central Kitchen (WCK), who were traveling in a convoy of three vehicles in the central Gaza Strip, were killed in a series of three missile strikes. These were most likely Spike missiles, according to Chris Cobb-Smith, a former British army personnel and UN weapons inspector, quoted by the BBC.

Spike missiles are developed by

Rafael. These were launched at the food aid workers from an Elbit Hermes 450 drone.

All in a day's work: Profits, War and Occupation

The American Friends Service Committee (AFSC) is a US-based Quaker nonprofit that has worked in Gaza and runs the Investigate database. It included Israel Aerospace Industries (IAI), Elbit Systems, Rafael Advanced Systems and the SK Group in its list of companies that have been profiting from Israel's attacks on Gaza since the beginning of this war on October 7th last year.

Elbit Systems' revenue for the last quarter of 2023 was \$1.6 billion, a 7% increase from the last quarter of 2022. Notably, Elbit earned 12% more in profits in this period from sale of land systems, including sale of ammunition and munitions to Israel, according to its financial report.

Similarly, IAI reported that 2023 was its "highest grossing year since the company's inception." Its sales in the last quarter of 2023, starting October and ending in December, amounted to \$1.4 billion. The company's CEO Boaz Levy said: "Israel Aerospace Industries' financial report for 2023 well reflects a year of significant and varied activities – one in which the country was at war during the last quarter."

For Rafael Advanced Systems, sales increased by 19% to \$1.2 billion in the last quarter compared to

All three have order backlogs or pending orders worth \$18 billion (IAI), \$17.8 billion (Elbit Systems) and \$14 billion (Rafael). More than 70% of IAI and Elbit Systems' orders were from international customers, while for Rafael, it's more than 50%.

Both Elbit Systems and IAI have been marked for divestment by Investigate.

Divestment means selling off one's investments in a company. In the context of the Gaza war and charges of genocide, it has meant shining a light on businesses that are directly or indirectly involved in the Israeli occupation of Palestine and rights violations against Palestinians.

According to the Investigate database, IAI has been marked because it "supports and maintains illegal settlements" in Occupied Palestine, makes killer drones, surveillance and other weapons systems that cause human rights violations.

Elbit Systems has been marked because its weapons are used in "war crimes" against Palestinians, and its surveillance systems are used along walls and checkpoints in Occupied Palestine.

The representatives of DRDO, Adani Enterprises Limited and Bharat Forge were contacted via email as well as a follow-up call to comment on their Israeli partners profiting from the war on Gaza, amidst calls for ceasefire and

charge of genocide against Israel.
They were specifically asked:
Why do you continue to do business with IAI/Rafael/Elbit Systems, despite the fact that the United Nations just passed a resolution urging for an arms embargo on Israel?

A spokesperson from Bharat Forge, owned by the multinational Kalyani Group, said: "Kalyani Rafael Advanced Systems is a joint venture formed in August 2015 for engagement on India Specific programmes/requirements only.

The entity does not undertake any export-related activity at all. Kalyani Group as a responsible corporate organisation is fully aligned with the policies laid out by the Government of India and in full compliance of various export control policies."

The spokespersons for AEL and DRDO had not responded at the time this article was published.

The Indian representative at the UN Human Rights Council was asked via email the reason that India abstained from voting on an arms embargo against Israel. He also has not yet responded.

Shir Hever is the military embargo coordinator for the Palestinian Boycott, Divest, Sanctions or BDS movement that organises actions to enforce international law on Israel, inspired by the antiapartheid movement in South Africa. He said, in the context of the International Court of Justice ruling, it's "plausible" that Israel is committing genocide against Palestinians: "This is enough to create obligation to third states, such as India, to respect the military embargo. Weapons may not be sold to Israel, bought from Israel or transited to Israel. Whatever atrocities may be committed by the Israeli forces using such weapons, the Indian authorities and defence companies will not be able to argue that they did not know in advance that the risk exists." Bangladesh protests: By backing Sheikh Hasina, India is undermining its own interests

he student-led protests that have swept Bangladesh since Sunday, and met violent reprisal, are the strongest indication yet that India should reconsider its long-standing policy towards its eastern neighbour. India's security-centric approach sees Prime Minister Sheikh Hasina and the ruling Awami League as stabilising allies against threats like a perceived Pakistan-backed dispensation. But this is increasingly at odds with the democratic aspirations of the Bangladeshi people, particularly its youth.

This position, while rooted in legitimate security concerns, risks undermining Bangladesh's potential for genuine political liberty and diversity. It now threatens India's long-term interests on its eastern border by alienating much of Bangladesh's population at a time when Hasina's political future seems increasingly precarious.

New Delhi's myopic approach not only undermines the democratic aspirations of Bangladeshis but also potentially sows the seeds for instability and anti-India sentiment in a strategically vital neighbour, compromising the very security interests India seeks to protect.

India needs to reevaluate not only its security-centric view but also consider if the hawks have overly influenced Indian foreign policy, promoting a security lens that enables the Awami League and bypasses a nuanced view of Bangladesh.

view of Bangladesh.

It is well-known that the conservative Jamaat-e-Islami has never received more than 5% of the vote. It is simplistic to assert that Pakistan can significantly influence Bangladeshi society or its politics through financial means

or the Directorate General of Forces Intelligence, the Bangladeshi intelligence arm.

So also the claim that the Bangladesh National Party, which includes numerous freedom fighters in its ranks solely caters to anti-Indian and pro-Pakistani sentiment. The Bangladesh National Party seeks to establish a uniquely Bangladeshi identity, a mission that is both

overtly promoted and subtly pursued.

Allegations that insurgents in India received support during the rule of the Bangladesh National Party three decades ago have contributed to New Delhi's narrow perspective. However, it is crucial to note that insurgent activities were not exclusive to any single political era: they persisted during the Awami League's regime between 1996 and 2001, partly as a response to India's involvement in the Chittagong Hill Tracts. This complex history calls for a more balanced assessment of Bangladesh's internal dynamics.

Despite the palpable shift in Bangladesh's political land-

scape, which is undoubtedly evident to Indian diplomatic and intelligence circles, the foreign policy hawks in New Delhi have stubbornly clung to a simplistic narrative.

Delhi have stubbornly clung to a simplistic narrative.

This reductionist viewpoint is largely a construction of Hasina's regime – a narrative built on years of disinformation, historical distortion, and manipulative rhetoric that has finally been unequivocally rejected by the youth-led

uprising.

The tenacious adherence to this outdated perspective by India's foreign policy establishment reflects a dangerous disconnect from the ground realities in Bangladesh. Hasina's long-standing strategy of invoking the spirit of the Liberation struggle of 1971 and exaggerating the influence of external forces like Pakistan's Inter Services In-

telligence has lost its potency.

The young protesters' bold appropriation of historically charged terms – evident in slogans like "I am razakar [collaborator], I am razakar, who said that, the autocrat" – signals a seismic shift in Bangladesh's political discourse that

Indian policymakers can ill afford to ignore.

As the student protests intensify in Bangladesh, Hasina's regime faces a crisis of legitimacy. The government's brutal crackdown, including 174 reported student deaths and

security forces, has turned Hasina into a pariah, waging war against her own people. This violence, coupled with financial instability and growing

widespread torture by

stability and growing opposition from the diaspora, signals the beginning of the regime's end game.

The perception that

India is Hasina's primary backer has solidified among
Bangladeshis, particularly young protesters.
Their determination, fu-

eled by the Bangladesh

National Party's failure to mount effective political resistance, has created a movement that refuses to back down. This puts India in a precarious position: continuing to support Hasina means running the risk of cementing a long-lasting hostility among Bangladeshis towards India.

No serious analyst is betting based on a timeline but it is clear that Hasina's government cannot sustain its grip on power indefinitely. If India waits to change sides until Hasina's fall becomes inevitable, it could be too late to salvage its reputation among the Bangladeshis.

Instead, a proactive, nuanced approach is imperative.

Instead, a proactive, nuanced approach is imperative. India must pivot from supporting specific political entities to championing democratic processes and institutions. By aligning with the democratic aspirations of Bangladesh's youth and embracing a comprehensive understanding of the political landscape, India can potentially salvage its relationship with its neighbor.

The window for such recalibration is rapidly closing.

Myanmar violence, South China Sea tensions are top issues as Southeast Asian diplomats meet in Laos

VIENTIANE, July 25: Southeast Asian foreign ministers and top diplomats from key partners including the United States and China were gathering in the Laotian capital on Thursday for the start of three days of talks expected to focus on the increasingly violent civil war in Myanmar, tensions in the South China Sea and other regional issues.

U.S. Secretary of State Antony Blinken and Chinese Foreign Minister Wang Yi are expected to hold one-on-one talks on the sidelines of the meetings of the Association of Southeast Asian Nations in Vientiane, which come as both Beijing and Washington are looking to expand their influence in the

Lao Foreign Minister Saleumxay Kommasith thanked ASEAN members and partners for their "unwavering collective effort" that has led to its past achievements and emphasized the importance of the bloc's continuous work to promote peace and stability.

"In light of the rapid and complex geopolitical and geoeconomic changes, we need to further enhance ASEAN centrality and unity so as to promote the relevance and resilience of ASEAN, aiming at addressing emerging challenges and seizing opportunity in the future," he said in the opening statement.

For the ASEAN nations — Indonesia, Thailand, Singapore, Philippines, Vietnam, Malaysia, Myanmar, Cambodia, Brunei and Laos — the violence in Myanmar is at the top of the agenda as the bloc struggles to implement its "five-point consensus" for

The plan calls for the immediate cessation of violence in Myanmar, a dialogue among all concerned parties, mediation by an ASEAN special envoy, provision of humanitarian aid through ASEAN channels, and a visit to Myanmar by the special envoy to meet all concerned parties. The military leadership in Myanmar has so far ignored the plan and has raised questions about the



bloc's efficiency and credibility to mediate for peace.

Broader talks, including diplomats from elsewhere in the region including Japan, South Korea, India, Australia, are expected to focus on issues including the economy, security, climate and energy.

Regional issues, including Cambodia's decision to build a canal off the Mekong River that Vietnam, which is downstream worries could have ecological and security implications, as well as massive dam building projects in Laos further upstream could also feature in the meetings.

In Myanmar, the army ousted the elected government of Aung San Suu Kyi in February 2021 and suppressed widespread nonviolent protests that sought a return to democratic rule, leading to increasing violence and a humanitarian crisis.

In an effort to put pressure on Myanmar, ASEAN has prohibited it from sending any political representatives to top-level meetings, and it has sent bureaucrats instead. Aung Kyaw Moe, the permanent secretary of Myanmar's Foreign Ministry, was expected to attend this week's meetings, which run through Saturday

More than 5,400 people have been killed in the fighting in Myanmar and the military government has arrested more than 27,000 since the coup, according to the Assistance Association for Political Prisoners. In addi-

placed people in the country, with the numbers growing daily as fighting intensifies between the military and Myanmar's multiple ethnic militias as well as the so-called people's defense forces of military oppo-

As the needs of civilians grow, discussions on humanitarian assistance to Myanmar will also be a focus of the ASEAN talks, Bolbongse Vangphaen, head of the Thai Foreign Ministry's department for ASEAN, told reporters ahead of the meetings.

Thailand, which shares a long border with Myanmar, has already been heavily involved in providing humanitarian assistance, and Bolbongse said the country is ready to support the next phase of delivery being planned by the ASEAN Coordinating Center for Humanitarian Assistance on Disaster

He did not say when or where the aid delivery would be. Thailand initiated its first delivery of aid to Myanmar in March from the northern province of Tak. It was said to be distributed in Kayin state to approximately 20,000 out of millions of people displaced by fighting.

Landlocked Laos is the bloc's poorest nation and one of its smallest, and many have expressed skepticism about how much it can accomplish while the crises mount. But it is also the first ASEAN chair that shares a border with Myanmar. Laos has already sent a special envoy to Myanmar for meetings with the head of the ruling military council and other top officials in an attempt to make progress on the peace plan.

ASEAN also has introduced a mechanism of trilateral informal consultation among its current, past, and future chairs, specifically for ensuring continuity in its response to the situation in Myanmar. The troika met for the first time on Wednesday, attended by Laos, Indonesia and Malaysia. (AP)

US disappointed about symbolism and timing of PM Modi's Moscow trip, says senior official

WASHINGTON, July 25: The US is disappointed about the symbolism and timing of Prime Minister Narendra Modi's Russia visit when President Joe Biden hosted the NATO summit here, a senior State Department official has told lawmakers concerned over the growing India-Russia ties.

Prime Minister Modi paid an official visit to Russia on July 8-9 at the invitation of Russian President Vladimir Putin for the 22nd India - Russia Annual Summit. This was Modi's first trip to Russia since the start of the Ukraine conflict.

India has not yet condemned Russia's invasion of Ukraine in 2022 and has consistently pitched for a resolution of the conflict through dialogue and diplomacy. "I could not agree with you more

HONG KONG, July 25: A defence lawyer said Thursday that prominent publisher Jimmy Lai will testify in his defence in the landmark national security trial brought under a Beijing-imposed law that has all but wiped out public dissent.

Lai, the 76-year-old founder of the now-defunct Apple Daily newspaper, was arrested in 2020 during a crackseditious publications. If convicted, he faces up to life in prison.

On Wednesday, Lai's lawyer Robert Pang argued his client had no case to answer because the prosecutors' evidence was insufficient. Pang said the prosecution had failed to prove Lai's intent after the introduction of the 2020 law and stressed the importance of freedom of speech. But judges Esther Toh, Susana D'Almada Remedios and Alex Lee ruled against him on Thursday.

"Having considered all the submission, we ruled that the first defendant has a case to answer on all charges," Toh said, without elaborating. Pang later said in court that Lai would testify in his depress freedom and a test for judicial independence in the Asian financial hub.

When Britain handed back Hong Kong to China in 1997, the city was promised to have its Western-style civil liberties kept intact for 50 years. However, the freedoms that once set Hong Kong apart from mainland China, including freedoms of press and assembly. have drastically shrunk since the enactment of the 2020 security law.

Beijing and Hong Kong governments insist that the law brought back stability to the city following the social unrest.

The prosecutors have alleged that Lai had engaged in requesting foreign countries, especially the United States, to

former U.S. Vice President Mike Pence, former U.S. Secretary of State Mike Pompeo and other senior senators in the United States in July 2019 to discuss a now-withdrawn extradition bill that sparked the massive anti-government protests that year. They alleged Lai had sought support from the U.S. on sanctioning Beijing and Hong Kong's leaders who allegedly cracked down the movement. In 2022, six former Apple Daily executives entered guilty pleas and admitted to the court they conspired with Lai to call for sanctions or other hostile activities against Hong Kong or China. They were convicted and await sentencing behind bars.(AP)

COLOMBO, July 25: Field Marshal Sarath Fonseka, Sri Lanka's former Army chief and the architect of the military offensive that led to the annihilation of the LTTE, on Thursday formally declared his candidacy for the upcoming Presidential election with a vow to crush corruption and boost the economy.

Fonseka, who defeated the LTTE's separatist campaign to create a Tamil state, was the opposition's main challenger in the 2010 presidential election against the incumbent Mahinda Rajapaksa. Taiwan sees flooding and landslides from Typhoon Gaemi, which caused 22 deaths in the Philippines

TAIPEI, July 25: Taiwan has seen flooding in lowlying areas, along with landslides and damage to homes and shops after Typhoon Gaemi made landfall on the island.

The storm swept up the western Pacific, leaving 22 people dead in the Philippines from flooding and landslides, and three in Taiwan, with more than 220 reported injured.

Offices and schools in Taiwan were closed for the second consecutive day on Thursday and people were urged to stay home and away from the coastline.

The island is regularly hit by typhoons and has boosted its warning systems, but its typography, high population density and high-tech economy make it difficult to avoid losses when such

unusually quiet, with light rain falling and occasionally gusting winds. In the Philippines, the death toll rose due to drownings and landslides. At least three people are missing, according to police.

The Philippine coast guard reported that an oil tanker, MT Terra Nova, loaded with about 1.4 million liters (370,000 gallons) of industrial fuel oil sank off Limay town in Bataan province early Thursday and rescuers saved 15 of 16 crew

It's not immediately clear if the sinking was related to the bad weather and rough seas but Transport Secretary Jaime Bautista said coast guard personnel could not immediately reach the area to contain a possible oil spill because of the rough sea conditions.The prompted the cancellation of air force drills off Taiwan's

east coast. Gaemi, called Carina in the Philippines, did not make landfall in that archipelago but enhanced its seasonal monsoon rains. Philippine President Ferdinand Marcos Jr. has ordered authorities to speed up efforts to deliver food and other aid to isolated rural villages. "People there may not have eaten for days," Marcos said in a televised emergency meeting.

In the densely populated region around the Philippine capital, government work and school classes were suspended after rains flooded many areas.

The storm's effects were expected to continue into Friday as it moved in a northwestern direction toward mainland China. In Fujian province on China's east coast, ferry routes were suspended on Wednesday and all train service will be halted on Thursday, China's official Xinhua Agency said. (AP)

He said, "Peace has gradually returned to the state and we must collectively strive to maintain it. All our demands, including the identification of illegal immigrants and the implementation of the NRC, should strictly adhere to constitutional and legal frameworks. We must denounce acts of violence and work actively to prevent them.'

Singh also responded to allegations by the Congress that no aid was mentioned for Manipur in the Union Budget.

Without directly naming the grand old party, Singh said, "The central government has consistently supported relief efforts since the beginning, regardless of whether the state was mentioned in Parliament or not. Let us

refrain from indulging in petty politics. The Centre has provided assistance for constructing prefabricated homes and daily food provisions. A total of ₹ 145 crore has been allocated for managing relief camps.

He added, "₹ 3 crore was spent on distributing television sets in relief camps, and ₹23 crore was distributed in ₹ 1,000 installments to each person residing in relief camps, on at least four occasions. Additionally, ₹44 crore was utilised for children's nutrition and personal hygiene, while ₹ 19 crore was allocated as compensatory packages for agricultural and related activities." Singh added, "₹25,000 has been disbursed as the first installment to 6,000 families under the special assistance package for violence-affected families, with each family set to receive ₹ 1 lakh.'

He addressed criticisms, stating, "Those engaging in petty politics have misrepresented the government's efforts for relief camp residents."

Singh continued, "Even amidst the disastrous hailstorms and floods in recent months, ₹ 80 crore was allocated for flood relief, and ₹45 crore was spent on distributing GI sheets to 42,000 peo-

Removal of indexation benefit will lead to huge inflow of black money in real estate: Raghav Chadha

NEW DELHI, July 25: The government's decision to remove indexation benefit on sale of old property will result in huge inflow of black money in real estate and investments in the sector will go down, AAP Rajya Sabha member Raghay Chadha said on Thursday.

Asking the government to roll back the proposal, Chadha, while taking part in the discussion on the Union Budget 2024-25, said people will never be able to buy their "dream homes"

"Restore indexation on long-term capital gains. Throughout the world, to woo investors to invest they are incentivised. In this country, by removing indexation we are disincentivising the investor class," he said, adding that removing indexation is not imposing tax but it is equivalent to "penalising in-

He said as a result of the step proposed by Finance Minister Nirmala Sitharaman in the Budget 2024-25, individuals selling old properties will incur higher tax outgo.

"If you do not bring back indexation three things will happen in this country. First, investment in real estate will go down and people will never be able to buy their 'dream homes'," Chadha asserted.

He further said there will be undervaluation of property deals, people will buy properties at 'circle rates' and will never disclose the real value of the property.

'Third, there will be a huge inflow of black money if you don't roll back this decision to withdraw indexation," he said.

In the Union Budget 2024-25, the government proposed reducing the long-term capital gains tax on immovable properties to 12.5 per cent from 20 per cent, but removed the indexation benefits to adjust for in-

As per the Memorandum to the Union Budget, with rationalisation of rate to 12.5 per cent, indexation available under Section 48 of the Income Tax Act has been proposed to be removed for calculation of any long-term capital gains, which is presently available for property, gold and other unlisted assets.

Chadha also highlighted the high tax burden faced by common people and asked for a comprehensive review of both direct and indirect "We impose taxes like the Euro-

NEW DELHI, July 25: The National Testing Agency (NTA) released the final answer keys of the Common University Entrance Test (CUET)-UG on Thursday, paving way for the declaration of the delayed results for the undergraduate admission exam.

The NTA had on July 7 released the provisional answer keys of the CUET-UG 2024. A retest for over 1,000 candidates whose grievances were found genuine by the agency was conducted on July 19.

'The final answer key has been released and the result will be declared soon," a senior official of the agency said.

The delay in the CUET-UG results comes amid a row over alleged irregularities in competitive exams, including in NEET-UG and UGC-NET.

Originally, the CUET results were scheduled to be released on June 30 but the NTA delayed it, grappling with paper leak al-

Heavy rains batter Pune, 4 dead; Army team in Sinhagad Road, says Dy CM Pawar

PUNE, July 25: Heavy rains wreaked havoc in Maharashtra's Pune, where at least four persons died in rain-related incidents on Thursday, while several houses and residential societies in low-lying areas in the city were inundated, following which people are being evacuated, officials said.

During his tour of the district, Deputy Chief Minister Ajit Pawar said as a precautionary measure, Army teams have been deployed at Ekta Nagar in Sinhagad Road, while NDRF personnel are also in the area.

He also said rescue operations are underway at the site of a landslide in Lavasa in which some bungalows have been affected and three persons are feared trapped.

The India Meteorological Department (IMD) issued a 'red alert' for Pune district and asked people to take precautions. Schools and colleges in most parts of the district have declared a holiday in view of the heavy rainfall warning, officials said. Pune city and other parts of the district, including Velha, Mulshi, Bhor talukas and the catchments areas of several

dams, including Khadakwasla, have been witnessing incessant rains since Wednesday night.

In the city, housing societies in the low-lying areas, such as Sinhagad Road, Bavdhan, Baner and Deccan Gymkhana, witnessed flooding and inundation and efforts have been launched by the fire brigade and disaster management cell of the Pune Municipal Corporation (PMC) to evacuate the stranded people, the officials said.

"Currently there is no flooding in Sinhagad Road and all those who needed to be shifted to safety have been moved. Arrangements have been made for meals, clothes and other relief materials for those who have been evacuated," Pawar said. Oueried about residents of Sinhagad Road complaining about not being informed about water being released from Khadakwasla Dam, he said the process started early Thursday morning. The water release and heavy rains aggravated the situation but deployment of relief mechanisms was done in advance and people were taken to

safety, Pawar asserted. Pune district collector Suhas Diwase said that in the wake of heavy rains in the Khadakwasla dam's catchment area, water has been released from the reservoir. "As the catchment areas of Khadakwasla dam has been witnessing incessant rains, water is being released at over 35,000 cusec and it will further increase to 45,000 cusec. Due to the water discharge, several low

flooding," he said. Later in the afternoon, Pawar said water from Khadakwasla reservoir was being released at 35000 cusecs but now it has been reduced to 15000 cusecs.

"I have told officials from the irrigation department that if they want to release the water from Khadakwasla, they can do it before it gets dark. If the water release is increased after it gets dark, those living in the low lying areas along the Mutha river may have to suffer hardships.," he said. "If we can empty the reser-

voir to some extent and if there are rains during the night, the reservoir will have capacity to store the water. The capacity of the Khadakwasla reservoir is

around 3 TMC. Instructions have also been given to release water through the canals at different dams in Pune district,' said Pawar.

Mulshi Dam is almost filling up and officials have been asked to use the water for power generation, the Deputy CM said.

Coordination is underway with the district administration of Kolhapur, Sangli and Satara to monitor the rain situation. while NDRF and SDRF teams are at critical spots as a precautionary measure, Pawar asserted. Four persons lost their lives in rain-related incidents in Pune, officials said.

While three men died of electrocution in Deccan area of the city while trying to move their handcart, on which they used to sell egg dishes, after it got submerged due to heavy rains, one person died and another one sustained injuries in a landslide in Tahmini ghat section in Mulshi tehsil, district officials said.

18 years on, Railways all set to replace iron

NEW DELHI, July 25: If things go according to plan, loco pilots and guards will no longer have to carry their personal belongings and official equipment in iron trunks and can use trolley bags instead.

In a letter to all its zones, the Railway Board asked them to provide trolley bags to the loco pilots and guards.

"Zonal Railways are requested to start implementing the policy decision of providing trolley bags to loco pilots and guards," the Railway Board said in the letter dated July 19.

According to railway officials, the Board had initiated this move in 2006 with a comprehensive instruction. A year later, it issued another guideline after discussions with trade unions for its implementation on a trial basis.

However, it remained pending for implementation for another 11 years due to stiff opposition from loco pilots and guards. In 2018, the Board once again took a decision to push the scheme in two zones -Northern Railways and South Central Railways - for trial.

After positive feedback from e various trials the Board is sued a final order on February 21, 2022 in which it said, "Trolley bags may be provided to loco pilots and guards in lieu Railways may decide to procure & distribute or give allowance in lieu of trolley bags purchased by the crew themselves. The allowance to be limited to ₹ 5000 for every 3 years." The order, besides directing departments concerned to standardise equipment in trolley bags, also asked to provide soft copies of railway rules and manuals to reduce the weight of the trolley bag.

But the All India Guards Council and other stakeholders concerned challenged this order at various legal fora, including Central Administrative Tribunal's (CAT) Principal Bench at New Delhi, forcing

"Whenever a loco pilot (train driver) or a guard (officially called train manager) signs on for train duty, he keeps an iron trunk weighing over 20 kg to the engine/guard cabin as it carries railway norms, various equipment as well as his personal belongings," a railway official said. "To carry the heavy iron trunk, they are provided with a porter who takes the box to their respective cab-

ins," the official added. The Railway Board emphasised before the CAT several benefits of doing away with the services of porters. For instance, it said that besides monetary savings due to termination of Box Boy contracts; it would also save detention time of trains on account of loading/unloading of heavy boxes to and from the engine or guard's coach.

On the other hand, the guards' union argued that the order was arbitrary and that the Railways was imposing duties of box porters/box boys on

The other crucial concern of the guards union was that they had to carry detonators comof notassium chlor sulphur, sand, binder and neutralizer issued by Ordnance Factory Board to Indian Railways for specific purposes durargued that often they have to leave their cabin and come out of it during train operation at many isolated locations.

"In such a situation, these detonators are safe in the iron trunk which is locked and difficult to carry. However, it is easy to take away the carry bags with detonators from the Guard's cabin," said SP Singh, former general secretary of All India Guards Council.

Finally, on February 8, the CAT refused to grant any relief to the guards' body and said it would not interfere with the railway ministry's order paying the way for the Board to implement its decision. (PTI)

Gabbi made her debut with a


small role in Imtiaz Ali-directed "Jab We Met" in 2007.

PARIS, July 25: Coach Montse Tomé proclaimed that Spain's women's soccer team has "insatiable ambition" heading into the Olympics. That mentality has served the squad well. La Roja is seeking to become the first team to win a gold medal in France after lifting a Women's World Cup trophy.

'We have a group of players who love what they do. We take them to work, work and work," Tomé said. "And in that work, their enjoyment comes out and their talent shines and they can be competitive, because we have footballers who have an insatiable ambition and mentality."

Loaded with talent, including reigning Ballon d'Or winner Aimer winner Alexia Putellas, Spain won the World Cup despite turmoil surrounding the

Before the tournament even started in Australia and New Zealand, more than a dozen players stepped away from the national team, citing poor treatment of the squad. Then-coach Jorge Vilda was peppered with questions about the mutiny throughout the event.

After the 1-0 victory over England for the title, Spanish federation president Luis Rubiales forcibly kissed forward Jenni Hermoso during the trophy cer-

The kiss touched off a

signing in disgrace. Vilda was dismissed and replaced with Tomé, a former national team player. Now settled, Spain qualified for the team's first Olympics by winning the UEFA Nations League. La Roja opens the tournament Thursday against Japan in Nantes. Group C also includes Brazil and Nigeria, which meet in Bordeaux.

Brazilian legend Marta says she's playing in her final major tournament with the national team. The six-time world player of the year, appearing in her sixth Olympics, has never won a World Cup trophy or a gold medal.

withdraw from coaching the match on Thursday. In the spirit of accountability, I do this with the interests of both teams in mind and to ensure everyone feels that the sportsmanship of this game is upheld."

In Group B, the United States seeks to move on from its disappointing finish at the World Cup. The Americans open against Zambia on Thursday against Nice, while Germany plays Australia in the group's other game in Marseille.

The Australians are without one of the sport's biggest stars, Sam Kerr, who injured her ACL in January. She's one of several high-profile players missing out on the tournament. (AP)

Sindhu is underdog but opponents wary of her credentials: Parupalli Kashyap



NEW DELHI, July 25: Former India shuttler Parupalli Kashyap on Thursday dubbed two-time medallist PV Sindhu an "underdog" at the Paris Olympics but said her name still carries a lot of weight and opponents would be wary of her bigmatch credentials.

Eyeing an unprecedented third straight Olympic medal, Sindhu has not been at her best since returning from a knee injury in February.

"It's her third Olympics, she won two medals in the last two Olympics and several world championship medals. So I think she feels she has an edge already even though her ranking doesn't say it or her recent form doesn't say it," Kashyap, an Olympics expert at JioCinema & Sports18, told reporters during an interaction. "In major events, I think the opponents also are a little wary of her even though she's not in form. I think she's going as a dark horse and underdog considering the last two years of

women's singles. Since the 2021 Tokyo Olympics, Sindhu won the Singapore Open Super 500 title and Commonwealth Games gold in 2022, but a left ankle injury she suffered in Birmingham took six months to heal.

When she returned to action, she struggled to find her rhythm and endured as many as seven first-round exits. Sindhu did reach the finals of the 2023 Spain Masters but, after a few months, she suffered a knee injury in October last year.

She came back in February this year but satisfactory results were tough to come by, with the ish at Malaysia Masters and a

couple of quarterfinals.

"There are clear four athletes in the women's singles who are out-and-out favourites to make it to the medal rounds but I'm sure they are wary and a little tense about facing Sindhu because she's a big-match player and her game style is also very suited to major events," Kashyap said.

"She's an out-and-out attacking player and backs herself with a fitness level as well," added the 2014 Commonwealth Game champion.

A lot is riding on Satwiksairaj Rankireddy and Chirag Shetty to win India's first-ever badminton gold, and Kashyap termed them one of the favourites for the title. "I think they are a title con-

tender. And I think the wins in Asian Games, Asian Championships, medals in World Championships, they are one of the title contenders," he said.

"I think Satwik-Chirag, the Chinese pair, and the Korean pair. These three are the favourites to win the gold." Talking about their opponents,

Kashyap said: "Their tough competitors will be the Chinese pair against whom they lost during the Thomas Cup. In the last two encounters, I think the Chinese pair won against Chirag and Satwik. So they are the immediate threat.

"They had a couple of tough matches against the Koreans who won the World Championships but I think they scored a win against them in another tournament.

"So I think the Chinese pair and the Korean pair, these two are the ones who are going to be tough for Chirag and Satvik, but highlight being a runner-up fin- I think they would be feeling the same about them." (PTI)

The team will begin its campaign on July 27 against New Zealand, followed by matches against Argentina (July 29), Ireland (July 30), Belgium (August 1) and Australia (August 2).

"Senior players in our team, Shree Bhai (PR Sreejesh), Manpreet, Harmanpreet have a lot of experience. They tell us about their experiences and motivate us to perform well. If we have any problem, we talk to them.'

Indians eye double-digit medal haul as Paris Olympics set for grand start

PARIS, July 25: Some would be carrying a huge burden of expectations, some others would look to spring a surprise and a few more would be eveing the perfect closure to their glittering careers as the 117-strong Indian contingent aims for a better-than-before performance in the Olympic Games, starting here on Friday.

India returned from Tokyo with seven medals, and it is only natural that a doubledigit performance is now desired in Paris.

Except for wrestlers, who have waded through a highly controversial build-up, athletes in all disciplines have have had no complaints about their preparations.

Whether it was training abroad or getting the best of facilities to sharpen their skills, there was planning in place.

But will the hard work, the strategies and the unbridled support translate into medals? It will be a Heculean task to match the Tokyo figures of seven medals, given that except for reigning Olympic champion Neeraj Chopra, not many are top contenders in their respective disciplines.

More than half of the 117-member contingent is from three sports -- athletics (29), shooting (21) and hockey (19). Of these 69 athletes, 40 are debutants.

In other sports too, there are debutants like tennis player N Sriram Balaji and wrestler Reetika Hooda. They are not exactly inexperienced, but largely, India's campaign will be driven by the athletes, who will be competing on a stage this grand for the first time. Then there are the seasoned ones who would be expected to raise their game suitably.

Two-time medallist shuttler PV Sindhu, tennis player Rohan Bopanna, legendary table tennis player Sharath Kamal and hockey goalkeeper PR Sreejesh are certainly playing their last Olympics.

The hockey team has endured patchy form in the build-up to the Games, the boxers and wrestlers are lacking in real competition time. The shooters too have notched up mixed results heading into the Olympics.

The track and field athletes, especially Avinash Sable, have done well of late, but compared to their global rivals, their per-



formances don't seem enough to put them in the bracket of medal hopefuls

For instance, steeplechaser Sable has been consistently bettering his own national record. His best stands at 8:09.94 but there are seven international runners who have achieved better timing than that in the run-

Given this, Even making the finals will be considered a huge achievement.

India's hopes for podium finishes largely hinge on Neeraj, despite concerns around his adductor niggle, and the in-form badminton duo of Chirag Shetty and Satwiksairaj Rankireddy.

The coveted 90m mark has eluded Neeraj from Tokyo to Paris but the ace javelin thrower seems to be doing just enough, and most importantly, consistently, to land

On big competition days, Neeraj has fared better than his other fancied rivals and if he is fit, the javelin thrower from Panipat will have a chance to become only the third athlete in India's sports history to win back-toback Olympic medals.

Only Sindhu (2016 Rio and 2012 Tokyo) and wrestler Sushil Kumar (2008 Beijing, 2012 London) have managed to win two consecutive medals.

Rankireddy and Chirag have grown into

bles teams and they are being seen as certain medal winners.

Talking about Sindhu, she is not in the best of form and has also got a tough draw but if she can come through the initial rounds, the vast experience could help her make the medal round.

HOCKEY: The men's hockey team has been inconsistent. It lost all five games in Australia recently after a mixed run in the Pro League. It was a far cry from the Asian Games in Hangzhou where the team emerged champion.

And if that's not enough, the Indian team has been clubbed with heavyweights Australia, Belgium, Argentina, New Zealand and Ireland. There is no room for error if the team has to make the top-four from this

SHOOTING: It's been a quiet build-up for the 21-member shooting contingent, the biggest ever, compared to London and Tokyo where stars such as Manu Bhaker and Saurabh Chaudhary had raised medal hopes with their exceptional performances in the run-up to the Games.

Even Divyansh Panwar and Elavenil Valarivan were hailed as future superstars but all of them have flattered to deceive.

There is hardly any spotlight on shooters but still Sift Kaur Samra (50m three position), Sandeep Singh (10m air rifle) and Aishwary Pratap Singh Tomar (men's 50 m rifle) have it in them to end the 12-year wait

Gagan Narang, who is now India's Chef de Mission, was the last Indian shooter to climb the podium when he won the 10m air rifle bronze in the 2012 London Games.

WRESTLING: The sport has delivered a medal for India in the last four editions. The hopes of winning four to five medals were raised for the Paris Games but the protest against the Wrestling Federation of India brought the sport to a standstill.

There was no national camp, and no competition for a long time. The qualified wrestlers have trained on their own at the centres of their choice -- both in India and abroad.

Fitness status of many is not known, but going into the Games, Anshu Malik, Antim Panghal and Aman Sehrawat are considered India's best bets. Reetika Hooda, the U-23 world champion, will be a dark dorse.

OTHERS: The archers and TT players have qualified for the Games on the basis of their rankings. While it is a huge achievement for TT players, the same can't be said about the archers.

They have promised a lot in the past too but have not been able to deliver. The recent episode of their coach being denied the Games accreditation means the campaign has started on a negative note.

Weightlifter Mirabai Chanu, the Tokyo Games silver-medallist, has struggled with injury and form of late and is perhaps not in the best frame of mind. There are question marks if she will be able to repeat her suc-

Experienced boxer Nikhat Zareen and Nishant Dev will be watched keenly as their latest results have been encouraging. So far, India have won 35 medals at the Olympics with shooter Abhinav Bindra (2008) and Neeraj Chopra (2021) being the only two individual gold medal winners.

It's time to turn aspirations into achievements. Let the Games begin. (PTI)

Gambhir's 1st headache: Pant or Samson for the **T20I series**



COLOMBO, July 25: New India head coach Gautam Gambhir will have the onerous task of choosing between Rishabh Pant and Sanju Samson during the three-match T20I series against Sri Lanka starting from Saturday.

While most of the key stars of the T20 World Cup winning side sans the retiring duo of Rohit Sharma and Virat Kohli are in the Island nation, the choice between two flamboyant wicketkeeper batters Pant and Samson won't be an easy one.

Worse, even with two slots vacant, one can't fit in both the hardhitting batters. Pant with 171 runs was the third highest run-getter for India in the T20 World Cup in the Americas but Samson, though was part of the team, didn't get into

A bilateral series against Sri Lanka, of late, has become a lowstakes affair with the two countries often engaged in inconsequential series, some of which India plays to help other international cricket boards stay afloat.

One such series was supposed to be the upcoming one against Sri Lanka but it has assumed greater significance after Gambhir took over as the coach and Hardik Pandya, a sure-shot candidate for captaincy was surpassed by Suryakumar Yadav.

In this backdrop, the presence of Gambhir, a fiercely opinionated former India opener and a successful franchise-level mentor, will certainly have a broader say in the team composition, something that will be built over two years in the run-up to the next T20 World Cup.

The choice of a keeper-batter in T20Is hasn't exactly been a straight forward one for India, especially during the time Pant was an 18-year-old even before he out of action due to a horrific car accident in December, 2022.

Ishan Kishan was around for some time before he fell out of favour after leaving the tour of South Africa midway. Samson has featured in some games, so has Jitesh Sharma and Dhruv Jurel in the interim. Samson, one of Pant's contemporaries, has so far played 28 T20I games with a couple of stack up the numbers and keep fifties and strike rate of 133 plus. Samson at bay. (PTI)

But it will be fair to say that 27 of those matches have come in the period between 2020 to present, having made his debut back in 2015. So in three and half years, 27 matches sporadically isn't a lot of games to build on confidence.

While average is a slightly less important aspect in the shortest format, the Kerala star would himself admit that 21.14 doesn't do justice to his immense potential. On the other hand, Pant from his 74 T20I games has three fifties and a strike-rate of a shade below 127. Samson's average is thus pretty similar to the Delhi Capitals skipper, who scored at 22.70 per game. In terms of sheer numbers there is not much to choose between the two. Both are audacious stroke-makers, Pant's falling pull shots are fascinating while Samson on his day can hit the fastest of bowlers over extra cover for maximums.

It will also purely depend on what the new team management feels. When it came to Rohit Sharma, he has blind faith in Pant's capabilities and Samson despite being in the squad wasn't even up for discussion during the T20 World Cup.

However, in the next tour following the T20 World Cup when most first XI boys were rested, Samson played the last three games in Zimbabwe and was also appointed vice-captain to Shub-

In terms of keeping, Pant is a far better keeper to spinners like Ravi Bishnoi but in T20Is, keeping skills aren't that important as there are very few balls that would pose trouble for the glovesmen.

Gambhir was Pant's first firstclass captain and has seen him as played for the India U-19s. But he has also been a big advocate of Samson's T20 prowess and vocal about his inclusion during his days as a TV pundit.

It will be a very tough choice and even if Pant is picked for the series, he knows that he would have to not only score quick but also play a few big innings to

PARIS, July 25: From spending time in a hypoxic chamber to sparring with a variety of partners to adapt to different styles, Indian badminton ace PV Sindhu has left no stones unturned to be battleready for the Paris Games, where she will be chasing an unprecedented third consecutive Olympic

Sindhu's form has been patchy of late but she says the hat-trick of medals is very much possible because the last eight months spent with mentor Prakash Padukone has instilled confidence in her.

No Indian player has won three Olympic medals on the trot and a podium finish will make Sindhu arguably India's greatest athlete.

"I am aiming for a medal, definitely, yes. Whether it's one or two or three, it doesn't matter. I've won two medals and I don't want to take pressure by thinking that, oh, what is the third one," she said after a training session at Porte de la Chapelle Arena here.

"Every time I play Olympics, it's a new Olympics for me. So every time I go out there, I want to get a medal and hopefully, I will do that hat trick soon.

Sindhu had won silver and bronze in the last two Olympics at Rio de Janeiro and Tokyo respec-

Before coming to Paris, Sindhu

trained at Sportcampus Saar in Saarbrucken, Germany where the altitude, the weather, and the conditions are similar to the French capital.

There she created a hypoxic chamber (low oxygen) in her room and slept for a couple of days. Hypoxic chambers help prepare an athlete's body to function at higher-altitude places.

"I couldn't go to the high altitude training center. I didn't have much time and obviously, there I couldn't have been playing. So I just thought, it would be good for me instead of going somewhere, getting it here and doing some changes and sleeping that way," she explained.

So, if the conditions demand the maximum from an athlete, with such training they feel ready to negotiate the challenge.

Sindhu said she has improved her strokes and is more consistent during the long rallies.

"Being much more confident in strokes," she replied when asked what difference she finds after training with Padukone.

"In women's singles now, there are a lot of long rallies and long matches, being consistent. I am confident in that now," she said.

"With every opponent, it's a different style and, you need to play the right stroke at the right time. And that's what Prakash sir also keeps saying. We've been working on that. And that's almost there. There's a lot of improvement. You will see that on court.'

The 29-year-old also shared her training regime in Germany, where she sparred with all kinds of players and sometimes competed against two players at the same

"Saarbrücken training was really good. I was there for almost a couple of weeks and I got my own sparring partners as well. I got an opportunity to train with different people. One was like a left-hander and one was an attacking player, a rally player.

"And I had a Nigerian guy, who also was sparring with me. And one was a German singles player who was also playing with me for a couple of days.

Sindhu was an underdog in the 2016 Olympics, while she competed at Tokyo Games as an experienced player.

Talking about her journey, Sindhu said: "I've experienced two different kinds of Olympics where, in one, a lot of people shouted and cheered, but there was no pressure. In the second one, there were a lot of responsibilities and pressure, everybody wanted you to get a medal, but there was

Indian athletes' confidence has reached new high: Gagan Narang

The London Games bronze medallist, who is serving as India's Chefde-Mission at the Paris Olympics, felt the Indian athletes are now not intimidated by their counterparts from other countries. "There is a huge change in the motivation and the level of thinking

our athletes have today. We used to feel scared, under-confident because other countries were better. But slowly that's changed, the mindset (has) changed," Narang told reporters here. "People started watching sports, playing it, then we had great performances. The confidence is at a new high. Today's athletes don't go just to

participate, they go to perform. "Someone in the top 8 or 5 wants to win a medal today and not just any medal but a gold. That's the difference in thinking of the athletes today. "They don't think anyone is above them. They rate competitors at par and that's a very positive sign for Indian sport," Narang added.

The 41-year-old said there has been an "unprecedented coordination" between the Sports Ministry, Indian Olympic Association (IOA) and the national federations.

"The support we have got from the government (this time) we never got before. The support has increased in the past few years, TOPS' players have increased, they have got all the facilities they wanted. "There is unprecedented coordination between the Ministry and SAI,

IOA NSFs. Hopefully, the athletes will be motivated and this will translate into medals," he added. (PTI)

Threat of missile attacks, fear for families' safety: How Ukrainians trained for Paris Olympics

PARIS, July 25: The fear of death has been a constant in an average Ukrainian's life ever since the war with Russia broke out in 2022 and that includes the majority of the country's 143-strong athlete contingent here for the Olympics beginning on Friday.

Even in normal circumstances, the pressure to perform on the biggest sporting stage can take a toll on the best in the business.

In the case of Ukrainian athletes, it's hard to imagine how they were able to train for the mega-event with missile attacks and air sirens becoming a part of their lives for the past 29 months. Electricity almost became non-

existent with power grids destroyed by the conflict. In the eyes of Ukraine president Volodymyr Zelenskyy, the athletes who are in Paris are already "he-

roes" and that is what he told them

in a virtual address on Wednesday. Teenaged diving sensation Oleksiy Sereda and slalom canoeist Viktoriia Us were part of the call with president Zelenskyy. Speaking to PTI outside the Athletes' Village, both Sereda and Viktoriia narrated their struggles for survival besides explaining how they trained for the ultimate sporting test. "We had lots of troubles for

preparation for this Olympics because there are always air alerts back home (for an impending missile strike), you have to go to a safe place and hide. "That is why all our preparation in Ukraine was super hard. But we are here and (will) try our best to

get some medals," said Sereda, who became the youngest European Diving Champion at 13 years of age back in 2019, breaking Tom Daley's record in the continental competition. Sereda is from Mykolaiv in the

south of Ukraine but trained in Kyiv for the Olympics. The constant sounds of air sirens made it almost impossible for him to focus on his craft but he somehow pulled through to make a second straight experience at the Summer Games. The now 18-year-old finished an impressive sixth on his Olympic debut in Tokyo 2020. He has already won as many as four medals in the World Champi-



onships.
