CM briefs PM on devastating flood situation in state

GUWAHATI, July 22: Chief Minister Himanta Biswa Sarma on Monday apprised the Prime Minister Narendra Modi of the flood situation in Assam. The Prime Minister was informed after Sarma met him in New Delhi.

"Had the absolute privilege of seeking the blessings and guidance of Hon'ble Prime Minister Shri @narendramodi ji today. I briefed him on the flood situation in Assam", Sarma wrote on micro-blogging site X. Sarma further inform the Prime Minister about the efforts underway to "mitigate the various challenges faced by our people".

It is worth mentioning that Assam's flood situation further improved as the number of affected people came down to 95,000 in 11 districts of the state. As per an official flood report, the death toll in this year's deluge stood at 98, while the total number of lives lost (CONTD. ON PAGE-2)

APSC's ADO scam **Rakesh Paul, 31 others convicted** 11 acquitted, 1 turns approver • Quantum of sentence yet to be pronounced

GUWAHATI, July 22: A special court on Monday convicted former Assam Public Service Commission (APSC) chairman Rakesh Kumar Paul and 31 others in connection with a cash-for-jobs case related to the appointment of agricultural development officers (ADO) in the state.

Special Judge Dipankar Thakuria acquitted 11 others in connection with the case filed with Bhangagarh police station here in 2017 for lack of evidence, while an APSC member Binita Rynjha turned an approver.

There were altogether 44 accused in the case, including four members and an employee of the commission, three middlemen and 36 candidates

Paul, along with two other mem-

bers of the commission, Basanta Kumar Doley and Samedur Rehman, and other officials were convicted in the case for tampering marks of candidates who had appeared in the ADO recruitment examination. The judge acquitted an APSC employee, three middlemen and seven candidates.

The judge observed that the quantum of sentences to the accused persons/convicts will be pronounced after hearing all the accused persons/convicts.

He ordered that the convicted persons should be taken into judicial custody. The 32 convicted people have since been sent to Guwahati Central Jail.

The judge also mentioned the seven candidates who have been 'acquitted of the charges were also

terations in candidates' marks, both increases and decreases, during the assessment process. He criticised the Assam Public Service Commission (APSC),

under Rakesh Kumar Paul's leadership, for disregarding the Assam Agriculture Service Rules, 1980.

The commission, according to the judge, arbitrarily awarded marks for additional qualifications and experience, rather than following prescribed guidelines.

Furthermore, the judge pointed out violations of APSC Rules 2010, particularly Rule 19, which compromised the selection process and favoured certain candidates.

He also highlighted instances where deserving candidates with qualifying marks were unfairly disqualified by reducing their scores in the merit list, describing the entire interview process as a farce. The judge emphasised the responsibility of the Assam government to restore (CONTD. ON PAGE-2)

Kanwar Yatra SC stays orders asking eateries to display names

NEW DELHI, July 22: The Supreme Court on Monday imposed an interim stay on directives passed by the Uttar Pradesh and Uttarakhand governments that eateries along the Kanwar Yatra route must display names of owners.

A bench of Justices Hrishikesh Roy and S V N Bhatti issued notices to the Uttar Pradesh, Uttarakhand and Madhya Pradesh governments while seeking their replies on the pleas challenging the directive.

"We deem it appropriate to pass interim order prohibiting the enforcement of the above directives. In other words, food sellers may be required to display kind of food, but must not be forced to display names of owners, staff employed," the bench said while posting the matter for further hearing on Friday. No one appeared for the state governments in the matter. The top court was hearing pleas filed by NGO As-

NEET-UG NEW DELHI, July 22: The Supreme Court on Monday asked the Director, IIT-Delhi to set up a

team of three experts that would go into a particular question asked in the NEET-UG 2024 examination and submit a report on the correct answer by Tuesday noon.

The top court took note of the submissions of some aspirants that a question related to an "atom" and its characteristics had two correct answers and a set of examinees, who gave one particular answer out of the two correct ones, were awarded four marks.

This, the petitioners contended before a bench headed by Chief Justice D Y Chandrachud, would have a significant impact on the final merit list of successful candidates.



Referring to the question, the bench said, "As indicated in the question as framed, of which students had to select one option as their answer. In order to resolve the issue as regards the correct answer, we are of the considered view that an expert opinion should be sought from IIT Delhi "

People in large numbers came out to the spot and demanded that police and district administration should take action against dumpers and other high speeding vehicles.

NEW DELHI, July 22: The BJP and the RSS on Monday hailed the Centre's move to lift the ban on government employees from participating in activities of the Hindutva organisation, with the Sangh saying the decision would strengthen the country's democratic system. It also accused the earlier regimes of furthering their

own political interests by imposing the ban in the past. BJP leader and Union minister Piyush Goyal said the Congress government's decision in 1966 to ban government employees from attending RSS activities was driven by political reasons.

The Congress has always had a negative mindset for nationalist organisatons, and such a thinking has no place in the country, he told reporters.

Opposition parties, which have criticised the Modi government's decision to lift the ban, were only interested in appeasement politics and have displayed a negative attitude to Hindus, he claimed.

Goyal described the RSS as a nationalist organisation whose members are full of patriotism.

A day after a government order became public about the ban being lifted and several opposition leaders criticised the move. RSS spokesperson Sunil Ambekar said in a statement, "The present decision of the government is appropriate and strengthens the democratic system of India.

the recent death and burial of a wild elephant on the premises of public sector undertaking Numaligarh Re-finery Limited (NRL) allegedly without informing the authorities concerned in Golaghat district.

A female elephant was suspected to have been electrocuted on July 18 after coming into contact with a live wire in the Butterfly Park, which is a part of the refinery, an official said on Monday. The forest department, which is investigating the case, is yet to file an FIR in this connection. Meanwhile, a NRL spokesperson told PTI that the incident was 'unfortunate and we are extending full cooperation to the forest department

in their investigation'. The elephant was 'buried before it came to the notice of the management and it was done primarily due to the fear of attack by the rest of the

nearby', she said. "There was no intention to cover up the incident as alleged by some sections. As a responsible corporate, we will abide by the outcome of the investigation", the spokesperson added.

Conservation biodiversity group 'Aaranyak' has expressed 'deep concern and outrage' regarding the incident which is a stark reminder of the ongoing threats faced by elephants in their natural habitat, particularly in the Golaghat district, which is part of a critical elephant corridor. "It is shocking that the refinery authorities buried the elephant without notifying the forest department, in gross violation of Wildlife (Protection) Act, 1972 as amended in 2022", a statement is-

sued by the organisation said. "The illegal disposal of the elephant's carcass not only undermines the legal (CONTD. ON PAGE-2)

"As education is one of the most critical areas for India's development. mission-mode and cost-effective implementation of well-designed and well-intentioned programmes is essential to improve the quality of education, especially primary education, without which further years of education add little value.

"To realise the same, unity of pur-



pose and convergence of efforts education requires spending on pedacross the centre, state, and local Governments is called for, as 'public education' is a concurrent list subject," the survey document said. It noted that increasing the cost-


NEW DELHI, July 22: The Congress on Monday slammed the Centre over its order removing the ban on the participation of government employees in RSS activities, alleging that Prime Minister Narendra Modi wants to politicise employees on an ideological basis.

The attack by the Congress, which also said that the move would be a challenge to the sense of neutrality of public servants, came after a government order became public about the ban being lifted and several opposition leaders criticised it.

In a post on X, Congress president Mallikarjun Kharge said on this day in 1947, India adopted its National Flag but the RSS opposed the Tricolour, and Sardar Patel had warned them against it.

"Sardar Patel had also banned RSS after Gandhi ji's assassination on February 4, 1948. Modi ji has lifted a 1966 ban on government servants attending RSS activities, after 58 years," he said. "We know how BJP is using RSS to institutionally take over all Constitutional and autonomous bodies. By lifting the ban on government employees from participating in RSS activities, Modi ji wants to politicise government offices and employees on ideological basis," Kharge alleged.

This will be a challenge to the sense of neutrality of public servants in government offices and the supremacy of the Constitution, he said.



The government is probably taking these steps because the people defeated its "nefarious intent to change the Constitution", he alleged.

"The Modi government continues its efforts to take control over Constitutional bodies and work its way in through the back door and tamper with the Constitution," Kharge alleged. "This is also a violation of the apology and assurance given by RSS to Sardar Patel in which they had promised that RSS will work as a social organisation without any political agenda, in accordance with the Constitution of India," he said.

Kharge asserted that the Opposition shall continue its efforts to protect the country's Constitution and its democracy. (CONTD. ON PAGE-2)

Stock markets close lower on muted earnings, caution ahead of Union budget

MUMBAI, July 22: Stock markets closed lower on Monday with benchmark Sensex dropping 102 points due to selling in index heavyweight Reliance Industries and Kotak Bank on muted earnings and caution ahead of the Union Budget. Falling for the second day in a row, the 30-share BSE Sensex dropped by 102.57 points or 0.13 per cent to settle at 80,502.08. The barometer fell by 504 points or 0.62 per cent to hit an intra-day low of 80,100.65 but recovered most of the losses as Infosys and HDFC Bank advanced. The broader Nifty of the NSE

dipped 21.65 points or 0.09 per cent to 24,509.25. During the day, it dropped 168.6 points or 0.68 per cent to 24,362.30. Among Sensex shares, Reliance Industries declined over 3 per cent after the company reported a 5 per cent drop in its June quarter net profit. Kotak Mahindra Bank also fell more than 3 per cent after its June quarter earnings failed to cheer investors. ITC, State Bank of India, HCL Technologies and IndusInd Bank were the other big laggards in Sensex shares.

However, gains in HDFC Bank after its financial results, and continued buoyancy in Infosys Ltd restricted the losses. NTPC, UltraTech Cement, and Mahindra & Mahindra also advanced. HDFC Bank climbed over 2 per cent after the company's consolidated net profit grew 33.17 per cent to ₹ 16,474.85 crore in the June 2024 quarter. "The conservative economic growth forecast for FY25,



presented in the economic survey, has introduced some spikes in volatility ahead of the budget. Further, the below-estimated Q1 refrom certain index sults heavyweights like RIL added to apprehensions of a slowdown in earnings growth in FY25. "Although the budget is anticipated to be favourable, investors will closely monitor whether it continues to tickle traction, given high valuations and the risk of a downgrade in earnings," said Vinod Nair, Head of Research, Geojit Financial Services. In the broader market, the BSE midcap gauge jumped 1.27 per cent and smallcap index climbed 0.83 per cent. Among the indices, Energy declined by 0.67 per cent, Realty by 0.53 per cent, FMCG by 0.27 per cent and Bankex by 0.27 per cent. Commodities, Consumer Discretionary, Financial Services, Healthcare, Industrials, Utilities

and Power sector indices were among the gainers. "After a sharp fall in early trades, markets were on a recovery mode and ended with marginal losses on profit-taking in banking and realty stocks. Investors traded with caution as nervousness gripped in ahead of tomorrow's Budget.

"However, markets could see volatility during the Budget announcement on Tuesday and one may see sector-based action," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said. "Benchmark equity indices

closed lower for a second consecutive session as investors awaited updates on the final budget and corporate earnings," said Avdhut Bagkar Technical and Derivatives Analyst, StoxBox. In Asian markets, Seoul, Tokyo and Shanghai settled lower, while Hong Kong ended in the positive territory. European markets were trading

higher in the mid-session deals. US markets ended lower in overnight trade on Friday.

According to the Economic Survey, 2023-24 tabled in Parliament on Monday, capital markets are becoming more prominent in India's growth story, with an expanding share in capital formation and investment landscape on the back of technology, innovation and digitisation. Further, Indian markets are resilient to global geo-political and economic shocks, it added.

"Despite heightened geo-political risks, rising interest rates and volatile commodity prices, Indian capital markets have been one of the best performing among emerging markets in FY24," the Economic Survey said. The Survey projected India's GDP to grow at 6.5-7 per cent in 2024-25, down from a high of 8.2 per cent in the the preceding financial year.

Meanwhile, global oil benchmark Brent crude dipped 0.08 per cent to USD 82.53 a barrel. Foreign Institutional Investors (FIIs) bought equities worth ₹ 1,506.12 crore on Friday, according to exchange data. The BSE benchmark hit its new all-time high of 81,587.76 in the initial trade on Friday but failed to carry forward the winning momentum and tanked 738.81 points or 0.91 per cent to settle below the 81,000 mark at 80.604.65.

Nifty tumbled 269.95 points or 1.09 per cent and ended at 24,530.90 after hitting its fresh record peak of 24,854.80 during the opening bell on Friday. (PTI)

Capital markets becoming prominent in India's growth story: Eco Survey

NEW DELHI, July 22: Capital markets are becoming more prominent in India's growth story, with an expanding share in capital formation and investment landscape on the back of technology, innovation and digitisation, according to the Economic Survey 2023-24 tabled in Parliament on Monday.

Further, Indian markets are resilient to global geopolitical and economic shocks, it added. "Despite heightened geo-political risks, rising interest rates and volatile commodity prices, Indian capital markets have been one of the best performing among emerging markets in FY24," the Economic Survey said.

The BSE benchmark Sensex and National Stock Exchange's Nifty 50 have given stellar returns to investors in the financial year 2023-24.

The Nifty 50 index surged by 26.8 per cent during FY24 against a decline of 8.2 per cent during FY23. Additionally, 30-share Sensex has soared around 25 per cent in FY24.

Moreover, the uptrend continued in FY25, with the 30-share index on July 3 touching the 80,000 mark in intra-day trading for the first time.

"The exemplary performance of the Indian stock market compared to the world and emerging markets over the years can be primarily attributed to India's resilience to global geo-political and economic shocks, its solid and stable domestic macroeconomic outlook, and the strength of the domestic investor base," said the document tabled by Finance Minister Nirmala Sitharaman in Parliament

Apart from India, all the major markets, barring

China and Hong Kong, delivered better returns in FY24 than the previous year.

The financial year 2023-24 saw stellar performances from the US, Brazilian and Japanese markets among the global markets. There was evidence of an AI-led tech stock surge, with the tech-heavy US Nasdaq index rising by 34 per cent in FY24 after delivering heavy losses in FY23.

Further, significant interest from domestic and global investors in the Indian stock market as an attractive investment destination and sustained IPO (initial public offering) activity placed the Indian market fifth in the world by market capitalisation in FY24.

India's market capitalisation to GDP ratio has improved significantly over the last five years to 124 per cent in FY24 compared to 77 per cent in FY19, far higher than that of other emerging market economies like China and Brazil.

The survey said it is imperative to strike a note of caution as market capitalisation to GDP ratio is not necessarily a sign of economic advancement or sophistication.

"Financial assets are claims on real goods and services. If equity market claims on the real economy are excessively high, it is a harbinger of market instability rather than market resilience," it added.

Indian capital markets have witnessed a broadbased expansion across various sub-markets, with the country's equity market capitalisation reaching ₹415 lakh crore or USD 5 trillion in May 2024, placing it fifth in the global rankings. (PTI)

public confidence by addressing these issues. 'The entire interview process was a mockery. Paul, along with the other members and officials of the APSC, were arrested in connection with another cash-for-jobs case related to the Combined Competitive Examinations (CCE) for recruitment of civil, police and other service officials. Paul, initially arrested in November 2016 by Dibrugarh Police, was granted bail in March 2023. The CCE case is presently under investigation by a Special Investigative Team (SIT) following the Gauhati High Court's directive. (PTI)



The affected people are from 345 villages in 21 revenue circles, according to the Assam State Disaster Management Authority (ASDMA) bulletin. The affected districts were Morigaon, Kamrup, Dhemaji, Kamrup Metropolitan, Dibrugarh, Sivasagar, Nagaon, Golaghat, Goalpara, Jorhat and Cachar. Nagaon was the worst-affected district with 70,280 affected, followed by Golaghat (12,321) and Cachar (6,773). As of Saturday, the number of affected people was 1.30 lakh in 10 districts. Floodwaters also inundated croplands over 6,467.5 hectares. A total of 6,311 people have taken shelter in 35 relief camps. Brahmaputra was flowing above the danger mark in Dhubri while in the other affected districts it was receding and was flowing below the danger mark, the bulletin added. The state has so far faced two waves of flood, affecting all the 35 districts of the state with the first wave from May 28 to June 13 while the ongoing second wave began on June 16. NEW DELHI, July 22: The pre-budget Economic Survey on Monday called for urgent reforms in India's agricultural sector, warning that the structural issues could impede the country's overall economic growth

trajectory. The survey, tabled in Parliament by Finance Minister Nirmala Sitharaman, highlighted the untapped potential of the Indian agriculture sector compared to other economies. Chief Economic Advisor V Anantha Nageswaran called for a pan-India dialogue on the agriculture sector. The survey, presented ahead of the annual budget, emphasised that India has yet to fully leverage its agricultural sector for economic growth and job creation, unlike East Asian economies and Western developed nations. "Indian agriculture is not in a crisis now but requires a serious structural transformation because climate change and water criticality loom large in the times to come," the survey stated The CEA advocated for a re-

assessment of existing policies, despite current government subsidies and support measures for farmers

"The payoff will be immense if we untie the knots that bedevil farm sector policies," Nageswaran said in the survey's preface.

At present, the bulk of the FDI coming into India falls under the automatic approval route, however, FDI from countries sharing land borders with India needs mandatory government approval in any sector. China stands at 22nd position with only 0.37 per cent share (USD 2.5 billion) in total FDI equity inflow reported in India from April 2000 to March 2024.

Countries which share land borders with India are China, Bangladesh, Pakistan, Bhutan, Nepal, Myanmar, and Afghanistan. (PTI)

NEW DELHI, July 22: The Indian economy needs to generate an average of nearly 78.5 lakh jobs annually until 2030 in the nonfarm sector to cater to the rising workforce, according to the Economic Survey for 2023-24.

The Survey tabled in Parliament on Monday also laid emphasis on the private sector's role to create employment in the country saying "In more than one respect, the action lies with the private sector. In terms of financial performance, the corporate sector has never had it so good."

It noted that results of a sample of over 33,000 companies show that, in the three years between FY20 and FY23, the profit before taxes of the Indian corporate sector nearly quadrupled.

"The nominal GDP grew 9.6 per cent y-o-y to ₹ 295-lakh crore. Hiring and compensation growth hardly kept up with it. But, it is in the interest of the companies to step up hiring and worker compensation," it stated.

The survey provided a broad estimate of the number of jobs (78.5 lakh per annum) that the economy has to generate.

The impact of automation on workers being complex and uncertain, the direction of technological change remains susceptible to forces of political economy, it noted. India thus needs to invest in research and steer the AI bandwagon towards shared prosperity, it suggested, adding that something as basic and age-old as unpaid care work needs attention too. (PTI)

importance of girls' education, its translation to economic empowerment will require better learning outcomes, employability, labour force participation and conducive infrastructure," it said. Female enrolment in higher education increased to 2.07 crore in FY 22 from 1.57 crore in FY 15 -- a 31.6 per cent increase since FY15. The growing equity in higher education implies better employment opportunities for the hitherto backward sections. The survey suggested that to better translate Gross Expenditure on Research and Development (GERD) to research output, the link between higher education, industry and research must be strengthened.

"Another challenge is low 'Land to Lab' time. Institutions in India develop technologies, but their transformation rate from the lab to the society for the benefit of the people remains low. Several efforts are underway to attract research personnel and create adequate opportunities in the research ecosystem of the nation.

"The ease of doing research is being bolstered through streamlining of patent grants, leading to a drastic reduction in the average time taken for examination of a patent application from 72 months in 2015 to between 5 to 23 months in 2022, depending upon fields of technology," the survey document said. His remarks come a day after Congress general secretary of communications Jairam Ramesh shared an office memorandum, dated July 9, issued by the Ministry of Personnel, Public Grievances and Pension pertaining to the participation of the government servants in the activities of the RSS.

"The undersigned is directed to refer to the OM (office memorandum)..dated 30.11.1966, OM No. 7/4/70-Est.(B) dated 25.07.1970 and OM No. 15014/3(S)/80- Estt. (B) dated 28.10.1980 on the above subject. 2. The aforesaid instructions have been reviewed and it has been decided to remove the mention of Rashtriya Swayam Sewak Sangh (R.S.S.S) from the impugned OMs dated 30.11.1966, 25.07.1970 and 28.10.1980," the order read.

In a post along with the picture of the order, Ramesh said on Sunday, "Sardar Patel had banned the RSS in February 1948 following Gandhi ji's assassination. Subsequently, the ban was withdrawn on assurances of good behaviour. Even after this the RSS never flew the Tiranga in Nagpur." In 1966, a ban was imposed - and rightly so on government employees taking part in RSS activities, Ramesh said. "After June 4th, 2024, relations between the self-anointed non-biological PM and the RSS have nosedived. On July 9, 2024, the 58-year ban that was in force even during Mr Vajpayee's tenure as PM was removed," he said.

'The bureaucracy can now come in knickers too I suppose," Ramesh had said, alluding to the RSS uniform of khaki shorts which was replaced by brown trousers in 2016. BJP's IT department head Amit Malviya also shared a screenshot of the order and said that an "unconstitutional" directive issued 58 years ago has been withdrawn by the Modi government. Ramesh too shared a screenshot of the original order dated November 30, 1966, banning the association of government servants with the activities of the RSS and the Jamaat-e-Islami. (PTI)

Economic Survey: A cautious optimism

he Economic Survey 2023-24 presents a cautiously optimistic outlook on India's growth trajectory. While it acknowledges the positive short-term prospects, it highlights several areas of concern requiring strategic long-term planning. The Survey emphasizes the need for comprehensive agricultural reform. Despite its central role in India's economy, the sector faces structural challenges, including food price inflation, inefficient price discovery mechanisms, and land fragmentation. Policymakers must balance incentivizing farmers to boost production with maintaining affordable food prices, necessitating nuanced policy interventions. Labour market improvements are noted, but the rise of artificial intelligence (AI) in economic activities poses challenges. The Survey calls on employers, not the government, to balance technology deployment with labour utilization, stressing the importance of steering technological choices towards collective welfare.

Regulatory hurdles, such as restrictive land use and building codes, also impede employment generation. The Survey urges reforms to unlock job creation potential, particularly in sectors and hours open to women's employment. The Survey addresses the Rupee's volatility, noting it was one of the least volatile currencies in FY24 despite depreciation pressures. However, this relative stability is viewed as cold comfort amid the US dollar's strength against major peers. The global impact of China on the economy remains significant. The Survey highlights the "China plus one" strategy, where nations like Mexico, Vietnam, Taiwan, and Korea have benefited from US trade diversion from China while also attracting Chinese FDI. This dynamic underscores that India's path to becoming a developed nation will differ from China's economic boom between 1980 and 2015. The Survey cites geopolitical stability post-Cold War, Western encourage ment of China's rise, and less pressing climate concerns as factors that facilitated China's growth. In contrast, India faces significant barriers, including Al's uncertain impact on employment and climate challenges, requiring a unified effort from union and state governments and the private sector to sustain high growth rates.

On welfare economics, the Survey touts a reformed approach focusing on empowerment, universal access to necessities, efficiency, and private sector participation. However, these claims remain contentious regarding their implementation and effectiveness. India's external sector remains resilient despite geopolitical headwinds and persistent inflation. The Survey attributes food price inflation to adverse weather in recent years but anticipates normal conditions will stabilize inflation in FY25 and beyond. Achieving long-term price stability hinges on enhanced price monitoring, market intelligence, and increased domestic production of essential food items like pulses and edible oils. The Survey praises India's post-pandemic economic recovery, with real GDP in FY24 being 20% higher than FY20 levels. While strong growth prospects for FY25 and beyond are anticipated, they are contingent on geopolitical, financial market, and climate risks. The Survey warns that geopolitical conflicts in 2024 could disrupt supply chains, elevate commodity prices, revive inflationary pressures, and stall monetary policy easing, impacting capital flows and RBI's policy stances. Increased geopolitical fragmentation and protectionism could distort merchandise trade growth, affecting India's external sector. Global financial markets, riding high on economic expansion bets, could face corrections that impact household finances and growth prospects. The Economic Survey 2023-24 offers a nuanced view of India's growth prospects, emphasizing the need for strategic long-term planning and reforms to address structural challenges in agriculture, labour markets, and regulatory frameworks. Achieving sustainable growth will require coordinated efforts across government and private sectors to navigate the complex global economic landscape.

Bangladesh reveals that a week-long wave of violent protests has caused a nationwide shutdown. The army has been called in to suppress the movement, which was reportedly initiated by college students opposing job reservations for the children of 'Mukti Joddhas,' the freedom fighters who liberated

the country from Pakistan in 1971 On Sunday, the Supreme Court overturned a high court ruling from earlier this month that had implemented reservations for nearly one-third of all government jobs. The new judgement permits only 5% reservation for veteran relatives and an additional 2% for various disadvantaged groups. This decision aims to address the violence, which has resulted in over 100 fatalities.

Interestingly, the job quota, which was established following Bangladesh's war of independence, had been abolished in 2021 when Prime Minister Sheikh

Hasina decided to eliminate it. How should one interpret the movement that has transformed Bangladesh into a conflict zone?

And what implications might it have for South Asia, particularly for its neighbouring country, India? The protests, initially sparked

by opposition to a now-abolished quota, have long since evolved from a typical student demonstration into a nationwide movement against the ruling party, which secured a third term in office in an election earlier this vear. This raises questions about whether the Supreme Court's recent judgement will be sufficient to permanently calm the unrest, especially given that over 100 people have died and many more have been affected by the crackdown.

The democracy deficit highlighted in this year's election, boycotted by the main Opposition BNP and excluding the radical Bangladesh Jamaat-e-Islami, which is accused of complicity in war crimes in 1971, has clearly contributed to fueling the broader protest. However, this is only part of the story. Earlier this month, the Dhaka

High Court's decision to potentially reinstate the scrapped quota system with increased reservations for veterans' children triggered spontaneous protests across nearly all universities. Efforts to defuse the tension by

Ihe latest news from Court suspend the order proved ineffective. The protests quickly escalated, drawing in discontented segments of the population and the opposition, all frustrated with the Awami League.

> Upon returning from a state visit to China, Sheikh Hasina made a tactless remark about the quota issue, exacerbating the situation. She sarcastically questioned whether reservations should instead be made for the children of 'Razaakars,' the fundamentalist militia that assisted the Pakistani army in committing genocide against millions of unarmed civilians between March and December 1971. This statement only intensified the unrest. The Awami League govern-

Taka, and a sudden decline in Bangladesh's primary exportgarments.

The government's once-close relationship with China has also deteriorated. Sheikh Hasina, who had been negotiating for a US \$5 billion soft loan, returned from Beijing last week with a mere US \$139 million in loans.

China, which had previously extended over US \$7 billion in loans for ports, highways, and other infrastructure projects in Bangladesh, is now pressing for debt repayments. This has significantly strained Dhaka's foreign exchange reserves, which have plummeted by 60% from August 2021 to June 2024.

The steep decline in exports, triggered by the Red Sea crisis that has driven up transportation costs to Europe and the US, has further exacerbated Dhaka's balance of payments issues. This situation has caused the Taka to depreciate from TK 105 to the dollar in March to TK 117 currently. Meanwhile, inflation has remained above 9% over the past

The Opposition, viewing the student protests as a crucial opportunity in their failing attempt to unseat Hasina, mobilized their student factions.

Many of these groups, some armed, intensified the riots, transforming them into a severe existential crisis for the Awami League and demanding Hasina's resignation.

Widespread frustration with



economic hardships and the ruling party's heavy-handedness quickly merged, causing the grievance over the now-abolished quota to fade into the background amidst the surge of public outrage.

When the Opposition, including Islamist groups, urged for a ramping up of

the protests that had already resulted in numer-

> deaths, ous Dhaka's streets erupted into a violent conflict on Friday, leaving many more dead. In response, Hasina called in the army.

This occurred despite the fact that Hasina's party harbors deep mistrust of the military, which has a history marked by coups. counter-coups, and the assassination of leaders, including Sheikh Mujib-ur-Rahman, the founder of Bangladesh and Hasina's father. On August 15, 1975, Mujibur-Rahman and his entire family were murdered, except for two daughters who were abroad at the time.

The future of this latest development in Bangladesh's tumultuous political landscape remains uncertain. Social media is currently flooded with false reports claiming that junior military officers are voicing opposition to the government in support of the students. However, in South Asia, fake news has a troubling tendency to become reality over time.

While these events are certainly cause for concern in Delhi and among the international democratic community, what is even more troubling is the emergence of overtly communal and anti-India slogans and posters during the protests.

One of the more moderate posters displayed during the protests read, "Chhatra Jodi Razakaar, Desh Kar? Indiar?" which translates to, "If students are Razakaars, who owns the country-India?" This implies that

the Sheikh Hasina-led government is merely an Indian puppet, a baseless accusation that has been repeatedly made by the opposition BNP and the radical . Bangladesh Jamaat-e-Islami for vears.

In the 1990s, the Taliban recruited a significant number of fighters from Bangladesh. Upon their return from Afghanistan, these individuals became the backbone of extremist groups that have troubled Dhaka over the past two decades. The extremist factions established by these returnee Bangladeshi Taliban conducted attacks both within Bangladesh and across India.

The most dramatic attack occurred in 2016 at a café in Dhaka, where terrorists brutally murdered 22 people. Following this, Sheikh Hasina's crackdown dismantled many of these extremist cells, leading to the arrest or death of numerous jihadists.

The current protest slogan, Amra Kara, tomra Kara, Razakaar, Razakaar" (Who are we? Who are you? Razakaar, Razakaar), bears a striking resemblance to an earlier chant used by Taliban returnees in the early 2000s during street demonstrations: "Amra sobai hobo Taliban, Bangla hobe Afghanistan" (We will all become Taliban, Bangladesh will turn into Afghanistan).

Following Mujib's assassination in 1975 and up until the 2000s, when BNP's Begum Khaleda Zia was in power, Bangladesh became a refuge not only for Islamist terror groups but also for insurgents from India's Northeast.

Ministers in the BNP-led government and military officers were implicated in the illegal arms trade, which was believed to have started in southwest China. This operation also reportedly involved the intelligence agency of another South Asian country, facilitating the flow of weapons to militants in India's Northeast.

Bangladesh has historically had a faction of its population backing fundamentalist causes, alongside a similarly significant group supporting moderate Islam and a secular government. The majority of the population tends to remain neutral, but periodically shifts towards either end of the political spectrum, leading to significant changes in the nation's political landscape.

In 1947, the Muslim League succeeded in shaping public opinion and persuaded East Bengal to join Pakistan. However, in 1971, the majority of the population shifted their support to the left-of-center Awami League, which advocated for a secular and democratic Bangladesh.

Should the movement to oust Hasina succeed, India faces the risk that the new leadershipwhether it be a BNP-Jamaatbacked coalition or a group of young military officers-might be influenced heavily bv Bangladesh's growing faction of radical Islamists and pro-China supporters.

This does not imply that India should blindly support the Awami League. A genuine ally should point out errors and assist in making necessary corrections. Hasina has been making numerous mistakes in her efforts to strengthen her rule-by bypassing democratic elections, empowering corrupt party officials, marginalizing longstanding loyalists, and yielding to pro-Islamist factions by accommodating their demands

However, both New Delhi and other major powers with interests in the region should recognize that a Bangladesh hosting Chinese interests, potentially including naval assets, would pose a direct military threat not only to India but also to the United States. The US is engaged in a crucial struggle with Beijing for control of the Indo-Pacific region

Bangladesh's Jamaat and BNP are also thought to maintain active links with Pakistan, particularly with its military intelligence agency, ISI. If Dhaka were to rejoin the expanding alliance between Beijing and Islamabad, it would place South Bloc in a precarious position, facing threats from both sides of its border and "dragon breathing fire from above." Karnataka's bold move on job reservations: A blueprint for Assam?

The Karnataka Cabinet's recent decision to mandate 50% reservation for locals in management jobs and 70% in non-management positions marks a significant move in regional employment policies. This legislative initiative, aiming to prioritize local employment, echoes similar sentiments seen across various states in India. It underscores the growing emphasis on regionalism and the need to address local unemployment issues by ensuring that a substantial proportion of job opportunities within a state are reserved for its residents.

In examining the potential implications and the broader context of this decision, it's essential to draw parallels with Assam, a state with its own unique set of challenges and policies related to employment and local reservations. Assam, much like Karnataka, has grappled with high unemployment rates and the complex dynamics of local versus non-local employment.

Assam's economy, traditionally agrarian, has been undergoing a slow transition with increasing industrialization and urbanization. However, the pace of job creation has not kept up with the growing workforce. According to the Centre for Monitoring Indian Economy (CMIE), Assam's unemployment rate stood at 8.1% in 2023, higher than the national average of 7.2%. This disparity has often led to local discontent, with many advocating for job reservations similar to those seen in Karnataka. The state's demographics, characterized by a significant proportion of indigenous communities, add another layer to the employment debate. Ensuring job opportunities for locals in Assam is not just an economic issue but also a cultural and political one.

The introduction of job reservations in Karnataka could serve as a blueprint for Assam. If Assam were to implement a similar policy, it would need to consider several factors unique to its socio-economic landscape. Firstly, the demographic composition of Assam, with its diverse ethnic groups, would necessitate a nuanced approach to job reservations. The policy would need to balance the interests of various indigenous communities and other resident groups to ensure inclusivity and avoid potential conflicts. Furthermore, Assam's economy is significantly different from Karnataka's. While Karnataka boasts a strong industrial and IT sector, Assam's economy is still heavily reliant on agriculture, tea plantations, and oil. This economic structure means that job reservations in Assam would need to focus not only on emerging sectors but also on traditional industries that form the backbone of the state's employment.

Another critical aspect to consider is the role of education and skill development. In both Karnataka and Assam, the success of any job reservation policy hinges on the availability of a skilled workforce. Assam has made strides in improving educational infrastructure, but there is still a significant gap in vocational training and higher education tailored to meet industry needs. A reservation policy must be accompanied by robust measures to enhance local employability through targeted education and skill development programs.

The implementation of job reservations in Karnataka also raises questions about the legal and constitutional framework governing such policies. While the Indian Constitution allows for affirmative action to address social inequalities, the extent and nature of iob reservations have often been subjects of judicial scrutiny. Assam would need to navigate this complex legal landscape to ensure that its policies are both effective and compliant with constitutional mandates. Moreover, the economic impact of job reservations

cannot be overlooked. Critics of reservation policies argue that they may deter investment and affect the competitiveness of industries by imposing restrictions on hiring. For Assam, attracting investment is crucial for economic growth and job creation. Therefore, any reservation policy would need to strike a balance between promoting local employment and maintaining a conducive environment for business and investment.

Public opinion and political will are also decisive factors in the implementation of such policies. In Karnataka, the move to introduce job reservations has been met with both support and opposition, reflecting the diverse views on regionalism and employment. In Assam, a similar policy would likely generate significant debate, given the state's history of ethnic and political movements. Building a consensus through dialogue and stakeholder engagement would be essential for the successful implementation of job reservations

In conclusion, the Karnataka Cabinet's decision to mandate job reservations for locals presents a compelling case study for Assam. While the underlying objective of addressing local unemployment is common to both states, Assam's unique socio-economic context necessitates a tailored approach. Implementing a similar policy in Assam would require careful consideration of the state's demographic diversity, economic structure, educational landscape, legal framework, and investment climate. By learning from Karnataka's experience and adapting it to local needs, Assam can work towards a more inclusive and equitable employment policy that benefits its residents while fostering economic growth and development. Gambia bans FGM

ast week, thirty-four out of 53 Gambian lawmakers voted to maintain the FGM ban, which was introduced in 2015, aid workers told the Guardian. The remainder voted to repeal it. There was certainly an air of jubilation amongst the anti-FGM activists and workers of the world bodies, like the WHO, UNICEF, UN Women who have continuously waged an advocacy campaign against this barbaric practice.

Jaha Dukureh, an FGM survivor and founder of Safe Hands for Girls, said: "Today we stood on the right side of history one more time. We have shown that even if they burn down this country, we will rebuild to protect our women and girls. Today, we won for Gambia."

According to the UN, Gambia has the ninth-highest rate of FGM in the world. Almost three-quarters of Gambian women between 15 and 49 have undergone FGM, which involves the partial or total removal of the external female genitalia. Nearly two-thirds of them were cut before the age of five.

The bill was tabled in March by Almameh Gibba, who said he did so to "uphold religious loyalty and safeguard cultural norms and values" in the Muslim-majority state. It was initially approved by a majority of MPs, which forced human rights campaigners to intensify lobbying against the move.

The law's repeal was backed by Muslim clerics, who hold much sway in the Gambia, a conservative country of 2.7 million people.

The vote was taken following the bill's second reading after being referred to a parliamentary committee for consultation. A third and final reading had been tabled for next week. Fabakary Tombong Jatta, the

speaker of parliament, said: (We) cannot be engaged in such a futile exercise as to allow the bill to proceed to a third reading. The bill is rejected and the legislative process exhausted."

Judy Gitau, coordinator for Equality Now's Africa office, applauded last Monday's vote for setting a precedent. She said: "Repealing the FGM law was going to set a new low in the pushback against women's rights.'

While welcoming the move to uphold the law, human rights campaigners warned that more needed to be done to improve the lives of women and girls in the West African country.

Binta Ceesay, women's rights manager at ActionAid Gambia, said: "Since FGM was banned nearly a decade ago, we have made encouraging strides in ending the practice, but it has not been enough."

The World Health Organisation estimates that about 230 million women and girls have undergone this traditional procedure, in which not only the clitoris but often also the inner and outer labia are cut away by a knife or razor, usually without anaesthetics, antiseptics or antibiotics. Infections, some of them fatal, are commonplace.

Most girls are "circumcised" in this way in Egypt, Sudan and the Horn of Africa, in the Muslim countries of West Africa. and in Indonesia, usually under the age of five.

It is less common in the eastern Arab countries (e.g., Iraq, Saudi Arabia and Yemen), and rare in Iran, Turkey and Pakistan, but the victims are overwhelmingly Muslims. So are the perpetrators.

This poses a real problem for the anti-FGM campaigners, because most of the people who do this to their girl children are convinced that it is an Islamic practice, or even a religious obligation.

It particularly appeals to men

who are obsessed about female "chastity"

These attitudes are common even in the farthest reaches of the Islamic world, like the Muslim-minority parts of Russia. When a 2016 report revealed

the practice is widespread in the mountain villages of Karachayevo-Cherkessia. Samira Daoud, Amnesty In-

ternational Regional Director for West and Central Africa, said: "We welcome with great relief the rejection of the bill aimed at reversing the ban on

FGM in Gambia. In 2015, the adoption of the Women's (Amendment) Act, which criminalises and sets out punishments for performing, aiding and abetting the practice of FGM, represented a significant milestone in the country's efforts to safeguard girls' and women's rights. It was essential

that this progress be protected." In a joint statement UNICEF Executive Director, Catherine Russell, UNFPA Executive Director, Natalia Kanem, WHO Director-General, Dr. Tedros Adhanom Ghebreyesus, UN Women Executive Director, Sima Bahous, and UN High Commissioner for Human Rights, Volker Türksaid: "The decision to maintain the FGM ban aligns with The Gambia's international and regional commitments to prevent harmful practices against girls and women, consistent with the Convention on the Rights of the Child (CRC), the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW), the African Charter on the Rights and Welfare of the Child, and the Maputo Protocol protecting

African women's rights.' Islam and FGM

There is no mention of female circumcision in the Holy Qur'an, and only five hadiths (reports of what Prophet Mohammed actually said) refer to it. None of them states that it is a religious duty, and there is no evidence that the Prophet (PBUH) had any of his wives or daughters circumcised.

Why do the hadiths mention it at all? "It is as if Islam deemed it necessary to regulate this practice which was already performed by the Arabs prior to the advent of Islam," suggests Egyptian Islamist scholar Dr Mohamed Selim Al-Awa, founding General Secretary of the International Union of Islamic Scholars.

Senior Muslim religious authorities agree that FGM is neither required nor prohibited by Islam. The Qur'an does not mention FGM or male circumcision.

FGM is praised in a few hadiths as noble but not required, and moreover the authenticity of these hadith has been questioned.

Several Muslim leaders have called for an end to the practice. In 2004, after CNN broadcasted images of a girl in Cairo undergoing FGM, the then Grand Mufti of Egypt Muhammad Sayyid Tantawi declared that hadiths on FGM as unreliable. A conference at Al-Azhar University in Cairo in 2006 saw prominent Muslim clergy declare it unnecessary.

Sheikh Ali Gomaa, the then Grand Mufti of Egypt, stated: "It's prohibited, prohibited, prohibited." Ekmeleddin İhsanoğlu, Secretary-General of the Organisation of Islamic Cooperation said in 2012 that FGM was "a ritual that has survived over centuries and must be stopped as Islam does not support it.'

Indeed, it would be much preferable if international Islamic organisation like the OIC join hands with world bodies like the UNICEF, UN Women etc. to put a complete ban on this inhuman practice in today's modern world. Eating ultra-processed foods may raise risk of death by 10%

eople who consumed significant amounts of ultra-processed foods were 10% more likely to die during the study's long follow-up period than those who did not.

The study drew on data from the US NIH-AARP Diet and Health Study, which tracked the diet and health of over a half million older people. The new analysis included adults ranging in age from 50 to 71 at baseline in 1995-1996, with a median 22.9-year follow-up period.

The researchers scored their diets using the NOVA system, which classifies foods according to the degree and type of processing used in their preparation. They looked at Healthy Eating Index (HEI)-2015 scores, and not just NOVA processing, and noted that people with higher UPF intake tended to have lower diet quality and a higher BML

What makes this study noteworthy, in particular, is the two approaches the researchers used to further validate the food frequency questionaries (FFO): expert consensus and an alternative and novel food-based approach to define UPF intake (grams per day), which was broken down into food codes, then ingredient codes, then classified via NOVA.

The researchers also used two 24hour diet recalls in a subgroup to calibrate their FFQ risk estimates, which is not standard practice and adds to the potential rigor of the study's findings. The research was presented this week at the American Society for Nutrition's NUTRITION 2024 confer-

What is the definition of ultraprocessed foods?

According to the NOVA system, natural, processed, and ultra-processed foods are defined as the following: Unprocessed, or natural, foods come directly from plants or animals without any alteration or processing, apart from transport to the location where they are sold. Minimally processed foods are similar, except that they have been cleaned and inedible or undesirable parts removed. They may be cut into portions, ground, dried, fermented, pasteurized, cooled, or frozen en route to the table. However, no oils, fats, sugar, salt, or other substances have

been added to them. NOVA also includes a category called Processed Culinary Ingredients, which are substances that have been extracted from natural foods. These include oils, fats, salt, and sugar, and are ideally used in small amounts to season and cook foods without nutritionally degrading the overall quality of the diet.

Processed foods are foods that have

been manufactured for consumption using sugar, salt, and oil added to natural foods for flavor, and to help extend their shelf life. They typically have no more than two or three ingredients

Ultraprocessed foods, or UPF, are industrial creations shaped mostly from substances, including oils, fats, sugars, and proteins derived from natural foods, along with modified starch and hydrogenated fats, with added coloring, and flavor enhancers. They are inexpensive for the consumer and convenient, and may contain five or (many) more ingredients

What is new about the study

It is already widely known that a diet heavy in ultra-processed foods can be damaging to one's health. However, the large number of people in this study - 318,889 men and 221,607 women - and the extended follow-up time are unusual.

Dietitian Kristin Kirkpatrick, MS, RDN, who was not involved in the research, said, "The very long follow-up period is interesting; however, the researchers also note that it's unclear what was done between the time the data was taken and the follow-up. Did these people make dietary changes? Were there other activities that were risky to overall health? We are unclear on the details."

Compared to the lowest amount of processed food consumption, the highest amount was associated with increased risks of death from heart disease and diabetes but not death due to cancer.

"This research shows that higher consumption of ultra-processed foods is associated with increased mortality risk independent of other factors like smoking, obesity, and diet quality,³ said Michelle Routhenstein, MS, RD, CDCES, preventive cardiology dietitian at EntirelyNourished.com, who was also not involved in the research. 'This suggests that the detrimental

effects of ultra-processed foods on health may persist regardless of overall lifestyle factors," said Routhenstein.

"Ultra-processed foods are typically higher in added sugars, unhealthy fats, and additives, while lacking essential nutrients such as fiber and vitamins, which can negatively impact cardiometabolic health. These foods contain higher levels of advanced glycation end products (AGEs) due to their processing methods, which may increase oxidative stress and inflammation in the body. AGEs may also raise cystatin C levels, associated with decreased kidney function and heightened cardiovascular disease risk.' Michelle Routhenstein, MS, RD, CDCES

An older cohort

Given the extended follow-up pe-

riod, participants were aged from roughly 73 to 94 at the time of followup. "Research on the impact of ultraprocessed foods specifically in older adults is limited but growing. The specific long-term impact on mortality in older populations is still an area of active study," said Routhenstein.

"It's never too late to make beneficial dietary changes," said Kirkpatrick. "Previous research has found similar results to lifespan, such as a study which assessed UPF in ages 57-91.' She noted that much of the research

she sees involves younger people, and focuses on prevention of later problems through better nutrition. The younger side of older

The researchers found that younger members of their study population tended to consume UPF more than older members.

"Younger participants - particularly middle-aged individuals - may consume more ultra-processed foods due to factors such as convenience, affordability, and advertising. These foods are often widely available, require minimal preparation, and are heavily marketed, making them appealing to busy lifestyles," Routhenstein said.

It may also be the case, noted Kirkpatrick, that "younger individuals who are generally healthy and have not had symptoms of/or serious illness may not be thinking of what the future holds in relation to their diet today."

Is processed food necessarily bad? The American diet typically contains a substantial number of foods that span the processing spectrum. "Some of these foods such as breakfast cereals, for example, may even help to fill some nutritional gaps via fortification," said Kirkpatrick.

However, she said, "Consuming a lot of these foods means not having the opportunity to feed the body with [more] nutrient-dense options." The result may be a high consumption of calorie-dense foods lacking in nutrition

Kirkpatrick expressed concern regarding an over-dependence on the NOVA classification system for assessing the impact of processed foods.

"The NOVA scale is strictly related to the degree of processing and has nothing to do with the foods' nutritional value, so it doesn't account for things like added sugar, protein, or fiber content," she explained.

"Lumping all processed foods together risks oversimplifying nutritional science, so limiting UPF should go alongside education for individuals as well," Kirkpatrick said.

"There is no one-size-fits-all dietary approach, so each and every patient may deserve a personalized approach to their dietary needs and goals," she said. (Courtesy: Medical News Today)

How the Indian freedom struggle inspired a future Sri Lankan president

n the late 1920s, when the British Empire's authority seemed almost unchallenged in what was then called Ceylon, the colonial authorities were alerted about an act of defiance challenging their rule: a student of the Ceylon Law College had hung a portrait of Mahatma Gandhi in the main parlour.

That rebel, Junius Richard Javawardene, was no ordinary student. The son of a Colombo lawyer, the young man would win a gold medal for his oratory skills and a special prize for his legal research, before going on decades later to become the president of Sri Lanka.

"This sensational episode gained me much publicity at that time, for it amounted to a challenge thrown at the British Rai." Javawardene wrote in his biography Men and Memories.

Although he began practising law after his graduation, Jayawardene found himself increasingly attracted to politics and the Indian independence movement.

"The masses were either apolitical or showed total indifference to national problems," he said about Ceylon of the 1920s and '30s. "But in the neighbouring subcontinent of India, a mass movement was in full swing. Mahatma Gandhi, the frail ascetic, was the general who planned the Swaraj Movement, and his technique of Satyagraha or the power of truth was the basis of the Indian freedom struggle. I was much impressed by the role played by Pandit Nehru for whom I developed a great affection.'

Jayawardene would get a chance to meet both Gandhi and Nehru when he went to India for sessions of the Indian National Congress, which made sure to invite delegates from Ceylon and Burma as well.

Buddha's footsteps A trip to Ramgarh in 1940 for

the 53rd session of the Congress left a deep impression on Jayawardene's mind.

of social and economic con-"It was a pretty countryside that we passed through on our way, for over a hundred miles to the west of Calcutta," he wrote. "Ramgarh itself is very similar to Divatalwa, undulating vallevs, large plains and mountain streams abounding."

Rajendra Prasad's words that "every particle of dust" was "sanctified by the touch of the feet of Gautama, the Buddha" really resonated with Javawardene. The countryside of Bihar, Javawardene said, had a history that was "unequalled in the world" since the founders of both Buddhism and Jainism spent large portions of their life there.

As a 34-year-old with a long political career ahead of him, Jayawardene observed the key figures of the Indian freedom struggle. Nehru, he said, was "quick of temper" and Khan Abdul Gaffar Khan "over six feet in height"

From his time in Ramgarh, Jayawardene took away some astute learnings. "Two facts were clear," he said. "First, India was united in her demand to be free and she wanted her freedom outside the British Commonwealth of Nations. Secondly, Mahatma Gandhi was still the unquestioned leader of India. There was no opposition to his leadership." He noted that Subash Chandra Bose had organised a counter-show with his "anticompromise" and "Forward Bloc" ideals. "These meetings were attended by the Kisan (peasant) organisations and had the support of over a lakh of people," he wrote. "The opposition was not, however, to Gandhi's leadership; it was to his refusal to begin the fight." He said Ceylon could learn

many things from the way Indian politicians conducted themselves in their struggle against the British, especially the absence of racial or personal feelings.

"No man or woman we met, be he/she leader or the follower, talked except in terms of ideals

struction, of a new world order based not on exploitation, but according to a planned economy," he wrote. "In the field of politics, the masses were trained to think not in terms of race or personalities, but in terms of social equality, equal opportunity for all and anti-imperialism."

The Ramgarh session marked the beginning of a decades-long friendship between Nehru and Jayawardene. Delegates from Ceylon and Burma were invited to stay with Nehru in Allahabad, an invitation that the Sri Lankan politician gladly accepted.

"We were treated with the greatest kindness and hospitality, as if we were old friends,' Jayawardene wrote. "Mrs Vijaya Lakshmi Pandit, as Nehru's sister as the hostess, used to sit down for morning breakfast with us to a typical Western breakfast with bacon and eggs, toast and marmalade. The host

presided and sat with us." Jayawardene treasured his brief stay in Allahabad. "We had long discussions with Pandit Nehru though we were far removed from his activities which covered almost 20 years of direct and indirect non-violent campaigns, to free India from foreign rule," he said. Nehru's role in the freedom movement was discussed as well.

Correspondence Nehru

"Like all other youths of our generation throughout the British Empire, we hero-worshipped Jawaharlal Nehru and his leader, Mahatma Gandhi," Jayawardene wrote. "The friendship formed thus enabled me to correspond with him." The two regularly exchanged letters until Nehru's incarceration.

Jayawardene released the correspondence in July 1971 after reading an appeal from Indira Gandhi to anyone possessing letters from her father to make them available to the Jawaharlal Nehru Memorial Fund. The letters make for interesting reading.

In 1940, there was a genuine fear that Ceylon may be bartered away to a rival power by the British if they lost the war. This led people like Jayawardene to look at what can only be described as a political union between Ceylon and India.

"Some of us – the number is increasing - think that our future lies with India, and we are endeavouring to arrange for the sending of a representative deputation from Ceylon to meet the Indian leaders," Jayawardene wrote in a letter dated July 20,1940. "Federation or closer union between a free India and a free Ceylon would certainly be a subject we wish discussed."

In his reply, Nehru said, "It is too much to hope that a real World Federation of free nations will emerge out of this terrible conflict." He suggested that various types of federations could exist with or without Britain and then added: "Personally I should like India to be closely associated in a future order with China, Burma and Ceylon, as well as other countries which fit in.'

Their correspondence exhibited a prodigy-mentor relationship. "The 21st session of our Congress party was held in December and it was modelled on the lines of the Indian Congress with Swadeshi exhibitions. open air mass meetings etc," Jayawardene wrote in a May 1941 letter. A few months before Ceylon attained independence in 1948, Jayawardene was appointed the country's minister of finance. Over the next few decades, he was either in government or in opposition.

The country was renamed Sri Lanka in 1972, and in 1977, he became prime minister. He then amended the constitution to make the presidency an executive post and served as the president from 1978 to 1989.

While he continued to express admiration for Gandhi and Nehru, his actions and inactions letter also spoke of the victory belied their ideals. "Had Jayawardene genuinely structured a compromise with Tamil citizens of his country, instead of indulging in political ambiguities aimed at perpetuating Sinhalese domination of Sri Lankan politics, the country's history would have been different and not as tragic as it is now," Dixit wrote in his book Assignment Colombo.

Dixit had plenty of praise for Jayawardene, though. "He was the last generation of South and South Asian leaders who witnessed the emergence into independence of Asian and African countries," Dixit wrote.

"Sri Lanka in general and South Asia in particular are poorer with his passing from the scene.'

Dixit mentioned that Jayawardene took great pride in his relationship with India's freedom fighters: "Jayawardene was deeply convinced that among all the leaders of the countries neighbouring India, he was the most knowledgeable about India.'

The Indian diplomat was always reminded by Jayawardene of his links with the Indian freedom struggle. "He had a photograph on his drawing room mantlepiece, where he appeared sitting on the dais between Mahatma Gandhi and Jawaharlal Nehru," Dixit wrote. "He invariably drew the attention of his important Indian visitors to this photograph in his Ward Place residence.⁷

It is clear from Javawardene's autobiography published in 1992 that he continued to have affection for India, despite the bad blood of the early 1980s. Dixit summed it up best: "I always felt that he had had an almost emotional feeling for India both in terms of the civilisational connections between India and Sri Lanka and his personal linkages with the freedom movement of India."

WASHINGTON, July 22: US Vice President Kamala Harris, endorsed by Joe Biden to be a new Democratic presidential nominee, has said that she intends to "earn and win" the nomination of the party and "do everything in my power" to unite the nation to defeat her Republican rival Donald Trump in November.

Harris, who received Biden's support to become the next Democratic presidential nominee after he quit the race for the White House, is poised to become the first Black woman and first Asian American to lead the ticket of a major American political party

Harris, 59, said she was "honoured" to receive Biden's endorsement and intends to "earn and win" the nomination of the Democratic Party

"I am honored to have the President's endorsement and my intention is to earn and win this nomination," she said in a statement. The historic endorsement came after Biden, 81, announced Sunday that he is dropping out of the race following weeks of disarray within the Democratic Party. Biden's disastrous first presidential debate with his Repub-



lican rival and former president Trump called into question his ability to win a second term and govern for another four years. Despite Biden's nomination. backing, it remains unclear whether Harris will become the nominee, or what process the Democratic Party would

take to select an alternative. Democratic National Committee chairman Jaime Harrison said in a statement that in the coming days the party will 'undertake a transparent and orderly process to move forward as a united Democratic Party with a candidate who can defeat Donald Trump in

November. Though Biden's endorsement almost seals her position as the presidential nominee of her party, Harris still needs to get elected by the party's delegates during the Democratic Convention in National

Chicago next month. Biden has won 3,896 delegates as against 1,976 required to win the party's presidential

In a move that would give her access to the campaign funds, the Biden-Harris campaign amended filings with the Federal Election Commission to rename its principal committee and declare Harris a candidate for president.

"I am honoured to have the President's endorsement and my intention is to earn and win this nomination." said Harris. who has been serving as US' first female, first Black and first South Asian vice president since 2021.

Rescuers search for dozens

of Gaza humanitarian zone

DEIR AL-BALAH, July 22: The Israeli military on Monday ordered the evacuation of part of an area in the Gaza Strip it has designated a humanitarian zone.

The military said it is planning to begin an operation against Hamas militants who have embedded themselves in the area and used it to launch rockets toward Israel. The area includes the eastern part of the Muwasi humanitarian zone, which is located in the southern Gaza Strip. Many Palestinians have been uprooted multiple times in search of safety during Israeli's punishing air and ground campaign

Earlier this month, Israel said it estimates at least 1.8 million Palestinians are now in the humanitarian zone it declared covering a stretch of about 14 kilometres (8.6 miles) along the Mediterranean. Much of that area is now blanketed with tent camps that lack sanitation and medical facilities and have limited access to aid, UN and humanitarian groups say. Families live in the midst of mountains of trash and streams contaminated by sewage.

The announcement came during delicate negotiations seeking a cease-fire in Gaza, with S and Israeli officials expressing hope that an agreement is closer than ever. A negotiating team will be sent to continue talks on Thursday, Prime Minister Benjamin Netanyahu's office said. Egypt, Qatar and the United States are continuing to push Israel and Hamas toward a phased cease-fire deal that would stop the fighting and free the hostages.

Netanyahu left Monday morning on a much-anticipated trip to the United States to meet with President Joe Biden, who announced Sunday that he will not seek another term, and address Congress

Netanyahu said that regardless of who becomes the next US president, "our enemies must know that Israel and the United States stand together tomorrow and always." He said he will thank Biden for more than 40 years of friendship, while also pushing him for more support on certain issues.

Also on Monday, Israeli police said a Canadian citizen was killed after threatening Israeli security forces with a knife near the Gaza border. The Israeli military said the man drove to

the entrance of an Israeli town close to the border, left his vehicle and approached the security forces with a knife. The forces opened fire and killed the man. There were no other iniuries

The attack took place at the entrance of the Israeli town of Netiv HaAsara, which is just 300 metres (yards) north of the Gaza border. On October 7, Netiv HaAsara was attacked and 20 residents were killed after gunmen passed over the concrete border wall using paragliders, according to Israeli military officials. Israel has experienced a wave of stabbing attacks across the country during the nine-month war in Gaza.

The war in Gaza has killed more than 38,900 people, according to the territory's Health Ministry, which doesn't distinguish between combatants and civilians in its count. The war began with an assault by Hamas militants on southern Israel on October 7 that killed 1,200 people, most of them civilians, and took about 250 hostages. About 120 remain held, about a third of them believed to be dead, according to Israeli authorities.

The Israeli military said on Monday that it is continuing to operate in central and southern Gaza. On Sunday, Israeli airstrikes killed at least 15 people, including women and children, in Gaza, according to hospital officials and a body count by an Associated Press journalist. The already precarious humanitarian conditions inside besieged Gaza have worsened with the discovery of the polio virus as water and sanitation services have deteriorated for the territory's 2.3 million people, most of them displaced. Traces of the virus were found in sewage samples in Gaza. The World Health Organisation has said no one has been treated for symptoms caused by the disease.

Israel's military said soldiers would be vaccinated and it would work with organisations to bring in vaccines for Palestinians.

Netanyahu has vowed to wipe out Hamas' military and governing capabilities and secure the return of the remaining hostages. Families of hostages and thousands of other Israelis have held weekly demonstrations to urge the prime minister to reach a cease-fire deal that would bring their loved ones home. (AP)

missing after flooding and a bridge collapse in China kill at least 25

BEIJING, July 22: Rescuers on Monday were searching for dozens missing after heavy rains caused flash flooding and a bridge collapse in different parts of China, killing at least 25 people.

Flash flooding tore through a village in southwestern Sichuan province in the middle of the night Saturday, and rescuers said 10 people died and they were searching for another 29 missing.

Days of heavy rain swelled the river that runs through the village of Xinhua in Hanyuan county. The water swept away 40 houses on the riverbank, according to local media, while also breaking bridges and cutting off roads.

In northwestern Shaanxi province, vehicles fell into a rushing river when part of a highway bridge collapsed on late Friday, and state broadcaster CCTV reported at least 15 deaths confirmed as of Monday.

Belarus' foreign minister will visit NKorea for possible talks on Russia cooperation

SEOUL, July 22: Belarus' foreign minister is to visit North Korea this week, the two countries announced on Monday, a trip expected to focus on discussions of trilateral cooperation involving Russia in the face of their separate confrontations with the West.

Belarusian Foreign Minister Maxim Ryzhenkov will come to North Korea on Tuesday for a threeday trip at the invitation of the North Korean Foreign Ministry, the North's official Korean Central News Agency reported in a one-sentence report. Belarus' Foreign Ministry issued a similar brief statement on his planned trip. Neither country provided details of Ryzhenkov's itinerary in North Korea, though observers say he's expected to meet his North Korean counterpart Choe Son Hui. Ryzhenkov would be Belarus' first foreign minister to travel to North Korea, according to South Korea's Unification Ministry. Koh Yu-hwan, a former president of South Korea's government-funded Institute for National Unification, said Ryzhenkov's meeting with North Korean officials will likely center on establishing trilateral North Korea-Belarus-Russia partnerships, because North Korea recently signed a major defense pact with Russia and Belarus has long-running close ties with Russia.

Belarus' authoritarian President Alexander Lukashenko, for his part, allowed Russia to use his country as a staging ground for the February 2022 invasion of Ukraine. In 2023, Russia also moved some of its tactical nuclear weapons to Belarus.

The three countries have been grappling with Western sanctions and deepening international isolation - North Korea over its advancing nuclear program, Russia over its invasion of Ukraine and Belarus over its support of the Russian invasion and its 2020 fraudulent election, as well as human rights abuses. During a meeting with Putin in the Black Sea resort of Sochi last September, Lukashenko suggested that Belarus could join Russia and North Korea in "three-way cooperation."

In April, the vice foreign minister of North Korea and Belarus met in Pyongyang and agreed to strengthen high-level contacts and visits, according to North Korea's state media. (AP)

ZAGREB, July 22: An assailant entered an elderly care home on Monday in central Croatia, killing and wounding several people, Croatian police said. Media reports said five people were killed.

The Index news portal said five people died immediately, while others were still receiving medical assistance.

The suspect fled the scene, but the police soon caught him in a cafe near the facility in the town of Daruvar, the report said.

Police said they were informed after 10 am Monday that a man using firearms killed and wounded several people at the nursing home.

The suspect is "under police supervision," said a statement by the regional police office.

The N1 regional television reported that the shooter was born in 1973, that he was a former fighter from the 1991-95 war in Croatia and a relative of one of the nursing home's residents.

Daruvar is a spa town and municipality in Slavonia, with a population of 8,500 people. Authorities are investigating the motive behind the attack. (AP)

Internet is down in B'desh despite apparent calm following protests



DHAKA, July 22: Bangladesh remained without internet for a fifth day and the government declared a public holiday on Monday, as authorities maintained tight control despite apparent calm following a court order that scaled back a controversial system for allocating government jobs that sparked violent protests.

This comes after a curfew with a shoot-on-sight order was installed days earlier and military personnel could be seen patrolling the capital and other areas.

The South Asian country witnessed clashes between the police and mainly student protesters demanding an end to a quota that reserved 30% of government jobs for relatives of veterans who fought in Bangladesh's war of independence in 1971. The violence has killed more than a hundred people, according to at least four local newspapers. Authorities have not so far shared official figures for deaths. There was no immediate violence reported on Monday morning after the Supreme Court ordered, the day before, the veterans' quota to be cut to 5%

On Sunday night, some student protesters urged the government to restore internet services. Hasnat Abdullah, a coordinator of the Anti-Discrimination Student Movement, told the Associated Press that they were withdrawing their calls for a complete shutdown, which they attempted to impose last week.

"But we are issuing an ultimatum for 48 hours to stop the digital crackdown and restore internet connectivity,"

he said, adding that security officials deployed at various universities should be withdrawn, student dormitories reopened and steps taken so students can return to their campuses safely. Abdullah also said they wanted the government to end the curfew and ensure the country was back to normal within two days. Students have also demanded some university officials to step down after failing to protect campuses.

Sarjis Alam, another coordinator of the Anti-Discrimination Student Movement, said that they would continue with their protests if all their demands weren't met. 'We cannot step back from our movement like a coward," he added. Another key organizer of the student protests, Nahid Islam, told reporters that the internet shutdown had disrupted their ability to communicate and alleged that authorities were trying to create divisions among protesters. "I am mentally traumatized ... our unity is being destroyed," he said.

The US Embassy in the capital Dhaka described Sunday the situation as "extremely volatile" and "unpredictable," adding that guns, tear gas and other weapons have been used in the vicinity of the embassy. They said the Bangladeshi army had been deployed and urged Americans to be vigilant, avoid large crowds and reconsider travel plans.

The protests have posed the most serious challenge to Bangladesh's government since Prime Minister Sheikh Hasina won a fourth consecutive term in January elections that the main opposition groups boycotted. Universities have been closed, the internet has been shut off and the government has ordered people to stay at home.

Protesters had argued the quota system was discriminatory and benefited supporters of Hasina, whose Awami League party led the independence movement, and wanted it replaced by a merit-based system. Hasina has defended the quota system, saying that veterans deserve the highest respect regardless of political affiliation. (AP)

SC's interim stay on Kanwar eatery order

NEW DELHI, July 22: Trinamool Congress MP Mahua Moitra and other opposition MPs on Monday welcomed the Supreme Court's decision imposing interim stay on directives passed by the Uttar Pradesh and Uttarakhand governments that stipulated eateries along the Kanwar Yatra route must display names of owners.

Moitra, one of the petitioners in the case, called the two governments' decision unconstitutional, and called the court order a victory for all Indians.

"We have just got a stay on the completely illegal and unconstitutional Kanwar Yatra order which UP had started... Muzaffarnagar Police, and then extended it to the whole of UP and parts of Uttarakhand," Moitra told PTI.

"It was requiring all shops and establishments along the Kanwar Yatra route to say the names of the owners and staff of the establishment. This was leading to religious discrimination," she said.

"We had filed against it. The Supreme Court had just stayed it completely, and there is no requirement for any eatery to have to display the names of their owners... It is a great victory for the Constitution, and for all people of India," Moitra added.

Samajwadi Party Chief Akhilesh Yadav alleged that the directive for eateries, as well as decision to allow government servants to participate in RSS activities, indicate the BJP's desperation. (PTI)

NEW DELHI, July 22: Asserting that Parliament is not for 'dal' but for 'desh'. Prime Minister Narendra Modi on Monday hit out at the opposition, saying that some parties have practised "negative politics" and "misused" Parliament to hide their political failures.

Speaking with the media ahead of the start of Parliament session, Modi said the Union Budget, which will be presented on Tuesday, will set the direction for the journey of the next five years and lay the foundation for fulfilling the dream of 'Viksit Bharat' in 2047.

Modi said people have given their verdict in the Lok Sabha polls and now all political parties must fight together for the country for the next five years.

"I want to tell all MPs, they may be of any party, that from January onwards we fought a pitched electoral battle, we conveyed to the people what we wanted to convey, some showed the way while others misled, but that period is over now. The people have given their verdict," he said.

"Now it is the responsibility of all elected representatives and that of all political parties that we have fought for our respective parties and now for the next five years, we have to fight for the country and strive for it," Modi said.

The prime minister urged political parties to rise above party lines and make use of the platform of Parliament for the next four to four-and-ahalf years.

"In January, 2029, when it will be an election year, then you can go into the poll field, even make use of Par-



liament for it. Play the games you want to for those six months but till then, work for empowering the poor, farmers, youth and women by building a movement of people's participation to fulfil the dream of 2047," Modi said

"I say with a lot of sadness that after 2014, some MPs were elected for 5 years, some for 10 years, but many MPs did not get a chance to talk about their constituency and share their views in Parliament because of the negative politics of some parties that misused Parliament to hide their political failures," he said. Modi urged all parties to give a chance to first-time MPs to speak in

Parliament and give opportunities to them. "You would have seen that in the first session of this Lok Sabha. An undemocratic attempt was made to scuttle the voice of the government that had been ordered by 140 crore

Indians to serve. For two-and-a-half hours, attempts were made to scuttle the voice of the prime minister and such a thing has no place in democratic traditions. They have no remorse over it," Modi said

His remarks were an apparent reference to the incident in the last session when Modi delivered his reply to the debate on the Motion of Thanks on the President's address amid vociferous protests and sloganeering by the opposition that was demanding that both MPs from Manipur be allowed to speak.

"People have sent us here for desh not dal. This Parliament is not for 'dal (party)' but for 'desh (country) This Parliament is not limited to MPs but it is for 140 crore people of the country," he asserted.

Modi hoped that all MPs will contribute to the debate.

He said there was nothing wrong with opposing views but it was the

Cong's 'raj dharma' jibe at PM, BJP after SC stays Kanwar Yatra directive

NEW DELHI, July 22: The Congress Monday welcomed the Supreme Court stay on Uttar Pradesh and Uttarakhand governments' orders asking eateries on the Kanwar Yatra routes to display the owners' names, and said the party hopes Prime Minister Narendra Modi makes BJP chief ministers aware of their "raj dharma".

The Supreme Court on Monday ordered an interim stay on the directives issued by the two BJP-ruled states. They had asked eatery owners along the Kanwar Yatra routes to display the names of their owners, the staff and other details, a move the opposition has claimed is intended to promote religious discrimination. Issuing notice to the governments of Uttar Pradesh, Uttarakhand and

Madhya Pradesh, where the Ujjain municipal body has issued a similar directive, a bench of Justices Hrishikesh Roy and SVN Bhatti, however, said eateries may be required to display the kind of food they are serving like they are vegetarian or non-vegetarian.

Reacting to the development, Congress' media and publicity department head Pawan Khera said, "We welcome the stay given by the Supreme Court on the completely unconstitutional orders by the Uttarakhand, Uttar Pradesh and Madhya Pradesh governments wherein

they have asked all shop keepers, eateries and street venders to put their name and identity on boards outside especially during the Kanwar

Yatra. This was unconstitutional and

"We are very happy that the Supreme Court has given such a strong order and we hope that the prime minister makes his chief ministers aware of their 'raj dharma (solemn duty)'. Unfortunately, he is the same PM, who when he was the chief minister of Gujarat, then prime minister Atal Bihari Vajapyee asked him to follow 'raj dharma' but he defied Atal ji," Khera said in his video statement.

"We hope his CMs don't defy him. Although the prime minister's position in his party is considerably weakened, we hope he retrieves that position and asserts himself and stops his chief ministers from indulging in such unconstitutional measures," he said.

A large number of devotees travel from various places with 'kanwars' carrying holy water from the Ganga to perform 'jalabhishek' of Shivlings during the Hindu calendar month of 'Shravan'. Many believers shun consuming meat during the month they consider holy.

The significant order comes amid an escalating row over the directives, with even BJP ally Rashtriya Lok Dal (RLD) joining the chorus for their withdrawal and opposition parties resolving to raise the issue in Parliament.

The opposition has alleged that the orders were "communal and divisive" and intended to target Muslims and Scheduled Castes by forcing them to reveal their identity, but the BJP maintained that the step has been taken keeping in mind law and order issues and the religious sentiments of pilgrims. (PTI)

Displaying names not mandatory for shopkeepers along Kanwar Yatra route: MP govt

BHOPAL, July 22: The BJP government in Madhya Pradesh has clarified that it has not issued any instructions requiring shop owners to display their names along the Kanwar Yatra route in the state, and there is no such compulsion.

Amidst a row in Uttar Pradesh over a directive to highlight shop owners' names on eateries along the Yatra route, the MP government has asked urban bodies to refrain from spreading any confusion.

A statement was issued by the Urban Development and Housing Department (UDHD) on Sunday night, days after the Ujjain mayor claimed shop owners had been directed to display their names and phone numbers on boards.

No instructions have been issued at the state government level regarding writing the names of shop owners on boards of their establishments along the Kanwar Yatra routes in urban areas, the UDHD stated.

Ujjain mayor Mukesh Tatwal last week cited a purported decision of the mayor-in-council

dated September 26, 2002, and claimed a proposal asking shopkeepers to display their names had been approved.

He claimed the approval was forwarded to the state government for objections and all formalities have been completed.

Stating that such reports are inaccurate, the UDHD instructed urban bodies to avoid spreading confusion regarding directives to shop owners along the Kanwar Yatra route, emphasising that Madhva Pradesh Outdoor Advertisement Media Rules, 2017, do not compel shop owners to display their names on boards.

"Boards can be put up on shops under the Madhya Pradesh Outdoor Advertisement Media Rules, 2017. There is no compulsion to display the name of the shop owner on these boards," the UDHD stated.

Following the mayor's comments, the Ujjain Municipal Corporation also confirmed that no proposal is in place to mandate the display of names and phone numbers on shop boards in the city.

Separately, BJP MLA Ramesh Mendola had written to Chief Minister Mohan Yadav, expressing support for shop owners to proudly display their names. Mendola argued that the display of names is a matter of personal pride and customer right, and not something to be mandated or discouraged.

"Every small and big trader, businessman, and shopkeeper in Madhya Pradesh will experience a sense of pride in telling their names,' the MLA stated.

In Uttar Pradesh, the controversy began when Muzaffarnagar police ordered eateries along the Kanwar Yatra route to display owners' names to avoid confusion. This directive has faced criticism from opposition parties and some ruling alliance members who argue that it unfairly targets Muslim traders.

The BJP government in UP extended this order statewide on Friday, while Uttarakhand Chief Minister Pushkar Singh Dhami said similar instructions are already in place in his state. (PTI)

Cong calls eco survey 'cherry-picked' view, says India in its most precarious economic situation

NEW DELHI, July 22: The Congress alleged on Monday that the Economic Survey released by the government presented a "cherry-picked" view of the economy and claimed that India is experiencing its "most precarious and difficult" economic situation in many years.

Finance minister Nirmala Sitharaman presented the Economic Survey 2023-24, along with the statistical appendix, in the Lok Sabha on Monday. The Economic Survey is an annual document presented by the government ahead of the Union Budget to review the state of the economy

Congress general secretary in-charge communications Jairam Ramesh said the need of the hour is a right to apprenticeship, protections for gig workers and unorganised sector workers, minimum wage hikes to Rs 400 per day, an end to "tax terrorism" and an expansion of social-protection schemes like the one for anganwadis.

"The Economic Survey of 2023-24, released in advance of tomorrow's Budget, must have been a difficult document for the non-biological PM's spin doctors to produce. It does its best to present an 'all is well' rosy picture of the economy. Unfortunately for the PM and for the people of India, the economic situation is so desperate that some harsh facts come through anyway," Ramesh said in a statement.

Food inflation remains unchecked, at nearly 10 per cent per year, with prices of specific foods growing at a rapid pace -- cereals at 11 per cent, vegetables at 15 per cent, spices at 19 per cent and milk at 7 per cent -- he said.

claimed Since 2014, imports from China have risen from 11

per cent of the overall imports to 16 per cent, the former Union minister said, adding that the uncontrolled dumping of these imports has rendered domestic MSMEs uncompetitive, forcing them to shut down.

"Housing, a critical sector, has also done poorly. In 2023, residential real estate sales in India are only now reaching back to the levels witnessed in 2013," he said. Ramesh claimed that the Economic Survey virtually admits the failure of the Centre's policymaking with regard to generating private investment.

"The Modi government's approach to the corporate sector has been to give generous handouts -- like the Rs 1.5 lakh crore corporate tax cut and the Rs 2 lakh crore PLI -- without directly incentivising investment or hiring," he said.

Thus, while the sops have contributed to record profitmaking, private investment has not risen, Ramesh said. "According to the economic survey, private sector GFCF in machinery and equipment and intellectual property products has grown cumulatively by only 35 per cent in the four years to FY23.... This is not a healthy mix,' he said

Modi suppressed voice of country for 10 years: Cong hits back at PM for his criticism of Oppn

NEW DELHI, July 22: The Congress hit back at Prime Minister Narendra Modi on Monday over his remarks criticising the opposition, alleging that it was he who "suppressed the voice" of the country for 10 years and for which people "punished" him in the Lok Sabha polls.

Talking to reporters ahead of the start of a Parliament session, Modi said in the first session of this Lok Sabha, "an undemocratic attempt was made to scuttle the voice of the government that had been ordered by 140 crore Indians to serve".

"For two-and-a-half hours, attempts were made to scuttle the voice of the prime minister and such a thing has no place in democratic traditions. They (opposition) has no remorse over it," he said.

Hitting back at Modi over his remarks, Congress's media and publicity department head Pawan Khera said the person who "throttled the country and suppressed its voice" for 10 years, today looked "very weak and was seen weeping" when the opposition raised its voice.

The prime minister started the Monsoon session by making a comment on the opposition that was not befitting of his post, Khera said

"He said the opposition throttled the voice of the prime minister for two-and-ahalf hours. It is important to remind Prime Minister Modi that during his unjust rule of the last 10 years, the entire country was suffocated, for which the public has punished him," he said in a post in Hindi on Х.

"Prime Minister Modi has forgotten that he is not the prime minister of a majority government, but the 'one-third' prime minister of an NDA government run with the support of two parties," he added.

He should also avoid using the term Modi government and prove himself to be democratic, the Congress leader said.

"It would be appropriate to remind Prime Minister Narendra Modi that when he was giving this speech, the Supreme Court was hearing a case against suppressing the voice of 32 lakh students of the country and the injustice done to them by his government," Khera said, referring to the National Eligibility-cum-Entrance Test (NEET) issue

"When you were giving your speech full of arrogance and lies, it is important to tell you that more than 15 Agniveers of the country have been forced to commit suicide with the dream of sacrificing their



lives for the country in their hearts," the Congress leader said.

Every hour, 19 farmers and labourers in the country are forced to commit suicide by hanging themselves, he claimed.

"You are right prime minister, Parliament is for the country. It is not the court of any king. Therefore, the opposition is forced to raise the voice and the pain of youngsters, farmers, soldiers, labourers, women, backward, Dalits, tribals and the poor people of the country in Parliament," Khera said.

"It is our parliamentary duty to repeatedly interrupt and stop you so as to raise the voice of the country. You too must understand that it is important to leave everything aside and listen to the questions related to the immediate needs and problems of the country," the Congress leader said.

"The country has now given you a third chance to speak its mind. Run the country's Parliament, do not create a royal court of Sengol," he added.

Congress's deputy leader in the Lok Sabha Gaurav Gogoi hit out at the prime minister, saying the NEET issue was listed as the second topic in Monday's Question Hour, but Modi stood up and walked away before that.

"Why did he go? Was it not his responsibility to give an answer on the issue? When we demanded the education minister's resignation, he (Dharmendra Pradhan) arrogantly said why would he resign when he has been appointed as the education minister by Prime Minister Modi," Gogoi told reporters outside Parliament.

Hitting out at Modi for his remarks, the Congress's whip in the Lok Sabha, Manickam Tagore, said the prime minister should practise what he preaches by doing positive things.

"He says something else outside and does something else inside the House,' Tagore alleged. (PTI)

SC dismisses plea to allow arrested political leaders to campaign virtually

NEW DELHI, July 22: The Supreme Court on Monday junked a plea seeking its direction for allowing arrested political leaders to campaign during elections virtually.

A bench of Justices Surya Kant and Ujjal Bhuyan refused to interfere with the Delhi High Court order which had dismissed the petition. "This petition has been filed with mala fide intent. It is concentrated on one politician (Arvind Kejriwal) who is every day before this court with a battery of the best laywers. "We do not deem it necessary to entertain this petition purportedly filed in public interest. Dismissed," the bench said. The top court was hearing a plea filed by Amarjeet Gupta, a law student, seeking permission for arrested political leaders to campaign through the virtual mode. (PTI)

IT industry exerting pressure on govt to extend working hours of employees, says Santosh Lad

BENGALURU, July 22: Karnataka labour minister Santosh Lad on Monday said the proposal to extend the working hours of employees in the IT/ITeS/BPO sector has come from the IT industry, and the government will take a decision after looking into opinions shared by all stakeholders including leaders in the field and employees.

Stating that the IT employees union has expressed their dissent, he urged industry veterans and captains to also come out and share their views.

The proposed 'Karnataka Shops and Commercial Establishments (Amendment) Bill 2024' seeks to normalise a 14hour work day. The existing act only allows a maximum of 10 hours work per day including overtime

"It is not the minister who has brought himself (the proposed bill). The industry is pressurising. (They) are asking and they want it. Since there is pressure from the industry, the bill has come to us. We are still evaluating it at the Labour department. The question is for all the heads of the industry to discuss this," Lad said.

Speaking to reporters here, he said: "The matter is in open do-



main, people are free to discuss this. They (industry leaders) express (opinion) for every thing, so I want all the big heads (of the industry) to debate and express their view. There is dissent from IT employees. I want people to have their opinion. Based on that as a department we will look into what has to be done.'

Karnataka State IT/ITeS Employees' Union (KITU) that has urged the Siddaramaiah-led government to reconsider the plans to extend the working hours,

strongly opposing the proposed amendment which. it said, poses an "attack on the basic right of any worker to have a personal

This amendment will allow the companies to go for a two shift system instead of the currently existing three shift system, and one third of the workforce will be thrown out from their employment, it claimed.

To a question on the impact of this proposed extended workers on the health, social and personal

life of the employees, the Minister said: "Let the IT heads, the socalled big heads of the country, discuss. For everything they come out. I want the IT heads, IT company owners, Directors -- let them come and share their opinion, whether it is required or not. The dissent is coming from the week.

union, let the IT industry people, the heads have to speak about it positive or negative, and the government will look into what has to be done.'

The IT industry is pressuring the government to go ahead with the proposal, he said. "Without their consent why would we do it suo moto. It is not done by any department, nor by the IT Minister. The pressure is from the IT industry itself, and that's how the proposal has come to us."

Asked as to why the government cannot say that they will not act on the proposal, considering the adverse impact it will have on the employees, the Minister said: "the government has done nothing. The proposal has come from the IT industry, it is good that it is in the public domain, definitely the government and my department in its wisdom will definitely take a call, but let people give their opinion.

Suhas Adiga, General Secretary of the Karnataka State IT/ITeS Employees Union, citing various reports regarding health implication of this proposed move, said as per the current understanding the employees might have to work 80-85 hours in a

"This cannot be accepted under any circumstances. We call upon all IT/ITeS Employees and their dependents or family members to come out and resist this," he added. Targeting the government on the issue, state BJP President B Y Vijayendra said the Congress government in Karnataka has not only made a mockery of themselves but is "leaving no stone unturned to destroy everything in its way.'

"While the Siddaramaiah govt itself is in a sleeping mode, it plans to propose a bill that will force the IT sector to work 14 Work Hours A Day, 70 A Week," he posted on 'X'.

Raising massive financial resources for net-zero goal unprecedented challenge: Economic Survey

an investment support of USD 1.4 trillion -- an average of USD 28 billion per year -- to become a net-zero economy by 2070 and raising financial resources for adaptation and mitigation action of this scale is an "unprecedented challenge", according to the Economic Survey 2023-24 tabled in Parliament on Monday

Reaching net zero means achieving a balance between greenhouse gas emissions and the amount of these gases removed from the atmosphere by either natural processes, such as photosynthesis, or by other methods of carbon capture and storage. The consolidated report on the state of the economy in the previous year said India's climate action has been largely financed through domestic resources and the flow of international finance has been "very limited".

Citing the Reserve Bank of India's (RBI) data, the report said bridging the "substantial funding gap" necessitates allocating 2.5 per cent of India's annual Gross Domestic Product (GDP) to green finance.

"Preliminary estimates indicate that the aggregate investment support required by India to achieve its 2070 net-zero target will be USD 1.4 trillion at an average of USD 28 billion per year. Raising financial resources for climate change adaptation and mitigation actions of this scale is an unprecedented challenge," the document read. A 2022 report by the Climate Policy

Initiative found that domestic sources accounted for the majority of green finance in India. at 87 per cent and 83 per cent in financial years 2019 and 2020 respectively.

While international sources are increasing (from 13 per cent in FY 2019 to 17 per cent in FY 2020), the economic survey said they are still insufficient to meet India's net-zero target. "Mobilising substantial capital from

traditional sources presents multifaceted challenges in emerging economies like India. The perceived sovereign risks associated with emerging market and developing economies (EMDEs) and the capital-intensive nature of such projects, coupled with lengthy gestation periods and evolving regulatory frameworks, can create misalignment between investor expectations and project timelines," the government said



The economic survey also noted that the flows of global capital to developing countries have been impeded by high costs of capital. Despite securing a good rating on

its green-bond framework, Indian sovereign green bonds have hardly received any "greenium" from private investors. It is more a "wall of capital" than a "flood of capital" that is waiting to fund energy transition in EMDEs. It is just not mobile. All of these together have severely hampered the flow of finance for green-transition projects, the survey said.

"Greenium" or green premium refers to the savings an issuer of a green bond realises on the associated coupon payment because the bond is green

Financial support to help middle-income and poor countries fight climate change will be at the centre of this year's UN climate conference in Baku, Azerbaijan, where the world will reach the deadline to agree on the New Collective Quantified Goal (NCQG) -- the new amount developed nations must mobilise every year starting 2025 to support climate action in developing

But achieving consensus will not be

easy, given the disappointing progress made on major conflict points at the mid-year UN climate talks in Bonn, Germany

At the 2009 UN climate conference in Copenhagen, rich nations pledged to provide USD 100 billion annually from 2020 to help developing countries mitigate and adapt to climate change. However, delays in achieving this goal have eroded trust between developed and developing nations and have been a continual source of contention during annual climate negotiations

In May, the Organisation for Economic Cooperation and Development (OECD) claimed that developed countries had met the long-standing USD 100 billion-a-year promise by providing nearly USD 116 billion in climate finance to developing countries in 2022, with nearly 70 per cent of the money given in the form of loans. However, international non-profit

organisation Oxfam last week said climate finance provided by rich countries in 2022 totalled no more than USD 35 billion. (PTI)

Officials said it is in touch with the Border Guard Bangladesh (BGB) to coordinate the safe evacuation of students, even during night-time operations.

The BSF has successfully assisted in the return of 572 Indian students, 133 Nepalese students and four Bhutanese students so far, the border guarding force said in a statement

"Amid this unrest, many Indian, Nepalese and Bhutanese students studying in various educational institutions in Bangladesh are being sent back to their countries. The BSF South Bengal Frontier has set up special help desks at ICP Petrapole, LCS Gede, Ghojadanga, and Mahadipur to facilitate the safe return of these students," a BSF statement said.

"The BSF is in constant touch with BGB. This coordination has ensured the safe evacuation of students even during nighttime oper-

Heavy rain in Mumbai, NDRF teams deployed; local train services partially hit

MUMBAI, July 22: Heavy rains continued to lash Mumbai on the second consecutive day on Monday, with some areas receiving up to 34 mm of rainfall in just one hour in the morning, affecting local train services during the rush hour between Kalyan and Thakurli stations of the Central Railway network.

In the last 24 hours ended at 8 am, the island city recorded an average of 135 mm of rainfall, eastern Mumbai 154 mm, and western Mumbai 137 mm, officials said

Three teams of the National Disaster Response Force (NDRF) have been deployed in Mumbai to tackle any situation amid the forecast of a high tide and heavy rains in the city and its suburbs.

In its forecast for the next 24 hours starting at 8 AM on Monday, the Indian Meteorological Department (IMD) has predicted "heavy to very heavy rain in the city and suburbs, with the possibility of extremely heavy rainfall at isolated places." According to the civic body, a high tide of 4.59 meters is expected at 12.59 PM.

Malabar and Mulund Hill recorded 34 mm of rainfall between 6 am and 7 am, followed by Bhandup with 29 mm, Wadala East with 24 mm, and Versova with 20 mm.

Western Railway stated that local train services were running normally on Monday morning, however, commuters claimed trains were running late by 5 to 10 minutes.

Central Railway also stated that local services on all four corridors were normal. Commuters, however, said train traffic was affected between All airport operators to conduct

Kalyan and Thakurli stations in the morning rush hour due to a signal problem. "Many commuters are walking on the tracks as

trains are halted for a long time," a passenger said A civic official said buses of Brihanmumbai

Electric Supply and Transport (BEST) were not diverted.

A day earlier, heavy downpours pounded Mumbai and suburbs, inundating roads in many areas, diverting flights, and briefly affecting local train traffic between Dadar and Matunga stations. The Mithi River, which originates in Sanjay Gandhi National Park and meets the Arabian Sea at Mahim, swelled due to continuous rainfall in Mumbai since Sunday. It was flowing at 1.5 meters on Monday morning, but its flood level reached 2.26 meters Sunday night.

In other parts of Maharashtra, Konkan and Vidarbha regions have been receiving heavy rainfall since the weekend, causing rivers to swell and low-lying areas to submerge. As a result, National Disaster Response Force (NDRF) teams have been deployed in Mumbai and other parts of the

DELHI, July 22: The government on Monday said all airport operators have been directed to carry out a third party audit of structural stability of airport buildings and associated infrastructure.

Besides, they will conduct a thorough evaluation of all civil, electrical and technical aspects of the buildings before the onset of monsoon every year. The directives came in the wake of roof collapse incidents at three airports last month. During heavy rain, forecourt canopy collapsed at Terminal 1D of the Delhi airport on June 28. Also, the kerb area canopy made of tensile fabric, a non-structural element, was damaged at Jabalpur and Rajkot airports on June 27 and 29, respectively.

In 2023-24, an amount of Rs 795.72 crore has been spent on Repair and Maintenance (R&M) works at 121 airports of the Airports Authority of India (AAI), as per official data submitted to the Rajya Sabha on Monday.

Meanwhile, Civil Aviation Minister K Rammohan Naidu told the Upper House that the ministry has constituted a high-level expert committee consisting of structural engineers from IIT Delhi to assess the incident at the Delhi airport and submit its report.

"Further, all the airport operators have been directed to carry out a third party audit of structural stability of airport buildings and associated infrastructures through a reputed government institution/body such as IITs, NITs, CBRI, EIL etc.

"All the airport operators have

also been directed to carry out a thorough evaluation of all civil, electrical and technical aspects of the building, including the design, specifications and workmanship of the roof sheeting structure before the onset of monsoon every year," the minister said in a written reply. Aviation regulator DGCA carries out regular audits in the form of surveillance inspections/spot inspections to ensure compliance to these standards.

In a separate written reply, Minister of State for Civil Aviation Murlidhar Mohol said the Airports Authority of India has initiated investigations to determine the root cause of incidents at Jabalpur and Rajkot airports.

Barring the Covid years, expenditure on Repair and Maintenance (R&M) activities in absolute terms at the airports has increased, Mohol said in another written reply while providing expenditure details for R&M activities at AAI airports.

"Expenditure on repair and maintenance as a percentage of revenue is not an appropriate metric to assess movement of the expenditure over a period of time since revenue can increase owing to various factors which have no bearing on the R&M expenses.

. alternatively, R&M expenses can also increase due to various factors (i.e. life of the assets, normal wear & tear, annual maintenance contract/ comprehensive maintenance contract costs charged by vendors etc) which may not affect revenue," the minister said. (PTI)

The authorities and the state government must trace my father. The social media post featuring the advertisement has now been deleted," Bharat Tambe, an eatery owner, told PTI on Monday. We had not filed a complaint

earlier as my father had the habit of going to homes of relatives without informing anyone. He used to return in a few days. There is a possibility this photograph has been taken from the wari (foot march of Lord Vitthal devotees) from Alandi to Pandharpur," he said.

Shikrapur police station senior inspector Deepratan Gaikwad said two teams have been formed to trace Dnyaneshwar Tambe after the missing person complaint was lodged.

"Our focus is on Pandharpur and Alandi since the family suspects the photograph was taken during wari. We will also check how the photo appeared on the advertisement for more leads," Gaikwad said.

After reports of the missing man appeared in a section of the media, the state government issued a clarification claiming the advertisement was not released by it nor was it posted through any government linked social media account.

NEW DELHI, July 22: Over 170 employees at the National Testing Agency (NTA) are either contractual or outsourced staff, the Ministry of Education (MoE) informed the Parliament on Monday.

The ministry, however, clarified that "all core activities involving setting up of question papers" for the exams conducted by the agency are not outsourced.

Union Minister of State for Education Sukanta Majumdar shared this information in response to a written question in the Lok Sabha asked by Dravida Munnetra Kazhagam (DMK) Member of Par-(MP) Kanimozhi liament Karunanidhi

The DMK MP asked about number of permanent staff, employees on deputation and contractual employees working at the NTA.

"Director General (DG) of NTA is appointed by Central Government under the Central Staffing Scheme. In addition, the number of employees working on deputation in NTA are 22 at present. The number of contractual employees are 39 and

outsourced staff or employees are 132. One employee is absorbed in NTA from his parent department," the minister said.

Asked about details regarding the tasks that have been outsourced by the NTA to other entities. Majumdar said that considering the sensitivity involved in competitive examinations, various operational and security measures are undertaken for

their smooth and fair conduct. "Such measures involve engagement of specialised or experienced agencies for providing services like capturing of biometric, frisking, CCTV surveillance, AI analytics with a view to identify any potential impersonation, exam delivery, etc.

"However, it is pertinent to mention that all core activities involving setting up of question papers are not outsourced," the minister said.

The NTA is under scanner over alleged regularities in various competitive examinations including paper leaks. The Centre had last month set up a high-member panel to review functioning of the NTA and suggest examination reforms. (PTI)

On Sunday, the Supreme Court of Bangladesh scrapped most job quotas that caused deadly unrest in the country, scaling down government jobs for veterans' descendants to 5 per cent, ruling that 93 per cent be allocated on merit. Nipah: Contact list of deceased boy updated, more tests being conducted

KOZHIKODE, July 22: The number of people at risk for contracting Nipah in the contact list of the 14-year-old boy who lost his life to the rare infection, has been increased to 350, out of which 101 are in the high-risk category, health minister Veena George said on Monday. The Kerala Health Department is waiting for

the test results of 13 people, whose samples were sent to the Kozhikode Medical College virology laboratory and the Advanced Virology Institute at Thiruvananthapuram for testing. "Out of the samples sent for testing, six of the persons have symptoms. Three of them are on the secondary contact list. Even though the parents of the deceased boy do not have symptoms, we have sent their samples also for testing to rule out all possibilities," she said.

The health department said two of the persons on the contact list are from Palakkad, while four are from Thiruvananthapuram. The two from Palakkad are working in a private hospital, while the four from Thiruvananthapuram have reached Perinthalmanna for treatment



The minister added that the friends of the deceased child have informed them that he had consumed a fruit from a nearby property in Pandikkad panchayat, where the presence of bats has been detected.

The 14-year-old boy from Kerala's Malappuram who was under treatment here for Nipah infection died on Sunday morning.

Minister George said that counselling will be given to the friends of the deceased child to help them cope with his loss, and that their classes will be held online.

->

The department has released a detailed route map of the boy's movements and has asked the people who are suspected to have come into contact with him to contact the health department and seek treatment.

"As of now, that locality is the primary source of infection, but it can be confirmed only after scientific examination. A team from the NIV, led by Dr Balasubramanyam will reach Kerala today (Monday) to observe the bats and their habitat in the areas," George said. Meanwhile, a team from ICMR has already reached Kerala.

A total of 224 fever surveillance teams have been deployed, the health minister said, adding that they were conducting surveys across the houses in Pandikkad and Anakkayam panchay-

"Eighty teams are in Anakkayam, while 144 are in Pandikkad panchayat. A team of the Animal Husbandry Department is conducting a field survey and observing the health condition of pets and livestock," the minister said.

În a statement, chief minister Pinarayi Vi-

jayan had exhorted everyone to work together to combat the Nipah virus and implored citizens not to destroy the natural habitats of bats.

He had also cautioned people against eating fruits half-bitten by animals and those found abandoned and also to avoid consuming the nectar found in plantain flowers.

In case humans have had any contact with bats, their excreta, have been bitten. he said should wash their hands with soap or use sanitiser immediately. They should contact the Nipah control room for clarification if needed, the CM added.

The state government had announced recently that a special action calendar was being prepared for the prevention of a Nipah outbreak, which has haunted the state on four occasions in the past.

Nipah outbreaks have been reported in Kozhikode district in 2018, 2021 and 2023 and in Ernakulam district in 2019. The presence of Nipah virus antibodies had been detected in bats in Kozhikode, Wayanad, Idukki, Malappuram and Ernakulam districts. (PTI)

If you liked 'The Diplomat', you're going to love season two: actor David Gyasi

MUMBAI, July 22: Actor David Gyasi, who starred opposite Keri Russell in "The Diplomat", says the show writers are working on creating a great season for viewers who loved the Netflix series.

Gyasi plays Austin Dennison, UK Foreign Secretary, to Russell's Kate Wyler, the newly appointed US ambassador to the UK. They must work closely to find those responsible behind the attack on a British aircraft carrier in the Persian Gulf that has killed 41 sailors in the series, which premiered in April last year to great reviews.

Asked about the pressure to do better in the next season, Gyasi told PTI, "We are fortunate that the writers are in the writing room so the pressure would be with them but we obviously get to see the scripts and I'm like, 'Oh my lord, this is really good'

The actor, 44, said while he cannot reveal much, he is looking forward to the second season like the fans of the show.

"I'm just excited for people to see season two, if you liked season one, you're going to love season two," he said.

Gyasi, who featured in films like "Cloud Atlas", co-directed by the Wachowskis and Tom Tykwer, Christopher Nolan's "Interstellar", Alex Garlandhelmed "Annihilation", has worked as a voice actor for

audio series, "Impact Winter" season three.

The series, a dystopian drama about survival, is set in a near future where a comet impact has blotted out the sun, enveloping the Earth in perpetual winter. Vampires have emerged from the shadows to rule supreme. Season two came out in 2023 while the third season premiered on Audible on July

The actor said he has always liked how "science fiction allows for metaphor" to talk about situations in the world without alarming people.

"If you get it right, maybe you can incite discussion and debate and think about how that relates to our world, and what can we do in our world to make it better or peaceful or prevent that sort of hate or exclusion from happening.

"Through studying, reading, and meeting different types of people, I've often found that (I) often searched for work that somehow taps into what I'm experiencing as I walk around the world and what I see and weirdly science fiction kind of does that a lot."

Giving the example of "Interstellar", Gyasi said the film talked about environmental neglect and the potential consequences of our actions.

"Interstellar' was about 'How are we going to save the people

on Earth?' It starts with a sort of crop destruction and focuses on the environment and how we've not treated the planet so well. So, we're in a situation where a group of professionals must travel to find a solution.'

As the world grappled with COVID-19, the dystopian theme of "Impact Winter" resonated deeply with audiences, said the actor.

"If we're not careful we could head to environmental issues, and then people hating one another, wars creeping up all over the place, and rise of segregationist rhetoric that is around. 'Impact Winter' taps into that sort of zeitgeist at the moment and perhaps it's a testament to that timing," he said, crediting writer Travis Beacham for creating an interesting series.

The actor said working on 2012's "Cloud Atlas" was a dream job and a "real affirmation" from Hollywood that he could be a part of the industry. But just before his next big project, "Interstellar", came out, he was without any work for a year as he was recovering from an injury.

"(Then) This kind of juggernaut of a movie comes out and does really well and I get to experience that and work with one of the greatest filmmakers of our time. To get up close and personal with his (Nolan) work

ethic, with his approach to family, which I found really key and interesting because his work ethic professionally is so high... I don't think I've seen it before," he said of his experience working on the 2014 movie

Gyasi said as someone who is very close to his family, it was a learning to meet a person like Nolan, who is focused on work while also being close to his family.

... I thought that was an interesting set of priorities. I learned that and it was encouraging. I'm a huge fan of my family and I want to go on adventures, and do all of these things. I'm dedicated to my work as well. So, it was nice to see the two things run alongside each other and complement one another," he said.

The actor, who also has a production company, hopes to get behind the camera in the near future.

"I've not directed yet. We've produced a couple of things but I've not directed yet largely because I haven't had the time and also there's been some stimulating acting projects that I've been involved with recently and currently involved. I don't have the space in my head to direct just yet, but I could see it coming over the next couple of years," he said. (PTI)

India registered convincing wins in their first two matches of the continental tournament, beating traditional rivals Pakistan and United Arab Emirates by seven wickets and 78 runs respectively to put one foot in the semifinals

Minnows Nepal hardly have any time to recover from the thrashing they received at the hands of Pakistan in their previous outing on Sunday, the same day when the tournament's overwhelming favourites and defending champions India bulldozed the hapless Emirates side. While India are primed to enter the last-four, Pakistan improved their net run rate with the comfortable win over Nepal lifting them to the second spot in Group A.

India will, however, not be bothered by how the other teams are doing and will look to sustain the momentum they have gained with two convincing victories heading into the semifinals. India have flexed their muscles in both batting and bowling so far in the tournament, and are likely to continue in the same vein come Tuesday.

Wehrlein crowned Formula

E champion after thrilling

LONDON. July 22: Pascal with a puncture. Wehrlein of Porsche withstood relentless pressure from Mitch Evans and Nick Cassidy of Jaguar to win his maiden Formula E world championship at the season-ending London E-Prix here. The dramatic conclusion unfolded on Sunday when Wehrlein's triumph exemplified Season 10's year of intense racing. The season finale saw three

contenders - Wehrlein, Evans, and Cassidy – entering the final round separated by just seven points. Cassidy, who led the championship going into the weekend, demonstrated remarkable resilience, rebounding from a disappointing performance in Portland and a challenging Saturday qualifying session in London.

Starting 15th in the first race, he managed to finish seventh, before earning pole position for the second race on Sunday morning. Cassidy led the field as teammate Evans overtook Maximillian Gunther (Maserati) for second place at Turn 1.

An early Safety Car period allowed Wehrlein to pass Gunther, placing all three title contenders in the top-three positions by Lap 6. Jaguar seemed to dominate, with their drivers battling for the

championship. However, internal tensions surfaced during Cassidy's Attack Mode activations, with Evans and Cassidy jostling for position and Wehrlein capitalising on their discord. Oliver Rowland, starting from ninth, surged to fourth by Lap 29 and overtook Cassidy for third, triggering a collision with Gunther that ended Cassidy's race

This left the championship fight to Wehrlein and Evans as the Safety Car reappeared. With less than eight laps to go,

both Evans and Wehrlein needed to activate their remaining Attack Mode boosts. An invalidated attempt during the caution period handed Rowland the lead, but a Safety Car infringement forced him to relinquish it to Evans.

The Kiwi's subsequent Attack Mode activation failed, returning the lead to Rowland.

On Lap 34, Evans successfully activated his boost, but Wehrlein's strategic Attack Mode activation allowed him to overtake, leaving him a clear run to the finish and secure the drivers' title.

Evans, unable to maintain his pace, finished as the championship runner-up once again.

Rowland comfortably claimed the final race victory of Season 10, while Wehrlein's second-place finish secured his maiden title by a seven-point margin over Evans. Cassidy finished third in the standings. Despite the setback for the drivers' championship, Jaguar celebrated their first top-tier mo-

torsport title since 1991 by lifting the team trophy. In a double victory for Jaguar, the British team also secured the inaugural manufacturers' trophy, narrowly edging out Porsche by four points. PTI takes a look at some Indian-origin athletes who will be representing their adopted countries at the Paris Games:

Rajeev Ram (Tennis, USA) Perhaps the most well known athlete on the list. The 40-year-old was born in Denver, USA to parents who migrated from Bangalore.

Steeped in academics, Ram's father Raghav, who passed away in April 2019, due to pancreatic cancer, was a botanist while his mother Sushma worked as a scientific technician. But Ram chose to break tradition and pursue tennis.

"I am very proud to be of Indian heritage and represent the community in any way I can. In tennis, there are not many of us from the community. Any success that we can achieve as a closed group can inspire the next generation to excel," Rajeev had once said.

Playing for the USA, Rajeev has achieved considerable success. The tennis doubles specialist won five Grand Slams titles including four men's doubles and one mixed doubles.

He teamed up with Venus Williams to clinch the mixed doubles 2016 Rio Olympics. He will compete in the men's doubles event

Prithika Pavade (Table Tennis, France)

Prithika's father was born and raised in Puducherry. In 2003, he migrated to Paris after getting married. A year later, Prithika was born in the French capital.

A TT player himself, Prithika's father introduced her to table tennis when she was six.

At only 16 years old, she participated in her first Olympic Games in Tokyo

The 24-year-old is a four-time U.S. National Champion (2016, 2017, 2018, 2019) and two-time Olympian (2016, 2020).

He was USA's youngest athlete at the 2016 Rio Olympics and also the first American to win a medal at the Youth Olympics in Argentina in 2018. He will be competing in the men's singles event at Paris.

Shanti Pereira (Singapore, Ath-

letics)

Known as Singapore's Sprint Queen, Veronica Shanti Pereira has her roots in Kerala. Her grandparents hailed from Vettukad near Thiruvananthapuram.

But after Shanti's grandfather got a job in Singapore, the couple migrated from India.

Last year, Pereira ended Singapore's 49-year-long wait for a track and field medal at the Asian Games, after she clinched a silver in women's 100m.

Awarded the 'Sportswoman of the Year' at the Singapore Sports Awards, Pereira will be one of the Lion City's two flag-bearers at the Paris Olympics opening ceremony

She also has a children's book -Go Shanti Go! -- based on her life, written by her two elder sisters. She will compete in the women's 100m race in Paris. (Wrestling, Dhesi Amar

Canada) Amarveer was born in Surrey, British Columbia, a small province on the western coast of Canada to Balbir Dhesi.



Gambhir wants Rohit and Kohli to be available for most games, aim for 2027 0DI World Cup

MUMBAI, July 22: India head coach Gautam Gambhir on Monday said he expects senior batters Rohit Sharma and Virat Kohli to be available for most of the ODIs and Tests after retiring from T20 Internationals, expressing hope that they would "keep their fitness" to be in the reckoning for the 2027 50-over World Cup.

Both Rohit and Kohli announced their retirement from the T20I format after India's World Cup win earlier this month and were expected to miss the upcoming tour of Sri Lanka.

However, they both were named in India's squad for next month's three ODIs in the island nation keeping in mind the Champions Trophy, which is slated for the first quarter of the next year.

Speaking to the media for the first time after being named India's head coach, Gambhir highlighted the importance of workload management for ace fast bowler Jasprit Bumrah but expected the regular presence of Rohit and Kohli going forward.

"I've said it before that workload management for someone like Jasprit Bumrah is important. For a batter, if they can play consistently, if they're in good form, might as well just play all the games," he said.

"With Rohit and Virat are not playing T20 cricket, we only have two formats to look after. I'm sure they're going to be available for most of the games," he added.



But for Bumrah, Gambhir said the "one rare kind of a bowler" deserves to be handled with more care due to injury concerns that are a regular nuisance for fast bowlers

"It's our responsibility to try and have him fresh for most of the important games (and) that's why workload management, not only for Jasprit Bumrah, but for most of the fast bowlers becomes very, very important," he said.

Gambhir also said he expects Rohit and Kohli to focus on their fitness keeping in my mind the

2027 ODI World Cup, slated to be held in South Africa. "They have shown what they

can deliver on the big day...in the T20 World Cup, in the 50-overs World Cup as well," he said. "One thing I can be very clear of is that both of those guys have

a lot of cricket left in them. More importantly with the Champions Trophy and a big tour of Australia coming up they will be motivated.

"Because then, hopefully, if they can keep their fitness to make

a very personal decision. I can't say how much cricket is left in them," Gambhir said.

Gambhir did not rule out having three different teams for respective formats but said it is imperative for the Indian team to show consistency, even though the T20I side is in transition following the retirements of Rohit, Kohli and all-rounder Ravindra Jadeja.

"See, eventually going forward, these things happen. For example, Virat and Rohit and Ravindra are not there in T20Is. 2027 World Cup as well but this is But (I) can't say right now that

there are going to be three different teams," he said.

"I think T20I (team) will obviously go through a transition with three seriously good players, world-class players, retiring from the format.

"But yes, in 50-overs and Test cricket, the more consistent we can be, the better it is going to be. The more players in both the formats, it is always better for any team," he said.

Gambhir said he would try to ensure a happy dressing room as international cricket can produce situations of pressure and insecu-

"My experience or my learning has been very simple. In a sport, it's all about winning, so I don't deviate from something like that," he said while talking about the lessons he learnt as mentors of IPL teams Lucknow Super Giants and Kolkata Knight Riders.

'...we try and play hard and more importantly, we try and come back in a winning dressing room.. A happy dressing room is a winning dressing room. I think I don't like complicating things and that's the kind of profession I'm in," he asserted.

'Sometimes. international cricket can be tough and it can be insecure as well because only 15 can play. But it's the job of the support staff to try and keep them in a happy state and that is going to be one thing which we definitely will be working for," he added. (PTI)

NEW DELHI, July 22: Wiser after her maiden Olympics appearance in Tokyo, Indian table tennis star Manika Batra on Monday said she is focused on taking one match at a time in the upcoming Paris Games and a medal will not be in her mind in the initial rounds.

Preparing for the Paris Olympics along with her teammates, Batra said she has learned from her Tokyo Games experience.

"I have learned many things from the last Olympics, and I am not going to make those mistakes again. My mindset has changed since then, I am calmer and have more confidence in myself," said Batra during an interview with Ul-

timate Table Tennis (UTT). "I have been working on my stamina and my agility, and my ultimate aim is to challenge for a medal

"But I will go slowly. I will try to be in that zone and give my best. I will go round by round and not think of a medal too early. I will give my best for my country," Batra, who represents PBG Bengaluru Smashers in UTT, added.

Batra played an instrumental role in the women's team qualifying for the Paris Olympics, a first for Indian table tennis.

She also reached the quarter-finals of the WTT Saudi Smash in May beating World No. 2 and former world champion Wang Manyu place in Chennai from August 22 of China and World No. 14 Nina to September 7. (PTI)

Mittelham of Germany "India qualified for the first time

(for the Olympics), this is a huge achievement. I am really happy with how we are working together (at the camp). I think we have a shot at the medal and we should give our best," Batra said.

"The growth of women's table tennis in India is really inspiring. I see many of my fellow players playing really well. Everyone in the team is motivated and training very hard. Women's table tennis in India will only grow further," she said.

Speaking about the growth of women's table tennis in India, the world No. 28 Batra credited UTT, which has provided young players a platform to rub shoulders with foreign stars and get exposure.

"UTT really helped us because we get to practice with foreign players, play matches (against them). We get good match practice," Batra said.

India will compete in the individual as well as team events of table tennis in Paris.

The cut-off date for qualification for the 2026 women's T20 World Cup qualifier was confirmed as October 31, 2024.

The CEC approved the appointment of Paul Reiffel to the Cricket Committee as the Elite Panel representative. (PTI)

with batting mainstay Virat Kohli "is between the two of us and not for TRPs", asserting that they are going to be "on same page" in the coming times. Gambhir and Kohli had not been the best of friends, something which was evident from the multiple confrontations between the two in the IPL. However, the duo will now be working together starting with the white-ball tour of Sri Lanka from July 27.

"Good for the TRP, but my relationship is not public. What kind of a relationship I share with Virat Kohli ... I think it's between two mature individuals," Gambhir said.

Gambhir was addressing a press conference along with chief selector Ajit Agarkar ahead of India's tour of Sri Lanka where they will play three T20 Internationals and as many ODIs.

In the context of Kohli, Gambhir added, "On the field, everyone has got the right to fight for their own jersey and come back to a winning dressing room.

"But at the moment, we're representing India, representing 140 crore Indians and I'm sure we're going to be on the same page and try and make India proud.

Kohli, who recently announced retirement from the T20 International format, is part of India's ODI squad against the island nation and ahead of that, the former India skipper has apparently communicated to the BCCI that he's ready to begin this new phase with a clean slate. (PTI)

We wanted someone who was likely to be available more often: Agarkar on Surya as T20 captain

MUMBAI, July 22: Fitness, feedback from the dressing room and consistent availability swung the pendulum in Suryakumar Yadav's favour when it was decided to appoint him captain of the Indian T20 team ahead of Hardik Pandya, chief selector Ajit Agarkar said here on Monday.

Agarkar was addressing a media conference along with newly-appointed head coach Gautam Gambhir ahead of India's tour of Sri Lanka where the team will play three T20 Internationals and as many ODIs against the hosts starting July 27.

"Why Surya was made captain? Because he is one of the deserving candidates. The one we know has been around the dressing room over the last one year, you get feedback from the dressing room a lot. He has got a good cricketing brain and he is still one of the best T20 batters in the world," Agarkar said during the joint press conference.

'You (would) want a captain that's going to be more likely to play all the games. We think he's a deserving candidate and hopefully we'll see over time how he develops into the role.

The chairman of selectors said they wanted a captain with a proven fitness record and not someone who was prone to injuries as Pandya is believed to be.

"But in regards to Hardik (Pandya), he's still a very important player for us and that's what we want him to be that player that he can be because those sorts of skill sets are very difficult to find what he has," Agarkar said.

"Fitness, obviously, has been a challenge for him over the last few years and then it becomes a little bit more difficult for him and even as selectors," he said.

"We're trying to now, we've got a bit more time till the next T20 World Cup when we can look at a few things. It's not rushed at the moment."

"We want him to be, you know, as I said, he's an important player for us and hopefully his performances are more important ó that was the thought behind it. The fitness is a clear challenge and we want someone who's likely to be available more often than not," Agarkar said.

As regards to former vice-captain KL Rahul being overlooked, he retorted, "I wasn't there when KL was superseded; I wasn't the selector firstly.

"We've got a little bit more time now till theÖ Since I've come, there's been a 50-overs World Cup, almost followed by the T20 World Cup. Fitness is a concern, not just that, we also feel that Surya has the necessary qualities to be a good captain.

"Two years is a long time, so at least it gives us a bit more of a chance to try and look at some things differently. The main thing is we want guys who are available all the time. In this way, we also feel we can manage Hardik a little bit better," he said.

Agarkar admitted the selection committee should have clarified that senior all-rounder Ravindra Jadeja, who also retired from T20Is



after the World Cup, was not "dropped".

"It would have been really pointless to take both him and Akshar for this short series. We know what Jaddu has done. He's had a terrific World Cup (T20). So, no, not at all dropped," he said.

"All options are open. But there was (a chance that) either of them would have played all three games if we'd taken both. There's a big test season coming up where he's (Jadeja) likely to feature in a lot of the Tests. I don't think three games would have mattered.

"We probably should have clarified that after the selection that he's not getting dropped. He's still within the scheme of things and very important as a player," said the former India pacer.

Agarkar said the door is not shut for the former deputies like KL Rahul, Rishabh Pant and even Pandya as far as leadership role is concerned.

"We need to get him (Pant) back playing, that's the first thing. He's going to be a key to us as a player; hasn't had a lot of cricket. We'll see what he can do," he said.

"We don't want to burden somebody again who's just coming back after over a year out of the game. KL has not been part of T20 now for a little while," he said.

"We've got a chance to reset the button a little bit. We've got a bit more time to plan. We want to try and seeÖ I mean, this time (in) T20 (against Afghanistan), frankly, when Hardik did get injured was a little bit of a challenge.

"At that point, Rohit wasn't playing but was still around (and) made our life a lot easier that he could come and play. We don't want that situation going forward again," he continued.

Agarkar said the selectors wanted vice-captain Shubman Gill to learn from the experience as well as from the senior players.

"Shubman is a guy that we feel is a three-format player and seems to have shown a lot of quality over the last year or so that we hear from the dressing room," he said.

"You try and have somebody who can also learn from a couple of the senior guys that are there.

"Surya in this instance or Rohit who's still around so we don't face the same challenges (that) suddenly (you are) trying to look for a captain in case there are injuries or loss of form somewhere," he explained

"He's shown some decent leadership qualities. We want to try and get him the experience that he can put forward. There are no guarantees in life but at this point, that's the thought," he said.

Agarkar admitted that while playing Tests in India the team may not need three seamers but going forward they will be discussing the fast bowling lineup too.

"Some of the guys, some of the fast bowlers are at the NCA. We hope that for the next month or so, they'll be back up playing," he said.

"I think he has (Mohammed Shami) started to bowl which is a good sign for us. (The) 19th September is the first Test. That was always the goal,' he added.

"We don't quite know whether that's the timeline at the moment. That I have to speak to the guys at the NCA but that's the aim.

"There are so many Tests coming in India; maybe you don't play three seamers in the eleven. But, going forward, there's a lot of cricket or Test cricket that's coming. We need some conversation around it," he said. (PTI)
