





## Budget reflects Modi's vision to achieve the developed India goal: Mandaviya

2024-25 focuses on the development of the poor, women, youth and farmers to make India a developed nation by 2047 which reflects Prime Minister Narendra Modi's holistic vision, Union minister Mansukh Mandaviya said on Saturday.

Addressing a press conference on the 'Union Budget of Modi 3.0' at the Chhattisgarh BJP office in Raipur, the Minister for Youth Affairs and Sports said ex-PM Rajiv Gandhi's slogan on taking India to the 21st Century remained unfulfilled. In contrast, Modi has set the development target with a roadmap. "The Budget reflects Modiji's vision. He doesn't think in token but in total (holistically). Modi Ji gave the vision of Amrit Kaal on taking the country forward in an inclusive manner," he said.

Mandaviya said Modi has resolved to transform India into a developed nation when it completes 100 years of Independence and proposed to fix pathways to achieve this goal.



"Former prime minister Rajiv Gandhi had spoken about taking the country to the 21st century but he didn't set the pathway to achieve this goal. The slogan of 21st Century remained merely a slogan," he added.

Modi's vision to make India a developed nation underscores the need to empower "four castes", namely Garib' (poor), 'Annadata'

'Yuva' (youth), the Union minister said, adding that key allocations have been made in the Budget for the development of these four sections. "The Union Budget is centred around the youth and employment, and a provision has been made for skilling the youth," he said, referencing to a provision to make ITIs skill hubs and increase employment opportunities.

"One crore youth will see skill

youth will get employment in the next 5 years," Mandaviya said.

He highlighted a Budgetary provision to provide basic facilities like "roads, water and electricity" in sync with time considering a growing number of middle-class people, noting the "roti, kapda, and makan" slogan is transformed into "road, paani, and light (electricity)'. Mandaviya also underlined the allocations for various sectors including manufacturing.

"Micro and small industries will benefit by developing e-commerce platforms. The Budget will ensure proper development of villages in rural areas, roads, water supply, cleanliness, all basic amenities, nearby markets," he said.

Under the Pradhan Mantri Awas Yojana (Urban) 2.0, the housing needs of 1 crore urban poor and middle-class families will be met with an investment of ₹ 10 lakh crore, Mandaviya said, adding that a provision of ₹ 1 lakh crore for research and innovation will directly benefit the youth. (PTI)

### Pakistan jittery as suspense continues on energy sector loan from China

ISLAMABAD/KARACHI, July 27: Two key Pakistani ministers are camping in Beijing to discuss the cash-strapped country's request for rescheduling its outstanding debts with China linked to the ambitious China-Pakistan Economic Corridor.

Muhammad Aurangzeb, Pakistan's Minister for Finance and Revenue, and Sardar Awais Ahmad Khan Laghari, the Minister for Energy (Power Division) are both in Beijing for the last three days, media reports said here on Satur-

The duo is meeting one author-

ity and agency after the other, including Pan Gongsheng, Governor People's Bank of China (PBoC), and Cao Yuanyuan, Deputy Secretary-General of National Association of Financial Market Institutional Investors (NAFMII).

The concern is that China was initially reluctant to discuss the issue, leading to a delayed visit, signalling their disagreement with Pakistan over talks related to energy loans, media reports said.

"Pakistan formally requested China on Thursday to reschedule its debts, with outstanding dues for China-Pakistan Economic Corridor (CPEC) power projects increasing by 44 per cent to Rs 401 billion by the end of the last fiscal year," The Express Tribune newspaper said.

According to power ministry documents, as of June 2024, the outstanding dues to Chinese power plants surged to Rs 401 billion, up Rs 122 billion or 44 per cent from the previous year.

"These unpaid debts, in violation of the 2015 CPEC Energy Framework Agreement, are hindering further financial and commercial relations between the two countries," the newspaper added. (PTI)

He also encouraged the creation of river grids at state level for effective utilisation of water resources. The Prime Minister emphasised on cooperation and collective effort of all states and the Centre to work together in order to achieve the vision of Viksit Bharat @2047. Modi encouraged states to initiate Demographic Management Plans to address the issues of population ageing in future.

Modi observed that the vision of Viksit Bharat can be realized through Viksit States, and that the aspiration of Viksit Bharat should reach the grassroot level i.e to each district, block, and village.

"For this, each state and district should create a vision for 2047 so as to realise Viksit Bharat @ 2047," he said. He observed that India has achieved steady growth in the past ten years. Indian economy, which was the 10th largest economy in the world in 2014, has risen to become the 5th largest economy by 2024.

Modi said that now the collective aim of the government and all citizens is to become the third largest economy in the world. The Prime Minister stressed that India has already made a lot of progress in the past ten years by strengthening social and economic infrastructure.

"From being a predominantly import-driven country, India now exports many products to the world. The country has made its mark on the world stage in wide-ranging sectors like defence, space, start-ups and sports," he said. The Prime Minister said that this is the decade of change which brings a lot of opportunities across

He encouraged States to utilise these opportunities and make policies and initiate governance programmes that are conducive for development through innovative approaches in policy-making and execution.

The Prime Minister emphasised on skilling and training of youth to make them employment-ready as the world looks favourably towards India for skilled human resources. Modi encouraged all states to increase productivity and diversification in agriculture and provide market

linkages to farmers. He further emphasised on spreading the adoption of natural farming practices which can improve soil fertility, ensure better and quicker returns to farmers due to low costs, and also provide a global market for the products. Meanwhile, talking to reporters, Banerjee said her microphone was switched off after only five minutes, while other chief ministers including from Andhra Pradesh, Goa, Assam and Chhattisgarh, were allowed to speak for longer durations.

"Tourists and the tourist vehicles ferrying tourists from Assam should come to Meghalaya without any fear, worry or agony-Khasi Students Union (KSU), All Assam Students Union (AASU) and North East Students' Organisation (NESO) on the issue of refusing entry of Assam registered cars in Meghalaya," he wrote.

In the statement signed by the presidents and the general secretaries of both the bodies, the KSU claimed that it was not "aware of any such incident of stopping vehicles from Assam and it firmly does not conform to any such initiative". While maintaining that tourists and their vehicles should come without any concern, KSU said it is "pertinent for both the governments of Assam and Meghalaya to have thorough dialogue on the issue and solve the same permanently

It urged the tourist taxi associations to maintain cordial relations and a spirit of common understanding. The two students' bodies maintained that it has been their constant endeavour to strengthen friendly relations

Dr G Narahari Shastry, former director of NEIST, stated that he had not been contacted by the CBI. Dr Jatin Kalita was unavailable for comment, and current director Dr Virendra Tiwari is out of station due to a family bereavement. This is the first time the CBI has investigated corruption at NEIST. The former controller of Finance and Accounts is also alleged to have sought approximately Rs 7 crore from CSIR Headquarters for equipment purchases linked to the private company.

#### India steel production to cross 300MT by 2030: Official



**KOLKATA**, **July 27:** Expressing optimism in steel demand amid headwinds, a senior central government official said on Saturday that the domestic production is likely to cross

300 million tonnes by 2030. The ministry also does not foresee any hurdles in capacity addition due to decarbonisation efforts in the steel sector and will soon release a draft roadmap seeking public opinion to reduce the carbon footprint in the steel sector, which accounts for 12 per cent of total emissions, Steel Secretary Nagaendra Nath Sinha said.

"The current steel demand remains strong with infrastructure push from the government and expecting a growth of about 10 per cent. The GDP is also growing robustly, and with continued emphasis on infrastructure from both government and private sectors, steel demand will continue to stay strong," Sinha said, while addressing members of the Bharat Chamber of Commerce (BCC).

Finished steel output during 2023-24 was 138.5 million tonnes, up 12.4 per cent yearon-year. To achieve 300 million tonnes of installed capacity, a CAGR of 12 per cent would be required.

From January to April 2024, steel produc-

#### cent, BCC president N G Khaitan said.

Sinha also stated that some steel makers were not reporting production and sales data accurately, and the ministry feels there are gaps. He urged companies to report correctly to support policy framing.

The steel makers complain of several headwinds like iron ore shortage, cheap steel im-

ports and policy shortcomings. The steel makers of eastern India raised serious concerns about iron ore shortages in the sector and suggested several steps to address the 53 million tonne iron ore shortage in the

Indian steel industry. Asked about steel import concerns from the industry, Sinha said imports in quantity are only 5 per cent of consumption, but there are complaints about hot-rolled coil from Vietnam, which the Directorate General of Trade Remedies, under the Ministry of Commerce and Industry, has taken up.

Speaking about the decarbonisation roadmap, Sinha said the government had set up 14 task forces on this and, after inter-minsterial discussions, the report will be released for public feedback soon. The roadmap focuses on increased hydrogen use in the steel industry and carbon capture, among others.

The short-term target for the government aims at about a 20 per cent reduction in carbon intensity. Currently, the average carbon intensity is 2.5 tonnes per tonne of steel production. A consortium has been planned with labs, IITs, primary and secondary steel makers, and equipment makers to develop indige-

nous green technology. Sinha stated that the steel ministry has writ-Rashtriya Ispat Nigam Ltd as a "going concern" during times of crisis so it does not lose

### Delhi-Jorhat direct air connectivity to commence from October: Gaurav Gogoi



HT Bureau GUWAHATI, July 27: Assam's Jorhat and Delhi will now have direct flight connectivity, the civil aviation ministry announced on Saturday, according to Lok Sabha MP Gaurav Gogoi.

The leader of the Congress party stated that he had asked the Union minister of civil aviation to start operating flights between Jorhat and the nation's capital earlier this month.

Civil Aviation minister Ram Mohan Naidu and submitted a letter requesting air connectivity.

"Naidu has informed that a189seater flight will run between Jorhat and Delhi. As per the information shared by the Minister, the routes connecting Jorhat to Delhi have been awarded to M/s SpiceJet with 189-seater type, of aircraft and frequency of 07 flights per week under UDAN 5.0 round of

Currently, Indigo Airlines offers flights from Jorhat to Kolkata, Di-

brugarh, and Tezpur. Gogoi, who is an MP from Jorhat parliamentary constituency said, "Further, my request for increasing the frequency of flights and operations have also been raised with the scheduled domestic airlines for favourable considera-

According to Jorhat MP, previously, there was a direct flight between Delhi and Jorhat, which was greatly valued by the community for its convenience and efficiency. Unfortunately, this service has been discontinued, leaving residents with limited and less optimal travel options.

"The absence of a direct flight has not only inconvenienced travellers but has also resulted in significantly higher ticket prices, ranging from 12,000 to 15,000 INR for a single journey. Such high costs impose a heavy finanwho depend on air travel for essential commuting purposes, such as medical emergencies, business travel, and family visits," Gogoi added.

He further said that Jorhat, renowned for its cultural heritage and economic potential, deserves reliable and direct air connectivity to Delhi-a critical hub for national and international travel.



problems were faced by tourists on Saturday as well, although local authorities promptly intervened and did not allow the situation to escalate.

"Around 80-90 pc of oral cancer patients have been found to use tobacco in some form, be it smoking or chewing. Most of the head and neck cancer are preventable, unlike other cancers for which the reason is unknown. It is a preventable cancer that can be prevented with lifestyle modification.

"There is a need to raise awareness to quit tobacco and early



check-ups for early pickup of the disease," Gupta said

In India, nearly two-thirds of cancer cases are detected late likely due to low adoption of proper screening, he said.

Gupta added that the Cancer Mukt Bharat campaign aims to reduce the incidence and impact of cancer on individuals and communities through education and early detection.

"If found early in stages one or two, most head and neck cancers are curable in more than 80 pc of patients. In the field of cancer treatment, we get new medicines almost every week which can treat cancer in better way leading to better outcomes and good quality of

"A combination of surgery, radiation therapy, chemotherapy, targeted therapy, and immunotherapy can be used for treating head and neck cancer. Latest cancer treatment has evolved to prioritise not just curing the disease, but also ensuring a good quality of life for survivors," he said

### BJP-EKADC backs KAAC power boost via 125<sup>th</sup> Amendment

DIPHU, July 27: Laichan Engleng, spokesperson for the BJP -East Karbi Anglong District Committee (BJP-EKADC), expressed support for the Karbi Anglong Autonomous Council (KAAC) chief executive member (CEM) Tuliram Ronghang's efforts to push for the implementation of Memorandum of Settlement (MoS) clauses 1 and 2 under the 125th constitutional amendment. This initiative aims to enhance

KAAC's powers as outlined in the Sixth Schedule of the Constitution of India.

At a press conference on Saturday at the Hills People Cultural Forum (HPCF) office, Engleng highlighted the progress made since the 1995 Memorandum of Understanding (MoU), which allocated certain subjects to KAAC.

He further said then 2011 MoS, signed by the disbanded United People's Democratic Solidarity (UPDS), increased funding from the central government for KAAC. The 2021 MoS, signed by six disbanded armed groups, further sought to enhance KAAC's powers for better protection of scheduled

tribe communities," he added. "On July 25, Ronghang and his team met Union home minister Amit Shah in New Delhi. Shah stated that the state home minister would prepare a report on KAAC's demands within a month, after which discussions on including



these in the constitutional amend ment would follow," he added.

While Engleng acknowledged the ultimate goal of achieving an autonomous state, he emphasised that increasing KAAC's powers through incremental transfers of subjects is a step in the right direction.

Notably, Ronghang has also convened a meeting with the heads of Sixth Schedule autonomous councils in Northeast India to advocate for enhanced powers and implementation of MoS clauses 1 and 2. Engleng also mentioned that if these clauses are included in the 125th constitutional amendment, KAAC's elected seats would increase from 26 to 44, with 34 reserved for ST and 10 open to all.

Engleng further urged public support for the 125th constitutional amendment, stressing that it would strengthen KAAC's Sixth Schedule provisions.

He criticised opposition from figures like All Party Hills Leaders Conference (APHLC) organising secretary Kursing Timung, suggesting that such leaders should support, rather than oppose, the

avud is a YouTuber based in Czech Republic, who can't help wondering how vehicles beeping pap-pap, while visiting our Doul Govinda Mandir on the foothills of Chandra Bharati hill at Rajaduar, North Guwahati. Surely he had noticed that most the vehicles sped by honking its horn. There were no pedestrians or even other vehicles on the road and he saw all honking vehicles passed by.

Commuters often distracted by a commotion across the bustling street of India. The other day while I was returning home, there were blaring sound of sirens along with so many VIP Cars in the midst of a rainstorm.

All those crazy traffic circled around and honked. Traffic blocked in key roads as police failed to streamline the flow of traffic. And there was an ambulance kept blowing siren for a passage.

This is our cityear-splitting crack of thunder all day and all night. The sound of horns is causing great annoyance in our day to day life. There is a need now to put an effort to suppress

Our ears are more sensitive to loud sounds. The effects of such noise can damage hearing leading to hearing loss. A sound's loudness is measured in decibels (dB). Sounds anything above 85 dB are harmful, where heavy traffic and noisy restaurant make noise levels between 80-89 dB.

Besides sports crowd, rock concert, and loud symphony, where it goes



120-129 dB, there is gun shot and siren at 100 feet that make 140 Db, which is extremely dangerous to us.

People regularly exposed to harmful noise because of their jobs such as construction factory workers, fire fighters, drivers and traffic police. Military personnel often face while firing

They suffer from Tinnitus symptoms. Even musicians face heavy crunch sound at musical concert. Such urban commotions by non-bothering individuals make not only our city noise but create systemic changes to our environment too.

The bustle of big city makes people sick. We forget that noise pollution is still pollution. Ironically hearing damage is irreparable. The days of birdsong, intelligible human speech, the gentle rustling of leaves, the crispy highs of brushes on jazz cymbals are over. People living in cities are regularly exposed noise.

An hour-long commute at such sound levels could cause significant hearing loss over time. Even noise level of 60 decibels could raise blood pressure, heart rate and cause stress, loss of concentration and sleep. Ac-

cording to WHO, human pain thresh-

old is at 120 decibels. However the permissible limits of noise at residential areas are 55 dB and 45dB during daytime and night respectively. So does with 75-70 dB and 65-55 dB for industrial and commercial areas respectively

Creating noise is considered to be a public nuisance under Section 290 of the Indian Penal Code, 1860. Further, if there is noise after 10 pm, one may contact the local police helpline.

Now loud horns (pressure horns) are to be a thing of past in India. The government is taking a significant step to reduce noise pollution on its roads by enforcing a 50-decibel limit for vehicle horns

Yet unnecessary honking is indeed a common issue on Indian roads. Many motorists installed modified silencers on their sports bikes and violated the

rules. It contributes significantly to noise pollution and can be quite annoying for everyone around.

Aizawl has set an example on how to deal with this crisis. Nobody honks, or jumps their lane in Aizawl. So be with Gangtok city. Horn is not OK please: Honking without reason is illegal, so we might as well stop it.

I have to wonder whether sirens in many instances are worth. Sirens often confuse peopleand frequently it's hard to tell what direction the sound is coming fromand causeda driver in stress and disorientation, doubtless leading to more accidents. However, it is essential to differentiate between the distinct sounds of a police siren and an ambulance siren.

Understanding their differences can help pedestrians and motorists respond appropriately, ensuring the smooth flow of traffic and timely assistance in emergency situations.

Police sirens typically produce a combination of wailing and alternating high-low sounds. Ambulance sirens generally produce a continuous, highpitched wailing sound.

So, the next time you hear a siren, you'll have the ability to differentiate between the type of emergency vehicle in action, facilitating a prompt and responsible reaction from everyone involved. That raised a key question.





## An Israeli airstrike hits a school sheltering people in Gaza, killing at least 30

DEIR AL-BALAH (GAZA STRIP), July 27: Israeli airstrikes hit a school being used by displaced people in central Gaza on Saturday, killing dozens, as the country's negotiators prepared to meet international mediators to discuss a proposed cease-fire.

At least 30 people sheltering at a girls' school in Deir Al-Balah were taken to Al Aqsa Hospital and pronounced dead after a strike that Israel's military said targeted a Hamas command and control centre used to store weapons and plan attacks. It said militants "used the compound as a hiding place to direct and plan numerous attacks against IDF troops" and "developed and stored large quantities of weapons inside"

Civil defence workers in Gaza said that thousands were sheltering in the school, which also contained a medical site.

Near the hospital, where the bodies were transported, Associated Press journalists saw an ambulance rushing through a dusty road as a few people ran in the opposite direction. An injured man lay on a stretcher on the ground. A body covered with a blanket and a dead toddler lav inside the ambulance.

Inside the school, classrooms were in ruins. People were seen searching for victims under the rubble and some were gathering the remains of those who were

### Vice President Kamala Harris officially declares candidature for US presidential elections



WASHINGTON, July 27: Vice on X. President Kamala Harris on Saturday officially signed her forms, declaring her candidacy for the post of President of the US and voiced confidence that she would November 5.

"Today, I signed the forms officially declaring my candidacy for President of the United States. I will work hard to earn every vote," 59-year-old Harris, who is of Indian and African origin, said

"In November, our people-powered campaign will win," the presumptive Democratic Party candidate said, referring to her electoral battle with former presinominee Donald Trump.

Harris launched her presidential campaign last Sunday, hours after President Joe Biden. 81, withdrew from the race for a second term. She is, however, yet to be officially declared as the presidential

candidate by the Democrats. If elected on November 5 to

succeed President Biden, Harris the daughter of a Jamaican father and an Indian mother - would not only be the first woman, but the first Indian-American, the first Asian, the first Black woman and the first person of Jamaican descent to ascend to the office. Meanwhile, no other Democ-

rats have announced their candidacy for the presidential race. Harris has secured endorsements from more than 40 state delegations, surpassing the number of delegates she will need to win the nomination and if that support nominate her for president during a virtual roll call vote early next

Under new rules adopted by the Democratic National Committee on Wednesday, the nominee will be selected as soon as August 1,

and the candidate has until August 7 to select a running mate. The party will meet for its convention in Chicago starting August 19.

Harris, who was a senator from California before she was elected vice president, quickly hit the campaign trail with events in Wisconsin, Indiana and Texas. Her campaign said it raked in more than USD 130 million since she officially joined the White House

The endorsement comes as 'Harris for President' kicks off a Weekend of Action' marking 100 days until Election Day (on November 5).

#### Hungary's nationalist leader warns of EU's demise and backs Trump in anti-Western speech

BAILE TUSNAD (ROMA- EU. "We Europeans do not have NIA), July 27: Hungary's nationalist Prime Minister Viktor Orban said on Saturday that the European Union was sliding toward oblivion in a rambling anti-Western speech in which he warned of a new, Asiaoriented "world order" while throwing his support for Donald Trump's US presidential bid.

"Europe has given up defending its own interests," Orban said in Baile Tusnad, a majority-ethnic Hungarian town in central Romania. "All Europe is doing today is following the US's pro-Democrat foreign policy unconditionally ... even at the cost of self-destruc-

"A change is coming that has not been seen for 500 years. What we are facing is in fact a world order change," he added, citing China, India, Pakistan and Indonesia as becoming the "dominant centre" of

Orban also alleged that the US was behind the 2022 explosions that damaged the Nord Stream gas pipelines built to carry gas from Russia to Germany, calling it "an act of terrorism carried out at the obvious direction of the Americans". He didn't offer any evidence to back up the claim.

The far-right leader's remarks come amid growing criticism from his European partners after he embarked on rogue "peace mission" trips to Moscow and Beijing earlier this month aimed at brokering an end to Russia's war in Ukraine. Orbán is widely considered to have the warmest relations with the Kremlin among all EU leaders.

On Ukraine, Orbán cast doubt on the war-torn country becoming either a member of NATO or the the money for it. Ukraine will revert to the position of a buffer state," he said, adding that international security guarantees "will be enshrined in an agreement between the US and Russia" Throughout Russia's full-scale

war in Ukraine, Orbán has broken with other EU leaders by refusing to provide Kyiv with weapons to defend against Russian forces and has routinely delayed, watered down, or blocked efforts to send financial aid to Kyiv and impose sanctions on Moscow. Orbán

Orbán said on Saturday that Trump's bid for re-election aims "to pull the American people back from a post-nationalist liberal state to a nation-state" and rehashed a slew of conservative tropes that Trump is being penalised unfairly to prevent his electoral bid.

"That is why they want to put him in prison. That's why they want to take away his assets. And if that doesn't work, that's why they want to kill him," Orbán said, referring to an assassination attempt on Trump at a Pennsylvania rally this month.

Orbán's remarks on Saturday aren't the first time he's used the festival in Transylvania to stir controversy. In 2014, Orban declared for the first time his intentions of building an "illiberal state" in Hungary, and in 2022, he sparked international

## Philippine forces sail to hotly disputed shoal without incident for first time since deal with China

PINES), July 27: Philipgovernment personnel transported food and other supplies on Saturday to a fiercely disputed shoal occupied by a Filipino navy contingent but closely guarded by Beijing's forces in the South China Sea and no confrontations were reported, Philippine officials

It was the first Philippine government supply trip to the Second Thomas Shoal, which has been the scene of increasingly violent confrontations between Chinese and Philippine forces, since the Philippines and China reached a deal a week ago to prevent clashes, the Department of Foreign Affairs in Manila said in a statement.

"The lawful and routine rotation and resupply mission within the Philippines' exclusive economic zone is a credit to the professionalism of the men and women of the Philippine navy and the Philippine coast guard and the close coordination among the National Security Council, Department of National Defense and the Department of Foreign Affairs," the Philippine Foreign Affairs Department said, without providing other details.

A top Philippine security official told The Associated Press that the Chinese and Philippine coast guards communicated for coordination Saturday, and their ships did not issue two-way radio challenges like in the past to demand that each other's ships leave the shoal immediately.

Also, for the first time at the shoal, Chinese coast guard ships did not shadow or block the Philippine vessels as they had repeatedly done in the past, said the official, who spoke on condition of anonymity because of a lack of authorization to discuss the delicate issue

China's coast guard said the Philippine ship delivered daily necessities "in accordance with a temporary arrangement reached between China and the Philippines." China Coast "The

Guard confirmed it, supervised and managed the enspokesperson Gan Yu said in a statement posted on-

The deal was reached by the Philippines and China after a series of meetings between the two country's diplomats in Manila and exchanges of diplomatic notes aimed to establish a mutually acceptable



arrangement at the shoal which Filipinos call Ayungin and the Chinese call Ren'ai Jiao — without conceding either side's territorial claims, Philippine officials said.

The deal has not been made public by either side. U.S. Secretary of State Antony Blinken welcomed the news that the resupply mission was completed without a confrontation.

"We applaud that and hope and expect to see that it continues going forward," said Blinken, who was in Laos for a meeting of foreign ministers of the Association of Southeast Asian Nations, a group that includes the Philip-

China's coast guard and other forces have used powerful water cannons and dangerous blocking maneuvers to prevent food and other supplies from reaching Filipino navy personnel at Manila's outpost at the shoal, on a long-grounded and rusting warship, the BRP Sierra Madre

In the worst confronta-

tion, Chinese forces on motorboats repeatedly rammed and then boarded two Philippine navy boats on June 17 to prevent Filipino personnel from transferring food and other supplies, including firearms, to the ship outpost in the shallows of the shoal, according to the Philippine government. The Chinese seized the Philippine navy boats and

damaged them with ma-

chetes and improvised

spears. They also seized seven M4 rifles, which were packed in cases, and other supplies. The violent faceoff wounded several Filipino navy personnel, including one who lost his thumb, in a chaotic skirmish that was captured in video and photos that were later made public by

Philippine officials. China and the Philippines blamed each other for the confrontation and each asserted their own sovereign rights over the shoal

The United States and its key Asian and Western allies, including Japan and Australia, condemned the Chinese acts at the shoal and called for the rule of law and freedom of navigation to be upheld in the South China Sea, a key global trade route with rich fishing areas and undersea gas deposits.

In addition to China and the Philippines, Vietnam, Malaysia, Brunei and Taiwan have been locked in separate but increasingly tense territorial disputes in the waterway, which is regarded as a potential flashpoint and a delicate fault line in the U.S.-China regional rivalry. The U.S. military has deployed Navy ships and fighter jets for decades in what it calls freedom of navigation and overflight patrols, which China has opposed and regards as a threat to re-

gional stability. Washington has no territorial claims in the disputed waters but has repeatedly warned that it is obligated to defend the Philippines, its oldest treaty ally in Asia, if Filipino forces, ships and aircraft come under an armed attack, including in the South China Sea. (AP)

### Japan's Sado gold mine gains UNESCO status after Tokyo pledges to exhibit dark WWII history

TOKYO, July 27: The UNESCO World Heritage committee on Saturday decided to register Japan's controversial Sado gold mine as a cultural heritage site after the country agreed to include it in an exhibit of its dark history of abusing Korean labourers during World War II.

The decision signals an improvement in ties between Tokyo and Seoul. The mine on an island off the coast of Niigata in northern Japan operated for nearly 400 years and was once the world's largest gold producer before closing in 1989. It was also linked to Japan's wartime abuse of Korean labourers.

Committee members, including South Korea, gave unanimous support to the listing at Saturday's annual meeting in New Delhi, India.

They said Japan provided additional information, made all necessary amendments to the plan and consulted with South Korea over the mine's wartime history. The Japanese delegate told the meeting that Japan has installed new exhibition material "to explain the severe conditions of (Korean labourers') work and remember their hardship"

Japan acknowledged that Koreans were put to more dangerous tasks in the mine shaft, which caused some to die. Many of them were also given meagre food rations and nearly no days off. A memorial service for all the workers at the Sado Island gold mines will be held annually at the site, Japanese officials said.

The South Korean delegation said the country expects Japan to keep its pledge to be truthful to history and to show "both the bright and dark side" of the Sado mine in order to help improve relations over the long term. Japan had to demonstrate a commitment to face its wartime atrocities in order to gain support from South Korea, which had opposed the UNESCO bid be-

cause of the wartime abuse of Korean labourers. Such disputes over history that have consistently strained bilateral ties. Seoul has said some Koreans brought to Japan during its 1910-1945 colonization of the Korean Peninsula were put to forced labour at the

Historians say Japan used hundreds of thousands of Korean labourers, including those forcibly brought from the Korean Peninsula, at Japanese mines and factories to make up for labour shortages, as most working-age men were sent to battlefronts across Asia and

the Pacific. Sado was among them. Japan's government has long been criticized for its reluctance to discuss wartime atrocities, including the sexual abuse of Asian women known as "comfort women" and Korean forced labourers.

Japanese authorities have hailed the Sado Island mine for advancements in mining technology before and after industrialisation but made no mention of its connection to the abuse of Korean laborers during

## More BJP ruled states announce reservation/preference to ex-Agniveers in state police recruitment

NEW DELHI/JAIPUR, July 27: Rajasthan and Arunachal Pradesh have joined other BJP-ruled states that have announced reservation or preference to ex-Agniveers for jobs in uniformed services like police, amid criticism of the short service military recruitment scheme by opposition parties which are calling for its scrapping.

States like Uttar Pradesh, Uttarakhand, Gujarat, Odisha, Madhya Pradesh and Chhattisgarh had on Friday announced similar in-

Rajasthan Chief Minister Bhajanlal Sharma said his government will provide reservation for Agniveers in the recruitment of jail and forest guards and state police.

A statement from the Chief Minister's Office on Saturday said Sharma made the announcement for Agniveers on the occasion of Kargil Vijay Diwas on July 26.

"The Rajasthan government has made a provision of reservation in state police, jail guard and forest guard recruitments for the Agniveers who protect the country's borders with a sense of dedication and patriotism," it said.

However, the percentage of the reservation in these services for Angiveers was not disclosed.

Retired Agniveers will be given preference during recruitment for the state's police, emergency and fire services, Arunachal Pradesh Chief Minister Pema Khandu announced. Khandu said this transformative initiative would enable



youngsters of Arunachal Pradesh to serve the country.

"The government of Arunachal Pradesh will facilitate training for local youths to prepare them for recruitment as Agniveers under the AGNIPATH scheme," the chief minister said in a post on X.

"Additionally, retired Agniveers from Arunachal Pradesh will be given preference in recruitment for the Arunachal Pradesh Police, AP Battalions, and Emergency and Fire Services," he added.

While campaigning for the Lok Sabha elections, Yadav repeatedly promised to scrap the scheme if the INDIA bloc, of which the Samajwadi Party is a constituent, formed the government at the cen-

In a post on X, Yadav said, "As soon as we come to power, the short-term 'Agniveer' military recruitment that compromises the security of the country and plays with the future of the soldiers will be cancelled within 24 hours."

"This is our demand on 'Ag-... The old recruitment niveer' (model) should be reinstated," he said in Hindi.

On Friday, Chhattisgarh Chief Minister Vishnu Deo said Agniveers from the state would be

lice constables and forest and jail guards once they complete their service in the Indian Army.

Gujarat Chief Minister Bhupendra Patel said his government will give priority to Agniveers in the recruitment for armed police as well as the State Reserve Police Force

Madhya Pradesh Chief Minister Mohan Yadav said his government will provide quota to Agniveers in police and armed forces recruitment. Agniveers will be granted a reservation in government jobs in Uttarakhand upon their return after serving in the armed forces, Chief Minister Pushkar Singh Dhami announced on Friday.

Last week, Haryana's BJP government had also announced a 10 per cent reservation for Agniveers in the recruitment of constables, forest guards and jail wardens, along with quotas in other posts, months ahead of the assembly

Chief Minister Nayab Singh Saini also said that in the recruitment for civil posts in Group B and Group C, the government has decided to grant Agniveers a relaxation of three years in the upper age limit. "However, for the first batch of Agniveers, this age relaxation will be five years," he added.

He said his government will provide Agniveers five per cent reservation in direct recruitments for civil posts in Group C and one per

Saini also announced that if an Agniveer takes a loan of up to Rs 5 lakh to start a business, no inter-

est will be charged on it. The Centre introduced the Agnipath scheme in 2022 for short-term induction of personnel in the Army, Navy and Air Force, with an aim to bring down the age profile of the three services.

The scheme provides for recruiting Agniveers youngsters between the age group of 17-and-a-half and 21 for a block period of four years with a provision to retain 25 per

cent of them for another 15 years. The Union Ministry of Home Affairs had announced that 10 per cent of vacancies for recruitment in the Central Armed Police Forces or the paramilitary forces would be reserved for ex-Agniveers.

PM Modi on Friday said the Agnipath scheme is an example of necessary reforms undertaken by the Army and accused the opposition of playing politics over the recruitment process.

"The aim of Agnipath is to make the forces young...The aim of Agnipath is to keep the armies continuously fit for war," he said and rubbished claims the Agnipath scheme was launched to save pension money.

The Congress and other parties have alleged that the Agnipath scheme is discriminatory to soldiers, has disrupted the recruitment process for armed forces and can compromise the country's security. (PTI)

#### India, Ukraine looking at possibility of PM Modi's visit to Kyiv next month

NEW DELHI, July 27: India and Ukraine are looking at the possibility of a visit by Prime Minister Narendra Modi to Kyiv next month amid renewed global efforts to bring peace to the eastern European nation, multiple diplomatic sources said on Saturday.

Modi might visit Kyiv around the Ukrainian National Day on August 24 and is expected to travel to Poland after concluding the trip to Ukraine, the sources said.

The prime minister held talks with Ukrainian President Volodymyr Zelenskyv last month on the sidelines of the G7 Summit in Italy's Apulia.

If Modi travels to Poland, it would be the first by an Indian prime minister to that country in more than four

India and Ukraine are looking at Modi's visit to Kyiv in the later half of August, the sources said, adding that there is no finality on the trip yet as massive preparations would be required in terms of logistics and related issues.

The prime minister's two-nation visit might begin around August 23-24, the sources said.

There is no official word on the visit either from India or Ukraine.

At the meeting with Zelenskyy on June 14, Modi conveyed to the Ukrainian president that India would continue to do everything within its means to support a peaceful solution to the Russia-Ukraine conflict and that the way to peace is through "dialogue and diplomacy'

Modi also told Zelenskyy that India believes in a "human-centric" approach to find a solution to the conflict in Ukraine.

At the meeting, the Ukrainian president invited the prime minister to

India has been maintaining that the conflict in Ukraine must be resolved through dialogue and diplomacy.

Modi visited Russia on July 8-9 and it drew criticism from the United States. Many western countries are also learnt to be unhappy over the prime minister's trip to Moscow.

India on Thursday rejected Washington's concerns over Modi's trip to Moscow and asserted that all countries have the "freedom of choice" in a multipolar world and everyone should be mindful of such realities.

In his summit talks with Russian President Vladimir Putin, the prime minister delivered an unambiguous message, saying a solution to the Ukraine conflict is not possible on the battlefield and peace talks do not succeed amidst bombs, guns


NEW DELHI/SRINAGAR, July 27: A soldier was killed and four others, including a captain, were injured as the Indian Army foiled an attack on Saturday by Pakistan's Border Action Team (BAT) in the Kamakari sector of Jammu and Kashmir's Kupwara district, military sources said.

They said a Pakistani intruder was also killed in the exchange of fire, while two more managed to return to Pakistan-occupied Kashmir (PoK) amid the intense gunfight that lasted for hours.

The BAT generally comprises special forces personnel of the Pakistan Army and terrorists.

"Action by Border Action Team has been foiled by alert Indian Army troops on Saturday morning in Kamakari sector," one of the sources

Security in the Union territory has been tightened following a recent uptick in terror attacks there. In the Jammu region alone, attacks in Rajouri, Poonch, Reasi, Udhampur, Kathua and Doda districts have claimed 22 lives, including that of 11 security personnel and a village de-



fence guard member, this year. As part of its attempt to beef up security in Jammu, the government is sending two BSF battalions, comprising more than 2,000 personnel,

in Kupwara, a Srinagar-based defence spokesperson said, the intruders crossed the LoC taking advantage of the bad weather and poor visibility in the area and fired on a forward Army post from prox-

According to the sources, the group of three intruders hurled a grenade and opened fire on a forward post near the Kumkadi post in the Trehgam sector of the north

The troops retaliated, triggering a gunfight between the two sides, the sources said, adding that five soldiers were injured in the encounter and one of them later succumbed to

They said the injured Army personnel, including the captain, were evacuated to the Base Hospital in Srinagar. In a statement, the defence spokesperson said the identification and affiliation of the slain Pakistani intruder was being ascertained.

One of the soldiers who suffered severe injuries in the gunfight is responding well to treatment and is stable at present, he added. The soldier who died was identified as rifleman Mohit Rathour.

The official said that in the past too, similar attempts by infiltrators, actively aided and abetted by the Pakistani Army, have exploited thick foliage and poor visibility conditions, but have always been successfully thwarted and disrupted.

The Indian Army is firm in its resolve and commitment to maintain the sanctity of the LoC and defeat the nefarious and inimical designs of the Pakistani side, he added. (PTI)

### 3 dead after 4-storey building collapses in Navi Mumbai; 2 rescued from under rubble



MUMBAI, July 27: Three persons were killed and two others injured after a four-storey residential building collapsed in Navi Mumbai's CBD Belapur area early on Saturday, officials said.

The two injured persons were pulled out alive from under the rubble after the incident that occurred at 4.50 am in Shahbaz village, they said, adding that the scale of the tragedy could have been bigger had 52 other residents of the building not been evacuated in time after cracks were noticed in it in the wee hours.

'The four-storey building with 13 residential units and three shops collapsed early this morning. A man and a woman who were trapped under the rubble were rescued and admitted to a hospital," Navi Mumbai Municipal Corporation (NMMC) Commissioner Kailas Shinde said.

The National Disaster Response Force (NDRF) and the personnel of the civic body's fire brigade launched a rescue operation. Around noon, the body of a man was recovered from under the debris, while the bodies of two others were recovered hours later, a civic offi-

The deceased were identified as Mohammad Miraj

Altaf Hussain (30), Miraj Saif Ansari (24) and Safique Ahmed Rahmat Ali Ansari (28). Their bodies were sent to a government hospital for post-mortem, he

According to the municipal commissioner, the collapsed building was 10 years old and a probe will be conducted into the cause of the crash.

Talking to PTI, NMMC's divisional fire officer Purushottam Jadhav said, "In the wee hours, some residents noticed cracks in the building and alerted the authorities about it. The fire brigade team reached the spot and evacuated 52 residents, including 13 children, from the building. The structure collapsed some

Two persons - Lal Mohammad (22) and Rukhsana (21) - were rescued from under the rubble around 6 am. The authorities later learnt that one person was feared trapped under the debris and the rescue teams tried to call him on his mobile, but in vain. Later on, they came to know that two of his friends were also with him at that time, he said.

A dog squad also assisted the rescue teams, the NDRF official said.

Meanwhile, Chief Minister Eknath Shinde, who was in Delhi for Niti Aayog's governing council meeting, spoke to the Navi Mumbai municipal commissioner and directed him that necessary assistance be provided to the injured and affected persons, an official release by the Thane district administration said.

The NDRF said final search is being carried out and the work of removing the debris is underway.

Earlier this week, heavy and incessant rains lashed Mumbai, Navi Mumbai, Thane, Raigad and parts of the Maharashtra capital metropolitan region. However, the showers have taken a break in the past two

### Bengaluru PG murder case: Accused arrested in Bhopal



BENGALURU, July 27: The Bengaluru police have arrested the prime suspect in the murder of a 24-year-old woman at a paying guest accommodation here on July 23.

Abhishek was arrested in Bhopal where he fled after committing the gruesome murder of Kriti Kumari. "Yes, he has been arrested," a sen-

ior police officer told PTI on Satur-Addressing reporters, Bengaluru Police Commissioner B Dayananda

said the accused has been identified and picked up from Madhya Pradesh. He is being brought to Bengaluru on a transit remand.

To a query about the motive behind the murder, he said, "We don't know it yet. He has to be brought here and then we have to take his police custody and thorough investigation and interrogation has to be conducted... only then further details can shared." On Friday, the video of the chilling incident went viral.

According to police, Abhishek had sneaked into the PG accommodation and killed Kriti Kumari from Bihar.

In the video, the man is seen walking into the corridor of the paying guest accommodation holding a polythene bag. He then knocks on the door and, later, drags a woman out. The victim resists the attack, but is soon overpowered by the murderer. who slits her throat and runs away.

Upon hearing the loud noise, other women in the building rush to the spot, but could not save her.

SHIMLA, July 27: The Union govern- of cost for ten years, Chief Minister ment would have no stake in ₹ 350-crore Medical Device Park coming up at Nalagarh in Solan district as the state government has decided to construct the park from its own resources and return ₹ 30 crore received from the centre, according to a release. The decision has been taken in the interest of the state.

The project would come up in over 265 acres of land and in case ₹ 30 crore received from the centre was not returned, the land would have been provided to industrialists at the rate of ₹ 1 per square meter, electricity at ₹ 3 per unit and water, maintenance and warehouse facilities, free

Sukhvinder Singh Sukhu said. The state government has so far spent ₹ 74.95 crore for the project, a statement issued here on

Keeping the interests of the state and steering out of the bindings, the government has decided to build the Park by itself as the project when commissioned would accrue benefits amounting to ₹ 500 crore from the sale of land and other resources in the next five to seven years, he added.

The state government will take a loan from SIDBI (Small Industries Development Bank of India) under the cluster development scheme for the construction of the medical device park and with restructuring of the project, 25 per cent of the land will be allotted exclusively for medical device industries and 75 per cent for other strategic industries, he said. The industrial park will be developed as a modern industrial hub which will become a perennial source of income for the state government along with economic development and better infrastructure in the coming years, he said. Earlier also the state government had decided not to take help from any private agency in the Bulk Drug Park being built at Haroli of Una district and the government will provide ₹ 1,000 crore from its own resources, the statement added. (PTI)

#### 'Protecting married people wanting to be in live-in relationships will encourage wrongdoers'

CHANDIGARH, July 27: The Punjab and Harvana High Court has held that granting protection to married people who want to be in live-in relationships with their partners would amount to encouraging "wrongdoers" and promoting the practice of bigamy.

A bench of Justice Sandeep Moudgil also observed that such couples, who run away from their parental homes, not only bring a bad name to their families but also violate the right of their parents to live with dignity and honour.

The court order came following several petitions, including one filed by a 40-year-old woman and a 44-year-old man, demanding protection due to a "threat" from their families.

Both of them are living together despite the fact that the man is married and both of them have children. The woman has taken divorce from her husband. The court said it is of the view that the peti-

tioners were fully aware that they were married earlier and that they could not have entered into a live-in relationship. "Further, the petitioner no. 2 (the man) has not taken divorce from his earlier wife. All livein relationships are not relationships in the na-

ture of marriage," the court observed. If the court holds that the relationship between the petitioners is in the nature of a marriage, it will be injustice to the wife and

children of the man, it said. The court said marriage is entering into a relationship that has public significance as well.

"The institutions of marriage and family are important social institutions that provide for the security and bear an important role in the rearing of children. The celebration of a marriage gives rise to moral and legal obligations, particularly the reciprocal duty of support placed upon spouses and their joint responsibility for supporting and raising children born out of the wedlock," it observed.

"Under Article 21 of the Constitution, each and every individual has a right to live with peace, dignity and honour, therefore by allowing such type of petitions, we are encouraging the wrongdoers and somewhere, promoting the practice of bigamy, which is otherwise an offence under section 494, IPC, further violating the right of the other spouse and children under Article 21 to live with dignity.

"The concept of right to life and personal liberty guaranteed under Article 21 of the Constitution of India includes the right to live with dignity and the petitioners, by running away from their parental homes, are not only bringing a bad name to the families but also violating the right of the parents to live with dignity and honour," the court

The court further said, "Merely because two persons are living together for a few days, their claim of live-in relationship based upon a bald averment may not be enough to hold that they are truly in a live-in-relationship, and directing the police to grant protection to them may indirectly give our assent to such illicit relationship." #### KYS protests at DU VC's office against fee hike, poor study material

**NEW DELHI, July 27:** The Krantikari Yuva Sangathan (KYS), a students body, on Saturday staged a demonstration outside Delhi University vice-chancellor's office against a fee hike imposed in various courses.

The student's body representing working class and marginalised sections also accused the university of providing substandard study material to students of School of Open Learning (SOL).

Members of the students body gathered outside vice-chancellor Yogesh Singh's office while an DU Executive Council meeting was being held. They demanded that the fee hike be immediately withdrawn and the proposed study material be sent for re-evaluation. The Executive Council (EC). comprising of faculty members and officials of the university, met to deliberate and pass policy proposals concerning students.

## WHO calls for accelerated action against hepatitis

NEW DELHI, July 27: The World Health Organization on Saturday called on countries in Southeast Asia to urgently scale up efforts for providing universal access to prevention, vaccination, diagnosis and treatment of viral hepatitis B and C.

Despite being preventable and treatable, these chronic infections are increasingly causing serious illnesses and deaths from liver cancer, cirrhosis, and liver failure, it said. Liver cancer today is the fourthbiggest cause of cancer deaths in the region and the second-most common cause of cancer deaths among men, the World Health Organization (WHO) said in a statement.

Almost 75 per cent of liver cirrhosis is due to hepatitis B and C infection. In 2022, the region accounted for 70.5 million people living with viral hepatitis B and C.

Early testing and treatment can cure hepatitis C and prevent hepatitis B from causing liver cirrhosis and cancer and help reverse the predictions that liver cancer rates in Southeast Asia were set to double by 2050 to more than two lakh deaths an-

"We have the knowledge and tools to prevent, diagnose and treat viral hepatitis, yet people with chronic hepatitis B and C are still waiting to access the services they need. We need to accelerate efforts to deliver equitable services closer to communities, at the primary healthcare level," said Saima Wazed, the WHO's regional director for Southeast Asia, ahead of World Hepa-

The theme for this year's World Hepatitis Day, which will be observed on Sunday,



is "It's time for action"

Globally, hepatitis B and C combined cause 3,500 daily deaths, with 6,000 people newly infected with viral hepatitis each day. An estimated 254 million people are living with hepatitis B and 50 million with hepatitis C worldwide. Many people remain undiagnosed and, even when diagnosed, the number of people getting services and receiving treatment remains extremely low, Wazed said.

In 2022, about 1.3 million people died of viral hepatitis, the same as deaths caused by tuberculosis. Viral hepatitis and tuberculosis were the second leading causes of death among communicable diseases in 2022, after COVID-19.

coverage of hepatitis B and C testing and treatment remains low, Wazed said. Only 2.8 per cent people with hepatitis B were diagnosed and 3.5 per cent of those

In the WHO's Southeast Asia region, the

diagnosed received treatment in 2022. A mere 26 per cent and 14 per cent, respectively, of people with hepatitis C were diagnosed and treated, she said.

"We have safe and effective vaccines

that can prevent hepatitis B infection. Antiviral drugs are highly effective in controlling and preventing disease progression, managing chronic hepatitis B and curing most cases of hepatitis C. More needs to be done for these life-saving interventions to benefit each person, irrespective of who they are and where they live," Wazed said.

Hepatitis B and C affect the general population and specific populations such as those at higher risk of or with a history of exposure through unsafe blood supplies, unsafe medical injections and other health procedures; newborns and children at risk through mother-to-child transmission of hepatitis B and C, especially in settings with high viral hepatitis prevalence; indigenous populations and mobile and migrant populations from countries with higher prevalence; and key populations, including people who inject drugs, people in prisons and other closed settings, sex workers and men who have sex with men, who may be disproportionately affected in different contexts, the WHO official said.

As most people are unaware that they are infected with hepatitis B or C, access to testing and treatment needs to be expanded beyond larger hospitals or referral centres, she added.

Testing and treatment must be made accessible within the community, close to where people live and work, and included as part of universal health coverage, Wazed said. Accelerated coverage of testing and treatment will reduce development of liver cirrhosis and cancer, and ultimately, death, she added. (PTI)





With steady rain pouring before the start of the opening ceremony in the afternoon, some people also chose the next best place to enjoy -- the pubs which did a brisk business, playing loud music and serving them from the worldfamous cuisine.

Among the spectators was Andre Burgers, a bricklayer from Amsterdam, who travfamily to celebrate his birthday and witness the opening ceremony.

"It's excellent. It's raining outside, so we're inside. It's beautiful," Burgers told PTI.

"It's my birthday present. We have a weekend in Paris, and there is the opening ceremony. Nice atmosphere, all nationalities are here, and we are having a great time. The route also highlighted several Olympic venues, including the Esplanade des Invalides and the Grand Palais, before culminating at the Trothe Eiffel Tower.

The opening ceremony featured five categories of tickets along the river, ranging from 90 euros (Category E from starting point) to 3000 euros (the premium Category A, which was the culmination point). Two lakh of these tickets were given free to ensure that as many as possible could

experience the grandeur.

Many also chose to gather in fan zones and pubs to catch every moment of the action live on TV with their drinks, contributing to the lively atmosphere throughout the city.

## France dazzles world with colourful, vibrant Olympics opening ceremony

Paris turned into a colossal amphitheatre, and the iconic river Seine served as a track for the athletes' parade as France showcased its cultural diversity, spirit of revolution, impeccable craftsmanship and architectural heritage in a riveting opening ceremony for the 33rd Olympic Games here on Friday.

The spectacle started with a dreamy break from tradition as 'Parade of Nations' kicked off the proceedings in which athletes from 205 countries and one refugee team sailed down the Seine on boats despite heavy rain, in the run-up to and during the ceremony, threatening to play spoilsport. The ceremony also gave a sweet nod to 'Hindi as it was among the six languages used in infographics to pay tribute to the contribution of prominent French women during the segment titled 'sister-French President Emmanuel Macron declared the Games open, marking the formal beginning of competitions for the next 16 days. The highlight of the unconventional and daring opening ceremony was



without doubt the athletes'

march on the Seine river. The show began with camera panning to French President Emmanuel Macron and International Olympic Committee head Thomas Bach after World Cup-winning football legend Zinedine Zidane was shown sprinting down the streets of Paris with the Olympic flame in a prerecorded video. The six kilometer parade began from Austerlitz

bridge and 85 boats carried more than 6800 athletes amid loud cheers from the gathered crowd. A good number of athletes also skipped the incredible show due to their competitions on Saturday. The sequence of arrivals followed the French alphabetical order. The first to arrive was the Greek contingent, for being the spiritual home of

the Games, followed by the

Refugee team. France, as host

country, came last to a boister-

ous cheer from the home crowd. The 2028 Olympics host USA preceded France. Australia. which is hosting the 2032 Games came just before USA. The Indian contingent was led by two flag-bearers -- two-time Olympic medallist PV Sindhu and table tennis legend A Sharath Kamal and was 84th on the call sheet. The women in the contingent were draped in sarees, while the men sported the traditional 'kurta-payjama' in the colours of the national flag.

A total of 78 Indian athletes and officials participated in the ceremony. The boats passed through the iconic landmarks of the city such as the restored Cathedral of Notre Dame, which was gutted in a fire five years ago, the iconic Louvre Museum and also a few of the Games

In April 2019, the images of the Cathedral on fire and the fall of its spire had shocked the world. American Pop superstar Lady Gaga was among the first international artists to enthral the assembled crowd. The ceremony was helmed by artistic director Thomas Jolly. (PTI)

The 22-year-old, who hails from Jhajjar in Haryana, shot 580 in the qualifications in which Hungarian ace Veronika Major claimed the top spot with a score of 582. The other Indian in the field, Rhythm

Sangwan, ended 15th with an underwhelming 573.

Bhaker, who was in control for the major part of the one hour 15 minute session, will have to maintain the same composure in the all-important final. India has not won an Olympic medal in shooting since 2012 and Bhaker is well placed to end that lean run.

Standing at a distance, Bhaker's personal coach Jaspal Rana could not stop his tears before saying that the job was only half done. "What happened today

doesn't matter anymore. Tomorrow is when it counts. We start afresh," he told PTI before pointing out the heat factor at the range with the air conditioning not being the most effective.

"She needed to take time and drink a lot of water as it was hot," he added.

At the other end of the spectrum was Sarabjot Singh, who felt the pressure on his Games

debut to narrowly miss out on a final berth in the men's 10m air pistol. Both he and Arjuna Singh Cheema showed promise before finishing ninth and 18th with scores of 577 and 544 respectively.


