#### Law and Order

**GUWAHATI:** Chief Minister Himanta Biswa Sarma on Saturday announced that there has been a significant enhancement in the state's law and order situation since his administration assumed office. The chief minister disclosed that more than 60% of cases were chargesheeted in 2024, demonstrating the effectiveness of proactive measures, and the crime rate has been reduced by half. Taking to micro-blogging site X, Sarma stated, "The Law and Order situation in Assam has seen a stark improvement since we assumed office due to various proactive measures of our Govt. Over 60% cases have been chargesheeted in 2024, while crime rate has halved." Sarma attributed these improvements to a variety of strategic measures aimed at strengthening law enforcement and judicial processes.

#### Assamese language

**GUWAHATI:** Chief Minister Himanta Biswa Sarma announced on Saturday that the state government is actively endeavouring to pursue the recognition of Assamese as a Classical Language in India. Taking to micro-blogging site X, Sarma stated, "Presently there are 6 classical languages in India. We are actively taking up the matter of Assamese being also recognised as a Classical language." "We are working diligently to secure the status of a classical language for Assamese," the Chief Minister said while sharing a video on his post. The chief minister also mentioned that the Department of Culture, Government of India, recognizes languages as classical only if they meet certain fundamental criteria. Sarma further emphasised his commitment to this cause, highlighting his ongoing efforts to elevate the Assamese language.

#### Viksit Bharat

GUWAHATI: Chief Minister Himanta Biswa Sarma on Saturday announced that the state has implemented numerous strategic initiatives that will greatly support Prime Minister Narendra Modi's vision of a 'Viksit Bharat'. Attending the NITI Aavog's Governing Council meeting, he mentioned that Assam is currently one of the fastest growing states in the country. The state is prioritising investments in roads, health, and education infrastructure. Assam is currently undergoing the development of water supply assets worth ₹ 35,000 crore and the establishment of 13.000 new SSA classrooms. Sarma informed on micro-blogging site X. Additionally, initiatives are being implemented to reintegrate 81,000 out-of-school students and enhance renewable energy capacity to 3,000 MW. chairman of the Forest Development Board, KAAC, added that the CEM is progressing with the eviction process methodically. The steps taken so far include terminating the appointment letters of all Sarkari Gaon Buras (SGBs) in the PGR/VGR land, serving an eviction notice, and the CEM's recent visit to the area.

This year, the Karbi Anglong Autonomous Council (KAAC) decided to initiate an eviction drive to remove illegal settlers from the PGR/VGR land, which is home to over 2,000 families and more than 10,000 people. The total land area is 11,607 hectares and 16 losas.

Notably, a notice has been issued for eviction, and last week, the chief executive member (CEM) of the KAAC, along with elected members, visited the area and put up hoardings notifying that all encroachers would be evicted according to the law. Following the CEM's visit, some groups and individual leaders have pressured the KAAC to expedite the eviction process.

## India's maternal mortality rates declined from 384 in 2000 to 97 in 2020 India can guide developing nations craft maternal, child healthcare strategy: PMNCH

NEW DELHI, July 28: India can guide developing nations craft effective health programmes by sharing its long history of tackling maternal, child, and adolescent health challenges, Rajat Khosla, executive director, Partnership for Maternal Newborn and Child Health (PMNCH), said.

India, as one of the prominent leaders of the Global South, can play a crucial role in sharing best practices for improving health outcomes, Khosla in an exclusive interview told PTI.

"The nation's achievements in significantly reducing maternal mortality rates (MMR) and effectively implementing the Rashtriya Kishor Swasthya Karyakram (RKSK) across its vast and diverse landscape stand as exemplary models for other countries,"



Khosla said. India's MMR declined from 384 in 2000 to 97 in 2020, whereas the global MMR came down from 339 in 2000 to 223 in

2020

## SC to hear AAP leader Manish Sisodia's bail pleas today


NEW DELHI, July 28: The Supreme Court is scheduled to hear on Monday Aam Aadmi Party (AAP) leader Manish Sisodia's bail pleas in corruption and money laundering cases linked to the alleged Delhi excise policy scam.

The former deputy chief minister of Delhi has sought bail contending that he has been in custody for 16 months and the trial against him has not made any progress since October last year.

According to the cause list of July 29 uploaded on the Supreme Court website, a bench of Justices B R Gavai and K V Viswanathan is slated to hear Sisodia's pleas.

The apex court had on July 16 agreed to hear the pleas and sought responses from the Central Bureau of Investigation (CBI) and the Enforcement Directorate (ED).

Sisodia has also filed an application seeking revival of his bail peti-



tions in the excise policy-linked corruption and money laundering cases. The AAP leader was arrested by the CBI on February 26, 2023 in connection with alleged irregularities in the formulation and implementa-

tion of the now-scrapped Delhi excise policy 2021-22. The ED arrested him in the money laundering case stemming from the CBI FIR on March 9 last year. He resigned from the Delhi (CONTD. ON PAGE-2)


## Sanctioned capital of ₹1,33,576 cr Advancing 119 projects to boost output: Coal India

KOLKATA, July 28: Coal India Ltd is advancing 119 projects with a capacity of 896 million tonne per year and a sanctioned capital of ₹ 1,33,576 crore, the world's largest miner said.

These projects, which are at various stages of implementation, are part of CIL's "proactive strategy" to increase production capacity and meet future coal demands, the company said in its latest annual report.

Though the mining major did not specify a timeline for the capex, it said the development of these projects involves substantial investments in advanced mining technologies and infrastructure, aimed at enhancing productivity and ensuring sustainable mining practices.

Kolkata-headquartered The company has set an ambitious target of achieving 1 billion tonne of production by 2025-26 to fulfill the nation's coal demand and sup-



port the goal of 'Atmanirbhar Bharat'

In the 2023-24 fiscal, its production stood at 773.6 million tonne.

CIL said in 2023-24, one coal mining project with a sanctioned capacity of 20 million tonne and a sanctioned capital of ₹ 1,783.09 crore was completed, which

demonstrates "our ability to exe cute large-scale projects within the stipulated time frames"

During the financial year ended March 31, 16 coal mining projects with a total capacity of 170.46 million tonne per annum (incremental capacity of 85.66 MT) and a total sanctioned capital of ₹ 27,087.69

crore were approved, it said. As part of its comprehensive modernisation strategy, CIL is embracing latest equipment, advanced exploration and assessment techniques, efficient mine planning and development, and optimised extraction processes, the report

said. The company plans to procure high-capacity equipment worth more than ₹ 3,700 crore in the next financial year, aiming to bolster coal production capabilities for increased efficiency.

The mining major has set a capital expenditure target of ₹ 15,500 crore for the 2024-25 fiscal. In line with its investment plans, CIL intends to allocate a significant portion of funds to diversification projects, including solar power, thermal power plants, revival of fertilizer plants, surface coal gasification (SCG) and coal bed methane (CBM) during the year. KOLKATA, July 28: With more commercial mines being auctioned, the DGMS has started discussions with captive and commercial coal block operators on mine safety, an official said on Sunday

The Directorate General of Mines Safety (DGMS) emphasises ensuring adherence to safety norms among new players.

'We see more captive and commercial mines coming into production every year. So, we are actively engaging in consultation with the mine operators so that they understand the rules and regulations that have to be followed for mine safety," DGMS Director General Prabhat Kumar said at the Mines Safety Award 2024 event.

In the last nine rounds, the Ministry of Coal has auctioned 107 blocks with a peak-rated capacity of 256 MT. So far, 11 commercial coal blocks have been operationalised.

Meanwhile, Coal India, which is diversifying into the non-coal sector, will actively participate in more auctions of critical mineral blocks, including lithium, to capi-

## UK is 'broke and broken': New Govt

**DGMS focuses on mine safety** 

LONDON, July 28: Britain's new left-leaning government said Sunday that the nation is "broke and broken," blaming the situation on its predecessors ahead of a major speech on the state of the public finances that is widely expected to lay the groundwork for higher taxes.

In a sweeping assessment three weeks after taking power, Prime Minister Keir Starmer's office professed shock at the situation they inherited after 14 years of Conservative Party rule, while releasing a departmentby-department analysis of the perceived failures of the previous government

The critique comes a day before Treasury chief Rachel Reeves is expected to outline a 20-billion-pound (\$26 billion) shortfall in public finances during a speech to the House of Commons.

"We will not shy away from being honest with the public about the reality of what we have inherited," Pat McFadden, a senior member of the new Cabinet, said in a statement. "We are calling time on the false promises that British people have had to put up with and we will do what it takes to fix Britain." Starmer's Labour Party won a landslide election victory earlier this month following a campaign in which critics accused both major parties of a "conspiracy of silence" over the scale of the financial challenges facing the next government.

Labour pledged during the campaign that it wouldn't raise taxes on working people," saying its policies would deliver faster economic growth and generate the additional revenue needed by the government. The Conservatives, meanwhile, promised further tax cuts in the autumn if they were returned to office. As proof that the previous government wasn't honest about the challenges facing the country, Starmer's office pointed to recent comments from former Treasury chief Jeremy Hunt confirming that he wouldn't have been able to cut taxes this year if the Conservatives had been returned to power.

Those comments came in an interview with the BBC in which Hunt also accused Labour of exaggerating the situation to justify raising taxes now that they've won the election.

"The reason we're getting all this spin about this terrible economic inheritance is because Labour wants to raise taxes," Hunt said on July 21. "If they wanted to raise taxes, all the numbers were crystal clear before the election. ... They should have levelled with the British public." (AP)

Trump calls for US to be 'crypto capital of the planet



NASHVILLE, July 28: Former president Donald Trump on Saturday laid out his plans to wholeheartedly embrace cryptocurrency if elected for a second term, telling hundreds of cheering supporters of the digital tokens that he wants the U.S. to be a "bitcoin superpower' under his leadership.

In his keynote address at a bitcoin conference in Nashville, Tennessee, the Republican presidential ominee promised to make the United States the "crypto capital of the planet" and create a bitcoin "strategic reserve" using the currency that the government currently holds.

He also promised to remove Securities and Exchange Commission Chair Gary Gensler if elected and implement a crypto advisory council, teasing the crowd by asking attendees if anyone wanted to

"We will have regulations, but from now on the rules will be written by people who love your industry, not hate your industry," he said

Trump's keynote address at the Bitcoin 2024 conference showed how radically his position on cryptocurrency has changed over time. He was not always a fan of cryptocurrencies, writing on social media in 2019 that their "value is highly volatile and based on thin

Ulbricht created the underground drug-selling website Silk Road but was sentenced to life in prison after a judge held him reponsible for six overdose deaths linked to his website. Some of the nearly 800 attendees who flocked to downtown Nashville to hear Trump speak wore "Free Ross Day One" hats, in a nod to Ulbricht's prison sentence.

Tennessee's U.S. Sen. Marsha Blackburn called Trump's announcement of a bitcoin strategic reserve a "historic moment."

Trump's remarks came a day after independent presidential candidate Robert F. Kennedy Jr. addressed the conference and also pitched launching a strategic bitcoin reserve. (AP)

## Tax clearance certificate only for people with tax dues: Govt

Every person is not required to obtain a tax clearance certificate

NEW DELHI, July 28: After social media outrage over a Budget proposal making it mandatory to get tax clearance certificates for going abroad, the government on Sunday clarified that the proposed amendment is not for all, and only those accused of financial irregularities or having substantial tax arrears need such clearance.

The finance ministry, in the Finance Bill, 2024, has proposed to add the reference of the Black Money Act, 2015, to the list of Acts, under which any person should clear his liabilities to obtain the tax clearance certificate.

"The proposed amendment does not require all the residents to obtain the tax clearance certificate," the ministry said in a statement.

As per section 230 of the Income-tax Act, 1961, ture-tax Act, 1987, it added. (PTI)

every person is not required to obtain a tax clearance certificate. Only in the case of certain persons, in respect of whom circumstances exist, which make it necessary to obtain a tax clearance certificate will be required to obtain such a certificate

The ministry said that the Income Tax department through a 2004 notification has specified that the tax clearance certificate may be required to be obtained by persons domiciled in India only in certain circum-

These include - where the person is involved in serious financial irregularities and his presence is necessary in the investigation of cases under the Income-tax Act or the Wealth-tax Act and it is likely that a tax demand will be raised against him, or where the person has direct tax arrears exceeding ₹ 10 lakh outstanding against him, which have not been stayed by any authority.

The I-T department said that a person can be asked to obtain a tax clearance certificate only after recording the reasons for the same and after taking approval from the Principal Chief Commissioner of Income-tax or Chief Commissioner of Income-tax.

Such a certificate is required to be issued by the income-tax authority, stating that such person has no liabilities under the Income-tax Act, or the Wealth-tax Act, 1957, or the Gift-tax Act, 1958, or the Expendi-



The event was held at Soraipung, Dehing Patkai National Park, and the Lakhipather forest reserve area under the Digboi Forest Division of Tinsukia district.

The program was organised by the Wings of Nature Conservation Society in collaboration with Bagpackgo Adventures and Dehing Patkai Krishna Dorik Homestay, and co-powered by the Assam Forest Department, Dehing Patkai National Park, Northeast Birding Tours, and Green Buds Society. This initiative aims to raise awareness and promote sustainable eco-tourism through butterfly and biodiversity conservation. ## Threat to secular governance?

Trime Minister Narendra Modi's decision to lift the 44-year-old ban on government employees joining the Rashtriya Swayamsevak Sangh (RSS) and participating in its programs is more than a mere political manoeuvre to appease RSS chief Mohan Bhagwat. It signifies a deeper, more troubling shift in the governance and secular fabric of India. The July 9, 2024, notification, which overturns the ban imposed by Indira Gandhi in 1980, could fundamentally alter the nature of Indian governance. By allowing government employees to openly associate with the RSS, the move paves the way for the RSS to exert direct influence on state machinery and decision-making processes. This unprecedented access could undermine the neutrality and secular character of the state, embedding a communal bias into the very heart of Indian administration. Historically, the RSS has faced multiple bans due to its controversial activities. The first ban was imposed by Sardar Vallabhbhai Patel in 1948, following Mahatma Gandhi's assassination by Nathuram Godse, an RSS member. Patel described the RSS as an extremist group posing a threat to the state. Although the ban was lifted in 1949 after RSS chief M.S. Golwalkar's assurances of loyalty to the Constitution and renunciation of political ambitions, the organization has repeatedly violated these promises.

The recent order, therefore, raises significant concerns. The state administration, which once had to maintain a facade of neutrality, can now openly engage with the RSS. This shift could embolden officials to follow directives from the RSS headquarters in Nagpur without fear of repercussions, leading to a dangerous erosion of impartial governance. Furthermore, this policy exacerbates existing religious disparities within the government workforce. While Hindu employees can join the RSS, Muslim employees do not have equivalent rights to join their own religious or cultural organizations. This discrimination deepens the sense of alienation and marginalization among Muslim employees, already strained under Modi's administration. The implications of this policy extend beyond mere bureaucratic adjustments. The RSS's vision of transforming India into a Hindu Rashtra aligns disturbingly with Modi's recent actions. An administration devoid of secular commitments would facilitate this vision, undermining the constitutional principle of Indian nationalism in favor of Hindu nationalism.

The military, known for its multicultural ethos, is also at risk. Efforts to integrate religious texts into military training and the politicization of military achievements are part of a broader strategy to align the armed forces with the RSS's ideological goals. Modi's controversial Agniveer scheme, which leaves the majority of short-term military recruits without long-term employment, could contribute to the formation of a militarized social force loyal to the RSS. The involvement of senior bureaucrats with RSS leanings, exemplified by officials participating in RSS events, further illustrates the deepening nexus between the state and the RSS. This trend is not merely about personal political affiliations but represents a systemic shift towards an ideologically driven administration. Modi's move to lift the ban on government employees joining the RSS is a significant step toward redefining India's governance and secular identity. It represents an overt attempt to align the state apparatus with a particular ideological framework, posing a serious threat to the country's democratic and secular values. The long-term consequences of this policy could fundamentally alter the nature of Indian governance, eroding the principles of impartiality, inclusiveness, and constitutional integrity that have long underpinned the Indian state.

shift of responsibilities of their production of labour force from the capitalist employer to the State through the denial of indirect wage payments to workers.

One of the major achievements of labour movement in the past was the recognition of elements as constituents of wage and benefits that ensured the reproduction of labour force in its totality. The underlying spirit was wages should not only cover the immediate needs of the worker but also should at the minimum be enough to maintain the intergenerational supply of a healthy workforce and the labour force not currently absorbed at work. This was required by capitalism to ensure the supply of workers in future.

In other words, wage determination should include apart from the necessities of direct workers, expenses to sustain other non-working family members, unemployed, including children and old parents. At a societal level this means the wages and salaries of active workers should be enough to take care of the unemployed, children, diseased and elderly members of the society.

Under neoliberalism this accepted rationale for wage determination is turned upside down and the idea of permanent employment is being replaced by the notion of flexibilised work regime. Besides few core workers there would be a vast periphery of unprotected or even unrecognized workers contributing paid or unpaid work to the process of accumulation.

The wage determination is reformed in a way that payments to workers should at least cover the immediate necessities of the labour for a short period of time. Calculation of wages, in this case, neither factor in the long-term sustenance of the employed worker nor the maintenance of their family members. The workers are in a continuous state of flux, they move from one place to another, they work with different employers and also with the same employer but with intermittent contracts

a multinational corporation operating through some opaque technological Economic Policy and Labour algorithm which is completely inaccessible to the worker

The radical shift towards the new regime of contractualisation and casualisation of workforce operationalised through domestic and global value chains not only increases the control of capital over the

process but also drastically reduces capital's cost of sustaining an overinflated reserve army of labour. The pay ment to the worker in

labour

the point of production completely denies the claims of indirect wages. Such payments in addition to covering immediate requirements of the working population could have actually helped in reproducing the intergenerational stream of labour and also maintaining the reserve army of labour.

True, that every capitalist crisis not only alters the composition of fixed capital but also redistributes the existing reserve army of labour by sectors, regions and occupations. But there is also a continuous process of replacing active workers by machines embedded in new technology which also recreates the reserve army of labour. This recreation of structural unemployment is important in capitalism to contain wages in periods of high growth because as the labour market approaches full employment the bargaining power of workers increases which tend to reduce capitalists' profits. The question now is the cost of maintaining the reserve army of labour

More importantly with rising cap-

would very much like to realise but that is actually a state of extinction of capitalism altogether because all source of surplus value is living labour and without that capitalism cannot exist.

The reserve army of labour was earlier maintained by the wages and security benefits paid to existing workforce. With contractualisation and flexibilisation of labour process

and rising outsourcing and offshoring, the employers have been able to deny the responsibility of bearing the cost of subsistence of

the unem-

ployed, old and children. But because capitalist development is always uneven the pace of technological development and hence the pace of labour substitution in different sectors is not uniform and the dynamics of the expansion and contraction of the aggregate reserve army of labour varies with the relative labour requirement

of sectors and related distribution. Now the cost of reproducing the potential labour force is being shifted to the workers. There might be some transfer of accumulated surplus to people mediated by the State through various micro-welfare schemes but the decline of the labour's share in the aggregate pie across countries show that the reserve army of labour expands with a reduced share of wages and salaries. Also, government revenue includes indirect taxes which is a deduction from the consumption fund of the working people.

The contradictory processes of capitalist accumulation accelerated through technological development gives rise to a contradictory division between the active and reserve labour

So, it is a bipolar outcome: vast mass of jobless and those who work have to produce more both physically and intellectually.

The simple reason being, in capitalism, work or employment is meaningful only when it produces surplus for the property owners. A more rational and humane society could have resolved the impact of new technology in a radically different way.

Machines allow humans to produce more with the same inputs, if that is the case, logically, use of technology should generally reduce direct labour time. In other words, the same GDP can be produced with less direct labour time or all should actually work less while all would be employed at the same time.

If the time necessary to produce our needs declines due to use of technology, human beings would be spending more time according to their choice and hence would be more productive. But this does not happen in capitalism as all the means of production are owned by the few capitalists who use technology to reduce the value of labour in order to generate higher amounts of surplus.

Technology instead of making vast number of labour redundant, in a different social setting, could have employed them for lesser hours of work and enhanced social disposable time which could have generated much more output for the society as a whole. In capitalism, on the contrary, use of technology and fragmentation of work process would reduce the value of labour power, will increase the number of jobless people, will shift the burden of maintaining the augmented reserve army of labour to the workers and finally intensify the rate of exploitation for the employed workforce. But this also creates the objective condition necessary to bringing together various segments of the working population: worker, unpaid workers and the redundant population in becoming a class

## Is stage 3 breast cancer curable? What causes upper stomach pain?

Thile advanced stages of cancer may not be completely curable, with timely awareness, appropriate diagnosis and medical intervention, vou can try to tackle the symptoms and prolong your life span, points out Dr Pritam Kataria, consultant, medical oncology at the Sir H N Reliance Foundation Hospital. Breast cancer is one of the most common types of cancer in India, with more women being diagnosed with it than men. Globally too, the incidence of breast cancer is rising.

Self-examination, early diagnosis and mammography are some of the ways to detect and confirm if you have underlying symptoms. However, in most cases, women do not seek help until the cancer reaches its later stages

In 2002, veteran actor Mumtaz was diagnosed with breast cancer. She was 54 and was able to recover after multiple rounds of radiation and chemotherapy

In September 2018, actor Ayushman Khurrana's wife Tahira Kashyap, was diagnosed with Stage 0 breast cancer (this is in the pre-cancer stage, affects the milk duct and is non-invasive). She underwent a mastectomy (removal of the breast) and later wrote a book documenting her journey to recovery.

Last week, actor Hina Khan - who is just 36 years old - announced that she has been diagnosed with Stage 3 breast cancer. While the news came as a shock, there were many who wondered why her cancer remained

undetected for so long. More importantly, people want to know: Is breast cancer curable at Stage 3?

While advanced stages of cancer may not be completely curable, with timely awareness, appropriate diagnosis and medical intervention, you can try to tackle the symptoms and prolong your life span. Dr Pritam Kataria, consultant, medical oncology at the Sir HN Reliance Foundation Hospital, answers some of the most frequently asked questions about breast cancer:

What are the warning signs of breast cancer that women should not ignore?

The most common symptom of breast cancer is a new lump or mass in the breast; however, not all such lumps are signs of cancer. A painless, hard mass that has irregular edges is more likely to be cancer. But breast cancers can be also soft, round, tender or even painful.

Other possible symptoms of breast cancer include:

• Swelling of all or part of a breast (even if no lump is felt)

· Skin dimpling (sometimes looking like an orange peel)

· Breast or nipple pain

• Nipple retraction (turning inward)

• Nipple or breast skin that is red, dry, flaking or thickened nipple discharge (other than breast milk)

• Swollen lymph nodes under the arm or near the collarbone (Sometimes this can be a sign of breast cancer spreading even before the tumour in the breast is large enough to be felt.)

A mammogram is an X-ray examination of the breast. It is used to detect and diagnose breast disease in women who have breast problems.

Breast cancer: How to do a self- such as a lump, pain or nipple discharge, as well as for women who have no breast complaints. The procedure allows the detection of breast cancers, benign tumours and cysts before they can be detected by palpation

Can breast cancer be treated/cured?

Yes, it can. There are typically five different stages of breast cancer, depending on the size and severity of the tumour. The risk of treatment and survival increases with each stage. Stage 0 is one of the most difficult

to detect due to poor symptoms. In stages 3 and 4, the tumour has probably grown in terms of size but may or may not have spread to other organs. In advanced stages, the tumour may have spread to other organs including the lungs, liver and the brain. Based on the severity of symptoms and size of the tumour, there are two

types of treatment -- local therapy and systemic therapy. Local therapy includes radiation therapy and surgery. Systemic therapy includes chemotherapy, targeted therapy, immunotherapy and hor-

monal therapy. In most cases where women are diagnosed with stage 1, 2 or 3 of breast cancer, it can be cured with surgery

#### Using technology to support healthy childhoods

They are examining family routines at home in great detail to understand exactly what is happening in the hours before bedtime. For example, technology could be used as part of 'family time', it could be used alone or with siblings. Parents may find it relaxes their children or alternatively wakes them up. Researchers are also looking very carefully at the type and timing of light emitted by digital devices used by children, in the context of the

tem. Children have strong body clocks, but are also very sensitive to light. The type of light emitted by devices, often quite blue light, seems especially powerful in its effects. This can lead to later sleep times, disruption of the body clock and increased risk of health problems.

The second theory is about displacement. Using technology at night is an additional, and often very engaging, activity. Spending time on screens makes it harder to fit in dinner, a bath, reading time or a regular bedtime wind-down routine. This can mean that sleep is pushed later just to fit everything else in.

This is hardly a new idea - it's likely today's parents were yesterday's children reading books by torchlight under the covers. The third theory is about the conflict between the technology-based activity itself and the need to relax and drift off to sleep. Some digital content can increase attention and focus. Some of it can be distressing, confusing or upsetting. If this is happening in the hours before bedtime, then it is another signal to delay sleep time. The challenge here is to measure and understand these emotional aspects of digital content, how it is used and how it is experienced by children

How to help your kids get a better night's sleep

It's now understood that sleep is just as important as diet and exercise for children's development and wellbeing. And research has revealed some of the

How is digital technology affecting our kids' sleep

wellbeing challenges. It is still not clear exactly how technology can impact kids' sleep, but researchers have some ideas to test out.

What role does technology play in your home?

Technology is not a new visitor to our homes. It has been evolving over time — at least from the advent of artificial lighting to radio, television, gaming consoles and podcasts. Even more traditional activities such as reading might have sometimes carried on into the night.

Kids' sleep has been a concern of parents right across this period. Children's sleep can be perplexing because it changes so much from birth through to the teenage years. The development from the almost 24-hour, anytime sleep of babies, through to regular naps in toddlers, then the end of daytime naps happens at different times for different children.

Children need a lot more sleep than adults do, and getting enough sleep at the right time can be challenging when there are a lot of demands on the time of children and their families.

Children and young people grow up in all sorts of different environments, places and circum-

While the light emitted by screens may be a concern, the role of bright artificial lighting in the home and other light sources such as TVs and street lighting also needs to be considered.

Parents and carers also need to think about light during the day: in the home, early education settings or at school. It is possible that some children aren't getting enough light at the right times. The timing of light sends important signals to our bod-

We expect relatively bright days and dark nights. It is more common now to experience relatively dim days, with little outdoor light, and artificial lighting in the home or from the street extended well after sunset.

How technology can make kids' sleep worse There are three main theories about the ways

technology might make kids' sleep worse. The first is increased exposure to light in the evening. Most screens emit light and some devices are held quite close to our eyes. Our internal body clocks, or circadian rhythms, more or less depend on bright days and dark nights to keep time. Light at night, even in small doses, can surprise this sys-

fundamentals of good sleep: a safe and secure bedroom environment, not too hot or cold, not too noisy, and nice and dark is a good starting point. A regular wake-up time and a regular bedtime routine help set and reinforce our body clocks. Researchers are also thinking of ways to use technology to help rather than hinder kids' sleep.

For example, technology could include alerts about bedtime and winding down time for children. It could suggest 'pro-sleep' content that isn't going to hype them up or upset them just before they need to fall asleep.

Technology could interact with smart homes and adjust lighting levels to reinforce sleep and wake times automatically. It could also be used to connect networks of young 'sleep champions' together or it could involve new programs for children to learn experiment and collaborate in developing better sleep habits.

There's never going to be a one-size-fits-all answer to helping our kids get a better night's sleep but there are things parents can do to help that don't involve ridding their homes of all digital devices. (Courtesy: Down To Earth)

## Understanding brain stroke: Essential strategies for prevention and treatment

T troke, often termed a "brain attack," ranks as the second most com-S mon cause of mortality after heart attacks and stands as the leading cause of disability. It affects one in every four person once in their lifetime.

This medical emergency occurs when blood flow to part of the brain is disrupted, depriving brain tissue of oxygen and nutrients. Without immediate medical attention, brain cells can begin to die within minutes. Therefore, a thorough grasp of stroke prevention, diagnosis, and treatment is crucial in reducing both the frequency and impact of this critical health emergency. Prevention

Stroke prevention primarily involves addressing risk factors and adopting a healthy lifestyle. Many strokes can be prevented through modifications in diet, exercise, and managing medical conditions. Adopting a healthy lifestyle is fundamental to stroke prevention. This includes a balanced diet rich in fruits, vegetables, whole grains, and lean proteins while limiting salt, sugar, and saturated fats to maintain healthy blood pressure and cholesterol levels

Regular physical activity like brisk walking, swimming, or cycling helps keep a healthy weight and improve cardiovascular health. Quitting smoking significantly reduces stroke risk by preventing blood vessel damage and high blood pressure. Moderation in alcohol consumption is also important.

Medical management is vital for stroke prevention. Controlling blood pressure through regular monitoring and medication is crucial. Managing diabetes by keeping blood sugar levels under control also reduces stroke risk. Additionally, lowering high LDL cholesterol levels, which can lead to plaque buildup in arteries, is important.

#### Diagnosis

Prompt diagnosis of a stroke is critical for effective treatment and improving outcomes. The quicker a stroke is identified and treated, the better the chances of minimizing brain damage. The acronym "BEFAST" helps remember the sudden signs of a stroke: B for balance problems, E for eye vision or double vision issues, F for facial asymmetry, A for arm weakness,

S for speech disturbances, and T for time. If any of these symptoms are noted, it is crucial not to delay and to immediately transfer the patient to a stroke-ready facility. The golden period for effective medical therapy has been extended to 4.5 hours from onset of symptoms, and for clot retrieval procedures, it can extend up to 24 hours. Acting swiftly within these time frames significantly enhances the chances of minimizing stroke-related damage and improvingpatient outcomes.

#### Assessment of different types of strokes

Strokes are broadly categorized into two types based on their underlying causes: ischemic strokes, which account for approximately 80% of cases and occur due to blockage or narrowing of blood vessels supplying the brain; and haemorrhagic strokes, constituting about 20% of cases, which result from the rupture of a blood vessel in the brain.

Imaging tests, such as CT scans or MRIs, are used to determine the type of stroke and assess the extent of brain damage. Blood tests can identify conditions that increase stroke risk, like high cholesterol, elevated blood sugar levels, and blood clotting issues. An electrocardiogram detects heart conditions that may have contributed to the stroke.

#### Treatment

For an ischemic stroke, treatment includes clot-busting medications or mechanical thrombectomy. Thrombolytics, such as tissue plasminogen activator, can dissolve the clot if given within a few hours of symptom onset. Mechanical thrombectomy involves using a catheter to remove the clot from the blocked artery, typically within six hours of symptom onset.

For a haemorrhagic stroke, treatment approaches differ. Surgery, such as aneurysm clipping or arteriovenous malformation repair, can help stop the bleeding. Medications to lower blood pressure, control bleeding, and prevent seizures may also be administered. While strokes remain a significant health threat, understanding and managing risk factors, recognizing symptoms, and seeking immediate treatment can improve outcomes. A commitment to a healthy lifestyle and regular medical check-ups is key to prevention, and rapid response is essential for effective treatment. ## Strike on Israeli Golan Heights kills 11 and threatens to spark a wider war

TEL AVIV, July 28: A rocket strike Saturday at a soccer field killed at least 11 children and teens, Israeli authorities said, in the deadliest strike on an Israeli target along the country's northern border since the fighting between Is-rael and the Lebanese militant group Hezbollah began. It raised fears of a broader regional war.

Israel blamed Hezbollah for the strike in the Israeli-controlled Golan Heights, but Hezbollah rushed to deny any role. Israeli Prime Minister Benjamin Netanyahu warned that Hezbollah "will pay a heavy price for this attack, one that it has not paid so far." The Israeli military's chief spokesman, Rear Adm. Daniel Hagari, called it the deadliest attack on Israeli civilians since the Hamas attack on October 7 that sparked the war in Gaza. He said 20 others were wounded.

'There is no doubt that Hezbollah has crossed all the red lines here, and the response will reflect that," Israeli Foreign Minister Israel Katz told Israeli Channel 12. "We are nearing the moment in which we face an all-out war."

Hezbollah chief spokesman Mohammed Afif told The Associated Press that the group "categorically denies carrying out an attack on Majdal Shams." It is unusual for Hezbollah to deny an attack.

Lebanon's government, in a statement that didn't mention Majdal Sham, urged an "immediate cessation of hostilities on all fronts" and condemned all attacks on civilians.

Hamas' attack on October 7 killed some 1,200 people and took 250 others hostage. Israel's offensive has killed more than 39,000 people, according to local health authorities.

Since early October, Israeli airstrikes in Lebanon have killed more than 450 people, mostly Hezbollah members, but also around 90 civilians and non-combatants. On the Israeli side, 44 have been killed, at least 21 of them soldiers. (AP)

Bangladesh witnessed violent clashes between the police and mostly student protesters demanding an end to a controversial quota system that reserved 30 per cent of government jobs for relatives of veterans who fought in Bangladesh's War of Independence in 1971.

The internet and mobile services were snapped following the countrywide violence.

On Monday last, the apex court slashed the veterans' quota to just per cent. Thus, 93 per cent of civil service jobs will be meritbased while the remaining 2 per cent reserved for members of ethnic minorities, transgender and physically challenged people.

The violence has reportedly killed more than 100 people, according to local newspapers. However, there are no official figures available for deaths.

Prime Minister Sheikh Hasina on Tuesday defended her decision to enforce a curfew with a shooton-sight order following the clashes, asserting that tough measures were taken to ensure the security of the lives and properties of the people.

## EAM Jaishankar holds talks with US Secretary of State Blinken in Tokyo

TOKYO. July 28: External Affairs Minister S Jaishankar on Sunday held "wide-ranging" talks with his American counterpart Antony Blinken against the backdrop of an unease in India-US ties following Prime Minister Narendra Modi's visit to Russia three weeks back.

Both Jaishankar and Blinken are in Tokyo to attend a meeting of foreign ministers of fournation grouping Quad or Quadrilateral coalition. The talks between the external affairs minister and the US secretary of state also came amid Washington consistently seeking accountability from New Delhi in the case relating to the alleged foiled plot to kill Sikh extremist Gurupatwant Singh Pannun in New York.

It is not immediately clear whether Prime Minister Modi's visit to Russia and the murderfor-hire plot figured in the Jaishankar-Blinken talks. In a post on 'X', Jaishankar said he and Blinken had a wide-ranging discussion on regional and global issues.

"Great to catch up with @SecBlinken in

Tokvo today," he said.

"Our bilateral agenda progresses steadily. Also had a wide ranging discussion on regional and global issues," Jaishankar added.

It is learnt that the Russia-Ukraine conflict and the overall situation in Gaza figured in the talks. The US and several of its allies were outraged over the timing of Modi's July 8 to 9 visit to Moscow as it coincided with the NATO summit in Washington. Some Western capitals were also learnt to be peeved over Modi choosing Russia for his first bilateral trip in his third term.

US Assistant Secretary of State for South and Central Asia Donald Lu told a US Congressional hearing on Tuesday that the US was disappointed by the "symbolism" and "timing" of Modi's visit to Russia.

The Biden administration official especially highlighted that the Indian prime minister paid the visit to Moscow when Washington was hosting a summit of the North Atlantic Treaty Organisation (NATO).

New Delhi on Thursday rejected Lu's comments and asserted that all countries have the "freedom of choice" in a multipolar world and everyone should be mindful of such realities.

Meanwhile, India and Ukraine are planning a visit to Kyiv by the Indian prime minister next month. The India-US ties also came under some unease following the alleged murder-for-hire

In November last year, US federal prosecutors charged Indian national Nikhil Gupta of working with an Indian government employee in the foiled plot to kill Pannun in New York. Pannun, wanted in India on terror charges.

## Venezuelan election could lead to seismic shift in politics Sunday's ballot also features eight other candidates challenging Maduro

CARACAS, July 28: Polls have opened in Venezuela, where people are voting Sunday in a presidential election whose outcome will either lead to a seismic shift in politics or extend by six more years the policies that caused the world's worst peacetime economic collapse.

Whether it is President Nicolás Maduro who is chosen, or his main opponent, retired diplomat Edmundo González, the election will have ripple effects throughout the Americas. Government opponents and supporters alike have signalled their interest in joining the exodus of 7.7 million Venezuelans who have already left their homes for opportunities abroad should Maduro win another term.

Polls open at 6 am local time. The number of eligible voters is estimated to be around 17 million.

Authorities set Sunday's election to coincide with what would have been the 70th birthday of former President Hugo Chávez, the revered leftist firebrand who died of cancer in 2013, leaving his Bolivarian revolution in the hands of Maduro. But Maduro and his United Socialist

Party of Venezuela are more unpopular than ever among many voters who blame his policies for crushing wages, spurring hunger, crippling the oil industry and separating families due to migration.

Maduro, 61, is facing off against an opposition that has managed to line up behind a single candidate after years of intraparty divisions and election boycotts that torpedoed their ambitions to topple the ruling party

González is representing a coalition of opposition parties after being selected in April as a last-minute stand-in for opposition powerhouse Maria Corina Machado, who was blocked by the Maduro-controlled Supreme Tribunal of Justice from

running for any office for 15 years. Machado, a former lawmaker, swept the opposition's October primary with over 90% of the vote. After she was blocked from joining the presidential race, she chose a college professor as her substitute on the ballot, but the National Electoral Council also barred her from registering. That's when González, a political newcomer, was chosen.

ens Maduro's rule. Venezuela sits atop the world's largest proven oil reserves, and once boasted Latin America's most advanced economy. But it entered into a free fall after Maduro took the helm. Plummeting oil prices, widespread shortages and hyperinflation that soared past 130,000% led first

to social unrest and then mass emigration.

Sanctions from US President Donald Trump's administration seeking to force Maduro from power after his 2018 reelection which the US and dozens of other countries condemned as illegitimate - only deepened the crisis.

In recent days, Maduro has crisscrossed Venezuela, inaugurating hospital wards and highways and

visiting rural areas where he had not set foot in years. His pitch to voters is one of economic security, which he underscores with stories of entrepreneurship and references to a stable currency exchange and lower inflation rates. The capital, Caracas, saw an in-

crease in commercial activity after the pandemic, bolstering an economy the International Monetary Fund forecasts will grow 4% this year - one of the fastest in Latin America - after having shrunk 71% from 2012 to 2020.

'They tried to subjugate our people," Maduro said of the United States during his closing rally Thursday in Caracas, "but today we are standing tall and ready for victory on the 28th of July.'

But most Venezuelans have not seen any improvement in their quality of life. Many earn under \$200 a month, which means families struggle to afford essential items. Some work second and third jobs. A basket of basic staples - sufficient to feed of family of four for a month costs an estimated \$385.

The opposition has tried to seize

on the huge inequities arising from tured lively electronic merengue the crisis, during which Venezuelans abandoned their country's currency, the bolivar, for the U.S. dollar. González and Machado focused much of their campaigning on Venezuela's vast hinterland, where the economic activity seen in Caracas in recent years didn't materialize. They promised a government that would create sufficient jobs to attract Venezuelans living abroad to return home and reunite with their families.

An April poll by Caracas-based Delphos said about a quarter of Venezuelans were thinking about emigrating if Maduro wins Sunday. The poll had a margin of error of plus or minus 2 percentage points. Most Venezuelans who migrated over the past 11 years settled in Latin America and the Caribbean. In

recent years, many began setting their sights on the US. Both campaigns have distinguished themselves not only for the political movements they represent but also on how they have addressed voters' hopes and fears.

Maduro's campaign rallies fea-

dancing as well as speeches attacking his opponents. But after he caught heat from leftist allies such as Brazilian President Luiz Inácio Lula da Silva for a comment about a "bloodbath" should he lose, Maduro recoiled. His son told the Spanish newspaper El Pais that the ruling party would peacefully hand over the presidency if it loses - a rare admission of vulnerability out of step with Maduro campaign's triumphalist tone.

In contrast, the rallies of González and Machado prompted people to cry and chant "Freedom! Freedom!" as the duo passed by. People handed the devout Catholics rosaries, walked along highways and went through military checkpoints to reach their events. Others video-called their relatives who have migrated to let them catch a glimpse of the candidates.

During a rally in mid-May, González, 74, asked supporters to imagine "a country in which our airports and borders would be filled with our children returning home". (AP)

IMPHAL, July 28: The directorate of fisheries, Manipur, has taken up River Ranching programme in 12 major rivers viz, İmphal, Nambul, Thoubal, Nambol, Barak, Chakpi, Iril, Irang, Makru, Khuga, Maha and Sekmai in 7 districts of Manipur by liberating Indian Major carp (Rohu, Mrigal and Catla) and indigenous fish species (Pengba, Ngaton and Khabak)

NEW DELHI, July 28: The Congress on Sunday called for fixing accountability over the death of three IAS aspirants due to waterlogging in a building in Delhi with Rahul Gandhi asserting that common people are paying the price for irresponsibility of institutions at every level

The three civil services aspirants died after the basement of the building housing a coaching centre in central Delhi's Old Rajinder Nagar area was flooded following heavy rain. Congress president Mallikarjun Kharge said it is very sad that three youths lost their lives due to waterlogging in the basement of an IAS coaching centre in the capital due to the "criminal negligence of the government and administration'

"Our deepest condolences to the bereaved families," he said.

Earlier, another UPSC aspirant died due to electric shock after waterlogging in Patel Nagar, he said.

"According to reports, eight people have lost their lives due to electric shock in the last few days. The Congress had made Delhi an international city. Today, the capital of India is suffering from indifference. Accidents keep happening every day," the Congress chief said

"We demand strictest actions against all those responsible for allowing such a disaster to take place," Venugopal said on X.

Congress media and publicity department head Pawan Khera said this is a man-made disaster.

"The students had come from far-off places to study in Delhi. But what is the system of filtering out illegal structures from legal structures? Is the MCD looking into it? What about the drainage system? All these questions plague these controversies around these deaths," he said.

Last week, a student died after touching a live wire, he said.

Is this how students coming to Delhi should be treated, Khera asked.

NEW DELHI, July 28: A private member's bill, seeking to promote rational thought, critical thinking and evidence-based decision-making in society, has been introduced in the Lok Sabha by a Congress MP.

Benny Behanan, the MP from Kerala's Chalakudy, on Friday introduced The Promotion of Rational Thought Bill, 2024 which envisages the constitution of a Board -- to be known as the Board for the Promotion of Rational Thought and Critical Thinking -for the implementing the provisions of the proposed act. Behanan said there is an urgent need for promoting rational thought in the wake of rising superstitions in the society.

"At a time when the prime minister is talking about being non-biological and rational thinking not being promoted since 2014, this bill is of critical importance," he told PTI.

It was India's first prime minister Jawaharlal Nehru who promoted rational thought and a scientific temper, the Congress MP said.

Critical thinking and divergent views are not encouraged since the BJP came to power because the PM and his party have promoted irrational thought and superstitions, Behanan alleged.

In its statement of objects and reasons, the bill states that rational thought and critical thinking are the bedrock of a progressive and informed society.

In recognising the fundamental importance of fostering intellectual curiosity, logical reasoning, and evidence-based decision-making, the bill seeks to emphasise the integration of curricula and teaching methodologies in educational institutions that focus on nurturing critical thinking skills, logical reasoning, and scientific inquiry, the statement says.

It calls for fostering an environment that encourages questioning and analysis aimed to empower individuals with the tools necessary for sound decision-mak-

The bill also seeks to promote the use of empirical evidence and rational analysis in government policies, public programmes, and societal initiatives.

It calls for cultivating a culture that values intellectual discourse, respectful debate, and open-mindedness by encouraging individuals to engage in constructive conversations based on reason and evidence, and seeks to build a society that celebrates diverse perspectives while upholding the principles of rational thought. ## **Congress calls for thorough** impartial review of Great Nicobar infrastructure project

NEW DELHI, July 28: The Congress on Sunday termed the proposed Great Nicobar infrastructure project an "environmental and humanitarian disaster" and called for its thorough impartial review, including by the parliamentary committees concerned.

Congress general secretary Jairam Ramesh shared a media report on X which claimed that a high-powered committee (HPC), appointed by the National Green Tribunal (NGT) and tasked with revisiting the green clearance for the Great Nicobar infrastructure project, has concluded that a proposed transshipment port does not fall in the Island Coastal Regulation Zone-IA (ICRZ-IA), where ports are prohibited, but is in ICRZ-IB where these are permitted.

In a post on  $\hat{X}$ , Ramesh said, "These are simply games being played at the behest of the Sutradhar, who is pushing for this environmental and humanitarian dis-

aster that the Great Nicobar Mega Infra Project is."

"Several questions arise -- How can land categorisation change like this? Surely, some sanctity must be given to the local authority -- the Andaman and Nicobar Coastal Management Authority, which knows more of ground-level realities -- than to some 'expert' body that can be manipulated?" he said.

What is the new information available to Andaman and Nicobar Islands Integrated Development Corporation (ANI-IDCO) and to the National Centre for Sustainable Coastal Management (NCSCM) that they have managed to overturn everything that was said thus far and change the categorization of the land, Ramesh asked.

He asked about the due process for such recategorisation.

"More details need to be made available about the activities of the NCSCM. When did they visit the Nicobar Islands? What methods did they employ to gather their information? When will the NSCSM report be made public?" he said

Ramesh asked when the HPC report to the National Green Tribunal will be made public.

"There needs to be a thorough impartial review of this proposed project, including by the Parliamentary committees concerned," the Congress leader said. (PTI)

KOLKATA, July 28: Legendary freedom fighter Subhas Chandra Bose's grandnephew Chandra Kumar Bose on Sunday appealed to Prime Minister Narendra Modi to bring back the "mortal remains of Netaii" from Japan's Renkoji temple by August 18.

He also said a final statement should come from the central government on the matter so that "false narratives" about Netaii are laid to rest.

Stating that the NDA-led government took initiative to declassify files related to the freedom fighter, Bose said after the release of all the "10 inquiries - national and international", it is evident that "Netaji perished on August 18, 1945" in an air crash in Taiwan

"It is therefore imperative that a final statement is made from the Government of India so that false narratives about the liberator of India are laid to rest," Bose wrote in a letter to Modi on Sunday.

"My humble appeal to you is to bring back the mortal remains of Netaji from Renkoji to India by August 18, 2024," he said.

In an interview to PTI Videos, Bose, also a former vice president of the West Bengal BJP. said the declassification process has exposed secret files and documents, "which conclusively establish that Netaji died in this air crash on August 18, 1945".

He said that Netaji wanted to return to India after Independence, but could not as he died in the air crash

"The... Justice Mukherjee Commission of Inquiry 2005 finding that Netaji did not die in the said air crash was found to be based on fundamental errors and the Government of India thus rejected it," Bose said

Maintaining that an array of "unscrupulous persons" found plenty of scope and opportunities for exploitation over the issue, he said from around the mid-1960's began the phenomenon of the re-appearance of Netaji. (PTI)

# Delhi coaching centre deaths: Owner and coordinator arrested, officials say norms flouted

NEW DELHI, July 28: The owner and the coordinator of a coaching centre where three civil services aspirants died due to rain-induced flooding in the basement were arrested on Sunday even as protests erupted in the area over the incident.

According to officials, the coaching institute had permission to use the basement as a store room, but it was being used as library which is a violation of the rules.

Delhi Mayor Shelly Oberoi directed MCD commissioner to take strict action against institutes that are using basements for commercial purposes in violation of building bye-laws and against any officers responsible for the incident.

Delhi Fire Service chief Atul Garg said the institute was functioning in violation of the norms of the fire department.

"The building has fire NOC, but in the NOC they had shown the basement will be used as store room. The management of the institute was using the same room as a classroom or library which is a violation of the NOC," Garg told PTI. The arrested accused have been

NEW DELHI, July 28: Climate entirely administered by bureauactivist Soman Wangchuk announced on Sunday that he will launch another 28-day fast on Independence Day if the government does not invite Ladakh authorities for talks on demands for statehood and constitutional protection for the union territory.

In an interview with PTI, Wangchuk said that the Apex Body, Leh (ABL), and the Kargil Democratic Alliance (KDA) from Ladakh submitted a memorandum of demands to Prime Minister Narendra Modi during his visit to Dras on the occasion of the 25th anniversary of the Kargil Vijay Diwas last week.

"We did not want to push the government too much during the elections; we were hopeful that the new government would take some concrete steps. If they do not heed our request, if they do not call us for talks, we will launch another round of protest from August 15," he told PTI.

In March, Wangchuk went on a 21-day fast, surviving only on salt and water, to demand statehood for Ladakh and its inclusion under the Sixth Schedule of the Constitution to help protect the ecologically fragile region from "greedy"

industries After the abrogation of Article 370, Ladakh became a separate union territory "without legislature". The Buddhist-dominated Leh district had long demanded union territory status due to alleged neglect by the erstwhile Jammu and Kashmir government.

#### crats, many in Ladakh demand that the union territory be included in the Sixth Schedule, which provides for the formation of Autonomous District Councils (ADCs) with legislative, judicial and administrative autonomy within a state.

These councils administer areas under their jurisdiction, making laws on specific matters with the governor's assent. They can establish village councils or courts for dispute resolution and manage facilities and services within their areas, including education and healthcare. They also have the authority to impose taxes and regulate certain activities.

Wangchuk had previously said that statehood and constitutional protection under the Sixth Schedule would not impact defence and national security-related projects in Ladakh.

Ladakh's former MP, Jamyang Tsering Namgyal of the BJP, had also demanded that the region be included in the Sixth Schedule to safeguard the land, employment and cultural identity of the local population.

În 2019, Union Tribal Affairs Minister Arjun Munda promised to do "whatever is required from a constitutional perspective to protect them".



BHUBANESWAR, July 28: With the Hirakud Dam authorities releasing the season's first flood water in the river Mahanadi, the Odisha government on Sunday asked collectors of seven downstream districts to be

on high alert and tell people not to go near the riverbank, officials said. After customary puja, the dam authorities opened sluice gate number seven followed by others. A total of 20 gates will be opened in three phases -7 gates at 9.30 am, another 7 at 12.30 pm and the remaining 6 gates at 2.30 pm, to flush out excess water amid heavy rainfall in the upper catchment areas and the inflow of water into the reservoir.

The water level of Hirakud stood at 616.93 ft against its full reservoir capacity of  $6\overline{3}0$  feet, at 6 am. While the inflow of water into the reservoir was 3,16,000 cusec, the out-

flow was 40,126 cusec. The state government in a release said that due to the opening of 20 gates, the Khairmal discharge would be around 4.50 lakh cusecs by 8 am on July 29 and the Mundali discharge will be around 5 lakh cusecs by 11 am on July 30.

"Collectors of Sambalpur, Sonepur, Nayagarh, Puri, Cuttack, Jagatsinghpur and Kendrapada have been asked to alert the people downstream not to enter to the Mahanadi riverside. Animals will also not be allowed to gaze close to the river. Collectors are also requested to remain alert and monitor the situation," it said The District Emergency Opera-

tion Centre will also be manned by senior officers so that no untoward incident happens, the Special Relief Commissioner (SRC) said in a letter to collectors. (PTI)

Prime Minister Narendra Modi had launched the campaign on the occasion of World Environment Day on June 5 and urged everyone in India and across the globe to plant a tree as a tribute to mothers.

Defence Minister Rajnath Singh had recently participated in the campaign and planted a tree in memory of his mother. He had called upon people to join the campaign to protect nature and contribute actively to make the movement more effective and dynamic, the statement said. (PTI)



BENGALURU, July 28: Chief Justice of India D Y Chandrachud on Sunday said the trial judges prefer playing safe by not granting bail on important issues of crime when it is looked at with a degree of suspicion.

The Chief Justice underlined the need for a 'sense of robust common sense' to look at the nitty-gritty of each case.

"People who should be getting bail in the trial courts and not getting it there, as a result of which, they have to invariably move the high courts. People who should be getting bail in the high courts will not necessarily get it, as a result of which, they have to move to the Supreme Court. This delay compounds the problem of those who are facing arbitrary arrests,' Justice Chandrachud said.

He was replying to a question at the end of a keynote address during the '11th Annual Conference of the Berkeley Centre on Comparative Equality and Anti-Discrimination'. The question was on the arbitrary arrests.

The questioner said we seem to live in a society where one acts first and seeks forgiveness later. This has become particularly true for public authorities acting in a politically motivated manner by detaining activists, academics, journalists and even politicians, including the chief ministers of opposition parties, he said.

According to him, all of these actions are taken with deep trust in the face of justice coming very slowly.

In reply, Justice Chandrachud said the Supreme Court has been constantly trying to convey that part of the reason for it is that there is an inherent distrust in the institutions within the country.

"I think it's important that we learn to

trust people who may be in a hierarchical legal system, like much below, which are the trial courts. We have to encourage trial courts to be more receptive to the need for accommodating concerns of people who are seeking liberty," the CJI said

"Unfortunately, the problem today is this, that we look at any grant of relief by trial judges with a degree of suspicion. That means that the trial judges increasingly are playing it safe, not granting bail on important issues of serious crimes,' he explained.

According to the CJI, judges have to look at the nitty gritties and see the fine prints of each case.

"You (judges) have to have a sense of robust common sense. Now, unless we, therefore, separate the grains from the chaff in criminal jurisprudence, it's very unlikely that we will have just solutions and to allow for decision makers to separate the grain from the chaff, it's important that we also place a great deal of trust," Justice Chandrachud noted.

"I think that's my concern that you can't render courts as in the hierarchy as you go up dysfunctional, just by the number of very small cases that are placed before us".

According to him, most of the cases should not have come to the Supreme Court at all.

"The reason why we are prioritising bail is to send this message across the nation that those at the most incipient levels of the decision-making process have to do their duties without this feeling that. I've been disgusted that my career will be on the line," the CJI underlined. (*PTI*)

## Majority school students across globe do not have access to minimum physical education: UN report NEW DELHI, July 28: The majority of the world's

schoolchildren still do not have access to the minimum required physical education, according to the first-ever Global Status Report on Quality Physical Education.

The report, "Global State of Play", published by UN-ESCO's education team, revealed that only 58 per cent of the countries have made physical education compulsory for girls and that only 7 per cent of schools worldwide have established equal physical education time for boys and girls.

Two-thirds of secondary school students and more than half of primary school students worldwide are not taught the required minimum weekly physical education.

An expert from the team told PTI that less than one in two primary school teachers has received specialist training in physical education. The team also flagged major differences in funding for physical education between countries -- two-thirds devote less than 2 per cent of their education budget to it while one country in 10 allocates more than 7 per cent.

"Physical Education (PE) has been a subject of extensive discussion among health and education professionals worldwide due to its potential to support learning and contribute to the holistic development of students. Opportunities for professional development are scarce due to budgetary constraints and/or insufficient time allocated in teacher schedules to attend training.

"For instance, only 33 per cent of countries reported providing in-service training (INSET) and continuous professional development (CPD) to their PE workforce

every five years, which significantly deviates from the recommended annual frequency," the report said.

Regarding the inclusion of girls and students with disabilities in physical education, 58 per cent of the countries worldwide report their participation in mainstream settings, yet significant disparities still exist between regions.

"A concerning issue is the discrepancy between policy and practice. For instance, while 54.5 per cent of countries report policies, strategies, guidelines or plans to provide equal amounts of PE time for boys and girls, in practice, only 7.1 per cent of schools report that equal PE time is actually implemented for boys and girls," the report said.

"This equates to a 47.4 per cent difference between policy and practice, a result that is observable across all regions. Similarly, one in three students with disabilities still

#### has no access to PE," it said.

Education (QPE) to distinguish it from traditional PE and highlight the importance of core factors such as frequency, variety, inclusivity and value content.

"There is a need for subjects like physical education to consider future orientations and curriculum developments to ensure continued relevance and effectiveness in relation to meeting student needs and learning outcomes," the report said.

"A teacher's delivery of a PE curriculum is a central aspect to be considered to ensure practice is meaningful, inclusive and meets the needs of a diverse range of learners. This clearly relies on a well-educated workforce with access to continuous professional development opportunities," it added.

UNESCO has called upon countries to work towards increasing investment in this area.

Improving the training of sports teachers and educators, increasing investment in infrastructure, developing physical education programmes that are resolutely inclusive, particularly for girls and young people with disabilities, increasing the number of hours of physical education in school curricula and placing the values of sport at the heart of educational programmes are among the recommendations made by the team for countries.

The report provides 10 indicators, including giving a good, moderate or poor score, to help local and national authorities assess the quality of physical education in their country and identify priority areas for improvement. (PTI)

Voicing apprehension that the boycott of the director by technicians and protests by other directors may snowball into a major crisis affecting shoots of films, serials, web series in Bengali film industry, forum president and veteran actor Ranjit Mallick and secretary Santilal Mukherjee requested all sides to sit for talks immediately and thrash out the differences. "Any disruption of shooting will affect actors, directors, technicians, producers - every stakeholder in the industry - which will do not good.

"We therefore call upon every side to sit for talks for the interest of industry and iron out differences. If required the artist's forum can mediate to resolve the issue. Let's not allow the situation to snowball into a major crisis that will only affect everyone in the industry as well as the audiences," the forum said.

The forum, the apex body of actors in the entertainment industry in Bengal, also stressed nothing should be done which will tantamount to showing its respect to anyone including directors.

On Saturday, despite the clean chit given to film maker Rahool Mukherjee by the Directors' Guild allowing him to work as creative producer in an upcoming film, no technician turned up at a Kolkata studio on the first day of shooting of the movie produced by a big production house.

The development comes despite the Federation of Cine Technicians and Workers of Eastern India (FCTWEI) on July 26 clarifying that Mukherjee is free to work as a creative producer of the film but not as a director for three

months. Federation president Swarup Biswas said Mukherjee was being debarred from directing films for three months for violating norms by visiting Bangladesh for shooting another movie without intimation to the federation and taking the help of technicians in Dhaka. "Neither the federation nor the Direc-

tors' Guild was informed by Mukherjee about his visit to Bangladesh for shooting a film, which is against the rule," he had said on Friday.

In fresh development after an urgent federation meeting on Saturday evening, Biswas told reporters that while it had been amicably decided earlier that Mukherjee would be the creative producer of the film to be shot from July 27, the call sheet given to them for the shoot referred to Mukherjee as the director and he was seen taking every initiative during the shoot as the de facto director. "This was seen as violating the spirit

of our agreement and we technicians don't want to work under the instruction of Mukherjee who had not taken any technician from Kolkata to complete 10 days of shooting of another film 'Lohu' in Bangladesh. Mukherjee himself had admitted his mistake at the first meeting with the federation and guild earlier in July but now retracting," Biswas said.

"We also don't wish to stop work in Tollygunge studios as the livelihood of 7,000-8,000 technicians revolve around shootings for films, serials and web series. We had never failed in our commitment. But the fact remains that someone must not undertake shootings in a clandestine manner keeping the local technicians of his project in dark and hiring crew from outside the country," another senior federation member said about the controversy revolving another film Lohu shot in Bangladesh creating all problem. ## Swiatek, Alcaraz and Djokovic start the Olympics with wins; Osaka loses

PARIS, July 28: Iga Swiatek and Carlos Alcaraz got the Paris Olympics tennis competition started with first-round victories under closed roofs at Roland Garros, the site of their French Open titles less than two months ago.

Novak Djokovic also won in straight sets as he, like Swiatek and Alcaraz, opened a bid for a first Olympic gold medal. Djokovic's second-round opponent could be longtime rival Rafael Nadal, who was scheduled to play his opening singles match Sunday — but said he isn't sure whether he will remain in that event.

"Tomorrow, I don't know what's going to happen," Nadal said Saturday. "I don't know if I'm going to play or not.'

In Saturday's last match, Angelique Kerber defeated Naomi Osaka 7-5, 6-3 in a contest between two women who have been ranked No. 1 and own multiple Grand Slam titles.

Kerber has said she will retire after representing Germany at these Games; Osaka was hoping for a deeper run than her thirdround exit at the Tokyo Olympics three years ago after lighting the cauldron during the opening ceremony in her native Japan.

Nadal, the Spaniard who won a record 14 of his 22 Grand Slam titles at the French Open and owns two Summer Games golds, was a surprise torch carrier during the rain-soaked opening ceremony along the Seine River on Friday night. He won his doubles opener alongside Alcaraz on Saturday night.

Nadal has not made entirely major championships in Paris clear whether or not these Sum-



mer Games will be the final event of his career.

He is 38 and has been dealing with injuries for much of the past two seasons. Nadal and Alcaraz never had played doubles together, but they got past the sixthseeded Argentine duo of Maximo Gonzalez and Andres Molteni 7-6 (4), 6-4.

The No. 1-ranked Swiatek claimed four of her five career and grabbed the last four games first time in two years. Ebden got

PARIS, July 28: Simone Biles briefly left the floor and said she has discomfort in her left leg but continued her quest to return atop the Olymipc podium Sunday.

The 27-year-old American and the five-woman U.S. gymnastics team took the floor at a packed, star-studded Bercy Arena during the second qualifying subdivision for the Paris Games on Sunday. The Americans are heavily favored to win the team gold after finishing runner-up to Russia three years ago in Tokyo.

Biles dazzled during her opening beam routine, then briefly left the floor with USA team doctor Marcia Faustin. She returned a short time later and spent several minutes sitting and watching her teammates.

Biles was heard on camera saving she felt something in her calf but stepped onto the competition floor with the leg taped. She appeared just fine when Taylor Swift's "Ready for It" began playing and her routine — the hardest in the world — was solid. She walked gingerly off the floor and sat off to the side for a moment before receiving a hug from longtime coach Laurent Landi.

She received a 14.600, assuring her a spot in the event finals next week.

The stands were buzzing and filled with celebrities. Tom Cruise posed for selfies while waiting for Biles to emerge. Snoop Dogg had front-row seats, and Ariana

AusCycling, Australia's cycl governing body, confirmed the procedure early Sunday. No other details were available.

Plapp was among the last riders to start on the 32.4-kilometer (20mile) course and was laying down a medal-worthy ride at the first time check, trailing then-leader and eventual bronze medalist Wout van Aert by just two seconds. But when Plapp reached a technical portion of the course, his bike slid out from under him and he crashed hard onto the pavement.

The crash was not shown on the race broadcast, but AusCycling said Plapp was conscious and moving afterward. He was lifted into the team vehicle and taken to the hospital for precautionary scans, and later he required the abdominal procedure.

"Plapp slid under a barrier fence shortly after passing the first checkpoint approximately 14 kilometers into the 32-kilometer course," AusCycling said. "His parents and an Australian team doctor were at the hospital with him." The 23-year-old Plapp, who won bronze at the Tokyo Games as part of the Australian pursuit team, is the reigning national time trial and road race champion. He was supposed to ride alongside Simon Clarke in support of teammate Michael Matthews in the Olympic road race next Saturday.

Remco Evenepoel won the time trial, giving Belgium two riders on the podium, while Filippo Ganna of Italy finished second. But both the women's and men's races were marred by a series of crashes on a course made treacherous by the rain. Among those who fell was American rider Chloe Dygert, the reigning time trial world champion, who remounted her bike and rallied to finish third behind gold medalist Grace Brown of Australia and Anna Henderson of Britain.

Survakumar and India made a winning start to the three-match series here on Saturday when they crushed hosts Sri Lanka by 43 runs in a high scoring opening T20I. "I played in the last Australia series with Surya bhai (as captain). I know that he is a bowlers' captain. He gives you free hand (in a way) that you decide first," Axar said at the post-match press conference on Saturday.

"Whenever you get hit, he comes and says that it was a good ball. He keeps giving you inputs. As a player, there is a good bond with him.

Axar recalled the experience of playing under Survakumar in the five-match T20I series against Australia in India late last year which the hosts won 4-1.

"As a captain, I have also played with him in the last five matches (against Australia) and when I was playing today, I didn't feel much change," he said.

India won, Pant batted at No 3 whereas on Saturday skipper Suryakumar came out at the coveted spot and the wicketkeeper-batter dropped down to No 4.

"Our team has four lefties and four righties. If there is a left-right combination (in the middle), it becomes very hard for the bowlers to maintain the line and lengths consistently especially with rotations with singles." "Now if there are four lefties, how can you use them? If you have that chance (to ensure) that there are no two lefties or two righties (in the middle) at the same time.

"If you have that chance, if you have those players in batting, then why not use them? You also have to keep changing the batting order as per the bowling options that the opposition has got," he added.

The spinner said the message from India's new staff under head coach Gautam Gambhir has been that the team will not experience a major overhaul in the way it operated. While fielding coach T Dilip has continued in his role, Abhishek Nayar, Sairaj Bahutule and Dutchman Ryan ten Doeschate are now a part of Gambhir's support staff for this tour of Sri Lanka as positions will be finalised after the tour ends.

"I have been playing for 10 years. I have played with different coaches and captains. I don't think a lot will change in the team," he said.

"When we were talking in the team meeting, they also said the same thing that the coach and captain keep changing but the team remains the same and the 11 or 15 players who stay, they have to do it," he said.

Small town comes to life for Olympics but with fair share of organisational hurdles

CHATEAUROUX (FRANCE), July 28: Norway shooting coach Tore Brovold, the silver medallist at the 2008 Olympics, is being forced to stay away from skeet shooters in the national team as there are not enough rooms available at the Athletes' Village here.

Chateauroux, a quiet town in central France with a population of less than 50,000, is hosting all the shooting events of the Paris Olympics. It is a two-and-a-half hour train ride from the bustling French capital, leaving 340 Olympians pretty much cut off from the Games hub.

After completing the 270km long journey from Paris, one would struggle to commute within Chateauroux due to limited public transport, which is free for everyone

For athletes, coaches, officials and media staying outside the Village, the only way to commute between the Games' ven-



ues is via the transport provided by the Organising Committee.

"These Games have been a disaster on the transport front. I went to the bus stop

near the train station last night but this morning they changed the timings and the athletes had to go ahead with the training in my absence," Brovold, who has also worked with Indian shotgun shooters, told PTI.

Due to limited availability of rooms, he had a choice to make: either stay at the Games' Village at the expense of a shooter or stay at a hotel outside. Keeping in mind the best interest of the team, he chose the latter.

"I have also come to know that the organisers are offering free accommodation to visiting teams outside the village as they are short on rooms," said the 54-year-old. Emin Jafarov, the deputy chef de mission of the Azerbaijan contingent, too is staying in a hotel due to shortage of rooms.

"I am in staying in a hotel as there are not enough rooms at the Village and the athletes need it more than me," said Jafarov.

A majority of Great Britian's shooting squad is staying outside the Athletes' Village by choice as that ensures them the food of their choice.

"It just works better for us. The hotel staff takes care of our individual requirements and we can also go out to eat in different places," said a support staff from Team GB on condition of anonymity.

The 21-member Indian team too is going out to eat everyday as the shooters are not getting the food of their choice.

"If you want food like home, then it is not possible. The shooters have been going out for meals and that is totally fine," said a coach with the Indian team.

On Sunday, a team doctor associated with the Portugal team arrived here due to a transport delay.

"It has only been a day so far. I can tell you more about the challenges we are facing here after three four days," the doctor said without wanting to be named. (PTI)
