### Himanta blames it on geographical factors

GUWAHATI, July 3: Chief Minister Himanta Biswa Sarma on Wednesday addressed the ongoing flood situation in the state, attributing it to geographical factors beyond the state's control.

The devastating second wave of floods in the state were mainly due to the cloudburst in neighbouring Arunachal Pradesh", he told reporters after reviewing the flood situation in Kamrup district.

Heavy rainfall in China, Bhutan and in the upper reaches of Arunachal Pradesh led to floods in Assam and this is 'beyond our control', he said. "Several flood control measures have been initiated over the years and the 'impact as well the suffering of the people has come down considerably but we will have to deal with the natural consequences in the best possible manner," Sarma said. ## SC takes strong note of not taking Kuki undertrial prisoner to hospital in Manipur



NEW DELHI, July 3: The Supreme Court Wednesday took a strong note of an undertrial prisoner lodged in a Manipur jail not being taken to a hospital for treatment just because he belonged to the minority 'Kuki' community, saying it does not "trust the State".

A bench of Justices JB Pardiwala and Ujjal Bhuyan made some strong observations against the State while hearing a plea filed by Lunkhongam Haokip that he was suffering from piles and tuberculosis and was not

"We do not trust the State...The accused was not taken to hospital because he is from the Kuki community. So sad! We direct him to be examined now. If the medical report reveals something serious, we will take you to task," the bench said.

The counsel for Haokip claimed the jail officials did not pay heed to persistent requests for medical help. The bench perused an order of the Manipur High Court and found that the undertrial prisoner was not taken to hospital since he was from Kuki community and "shifting him to a hospital will be hazardous tak-

ing into account the law and order situation". Manipur has been in the grip of an ethnic conflict between the minority Kuki and majority Meitei com-

The bench directed the jail superintendent and the state authorities "to make necessary arrangements for his transportation to the Gauhati Medical College and get him examined therein. The medical exam shall be as regards piles, TB, tonsillitis, abdominal pain as well as problems in lower lumbar spine".

It sought a detailed medical report on or before July 15 and asked the state to bear all the expenses includ-

Manipur descended into chaos and violence in May last year over a high court order directing the state government to consider including the non-tribal Meitei community in the list of Scheduled Tribes.

More than 170 people have been killed and several hundred others injured since ethnic violence first broke out in the state on May 3 last year when a 'Tribal Solidarity March' was organised in hill districts to protest against the majority Meitei community's demand for ST status. (PTI)

## Adityanath announces judicial probe into Hathras stampede

HATHRAS (UP), July 3: Uttar Pradesh chief minister Yogi Adityanath on Wednesday announced a judicial probe into the Hathras tragedy while not ruling out the possibility of a "conspiracy" behind the stampede that killed 121 people.

He also said the "sevadars" (volunteers working for the 'satsang' organisers) should have taken the victims to the hospital. People were dying and the "sevadars" fled, he claimed.

Adityanth met those injured in the incident at the venue of the religious congregation here and obtained information from the eyewitnesses about the course of events preceding the tragedy.

Asserting the government will ensure that such incidents do not recur, the chief minister said a standard operating procedure might be put in place for religious congrega-

#### Failed partnership talks, funding winter took toll

## Curtains down for Koo

NEW DELHI, July 3: Koo, the Indian replica of Twitter (now X), is shutting down operations, its cofounders announced on Wednesday blaming the platform's failed attempts at partnerships and harsh funding winter for the closure.

The announcement brings curtains down on Koo - which was launched in 2000 and whose popularity in India soared around 2021 following the Indian government's spat with X (then Twitter). Back then, amid growing calls for expanding the ecosystem of homegrown digital platforms, several Union ministers, politicians and government departments had signed up on Koo.

In the days of its heady growth, Koo snapped up about 2.1 million daily active users and about 10 million monthly active users, and had marquee investors like Tiger Global, Accel, 3one4 Capital, and Kalaari Capital backing it.

However, prolonged funding winter and failed acquisition talks took a toll on the platform which later struggled with dwindling user base and resorted to layoffs, last year. In a post on LinkedIn on Wednesday, co-founders Aprameya Radhakrishna and Mayank Bidawatka announced that the platform will be discontinuing its services to the public and that the little vellow bird is bidding

#### Gold rises ₹ 50; silver jumps ₹300

**NEW DELHI, July 3**: Gold prices rose ₹ 50 to ₹ 72,550 per 10 grams in the national capital on Wednesday in line with firm trends in the international markets, according to HDFC Securities. The precious metal had closed at ₹72,500 per 10 grams in the previous session.

Additionally, silver prices also iumped ₹ 300 to ₹ 91,300 per kg. It had settled at ₹91,000 per kg in the previous session. "In Delhi markets, spot gold prices (24 carats) are trading at ₹72,550 per 10 grams, up ₹ 50 from the previous close," Saumil Gandhi, Research Analyst at HDFC Securities, said. The yellow metal traded at ₹ 74,650 per 10 grams in local markets in the national capital, marketmen said. Silver traded at ₹ 92,300 per kg. Gold traded within range with a modest gain on Wednesday, as traders are awaiting the release of US macro data that could provide new insights into the timing of the Federal Reserve's interest rate cut, Gandhi said.

In the global markets, spot gold at Comex was trading at USD 2,339 per ounce, slightly up USD 4 from the previous close.

"tone down" its growth trajectory. "Social media is probably one of the toughest companies to build even with all resources available as you need to grow users to a significant scale before one thinks of revenue. We needed 5 to 6 years of aggressive, long term and patient capital to make this dream a reality," the co-founders said in their note. They conceded that the mood of the market and the funding winter got better of the company.

'Koo could have easily scaled internationally and given India a global brand that was truly made in India. This dream will remain," according to the note.

The co-founders further said that Koo will evaluate making its assets into a digital public good to enable social conversations in native languages, around the world.

"What we have built is truly magnificent. We will be happy to share some of these assets with someone with a great vision for India's foray into social media," the note read. (PTI)

## Mcap of BSE-listed firms hit all-time high

#### ₹445.43 lakh cr amid record rally in stocks

**NEW DELHI, July 3:** The market capitalisation of BSE-listed firms hit a record high of ₹ 445.43 lakh crore on Wednesday, driven by a sharp rally in equities, where the benchmark Sensex breached the historic 80,000-mark for the first time ever.

The 30-share Sensex hit the historic 80,000-mark for the first time earlier in the day. It surged 632.85 points, or 0.79 per cent, to hit a record intra-day high of 80.074.30. The benchmark later ended near the 80,000-level at 79,986.80, up 545.35 points, or 0.69 per cent. The market capitalisation (mcap) of BSElisted firms hit a record peak of ₹4,45,43,642.29 crore (USD 5.33 trillion).

The BSE Sensex breached the 78,000 level on June 25 and 79,000 for the first time on June 27.

"Markets continued their ongoing streak of making new highs supported by firm global trends. Nifty crossed the 24,300 mark while Sensex breached the historic 80,000 mark amid buying in banking stocks,' said Siddhartha Khemka, Head - retail research, Motilal Oswal Financial Services Ltd.

Among the Sensex pack, Adani Ports, Kotak Mahindra Bank, HDFC Bank, Axis Bank, IndusInd Bank, State Bank of India, Power Grid, JSW Steel, Baiai Finance and Tata Steel were the biggest gainers. Tata Consultancy Services, Titan, Reliance Indus-

1 and 2 of the IHDS. "According to the IHDS findings...poverty declined significantly between 2004-2005 and 2011-12 (from a headcount ratio of 38.6 to 21.2), and it continued to decline between 2011-12 and 2022-24 (from 21.2 to 8.5) despite the challenges posed by the pandemic," the paper said.

The paper said economic growth and poverty decline create a dynamic climate that requires nimble social protection programmes. Traditional strategies designed

to address chronic poverty in a large segment of society may be less effective as accidents of birth become less important than acci-

social protection systems keep up with the pace of social transformation will be a key challenge for India as it strives towards equitable development.

According to the paper, during an era of economic growth, when opportunities increase, the longterm determinants of poverty may decline while accidents of life associated with natural disasters, illness and death, and changes in occupation-specific opportunities may become more important.

"Accidents of birth are more likely to affect long-term chronic poverty, accidents of life may have a transitory effect on moving in and out of poverty," it said.

Earlier this year, NITI Aayog CEO B V R Subrahmanyam had said the latest consumer expenditure survey indicates that poverty has come down to 5 per cent in the

country and people are becoming prosperous both in rural and urban areas. "If we take the poverty line and inflate it with the Consumer Price Index (CPI) to today's rate, we see that the average consumption of the lowest fractional, the 0-5 per cent, is about the same. This means poverty in the country is there in the 0-5 per cent group only," the NITI Aavog CEO had said.

The National Sample Survey Office (NSSO), under the Ministry of Statistics and Programme Implementation, released data on household consumption expenditure for the year 2022-23 on February 24 that showed per capita monthly household expenditure more than doubled in 2022-23 as compared to 2011-12. The poverty line recommended by the Tendulkar Committee Report was set to ₹ 447 and ₹ 579 for rural and urban areas, respectively, but varied between states for 2004-2005. These poverty thresholds were subsequently adjusted by The Planning Commission to ₹860 and ₹ 1,000 for 2011-12. (PTI)

## Supernova insolvency case NCLAT to wait for lenders' decision on settlement offer

NEW DELHI, July 3: Insolvency appellate tribunal NCLAT on Wednesday said it will wait for the decision of lenders on a revised settlement offer by Supertech Realtors, which is developing a residential apartment, offices, retail and luxury hotels at its Supernova project.

The National Company Law Appellate Tribunal further said bank accounts of the Supertech Realtors "shall be operated only with the joint signature of the IRP, only to carry out construction". The interim order came while hearing the appeal filed by Ram Kishore Arora, director of the suspended board of Supertech Realtors, challenging the order passed by the National Company Law Tribunal (NCLT) last



month. A Delhi bench of NCLT had admitted the insolvency plea filed by the Bank of Maharashtra over a default of ₹ 168.04 crore and appointed Anju Agarwal as interim resolution professional (IRP), suspending the board of Supertech Realtors, a step-down subsidiary of Supertech. The appellate tribunal issued notices asking lenders to file replies within three weeks and listed the matter for further hearing on August 8, 2024. Supertech Realtors, a subsidiary of Supertech, is developing the Supernova project at a cost of ₹2,326.14 crore on a land measuring 70,002 square metres at Sector 94, Noida.

During the proceedings of the NCLAT, the counsel appearing for Supertech Realtors said he is not raising any dispute regarding the debt and default to Bank of Maharashtra. He said the realty firm has submitted a proposal to the Consortium of Lenders for settlement of dues from the investor, namely Kotak Advisors Ltd, via an ARC (asset reconstruction companies) sale.

The offer made by Supertech Realtors was 75 per cent of the running ledger book balance of the consortium lenders and the lead bank acknowledged the receipt of the revised proposal.

A meeting of lenders' was held on March 18, 2024, in which the Bank of Maharashtra also participated. Union Bank of India, the lead bank, after taking note of the proposal has principally agreed with the proposal, Supertech Realtors' counsel submitted.

However, Bank of Maharashtra representatives sought time to consult their head office and inform them about their decision

Supertech Realtors submitted that as the proposal has been principally accepted by the lead bank and is under consideration, no purpose be served in initiating a Corporate Insolvency Resolution Process against it.

He further submitted Supernova Project is 80 per cent complete and an investor has also offered to infuse funds for the construction and completion of the project. However, counsel appearing for the Bank of Maharashtra submitted that the OTS proposal of the Corporate Debtor, which the bank earlier approved, was not honoured by the realty firm. (PTI)

### Rupee settles 1 paisa lower at 83.49 against US dollar

MUMBAI, July 3: The rupee settled 1 paisa lower at 83.49 against the US dollar on Wednesday, weighed down by elevated crude oil prices.

Forex traders said the Indian rupee depreciated on strength in crude oil prices, which touched a two-week high on Tuesday. However, a firm tone in domestic markets and favourable macroeconomic data cushioned the downside. At the interbank foreign exchange market, the local unit opened at 83.51 and hit the intraday high of 83.49 and a low of 83.56 against the American currency during the session. It finally settled at 83.49 against the dollar, 1 paisa lower than its previous close.

On Tuesday, the rupee depreciated 4 paise to settle at 83.48 against the US dollar. "We expect the rupee to trade with a slight positive bias on softening of the US dollar and rise in global risk sentiments. Strength in the domestic markets may also support sentiments," said Anuj Choudhary – research analyst at Sharekhan by BNP Paribas.

"However, elevated crude oil price and FII outflows

may cap sharp upside. Traders may take cues from ADP non-farm employment, weekly unemployment claims, ISM services PMI, Challenger job cuts, trade balance and factory orders data from the US. Investors may remain cautious ahead of FOMC meeting minutes." Choudhary said.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.10 per cent lower at 105.61.

Brent crude futures, the global oil benchmark, were trading 0.09 per cent higher at USD 86.32 per barrel. In the domestic equity market, Sensex hit the historic 80,000-mark and Nifty scaled a fresh lifetime high. The 30-share BSE Sensex finally ended the day 545.35 points, or 0.69 per cent, up at 79,986.80 points. The broader NSE Nifty settled 162.65 points, or 0.67

per cent, higher at 24,286.50 points. Foreign Institutional Investors (FIIs) were net buyers in the capital markets on Wednesday, as they purchased shares worth ₹ 5,483.63 crore, according to

After meeting the injured, Adityanath reached the stampede spot in Sikandrarau where the divisional commissioner of Aligarh briefed him about the accident.

At a press conference, the chief minister said "When the gentleman's (Saakar Vishwa Hari Bhole Baba) preaching was over, he came down from the stage and his convoy moved forward, a group of women moved towards him to touch him. A crowd followed them and started climbing on top of each other.'

Adityanath said, "The 'sevadars' kept pushing people leading to the accident. It is sad that the 'sevadars', who do not allow the administration to enter such events, tried to hush up the matter. But when the administration started taking the injured to hospital, most of the 'sevadars' fled." Action is being taken to fix accountability, he said, adding some special teams have been formed and after initial investigation, "we will take further action." Asked about opposition parties trying to corner the government over the stampede, the chief minister said, "Some people have a tendency to dig up politics in such tragic incidents."

Apparently referring to Samajwadi Party chief Akhilesh Yadav, he said, "Everyone knows with whom that gentleman has a photo and who are his political connections... I think it is necessary to get to the bottom of it." "Those who play with the lives of innocent people will also be held accountable," the chief minister said. A photo of Vishwa Hari Bhole Baba with Akhilesh Yadav has gone viral on social media.



It is alleged that Jagiroad, a prospective town with the proposed TATA Semiconductor Project, is suffering a lot due to a lack of proper planning and development. ## Monsoon fury

he arrival of the monsoon season has brought relief from the scorching summer heat across the country. However, it has also introduced significant challenges, especially in major cities where inadequate drainage systems lead to severe waterlogging. Flooding has exacerbated the situation in various regions, disrupting daily life and causing widespread distress. Recently, newly elected Members of Parliament shared images of their homes and neighbourhoods in Delhi inundated with muddy, filthy rainwater. They were unable to leave their homes, highlighting the dire state of urban infrastructure. This is a stark contrast to the recent past when Delhi grappled with a shortage of clean drinking water due to reduced supplies from upstream states, failing to meet the capital's demands during peak summer. Despite Delhi receiving less rainfall compared to other Indian cities, it still faces persistent waterlogging issues. This problem underscores the ineffective and visionless functioning of local bodies, including the capital's three municipal corporations. Disappointingly, when the new Parliament commenced its maiden session, these pressing civic issues were notably absent from discussions. Instead, the focus was on defining Hindus, the largest community in India, triggering widespread political turmoil. The Maharashtra Assembly witnessed derogatory exchanges, reflecting poorly on the quality of our legislative bodies.

It is concerning that our lawmakers lack mutual respect and fail to appreciate diverse viewpoints, leading to national embarrassment. How did India reach this juncture? A nation with a rich heritage and great traditions seems to have lost its lofty ideals. The BJP, facing an abusive opposition, must share the blame for not setting commendable precedents. If the opposition resorts to such behaviour today, they must be prepared to face similar responses in the future. A political brawl benefits no one and only leaves all parties injured. India boasts numerous academicians and professionals who embody formal, socially-acceptable behaviour and respect for differing perspectives. The neglect of high-quality education for all has resulted in a population prone to abusive conduct, both within legislative bodies and in public life. Lawmakers must focus on making laws and addressing public concerns, not defining religion. Currently, Delhi's municipal issues should be a priority in parliamentary discussions. The plight of political leaders in jail is highlighted, but millions of ordinary Indians are also imprisoned without similar attention. Lawmakers must remember their duty to the people and avoid prioritizing non-issues over significant concerns. This cycle of neglect will only cease when lawmakers stop imposing trivial matters on the legislative agenda. They must learn to prioritize the country's pressing issues, which emerge daily. In a populous nation like India, educated, intelligent, and productive

Conversely, a population marked by ignorance, idleness, and abusive behaviour hinders progress. Restoring order is achievable. Small, daily steps in the right direction can lead to substantial changes. Lawmakers should focus on improving law enforcement and justice systems, ensuring educational opportunities for all, including night schools for the elderly and productive activities for the literate. This positive approach should permeate society from the grassroots to the highest levels. Instead of fixating on religious definitions, our lawmakers must prioritize issues that genuinely impact citizens' lives. Addressing urban infrastructure, ensuring clean water supply, and promoting education are essential steps towards a more just and progressive society. Only then can we move towards a future where civic responsibility and effective governance prevail.

# Rahul Gandhi's blistering speech as leader of Opposition rattles BJP

or the first time in his ten-year rule, Prime Minister Narendra Modi, proclaimed to be the super-leader to shape the destiny of India, wore a pitiable, visibly shaken and dejected look sitting in the front row of the treasury benches in Lok Sabha, while Rahul Gandhi, who has been assigned the constitutional task of being the Leader of Opposition, shredded his assiduouslyand nurtured-atmassive-cost image of 'Hindu Hridaya Samrat'.

Modi, who arrogantly boasted of being the 'Vishwa Guru' and the 'creator of New India' would face this nature of jibe and derision from Rahul, the Gandhi scion who till recently was derided by him as "Pappu" and "Shahzada". Rahul did not simply berate Modi's brand of Hindutva based on fear and hate, he even told him on his face on the floor of the Lok Sabha "you are not a true Hindu". Rahul said: "Narendra Modi doesn't represent the entire Hindu samaj. BJP-RSS doesn't represent the entire Hindu samai.'

Something unimaginable happened in the house. Modi who usually preferred to skip the proceedings of the house, for the first time not only remained seated in his chair, instead he rose twice to defend himself. None could have imagined that Rahul, who till the other day, was not taken seriously by the urban middle class and dismissed by the BJP leaders as nonserious person, who is yet to attain the status of a master politician, would floor Modi on the mat. Members of the house and people across the country were witnessing the rare sight of a shaken Modi and Shah intervening repeatedly, and ironically enough, urging the Speaker for protection'!

Unable to face the onslaught from Rahul, Union home minister Amit Shah even lost his cool and went to extent of blaming the Speaker, Om Birla, who is a BJP member, known for having a harsh and tough approach towards the Opposition, of being soft towards Rahul. Shah said: "Aap ek tarfa niyomo ke upar jaake unko riyata de rahe ho, manyavar. Humein sangrakshit kariye, aise nahi chalta (You are ignoring rules to give them onesided concessions. Protect us, this

isn't acceptable)".

No doubt, Rahul created a history in the Lok Sabha. Rahul took Modi head on. He exposed the PM's claim of being the 'Hindu Hridaya Samrat' by saying "Aap Hindu ho hi nahi! (You are not a Hindu). In the Hindu religion, it's written, 'Stand with the truth, don't step back from the truth, don't fear the truth'. Non-violence is our creed". Modi's twodecade-long Hindu saviour image, manufactured painstakingly from the days of the 2002 Gujarat pogrom, was delivered a massive blow by Rahul's firebrand speech as the Leader of Opposition.

Modi and Shah desperately tried to turn the situation in their DEGREE OF THOUGHT favour, but failed

miserably.

their attempt to polarise Hindus, they tried to project Rahul as anti-Hindu. But this too did not work. Rahul succeeded in his mission to paint Modi as a communal leader who was using religion for his political gains. To substantiate his observation, Rahul cited the preaching of Lord Shiva. He said: "Shivji kahte hain, 'daro mat, darao mat' (Lord Shiva says, 'Don't be afraid and don't make others afraid'). He shows the fearless posture, talks about non-violence... and those who call themselves Hindu, they talk about violence, hatred and falsehood round the clock"

Though Rahul in past had questioned Modi's claim of representing the aspirations of Hindus, it was first occasion when he shattered this claim on the floor of the house. Citing the message of Abhay Mudra, he said that a true Hindu cannot indulge in violence and falsehood. He challenged Modi and Shah's claim of being real Hindus and presenting Hindu values.

Obviously, this was not at all palatable for them. Shah tried to generalize Rahul's pointed criticism by saying that the Leader of Opposition was accusing all Hindus of resorting to violence. Modi and Shah accused Gandhi of labelling Hindus as violent. Gandhi clarified that his remarks were targeted at the BJP, not Hinduism, emphasising that true Hinduism promotes courage and peace. Even Rahul's admirers would

It was after being pointed out by Shah and other MPs, Birla interrupted Gandhi, advising him that "rules don't allow the display of placards". Though the remark drew immediate criticism from Gandhi, Birla did not ask him to remove those placards from house. Rahul replied: "I wanted to show the image because it represents ideas that we in the opposition defend."

Effectively, in one single stroke, Rahul smashed the edifice of Hindutva built by RSS, BJP and Modi over the last ten years of Modi Raj. Though Modi bhakts as usual were highly critical of Rahul's attacks, the people on the streets appreciated his bulldozing the structure of hatred created by RSS and Modi surrounding Hindutva. People were appreciative of the fearlessness of Rahul, his rare variety of courage and conviction to take

have been astonished to see him the BJP-RSS hate machine head on. Even while interrupting Rahul's speech, Shah tried to resort to his old tactics of terrorising his opponent. He urged the speaker to ask Rahul to apologise to the House and the country for hurting the feelings of crores of people who take pride in identiying themselves as Hindus.

The speech of Rahul was so absorbing and focused that Congress members consented to Speaker's query whether their time should be allotted to Rahul. While Rahul was focussed, none of the BJP stalwarts could counter his allegations through facts. On the issue of providing MSP, the concerned minister tried to counter the allegation by saying that it was being given, but he preferred to remain silent when Rahul pointed out that the farmers' demand for legal guarantee has not meet met with.

On the issue of providing compensation to Agniveer soldiers, defence minister Rajnath Singh was seen hedging around saying that a soldier was paid one crore as compensation. But on this count he could not reply to Rahul's observation that Agniveer soldiers and regular army soldiers are the best persons to certify the real position.

Modi and Shah today miserably failed in their attempt to divert the attention of the house and distract the debate. Unsurprisingly, Shah spoke of the Emergency and 1984 anti-Sikhs riots instead of replying to Rahul's charges. Shah said Rahul had no right to talk about non-violence when the Congress had spread "terror" in the country. But this attack from Shah could not deter Rahul in his pointed criticism of the Modi-Shah duopoly.

Commentators have already observed how in the backdrop of Modi's serial and staggering assault on the constitutional bedrock of the country, the charges against Indira Gandhi pale in comparison. She had formally suspended fundamental rights, imprisoned leaders and imposed censorship, but it was for a short period of two years. But India under Modi has been witnessing an undeclared emergency for the last ten years, since he took over the office of prime minister.

Many leading scholars and ac-

ademics, even social and political activists are languishing in jails for years. Journalists are terrorised and even killed. Father Stan Swamy, a prominent human rights activist, died while in custody on July 5, 2022. He was even denied a sippy cup despite having serious medical condi-

Modi had showed to the world that emergency could be imposed even without using the Constitutional provisions. It was his intento incapacitate the democratic system and functioning that he disregarded the parliament and its practices. The three draconian bills, the Bharat Nyay Samhita, which came in force from July 1, were never debated in the house.

They were adopted without vote after 146 members of Parliament were expelled from the house. There are many examples of this nature of wilful violation. It was quite revealing to listen to Rahul saying: "I was attacked on the orders of Prime Minister Modi. There were 20-plus cases (against me), (my) house was taken away, 55 hours of interrogation by the ED".

Gandhi accused Modi of a 'systematic and full-scale assault on the idea of India, the Constitution, and those who resisted this attack. Some of the leaders are still in jail. Anyone who resisted the idea of concentration of power and wealth, aggression on poor & Dalits and minorities was crushed". He even said: "I was attacked by the order of Govt of India, by the order of the Prime Minister of India...The most enjoyable part of it was the 55 hours of interrogation by ED...'

Modi will certainly refute the accusations and allegations levelled against him by Rahul Gandhi while delivering his speech on the motion of thanks on President's address. Already, the entire corporate media ecosystem has been activated to discredit Rahul once again, describing him as 'anti-Hindu' and insinuating that he 'insulted Hindus'. However, no amount of saffron-washing will succeed in repairing the damage inflicted by Rahul Gandhi's scathing expose in the floor of the House. India finally has a worthy Leader of Opposition in the lower House of the Parliament. (IPA Service)

## for Indian agriculture?

ndian agriculture has undergone intense cultivation practices for the past six decades to ensure food security in the country. This has resulted in significant loss of soil organic carbon, deterioration of soil fertility and chemical pollution in major cultivated lands across the country. Further, intensive cultivation together with mono-crop cultivation of major cereals led to loss of biodiversity and exhaustion of ground water resources. These cultivation practices have also led to an increase in greenhouse gas (GHG) emissions that contribute to global warming and climate change.

The emissions from rice cultivation accounted for about 17.4 % of total GHG emissions from agriculture sector in the country, according to the India Third National Communication, submitted in December 2023, to The UN Framework Convention on Climate Change (UNFCCC). In such a scenario, carbon farming or regenerative agriculture can provide a potential opportunity for improving soil fertility, improving yields and reducing emissions, while providing additional income for farmers through trading carbon credits in a voluntary carbon market (VCM).

What is carbon farming? Although the concept of carbon markets has been around for a few decades, global participation in them started after legally binding emission reduction targets were set for developed countries in the Kyoto Protocol in 1997. Subsequently, the Paris Agreement in 2015 made provisions under Article 6, allowing international cooperation to establish functional carbon markets. In simple terms, a carbon market is a marketplace where carbon credits are traded. One carbon credit is equivalent to one ton of emissions removed in CO2 equivalents (tCO2e). At present, there are no set targets for emission reduction in the Indian agriculture sector and hence farmers can trade their carbon credits in voluntary carbon markets to earn additional income

They can do this by taking up the specified farming practices on their land and receive carbon credits. This process is commonly known as carbon farming or regenerative agriculture. Such farming practices aim to help in removing the atmospheric carbon (CO2) and store it in plants and/or soil. Some farming practices used in regulative farming include: less tillage, agroforestry practices, rotation of crops, use of cover crops, reduction of chemical fertiliser use and improved water management and irrigation techniques. Farmers receive one carbon credit for removal of one tonne of carbon emissions. They can trade these to receive additional income while also benefiting from the improved soil fertility and better vields.

Global VCM was valued at around \$2.4 billion in 2023, according to the Voluntary Carbon Credit Market Report by Global Market Insights. As per the Voluntary Registry Offsets Database (v10) maintained by Berkeley Carbon Trading Project, a total of 1,978 MtCO2e of carbon credits were issued, from around 8,777 projects, across the globe till December 2023. However, agriculture accounted for only 1.4%, while forest and land use along with renewable energy accounted for more than 70% of total carbon credits is-

India stood in first place with 1,586 projects and 321 MtCO2e of carbon credits issued till December 2023, accounting for 18% of total projects and 16% of total carbon credits. About 89% of the carbon credits were issued in the renewable energy sector in India, while agriculture received only 0.2 %. As of the end of December 2023, there are 78 VCM projects in India's agriculture sector covering areas such as improved irrigation management, manure methane digestion, rice emission reductions, and sustainable agriculture. VCMs, at the moment, are largely functional through private sector agencies and companies. To encourage small and medium farmers to avail their benefits, the agriculture ministry released a framework in January 2024. The framework aims to promote sustainable agricultural practices, and adopt regenerative farming to build climate resilience, in the country's food produc-

Apart from carbon credits, the green credit programme (GCP), which provides incentives in the form of green credits for specified activities, is also being implemented. GCP is overseen by the Ministry of Environment, Forests and Climate Change, while the implementing agency for VCM is the Bureau of Energy Efficiency. However, according to the agriculture ministry's framework, an activity generating green credits under GCP may also receive carbon credits.

Carbon credits currently fetch between ₹ 700 and ₹1,000 each in international markets. But their price is expected to increase substantially with the rise in demand in coming years. On average, a farmer may generate about 2-6 carbon credits per hectare, according to an agriculture ministry report. Although, at present, Indian agriculture is kept away from targeted emission reduction commitment, adoption of sustainable agricultural practices can help Indian the sector in mitigation and adaptation to climate change in

Major challenges and the way forward Indian agriculture is highly fragmented, with more than 80% of holdings being small and marginal. Hence, the size of holdings poses a major constraint, as pooling land across farms with diverse cropping patterns can be challenging. Another major challenge is the lack of awareness and knowledge to participate in VCMs. Moreover, it takes a considerable amount of time to receive the monetary benefits: up to 1.5 years to list and another 8 months to a year for receiving the money, studies show.

Transaction costs – in the form of measurement, monitoring, third party verification and certification etc - too add to the challenge. These costs may be very high, resulting in limited net monetary benefits for

Accurate measurement of carbon in the soil, before and after the implementation of proposed practices, is another major problem. Availability of technology, data and trained personnel are crucial for precise measurement. Carbon credit market in agriculture is in its nascent stage and requires a strict monitoring and regulatory system. There are concerns that asymmetric information, lack of transparency, and inadequate regulation could lead to unfair pricing practices for carbon credits, resulting in low earn-

Additionally, the lack of knowledge and awareness among farmers and rural communities may lead to their exploitation. Given the fast-growing VCM in the country, there is an urgent need for policy measures to ensure transparency, regulation, and widespread awareness about VCM. These systems are essential for the efficient and transparent functioning of VCM in the country to ensure that the intended benefits reach farmers. At the same time, concerns regarding the calculation of credits under the GCP need to be addressed. Activists and experts have expressed doubt over the methodology used in the process, which may lead to further exploitation of natural resources instead of protecting and conserving them.

The future demand for carbon credits is expected to increase about 15 times by 2030, according to McKinsey and Company. To address the long wait time to receive carbon credits, GCP may provide initial incentives to encourage farmers' participation in VCM until they start receiving monetary benefits from carbon credits. It is essential to strengthen and equip the agricultural extension system in the country to create widespread awareness among farmers about the framework and processes of VCM, the direct and indirect benefits of regenerative agriculture, and its long-term positive impact on their cultivated lands and crop yields. ## What does 'carbon farming' mean How to avoid fast fashion's disastrous carbon footprint and build a sustainable wardrobe

s sunny summer days return in the northern hemisphere, you may be looking to refresh your wardrobe. The allure of a whole "new you" is pervasive, and the foundation of many a successful marketing

Indeed, as the weather changes and we spend more time outdoors, you may need lighter summer clothing. However, before you run out to H&M, it is worth considering how you can sustainably add to your wardrobe while limiting its carbon footprint.

Sustainably adding to your wardrobe involves questioning your needs and taking your time shopping for each piece to understand how and where it was made – the antithesis of the fast fashion which has come to dominate global shopping trends.

These four tips can help you build a more sustainable wardrobe.

**Unsustainable clothing** 

Fast fashion refers to the rapid production and distribution of clothing to reflect the latest trends. Since the early 1990s, technological improvements, lower costs of production and streamlined supply chains have significantly shortened fashion cycles. Clothes today can be made and sold to consumers at a low price within just a few weeks of being designed.

Two seasons – autumn/winter and spring/summer – were common in the Western fashion industry just a few decades ago. Nowadays, some retailers offer tens of small seasons a year. This constant churning of trends pushes consumers to update their wardrobes frequently by encouraging disposability.

While easier on the wallet, the consequences of the fast fashion industry are myriad. According to the United Nations Environment Programme, the global fast fashion-dominated clothing and textile sector is responsible for 2%-8% of all global carbon emissions and 9% of annual microfibre pollution to oceans.

In addition, fast fashion uses about 215 trillion litres of water annually, the equivalent of 86 million Olympic-sized swimming pools. Moreover, workers are often exploited in inhuman conditions for little pay while shareholders pocket skyrocketing profits.

In response to these criticisms, a growing number of fast-fashion retailers, such as H&M and Zara, are claiming to take steps towards reducing their environmental footprint. These outlets claim, for instance, that they have replaced synthetic fibres and polyester, made from oil and petroleum, with natural and recy-

However, the ubiquity of greenwashing across the fashion industry makes it hard to tell if these claims have any weight.

Sustainable fashion

In the face of such serious concerns, how can anyone hope to shop sustainably?

The first, and in many ways most crucial, step is to simply commit to slowing down your approach to fashion itself by embracing sustainable fashion and shopping ethically to help put the brakes on overproduction and overcon-

1. Buy less, buy better: While forgoing shopping or opting for hand-me-down and secondhand options is preferable to buying new from a sustainability standpoint, such avenues may not always be possible. Therefore, try and buy fewer items of a higher-quality from sustainably conscious brands. Being careful with where, and what, you purchase can help limit the negative environmental and societal impacts of our clothing purchases.

However, most fashion retailers do not conol the entire supply chain and, thus, cannot guarantee the sustainability of their clothing. This means consumers must be diligent when shopping and make informed choices themselves. Recycling and clothing rental are valid options, however, it is worth noting that textile recycling can be expensive and not without environmental impact in terms of both materials and carbon footprint.

If you do opt for a clothing rental service, then avoid using online services that rely on delivery. Likewise, if you must purchase your clothes online, then avoid fast fashion sites like Temu in favour of buying directly from manufacturers you trust.

2. Repair, reuse and recycle: Prolonging clothing life by wearing pieces over several years and mending it when required, rather than throwing it away, can also be a great way to reduce the environmental footprint of your wardrobe. Even paying for a pair of jeans to be professionally repaired will likely be considerably cheaper than buying new – saving you money in the long-run.

Patagonia, a California-based outdoor gear retailer, encourages consumers to " repair, reuse, and recycle" items. They practice what they preach, using materials, among others, made of recycled bottles since 1993.

The French government recently introduced a country-wide program to subsidize clothes and shoe repairs with the aim to reduce the amount of clothing thrown away. Check to see if your area has similar programs and petition for their creation if not.

**3. Prioritise natural fibres:** Opt for natural fibres such as organic cotton, linen, silk, hemp and bamboo. Ideally, clothing should be durable, locally manufactured and made from fair-trade, sustainably sourced natural materi-

While natural fibres are ideal for everyday clothing, synthetic high-performance materials are essential in athletic wear or water-resistent outdoor apparel that can withstand the elements. Recycled materials and other "circular" manufacturing processes should be sought out for these needs where possible.

4. Choose simple, timeless pieces: Clothing, such as jeans, should be worn for as long as possible and be made from safe, recycled or renewable materials. The design of the garment should also be minimal. For instance, distressed jeans require the use of several toxic chemicals to give them their worn-out appearance. Forgo ever-changing trends – such as the short-lived Regencycore or Barbiecore - and add to your wardrobe slowly. Make sure that every item you buy is a good fit and aligns with your current lifestyle.

In today's world of high turnover fast fashion, it can be easy to feel overwhelmed or despondent at the relative lack of sustainable options. However, it is possible to add to your wardrobe sustainably by questioning your needs and taking your time shopping for each piece to understand how and where it was made. In time, you may even come to appreciate a smaller well-curated wardrobe of timeless pieces that you can wear for years, and not just a few weeks. (Courtesy: Scroll.in)

## "Close to 75% world's coral reefs bleached in last 17 months"

lmost three-fourths, or 72.1 per cent, of the world's coral reefs have experienced bleaching due to global heat stress, the highest recorded to date, NOAA said. Since January 2023, almost three-fourths of the world's coral reefs have been affected on a spatial scale and possibly more, said Derek Manzello, coordinator of NOAA Coral Reef Watch. In an interview with DTE, he said, "We still need the in-water coral data to really know what the impacts are. I'm slightly hesitant to say that this is the worst event on record because the last one lasted for three years, and for this one, we're in year two. It's my hope that if the heat stress goes away quickly, in the next several months, that maybe the impacts won't be as severe as they were over the three years.'

The last severe coral bleaching, lasting from 2014 to 2017, impacted 65.7 per cent of the coral reefs. However, Manzello noted that some corals take a year or two before the actual impacts are seen. The world is experiencing the fourth global coral mass bleaching on record since 1998. Manzello highlighted that apart from the spatial scale, the magnitude of the current bleaching has also been severe. He mentioned that the north and southern Atlantic Ocean, stretching farther towards the Caribbean and Florida, saw record-setting heat stress in the summer of 2023. "It was two to three times greater than ever occurred before on record in the satellite record," he said.

Mass mortality events have been recorded among reef-building species such as Elkhorn and staghorn in Florida, Puerto Rico, Mexico, and Brazil. A similar situation has been reported from the Great Barrier Reef, which has

not experienced severe bleaching since 2022. In the Indian Ocean, coral reefs have been affected in Seychelles, Madagascar, Kenya, Tanzania, Maldives, India, Thailand, Malaysia, Indonesia, and the Chagos Archipelago, among other places. He said scientists are documenting these events and mass mortality, and it could take another year to know the actual scale of the impact. He explained that corals respond to elevated temperatures and the duration of exposure to extreme heat stress. For instance, in Florida, the magnitude of heat stress was two to three times higher, and the bleaching started a month earlier than usual.

Manzello said that given the impacts of climate change resulting in frequent stops and bleaching events, it may become challenging for corals to recover in the long term.

"The big issue is when you start having mass mortalities of corals, these reefs will start shifting to a net erosional state. And what that means is, they start losing all that architectural complexity that you see on a healthy reef with all those branching corals and everything. Basically, the reef becomes flattened over time, which is detrimental.'

He added that reefs experiencing mass mortality require larvae and baby corals coming in from water columns from other parts of the ocean to regenerate. It may take about five to seven years for corals to show signs of recovery, and they are vulnerable to diseases during this phase. Full recovery can take about 15-20 years, depending on their location.

Corals are crucial to marine ecosystems as they are the rainforests of the sea. They provide habitat and food to 25 per cent of marine species globally. Mass mortality means these species lose their habitat and dependency on

the corals, he explained. Manzello noted that corals are also important for many species that have not been documented to date and are equally crucial for humans. He mentioned that some experimental cancer drugs are derived from compounds found in coral reefs.

"Hypothetically, there could be cures for all kinds of human diseases that we can source from coral reef organisms we don't even know exist. It's unfortunate that we're likely going to lose species that will never even be documented on coral reefs.

Regarding coral reef restoration exercises carried out across various parts of the globe. Manzello said the coral reef management science community's worst fear is that, given climate change, in the next 20-30 years, coral

reefs may not recover due to high stress. "We at NOAA, the Australian Institute of Marine Sciences, the University of Hawaii, the University of Miami, and others are engaged in the process of system evolution, where we are trying to find corals that have higher heat tolerance than others."

Manzello said the attempt is to identify those genes and successfully breed corals for the future that are more tolerant. "This has been successfully done in multiple locations now. There could be more outliers who have the natural

ability to adapt and evolve as well." However, he pointed out that the big issue is the scale of the problem. "For example, the Great Barrier Reef is bigger than the country of Italy. Any kind of restoration or intervention activities that take place are going to be very localised in scale." Manzello urged that it is climate change that needs to be addressed for a problem of this magnitude. cial media platform X along with the photos of the meeting. "Pleased to meet FM Maksim Ryzhenkov of Belarus today. Welcome Belarus to the SCO as its newest member. Discussed our bilateral relationship and its future growth potential," the Minister posted earlier on X. The meeting of the two Foreign Ministers came days after the first-ever India-Belarus Consular Dialogue that was held on June 28 in Minsk. "The Indian delegation was led by Dr Aman Puri, JS (CPV), while the Belarusian delegation was led by Andrei Kozhan, Head of General Directorate for Consular Affairs, Ministry of Foreign Affairs of Belarus," a statement from the MEA said on Tuesday. With nine member states -- India, Iran, Kazakhstan, China, Kyrgyz, Pakistan, Russia, Tajikistan and Uzbekistan - the SCO has emerged as an influential economic and security bloc and one of the largest trans-regional international organisations. ## Israel makes largest West Bank land seizure in 3 decades

JERUSALEM, July 3: An anti-settlement watchdog says Israel has approved the largest seizure of land in the occupied West Bank in over three decades.

The Israeli group Peace Now said Wednesday that authorities recently approved the appropriation of 12.7 sq km (nearly 5 sq miles) of land in the Jordan Valley. The group's data indicate it was the largest single appropriation approved since the 1993 Oslo accords at

the start of the peace process. The land appropriation was likely to worsen already soaring tensions linked to the ongoing Israel-Hamas war in Gaza. Violence has surged in the West Bank since the start of the war, with Israel carrying out neardaily military raids that often spark deadly gunbattles with Palestinian militants.

The land seizure, which was approved late last month but only publicised on Wednesday, comes after the seizure of 8 sq km (roughly 3 square miles) of land in the West Bank in March and 2.6 sq km (1 square

mile) in February That makes 2024 by far the peak year for Israeli

land seizure in the West Bank, Peace Now said The parcels are contiguous and located northeast of the West Bank city of Ramallah, where the Westernbacked Palestinian Authority is headquartered. By declaring them state lands, the Israeli government has opened them up to being leased to Israelis and prohib-

ited private Palestinian ownership. The Palestinians view the expansion of settlements in the occupied West Bank as the main barrier to any lasting peace agreement and most of the international

community considers them illegal or illegitimate. Israel's current government considers the West Bank to be the historical and religious heartland of the

Jewish people and is opposed to Palestinian statehood. Israel captured the West Bank, the Gaza Strip and east Jerusalem in the 1967 Mideast war. The Palestinians want all three territories for a future state. Israel has built well over 100 settlements across the West Bank, some of which resemble fully developed suburbs or small towns. They are home to over 500,000 Jewish settlers who have Israeli citizenship. (PTI)

NEW DELHI, July 3: Prime Minister Narendra Modi said on Wednesday that violence in Manipur is continuously declining and educational institutes along with businesses have opened in most parts of

THURSDAY, JULY 4, 2024

He asserted that all efforts are being made to ensure a return of complete peace in the state.

Replying on the Motion of Thanks on the President's address to a joint sitting of Parliament, Modi said the Centre is working with the state government and others to restore normalcy in the state.

The Prime Minister noted that more than 500 people have been arrested and over 11,000 FIRs have been registered in Manipur.

Modi further said Manipur is facing flood situation as well, and the Centre has dispatched two teams of the National Disaster Response Force (NDRF) to the state.

Recalling his elaborate speech concerning Manipur in the previous session of Rajya Sabha, Modi reiterated that the "Government is continuously making efforts to bring



normalcy in Manipur".

"We must acknowledge the fact that the incidents of violence in Manipur are on a continuous downward trajectory," he said, adding that this meant the hope for peace is a definite possibility in Manipur.

### Flood situation remains grim in Arunachal, over 60,000 affected

ITANAGAR, July 3: The flood situation in Arunachal Pradesh remained unchanged on Wednesday, as major rivers continued to surge above the danger mark, officials

Four districts - Namsai, Lohit, Changlang, and East Siang - bore the brunt of severe flooding, while other districts witnessed landslides following incessant rains over the past few days, they

In Papum Pare district, a cloudburst in Sagalee triggered the release of a significant volume of water from the Pare Hydropower Project (PHEP).

The district administration has cautioned the public to stay away from waterbodies. Taba Gagung Tebw, Assistant General Manager (Technical) of PHEP, urged residents downstream to remain vigilant and avoid riverbanks for fishing in the coming days.

In Bordumsa, under Changlang district, the overflowing Burha Dehing river flooded Bijoypur, Makantong, and Wagun-III and -IV areas, causing damage to bridges, culverts, crops, and live-

A high flood alert has been issued for Namsai district and Wakro circle in Lohit district, where water levels have exceeded

danger levels, officials said.

Sources from the state water resources department reported that 34 villages in Namsai and Wakro have been affected by floods so

According to official reports, five villages in Lohit district, 11 in the state capital, 16 in Changlang district, and four in West Kameng district have also been hit.

The ongoing rains and resultant floods and landslides have affected a total of 61,948 people across the state. Approximately 300 people have been evacuated to relief camps in the state capital, Changlang, and Namsai districts, officials said.

The calamity has also impacted 143.58 hectares of agriculture and horticulture land in the state.

Meanwhile, a major water supply line feeding Itanagar township has been disrupted between Zoo Road and Ganga Lake due to landslides, affecting water supply to areas such as C-sector, ESS, Gandhi Market, and others.

Restoration efforts are underway, with officials estimating it will take about a week to fully restore the supply.

In the interim, the PHE department has deployed water tankers to ensure adequate water supply wherever needed. (PTI)

GANGTOK, July 3: A team of experts from the National Disaster Management Authority (NDMA) on Wednesday conducted a comprehensive survey of the landslide-affected areas

in Sikkim's Mangan district, officials said. Accompanied by officials of the Sikkim State Disaster Management Authority (SSDMA), the NDMA team led by Deputy Commandant Rajat Malhotra visited Mangshila, Naga, Sanklang and Phidang areas.

They identified several key factors, including heavy rainfall, steep slopes, challenging topography and unstable soil composition as the reasons behind the occurrence of landslides in the strategically located Mangan district in north Sikkim.

The team also recorded the significant damage to infrastructure, including roads, houses and agricultural land, besides displacement of the local people and the impact on the local economy and livelihood, they said.

The NDMA team also interacted with the locals and took note of their grievances and assured them of long-term solutions to their

IMPHAL, July 3: Manipur Governor Anusuiya Uikey has said that necessary steps will be taken to ensure that the National Register of Citizens (NRC) is implemented in the state.

Uikey told a delegation of the Coordinating Committee on Manipur Integrity (COCOMI) and United Naga Council (UNC) on Tuesday that the matter has been discussed with President Droupadi Murmu, Union finance minister Nirmala Sitharaman and home minister Amit Shah, according to a statement issued by Raj Bhavan.

"Governor assured the representatives that necessary steps will be taken to ensure the NRC be implemented in the state and it is just a matter of time. Governor said the matter has been discussed with the President of India, Union finance minister and home minister and the Center is aware about the situation in the state," it said.

"She also assured the delegation that all necessary action will be taken up in best interest of the people of Manipur," it added.

The delegation, led by COCOMI coordinator Thokchom Somorendro and UNC president NG Lorho, submitted a memorandum to the governor, advocating for the expedited implementation of the NRC with 1951 as the base year in the state, the statement said.

The delegation urged the governor that NRC should be implemented at the earliest so that a "scientific method of identification" may be applied to detect illegal immigrants and ensure that no further infiltration occurs in the state henceforth, it said.

"Random village recognition without verification must be stopped. They further mentioned that the abnormal increase of villages in specific districts should be examined and corrective measures must be taken up," the statement said. (PTI)

## Jailed radical preacher Amritpal Singh likely to take oath as MP tommorow

CHANDIGARH/AMRITSAR, July 3: Jailed radical Sikh preacher Amritpal Singh, who recently won the Khadoor Sahib parliamentary seat in Punjab, is likely to take oath as Lok Sabha member on Friday.

The chief of the 'Waris Punjab De' outfit, who is currently lodged in Assam's Dibrugarh jail along with nine associates under the National Security Act, has been granted a four-day parole to enable him to take oath, officials in Amritsar said. Sarabjeet Singh Khalsa, an Independent MP from Faridkot, said Amritpal Singh is likely to take oath as MP on July 5.

"I went to meet Lok Sabha Speaker Om Birla at his residence in Delhi on Wednesday. He said the oath will be administered on July 5," Khalsa told PTI over phone.

He also said that clearances and permissions from various quarters to enable Amritpal Singh to take oath have come.

"I understand that he will be flown in from the prison for taking oath, which will be in the private chamber of the Speaker," he said

Khalsa said the sole purpose of his meeting the Speaker on Wednesday at the latter's Akbar Road residence in the national capital was regarding Amritpal Singh's oath taking issue.

About parole, Deputy Commissioner-cum District Magistrate, Amritsar, Ghamshyam Thori told PTI, "Amritpal Singh has been granted parole for up to four days or less beginning 5th July with certain conditions that has been communicated to Jail Superintendent Dibrugarh.

In response to another query about the parole, Thori said in a brief statement, "...granted by District Magistrate, Amritsar, after authorisation by the Home Department.'

According to Rajdev Singh Khalsa, a lawyer of Amritpal Singh who meets him in jail, said he (Amritpal), through the Dibrugarh jail superintendent, had recently sent a letter to the Amritsar deputy commissioner, who in turn forwarded it to the state government for necessary clearance to allow the jailed preacher to take oath.

His temporary release was sought under Section 15 of the National Security Act.

Having fought the 2024 Lok Sabha elections as an independent, Amritpal Singh won from the Khadoor Sahib Lok Sabha seat after he defeated Congress candidate Kulbir Singh Zira. He won by a margin of 1,97,120 votes. Amritpal Singh, who styled himself after slain Khalistani militant Jarnail Singh Bhindranwale, was arrested in Moga's Rode village on April 23 last year following an over a month-long manhunt.

The Khalistan sympathizer had escaped the police net in Jalandhar district on March 18, switching vehicles and changing appearances.

The Punjab Police had launched the crackdown after the February 23 Ajnala incident last year in which Amritpal Singh and his supporters, some of them brandishing swords and guns, broke through barricades and barged into the police station on the outskirts of Amritsar city, and clashed with police for the release of Lovepreet Singh Toofan, one of his aides.

He and his associates were booked under several criminal cases related spreading disharmony among classes, attempt to murder, attack on police personnel and creating obstructions in the lawful discharge of duty by public servants. (PTI)

## MP budget focuses on infra, women and tribal welfare; no new tax

BHOPAL, July 3: Madhya Pradesh government on Wednesday presented the state budget for 2024-25 with an outlay of ₹ 3.65 lakh crore, marking major allocations for the infrastructure development and welfare of women and tribals.

No new taxes were announced in the budget, which state Finance Minister Jagdish Devda termed as "sarvsparshi" (all-inclusive).

Devda presented the budget in the state legislative assembly amid ruckus created by the opposition Congress over the issue of an alleged nursing college scam.

The CBI is probing the alleged scam pertaining to gross irregularities in the functioning of several nursing colleges that lacked infrastructure while some existed only on

Talking to reporters after presenting the budget, Devda said the behaviour of the opposition members in the House was highly condemnable.

"The budget for the year 2024-25 has been made keeping in view the doubling of the budget size in next five years, increasing capital investment, expansion of roads, irrigation and electricity facilities, quality health facilities, attracting investment for employment generation and good governance," Devda said in his



Amid continuous sloganeering by the opposition, the government presented an outlay of ₹ 3.65 lakh crore for the financial year 2024-25, which is 16 per cent more than that of the previous year.

The budget for the women and child development department has been substantially raised to ₹ 26.560 crore from 14,686 crore in the last Devda said there will be an esti-

mated increase in capital expenditure by 15 per cent in 2024-25, compared to the budget estimate for 2023-24. The capital outlay for 2024-25 is

Hemant Soren likely to return as Jharkhand CM following consensus among JMM-led alliance MLAs RANCHI, July 3: JMM executive president Hemant Soren is likely to return as chief minister of Jharkhand for the third time following consensus

state, sources said on Wednesday. Leaders and MLAs of the alliance during a meeting at Chief Minister Champai Soren's residence here unanimously decided to elect Hemant Soren as JMM legislature party leader, they said.

"A decision was taken in the meeting to replace Champai Soren with Hemant Soren," a party source told PTI. If sworn in, he will be the 13th chief minister of Jharkhand, which was carved out of Bihar on November 15, 2000. Congress's Jharkhand in-charge Ghulam

Ahmad Mir and its state president Rajesh Thakur also attended the meeting, besides Hemant Soren's brother Basant and wife Kalpana. Hemant Soren was released from jail on June

28 after nearly five months, as the high court granted him bail in a money laundering case on June 11 after his arrest by the Enforcement Di-

linked to an alleged land scam. He had resigned as the CM before his arrest on January 31.

Meanwhile, in a post on X, BJP MP Nishkant among legislators of the party-led alliance in the Dubey said: "The Champai Soren era is over in Jharkhand. ## Zika cases in Maharashtra: Govt asks states to maintain vigil, focus on screening pregnant women

**NEW DELHI, July 3:** In view of some cases of Zika virus reported from parts of Maharashtra, the Union Health Ministry on Wednesday issued an advisory to all states highlighting the need for maintaining a constant vigil over the situation in the country.

States have been urged to focus on screening pregnant women for Zika virus and monitor the growth of foetus of expecting mothers who tested positive for the infection.

Besides the advisory by Director General of Health Services Dr Atul Goel, the ministry also asked health facilities to identify a nodal officer to monitor and act to keep the premises free of Aedes mosquito infestation.

Zika is an Aedes mosquitoborne viral disease like dengue and chikungunya. Though nonpected) in babies born to affected pregnant women which makes it a cause of major concern.

As Zika is associated with microcephaly and neurological consequences in the foetus of the affected pregnant women, states have been advised to alert the clinicians for close monitoring, the advisory stated.

States are urged to instruct the health facilities in the affected areas or those catering to cases from affected areas to screen pregnant women for Zika, monitor the growth of the fetus of expecting mothers who have tested positive for the infection and act as per Central government guidelines. The advisory has emphasised

on the importance of strengthening entomological surveillance and intensifying vector control activities in residential areas, workplaces, schools, construction sites, institutions and health facilities.

The states have been urged to



promote awareness through precautionary IEC messages in social media and other platforms to reduce panic among the community as Zika is like any other viral infection with most cases being asymptomatic and mild.

The Health Ministry said that though Zika is reported to be associated with microcephaly, no report of any such Zika-associated microcephaly has been reported in the country since 2016, the Health Ministry said.

For timely detection and control of any impending upsurge or outbreak of the infection, state au-

thorities have been advised to be vigilant and ensure the availability of appropriate logistics at all lev-States were also urged to immediately report any detected case to



"Are you well?" an exasperated bench asked the appellant, adding he needs "medical help". BERHAMPUR, July 3: Odisha Forest department will plant mangroves in a coastal village in Ganjam district to mitigate cyclone impacts and curb soil erosion, officials said on Wednesday. The plantation drive will be taken up at Purunabandh, a village located near the mouth of river Rushikulya under Khallikote range of Berhampur forest division.

Approximately 15,000 mangrove saplings will be planted across a six-hectare area near the village under the United Nations Development Programme (UNDP)-funded Enhancing Climate Resilience of India's Coastal Communities (ECRICC) project, Sunny Khokkar, Divisional Forest Officer (DFO) of Berhampur and the project's nodal officer, said. The project, costing an estimated ₹ 33 crore, aims to enhance climate resilience across 33 panchayats in four coastal blocks - Chikiti, Rangeilunda, Khallikote, and Ganjam, primarily benefiting the fishing community. Collaboration among various departments including agriculture, horticulture, fisheries, animal resources development, and watershed management is pivotal for its implementation, Khokkar emphasised. Experts have advocated for mangrove plantation in coastal Ganjam, identified as vulnerable to floods and cyclones. Mangrove forests serve as natural barriers during cyclonic events, they noted. Ganjam district faced severe impacts from cyclones Phailin in 2013 and Titli in 2018. The DFO outlined plans to conduct mangrove plantation on a trial basis in saline zones along the riverside near Purunabandh, ensuring it does not disrupt the mass nesting of Olive ridley turtles. These endangered turtles annually flock in large numbers near the village for mass nesting, although they did not arrive this year. A mangrove nursery has been set up near Purunabandh to facilitate the plantation. According to the Forest Survey of India-2021, Odisha's mangrove cover spans approximately 259 square kilometres, spanning across five coastal districts- Kendrapara, Balasore, Bhadrak, Jagatsinghpur, and Puri. ## BNS makes sexual offences gender neutral; new clauses for crime against children, women

**NEW DELHI, July 3:** The newly enacted Bharatiya Nyaya Sanhita, which replaces the British-era Indian Penal Code, has made sexual offences "gender neutral" for the victim and the perpetrator, according to official documents.

Both boys and girls could get procured for sexual exploitation. The word 'minor girl' in section 366A of the IPC has been replaced with the word 'child' in clause 96 of the BNS to cover both male and female children below the age of 18 years and the offence of procurement has been made punishable," an explanatory note for the new criminal law said.

It said Section 366B in the IPC has been made gender neutral by replacing the phrase "importation of girl from a foreign country" with "importation of girl or boy from a foreign country'

It has been introduced as clause 141 in the BNS to cover the offence of importing into India any girl under the age of 21 years or any boy under the age of 18 years with the intent that such person will be forced or seduced to illicit sexual acts with another person, it


The BNS, Bharatiya Nagarik Suraksha Sanhita (BNSS) and the Bharatiya Sakshya Adhiniyam (BSA) came into effect on July 1. They replace the IPC, Code of Criminal Procedure (CrPC) and the Evidence Act respectively.

The BNS also introduces a new chapter titled 'Offences Against Women and Children' to deal with sexual offences, according to the documents

Similar offences under the IPC were part of the chapter on 'Offences Affecting the Human Body'. Additionally, the law (BNS) proposes changes to provisions relating to rape of women under the age of 18.

It renumbers existing rape provisions and harmonises the treatment of gang rape of minor women with the Protection of Children from Sexual Offences Act (POCSO), the documents said.

Further, it said, the BNS has introduced age-based classification



POCSO and prescribes different sentencing options for the rape of minors under the ages of 18, 16

The range of punishments for rape of minors of different ages is largely the same across the IPC, POCSO, and the BNS, according to the explanation.

It further said that Clause 64(1) punishes a rape accused with 10 years to life imprisonment whereas Clause 64(2) punishes aggravated forms of rape with 10 years to life mprisonment for the remainder of a person's natural life.

Additionally, Clause 70(2) of the BNS introduces a "new offence" of gang rape of a woman under 18 years of age.

This clause of the BNS merges sections 376DA and 376DB of the IPC and removes age-based qualifiers to consider gang rape of a minor woman as an aggravated offence. "This new offence proposes that gang rape of all minor women be punishable with death or with whole life sentence. The IPC currently provides this sentencing option only for the gang rape of a woman under 12 years under section 376DB," it said.

Another "significant change", as per the explanatory statement, is that the age of consent for a married woman under the definition of rape (Clause 63 BNS and section 375 IPC) has been increased from 15 to 18 years.

"Exception 2 to section 375 IPC provides that sexual intercourse

between a man and his own wife. wife not being under the age of 15, is not rape. The change in the age of consent seeks to give legislative effect to the Supreme Court's judgment in Independent Thought vs Union of India (2017), where the marital rape exception was read down to the extent that it allowed sexual intercourse between a man and his minor wife over the age of 15 years," it said.

Clause 63 of the BNS retains the marital rape exception.

There are some changes made for crimes perpetrated against chil-

"The newly added Clause 95 of the BNS punishes a person who hires, employs or engages any person below the age of 18 years to commit an offence.

"The punishment will be the same as that provided for the offence committed by the child as if the offence has been committed by such person himself," it said.

The explanation to Clause 95 states that using a child for sexual exploitation or pornography is included within its meaning.
Additionally, Clause 137 of the

BNS proposes to make changes to section 361 of the IPC.

Under the IPC, this section criminalised the kidnapping of girls below the age of 18 years along with the kidnapping of boys under 16 years. Clause 135 of BNS proposes to make kidnapping of all children below 18 years of age an offence, as per the official explanation. (PTI)

### Army chief reviews security situation along LoC in J&K

POONCH/JAMMU, July 3: Army Chief Gen Upendra Dwivedi reviewed the security situation along the Line of Control (LoC) in Jammu and Kashmir on Wednesday, exhorting the troops to remain steadfast to meet all security challenges, officials said.

This was his first visit to the Jammu region after taking charge as the 30th chief of the Indian Army on June 30, and it assumes significance in view of the ongoing Amarnath Yatra and massive anti-terror operations underway, especially in hilly districts.

The Army chief reached Jammu in the morning and flew to the border district of Poonch to review the security situation and operational preparedness along the LoC, the officials said.

In a post on ' $\bar{X}$ ', the additional directorate general of public information the Army said Chief of Army Staff Dwivedi, along with Northern Army Commander Lt Gen Suchindra Kumar and General Officer Commanding of Jammu-based White Knight Corps Lt Gen Navin Sachdeva, visited forward locations of the 'XVI corps', as known as the White Knight Corps, to review the security situation along the LoC.

"He was briefed on the operational preparedness by the commanders on the ground. The COAS lauded all ranks for maintaining high standards of professionalism and exhorted them to remain steadfast to meet all current and emerging security challenges," the additional directorate general of public information said. In photos shared by the Army, Gen Dwivedi can be seen interacting with troops.

Earlier, the officials said, the Army chief chaired a meeting of field commanders on reaching Poonch before leaving for the forward areas. (PTI)

## 'Mirzapur', 'Masaan' made me want to tell stories that investigate humanity: Shweta Tripathi Sharma

MUMBAI, July 3: Actor Shweta Tripathi Sharma savs she wanted to be a conventional big-screen heroine who would dress up in a yellow salwar-suit and run across a farm, until she became a part of acclaimed films such as "Masaan", "Haraamkhor", and popular web series "Mirzapur". Shweta said she found "joy" in doing projects that gave her an opportunity to investigate humanity through different characters and stories. Before she tasted nationwide fame as Gajagamini 'Golu' Gupta, her "Mirzapur" character, the 38-year-old had also made a name for herself with acting credits in "Haraamkhor", "The Trip" and

"Suite Life of Karan and

Kabir". "It is important to remember why you wanted to act... I wanted to become a heroine wearing a yellow suit and dupatta in a farm because I didn't know that this kind of world ('Mirzapur') exists, I was interested in acting. Thankfully, when 'Masaan' or

'Haraamkhor' happened to me, I realised that there's a joy in doing these kinds of films.

"When I did those films, I realised this is what I want to do, I want to do cinema that tells stories where the perspective and heart (of a film) is emotions... Investigating humanity through characters and stories, and getting to know and understanding their pain, loss and happiness, but we don't talk

about all these emotions (often)." Shweta said in an interview here. The drama and getting into the skin of her character is a major draw for her.

"You'll have to break stereotypes and it is not easy because people love to put actors in boxes as we don't want to imagine (different things). What's amazing is the casting of Rasika (Dugal) for the role of Beena or Divyenndu as Munna, so this casting is a testament that as actors we should keep trying (to do different things).

"As actors, you have to keep at it no matter what, there are days when you are frustrated and crying, and you feel, 'When will I get that work that I want to do'. But I realised that this

iourney is long and projects will be coming in, what we have to do is keep trying (to do different things)", she added.

Over the two seasons of the gangster drama, Shweta's Golu has undergone a major arc shift from an intelligent college student, who advocates non-violence, to a woman seeking to avenge the murder of her loved ones. 

## FILMMAKERS TRUST ME TO PULL OFF OUT-OF-THE-BOX ROLES, SAYS TABU

MUMBAI, July 3: Be it Vishal Bhardwai, Sriram Raghavan or Neeraj Pandey, Tabu says filmmakers tend to approach her with out-of-the-box ideas, a pattern she finds difficult to decipher.

The actor, fresh from the success of heist comedy "Crew", will next be seen in director Pandey's musical romance drama 'Auron Mein Kahan Dum Tha".

The film reunites her with frequent collaborator Ajay Devgn. "It's a pattern of filmmakers

coming to me with absolutely out-of-the-box ideas, and by outof-the-box, I don't mean one kind of a film. If a filmmaker has made a gritty suspense film or an emotional drama with me, the next filmmaker comes with a comic caper. Or, somebody will come with a cop's role, and then with (comedy) De De Pyaar

"So, it's a mix of so many things that I can't explain why it happened but I'm sure there is some kind of trust factor that filmmakers feel that I can pull it off or that I'll be good at it," Tabu told PTI in an interview here.

The National Award winner said her approach to choosing projects is rooted in the equation she shares with directors Bhardwaj ("Maqbool", "Haider", "Khufiya") or Raghavan, with whom

she did "Andhadhun". She admits whenever Bhardwaj approaches her with a project, her response is instinctively

affirmative. "My approach is very characteristic to me; I can't put it in a few words or dissect or explain it. There are many factors, like my body of work of the past so many years, there is a certain kind of equation that I've with directors like Vishal and Sriram," she added.

"Auron Mein Kahan Dum Tha" reunites Tabu with Devgn, her longtime industry friend and costar of films such as "Vijaypath", "Haqeeqat", "Thakshak", and "Drishyam" franchise.

The actor said her bond with Devgn is built on mutual respect.

"We have an unspoken understanding and appreciation for each other's talent. I really value what he brings with him to a film. His understanding of cinema, of technique is just amazing and I really respect that," she said. "Both of us are very conscious about what we are doing and it has so happened that whatever has come to us, we've agreed and been on the same page. It's been great to find one co-actor in your profession that has occupied that space and that whole phenomena gave you that

platform to experience one person at different stages of your ca-

reer," she added. Asked about the box office success of her last film "Crew", Tabu said the movie worked because of several factors, including the story and a

predominantly female cast. Also starring Kareena Kapoor Khan and Kriti Sanon, the film earned Rs 150 crore globally at the box office.

"Rhea (Kapoor, producer) was always convinced that it would do very well. I was always convinced that it would do very well. There are many factors for a film to do well. But the fact that we did something like this and it worked in such a big way

is definitely exciting.' "Crew", which released in March, revolves around three air hostesses working for a fictional airline called Kohinoor, which is on the verge of bankruptcy.

How they seek to turn around their future after they find a dead crew member smuggling gold biscuits forms the core of the story. Since its release, many people who have worked as cabin crew have come up to the actor and said "we loved the film", the actor said.

"It's a happy, fun film that did well so it feels different. It's a

different kind of chemistry and rhythm to this film. It's not that we are narrating the story of one person, the format was different. I'm happy that it worked and I'm happy that it could make people laugh. So, it's great."

"You want to not disappoint people, or at least give them an experience that they will enjoy, and by enjoy I don't just mean laugh and have fun, which is also great but to be able to do movies that give people a different experience than they expected," she

"Auron Mein Kahan Dum Tha" revolves around Krishna (Devgn) and Vasudha (Tabu), a couple who separates when Krishna is jailed for murder.

They cross paths after 20 years when he is released from prison. Shantanu Maheshwari and Saiee Manjrekar play the younger Krishna and Vasudha,

## Satwik-Chirag eyeing 'great things' at Paris Olympics after cracking service variation challenge

**NEW DELHI, July 3:** Star Indian men's doubles pair of Satwiksairaj Rankireddy and Chirag Shetty has "cracked" the service variation challenge and is focussing on "comprehensive physical and mental conditioning" to ensure peak performance at the

upcoming Paris Olympics. Satwik, 23, and Chirag, 26, have been troubled by the wide variations of tumble, spin and wide serves that their opponents, mainly the Koreans and Indonesians, have employed against them during the recent tournaments. Chirag said they have addressed the "new challenge" and remains confident of negotiating it during the Paris Games. "Regarding serve variations, they are a new challenge, but placing complete importance on

PTI in an email interview.

"There was a time when we struggled with receiving them, but we eventually cracked it. We know what to do, we've been practicing, and we're confident we'll come out strong at the Olympics to counter that." The current world number 3 pair had narrowly missed out of a quarterfinal berth in the last Olympics when despite winning two of their three group matches, the duo couldn't qualify for the knockout stage as it was settled on the basis of the number of games

won and lost. "The experience of playing in the Tokyo Olympics has been invaluable in our preparation for the Paris Games. Competing at such a high level has taught us crucial lesstaying focused, and adapting to different playing conditions," Satwik said

Chirag added: "The intensity and atmosphere of the Olympics are unparalleled, and having been through it once, we now have a better understanding of what to expect and the initial jitters of being at the Olympics for the first time are also not going to be there.

"Additionally, winning the French Open has naturally given us a significant confidence boost." In the last couple of years, the duo worked its way to become the world number one after a series of sensational performance, including winning the Commonwealth Games gold medal, a bronze at the World Championships in 2022,

The statement came after a media report stated that Chopra pulled out of the event due to the adductor niggle that has been troubling him for the past couple of months.

The 26-year-old took to 'X' to say that there was no question of a withdrawal when he had not

even entered his name. "Hello, everyone. Just to clarify: the #ParisDL wasn't part of my competition calendar this season, so I haven't 'withdrawn' from it. I'm focusing on getting ready for the Olympic Games.

"Thanks for your understanding and support, and wishing all the athletes competing all the #RoadToOlympics,"

Chopra posted. He was exempted from last week's National Inter-State Championships, which was a mandatory event for all Indian athletes, by the Athletics Federation Of India.

The AFI said the relaxation was given to him due to the short turnaround time between the domestic event and the Diamond League on July 7.

'We have made it very clear that every athlete will compete in India at the Inter-State Championships," AFI president Adille Sumariwalla had said,

"But Paris Diamond League is clashing with the Inter-State Championships and we feel that Paris Diamond League will be very important for him (Neeraj) before the Olympic Games therefore he is the only guy who has been given special permission to participate in the Federation Cup," he added.

However, Chopra had indicated last month that his schedule will be decided according to the state of his body.

"We had a discussion that I



would play in the National Inter-State Championships (June 27-30) and it's going to be held in Panchkula in Haryana but it was very near to the Paris Olympics," Chopra had said. 'Since I was playing in Doha which is near to India. Moreover,

"I arrived at the ground around 30-40 minutes before the toss. I missed the team bus. The bus left

"I left for the ground at 8.43am. I almost reached the ground with the bus. It is not as if they didn't pick me because I arrived late. I wasn't going to play anyway," he added. Taskin made his way back into
