# Real estate LTCG transactions sans indexation practically beneficial for taxpayers: CBDT Chairman

NEW DELHI, July 24: The removal of indexation benefits from real estate transactions will turn out to be beneficial for taxpayers when it is seen through the prism of "actual market dynamics" rather than plain mathematics, CBDT Chairman Ravi Agrawal said on Wednesday

The head of the direct taxes administration in the country told PTI in a post-budget interview that the department did "some calculations" in this context before the measure announced by Union Finance Minister Nirmala Sitharaman on Tuesday in Parliament.

Agrawal also underlined that the new system says there will be "less tax obligation" for a taxpaver here.

The Budget 2024-25 has reduced tax rates on capital gains earned from the sale of house properties held for the long term but has removed the benefit of indexation available to taxpayers.

The LTCG (long-term capital gains) has been reduced from 20 per cent with indexation benefit to 12.5 per cent without indexation for the real estate sector.

Indexation is a mechanism to adjust the purchase price of an investment like a house to reflect the effect of inflation on such assets.

Over the concerns raised by a section that feels taking away indexation will affect the real estate market adversely, Agrawal asserted that "practically, in most of the cases, the new scheme would be beneficial"

## Sensex, Nifty close lower on profit taking in banks after budget; fall for 4th day

MUMBAI, July 24: Extending the losing streak to the fourth day, benchmark BSE Sensex declined by 280 points on Wednesday due to profit booking in financial and banking shares after the government announced a hike in securities transaction tax and short term capital gains tax in the budget for 2024-25.

The 30-share BSE Sensex declined 280.16 points or 0.35 per cent to settle at 80,148.88 with 19 of its components closing lower and 11 with gains. During the day, it tumbled 678.53 points or 0.84 per cent to

The NSE Nifty dropped 65.55 points or 0.27 per cent to 24,413.50.

From the Sensex pack, Bajaj Finserv declined by 2 per cent after its first-quarter earnings failed to cheer in-

Bajaj Finance, Hindustan Unilever, Kotak Mahindra Bank, Adani Ports, Axis Bank and State Bank of India were the other big laggards.

However, Tech Mahindra, ITC, NTPC, Tata Motors and Sun Pharma were among the gainers.

Conglomerate ITC surged to 52-week highs before closing higher by 0.42 per cent in its second straight day of gains after the budget proposed no new tax on tobacco products.

"The budget event has gone by leaving a mixed bias while reshuffling of capital gain tax is only a shortterm negative surprise. The broad market seems to be losing momentum due to lack of further traction," Vinod Nair, Head of Research, Geojit Financial Services said.

Nair added that domestic investors are biased but strong government fiscal and growth policy is attractive for FIIs, which will help to hold the ground. The recovery noticed from today's low will be evident only post the monthly expiry on Thursday.

"Profit-taking continued as investors cut their position in banking and automobile stocks, which led to a fall in key benchmark indices. However, markets ended off their lows on selective buying support al-

though concerns of higher valuations continue to weigh,' Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

## Rupee falls 1 paisa to revisit all-time low of 83.70 against US dollar

MUMBAI, July 24: The rupee depreciated 1 paisa to revisit its alltime closing low of 83.70 (provisional) against the US dollar on Wednesday, weighed down by a strong dollar against major crosses overseas amid investors' weak appetite for riskier assets.

Forex traders said the increase in capital gains tax and removal of indexation benefits announced in the FY25 Budget on Tuesday was the main reason for dollar buying as foreign investors sold stocks.

At the interbank foreign exchange market, the local unit opened at 83.69 and touched an intra-day high of 83.68 and a low of 83.72 against the dollar during the session.

It finally settled at an all-time low level of 83.70 (provisional) against the American currency, registering a fall of 1 paisa from its previous

On Tuesday, the rupee declined 3 paise to 83.69 against the US dollar after the government raised tax rates on capital gains in the FY25 Budget.

Forex traders said US dollar buying continued to be the theme after the increase in long-term capital gains tax (LTCG) and short-term

## Indo-Bangla trade resumes after two days of shutdown

KOLKATA, July 24: Trade between India and Bangladesh, which was stalled for the last two days due to the violence in the neighbouring country, resumed on Wednesday.

Trade to all major land ports in West Bengal, including Petrapole, Gojadanga, Fulbari, and Maresumed Bangladeshi Customs resumed work and the restoration of the internet link, an export body official

"Trade has resumed from the Petrapole border since this morning after the Benapole side reopened to receive cargo," Kamlesh Saini, manager of the Land Port Authority of India (Petrapole), told PTI.

Petrapole, located in Bongaon in the North 24 Parganas district, serves as South Asia's largest land port and plays a crucial role in facilitating trade between India and Bangladesh..

"Benapole border has resumed functioning. Altogether 220 trucks entered Bangladesh from Petrapole while 27 trucks reached Bangladesh today," said Sajedur Rahman, general secretary of the Benapole C&F Staff Association. (PTI)

at Kathmandu Model Hospital. Of the deceased, 15 died on the spot while three died during treatment at a local hospital, authorities said. Prime Minister KP Sharma Oli and Home Minister Ramesh Lekh separately visited the accident site to gather details about the incident and provide necessary directives. Oli said he was deeply saddened by the tragic deaths in the crash and was at the site to inquire about the cause

of the air crash with the Civil Aviation Authority's officials. He urged all for patience at this hour of grief.

According to Tribhuvan International Airport chief Jagannath Niraula, the plane flying from Kathmandu to Pokhara turned in the wrong direction. "As soon as it took off, it turned right instead of turning left," Niraula was quoted as saying by the BBC News Nepali.

However, "the cause of the accident has not been revealed yet," he said. The accident happened less than a minute after the plane took off, Niraula said. The aircraft "suffered a runway

excursion and burst into massive flames immediately", the Search and Rescue Centre of the Civil Aviation Authority The aircraft, manufactured by the Canadian company Bombardier in April 2003, was the sixth of its kind pur-

chased for use in Nepal, according to information from planesspotters.com. Following the accident, services at the Kathmandu airport were halted briefly before being resumed, the airport authorities said. According to the company's website, Saruya Airlines operates flights to five tourist destinations within Nepal, with a fleet of three Bombardier CRJ-200 jets. Nepal has been criticised for its poor air safety record in recent

years but the reasons also include partly sudden weather changes and partly airstrips located in hard-to-access rocky terrains apart from human error. According to Nepal's civil aviation body, 914 people have died in air crashes in the country since the first disaster

In January last year, all 72 people on board, including five Indians, were killed when a Yeti Airlines aircraft

crashed in the resort city of Pokhara. The crash was attributed to a human error. Yeti Airlines' 9N-ANC ATR-72 aircraft crashed on the bank of the Seti River between the old airport and the new airport minutes before landing on January 15, 2023, which was the 104th crash in Nepali skies and the third

biggest in terms of casualties. The only incidents in which more people were killed took place in July and September 1992. Those crashes involved aircraft of Thai Airways and Pakistan International Airlines and left 113 and 167 people dead, respectively. On May 29, 2022, all 22 people on board, including four members of an Indian family, were killed as a Tara Air plane crashed in Nepal's mountainous Mustang district.

In 2016, all 23 people aboard were killed when a plane of the same airline flying the same route crashed after takeoff. In March 2018, a US-Bangla Air crash occurred at the Tribhuvan International Airport, killing 51 people on board. (PTI)

The Chang'e-5 China's first lunar sample-return mission sent back the first on-site evidence of water on the surface of the moon in 2020. More discoveries were expected to follow with the return to Earth last month of China's Chang'e-6 moon mission with up to 2kg of material scooped and drilled from the moon's oldest basin on the lunar far side. "China's Chang'e-5 mission in 2020 initiated a new phase of in-depth studies on lunar samples after a 44-year hiatus, advancing our understanding of the moon's evolution," said Li Xianhua, an academician of the CAS.

However, prior to the Chang'e-6 mission, all ten lunar sampling missions in human history, including the Chang'e-5 mission, took place on the near side of the moon. "Our current knowledge of the moon primarily comes from research on samples collected from its near side, which does not represent a comprehensive scientific understanding of the whole moon," Li told state-run Xinhua news agency. #### Officials arrested

GUWAHATI: The forest department on Wednesday arrested two officials of the NRL in connection with the recent death and burial of a wild elephant on the premises of the PSU without informing the authorities concerned in Assam's Golaghat district, an official said. The forest department summoned NRL chief manager Ujjawal Nayan Handique and Manager Bedanga Kashyap and questioned them for six hours. The two were later handed over to the police for further legal proceedings. A female elephant was suspected to have been electrocuted on July 18 after coming in contact with an exposed power cable in the butterfly park, which is a part of the refinery. The NRL authorities had buried the elephant without informing the forest department and following the necessary protocols.

#### Heroin seized

MORIGAON: Two persons were arrested in Assam's Morigaon district on Wednesday after heroin worth over ₹1.57 crore was seized from their possession, police said. Acting on a tip-off, a police team conducted a search operation in Barchal village and seized 875 gms of the narcotics substance from a house, an officer said. The heroin was hidden in 77 soap boxes and was brought to the district from Dimapur in Nagaland, he said. The police arrested the two accused persons and registered a case against them.

# Plane crashes after takeoff at Nepal's Kathmandu; 18 killed

caught fire shortly after taking off from the Tribhuvan International Airport here on Wednesday, killing 18 people aboard, including a child, and seriously injuring the pilot - the only survivor.

The Bombardier CRJ-200 aircraft of Saurya Airlines, carrying 19 people, including two crew members and technical staff of the airline, was bound for Pokhara International Airport for regular maintenance service when the accident occurred at 11.11 am (local time)

"Shortly after takeoff from runway 02, the aircraft veered off to the right and crashed on the east side of the runway," said a statement issued by the Civil Aviation Authority of Nepal. It said rescue operations were initiated immediately and fire was brought under control.

"One injured person (Captain Manish Ratna Shakya) was rescued

**KATHMANDU**, **July 24:** A and taken to the hospital, and 18 Nepalese private plane crashed and People were found dead," it added.

The aviation authority identified one of the passengers as a child named Adhiraj Sharma, who was the son of Manu Raj Sharma, a technician of Saurya Airlines.

Sharma's wife Priza Khatiwada and their four-year old son Adhirai died in the crash.

A statement issued by the airline said that Priza and her son were initially identified as employees of the company, but it was later revealed that they were passengers.

Videos posted online showed the plane being enveloped in fire and smoke. Fire engines and ambulances were rushed to the spot after the incident.

The deceased were identified as co-pilot S Katuwal and employees of Saurya Airlines and a Yemeni national (Aref Reda). Pilot Captain Manish Shakya, 37, is undergoing

"I highlighted the deteriorating condition of NH 37 in Assam to him(Gadkari). I also informed him that the tender process for the Jorhat to Jhanji portion onward to Dibrugarh has been initiated and cancelled three times till date. I am skeptical whether the ongoing fourth round of the process will yield a positive outcome," Gogoi

In his letter, the MP from Jorhat said the current condition of NH 37, a lifeline for the people of Assam, has reached a critical point, causing significant inconvenience to residents and commuters alike

'The rise in traffic volume, attributed to commercial activities, tourism, and regular transportation, has far outpaced the capacity of the road infrastructure, resulting in extensive wear and tear," he

Gogoi said the Nagaon to Jakhalabandha section of the highway has undergone repairs multiple times due to "defective construction but cracks and uneven surfaces were visible within a year of construction".

## **Search ops continues for Ramen Barua**

Police questions daughter, brother of music composer

GUWAHATI, July 24: A massive search was underway in the Brahmaputra river on Wednesday for noted Assamese music composer Ramen Barua who went missing, police said.

Barua, 84, left his home in Guwahati's Latasil area on Monday morning after an altercation with a family member, and he was last seen on the road leading to the Brahmaputra near the new Gauhati High Court building, Police Commissioner Diganta Barah said.

Several people have been questioned in the case, including his daughter Barnika Barua and brother Dwipen Baruah who is a renowned singer, he said.

"On the basis of the questioning, we have come to the conclusion that he had left home as he was emotionally upset following an altercation with a family member," Barah said, refusing to identify the person.

# Chinese scientists find



BEIJING, July 24: Chinese scientists studying the soil samples of the moon brought by Chang'e-5 mission found water molecules in lunar soil, according to the Chinese Academy of Sciences (CAS).

The research - carried out jointly by researchers from the Beijing National Laboratory for Condensed Matter Physics and the Institute of Physics of CAS and other domestic research institutions - was published in the peer-reviewed journal Nature Astronomy on July 16, the Hong Kong-based South China Morning Post reported.

Based on lunar soil samples returned by Chang'e-5 mission in 2020. Chinese scientists have found a hydrated mineral "enriched" with molecular water, CAS said on Tuesday. In 2009, India's Chan-

drayaan-1 spacecraft detected signs of hydrated minerals in the form of oxygen and hydrogen molecules in sunlit areas of the moon. Among its suite of instru-

ments, it carried NASA's Moon Mineralogy Mapper (M3), an imaging spectrometer that helped confirm the discovery of water locked in minerals on the Moon.

In 2020, Nasa announced the discovery of water on the sunlit surface of the moon based on data from the airborne Stratospheric Observatory for Infrared Astronomy, which detected water molecules in the Clavius crater, one of the largest craters visible from Earth, in the moon's southern hemi-

But the lack of returned lunar samples from high latitude and polar regions means that "neither the origin nor the actual chemical form of lunar hydrogen has been determined", according to the Nature article.

The Chinese scientists studying the lunar soil isolated more than 1,000 min-"clasts". researchers said that among them was a platelike transparent crystal, dubbed "unknown lunar mineral" (ULM-1), that contained water molecules, the Post reported. The researchers ruled out the possibility that the water-bearing mineral was contaminated by terrestrial sources or rocket exhaust. But one geochemist said he expected the team to find more evidence in their further study.

"If this water-bearing mineral is present in the lunar samples, more than one piece should be found," said the scientist who asked not to be named and was not associated with the study.

# Assam police search Cong MLA's traces of water in lunar soil home in MP over cheating case

police team from Assam on Wednesday searched the residence of a Congress MLA in Madhya Pradesh's Tikamgarh city over a cheating case registered against his son, an official said.

Superintendent of Police (SP) Rohit Kashwani said a case of cheating has been registered against the lawmaker's son, Shashwat Singh, in Assam. "A team of Assam police has come here in this regard and they sought the help of local police," he said.

Keshwani said the team returned after a search at the home of Bundela, who represents the Tikamgarh assembly constituency, for three police. The SP said he was not authorised to disclose more about the matter. The MLA has yet to react to the search

Sources said this is the second time the Assam police came to Tikamgarh. The Assam police had interrogated Shashwat Singh in September last year in connection with a multi-crore cheating case, they said. (PTI)

## 3 die of Japanese encephalitis in Morigaon

MORIGAON, July 24: Three persons from Assam's Morigaon district have died due to Japanese encephalitis, an official said on Wednesday.

At present, 11 patients are undergoing treatment for the disease, and their conditions are stated to be stable, he said.

Among the deceased was Rajamani Medhi, 22, who died at the Gauhati Medical College and Hospital on Wednesday, after being diagnosed with the disease last week, he added.

"He was in ventilator support for last 4

days in GMCH battling for his life. But the youth faced untimely death. Medhi secured 1st class in Bsc physics," a local said. The other two deceased were sevenyear-old Imrana Begum of Gagalmari village and Bhabakanta Nath, 66, of Shimuluguri, the official said.

Five cases of malaria were also reported, and all the patients have recovered, District Malaria Officer Supriya Das said. Cases of both Japanese encephalitis and malaria were reported after the flood waters receded. (PTI)

## **Decoding FM's Budget** strategy

inance Minister Nirmala Sitharaman has employed a clever framework for her budget formulation, encapsulated in the acronym EM-PLOYMENT. This stands for Employment and Education, MSMEs, Productivity, Land, Opportunity, Youth, Middle Class, Energy Security, New Generation Reforms, and Technology. However, beneath this surface-level strategy lies a more intricate index, which we term CO-NANDROM—an index calculating the Chances of Nitish And Naidu to Ditch the Rule Of Modi. This index likely considers the number of MPs from both Nitish Kumar's Janata Dal (United) (JD(U)) and Chandrababu Naidu's Telugu Desam Party (TDP), their propensity to leverage their numbers to pressure the alliance, and their history of shifting allegiances. This could explain why Bihar, with fewer MPs (12) compared to Andhra Pradesh (16), received a significantly larger allocation. Bihar has been granted ₹26,000 crore for infrastructure projects including national highways, airports, medical colleges, and tourism development. This also includes the Bodh Gaya temple corridor, an initiative akin to Varanasi's development. In contrast, Naidu's Andhra Pradesh receives ₹ 15,000 crore but with crucial backing for the Amaravati-Polavaram project, a venture previously unsupported by the Modi government during Naidu's earlier alliance with the NDA. The lack of support for this project led Naidu and the TDP to exit the alliance in 2018.

The CONANDROM index seemingly assigns higher weightage to Nitish Kumar's propensity for switching sides, earning him the moniker 'Paltu Kumar' (turncoat), a stark departure from his former reputation as 'Sushasan Babu' (Mr. Good Governance). Kumar's political journey is marked by frequent shifts in alliances. In 2013, he broke from the BJP over Narendra Modi's nomination as prime ministerial candidate, which clashed with his own ambitions. In 2015, Kumar allied with the Rashtriya Janata Dal (RJD) and Congress, forming the 'Mahagathbandhan' or Grand Alliance, winning the Bihar assembly elections and becoming chief minister again. However, the alliance dissolved in 2017 over corruption charges against his deputy, leading Kumar to re-align with the BJP. This partnership lasted until 2022 when he again parted ways with the BJP, although he retained his CM position with RJD support. Ahead of the 2024 Lok Sabha elections, Kumar surprisingly re-joined the BJP, maintaining his CM role while holding a significant position in the BJP camp. Similarly, Chandrababu Naidu has had a volatile relationship with the NDA and Narendra Modi. Naidu's strategic alliances have significantly influenced the political landscape of Andhra Pradesh and his national stature. In the early 2000s, Naidu aligned the TDP with the BJP-led NDA, advocating coalition politics. However, his tenure with the NDA under Modi was fraught with tension, especially over the issue of Special Category Status (SCS) for Andhra Pradesh. This status was promised during the state's bifurcation in 2014 to compensate for losing Hyderabad.

Naidu's calls for SCS were unmet by the Modi government, leading to a full-blown political confrontation. In 2018, frustrated by failed negotiations, Naidu and the TDP withdrew from the NDA. His return to the NDA now under more favourable terms highlights a tactical political manoeuvre, demonstrating Naidu's adaptability and influence. Nirmala Sitharaman's budget, through the lens of the CONANDROM index, reveals a strategic allocation of resources aimed at maintaining alliance stability, reflecting the nuanced dynamics of contemporary Indian politics.

## War of dominance between Modi and Bhagwat acquires curious shape

The battle for dominance between Uttar Pradesh Chief Minister Yogi Adityanath and his deputy Keshav Prasad Maurya, believed to be the protégé of the Modi-Shah duo, is only the prelude; the 'big fight' is between Prime Minister Narendra Modi and RSS chief Mohan Bhagwat for the 'Hindu Hridaya Samrat' crown, though post Lok Sabha elections it will be intellectual dishonesty to think of Modi as a Hindutva icon. o a vast section of Hindus Modi turned out to be a rolling stone who gathered no Hindutva moss.

And the RSS top brass is determined to find a replacement for Modi. This, despite Modi's lieutenants going all aggressive. They have declared war against BJP leaders close to the RSS. So much so, RSS chief Mohan Bhagwat, who till now had given Modi a long rope, has decided that Modi must go. On July 18. Bhagwat observed, while addressing cadres at Gumla in Jharkhand, "that man wants to become Superman, even Bhagwan". He didn't mention Modi by name, but the audience understood.

"Is there ever an end to progress? Development is such a thing that once we reach it, we realise we can go further. When we reach our goal, we see that there is still more to go... man then wants to become a superman... in movies they show Superman who has extraordinary powers. So a human wants to have such power... but he doesn't stop there. He then wants to become a Dev. But Devtas say Bhagwan is bigger than us, so then he wants to become Bhagwan," the RSS chief elaborated.

Modi cannot complain. He created his own hell. Modi's "advisers", like Amit Shah and possibly JP Nadda, have made Modi self-delude that he is a "maker of destiny" for crores of Indians. Modi dared to even challenge the RSS. Post-2024 Lok Sabha elections, the chasm between the BJP and RSS has widened and Nadda went to the extent of saying that the BJP doesn't need the RSS. Meanwhile, Modi continues to be consumed by his autocratic hangover, not realizing that he was eroding the relevance of the BJP. Modi's autocratic style will be his political

Is it coincidence that the Yogi openly challenged Modi's authority by replacing the chief secretary loyal to Modi with his own favourite, Manoj Singh? NDA leaders Nitish Kumar, Chirag Paswan and Jayant Chaudhary, who are virtually the crutches of Modi, did not mince words when opposing Yogi Adityanath's attempt to arouse communal passions using the Kanwaria yatra. The Yogi ordered shopkeepers, vendors, handcart hawkers on Kanwaria routes to put their names on their shops and carts. It is part of a well-designed plan to snatch the initiative from Modi and present Yogi as the symbol of RSS's Hindutva. The claim that "it was done to avoid confusion" is not tenable. Yogi was desperate enough to use any weapon

The RSS wanted to put an end to the raging controversy. RSS joint general-secretary Arun Kumar convened a two-day meeting of senior BJP leaders and ministers to sort out the differences between Modi and Yogi. But the July 20-21 meeting was cancelled after Modi-loyalists leaked the information. "RSS wanted the meeting kept a secret. The Sangh did not want to appear like a peacemaker between BJP leaders blaming each other for the party's dismal show in the Hindi heartland," a senior RSS leader said.

Arun Kumar had asked CM Yogi Adityanath, Deputy CM Keshav Prasad Maurya, Deputy CM No.2 Brajesh Pathak and BJP state president Bhupendra Chaudhary to be at meeting. Yogi Adityanath cancelled all his programmes for the two days but, sensing the mood of RSS leaders, both Yogi and Modi loyalists wanted to skip the meeting, which would have laid bare the failures and fallacies of Modi and his major domo Amit Shah.

The Yogi was even ready with documents and other evidence to prove his case against Modi and Shah. Apparently, the duo was plotting against the Yogi. For public consumption it was said that the meeting had been "postponed" when in reality, the RSS did not want news of the meeting in the public domain. People shouldn't speculate if it favoured one particular group/leader over another. The façade of neutrality must be maintained at all costs. But the key reason why the meeting was scrapped was the fear of losing face if Modi supporters refused to agree to "suggestions and decisions"

That Modi challenged RSS should not go out to the public at large. The RSS mission to review the disappointing performance of the BJP in the Lok Sabha elections could not succeed. Nobody is talking of when the next meeting would be held, but the Yogi struck fast and first, leaving Modi loyalists in the lurch. ment of the meeting may have saved Modi and Shah from public humiliation but their position within the saffron ecosystem has become more vulnerable. It has simply strengthened the belief that Modi and Shah were at fault and that they were responsible for the beating the BJP got in the Lok Sabha

At the extended executive meet, Keshav Maurya had blamed Yogi government's "apathy" towards party workers as the prime reason for the BJP winning only 33 of UP's 80 Lok Sabha seats compared to 62 seats in 2019. He alleged state government officials had become too powerful under Adityanath and were ignoring ruling party workers. But Yogi was armed with complaints from the ground level RSS cadres and block chiefs that cabinet colleagues of Modi did not respond to their requests. Interestingly only some time back these RSS cadres apprised their top leaders with the same nature of complaints against Yogi and his ministers and state BJP leaders.

At the state meet Maurya had also said "the organisation is always bigger than the government", obliquely blaming Yogi for the BJP's electoral setback. His accusation was a warning for Yogi to abide by the dictates of Modi and Shah. The meeting between the RSS leaders, party leaders and Yogi was supposed to review and find out the real reasons for the dismal performance. The meeting had acquired serious implications after Modi loyalists and Yogi supporters engaged in public outrage. It is alleged that Modi loyalists kept away on Shah's instructions.

Is Amit Shah the villain of the piece, responsible for endangering Modi's position? For the last five years, Shah has been conspiring against Yogi and replacing him with Keshav Prasad Maurya. But the Yogi enjoys the support of the RSS because of his hard Hindu posture and sanctity and purity in personal life. The Yogi is not only a diehard Muslim hater; he also nurses a marked apathy towards Brahmins and Bhumihars.

RSS will take its own independent stand. The BJP not only lost 37 seats, the defeat was a serious setback for RSS, which now will find it hard to execute its expansion plan. In a tactical move the RSS has tried to send the message that "it works for shaping public opinion and does not get directly involved in elections" (Sangh lagataar lokmat parishkar ka kaam karta hai aur seedhe chunav ke karyon mein nahi lagta hai, aur who kaam is baar bhi kiva hai).

The strained relations in the BJP and RSS's readiness to strike at anytime has put Modi in a tight situation. For the first time since he became third-time Prime Minister, Narendra Modi has been warned by ally partners Nitish Kumar, Chirag Paswan and Jayant Chaudhary to refrain from indulging in hate politics and keep saffron vigilantes and cadres under check. The UP government's diktat to shop owners to name shop owners forced these leaders' hands.

They have told Modi in no uncertain terms that that perpetuating such politics would prove costly for him. Nitish Kumar's JD(U), Chirag Paswan's LJP and RLD's Jayant Chaudhary are dependent on Muslims for their political survival and they were not willing to sacrifice their future for Modi's present. They are perplexed Modi hasn't learned from the BJP defeat in the Lok

The "three crutches" believe Amit Shah is to blame. Being Union Home Minister, he could have stopped the CM from playing around with the lives of citizens, instead he chose to keep mum. Is it coincidence that Yogi's "actions" come just ahead of assembly elections in Harvana, Jharkhand and Maharashtra and is tantamount to polarizing the Hindu votebank for electoral purposes? # RBI's record dividend payment to the govt for 2023-24 was under pressure?

The Reserve Bank of India (RBI) decided to pay a record dividend of ₹ 2.11 lakh crore to the Union government for 2023– 24. Last year it paid ₹ 87,416 crore.

This is 0.64 percent of India's Gross Domestic Product (GDP) and helps the Union government reduce its budgeted fiscal deficit of 5.1 percent in 2024–25 by about 0.37 percent of the GDP, with other things remaining the same. The financial markets welcomed the news of the record dividends since it implies that the government will borrow less from the market.

The previous highest dividend was in 2018-19 when RBI declared a dividend of ₹ 1.76 lakh crore. The issue was contentious then too. The Union government wanted a large transfer to check its growing fiscal deficit and was putting pressure on RBI for it.

The matter was settled when the then RBI governor Urijit Patel prematurely resigned in December 2018 and RBI adopted the Bimal Jalan Committee Report on the Economic Capital Framework (ECF), which defined the safe levels of reserves required to be held by RBI (5.5 percent to 6.5 percent of the balance sheet

Officials have argued that the current large transfer is within this framework. The Opposition has not challenged this large transfer since it came during the ongoing general elections when the attention was focused on other critical political mat-

How does RBI, a Central bank, generate a surplus? It is not a usual economic entity, producing normal goods and services for a profit. It gets currency printed and circulated in the economy to enable transactions to

This is a unique role in the economy. It is mandated to control inflation which is taken to be a monetary phenomenon. For this purpose, it sets interest rates in the economy to impact demand and decide on the amount of money available in the economy

Further, it is a banker to the government, managing its accounts. It also acts to provide stability to highly volatile financial markets that are often buffeted by internal and external shocks and changes. To perform these tasks, it acts like

a financial institution that lends to banks and takes deposits from them. It is called a lender of last resort. To stabilise the money supply, banks have to hold a 'cash reserve ratio' (CRR) with RBI.

On this deposit, RBI does not pay an interest. But when banks have a surplus above the CRR, they deposit that with RBI to earn interest. When banks are short of funds, they borrow from RBI and pay interest on it. So, RBI earns a net interest income from deposits.

change flows and holds foreign exchange reserves. When foreign exchange comes into the country, it is deposited with RBI, and corresponding rupees are released. It releases foreign exchange to those who have to make payments abroad. This leads to the withdrawal of money from circulation.

Thus, there is a net flow of foreign exchange into and out of the nation. The excess of the inflow is held as foreign exchange reserves. These reserves are largely invested abroad in different forms to earn an income. A certain amount of gold is also bought as an investment. Of late, more gold is being bought given the international uncertainty.

The value of the foreign exchange reserves fluctuates in rupee terms as the value of the rupee changes vis-àvis the currency in which the reserves are held abroad. This results in a capital gain or loss. If the dollar was worth ₹ 50 when it was bought and today it is at ₹ 75, then a 50 percent capital gain is made and the reserves grow in rupee terms.

Similarly, on RBI's domestic holding of bonds and securities (of government and banks) as interest rates change, there is a capital gain or a loss. To take care of these fluctuations, a contingency fund is kept by

In brief, RBI holds assets and has liabilities as reflected in its balance sheet. These will change when the dividend is paid to the Union government. What will be the economic im-

RBI's accounts for any year are released in its annual report which presents the balance sheet for the year-end (March 31) and the income statement for the financial year.

Explanations for the various heads under these two statements are given in the Schedules. This is like what any firm does when it presents its annual accounts to its shareholders. In the case of RBI, the government is the owner and the report is sent to the Union ministry of finance.

The income statement lists the incomes (mentioned above) and expenditures. The difference between them is called the surplus. This surplus has increased over the last year due to an increase in the interest income by ₹ 45 thousand crore and a dramatic reduction in provisions by ₹88 thousand crore. This surplus is transferred to the Union government as a divi-

How is this surplus/dividend shown in the balance sheet and how is it paid to the government? Unlike a usual firm, RBI's surplus does not lie in some bank which drawn and distributed to the shareholders as a dividend.

In the balance sheet, there is a category under liabilities called other liabilities. It is described in Schedule 4 and mentions the surplus payable to the Union government as ₹ 2,10,873.99crore. When this surplus is transferred to the Union government, the liabilities of the banking division of RBI will decline by this

Correspondingly the asset side of the banking division of RBI must also contract by this amount. The assets in the form of Gold (₹ 2,74,714crore) and foreign investment (₹ 14,89,081 crore) constitute the foreign exchange reserves. If they are sold to pay the government, reserves will fall.

What can be sold to pay the dividend has to come from the heads of domestic investment (₹13.63.369crore) and loans and advances (₹ 3,75,593 crore), mentioned in Schedules 9 and 10.

When some of these investments and loans, and advances are liquidated, the money supply will contract. The Union government will get these funds and use them over time.

Its market borrowing will decline by this amount during the year. Further, this dividend is a transfer from RBI on which the government will not have to pay any interest.

So, the government can show a lower fiscal deficit both by showing higher income and lower revenue expenditure. We would not know if there was government pressure for this large surplus so that it could show a lower fiscal deficit in the

As RBI withdraws funds from banks, they will have to reduce their lending and that will raise interest rates in the short run which will not help increase the tepid private invest-

Thus, RBI's increased surplus is due to a dramatic reduction in provisions which is not explained in the Schedules. Further, dividend to the government is a bit like deficit financing of old. This will have an economic impact not only because the amount is large but also because RBI is unlike a usual firm paying dividends to its shareholders. (IPA Serv-



# Heatwaves are killing India's fruit bats, crucial to pollination and seed dispersal

undreds of Indian flying foxes (Pteropus medius for-Lmerly Pteropus giganteus), large fruit-eating bats, dropped dead in droves in the northern states of India due to intense heatwaves. In Rajasthan, where temperatures soared over 45 degrees celsius in May, there were multiple mass deaths, with 400 in one case, and 300 in another.

"They died as all water bodies near their roosts had dried up and they could not drench themselves in water to cool off," said Dau Lal Bohra, a wildlife researcher and head of the Department of Zoology at Seth Gyaniram Bansidhar Podar College in Rajasthan. Municipal authorities sprinkled water near their roosts to provide some respite but the damage had already been done, Bohra said.

Bat deaths were also reported in Jharkhand, Delhi, Uttar Pradesh and Madhya Pradesh over the last month. While a number of flying foxes had died in the heatwayes last year, their numbers were in the dozens, unlike this year.

This particular bat species is found only in South Asia, and plays a vital ecological role as a pollinator, and the dispersal of seeds. Until recently, though, it has attracted little research interest. It is listed as being of "least concern" in the IUCN Red List, which means that although its population is declining, it is still plentiful in the wild.

There are no exact numbers available, but conflicts with fruit growers led to a culling of the flying fox in the Maldives, leading to 80% of the population being wiped out. More worryingly, heatwaves seem to be connected to the local extinction of the species in southern Pakistan, which borders northern India.

#### Vulnerable to heat

C Srinivasulu, professor of zoology and director at the Centre for Biodiversity and Conservation Studies at Osmania University in Hyderabad, said that extreme weather fluctuations have also led to mass bat deaths in Australia. In 2014, as Australia experienced one of its hottest summers, about 23,000 spectacled flying foxes – a related species – dropped dead.

Baheerathan Murugavel, research associate at the Indian Institute of Science Education and Research Mohali, said that Indian flying foxes spend the day hanging in open tree branches, thus exposed to bright sunlight, making them vul-

nerable to high temperatures. But in India, there are few studies

waves on bat populations. One such study reporting mass mortality due to a heatwave in West Bengal was done in 2010.

Sumit Dookia, assistant professor at the University School of Environmental Science, GGS Indraprastha University in New Delhi said that summer months are the calving season for these bats, which adds to the problem.

"These bats only have one pup a year, meaning that if these babies die due to heat with the mothers, the survival of the population will be at stake if no efforts are made to protect them," he said

#### Ecological losses, zoonotic dis-

Indian flying foxes play an important part in seed dispersal, providing a key ecosystem service. When seeds pass through the guts of these mammals, the acid in the gut dissolves the outer layer of the seeds, increasing their chances of germination.

A report on sustainable management of forests through ecosystem services of bats states that bat-dispersed seeds affect the natural recolonisation of the lost population of plant species as well as the propagation of many endemic trees that sustain other endangered fauna.

Srinivasulu told Dialogue Earth, Though there are no scientific studies on this in India, [but our observations] have shown that in the places where fruit bat colonies have disappeared, regeneration of trees has gone down. We have around 200 species of trees in India that are dependent on bats for pollination," he said.

"In a local ecosystem around 18 to 20% of plant species are nightblooming, and of these around 50% are dependent on bats for pollination. This means that if fruit bats disappear, the ecological losses will be huge.'

He added that fruit bats and plants dependent on them for pollination evolved together. The plants have wider funnels for the bats to drink nectar. As the bats drink. pollen from the plants gets stuck to their wide wings, and is then dispersed when the bats fly off, pollinating the area. If bats are lost, many of these plant species will be lost too.

Plants used in textiles, foods and medicine, like silk cotton tree (semal), bitter bean, cashew nut, and mahua are examples of a few bat-pollinated plant species in India. The economic benefits drawn from these plants are huge and spread across several sectors.

"Indian flying foxes can carry

tres... and the decline in these bat numbers will directly affect the ecosystem services we get from them. But unfortunately, we do not have much research in India to quantify the losses," Murugavel ex-

Another concern is that, if the bat population falls steeply, there could be a spillover of diseases from them to humans. The Covid-19 pandemic was, according to some sources, linked to a virus found in bats. Srinivasulu said, "When we disrupt bats' habitats their stress mounts. rendering viruses more virulent. This stress-induced virulence can lead to the proliferation of viruses from one host to another, underscoring bats' potential to disseminate zoonotic diseases.

He added, "Every living organism, including humans, is a potenzoonotic vector. Some organisms harbour higher viral loads than others, while some, like bats, possess such robust immunity that pathogens have minimal impact on them.'

Nonetheless, he suggested that emphasising the risk of zoonotic diseases may be counterproductive, as misinformation about the large bats has already sparked unnecessary fears, leading to indiscriminate

#### Stigma hinders conservation

Up until the latest amendment of the Wildlife Protection Act, 1972, the Indian flying foxes were listed under Schedule V of the Act, as vermin - making their killing accept-- because they feed on fruit-bearing trees. The caretakers and owners of such orchards considered such feeding as damage to their crops. Indian flying foxes, though, were moved to Schedule II, which has severe penalties for killing animals in its list, from Schedule V, after the latest amendment of the Act in 2022.

But the bats are suffering also as part of the overall degradation of ecosystems. A study from Haryana shows that these bats prefer tall trees with broad canopies, but such tree cover is becoming harder to find. According to Global Forest Watch lost 2.33 million hectares of tree cover from 2001 to 2023.

"Linear infrastructure development impacts these bat colonies as they roost for 50 to 60 years on the same trees. As urban areas expand laterally these bats will lose their suitable habitats. As per our estimates, around 80% of the Indian flying fox colonies currently known to us in India will be lost in the next 30 years," added Srinivasulu. (Courtesy: Scroll.in)

# Unequal cities cannot be climate just: Urgent steps needed to curb climate impacts in Indian cities

The first few days of the monsoon have seen Indian cities inundated by heavy downpours. However, the worst affected are slum dwellers who invariably reside in low-lying areas with minimal drainage and sewerage facilities. While affluent gated communities can swiftly pump out the water, slum dwellers must endure it until the water subsides or the government intervenes.

Just days ago, these same cities reeled under an intense heatwave, which claimed over 100 lives and caused an estimated 40,000 suspected heatstroke cases in India, primarily impacting urban informal workers. This erratic and extreme weather has become a regular occurence and scientists warn it will only intensify in the future.

This necessitates an urgent overhaul of urban planning that addresses both inequality and climate change.

Context of Indian cities with a focus on Bhubaneswar India's slum population, according to the 2011 census data, is a staggering 65 million. Three states — Maharashtra Andhra Pradesh and West Bengal — house a third of the slum population, at 28.4 million. Even smaller states like Odisha have over 1.5 million slum dwellers, with a city like Bhubaneswar having over 436 slums.

It is this slum population that endures abysmal conditions, with minimal access to water, drainage, and proper housing. They are also disproportionately impacted by climate-related disasters like heatwaves and flooding. With the arrival of the monsoons, their situation worsens as water inundates their homes, disrupting their livelihoods. Needless to say, such adverse events trigger numerous health problems, adding to their existing struggles.

'The drain beside our slum is a breeding ground for waterborne diseases and mosquitoes," said Nandini Khurti, a resident of Tuihut, a slum located near a large drain in Bhubaneswar. "All year round, someone from our slum suffers from malaria or dengue. Regular fevers, coughs, and colds are commonplace in every household. During the rainy season, prolonged exposure to dirty water leads to skin diseases amongst many of us.'

It is in these settlements that climate-resilient planning is essential to achieve urban climate justice for these communities who contribute the least to pollution and are often referred to as the city's backbone, providing cheap and accessible labour to the urban population.

#### Contradictions in urban infrastructure: Gated communities vs. slums

Even so-called planned cities like Chandigarh, Bhubaneswar, and Delhi have not factored informal settlements, including slums and homeless populations, into their initial planning stages. These very communities are the ones who built these cities.

While everyone is affected by climate change, the brunt of floods, cyclones, heatwaves, and cold waves is borne by the urban poor. The infrastructure has not kept pace with their population growth, even though they have become politically significant due to their voting power.

#### Contradictions in basic facilities: City builders vs. other city dwellers

Time and again, slum dwellers have demanded decent wages, safety regulations, social security benefits, skill development programmes, formal employment opportunities, enforcement of labour laws, and decent living conditions to enable them to continue serving the city and earn a living. The situation has shown gradual improvement, but much more needs to be done to keep pace with rapid climate change.

"We've been living in this slum since 1997," said Dali Sahoo, a 55-year-old resident of Panitanki slum in (Courtesy: Down To Earth)

Bhubaneswar. "Earlier, when the area was relatively empty, we never had waterlogging problems. But with new apartment buildings and hospitals coming up, waterlogging has become even worse. Being a low-lying area, rainwater seeps into my house, sometimes up to waist-deep for one to two days until the water is pumped out. We have yet to be provided with a pucca house [permanent house] as promised under the Jaga Mission.'

City flooding has become a regular occurrence, highlighting the need to assess drainage, sewerage, and drinking water during the monsoon season. Livelihood loss is also highest during monsoons and disasters like cyclones that destroy homes. During Cyclone Fani, the entire city of Bhubaneswar came to a standstill. Slum houses were ripped apart, and there was no subsequent compensation for the damage. This indicates a failure to learn from the devastation of the 1999 super cyclone that ravaged

#### The path forward

The most pressing need to tackle climate injustice and inequality in cities is to involve local leaders and establish a participatory approach to urban planning. The communities that build our cities and enable a good quality of life for city dwellers deserve respect and involvement. No successful city planning strategy can be developed without the significant participation of slum communities in each city. Without these participatory processes, inequality and urban climate disasters are likely to worsen in the future.

Visiting individual slums and interacting with residents will reveal low-cost solutions to many problems. Infrastructure improvements like drainage and sewerage can be done in consultation with slum dwellers. Some infrastructure, such as flood/cyclone shelters or homeless shelters, could be planned for the grounds of government schools or other multi-use open spaces.

Regarding individual housing, while some slum dwellers in Bhubaneswar have pucca houses, others have land rights certificates that are not legal patta (registered deeds).

One innovative programme in Odisha is the Aahaar scheme, launched in 2015 across five municipal corporations including Bhubaneswar, Cuttack, Sambalpur, Rourkela, and Berhampur. This scheme provides subsidised meals to those in need in urban areas. Such programmes should be continued, as they help the urban poor maintain their nutrition while they work hard.

Similarly, the urban employment guarantee scheme should be reintroduced to support the urban poor during lean seasons, like the monsoon. This scheme could be creatively used to clean drains and assist local authorities during this period.

The government health infrastructure also needs to be revamped to better serve slum dwellers, who require it the most due to the unhygienic conditions they often live in. Finally, children should have access to good, affordable government schools. They also need support to complete their studies and find employment. New skill-building courses can empower them to break free from the cycle of poverty. Government scholarships for wards of those with labour cards through the Building and Other Construction Workers' Welfare Board are a great benefit, but this needs to be extended to the entire slum population.

In conclusion, unequal cities cannot achieve urban climate justice. The urban poor are the ones who build and enable the growth of cities. By involving them in planning, we can create habitable, climate-resilient cities that are prepared to face the increasing intensity of climate change.

# It's not just us: Other animals change their social habits in old age

**7** alnut was born on June 3, 1995, at the start of what would become an unusually hot summer, on an island called Rum (pronounced room), the largest of the Small Isles off the west coast of Scotland. We know this because since 1974, researchers have diligently recorded the births of red deer like her, and caught, weighed and marked every calf they could get their hands on -

about 9 out of every 10. Near the cottage in Kilmory on the eastern side of the island where the researchers are based, there has been no hunting since the project began, which allowed the deer to relax and get used to human observers. Walnut was a regular there, grazing the invariably shortclipped grass in this popular spot. "She would always just be there in the group, with her sisters and their families," says biologist Alison Morris, who has lived on Rum for more than 23 years and studies the deer year-round.

Walnut raised 14 offspring, the last one in 2013 when she was 18 years old. In her later years, Morris recalls, Walnut would spend most of her time away from the herd, usually with Vanity, another female (called a hind) of the same age who had never calved. "They were often seen affectionately grooming each other, and after Walnut died of old age in October 2016, at the age of 21 — quite extraordinary for a hind — Vanity spent most of her time alone. She died two years later, at the

## Are old hinds left behind?

Such a shift in social life is common in ageing red deer females, says ecologist Gregory Albery, now at Georgetown University in Washington, DC, who spent months on the island studying the deer during his PhD training. (Males roam around more and associate less consistently with others, so they are harder to study.) "Older females tend to be observed in the company of fewer others. That was easy to establish," he says. "The more difficult question to answer has been why we are see-

ing this pattern, and what it means. The first question one should ask, Albery says, is whether individual deer alter their behaviour to associate with fewer others as they age, or whether individuals that associate with fewer others tend to live to an older age. This is the kind of question that many researchers are unable to answer when simply comparing individuals of different ages. But long-term studies like the one at Rum can do so through long-term tracking of populations. Forty times a year, the deer are censused by fieldworkers like Morris who recognize the deer on sight and meticulously note where they are and with

When they accounted for the age and survival of the deer in their analysis, Albery and colleagues found that the link between age and number of associates remained solid: Social connections do, indeed, decrease as individuals age. Might this be because many of the older deer's friends have died? On the contrary, Albery and colleagues found that older deer who had recently lost friends tended to hang out with others more often.

So why do old hinds have fewer contacts? Part of the explanation may be that they don't range as widely as they grow older. Studying the deer for a couple of months would not have exposed this trend, says Albery: It was only revealed by tracking the same individuals through time. "Deer with a larger home range generally live longer," he explains, so an analysis at any single point in time would show larger ranges for older deer and suggest that home ranges expand with age. Tracking individuals through time reveals the opposite is true. "Their home ranges decrease in size as they age," Albery says.

It is unlikely that older deer move around less because they are concentrating on the core of their favorite habitat, says Albery. The center of their range shifts with age, and they are observed more often in taller and probably less nutritious vegetation, away from the most popular spots. This indicates there might be some kind of competitive exclusion going on: Perhaps more energetic, younger deer with offspring to feed are colonizing the best grazing patches.

On the other hand, older deer may also have different preferences. "Perhaps the longer grasses are easier to eat when your incisors are too worn to clip the short grass everyone else is after," Albery says. Plus the deer don't have to bend over as far to reach the longer grass.

A recent study by Albery and colleagues in Nature Ecology & Evolution found that older deer reduce their contacts more than you'd expect if their shrinking range was the only cause. That suggests the behaviour may have evolved for a reason — one that Albery prosaically summarizes as, "Deer shit where they

Gastrointestinal worms are rampant on the island. And though the deer do not get infected through direct contact with others, being at the same place at the same time probably does increase their risk of ingesting eggs or larvae in the still-warm droppings of one of their associates. "Younger animals need to put themselves out there to make friends, but perhaps when you're older and you already have some, the risk of disease just isn't worth it," says study coauthor Josh Firth, a behavioural ecol-

ogist at the University of Oxford.

In addition, says ecologist Daniel Nussey of the University of Edinburgh, another coauthor, "there are indications that the immune system of ageing deer is less effective in suppressing worm infections, so they might be more likely to die from them.'

## Bad news for old ewes?

This was the case in another study Nussey was involved in, on a remote island called Hirta, about 100 miles to the northwest of Rum, where the hardy Soay sheep flock on the hillsides of Village Bay. Founded and run by some of the same people who started the Rum Red Deer Project, the St Kilda Soay Sheep Project has tracked the lives of the sheep since 1985. Unlike the deer, the sheep are caught once a year, which allows the researchers to take blood samples to monitor their health.

In the blood, Nussey and colleagues identified an antibody that helps the sheep's immune systems resist the brown stomach worm Teladorsagia circumcincta. Higher blood levels of the antibody predict a higher chance of surviving winter, they found, and as animals age, the levels of the antibodies decline. "This doesn't mean the decline is causing the increased risk of death," Nussey specifies, "but there clearly is an association." Just as it seems for the deer, it might make sense for older sheep to keep a bit of distance from the

Though there are few published data yet on how social networks change in ageing sheep, one study did reveal that female sheep, like female deer, reduce the size of the area in which they roam. (Unlike the deer, older sheep are found in higher-quality vegetation, with the possible exception of the final year of their ives, when they might be pushed off of it.) This probably has the effect of limiting their contacts. But why would older sheep — or older deer — unaware as they are of the infec-

tion risk, reduce their range? Perhaps, given the physical decline that most ageing humans can probably relate to, and the potentially higher burdens of parasitic worms, the older sheep just don't feel so well. This might cause them to lag behind, move around less, and avoid others to stay out of trouble. "This is a behavioural tendency that also occurs in young animals when ill," says Nussey. "But older animals may feel this way more often."

If this can explain the patterns the researchers have observed, it would solve a problem that has long occupied Nussey: the selection shadow." This refers to the well-established fact that natural selection does not operate as strongly in later life, since animals of that age have done their reproducing and

rearing and there isn't much fitness to be gained anymore. If elderly animals are just doing what their kind does when they don't feel well, their changing behaviour wouldn't require an explanation involving evolutionary adaptations specific to old age.

The first step to finding out what's really going on will be to study how social life changes in the Soay sheep. If a recent application for a research grant is successful, Nussey will collaborate on this with Erin Siracusa, a behavioral ecologist at the University of Exeter in England who has already been studying elderly social networks on the other side of the Atlantic, on the island of Cayo Santiago less than a mile east of Puerto Rico.

Who's grooming grandma? In 1938, scientists released 409 rhesus macaques imported from India on this tiny, uninhabited island. The intention was to observe this species, which is important for medical research, in a more natural setting. The descendants of this population — there are about 1,800 today — have been studied there ever since, so the researchers know how old they are, whom they're related to, and with whom they often hang out.

Unlike sheep and deer, macaques dedicate much of the day to affiliating with one another. "They spend upwards of 20 per cent of their time engaged in cooperative behaviours like grooming," says behavioural ecologist Lauren Brent, also of the University of Exeter. Grooming helps to keep skin and fur healthy and clean and removes parasites, but it probably also just feels nice, and is therefore a great way to initiate and maintain friendships. These are important in this strongly hierarchical society, to avoid being attacked or mistreated.

Older females groom and are groomed just as often as younger animals are, Brent and Siracusa have calculated, but they do become more selective. "They're really shrinking the size of their social networks as they age," says Siracusa. "They tend to focus more on kin and on partners they've long had strong relationships with." And just as Albery found for the red deer, this isn't because older macaques have lost more friends or because macaques with fewer friends live longer. "On the contrary," says Brent. "Macaques that are less socially connected are more likely to die."

Perhaps, again, grooming with fewer others is a way for older and weaker animals that aren't feeling too well to reduce their chance of catching infections. It might be safer in other ways, too. "Macaques can really hurt each other," says Siracusa, "and older animals' wounds don't heal quite as well. Staying close with friends while avoiding others helps to avoid injuries.

After Hurricane Maria struck Puerto Rico on September 20, 2017, destroying nearly two-thirds of the vegetation, the macaques gained another reason to make friends, as shade became rare and proximity unavoidable. A new study by Brent and colleagues recently published in Science shows that after the hurricane, socially connected macaques were more likely to survive. Tolerance went up, even outside the shade, while aggression fell.

The Cayo Santiago work also revealed another interesting trend. Macaques that are lower in the social hierarchy lose friends faster as they age, and they are more often injured, while dominant ones maintain their positions and live longer. "You can be an elderly, infirm, hunchbacked, crusty-looking old rhesus macaque — and also the alpha female," says

This is eerily reminiscent of human societies, in which lower socioeconomic status lower income, poorer living conditions, fewer connections and opportunities — is often associated with lower life expectancy.

Brent and Siracusa don't think it's appropriate to draw lessons from macaques, or red deer, or Soay sheep, and apply them to humans directly — there are obviously many differences between the species. But Brent does think there is a cautionary tale in these studies of ageing animals for medical scientists who conduct studies comparing the health of people of different ages rather than tracking many individuals to find out how they change over time. The former, says Brent, "might suggest interventions that aren't really helpful.'

One example may be the focus today on loneliness in late life, which is inspired by studies showing that people with fewer social connections tend to have more health issues. There may be other reasons why people have fewer friends and also poor health," says Brent, "and we may need more inspired solutions to improve their wellbeing than programs targeting loneliness itself. Plus, as we have learned in the pandemic, increasing people's number of social contacts is not without

This is not to say, of course, that positive social contacts can no longer brighten the days in our twilight years. Like other animals, when we're young and healthy and natural selection is in full force, we are eager to make friends and find a mate even if that comes at a cost. Then, when we get older and enter the selection shadow, we can afford to be choosier and shrink our social networks to the size of our comfort zone. With little fitness left to gain, evolved adaptations may no longer be helping us. But close friends and family certainly can. (Courtesy: The Wire)

Prime Minister Benjamin Netanyahu speaks before Congress on Wednesday in hopes of bolstering US support for continuing Israel's fight against Hamas and other adversaries, even as the Biden administration is urging him to focus on closing a deal ending the devastating ninemonth war in Gaza.

Netanyahu is assured a warm welcome from Republican lawmakers who arranged his speech in the House chamber, an appearance making him the first foreign leader to address a joint meeting of Congress four times, surpassing Winston Churchill.

But many Democrats and independents plan to boycott his appearance. The most notable absences will be behind Netanvahu as Vice President Kamala Harris, who serves as president of the Senate and traditionally would sit behind whatever dignitary is speaking, says a long-scheduled trip will keep her away. The next Democrat in line, Sen. Patty Murray of Washington, is declining to attend.

Republicans targeted the ab-

ocratic front-runner for the presidency — as a sign of disloyalty to an ally. But Donald Trump's running-mate, JD Vance, said campaigning would also make him a no-show for the Israeli leader's speech.

And outside the Capitol, demonstrators angry over the deaths of nearly 40,000 Palestinians, or over Netanyahu's inability to free Israeli and American hostages, are promising massive

In anticipation, House Speaker Mike Johnson warned of a "zerotolerance policy" for any signs of disturbances in the Capitol building. "It is our tradition to acknowledge every guest speaker's right to free expression even if we disagree with their viewpoint," the Louisiana Republican

rote to members Tuesday. Johnson arranged the address, an honour that marks both the two countries' historically warm bonds and the political weight that support for Israel has long carried in US politics. But the attention for the visit has been diminished some by American



political turmoil of recent weeks. including the assassination attempt against Trump and President Joe Biden's decision not to seek another term.

Netanyahu hopes to project the image of a tough, respected statesman for an increasingly critical domestic audience back home in Israel. That may be difficult given the wide division among Americans over Netanyahu's conduct of the war.

Many Democrats who support Israel but have been critical of Netanyahu see the address as a Republican effort to cast itself as the party most loyal to Israel and to provide the prime minister with a much-needed political re-

the US visit are to press for freeing hostages held by Hamas and other militants in Gaza, to build support for continuing Israel's battle against the group, and to argue for continuing to confront Hezbollah in Lebanon and other Iranian-allied groups in the region. The US, France and others are seeking to calm border fighting between Hezbollah and Israel, fearing a larger war.

Netanyahu in his speech also may address a new China-brokered deal between Palestinian factions Hamas and Fatah to form a government together. The agreement was an attempt to resolve a rivalry that could make it even harder for Palestinians to secure a role governing Gaza whenever the war ends. Israel immediately denounced the pact. and State Department spokesman Matthew Miller called Hamas a terror group that should have no role in governing Palestinians.

## Ukraine's foreign min seeking 'common ground' with China in talks on ending war with Russia

BEIJING, July 24: Ukraine's Foreign Minister Dmytro Kuleba has said he is seeking "common ground" in talks this week with his Chinese counterpart on ending his country's war with Russia.

Kuleba met Wednesday with Foreign Minister Wang Yi in Guangzhou, a major commercial and manufacturing center in southern China. It is the first visit to the country by a Ukrainian foreign minister since Russia's invasion of Ukraine, which has strained Ukraine's relations with

"I am convinced that a just peace in Ukraine is in China's strategic interests, and China's role as a global force for peace is important," Kuleba said in opening remarks.

China has close ties with Russia and has pushed for an end to the war that would take into account the interests of both sides. That position has put it at odds not only with Ukraine but also Western European countries and the United States, which are demanding a Russian withdrawal as the basis for any settlement.

China did not participate in a peace conference in Switzerland last month that did not include Russia

Kuleba was expected to lobby Chinese officials to attend another peace conference planned for sometime before the American presidential election in early November. His visit reflects a calculation that any peace deal favorable to Ukraine would likely be a non-starter without China on board. Chinese officials maintained that the two countries have friendly

and cooperative relations. Noting the growth in trade between them, Wang said in his opening remarks that ties have continued to develop normally "despite complex and ever-changing international and

regional situations.' Kuleba arrived in China on Tuesday and is scheduled to depart on Friday. In a video posted late Tuesday on his social media accounts, Kuleba said he would have extensive negotiations to look for common ground in the pursuit of peace in Ukraine.

"We need to move to a just and stable peace," he said, according to a translation posted by Euromaiden Press, an Englishlanguage news site on Ukraine. "China can play a significant role in this. Let's

His visit follows a rare public rebuke of China by Ukrainian President Volodymyr Zelenskyy in June. Zelenskyy accused China of helping Russia block countries from participating in the Swiss peace conference. China denied pressuring others.

It was the first time Zelenskyy had departed from careful attempts to court Beijing away from its strong relationship with

China published a separate six-point peace plan with Brazil ahead of the conference. The move and the timing likely angered Ukrainian officials who were in the midst of seeking support for their peace proposal.

"We must avoid the competition of peace plans," Kuleba said in his social media video this week. (AP)

## Bangladesh crawls back to normalcy after violent clashes that killed nearly 200 people



DHAKA, July 24: Bangladesh was crawling back to normalcy with limited internet and office hours on Wednesday after more than a week of chaos over student protests involving government job quotas. Nearly 200 deaths were reported in just over a week

Most of the country remained without internet, but thousands of cars were on the streets of the capital after authorities relaxed a curfew for seven hours.

Offices and banks opened for a few hours Wednesday while authorities restored broadband internet in some areas in Dhaka and the second-largest city of Chattogram. Since July 16, at least 197 people have been killed in violence, the leading Bengali-language Prothom Alo daily reported could not confirm the death toll from any official sources.

Schools and other educational institutions have remained shut until further notice.

Clashes have occurred since July 15 between the police and mainly student protesters demanding an end to a quota that reserved 30% of government jobs for relatives of veterans who fought in Bangladesh's war of in-

dependence in 1971. The chaos became deadly after the country's main opposition Bangladesh Nationalist Party and right wing Jamaat-e-Islami party extended their support to the protests. While violence spread across the country, many government establishments were also under attack in Dhaka.

On Sunday, the Supreme Court ordered that 1971 war veterans' quota to be cut to 5 per cent. Thus, 93 per cent of civil service jobs will be merit-based while the remaining 2 per cent reserved for members of ethnic minorities as well as transgender and disabled people. On Tuesday, the government issued a circular, accepting formed the quota system for the government jobs. The government of Prime Minister Sheikh Hasina welcomed the verdict and said it was ready to implement the verdict

The protesters took time to respond to Sunday's verdict, and on Tuesday they said that the Supreme Court verdict and the subsequent government circular were in favour of the protesters, but the government should answer for the bloodshed and deaths involving the protests.

The protests have posed the most serious challenge to Bangladesh's government since Hasina won a fourth consecutive term in January elections that the main opposition groups boycotted. Universities have been closed, the internet has been shut off and the government has ordered people to stay at home.

Protesters had argued the quota system was discriminatory and benefited supporters of Hasina, whose Awami League party led the independence movement, and wanted it replaced by a meritbased system. (AP)

The Supreme Court on June 24, 2022, overturned abortion rights that had been in place since 1973. Since then, roughly half the states have put some sort of ban in

tions also have the worst rates of maternal mortality. Trump has repeatedly taken credit for the overturning of the federally guaranteed right to abortion. He nominated three of the Supreme Court justices who voted to overturn Roe. But he has publicly resisted supporting a national abortion

Trump's running mate, JD Vance, has said he adheres to Trump's views. But in 2022, when he was running for the Senate, Vance said: "I certainly would like abortion to be illegal nationally.'

## Trash dropped by a North Korean balloon falls on South Korea's presidential compound

SEOUL, July 24: Trash from at least one North Korean balloon fell on the South Korean presidential compound on Wednesday, raising worries about the security of key South Korean facilities from North Korean provocations.

The rubbish that fell on the ground at the compound in central Seoul contained no dangerous material and no one was hurt, South Korea's presidential security service said in a statement. But experts say South Korea needs to shoot incoming North Korean balloons at border areas next time, as it's not clear whether North Korea would put in hazardous items in future campaigns.

North Korea's latest balloon launches came days after South Korea boosted its frontline broadcasts of K-pop songs and propaganda messages across the rivals' heavily armed border. Their tit-for-tat Cold War-style campaigns are inflaming tensions, with the rivals threatening stronger steps and warning of grave consequences.

Seoul officials earlier said North Korea had used the direction of winds to fly balloons toward South Korea, but some of the past balloons had timers that were likely meant to pop the bags of trash midair. The security service gave no further details about the rubbish found at the presidential compound, like whether balloons were discovered along with the trash.

If North Korea is found to have used timers or any other device to deliberately dump trash on key South Korean facilities like the presidential office, it would certainly invite strong response by South

But experts say dropping balloons at ground targets is extremely sophisticated technology and that North Korea would certainly lack such an ability.

The security service refused to disclose whether President Yoon Suk Yeol was in the office at the time. Yoon's office earlier said he has no official schedule on Wednesday. South Korea's Joint Chiefs of Staff said

earlier Wednesday that North Korean balloons were flying north of Seoul after crossing the border and had urged people to be alert for falling objects.

It was North Korea's 10th such launch since late May. The more than 2,000 huge balloons so far have dropped wastepaper, scraps of cloth, cigarette butts and even manure on South Korea. North Korea has said it was responding to South Korean activists scattering political leaflets across the border via their own balloons. (AP)

## Taiwan prepares for a strong typhoon that worsened monsoon rains in the Philippines, killing 13 classes were suspended after nonstop rains

TAIPEI, July 24: Taiwan shuttered offices, schools and tourist sites across the island on Wednesday ahead of a powerful typhoon that already worsened seasonal rains in the Philippines, killed at least 13 people and displaced

Typhoon Gaemi's outer skirt was bringing heavy rain to much of Taiwan, where a direct landfall was expected Wednesday evening in the northern county of Ylan. Fishing boats were recalled to port amid turbulent seas, while air travellers were rushing to board overseas flights before the storm arrives, amid numerous cancel-

On Wednesday morning, the typhoon was east of Taiwan moving at 18 kilometres per hour with maximum sustained wind speeds of 183 kilometres per hour, the Central Weather Administration said. In the capital Taipei, heavy rain was falling, but high winds had not yet ar-

## Mudslides in Ethiopia have killed at least 229, people are still missing

ADDIS ABABA, July 24: Mudslides triggered by heavy rain in a remote part of Ethiopia have killed at least 229 people, including many who tried to rescue survivors, local authorities said on Tuesday, in what the prime minister called a "terrible loss.

Young children and pregnant women were among the victims in Kencho Shacha Gozdi district of southern Ethiopia, said Dagmawi Ayele, a local administrator, adding that at least five people have been pulled out alive.

The death toll rose sharply from the initial one of 55 late on Monday. Search operations continued in the area, said Kassahun Abayneh, head of the communications office in Gofa Zone, the administrative area where the mudslides occurred.

Ethiopia's ruling party in a statement said it felt sorrow over the disaster. Prime Minister Abiy Ahmed said in a statement on Facebook that he was "deeply saddened by this terrible loss."

The federal disaster prevention task force has been deployed to assist in search and rescue efforts, Abiy's statement said. It was not immediately clear how many people were still unaccounted for. (AP)

# Last Sunday was Earth's hottest day in all recorded history, European climate agency says

WASHINGTON, July 24: On Sunday, the Earth sizzled to the hottest day ever measured by humans, yet another heat record shattered in the past couple of years, according to the European climate service Copernicus on Tuesday.

Copernicus' preliminary data shows that the global average temperature Sunday was 17.09 degrees Celsius (62.76 degrees Fahrenheit), beating the record set just last year on July 6, 2023 by .01 degrees Celsius (.02 degrees Fahrenheit). Both Sunday's mark and last year's record obliterate the previous record of 16.8 degrees Celsius (62.24 degrees Fahrenheit), which itself was only a few years old, set in 2016.

Without human-caused climate change, records would be broken nowhere near as frequently, and new cold records would be set as often as hot ones.

"What is truly staggering is how large the difference is between the temperature of the last 13 months and the previous temperature records," Copernius Director Carlo Buontempo said in a statement. "We are now in truly uncharted territory and as the climate keeps warming, we are bound to see new records being broken in future months and years.

While 2024 has been extremely warm, what

kicked on Sunday into new territory was a way toastier than usual Antarctic winter, according to Copernicus. The same thing was happening on the southern continent last year when the record was set in early July. But it wasn't just a warmer Antarctica on Sun-

day. Interior California baked with triple digit heat Fahrenheit, complicating more than two dozen fires in the U.S. West. At the same time, Europe sweltered through its own deadly heat wave. "It's certainly a worrying sign coming on the heels of 13 straight record -setting months," said

who now estimates there's a 92% chance that 2024 will beat 2023 as the warmest year on record. July is generally the hottest month of the year globally, mostly because there is more land in the Northern hemisphere, so seasonal patterns there drive global temperatures.

Berkeley Earth climate scientist Zeke Hausfather,

Copernicus records go back to 1940, but other global measurements by the United States and United Kingdom governments go back even further, to 1880. Many scientists, taking those into consideration along with tree rings and ice cores, say last year's record highs were the hottest the planet has been in about 120,000 years. Now the



first six months of 2024 have broken even those. Scientists blame the supercharged heat mostly on climate change from the burning of coal, oil and natural gas and on livestock agriculture. Other factors include a natural El Nino warming of the central Pacific Ocean, which has since ended. Reduced marine fuel pollution and possibly an undersea volcanic eruption are also causing some additional warmth, but those aren't as important as greenhouse gases trapping heat, they said.

Because El Nino is likely to be soon replaced by a cooling La Nina, Hausfather said he would be surprised if 2024 sees any more monthly records, but the hot start of the year is still probably enough

to make it warmer than last year. Sure Sunday's mark is notable but "what really kind of makes your eyeballs jump out" is how the last few years have been so much hotter than previous marks, said Northern Illinois University climate scientist Victor Gensini, who wasn't part of the Copernicus team. "It's certainly a fingerprint of climate change."

University of Pennsylvania climate scientist Michael Mann said the difference between the this year's and last year's high mark is so tiny and so preliminary that he is surprised the European cli-

mate agency is promoting it. "We should really never be comparing absolute temperatures for individual days," Mann said in an

Yes, it's a small difference, Gensini said in an interview, but there have been more than 30,500 days since Copernicus data started in 1940, and

this is the hottest of all of them. "What matters is this," said Texas A&M University climate scientist Andrew Dessler. "The warming will continue as long as we're dumping greenhouse gases into the atmosphere and we have the technology to largely stop doing that today. What we lack is political will." (AP)

# Tripura rights panel issues notices to DGP, Dhalai DM on Gandatwisa violence, seeks reports



AGARTALA, July 24: The Tripura Human Rights Commission has served notices to DGP and Dhalai DM on violence in Gandatwisa earlier this month, and sought to know what action has been taken against those involved in arson and looting houses in the area. The rights panel asked Director General of Police Amitabh Ranjan and Dhalai District Magistrate Saju Vaheed to submit their reports within three weeks.

Many houses were looted and set on fire by a mob on July 12, following the death of a 19-yearold man in a clash between two groups in Dhalai district.

"Before initiating a formal inquiry, the commission likes to ask for a report from the DGP, Tripura as to what action has been taken by the law enforcement agencies to nab the offenders of such gusty incident and whether any criminal

# Record allocation in railway budget to transform northeast: Ashwini Vaishnaw



HT Bureau GUWAHATI, July 24: Ashwini Vaishnaw, minister for Railways, Information & Broadcasting and Electronics & Information Technology, on Wednesday, held an interaction with media persons of north-east virtually from New

Delhi in connection with the allocation for the Railway Ministry in the General Budget 2024-25. While addressing the media persons, the minister of Railways informed that a record allocation for capital investment of ₹ 2.62 lakh crores has been provided for the railways. A large part of it, i.e. on safety-related activities such as replacement of old tracks with new ones, improving signalling systems, installation of Kavach system, construction of road under bridges/road over bridges by replacing existing level cross-

ing gates. He further said that this budget focuses on introduction of new rolling stocks like Amrit Bharat Trains, Vande Metro, and Vande Bharat Sleeper. Railways' direction on safety first, comfort of passengers, capacity augmentation and improving the infrastructure of railways are

prioritised. An advanced version of 'Kavach 4.0' has got recent approval, which will be installed at a rapid pace. 'Kavach 4.0' is a combination of hardware, software, optical fibre, telecom tower, on-track system, stations and data centre administration. The minister of Railways informed that due to the rising demand for general coaches, railways had decided to manufacture 2,500 general coaches in this current fiscal year. Further, it has been decided to manufacture an additional 10,000 general coaches to cater to the rising

The minister of Railways said that the gross budget allocation for NF Railway for the FY 2024-25 is ₹ 14,183.69 crores. The allocation for north-eastern states is ₹ 10,376 crores, which is about 5 times higher than the average allocation of ₹ 2,122 crores made during 2009-14.

During the interaction, GM informed that adequate funds have been allotted for all infrastructure & safety related works as compared to previous years. The general manager announced that electrification of 921 RKM was done during 2023-24. 1,573 RKM forming north-eastern states.

# India-UK FTA negotiations floor not ceiling of our ambitions: British Foreign Secretary David Lammy

*India is emerging superpower of the 21st century, the* largest country in the world with 1.4 billion people and one of the fastest growing economies in the world

NEW DELHI, July 24: British Foreign Secretary David Lammy on Wednesday began a two-day visit to India to galvanise negotiations for an ambitious Free Trade Agreement and reset the overall bilateral partnership in crucial areas such as clean energy, new technologies and security.

THURSDAY, JULY 25, 2024

As he embarked on the high-profile trip, Lammy described the negotiations for the trade deal as the floor and not the ceiling of the ambitions to unlock shared potential and deliver growth.

The British foreign secretary's visit to New Delhi is the first highlevel engagement between India and the UK after Prime Minister Keir Starmer's Labour government came to power on July 5.

"India is the emerging superpower of the 21st century, the largest country in the world with 1.4 billion people and one of the fastest growing economies in the world," Lammy said.

"Our Free Trade Agreement negotiations is the floor not the ceiling of our ambitions to unlock our shared potential and deliver growth, from Bengaluru to Birmingham," he said.

A British government readout said, Lammy will push for a "reset" of the UK-India partnership, including through reinforcing London's commitment to securing a free trade agreement that will benefit both economies.

It said the foreign secretary will also galvanise support for accelerated action on the climate crisis with India as an "indispensable partner", driving forward the clean energy transition and creating opportunities for British and Indian businesses. He will discuss partnering on Indian-led global initiatives to build clean power access, climate resilience in the global south and small island states, it said.

"We have shared interests on the green transition, new technologies, economic security and global security," Lammy was quoted as saying in the readout.

"I am travelling to India in my first month as Foreign Secretary because resetting our relationship with the Global South is a key part of how this government will reconnect Britain for our security and prosperity at home," he said.

In a post on 'X', External Affairs Ministry spokesperson Randhir Jaiswal said Lammy's visit will strengthen the comprehensive strategic partnership between the two countries.

Lammy and External Affairs Minister S Jaishankar will hold wide-ranging talks this evening that is expected to focus on the FTA and New Delhi's concerns over activities of pro-Khalistan elements in Britain, people familiar with the

The British foreign secretary is also scheduled to meet Commerce Minister Piyush Goyal during which both sides are likely to reaffirm their commitment to the proposed free trade pact, they said.

It is learnt both sides have already agreed on almost 90 per cent of the trade pact but the remaining 10 per cent comprised several sticky issues such as import duties on automobiles and scotch whisky and visas for business people. The British readout said Lammy will highlight the importance of a new partnership with India that focuses on economic, domestic and global

Economic, domestic and global security will be at the heart of the foreign secretary's first visit to India as he travels to New Delhi to unlock the full potential of the UK-India partnership

He will tell his Indian counterpart that he wants to drive forward greater growth for both countries, it

The foreign secretary will underscore the importance of the "living bridge" between the UK and India.

It represents the 1.7 million people with Indian heritage that have made their home in the UK and make an exceptional contribution to British life, the readout released by the UK high commission in New Delhi said.

"In a visit to India's third largest technology company, the Foreign Secretary will meet business leaders to highlight how the UK and India are working together on shared ambitions such as cuttingedge science to encourage innovation, boost trade, and improve the livelihoods of working people in both countries," it said.

The foreign secretary will also hold high-level talks with members from the Indian government, including Jaishankar, it said.

Lammy will reiterate the extraordinary contribution of British Indians, saying that they enrich the UK's social and economic landscape and are the epitome of modern Britain, it added.

In their talks, Jaishankar and Lammy are also expected to review the implementation of the India-UK roadmap that seeks to broadbase the ties in a range of areas.

In 2021, India and the UK adopted the 10-year roadmap to expand ties in key areas of trade and economy, defence and security, climate change and peopleto-people connections among others.

Jaishankar and Lammy are also likely to deliberate on pressing global challenges, including the Russia-Ukraine conflict and the situation in the Middle-East. (PTI)

"We worked there under a contractor for four months, but received no payment. We also started facing food-related problems," he told reporters. Jharkhand Labour Secretary Mukesh Kumar said his department has 10 lakh registered labourers. (PTI)

## 'KILL' A **LOVE STORY** WITH TWIST, SAYS **DIRECTOR NIKHIL NAGESH BHAT**

NEW DELHI, July 24: Two lovers on a train journey instantly conjures up the image of "Dilwale Dulhania Le Jayenge" but director Nikhil Nagesh Bhat says he wanted to tell a different kind of love story with "Kill".

The film, which released in India on July 5 to positive reviews and is still in cinemas three weeks after its release, has been billed as the most violent movie ever made in India by its producers Dharma Productions and Sikhya En-

Starring Lakshya, Raghav Juyal and Tanya Maniktala, the film's story is inspired by a train robbery that Bhat witnessed in his student days but he understands the "DDLJ" connection with trains.

That film is so ingrained in us that whenever we think about trains, we think about romance. This is also a love story at heart but with a twist," the filmmaker told PTI in

"Kill" is set on a moving train and revolves around an army commando, who boards the train his lover is travelling in with her family. He soon realises that robbers have taken over the train and he must face off against these group of bandits as they start looting and killing passengers randomly.

Bhat said he wrote the basic premise of "Kill" in 2016 based on the robbery incident that happened during his train ride from Patna to Pune in the 90s. He told a friend about the story and forgot about it only to receive a call from the friend who informed him that she had given a brief synopsis of the story to Guneet Monga and the producer wanted to meet him.

"I met Guneet and told her that it is an impossible story to make as it is all about 'vibhats ras'. But Guneet said, if it is difficult, then we must do it' and that's how the journey began. We wrote the first draft and went to Karan (Johar),"

Johar also boarded the movie just after a brief narration,

which came as a major confidence boost for Bhat, who had previously made films such as "Brij Mohan Amar Rahe" and "Hurdang" and web shows "The Gone Game" and "Rasbhari".

The maximum action in those projects, he explained, would probably include a slap but "Kill" was a challenge as it revolved around a man who transforms into a killing machine during when things go south.

Having Sikhya and Dharma as backers helped find the right people to execute

"It was my first action film and I was trying to ensure that when the audiences see it, they feel like they are on the train as passengers and going through the tragedy. It was an important challenge and everything hinged on that because if I manage that, I will involve them in the story and its emotions," he said. The action in the movie had to be designed in a way that it captured the "contained

pressure cooker" like situation inside the confined space of a train compartment. "You cannot change the setting or location so the only thing you can change is the way each killing is depicted. During the writing phase, I would wake up and imagine myself as the protagonist and his adversaries and ghost fight in those

> my action choreographers come, they, at least, have a blue print to build upon," he said. The film premiered at the Toronto Intern Film Festival's Midnight Madness section to positive reviews last year. Asked about the violence in the movie, Bhat said while the film is "gory and full of action", the portrayal makes it different

Lakshya was the first to come on board as the filmmaker was impressed by the way he responded to the story that he didn't even want to meet other actors who were supposed to audition for the role. (PTI)

# It's a phase, we should focus on films that did well: Rohit Shetty on Bollywood performance in 2024

MUMBAI, July 24: Bollywood movies not doing well at the box office this year is just a phase and one should focus on films that have been successful, says filmmaker Rohit Shetty as he hopes his much-awaited "Singham Again" makes viewers

Other than small and mid-budget movies like Kiran Rao-directed "Laapataa Ladies", Dinesh Vijan's home production, "Munjya", Kareena Kapoor Khan and Tabu-starrer "Crew", Ajay Devgn's "Shaitaan", and Rajkummar Rao's "Srikanth", the first half of the year has been dismal for the Hindi film industry with the failure of "Bade Miyan Chote Miyan", "Maidaan" and "Yodha".

But Shetty, known for making big budget, star-studded blockbusters, is not worried.

"It's a phase which comes every five to six years, where a year or two goes bad business-wise. Like, we have had 'Pathaan', 'Jawan', 'Gadar 2', and 'Oh My God 2', so it's like missing time syndrome. So, we focus on that, we don't look at films that did well," the filmmaker told PTI in an interview.

"For instance, 'Gadar 2', it's not like they did business of Rs 100 or Rs 200 crore, it did Rs 500-600 crore plus business. We need to focus on the good part. It happens, you've phases. It's a cycle.

Following the commercial success of films like "Pathaan", "Jawan", and "Gadar 2" last year, many thought action genre was going to be the flavour of the season but Shetty said such assumptions are wrong.

"We come to a conclusion very soon that only action will work or comedy will not work. Films have to be taken individually, irrespective of the genre. We don't know which film will work, which won't and that's a fact of life," he said.

The 50-year-old director is optimistic about "Singham Again", his next directorial venture with frequent collaborator Ajay Devgn, which opens in theatres on November 1 on the occasion of Diwali.

"It is a big responsibility. I hope when it comes, it will make everyone happy like how 'Sooryavanshi' opened in theatres after COVID-19. I hope this one also makes everyone happy. If that is done, then my job is

The upcoming action film is the third film in the "Singham" series, which started with 2011's "Singham" and was followed by "Singham Returns" in 2014. These movies are tied with the storylines of "Sooryavanshi", led by Akshay Kumar and

"Simmba", starring Ranveer Singh. Shetty, however, is wary of comparisons between his cop universe

and Avengers movies.

"I can't compare 'Singham Again' with 'Avengers'. They are too big. Ours is a cop universe, we've Ajay, Akshay, Ranveer, and Kareena, and then there are new characters this time. We are trying to work in our world and the way it is shaping up, I think people will get what they want from 'Singham Again'.

The idea, he said, is to create content that appeals to a wide segment of

"You need to up your game every time because there's a lot of exposure that the audience has, so you need to be on that level. We've to be on that level," he said.

In "Singham Again", Devgn will

reprise his fan-favourite cop character of Bajirao Singham, and Arjun Kapoor will be seen as the antagonist. Kareena Kapoor Khan, who played Devng's love interest in the second part will be seen in the third


"Singham Again" is the fifth part in Shetty's cinematic cop universe, which includes Ranveer Singh's "Simmba" (2018) and Akshay Kumar's "Sooryavanshi" (2021).

alongside tennis icon Roger Federer to taking a set off Chinese legend Ma Long, India's flag-bearer for Paris Olympics, Achanta Sharath Kamal, on Wednesday recalled the most memorable moments from his five appearances at the Games so far. The 42-year-old table tennis legend helped the Indian men's team qualify for the first time in history and is believed to be set for his final appearance at the Games.

I feel like I have seen him somewhere. I couldn't recognise who he was with his hair let loose," he said in a release from Ultimate Table Ten-

"We pass each other -- we actually cross paths -- (and) he goes to give his bag at the baggage keeping area. I walk in, take my plate looking at what to eat and it suddenly strikes me. Man, it's Roger

Sharath said he was rather shy searched for the Swiss ace.

"He was sitting at one of the tables all by himself. I went as close as possible. I didn't want to get in his place but still got close and I was eating (on the same table)," he continued.

"Suddenly, a guy comes in with a reverse hat and shorts and they are clapping hands. I look at him and it's Andy Roddick," Sharath

MUMBAI, July 24: Human excellence is often closely linked to human fortitude and Olympics is the prime example of it.

the podium. It will also boil down to the mind and how one can discipline it to cope with the grandeur and pressure of the big moments.

Visualisation, blocking out the noise and being focussed are among the techniques that are often talked about but are they as easy to implement in a highly competitive environment?

'There is a lot of pressure (already) in sports and when you compete at the Olympics, you have to be someone who has gone through a lot of highs and lows as well," explains Dr Divya Jain, a sports psychologist with Fortis Healthcare.

"In sports, you're confronted with winning and losing on a day-to-day basis, so it's not about

winning every time; it's about how you recover, how quickly you bounce back from a mistake," she said while explaining between difference

Olympians and other athletes. "There is public scrutiny, staying away from family, the noise of the Games... All of these are Needless to say, talent alone aspects that athletes have to cope won't decide who finishes on with at a psychological level,"

# Pierre de Courbetin - the greatest forgotten hero

PARIS, July 24: Pierre de Coubertin, the visionary behind the modern Olympic Games, is buried in the pages of history.

Inspired by historian and educator Thomas Arnold, who had introduced sports in British schools, Coubertin initially used sports as a tool to bring about educational reforms in France.

Eventually, the dream took: better shape and in 1894, he founded the modern Olympics, which gradually grew into the greatest sporting show on the planet. Convinced that sports can play a key role in character building, Coubertin, born into a French aristocratic family, conceived an international sports competition. He was a cofounder of the International Olympic Committee (IOC).

Athens hosted the first ever Olympic Games in 1896. When France became host for the second time in 1924, that was the last instance when Coubertin, who held the title of Baron, was actively involved in the organisation of the spectacle.

Unfortunately, the man who created the show, died in obscurity in Geneva in 1937.

A century later when France is ready to conduct the Games in the grandest fashion, is Pierre de Coubertin just a memory? Do the people of France remember him?

"This is a hard question to answer," his great-great-grandniece Alexandra de Navacelle de Coubertin told PTI in an exclusive interview.

"In France, there are more than 600 places that have his name, sports stadium, streets, and schools, so he is definitely known and remembered, but since he lived over 100 years ago, people do not remember exactly what he did," she admitted. Alexandra is a part of the fourth generation of Coubertin's descendants.

In 2016, they decided to form the Pierre de Coubertin Family Association as a representative of the 30 descendants that exist today. "All the descendants of Pierre de Coubertin come from his sister Marie de Coubertin who he was very close to. After Marie's husband died, he took care of her and her children. He was therefore a second father to my direct family. "Since his death in 1937, there has always been a nephew of his at the IOC to represent his spirit. This role has been passed on from generation to generation." (PTI)

# Women's boxing fights its way to parity with the men's game, just 12 years after its Olympic debut

Charley Davison's husband and their three young children were already in bed back home on the east coast of England before she pulled on her headgear and stepped into the World Boxing ring in southern Colorado ear-

lier this year. The 30-year-old Davison was able to pursue her Olympic dreams half a world away from her family only because of the spectacular growth of women's boxing. In just over a decade, the sport has proliferated from its Olympic debut with only 36 fighters in three weight classes in London to become an equal part of the tournament in Paris, where half of the 248-fighter field will be women competing in a record six weight classes. The addition of a 54-kilogram bantamweight division at the Paris Olympics changed the

game for fighters like Davison. "After the Tokyo Olympics, if there wasn't going to be a 54 (division), I would have hung my gloves up," said Davison, a former youth champion who left

returning to get in shape after having kids.

"Because 51 (kilos) was getting too hard, and 57, I'm not quite big enough for that one, I feel," she added. "So 54 was a blessing. As soon as I heard that weight, I knew it was for me. Every kilo makes a difference. I know I'm not the only one who's grateful. I think it's ideal for a lot of women to have this many weight classes. It makes such a difference for the sport."

Davison fought for Britain in Tokyo, but lost early. Three years later, she has the opportunity to try again only because of the IOC's commitment to the sport's growth. Boxing essentially has reached gender parity along with the rest of the Olympic program, and dozens more women are getting a shot.

"Since I've started, especially on the international level, the level (of women's boxing) has raised incredibly," said Canada's Tammara Thibeault, the middleweight world champion and an Olympic quarterfinalist in

Tokyo headed to her second Games. "That makes us all better, because we elevate each other. That's how a sport grows, and we're really growing right now." Women's boxing entranced athletes like Australia's Tiana Echegaray, who had never boxed just five years ago. She was 25 and working at a boring

# Archers aim to break medal jinx, aim for first Games medal in Paris

PARIS, July 24: A different year and another Olympics, but for Indian archers, the target will be the same -- fetching their first ever medal at the Games

More or less regular at the Olympics since debuting back in 1988, the archers will kick off the nation's Paris campaign here on Thursday with the qualification rounds at the Les Invalides gardens here.

For the first time after London 2012, India will have a full six-member squad after both the men's and women's teams qualified on the basis of rankings. This means they will compete in all the five

Veterans Tarundeep Rai and Deepika Kumari, appearing in their fourth Olympics, will lead their young teammates, hoping to securing at least a top-10 finish in the qualification round to ensure a favourable draw.

Each archer will shoot 72 arrows and the scores in the qualification round of 128 athletes from 53 countries will decide the seeds for the main knockout competition beginning with the women's team finals on Sunday.

The qualifying round will crucial for the Indiana with be crucial for the Indians, who have often slipped in the seedings and ended up losing to heavyweights Korea, tipped to top the qualifications.

At the Tokyo Olympics, all the male archers finished outside the top-30 and got the ninth seeding as a team. Deepika, the sole woman archer there, also got a ninth place in rankings. Both ended up losing to top-seed Koreans in their respective quar-

On form front, India will have high hopes from the men's team, which won a historic World Cup this year in Shanghai, upsetting Korea for the first time in a final.

They will have the experience in Rai and Tokyo Olympian Pravin Jadhav, while debutant Dhiraj Bommadevara will be on a high after beating Tokyo Olympics silvermedallist Mauro Nespoli of Italy en route a bronze at the World Cup Stage-3 in Antalya

Individually, debutant Dhiraj is seen as a



bright prospect as he has tasted success by winning the Asian Games team silver last year, albeit with different teammates.

Known to be "ice cool" in tough situations, Dhiraj would look to overcome the bitter memories of Hangzhou Asian Games where he botched up his release twice to exit in the individual quarters.

Deepika will fight against herself in a redemption act.

# It's a now-or-never situation for me: Tarundeep Rai



PARIS, July 24: It's a "now-ornever situation for me", says veteran Indian archer Tarundeep Rai as he seeks to win a maiden Olympic medal in his fourth appearance at the Games while also serving as the team's unofficial mentor in Paris.

The 40-year-old Rai has won medals in every championships at the global and continental level but not the Olympics.

He has two silver at the World Championships (2005, 2019), nine World Cup medals, including three gold, a silver and a bronze in Asian Games, two silver and a bronze in Asian Championships.

"It's emotional every day. It's the fourth time. It's a now-ornever situation for me, and that's what I tell my teammates too. Maybe someone playing his first or second Olympics should think like it's now or never. You have to put in an effort as if it's going to be your last," Rai told PTI in an interview.

The veteran archer from Sikkim was part of the Indian teams at the 2004 Athens, 2012 London and 2021 Tokyo Olympics. He exited in the first round in the individual event in Athens, and in the second round in both 2012 and 2021 editions.

In Tokyo, the men's team, which had Tarundeep Rai in it its ranks, reached the quarterfinals. "Olympics is a dream for

everyone, and I'm no different. You need an extreme level of preparation for this, and you have to put in a lot of hard work to qualify and win a medal. The colour of your sweat sometimes turns red," Rai said ahead of the

whatever I lacked, the objective is to rectify. Will do my best,' said Rai who hails from Namchi in Sikkim.

# England can make 600 Test runs in a day's play



LONDON, July 24: Ollie Pope reckons England can breach the 600-run mark inside a day's play in Test cricket while ruling out any let up to their ultra aggressive 'Bazball' approach with the bat.

England hold the record for the most runs scored in a day when they piled up 588 for 6 on the second day of the Manchester Test against India in 1936, and Pope believes the current side under Ben Stokes can eclipse that.

"Sometimes we might score 280 to 300 in a day but that's OK and probably because we're reading situations. There might also be a day where we go and get 500 to 600 at some point in the future as well. And that's a cool thing to have," Pope was quoting as saying by 'BBC Sport'.

In December 2022, England smashed 506 runs on the opening day of the first Test against Pakistan in Rawalpindi.

England are currently 2-0 up in the three-match Test series against the West Indies after they followed up a victory by an innings at Lord's with a comprehensive 241-run win at Trent Bridge, Nottingham last week.

The third and final Test starts on

Friday at Edgbaston. The win in Nottingham was the first time England scored 400-plus in both innings of a Test match with totals of 416 and 425. Pope (121 in first innings) was one of three England centurions in the second Test alongside Joe Root and Harry Brook.

Pope said there might be times England batters will have to "manage the game a little bit more" but that their attacking Bazball style under coach Brendon McCullum and captain Stokes has now become second nature.

"I got asked on day one at Trent Bridge 'do you get told to play like that?'. No, we don't. It's just our natural games and the way we go about it," Pope said. (PTI)

# Neeraj's advice boosting his confidence, high jumper Kushare aims final round in Paris

NEW DELHI, July 24: 'Just focus on training and don't get scared by the fame of the opponents' is the mantra Paris Gamesbound high jumper Sarvesh Kushare learnt from none other than Olympic and world champion javelin thrower Neeraj Chopra.

Kushare said Chopra's advice has boosted his confidence as at one point in time this year, he was not even sure of making the Paris Games cut. He made it to the Olympics through world ranking quota. The Paris Games automatic qualification mark was 2.33m.

From doing practice on fodder-made makeshift mat to becoming the first Indian high jumper to qualify for the Olympics, Kushare has come a long way

"I have not met Neeraj bhai for a long time, but when we met last time, he told me to focus on training and not be afraid of the fame of the opponents. He always keeps giving important tips," Kushare told PTI Bhasha in an interview from Poland where he is training along with other Paris-bound

"He (Chopra) is my idol and he gave us confidence by winning the first ever Olympic medal in athletics. We also want to be like him and bring pride to the country," said the high jumper, who hails from Deogaon village, a few kilometres from Nashik in Maharashtra.

With a personal best of 2.27m and season's best of 2.25m, making it to the final round in the Paris Games can be a realistic target. The 29-year-old, who is making his Olympic debut, though, claimed that he has been jumping over 2.30m mark frequently during practice.

"It is only my height that is small but I



am also very strong from within. There is no fear of seeing my opponent's personality. It is important to be in top form at the right time and have faith in your preparation," Kushare, who stands at 5 feet 9 inches, said.

"Right now the focus is on the qualification round which will be held on August 7 at 10 am. The first goal is to make it to the finals. I will plan for the rest later."

Kushare, who is currently training at Spala, Poland, along with other Olympicbound Indian athletes, started the sport on a makeshift mat made of waste from corn which was used as fodder for cows.

'There was no high jump mat in our village, so the corn fodder collected for the cow was used as a mat with a foam cover on it. It was used as a landing area and we used to do practice on it,' he recollected.

'I started playing under the guidance of my school's PT teacher R W Jadhav sir. Then I went to the Army Sports Institute

and also got support from Olympic Gold Quest (OGQ) which sent me to America for training." He became a father nine months ago but he will be able to see his newborn daughter only after the Olympics.

"I have a nine-month-old daughter but I have not met her since November. Initially, I stayed with her for just five days and now I will meet her only after the Olympics," he

It will, however, be a tough task for Kushare to be in the medal bracket in Paris. At least nine athletes have jumped 2.33m or above in the last one year.

Qatar's Mutaz Barshim and Gianmarco Tamberi of Italy shared the gold medal in Tokyo with an identical jump of 2.37m. Tamberi is the leading the chart this season with 2.37m while Barshim has been struggling a bit with a season best of 2.31m.

At one point in time, Kushare, who won gold with a jump of 2.25m in the National Inter-State Championship in Panchkula in June, was uncertain whether he would qualify for the Paris Olympics or not.

"Before June, my ranking had gone down to 36 because I could not play in May when competitions were going on all over the world. I was afraid whether I would be able to play in the Olympics or not. I was under a lot of pressure but then I qualified by performing consistently well in Malaysia, Kazakhstan and Panchkula," he

'I had a lot of problems due to an ankle injury but now my confidence has increased by practising well consistently.

Talking about his daily training routine at Spala, he said, "Practice includes gym, speed work, strength training. The recovery sessions here are very good. We just rest in our free time because it is very important to give rest to the body." He said when asked about his routine

"I talk to a sports psychologist regularly for mental preparation. He tells me how to deal with pressure and how to keep myself mentally fresh. I do yoga and meditation every morning.

The Indian athletics team has been training at Spala from July 8 and will leave for Paris on July 29. (PTI)
