How dare you threaten Assam: Assam CM on Bengal counterpart's 'provocative' speech

Himanta fires 'failure' salvo at Mamata Banerjee

GUWAHATI, Aug 28: Chief Minister Himanta Biswa Sarma hit out at West Bengal chief minister Mamata Banerjee on Wednesday for allegedly threatening the northeastern state with unrest.

Sarma claimed that Baneriee was trying to provoke the public to hide her own failures.

The development follows a viral video of her addressing a gathering on the foundation day of her party's student wing, Trinamool Chhatra Parishad, where the West Bengal chief minister can be seen making a provocative speech.

"Didi, how dare you threaten Assam? Don't show your anger to us. Don't even try to incite India with your politics of failure. It does



not suit you to speak divisive language," Sarma wrote on micro-

blogging site X. In the clip, Banerjee is seen stressing that though Bangladesh guage and culture, both are two different countries with West Ben-

gal being part of India. Alleging that Modi's party is trying to fuel the situation in West Bengal, the Trinamool Congress

GUWAHATI, Aug 28: Chief ernment of Assam has not de-Minister Himanta Biswa Sarma on Wednesday said the state government has not yet decided on implementing a comprehensive Uniform Civil Code (UCC), as its focus is not aimed at targeting any particular religion but to address child marriage and promote women's empowerment.

Sarma's latest remarks contradict his earlier position, when he had indicated that Assam would follow Uttarakhand and Gujarat in introducing a UCC Bill, with exemptions for tribal communi-

UCC implies that all sections of society, irrespective of their religion, shall be treated equally according to a national civil code, which shall be applicable to all uniformly, covering areas like marriage, divorce, maintenance, inheritance, adoption and succession of the property.

cided on implementing a comprehensive UCC. Our focus is on stopping child marriage and ensuring women's empowerment.'

He mentioned that the recently tabled 'The Assam Compulsory Registration of Muslim Marriages and Divorces Bill, 2024' is a step towards these objectives.

"This Bill mandates the compulsory registration of all marriages, which must be done by a sub-registrar rather than a 'kazi'. This is part of our effort, along with banning polygamy," Sarma explained.

BJP workers clash with police while trying to enforce West Bengal shutdown

KOLKATA, Aug 28: BJP workers clashed with the police at several places across West Bengal on Wednesday as they tried to enforce a 12-hour shutdown, which had a mixed impact in the state

Several BJP leaders, including former MPs Roopa Ganguly and Locket Chatterjee, Rajya Sabha MP Samik Bhattacharya and MLA Agnimitra Paul, were detained for blocking roads since the morning.

The 'Bangla Bandh', which began at 6 am, was called by the BJP in protest against Tuesday's police action on participants of 'Nabanna Abhijan' or march to the secretariat, organised by the newly formed students' group Chatra Samaj over the rape and murder of the doctor at RG Kar hospital.

The shutdown partially affected daily life in the state with many people choosing to remain indoors apprehending trouble on the roads.

In state capital Kolkata, the usual weekday flurry was missing with a smaller number of buses, auto-rickshaws and taxis plying. Private vehicles were also significantly less, even as

markets and shops remained open. Schools and colleges were open, though the number of students was fewer. Many Englishmedium schools in Kolkata suspended classes. In many private offices, attendance was low with employees asked to work from home. However, attendance was as usual in government offices. Several BJP leaders were detained across the

state for attempting to enforce the shutdown. Ganguly and Paul were detained from south Kolkata's Gariahat area when they were urging traders to down their shutters and requesting people to support the bandh.

Chatterjee was detained from Shyambazar when she was leading a demonstration, while Bhattacharya was detained from Wipro More in Salt Lake Sector 5. Kolkata's Ward 50 councillor Sajal Ghosh

Gold prices remain steady, silver declines ₹ 400

NEW DELHI, Aug 28: Gold prices remained flat at ₹ 74,350 per 10 grams in the national capital on Wednesday in scattered deals even as it weakened in the overseas markets. Silver prices, however, declined ₹ 400 to ₹ 87,800 per kilogram. It had ended at ₹ 88,200 per kg in the previous

Meanwhile, gold of 99.5 per cent purity also ruled flat at ₹ 74,000 per 10 grams. Traders attributed the fall in silver price due to poor offtake by industrial units and global influences.

In the international markets, comex gold is trading at USD 2,542.20 per ounce, down USD 10.70 per ounce or 0.42 per cent.

"Gold prices were slightly lower during European trading hours on Wednesday, due to a rebound in the US dollar," Saumil Gandhi, Senior

Analyst of Commodities at HDFC Securities, said.

According to Kaynat Chainwala, AVP-Commodity Research, Kotak Securities, comex gold is trading above USD 2,500 per ounce, supported by the FOMC meeting minutes, which reinforced expectations of a September rate cut. Rising geopolitical tensions, particularly the escalating Israel-Hezbollah conflict, also bolstered gold prices as a safe-haven asset, Chainwala said. PMJDY, the national mission for financial inclusion, which completed a decade of successful implementation continuously endeavours to provide support to the marginalised and economically backward sections through its financial inclusion interventions.

In her message on the 10th anniversary of PMJDY, Sitharaman said, "universal and affordable access to formal banking services is essential for achieving financial inclusion and empowerment. It integrates the poor into the economic mainstream and plays a crucial role in the development of marginalised communities"

By providing universal, affordable, and formal financial services including bank accounts, small savings schemes, insurance, and credit to the previously unbanked, PM Jan Dhan Yojana has transformed the banking and financial landscape of the country over the last decade, she said

The success of the initiative is reflected in 53 crore people having been brought into the formal banking system through the opening of Jan Dhan Accounts, she said, adding, these bank accounts have



garnered a deposit balance of ₹ 2.3 lakh crore, and resulted in the issuance of over 36 crore free-of-cost RuPay cards, which also provide for a ₹ 2 lakh accident insurance cover. Notably, there are no account opening fees or maintenance charges and no requirement to maintain a minimum balance, she

The Jan Dhan Yojana, which was announced by Prime Minister Narendra Modi in his Independence Day address in 2014, was launched on August 28 of the same year.

The Finance Minister further said it is heartening to note that 67 per cent of the accounts have been opened in rural or semi-urban areas, and 55 per cent of accounts have been opened by women.

"The consent-based pipeline created through the linking of Jan Dhan-Mobile-Aadhaar has been one of the most important pillars of the financial inclusion ecosystem. It has enabled swift, seamless and

transparent transfer of government welfare schemes to eligible beneficiaries and promoted digital payments," she said.

In his message on the occasion, Minister of State for Finance Pankaj Chaudhary, said, "PMJDY is not only a scheme, but a transformation movement that has enabled financial independence of many of the unbanked population and has instilled a sense of financial security

The journey of PMJDY-led interventions undertaken over the last decade has in effect, produced both transformational as well as directional change thereby making the banks and financial institution ecosystem capable of delivering financial services to the last person of the society-the poorest of the poor, he said.

The PMJDY accounts have not only been instrumental in receiving Direct Benefit Transfers but also serve as a platform for hassle-free

subsidies/payments made by government to the intended beneficiary without any middlemen, seamless transactions, and savings accumulation, the finance ministry said in a statement.

Moreover, it said, they have been crucial in providing life and accident insurance to millions of unorganized sector workers through Jan Suraksha schemes (micro insurance schemes).

Under the scheme, the number of bank accounts grew nearly four-fold from 14.72 crore in March 2015, to 53.13 crore as on August 14, 2024. Total deposits under PMJDY have swollen from ₹ 15,670 crore as of March 2015, to over ₹ 2.31 lakh crore as of August 2024.

Average deposit per account is ₹ 4,352 as on August 14, 2024. Average deposit per account has increased 4 times over August 15. Increase in average deposit is another indication of increased usage of accounts and inculcation of saving habits among account holders.

Over the past decade, PMJDY has played a pivotal role in bringing millions of unbanked individuals, particularly women, into the formal financial system, Women's World Banking Regional Head (South Asia) Kalpana Ajayan said.

The impact of the scheme is evident in the increased financial participation of women, who now have the opportunity to save, invest, and secure their financial futures. Ajayan said. (*PTI*)

incite TMC supporters to take the law into their own hands and attack opposition members, thereby stifling democratic dissent. He also criticised Banerjee's statement suggesting that if Bengal were to be engulfed in flames, neighboring states such as Jharkhand, Odisha, Assam, and even distant Delhi would also be affected. Majumdar described this as contrary to the federal spirit of the republic. "It is unthinkable for an elected Chief Minister to make such a comment. How can she say such things?" he questioned.

Majumdar expressed hope that Banerjee was not alluding to any extremist groups with her remarks. He also criticised her comments about the agitation by R G Kar doctors, viewing them as intimidation and indicative of her fear that the spontaneous protest against the rape-murder of a woman doctor would not cease at her command. "The honourable court has already upheld the democratic rights of junior doctors. The Chief Minister cannot coerce them into silence until justice is served," Majumdar added.

Majumdar wrote a letter to Union home minister Amit Shah, condemning Banerjee's reported comments as a "blatant endorsement of revenge politics from the highest office in the state."

In the letter, Majumdar accused Banerjee of making anti-national remarks by suggesting that if Bengal were to burn, other states would also be affected. "This isn't the voice of someone holding a constitutional position. It's the voice of an anti-national," Majumdar stated in his letter, asserting that Banerjee "no longer deserves to hold such an important position" and calling for her immediate resignation. Fish boycott continues in Sivasagar amid prohibitory order

ATASU president criticises the prohibitory order as unnecessary, stressing that Sivasagar remains peaceful despite ongoing tensions

SIVASAGAR, Aug 28: Student and youth organisations in Sivasagar, excluding AASU, have called for a total boycott of fish from the Nagaon district following reports of Nagaon fish traders threatening to stop sending fish to Sivasagar. Partha Pratim Gogoi, secretary of Sivasagar District ATASU, stated on Wednesday that there will be no let-up in their agagainst Bangladeshis residing in Upper

He mentioned that the people here are prepared to live without the formalin-dipped "salani" fish (transported fish) from Nagaon, which he believes will be beneficial for their health.

Meanwhile, a prohibitory order under Section 163 BNSS, 2024, was issued by Sivasagar District Magistrate Aditya Vikram Yadav, IAS, on August 23 in response to a recent incident involving an attack on an adolescent girl and the subsequent public reactions.

The District Magistrate noted in



the order that there may be a threat to public peace and tranquillity, as well as the safety of tourists visiting the region's ancient monuments, based on reports from various sources.

The order prohibits gatherings of more than five persons in public places, the organisation of rallies or meetings, the collection of subscriptions in any form from individuals, business establishments.

or institutions, and the intimidation of anyone for such subscriptions. The order took immediate effect and will remain in place for 60 days or until further notice.

Basanta Gogoi, president of ATASU, told this correspondent on Wednesday that the prohibitory order was absolutely uncalled for, as the situation in Sivasagar has been and continues to be completely peaceful

He expressed concern that the police administration's road march might send the wrong signal to people outside the district.

The administration's decision may have been influenced by ongoing agitation against suspected Bangladeshi nationals migrating to Upper Assam districts, including Sivasagar.

Over 30 organisations, including ATASU, TAYPA, Bir Lachit Sena, and Sangrami Sena Asom, have called for a total boycott of the suspected Bangladeshi nationals, who are believed to be gradually changing the demographic pattern of the state.

The district's Executive Magistrate has already issued 27 summonses to the leaders of these organisations as a pre-emptive measure against further public agitations over the issue.

These populations, previously concentrated mostly in Barak Valley, Nagaon, and the lower Assam districts, have recently infiltrated into the nooks and corners of the Upper Assam districts as well.

Residents struggle with non-functional JJM water supply

MARGHERITA, Aug 28: Since the completion of the Jal Jeevan Mission (JJM) project three years ago in the Balukhad area under Ward No 6 of Margherita Municipal Board, Tinsukia, residents have unfortunately not received a single drop of water from the taps installed at their homes

At the Jal Jeevan Mission project site, large bushes have grown, and the fencing has been removed by miscreants. Despite this, the contractors have not made time to inspect the area.

Margherita, said that in 2021, Margherita MLA Bhaskar Sharma laid the foundation stone for the Jal Jeevan Mission project in the Balukhad area. However, three years after completion by inexperienced contractors from nearby areas, water supply has still not been provided, forcing local residents to regularly buy water for their daily needs.

BJP's Bengal strategy backfires

The BJP's attempt to leverage public outrage over the rape and murder of a young doctor from R G Kar Medical College in Kolkata has backfired, leaving the party isolated and exposing internal divisions. The 12-hour bandh called by the BJP on August 28, intended to protest alleged police atrocities during a march to the state secretariat, Nabanna, fell flat. Normal life continued across Bengal, with only minor disruptions reported. The BJP's efforts to hijack the grassroots movement, which was primarily led by women demanding justice, have only weakened the party's position. The "Nabanna Abhijan," spearheaded by Paschimbanga Chhatra Samaj, a group linked to the RSS, failed to garner significant support. The Chhatra Samaj was unveiled just a week before the August 27 rally, but its student-led facade quickly crumbled. The political maneuvering behind the scenes became apparent, and instead of bolstering the BJP's cause, it further solidified Mamata Banerjee's hold on Bengal politics. The tragedy at R G Kar Medical College not only ignited widespread anger but also led to introspection within the Trinamool Congress (TMC). Many questioned whether the government had handled the situation appropriately.

The BJP's internal conflicts also came to the fore, with two factions clashing over strategy. Subhendu Adhikari, representing the defectors from the TMC, and Sukanta Majumdar, the state president aligned with the RSS, were at odds. While Adhikari pushed for broader participation in the rally, Majumdar stuck to the RSS's plan to focus the protests on areas frequented by intellectuals and social activists. This rift only weakened the party's efforts. Violence erupted in Kolkata and Howrah during the protests on August 27, with demonstrators pelting stones and glass bottles at the police, leaving several officers injured. Despite the provocation, the Kolkata police maintained restraint, avoiding the use of firearms. Instead, they resorted to lathi charges and tear gas to control the situation. The BJP, however, failed to provide credible figures on the number of injured protesters, further undermining its claims. Adhikari later claimed that 133 protesters, including 17 women, were injured. But the rally, ostensibly organized to seek justice for the murdered doctor, quickly shifted focus to demanding Mamata Banerjee's resignation. Some agitators even framed the protest as a response to her alleged "appeasement of Muslims," exposing the communal undercurrents within

Interestingly, the RSS avoided involving its student wing, ABVP, in the protests, likely anticipating the limited student participation. Instead, the BJP had to rely on its workers to bolster the numbers, further highlighting the disconnect between the party and the grassroots movement. The CPI(M) and other left parties, which had played a significant role in organizing protests for justice, distanced themselves from the BJP's bandh, choosing to continue their own demonstrations independently. Adding to the BJP's woes, the CBI, tasked with investigating the R G Kar case by the Calcutta High Court and the Supreme Court, has not found evidence to support the BJP's claims. Despite this, the party's IT cell and social media supporters continue to spread misinformation, drawing criticism even from the judiciary. In the end, the BJP's plot to unseat Mamata Banerjee and impose President's Rule in Bengal has failed.

The wizard of Hockey: Major Dhyan Chand and India's National Sports Day

29th, India cele-✓ brates National Sports Day - a day that honors not just the importance of sports and physical fitness, but also pays tribute to one of the greatest athletes the country has ever produced: Major Dhyan Chand. Known as "The Wizard" or "The Magician" of hockey, Dhyan Chand's extraordinary skills and achievements on the field have made him a legendary figure in Indian sports his-

Born on August 29, 1905, in Allahabad (now Prayagraj), Uttar Pradesh. Dhyan Singh would go on to become the most celebrated field hockey player in the world. His journey to greatness began in 1922 when he enlisted in the British Indian Army at the age of 17.

It was during his time in the army that he honed his skills in hockey, often practicing late into the night under moonlight - a habit that earned him the nickname (meaning moon in Hindi).

Dhyan Chand's international career took off when he was selected for the Indian hockey team for the 1928 Amsterdam Olympics. This marked the beginning of India's golden era in field hockey, with Chand leading the charge. In Amsterdam, he showcased his exceptional skills; scoring 14 goals in 5 matches and helping India secure its first Olympic gold medal in hockey. A Dutch newspaper aptly described his performance: "This is not a game of hockey, but magic. Dhyan Chand is in fact the magician of hockey."

The legend of Dhyan Chand only grew from there. He went on to lead India to two more Olympic gold medals in 1932 (Los Angeles) and 1936 (Berlin). The 1936 Berlin Olympics final against Germany is perhaps the most famous match of his career. Despite initial nervousness and trailing at half-time, India, led by Chand, mounted a spectacular comeback to win 8-1. Chand scored three goals in the final, cementing his status as a hockey icon.

Dhyan Chand's goal-scoring prowess was un-In matched. autobiography "Goal," he claimed to have scored over 1000 goals in his entire domestic and international career from 1926 to 1948. His stick work was so mesmerizing that there are stories of officials breaking his hockey stick to check if there was a magnet inside!

Throughout his career,

After retiring from active play, Chand continued to contribute to Indian hockey as a coach. He served as the Chief Hockey Coach at the National Institute of Sports, Patiala from 1961 to 1969. The Government of India recognized his immense contribution to Indian sports by awarding him the Padma Bhushan, India's third-highest civil-



ian honor, in 1956. Dhyan Chand passed away on December 3, 1979, but his legacy lives on. In 2012, the Govern-

Pakistan seeks rescheduling of US\$ 12 billion debts as crisis worsens

t is no secret that Pakistan is a debt burdened country. In his previous term Prime Minister Shehbaz Sharif publicly acknowledged that even friendly countries look at Pakistan as a country always "begging for money."

His more recent contention is that he has broken the begging bowl and the era of Pakistan asking others for money is over. Yet finance minister Muhammad Aurangzeb have of late said that Pakistan is seeking debt relief from China and other bi-lateral lenders to plug a financing gap aiming to secure a loan from IMF.

The Pakistani finance minister further spoke of engagement of Pakistan with China, Saudi Arabia and UAE for debt scheduling around \$ 12 billion. Instead of being broken, the begging bowl seems to have been enlarged.

Longer loan repayment periods have been sought. The countries from whom such favour have been sought are China, Saudi Arabia and UAE. In any case seeking external support is necessary but not sufficient to bolster the economy. It is a fire fighting measure.

And as such it should be accompanied by the country's longer term economic plan involving resolution of longstanding structural problems. But the fact remains that such a plan is yet to be

Pakistan's economy has a long history of exter-

nal debts. By 1995, its external debt soared to US\$ 30 billion. The external debt/GDP ratio rose from 42 per cent to 50 per cent, accompanied by increases in the external debt/exports ratio (from 209 per cent to 258 per cent).

On the other hand, the debt service ratio rose from 18 per cent to 27 per cent. Domestic debt was pushed up to \$ 909 billion by deteriorating external debt profile with the domestic debt/GDP ratio at 42 per cent.

The late 1990s was marked by a severe debt crisis. The public debt/GDP ratio shot up from 57.5 per cent in 1975-76 to 102 per cent in 1998-99. Pakistan's public debt was rendered unsustainable after a surge in public debt/revenue ratio and interest payment revenue ratio.

In May, 1998 Pakistan conducted nuclear tests. Concerns over economic sanctions emerged in 1998. Western economic sanctions caused massive flight of capital leading to an unenviable economic

The 2000s witnessed the impact of high public debt. It was identified by the Official Debt Reduction and Management Committee in 2001 contributing to a decline in growth rate to less than 4

per cent per annum. The decade unfolded in persistent macroecononic crisis negating an initial upturn. Growth slowdown, a low growth, high inflation, an energy crisis and worsening balance of payments position marred the decade. (IPA Service)

Climate risks threaten rice productivity in key Indian states

Recent research at the 32nd International Congress of Agricultural Economists in Delhi reveals a significant threat to India's rice production due to climate change. According to Nishi Yadav from the Indian Institute of Technology, Guwahati, states like Assam, Arunachal Pradesh, Himachal Pradesh, and Tamil Nadu face severe climate risks impacting rice yields, while Bihar, Uttarakhand, and Jharkhand are less affected.

Yadav's study shows a clear negative relationship between climate risk and rice productivity, posing a threat to national food security and

Additionally, Disha Gupta's study from the Indira Gandhi Institute of Development Research highlights inefficiencies in water use in Punjab, suggesting that raising electricity prices could re-

duce water extraction significantly. These findings underscore the urgent need for targeted policy interventions to address climate risks and optimize resource use to sustain India's agricultural sector and global food supply.

Grief, hope, and the future of coral reefs

ately, grief is an emotion that I find myself smothered by. One look at our world and nothing comforting emerges. While at a global level we have wars, environmental disasters, extreme weather events, and a general sense of apathy, I cannot say that the scenario within our country is any better. The atmosphere within the country is supercharged with the 2024 general elections having concluded, but this figurative atmosphere is not the only concern that I have. The literal atmosphere too, has been inundated by decades of greenhouse gas emissions, fuelled largely by greed, capitalism and apathy. Every single month, for the past 12 months, we have consistently remained 1.5°C above the pre-industrial average levels across the

Intergovernmental Panel on Climate Change's (IPCC's) Representative Concentration Pathways (RCP) 1.5 scenario seems to be a joke, as climate scientists all over the world share a similar pessimistic view on how the world is failing to tackle climate change. Words of comfort go along the lines of, "focus on what you can do", or "forget about the problems of the world and concentrate on finishing your PhD". Unfortunately, even if I take their advice and "focus" on my doctoral study, there is no relief as the system that I study is slowly and painfully dying.

There is no other way to put it. Coral reefs, the ecosystem that I study, are an endangered ecosystem given the age of climate change. You will have read many articles on what coral bleaching and climate change is, and what the world is doing to combat it, but coral

sooner rather than later. Coral reefs, typically constructed by Scleractinian corals (stony corals) have a very narrow preference for where they can survive. Warm and sunlit waters are the ideal place and thus many coral reefs are restricted to the tropical belt. This is a problem though, as tropics generally behave differently from the temperate regions in terms of how they respond to climate change.

According to the latest IPCC report, changes in climate trends are more pronounced in the tropics while the temperate regions undergo higher variability in climatic variables. This would mean that an increase in temperature is noticeable over the past few decades in the tropics and this is of concern for shallow water reefs, because of how much heat the ocean can absorb.

Almost 90% of all of the sun's energy is absorbed by the ocean and as the layer of greenhouse gases insulates the earth even more, much of this excess energy is channelled back into the ocean. Coral reefs are doomed to die, at least in the long run.

"Hope? Let me tell you something, my friend. Hope is a dangerous thing. Hope can drive a man insane. It's got no use on the inside. You'd better get used to that idea." This line by Red from the movie Shawshank Redemption, rings deep with me. There is no hope for these ecosystems if current trajectories of "progress" are maintained. There are, however, pockets of resistance; in the reef, I mean. But this too, has a tinge of grief mixed in.

A criticism to most coral reef published research has been about baselines when looking at change, and therefore the reefs they've selected to study. many coral reef biologists often choose to study reefs where "corals grow on the backs of other corals". This often means that the reefs are dominated by the most speciose and fast-growing genus of corals, the Acropora. Decades of research has shown that Acropora is one of the most susceptible corals to bleaching and as a result, reefs dominated by this genus can

show dramatic declines. Consequently, studies that have monitored such diverse and spectacular reefs often show complete destruction of a functioning ecosystem. But of course, coral reefs are not this diverse and extravagant in many places, and local environment often shapes the community of corals you find in a reef. Lakshadweep, where I study reefs, is an example of such a place. This does not mean that

there are no 'spectacular' reefs in Lakshadweep; it's just not the norm. Lakshadweep, like the rest of the world's reefs, has been marred by three mass bleaching events since 1998. As I write this article, it undergoes the fourth. Our work in the Lakshadweep shows concerning trends as it is not just the reefs dominated by Acropora that are affected. Sure, dramatic changes of bleached corals are most pronounced in strands of Acropora but this time, my colleague Wenzel says, "corals of all manner are turning pale and dying".

Honestly, we know what to expect; our work, which is currently in review, highlights how the reefs of Lakshadweep have fared over the past 25 vears. Certain areas of the atoll recover better than the rest, but they all show a steady ratcheting down of coral cover.

This has consequences for the 70,000 people who call

were able to colonise and inhabit Lakshadweep is because of the reefs that surround these atolls. Apart from providing a rich source of nutrition, coral reefs buffer against large oceanic waves and generate sediments that replenish the ephemeral sandbars upon which people dwell.

Rainfall then accumulates as a thin freshwater lens beneath these sandbars, creating conditions necessary to sustain life. But then, if the reef keeps dying and recovers slowly after every bleaching event, it is quite obvious that their regulatory and provisioning functions will be compromised. What does that mean for an island community whose homes are barely two metres above sea level? A hint of an answer can be found elsewhere, in places like Kiribati, and Tokelau, two south Pacific atolls currently fighting to keep seawater out of their homes and

How do you sustain yourself when the ecosystem you study has several polyps in the grave? How do you reconcile with the fact that Lakshadweep faces a near certain future where climate change induced environmental disasters become a yearly, if not daily occurrence? What does one do when such a fragile location sees progress in the opposite direction? When scientists and local communities who best know the place and have observed them for decades are silenced, what does it say about the societal values we encour-

Even if Lakshadweep is too far away for mainlanders to care about, how are we so unperturbed by the more immediate risks to our lives and livelihoods? Human beings seem to be extremely myopic. We cannot comprehend consequences nor realise the future can be dangerous as well, as we are about to inherit. Much like the coral reefs, we too in the subcontinent, are living in extremely narrow climatic conditions. Being in the tropics means the air is often saturated with moisture and as a result, our bodies may not be able to cool down by sweating as temperature increases. This physiological limitation should be a concern for us all and similar to sessile corals on reefs, many of us are in no position to escape the inevitable.

Clearly this piece was not meant to sugar-coat reality nor provide any hope. What do I mean when I say that I feel grief over how our current situation has played out? A part of my thesis is to estimate the wave buffering function of coral reefs at shallow depths. While being tossed around at these wave-beaten depths, my colleagues and I noticed what many scientists have said about extravagant reefs. We were swimming over a stretch that had 100% coral cover with at least 16 different species of corals, and the first thought that came to my mind was, "this will die in a few months".

Throughout this field season, we have seen some of the most beautiful reefs in the Lakshadweep, and the same thought plagued my mind, "this will all die". As I was finishing my last dive for the season, off the reefs of Kavaratti, I noticed the entire reef was turning pale, and a few corals had already turned white. 'These are all dying," the only thought that rang in my head.

What can hope do when the powers that be are more interested in lining their pockets than caring about the kind of world they leave behind? What can we hope to do when we know bleaching events in the Lakshadweep and around the world are now going to become a recurring event? Hope many conservation initiatives promulgate the notion that palliative fixes like coral restoration and establishment of Marine Protected Areas (MPAs) can help shield coral reefs from climate change.

I apologise for being blunt, but they will not. At their most benign, they can help alleviate proximate problems that plague coral reefs and thereby offer a few additional years for the reef to remain as it is. At their worst, they can be used to justify ecosystem restoration, and provide a concrete (read, monetary) way of ensuring conservation initiatives are implemented, even legitimising destructive projects in some instances, as is happening in the Great Nicobar.

There is science that shows individual corals are becoming more resistant to thermal stress but these studies are often conducted on a few species and a few species do not make up a reef. This to me, is a problem of scale; a mismatch between the issue of 'global' warming and 'individual' resistance of corals to thermal stress. Given that we are showing no signs of slowing down our voracious appetite to consume, no amount of ecosystem restoration can help if coral polyps just 'melt' away in the heat.

This consumptive attitude of ours is so pervasive that I fear even death and destruction will be looked at with currency in one's eyes. It isn't too farfetched to imagine a new kind of tourism emerging out of these mass mortality events, given how capitalism works. A sort of dark tourism. It is entirely possible that the Lakshadweep in the next century might see relocation of people as climate refugees to mainland India, and there will then be no 'ethical' reason to stop minting money from destruclarge cruise ships set sail from the ports of Mumbai, or on seaplanes, carrying tourists who care only for a few pictures by the beach, and some handouts of 'Lakshadweep coconut' as souvenirs is all too probable. But wait, that's the state of tourism today; the only difference in the future will perhaps be the lack of people in the Lakshadweep to host them. But...what if? What if I'm wrong about the greed and corruption of man? What if there's more to being human than being a self-serving and myopic organism?

"Remember, Red: hope is a good thing, maybe the best of things, and no good thing ever dies." Again, a quote by Andy from Shawshank Redemption. Can we perhaps re-examine grief? Grief can be debilitating, crippling our functioning, making us question any sense of agency and identity we may have in this world. But perhaps, grief can be empowering as well. If nothing, it highlights what it is that we're most affected by, confronts us with our values.

Grief can help find clarity, attract souls who feel the same way as I, illuminate what is truly important to me individually. I am grief-stricken by the plight of this ecosystem, the consumptive and exploitative nature of humans, the inevitable future of the Lakshadweep, and the potential collapse of humanity. But I am not debilitated. My actions may or may not amount to any substantial change but adherence to my values is what helps me sleep at night. What's your secret to a sound sleep in this unsound world? I pray that the answer to this question doesn't trouble your conscience, and I'm choosing to view the perspective that doesn't echo grief. Behind devastating floods in Tripura and Bangladesh, record rainfall and not just a dam

or four days starting August 19, d heavy rain lashed Tripura. While this is not unusual during the monsoon, the state received 298% excess rainfall between August 15 and August 21, according to data from India Meteorological Department.

As water levels in rivers in six locations flew above the danger mark, the state was flooded. Twenty-four people lost their lives, over 17 lakh people were affected and over 1.28 lakh displaced. It was an "unprecedented situation", the state disaster management authority

Across Tripura's western border, Bangladesh was in a similar predicament, with rivers flowing above the danger mark and continuous heavy rain. The districts on the country's border with Tripura saw severe floods

However, the common experience of a natural calamity ended up only dividing the two countries, as a section of the media alleged that India had a hand in Bangladesh's suffering. Reports claimed that India's decision to open the sluice gates of a dam on the river Gumti on August 21 had caught Bangladesh offguard. Social media accounts accused India of creating an "artificial flood" or "intentionally creating" floods, reflecting the animosity against India in Bangladesh after the fall of the Sheikh Hasina government.

Though the Bangladesh government did not echo those allegations, India's Ministry of External Affairs put out a statement, denying the claims. It is "factually incorrect" that the opening of the Dumbur dam contributed to the flood across the border, the ministry said. It noted that catchment areas of Gumti have "witnessed heaviest rains of this year" and the flood in Bangladesh is primarily due to waters from these large catchments downstream of the

dam." Disaster management and dam officials Scroll spoke to denied that the release of the water was "intentional", pointing out that the gates of the dam "automatically opened" once the water had breached a certain level. They, however, confirmed that information about the water release from Dumbur dam was not shared with Bangladesh officials.

"As an upstream state it becomes India's duty to alert both Indian and Bangladeshi authorities," said Himanshu Thakkar, the founder and coordinator of South Asia Network on Dams, Rivers and People.

But was the amount of water released from the Dumbur dam alone responsible for the floods in Bangladesh? The experts Scroll spoke to contest that claim.

Scroll emailed the Bangladesh interim government and India's Central Water Commission for their responses. The story will be updated if they respond.

The deluge across the border In the past few weeks, districts in Bangladesh bordering Tripura like Comilla, Feni and Naokhali have been

in the grip of floods. Water levels in rivers have been flowing "above danger level" and "above 1 metre of danger level", impacting nearly three million people and killing seven. Moreover, a low pressure system over Bangladesh has led to continuous rainfall.

On August 22, a section of Bangladesh media reported that a large volume of floodwater entered Bangladesh as the sluice gates of the Dumbur dam in Tripura's Dhalai district were opened a day earlier.

They claimed that the water entered Bangladesh through Gumti, a river that flows from east to west of Tripura, be-

Dam gates and heavy rain: A dan-

gerous combination In India, meanwhile, starting August 20, excessively high rains lashed eight districts of Tripura. Rainfall as high as 261.6 mm was recorded for a single day in South Tripura district, and 232.1 mm in Gomati district, contributing to the high volume of water in the catchment area of the river.

On August 21 at 8.35 am, the Gomati district's district magistrate posted on Facebook that water from the Dumbur Hydroelectric Project Dam has to be released as "water has accumulated to the critical level giving no scope [sic] to the Tripura Power Generation Limited but to release some water".

The post urged all citizens concerned and downstream districts of the state to take precautionary measures immedi-

Dam officials told Scroll that the release of this water was "automatic" once the water had reached a certain level in the dam.

In the evening at 5 pm, the district magistrate provided another update -"two flap gates and one gate partially (50%) [were] (automatically) discharging water from the reservoir".

Once released, the water flowed through Gomati and Sepahijala districts of Tripura, taking about five hours to reach Bangladesh territory, a distance of about 160 km, said Suman Deb, a senior Tripura disaster management official.

Data from Bangladesh's Flood Forecasting and Warning Centre shows that water levels in Gumti river in Comilla district rose sharply starting from August 20. By 6 pm on the same day, water level was at 10.5 metres – a metre below its danger level. By 3 pm on August 21, the river had crossed the danger level of 11.3 metres at Comilla, and continued to rise till August 23, when it reached 12.5 metres – the highest recorded level for the observation site.

However, experts pointed out that the Dumbur dam has a limited role to play in the floods in both Bangladesh and Tripura. M. Inamul Haque, chairman of the Bangladesh-based Institute of Water and Environment, told Jamuna TV in an interview that the "dam handles 20% of Gumti's catchment areas. The real reason for the floods is the excessive rain in Tripura."

In Tripura, the disaster management authority echoed this, suggesting that the dam's water release alone is not re-

sponsible for floods in either Tripura or Bangladesh. "We have floods in all the eight districts of the state and the dam is located only in one district. The dam is not responsible for it," said J B Vanlal Duati, the director of the Tripura Disaster Management Authority.

Tripura's river basin is upstream of Bangladesh's upstream – as are river discharge areas of Manipur, Mizoram,

Together, the abundance of water in this region during the monsoon regularly contributes to floods in Bangladesh, explained Mirza Zulfiqur Rahman, a Guwahati-based independent researcher, who has worked on the issue of transboundary water-sharing in the North East.

The pressure from the Brahmaputra river basin adds to the problem. "Bangladesh becomes overwhelmed by a combination of river systems discharging in a limited riverine space, covering a huge density of population," said Rahman

Could dam waters be released

At the same time, experts said dam authorities could have managed water release better. They pointed out that water from the Dumbur dam could have been released earlier than August 21, to avoid the sudden surge of water down-

Action could have been taken "at least three days ago", said Thakkar, when on August 18, the India Meteorological Department forecast "heavy to very heavy rainfall" for Tripura between August 18 and August 23.

'To prepare for such heavy rainfall, the authorities could have made space in the reservoir by releasing the water earlier than August 21," said Thakkar.

Even the data from the Central Water Commission showed that at Amarpur – one of three sites along the Gumti where water level is observed - the river had started reaching alarming levels at 1 pm on August 20, crossing the danger mark of 35.5 metres by 5 pm on the same day.

Data from the North East Region Load Despatch Centre, a regional office of its national counterpart that facilitates transmission of electric power, also indicated that the dam was not releasing water when heavy rains began.

Starting August 20, the day when heavy rains lashed Tripura, the dam generated 0.01 million units of electricity, and none on August 21 and August 22. "So even in peak monsoon months with high water flow in the river, the dam was not generating almost any power. Why was the reservoir storing so much water in that case?" Thakkar wrote on the website of South Asia Network on Dams, Rivers and People.

When asked why the dam was not opened before August 21, Deb, the senior Tripura disaster management official, told Scroll that there is a 94 metre water-level limit at the dam, and once the water touches that limit, "the gate is opened automatically" to discharge

"Whenever there is rainfall, they will not open the gates on the first day. The system is that the gate will automatically open after it reaches the 94 metre level. The early opening of gates would have submerged the downstream low-lying areas," added Deb.

An official from the Tripura State Electricity Corporation Limited, which operates the Dumbur dam, also said that the gates were not operated manually. "Excess water was released automatically after the reservoir was full," said Manoj Debberma, additional general manager (generation) of Tripura State Electricity Corporation Limited.

He added that till the water was below the danger level of 93.5 metres, "there is no need to release the water then. Had they operated the gates manually, they could have lowered the water level by 1.5 metres, he said. "But why will we do so?" he said. "If we do, there will be water downstream."

Thakkar said this claim does not hold true. He noted that a decision to open the gates manually to a certain extent could have been made by assessing the carrying capacity of downstream catchment areas.

Over the rainfall days, they could have done this at a sustainable rate till the dam reached the full reservoir level of 93.5 metres, he said, adding that this "would have given more time and preparation for downstream areas in Tripura and Bangladesh.

with communication Bangladesh

While the role of the dam water might have been limited, Bangladeshi officials claimed they had not been notified by India about the dam gates being opened.

opening could have helped them take 'precautionary measures to protect people and assets from the sudden floodwa-Partha Pratim Barua, a sub-divisional engineer working at the Flood Forecasting and Warning Centre of the Bangladesh Water Development Board, told Dhaka Tribune.

An advance notice about the dam

While the Dumboor dam authorities kept sharing information with the state government, authorities in Tripura did not inform Bangladesh about the release of water. "There is no mechanism in place to inform Bangladesh as it is an international matter," Deb said.

Duati from Tripura's disaster management authority added: "We are not responsible for sharing information to Bangladesh.'

Experts point out that the issue is beyond being a "Tripura-Bangladesh problem" or associated with "a single dam." Cross-border coordination and flood management is needed, they suggested, especially for the two countries that have 54 transboundary rivers.

Considering the geographically unfor-

tunate position of Bangladesh when it

came to receiving flood water discharge,

Rahman suggested joint research, coop-

eration, and coordination mechanisms between the North East and Bangladesh. He highlighted a need for an "overall riparian cooperative model between India and Bangladesh, and data-sharing and early warning mechanisms." (Courtesy: Scroll.in)

Climate change accelerates: 2023 set multiple new records for drought, with nearly 8% of land area severely affected

Tearly 8 per cent of the global land area was under extreme drought in July 2023, setting a new record, according to the State of the Climate in 2023 report by the National Oceanic and Atmospheric Administration (NOAA). This surpasses the previous high of 6.2 percent set ust a year earlier in July 2022.

Globally, 29.7 per cent of land experienced moderate or worse categories of drought in 2023 another record-breaking figure. In addition, greenhouse gas concentrations, global temperature across land and ocean, global sea level and ocean heat content all set new records in 2023.

"This report documents and shares a startling, but well-established picture: We are experiencing a warming world as I speak and the indicators and impacts are seen throughout the planet. The report is another signpost to current and future generations," Derek Arndt, director at the National Centers for Environmental Information, NOAA, said in

a statement Further, the annual global surface temperature was 0.55 to 0.60 of a degree Celsius above the 1991–2020 average, making 2023 the warmest year since records began in the mid-to-late

The major greenhouse gases - carbon dioxide, methane, and nitrous oxide — continued to rise, reaching record levels in 2023 as well.

The global ocean heat content up to a depth of 2,000 metres continued to increase and reached new record highs in 2023. The global mean sea level reached 4 inches (over 10 centimetres) above the 1993 average, a record high for the 12th

consecutive year. Mexico reported its driest (and hottest) year since the start of its record in 1950. West Asia, Europe and South America scored high on the drought severity index, which measures longer-term meteorological drought. South America, for instance, experienced severe drought in the latter half of the year throughout Amazon basin, with Rio Negro in Manaus, Brazil, a major tributary of Amazon river, reaching its lowest level since records began in

conditions set conditions ripe for wildfires. Canada experienced its worst national wildfire season on record in 2023, where large-scale fires burned continually from May to September. The burned area was roughly 15 million hectares, which was more than double the previous record from 1989.

Globally, 29.7 per cent of land experienced moderate or worse categories of drought in 2023 another record-breaking figure Greece, too, saw record wild-

fires. The total area burned in the country in 2023 was more than four times its long-term average, the report highlighted. Australia experienced its dri-

est three-month period in Australia in the 104-year record between August and October 2023. Millions of hectares of bushfires burned for weeks in the Northern Territory.

As for the poles, the Arctic saw its fourth-warmest year in 2023 in the 124-year record. Over half of the sites in the region saw the highest belowground, permafrost temperatures on record. Thawing of permafrost does not just affect infrastructure; it can also affect the rate of greenhouse gas release to the atmosphere, potentially accelerating global warming.

The seasonal Arctic sea ice, which typically reached its minimum extent in September, was the fifth-smallest in the 45-year

In the South Pole, new monthly mean record lows in sea ice extent and sea ice area were seen in eight months of the year. On February 21, 2023, Antarctic Sea ice extent and sea ice area reached all-time record lows, surpassing the previous record lows observed in February 2022.

The tropical cyclone activity was below average in 2023, with over 82 named tropical storms against the average of 87 observed in 1991–2020.

However, storms still set records around the globe, with over seven tropical cyclones reaching Category 5. Globally, the accumulated cyclone energy - a combined measure of the strength, frequency and duration of tropical storms and hurricanes was above average in 2023.

Bangladesh's interim government led by Yunus lifts ban on the Islamist Jamaat-e-Islami party

DHAKA, Aug 28: Bangladesh's interim government led by Nobel laureate Muhammad Yunus on Wednesday lifted a ban on the Islamist Jamaat-e-Islami party that was imposed by the former prime minister who was ousted in nationwide protests against

Sheikh Hasina, who fled to India on Aug. 5, had banned the party as a "militant and terrorist" organization and blamed its student wing and other associate bodies for inciting chaos over a quota system for government jobs. The weeks of violent protests and Hasina's crackdown left more than 600 people dead, according to U.N. estimates.

The Ministry of Home Affairs repealed the ban on Wednesday, paving the way for

the party to resume its activities. It still needs to register with the Election Commission to contest polls.

There was no immediate reaction from the party leadership. maat-e Islami has been banned from taking part in elections since 2013, after the

Election Commission canceled its registration, a decision upheld by the High Court, which ruled that the party's charter violated the constitution by opposing secularism. Bangladesh's Law Affairs Adviser Asif

Nazrul said that Hasina's ban was politically motivated and not based on ideology.

Mirza Fakhrul Islam Alamgir, secretarygeneral of the Bangladesh Nationalist Party led by former Prime Minister Khaleda Zia, Hasina's rival, also had blamed Hasina's government for the ban that he said was meant to divert attention from the violence in which security officials were accused of using excessive force and causing deaths

struggling to restore political stability and order as police forces and other government sectors are demoralized after attacks by protesters. Compounding the crisis was a devastating flash flood that ravaged the country's eastern and other regions, killing at least 27 people.

Under Hasina, who was criticized as an authoritarian, thousands of opposition leaders and activists were arrested before the January election that returned her to power for the fourth consecutive term. Human rights groups blamed her for using security forces and courts to suppress the opposition, the charge she denies.

Jamaat-e-Islami was founded during the British colonial rule in 1941 by a controscholar and campaigned against the

> Bangladesh as an independent state during the war of independence from Pakistan in 1971. In 2013, a mass

uprising in Dhaka led by youth groups, civil society organizations and secular political parties called for the execution of the party leadership for their role in 1971 war crimes.

Most of the senior leaders were hanged or jailed since 2013 after they were convicted of crimes against humanity including killings, abductions and rapes in 1971. The party had formed militia groups to help the Pakistani military during the ninemonth war. Bangladesh won independence on Dec. 16, 1971, with the help of neigh-

Israel launches a large-scale military operation in the occupied West Bank, killing 9 Palestinians

CAMP (WEST BANK), Aug 28: Israel launched a largescale military operation in the occupied West Bank on Wednesday, where its forces killed at least nine Palestinians and sealed off the volatile city of Jenin, according to Palestin-

Israel has carried out neardaily raids across the West Bank since Hamas' Oct. 7 attack out of Gaza triggered the ongoing war there.

Lt. Col. Nadav Shoshani, an Israeli military spokesman, said that "large forces" had entered the volatile city of Jenin, which has long been a militant stronghold, as well as Tulkarem and the Al-Faraa refugee camp dating back to the 1948 Mideast war, all in the northern West

He said the nine dead were all militants, including three killed in an airstrike in Tulkarem and another four in an airstrike in Al-Faraa. He said another five suspected militants were arrested, and that the raids were the first stage of an even larger operation aimed at preventing attacks on Israeli civil-

Palestinian militant groups said they were exchanging fire with the Israeli military. The governor of Jenin, Kamal Abu al-Rub, said on Palestinian radio that Israeli forces had surrounded the city, blocking exit and entry points and access to hospitals, and ripping up infra-

The Palestinian Health Ministry in the West Bank said Israeli forces had blocked the roads leading to a hospital with dirt barriers and surrounded other medical facilities in Jenin. Shoshani said the military was

trying to prevent militants from

taking shelter in hospitals. An Associated Press reporter saw army vehicles blocking all the entrances to Al-Faraa camp. Military jeeps and bulldozers entered the camp and soldiers could be seen patrolling its alleyways by foot. Water leaked onto the damaged streets from houses where fighting had damaged tanks and pipes. Shots

Israeli Foreign Minister Israel Katz drew comparisons with Gaza and called for similar measures in the West Bank.

rang out every few minutes.

"We must deal with the threat just as we deal with the terrorist infrastructure in Gaza, including the temporary evacuation of Palestinian residents and whatever steps might be required. This is a war in every respect, and we must win it," he wrote on the platform X.

Shoshani said there was no plan to evacuate civilians.

At least 652 Palestinians in the West Bank have been killed by Israeli fire since the war in Gaza began over 10 months ago, according to the Palestinian ministry. Most have died during such raids, which often trigger gunbattles with mili-

Israel says the operations are required to dismantle Hamas and other militant groups and to prevent attacks on Israelis, which have also risen since the

start of the war. The Palestinian Health Ministry said the bodies of seven people were brought to the hosBank city, and another two were brought to the hospital in Jenin. The ministry identified two killed in Jenin as Qassam Jabarin, 25, and Asem Balout,

Israel captured the West Bank, Gaza and east Jerusalem in the 1967 Mideast war. The Palestinians want all three for a

Israel has built scores of settlements across the West Bank, which are home to over 500,000 Jewish settlers. They have Israeli citizenship, while the 3 million Palestinians in the West Bank live under Israeli military rule, with the Palestinian Authority exercising limited control over population centers.

The war in Gaza erupted on Oct. 7, when Hamas-led militants stormed into southern Israel and rampaged through army bases and farming communities, killing some 1,200 people, mostly civilians, and abducting around 250.

third of whom are believed to be dead, after most of the rest were released during a November cease-fire.

Israel responded with an offensive that has killed over 40,000 Palestinians, according to Gaza's Health Ministry, which does not say how many were militants. A Russian missile strikes a Ukrainian city already in mourning for deaths in an earlier attack

KYIV, Aug 28: A Russian missile slammed into Kryvyi Rih on Wednesday, local authorities said, just as Ukrainian President Volodymyr Zelenskyy's home city was observing an official day of mourning for an attack the previous day that killed four civilians

The latest attack on the city struck civilian infrastructure, wounding four people, local administration head Oleksandr Vilkul said on social media.

The previous attack on Tuesday, which also wounded five people in Kryvyi Rih in addition to the four dead, was part of a barrage of dozens of missiles and drones across Ukraine that Russia launched for a second consecutive day.

"When Kryvyi Rih is in mourning, the enemy attacks again. And it once again aims at civilians," regional head Serhii Lysak said on Wednesday.

Russia stepped up its bombing of Ukraine on Monday, when it fired more than 100 missiles and a similar number of drones in its biggest onslaught in

The intensified bombing campaign coincided with what could prove to be a decisive period of the war, which Russia launched on Feb. 24, 2022.

Russian forces have been driving deeper into Ukraine's partly occupied eastern Donetsk region, whose total capture is one of the Kremlin's primary ambitions.

Russia's army is closing in on Pokrovsk, a critical logistics hub for the Ukrainian defense in the area.

At the same time, Ukraine has sent its forces into Russia's Kursk region in recent weeks in the largest incursion onto Russian soil since World War II. The move is in part an effort to force Russia to draw troops away from the Donetsk front.

At the hotel in Kryvyi Rih, rescuers on Wednesday found another body under the rubble. The rescue operation was subsequently ended.

Meanwhile, Ukraine claimed its anti-aircraft defenses destroyed a Russian Su-25 jet in the Donetsk

Ukraine also kept up its long-range drone attacks on Russia's rear logistical areas, setting fire to a fuel

Germany and the UK seek a new bilateral treaty as Starmer pursues a 'reset' with the EU



BERLIN, Aug 28: The leaders of Germany and the United Kingdom announced plans on Wednesday to draw up a treaty meant to deepen the two nations' trade, defense and other

The move comes as new U.K. Prime Minister Keir Starmer moves ahead with plans for a "reset" of relations with the European Union.

German Chancellor Olaf Scholz said that he welcomes fellow centerleft leader Starmer's desire for a new beginning in relations with the EU, and "we want to take this outstretched

Starmer took office in early July after the previous Conservative government was trounced in an election. Four years after the U.K. left the EU, he says he wants to rebuild ties strained by years of ill-tempered wrangling over Brexit terms.

He said that he hopes to conclude the bilateral agreement with Germany, which has Europe's biggest economy, by the end of this year.

"That will be ambitious, it will be wide-ranging, covering trade, the economy, defense and many other issues," he told reporters. The two leaders are among Ukraine's biggest military backers and stressed their

Starmer said that the two countries also plan to draw up a "joint action plan to tackle illegal migration." His government still faces pressure to stop migrants crossing the English Channel in small boats, though it scrapped the Conservatives' contentious plan to send them on a oneway trip to Rwanda.

Migration is also an issue on which Scholz's government has long been under heavy pressure, even more so since Friday's attack in Solingen in which a suspected extremist from Syria who had avoided being deported is accused of killing three peo-

The proposed U.K.-Germany treaty is modeled in part on agreements that Britain struck in recent years with France on defense, security and closer law enforcement cooperation against people-smuggling gangs.

Starmer sent a signal by visiting Berlin early in his term — unlike predecessor Rishi Sunak, who took 18 months. But his talk of starting anew with the EU has its limits.

He has ruled out many of the major possible steps to closer ties and has been cool to the idea of a youth mobility agreement with the 27-nation

"I'm absolutely clear that we do want a reset ... with Europe, a reset with the EU," Starmer said in Berlin. However, "that does not mean reversing Brexit or reentering the single market or the customs union, but it does mean a closer relation on a number of fronts - including the economy, including defense, including exchanges, but we do not have plans for the youth mobility scheme." (AP)

Church sex abuse scandals in East Timor met by silence, but Pope Francis' visit brings new attention

DILI, Aug 28: When the Vatican acknowledged in 2022 that the Nobel Peace Prize-winning, East Timorese independence hero Bishop Carlos Ximenes Belo had sexually abused young boys, it appeared that the global clergy sexual abuse scandal that has compromised the Catholic Church's credibility around the world had finally arrived in Asia's newest country.

And yet, the church in East Timor today is stronger than ever, with most downplaying, doubting or dismissing the claims against Belo and those against a popular American missionary who confessed to molesting young girls. Many instead focus on their roles saving lives during the country's bloody struggle against Indonesia for

Pope Francis will come face to face with the Timorese faithful on his first trip to the country, a former Portuguese colony that makes up half of the island of Timor off the northern coast of Australia. But so far, there is no word if he will meet with victims or even mention the sex abuse directly, as he has in other countries where the rank-and-file faithful have demanded an accounting from the hierarchy for how it failed to protect their children.

Even without pressure from within East Timor to address the scandals, it would be deeply meaningful to the victims if Francis did, said Tjiyske Lingsma, the Dutch journalist who

helped bring both abuse cases to light. "I think this is the time for the pope to say some words to the victims, to apologize," she said in an interview from Amsterdam.

The day after Lingsma detailed the Belo case in a September 2022 report in De Groene Amsterdammer magazine, the Vatican confirmed that Belo had been sanctioned secretly two years ear-



In Vatican spokesman Matteo Bruni's statement, he said the church had been aware of the case since 2019 and had imposed disciplinary measures in 2020, including restrictions on Belo's movements and a ban on voluntary con-

Despite the official acknowledgement, many in East Timor still don't believe it, like Dili university student Martinha Goveia, who is still expecting Belo will show up to be at Francis' side during his upcoming visit.

If he's not there, she said, "that is not good in my opinion," because it will confirm he is being sanctioned by the Vatican.

Vegetable trader Alfredo Ximenes said the allegations and the Vatican's acknowledged sanctions were merely rumors, and that he hoped Belo would come to welcome the pope and refute the claims in person. "Our political leaders should imme-

diately meet him to end the problem and persuade him to return, because after all he has contributed greatly to national independence," Ximenes said.

Timorese officials refused to answer questions about the Belo case, but there's been no attempt to avoid mentioning him, with a giant billboard in Dili welcoming Pope Francis, whose visit starts Sept. 9, placed right above a

mural honoring Belo and three others as national heroes.

Only about 20% of East Timor's people were Catholic when Indonesia invaded in 1975, shortly after Portugal abandoned it as a colony.

Today, some 98% of East Timor's 3 million people are Cathol it the most Catholic country in the world outside the Vatican.

A law imposed by Indonesia requiring people to choose a religion, combined with the church's opposition to the military occupation and support for the resistance over years of bloody fighting that saw as many as 200,000 people killed, helped bring about that flood of new members.

Belo won the Nobel Peace Prize for his bravery in drawing international attention to Indonesian human rights abuses during the conflict, and American missionary Richard Daschbach was widely celebrated for his role in helping save lives in the struggle for independ-

Their heroic status, and societal factors in Asia, where the culture tends to confer much power on adults and authority figures, helps explain why the men are still revered while elsewhere in the world such cases are met with outrage, said Anne Barrett Doyle, of the online resource Bishop Accountability.

Ukraine first lady wants country's kids to see themselves as 'generation of winners' not war victims

UZHHOROD, Aug 28: Ukraine's first lady wants her country's children to view themselves not as a generation enduring a grinding war, but rather as "a generation of winners.'

On the sidelines of a day spent at a rehabilitation camp for Ukrainian children in the relatively safe western city of Uzhhorod, Olena Zelenska said on Tuesday that working with the next generation was both a moral obligation and a "strategic priority" for Ukraine's future.

Many of the children will return to front-line cities after spending a few weeks at the camp, barely enough time to overcome the

trauma they face over and over. "This issue needs to be addressed immediately, as soon as it arises, before it grows into something more," Zelenska told The Associated Press in a brief interview

at the camp. The foundation that bears her name, which is funded entirely by foreign donations, created the camp along with the Voices of the Children charity. A study by the Olena Zelenska Foundation and the Kyiv School of Economics this year found that 44% of Ukrainian children show signs of post-traumatic stress disorder.

Dressed casually with white sneakers, black pants, a white Tshirt and pearls around her neck, Zelenska blended into the camp's activities with the children.

Since the start of the war, she has emerged as an unofficial ambassador for Ukraine globally. She was the first from President Volodymyr Zelenskyy's family to leave the country after Russia invaded in February 2022 to promote Ukraine's cause. But she is equally active within Ukraine, and easily recognizable to the displaced families and wounded soldiers she visits. At the camp, she joined an art therapy session midway, sitting beside a boy whose home was struck by an aerial bomb and who was later forced to evacuate from his hometown ahead of the Russian

advance this summer. Zelenska smiled and engaged with the children, examining each



watercolor they presented. She even joined in, drawing a pink flower, a star and a heart. The conversation stayed away from the

"To ensure our children do not become a lost generation, we as adults must be not just active but also swift," Zelenska said. "It's difficult, but there is still the ongoing defense of the country. However, I am confident that political will combined with international cooperation can work wonders."

The first lady said she first heard about "war fatigue" in the summer 2022 but she refuses to believe in

"When your neighbor has a fire, it seems pointless to say: 'I'm tired of your fire. Stop it. Let's forget about it," she said. "We still need help, and we will continue to ask for it. Not because we are bold, but because it is vital for our survival."

During one of the activities, in which a mystery guest connected via an online call, eventually revealed to be Ukrainian boxer Oleksandr Usyk, one child in the crowd shouted, suggesting it might be the president.

The first lady quickly responded, "No, Zelenskyy is currently busy," prompting an eruption of laughter from dozens of children.

Zelenska studied architecture but wound up working as a comedy scriptwriter, including for Zelenskyy, who was a comedian with a popular television show before winning the presidency in 2019.

The couple periodically appears in public together, visiting schools or rehabilitation centers and making formal visits abroad. The scrutiny has taken something of a toll on Zelenska, who was not a public figure before her husband became president.

"I feel a responsibility because I understand that all eyes are on us," she said. "Even when you're not doing anything particularly special, people still assess how the president's family is functioning during the war — what they're doing, where they are, how they are behaving.

Zelenska noted that since the start of the invasion, Ukraine has been in a constant humanitarian crisis, with one of the biggest issues being internally displaced people and several million refugees abroad. (AP)

24 people missing after floods tore through a northern Yemen village

CAIRO, Aug 28: Floodwaters swept through a village in northern Yemen, inundating homes and shops and leaving at least 24 people missing, authorities said on Wednesday.

Heavy rains over the past few days pounded the Melhan district in Al-Mahwit province, triggering floods that caved in seven homes and four shops, according to a statement by Yemen's Houthi

rebels. Yemen was already the poorest Arab nation before it was plunged into civil war in 2014, when Iranbacked Houthi rebels took control of the capital, Sanaa, and much of the country's north, forcing the government to flee to the south,

hen to Saudi Arabia. Seasonal monsoon rains in the late summer often turn into flooding in Yemen, but there are indications that the country is experiencing more extreme weather events due to climate

A 2024 report by Yemen's Red Crescent projected that the country will see less precipitation overall, but that flooding events are expected to be more severe in the monsoon season.

Yemen's rainy season begins in late March, and rains intensify in July through mid-August.

The World Health Organization said this week that Yemenis were suffering "disproportionately from climate change due to their already undermined capacities, limited resources and fragile infrastructure." It warned that more heavy rains were expected in the

coming weeks and months. Though the country's conflict and disorder makes determining the true toll of the floods difficult. the organization said that at least 36 people had been killed in the western province of Hodeida alone by flooding in recent weeks, and in the central province of Marib there are roughly 8,400 internally displaced families. (AP)

Centre approves ₹ 4,136 cr for 15 GW hydropower projects in NE

NEW DELHI, Aug 28: The Union Cabinet on Wednesday approved equity support of ₹ 4,136 crore to northeast states for developing hydropower projects, totalling 15,000 MW capacity over the next

THURSDAY, AUGUST 29, 2024

The Cabinet, chaired by Prime Minister Narendra Modi, has approved the proposal of the Ministry of Power for providing central financial assistance (CFA) to the state governments of NER (North East Region) towards their equity participation in the development of hydroelectric projects through Joint Venture (JV) collaboration between state entities and Central Public Sector Undertakings, an official statement said.

This scheme has an outlay of ₹ 4,136 crore to be implemented from 2024-25 to 2031-32, Information and Broadcasting Minister Ashwini Vaishnaw said in a briefing on the Cabinet decisions.

A cumulative hydro capacity of about 15,000 MW would be supported under the scheme, the statement said.

The scheme will be funded through 10 per cent gross budgetary support (GBS)



for the northeastern region from the total outlay of the Ministry of Power.

The grant towards the equity portion of the state government of NER would be capped at 24 per cent of the total project equity, subject to a maximum of ₹ 750

The cap of ₹ 750 crore for each project would be revisited, if required, on a caseto-case basis.

The equity ratio of the CPSU and state government in the JV will be maintained at the time of disbursing of the grant.

Central financial assistance would be limited to only viable hydroelectric projects. States would be required to waive or

to make the project viable.

With the introduction of this scheme, participation of state governments in hydro development will be encouraged and risk and responsibilities will be shared in a more equitable manner, the statement said.

The issues like land acquisition, rehabilitation & resettlement and local law & order issues would be reduced with state governments becoming stakeholders. This will avoid time and cost over-run of the projects, it added.

It would bring huge investment in the northeastern region and will provide a large number of direct employment to the local people, it noted

The development of hydroelectric projects will also contribute towards the realisation of India's Nationally Determined Contribution (INDC) of establishing 500 GW renewable energy capacity by 2030 and help the integration of RE sources in the grid thus enhancing flexibility, security and reliability of the national grid, as per the statement. (PTI)

Mining minor mineral not exempted under MMDR Act: Dy CM



SHILLONG, Aug 28: Meghalaya deputy chief minister Prestone Tynsong recently said that there is no scope under the law for exempting any traditional form of mining of minor minerals from the operation and purview of the Meghalaya Minor Minerals Concession Rules (MMMCR), 2016 or Mines and Minerals (Development and Regulation) (MMDR) Act, 1957.

Replying to a zero-hour notice moved by a BJP legislator from South Shillong Sanbor Shullai in the Assembly, Tynsong said, "It is under the aforesaid circumstances, statutory requirements including the Rules and the unambiguous court rulings which are binding on the state government the state government had promulgated Meghalaya Mineral (Prevention of illegal mining, transportation and storage) Rules, 2022 which do not permit any transport of minor minerals without securing transport challan as per Form-H of MMMCR, 2016 which in turn would require that the stone boulder is sourced from a quarry or mine which has a legal mining lease or quarry per-

"On the face of all the aforesaid rulings of the High Court and Supreme Court and the relevant Acts and Rules there is no scope under the law for exempting any traditional form of mining of minor minerals from the operation and purview of MMMCR, 2016 or the MMDR Act, 1957 nor for transporting any minor mineral such as boulder stones, sand etc without obtaining transport challan as prescribed under the Rules," he said.

He further conveyed that it is also of concern that a violation of these rules would amount to a violation of the MMDR Act, 1957 which is an offence under Section 21 of MMDR Act, 1957.

"Therefore, in view of the extant court Rulings including those of the Supreme Court and the Meghalava High Court in interpretation of the Constitution of India and prevailing statutes relating to mining and environmental clearance, the existing laws on the matter which are in force in our state perhaps no exemption could be made in favour of either traditional mining of stones or any other minor mineral from the operation of these statutes or for their transportation," he added.

Further, Tynsong assured that all steps would be taken to expedite the granting of a mining lease or quarry permit to applicants who approached the department for the same.

"The departmental staff would also be instructed to assist such individuals in helping them fill the relevant applications, and explain to them the procedure involved for applying such permits.

After a mining lease or quarry permit has been granted to the applicant then he would be entitled to Form-H under Meghalaya Minor Mineral Concession Rules, 2016 for transporting the excavated boulder stone or any other minor mineral.

"Thereafter neither the miner nor the transporter would face any hurdle in either mining the boulder stone or transporting the boulder stone," Tynsong said.

Meanwhile, Tynsong also informed that the government is examining the possibility of a single window agency. (NNN)

M'laya assembly rejects bill on NCL for ST

Meghalaya launches District Nutrition Challenge

Aims to improve nutritional issues

GUWAHATI, Aug 28: Aligning with the SDG goals, set to be achieved by 2030, a two-day Human Development Leadership Programme (HDLP) workshop took place from August 23-24 in Shillong. Out of the 17 goals, a heightened focus was on reducing maternal and child deaths, improving nutrition outcomes, addressing learning outcomes and overall socio-economic development.

Notably, the state has constituted a firstof-its-kind Human Development Council headed by the chief minister in February this year and as part of this, the 2-day workshop was conducted.

Day 1 of the workshop witnessed participation of Deputy Commissioners from 12 districts, including key state officials: Chief Secretary-D.P Wahlang, IAS, Additional Chief Secretary-Shakil P Ahammad, IAS, Development Commissioner & Principal Secretary-Sampath Kumar, IAS, Commissioner & Secretary- Planning & Finance Vijay Kumar, IAS, Commissioner & Secretary, Education- Vijay Mantri, IAS, and Additional Development Commissioner, Joram Beda IAS, among other key officials. The workshop also witnessed the presence of Health Minister Dr M Ampareen Lyng-

The prime focus of Day 1 was on the need to improve nutritional indicators, especially stunting rates among children. A District Nutrition Challenge was assigned to each district, along with targets to achieve, based on the insights given by the members on their developmental indicators.

It focused on the improvement of nutritional indicators, which will be done through a decentralized leadership approach, initiated through joint field visits to vulnerable households as part of HDLP. These visits are aimed at identifying & addressing systemic challenges causing low development indicators such as anaemia, malnutrition, stunting, high-risk pregnancies, teenage pregnancies, housing facilities, SHG coverage, education & learning engagement among children and adolescents as well as poverty.

It further aimed at facilitating a convergent cross-departmental approach with enhanced public service motivation to address the identified issues and mobilise communities to ensure ownership and intervention to tackle the human development chal-

Following discussions with the DCs, directions were given to them to decentralize the Supplementary Nutrition Programme (SNP) under the ICDS to ensure that local & nutritious food is made available to the children as well as lactating mothers.

The need for decentralization of the SNP was discussed at length and a collective decision was taken for the need to decentralize the ICDS-SNP programme, with directions being given to the departments and districts to initiate steps for the same.

In his opening address, the Development Commissioner Mr. Sampath Kumar, IAS, said that since the launch of mission mode "Rescue Mission and CM-SMS programs, the maternal deaths reduced by around 50% and infant deaths by 34% from in the last 4 years." He highlighted that the joint field visits to each vulnerable household under the HDLP will help address the problems of all members of a household while aiming to strengthen the citizen-state relationship.

Meanwhile, health minister Dr M. Ampareen Lyngdoh highlighted the wealth of data and insights being gathered through the house-to-house visits as part of HDLP joint visits, which is essential for driving strategic decisions and interventions aimed at improving health outcomes across Meghalaya. She advocated for involving MLAs in in-depth research and involving them more effectively in health and development initiatives.

Chief Secretary D.P. Wahlang, IAS, highlighted key health issues, including Meghalaya's high Total Fertility Rate (TFR). "With about 80,000 new individuals added annually due to TFR, it is important to focus on skill development and a fieldoriented approach to meet Meghalaya's long-term development goals," he stated. He further provided a comprehensive overview of the current development priorities for Meghalaya

The second day of the workshop focused on the need for and steps to improve nutritional outcomes as part of the District Nutrition Challenge launched on Day 1.

The Development Commissioner, while facilitating the workshop, stated, "We need to address stunting to improve learning outcomes among children, and hence, we will set a collective target to increase the aver-

age height of children through the District Nutritional Challenge – This will be done through a three-pronged strategy - 1. Promoting effective exclusive breastfeeding during the first six months, 2. Decentralizing the Supplementary Nutrition Program (SNP) under ICDS to ensure that nutritious food is provided through local community participation, and 3. Increasing the consumption of Iron Folic Acid (IFA) supplements among all mothers during the antenatal period and adolescent girls to address anaemia." The importance of the first 1000-day pe-

riod was emphasized, spanning from conception to a child's second birthday- a critical window for ensuring proper nutrition and development.

Explaining the high stunting rates among children in Meghalaya (46.5% as per NFHS-5), the Development Commissioner urged the districts to achieve the "Half a Feet Challenge" by aiming to improve the average height of a child by the age of two years. Currently, the average height of a two-year-old child in Meghalaya is approximately 2.5 ft, compared to an optimal height of 3 ft to be gained by a child of 2 years of age (in the first 1000 days).

A key component of the workshop was a case study exercise facilitated by MD-NHM-Ram Kumar, IAS that simulated scenarios faced by pregnant women in rural Meghalaya.

Participants were asked to develop follow-up questions and support strategies for a household dealing with anaemia, malnutrition, and school dropout. This session emphasized the importance of asking the right questions during field visits and providing tailored solutions to each household's unique challenges.

The second day witnessed about 140 participants comprising Secretaries and Directors of aforementioned departments and Deputy Commissioners of all 12 districts, Additional Deputy Commissioner/Project Director (DRDA), DM&HO, DPO (ICDS), DSEO, DPM (NHM), DMM (MSRLS), Medical Superintendents, DM&CHOs, MSRLS, DHS, Officials from Social Welfare department, functionaries from ICDS, MSRLS, NHM, MHSSP, UNICEF, Research Fellows from School of Public Policy- UCL, team members from the Public Affairs Center, among others.

Bengal govt will amend existing laws to ensure death penalty to rapists: Mamata

"We will pass the amended bill in a special session of the assembly next week. We will then send it to the governor for his nod. We will stage dharna outside Raj Bhavan if he sits on the bill," she thundered from the Trinamool Congress Chhatra Parishad foundation day rally here.

The CM said women will be at the forefront of the proposed dharna accompanied by "their brothers".

NEW DELHI, Aug 28: The Enforcement Directorate on Wednesday said a penalty of Rs 908 crore has been slapped in a case related to the violation of foreign exchange rules against DMK MP S Jagathratchakan and his family

The federal agency issued a statement which said that properties worth Rs 89.19 crore, seized in September 2020, have been confiscated following an adjudication order issued on August 26 under the Foreign Exchange Management Act (FEMA).

Jagathratchakan, 76, represents the Arakkonam Lok Sabha seat.

The agency said a FEMA probe was initiated against the MP, a businessman from Tamil Nadu, his family members and related Indian

This investigation, it said, resulted in the passing of seizure order, dated September 11, 2020 under section 37A of FEMA, for various movable and immovable properties in the name of the MP and his family members. There are

K'taka HC to resume hearing on CM's petition today

BENGALURU, Aug 28: The Karnataka High Court is set to resume hearing on Chief Minister Siddaramaiah's petition challenging the legality of the Governor Thaawarchand's sanction for his prosecution in the Mysuru Urban Develop-

ment Authority (MUDA) case on

The Governor on August 16 accorded sanction under Section 1/A of the Prevention of Corruption Act, 1988 and Section 218 of the Bharatiya Nagarik Suraksha Sanhita, 2023 for the commission of the alleged offences as mentioned in the petitions of Pradeep Kumar S P, T J Abraham and Snehamayi Krishna.

On August 19, Siddaramaiah moved to the High Court challenging the legality of the Governor's order. The HC had directed the special court for people's representatives that was slated to hear complaints against him in the case, to defer its proceedings till the next date of hearing on August 29.

In the petition, the Chief Minister submitted that the sanction order was issued without due application of mind, in violation of statutory mandates, and contrary to constitutional principles, including the advice of the Council of Ministers, which is binding under Article 163 of the Con-

stitution of India. The court proceedings will be keenly watched for its possible political impact.

The Congress has rallied behind Siddaramaiah and ruled out his resignation over the issue and said it would wage a legal and political fight. Siddaramaiah and Deputy Chief Minister D K Shivakumar, who is also state Congress chief, and several senior Ministers recently met AICC President M Mallikarjun Kharge and Rahul Gandhi in New Delhi and held discussions on the Governor's order and

strategy to be adopted going forward. On the Chief Minister's petition coming up for hearing in the High Court on

Thursday, Home Minister G Parameshwara said there is hope that the HC will not consider the argument in favour of the Governor's decision. "There should be material about Siddaramaiah's involvement. If they (materials) are there, they can be taken into cognisance. When there are no materials like -- his signature, his order, involve-

ment and name... even in the registration his name is not there. When such is the case, the court will look into all these things and will decide on it," he said. Responding to a question on whether there have been any discussions by the high command regarding the next course of action, in case the developments in the

court on August 29 go against Siddaramaiah, the Minister said: "What developments will happen cannot be speculated, once things happen let's discuss, this is what they have told." Asked about speculations that he may

become CM (in the event of Siddaramaiah quitting), Parameshwara, who held a prolonged discussion with Congress leadership -- Mallikarjun Kharge and Rahul Gandhi -- during the recent Delhi visit,, said that question doesn't arise at all, and the issue has never come up for discussion. " (My) seniority may be there....it is true that Rahul Gandhi spoke to me separately, but what was discussed cannot be speculated. I'm a disciplined soldier of the party and have fulfilled the responsibility given to me from time to time. He (Rahul) spoke to me regarding party things, other than that nothing was discussed," he added.

Chief Minister's Legal Advisor and Virajpet Congress MLA, A S Ponnanna

said: "According to us, the Governor's order is contrary to the law and seems to have been taken in a hurry.'

"Unilateral decision was taken by the Governor without any inquiry or examining evidence, so we are hopeful of winning in the court. Necessary action will be taken based on what the court decides," he said.

Claiming that there is situation in the country where all non-BJP governments in the states are "forced to go to court for everything," Ponnanna accused ruling BJP at the Centre of "using" the Raj Bhavan and said: "in the days to come after getting admonished by the court, they will learn a lesson.' resolution can be passed in the state legislature seeking the removal of the Governor and send it to the Centre. Govt plans to revive district agrometeorological units with permanent manpower: Officials

NEW DELHI, Aug 28: The government plans to revive the network of district agrometeorological units, which provided detailed block-level weather-related information to lakhs of farmers in the country until the India Meteorological Department directed their closure earlier this year, according to officials.

Several politicians, including Union minister Nitin Gadkari and Congress MP Jairam Ramesh, had opposed the shut-

"Human intelligence plays a crucial role in weather forecasting, even when we use models, artificial intelligence and machine learning," an official told PTI when asked if there's a plan to revive the district agrometeorological units

"DAMUs were temporary in nature, with staff hired on a per-project basis. The ad-hoc nature of posts affected the forecast quality. There will be a permanent structure in place this time. The manpower will include both permanent and contractual staff. We aim to formalize and structure the process," the official

In 2015, the government launched the Gramin Krishi Mausam Seva (GMSV) to provide crop and location-specific detailed advisories to farmers, aiding them

in day-to-day decision-making. Over the years, 130 agromet field units (AMFUs) were set up in agro-climatic zones in the country in collaboration with the Indian Council of Agricultural Research (ICAR). Each AMFU caters to four to five districts.



In 2018, the government decided to extend the reach of the service by setting up 530 district agromet units on the premises of Krishi Vigyan Kendras (KVK). However, the Covid pandemic impacted the process, and only 199 DAMUs could be set up, each with two contractual employees - SMS Agromet and Agromet Ob-

In a meeting of the Expenditure Finance Committee held in February last year, a senior advisor of Niti Aayo had suggested reevaluating the "necessity of

providing staff at each DAMU". The official suggested the Ministry of Earth Sciences (MoES) may have "centralized units instead of field units as the

collection of data is automated". On January 17, the IMD wrote to all the DAMUs, asking them to wind up their operations by the end of the financial year 2023-24.

According to sources, the Ministry of Earth Sciences want the agriculture ministry to bear the expenditure for DAMUs.

"The data collection is automated. The IMD analyzes it and prepares forecasts centrally; DAMUs only disseminate advisories. The agriculture ministry is responsible for dissemination work, and therefore, it should be the nodal ministry," an MoES official had said earlier.

In a letter to former Earth Sciences Minister Jitendra Singh, Gadkari had said closure of DAMUs will have an adverse impact on agriculture production, food security, and livelihood of the farming

Earlier this month, Ramesh said that the DAMUs were shut down because the NITI Aayog "misrepresented" their role and sought privatisation. (PTI)

A decade of financial inclusion: PM Modi hails Jan Dhan Yojana

NEW DELHI, Aug 28: As the Pradhan Mantri Jan Dhan Yojana completed 10 years, Prime Minister Narendra Modi on Wednesday said the scheme personifies dignity, empowerment and the opportunity to participate in the economic life of the nation.

Modi also hailed those who worked to make the Jan Dhan Yojana a success, and said the scheme has been paramount in boosting financial inclusion.

"Today, we mark a momentous occasion - #10YearsOfJanDhan. Congratulations to all the beneficiaries and compliments to all those who worked to make this scheme a success," the prime minister said in a post on X.

The Jan Dhan Yojana has been paramount in boosting financial inclusion and giving dignity to crores of people, especially women, youth, and the marginalised communities, he said.

Later, on a Linkedin post, Modi said today marks a decade since the Pradhan Mantri Jan Dhan Yojana was launched and for him, this initiative was more than just a policy -- it was an endeavour to build an India where each and every citizen, irrespective of one's economic background, has access to the formal banking apparatus.

"Many of you, especially the youth, would be thinking -- why does this matter so much? After all, in this age, having a bank account would be very basic and even taken for granted. However, when we assumed office in 2014, the situation was very different. It was almost 65 years since Independence, but access to banking was a distant dream for almost half of our households," the prime minister said.

Theirs was a world where savings were kept at home, vulnerable to loss and theft, he noted.

"Access to credit was often at



the mercy of predatory lenders. The absence of financial security held back so many dreams," Modi said. "This problem becomes even more ironical considering the fact that four and a half decades ago, banks were nationalised by the then (Congress) Government and that too in the name of the poor! Yet, the poor never got access to banking," he said.

"When the Jan Dhan Yojana was rolled out, I remember the scepticism that surrounded it too. Some people asked -- could it really be possible to bring such a large number of people into the banking system? Will this effort lead to any concrete changes? Yes. The scale of the challenge was enormous, but so was the determination of the people of India to ensure it becomes a reality," he said.

The success of the Jan Dhan Yoiana has two parts to it. Modi pointed out and said one is in the numbers with over 53 crore people who never imagined they would enter a bank having bank accounts

CBI starts polygraph test on Kolkata Police ASI



NEW DELHI, Aug 28: The CBI on Wednesday began the process of conducting a polygraph test on Kolkata Police ASI Anup Dutta to decipher his alleged links with Sanjay Roy, arrested in the rape and murder case of a trainee doctor at RG Kar Medical College and Hospital, officials said.

The Central Bureau of Investigation (CBI) had taken permission from a Kolkata court to conduct the polygraph test on Assistant Sub-Inspector Dutta, who was earlier questioned by the agency in the

Dutta will be the eighth person to undergo a polygraph test in this

According to the officials, Dutta, posted in the Kolkata Police Welfare Committee, had allegedly extended a number of favours to Roy, a traffic police volunteer.

The CBI is trying to find out if Roy informed Dutta about the crime he allegedly committed and whether he sought any favours for covering up the crime, the officials said. The information revealed during the polygraph test may not be used as evidence during the trial but the agency may gather corroborative evidence which could be used in court, they said.

A polygraph test can help in assessing inaccuracies in the statements of suspects and witnesses. By monitoring their psychological responses, heart rate, breathing pattern, sweating and blood pressure, investigators can determine if there are discrepancies in their re-

The trainee doctor was allegedly raped and murdered in the seminar hall of RG Kar Medical College and Hospital when she had gone to rest during her graveyard shift in the early hours of August 9.

Her body with severe injury marks was found inside the hall by a doctor who was on rounds.

Roy was arrested the next day based on CCTV footage in which he was seen entering the seminar hall at 4.03 am on the day of the in-

He was put through extensive interrogation when "recent injuries" on his left cheek, abrasion on the left hand and the back of his left thigh, among others, showing signs of struggle were recorded by police.

His biological samples like urethral swab and smear, semen, hair, nail clippings and nail scraping were collected during the medicolegal examination.

On August 13, the Calcutta High Court ordered the transfer of the probe from the Kolkata Police to the CBI, which took over the case on August 14.

After taking over the case, the CBI subjected Roy, former principal of the medical college Sandip Ghosh, four doctors who were on duty with the victim, and a civic volunteer to polygraph tests to get further leads about the crime. (PTI)

Junior doctors in Bengal reject Mamata's appeal to end cease work

KOLKATA, Aug 28: The agitating junior doctors in West Bengal, who have been continuing ceasework for 20 days to protest against the alleged rape and murder of a medic, on Wednesday rejected Chief Minister Mamata Banerjee's appeal to join duty.

A member of the West Bengal Junior Doctors' Forum said they would not withdraw the agitation unless their demands, such as justice for the deceased postgraduate trainee of the RG Kar hospital,

They also demanded the suspension of Dr Sandip Ghosh, the former principal of RG Kar Medical College and Hospital, from the health services and the same action against the Kolkata police commissioner. The doctor's forum took out a rally in Shyambazar area in the northern part of Kolkata to press their demands. "We are glad to know that the chief minister is supporting our cause. We want to return to work but that is not possible now as our demands are vet to be met." the member of the forum said.

Addressing a rally organised by Trinamool Congress Chhatra Parishad, Banerjee said, "I have remained sympathetic towards the cause of the doctors from the very beginning since they were seeking justice for their colleague. We did not take any action against them although so many days have passed since the incident. We understand your pain. But please come back to work now since patients are suffering." The agitating medics demanded elections in colleges, participation of junior doctors and students in all

decision-making committees of the medical facilities and security measures at workplaces. During the rally, which culminated in Esplanade area in central Kolkata, the junior doctors carried placards and posters and raised demands for justice for the deceased medic.

The doctors' rally coincided with a 12-hour bandh called by the BJP to protest against the police action during the 'Nabanna Abhijan' by Paschimbanga Chhatra Samaj, an unregistered students' organisation. (PTI)

India sees 2nd highest drop in particulate pollution, one year added to life expectancy: Report

NEW DELHI, Aug 28: India logged a 19.3 per cent decline in particulate pollution in 2022, the second highest in the world after Bangladesh, adding an average of one year to the life expectancy of citizens, a new report showed on Wednesday.

The annual report, "Air Quality Life Index" 2024, by the Energy Policy Institute at the University of Chicago (EPIC) also said that Indians are likely to lose 3.6 years of life expectancy if the country fails to meet the World Health Organisation's (WHO) annual PM2.5 concentration standard of 5 micrograms per cubic metre.

The researchers attributed the decline in particulate levels in India and other South Asian countries primarily to favourable meteorological conditions and a reduced number of thermal inversions -- when a layer of warm air traps cooler air near the ground, causing pollution to build up.

PM2.5 concentrations in India in 2022 were around 9 micrograms per cubic metre (19.3 per cent) lower compared to 2021.

The most significant declines were observed in Purulia and Bankura districts of West Bengal, followed by Dhanbad, Purbi, Paschim Singhbhum, Paschim Medinipur and Bokaro districts in Jharkhand. In each of these districts, PM2.5 concentrations dropped by

over 20 micrograms per cubic metre. Despite the decline in pollution, 42.6 per cent of the Indian people live in areas which exceed the country's national air quality standard of 40 micrograms per cubic metre.

People in Delhi -- India's capital and most populous city -- would gain 7.8 years of life expectancy if all of India were to reduce particulate pollution to meet the WHO guideline. In North 24 Parganas -- the country's second



most populous district -- people would gain 3.6 years of life expectancy, the report said. It said that the northern plains, the most polluted region in India, saw a 17.2 per cent reduction in particulate levels in 2022 compared

However, despite this improvement, the average resident in this region is still likely to lose about 5.4 years of life expectancy if the current pollution levels persist. On the other hand, if the decline in particulate levels continues at the same rate in the coming years, life expectancy in the northern plains could increase by 1.2 years.

Beyond the northern plains, Maharashtra, Madhya Pradesh and Rajasthan have the highest burden of pollution in the country. On average, 292.3 million people living in these states are now losing 2.9 years of life ex-

"The report clearly shows that even a modest reduction in air pollution levels could lead to increased life expectancy. Air pollution, even at low levels, significantly shortens lives and poses serious public health risks.

"Our current national air quality standards fall short of protecting public health and must be revised in line with World Health Organisation guidelines. We have the tools and technologies to solve the air pollution crisis, what we need now is the political will to implement them," said Avinash Chanchal, Campaign Manager, Greenpeace India.

The report said that PM2.5 concentrations declined by 19 per cent on average in districts with cities covered by India's flagship programme on air quality management, the National Clean Air Programme (NCAP), while districts not covered by the programme saw a 16 per cent decline.

However, barring Dhanbad, none of the districts with the highest decline in PM2.5 concentrations are covered by the NCAP

Launched in 2019, the NCAP is India's first national effort to set clean air targets, aiming for a 20-30 per cent reduction in particulate pollution by 2024, using 2017 as the base year.

The revised target is a 40 per cent reduction

by 2026, with 2019-20 as the base year. The programme covers 131 non-attainment cities, which consistently failed to meet the prescribed national ambient air quality stan-

dards between 2011 and 2015. "As of 2022, pollution in districts with nonattainment cities has declined by 18.8 per cent relative to 2017, adding 10.8 months to the life expectancy of 446.7 million residents of these districts and four months to India's national

average life expectancy," the report said. If India meets the NCAP target, residents in non-attainment areas could see their life expectancy increase by two years compared to 2017. India's national average life expectancy would also increase by an additional 7.8 months as a result, it said.

The EPIC team emphasised that in India, where the annual PM2.5 standard is 40 micrograms per cubic metre, more than 40 per cent of the population breathes air that exceeds this standard.

However, India is responding by implementing innovative policies. In 2019, Gujarat launched the world's first market for particulate pollution, which has since reduced pollution by 20-30 per cent in Surat and is rapidly expanding to other cities and states.

These types of innovative policies demonstrate that it is possible to achieve improvements in air quality and people's health, without unduly impeding economic growth, the researchers said.

The report also praised India's clean cooking programme, the Pradhan Mantri Ujjwala Yojana, saying that the decline in emissions from the residential sector in India can largely be attributed to the nationwide rollout of this scheme. (PTI)

WOMEN ACTORS SEEKING DIRECTORS WHO DON'T PLACE THEM AS DOLLS, SAYS MALAVIKA MOHANAN

MUMBAI, Aug 28: When she was approached for "Thangalaan", actor Malavika Mohanan says she knew little about the story but what got her on board was Pa Ranjith's credibility as a director who writes strong roles for women.

Playing Aarathi, a fiery and gifted woman who comes to blows with Vikram's Thangalaan in the Tamil period drama, was one such opportunity for the actor who wanted to "break out" of portraying one-note

"Thangalaan", slated to be released in north India in Hindi on September 6, is set in the backdrop of Kolar Gold Fields (KGF) of Karnataka and based on real-life incidents in the 18th and 19th centuries.

"Initially, when they approached me for the film, I knew about the project, and not really about the story and script, I knew that it was a Pa Ranjith and Vikram film. I was well aware of the fact that he is one of the filmmakers who writes very strong roles for women. "He is such a prolific filmmaker. As women, we are also seeking those few makers who don't place us just as dolls in scenes, I've done a few of those films in the recent past. I wanted to break out of this clutter and work with makers who do the opposite of that. I was very keen from the get-go before I knew about the story or the script," Malavika

told PTI in an interview here.

The actor, known for films such as "Beyond the Clouds", "Petta", and "Master", said the process of bringing Aarathi to life involved a considerable amount of on-the-spot improvisation and intense preparation.

"When I read the story, there were a lot of mixed emotions because I didn't have a point of reference for a character like that in Indian cinema. There was a lot of curiosity about how he (Ranjith) would bring Aarathi to life, how she was going to look, and how she was going to be.

"Like, I would do something and he would be like, 'Don't do this, do this, don't scream like that, scream like this, open up a lot more, be a lot wilder'. He had to systemically break down my body language from being feminine, dainty and being more ferocious and wilder. It was a long and challenging process, unlike anything that I've ever done," she added.

WAS ADVISED NOT TO DO SMALL ROLES INITIALLY: RASIKA DUGAL

NEW DELHI, Aug 28: When you are just trying to find your ground in the film industry, you take up any and every role that comes your way, says actor Rasika Dugal, who remembers being advised not to play smaller parts in her early

The Jamshedpur-born actor, who made her feature film debut with 2007's "Anwar", is one of the most recognisable faces in the streaming space today thanks to web series such as "Mirzapur", "Delhi Crime", and "Out of Love".

Dugal, a postgraduate from Pune's Film and Television Institute of India (FTII), said it took her time, but she charted her own path.

"When I came to Bombay, I wouldn't say I had one particular kind of role in mind because you can't come with a set idea, especially because you are just starting out. I pretty much did whatever came my way. At that time, I was advised not to do small roles, do only big parts.

"But I said, 'Listen, I don't

know how else to introduce myself to people, except through my work. So if I'm getting smaller parts in the beginning of my career, I'll take them. Thanks for the advice, but I'll make this my own journey. I'll play it my



own way.' So that's what I did. I got bigger parts after that, it took some time but it happened," the actor told PTI in an interview.

"transforming" her career.
"I had an opportunity to do so many kinds of roles. In 2018, I had four releases, which was the beginning of a good phase in my career. There was 'Manto' (in which she played Safia Manto) and shortly after that, there was Beena Tripathi in 'Mirzapur', which was completely different from that. Then, there was Neeti Singh, who is a cop, in 'Delhi Crime'," she added.

While she is all for the "captive sort of viewing" experience one gets in a cinema hall, the 39-year-old said streamers offer convenient access to the audience.

"This kind of viewing is I think more in sync with the kind of lives we lead these days because people are always strapped for time. This is something that naturally has happened because of the way we live these days and there is a certain kind of accessibility to it (OTT), which is nice.

"But I also romanticise the other captive sort of viewing, which is the theatrical viewing where there's no noise, there's no disturbance, you are in a dark space and watching it with other people. Asked about the trolling he faced on social media after appearing in the first season, the actor, who is one of the first people of colour to portray an elf in


the Tolkien universe, said "racism is illogical" and the best response to it would be to live one's life as fully as possible.



NEW YORK, Aug 28: A year ago, still on maternity leave and still unsure when she would play elite tennis again, Naomi Osaka visited the U.S. Open to appear with Michael Phelps for a discussion about mental health. While at the site, she sat in the stands to watch one of Coco Gauff's matches.

Osaka also already was thinking about being back on a court at Flushing Meadows, so much so that she was pondering what she might want to wear to compete. And there she was Tuesday at Louis Armstrong Stadium, overpowering No. 10 seed Jelena Ostapenko 6-3, 6-2 while decked out, from her visor to her dress to the bows on her back and attached to her shoes, in lime green — the color of this "Brat" summer, as it happens (IYKYK) — and playing very much like a two-time champion at the place and a former No. 1-ranked star.

"I feel like being able to be a part of (designing) my tennis outfits gives me, I would say, a different strength, especially the U.S. Open outfits. I feel like they are a little bit more flamboyant. When I was putting on my outfit today, I was, like, Ah, I hope this isn't too much," Osaka said with a smile. "Because I had the tutu, and then I had the bow jacket and it was green. I feel like everyone was staring at me.

Another player asked for a photo, Osaka said, adding: "I hope it was a positive picture (and) it wasn't, like, Oh, my God, look at her.' For me, when I put on the outfit, it's almost like a super suit, so I try to channel that.'

Did that well enough Tuesday to register her first victory against a Open champion Sofia Kenin beat



top-10 opponent in more than four years. Osaka claimed titles in New York in 2018 and 2020, along with a pair of trophies at the Australian Open in 2019 and 2021, and her matchup against 2017 French champion Ostapenko marked the first time two past major champs faced off in the opening round at the U.S. Open since Serena Williams defeated Maria Sharapova five years ago. Another such contest came Tuesday night, when 2020 Australian

2021 U.S. Open winner Emma Raducanu 6-1, 3-6, 6-4. "Having two wins here means a lot, and I think for me, I've been struggling with confidence throughout the year," said Osaka, who returned to action at the Australian Open in January, her first Grand Slam appearance in nearly 1 1/2 years because of mental health breaks and time away to have a baby. "This time now forces me to look in the mirror and say, Hey, you've done really well here. There's no reason why you can't do well again."

How's this for doing well? Osaka did not make a single unforced error in the first set and finished with only five, 16 fewer than Ostapenko.

"I do remember thinking, I need to win this match so I can wear my other color.' That was very important to me," said Osaka, who is ranked 88th and received a wildcard invitation from the U.S. Tennis Association. "I guess you'll see my other color next time.

NEW DELHI, Aug 28: Krishan Harmanpreet Singh, Jugraj Singh Bahadur Pathak, on expected lines, was on Wednesday named the main goalkeeper after the retirement of PR Sreejesh in the Harmanpreet Singh-led 18-member Indian team for the upcoming Asian Champions Trophy.

The tournament will see defending champions India vie for top alongside Malaysia, Pakistan, Japan and hosts China at Hulunbuir from September 8-17.

Sreejesh announced his retirement after India won a second successive Olympic bronze medal in Paris earlier this month.

Pathak, who was India's standby goalkeeper at the Paris Olympics and in many tournaments prior to that, will now be the man in charge at the post, while Suraj Karkera will be the reserve custodian.

Experienced midfielder Vivek Sagar Prasad has been made the vice-captain in place of Hardik Singh who has been rested along with Mandeep Singh, Lalit Upadhyay, Shamsher Singh and Gurjant

The tournament will also be a big opportunity for India's promising drag-flicker Jugraj Singh who travelled to Paris Olympics as standby and will look to prove his credentials alongside the brilliant Harmanpreet.

A power-packed drag-flicker, Jugraj has proven his worth in the limited opportunities he got in the Pro League, and it will be up to him to cement his place in the side. Araijeet Singh Hundal is the third drag-flicker in the team.

The defence will be manned by Jarmanpreet Singh, Amit Rohidas, Sanjay and Sumit.

Rai Kumar Pal, Nilakanta Sharma, Manpreet Singh, and Mohammed Raheel will form the midfield, while a young forwardline featuring Abhishek, Sukhjeet Singh, Hundal, junior India captain Uttam Singh, and debutant Gurjot Singh will lead the attack.

Ten players from the Paris Olympics bronze medal-winning squad are part of this team.

Hospital Albert Einstein in Sao Paulo said in a statement that the Nacional defender died at 9:38 p.m. local time following "cardiorespiratory arrest associated

with his cardiac arrhythmia." Izquierdo was taken to the hospital after he collapsed shortly before fulltime in a Copa Libertadores soccer match at Sao Paulo's Morumbi Stadium last Thursday.

The Uruguayan club posted a statement on social media saying Izquierdo's death is felt "in deep pain and impact in our hearts" and "all Nacional is in grief for his irreplaceable loss.

South American soccer's governing body also posted a tribute. CONMEBOL president Alejandro Domínguez said he's "deeply sorry about the early departure of Juan Izquierdo.

"South American soccer in in mourning," he said. Other federations, including Uruguay, Brazil and Argentina, also expressed their condolences.

In a statement Monday, doctors at the hospital said Izquierdo was put into neurological critical care because of increased intracranial pressure. He had been on a ventilator since Sunday.

Uruguayan media Izquierdo's parents and Nacional executives were at the hospital in Sao Paulo. Izquierdo was married and had two children — the youngest, a boy, was born earlier in August.

Uruguay's first- and second-division soccer leagues were postponed last weekend due to concerns over Izquierdo's health. Sao Paulo players wore a shirt in support of the Uruguayan footballer before the team's 2-1 Brazilian league win against Vitoria on Sunday.

The Brazilian club also posted a message after Izquierdo's death. "We had days of prayers, union and hope, and today we are in deep sadness with the news of the death of Juan Izquierdo," Sao

Paulo's club statement said. (AP)

New Champions League format promises more of almost everything storied clubs wanted from UEFA

GENEVA, Aug 28: The new Champions League format this season will see more teams playing more games for more prize money. On Thursday, UEFA makes the draw in Monaco for the match schedule of the new singlestandings league phase that re-

places the traditional group stage. The first new Champions League format since 2003 promises more of almost everything that Europe's wealthiest and most influential clubs wanted from UEFA. There are four more places in a 36-team lineup; at least eight games each instead of six; Champions League games scheduled in January for the first time; a prize money rise of at least 25% to a minimum 2.5 billion euros (\$2.8 billion).

There also was more evidence, at UEFA's European Championship this summer, that constant expansion of international competitions is leaving players tired and unable to perform at their best

year-round. The new league phase in European club soccer's marquee event will have 144 total games compared to 96 in the group stage last

The "key aims," UEFA said. is to "improve competitive balance and sporting interest and in the process increase the number of meaningful matches — matches with something at stake for both sides — throughout the competition." In the eighth and final round, all 36 teams play on the same Jan. 29 evening to finalize the standings which will decide which eight teams advance directly to the round of 16 — and with what seedings in a tennis-like knockout bracket — as well as which 16 go into a new knockout playoff round in February, and which 12 are eliminated.

"We simulated that qualification should be possible with an average of 7.6 points, which means two victories and two draws," said UEFA's head of competitions strategy, Stéphane Anselmo.

Why change such a successful competition? Money, mostly, though that's

not the only reason. The Champions League in Europe has for the past 32 years showcased the highest quality play in world soccer. It let UEFA steer billions of euros (dollars) of

prize money to clubs who pay the highest transfer fees and salaries. Still, influential officials at the European Club Association (ECA) got bored of the group stage, saying it was too repetitive and lacked drama. They wanted more games against stronger opponents that would be more valued by broadcasters, viewers and

new fans worldwide. Their lever-

age over UEFA was potentially launching their own breakaway competition

The road to agreeing the format was rocky. A controversial first proposal in 2019, favoring storied clubs, was stopped by a backlash from mid-ranked clubs and domestic leagues.

There was intense turmoil sparked by the failed Super League launch in April 2021 by most of the same club officials who negotiated Champions League reform with UEFA.

May 2022 — when Real Madrid, Barcelona and Juventus were exiled from the talks and still pursued UEFA in court — and it was broadly what the rebel Super League clubs had negotiated. What is the new format?

Out goes the group-stage format played for 21 seasons where 32 teams were put into eight groups of four teams from a seeded draw. The top two in each group advanced to the round of 16. Groups gave each team six games from September into December, playing each rival once at home and once away.

In comes a single-standings league — 36 teams each playing eight games against eight different opponents through January.

The top eight in the standings go direct to the round of 16 in March. Teams ranked ninth to 24th go into the knockout playoffs in February. The bottom 12 teams are eliminated.

In the playoffs, teams ranked Nos. 9-16 are seeded in the draw to play second legs at home against unseeded teams Nos. 17-

Final format approval came in 24. Who gets the four extra places? Two for countries whose teams

> collectively had the best record in UEFA club competitions in the previous season. That was Italy and Germany so the fifth-placed teams in Serie A and the Bundesliga qualified: Bologna and Borussia Dortmund.

The fifth-ranked national league (based on five years of results in UEFA club competitions) gets a third direct entry. That is currently France and Brest was third in Ligue 1.

An extra place goes to the qualifying rounds path for national champions from lower-ranked countries. They now play for five total qualifying places instead of four last season.

How will the draw be done? The 36 teams come out of four seeding pots graded by each team's "UEFA club coefficient" – its ranking by results in five years of European competitions. The top-seeded pot contains recent Champions League winners and beaten finalists, plus Leipzig and Barcelona. (AP)

Shah said he would also like to work towards setting up a separate program for talent search. He emphasised on lifting the standard of the game across the globe.

"I want to assure you that I will do everything possible to elevate the standard of our game across



the globe. As I step into this pivotal role, I am resolutely committed to meeting your high expectations and dedicating myself to the beautiful game of

cricket," he said. Shah, who is the son of union home minister Amit Shah, will relinquish his position as the BCCI secretary at the board's Annual General Meeting likely to be held towards the end of next month or in October.

Shah became the fifth Indian after the late Jagmohan Dalmiya, Sharad Pawar, N Srinivasan and Shashank Manohar to be elected for the high-profile job.

'KL Rahul an integral part of LSG, but lot of time left to decide on captaincy and retention'

KOLKATA, Aug 28: Lucknow Super Giants owner Sanjiv Goenka on Wednesday called KL Rahul "an integral part of the franchise" amid speculations around his future in the team but remained evasive on player

retention and captaincy for next IPL season. Goenka's animated discussion with Rahul after a heavy defeat against Sunrisers Hyderabad had become one of the talking points of last season's IPL.

On Monday, Rahul met the team owner in Kolkata and expressed his wish to remain in the team, months after the video of the discussion between the two sparked speculations on whether the elegant India batter would want to continue his stint at the franchise.

"Look, I've been meeting KL regularly over last three years. I'm a little surprised this meeting got so much attention. As I've said we have not taken any call till the retention rules are out," Goenka told reporters while unveiling Zaheer Khan as their team mentor.

"But KL has been an integral and important part of the LSG family since inception. He's played a very important role. He's like family and will be family.'

When asked about player retention and captaincy, Goenka said they are yet to arrive at a decision and are waiting for the BCCI to release the rules regarding re-

"We have all of September, October and November to decide that. Let the policies be out. We have not even thought about the team going forward, whether retention will be three-four-five or six, we have no clue," Goenka said.

"Let us see, there is enough time, so bit by bit. Whatever decisions we take today will impact us for the medium term future, so it has to be very well thought out and considered.

"There is enough time for it so it's too early. Let the BCCI announce the policy first, then there will be dis-



cussions." Asked whether they are going to press the "reset mode" under the newly-appointed mentor Zaheer, he said: "You always try and improve and that is a constant endeavour. When you have a mega auction, there is bound to be a reset but you want to retain the core as much as possible you can. Let's see how it goes.

"One doesn't know which way what goes. Certainly the coach (Justin Langer) continues. Lance Kluesener (assistant coach), Jonty Rhodes (fielding coach) also continue. We are delighted for Morne Morkel and Gautam Gambhir, very pleased they have joined the national team," Goenka said.

"Being enthusiastic and having the drive to do something good for cricket are essential qualities for a cricket administrator. @JayShah displayed these traits wonderfully during his stint as @BCCI secretary," Tendulkar wrote on X.

"His endeavours towards prioritising both women's cricket and men's cricket have made the BCCI a pioneer that other boards can follow. I wish him the very best of luck towards the next phase of his journey, as he becomes the youngest chairman of the @ICC," he said. Shah will be the fifth Indian to head the ICC and Tendulkar hoped that he would be able to carry the legacy forward.

"India has sent several luminaries to lead the ICC as administrators: Mr. Jagmohan Dalmiya, Mr. Sharad Pawar, Mr. N. Srinivasan, and Mr. Shashank Manohar. I am sure he will build on their legacy and take the game of cricket forward," he added.

Former India skipper Sourav Ganguly, who was the BCCI president during Shah's first term wrote, "Congratulations to Jay Shah @JayShah on his new role as ICC chair.. wish him a great journey ahead .." (sic)
