GUWAHATI, Aug 30: The Assam government's outstanding debt increased by over 107 per cent from 2018-19 to 2022-23 with the growth rate of outstanding liability also rising during the period, a Comptroller and Auditor General (CAG) report said on Friday.

The report for the 2022-23 fiscal, which was tabled in the assembly, noted that the capital expenditure by the state government decreased by over 20 per cent in FY'23 as compared to 2021-22.

The outstanding debt of the state "rapidly increased by 107.34 per cent from ₹ 59,425.61 crore in 2018-19 to ₹ 1,23,214.80 crore in 2022-23", the report said, adding that the growth rate of outstanding liability also increased from 20.60 per cent in 2018-19 to 23.32 per cent in 2022-23.

The outstanding liabilities-GSDP ratio also rose from 19.21 per cent in 2018-19 to 24.98 per

ing at the end of 2022-23. During the year, it grew by 26.15 per cent, the second highest

in the last five-year period, accord-The average growth rate of pub-

lic debt at 23.92 per cent also outpaced that of GSDP (11.91 per cent) during the year. "These all indicate that there would be increased pressure on interest payment on public debt in the forthcoming years,"

the report added. The auditor said capital expenditure, which is incurred for creation of fixed infrastructure assets such as roads and buildings, decreased by 20.51 per cent from ₹ 20,125.83 crore in 2021-22 to ₹ 15,999.71 crore in 2022-23.

Revenue expenditure in 2022-23 was ₹ 1,01,814.65 crore, constituting 84.88 per cent of the total expenditure of ₹ 1,19,952.20 crore, the report said.

There was a misclassification of ₹ 6,668.99 crore as grants-in-aid given by the state government to different bodies or individual entities were classified as capital expenditure instead of revenue expenditure, resulting in an overstatement of capex.

Committed expenditure of the government, like salary, pensions and interest payments, also increased steadily by ₹ 16,548.72 crore during the five years of 2018-23. The Gross State Domestic Product (GSDP), however, grew from ₹ 3.09 lakh crore in 2018-19 to ₹ 4.93 lakh crore in 2022-23, with a (CONTD. ON PAGE-2)

GUWAHATI, Aug 30: The Numaligarh Refinery Limited (NRL) has recorded a revenue earning of ₹23,731 crore and a net profit of ₹ 2,160 crore during the financial vear 2023-24, chairman Ranjit Rath said here on Friday.

'The financial year ended on a positive note despite loss of operations during the first quarter of the financial year 2023-24 on account of planned refinery shutdown and an unforeseen fire incident', Rath said at a press conference after NRL's 31st annual general meeting held here.

NRL bounced back after the initial setback and a final dividend of ₹ 258.42 crore for the financial year was declared during the AGM, he said. The company has already paid an interim dividend of ₹ 452.24 crore with the total dividend pay-out for the year being ₹ 710.66 crore, representing 32.90 per cent of NRL's Profit After Tax (PAT) for the year.

The refinery processed 2,510 TMT of crude oil, equivalent to 100 per cent capacity utilisation for 10 months and during the year, the company's net worth soared to ₹ 13,926 crore, he said.

Asked about the impact of the Bangladesh situation on the movement of the refinery products to the neighbouring country, Rath said there has been no difference with the pipelines functioning normally



and products moving normally. The refinery continued to show impressive performance with respect to Specific Energy Consumption (SEC) and Energy Intensity Index (EII), pointers that determine energy-efficient operations.

The company continued to contribute significantly to the central and state exchequer in the form of taxes, duties and dividends, with a contribution of ₹ 3,819 crore extended during the financial year. The total product sales during

the year was 2,720 TMT. NRL's LPG bottling plant recorded the highest-ever capacity utilisation of 68 TMT during the year against an installed capacity of 42 TMT. NRL remains the market leader in the country with regard to wax production and sales.

### VHP welcomes law mandating registration of marriage, divorce of Muslims in Assam

NEW DELHI, Aug 30: The Vishva Hindu Parishad on Friday hailed the passage of a bill in Assam assembly, which provides for compulsory government registration of marriage and divorce of Muslims, saying other states should also follow the suit for empowerment of women belonging to the minority community.

VHP national spokesperson Vinod Bansal said the enactment of the law will empower Muslim women and check atrocities against them. It will also end child marriage, he said. "Other states should also follow

the suit for empowerment of women," he said in a post on X. The Assam Assembly had on Thursday passed a bill for compulsory government registration of marriage and divorce of Muslim people. The Assam Compulsory Registration of Muslim Marriages and Di-

vorces Bill, 2024, was introduced in the state assembly by Revenue and Disaster Management Minister Jogen Mohan on Tuesday. While replying to queries, Chief Minister Himanta Biswa Sarma said all earlier registrations of marriages conducted by Kazis will remain valid

and only new ones will come under the purview of the legislation. "We are not interfering with the marriages solemnised by Islamic rituals under Muslim Personnel Law at all. Our only condition is that Islam

prohibited marriages will not be registered," he added. Sarma said with the enactment of this new law, child marriage registration will be completely banned. In the Statement of Object and Reason, it has been said that the bill has been proposed for prevention of child marriages and marriages without consent of both parties. It will help check polygamy, enable married women (CONTD. ON PAGE-2)

# Cong questions PM Modi's global peace focus while ignoring Manipur

NEW DELHI, Aug 30: The Congress on Friday wondered why Prime Minister Narendra Modi can't be the peacemaker by visiting violence-hit Manipur when he is going "all over the world" trying to

Congress general secretary incharge communications Jairam Ramesh also asserted that Manipur chief minister N Biren Singh has "lost all credibility" and things cannot improve under him.

Ramesh's remarks came in response to Biren Singh's interview to PTI in which the chief minister has promised to fully restore peace in the state in six months with the Centre's help, and also ruled out stepping down, saying he has neither committed a crime nor spawned a scandal.

In his remarks, Singh said, "PM coming or not coming has been made an issue by people. The PM may not have come but he has sent his home minister. And PM has so often spoken about Manipur, even from Lal Oila on Independence Day...and whatever is being done here in terms of security, funding etc, is under his leadership only. In a complex situation a PM coming was not necessary."

Reacting to the remarks, Ramesh told PTI, "The people of Manipur want the prime minister to come to the state and the prime



minister has not gone. It is an extraordinary situation, he has gone all over the world but he has not found to go to Manipur even for a few hours. What the chief minister is saying about the PM is unacceptable, it is indefensible what he has

Ramesh said almost 16 months have gone by and there has been no peace, no harmony, no reconciliation, no semblance of normalcy in Manipur

"The Supreme Court actually called it a breakdown of constitutional machinery. So I don't know which world the chief minister is living in?" Ramesh said.

He claimed that the chief minister has "lost all credibility". There have been revelations and audio recordings of what the chief minister has said which needs to be investigated, (CONTD. ON PAGE-2)



# Sensex, Nifty extend gains to scale fresh peaks on firm global cues

Nifty marched higher to scale fresh lifetime closing peaks on Friday, tracking a largely firm trend in global markets and renewed foreign fund inflows amid the US rate cut hopes gathering momentum.

Rallying for the ninth straight session, the 30-share BSE Sensex climbed 231.16 points or 0.28 per cent to settle at an all-time closing high of 82,365.77. During the day, it jumped 502.42 points or 0.61 per cent to hit a record intra-day peak of 82,637.03. A total of 2,228 stocks advanced, while 1,701 declined and 116 remained unchanged on the BSE.

In its best winning streak since its launch in 1996, the NSE Nifty soared 83.95 points or 0.33 per cent to hit a new lifetime closing high of 25,235.90, taking its victorious run to the 12th day in a row. During the day, it surged 116.4 points or 0.46 per cent to hit a new record intra-day peak of 25,268.35.

"Global markets are...resonating with the US Fed's pledges of a rate cut in September. The US and Indian markets have regained the recent highs, reflecting the continuation of this optimism," said Vinod Nair, Head of Research, Geojit Financial Services. On the weekly front, the BSE benchmark jumped 1,279.56 points or 1.57 per cent, and the Nifty soared 412.75 points or 1.66 per cent.

"India's UPI has become a major example of fintech in the world," he said, adding that it has enabled 24X7 banking services in every village and city in all weather conditions.

Underlining the role of fintech in democratising financial services, the Prime Minister gave examples of readily available loans, credit cards, investments and insurance.

He said that fintech has made access to credit easy and inclusive, and gave the example of PM SVANidhi scheme that has enabled street vendors to avail collateral-free loans and further expand their business with the help of digital transactions.

"Sustainable economic growth is India's priority today," he said and emphasised that the government is creating robust, transparent and efficient systems to strengthen financial markets with advanced technologies and regulatory frameworks.

### GDP growth slows to 15-month low of 6.7 pc in Apr-Jun

NEW DELHI, Aug 30: India's economic growth slowed to a 15-month low of 6.7 per cent in April-June 2024-25, mainly due to poor performance of the agriculture and services sectors, government data showed on Friday. The gross domestic product (GDP) expanded by 8.2 per cent in the April-June quarter of 2022-23. India, however, remained the fastest-growing major economy, as China posted a 4.7 per cent growth in April-June 2024. The previous low of 6.2 per cent was recorded in the January-March quarter of 2023. "India's GDP growth expectedly slowed down in Q1 FY2025 relative to Q4 FY2024 (to a fivequarter low of 6.7 per cent from 7.8 per cent), even as the GVA growth surprisingly accelerated between these quarters (to 6.8 per cent from 6.3 per cent). "This divergent trend was led by the normalisation of the growth in net indirect taxes, and the slowdown in the GDP growth is not a cause for alarm, in our view," said Icra Chief Economist, Head - Research & Out-

According to the National Statistical Office (NSO) data, the agriculture sector gross value added (GVA) growth decelerated to 2 per cent from 3.7 per cent in the April-June quarter of 2023-24.

The expansion in 'financial, real estate and professional services' GVA too slowed to 7.1 per cent from 12.6 per cent in the year-ago quarter.

However, the GVA in the manufacturing sector accelerated to 7 per cent in the first quarter of the current fiscal compared to 5 per cent a year ago, "Real GDP or GDP at Constant Prices in Q1 of 2024-25 is estimated at ₹43.64 lakh crore against ₹ 40.91 lakh crore in Q1 of 2023-24, showing a growth rate of 6.7 per cent," NSO said in a statement. It further stated that nominal GDP or GDP at current prices in Q1 of 2024-25 is estimated at ₹ 77.31 lakh crore against ₹ 70.50 lakh crore in Q1 of 2023-24, showing a growth rate of 9.7 per cent. Sukhu had announced on Thursday that he, his ministers, chief parliamentary secretaries and chairpersons and vice-chairpersons of boards and corporations would defer drawing their salaries and allowances for two months, citing the state's "grim financial situation"

The chief minister made the announcement in the assembly and also urged other members of the House to follow suit. "Among the nine hill states, Himachal Pradesh is worst affected by economic distress. Wherever the Congress goes, it brings misery along with it. "Rahul Gandhi used to say that money will be swiftly credited to people's accounts. Money did not come swiftly, though the bankruptcy came in quickly," Shukla said.

The BJP leader also condemned Telangana chief minister A Revanth Reddy's remarks on grant of bail to BRS leader K Kavitha by the Supreme court in cases linked to alleged Delhi excise policy scam and demanded that the Congress apologise to "all constitutional bodies" for insulting them.

In an interaction with mediapersons, Reddy had on Tuesday said there are doubts over MLC Kavitha getting bail in five months when Manish Sisodia got it after 15 months and Kejriwal is yet to get it.

"It is a fact that BRS worked for the victory of the BJP in the 2024 LS polls. There is also talk that Kavitha got bail because of the deal between BRS and BJP," he had alleged. Ramesh said. "I don't see on what strength the CM is claiming normalcy. This is absolutely contrary to the facts on the ground," he said.

The Congress leader said 15 months after getting a huge majority in the assembly elections, the state began burning and "it was made to blow up". "This is not accidental what has happened. The fact of the matter is that the prime minister has gone to Ukraine, the prime minister has gone to Russia, he has gone to Poland, he has gone all over the country, he has gone to other countries of the world but he has neither found the time nor the inclination to visit Manipur even for a few hours," Ramesh said.

"He is the PM of the country and Manipur is an exceedingly important and strategic state of our country and this is the way he deals with Manipur," he said. Ramesh said Modi has not met Singh and asked whether the chief minister can say that he has had a one-on-one meeting with the prime minister in New Delhi.

"Has the PM met the elected representatives of Manipur, he has not. The answer that the people of Manipur gave to all these bogus claims being made by the CM is the fact that in both Inner Manipur and Outer Manipur, the Congress has won and the BJP has lost (in the Lok Sabha polls) and they have lost by a good margin," he said. "I think the prime minister must go to Manipur. That is the most important requirement. The prime minister must go and begin the process of sending the healing touch, the process of reconciliation," he said.

Ramesh said it is not enough to speak for a few minutes in Parliament or outside and the prime minister must visit the state. Modi has to show he means business, he has to reassure all communities of Manipur -- the Meiteis, the Kukis, the Nagas and all the tribal communities, he added. Modi has to show that the agony of Manipur is the agony of India, Ramesh said.

"The non-biological PM is going all over the world trying to be the peacemaker, why can't he be the peacemaker by going to Manipur," he said. He said that one consequence of the PM not being able to go to Manipur is that he is not being able to go to Mizoram. "He (Modi) had to go to Mizoram for an election rally which had to be cancelled because the BJP thought that this would invite negative comments because he would have gone to Mizoram and not to Manipur," the Congress leader claimed.

"The prime minister goes to Tripura, he goes to Assam but he has neither the time nor the inclination to go to Manipur. It is complete neglect on the part of the PM. I hold the PM singularly responsible," Ramesh said. "Ukraine is not complex? Russia is not complex? And the non-biological PM has found time to go there. Of course, the situation is complex but six autonomous district councils in Manipur, last time the elections for them were held in 2015. Why aren't elections being held to the ADCs in Manipur. Why is the CM constantly defensive?" he said. Going forwad, Ramesh said the Congress wants peace, reconciliation and harmony in the state. # Tribal organisations protest in Margherita demanding justice for murdered student

MARGHERITA, Aug 30: Over 20 indigenous tribal organisations from the Margherita sub-division have been holding a sit-in demonstration at North Margherita Rangamancha from August 29 to 31, demanding justice for Gamrin Maket, a class 10 student from St Paul School, 4th Mile, Udaipur, who was brutally murdered and later hanged at the hostel verandah on August 1. The sit-in demonstration was organ-

ised by the Singpho National Council and the All Singpho Students Union, in collaboration with several other organisations, including the All Assam Sonowal Kachari Students Union, All Assam Mech Kachari Students Union Tangsa Students Union, All Assam Tribal Sangha Margherita Regional Committee, Satra Mukti Sangram Samity, All Assam Man Tai Speaking Students Union, Tirap Autonomous District Council Demand Committee, Pan Singpho Students Union, Asomiya Yuba Mancha, Margherita Regional Students Union, All Tai Ahom Students Union, and Tai Ahom Yuba Parishad Asom Margherita Sub-Divisional Committee. More than 300 people gathered at North Margherita Rangamancha to seek justice for Gamrin Maket.

Jawong Gam Gudung, general secretary of the Pan Singpho Students Union Central Committee, expressed his deep sorrow over the incident, stating that it is tragic that an indigenous and meritorious Singpho student, Gamrin Maket. All Rabha Students Union, All Assam who was studying in class 10 at St Paul due to the negligence of police officers, School, 4th Mile, Udaipur, under the

sukia district, was found hanging at the hostel verandah on August 1, just one day after his parents had left him at the hostel on July 31.

Gudung asserted that Gamrin Maket's death was a premeditated murder and demanded an impartial CBI inquiry into the case, as well as compensation of Rs 1 crore for the deceased's family.

Sengram Lebram and Amio Ningda, the president and general secretary of the Singpho National Council, respectively, echoed Gudung's sentiments. They stated that following the brutal murder of Gamrin Maket, the organisation has conducted a series of protests at various locations under the Margherita sub-division. On Friday, they submitted a memorandum to chief minister Himanta Biswa Sarma through the Tinsukia district commissioner, demanding a high-level judicial inquiry led by a retired Guwahati High Court judge to ensure a fair investigation and punishment for the culprits under strict

They also called for a forensic examination of the entire body, as they suspect the post-mortem report is flawed and may have been influenced by powerful individuals to weaken the case. 
# Dibrugarh University hosts lecture on 'Global' Trends in Higher Education & NEP 2020'

#### What lies ahead in Manipur?

anipur's recent history has been marked by deep ethnic tensions between the Meiteis and the Kuki-Zo tribal communities, with conflict erupting on May 3, 2023, over the issue of tribal status for the majority Meitei community. Though violence has subsided in recent weeks, the situation remains precarious, and the path to peace is far from assured. Prime Minister Narendra Modi's recent statement in the Rajya Sabha, where he suggested that "hope for peace" is visible in Manipur, has been met with scepticism from the Opposition and many on the ground. The visible absence of a functioning civil administration and the continued reliance on extraordinary security measures underscore the fragility of the current calm. Thousands of displaced people still languish in relief camps, unable to return to their homes due to fears for their safety.

Complicating matters further is the political landscape in Manipur. Chief Minister N Biren Singh, once a strong figure, now finds himself in a weakened position. The BJP's central leadership, while still backing him, seems to be doing so more out of necessity than conviction. Singh's political fortunes have been tied to the influence of Assam Chief Minister Himanta Biswa Sarma, a key player in the BJP's North-East strategy. However, the recent loss of both of Manipur's Lok Sabha seats to the Congress indicates a growing discontent with the state's leadership. Despite this, Singh remains indispensable due to the lack of a viable alternative, a situation that places him in a precarious position within his party. At the national level, Union Home Minister Amit Shah appears to be increasingly involved in managing Manipur's affairs, further limiting Singh's authority. The political dynamics within the state are also complicated by the ongoing issues with Myanmar, whose internal instability continues to exacerbate cross-border tensions and illegal migration into Manipur. The Suspension of Operation (SoO) agreement, originally signed in 2008 between the government and 25 armed Kuki groups, was intended to facilitate peace and dialogue. However, the agreement has failed to achieve its objectives, and the state government, with the backing of the Manipur State Assembly, has been pushing for its termination. The decision to withdraw from the SoO agreement with two insurgent groups in March 2023, citing their involvement in illegal activities, marked a significant escalation in the state's approach to handling the conflict.

Recent developments, including the visit of Chief of the Army Staff General Upendra Dwivedi to Manipur, have fuelled speculation that the central government may be considering the state's demands. General Dwivedi's discussions with the chief minister, coupled with his planned (though weather-impacted) visits to conflict-affected areas, suggest that the Centre is taking these demands seriously. However, the potential termination of the SoO agreement raises concerns about the resurgence of violence, particularly from the insurgent groups that were part of the accord. If the SoO is indeed terminated, it may necessitate a renewed military presence in the region, further complicating the situation. While Chief Minister Singh has expressed optimism that the Centre will act on his demands, the reality is that any move to end the SoO will need to be carefully managed to avoid reigniting conflict. While the reduction in violence is a positive sign, it is far too early to declare peace in Manipur.

#### Why small businesses matter for a more resilient future

n today's parlance, when the whole world is moving at an unprecedented pace across sectors, a look back at the role of MSMEs (Micro, Small & Medium Enterprises) is crucial as they are the backbone of an economy. With artificial intelligence and Industry 5.0 in action, focus is shifting more towards upgrading the small industry and upskilling the workforce so that efficiency is at par. During the observance of MSME Day on June 27 this year, the United Nations outlined key points on MSME's role in achieving the Sustainable Development Goals (SDGs), including poverty eradication and mitigating crises.

The UN considers MSMEs as the closest sector to local communities, and hence brimming with scope to provide local employment. With collective efforts, they also have the strength to pan out critical pathways to development, they observe. The COVID pandemic enhanced the need for empowering local communities through MSMEs to a greater extent, as the world real-

ized the fragility of our systems. In India, the growth of MSMEs is even more significant than in a global context, as a greater portion of our economy relies on it. Whereas, globally, the sector covers around 90 percent of all businesses, for India, it contributes to 30% of Gross Domestic Product (GDP) and over 45% in exports.Recent statistics suggest a projected growth stride to \$1 trillion by 2028 for MSMEs in India, with opportunities increasing across industries like agriculture, textiles, food processing etc.

In the Union Budget 2024-25, however, the MSMEs sector got a boost in terms of provisions. A package to cover the financial and technological support to MSMEs to spur their growth has been proposed. A credit guarantee scheme to facilitate term loans for machinery without provision of a collateral or thirdparty guarantee, a new assessment model for MSME credit by public sector banks, credit support to MSMEs during a stress

period, increase of Mudra loan limit from the current ₹ 10 lakh to ₹ 20 lakh, setting up of ecommerce export hubs to enable MSMEs and traditional artisans to make their mark in international markets, are some of the

key takeaways. Among the northeastern states, a boost to MSMEs is quintessential for progressive future. Although much is talked about than done and schemes get entangled in bureaucratic processes, there is a steady uprising of small businesses evident across the eight states. In Assam, jute industry, fabric and textile industry, small tea garden industry, food processing units are blossoming. Similarly, in the other states also, a pull for utilizing local produce and resources and market them to the world is fuelling progress in the

Whether it is a small café, a small homemade food business, garment designing, or pottery, entrepreneurs from North-east India are gradually creating a niche for themselves. In Assam's context, the incubation and training programmes given to early-stage startups and MSMEs under Assam Startup shall be mentioned for their efficacy. As per recent state government data, startups from Assam have managed to garner revenue of ₹ 40 crore in 3 years, with 4,900 jobs created in the process. With most of the startups in the state being from the MSME sector, a boost in the coming years can be empowering for a large section of youth

As the whole NE region faces distinct challenges for economic growth, strategic approaches at the government level as well as at the individual level are crucial to planning for a thriving economy. Although it is a positive sign that more youth are getting the hang of entrepreneurship, more budgetary allocation and hassle-free processes at the bureaucratic level shall be ensured so that a holistic ecosystem can be envisaged. # Smart meters: The new face of public discontent and protest

transformation of India's energy sector has always been a subject of intense public interest and debate. From the days when kerosene lamps and hurricane lights illuminated our homes, the country has steadily moved towards modernization, embracing new technologies in the name of progress. However, this wave of change, which was once viewed with hope, has today become a source of terror and anxiety for many, particularly in the context of the recent mandatory installation of smart meters in households across Assam and other parts of

The Arrival of Smart Meters: A Double-Edged Sword: Smart meters, hailed as the next big step in energy management, were introduced with the promise of revolutionizing the way consumers interact with electricity. These devices, which can only be recharged much like mobile phones, were intended to bring about greater efficiency in billing and energy usage monitoring. The concept, on paper, appeared sound—curbing electricity theft, reducing losses, and increasing revenue for the state. However, the reality for the common man has been far from what was promised.

Initially, many people welcomed the introduction of smart meters, seeing them as a necessary measure to ensure that those who habitually defaulted on their electricity payments would be held accountable. But as the bills began to arrive, shock and disbelief spread among consumers. Monthly bills that once stood at ₹ 70-80 per month suddenly surged to ₹ 250-300, leaving many households struggling to cope with the sudden financial burden. What was once viewed as a progressive step forward quickly became a point of contention, leading to widespread public out-

A Wave of Protests: From Social Media to the Streets: As frustration grew, people took to social media to express their dissatisfaction. Videos and images surfaced, showing angry residents tearing out and discarding smart meters in protest. The movement quickly gained momentum, and what began as isolated incidents escalated into organized demonstrations.

One of the most significant protests took place on August 27, 2024, when the Karbi Anglong District Congress Committee (KADCC) staged a rally in Diphu. Led by KADCC president Bidyasing Rongpi, the protesters marched through the main thoroughfares of the Diphu market, demanding an immediate halt to the installation of smart meters. In their memorandum to the Assam Power Distribution Company Limited (APDCL), the Congress leaders decried the smart meter initiative as a means of extorting money from the public, citing the abnormal increase in electricity bills as evidence of the system's defects.

Rongpi's sentiments were echoed by hundreds of members of the All Assam Students' Union (AASU), who took to the streets in Dibrugarh on the same day. The protesters carried a makeshift funeral pyre symbolizing APDCL and marched through the city, chanting slogans against the power company. The protest culminated in front of the district commissioner's office, where the demonstrators set fire to the pyre, an act that was both symbolic and provocative. AASU Dibrugarh unit president, Tanuj Haloi, voiced the frustrations of many, stating that the installation of prepaid digital smart meters had made life unbearable, with electricity bills soaring three to four times higher than before.

The Government's Response: A Disconnect with Public Sen**timent:** In response to the growhave repeatedly asserted that the billing rates for smart meters and traditional meters are the same. Assam's Chief Minister has assured the public that any discrepancies in billing are not the result of the smart meters themselves but rather the work of unscrupulous middlemen. Despite these assurances, the public remains unconvinced, and the protests have only intensified.

The government's insistence on the continued rollout of smart meters has led to accusations of ignoring the will of the people. In many rural areas, particularly in Assam, where agriculture is the primary livelihood, the introduction of prepaid smart meters has been met with staunch resistance. For day laborers and low-income families, the concept of near realenergy

tracking and regular bill payments is not just inconvenient but also incompre-

hensible. The fear of being plunged into darkness without warning—unable to pay for electricity in advance—has only

added to the anxiety. Furthermore, with a significant portion of rural households lacking smartphones or access to reliable internet, the task of managing prepaid smart meters becomes even more daunting. The public has repeatedly called for a return to the previous system of manual meters, where bills could be paid after consumption, ensuring that households are not left without power simply because they cannot afford to recharge their meters in time.

A Broader Political and Social Crisis: The controversy surrounding smart meters is not just a technical issue but also a reflection of broader political and social discontent. The protests have highlighted the deep-seated frustration among the populace over

ment's failure to address their needs and concerns. The smart meter issue has become a lightning rod for broader dissatisfaction with rising costs, economic inequality, and perceived government indifference.

The Congress party, seizing on the public's discontent, has positioned itself at the forefront of the opposition to smart meters, organizing rallies and submitting memorandums to the government. The party has framed the smart meter issue as part of a larger pattern of government overreach and exploitation, arguing that the initiative is just another example of how the current administration is out of touch with the needs of ordinary citi-

District Magistrate Neha Yadav cited concerns over potential violence, noting that anti-social elements might exploit public sentiments to incite unrest. The curfew, which was imposed under Section 163 of the Bharatiya Nagarik Suraksha Samhita (BNSS), reflects the seriousness of the situation and the government's growing concern over maintaining public order.

On one hand, the National Smart Meter Program is a key component of the country's broader energy sector reforms, aimed at reducing losses, increasing revenue, and improving overall efficiency. Additionally, the government must address the issue of rising electricity bills, ensuring that any increases are justified and transparent.

Moreover, the government must engage in meaningful dialogue with the public, particularly with those who have been most affected by the smart meter rollout. This includes not only addressing technical issues but also rebuilding trust between the government and the people. The current wave of protests is a clear indication that the public feels ignored and marginalized, and it is up to the government to demonstrate that it is responsive to the needs and concerns of all citizens, not just the wealthy and powerful. The smart meter controversy is a microcosm of the broader chalenges facing India today.

As the country continues to modernize, it must do so in a way that is inclusive and equitable, ensuring that the benefits of progress are shared by all. The government must strike a balance between innovation and tradition, between efficiency and fairness, and between progress and compassion. ### Tragic Nepal bus accident highlights the dangers of monsoon travel in the Himalayas

The Nepal bus accident on August 23, in which a tourist bus with 40-odd Indian tourists fell into the Marsyangdi river, killing 26 people on the spot and one at the hospital, comes across as a grim reminder of how dangerous Himalayan mountain roads can be during the monsoon. All the victims came from Jalgaon in Maharashtra and were travelling in a group of three buses. There were more than 150 people from the same village. One of these buses fell into the roaring monsoon river, killing 27 of these tourists, with one still missing after five days of the incident.

The loss of these innocent lives makes one wonder if travelling from Pokhara to Kathmandu during August, which is the peak monsoon season, was safe. Did these tourists know the full scale of risks in travelling by bus from one Himalayan tourist hotspot to another? Similar bus accidents had already claimed over a hundred lives before this accident in the ongoing monsoon season.

Surely enough, they did not know. The decision to travel to Nepal by bus during the monsoon season is never safe. Anybody living in Nepal or near the Nepal border in India knows this very well: travelling in the mountains in the rainy season is risky. People in these areas cut down on their travels and venture out only in case of unavoidable circumstances.

But these people from Jalgaon, whose knowledge of

mountains is based on their understanding of the rocky terrains of Western Ghats (the Sahyadri), which is much older and therefore more stable than the Himalayas, were unaware of the risks. It brings the discussion to the advisers and organizers of this travel.

If any company or agency makes people travel by bus through these Himalayan roads during the monsoon season, it's something that the government must look at and set safety standards for such travel.

The Himalayas and the other mountains in its vicinity are relatively very young, and their soil is loose, making them suitable for setting up orchards or agriculture farms. Nepal gets abundant rain during the monsoon, creating

over 6000 rivers. It gets so much water that half of Bihar is flooded, causing a perennial problem for Bihar and Indian rivers in this region swell up to dangerous levels. Nepal's water resources make it one of the most promising lands for hydro-electricity. Landslides and lighting are such massive problems that international institutions working on these natural occurrences have set up research

Nepal is a tourist destination, but travelling in the monsoon season should not be on your plate. The right thing to do is go to Nepal before the monsoon season and rent a house or hotel room if you want to enjoy the monsoon season there. Avoid bus travel at all costs. All these 6000 rivers flow menacingly as they go down the slope.

People in Delhi and Kolkata who have closer access to Himalayan towns and villages have a better understanding of this. But sadly, Mumbaikars and Maharashtrians don't

have the same level of understanding of the fragile and perilous Himalayan ecosystem. Taking appropriate lessons from this accident, the state governments, including Maharashtra, should prepare an

advisory for unessential travels to risky mountain areas in India and neighbouring Nepal.

As the incident involved unsuspecting people from Maharashtra, the state government should see what it can do to lessen the pain of the families who have lost their members in this accident. It's surprising that political leaders are seen fighting over statues that strong Arabian Sea winds brought down and ignore families who fell hundreds of meters into the swelling monsoon river. ## The Paris Olympics 2024 from an Indian perspective

On July 26, 2024, the Paris Olympics commenced with a grand opening ceremony. Under the supervision of the International Olympic Committee, 10,714 athletes from 206 countries will compete in 329 events across 32 sports. A total of 117 Indian athletes have qualified to represent India in the Paris Olympics 2024. Among them are 70 male athletes and 47 female athletes, who will compete for a total of 95 gold medals. India's best performance in the Olympics to date was in the Tokyo 2020 Olympics, where the country won a total of seven medals, including one gold, two silver, and four bronze. Based on this performance, it was anticipated that the Indian athletes would perform even better in the Paris Olympics 2024.

However, the performance of the Indian athletes in the Paris Olympics has not been as promising as expected. Contrary to the hopes of the nation, India was unable to secure even a single gold medal. Almost every athlete expected to

win a medal for India ended up disappointing the fans. There was a moment of hope when Indian wrestler Vinesh Phogat won her bout against her opponent, but it was short-lived. According to the Olympic Committee, she was disqualified from the competition before the final match because her weight exceeded the limit by 100 grams. As soon as this news became public, various reactions started pouring in, but despite the uproar, her disqualification was not revoked.

In badminton, fans had high expectations from PV Sindhu, in table tennis from Manika Batra and Sharath Kamal, in boxing from Nikhat Zareen, in archery from Deepika Kumari, and so on. However, despite giving their best, these athletes fell short against their competitors. Even though the Paris Olympics 2024 didn't turn out to be very promising for India, it brought some positive signs for Indian sports.

Indian shooter Manu Bhaker made history by winning two bronze medals in the Air Pistol event, becoming the first Indian athlete to win two medals in a single Olympic event. Additionally, young badminton player Lakshya Sen reached the semifinals in the men's category, an achievement no Indian male badminton player had accomplished before in the Olympics. Indian table tennis player Sreeja Akula became the first Indian to reach the pre-quarterfinals in the Olympics. Swapnil Kusale won a bronze medal in the 50m Rifle event, becoming the first Indian to win a medal in this event at the Olympics. After a gap of 52 years, the Indian hockey team defeated a strong opponent like Australia and managed to secure a medal in consecutive Olympics.

Amidst the disappointment of Vinesh Phogat's disqualification, wrestler Aman Sehrawat won a bronze medal, becoming the youngest Indian athlete to win an individual medal at the age of 21. India's "Golden Boy" Neeraj Chopra, from whom the country expected a gold medal, had to settle for silver. Thus, India was unable to win any gold medals in the Paris Olympics 2024, resulting in a lower position in the medal tally. Although In-

dian athletes were unable to win medals, their record-breaking performances in this Olympics are seen as a beacon of hope for Indian sports. Sports experts believe that these records will positively impact Indian sports in the future. If given the right training at the right time, Indian athletes have the potential to win medals in major competitions like the Olympics, as evidenced in Paris 2024. To ensure that Indian athletes perform their best in the next Olympics, training and practice should begin immediately. It is crucial that athletes are not only physically prepared to compete but also mentally strong. Every Indian sports enthusiast hopes that the positive messages from Paris 2024 will translate into medals in the next Olympics. By learning from the mistakes made this time and becoming stronger, Indian athletes can make the dreams of Indian sports fans come true without having to wait too

o you think cost is the biggest factor in pursuing undergraduate studies in USA? It depends. As an applicant to U.S. colleges you will have to walk some extra miles to fetch substantial financial assistance to full scholarship. My two decades of experience says, yes, it is possible for you to be awarded full aid. This the right time to embark on the application process for admission in Fall 2025 (September). But, you can chalk out your action plan much earlier if you are in Class IX or X.

International students have limited sources of financial aid from U.S. colleges. Two common sources are (i) Need-based and (ii) Merit-based financial aid. Depending on your family financial status and your academic strength, you need to carefully select the colleges which meet your specific expectations.

There are a few top colleges or Ivy League institutions, such as, Amherst, Dartmouth, Harvard, Yale, Princeton, and MIT, which offer Need-Blind scholarships. Students applying to these colleges will not be disadvantaged in the undergraduate application process due to their financial need. These colleges are the most competitive.

There are multiple factors in the undergraduate admission process to get into top colleges and to fetch substantial to full aid. These factors include outstanding or very good academic performance; meaningful co-curricular activities involvement; strong and effective recommendations; application essays that portray perfectly who you are; and high standardized test scores,

Dartmouth says: "As part of the holistic review, we evaluate school transcripts, test scores, letters of recommendation, essays, and other information our applicants provide about how they invest their time when they are not in

plication competitive: 1. If you are in Class IX or X, start doing some additional work beyond academics. Use your free time wisely on some community or social work. Reflect on your diary, why you do that and the social impact of your work. Keep some "action photos", NOT selfies. Maintain your social media account wisely.

If you have some unique talent – music, performing art, writing, or anything else at your age, keep records of your performance or creativity on social media. If possible, create a webpage with the help of a senior/family member. Remember that you do not need to be engaged in multiple activities. Do one or two activities you are passionate about.

Your school may play an important role in your applications. Talk to your school counsellor. Remember that you need a recommendation letter from your school counsellor and two from your teachers. Please check if your counsellor is already aware of the (i) CommonApp, (ii) Coalition, and (iii) Quest-Bridge Applications and if he or she already assisted any seniors in applying to U.S. colleges.

2. Although many colleges presently have Test-Optional admission policy, still some may need test scores of SAT or ACT. Some may change their policy in the coming years, as did Harvard, Dartmouth and others. Prepare for these tests well ahead so that you get competitive test scores. One of the English proficiency tests (IELTS/TOEFL/PTE/ DuoLingo) is mandatory. Some colleges may have higher expectations – Yale needs at least 100 in TOEFL (maximum score 120).

3. Most important task is choosing colleges. First step is to identify colleges which have: (i) Need-Based aid for students from low-income family: (ii) Merit-Based – for students who are academically strong and (iii) five Need-Blind colleges, highly competitive, for outstanding

## Aid group says Israel hit convoy to hospital in Gaza. Israel says it hit gunmen who seized the car

DUBAI, Aug 30: An Israeli missile hit a convoy carrying medical supplies and fuel to an Emirati hospital in the Gaza Strip, killing several people from a local transportation company, the American Near East Refugee Aid group said on Friday. Israel claimed without immediate evidence that it opened fire after gunmen seized the convoy.

The strike killed several people employed by a transportation company that the aid group was using to bring supplies to the Emirates Red Crescent Hospital in Rafah, said Sandra Rasheed, Anera's director for the Palestinian territories.

The strike happened Thursday on the Salah al-Din Road in the Gaza Strip and hit the convoy's first vehicle.

"The convoy, which was coordinated by Anera and approved by Israeli authorities, included an Anera employee who was fortunately unharmed," Rasheed said in a statement. "Despite this devastating incident, our understanding is that the remaining vehicles in the convoy were able to continue and successfully deliver the aid to the hospital. We are urgently seeking further details about what happened.

Anera planned to release more information later Friday.

The Israeli military did not immediately respond to a request for comment Friday from The Associated Press. However, Israeli military spokesperson Lt. Col. Avichay Adraee posted to the social platform X that "gunmen seized a car at the head of the convoy (a jeep) and began driving."

"After the seizure operation and after confirming the possibility of attacking the militants' vehicle alone, the raid was carried out,



as the rest of the convoy vehicles were not harmed and reached their target according to the plan." Adraee wrote, "The operation to target the militants removed the risk of seizing the humanitarian convoy."

He added: "The presence of armed men inside a humanitarian convoy in an uncoordinated manner makes it difficult to secure the convoys and their staff and harms the humanitarian effort."

The United Arab Emirates, which reached a diplomatic recognition deal with Israel in 2020 and has been providing aid to Gaza since the Israel-Hamas war began, did not immediately acknowledge the attack.

Israeli forces have opened fire on other aid convoys in the Gaza Strip. The World Food Program announced Wednesday it is pausing all staff movement in Gaza until further notice over Israeli troops opening fire on one of its marked vehicles, hitting it with at least 10 rounds. The shooting came despite having received multiple clearances from Israeli au-

On July 23, UNICEF said two of its vehicles were hit with live ammunition while waiting at a designated holding point. An Israeli attack in April hit three World Central Kitchen vehicles, killing seven people. (AP)

#### NSA Doval calls on Lankan Prez, discusses ongoing economic collaboration

COLOMBO, Aug 30: India's National Security Adviser Ajit Doval on Friday called on Sri Lankan President Ranil Wickremesinghe and discussed the ongoing bilateral economic collaboration.

Doval arrived here on Thursday to attend the Colombo Security Conclave to be held on Friday.

Doval called on President Wickremesinghe at the Presidential Secretariat this morning, the President's Media Division (PMD) said.

They discussed the ongoing economic collaboration between Sri Lanka and India.

Senior Advisor to the President on National Security, Sagala Ratnayake, also attended the meeting, the PMD said.

The Colombo Security Conclave brings together National Security Advisors and Deputy NSAs from India, Sri Lanka, Maldives and

Bangladesh and the Seychelles have observer status at the conclave. The conclave deals with maritime security counter-terrorism and cyber security with India bringing to the the Indian Ocean. (PTI)

#### actually served a border state as attor-Japan's defense ministry seeks record budget as it faces growing threat from China

TOKYO, Aug 30: Japan's Defense Ministry Friday sought a record 8.5 trillion yen (\$59 billion) budget for the next year to fortify its deterrence on southwestern islands against China's increasing threat, while focusing on unmanned weapons and AI to make up for the declining number of servicemembers as a result of the country's shrinking population.

The ministry's request for 2025 marks the third year of Japan's rapid five-year military buildup plan under the government's ongoing security strategy. Japan aims to spend 43 trillion yen (\$297 billion) through 2027 to double its annual military spending to around 10 trillion yen, making it the world's third-largest military spender after the United States and China.

The budget request was approved at the Defense Ministry meeting Friday ahead of a submission to the Finance Ministry for negotiations through De-

Japan has been rapidly building up the defense of the southwestern region in recent years amid China's growing military threats and tension in the regional seas. China has escalated clashes with the Philippine coast guards in disputed waters in the South China Sea and sent a fleet of coast guard boats to routinely violate territo-



disputed islands in the East China Sea that Beijing also claims.

A hefty 970 billion yen (\$6.7 billion) of the budget request for 2025 covers the cost of bolstering strike-back capability with the development and purchases of long-range missiles and equipment for their launch, including from an Aegis-class destroyer. About one-third of it goes to a satellite constellation aimed at bolstering the capability to detect missile-related activity, as North Korea, China and Russia develop hypersonic missiles that are

harder to detect and track. While pushing military buildup, Japan must deal with a shrinking troop size and is focusing on developing and buying more drones for surveillance and combat, requesting 103 billion yen (\$710 million). It also seeks 314 billion yen (\$2.17 billion) to build three new

### Pak PM Sharif speaks to Bangladesh's Chief Adviser Yunus

ISLAMABAD, Aug 30: Pakistan Prime Minister Shehbaz Sharif on Friday spoke to Bangladesh's Chief Adviser Muhammad Yunus during which the two leaders agreed to work closely for the progress and prosperity of the people of

During the telephone conversation, they further agreed that "greater regional cooperation could play a vital role in uplifting the lives of the people of South Asia", according to an official statement here.

Sharif's telephone call to Yunus marks the first high-level direct contact between the leaders of the two countries since the change of government in Dhaka.

Prime Minister Sharif highlighted the importance of "revitalizing bilateral relations" through enhanced cooperation across various domains. He emphasised the shared historical, religious, and cultural bonds and expressed a "keen desire to boost commercial relations, cultural exchanges, and peopleto-people contacts.'

Sharif congratulated Yunus on his assumption of the leadership of Bangladesh's interim government. He expressed his best wishes to the Chief Adviser and hoped that the goodwill between the two countries would be translated into substantial cooperation for the benefit of their peoples.

Sharif expressed sympathies over the devastation caused by the recent floods in Bangladesh and expressed his willingness to provide support.

Yunus thanked Sharif for the phone call and the congratulatory message received from him following his swearing-in

The 84-year-old Nobel laureate was sworn in as Bangladesh's interim leader on August 8, vowing to "uphold, support and protect the constitution'

He flew into the capital, Dhaka, just days after Prime Minister Sheikh Hasina was forced to step down and flee to India.

#### Germany deports 28 Afghan nationals to their homeland, the first since the Taliban takeover in 2021

BERLIN, Aug 30: Germany deported Afghan nationals to their homeland on Friday for the first time since August 2021, when the Taliban returned to power.

Government spokesperson Steffen Hebestreit described the 28 Afghan nationals as convicted criminals but did not immediately respond to a request for comment to clarify their offenses.

Interior Minister Nancy Faeser called the move a security issue for Germany.

Germany does not have diplomatic relations with the Taliban, requiring the government to work through other channels. It's unlikely that Friday's actions will lead to a wider thawing of relations between Germany and the Taliban, especially after last week's issuing of the first set of laws to prevent vice and promote virtue in Afghanistan. They include a requirement for a woman to conceal her face, body and voice outside the home.

German Foreign Minister Annalena Baerbock has slammed the morality laws in posts

While Hebestreit said the deportations have been in the works for months, they occurred a week after a deadly knife attack in the town of Solingen in which the suspect is a Syrian citizen who had applied for asylum in Germany.



ing the protest. Speaking on the sideline of the protest, UCM leader YK Dhiren condemned the bomb attack and termed it as the "most unfortu-

He said that UCM has been working for the integrity of Manipur and the peaceful coexistence of the communities in the state.

"Attacking at the office of such a civil society organisation at a time when the state is facing mayhem is very unfortunate. If there is any dissatisfaction with the working of the organisation or something which likes to be done more by the same, everything can be resolved peacefully through dialogue," Dhiren added.

The UCM leader also appealed to all concerned not to carry out such an attack in the future.

All Manipur Kanba Ima Lup (AMKIL) president Lourembam Nganbi demanded the individuals or organizations involved in the attack on the UCM office to clarify on the matter at the earliest.

SHILLONG, Aug 30: Meghalaya Social Welfare Minister, Paul Lyngdoh today assured the assembly session that the government will constitute a committee to study the proposal for amending the Constitution (Scheduled Tribes) Order, 1950 and come up with a report within three months' time.

"The department will constitute a Departmental Committee to study the matter in depth and come up with a final report in 3 months' time," Lyngdoh said while replying to a resolution moved by opposition VPP legislator Adelbert Nongrum in the Assembly.

The resolution seeks to impress upon the Union government on the crucial need to further amend the Constitution (Scheduled Tribes) Order, 1950 to make necessary exclusions and substitutions to the list of tribes in Part XI of the schedule pertaining to the state of Meghalaya, in keeping with the actual demographic of the state.

"We will engage with the stakeholders and obtain their views before finalising the report. And thereafter it will be forwarded to the Registrar General of India, and we will duly follow up the matter as per prescribed procedure,' Lyngdoh assured.

Part XI of the Constitution (Scheduled Tribes) Order, 1950 (Part III - Rules and Orders under the Constitution) is the list of notified Scheduled Tribes in Meghalaya which currently has 17 notified tribes as Scheduled

Lyngdoh said that in June 1999, the government approved modalities for deciding claims for inclusion in or exclusion from the lists of Scheduled Tribes. According to these approved (NNN)



guidelines, only those claims that have been agreed to by the concerned state government. the Registrar General of India and the National Commission for Scheduled Castes & Scheduled Tribes will be taken up for consideration.

Wherever representations are received in the Ministry of Tribal for inclusion of any community in the list of Scheduled Tribes of a State/UT, the Ministry forwards that representation to the concerned State Government/UT administration for recommendation as required under Article 342 of the Constitution. If the concerned state government recommends the proposal, then the same is sent to the Registrar General of India (RGI), he said.

The RGI, if satisfied with the recommendation of the State government, recommends the proposal to the central government. Thereafter, the Ministry of Tribal Affairs referred the proposal to the National Commission for Scheduled Castes and Scheduled Tribes for their recommendation, he added

#### Key to ensuring safety during festival AMC issues strict Durga Puja guidelines

AGARTALA, Aug 30: The Agartala Municipal Corporation (AMC) has issued detailed guidelines for the Durga Puja festival to ensure safety and prevent any untoward incidents during the celebrations.

Speaking to reporters, AMC Mayor Dipak Majumder stated that the number of Durga Puja celebrations within the Agartala Municipal Corporation areas may increase this year.

The Mayor urged Puja organizers to register their names with the AMC and directed that no Puja committee may set up Puja mandaps in a manner that obstructs the movement of common people. "Gates should be constructed outside the

road. Puja committees must obtain permission from the Traffic Department, Fire Service, Public Works Department, and Power Department. If any government property is

damaged during the construction of the Puja mandap, the respective Puja committee will be required to pay compensation for the loss,' said the Mayor.

He further emphasized that Puja mandaps with a height of more than 20 feet must receive approval from the Civil Engineering Department. "Every year during Durga Puja, some Puja committees raise the mandap too high, causing safety concerns. Therefore, Puja mandaps should be constructed at least 8 feet away from power lines. No one will be permitted to set up temporary shops without a vendor license during Durga Puja. The place of worship and its surroundings should be kept clean at all times. All Puja committees registered with the Agartala Municipal Corporation will be provided with two cleaning staff by the Municipal Corporation," said the

## Sit next to NCP ministers but it's nauseating: Sena minister

The former chief minister was referring to alleged rigging in the 1987 polls.

When the third force came forward in the shape of the MUF, it committed irregularities by which it shut the doors of elections for other parties forever," Mehbooba alleged.

#### Akal Takht declares Sukhbir Badal 'tankhaiya' for 'religious misconduct'

AMRITSAR, Aug 30: The Akal Takht on Friday declared Shiromani Akali Dal president Sukhbir Singh Badal 'tankhaiya' -- guilty of religious misconduct-- for the "mistakes" committed by his party and the party's government from

2007 to 2017. Soon after the declaration, Badal said he bows his head and accepts the order of the Akal Takht.

In a post on X in Punjabi, Badal said he will soon appear before the Akal Takht to apologise.

Banerjee, who wrote to Modi a few days ago on the issue following nationwide uproar over the rape and murder of a doctor at R G Kar Medical College and Hospital in Kolkata on August 9, sought mandatory provision for timebound disposal of cases of rape/rape and murder.Banerjee had on Wednesday said an amendment to existing laws will be passed in the state assembly next week to ensure capital punishment to convicted rapists.

Stating that she is yet to receive a reply from the PM on the issue flagged by her, Banerjee wrote that she has, however, received a communication from the Union Women and Child Development minister.

Mamata seeks stringent central legislation in rape and murder cases

Maintaining that the letter by the WCD minister "barely attends the gravity of the issue" raised by her, Banerjee wrote, "The seriousness of the subject and its relevance to the society have not been adequately appreciated while sending out this generic reply.

The CM wrote that 10 exclusive POCSO (Protection Of Children from Sexual Offences Act) courts have been approved by the state government. She further mentioned that 88 fasttrack special courts and 62 POCSO-designated

courts are already functioning in West Bengal on state funding.

Banerjee wrote that helpline numbers 112 and 1098 are functioning in the state and additionally, Dial-100 is extensively used in emergency situations.

WCD Minister Annapurna Devi had on Wednesday said the situation of women in West Bengal has been "deteriorating" and slammed the Mamata Baneriee government for failing to implement central schemes such as fast-track courts and emergency helplines to deal with crimes against women.

Devi claimed that the fast-track special courts (FTSCs), which were allocated to West Bengal, are yet to become operational in the state. (PTI)

Under those circumstances, it is unfortunate but the Indian parliamentary system has been traveling down that road for a very long time," he said. "To my mind, I have always held this view that if we keep going down this road, we will make legislative institutions irrelevant to India's democratic

discourse," Tewari told PTI. The Chandigarh MP also asserted that the responsibility of running Parliament is not of the Opposition and lies squarely with the government.

"Parliament is not only to transact government business. There are people's issues which need to be articulated and I have once in an informal conversation told one of the presiding officers.

"Ultimately what is it all about? It is all about the opposition wanting space to articulate their views so everyday from 6-9 PM in the

evening, at least three days in a week, why don't you allow a rule 193 discussion and which the joint

opposition agrees to," Tewari said. "Therefore if you have three rule 193 discussions in the Lok Sabbha in a week between 6-9 PM in the evening, the opposition would have found its space," he said.

Tewari said there was a time in 1952 when Parliament used to meet 150 odd days in a year which has come down to 55 days, the Congress leader said. "The biggest problem is that the

anti-defection law, which is actually a well-intentioned law to try and curb the menace of defections, has failed to do that but has sucked democracy out of legislative institutions. No longer members of Parliament and members of legislative assemblies are free to exercise their conscience," he said.

Tewari pointed out that he keeps moving a private member bill almost every session that seeks to strike a balance between stability which the anti-defection law seeks to bring, and which it has failed in bringing, and the space for legislators or parliamentarians to articulate their point of view. # **Engineering college management** hushed up hidden cameras issue: **Students to AP Minister**

GUDLAVALLERU (ANDHRA issue," said an official statement, PRADESH), Aug 30: Female students of an engineering college here complained to Mines Minister K Ravindra on Friday that the management attempted to hush up the issue of hidden cameras allegedly found in a women's washroom and also went to the extent of threatening students who lodge a complaint over the matter.

Hundreds of students have been staging protests at S R Gudlavalleru Engineering College in Krishna district since Thursday night over the alleged incident.

The students poured out their woes to Ravindra, who reached the college with the district collector and superintendent of police, following instructions from Chief Minister N Chandrababu Naidu.

"We (students) don't have faith in the college management as it has been trying to hush up the matter (alleged hidden cameras issue) for the past three days. The college management threatened to act against us if we complain over this

quoting the students' complaint to Ravindra. Demanding justice at any cost, the students vowed not to attend classes until then, while the minister said that truth would come out and the culprits would be punished.

Meanwhile, the Chief Minister discussed the issue with the district officials and ordered an inquiry into the allegations of hidden cameras found in the girl students' washroom in the college.

If the crime of capturing videos through hidden cameras is proven, then the CM directed officials to take stringent action against the culprits, said an official statement.

In the event of students possessing any evidence regarding the incident, Naidu urged them to share it with him.

A case was registered in connection with the alleged incident. However, the police maintained that there were no such hidden cameras found in the students' washroom. (PTI)

#### Excess allocation of seats in college creates burden on infrastructure: Delhi HC

**NEW DELHI, Aug 30:** Excess allocation of seats in a college would not only create a burden on the limited available infrastructure but also impair the institute's ability to impart quality education to its students, the Delhi High Court has said.

The court's observation came while dealing with an argument of St. Stephen's College that instead of allocating students against the sanctioned intake, excessive allocation of seats has been made by the Delhi

According to the university, it was for convenience as normally all the students do not take admission, resulting in some seats remaining vacant.

"This court is further of the view that the appellant's (Stephen's College) argument that excessive allocation has been made by the university has not been rebutted with specificity by the university.

"This court would like the university to appreciate that excess allocations of seats in a college would not only create a burden on the available limited infrastructure but would also impair the ability of the college to impart quality education to its students. Such action could also jeopardise the careers of young students," a bench of Acting Chief Justice Manmohan and Justice Tushar Rao Gedela said. While the order was passed Thursday, it was uploaded on the court's website on Fri-

The division bench was hearing an appeal by the college challenging a single judge's interim order directing that six students be granted provisional admission in accordance with the allocation by the varsity.

The bench said though the single judge's August 23 order stated that provisional admission be granted to these students, it was of the opinion that the order virtually granted the relief sought by them in the main petition. It, however, advanced the date of hearing from September 11 to September 5 in the petition pending before the single judge and

said the six students must not attend their classes till the plea is decided. "Since the final hearing before the single judge has been expedited and with a view to balance the equities, this court directs that till the disposal of the writ petition, the respondents no.1 to 6 (six students) shall not attend

the classes at the appellant-college," the

bench said During the hearing, senior advocate Romy Chacko, representing the college, said the institution is much sought after and students allotted different programmes of study ordinarily accept whichever course is offered, and the number of vacancies after the initial allotment is minimal or not at all.

He said after protesting against such a policy, the university agreed that excess allotment to the college would be limited to 5 per

cent in each programme. The senior counsel submitted that contrary to the commitment, the varsity allotted more students. Advocate Mohinder JS Rupal, appearing for the university, submitted that the varsity has allocated only 5 per cent extra seats in the unreserved category in the college. The court also pulled up the varsity for allotting more students to the college than the sanctioned strength.

"The university must understand that they are playing with the students' careers. You are not playing a game of chess that you are settling for. It is a very serious matter," the division bench observed orally. (PTI)

The writer, who has done around 14 films with Bachchan including "Sholay", "Don", "Deewar", and "Amar Akbar Anthony", praised the superstar for his work ethic.

"He is exceptionally good, we have to accept it. He is a brilliant actor. After Dilip saab, the second man who came was Amitabh Bachchan. His turnover was much more than him (Kumar). Dilip saab used to do one film in two years, he (Bachchan) gave seven superhits in a year

"We backed him, he gave us a great performance... He had tremendous discipline and focus. (He had) Total control over his tongue, he would never make a statement which could be controversial in so many years. Seven o' clock shift would mean, he would be there quarter to seven in spite of being a star," Javed Akhtar said at an event.

He was speaking at the third edition of the Indian Express' six-part series Expresso, held in Mumbai. He was also joined by his daughter,

filmmaker Zoya Akhtar. The 79-year-old said, as Salim-Javed, he and his writing collaborator were intelligent enough to recognise Bachchan's acting abilities.

"I never had any complaint from him that he didn't say the dialogues well. At times, I'm thankful for him saying the lines as he did because he added that (emotion) to them that wasn't there on paper. We were intelligent and sharp enough to see





# Man United to play at José Mourinho-coached Fenerbahce in new Europa League format

MONACO, Aug 30: Manchester United will face former coach José Mourinho's new club Fenerbahce among its eight opponents drawn Friday in the new format of the Europa League.

Mourinho led Man United to win the Europa League in 2017 during his 21/2 years at Old Trafford and took the Fenerbahce job in the offseason.

The date of the game in Istanbul will be confirmed by the Union of European Football Associations on Saturday. The competition starts on September 25, a week after the Champions League opens.

As in the Champions League, the traditional group stage of the Europa League has been abolished and replaced with an expanded league phase with all 36 teams competing in a single

Clubs wanted UEFA to provide more revenue from more games against a wider range of higher-profile opponents. Each Europa League team will play eight games against eight different opponents through January 30. Man United will host Rangers, PAOK, Bodo/Glimt and Twente, and also travel to Porto, Viktoria Plzen and FCSB, the club known as Steaua also will host Lyon and Athletic



Bucharest when it won the 1986 European Cup.

Man United avoided being paired with Ajax, the former club of its coach Erik ten Hag and the team it beat in the 2017 final. Fenerbahce and Mourinho

It followed another exit in Ashe for a past U.S. Open champion, Naomi Osaka, who was sent home Thursday by Karolina Muchova 6-3, 7-6 (5). That one, though, was not nearly as out-ofnowhere as what happened to Alcaraz.

He won the French Open in June and Wimbledon in July to raise his career total to four major championships, including taking the title at Flushing Meadows in 2022. Then, in early August, Alcaraz won a silver medal at the Paris Olympics, losing to Novak Djokovic in the final.

# 15-match Grand Slam win streak ends in loss to Botic van de Zandschulp

NEW YORK, Aug 30: After much. double-faulting to fall behind two sets to none — a deficit he's never overcome — in the second round of the U.S. Open, Carlos Alcaraz slung his equipment bag over a shoulder and trudged toward the locker room.

Glancing in the direction of his coach, 2003 French Open champion Juan Carlos Ferrero, Alcaraz pointed his right index finger at his temple, then wagged that finger, as if to say, "I'm not thinking straight."

He might have been excused for being confused by what was transpiring under the closed retractable roof at Arthur Ashe Stadium on a chilly evening, and one set later, Alcaraz's 15-match Grand Slam unbeaten streak was over with a sloppy 6-1, 7-5, 6-4 loss to 74th-ranked Botic van de Zandschulp.

"It was a fight against myself, in my mind, during the match. In tennis, you are playing against someone that wants the same as you — to win the match — and you have to be as ... calm as you can, just to think better in the match and try to do good things," Alcaraz said. "Today I was playing against the opponent, and I this week and hadn't won conwas playing against myself, in secutive matches at a tour-level my mind. A lot of emotions that I couldn't control."

The result eliminated the pretournament men's favorite and certainly was hard to predict beforehand, given the No. 3-seeded Alcaraz's standing in the game. his excellence of late and his opponent's far-lesser resume.

Maybe, Alcaraz acknowledged, a tennis schedule he called "so tight" drained him too

"Probably, I came here with not as much energy as I thought that I was going to (have)," he said. "But, I mean, I don't want to put that as excuse.'

What's clear is he never found his footing against van de Zandschulp, a 28-year-old from the Netherlands. Alcaraz was way off, repeatedly missing the sorts of shots he usually makes rou-

The 21-year-old from Spain came in with a 16-2 record at the U.S. Open, where he never lost before the quarterfinals in three previous appearances. This also was Alcaraz's earliest defeat at any major tournament since bowing out in the second round of Wimbledon in 2021 as a teenager; he's never been beaten in the first round at a Slam event.

In contrast, van de Zandschulp only once has been to a Grand Slam quarterfinal, getting that far at the U.S. Open in 2021.

Otherwise, though, he is not someone most folks would have expected to pull off this sort of monumental upset. Consider: van de Zandschulp was just 11-18 for the season at the start of event in 2024 until now

"Actually, I am a little bit at a loss for words," he said. "It's been an incredible evening for Sure was.

The key stat probably was that van de Zandschulp won the point on 28 of his 35 trips to the net.

The opening set was unbelievably lopsided. With van de Zandschulp's powerful forehands and serves at up to 132 mph finding their marks, Alcaraz never seemed to get comfortable.

He did not produce a single winner in that set and was nearly doubled up in total points, 24-13. The second set was a bit better for him, but not enough so, and a double-fault gift-wrapped a service break that put van de Zandschulp up 6-5. When Alcaraz pushed a forehand wide to end the next game, van de Zandschulp finished off a hold at love that gave him the initial two sets after 1 1/2 hours of action. (AP)

# Jurgen Klopp joins the crowd at the Paralympics, cheering on long-time friend playing badminton

**PARIS, Aug 30:** Former Liverpool coach Jürgen Klopp is used to being at the center of attention. On Thursday he was more than happy to be on the sidelines, cheering for his longtime friend Wojtek Czyz as he competed in badminton at the Paris Paralympics.

"I stood next to Elena, his incredible wife, and we both had tears in our eyes," Klopp said after watching Czyz lose to Britain's Daniel Bethell in the men's singles. "I couldn't be prouder of him. I know sports are all about results, but just seeing him on the court was so touching, and I couldn't get my head around that.

Their friendship began about 20 years ago when Czyz, a promising soccer player, suffered a devastating injury in a collision with a goalkeeper that led to the amputation of his lower left leg. During his rehabilitation Czyz met Klopp, who was managing FSV Mainz 05, a second-division German club at the time.

They made an immediate connection that grew deeper over the years. Klopp, who stepped down as Liverpool coach this year after more than eight seasons, often uses Czyz's story as a source of inspiration for others. "Wojtek is constantly doing things I'm not brave enough to ' Klopp said at the La Chapelle Arena in the north of Paris. "Yesterday, he was telling me how easy it is to swim with sharks," he added, referring to Czyz's experience as a licensed diving instructor.

Following his injury, Czyz started competing in para athletics, winning gold medals for Germany in the 100 meters, 200 meters and long jump at the 2004 Paralympics. After he quit the sport in 2013 he and his wife Elena Brambilla-Czyz bought a catamaran and sailed around the world, helping amputees living on remote islands to get pros-

They arrived in New Zealand in 2019 where Czyz decided to take up badminton. After just a few years, he got so skilled at the the sport that he earned a spot at the Paris Paralympics, competing for New Zealand.

However, Bethell, the No. 2 seed, proved to difficult for the 44-year-old Czyz in the SL3 category for players who practice standing and have a disability in one or both legs. Bethell won in straight sets 21-5, 21-2. Still, Czyz said Klopp's sup-

port meant a lot. "Jürgen is family to me," Czyz said. "It was great having him in my corner, despite the tough loss today. We need people like Jürgen putting the spot-

light on us. It was a special movement also for Bethell who received a thumbs-up and a "Great job, Dan" from Klopp.

'That was surreal, seeing him (Klopp) in the stands," Bethell

Despite the loss, Czyz's journey in Paris is not over. He will Ukraine's Oleksandr Chyrkov in a decisive second group stage match.

'Given my performance today, I'll have to think about it," Czyz joked. (AP)

# Paralympics: Avani retains gold; Mona clinches bronze in historic 10m air rifle double for India



CHATEAROUX, Aug 30: The incredible Avani Lekhara became the first Indian to claim successive Paralympic gold medals with a record-shattering top finish in the women's 10m air rifle (SH1) shooting competition and had a bronze-winning Mona Agarwal for company on the podium in a historic double for the country here on Friday.

Winner of the Tokyo Paralympics gold three years back, Avani, 22, shot a superb 249.7 to erase her own Paralympic record of 249.6 set in the Japanese capital three years back.

The 37-year-old Mona, who dabbled in several sports including shot-put, powerlifting and wheel-chair volleyball before settling on shooting, notched up 228.7 for the third-place finish.

She lost quite a bit of weight following the surgery but the determination to overcome all odds was all too evident during the national camp at the Karni Singh ranges, Avani kept her cool to shoot a superb 10.5 to clinch the gold with a Paralympics record.

The success will come as a huge boost for Avani ahead of the 50m rifle 3-positions event, where she is also a firm favourite for a medal after winning bronze in the previous edition of the Games in Tokyo.

Earlier, Avani came up with another sterling performance by qualifying for the final in second place, while Mona, who too has been in sublime form in the last one year, also made it to the eight-shooter summit clach in fifth place.

While Avani shot a 625.8 to be placed second behind Ukraine Iryna Shchetnik, who broke the Paralympic Qualification Record with a score of 627.5, Mona, the two-time World Cup gold medallist, shot 623.1.

Avani had credited the "positive environment" in the national camp for helping her overcome her fitness worries.

"I think we have been in a very positive environment throughout. We are just focussing on the process rather than the outcome.

"There, obviously, will be expectations but those expectations only motivate me and inspire me more to give my best. I am also more mature in my technique," she had said before leaving for Paris

As the lead changed hands between Avani, Mona and Yunri, it was all too evident who was the strongest of them all in terms of mental fortitude. The bespectacled shooter kept striking consistently, with just one shot below 10, even as the other two succumbed to pressure. (PTI)

#### Badminton at Paralympics: Suhas, Nitesh seal semifinal spot; Manasi, Manoj out



PARIS, Aug 30: Tokyo silver medallist shuttler Suhas Yathiraj and Nitesh Kumar continued their impressive run to secure spots in the men's singles SL4 and SL3 semifinals, respectively, at the Paralympics here on Friday.

Suhas, a 2007 batch IAS officer, defeated Korea's Shin Kyung Hwan 26-24, 21-14 in his second match, topping the three-man Group A in the SL4 category.

Meanwhile, Nitesh, a 29-year-old IIT Mandi graduate, dominated China's Yang Jianyuan with a convincing 21-5, 21-11 victory, ensuring a top-two finish in the four-man Group A of the SL3 category.

In the SL4 class, the group toppers advance to the last four, while in the SL3 class, the top two players from each of the two groups qualify for the semifinals. Nitesh, who suffered permanent leg damage due to an accident in 2009, will next face Thailand's Bunsun Mongkhon in his final Group A match.

However, it was a disappointing day for Manasi Joshi and Manoj Sarkar, as they both suffered their second consecutive defeats, ending their chances of reaching the semifinals in their respective groups. Manasi, the 2019 World Champion, narrowly lost to Ukraine's Oksana Kozyna 21-10, 15-21, 21-23 in her second women's singles SL3 Group A match. She had previously lost her opening match to Indonesia's Qonitah Ikhtiar Syakuroh on Thursday.

Tokyo bronze medallist Manoj also faced another setback, losing 19-21, 8-21 to Bunsun in his second Group A match. Manoj had earlier lost to compatriot Nitesh on Thursday and will meet Yang on Friday.

The SL4 class is designated for athletes with lower limb impairments and minor balance issues in walking or running, while the SL3 class is for players with more severe lower limb disabilities, requiring play on a half-width court.

On Thursday night, Nitesh and Thulasimathi Murugesan were defeated by the Indonesian pair of Ramdani Hikmat and Oktila Leani Ratri 15-21, 8-21 in their second mixed doubles SL3-SU5 group stage match.

Suhas Yathiraj and Palak Kohli also suffered a 15-21, 9-21 loss to France's Lucas Mazur and Faustine Noel in their second Group A mixed doubles match. The SU5 class includes athletes with upper limb impairments. (*PTI*)

#### Persistent rain in Rawalpindi washes out Day 1 of 2<sup>nd</sup> test between Pakistan and Bangladesh

RAWALPINDI, Aug 30: Persistent rain washed out the opening day of the second test match between Pakistan and Bangladesh at the Rawalpindi Cricket Stadium on Friday. Bangladesh leads the twomatch series 1-0 after it notched a historic 10-wicket win at the same venue last week when Pakistan was bowled out for an embarrassing 146 in the second innings on the fifth and final day.

Players and team officials stayed in the hotel and umpires called off the play at 12:05 p.m. local time with rain still pouring down and leaving the outfield submerged.

Both teams are in the bottom half of the World Test Championship standings with Bangladesh at No. 7 and Pakistan at No. 8, just above last-place West Indies.

An embattled Pakistan, which has lost four test matches in a row since Shan Masood was elevated as captain last year, hasn't won a home test since it beat South Africa in December 2021. The remaining four test matches against New Zealand and Australia were drawn.

Pakistan dropped rusty fast bowler Shaheen Shah Afridi and named another left-armer Mir Hamza along with leg-spinner Abrar Ahmed in its 12-man squad.

Afridi, who was playing his first test in eight months, was ineffective and had to wait until Pakistan took the third new ball to claim 2-88 as Bangladesh replied to Pakistan's 448-6 declared with a strong total of 565. Abrar was surprisingly released from the first test squad and was asked to play in a four-day game against Bangladesh A' in Islamabad and Pakistan's ploy to go with an all-out pace attack in a home test match after 28 years backfired.

In contrast left-arm spinner Shakib Al Hasan and off-spinner Mehidy Hasan Miraz took seven wickets in between them on a dramatic fifth day to skittle out Pakistan for its lowest-ever total against Bangladesh in 14 test matches.

Bangladesh batters, led by Mushfiqur Rahim's resilient 191, were also among the runs with Shadman Islam, Mominul Haque, Litton Das and Mehidy all scoring meaningful half centuries. (*AP*)
