## RG Kar doctor rape-murder SC tears into Kolkata police for 'lapses' in probe

NEW DELHI, Aug 22: A tough talking Supreme Court on Thursday tore into the Kolkata police over the delay in registering the unnatural death of the woman doctor, who was raped and

killed at the RG Kar Hospital, calling it "extremely disturbing" and questioned

sequence events and the timing of its procedural formalities. Making an impassioned appeal to the

protesting doctors across the country, the apex court also asked then to get back to work. saying "justice and medicine" cannot be stopped and moreover, it was issuing all the necessary directions to ensure their safety. It further directed no coercive action against them.

Expressing surprise that the postmortem of the victim was conducted on August 9 between 6.10 pm to 7.10 pm before the registration of case as unnatural death, the top court pulled up the Kolkata police over "unexplained" delay of 14 hours in lodging of the FIR in the case. ## Oppn stages walkout protesting Speaker's action

Stormy start to autumn session of State assembly • Daimary rejects Oppn's 3 adjournment motions

GUWAHATI, Aug 22: The Assam Assembly session on Thursday was marked by controversy as the opposition staged a walkout after Speaker Biswajit Daimary rejected three adjournment motions.

When their motions were rejected by Speaker Daimary, members of Congress, AIUDF, CPI(M) and Raijor Dal went to the Well of the House with placards and shouted slogans in support of their demands.

Leader of the Opposition Debabrata Saikia raised concerns over high charges from smart meters, while Independent MLA Akhil Gogoi sought to address a recent attack on a minor national-level player. On the other hand, AIUDF MLA Aminul Islam discussed restrictions on land sales between different communities.

Saikia criticised the smart meter charges, stating, "Electricity is a basic amenity, and the public can't be deprived of it. The exorbitant charges are causing suffering for poor people and need urgent attention." Islam argued that restricting land sales based on religion is unconstitutional.

"The CM's proposal to prohibit inter-



community land deals and require his approval is an attempt at polarisation politics. The government is trying to divide people along religious lines," he

added. Later, Gogoi expressed concerns about deteriorating law and order, demanding the resignation of chief minister Himanta Biswa Sarma, who also serves as home minister.

He highlighted a recent incident where a minor arm wrestler was attacked, claiming police inaction until public protests ensued.

"A national award-winning minor arm wrestler was physically abused by three men, even attacked in her private parts. But the police didn't take any action. When people hit the streets, then only police arrested two people," he Gogoi also noted a recent ULFA(I) threat involving bombs, criticising the police's response. "The law and order (CONTD. #### **Bill to abolish Muslim** marriages, divorce Act tabled

GUWAHATI, Aug 22: The Assam government on Thursday introduced a Bill to repeal a law to register marriages and divorces of Muslims, stating that it had scope to allow marriages of minors from the community.

Revenue and Disaster Management minister Jogen Mohan tabled The Assam Repealing Bill, 2024 in the Assembly to abolish The Assam Moslem Marriages and Divorces Registration Act, 1935 and the Assam Repealing Ordinance 2024.

There remains a scope of registering marriages of intended person below 21 years (in case of male) and 18 years (in case of female)," he said in the Statement of Object and Reasons of the Repealing Bill.

It hardly had any provisions for monitoring the implementation of the Act throughout the state and it attracted huge amounts of litigation in the court, he added.

"There is a scope of misuse by both authorised licensee (Muslim marriage Registrars) as well as by citizens for underage/minor marriages and forcefully arranged marriages without the consent of the parties,

Besides, the registration of marriages and divorces were not mandatory, and the registration mechanism was informal that left a lot of scope for non-compliance of the norms, he added. (CONTD. ON PAGE-2)

## DGP seeks people's cooperation in maintaining law and order

GUWAHATI, Aug 22: Assam Director General of Police G P Singh on Thursday requested all stakeholders to cooperate in maintaining law and order in the state, while instructions were issued to officers to take action against anyone trying to break the law

The development came in the wake of a recent incident in which a group of Marwari leaders issued a public apology in Sivasagar district following the assault of a teenage girl by a member of the community.

"Reiterating commitment of @assampolice to strict adherence to law, I request all stakeholders to cooperate with us in maintaining L&O in the state", the DGP posted on 'X'. In a letter sent to police heads in the city, districts and all ranges, Singh said that it has been observed



that in the recent past, that a few incidents of criminal acts have taken place where the victim and the accused belong to different communities. In such cases, it is directed that police should proceed in absolute accordance with law, he said.

The DGP also advised police units, along with the police stationlevel citizens' committees and the district administration to have regular meetings with stakeholders from all communities and strive to maintain amity amongst different communities. There should be no space for resorting to instant justice or action beyond law by any section of people, he said.

The field police units shall mandatorily ensure the rule of law under all circumstances with 'failure to do so viewed adversely and dealt accordingly', Singh said. "I reiterate the commitment of

Assam police to absolute adherence to law and neutrality in implementation of the law," the DGP added. Notably, a group of Marwari community leaders had knelt down and

## 47,928 foreigners detected in 43 years; 43 pc of them Hindus: CM

Assam government on Thursday said over 47,900 foreigners have been detected in the state from 1971 to 2014, out of which more than 43 per cent are Hindus.

In a written reply to a query by AGP MLA Ponakan Baruah, chief minister Himanta Biswa Sarma said the Foreigners Tribunal (FT) has declared 47,928 people as foreigners between 1971 and 2014.

Out of them, 27,309 were Muslims, 20,613 Hindus and six belonged to other religions, he said.

The CM said the highest number of foreigners was detected in Cachar. Out of 10,152 declared foreigners, 8,139 were Hindus and the remaining 2,013 were Mus-

GUWAHATI, Aug 22: The of all foreigners coming to the state on or after March 25, 1971 would be detected and deleted from electoral rolls and steps would be taken to deport them.

Sarma said that according to the 2011 census, the state had a total Assamese speaking population of 1.51 crore, making up 48.38 per cent of the 3.12 crore residents.

There were 90.24 lakh Bengali speaking people, both Hindus and Muslims, in the state -- 28.92 per cent of the total population, he said. ## Members raise questions on provisions of Waqf bill as Parl panel holds first meeting

NEW DELHI, Aug 22: The Joint Committee of Parliament on the Waqf (Amendment) Bill held its marathon first meeting on Thursday amid objections by opposition MPs over a host of provisions in the proposed law as the Union minority affairs ministry made a presentation.

Heated words were exchanged at times during the meeting but members from various parties sat through several hours, recording their views on the provisions of the Bill, offering suggestions and seeking clarifications.

The Trinamool Congress' Kalyan Baneriee, Saniav Singh of AAP, Asaduddin Owaisi of the All India Mailis-e-Ittehadul Muslimeen (AIMIM) and A Raja of the DMK were joined by some other opposition members in raising questions over the need for several clauses, including the move to give more powers to the collector and have non-Muslim members on Waqf boards.

There was a view among the members, some of them said, that the ministry was not "adequately prepared" to address the queries raised in the meeting The next meeting of the committee will be held on

August 30, a member said. Committee chairperson Jagdambika Pal assured the



members that the panel would speak to all stakeholders, including various Muslim bodies.

The 31-member committee has been tasked by the Lok Sabha to scrutinise the contentious Bill, which has drawn protests from the opposition parties and Muslim organisations. The GoM was originally set up in September 2021, under the then Karnataka Chief Minister Basavaraj Bommai. "How was it that the post-mortem was conducted at 6.10 pm on August 9 and yet the unnatural death information is sent to Tala police station at 11.30 pm on August 9. This is extremely disturbing," the bench, also comprising Justice J B Pardiwala and Manoj Misra, said.

Pointing out the laxity in investigation by the Kolkata Police, Justice Pardiwala said, "When you start performing the post-mortem, it means that it is a case of unnatural death. However, case of unnatural death was registered at 11.30 pm on August 9 after post-mortem and the FIR is recorded at 11.45 pm.

The entire procedure followed by your state is something which I have not come across in the 30 years of my (professional) life," Justice Pardiwala said.

The top court also quizzed West Bengal government over the role of Dr Sandip Ghosh, former principal of RG Kar Medical College and Hospital, who has come under the scanner in the aftermath of the ghastly crime. "Procedure is a separate issue, but the point remains. What is the reason the FIR is lodged almost 14 hours after the discovery of the body. The most important thing is that the principal of the college should have come straightaway to the college and directed the filing of the FIR. Who was he in touch with? What was the purpose? the bench asked senior advocate Kapil Sibal, appearing for the West Bengal government. (PTI)

## Roadmap to profitability laid out, electric car off the table: Ola Electric CMD Bhavish Aggarwal

NEW DELHI, Aug 22: Newly-listed Ola Electric has laid out a roadmap to profitability banking on higher volume, vertical integration of supply chain and in-house produced cells, while it has shelved plans to make electric car, according to company founder and CMD Bhavish Aggarwal. The company, which forayed into the electric

motorcycle segment last week, will build products that Indians need, which are by a vast majority two-wheelers and three-wheelers, he said in an interaction with PTI editors at the agency's headquarters here. In the first quarter of this fiscal, Ola Electric's

automotive segment EBITDA was almost break-even but for a one-time reversal of about ₹ 30 crore it had to pay for a change in standard operating procedure in the government for PLI rules, he said, adding the cell segment is at a different stage of evolution. Ola Electric's net loss widened in the first quarter to ₹ 347 crore, from ₹ 267 crore in the corresponding period a year ago. In FY24, the company's net loss was at ₹1,586 crore.

"We have shown that even with fast growth, even with investing in 'penetration', you can improve margins. Now, there is a roadmap to profitability from EBITDA to PAT. We have two or three strategies, which we are continuing to execute on, which will deliver improving margins over the subsequent quarters," Aggarwal said. He was responding to a query on Ola Electric's roadmap to profitability, as it remains a concern despite the company's share price almost doubling from the listing price of Rs 76.

"As volumes are growing, the margins are improving because costs are not growing with it. That's one theme on the path to profitability,' he said, adding the company would benefit



from having a stable fixed cost as it has built a factory for a higher scale. Aggarwal further said, "As a strategy, we did much more vertical integration of manufacturing and engineering. As we continue down that path, we further see margin expansion, because instead of buying from a global supplier, we are producing ourselves and then saving the 20-30 per cent margin for that component that the supplier will be charging us." Stressing that the cell is at the "centrepiece" of the roadmap to profitability, he said, "as our cell production goes into our own products, by early next year, there'll be a very sizable margin expansion because of that also."

Ola Electric has already announced plans to integrate its 'Bharat 4680' cell into its vehicles starting Q1 FY26. He, however, said the company has not set a timeline to become profitable. When asked if the electric car project is off the table, Aggarwal said, "Yes. We are not working on it right now. Our vision is to build products relevant for India and build technologies to enable those products at scale and we're going in a sequence, two-wheelers and then other products." "India needs to build a sustainable paradigm of energy and automotive. The global solution for sustainability is (electric) luxury cars... That's not relevant for India. India is (electric) two-wheelers, three-wheelers, maybe small cars," he said.

In 2022, he had announced that Ola Electric would foray into the electric cars segment with plans to launch its first model by 2024, while setting an ambitious target of selling 10 lakh electric cars by 2026-2027. On his 'End ICE Age' campaign, he said," (it) is a given. Only question is when." Explaining the reasons, Aggarwal said internal combustion engine (ICE) vehicles are inflationary on two fronts, as vehicle cost goes on increasing in order to comply with emissions, while fuel cost also goes up because of macroeconomic factors. On the other hand, EVs only become more affordable as the battery cost is reducing, while electricity cost is also coming down as generation cost is declining with more and more renewable energy coming into play.

He said from a penetration of just 1 per cent when Ola Electric entered the market three years ago, electric two-wheeler penetration was 7.5 per cent in July. "It is a very fast pace of growth actually. Most of the action has been on the electric scooter side... Think of another three years. It's only going to amplify... Now we are bringing motorbikes where the EV penetration is very early. Same journey will happen there," he said. In 2023-24, ICE two-wheelers wholesales were 1.8 crore, on the other hand electric two-wheeler retail sales were at 9.47 lakh. Asked about the response of major conventional two-wheeler makers like Bajaj Auto, Hero MotoCorp and TVS to EV adoption, he said, "The incumbents have entered into the EV world, a bit halfheartedly." (PTI)

"The DMS and ABMMM are demanding arrest of the culprits involved and punishing them as per law of the land. The two women's organisations demand justice to the victim's family," she added.

Boruah further said that laws are enacted by the Government for protection of women, despite it women are still not safe in male dominated society.

"There are regular incidences of violence against women. Women are burdened with several tasks, yet they face atrocities," she said. She said if women are given respect and treated as their own sisters by the men, then they (women) won't feel insecure.

## When justice is subverted

In two separate corners of India, gruesome rape cases in Kolkata and Badlapur have become flashpoints, with political forces seemingly working to shield themselves rather than seeking justice for the victims. In West Bengal, the BJP has launched a scathing attack on chief minister Mamata Banerjee following the rape and murder of a trainee doctor in Kolkata. Meanwhile, Congress is capitalizing on the horror in Badlapur, where two young schoolgirls were sexually assaulted, to put pressure on the BJP-led Maharashtra government. These heinous crimes have led to a political blame game that detracts from the core issue – the safety of women and the need for accountability. In both cases, the focus has shifted from justice for the victims to a battle of political supremacy. In Kolkata, the CBI's investigation into the rape and murder of the trainee doctor has revealed troubling details. The crime scene was reportedly tampered with, a fact that raises questions about the local police's involvement and the larger political machinery at play. Despite this, progress in the investigation has been slow, with no arrests made thus far. The involvement of chief minister Mamata Banerjee, who holds the dual portfolios of Home and Health Minister, further complicates matters. The possibility of her being summoned for questioning by the CBI has created a tense atmosphere in the state, with fears of unrest should this occur.

The Supreme Court's intervention, which demanded a status report from the CBI, has done little to move the needle. The report, submitted in a sealed cover, indicates that the investigation is bogged down by the same issues that have plagued similar cases – political interference and a compromised police force. The West Bengal government, with senior counsel Kapil Sibal defending it, appears to be in damage control mode, with the opposition BJP keen to leverage the case to weaken Mamata Banerjee's position. In Maharashtra, the situation is equally grim. Congress MLA and leader of the opposition Vijay Wadettiwar has been vocal in his criticism of chief minister Eknath Shinde and deputy chief minister Devendra Fadnavis, accusing them of failing to protect women in the state. The sexual assault of the two young girls in Badlapur sparked public outrage, with citizens blocking trains in protest.

As the Maharashtra Assembly elections loom, the Congress is using this case to gain political mileage, while the BJP struggles to manage the fallout. The creation of a Special Investigation Team (SIT) and the establishment of a fast-track court by the Shinde-Fadnavis government are steps in the right direction, but they seem more like damage control measures than genuine attempts to deliver justice. The stark reality is that in both Kolkata and Badlapur, political leaders are more concerned with protecting their own interests than ensuring justice for the victims. As the Supreme Court continues to monitor the Kolkata case and Maharashtra grapples with the fallout from the Badlapur incident, the common citizen is left questioning whether justice will ever be served. The unfortunate reality is that in India today, whether in Kolkata, Badlapur, or elsewhere, crime often finds a saviour in politics, leaving the victims and their families to fend for themselves in a system that is skewed in favour of the powerful.

fter lengthy negotiations in Doha, Hamas has named Yahya Sinwar as its new Political chief, replacing Ismail Haniyeh who was assassinated in Teheran, Since 2017, Sinwar has served as the group's leader inside the Gaza strip. He now becomes overall leader of its political wing. Sinwar's promotions undermines more pragmatic and senior figures in Hamas with wider exposure to the international political arena and geopolitical landscape of the region, such as former politburo head Khaled Meshaal.

Following the death of Haniyeh, who had strong relations with Iranian officials, the most prominent name to be considered as his successor was Khaled Meshaal.

The appointment of Sinwar came as a big surprise because many did not take into account the Iran factor. Initially, it was thought Khaled Meshaal would resume his role as chairman of the Hamas Political Bureau, an office he previously held between 1996 and 2017 prior to Haniveh But Iranians purportedly vetoed this and put all the

weight behind Sinwar candidature. Meshaal's vocal criticism during the 2011 Arab Spring of Syrian President Bashar al-Assad, a close ally of Teheran, made him a deeply unpopular figure among Iran's top leadership. In addition to this Meshaal had made statements in the past opposing Hamas growing dependence on Tehran.

Hamas is predominantly a Sunni Islamist organisation, while Iran is a hard-line Shiite regime, they found common ground only in their opposition to Israel. That's why the alignment between Iran and Hamas has fluctuated in the past many times. Most importantly in 2012, differences over the Syrian civil war introduced a major rift in their relationship.

Hamas tacit support for Sunni rebels in Syria was at odds with Iran's allegiance to the Assad regime, leading to a temporary withdrawal of Iranian support. For years, ever since Jordan expelled the Hamas leadership from Jordanian capital Amman, in 1999, Hamas had maintained the headquarters of its external leadership in

But in January 2012, Hamas leader Khaled Meshaal abandoned the group's Damascus base after airing the group's views about the Syrian civil war. Although in June 2022, Hamas and Syria announced their decision to restore ties.

On the other hand, Sinwar forged close relations with Iranians

fter Pakistan's surrender at Bogra during the 1971 A Liberation War, Maj Gen Nazir Hussain Shah, the General Officer Commanding of the 16 Pakistan Infantry Division, made a prescient remark: "Bangladesh

will be a troubled nation." Muhammad Yunus, the Nobel laureate and leader of the 16member non-political interim advisory council, which includes two student leaders, has characterized Sheikh Hasina's departure as "the second Liberation." This event has also been dubbed the "third revolution," drawing parallels to the 2006 Nepalese revolution and described as an "Arab Spring on steroids." Additionally, it has been compared to the 2022 Aragalaya uprising in Sri Lanka.

Last month's Anti-Discrimination Students Movement has been clouded by conspiracy theories, including a viral claim by Bangladeshi filmmaker and philanthropist Chanchal Chowdhury that a US-led coup is imminent. The immediate repercussions of Sheikh Hasina's removal are likely to impact India, which has traditionally supported the Awami League.

While non-kinetic military equipment has been sold, Bangladesh's defense acquisitions are categorized by priority, with India falling under the C category and China, the primary source of military hardware, classified under A. The durability of these

enhanced defense ties amidst potential regime changes in Bangladesh remains a critical concern for India

Anti-India sentiment, a recurring theme in the region, has increasingly come to symbolize New Delhi's steadfast backing of Hasina. Some Indian officials have persistently advocated for the implementation of the Citizenship Amendment Act and the National Register of Citizens, referring to Bangladeshis with derogatory terms like 'insects' and 'infiltrators'. Additionally, the China Media Group, in conjunction with Pakistan's ISI, is reportedly supporting the banned Jamaat-e-Islami and its student organization, Islami Chhatra Shibir, in stoking anti-India senti-

Bangladesh shares its border with five Indian states, making it crucial for regional stability. The ongoing unrest along the India-Myanmar border and the escalating tensions in Manipur could severely impact India's Act East and Neighbourhood First policies if an unfriendly regime were to emerge in Dhaka.

Additionally, the threat to the Siliguri corridor from China would resurface, and the BIM-STEC (Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation) could face destabilization as a regional coalition. Consequently, the Indian Army's role will be pivotal in safeguarding India's strategic interests and maintaining stable, amicable relations Bangladesh, reflecting the considerable effort invested in these relationships. India strategically communicate with key players in Dhaka, as a lot is at stake for New Delhi, which has recently been distracted from its regional priorities. ## Budget 2024-25 proposals give a boost to development in Himalayan states

Timalayan states that share borders with neighboring countries of China, Pakistan, Bangladesh, Nepal, Bhutan and parts of Myanmar have faced tardy development since independence. This is partly because of difficult terrain and ecological fragility. Backwardness too is a factor. The terrain is hilly but most of the states are important from security point of view particularly because of some hostile neighbours like China and Pakistan. China in particular is a huge country and economy and has expansionary tendencies right from the beginning.

During British era China's Xinjiang and Tibet autonomous region used to form as a buffer and hence India did not share borders with China directly in spite of the fact that both India and China were two large ancient civilizations. Nevertheless, it changed with Tibet and Xinjiang becoming part of China.

Himalayan states comprise Jammu and Kashmir, Ladakh, Himachal Pradesh, Uttarakhand, and North Eastern states of Sikkim, Assam, Arunachal Pradesh, Nagaland, Mizoram, Meghalaya, Manipur and Tripura. These states have been backward, barring Himachal Pradesh and Sikkim which have done well in social, human and economic indices, which are comparable with some of the advanced states in the country. Jammu and Kashmir though has a lot of potential has been lagging behind due to cross boarder terrorism for decades and has been a trouble-torn right from independence in 1947 due to hostilities from neighboring Pakistan, , which has ruined itself both politically and economically as a

The economic developments of these Himalayan states have been not that good and progress was at a snail's pace as the successive governments have had other more pressing priorities. It was Prime Minister Narandra Modi who laid special emphasis on economic development since he came to power in 2014. Every successive budget since then has stressed on the development of the region, both from security point of view and to bring these regions into the mainstream of the nation.

The 2024 general budget, presented by

Finance Minister Nirmala Sitharaman on July 23 after Modi came to power for this third term, is no different and in fact has gone step further in pushing ahead this

Article 370 of the constitution was abrogated by the Modi government in August 2019, making constitutional rights and power there on par with the rest of the states in the country. Since then there has been special efforts by Modi to double-up development and wean away people from fissiparous tendencies. The Union Budget for 2024-25 has therefore allocated significant funds to Jammu and Kashmir, with a total transfer of ₹ 42,277.74 crore through the Ministry of Home Affairs as there is no elected government at the moment.

This allocation aims to bolster various sectors, from industrial development to education and infrastructure. More recently assembly elections have been announced in three phases in September/October and the results will be announced on October 4. This is the first elections in 10 years and it is happening for the first time after abrogation of Article 370 of constitution.

Though there is nothing direct for industry for the Northeast, industry, chambers feel that the region can take benefit from the allocations in different heads.

To promote industrialisation of Himachal Pradesh and Uttarakhand, the budget has announced ₹ 567 crore to these two states with special emphasis on job creation apart from pushing economic growth of these two hill states. Over ₹1300 crore GST is to be provided to the Himalayan and North Eastern states, which will give that much relief and additional funds for development activities in these states. This will encourage mores businesses to be set up particularly micro, small and medium industries, which are not only drivers of growth in backward areas but also an employment

Border roads development gets a substantial Rs 6500 crore, which are to be spent mostly in these Himalayan states. The spin-off of this boarder roads development would lead to creating much needed infrastructure and providing logistics development in these backwards regions to spur economic activity. This infrastructure development also helps in securing our bor-

ders and road development by itself provide huge employment opportunity to locals in the region. It will help in connecting remote areas and act as growth engines in rural areas. Border area development programme has been allocated an additional ₹ 2000 crore. This will benefit the Himalayan region in creating infrastructure facilities in remote areas, apart from rural development, education and health care. Livelihood issues too will get addressed.

These states are to benefit from the massive allocation of over ₹ 70,000 crore in the budget for the national rural drinking water mission called Jal Jeevan Mission. This is aimed at providing access to clean drinking water for all and the mission was started a few years ago and every year the allocation is increased to cover more areas. The health mission gets over ₹38,000 crore and Pradhan Mantri Awas Yojana gets over ₹ 80,000

The Himalayan states would get its share in these two national missions aimed at improving health care and providing roof over the head of every family in this country through this rural housing mission. Ayushman Bharat Yojana gets ₹ 7,500 crore to provide health cover to the poor and Pradhan gram Sadak Yojana gets ₹ 19,000 crore and Himalayan and North Eastern states too would get its due share in these national projects.

During the last 10 years, it was ensured that all the northeastern states have both air and rail connectivity, which had been eluding for several states. The last state to get air connectivity was Arunachal Pradesh. Now all these state capitals have both rail and air connectivity apart from road connectivity. This is important to give a fillip to economic and social development. There are IITs and IIMs in the North eastern region as well besides AIIMS. All these have happened during the last 10 years.

Ranjit Barthakur, Chairman of FICCI North East Advisory Council (NEAC), says the Union Budget 2024-2025 is a positive step towards the holistic development of the northeastern states. Assam Chief Minister Himanta Biswa Sarma thanked Sitharaman for proposing special assistance to the state to meet the challenges posed by ongoing floods in Assam.

The significant allocations for infrastructure and connectivity, particularly the ₹ 1.11 lakh crore for capital expenditure and specific assistance for flood management in Assam, will bridge the regional disparities and enhance the connectivity of the northeast with the rest of the country. This budget truly recognizes and addresses the unique needs of our region.

Barthakur emphasized the need for substantial investment in connectivity infrastructure in the Northeast, including river-ways, international road and rail connectivity, and airways. He expressed confidence that the significant allocation towards capital expenditure will help address these needs. The allocation of ₹ 1.52 lakh crore for agriculture and allied sectors,

along with targeted support for shrimp production and the creation of large-scale vegetable clusters. This is poised to transform the agricultural landscape of the northeastern states.

The budget also underscores the government's commitment to combating climate change and promoting environmental sustainability. It includes policies for renewable energy projects, sustainable energy solutions, and initiatives aimed at reducing carbon footprints. The focus on green growth, including the PM Surya Ghar Muft Bijli Yojana, highlights the importance of integrating environmental considerations into economic development. The northeastern states, with their rich biodiversity and unique ecosystems, will benefit greatly from these initiatives.

The next generation reforms outlined in the budget are crucial for the northeastern states. Collaboration with states for landrelated reforms and urban planning will address our unique challenges and improve productivity and market efficiency. This will drive overall economic development in

Ravi Patwa, Chairman of FICCI Assam State Council said the operationalization of the Anusandhan National Research Fund and a venture capital fund for the space economy will support research and innovation initiatives relevant to the northeastern

The comprehensive development initiatives and investments in cultural heritage sites and natural landscapes will position the northeast as a key tourist destination. The Budget 2024 is a testament to the government's dedication to integrating the Northeast with the rest of the country's growth trajectory.

The Tea Association of India says the Pradhan Mantri Cha Shramik Protsahan Yojana" (PMCSPY) devised for the welfare of Tea workers especially women and their children in Assam and West Bengal would be of great benefit. As proposed earlier in the Budget Speech of 2021-22, ₹ 1,000 crores will be provided for the same and is aimed at making need-based interventions in tea garden areas for interalia strengthening provisions of education and health services to the tea workers. The scheme will be implemented in the period of FY 2024-25 and 2025-26.

In sum, the budget 2024 has made an honest attempt to bring these backward Himalayan region into the national mainstream and create necessary ambience to kick-start these economies to compete with other states in the country. Some of these states are already fast catching up with the rest of the country. Also the recent announcement of Tata group to set up a huge semiconductor manufacturing facility in Assam will give a boost to the region. There are steps being taken to attract FDI in Jammu and Kashmir from the middleeast. All this augurs well for the economic development of the Himalayan region. (IPA

Barely hours before Bangladeshi Prime Minister Sheikh Hasina was compelled to flee Dhaka, India's home minister was making a statement of Prime Minister Narendra Modi's inescapable durability beyond 2029. Just as Sheikh Hasina had come to entertain notions of indispensability, the prime minister's righthand man appears to have convinced himself – and probably his boss – that India is doomed without Modi at the helm.

On Sunday, Amit Shah was telling an audience in Chandigarh: "The Opposition may try and make as much noise as it wants to. Let me make it clear that in 2029, it is again PM Modi who is coming to power." Such undiluted arrogance. Such a sense of enti-

Of course, the Union Home Minister's primary purpose to signal to all the democratic and constitutional stake-holders not to take too seriously the rebuff the electorate has administered to the Modi regime in the Lok Sabha elections two months ago. Of course, with an invigorated Opposition making its presence felt in Parliament, the Modi coterie has every reason to feel worried that many in the judiciary and bureaucracy may not be all that enthusiastic about implementing their agenda of vengeance. Of course, the Modi establishment cannot be unaware that murmurs of unease and defiance within the BJP, starting from Lucknow,

Sheikh Hasina was also recently "elected" under an arrangement that lacked credibility. The opposition parties had boycotted the poll process. There was no pretence of any free and fair vote. In our own country, there were many voices who felt that given the Modi regime's stranglehold over the Election Commission, the anti-BJP parties should stay away contesting the 2024 Lok Sabha poll. Apart from self- praise and self-promotion, Modi's decade long tenure in government is one of inefficiency, insensitivity and incapacity because it was premised on the fallacious and arrogant assumption that one honest, incorruptible helmsman could fix the "broken" system.

After 10 years India remains as, if not more, corrupt a place it was before 2014; in 10 years, it has become more unfair, more unequal and more undemocratic a place. In Bangladesh, every good impulse, every healthy tradition, every admirable protocol, every vital institution had been suborned in the interest of the glory and power of one individual. We have come very close to flirting with the Bangladesh model. The self-corruption of the establish-

The Bangladesh events make it imperative to remind ourselves that irrespective of whatever Home Minister Amit Shah asserts, democracies do not elect kings or emperors. Democracies choose prime ministers and presidents, all drawing legitimacy and authority from the Constitution. A democratic government is an accountable government. The BJP and RSS will make a terrible mistake if they think that they can get away with misusing constitutional processes to suborn institutional arrangements anchored in democratic accountability.

It is the historic conceit of every autocrat to think they would be able to bring unprecedented prosperity and peace in their land if only they shut down the nagging voices from civil society and the carping critics in the Opposition. Sheikh Hasina is not the first and will not be the last ruler to fall in this illusional trap. Every ruler commits this folly, only to find either the army or angry mobs storming the presidential palace.

No one can be confident that the Amit Shahs and the JP Naddas of our world, who traffic in political arrogance, have the wisdom and sagacity to draw appropriate lessons from Sheikh Hasina's flawed model of personal rule. But one can be confident that India's constitutional institutions will regain their vitality and assert themselves against the Modi regime's uncured waywardness. ## Why the BJP has become cautious on matters of caste

Between 2018 and May 2023, the Narendra Modi government inducted 63 specialists as mid-level bureaucrats through lateral entry, bypassing the established recruitment system where a designated number of posts are reserved for members of the Scheduled Castes and Tribes. This sparked some resentment among the Dalit and Adivasi middle classes but the Bharatiya Janata Party ignored it.

This month, however, after the Opposition and the BJP's own allies in the National Democratic Alliance criticised its decision to issue an advertisement seeking to recruit 45 bureaucrats through lateral entry, the government lost no time withdrawing it

On Tuesday, Jitendra Singh, the minister handling the portfolio of personnel, asked the Union Public Service Commission to retract the notice. He told the recruitment body that the absence of reservations in lateral entry appointments must be "reviewed and reformed".

What prompted the change in the government's position? Political observers say

this is directly connected to the outcome of the 2024 Lok Sabha election where the BJP lost ground in seats reserved for both Scheduled Castes and Scheduled Tribes. Campaign speeches by BJP leaders asking voters to give the Hindtuva party a large majority in Parliament so that it could amend the Constitution had sparked fears among Dalits and Adivasis that mantle the quotas for them in educational institutions and government jobs.

"Forty-five vacancies [through lateral entry] is a very small number, but it has a symbolic value and the BJP would not want to be seen as undermining reservations," political scientist Gilles Verniers told Scroll.

BJP pivots to 'social justice'

The advertisement announcing 10 positions of joint secretaries and 35 deputy secretaries was issued on August 17. Within hours, the Op-

position alleged it was a conspiracy by the government to undermine reservations for disadvantaged groups in public sector jobs. Three allies of the government Janata Dal (United), Lok Janshakti Party and Hindustani Awam Morcha – also opposed the move. The BJP does not have a majority in Parliament, so the support of its allies is crucial.

Initially, the government defended the lateral entry positions. On August 19, Union minister Ashwini Vaishnav said that these were "temporary recruitments" and would not impact the reservation system in regular open-

But just a day later, his colleague in the Union Cabinet, Personnel Minister Jitendra Singh told the Union Public Service Commission that the advertisement needed to be withdrawn "in pursuit of social justice and empowerment".

Vaishnaw, too, spoke in a different voice. On Tuesday, he claimed that the withdrawal reflected the Modi government's commitment to the

"Babasaheb's Constitution". BR Ambedkar. who chaired the committee that drafted the Indian Constitution, was a

This is the second

time in a fortnight that the government has invoked "social justice" and the legacy of Ambedkar. On August 9, after the Union Cabinet turned down a suggestion from the Supreme Court to exclude more affluent members of the Scheduled Castes and Scheduled Tribes communities from the benefits of reservation under the "creamy layer" principle. Vaishnaw had said that the government was "committed to the Constitutional provisions

During the Lok Sabha election, the BJP had found itself on the defensive after the Opposition capitalised on the speeches of its leaders asking for the Constitution to be changed. The Opposition made the Constitution a rallying point in their campaign against the BJP. The ruling party tried to counter the narrative by pitting Muslims against the disadvantaged castes. But this evidently did not

'Compromising is a

compulsion' Political observers told Scroll that the matter of lateral entry to the civil services is a good example of how the pulls and pressures for the BJP have changed after the Lok Sabha elections when it comes to matters related to caste and reservation.

The policy for civil services from outside the usual bureaucratic setup was announced by the BJPled National Democratic Alliance government in 2018. Between then and May 2023, four rounds of lateral entry recruitments were conducted.

The Lok Janshakti Party was part of the ruling alliance throughout this period, and the Janata Dal (United) and the Hindustani Awam Morcha for the majority of the duration. None of these parties raised objections to the policy then. Neither did the BJP itself talk about towing the "social justice and

empowerment" line. However, this time, Lok Janshakti Party's Chirag Paswan made sure to publicly demand the withdrawal of lateral-entry positions. After the withdrawal was announced, he claimed his share of credit, saying that he had been in touch with the prime minister on the matter.

Harish Wankhede, assistant professor at the Centre for Political Studies in Jawaharlal Nehru University, said that the BJP falling short of a majority of its own in the Lok Sabha has enthused parties like the Lok Janshakti Party and Janata Dal (United) to assert the interests of the social groups they represent.

'The Lok Janshakti Party has won five seats due to its voter base among the Dalits, so even for its own survival it needs to put pressure on the government on matters," he said. "The BJP needs the support of these parties so compromising is a compulsion for it." Political scientist Verniers said it was not only pressure from the

allies that had forced the Modi government to rethink its stance. "For states like Uttar Pradesh, where the BJP does not have any major allies, it needs to recalibrate for its own good," he said.

Wankhede agreed with this view. "If you look at the [Lok Sabha election] results in states like Uttar Pradesh, Maharashtra and Karnataka, the Dalits and OBCs Other Backward Classes] did not see BJP as their first choice and many of them have moved towards the Congress and its allies," he said. "The BJP has now realised that if this trend continues it could face even bigger losses in state elections.'

The limits of welfare One of the key ingredients of the BJP's success since 2014 especially in the Hindi belt – was its success in stitching together a social coalition of non-Yadav backward caste communities and non-Jatav Dalits by giving them more representation. In Uttar Pradesh, this coalition overwhelmed the Samajwadi Party's support among Yadavs and that of the Bahujan Samaj Party among Jatavs.

Along with this, the Modi government at the Centre introduced a slew of cash transfer schemes for rural families that gave rise to what political observers called the "labharthi factor" - it was assumed that beneficiaries of such schemes had emerged as a separate voter bloc transcending their social identities.

The 2024 Lok Sabha verdict, however, has led to a reassessment of the idea that welfare can trump caste inequity.

Ajay Gudavarthy, a professor of political science, said that in the Lok Sabha elections, the Opposition parties were successful in cornering the BJP by consistently attacking its leaders for their comments about changing the Constitution. The Samajwadi Party also effected deft social engineering in its ticket distribution suring greater representation for Dalits and non-Yadav classes, he said.

In its internal assessment, the BJP itself identified an erosion in Dalit and OBC votes over matters of reservation and the Constitution as a reason for its poor performance in Uttar Pradesh. But only anxieties about the BJP undermining reservations could not have reduced the party's tally in the Lok Sabha from 62 seats in Uttar Pradesh in 2019 to 33 in 2024, Gudavarthy said. Also in play were factors such as unemployment and ecodistress that blunted the "labharthi factor", he said. "Modi's brand of wel-

farism is aspirational in which he asks people to be atmanirbhar [self-reliant], and become job givers instead of job seekers, but ground realities do not match this rhetoric," said Gudavarthy. "The BJP has lost the momentum generated by aspiration and once that happens there is bound to be backlash over more permanent factors like social backwardness.'

Verniers also agreed that the 2024 elections showed that social welfare schemes cannot be milked indefinitely to compensate for the lack of job creation and unequal wealth distribution.

"The Opposition has taken the opportunity to link joblessness and economic distress to issues like reservation to mobilise people against the government," Verniers said. "This is a challenge that the BJP has not had to face earlier." (Courtesy: Scroll.in)

## Why India needs a secular civil code

s India approaches its 76th Republic Day, the question of whether laws should be shaped by religion or remain universally applicable becomes ever more urgent

Prime Minister Narendra Modi, in his Independence Day address from the ramparts of the Red Fort, dispelled all misconceptions and rumours about the stability and strength of his coalition and showed that he has complete control over the government. His address also revealed that his goals have remained the same. His speech was filled with energy and strong determination,

He stressed the implementation of the Secular Civil Code (SCC). He said the Supreme Court has repeatedly discussed and given orders on the Uniform Civil Code (UCC) because a large section of the country feels, and it is correct, that the present civil code is a communal and discriminatory civil code. There is no place for them in modern society.

The need of the hour is a Secular Civil Code (SCC).

The Prime Minister's use of the phrase "Secular Civil Code" was interesting. A "Secular Civil Code" (SCC) was used instead of the possible "Uniform Civil Code" (UCC) so that opposition parties could support it appropriately.

On November 23, 1948, Article 44 was introduced in the Constituent Assembly by Dr B R Ambedkar as draft Article 35 and was unanimously passed. "Uniform Civil Code for the citizens – The State shall endeavour to secure a Uniform Civil Code throughout the territory of India for the citizens.'

So states Article 44 of our Constitution. During the Constituent Assembly discussion, amendments were moved by Hussain Imam and some other members, "That any group, section or community or people shall not be obliged to give up its own personal law in case it has such a law, and, provided that the personal law of any community which is guaranteed by the statute shall not be changed except with the previous approval

of the community." Dr. B. R. Ambedkar, in his reply to the discussion, stated that our country has a Uniform Code of Laws covering nearly every aspect of human relations. We have a uniform and comprehensive criminal code throughout the country, contained in the Penal and

Criminal Procedure codes. We also have the law of transfer of property, which deals with property relations and applies throughout the country. Additionally, there is the Negotiable Instruments Act, among other acts, which proves that this country has practically a civil code that is uniform and

applicable throughout the country. Dr Ambedkar argued in the Constituent Assembly that the Uniform Civil Code should be viewed as a secular law applicable to all. In 1985, the former Chief Jus-

tice of India, YV Chandrachud, shared similar views

during the 'Shah Bano' case. This case revolved around Shah Bano Begum, a Muslim woman who had sought maintenance under Section 125 of the Code of Criminal Procedure after her divorce.

The initial judgment ruled in her favour. However, her husband, Mohammed Ahmed Khan, appealed to the Supreme Court, arguing that Section 125 should not apply to Muslims as it contradicted Muslim Personal Law. The Supreme Court disagreed with this contention, asserting that Section 125 applies to all individuals, irrespective of religion or personal law, and dismissed the husband's petition.

Eminent Muslim jurists like Chaudhary Haider Hussain and former Chief Justice of Bombay High Court M C Chagla had also strongly upheld Article 44 (UCC). In the case of John Vallamattom vs Union of India in 2003, the Supreme Court once again expressed regret that Article 44 of the Constitution had not been implemented. The Supreme Court also asked the government if they were ready to implement the Uniform Civil

Next year, on January 26, 2025, when we celebrate the 76th Republic Day, we must ask ourselves: "Do we want to continue living in an era where laws are based on religion, gender, or any other class or community?"

If the answer is NO, then the Secular Civil Code (SCC) must be implemented. Implementing the Uniform Civil Code (UCC) would be equivalent to fulfilling the vision of Dr. B. R. Ambedkar because the codification of laws should be independent of any spe-

cific religion. The current times require a secular civil code, leading to freedom from religious discrimination.

## Decoding the Bangladesh crisis through the lens of Kautilya outer, outer-outer, and inner-inner),

The recent ousting of the longestserving Prime Minister of Bangladesh, Sheikh Hasina, by a mass movement which started as a student protest has caught the world's attention for both the suddenness of the event and the vandalism on display. The resignation and escape of Hasina may have been swift but the angst and disgruntlement portraved by the mass protesters point to a deener rot in the political establishment of which the reinstated job quota is perhaps, only a tipping point. For Kautilya, Hasina has broken the social contract and has failed to achieve yogakshema (security and prosperity) for the citizens of Bangladesh.

Power is not success Hailed by the World Bank as the 'country on a mission' Bangladesh has seen rapid economic growth in the past two decades. The gross domestic product (GDP) of Bangladesh grew to US\$446.35 billion in 2023, an increase of about US\$253 billion since 2014. Recent macroeconomic headwinds notwithstanding, the moderated growth of fiscal year 2023 is projected to edge up in FY 2024.

Bangladesh ranks third in terms of military expenditure in South Asia and ranks 37 of 145 countries on the global firepower index. With these economic and military indices of comprehensive national power, why have things come to such a pass? Kautilya, an ancient Indian strategist, would reason that the swami (ruler) and amatya (council of ministers), making the two most important constituent elements (ranking higher than economic and military might) of the Kautilyan state, were in disarray and inept in translating the possession of strength (power) to the happiness of the people (success).

The ancient political treatise on statecraft, Arthashastra, is categorical about the roots of popular uprisings-"The use of peace and other policies not in the prescribed manner is a wrong policy. From that springs dan-

vice to the political leadership facing these challenges is categorical too-

"The ruler should not allow causes of decline, greed, and disaffection among the subjects to arise, and if arisen, should immediately counter-act them. Kautilya squarely puts the blame on a wrong policy enunciated by the ruler and the ruling class as the reason for popular revolt.

In this context, the most notable statement coming from Sheikh Hasina's son, Sajeeb Wazed Joy, is the admission of mistakes in handling of the student protests—perhaps, too little and too late.

Let us assess the addressal of what States (US) is seen the symptom of t h e graver problem of disaffection a n d m i s trust of t h e

Awami League rule—the student protest. Far from acknowledging the problem raised, the Hasina government detracting from the Kautilyan rules of engagement with the multitude of people, cracked down on the masses.

The Kautilyan toolkit provides an array of remedial and suppressive approaches to tackle internal security challenges but is clear about seeking success over the people only through means excepting force—conciliation, gifts, exemption, and employment.

Rajamandala dynamics Notwithstanding the internal fissures and general resentment, a 'foreign hand' cannot be ruled out. The Arthashastra delineates four kinds of dangers in the realm of internal security based on the origin of instigation and the response (outer-inner, innertageous, and Kautilya would prescribe the use of only sama (conciliation) and dana (gift-giving). united based on its national interests. Dhaka's attempts to diversify by placing some eggs in the China basket have ruffled feathers in Washington which would use any opportunity to place a more pliant government. Additionally, a tumultuous neighbourhood on a previously relatively secure border, a potential revival of cross-border terrorism, and a US-backed establishment in Dhaka could arguably keep Washington's strategic partner in the region—India—hemmed in, particularly when Delhi's independent deciests in the region and beyond. Kautilya would sanction the udasina's move (the US in this context) intent on allowing the weaker partner to neither become too powerful nor too weak.

China is the madhyama which (almost) sits abutting the territories of Bangladesh (vijigishu) and Myanmar (potential enemy), is stronger than the two put together, and can keep them united or disunited in pursuance of its political goals. While the Hasina government may have been favourable to China, its proximity with India and her effective crackdown on anti-India terror groups in Bangladesh could arguably propel China to fan the people's movement and destabilise yet

another border of India. Pakistan is an innate enemy by birth. It is also in league with China and shares Beijing's inimical disposition towards India. There are intelligence reports that have identified the student wing of Jamaat-e-Islami as having played a pivotal role, with evidence of training in Afghanistan and Pakistan. The possible return of Khaleda Zia with an anti-India stance would serve Islamabad's interests.

India is a mitra (ally) for Bangladesh. Hasina gained Delhi's patronage with deft diplomacy, without losing out on lucrative deals from its adversary in the region. With the red lines met and Dhaka broadly identifying with India, Delhi's friendship was mutually beneficial, even as anti-India sentiments among Bangladeshis was on the rise.

Hasina's external parleys with regional and great powers have followed the Kautilyan handbook-hedging, leveraging its neutrality to strike deals, and rarely crossing the set red lines. But she failed to ascertain the pulse of the citizens. Robustness in domestic security is key, both for sound political legitimacy and for safeguarding itself from the machinations of external powers. Internal security is the bedrock of successful strategic autonomv. (Courtesv: ORF)

JAKARTA, Aug 22: Thousands of protesters attempted to storm Indonesia's parliament on Thursday, tearing down a section of fence and throwing stones at police, and forcing the legislature to delay a vote on controversial changes to election laws that could further enhance the political influence of outgoing President Joko Widodo.

Parliament was to meet in an emergency session in order to overturn one decision made by the country's Constitutional Court on election procedures, while amending another.

The Constitutional Court court on Tuesday dismissed a challenge to an age limit that prevents people younger than 30 for running

for regional governorships, which would prevent the Widodo's 29year-old youngest son, Kaesang Pangarep, from running in a regional contest in Central Java.

The court also made it easier for political parties to nominate candidates by cutting back a requirement that they hold 20% of a local legislature.

Parliament passed an emergency motion to changing the minimum age to serve as governor to 30 at the time of inauguration and further ease nomination requirements on Wednesday, and planned to ratify the vote in a plenary session on Thursday.

The moves triggered widespread condemnation on local social media and raised concerns about a potential constitutional crisis.

The legislature was forced to



delay the vote after failing to achieve a quorum.

Widodo's eldest son, Gibran Rakabuming Raka, is the incoming vice-president after the same court created an exception to the age limit for the post for former regional leaders, while Widodo's brother-in-law was serving as chief justice. He was criticised for participating in a case involving a close relative and later dismissed. Activists, students, workers, and a number of Indonesian celebrities and musicians also joined the protest, voicing concerns about democracy in Indone-

Protests were also reported in other big cities, including Bandung, Yogyakarta, Surabaya and

In Yogyakarta, at least 1,000 protestors including students and workers rallied in front of Yogyakarta's Parliament building, the state palace and the city's cer-

emonial centre. Their demands included voting down the regional election bill, respecting the Constitutional Court's ruling and rejecting political dynasties.

The simultaneous protests in the major cities showed anger at Parliament's efforts to overruled the Constitutional Court decision to allow more candidates to compete in the regional elections, said Yoes Kenawas, a political analyst at Atma Jaya Catholic University.

## Zelenskyy visits border area for the first time since Ukrainian forces entered Russia's Kursk region

**KYIV, Aug 22:** President Volodymyr Zelenskyy toured the northeastern Ukrainian region of Sumy on Thursday in his first visit to the border area since his forces entered Russian territory more than two weeks ago.

After a meeting with Ukraine's military commander, Zelenskyy said Ukrainian forces have claimed control of another settlement in the Russian region of Kursk and taken more Russian prisoners of war whom he hopes to exchange for captured Ukrainians. He referred to that as Ukraine's "exchange fund."

"Another settlement in the Kursk region is now under Ukrainian control, and we have replenished the exchange fund," Zelenskyy wrote on the social media platform X after hearing a report from the military commander, Col. Gen. Oleksandr Syrskyi.

But the gains there come as Ukraine continues to lose ground in its eastern Donetsk region. The Russian Defense Ministry announced on Thursday that its military has claimed control of the village of Mezhove.

Ukraine's push into Russia marks the first capture of Russian territory since World War II.

It comes as both sides in the war use drones to attack far within enemy lines.

A Ukrainian drone attack on Thursday sparked a fire at a military facility in southern Russia as Kyiv pushes its offensive in the Kursk region and struck key infrastructure including bridges.

Andrei Bocharov, governor of the Volgograd region, said on Thursday that a "defense ministry facility" was on fire after being attacked by drones in the area of Marinovka, in a sign that Ukraine is not letting up on its attacks. He did not specify what was dam-

aged. Ukraine attacked Russia overnight with 28 drones, Russia's Ministry of Defense said. Thirteen were shot down over the Volgograd region, seven over the Rostov region, four over the Belgorod region, two over the Voronezh region, and one each over the Bryansk and Kursk regions, the ministry said.

Russian Telegram channels said drones attempted to attack a military air base near Marinovka in the village of Oktyabrsky. Videos shared on Russian social media showed an explosion in the night sky, reportedly near the base. Marinovka is about 300 kilometers (185 miles) east of the Ukrainian border and about the same distance west from the bor-

Ukraine claimed responsibility

Ukraine's Security Service and the Special Operation Forces of the Armed Forces of Ukraine conducted the drone attack on Wednesday night striking the Marinovka airfield in Russia, a law enforcement official told The Associated Press. The official spoke on condition of anonymity because he was not authorized to speak publicly.

The attack came as the ground offensive in Russia's Kursk region rattles the Kremlin. The daring operation could involve as many as 10,000 Ukrainian troops backed by armor and artillery, military analysts say.

The Baza Telegram channel, which is close to Russian law enforcement, said one drone was taken down several kilometers (miles) from the airfield near Marinovka and that wreckage from another fell on a trailer near the air base, causing it to catch

Data from NASA fire satellites, which monitor Earth for forest blazes, showed fires breaking out around the air base's apron, where fighter jets were previously seen

Another fire burned on Thursday in Russia's Rostov region, where firefighters struggled for the fifth day to put out a fire at an oil depot in the town of Proletarsk caused by a Ukrainian drone attack Sunday.

Russian state television channels have largely avoided covering the attack. Russian Orthodox priests visited Proletarsk to pray for injured firefighters.

Independent Russian Telegram channels said another powerful explosion was heard Wednesday evening and shared videos of a fireball burning in the night sky. State news agency Tass said 47 people were injured while putting out the blaze, but firefighters succeeded in stopping fires in six fuel

Satellite photos from Planet Labs PBC analyzed on Thursday by The Associated Press showed the fire at the oil depot still intensely burning as of Wednesday. Storage tanks at the facility appeared engulfed in flames. Visible flames could be seen in the images, with a thick black smoke cloud drifting west over the city of Proletarsk.

Kursk's acting governor, Alexei Smirnov, said authorities began putting up concrete shelters at bus stops and other locations around the city on Thursday to protect from shelling.

He said similar work will be done in Zheleznogorsk and Kurchatov, where the Kursk nuclear power plant is located. (AP)

## Putin meets China's Premier Li as Moscow and Beijing deepen their relations



MOSCOW, Aug 22: President Vladimir Putin met with Chinese premier Li Qiang on Wednesday, hailing growing trade relations as Moscow becomes increasingly dependent on Beijing for political and economic support.

"Our trade relations are developing, developing successfully ... The attention that the governments of the two countries on both

sides are paying to trade and economic ties is yielding results," Putin said at the meeting in the Kremlin.

He also said that Russia and China have developed "large-scale plans" for economic and other projects.

"Chinese-Russian relations are at an unprecedentedly high level," said Li, who earlier had met with his Russian counterpart, Prime Minister Mikhail Mishustin. The meeting took place as Russia struggled to push back a Ukrainian incursion into the Kursk region now in its third week. And overnight, Moscow experienced one of the largest waves of drone attacks on the Russian capital since the start of the Ukraine conflict.

Russian news reports did not indicate whether Putin and Li discussed Ukraine. China has tried to position itself as neutral in the Ukraine conflict, but it shares with Russia high animosity toward the West.

After Western countries imposed heavy sanctions on Russian oil in response to Russia sending troops into Ukraine in February 2022, China strongly stepped up its purchase of Russian oil, increasing its influence in Russia. Putin underlined the importance of China by meeting in Beijing with Chinese

leader Xi Jinping soon after being inaugurated for a fifth term in the Kremlin. A U.S. intelligence assessment released this year indicates that China has significantly increased sales to Russia of machine tools, microelectronics and other technology Moscow uses to produce missiles, tanks, aircraft and other weaponry.

## **US** reaffirms 'commitment' to advancing human rights of Tibetans

**WASHINGTON, Aug 22:** A top US government official met with the Dalai Lama and, on behalf of President Joe Biden, reaffirmed the US' "commitment" to advancing the human rights of Tibetans and supporting efforts to preserve their distinct historical, linguistic, cultural, and religious heritage.

The Dalai Lama, 89, is recuperating in New York since he underwent a successful knee replacement surgery on June

Tibetan spiritual The leader's meeting with the top US State Department official comes months after President Biden signed into law a bill which enhances US support for Tibet and promotes dialogue between China and the Dalai Lama toward a peaceful resolution of the dispute over the status and governance of the remote Himalayan region.

China had opposed the 'Resolve Tibet Act' -- passed by the House of Representatives last February and cleared by the Senate in May -- and described it as "destabilising."

President Biden's message to the Dalai Lama was conveyed by Uzra Zeya, the US Under Secretary of State for Civilian Security, Democracy, and Human Rights and Special Coordinator for Tibetan Issues, who travelled to New York for an audience with the



Dalai Lama on Wednesday, a statement from the Department of State release said here.

"During the audience, Zeya conveyed, on behalf of President Biden, best wishes for His Holiness's good health and reaffirmed the US commitment to advancing the human rights of Tibetans and supporting efforts to preserve their distinct historical, linguistic, cultural, and religious heritage," the statement said.

Welcoming Dalai Lama's "lifelong dedication to promoting nonviolence and compassion," Zeya also took the opportunity to discuss with the spiritual leader about "Tibetan cultural preservation, the United States' ongoing efforts abuses inside Tibet, and sup-

## Russian climbers reach Kennedy campaign's future in question as Trump allies lobby for endorsement hospital after rescue in Pakistani Himalayas



PESHAWAR, Aug 22: Two Russian climbers who were injured on the slopes of one of northern Pakistan's highest mountains reached a hospital in Peshawar on Thursday, a week after they were stranded after being hit by falling ice.

The climbers were part of a five-member team of Russian climbers that was attempting to climb one of Gasherbrum's peaks to retrieve the body of a fellow climber who died there last year when it was hit by a pile of ice on Friday.

Rescuers airlifted two of the mountaineers Monday, but two others remained stuck on the base camp because of their injuries and bad weather until on Wednesday. Akhtar Hussain, a police official in Skardu, a city in Khyber Pakhtunkhwa provinces, said the Russians were transported to a hospital by ambulance, and were in stable condition.

Karrar Haidri, the secretary of the Alpine Club of Pakistan, told The Associated Press that climbers Mikhail Mironov and Sergei Mironov are getting the best medical care at a hospital in Skardu.

He said the search for the fifth climber, Sergei Nilov, had been called off as he is presumed dead. Hussain said doctors provided medical care to the two injured climbers.

"They are sad over the death of their fifth colleague, but are thankful to the Pakistani rescuers and the army for making efforts to save their life," he said.

He said one needed only minor medical care, while the other had bruises on his arms and legs because he was hit by the pile of ice on Friday

Haidri said the climbers were fully aware of the dangers linked to the mission when they began expedition to retrieve the body of their colleague whodied in 2023 on the same mountain while trying to scale it.

Hundreds of climbers try to scale mountains in northern Pakistan every year, and accidents are common because of avalanches and sudden weather changes. This month, a Pakistani climber Murad Sadpara, 35, known for taking part in high-altitude rescue missions died during a descent from one of the country's tallest mountains in the north. (AP)

PHOENIX, Aug 22: Close allies to Donald Trump are quietly urging independent presidential candidate Robert F. Kennedy Jr. to endorse the Republican nominee if he withdraws from the campaign for the White House as soon as this week.

Trump's son, Donald Trump Jr., along with former Fox News host Tucker Carlson and GOP donor Omeed Malik are among those who have been working behind the scenes to lobby Kennedy to drop out of the race and back Trump, according to a person familiar with the efforts. The person requested anonymity to discuss private con-

Kennedy will speak Friday "about the present historical moment and his path forward." his campaign announced Wednesday, fueling growing speculation that he could drop out and support Trump. Kennedy's running mate openly discussed the possibility on a podcast this week, saying the campaign was considering a move to "join forces" with Trump to limit the election chance of Kamala Harris, whose Democratic convention winds up Thursday night in Chicago.

The move would have once seemed unthinkable for Kennedy, a Democrat for most of his life and — as the nephew of President John F. Kennedy and the son of Robert F. Kennedy — a member of a



beloved Democratic dynasty.

Trump speaks from behind bulletproof glass at first outdoor rally since his attempted assassinationLast month, during the Republican National Convention, Kennedy's son posted and then quickly deleted a video showing a phone call between Kennedy and Trump, in which the former president appeared to try to talk Kennedy into siding with him.

Kennedy will give a speech in Phoenix, hours before Trump is scheduled to hold a rally in neighboring Glendale. A spokesperson for Kennedy, Stefanie Spear, declined to say whether he planned to drop out or why he chose Arizona for his speech.

Trump and Kennedy have been in regular contact in recent weeks, including a meeting in Milwaukee as Republicans gathered for their national convention last month. He told CNN on Tuesday that he would "love" an endorsement from the independent candidate, whom he called a "brilliant

He also said he would "certainly" be open to Kennedy playing a role in his administration if Kennedy drops out and endorses him instead. "He's a very smart guy. I've known him

for a very long time," Trump told the net-

work. "I didn't know he was thinking about getting out, but if he is thinking about getting out, certainly I'd be open to it." Trump, who had previously railed against Kennedy as "the most radical left candidate in the race," was also asked by CNN If he would consider appointing

he wins in November. "I like him a lot. I respect him a lot," Trump said. "I probably would, if something like that would happen. He's a very different kind of a guy — a very smart guy. And, yeah, I would be honored by that en-

The news comes a little over a week since a New York judge ruled that Kennedy should not appear on the ballot in the state because he listed a "sham" address on nominating petitions. Kennedy has appealed, but has faced several similar challenges around the country.

On Wednesday, he was in a courtroom in a suburb of New York City, testifying in a trial for another ballot lawsuit in the state, this one backed by the Democratic National Committee, that challenges the signatures collected by his campaign.

During a break in the court proceedings, Kennedy declined to answer questions from reporters about whether he was dropping out. He's also facing a likely legal challenge in Arizona, where last week he submitted signatures that may have been collected by a super PAC that supports him, which Kennedy's critics say is illegal coordination between a candidate and an independent political group. IMPHAL, Aug 22: Ten Kuki Zo legislators of Manipur have urged the judicial commission which is probing the ethnic violence in the northeastern state to expedite its probe in the wake of the alleged audio clip of Chief Minister N Biren Singh.

He must also be immediately debarred from the office of chief minister so that he is prevented from influencing the outcome of the probe against

The Congress government's move comes within a week of the Governor granting sanction for prosecution of Chief Minister Siddaramaiah in the Mysuru Urban Development Au-

"To take decisions in the pending cases at the earliest and to smoothen the judicial process, under article 163 of the Constitution the Cabinet can give aid and advice to the Governor. Using it, the Cabinet has given its approval to give the Governor aid and advice," Law and Parliamentary Affairs Minister H K Patil said.

Briefing reporters after the Cabinet meeting, he said: "the advice will be sent to the Governor."

"Out of the four cases that are pending regarding which we have given aid and advice, in two of these cases (Janardhan Reddy and Kumaraswamy) the charge sheet has been filed...," he added.

Asked whether the Governor can reject the Cabinet's aid and advice, Patil said: "According to us, he is bound by our advice; his discretion is limited. I am sure he shall use his discretion very judiciously.'

The Governor on August 16 accorded sanction against Siddaramaiah, under Section 17A of the Prevention of Corruption Act, 1988 and Section 218 of the Bharatiya Nagarik Suraksha Sanhita, 2023 for the commission of the alleged offences as mentioned in the petitions of Pradeep Kumar S P, T J Abra-

Patil said several petitions seeking his sanction for prosecution are pending before the Governor, including those submitted by the investigating agencies under the Prevention of Corruption Act, 1988; in some of these cases charge sheets have been filed.

"Sanctions have been sought under section 19 of Prevention of Corruption Act and under the provisions of criminal procedure code, which is now Bharatiya Nagarik Suraksha Sanhita (BNSS) -- section 197 and 218, also some applications are under section 17 A of the Prevention of Corruption Act,'

The Minister said, out of these petitions, special are against -- (former BJP Minister) Shashikala Jolle against whom application was submitted on December 9, 2021 by the Lokayukta police seeking prior approval under section 17 A of PC Act, and (former BJP Minister) Murugesh Nirani against whom application was submitted on February 26, 2024 for prior approval under section 17 A of PC Act.

The third is that of Kumaraswamy, against whom application was submitted on November 21, 2023, according to which approval for sanction was sought section 19 of the PC Act and provisions of BNSS, he said, adding, the Special Investigation Team (SIT) had filed a charge sheet, and the Governor had sought a clarification on the case July 29. 2024 and SIT had provided required clarification on August 16,

The Congress government on July 14 constituted a single member inquiry commission under former High Court Judge Justice P N Desai to probe the MUDA alternative site allotment 'scam'

"It needs to be looked into. I don't know. They (opposition) have made a statement. The SIT or the investigation agency, will look into it if necessary." Parameshwara told reporters, in response to a question. In the letter, Parvathi had sought alternative land in lieu of her 3.16 acres on which MUDA had formed

Opposition BJP and JD(S) claimed that whitener was used to erase a line in which Parvathi specifically sought alternative land in the posh Vijayanagar Layout.

Since the allegations surfaced against him, Siddaramaiah, denying any wrong doing, has repeatedly maintained that his wife did not seek alternative plots in any specific lo-

Further noting that BJP is protesting seeking Siddarmaiah's resignation, the Minister said, it is their right to protest, but there is no question of the Chief Minister resigning and there is no need for it

ter D K Shivakumar on Thursday appeared before the Lokayukta police for a probe in connection with a disproportionate assets (DA) case against him.

The Lokayukta police had in February registered a case against Shivakumar, following the Congress government withdrawing consent to the Central Bureau of Investigation (CBI) to probe the DA case against him on November 23, 2023, and referring the case to it.

Speaking to reporters after appearing before the Lokayukta, Shivakumar said: "Lokayukta had issued summons yesterday, I couldn't appear as I was on a visit to Almatti. So I had requested it for today and they had given me time today. For about three hours they have questioned me, they have inquired. I have answered them. They have sought for more documents, so I will submit them.

"After studying things", the Lokayukta will once again issue him a notice to appear, he said. "One thing is that CBI is better than them (Lokayukta). They are asking a number of questions and on different things. The CBI has not asked me anything yet, they haven't called me yet. But they (Lokavukta) have called me and are troubling me."

Noting that the case has been transferred by the State government from CBI to Lokayukta, Shivakumar said Lokayukta has been probing the case since the last six months. "...CBI should have stopped the investigation, but they have not stopped. They are harassing all my people. They have still not summoned me, but they are harassing a lot of my friends and relatives. More than hundred people have been harassed. Now these people (Lokayukta) have

The Supreme Court on July 15 dismissed a petition filed by Shivakumar challenging the CBI's FIR against him in the DA case. The Supreme Court, bench of Justices Bela M Trivedi and S C Sharma had said it was not inclined to interfere with the Karnataka High Court order.

The top court was hearing a plea filed by Shivakumar against the October 19, 2023 order of the High Court which rejected his plea. The HC had also directed the CBI to conclude the investigation and file the report within three months. The CBI has alleged that Shivakumar amassed assets disproportionate to his known sources of income between 2013 and 2018. He was a minister in the then Congress government during this period.

The FIR was filed by the CBI on September 3, 2020. Shivakumar challenged the FIR in the High Court in 2021.

The previous BJP government had granted sanction to the CBI to prosecute Shivakumar, following which an FIR was lodged against him and investigation undertaken on alleged charges of disproportionate assets.

The current Karnataka cabinet headed by Chief Minister Siddaramaiah on November 23 last year held that the previous BJP government's move to give consent to the CBI to investigate the DA case against Shivakumar was not in accordance with law and decided to withdraw the sanction. Subsequently a government order was issued in this regard. Based on the Income Tax Department's search oper-

ations in Shivakumar's home and offices in 2017, the Enforcement Directorate started its own probe against

#### Ayodhya gang-rape accused Moid Khan's shopping complex demolished

## Solvent leak could have triggered fire in AP pharma unit: Official ATCHUTAPURAM (ANDHRA them and their families. I gave the

PRADESH), Aug 22: A suspected solvent leakage could have triggered a blaze in a pharma unit here that has killed 17 persons, a senior official said on Thursday.

Andhra Pradesh Chief Minister N Chandrababu Naidu visited the injured persons at a hospital in Visakhapatnam and announced exgratia of Rs one crore to the kin of victims. He also assured necessary precautions to prevent such incidents in future.

Anakapalli district Collector Vijaya Krishnan told PTI there was no rise in the death toll which stood at 17 following the accident on Wednesday.

"The actual cause is yet to be ascertained," she said, adding preliminary assessment pointed to solvent leakage from a pipe which fell on an electric panel, leading to the fire accident.

Vijaya Krishnan observed that a suspected solvent leakage could have triggered the blaze in the plant of Escientia Advanced Sciences Pvt Ltd here, leading to the death of 17 persons and injuries to 33. The Anakapalli district Collector told PTI that there was no rise in the death toll which stood at 17 following the accident on Wednes-

"The actual cause is yet to be ascertained," she said, adding preliminary assessment pointed to solvent leakage from a pipe which fell on an electricity panel, leading to the fire accident.

The Chief Minister who met the injured persons undergoing treatment at a hospital, said ₹ 50 lakh would be given to severely injured workers and ₹ 25 lakh to the iniured persons.

Promising to take necessary precautions to avoid these kinds of accidents in future, the CM wished for the speedy recovery of the workers undergoing treatment.

Though it is being reported the accident occurred due to a reactor blast, officials said when solvent oil was being pumped from one floor to another it led to leakage and resulted in a blaze followed by a large explosion, according to a post on 'X' by the Office of the Deputy Chief Minister of Andhra Pradesh, K Pawan Kalyan.

Relatives of the affected workers continue to wait anxiously at the pharma company, eager to know the fate of their loved ones.

"I want my father back and this company removed...," a minor girl told a vernacular news channel, referring to her father, who was employed in the firm.

The sister of a victim complained that authorities were not showing where her brother was while a sobbing elderly woman demanded the return of her son-inlaw. Harrowing scenes unfolded with injured workers -- their skin ripped and peeling off, bodies soaked in blood -- being shifted to hospitals in ambulances after the incident occurred at 2.15 pm on Wednesday at Escientia Advanced Sciences Pvt Ltd.

The company, which manufactures intermediate chemicals and active pharmaceutical ingredients (API) commenced production in April 2019 with an investment of ₹ 200 crore.

which it has completed only 16,000 hours. It is pertinent to mention here that we directly purchase engines only from Lycoming Engines, USA. We do not use locally overhauled engines," it

A search was launched in the dam after a pair of shoes was found floating that was subsequently recovered and identified,

"This led us to the fear that the point of incidence would be in the dam itself. The initial search was conducted by Tata Steel's helicopter and with our own aircraft with all our efforts. Subsequently, the weather deteriorated and the operation was resumed by land vehicles and the local police were informed. The local government authorities were then informed and a massive search and rescue operation was launched with the help of the National Disaster Response Force (NDRF)," the company said.

The Indian Navy was then called for help and it deployed a Sonic Navigation and Ranging (SONAR) device, which would assist in identifying the exact position of the incident, it said.

"In this hour of distress, we stand with the family of our dear pilots who were involved in this incident. We mourn the loss of the pilots, which has been the biggest loss for us yet. ## **Delhi Police busts Al Qaeda terror module**



NEW DELHI, Aug 22: The Delhi Police on Thursday claimed to have busted an Al Qaeda terror module after detaining 14 people from Jharkhand, Rajasthan and Uttar Pradesh.

After receiving intelligence inputs, an operation was conducted along with the police forces of the states, officials said.

"The module, as per state of operations, was being led by one Dr. Ishtiyaq of Ranchi (Iharkhand), and it was aspiring to declare 'khilafat' and execute serious terrorist activities within the country," a Delhi Police statement said. The members of the terror module were trained, including in handling weapons, at various locations, it said.

The statement said six people were detained from Bhiwadi in Rajasthan while they were undergoing training to handle weapons, and eight from Jharkhand and Uttar Pradesh for questioning, it said. They are being interrogated and additional detentions are anticipated. Raids are being conducted to recover arms, ammunition and documents, the officials said. (PTI)

NEW DELHI, Aug 22: In a bid to sustainable river management, a Smart Laboratory on Clean Rivers (SLCR) has been developed at IIT-BHU to rejuvenate small rivers through innovative and sustainable approaches, the Jal Shakti ministry said. This initiative, part of the

Green Strategic Partnership between India and Denmark, aims to rejuvenate small rivers through innovative and sustainable approaches, the ministry said in an official statement.

The SLCR project is designed to rejuvenate the Varuna River, leveraging cutting-edge technology and international expertise.

With an initial funding of Rs 16.80 crore from Ministry of Jal Shakti and an additional grant of Rs 5 crore from Denmark, the project aims to create



a collaborative platform for government bodies, academic institutions and local communities to develop and implement solutions for clean river water.

A hybrid lab model will be established at IIT-BHU, coupled with an on-field living lab at the Varuna River. This model will allow for real-world testing and scaling of solutions aimed at improving river health, the statement said. The SLCR's institutional framework includes a robust appraisal mechanism to ensure excellence and diligence in project execution.

The Indo-Danish Joint Steering Committee (JSC), the highest authority within the SLCR, will provide strategic guidance and review the project's progress. Additionally, a Project Review Committee (PRC), comprising members from the National Mission on Clean Ganga (NMCG), Central Water Commission (CWC), Central Ground Water Board (CGWB), IIT-BHU and Denmark's Urban Sector Counsellor, will oversee quality control at the project level.

Coordination efforts will be managed by the Multi-Stakeholder Working Group (MSWG), chaired by the district magistrate of Varanasi and co-chaired by representatives from NMCG and IIT-BHU.

The SLCR Secretariat, a joint establishment of NMCG and IIT-BHU, will handle dayto-day operations, project development and knowledge dissemination.

The Joint Steering Committee has already cleared four key projects under the SLCR initiative. Among them is the development of a Decision Support System (DSS) for water management aimed at analysing basin water dynamics through advanced hydrological models and data analytics.

This project, expected to last two to three years, will facilitate real-time monitoring and scenario simulations to support holistic planning and effective water management.

Another vital project focuses on the characterisation of emerging pollutants in the Varuna River. Over the next 18 months, advanced analytical techniques will be employed to identify and quantify contaminants, creating a comprehensive fingerprint library for water quality monitoring and proposing effective remediation strategies, the statement said. (PTI)

## Auto, taxi drivers begin 2-day strike in Delhi-NCR

NEW DELHI, Aug 22: Commuters in Delhi-NCR faced a tough time as taxi and autorickshaw drivers began their two-day strike on Thursday demanding better compensation from cab aggregator services.

bike taxis that offer services using non-commercial numberplates. "The government should step in and ban the commercial plying of vehicles with noncommercial numberplates. It is becoming difficult to make ends meet," he said.

Adarsh Tiwari, another cab driver, said, "The companies offer us very less rate for our services. Due to this, we are unable to pay the installments of our vehicles and meet other expenses. We are unable to ensure good education for our children and sufficient food for our families."





# Morally ambiguous characters more interesting: Bill Skarsgard on 'The Crow'

**NEW DELHI, Aug 22:** Hollywood star Bill Skarsgard, who is playing the lead role in the upcoming film "The Crow", says he is drawn to movies that explore conflicts within its characters.

Skarsgard, who is the son of Stellan Skarsgard and brother to actors Alexander, Gustaf and Valter Skarsgard, is popular for essaying the role of Pennywise the Dancing Clown in the horror movie "It" and its sequel. He was also the lead villain in "John Wick: Chapter 4".

In "The Crow", a reboot of the 1994 cult movie of the same name, the Swedish actor stars as Eric as well as the titular Crow, a musician who is resurrected and decides to avenge his and his fiancee's death.

"Morally ambiguous characters are more interesting to me than the traditional, straightforward, kind of black and white hero archetype. The more conflict within the hero, the more interesting.

"That's the kind of movie that I'm drawn to-

wards watching as well... If it's too black and white, it doesn't feel truthful to me," the 34-year-old actor told PTI in an international roundtable.

"The Crow" directed by Rupert Sanders will be released on August 30 in India by PVRI-NOX Pictures.

The 1994 original movie, which was directed by Alex Proyas, featured Brandon Lee, son of martial artist and star Bruce Lee, in his last film role. Brandon Lee, who was 28, died in an on-set accident while filming a key scene that involved him being shot.

Skarsgard said he watched Proyas' movie starring Brandon Lee and carried it "in spirit" but ultimately he wanted to play the character in his own way.

"This is the only way I know how to approach something, which is my way. This is a new story... Rupert's version of Eric was very different from the original. And that was the point," he added. (PTI)

SGPC chief Harjinder Singh Dhami, addressing a press conference, also sought the registration of an FIR against the Kangana Ranaut, the film's writer, director, producer and lead actor.

"Emergency", starring actor-MP Ranaut, is slated to hit the screens next month.

The release of the period political drama has been delayed multiple times; it was previously scheduled to be released on November 24, 2023.

Expressing strong objection, Gyani Raghbir Singh, Jathedar (head) of the Akal Takht, said it is clear from the released excerpts of the film that it has deliberately misrepresented the character of Sikhs as separatists, which is part of a deep conspiracy. This is a "despicable act" of

disrespecting the community by "creating an anti-Sikh narrative about the martyrs of June 1984", he said in a statement.

The community can never forget the anti-Sikh brutality of June 1984 and Ranaut's film is trying to character assassinate Jarnail Singh Khalsa Bhindranwale, who has been declared a Qaumi Shaheed (community's martyr) by Sri Akal Takht Sahib, Singh said.

Dhami said this film has been made by Ranaut, who remains in controversy due to her anti-Sikh and anti-Punjab statements, with the intention of "deliberately character assassinating" Sikhs, which the community cannot tolerate. He alleged that Ranaut has often deliberately made statements that provoked the sentiments of Sikhs, but instead of taking action against her, the government is protecting her.

He urged that the Lok Sabha MP be booked "for inciting religious sentiments of Sikhs for her act through the film Emergency".


He said the film could "cause a lot of anger and resentment in the Sikh community".

Dhami said in the past, there have been numerous instances where Sikh sentiments were hurt due to the misrepresentation of Sikh characters and the disregard for religious concerns in films.

He urged the Union Minister of Information and Broadcasting to impose an immediate ban on the "Emergency" film and said it should be ensured that no film with anti-Sikh sentiments is released from now on.

The SGPC president called for the inclusion of Sikh members in the Central Board of Film Certification (CBFC), claiming "biased decisions are being taken due to the absence of a Sikh member".

He said the SGPC has on several occasions passed resolutions in its general meeting to demand the inclusion of a representative of Sikhs in the CBFC, but the government is not meeting the demand. (PTI)



## Chaos at Chelsea: A high-risk, \$1.3B spending spree has left the club fractured and vulnerable

to come, the experiment unfolding at Chelsea under their American investors will be a fascinating case study in how to run a soccer club.

Because no one in England has ever seen anything like what has been happening at Stamford Bridge over the last two years.

Just take this in: Chelsea has spent nearly \$1.3 billion on 39 players across five transfer windows since a consortium fronted by Los Angeles Dodgers partowner Todd Boehly and Clearlake Capital bought the Premier League club from its long-time owner, Russian oligarch Roman Abramovich, for \$3.2 billion in

Throw in the club having four

different full-time managers in this period — plus another coach on a temporary basis — and the revolving door at Chelsea, a six-time English champion and two-time European champion, simply hasn't

stopped spinning. "It's not a mess like it looks from the outside," Enzo Maresca, the latest Chelsea manager, said Wednesday as he attempted to explain the wisdom behind taking the number of players in the squad to 43 by signing two wingers — Pedro Neto and Joao Felix — for a combined \$130 million over the past week. This while already having five wingers in the squad, including one — Mykhailo Mudryk - signed for more than \$100 million just last year and another — first signing of this unprecedented two-year trolley dash for nearly \$60 million.

Sterling has been stripped of his squad number following the arrival of Neto and is one of around 20 players "training apart," Maresca said. Among them is striker Romelu Lukaku, signed three years ago for a then-club record of \$135 million, and goalkeeper Kepa Arrizabalaga, the world's most expensive keeper signed for \$92 million.

## Germany goalkeeper Manuel Neuer retires from international soccer and will focus on Bayern

MUNICH, Aug 22: Germany goalkeeper Manuel Neuer said Wednesday he is retiring from the national team after 15 years and 124 games. He is staying in club soccer with Bavern Munich

The 38-year-old Neuer made his debut for Germany in 2009 and won the World Cup in 2014. His last game for the national team was the 2-1 extra-time loss to eventual champion Spain in the quarterfinals as Germany hosted Euro 2024.

Neuer said he was "tempted" by the prospect of staying on for the 2026 World Cup but decided against it after speaking with family and friends. That could open the door for Barcelona's Marc-André ter Stegen, who has played for Germany 40 times but never at a major tournament, to take over as starting goalkeeper.

"I feel very good physically and obviously would have been very tempted by the 2026 World Cup in the U.S.A., Canada and Mexico. At the same time I am convinced that now is the right time to take this step and to concentrate fully on FC Bayern Munich in the future," Neuer said in a statement. Neuer is the second leading player in the German team to retire from international soccer this week after midfielder Ilkay Gündogan, who captained when Germany exited Euro

He made history at the Tokyo Paralympics by becoming only the second Indian, after Pramod Bhagat, to win a gold medal, making his Games debut memo-

Now, as he prepares to defend his title, the 25-year-old from Jaipur is focusing on maintaining composure and playing it safe to replicate his success when he takes court at the Paris Games.

"This is my second Paralympics, and there is some nervousness because it's a big tournament," Krishna, who competes in the SH6 category, told PTI in an interview.

The SH6 category is for short stature athletes, who compete

## Faruque Ahmed takes charge as new BCB president

DHAKA, Aug 22: Former ing held at the Ministry of cricketer and chief selector Faruque Ahmed has replaced Nazmul Hasan Papon as the new president of the Bangladesh Cricket Board (BCB) after the incumbent resigned in the wake of the political unrest in the country.

The BCB held an emergency meeting on Wednesday during which the 58-year-old Ahmed was elected.

Papon, who was in his fourth term, has been in London with his wife following the political unrest in the country which began with a huge student protest against quotas in jobs.

The Sheikh Hasina-led Awami League regime was toppled as a result and there has been widespread violence despite an interim government taking charge.

Papon was an Awami League MP since 2009. He, along with 16 other directors, left Dhaka on August 5.

"I resigned as a selector in the past because I opposed the system. Now, I aim to create a system that can run the board smoothly," Faruque was quoted as saying by 'Cricbuzz' on Wednesday. Faruque played seven ODIs for Bangladesh between 1988 and 1999 and also served as a BCB chief selector for two terms -- from 2003 to 2007 and from 2013 to 2016. He resigned without completing his second term after disagreement over selection process. The National Sports Council (NSC) appointed Ahmed and Nazmul Abedin, a prominent local coach, as its new directors, replacing Jalal Yunus and Ahmed Sajjadul Alam. Following the announcement, they participated Youth and Sports.

The meeting was attended by directors Mahbubul Anam, former cricketers Khaled Mahmud and Akram Khan, Salauddin Ahmed, Kazi Inam Ahmed, Iftekhar Ahmed and Fahim Sinha. Shakib Al Hasan, who was a lawmaker in the Awami League, was cleared by Bangladesh's new interim government last week to face Pakistan in a two-match Test series.

"We will discuss Shakib's situation and whether he can continue under the current circumstances. We are also considering adding rules regarding player conduct during tours, including restrictions on endorsements," Faruque said.

Tamim Igbal, who had a rift with Shakib, last played for Bangladesh in a home ODI series against New Zealand ahead of the 2023 World Cup but Faruque backed the opener to continue playing for a few more years. "Tamim is a sensible player and one of the best from Bangladesh. Personally, if you ask me, I would want him to play for two-three more years. But me wanting that doesn't mean it will happen. We will have to see what his fitness is like and we have to see which formats will be feasible. Tests maybe difficult but it'll be good if it's ODIs," he said.

The new BCB president also reiterated his stance on not retaining Chandika Hathurusingha as the national head coach. "I am not sure about the details of the contract with Chandika Hathurusingha. I am still in the same place I was before. I haven't deviated from what I said (I will not keep Chandika if elected as BCB in the board of directors meet-president)," he said. (PTI)

## ICC to get new female director as Indra Nooyi's six-year term ends

DUBAI, Aug 22: The International Cricket Council is on the lookout for a new female independent director after PepsiCo head Indra Nooyi's six-year tenure came to an end last month.

The world body is also set to get new chairman after incumbent Greg Barclay's refusal to seek a third term. Nooyi, who became ICC's first independent woman director in 2018, has completed her full term.

It is understood that ICC's allpowerful board has already started looking for a high-profile name like Nooyi, who was one of the most sought after names in corporate world. "The Board of Directors shall elect one individual who must be a female and who must meet the Director Eligibility Criteria to ensure that equality, diversity and inclusivity interests in the sport of Cricket are appropriately represented from time to time, and such individual so elected shall be a Director (the "Independent Director")," the ICC statute makes clear. A source close to the all-



powerful ICC Board was asked about the exact criteria for the appointment and he said that it could be any woman of eminence -- be

it from corporate world or sports. "It could be anyone who has contributed in sports, business or in general. Just for example, it could be a Meg Lanning, a Charlotte Edwards or someone powerful from business community. Basically anyone who is eligible and person of eminence with contribution to sport," the source said.

The Independent Director will be elected for a first two-year term by the Board of Directors from a list of at least three recommendations provided by the Nominations Committee. She will also be eligible to vote during the chairman's

The next WTC cycle will run from 2025 to 2027 and it starts right after the final of the current cycle which will also be held in England.

The England and Wales Cricket Board (ECB) has strategically kept matches at venues where England's swing bowlers will enjoy distinct advantage. The second Test will be held at Edgbaston in Birmingham from July 2-6. The third Test will be held at the hallowed Lord's ground from July 10-14, while Old Trafford in Manchester will host the fourth Test between July 23-27. The tour concludes with the final Test at the Oval from July 31-August 4. There is a week's gap between first and second Test and eight-day interval between the third and fourth Tests giving players enough time to recuperate. (PTI)

## Chaos at Chelsea: A high-risk, \$1.3B spending spree has left the club fractured and vulnerable

come, the experiment unfolding at Chelsea under their American investors will be a fascinating case study in how to run a soccer club.

Just take this in: Chelsea has spent nearly \$1.3 billion on 39 players across five transfer windows since a consortium fronted by Los Angeles Dodgers part-owner Todd Boehly and Clearlake Capital bought the Premier League club from its long-time owner, Russian oligarch Roman Abramovich, for \$3.2 billion in May 2022.

Throw in the club having four different full-time managers in this period plus another coach on a temporary basis - and the revolving door at Chelsea, a six-time English champion and two-time European champion, simply hasn't stopped spinning.

"It's not a mess like it looks from the outside," Enzo Maresca, the latest Chelsea manager, said as he attempted to explain the wisdom behind taking the number of players in the squad to 43 by signing two wingers — Pedro Neto and Joao Felix — for a combined \$130 million over the past week.

This while already having five wingers in the squad, including one — Mykhailo Mudryk — signed for more than \$100 million just last year and an-

Among them is striker Romelu Lukaku, signed three years ago for a then-club record of \$135 million, and goalkeeper Kepa Arrizabalaga, the world's most expensive keeper signed for \$92 million.

Not much seemingly makes sense in Chelsea's brave new era.

"It's been a crazy one to follow so far," Dr. Dan Plumley, sports finance expert at Sheffield Hallam University, told The Associated Press, "and it shows no sign of slowing down.'

Plumley said the Chelsea owners' initial "aggressive" play in the transfer market to overhaul the squad was not unexpected, even if spending \$280 million in the summer of 2022, \$350 million in January 2023 and more than \$400 million in the offseason of that year was unprecedented for a soccer club. In the current window, the outlay is more than \$250 million on 10 players.

"You are thinking, That's the initial burst but now you have to rein it in a little bit," Plumley said in a phone interview. "But they seem to be carrying on, which raises a few question marks around what the actual strategy is there and what are the owners looking to do."

With their background in private equity and venture capital, Boehly and Clearlake are coming at soccer ownership very differently and have moved the goalposts in their efforts when dealing with the sport's financial fair-play constraints.

They've typically given contracts of seven-to-nine years to new signings to spread "amortization" costs of transfer fees across the whole deal. That prompted UEFA and then the Premier League to tighten their rules, and it's a risky strategy as a whole because it leaves Chelsea extremely vulnerable if the players recruited prove to be flops and can't be moved on.

They've focused on selling homegrown or academy players, essentially because they can be sold for pure profit in the annual accounts which facilitates the purchase of other more high-profile players on amortized deals. Hence the departures of Conor Gallagher, the team's vice-captain last season, this week and those of youngsters like Ian Maatsen, Lewis Hall and Omari Hutchinson late in the last financial year to balance the books in a way some find unseemly.

According to the most recent accounts, Chelsea's owners reportedly sold two hotels at Stamford Bridge to another company they own — a deal that is being scrutinized by the Premier League. They've also been looking at selling a stake in their successful women's team to raise money. Plumley said Chelsea's strategy has

left the club "very close ... if not over" the limit of the Premier League's profit and sustainability regulations. That might mean the team is liable to potential future points deductions, as suffered by Everton and Nottingham Forest last

It doesn't help Chelsea that it isn't currently in the lucrative men's Champions League, which deprives the club of approaching \$100 million a season.

"It was high-risk at the start and it's still high-risk now," Plumley said of the methods of Chelsea's owners. "There's a whole manner of things that could create problems down the road.'

In the short term, however, the biggest problem lies at the door of Maresca, an inexperienced manager who has to deal with a bloated squad containing an increasing number of frustrated players who Chelsea is keen to offload, such as established internationals Lukaku, Sterling and Ben Chilwell.

"I'm working with 21 players. The other 15 or 20, they are training apart," Maresca said. "They are Chelsea players, but they are not working with me. I don't see them.'

So much for creating a strong squad dynamic in a season that started with a 2-0 loss to Manchester City on Sunday and will continue in the Premier League on Sunday with a trip to Wolverhampton. (AP)

## Test between India and England

**Lord's to host its** 

first-ever women's



India and England in 2026, the ECB announced on Thursday. The England and Wales Cricket Board (ECB) said that after playing a three-match ODI series

against hosts England in July 2025, India will return in 2026 for a one-off Test. India will travel to England for

a white-ball tour in 2025. A fivematch T20 series will be followed by three ODIs.

"We can confirm that India Women will return in 2026 to take on England Women in the firstever women's Test match at Lord's. It will be a truly special occasion, and one of real significance," ECB CEO Richard Gould was quoted as saying by the Board's website.

The first match of the T20I series will be played at Nottingham on June 28, the second at Bristol on July 1 and the third will be at The Oval on July 4. The fourth and fifth T20Is will be played at Old Trafford and Edgbaston on July 9 and 12 respectively.

The first of the three ODIs will be at Southampton on July 16, the second at Lord's on July 19 and the final match of the series will be at Chester-le-Street on July 22.

"It has also been confirmed that India Women will return in 2026 for a one-off Test match at Lord's the first-ever Women's Test to be staged at the Home of Cricket," the ECB added

"England Women have played white-ball matches at Lord's for the past three years, with another scheduled next year, but it will be the first time the ground has hosted a Women's Test match."

India have played nine Tests so far against England in their backyard from June 1986 with their last clash at Bristol in June 2021 ending in a draw. (PTI)

MUMBAI, Aug 22: The legendary Rahul Dravid acknowledged that sometimes a little bit of luck can heavily impact the outcome of big matches, citing India's heartbreaking defeat in the ODI World Cup final to Australia and his side's sensational triumph from a precarious position against South Africa in the T20 World

India had stormed into the ODI World Cup final last year with a 10-match winning streak but when the tournament's best team bumped into Australia in the title clash, nothing worked.

Six months later, skipper Rohit Sharma and Dravid combined to complete the unfinished business. A formidable South Africa stood between them and the trophy but the luck smiled on them.

Having drawn lessons from the incredible highs and lows. Dravid on Wednesday recalled how crucial it was for the team to stick to the clichéd process and hope for luck to favour them against the Proteas at Barbados on June 29.

"I've had time to reflect on it. I've had

time to reflect on a lot of things we've done. You do realise, sometimes, you have to do a lot of these things, you have to do the process, you have to do everything right," Dravid, who was chosen for Life Time Achievement honour during the Ceat Cricket Rating Awards, said.

"Sometimes at the end of the day, you need a little bit of luck. (Against South Africa in T20WC final)... 30 balls to go, 30 runs to go. (It was about) incredible execution, incredible calmness by Rohit."

"We didn't focus on what we needed to do, but we needed a guy who could keep his foot within one inch of a line. Sometimes (it is) the skill," he said without mentioning Suryakumar Yadav's juggling act at the ropes to complete David Miller's dismissal.

That catch had tilted the match in India's favour. Dravid then recalled how India were

close to dismissing Travis Head in the ODI World Cup final but the opener rode on his tremendous luck to come up with a match-winning century, single-handedly



crushing a billion hopes.

"(On) 19th November... I remember whatever it was, we beat Travis Head's bat 15 times — he didn't touch a single ball. You know, things can go your way sometimes, but you have to stick to the process," the articulate Dravid circled back to sticking to the basics.

Dravid retired as India's coach following the title triumph.

Extolling India's bench strength and the ability to churn out high-quality cricketers consistently, Dravid said the next generation of players have successfully carried forward the legacy of the 'Fab Five'.

Dravid himself, Sachin Tendulkar, Sourav Ganguly, Virender Sehwag and VVS Laxman were part of the Fab-five that wowed the cricket fans globally.

"I left in 2011-2012. These players have been able to carry the legacy forward. If you just look at the success that we've had over the last 12 years in all the three formats of the game, the time that after we left, it's been absolutely phenomenal," he said. "Very easily, clearly in a lot of the rankings, we're always (No.) 1 or 2... we're always up there with anyone. To be able to go out and win that, just the kind of cricket that we play, the level of skill of some of our players, the way that they approach the game, is great," he said.
