Official documents: There are requirements for 7,800 vehicles in Assam Police

### Manpower crisis hits police dept; 12,485 posts lying vacant



GUWAHATI, Aug 25: Assam Police is grappling with vacancies at various levels including ADGP, IG, DIG, SP, according to official documents. The state police force is also struggling hard to maintain its pace as it is operating at little over 70 per cent of its vehicle requirement as per official assessment to run its operations efficiently, government records revealed. The total sanctioned strength of Assam Police is 79,852, including 4,835 personnel of Assam Police Radio Organisation (APRO).

Out of this, a total of 12,485 posts, which is 15.64 per cent of the required manpower, are at present lying vacant at various levels, as per official documents of the Home Department. Three posts of additional director general of

Police are lying vacant against the sanctioned strength of six. Three posts of inspector general of Police are also lying vacant against 14 posts, while there are no DIG at nine places out of 15 sanctioned posts, it said. The documents also revealed that eight posts of superintendent of Police, assistant IG, commandant and Senior SP ranked officials are lying vacant out of the total sanctioned posts of 147 in Assam Police. In the Additional SP rank, 68 posts out of 168 are non-occupied, while 146 positions of deputy SP are lying vacant against the sanctioned strength of 483 across the state.

Besides these senior posts, there are vacancies at every level of Assam Police as per the data. The official documents further revealed that there are requirements for 7,800 vehicles in Assam Police for its efficient functioning as per assessment by the Bureau of Police Research and Development (BPR&D).

However, the force currently has a total of

5,543 vehicles in a mix of owned and rented ones, which is 71.06 per cent of its requirement. Assam Police is still running short of 2,257 vehicles as per the BPR&D standards.

Out of the available vehicles, 1,413 are taken on rent and the remaining are government vehicles. Of these, 1,888 are government two-wheelers, the official papers showed. For the rented vehicles, the Assam government is shelling out crores of rupees from its exchequer every year, the set of documents showed.

Since 2016, when the BJP government came to power for the first time in Assam, a total of ₹412.79 crore have been paid for taking the vehicles on rent in the state.

In 2024 itself, ₹ 53.8 crore of rent bill has been paid till now, the official data said. The Assam Police has a total of 336 police stations and 295 outposts. Out of them, one police station and 15 outposts are inactive. Of the total establishments, nine stations and 17 outposts are operating from rented accommodation at present, while it has permanent buildings for 326 stations and 263 outposts. (PTI)

## Over 40,000 rape cases in state since 2001

Govt working to create safe environment for women: CM

GUWAHATI, Aug 25: Over 3,000 cases of rape were registered for three consecutive years during the first term of the BJP-led government in Assam from 2016-2021, according to data shared by chief minister Himanta Biswa Sarma on Sunday.

The number of such cases, however, has come down since 2020, it showed. The BJP retained power in Assam in 2021, with Sarma as the CM.

The Congress was in power in the state from 2001 to 2016, with the BJP-led government taking over thereafter. Union minister Sarbananda Sonowal had helmed the first BJP government in Assam.

"Every single incident of rape must be unequivocally condemned, as it represents a grave violation of human dignity and it is our collective responsibility to work towards eliminating this heinous crime from society," Sarma wrote on X, sharing the data of rape cases registered in the state from 2001 to July 2024.

"The chart... reflects our ongoing efforts and commitment to creating a safer and more just environment for everyone, especially our women," he said.

Sarma urged people to "unite to ensure that such



atrocities find no place in our world, and that safety, justice and compassion prevail".

As per the data, 3,544 rape cases were registered in 2017, 3,296 in 2018 and 3,546 in 2019. The 2019 figure was the highest during the 2001-July 2024 period.

The number of cases was 1,657 in 2020, 1,733 in 2021, 1,113 in 2022, 989 in 2023 and 580 till July 2024. During the Congress rule from 2001 to 2016, the highest number of such cases at 1,980 was regis-

#### India, Indonesia resolve to boost antiterror cooperation

NEW DELHI, Aug 25: India and Indonesia have condemned the use of terrorist proxies for cross-border terrorism amid Pakistan's support to terror groups carrying out terrorist activities in Jammu and Kashmir.

The issue of cross-border terrorism figured at the sixth meeting of the India-Indonesia joint working group on counter-terrorism that was held in Jakarta on Friday.

The two sides focused on ways to effectively combat terrorism, including how to stop the use of new and emerging technologies by terrorists, according to the Ministry of External Affairs (MEA).

"India and Indonesia strongly condemned terrorism in all its forms and manifestations and emphasised the need for strengthening international cooperation to combat terrorism in a comprehensive and sustained manner," it said in a statement on Sunday.

The MEA said the two sides also condemned the "use of terrorist proxies for cross-border terrorism." "The two sides exchanged views on the domestic, regional and global terrorism threat assessment," it said.

"They discussed counter-terrorism challenges related to the use of new and emerging technologies by terrorists, misuse of internet for terrorist purposes, terror financing, and the nexus between organised crime and terrorism," the MEA

It said the two sides also exchanged views on cooperation in regional, global and multilateral fora such as the UN, ARF (ASEAN Regional Forum) and ASEAN (Association of Southeast Asian Nations) to combat global terrorism.

The Indian delegation at the meeting was led by K D Dewal, Joint Secretary (Counter-Terrorism) in the MEA.

NEW DELHI, Aug 25: Businessman Anil Ambani is reviewing a Sebi order imposing a fine and banning him from capital markets for five years in an alleged fund diversion case and will take appropriate next steps as legally advised, his spokesperson said in a statement on Sunday

Ambani, the spokesperson in a statement said, had resigned from the board of Reliance Infrastructure Ltd and Reliance Power Ltd, pursuant to Sebi's interim order dated February 11, 2022 in the matter pertaining to Reliance Home Finance Ltd.

He "is in compliance with the said interim order (of February 11, 2022) for the last two and half

years," the statement said. On the August 22 order that banned him and 24 others from the securities market for five years on charges of diversion of funds, the spokesperson said, "Mr Ambani is reviewing the final order dated August 22, 2024 passed by Sebi in the said matter, and will take appropriate next steps as legally advised."

The Securities and Exchange Board of India (Sebi) had also imposed a fine of Rs 25 crore on Ambani, saying he orchestrated a scheme to "siphon off" funds from Reliance Home Finance, a listed subsidiary of conglomerate Reliance Group of which he is chairman. The ban means that he and the other 24 will not be able to access the securities market and are prohibited from buying, selling or otherwise dealing in securities, di-

rectly or indirectly. In a separate statement, Mumbai-listed Reliance Infrastructure Ltd said it "was not a noticee or party to the proceedings before Sebi in which the order is passed. No directions are given in the order against Reliance Infrastructure

NEW DELHI, Aug 25: Ola Founder Bhavish Aggarwal is placing bold bets on new-age technologies with a view for India to be at the forefront of the current global tech transition led by AI, and build jobs of the future in the

In an interaction with PTI editors at the agency's headquarters here, he said the private sector has to do the bulk of job creation, step up and do more, while creating an enabling environment and correcting imbalances, such as that of trade, are the responsibility of the

Aggarwal also supported the government's move to offer fiscal incentives to global EV makers, including Tesla, through the new EV policy saying it is important for India to attract all kinds of investment, and globally established players will help in the development of the EV ecosystem in the

The group's newly-listed entity Ola Electric aims to make India a global electric vehicle (EV) hub but the country has to invent an EV and energy transition paradigm for itself based on its needs as the world cannot achieve a sustainable future without India, he added.

"There is a global technology transition happening and AI is a very important technology of the future, and we in India need to lead this journey. If you look at the current state, I think we are still adopters of somebody else's technology paradigms, especially in the digital world," Aggarwal said, explaining why the Ola group had set up AI start-up Krutrim last year.

One of the things in Krutrim is to build AI models on Indian data, which is more attuned to Indian use cases, Indian paradigms, he said, adding, "We are making our own AI, on our own cloud, on our



cent of the world's digital data at present, he lamented that the country does not fully own the data, as 80 per cent are stored outside, which are then processed into AI and "brought back into India and sold to us in dollars".

When asked about concerns over AI leading to job losses, he allayed the apprehension saying that the IT boom created jobs in India when people feared that computers would take away jobs, and AI is a similar tool. "AI is not going to replace anyone. Maybe that future is a few decades away... We don't need to get anxious about that future right now. "We are diluting 10 per cent stake in the company through a VC. We are bringing ₹ 90 crore which will be primarily invested this year to make sure that we are touching around ₹ 400 crore to ₹ 450 crore turnover by the next financial year," Mirchandani told PTI. Candytoy Corporate Pvt Ltd (CTC) had a turnover of around ₹ 250 crore in FY 2023-24.

"Now with 30 per cent y-o-y growth in orders for the last two years, we see the requirement to open new plants to not only cater to this growth in demand but also bring newer product lines," he said.

The company, with 250 injection moulding machines, manufactures 10.5 million candy toys per day. "Our third Manufacturing plant in Indore has just commenced operations and we will also soon start manufacturing at our Jebel Ali plant (near Dubai, UAE) which will cater to the brands in UAE, Saudi

Arabia Oman & Kuwait," he said. CTC has invested ₹ 35 crore each (\$5 million) in

gories including inflatables, and bubble water toys, Mirchandani added.

Mirchandani said the Indian market has "immense" growth potential as only a few companies like Ferrero India, with its Kinder Joy, offer chocolates with a surprise toy. "Most of these candy toys are imported from China, which has quality issues because of the sugar quality. Here we are using organic sugar, which is good for the kid and the toy attached to it has a creative value," he said.

Its major clients include Pratap Snacks, HUL, Colgate Palmolive, and Perfetti Van Melle for the domestic market. While on the international market, the majority of its products are going to the US and Europe right now.

Incorporated in 2019, Candytoy Corporate operates with its two brands SM Toys and confectionary brand Hoppin Candy Toy, which is the leading manufacturer of plastic promotional toys and confectionery. Around 80 per cent of sales come from business-to-business (B2B) and the rest from business-to-consumer (B2C) brands. Overall, CTC through its five factories (three in Indore, one in Hyderabad and one in Delhi) and 11 contractual manufacturers in India makes promotional toys, candy toys, Barbie dolls, electronic toys, DIY toys, LED toys, musical toys, prank toys and sticky

According to the memo, Hojai district is an educational hub in the north-eastern region, attracting thousands of students, including girls, from various parts of Assam.

Many students, especially girls, travel alone early in the morning and late in the evening to attend coaching classes or tuition centres, making them vulnerable to eve-teasing, harassment, and

other forms of violence. Through this memorandum, AAMSU raised several demands: The accused, Biswajit Das, and his accomplices should be jailed, a speedy investigation conducted, and a charge sheet filed at the earliest to ensure a custodial trial; the accused should be sentenced to death by the court, and no loopholes should be allowed; a list of all coaching centres and tuition classes in Hojai town should be prepared, and police patrolling should be arranged in those areas; the safety and security of all girl students in PG hostels and colleges in Hojai and surrounding areas should be ensured; all private educational institutions should employ female security guards; rowdy elements and eveteasers should be strictly punished, and their gatherings near schools and colleges should be banned; CCTV cameras should be installed in all private schools, colleges, PG hostels, and coaching centres; school buses should also have CCTV cameras installed; teachers should not be allowed to give private tuitions to their own students; all private educational institutions should appoint a female coordinator for girl students; police veri-

#### 'Bigger intention' of grabbing land, threatening Assamese identity behind crimes against women: CM

GUWAHATI, Aug 25: Chief Minister Himanta Biswa Sarma has claimed that the recent incidents of crimes against women in the state are being committed with a "bigger intention of grabbing land and threatening the identity of the Assamese people". He hinted at 'political patronage' behind the crimes, while also claiming that financial power is shifting out of the hands of the Assamese people.

"No society is perfect. Crimes against women are a reality. These crimes had come down in the state in the last three years. But the real intention in the recent incidents is much bigger, through crimes such as rape the target is our land, civilisation," Sarma said at a press interaction late on Saturday evening.

"In Assam, this design is on for the last 30-35 years. That is why the Assam Agitation happened. We have identified the radicals now, but in 1975 itself, the Assamese society was warned that this would happen," he said, referring to the six-year-long movement from 1979 against illegal immigrants from Bangladesh.

Claiming that a "big conspiracy of grabbing land" is being hatched through such crimes, Sarma said, "The survivor's family in Dhing told me that they don't want to stay there anymore... people sell off their property and leave for other places. For a plot of land worth Rs 5 lakh, they are offered Rs 50 lakh.'

Å 14-year-old girl was allegedly raped by three persons in Nagaon's Dhing area on Thursday evening, with the incident sparking widespread protests. One of the accused was arrested by the police the next day, but he died when he jumped into a pond while purportedly trying to escape from custody.

Sarma claimed that there is a "pattern" in which first, one or two persons enter and set up their houses in a village, then they start eating beef in their homes and neighbours, uncomfortable with it, start leaving the area.

"It is happening in Barpeta, Mangaldai and other places. Previous chief ministers didn't say these things, but I have said it. There could be threat to my life someday, but I am saying it as it is my duty," Sarma

"It is all a game of money. Financial power is shifting out of the hands of Assamese people. They are taking advantage of it," he said, without naming any community. (PTI)

#### Modi's balancing act in Ukraine

rime Minister Narendra Modi's recent visit to Ukraine has highlighted India's delicate balancing act in the ongoing Russia-Ukraine conflict. As the first Indian leader to visit Ukraine since the war began, Modi's trip underscores India's attempt to navigate a complex geopolitical landscape, maintaining ties with Russia while engaging with Ukraine. President Volodymyr Zelenskiy's call for India to use its influence on Russia reflects the significance of New Delhi's position in global affairs. As a major importer of Russian oil, India's economic ties with Moscow are pivotal, and Zelenskiy's dissatisfaction with these ties was evident during his talks with Modi. The Ukrainian President expressed his concerns over India's "record-breaking" oil deals with Russia, emphasizing the need for India to reconsider its stance on the conflict

Modi's visit came shortly after his meeting with Russian President Vladimir Putin, which drew international attention. The optics of Modi and Putin's warm embrace were not lost on the global stage, especially as it coincided with Russian strikes on Ukrainian targets, including a children's hospital in Kyiv. ## A new dawn in Assam's legal landscape: Repealing the 1935 Muslim marriages act

decision to table the Assam Repealing Bill, 2024, which seeks to annul the Assam Muslim Marriages and Divorces Registration Act, 1935, is a momentous step that warrants deep reflection. The initiative, ostensibly aimed at modernizing the legal framework surrounding Muslim marriages and divorces, reflects broader socio-political currents in India. The repeal of a colonial-era statute, while introducing a new legislative framework, signifies a shift not only in legal paradigms but also in the state's approach to the social fabric of Assam's Muslim community.

#### The Context of Repeal

The Assam Muslim Marriages and Divorces Registration Act. 1935, was a product of its time—a legal instrument devised under British India to manage the registration of Muslim marriages and divorces in Assam. It was part of a broader colonial strategy to codify personal laws based on religious communities.

While the Act did provide a legal avenue for the registration of marriages and divorces among Muslims in Assam, it was, in essence, a non-compulsory framework. The machinery of registration under this Act was informal, and compliance was largely voluntary, leading to widespread instances of nonregistration and, by extension, the potential for legal ambigui-

The state's new move to repeal this Act must be viewed in light of these historical shortcomings. Minister Jogen Mohan's statement highlights the inherent weaknesses of the 1935 Act—its susceptibility to misuse by both registrars and citizens, particularly in the context of underage marriages. The Act, being outdated, fails to align with the modern legal standards that aim to safeguard the rights of individuals, especially women and children.

The Introduction of the Assam Repealing Bill, 2024

2024, is positioned as a corrective measure—a legislative attempt to replace an archaic law with a more robust and compulsory framework.

The Bill proposes to annul not only the Assam Muslim Marriages and Divorces Registration Act, 1935, but also the associated Rules of the same year. This repeal is not merely a symbolic act of discarding a colonial relic; it is a substantive shift towards enforcing stricter legal standards in the registration of marriages and divorces within the Muslim community.

This move aligns with the Assam government's broader strategy, as evidenced by the simultaneous introduction of the Assam Compulsory Registration of Muslim

Marriages and Divorces Bill, 2024. This prois intended to strengthen the in-

stitution of marriage by making registration compulsory, thereby ensuring legal recognition and protection. The emphasis on compulsory registration is a clear response to the perceived inadequacies of the 1935 Act, where non-registration often left individuals, particularly women, vulnerable to exploitation and legal uncertainties.

#### The Rationale Behind the Legislative Shift

The Assam government's rationale for this legislative overhaul is rooted in its desire to prevent the "menace" of child marriage and unauthorized divorces. Minister Jogen Mohan's statement of objectives and reasons outlines the potential for the 1935 Act to be misused, particularly in cases where marriages involve minors. By not mandating registration and by allowing a lax system of oversight, the Act inadvertently facilitated underage marriages—a practice that the current government is keen to eradicate.

### Democracy's dawn: Jammu & Kashmir poised for landmark ballot

ammu and Kashmir will hold Assembly elections from Sep-J tember 18 to October 1, marking the first time voters will elect 90 legislators since the abrogation of Article 370 and the state's bifurcation in August 2019. The prolonged delay in conducting these elections has been a point of contention for years, but a recent directive from the Supreme Court played a pivotal role in establishing the timeline. With the announcement now made, political parties across the spectrum have expressed their support. Kashmir has long been a flashpoint in the conflict between India and Pakistan, with both nations claiming the region while controlling only parts of it. Pakistan has taken the issue to the international stage, including the United Nations. Modi's 2019 decision to split the state sparked mixed reactions domestically and internationally.

The revocation of Article 370 resulted in significant changes for Kashmir, including the loss of its unique flag, criminal code, and constitutional protections. Government job opportunities for locals have diminished, with positions now open to non-residents. Despite these challenges, the state has experienced both positive and negative developments. Prime Minister Modi's initiatives have driven progress, and increasing investment interest from Gulf countries suggests a hopeful future for the region. According to the Ministry of Home Affairs, security force casualties have decreased from 80 in 2019 to 33 in 2023, and civilian deaths have fallen from 44 in 2019 to 12 in 2023. The last Assembly elections were held in 2014, and the high voter turnout in the 2024 Lok Sabha polls has paved the way for these upcoming Assembly elec-

Kashmir witnessed a landmark voter turnout of 58.46% in the recent parliamentary elections, reflecting a significant 30-point increase from the 2019 general elections. Following the 2019 revocation of Article 370 and the state's bifurcation, the government completed a delimitation exercise, expanding the number of assembly

8 / to 114 as of 2022, including 24 reserved for Pakistan-occupied Kashmir (PoK). This adjustment could alter the balance of power and affect political strategies in the forthcoming elections. The BJP has argued that the abolition of Article 370 and its subsequent policies have led to substantial development in the region. The recent Lok Sabha elections in Jammu and Kashmir marked a notable triumph for Indian democracy, with the National Conference (NC) and the People's Democratic Party (PDP) experiencing a resurgence in the 2024 polls.

The election provided an opportunity for the National Conference (NC) and the People's Democratic Party (PDP) to reinvigorate their membership and highlight longstanding issues. While the Congress failed to win any seats, the NC achieved a notable victory by securing two out of three available seats and posed a strong challenge for the remaining seat.

Despite the region's troubled history with terrorism and accusations of election rigging, the recent elections were broadly praised for their fairness and transparency. The forthcoming election will be a crucial test of the central government's efforts to more fully integrate Jammu and Kashmir into the Indian Union following the revocation of the region's special status under Article 370.

The upcoming assembly elections will also be a significant challenge for the Election Commission to ensure a violence-free process. Political parties have begun their preparations, focusing on campaign strategies, forging alliances, and selecting candidates. The People's Conference, Congress, Peoples Democratic Party, and National Conference have all convened to strategize for the elections and coordinate their efforts.

The People's Conference, Congress, Peoples Democratic Party (PDP), and National Conference have each held meetings to strategize for the upcoming assembly elections. Should the elections proceed as planned, the primary contest in the Valley is expected to be between the NC and PDP. Additionally, the polarization and sepa-

seats in Jammu and Kashmir from ratist rhetoric that emerged during the Lok Sabha elections are likely to intensify and reach their peak during the assembly elections.

The PDP leader Mehbooba Mufti's daughter, expressed sentiments similar to those of other party leaders. Additionally, various political parties, including the Congress, BJP, CPI(M), and the Democratic Progressive Azad Party (DPAP), all welcomed the Election Commission's announcement.

In the 2014 Jammu and Kashmir elections, no single party secured a majority, resulting in the imposition of Governor's Rule for 49 days. This period ended when Mehbooba Mufti of the PDP was appointed chief minister with support from the BJP. In 2018, the BJP withdrew from the coalition, leading to a return of Governor's Rule. The assembly was dissolved in November 2018, and President's Rule was implemented in December 2018. Since then, the state has re-

mained under Governor's Rule. The government faces a crucial decision on whether to intervene in the Kashmir Valley to tackle soft separatism or to consider a reorganization plan before the elections. During the parliamentary elections, the Congress and the National Conference (NC) formed an alliance, with the NC contesting three seats in Kashmir and the Congress focusing on Jammu and Udhampur.

The PDP, which is part of the INDIA Alliance, was not included in this arrangement and contested three seats in Kashmir against the NC. As for the upcoming Assembly polls, the situation remains unclear. There is speculation that the Congress and NC might join forces, although Omar Abdullah has indicated that forming an alliance with the PDP could be challenging due to their electoral rivalry in the parliamentary elections. For regional parties to strengthen their position, unity is essential, and collaboration with the INDIA Bloc is necessary. The Kashmir elections are highly significant and will be closely watched as the country anticipates the emergence of a popular government after a decade. #### Bracing

## Could mpox become established in the Indo-Pacific?

nce thought to be mainly contained to Africa, cases of mpox (previously known as monkeypox) have been detected in Sweden, Pakistan and the Philippines over the last few

This follows the World Health Organization's decision last week that the recent upsurge in mpox cases warranted it to be declared a public health emergency of international concern, highlighting the rapid spread of the virus and its potential for severe health im-

The last time this happened was in July 2022.

Of particular concern, testing has revealed the case in Sweden is the more virulent clade 1b subtype, the first time the strain has been detected outside

It's only a matter of time before mpox cases increase across the Indo-Pacific, although the WHO is stressing we know a lot more about this virus and how it spreads than we did about COVID-19.

Mpox is an infectious disease caused by the monkeypox virus, which belongs to the orthopoxvirus genus. This genus or family of viruses — also includes the variola virus, the virus that causes smallpox.

The first documented case of mpox in humans was reported in 1970 in the Democratic Republic of the Congo.

Since then, mpox has been classified into two primary clades: clade 1, previously known as the Central African strain, which is more virulent; and clade 2, previously known as the West African strain, which is generally less severe.

Historically cases of mpox were rare outside of Africa, however a significant global surge in cases began in May 2022 and has been followed by another increase this year, as the number of cases in Australia shows.

#### How mpox is spread

The transmission of the monkeypox virus occurs through several primary routes, with human-to-human transmission being the most significant.

This transmission typically involves direct contact with the lesions or bodily fluids of an infected individual, particularly during intimate interactions.

facilitate transmission during olonged face-to-face



Additionally, fomites — contaminated surfaces — can serve as vectors for the virus.

Animal-to-human transmission remains a critical route, often occurring through direct contact with infected animals. such as rodents or non-human primates, particularly in regions where bushmeat is consumed. Vertical transmission from mother to fetus during pregnancy has also been documented.

The epidemiology of mpox has notably shifted since the outbreak in May 2022, with a marked increase in cases reported among men who have sex with men, indicating a change in transmission dynam-

The clinical presentation of mpox includes symptoms such as fever, lymphadenopathy (swollen or enlarged lymph nodes) and characteristic skin lesions. One good thing for now, is that people with mpox can only transmit the disease when they are showing symptoms.

Although mpox is less lethal than smallpox, it still poses significant health risks, particularly to vulnerable populations.

Recent outbreaks and the global response The emergence of mpox

cases in non-endemic regions has raised concerns about public health preparedness.

Countries like Australia are enhancing surveillance and public health education to monitor potential cases and prevent outbreaks.

China will be monitoring people and goods entering the country for mpox for the next six months, it announced last The WHO's designation of

mpox as a public health emergency underscores the urgency of addressing the disease's potential for rapid spread, particularly in populations with low immunity due to the end of Respiratory droplets can also smallpox vaccination pro-

grams.

spread immunity against orthopoxviruses is lacking, vigilance is essential to mitigate the risk of mpox entering the country, especially through international travel.

The recent emergence of the more virulent clade 1 strain of mpox raises significant concerns about its potential to escalate into a global pandemic, particularly in the Indo-Pacific

This strain has been linked to higher mortality rates and increased transmissibility.

While the Indo-Pacific has been one of the regions least affected by mpox in the past, due to its interconnectedness and varying healthcare capacities, it could face substantial risks if the virus spreads unchecked.

The appearance of clade 1 in Sweden indicates that the virus can cross borders easily, posing a threat to countries with less robust public health infrastruc-

**Current treatment options** Vaccination strategies for mpox significantly differ between its two primary clades,

clade 1 and clade 2, due to variations in virulence, transmission dynamics and outbreak contexts. Clade 1, endemic to Central

Africa, has a historically higher mortality rate of up to 10 percent and is primarily transmitted zoonotically - from an animal to a human - with limited human-to-human spread.

By contrast, clade 2, particularly the subtypes clade 2a and 2b, has a lower mortality rate of about 3.6 percent and was responsible for the global outbreak that began in 2022, spreading predominantly through human contact, especially within sexual networks.

Vaccination efforts for clade l target high-risk populations in endemic regions, emphasising rapid vaccination following exposure.

Vaccines such as JYNNEOS and ACAM2000 originally developed for smallpox, are ex-

cross-protection against clade I mpox, although specific efficacy data is limited.

Public health education on zoonotic transmission is also

crucial to prevent outbreaks. For clade 2, vaccination strategies have been more aggressive, especially for clade 2b, with vaccines like JYN-NEOS deployed in non-endemic regions targeting men who have sex with men and other high-risk groups.

This includes both pre-exposure and post-exposure prophylaxis, supported by global efforts to establish vaccine stockpiles and ensure equitable distribution - particularly in Africa where shortages have been reported.

Antiviral treatments such as tecovirimat have been found to be ineffective, highlighting the need for urgent further research into effective therapeutics for npox management.

Where do we go from here? The current global mpox outbreak has underscored critical lessons learned from the COVID-19 pandemic, particularly in the areas of communication, equity reparedness.

Effective responses require clear, empathetic communication to build trust and reduce stigma around the disease, especially among marginalised communities disproportionately affected by outbreaks.

Rapid containment measures, including case identification, contact tracing and isolation, have proven essential in managing spread, mirroring successful strategies from

The COVID pandemic highlighted the importance of levertechnology information dissemination, ensuring equitable access to resources.

A coordinated government response is vital, emphasising collaboration across all levels of public health agencies to address emerging inequalities.

The necessity of stockpiling vaccines and ensuring their equitable distribution has become evident, as seen in the challenges already faced during this mpox outbreak. The most effective strategy

right now is to send mpox vaccines to Africa to try and stop the disease from spreading.

COPD is a group of medical conditions that affect the lungs, including chronic bronchitis and emphysema.

One of the most common symptoms associated with COPD is cough, which can severely impact a person's quality of life. A COPD-related cough is often productive, which means the person coughs up sputum or phlegm. However, some people with COPD may have a dry cough. This includes those who have COPD and asthma.

Over 16 million people in the United States have a diagnosis of COPD, according to the Centers for Disease Control and Prevention (CDC), and many more people living with COPD do not have a di-

**COPD** change over time? COPD symptoms, including the frequency and severity of the cough, tend to worsen over time. There are four stages of COPD, and some research suggests that the most severe decline happens at stage 2, when the measurement of a person's forced expiratory volume in 1 second (FEV1) is in the 50–70 range.

However, studies also suggest that if a person quits smoking or stops inhaling the particles that are causing lung inflammation, the rate of decline can go back to that of a normal lung within 5 years. A person with a severe

### Dhaka limps back to normal Israel stages heavy airstrikes on Lebanon

#### Hezbollah launches attack over slain top commander

JERUSALEM, Aug 25: Israel launched a wave of airstrikes across southern Lebanon early Sunday in what it said was a preemptive strike on Hezbollah, as the militant group said it had launched hundreds of rockets and drones to avenge the killing of one of its top commanders last month.

The heavy exchange of fire threatened to trigger an all-out war that could draw in the United States, Iran and militant groups across the region. It could also torpedo efforts to forge a cease-fire in Gaza, where Israel has been at war with the Palestinian group Hamas, an ally of Hezbollah, for over 10 months.

The Israeli military said Hezbollah was planning to launch a heavy barrage of rockets and missiles toward Israel. Soon after, Hezbollah announced it had launched an attack on Israeli military positions as an initial response to the killing of Fouad Shukur, one of its founders, in an Israeli airstrike in Beirut last

The attacks came as Egypt hosts a new round of talks aimed at ending the Israel-Hamas war. Hezbollah has said it will halt the fighting if there is a cease-fire in Gaza. Iran supports both groups as well as militants in Syria. Iraq and Yemen who might join any larger conflict. Air raid sirens were reported

throughout northern Israel, and Is-



rael's Ben-Gurion international airport diverted incoming flights and delayed takeoffs for a time. Israel's Airports Authority said

flights resumed at 7 am local time. Rear Adm. Daniel Hagari, the top Israeli military spokesman, said "dozens" of warplanes were striking targets in southern Lebanon. He said air defences, warships and warplanes were defending Israel's skies and involved

in the operation. Hezbollah said its attack involved more than 320 Katyusha rockets aimed at multiple sites in Israel and a "large number" of drones. It said the operation was targeting "a qualitative Israeli military target that will be announced later" as well as "enemy sites and barracks and Iron Dome (missile

defence) platforms." Hezbollah later announced the end of what it said was the first stage of retaliatory strikes, which it said would allow it to launch more attacks deeper into Israel. The group said all the exploding drones it launched hit their targets, without saying how many. It listed 11 bases, barracks, and military positions that it said it targeted in northern Israel and the Israeli-an-

nexed Golan Heights. In the US, a spokesman for the National Security Council, Sean Savett, said President Joe Biden was "closely monitoring events in

The recent protests that rocked Bangladesh for over a month have hit the hospitality sector hard in Dhaka with the majority of rooms at several luxury and economy hotels here going empty in the aftermath of the

A front office staff at a luxury hotel, running here since 2007 and operated by an international hotel chain, told PTI: "The situation in the hospitality sector is not good due to the impact of the unrest the country has seen recently" and "heavy financial losses have been incurred".

Abdul Moyeen Khan, a top BNP leader and a former Cabinet minister of Bangladesh, who lives in the plush Gulshan area, however, feels the city "largely went back to routine life" soon after August 5.

"The current situation is quite clear. It is amazing how the country is settling back after such a big upheaval. People are trying to get back to their normal day-to-day life, the (interim) government is trying to normalise everything, and they are up to their main mandate which is the transition from autocracy to democracy," Khan told PTI on Thursday.

Ask any autorickshaw driver or a rickshaw-puller on the streets of Dhaka, and they respond mutely. 'Even we don't know what lies ahead. We just need to go through the struggle of our daily lives," said Mohd Alam, a rickshaw puller.

The rickshaws of Dhaka are one of the defining images of the city. Keychains, fridge magnets and other merchandise at tourism department stores at the Dhaka airport celebrate this ubiquitous three-wheeler.

Even as Bangladesh's wait for the next elections and the next government gets longer, many have decided to go out and explore the world. (PTI)

tained a suspect in the Solingen knife attack that killed three people and further details. wounded eight others, the state internal affairs minister of North Rhein Westphalia said.

"We have been following a hot lead all day," Herbert Reul told Tagesschau, the news program of the German public television network ARD. "The person we have been searching for all day has been detained a short while ago," he said. He is now being questioned.

Reul said that police not only have "clues" but also have collected "pieces of evidence."

The Islamic State militant group Saturday claimed responsibility for a knife attack in Solingen, Germany that killed three people and wounded eight others at a crowded festival marking the city's 650th anniversary. The group said on its news site

that the attacker targeted Christians and is a "soldier of the Islamic State" who carried out the assaults Friday night "to avenge Muslims in Palestine and everywhere."

The IS claim couldn't immediately be verified. No evidence for the group's assertions was provided.

Police began raiding a home for asylum seekers in Solingen's city center, including with special forces, the German news agency DPA reported. Police told DPA later that they detained a man in the home and were looking into a possible connection to the knife attack. There was no official statement from police.

A 15-year-old boy was arrested early Saturday. Police said he was suspected of knowing about the planned attack and failing to inform authorities, but he was not the attacker.

Markus Caspers, senior public prosecutor from the counterterrorism section of the public prosecutors office, told a news conference earlier Saturday that authorities have not found the perpetrator.

"So far we have not been able to identify a motive, but looking at the Caspers said, though he did not offer

Police said the attacker appeared to have deliberately aimed for his victims' throats

"We are seeing the first signs of a new wave of terrorist attacks," said Peter Neumann, a professor of security studies at King's College in London. IS "is trying to capitalize on the huge mobilization resulting from Hamas' terror offensive on 7 October 2023, even though strictly speaking it had nothing to do with it," he

"The kind of attack we saw in Solingen is exactly the kind of attack that (IS) is trying to inspire. It's calling on people over the internet to attack unbelievers' using simple methods like cars and knives. That way, it is trying to create an impression that (the Islamic State group) is everywhere and could strike anytime," Neumann told the Associated

Thorsten Fleiss who was the chief of police operations on Friday night, said that police were conducting various searches and investigations in the entire state of North Rhine Westphalia that will continue throughout the day. He said that it is a "big challenge" to bring together available evidence and testimony from witnesses in order to come up with a overall picture.

Fleiss also said that police have found several knives but added that he was unable to confirm whether any of them have been used as weapon by the perpetrator during the

Police warned people to stay vigilant even as well wishers started to leave flowers at the scene. Authorities established an online portal where witnesses could upload footage and any other information relevant to the attack.

COX'S BAZAR, Aug 25: Tens of thousands of Rohingya refugees from Myanmar who live in sprawling camps in Bangladesh on Sunday marked the seventh anniversary of their mass exodus, demanding safe return to Myanmar's Rakhine state.

The refugees gathered in an open field at Kutupalong camp in Cox's Bazar district carrying banners and festoons reading "Hope is Home" and "We Rohingya are the citizens of Myanmar," defying the rain on a day that is marked as "Rohingya Genocide

On August 25, 2017, hundreds of thousands of refugees started crossing the border to Bangladesh on foot and by boats amid indiscriminate killings and other violence in Myanmar's Rakhine state.

Myanmar had launched a brutal crackdown following attacks by an insurgent group on guard posts. The scale, organisation and ferocity of the operation led to accusations from the international community, including the UN, of ethnic cleansing and genocide.

Then-Bangladesh Prime Minister Sheikh Hasina ordered border guards to open the border, eventually allowing more than 700,000 refugees to take shelter in the Mus-



lim-majority nation. The influx was in addition to the more than 300,000 refugees who had already been living in Bangladesh for decades in the wake of waves of previous vi-

olence perpetrated by Myanmar's military. Since 2017, Bangladesh has attempted at least twice to send the refugees back and has urged the international community to build pressure on Myanmar for a peaceful environment inside Myanmar that could help start the repatriation. Hasina also sought help from China to mediate.

But in the recent past, the situation in Rakhine state has become more volatile after a group called Arakan Army started fighting against Myanmar's security forces. The renewed chaos forced more refugees to flee toward Bangladesh and elsewhere in a desperate move to save their lives. Hundreds of Myanmar soldiers and border guards also

took shelter inside Bangladesh to flee the violence, but Bangladesh later handed them over to Myanmar peacefully.

As the protests took place in camps in Bangladesh on Sunday, the United Nations and other rights groups expressed their concern over the ongoing chaos in Myanmar. Washington-based Refugees International in a statement on Sunday described the sce-

"In Rakhine state, increased fighting between Myanmar's military junta and the AA (Arakan Army) over the past year has both caught Rohingya in the middle and seen

them targeted. The AA has advanced and burned homes in Buthidaung, Maungdaw, and other towns, recently using drones to bomb villages," it said. "The junta has forcibly recruited Rohingya and bombed villages in retaliation. Tens of thousands of Rohingya have been

newly displaced, including several who have tried to flee into Bangladesh," it said. UNICEF said that the agency received alarming reports that civilians, particularly children and families, were being targeted or caught in the crossfire, resulting in deaths and severe injuries, making humanitarian ac-

Darmanin also hailed the "professional conduct" of police forces and its elite intervention unit "despite the gunfire" during the operation. French prosecutors said the man was arrested in the southern city of Nimes shortly be-

fore midnight Saturday. "He opened fire on the police intervention unit, which returned fire, injuring (the suspect) in the face," the National Antiterrorism Prosecutor's Office said in a statement Sunday. Two other people linked to the suspect were also taken into custody, it added.

Prosecutors were investigating the attack as an attempted assassination linked to a terrorist group and destruction of property with dangerous means, and a crime planned by a terrorist group with an intent to cause harm, the statement said.

After the attack Saturday, Darmanin ordered police reinforcements to protect Jewish places of worship following what was "clearly a criminal act."

"I want to assure our Jewish fellow citizens of my full support and say that at the request of President Emmanuel Macron all means are being mobilised to find the perpetrator," Darmanin posted on X. He ordered more police officers deployed at Jewish places of worship around the country following a surge of antisemitism since the start of the Israel-Hamas

war in October. The mayor of La Grande Motte, Stéphan Rossignol, said that investigators were reviewing the city's surveillance videos and said that a lone suspect was spotted at the site of the at-

"The individual in question did not manage to get inside the synagogue, even though that was clearly his objective." Rossignol said in an interview with broadcaster France Info. (AP)

AGARTALA: Aug 25. The flood situation in Tripura, which began on August 19, is gradually improving. However, the disaster has severely impacted the state, with 1.17 lakh people displaced and over 20,000 houses damaged. The death toll has now risen to 26.

According to a statement from the Relief, Rehabilitation & Disaster Management Department, 525 relief camps have been set up across the state, currently sheltering over 1.17 lakh individuals.

The continuous and heavy rainfall between August 19 and 24 caused a significant rise in water levels in the state's rivers, particularly the Gomati River at Sonamura, which remains above the danger mark.

While the rainfall has lessened in the last two days, the state recorded its highest

#### Man confesses to brutal murder of wife and child

ITANAGAR, Aug 25: A man allegedly killed his wife and child in Arunachal Pradesh's Longding district, a police officer said on Sunday.

Police arrested 35-year-old Gangngam Gangsa, a resident of Khanu village of the district for allegedly killing his wife Ngamjun Gangsa and their child Phagang Gangsa on Saturday, Longding, Superintendent of Police (SP) Dekio Gumja said. According to the SP, one Mangu Pansa filed an FIR at Longding police station alleging that Gangngam Gangsa had shared a picture of his wife and their child in a WhatsApp group, claiming responsibility for their murder.

Upon receiving the information, a police team accompanied by the complainant and executive magistrate Bini Shiva, arrived at the scene and found the bodies of the woman and the infant, the SP said, adding that the accused was immediately arrested and taken into custody. A local 'dao' and spade were seized from the crime scene, he said, adding that the postmortem examination was conducted and the bodies were handed over to relatives. A case has been registered and investigation is going on to find out the reason behind the gruesome murder, the SP added. (PTI)

She said it is not for the first time such a thing had happened but 2011 onwards, there are hun-

The census operation continues to be on hold and the government has not yet announced a new schedule for it.



### Cong slams govt over 'unprecedented decline' in real wages



NEW DELHI, Aug 25: The Congress on Sunday claimed that a combination of slow wage growth and "back-breaking" inflation has caused an unprecedented decline in real wages and said that like the "proverbial ostrich", the government continues to remain blind to the most fundamental challenge faced by the Indian economy.

Congress general secretary incharge communications Jairam Ramesh said a new report by a noted brokerage firm has once again shed light on the truth that the Union Government has consistently denied - real household incomes in India are facing a persistent decline.

"A combination of slow wage growth and back-breaking inflation has caused an unprecedented decline in real wages (wages adjusted for price rise) and therefore incomes," he said in a statement.

Ramesh pointed out that several surveys and data sets - including the Annual Survey of Unregistered Enterprises (ASUSE), the Reserve

Bank of India's KLEMS data, and the Household Consumer Expenditure Survey (HCES) - have demonstrated financial distress among working class Indians.

Multiple data sources, including the government's own official statistics, have even shown clear evidence that workers can buy less today than they could 10 years ago,

"Labour Bureau's Wage Rate Index (Government Data): Real wages for labourers stagnated between 2014-2023, and in fact debetween 2019-2024. Ministry of Agriculture's Agricultural Statistics at a Glance (Government Data): Under Dr Manmohan Singh, real wages for agricultural labourers grew at 6.8% each year. Under Mr. Modi, real wages for agricultural labourers declined by minus 1.3% each year," he said.

Citing periodic labour force survey series, Ramesh said average real earnings over time have stagnated between 2017 and 2022 across all employment types salaried workers, casual workers, and self-employed workers. Citing Centre for Labour Re-

search and Action data, he said real wages of brick kiln workers have stagnated or declined between 2014 and 2022.

Brick kilns involve intensive labour and are a low-paying work of last resort for India's poorest, he

"In my intervention on the Finance Bill in the Rajya Sabha on August 8, 2024, I had asked four straight questions on the state of the economy," he said.

"The non-biological PM hasn't yet broken his silence on them, so they are worth repeating: Why does private investment continue to be sluggish? Why has the private sector's share in overall investment declined to its lowest level in four years?" Ramesh said.

"Why is consumption growth so weak and why did private final consumption expenditure - the largest component of the GDP grew at only around 4% in FY24,"

Why are real wages and incomes stagnant or falling, Ramesh further asked.

"Why has manufacturing as percentage of GDP fallen from 16.5% in UPA to 14.5%? Why has this decline been particularly sharp in labour-intensive manufacturing like textiles? Why have India's garment exports fallen from USD 15 billion in 2013-14 to USD 14.5 billion in 2023-2024?" the Congress leader said.

"The Union Budget has come and gone, but like the proverbial ostrich, the Government and the non-biological PM continue to remain blind to the most fundamental challenge faced by the Indian economy," Ramesh said. (PTI)

### NC, PDP can't ensure Art 370 restoration: BJP leader

JAMMU, Aug 25: BJP Mahila Morcha president Vanathi Srinivasan on Sunday said it "impossible" for the opposition parties NC and PDP to ensure Article 370 restoration but they are fooling people by guaranteeing it in their manifesto for the Jammu and Kashmir assembly elections.

Addressing reporters after a meeting of Jammu and Kashmir Mahila Morcha at the BJP headquarters here in the run-up to the assembly polls, Srinivasan said the younger generation in the union territory want a peaceful life and development, which can only be ensured by her party.

In its manifesto, the National Conference (NC) mentioned 12 guarantees, including the restoration of Article 370 and Jammu and Kashmir's statehood, while People's Democratic Party (PDP) promised to pursue the restoration of Jammu and Kashmir to its "original status", and advocate for confidence-building measures (CBMs) and regional cooperation between India and Pakistan. In August 2019, the BJP-led government abrogated Article 370, which gave special status to Jammu and Kashmir, and bifurcated the erstwhile state into two Union Territories --Jammu and Kashmir and Ladakh.

"It is impossible for them (NC and PDP to restore Article 370). They are trying to fool the people. It (the abrogation) was done by the parliament. It is a constitutional amendment and more than that in the name of Article 370, discrimination has been happening here," the BJP women's wing president said. She said the people of Jammu and Kashmir have suffered a lot due to some separatist political parties but now the younger generation wants to live a peaceful life and hopes to see development in this region for which "BJP is the

only solution". Srinivasan said both the NC and PDP would be defeated in the upcoming assembly elections and "whatever they are saying about restoration of the Article 370 or renaming Shankaracharya hill will not help them because now the people understand that they are doing politics for the sake of their family members".

She said the women wing of the Jammu and Kashmir BJP is proactive and its members did a "tremendous job" during the Lok Sabha elections this year.

Speaking at the 'Lakhpati Didi Sammelan' in north Maharashtra's Jalgaon, Modi said the safety of women should be a prior-

"The safety of mothers, sisters, and daughters is the country's priority. I have repeatedly raised this issue from the Red Fort. Be it any state of the country, I understand the pain and anger of my sisters and daugh-

Modi said that he would tell every political party and state government that crime against women is an unpardonable sin. Whoever is guilty should not be spared, he added.

"Those helping the perpetrators of crimes against women should not be spared. Be it a hospital, school, government or police station, at whatever level negligence occurs, everyone should be held accountable.

"The message should go from top to bottom. This sin is unpardonable. Governments will come and go, but protecting life and women's dignity is a big responsibility of all of us, both as a society and as a government," Modi said.

Kolkata horror accused Sanjay Roy undergoing lie detection test



NEW DELHI, Aug 25: The lie detection test on Sanjay Roy, the main accused in the alleged rape and murder of a RG Kar Medical College trainee doctor, is underway at Kolkata's Presidency Jail where he is lodged, officials said on Sunday.

Two more individuals will undergo the test at the CBI office in

Kolkata during the day, they said. Four persons including former principal Sandip Ghosh underwent the polygraph test on Saturday, the officials said.

The CBI has sought permission from court to put seven persons including Roy and former principal of the medical college Sandip Ghosh through THE lie detector test. The test cannot be used as evidence during the trial but findings give the agency a direction for the

A team of polygraph specialists flown to Kolkata from the Central Forensic Science Laboratory (CFSL) in Delhi is conducting the tests, they said.

Roy was arrested by the Kolkata Police on August 10, a day after the body of the 31-year-old medic was found in the Seminar hall of the medical college. A CCTV footage and a Bluetooth device found near the medic's body resulted in the arrest of Roy, who was allegedly seen entering the seminar hall of the college where the body was found at around 4

Roy (33) was working with the Kolkata Police as a civic volunteer

The accused, who is a trained boxer, allegedly got close to a few senior police officers over the years, following which he was moved to the Kolkata Police Welfare Board and posted at the police outpost at the RG Kar Medical College and Hospital.

He has denied the allegations against him.

The CBI earlier told the Supreme Court that the crime scene was altered by the time it took over the probe which suggests there was an attempt by the local police to cover up the rape and illing of the post-graduate medic.

The medic's body with severe injury marks was found inside the seminar hall of the hospital's chest department in the morning of Au-

The incident has sparked widespread protests.

The Calcutta High Court on August 13 ordered the transfer of the probe from the Kolkata Police to the CBI, which started its investigation on August 14. (PTI)

**HT Bureau** GUWAHATI, Aug 25: In a significant move to enhance the retirebenefits of central government employees, the Union Cabinet, led by Prime Minister Narendra Modi, has approved the Unified Pension Scheme (UPS).

The decision, made on August 24 promises a comprehensive pension plan that ensures financial security for retirees.

The UPS introduces several key features aimed at providing substantial benefits to employees postretirement. Central to the scheme is the assurance of a pension amounting to 50% of the average basic pay drawn in the last 12 months of service, with a minimum qualifying period of 25 years. For employees with less than 25 years of service, the pension will be prorated, with a minimum serv-

ice requirement of 10 years. Additionally, the scheme guarantees a family pension equivalent to 60% of the employee's pension, payable immediately upon the em-

ployee's death. To further support retirees, the UPS sets a minimum pension of ₹ 10,000 per month for those who retire after at least 10 years of serv-

Inflation protection is another critical aspect of the UPS, as it includes indexation for pensions, family pensions, and minimum pensions to adjust for cost-of-liv-

The scheme also offers a lumpsum payment upon retirement, calculated as 1/10th of the monthly emoluments (pay plus dearness allowance) for every six months of service, in addition to gratuity.

For retirees under the previous New Pension Scheme (NPS), the UPS will be applicable retroactively, with arrears paid along with interest at Public Provident Fund

The Unified Pension Scheme is slated to come into effect on April l, 2025. While initially targeting central government employees, the scheme has been designed with flexibility for adoption by state governments, allowing them to extend similar benefits to their employees currently under the NPS.

## India considered sourcing cheetahs from Somalia, Tanzania, Sudan after biorhythm challenges

NEW DELHI, Aug 25: India considered sourcing new cheetahs from Somalia, Tanzania, Sudan and other range countries closer to the equator or in the Northern Hemisphere to avoid biorhythm complications observed in big cats brought from Southern Hemisphere countries like South Africa and Namibia, according to official records. Due to the differences in circa-

ern and Southern Hemispheres, some cheetahs developed thick winter coats during the Indian summer and monsoon last year, anticipating the African winter (June to September). Three of these cheetahs -- a Namibian female and two South

African males -- died after wounds

beneath their winter coats, on their

backs and necks, became infested

with maggots and led to blood in-

dian rhythms between the North-

fections PTI has learnt from sources that the cheetahs from Namibia and South Africa have once again developed thick winter coats. Despite these concerns, discussions are ongoing with Southern Hemisphere

countries to bring new cheetahs. "Talks are ongoing with all countries, including South Africa and Namibia, but we have not formally approached anyone. Currently, our focus is on addressing immediate issues, such as augmenting the prey base, managing the leopard population and readying the Gandhi Sagar Wildlife

Sanctuary," a source told PTI. Documents obtained by PTI through an RTI application revealed that during a steering committee meeting on August 10 last



year, Chairman Rajesh Gopal said the time it takes for cheetahs from Southern Hemisphere countries to adjust their biorhythms to the local environment, climate, and conditions in Madhya Pradesh's Kuno National Park might be a significant factor in their deaths.

"For want of biorhythmic adjustment, some cheetahs have succumbed to ectoparasitic infections during their pelage change, which was synced with the climate conditions of their earlier habitat. The third filial generation from surviving cheetahs would be more resistant and better adapted to Kuno conditions," Gopal said in the meeting. He acknowledged the possibility of further mortality due to this issue and recommended that "future cheetahs for reintroduction should be sourced from Northern Hemisphere countries like Kenya or Somalia to avoid biorhythmic

complications". According to the Africa Range-Wide Cheetah Conservation Initiative, Southern and Eastern Africa are strongholds for the species, al-

#### report flags challenges train controllers face NEW DELHI, Aug 25: A study dards Organisation (RDSO), Control board.

by the Research Design and Stanwhich functions under the Railway Ministry, has found that train controllers face multiple challenges at work including "unattractive" pay scale, huge stress due to vacancy leading to health concerns, and a lack of basic amenities.

The report, which was submitted to the Railway Board recently, said section controllers perform highstrain jobs, their task made more difficult by the around 15-20 per cent vacancy, medically-decategorised officers posted in the department and the absence of appropriate reward either in terms of money, or esteem and career growth.

Titled 'The challenges faced by Section Controllers in carrying out their duties effectively' the report aims at exploring improvements in selection procedure, training, and infrastructures for enhancing the efficiency and effectiveness of train operations.

The Indian Railways is one of the largest networks in the world with thousands of trains traversing various sections of almost 1,05,555 km of tracks daily, the report states. "This mammoth activity is controlled by 68 operation centers over the IR network called the Divisional Control Office."

The Divisional Control Office, situated at divisional headquarters, plays a vital role in the entire operation of the railway network, tt

The rail network in a division is subdivided into sections consisting of several stations. "The trains running over these sections are controlled and monitored by the

Section Controllers working round the clock in shift duties on the

'Vacancies, pay, health, basic amenities': RDSO

The RDSO team collected data from various divisional control offices and found that there are vacancies ranging from 15 to 24

"High vacancy in the cadre ultimately affects the working condition of the staff on roll. Under strenuous conditions, the quality of work also suffers. Administration also faces difficulty in managing the rest and leave of the staff. Therefore, vacancy in the cadre should be analysed on priority and effort should be made to fill up the vacancy," the report says.

It says section controllers work 24x7 their shifts cannot be left unmanned "As per the roaster, Section

Controller requires 30 hrs of weekly rest. But in the absence of adequate number of staff, sometimes the administration faces problems in arranging weekly rest or leave to Section Controllers. In a continuous work schedule, they feel burned out and their productivity gets affected," the report adds. While identifying the reasons for the shortage of section controllers, the report said 75 per cent of the posts are filled through selection from the feeder cadre of Station Masters (55 per cent), train managers (10 per cent) and train clerks (10 per cent).

'The initial grade pay of Section Controllers has been made identical with the Station Masters grade pay (L/6) in the VIIth CPC. While, earlier the initial pay of Section Controllers was a grade higher (L/6) than the pay of SMs (L/5)and therefore, SMs were interested

in applying for the post," the study

manufactured. (PTI)

says.
"But in the present selection process, there is reluctance from the SMs category to apply for the post of Section Controllers due to lack of any substantial financial gain. This situation has led to the shortage of staff in the Section Controller cadre resulting in further stress on the working strength of the Section Controllers," it adds.

Expressing concern over the current practice of inducting "medically de-categorized" staff in the control department as section controllers, the study says, "A person with any medical condition or handicap will have some restricting working condition where that person will be unable to meet the demand of the job."

The study has suggested several measures such as upgradation in the initial pay scale from grade pay 4,200 to grade pay 4,600 to make them more attractive for the feeder category candidates, introduction of an aptitude test in the recruitment/selection, extension in the

duration of training period. The team has also suggested the Railway Board reintroduce direct recruitment of section controllers through the Railway Recruitment Board which was discontinued in 2020. It also said no controller should be allowed to work without undergoing the periodical refresher

courses, the Study said. "Increase in the frequency of refresher courses will also equip the Section controllers with frequent updates in their knowledge and skill. It may be increased from once in 03 years to once in a year as in the case of Air Traffic Controllers," it added. (PTI)



"I've watched a lot more Hindi films than people who live here (in the north). There are some amazing directors that I want to work with every time I see (their work). I'm a huge fan of Bachchan sir. My interest towards movies and wanting to make a film... "Then even with the performance, 'Agneepath' played a big role in the later part. Like, when I wanted a certain intensity for the character... I always looked for a script like 'Agneepath', that was one childhood thing for me," Nani told

PTI in an interview here. "Agneepath" featured Bachchan as Vijay Deenanath Chauhan, who sets out to avenge the death of his father and the injustices done to his family by becoming a part of the Mumbai underworld

The film not only turned the actor into a movie buff but also inspired him to pen a couple of stories, including a thriller, he said.

"I still have the story, and then I've two or three more stories, which have to be adapted to the current times. There are a couple of directors who I've worked with, who know the basic idea about it, they are always like, 'Let's do it'."

The 40-year-old credited "Agneepath", directed by Mukul Anand and produced by Yash Johar, for redefining the quintessential Hindi cinema hero. The 1990 film, which earned Bachchan his first best actor National Award, was remade in 2012 with Hrithik Roshan in the lead.

"It played a very big part (in my life)," Nani said, re-enacting the introduction scene of Bachchan's character, "Naam, Vijay Deenanath Chauhan...

"I think that's the greatest intro of all time. I love how he asks for the tailor's number when he meets Kancha Cheena (played by Danny Denzongpa) and Mandwa village, that mood, that set-up, that line 'Maloom?'. Every detail about that film, it was something new for me, it hit me very strongly," said the actor, adding he counts veteran actors Chiranjeevi and Nagarjuna among his influences. Nani further expressed his deep admiration for Aamir Khan and the Bollywood superstar's per-

formances in films such as "Dil Chahta Hai", "Lagaan" and "Rang De Basanti". "Before I was about to join cinema, there was a huge influence of Aamir Khan sir, his films. Then he did films like 'Dangal', which came after I became an actor,

and it was very inspiring. "It was like, 'We have to up the game'. So, Hindi cinema has always been a part of this love for cinema, he said, adding "Dilwale Dhulania Le Jayenge", "Hum Dil De Chuke Sanam", "Baazigar", and "Darr" are among his favourite Bollywood films. The "Jersey" star will next be seen in the Telugu vigilante action thriller "Saripodhaa Sanivaaram", titled "Surya's Saturday" in its Hindi dubbed version.

Written and directed by Vivek Athreya, the film will hit the screens on Friday. It is produced by DVV

metall kills," said another couple

The fans were also noticeably

quieter than usual when the second half began, withholding their support for several minutes before eventually resuming. More than 81,000 supporters attended the match at Dortmund's Westfalenstadion. Campaigners set up a dummy tank outside the stadium before the game, when an activist wore a mask with the face of Rheinmetall's CEO, Armin Papperger, while holding a red card.

On Wednesday, supporter association Südtribüne Dortmund had signaled the intent of more than 90 fan groups to make their opposition to the deal clear at the start of the second half of Saturday's game. The association encouraged fans to bring placards and banners criticizing the deal.

The association also criticized

the timing of Dortmund's announcement of the deal – in May, three days before the team lost to Real Madrid in the Champions League final – saying the news came as a "bombshell."


Vimal noted. "In the last six months, she has



### B'desh registers historic 10wicket win after Pakistan collapse to 146 all out in 1st test



RAWALPINDI (PAKISTAN), Aug 25: Bangladesh shrugged off political unrest back home to notch a historic 10-wicket win after Pakistan collapsed to 146 all out on a dramatic final day of the first test on Sunday.

Off-spinner Mehidy Hasan Miraz and left-arm spinner Shakib Al Hasan, who was a lawmaker in the government of former Prime Minister Sheikh Hasina, shared seven wickets after the pace bowlers mopped up the top order to give Bangladesh its maiden win in 14 test matches against Pakistan.

Openers Zakir Hasan and Shadman Islam were unbeaten on 15 and 9. respectively, as Bangladesh reached 30-0 at the stroke of the tea interval for only its seventh away test win and the first since beating New Zealand at Mount Maunganui in January 2022.

Pakistan, which conceded a 117-run first innings lead despite declaring at 448-6, was bowled out by a disciplined pace and spin attack after it resumed on 23-1 and still 94 runs behind.

Mohammad Rizwan followed his career-best unbeaten 171 to topscore with 51 but most of his teammates were guilty of falling to rash shots coupled with some aggressive field placings by Bangladesh skipper Najmul Hossain Shanto.

Mehidy picked up 4-21 and Shakib 3-44 while the three fast bowlers Shoriful Islam, Hasan Mahmud and Nahid Rana snared one wicket each. Earlier, in a dramatic first session Bangladesh set up its victory as Pakistan limped to 108-6 and lost five wickets. Captain Shan Masood (14) was dismissed in the second over of the day when Hasan found a faint edge and had the Pakistan skipper caught behind.

# Root anchors England to nervy 5-wicket win over Sri Lanka in 1st test

MANCHESTER, Aug 25: Joe Root hit an unbeaten 62 to anchor England to a five-wicket win over Sri Lanka late on Day 4 of the first test on Saturday.

Set 205 to win, England was faltering at 70-3 but Root and Harry Brook (32) steadied the innings before the former captain guided the team home to its target as shadows lengthened on a sunbaked evening at Old Trafford.

The English finished on 205-5 to secure a fourth straight test victory this summer, after beating the West Indies 3-0 in July.

The win in Manchester was also significant in that it might have signaled a reset of "Bazball" the nickname of the expansive approach favored by the leadership team of captain Ben Stokes and coach Brendon McCullum.

Root and his teammates picked

their moments to attack as the runrate fell to around 3.5 per over by the end of the second innings.

Root, who only hit two fours the second coming off what proved to be the last ball of the match — said "sometimes it's good to win ugly." "It was a tricky one today," Root said. "A long, slow, hard grind."

Root said he didn't feel comfortable "muscling it" so compiled his knock in a different way. "For us to do it differently and

still get the win is a good sign for us," Root said.

Earlier, Sri Lanka was dismissed for 326 soon after lunch, collapsing following the departure of No. 7 batter Kamindu Mendis for 113 — the third century of his four-match test career. Dinesh Chandimal was the last batter out for 79, with the final four wickets



tumbling in 26 balls. Sri Lanka added 122 runs on the

fourth day after resuming its second innings on 204-6.

"Our mistakes were made in the first innings and that cost us the match," Sri Lanka captain Dhananjaya de Silva said. "Lots of good individual performances.

There are positives here and there. But we were off-target too much and you have to be 100% here to win test matches. "In English conditions and their very good bowling line-up, we have to tighten our game at the top of the order."

The second test starts at Lord's on Thursday. (AP)

### 95 officials to accompany 84 Paris Paralympics participants to look after their 'special needs'

**NEW DELHI, Aug 25:** The 84-member Indian contingent taking part in the Paris Paralympics beginning on August 28 will be accompanied by 95 officials as many participants will have their personal coaches and escorts travelling with them to take care of their special needs.

The total strength of the Indian contingent will thus have 179 members. Out of the 95, as many as 77 are team officials, nine are contingent medical officials and another nine contingent officials.

India is sending the largest number of participants in the Paris Paralympics (August 28 to September 8) with 84 athletes

competing in 12 sports. In the Tokyo Paralympics in 2021, India was represented by 54 members in nine sports.

"Considering the special needs of some para athletes, personal coaches have been included in the contingent. However, they will provide necessary services to other players as per the directions of the Chef de Mission/team head coach," the ministry said while clearing the contingent.

"The participation of the entire contingent (including sportspersons, contingent officials, coaches) except that of Chef de Mission and one team manager for para

The likes of javelin thrower Sumit Antil and shooter Avani Lekhara, who would be looking to defend their Tokyo Paralympics gold, are among those who will be having personal coaches.

"In any para sports event, the participants need more support staff like personal coaches and escorts than able-bodied competitors. So, it is nothing new to have more support staff in para sports," a team official said.

The para-athletics team, which is the largest with 38 competitors, also has most number of personal coaches and escorts.

#### Chinese players are not invincible, says para table tennis star Bhavina Patel

NEW DELHI, Aug 25: Tokyo Paralympics silver medallist in table tennis Bhavina Patel is determined to do one better against her Chinese opponents at Paris Paralympics starting on August 28, saying they are not invincible. The first Indian paddler to clinch a medal at Tokyo in Class 4 event, Bhavina said on departure for this year's edition that she would look to defy Chinese domination in table tennis as they are "humans" too.

Bhavina told PTI Videos on Sunday, "Chinese players are humans and so are we. China does not matter to me, even during the Tokyo edition I had beaten a Chinese player so there's no pressure on me to face them." "I have changed my tactics according to them so I will deploy my best plans against them on the day," she said.

The table tennis player from Mehsana, Gujarat, who is also a Commonwealth Games Champion and Asian Games medallist, said her only focus will be to give her best. "There is no nervousness. I just have to give my best. I believe that when we think about giving our best, nothing else comes to mind," she said. Her doubles partner Sonalben Patel said, "Bhavina and I have put in a double amount of effort in our training as partners and we will try our utmost to return home with a medal."

Tokyo Paralympics gold medal winner in men's singles badminton SH6 event, Krishna Nagar said he will aim to replicate his performance. "I hope that everything will be fine in Paris and I will try to win gold for India again. I will give it my all to defend my gold from Tokyo. Preparations went well. I feel positive and will look to play safe," he said. Making his debut appearance at the Para Games, shot putter Sachin

Khilari said that he is at least expecting a gold medal from himself. "There is a lot of excitement in me, my preparations were going on for 1.5 years for the Paralympics, I performed well at the World Championship and I expect a gold medal out of myself because I have worked hard to earn it," he said. On how he is going to handle the pressure of competing against the best athletes in the world, Khilari quipped, "The pressure is on them to compete against me as I consider myself to be the best." Debutant Sakshi Kasana, a discus throw athlete said, "I have worked tirelessly hard for this moment to come true as representing your nation at the Paralympics is the biggest thing for any athlete so I hope my four years of hard work pays off."

PCI President and legendary para javelin thrower Devendra Jhajharia claimed that India will finish among the top nations at the Para Games. "I have 20 years of experience in para sports. I have taken 3 medals. I know each player and their performances individually." (PTI)
