

GUWAHATI, Aug 23: A 14-yearold girl was allegedly gang-raped by three persons in Nagaon district, triggering massive protests by people on the streets.

Chief Minister Himanta Biswa Sarma promised that stern action would be taken against the perpe-

The girl was allegedly assaulted and raped by three persons while she was returning home from her tuition on her bicycle in Dhing area around 8 pm on Thursday, police said. Three persons came on a motorcycle and surrounded the girl, who was then allegedly raped by them and left in an injured and unconscious state on the roadside near a pond. The class 10 student was later rescued by locals, who informed the police.

She was initially taken to a health centre in Dhing and later shifted to a hospital in Nagaon for treatment and medical examination. "The criminals who dared to commit such a heinous crime against a minor Hindu girl of Dhing will not be spared by the



Water Resources Minister Pijush Hazarika to rush to Dhing and take the toughest action," Sarma told reporters in Hailakandi.

Sarma alleged that after Lok Sabha elections, "a section of members of a particular community have become very active and have been encouraged to commit such crimes. We will, however, come down heavily on the perpetrators and nobody will be spared."

In the last two months, 22 such crimes against women have taken place and this is the 23rd such incident in the state, he added. "In Lower and central Assam and Barak Valley districts, where indigenous people have become a numeric minority, they are living in constant fear. People outside these

regions cannot gauge this harsh re-

ality," he said. The chief minister urged all to be sensitive about these issues of the indigenous people. "We should identify the real perpetrators behind these heinous crimes and not be stuck in blaming communities

27 Indian pilgrims killed, 16 injured as tourist bus plunges into river in Nepal

KATHMANDU, Aug 23: At least 27 Indian pilgrims who arrived in Nepal from Maharashtra for a 10day tour were killed and 16 others injured after a tourist bus veered off the highway and fell into fastflowing Marsyangdi river in central Nepal on Friday, police said.

The incident occurred at Anbookhaireni area in Chitawan district when the bus from Gorakhpur in Uttar Pradesh carrying 43 passengers, including the driver and two helpers, was heading towards Kathmandu from Pokhara.

While 16 people died on the spot, 11 succumbed to their injuries while undergoing treatment, deputy spokesperson of Armed Police Force (APF) Shailendra Thapa



Sixteen people who sustained injuries have been airlifted to Kathmandu and admitted at Tribhuvan University Teaching Hospital, he said.

The dead bodies will be handed over to their family members after

that the postmortem will be conducted on Saturday at Western Regional Health Science Academy in Pokhara. The bus with an Uttar Pradesh number plate that fell around 150 metre down the hilly road is still lying in the bank of Marsyangdi river and will be lifted with the help of a crane on Saturday, he said.

Thapa said 250 security personnel, including from Nepal Army, Armed Police Force and Nepal Police, were mobilised for rescue works. Twin rope was used to conduct the rescue operation as the accident site lies in a deep and narrow gorge near the Marsyangdi River, he said. The reason for the accident is not yet known. NEW DELHI, Aug 23: The Central Bureau of Investigation (CBI) on Friday defended in the Supreme Court the arrest of Delhi chief minister Arvind Kejriwal, saying it was necessary as he chose to remain "evasive and non-cooperative" in his replies to questions about his role in the alleged excise policy scam. In its detailed affidavit filed in response to Kejriwal's plea challenging his arrest by the central agency, the CBI alleged all critical decisions in the formulation of the now- scrapped excise policy were taken at his behest with the connivance of the then deputy chief minister Manish Sisodia

Amit Shah slams Congress for tie-up with National Conference

NEW DELHI, Aug 23: Real-world vehicle emissions are much higher than laboratory tests suggest and CNG vehicles, once considered a cleaner alternative, actually emit high levels of nitrogen oxides, according to a new study.

Conducted as part of The Real Urban Emissions (TRUE) Initiative in collaboration with authorities in Delhi and Gurugram, the study utilised non-intrusive remote sensing technology to measure the emissions of on-road vehicles. The study, conducted with technical analysis by the global think tank International Council on Clean Transportation (ICCT), revealed that nitrogen oxide (NOx) emissions from BS-VI private cars were 81 per cent lower than those from BS-IV cars. Similarly, BS-VI buses produced 95 per cent lower NOx compared to BS-IV buses

The study also found that compressed natural

gas (CNG) vehicle fleets emitted high levels of NOx, challenging the narrative of CNG being a 'clean" alternative fuel.

For example, Class II light goods vehicles emit up to 14.2 times their NOx lab limits while taxis emit four times the amount. This also means that to improve air quality, it is crucial to focus on the actual emissions from vehicles on the road, not just their lab results. Commercial vehicles, such as taxis and light goods vehicles, emit much more NOx than private cars, even if they meet the same emission standards.

"It is evident that real-world emissions from transport vehicles differ significantly from their laboratory values. For the first time in India, we have collected substantial emissions data from motor vehicles on the road. It is crucial to remember that what impacts our air quality is not the laboratory emissions but the pollutants released by these vehicles in operation," said ICCT India managing director Amit Bhatt. Therefore, it is time to rethink our emissions

The Union home minister asked whether the Congress supports promoting separatism again by engaging in dialogue with Pakistan instead of Kashmir's youth and the National Conference's decision to start LoC trade with Pakistan, thereby nurturing terrorism and its ecosystem across the bor-

His other queries fired to the Congress and Gandhi included whether the party supports reinstating relatives of those involved in terrorism and stone-pelting into government jobs, "thereby bringing back terrorism, extremism and the era of strikes"

Sebi bans Anil Ambani, 24 others from securities mkt for 5-yrs for fund diversion

NEW DELHI, Aug 23: Markets regulator Sebi has barred industrialist Anil Ambani and 24 others from the securities market for five years on charges of diversion of funds from Reliance Home Finance Ltd.

Additionally, Sebi has imposed a penalty of ₹ 25 crore on Ambani and restrained him from serving as a director or Key Managerial Personnel (KMP) in any listed company or Sebi-registered entity for five years

Besides, a fine ranging R₹ 21 crore to ₹ 25 crore have been levied on 24 entities. Also, the regulator barred Reliance Home Finance from the securities market for six months and slapped a fine of ₹ 6 lakh on it. An email sent to Anil Ambani-led Reliance Group company remained unanswered.

After receiving multiple complaints alleging diversion/siphoning of funds of Reliance Home Finance Ltd, Sebi conducted an investigation for the period of FY 2018-19 to ascertain any regulatory violations.

In its probe, Sebi found that Anil Ambani, with the help of RHFL's KMPs -- Amit Bapna, Ravindra Sudhalkar and Pinkesh R Shah -- have orchestrated a fraudulent scheme to "siphon off" funds from RHFL by disguising them as loans to entities linked to him.

Although the board of directors of RHFL had issued strong directives to stop such lending practices and review corporate loans regularly, the company's management ignored these orders. This suggests



a significant failure of governance, driven by certain KMPs under the influence of Ambani.

Given these circumstances, the company RHFL itself should not be held equally responsible as the individuals involved in the fraud.

Further, the remaining entities have played the role of being either recipients of illegally obtained loans or conduits to enable illegal diversion of money from RHFL, the regulator noted.

Sebi said that findings have established the "existence of a fraudulent scheme, orchestrated by Noticee No. 2 (Anil Ambani) and administered by the KMPs of RHFL, to siphon off funds from the public listed company (RHFL) by structuring them as loans' to credit unworthy conduit borrowers, and in turn, to onward borrowers, all of whom have been found to be promoter linked entities' i.e. entities associated/ linked with Notice 2 (Anil Ambani)".

Ambani has used his position as 'chairperson of the ADA group' and his significant indirect shareholding in the holding company of RHFL to orchestrate the fraud.

Sebi, in its 222-page order on Thursday, noted the cavalier approach by the company's management and promoter in approving loans worth hundreds of crores to companies that had little to no assets, cash flow, net worth, or revenue. This suggests a sinister objective behind the 'loans'. The situation becomes even more suspicious when considering that many of these borrowers were closely linked to the promoters of RHFL.

Eventually, most of these borrowers failed to repay their loans, causing RHFL to default on its own debt obligations. This led to the company's resolution under the RBI Framework, leaving its public shareholders in a difficult position.

For example, in March 2018,

RHFL's share price was around ₹ 59.60. By March 2020, as the extent of the fraud became clear and the company was drained of its resources, the share price had plummeted to just ₹ 0.75. Even now, over 9 lakh shareholders remain invested in RHFL, facing significant losses.

Accordingly, Sebi has barred these 25 entities including Ambani and former officials from "accessing the securities market and prohibited from buying, selling or otherwise dealing in securities, directly or indirectly, for a period of 5 years". Ambani and three former officials of RHFL (Bapna, Sudhalkar and Shah) have been "restrained from being associated with the securities market including as a director or Key Managerial Personnel (KMP) in any listed company or any intermediary registered with Sebi, for a period of 5 years". Also, the regulator levied a fine of ₹ 27 crore on Bapna, ₹ 26 crore on Sudhalkar and ₹21 crore on Shah

Additionally, the remaining entities including Reliance Unicorn Enterprises, Reliance Exchange next Ltd, Reliance Commercial Finance Ltd, Reliance Cleangen Ltd, Reliance Business Broadcast News Holdings Ltd and Reliance Big Entertainment Private Ltd have been imposed a penalty of ₹ 25 crore each. These fines have been levied on them for either receiving the illegally obtained loans or acting as intermediaries to facilitate the illegal diversion of funds from RHFL. (PTI)

Hindu society," Sarma said. The police said that one person had been already arrested and another detained while a search was on to nab the others. DGP G P Singh reached Dhing and visited the crime scene along with district police officials. He also visited the survivor's house and talked to her parents and other family members. "I have reviewed the incident site and the progress of the investigation which is moving in the right direction. A case has been registered under Protection of Children from Sexual Offences (POCSO) Act and other relevant acts," the DGP told reporters in Dhing.

The police have gathered sufficient evidence and the additional director general of police (special branch) has been requested to provide the technical support regarding the mobile data details which will be made available soon, he said. The DGP reviewed the situation with IGP (central range) and the district commissioner and also discussed the recurrence of such incidents in some parts of the district. "Such incidents have earlier occurred in Samaguri, Rupohihat, Dhing, Juria and Lahorighat and I have directed that geo-tagging be done in areas where inter-community interface exists," he said. "If geo-tagging can be done in the next few days, then we can prepare an area security plan to ensure that such incidents do not occur in the future," Singh said.

Besides, the Nagaon superintendent of police has been directed to increase patrolling in the evenings, particularly in areas around girls educational institutions and tuition centres, the DGP said. A senior doctor of the hospital where the survivor has been admitted said that she is being treated by a multi-speciality team of doctors from the medicine, surgery and gynaecology departments. "After she was admitted, the sexual offences investigation team conducted all the formalities and the girl was treated by a team of doctors. The necessary tests were conducted and as per the law, some of the reports were handed over to the police," the doctor said. A team of psychiatrists have also been alerted to provide necessary mental support and counselling to the survivor to help her deal with the trauma, he added.

Meanwhile, people from all the communities hit the streets on Friday morning demanding the arrest of the culprits. Shopkeepers downed the shutters of their business establishments and social and political organisations demanded stringent action against the culprits and security for women and girls. (PTI)

lies in the national highway some 90 km west of Kathmandu.

According to a report in MyRepublica news portal, the passengers onboard the bus were part of a group of 104 Indian pilgrims who arrived in Nepal from Maharashtra in three buses two days ago for a 10-day tour of the Himalayan nation. They came from Bhusal village in Jalgaon district. After visiting Pokhara for two days, all three buses left for the capital Kathmandu on Friday morning. Madhav Pad Paudel, chief of the Armed Police Force (APF), Kurintar, said that most of the passengers travelling in these three buses were families and relatives. A list of names of the 43 passengers who were in the ill-fated bus has been released. "An Indian tourist bus travelling from Pokhara to Kathmandu with around 43 Indians fell 150 metres into Marshyandi River today," the Embassy of India said in a post on X. The mission is coordinating with local authorities undertaking relief and rescue. The bus that fell on the river bank was badly damaged. An MI 17 helicopter of the Nepal Army was deployed to transport injured passengers from the accident site at Anbu Khaireni in Tanahun district with a medical team for the rescue operation, MyRepublica reported.

Meanwhile, the Uttar Pradesh government has sent a sub divisional magistrate to the incident site. An ADM has also been appointed to coordinate the relief work. Uttar Pradesh relief commissioner GS Naveen Kumar in a press statement said, "As per media reports and further confirmed from the MEA Nepal Division, today at about 11:30 am, a bus with registration number - UP 53 FD 7623 carrying approx 43 passengers from Maharashtra, including the driver and one assistant, fell around 150 metres into river Marshyandi in Ambukhereni region in the Tanahu District of Nepal."(PTI)

Kejriwal has also been confronted with sensitive documents and statements of witnesses during his custodial interrogation, and having such knowledge, he is likely to influence the witnesses. The federal probe agency said Kejriwal was not entitled to parity with the other co-accused considering his role in the criminal conspiracy in the formulation and implementation of the Delhi Excise Policy 2021-22, more specifically when any or all decisions of the government and the party were taken only as per his directions.

"Even otherwise, bail granted to co-accused has no bearing on a petition challenging the legality of the arrest of the petitioner," it said, adding that Kejriwal's release on bail will "gravely prejudice" the trial of the case, which is at an initial stage and key witnesses are yet to depose.

It said the July 12 order granting interim bail to Kejriwal in an excise policy case related to alleged money laundering has no bearing on the CBI's case in which he stands accused of corruption. "As far as the averments regarding interim bail on medical grounds is concerned, it is humbly submitted that regarding the ailments, the treatment can be provided at the Tihar Jail hospital or any of its referral hospital as per jail rules & manuals, which is being already done. No case has been made out by the Petitioner to be released on medical bail, which ought to be granted only if the treatment is not possible in the jail," it said. The CBI said though Kejriwal does not hold any ministerial position, it has emerged over a period of time that all critical decisions in the formulation of the now scrapped excise policy were taken at his behest with the connivance of the then deputy chief minister Manish Sisodia, who held the excise portfolio.

"The petitioner was initially asked to join the investigation under section 160 CrPC being understood as one of the persons acquainted with the facts of the case. However, there was certain material which pointed a needle of suspicion towards him. As the investigation progressed, it started becoming clear that the petitioner (Kejriwal) has a pivotal role in the formulation of the new excise policy," it said. (PTI)

retail inflation fell to a five-year low of 3.54% and foreign exchange reserves have reached an all-time high of USD 675 billion. The defence minister enumerated the steps taken by the government to achieve 'Aatmanirbharta' in defence, including the notification of Positive Indigenisation Lists comprising over 5,000 items. He emphasised that the consistent efforts are being made to ensure that state-of-the-art defence items are manufactured on Indian soil by domestic companies. Singh acknowledged the fact that the defence exports, which were ₹ 600 crore before the current government came to power, have now risen significantly to over ₹21,000 crore. He added that due to the measures taken to promote innovation, the number of start-ups in the country rapidly increased to 1.20 lakh from around 400 in 2014. He credited these achievements to the willpower along with the policies and planning of the government. Voicing Prime Minister Modi's vision, he said: "We want to develop India into a strong, secure and prosperous nation."

Singh concluded the address by urging the Indian community in the US to work with honesty and dedication, in line with the spirit of 'Vasudhaiva Kutumbakam' (The World is One Family).

Meanwhile, in a post on X Singh said he had a lively interaction with the Indian community at Washington DC. "It's heartwarming to see how the Indian community continues to cherish and uphold their cultural values and maintain their connection to their roots," he said, sharing some photographs from the event. Coinciding with Singh's arrival, senior defence officials from both sides signed two major agreements - Security of Supplies Arrangement (SOSA) and Memorandum of Agreement regarding the Assignment of Liaison Officers. zero-emission vehicles," he added. FIA Foundation deputy director Sheila Watson said the research clearly showed India and the rest of the world that CNG was not the clean alternative fuel that was promised. The report's release is timely, given the recent directive from the Supreme Court to finalise the Automotive Industry Standard (AIS) 170 and implement remote sensing in the National Capital Region.

AIS 170 will set the technical parameters for remote sensing devices and equip authorities with the necessary resources to measure vehicle exhaust in real time. "Remote sensing technology has the capability to non-intrusively screen tailpipe emissions from vehicles on a mass scale under real-world conditions and can help identify highly polluting vehicles. It is encouraging to see the Supreme Court and the (Union) Ministry of Road Transport and Highways moving forward with the implementation of this technology, beginning with the National Capital Region," said ICCT India researcher Anirudh Narla. "Remote sensing as an on-road surveillance method can not only help identify and remove the worst emitters but also helps understand emissions performance of different technologies and fuels. This shows that while the CNG transition has helped cut toxic particulate emissions from diesel vehicles during the early years, NOx emissions from on-road CNG vehicles without adequate controls can still be high. This builds a case for the next major transition to electrification to make tailpipe emissions not cleaner but zero," said executive director (Research and Advocacy) at the Centre for Science and Environment, India, Anumita Roychowdhury. (PTI)

Restoration of Article 370 and Jammu and Kashmir's statehood as well as implementation of the autonomy resolution passed by the erstwhile assembly in 2000 are among the National Conference's 12 guarantees announced in its manifesto for the upcoming polls. Gold prices decline by ₹350, silver drops ₹ 200

NEW DELHI, Aug 23: Gold prices declined by ₹ 350 to ₹ 73,800 per 10 grams in the national capital on Friday, according to the All India Sarafa Association.

In the previous session, gold of 99.9 per cent purity traded at ₹74,150 per 10 grams. Silver declined by ₹200 to ₹87,000 per kg from ₹87,200 per kg in the previous day.

Meanwhile, gold of 99.5 per cent purity also dropped by ₹ 350 to ₹ 73,450 per 10 grams against ₹ 73,800 per 10 grams on Thursday. The yellow metal extended losses on Friday, weighed down by rising US Treasury yields and a recovery in the dollar index, market experts said.

Prices of precious metal were also influenced by the minutes of the last Monetary Policy Committee (MPC) released by RBI on Thursday. Reserve Bank Governor Shaktikanta Das said that the current policy rate of 6.5 per cent is broadly balanced, and any justification for policy easing at this juncture can be misleading, according to the MPC minutes. Governor Das and three other members voted for the status quo on the repo rate in the MPC, while two members advocated a rate cut. Globally, gold at Comex gained USD 18.20 to trade at USD 2,534.90 per ounce. Silver was trading 1.24 per cent higher at USD 29.84 per ounce in the international markets. Minutes from the US Federal Reserve's July meeting revealed a strong inclination toward a rate cut next month, a move supported by at least two Fed officials, Prathamesh Mallya, DVP- Research, Non-Agri Commodities and Currencies, Angel One Ltd, said.

"Speculators overstated the likelihood of an aggressive rate cut before the end of the year; now they trimmed their bets and are pricing three 25-basis-point cuts across the remaining three Fed policy meetings this year, down from around four cuts priced two days ago," said Saumil Gandhi, Senior Analyst - Commodities at HDFC Securities. Sensex, Nifty edge up in volatile trade ahead of US Fed chief speech

MUMBAI, Aug 23: Benchmark Sensex and Nifty edged up in volatile trade on Friday following buying in blue-chip stocks such as ICICI Bank and Bharti Airtel amid mixed global trends ahead of the US Fed chair Jerome Powell's speech at Jackson Hole Symposium.

Rising for the fourth straight session, the 30-share BSE Sensex ended 33.02 points or 0.04 per cent higher at 81,086.21.

In early trade, the benchmark declined 169.93 points or 0.20 per cent to a low of 80,883.26. Later, it bounced back 178.3 points or 0.21 per cent to hit a high of 81,231.49 but gave up gains towards the end.

The NSE Nifty edged up 11.65 points or 0.05 per cent to close at 24,823.15 registering gains for the seventh session in a row.

From the Sensex pack, Tata Motors, Sun Pharmaceutical, Bharti Airtel, Bajaj Finserv, ICICI Bank, Mahindra & Mahindra and JSW Steel were the gainers.

Tech Mahindra, HCL Technologies, Asian

Paints, Titan, Infosys, State Bank of India, Tata Consultancy Services and HDFC Bank were the laggards. "Ahead of the FED chair Powell's speech, the

Dima Hasao Council eyes mithun Heavy vehicle ban imposed rearing for farmer empowerment

GUWAHATI, Aug 23: In a significant move to safeguard public safety, the executive engineer of PWRD, Borkhola & Katigorah Territorial Road Division, has announced a new restriction on heavy vehicles along the Borkhola-Kalain Road, currently under construction as part of the Asom Mala Project. The prohibition, effective immediately, applies to all vehicles with a Gross Total Weight (GTW) exceeding 15 metric tons (MT) on the Borkhola-Khambarbazar stretch of the road. This measure comes in response to regular damage to the ongoing construction caused by the frequent movement of heavily loaded commercial vehicles, leading to severe disruptions for pedestrian traffic and smaller vehicles.

To alleviate these issues and prioritise public interest, the ban will remain in place until further notice. However, LPG carriers have been granted an exemption, provided they enter and exit through the Borkhola side only.

BSNL's 4G Launch

SNL, the public sector telecom giant under the Department of Telecommunications (DoT), has been struggling to keep pace with private competitors. Despite being left behind in the race for technological advancements, the company's muchawaited 4G launch, now set to be completed by March next year. may offer a glimmer of hope. Yet, the question remains: Will it be enough to revive the once-dominant PSU? The launch of BSNL's 4G services has faced multiple delays over the past 18 months, with several internal deadlines proving to be overly optimistic. However, recent indications from DoT suggest that the government is keen on rolling out the service by December, with a final deadline set for March if further delays occur. This push comes as the company attempts to regain relevance in a market dominated by private giants like Reliance Jio, Airtel, and Vodafone Idea (VI). BSNL's reliance on Tata Consultancy Services (TCS) for the software and Tejas Networks for hardware, along with the involvement of DoT-administered ITI and C-DoT, adds layers of complexity to the project. The implementation of one lakh 4G/5G Radio Access Network (RAN) sites across the country is a massive undertaking, and BSNL must ensure that its vendors meet the ambitious dead-

Despite the challenges, there are some positive signs. BSNL has reported a steady increase in users porting to its network under the Mobile Number Portability (MNP) scheme. Since July, when private telecom companies raised their tariffs by 10-25%, BSNL has seen over 2.5 lakh new subscribers. By the end of 2023, the company had gained around 8 lakh subscribers, bringing its total new user base to an estimated 25 lakh in regions like Punjab, Haryana, Himachal Pradesh, and parts of South India. The company's competitive tariff strategy, aimed at being "rational, affordable, and user-inducing," could play a key role in attracting more users, particularly in rural areas. However, whether this will be enough to stabilize the company's financial position remains uncertain. BSNL's market share currently stands at a mere 8%, a distant fourth behind its private sector rivals. Achieving even a modest 15% market share over the next three to four years will require sustained efforts and strategic initiatives. One potential area for growth is the tourism sector, where BSNL's network coverage in remote areas gives it a competitive edge. Tourists often prefer BSNL SIM cards as a secondary option due to the availability of its towers in farflung locations.

However, BSNL faces an uphill battle. The company's decline over the past decade has been steep, and even with the 4G rollout, regaining a significant market position will be challenging. To achieve this, BSNL must also focus on revitalizing its landline services, which have seen a significant decline due to customer defections to private competitors. The company's weak financial position has hindered its ability to refund deposits to former landline customers, further eroding its reputation. The road ahead is difficult, but BSNL's survival may hinge on its ability to adapt and innovate in a rapidly changing telecom landscape. The upcoming 4G launch, if executed well, could mark the beginning of a turnaround. However, the company must remain vigilant and committed to ensuring that this opportunity does not slip through its fingers once again. As BSNL approaches the five-year anniversary of its revival package approval, the stakes have never been higher.

Rightly so, for such interactions were often either sporadic or localised or both. The asymmetry with the state's forces was dealt with through tactical means such as guerrilla tactics or anonymisation.

Declaration of war has significant political connotations, both internal and external. Such a declaration, however, also gives

Until merely a the state access to a broader set of mechanisms which would otherwise be deemed illegitimate. Thus, the status of war is invoked only in the face of major threats, which till recently, only organised militaries of foreign states were capable

> of posing. Non-state actors have existed within various states for long. But never before has the impact of their attacks been to the extent seen today. The emergence of and ease of access to new-age technologies like offensive UAVs and automated weaponry has transformed the economics of

The David's Sling apparatus, likely used for the purpose, costs more than 5 times the unit (allegedly Shahed drones) it seeks to counter. The much touted cheaper alternative, Iron Dome is significantly less effective against navigable

drones with unpredictable trajectories. The Israeli response a few days later exemplifies the case, when it used cheap quadcopters to mislead and render toothless the Iranian defences. Up North, Hezbollah has been successful in repeatedly penetrating the Israeli air defences to cause nontrivial damage to civilian and even military installations on Israeli Soil.

More recently, Houthis successfully targeted Tel Aviv all the way from Yemen. In the recently concluded Armenia-Azerbaijan war, the drones proved to be pivotal in the establishment of air superiority by Azerbaijan over Armenia.

A hoard of low-cost drones would be flown towards the enemy, engaging with which would expose the location and nature of the defences. These sitting ducks would then be eliminated, leaving the airspace undefended.

While there is a widespread consensus on the tactical advantages the drones provide on the battlefield, some commentators have underplayed their strategic significance. It is true that at present drones play a tactical role. It is one however which has quick and major strategic implica-

Would the establishment of air superiority not give one side a decisive advantage? Does the large-scale

annihilation of traditional frontline equipment such as tanks and armoured vehicles, as seen in Ukraine, not obliterate the adversary's strategic plans? Not to mention the jarring effect on the morale of the soldiers in the face of an invisible enemy. The intelligence gathered using drone surveillance can prove decisive.

Future developments such as 'loyal wingman' could have a clear and direct strategic role. The freshly acquired ability of non-state actors to pose strategic challenges to the states has transformed the nature of interaction between them.

Given the stakes at play and willingness to scramble resource-intensive sponses, the war room outlook towards such groups has shifted from a mere nuisance to a full-scale war. This is despite the lack of de jure recognition of the challenger. The emerging nature of diplomatic interactions between states and non-state groups resembles in many ways the inter-state interactions, albeit unoffi-

Uncertainty in Bangladesh: BNP, army differ on election timing

ore than seventeen days after the abdication of former Prime Minister of Bangladesh, Sheikh Hasina from power in Bangladesh on August 5 and taking political shelter in India, conflicting trends are visible in the functioning of the interim government headed by Dr. Muhammad Yunus, as also in the activities of the political parties in the faction-ridden country. The struggle to protect our language, culture, and economy is indeed our constitutional right, but it should not be confused with baseless concerns about economic exchanges.

Let us move forward with a balanced perspective, understanding that mutual dependence in trade and commerce is not a sign of weakness but of strength. This interdependence is what fosters growth and prosperity for all.

The Humanitarian Access SCORE Report says that in Gaza - the first six months (March 2024) estimated that more than 30,000 civilian deaths have included over 150 aid workers, an

unprecedented number for a single context in such a short period. The 2024 Global Humanitarian Overview requires \$48.65 billion to assist 186.5 million people in need. As of the end of July 2024, reported GHO funding amounts to \$12.26 billion or 11 per cent less than last year at the same

From Sudan to Myanmar and beyond, the first half of 2024 was characterized by attacks against health, education and water and sanitation facilities that left millions of people without access to the services they need to survive. (Global Humanitarian Overview 2024). These facts lay bare a glaring truth: the world is failing hu-



manitarian workers and, by extension, the people they serve.

Despite universally accepted international laws to regulate the conduct of armed conflict and limit its impact, violations of

these laws continue unabated, unchallenged and unchecked. And while civilians, including aid workers, pay the ultimate price, the perpetrators continue to evade

(WHD), we demand an end to these violations and the impunity with which they are committed. On 19 August 2003, a bomb attack on the Canal Hotel in Baghdad, Iraq, killed 22 humanitarian aid workers, including the UN Special Representative of the Secretary-General for Iraq, Sergio Vieira de Mello. Five years later, the United Nations General Assembly adopted a resolution designating 19 August as WHD.

Humanitarian crises, such as conflicts, natural disasters and pandemics, often result in human rights concerns. Deteriorating human rights situations may also trigger crises and increase the huulations. We need trained and professional workers who could work and bring positive changes. There are many international agencies that hire humanitarian workers.

One may choose courses like Social Work, Disaster Management, Human Rights, Development Studies, etc. There are different job profiles who would like to work in humanitarian support activities. Health workers like doctors or nurses can also join this profession and work for organisations like Red Cross, World Vision, or agencies of the United Nations, etc. UN Human Rights mainproach to humanitarian action. To achieve this, it works at both field and global levels, ensuring that the voices of affected communities are integrated in strategic, operational and policy approaches. It brings opportunity for the qualified and trained and skilled people to work with different international agencies to bring positive changes. Harris warns Americans of consequences of putting Trump back in White House

mala Harris has used her presidential acceptance speech to present herself as a leader who could unite all Americans to chart a "new way forward" and warned them of "extremely serious" consequences of putting her Republican rival Donald Trump back in the White House.

Vice President Harris, who is of Indian and African heritage, on Thursday night accepted her party's nomination at the Democratic National Convention in Chicago, becoming the second woman to do so for the Democratic Party after former first lady Hillary Clinton.
The 59-year-old leader

walked on stage to thunderous applause and a standing ovation from the audience. Chants of "Yes You Can!" erupted before her remarks.

Taking the stage at the United Center in Chicago to accept her nomination, Harris, who was a tough prosecutor in California before becoming US Vice President, said she is no stranger to unlikely journeys.

"On behalf of the people, on

gardless of party, race, gender or the language your grandmother speaks, on behalf of my mother and everyone who has ever set out on their own unlikely journey on behalf of Americans, like the people I grew up with, people who work hard, chase their dreams and look out for one another, on behalf of everyone whose story could only be written in the greatest nation on earth, I accept your nomination the United States," she said.

She fondly remembered her mother Shyamala Gopalan and said that she misses her every day, especially when she is on the verge of breaking the highest glass ceiling of the United States. She said the November 5 election is the most important in America's history

"Our nation with this election has a precious, fleeting opportunity to move past the bitterness, cynicism, and divisive battles of the past. A chance to chart a new way forward. Not as members of any one party or faction, but as Americans," she said in her 40-

"I will be a president who unites us around our highest aspirations. A president who leads and listens. Who is realistic, Practical and has common sense. And always fights for the American people. From the courthouse to the White House, that has been my life's work," Harris

She laid out the consequences of electing former president Trump, 78, to a second term.

"In many ways, Donald

the consequences of putting Donald Trump back in the White House are extremely serious,"

She spoke about the "chaos and calamity" of his years in the Oval Office and also pointed to him questioning election results in 2020 when he lost his reelection bid to Biden.

she warned.

"Donald Trump tried to throw away your votes. When he failed, he sent an armed mob to the United States Capitol where they assaulted law enforcement officers. When politicians in his own party begged him to call off the mob and send help, he did the opposite. He fanned the

Trump was convicted on 34 felony counts in a hush-money case and that a federal jury in his civil defamation trial found that the former president had sexually abused writer E Jean Car-

"He was found guilty of fraud by a jury of everyday Americans, and separately found liable for committing sexual abuse," she said.

In describing her "unexpected" ascent to the top of the Democratic ticket after President Joe Biden decided to leave the race in July, Harris said that she is "no stranger to unlikely jour-

"America, the path that led me here in recent weeks was no doubt unexpected. But I'm no stranger to unlikely journeys," Harris said

Ukraine says it has recaptured land in the Kharkiv region, reversing some Russian gains there

KYIV, Aug 23: Ukrainian forces say they have recaptured territory in the eastern region of Kharkiv, where Russia launched a large offensive in the spring that brought initial gains but the operation soon stalled

Ukraine's 3rd Separate Assault Brigade said in a statement late on Thursday that its forces advanced nearly two square kilometers (about threequarters of a square mile) in that area.

It was unclear when the attack was launched, its scale, and the area of the offensive, and it's hard to predict if it will have further impact on the battlefield. Ukraine's reported counteroffensive in the Kharkiv region comes as its forces have gained new momentum and altered the battlefield this month.

Kyiv launched a shock offensive into Russia's western Kursk region on August 6, while simultaneously intensifying a drone war against military and fuel targets that sparked blazes deep in Russia this week

On Friday some new details emerged about damage and injuries caused by some of those attacks.

A Ukrainian drone attack targeting a distant Russian air base in its Volgograd region caused significant damage to an airfield that reportedly housed glide bombs used by Moscow in the war, satellite photos analyzed Friday by The

at the port of Kavkaz in Russia's Krasnodar region on Thursday injured 13 people, Russia's state news agency Tass reported on Friday. Citing health officials, Tass said that four of the injured have been hospitalized and one other person remained unaccounted for.

Ukraine's gains have reshaped the battlefield and buoyed the morale of Ukrainians 10 years after Russia first invaded their country, and 2 1/2 years after Moscow launched a full-scale invasion that has led to mass death and destruction and created Europe's largest refugee crisis since World War II.

Ukraine and its Western allies hope that the regained momentum could strengthen Kyiv's hand on the diplomatic front. A visit to Kyiv by Indian Prime Minister Narendra Modi, who is meeting Friday with President Volodymyr Zelenskyy, is being closely watched. Modi, who has maintained cordial ties and economic relations with Russian President Vladimir Putin, could play a role in forging a mediated peace.

But the incursion into Russia itself is risky. It has highlighted Russian vulnerabilities but also further stretched Ukrainian forces, who were already fighting on a frontline running for hundreds of kilometers. (AP)

Last body from sunken superyacht has been recovered off Sicily

ROME, Aug 23: Italian rescuers brought ashore the body of the final missing person who was on a superyacht that sunk off the coast of Sicily.

The woman's body was detected on Friday, the Coast Guard said. She has not been officially identified, but Hannah Lynch, the 18-year-old daughter of British tech magnate Mike Lynch, is reportedly unaccounted for. The Lynch family was aboard The Bayesian, a 56-meter (184-foot) British-flagged yacht, when went down in a storm early Monday.

Civil protection officials said they believe the ship was struck by a tornado over the water, known as a waterspout, and sank quickly.

Mike Lynch's body was recovered Thursday. He had been celebrating his recent acquittal on fraud charges with his family and the people who had defended him at trial in the United States.

His wife Angela Bacares was among the 15 survivors. Divers struggled to find the six bodies trapped in the yacht's hull 50 meters (164 feet) underwater. (AP)

PARIS, Aug 23: After the excitement of the Paris Olympics and a Mediterranean vacation now French President Emmanuel Macron has to figure out how to make his country governable again.

Faced with a hung parliament, social tensions and ballooning debt, Macron kicked off talks on Friday with key political players in a bid to choose a new prime minister who would form a government and end the deadlock created by snap legislative elections last

Members of the leftwing New Popular Front coalition that won the most seats pressured Macron for a quick decision. Their nominee for prime minister, littleknown civil servant Lucie Castets, said after Friday's meetings in the Elysee Palace that she was ready to govern, and ready for compromise to get things done.

But the party only has about a third of the seats in the National Assembly, France's powerful lower house of parliament, and no party has a majority. Macron's centrist alliance came in second and the far-right National Rally came in third.

There's no rulebook that requires Macron to name a candidate from the party that won the most responsible." The New Popular

Front, which includes the hard-left France Unbowed, the Socialists and the Greens, has insisted that the prime minister should come out of their ranks as the largest group. Macron last month ap-

peared to dismiss Castets, saying in a televised interview "the issue is not a name provided by a political group" and stressing instead the need for a parliamentary majority behind the candidate.

Security is stepped up at a NATO air base in Germany due to a potential threat'



BERLIN, Aug 23: Security at a NATO air base in western Germany has been raised because of intelligence information pointing to a "potential threat," and all staff not essential to missions have been sent home as a precaution, NATO

The Geilenkirchen air base, near the border with the Netherlands, is where the alliance's Airborne Warning and Control System, or AWACS, aircraft are based. A post on the NATO AWACS fleet's account on social media network X late Thursday night announcing that "we raised the security level" did not elaborate on the nature of the potential threat. It said that "operations continue as planned."

The Geilenkirchen base said Friday that it had nothing to add to the statement and "the situation at the moment is unchanged." German news agency dpa said a reporter saw police cars on the grounds of the air base. Police confirmed a deployment on Thursday night but gave no details, and offered no information on Friday morning.

Last week, a major German air force based near Cologne was locked down for several hours amid fears that its water supply might have been tampered with. An investigation found no evidence of such sabotage. There were also reports of suspicious observations at Geilenkirchen and a person was briefly detained for questioning near the base, dpa reported at the time, but there turned out to be nothing untoward.

The incidents come at a time of iitters about the possible vulnerability of infrastructure to attempted Russian sabotage.

On Thursday, prosecutors in Flensburg, in Germany's far north, said they were investigating suspicions of espionage for the purpose of sabotage, without elaborating on who might be behind it. German media reported that drones had been spotted over a chemical park in Brunsbuettel, on the North Sea coast.

A statement by the Security Services Division of the Home Affairs Ministry on Thursday said diplomatic passports received by the former prime minister, ex-PM's advisors, ex-cabinet members and all members of the recently dissolved Jatiya Sangsad (Parliament) and their spouses would be revoked immediately, the official BSS news agency reported.

President Mohammed Shahabuddin in August dissolved the 12th Parliament after Hasina, 76, fled the country. Currently, an interim government led by Nobel Peace laureate Muhammad

would also be revoked immediately upon termination of their tenure or appointment, it said.

The release said ordinary passports may be issued in their favour based on the reports of at least two investigating agencies, it added.

Hasina fled to India after being forced to resign in the face of a studentled mass uprising on August 5.

According to the Indian visa policy, Bangladeshi citizens holding diplomatic or official passports are eligible for visa-free entry and a stay of up to 45 days, The Daily Star newspaper said. As of Thursday, Hasina has already

spent 18 days in India. Hasina does not hold any passport other than the diplomatic passport issued in her name, the paper said quoting government sources.

passport and its associated visa privileges may put her at risk of extradition.

The extradition of Hasina, who is facing 51 cases, including 42 for murder, falls within the legal framework of the extradition treaty signed between Bangladesh and India, the BSS report

According to the treaty signed in 2013 and amended in 2016, "extradition may be refused if the offence for which it is requested is an offence of a political character."

It also says that certain offences -like murder -- "shall not be regarded as offences of a political character" for the purposes of the treaty.

However, one of the grounds for refusal of extradition is if the charges being pressed have not been "made in good faith, in the interest of justice", the report said. (PTI)

The twins are here! A second set of giant panda cubs has been born in Berlin

BERLIN, Aug 23: The Berlin Zoo announced on Friday that longtime resident giant panda Meng Meng has given birth to twins — for a second time.

The cubs were born on Thursday, the zoo said in a statement. They were born only 11 days after ultrasound scans showed that Meng Meng, 11, was pregnant. Their sex has not yet been determined "with certainty."

"Now it's time to keep your fingers crossed for the critical first few days," the zoo said. The cubs are tiny, weighing just 169 grams and 136 grams (about 6 ounces and 4.8 ounces) respectively, and are about 14 centimeters (5.5 inches) long.

As with other large bears, giant pandas are born deaf, blind and pink. Their blackand-white panda markings only develop later.

"I am relieved that the two were born healthy," zoo director Andreas Knieriem said. "The little ones make a lively impression and mom

The zoo said that giant pandas usually only raise one cub when they give birth to twins, so it will "actively support" Meng Meng's child care in cooperation with two from China's Chengdu Research Base of Giant Panda Breeding who are in the German capital.

"With around 20 births a year, they have much more experience and are better able to assess development," panda curator Florian Sicks

In August 2019, Meng Meng gave birth to male twins Pit and Paule, also known by the Chinese names Meng Xiang and Meng Yuan, the first giant pandas born in Germany.

The twins were a star attraction in Berlin, but they were flown to China in December — a trip that was contractually agreed from the start but delayed by the COVID-19 pandemic.

China gifted friendly nations with its unofficial mascot for decades as part of a

"panda diplomacy" policy. The country now loans pandas to zoos on commercial

Giant pandas have difficulty breeding and births are particularly welcomed. There are about 1,800 pandas living in the wild in China and a few hundred in captivity worldwide. Meng Meng was artificially inseminated on March 26.

Female pandas are fertile only for a few days per year at the most. The new arrivals and their mother won't be on show to the public for the time being — but visitors can still see Jiao Qing, 14, as male pandas don't get involved in rearing cubs. (AP)

IMPHAL, Aug 23: Three Manipur MLAs from the Paite and Hmar tribes have expressed concerns about the use of the term 'Kuki Zo' in press statements and social media, arguing that it does not adequately represent their tribes and fails to honour their distinct identities.

In a statement on Friday, Tipaimukh MLA N Sanate said, "I remain committed to upholding the aspirations and dreams of my people. I would like to make a solemn clarification that I have never endorsed, nor will endorse, any platform, organisation, or statement that excludes the Hmar nomenclature."

Thanlon MLA Vungzagin Valte said, "The recent usage of the term 'Kuki Zo' is perceived by many within my community as non-inclusive and assimilative. I cannot accept or endorse any term that does not respect the individuality and dignity of all groups that form the fabric of my constituency."

Valte emphasised that he is a "Paite scheduled tribe belonging to the Zomi community" and urged stakeholders to promote a term that unites and honours their shared history and future aspirations. Kuki and Zomi are terms used to describe various sub-tribes sharing related customs and identities.

The term 'Kuki' became popular during the 19th and 20th centuries under British rule, while 'Zomi' is a collective identity adopted by some Kuki-Chin language speakers in India, Myanmar, and Bangladesh. Zomis generally reject the labels 'Kuki' and 'Chin. '(PTI)

Workers break barricades

BJYM's rally: Police use tear gas shells, water cannons

RANCHI, Aug 23: The Jharkhand Police on Friday lobbed tear gas shells and used water cannons to disperse Bharatiya Janata Yuva Morcha (BJYM) workers who broke barricades during a protest rally here against the "injustice" meted out by the Hemant Soren government and its "failure to fulfil election promises"

The protesters, gathered in the rally, tried to march towards Chief Minister Hemant Soren's residence, which is located near the Morabadi Ground, the venue of the protest programme, and the police baton-charged them.

BJP leaders claimed several workers were injured during the baton charge by the police with party leader Amar Kumar Bauri claiming that the "time has come to wipe out the JMM-led coalition from the state".

"No one can stop us," he said. The district administration enforced Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (BNSS), which replaced Section 144 of the CrPC. within a 500-metre radius of the Morabadi Ground, excluding the premises.

prohibitory orders banned public meetings, rallies, dharnas, demonstrations and gatherings of five or more people within this perimeter from 11 am to 11 pm on Friday.

Additionally, carrying arms, ammunition, explosives and traditional weapons such as lathis.

spears, bows and arrows is prohibited and using loudspeakers is barred in the area, an official release said.

A police official said BYJM workers violated the prohibitory

Ranchi Senior Superintendent of Police Chandan Kumar Sinha said, "Permission has not been sought for the rally, it was sought for 'sammelan' or meeting, which has been granted. Beyond the periphery of Morabadi Ground, we have promulgated prohibitory orders so no rally is allowed. We have made sufficient deployment. We have also appealed to the organisers to limit the programme to meeting

Another police official said, "We have erected barricades near the chief minister's house and Morabadi Ground to prevent any untoward incident.'

The police personnel batoncharged the protesters to prevent them from going towards the CM's house, he said.

Workers of the Bharatiya Janata Yuva Morcha gathered in the Morabadi Ground where leaders of the BJP were scheduled to address the 'Yuva Aakrosh Rally".

A scuffle broke out between police personnel and BYJM and BJP workers led by party leader CP Singh during the rally.

The BJP termed the imposition of prohibitory orders as an attempt to "stifle voices" of

Bharatiya BJYM workers against the "injustice" meted out by the Hemant Soren government and claimed that hardly two months are left before the government would be shown the exit door in the assembly elec-

Union Minister Shivraj Singh Chouhan attacked the JMM government, alleging that it was attempting to "stifle the voices of workers", which would prove to be "the last nail in its (the JMM government's) coffin".

The order noted concerns that some organisations or parties are planning to hold dharnas, demonstrations and rallies and there is a possibility that protesters may gherao the chief minister's residence.

"Such activities may cause disruption in government work, traffic movement may get affected, law and order situation may arise and public places may witness disturbances. Therefore

Countless questions waiting for BJP in UP: Akhilesh

Siddaramaiah, Shivakumar in Delhi to discuss MUDA 'scam' with Congress high command

NEW DELHI, Aug 23: Karnataka Chief Minister Siddaramaiah and Deputy Chief Minister D K Shivakumar arrived in the national capital on Friday for crucial meetings with top Congress leaders.

Sources indicate that the primary focus of these discussions will be to formulate a strategy ahead of next week's high court hearing on the controversial Mysuru Urban Development Authority (MUDA) 'scam' case. The MUDA 'scam' has been a thorn in Siddaramaiah's side, with allegations of illegal land dealings involving the chief minister and his wife Parvathi flying thick and fast. At the heart of the controversy are claims that Parvathi received 14 plots in exchange for 3.16 acres of land, which was allegedly acquired illegally by MUDA.

Adding to political pressure, Karnataka Governor Thawar Chand Gehlot has recently sanctioned investigations under the Prevention of Corruption Act, intensifying scrutiny of the chief minister.

Sources privy to the matter suggest that the Delhi meetings will also address pending corruption cases against the state BJP leaders. The Congress leadership is expected to devise a counter strategy to exert pressure on the governor.

Accompanying Siddaramaiah and Shivakumar are several key state ministers, including Home Minister G Parameshwar, Social Welfare Minister H C Mahadevappa and Minority and Housing Minister B Z Zameer Ahmed Khan, MLC K Govindaraju and Power Minister K J George. (PTI)

Pension restored for elderly in city: Atishi

Cong leader Pilot slams arrest of MLA Yadav in Chhattisgarh

RAIPUR, Aug 23: Congress leader Sachin Pilot on Friday slammed the BJP government in Chhattisgarh for arresting his party MLA Devendra Yadav in connection with the June 10 arson in Balodabazar city and dubbed it as politically motivated.

The BJP was targeting political opponents both at the Centre and the state using central agencies and police, the former Rajasthan deputy chief minister and the Congress' in charge for Chhattisgarh told reporters outside Raipur Central Jail after meeting Yadav.

"An unfortunate incident happened in Balodabazar which was the result of the state government's failure. Neither the Centre nor the state government is able to ensure protection to Satnamis, Dalits and Adivasis. Instead of taking action against the anti-social elements involved in that incident, our twotime MLA Devendra Yadav was arrested as part of a political conspiracy," he said. ment has presented a bad example by arresting him with an intention of vendetta without any evidence against him, he alleged. "The Congress and our leaders

Yadav was summoned by police and he was cooperating in the interrogation but the state govern-

Unidentified persons had vandalised 'jaitkham' or 'victory pillar', a sacred symbol worshipped by the Satnami community, near the Amar Gufa at Giroudpuri Dham in the Balodabazar-Bhatapara district in the intervening night of May 15 and 16 this year.

During a protest called on June 10 over the desecration, a mob set fire to a government office building and more than 150 vehicles were damaged. Congress leaders, including Yadav, had allegedly attended a public meeting during the demonstration held by Satnamis at Dussehra Maidan

Around 150 people, including members of National Students' Union of India (NSUI) and the Bhim "Regiment" were arrested in connection with the June 10 arson.

The influential Satnami community, founded by medieval-era social reformer Baba Guru Ghasidas, represents the largest Scheduled Castes group in Chhat-

President Murmu voices concern

Chouhan praises Modi govt's efforts for backward classes, criticises Cong for 'lip service'

PATNA, Aug 23: Senior BJP leader and Union Minister Shivraj Singh Chouhan on Friday praised the Narendra Modi government for its efforts to uplift backward classes and accused the Congress-led opposition of merely offering "lip service" to the cause.

The Minister for Agriculture and Farmers' Welfare and Rural Development was addressing a party function in memory of Ramphal Mandal, a freedom fighter who went to the gallows at the age of 19 for killing three British officials who were blamed for a police firing during the 1942 Quit India movement.

Chouhan, a former chief minister of Madhya Pradesh, noted that Mandal was a "dhanuk", a backward class "known for its contribution in nation building, in my home state as well as Bihar"

"Our opponents only service to backward classes who have got their due only under the current BJP regime, with an 'ati pichhda' (extremely backward class) Narendra Modi at the helm", said Chouhan.

He added, "It is Modi who gave 27 per cent reservation to the OBCs in entrance tests like NEET. It is this government which granted constitutional status to the National OBC Commission. Compare this with the Congress which slept over recommendations of the Kalelkar Commission".

Chouhan's averment comes in the backdrop of the opposition, led by Rahul Gandhi, making a strong pitch for "caste census", which implies enumeration of social groups other than SCs, STs and religious minorities, which was last undertaken about a century ago. The BJP leader said, "Mere talks

will not do. We need to make a difference to the lives of the common people. The Modi government is committed to build 13 lakh houses in the next four years for the benefit of the homeless. Entrepreneurship is being encouraged among women through schemes like Lakhpati

"We are also trying to ensure an increase in agricultural output, alongside a reduction in cost of farming, so that agriculture is not seen as an economically unviable activity. Activities like horticulture and floriculture are also being encouraged and farmers are being provided support when they face losses because natural calamities". the agriculture minister said.

Earlier, Chouhan held a discusion with farmers and said he was 'amazed" to see stalls of local items like makhana, rice, honey and maize put up at the state-ofthe-art 'Krishi Bhavan'

"In Bihar, we do not have large tracts of land. More than 90 per cent of cultivators are marginal farmers. But they are working wonders", remarked Chouhan.

The Minister also said that "makhana" (fox nuts), which is cultivated mostly in Bihar, is in huge demand abroad and its export would bring immense benefits to farmers.

"Diversification of agriculture is on the government's roadmap... along with traditional crops, we will encourage cultivation of items which could bring in more money", the minister added. (PTI)

MUMBAI, Aug 23: Shiv Sena (UBT) chief Uddhav Thackeray on Friday demanded the withdrawal of cases against those who had protested in Badlapur against the alleged sexual abuse of two kindergarten girls, warning that the opposition would have to hit the streets if it is not done.

Addressing a news conference, Thackeray said the August 24 'Maharashtra Bandh' called by the opposition bloc Maha Vikas Aghadi (MVA) is not political but against "perversion" and urged people cutting across caste and religion to participate in it.

He claimed the bandh would be observed on behalf of the people of the state. Slamming the Eknath Shinde government's action over the Badlapur protest, Thackeray said, "Arrests are still taking place in Badlapur. The cases against the protesters must be withdrawn

or else we have to hit the streets." A massive protest rocked Badlapur

town in Thane district on Tuesday after thousands of people hit the streets and spilled onto railway tracks to protest the alleged sexual assault of two four-yearold girls by a male attendant at a local school. At least 25 police personnel were injured in the incidents of stone-pelting at the railway station and other parts of Badlapur during the protest.

Police have arrested 72 persons in connection with the violence during the

The accused was arrested on August 17. He has been sent to police custody

Thackeray said the bandh should be "strictly" followed till 2 pm, ensuring that emergency services remain operational. He said people are entitled to express their anger not just during elections.

When all roads are shut, justice is sought in the court of people, he said. The bandh is to make the government realise that the system should discharge its duties diligently.

country's nascent space industry.

"I am also happy to note that India is moving forward to make all its space missions debris free by 2030," Murmu said.



The president presented awards to winners of the Robotics Challenge and the Bharatiya Antariksh Hackathon on the occasion

During her speech, Murmu made a mention of the research paper on the Chandrayaan-3 data that proved that the Moon was an ocean of molten magma which cooled down later.

The findings were made by scientists from Ahmedabad's Physical Research Laboratory (PRL) after studying the data from Chandrayaan-3 and published in the scientific journal Nature.

The president said ISRO had made remarkable achievements in the space sector as well as invaluable contributions to the country's

GANDHINAGAR, Aug 23: Forensic science is not just a technical field but the cornerstone of truth and iustice, Vice President Jagdeep Dhankhar said here on Friday as he called upon forensic experts to apply their skills to combat terrorism, organised crime as well as address environmental degradation and cyber

Forensic science ensures justice is served to the perpetrators and, more importantly, it helps in establishing innocence, Dhankhar said, adding that a "society that cannot listen to the cry of an innocent person is a society that is bound to slide down".

Delivering a special address at the National Forensic Sciences University (NFSU), he hailed the passage of Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita and Bharatiya Sakshya Adhiniyam and said it had unshackled us from our draconian colonial legacy.

'(With passage of the three criminal laws) we unshackled from the colonial legacy, we tested our freedom. Our tryst with freedom in the criminal jurisprudence system happened with these laws. 'Dand Vidhan' became 'Nyay Vidhan.' Not just a change, a big change, a muchneeded change, unshackling us from the draconian colonial legacy where the determining factor of law was how to deal with the subject in a stringent manner," he said



nation defines its democracy and is the first to come to anyone's mind since it touches upon our liberty, he

Asserting that forensic science is not merely a technical field but the cornerstone of truth and justice, he said the actions of those in the field of forensic science were the "ultimate refuge for the innocent" and "you help pin down the one who would be suffering ultimate culpa-

"Miscarriage of justice is a very demoralising factor for a society, and without application of forensic science, miscarriage of justice is not avoidable. Forensic science is more than just a tool to bring the perpetrator to justice. It's much beyond that. Perpetrators of justice do really suf-

fer, but this also helps in establishing innocence as well," he said.

"A society that cannot listen to the cry of an innocent person in a system is a society that is bound to slide down. You are bulwarks between an innocent person being held guilty on oral testimony that is prejudiced and motivated. Your skill comes to the aid of the innocent, and to the surprise of those who seek to wreak vengeance," he added.

As the cyber security field witnesses paradigm shift, it poses a challenge to institutions, society and individuals and increases the need for forensic experts who can investigate such crimes, Dhankhar said.

"As cyber threats become more sophisticated, exponential, the need for forensic experts who can inves-

digital infrastructure has never been greater. Cyber security becomes all the more important as India witnesses rapid growth in digitisation,"

"We account for more than 50 percent of global direct transactions. Our internet usage per capita is more than the US and China together. A 100 million farmers thrice a year benefit from direct transfer. Therefore, security is all important. It is your expertise that helps keep away cheats who seek to destabilise the system," he said.

The work that is being done in this domain is crucial for safeguarding our nation's security, protecting sensitive information and maintain ing public trust in the digital system,

Dhankhar said India has been ahead of other nations in this field so far but added that forensic experts will have to be on their toes as challenges are emanating every day.

Forensic science can also play a diverse affirmative role in addressing the challenges posed by climate change and ecological degradations by helping identify sources of pollution, track wildlife poaching and monitor compliances with environmental regulations, he said.

"The need to keep our planet safe for our future generations requires convergence of all human energy

major role. The ability to scientifically determine the course of environmental damage is essential for holding violators accountable and preserving our natural resources for future generations," the Vice President pointed out.

The VP said as India grows, the challenges are also becoming complex, with many of them coming from "within and without"

"We find people failing to respect our nationalism. It is our bounden duty as citizens of this great country to keep national interest uppermost, much higher than political or self interest. There are people quick to capitalise on disturbance in this country," Dhankar said.

"What a pain, my young friends, (when) people in authority who are great lawyers, have been ministers, members of foreign services, say what happened in neighbouring countries can happen in this country. Not a chance. Such people must not be dealt with by your silence," he added. Dhankhar urged forensic science students to ensure these narratives that are sinister and are designed to destabilise the largest functional democracy on the planet are neutralised.

'Your contribution to forensic science should not only meet global standards but also make new benchmarks as India's continual rise is exponential and trajectory geometric," he said. (PTI)

4 labourers among 5 killed as under construction roof caves in

MHOW (MP), Aug 23: Five per- Ajay Malviya (20), Gopal Prajapsons -- four labourers and their contractor -- were killed after the roof of an under-construction cottage at a resort collapsed in Indore district amid heavy rains, a police official said on Friday

The incident occurred at Choral village in Mhow tehsil, about 40km from the district headquarters, on Thursday night when four labourers and their contractor were sleeping under the freshly laid concrete slab, which suddenly came crashing down, trapping them, he said. Two of the deceased were brothers.

Police were informed about the roof collapse at around 6.30 am and they immediately rushed to the spot and started a rescue operation, Indore (Rural) Superintendent of Police Hitika Wasal told PTI over the phone from the construction site which is surrounded by forests and hillocks.

The operation ended with the recovery of five bodies, which were sent to a hospital, she said, adding We have launched an investigation into the incident.

The accident came to light in the morning when other labourers turned up for work at the site, said inspector Amit Kumar of the Simrol police station.

The deceased were identified as labourers Hariom Malviya (22), ati (45), Raja (22) and their contractor Pawan Panchal (35), Deputy Superintendent of Police (DSP) Umakant Chaudhary said. Hariom and Ajay Malviya were

brothers, he added. "The roof slab which collapsed was constructed just one or two

days ago," Chaudhary added. The police officer said six cottages were being readied at the resort and their structures appeared weak at the first glance.

The department concerned will check the quality of construction work, Chaudhary added.

Madhya Pradesh Chief Minister Mohan Yadav expressed grief over the tragedy and announced financial assistance of Rs 2 lakh each to the family of the deceased.

Indore District Magistrate Ashish Singh said, "According to initial investigation a lawyer was etting the resort built."

He said authorities were ascertaining if the owner took required permission from the village panchavat for the construction of the resort spread over an area of four

A local resident, Sanjay Yadav, said the labourers and their contractor had taken shelter under the partially built cottage to escape from downpour and were asleep when the tragedy struck. (PTI)

Improved reservoir levels across India, but northern region faces lower-than-normal level: CWC

NEW DELHI, Aug 23: The overall water-storage levels across the country's major reservoirs have improved significantly compared to last year but certain areas, particularly in the northern region, are facing lower-than-normal storage levels, which could impact water availability in the coming months, according to official data.

The Central Water Commission (CWC) has released its latest report on the live storage status of 155 reservoirs across India, revealing that the overall water-storage levels have improved significantly compared to last year.

According to the bulletin released on Friday, the live storage available in these reservoirs is 130.800 billion cubic metres (BCM), which is 72 per cent of the total live storage capacity.

However, the report also notes that certain areas, particularly in the northern region, are facing lower-than-normal storage levels, which could impact water avail-

ability in the coming months. This marks a notable increase from the 114.657 BCM recorded during the same period last year, indicating that the current storage is 114 per cent of last year's level and 112 per cent of the average

storage over the last 10 years. The report highlights regional variations in water-storage levels, with some areas experiencing better storage than others. In the northern region, which includes Himachal Pradesh, Punjab and Rajasthan, the storage levels are below normal, with reservoirs holding only 53 per cent of their capacity

This is a significant drop from the 84 per cent recorded last year. Conversely, the southern region,

covering states like Andhra Pradesh, Karnataka and Tamil Nadu, shows a more positive trend, with reservoirs at 80 per cent capacity, a substantial improvement from the 52 per cent recorded during the corresponding period last year.

The eastern region, comprising states such as Assam, West Bengal and Bihar, also reported an increase in the water-storage levels.

The reservoirs in this region are currently at 60 per cent capacity, a marked improvement from the 43 per cent recorded last year.

Similarly, the western region, which includes Gujarat, Maharashtra and Goa, has seen an increase in the storage levels, with water supply. (PTI)

reservoirs now at 74 per cent capacity, up from 69 per cent last

In the central region, which includes Uttar Pradesh, Madhya Pradesh and Chhattisgarh, the reservoirs are currently holding 76 per cent of their total capacity, reflecting a moderate improvement from the 73 per cent recorded during the same period last year.

This region's storage is also higher than the 10-year average, which stood at 68 per cent.

The CWC report concludes that the overall storage position across the country is better than both last year and the 10-year average, which is a positive sign for water availability in various sectors, including agriculture, hydroelectric power generation and drinking

continue to give sleepless nights to Delhi's businessmen as three such cases have been reported in the last 10 days from separate areas of the city, official sources said on Friday.

They said the calls were made in the names of fugitives Anmol Bishnoi and Himanshu Bhau to a jeweller in Shahdara, a businessman in Outer Delhi and a property dealer in Dwarka.

Anmol Bishnoi is the brother of jailed gangster Lawrence Bishnoi. While Anmol Bishnoi is believed to be hiding in the United States, Bhau is stated to be hiding either in Spain or in Portugal, according to the sources in the Delhi Police.

During one of the calls, the caller reminded the receiver about the Rajouri Garden Burger King case and said "hawa mein goli nahi chalegi (bullets will not be fired in the air)", the sources said. According to a police officer, who did not wish to be named, the cases have been registered at the ferred to the Special Cell and the Crime Branch for further probe.

The jeweller from Shahdara has got a police complaint filed, stating that a person called him on behalf of the Anmol Bishnoi Gang, demanded ₹ 2 crore and asked him to arrange the money in five days.

The call was received on Thursday, the officer said. The Dwarkabased property dealer has told police that he received a call from Bhau on August 15. The Outer ceived a call from Bhau on August 14, the sources said.

According to the Delhi Police's statistics, accessed exclusively by PTI, a total of 133 extortions cases were reported from across the national capital this year, till August

A total of 141 such cases were reported in the same period last year. At least 110 extortion cases were registered in the corresponding period in 2022, according to the statistics. At least 204 cases of extortion were reported throughout 2023 and 187 in 2022.

A police officer, who often deals with such cases, said the callers mostly use VOIP numbers or WhastApp numbers taken on fake SIM cards.

The sources said police have identified 11 gangs involved in making extortion calls, threatening businessmen, shootings and killings in the National Capital Region in the last few months.

The issue of the growing menace of these gangs was raised in an Delhi Police headquarters earlier this month. Officers from Uttar Pradesh, Harvana, Punjab and Raiasthan also attended the meeting.

The police commissioner had directed the officers to curb the activities of these gangs by invoking the Maharashtra Control of Organised Crime Act (MCOCA) and other stringent local laws wherever applicable. The MCOCA is also applicable in

40 children injured after school balcony collapses



BARABANKI (UP), Aug 23: At least 40 children were injured, five of them seriously, after a portion of the first-floor balcony of their school here collapsed on Friday, police said.

The children are being treated at the district hospital. The condition of five students is stated to be "critical", Barabanki Superintendent of Police (SP) Dinesh Kumar Singh said.

Singh said the incident took place at the Awadh Academy School, a private institution, when a large number of children gathered on the first-floor balcony while going down to attend the

morning assembly. The 40 injured children were rushed to the Jahangirabad Primary Health Centre, around 300 metres from the school, and after they were given first aid, they were referred to the district hospital, police said. Many of the students were pulled out from under the debris of the collapsed balcony, they said. At the hospital, the children are being treated for injuries to their face, neck,

plastic waste.' Dressed in a green overcoat over a pale yellow churidar, she carries a plastic sack as she visits each doorstep.


At 48 years, Dhanuja looks much older with stress marks etched on her face, but she always wears a happy smile.

Dhanuja dropped out of school in the

9th standard when her parents married her off to a 19-year-old 'Chenda' (a famous Kerala percussion instrument) artist. She spent years living in Chengalchoola, a slum in Thiruvananthapuram, facing many struggles. But these chal-

lenges would later shape her journey as a She penned a book recounting her struggles as a slum dweller, and it is now part of the curriculum for BA students at Kannur University and MA students at Calicut

The book, "Chengalchoolayile Ente Jeevitham" ("My Life in Chengalchoola"), is



now in its fifth edition.

"I am not an imaginative writer. What I have written is what life gave me in Chengalchoola. I do not think it is literature, but my life," Dhanuja Kumari told PTI, sitting in her one-room house in Rajaji Nagar, earlier known as Chengalchoola.

Her house is built using tin sheets erected on four rows of cement hollow bricks, with a roof made of similar tin sheets. The house has no windows and has a small area for cooking and washing.

An automatic top-loading washing ma-

chine is the most expensive piece of equipment in her house.

Sitting on her queen cot, which occupies almost 90 per cent of the space in her oneroom house, Dhanuja recalled how she became a writer. "Our colony was notorious at that time, and we will be writing police petitions almost every day. They used to call me to write petitions, as I used to write them elaborately. That is what helped me sharpen my language," Dhanuja said, with

a smiling face as always. Dhanuja had a troubled childhood, with her parents quarrelling between them reg-

"They had small issues, but sometimes they stopped seeing each other for a year or more. So they had sent me to a Christian convent, where I stayed and studied," she said, recalling that a practice the convent insisted all students follow was her introduction to writing.

"The convent teachers asked us to write down whatever we had done during the day in a small notebook. The bad things we did and the good things we did. Those were my first writings," Dhanuja said.

She continued doing the same when she moved into the present single room house along with her husband at the age of 14. "My husband was just 19, and we were not mature enough to run a family. There were so many problems, and the discrimi-

nation we faced on the basis of caste and

our life in the colony was too difficult to

bear. I wrote all my pains, experiences,

and little happiness we had in between," Dhanuja said. As she grew up, she continued to be active in society and wanted people to have a different view of her colony and its peo-

She fought fiercely for the rights of the colony people to have a dignified life.

"I used to tell everyone--the social workers, the researchers who visited our colony--that they were only interested in their study materials and not in our lives. I used to give public speeches. Hearing this, a noted writer, Vijila, prompted me to compile my writings as a book."

She published the book when she was

38 years old, which was very well accepted by the readers, and the universities have now included it in their curricula. Dhanuja is writing the second part of her book. "This book again would be my experiences. I do not know how to write in the language of literature," Dhanuja said. Apart from newspapers and children's

Sarkata in 'Stree 2' most warped form of patriarchy: writer Niren Bhatt

NEW DELHI, Aug 23: What ties all movies in the Maddock Films horror comedy universe together is the representation of social fallacies and Sarkata, the newest villain in "Stree 2", is the symbol of all that is wrong about patriarchy, says writer Niren Bhatt.

The Bhavanagar-born screenwriter, who ditched a high paying corporate job to join showbiz around 2007, is delighted with the response to "Stree 2" but admits the numbers are a "bit crazy".

"People have been asking for the film for six years, but we don't dwell much into expectations," he said, referring to the much awaited sequel to 2018's "Stree" which released on August 15 and is nearing Rs 500 crore mark globally.

Bhatt, who also wrote other successful films in the horrorcomedy franchise "Bhediya" and "Munjya", said all these fantastical characters represent something about society.

"Some people complain that there is a lot of humour but less horror or vice versa but these are not horror films where actual ghosts are haunting people. All our ghosts are fallacies of our society. Sarkata is the most warped form of patriarchy.

'Stree is the symbol of matriarchy, she is not a witch. Bhediya is the protector of the forests. We have designed these characters in a certain way. We are not talking about hocus pocus or spirits out of the blue," the writer told PTI in an interview. While "Stree" revolved around a female ghost, who was wronged in her mortal life, its follow-up focuses on a headless villain called Sarkata with a connection to the eponymous charac-

Directed by Amar Kaushik, the new film brings back the original star cast of Rajkummar Rao, Shraddha Kapoor, Abhishek Banerjee, Pankaj Tripathi, and Aparshakti Khurana. "Stree 2", which follows Sarkata abducting women with an independent voice, hits harder in the backdrop of the Kolkata alleged rape-murder and the Justice Hema Committee report on women's exploitation in Malayalam cinema. Storyteller Himanshu Bajpai says his 'Dastan' on Wajid Ali Shah challenges colonial narrative

LUCKNOW, Aug 23: Lucknowbased storyteller Himanshu Bajpai is set to present a compelling Dastan (story) on Wajid Ali Shah, the eleventh and final king of Awadh, which he says is aimed at challenging entrenched colonial narratives.

The Dastango (storyteller) says that through "Dastan-E-Jaan-E-Aalam" his attempt is to highlight the cultural and historical significance of the monarch, whose story has been subject to differing interpretations over the years.

Bajpai, who has received accolades from Sahitya Akademi, former President Ram Nath Kovind and praise from Prime Minister Narendra Modi in 'Mann ki Baat', described the story as a culmination of years of research and personal dedication.

Ahead of the August 24 public premiere of the Dastan here, Bajpai told PTI said that his fascination with Wajid Ali Shah began early in life, influenced by the rich storytelling traditions of Lucknow, where the stories about the king are widely shared.

"From childhood, I was immersed in stories about Wajid Ali Shah. It became evident that he was a remarkably interesting character, with narratives deeply embedded in the fabric of old Lucknow." He said that while the British established a "negative portrayal" of Wajid Ali Shah to justify the annexation of Awadh, the local sentiment in Lucknow tells a different story. The colonial narrative, as Bajpai elaborated, portrayed Wajid Ali Shah

as an ineffective and indulgent ruler, suggesting that his removal was necessary for the welfare of the people.

'The British aimed to discredit Wajid Ali Shah to legitimize their control over Awadh. They depicted him as a failure and his removal as a necessity," Bajpai said and criticised this portrayal as a distortion designed to serve colonial interests.

Bajpai said local perspective on Wajid Ali Shah is starkly different. "For the people of old Lucknow,

Wajid Ali Shah is a cherished figure. His reign is remembered for nurturing the Ganga-Jamuni Tehzeeb, an amalgamation of cultural and religious traditions," he noted.

He emphasised that the king's contributions to music, theatre, and the arts significantly shaped the cultural landscape of Lucknow.

The storyteller described his mission as both a personal and cultural endeavour. "As a Lucknowi, I felt a deep sense of protest against the colonial myths that have overshadowed the true legacy of Wajid Ali Shah," Bajpai said. He said the Dastan is intended to present the king's story as it is remembered by those who lived through his era, capturing the elements of love, beauty and social progress.

The research process for the Dastan was extensive, involving three to four years of meticulous work.

Bajpai compiled primary sources, including books and oral histories from local experts and elders.

"Gathering material from various sources, including books in English, Hindi, Urdu, and Bangla, was a monumental task. The challenge was to piece together an authentic narrative from a wide range of perspectives," he

Bajpai also addressed the political significance of the Dastan, noting that it aligns with the broader theme of revisiting historical narratives in the context of the 'Azadi ka Amrit Mahotsav'. "This Dastan is not only a tribute to Wajid Ali Shah but also a political act aimed at correcting historical distortions. It represents an Indian narrative that stands in opposition to the colonial version," Bajpai asserted.

He said the free and open for all performance at the Sahu Theatre here on August 24 is set to be aimed at reinvigorating public memory about Wajid Ali Shah's contributions and correcting longstanding misconceptions.

Bajpai added, "I hope this Dastan will bring to light the true essence of Waiid Ali Shah's legacy and celebrate the rich cultural heritage of Lucknow. It is a long-overdue correction to the myths that have persisted for over 150 years." Bajpai will be joined by frequent collaborator Pragya Sharma in narrating 'Dastan-E-Jaan-E-Aalam'. "Sharma who has a PhD in economics quit her government job some yeas ago to pursue her passion for storytelling. We have performed serveral shows together within India and abroad," he said. (PTI)

Just take this in: Chelsea has spent nearly \$1.3 billion on 39 players across five transfer windows since a consortium fronted by Los Angeles Dodgers partowner Todd Boehly and Clearlake Capital bought the Premier League club from its long-time owner, Russian oligarch Roman Abramovich, for \$3.2 billion in May 2022.

Throw in the club having four different full-time managers in this period — plus another coach on a temporary basis — and the revolving door at Chelsea, a sixtime English champion and twotime European champion, simply hasn't stopped spinning.

"It's not a mess like it looks from the outside," Enzo Maresca, the latest Chelsea manager, said Wednesday as he attempted to explain the wisdom behind taking the number of



players in the squad to 43 by signing two wingers — Pedro Neto and Joao Felix — for a combined \$130 million over the

This while already having five wingers in the squad, including

signed for more than \$100 million just last year and another — Raheem Sterling — who was the first signing of this unprecedented two-year trolley dash for

nearly \$60 million. Sterling has been stripped of his squad number following the

arrival of Neto and is one of around 20 players "training apart," Maresca said. Among them is striker Romelu Lukaku, signed three years ago for a then-club record of \$135 million, and goalkeeper Kepa Arrizmillion.

Not much seemingly makes sense in Chelsea's brave new era that has so far brought underwhelming Premier League finishes in 12th and then sixth place

"It's been a crazy one to follow so far," Dr. Dan Plumley, sports finance expert at Sheffield Hallam University, told The Associated Press, "and it shows no sign of slowing down."

Plumley said the Chelsea owners' initial "aggressive" play in the transfer market to overhaul the squad was not unexpected, even if spending \$280 million in the summer of 2022, \$350 million in January 2023 and more than \$400 million in the offseason of that year was unprecedented for a soccer club. In the current window, the outlay is more than \$250 million on 10

"You are thinking, That's the initial burst but now you have to rein it in a little bit," Plumley said in a phone interview. "But they seem to be carrying on, which raises a few question marks around what the actual strategy is there and what are the owners looking to do." (AP)

NCC Unit NER trophy unveiled

Not many takers as PCB sells broadcast rights for nearly half of reserve price

KARACHI, Aug 23: The Pak-rent and next season. istan Cricket Board has settled for nearly half of its reserve price kept for selling broadcasting rights for the international home matches between the period of August 2024 and December 2026.

The broadcasting rights for the Pakistan region have been sold for PKR 1.72 billion, which is at least PKR 1.48 billion less than the initial reserve price of PKR 3.2 billion the board kept for selling the rights. However, the PCB officials, without having sharing any figures, claim that the rights were sold at more than twice the amount from the previous rights cycle (FTP 2021 to 2024).

As per available details, the PCB recently sold its Pakistan region broadcasting rights for the 28-month period to a Pakistani consortium of ARY and Tower Sports and claimed to have sold it for a higher amount when compared with the last contract.

The PCB said that the rights were awarded "following a transparent tender process" in which several bids were received.

The rights are for 11 Tests, including seven in the 2024-25 season, 26 ODIs and 24 T20Is.

The ODIs include a couple of three-nation ODI series in the cur-

The fact that no high profile foreign broadcaster showed interest in the Pakistan international home season rights is an indication that the PCB is facing problems in generating revenues expected from broadcasting rights.

Even Pakistan Television, the state owned network, bid PKR 1.6 billion and didn't bother to increase the amount even though the eventual successful bid was for PKR 1.72 billion.

"It is far less than initially what the PCB had anticipated while keeping its reserve price of PKR 3.2 billion," a source aware of the developments said.

Additionally, the PTV bought the broadcasting rights after securing the sub-licensing for PKR 500 million from the consortium

Therefore, both the consortium and the PTV earned profitable deals but PCB failed to make the most jam-packed season finan-

Interestingly, the PCB is now finding it difficult to get a broadcaster in the UK to show the Pakistan and England Test series in October-November with Sky Sports showing no interest at all in securing rights for the UK terri-

Olympic champion Wanyonyi runs 4th fastest 800 meters all-time in first major meet after Paris Games

LAUSANNE (SWITZER- Paris after becoming the Olympic LAND), Aug 23: Olympic champion Emmanuel Wanyonyi ran the fourth-fastest 800 meters time in history Thursday at the first major track meet after the Paris Games.

Wanvonvi clocked 1 minute. 41.11 seconds — 0.08 faster than his winning time in Paris two weeks ago — to tie Wilson Kipketer's mark in 1997 that was a world record then. Only Wanyonvi's fellow Kenvan David Rudisha has run the 800 faster.

"I'm so happy to have run that crazy time here in Lausanne," Wanyonyi said. "I really loved the crowd here.'

It was a fast early start to the storied Athletissima meet as the global Diamond League circuit resumed after a pause for the Olympics. Jakob Ingebrigtsen regained his authority in the men's 1.500 — after a shocking fourth place in Paris — to beat Olympic champion Cole Hocker by more than two seconds.

In the men's 200, Olympic champion Letsile Tebogo kept his form despite a return trip home to Botswana to win in 19.64 seconds easing into the line. "It was a great race for me here today," said the 21-year-old Tebogo, who said on the eve of the race he had not trained in the previous week.

Tebogo still finished 0.14 ahead of Erriyon Knighton, who placed fourth in Paris. Noah Lyles, who took bronze in 200 in champion at 100, skipped the Swiss meet.

The standout performance was by the 20-year-old Wanyonyi, who surged past Marco Arop on the back straight and finished 0.61 clear of the Olympic silver medalist from Canada.

Wanyonyi was 0.20 off Rudisha's world record of 1:40.91 set winning the first of his back-toback Olympic titles in 2012 in

Ingebrigtsen's winning time of 3:27.83 was a meet record in Lausanne though still would have been fast enough only for fourth place at the Olympics.

"For me, a lot of it has been mental including going home, taking some easy days and then getting back to work," said Ingebrigtsen, who did win Olympic gold in the 5,000. "Tonight's race gave me good answers." Hocker acknowledged it had been "a new challenge being announced as Olympic champion," though the American's 3:29.85 time was second fastest in his career behind his 3:27.65 in Paris. Dina Asher-Smith won the women's 100 clocking her season-best time of 10.88. That would have won a bronze medal in Paris where the British star failed to make the

"After the Olympics I took some time to refocus and now I'm just enjoying running, feeling fit and injury free," Asher-Smith

NEW DELHI, Aug 23: Avani air rifle gold and 50m rifle 3-po-Lekhara would have never taken up shooting if not for the persuasion of her parents two years after a catastrophic car mishap left her paralysed waist down and confined to a wheelchair at

the age of 11. As the 22-year-old, who is one of the most recognisable faces in Indian para sport, embarks on a journey to win more medals for the county in rifle events at the Paris Paralympic Games, she thanked her family for giving meaning to her life at a time she was struggling to overcome the trauma.

Just six years after trying her hand at archery and then shooting at the Kendriya Vidyalaya No.3 in Jaipur during the summer vacations in 2015, Avani became the toast of the nation by winning India's first medals in shooting at the Tokyo Paralympics in SH1 category -- 10m

sitions bronze.

"Before the accident I was not into any sport and after that too I was not at all thinking about joining any sport. But my parents always thought that I need to do something other than studies. I went back to school two years after the accident. I went

to KV No. 3 Jaipur. "They have these regional games, national games, so my parents also thought of enrolling me in some sport, and then I went there during my summer vacations in 2015 and I tried archery, I tried shooting.

Neeraj finishes second in Lausanne Diamond League with season's best 89.49m

LAUSANNE, Aug 23: Star Indian javelin thrower Neeraj Chopra finished second in the Diamond League here after producing a season's best effort of 89.49m from his last attempt in a gritty performance despite lingering fitness concerns.

The 26-year-old was at the fourth spot till the fourth round before sending his spear to 85.58m in his fifth attempt. He saved the best for the last and his final attempt measured 89.49m on Thursday, a marginal improvement on the 89.45m achieved in the Paris Olympics a few days ago.

He was in danger of missing the sixth throw but his fifth round effort of 85.58m saved him. Only the top three after five rounds get their respective final attempts.

Two-time world champion and Paris Olympics bronze-medallist Anderson Peters of Grenada won the event with a monster throw of 90.61m in the second round while Julian Weber of Germany took the third spot with 87.08m.

"The feeling wasn't great at first, but I am happy with my throw, especially the second (career) best throw on my last attempt. It was a tough start, but the



comeback was really nice and I enjoyed the fighting spirit I showed," Chopra said after the

"Even though my early throws were around 80-83m, I pushed hard in the last two attempts finishing strong. Competing at this high level, it's important to stay mentally tough and fight through.'

Pakistan's Arshad Nadeem had beaten Chopra for the gold in Paris with an Olympic record throw of 92.97m. Nadeem was missing from the field here.

On Saturday, Chopra had confirmed his participation here, postponing a decision on a possible surgery till the end of the season.

Chopra had won the Lausanne leg in 2022 and 2023 and finished second behind Vadlejch in the winner-takes-all Diamond League final in Eugene, USA, last year.

This season's DL finals will be held in Brussels on September 14. He needs to finish in the top-six of the series standings to qualify for the finale. There is another DL meeting --

ICC planning multi-million dollar fund to save Test cricket: Report

SYDNEY, Aug 23: The International Cricket Council (ICC) is mulling a dedicated fund of at least USD 15 million for Test cricket that will help increase the players' match fee and address the migration of talent to lucrative T20 franchise leagues.

The initiative, which was was proposed by Cricket Australia (CA), has the support of BCCI Secretary Jay Shah, who is the front-runner to become the next ICC Chairman, and the England and Wales Cricket Board (ECB), a report in 'The Sydney Morning Herald' stated.

The fund would increase the minimum match payment for Test players and cover the cost of sending teams on overseas tours. It would support national boards like the West Indies that currently struggle to compete with the wages offered in global T20 competitions. "The fund would ensure a minimum Test payment for all players, thought to be USD 10,000, and pay the costs of overseas tours for struggling countries," the report stated.

"It's fantastic to see some momentum behind the Test match fund," CA chairman Mike Baird, who floated the concept in January, said. "We need to take away

the barriers and encourage Test cricket to be the best of the best. To retain that history and that legacy, which goes alongside the newer forms of white ball cricket," he added. The fund is unlikely to benefit the three wealthiest cricket nations - India, Australia, and England - since they already offer sub-

However, how much money is available for Test cricket from the ICC is also likely to depend on a dispute with broadcaster Star, the report added.

The BCCI had introduced an incentive scheme for India's men's Test cricketers earlier this year to encourage players to prioritise Test cricket and reward consistent performances in the longest format of the game. Under the new scheme, a player who plays at least 75 per cent of India's Test matches in its annual cycle, from October to September, will earn a whopping Rs 45 lakh per match in addition to the Test match fees of Rs 15 lakh.

The players who feature in the 50-75 per cent games bracket will earn a bonus of ₹ 30 lakh per match. The non-playing members -- if selected in the squad -- will be paid half the amount. (PTI)

Sri Lanka-New Zealand opening Test at Galle to have a rest day

DUBAI, Aug 23: Sri Lanka's opening Test against New Zealand at Galle next month will be a six-day affair with the provision of a rest day owing to the presidential election in the is-

The Test, scheduled to commence on September 18, will have a rest day on September 21, "owing to the Presidential Election of the Democratic Socialist Republic of Sri Lanka", said an ICC release on Friday. It will be the first time in more than two decades that Sri Lanka have been scheduled to host a Test across six days, with their match against Zimbabwe in Colombo in 2001 also including a rest day due to Poya Day (full moon), said the ICC.

The two-match series is part of the ongoing ICC World Test Championship cycle with the second Test scheduled at the same venue from September 26-30. Rest days were a common feature in Test cricket in the last century, with several matches in the cricketing world being played across six days with Sunday usually being an off day. More recently, Bangladesh played a Test-series opener against Sri Lanka in December 2008, which was a six-day affair because of a parliamentary election. (PTI)
