

Dhing rape case prime accused dies after jumping into pond

Two other accused still at large • Villagers disallow burial of deceased accused

NAGAON, Aug 24: The prime accused in the rape of a minor girl in Dhing of Nagaon district died on Saturday after jumping into a pond while in police custody.

The accused, identified as Tafajjul Islam, was arrested on Thursday night. However, he jumped into the pond while being taken to the crime scene around 3.30 am for reconstruction of the incident.

"The accused attacked a policeman, escaped custody, and jumped into the pond. The SDRF was immediately alerted, a search operation was launched, and his body was recovered after nearly two hours. The policeman was also injured and admitted to a hospital," Nagaon Superintendent of Police Swapneel Deka said.

Deka also stated that the SDRF personnel were called promptly, and Islam's body was retrieved early Saturday morning.

Meanwhile, local women's organisations, chambers of commerce, and student groups, including the All Assam Students' Union and Asom Jatiyatabadi Yuva Chatra Parishad, continued their

protests on Saturday, demanding the arrest of the two other suspects who have been absconding since

The 14-year-old girl was allegedly raped by three persons who came on a motorcycle and surrounded her while she was returning home from tuition on her bicycle at Dhing on Thursday

evening. She was left injured and unconscious on the roadside near a pond, before being rescued by locals who

Following this, villagers of

Borbheti held a meeting on Saturday morning and took three decisions regarding the crime committed by the youth.

"We have decided not to allow his burial in the village graveyard, not participate in his 'janaza' (burial prayers) and social boycott of his family", a village elder Md Shahjahan Ali Choudhury told a news agency. "The village youth's crime has shamed us and we cannot allow his burial in the community graveyard", he added.

A march was also taken out from the village mosque to protest

against the incident. Chief Minister Himanta Biswa Sarma had said on Friday that stern action will be taken against the cul-

NEW DELHI, Aug 24: Congress president Mallikarjun Kharge on Saturday accused the Modi government of creating a "fake narrative" about jobs and claimed that in the upcoming assembly polls, the BJP would be taught a lesson. Kharge alleged that due to the antiyouth policies of Prime Minister Narendra Modi, there is a shortage of jobs in the country.

The latest report of Bank of Baroda shows that in 2022-23 alone, 2.43 lakh jobs were reduced in 375 companies of the country," he said in a post in Hindi on X.

Lakhs of our youth are running around to get a handful of jobs, he said. "The constable recruitment exam is going on in Bihar, in which 18 lakh candidates have applied for only 21,000 vacant posts. The paper of the exam before this was leaked four days before the exam, due to which this exam is being conducted again," he said.

Kharge further said that 6.30 lakh youth from 26 states have also applied for the recruitment of 60,000 constables in Uttar Pradesh



Cognizant files lawsuit against **Infosys over** trade secrets

NEW DELHI, Aug 24: IT major Cognizant's subsidiary TriZetto has slapped a lawsuit on Infosys in a US federal court, accusing the Bengaluru-headquartered company of stealing trade secrets and information related to healthcare insurance software. Infosys, in a statement, denied all allegations. The company asserted it is aware of the lawsuit and will defend its position in the court. Cognizant in a lawsuit filed in Texas federal court has accused Infosys of illegally accessing data from TriZetto's software --Facets and QNXT -- and using the same to develop and market a competing product. Cognizant offerings include TriZetto's Facets and QNXT, which healthcare insurance firms use to automate tasks. Teaneck, New Jersey-based Cognizant has the bulk of its employees in India. Cognizant has reportedly alleged that Infosys misused TriZetto's software to create "Test Cases for Facets," which repackaged its data into an Infosys product. Further, it has reportedly alleged that Infosys created software to extract data from QNXT, that contained confidential TriZetto information. It is interesting to note that just this week, Cognizant named former Infosys executive Rajesh Varrier as global head of operations and India Chairman the resignation of Rajesh Nambiar, president. Moreover, Cognizant's Chief Executive Officer Ravi Kumar S is also an Infosys veteran, whose 20-year career at the Bengalurubased firm saw him holding various leadership roles, including as President from January 2016 through October 2022. NEW DELHI, Aug 24: FMCG distributors have raised concerns over the "rapid and unregulated growth" of quick commerce platforms, saying it needs immediate

In a letter written to Commerce & Industry Minister Piyush Goyal, FMCG distributors' body AICPDF said this unchecked expansion of quick commerce platforms, which typically deliver goods within 10 to 30 minutes, is creating an "uneven playing field", threatening the livelihoods of millions of small retailers and distributors who have been the backbone of India's retail sector for decades.

The All India Consumer Prod-Distributors Federation (AICPDF) also suspected potential violations of FDI regulations by these quick-commerce companies and sought an immediate investigation into the operational models of these platforms.

The rapid growth of quick commerce platforms like Blinkit, Zepto and Instamart has posed significant challenges to the traditional retail sector and the established fastmoving consumer goods (FMCG)

distribution network. "We are witnessing the erosion of small "mom-and-pop" stores and a shift in the FMCG distribution landscape, as these platforms are increasingly being appointed as and Managing Director, following direct distributors by major FMCG companies, side-lining traditional distributors," AICPDF said in the

> While raising concerns regarding the compliance of foreign direct investment (FDI) regulations by the quick-commerce platforms, it said AICPDF suspects them of blurring the lines between the marketplace and inventory-based mod

els. "The FDI rules clearly prohibit e-commerce entities operating under the marketplace model from holding inventory or exercising control over the inventory sold on

their platforms. "However, it appears that these quick commerce platforms may be engaging in practices that blur the lines between a marketplace and an inventory-based model, potentially violating FDI norms," it noted.

It also requested the government to "initiate a thorough investigation into the operational models of these quick commerce platforms to ensure compliance with FDI regulations" and to "implement protective measures for small retailers and traditional distributors to safeguard their interests and prevent monopolistic practices".

AICPDF has urged the government to facilitate a dialogue between all stakeholders, including representatives from the retail sector, FMCG companies and quick commerce platforms, to establish the e-commerce companies, questioning their business model that has been impacting small retailers in the country.

Earlier this week, the Commerce and Industry Minister had questioned Amazon's announcement of USD 1 billion investment in India, saying the US retailer was not doing any great service to the Indian economy but filling up for the losses it had suffered in the country. He said that their huge losses in India "smells of predatory pricing", which is not good for the country as it impacts crores of

small retailers. The quick-commerce market in India is currently valued at approximately USD 5 billion.

Several FMCG companies, in their latest June quarter earning, reported a high double-digit growth coming from quick-commerce in online sales.

BJP steps up attack on Cong

Rahul Gandhi, asking him to make it clear if he supports the NC's stand on Article 370, a separate flag and reservations for OBC. The Congress formed an alliance with the National Conference due to its "lust for power", Uttarakhand chief minister Pushkar Singh Dhami alleged. He also posed 10 questions to the Congress and Gandhi and alleged that the Abdullahs "ruined" Jammu and Kashmir which regressed for three decades under their rule.

Describing the National Conference as a party that fomented separatism and terrorism in Jammu and Kashmir, Dhami said, "(Rahul) Gandhi owes an explanation to the nation on whether, by entering into an alliance with the National Conference, he supports the party's promise of a separate flag for Jammu and Kashmir and restoration of Article 370."

"Gandhi and his party must explain whether they want to push Jammu and Kashmir back into disorder.

"Does he support separatism and cross-border terrorism and the National Conference's decision of resuming trade with Pakistan?" Dhami asked during a press conference in Dehra Dun. Uttar Pradesh chief minister Yogi Adityanath said the "political ground" of the Congress and the NC that "reaped the harvest of hatred has become barren forever".

He also slammed Congress leader Rahul Gandhi, saying his party has "again put its anti-national intentions in front of the country by allying with the National Conference of Abdullah and Sons Family Private Limited".

"The political ground of the Congress and the NC, which harvested the crop of hatred, has become barren forever," he said, adding that the issue of terrorism and separatism has merged with the water of the Chenab River. Madhya Pradesh chief minister Mohan Yadav alleged the alliance was aimed at bringing back anarchy in Jammu and Kashmir. "Does Congress support a separate flag for J-K in accordance with the manifesto of NC? Does Con-

gress want to reintroduce Article 370 and 35A in J&K?" he alleged. "Does Congress wish for Shankaracharya Parvat to be known as Takht-e-Suliman and Hari Parvat as Koh-e-Maran? "the MP CM said. Manipur chief minister N Biren Singh accused the Congress of compromising national unity and security to satisfy its desire for power and questioned the party's motives in allying with the NC. "The Congress, which has

repeatedly risked the nation's unity and security for power, has again exposed its ulterior motive by allying with Farooq Abdullah's NC ahead of the J&K polls," Singh said. PDP chief Mehbooba Mufti, meanwhile, said her will extend complete support to the Congress-NC alliance if it is ready to accept her party's agenda. She also ruled out an alliance with the BJP, with which the People's Democratic Party (PDP) had earlier run a

coalition government. "Forget about alliance and seat-sharing, if the Congress and the National Conference (NC) are ready to accept our agenda -- that resolution of the Kashmir issue is necessary and on the opening of routes -we will tell them to contest on all the seats and we will follow you," she said. "Because, for me, the resolution of the Kashmir problem is much more important than anything else," she added

when asked if the Congress had approached the PDP for an alliance Bihar deputy chief Minister Samrat Choudhary said the Congres must disclose whether it was in agreement with the NC's contention on Article 370 and advocacy for Kashmir having a separate flag.

J-K BJP president Ravinder Raina described the pre-poll alliance of the Congress and National Conference (NC) as an outcome of the "growing popularity" of the BJP. Polls to the 90-member assembly will be held in three phases on September 18, September 25 and October 1, while results will be announced on October 4. (PTI)

Resisting migration, says Himanta

Hindus remain in turbulent Bangladesh: CM

SILCHAR, Aug 24: Chief

Minister Himanta Biswa Sarma on Saturday claimed that Hindus have not tried to enter India from Bangladesh since the neighbouring country plunged into instability.

"Hindus are staying and fighting in Bangladesh. In the last one month, not a single Hindu person has been detected trying to enter India," he said at a press conference here.

He also asserted that Muslims from the neighbouring country were attempting to crossover to seek employment in India's textile sector.

"35 Muslim infiltrators have been arrested in the past one month... they are trying to enter... but those coming are headed for Bangalore, Tamil Nadu, Coimbatore to work in the textile industry," the CM claimed.

"We have intercepted and

pushed them back. Fortunately or unfortunately, they belong to one community," he said. The infiltrators trying to

enter through Tripura, travel via Karimganj in Assam by train and reach the south Indian cities, Sarma said.

Those trying to enter India illegally are being apprehended by the police force of Assam and Tripura, and the BSF, he

Sarma maintained that if Hindus wanted to come, they would have done so at the time

"They consider Bangladesh as their motherland, hence they didn't come. We should have respect for them," the CM said.

"We have requested our prime minister to impress upon the Bangladesh government to ensure the safety of Hindus," said Sarma.

On Bengali Hindus who migrated to India prior to 2014, the deadline set for granting Indian citizenship under the Citi-

zenship (Amendment) Act, the chief minister asserted that the number of such people in Assam will nowhere be near 20 lakh, as claimed by a section of anti-CAA activists.

To ease the process for these immigrants to get citizenship, Sarma said, "Police have been directed not to visit them as they (Hindu Bengalis from Bangladesh) will take the CAA route. We are also trying for disposal of cases in Foreigners' Tribunals.

The Assam government is also trying to activate the biometrics of the eligible people, frozen during the NRC updating process, and these measures together will ensure that the Bengali Hindus don't face further problems, he said.

"I don't think the number of people who will benefit from these measures is very high. Maximum... maybe it will be 20,000. But, the anti-CAA leaders provoked the people of Assam by saying that 20 lakh people will enter and get citizenship under the CAA,"

On impact of the regime change in Bangladesh, Sarma said, "The northeast insurgency situation might change now... If a government is installed that is anti-India, we will definitely have a problem."

"But, let us wait and watch. Elections are to be conducted there. After the polls, we will know what kind of government is formed. Saying anything now is premature," he added.

The CM also said that the instability in Bangladesh could have a bearing on the Paresh Barua-led ULFA (I).

"Paresh Barua has 700 trained cadres, a very good network of well-wishers who are not well-wishers of India, and with instability in Bangladesh, he has his power.

"We cannot undermine this, but the police should have more power to control the situation. I won't say ULFA(I) is a dying organisation, but we have had peace for the last three years and we will continue to ensure it," Sarma added. (PTI)

Two teenage girls rescued after abduction; suspects arrested

GOSSAIGAON, Aug 24: In the wake of the horrific gang rape and murder of a doctor at the R.G. Kar Medical College in Kolkata, West Bengal and a gang rape of a minor girl in Dhing, a similar shocking incident has shaken the Gossaigaon subdivision, where two teenage girls went missing at night and has led to a tense situation in Tulsibil on Aug 24.

According to the information available here, two teenage girls suddenly went missing from their homes last night prompting their families to report the incident to the nearest Tulsibil police station. The police, along with the sub-divisional police officer soon receiving the information launched a search operation across various areas.

As the incident spread rapidly, local residents also accompanied in patrolling the area to find out the missing girls. Sensing danger, the group that had abducted the girls abandoned them in a deserted area and

Later this morning, when the local residents found the two girls who went missing at night from a deserted area about 10 kilometers away from Tulsibil informed the police and were taken them into custody.

The police then examined one of the girl's mobile phones, including her Instagram and Messenger accounts, leading to the arrest of three youths involved in the incident. The suspects are currently being interrogated by the police.

It is disclosed that the girls were lured by a group of miscreants from right in front of their home and taken away in a vehicle during the night. When the girls did not return home for a long time, their families grew

suspicious, leading to a state of panic. The families informed the police about the girls' disappearance, after which a search operation was launched, forcing those miscreants to abandon the girls and

One of the girls is now under police custody, while the other, who fell ill, has been admitted to a hospital for better treatment.

The police have arrested three youths in connection with the incident and have been identified as Jamal Khan (21) of Choutara, Sheikh Abdullah (21) of Harbhanga village, and Noor Alam (25) of Jaipura village. Additionally, the vehicle used in the

abduction has been recovered by the police. Following the incident, hundreds of local people came out on the street and staged protest in front of Tulsibil police station, alleging that the two girls were gang-raped and demanded a proper investigation and appropriate punishment for the culprits.

Simultaneously, local organizations like AKRASU, AMSU, and ABMSU condemned the incident and demanded a thorough investigation and strict punishment for those involved in the heinous crime. They also urged that no one should exploit this incident for communal politics or disrupt the peace and harmony in the area.

Prime Minister Modi's Ukraine visit: A strategic balancing act

rime Minister Narendra Modi's visit to Kyiv marks a significant moment in international diplomacy, reflecting India's strategic balancing act between Russia and the West amid the ongoing conflict in Ukraine. As the first leader from a nation that maintains strong relations with both Russia and Western countries, Modi's visit sends a nuanced message to global powers, particularly Russia.

Gruesome rape cases in Kolkata, Badlapur have 'political saviours'

Kolkata rape-murder" versus the "Badlapur monstrosity". The BJP is targeting West Bengal Chief Minister Mamata Banerjee for the horrendous rape-cum-murder of a trainee doctor in a hospital and the Congress is out to settle scores for the INDI-Alliance after the sexual assault on a pair of schoolgirls aged 3 and 4! Congress MLA Vijay Wadettiwar, who is Leader of Opposition in the Maharashtra Assembly, went after Chief Minister Eknath Shinde and Deputy Chief Minister Devendra Fadnavis even as a Congress team arrived in Badlapur to put

Like the LoP in the Lok Sabha Rahul Gandhi, Vijay Wadettiwar also doesn't want to be distracted by the Kolkata gangrape-cum-murder. "Maharashtra has left Uttar Pradesh behind in crimes against women," he said. The two girls were sexually assaulted by a sanitary worker, enraging Badlapur citizens who gathered in the hundreds and blocked trains. Only then did the local police lodge an FIR. The police, whether in Kolkata or in Thane, are the same, kowtowing to politicians who are neck-deep in their own mess.

Who are they protecting? The CBI is investigating the Kolkata rape-murder. On Thursday, the CBI submitted a "status report" to the Supreme Court. The report

says the "scene of crime" had been "altered" – a fact every Tom, Dick and Harry knew. What will the Supreme Court do now that it, too, knows? "Nothing" comes

Meanwhile, Maharashtra Chief Minister Eknath Shinde and Deputy Chief Minister Devendra Fadnavis passed a series of orders including setting up an SIT and a fasttrack court. The Congress is not deterred. LoP Vijay Wadettiwar said "Badlapur" was worse than "Kolkata" – i.e., "your rape and my rape" entered the arena. The Supreme Court should keep this mind when hearing the Kolkata trainee doctor's rape and murder. It is snake-eat-eat outside.

The Maharashtra Assembly elections are too close for comfort for both Congress and BJP. Think of LoP Rahul Gandhi teaming up with LoP Vijay Wadettiwar and Gandhi will harvest headlines like missionaries harvest pagan souls. There will be hell to pay for the Shinde-Fadnavis duo, which in turn will affect the Modi-Shah duo. Will the CBI's "status report" open up the Kolkata rape-murder case further? The apex court had on August 20 asked the CBI to submit the status report in a "sealed cover" so that only the CBI and the top court will know the status of the investiga-

The CBI hadn't arrested anybody though it questioned the sole accused in the rapeand-murder of the trainee doctor and also questioned the principal of RG Kar Medical College and Hospital. The CBI is making slow progress. Knowing the Kolkata Police's reputation, things were bound to be difficult for the CBI. Chief Minister Mamata Banerjee is both Home Minister and Health Minister, should the CBI summon Mamata Banerjee for questioning?

Mamata in the dock will be exciting for some and disheartening for others. In West Bengal streets will boil over. The impression one gets, however, is that the crimescene alteration has worked and Mamata Banerjee will ride this storm, too. There is a lot of circumstantial evidence but nothing to nail the real culprits. The one in custody will also go scot-free -- a civic volunteer, the man is a lout and a foul-mouthed piece of #*^ -- perfect volunteer for the cops!

The CBI's 'Status Report' is proof that the central investigating agency has surrendered to the fait accompli. Not only was the crime scene altered out of kilter, the status report also spoke of the West Bengal Police telling the rape-murder victim's parents that it "was a suicide" before confessing that it was rape-cum-murder, a largely well-known fact. Truth be told, the Supreme Court's suomotu hearing hasn't made a difference to the "untruth".

The bench of CJI DY Chandrachud, Justice JB Pardiwala and Justice Manoi Misra are hearing what's already there in the public domain and widely circulated in Social

Media. The Supreme Court cannot and will not pull a rabbit out of its hat, but the Central Bureau of Investigation might. Chief Minister Mamata Banerjee has senior counsel Kapil Sibal to fight for the West Bengal government and Sibal is under attack in social media for siding with the 'gang-rapists and murderers".

So, will the CBI be able to nail Mamata Banerjee? The beneficiaries will be the Modi government and the BJP. The rapemurder of the trainee doctor in Kolkata came at a very opportune time for those against Mamata Baneriee and the INDI-Alliance. For the first time in 11 years of Modi, there was talk of President's Rule in West Bengal though the asking price had come down to "Mamata Banerjee Resign." This, after the Supreme Court took suomoto notice. The top court saved Mamata.

So, it's Kolkata rape-cum-murder versus the Badlapur horror. Maharashtra has left Uttar Pradesh behind in crimes against women; law and order has collapsed. And if the Kolkata victim's parents were made to wait for "three hours to get a glimpse of their slain daughter", the Badlapur victims' families were made to "wait for 11 hours to get an FIR lodged." The Badlapur school allegedly has high connections in the government. Bottom-line: whether Kolkata or Badlapur, Mumbai, crime always finds a saviour in a politician. (IPA

Jobs in urban India declined in the first quarter of 2024-25

t a time when Budget 2024-25 is aiming at creating about 3 crore formal jobs, the Periodic Labour Force Survey (PLFS) for the first quarter of the current financial year shows a decline in the employment in urban India. Women workforce suffered even more than their male counterpart in all age group.

The PLFS data revealed that during April-June 2024, the labour force participation rate (LFPR) in current weekly status (CWS) declined to 39.3 per cent from 39.5 per cent during January-March 2024. For female it declined from 20.3 to 20 per cent during this period while it remained at 58 per cent for male. It means the decline was registered almost all for women workforce.

However, for the workers of 15 years and above the decline was from 50.2 per cent to 50.1 per cent. Women workers of this age group suffered much. Decline in their LFPR was from 25.6 per cent to 25.2 per cent, while there was increase in male LFPR from 74.4 per cent to 74.7 per cent.

As for the workforce in the age group of 15-29 the was a minor increase in LFPR from 40.7 per cent to 40.8 per cent, female LFPR remained stagnant at 21.3 per cent, and for male workforce it increased from 58.2 per cent to 58.9 per cent.

All these show that the policies adopted in the Union Budget 2024-25 is not working for women workforce whose participation has declined in the urban areas of the country.

As for worker population ratio (WPR) in CWS the first quarter of the current fiscal is concerned it declined form 36.9 per cent to 36.7 per cent in the urban areas. Women suffered more even in this respect whose WPR was 18.6 per cent during January-March 2024 but declined to 18.2 in April-June 2024. WPR for male increased from 54.5 per cent to 54.7 per cent during this period. Women WPR declined in all age groups while it increased for male in all age group of workers though only

There was an increase in casual labour from 10.8 per cent to 11 per cent. Regular wage and salaried employed in the urban India were just 49 per cent during April-June 2024, which was 48 per cent in the previous quarter. There was a decline in own account worker and employer, helper in household enterprise and selfemployed. Self-employed declined from 40.5 per cent to 40 per cent, helpers in household enterprises declined fore 6.4 to 6.1 per cent and own account worker declined from 33 per cent to 32.9 per cent.

There was though an increase in women regular wage and salaried employees from 52.3 per cent to 54 per cent, their percentage declined in all other categories of workers, barring the own account workers which remained constant at 27.5 per cent. Women were about four times more than male as help in household enterprises. In the first quarter about 4.4 per cent male were helper in household enterprises, but the percentage of women was 11.4 per cent in the urban India.

Maximum percentage of workers were in the tertiary sector of the economy which account for 62.4 per cent as against 62.2 per cent in the previous quarter. In the first quarter only 5.9 per cent of urban workers were engaged in agriculture, while 32.1 per cent were engaged in secondary sector including mining and quarrying.

Unemployment rate was 6.6 per cent in the urban India during April-June 2024, which was still above 6.5 per cent during October-December 2023. Female unemployment rate increased to 8.9 per cent from the previous quarter's 8.4 per cent. Unemployment rate in all age group of women increased during this period. For the women in age group 15-29, unemployment rate was 23 per cent, in the first quarter, while it was 14.8 per cent for male. Combined together total urban unemployment rate was 16.8 per cent.

Unemployment rate among urban population above 15 years of age was 6.6 per cent in the first quarter, for male it was 5.8 per cent and for female it was 9 per cent.

All these data indicates that government will need to exert more if the promises made in the Budget 2024-25 are to be fulfilled for creation of 3 crore new jobs. Union government has started talking with the state governments and UTs if they are ready to implement the labour reforms to create additional jobs, which may be a strategy to put blame on the states in respect of failure in job creation. UNHRC makes damning observations on human rights in India

United Nations Human Rights Council(UNHRC) made critical observations about the status of human rights in India in its country audit prepared after 28 years. The comments are critical about most of the areas of operations of the government where rights of the people are involved.

It was also concerned about information about multiple security breaches and vulnerabilities relating to the information stored in the Aadhaar identification database: the de facto requirement for the mandatory use of Aadhaar; and the increasing use of facial recognition technology for surveillance, and access to public benefits and voting rights; as well as by the lack of adequate privacy safeguards in content and data regulation legislation, and in the context

of search and seizures. The UNHRC stated that India should ensure that legislation regarding surveillance, content and data regulation, as well as related activities, and any other interference with privacy, such as search and seizure activities, is in full compliance with article 17 of the ICCPR and with the principles of legality, proportionality and necessity.

The UNHRC was concerned about the high levels of violence against religious minorities, such as the incidents in Manipur since May 2023 and the riots in Gujarat in 2002, and the resulting lack of accountability for human rights violations, including extrajudicial killings.

The UNHRC was also concerned about other violent incidents, such as the demolitions of places of worship and homes of religious minorities - most Muslim - following the riots during the

Ram Navami processions in 2022, and the reports of violence and lynching by 'cow vigilantes' against Muslims and Christians.

The UNHRC was also concerned about the application of nasecurity tional counter-terrorism laws to target religious minorities and about reports of public officials engaging in hate speech and inciting public violence against religious minori-

The UNHRC stated that in accordance with Article 18 of the ICCPR and General Comment 22 on the right to freedom of thought, conscience and religion of 1993, India should ensure respect for freedom of thought, conscience and religion for all and prevent combat and address all forms of discrimination and violence against religious minorities.

The UNHRC was concerned about provisions that require individuals to notify authorities of their intention to convert; contain vague wording that gives officials broad power to decide on religious conversions; impose enhanced punishments for conversion by minority groups; consider interfaith marriages as presumptively unlawful: or shift the burden of proof to the accused to show that a conversion was not coerced.

The UNHRC was concerned about information received about India's use of the Pegasus spyware to target mobile phones of journalists, activists and government officials from mid-2017 to 2023.

The UNHRC was also concerned about vigilante attacks against religious minorities. The UNHRC was concerned about 'gharwapsi' (homecoming) ceremonies, where religious minorities are allegedly coerced to convert to Hinduism; according to reports received, over the past decade, thousands of Christians and Muslims have been converted to Hinduism

during these ceremonies.

The UNHRC stated that India should guarantee, in law and practice, the effective exercise of freedom of religion and belief and refrain from imposing any restrictions on those rights beyond the narrow limitations permitted under Article 18(3) of the ICCPR. The UNHRC was concerned

about the arbitrary restrictions in law and practice to freedom of expression online and offline in India, including the broad and frequent use of internet shutdowns, such as the complete ban on mobile internet facilities for months in Jammu and Kashmir in 2016 and for 18 months in 2019, the blockage of online content on vaguely defined grounds and without court authorisation, and the banning of books and films.

While the UNHRC commended the abolition of the offence of sedition in the former penal code, it remains concerned that Section 152 of the new penal code, Bharatiya Nyaya Sanhita, 2023 criminalises forms of expression that endanger the sovereignty, unity and integrity of the State The UNHRC was also con-

cerned about the misuse of vague and broadly formulated provisions of legislation, such as on counterterrorism, which according to information received is misused for the arbitrary arrest and prosecution of minority groups, journalists and other individuals expressing minority or dissenting views and exercising their right to peaceful assembly.

The UNHRC stated that India should take all measures necessary to guarantee the full enjoyment of freedom of expression by everyone; in accordance with Article 19 of the ICCPR and the UNHRC's General Comment 34 (2011), and that any restrictions comply with the strict requirements of Article 19 (3) of the

The UNHRC was concerned about the killing of 59 journalists since 2006, as well as allegations that human rights defenders have been barred from travelling outside India and engaging with United Nations bodies, such as in the case of Khurram Parvez, a Kashmiri human rights defender who was prevented from travelling to Geneva to attend the Human Rights Council and has been arbitrarily detained since

The UNHRC was concerned about information regarding the transnational repression of political opponents and human rights defenders.

The UNHRC was also concerned about the frequent disruption of demonstrations and cases of excessive use of force, such as in the protests in Tamil Nadu in 2018 that resulted in 13 deaths; and the use of pellet-firing shotguns for crowd control purposes resulting in numerous persons injured, in particular in Kashmir

The UNHRC was concerned about the possibility of the arbitrary application of certain provisions of the new criminal legislation, such as those on public order related to peaceful assemblies.

The UNHRC was also concerned about other violent incidents, such as the demolitions of places of worship and homes of religious minorities.

The UNHRC wants India to take measures to guarantee that everyone can exercise the right to freedom of expression, as well as the right of peaceful assembly in accordance with Article 21 of the covenant and the committee's General Comment 37 (2020) on the right of peaceful assembly. (IPA Service)

The UGC NET conundrum

Let there be finality, we are not in a perfect world. Let the exams happen on August 21. Let there be certainty for students," Chief Justice of India DY Chandrachud said on August 12 while dismissing a plea against the re-conduction of the UGC-National Eligibility Test (June, 2024). I agree with him that we are not in a perfect world, but can it not be a little more sensible and sincere? The National Testing Agency (NTA), entrusted with conducting such high-intensity national-level exams every year, should have more accountability than they have shown in the recent past.

June 2023, you sit for NET in Mass Communication & Journalism subject. Fifteen minutes into the paper, you scratch your eyes thinking if you read it wrong. No, you did not. You are baffled to find out grammatical errors and obscure sentence structures throughout the paper. That was my experience. I had to turn the language to Hindi to comprehend some questions;



such was the level of insincerity in typing a paper for a computer-based test by supposedly the 'highest' authority in conducting nationwide examinations, not to mention a 'Kasauti Zindagi Ki' surprise feature in Paper Two.

Cut to 2024 June edition. they decide to bring back the offline paper mode, and there were no such blunders in setting the papers as such. But lo. before the students can even sit down to analyse their answers at home, news breaks out of possible 'integritybreach' and the exam gets cancelled in its entirety, in an

All considerations for students' invested time and resources, its implications in their next course of academics, the logistical hassle to reach venues, etc. go for a toss. Discontentment erupts, some join the ongoing chorus for the NEET fiasco, case reaches the CBI, and their initial finding discards a potential paper leak (although the investigation is not over yet and findings are yet to be disclosed in full). The verdict is in favour of a re-examination, which brings back the CBT (computer-based test) mode.



phere pervades Ukraine's 33rd Independence Day on Saturday, as the nation's war against Russia's aggression reaches a 30-month milestone. No fireworks, parades or concerts are planned and instead Ukrainians will mark the day with commemorations for civilians and

soldiers killed in the war. Ukrainians have flooded social media with messages of gratitude and support, greeting each other and thanking the soldiers on the front lines. In the outpouring of unity, there's a shared acknowledgment that the two-and-a-half years have been tough, with fatigue in-

"Independence is the silence we experience when we lose our people," President Volodymyr Zelenskyy said to the nation. "Independence descends into the shelter during an air raid, only to endure and rise again and again to tell the enemy: You will achieve

nothing. Zelenskyy pointed out that the war started by Russia has now spread to its own territory. "Those who seek to sow evil on our land will reap its fruits on their own soil," he said, referring to Ukraine's incursion earlier this month into Russia's Kursk region



The president symbolically chose to record his address in the northeastern town of Sumy, just a few kilometers from the Russian

border, where Ukrainian forces crossed into Russia on August 6. "913 days ago, Russia launched its war against us, partly through

Sumy region," Zelenskyy said. "They violated not only sovereign borders but also the boundaries of cruelty and common sense, driven by an insatiable desire to destroy

Ukraine's surprise incursion into Russia's Kursk region, gave the war a startling turn, adding a new front to the conflict to counter Russia's grinding advances in eastern Ukraine's Donetsk region. Ukraine quickly seized considerable Russian territory, including scores of small towns, and captured hundreds of Russian soldiers, moves that may influence the war's trajec-

"And those who sought to turn our lands into a buffer zone should now worry that their own country doesn't become a buffer federa-

Dozens killed in strikes in southern Gaza as preparations for cease-fire talks move forward

dozen Palestinians were killed in multiple Israeli strikes in the southern Gaza Strip, officials said on Saturday, even as preparations moved ahead for high-level ceasefire talks in the Egyptian capital.

Among the dead were 11 members of the same family, including two children, when an Israeli airstrike hit their home in the city of Khan Younis early on Saturday, according to Nasser Hospital where the bodies and wounded were taken.

The hospital received a total of 33 dead who were killed in three separate strikes in and around Khan Younis. The city's Al-Aqsa Martyrs Hospital said it had received another three bodies from an early on Saturday strike.

Seventeen others were killed when a strike hit a road south of Khan Younis, including the passengers on a tuk-tuk and passersby, Nasser Hospital said.

Another strike hit a tuk-tuk east of Khan Younis, killing at least five people. The Israeli military said it was looking into the reports but had no immediate comment.

First responders also recovered 10 bodies from a residential block

and two farther south in Rafah. The circumstances of their deaths were not immediately clear, the hospital said, but the areas were repeatedly bombed by the Israeli

military over the past week. An Associated Press journalist at the hospital counted the bodies and filmed the funeral service in the hospital's courtyard.

The war in Gaza broke out Oct. 7 when Hamas and other militants staged a surprise attack on Israel. killing some 1,200 people, primarily civilians.

More than 100 hostages were released during a cease-fire last year, but Hamas is still believed to be holding around 110 more, about a third of whom are dead, according to estimates from Israeli authorities.

Israel's retaliatory offensive has killed more than 40,000 Palestinians, according to Gaza's Health Ministry, which does not distinguish between civilians and combatants in its count.

It has also caused widespread destruction and forced the vast majority of Gaza's 2.3 million residents to flee their homes.

Experts were meeting Saturday to work through technical issues



and pave the way for the highlevel talks Sunday on a possible cease-fire mediated by the United States, Egypt and Qatar.

A Hamas delegation arrived Saturday in Cairo to meet with Egyptian and Qatari officials, senior Hamas official Mahmoud Merdawy told the AP. He stressed that Hamas will not take part directly in the Sunday talks, but instead will be briefed by Egypt and

Moscow and Kyiv exchange attacks as Ukraine marks independence anniversary

KYIV, Aug 24: Russia and Ukraine exchanged drone, missile and artillery attacks on Saturday as Kyiv marked its third Independence Day since Moscow's full-scale in-

Two people were killed and four were wounded, including a baby, when Russian forces shelled the southern Ukrainian city of Kherson

the capital of the partially occupied Kherson region, according to local officials. Ukraine's air force said it had intercepted and destroyed seven drones over the country's south. Russian long-range bombers also attacked the area of Zmiinyi (Snake) Island with four cruise missiles, while the wider Kherson region was also struck by aerial bombs.

In Russia, the Defense Ministry said Saturday that air defenses had shot down seven drones overnight.

Five drones were downed over the southwestern Voronezh region bordering Ukraine, wounding two people, regional Gov. Aleksandr Gusev said. News outlet Astra published videos appearing to show explosions at an ammunition depot after being hit by a drone. The videos could not be independently verified.

Two people were wounded in a drone attack in the Belgorod region, also bordering Ukraine, regional Gov. Vyacheslav Gladkov said. Local authorities did not report any casualties in the Bryansk region, where the fifth drone was intercepted. In the Kursk region, where Ukrainian forces launched their surprise offensive into Russia two weeks ago, regional Gov. Alexei Smirnov said Saturday that three missiles were shot down overnight and another four on Saturday morning.

Russian air defenses shot down two more drones on Saturday morning, Russia's Defense Ministry said — one over the Kursk region and one over the Bryansk region. Ukraine marked its 33rd Independence Day Saturday as its war against Russia's aggression reaches a 30-month milestone. No festivities are planned and instead Ukrainians will mark the day with commemorations for civilians and soldiers killed in the war.

Poland's President Andrzej Duda arrived by train early Saturday to Kyiv in a symbolic show of support from one of Ukraine's key allies.

Videos posted by his office show him being greeted by Ukrainian officials and later paying his respects in a ceremony at the Wall of Remembrance of the Fallen for Ukraine.

Duda's visit to Kyiv, his fifth since February 2022, sends a message that Warsaw's support for Ukraine remains strong as the war drags on for the third year. Poland, located to Ukraine's west, has donated arms and become a hub for Western weapons destined for Ukraine. It has also welcomed tens of thousands of Ukrainians who fled the war. It hosts the most Ukrainian refugees outside of the country after Germany. (AP)

Philippines says flares fired from a Chinese island base threatened its fisheries plane

MANILA, Aug 24: A Philippine fisheries bureau plane was threatened by flares fired from a Chinese island base while conducting a routine patrol in the South China Sea, Philippine officials said Saturday, the latest territorial spat between Beijing and Manila over one of the world's busiest trade routes, with confrontations spreading from the disputed waters to the airspace above.

China has been at odds with several other countries in the Asia-Pacific for years over its sweeping maritime claims, including almost all of the South China Sea.

The Bureau of Fisheries and Aquatic Resources' Cessna 208B Grand Caravan plane was flying near Subi Reef on Thursday when it spotted flares being fired from the fishing atoll, which China has transformed into a militarised island base, a Philippine government interagency task force said in a state-

Turkey and Russia resume joint patrols in northern Syria as Ankara seeks to mend ties with Assad ISTANBUL, Aug 24: Turkey and

Russia have resumed joint military patrols in northern Syria after nearly a year's break, the Turkish Defence Ministry announced Saturday.

Combined patrols began in the Operation Peace Spring area, the statement said, referring to a 30-km (19-mile)-deep strip of land on the Syrian side of the Turkey-Syria border between Tal Abyad and Ras al-Ayn. The territory was captured from Kurdish fighters by Turkish and allied Syrian forces in 2019.

The renewed Turkish-Russian patrols come as Ankara is trying to repair its relations with Syrian President Bashar Assad, whose regime draws support from Moscow.

Assad has said he will only meet Turkish President Recep Tayyip Erdogan to discuss the withdrawal of Turkish troops from Syria and an end to Ankara's support for Syrian fighters that Damascus considers terrorists.

Turkish and Russian soldiers first began joint operations in the area in November 2019, conduct-

ing 344 patrols until October last year, when they were suspended, the ministry said.

Some 24 Turkish personnel in four vehicles took part in the first resumed patrol on Thursday at the eastern end of the Operation Peace Spring area. "It is planned to continue the United Land Patrol...to ensure the security of our country's borders and the civilian population in the region (and) to establish stability in northern Syria," the ministry said in its statement.

The operation would also identify "checkpoints, headquarters and military structures" of Kurdish fighters known as the YPG.

Turkey considers the YPG a terrorist organization due to its links to the PKK, which has fought a 40vear insurgency against Ankara. leading to tens of thousands of deaths.

The United States, however, partnered with the YPG in 2014 to fight the Islamic State group in Syria and continues to support the Kurdish fighters under the umbrella of the Syrian Democratic

Fasting and puja can coexist in Bangladesh, says interim govt advisor

DHAKA, Aug 24: The Religious Affairs Adviser of the ingovernment Bangladesh has asserted that there is no problem in observing fasting and puja at the same time in the country as he called for building a harmonious state where all faiths coexist peace-

Bangladesh saw several incidents of violence against members of Hindu, Buddhist and Christian communities following the fall of the Sheikh Hasina-led government earlier this month. The Bangladesh National Hindu Grand Alliance said the minority community faced attacks and threats in 278 locations across 48 districts since the fall of the Hasina-led government. Several Hindu temples, homes and businesses of the minority community in Bangladesh were destroyed this month amidst the student-led unrest against quotas in government jobs.

Thousands of Bangladeshi Hindus have been trying to flee to neighbouring India to escape Speaking to Muslim devotees

before Friday's Jumma prayers at Hazrat Usman Jame Masjid in the Halishahar area of Chattogram district, Religious Affairs Adviser Dr A F M Khalid Hossain called for building a country of religious harmony where people of all faiths would live peacefully, the state-

run BSS news agency reported. "I want to give the nation a harmonious state. Bangladesh is a country of communal harmony. 

Will extend complete support to Congress-NC alliance if it accepts PDP agenda: Mehbooba

'Resolution of the Kashmir problem is much more important than anything else'

SRINAGAR, Aug 24: The PDP will extend complete support to the Congress-NC alliance and leave all seats in the Jammu and Kashmir assembly elections to the coalition if it is ready to accept the party's agenda, PDP chief Mehbooba Mufti said on Saturday.

Mehbooba also ruled out an alliance with the BJP, with which the People's Democratic Party (PDP) had earlier run a coalition government.

"Forget about alliance and seatsharing, if the Congress and the National Conference (NC) are ready to accept our agenda -- that resolution of the Kashmir issue is necessary and on opening of routes -- we will tell them to contest on all the seats and we will follow you," she said.

"Because, for me, the resolution of the Kashmir problem is much more important than anything else," she added when asked if the Congress had approached the PDP for an alliance.

Mehbooba was talking to reporters following the release of the PDP's manifesto for the as-



sembly elections.

NC chief Farooq Abdullah has announced a pre-poll alliance with the Congress for the assembly elections in Jammu and Kashmir, which is going to the polls for the first time since the abrogation of Article 370 in August 2019. Polls to the 90-member assemblv will be held in three phases --September 18, September 25 and October 1. The counting of votes will be held on October 4.

Mehbooba, the PDP president, said the dignity of the people of Jammu and Kashmir, which "was being trampled on", was important

"Whether you give me three or four seats, it does not mean anything to me. When we entered into an alliance with either the Congress or the BJP, it was on our agenda. The NC and the Congress have not entered into an alliance on any agenda but for seat-sharing and we will not talk of such an alliance, which only talks about

seat-sharing," she said. "Our alliance should be based on an agenda and our agenda is to find the resolution to the Jammu and Kashmir issue... No doubt within the Constitution of this country but a resolution," she

Asked if there could be a postpoll alliance between the PDP and the BJP, Mehbooba said, "There is nothing like that. We had joined hands with the BJP government and not the party and we had put a condition that they would not touch Article 370."

The PDP in its manifesto promised to pursue the restoration of Jammu and Kashmir's statehood and advocate for diplomatic initia-

It also aims to establish full connectivity across the Line of Control for trade and social exchange.

The manifesto also talks about striving for the revocation of the Public Safety Act (PSA) and the Unlawful Activities (Prevention) Act (UAPA) as well as its commitment to revocation of the Armed Forces Special Powers Act (AFSPA).

Assembly elections in Jammu and Kashmir were last held in November 2014, resulting in the PDP and the BJP forming a coalition government led by Mufti Mohammed Sayeed. His death in 2016 led to his

daughter Mehbooba taking up the mantle of leadership as chief minister of the coalition government. The BJP pulled out of the gov-

ernment in June 2018 and the state was put under governor's rule. On August 5, 2019, the BJP-led

Centre abrogated the special status of Jammu and Kashmir and reorganised the erstwhile state into two Union territories -- Ladakh, tives between India and Pakistan. and Jammu and Kashmir. (PTI)

Cong leadership briefed on political developments in Karnataka, says Siddaramaiah

Chief Minister Siddaramaiah on Saturday said the Congress high command had been explained about the recent political developments in the state, and the prosecution sanction against him by the Governor, which he termed as "anti-Constitution and illegal'

He also said the Governor sending some Bills back to the government will be discussed in the Cabinet and the next course of action will be decided at the meeting.

Siddaramaiah and Deputy Chief Minister D K Shiyakumar, who is also state Congress chief, and several senior ministers met AICC president Mallikarjun Kharge, Leader of Opposition in Lok Sabha Rahul Gandhi in New Delhi on Friday, and held discussions.

"We went to Delhi yesterday on our own.... D K Shivakumar and I have explained (to Congress high command) regarding political developments in the state, especially on the opposition's padayatre (Bengaluru to Mysuru foot march) on the MUDA issue, how we faced it politically," Siddaramaiah said.

Speaking to reporters here, he said, "We have informed them (high command) about the government's clear stand that the Governor's prosecution sanction (against me) is anti-Constitution and illegal, and to challenge it

BENGALURU, Aug 24: Karnataka both the Cabinet and the legislature party have condemned it (Governor's sanction), and explained to them that the Governor's decision has been challenged in the High Court."

Asked whether any discussion happened regarding complaining to the President against the Governor, Siddaramaiah said, "no....all options are open." Governor Thaawarchand Gehlot on August 16 granted sanction for prosecution of Siddaramaiah in connection with the Mysuru Urban Development Authority (MUDA) site allotment 'scam', giving a major jolt to the nearly 15-month-old Congress government

The Governor accorded sanction under Section 17A of the Prevention of Corruption Act, 1988 and Section 218 of the Bharatiya Nagarik Suraksha Sanhita, 2023 for the commission of the alleged offences as mentioned in the petitions of activists Pradeep Kumar S P, T J Abraham and Snehamayi Krishna.

The High Court on August 19 had directed the special court for people's representatives to defer its proceedings against the CM in the alleged MUDA site allotment 'scam', till the next date of hearing on August 29.

To a question about the Governor sending back some Bills to the government, Siddaramaiah said, "he (Governor) has sent back six Bills. We will discuss in the Cabinet and decide the

Pity govt standing with culprits involved in crimes against women: Uddhav



MUMBAI, Aug 24: Shiv Sena (UBT) chief Uddhav Thackeray on Saturday said it is a pity that instead of taking action against culprits involved in crimes against women, the Maharashtra government, which he termed "shameless", was standing with them.

Addressing party workers during a demonstration over crimes against women, and the alleged sexual assault on two kindergarten girls at Badlapur, Thackeray said it is imperative to dislodge the Mahayuti government to ensure the safety of women in the state.

"It is a pity that instead of taking action against the culprits it is standing with them," Thackeray alleged. He said Maharashtra has never seen a government as "shameless" as the incumbent dispensation.

Mahayuti is a coalition of BJP, Shiv Sena led by Chief Minister Eknath Shinde and NCP headed by Ajit Pawar.

In a veiled attack on CM Shinde, Thackeray said the 'Kansa Mama', a reference to a character in Mahabharat, is busy getting rakhis tied on his wrists and asked when he will get justice for the nieces.

Thackeray, his wife Rashmi and their son and former Maharashtra minister Aaditya staged a demonstration at Shiv Sena Bhavan in the Dadar area along with party workers by wearing black ribbons and black bands on the mouth to protest against the Badlapur in-

The party also staged protests in several parts of the state.

He accused the state government of forgetting that the responsibility for the safety of women lies with it. Pawar, who took part in a silent protest in Pune, said the government is insensitive if it thinks the opposition is playing politics over the Badlapur incident.

"The Badlapur incident has hit the image of Maharashtra in the country," said the chief of NCP (SP), which is a constituent of the opposition bloc Maha Vikas Aghadi (MVA), also comprising Congress and Uddhav Thackeray-led Shiv Sena (UBT). Pawar said such an incident has taken place in the land of Chhatrapati Shivaji who used to chop off the hands of culprits involved in crimes against women.

The alleged sexual assault on two 4-year-old girls by a male attendant at a school in Badlapur of Thane district had led to a massive protest in the town on Tuesday, with thousands of people blocking roads and railway tracks and clashing with the police.

The MVA had called for a 'Maharashtra Bandh' on August 24 to protest against the crime against the young girls. However, the Bombay High Court on Friday restrained political parties or individuals from proceeding with the bandh on August 24 or any future date over the

'Bulldozer justice' completely unacceptable, must stop: Congress





NEW DELHI, Aug 24: The Congress on Saturday said "repeated targeting" of minorities in BJP-ruled states is deeply troubling and asserted that 'bulldozer justice' is completely unacceptable and must stop.

The opposition party's assertion comes after the house of a man who allegedly indulged in violence in Madhya Pradesh's Chhatarpur district during a protest was demolished.

"The house of Shahzad Ali under Kotwali police station limits was demolished. We had registered a case against 150 people for the violence on Wednesday. We had named 46 people," an official had said.

Congress president Mallikarjun Kharge said demolishing someone's home and rendering their family homeless is both inhumane and un-

"The repeated targeting of minorities in BJP-ruled states is deeply troubling. Such actions have no place in a society governed by the Rule of Law," he said in a post on X.

The Congress strongly condemns the BJP state governments for their blatant disregard of the Constitution, using bulldozing as a tactic to instil fear among citizens, Kharge said.

"Anarchy cannot replace natural justice - offences must be adjudicated in courts, not through statesponsored coercion," he said.

In a post in Hindi on X, Congress general secretary Priyanka Gandhi Vadra said, "If someone is accused of a crime, then only the court can

"But punishing the family of the accused as soon as the allegation is made, taking away the roof from their heads, not following the law, disobeving the court, and demolishing the house of the accused as soon as the allegation is made - this is not justice," she said.

This is the height of barbarism and injustice. There should be a difference between the lawmakers, the law keepers and the lawbreakers, she stressed, adding that governments cannot behave like criminals. Following the law, Constitution,

democracy and humanity are the minimum conditions of governance in a civilised society, Priyanka Gandhi said.

"One who cannot fulfil 'rajdharma' can neither work for the welfare of the society nor the country. Bulldozer justice is completely unacceptable, it must stop," she said.

India needs 400 million more women in workforce to contribute USD 14 trillion to economy: Report

NEW DELHI, Aug 24: India requires an additional 400 million women in the workforce to contribute USD 14 trillion to the economy which would necessitate nearly doubling the current female labour force participation rate (LFPR) from 37 per cent to 70 per cent by fiscal year 2047, according to a new report.

Non-profit The/Nudge Institute has unveiled a new report, Labour Force Participation Distillation Report, outlining a crucial element for India's economic future. The report is based upon Periodic Labour Force Survey (PLFS) over

As the country aims to become a USD 30 trillion economy by 2047, the report highlights the need for a substantial increase in female labour force participation

to achieve this goal. According to the report, India requires an additional 400 million women in the workforce to contribute USD 14 trillion to the economy. This would necessitate nearly doubling the current female labour force participation rate (LFPR) from 37 per cent to 70 per cent by



fiscal year 2047. With only 110 million women

projected to join the labour force by then, an additional 145 million women need to be integrated to meet this target.

The report reveals a stark disparity in job security and recovery between men and women Women were found to be seven

times more likely to lose their jobs

and eleven times more likely not to

recover from job loss. By 2020, nearly half of the women employed in 2019 had exited the workforce, the report said.

Women predominantly work in low-productivity sectors, such as agriculture and manufacturing, where they face limited advance-

According to the report, in construction, women represent just over 12 per cent of the workforce, often earning significantly less than men in unskilled roles. The pandemic has exacerbated these issues, with many rural women forced back into work due to income loss or job loss by primary earners, underscoring the fragility of female employment. To address these challenges, the

report outlines three key pathways to increase female labour force First, redefining work through

platform jobs and digital microwork could activate fractural employment. Second, enhancing entrepreneurship opportunities via digital

commerce infrastructure could in-

vigorate the sector. Third, addressing bottlenecks, such as mobility and digital access, is crucial to improving women's participation in the labour market. Kanishka Chatterjee, Director & Head of The/Nudge Prize, emphasised the urgency of this challenge.

"India's demographic dividend and dreams of a \$30 trillion economy cannot be realised without boosting the participation of women in the workforce," Chatter-

jee said. He acknowledged the strides made but stressed the need for urgent and sustained action to overcome economic, social, and cultural barriers. To build this report, The/Nudge

Prize team looked at all of the PLFS data across the last two cycles of different sectors that are contributing to it or that are seeing higher growth rate, the report said. 'When we looked at PLFS data,

we understood what the supply side is or where women or men work today. But there are no other data pointers available where we can clearly see what are the demand markers available in India which will hire women, or which may be better suited for women to take jobs or to drive their entrepreneurial journeys," it said.

"One of the key things to consider, if we need to solve or address labour force participation rate, is two have a holistic approach. Not only to see how labour is available and what skills are available, but also to see what is driving demand today -- and this is exactly what we also bring out in the report," the report added. (PTI)

Wayanad landslides an instance of nature reacting to human apathy, greed: Kerala HC

KOCHI, Aug 24: The landslides that hit Wayanad district in Kerala claiming over 200 lives was just another instance of nature reacting to human "apathy and greed", the High Court here has said.

The court said that the "warning signs" had appeared a long time ago but "we chose to ignore them in pursuit of a development agenda that would supposedly put our state on the high road to economic prosperity".

It said that the natural disasters in 2018 and 2019, the pandemic that persisted for nearly two years and the recent landslides "have shown us the error of our ways".

"If we do not mend our ways and take affirmative remedial action now, perhaps it will be too late," a bench of justices A K Jayasankaran Nambiar and Syam Kumar V M said while hearing a plea initiated on its own by the court following the July 30 landslides that completely wiped away three villages in Wayanad with 119 people still unaccounted for.

The court suo motu initiated the PIL "to persuade the state government to introspect on its currently held notions for sustainable development in the state of Kerala and revisit its policy regarding the same", the bench said in its order of August 23.

The bench said the court will take stock of the state's existing policies in relation to ex-



ploitation of natural resources, preservation of the environment, forests and wildlife, prevention, management and mitigation of natural disasters and sustainable development

"It was felt that an intervention by this court was required to gather information, and requisition assistance from institutions and agencies that can assist in the identification of ecologically sensitive areas in the state, and help the state in reformulating its

policies in the areas mentioned above," it

The bench also outlined the stages by which it was going to achieve the goals for which the PIL was initiated.

It said it will proceed in three stages, with the first one being focused on gathering scientific data regarding the manner in which ecologically sensitive areas in the state can be identified, and thereafter proceed to identify and notify them district wise.

'We will also monitor the rescue rehabilitation and reconstruction efforts in Wayanad district on a weekly basis," it said.

In stage two, data will be gathered with regard to the desirable composition of regulatory agencies and advisory boards that would enable such agencies and boards to function effectively towards achieving the objectives for which they have been consti-

"The data gathered will be placed before the state government for its consideration so that suitable amendments can be effected to existing statutes, rules or regulations.

"In stage three, we propose to collect data from the people residing in ecologically sensitive areas in the state, through the Local Self Government department of the state, so that the state can re-formulate its policies with regard to infrastructural development, tourism, exploitation of natural resources, and preservation of environment, forests and

As a part of that, the state shall conduct the necessary environmental impact assessment studies and hold adequate public hearings to ascertain the views of persons or

residents of the locality concerned, it added. The bench has also directed the Centre and Kerala government to file affidavits clarifving whether in the wake of the natural disasters that have occurred in the state, they propose to increase the number of subject experts as mandated under the Disaster Management Act (DMA) 2005.

It also asked them to clarify whether the Advisory Committees as contemplated under the DMA have been constituted at the national, state and district levels and if so, the composition of the said panels as well as the details of the Disaster Management Plans prepared at the national, state and district levels in accordance with the DMA, together with details of the latest updates to the said

In addition to these, the Centre and Kerala government also have to state in affidavit the details of the funds allocated for carrying out the activities and programmes set out in the respective Disaster Management Plans and details regarding the steps taken by the Central government to include a checklist of safety measures to be adopted in landslide prone areas in the Building Rules applicable in the state.

The court has given them three weeks to file their affidavits containing these details.

"We make it clear that in view of the expediency required in this matter, we expect all the respondents to strictly adhere to the time limits specified by this court for filing affidavits and other documents," it said. (PTI)

Two arrested for raping teenage girl

PALGHAR, Aug 24: Police in Maharashtra's Palghar district have arrested two persons for allegedly raping a 17-year-old girl after taking her on an outing, an official said on Saturday.

An official from the Tulinj police station said that the complainant, a resident of Mumbai. often visited Nallasopara to meet a friend. During her visits, she got acquainted with one of the accused, identified as Sonu, who worked in a studio in the locality.

On Thursday, Sonu and his friend invited the teenager for an outing. They took the girl in an auto to an isolated place where both raped her, the official said citing the FIR

After learning about the sexual assault from their daughter, the girl's parents filed a police complaint.

The Tulini police on Friday registered a case under the Bharativa Nyaya Sanhita (BNS) and Protection of Children from Sexual Offence (POCSO) Act and arrested the two accused, said senior inspector Shailendra Nagarkar. (PTI)

Man held for selling fake question paper of UP Police constable recruitment exam

LUCKNOW, Aug 24: A man was arrested for allegedly duping people on the pretext of providing a leaked question paper of the Uttar Pradesh Police constable recruitment exam, a press statement from the Special Task Force (STF) said on Saturday.

The accused was identified as Aniruddha Modanlal, they said.

According to the press statement, Modanlal was operating a social media platform where he would charge candidates money on the pretext of providing them with a leaked question paper of the ongoing police recruitment exam.

According to the Uttar Pradesh Police Recruitment and Promotion Board, the exam will be held in two shifts on five days, i.e., August 23, 24, 25, 30 and 31. The fresh recruitment exercise to fill over 60,000 posts is being carried out after the exams, held on February 17 and 18, were cancelled following allegations of a paper leak.

The officials said, Modanlal was in touch with Abhay Kumar Srivastav who is the mastermind of the racket. In Srivastav's direction, he made a channel on telegraph and took ₹ 1 lakh from candidates to provide them with leaked question papers for the recruitment

Modanlal withdrew the money deposited in his account by the candidates and shared a fake question paper. The STF officials, already on alert in the wake of the ongoing recruitment exam, arrested him. Efforts are on to arrest the mastermind, they said.

Meanwhile, lakhs of candidates appeared for the UP police constable recruitment exam on Saturday at 1,174 centres across 67 districts in the state amid tight security arrangements, marking the second day of a five-day exercise.

Director General of Police (DGP) Prashant Kumar inspected the arrangements at exam centres in Lucknow University and National PG College on Saturday.

The college has come into media glare following the alleged rape and murder of a trainee doctor on the campus on August 9, they said. The high court had directed the

CBI to submit a progress report on the investigation within three weeks. The court has scheduled a follow-up hearing for September 17 to review the report. (PTI)

Kolkata doctor's rape-murder: Polygraph test on accused begins



NEW DELHI/KOLKATA, Aug **24:** The lie detection tests on the main accused and six others in the alleged rape and murder of a trainee doctor at Kolkata's RG Kar Medical College and Hospital began on Saturday, officials said.

The polygraph test on Sanjay Roy, the main accused, is being conducted in the prison where he is lodged, while the remaining six, including former principal Sandip Ghosh and four doctors who were on duty during the night of the incident and a civic volunteer, are undergoing the test at the agency's office in Kolkata, they said.

Ghosh arrived at the CBI's office at CGO Complex in Salt Lake on Saturday morning for the ninth day consecutive day, and was then taken for the test, the officials

CHENNAI, Aug 24: Tamil Nadubased startup Space Zone India on Saturday launched its first reusable hybrid rocket, Mission RHUMI-2024, onboard a mobile platform to take up research on global warming and climate change.

Cheetahs set to roam free again in Kuno after year-long enclosure stay

NEW DELHI, Aug 24: African cheetahs brought to India as part of the world's first intercontinental translocation of big cats will soon roam free again in the wild, nearly a year after they were returned to enclosures in Madhya Pradesh's Kuno National Park for health check-ups and monitoring, according to officials.

Officials told PTI that the Centre's Cheetah Project Steering Committee decided on Friday to release the African cheetahs and their cubs, born in India, into the wild in a phased manner after the monsoon withdraws from central parts of the country

According to the India Meteorological Department (IMD), the monsoon normally withdraws from most areas in Madhya Pradesh by the first week of Octo-

"Members of the committee and NTCA (National Tiger Conservation Authority) officials conducted field visits to Kuno and discussed

the schedule for releasing the cheetahs. While adult cheetahs will be released into the wild in phases once the rains end, the cubs and their mothers will be released after December," an official said. All 25 cheetahs -- 13 adults and

12 cubs -- are doing well. The animals have been administered vaccines to safeguard them against diseases and given prophylactic medicine to prevent infection, according to the official. The first batch of eight cheetahs from Namibia was introduced in

India in September 2022, and the

second batch of 12 cheetahs was flown in from South Africa last The cheetahs were initially released into the wild but were brought back to their enclosures by August last year after the death of three -- a female named Tbilisi

occurs when bacteria enter the bloodstream and spread.

This condition arose from wounds under the cheetahs' thick winter coats on their backs and necks, which became infested with maggots and led to blood infec-

tions, according to the government's annual report on Project Cheetah

Officials had earlier told PTI that the unexpected growth of winter coats by some cheetahs during the Indian summer and monsoon,

in anticipation of the African winter (June to September), was a major challenge in managing the animals in India during the first

"Even African experts did not expect this. The winter coat, combined with high humidity and heat, caused itching, leading the cheetahs to scratch their necks on tree trunks or the ground. This resulted in bruises and exposed skin, which attracted flies that laid eggs, leading to maggot infestations, bacterial infections and ultimately, the deaths of three cheetahs," said S P Yaday, Director General of the International Big Cat Alliance and

former NTCA member secretary. The deaths prompted the steering committee to recommend that future cheetahs for reintroduction should be sourced from countries in the Northern Hemisphere, such as Kenya or Somalia, to avoid bio-

rhythmic complications". The steering committee had prepared a plan in December last year to release the cheetahs into the wild, but it was not implemented. Currently, only one cheetah, named Pavan, is roaming free, with officials noting that he is difficult to spot and capture.

Though such "experimental" projects come with challenges and expected mortalities, experts in both India and Africa have expressed concerns about keeping the cheetahs in enclosures for extended periods.

"The cheetahs are not truly living in the wild, despite spending two years on Indian soil. Cheetahs prefer long journeys, and they could be under severe stress," an African expert who assisted with the cheetah reintroduction in India said on condition of anonymity.

"Based on global experience and Namibian laws and policies, my understanding is that it is not a good idea to release these cheetahs because of their extremely long period of captivity, especially the captive-born cubs," said Ravi Foundation and Coordinator, Biodiversity Collaborative. Another African expert said the

cheetahs are fit enough for the wild if they have been hunting for themselves in enclosures and have not been provided with supplementary feeding. "They may have also received

antiparasitic medications, which could help them during the monsoon, but this might reduce their ability to develop natural immunity to these parasites once they are released," the expert said.

Since their arrival in India, seven adult cheetahs -- three females and four males -- have died, including four due to septicemia. All these deaths occurred between March 2023 and January 2024.

Seventeen cubs have been born in India and 12 of them survived. This brings the total number of cheetahs, including cubs, in Kuno to 25, all but one of which are currently in enclosures. (PTI)

Bengali female actor levels 'misbehaviour' charge against eminent Malayalam filmmaker Ranjith

KOLKATA, Aug 24: A Bengali actor has levelled accusation of misbehaviour against eminent Malayalam film director and chairman of the state-run Kerala Chalachitra Academy, Ranjith, spelling fresh trouble for the Pinarayi Vijayan government which is facing opposition heat on its alleged inaction over the Justice Hema Committee report.

The report had revealed instances of harassment and exploitation of women in the Malayalam cinema industry, prompting calls for action against the guilty.

The filmmaker has reportedly rejected Mitra's charge and said he was the "real victim" in the case.

Key LDF constituent CPI was among those seeking a probe into the allegation of Bengali actor Sreelekha Mitra, who has recalled a yearsold incident in the backdrop of the ripples being created by the Justice Hema Committee findings. "The person concerned is a big name in Malayalam film industry and a national award winning director. I went to his residence to discuss an upcoming film project and I did not like his behaviour. He made certain advances subtly and I felt uncomfortable while we were discussing the script," Mitra told PTI in Kolkata.

He did this without her consent and she her made her disapproval very clear.

"I immediately communicated my decision not to be part of the project any more, left the place and came back to Kolkata the next day," she added. "I don't know if he has treated other female actors in the film industry in the same way. It is upto them to open up or not if they had faced similar situation. May be his power and influence played a role for others to not to

speak out," she added.

Mitra said she did not have any such experience in the Bengali cinema industry, but that there could be similar situations for other female actors as well with regard to someone. Such women should muster the courage and speak out without any fear.

"The incident in Kerala was years back...but it is heartening that women are speaking out with greater vigour and conviction against any form of misconduct now, taking out rallies, and I am looking forward to the day when number of any instance of gender abuse, misconduct will go down and women will not have such harrowing tales any more," Mitra added.

In Kerala, many demanded Ranjith stepped down as the Chairman of the film academy. Several people including well-known filmmaker Dr Biju came out against Ranjith.

While opposition Congress said it expects Ranjith would step down as film academy chairman, BJP said he has no moral right to continue. CPI national leader Annie Raja urged the government to carry out a probe based on Mitra's allegations and wanted to keep Ranjith away from the position during investigation.


Kerala Cultural Affairs Minister Saji Cheriyan assured the government would not protect anyone who had committed a wrong. If the allegations against Ranjith were

No case can be registered based on just allega-

tions and such cases wont stand, Cheriyan added. He underlined the government's support for women who face harassment at their workplaces and said stringent action would be taken against wrongdoers. Health Minister Veena George said all facilities and support would be provided to the actress to lodge a complaint against the director.

"If she wishes to go ahead with the complaint, the government will provide all facilities for the same. The government's stand is clear in this. The CM has already made it clear that the government won't protect wrongdoers," she said.

Higher Education Minister R Bindhu said action would be taken after understanding the facts in the issue and said she expects the government would do it, as a woman has come up with such a complaint.

Sharing similar views, Women's Commission chairperson P Sathidevi said she came to know about the allegations about the actress through the media and if it is proved correct, Ranjith should step

down as academy chairman. Opposition leader V D Satheesan also said Ranjith is an acclaimed director who has contributed

several good movies in the Malayalam film industry. "As a friend and as a brother, I request him to step down as film academy chairman. I think he will step back from his current responsibility," the Congress leader told reporters

BJP state chief K Surendran attacked Cheriyan and Ranjith and said both of them should quit.

"Ranjith has no moral right to continue in the position. A victim herself has come up with the complaint. She raised the allegation openly...before the public society," he told a press conference in Thiruvananthapuram. (PTI)

NEW YORK, Aug 24: Jannik meet first-round opponent Sinner fired his fitness trainer and physiotherapist because of his two positive steroid tests in March and said Friday at his pre-U.S. Open news conference his first public comments on the matter — that he knew he was innocent but worried what the case's outcome would be until finding out he wouldn't be sus-

A 2007 batch IAS officer, Suhas won the silver (SL-4 category) at the Tokyo Paralymics. He served as the District Magistrate of Gautam Buddh Nagar during the Covid times and was also the DM of Prayagraj.

An Ajuna awardee, Suhas is currently posted as the secretary and director-general of Youth Welfare and Prantiya Rakshak Dal, a department under the Uttar Pradesh government. Suhas admits the journey to become the best in the business has not been easy.

Key chain to ward off evil, coach Deepali's hard work behind Swapnil's Olympic glory

Swapnil Kusale isn't really superstitious but when fellow mates Akhil Sheoran and Shriyanka Sadangi gifted him a small key chain to ward off evil eye, he readily accepted it before boarding the flight to Paris for the Olympics.

Swapnil has found himself being defeated by fate in several top-notch competitions, including the Asian Games in 2023 and the 2022 World Championships in Cairo, where just one shot -- and a few decimal points -- pushed him to fourth place.

But in Paris, the 29-year-old set the record straight, becoming the first Indian ever to win a bronze medal in 50m rifle 3-positions event at the Olympics.

While Akhil and Shriyanka, both 50m rifle 3-positions shooters, had secured Olympic quota places for the country, they could not make the cut for the Games following the Olympic Selection Trials conducted by the National Rifle Association of India.

"Just before I was to travel to Paris, My best friends Akhil and gifted a key chain to guard me against the evil eye. They said, 'bhai jeet ke aana hai' (return a

That, and the learnings imparted by personal coach Deepali Deshpande and 'elder sister' Tejaswini Sawant, says Swapnil, played a huge role in his Olympic success.

"The three of us -- me, Akhil and Shriyanka -- have been together for years and they take care of me whenever I am in Delhi. We share a very strong bond. Akhil is like my brother and Shriyanka my sister. We are a family whenever we are in camp or competition... so many years we have spent together since our junior days," wapnil told PTI on Saturday.

Swapnil, who hails from Kolhapur in Maharashtra, says that it's the hard work put in by former international rifle shooter Deepali that has helped him achieve success in his maiden Olympics.

Five years ago, Rahul and fellow cricketer Hardik Pandya faced a nationwide outcry after making comments about women on Bollywood director Karan Johar's talk show. The remarks sparked outrage on social media and led to their suspension ahead of an ODI series against Australia.

"The interview was a different world. That changed me. Completely changed me," Rahul said in a podcast with Nikhil Kamath, which also included Bollywood stars Kriti Sanon and Badshah.

"I was a very shy, soft-spoken boy growing up. Then I played for India and became very confident, I had no problem being in a huge group of people. People will know I have been in a room of 100 people because I would talk to everyone.

"Now I don't (do that) because that interview scarred me massively. Getting suspended from the team. I have never been suspended in school, I have never been punished in school. All this never happened to me. I didn't know how to handle it," he added.

Rahul said that while he was 'mischievous' in school, he had never been suspended or ex-

"I did mischievous things in schools like chota mota (small things), but nothing to get me expelled from school or my parents have had to come. That was my first, and then you realise how bad it is," he said.

India opener Shikhar Dhawan announced his retirement from all forms of cricket two years after he last donned the national jersey, saying that he leaves the scene a content man after representing the country in all three formats.

The 38-year-old made his international debut in 2010 in an ODI against Australia in Visakhapatnam and his last India game was also a 50-over match, against Bangladesh in 2022.

"As I close this chapter of my cricketing journey, I carry with me countless memories and gratitude. Thank you for the love and support! Jai Hind!," Dhawan said in a post on 'X'. "It's important to turn the page to move forward in life and that's why I am announcing my retirement from international and domestic cricket. As I bid goodbye to my cricket journey, I have peace in my heart that I played for so long," he said.

Tributes also poured in from across the border with former Pakistan opener Saeed Anwar hailing Dhawan's hard work and other qualities.

"Your hard work, determination, quality cricketing skills, and great human being will always be remembered; thank you, boy, for wishing you all the best for the next career ahead," wrote Anwar. (PTI)

nic conflict in Manipur since May last year has affected the performance and mental strength of the players, two Imphal-based football clubs have said in their petition to the Delhi High Court, while pleading for quashing of the national federation's (AIFF) decision to relegate them from the I-

Last month, the All India Football Federation (AIFF) relegated NEROCA FC and TRAU FC from the I-League after the two Manipur clubs finished at the bottom of the 2023-24 season points table. NEROCA finished 12th with 14 points while TRAU got 13 points to end at 13th and last spot.

Beacuse of the prevailing conditions in Manipur, NEROCA and TRAU could not play their home matches in Imphal. They played five of their home games in Kalyani, West Bengal, while the remaining seven were played in Shillong. The two clubs had also requested to shift their respective away matches against Aizawl FC to a neutral venue. Thousands of people from the other ethnic community involved in the conflict

had shifted to Mizoram. Later, NEROCA and TRAU refused to travel to Aizawl to play their away matches on April 8 and 12, leading to the AIFF cancelling



The AIFF took the decision to relegate the two clubs to I-League second division despite Manipur Chief Minister N Biren Singh's earlier request to exempt the two Imphal-based clubs from relegation, citing ethnic conflict in the state that began on May 3, 2023.

The two clubs have now knocked the doors of Delhi HC which has issued notice to the AIFF. The case is coming up for hearing on September 6.

"Counsel for the petitioners asserts that this relegation is arbitrary and it fails to consider not only the petitioners past performances and scores but also the societal background immediately preceding the qualifying matches placement," an order of Delhi HC single bench read

The order of Justice Sanjeev Narula delivered on July 24 said "prior to the conclusion of the footballing season from 2022-23, the situation in Manipur became alarming leading to loss of life, vandalism, destruction of properties and communal clashes in the state." "Due to such communal disturbances and keeping in mind the prevailing law and order situation, the 'home base' venue for the petitioners' I-League matches were shifted to the Kalyani Stadium in Kolkata. The teams had to travel outside the state of Manipur and set up a new 'home-base' outside their actual home state.

grave fear of imminent devastation of their homes, family and close ones, the mental strength of the players was severely affected. Due to these circumstances, the petitioner teams ended up at the bottom of the scoreboard for the I-League season 2023-24," the petitioners said, according to the order of the HC single bench.

The two clubs submitted to the High Court that the AIFF has the discretionary power to take into account the prevailing circumstances faced by a football club and consider exemption from relegation. They said such a power has previously been invoked by the AIFF to exempt other football clubs from relegation on account of prevailing situation faced by the teams. "The petitioners point out that there have been situations in the past where such an exemption from relegation, as requested by the petitioners, was granted by AIFF to other football clubs, details thereof are mentioned in the present petitions.

"The petitioners claim parity with these earlier instances of exemption being granted to other football club. They argued that AIFF ought not to have taken a rigid approach by ignoring the relevant circumstances," according to the order. (PTI)
