

AIUDF seeks safety of Muslims in Upper Assam

Threats are directly in violation to fundamental rights, says memo to Guv

GUWAHATI, Aug 26: The AIUDF on Monday submitted a memorandum to Governor Lakshman Prasad Acharya, seeking action by the state government against several organisations which have issued threats against a section of the Muslim community" asking them to leave the Upper Assam districts or "face the conse-

Upper Assam, comprising nine districts, is an administrative division of the northeastern state.

The opposition party also sought a public statement from the BJPled state government, condemning the stand taken by these organisations against a section of Muslims.

A number of organisations recently asked the 'Miyas' to leave the upper Assam districts immediately, claiming it as a step to protect the indigenous people and their culture.

'Miya' is originally a pejorative term used for Bengali-speaking Muslims in Assam and the non-Bengali speaking people generally identify them as Bangladeshi immigrants. In recent years, activists from the community have started



adopting this term as a gesture of

In a memorandum to Governor Lakshman Prasad Acharya, the AIUDF said, "It has come to our notice that some unknown organisations and fundamentalist groups have publicly issued threats against a section of the Muslim community demanding that they should leave upper Assam immediately or face dire consequences.'

Such statements are not only alarming but also create a serious threat to communal harmony and safety of the community in the retions. Urging the governor's intervention in the matter, the party also asked the state government to take strict legal action against those organisations, including initiating legal proceedings.

It requested the state government to deploy adequate security forces in the upper Assam areas to ensure the safety and security of

The memorandum also asked the state government to issue a public statement condemning such threats issued by the organisations and reassure all communities that their safety and rights will be protected.

The AIUDF also urged the government, in collaboration with civil society, to initiate programs and campaigns to promote communal harmony and unity among the different communities.

"We, the members of AIUDF, remain committed to upholding the values of fraternity, peace, unity and justice and we believe that your timely intervention will help prevent escalation of tension and ensure the continued harmony of our state,"

12 houses set on fire after idol defaced at Tripura temple

AGARTALA, Aug 26: At least 12 houses and a few vehicles were set on fire by unidentified persons after an idol was found defaced at a temple in Ranirbazar area in West Tripura, police said on Monday.

Prohibitory orders under Section 163 of BNSS were imposed in Jirania subdivision under which Ranirbazar falls. Heavy security deployment has also been made in the area to defuse tension.

"Around 12 dwelling houses were set on fire at Ranirbazar by miscreants late on Sunday after an idol of Goddess Kali was found disfigured in Kaiturbari. A few motorcycles and pick-up vans were also gutted in the blaze," assistant inspector general (Law and Order) Ananta Das told PTI.

No human casualties were reported in the incident. Evewitnesses said that the resi-

dents fled their dwellings upon seeing the raging mob.

Das said heavy deployment of security forces have been made to defuse tension and director general of Police, Intelligence, Anurag Dhankar and West Tripura superintendent of Police Kiran Kumar



have visited the area.

"Police will register a suo moto case once the assessment of loss of properties is completed. The situaion is under control," he said.

Following apprehension of breach of peace, prohibitory orders under Section 163 of BNSS have been imposed in Jirania subdivision of West Tripura district from August 26 to 28, district magistrate Vishal Kumar said in an order.

Under the prohibitory orders, assembly of five or more people will be prohibited due to violent activities in the subdivision, it added.

Tipra Motha supremo Pradyot Kishore Manikya Debbarma on Monday expressed concern over the incident and appealed to everyone to maintain law and order.

"Last night incident in Ranirbazar Kaiturbari area is a worrying sign with reports of communal clashes. I appeal to those who are responsible for maintaining law and order to follow the rule of law." he wrote on Facebook. Relief Fund

DIPHU: MLA of Diphu, Bidyasing Engleng distributed cheque of ₹ 5,000 each to 80 students of Taralangso here under Chief Minister's Relief Fund (CMRF) in a formal ceremony held at Longmirjeng Open Stage at Karbi People's Hall, Taralangso on Monday. The MLA said, "Under Mukhya Mantrir Nijut Moina Asoni (MMNMA) scheme, girl students who have passed Class 10 and have enrolled in Class 11 will get ₹1,000 per month. After completing Class 12 board exam and enrolled in degree courses will get a monthly stipend of ₹1,250 for the next three to four years till they complete their graduation. Those girls who have enrolled in post-graduate courses will get ₹ 2,500 per month till they complete their courses. Also under the state government's initiative both boys and girl students of Class-IX have received bicycles. Besides these, in Pragyan Bharati Scheme all girl students securing 60% or more marks and boys securing 75% or more marks in Class 12 board examination will get a scooter. There are many schemes introduced by the state govt to help the students." He urged the students who received the scholarship to make proper use of the money given by the State. MLA Engleng urged the people of Taralangso to be hospitable as it is the seat of Karbi cultural festival.

Shops inspection

DIPHU: District Commissioner, Karbi Anglong, Nirola Phangchopi along with superintendent of police, Sanjib Kumar Saikia visited Diphu market to inspect shops and business establishments to take stock of the grievances of the shopkeepers. The DC urged the shopkeepers and business community to maintain hygiene and cleanliness in the Diphu market and to be polite with the customers. The president of the greater Diphu Market Committee, Bidyasing Tisso showed DC the chocked drain in narrow passage passing through the dry fish market which emanates foul odour. Tisso urged for a suitable place to relocate street food vendors. The DC held a meeting with the shopkeepers which was largely attended.

Railway tracks

GUWAHATI: Railway tracks in Hailakandi district have been severely damaged due to erosion, leading to the complete disruption of rail connectivity between Assam and Mizoram, a news bulletin informed on Monday. As per reports, the affected stretch of the railway line has made it impossible for trains to pass, causing a major inconvenience to passengers and disrupting transportation between the two states. Subsequently, railway authorities are closely monitoring the situation and have dispatched teams to assess the extent of the damage. Additionally, efforts to restore the damaged tracks are underway, but it is expected that the rail connectivity between Assam and Mizoram will remain suspended for several days. Furthermore, the disruption of rail services is expected to have a significant impact on the movement of goods and passengers, especially in the border areas between Assam and Mizoram.

Assam: 32 deaths reported due to JE, malaria in June, July

GUWAHATI, Aug 26: Nearly 1,100 cases of Japanese Encephalitis, malaria and dengue have been reported across Assam in June and July this year and of the patients, 32 have died, officials said.

According to state Health and Family Welfare Department's data, a total of 424 Japanese encephalitis cases were detected in June and July across the state.

"Out of that, 48 cases were detected in June and 376 were reported in July. One patient died in June and 28 lost their lives in July," an official of the department said, citing the data.

In case of malaria, 166 cases were reported in June and 187 in July. In June, three people died due to the disease, as per the records. In June, 80 people tested positive for dengue across

the state, while 214 cases of the disease were detected in July. There was no report of any death due to dengue. As per official records, the Health Department is undertaking several steps to control the spread of the disease, caused by mosquito bites.

The government has conducted fogging across the



state, especially in the targetted areas. Also, larvicidal spraying has been carried out, while larvivorous fishes were released in different drains to contain breeding of the mosquitoes. (PTI)

Assam CM bats for stringent law to tackle crimes against women

RANCHI, Aug 26: Chief Minister Himanta Sanjay Seth's residence in Ranchi, Sarma Biswa Sarma on Monday advocated for a stringent law to tackle crimes against women, expressing support for Prime Minister Narendra Modi's call for such legislation.

Sarma emphasised that all legal processes, including inquiry, charge-sheet, trial, and conviction, should be completed within six months in cases involving crimes against women.

"Crimes against women are on the rise. I welcome the PM's announcement that a strict law is needed," Sarma said.

He further remarked, "My only observation is that a deadline of six months should be fixed for all processes such as inquiry, charge-sheet, trial, and conviction in crime cases against women. Then only will we be able to reduce such crimes.

GUWAHATI, Aug 26: Two Rajya Sabha candidates of BJP in Assam were elected unopposed on Monday as the opposition refrained from fielding candidates against two vacant berths in the upper

house of the parliament. The ruling party fielded former Union minister Rameswar Teli and ex-MLA Mission Ranjan Das in the two vacant seats of Rajya Sabha last week. Since there were no candidates from the opposition camp, both Teli and Das were declared elected to the Rajya Sabha unopposed by the election officials.

The two BJP nominees collected their certificate of winning the election unopposed. The seats got vacant after Sarbananda Sonowal and Kamakhya Prasad Tasa fought the Lok Sabha elections and they became

MPs in the lower house of the parliament. Sonowal won from the Dibrugarh Lok Sabha seat and Tasa defeated the Congress candidate Roselina Tirkey in the newly formed Kaziranga parliamentary con-

> stituency. To recall, in the delimitation exercise, the Kaliabor constituency was scrapped by the Election Commission and a Kaziranga Lok Sabha seat was introduced. This had forced Congress leader Gaurav Gogoi to shift to Jorhat parliamentary constituency.

LEH/NEW DELHI, Aug 26: Union Home Minister Amit Shah announced Monday the creation of five new

districts in Ladakh, raising their number to seven in a decision welcomed by local people as fulfilment of their long-pending demand.

The new districts are: Zanskar, Drass, Sham, Nubra, and Changthang.

However, the Leh Apex Body, which along with the Kargil Democratic Alliance (KDA) is fighting for their four major demands including granting of statehood and extension of sixth schedule of the Constitution, said they will continue their peaceful struggle.

In a post on X, Shah said the Union Home Ministry has decided to create the five new districts in pursuit of Prime Minister Narendra Modi's vision to build a de-

veloped and prosperous Ladakh. "The new districts, namely Zanskar, Drass, Sham, Nubra and Changthang, will take the benefits meant for

the people to their doorstep by bolstering governance in every nook and cranny," he said. Leh and Kargil were the only two districts in Ladakh, the largest union territory in terms of area but the second least populous. It has an expanse of 86,904 square kilometers bordering China and Pakistan, with a population of 2.74 lakh according to the 2011 census.

The home minister said the Modi government is committed to creating abundant opportunities for the people of Ladakh. Ladakh was carved out of the erstwhile state of

Jammu and Kashmir and declared a UT after the state was divided into two UTs on August 5, 2019. On that day five years ago, Article 370, which gave

special status to the erstwhile state, was also abrogated. Being a UT, Ladakh comes under the direct administrative control of the union home ministry.

Prime Minister Modi hailed the creation of the new districts as a step towards better governance and prosperity. Zanskar, Drass, Sham, Nubra, and Changthang will now receive more focused attention, bringing services and opportunities even closer to people, he said, congratulating them.

Affordable TB testing technology developed by ICMR's regional centre

NEW DELHI, Aug 26: An affordable tuberculosis testing technology that can detect the disease using a patient's sputum for just ₹ 35 has been developed by apex medical research body ICMR's re-

gional centre in Assam's Dibru-

The 'A CRISPR case-based TB detection system' is light, portable and involves three steps of testing. Over 1,500 samples can be tested in one single run in around twoand-half hours, ICMR sources said. Conventional diagnostic techniques for TB commonly rely on culture, which requires 42 days to confirm as TB negative, microscopy, and nucleic acid-based methods. These are also time-consuming and may require sophisti-

cated equipment. An official said, "Tuberculosis lenge, necessitating the development of accurate and rapid diagnostic tools for effective disease management. Current diagnostic methods often exhibit limitations in terms of sensitivity, specificity, speed and cost, emphasising the need for innovative approaches"

(TB) remains a global health chal-

Additionally, some molecular diagnostic methods, while offering improved sensitivity, may lack the desired specificity or face challenges associated with cost and ease of handling.

"Considering these problems, the CRISPR-Cas12a-based molecdiagnostic system 'GlowTBPCRKit' coupled with an amplification step (using thermal cycler) and the 'RapidGlow device' provides a promising solu-



tion," the official said.

The Indian Council of Medical Research (ICMR) has now invited Expression of Interest (EoI) from eligible organisations, companies, manufacturers for undertaking

'Transfer of Technology' for commercialisation of the 'A CRISPR case-based TB detection system for the detection of Mycobacterium tuberculosis.

The ICMR-RMRCNE institute

will provide expert guidance and technical support for the production of 'A CRISPR Cas based TB detection system' in all phases.

Such technical oversight by the institute would accelerate the development of the product and its commercialisation.

The ICMR would also provide technical support through its team of experienced scientists in study, planning, product development, development of study protocol, results or data analysis, outcome assessment, safety and efficacy assessment, product improvement, etc., if deemed fit upon the mutual understanding between ICMR and collaborative company.

"US Fed has signalled a rate cut in September, reflecting in the decline in US treasury yields and the dollar index, which has led to a rally in global markets despite there being no indication of the size of cuts. Indian markets hit a new high led by a change in FII stance to positive from negative, along with continued strong DII inflows.

"Although the overall trend was positive, large caps outperform on account of healthy earnings and relatively fair valuation compared to broader markets. IT, Realty, FMCG and Consumption gained

on account of improved outlook,' Vinod Nair, Head of Research, Geojit Financial Services, said.

Among the indices, metal surged 2.03 per cent, realty (1.69 per cent), consumer durables (1.43 per cent), IT (1.37 per cent), teck (1.11 per cent) and commodities (0.91 per cent).

success of digitalisation of financial services, the Reserve Bank will be launching Unified Lending Interface (ULI), a platform to ensure frictionless flow of credit, especially for smaller and rural borrowers.

Last year, the Reserve Bank had launched a pilot of a technology platform which enables frictionless credit in two states.


"From now on, we propose to call it (platform) the Unified Lending Interface (ULI). This platform facilitates seamless and consent-based flow of digital information, including even land records of various states, from multiple data service providers to lenders," said RBI Governor Shaktikanta Das at the RBI@90 Global Conference on Digital Public Infrastructure and Emerging Technologies' here. He emphasised that the 'new trinity' of JAM-UPI-ULI will be a revolutionary step forward in India's digital infrastructure journey.

In the inaugural speech, Das said Unified Payments Interface or UPI, a real-time payment system launched in India in April 2016 by the National Payments Corporation of India (NPCI), has played a significant role in the growth of retail digital payments in India. NPCI was promoted by banks under the guidance of the Reserve Bank.

While initial participants on the UPI platform were banks, non-bank third party app providers and use of QR codes have all ombined in popularising UPI.

It has since emerged as a robust, cost-effective and portable retail payment system and is attracting active interest across the

globe. Das said He said the ULI will cut the time taken for credit appraisal, especially for smaller and rural borrowers. The ULI architecture has common and standardised APIs, designed



for a 'plug and play' approach to ensure digital access to information from diverse

This reduces the complexity of multiple technical integrations and enables borrowers to get the benefit of seamless delivery of credit, quicker turnaround time without requiring extensive documentation, he said.

Das said by digitising access to the customer's financial and non-financial data that otherwise resided in disparate silos. ULI is expected to cater to large unmet demand for credit across various sectors, particularly for agricultural and MSME borrowers.

"Based on our experience from the pilot project, a nationwide launch of the ULI will be done in due course. Just like UPI transformed the payments ecosystem, we expect that ULI will play a similar role in transforming the lending space in India," Das

The Governor further said that ideally, while the legacy payment systems should be able to connect to each other and so should the Central Bank Digital Currency (CBDC) systems, one country's legacy system should also be interoperable with another country's

He also praised the Ladakh Lt Governor Brig (Retd) B D Mirsha for his efforts in granting the five new districts to the region. "I am thankful to home minister and Modi government on behalf of the people of Ladakh for announcing five new districts to Ladakh which was a long pending demand of the people, especially Zanskar region," said Sonam Wangchuk, a climate activist and a member of the Leh Apex Body.

He said the decision is in accordance with the promise made by the BJP to the people of these areas but "we have to see whether these are just administrative districts or democratic units wherein they have autonomous district councils like Leh and Kargil". Wangchuk reminded the BJP of its promise of extending sixth schedule of the Constitution to the region and said the government must address the primary demand of the people for safeguards otherwise the struggle of the locals would continue.

The Congress' Ladakh president Nawang Rigzin Jora also welcomed the Centre's decision but said just creating administrative districts would not save environment, culture and identity of the people of Ladakh for which they are on the streets for the last over four years.

"Creating five more districts further strengthens our demand for statehood because the UT of Pondicherry with only four districts has a legislative assembly. Ladakh is strategically located and the demands of its people are justified," Jora, whose party is also part of the LAB, said, adding the LAB will continue its struggle in support of its four-point agenda. He also demanded democratically elected autonomous hill councils for the newly created districts and a separate budget for the new districts.

Ladakh Buddhist association president Chering Dorje Lakrook, who is also co-chairman of the LAB, said the government's decision fulfilled the justified demand of the people. "This decision will benefit the people especially living in far-flung areas by getting all facilities at their doorstep," he said.

He said there will be no impact of the decision on the ongoing struggle in support of their four demands. "The creation of new districts is not the demand of the LAB and KDA, so we stand by our decision to undertake foot march from Leh to Delhi beginning September 1." (PTI)

Over 23 lakh govt employees under NPS get option to choose unified pension scheme

announced Unified Pension Scheme for central government employees will be available only for those who are currently subscribers of the New Pension Scheme (NPS), including retirees. The new scheme guarantees employees 50 per cent of their average basic pay over the last 12 months before retirement as a pension for a minimum qualifying service of 25 years against a market returns linked payout under the NPS.

According to the scheme approved by the Union Cabinet, the pension will be proportionate for a lesser service period of up to a minimum of 10 years. Also, assured pension of ₹ 10,000 per month on superannuation after a minimum of 10 years of service.

The scheme has been brought out to address the concerns of government employees over NPS, which came into effect from January 1, 2004. Under the old pension scheme

(OPS), effective before January 2004, employees got 50 per cent of their last drawn basic pay as pension. Unlike the old pension scheme, UPS is contributory in nature, wherein employees will be required to contribute 10 per cent of their basic salary and dearness allowance while the employer's contribution (the central government) will be 18.5 per cent.

Under the NPS, the employer contribution is 14 per cent, and the employee contribution is 10 per cent. However, the eventual payout depends on the market returns

government debt. Employees, under the OPS, were not required to make any contribution. They, however, contributed to the General Provident Fund (GPF). The accumulated amount, along with interest, was paid to the employee at the time of

As the NPS was less attractive than the OPS, several non-BJPruled states decided to go back to the old pension scheme, which offered a DA-linked benefit. This prompted the Centre to constitute a committee in April 2023, under former Finance Secretary and now Cabinet Secretary-designate TV Somanathan to suggest improve-

ment in the NPS architecture. Fulfilling the long pending demands of government employees ahead of assembly elections in Harvana and Jammu and Kashmir, the Union Cabinet on August 24 approved the UPS, which will provide assured pension to 23 lakh eligible central government employees. Those opting for the UPS will not be able to switch back. The UPS will put an additional burden of ₹ 6,250 crore on the exchequer per year. The expenditure will vary every year according to variations in the number of employees.

In addition, there will be an arrear of ₹ 800 crore that has to be paid under the National Pension System (NPS) to employees retiring before March 31, 2025. If these retirees opt for UPS, they will receive arrears.

"UPS is being implemented by the Central Government, benefitting 23 lakh central government employees," Information & Broadcasting Minister Ashwini Vaishnaw said on X on Sunday.

"This move signals the government's commitment to providing robust support for its workforce, enhancing financial stability for millions of government employees across the country," Thomas said. 
BTR chief Pramod Boro lays foundation for new infrastructure in Kokrajhar

Police conduct road march to ensure public peace in Sivasagar

SIVASAGAR, Aug 26: Apprehensive of potential public unrest following two recent incidents in Sivasagar and Dhing, and the resulting widespread reaction, the Sivasagar district administration conducted a road march in Sivasagar town on Monday, District commissioner Aditya Vikram Yadav and SP Sivasagar Subhrajyoti Bora led the march, which covered the main roads of the town. The district commissioner told The Assam Tribune that this is a normal procedure to maintain public peace. When asked about the bondsigning by several leaders of organisations calling for a mass public democratic movement against attacks on Indigenous people, the district commissioner stated that it is part of the administrative procedure under Bharatiya Nagarik Surakhya Samhita (Dhara 126) and CrPC 107 to maintain law and order. He noted that the leaders of the organisations have cooperated with this

Reacting strongly against the administration's bond-signing tactics, Shrinkhal Chaliha, leader of Bir Lachit Sena, said he would never sign such bonds. He added that the narrative of Hindu Bangladeshi supporters being aligned with the BJP and Muslim Bangladeshi supporters with the Congress must change. In Sivasagar, no one speaks of discrimination on religious lines; the focus is on resisting outsiders

who exploit local resources. Partha Pratim Gogoi, secretary of ATASU's Sivasagar unit, stated that the move to silence the spontaneous movement against illegal land grabbers and to protect indigenous people, led by student and youth organisations, has been applauded by the people of the state for its discipline. He asserted that bondsigning is absolutely irrelevant and unjust.

ATASU leader Basanta Gogoi criticised the administration's bond-signing of leaders from indigenous people's organisations as an anti-people move. He warned that such coercive steps to deter indigenous Assamese from voicing their grievances would only aggravate the situation. Gogoi claimed that the administration seems more concerned about the security of non-Assamese traders and Bangladeshi Miyans than about the Assamese people. He emphasised that the recent democratic movement in Sivasagar was peaceful and did not involve any illegal activities.

There is an undercurrent of apprehension among certain sections of society, particularly among migrated Muslims from other districts. Hundreds of Miyans disappeared from the crowded Sunday market (Krishak Bazar), and many e-rickshaw drivers went nto hiding overnight in Sivasagar, Nazira, Sonari, and Mahmora. Activists from indigenous organisations like ATASU and TAYPA have launched door-to-door searches for suspected Bangladeshi nationals, creating an atmosphere of fear and anxiety among certain

In Moran, Debajit Gogoi, executive president of the central committee of ATASU, threatened supporters of Congress (I) MLA Abdul Rashid Mandal for allegedly supporting Bangladeshi Miyans in connection with the Dhing incident. Gogoi stated that Mandal and his supporters would not be allowed to enter Upper Assam, and other party leaders who have remained silent over Mandal's comments must prove that they support the rights of indigenous people in the future.

100 people rejoin Hinduism after converting from Christianity

Malayalam film industry at crossroads

The recent release of the Hema Committee report on the Malayalam film industry has laid bare its dark, exploitative underbelly. Sexual harassment, wage disparity, illegal bans, drug and alcohol abuse, and inhumane working conditions are rampant. The findings, released five years after the report was submitted to the Kerala Government, demand immediate attention and action. At the heart of this toxic environment is a powerful cabal of male producers, directors, and actors. A prominent actor labelled them as a "mafia" controlling the industry. Their dominance extends to blacklisting those who refuse to comply with their demands, with the Committee confirming the prevalence of the notorious "casting couch" culture. Disturbingly, sexual exploitation begins even before women are hired, with prominent figures demanding sexual favours in exchange for roles. Numerous women have come forward with evidence of these casting couch attempts, including audio and video clips. However, their testimonies also reveal a pervasive fear of retaliation, deterring many from speaking out or even informing their families. The situation is especially dire for junior artists, who face exploitation and deplorable working conditions. They are often forced to work up to 20 hours a day without proper compensation, and intermediaries siphon off much of their pay. One of the most alarming revelations is the lack of basic facilities for women on set, such as toilets and changing rooms, leading to health issues like urinary infections. Adding to the horror, drunken men often harass women in their accommodations, even attempting forced entries.

One case highlights the trauma of an actress forced to perform with her abuser the day after the assault. Despite the gravity of these issues, the internal complaints committees within the industry remain powerless, often manipulated by those in power. The Hema Committee has recommended the establishment of a Tribunal and new laws to address these concerns. Meanwhile, the Kerala High Court has taken notice. A public interest litigation (PIL) has been filed seeking criminal proceedings against those guilty of sexual exploitation. The Court has asked the Government to submit the full Hema Committee report, parts of which remain unreleased due to concerns for the victims' safety. The Court has also stressed the need to protect vulnerable women and hold perpetrators accountable, urging the Government not to ignore the report. The Advocate General argued that victims could approach the police or courts, but this fails to address the fear and intimidation many women

In 2022, the Women in Cinema Collective (WCC) secured a significant victory when the Kerala High Court ordered the formation of Internal Complaints Committees (ICC) on film sets. While the formation of the WCC and the Hema Committee report have led to some improvements, much more remains to be done. Opposition leader V D Satheesan has called for an all-women team of IPS officers to investigate the Committee's findings, and Congress MP Shashi Tharoor has labelled the documented criminality as a stain on the industry, long overdue for cleansing. The intervention of the High Court has rekindled hope among victims, and the Government must act decisively on the Court's directives. The Malayalam film industry is at a crossroads—either it can continue to protect the powerful at the expense of the vulnerable, or it can seize this moment to cleanse itself and ensure justice for all. Assam's identity crisis: Balancing indigenous rights and communal harmony

The situation in Assam presents a deeply complex and historically rooted narrative that has become more pronounced in recent times. Assam, a state in India's northeastern region, has witnessed significant demographic and cultural shifts over the past several decades, driven by various socio-political and historical factors. The tension between indigenous communities and those who have migrated to the region from erstwhile East Bengal, East Pakistan, and present-day Bangladesh has culminated in a fraught environment where indigenous populations often feel marginalized, threatened, and, in many cases, fearful for their lives.

The Historical Context: Immigration and Demographic **Shifts:** The roots of this situation can be traced back to the early 20th century when Assam was clubbed with the newly created Bengal province in 1905 by Lord Curzon. This period saw the first major influx of "land-hungry" Muslim peasants from East Bengal into Assam. Over time, these migrants settled in various parts of Assam, leading to significant demographic changes in the region. The tension between the indigenous Assamese communities and these migrants has persisted since, with several flashpoints marking the relationship between the two groups.

1985) was a significant chapter in this ongoing conflict. Led by the All Assam Students' Union (AASU) and other local organizations, the movement aimed to stop the influx of illegal immigrants and protect the rights of the indigenous population. However, this period was also marked by violence, with several incidents where immigrants were accused of attacking villages of indigenous communities. These attacks often involved looting, arson, and heinous crimes such as rape and kidnapping, further deepening the divide between the two commu-

South Kamrup and Mangaldoi in Darrang are often cited as glaring examples of such violence.

The Recent Developments: Fear and Insecurity: Fast forward to the present, Assam Chief Minister Himanta Biswa Sarma has expressed concern over the safety and security of indigenous communities in the state. According to Sarma, these communities. particularly in areas where they are minorities, are living under the constant shadow of fear. He has pointed out that crimes against indigenous people, especially women, have seen a disturbing rise, allegedly encouraged by a section of the population post the Lok Sabha elections.

The case of Dhing, a small town in Assam, exemplifies the ongoing struggle between the indigenous Assamese population and the migrants. The area, once inhabited by close followers of the Assamese saint-scholar Sankaradeva, has seen a significant demographic shift over the past few decades. The story of the Kobaikata Satra, a Vaishnavite monastery near Dhing, is particularly telling.

Over a period of about twenty vears, the local indigenous population was reportedly driven out by immigrants through a systematic campaign of thefts, burglaries, kidnappings, rapes, and threats. Today, only a small portion of land remains where the naamghar (prayer hall) of the Satra stands, with the surrounding areas now dominated by the migrant population.

This pattern of demographic invasion, as some call it, is not

isolated to Dhing alone but is seen across various parts of Assam and the broader northeastern region. The fear is that such incidents are part of a larger design to push out the remaining indigenous populations, thereby altering the demographic and cultural landscape of Assam.

New Dimension to the Conflict: While the issue of indigenous versus migrant

communities

continues to simmer, a new dimension to the conflict emerged recently in Sibsagar, another town in Assam.

Here, a community was compelled to apologize for the actions of a few individuals who were accused of assaulting a minor female arm wrestler. The incident, which took place on 13 August, sparked outrage as the entire community (in this case, the Marwari community) was held accountable for the crime of a few. What made this incident particularly controversial was the fact that the apology was extracted in the presence of a state minister, leading to allegations of communal bias and further stoking tenbetween different communities in Assam.

This incident was seen by some as an example of "Asomiyagiri," a term used to describe the domination of the Assamese community over others. It highlighted the deep-seated resentment that exists among some sections of the Assamese population towards non-Assamese residents, whom they view as outsiders. However, demned by a large number of Assamese intellectuals and social media users, who argued that such divisive ideologies were harmful to the social fabric of Assam. They called for a more inclusive approach that respected the cultural diversity of the state while also addressing the genuine concerns related to illegal immigration.

The Dhing Rape Case: A Test of Justice: As if to underscore the volatile situation in Assam. another horrific incident occurred in Dhing, where a minor girl was allegedly gang-raped by suspected migrants on 22 August. This incident sent shockwaves across the state, leading to widespread protests and demands for justice. The All Assam Students' Union (AASU) led the charge, organizing a bandh (shutdown) in Dhing to protest

against women in the region. The AASU president, Utpal Sarma, expressed deep concern over the failure of law enforcement agencies to protect the indigenous population and called for stringent action against the

against the in-

creasing crimes

perpetrators. In response to the public outcry, Chief Minister Himanta Biswa Sarma directed the state police to take swift action against the accused. However, the situation took a dramatic turn when one of the accused died under mysterious circumstances while in police custody. According to reports, the accused drowned while trying to escape from custody, raising questions about the circumstances of his death and whether it was a case of extrajudicial killing.

The Way Forward: A Call for Rational Discourse: The situation in Assam is a complex and sensitive issue that requires a balanced and rational approach. On the one hand, there is a genuine concern about the changing demographics of the state and the threat it poses to the cultural identity of the indigenous population. On the other hand, there is a need to ensure that justice is not compromised in the name of protecting cultural identity. The recent incidents in Sibsagar and Dhing highlight the dangers of communalism and the importance of upholding the rule of law.

The Patriotic People's Front Assam (PPFA), a forum of nationalist citizens in northeast India, has called for a more nuanced approach to the issue. They have urged the Assamese population to support a corrected National Register of Citizens (NRC) with the base year of 1951, to ensure that all illegal immigrants can be identified and dealt with according to the law. The PPFA has also criticized the tendency among some Assamese leaders to be overly lenient towards illegal immigrants while being harsh on other non-Assamese communities, such as Hindi-speaking residents. They argue that this double standard only serves to weaken the Assamese cause and alienate potential allies in the fight to protect Assam's cultural identity.

Navigating a Complex Reality: Assam stands at a crossroads, grappling with issues of identity, immigration, and communal harmony. The state's history is marked by a continuous struggle to protect its cultural and demographic integrity against external influences. However, in doing so, it must also navigate the complex realities of a diverse society, where different communities coexist and contribute to the state's rich cultural mosaic.

The incidents in Dhing and Sibsagar are stark reminders of the challenges that lie ahead. The path forward requires not just strong leadership but also a collective commitment to justice, inclusivity, and the rule of law. Only by addressing the root causes of these conflicts and fostering a spirit of mutual respect and understanding can Assam hope to overcome the divisions that threaten to tear it apart. Prospects of a Left-wing prime minister in France brighten after talks

The prospects of the appointbrightened after President Emanuel Macron had talks on Friday with the Prime Minister nominees of the New Popular Front and the right wing National Rally. Sources said that the President may take a final decision next week after discussions with his party colleagues.

The final round of national elections were held on July 7 and the results were announced the same night. The New Popular Front, the coalition of the left wing parties gotten highest number of seat sat 183, followed by President Macron's coalition at 163 and the rightwing National Rally (RN) of Marie Li Pen

There are other smaller parties also. Since no combination got majority on its own, the New Popular Front staked the claim for the PM's position and nominated a veteran socialist Lucie Castets. President Macron had detailed discussions with this former civil servant and environment activist about the formation of the new Government.

Lucie Castets told the President that she was ready to form the Government and she would discuss the programme with Macron's party about the need for making some changes, if needed. Castets gave the impression that she would not be rigid about the official programme of the New Popular Front and she would take into account the need for keeping out the far Right National Rally from power.

President Macron had talks with the National Rally leaders also during the day, but this was not conclusive. President will be meeting the two to pleaders of the RN Marie Le Pen and their PM candidate Jordan Bardella on Monday.

The RN is not keen on forming the ministry as both Macron's neo liberal coalition and NFP have more seats in the national assembly and both are committed not to have any truck with RN.

Marie Le Pen feels that even if the Macronites and the Left unite to form the government, it will not last. That will help Le Pen in the Presidential elections in 2027. Le Pen is more interested in preparing for 2027 polls.

Macron's office said he would name a prime minister based on these consultations, which are aimed

at "moving towards the broadest and most stable majority possible.'

But in the assembly presidents' election, Macron's party defeated the communist candidate by only seven votes by organizing votes from other parties. Now, it has to be seen whether President Macron abides by the July 7 mandate or resorts to some manipulative tactics to retain power and deny the Left the post of their due Prime Ministership.

Castets said that in her meeting with Macron, he "recognised that a message was sent by the French during the elections" but seemed reluctant to allow an opposition party to form a government.

Marine Tondelier, the national secretary of the Green Party said We need a response by Tuesday. There are urgent issues and leaving weeks rolling by without facing tem is grave and even irresponsible'

The New Popular Front, which includes the French Communist Party (PCF), France Unbowed, the Socialists and the Greens, has insisted that the prime minister should come out of their ranks as the largest group.

PCF general secretary Fabien Roussel said that the president agreed during the meeting that the New Popular Front is the only one to have formally made the proposal for nominating their Prime Minister.

The NFP is the biggest group and the leader of the largest component Jean Luc Melenchon has urged the President to respect the verdict and invite the Left to form the government.

French unbowed the party of Melenchon has 74 seats followed by the Socialists 59 the Greens 28 and the Communist Party 9.

In fact, President Macron made it clear after July 7 elections that Jean Luc Melenchon who heads the largest party of the NFP, does not represent the French republican values and his programmes cannot be accepted by him. Itis clear that the NFPPM candidate may be asked by President Macron to bring out more changes in the programme to make that acceptable to him. Jean Luc Melenchon has to agree to that. 

What a Bioluminescent Petunia had to teach me

netunias have never done much for me. If you had told me that one day, I'd fork over more than \$50 for a single petunia plant; my eyes would have rolled out of my head. But this plant was special. This petunia glowed in the dark.

My plant was one of 50,000 shipped around the United States in April by the Idaho-based biotech start-up Light Bio. Called the "Firefly" petunia, it contains genes from bioluminescent mushrooms that make it constantly glow. A news release announcing the petunia's arrival included a photo of a woman gazing serenely at a mass of flowers lit up like oversized glow-in-the-dark stars. Well, that's a neat trick, I thought.

I also wondered whether the Firefly petunia was more than just a trick. Though it seemed inconsequential, perhaps there was some implication I hadn't thought of. At the very least, the plant might make me – a great admirer of plants (but a bit of a botanical snob) - think differently about petunias, those go-to ornamentals for gas stations and mansions

I decided to learn more. So I paid my \$53 (\$29 for the plant, \$24 for shipping) and placed an

Behold, bioluminescence Bioluminescence is the emission of light by living things. It is generated by a chemical reaction within the organism (unlike the phosphorescence of glow-in-thedark stickers, which need to be charged up with light before emitting it). Bioluminescence is widespread, especially in the oceans: There are bacteria, sea snails, shrimp, fish and squid that glow. Terrestrial glowers include some insects and worms as well as fungi.

Scientists have worked out the precise chemical compounds involved for only a handful of bioluminescent organisms. But for the most part, the basics of the light-producing reaction are the same: It requires fuel, oxygen and a catalyst to get the reaction going. In the parlance of bioluminescence research, the fuel is called the luciferin and the catalyst is called the luciferase. The luciferase helps to add oxygen to the fuel, transforming it into a very reactive, high-energy compound. As this overexcited luciferin relaxes,

This ability to produce light has been documented in hundreds of genera across the tree of life. Scientists think it evolved independently in various lineages, perhaps more than 94 different times.

Organisms use bioluminescence in a variety of ways. For fireflies, tracts mates. Some fish use it to lure prey. Other animals, such as the vampire squid, which can expel a cloud of glowing mucus, use it to distract or confuse preda-

In many lineages, giving off

in a reactive state, it can ricochet through cells and damage molecules. This suggests that many luciferins were antioxidants first; their primary role was to mop up damaging oxygen that had been generated during metabolism.

Hunting for the fungal glow Bioluminescent fungi have long grabbed people's attention. In the fourth century BCE, Aristotle noted that fungi could be "fiery and glittering" in the dark. A few centuries later, Pliny the Elder, in his encyclopaedic Natural History, mentions the "brilliant light" emitted by a mushroom that grows on trees. But until recently, no one knew exactly what fungi were using as the fuel or catalyst, or even whether all glowing fungi light up in the same way.

The hunt for fuel and catalyst molecules culminated in 2017 after more than a century of research and a yearslong international race between a scrappy team from the Americas and a well-connected lab in Russia. Yet even before then, scientists had been trying to unravel the mysteries of bioluminescence.

In the 1880s, French physiologist Raphaël Dubois was investigating a click beetle of the genus Pyrophorus, among the brightest of bioluminescent insects. Dubois ground up the glowing parts of the beetle in cold water. They glowed and then faded to nothing. Then he did the same in boiling water: no glow. But when he added the hot mixture to the cold, the mix-

ture glowed. Dubois (who would go on to coin the terms luciferin and luciferase) realised that the reaction required a catalyst and fuel. Only the cold water contained working catalyst – boiling destroyed it. But both hot and cold extracts contained the fuel, which survived boiling. Adding the hot extract to the cold extract provided fresh fuel to the extract with functioning

catalyst – and so it generated light. Decades later, scientists would conduct this hot/cold experiment with bioluminescent fungi, but the identity of the fuel and the catalyst

still eluded them. Roughly 130 fungus species are bioluminescent, says mycologist Dennis Desjardin, emeritus researcher at San Francisco State University, who has described several of those species. Fungi spend most of their lives as webs of thread-like filaments called mycelia, and the mycelia of the bioluminescent fungi give off light, though it's often hidden within the decaying wood in which many of them grow. In species that bear mushrooms, the mushrooms may In 2005, Desjardin began work-

ing with chemist Cassius Stevani of the University of Sao Paulo, Brazil who was looking into how fungi generated their glow. Stevani, along with then-graduate student Anderson Oliveira, had refined Dubois's hot/cold experiment, adding various cellular chemicals to grease the reaction. After perfecting the protocol, Stelight may have arisen as a detoxi- vani wanted to perform the

fication strategy. When oxygen is hot/cold experiment using different species of fungi, one species for the cold and another species for the hot.

These cross-species experiments showed that the different fungi used the same catalyst and fuel, suggesting that bioluminescence had evolved just once in the fungal lineage, Stevani and Desjardin reported in 2012.

"This was very important," says Stevani. "It was saying, Oh, if you have a fungus in Russia or in Asia. you can use it to study the mechanism, because it's the same in all

Meanwhile, biochemist Ilia Yampolsky, who now heads a lab at the Russian Academy of Sciences in Moscow, was also hot on the fungal-light trail. Stevani got wind of this development. "I got crazy, of course, because, I was studying this for 15 years," he says. He wrote to Yampolsky in 2015, suggesting that they collaborate. But the Russians had beaten Stevani to the luciferin punch; their discovery just hadn't been published yet.

The fungal fuel turned out to be made from an antioxidant called hispidin. Hispidin is found not only in fungi, but also in many plants as well. "The molecule I was searching for, for 15 years – I look out of my window, I see plants that have this molecule," tevani says

Since then, the two teams have collaborated. ("We colluded with the Russians," Desjardin jokes.) They nailed down details of the biochemical assembly line that leads up to the light-emitting reaction and published the results together in the Proceedings of the National Academy of Sciences in 2018. Stevani got to name the fungal catalyst. He called it luz, the Portuguese word for light.

Out of fungi and into the

A key discovery in the creation of the glowing petunia was the source of the luciferin fuel in the fungi. It's made from a precursor compound called caffeic acid that is common in fungi and in plants. The fungal assembly line for making light forms a tidy loop - caffeic acid gets converted to hispidin, hispidin gets converted to the fuel, the fuel gives off light and the remaining compound gets converted back into caffeic acid restarting the loop.

Stevani realised that if plants also made that precursor compound, then practically any plant might be engineered to glow. He said as much to Yampolsky. "I said, 'Man, we have a system that uses caffeic acid. We can transform any plant!" Yampolsky replied, "What do

you think I am doing?"

Russian synthetic biologist Karen Sarkisyan led the careful work of sorting out the various genes involved in the light-emitting reaction. Then the team stuck those genes – from the bioluminescent fungus Neonothopanus nambi – into a tobacco plant. It worked: The shoots, buds, flowers and even roots — they all glowed. "Plants and fungi, they speak a

similar biochemical language,' says Sarkisyan, a cofounder of Light Bio who now runs his own lab at Imperial College London. "And because they speak that similar biochemical language, it was relatively easy to translate the metabolic pathway from the fungus to the nlant."

With a bit more genetic tinkering, Sarkisyan, Yampolsky and their collaborators managed to coax other plants - chrysanthemum, poplar, Arabidopsis and petunia - into glowing. By September 2023, the US Department of Agriculture had approved Light Bio's request to make and sell glowing petunias, determining that the plants posed no great risks. Five months later, I placed my order.

Oh, Petunia

My petunia looked like an ordinary white garden petunia when it arrived. It was a bit dishevelled; I transplanted it into a new pot and gave it some water and a spot by a sunny window. After a few weeks it perked up. When I brought it into a dark closet, its flowers faintly glowed - dimmer than a candle, but glowing nonetheless.

I had intended to look into whether the petunia could wreak any ecological havoc - what if it interbred with wild species and the glowing genes escaped? Might our outdoor spaces be transformed into (very quiet) botanical raves? But the petunia's light seemed too dim to interfere with much of any-

Elsa Youngsteadt, who co-authored an article in the 2023 Annual Review of Ecology, Evolution, and Systematics on how constant light in urban environments may influence pollination, basically agreed with me.

She explained that there aren't any wild native petunias in the United States, which is the only place where the Firefly petunia is currently available. The ubiquitous common garden petunias are all hybrids, the result of a long history of crossing the white-flowered and moth-pollinated Petunia axillaris with a pigmented, beepollinated species.

These hybrid petunias already present a crazy mix of signals that might confuse a pollinator, says Youngsteadt, a pollination ecology expert at North Carolina State University. And none of them have proved to be invasive in the United States.

So - the Firefly petunia? "I'm not immediately alarmed by it," Youngsteadt says. But, she adds, Why would we put time, money and potential risk into making something glow for fun?" Why indeed. In fact, the more I

thought about it, the more I wondered whether popping the fungal genes into the petunia was just the himsical icing on a cake cake - the real marvel - was all the years of gumshoe detective work that went into figuring out precisely how the fungi got their glow. And that made me look at my petunia with a fondness that surprised me. (Courtesy: The

When your first start-up fails... 7 things to do

tatistically, about 90 per cent of all startaps fail to survive in the first few years of their operation and are forced to shut down. Nearly 10 per cent of start-ups fail in the first year, while a staggering 70 per cent fail within five years.

While there are numerous reasons that lead to such failure, there are insights available to entrepreneurs on what should be done after they are forced to abandon their aspirations. The road does not end with the shutdown of their businesses.

Start-ups are often defined by their workforces, whose dedication and innovation lead to eventual success. However, failure remains a part of the journey. This begs the question -- what should be done by an entrepreneur upon the failure of their first start-up?

Here is some advice that can help. 1. Measure the critical factors

When entrepreneurs fail to sustain their first start-up, the first thing they must to do is to go back to the drawing board.

They need to analyse every minute detail that led to the breakdown. Based on the findings of the analysis, entrepreneurs need to tweak their approach and address critical issues. For example, a multinational American company offering homestay services almost failed before it was relaunched by its founder following meticulous analysis of certain critical factors. Presently, the company operates in over 190 countries around the world.

Additionally, entrepreneurs also need to prioritise their mental well-being at this point. Sustaining a resilient mindset during trying times like these shapes entrepreneurs for the long run, enabling them to make sound decisions that lead them to establish potential uni-

2. Survey market demand

One of the primary contributing factors behind the premature shutdown of first-time start-ups is a limited understanding of market sentiments and demands.

Founders need to gather valuable data through surveys/interactions with prospective

customers, industry professionals and other relevant stakeholders to establish a feedback loop. They can thus identify demand gaps which will help them to evolve their products/services accordingly.

3. Repurpose the analysis

Upon completion of the in-depth analysis and customer surveys, they need to determine their next course of action. Usually, there are two ways forward from

this point. The first is to use the analysis to relaunch the old start-up while the other is to launch a new entity using the new data and ideas that address the old problems. Founders who decide to re-launch their old

start-ups often opt for a complete rebranding keeping in mind the challenges they faced the first time. This allows them to keep in touch with their prior consumer community with renewed promises and strategies.

Entrepreneurs opting to launch a new entity must keep a keen eye on addressing the challenges faced in the past.

However, the experience from the initial venture is often integrated within the second organisation, which may operate in a different industry but can, because of the founder's past experience, offer significant advantages over peers and competitors.

4. Build a stronger team

A competent founding team is vital for startups at any stage. Highly qualified, capable founding team members, working passionately towards a shared goal often become the deciding factor for start-ups.

Entrepreneurs need to focus on building a strong team for their next venture to ensure its

This team also needs to be versatile so that it can identify opportunities and risks well before time to avert crises that might lead to fail-

5. Craft a robust marketing strategy Entrepreneurs who have failed their first-

time start-ups need to focus on creating a robust marketing strategy for their second term. Marketing strategies help businesses create meaningful interactions with prospective clients and drive growth.

Statistically, more than half of the start-ups (56.9 per cent) employ a full-fledged marketing team while 20 per cent rely on a single individual to spearhead the marketing initiatives. This highlights the importance of marketing

strategies for start-ups as they can create a unique selling point that helps the brand to stand out.

6. Focus on technological upgrades

The development of new-age technologies such as artificial intelligence has changed how customers are served and how organisations

For example, many companies provided after-sale customer care services to big corporations but after AI chatbots were introduced, organisations used them to automate customer service.

Several companies that decided to continue manually interacting with customers were forced to shut down soon after because of the lack of agility when it came to integrating technological upgrades in their business mod-

7. Proactive networking Aspiring entrepreneurs need to initiate and

maintain a productive relationship with prospective investors, industry veterans and other stakeholders. This approach leads to numerous benefits,

such as brainstorming ideas, ensuring critical funding, industry insights and valuable advice. Furthermore, robust networking also translates into a community that will support you and help you grow.

While the popular narrative suggests otherwise, failing start-ups are more common than unicorns -- which has been proved by statistics numerous times.

For example, while India boasted of at least 1.24 lakh start-ups in April 2024, only 114 of them were unicorns.

Entrepreneurs need to understand that failing their first start-up is not necessarily be the end of the line of their entrepreneurial journey.

men in southwestern Pakistan killed at least 31 people in two separate attacks on Monday, with reports of other shootings and unrest across the same province, police and officials said.

Twenty-three people were fatally shot after being identified and taken from buses, vehicles and trucks in Musakhail, a district in Baluchistan province, senior police official Avub Achakzai said. The attackers burned at least 10 vehicles before fleeing.

In a separate attack, gunmen killed at least nine people, including four police officers and five passersby, in Qalat district also in Baluchistan, author-

Insurgents blew up a railway track in Bolan, attacked a police station in Mastung and attacked and burned vehicles in Gwadar, all districts in Baluchistan. No casualties were reported in those attacks.

Sved Muhammad Ali, an

analyst, said the latest killings of non-Baluch people are an attempt by separatists to harm the province economically.

Ali told The Associated Press that most such attacks are carried out with the aim to economically weaken Baluchistan, noting that "the weakening of Baluchistan means the weakening of Pakistan."

He said insurgent attacks could hamper development work being done in the

Separatists in Baluchistan have often killed workers and others from the country's eastern Punjab region as part of a campaign to force them to leave the province, which for years has experienced a low-level insurgency.

Most such previous killings have been blamed on the outlawed group and others demanding independence from the central government in Islamabad. Islamic militants also have a presence in the province.

Russia unleashes a massive drone and missile attack on Ukraine; At least 3 people are killed

KYIV, Aug 26: Russia unleashed a massive drone and missile barrage throughout Ukraine on Monday, targeting energy infrastructure. At least three people were reported killed, and power cuts were reported across the

The barrage began around midnight and continued beyond daybreak in what appeared to be Russia's biggest attack against Ukraine in weeks.

Russian forces fired drones, cruise missiles and hypersonic ballistic Kinzhal missiles at 15 Ukrainian regions — more than half the country, Ukraine's Prime Minister Denys Shmyhal said Monday morning.

"The energy infrastructure has once again become the target of Russian terrorists. Unfortunately, there is damage in a number of regions," Shmyhal said, adding that Ukraine's state-owned power grid operator, Ukrenergo, has been forced to implement emergency power cuts to stabilize the system.

He called on Ukraine's allies to provide Kyiv with long-range weapons and permission to use them on targets inside Russia.

"In order to stop the barbaric shelling of Ukrainian cities, it is necessary to destroy the place from which the Russian missiles are launched," Shmyhal said. "We count on the support of our allies and will definitely make Russia pay.

According to Ukraine's air force, there were multiple groups of Russian drones moving toward eastern, northern, southern, and central regions of Ukraine, followed by multiple cruise and ballistic missiles.

Explosions were heard in the capital, Kyiv. Power and water supplies in the city have been disrupted by the attack, Kyiv Mayor Vitali Klitschko said.

At least three people were killed — one in the western city of Lutsk, one in the central Dnipropetrovsk region and one in the partially occupied Zaporizhzhia region in the southeast, according to local officials. Thirteen others were wounded — one in the Kyiv region that surrounds the Ukrainian capital, five in Lutsk.

Such points were first opened in Ukraine in the fall of 2022, when Russia targeted the country's energy infrastructure with weekly barrages.

In neighboring Poland, the military said Polish and NATO air defenses were activated in the eastern part of the country as a result of the attack.

Greek-flagged tanker is burning after Houthi attacks, but no sign of oil spill

DUBAI, Aug 26: A Greekflagged tanker repeatedly attacked by Yemen's Houthi rebels in the Red Sea remains ablaze but hasn't sprung a major oil leak in the waterway, a European Union naval command said on Monday.

The attack on the Sounion marks the most serious assault in weeks by the rebels, who continue to target shipping through the Red Sea corridor over the Israel-Hamas war in the Gaza Strip.

The attacks have disrupted the \$1 trillion in trade that typically passes through the region, as well as halting some aid shipments to conflict-ravaged Sudan and

Images published by the EU's Operation Aspides, whose mission is to protect shipping in the area, showed smoke rising from multiple points along Sounion's deck and its bridge

Fires could be seen burning in at least nine different locations on the deck of the vessel, which had been loaded with 150,000 tons of Iraqi crude oil — roughly 1 million barrels. Some flames appeared near hatches of the



"So far there are no obvious signs of an oil spill," the EU mission said. The Sounion "is both a navigational and an imminent environmental hazard. This situation underlines that these kinds of attacks pose not only a threat against the freedom of navigation but also to the lives of seafarers, the environment, and subsequently the life of all citizens liv-

ing in that region.' The U.S. State Department similarly warned about the ecological danger to the Red Sea, home to coral reefs and other natural habitats and wildlife. Footage showing explosions on board the Sounion released earlier by the Houthis and later analyzed by The Associated Press suggested that

the rebels again boarded an abandoned vessel and rigged it with explosives in an attempt to sink it.

"While the crew has been evacuated, the Houthis appear determined to sink the ship and its cargo into the sea," State Department spokesperson Matthew Miller said in a statement Satur-

"Through these attacks, the Houthis have made clear they are willing to destroy the fishing industry and regional ecosystems that Yemenis and other communities in the region rely on for their livelihoods, just as they have undermined the delivery of vital humanitarian aid to the region through their reckless attacks."

Masirah satellite news channel highlighted the EU's photographs and described the Sounion as being targeted for "punishment to the company that owns the ship for violating the decision to ban access to the ports" of Israel.

The Sounion came under repeated attack last week by the Houthis. A French destroyer operating as part of Operation Aspides later rescued the Sounion's crew of 25 Filipinos and Russians, as well as four private security personnel, and took them to nearby Diibouti. The Houthis have targeted

more than 80 vessels with missiles and drones since the war in Gaza started in October. They seized one vessel and sank two in the campaign that also killed four sailors. Other missiles and drones have either been intercepted by a U.S.-led coalition in the Red Sea or failed to reach their targets.

The rebels maintain that they target ships linked to Israel, the U.S. or the U.K. to force an end to Israel's campaign against Hamas in Gaza. However, many of the ships attacked have little or no connection to the conflict, including some bound for Iran. (AP)

North Korea shows new drone attacking a target as Seoul and US hold large military exercises

The North's official Korean Central News Agency said Saturday's test involved various types of drones built to fly different ranges to attack enemy targets on land and sea and flew along various routes before accurately hitting test targets.

Bangabandhu to toppled statue Mujibur Rahman's contested legacy post B'desh upheaval



DHAKA, Aug 26: When a uprising in Bangladesh brought down the Sheikh Hasina-led government, college student Alif Hossain felt the deposed prime minister got what she deserved, but the toppling of the Dhaka statue of Sheikh Mujibur Rahman by protesters on August 5 left him deeply dis-

"It was just wrong. He fought for the liberation of our country, he is the Father of the Nation, our Bangabandhu, how could he be so disgraced in the fit of anger," the Dhakabased student rued.

The legacy of Rahman or Mujib, as he was popularly called, lives on in the names of streets, institutions, public landmarks, his fiery speeches made during the struggle for independence, the face of Bangladeshi currency, and till recently in statues and murals.

The unprecedented protests precipitated the fall of the previous government as Hasina fled to India on August 5 leaving behind a country in political turmoil.

In the wake of her departure, she courted even more public opprobrium, and her father's legacy too became a prime target as anti-government protesters vented their ire

on Rahman's towering statue at Bijoy Sarani in the heart of Dhaka and pulled it down, with images being broadcast on local and international media channels. Public murals depicting

Bangabandhu ('Friend of Bengal') -- a sobriquet that characterised the legacy of Bangladesh's first president -were defaced, and his house in Dhanmondi where he and most of his family members were assassinated on August 15, 1975 and which was later turned into a memorial, was

badly damaged by protesters. In the Dhaka University area, a series of wall panels on the front side of the building of the famous Teacher Student Centre (TSC) bears old mosaic panels depicting legendary personalities and historic moments like the signing of the Instrument of Surrender of Pakistani forces in Dhaka on December 16, 1971, which led to the birth of the new nation of Bangladesh.

KBPF against partial upliftment of ban

Long-term consequences awaits

GUWAHATI, Aug 26: The Kohima Baptist Pastors' Fellowship (KBPF) slammed the state government over the partial lifting of the Nagaland Liquor Total Prohibition (NLTP) Act, 1989.

KBPF stressed that the NLTP Act has protected the people of the State since its official enactment.

The law brought in 1989 by the Nagaland Legislative Assembly, was the result of vigorous prayers and significant efforts by believers, including mass protests and public rallies led by the NBCC and Naga Mothers' Association (NMA), among other civil societies.

However, the recent decision by the Cabinet to re-analyse the law and partially lift it has left the KBPF deeply concerned as they expressed strong opposition against the decision. The fellowship suggested that the upliftment is a violation of God's precepts and a dangerous step backwards.

They further mentioned that alcohol abuse leads to a plethora of problems, ranging from health complications to moral and spiritual degradation to family and domestic violations.

The Neiphiu Rio-led government predicts that the partial upliftment will boost the State's revenue through increased sales and tax. However, the Fellowship maintained on their argument by stating that the short-term gains will only lead to severe long-term losses.

They argued that the NLTP Act has not failed but rather that its implementation has been lacking. The Fellowship urged the government to strictly enforce the Act through proper consultation, rather than relaxing it for revenue purposes.

The KBPF affirmed its position with the NBCC against the proposed partial lifting of the Act and called upon all believers and responsible citizens

The story of Panna's death being circulated is entirely fabricated. Any attempt at illegal infiltration or activities that compromise the security of our nation will be dealt with firmly.'

The BSF increased vigil along the border following the August 5 violence in Bangladesh, successfully thwarting several illegal entry attempts and arresting those

The BSF has contacted the assistant high commission of Bangladesh in Assam regarding the matter. "The assistant high of Bngladeshhas confirmed that they have not received any official information concerning Panna's death near the border area as of now," the BSF spokesperson added.

Local sources in Dawki, including villagers, have denied the claims of Panna's death while climbing a hill in Meghalaya.

An elder from Dawki said, "If a Bangladeshi tried to enter India, our relatives from across the border would have informed us, and we would relay the information to the BSF and police. There is no such incident, and several attempts by Bangladeshi nationals to cross the border have been thwarted."

Another source at the border claimed that Panna died around 400 metres away from the international border, well within Bangladeshi territory.

The source added that Panna was travelling with few people he trusted and had come close to the Bangladesh border when he was attacked. (PTI)

HPC appeals for extension



SHILLONG, Aug 26: The Harijan Panchayat Committee (HPC) today appealed to the Meghalaya state government for an extension of the time to respond to the blueprint for the relocation of 342 families from Them Iew Mawlong in Shillong. This came after the 15 days' time granted by the state government to the HPC for communicating its final decision on the proposal has expired on Monday.

In a statement, HPC Secretary Gurjit Singh said that following a recent meeting where the deputy Chief minister suggested that the committee convey its final decision within two weeks, the Harijan Panchayat Committee has emphasized that the short period is insufficient for them to consult with the highest authorities of the Sikh community.

"We intend to seek the counsel of the Jathedar of Sri Akal Takht Sahib, the Shiromani Gurdwara Prabandhak Committee in Amritsar, the Delhi

Sikh Gurdwara Management Committee, and other senior community organizations and leaders. Their guidance is crucial," Singh said.

"Given the current engagements and prior commitments of the Sikh religious leadership, they have indicated that they will not be available for consultations for the next two to three weeks." The letter suggested that in light of

these circumstances, the Harijan Panchayat Committee earnestly requested that the next meeting on this issue be scheduled around the last week of September. The committee is hopeful that by that time, they will be able to present a well-considered response that reflects the consensus of the broader community.

The Harijan Panchayat Committee has politely sought the cooperation of the Government of Meghalaya in this matter of great importance, Singh stated. (NNN)

Tripura requests for Inter-Ministerial Central Team



HT Correspondent AGARTALA, Aug 26: The Tripura government has formally requested the Government of India to dispatch an advance Inter-Ministerial Central Team to assess the damage caused by the recent floods. This team will assist the state in preparing a detailed memorandum to seek additional support for restoration efforts

The flood situation in Tripura has shown signs of improvement, with a significant reduction in the number of people living in relief camps. At the peak of the crisis, around 1.2 lakh individuals were displaced and sheltered across 471 camps; currently, the number has dropped to 70,000.

According to the Relief, Rehabilitation & Disaster Management Department, rainfall has been lighter over the past three days, with the highest recent rainfall recorded at 38 mm in Panisagar over the last 24 hours. However, the water level in the Gomati River at Sonamura remains above the danger mark. "The situation is under constant monitoring at the highest level.

The state has sought an advance Inter-Ministerial Central Team for on-ground damage assessment to facilitate the submission of a formal memorandum to the Centre, requesting additional aid for restoration," stated an official report. Relief operations are ongoing, with three teams from the State

tional Disaster Response Force (NDRF) actively working in Gomati and Sepahijala districts. Around 500 Civil Defense and Aapda Mitra volunteers are also aiding in relief efforts. The district administration is operating 471 relief camps, providing shelter, food, drinking water, and medical assistance to over

Disaster Response Force (SDRF) and five teams from the Na-

70,000 displaced residents. Additionally, clothing has been distributed to 150 people in the Amarpur of Karbook Sub-Division. The floods have claimed 26 lives, left two individuals injured, and one person remains missing. Preliminary assessments suggest significant damage to infrastructure, including roads, buildings, power lines, embankments, agricultural crops, homes, and live-

District Disaster Management Authorities, led by respective District Magistrates and Collectors, have been tasked with conducting a comprehensive assessment of the damages. The assessment work is already underway.

The state government remains committed to working closely with central agencies to mitigate the disaster's impact on its citizens. Meanwhile, the Indian Meteorological Department (IMD) has issued a yellow alert, warning of heavy rainfall in some parts of South Tripura over the next two days.

NEW DELHI/JAMMU, Aug 26: The BJP on Monday named 16 candidates for the first phase of elections to the 90-member Jammu and Kashmir Assembly to be held on September 18.

The party had earlier released its first list of 44 candidates but put out a revised one a few hours later, withdrawing names for the second and third phases, amid disgruntlement among a section of party cadre over a few names in the original list.

While Jammu and Kashmir BJP president Ravinder Raina downplayed the resentment over the initial list, a group of party workers held a protest at its headquarters in Jammu and claimed "parachute candidates" were picked over hardworking workers.

The list of 16 candidates for the first phase includes three former MLAs and a woman candidate, Shagun Parihar, whose father Ajeet Parihar and uncle Anil Parihar were gunned down by terrorists in Kishtwar district in November 2018. The Parihar brothers were affiliated with the BJP.

The initial list covered 36 segments in the Jammu region and eight in the Kashmir Valley. It included nearly a dozen prominent leaders, including several former ministers who have joined the party in the last five years.

CBI names RG Kar Hospital ex-principal Sandip Ghosh in corruption FIR, slaps non-bailable sections

KOLKATA, Aug 26: The Central Bureau of Investigation (CBI) has named Sandip Ghosh, former principal of RG Kar Medical College and Hospital, in the FIR the agency has filed in connection with its probe into the alleged financial irregularities at the institution during his tenure.

The agency has slapped Section 120B of IPC (criminal conspiracy) read with Section 420 IPC (cheating and dishonesty) and Section 7 of Prevention of Corruption Act, 1988 (amended in 2018) which covers unlawful acceptance of gratification by a public servant.

The cases read together account for cognisable offences and are non-bailable in nature, a senior Calcutta High Court lawyer said.

Besides Ghosh, the CBI has also registered cases against one M/s Ma Tara Traders of Madhya Jorehat, Banipur, Howrah, M/s Eshan Cafe of 4/1, H/1, JK Ghosh Road, Belgachhia, Kolkata and one M/s Khama Louha. The FIR was lodged on the basis of a written complaint lodged by Debal Kumar Ghosh, special secretary to the state health department. PTI retains a copy of the FIR.

The FIR was lodged on Saturday after the CBI took over the

probe from a state-constituted Special Investigation Team (SIT) following directions of the Calcutta High Court which the West Bengal government had initially formed following the alleged rape and murder of a woman medic on Au-

The order was issued on a petition by former deputy superintendent of RG Kar Hospital, Akhtar Ali, who requested a probe by the Enforcement Directorate (ED) into alleged financial misconduct at the institution.

Ali had moved the high court after fervent speculations in the public domain on whether the alwere pressured to pay amounts ranging between Rs 5 and 8 lakh to pass exams. Ghosh served as principal of RG

Kar Hospital from February 2021 to September 2023. He was transferred from the medical establishment in October that year but inexplicably returned to that position within a month. He held his position at the hospital till the day the doctor was found murdered.

Ghosh, who was removed from his chair at RG Kar Hospital after the crime came to light and reinstated in the same position at the Calcutta National Medical College and Hospital within hours by the Mamata Banerjee government, has subsequently been asked to go on an indefinite leave in the wake of massive resistance from CNMC students and pending the corruption inquiry. The CBI on Sunday conducted a day-long search operation at Ghosh's Beliaghata residence in Kolkata in connection with the corruption cases.

Ghosh has also been examined by the agency for 10 days at a stretch and it was conducting a polygraph test on him on Mondav in connection with the rape and murder probe. (PTI)

25 Naxalites, surrender in Bijapur



BIJAPUR, Aug 26: Twenty-five Naxalites, five of them carrying a cumulative bounty of ₹ 28 lakh on their heads, surrendered in Bijapur district in Chhattisgarh on Monday, a senior police official said.

The 25 ultras, who were active in Gangloor and Bhairamgarh area committees of the outlawed Communist Party of India (Maoist), include two women, the official added. "The two women, Shambati Madkam (23) and Jyoti Punem (27), and Mahesh Telam were active in company no. 2 of the Maoists and carried rewards of ₹ 8 lakh each on their heads. Madkam was active in the movement since 2012 and was allegedly involved in the 2020 Minpa ambush in Sukma in which 17 personnel lost their lives. She was also involved in the Tekalgudem (Bijapur) attack in which 22 security personnel were killed in 2021," said Bijapur Superintendent of Police Jitendra Kumar Yadav. "Punem and Telam were allegedly involved in an encounter in Pidia village in Bijapur in May this year in which 12 Naxalites were gunned down. Vishnu Kartam alias Monu (29), section deputy commander of platoon no. 16 'B', and Jaidev Podiam (18), Mirtur LOS (local organization squad) PLGA member, were carrying rewards of ₹ 3 lakh and ₹ 1 lakh, respectively," the SP in-

formed. Two others who surrendered, Guddu Kakem (20) and Sudru Punem (32), were carrying rewards of ₹ 10,000 each on their heads, the official added. They surrendered citing disappointment with the hollow Maoist ideology and atrocities on tribal by leaders of the outlawed movement, he said, adding those who laid down down arms were provided assistance of ₹ 25,000 each and will be further rehabilitated as per the government's policy. "With this surrender, 170 Naxalites have so far quit violence in the district this year. Besides, 346 Maoists have been arrested in the district during the same period," the SP said. (PTI)

3.95 lakh cusecs water discharged into Narmada river

BHARUCH, Aug 26: As many as 280 people were shifted to safer places from the low-lying area in Gujarat's Bharuch city after nearly 4 lakh cusecs water was released into the Narmada river from Sardar Sarovar Dam, officials said on Mon-

Following a huge inflow of water from Omkareshwar dam in Madhya Pradesh upstream of Narmada, the Sardar Sarovar's water storage on Monday touched a height of 135.20 meters, just 3.48 meters less than its full capacity of 138.68 meters, a release by the state government stated.

The dam, situated near Kevadia in Narmada district, is receiving 3.68 lakh cusecs (cubic feet per second) water and 3.95 lakh cusecs were released in the river, it said.

Of 30 gates of the dam, 15 were opened on Sunday night, and eight have been opened since morning. At present, these 23 gates are open up to the height of 2.2 meters to allow discharge of 3.95 lakh cusecs water directly into the river, the release stated. With such a huge discharge coupled with incessant rains, the Narmada river is now flowing just below the danger level of 24 feet near Bharuch town, prompting the authorities to shift 280 people living in low-lying areas, Bharuch collector Tushar Sumera said. Tractor-trolley swept away in flooded river amid rain; 10 rescued, 7 missing

MORBI, Aug 26: A search operation by NDRF is underway in Gujarat's Morbi district to trace seven persons swept away along with their tractor trolley while crossing a flooded causeway on a river amid heavy rains, an official said on Monday.

Ten out of 17 persons on board the tractor-trolley were rescued in an overnight operation near Dhavana village.

"The tractor-trolley carrying 17 persons swept away when it was passing through a causeway (over a river) near Dhavana village in Halvad taluka of Morbi district at around 9 pm on Sunday. Ten persons were rescued while seven others are missing," said Morbi fire officer Devendrasinh Jadeja.

State Disaster Response Force (SDRF) and National Disaster Response Force (NDRF) personnel are conducting a search operation,

Several parts of Gujarat were battered by heavy to very heavy rains in the last 24 hours till 6 AM on Monday, forcing authorities to shift hundreds of people to safe places after low-lying areas in Navsari and Valsad districts were inundated due to a rise in the water level of monsoon rivers.

At 356 mm, Khergam taluka in Navsari district recorded the highest rainfall in the last 24 hours ending 6 AM on Monday, the State Emergency Operation Centre (SEOC) data showed. During this period, Dang-Ahwa taluka of the Dangs district received 268 mm of rainfall and Kaprada (Valsad district) 263 mm.

Parts of Narmada, Sirendranagar, Rajkot, Tapi, Mahisagarand Morbi. Dahod and Vadodara were among other districts that received over 100 mm of rainfall.

Chief Minister Bhupendra Patel spoke over the phone to collectors of Morbi, Kutch, Rajkot, Surendranagar and Bhavnagar districts of the Saurashtra region, and Bharuch and Dang districts in south Gujarat late Sunday to review the situation.

Patel instructed the collectors to remain alert and ensure the safety of people and their livestock by constantly monitoring the rainfall situation, the Chief Minister's Office (CMO) stated.

Amid forecasts for more rains in the state, Chief Secretary Raj Kumar chaired a review meeting on Sunday evening.

The India Meteorological Department has predicted heavy to very heavy rains in Gujarat over the next week.

"Based on this (forecast), the Chief Secretary instructed the various district administrations to make all necessary preparations. He instructed the officers and employees of the district and taluka administrative system to be present on duty at the headquarters considering the prevailing rain situation,"

stated an official release. The chief secretary said the administrations should remain especially vigilant in places where people are likely to gather in large numbers considering the upcoming festivals during Shravan month to avert any rain-related tragedy.

Local administration should also ensure that roads closed due to flooding are restored immediately and electricity supply is not disrupted for long. With the current spell of rains, districts in south Gujarat have received over 105 per cent of the average annual rainfall so far, the highest in the state.

Eight districts of south Gujarat

HARIDWAR, Aug 26: A man suspected of being involved in illegal cow slaughter drowned in a pond after he jumped into it while trying to run away from the po-

The incident happened in Madhopur area near Roorkee late on Saturday night, Haridwar's Senior Superintendent of Police Pramendra Dobhal said on Monday.

The Cattle Protection Squad (CPS) of the local police was patrolling in Madhopur area after receiving information that some people in the village were involved in cow slaughter. The CPS saw a man coming on a scooty. As it tried to stop him, the man named Wasim alias Monu left his scooty and ran away. While trying to escape, he jumped into the pond, the SSP said. A search was launched but he could not be found as it was dark.

The body of Wasim was recovered from the pond on Sunday morning. A crowd of locals gathered at the spot and clashed with the CPS in protest refusing to hand over the body to the police for a post mortem. The crowd alleged that the man was beaten up and pushed into the pond by the

The police had to finally chase

away the crowd to take the body into custody for autopsy. Wasim's body was handed over to his family after autopsy, the SSP said. On the basis of a complaint lodged by the CPS, a case was lodged against one Alauddin and 100-150 other unidentified persons under sections 190, 191(2), 189(5), 132, 115(2), 352, 351(3), 238, 126(2) and 121(1) of the BNS and section 5/11 of the Cattle Protection Act for rioting and preventing public servants from performing their official duty, the SSP said. (PTI)

CBI conducts second round of polygraph tests on RG Kar hospital ex-principal, others

KOLKATA, Aug 26: The CBI on Monday started a second round of polygraph tests on former RG Kar Medical College and Hospital (RGKMCH) principal Sandip Ghosh and five others as part of their investigation into the rapemurder of a woman doctor at the

According to an officer, over the last 10 days, Ghosh provided inconsistent answers during questioning, prompting officers to conduct another round of polygraph tests.

The CBI initially conducted the lie-detection tests on Ghosh and five others on Saturday, followed by a test on arrested accused Sanjay Roy at the Presidency Correc-

tional Home on Sunday. Additionally, Ghosh and former medical superintendent and viceprincipal Sanjay Vashisth are also being investigated for alleged financial irregularities within the institute. The case centres on the rape-murder of a postgraduate trainee woman doctor in the seminar hall of the hospital on August 9. A civic volunteer was arrested in connection with the crime the next day. The gruesome crime resulted in nationwide protests by doctors

and citizens.

On Sunday, the CBI searched Ghosh's and Vashisth's homes, with Ghosh presenting files and documents at the central agency's office in Salt Lake on Monday morning. Vashisth appeared at Nizam Palace, where a forensic medicine department professor was also questioned. The agency also searched 13 other locations in Kolkata, including residences and offices of people involved in patient care and management supplies connected to the hospital. "After vesterday's search operations, we have several questions

for them," the officer told PTI.

This action follows a complaint by Akhtar Ali, former deputy superintendent of RGKMCH, alleging that Ghosh and his associates issued issued tenders for the construction of food stalls, cafes, canteens, and urinals without the permission of the health department and the college council.

Initial probe revealed that three traders got these "illegal" tenders, the officer said. The CBI started the investigations into both the murder and the alleged financial irregularities on the direction of the Calcutta High Court. (PTI)

9 prison officials, including chief superintendent suspended

BENGALURU, Aug 26: Nine prison officials, including Chief Jail Superintendent V Seshumurthy and Jail Superintendent Mallikarjun Swamy were suspended on Monday for allegedly giving special treatment to Kannada actor Darshan Thoogudeepa, who is currently in judicial custody in the Renukaswamy murder case.

The action came a day after an inquiry was conducted after a photo of the actor smoking with a coffee mug in hand in the Central Jail at Parappana Agrahara in the city emerged on social media on Sunday sparking a row. The picture shows Darshan sit-

ting leisurely on a lawn on the jail premises along with three others, including two alleged rowdysheeters. Others who have been suspended are jailers Sharan Basappa Amingad and Prabhu S Khandelwal, assistant jailers L S Kuppeswamy, Srikanth Talwar, head warders Venkappa, Sampath Kumar and warder K Basappa, Karnataka Home Minister G Parameshwara told reporters here on Monday. "Already seven officers have been suspended. After gathering more information after visiting the place, the Chief Jail Superintendent Sheshumurthy and

Swamy have been suspended as it was a lapse on their part," the Minister said. He added that if more officers are found involved in this case then they could be either suspended or dismissed from the serv-

The investigation will also follow to find out who provided cigarette, tea and chairs to the actor, he added. "Three FIRs have been registered against him (Darshan) since he has violated the prison manuals. Action will be started against him," Parameshwara said.

He said he has given instruction to carry out further investigation. Senior IPS officials will carry out further investigation. Action will follow based on the report, he added. To a question. Parameshwara said presently discussions are on regarding shifting Darshan.

The Additional Director General of Police (Prisons and Correctional Services) Malini Krishnamoorthy said the three FIR pertains to the usage of mobile phones and cigarette on the jail premises and smuggling these items inside the jail. "Darshan is a party in it. The FIR includes the prison officers and those who used these items as accused. A senior IPS officer will investigate it," Krishnamoorthy told reporters.

Asked whether it requires an incident like this to "wake up," she said: "We have been monitoring but when we have black sheep it becomes difficult to keep a track. That's the reason we are insisting on CCTV cameras. We are also mulling over using artificial intelligence and purchasing it (de-

According to her, the preliminary inquiry suggested that the incident happened on August 22 evening. "We did not have any information about any such incident. If we knew it then we would have taken action. There was a lapse in monitoring the CCTV footage," Krishnamoorthy said.

Noting that the Prisons department is committed to enforce the jail manuals, she said the government has taken this incident seriously. Meanwhile, addressing media in Belagavi, Chief Minister Siddaramaiah admitted that there was a lapse on the part of Prison officials.

"There has been a lapse on the part of the officers concerned. We have already suspended seven officers. A few more will also be suspended. I have told the Home Minister G Parameshwara to visit the place and remove those who facilitated," the CM said. (PTI)

More body parts recovered from landslide-hit Wayanad

WAYANAD (KERALA), Aug 26: Five more human body parts were recovered from the landslide-hit areas of Wayanad during a search mission carried out in the hilly district on Monday, district authorities said.

As many as six body parts were

recovered in the search, and of these five were confirmed to be those of human beings during a postmortem conducted at the taluk hospital in Sultan Bathery, they said. All the recovered body parts are now kept at the hospital mortuary. So far, 231 bodies and 217 body parts were recovered during the search mission conducted in the disaster-hit areas. Of this, 176 identified bodies have been handed over to relatives of the deceased. As per the government directive,

55 dead bodies and 203 body parts were buried at a public graveyard in Puthumala. Thirty more bodies were identified through DNA examination, the statement added.

Meanwhile, Meppadi Higher Secondary School, where hundreds of survivors were accommodated for days after the devastating landslide hit the hamlets of Wayanad on July 30, will be reopened on Tuesday, authorities added. (PTI)

IMD warns of intense rains in Madhya Pradesh, Rajasthan, Gujarat, Maharashtra

NEW DELHI, Aug 26: A depression over northwest Madhya Pradesh and adjoining east Rajasthan has intensified into a deep depression, the India Meteorological Department said on Monday and warned of heavy to extremely heavy rainfall in parts of the two states and Gujarat, Goa and Maharashtra over the next two to three days. At 11:30 pm on August 25, the deep depres-

sion lay centred near 70 km south-southeast of Chittorgarh, Rajasthan. This system is expected to move west-southwest, affecting South Rajasthan, and Gujarat, and reaching Saurashtra, Kutch, and parts of Pakistan by August 29, the IMD said in an update issued at 2 am. The weather department said another low-

pressure area is located over Bangladesh and

adjoining Gangetic West Bengal. It is likely to intensify further and move towards Gangetic West Bengal, north Odisha, and Jharkhand over the next two days. Issuing a red alert, the IMD said heavy to extremely heavy rainfall is expected in West Madhya Pradesh on August 26. Similar conditions are forecast for east and south Rajasthan, Gu-

jarat, Saurashtra and Kutch from August 26 to Konkan, Goa, Madhya Maharashtra, Odisha, Gangetic West Bengal, and Jharkhand are also expected to receive heavy to extremely heavy rainfall over the next two days.

The IMD has warned of strong winds reaching up to 50 kmph in Madhya Pradesh on Au-



gust 26 and up to 60 kmph in south Rajasthan on August 26-27.

In Gujarat, nearby Pakistan, north Maharashtra, and the northeast Arabian Sea, strong winds gusting up to 55 kmph are expected on August

26, increasing to 60 kmph on August 27 and 28. Rough to very rough sea conditions are anticipated off the coasts of Gujarat, Pakistan, and north Maharashtra until August 30. Rough seas are also expected in the North Bay of Bengal on

The IMD has advised fisherfolk to avoid venturing into the Arabian Sea and Bay of Bengal, especially around the coasts of Gujarat, Pakistan, and Maharashtra, until August 30. Small ships and exploration and production operators have been asked to monitor weather developments and take necessary precautions.

People are advised to avoid areas prone to waterlogging and check for traffic advisories before travelling. Farmers in the affected areas should ensure proper drainage in fields and provide support to crops, according to the IMD.

The IMD has also warned of potential localized flooding, road closures, and waterlogging, particularly in urban areas. There is a risk of landslides and damage to horticultural crops due to inundation in the affected regions. (PTI)

US-based doctor from Kolkata demands accountability over RG Kar medic's rape-murder

out ever feeling unsafe.

KOLKATA, Aug 26: A US-based doctor who has contributed immensely to India's polio elimination efforts and measles surveillance initiatives has criticised the brutal rape and murder of a doctor at RG Kar Medical College and Hospital and slammed the West Bengal government for failing to ensure safety of frontline health workers.

Speaking to PTI from Seattle, deputy director of the polio team at the Bill and Melinda Gates Foundation, Dr Ananda Sankar Bandyopadhyay, pointed out a significant lack of accountability, expressing deep shame and sadness over the violence inflicted on the woman medic.

Bandyopadhyay, who grew up in Kolkata and studied medical science at one of its premier colleges, said, I am infuriated, ashamed, and saddened. I have spent sleepless nights in shock and horror over what happened at RG Kar Hospital. My heart and soul are with Kolkata and those rising against this heinous crime against a female frontline health professional." A gold medalist from Calcutta National Medical College & Hospital (CNMC),

Bandyopadhyay recalled his time working there, saying he and his colleagues, including women health professionals, spent countless hours and nights in makeshift rooms with-

"I was born and raised in Kolkata. The city and its inclusive, forwardlooking culture shaped me. I never felt unsafe in Kolkata, and I believe this was true for my female class-

mates and colleagues, at least from

my perspective," he said. "I, along with my batch mates and colleagues -- many of whom were women -- worked round-the-clock in the hospital. This included spending nights in seminar rooms as we did not always have dedicated places to rest. But we never felt unsafe on the hospital premises," he added.

Reflecting on his days at CNMC, the global health professional criticised the administration for failing to ensure the safety of frontline health workers and pointed out a lack of accountability

"The inadequacy of safety for frontline health workers has long been an issue, with violent assaults occurring in the past. However, this incident surpasses all forms of barbarity. Equally glaring is the failure of authorities to prevent such a heinous crime within hospital premises. If we cannot protect those who save lives, especially women frontline professionals, we have failed as a society," he said.

Regarding the ongoing strike by junior doctors that has paralysed

healthcare services across West Bengal for the past 17 days, Bandyopadhyay expressed solidarity with them and hoped for a resolution soon. "No one understands the suffering of patients more than doctors, nurses, and paramedical staff. I stand in solidarity with those demanding safety and dignity at their workplace. I am saddened by the suffering of people and hope the situation improves soon," he stated. Asked whether he felt Kolkata was no longer safe for women, Ananda, as he is known among his peers, replied in negative. "I hope that is not the case. Even

though it may feel like we are in desperate times, let us not succumb to despair. The peaceful protests are a mark of courage and hope. We should contribute positively -through our behaviour at home, at work, by raising children with values of empathy, equity, and inclusion, and by speaking out against injustice. I hope this apparent decline is transient, and Kolkata will regain its status as a safe, vibrant, and lively

Regarding measures to address the issue, Bandyopadhyay called for accountability and transparency from law enforcement and health authorities to uncover the failures that allowed this crime to occur on hospital grounds. (PTI)

Parvathy on similarity between Irrfan Khan and Vikram: It's definitely the generosity

MUMBAI, Aug 26: Malayalam star Parvathy Thiruvothu on Monday said greatness is all about how people feel when you are around, and not about mere words, and that's something common between the late Irrfan Khan and her "Thangalaan" co-star Vikram. The actor, who is paired opposite Vikram's Thangalaan in the Tamil period drama, made her Hindi film debut with 2017's romcom "Qarib Qarib Singlle" in which she shared the screen with Irrfan. At the press event of "Thangalaan", Parvathy was asked whether there are any similarities between her two colleagues. "It's definitely the generosity I see in both of them. Irrfan used to help me out with things because Hindi is not my native language. He used to help me get into that space... "You are as good as the other person on set... I find that greatness comes from that saying about people who don't remember what you might have said or given them. It's about how you make them feel. That's the similarity in Irrfan sir and Vikram," she told

Parvathy, who plays Gangamma in the Pa Ranjith directorial, recalled how Vikram would make everyone's day on set when he would share 'kamarkattu', a traditional South Indian candy. "It's called kamarkattu. It has jaggery palm sugar... He'd just be walking around, he'd shake hands and suddenly you have a toffee in your hand. He just brightens the mood for everybody... I miss getting all the toffees," she added. Both on screen and off screen, Vikram was like a true leader, said the actor. "Everybody's like 'Have you eaten or not?' But (he would ask) genuinely. There's a concern about how everyone is doing. Our shooting location was very difficult. It was one of the harshest locations. It was all real locations that they shot in. He had everyone's back. In that sense, he was our Thangalaan. He was leading the pack." Set in the 19th century, "Thangalaan" is based on the real story of the Kolar Gold Fields (KGF) during its discovery by the British, who exploited and looted it for their own gain.

The film, which released in the South on August 15, is set to have a north India release with the Hindi version arriving in theatres on August 30. (PTI)

'THANGALAAN 'STAR VIKRAM **CALLS INCIDENTS OF CRIME AGAINST** WOMEN 'DISGUSTING'

MUMBAI, Aug 26: Women need to feel safe at any odd hours or place and the onus on men to give them their space, says South star Vikram, who termed the recent incidents of crime against women in the country

The 58-year-old actor's remarks come in the wake of the alleged rape and murder of a female doctor in Kolkata and the Justice Hema Committee report on women's exploitation in Malayalam cinema.

"All women need to feel protected. They should be able to walk the streets at 3.00 in the morning and feel they can walk, go home, and that nobody will do anything. That every man is there to protect them, to give them their space. It's disgusting what's happening, Vikram told PTI.

DUBAI, Aug 26: Musician Nabeel Khan says he is leaving no stone unturned in making his late grandfather and legendary sarangi maestro Ustad Sabri Khan's dream a reality: helping the sound of the Indian classical instrument sarangi reach every corner of the world.

Nabeel Khan, who belongs to a traditional family of Moradabad Sainia Gharana of sarangi players, performed at a spectacular candlelight concert here on Sunday. "My aim is to pursue my grandfather, the legendary sarangi maestro and Padma Bhushan awarded Ustad Sabri Khan Sahab's dream to spread Indian classical sarangi all over the world.

"I am trying my best to make it more famous and always try to show the people about the peaceful and soulful sound of sarangi and this is my belief that I will make this dream real," he told PTI after

The 25-year-old musician said he is happy promoting Indian classical music in the United Arab Emirates and other Gulf countries. "I am the first sarangi player who pioneered this instrument in this region, and I'm very happy at the way the audience are responding and loving my music here and in western countries as well," he added.

Nabeel Khan belongs to a gharana that traces its musical roots from Mian Tansen, the great vocalist in the court of Mughal emperor Akbar. Alongside education, he was soon initiated into the rare art of the instrument sarangi. Growing up in a family of great sarangi players, Nabeel Khan grasped the techniques of sarangi swiftly under the tutelage of his grandfather and

soon emerged as a sarangi prodigy. He started learning the stringed instrument at the age of seven from his grandfather. The Moradabad Sainia Gharana has produced many legendary sarangi players since the 15th century in India.

"I believe gharanas like mine are unique, but we have also evolved in a unique way. We have embraced the many benefits of the digital race, the technology that it has offered yet using them to only preserve our classical roots. This has been tremendously helpful in making our music and art accessible to more people across the planet," said Nabeel Khan, the eight generation sarangi artist in his family.

"Whenever I go abroad like to the United Kingdom or European countries, I find more international audience, but this is the nice thing about the UAE that you find different people from different countries and yes, it is their love towards our

Indian classical music, which is so beautiful, not from today since many years," he said, adding that he has grown up seeing international students from different coun-

"I used to see all the foreigners coming to my home and learn sarangi from my father Ustad Nasir Khan and my grandfather Ustad Sabri Khan. That's how I learnt how to teach sarangi, and we have more than 100 international students all over the world. That's why they learn and listen to our Indian classical music.

On the attention span challenge posed by social media, Nabeel Khan said gone are the days when people used to listen to two-

three hours of Indian classical music. Unfortunately, today that time is reduced to one hour, he added.

"There are even 30 minutes, 20 minutes, sometimes 40 minute-concerts. However, it is still better than listening to 30-second short videos. At the moment, people seem to be focusing more on social media reels and short videos. "However, there are some talented Indian classical musicians, especially youngsters who are performing great. So it is here to stay, and I am sure people will continue to enjoy live concerts of sarangi and Indian classical music.'

Prannoy takes break to recover from impact of chikungunya

NEW DELHI, Aug 26: Seasoned Indian shuttler HS Prannoy on Monday said he is taking a break from the sport to allow his body to fully recover from the effects of chikungunya, which had adversely impacted his performance at the Paris Olympics.

The 32-year-old, a 2022 Thomas Cup title winner and a world and Asian Games bronzemedallist, had been laid low by a week-long bout of the mosquito-borne viral disease that causes severe pain in the joints just ahead of the Paris

"Unfortunately, the battle with chikungunya has taken a toll on my body, leaving me with persistent pains that make it impossible to compete at my best," Prannoy wrote on X.

"After careful consideration with my team, I've decided to withdraw from some of the upcoming tournaments to focus on recovery. Thank you for your understanding and support during this challenging time. I'll be back stronger," he added.

Prannoy, however, did not provide a time line for his recovery or mentioned the tournaments he has withdrawn from.

The Kerala shutler, who won the world championship bronze in 2023, had been ravaged by a spate of illnesses, including a chronic stomach disorder and a nagging back injury

At the Paris Games, despite not being fully fit, Prannoy won both his Group matches to progress to the round of 16. He, however, went down to compatriot Lakshya Sen in the pre-quarterfinal. (PTI)

NEW YORK, Aug 26: Tennis fans unable to decide who has the best shot at doing well at the US Open have company as the year's last Grand Slam tournament is set to begin Monday.

Even the players themselves

aren't sure what to expect. "We've seen people, all the time, surprise us every single week, every single tournament, every Slam. Sometimes there's no rhyme or reason why someone maybe does well," said Jessica Pegula, a six-time major quarterfinalist. "Sometimes it doesn't make any sense."

There is the usual uncertainty that comes in New York, thanks to the vagaries of injuries and the grind of a long season. One additional factor this time could be all of the surface-switching: Tennis at the Summer Olympics was played on courts at Roland Garros, also the French Open site. So players went from clay in Paris to grass at Wimbledon, then back to clay, before shifting to hard courts before the U.S. Open.

"It's a strange year," British player Dan Evans said. "That's for sure." Pegula, for one, handled that last transition just fine, going from the Olympics to a title at Toronto and a runner-up showing at Cincinnati. Her doubles partner in Paris, 2023 U.S. Open champion Coco Gauff, played in three Olympics events, exiting early in each, then lost her second match in Toronto and her first in Cincin-

"Changing surfaces, it's tough, not just on your body, but mentally. ... But it's part of the job, and we'll adjust," said Tommy Paul, who won a bronze medal in doubles with Taylor Fritz for the U.S. in Paris and had a 1-2 record in Montreal and Cincinnati. "Maybe there's one player or two players that are burned out from the (Olympic) experience. But other than that, for the most part, everyone is pretty adjusted by now." The woman who defeated Pegula in the Cincinnati final, No. 2 Arvna Sabalenka, skipped the trip back to France for the 2024 Games but said she isn't all that convinced that having — or not having — normal preparation necessarily will dictate results the

"Everyone who came here, they think they are ready to win. I think it's not about who is ready. You can be ready better' than the rest of the group," said Sabalenka, a two-time champion at the Australian Open and runner-up to Gauff at last year's U.S. Open, "but at the end of the day, it's all about how hard are you ready to fight for it — especially on those days when you don't feel your

Another player not at the Frances Tiafoe, Olympics, reached the Cincinnati Open title match before losing to No. 1 Jannik Sinner, whose two positive steroids tests in March came to light less than a week ago.

Tiafoe, a 26-year-old from Maryland, finds the home crowds and high attention of the U.S. Open bring out his best, so he wanted to concentrate on getting ready for the site of his first Grand Slam semifinal in 2022. "It's open for a lot of guys this year, for sure. . It's always different in a Slam. The lights are a little brighter," he said. "We'll see what ends up happening. Personally, I just like

where I'm at." Then there are those such as defending U.S. Open champion Novak Djokovic, who won a gold medal at the Paris Games but didn't play a single hard-court tuneup event, or Carlos Alcaraz, the silver medalist whose only recent match on a hard court was a loss in Cincinnati.




