HT Bureau GUWAHATI, Sept 1: The Trinamool Congress suffered a major jolt on Sunday as its Assam unit chief Ripun Bora resigned from the primary membership of the party. Bora joined Mamata Banerjee's party two and half years ago and he led TMC in this year's Lok Sabha

polls in the state. However, for the last few days, it was speculated that Bora might return to the Congress party which he had left after losing Rajya Sabha polls.

Bora wrote a two-page resignation letter to Lok Sabha MP and Trinamool Congress general secretary Abhishek Banerjee where he has outlined the reason behind his abrupt departure from the party.

"Assam TMC has great potential, but several recurring issues have hindered our progress, including the perception of TMC as a regional party of West Bengal. To counter this perception, we made several suggestions, such as the



need for an Assamese leader at the national level, declaring the residence of Bharat Ratna Dr Bhupen Hazarika at Tollygunge as a heritage site, and converting the Madhupur Satra at Cooch Behar (the place from where Assam's greatest social reformer Mahapurush Sankar Dev started the Vaishnavite movement) into a cultural hub," he

# Assam tea workers' wages low, welfare scheme lacks implementation: CAG report

GUWAHATI, Sept 1: Wages of zones - Cachar, Dibrugarh, Natea garden workers in Assam are "meagre", with "several shortcomings and areas of concern" in implementation of labour laws and worker welfare provisions, a recent Comptroller and Auditor General (CAG) report has said.

It also found the state government's intervention in fixing wages as per the Minimum Wage Act (MW Act) "insufficient", noting that efforts to improve the lives of the workers have "fallen short" of making any substantial change.

The performance audit on 'Implementation of Schemes for Welfare of Tea Tribe' for the period 2015-16 to 2020-21 maintained gaon and Sonitpur. There are 390 tea estates in the four sampled zones, of which 40 estates (10 per cent) were selected based on the lowance. size of the plantations and number of workers employed.

Apart from scrutiny of records, the exercise included interviews of 590 workers in the selected estates. The report said the Tea Tribes Welfare Department (TTWD) tried to address the issues of the workers, but without basic socio-economic data, and their initiatives

were implemented "haphazardly". "The wages the workers received in the tea estates were meagre," the report said, pointing out tion" for it.

GST collections rise

10 pc to ₹ 1.75 lakh

NEW DELHI, Sept 1: Gross GST collections in August grew 10 per cent to about ₹ 1.75 lakh crore, reflecting higher domestic consumption

As per the government data released on Sunday, gross GST revenues from domestic transactions grew 9.2 per cent to about ₹ 1.25 lakh crore.

Revenues from import of goods were up 12.1 per cent to ₹ 49,976 crore.

In July, gross Goods and Services Tax (GST) mop-up was ₹ 1.82 lakh crore, while in August last year it was ₹ 1.59 lakh crore.

M S Mani, Partner, Deloitte India, said a 10 per cent increase in collections on a vear-to-month basis at the start of the festive season for the year indicates that consumption is robust and will only improve further in the coming festival months.

"This would give renewed confidence that the collection targets for the year would be achieved. There are some differences in the GST collection increases across major states which may need a deep dive," Mani said.

Refunds worth ₹ 24,460 crore

were issued during August, 2024, which is 38 per cent more than the refunds issued in the year-ago period

After adjusting refunds, net GST revenue increase was 6.5 per cent at ₹ 1.5 lakh crore during the month under review.

EY Tax Partner Saurabh Agarwal said the continued growth in gross GST collections indicate a robust economy

"The government's commitment to reduce working capital costs for businesses facing inverted duty structure is demonstrated by the higher domestic GST refunds. By rationalising rates, the government aims to address this issue over time," Agarwal said.

Mani further said the ability of large states like Maharashtra, Karnataka, UP, MP and Haryana to record double digit increases in collections once again indicates the robust consumption in these states accompanied by the tax authorities measures to improve compliance and crack down on evasion.

# 'It is a fact that loose tea consumption has been giving way to packet tea? Sluggish consumption growth, high food inflation areas of concern for tea industry: FAITTA chief

GUWAHATI, Sept 1: Sluggish growth in domestic consumption, rising food inflation and slow recovery of exports post the Covid pandemic are some of the challenges faced by the tea industry, a senior official said.

Tea producer associations and the Tea Board India have been concerned over the muted demand growth in the country, he said.

The remarks came from Sanjay Shah, chairman of the Federation of All India Tea Traders Association (FAITTA), during its 10th annual general meeting here on Saturday evening.

"As retailers within the FAITTA fold, we are witnessing the market movements from close quarters. It is a fact that loose tea consumption has been giving way to packet tea," Shah said. Rising levels of food inflation also remain a concern area, as it adversely impacts consumption, he said.

"Given that incomes do not ad-

"The situation in 2024 has significantly altered. Looking at north Indian combined leaf and dust tea rates, prices are almost 46 per cent higher than the corresponding levels last year," the FAITTA official said.

Shah said tea production in the calendar year 2023 closed at 1,393 million kg as against 1,366 million kg in 2022

On exports, he said after successive years of clocking over 250million kg levels, shipments sharply declined in 2020 and 2021. Exports registered some recovery in 2022, touching 231 million kg. In 2023, exports closed at 228 million kg

After many years of relative stagnation, Indian tea exports appear to be on a higher growth trajectory, Shah added. (PTI)

regional party operating from another state. Bora has also accepted this fact in his letter stating that people of Assam are not ready to accept a regional party from another state unless it gives immense effort in gaining the confidence of voters

Another source said the leadership was not happy with Bora, especially after the performance of TMC in Assam in the Lok Sabha polls. The TMC has contested from four Lok Sabha constituencies in Assam and secured only 0.37 per cent vote share.

It has been widely speculated that Bora will soon join the Congress party although he has not mentioned about his next move yet. But the former Rajya Sabha MP has already met with his supporters in his home constituency in Gohpur about possible shifting of political sides.

PTI adds from Delhi: Meanwhile, following Bora quitting the party on Sunday, party sources said its Rajya Sabha member Sushmita Dev will go to Guwahati soon to meet the state office bearers

"MP Sushmita Dev will be going to Guwahati in the next few days to meet TMC office bearers," a party source said after Bora's resignation.

The TMC has been keen on expanding its presence in the northeastern states. It got a boost recently when Meghalaya TMC chief Mukul Sangma became the leader of opposition in the state assembly.

of Guwahati faced a horrendous situation on August 5 as a spell of heavy rain left people stranded for 7-8 hours on their vehicles till midnight. School children were in their buses till 11 pm.

The Gauhati High Court had on August 7 said the time has come to deal with the problem of flooding in the state capital and the government is required to take steps to resolve the issue permanently.

The court asked the administration to submit a plan to mitigate the crisis.

The Housing and Urban Affairs Department, in its affidavit, told the high court that efforts were being initiated to tackle such situations in the city.

Stating that the Assam government was "not serious" in solving perennial waterlogging problems in the state capital, the Gauhati High Court had on June 26 come down heavily for not responding to its repeated notices and slapped a fine of ₹ 1,000 each to four departments concerned.

Chief Minister Himanta Biswa Sarma had on August 9 accused a private university in neighbouring Meghalaya of engaging in a "flood jihad" by demolishing hills on its campus to build new structures, which he claimed

# Assam tea workers' wages low,

government never intervening to address the issue. The report said that as per the 2019 wage rates, tea workers of Assam were being paid the least wages compared to other tea-producing states like Tamil Nadu, Kerala, Karnataka and West Bengal.

It noted that though wages to tea workers are paid partly in cash and partly in kind in Assam, the authorisation granted by the government for such an arrangement is not available on record.

"The Labour Department was also not aware about the year of commencement of payment of wages in kind and the purpose for the state," the report said.

The list of qualified items to be paid in kind was neither prescribed by the government nor was the system for calculating the cost of these items, it said, adding, the payment of wages in cash or in kind was "not in compliance with provisions" of the MW Act.

The CAG report also said the Assam Tea Employees Labour Welfare Board did not undertake any mandated welfare activities, and 85 per cent of the expenses borne for it during 2015-20 are related to administrative expenses.

During 2015-16 to 2020-21, the director, TTWD, had planned 187 welfare schemes with a budget of ₹ 600.19 crore, out of which actual implementation was carried out in only 82 schemes at a cost of ₹ 210.65 crore against the budget allotment of ₹ 365.60 crore, it said.

The budget speeches from 2015-16 to 2019-20 had mention of 25 schemes under the TTWD, out of which nine were not implemented due to non-receipt of funds.

The TTWD claimed that lack of adequate field staff was an issue resulting in shortcomings in the implementation of schemes, which was also observed by the auditors.

"However, such constraints were not new for the Department, rather these shortcomings persisted since the inception of the TTWD (1984) and should have been addressed long back," it said.



NEW DELHI, Sept 1: India's 21 major listed real estate developers have together sold properties worth nearly ₹ 35,000 crore during the latest June quarter with Godrej Properties reporting highest sale bookings.

Except few, all major listed real estate developers have shown annual growth in sale bookings in the April-June quarter driven by strong consumer demand for residential properties, especially of luxury homes.

According to the data compiled from regulatory filings, India's 21 major listed realty firms have reported combined sale bookings of ₹ 34.927.5 crore in the first quarter of 2024-25 fiscal.

Out of these combined sale bookings, bulk of pre-sales came from residential segment.

In terms of sale bookings, Godrej Properties emerged as the largest listed player in the June quarter with pre-sales of ₹ 8,637 crore.

DLF Ltd, the country's largest realty firm in terms of market capitalisation, reported more than three-fold jump in its sale bookings at ₹ 6,404 crore in the first quarter of this fiscal.

Mumbai-based Macrotech Developers, which sells properties under 'Lodha' brand, clocked presales of ₹ 4,030 crore.

Gurugram-based Signature Global, which recently got listed, achieved sale bookings of ₹ 3,120 crore in June quarter, more than three times from the year-ago period.

Bengaluru-based Prestige Estates Projects clocked sale bookings of



₹ 3,029.5 crore in June quarter, 376 crore. down from the corresponding pe-

riod of the previous year. Bengaluru-based firms Sobha Ltd and Brigade Enterprises sold properties worth ₹ 1,874 crore and ₹ 1,086 crore, respectively, during the April-June period of this fiscal. Bengaluru-based Puravankara

Ltd achieved sale bookings of Rs 1,128 crore, almost flat compared to the year-ago period. Mumbai-based Oberoi Realty,

Branded and reputed players, including listed and unlisted ones, have benefited most in this revival cycle as homebuyers do not want to take risk of getting stuck in real estate projects after making payments.

Thousands of buyers are still stuck in housing projects of builders like Unitech and Jaypee Infratech Ltd which defaulted in delivering projects.

Homebuyers of Amrapali Group are getting possession of their flats after intervention from the Supreme Court

Suraksha Group has won a bid to acquire Jaypee Infratech Ltd (JIL) through insolvency process. The Group has infused capital and is awarding construction contracts to complete around 20,000 unfinished flats in Delhi-NCR. (PTI)

# NHRCCB reviews Cardiology Unit's progress & issues at AMCH, Dibrugarh

HT Correspondent BISWANATH CHARIALI, Sept 1: National Human Rights and Crime Control Bureau (NHRCCB) state president Nishant Thard analysed the Cardiology Unit of Assam Medical College & Hospital (AMCH), Dibrugarh, which has a rich history dating back to its establishment in April 1978. The unit began its journey with the appointment of Dr Bhadreswar Das as an assistant professor. Since then, it has grown and evolved significantly, contributing to the advancement of cardiac care in Assam. Dr Hem Chandra Kalita was the first faculty member in the Cardiology department with a DM degree, which he obtained from PGIMER, Chandigarh. He joined the department as an assistant professor in December 1990, marking a new chapter in the development of the unit.

In recent years, the department has seen further expansion in both personnel and facilities. Dr Darpan Gogoi joined as a general duty medical officer (GDMO) in 2013, followed by Dr Krishna Narayan Dutta Baruah in 2015. Both doctors have been pivotal in providing quality support and service, particularly given the department's struggle with minimal manpower.

A significant milestone for the Cardiology Unit was the commencement of the DM course on May 1, 2022. This was a historic achievement for AMCH, as the Cardiology department became the first department in the hospital to initiate super-specialty (DM/MCh) education and training. In a further boost to the department's capabilities, it moved to the new Super Specialty Building (SSB) in June 2022, enhancing its infrastructure and capacity to provide advanced cardiac care

Despite these accomplishments, the Cardiology Unit faces some serious challenges, alleged by state president NHRCCB through its state media officer Mrinmay Kr Nath.

"It is disheartening to note the inadequate facilities

arate toilets for men and women on Floor no 3, Ward no 3, has been a significant concern. Currently, both genders are forced to share a single toilet, raising questions about privacy and respect, especially at a time when there is a national emphasis on respecting women's rights. Moreover, the men's bathroom has been closed for an extended period, leaving male patients to use a bathroom outside the ward. However, this alternative facility has also been inconsistently available, often locked, further complicating the situation. Another pressing issue is the closure of the RO water system inside and outside the ward, which compromises patient hygiene and comfort, as the space is now used to store urinals. Additionally, the ward suffers from an inadequate number of nursing staff, leading to an overburdened workforce and potentially compromising patient care. The hospital is equipped with a centralised AC system in the patient wards. However, it often remains turned off, raising concerns about the effectiveness and quality of the installation by the state government.'

"These conditions are in stark contrast to India's commitment to respecting privacy and maintaining dignity in healthcare settings. It is imperative for the hospital management and the HR division to address these concerns promptly. Improving the basic amenities and staffing levels is crucial to ensuring that the Cardiology Unit can continue to provide the high standard of care for which it has become known.'

'The dedicated team at AMCH's Cardiology Unit, including those who have chosen to remain in Dibrugarh, like Dr HC Kalita, has made significant contributions to the hospital and the broader community. However, to maintain and build upon this legacy, it is essential to address these challenges and ensure that the facilities meet the needs and rights of all patients. The state government must take immediate action to rectify these issues, uphold human rights, and honour the institution's longstanding commitment to quality

GUWAHATI, Sept 1: In a significant move aimed at enhancing the operational efficiency and safety of train operations, the Lumding division of Northeast Frontier Railway (NFR) has successfully replaced the existing 1 in 12 track turnout at the Langting yard, located in the Lumding-Badarpur hill section, with a safer 1 in 16 turnout set.

This marks a milestone achievement, as this is the first time such an upgrade has been adopted and implemented in the zone.

In fact, following the success of this installation, plans are already in place to further replace 12 more turnouts with 1 in 16 turnouts in the LumdingBadarpur hills section under Lumding division, with projects already sanctioned and underway

The previous 1 in 12 turnout (point 101) at Langting yard was laid on a 3.5-degree curve, resulting in a sharp curvature of the crossover at 7.5 degrees. This sharp curvature posed challenges in maintaining smooth train operations.

By installing the 1 in 16 turnout, the resultant curvature has been significantly reduced to 5.73 degrees, thereby facilitating safer and more efficient train movement through the yard. The replacement process involved meticulous planning and execution, with multiple rounds of machine tamping conducted using MFI technology, which further stabilises the tracks and ensures optimal alignment.

NFR is committed to continuous improvements and upgrades to its train connectivity infrastructure.

The upgraded Langting yard is a testament to NFR's dedication to adopting advanced technologies and practices, ensuring high standards for railway operations and minimising the challenges of the existing layout

# Himanta's campaign against 'Miya Muslims'

n a political landscape increasingly defined by identity and exclusion, Assam's Chief Minister Himanta Biswa Sarma has emerged as one of the most polarizing figures. His governance has taken a distinct and aggressive approach, particularly targeting the state's 'Miya Muslims,' a community he claims are infiltrators from Bangladesh. This strategy, while appealing to a segment of Assam's indigenous population, has deepened religious and ethnic divisions in the state. Sarma's rhetoric is blunt and unapologetic. He has openly declared that he is the Chief Minister for only "some" of Assam's people, pointedly excluding the 'Miya Muslims' from his purview. These statements, while shocking to some, have resonated with a portion of the indigenous Assamese population, who see Sarma as a protector of their interests against what they perceive as a demographic and cultural invasion by Bengali-speaking Muslims. The 'Miya Muslims' have long been a contentious issue in Assam. Often portrayed as illegal immigrants from Bangladesh, they have been accused of altering the state's demography, occupying significant portions of land, and overwhelming the native population. Sarma has capitalized on these fears, positioning himself as a defender of Assam's indigenous identity.

One of Sarma's most controversial policies has been his crackdown on madrasas, which he has linked to crimes against women. His use of bulldozers to demolish these institutions, coupled with his tough stance on issues like child marriage, has won him support among those who believe in strong, decisive action. However, these moves have also drawn criticism for targeting a specific community under the guise of law enforcement. Sarma's latest campaign focuses on banning polygamy, a practice he associates with the 'Miya Muslim' community. The Assam Assembly's recent passage of the Assam Compulsory Registration of Muslim Marriages and Divorces Bill, 2024, is a clear indication of his determination to regulate Muslim marriages, further encroaching on personal and religious freedoms. Critics argue that Sarma's actions are less about governance and more about stoking religious and ethnic tensions. The opposition, led by the Congress, has accused him of exploiting these divisions for political gain. They warn that his policies could ignite unrest in a state already fraught with tension

Sarma's rise to power is as much about his political acumen as it is about the failures of his rivals. A former Congress leader, Sarma defected to the BJP after a falling out with Rahul Gandhi, whom he accused of treating him with disdain. This personal slight seems to have fuelled his ambition, and he has since become one of the BJP's most prominent leaders in the Northeast. While Sarma's policies have made him a hero to some, they have also drawn sharp criticism from those who see them as divisive and dangerous. The opposition's warnings of potential unrest are not unfounded, as history has shown that such deeprooted tensions can easily flare into violence. As Assam navigates this fraught political landscape, the question remains: Will Sarma's hardline approach bring stability and security, or will it deepen the divisions that have long plagued the state? Only time will tell, but one thing is certain-Assam's future is being shaped by a leader who is unafraid to take bold, controversial steps, regardless of the consequences.

# Narendra Modi's visit to Ukraine was primarily meant to mollify US

arendra Modi's brief visit to Ukraine has been hailed by the pro-American circles and the corporate media as a big success. According version, here is an Indian

tional security advisor, Jake Sullivan, to the state department spokesperson. But it was left to the American Ambassador to India, Eric Garcetti, to convey the warning that the US-India defence partnership is amongst the most consequential in the world. but "don't take the relationship for granted". He added: "I know India like its strategic autonomy. But in times of conflict, there is no such thing as strategic autonomy" The national security advisor Ajit Doval called up the US national security advisor Jake Sullivan just two days after Modi's Russia visit to mollify the Americans to assure them that India would be seriously pursuing the strategic alliance and confirming its participation in the forthcoming Quad foreign ministers' meeting in Tokyo. Soon after, foreign ministry sources began briefing the media about a possible visit of Modi to Ukraine in the third week of August. It is evident, therefore, that Narendra Modi went through the motions of reaching out to Ukraine in order to pacify the Americans and to signal India's continuing fealty to the US alliance. This commitment to its US ally was further exemplified by the visit of defence minister Rajnath Singh to the US which began exactly on the day of Modi's trip to Kyiv. The four-day visit has led to the signing of a `Security of Supplies Arrangement' (SOSA) and an agreement for posting of Indian military officers as liaison at key US commands. As part of the burgeoning purchase of arms from the United States, the US government approved the sale of anti-submarine sonobuoys amounting to 58.6 million dollars While India cannot dispense with its longstanding ties with Russia, especially military supplies in the short term, the Modi visit to Kyiv and the outcome of Rajnath Singh's visit to the US show that the Modi government is set on a course of strengthening its strategic alliance with the United States and signalling, at the same time, that it is willing to lessen its dependence and ties with Russia in the long run. The Modi government seems to have learnt its lesson – that there is not much scope for strategic autonomy whilst being a US ally. (IPA Service)

Modi's visit to Moscow in July coincided with the holding of the 75th anniversary meeting of NATO in Washington. The spectacle of Modi hugging president Putin and receiving the highest Russian civilian award from Putin caused indignation in Washington. The NATO meeting was meant to marshal all forces against Putin's Russia, when on that very occasion, the `Indo-Pacific' ally of the US was brazenly courting the enemy.

# Advancement in Robotic Surgery Life without movement is a misery for Cancer treatment **By: Gita Debnath**

t is well known that minimizing the impact of oncological treatment is the way not only to improve cancer patients' quality of life, but also to increase compliance to treatment and ultimately the chances of a cure. Maintaining oncological standards, improving perioperative outcomes and functional results, and minimizing complications, are the principles that inspired the minimally invasive approach in oncological surgery.

The laparoscopic technique has been a revolution in particular for gynecological surgery, as well as abdominal and urological surgery. Less scarring, less pain, visual magnification, and the pneumoperitoneum tamponade effect reducing the risk of bleeding are the strengths of laparoscopic surgery

On the other hand, 2D vision, counterintuitive movements and instruments with few degrees of freedom rendered laparoscopy a technically challenging approach. The introduction of Robotics at the end of the last millennium has led to a revolution, fixing all the shortcomings of laparoscopy. There are numerous advantages of Robotic surgery which include 3D HD vision. 7 degrees of freedom. more precision and control, meticulous dissection, better ergonomics, improved dexterity, endo-wrist movements, 10X magnification and greater instrument stability. Robotic-assisted surgery is expanding the capabilities of surgery and is changing the face of medical care.

Robotic Surgery is very safe, infact much safer than open surgery in skilled hands. The machine is not a true robot (it does not operate or move by itself), but is a "master slave" unit. This means the surgeon is in complete control throughout the procedure, and controls the instruments at all times. Robot allows more-precise tremor-free movements in tiny spaces. Tumours can be dissected free from surrounding tissues safely. A great constraint to the wider and far reaching application of Robotic Surgery is the cost factor, robotic surgery being perceived as way too expensive. Overall robotic surgery is not expensive as compared to open surgery.Definitely, the initial cost involved is higher because of the costly equipment involved but the long term benefits offered by robotic surgery even out the initial cost. Patients have shorter hospital stay, rapid recovery, and early return to the work and less work hours lost. In some cases the need for chemoradiotherapy may be reduced or even eliminated.

surgery can overcome the intrinsic limitations of laparoscopic instruments and can be useful for various cancer surgeries of the Pancreas, Stomach, Gallbladder, Liver and Colon. Robotic surgery finds special application in the treatment of Rectal cancers in terms of better functional outcomes and preserving the normal continence

of the patients. In thoracic surgeries for Lung cancer, Esophageal cancer and other mediastinal tumours robotic surgery avoids the large thoracic incision and provides earlier return to normal routine with better perioperative outcomes and less complications. Regarding the commonest ro-

botic operation, radical prostatectomy, there is increasing evidence reporting functional advantages for robotic surgery compared to open while as robotic surgery also offers advantage in other urology surgeries like radical nephrectomy, partial nephrectomy, and radical cystectomy. At the same time, Robot provides better vision and outcomes in pelvic surgeries like those for the Gynecologic Cancers of Uterus, Ovary and Cervix.

Beyond the abdominal approach, TORS (Trans Oral Robotic Surgery) represents one of the most interesting experiences of extra abdominal robotic application. Nowadays TORS In abdominal surgery, robotic may be applied for benign and

malignant lesions of the upper aero-digestive tract like throat and voice box cancers attaining good functional results in terms of return to normal speech. avoiding disfiguring mandibulotomy and long incisions on the neck and face.

Similarly Robotic Thyroid Surgery offers the same oncology outcomes with no neck scar. Faster return to normal function allows patients to begin adjuvant therapy, if warranted, much sooner than in patients who undergo open surgery, affording potential advantages and benefits over current treatment modalities of

ing robotic experiences demonstrates multiple opportunities for surgical indications in the oncological setting. The miniaturization of the instruments and further technological advancements provide a glimpse of an even less invasive surgical approach for the near future.

Everyone experiences negative emotions in difficult situations - like sadness after a breakup or anxiety before a big life event. But when do these feelings become problematic? When you have poor mental health.

Mental health and mental illness are distinct, but related, concepts. Mental health refers to the inner resources you have to handle life's ups and downs. You have good mental health if you enjoy life; feel connected to others; cope well with stress; and have a sense of purpose, a sense of self and strong relationships. If you have poor mental health, it can be hard to adapt to changes like a breakup, move, loss or parenthood. Therapy can help you improve your mental health, develop resilience and maintain a state of well-being.

Memories allow us to remember important events in our lives, the faces of those we know, and give us the ability to learn.

Special cells in the brain called neurons help create memories, which are then stored in the hippocampus area of the brain. A number of lifestyle factors can help improve a person's ability to create memories, including following a healthy diet, exercising, meditation, and getting enough sleep.

"We have a bulk knowledge about sleep being better for our body to rest, for our memory to be better, but we do not yet understand all the details of how this happens," Azahara Oliva, PhD, assistant professor in the Department of Neurobiology and Behavior in the College of Arts and Sciences at Cornell University explained to Medical News Today.

"Once we start cracking the neural processes that are important for these many different things, we could use that to reverse detrimental conditions, such as memory impairment, during sleep," she added

Oliva is the corresponding author of a new study recently published in the journal Science, which found that during sleep, the hippocampus goes "silent" and allows neurons to "reset," making them available to create new memories the next day, via a mouse model.

"We want to see what exactly the brain is doing during sleep that favors or disfavors memory," Oliva said. "We [spend] about a third of our life sleeping — this is a lot of time. Understanding the relation between sleep and memory will provide insights into how we can tackle detrimental memory conditions."

### How do neurons 'reset' during sleep?

The researchers explained that there are three main regions of the hippocampus: CA1, CA2, and CA3.

Using a mouse model, the scientists discovered that while the neurons in areas CA1 and CA3 were very active during daytime learning, those regions became "silent" while the mice slept.

'We realized there are other hippocampal states that happen during sleep where everything is silenced," Oliva said in a press release. "The CA1 and CA3 regions that had been very active were suddenly quiet. It's a reset of memory, and this state is generated by the middle region, CA2.'

This "silencing" of areas CA1 and CA3 allow neurons to "reset" during sleep.

"During our experience, a few neurons become highly active," Olivia explained. "The same neurons 'work hard' during sleep to imprint this experience into memory. What we found is that for these neurons to be able to imprint these memories, they also need breaks or a 'reset.' Without these breaks, the neurons are not able to make proper memories.

### Opening treatment options for memory-related conditions

Thanks to the findings of this study, Oliva and her team believe they now have some tools to might help one day allow doctors to remove neg ative or traumatic memories from a person to assist with conditions like post-traumatic stress disorder (PTSD).

'We now know which particular neurons and through which particular neural circuits are responsible for different neural processes, both important for memory, like consolidation and resetting," Oliva said. "That will facilitate the specificity that we can gain when treating different types of detrimental memory conditions.

Commenting on the next step in this research, she told MNT:

"We want to know how exactly the brain coordinates high memory demands. What happens when there is more than one experience? At the end of the day, during most of our life we [always have] many things we want to learn and remem-

Memory research: Hippocampus remains an area of interest

After reviewing this study, Manisha Parulekar, MD, FACP, AGSF, CMD, director of the Division of Geriatrics at Hackensack University Medical Center, co-director of the Center for Memory Loss and Brain Health at Hackensack University Medical Center, and associate professor at Hackensack Meridian School of Medicine in New Jersey, told MNT that it provides insight into how sleep "resets" the brain for new learning, offering a potential explanation for why we need sleep and how it impacts memory consolidation.

"Understanding the role of the CA2 region in silencing and resetting memory circuits could lead to therapies that enhance memory consolidation and prevent further cognitive decline in patients with dementia and Alzheimer's disease," Parulekar explained.

"Additionally, optimizing sleep quality through interventions like cognitive-behavioral therapy for insomnia could be crucial in managing these conditions," she noted.

Parulekar said that it is important for researchers to continue to find new ways in which sleep affects the brain asfurther research is needed to understand individual variations in sleep patterns and brain activity to personalize these potential therapies.

"Exploring the contributions of other sleep stages and developing noninvasive techniques to modulate brain activity during sleep are also important areas for future investigation," she continued.

'Translating these findings into clinical trials to test the efficacy of interventions targeting the CA2 circuit or sleep quality in patients with dementia and Alzheimer's disease is crucial," said Parulekar. "Developing personalized approaches based on individual sleep patterns and brain activity and conducting studies to evaluate the sustained benefits and potential risks of these interventions are essential next steps." # Acid reflux disease: Heartburn in modern lifestyle

★ astroesophageal reflux disease (GERD) commonly known as acid reflux disease is increasingly becoming a common ailment in India, affecting a significant portion of the population. Characterized by persistent heartburn and acid regurgitation, GERD occurs when stomach acid frequently flows back into the esophagus, irritating its lining. This condition, which can significantly impact quality of life, is closely tied to modern lifestyle habits, making it a pertinent issue in today's fast-paced world.

### **Symptoms and Diagnosis**

The primary symptoms of GERD include chronic heartburn, acid reflux, and a sour taste in the mouth. For severe cases that do not respond to medication or lifestyle changes, surgical options such as fundoplication may be considered. These treatments aim to address the underlying causes of GERD and provide relief from persistent symptoms.

### The Impact of Modern Lifestyle

The rise of GERD cases in India is closely linked to modern lifestyle factors. # Israel recovers bodies of 6 hostages in Gaza

**JERUSALEM, Sept 1:** Israel on Sunday said it had recovered the bodies of six hostages in Gaza, including a young Israeli-American man who became one of the most well-known captives held by Hamas as his parents met with world leaders and pressed for his release.

The military said all six had been killed shortly before the arrival of Israeli forces trying to rescue them. Their recovery sparked calls for mass protests against Prime Minister Benjamin Netanyahu, whom many families of hostages and much of the wider Israeli public blame for failing to bring them back alive in a deal with Hamas to end the 10-month-old war. Negotiations over such a deal have dragged on for months.

Netanyahu expressed sorrow over the deaths and said Israel would hold Hamas accountable for killing them in "cold blood". He said the killings prove that the militant group does not want a a cease-fire agreement.

"Whoever murders hostages doesn't want a deal," he said.

Militants seized Hersh Goldberg-Polin, 23, and four of the other hostages at a music festival in southern Israel during Hamas' October 7 attack, which triggered the war.

The native of Berkeley, California, lost part of his left arm to a grenade in the attack. In April, a Hamas-issued video showed him, his left hand missing and clearly speaking under duress, sparking new protests in Israel urging the government to do more to secure his and others' freedom.

The army identified the other dead hostages as Ori Danino, 25; Eden Yerushalmi, 24; Almog Sarusi, 27; and Alexander Lobanov, 33; who were also taken from the music festival. The sixth.

Carmel Gat, 40, was abducted from the nearby farming community of Be'eri.

It said the bodies were recovered from a tunnel in the southern Gaza city of Rafah, around a kilometer (half a mile) from where another hostage, Qaid Farhan Alkadi, 52, was rescued alive last week

"According to preliminary information, they were cruelly murdered by Hamas terrorists shortly before we reached them," Rear Adm. Daniel Hagari, the Israeli military spokesperson, told reporters.

Hamas has offered to release the hostages in return for an end to the war, the withdrawal of Israeli forces and the release of a large number of Palestinian prisoners, including high-profile militants.

Izzat al-Rishq, a senior Hamas official, blamed the hostages' deaths on Israel and the United States, saying they would still be alive if Israel had accepted a cease-fire proposal that Hamas said it had agreed to back in July. He did not mention the hostages by name.

Families of hostages call for a complete halt of the country'

Netanyahu has vowed to continue the war until Hamas is destroyed and says military pressure is needed to bring home the hostages.

Israel's Channel 12 reported that he got into a shouting match at a security Cabinet meeting late Thursday with his defense minister, Yoav Gallant, who accused him of prioritising control of a strategic corridor along the Gaza-Egypt border ---a major sticking point in the talks — over the lives of the hostages.

The Cabinet reportedly voted in favour of re-



maining in the corridor over the objections of Gallant, who said it would prevent a hostage deal.

An Israeli official confirmed the report and said three of the hostages - Goldberg-Polin, Yerushalmi and Gat - had been slated to be released in the first phase of a cease-fire proposal discussed back in July. The official was not authorized to brief media about the negotiations and spoke on condition of anonymity.

"In the name of the state of Israel, I hold their families close to my heart and ask forgiveness," Gallant said Sunday after the remains were recovered. He later called for the Cabinet to reverse its decision

A forum of hostage families called for a massive protest on Sunday, demanding a "complete halt of the country" to push for the implementation of a cease-fire and hostage release.

"A deal for the return of the hostages has been on the table for over two months. Were it not for the delays, sabotage, and excuses those whose deaths we learned about this morning would

likely still be alive," it said in a statement. US President Joe Biden, who has met with Goldberg-Polin's parents, said he was "devastated and outraged".

"It is as tragic as it is reprehensible," he said. 'Make no mistake, Hamas leaders will pay for these crimes. And we will keep working around the clock for a deal to secure the release of the remaining hostages.

Vice President Kamala Harris said her prayers were with the Goldberg-Polin family and condemned Hamas

### A high-profile campaign

Goldberg-Polin's parents, US-born immigrants to Israel, became perhaps the most high-profile relatives of hostages on the international stage. They met with Biden, Pope Francis and others and addressed the United Nations, urging the release of all hostages.

On August 21, his parents addressed a hushed hall at the Democratic National Convention after sustained applause and chants of "bring him home'

"This is a political convention. But needing our only son - and all of the cherished hostages home is not a political issue. It is a humanitarian issue," said his father, Jon Polin. His mother, Rachel, who bowed her head during the ovation and touched her chest, said "Hersh, if you can hear us, we love you, stay strong, survive.'

She and her husband sought to keep their son and the others held from being reduced to numbers, describing Hersh as a music and soccer lover and traveller with plans to attend university since his military service had ended. At events she often addressed her son directly in the hope he

Before the military's announcement of the latest discovery of bodies, Israel said it believed 108 hostages were still held in Gaza, of which about one-third were dead. In late August, the Israeli military recovered the bodies of six hostages in southern Gaza.

Eight hostages have been rescued by Israeli forces, the most recent found on Tuesday. More than 100 were freed during a weeklong cease-fire in November in exchange for the release of Palestinians imprisoned by Israel.

Two previous Israeli operations to free hostages killed scores of Palestinians. Hamas says several hostages have been killed in Israeli airstrikes and failed rescue attempts. Israeli troops mistakenly killed three Israelis who escaped captivity in December.

Hamas-led militants killed some 1,200 people, mostly civilians, when they stormed into southern Israel on October 7, attacking army bases and several farming communities.

Israel's retaliatory offensive in Gaza has killed over 40,000 Palestinians, according to local health officials, who do not say how many were fighters and how many civilians. It has displaced the vast majority of Gaza's 2.3 million people, often multiple times, and plunged the besieged territory into a humanitarian catastrophe.

In a separate development Sunday, Palestinian militants killed three Israeli police officers when they opened fire on their vehicle in the West Bank, according to Israeli officials. Israel has been carrying out large-scale military raids across the occupied territory in recent days. (AP)

# **Country needs more than USD 100** billion in foreign investment: Iran Prez

TEHRAN, Sept 1: Iran's president said Saturday his country needs some \$100 billion in foreign investment to achieve an annual target of 8% economic growth up from the current rate of 4%

The remarks by Masoud Pezeshkian, who was elected in July, came in his first live televised interview by state TV.

Pezeshkian said Iran needs up to \$250 billion to reach its goal but more than half is available from domestic resources. Experts say growth in GDP of 8% would reduce doubledigit inflation and unemployment rates.

Iran's economy has struggled since 2018 after then-President Donald Trump pulled the US out of the deal to constrain Tehran's nuclear programme and imposed more sanctions. Pezeshkian said during his presidential campaign that he would try to revive the nuclear deal. (AP)

JERUSALEM, Sept 1: A campaign to inoculate children in Gaza against polio and prevent the spread of the virus has begun, the Health Ministry has said, as Palestinians in the Hamas-governed enclave and the occupied West Bank reeled from Israel's military offensives.

Meanwhile, Israel's military late Saturday in a terse announcement said it had "located a number of bodies during combat" in Gaza. The army was trying to identify the bodies, including whether they were hostages, but said the process would take several hours. "We ask to refrain from spreading rumors," it said. There were no further details. A small number of children in Gaza received vaccine

doses on Saturday, a day before the large-scale rollout and planned pause in fighting agreed to by Israel and the UN World Health Organisation.

"There must be a cease-fire so that the teams can reach everyone targeted by this campaign," said Dr Yousef Abu Al-Rish, Gaza's deputy health minister, describing scenes of sewage running through crowded tent camps. Polio is spread through fecal matter.

Associated Press journalists saw about 10 children receiving doses at Nasser hospital in Khan Younis.

"I was terrified and waiting for the vaccination to arrive and for everyone to receive it," said Amal Shaheen, whose daughter received a dose.

In its first statement on the campaign, Israel said the vaccination program would continue through Sept 9 and last eight hours a day. It is expected to pause some operations in Gaza to allow health workers to administer vaccines with the aim of reaching some 640,000 Palestinian children.

The vaccination campaign comes after the first polio case in 25 years in Gaza was discovered this month. Doctors concluded a 10-month-old had been partially paralysed by a mutated strain of the virus after not being

Israel's military on Saturday said 23 militants had been killed since the incursion, including 14 in the Jenin area. Some people fled Jenin. Holding a baby, Oroba al-Sha-

labi said Israeli gunfire had pelted her windows. "We began screaming that we had small children, but they (the Israeli soldiers) didn't respond at first. The more we screamed, the more they shot at the house, shattering the TV and the windows around us," she said.

The family cowered in their kitchen until soldiers entered, she said, separating women and children from the men and searching everyone's phones before letting her

# Without X, Brazilians say they feel disconnected from world

Doctors across the country announced a complete shutdown of all public and private hospitals starting September 1 with a four-point demand, including the arrest of those involved in the assault on doctors in Dhaka Medical College Hospital (DMCH) on Saturday night.

"The sooner they accept our demand, the better. We will start giving treatment as soon as our demands are met," the protesting doctors told the media at the DMCH premises.

They said the nurses also expressed solidarity with doctors and refused to join work.

Asked who would take responsibility if anyone died for lack of treatment, the protesters said the administration would be responsible for any such incident.

The doctors demanded immediate security measures at all healthcare facilities in the country through the deployment of armed "health po-

They said if any irregularities or negligence in patient care were observed at any hospital, appropriate action should be taken through complaints to relevant authorities.

"Under no circumstances should individuals take the law into their own hands," the doctors said in a statement.

The protest by medical professionals comes following the massive quota reform demonstrations that led to the ouster of former Prime Minister Sheikh Hasina. (PTI)

SAO PAULO, Sept 1: The blocking of social media platform X in Brazil divided users and politicians over the legitimacy of the ban, and many Brazilians had difficulty and doubts over navigating other social media in its absence.

The shutdown of Elon Musk's platform started early Saturday, making it largely inaccessible on both the web and through mobile apps after the billionaire refused to name a legal representative to the country, missing a deadline imposed by Supreme Court Justice Alexandre de Moraes. The blockade marks an escalation in a monthslong feud between Musk and de Moraes over free speech, far-right accounts and misinformation.

Brazil is one of the biggest markets for X, with tens of millions of users. "I've got the feeling that I have no idea what's happening in the world right now. Bizarre," entertainment writer and heavy X user Chico Barney wrote on Threads on Saturday, Threads is a text-based app developed by Instagram that Barney was using as an alternative. "This Threads algorithm is like an all-you-can-eat restaurant where the waiter keeps serving things I would never order.<sup>7</sup>

Bluesky, a social media platform that was launched last year as an alternative to X and other more established sites, has seen a large influx of Brazilians in the past couple of days. The company said Friday it has seen about



200.000 new users from Brazil sign up during that time, and the number "continues to grow by the minute". Brazilian users are also setting records for activities such as follows and likes,

Bluesky said. Previous users of other platforms welcomed Brazilians to their ranks. "Hello literally everyone in Brazil," a user wrote on Threads. "We're a lot

nicer than Twitter here," said another. Platform migration isn't new for Brazilians. They were huge adopters of Orkut and, when Orkut went kaput, they very gladly moved to other platforms.

X is not as popular in Brazil as Facebook, Instagram, YouTube or Tik-Tok. However, it remains an important platform on which Brazilians engage in political debates and is highly influential among politicians, journalists and other opinion makers.

It's also where they share their sense of humour. Many of the country's most famous memes originate from posts on X before spreading to other social networks. Last week, for instance, Brazilians collaboratively crafted an absurd storyline for a fictional telenovela, complete with a theme song created using artificial intelligence tools.

Pop stars and their fanbases were also hit by Brazilians being left off the platform.

"Wait a lot of my fan pages are Brazilian!!! Come back hold up!!," Cardi B said Friday on X. A fan page dedicated to Timothée Chalamet. known by the handle TimotheeUpdates, said it would temporarily cease

updating as all of its administrators are Brazilian. De Moraes said X will stay suspended until it complies with his orders, and he also set a daily fine of 50,000 reais (\$8,900) for people or companies using virtual private networks. or VPNs, to access it. Some legal experts questioned the grounds for that decision and how it would be enforced. Others suggested the move was authoritarian.

The Brazilian Bar Association said Friday in a statement that it would request the Supreme Court review the fines imposed on all citizens using VPNs or other means to access X without due process. Brazil's bar association argued that sanctions should never be imposed summarily before ensuring an adversarial process and the right to full defence.

"I've used VPNs a lot in authoritarian countries like China to continue accessing news sites and social networks," Maurício Santoro, a political science professor at the State University of Rio de Janeiro, said on the platform before its shutdown. "It never occurred to me that this type of tool would be banned in Brazil. It's dystopian.'

A search Friday on X showed hundreds of Brazilian users inquiring about VPNs that could potentially enable them to continue using the platform by making it appear they are logging on from outside the country. (AP)



BERLIN, Sept 1: German leaders paid tribute on Sunday to the three people killed in the August 23 knife attack by a suspected Islamic extremist, which has pushed immigration back to the top of the country's political agenda. Eight people also were wounded in the attack at a "Festival of Diversity" marking the 650th anniversary of the city of Solingen in western Germany. President Frank-Walter Steinmeier said at a memorial event in a city theatre that he was "re-

lieved and thankful" that none of them is now in serious danger. The 26-year-old Syrian suspect, who was arrested a day after the attack, was supposed to be deported to Bulgaria last year but reportedly disappeared for a time and avoided de-

portation. In recent days, Chancellor Olaf Scholz's government has announced new restrictions on knives and new measures to ease deportations. On Friday, it deported Afghan nationals to their homeland for the first time

since the Taliban returned to power in 2021, following up on a pledge made in June after a previous attack.

"It is a horrifying crime that brings us together today, carried out by a man who, according to everything we know, sought and and found protection here, and abused this protection so terribly," Steinmeier said at the memorial, also attended by Scholz and other top officials. "That is also intolerable.

Steinmeier said that "we are for good reason a country that takes in people who seek protection from political persecution and war".

He added that "we want to remain that country, but ultimately we can only do so if the number of those who are not entitled to this special protection does not overburden us".

"We must make every effort to implement the entry rules that exist and the ones that are now being drawn up," he said, adding that "this must be a priority in the coming years".

The attack in Solingen also has reawakened painful memories of a racist firebomb attack on a Turkish family's home there in which five women and girls were killed in 1993. Four young Germans were later convicted. "There was already one shocking Solingen attack, now a second," Mayor Tim Kurzbach said.

# ZPM govt's flagship programme led to growth of plantation area of agricultural crops

AIZAWL, Sept 1: The Zoram People's Movement (ZPM) government's plan to purchase a few agricultural and horticulture produce of farmers has led to growth of plantation area of such crops in the state, an official said.

Sticking to its pre-poll plank, the ZPM government led by Chief Minister Lalduhoma soon after it came to power in December last year, had announced that it will purchase four agricultural or horticultural crops - ginger, turmeric, chilli and broom sticks under its flagship programme "Bana Kaih" or hand holding policy to economically uplift the farmers. The government also fixed minimum prices for such crops.

According to officials of the state horticulture department, the number of farmers cultivating organic ginger, turmeric and Mizo chilli and the extent of the area where such cultivations are being done has gone up this year as compared to the previous year.

The reason for such growth might have been due to the government's assurance to arrange markets or buy the four crops and also to provide minimum price support to farmers in the case of failure to sell their produce below the minimum prices fixed by the government, they said.

The department officials said that ginger plantation is now done in 27,608.5 acres of land by 25,102 families in 11 districts and more than 19,000 quintals are expected to be harvested by farmers this year

The officials said that turmeric cultivation also spread to over 4,281 acres of land in the state and is being cultivated by 3,415 families

The state is expected to harvest more than 81,000 quintals of turmeric at the end of this year, they said.

With 892 families planting turmeric plants in over 1,600 acres of land, south Mizoram's Lunglei district topped in turmeric cultivation, followed by Aizawl district and Kolasib district.

Over 8,600 families are currently cultivating Mizo chilli in over 11,800 acres of land across all the 11 districts, officials said.

The cultivation is expected to yield over 37,000 quintals of chilli by the end of the year, they said. Aizawl district has the highest number of farmers (1,138 families) doing chilli plantation on 1.218 acres of land, followed by Serchhip district, which has 1,026 families doing such plantation on 1,258.5 acres of land, officials said. (PTI)

Need for policy, institutional support to protect Arunachal state animal In a bid to save Mithun from extinction



ITANAGAR, Sept 1: Arunachal Pradesh Governor Lt Gen (retd) K T Parnaik on Sunday emphasised the urgent need for both policy and institutional support to protect the state animal, Mithun, whose population is declining.

Speaking at the second edition of "Mithun Day" and the inauguration of the national seminar on "Integrated Mithun Farming for Enhancing Farmers Income in NE", Parnaik highlighted that the animal has not received adequate support, likely due to its small population and localised presence.

"Lack of support has led to habitat exploitation and destruction, posing a serious threat to its already dwindling numbers," Parnaik said and underscored that conservation efforts for Mithun should integrate traditional practices with modern conservation techniques.

The Governor proposed the development of a "special land

use policy" and designation of Mithun conservation areas. He suggested that community Mithun rearing centres be established in strategic locations to serve clusters of 2-3 villages.

He also recommended in-depth discussions with scientists, farmers, and officials to create a pilot project for Mithun research and development, focusing on evolving best practices to benefit Mithun farmers.

Parnaik noted that Arunachal Pradesh holds the highest Mithun population among the North Eastern states, accounting for 89 per cent of the global population. He expressed pride in the farmers and people of the state for nurturing such a unique animal.

The Governor described the Mithun as a symbol of peace and communal harmony, frequently featured in tribal mythology and folklore.

He further advocated for the domestication of Mithun for draft power in plowing and as a beast of burden in hilly areas.

Parnaik suggested forming cooperatives for Mithun milk and its products and establishing tanneries with modern equipment to utilise the skin and hides, which are often discarded after slaughter. These products could include high-quality coats, mats, and shoes for export, he added. The governor exhorted the scientists and officials to evolve a technically and biologically sound breeding policy to avoid "inbreeding" and reduce mortality and establish research centres to exploit the productive inbuilt potential of milk, meat and draught.

The seminar was organised by the Arunachal Mithun and Yak Conservation Mission, the state Department of Animal Husbandry, Veterinary, and Dairy Development, in collaboration with the National Research Centre on Mithun in Nagaland, under the Indian Council of Agricultural Research (ICAR). (PTI)

# Former JJP leaders Anoop Dhanak, Ram Kumar Gautam, Jogi Ram Sihag join BJP

CHANDIGARH, Sept 1: Former Jannayak Janta Party leaders Anoop Dhanak, Ram Kumar Gautam and Jogi Ram Sihag, who quit the party recently, joined the BJP on Sunday giving the ruling party in Haryana a boost ahead of the October 5 Assembly poll.

The three leaders along with Ambala Mayor Shakti Rani Sharma were welcomed into the BJP fold by Chief Minister Nayab Singh Saini, the party's state unit chief Mohan Lal Badoli and its Haryana affairs co-incharge Biplab Kumar Deb at a rally in Jind.

Sharma is the wife of Haryana Janchetna Party chief and former Union Minister Venod Sharma. Her son and Independent Rajya Sabha member Kartikeya Sharma was also present at the Jind event.

Dhanak, Gautam and Sihag were Jannayak Janta Party (JJP) MLAs when they abandoned the party.

Gautam, who was with the BJP earlier, represented the Narnaund segment in Harvana Assembly after winning the seat on a Jannayak Janta Party (JJP) ticket in 2019. He, however, did not get a ministerial berth in the BJP-JJP coalition government and was also a vocal critic of former deputy chief minister Dushyant Chautala on various issues.

Addressing the gathering rally, Gautam said the BJP will return to power in Haryana for a third consecutive term, adding, "Nayab Saini will again become chief minister, 200 per cent"

Anoop Dhanak, a former minister, was an MLA from Uklana while Jogi Ram Sihag represented the Barwala segment in the Assembly.

Recently, Jogi Ram Sihag, Ram Niwas Surjakhera, Ram Kumar Gautam and Anoop Dhanak extended support to BJP leader Kiran Choudhry's candidature for the Rajya



Sabha bypoll in Haryana. Kiran was elected unopposed to the Upper House of Parliament.

Notably, Surjakhera was also expected to join the BJP at the Jind rally but was not seen at the event. A few days ago, he was booked on the charge of rape by the Jind police based on a woman's accusations against

Surjakhera has dismissed the allegation as "conspiracies" against him ahead of the Assembly polls.

Addressing the Jind rally, Chief Minister Saini said the joining of these leaders has come as a boost for the BJP.

Taking a dig at the Congress over its 'Haryana Maange Hisab' campaign, he accused the opposition party of spreading lies. Referring to Congress leaders' remarks a

week ago that the saffron party has accepted defeat by seeking deferment of the polls, Saini said, "(Bhupinder Singh) Hooda sahab this is BJP. I want to tell Congress leaders that the BJP is not scared, we are always ready to face polls at any time.'

Notably, the ruling BJP and the opposition

Vijayan said the state sought a disaster relief package of about ₹ 2,000 crore from the Centre when he recently met with Prime Minister Narendra Modi in Delhi.

The PM was "very positive" on the issue and the state was hopeful of getting "good assistance" from the Union government, he added.

The chief minister said the funds were expected to be released after a central team submitted a report to the Union government.

the best possible rehabilitation

that commissioned them." This highlights the fact, he said,

that "much of the recommendations in these reports were not pragmatic and did not consider societal aspirations and ground realities"

"At least some parts of the reports did not consider humans dwelling in ecologically fragile zones for centuries as part of the ecosystem," the chief minister added.

He also underlined that "small and marginal" farmers cannot be equated with rich realtors, planters or miners occupying similar terrains

"There was no such differentiation in these reports, which is why many states were forced to completely disregard them," Vijayan said

He added that it was also "not desirable" for his government to take a position in a "hasty manner" without "adequately" studying the draft Ecologically Sensitive Area (ESA) notification issued by the Centre recently.

The notification issued on July 31 seeks to declare over 56,800 square kilometres of the Western Ghats across six states, including 13 villages in Kerala's landslidehit Wayanad, as an Ecologically Sensitive Area (ESA). It invited suggestions and objections within 60 days.

"We have to wait to hear from the local self-governments and eventually take an informed decision on it. This is going to affect the lives of millions...," Vijayan said

Asked about the controversy

"not fully accepted by the entities that erupted after the Centre alleged that Kerala did not heed the alerts sent by it, he said while there was no time for these issues as their aim was to swiftly rehabilitate the affected, the "so-called alerts were generic, routine and carried no specifics regarding an event of such a magnitude".

He said the calamity was triggered by extremely heavy and continuous rainfall in two days.

"It is a fact on record that this was not foreseen by the early warning mechanisms of the government of India. Even a red alert was issued after the massive landslide," Vijavan said.

He said the four settlements that were affected by the landslides had human inhabitation for two centuries.

"However, the landslide originated in a pristine forest. It is pertinent to note that there was no human settlement even remotely close to the point of origin," the chief minister asserted.

Vijayan said the proposed townships will "exemplify the best possible post-disaster rehabilitation plan in the country and these will be climate-resilient and sustainable".

The state has identified five parcels of land, each of about 50 hectares, for the township projects and the chief minister said they were investing "significantly" for this project, with support from businesses and philanthropic organisations

As of now, a post-disaster needs assessment is ongoing in Wayanad. "This will give us more insights into the changes that we may have to bring about," Vijayan said. (PTI)

supremo Sharad Pawar and Shiv Sena (UBT) leader Uddhav Thackeray on Sunday led a march of Maha Vikas Aghadi from the iconic Hutatma Chowk to Gateway of India in south Mumbai to rotest the collapse of Chhatrapati Shivaji Maharaj's statue in Maharashtra's Sindhudurg district.

They slammed the Union and state governments for the collapse, with Thackeray calling Prime Minister Narendra Modi's apology as one "smacking of arrogance", while Pawar said the episode was an example of corruption.

The statue of the 17th century Maratha warrior king at Rajkot fort in Malvan tehsil, some 480 kilometres from here, fell on August 26. It was unveiled by PM Modi on December 4, 2023, on the occasion of Navy Day.

Addressing a gathering at Gateway of India, where the protest march culminated, Thackeray said, "Did you notice the arrogance in the (Prime Minister Narendra Modi's) apology? It smacked of arrogance. One deputy chief minister was smiling." "The mistake (collapse) cannot be forgiven. We have all gathered here to demand 'BJP get out of India'," he said at the well-attended protest march.

Asserting that people of Maharashtra will never forgive the insult to the legendary warrior king, Thackeray cited the statue collapse, leakages in the Ram Temple and the new Parliament complex to mock Modi's "guarantees". "For what was the PM apologising? For the statue he inaugurated eight months ago? For the corruption involved? The MVA cadre must work together to defeat the forces that have insulted Shivaji Maharaj.

MUMBAI, Sept 1: NCP (SP) The collapse of the statue is an insult to the soul of Maharashtra," he asserted.

> During his address in Palghar on Friday, PM Modi had said Chhatrapati Shivaji Maharaj is not just a name or a king but a deity. "Today, I bow my head at his feet and apologise to my deity," he had said.

> Speaking at the protest march, Pawar said, "The collapse of Chhatrapati Shivaji Maharaj's statue in Sindhudurg is an example of corruption. It is an insult to all Shiv premis (followers of the warrior king)." Maharashtra Congress chief Nana Patole said, much before the PM, the opposition had sought forgiveness from the emperor for allowing such a "Shiv drohi" (those betraying the principles of Chhatrapati Shivaji) government to come to power.

"We have taken a pledge to never let it happen again," he said, adding the PM's apology was with an eye on the upcoming state polls.

During the agitation, called jode maro andolan' (hitting with slippers), Thackeray joined Shiv Sena (UBT) and Congress leaders to hit a poster of Chief Minister Eknath Shinde and deputy CMs Devendra Fadnavis and Ajit Pawar with footwear. Kolhapur Congress MP Shahu Chhatrapati, a descendant of the emperor, said the latter's dignity must be maintained at all cost.

NCP (SP) supremo Pawar, Shiv Sena (UBT) leader Thackeray, Congress state unit chief Nana Patole and the party's Mumbai head Varsha Gaikwad began the protest march by laying wreaths at Hutatma Chowk, a memorial to those martyred in the 'Samyukta Maharashtra' agitation. (PTI)

## 24 pc rain deficit in Himachal Pradesh

SHIMLA, Sept 1: Himachal Pradesh has recorded a 24 per cent deficit in rainfall between June 1 and September 1 despite spells of heavy rains during the ongoing monsoon that caused extensive damage and claimed over 150 lives in the state. Of the 12 districts in the state, 11 recorded a rainfall deficit. Only Shimla district received 10 per cent excess rains, according to the meteorological department. The state received 471.1 mm of rainfall in the current monsoon season against an average of 618.9 mm, a deficit of 24 per cent. According to data from the weather department, Lahaul and Spiti district recorded the highest 73 per cent rain deficit, followed by Kinnaur 43 per cent, Chamba and Una 34 per cent each Hamirpur 33 per cent, Solan 31 per cent, Kullu 22 per cent, Sirmaur 16 per cent, Mandi and Bilaspur each 11 per cent, in Kangra eight per cent.(PTI)

# 2 new spider species found by ZSI

KOLKATA, Sept 1: The Zoological Survey of India announced the discovery of two spider species in the Western Ghats region, a biodiversity hotspot, in south India, A ZSI statement said the newly discovered species - Mimetus Spinatus and Mimetus Parvulus - highlight the importance of the region.

The addition of two new spiders brings the number of Mimetus species in India to three, all of which have been spotted from the southern part of the country, the surveyor said.

Speaking about the discovery, ZSI Director Dr Dhriti Banerjee said, "The Western Ghats plays a crucial role in the climatic conditions of the country and continue to surprise scientists with their high levels of endemism.



The discovery was made by a research team comprising Dr Souvik Sen along with Dr Sudhin PP and Dr Pradeep M Sankaran. Mimetus Spinatus and Mimetus Parvulus were collected from the Mookambika Wildlife Sanctuary, Karnataka and Ernakulam district of Kerala respectively.

This discovery highlights the need for

continued exploration and conservation efforts in the region, which is one of the world's hottest biodiversity hotspots, she said on Saturday.

Banerjee emphasised the importance of the Western Ghats, a UNESCO World Heritage site, in preserving India's rich biodiversity. She said this discovery assumes significance as it comes 118 years after the last Mimetus species was found in India. "This long gap emphasises the need for more extensive surveys and research into the taxonomy and biogeography of spiders in India. "The current findings suggest that the true diversity of Mimetus in the country remains largely unexplored, with the potential for more undiscovered species in India's least explored areas," she said. (PTI)

Teamwork key to solving Delhi's pollution woes: Gopal Rai

NEW DELHI, Sept 1: The problem of pollution in Delhi can only be solved through teamwork, Environment Minister Gopal Rai said on Sunday as he urged the Centre to give permission for artificial rain during winter, when air quality levels in the city plummet.

Addressing a press conference, Rai said though the Delhi government has taken several steps to address the problem, pollution levels in and around the national capital spike in November.

"An emergency situation arises in Delhi, Punjab, Haryana and Uttar Pradesh. The Kejriwal government is working to reduce the pollution levels. Ever since our government came to power, the pollution levels have declined," he said. But November witnesses a spike in pollution levels, he said.

"Last year, IIT-Kanpur submitted a proposal that artificial rain or a cloud seeding experiment could be done in Delhi. They said that financial management and security permissions were needed. Last year, there was very little time so permissions could not come through.

"We held a meeting with experts and I wrote to Union Environment Minister Bhupendra Yadav and sought the Centre's help," he added.

Rai said he has requested a meeting with central agencies and IIT Kanpur experts to discuss the proposal for artificial rain.(PTI)

# India to host 15<sup>th</sup> World Conference on Injury Prevention and Safety Promotion

edge research, innovative practices and collaborative strategies to create safer environments and prevent injuries worldwide.

Last month, Dharavi redevelopment project received a shot in the arm after a newly formed association of residents of Dharavi approached Srinivas and lent its support to the survey of informal tenements.

The survey, which began on March 18, 2024, has so far completed over 11,000 tenements via door-to-door visits, while numbering has been done on more than 30,000 tenements. (PTI)

# No power group in cinema world: Mammootty; requests govt to implement Hema committee report

**KOCHI, Sept 1:** Actor Mammootty on Sunday denied the presence of any 'power group' in the film industry and called upon everyone working in the field to be vigilant so that nothing untoward happens there.

The veteran actor, in a Facebook post, praised the state government's initiative to constitute the Justice Hema Committee and requested it to implement the recommendations of the panel by enacting necessary legislation if there were any legal hurdles.

Breaking his silence on the report and the subsequent allegations that rocked the cinema world, Mammootty said that he wholeheartedly welcomes and supports the recommendations and solutions in the committee's report and urged all associations in the film industry to join hands in implementing them.

He said that the police was vig-

orously investigating the complaints of sexual harassment and abuse raised by several women, so let the agency carry on with its probe honestly.

The actor also said that as the full report of the committee was before the court, it can decide the punishments.

Mammootty, in his post, said that his response was delayed as he was waiting for the organisation representing actors and its leadership to first respond to the committee report.

He said that cinema was the "epitome" of society and the good and the bad present among the general public are there in the films too.

He also said that as society pays close attention to the film industry, anything that happens there becomes a major topic of discussion. "Therefore, those working in the

film industry need to be careful

and vigilant so that nothing untoward happens in this sector," the actor said, adding that "cinema must survive."

His response comes a day after his colleague in the film industry, actor Mohanlal, broke his silence over the shocking revelations in the committee's report.

Mohanlal too denied the existence of a power group in the industry and had said that cinema was a part of the society and what happens everywhere else is happening in the film world also.

He too had welcomed the panel's report and said that wrongdoers should be punished if there was evidence against them.

The Justice K Hema Committee was constituted by the Kerala government after the 2017 actress assault case, and its report revealed instances of harassment and exploitation of women in the Malayalam cinema industry. (PTI)



# I'm fighting the perception of what audience thinks of me: Ananya Panday

**MUMBAI, Sept 1:** Actor Ananya Panday, set to make her web series debut with "Call Me Bae", says she wants to break out of her perceived image in the audience and industry, and that will happen when she is in a position to say no to offers that feed into a certain stereotype. "Call Me Bae", directed by Collin D'Cunha and created by Ishita Moitra, sees Ananya's Bae leading a privileged life in New Delhi, before she is disowned by her family. The eight-episode series will debut on Prime Video on September 6.

The actor, who made her debut with 2019's rom-com "Student of the Year 2", said "fighting perception" is a challenge that she continues to deal with as an individual.

"When you start up with a certain kind of film, people put you in a box and they would expect the same thing from you.

"So, I'm fighting the perception of what the audience thinks of me and the kind of work you get within the industry. When something of yours does well, you get the same offers, and it is up to us as actors if we have that position where we can say no," Ananya told PTI in an interview here.

Sometimes saying no is more important than yes because that defines you as an actor and a person, she added.

"You can be scared that, 'Oh this is such a big opportunity, what if I say no to this'. But then, in the long term, it does well because you are not feeding into a stereotype. "You are reinventing, challenging yourself and doing something different. All this might mean that you are missing out on something that seems big but actually, you are choosing growth over doing something similar." "Call Me Bae" marks the web series debut for the 25-year-old, whose previous films such as "Gehraiyaan" and "Kho Gaye Hum Kahan" were direct-to-digital releases.



# No power group, but 'strong alliances' are there in film industry: FEFKA gen secy

**KOCHI, Sept 1:** B Unnikrishnan, general secretary of the Film Employees Federation of Kerala (FEFKA), on Sunday said there were "strong alliances" in the cinema industry, but he was not aware of any "power group" as mentioned in the Justice K Hema Committee report. Unnikrishnan, speaking to a TV channel, said that it was an "undeniable fact" that there were "strong alliances" of some production houses with certain directors, writers and actors to make big films.

"They often work together on several projects back-to-back and naturally, everyone would try to align themselves with them to get opportunities. However, such alliances are based on commercial interests," he said.

He also said that such alliances were not confined to Malayalam cinema alone and were present in film industries everywhere.

At the same time, he said that there cannot be a secret lobby of different cinema-related organisations which meet periodically to decide who should be isolated from films.

"The industry will not be able to work like that," he said in response to queries about whether there was a "power group" in the film sector. Another undeniable fact that he admitted was the presence of the "casting couch". "It is a reality we have all heard about. We cannot escape from it by saying it is present in other film industries too. Our endeavour should be to ensure that such things are not there in the Malayalam film industry," he said. Unnikrishnan also said that the names of the perpetrators in the Hema Committee report should be disclosed.

Regarding south Indian actress Radhika Sarathkumar's startling claim that objectionable videos of female actors were recorded with hidden cameras inside caravans on the shooting sets, he said that a thorough investigation would be carried out into the matter. Sarathkumar had said on Saturday that at the shooting set of a Malayalam film, she had seen men watching clips of actresses captured using hidden cameras in their caravans.

On whether the response of the Association of Malayalam Movie Artists (AMMA) to the committee report was delayed, Unnikrishnan said that it was not late, but what they said was criticised by the general public.

"They (AMMA) should be ready to accept that criticism and learn from it," he said.

He also said that the present crisis in

AMMA was due to the fact that it was not a trade union like organisation and has a loose structure. They lack the "experience and flexibility" to deal with the issues that were mentioned in the Hema Committee report, he further said. (PTI)

# Raj & DK walk down memory lane as 'Stree' turns 6, say it was the 'fastest film' they ever made

**NEW DELHI, Sept 1:** Raj Nidimoru and Krishna DK, writers and producers of "Stree", marked the six year anniversary of the popular horror comedy franchise in a lengthy heartfelt note in which they reflected upon how they finished the script in three weeks and how the film went on to become a phenomenon.

Raj, one-half of the writing duo, said they came up with the story of "Stree", based on the urban legend of Naale Ba, at a time when their production banner D2R Films was facing back-to-back flops, including 2017's "A Gentleman" starring Sidharth Malhotra.

"And a film was made at the smallest budget possible and dared to go into theatres without a formula, and not following the norms. Edits were changed, interval points were invented... But the original core story only got stronger at every step.

"It was the fastest film we ever made. I guess that is what happens when you have a point to prove, to yourself. On the cusp of the release, we knew something magical was going to happen. And it happened!" he wrote on Instagram on Saturday.

"Stree" opened in theatres on August 31, 2018 to glowing reviews and went on to become a box office success. Directed by first-time filmmaker Amar Kaushik, the horror comedy starred Rajkummar Rao, Shraddha Kapoor, Pankaj Tripathi, Abhishek Banerjee and Aparshakti Khurana.

"Aug 31, 2018. A ridiculous story, defying all odds, became a phenomenon. Glad we went back to our roots. Glad we stuck to the films we want to make. Glad this was the first Hindi film we produced. A renewed second innings of D2R Films started, on our terms with our kind of stories and with no compromises. The Family Man, Farzi, Guns & Gulaabs, Cinemabandi, Citadel Honey Bunny, Gulkanda Tales, Rakt Brahmand... all followed," he added in the post.

Raj said he and DK wanted to make "original and unique" films and so one day he typed out on a blank page: "O Stree, Kal Aana!"

Ironically as soon as the script was done and the shoot was getting ready, the BMC pulled down that sweet little coffeeshop." Soon, they found a crew that was ready

to buy into this "silly story".

"A cast was cajoled into doing this film despite it being nonconforming. A film started getting shot despite there being no precedent for this kind. A super friendly fun shoot happened in the tiniest of the towns, Chanderi, where we stayed in guesthouses and schools, shot all over the town and played Mafia at nights. Many lasting bonds were formed," Raj said.

The writer-producer said it wouldn't have been possible without the coffee shop, failures, two-decade-old friendships, and the firm belief that "even our kind of stories can break mainstream norms".

"I guess every failure is an opportunity to grow. And every heartbreak is a chance to cleanse and recreate. Thank you, wholeheartedly, for everyone who backed us, believed in us and loved our stories," he wrote.

The success of "Stree", also backed by Dinesh Vijan of Maddock Films, spawned a franchise, the latest offering being "Stree 2", its sequel. (PTI)

# Haaland hat trick gives Man City early lead over Arsenal in EPL



LONDON, Sept 1: At the rate Erling Haaland is scoring, keeping up with Manchester City is going to be a difficult task in the English Premier League.

So while it's still only three games into the season, it felt significant when title rival Arsenal dropped points on Saturday and then saw City take full advantage thanks to another hat trick from Haaland

The Norway striker netted his second treble in two games as City beat West Ham 3-1 to main- Kane (320) and Michael Owen

tain its perfect start and move two points ahead of Arsenal, which was held 1-1 by Brighton after Declan Rice was sent off early in the second half.

"No words for him," City manager Pep Guardiola said about Haaland, who has seven goals in three games to start the season and 70 in total in the 69 league games he has played for the club.

With eight Premier League hat tricks, Haaland has as many as Thierry Henry (258 games), Harry

(326) managed in their careers. This was his first away from Etihad Stadium, though, and showed his wide range of finishing skills.

The opener came when he ran onto a pass from Bernarndo Silva and beat goalkeeper Alphonse Areola with a low shot. After an own goal from Ruben Dias, Haaland made it 2-1 when he received a pass inside the area and hit a

thumping strike into the roof of the net in the 30th minute. The hat trick was complete in the 83rd

when he went clear through on goal and lifted the ball past Lukasz Fabianski, who replaced Areola at halftime

"I really liked the second goal, I have to be honest," Haaland said. "The second one was lovely. ... I like to shoot a bit hard sometimes, as well. Not only easy shots. So it's good to get a little bit of power out of my body.'

While there's another 35 games left, Haaland's prolific form makes any small gap to City look tough to overcome.

So perhaps it's no wonder Arsenal manager Mikel Arteta was so frustrated after what he felt was a decisive refereeing decision. In the early kickoff, Arsenal was 1-0 up at Emirates Stadium and looked in control when Rice was shown a second yellow card in the 49th minute, apparently for nudging the ball to the side as Joel Veltman tried to take a quick free kick near the sideline deep in Brighton's half.

Veltman kicked Rice from behind in the process and the home crowd was screaming for the Brighton player to get sanctioned, only for referee Chris Kavanagh to show Rice a red card instead.

"I was amazed. Amazed, amazed, amazed, because of how inconsistent decisions can be," Arteta said, arguing that similar offenses went unpunished earlier in the game.

"It was a really, really hard one to take." That decision turned the game completely and Joao Pedro equalized from a rebound in the 58th after David Raya saved a shot from Yankuba Minteh.

Kai Havertz put Arsenal ahead in the 38th with a lob over goalkeeper Bart Verbruggen and had a chance to restore Arsenal's lead when he ran through on goal again in the 74th but his low shot was saved that time.

Brows furrowed and hands anchored at her hips, Team USA's youngest breaker this year seemed more serious than some of her competitors at the Paris Olympics. This was not just a contest for the 21-year-old daughter of Filipino immigrants, but a pressure-packed chance to bring her cultural heritage into a traditionally American art form for all to see.

Representing both Filipinos and immigrant families more broadly was "the most overwhelming part" of breaking on the Olympic stage, Edra said, calling it "a different layer of love.

As the spotlight now shifts to the Paralympics, athletes like Edra shoulder not only their countries' hopes for gold, but the responsibility of representing their identities and cultures, which spectators increasingly

Edra did not advance past the quarterfinals in the Paris b-girl competition, but her Olympic journey and current No. 10 world ranking clearly showcase her skill. When an athlete excels at this level, she said, stigma and judgment often give way to respect.

"If someone's doing a crazy move on their elbows, and they spin on their head — clearly it takes so much human strength. You can't deny that," Edra said. However, this effect of positive exposure can unravel if a minority athlete becomes politically outspoken. It's a real dilemma: Voicing opinions on a sensitive topic can jeopardize the breadth of their influence, yet remaining silent can feel like betraying their true selves. Navigating this balance between embracing authenticity and preserving respect is a constant challenge.

Social scientists call this dynamic the "parasocial contact hypothesis," which suggests prejudice can be reduced through

Researchers tested the theory by exploring soccer's influence on Islamophobia in British culture. After Egyptian striker Mohamed Salah, known for his prayers on the pitch, was instrumental in a decisive Liverpool win, viral videos showed British

fans celebrating with chants like "If he scores another few, then I'll be Muslim, too," and "Mohamed Salah, a gift from Allah.

He's always scoring; it's almost boring.'

Researchers analyzed 15 million tweets and hate-crime data from 25 police departments, finding a 16% drop in Liverpoolarea hate crimes and a halving of anti-Muslim tweets by Liverpool fans after Salah joined the team. Surveys showed Salah's Muslim identity increased belief in compatibility with Islam's British values.

Salma Mousa, a political scientist at University of California,

Los Angeles, who specializes in prejudice reduction and who coauthored the 2021 study, pointed out the limitations of this influence — she said Salah maintained a "completely apolitical" stance on controversial issues at the time. "Practically this does place a burden on minority players," said Ala Alrababah, another co-author of the study and a political scientist at Bocconi University. "As a Muslim player, as a Black player, as an LGBTQ player, or as any other minority, knowing that playing well can improve attitudes or playing badly can worsen attitudes This is adding pressure. This is tough." Whether it's their intention to or not, minority Olympians become emblematic figures for entire ethnicities or religions.

Gabby Douglas and Simone Biles have ignited waves of Black participation in gymnastics. Sunisa Lee, who in Tokyo became the first Hmong-American and first Asian American to win women's all-around gold, sparked surges in Google searches for "Hmong" and "What is Hmong descent?" And when Lee began battling an incurable kidney condition after her 2021 win, she raised awareness about high rates of kidney disease among the Hmong American population.

Biles waited until after she had won a sixth gold medal at Paris before posting an apparent reference to the U.S. presidential campaign on X, writing "I love my black job."

'All sports go way beyond what happens on the field of play, but that is true to a factor of 10 for the Olympic Games," USA Gymnastics spokesperson Jill Geer said.

Some civil society groups recruit minority athletes to be ambassadors in prejudice reduction campaigns. Show Racism the Red Card — the U.K.'s largest anti-racism educational charity - offered a 53-page guide on "using the Olympics and Paralympics to educate against prejudice" to teachers across England, Scotland and Wales. # Sukant sets up semifinal clash with Suhas in semis; Nîtesh too win, Krishna out

PARIS, Sept 1: India's Sukant Kadam set up a men's singles SL4 semifinal clash against compatriot Suhas Yathiraj to assure India of a medal in para badminton but Krishna Nagar's title defence ended in agony following an ankle injury at the Paris Paralympics.

There was heartbreak in store for mixed doubles pair of Sivarajan Solaimalai and Nithya Sre Sumathy Sivan as the second seeded duo squandered an opening game advantage to go down 21-17 14-21 13-21 to USA's Miles Krajewski and Jayci Simon in SH6 semifinals on Saturday.

The Indian duo will now play in the bronze medal play off.

Earlier, debutant Sukant thrashed Thailand's Teamarrom Siripong 21-12 21-12 to top group B and will clash with Suhas, a Tokyo silver medallist, in the semifinal to ensure a final finish for India in SL4 class. which is meant for athletes with lower limb impairments and minor balance issues in walking or running.

Nitesh Kumar, who had won a silver medal in the Asian Para Games last year, also qualified for the semifinals of men's singles SL3 category after recording a straight-game win in his last group match.

Nitesh topped Group A after outplaying Mongkhon Bunsun of Thailand 21-13 21-14, notching up his third successive win.

However, it was a heartbreaking end to Krishna's campaign as he twisted his ankle during his must-win SH6 group B match against Thailand's Meechai Natthapong.

Following his loss against Miles Krajewski, Krishna needed to win the match with a good point difference to stay in the hunt but he sustained the injury while lagging 20-22 3-11 and was forced to retire.



"I had to win in straight games to reach knockout, but I lost the opening game but luck hasn't been on my side. My ankle twisted in second game, so I had to retired. I will try to comeback stronger next time," Krishna said after the match.

For Sukant, this was his second consecutive win in the three-player group.

"It's my debut tournament. I am so happy to qualify for the semifinals," said Sukant, who had won a bronze in the Asian Para Games last year.

"I was well prepared for today's game. The first match was much tougher than this. And against him I have played plenty of times and I was very confident. So, I wanted to go one point at a time and then I played really well." In the men's SL4 competition, only the top-

pers from each of the four groups qualify for the semifinals. In SL3 class, which is meant for players

with severe lower limb disability competing on half-width court, the top two finishers from each of the two groups qualify for the semifinals.

Therefore, apart from Nitesh, Bunsun also qualified for the semifinals as the secondplace finisher from group A.

In the group A, Tokyo Paralympics bronze medallist Manoj Sarkar, who has already bowed out of the tournament, beat Yang Jianyuan of China 21-1 21-11. Manoj had earlier lost to Bunsun and Nitesh.

In SL4, Tarun Dhillon, however, couldn't make it to the semifinals after finishing second in group D following his 7-21 16-21 loss to France's Lucas Mazur, who topped the group

In men's SL4 competition, only the toppers from each of the four groups qualify for the semifinals.

Meanwhile, Mandeep Kaur entered the

quarterfinals of the women's singles SL 3 category after defeating Australia's Vinot Celine Aurelie in the women's singles SL 3 event on Saturday.

Mandeep regrouped to win her last group B match 21-23 21-10 21-17 against her Australian rival. She had lost her opening match to Nigeria's Bolaji Mariam.

The Indian finished second in the threeplayer group B to book a quarterfinal spot. Mariam topped the group to enter the semifinals.

The toppers of group A and C directly advanced to the semifinals. The top two teams in group B as well as second-place finishers in group A and C compete in the quarterfinal for the two remaining semifinal spots.

In women's singles SU5 which is for athletes with upper limb impairments, second seed Manisha Ramadass suffered a 15-21 7-21 loss to Yang Qiu Xia to finish second in group C.

The Indian, whose right arm got damaged even before she was born due to a clinical mistake by doctor, thus will be playing the quarterfinals, while the Chinese moved into e semis after topping the group.

Nithya Sre Sumathy Sivan, the top seed in women's singles SH6, went down 20-22 18-21 against Lin Shuangbao of China in her third match to finish second in the group.

The 19-year-old from Tamil Nadu, who won two bronze medals at the 2022 Asian Para Games, will play the quarterfinals, while her opponent will get a bye into the semifinals

In men's singles SH6, Sivarajan Solaimalai ended his campaign with a third successive loss, going down 12-21 10-21 to Krysten Coombs of Great Britain. (PTI)

# Manisha sets up semifinal duel with Thulasimathi to assure India another medal; Palak, Mandeep bow out

PARIS, Sept 1: India were assured of a second medal in badminton with Manisha Ramadass setting up a women's singles SU5 semifinals duel with compatriot Thulasimathi Murugesan at the Paris Paralympics here on Sunday.

The 19-year-old Manisha, who was born with Erb's palsy which affected her right arm, had no trouble in dispatching Japan's Mamiko Toyoda 21-13 21-16 in the quarterfinals.

Erb's palsy is a nerve disorder in the shoulder and arm that results in weakness or loss of muscle function.

The second seeded Indian left-hander needed 30 minutes to down her unseeded rival.

In the last four, Manisha will meet top seed Thulasimathi, who had defeated Portugal's Beatriz Monteiro in group A on Saturday.

In SU5 category, the players have impairment of the upper limbs. The npairment could be on the playing or non-playing hand.

On Saturday, Sukant Kadam earned the right to take on compatriot Suhas Yathiraj in SL4 semifinals to assure the country its first medal in badminton from this edition of the Games.

However, Mandeep Kaur and Palak Kohli were eliminated following contrasting defeats in their respective quarterfinals here on Sunday.

Competing in SL3 category, Mandeep hardly posed a challenge to Nigeria's third seed Bolaji Mariam Eniola, losing the contest 8-21 9-21 in 23 minutes.

It was the second consecutive defeat for Mandeep against Eniola, having lost to the Nigerian in the group stage as well.

SL3 category is for players with severe lower-limb disability competing on a half-width court.

In SL4 category, para world championship bronze medallist Palak went down fighting 19-21 15-21 to Indonesia's Khalimatus Sadiyah in 28 min-

SL4 is a class for athletes competing while standing with less severe impairment than in SL3.

Later in the day, Nithya Sivan Sumathy will compete in the last-eight stage in SH6 category against Poland's Oliwia Szmigiel.

The men's singles semifinal in SL4 category will be an all-Indian affair with Yathiraj and Kadam clashing against each other.

Nitesh Kumar will fight it out with Japan's Daisuke Fujihara in the men's singles semifinal in SL3 category. (PTI)

# Purani Dilli 6 beat West Delhi Lions by Boxing's future hangs in balance after Asian body votes in favour of IBA 6 wickets, climb to 3<sup>rd</sup> place in DPL

NEW DELHI, Sept 1: Purani Dilli 6 defeated West Delhi Lions by six wickets to register their fourth win in the ongoing Delhi Premier League

at the Arun Jaitley Stadium here. Purani Dilli 6 on Saturday bowled out West Delhi Lions for 139 and then chased down the target with 11 balls to spare.

Kesha Dalal played a match-winning knock as he smashed 47 runs off 30 balls. Ayush Singh was the pick of the bowlers, taking four wickets for Purani Dilli 6

Chasing 140, Purani Dilli 6 got off to a good start with the openers scoring 40 runs in four overs.

However, Arpit Rana departed in the fifth over. Manjeet and Yug Gupta stitched a brief 27-run stand before the latter got out in the eighth over. Purani Dilli lost two more wickets in the coming overs as West Delhi

Lions got hold of the match. But Keshav and Lalit Yadav built an unbeaten 59-run partnership to

seal the game for Purani Dilli 6. (PTI)

AL AIN (UAE), Sept 1: Boxing's already uncertain Olympic future was thrown into further jeopardy after the sport's Asian governing body voted against leaving the suspended International Boxing Association (IBA) to join the rival association.

The polling was held via a secret ballot on Saturday with 21 countries voted to continue with IBA, while 14 cast their ballot in favour of joining World Boxing (WB), a breakaway body which is aiming for recognition of the International Olympic Committee (IOC). There was one invalid vote.

Besides India, which participated as an observer, the other countries whose names figured on the roll call included. Bahrain. Bhutan, Brunei, Cambodia, China, Chinese Taipei, Timor Leste, Hong Kong, Indonesia, Iran, Iraq, Japan, Jordan, Kazakhstan, Kyrgyzstan, Laos, and Lebanon.

Other members present were Macau, Malaysia, Myanmar, Nepal, Pakistan, Palestine, Philippines, Qatar, Saudi Arabia, Singapore, Sri Lanka, Syria, Tajikistan, Thailand, Turkmenistan, United Arab Emirates, Uzbekistan, Vietnam and Yemen.

The IOC has time and again reiterated its threat to leave boxing out of the 2028 Olympics if national federations continue to align themselves with the suspended IBA.

World Boxing has 42 members currently while suspended IBA has more than 100 affiliated units. With the Asian Boxing Confederation (ASBC) refusing to join the IOC 'promoted' WB, the Olympic future of the sport hangs in a balance.



However, Boxing Federation of India (BFI) president Ajay Singh, who was present at ASBC's extraordinary congress, is confident WB will get to the 50-member mark it requires to receive the provisional recognition by the end of the year.

"India is taking all possible steps to ensure that boxing remains a part of the Olympic movement. It is clear that the International Olympic Committee will not accept IBA as the international parent body for boxing,' Singh told PTI on Sunday.

"India has chosen to support World Boxing as the only viable alternative. Yesterday's vote showed that 14 countries that are part of the ASBC are keen to join World Boxing.

"We are confident that World Boxing will soon have the requisite strength to apply and be accepted by IOC as the governing body for boxing," he added.

It is also learnt that a few of the 14 Asian countries that voted in favour of joining WB will be putting in their application to join the breakaway body soon. (PTI)
