## Over 25 pc micro and small units struggling to survive in NE: Study

GUWAHATI, Sept 25: A study by the MSME Export Promotion Council (EPC) stated that over 25 per cent of micro and small enterprises in Northeastern states are struggling to survive and suggested a five-point strategy to revive these units and support new startups.

The region hosts around 74,000 MSMEs, but many face crises due to challenges such as a lack of affordable finance, rapidly changing technology and inadequate infrastructure, it said.

MSME EPC chairman Dr D S Rawat, while releasing the study report in New Delhi on Wednesday, said many startups have come up and helped the region in providing jobs, but some of them are in deep crisis in the absence of hand-holding either by large units or institutions.

To address these issues, the EPC has recommended that state governments establish high-powered committees to prioritise the challenges faced by MSMEs.

They suggested developing a roadmap to create a conducive environment for tapping into the region's potential, focusing on skill development, opening showrooms for MSME products, and connecting these enterprises with research and development centres and global marketing agencies. The study emphasised the need for a new financing model that involves the DoNER ministry, multilateral institutions, and private (CONTD. ON PAGE-2)

## INDIA bloc will hit road if J-K statehood not restored after polls: Rahul Gandhi

JAMMU, Sept 25: Congress leader Rahul Gandhi on Wednesday said restoration of statehood was the "right" of people of Jammu and Kashmir, asserting that the INDIA bloc will hit the road and use "full force" in Parliament and outside if the Centre fails to restore it after assembly polls.

In an election rally here, he said the 2019 decision to bifurcate the erstwhile state into two Union territories (UTs) was "a grave injustice" to the people of Jammu and Kashmir.

"This has never happened in the history of India that we have taken away statehood and transformed a state into a Union territory," Gandhi, who is the leader of opposition in Lok Sabha, said.

"It should have never happened, and I guarantee you that if the BJP does not restore statehood after the elections, we the INDIA alliance — will use our full force in the Lok Sabha, Rajya Sabha, and even take to the streets for the restoration of statehood to J&K," he asserted. This rally marked Gandhi's third visit

to the region in nearly three weeks, fol-



lowing prior stops in Banihal and Dooru on September 4 and in Surankote and Central-Shalteng on September 23. His visit comes ahead of the crucial third phase of the assembly elections, with the first round having taken place on Septem-

ber 18 and the second on September 25. Gandhi criticised the current administration for allegedly prioritising "outsiders" over local residents, claiming that the presence of the Lieutenant Governor has marginalised local interests.

"As long as the Lt Governor is there,

outsiders will benefit and locals will be sidelined," he said, arguing that the statehood was revoked to facilitate governance by non-residents.

He told the youths that the restoration of statehood is "your right and your future" and J&K cannot move forward without it

Gandhi began his day in Jammu with an interaction with local professionals at a hotel before heading to JK Resort Ground for the rally. He further stated that the restoration of statehood is crucial for the region's future, asserting, "J&K cannot move forward without it.

In addition to his focus on statehood, Gandhi criticised the central government's economic policies, alleging that they favour a select few business magnates. "This government runs for Ambani and Adani," he claimed, denouncing the GST and demonetisation as tools designed to benefit these conglomerates.



## Dairy is sensitive sector; no plans to open up in any FTA: Goyal

merce and Industry Minister Piyush Goyal on Wednesday said dairy is a sensitive sector in India as it involves livelihood issues of small farmers and there are no plans to give duty concessions under any Free Trade Agreement (FTA) in this area.

He said India has not given any duty concessions in the dairy sector even to Switzerland and Norway under the EFTA (European Free Trade Association) trade pact, which was signed in March.

With Australia also, he said, the sector was discussed but India clearly conveyed the sensitivities involved in this area.

"Our average holding with the farmer is small. It is 2-3 acre farm with 3-4 livestock whereas Australia's farm and dairy farms are both very large and it would be near impossible for these large and small farms to compete with each other on a common footing.

"We had discussed this issue even three years ago and on earlier occasions also, and dairy is such a sensitive sector that in any of our FTAs across the world, we have not been able to open up the sector with duty concessions," Goyal told reporters in a joint press conference at Adelaide with Australian Trade Minister Don Farrell.

The minister is in Australia for bilateral talks to promote trade and

He said the sector is open for trade but there are certain customs duties imposed on that.

"We have neither opened up dairy for Europe nor planning to open up...nor have we opened it with Switzerland and Norway with whom we have recently signed EFTA trade agreement," he said adding "This is the agreement that

Goyal was responding to a question on India's hesitancy on removing barriers to Australian exports in sensitive sectors like dairy. On CECA talks, the Indian minister said that both the countries are aware of each other's sensitivities.

"So any issue that I can see Australia will be uncomfortable with, I would not like to push, press on that, and likewise our approach has been that if something is very sensitive to a large Indian population given our current status of development, Australia has been very gracious in their understanding of our sensitivities," he said.

Further, Goyal flagged outstanding issues of ECTA (Economic Cooperation and Trade Agreement) for early progress including timely conclusion of Mutual Recognition Agreements (MRAs) in Services and Organics

Farrell said that Australia has a lot to offer to India in agriculture, as well as the emerging sectors.

Asked about the progress of talks on CECA, the Australian minister said that in terms of agriculture, "we are talking about the removal of all of the tariffs that weren't removed at the last process, so we've

made significant progress". "So things like chickpeas, pistachios, and apples...all of the issues, all of the products where there are still tariffs, wine is another one we are seeking to have those tariffs removed" he said

On Whyalla steelworks issue, the minister said that he is aware that there have been some discussions between Prime Minister Narendra Modi and his Australian counterpart.

"Obviously steel making is a very important business in Whyalla. As a government we want to see steel making continue, and of course all of those jobs be protected, and we will, of course, continue those discussions between the Prime Minister and the Premier,"

India and Australia implemented an interim trade agreement in December 2022 and now they are in negotiations to widen the scope of the pact through CEPA.

The bilateral trade between the two countries dipped to USD 24 billion in 2023-24 from USD 26 billion in 2022-23. The trade is in favour of Australia as India's exports stood at USD 7.94 billion in the last fiscal year, while imports were at USD 16.15 billion.

Australia is the 25th largest investor in India with foreign direct investments of USD 1.5 billion during April 2000 and June 2024. Goyal also announced opening up of the Invest India office soon in Sydney to help promote bilateral investments.

He said that India offers huge opportunities for investments as it has the advantage of four 'Ds' democracy, demographic dividend, demand and decisive leadership.

The two sides are looking to double the bilateral trade to USD 100 billion in the coming years.

Farrell also announced USD 10 million in new grants for Australian businesses, organisations and universities to boost cooperation with India.

By extending the USD 10 million Maitri Grants programme, the government will deliver, firstly, USD 5 million for Australian organisations working on projects that boost trade and innovation, cultural ties and community leaders, and then a further USD 5 million for scholars and fellowships to support Australian universities to host some of the brightest Indian students in their research, on some of "our biggest" shared challenges.

Goval said that the Invest India office will be set up "shortly" to cover four areas - investment, trade, technology, and tourism. It will have representatives from Invest India, the organisation responsible for building industrial smart cities and townships (NICDC), Export Trade and Guarantee Corporation, and CII.

# ADB retains India's growth forecast at 7 pc; govt spending, agriculture to boost economy

**NEW DELHI, Sept 25:** The Asian Development Bank (ADB) on Wednesday retained India's growth forecast for the current fiscal at 7 per cent saying better farm output and higher government spending will boost economic activity.

In its Asian Development Outlook (ADO) update of September, the ADB said exports in the current fiscal will be higher than earlier projected, led by larger services exports. However, merchandise export growth will be relatively muted through the next fiscal.

"GDP growth is expected at 7 per cent in fiscal year 2024 (FY2024, ending 31 March 2025) and 7.2 per cent in FY2025, both as forecast in ADO April 2024," the ADB said, adding that India's growth prospects remain robust.

The Indian economy grew 8.2 per cent in the last fiscal (2023-24). The RBI projects growth to be 7.2 per cent in the current fiscal.

It said while GDP growth slowed to 6.7 per cent in the first quarter (April-June) of FY2024, it is expected to accelerate in the coming quarters with the improvement in agriculture and a largely robust outlook for industry and

"India's economy has shown remarkable resilience in the face of global geopolitical challenges and is poised for steady growth," ADB Country Director for India Mio Oka said

"Agricultural improvements will enhance rural spending, which will complement the effects of robust performance of the industry

and services sectors," he added. The report highlights that an above-average monsoon in most



parts of the country will lead to strong agricultural growth, enhancing the rural economy in

Private consumption is expected to improve, driven by rural consumption fuelled by stronger agriculture and by already robust urban consumption.

The outlook for private investment is upbeat, but growth in public capital expenditure, heretofore high, will moderate in FY2025.

Efforts toward fiscal consolidation are expected to drive down the fiscal deficit to a level last seen before COVID-19, reflecting robust revenue collection and restrained current expenditure, the ADB said.

With the government's fiscal consolidation efforts, central government debt is projected to decrease from 58.2 per cent of GDP in 2023-24 to 56.8 per cent in

The general government deficit, which includes state governments, is expected to fall below 8 per cent of GDP in the current fiscal.

A recent policy announcement

offering workers and firms employment-linked incentives could boost labour demand and bolster job creation starting in FY2025, it

The Budget 2024-25 has announced three employment-linked incentive schemes and said the government would allocate Rs 2 lakh crore to implement them.

"Growth slowed year-on-year (yoy) in the first quarter (Q1) of FY2024 but is expected to rise in the coming months on improved agricultural performance and higher government spending.

Industry and services are expected to continue performing robustly," the ADB said.

Elevated food prices will likely mean higher inflation in the current fiscal than previously forecast, but inflation should moderate in the next fiscal, the ADB said.

Consumer inflation is anticipated to rise to 4.7 per cent in the current fiscal due to elevated food prices, despite higher agriculture output expectations. This has prevented India's central bank from

adopting a more accommodative monetary policy, the ADB said.

"If improved agricultural supply leads to moderating food price increases, the central bank may begin lowering policy rates in FY2024 (2024-25), enhancing prospects for credit expansion," it said. The current account deficit will remain moderate, helped by strong service exports and remittances.

ADB projected India's current account deficit to be 1 per cent of GDP this fiscal and 1.2 per cent in the next, down from the previous forecast of 1.7 per cent for both years, due to better exports, lower imports, and strong remittance inflows. "Near-term growth risks include geopolitical shocks that could disrupt global supply chains and commodity prices, as well as weather-related risks to agricultural output. The outlook is based on the central government achieving its capital expenditure target in FY2024," it said.

ADB said growth in developing Asia remained strong during the first half of 2024, supported by domestic demand and continued recovery in exports. The growth outlook for developing Asia has been revised slightly upward to 5 per cent for 2024 from 4.9 per cent in April.

However, downside risks persist from rising protectionism, depending on the outcome of the presidential election in the United States, which could lead to negative real and financial spillovers in developing Asia.

Other risks to the outlook relate to escalating geopolitical tensions, a deterioration in China's property market, and adverse weather conditions. (PTI)

## Sensex ends above record 85,000 level, Nifty scales 26K mount on fag-end buying

MUMBAI, Sept 25: Benchmark Sensex closed above the 85,000 level for the first time while Nifty scaled the 26,000 peak at close on Wednesday as fag-end buying in banking and power shares helped stock markets recoup early losses.

After a see-saw trade during the day, the 30-share BSE Sensex rose by 255.83 points or 0.30 per cent to settle at an all-time high of 85,169.87. During the day, it surged 333.38 points or 0.39 per cent to hit a record intra-day peak of 85,247.42. As many as 20 Sensex shares closed in green while 10

The broader Nifty climbed 63.75 points or 0.25 per cent to close above the 26,000 level for the first time. The 50-issue index closed at a record high of 26,004.15 after scaling a new intra-day peak of 26,032.80.

From the 30 Sensex firms, Power Grid, Axis Bank, NTPC, Bajaj Finserv, Bajaj Finance, Tata Steel, Mahindra & Mahindra and

Tech Mahindra, Tata Motors, Titan, Kotak Mahindra Bank, State Bank of India and JSW Steel were the biggest laggards.

"After a range-bound trade, the benchmark indices inched higher towards close, led by power and banking stocks, while mid- and small-cap indices experienced corrections driven by valuation concerns," Vinod Nair, Head of Research, Geojit Financial Services said. The domestic market may face short-term challenges owing to a decline in FIIs inflow and shift of funds to other emerging markets due to their cheap valuation, he added.

"Nifty 50 recovered from day's low in the last leg of the trade to end at record close. A brief Chinaled rally seemed to be dying out, leaving shares in Europe and Asia mixed on Wednesday after a strong start that had extended overnight gains on Wall Street," Deepak

NEW DELHI, Sept 25: State Bank of India (SBI) is aiming to become the first Indian financial firm to cross a milestone of ₹ 1 lakh crore net profit in the next 3-5 years, chairman of the country's largest lender C S Setty has said. SBI recorded a standalone net profit of ₹ 61,077 crore in FY24, registering a growth of 21.59 per cent. "We have potential. Definitely, we would like to be the first company in India to reach that milestone," Setty said when asked if it is possible to cross ₹ 1 lakh crore in the next 3-5 years.

## **High Court orders reinstatement of Batadroba Than Management Committee**

NAGAON, Sept 25: The Gauhati High Court on Tuesday intervened in the longstanding dispute surrounding the historic Batadroba Than Management Committee, bringing relief to the revered Batadroba Than, the birthplace of the great Vaishnavite Saint Srimanta Sankardev

The committee had been embroiled in controversy following the formation of a parallel committee, which led to widespread criticism and outrage. The parallel committee was formed after a faction of members disrupted the biennial general meeting on June 9, violating constitutional norms. The permanent management committee filed an affidavit in court, stating

that the parallel committee was unconstitutional. The court initially ruled in favor of the parallel committee on July 2 but later reversed its decision following an appeal by the permanent committee.

In a landmark judgment (Case No. MJ-84/2024), the High Court upheld the legitimacy of the permanent committee led by president Jogendra Narayan Dev Mahanta, restoring order and ending the five-monthlong stalemate at the historic Batadroba Than, birthplace of Mahapurush Srimanta Sankardev.

**DIPHU**, Sept 25: At a time when the State cabinet has taken a decision to regularise the posts of 131 LP school teachers of Karbi Anglong, the 189 ME school teachers of the district have questioned the state government as to why they are being left out in the cabinet decision for regularisation process.

The 189 ME school teachers have expressed their displeasure for the indifferent attitude shown towards them by the State government and have made a fervent appeal to the Chief Minister of Assam, Himanta Biswa Sarma to take up the matter in the next cabinet meeting for regularisation of the posts.

Expressing their displeasure before the media here at Diphu Govt. Boys HS school playground, where the aggrieved teachers have assembled and one among them Anita Rongpipi said, "It was on April 15, 2022, our Chief Minister of Assam Himanta Biswa Sarma had himself handed the appointment letters to us. For the first 6 months we received provisional



salaries and after that no salaries were given to us. It is now 25 months since we have not received our salaries.'

Due to such challenges the teachers are compelled to come out on the streets to express their grievances, Rongpipi stated and said that it is not known why the matter is still pending, but every time the teachers approach the concerned officer they say things will be settled very soon. She said, "Yesterday in the State cabinet meeting passed a resolution for regularisation of 131 posts of LP teachers. We fervently appealed to our chief minister to take up the matter in the next cabinet meeting for approval of the posts when it is

Joining with her is another teacher Rumi Kropi, where she explained that the teachers have endured much hardship. #### **Easing business in India**

s India marks the 10th anniversary of the Make in India initiative on September 25, 2024, the government's commitment to enhancing the ease of doing business continues to be at the forefront. The flagship program, launched in 2014, aimed to transform India into a global manufacturing hub. However, despite significant efforts, the initiative has yet to deliver the anticipated results. To address lingering hurdles, the Modi government decriminalized 183 provisions across 42 central laws in 2023. Now, it plans to go further by decriminalizing 300 more provisions, aiming to reduce the compliance burden for businesses and boost foreign investment. But the question remains: will these measures truly accelerate India's journey to becoming a manufacturing powerhouse? India's ranking in the World Bank's Ease of Doing Business index has improved significantly since 2014, moving from 142nd to 63rd by 2019. While this is a commendable achievement, the desired momentum in foreign direct investment (FDI) has been slow to follow. FDI inflows, which stood at \$45.15 billion in 2014-15, increased to \$83.57 billion by 2021-22, but this modest rise indicates that regulatory reform alone may not be enough to attract the level of investment needed.

The government's Make in India 2.0 initiative, launched in 2019, targets 27 sectors, with a renewed focus on both manufacturing and services. Various policy measures, such as the Production Linked Incentive (PLI) schemes and the National Infrastructure Pipeline (NIP), were rolled out to boost domestic and foreign investments. Yet, despite these efforts, FDI inflow in the manufacturing sector remained limited, totalling only \$165.1 billion over the past decade. The Modi government has placed significant emphasis on reducing the compliance burden to encourage investment. The Jan Vishwas (Amendment of Provisions) Act, passed in 2023, was one such attempt to simplify regulations by decriminalizing numerous business-related provisions. However, the results have been underwhelming, raising doubts about whether further decriminalization will make a tangible impact. While regulatory hurdles undoubtedly play a role in discouraging investment, they are not the only barriers. India's socio-political environment has also been a critical factor in limiting the success of Make in India. Frequent disruptions, such as internet shutdowns, curfews, and escalating political tensions, have adversely affected industrial relations and market stability. These factors create an unpredictable business climate, which cannot be addressed solely through legal

The government must go beyond regulatory simplification and tackle the broader socio-political issues that deter investors. Stable connectivity, peaceful industrial relations, and a conducive business environment are just as crucial to attracting investment as reducing red tape. Furthermore, labour reforms must be handled with care to ensure that the workforce is not sidelined in the pursuit of profit. To truly transform India into a manufacturing hub, the focus must extend beyond business interests to include social welfare and human development. A harmonious balance between easing business operations and ensuring workforce security is vital for sustainable growth. Decriminalization alone will not suffice what is needed is a more comprehensive approach that addresses both economic and social challenges. Additionally, fostering trust between businesses, labour unions, and the government is crucial for sustainable growth and long-term success. Only with a peaceful and stable environment can India hope to realize the full potential of Make in India and truly become the global manufacturing hub it aspires to be.

angladesh will not have b to wait 101 years, and happens in countries to wait for years, as it where popular people's revolutions have ousted autocratic regimes and military dictators.

The election in Bangladesh is expected sometime in the winter of 2025. In a rare press interview. General Waker-uz-Zaman. the chief of the Bangladesh Army, told world-reputed British news agency, Reuters that a transition to democracy should be made between a year and a year-and-a-half, but urges to hold patience.

In line with sweeping government, reforms proposed since Hasina was shunted from power, the army, too, is looking into allegations of wrongdoing by its personnel and has already punished some soldiers, Zaman said, without providing further

## Quad summit at Delaware was US president's swan song in diplomacy

he latest Quad Summit is largely seen as an effort by the US President Joe Biden to leave a lasting legacy. Though Prime Minister Narendra Modi ticked all boxes, yet nothing substantial for India was gained at the summit, apart from

PM Modi along with President Joe Biden, Australian Prime Minister Anthony Albanese, and Japanese Prime Minister Fumio Kishida attended the Quad Summit at President Biden's hometown of Wilmington, Delaware, 100 miles north of capital, Washington DC, last weekend.

India was initially set to host the Quad summit this year but agreed to swap duties as Biden's time in office will end in next two months. The leaders met ahead of the UN General Assembly in New York City this

The Delaware Summit is also seen by many analysts as an attempt by President Biden aiming to put a final stamp on an alliance he hopes will endure beyond his presidency. Or which might be referred to in the broader context of a Biden Doctrine. Concerns are also being raised about the fate of the Quad, if Trump returns to

At the summit, China and its actions in the South China Sea were first on the agenda. At the start of the discussion, Biden was caught in a hot mic moment and could be heard saying that Chinese President Xi Jinping is looking to "buy himself some diplomatic space, in my view, to aggressively pursue China's in-

"We believe Xi Jinping is looking to focus on domestic economic challenges and minimise the turbulence in China diplomatic relationships," Biden could be heard saying.

In a joint statement after the summit, the leaders of the Quad countries said that they are "seriously concerned" about China's escalations in the South China Sea, without naming the



country by name.

Biden emphasised that his administration views Beijing's actions as a tactical shift rather than a fundamental change in strategy. The Quad leaders also unveiled a significant strategy to bolster maritime security cooperation in the Indo-Pacific and pledged for lasting peace in Ukraine.

Prime Minister Narendra Modi reaffirmed the Ouad's commitment to a rules-based global order, emphasising respect for national sovereignty and territorial integrity. In his address, Modi said a free, open, inclusive, and prosperous Indo-Pacific is a shared priority of the

The leaders also announced a new regional Maritime Initiative for Training in the Indo-Pacific (MAITRI), to enable partners to maximize tools provided through Indo-Pacific Maritime Domain Awareness (IPMDA) and other Quad initiatives.

In addition, an expansion of the Indo-Pacific Partnership for Maritime Domain Awareness, which helps countries monitor illegal fishing and other unlawful activities in their waters, to the Indian Ocean and provide partners with more sophisticated technology and training, was also announced.

They also launched a logistics network to allow the US military to share cargo space on aircraft and vessels to be used in humanitarian assistance or disaster relief operations. The partnership will also roll out new Open Radio Access Network pilot projects in the Pacific Isands and Southeast Asia.

## "Frontier Nagaland Territory's legal case for direct central funding: Implications of proposed reforms"

nder the Indian Self-Determination and Education Assistance Act (ISDEAA) of 1975, tribes are empowered to manage federal funds dibypassing intermediaries. This Act allows tribes to enter into contracts and compacts with federal agencies to administer programs that address their specific needs, such as healthcare, education, and infrastructure. The success of this model has significantly contributed to the socio-economic upliftment of Native American communities, providing a blueprint for similar governance reforms in India.

Adopting such a model in the Indian context would not only enhance governance but also ensure that tribal regions / backward among backward tribal regions are no longer left behind in the nation's development trajectory. This direct funding model has led to a significant improvement in resource allocation and governance outcomes, ensuring that tribal governments have the autonomy to prioritize their developmental goals.

Moreover, the U.S. approach is bolstered by the Federal Trust Responsibility, a legally binding obligation requiring the federal government to protect tribal assets, resources, and treaty rights. Through the Bureau of Indian Affairs (BIA) and other federal agencies, Native American tribes receive grants and other financial resources directly, ensuring that funds are not diluted or misallocated by state governments. This legal provision has fostered greater transparency, accountability, and efficiency in the use of federal funds, significantly empowering tribal communities to govern themselves and manage their development more effectively.

The parallels between the U.S. system and the situation in Eastern Nagaland (in our case, Tribal backwards among Tribal backwards) are evident, with both contexts demonstrating the necessity of aligning financial mechanisms with the unique governance needs of indigenous populations. Implementing a similar direct funding model in India would represent a significant step towards fulfilling the constitutional promises made to its tribal communities. The parallels between the U.S. system and the situation in Eastern Nagaland and the demand for Frontier Nagaland Territory underscore the potential benefits of adopting a similar approach in India starting with proposed Frontier Nagaland Territory as a test case, especially given the constitu-

as Naga tribal areas under Article 371(A) and related provisions.

The U.S. case strengthens the argument of the ENPO for direct funding from the central government in India. By demonstrating that direct funding, coupled with appropriate legal frameworks, can improve governance and development outcomes, the U.S. model serves as a compelling example of how India could reform its approach to funding tribal re-

The American experience shows that when tribal communities are entrusted with managing their own resources, with proper oversight, strict legal framework, robust system of accountability, checks and balances and constructive support and direct intervention from the central government, they can make more effective use of funds tailored to their unique socio-economic contexts. This evidencebased approach highlights the importance of empowering local governance structures to handle their own affairs, a principle that resonates with the aspirations of the ENPO for Frontier Nagaland.

Adapting such a model to the Indian context could revolutionize the way tribal regions are integrated into the national development agenda. This model could be adapted to the Indian context starting with the proposed Frontier Nagaland Territory as a test case, where constitutional provisions already exist for special treatment and autonomy for tribal areas, further reinforcing the case for direct funding. However, critics caution that direct funding alone may not resolve the region's complex challenges. Without robust legal frameworks, direct supervision from New Delhi and effective and transparent local implementation mechanisms, even direct funding may not yield the desired development outcomes.

Past experiences in the ENPO region. where development funds often failed to translate into tangible benefits due to mismanagement and corruption, underscore the need for stringent oversight and active local agency involvement to ensure effective use of resources in the proposed Frontier Nagaland Territory. This also calls for a simultaneous strengthening of local traditional governance institutions and also various government bodies that will come under proposed FNT, ensuring that they are equipped with the necessary tools and capacities to manage funds responsibly.

Transparent and accountable traditional institutions as well as government institutions are the bedrock of successful governance, making the fight against corruption an integral part of this reform state governments comply with laws en- constitutionally sound. acted by Parliament and ensure the implementation of these laws.

While Article 256 requires states to follow the directions given by the central government, it does not directly address direct funding. However, effective governance, particularly in the context of direct funding, indeed necessitates a clear legal and institutional framework, which could be reinforced by compliance with central directives under this Article.

The proposed Frontier Nagaland Terri tory would operate under Article 371(A) of the Constitution, which grants Nagaland special autonomy to manage its internal affairs, including religious and social practices, customary law and procedure, administration of civil and criminal justice, and ownership and transfer of land and resources. This special provision allows the FNT to leverage an existing constitutional framework tailored to the region's specific needs, ensuring an effective and culturally appropriate governance structure that reflects local customs and aspirations. This constitutional framework is pivotal in ensuring that the development initiatives are not only effective but also resonate with the sociocultural ethos of the region.

Moreover, it enables the FNT to operate with a level of constitutional autonomy that is crucial for sustainable and inclusive development, providing an effective model for other tribal regions in India. The autonomy granted to the proposed Frontier Nagaland Territory under Article 371(A) is crucial for tribal regions, where governance must be sensitive to unique cultural and social practices, ensuring that development initiatives align with the region's specific needs and requirements.

As is widely recognized, the proposed Frontier Nagaland Territory (FNT) will not be governed under the Sixth Schedule of the Constitution of India, which typically provides for autonomous councils in tribal areas. Instead, it will operate under the unique provisions of Article 371A. This unique constitutional framework under Article 371A grants Nagaland special autonomy, particularly concerning religious and social practices, customary law, and ownership of land and resources. Given this distinct status, there are no constitutional or legal barriers to extending direct funding to the proposed FNT. This distinct constitutional positioning of the FNT offers a significant opportunity for pioneering governance reforms in tribal regions in India.

This makes the FNT a potential model for financial governance in tribal areas, offering valuable insights for the Government of India as it seeks to reform and improve financial governance across other tribal regions, potentially setting a precedent for more responsive and effective resource allocation in areas with unique governance needs.

In summary, the direct funding model demanded by ENPO for the Frontier Nagaland Territory not only aligns with existing constitutional provisions but also enhances the autonomy and self-governance of tribal regions, addressing longstanding developmental disparities. This model would empower the FNT to directly manage and allocate funds according to its specific needs, without the bureaucratic delays and mismanagement that have plagued state-level interventions. The move towards direct funding is a step towards rectifying the historical neglect of these regions, empowering them to chart their own development traiectories. Furthermore, it represents a broader shift in governance philosophy, where underrepresented, backward local communities (backward among backwards in case of Eastern Nagaland Tribes) are recognized as capable and responsible stakeholders in their own development.

By leveraging the special status granted under Article 371(A) and the constitutional flexibility provided by Articles 275(1) and 282, there is no doubt that the FNT could serve as a model for other tribal regions across India. This initiative would not only uplift marginalized communities but also demonstrate the transformative power of our Constitution, which ensures justice and equality for all.

The successful implementation of the proposed Frontier Nagaland Territory would reaffirm India's commitment to preserving the unique identities of its tribal populations and the "backward among backwards" among them; while securing their rightful place in the nation's progress and prosperity. # The new 'green revolution' will not feed India: Lessons for Assam's agricultural future

The promise of natural farming, often referred to as zero-budget farming due to its lack of purchased inputs, has sparked significant debate across India. Agriculture Minister Shivraj Singh Chouhan's recent proposal to increase subsidies for farmers transitioning from Green Revolution techniques to natural farming has brought the issue to the forefront.

While the government has launched the National Mission on Natural Farming with much fanfare, the finance ministry has temporarily rejected an increase in the subsidy from ₹15,000 to ₹ 20,000 per hectare. The divide between supporters and critics of this agricultural approach raises important questions for Assam's future in farming.

#### The Context of Assam's Agriculture

Assam, with its rich agricultural traditions and unique agro-climatic conditions, stands at a crossroads in determining the best way forward for its farming community. The state's agricultural sector, predominantly based on small and marginal farmers, depends heavily on rice, tea, and horticultural crops. The Green Revolution, which dramatically increased India's food producAssam compared to regions center of this transformation, like Punjab and Haryana. This was partly due to Assam's distinct topography, less developed irrigation infrastructure, and a reliance on traditional farming methods.

Natural farming techniques, such as the use of cow dung, crop rotation, and plant-based insecticides, resonate with Assam's historical farming practices. However, the modern challenges faced by farmincluding climate variability, soil degradation, and the need for higher yields to support a growing population, demand a careful evaluation of whether natural farming can truly meet these needs.

#### Lessons from the Green Revolution

The Green Revolution of the 1960s played a pivotal role in making India self-sufficient in food production. During that period, the country faced a food crisis exacerbated by two consecutive years of drought in 1965 and 1966. India was dependent on food aid from the United States, with the country's agriculture producing insufficient grain to feed its population. The introduction of high-yielding varieties of wheat and rice, along with chemical fertilizers and modern irrigation techniques, transformed India's agricultural

still benefited from increased food availability and the gradual adoption of better farming practices.

However, the adverse effects of the Green Revolution, including the overuse of chemical fertilizers, depletion of groundwater, and soil salinity, are issues that Assam's farmers must now navigate. With limited irrigation facilities in many parts of the state, overpumping of water remains a potential risk, while the excessive use of pesticides is already a growing concern.

#### The Rise of Natural Farming: Hopes and Challenges

Agriculturist Subhash Palekar, the father of Indian natural farming, claims that farmers can achieve higher yields using ancient techniques that avoid costly inputs like chemical fertilizers. This idea of returning to traditional, resource-efficient methods appeals to many, particularly in regions like Assam where smallholder farmers often struggle with the high costs of agricultural inputs.

Assam's agro-climatic zones are well-suited for crop diversity, including pulses, vegetables, and medicinal plants that can thrive under natural farming systems. Proponents argue that the state could benefit from adopting zero-budget Assam, although not at the farming techniques, using local

and plant-based insecticides to reduce dependency on external

inputs. However, critics like Swaminathan S Anklesaria Aiyar caution against an over-reliance on natural farming, pointing out that such techniques left India hungry and humiliated in the 1960s. Historically, these practices were used because farmers lacked the money for modern inputs.

While efficient within the limits of old technology, they were not capable of producing enough food to feed a rapidly growing population. Aiyar argues that India's successful escape from famine and food aid dependency was made possible by the technological advances of the Green Revolution.

Scaling Up: The Key Issue One of the biggest challenges with natural farming, as pointed out by critics, is scalability. While isolated cases of high yields have been reported, particularly on small plots of land, the question remains whether these techniques can be expanded to cover larger areas and sustain the food needs of a growing population.

This issue of scalability is particularly relevant for Assam. The state's fragmented landholdings and dependence on subsistence farming mean that while natural farming may offer short-term benefits for feasible for large-scale food production. Moreover, Assam's frequent floods and changing weather patterns pose additional challenges to the implementation of natural farming techniques, which may not be resilient enough to withstand these environmental

#### pressures. The Organic Farming Debate

Organic farming, which is closely related to natural farming, has already established a niche market in India. Organic products, which are often more expensive, appeal to consumers seeking healthier, chemical-free food. In Assam, organic tea and other products are gaining popularity among health-conscious urban consumers.

However, as seen in Sri Lanka's failed experiment with organic farming, transitioning too quickly away from conventional farming can lead to a sharp drop in agricultural output and economic chaos. Assam's farmers, who rely heavily on cash crops like tea and rice, must therefore tread carefully when considering a shift towards organic or natural farming on a larger scale.

The key challenge is that Assam, like much of India, requires a balanced approach. While there is merit in reducing chemical inputs and pro-

resources such as cow dung some farmers, it may not be moting sustainable practices, abandoning modern agricultural techniques entirely could jeopardize food security. Assam's farming community, particularly in flood-prone and resource-constrained areas. needs policies that integrate both modern technology and traditional knowledge.

#### A Path Forward **Assam's Agriculture**

As Assam looks toward the future, the question of how to balance sustainable practices with the need for food security is more relevant than ever. While natural farming offers the promise of reducing costs for farmers and protecting the environment, it cannot be seen as a silver bullet. The state's policymakers must consider a blended approach, incorporating the best of both worlds: the efficiency of modern technology and the sustainability of

traditional farming methods. Investments in research, irrigation infrastructure, and rural credit will be essential for Assam's agricultural growth. Additionally, promoting agroecological practices that combine natural farming principles with modern innovations such as precision farming, integrated pest management, and conservation agriculture could offer a more sustainable

Ultimately, Assam's farmers, like those across India, are the best judges of what works. As Aiyar notes, farmers have been quick to adopt high-yielding varieties and modern techniques when they see tangible benefits. The government's role should be to support them with a range of options, ensuring that they have the tools and knowledge to make informed choices about their farming practices

#### **Conclusion:** Sustainable **Progress**

While the new 'green revolution' of natural farming may not be the panacea for India's agricultural challenges, it offers valuable insights into how farming systems can be made more sustainable. Assam, with its unique agricultural landscape, has the potential to lead the way in developing a balanced approach to farming that embraces both traditional wisdom and modern advancements. By focusing on sustainability, scalability, and food security, Assam can chart a course toward a resilient agricultural future that meets the needs of its people while preserving its natural resources. ## Antibiotic pollution in a warming world

ollowing the World War II, ■ when industrially produced antibiotics emerged, our quality of life and life expectancy substantially improved. A world in awe of the new cure that could beat the once-fatal infection never suspected that bacteria could outsmart the very drugs designed to kill them. As the author of A Short History of Nearly Everything, Bill Bryson aptly puts it: "Because we humans are big and clever enough to produce and utilise antibiotics and disinfectants, it is easy to convince ourselves that we have banished bacteria to the fringes of existence. Don't you believe it. Bacteria may not build cities or have interesting social lives, but they will be here when the Sun explodes. This is their planet, and we are on it only because they allow us to be.'

change today, society faces an unprecedented juncture of Antibiotic Pollution combined with Antimicrobial Resistance (AMR). Rising temperatures allow the increased contamination of our water systems by antibiotic residues, feeding the surge in resistant "superbugs"—bacteria which common medical treatments cannot kill.

A recently published study in the Lancet estimates that more than 39 million deaths will occur due to antibiotic-resistant infections between now and the year 2050. AMR-related deaths are projected to rise by nearly 70 percent by 2050, and South Asia, which includes India, is expected to be the most hit. 11.8 million deaths would likely be attributed to resistant infections over the next 25 years in South Asia. The consequences of inaction could be disastrous, where decades of medical progress could be undone and put public health in jeopardy on a scale never before

#### The invisible pathways of pollution

Antibiotic pollution influences the environment through several key paths, each playing a sizable role in the spread of AMR. Pharmaceutical manufacturing: India, one of the world's largest producers of antibiotics, accounts for more than 20 percent of the world's generic drugs. But this kind of positioning comes at a cost.

The effluents discharged from the manufacturing units, like in industrial belts such as Patancheru-Bollaram industrial estate in Hyderabad, have been found to carry high concentrations of antibiotics like Ciprofloxacin, Ofloxacin, and Azithromycin, at levels thousands of times higher than what is deemed safe. A study estimated the antibiotic residue concentrations in certain Indian rivers, namely the Yamuna and Gomti, to be 2-5 times higher than the limits proposed by the Ministry of Environment, Forest, and Climate

Change. Even with wastewater treat-



ment systems installed, systems usually fail to effectively filter out these antibiotic residues. The Indian pharmaceutical industry, valued at around US\$50 billion, has vet to fully execute stricter wastewater management practices.

Improved surveillance is a significant component of the new World Health Organisation (WHO) guidelines on wastewater management and limiting antibiotic pollution from manufacturing. India is far from the mark as local industries continue to discharge untreated toxic waste into nearby water bodies.

Agriculture and livestock: Increased temperatures and changing disease patterns in agriculture have spurred overuse in livestock and crop production. A major share of antibiotics is consumed by livestock farming in India, with most farmers using antibiotics to promote the growth of their animals. This practice causes significant quantities to seep into the soil and find their way into nearby water bodies.

A 2021 study by the Indian Council of Agricultural Research noted AMR in E. coli and other bacterial samples taken from livestock and shrimps in 12 states. The samples had resistance levels higher in regions where antibiotics were used extensively.

Aquaculture: Aquaculture in India, particularly within shrimp farms along the coastal regions, is highly dependent on antibiotics as infections are too common due to warmer water temperatures. A 2022 study detected Norfloxacin in the waters of the Zuari river (Goa). The concentrations were higher than the WHO recommended limits. With water temperatures rising, the demand for antibiotics also continues to rise. This not only affects marine ecosystems but also poses a risk to public health.

#### Climate change as a pollution

multiplier Climate change also means that the risks posed by antibiotic pollution are amplified, doubling the need for such urgent action. More flooding due to increasing global temperatures sends antibiotic residues derived from pharmaceutical plants, agricultural lands, and urban areas into rivers and

An example to understand this would be to look at monsoon floods this year, the spillover from urban sewage systems, which carry waste containing antibiotics, contaminate local water bodies and create an environment conducive to the amplification of

bacteria that were resistant to those antibiotics. A study finds that over 85 percent of Indian districts are exposed to extreme climate events such as floods. thereby placing more ecosystems at risk of contamination from pollution with antibiotics.

Simultaneously, in northern India and much of the country, the increasing intensity of tants (with evaporation), including antibiotic residues, in shrinking water bodies such as local lakes. This creates a "perfect storm" for bacteria to develop resistance. In addition to this, a warming climate directly drives the proliferation of bacteria. Elevated temperatures allow bacteria little time to multiply; in this case, chances of developing resistance increase. The high temperatures make it possible for bacteria to exchange genes, i.e., horizontal gene transfer, thus spreading the genes carrying antibiotic resistance between additional bacterial

One 2020 article reports that a 10°C temperature increase predicts an added ~5 percent rise in the antibiotic resistance rate of common pathogens like E. coli and S. aureus. In India, with a 0.7°C increment in temperature compared to that in 1901, the accelerated growth of bacteria is contributing to the vicious cycle of escalating antibiotic use and resistance.

#### AMR: A global and Indian public health crisis

It is staggering to realize that drug-resistant infections kill approximately 1.27 million every year, and will rise by 10 million every year by 2050 if rapid action is not taken. Projections estimate that AMR will cause a death toll of 2 million annually in India by 2050 due to its heavy use in health care and agriculture.

India is at the centre of this emerging crisis. With ~1.4 billion people and the world's highest use of antibiotics, it has very particular challenges with both use and pollution. Resistance to antibiotics accounted for an estimated more than 56,000 neonatal deaths in India in 2019 alone, according to an analysis published in The Lancet Microbe. Antibiotic misuse has been rendered possible in light of prevalent over-the-counter availability and lax regulations in human and veterinary medicine.

The healthcare systems are overworked in rural areas, where a course of antibiotics is often used as a quick fix for most general ailments, whether required or not. With WHO support, India drew up the National Action Plan on AMR (NAP-AMR) in 2017, which targets improvement in regulation, education, and surveillance. Yet, the implementation has been sluggish, and the country remains a global hotspot for AMR.

#### Policy and solutions: What

Antibiotic pollution requires more than just awareness; it needs stringent regulatory reform. India, as one of the world's largest antibiotic producers, needs to take greater responsibility for the environmental consequences of this industry. It needs stricter regulations that will offer better governance in terms of disposing of antibiotic waste, with mechanisms to ensure compliance.

According to the WHO 2024 guidelines on wastewater management, monitoring the antibiotic residues in manufacturing effluents is vital.

The broad plan for tackling AMR is given in India's NAP-AMR, but it needs to go further to the local level. Needless to say, stricter regulations are needed concerning the disposal of pharmaceutical waste and the improvement of standards for the treatment of wastewater to cope better with the residues of antibiotics. The country should also strengthen its agriculture by advocating antibiotic stewardship and Climate Smart Agriculture to reduce overdependence on antibi-

India, along with major antibiotic producers like China, must work within global frameworks to enforce limits on pharmaceutical waste. Partnerships between countries, international organisations like WHO, and global industries are vital to stem the tide of antibiotic pollution. **Urgency in action** 

The time to take action on antibiotic pollution is now. Still, with climate change gathering at an accelerated pace, the dispersal of antibiotics in the environment will continue to worsen. The consequences of inaction are dire: millions of lives are at risk, and modern medicine itself could be undermined. This calls for coordination by governments, industries, and the community to reduce antibiotic pollution by bringing in stricter regulations. ## Plastic recycling: A deceptive solution to an escalating crisis

To date, over 10 billion metric tonnes of plastic have been produced worldwide, with plastic production skyrocketing by more than 18,300 per cent over the past 65 years. Currently, around 460 million metric tonnes of plastic are produced annually, and without intervention, this figure is projected to triple by 2050

Despite this massive production and recycling being pitched as the solution for plastic pollution, less than 9 per cent of all plastic ever made has been recycled, 12 per cent is incinerated or openly burned, and the remaining 79 per cent ends up in landfills or the environ-

Plastic recycling, once touted as a cornerstone of environmental sustainability, has proven largely ineffective in combating plastic pollution. Despite decades of advocacy and public education campaigns by plastic manuplastic waste continues to proliferate. This disconnect raises critical questions about the viability of recycling as a sustainable solution.

Historically, plastics were never designed to be recycled. In 1956, a packaging industry executive bluntly declared that "the future of plastic is in the trash can", reflecting the industry's intent for plastic to be disposable rather than recyclable. The recycling process often leads to downcycling, where plastics are transformed into products of lesser quality and utility, such as plastic lumber, park benches,

Many of these products cannot be recycled again, and the process is energy-intensive, contributing significantly to greenhouse gas emissions and contaminating water resources.

Additionally, recycled plastics frequently contain a toxic cocktail of chemicals, making them unsuitable for many applications, particularly food and beverage packaging. Research has shown that these toxic chemicals can leach

into products, posing serious health risks. The concept of plastics circularity, where plastics are endlessly reused without adverse effects, is fundamentally flawed. Current recycling practices exacerbate environmental degradation, climate change, and public health issues. Effective recycling requires significant inputs of virgin plastics and toxic additives, undermining the notion of a closed-loop sys-

For example, when plastics are collected for traditional "mechanical" recycling, they must be sorted by colour and type, washed and shredded. These processes consume large amounts of fossil fuel energy, emitting chemicals and greenhouse gases, wasting and contaminating water, and creating microplastics and nanoplastics.

Moreover, to restore some of the useful properties of recycled plastics, manufacturers often need to mix in virgin plastic and / or toxic additives. Studies have identified hundreds of additional toxic chemicals, including pesticides and pharmaceuticals, in recycled plastics. This is in addition to the mix of more than 16,000 chemicals in the newly made plastics, with over 4,000 of them identified as toxic. This raises further questions on the safety and sustainability of plastic recycling.

Since monitoring of plastic waste trade began in 1988, more than 250 million tonnes have been legally exported across the world, highlighting stark inequalities by often shifting the burden of plastic waste to the Global South. These regions become dumping grounds where plastic waste is frequently burned in the open, releasing toxic pollutants into the air and disproportionately affecting vulnerable communities.

India, for instance, imported around 121,000

metric tonnes of plastic in 2019, according to a report by Pandit Deen Dayal Upadhyay Smriti Manch. The report, along with objections from environmentalists, eventually led the Indian government to ban plastic imports in

Although the government had already banned plastic imports in 2014, a loophole allowed companies in Special Economic Zones to continue importing plastic, which was heavily exploited. This loophole was finally closed in August 2019.

Malaysia has a recycling capacity of 515,009 tonnes but imports an average of 835,000 tonnes of plastic waste each year, in addition to an estimated 2.4 million tonnes of domestic plastic waste. The import of plastic waste has led to severe

environmental and health impacts, with local communities facing polluted air and water, increased disease rates and degraded living conditions. These practices perpetuate environmental injustice, as communities near recovery facilities and recycling plants, typically the most underserved, face increased health risks, including polluted air, soil and drinking water, as well as frequent fires and

exposure to hazardous materials. As awareness of plastic recycling's limitations grows, the plastic and fossil fuel industries have promoted "chemical recycling" techniques, which involve the chemical breakdown of plastics into fuels or other materials. These methods are marketed as innovative solutions but often perpetuate harmful practices, diverting attention from the need to reduce plastic production.

These industries' substantial lobbying efforts aim to maintain the status quo, hindering meaningful progress toward addressing the root causes of plastic pollution. For example, in the United States, significant investments in chemical recycling facilities have faced criticism for failing to deliver promised environmental benefits while continuing to pollute. In Europe, similar projects have also been scrutinised for their environmental impact and questionable effectiveness in reducing plastic

To address the plastic crisis, a paradigm shift is necessary. Policymakers must prioritise reducing plastic production and supporting sustainable, reuse-based solutions. This involves implementing policies that restrict single-use plastics, incentivise reusable alternatives and promote equitable waste management practices. On an individual level, adopting plastic-free habits in daily life can significantly reduce the demand for disposable plastics. Countries like Sweden have made strides in reducing plastic use by implementing strict regulations and promoting reusable alternatives, resulting in lower plastic waste levels.

Scientific consensus and indigenous knowledge emphasise minimising plastic use to protect human health and the environment. For instance, indigenous communities around the world have long practiced sustainable living and resource management, offering valuable insights into reducing plastic dependency. Society must move beyond the false promises of recycling and embrace comprehensive strategies that tackle plastic pollution at its source.

The notion that we can recycle our way out of plastic pollution is a dangerous illusion. Evidence shows that current recycling practices are insufficient and often counterproductive. By focusing on reducing plastic production and fostering a culture of reuse, substantial strides can be made toward mitigating the plastic crisis. It is time to abandon the myth of plastic recycling and implement real, effective solutions that prioritise the health of our planet and its inhabitants. (Courtesy: Down To

## Zelenskyy's victory plan sets Ukraine's terms in desperate war against Russia

President Volodymyr Zelenskyy will present to the White House this week asks the Biden administration to do something it has not achieved in the two and a half years since Russia invaded Ukraine: act quickly to support Kyiv's campaign.

While Western dawdling has amplified Ukraine's losses, some Ukrainian officials, diplomats and analysts fear Kyiv's aim to have the plan implemented before a new US president takes office in January may be out of reach.

US Ambassador to the UN Linda Thomas-Greenfield, reportedly briefed on the plan, said it "can work" but many privately question how.

The specifics of Zelenskyy's blueprint have been kept under wraps until it can be

formally presented to President Joe Biden, but contours of the plan have emerged, including the need for fast action on decisions Western allies have been mulling since the full-scale invasion began in 2022.

It includes the security guarantee of NATO membership, according to Zelenskyy's chief of staff Andrii Yermak — a principal demand of Kyiv and Moscow's key point of contention. Western allies, including the US, have been sceptical about this option.

Zelenskyy has said he will also seek permission to use long-range weapons to strike deep inside Russian territory, another red line for some of Ukraine's sup-

"Partners often say, 'We will be with



Ukraine until its victory.' Now we clearly show how Ukraine can win and what is needed for this. Very specific things," Zelenskyy told reporters ahead of the trip. "Let's do all this today, while all the officials who want victory for Ukraine are still in official positions.

Meanwhile, outnumbered Ukrainian forces face grinding battles against one of the world's most powerful armies in the

east. As Zelenskyy pitches his plan to tory and tens of thousands of lives in the Biden on Thursday, Ukrainian servicemen will be grappling to hold defensive lines in the key logistics point of Vuhledar in the Donetsk region. For some of them, it is essential that Biden buys into Zelenskyy's plan.

"I hope that allies will provide us with what we need," said Kyanin, a soldier fighting in the Donetsk region. "Not 10 or 31 tanks, but a thousand tanks, thousands of weapons and ammunition."

Kyiv sets the terms The victory plan is Kyiv's response to rising pressure from Western allies and war-weary Ukrainians to negotiate a cease-fire. A deal with Russia would almost certainly be unfavourable for Ukraine, which has lost a fifth of its terriconflict. Unless, Kyiv calculates, its western partners act quickly. Ukraine's allies have routinely mulled over requests for weapons and capabilities, granting them often after their strategic value is diminished. Under the plan, from October to December, they must dramatically strengthen Kyiv's hand.

The plan comprises military, political, diplomatic and economic elements.

Aside from the demand for NATO membership, it seeks to bolster Ukraine's defenses, including air defense capabilities, enough to force Moscow to negotiate. A request to ramp up sanctions to weaken Russia's economy and defence industry is also expected.

Zelenskyy has said without elaborating

that Kyiv's military incursion into Kursk, in Russia, is part of the victory plan. That offensive, which embarrassed President Vladimir Putin as the Kremlin scrambled to counterattack, has not yielded any strategic gains. But it has shown the Russian public and doubtful Western allies that Russian is not invincible and Kyiv still has offensive capabilities despite being battered on the eastern front.

The cost of inaction

Zelenskyy has described his proposal as "a bridge to the Peace Summit" that he has proposed for November but that Russia says it will not attend. No international players capable of swaying Moscow agreed to his earlier 10-point peace plan, which calls for the full withdrawal of Russian forces. (AP)

## Hezbollah fires a missile at Tel Aviv in deepest strike yet after Israeli bombardment of Lebanon

lah hurled dozens of projectiles into Israel on early Wednesday, including a missile aimed at Tel Aviv that was the militant group's deepest strike vet and marked a further escalation after Israeli strikes on Lebanon killed hundreds of people.

The Israeli military said it intercepted the surface-to-surface missile, which set off air-raid sirens in Tel Aviv and across central Israel. There were no reports of casualties or damage. The military said it struck the site in southern Lebanon where the missile was launched.

Hezbollah said it fired a Qader 1 ballistic missile targeting the headquarters of Israel's Mossad intelligence agency, which it blames for a recent string of targeted killings of its top commanders and for an attack last week in which explosives hidden in pagers and walkie-talkies killed dozens of people and wounded thousands, including many Hezbollah members.

## 'Leave Lebanon immediately': **UK PM to British nationals**



LONDON, Sept Prime Minister Keir Starmer has called on British nationals to leave Lebanon "immediately" after fighting intensified between Israel and Iranbacked Hezbollah and around 700 UK troops were deployed to Cyprus in case an emergency

evacuation is needed. Speaking on the sidelines of the Labour Party conference in Liverpool on Tuesday before he left for the United Nations General Assembly in New York, Starmer said the UK was ramping up its contingency plans in light of the "escalation" of violence, with fears growing of allout war between Israel and Hezbollah.

Thousands of British nationals are believed to be in Lebanon and the UK Foreign, Commonwealth and Development Office (FCDO) continues to advise against all travel to Lebanon

"The most important message from me to nationals Lebanon is to leave immediately," Starmer told reporters in response to questions about his mes-

"It is important that we've been really, really and transport helicopters clear: now is the time to leave," he said.

On the situation in the region, he added: "I think we need to be clear, we need de-escalation, we need a ceasefire, we need to pull back from the

Meanwhile, the FCDO said the UK is focused on bolstering its presence in the region with around 700 UK troops moving to Cyprus as part of the first phase of its contingency plans following "significant escalation" between Israel and Lebanon in re-

cent days. The military teams will be supported by Border Force and FCDO officials as the situation continues to "deteriorate rapidly, with devastating conse-

quences" "Events in the past hours and days

demonstrated how volatile this situation is, which is why our message is clear, British nationals should leave now," said UK Defence Secretary John Healey, who left the Labour conference early to chair an emergency Cabinet Office Briefing Room A (COBRA) meeting with ministers, intelligence chiefs and diplomats to assess government planning.

"We continue to urge all sides to step back from conflict to prevent further tragic loss of life. Our government is ensuring all preparations are in place to support British nationals should the situation deteriorate. I want to thank the British personnel deployed in the region for their commitment and professionalism," he said.

The UK said it already has a significant diplomatic and military footprint in the region, including RAF Akrotiri in Cyprus and Royal Navy ships RFA Mounts Bay and HMS Duncan, which have remained in the eastern Mediterranean to support British nationals and allies over the recent

The Royal Air Force (RAF) also has aircraft on standby to provide sup port if necessary.

It comes as Israel launched one of its biggest offensives against Hezbollah – considered a terrorist organisation by the UK – since the two sides went to war in 2006.

The operation followed the detonation of thousands of pagers and walkie-talkies used by the group, for which Israel has not staked a formal claim.

This covert action was soon followed by Israel Defence Forces saying they targeted Hezbollah weapons sites and killed several senior command-

According to reports from the region, hundreds are believed to have been killed in clashes as people are being forced to flee their homes in southern

## China test-fires an intercontinental ballistic missile into the Pacific Ocean

TAIPEI, Sept 25: China test-fired an intercontinental ballistic missile into the Pacific Ocean on Wednesday, stirring security concerns in the region already tense over Beijing's territorial claims and rivalry with the U.S. The ICBM carried a dummy

warhead and fell into a designated area of the sea, the Defense Ministry said in a statement posted to social media.

The launch by the People's Liberation Army's Rocket Force was part of routine annual training, complied with international law and was not directed against any country or target, according to the statement. It is unclear how often China conducts tests over such a distance. In 1980, China launched an ICBM into the South Pacific.

A map published in Chinese newspapers at the time showed the target area as roughly a circle in the center of a ring formed by the Solomon Islands, Nauru, the Gilbert Islands, Tuvalu, western Samoa, Fiji and the New Hebrides. The U.S. and non-governmental



The People's Liberation Army, which functions as the ruling Communist Party's military wing, runs China's space program, which has established an orbital station and has ambitions to set up a Moon

base and land a spacecraft on Mars. Rocketry has long been part of China's development into a major global power, spurring nationalism and growth that has made China the world's second-largest econ-

The U.S. remains China's main global rival, although Japan, Taiwan, the Philippines and others have territorial disputes with Beijing that occasionally threaten to develop into military clashes.

China maintains a "no first use" of nuclear weapons policy, even as its desire for regional predominance grows

Tests of China's intercontinental ballistic missiles into international waters are rare. Experts and a historical survey of China's program by the Washington-based Nuclear Threat Initiative suggest the last occurred in May 1980. That test saw China launch its DF-5 missile into the South Pacific. China typically launches missiles toward its western deserts from its east coast, said James Acton, the co-director of the Nuclear Policy Program and a senior fellow at the Carnegie Endowment for International Peace. The fact that China launched a test that splashed down in international waters was unusual, but mirrors testing that the United States does for its own ballistic missile fleet.

"When they haven't done something for 44 years and then they do it, that's significant," Acton told The Associated Press. "It's China's way of telling us, 'Like you, we're not ashamed we have nuclear weapons and we're going to behave like a great nuclear power."

The launch came amid the ongoing United Nations General Assembly in New York. China is one of five veto-holding permanent members of the U.N.'s Security Council and has sought to gain influence over its key departments involving human rights and that align with its authoritarian system.

landmark marriage equality bill was officially written into law on Tuesday, allowing same-sex couples to legally wed. The law was published in the

Royal Gazette after endorsement by King Maha Vajiralongkorn, and will come into effect in 120 days.

This means LGBTQ+ couples will be able to register their marriage in January next year, making Thailand the third place in Asia, after Taiwan and Nepal, to allow same-sex marriage. The bill, which grants full legal,

# Mizoram's connectivity remains intact despite landowners' agitation

connectivity remained stable on Wednesday as vehicles continued to use National Highway-306, the state's vital link with Assam, despite ongoing protests by landowners in Kolasib district over land ownership disputes.

A police officer said landowners began blocking NH-306 at Sethawn, but heavy police deployment ensured that traffic movement remained unaffected.

Some minor injuries were reported during scuffles between poice and protesters. Over 2,000 landowners launched an indefinite blockade on NH-306, demanding a resolution of land ownership issues and the lifting of a freeze on lands they assert are privately owned.

The Kolasib District Land Owners' Association (KDLOA) alleged that their long-held lands along NH-306 and NH-6, between Vairengte and Mualkhang, have been designated as Roadside Reserve Forest (RRF) by the state forest department since 2020, effectively freezing these properties.



The Centre had previously approved a widening project for NH-306 and NH-6 in the Aizawl district, with the National Highway Infrastructure Development Corporation Limited (NHIDCL) assigned to execute it.

However, the project has stalled due to ongoing disputes between the state forest and revenue departments. The KDLOA contended that when the widening project was announced, the forest department declared an 800-metre strip on either side of the highways as RRF.

Recently, the Supreme Court directed the Gauhati High Court to expedite its decision regarding the RRF notification within three months and suggested that Mizoram's chief secretary convene a meeting with the secretaries of the forest and revenue departments to resolve the dispute. (PTI)

## Regional centre for Kendriya Hindi Sansthan's to be set up: CM Khandu

#### 'Plot of land to be located immediately'

ITANAGAR, Sept 25: Arunachal Pradesh chief minister Pema Khandu said on Wednesday that his government will provide land for the establishment of a regional centre of Kendriya Hindi Sansthan

Addressing the silver jubilee celebrations of the Hindi department of Rajiv Gandhi University (RGU) near here, Khandu said that his government's proposal for the establishment of a regional centre of Kendriya Hindi Sansthan in the state has been accepted by the Centre and now sufficient and suitable land has to be provided for it.

The event was also attended by Kendriya Hindi Sansthan Director Professor Sunil Baburao Kulkarni. "Arunachal Pradesh is the only

Congratulating the Hindi department of the central varsity on the completion of 25 years of its existence and churning out Hindi language scholars, Khandu said that students of the department have excelled in their fields like poetry, storytelling, and novel writing, among others.

Khandu said that in Arunachal Pradesh, Hindi plays a pivotal role in uniting the diverse ethnic texture of the state.

"Yes, our Hindi may not be of the purest form but it's the sole medium of communication between different tribes and communities of the state. All other northeastern states have their one common language of communication except Arunachal Pradesh.

## TPYC demands release of exam marks for Group D post

AGARTALA, Sept 25: Tripura Pradesh
Youth Congress (TPYC) on Wednesday demanded immediate implementation of the waiting list in group D and publication of written and viva marks separately for all appeared candidates of Joint Recruitment Board Tripura (JRBT).

In a memorandum submitted by TPYC President Neelkamal Saha to the director of JRBT, said that in the last meeting with the JRBT, the party tabled two important demands which are the immediate publication of a waiting list for JRBT GROUP D. Neelkamal pointed out that many candidates from Group D have also appeared in exams for Group C and they are placed under Group C.

"We also know from sources that nearly 700 Group D candidates are from outside states and a maximum of them will not join the job so in total approx 950 to 1000 candidates in JRBT Group D will not appear for their job so as to not create the vacuum of unemployment. Again the need for a waiting list is a must so that the next 1000 candidates can join the jobs, as many of them can never appear for government jobs again because of their age barriers," he said.

He also demanded immediate publication of written and viva exam results separately so that a clear picture of performance satisfaction is established among the candidates who appeared for the JRBT GROUP D post.

#### Manipur Cong MLA concerned over security advisor's remark IMPHAL, Sept 25: Manipur Congress MLA Th

Lokeshwar on Wednesday expressed concern on security advisor Kuldiep Šingh's recent claim that 900 Kuki militants have entered the state, which he said has caused panic in the outlying villages of Imphal valley. Demanding clarity on the claim, Lokeshwar asked what actions have been taken to address the potential threat.

Speaking to reporters during a visit to the Khundrakpam constituency, Lokeshwar said, "Singh's claim has created unrest in peripheral areas of Imphal valley. He should clarify the grounds for his assertions and what measures are in place to

counter the militants' entry. Villagers should not be left to live in fear." He urged the government to act promptly, emphasising that the responsibility for protecting the villages lies with the authorities, not the villagers themselves. On Friday, Singh had said security forces are on high alert following reports that 900 Kuki militants had entered the state to target peripheral villages, with potential attacks expected around September 28.

Singh asserted that intelligence has been shared among various security agencies and proactive measures are being communicated to remote areas to prevent any militant preparations. (PTI)

health-related goal for the year 2030. The MoU will last for four years where both stakeholders shall facilitate successful delivery of the set objectives in the

paper with efficiency checkups, monitoring, and evaluation. Through the MoU, BMGF will provide both financial and technical support to improve outcomes in twelve key areas: comprehensive primary healthcare, family planning, maternal health and anaemia, neonatal health, immunisation, childhood wasting and nutrition, nursing education, supply chain management, digital health, results-based financing and performance management in healthcare, competency mapping and development for government functionaries, and agriculture and livestock development.

Speaking at the signing event, Conrad K. Sangma emphasized the importance of this collaboration and said, "We are happy and excited about the partnership that we are going to have with the Gates Foundation. We need to have the right-minded people with the right desire, goal, and mindset to sit together and try to resolve the problems, the institutional setups, and the plans that we have. We are looking at expertise in terms of knowledge.' "To conclude, for us what matters is how to make life better for our citizens." He also stressed improving the socio-economic

conditions of mothers and the female population at large. "We have started to make plans based on the real problems, the institutional systems and what we have to do to address the problems. ter Narendra Modi on Tuesday launched a blistering attack on the Congress saying if it comes to power in Haryana even by mistake, stability and development will be at stake because of its "infighting" and this will ruin the state. "In Karnataka, its chief minister and deputy chief minister are busy in internal fighting. In Telangana and Himachal Pradesh, it is the same story," he said in his second rally in the state, the first being over a week ago in Kurukshetra.

Modi also mentioned about alleged infighting in Rajasthan and Chhattisgarh when the Congress was in power there.

"Therefore, Haryana has to be cautious. Haryana has right over me. Remember, if Congress comes to power even by mistake, it will ruin Haryana due to its infighting,"

NEW DELHI, Sept 25: Leader of Opposition in the Lok Sabha Rahul Gandhi on Wednesday slammed the BJP over its MP Kangana Ranaut's remarks calling for bringing back the three farm laws and demanded that Prime Minister Narendra Modi must clarify whether he is opposed to the comments or is "upto some mischief".

Gandhi asserted that any attempt to revive the farm laws will be met with opposition from the INDIA bloc. Ranaut on Wednesday withdrew her remarks calling for bringing back the three farm laws and said those were her personal opinions and did not represent the party's stand. The actor-politician said she must remember that she is not only an artiste but also a BJP member now and her statements should be in

line with her party's policies. In a video statement, Gandhi said, The BJP people keep testing ideas They ask someone to voice an idea among the people and then they see the reaction. This is what has happened, one of their MPs has talked about reviving the three black farm laws. Modi ji you must clarify, whether you are against this or you are again up to some mischief." "Will the three farm laws be revived or not? If you do so, I guarantee you that the INDIA bloc will together stand against it. 700 people were martyred, they must be remembered and respected," the former Congress

Congress, entire Haryana is watching," he said. Voting for Congress means putting Haryana's stability and development at stake and opening the doors of destruction, he further said.

"This instability will stop every work in Haryana. Investment and jobs will be impacted", said Modi.

Notably, with Haryana going to polls next month, the ruling BJP has been targeting the Congress over the alleged infighting in its Haryana unit and even claimed that Lok Sabha member and prominent Dalit leader Kumari Selja is unhappy with her party over ticket distribution and so is staying away from the poll campaign. Former chief minister Manohar Lal Khattar had also invited Selja to join the BJP but she dismissed any possible switch, saying, "I am a Congress person, I will remain a Congress person."

In his speech, Modi said whenever the Congress remained out of power, the poor, SC, ST and OBC got their due rights.

Whenever the Congress remained in power, it snatched rights of Dalits and downtrodden, he alleged. Whoever became prime minister from Congress's 'royal family', they always opposed reservation, he said.

"Opposing and hatred towards reservation is in Congress party's DNA. That is why today we are seeing that fourth generation of the royal family of the Congress wants to remove reservation. You have to



be cautious of Congress party's anti-reservation tactics," he said.

The BJP gave participation, in true sense to Dalit, OBC and tribals while it worked to take forward deprived and backward sections, Modi said. "In Haryana, you see BJP made Nayab Saini (who comes from OBC community) chief minister. In short time, Saini has created a place in hearts of people of Haryana," he said.

"It is my first time here in Kashmir. I am happy to be here as a part of the MEA delegation. I see it is a beautiful place and people are very nice. It is special to witness how democracy works. This idea of a pink polling station is very ingenuous. It is a great way to attract more people to come to vote," Lim added. Singapore deputy head of the mission in Delhi Cheng Wei Wei Alice said it was wonderful to be part of the delegation observing the polls here.

"I am glad that all the voters showed up. That's wonderful to see. The process is very similar to how we conduct elections in Singapore. We use government buildings for polling stations so that it is easily accessible to voters," she said. ## Expel Kangana if you don't agree with her views on farm laws: Cong to BJP

NEW DELHI, Sept 25: The Congress on Wednesday stepped up its attack on the BJP over its MP Kangana Ranaut's remarks calling for bringing back the three farm laws, demanding that the actor-politician be expelled by the ruling party if it does not agree with her remarks.

Ranaut on Wednesday withdrew her remarks calling for bringing back the three farm laws and said those were her personal opinions and did not represent the party's stand.

The actor-politician said she must remember that she is not only an artiste but also a BJP member now and her statements should be in line with her party's policies.

The Congress on Tuesday shared on X a video in which she said in Hindi. "Farm laws that have been repealed should be brought back. I think this may get controversial. The laws in farmers' interest be brought back. Farmers should themselves demand this (to bring farm laws back) so that there

is no hindrance to their prosperity. "Farmers are a pillar of strength in India's progress. Only in some states, they had objected to farm laws. I appeal with folded hands that farm laws should be brought back in the interest of farmers."

In an apparent response to Ranaut's remarks, Kharge said, "Even after the martyrdom of 750 farmers, the anti-farmer BJP and Modi government did not realize their grave crime! There is talk of re-implementation of the three black anti-farmer laws. The Congress Party strongly opposes this.'

The 62 crore farmers will not forget that the Modi government crushed the farmers under a vehicle, used barbed wire, teargas from drones, nails and guns against them. Dubey told Pal that it is essential to ask whether foreign entities, organisations, and individuals may be deliberately orchestrating this "flood of responses to manipulate the democratic process'

Urging him to ask the Ministry of Home Affairs to conduct a thorough investigation, he said the probe finding should be circulated to all members of the committee to ensure complete transparency.

India has a robust parliamentary system, and any attempt to influence it through coordinated foreign intervention represent a direct threat to national sovereignty, he asserted. Citing media reports, he said the content of a

large portion of these submissions is identical or contains minor variations, signalling that many of these communications may be part of an organised campaign. "It is not uncommon for special interest

groups, both foreign and domestic, to use this tactic to saturate the legislative process with pre-drafted suggestions or demands, giving the illusion of mass public support. This orchestrated effort undermines the very purpose of soliciting genuine public feedback," he said.

Hinting at the role of Islamic fundamentalist organisation, he said these groups often funded or influenced by outside powers seek to divide India along religious lines, destabilising its democracy and disrupting our legislative processes.He said, "There is reason to suspect that these elements are leveraging the Waqf Bill deliberations to sow discord and polarise public opinion. These efforts are not isolated but part of a broader strategy by fundamentalist groups to manipulate sensitive issues in our country.

The influence of a radical Islamist peacher Zakir Naik cannot be underestimated, he said.

There are credible concerns that Naik and his network may be involved in orchestrating this deluge of submissions to the Waqf Bill, leveraging the issue to further his extremist rhetoric, he added, noting that Naik is a fugitive wanted in India for promoting hate speech and inciting

Dubey also mentioned foreign powers like Pakistani spy agency ISI, China, and radical organisations like Jamaat-e-Islami Bangladesh and the Taliban.

Given the sheer volume of submissions and their questionable content, it is entirely plausible that foreign actors are attempting to influence the legislative process, he said. "If foreign intelligence agencies are behind

this flood of submissions, it would constitute an unprecedented attack on Indian sovereignty and a deliberate attempt to compromise the independence of Parliament," he added.

Noting that Article 105 of the Constitution guarantees the free and fair functioning of Parliament, including the operations of its committees, he said any attempt by external forces to manipulate the legislative process will be an attack on the very foundations of parliamentar system.He said an investigation by the MHA is critical to preserving the fairness, integrity, and independence of the Waqf Bill deliberations.

The Waqf bill deliberations, he stressed, must proceed without the interference of outside influences that aim to destabilise, delay, and disrupt the process.

The committee, whose meetings have been marked by fiery exchanges between BJP and opposition members, has been holding extensive consultations and has held frequent daylong deliberations as it rushes to meet the deadline of submitting its recommendatons to Parliament in the first week of winter ses-

# Court orders probe by Lokayukta police against CM Siddaramaiah, sets the stage for FIR against him

**BENGALURU, Sept 25:** A Special Court here on Wednesday ordered a Lokayukta police probe against Karnataka Chief Minister Siddaramaiah in the Mysuru Urban Development Authority (MUDA) site allotment case, setting the stage for filing of an FIR against him.

The order of the Special Court Judge, Santhosh Gajanan Bhat, came a day after the High Court upheld the sanction granted by the Governor Thaawarchand Gehlot to conduct an investigation against Siddaramaiah on the allegations of illegalities in the allotment of 14 sites to his wife B M Parvathi by

The Special Court exclusively to deal with criminal cases related to former and elected MPs/MLAs issued the order directing the Lokayukta police in Mysuru to initiate an investigation on the complaint filed by RTI activist Snehamayi Krishna.

The Court issued directions to take up the probe under section 156 (3) of the Code of Criminal Procedure (CrPC) (that gives a magistrate the power to order an investigation into a cognisable offense.) and file the investigation report by December 24.

The HC had also vacated its Au-



gust 19 interim order directing the Special Court to defer the decision on complaints against the Chief Minister, giving the green signal for ordering a probe.

It had dismissed Siddaramaiah's petition challenging the legality of the Governor's August 16 order granting approval for investigation under Section 17A of the Preven-

tion of Corruption (PC) Act, 1988. Reacting to the Special Court order, Siddaramaiah reiterated that he was ready to face an investigation. "Already I have said that I am ready to face an investigation. I am not afraid of a probe," Siddaramaiah told reporters here. "I am ready for a legal fight. I had said this yesterday and I am reiter-

ating it today as well." Home Minister G Parameshwara said Lokayukta police is an independent body. "It is not under anyone's mercy, they will investigate independently.

"...will react once the order copy comes. Chief Minister Siddarama iah has said that he is ready for any probe....what investigation and other things let the order come, and let's see what (the court) has defined in the order," he said.

Parameshwara chose not to directly respond to a question regarding a statement made by Siddaramaiah seeking BJP leader and former CM B S Yediyurappa's

resignation during a "similar situation" in the past, and said "let's see what's in the order copy."

Meanwhile, the BJP once again demanded Siddaramaiah's resignation and asked him to cooperate with the probe

State BJP President B Y Vijayendra said: "the CM has said that he is ready for any probe, but has questioned why he should resign. Siddaramaiah seems to have forgotten what he preached as Leader of Opposition to the then Chief Minister Yediyurappa. He had asked Yediyurappa to resign for fair and impartial probe when the accused person is at the helm of affairs." "The Court might have asked Lokayukta police to probe, but we urge the CM -- before he resigns -- that he should order the investigation to be handed over to independent agency CBI, for free and impartial probe,", he said.

The opposition BJP and JD(S) in Karnataka on Wednesday also sought to step up its demand for Chief Minister's resignation as they tried to lay siege to his residence. Holding posters, placards and raising slogans, members of BJP Yuva Morcha marched towards "Cauvery" but the police thwarted their attempt, took them into preventive custody and

whisked them away in a bus. Leaders and workers of the JD(S), an NDA partner, headed by former Prime Minister H D Deve Gowda, staged a demonstration at the Freedom Park here before proceeding to "Cauvery" but were stopped by police.

Complainant Snehamayi Krishna hailed the Special Court's order and said, after filing of the FIR, he would appeal to the High Court to hand over the case to CBI.

In the MUDA site allotment case, it is alleged that compensatory sites were allotted to Siddaramaiah's wife in an upmarket area in Mysuru, which had higher property value as compared to the location of her land which had been 'acquired" by the MUDA.

The MUDA had allotted plots to Parvathi under a 50:50 ratio scheme in lieu of 3.16 acres of her land, where it developed a residential layout.

Under the controversial scheme, MUDA allotted 50 per cent of developed land to the land losers in lieu of undeveloped land acquired from them for forming residential lavouts. It is alleged that Parvathi had no legal title over this 3.16 acres of land at survey number 464 of Kasare village, Kasaba hobli of Mysuru taluk. (PTI)

### Glitzy ads on Make in India cannot sugarcoat its colossal failures: Congress

NEW DELHI, Sept 25: Congress president Mallikarjun Kharge on Wednesday alleged that 10 years of the Narendra Modi government's Make in India "stunt" has put a break on India's manufacturing and said that glitzy ads cannot sugarcoat its "colossal failures."

Kharge said that contrary to the BJP's high decibel propaganda, India's manufacturing sector has become de-industralised.

'10 years of Modi Govt's Make in India Stunt has put Break in India's Manufacturing! 10 years ago, PM Narendra Modi crafted the slogan of 'Make in India' and claimed to build Aatmnirbhar Bharat. Contrary to BJP's high decibel propaganda, India's manufacturing sector has got de-industralised due to Modi government's FLOP policy initiatives," he said in a post on X. Kharge listed five 'stark facts" which he claimed made India miss the bus on manu-

facturing. "The average growth rate of the manufacturing sector between 2014-15 and 2023-24 is just 3.1% (BJP-NDA) whereas between 2004-05 and 2013-14, the average growth rate was 7.85% (Congress-UPA). The number of employees in factories grew at 6.2% annually during the Congress-UPA regime. This growth fell spectacularly to just 2.8% under the Modi government," the Congress chief said.

Between 2011-12 and 2022,

India's manufacturing sector saw minimal growth in employment, increasing from 6 crore to merely 6.3 crore workers, he said.

"This modest addition of 3 lakh jobs annually is insufficient, considering 1.5 crore youth enter the workforce every year," he said.

Kharge said that according to NSO, the share of employment in manufacturing accounted for 12.6 per cent of all workers in 2011-12. This declined to 10.9 per cent in 2020-21, before recovering 11.6 per

cent in 2021-22, he said. Kharge said that the share of manufacturing in India's GDP has hit "an all time low" of 12.83 per cent in 2023, which under the UPA

in 2013 was 15.25 per cent.

"PLI schemes have miserably failed in several sectors. Sectors such as high-efficiency solar PV modules, advance chemistry cell (ACC) batteries, textile products, speciality steel, white goods and medical devices have failed to yield the claimed results," Kharge said. He claimed that most Production-Linked Incentive, or PLI, schemes have garnered "lukewarm and tepid" response from the industry and experts have criticised the schemes for their poor design, lack of clarity and no real value addition. "Year after year, the Modi government has sold stakes of even profit making PSUs to Modi ji's crony friends, thereby breaking the backbone of our Public sector. (PTI)

## PM Modi to launch projects worth ₹22,600 crore from Maharashtra

Minister Narendra Modi will flag off a Metro train in Pune on Thursday and also launch various development projects worth over ₹ 22,600 crore. An official statement said the inauguration of Pune Metro section of District Court to Swargate will mark the completion of Pune Metro Rail Project (Phase-1). The cost of the underground section between District Court to Swargate is around ₹ 1,810 crore.

He will also lay the foundation stone for Swargate-Katraj extension of Pune Metro Phase-1 to be developed at the cost of around ₹ 2,950 crore. This southern extension of around 5.46 km is completely underground with three stations namely Market Yard, Padmayati and Katrai, it said.

Among other projects, he will lay the foundation stone for the memorial for Krantijyoti Savitribai Phule's first girl school at Bhidewada in commemoration of the noted social reformer.

In line with his commitment to make India self-reliant in the field of supercomputing technology, the statement said, Modi will dedicate to the nation three PARAM Rudra Supercomputers worth around Rs 130 crore, developed indigenously under the National Supercomputing Mission (NSM).

These supercomputers have been deployed in Pune. Delhi and Kolkata to facilitate pioneering scientific research. Giant Metre



Radio Telescope (GMRT) in Pune will leverage the supercomputer to explore Fast Radio Bursts (FRBs) and other astronomical phenomena. Inter University Accelerator Centre (IUAC) in Delhi will enhance research in fields like material science and atomic physics.

The S N Bose Centre in Kolkata will drive advanced research in areas such as physics, cosmology and earth sciences, it added.

During his visit to the pollbound state, the prime minister will inaugurate a high-performance computing (HPC) system tailored for weather and climate research. This project represents an investment of ₹ 850 crore, marking a significant leap in India's computational capabilities for me-

teorological applications.

Located at two key sites, the Indian Institute of Tropical Meteorology (IITM) in Pune and the National Center for Medium Range Weather Forecast (NCM-RWF) in Noida, this HPC system has extraordinary computing power. The new HPC systems are named 'Arka' and 'Arunika,' reflecting their connection to the Sun, it said. Modi will launch various initiatives of petroleum and natural gas sector worth Rs 10,400 crore. These initiatives will focus on energy, infrastructure, safety and convenience of truck and cab

## Delhi govt mandates one-year service bond for medical graduates

NEW DELHI, Sept 25: Delhi government has introduced a one-year mandatory service bond for medical students passing out from All India Quota and State Quota in both undergraduate (UG) and postgraduate (PG) programs from medical institutions in Delhi.

Under this new regulation, students graduating from undergraduate and postgraduate courses, including super-speciality programs, will be required to serve for one year in medical institutions under the Government of the National Capital Territory (GNCT) of Delhi, according to the order issued by the Health and Family Welfare Department of the Delhi Gov-

At the time of admission, UG students will have to furnish a bond of Rs 15 lakh, while PG and super-specialty students will submit a bond of Rs 20 lakh. These bonds will be forfeited if a student opts out of the mandatory service period, as stated in the GNCTD order.

The scheme will ensure that UG pass-outs are placed in Junior Resident (JR) positions, while PG pass-outs will be assigned Senior Resident (SR) roles. They will be compensated at the same level as the stipends paid to JRs and SRs, with super-specialty graduates receiving appropriate increments. Medical graduates will be deployed across various hospitals under the GNCT hospitals, with remuneration as GNCT of Delhi, including society hospitals.

They may also be posted in other hospitals as needed by the Health and Family Welfare (H&FW) Department, according to the order.

A committee chaired by the Dean of Maulana Azad Medical College (MAMC) has been tasked with assessing the need for additional JR and SR posts. If necessary, new positions will be created, and the services of these graduates will be deployed accordingly. The mandatory one-year service bond will come into effect from the next academic session. Until then, current medical graduates will have the option to voluntarily take up available JR or SR positions in GNCT hospitals, with remuneration as pre-

## Probe into death of Badlapur sexual assault case accused should be fair, impartial: HC

MUMBAI, Sept 25: The Bombay High Court on Wednesday said the shoot-out of Badlapur sexual assault case accused Akshay Shinde could have been avoided and urged for the probe into his death to be carried out in a fair and impartial manner.

A division bench of Justices Revati Mohite Dere and Prithviraj Chavan said if it would be constrained to pass appropriate orders if the probe is not done properly.

"We are not suspecting the police on their activities, but come clean on all aspects," the court said. It said this shoot-out cannot be termed as an 'encounter' as its definition is different.

The bench raised questions on the shoot-out, which took place on Mumbra bypass in Maharashtra's Thane district on Monday evening, and said it could have been avoided if police had tried to overpower Shinde first.

Why the accused was shot in the head instead of opening fire on his hand or legs first? it asked.

The bench said while it was not raising any suspicion at this stage, it was very hard to believe Shinde managed to seize a pistol from a police officer and open fire.


It is not very easy to unlock and open fire from a pistol, the HC said. "The investigation has to be done fairly and impartially. If we find this is not done, then we would be constrained to pass appropriate orders," the court said.

It posted the matter for further hearing on October 3, by when police would have to take a decision on the complaint submitted by Shinde's father, seeking an FIR against the cops concerned.

Shinde, a 24-year-old contractual sweeper, was accused of sexually assaulting two minor girls at a school in Thane's Badlapur town. He was arrested on August 17.

The court also directed for all case papers to be immediately handed over to the Maharashtra Crime Investigation Department (CID), which would be probing the

"Why are files not handed over to the CID yet? Preservation of evidence is vital. Any delay on your part would raise doubts and spec-



ulations," it said.

The court was hearing a petition filed by Akshay's father Anna Shinde, who alleged his son was killed in a "fake encounter" and sought a probe into it by a special investigation team (SIT).

The petition, filed through advocate Amit Katarnaware, also demanded the HC monitor the investigation. The HC asked how the police officers escorting the accused could be so negligent and careless that he managed to seize a cop's pistol and open fire.

What is the SOP or guidelines when an accused, especially in such a serious crime, is taken in custody. Why should they (police) be so negligent and careless?" the HC said. The officer who shot at the accused is an inspector who has experience on how to react in such a situation, it noted.

"Ordinarily, the retaliation would be on the leg or arm. Why directly on the head? Does he (police) not know where the shot has to be fired? It may have been spontaneous. The first reaction should have been to disarm him," the court said.

It also questioned police's case that Akshay managed to seize the pistol and opened fire.

Justice Chavan said, "This is very hard to believe. I have fired pistol hundred times. It is hard to unlock and fire. We are not suspecting at this stage but just looking at the possibilities. Revolver is easier. Any Tom, Dick or Harry can do it. But a pistol is very hard

## Odisha CM announces assistance Maharani Lakshmi Bai 'national hero', don't divide history on 'communal politics': HC

NEW DELHI, Sept 25: Maharani Lakshmi Bai of Jhansi is a "national hero" and history should not be divided on "communal politics", the Delhi High Court said on Wednesday while pulling up the Shahi Idgah Managing Committee for making "scandalous pleadings" in its plea against installation of her statue inside the Shahi Idgah Park at Sadar Bazar here.

The high court said the committee's intent was to do communal politics through court and a religious colour was being given to the matter. "A religious colour is being given to this. It is a matter of pride that you are having this statue there. On one hand we are talking about women empowerment... She is a national hero, cutting across all religious lines and you are doing this on religious lines. Let's not divide history on communal politics," a bench of Chief Justice Designate Manmohan and Justice Tushar Rao Gedela

The division bench, which was hearing an appeal by the committee challenging a single-judge's order, dismissed its petition seeking to restrain the installation of the statue of 'Maharani of Jhansi'

inside the Shahi Idgah Park at Sadar Bazar here on the ground that the plea appeared to be without any cause of action. The court took exception to certain paragraphs against the single judge in the appeal which it said was "divisive". "Someone has clearly lost it. The person who is doing it has got totally swaved. Just because someone has got emotionally swaved... The petitioner is indulging in communal politics and also dragging the court into it. Courts don't get involved in communal politics. Give a written apology. What you are doing is not done," the bench

The bench further said, "Look at the wordings which have been used for the single judge. Withdraw these pleadings please and give us an apology letter. This is scandalous. Absolutely scandalous. Communal politics being played through court. Do communal politics outside the court. Don't use us in the process. She is a national hero. This is not fair what you people are doing."

"The intent, it seems, is to do communal politics through court. Rani Lakshmi Bai has nothing to do with religion. In case the land belonged to you, you should have volunteered yourself," it said.

The counsel for the petitioner committee apologised and said this was not the intent and added that the plea was not politically motivated. He said that the land here does not belong to the managing committee and that it was only concerned with the Shahi Idgah.

Delhi government standing counsel Santosh Kumar Tripathi said it has become a fashion to make harsh statements, including against judges, in pleadings and that "people don't know how to address the single judge or the tribunal"

To this, the bench remarked that the court was not being addressed in the pleadings but "someone behind was being addressed" and that everyone was going through some

political pressure The court asked the petitioner's counsel to delete the objectionable paragraphs in which scandalous pleadings were made and file an application to that effect by Thursday. "The senior counsel for the appellant (managing committee) admits that the aforesaid paragraphs are scandalous and shall be deleted forthwith. (PTI)

the Muslim side's contention that the suits filed by Hindu litigants relating to the dispute over the Shahi Idgah mosque complex adjoining the Krishna Janmabhoomi temple violated the Places of Worship (Special Provisions) Act, and were hus not maintainable.

The 1991 Act prohibits changing the religious character of any shrine from what existed on the day of the country's Independence. It exempted only the Ram Janmabits purview.

The cases filed by the Hindu side seek the "removal" of the Aurangzeb-era mosque they claim was built after demolishing a temple that once stood there. In its ruling, the high court had

said the 1991 Act did not define the "disputed" place cannot have a dual religious character -- of a temple and a mosque, which are "adverse to each other" -- at the same

"Either the place is a temple or a mosque. Thus, I find that the religious character of the disputed place as it existed on August 15, 1947 is to be determined by documentary as well as oral evidence led by both the parties," the high court judge had said.

The controversy is related to Mughal emperor Aurangazeb-era Shahi Idgah mosque at Mathura, which is alleged to have been built after demolishing a temple at the birthplace of Lord Krishna.

However, the Muslim side (management committee of the Shahi-Idgah and the UP Sunni Central Waqf Board) has opposed it on several grounds. (PTI)





COMO (ITALY), Sept 25: Former France and Real Madrid center back Raphael Varane announced his retirement on Wednesday, ending a career that included a World Cup title and a big haul of club trophies.

The 31-year-old Varane signed with promoted Serie A club Como in July but injured his knee during his only appearance with the club an Italian Cup match against Sampdoria last month.

"In my career I have taken on many challenges, rose to occasion after occasion, almost all of it was supposed to be impossible," Varane wrote on Instagram. "Reflecting on these moments, it is with immense pride and a feeling of fulfillment that I am announcing my retirement from the game that we all love.'

Varane was arguably the tournament's standout defender when France won the 2018 World Cup in Russia, where he scored the most important of his five international goals with a header against Uruguay in the quarterfi-




