### ULFA-I linkman apprehended for planting bomb on I-Day

GUWAHATI, Sept 8: Assam Police arrested a linkman from the United Liberation Front of Asom— Independent (ULFA-I), a proscribed terrorist group, for allegedly planting explosives on Independence Day in several parts of the state, officials said on Sunday.

As per the officials, the linkman was identified as Manab Kalita and was arrested in Jorhat district. During investigation, Kalita ad-

mitted that he was an active cadre of ULFA-I and that, on Independence Day, he took a proactive part in putting bombs in multiple locations in Guwahati.

"The ULFA-I linkman was active in the region for the last several days. He demanded extortion money from the owner of a tea garden in the upper Assam area. However, initially, the authority of the

tea garden thought he was demanding money to befool people on the name of ULFA-I but actually he is an active cadre of the outlawed group," a senior official from Assam Police said while speaking to news agency IANS.

It has been learned that Kalita has disclosed a great deal about ULFA-I's plan to sabotage Assam's Independence Day celebrations during her police interrogation. For security considerations, the police have not yet made an official statement on the matter.

To recall that on August 15, several places of Assam received bomb threats after the United Liberation Front of Asom—Independent (ULFA-I), a proscribed militant group, claimed to have planted exploded devices in 25 different locations throughout the state. Tinsukia, Dibrugarh, (CONTD. ON PAGE-2)

### **SEBI** has lot to explain: Cong after Mauritius FPIs 'challenge'



NEW DELHI, Sept 8: The Congress on Sunday said the SEBI investigation into "the Adani Group's brazen attempt" to bypass regulations is still languishing and the capital markets regulator has a lot to explain.

Congress general secretary in-charge communications Jairam Ramesh's remarks attacking SEBI came after a media report which claimed that two Mauritiusbased foreign portfolio investors (FPIs), who were mentioned in the January 2023 report on the Adani Group by short-seller Hindenburg Research, have petitioned the Securities Appellate Tribunal, seeking urgent relief from

complying with SEBI's new foreign investor norms. "Two Mauritius-based foreign portfolio investors (FPIs), a part of the revelations in the still-unfolding Modani mega scam, have now petitioned the Securities Appellate Tribunal, seeking urgent relief from complying with SEBI's new foreign investor norms before the

upcoming September 9th deadline," Ramesh said. Both the FPIs are alleged to be violating rules that require investors to not be over-invested in a single stock, he said. These rules are meant to ensure that black money routed through tax havens does not flood back into Indian capital markets, Ramesh said, adding they must be upheld at all costs.

"These are the very same FPIs who stand accused of participating in the Adani Group's brazen attempt to bypass SEBI's regulations and amass benami stakes in its own companies. These are the very firms that benefitted from SEBI's removal of the requirement to identify the ultimate beneficial owner' of offshore funds, a decision that it was forced under public pressure to reverse in June 2023 in a tacit admission of its guilt," the Congress leader said in his post on X. "The basic fact is that a SEBI investigation into these violations that was supposed to be completed in two months and shared with the Supreme Court is still languishing 18 months later,' Ramesh said. ## **Adani floats China subsidiary for** providing project management services

China to carry out business of providing supply chain solutions and project management services, according to a regulatory filing.

Adani Enterprises, the group's flagship firm, in the filing said a Singapore-based step-down subsidiary incorporated a whollyowned subsidiary, Adani Energy Resources (Shanghai) Co. (AERCL), domiciled in Shanghai, China on September 2, 2024.

"AERCL is incorporated to carry out business of providing supply chain solutions and project management services," it said without providing details.

The subsidiary was incorporated by Adani Global Pte (AGPTE), Singapore - a step-down subsidiary of Adani Enterprises Ltd (AEL).

AEL houses the conglomerate's mining, roads, airports, data center and water infrastructure businesses. "AERCL has been incorporated and registered under the laws



of Company Law of the People's Republic of China on September 2, 2024," the filing said. AERCL is yet to commence its business operations. The new unit comes days after AEL set up a subsidiary in Kenya, Airports Infrastructure PLC (AIP) "to take over, operate, maintain, demodernize and manage the airports'

The group, which currently operates seven airports in the country, is looking to expand overseas.

of airports outside India. This unit has now set up the Kennian sub-

Adani Group had reportedly submitted a proposal to the Kenyan government for investing in its main airport, the Jomo Kenyatta International Airport (JKIA) in Nairobi. It has proposed to invest USD 750 million for a new terminal and taxiway system by 2029 and an USD 92 million for improvements by 2035.

JKIA, which would be Adani's first airport outside of India, is a major hub in East Africa but has a crumbling infrastructure. It could provide Adani with a strategic advantage in the region, enhancing connectivity and trade routes.

Talks with the Kenyan government are ongoing. "AIP has been incorporated and registered under the laws of Kenya Companies Act, 2015 on August 30, 2024," AEL said. AIP is yet to commence its business operations. (PTI)

### Over 1.4K accessibility complaints filed on govt app, 75% solved: Data

NEW DELHI, Sept 8: More than ,400 complaints related to accessibility have been lodged through the government's flagship Sugamya Bharat mobile application since its launch in 2021, with approximately 75 per cent of those resolved, according to official data.

The Sugamya Bharat app, designed to assist people with disabilities and the elderly, allows users to report accessibility issues in public infrastructure, transportation and buildings by uploading

a Right to Information (RTI) request filed by PTI showed that 1,441 complaints were received on the app between 2021 and 2024. Of these, 1,081 were addressed after being forwarded to the au-

thorities concerned. The RTI response revealed that 647 complaints were received in the 2021-22 period, of which 567 were resolved. The following year, 530 complaints were lodged and 391 resolved. The app recorded 264 complaints in 2023-24 while

To further improve the app's functionality, the government plans to redesign the platform, incorporating artificial intelligence (AI) features.

A senior Department of Disability Affairs official said the upgraded Sugamya Bharat app would become a comprehensive platform for people with disabilities, offering an AI-powered chatbot, a multilingual interface, and tools for complaint registration and feedback. (PTI)

### ULFA-I linkman apprehended

Sivasagar, Nagaon, and a few locations in Guwahati are among the locations. It has been discovered that ULFA-I dropped bombs in Guwahati city in at least eight locations.

The outlawed group in a statement said that due to some technical errors, the bombs were not blasted. According to a statement by ULFA-I, they intended to protest violently by detonating the explosives during Independence Day festivities. But between 6 am and 12 noon, "technical errors" prevented the bombs from detonating as intended. A list of the targeted areas and pictures of certain bomb sites, including one close to the state secretariat in Dispur in Guwahati, were also published by ULFA-I.

### Mission Basundhara 3.0 to be

Basundhara 1.0 and 2.0 have enabled the government to take steps for making Mission Basundhara 3.0 more effective and beneficiary friendly. "All preparations have been taken for rolling out of Mission Basundhara 3.0. Moreover, the two-day workshop on the preparedness of Mission Basundhara 3.0 held at Srimanta Sankardeva Kalakshetra will also help all the stake holders to reorient themselves for the successful implementation of Mission Basundhara 3.0," he added. Sarma said that Mission Basundhara 1.0 which was launched on 2 October, 2021 benefitted around eight lakh people. Moreover, Mission Basundhara 2.0 which was launched on 14 November, 2022 also benefitted more than two lakh people.

"Taken together, Mission Basundhara 1.0 and 2.0 ensured land rights to around 84 per cent indigenous people, SC and ST of the state. Moreover, in Mission Basundhara 3.0, the cases will also be taken where offer of settlement could not be given to the beneficiaries in MB 2.0," Sarma stated.

The chief minister also said that one of the criteria for being considered for MB 3.0, a beneficiary should be living on the piece of land for three generation, adding, "However, this criterion would be exempted for the people belonging to tea tribes, Adivasi, Gorkha community and people belonging to six ethnic communities in the state. These classes will be declared as protected class and they will be considered for allotting land pattas under MB 3.0. without any evidence of three generation legacy associated with the piece of land. This move of the government will greatly benefit the indigenous people of the state".

He said that during MB 3.0, claims for land for educational institutions like colleges and universities will be given preference. Moreover, he said that it was observed that some of the beneficiaries even after being eligible for land pattas under Mission Basundhara 2.0 could not regularise their rights because of their inability to pay high premium of land. "Therefore, the government, decided that in MB 3.0 for the lands falling in towns and cities, the beneficiaries will be allowed to regularise their possession by paying less premium against the government rate. However, if they want to sell the land, the unrealized premium will have to be paid to the government from the amount thus realised from the sale of the land. This system will also ensure land rights to the indigenous people," Sarma avowed.

Coming to escalation matrix, it may be noted with the help of this portal time-frame will be set for handling and disposing of the matters contained in ARTPS Act. With the help of E-chitha through 'sewa setu portal', buyers will get the facility to get into the history of any piece of land like the names of its owners in Assam for the purpose of buying. Land valuation certificate will enable the buyers and sellers to get valuation information about a piece of land. The community response portal of ASDMA will help various NGOs, volunteers along with the government to provide aids to the disaster victims in times of any disaster.

Minister Revenue and Disaster Management Jogen Mohan also spoke on the occasion. Chief Secretary Dr. Ravi Kota, principal secretary Revenue and Disaster Management Department G D Tripathi and host of senior government officers were also present on the occasion.

However, Geelani snubbed the delegation and did not even open the doors. Targeting PDP and NC, the defence minister said they used to say that the revoking of Article 370 will engulf the region into a devastating fire. "We did it boldly and nothing had happened".

"After independence, the rights of women and weaker sections including Pakistani refugees, sweepers were denied. But we ensured justice for them and they are going to vote in this elections. We also provided political reservation to Scheduled Tribes," he said.

Singh said a G20 event happened in Srinagar last year, projecting Kashmir as a "tourism hotspot instead of

terrorism hotspot" as government focused on road and rail connectivity and infrastructure building. "The government under the leadership of Modi has decided to call the border villages as first villages of the country rather than last villages and we will ensure their fast development," he said, adding the border-fencing project will be completed to block infiltration. (PTI)

SEBI has a lot to explain, quite apart from the multiple conflicts of interest of its Chairperson that are now unravelling, he said. Ramesh's remarks come weeks after Hindenburg Research launched a fresh broadside against market regulator SEBI chairperson Madhabi Buch, alleging that she and her husband had stakes in obscure offshore funds used in the Adani money siphoning scandal. SEBI Chairman Buch and her husband have denied the allegations levelled against them as baseless and asserted that their finances are an open book. Adami Group had also termed Hindenburg Research's allegations as malicious and manipulative of select public information, saying it has no commercial relationship with the SEBI chairperson or her husband. The Congress has been alleging financial regularities against the Adani Group and favours being given by the government to the conglomerate to augment its profits.

The opposition party has been persistent on its attack on the government, since Adani Group stocks took a beating on the bourses in the wake of the Hindenburg Research making a litany of allegations, including fraudulent transactions and share-price manipulation on the conglomerate headed by industrialist Gautam Adani. The Adani Group had dismissed the charges as lies, saying it complies with all laws and disclosure requirements. (PTI)

"We are planning to raise \$300 million in the next few weeks, may be by October and rest \$500-700 million during the remaining part of the current financial year," Shriram Finance Managing

Director and CEO Y S Chakravarti told PTI. The fund raise would also include loans from development financial institutions like Asian Development Bank, Kfw, and United States Development Finance Corporation (DFC). The timing would de-

pend on market conditions, he added. To fund its business growth, the Non-Banking Financial Company (NBFC) raises resources from diversified sources like public deposits, bank finance and raising money from domestic markets.

On the loan growth, Chakravarti said, it is expected to increase 15 to 16 per cent during the current financial year.

The company's Assets Under Management (AUM) stood at ₹ 2.33 trillion at the end of June 2024. Disbursement in Q1 FY25 aggregated to ₹ 37,710 crore as against ₹ 30,455 crore in Q1 FY24.

The Reserve Bank of India (RBI) in November 2023 asked all lending entities to set aside more capital on loans given to NBFCs. This made fund raising from banks costlier especially for smaller

Chakravarti said Shriram Finance, which provides loans to buy commercial vehicles and lends to small and medium-sized companies, has not seen any funding pressure due to the firm's higher credit rating and multiple-source borrowings. "It is the smaller players that are rated below AA which are getting squeezed. For us, it's not too much of a concern because my entire bank borrowing in my total liability portfolio is about 24 per cent," he said.

### Apple's upcoming iPhone to break grounds with shift into age of Al

WASHINGTON, Sept 8: Apple's ubiquitous iPhone is about to break new ground with a shift into artificial intelligence that will do everything from smartening up its frequently dim-witted assistant Siri to creating customised emojis on the fly.

The new era will dawn Monday with the unveiling of the hotly anticipated iPhone 16 in a Cupertino, California, auditorium named after Apple cofounder Steve Jobs, who pulled out the first iPhone in 2007 and waved it like a magic wand while predicting it would reshape society.

Apple has sold billions of iPhones since then, helping to create about \$3 trillion in shareholder wealth. But in the past decade, there have been mostly minor upgrades from one model to the next a factor that has caused people to hold off on buying a new iPhone and led to a recent slump in sales of Apple's marquee product.

The iPhone 16 is generating a bigger buzz because it is the first model to be tailored specifically for AI, a technology that is expected to trigger the biggest revoluthrust Apple into the smartthe iPhone 16 could set up Apple to be the gatekeeper of the consumer AI revolution, Wedbush Securities analyst Dan Ives wrote in a research note. ### Declining bank credit to hurt export; traders to flag issue to Goyal

NEW DELHI, Sept 8: The declining bank credit to exporters will hurt the sector, and traders will flag the issue prominently during their meeting with Commerce and Industry Minister Piyush Goyal on September 11, an industry official said on Sunday.

While exports grew by 15 per cent in the rupee terms between 2021-22 and 2023-24, the outstanding credit in March 2024 dropped by 5 per cent over the same month in 2022, according to exporters.

Apex exporters body Federation of Indian Export Organisation (FIEO) said the export credit growth is not keeping pace with rising exports of the country.

"We have seen a decline in export credit between March 2022 and March 2024 despite the need for more credit for longer duration due to hike in prices of commodities, sharp spurt in freight (both sea and air) and the Red Sea crisis, leading to longer voyage time and delayed payment," FIEO Director General Ajay Sahai told PTI.

According to FIEO, the value of export credit outstanding has come down to ₹ 2,17,406 crore in the March 2024 quarter from ₹ 2,27,452 crore in the same quarter last year.

"We will raise this issue during the meeting of the exporters community with the minister," Sahai said, adding that given a consistent decline in credit to exporters during recent times, the RBI should consider prescribing a sub-target for export credit within the existing 40 per cent target for priority sector lending (PSL).

This suggestion is worth considering as despite exports being under PSL, the flow of credit has not improved. It was ₹ 11,721 crore on June 28 this year against ₹ 19,861 crore on July 1, 2022, he added. FIEO also asked for the availability of pre/post-shipment credit in foreign currency (PCFC) at a compet-



itive price through IFSC (International Financial Services Centre) Banking Units (IBUs).

"This is likely to contribute to the difference in financing cost between Indian exporters and their overseas competitors (typically Chinese and ASEAN exporters) and adversely impact the pricing power of Indian exporters. Enabling Pre-shipment financing in foreign currency for Indian exporters from IBUs (along with the existing activity of post-shipment credit from IBU) can significantly boost trade financing volumes,' Sahai said. Due to current geopolitical developments and China plus one policy of the multinational companies, Indian exporters are able to secure additional/new

buyers, he added. Fulfilment of such export orders requires additional working capital that is pre-shipment and post-shipment export credit.

"However, the credit risk assessment done by the exporters, banks may not be able to extend the required export credit. Our nation's exports can reach USD 2 trillion by 2030 through the sufficient availability of the required export

credit," Sahai said. India has a large access gap compared to advanced economies

said the government should address issues related to the interest equalisation scheme

Each bank has framed its own rule and applies its own logic to exercise discretion in giving interest equalisation benefit, Kumar said, adding that while the RBI requires banks not to insist on security for export finance, most banks insist on the same.

The purpose of interest subvention, as envisaged by the government, is to reduce the cost of interest on the rupee borrowing for export finance, thus encouraging exports, but the banks are interpreting the policies as convenient to them without export promotion being the vision, he said.

"There is a need to increase the rate of subvention to at least 4-5 per cent," he suggested.

"The subvention rates were reduced from 5 per cent to 3 per cent and from 3 per cent to 2 per cent in March 2022 due to drop-in interest rates. It is worthwhile to note that the Repo Rate in March 2022 was 4.4 per cent, which currently is 6.5 per cent.

"An increase in the Repo rate by over 2 per cent, with spread by the banks, has pushed the overall interest rates by close to 3 per cent. These rates are much above the pre-Covid rates. Therefore, to provide competitive interest rates, the interest subvention may be restored to 3 per cent and 5 per cent for MSME manufacturers," Kumar added.

The annual net subvention amount has been capped at ₹ 10 crore per Importer-Exporter Code (IEC) in a given financial year. This cap applies to all disbursements made from April 1, 2023, onwards. He said that this has caused problems for exporters, including some SMEs with impressive export turnover, and the denial of interest subvention beyond Rs 10 crore makes their exports uncompetitive. 

### CBI lawyer's dilly-dally

n a significant development in the RG Kar Medical College rape-murder case, the Sealdah court recently expressed its displeasure with the conduct of the Central Bureau of Investigation (CBI) lawyer. The incident has raised questions about the effectiveness of the legal process in such a critical case. The case centers around Sanjay Roy, the prime accused in the horrific rape and murder of a 31-year-old trainee doctor. The court's frustration stemmed from the CBI lawyer's delayed arrival, which could have jeopardized the proceedings. If the court had granted bail during the 50-minute delay, it would have been a severe setback in a case that has gripped the city of Kolkata. The delay in the CBI lawyer's appearance in court highlights a broader issue of accountability within the legal system. While the court's anger is understandable, the threat of granting bail to a prime accused like Sanjay Roy as a consequence of the lawyer's tardiness raises ethical concerns. Granting bail to a person accused of such a heinous crime could have far-reaching implications, not only for the case itself but also for public trust in the

The court's reaction underscores the immense responsibility that comes with judicial power. The Additional Chief Judicial Magistrate, Pamela Gupta, expressed her frustration with the CBI's "lethargic approach." While the CBI lawyer eventually arrived and opposed the bail plea, the delay had already created a tense situation in the courtroom. The court's warning, though ultimately not acted upon, serves as a reminder of the delicate balance between judicial discretion and the pursuit of justice. The CBI's investigation into this case has also come under scrutiny. Critics have questioned why the agency has shifted its focus from the rape-murder case to investigating corruption charges against the Principal of RG Kar Medical College. The court had previously emphasized the gravity of the situation and the need for prompt action. The public is left wondering if the CBI's diversion of attention is hindering the pursuit of justice in the case of the murdered trainee doctor. The political implications of the case cannot be ignored. The Trinamool Congress has accused the CBI of sabotaging justice, pointing fingers at the Bharatiya Janata Party (BJP) and the Modi government. The political blame game only adds to the complexity of the case, with allegations that the BJP is trying to exploit the situation for political gain. Meanwhile, Sanjay Roy remains behind bars, but the lack of concrete evidence against him continues to raise questions.

At the heart of this case is the tragic loss of a young life. The court's decision to deny bail and remand Sanjay Roy to judicial custody is a step toward ensuring justice is served. However, the episode serves as a stark reminder that delays and missteps in the legal process can have serious consequences. The public's trust in the justice system is fragile, and cases like this one test its limits. While the court ultimately made the right decision, the incident should prompt reflection within the legal community. The pursuit of justice requires diligence, responsibility, and, above all, a commitment to ensuring that those accused of heinous crimes are held accountable without unnecessary delays. This case also underscores the need for better coordination between legal authorities to prevent delays that could jeopardize crucial proceedings.

No matter how rich a country is, if education is poor, it can never progress.

In recent times, globalization has placed great emphasis on education around the world and various measures have been taken to implement the 'Education for All' system for the overall development of education. It has emphasized the need for the expansion and influence of science and technology in the modern education system and has made it progressive by expanding vocational education, enabling people to find new paths in the complex pace of life.

Under Article 45 of the Constitution of India, free and compulsory primary education for all children aged 6 to 14 years is adopted as the guiding policy and various schemes are adopted to achieve the objectives of universal primary education. These schemes include Operation Blackboard, Restructured and Restructured Teacher Training System, District Primary Education Scheme, Mid-Day Meal Scheme, Non-formal education; Education Guarantee Schemes, Alternative and Innovative Education Systems, Janshala Schemes and Sarva Shiksha Abhiyan have contributed significantly to bridging the gaps in achieving the goals of universal education.

However, even these can never improve the educational quality of a school. The most important thing is to entrust the responsibility of teaching to the right people. In fact, the quality of education will improve if every teacher can develop himself as a real educator and only then will the students be able to receive real education.

It cannot be denied that there has been a major decline in education in our state from primary to secondary level recently. The stage that should be given higher priority in order to improve the quality of education has been neglected in our state. As a result, education has deteriorated and been adversely affected. Needless to say, if the foundation it-

ucation as a whole. Therefore, teachers should be recruited in each school according to the needs with proper consideration to improve the quality of education. Teachers must be made great with proper training.

The most important issue is the lack of teachers in many educational institutions in our state. Some schools have science teachers, but no art teachers. In some schools, the opposite picture again in another school. As a result, although various steps have been taken to improve education, the desired results have not been achieved. As per the policy of the Central Government, the teacher-student ratio is 1:30 in primary, 1:35 in upper primary and 1:40 in secondary. This means that one teacher should be recruited for every thirty to forty students from primary school to secondary school respectively. But is this equal arrangement in the educational institutions of Assam? Have well-planned schemes been implemented in this re-

Today, one of the most discussed issues at the primary level is the recruitment of classwise teachers. There are still many primary schools in rural areas with more than forty students but only two teachers. The headmaster is busy with everything from shopping for lunch to various office works have to attend various departmental discussions and meetings at different times.

Therefore, most of the time the assistant has to teach all the classes of the school from class Kaman to class V and take care of all aspects of the students. Everyone can understand how effective teaching and learning will be in such circumstances. There is no reason why a teacher should teach six classes at the same time. There are also many schools where the number of teachers is relatively higher than the number of students

In 2017, the Government of Assam adopted a scheme to assess the quality of schools in schools from class I to class VIII called 'Gunotsay'. The results of the Gunotsav, which was conducted in four phases with the aim of identifying educational gaps and taking diagnostic education measures, have already been published.

propriate to take steps to improve government schools and to continue these efforts in the future this will lead to progress in the field of education.

In fact, the most flawed and offensive aspect of the education system in Assam is the system of formulation, publication and distribution of textbooks. In the field of secondary education, the Mudaliar Commission (1952-53), the Kothari Commission (1964-66) and the National Education Policy (1986) formed after independence in Assam have been trying to make the development of education interesting That has been discussed at all levels.

In conclusion, it can be said that it is very important for the conscious educated people, parents and the teaching community to come together to bring to life this primary and secondary level education system, which is the foundation of life and the Education Department should also come forward to take a well-planned system of schemes to remove the anarchies in the academic world. The shift from the Old Pension Scheme (OPS) to the National Pension Scheme (NPS) sparked significant discontent among government employees, and opposition parties, notably Congress, saw an opportunity to challenge the BJP-led central government. Congress, in its election manifesto, promised to restore OPS in states where they achieved power, alongside various other incentives. Montek Singh Ahluwalia has publicly warned that reinstating OPS for employees who joined service after 2004 could severely damage the nation's economy, a perspective echoed by many experts. Although Congress won the Himachal Pradesh Assembly election with a pledge to revert to OPS, this promise was not fulfilled. Furthermore, in the Telangana elections and the 2024 Lok Sabha elections, Congress did not mention the revival of OPS in their manifestos.

Following disappointing Lok Sabha results in Maharashtra, Rajasthan, Haryana, and Uttar Pradesh, the BJP has had to navigate a challenging situation, seeking a compromise between the Old Pension Scheme (OPS) and the National Pension Scheme (NPS). The central government is now proposing a new initiative, the United Pension Scheme (UPS), which aims to offer a pension equivalent to 50% of the average salary from the last twelve months of service for employees with 25 years or more of service. This pension will be adjusted for inflation through dearness

allowance twice annually. Additionally, the scheme includes a provision for a 60% family pension for (OPS) placed a significant fi- the dependents of deceased employees. However, it excludes those with monthly pension of Rs 10,000. An extra incentive is also introduced with a lump sum payment based on the length of government service. The new United Pension Scheme

(UPS) is set to launch on April 1, 2025, and will be available to 23 lakh central government employees who choose to participate. Should all states adopt the scheme, it could benefit up to 90 lakh employees nationwide. The Maharashtra government, which is preparing for an upcoming Assembly election, has already committed to implementing UPS. Like the National Pension Scheme (NPS). UPS is a contributory plan where employees' contributions will remain at 10%, but the government's matching contribution will rise from 14% to 18.5%.

For an employee with a monthly salary of Rs 50,000, the annual growth of their pension corpus is projected at 3%, translating to a compound annual growth rate of 8%. The State Bank of India (SBI), Life Insurance Corporation (LIC), and Unit Trust of India (UTI) manage the pension corpus for employees. SBI provides an interest rate of 9.75%, while LIC offers 9.56%. Under the current National Pension Scheme (NPS), government employees can choose from three investment options, with 95% of subscribers opting for a portfolio consisting of 65% in government securities, 15% in equities, and 20% in corporate debt. Given that the corpus may not generate enough to provide 50% of the average salary over the last twelve months, the government has increased its matching contribution from 14% to 18.5%. Cabinet Secretary TV Somanathan described the United Pension Scheme (UPS) as "definitely fiscally more prudent," noting that it maintains the structure of a contributory funded scheme.

The key distinction lies in the nature of the schemes: the Old Pension Scheme (OPS) is an unfunded, noncontributory plan, whereas the new scheme is a funded, contributory one. The primary adjustment made is to provide a more reliable assurance rather than relying on the uncertainties of market fluctuations.

"The UPS incorporates the most advantageous features of both the OPS and NPS," he noted. Economists believe that UPS effectively balances fiscal responsibility with employee expectations. The scheme addresses rising living costs by ensuring that the real value of the pension remains constant, as it is exed to inflation. In under the NPS, rising inflation can reduce the real value of the pension. However, implementing the UPS will initially impose an additional financial burden of Rs 6,250 crores on the government in its first year.

This move aims to appease the 23 lakh beneficiaries, a significant and vocal political constituency that no party can afford to disregard. It is anticipated that most states will opt for the UPS, even if it means accepting the additional financial bur-

In response to the announcement of the UPS, opposition parties are intensifying their calls for a return to the Old Pension Scheme (OPS). Economists have consistently warned that reinstating OPS could slow economic growth and hinder national progress, while also adversely affecting poorer populations. The Economic Advisory Council to the Prime Minister has cautioned that reverting to OPS could be disastrous for low-income groups and could deter private investment in states that adopt it. Additionally, the Reserve Bank of India had raised concerns in January 2023 about the financial implications for states considering a return to OPS.

The Reserve Bank of India had already warned that reverting to the Old Pension Scheme (OPS) could lead to a buildup of liabilities, posing significant future risks. The RBI also projected that pension expenditure for states would increase by 16%, reaching Rs 4,63,436 crores compared to Rs 3,99,813 crores the previous year. Under the National Pension Scheme (NPS), pension outgo is Rs 4 lakh crores, but this would surge to Rs 17 lakh crores if OPS were reinstated. Currently, Rajasthan, Chhattisgarh, and Punjab have reverted to OPS. However, with the BJP regaining power in Rajasthan and Chhattisgarh, it is anticipated that these states will continue with the NPS and adopt the United Pension Scheme (UPS) starting April 1, 2025. Punjab, governed by the Aam Aadmi Party (AAP), prioritizes maintaining power over financial concerns, which may influence its approach to pension reforms. In an interview with the Indian news agency PTI. Hasina hastily fled, when the students and protesters on August 5 marched to Gonobhaban, the official residence of the Bangladesh Prime Minister. Tens of thousands from east, west, north and south joined the rally, the Bangladesh Army responsible for her security, forcibly whisked her away to a military airfield, a kilometre away and air dashed her to an air force base, adjacent to Dhaka International Airport. She boarded a transport plane and flew to Delhi, sinking her party's boat (election symbol). She also abandoned thousands of leaders and millions of members of her party, the Awami League.

In the absence of a backup plan, the dumbstruck leaders and members of the Awami League either went into hiding and many tried to leave the country. Few managed to fly away. Some paid a hefty price to human traffickers and crossed the porous international border to India. At Hindon Air Base near Delhi, where the Bangladesh Air Force transport plane landed, there she is still living in a safe house

for a month. After hectic negotiations with several "friendly" Western countries, one after another her requests were turned down. A top Indian diplomat stationed in Dhaka said what India would do when applications for refugee status (political asylum). The United States promptly revoked her multiple visa. 10-vear Bangladesh's new regime invalidated her Red and Green

passports. Hasina is a stateless person. Delhi is now in a fix! It is understood that Hasina is apparently under house arrest. She is not allowed to venture out of the safe house to take a stroll around the place, nor allowed to buy essentials

nearby. Her daughter Saima Wazed, who is employed as Regional Director of the World Health Organisation (WHO) South-East Asia office in New Delhi, has not been able to meet her.

Saima in posts on Twitter (X) has given several excuses for her tight schedule and unable to hug her mother. Her elder brother in Washington DC had announced to visit Delhi and meet her mother. Unconfirmed news claims that Sajeeb Wazed Joy was asked not to arrive in Delhi, as he may not be able to meet her.

Many political observers say after Dr Yunus had a telephonic conversation with Prime Minister Narendra Modi, the Indian authorities decided to sever all communications with the outside world and stav away from her. ## Diet rich in fruits and vegetables may reduce heart and kidney disease risk

ypertension, commonly known as high blood Lpressure, is the leading preventable risk factor for cardiovascular disease, such as heart disease and stroke. Based on 2017-2020 data, 47% of U.S. adults are estimated to have hypertension.

Uncontrolled high blood pressure can also lead to the occurrence and progression of chronic kidney disease. The early adoption of lifestyle modifications, such as dietary changes, can reduce the risk of complications of uncontrolled hypertension and the need for drug therapy. However, such dietary interventions are often

A new 5-year follow-up study published in The American Journal of Medicine involving high blood pressure patients with chronic kidney disease shows that incorporating 2 to 4 additional cups of fruits and vegetables in their daily diet along with drug therapy resulted in lower blood pressure, a larger reduction in cardiovascular risk factors, and a greater preservation of kidney health than drug therapy alone.

The patients were specifically prescribed fruits and vegetables that increase blood pH levels after their metabolism. The protective effects on kidney health in the group consuming the diet rich in fruits and vegetables were also seen in participants who were administered an oral sodium bicarbonate tablet daily.

Sodium bicarbonate also increases the blood pH, and these results suggest that rebalancing of plasma pH could have potentially mediated the effects of increased fruit and vegetable consumption on kidney health. However, while both were shown to improve kidney health, only consuming fruits and vegetables, and not sodium bicarbonate, reduced blood pressure and improved cardiovascular disease risk factors.

The study's author, Dr. Donald Wesson, a professor of internal medicine at The University of Texas at Austin, said, "The study supports redoubling our efforts to make diets high in fruits and vegetables foundational to the treatment of hypertension, with drugs added as needed to achieve blood pressure goals and to prevent kidney and cardiovascular complications."

"An additional benefit of including extra fruits and vegetahypertension management appears to be that lower doses of anti-hypertensive drugs will be needed to achieve these health benefits," said Dr. Wesson.

#### Link between hypertension and chronic kidney disease

Besides cardiovascular diseases, uncontrolled high blood pressure is also a risk factor for chronic kidney disease. High blood pressure is associated with the narrowing and stiffening of blood vessels in the body, including the kidneys.

While the body possesses mechanisms to limit kidney damage in response to changes in systemic blood pressure, once blood pressure increases beyond a certain threshold, it can cause the blood vessels in the kidney to harden and influence their function.

Specifically, prolonged high blood pressure can cause damage to the glomeruli, the specialized blood vessels in the kidney that filter wastes and water from the blood. High blood pressure can thus impair kidney function, hampering its ability to filter wastes from the blood. In addition, chronic kidney disease is also characterized by the excretion of proteins in

The progression of chronic kidney disease further increases the risk of cardiovascular disease, with cardiovascular disease being the leading cause of death in patients with kidney disease. This highlights the importance of the management of high blood pressure and protecting kidney function.

#### Role of diet in managing hypertension

Lifestyle changes, including adopting healthier dietary patterns, are the recommended first line of treatment for managing high blood pressure. For instance, the Dietary Approaches to Stop Hypertension (DASH) diet, promoting the consumption of fruits, vegetables, lean protein, and low-fat dairy products, has been developed to help lower blood pressure in patients with hypertension.

Moreover, the DASH diet can reduce overall cardiovascular disease risk and prevent or slow down the progression of chronic kidney disease. In addition, medications, such as angiotensin receptor blockers, are typically prescribed to patients with high blood pressure and other conditions like chronic kidney disease or heart failure.

In general, studies suggest that diets rich in fruits and vegetables, such as the DASH diet. are linked to a reduced risk of chronic kidney disease occurrence and progression and lower cardiovascular disease risk. In the present study, the researchers further examined the protective role of fruits and vegetables in individuals with hypertension and chronic kidney

How acid-producing foods affect kidney health

Most plant-based foods, including fruits and vegetables, produce basic (alkaline) compounds after digestion, leading to a net increase in blood pH levels. So, these foods are referred to as alkaline foods.

In contrast, most animal products and grains, consumed in large amounts in Western diets, tend to produce acid and decrease blood pH levels after their metabolism. These are referred to as acidic foods.

The kidneys contribute to the maintenance of blood pH levels by excreting acids and reabsorbing bases. However, the kidnevs can only excrete a limited amount of acid to maintain the body's pH, and the higher consumption of acid-producing foods can potentially impair kidney function.

"Our animal studies showed years ago that mechanisms used by kidneys to remove acid from the blood can cause kidney injury if the animals were chroniexposed to an acid-producing diet. Our patient studies showed similar findings: that is, an acid-producing diet (one high in animal products) was kidney-harmful, and one that is base-producing (one high in fruits and vegetables) is kidney-healthy," explained Dr. Wesson. Observational studies also suggest that consuming a diet rich in acidic food is associated with negative health outcomes, including increased risk of cardiovascular diseases.

"Other investigators showed that a diet high in fruits and vegetables is heart-healthy. We hypothesized that one way that fruits and vegetables are both kidney- and heart-healthy is that they reduce the amount of acid in the diet and therefore the amount of acid that kidneys have to remove from the body," Dr. Wesson further noted.

Consistent with this hypothesis, some studies have suggested that dietary acid reduction using oral sodium bicarbonate (baking soda) can slow down the progression of chronic kidney disease. However, more research is needed to better understand the role of dietary acid load in preventing and managing chronic kidney disease.

In the present study, the researchers compared the effectiveness increased consumption of fruits and vegetables with sodium bicarbonate in slowing the progression of chronic kidney disease, controlling blood pressure, and improving cardiovascular health in high blood pressure patients with established kidney disease.

2 to 4 cups of fruit a day The present randomized controlled study involved 153 individuals with high blood pressure and chronic kidney disease. The study only included participants with an elevated albumin-to-creatinine

urine ratio (200mg/g). Albumin is a protein present in blood, whereas creatinine is a byproduct of muscle metabolism that is normally excreted via the urine. High levels of albumin in the urine can indicate chronic kidney disease, and these patients are at an increased risk of cardiovascular diseases and further progression of kidney disease.

Although these patients had kidney disease, they still showed normal glomerular filtration rates, placing them in a category likely to benefit the most from kidney-protective interventions. The participants were randomly assigned to either the fruits and vegetables intervention, oral sodium bicarbonate treatment, or the usual treatment groups.

The participants in the fruits and vegetables group consumed 2 to 4 additional cups of baseproducing fruits and vegetables daily, in addition to their regular daily diet. Individuals in the sodium bicarbonate group were given an oral dose that would have a similar effect on blood pH levels to that observed after the digestion of 2 to 4 cups of fruits and vegetables.

All participants received usual care, which involved statins to protect cardiovascular health and anti-angiotensin II blockers to preserve kidney health. The patients were tracked over a period of five years to assess changes in kidney and cardiovascular health.

#### Health impact of eating more fruits and vegetables

During the five-year followup period, the researchers tracked changes in glomerular filtration rates to assess kidney function and in urine albuminto-creatinine ratio to monitor kidney disease progression. They also looked at cardiovascular disease markers.

The researchers found that the individuals in the usual treatment group showed a greater decline in kidney function and a larger increase in the albumin-to-creatinine ratio than both the fruits and vegetables and sodium bicarbonate intervention groups.

The researchers did not observe a difference in kidney function or urine albumin levels between the fruits and vegetables intervention and sodium bicarbonate group. These results suggest that both increased consumption of fruits and vegetables, as well as oral sodium bicarbonate intake, had a greater protective effect on kidney health and function than drug therapy alone.

vegetables intervention and the sodium bicarbonate groups showed higher plasma bicarbonate levels than the usual treatment group, which may indicate better acid-base balance in the body. This suggests that both increased fruit and vegetable consumption and oral sodium bicarbonate could potentially exert protective effects on kidney health through changes in the acid-base bal-

Participants in all three groups showed a decline in systolic blood pressure during the follow-up period, but the fruits and vegetables intervention group showed the largest reduction. In addition, the fruits and vegetables intervention group showed greater improvements in other cardiovascular markers, including body mass index and low-density lipoprotein (LDL) cholesterol, than the oral sodium bicarbonate and usual treatment groups.

Lastly, participants in the fruits and vegetables intervention group had superior health outcomes despite being on lower doses of blood pressure medication than the sodium bicarbonate and usual treatment groups. "This study demonstrated that a diet high in fruits and vegetables can significantly lower important indices of cardiovascular disease risk such as high blood pressure, LDL cholesterol, and BMI. These results further support our recommendations to eat a diet rich in fruits and vegetables as part of a 'heart-healthy diet.'" — Dr. Cheng-Han Chen, MD, a board-certified interventional cardiologist and medical director of the Structural Heart Program at MemorialCare Saddleback Medical Center in Laguna Hills, CA. ### **Understanding Coronary Angiography** & Angioplasty

eart attack is one of the leading causes of Ldeath globally. The reasons for Heart Attack are many but mainly It occurs by narrowing or blockage of coronary arteries, which supply blood to the heart muscle. This blockage is usually due to the buildup of cholesterol, fatty deposits (plaque), and other substances that form atherosclerosis. When a plaque ruptures, it can create a blood clot (thrombus) that blocks the artery and deorives the heart muscle of oxygen-rich blood, leading to a heart attack

#### **Understanding Coronary** Angiography and Angioplasty: Procedures and benefits in heart disease

Coronary angiography and angioplasty are critical procedures used to diagnose and treat heart disease, particularly in cases where there is a suspicion of blockages or narrowing in the coronary arteries. These procedures play a vital role in assessing the severity of heart disease and restoring blood flow to the heart muscle, thereby preventing complications such as heart attacks and improv-

#### ing overall heart function. Coronary Angiography: exploring the heart's arter-

Coronary angiography, also known as cardiac catheterization, is a procedure used to visualize the coronary arteries—the blood vessels that supply oxygenrich blood to the heart muscle. It involves the insertion of a catheter (a thin, flexible tube) into an artery, usually in the groin or wrist, and guiding it to the coronary arteries under X-ray guidance.

allbladder cancer, although less talked about compared to other cancers, is a serious condition that requires more attention and awareness. Gallbladder cancer is a significant health concern in India. In 2022, India reported 21,780 new cases of gallbladder cancer, making it the second-highest in the world after China. With its subtle symptoms and aggressive nature, early detection is key to improving patient outcomes and survival

#### Understanding gallbladder cancer

Gallbladder cancer starts in the gallbladder, a small organ beneath the liver. Although it is rare, its diagnosis often comes at an advanced stage, making it particularly deadly. The gallbladder's location deep within the body means early tumours often go undetected until they cause significant symptoms.

#### Risk factors

Several factors can increase the risk of developing gallbladder cancer, including chronic inflammation from gallstones, which is a major risk factor. Women are more frequently diagnosed with gallbladder cancer than men, and the risk increases with age, particularly in those over 65. Excess body weight is also linked to an elevated risk. Additionally, a family history of gallbladder cancer can increase the likelihood of developing the disease.

Hidden health crisis of Gallbladder Cancer

#### Symptoms to watch for

Early stages of gallbladder cancer are often asymptomatic, but as the disease advances, symptoms may emerge, including abdominal pain, particularly in the upper right section, jaundice (characterized by yellowing of the skin and eyes), nausea and vomiting, bloating, and unexplained weight loss.

#### Diagnosis and treatment

Diagnosing gallbladder cancer typically involves imaging tests such as ultrasound, CT scans, and MRIs, followed by a biopsy to confirm the presence of cancerous cells. Blood tests may also be conducted to check for liver function and tumor markers.

Treatment options for gallbladder cancer vary based on the cancer's stage and the patient's overall health. For early-stage cancer, the primary treatment is surgical removal of the gallbladder (cholecystectomy), while advanced cases may require removal of part of the liver and surrounding tissues.

Radiation therapy, utilizing high-energy rays, targets and kills cancer cells, often used post-surgery to eradicate any remaining cancerous tissue. Chemotherapy involves powerful drugs to eliminate fast-growing cancer cells, especially when the cancer has metastasized beyond the gallbladder. Targeted therapy focuses on specific abnormalities within cancer cells, inhibiting their growth and spread.

The importance of early detection Early detection significantly improves the prognosis for gallbladder cancer patients. Regular check-ups and awareness of risk factors can lead to earlier diagnosis and more effec-

tive treatment. Healthcare providers stress the importance of seeking medical advice if any symptoms or risk factors are present. Gallbladder cancer, though rare, poses a sig-

nificant health threat due to its aggressive nature and late diagnosis. ### Yellow food dye can make living tissue transparent – these methods could one day improve cancer treatment

Thy isn't your body transparent? Some animals such as jellyfish, zebra fish and some glass frogs have see-through bodies. But most mammals, including humans, aren't transparent. While the idea of a transparent body might seem odd or even a bit creepy, it could actually be really helpful for doctors. If our bodies were transparent, doctors could easily see inside to diagnose diseases in organs such as the liver. spleen and brain. They wouldn't need invasive procedures such as biopsies or expensive machines such as CT scanners and MRIs.

I'm a materials scientist, and my team and I work on how new materials can aid biomedicine. My colleagues and I have wondered whether it's possible to make living tissue transparent temporarily to aid in medical treatments and other uses.

We discovered that by dissolving certain dye molecules, including a food dye commonly used in snacks called FD&C Yellow 5, into water, we can change the way light travels through the water. We used this phenomenon to make organic tissue – specifically the thin skin of mice – transparent in our study, published in September 2024 in Science.

#### Refractive indices

Our bodies, like those of most mammals, aren't transparent mainly because of how light interacts with our tissues. Normally, light travels in a straight line through the air. But when light hits the human body, it doesn't go very far before its path gets scattered. The light bounces around in different directions instead of

passed through us without scattering, our tissue would be transparent. This scattering happens because human tissues are made up of many different components, including water, fats and proteins. Each of these components slows down light differently, a property

known as the refractive index. For example, water has a refractive index of about 1.33, while fats and proteins have a higher refractive index of around 1.45 in the visible spectrum. So, light travels more slowly in lipids than in water.

The key to making living tissue transparent would be to reduce the differences in how light moves through different parts of the tissue – specifically between water and fats and proteins.

#### **Kramers-Kronig relations**

A principle in physics known as the Kramers-Kronig relations explains how if a material absorbs more light of one color, such as blue, this increased absorption will change how light of a different color, such as red, moves through it. Kramers-Kronig relations say that the colors of light are not independent of each other but connected.

FD&C Yellow 5 absorbs blue light strongly, which yields its characteristic orange-to-red color when dissolved in water. This happens because the blue part of the light is absorbed, leaving only the orange-to-red part visible. As a result of the Kramers-Kronig relations, this absorption of blue light increases the refractive index of water for red light. The water's refractive index increases from 1.33 and matches that of fats and

proteins, around 1.45. When the refractive indices

traveling straight through. If light match, red light no longer scatters as much. It travels in water the same way that it does in fats in the tissue. So, the whole tissue appears as a single, uniform material. This process can make the tissue look transparent, even

#### though it's normally opaque. **Turning tissue transparent**

My research team applied this idea in an experiment using a scattering phantom, which is a material designed to mimic the opaqueness of human skin. As we added more FD&C Yellow 5 dye to the phantom, it became more orange-red in color, just as we expected.

However, something else happened. It became more transparent to red light. This increased transparency allowed us to see the grid pattern on the table underneath the phantom.

We then decided to test this idea on a piece of chicken breast from the grocery store. Unless it's sliced very thin, chicken meat usually looks opaque. When we soaked the chicken breast in a solution containing FD&C Yellow 5 dye, something amazing happened. It became more transparent, allowing us to clearly see a

Stanford sign placed underneath. Finally, we used this idea to make the skin of a mouse optically transparent. We applied the FD&C Yellow 5 dye to different parts of the mouse's body. When we added it to the mouse's scalp, we could see the blood vessels in its brain. When we added it to the mouse's belly, we could see its gut. When we added it to the mouse's limbs, we could see its muscle fibers. All this experiment took was gently massaging a solution of the dye into the mouse's skin and a bit of patience.

This process is noninvasive because it doesn't require tissue removal or surgery, and the skin returns to its normal opacity once you rinse off the dye with water. Although it's a fascinating technique, we strongly advise against

trying this on yourself. While the use of Yellow 5 is approved by the FDA, some people have raised concerns about its potential health risks. These include allergic reactions – particularly in people with asthma - hyperactivity in children and potential links to cancer. But researchers will need to conduct more tests to determine whether there are any

#### **Future uses**

So what could this approach be used for? Right now, it works best on very thin layers of skin, like that of a mouse.

Unfortunately, human skin is much thicker, so this method isn't quite ready for practical use on people vet. Also, the red color of the dye means that the colour balance isn't quite right and the transparency isn't perfect across the entire visible spectrum. The dye still blocks blue light.

It could also aid in the early detection of skin cancer, enhance light delivery into deep tissues for photodynamic and photothermal therapies and simplify laser-based tattoo removal. In photodynamic and photothermal therapies, doctors use a laser to kill cancerous and precancerous cells. But light from the laser penetrates only so far into the tissue, so these therapies aren't suitable for organs deeper in the body – yet. All of these applications could benefit from a reversible, on-demand transparency window into the body. (Courtesy: Down To Earth)

ISLAMABAD, Sept 8: Pakistan's Defence Minister Khawaja Asif has said that the evidence against jailed former prime minister Imran Khan points towards a military trial in the cases concerning the violence on May 9 last year, a media report said on Sunday.

Speaking to a private news channel on Saturday, Asif said that military trials had taken place before and will continue to do so in future as well, Geo News reported.

"Evidence against founder Pakistan Tehreek-e-Insaf party founder (Imran Khan) points towards military trial," Asif said.

His remarks come after 71-yearold Khan - fearing a military trial over his alleged involvement in the May 9 riots - filed a petition in the Islamabad High Court (IHC) to stop his potential trial in military courts.

However, the IHC registrar's office raised objections over Khan's plea, saying that neither it mentioned any specific first information report (FIR) nor any documentation or order was attached to the petition and how a petition be filed in a high court while the matter of military trials is sub judice in the Supreme Court.

It is not the first time that the ruling Pakistan Muslim League-Nawaz (PML-N) expressed such a possibility. Several leaders of the party have accused Khan of orchestrating the May 9, 2023 violence.

On September 2, Asif had said that a military trial of Khan was "possible". He had said that during the Khan-led government, military trials of the civilians were held and he remembers cases of 24 civilians who went through the process of facing military court.

### Yemen's Houthi rebels claim they shot down another US MQ-9 drone

**DUBAI, Sept 8:** Yemen's Houthi rebels claimed early Sunday they shot down another American-made MQ-9 drone flying over the country, marking potentially the latest downing of the multimillion-dollar surveillance aircraft. The US responded with airstrikes over Houthi-controlled territory, the rebels said.

The US military told The Associated Press it was aware of the claim but has "received no reports" of American military drones being downed over Yemen.

The rebels offered no pictures or video to support the claim as they have in the past, though such material can appear in propaganda footage days later. However, the Houthis have repeatedly downed General Atomics MQ-

9 Reaper drones in the years since they seized Yemen's capital, Sanaa, in 2014. Those attacks have exponentially increased since the start of the Israel-Hamas war and the Houthis launched their campaign targeting shipping in the Red Sea corridor. Houthi military spokesperson Brig. Gen. Yahva Saree made the claim

in a prerecorded video message. He said the Houthis shot down the drone over Yemen's Marib province, a long-contested area home to key oil and gas fields that's been held by allies of a Saudi-led coalition battling the rebels since 2015.

### All available evidence suggests that Venus is currently volcanically active

#### Moon had surprisingly recent volcanic activity, samples from Chinese space mission confirm LANCASTER (UK), Sept 8: ing the mission's launch in 2009. thus causing the crater-counting Lunar eruptions should have in-

Volcanoes were erupting on the Moon as recently as 120 million years ago, evidence collected by a Chinese spacecraft suggests. Until the last few years, scientists had thought volcanic activity ended on the Moon around 2 billion

The findings, published in Science, come from analysis of lunar rock and soil delivered to Earth by China's Chang'e 5 spacecraft in 2020. While these results are difficult to reconcile with the accepted history of lunar volcanism, it's possible some areas of the Moon's interior were more enriched in radioactive elements that generate the heat that drives volcanic activity.

The region where Chang'e 5 landed, called Oceanus Procellarum, may be one such area where rocks were enriched in these heat-producing elements.

.Volcanism is a major way in which all rocky planetary bodies lose their heat. The rocky bodies in our Solar System are Earth, Venus, Mars, Mercury, Jupiter's satellite Io, and Earth's satellite, the Moon.

All available evidence suggests that Venus is currently volcanically active. On Mars, we can date the ages of formation of large lava flows by counting the numbers of impact craters on these flows.

This crater-counting technique relies on the fact that craters form randomly and uniformly across planetary surfaces, so highly cratered terrains are considered older. The results suggest that Mars, which is half the size of Earth, is volcanically active every few million years.

This is expected, because larger bodies conserve heat better than smaller ones. On this basis Mercury, which is a third of Earth's size, and our Moon, a quarter the size of Earth, should have been volcanically dead for about 2 billion years.

The same should be true of Io, which is similar in size to our Moon. However, tidal forces generated by gravitational interactions with Jupiter give Io an additional, strong heat source. Io

The Moon's dark areas Most eruptions on the Moon

took place near the edges of giant depressions formed early in the Moon's history by asteroid impacts. Lava flooded the interiors of these basins to form the dark areas on the Moon's near side. These areas are call maria (singular mare), the Latin for seas, because the flat sheets of lava were mistaken for expanses of water by

early observers.

Analyses of the composition and age of samples returned from these mare areas by the six Apollo missions and three Soviet robotic probes were consistent with the belief there had been no geologically recent volcanic activity on the Moon.

This understanding persisted until very high-resolution images of the lunar surface from the US Lunar Reconnaissance Orbiter mission became available follow-

Counts of the numbers of very small impact craters revealed a lack of craters in some volcanic areas with unusual surface textures, named irregular mare patches (IMPs).

The simplest explanation for this was that these IMPs were young, typically about 100 million years old. This is 20 times younger than the 2 billion-year youngest age that had been expected.

In an attempt to reconcile these observations with the accepted history of lunar volcanism, it was pointed out that the lack of any atmosphere on the Moon would make eruptions there significantly different from those on Earth. The lack of confining pressure would have allowed erupting lavas to release almost all of the gaseous compounds dissolved in them, allowing some lava flows to contain very large numbers of gas bubbles to the extent of being a foam.

Meteoroid impacts into this soft foam would produce much smaller craters than in solid rock, method to give ages that were too

This issue has seen much debate, and the best way to resolve it is the return of samples to Earth for detailed laboratory analysis. Chang'e 5 brought back samples from a very large lava flow which was already known, from cratercounting, to be relatively young in geological terms.

Initial analyses of many fragments of the lava were consistent with the long-accepted theory that lunar volcanism stopped 2 billion years ago. However, closer examination of the Chinese samples, as described in the new Science paper, focused on some of the smallest fragments the majority from rock shattered and melted into droplets by meteoroid impacts. Three of these 3,000 droplets were identified from their detailed chemistry as volcanic in origin, and are only 120 million years old very similar to the young ages inferred for IMPs elsewhere on the Moon.

**Lunar eruptions** 

volved high lava fountains like those commonly seen erupting in Hawaii, for example. While most of these droplets would have accumulated into lava flows, some would have been thrown out for tens of kilometres to other parts of the Moon's surface. The three volcanic droplets

identified in the Chang'e 5 sample were probably not erupted from the same vent as the bulk of the rock and soil delivered to Earth. This would explain why these droplets are much younger than the lava flow at Chang'e 5's landing site. These three glassy droplets are the first physical evidence we have for anomalously recent volcanic activity on the Moon. There would have to have been much higher concentrations of heat-producing radioactive elements in some areas than others for volcanic activity to have occurred as recently as the new results imply. So, these findings could prompt a major revision in our understanding of how the Moon developed. (AP)

## Liquor shops near national highways to be relocated: Tripura CM

AGARTALA, Sept 8: In a bid to check fatal road accidents caused by drunken driving, Tripura Chief Minister Manik Saha on Sunday directed law enforcement agencies to prepare a comprehensive report on liquor shops operating within 100 metres of national highways following which his government would take steps to relocate the outlets.

In December 2018, the Supreme Court banned the sale of liquor within 500 meters of the outer edge of national and state highways and the limit was reduced to 220 metres for locations with a population of 20,000 or less.

'Tripura recorded 1,340 deaths and 3,824 injuries in 3,308 road accidents in the last six years. Although the number of road accidents seems less in the state compared to the number of vehicles (8, 88,203), police and other law enforcement agencies must work to reduce fatal road mishaps," he said at a programme here on road safety. Saha said law enforcement agencies must prepare a list of liquor shops function-

**GUWAHATI, Sept 8:** In a swift operation, Tripura Police apprehended four Bangladeshi nationals in the early hours of Saturday for illegally crossing the India-Bangladesh border. The arrests took place in Kumarghat, Unakoti District, after the group was spotted behaving suspiciously in the area.

The apprehended individuals, identified as Mohammad Hanif (50), Mohammad Yusuf Ali (35), Parul Begum, and Jasmine Akhtar, all from different parts of Bagerhat district in Bangladesh, had reportedly entered India through a border town. They had traveled by auto-rickshaws throughout the night before being

dropped off near the LIC office in Dharmanagar. Upon questioning, the group revealed that they had been lured to India by a man named Rubel from Dhaka, who had promised them employment opportunities in Bangalore.

The deteriorating economic conditions in Bangladesh are believed to have motivated the individuals to seek better prospects in India.

The arrested individuals have been presented before a local court, and legal proceedings are underway. Tripura Police is continuing its investigation into the matter and is working to identify any potential human traffickers involved in the illegal entry.

## **ANSAM condemns Kuki-Chin-Mizo Rally**

Accuses community of historical distortion and provocation

SENAPATI, Sept 8: The All Naga Students' Association, Manipur (ANSAM) said on Sunday that it took strong exception to the "outrageous demands and unwarranted provocations of a particular community including the recently concluded rally of Kuki-Chin-Mizo in the hill areas on August 31, across Nagas homeland that poses serious political implications and threat to the already turmoil situation of the state". The Naga student body said it issued this statement to put across its "serious concerns and dismay over their continued demands and claims based on blatant lies and invention of lop-sided his-

In a statement made available to Newmai News Network on Sunday, the Naga student body said, "Time and again, the Nagas are perturbed by the circulation of fabricated information, distorted statements and historical accounts contained in every press release and memorandum issued by the Kuki- community which is tantamount to assault on Naga history and insult to the Naga people".

It also said, "Indeed, it is very unfortunate and alarming that endless fabricating stories and concoction of history has been trending far and wide put forth by the Kuki-Chin-Mizo recklessly to suit their wild imaginary dream, taking undue advantages over the civility and understanding of Nagas towards them".

The ANSAM then said it has also seriously viewed on the "contumacious behaviour and chilling provocation" of Kuki-Chin-Mizo protesters towards the Naga leaders in and around Tumnaopokpi areas on August 31, while they were conveying "gentle caution and advisory" not to provoke Nagas to avert any possible confrontation between the two communities.

The ANSAM then questioned the veracity of including the names of Naga tribes- Anal, Aimol, Chiru, Chothe, Lamkang, Moyon, Monsang, Kom etc. in the flyer of the recently concluded August 31,

The Naga student body said it was nothing but trying to baselessly portray "their geography and demography" to suit their wildest demands of Kuki land within Naga areas which clearly prove their lies and false territorial claims. The ANSAM cautioned that such "acts of blasphemy" should be stopped forthwith or else they will only bring chaos and enmity amongst the communities.

"Instead of all these, with deep concern, we advise the Kuki-Chin-Mizo brethren to acknowledge and respect the traditional land ownership of the Nagas as in the olden days, so that we can continue to share and remain as a good neighbour for the rest of the centuries," the ANSAM added. Whereas, the ANSAM also said the continued effort of raising "their demand on false territorial foundation" and attempts to be fool the various concerned authorities with concocted history is a direct aggression to the Nagas and a burgeoning threat to Northeast India, "a region of indigenous peoples"

Once again, the ANSAM cautioned all concerned that any community or individual may have their own aspiration and demand democratically within their own share, but the same action and inaction should not infringe the rights, interest and position of others by way of distortion and fabrication. Further, any untoward consequences or collateral eventualities that arise in this regard shall solely held responsible by those who engineered the crisis, the Naga student body warned.

The ANSAM then urged the Government of India to show their sincerity in handling the present crisis in the state of Manipur and must look at the issues and evolving demands and claims in the right perspective based on historical truth. It also said the history of land and people in the state of Manipur is loud and clear on record and any authority at the helm should not be confused in this regard. ## 'Have suffered patiently': TMC MP Jawhar Sircar

'They want no politics; they just want justice and punishment'

KOLKATA, Sept 8: TMC MP Jawhar Sircar on Sunday wrote to West Bengal CM Mamata Banerjee, the chief of his party, and said he has decided to quit Rajya Sabha and leave politics altogether, describing the steps taken by the state government in handling the rape and murder of the doctor at RG Kar hospital "too little and quite

In the letter, Sircar said he became increasingly "disillusioned" with the state government as it seemed "quite unconcerned" about corruption and "strong-arm tactics" of a section of leaders.

Terming the protests over the doctor's death spontaneous, the retired IAS officer said he had not seen "such angst and total no-confidence" against a government, even when it was saying things that were correct or factual.

"The primary purpose of joining as an MP, without any direct involvement in party politics, was that it offered an excellent forum to carry on the struggle against the autocratic and communal politics of the BJP and its Prime Minister. To that extent, I have some satisfaction and my several interventions in parliament...," he said in the letter.

Sircar said that in 2022, a year after he joined the TMC, he was "quite shocked" to see the "open evidence of corruption" that former education minister Partha Chatterjee had indulged in.

I know that the present Central regime thrives on the multi-billionaires that it has enriched, and not a day goes when I do not accuse it of dirty crony-capitalism. I just cannot accept some things, like corrupt officers (or doctors) getting prime and top postings. No," he added.

"In all my years, I have not seen such angst and total no-confidence against the government, even when it says something correct or factual," he said.

Sircar said he had "suffered patiently" for a month since the incident at RG Kar hospital, hoping for direct intervention with the agitating junior doctors, "in the old style of Mamata Banerjee".

"It has not happened and whatever punitive steps that government is taking now are too little and quite late. I think normalcy may have been restored in this state much earlier, if the caucus of the corrupt doctors was smashed and those guilty of taking improper administrative actions punished immediately after the scandalous incident happened," he said.

Sircar said the agitation was non-political and spontaneous and it was not correct to take a "confrontational stand, by labelling it political". "They want no politics: they want justice and punishment. Let us analyse frankly and realise that the movement is as much for Abhaya (name given to the victim) as it is against the state government and the party. This calls for course correction immediately or else communal forces will capture this state," he said.

Sircar claimed he wrote the let-

ter as he did not get the opportunity to speak privately with Baneriee for months.

"I express my gratitude again for the opportunity you gave me to raise Bengal's issues in parliament for 3 years, but I do not wish to continue as MP at all. My commitment to fight corruption, communalism and authoritarianism in the Centre and the States is simply non-negotiable," he said.

He said he would soon visit Delhi, and offer his resignation to the Rajya Sabha chairperson, disassociating himself from politics.

TMC leader Kunal Ghosh said the party respects Sircar's decision, and he was hopeful that the leadership would address the issues that were raised, and take strong, clear, and positive actions. "We are also mindful of the

other issues Sircar has recently highlighted and understand that as a person of integrity and deep emotion, he is entitled to respond as he sees fit," said Ghosh.

The BJP said it would be unwise for it to comment before Sircar submits his resignation to the Rajya Sabha chairperson.

This is not the first time, earlier also he had expressed his desire to resign from the party and give up his membership of Parliament. Later he backtracked. Let us see what happens now. cember 13, 2023 Parliament security breach accused wanted to discredit India's democracy, gain instant global fame, usurp power and achieve "richness and glory" by targeting the "very symbol of democracy", according to the chargesheet filed in the court by Delhi Police.

The accused first met on social media and planned their move for nearly two years before executing it last year on the anniversary of the 2001 Parliament attack. According to the chargesheet, a source said, their first in-person meeting was held in February, 2022 at Mysuru. Citing from the chargesheet, sources told PTI, that in total they held five meetings in Mysuru, Gurugram and Delhi to decided finalise their plan and arrive at a modus operandi.

The chargesheet, spread over 1,000 pages, was filed before the Patiala House Court in June and the court took its cognisance last month. A supplementary was filed in July. The chargesheet mentioned that the group of young people, led by Manoranian D. a resident of Karnataka, met on social media.

Manoranian is among the six accused arrested by the Delhi Police Special Cell, sources said.

Manoranjan, according to the chargesheet, is suspected to be among the main conspirators of the parliament breach, who allegedly "instigated and motivated" the young people by promising them "richness, glory and wealth" and by targeting the "very symbol of

The source said the accused wanted to send out a wider message that the "Indian Democracy is ineffective and needs to be retook place on the anniversary of the 2001 Parliament terror attack. The accused launched coordinated gas attack both inside and outside the parliament house during the

Zero Hour on December 13, 2023. Two persons -- Sagar Sharma and Manoranjan D -- jumped into the Lok Sabha chamber from the public gallery and opened canisters that released yellow gas in the House. They also shouted slogans before parliamentarians overpowered them.

Outside the Parliament premises around the same time, two other accused -- Amol Shinde and Neelam Azad -- also sprayed coloured gases from canisters while shouting "tanashahi nahi chalegi (dictatorship won't be allowed)"

Manoranjan, Sagar Sharma, Amol Shinde and Neelam Azad were arrested on the same day as they were caught soon after their acts. Lalit Jha and Mahesh Kumawat were arrested on December 15 and 16, respectively. All the accused are lodged in the Tihar jail.

They have been booked under sections 16 and 18 of the Unlawful Activities Prevention Act (UAPA) and other sections of the Indian Penal Code by the Delhi Police's anti-terror unit, Special Cell.

Citing the charegsheet, a source said that Manoranian dropped out of an engineering course and travelled to Combodia in 2014 where he stayed for eight months.

The source said that after coming back to India, he travelled to Ladakh on a motorcycle in 2015, which "mirrors" the famous "Motorcycle Diaries" penned by Che Guvevara, a Cuban revolution communist icon.

During his trip to Ladakh, a Chinese student, who was then studyat Hyderabad, also accompanied him as a pillion rider to Delĥi, via Madhya Pradesh and Rajasthan.

Citing the chargesheet, the source further said the first meeting of the accused was held in February, 2022 in Mysuru at a flat of Manoranjan's friend which was attended by 10 people including Manoranjan D, Sagar Sharma, Amol Shinde, Lalit Jha and Mahesh Kumawat. 

The Jammu and Kashmir Pradesh Congress Committee chief also asserted that the Ghulam Nabi Azad-led Democratic Progressive Azad Party (DPAP) is a "closed case" and "doesn't have a future"."I have been on record to say that as far as DPAP is concerned, it is a closed case now. Whatever they had been doing was to cause fragmentation which they failed in. So I don't think they have any future anymore," he said.

Asked that with NC being the senior partner in the alliance, was it a foregone conclusion that the chief minister will be from that



derstanding as far as going into elections is concerned. We have a seat arrangement which we call as pre-poll alliance but the result would speak for itself that what would follow. We can't forecast about things which have to follow after the elections." On whether he was in the chief ministership, Karra said, "You can't say it now."

The NC and the Congress have agreed on a seat-sharing arrangement for the 90 assembly seats, with the National Conference set to contest 51 of them and the Congress 32. They are having a friendly fight on a few seats.

On the Centre significantly strengthening the authority of the lieutenant governor in Jammu and Kashmir, Karra claimed that the BJP realised that it would not be

forming the government and some other combination would be doing so and therefore, before handing over the power to the next government, they thought it is better to curtail powers.

"This is a politically motivated attempt," the J-K Congress chief told PTI over phone.

He asserted that while restoration of statehood is the paramount concern, as far as the curtailment of powers of the government is concerned, "we shall have to get it reviewed and the assembly will also decide about it". On the main plank of the polls, Karra said today's elections are not (just) about forming the government or adjusting our leaders in the government, but it has different con-

this time," he asserted. Talking about the security situation of Jammu and Kashmir, Karra lashed out at the BJP, alleging that it is "simply parroting" that the situation is normal on the ground but everyone has seen that only the goal posts have changed from Kashmir to Jammu division.

"It is an utter failure of the government of India and the local administration. They have always been glorifying their double engine governments and it (the security situation) is a sample case of the failure of those double engine governments," the Congress leader said. "For the last few months everybody is seeing that how much damage is being done in the Jammu division while all along it had been a peaceful area but for their utter failure and in their jingoism, they have been using it for their electoral political gains," he said. "So, I think it is their moral responsibility to ac-

cept their failures," Karra added. He also slammed the BJP promises made in its manifesto and said they have been "selling" the situation of Kashmir all over the country and till a few months back they had succeeded in that but now the situ-

"This jugglery of words and jingoism of years has no takers anymore. Whatever they have been promising and whatever they have been selling, I think the shelf life of that is over now," Karra said.

On whether the People's Democratic Party (PDP) could hamper the chances of the Congress-NC alliance, Karra said their tie-up has been a continuation of the previous alliance for parliamentary polls.

"I think we had quite a good result in parliamentary polls except for a setback of Omar Abdullah losing and they (PDP) had a bug setback of Mehbooba Mufti losing. I don't think there is going to be any change of that perception which was created in the previous election. I think it(our result) would be better than the previous result," he said. Pressed further about the PDP possibly playing spoiler, Karra said, 'When there is a multi-cornered contest things become difficult but I won't accept this that they (PDP) will totally hamper it."

Karra is contesting the polls from Central Shalteng that will go to polls on September 25. The Jammu and Kashmir Assembly elections are scheduled to be held in three phases with voting for the first phase to be held on September 18 followed by the second phase on September 25 and the third phase on October 1. The results of the polls would be announced on OctoMONDAY, SEPTEMBER 9, 2024

### Community radio becomes new tool Lucknow building collapse: Toll rises to 8 in fight against 'sarpanch pati' practice

hance its outreach among the rural population, the Panchayati Raj Ministry is using community radio to spread awareness about a range of issues, including combating the "sarpanch pati" practice and promoting digital initiatives.

The "sarpanch pati"? system is a practice in which the husband of an elected woman sarpanch wields the actual power. According to officials, the pilot project for using community radio has been started in three states -- Bihar, Karnataka and Maharashtra -- and have received a good response.

"Jan Jan Tak Jankari", a series of community radio programmes launched by the Ministry of Panchayati Raj, aims at involving the local populace in grassroots governance by providing them with updates on various activities, interventions, and initiatives spearheaded by the government, an of-

Five community radio stations have been engaged in different districts of the three states, the min-



istry official said.

In Bihar, the pilot project is being run through five community radio stations -- Radio Snehi, Siwan, Radio Active in Bhagalpur, Radio Rimjhim in Gopalganj, Radio Mayur in Chapra, and Radio Risarch in Munger.

Similarly, Radio Sarang, Radio Manipal, Radio Shivamogga, Nammadhwani Radio, and Antarvani Radio have been engaged in istry of Panchayati Raj," the official told PTI.

"Even in the digital era, radio continues to be a powerful mass medium, reaching millions of listeners. Rural communities, in particular, still rely heavily on radio for information and entertainment," the official said.

The official added this initiative is part of the ministry's broader effort to involve local communities in advancing towards self-sustaining models of Smart Panchayats.

The issues being raised through the community radios include eliminating unwarranted practices like "Sarpanch Pati", "Pradhan Pati", and "Mukhiya Pati", a practice where male relatives of Elected Women Representatives (EWRs) such as their husband, exert undue influence on the woman representative, the official said. Augmenting Own Source of Revenue (OSR) for Panchayats, and popularising digital interventions such as the Meri Panchayat app, eGramSwaraj ?Bhashini, PanSabha will also be covered through the programme.

Localisation of Sustainable Development Goals (LSDGs) will also be covered, which includes having poverty-free villages with enhanced livelihood, healthy, child and women friendly, water sufficient, clean and green village, with self-sufficient infrastructure, socially just and socially secured environment, and good governance.

The official added that the ministry has requested the state departments of Panchayati Raj to support the community radio initiative by providing inputs and finalising content in local languages to maximize outreach. The effort is being coordinated by the Community Radio Association (CRA).

"The response to this initiative has been overwhelmingly positive, as reported by the CRA. They have observed a phenomenal engagement rate among the communities, indicating a strong resonance with the content being aired," the offi-

CM Adityanath to visit injured at hospital

LUCKNOW, Sept 8: The death toll in the building collapse here has climbed to eight with rescuers pulling out three more bodies from the debris, officials said on Sunday.Chief Minister Adityanath will visit Lok Bandhu Hospital here to meet those injured in the incident, after returning from Ambedkar Nagar, Director, Infor-

mation, Shishir said. Joint Commissioner of Police Amit Verma said there is minimum possibility of someone still being trapped inside.

A three-storey building housing godowns and a motor workshop collapsed in the Transport Nagar area here on Saturday, leaving 28 people injured. Five bodies were recovered from the spot.

As the rescue operation continued overnight, teams of National Disaster Response team (NDRF) and State Disaster Response Force (SDRF) recovered the bodies of three people, who were identified as Raj Kishore (27), Rudra Yadav (24) and Jagrup Singh (35), Relief Commissioner G S Naveen said.

The eighth body was recovered around 3 am on Sunday, officials said. Joint CP Verma said, "We are now focusing on ensuring that no one else is trapped under the rub-

"NDRF and SDRF teams are removing the debris that will take time. The possibility of someone still inside the debris is less. Had there been someone, their family members would have contacted us by now," he said.

Police said the building was constructed around four years ago and some construction work was underway at the time of the incident. Most of the victims were working on the ground floor when the incident occurred at 4:45 pm on Saturday. The injured have been admitted to various hospitals, including Lok Bandhu Hospital, in the district.

According to the officials, the building had a motor workshop and warehouse on the ground floor, a medical godown on the first floor and a cutlery warehouse on the second floor.

Akash Singh, who worked in the medical godown and was among the injured, said a pillar of the building had developed a crack.

"We had come down to the ground floor because it was raining. We noticed that a pillar of the building had developed a crack. Suddenly, the entire building collapsed on us," he said. (PTI)

### Train splits into two in Bihar's Buxar



PATNA, Sept 8: The coupling of Magadh Express from New Delhi to Islampur broke, splitting the train into two in Bihar's Buxar district on Sunday, an official said. No one was injured in the incident which occurred between Twiniganj and Raghunathpur railway stations in Buxar district, Chief Public Relations Officer (CPRO) of East Central Railway, Sharswati Chandra

The incident took place at around 11.08 am and rail traffic was restored by 2.25 pm, Chandra said."The restoration work, including the coupling of the Magadh Express (20802) from New Delhi to Islampur, was completed and the same train started from the site at 2.25 pm ...after that movement of other trains was also allowed on the down line", said the CPRO.

An inquiry has been ordered to probe the exact cause of the incident, he said, adding the incident disrupted rail traffic for more than three hours. The incident had occurred when the train passed Twiniganj. It uncoupled between coach no S-7, the 13th from the train engine and coach no S-6, the 14th from the engine between Twininganj- Raghunathpur in the down line. A rescue team as well as technical teams immediately reached the spot and rectified the snag, said the CPRO. (PTI)

NEW DELHI, Sept 8: The key Hamburg Sustainability Conference that will bring together experts from around the world to discuss "ideas and innovations" to accelerate efforts to achieve the SDGs will take place around the first week of October, a top German official here said.

In an interview to PTI, Uwe Gehlen, Head of Development Cooperation, German Embassy in India, also said the conference will be opened by Chancellor Olaf Scholz. The Hamburg Sustainability Conference is scheduled to be held on October 7 and 8, and India will participate in it, both from the public and private sectors.

Gehlen took part in a panel discussion 'Financing the Renewable Energy Revolution' at the International Solar Festival here on Friday and spoke about Germany's role in helping India realise its renewable energy goals by 2030.

Later interacting with PTI, he spoke about the progress made in the Green and Sustainable Development Partnership (GSDP) between the two countries and the significance of the upcoming visit of Chancellor Scholz late in October. Gehlen described the relationship between India and Germany in the clean and renewable energy sector as "marvellous".

He also shared details Hamburg Sustainability Conference, which will take place in Germany ahead of Chancellor Scholz's scheduled visit to India next month. "We got to the conclusion, specifically from the development anchor that we would like to take up efforts to qualify a little bit more beyond the existing format, the discussion about innovation in SDGs," the top German official told PTI on the sidelines of the festival. The 2030 Agenda for Sustainable Development, adopted by all United Nations Member States in 2015, provides a shared blueprint for peace and prosperity for people and the planet, now and into the future.

At its heart are the 17 Sustainable Development Goals (SDGs), which are an urgent call for action by all countries - developed and developing - in a global partnership. "They recognise that ending poverty and other deprivations must go hand-in-hand with strategies that improve health and education, reduce inequality and spur economic growth all while tackling climate change and working to preserve our oceans and forests,' the SDGs website reads. Gehlen said the SDGs are meant to be fulfilled in 2030 and it's not that the stakeholders are struggling, but it would be "very challenging" road ahead. "So, more activities needed, more networks needed, more good ideas needed, more innovations needed and the idea from the leadership in my ministry together with the chancellory was setting up a format where these discussions could happen, so we developed this format," he said.

"And it will take place time, in Hamburg, and will be opened by our Chancellor Olaf Scholz, so, we are very proud about that," Gehlen added.

The German official said that an entire range of thematic sessions related to a whole lot of questions "we ask ourselves continuously" have been planned

The key conference will see gathering of "very high-ranking participants" from all over the world, but also a lot of people who are not so famous, but having good ideas, he said.

"We need a new era of sustainability, new alliances with business leaders, global policymakers, and society. Halfway from the adoption of the SDGs in 2015 on the path to 2030, the Hamburg Sustainability Conference is establishing a new global platform to speed up the implementation of the SDGs and deliver result-oriented solutions,' reads a description on its official website. Asked if India's participation will be from both public and private sectors, Gehlen said, "yes".

India-Germany relationship is based on "tremendous amount of trust, friendship and shared responsibility", bringing both countries forward as well making contribution to the world, and the upcoming visit of Chancellor Scholz is in line with it, he said.

German Chancellor Scholz and Prime Minister Narendra Modi had in May 2022 signed the German-Indian Green and Sustainable Development Partnership (GSDP), which gears cooperation between the two countries across different sectors towards the objectives of the 2030 Agenda for Sustainable Development and the Paris Agreement. Scholz is set to visit India in October to hold wide-ranging talks with Modi, with a focus on boosting bilateral trade and economic relations. He said the upcoming 'visit of our Chancellor with parts of the German Cabinet will push us forward. I am verv much looking forward to it". (PTI)

### WW2 veteran turns 100, Indian Army celebrates his centennial birthday



NEW DELHI, Sept 8: Lance Naik Charan Singh (retd), a World War II veteran who served the Army for 17 years and received the prestigious Burma Star Award has turned 100.

"Over the years, his dedication was recognised with the prestigious Burma Star Award and the Indian Independence Medal. After 17 years of valiant service, he retired from the Indian Army on May

### **12 dead in Kutch** from pneumonitis, say officials

BHUJ, Sept 8: Twelve persons, including four children below the age of 12, have died in Lakhpat taluka in Gujarat's Kutch district days after the region was battered by heavy rains, with officials on Sunday saying the cause of death primarily appears to be pneumonitis. Some local district panchayat members, however, said doctors had not been able to accurately diagnose the fever, which was also causing difficulty in breathing.

Medical services in the taluka. which is located near the border with Pakistan, have been intensified with the deployment of 22 surveillance teams, doctors and obtaining samples from residents to rule to possibility of H1N1, swine flu, Crimean-Congo fever, malaria and dengue, Kutch Collector Amit Arora said. "Primarily, the deaths appear to

have been caused by pneumonitis. It does not appear to be from contamination nor does it seem like a communicable disease. Twenty-two health department teams are working in the affected areas, including those brought on deputation from two community health centres as well as rapid response teams from Rajkot PDU medical college," he added. Kutch district panchayat member Meenaba Jadeja, in a letter to Gujarat Congress chief Shaktisinh Gohil, claimed 12 persons in the 5-50 age group have died between September 3 and 9 due to fever in Bekhada, Sanandro, Morgar and Bharavandh villages in Lakhpat taluka. # UNESCO experts debate consequences of Covid-induced shift to tech in education

'Sudden shift to ed-tech also accelerated a concerning transfer of authority'

NEW DELHI, Sept 8: The COVID-19 pandemic pushed the teaching-learning process from schools to educational technologies at a pace and scale that has no historical precedent, resulting in numerous unintended and undesirable consequences, UNESCO's education team has said in a report.

The report titled "An-Edtech tragedy", also published as a book, examines the numerous adverse and unintended consequences of the shift to ed-tech.

It documents how technologyfirst solutions left a global majority of learners behind and details the many ways education was diminished even when technology was available and worked as intended.

The missed schooling is expected to reverberate for years, both personally for individuals and at the level of countries, regions and local communities.

Experts from the United Nations Educational, Scientific and Cultural Organization's (UNESCO's) Education team told PTI that the book extracts lessons and recommendations to ensure that technology facilitates, rather than subverts, efforts to ensure the universal provision of inclusive, equitable and human-centred public education

"For millions of students, formal learning became fully dependent on technology -- whether on Inter-



net-connected digital devices, televisions or radios. The massive uptake of educational technologies that could be used outside schools was anchored in a hard truth about disease transmission: strictly speaking, people are biohazards and technology used in isolation is

not," the report said. 'So while schools were forced to close because they put large numbers of children and adults in close physical proximity, learners were asked to use technology because it accommodated social disand stay-at-home directives," it said.

The report stated that as technology-mediated education replaced face-to-face learning in schools as the locus of formal education, technology use was widely mandated by governments in line with commitments to make education compulsory. Even families that had no previous experience with edtech or saw it as purely peripheral to school-based education commonly operated under the assumption that they needed to secure and use technology for educational purposes, the report observed.

"With a speed that few had anticipated, technology, rather than schools, became the primary interface for education," it added.

The experts noted that during the pandemic, students' academic progress was dramatically less than what would have been expected without school closures.

'This 'lost' education – along with the wider socio-emotional tolls of the pandemic - carried individual, familial, social and economic consequences, especially in contexts where the average years of school completion are already

In countries where learners typically complete only a few years of formal education, the COVID-19 disruption to schooling and failure or insufficiencies of ed-tech to provide alternatives translated into some students missing a sixth or more of their lifetime education, the report said.

"Although connected technology supported the continuation of education for many learners, many more were left behind. Exclusion soared and inequities widened. Achievement levels fell, even for those with access to distance learning, "Educational experiences narrowed. Physical and mental health declined. Privatization accelerated, threatening education's unique standing as a public good and human right," it said.

According to experts, automation replaced human interactions with machine-mediated experiences while technology production and disposal placed new strains on the environment.

Visions that technology could form the backbone of education and supplant school-based learning - in wide circulation at the outset of the health crisis – had promised better outcomes.

"Ed-tech proponents held that the immense challenges of school closures could be met with technology and that deeper technology integration would transform education for the better. But these high hopes and expectations unravelled when ed-tech was hurriedly deployed to maintain formal education as Covid-19 tore across countries," the report said.

"The sudden shift to ed-tech also accelerated a concerning transfer of authority away from teachers, schools and communities and towards private, for-profit interests," it said.

Additionally, the censorship, data extraction, advertising, topdown control, intimidation and surveillance that so often characterize current models of digital transformation have made education less free and, arguably, less capable of facilitating critiques of and positive changes to the status quo, the report added. ### 21 cities under NCAP cut PM10 pollution by over 40 pc since 2017-18, shows CPCB data NEW DELHI, Sept 8: Ninety-Chittur, Kala Amb, Mandi Gobfive of the 131 cities covered under

the National Clean Air Programme have shown an improvement in air quality, with 21 reducing PM10 pollution by more than 40 per cent compared to 2017-18 levels, CPCB data shows.

The Central Pollution Control

Board (CPCB) also said that only 18 of the 131 National Clean Air Programme (NCAP) cities adhered to the National Ambient Air Quality Standards (NAAQS) for PM10, set at 60 micrograms per cubic metre. The 21 cities and urban agglomerations that achieved more than 40 per cent reduction in PM10 pollution are Varanasi, Dhanbad, Byrnihat, Bareilly, Firozabad, Dehradun, Tuticorin, Nalagarh, Moradabad, Khurja, Trichy, Kohima, Lucknow, Kanpur, Kadapa, Sivasagar, Sunder Nagar, Agra, Greater Mumbai, Rishikesh and Parwanoo.

Fourteen cities. -- Ahmedabad. Ghaziabad, Rajkot, Jalandhar, Raebareli, Amritsar, Kolkata, Jammu, Silchar, Vijayawada, Naya Nangal, Dimapur, Baddi and Jodhpur -- reduced PM10 pollution by 30-40 per cent, compared to 2017-18 levels. Khanna, Durgapur, Kurnool, Dera Baba Nanak, Vadodara, Allahabad, Asansol, Hyderabad, Gorakhpur, Ranchi, Bengaluru, Akola, Ananthapur, Durg Bhilainagar. Surat and Noida recorded a 20-30 per cent reduction in PM10 levels during the same period, the data showed

A 10-20 per cent reduction in PM10 pollution was recorded in 21 cities -- Delhi, Howrah, Thane, Latur, Nellore, Gajraula, Alwar,

indgarh, Amravati, Patiala, Jaipur, Ongole, Chandrapur, Nashik, Jhansi, Sangli, Kota, Devanagere and Rajahmundry.

India launched the NCAP in 2019 with a target to reduce particulate pollution by 20-30 per cent by 2024, using 2017 as the base year. The target was later revised to a 40 per cent reduction by 2026, using 2019-20 as the base year.

In practice, only PM10 concentration is being considered for performance assessment. Surat was on Saturday ranked as the top major city in India for air quality improvements, followed by Jabalpur and Agra.

The Union environment ministry presented the National Clean Air City Awards during the Swachh Vayu Survekshan - 2024, held at a national workshop celebrating the International Day of

Clean Air for Blue Skies in Jaipur. While Surat, Jabalpur and Agra secured the top three positions among cities with populations of more than 10 lakh, Firozabad (Uttar Pradesh), Amravati (Maharashtra) and Jhansi (Uttar Pradesh) were recognised as the best among cities with populations between three and 10 lakh. Raebareli (Uttar Pradesh), Nalgonda (Telangana) and Nalagarh (Himachal Pradesh) topped the list among cities with

populations under three lakh. Swachh Vavu Survekshan is an initiative by the environment ministry to rank cities based on the implementation of activities approved under the city action plan and air quality in cities covered under NCAP. (PTI)

Co-directed by his manager and husband David Furnish and filmmaker R J Cutler, "Never Too Late" was screened at the gala on Friday.

The documentary takes an intense look at the first five years of John's career in the 1970s and juxta-

poses them with his recent "Farewell Yellow Brick Road" tour. In his first public appearance since announcing his diagnosis on social media, the 77-year-old told Vari-

ety: "I couldn't really see it because of my eye, but I sensed it. I'd seen it before. I don't know. Seeing it with an audience is far more emotional than just sitting with a bunch of people. I got more out of it last night than I did when I saw it the first time, and it hit harder.'

## Directors' body suspends Bengali filmmaker Arindam Sil over sexual harassment charge

KOLKATA, Sept 8:Bengali filmmaker Arindam Sil was suspended by the Directors' Association of Eastern India (DAEI) following a complaint of sexual misconduct by an actress. Sil was the first big name in the Bengali film industry, also called Tollywood, against whom action was taken after allegations of sexual harassment shook the entertainment industries of the southern states.

The suspension came into force with immediate effect, said a letter sent by DAEI late on Saturday.

"Due to certain allegations made against you, and prima facie evidence we have with us, which are of deep concern and is maligning to the entire organisation, DAEI has decided to suspend you from membership for indefinite period or till the allegations against you are cleared," said the letter sent by

DAEI president Subrata Sen and secretary Sudeshna Rov.

Sil, who is also a wellknown actor, told reporters that what was being construed as misbehaviour was unintentional.

He said the incident being referred to happened recently when he was explaining a scene to the actress during the shooting of a film. "No one objected to my actions or conduct at that time," he claimed.

The DAEI took up the matter after the actress filed a complaint with the West Bengal Commission for Women.

The DAEI secretary said they took a considered view of the matter after talking to all sides and prima facie found merit in the complaint.

The actress told NEWS18 Bangla that she had full faith in the commission.

"Let me ask him why one has to be physical to explain a shot. We are all professional actors. The rest I will state before the commission whenever needed in the future," she said. Sil is known for his detective films such as 'Har Har Byomkesh' and 'Mitin Mashi', besides the Shabor series. (PTI)

## WAS SUPPOSED TO SING **ONLY ONE SONG FOR 'UMRAO JAAN': ASHA BHOSLE**

NEW DELHI, Sept 8: Music icon Asha Bhosle, a firm believer in destiny, says she was meant to sing only one song for the 1981 classic "Umrao Jaan" but ended up lending her voice to the entire soundtrack.

Directed by Muzaffar Ali and starring Rekha in the title role, the film earned Bhosle her first National Film Award for best female playback singer.

The singer, who turned 91 on Sunday, sang chartbusters such as "Dil Cheez Kya Hai", "Inn Aankhon Ki Masti Ke", "Ye Kya Jagah Hai Doston", "Jab Bhi Milti Hai", and "Justuju Jiski Thi". Khayyam composed the music of "Umrao Jaan" and Shahryar penned the

Bhosle said she "became Umrao Jaan" after reading the 1905 Urdu novel "Umrao Jaan Ada" on which the film

"I had one song in the film. I said ok and the producer gave me the 'Umrao Jaan' book. All the songs were set in one tone. I read it and became Umrao Jaan.

'I was supposed to sing just one song and I ended up singing for all the songs in the film. This is destiny, isn't? All songs were hits," the illustrious singer told Doordarshan in an interview.

At 91, what keeps her going? "I don't do anything to look young like it happens these days. Someone who is happy from within and is positive, they have a good outlook towards life. I stay positive, embrace learning,

and only pursue what I love, guided by my unwavering faith in God."

Bhosle said she and her elder sister, the late melody queen Lata Mangeshkar had "somewhat similar" voices but she always wanted to have her own identity.

"Had I sung like her, it would appear as if I was imitating her. You shouldn't imitate, you should make your own name. So, I listened to English songs, Punjabi songs, songs from different parts of the country and world.



"If you ask Didi to do staccato, she would do that. But she wouldn't change her voice, she didn't like doing it. But I did it for 'Eena Meena Deeka' ... I was also thorough in Classical singing. Whatever people are singing today, they are modelling it on whatever they have heard me sing," she added.

One must keep their personal and professional life separate, said Bhosle, known for a diverse variety of songs such as "Piya Tu Ab To Aaja", "Tora Man Darpan Kehlaye", "Mera Kuch Samaan", and "Le Gayi Le Gayi".

"The sorrow in your life shouldn't reflect in your songs. As an artist, you are supposed to change according to the emotion. That's why in playback singing, Didi and I maintained our position for so many years. Didi started and then I came in.'

In the interview, the industry veteran also spoke about her frequent collaborator music composer-husband RD Burman, fondly known as Pancham.

"There are few music directors who would understand what's going on in the mind of an artist and then make them sing. Pancham was one of them. Once I asked him to give me a simple song.

"He said, 'Anyone can sing simple songs, but no one is like you. If you won't sing these songs, I'll stop composing them'. But I also liked taking up challenges in life and every song by Pancham was a challenge," she added.

## Thanks to plenty of firsts and proven performers, India emerges as Paralympic power in Paris

PARIS, Sept 8: Differently- were record efforts and perabled but exceptionally resolute, India's para-athletes would look back at their Paralympics campaign with pride as most of the established names lived up to expectations and many talented greenhorns made the big stage their own in a record-smashing medal haul of 29. Seven of these 29 medals are gold, which is another first for the country that started to make its presence felt only in the 2016 edition, where it won four medals. The upswing in performance after that has been meteoric with Tokyo yielding 19, a number that was surpassed this time.

Not to forget, a lot of medal-

sonal bests, demonstrating that the athletes have made significant progress as far as their selfbelief is concerned.

The 29 medals in five sports, including a whopping 17 at the track and field events, have ensured that the country will end in the top 20 of the mega-event that was once again dominated by China with over 200 medals.

India is still far away from becoming a force at the Olympic level but the nation has certainly emerged as a force to be reckoned with in the competition for the differentlyabled. The contingent of 84 ensured plenty of firsts for India in Paralympic history including

bronze in the women's 100m T35 and 200m T35 class.

T35 classification is meant for athletes who have coordination impairments such as hypertonia ataxia and athetosis. Preethi was born with weak legs and it became progressively worse as she grew up.

Another first ever medal came via Kapil Parmar in Judo. He made India proud by securing a bronze in the men's 60kg J1 class.

# India face Syria, aim for successive Intercontinental Cup titles

HYDERABAD, Sept 8: Hosts India and Syria will go head to head in the winnertakes-it-all third and final game of the Intercontinental

Cup trophy here on Monday. India, who began the competition with a goalless draw against Mauritius on Tuesday, are eyeing their second consecutive Intercontinental Cup triumph, and third overall.

Syria beat Mauritius 2-0 on Friday, which means they hold a slight advantage heading into the final game as the Eagles of Qasioun require only a draw to claim the trophy.

Syria have a long history of playing tournaments in India, but the title has always evaded them. The West Asians lost back-to-back Nehru Cup finals to India in 2007 and 2009 before finishing fourth in 2012.

In their last trip to India in the 2019 Intercontinental Cup, Syria ended in third place. But for the Blue Tigers to deny them a first silverware on Indian soil, they will need to end a winless streak stretching back to November last year.

"It will be a difficult game for both sides. It's a friendly game, but the team who wins the game wins the trophy. We expect to play a good game



and win the tournament," said India head coach Manolo Márquez, who celebrated his 56th birthday on Saturday.

Sept 8: The Indian men's hockey team dished out a dominant performance to launch its title defence with a commanding 3-0 win over hosts China in the Asian Champions Trophy here

As the track and field competitions concluded at the Paris Games, Navdeep's golden throw in the final ensured the hallowed Stade de France echoed with the Indian national anthem. His personal best effort of

47.32m initially placed him in

He continued to train tirelessly at the Sports Authority of India (SAI) centres in Gandhinagar and Bangalore, honing his skills and refining his technique. (PTI)

### Randhir Singh becomes first Indian to be elected as OCA president

NEW DELHI, Sept 8: Veteran sports administrator Randhir Singh on Sunday became the first Indian to be elected as the president of the Olympic Council of Asia (OCA) during the 44th General Assembly of the continental body here.

A five-time Olympic shooter, Randhir was the lone eligible candidate for the OCA president's post. His tenure will run from 2024 till 2028, and his election was

The 77-year-old Randhir has been the OCA acting president since 2021, filling in for Kuwait's Sheikh Ahmad Al-Fahad Al-Sabah, who was handed a 15-year ban from sports administration in May this year over ethics breaches.

Randhir, who held different administrative posts in Indian and Asian sports bodies, was officially named OCA president in the presence of Sports Minister Mansukh Mandaviya and top sports leaders from all 45 countries of Asia.

He hails from Patiala in Punjab and belongs to a family of sportspersons.

His uncle, Maharaja Yadavindra

India thus concluded the Paris Paralympics with a record haul of seven gold, nine silver, and 13 bronze medals, set to finish 18th in the overall medals tally.

The final addition to India's unmatched medal count came from the athletics arena late on Saturday, where Navdeep Singh's silver medal in the men's javelin F41 category was upgraded to gold, capping a spectacular finish to the Games. At the last edition in Tokyo, India were ranked 24th with five gold, eight silver and six bronze medals.

On the concluding day of the Paralympics at the Vaires-sur-Marne Stadium. Pooja was the last Indian in fray and she finished her semifinal 1 with a timing of 1:17.03, which was 7.03 seconds behind the third-placed Eleonora de Paolis of

Indian cricket is extremely powerful because talent comes from everywhere: Dravid

Rahul Dravid on Sunday said that Indian cricket has evolved into an "extremely powerful" force, thanks to the growing talent pool that now extends to even the remotest corners of the country Dravid, who masterminded India's tri-

umph in the T20 World Cup, said a strong club cricket culture has a lot to do with bucking the old trend of city cricketers dominating the passage to the national team.

"If you look at Indian cricket today, Indian cricket is extremely strong, it's extremely powerful. One of the big reasons for that is that talent comes from everywhere, from all over the country," said Dravid during the 50th year celebration of Mount Joy Cricket

"I think if you go back to the time of say GR Vishwanath or even when I was starting out my career, most of the talent came from the big cities or from few other states.

"Even if they were talented boys in smaller places, they had to come to the big cities to play cricket. But today I think you see in Indian cricket that boys are coming from everywhere," he added.

Dravid said it's getting reflected in the standards of domestic cricket in India.

"You just look at the standard of the Ranji Trophy. In the old days when you played in



the South Zone, other than playing Hyderabad or Tamil Nadu, I think it is fair to say, without being disrespectful, that a lot of other teams you could take it not for granted

but you could certainly take it a little bit more lightly. "I don't think there is any team in the

South Zone today that you can walk in and

say that you will comfortably beat," he

Hailing the club cricket structure in the country, particularly in Karnataka, Dravid said the system has allowed the sport to remain accessible to all.

"We need clubs to be strong. We need cricket not to be concentrated in the hands of a few people. We need cricket to be egalitarian, we need it to be all over the place. "You cannot have talent or you cannot

have facilities concentrated only in one or two places. To get the best out of talent, we need to ensure that young boys and girls are getting access to good infrastructure in every part," he noted.

The 51-year-old former Indian captain then briefly revisited his club career when he was young to underscore the need for that system to thrive.

"After the practice, HAL (Hindustan Aeronautics Limited) would give us two eggs and one small glass of milk. I would always stay back for that glass of milk and those eggs. Not because I wanted the milk and eggs.

"But because I wanted to sit and listen to the likes of BK Kumar or Nandan talking about cricket. And it used to be great fun to listen to them and learn so much from them," said Dravid. (PTI)
