

Violation of order on demolition drive: SC seeks replies from Assam govt, others

Supreme Court on Monday sought the responses of the Assam government and others on a plea seeking initiation of contempt proceedings for the alleged violation of the apex court's order that had said there shall be no demolition of properties across the country without its per-

A bench of Justices B R Gavai and K V Viswanathan also asked the parties to maintain status quo in

The top court had, on September 17, said there will be no demolition of properties, including of those accused of crimes, till October 1, without its permission.

The plea seeking initiation of contempt proceedings against the authorities concerned over proposed demolitions in Assam's Sonapur came up for hearing before the

court on Monday. Senior advocate Huzefa Ahmadi, appearing in the court on behalf of the petitioners, said there has been an "egregious violation" and breach of the apex court's order that had cat-

Assam BJP ahead of all other state units in achieving membership target: Himanta

GUWAHATI, Sept 30: The Assam BJP is ahead of the party's other state units in achieving membership targets with 53 lakh people already enrolled, chief minister Himanta Biswa Sarma said on Monday.

Speaking to reporters after attending a meeting to review the membership exercise at the state BJP headquarters here, he said the entire drive was being conducted online, with physical form fill-up kept for a

"So far, 53 lakh members have already registered. With regards to fulfilling the target for membership set for different states, we have achieved 85 per cent of our target already and are at the top position," he

The membership target is set at 75 per cent of the total votes polled by the BJP in a particular state in this year's Lok Sabha elections, he added.

The party, which had bagged nine out of 14 seats in

Assam, had polled over 63.25 lakh votes. Sarma said the Assam unit had set a target of enrolling 40,000 members in each of the 126 assembly constituencies, and it has already been achieved in 71

"By October 9, we are hopeful that we will be able to cross 40,000 members in over 90 constituencies,



He said Dibrugarh district has made the highest en rolment till date, while his Jalukbari constituency is the only one to cross the 1 lakh membership mark.

The enrolment figures have been low in Kokrajhar and Dhubri Lok Sabha constituencies, Sarma said. It has also been slow in parts of the Diphu Lok Sabha seat, he said, attributing it to low mobile network coverage

"To touch 53 lakh members already from 18 lakh last year is a big achievement. It has been possible due to our leaders and the team," the chief minister said. He said the physical membership drive will be initiated after the end of the online exercise on October 9 in parts where mobile network coverage is low. (PTI)

Minister Himanta Biswa Sarma on Monday said that the state is progressing towards a new era of transparency as it has left behind an era of corruption.

Sarma was speaking during a programme at the Veterinary college field in Guwahati where he handed over the first instalment of ₹ 75,000 to 25,238 entrepreneurs under the Mukhyamantrir Atmanirbhar Assam Abhiyan.

"Assam is leaving behind an era of corruption and negativity, and is now on the path to peace, stability, and development," an official statement quoted Sarma as saying.

Sarma also reiterated the government's commitment to fulfilling its election promises, adding, "The present state government had

pledged to provide 1 lakh government jobs, a promise that has been successfully fulfilled with the re-

cruitment of 1 lakh candidates".

"Furthermore, the state government has gone beyond this pledge by providing an additional 40,000 government jobs. The successful completion of several recruitment drives, including the Assam Direct Recruitment Exam, teacher recruitment, and ongoing police recruitment, all of which have boosted the morale of the state's youth," he added.

Emphasising transparency, Sarma noted that each recruitment process has been conducted without any malpractices, thereby instilling trust in the system.

"The state government has eradicated corruption in recruitment,

Over 20k polling staff

JAMMU, Sept 30: Over 20,000 polling staff have been mobilised Monday across seven districts of Jammu and Kashmir on the eve of third and final phase of assembly elections which will decide the electoral fate of 415 candidates including two former deputy chief ministers Tara Chand and Muzaffar Beig, officials said.

The highlight of the voting will be participation of west Pakistani refugees, Valmiki Samaj and Gorkha community who got the voting rights in assembly, urban local bodies and panchayat elections only after the abrogation of Article 370. They have earlier voted in panchayat and urban local bodies polls in 2018.

Over 39.18 lakh voters are eligible to exercise their franchise at 5.060 polling stations in this crucial phase. covering 40 assembly segments in Jammu, Udhampur, Samba and Kathua in the Jammu region and Baramulla, Bandipora and Kupwara in north Kashmir, on October 1.

Additional Director General of Police (ADGP), Jammu zone, Anand Jain, said adequate security arrangements have been put in place in the poll-bound areas to ensure "terrorfree and peaceful" polling.

Amid tight security arrangements, thousands of election staff along with poll material left their respective district headquarters this morning to take positions at their designated polling stations by this

The voter turnout was robust in the earlier phases, with 61.38 per citizen-centric administration. (PTI) cent participation recorded in the

first phase on September 18 and 57.31 per cent in the second phase on September 26. This is the first Assembly election in Jammu and Kashmir since the abrogation of Article 370 of the Constitution in August 2019, with the results set to be announced on October 8.

According to J&K chief electoral officer Pandurang K Pole, more than 39.18 lakh voters are eligible to exercise their electoral franchise in the final phase across the 40 assembly constituencies – 24 in Jammu region and 16 in Kashmir valley.

In Jammu division, Jammu district accounts for the highest number of 11 segments (Bishnah-SC, Suchetgarh-SC, R S Pura, Jammu South, Bahu, Jammu East, Nagrota, Jammu West, Jammu North, Akhnoor-SC and Chhamb), followed by six seats in Kathua district (Bani, Billawar, Basohli, Jasrota, Kathua-SC and Hiranagar), four in Udhampur district (Udhampur West, Udhampur East, Chenni and Ramnagar-SC) and three in Samba (Ramgarh-SC, Samba and

Similarly in Kashmir division, 16 assembly constituencies including Karnah, Tregham, Kupwara, Lolab, Handwara and Langate fall in Kupwara district, Sopore, Rafiabad, Uri, Baramulla, Gulmarg, Wagoora-Kreeri and Pattan in Baramulla district and Sonawari, Bandipora, Gurez (ST) in Bandipora district.

Rescue operations continue as over 200 people killed in floods, landslides in Nepal KATHMANDU, Sept 30: Search and rescue oper-

SHILLONG, Sept 30: Meghalaya Chief ations continued in Nepal for the third consecutive Minister Conrad K Sangma on Monday day on Monday after monsoon-induced floods and landslides killed more than 200 people in one of the worst rain-related disasters in the Himalayan nation in recent years.

Incessant rainfall over the weekend triggered floods and landslides, wreaking havoc in Kathmandu and most of the districts of Nepal.

At least 205 people have been killed with 24 others still missing in the continuous rainfall, floods, landslides and inundation. Home Ministry officials said, adding that Kathmandu alone recorded 56 deaths related to the natural disaster.

According to the officials, 130 people have been injured nationwide in the disaster.

The Home Ministry said all security agencies have been deployed for relief efforts following the floods and landslides, and the Nepal Army, Nepal Police and Armed Police Force personnel have rescued around 4,500 disaster-affected individuals so far. While those injured are receiving free treatment, food and other emergency relief materials have been provided to others affected by the floods.

Hundreds of people are facing a shortage of food, safe drinking water and sanitation in Kathmandu following the natural disaster, according to eyewit-

Market prices have also soared as vegetables coming from India and other districts of the country have been temporarily halted due to obstruction in major highways due to landslides.

At least 20 hydropower plants with a combined capacity of 1,100 MW suffered damages due to floods and landslides in the past three days, leading



to the disruption of power supply in Kathmandu and other major cities, officials said.

Meanwhile, Prime Minister K P Sharma Oli, who returned home from his visit to the US to attend the United Nations General Assembly on Monday, said the government will not leave any stone unturned in rescue and relief distribution works and urged all sides to cooperate with the government.

Earlier, an all-party meeting convened on Sunday by Officiating Prime Minister Prakash Man Singh at the Prime Minister's Office in Singha Durbar decided to enhance rescue, relief, and re-establishment efforts during the ongoing disaster caused by heavy rains. A task force was also formed to assess the details of the damage caused within a 15-day deadline.

The Disaster Management Executive Committee said it will provide a relief amount to the families of those missing. If the missing person is not found within 10 days, their family will be provided the same amount as that given to the kin of a person killed in the rain-induced (CONTD. ON PAGE-2)

Study reveals growing trend of solo ageing among elderly in India

disputes are eliminated, official sources said Monday, NEW DELHI, Sept 30: A recent study has shed light on the increasing trend of solo ageing among India's elderly population, one of the key reasons for this shift is the increasing preference for financial

and social independence. Conducted in September to coincide with the International Day of Older Persons on October 1, the study by Agewell Foundation titled 'Study on Solo Aging with Special Focus on the Status of Older People Living Alone' surveyed 10,000 elderly individuals across rural and urban areas.

According to the study, 14.3 per cent of elderly respondents reported living alone, with a higher prevalence in urban areas (15 per cent) compared to rural regions (13.4 per



41.9 per cent—including 46.5 per cent of elderly women—had been living independently for more than

One of the key reasons for this their mental health had been negashift towards solo ageing is the increasing preference for independence, both financial and social, the study said. More than 31 per cent of elderly

respondents stated that people opt to live alone for independence, while 26.7 per cent pointed to the socioeconomic changes such as the migration of younger generations and the rise of nuclear families.

Additionally, 21.5 per cent noted that privacy and personal space were critical factors in choosing to

The study also highlighted the emotional and mental health challenges associated with solo ageing.

Nearly 41 per cent of elderly respondents living alone reported that

tively affected, while approximately 32 per cent felt it had improved. Loneliness remains a pervasive issue, with 10.4 per cent of respondents saying they always feel lonely, and 21.2 per cent admitting to feeling lonely often.

MUMBAI, Sept 30: Equity benchmark indices Sensex and Nifty tumbled nearly 1.5 per cent on Monday due to heavy selling in banking, finance and auto stocks amid rising geopolitical risks in the Middle East and weakness in Japanese markets.

Besides, profit-taking in frontline stocks like Reliance Industries after a record-breaking rally and foreign fund outflows added to the gloom, analysts said. Declining for the second straight session, the BSE Sensex tumbled 1,272.07 points or 1.49 per cent to

settle at 84,299.78. During the day, it plunged 1,314.71 points or 1.53 per cent to 84,257.14. A total of 2,223 stocks declined, 1,819 advanced

and 151 remained unchanged on the BSE. The NSE Nifty tanked 368.10 points or 1.41 per cent to 25,810.85. "Nifty-50 had its worst day in nearly two months on Monday fuelled by weak Asian markets (led by Japan), rising tensions in the Middle East and fear of funds moving to China based on recent measures taken by its government," Deepak Jasani, Head of Retail Research, HDFC Securities, said. From the 30 Sensex firms, Reliance Industries and Axis Bank declined over 3 per cent each. ICICI Bank, Nestle, Tech Mahindra, Mahindra & Mahindra, Maruti, Bajaj Finserv, State Bank of India and Tata

Motors were the other major laggards. In contrast,

JSW Steel, NTPC, Tata Steel, Titan and Asian Paints were the gainers.

"This sharp decline was primarily driven by profit booking after recent highs and heightened geopolitical tensions that have unsettled investor sentiment. The biggest drag on the index was Reliance Industries, which fell by 3 per cent, significantly contributing to the overall market decline," Vikram Kasat, Head - Advisory, PL Capital - Prabhudas Lilladher, said.

The BSE midcap gauge declined 0.28 per cent, while smallcap index climbed 0.07 per cent.

Among the indices, auto tumbled 1.91 per cent, bankex (1.82 per cent), realty (1.80 per cent), financial services (1.40 per cent), services (1.22 per cent) and telecommunication (1.19 per cent).

Metal and commodities were the winners. "Global markets turned topsy-turvy under the threat of rising geopolitical risk in the Middle-East and plausible increase in Yen interest rate which can reduce

cross country investments in equity. "On the contrary, the Chinese market had a resurgence due to a large stimulus package and cheap valuation. FM asks taxman to analyse cases

that this organisation was among those which had a huge pile up of legal disputes in the government of India. Only this month, the I-T department had hiked the minimum threshold for filing appeals by the department at various tribunals, high courts and the Supreme Court. This move came after Sitharaman, in her July Budget speech, declared this policy decision. The CBDT, while increasing these thresholds, had said that an appeal should not be filed merely because the

tax effect in a case exceeds the prescribed monetary limits and instead should be decided on merit of the case. "The officers concerned shall keep in mind the overall objective of reducing unnecessary litigation and providing certainty to taxpayers on their income tax assessments while taking a decision regarding filing an appeal, the CBDT had said in a circular. Sitharaman, during the meeting with the top I-T brass in August, also asked the Board to prepare a list of advocates who were "experts" in direct tax laws after it was stated in the meeting that the lawyers assigned to the I-T Department by the Ministry of Law and Justice for representing the department before the NCLT were "not upto the mark". It was also discussed to hike the fee that is paid to special legal counsels of the department as it was found that their current remuneration was "low"

The minister also approved a proposal of the department to have the name of the assessing officer printed in the faceless assessment orders issued by the department after it was flagged that having no name was leading to "lack of ownership" of the document and "demotivation" among the officials. The FM approved that the faceless assessment orders of the I-T department will now bear the name of the assessing officer at the end of the document, the sources said.

Tax officials manning the faceless assessment regime also flagged to the FM that the jurisdictional assessment officers (JAOs) and Faceless Assessment Officers (FAOs) should be merged in order to streamline the work of the department and also lessen the workload on the former. The JAOs, as the name suggests, look after routine tax work in their assigned jurisdiction while the FAOs only deal with faceless assessment cases.

It was also stated by an officer of the department, the sources said, that the digitisation of I-T documents should have been completed before the faceless assessment scheme was launched in 2019-20. The faceless assessment of I-T scheme was launched by the Modi government with an aim to eliminate instances of high handedness and corruption as the assessee (taxpayer) and the assessor (taxman) will not come face-to-face and tax processes could be completed over the Internet with the taxpayer not required to go to an I-T office. (PTI)



Nasrallah's assassination

assan Nasrallah, one of the Arab world's most prominent and charismatic leaders, was a figure who could stir emotions far be-Lyond his homeland. His assassination, killed by a barrage of the US-made bombs dropped by Israel, has sent shockwaves through the Muslim world. For some, including Kashmiri politicians Mehbooba Mufti and Omar Abdullah, the news hit close to home, symbolizing a deeper conflict that transcends borders. However, Mehbooba and Abdullah, both prominent figures in Jammu and Kashmir, remained notably restrained in their reactions. They did not name the United States, which has steadfastly supported Israel. Yet, a young Kashmiri girl's reaction on social media was markedly more emotional. In a defiant statement, she warned that "a Nasrallah will be born in every Kashmiri home," a clear indication of the admiration Nasrallah commanded even beyond Lebanon. Her conviction and fiery expression left a powerful impact, with her words resonating like a 5,000-watt bulb in a region marked by its own struggles. Nasrallah, widely regarded as the most eloquent orator in the Arab world, met his end in a manner devoid of the grandeur that marked his life. He was killed in his Beirut bunker, alongside his daughter, in a devastating airstrike. Nasrallah's speeches, once sold like hotcakes in Lebanon, made him a symbol of resistance for many. For over 32 years, Nasrallah built Hezbollah into a formidable force, shaking the boots of Israel and its Western allies. His assassination, therefore, was not just a military action but a political earthquake that reverberated across continents.

India, like much of the international community, has reacted with a level of indifference that frustrates many Muslims. Nasrallah wasn't merely a militia leader, but a figurehead of the resistance against Israeli and Western intervention in the Middle East. Mehbooba Mufti's silence could be interpreted as caution, but her sentiments may well align with the popular refrain: "Nasrallah is dead, but Hezbollah lives on." The United States. already heavily invested in the Middle East, has deployed more troops to the region in the wake of Nasrallah's assassination. Hezbollah's leadership, already decimated by previous strikes, now faces a critical turning point. as experts warn that Nasrallah's death could trigger an all-out war. Yet, the circumstances leading to Nasrallah's death point to a failure of Hezbollah's military wing. Israeli intelligence had successfully carried out a slew of targeted assassinations and airstrikes, seemingly lowering Hezbollah's guard. Nasrallah's bunker, previously thought to be impenetrable, became his tomb, courtesy of 5,000-pound U.S.-made bunker-busting bombs.

Nasrallah, who wore the distinctive black turban symbolizing his descent from the Prophet Muhammad, was not just a military leader but a symbol of Shia resistance. He, along with Iranian general Qassem Soleimani, was a key strategist of the so-called "Axis of Resistance." Now, with his death, Israel has turned its attention to other enemies, including the Houthis and Islamic fighters in Syria and Lebanon. Hezbollah remains a significant force, with over 50,000 fighters still ready to take up arms, and a new leader will undoubtedly rise to take Nasrallah's place—just as Abbas al-Musawi did when Israel assassinated him in 1992. Israeli Prime Minister Benjamin Netanyahu, speaking from New York at the United Nations, took responsibility for the strike, calling Hezbollah a "quintessential terror organization." His message was clear: Israel will defend itself at any cost. And in the wake of Nasrallah's death, the United States has doubled down on its support for Israel, despite previously speaking of a

SBI's move to buy equity in big defaulter company SIIL is preposterous

n a move that has surprised corporate watchers, State Bank of India (SBI) will take a dual role in the debt restructuring of defaulter Supreme Infrastructure India Ltd (SIIL). This development marks an unprecedented step in India's corporate debt resolution landscape, as the country's largest public sector bank transitions from being SIIL's primary creditor to becoming an equity stakeholder.

State Bank of India has been SIIL's largest lender, with the infrastructure company defaulting on a substantial ₹ 1,023.42 crore of SBI loans. Now, in a surprising turn of events, SBI is poised to invest ₹ 24.33 crore in SIIL's preferential allotment, acquiring 28,55,771 shares at ₹85.23 per share.

This investment will give SBI approximately a 2.49 percent stake in the restructured AIBEA's Banking News Bulletin from All India Bank Employees' Association company. The move represents a shift from being a creditor facing a substantial write-off to becoming an equity participant in SIIL's potential recovery. According to Company Announcements SBI's decision to take an equity stake in a company that has defaulted on its loans is an extraordinary development in Indian banking

This move raises several critical issues. Its eagerness to invest equity in a company that has already defaulted on over Rs 1,000 crore of its loans suggests a strange risk assessment process. The bank appears to be betting on SIIL's long-term recovery potential. As a public sector bank, its decision to use public funds to take an equity position in a distressed company may face scrutiny. The bank will need to justify this investment strategy to its shareholders and regulatory bodies. SBI's dual role as a creditor and shareholder could potentially lead to conflicts of interest in future decision-making processes regarding

On July 8, 2024, it was reported that SIIL filed a plea with the national company law tribunal (NCLT) seeking approval for a new resolution plan to settle its debts with financial creditors within a 90-daytimeframe. Following the creditors' meeting, SIIL's outstanding debt to financial creditors has been dramatically reduced from ₹ 2,200.36crore to ₹ 464 crore as the settlement amount. Its 'composite scheme of compromise and arrangement' received overwhelming support, with 92 percent of financial creditors voting in favour.

This scheme was initially approved by the company's board of directors in 2022. The company is now awaiting final approval from the NCLT to proceed with the restructuring plan. Post-NCLT clearance, the company plans to implement the resolution by monetizing company and promoters' assets, raising equity from existing or new investors and utilizing promoters contributions to finance the settlement amount. It aims to achieve debt-free status by the end of September 2024. Vikram Sharma, managing director of SIIL, expressed gratitude towards the company's partners and creditors for their trust and support. He stated, "With a strong restructured resolution plan, we are confident about obtaining NCLT clearance and achieving a debt-free status for Supreme Infrastructure by the end of September 2024." The company's total bank outstanding stood at ₹ 7,093 crore, including ₹ 2,200 crore in principal debt and ₹ 4,893 crore in funded interest term loans and unapplied in-

The settlement amount of ₹ 464 crore represents a substantial haircut of 93.45 percent for the lenders. The rationale behind such a SBI Suffers settlement amount of ₹ 464 crore represents a substantial haircut of 93.45 percent for the lenders. The rationale behind such a significant write-off and its longterm implications for the banking sector and other corporate defaulters remain unclear. Its annual report received a qualified opinion from auditors in FY 22-23, highlighting issues with loan confirmations and interest accruals. The auditor report also highlighted that SIIL has not recognized financial liability for ₹ 1,533crore in corporate guarantees given to its subsidiaries and group companies.

This significant offbalance-sheet risk could potentially un-

dermine the effectiveness of the current restructuring plan. SIIL is issuing up to 8,80,44,460 equity shares at ₹85.23 per share, along with 1,78,63,430 convertible warrants. This preferential allotment aims to raise approximately ₹ 750.40 crore. The issuance of 1,78,63,430 convertible warrants adds another layer of complexity to this restructuring. These warrants, primarily allocated to promoters and select investors, have the potential to significantly alter SIIL's ownership structure in the future. The warrant structure, which requires only25percent payment upfront with the remaining 75 percent due within 18 months, provides these select investors a low-risk option to increase their stake if the company's performance improves. This structure could be seen as a backdoor for further promoter control. potentially at the expense of existing minority shareholders.

According to an insolvency expert the table below shows that SIIL was insolvent and defaulting to banks at least since FY-2016 as is evident from the table below: According to the insolvency expert an analysis of SIIL's financial history reveals a troubling pattern of insolvency that dates back to at least FY15-16. Despite clear signs of financial distress, there is no evidence that banks, including SBI, ever initiated insolvency proceedings under the Insolvency and Bankruptcy Code (IBC). Instead, it was an operational creditor, Vikas Shuttering Store Private Limited that finally dragged SIIL into insolvency proceedings in November 2018 for accumulated defaults of merely ₹ 14.26 crore. This action, taken for a relatively small amount compared to the company's total debt, highlights the apparent reluctance of major financial institutions to take decisive action. The Corporate Insolvency Resolution Process (CIRP) order was passed on September 30, 2019, followed by a disputed mutual settlement for ₹ 9.50 crore.

The outcome of this settlement remains unclear, further underscoring the opacity surrounding SIIL's financial dealings. According to the insolvency expert given SIIL's precarious financial condition according to the insolvency expert it was logical to expect a standard CIRP with the promoters being ineligible under Section 29Aof the IBC. However, it appears that the promoters reached a settlement with the lenders under Section 12A of the IBC. While such settlements can include asset and financial restructuring, including debt-to-equity conversion, the terms of this particular deal raise serious concerns. The insolvency expert also highlighted that the decision by SBI to subscribe to SIIL's fresh equity at a premium is particularly alarming. Typically, in such 5 restructuring scenarios, lenders are expected to recover their debt while leaving minimal equity value for the promoters.

SBI's investment in equity at a premium suggests that the bank may have written off an excessive amount of debt, inadvertently leaving substantial value for the very promoters responsible for the company's financial troubles. According to the insolvency expert this arrangement between SBI and SIIL creates a dangerous precedent in India's corporate debt landscape. It potentially encourages other defaulting companies to seek similar deals, where they can retain control and value even after significant defaults. Moreover, it raises questions about the effectiveness of India's insolvency resolution framework and the role of public sector banks in managing distressed as-

The situation bears hallmarks of what some experts are terming a "financial Stockholm syndrome," where the lender (SBI) appears to be aligning itself with the interests of the defaulting borrower (SIIL) rather than prioritizing the recovery of public funds. The unusual nature of this debt restructuring and equity investment calls for immediate regulatory scrutiny.

The Reserve Bank of India (RBI) needs to step in and examine SBI's decision-making process in this matter. There is a pressing need to ensure that public sector banks maintain strict discipline in their approach to debt resolution and avoid creating moral hazards in the financial system. This is a watershed moment in Indian corporate debt resolution. This move blurs the traditional lines between lenders and equity holders, potentially opening up new questionable avenues for dealing with distressed assets. (IPA Service)

The crisis of leadership in Kashmir: A legacy of broken trust and compromises

ashmir, a region with a long and tumultuous history, has been shaped by leaders who have repeatedly compromised the aspirations of its people. The National Conference (NC) under Sheikh Muhammad Abdullah and the People's Democratic Party (PDP) under Mufti Mohammad Sayeed have both played major roles in this. These parties have let down the people of Kashmir by making compromises on their ideologies and aligning with powers in Delhi for personal gains, while neglecting the region's demand for autonomy self-determination and

Sheikh Muhammad Abdullah, hailed as the "Lion of Kashmir," began his political career as a leader who championed the cause of the oppressed Kashmiri Muslims. His early years were defined by his advocacy for Kashmiri autonomy and self-rule, particularly through the establishment of the All Jammu and Kashmir Muslim Conference in 1932.

However, his transition to the National Conference in 1939 marked the beginning of his ideological shift, as he sought to present himself as a secular leader, aligned with the Indian National Congress, though some see that as a change towards better

Abdullah's departure from the aspirations of the Kashmiri people began after the partition of India in 1947. Initially, he had leaned towards a plebiscite for Kashmir, but his relationship with Jawaharlal Nehru, India's first Prime Minister, ultimately resulted in the Instrument of Accession, whereby Jammu & Kashmir became a part of India, albeit with special status under Article 370. This move, while maintaining a degree of autonomy for Kashmir, tied its fate to the Indian Union. Critics argue that Sheikh Abdullah had entered into a Faustian bargain that allowed for the gradual erosion of Kashmir's autonomy. Through this, the Indian constitution's laws seeped into the state, diminishing its

self-governance. In 1952, Sheikh Abdullah entered into the Delhi Agreement with Nehru, which confirmed that Jammu and Kashmir would enjoy special privileges, including its own constitution, flag, and Sadr-e-Riyasat (the state's head of government). However, this agreement was seen as another betrayal, as it effectively conceded several important powers to the central Indian government. This left the state's autonomy under threat from right-wing parties and the Indian government alike. For many Kashmiris, this agreement was a clear signal that Sheikh Abdullah was more interested in holding onto power than in securing the full autonomy of Kashmir.

Sheikh Abdullah's downfall came swiftly in 1953 when he was dismissed and imprisoned. This occurred after it was believed that he was contemplating an independent Kashmir or leaning towards Pakistan, something that alarmed Nehru and Indian leadership. Abdullah's political games and power struggles led to his isolation, with his old ally, Bakshi Ghulam Mohammad, replacing him. Abdullah had hoped to maintain his unchallenged rule, but his ambiguous policies led to his own ouster, reinforcing his image as a leader who compromised the aspirations of the Kashmiri people for personal power.

The 1987 Jammu and Kashmir Legislative Assembly elections represent another troubling chapter in the history of the National Conference's broken promises. Sheikh Abdullah's son, Farooq Abdullah, took over the reins of the party after his father's death in 1982. The elections were widely rigged to ensure the victory of the NC-Congress alliance, and this event is often seen as a turning point that shattered the people's faith in democracy.

The election fraud led to the rise of armed insurgency in Kashmir. Opposition leaders, particularly from the Muslim United Front (MUF), were harassed, and votes were manipulated. Many leaders of the MUF, who had tried to engage in peaceful political processes, turned to militancy after losing faith in the system. This betrayal by the NC directly fueled the insurgency, leaving Kashmiris disillusioned and pushing the region into decades of vi-

Mufti Mohammad Sayeed's career, like that of Sheikh Abdullah, is marked by a series of ideological compromises. Initially a member of the Congress Party, Mufti Sayeed rose to prominence by supporting the Indian narrative on Kashmir. His tenure as India's first Muslim Home Minister from 1989 to 1990 was marked by controversy, especially the kidnapping of his daughter, Rubaiya Sayeed, by militants. The release of militants in exchange for her freedom was seen by many as a major compromise, further undermining his credibility in Kashmir.

However, Mufti's most significant ideological shift came in 1999 when he formed the People's Democratic Party (PDP). This new party positioned itself as a moderate voice advocating for dialogue and reconciliation between India and Kashmir. While the PDP initially attracted support by promoting the idea of "selfrule" and peace talks, many saw this as a calculated attempt by Mufti to rebrand himself and gain political power in a postinsurgency Kashmir, however some considered it as embracing a more progressive viewpoint.

The most controversial decision in Mufti Sayeed's political career came in 2015 when he formed a government in alliance with the Bharatiya Janata Party (BJP), a party with a starkly different vision for Kashmir, The BJP, known for its stance on the complete integration of Kashmir into India and its opposition to Article 370, was seen as an enemy of Kashmiri aspirations for autonomy.

By entering into an alliance with the BJP, Mufti Sayeed and the PDP betraved the trust of the Kashmiri people who had

supported the PDP as an alternative to the NC and Congress. This alliance was deeply unpopular, with many Kashmiris feeling that Mufti had compromised his principles for power. The PDP's decision to align with a party that was actively seeking to dismantle Kashmir's autonomy alienated many of its supporters and led to widespread protests in the region.

The history of the National Conference and the People's Democratic Party is one marked by compromises and unfulfilled commitments. From Sheikh Abdullah's alignment with the Indian government in 1947 to Farooq Abdullah's rigging of the 1987 elections, and Mufti Sayeed's alliance with the BJP in 2015, these leaders have repeatedly chosen personal and political gain over the aspirations of the Kashmiri people. Their legacies are marked by broken promises and unfulfilled hopes, leaving Kashmir in a state of unresolved conflict and disillusionment.

But it's not just the NC and PDP anvmore. Several leaders who were once part of these parties have broken away to form their own factions, now serving as proxies for the central government. These newer parties and leaders are simply a continuation of the unfulfilled promises we've witnessed for decades, who are now aligned closely with the ruling party at the Centre, further deepening the manipulation and erosion of local authority.

These parties—both old and new claim they will restore Article 370, but this is nothing more than political theatre. They know full well that the constitutional amendment that removed our special status cannot easily be reversed. Yet they continue to make empty promises, preying on the hopes of the people. Their claims are hollow, designed to exploit our pain and frustrations for their own electoral gain.


Moreover, these leaders have not been courageous enough to speak for the voiceless in Kashmir. The real issues-unemployment, lack of development, and the suppression of civil liberties—are often ignored. The common people are left in a state of fear, unable to raise their voices against the injustices they face daily. These parties prefer to stay silent on these matters because addressing them would mean going against the powers that be, something they are unwilling to do.

What Kashmir needs now is true leadership—individuals who will advocate for the rights of the people, not for personal or political gain. We need leaders who have the courage to speak about the suppressed issues, those that common people cannot discuss openly due to fear. This suppression cannot continue if we are ever to see lasting peace and prosperity. The graveyard silence that currently pervades our land is not peace. Real peace comes from justice, equality, and the freedom to express our desires for a better future. We deserve leaders who will fight for this, not just for their next electoral win. How Hanoi became a hub for French scholars studying India

The French first arrived in India in the 17th century, but for another 100 years or so, they had no interest in its civilisation. India was just another source of trade for them – until Abraham Hyacinthe Anquetil-Duperron came along.

Anquetil-Duperron, the son of a spice importer, had dedicated himself to classical studies and philology. He travelled to India in 1754 and ended up spending eight years in the country, learning Persian, Sanskrit and other Indian languages as well as Zoroastrian theology. He published the first European translation of the Avesta and became the first professional French Indologist. It was he who conceived the institutional framework for the profession.

"It is true that a few missionaries have already produced some work on Asia that is important and even essential in its genre,' Anquetil-Duperron wrote. "European scholars have also extended the field of our knowledge in the same area.

However, their work suffers from certain drawbacks. On the one hand, these relate to the duties attached to the state of being a missionary. On the other, there are drawbacks such as being deprived of the company of Orientals, and the advantages of being able to do all things they do, and seeing things with their eyes.'

Anquetil-Duperron insisted that another way had to be tried or else these disadvantages would prevent France from having a "satisfactory understanding" of Asian countries. "This gulf will never be bridged by simple travellers' tales from soldiers, sailors or traders," he warned.

His solution was straightforward: "It is professional scholars who are needed, scholars who travel." "But how will they be able to do this? We know that communication helps to increase understanding, and that distant countries sometimes have needs that require informed and prompt help. A way that might be advantageous to both sides could be to set up what I might call travel-

Anquetil-Duperron died in 1805, with his wish to establish such academies unfulfilled. But his work became popular in France. The Collège de France in Paris introduced Sanskrit as a subject in 1814, followed by others such as the École Pratique des Hautes Études, which was established in 1868, and the École des Langues Orientales.

At these schools, the emphasis "was on the study of classical languages and texts or written documents taken out of their original context," write Catherine Clémentin-Ojha and Pierre-Yves Manguin in their book A Century in Asia: The History of the École

Française D'extrême-Orient (2007) It was Anquetil-Duperron's ideas that provided the framework for the École Française D'extrême-Orient (or the French School of the Far East, abbreviated as EFEO). This institute played a priceless role in enabling Indologists and Sanskrit scholars from France to engage in research and conservation in what was called "Further India"

The EFEO was established in Hanoi in 1900 while it was under French colonial occupation. Its first researchers were either Indologists or Sinologists, many of whom knew Sanskrit.

Although it opened in French-occupied Indochina, the EFEO had a pan-Asian outlook from the start. "The goal was to deepen knowledge about the civilisations of India and China and their influence in Southeast Asia," Clémentin-Ojha and Manguin say.

The school followed Anquetil-Duperron's vision. "In a university setting where Asia was studied through texts and from Europe, the EFEO saw itself as playing an original role," Clémentin-Ojha and Manguin say. "From the time of its foundation, it allowed its members to conduct their prolonged research in situ and facilitated their direct contact with Asians on the very site where their traditions had evolved.

New generation

One of the co-founders of the EFEO was Sylvain Lévi. A "brilliant Indologist" who was "prodigiously erudite", Lévi became "a professor at the Collège de France at the age of 31," say Clémentin-Ojha and Manguin.

Lévi was a master of Sanskrit as well as Japanese and classical Chinese. He taught and inspired a whole generation of Indologists such as George Coedès, who was the director of the EFEO from 1929 to 1947 and whose book The Indianized states of Southeast Asia is a definitive text on the subject.

About his mentor Lévi, Coedès said, "His intellectual brilliance was supported by an unfailing memory, a rare ability to assimilate knowledge and an uncommon power to work without flagging.

"As competent as a pandit in Sanskrit, he still found time to learn Chinese in spite of his workload, as he considered a knowledge of that language indispensable in his studies of Buddhism," Coedès added. "For the same reason later on, he felt he had to learn Japanese. He was always ready to make the effort

needed to acquire a new tool for his work." In 1911, Lévi took a critical look at how the "Orient" was seen in France. "In principle this is simply a geographical term," Lévi explained. "In fact, it is a brutal conception that sweepingly divides up humanity into two halves, in the vein of the old hellenistic idea of barbarians. Its crude symbolism conveys a sense of the smug pride of the West that scorns the whole world outside its bor-

Even in the early 20th-century France, there was little understanding of the great civilisations of Asia, such as India and China. Knowledge of these countries was "not ranked highly in institutions of higher learning," Clémentin-Ojha and Manguin write. "Certainly, a discipline focussing on the Orient had existed from the second half of the 17th century but Oriental studies and orientalism had a marginal place in comparison with the Classical studies which were considered an integral part of the education of any cultivated man.'

Nehru's request

While a large number of French scholars focused on the Indian influence in Indochina, one of Lévi's best students, Jules Bloch, was determined to follow in Anquetil-Duperron's footsteps and live in India. Bloch, who graduated from the École des Langues Orientales, majoring in Hindi and Tamil, became a member of the EFEO in 1905 and lived in Hanoi for three years before moving to India.

Bloch's first stop in India was the French colony of Pondicherry, where he put his knowledge of Tamil to good use. "His first port of call in India was Tamil Nadu but eventually he settled in Maratha country at Poona with R.G. [Ramakrishna Gopal] Bhandarkar, and a group of philologists gathered around him," Clémentin-Ojha and Manguin write.

His book titled Caste et dialectes en tamoul (Caste and Tamil Dialects) was published after he returned to Paris. The book illustrates "how sociological and linguistic research could happily go hand in hand," says the EFEO on its website.

In 1914, he published his thesis titled La formation de la langue marathe (The Formation of the Marathi Language), which the EFEO calls "the greatest fruit of his stay in India". This was turned into a book in 1919 and translated into Marathi in 1941 and English in 1970.

"In his second major work published in 1934, L'indo-aryen, du Veda aux temps modernes (The Indo-Aryan, from the Vedas to Modern Times), he describes the languages of India in direct relation to Sanskrit, and Sanskrit itself, in all its forms and with its Iranian connections," the EFEO says.

Bloch moved back to Paris in 1937, where he was appointed professor of Sanskrit language and literature at the Collège de France. This was the same position Bloch's mentor Lévi had held until his death two years earlier.

The outbreak of the Second World War and the subsequent German occupation of Paris forced Bloch out of the institution. He returned to the Collège de France and his professorship once the city was liberated in 1944 and stayed on for the next seven years. His most notable work in the post-war years was Structure grammaticale des langues dravidiennes (Grammatical Structure of Dravidian Languages). Published in 1946, the book was translated into English by Ra-

makrishna Harshe in 1954. The EFEO, encouraged by Jawaharlal Nehru, finally set up its first centre in India in Pondicherry in 1955. By this time, thanks to the efforts of Indologists like Lévi, Coedès and Bloch, India studies had become

well established in France. "The aspiration was simply to set up a great French research centre in India that would be comparable to that of the Mecca of Orientalism, the Asiatic Society of Calcutta," Clémentin-Ojha and Manguin write. "Unlike the British, for lack of any dedicated base in India, French Indologists had great difficulty carrying out long-term studies in their chosen country. They had to work principally outside the frontier of the subcontinent. Some studied the effects of the expansion of Buddhism or Brahminisim in Southeast Asia or 'Further India' as the regions which had undergone Indian influence were then known.'

Although India, after attaining independence in 1947 from Britain, pushed France to leave its colonies in the country, the French scholarship in further establishing the ancient links between India and South East Asia was appreciated. Indian diplomat and historian KM Panikkar, for instance, praised the work of the EFEO while serving as India's first ambassador to China: "Whatever its lack of success in other domains, France in the Orient stands out for its sympathetic understanding in the cultural domain." Panikkar added that the EFEO had earned the "gratitude of the peoples of Asia for the magnificent work of its scholars in the restoration and conservation of monuments, the collection, publication and interpretation of inscriptions and other related

What are the early signs of multiple sclerosis (MS)?

S is a relapsing or progressive disease of the Lentral nervous system (CNS). It occurs when the body's immune system mistakenly attacks the healthy nerves of the brain and spinal cord. According to the National Multiple Sclerosis Society (NMSS), the disease affects nearly million adults in the United States. Most people with MS experience their first symptoms in their 20s or 30s.

Early intervention offers the best chance at preventing long-term disability. So it is crucial to recognize the initial symptoms of MS and seek prompt medical attention

Vision changes with MS

The National Institute of Neurological Disorders and Stroke reports that vision problems are often the first symptom of MS. Inflammation and demyelination disrupt vision when it affects the optic

Possible vision changes include:

- · blurred vision double vision
- red color distortion loss of vision

· pain with eye movement when looking up or to the side

Fatigue and weakness with MS Most people with MS experience fatigue and weakness. Nerve damage in the spine and brain results in long-term, or chronic, fatigue. Weakness most commonly affects one extremity at a time before affecting other body parts. The symptom may be very bothersome for several days to a few weeks or barely detectable to start with and

worsen over time. Tingling and numbness with

Tingling and numbness are other common early warning signs of MS. These symptoms most often

Initially, the numbness and tingling may be very noticeable. However, this can become painful over time. Most of the time, these symptoms are not disabling ini-



Symptoms can come and go in periods of exacerbation, when they worsen, and remission, when they lessen in severity but do not resolve completely. Pain and spasms with MS

Up to two-thirds of people with MS worldwide report experiencing related pain. Examples of shortterm pain include:

• trigeminal neuralgia, a sudden, severe pain in the face

· Lhermitte's sign, a brief, electric shock-like sensation from the back of the head down the spine • neuropathic pain, a burning or

sharp sensation around the body • MS hug, a sensation of pressure around the ribs

Dizziness and loss of balance

Dizziness and balance problems affect many people with MS. They may experience:

- feeling off balance frequent falls
- near-falls, such as tripping • a feeling of falling toward one side or the other These symptoms can cause peo-

ple to lose their balance, fall, or find it difficult to walk. Less commonly, people with MS experience vertigo, which is the sensation that the surroundings are spinning.

Bladder and bowel issues with

The majority of people with MS experience some degree of bladder dysfunction. Bladder issues occur when lesions affect nerve signals that control the bladder and urinary function.

Symptoms typically include:

· increased urinary frequency

- urinary urgency • difficulty starting urination
- nighttime urination
- incontinence • difficulty emptying the bladder

Bowel issues are also common in people with MS. Most experience constipation or loss of bowel con-

Sexual problems with MS Sexual arousal begins in the CNS when the brain sends mes-

sages to the sex organs. Damage to these nerves causes some people with MS to notice changes in their levels of sexual desire, sexual activity, and ability to orgasm. Other symptoms of MS, such as fatigue and pain, may also reduce sexual desire.

any background. Recent research indicates the incidence of MS among Black people is consistent with the rate among white people. When to contact a doctor

Anyone with early symptoms of MS should consult a doctor without delay. Damage to the CNS can occur before a person experiences symptoms.

Early diagnosis and treatment can provide the best chance of preventing disability. Many treatments can help slow the progression of MS, and medication can help alleviate symptoms such as pain, fatigue, and bladder problems.

Summary

The signs of MS can vary widely. Most people who develop MS have symptoms in their 20s or 30s. Early signs include vision changes, numbness and tingling, and weakness. However, people may experience these symptoms at any point, or they may recur throughout the course of the disease. Some MS effects, such as muscle spasms, chronic pain, and emotional disturbances, only occur

Social media age limit: Will banning children be enough?

ustralia's recent proposal to introduce a minimum age for children to use social media has sparked a global debate about how best to protect young people from its negative effects. With the government suggesting an age limit between 14 and 16, the intention is clear: shield children from the social harms linked to excessive screen time, mental health issues, and unrealistic social comparisons. But is an outright ban the answer? Can we expect this move to be effective, or are we merely sweeping the problem under the carpet?

In theory, setting an age limit seems like a straightforward solution to mitigate the risks associated with social media. However, the reality is far more complex. One of the most significant challenges in enforcing an age limit on social media is the sheer difficulty of verifying users' ages reliably. Most platforms already have minimum age requirements. Yet, we all know that younger children are active on these platforms, often bypassing age restrictions by simply entering a false birth date during

It's a loophole too easy to exploit, and without a robust verification system, raising the age limit can't be a solution. Some platforms have attempted to introduce measures such as ID verification or even facial

recognition, but these solutions come with their own set of concerns. For instance, YouTube Kids requires credit card information to verify the parent's identity. While well-intentioned, this method raises privacy concerns and is far from foolproof. Moreover, tech-savvy children often outsmart such measures using VPNs. Banning social media for children without a watertight system to monitor and regulate their access is like locking the front door while leaving the back door wide open. When discussing social media and its impact on children, parental oversight inevitably comes into play. Parents are expected to monitor and control their children's access to these platforms, but can they realistically do so in this hyper-connected world?

The answer, unfortunately, is no. Even the most diligent parents cannot be expected to oversee every minute of their children's online activity. A well-meaning ban on social media might give parents a false sense of security, but it doesn't change the reality that children will find ways to access these platforms.

If we push them off regulated, mainstream platforms, they may seek refuge in the darker, unregulated corners of the internet—spaces where risks of cyberbullying, exposure to harmful content and even predatory behaviour are even greater. Social media is, undeniably, a double-edged

On the one hand, it exposes children to unrealistic portrayals of life, leading to anxiety, depression, and a constant need to measure up to others. On the other hand, it provides a space for young people to connect, express themselves, and access educational resources. Banning it outright may remove the toxic aspects but also deny them these valuable oppor-

tunities. As parents and educators, our challenge is to strike a balance. Instead of rushing towards a ban, it might be more prudent to focus on equipping children with the skills they need to navigate the online world responsibly. Digital literacy, mental health education, and open conversations between parents and children can go a long way in protecting young minds from

the pitfalls of social media. Rather than looking at social media as an enemy to be vanquished, we should view it as a tool that requires careful handling. Age restrictions, when implemented properly, can help shield younger users, but without holistic solutions—ranging from better parental support to more reliable age verification methods—their efficacy will be limited. 



In the past week, Israel has frequently targeted Beirut's southern suburbs, where Hezbollah has a strong presence — including the massive strike on Friday that killed Nasrallah — but had not hit locations closer to the city centre.

The strike early Monday killed three members of the Popular Front for the Liberation of Palestine, a small, leftist faction that has not been meaningfully involved in months of fighting between Israel and Hezbollah in Lebanon. Israel has not claimed the strike but is widely assumed to have carried it

Also on Monday, Hamas announced that its top commander in Lebanon, Fatah Sharif, was killed with his family in an airstrike on the Al-Buss refugee camp in the southern port city of Tyre. The Israeli military confirmed that it had

targeted him.

Hezbollah began firing rockets, drones and missiles into northern Israel after Hamas' October 7 attack from Gaza into Israel sparked the war there. Hezbollah and Hamas are allies and both supported by Iran, and Hezbollah said t would continue the attacks in solidarity with the Palestinians until there was a cease-fire in Gaza.

Israel has responded to the rockets with airstrikes in Lebanon. where Hezbollah is based, and the fighting has steadily escalated over the past year. The Lebanese government says the fighting may have displaced up to a million people, although the UN estimate is around

Tens of thousands of Israelis have also been displaced. Israel has vowed to keep fighting until the attacks stop and its citizens can return to their homes.

The United States and its allies have called for a cease-fire, hoping to avoid further escalation that could draw in Iran and set off a wider war. But Israeli Prime Minister Benjamin Netanyahu has shown little interest, as his country racks up military achievements against a longtime foe.

Some Israelis broke into spontaneous celebrations after Nasrallah's death was announced. Videos circulated of crowds at bars singing a song in Hebrew mocking him. A news anchor on a pro-Netanyahu station sang and danced as the studio audience joined in with him while a commentator on Israel's largest TV station offered co-panelists celebratory shots.

Hezbollah, which boasts tens of thousands of battle-hardened fighters and long-range missiles capable of hitting anywhere inside Israel, has long been seen as the most powerful militant group in the region and a key partner to Iran in both threatening and deterring Israel. Hezbollah fought Israel to a month-long stalemate in their 2006

Russia targets 11 Ukrainian regions as it steps up drone attacks

KYIV, Sept 30: Russia fired missiles and drones at 11 regions of Ukraine, the Ukrainian air force said on Monday, in a 33rd consecutive night of aerial attacks behind the front line and set a new monthly record of drone barrages.

In Kyiv, multiple explosions and machine gun fire could be heard throughout the night as the Ukrainian capital's air defences fought off a drone attack for five hours. No casualties were reported in Kyiv or elsewhere, though a "critical infrastructure object" caught fire in the southern Mykolaiv region, Gov. Vitalii Kim said, without elaborating. Russia has increasingly deployed Shahed drones, rather than more expensive missiles, in its aerial bombardment of Ukrainian cities since its full-scale invasion of its neighbour in February 2022.

It launched more than 1,300 Shahed drones at Ukraine in September alone — the highest number of drone attacks in a single month since the war began. Ukraine, too, has developed a new generation of drones for the battlefield and for long-range strikes deep inside Russia. More than 100 Ukrainian drones were shot down over Russia on Sunday, Russian officials said. Also Monday, Russian President Vladimir Putin released a video marking the second anniversary of the annexation of four Ukrainian territories and again accused the West of turning Ukraine into "a military base aimed at

Putin was speaking to mark the annexation of the Donetsk, Luhansk, Kherson and Zaporizhzhia regions of Ukraine after a referendum held in 2022 which was denounced by the West as a sham. Russia also illegally annexed Crimea in 2014.

Since 2022, Putin said, businesses in the occupied areas are being "actively restored" and hospitals and schools are being rebuilt. Thousands of Ukrainians fled from the four regions as a result of Russia's invasion, but Putin said Russia's military operation in the country was to defend residents' "well-being" and the "future for our children and grandchildren". (AP)

Biden says he hopes to visit Helene-impacted areas this week if it doesn't impact emergency response

WASHINGTON, Sept 30: President Joe Biden says he will visit Hurricane Helene-impacted areas this week as long as it does not dis-

rupt rescue and recovery operations. Biden was briefed again on Sunday evening about the impact of the devastating storm on an enormous swath of the Southeast.

In a brief exchange with reporters, he described the impact of the storm as "stunning" and said that the administration is giving states "everything we have" to help with their response to the storm. Biden planned to speak about the

administration's response efforts in remarks from the White House on Monday. The White House also said Vice President Kamala Harris will visit

the storm-ravaged areas "as soon as it is possible without disrupting

emergency response operations.' At a Las Vegas rally Sunday night, Harris spoke about the impact of Helene, saying, "I know everyone here sends their thoughts and prayer for the folks who have been so devastated by that hurricane." She added: "We will stand with

these communities for as long as it takes and make sure they are able to rebuild.'

Harris was spending Sunday night in Las Vegas and had planned campaign stops in the city on Monday. But her office announced that she'd instead head back to Washington earlier than expected and will

attend a briefing on the damage caused by Helene at the headquarters of the Federal Emergency Management Agency. A North Car-

Flooding deaths in Nepal reach 193 as recovery work is stepped up



KATHMANDU, Sept 30: The number of people killed in Nepal by flooding and landslides triggered by heavy rainfall over the weekend reached 193 while recovery and rescue work

stepped up on Monday. Many of the deaths were in the capital, Kathmandu, which got heavy rainfall, and much of southern part of the city was flooded. Police said in a statement that 31 people were still reported missing and 96 people were injured

across the Himalayan nation. A landslide killed three dozen people on a blocked highway about 16 kilometers (10 miles) from Kathmandu. The landslide buried at least three buses and other vehicles where people were sleeping because the highway was

Kathmandu had remained cut off all weekend as the three highways out of the city were blocked by landslides. Workers were able to temporarily open up the key Prithvi highway, removing rocks, mud and trees that had been washed from the mountains. The home minister announced temporary shelters would be built for people who lost their homes and monetary help would be available for the families of those killed and to the people who were injured by the flooding and landslides. Prime Minister Khadga Prasad Oli was returning home Monday from attending the U.N. General Assembly meeting and has called an emergency meeting, his office said. Improved weather has allowed rescue and recovery work to be stepped up.

Residents in the southern part of Kathmandu, which was inundated on Saturday, were cleaning up houses as water levels began to recede. At least 34 people were killed in Kathmandu, which was the hardest hit by flooding.

Police and soldiers were assisting with rescue efforts, while heavy equipment was used to clear the landslides from the roads. The government announced it was closing schools and colleges across Nepal for the next three days.

The monsoon season began in June and usually ends by mid-September. Meanwhile, in northern Bangladesh, about 60,000 people were affected by flooding in low-lying areas because of rains and rising water from upstream India.

People have taken shelter on roads and flood protection embankments in Lalmonirhat and Kurigram districts, the English-language Daily Star reported. The River Teesta that crosses the border was overflowing at some points and the Dharala and Dudhkumar rivers in the Rangpur region were rising but remained below danger levels, the Dhaka-based Flood Forecasting and Warning Center said Monday. Waters could start receding in a day or two, it said.

Bangladesh is a low-lying delta nation crisscrossed by about 230 rivers, including more than 50 that cross borders. (AP)

SKorean court sentences to prison 3 police officers over deadly 2022 Halloween crush

SEOUL, Sept 30: A South Korean court gave three police officers prison sentences on Monday over their botched handling of a 2022 Halloween crush in a

Seoul nightlife district that killed nearly 160 people. It was the first conviction of officials over the failure by authorities to prevent or adequately respond to the overcrowding that occurred in the popular Itaewon district. No top-level officials have been charged or held accountable, prompting criticism from bereaved families and opposition politicians.

The crush, one of the biggest peacetime disasters in South Korea, caused a nationwide outpouring of grief. The victims, who were mostly in their 20s and 30s, had gathered in Itaewon for Halloween celebra-

The Seoul Western District Court sentenced Lee Im-jae, the former chief of Seoul's Yongsan police station, whose jurisdiction includes Itaewon, to three years in prison. It sentenced another Yongsan police officer to two years in prison and gave a third officer a suspended two-vear term.

The three officers were convicted of professional negligence resulting in death. The court ruled that the crush wasn't a natural disaster and could have been prevented or the toll reduced if the three officers had prepared properly for the crowd, alerted others of the danger quickly and supervised other police officers appropriately.

The police officers and prosecutors can both appeal the ruling. The court also ruled that Park Hee-young, head of the Yongsan ward office, and three other ward officials were not guilty. It said a ward office was unlikely to have a legal right to control or break up a crowd of people. (AP)

Rwanda reports 8 deaths linked to Ebola-like Marburg virus days after declaring outbreak Health Minister Sabin

(RWANDA), Sept 30: Rwanda says eight people have died so far from the Ebola-like and highly contagious Marburg virus, just days after the country declared an outbreak of the deadly hemorrhagic fever that has no authorized vaccine or treat-

Like Ebola, the Marburg virus originates in fruit bats and spreads between people through close contact with the bodily fluids of infected individuals or with surfaces, such as contaminated bed sheets.

Without treatment Marburg can be fatal in up to 88 per cent of people who fall ill with the disease. Rwanda, a landlocked country in central Africa, declared an outbreak on Friday and a day later the first six deaths were reported.

So far 26 cases have been confirmed, and eight of the sickened people have died, Nsanzimana said on Sunday night.

The public has been urged to avoid physical contact to help curb the spread. Some 300 people

who came into contact

with those confirmed to have the virus have also been identified, and an unspecified number of them have been put in isolation facilities. Most of the affected are healthcare workers

told journalists. "We are intensifying contact tracing and testing to help stop the spread." The minister said the source of the disease has not been determined person infected

Organisation was scaling up its support and will work with Rwandan authorities to help stop the spread, WHO's Director-General Tedros Adhanom Ghebreyesus said on Saturday on the social media platform X.

The US Embassy in Rwanda's capital of Kigali has urged its staff to work remotely and avoid visiting offices. Marburg outbreaks and individual cases have in the past been recorded in Tanzania, Equatorial Guinea, Angola, Congo, Kenya, South Africa, Uganda and Ghana, according to the WHO.

The rare virus was first identified in 1967 after it caused simultaneous outbreaks of disease in laboratories in Marburg, Germany, and

AFSPA extended in Manipur for six more months

Probability of public criticism high if mishandled



IMPHAL, Sept 30: The government on Monday extended the Armed Forces (Special Powers) Act (AFSPA) by another six months in Manipur excluding 19 police station areas falling under the Imphal valley and a region that shares its boundary with Assam.

In a notification, the state government's home department said the extension will come into effect from October 1.

"The state government is of the opinion after analysing the prevailing law and order situation in the state that it is not expedient to have a detailed assessment on the ground as security agencies are preoccupied with maintenance of law and order," the notification

"The issue of declaration of Disturbed Area status is very sensitive and may likely attract public criticism and resistance if proper care SPT buildings with multistoried is not taken," it said.

"The governor of Manipur hereby accords approval to declare the entire state of Manipur excluding the areas falling under the jurisdiction of 19 police stations... as Disturbed Area for a period of six months with effect from 1st October," the notification signed by Commissioner (Home) N Ashok Kumar read.

The police station areas where

the Disturbed Areas have not been imposed include Imphal, Lamphel, City, Singjamei, Sekmai, Lamsang, Patsoi, Wangoi, Porompat, Heingang, Lamlai, Iribung, Leimakhong, Thoubal, Bishnupur, Nambol, Moirang, Kakching and

The areas that have been kept out of the purview of AFSPA are dominated by the majority Meitei community.

The disturbed area tag was first withdrawn from the Imphal Municipality areas in 2004 and was removed from 15 police stations in six districts in April 2022.

The disturbed area was removed from the other four police stations in April 2023.

The AFSPA gives sweeping powers to the armed forces operating in disturbed areas to search, arrest and open fire if they deem it necessary

More than 200 people have been killed and thousands rendered homeless since ethnic violence between Meiteis and Kukis broke out in Manipur on May 3 last year.

Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal valley, while tribals, including Nagas and Kukis, constitute 40 per cent and reside mostly in the hill districts. (PTI)

Tripura witness dip in crime rate: DGP Arunachal seeks more funds from Action taken against 3 lakh offenders

HT Correspondent AGARTALA, Sept 30: In the last three years, the Tripura Police have taken action against 3 lakh anti-social elements, while witnessing a nearly tenfold rise in arrests of border touts, according to Tripura Director General of Police (DGP) Amitabh Ranjan.

DGP Ranjan provided this update after a review meeting on law and order with Tripura chief minister Dr Manik Saĥa at the Police Headquarters on Monday.

"The Chief Minister held an indepth discussion on border issues, law and order, and other concerns. He emphasized that there should be no compromise when it comes to maintaining law and order. We must ensure a peaceful Durga Puja and take firm action against extortion. District SPs have been directed to closely monitor incidents, visit camps and areas, and ensure the welfare of police personnel," DGP Ranjan stated.

During the meeting, the CM particularly emphasized the importance of tackling drug trafficking and dealing with the issue of Rohingya infiltration. The CM also stressed the need for annual inspections, addressing property crimes and small thefts, and improving border coordination.

DGP Ranjan highlighted a notable reduction in overall crime. Comparing data from 2014-2016 (up to August) with 2022-2024 (up to August), he reported that crime figures, which once stood at 10,000, have dropped to 9,000.

"In 2014, the overall crime count was 4,026, but by August 2024, it had reduced to 2,700. Despite population growth and various constraints, we have managed to control and reduce crime," he

Crimes against women have also seen a significant drop. In 2014-2016, there were 2,700 such cases, while by August 2024, the figure had been brought down to 1,500. Similarly, offences involving physical violence have dropped from 2,800 to 2,500, and property crimes have decreased from 1,240 to approximately 800.

The DGP also emphasized the state's focus on combating drugrelated crimes. Tripura has recorded the highest seizure rates of narcotics in the Northeast re-

HT Correspondent AGARTALA, Sept 30: The Tripura Congress on Monday expressed strong dissatisfaction with the Central government, accusing it of failing to provide adequate financial aid for those affected by the recent floods in the state. The party called for urgent financial and relief measures to assist the flood victims.

In response to the crisis, the Congress organised a series of protest rallies across Tripura, urging the government to take swift action. Addressing the media, Congress MLA and former minister Sudip Roy Barman highlighted the severe losses suffered by farmers, labour-

ers, livestock keepers, and fish farmers due to the floods. "The so-called 'double-engine' government, especially the Central administration, has not provided even a single penny to the state for flood relief. This shows how little importance the Central government places on Tripura. People are starving, they've endured devastating losses, and in places like Gandacherra in the Dhalai district, the Durga Puja celebrations were completely cancelled. People are in deep distress, and no one is paying attention," said Roy Barman.

He further alleged that Congress workers were attacked while advocating for flood victims in Mohanpur, West District. "Nine individuals were seriously injured and are currently receiving treatment, BJP goons attacked us inside the SDM office while we were there to speak on behalf of the flood victims. This is beyond fascism. We stand with the people and are fighting for their rights," Roy Barman added.

The Congress has organized rallies across 23 subdivisions in the state. Additionally, the party is demanding a freeze on power tariff hikes for the upcoming year and the withdrawal of additional fees imposed on Vidyajyoti students, citing the dire state of Tripura's economy. "We will visit the SDM and submit a deputation," Roy Barman said, underscoring the party's commitment to pushing for relief and reform.

NEW DELHI, Sept 30: The Enforcement Directorate (ED) is soon expected to book Karnataka Chief Minister Siddaramaiah and some others in a money-laundering case linked to the Mysuru Urban Development Authority (MUDA), taking cognisance of a recent state Lokayukta FIR, official sources said on Monday.

Siddaramaiah, his wife B M Parvathi, brother-in-law Mallikarjuna Swamy and Devaraju -- from whom Swamy had purchased land and gifted it to Parvathi -- and others have been named in the FIR registered by the Mysuru-located Lokayukta police establishment on September 27. The FIR was lodged after a special court in Bengaluru last week or-

dered a Lokayukta police probe against Siddaramaiah in the case. The order of the special court judge came a day after the high court upheld the sanction granted by Governor Thaawarchand Gehlot to conduct an investigation against the senior Congress leader on allegations of illegalities in the allotment of 14 sites to his wife by the MUDA.

The ED is expected to press sections of the Prevention of Money Laundering Act (PMLA) to book Siddaramaiah in its Enforcement Case Information Report (ECIR). Sources said the federal agency is studying the

According to procedure, the ED is empowered to summon the accused for questioning and even attach their assets during investigation. Siddaramaiah (76) had last week said he was being targeted in the

MUDA issue as the opposition is "scared" of him and noted that it is the first such "political case" against him. He also reiterated that he will not resign following the court ordering

he would fight the case legally. In the MUDA site-allotment case, it is alleged that compensatory sites were allotted to Siddaramaiah's wife in an upmarket area in Mysuru, which had higher property value as compared to the location of her land that was "acquired" by MUDA. (PTI)

cers working on cases of crime against women are "expected to have exceptional sensitivity and empathy for the victim and utmost commitment to the task of ensuring justice"

She said law and order is not only the bedrock of governance but also the very basis of the modern state, and asked the officers to be efficient, sympathetic, fearless as well as friendly.

Murmu said police officers' roles become more crucial as India aims to scale new heights in the years to come. "Economic growth and social

development are possible only where the rule of law is upheld. Without maintaining law and order, ensuring justice and protecting citizens' rights, progress becomes a meaningless term," the president said. She asked the police officers to be tech-savvy and stay a step ahead of the criminals. Maintenance of law and order,



crime prevention and detection as well as other aspects of policing have benefited from advances in technology, the president said.

"The flip side, however, is that criminals and terrorists too have resorted to using technology. When cyber-crimes and cyber warfare are rising around the world, you will be expected to be techsavvy and stay a step ahead of the

criminals," Murmu said. The president expressed happiness over the rise in the number of women officers in the IPS

"I am told that in this batch there are 54 lady officers out of the total strength of 188. At 28.72 per cent, it is a sharp jump from last year's numbers as well as the average of

recent years," she said. Murmu said that the role of lady officers goes much beyond addressing gender-based crimes.

"Their increasing numbers can change the overall character of policing for the better, improve the police-community relations, and will prove beneficial to the nation too," the president said, addressing the IPS probationers of the 76 Regular Recruits (2023) batch.

She also advised the officers to make yoga a part of their routine and not ignore their mental well-

"I have spoken about the great responsibilities placed on your shoulders. These can sometimes be too stressful. I would like to offer you a word of advice in this regard.

"Never ignore your mental wellbeing. Make yoga, 'pranayama' and relaxation techniques part of your routine from now, and they will help you do your job better,'

India needs more time for transition from coal: Experts

NEW DELHI, Sept 30: As the UK officially shut down its last remaining coal power plant on Monday, policy experts said coal will continue to be a part of India's energy mix for the next few decades, given that it is still a developing country with significant energy needs.

The UK on Monday closed its last coal power plant, becoming the first G7 nation to do so amid calls for a global coal-free energy system by

The world's first coal power plant opened in London in 1882, and until 2012, coal accounted

for 39 per cent of the UK's electricity generation. Global energy think tank Ember said the closure of the UK's last coal plant means that more than a third of OECD countries are now coal-free, with three-quarters expected to eliminate coal power by 2030, in line with global climate goals aimed at limiting warming to 1.5 degrees Celsius.

The International Energy Agency's (IEA) "Net Zero by 2050" report recommends that developed countries phase out unabated coal by 2030, while developing countries should aim to do so by 2040 to remain on track for global net-zero emissions

The term "unabated" in this context refers to electricity production that does not use technologies designed to capture and reduce greenhouse

These developments occur as developed countries push developing countries to accelerate the phase-down of unabated coal power.

India, the world's second-largest consumer of coal for electricity generation after China, saw the share of coal-fired power generation rise to 75 per cent in 2023-24 from 71 per cent in 2019-20.

According to the IEA, while coal consumption fell in Europe and the US in 2023, it rose by 8 per cent in India and 5 per cent in China.

That said, India's coal usage for power generation began several decades later than that of developed nations. While the UK's first coal power plant opened in 1882, India established its first major thermal power plant, the Hussain Sagar Thermal Power Station in Hyderabad, in 1920.

Policy experts say India is focusing on a longterm energy transition, where coal will continue to be part of the energy mix for the next few

Sunil Dahiya, an independent analyst, said that while coal will not disappear in the near future, India must reduce harmful emissions from the sector by deploying advanced air pollution control technologies and improving efficiency to curb carbon emissions.

According to climate activist Harjeet Singh,



India has made remarkable progress in renewable energy, but the intermittent nature of these sources and the lack of scalable battery storage mean that coal still underpins its power supply and industries like steel and cement.

"Yet, the cost of coal goes far beyond emissions -- it destroys ecosystems, displaces communities, and deepens environmental injustice. India must urgently shift away from coal, and the international community must provide the financial and technological support needed for a just transition -- for both people and the planet," he said.

Labanya Jena, a sustainable finance specialist at global think tank Institute for Energy Econom-

ics and Financial Analysis, said achieving 100 per cent renewable energy deployment in India's energy mix quickly poses significant challenges.

'We need to reduce the cost of energy storage, make it easier to acquire land for RE projects, address social challenges associated with green economic transition, and make capital available at a

However, rapid RE deployment can help India decarbonize its energy system while balancing economic and energy security needs," he said.

Montek Singh Ahluwalia, former deputy chairman of the erstwhile Planning Commission, said in a webinar organized by the think tank Centre for Social and Economic Progress last week that India can't cut down coal immediately and it is hypocritical in the West to focus solely on coal while ignoring oil and natural gas.

"However, if we are going to achieve net-zero emissions by 2070, we must recognise that we need to phase out thermal power. We should indicate to the world that India's emissions will increase for a while, then peak, and eventually decline. Right now, there's a lot of misunderstanding in the West about India's willingness to reduce emissions," he said.

Sunita Narain, the director general of the Centre for Science and Environment, echoed this senavailable.

"We need to talk about a different future for coal. We must clean up coal -- not just for climate change but also for local air pollution. We will still need to invest, and that's where the world needs a conversation.

India has repeatedly emphasised that it is still a developing country with significant energy needs and that coal remains a crucial part of its energy mix because it is a reliable and affordable source of electricity.

It argues that developed countries have historically contributed more to greenhouse gas emissions, having relied on fossil fuels for their economic development. Therefore, developed nations should take the lead in reducing emissions while allowing developing countries more time to transition to cleaner energy sources.

India's Environment Minister Bhupender Yadav had said earlier that the country is committed to meeting the energy needs of its population and "will also have to rely on coal power until it achieves developed country status"

He said the nation cannot solely depend on "importing oil and gas" to meet its energy de-

NEW DELHI, Sept 30: The Supreme Court on Monday reiterated its earlier order that no intermediary is allowed to publish the name and photo of the victim in R G Kar Hospi-

tal rape-murder case As the hearing commenced, advocate Vrinda Grover told a bench of Chief Justice D Y Chandrachud and Justices J B Pardiwala and Manoj Misra that the parents of the deceased victim are disconcerted by repeated clips in social media disclosing her name and photos

The top court said it had already passed an order on this issue and it was for the law enforcement agencies to implement the order. It clarified its earlier order and said it applies to all intermediaries.

The bench noted that substantial leads have come up in the CBI investigation and it has given statements on both aspects -- alleged rape and murder and the financial irregularities. The hearing is currently underway.

The top court on September 17 had said it was disturbed by the findings given in a status report filed by the Central Bureau of Investigation (CBI) in the rape-murder case but



jeopardise the ongoing investigation.

On September 9, the top court had voiced concern over the absence of the "challan", a key document forwarding the body of the junior doctor who was raped and murdered at R G Kar Medical College and Hospital in Kolkata for postmortem, from the records presented before it and sought a report from the West Bengal government.

On August 22, the apex court had tore into the Kolkata Police over the delay in registering the unnatural death of the woman doctor, who was raped and killed at the hospital, calling it "extremely disturbing", and questioned the sequence of events and the timing of its procedural formalities.

The top court had earlier constituted a 10-member National Task Force (NTF) to formulate a protocol for ensuring the safety and security of doctors and other health care professionals

Terming the incident as "horrific", the apex court had excoriated the state government over the delay in filing the FIR and allowing thousands of people to vandalise the state-run

The rape and murder of the junior doctor in a seminar hall of the state-run hospital has sparked nationwide protests. The medic's body with severe injury marks was found on August 9. A civic volunteer was arrested by the Kolkata Po-

lice in connection with the case the following day. On August 13, the Calcutta High Court ordered the transfer of the probe from the Kolkata Police to the CBI, which started its investigation on August 14. (PTI)

Flood situation in Bihar worsens as embankments of Kosi, Bagmati rivers breached

PATNA, Sept 30: Flood situation in several parts of Bihar worsened on Monday as embankments of Kosi river in Darbhanga district and Bagmati river in Sitamarhi were breached, officials said.

The Kosi river was in spate and breached its embankment near Kartarpur block, inundating Kirtarpur and Ghanshyampur villages in Darbhanga late on Sunday, while seepage was reported in the embankment of Bagmati river in Runni Saidpur block in Sitamarhi district, they said.

The flood situation has worsened with fresh embankment breaches but it is under control. There is nothing to panic," an official said.

The state water resources and disaster management departments have

been working on a war footing, he said. "Altogether six incidents of embankment breach have so far been reported from various parts of the state. Some of them have already been repaired and work is going on for others," Bihar Water Resources Minister Vijay Kumar Choudhary told PTI on Monday.

The embankment of the Bagmati River at Madhkaul village in Sitamarhi and the Gandak river's embankment in West Champaran were damaged due to excessive water pressure, resulting in inundation in the Valmiki Tiger Reserve, another official said. "Water flowing above the embankments was reported from Valmikinagar and Kiratpur in Darbhanga. But now the water level in several rivers started receding. No casualty has been reported so far in Bihar due to the flood", the minister said. Considering the gravity of the flood situation in north Bihar, six more teams of the National Disaster Management Authority (NDRF) from Varanasi in Uttar Pradesh and Ranchi in Jharkhand are being deployed, he said.

They are being engaged in addition to the existing 12 teams of NDRF and 22 of State Disaster Management Authority (SDRF) deployed in the relief and rescue operation in the flood-affected districts," said a bulletin sued by the disaster management department on Monday.

"Despite water levels receding in several small rivers, the overall situation remained grim with over 16 lakh people affected by the deluge. No fatality has been reported so far." another official said. (PTI)

CBI arrests 26 cybercriminals in multi-state crackdown

NEW DELHI, Sept 30: In a multi-state crackdown on organised cybercrime, the CBI has arrested 26 alleged cybercriminals involved in fraudulent activities targeting people globally, officials said on Monday.

The action under operation Chakra-III started with raids at 32 different places across Pune, Hyderabad, Ahmedabad and Visakhapatnam late night last Thursday. The central agency has seized ₹ 58.45 ury vehicles, they said. Four call cen-

Inconformities Pvt. Ltd at Regent Plaza, Pune; V.C. Infrometrix Pvt. Ltd, Murli Nagar, Visakhapatnam; Viajex Solutions, Hyderabad; and Atriya Global Services Pvt. Ltd, Visakhapatnam -- were among the places raided by the agency. The Central Bureau of Investigation (CBI) intercepted 170 people engaged in live online criminal activities across the four call centers, the officials said.

'The cybercriminals targeted in this operation were involved in a range of illicit activities, including impersonating... tech support services and approaching victims, especially in the USA in the guise that the victim's systems have been hacked," a CBI spokesperson said in a statement. He said the victims were convinced by the criminals that their identities had been stolen and that a large number of unauthorised transactions were being made in their bank accounts. The scammers told the victims that they were under the scanner of investigation agencies of their respective countries, he added.

"The cybercriminals then induced the victims to transfer their bank holdings into new bank accounts given by cybercriminals in the guise of safeguarding their finances. "In some instances, the cybercriminals intimidated the victims into transferring funds to them through international gift cards or crypto currency. Extensive wrongful losses were incurred by the victims targeted by this criminal network," the statement said.

So far, the CBI has arrested 10 cybercriminals from Pune, five from Hyderabad and 11 from Visakhapatnam. Further investigation and questioning into the role of other workers at these illegal call centers is ongoing, it said.

"These operations have resulted seizure of critical digital evidence and incriminating material. 951 items have been seized including electronic devices, mobile phones, laptops, financial information, communication records and incriminating material used by this cyber crime network for criminal activity and to defraud victims," the spokesperson said. (PTI)

3 held in Delhi for duping man of ₹ 2.39 crore on pretext of providing CNG pump

NEW DELHI, Sept 30: Delhi Police has arrested three people, including a former contractual employee of the Ministry of Petroleum, for allegedly duping people on the pretext of providing CNG pumps, officials said on Monday.

The fraudsters duped a man of ₹ 2.39 crore under the guise of setting up a CNG pump, they said, adding that the accused had received ₹ 1.79 crore through various dummy bank accounts and ₹ 60 lakh in cash.

"On March 27, this year, the complainant approached the IFSO Special Cell, stating that he had been defrauded of ₹ 2.39 crore by individuals who promised to install a CNG pump on his land," Deputy Commissioner of Police (IFSO) Hemant Tiwari said.

The officer further said that the complainant told police that he was searching petrol or CNG pump allotment processes online and was approached by two individuals, Amrendra and Amit Pandey, who presented themselves as coordinators and agents of a gas company. "They lured him with promises of getting a CNG pump

installed with minimal formalities. The accused created forged documents, including a registration certificate, bank account details, and an invoice with a GST number, and sent them to the complainant. By posing as officers of a gas company. They swindled ₹ 2.39 crore from the victim," said the DCP, adding that an FIR was registered and an investigation was taken up.

According to the police, a special team was formed as the fraud dates back almost three years. The team gathered details of the bank accounts involved in the fraud and traced the money trail. The registration and allotment documents provided by the accused were verified with the gas company and found to be fake.

"Team pinpointed the location of the accused and subsequently Singh (62), the DCP said.

NEW DELHI, Sept 30: Over 50 per cent of the cotton farmers surveyed in Gujarat and Maharashtra have suffered either "major or complete" crop loss due to floods and droughts in the past five years, according to a new report.

The survey, conducted by a UKbased think tank International Institute for Environment and Development (IIED) and the All-India Disaster Mitigation Institute (AIDMI), revealed that about twothirds of the 360 farmers surveyed were experiencing longer dry spells, higher average temperatures and more days of extreme heat.

The survey, conducted in September 2023, involved cotton farmers equally split between Surendranagar district in Gujarat and Sambhaji Nagar district in Maharashtra. Most farmers were landowners, with the majority of landholdings smaller than 10 acres.

India is the largest producer of cotton globally. In 2023, it produced around 5.84 million metric tonnes -- almost a quarter of the world's cotton -- across 13 million hectares, engaging nearly six mil-

However, climate change, specifically more frequent periods of extreme heat, poses a significant threat to the livelihoods of smallholder farmers, especially women, who depend on this crop and is a critical risk to the global textile supply chain. Research shows that the western and central zones of India are more vulnerable to drought-like conditions, while the northern and northeastern zones are more susceptible to extreme flood events. Smallholder cotton farmers are particularly vulnerable in this ongoing climate crisis, putting millions of livelihoods at stake. Laura Kelly, director of IIED's

Shaping Sustainable Markets team, said, "Climate change is turning into a nightmare for farmers everywhere, and India's cotton growers are no exception.

"There are some government programmes and insurance schemes to help them, but our research shows they are not well known and may not provide comprehensive support in any case. While farmers are already doing what they can to protect their livelihoods, the government and

The IIED director said big fashion chains need to recognise they have a role to play in helping their suppliers deal with climate shocks. Supporting the families producing a key commodity for their industry is not only a moral imperative but also a smart commercial choice.

The survey found that farmers are combating the climate threat by diversifying and rotating their crops or taking loans to invest in resources like irrigation to mitigate future problems.

Dipping into savings is another common coping strategy, but not all respondents have this option available. Others reported that in response to climate shocks, they have been forced to sell land or livestock, while a small number have avoided using healthcare or even cut back on the amount of

food they consume. About two-thirds of respondents said they had crop insurance (81 per cent in Maharashtra and 42 per cent in Gujarat), one-third had life insurance, 36 per cent had health insurance and only 8 per cent had livestock insurance. (PTI)

Veteran actor Mithun Chakraborty to receive Dadasaheb Phalke Award: I&B minister

NEW DELHI, Sept 30: Veteran actor Mithun Chakraborty, star of films such as "Mrigayaa", "Surakshaa", "Disco Dancer", and "Dance Dance", was on Monday named recipient of the Dadasaheb Phalke Award, the government's highest recognition in the field of cin-

The announcement comes months after Chakraborty was awarded Padma Bhushan, the third-highest civilian honour, by the Government of India.

Union Minister for Information and Broadcasting Ashwini Vaishnaw made the announcement on X.

"Mithun Da's remarkable cinematic journey inspires generations! Honoured to announce that the Dadasaheb Phalke Selection Jury has decided to award legendary actor, Sh. Mithun Chakraborty Ji for his iconic contribution to Indian Cinema," the minister said in the post. The award will be presented to Chakraborty at the 70th National Film Awards ceremony on October 8, 2024, Vaishnaw said. The three-member jury -- comprising former Dadasaheb awardee Asha Parekh, actor-politician Khushbu Sundar and filmmaker Vipul Amrutlal Shah -selected Chakraborty for the prestigious

Chakraborty, 74, is very happy, said his son Namashi Chakaborty about the Dadasaheb Phalke Award announcement. "We all are feeling very proud. He is in Kolkata, I just spoke to him. He is a self-made superstar and a great citizen. This was long, long overdue but I am so proud that he is finally being awarded with this honour," Namashi told PTI over phone from Los Angeles.

Chakraborty, whose real name is Gourang Chakraborty, is an alumnus of Pune's Film and Television Institute of India (FTII) who has predominantly worked in Hindi and Bengali cinema.


He made his acting debut with Mrinal Sen's 1976 film "Mrigayaa", for which he won his first National Film Award for Best Actor. He earned two more National Awards for 1992's "Tahader Katha" (best actor) and 1998's "Swami

WC winner Griezmann retires from int'l soccer after 10 years with France

PARIS, Sept 30: World Cup winner Antoine Griezmann took the soccer world by surprise on Monday when he announced the end of his international career with France.

The 33-year-old Atletico Madrid player has played 137 matches with Les Bleus, scoring 44 goals during a successful 10year tenure.

Griezmann started with France in 2014 in a friendly match against the Netherlands then quickly established himself as a stalwart of the team coached by Didier Deschamps with his versatile talent and influence as both a goalscorer and an assist provider.

Only two players, Hugo Lloris and Lilian Thuram, have played more international games with France than Griezmann.

"It's with a heart full of memories that I close this chapter of my life," Griezmann said in a message posted on Instagram. "Thank you for this wonderful tricolor adventure and see you

Griezmann is fourth on France's list of all-time scorers behind Olivier Giroud, Thierry Henry and Kylian Mbappe.

He won the 2018 World Cup and the Nations League three vears later with his France team-

"After 10 incredible years, marked by challenges, successes and unforgettable moments, it is time for me to turn a page and make way for the new generation," he said.

Deeply concerning: Usha slams EC members for not felicitating Olympic medallists

NEW DELHI, Sept 30: Indian she stated. Highlighting the con-Olympic Association (IOA) President PT Usha on Monday said it is "deeply concerning" that the Executive Committee members failed to honour Olympic medallists and accused the Finance Committee of blocking funds intended to support Indian athletes' preparation for the Paris Games.

India secured six medals, including two historic bronze by young shooter Manu Bhaker, but Usha said the "EC does not want to celebrate their success" and it makes her "very sad.

These athletes have made the nation proud, and it is the responsibility of the IOA to celebrate their achievements with the respect they deserve. It is deeply concerning that, even after returning home in mid-August, the EC has failed to discuss or take any steps towards organizing a formal felicitation ceremony," she said in a statement. She revealed that a proposal for a preparatory grant of ₹ 2 lakh for each Olympic-bound athlete and ₹1 lakh for each coach had been blocked by the Finance Committee, notably by IOA Treasurer Sahdev Yadav.

"I strongly believe that this grant would have given our athletes and their coaches the support they needed in the crucial period leading up to the Olympic Games.

The refusal to disburse these funds reflects a lack of understanding of the needs of athletes and shows a complete disregard for athletes receive the honours and their preparation and well-being,"

trast with previous leadership. Usha pointed out that a successful felicitation ceremony was organised for the seven medallists from the Tokyo 2021 Olympics, even amid the COVID-19 pandemic.

Comparing Kohli and Babar baseless, the Indian star way ahead: Zaheer Abbas

SHARJAH, Sept 30: Pakistan great Zaheer Abbas feels the comparisons between Virat Kohli and Babar Azam are baseless as the Indian superstar is a lot more consistent than the under-fire Pakistan batter.

Once regarded as part of the 'Fab Five' including Kohli, Steve Smith, Joe Root, and Kane Williamson, Babar is currently enduring an extended slump in

"Yeh fizool ki baatein hai (the comparisons are pointless). Virat Kohli scores in every match the other player (Babar) doesn't score in any match so then how can you compare. The person who scores, he is the bigger player," Abbas told PTI on the sidelines of the Cricket Predicta Conclave

Kohli has 80 international hundreds to his name while the much younger Babar has scored 31

centuries across formats. Abbas also acknowledged the consistency displayed by India across formats and said the Rohit Sharma-led team will be a strong contender for the upcoming Champions Trophy.

"Indian team overall is very good. Their batters are doing well and the bowlers both are good. It is a very balanced team, one that plays soch samajh kar (thoughtfully)," said Abbas.

They have a very good captain, who understands cricket very well. So, when everything is going in your favour it is smooth sailing. That's the case with India right now.

There is a very good chance of them doing well (at the Champions Trophy) because they have a balanced team," the 77-year-old

Hailed as the 'Asian Bradman' for insatiable appetite for runs, Abbas was one of the most elegant batters of his time. He played 78 Tests and 62 ODIs for Pakistan, accumulating 5062 and 2572 runs respectively.

The 77-year-old strongly believes that Test cricket truly tests the players' character, resilience, mental strength, technique, and consistency

"Test cricket is real cricket. That it is the real Test of any player, bowler. At one point India and Pakistan's Test team



used to be good. And now the boards are realising that we can't go on without Test cricket.

"How many T20s can you play? How many white-ball tournaments can the ICC organise? Maybe 2 or 3 but in the end you have to return to ODI or Tests.

"If you continue Test cricket the cricket will last longer. I know people like to get results fast but slowly they will get bored of T20s and we need Tests and ODIs.'

An increasing number of players are turning down central contracts from their boards to focus on careers in T20 franchise leagues, a worrying trend that Abbas believes should be addressed. "Test cricket is ultimate. Anyone can win in T20. Teams can win by fluke. But that is not the case in Test cricket as it has two innings. You have the scope to do well in one innings. Test cricket teaches you a lot.

"I know a lot of the players

don't want to play Test cricket and play T20 instead. That needs to be stopped. They need to come up with something...

"Something like you have to play at least 5 or 6 Test matches a year then you can play ODI or T20s. Every year a minimum number of Test matches need to be allotted," he added.

Once a cricketing powerhouse, Pakistan now find themselves in a difficult situation. Their downward spiral began with the Asia Cup last year which was followed by the team's early elimination from the ODI World Cup in 2023 and the T20 World Cup this year.

Earlier this month they suffered their first-ever Test series loss to Bangladesh.

"Bohot bada dhakka tha (It was a huge setback) that Pakistan lost to Bangladesh. We never thought that not only Pakistan will lose but it will lose so bad.

"Pakistan cricket abhi daamadol hai (is not doing great). The performance has dropped. I am hopeful that it will get better. The reasons behind this are many. (PTI)

DC co-owner GMR group takes over Hampshire in county cricket

Kohli becomes fourth player to complete 27,000 international runs

KANPUR, Sept 30: Indian batting superstar Virat Kohli on Monday became only the fourth player in history to complete 27,000 runs in international cricket across formats, a feat that he achieved on the fourth day of the ongoing second Test against Bangladesh here. Kohli made a brisk 47 off 35 balls with four fours and a six as he helped India push on further in an aggressive mode to make up for the lost time in the Test due to incessant rains.

He is only the second Indian cricketer to have breached the 27,000-run mark and stands fourth in the list for most international runs across formats, which is headed by the legendary Sachin Tendulkar

In between the two Indian batting greats are Sri

Lanka's Kumar Sangakkara with 28,016 runs at the second spot and Australia's Ricky Ponting at the third, with 27,483 runs.

Kohli, who has a little over 8,870 runs in Tests, has 13,906 runs in 295 ODIs and another 4,188 runs in 125 T20Is — a format from which he retired after helping India win the T20 World Cup in June this

India record fastest team hundred and fifty during 2nd Test against Bangladesh

KANPUR, Sept 30: Indian batters went on a rampage to better their own record of fastest team hundred in men's Test cricket while resetting the record of quickest fifty on the fourth day of the rain-affected second match against Bangladesh here. Yashasvi Jaiswal hammered 10 fours and a six to make the fourth fastest fifty for any Indian batter after Rohit Sharma's early fireworks (23 off 11 balls, 3x6s, 1x4s), as the 50-run mark was breached in a mere three overs at the Green Park on Monday

India thus broke England's record of scoring the fastest team fifty in 4.2 overs which they had reg-

istered against the West Indies at Trent Bridge in July this year. While Jaiswal continued with his aggressive approach, No 3 Shubman Gill also joined in to punish the Bangladesh bowlers as India crossed the triple-figure mark in 11.overs, improving their own record. India had recorded the fastest century for any team in terms of overs faced when they went past the 100-run mark against the West Indies at Port of Spain in 2023. Indian batters went all guns blazing in reply to Bangladesh's 233 all out in the first innings. Only 35 overs' play was possible on the first three days of this final match due to persistent rains and ground conditions. (PTI)
