Trading scam accused to be brought to Assam

Guwahati Police gets transit remand for Deepankar Barman



GUWAHATI, Oct 28: Deepankar Barman, who was arrested in Goa for his alleged involvement in a multi-crore online trading scam in Assam, will be brought here after completing legal formalities, a top

police officer said on Monday. Barman, the prime accused in the case, was presented before a local court in the western state for transit remand. He was arrested from Pernem police station area in north Goa on Sunday evening.

Meanwhile, Pernem court of Goa today granted three-day transit remand for Deepankar Barman

Earlier, addressing a press conference, Guwahati police commissioner Diganta Barah said the first case against Barman was registered at Paltan Bazar police station on August 22, but he had fled the city by August 18 when media reports had appeared on his firm's

The multi-crore online trading scam in the state had come to light in August when investors, who had put in huge amounts of money in 29-year-old Barman's company, complained that he had not paid them the due returns and his office had been closed.

Most of the cases registered in connection with the scam, including the one concerning Barman, have been transferred to the Central Bureau of Investigation (CBI).

Barah said though Guwahati Police couldn't trace Barman till the time the case was under its investigation, they still continued with their technical analysis which led them to Goa. "Our team was stationed in Goa for two weeks. We had some information, like how he transferred money from here to Goa. We coordinated with Goa Police's crime branch and also devel-

Credible information on Barman's location was received on Saturday and a four-member team, led by an additional commissioner of police, left for the western state on Sunday morning.

"As the original case registered against Barman was transferred to CBI, we registered a new case at Paltan Bazar police station on Saturday and pursued him under it," the CP said.

"He was staying in a homestay at an isolated location. While searching his room, our team recovered more than ₹ 27 lakh in cash, his passport and the gold jewellery he was wearing," Barah said.

Since the arrest was made in a different state, legal formalities have to be completed before bringing him, he said. He said "not much spot interrogation" has been done and thorough questioning

Rahul launches fresh attack on SEBI chief

NEW DELHI, Oct 28: Stepping up his attack over conflicts of interest allegations against SEBI chief Madhabi Buch, Congress leader Rahul Gandhi on Monday said the current regime is no longer merely encouraging monopolies but actively concentrating the nation's wealth in the hands of a few.

Gandhi, the leader of opposition in the Lok Sabha, made the remarks in his post along with a video featuring him and Congress' media and publicity department head Pawan Khera in which they talk about the alleged conflicts of interest of SEBI chief Buch.

"Institutional collapse has now given way to a more dangerous form of cronyism -- Adani Bachao. The current regime is no longer merely encouraging monopolies, it's actively concentrating the nation's wealth in the hands of a few," Gandhi said.

The Madhabi Buch scandal goes deeper than initially imagined, he said, adding that it may be that Buch, entrusted with safeguarding retail investors, has been manipulating the system to protect Adani's interests and his inflated valuations. Those (CONTD. ON PAGE-2)

No decision yet on oppn demand for caste census

NEW DELHI, Oct 28: The muchdelayed decadal census exercise and the work to update the National Population Register (NPR) are likely to begin in early 2025, and the data will be declared by 2026, thus changing future census cycles completely, official sources said.

However, no decision has been taken yet on whether the caste census will also be carried out along with the general census.

The country's population count has been conducted every 10 years since 1951, but the census work in 2021 could not be carried out due to the Covid-19 pandemic. So far, no formal announcement has been made on its next schedule. "In all probability, the work for

the census and the NPR will begin early next year and the population data will be announced by 2026. With this, the census cycle is likely to be changed. So, it will be 2025-2035 and then 2035-2045 and so on in future," sources privy to the thinking of the government said.

The office of the registrar general and census commissioner had prepared 31 questions to be asked to the citizens during the census exercise.

These questions include whether the head of the household belongs to a Scheduled Caste or Scheduled Tribe and other family members as asked in the previous census.

Opposition Congress and the RJD are among the political parties which have been demanding a caste census so that the total OBC population in the country is known.

"The government has not yet taken any decision on caste census,' a source said. It is to be seen whether the government will go ahead with the delimitation exercise, which is due in 2026 after the census data is published. Several political leaders from Southern states have expressed their apprehensions over the possibility of their states losing out on Lok Sabha seats and thereby their political clout as they have been successful in population control, unlike the Northern states.

They feel that the southern states may get less number of Parliamentary seats than the existing number of constituencies if the delimitation is carried out with the new data. On the other hand, Article 82 of the Constitution states: "Provided also that until (CONTD. ON PAGE-2)

India and Spain sign MoUs on multiple fronts

VADODARA, Oct 28: India and Spain signed several memorandums of understanding (MOUs) during the bilateral meeting between Prime Minister Narendra Modi and his Spanish counterpart Pedro Sanchez in Gujarat's Vadodara city on Monday. During the bilateral talks held at the iconic Laxmi Vilas Palace here, both leaders also discussed the situation in Ukraine and in West Asia, said Tanmaya Lal, secretary (west), ministry of external affairs.

"With respect to Ukraine, both sides exchanged their views on how they see the situation. PM Modi reiterated India's position that any such conflict can only be resolved by dialogue and diplomacy. This is not the time for war, this cannot be resolved on the battleground. It is necessary that direct discussion takes place between both the parties," Lal told reporters.

India reiterated its position that it really looks for a free, open, inclusive, prosperous and peaceful Indo-Pacific, he said, adding more on the region will be covered in the joint statement to be issued soon.

India and Spain, during the bilateral talks, signed agreements on cooperation in key sectors like infrastructure, railways as well as culture and tourism, he said.

Greenhouse gas emissions surge to new record in 2023: WMO report

NEW DELHI, Oct 28: Greenhouse gas levels surged to a new record in 2023, rising by more than 10 per cent in just two decades, according to a new report by the World Meteorological Organisation (WMO).

In the course of 2023, large vegetation fire CO2 emissions and a possible reduction in carbon absorption by forests combined with stubbornly high fossil fuel CO2 emissions from human and industrial activities to drive the increase, according to the WMO's annual Greenhouse Gas Bulletin.

The globally averaged surface concentration of carbon dioxide reached 420 parts per million (ppm), methane 1934 parts per bilion and nitrous oxide 336.9 parts



per billion (ppb) in 2023. These values are 151 per cent, 265 per cent, and 125 per cent of basis of the long-term observations within the Global Atmosphere Watch network of monitoring sta-

"Another year. Another record. This should set alarm bells ringing among decision-makers. We are clearly off track to meet the Paris Agreement goal of limiting global warming to well below 2 degrees Celsius and aiming for 1.5 degrees Celsius above pre-industrial levels. These are more than just statistics. Every part per million and every fraction of a degree temperature increase has a real impact on our lives and our planet," said WMO Secretary-General Celeste Saulo.

The 2023 increase of CO2 in the atmosphere was higher than that of 2022, although lower than that of the three years before that. The annual increase of 2.3 ppm marked the 12th (CONTD. ON PAGE-2)

Economic performance satisfactory, demand conditions bear watching: Finmin Report

NEW DELHI, Oct 28: The performance of the Indian economy has been satisfactory during the first half of the ongoing fiscal year but concerns remain with regard to demand conditions going forward, the

finance ministry said in a report. The outlook for the Indian economy is good, underpinned by a stable external sector, positive agricultural outlook, expected improvements in demand supported by the festival season, and the likelihood of an increase in government spending, which will boost in-

vestment activity, it said. However, at the margin, demand conditions in the economy bear watching, the September edition of Monthly Economic Review released by the Depart-

ment of Economic Affairs on Monday said. Urban demand appears to moderate due to softening consumer sentiments, limited footfall due to abovenormal rainfall, and seasonal periods during which people tend to refrain from new purchases.

Further, risks to growth arise from escalating geopolitical conflicts, deepening geoeconomic fragmentation and elevated valuations in financial markets in some advanced economies, it said

Their spillover effects on India could cause negative wealth effects, impacting household sentiments and altering spending intentions on durable goods, it said. After two months of low inflation, consumer price inflation rose in September, primarily driven by the effects of erratic monsoon on a few vegetable supplies. Barring a sharp rise in prices of a few vegeta-

bles, inflation appears well contained, it said. In the medium term, it said, favourable factors, such as rejuvenated reservoir levels, healthy Kharif crop sowing brightening the agriculture output prospects, and ample food grain stocks, would help contain price

consecutive year with an increase greater than 2 ppm. In the last 20 years, the CO2 level has increased by 11.4 per cent (42.9 ppm) above the level of 377.1 ppm recorded in 2004 by WMO's Global Atmosphere Watch network of monitoring stations.

From 1990 to 2023, radiative forcing -- the warming effect on our climate -- by long-lived greenhouse gases increased by 51.5 per cent, with CO2 accounting for about 81 per cent of this increase, according to the National Oceanic and Atmospheric Administration Annual Greenhouse Gas Index cited in the WMO Bulletin. As long as emissions continue, greenhouse gases will continue accumulating in the atmosphere leading to global temperature rise. Given the extremely long life of CO2 in the atmosphere, the temperature level already observed will persist for several decades even if emissions are rapidly reduced to net zero.

The last time the Earth experienced a comparable concentration of CO2 was 3-5 million years ago, when the temperature was 2-3 degrees Celsius warmer and the sea level was 10-20 metres higher than now. (PTI)

This ROB is being constructed to replace level crossing gate no ST-35 at Kampur Station on the Guwahati–Lumding BG line section. The ROB is targeted for completion by January 2025 at an estimated cost of ₹ 60 crores.

The existing road on level crossing gate no ST-35 passes through the station yard of Kampur and is situated on a state PWD road. There is significant detention of road traffic due to shunting operations, movement of trains in both directions, or stabling of trains. The gate experiences heavy traffic, with a total vehicle unit count of 1,98,181. The ROB will have an overall length of over 512.58 meters, with the main span consisting of a 42-meter bow string arch steel

Kazan summit and economic ties

RICS nations concluded their annual summit in the Russian city of Kazan on October 24 resolving to deepen economic ties. Plans to deepen financial cooperation and develop alternatives to Western-dominated payment systems were also discussed, besides offering African nations a bigger say in the changing global order. The BRICS group has become a major political force in the last two decades, building on its desire to create a counterweight to Western influence in global institutions. The group's expansion in 2023 increased its heft. After Iran, Saudi Arabia and the United Arab Emirates (UAE) joined it in 2023, the alliance that initially referred to Brazil, Russia, India, China and South Africa has gradually become a bigger body. Russian President Vladimir Putin at the BRICS closing session in the southwestern Russian city of Kazan said all countries joining the bloc "share similar aspirations and values and a vision of new democratic global order." The threeday summit, which ended last Thursday, also provided a platform for member countries to discuss plans to deepen financial cooperation and develop alternatives to Western-dominated payment sys-

At the same time, the summit also brought out new disagreements on issues such as Russia's invasion of Ukraine. Russia's 2024 leadership could intensify the bloc's anti-West focus, including attempts to edge out the US dollar - though experts feel that it may be an uphill task. Though there are assumptions that the bloc could undermine the Western-led international order, sceptics say its ambitions to create its own currency and develop a workable alternative to existing institutions face potentially insurmountable challenges. The group's 2024 expansion comes with a range of geopolitical implications. It represents growing economic and demographic heft: the ten BRICS countries now comprise more than a quarter of the global economy and almost half of the world's population. The group is poised to exert influence over the wars in the Gaza Strip and Ukraine, the shape of the global economic system, the competition between China and the West, and efforts to transition to clean

BRICS' thematic priorities are, firstly, advocate for greater representation in global organisations. The group aims both to push for reform of existing institutions, and to form negotiating blocs within those institutions. Secondly, coordinate a balanced economic policy. Thirdly and most ambitiously, work out a new global payment system to reduce reliance on the US dollar. And lastly, create an alternative finance system. Indeed, this year's Summit Declaration may offer little of substance. But there were a number of bilateral meetings before and in the margins of the gathering that are more indicative of the direction of BRICS. Perhaps most importantly, India's prime minister, Narendra Modi, and China's president, Xi Jinping, held their first face-to-face discussion in five years. A warming of relations between China and India could generate more momentum for BRICS to deliver on its ambitious agenda to develop, and ultimately implement, a vision for a new global order.

There is a disturbing trend of people travelling to the sadder places of the world: sites of military attacks, war zones and disasters. Dark tourism is now a phenomenon, with its own website and dedicated tour guides. People visit these places to mourn, or to remember and honour the dead. But sometimes they iust want to look, and sometimes they want to delight in the pain of oth-

Of course, people have long visited places like the Auschwitz-Birkenau Memorial, the site of the Twin Towers destroyed in the 9/11 attacks, Robben Island Prison, where Nelson Mandela and others spent many years, and more recently, the Chernobyl nuclear power plant. But there are more recent destinations, connected to active wars and aggression.

Since the Hamas military attacks of October 7, 2023, in which around 1,200 people were killed and more than 250 taken

hostage, celebrities and tourists have visited the related sites of the Nova music festival and the Nir Kibbutz Palestine/Israel.

kibbutz tours, guided by former residents, allow people to view and be guided through houses of the dead, to be shown photographs and bullet holes. Sderot, the biggest city targeted by Hamas, is offering what it describes as "resilience tours", connecting tourists with Octo-

ber 7 survivors. Similar places are visited in Ukraine. The "popular" Donbas war tour, for instance, takes visitors to the front lines of the conflict and offers "a firsthand look at the impact of the war on the local population", introducing them to displaced locals, soldiers and volunteer fighters. There's also a Kyiv tour, which takes in destroyed military equipment and what remains of missile strikes

Solidarity tours These tours have vari-

ous names, but one Israeli company calls them "solidarity tours"

The idea of solidarity lessens the presumption of voyeurism, or the accusation of ghoulish enjoyment of pain or suffering. It suggests an affinity with those who have died or those who have lost loved

But solidarity is a political affiliation too. These tours are not only therapeutic. They are not only about "bearing witness", as many guides and visitors attest. They are also about solidarity with the

What is this struggle? Genocide scholar Dirk has written Moses thoughtfully on this after October 7. Colonial states seek not just security, but "permanent security". This makes them hyperdefensive of their borders. Israel was created as a nation by the newly formed United Nations in 1947, two years after the end of World War II and in the shadow of the Holocaust: it was an inevitable product of the Balfour Declaration (1917) that carved up the Middle East.

The creation of the Israeli state turned relationships between Palestinians and Jewish people into borders to navigate and police, producing a line of security to defend.

Pretoria, South Africa, a memorial called Freedom Park depicts the names of every person who died in every war fought in South Africa, as well as those South Africans who died in the world wars. The names are written on a wall that circles the park. It is impossibly long and circular, and you cannot measure it with your own stride. It is disorientating and interminable, like grief.

In this memorialmetaphor, you are unable to comprehend - and at the same time are awash with - a history of loss, represented by the names. The walls contain you, and then they cannot. Grief and even solidarity is not always about comprehension or contain-

Sometimes it is about proximity. Sometimes, it is about sitting with not knowing. Sometimes, it is about solidarity with something that cannot be

Trauma, psychoanalysis tells us, is an experience of what we cannot assimilate. If you sit in proximity people and places where traumatic events have happened, you can learn something. If you see the bullet holes at a site of loss, you can comprehend something. But not everything. Bullet holes in a wall are the very definition of a partial

People visit memorials and sites of loss to learn and to unlearn. Dark tourism has this quality.

Obscenity of understanding

In my field, criminology and trauma studies, we try to understand why people do the violent things they do. Holocaust filmmaker and commentator Claude Lanzmann has said we must not indulge in what he calls the "obscenity of the project of understanding" in relation to Nazi perpetrators of the Holo-

He regards curiosity about the minds of perpetrators and the rationale for violence as a violence in itself. Of the Holocaust, he says you cannot ask Dissappeared. Childhood: A right, not a privilege

Regular exercise not only a preventive but also a rehab tool for stroke

troke is a medical emergency and every 40 seconds, someone in the country suffers a stroke, and every four minutes, someone loses their life to it. This year, World Stroke Day highlights the transformative theme, "#GreaterThan Stroke Active Challenge," a call to empower communities around the world to embrace sports and physical activity as a vital force in stroke prevention and rehabilitation. With stroke remaining one of the leading causes of death and long-term disability, this campaign underscores how an active lifestyle is not only a preventive tool but also an aid to recovery, empowering people to push beyond the limitations of stroke.

By bringing attention to the benefits of physical activity in managing stroke risk and supporting recovery, this year's World Stroke Day encourages individuals, families, and communities to come together to address stroke proactively.

Understanding stroke: The importance of immediate action

A stroke occurs when blood flow to a part of the brain is blocked, either by a clot in the case of an ischemic stroke or by a ruptured blood vessel, causing a hemorrhagic stroke. This interruption deprives brain cells of oxygen and nutrients, leading to cell death within minutes. As stroke attacks brain tissue, it can result in physical disabilities, speech and memory problems, and other long-lasting effects. The severity depends on the extent and location of brain damage, but timely intervention is crucial in reducing the chances of severe disability or death.

Raising awareness among the public about the acronym - "FAST" Face drooping, Arm weakness. Speech difficulty, and Time to call emergency services - can save lives. Knowing these signs helps individuals take swift action and improves the chances of timely treatment.

Physical activity as a key player in stroke

Stroke is often preventable and that lifestyle choices play a major role in reducing one's risk. According to the American Heart Association, physical activity can lower the risk of high blood pressure, high cholesterol, diabetes, and obesity - all major contributors to stroke risk. Regular activity improves cardiovascular health by enhancing blood flow, lowering inflammation, and improving the function of blood vessels.

For those seeking to prevent stroke, aiming for at least 150 minutes of moderate-intensity exercise per week can significantly reduce risk. Activities like walking, swimming, cycling, and dancing are not only enjoyable but effective in keeping the body active. Strengthening the heart and maintaining a healthy weight have shown to be crucial factors in lowering stroke risk. But beyond these wellknown benefits, sports and physical activities provide a sense of community, accountability, and motivation, helping people make physical activity a sustainable part of their lives. The role of exercise in stroke rehabilita-

Exercise is not only preventive but a reha-

bilitative tool as well. For stroke survivors, engaging in movement aids in the process of neuroplasticity, the brain's ability to reorganize itself by forming new neural connections. Physical activity helps survivors regain mobility strength, and confidence. Rehabilitation through exer-

cise enhances brain function by improving blood flow to affected areas, encouraging new pathways to form and aiding the recovery of skills lost to stroke.

Rehabilitation exercises focus on controlled movement, balance, and strength training. For example, hand exercises or leg lifts can help with regaining the strength needed for daily tasks, while aerobic exercises like walking or stationary biking can improve cardiovascular health and boost mood. Simple balance exercises can also make a world of difference for survivors facing mobility challenges, and gentle yoga has been shown to reduce stress and improve flexibility.

Joining a group exercise program or working with physical therapists trained in stroke recovery further amplifies these benefits, providing stroke survivors with structured and supportive environments to rebuild strength

Traditionally, stroke treatment windows were narrow, limited to 4.5 hours for intravenous thrombolysis and six hours for mechanical thrombectomy, a minimally invasive procedure to physically remove clots. This constrained time frame left many patients who couldn't access immediate care or who experienced strokes during sleep without critical treatment options. However, recent advancements in medical science have extended the treatment window for ischemic stroke to up to 24 hours, offering new hope to patients who would otherwise be beyond reach.


Advanced imaging tools, such as perfusion CT and MRI, can now identify "penumbra" the brain tissue that is still viable but at risk of

irreversible damage. This allows medical professionals to assess which patients could benefit from treatment, even if they arrive at hospital well after traditional timeframes.

Mechanical thrombectomy, a minimally invasive procewhere dure doctors use a

stent retriever to remove a clot, has shown effectiveness up to 24 hours after stroke onset in certain patients. This breakthrough has significantly improved stroke care, offering a new chance for recovery and a reduced risk of long-term disability for patients who might have otherwise been considered ineligible for

KYIV, Oct 28: There is no doubt that the U.S. election will determine the trajectory of the war in Ukraine. The status of military aid from Kyiv's chief international backer is dependent on who becomes president, as is any prospect for a cease-fire that could benefit Ukraine.

Some in Kyiv say the country's very existence hinges on who wins the White House. As Americans vote, exhausted and outmanned Ukrainian soldiers are holding defensive lines under constant Russian fire, knowing the results will dictate their future.

The war in Ukraine is one of the most divisive issues of the Nov. 5 election: Former President Donald Trump, the Republican nominee, and Vice President Kamala Harris, the Democratic nominee, advocate very different views on how much support the U.S. should continue to

After a whirlwind Western tour, Kyiv's leaders have tried to promote their version of what President Volodymyr Zelenskyy calls his "victory plan." They hope key decisions will be made — including Ukraine's bid for NATO membership by the new administration.

name of the future president of the U.S., the country of the United States will not give up global dominance, global leadership as such. And this is possible only through the support of Ukraine and through the defeat of the Russian Federation," said Mykhailo Podolyak, an adviser to Zelenskyy.

Harris, who has decried President Vladimir Putin's "brutality," would likely carry on President Joe Biden's policy of support, albeit within the strict limits on Ukraine's ability to strike deep inside Russian territory that have frustrated Kyiv's leaders.

"President Biden has made it clear from the beginning of this conflict that his top priority has been to avoid an allout war with Russia. I think that remains the top American priority," said Malcom Chalmers, deputy director general at the Royal United Services Institute in London. The U.S. has provided Ukraine more than \$59.5 billion in military weapons and assistance since Russia invaded in February 2022. But throughout, Kyiv has been captive to fraught American politics that often undermined its battlefield po-

tential. Ukraine lost territory and manpower as weapons stocks dwindled during the six months it took the U.S. Congress to pass an aid package. Even promised military assistance has failed to arrive on time or in sufficient quantities.

Ukraine is still hoping for Western approval of strikes inside Russian territory with longer-range weapons supplied by its allies. It also holds hundreds of square kilometers (square miles) in Russia's Kursk region after an incursion in Au-

Still, Biden's commitment to support Ukraine has never wavered. Defense Secretary Lloyd Austin announced a \$400 million package during his recent visit. Zelenskyy said he expects another worth \$800 million, the first tranche for Ukraine's production of long-range capabilities. Still another \$8 billion is expected by the end of the year.

But for some, all that is too late. "If the amount of aid that was promised but not delivered had been fulfilled, we could have entered negotiations in a stronger position with Russia," said Gen. Lt. Ihor Romanenko, former deputy chief of the General Staff.

But the practical implications would be dire, and Kyiv may be forced to accept devastating cease-fire terms, with a fifth of its territory under Russian

"If the aid is stopped, the situation will become more complicated," Romanenko said. "In this case, the seizure of Ukrainian land will continue, but we do not know how fast, because their offensive potential is not unlimited.'

Zelenskyy has presented his vision for ending the war to both Trump and Harris, arguing for its necessity. He said Ukraine hopes for a post-election response from Washington, particularly on the question of NATO membership, insisting that such an invitation be irreversible.

Both Ukraine and Russia are feeling considerable economic and societal strain to maintain the war effort, (AP)

NATO confirms that North Korea has sent troops to join Russia's war in Ukraine

BRUSSELS, Oct 28: NATO on Monday confirmed that North Korean troops have been sent to Russia to aid in its almost three-year war against Ukraine and that some have already been deployed in Russia's Kursk border region, where Russia has been struggling to push back a Ukrainian incursion.

'Today, I can confirm that North Korean troops have been sent to Russia, and that North Korean military units have been deployed to the Kursk region," NATO Secretary-General Mark Rutte told

Rutte said that the move represents "a significant escalation" in North Korea's involvement in the conflict and marks "a dangerous expansion of Russia's war.'

His remarks came after a high-level South Korean delegation including top intelligence and military officials as well as senior diplomats briefed the alliance's 32 national ambassadors at NATO headquarters in Brussels.

Pak starts new polio vaccination drive as virus detected in 16 district samples

ISLAMABAD, Oct 28: Pakistan on Monday started its third nationwide polio campaign to vaccinate 45 million children against the crippling disease as the virus was detected in the environmental samples from 16 districts.

Prime Minister Shehbaz Sharif inaugurated the campaign during a ceremony at the Prime Minister's House on World Polio Day last week, the Dawn newspaper reported. He also administered polio drops to children there.

The week-long vaccination campaign, which will run till November 3, aims to tackle the alarming spread of polio in the country, which has reported 41 cases this year. During the drive, special teams of health departments will go door to door to inoculate more than 45 million children. Children will also be given Vitamin-A supplements during the campaign for additional immunity, according to the

The launch coincided with the Regional Reference Laboratory for Polio Eradication at the National Institute of Health confirming the detection of wild poliovirus type 1 (WPV1) in sewage samples from

16 districts, the report said. So far, 21 polio cases have been reported from Balochistan, 12 from Sindh, six from Khyber Pakhtunkhwa, and one each from Punjab and Islamabad. Speaking at the inaugural ceremony last week, Prime Minister Sharif underscored the importance of the campaign to prevent the disease's further spread as he stressed the urgency of the country's battle against the recent resurgence of wild poliovirus.

"Polio has re-emerged in Pakistan, reminding us of our collecavailable vaccine. With the threat at an all-time high, we must act as one nation to keep our children safe through vaccination," said Anwarul

4 Indians killed in single-vehicle crash in Canada

OTTAWA, Oct 28: Four Indian nationals were killed and one injured when the car they were travelling in crashed and burst into flames in Canada's Ontario province, authorities said. The accident occurred last week on Thursday in the Lake Shore Boulevard East and Cherry Street area of Toronto city, police said in a press release.

The five people, between the ages of 25-32, were travelling in a Tesla when it "lost control and struck the guard rail and then a concrete pillar" before bursting into flames, the press release said.

"We have gathered some evidence so far to suggest that speed was a factor," Toronto Police Duty Inspector Phillip Sinclair was quoted as saying by the Toronto Sun newspaper. Four of the car occupants were pronounced dead on the scene by the police officials responding to the accident, the press release said. The fifth occupant, a 25-year-old woman, was transported to a hospital with non-life-threatening injuries. She was rescued by a passing motorist who stopped to help, according to the report.

"Heartfelt condolences on tragic loss of Indian nationals in car accident that took place yesterday in Toronto," the official handle of the Indian Consulate in Toronto said in a post on X. The post added that the consulate was in regular touch with local authorities and affected families in Canada and India. "All required assistance is being provided," it said. (PTI)

France and Morocco have historically partnered on issues ranging from counterterrorism to Western Sahara. Morocco is the top destination for French investment in Africa and France is Morocco's top trade

Morocco imports French cereals, renewable energy infrastructure like turbines and weapons. Morocco exports goods to France including tomatoes, cars and air-

Moroccans are among the largest foreign-born communities in France, where North African immigrants are a key political constituency and a focal point of debates about the roles of Islam and immigration in French society. In recent months, France's new Interior Minister Bruno Retailleau has pushed for the country to take a hard-line approach toward immigration and seek deals with countries like Morocco to better prevent would-be

Social Democrats win Lithuania's election, overcoming center-right government

VILNIUS, Oct 28: Lithuania's centerleft opposition parties celebrated victory on Monday after prevailing over the center-right ruling coalition in the final round of national elections.

With 100% of votes counted from Sunday's polls, the Social Democrats won 52 seats in the 141-seat parliament, known as the Seimas, ending the fouryear rule of the Homeland Union government led by conservative Prime Minister Ingrida Šimonytė. The Social Democrats will start talks

on forming a majority cabinet with two smaller center-left parties, the Democratic Union and the Union of Peasants and Greens, which won respectively 14 and 8 seats. The coalition is expected to control at least 74 seats Šimonytė's Homeland Union won

Vilija Blinkevičiūtė, who heads the Social Democrats, thanked supporters as a cheering crowd celebrated victory in downtown Vilnius on Sunday. "I am very grateful to the people of Lithuania who were so active today voting for us" she said adding that "the results have shown that the people want

Sophie said no items(s) other than the reduced emission firecrackers (improved crackers) and reduced emission firecrackers (green crackers: safe water and air sprinklers) as prescribed and approved by the Petroleum and Explosive Safety Organisation (ESO) will be used during the permitted hours.

Tripura CM directs for development of new parking zones to tackle traffic woes

AGARTALA, Oct 28: Chief Minister Manik Saha said on Monday that the Traffic Police, Transport Department, and Agartala Municipal Corporation (AMC) must collaborate to alleviate traffic congestion on Agartala's busiest roads. She had joined the BJP from the Congress in March this year. Sumit Wankhede, who has served as Fadnavis's personal assistant for several years, will be the BJP's candidate from Arvi assembly constituency.

Incidentally, the BJP had given Fadnavis' former PA Abhimanyu Pawar a ticket from Ausa in 2019. Pawar had won at the time. Later, Shreekant Bharatiya was made an MLC by the party.

Maratha-OBC division likely to tilt scales in late Gopinath Munde's hometown Consolidation of Maratha votes in favour of Sonawane evident

NAGAR, Oct 28: Maharashtra agriculture minister Dhananjay Munde will have to effectively counter the Maratha vote consolidation in Parli assembly segment, the hometown of late Gopinath Munde which interestingly won't have a BJP nominee in the fray

after decades Elections to Maharashtra assembly will be held on November 20 and votes will be counted three

days later. Just four months ago, the Maratha factor contributed to the narrow defeat of BJP candidate Pankaja Munde, cousin of Dhananjay, from the Beed Lok Sabha constituency which includes

the Parli constituency. The Maratha quota sentiment remains a strong factor to reckon with in Parli, a rural constituency dominated by issues like MSP for soybean crops and unemployment.

Political observers feel Dhananjay will have to ensure the support of the OBC community to blunt the resentment in Marathas against the BJP-led government.

In a strategic move, Sharad Pawar has fielded Rajesaheb Deshmukh as NCP (SP) nominee against Dhananjay Munde, an Ajit Pawar loyalist and NCP candidate.

Parli is the hometown of the late Gopinath Munde, credited for expanding BJP's footprint in the Marathwada region.

With BJP nominating Pankaja as an MLC and Dhananjay already a member of the NCP camp, the Parli constituency won't have a BJP representative this time.

Pankaja Munde had scored two victories in Parli in 2009 and 2014 polls. She missed a hat-trick in 2019 when Dhananjay Munde defeated her by 30,701 votes.

The brother and sister duo have buried their differences over the last five years.

NCP (SP) nominee Deshmukh claimed Dhananjay had failed to resolve farmers' issues in Parli. He alleged local people are living in an atmosphere of fear and insecu-

Dhananjay, however, feels that the intensity of the Maratha factor has reduced over the months. Speaking to PTI, he said the

caste politics witnessed in the Lok Sabha elections was an aberration, highlighting the victory of candidates of various castes from the Beed parliamentary constituency in the past.

He acknowledged that Beed is not unaffected by Maratha quota agitation, without mentioning



reservation leader Manoj Jarange. "My fight for Maratha reservation was not considered during Lok Sabha polls. Reservation was not the only issue. There are other factors including a limited discontent among farmers," Dhananjay said analysing the Lok Sabha poll

According to officials, members of the organisation also put a banner, "Devi Ahilya Bai Kothi", outside the main gate of this building on October 21.

Talking to PTI on Monday, Saadat Khan's descendant, Rizwan Khan, said, "We fully honour Chhatrapati Shivaji Maharaj and Devi Ahilyabai, but whenever one speaks about Residency Kothi, Saadat Khan's martyrdom is also men-

"Hence, we want the building to be named after Saadat Khan," he added. He recalled that his family and descendants of other revolutionaries have been demanding the renaming for years.

BANDRA STATION STAMPEDE

Viral CCTV footage shows passengers in mad scramble to board express train

MUMBAI, Oct 28: A CCTV footage has surfaced on social media showing passengers crowding and jostling to board an unreserved express train at Bandra Terminus, which led to a stampede that left ten persons injured.

The footage, purportedly from a CCTV camera on the north end of platform no. 1 at Bandra Terminus, shows the chaos that ensued when the 22-coach unreserved Bandra-Gorakhpur Antyodaya Express arrived from the railway yard around 2.44 am on Sunday. As a large number of passengers attempted to board the unreserved train, some lost their footing and fell, causing a stampede that left several injured.

However, the CCTV footage, which has gone viral on social media, does not show the stampede, as it may have taken place on the other end of the platform.

The WR is operating more than 130 festival special trains for various destinations, especially Uttar Pradesh and Bihar, for the upcoming Diwali and Chhath festivals.

While the Brihanmumbai Municipal Corporation's disaster management cell said ten passengers were injured in the incident in the early hours of Sunday, the Western Railway's official claimed only two were hurt.

In the footage, passengers with bags and belongings on their heads and shoulders are seen crowding around the train's doors. Some even carrying small drums blocked the entrance, with barely anyone getting to board the train.

It also shows passengers trying to board the train before it comes to a complete halt, while some are seen attempting to enter through an emergency exit window.

In the footage from the CCTVcamera, which covered only a couple of coaches, one RPF personnel is seen trying to deal with the crowd near the second coach from the engine, but a few more personnel later arrived, pushing through the crowd to help him.

In the viral footage, no one managed to enter the packed train.

Multiple videos of the incident circulated on social media on Sunday, one of which showed an injured passenger lying in a pool of blood on the platform as others continued boarding. Another footage showed RPF personnel rushing injured passengers to the hospital with the help of others on the platform. (PTI)

YouTuber moves Delhi HC alleging law abuse by TN police



NEW DELHI, Oct 28: YouTuber Felix Jerald on Monday moved the Delhi High Court alleging violation of his human rights by the Tamil Nadu police, which reportedly detained him illegally.

Following his plea, Justice Manoj Kumar Ohri granted him time to file additional documents in support of his contention. Jerald was allegedly arrested for hosting an "objectionable" interview of another YouTuber Savukku Shankar on his YouTube channel. The interview purportedly contains objectionable remarks against the Madras High Court and the women police officers of the Tamil Nadu police.

The high court listed the matter on December 16. Jerald, a journalist, claimed he was illegally detained for two days by the Tamil Nadu police officials and his whereabouts were not disclosed to his family members or friends with an "ill motive". He alleged non-compliance of provisions of the Code of Criminal Procedure during his arrest in violation of his fundamental rights. The plea, filed by advocates Surya Prakash and Avinash Kumar, sought a direction to state of Tamil Nadu and several police officials to pay ₹ 1 crore compensation for the pain, suffering, humiliation and loss of

reputation caused to the petitioner. The plea said Jerald, owner of "RedPix 24×7" YouTube

channel interviewed a critic and journalist Savukku Shankar on April 30, highlighting the alleged targeting of Savukku Media, the latter's news outlet, by the Tamil Nadu ruling dispensation. Following the interview, Shankar was arrested by the Coimbatore police for his allegations against the women police personnel on May 4.

Jerald's channel was also made as accused in the FIR, it said. According to the plea, Jerald had an appointment with the Press Council of India chairperson on May 11 and he had planned to extend his stay in Delhi for two more days.

However, at around 11 pm on May 10, he was "unexpectedly abducted by unknown persons claiming to be from the olice department of Tamil Nadu", the plea stated.

"It is learnt that they were the police personnel from Trichy Rural District, Tamil Nadu, and secured the petitioner in connection with a case of Trichy Cyber Crime Police Station, which was one of subsequently registered FIR for the same interview of April 30," it alleged. Jerald was stated to have not been made aware of the sub-

sequent FIR, his implication and not been served with a prior notice under Section 41A of the Code of Criminal Procedure to appear before the investigation agency. Further, it was alleged the petitioner was neither provided

with a copy of the FIR nor informed of the grounds of his arrest. The police was accused of not informing his family about their action and not producing him before the court concerned in Delhi to carry out the transit process or before a local court in Trichy within 24 hours after his arrest.

The plea claimed after keeping his whereabouts undisclosed for 66 hours, Jerald was produced before a Tiruchirappalli court on May 13 at around 5 pm and remanded to 15 days police custody. On July 31, the Madras High Court granted him bail with a directive to shut down his YouTube channel.

The Supreme Court, however, stayed the Madras High Court order. Before the Delhi High Court Jerald has alleged facing "gross human rights violations" at the hands of the Tamil Nadu police. (PTI)

They fled towards the nearby forest area in the face of retaliation by the troops.

The terrorists were later located inside a basement.

The Army's special forces and the National Security Guards (NSG) were mobilised. leading to deafening explosions and intense gunfire around 2.45 pm, the officials said, adding a helicopter was also seen hovering for surveillance. (PTI)

imports of critical minerals, says report NEW DELHI, Oct 28: India remains highly dependent on imports for minerals critical to accelerating its energy transition, with a full re-

liance on shipping in lithium, cobalt and nickel, according to a report released Monday. The report, published by the Institute for Energy Economics and Financial Analysis (IEEFA), said that India's demand for critical minerals is expected to more than double by 2030, while domestic

decade to start producing. It stresses that India needs a carefully crafted import strategy to mitigate potential trade risks while balancing international relationships to secure these essential min-

mining operations may take over a

IEEFA's report examines five critical minerals (and their compounds) - cobalt, copper, graphite, lithium and nickel – from the perspectives of import dependency, trade dynamics, domestic availability, and global price fluctuations.

The findings show that India remains largely import-dependent for



these minerals and their compounds, with 100 per cent import reliance for minerals like lithium, cobalt, and nickel.

"India should strive to de-risk its critical minerals sourcing by identifying new international resources and expediting domestic production. A concerted effort to partner with and foster bilateral relations with mineral-rich nations should be a priority for India," said the report's co-author Charith Konda,

Energy Specialist, IEEFA. "The country can also explore

investment opportunities in resource-rich, friendly nations, such as Australia and Chile, as well as African countries like Ghana and South Africa." he added.

The report said India depends heavily on China for synthetic graphite and natural graphite and it should explore cooperation initiatives with countries like Mozambique, Madagascar, Brazil and Tanzania which are some of the highest graphite producing coun-

"As part of the Global South co-

operation initiatives, these countries could be favourable partners for India for graphite trading," said the report's co-author Kaira Rakheja, Energy Analyst, IEEFA.

India is also highly import-dependent for copper cathodes and nickel sulphates from just two countries - Japan and Belgium. The report suggests India could look at the US, the fifth largest producer of copper in the world, to diversify its suppliers and enhance

supply security. For minerals like lithium oxide and nickel oxide, the dependency is low on one country, but overall imports largely come from Russia and China, both countries with poten-

tial trade risks. "Developing domestic lithium refining capacity will help India integrate with the global lithium supply chain," said Rakheja.

The report also notes the significant efforts that the Indian government is making to improve domestic production of critical minerals with the auctions by the Ministry of Mines and the planned Critical Minerals Mission.

"The critical minerals mining block auctions can serve as an opportunity for India to focus on building refining and processing capabilities to emerge as a global value-adding hub," said Rakheja.

"Government support in the form of viability gap funding and technology development will help promote such auctions and ultimately the domestic production of critical minerals. "A stable supply of critical minerals is imperative for India to achieve its renewable

energy goals," Konda said. India has committed to achieving 500 gigawatts (GW) of nonfossil fuel-based electricity installed capacity by 2030. Currently, the country's renewable energy installed capacity stands at 201 GW, with solar energy ac-

counting for 91 GW. According to another study, the fast-developing South Asian nation needs to install around 7,000 GW of renewable energy capacity to achieve net-zero emissions by 2070. (PTI)



It was clear from the first match, which the hosts won by 59 runs through a fine effort by the bowlers, that India's batting is not in top shape, and the second one-dayer underscored that reality.

India's batting went a notch down on Friday as they were bundled out for 183 while chas-

It was a tough target indeed, but not improbable in nature as Indian batters succumbed to spot-on White Ferns bowlers and to their own indiscretions.

It required a record ninthwicket stand of 70 runs between Radha Yadav and Saima Thakor to add a touch of respectability to India's run chase.

Even the overall picture is not a rosy one, as Indian batters are yet to score an individual fifty across two matches.

Radha's 48 in the second ODI is the highest individual score from India's side during this series, and the home team will require a drastic turnaround in the final match.

For that, India's power troika upfront -- openers Smriti Mandhana, Shafali Verma and skipper Harmanpreet Kaur -- will have to fire in unison.

It can have a ripple effect in a strong-on-paper middle-order consisting of Jemimah Rodrigues, Deepti Sharma and Tejal Hasabnis.

Barcelona flying high and humiliated Real Madrid seeking answers in clasico fallout



MADRID, Oct 28: Barcelona entered the latest clasico as the team to beat in Spain, having played entertaining soccer from the start of the season and coming off a big win over Bayern Munich in the Champions League.

And there was no letdown Saturday for Hansi Flick's team, leaving its biggest rival Real Madrid searching for answers after being humiliated at home.

With an attack that continued to click and a near-perfect defensive tactic, the Catalan club reinforced its status by routing Madrid 4-0 at the Santiago Bernabeu Stadium to increase its lead at the top of the Spanish league and gain added momentum following an already fast start under

"We already showed against Bayern that we are a great team," said Barcelona forward Lamine Yamal, who scored one of his team's goals. "We believe in ourselves, now people just need to see it." That goal made Yamal the youngest scorer in a clasico at 17 years, 105 days, surpassing teammate Ansu Fati, who was about 250 days older in October 2020. Barcelona has been dominant since the start of the season,

with 12 wins and only two losses - at Monaco in the Champions League and at Osasuna in the Spanish league. It was coming off a 4-1 win over Bayern Munich in the European competition. The team's attack — led by Yamal, Raphinha and leagueleading scorer Robert Lewandowski — has been virtually unstoppable, having outscored opponents 47-12 in all

Barcelona has scored four or

Valladolid in the Spanish league and a 5-0 win over Young Boys in the Champions League.

The defense came through to contain Kylian Mbappé in his first game against Barcelona as a Madrid player. He was one of the many Madrid players to be caught by Barcelona's offside traps throughout the match.

The synchronized traps limited Madrid's chances as its forwards kept failing to correctly time their breaks behind the defenders and found themselves in offside positions

Barcelona is already six points ahead of Madrid in the Spanish eague after 11 matches.

This is what we want to do, it's our philosophy," said Flick, who replaced former Barcelona great Xavi Hernández this season. "We want to go on, step by step, game by game."

Barcelona's most recent victories helped the club end two losing streaks — it had lost six straight against Bayern and four consecutive against Madrid.

Madrid, the defending league champion and Champions League title-holder, has not played its best soccer recently, having lost twice in its last five

The other defeat came at Lille in the Champions League to end a 36-game unbeaten run in all competitions. It hadn't lost in the Spanish league in 42 straight games, falling one short of a joint record with Barcelona, which went 43 matches without defeat in the competition in 2016-17 and 2017-18.

Madrid also struggled early in its Champions League match against Borussia Dortmund, when it was losing 2-0 at halfmore goals in seven of its 14 time before rallying impressively matches, including a 7-0 rout of to win 5-2. (AP)

It has only one win in its last six matches in all competitions — a 3-1 victory over Leganes in the Spanish league last weekend. Before that, it had league draws at home against Real Madrid and at Real Sociedad, and it lost 4-1 at Benfica in the Champions

"We know what we have to do, what we need to work on," Simeone said. "It's clear to me that soccer is all about getting the work done and when you can't find that dynamic you end up suffering."

On the plus side, Atletico had been unbeaten in 11 consecutive league matches until Sunday's defeat in Seville.

"We weren't able to play the type of game we wanted to play," Simeone said. "They got off to a strong start and were lucky to get the early goal."

Leganes scored three secondhalf goals in a 3-0 win over Celta Vigo, while Getafe converted a 90th-minute equalizer in a 1-1 home draw against last-place Valencia, which is winless in five consecutive matches. (AP)

Chirag Chikkara clinches gold at U23 **World Wrestling Championships**

TIRANA (ALBANIA), Oct 28: Chirag Chikkara became only the third Indian to become Under-23 world champion as India capped a rich haul of nine medals, including a gold and silver each, at the age group tour-

Chikkara, competing in the men's freestyle 57kg category, eked out a narrow 4-3 in the closing seconds of the final win over Abdymalik Karachov of Kyrgyzstan.

He becomes the second Indian man, after Paris Olympics bronze medallist Aman Sehrawat, to win the gold at the U23 Championships. Sehrawat had achieved the feat in the same category in the 2022 edition

of the meet while Reetika Hooda had become the first Indian woman to bag a gold at the tournament when she won in the 76kg category last year. Ravi Kumar Dahiya had also won a silver in the U23 World Championships in 2018.

Chikkara reached the final after a series of dominant performances, defeating Gaukoto Ozawa 6-1 in the pre-quarterfinals, Iunus Iavbatirov 12-2 in the last eight stage and Allan Oralbek 8-0 in the semifinals.

India's medal haul in the men's freestyle category also included two bronze medals, placing the nation fourth in the team standings with 82 points, trailing Iran (158), Japan (102), and Azerbaijan (100).

India also won two more bronze in men's freestyle taking the country's medal count in the category to four that secured the nation a fourth place in the team rankings.

Iran topped the team rankings with 158 points followed by Japan (102), Azerbaijan (100) and INida (82).

Vicky defeated former U20 World Championships silver medalist and European junior champion Ivan Prymachenko of Ukraine with a convincing 7-2 margin to win bronze in the men's 97kg freestyle event. It is the highest weight category at which India have medalled at this tourna-Vicky had defeated Merab Suleimanishvili of Georgia via fall in round

KYIV (UKRAINE), Oct 28: At soccer games in Ukraine, crowd sizes are determined by the capacity of the nearest bomb shelter.

For the first time since the full-scale war began in 2022, the Ukrainian Premier League is holding a full season with fans present, as martial-law bans on public gatherings have been eased.

Despite the constant threat of airstrikes, Dynamo Kyiv supporters eagerly snap up the 1,700 tickets available for each home game at the 16,000-seat Valeriy Lobanovskyi Stadium. Many fans are keen to experience a

rare moment of calm, free from the country's traditionally intense sporting rival-While the war forced Dynamo to relocate its home matches in the Europa

League to Hamburg, Germany, it uses its home stadium in Kyiv for domestic league matches. Vitalii Kozubra brought his nine-yearold son Makar to watch Dynamo, a title contender, face mid-table Zorya

Luhansk, a club displaced by Russian attacks in eastern Ukraine. "Even though there's a war going on, this is something people can enjoy together," Kozubra said, noting the friendly atmosphere at the stadium, where Zorya

fans mingled with locals. Makar marvelled at the difference between watching a game in person and on television. As the players took the field, all 22 of them draped in Ukrainian yellow-and-blue flags, the crowd, which included servicemen and families with children, erupted in applause.

The stadium was alive with the sound of players' exertion and the thud of the ball. Children rushed to the touchline for autographs, drawn by the few foreign players from Brazil, Senegal, Ivory Coast and Panama who have chosen to remain despite the war. Zorva wasn't booed

Ukraine's 16-team top-flight league has managed to continue, despite increasing challenges. Matches are scheduled for the early afternoon due to frequent power outages and the logistical challenges of travelling across Europe's second-largest country during the war.

When air raid sirens interrupt play sometimes for hours – players and fans alike head to shelters as alarms blare from loudspeakers and thousands of mobile phones. "This season, we've been lucky in

Kyiv, with no air alarms during our home games," said Dynamo club spokesman Andrii Shakhov. "But, it's a different story for away

games... The longest one we had lasted 4½ hours because of four air alarms." Ukrainian soccer players are subject to the draft at age 25, but clubs can apply

for exemptions under business protection

Two teams currently play permanently outside their home field due to the war, amid broader disruption, while two others withdrew after fighting started due to stadium damage.



The country's soccer tradition dates back to its Soviet past, when it was a soccer powerhouse, producing top-tier players and coaches.

In the 1980s, fan movements often became expressions of Ukrainian identity, defying Soviet authority.

After Ukraine declared independence in 1991, soccer continued to be a source of national pride through years of political and financial turmoil. Ukraine reached the 2006 World Cup quarter-finals and co-hosted the 2012 European Championships.

At home, supporters' groups have set

aside violent rivalries for more than a decade, ever since they united to back protesters during the deadly 2013-14 uprisings against Russian influence. Later, they organized military recruitment drives to fight in the ensuing wars.

"Dexter," a red-bearded Dynamo supporter and civilian contractor for the military, explained why the truce among rival fan groups still holds.

"It became necessary because we needed to unite against a common enemy. These internal conflicts lost their relevance when people from rival fan groups ended up fighting together in the

same military units," he said while walking his dog along the banks of the Dnipro River.

He added that fan organizations are involved in nearly every aspect of the war effort, from active combat duty to fundraising, veteran support, and providing technical skills like computer programming to the military.

He and others serving in or working alongside the armed forces spoke on the condition that they be identified only by their call signs in keeping with Ukrainian military protocol.

Dynamo officials estimate that more

than 80% of their pre-2022 fanbase is now serving on the front lines in eastern Ukraine or performing other military du-

Eight hours east of Kyiv, in the Kharkiv region bordering Russia, servicemen from the 3rd Assault Brigade played a match on a field near bombedout buildings. Many of these fighters had been recruited through soccer-related channels and acquaintances.

"Organized fans play a huge role in this war because they're highly motivated," said a serviceman with the call sign "Shtahet," a Dynamo supporter currently on deployment. Combat medic "Poltava" noted that soccer remains a vital morale booster.

"We get together whenever we can and rent spaces to play," he said. "There's not much entertainment here, so football is our only joy.

Back in Kyiv, Dynamo fan "Escobar" was grateful to catch a game while home on leave before heading back to

the front. "This is football, it's a game," the soldier said, in uniform and wearing a camouflage bucket hat, after Dynamo's 2-0 win over Zorya. "There are no bad feelings between the teams, and it's great to

see such a friendly atmosphere.' Vitaliy Buyalskyi and Maksym Braharu scored second-half goals for Dynamo, and even though Zorya players looked dejected as they walked off the field, they were still applauded by the
