Sumi, Tarkik today Online trading scam: Dibrugarh police hand over files to central probe team

DIBRUGARH, OCT 18: A fivemember CBI team arrived in Dibrugarh on Friday as part of their investigation into a multi-crore online trading scam involving Bishal Phukan, actor-choreographer Sumi Borah, Tarkik Borah, and Amlan

Confirming the CBI team's arrival, Dibrugarh Superintendent of Police Rakesh Reddy stated, "The necessary files related to the case have been handed over to the CBI tion. We are cooperating fully with them.

Until now, the investigation was led by the Dibrugarh police, headed by Additional SP (Crime) Sizal Agarwal.

Highly placed sources indicated that the CBI team will begin interrogating the accused, who are currently lodged at Dibrugarh Central Jail, on Saturday.

On September 3, the mastermind of the scam, 22-year-old Bishal Phukan, was arrested by the Dibrugarh Police after the fraud, esti-

mated to be worth at least Rs 2,200 crore, came to light. Initially, a suo-motu case was registered by the Dibrugarh Police, followed by four FIRs filed by several duped investors against Phukan.

Two of Phukan's accomplices. actor-choreographer Sumi Borah and her photographer husband, Tarkik Borah, were arrested by the Special Task Force (STF) of Assam police on September 12. A day earlier, on September 11, Sumi Borah's brother-in-law, Amlan Borah, was arrested from Muzaffarpur district in Bihar in a joint operation by Assam Police and Bihar Police.

The accused have been booked under Section 316(2)/318(4) of the BNS 2023, along with Section 21/23 of the Banning of Unregulated Deposit Scheme Act, 2019.

According to police, the online trading scam reportedly operated over nearly three years, luring clients with promises of nearly doubling their investments within 60 days. Authorities allege that the collected (CONTD. ON PAGE-2)

Bypolls to Dholai (SC), Samaguri, Behali, Bongaigaon, and Sidli (ST) were necessitated after the MLAs were elected as MPs in the Lok Sabha polls earlier this

Out of the 910.665 electorate. there are 455,924 women and 454,722 men, Goel said at a press conference.

Voting will take place at 1,078 polling stations across the five constituencies, with Sidli (ST) having the highest number of 273 booths, while Behali has the lowest at 154. Goel said there are 4,389 voters

NEW DELHI, Oct 18: Vice President Jagdeep Dhankhar on Friday flagged human rights violations against Hindus in India's neighbourhood and questioned the global silence, saying being "too tolerant" against such transgressions was not appropriate.

Questioning the "deafening silence" of the "so-called moral preachers, custodians of human rights", he said they stand exposed.

"They are mercenaries of something which is totally antithetical to human rights," he said addressing the foundation day celebrations of the National Human Rights Com-

mission. He said we are "too tolerant" and being too tolerant to such transgressions is not appropriate.

"Think if you were one of those," he said asking the people to

"Look at the kind of barbarity, torture, traumatised experience of boys, girls, and women," he said, adding look at our religious places being subjected to sacrilege.

However, he did not name any country The Vice President also cau-

tioned that some pernicious forces were trying to show India in a "bad colour" and called for a "counterattack" to neutralise such attempts.

He also said that India does not like to be sermonised or lectured on human rights.

He described Partition, imposition of Emergency and the 1984 events which "stand as a sombre reminder of the fragility of lib-

Dhankhar said there are "pernicious forces, that in a structured manner, seek to unfairly seek to

taint us" and these forces have a "sinister design" to use international fora to question our human rights record.

He said there was a need to neutralise such forces and they should be neutralised "by actions which exemplify, if I may say in the Indian context, 'pratighat' (counter-

The Vice President said these forces have devised indexes and rank everyone in the world to show "our nation in bad colour"

He also hit out at the hunger index which ranked India poorly, saying during the Covid pandemic, anti-Sikh riots as traumatising the government supported over 80 crore people with free ration regardless of their caste and creed.

The Vice President said the "sinister forces" are driven by an agenda which is "fiscally fuelled" by people (CONTD. ON PAGE-2)

CMAAA 2.0 is an extension of the earlier mission CMAAA 1.0, a flagship entrepreneur support initiative by the state government, under which Sarma distributed ₹ 510 crore to 25238 budding entrepreneurs across the state.

75.000 beneficiaries will be selected for the CMAAA 2.0. Speaking on the occasion, chief minister Sarma said, "State government is committed to start a new era of entrepreneurship in Assam where by, the empowered youth will be given opportunities to start their entrepreneurial ventures. He said that under CMAAA 2.0, the selected beneficiaries will receive ₹ 5 lakh for Professional Course Category and ₹ 2 lakh for Non-professional Course Category in two trenches as entrepreneurship incentives.'

"Applicants possessing four years degree in the



fields of engineering, medicine, agriculture, veterinary, and fishery will be treated as professional course category applicants, whereas, all other applicants (except professional category) will be treated as non-professional course category," he added.

The Chief Minister moreover said that the interested and eligible applicants will have to register themselves in the CMAAA portal and subsequently submit the detailed project report during the application phase. The portal will remain open till (CONTD. ON PAGE-2)

The elections for the 81-member Jharkhand Assembly will be held in two phases, on November 13 and November 20, with the counting of votes scheduled for Novem-

Sarma said, "NDA allies All Jharkhand Students Union (AJSU) Party will contest 10 seats, JD(U) 2, and LJP (Ram Vilas) 1 in Jharkhand as per the seat-sharing arrangement, which is almost fi-

AJSU Party will contest from

Silli, Ramgarh, Gomia, Ichagarh, Mandu, Jugsalai, Dumri, Pakur, Lohardaga, and Manoharpur. JD(U) will field candidates in Jamshedpur West and Tamar, while LJP (Ram Vilas) will contest from Chatra, he said. Sarma made these remarks in

the presence of Union agriculture minister Shivraj Singh Chouhan and AJSU party chief Sudesh

As per the arrangement, the BJP will contest 68 seats, but discussions are ongoing, and a final decision will be made soon.

Personal laws can't hinder law preventing child marriage: SC Supreme Court on Friday said the

Prohibition of Child Marriage Act cannot be stunted by traditions under any personal law and observed marriages involving children violate the free will to choose a life partner.

A bench comprising Chief Justice of India (CJI) D Y Chandrachud and Justices J B Pardiwala and Manoj Misra further issued a slew of guidelines for the effective laws. The CJI highlighted that a implementation of the law on the prevention of child marriages in the country

The bench, however, noted the issue of whether the Prohibition of Child Marriage Act (PCMA) would prevail over personal laws was pending with the Parliament for consideration. The Centre had urged the apex court to hold the PCMA to prevail over personal

"very extensive" sociological analysis was made in the judge-

"While the PCMA seeks to prohibit child marriages. It does not stipulate big social malaise of marriages fixed in the minority of a child which also has the effect of violating the rights to choice...It takes away from them, their choice of partner and life paths before assert their agency...," the CJI said.

The court noted that child marriages require an intersectional approach that acknowledges the overlapping vulnerabilities experienced by children, especially girls, from marginalised communities.

NEW DELHI, Oct 18: The Indian Institutes of Technology (IITs) across the country are offering fee concessions and relaxation in already lower cut-off to students from reserved categories to ensure inclusive and equitable quality education for all, according to offi-

"In the JEE-based admissions, fee remissions and fee waivers are provided right from the application stage. At the application stage, students belonging to the SC, ST, and PwD (persons with disability) need to pay only half the examination fee. Further, cut-offs are relaxed to support a greater number of admissions in the SC, ST, PwD and OBC categories," said IIT Madras Director V Kamakoti.

IIT Madras conducted the Joint Entrance Exam (JEE)-Advanced, the entrance exam for IITs, this "There are 23 IITs currently and

as per Ministry of Education's

focus on providing support to stu-

dents from the disadvantaged sec-

tions of society, several initiatives have been taken. Besides these, some IITs take additional measures individually as well," he said.

"To further enable a greater number of students to benefit from the high quality of education that the IITs have to offer, SC, and ST students who secure marks lower than the relaxed selection cut-off, are given special training through a preparatory course, which enables them to directly join the IITs after completion of the preparatory course," he added.

Starting this year, the JEE (Advanced) 2024 team enabled "Citizen Service Centres" across the country to help candidates, specifically from rural places, to fill out the choices and pay the fees through the online portal.

"A multi-lingual call centre was also set up to answer queries from candidates. A reconciliation day after the fee-payment deadline date was introduced this year to handle cases (who made at least one payment attempt) that had last-minute technical glitches," Kamakoti said.

During the admission process, all eligible candidates pay a seat acceptance fee to ensure seriousness (CONTD. ON PAGE-2)



Underlining the safety of minorities in India, he said the country is way ahead of others when it comes to preserving human rights, particularly those of minorities, the marginalised and vulnerable sections of society.

He also noted that on the domestic front, some were trying to use human rights to further their political agenda. In the course of his address, Dhankhar said, "Evidence in episode after episode" is piling up that the "deep state" is engaging in efforts against rising powers. Human rights, Dhankhar underlined, cannot and should not be used as a tool of foreign policy to exert power and influence over others.

'Naming and shaming is a degraded form of diplomacy. You have to preach only what you practice," he said. "Look at our school system- we don't have the kind of shootings that some countries claiming to be very developed have on a regular basis. Think of those nations that turn Nelson's eye to such horrendous transgressions of human rights," he said.

Dhankhar was of the view that the rights of other non-Hindu refugees are repeatedly invoked, "surprisingly, also in the name of human rights, when cases are filed in the Supreme Court.'

This, he asserted, exposes a political agenda aimed at disrupting the demographic balance of the country, which could have global repercussions. History is testimony that nations have completely lost their identity by not addressing this issue. It has global repercussions from the perspective of human rights, he warned. (PTI)

He also said that to be eligible for CMAAA 2.0, the applicants should not be a defaulter in loan repayment taken from any scheduled commercial bank and the applicants' household member spouse or sibling must not be a beneficiary of CMAAA 1.0.

The spirit of Chief Minister's Atmanirbhar Asom Abhijan is to empower the youth of the state and inculcate in them entrepreneurial skills. India may account for 8-10% of global work share to CDMOs by 2033: Report

NEW DELHI, Oct 18: India could potentially account for 8-10 per cent of work share outsourced to CDMOs globally by 2033, an outcome of a significant amount of work shifting from EU and the US to Asia, a report by McKinsey & Company has said.

The global CRDMO (Contract Research Development & Manufacturing Organisation) industry is about to witness a re-distribution of outsourcing work across several Asian countries, with India and Korea emerging as new powerhouses by 2033, the report said.

According to a McKinsey analysis, by 2033, India could potentially account for 8-10 per cent share of work outsourced to CDMOs globally

"This growth is largely driven by the evolving geopolitical environment with most Indian CRDMOs expecting 20-40 per cent of their



new business to stem from these changes," the survey stated.

As per market estimates, the global CDMO industry is estimated at \$224 billion which is expected to rise to \$465 billion by

McKinsey & Company Partner Anirudh Roy Popli said the biopharma industry is increasingly recognising the value Indian CDMOs bring to the table.

"With a strong focus on value and innovation, Indian CDMOs are well-positioned to play a pivotal role in shaping the future of healthcare," he added.

Eight Roads Ventures Senior

Healthcare Investments Prem Pavoor said the living geopolitical landscape and impending legislation presents a significant opportunity for the Indian CDMO industry, one that could be truly transforma-

"We're already seeing leading Indian bio-pharmaceutical companies receive more request-for-proposals, especially from US customers. Though these customers may be adopting a waitand- watch approach for now, it's clear that, amidst global uncertainties, they will seek to diversify their outsourcing footprint," he added.

This creates a huge opportunity for India, but also a challenge because Indian CDMOs will need to be prepared with the right infrastructure and services to meet this increased demand. Pavoor said. (PTI)

KNCA president, Maikon Rongpharpi said there is suppression of women. Case of child labour is increasing. Children are being kept as domestic helps, where the house owners inflict severe mental and physical abuse on the children.

She also expressed that girls staying in rented houses are also inviting crime. The owner of the rented house should enforce strict discipline and timing for them to go out and return for their safety.

Another faction of KNCA president, Protima Enghipi also stated that there is an increased rate of crime against women in recent days. In the name of sending children to schools, children staying in others homes as domestic helps are becoming bonded labourers.

We urge upon the DC and KAAC authority to build social security and normalcy so that women can move out without any feeling of insecurity." She also blamed the law and order authority for their weakness as they failed to take prompt action on any incidents. Investigation should be fast, she demanded.

She also said in the case of murder of Rina Rongpipi, where three suspects involved in the crime have been arrested. Police said there is one more. That fourth person should also be arrested immediately to award punishment. Compensation should be given to the victim's families.

Aaranyak urges collective action to protect migratory birds

HT Bureau GUWAHATI, Oct 18: As the winter season is set to bring comfort to the atmosphere in Assam, the time has come for winged visitors from faraway places to flock to the state's numerous forest

These migratory birds add to the richness of the state's biodiversity during winter, making the destinations more attractive for nature lovers and significantly enhancing the tourism potential of the state.

areas and wetlands.

The region's premier researchbased biodiversity conservation organisation, Aaranyak, has called for concerted efforts by all sections of society in the state to ensure the safety of these winter-season winged visitors, which contribute immensely to the state's in-situ biodiversity.

From November 2024 onwards. Aaranyak is organising a series of birdwatching events, as well as bird counts at various locations across Assam.

"Migratory birds that visit different areas of the state during winter are valued guests, and we



all should safeguard them during their stay. The people of the state, in general, should also remain sensitive to the protection and conservation of natural areas frequented by these migratory birds," said Dr Bibhab Kumar Talukdar, secretary

general and CEO of Aaranyak. Dr Talukdar informed that Aaranyak will be eager to extend as much cooperation as possible to bird lovers who wish to observe these wonderful winged visitors more closely.

"Assam is home to over 900 of the 1,377 bird species recorded in India so far. The diversity of habitat and altitudinal range, coupled with the location encompassing two biogeographic zones, explains this diversity and the high number of breeding birds in the state.

Assam also hosts a significant number of migratory birds, thanks to two major migration flyways, the Central Asian and East Asian-Australasian flyways, that pass over the state," said Udayan Borthakur, a senior scientist at Aaranyak.

"Aaranyak has undertaken crucial ecological research on some globally threatened birds, such as the White-winged Wood Duck. Bengal Florican, Greater Adjutant, and White-bellied Heron. We have also pioneered genetic research on the critically endangered Whitebellied Heron.

"Besides scientific research, Aaranyak has been using birdwatching as a tool to connect people with nature and contribute to citizen-science-based initiatives. Aaranyak's biologists, members, and volunteers have contributed to the development of checklists of birds for several Important Bird Areas (IBAs) in Assam," Borthakur said.

Regarding the importance of birds and migratory birds to ecosystems, Aaranyak researcher Karishma Sharma Chamlagain

said, "Birds are vital agents for critical ecosystem services such as pollination, seed dispersal, pest control, and nutrient cycling. In many regions, migratory birds further amplify these benefits, connecting ecosystems across continents. Their migratory routes span thousands of miles, demonstrating nature's intricate interconnections. "Migratory birds, in particular, are a vital link between different ecosystems. They contribute to global biodiversity by transporting genetic material across geographic regions and enriching ecosystems far from their breeding grounds.

"However, despite their ecological importance, birds and migratory birds face significant threats due to habitat loss, climate change, pollution, and human activities. Protecting them is critical not only for biodiversity but also for sustaining ecosystem services that benefit humans," she added.

Spying an art

The allegation by the Canadian Prime Minister Justine Trudeau involving Indian diplomats of the high commission in the killing of the Sikh extremist Canadian citizen, Hardeep Singh Nijjar, last year and also in the assassination attempt on another Sikh lawyer G S Pannun in USA, has created a storm in the global diplomatic community. India-Canadian ties have reached its lowest ebb with the expulsion of diplomats by both governments. What is more, the name of the Indian Union Home Minister, Amit Shah, has come up in the mails accessed by the Canadian authorities in the course of investigation. For India, and, especially, for Prime Minister Narendra Modi, the diplomatic situation is terrible, with India's trusted strategic partner United States endorsing the Canadian position. Additionally, Canada has also got the support of its other allies of the 'Five Eyes' group — UK, Australia and New Zealand. This means that most of the West is positioned against India on this spat with Canada. India is a member of four-nation QUAD led by the US. Two QUAD members USA and Australia have taken position against India.

What is the big deal about Indian government taking actions in foreign land against known terrorist? Every country does it; the only thing, it has to be foolproof and not messy. The fault with the Narendra Modi Government is that its officials and agents messed up, and the work was so shoddy that even the instructions made by the Home Minister could not be kept secret; those were intercepted by the Canadians. SC upholds 1971 cutoff: Assam's legal win, indigenous struggles continue

The Supreme Court's historic judgment, delivered on October 17, 2023, has reaffirmed the constitutional validity of Section 6A of the Citizenship Act of 1955. This judgment upheld March 24, 1971, as the cutoff date for determining the eligibility of citizens in Assam under the Assam Accord. The ruling marks a significant moment in Assam's history, affirming the state's longstanding battle with illegal immigration from erstwhile Pakistan (now Bangladesh). For decades, Assam has grappled with the challenge of migration, and the Supreme Court's decision seeks to solidify a legal foundation for addressing this contentious

The cutoff controversy: 1951 vs. 1971

The debate surrounding the cutoff date for the detection and deportation of illegal migrants has persisted for decades. During the Assam Movement, which lasted six years, indigenous groups, led by the All Assam Students' Union (AASU), originally demanded 1951 as the cutoff

Amid the challenges of deportation, a novel proposal by former Assam Governor, Lt. Gen S.K. Sinha, has gained renewed attention. Lt. Gen Sinha suggested that instead of focusing on deportation, which has proven to be largely ineffective, the government should consider making illegal migrants stateless citizens.

Under this proposal, foreigners would be allowed to live and work in Assam but would be denied voting rights. This measure, Sinha argued, would reduce political patronage for illegal migrants, which is one of

Clause 6 of the Assam Accord: Safeguarding indigenous rights

Beyond the detection and deportation of illegal immigrants, the Assam Accord's Clause 6 focuses on providing constitutional safeguards for the indigenous people of Assam. The Central government formed a committee, headed by retired justice Biplab Sharma, to recommend measures for implementing Clause 6. The committee's report includes provisions for the protection of land rights, the preservation of cultural heritage, and reservations in political and educational institutions for indigenous

While the Assam government has begun implementing some of these measures, such as land protection, many key recommendations, such as the reservation of seats in Parliament and the introduction of the Inner Line Permit (ILP) system, require constitutional amendments. These recommendations aim to protect the cultural and political rights of indigenous Assamese in the face of ongoing migration.

Economic empower-

ment as a solution While legal and political measures are crucial, they alone cannot solve the deep-rooted challenges faced by Assam's indigenous population. Economic self-reliance is seen as a vital aspect of building resilience against the sociopolitical pressures exerted by migration. Many indigenous people in Assam redependent traditional farming, which has become increasingly younger generations are migrating out of the state in search of better opportunities, leaving the agricultural economy in decline.

One pragmatic solution lies in diversifying the economy by engaging every household in incomegenerating activities. Women, in particular, can play a significant role in improving household incomes through skilled and unskilled work. Economic empowerment will allow the Assamese people to strengthen their cultural identity and heritage while securing their political fu-

A multi-faceted approach

The Supreme Court's judgment on the cutoff date for citizenship is a major step towards addressing Assam's long-standing issue of illegal migration. However, legal rulings alone cannot solve the deep-seated socio-economic and political challenges faced by the indigenous population.

The combined efforts of the state and central governments, along with active participation from civil society, are necessary to enthe effective implementation of the NRC, the Foreigners' Tribunals, and Clause 6 of the Assam Accord.

Simultaneously, the Assamese people must strive for economic self-reliance to protect their cultural identity. Only by addressing both the political and economic aspects of the issue can Assam hope to build a resilient and prosperous future for its indigenous people. Omar Abdullah has tough task as Chief Minister of J&K sans statehood

mar Abdullah has become the first Chief Minister of Jammu & Kashmir sans statehood. With it comes numerous was prior to 2019 when the region stow on the LG the power to transchallenges and responsibilities. Administering this Union Territory as chief minister will be just like serving two masters simultaneously – the Centre's diktat on the one hand and People's mandate to uphold democracy and federalism on the other.

People of Jammu & Kashmir have rejected the very idea of Prime Minister Narendra Modi's New Kashmir, and trusted the leadership of the National Conference, that had promised not only restoration of statehood for Jammu & Kashmir during the Vidhan Sabha election but also passage of a resolution for restoration of the Article 370 and 35A of the Constitution of India, that Modi government had abrogated in August 2019.

In pursuance of PM Modi's idea of New Kashmir, Jammu & Kashmir's statehood was done away with the abrogation of the Article 370, and the region was split into two Union Territories – Jammu & Kashmir and Ladakh. Peace and development was the major political plank of the BJP during the elections, which has remained elusive so far. People mandated the National Conference with majority as against the BJP's peace and development plan, which shows the people's preference is fundamentally their political aspirations.

It is here, the challenges and responsibilities of Omar Abdullah lie from which emerges the thorny tasks of administering the troubled Union Territory. To keep National Conference's promises during the elections, Omar Abdullah led government will have to pass resolution for restoration of Article 370 and statehood. Given the majority in the Vidhan Sabha, it would not be numerically very difficult. However, the sensitiveness of the issues may bring troubles for him chiefly from the Centre's representative Lieutenant Governor as true administrator of Jammu & Kashmir. The Centre is totally against restoration of Article 370, though it had promised statehood without any timeframe.

Congress, though NC's ally in INDIA bloc, has kept mum on restoration of Article 370, but has been demanding restoration of statehood. It is yet to be seen, what

would be the nature of restoration Business of the Government of of statehood – whether the resolution would only be for statehood of the bifurcated Jammu & Kashmir or the restoration of statehood as it legal powers. The new changes behad lost it.

Statements made so far regarding restoration of statehood are somewhat vague on this point. Congress leader Rahul Gandhi while congratulating Omar Abdullah for becoming CM said that "government formation without statehood felt incomplete today' adding "Democracy was snatched from the people of Jammu and Kashmir, and today we renew out pledge to continue our fight until statehood is fully restored." Omar Abdullah replied, "Thank you very much Rahul Gandhi and thank you for joining us today. The people of J&K look towards you for your continued support as we work to get out statehood back."

Nevertheless, neither restoring the statehood nor the passage of resolution to bring back now abrogated Article 370 will be easy. In the name of peace and security of Jammu & Kashmir Centre would continue to dominate, and a chief minister of this troubled region will certainly be reduced to a status of powerlessness in administrative and legislative matters.

PM Narendra Modi is not a person who accepts democratic defeats lying prostrate. We have seen it in Delhi, which is also a Union Territory with an assembly. His government has clipped the powers of the Chief Minister of Delhi by bringing several legislations and executive orders. Lieutenant Governor is calling the shots, while the officers were not taking orders from the elected state government ministers. There have been intermittent rifts between the Lieutenant Governor and the elected Delhi Government triggering litigations that went even to the Supreme Court of India, which ruled in favour of democracy and federalism. However, administering Delhi remains very tough for the elected government on account of interference of the Centre through Lieutenant Governor.

Lieutenant Governor of Jammu & Kashmir has said, "From my side, there will be no cause of confrontation." Even though his statement is not trust worthy given the track record of Modi government. The Centre has recently amended the rules of the 'Transaction of

Union Territory of Jammu and Kashmir' to ensure that Lieutenant had even more administrative and fer IAS and IPS officers, control J&K Police and law and order, and have a say in the appointment of judicial officers, including the advocate general. The Anti-Corruption Bureau, prosecution matters and prisons will also be now under LG's ambit.

It would then be naïve to believe that situation would be different than Delhi in Jammu & Kashmir and for the elected government led by Omar Abdullah. He will have to walk on fire, on several issues concerning Jammu & Kashmir including of protecting the democracy and federalism. Centre's grip over Jammu & Kashmir administration is more likely to be stronger since people's mandate clearly shows their political aspirations intact and they did not go for PM Modi's development plank.

Thorny political issues apart, Omar Abdullah will have to navigate the political landscape of every region of the Jammu & Kashmir. He has shown promise in this regard just by incorporating ministers from Jammu and Chhamb region, which may address the old grievances of these regions that they suffered neglect over Kashmir region. It is a very good beginning, but he will have to work hard to ensure development of all regions in the months to

Security will remain in the hand of the Centre, and hence, CM Omar Abdullah will be spared for numerous security related troubles. Nevertheless, policing the state will not be an easy task. Only a perfect co-ordination between the Centre and the State can solve the problem, but it should be based on the principle of democracy and federalism as provided by the Constitution of India.

CM Omar Abdullah himself has put the challenges in these words, "In my first innings (2008-2014) I was CM of the most empowered state. But now J&K is the country's most disempowered Union Territory. Also, while the win is humbling, the expectations of the people are scary as they are enormous." However, he has promised a "clean government with will to deliver on expectations of the people." March 25, 1971 - The Citizenship cutoff

arch 25, 1971, holds a special significance in L V L the history of Assam, not just as a date but as a critical legal and emotional marker that defines the state's identity and relation ship with citizenship. It is this date that marks the cutoff for determining legal residents from illegal immigrants in Assam, as enshrined in the Assam Accord, signed in 1985. This agreement was a response to years of agitation and unrest, and the decision to set March 25, 1971, as the cutoff date was both a practical and political solution to the inflamed tensions around identity and migration that have plagued Assam for decades. The consequences of this decision continue to reverberate, most recently highlighted by the Supreme Court's reaffirmation of this cutoff in its judgments, underlining its importance in shaping not just Assam's past but its future.

The roots of this cutoff date can be traced back to the tumultuous surrounding Bangladesh Liberation which saw millions of refugees fleeing violence in what was then East Pakistan. The war culminated the independence Bangladesh in December 1971, but before that, starting from March 25, 1971, the crackdown by the Pakistani military on Bengali nationalists and civilians triggered a mass exodus of refugees into neighboring regions, particularly Assam and West Bengal. This influx of refugees was unprecedented, placing immense pressure on the local infrastructure, economy, and social fabric of Assam. For the indigenous Assamese, who had long felt that their identity was being diluted by waves of migration from Bengal, this refugee crisis deepened the sense of existential threat.

Before delving into the specifics of March 25, 1971, it is important to understand the demographic and political backdrop of Assam. The state's proximity to the Bengal region meant that migrations between the two areas were common, especially during the British colonial era, when the colonial administration encouraged Bengali migration into Assam to work in tea plantations and agricultural fields. Over time, however, the influx of Bengalispeaking people, particularly Muslims from East Bengal, al-

tered the demographic balance in Assam. This created anxiety among the indigenous Assamese population, who began to feel marginalized in their own land. The Assam Movement, which gained momentum in the 1970s and culminated in the Assam Accord of 1985, was rooted in these demographic fears and sought to protect the political and cultural identity of the Assamese people.

The core demand of the Assam Movement was the detection and deportation of illegal immigrants. For the movement's leaders, any person who had entered Assam after 1951, the year of India's first census after independence, was considered an illegal migrant. However, the situation became more complicated with the Bangladesh Liberation War and the refugee crisis it created. By the time the Assam Accord was signed, the Indian government and the movement's leaders reached a compromise: March 25, 1971, the day the Pakistani military launched its operations in East Pakistan, would be the cutoff date for determining citizenship. Those who had entered Assam before this date would be granted Indian citizenship, while those who arrived after would be deemed illegal immigrants.

The significance of March 25, 1971, is therefore multifaceted. Legally, it serves as the basis for the determination of citizenship in Assam, but it also has deeper symbolic meanings. For many indigenous Assamese, this date represents the last stand in their effort to preserve their cultural and linguistic identity. The fear that unchecked migration would lead to their political marginalization and the erosion of their culture was the driving force behind the Assam Movement. Setting March 25, 1971, as the cutoff date was, in their eyes, a necessary step to protect the future of Assam.

The Assam Accord was intended to bring peace and resolution to a region torn apart by years of agitation, violence, and unrest. However, implementing its provisions proved to be a monumental task. One of the key challenges was the updating of the National Register of Citizens (NRC), a process aimed at identifying illegal immigrants and distinguishing them from legal residents. The first NRC was compiled in 1951, but with the signing of the Assam Accord, it became necessary to update the list to reflect the March 25, 1971, cutoff date. The process of updating the

troversy, delays, and legal challenges. Many residents of Assam, of the emotional and political bagparticularly those from marginalized communities, found it difficult to produce the necessary symbolizes the defense of their accumentation to prove their lineage or presence in the state before the cutoff date. The bureaucratic process was cumbersome, with many facing the risk of being left stateless despite having lived in Assam for generations. This led to widespread fear and uncertainty, as individuals and families awaited the outcome of

the verification process. The final NRC list, published in August 2019, excluded nearly 1.9 million people, sparking protests and legal challenges. For those left off the list, it meant the possibility of losing their citizenship, being declared illegal immigrants, and facing deportation or detention. The exclusion of such a large number of people also raised concerns about the fairness and transparency of the NRC process, with critics arguing that many genuine residents were being unfairly penalized.

It is in this context that the Supreme Court's recent rulings reaffirming the March 25, 1971, cutoff date take on added significance. The Court's judgments have essentially upheld the provisions of the Assam Accord, confirming that those who entered Assam after this date cannot claim citizenship. While this ruling has brought some clarity to the legal framework surrounding citizenship in Assam, it has also reignited debates about the fairness of the cutoff date and the humanitarian consequences of denying citizenship to people who may have lived in Assam for decades.

The Supreme Court's judgments underscore the delicate balance that must be struck between preserving the cultural and political identity of Assam and upholding the rights of individuals who find themselves stateless. The Court's decision to uphold the March 25, 1971, cutoff date has been hailed by some as a victory for the indigenous Assamese people, who have long feared being outnumbered and politically marginalized. However, for others, particularly those who have been excluded from the NRC, the ruling has raised concerns about the potential for human rights abuses and the creation of a large stateless population.

March 25, 1971, remains a contentious date not just because of its legal implications but because gage it carries. For many Assamese, it is a date that identity in the face of overwhelming demographic changes. For others, it represents an arbitrary line drawn in the sand, one that has the potential to create a humanitarian crisis by denying citizenship to people who have lived in Assam for decades but cannot prove their presence before the cutoff date.

The debate over March 25, 1971, also reflects larger questions about citizenship, migration, and national identity in India. Assam's struggle to balance its cultural identity with the realities of migration is not unique; similar debates are playing out in other parts of India and around the world. The question of who belongs and who does not, of who has the right to citizenship and who is considered an outsider, is one that cuts to the heart of modern nation-states.

As Assam moves forward, the legacy of March 25, 1971, will continue to shape the state's political and social landscape. The challenge for policymakers and citizens alike is to find a way to balance the need to preserve Assam's unique cultural identity with the imperative to respect the rights of all residents, regardless of their origin. The NRC process, while flawed, represents an attempt to address these competing concerns, but it is clear that the debate is far from over.

Ultimately, the significance of March 25, 1971, lies not just in its legal standing as the cutoff date for citizenship in Assam, but in its role as a symbol of the state's ongoing struggle to define its identity in a rapidly changing world. For the indigenous Assamese, this date is a reminder of their long fight to protect their culture and heritage. For others, it represents the complexities and challenges of migration, citizenship, and belonging in a world where borders and identities are increasingly fluid. Israel says it has killed Hamas leader Yahya Sinwar in Gaza

JERUSALEM, Oct 18: Israeli forces in Gaza killed Hamas leader Yahva Sinwar, a chief architect of last year's attack on Israel that sparked the war, the military said on Thursday. Troops appeared to have run across him unknowingly in a battle, only to discover afterwards that a body in the rubble was Israel's most-wanted man.

Israeli leaders celebrated his killing as a settling of scores just over a year after Hamas-led militants killed some 1,200 people in Israel and kidnapped 250 others in an attack that stunned the country. They also presented it as a turning point in the campaign to destroy Hamas, urging the group to surrender and release some 100 hostages still in Gaza.

"Hamas will no longer rule Gaza. This is the start of the day after Hamas," Prime Minister Benjamin Netanyahu said.

U.S. officials expressed hopes for a cease-fire with Sinwar out of the picture. But eliminating him may not end the devastating war, during which Israel has destroyed much of the Gaza Strip and killed more than 42,000 Palestinians. The Gaza Health Ministry does not distinguish between civilians and combatants but says more than half of those killed were women and children.

Sinwar's death is a crippling blow to Hamas, but the group, which receives support from Iran, has proven resilient to past losses of leaders. There was no

Hamas of Sinwar's death.

Netanyahu has said Israel will keep fighting until all the hostages are free, and that it will keep control over Gaza long enough to ensure Hamas does not rearm - an effective occupation that raises the possibility of months or even years of continued fighting.

Earlier this month Israel opened a new front in its war with Hezbollah, stepping up bombardment in Lebanon and launching a ground campaign against the Iran-backed militia after a year of trading cross-border fire. In his speech about Sinwar's death, Netanyahu said, "Our war is not yet ended."

President Joe Biden said Sinwar's death opens the way for "a political settlement that provides a better future for Israelis and Palestinians alike." He said he would talk with Netanyahu "to discuss the pathway for bringing the hostages home to their families, and for ending this war once and for all."

Sinwar has been Hamas' leader inside the Gaza Strip for vears. He was elevated to the group's top leadership position in July after his predecessor, Ismail Haniyeh, was killed in an apparent Israeli strike in the Iranian capital. Tehran

The military then fired an additional shell at the building, causing it to collapse and killing Sinwar, Hagari said. He said Sinwar was found with a bulletproof vest, grenades, and 40,000 shekels (\$10,707)

Hundreds of people demonstrated in Tel Aviv on Thursday night for the release of the hostages after news of Sinwar's death emerged. Some carried signs that read "Sinwar's end, end the war."

Ifat Kalderon, whose cousin, Ofer Kalderon, is being held hostage in Gaza, said he was happy that Sinwar was dead but 'scared about the 101 hostages. They might murder them or do something because of the murder of Sinwar.'

In the central Gaza town of Deir al-Balah, one Palestinian woman displaced from her home in the north said she hoped Sinwar's death would bring an end to Israel's campaign. "What more goals do they have than that? Enough. We want to go back," said the woman, Umm Mohammed.

Some praised Sinwar as a symbol of resistance against Israel's decadeslong occupation of the Palestinians in the West Bank. Ahmed Hamdouna, who also fled his home in northern Gaza, said Hamas would be able to replace him. "After the leader, a thousand leaders will come. After the man, a thousand men will come," he said.

For more than a week. Israeli forces have been waging a ground campaign in Jabaliya refugee camp in northern Gaza, saying they are battling Hamas fighters who have once again regrouped there.

On Thursday, an Israeli strike hit a school sheltering displaced Palestinians in Jabaliya, killing at least 28 people, according to Gaza's Health Ministry. Fares Abu Hamza, head of the Gaza Health Ministry's emergency unit in the north, said the dead included a woman and four chil-

The Israeli military said it targeted a command center run by Hamas and Islamic Jihad inside the school. It provided a list of around a dozen names of people it identified as militants who were present when the strike was called in. It was not immediately possible to verify the names.

Israel has repeatedly struck tent camps and schools sheltering displaced people in Gaza. The Israeli military says it carries out precise strikes on militants and tries to avoid harming civilians, but its strikes often kill women and children. (AP)

UK Foreign Secy Lammy says engagement with China necessary

BEIJING, Oct 18: Britain's foreign secretary has called engagement with China "pragmatic and necessary" as he makes he makes the first visit by a Cabinet minister since the Labor government took control in July.

David Lammy met Friday with Vice Premier Ding Xuexiang and was to hold talks with Foreign Minister Wang Yi later the same day.

His two-day trip is an attempt to reset ties with Beijing after relations turned frosty in recent years over spying allegations, China's support for Russia in the Ukraine war and a crackdown on civil liberties in Hong Kong, a former British colony now part of China.

"From stopping Russia's illegal invasion of Ukraine, to supporting a global green transition, we must speak often and candidly across both areas of contention as well as areas for cooperation in the U.K.'s national interest.' Lammy was quoted as saying in a Foreign Office news release.

The release said that Lammy would urge China to stop its political and economic support of the Russian war effort.

The U.S. sanctioned two Chinese companies on Thursday for allegedly helping Russia build long-range attack drones used in the war in Ukraine. The Chinese Embassy in Washington said the allegations were false.

Lammy will also visit Shanghai, where he will meet with British business leaders, the Foreign Office release said. China including Hong Kong is the UK's fourth largest trading

Pak's Punjab province shuts schools for 2 days to contain protests over alleged on-campus rape

LAHORE, Oct 18: Authorities in Pakistan's eastern Punjab province shut all schools and universities for two days on Friday in an attempt to contain the spread of protests by students over an alleged on-campus rape.

The closures in Pakistan's most populous province affect an estimated 18 million students. Tensions have been high on college campuses since reports of the alleged rape in the eastern city of Lahore spread on social media, and protests have broken out in four cities. In Gujrat in Punjab province, a security guard died in clashes between student protesters and police on Wednesday.

Police arrested a person in connection with the death. The government and police have denied that any rape occurred on a campus of the private Punjab Group of Colleges in Lahore, the capital of Punjab. They are seeking the arrest of nearly three dozen people, including several journalists, saying they spread misinformation on social media that led to the protests.

Students, however, announced they would hold a rally later Friday to demand justice for the alleged victim in the northwestern Khyber Pakhtunkhwa province bordering Afghanistan.

The decision to shut all schools in Punjab came a day after hundreds of students ransacked a college building in the garrison city of Rawalpindi. Police fired tear gas and charged at the students, arresting more than 250 people. The protests appear to have begun sponta-

neously, as student unions have been banned in Pakistan since 1984. There are no organizations representing students, although political parties' youth wings exist.

Separately, the political party of imprisoned former Prime Minister Imran Khan announced it will hold protests across the country on Friday to oppose any amendments to the country's Con-

Khan's supporters say Prime Minister Shehbaz Sharif, who replaced Khan after his ouster in 2022 in a no-confidence vote in parliament. wants to appoint judges of his own choosing and set up a new constitutional court in parallel with the Supreme Court. The government denies the allegations.

Sexual violence against women is common in Pakistan but is underreported because of stigma in the conservative country. Protests about the issue have been rare. (AP)

SINGAPORE, Oct 18: Singapore has detained a 17-year-old self-radicalised supporter of terror group ISIS under the Internal Security Act (ISA) mere weeks before his planned attack on non-Muslim males in a public housing estate.

The teenager, purportedly influenced by the ongoing Hamas strikes and developments around Syria, wanted to use either a kitchen knife or a pair of scissors from his home as his weapon, said the Internal Security Department (ISD) in a press release on Friday.

It was a "very close shave as he could have easily gone on a rampage", Singapore's Minister for Law and Home Affairs K Shanmugam said.

"I would say this is one of the ones where it was quite close, fairly close," Shanmugam said on the duration between the teen's arrest and

Shanmugam pointed out that the area that the teen had intended for the attack was frequented by "thousands of people" every day, including senior citizens and young children, and that it would be even more crowded during the school holidays being a main housing estate area with shopping malls and

leisure facilities Since 2020, the ISD has detained five self-radicalised youths who wanted to carry out attacks in Singapore using such easily accessible weapons. Such attacks require little time and preparation to execute,

said the department. In this particular case, the youth was determined to follow through with his plan and was less than a month away from executing it at the time of his arrest in August, it added. (PTI)

KATHMANDU, Oct 18: A British mountaineer who set the record as the youngest female to climb all the 14 tallest mountains in the world said on Thursday that inexperienced climbers should not be allowed to climb the highest peaks because they run the risk of endangering their lives and

Adriana Brownlee, 23, climbed Mount Everest at 20 in 2021 and earlier this month climbed Mount Shishapangma in China, completing her endeavor to scale all 14 peaks over 8,000 meters (26,247 feet)

She said she has seen numerous climbers who lack training in basic skills and in coping with the unpredictable slopes of the high peaks.

"I have seen many examples

of people in the mountains that

should not really be there, that

should have more training beforehand," Brownlee told The Associated Press on Thursday in Nepal's capital, Kathmandu. "We have had to support them and have had to help with like small things like how to put on crampons, how to put on har-

She said mountaineering authorities should ensure that climbers attempting to scale the highest peaks have at least climbed smaller mountains to ensure they can handle the altitude and have the proper skills.

Brownlee flew to Nepal this week alongside other climbers from Tibet including Nima Rinji Sherpa, who at age 18 is now the youngest person to climb the 14 peaks.

There are generally no rules besides age restrictions on people who want to climb mountains as long as they are able to pay their permit fees. In Nepal,



climbers need to be at least 16 years old. Brownlee said she was just 8

years old when she began dreaming of becoming a mountaineer like her father, who she said was her main inspiration. She said she now wants to

scale unclimbed peaks in Nepal and explore mountains in other parts of the world. Brownlee and her partner have opened a mountaineering company in Nepal focusing on

skilled and experienced enough to handle the harsh condition of the mountains.

She said she hopes to inspire other young people to pursue their dreams "For me the message is that

in life ... you can take any path you like to reach your goal," she said. "That goal might be totally unique to you and it's very important to keep at that and not to listen to rest of society what they have to say." helping customers who are

No resolution on Article 370, scaling down on J-K's statehood demand huge setback: PDP

SRINAGAR, Oct 18: People's Democratic Party (PDP) on Friday said Jammu and Kashmir government's first reported resolution demanding restoration of statehood and not Article 370, was a "huge setback" and nothing less than the ratification of the Centre's 2019

Another political party, the People's Conference, has also questioned the secrecy over the resolution.

The reactions came after a Jammu-based newspaper 'Daily Excelsior' carried a report that the cabinet had passed a resolution urging the Centre to restore J-K's statehood. stated, provides for free treatment to road accident victims in any hospital, including private ones.

According to Kejriwal, the scheme saved 26,000 lives before it was stalled. "We saved many lives through this scheme, and we will ensure it continues to serve Delhi's citizens," he said.

NHRC chief invokes Sandeshkhali case at foundation day event

NEW DELHI, Oct 18: NHRC's acting Chairperson Vijaya Bharathi Sayani on Friday invoked the case of alleged sexharassment of women at Sandeshkhali in West Bengal, as she recalled some of the strong words the rights panel used in its scathing report after its on-spot inquiry into the matter.

She made the remarks while addressing an event to mark the 31st anniversary of the National Human Rights Commission (NHRC) at the Vigyan Bhawan here with Vice President Jagdeep Dhankhar present on the dais as the chief guest.

"NHRC has addresses a broad spectrum of human rights violations, including custodial deaths, bonded labour, exploitation of marginalised groups and denial of medical care," Sayani said.

She also recalled the case of alleged sexual harassment of women at Sandeshkhali in West Bengal's North 24 Parganas district, and the findings of the NHRC's inquiry report published in April this year.

"Recently, the NHRC responded to grave reports of harassment and sexual ssaults against women at Sandeshkhali in West Bengal. An on-spot inquiry conducted by the NHRC members revealed a climate of fear and intimidation that prevented the victims from seeking justice," Sayani said.

The Sandeshkhali case assumed a political colour and turned into a full-blown controversy earlier this year, as a leader linked to the ruling Trinamool Congress in West Bengal was at the centre of the charges levelled by some of the alleged

In its report that was widely published in the media, the rights panel made the observation that the "atmosphere created due to the atrocities by the alleged accused persons rendered the victims silent", while intimidation and terror made them "reluctant to seek justice".

This "climate of terror" not only "perpetuates the cycle of abuse" but also underscores the urgent need to create a safe and supportive environment for victims to "break free from the shackles of silence", it had observed.

The political face-off over the case between the Trinamool Congress (TMC) and the Bharatiya Janata Party (BJP) also took centre stage in the run-up to the 2024 Lok Sabha elections in West Ben-

On Wednesday, the NHRC said in a statement that since its inception on October 12, 1993, till September 30, 2024, the commission handled 23,05,194 cases, including 2,873 which it took up suo motu, besides recommending the payment of monetary relief to the victims of human rights violations totalling more than Rs 254 crore in 8,731 cases.

Between October 1, 2023, and September 30, 2024, the commission disposed of 68,867 cases and recommended more than Rs 17.88 crore as monetary relief to the victims of rights violations in 404 cases, it added.

Pointing at the numbers, Sayani said that disposing of an "astounding" over 68,000 complaints shows the NHRC's "commitment to justice"

In her address, the NHRC acting chairperson also said that human rights

are the cornerstones of a just society ensuring dignity, freedom, and well-being for all, besides empowering the marginalised to assert their entitlements.

"India's progress as a nation is closely tied to its commitment to human rights, which is deeply embedded in our civilisation and enshrined in our Constitution. As a home to one-sixth of humanity, India is becoming a role model for the world in promoting individual dignity and freedom," she said.

Stating that India's rich cultural tapestry "showcases our strength and diversity", Sayani said, "Respect to individual dignity is central to the Indian ethos rooted in ancient texts such as the Vedas and the Gita.

The NHRC has conducted independent inquires, alongside addressing complaints, while investigating human rights violations in 30 cases over the past year, Sayani added.

The acting chairperson also shared that around the time of its inception in 1993-94, it had received only 496 complaints.

"As we celebrate our achievements, we must remain committed to uplifting the vulnerable groups and prioritising their human rights with compassion for their unique situations," she said.

"Our strength lies in our unity in diversity guided by the 'Manav Dharma', placing humanity at the heart of our mission. The NHRC envisions a society where dignity and rights of every individual are respected, while promoting inclusivity and understanding," Sayani added. (PTI)

Police dog helps recover ₹ 1.07 cr stolen from Gujarat farmer's house

AHMEDABAD, Oct 18: A police dog helped crack a theft case involving ₹ 1.07 crore and led to the arrest of two persons in Gujarat's Ahmedabad district, an official said on Friday

With the help of Penny, a Dobermann, the district police on Thursday apprehended the accused and recovered the entire sum they allegedly stole on October 12, the official said.

As per an official release, the police have arrested Budha Solanki and his accomplice Vikram Solanki, both residents of Saragvala village in Dholka taluka.

A 52-year-old farmer became a millionaire overnight after selling a piece of land near the Lothal archaeological site close to his village, and it fetched him ₹ 1.07 crore, sub-inspector P N Gohil of Koth police station said.

The farmer then went to Tarapur in Anand district on October 12 for some work after locking his house,

"Since the farmer was planning

the proceeds, he stuffed the cash in two plastic bags and kept them inside his dilapidated kutcha house on October 10. On the night of October 12, some persons broke into the house by removing some bricks near the window and decamped with the bags," the official

Gohil said the local police found out about the theft the next day and started questioning 30 suspects and 14 history-sheeters to get some

A dog squad also visited the spot with Penny to trace the route taken by the thieves, he said.

"On Thursday, Penny stopped at a spot some distance away from Budha's house. He was already on our list of suspects because he knew about the cash. When the accused was lined up with other suspects, Penny stopped near him for

a while," he said. Police raided Budha's house and recovered ₹ 53.9 lakh, and during interrogation, he confessed to the theft and the involvement of

Leopard 'suspected' to have turned man-eater shot dead in Udaipur

JAIPUR, Oct 18: A leopard "suspected" to have turned man-eater was shot dead on Friday by a joint team of forest department and police in Rajasthan's Udaipur district, an official said.

In Udaipur district, humans were hunted by leopards on September 18, 19, 20, 25, 28 and 30. In the above incidents, the place of attack by leopard were Gram Panchayat Chhali, Bagdunda, Majavad and Madar under the jurisdiction of Deputy Forest Conservator Udaipur (North).

In a fresh attack on Wednesday, the leopard attacked two women who were working in in the field in Madar village of Badgaon. One of the women, who was seriously injured in the attack, died during treatment.

The leopard which was shot dead in Madar area near the city is said to be involved in these attacks.

Further confirmation will done after the sample test report will come out. Chittora added.

Chief Wildlife Warden PK Upadhyay told PTI that there could be more than one leopard, so it cannot be claimed that this is same leopard that was involved in all the attacks.

He said that there is no relaxation in vigil at the moment and a team from Gujarat was called on Thursday to be in the Madar area for seven days

Samples were collected from the attack that took place on Wednesday and from the leopard that was killed today for DNA sampling test. The final test results will confirm if it was the same animal or not,

Upadhyay said that with the killing of a five-year-old child who died due to



this leopard, the permission that we had issued earlier for shooting has expired and now no one can shoot a leopard.

He noted that the postmortem will be done according to the standard operating procedure (SOP) which is the same for a tiger and a leopard.

The DNA report will take some time to arrive and till then the team will remain deployed in the affected area, he added. Earlier today, Divisional Forest Officer Ajay Chittora had said that the leopard

was an adult male which apparently turned man-eater. Further confirmation will be done after the sample test report will come out, Chit-

tora had said. The woman that was killed on Wednes-

day was the eighth person to die in leopard attack since September 18. Eight victims include four women and leopard attacks in various areas of Udaipur.

Concerned over the leopard attack and growing resentment among the locals, the forest authorities placed cages, installed camera traps and sought help from the Indian Army to track the leopard last month. As a result, three leopards were captured from different places.

However, after a 55-year-old woman was mauled to death on October 1 outside her house in Suawaton ka Gudha when she was feeding fodder to livestock, authorities issued an order to shoot down the animal.

The permission was granted under conditions that an attempt should be made to tranquillise or trap the leopard. However, in case the animal cannot be tranquillised or trapped, its correct identification should be ensured before killing the ani-

The season's first derby, originally scheduled during the Durand Cup in August, was abandoned due to security concerns amid the RG Kar rape-andmurder protests, leaving fans eagerly awaiting for this showdown between the two Kolkata giants. Since that abandonment, fortunes have been rough for East Bengal.

Four consecutive defeats led to the departure of last season's Super Ĉup-winning coach Carles

The Red and Gold Brigade remain the only team without a win in the 13-team standings, adding pressure on Bruzon to steady the ship and deliver results.

On the other hand, Mohun Bagan have displayed their attacking flair but have struggled defensively, conceding seven goals in their first four games.

Currently sitting in fourth place with two wins, one draw, and one loss, they will aim to tighten their defense as they head into this high-stakes derby.

Jose Molina's men will take confidence from their recent 3-0 win over Mohammedan SC, as the coach looks to secure backto-back wins and clean sheets for the first time this season.

For the Mariners, their fortress at the Salt Lake Stadium has seen a flurry of goals.



2024, finding the back of the net at least twice in 11 of those matches. They have scored 29 goals at the Salt Lake Stadium in 2024, the second-highest tally for any team at a single venue in a

calendar year. Their attacking stats are equally impressive this season, averaging 7.3 shots on target per game at a staggering 55.8% shooting accuracy, which is the best in the league.

The Frenchman is also the player with the most successful passes in this region in 2024-25 as he will be key to the red-andgold's attack.

For Mohun Bagan, Dimitri Petratos has five goal contributions against East Bengal in previous derbies. Petratos will once again be the threat for East bengal.

However, he has found the net only once in his last six ISL games and it remains to be seen if East Begngal defence is able to mark him successfully.

MUMBAI, Oct 18: Former India cricketer and NCA head VVS Laxman on Friday praised Rohit Sharma for taking ownership of the wrong call at the toss in the first Test against New Zealand, saying that he does a "phenomenal job" in leading by

Rohit's decision to bat first in the opening Test backfired horribly as India were shot out for a mere 46 inside 32 overs, recording their third lowest total in 593 Tests and lowest-ever in 293 matches on home soil.

The Indian captain fronted the media after end of play on Thursday and acknowledged that he erred in reading the M Chinnaswamy Stadium pitch, while citing that not all calls taken by leadership can always

be right. "For leaders, it's humanly impossible not to make mistakes. We won the toss and we elected to bat first and it was counterproductive (because) we were bowled out for 46," Laxman told a gathering at the Security Now 2024 conference by Se-

clore here.
"Who went to the press conference? It was Rohit Sharma. He accepted that 'yes, I misread the wicket'. Leaders take that ownership of (their) decisions."

"It's not necessary that every time the decisions are right, but you take the ownership and then whenever the team doesn't do well, you go and face the flak. Whenever the team does well, you promote the guy who actually requires that recognition and that limelight," he added.

While citing preparations and having a roadmap as important elements for success, Laxman said great leaders are the best performers in any team and Rohit has done a "phenomenal job" with this Indian team.

"Great leaders are the best performers in a particular team, (a) classical example is Rohit Sharma. What he has done, the way he's leading the Indian team, is just phenomenal," Laxman said.

"He (has) told (his teammates) that, 'okay, this is the style of cricket I want our team



to play', and he's going out and doing that, (the) selfless style of

The recovery was impressive but it could not overshadow what New Zealand accomplished earlier in the

Resuming the day at 180 for three, the Kiwis were halted to an extent by Ravindra Jadeja (3/72) and the other Indian bowlers who took some early wickets to reduce them to 233 for seven.

They lost Daryl Mitchell, Glenn

Ravindra started cautiously but unfurled his full range once he and the pitch settled down past the firsthour mark.



Cameron Green's absence will change Australia's bowling dynamics, says Mitchell Starc



SYDNEY, Oct 18:The absence of allrounder Cameron Green will change Australia's bowling dynamics for the upcoming five-Test Border-Gavaskar Trophy and may increase spinner Nathan Lyon's workload, according to star pacer Mitchell Starc.

Green will undergo surgery to address his back-related troubles which will keep him out of action for at least six

While Australia have another all-round option in Mitchell Marsh ready to share the workload, Starc admitted that Green's unavailability changes the equation.

"It will always change the dynamic when you take a genuine allrounder like a Cameron Green, or with England when you take a Ben Stokes, out," Starc was quoted as saying by ESPNCricinfo.

"When you have that genuine allrounder who has been part of a group for a while ... you get into a bit of a routine of having that extra bowling op-

namic of that line-up is going to be, there is a lot of talk around that opening spot and Mitch (Marsh) bowling as well," he said.

Starc said the issue isn't something which Australia have not dealt before.

wickets on Day 3. The BCCI Medical Team is monitoring his progress," the statement said. Pant was hit on his right knee in

the 37th over of New Zealand's innings when a delivery from Ravindra Jadeja spun sharply inwards and hit his right knee with Devon Conway at the strike. The wicketkeeper-batter had to

leave the field and captain Rohit Sharma informed after the end of play that there was some swelling

and the team did not want to take any risks. He was replaced by Dhruv Jurel for the remainder of the play.

Pant had undergone multiple surgeries on the right knee after that horrific car accident in December

"Unfortunately, the ball hit straight on his knee cap, the same leg which he has done a surgery. So, he has got a little bit of swelling on it and the muscles are quite tender at this point of time," Rohit told media on Thurs-

"It is a precautionary measure. We do not want to take a risk. Rishabh does not want to take a risk because he has gone through a massive surgery on that particular leg," he said.

Former Fulham women's captain Ronnie Gibbons says she was groped by Mohamed Al Fayed at Harrods

LONDON, Oct 18: The former captain of Fulham's women's team. Ronnie Gibbons, says she was sexually assaulted on two occasions by the late Mohamed Al Fayed when he owned the club.

Speaking to The Athletic, Gibbons said in a

story published Friday that the former Harrods owner tried to "forcefully" kiss her and groped her at his department store in 2000 when she was 20. "The club is profoundly troubled to learn of the experiences told today by former Women's Team

captain, Ronnie Gibbons," Fulham said in a statement. "She has our deepest empathy and support." Earlier this month, police in London said that 40 women have made allegations of rape or sexual assault against Al Fayed since the BBC broadcast claims by several former Harrods employees.

They are in addition to the 21 women who went to the police between 2005 and 2023 with sex crime allegations against the businessman. He was never prosecuted and died last year aged 94.



"We continue to stress our absolute condemnation of abuse in all forms," Fulham said, "We remain in the process of establishing whether anyone at the club is or would have been impacted by Mohamed Al Fayed in any manner as described in recent reports.

Al Fayed owned Fulham between 1997 and 2013. Gibbons told The Athletic she was twice summoned to Al Fayed's office above Harrods on the pretext that she would speak about soccer to his children, who were not there when she showed

She said that Al Fayed made her sit on his lap, stroked her knee and forcefully kissed her on the lips as she tried to go away during her first visit. "I just remember feeling sick, just really phys-

ically feeling sick, when I left there," she recalled. When she was asked to return to Harrods, she said that he kissed and then groped her, running his hand down from her face to her waist. "Speaking my truth and finally telling my story

will hopefully help me heal and be rid of the shame, embarrassment and pain I have carried for years," said Gibbons, who played for Ireland at international level.

"If this can help one person open up and realise it's not your fault and be free of the same burdens, then I'll be happy." (AP)
