GUWAHATI, Oct 24: Two days after the resignation of state Congress chief Bhupen Kumar Borah as the president of the united opposition forum in Assam over differences in seat sharing for by-polls, the alliance on Thursday named Ajit Kumar Bhuyan as its new head.

The Asom Sonmilito Morcha (ASOM) also resolved to move forward even without the Congress, which had been at the forefront in forming the conglomerate of anti-BJP forces ahead of the last Lok Sabha elections.

ASOM general secretary Lurinjyoti Gogoi, addressing a press conference after an emergent meeting of the alliance here, said, "It has been decided that Rajya Sabha MP and Anchalik Gana Morcha chief Ajit Kumar Bhuyan will be the president of ASOM."

Jones Ingti Kathar and Suprakash Talukdar have been named as working presidents, he

However, no candidate has filed nominations for 77 Behali Assembly Constituency on Thursday. "With these nominations, the total number of nominations filed have reached to 14. The deadline for submission of nominations for the Bye-Election is October 25," the statement concluded.

rav Bhatia also alleged discrepancies in the declaration of assets in Congress general secretary Priyanka Gandhi's poll affidavit.

Addressing a press conference at the Bharatiya Janata Party (BJP) headquarters here, he accused the Gandhi family of "insulting" Congress president Mallikarjun Kharge, a Dalit, by not allowing him to accompany Priyanka Gandhi to the returning officer's office for filing her nomination

"It is a victory of the Gandhi family's corruption and dynastic politics and defeat of merit," Bhatia said, slamming the Congress over Priyanka Gandhi's nomination for the Wayanad Lok Sabha bypoll in

Kerala. Bhatia claimed that the assets declared by Priyanka Gandhi in her poll affidavit are way below the

assets she and her husband Robert Vadra possess. "The assets of Robert Vadra declared in the poll affidavit are lower than the income-tax department's demand.... The total demand raised by the income-tax department is ₹ 75 crore," he said, alleging that Priyanka Gandhi's poll affidavit is a confession of corruption committed

by the Gandhi family and Vadra. She has also shown the value of her house in Shimla much lower than what it is, Bhatia alleged. Gandhi on Wednesday filed the nomination for her maiden electoral

battle from Wayanad. In her affidavit filed for the bypoll, she has declared assets worth more than ₹ 12 crore, including a₹ 5.63-crore house in Shimla The Congress candidate has also

declared that her husband, Vadra, has movable assets worth more than ₹ 37.9 crore and immovable assets worth over ₹27.64 crore.

According to her declaration, she had a total income of more than ₹ 46.39 lakh in the 2023-2024 financial year, including rental income and interest from banks and other investments.

Bhatia claimed that there are certain restrictions on buying property in Himachal Pradesh but the rules were bent for the Gandhi family to enable them to get a house in Shimla.

"These are people with SUVs and farmhouses, big vehicles and big bungalows But they do not disclose the correct value of their assets," the BJP leader said.

GUWAHATI, Oct 24: The Aam Aadmi Party (AAP) on Thursday announced that it will contest two seats in the November 13 bypolls in Assam, naming its candidates for Behali and Samaguri constituencies.

Bypolls will be held in Dholai (SC), Sidli (ST), and Bongaigaon, besides Behali and Samaguri. The bypolls were necessitated following the election of the sitting MLAs to the Lok Sabha earlier this year. AAP's Northeast coordinator Rajesh Sharma and state president Manoj Dhanowar, addressing a press meet here, said that party candidates for Behali and Samaguri are Ananta Gogoi and Nurul Amin Choudhury respectively.

Both of them will file their nominations on Friday, the last day for doing so, they added. AAP is contesting the (CONTD. ON PAGE-2)

'Tobacco Free India' initiative garners 65,000 responses Majority in survey support smoke-free public places in India

NEW DELHI, Oct 24: Nearly 93 per cent of respondents in a survey have favoured making public spaces completely smoke-free while 97 per cent have pitched for declaring airports completely smoke-free, similar to railway stations.

A recent poll conducted by the citizen-led initiative "Tobacco Free India", which garnered more than 65,000 responses, highlights the growing concern among Indians about the harmful effects of secondhand smoke.

The survey has revealed that an astounding 92.72 per cent of respondents are in favour of making public spaces completely smokefree.

Conducted in both Hindi and English, the poll included six key questions about smoke-free public



ports. "While the Cigarettes and places and the health risks associ-Other Tobacco Products Act ated with second-hand smoke. Across all questions, the majority (COTPA), 2003 bans smoking in public places, it still permits desigsupported stricter measures to protect women, children and other vulnated smoking areas in airports, honerable groups from exposure to tels with 30 or more rooms and toxic tobacco smoke in public areas, restaurants with seating capacities such as restaurants, hotels and airabove 30," said Dr Uma Kumar,

head of the rheumatology department at the All India Institute of Medical Sciences (AIIMS) here.

"This situation continues to pose a significant public health threat. Scientific evidence has unequivocally demonstrated that secondhand smoke can easily penetrate these designated areas, exposing non-smokers to harmful toxins and increasing their risk of various diseases," she said.

The poll was conducted between October 2 and October 19 on X, involving 65,272 participants.

While India has made significant strides in tobacco control -- strictly prohibiting smoking on trains, platforms, and station premises as well as banning the carrying or sale of tobacco products in railway campuses -- the (CONTD. ON PAGE-2)

Implementation measures should be aligned with national priorities: India at COP16

NEW DELHI, Oct 24: At the ongoing UN Biodiversity Conference, India has emphasised that implementation measures should be aligned with national priorities, according to a think-tank present at the UN COP16 summit negotiations.

Speaking during the discussions on the Cartagena Protocol on Biosafety, Indian delegates underscored that assessments related to socio-economic factors must not be conflated with biosafety measures, according to the Earth Negotiations Bulletin issued by the think-tank International Institute for Sustainable

"India underscored the need to distinguish assessment of socio-economic considerations from biosafety risk assessment," it said.

In addressing socio-economic considerations, the Indian representatives noted the need for a more robust framework that prioritises national interests while fostering ca-



pacity-building initiatives. "India emphasised that imple-

mentation measures should be aligned with national priorities," the bulletin said.

The conference, which started on Wednesday, continued its negotiations with multiple working groups tackling various aspects of biodiversity and its interconnections with climate change, health and sustainable

development. Working Group II wrapped up the first reading of all 26 agenda items, paving the way for detailed deliberations on conference room papers (CRPs).

The emphasis on regional contexts was echoed in discussions on marine, coastal and island biodiversity, where the delegates agreed that further efforts must correspond to individual (CONTD. ON PAGE-2)

Nvidia, Reliance to build AI computing infra in India

MUMBAI, Oct 24: Nvidia Corp has struck a deal with billionaire Mukesh Ambani's conglomerate Reliance Industries to build out an artificial intelligence (AI) computing infrastructure as well as an innovation centre in India, the AI chip giant's CEO Jensen Huang said on Thursday.

A new major data centre by Reliance Industries will use the latest Nvidia's Blackwell AI chips.

The diversified Indian conglomerate will be creating applications as part of the partnership and selling it to consumers, said Huang, who is on a two-day visit to the financial capital.

Nvidia already has a presence in six locations across India. The US firm works with enterprises, cloud providers and startups to build AI infrastructure powered by Nvidia's accelerated computing stack comprising tens of thousands of its most advanced GPUs, high-performance networking, and AI software platforms and tools.

At the Nvidia AI Summit 2024 here, Ambani and Huang had a fireside chat to discuss India's transformative potential in AI and its emerging role as a global leader in this field.

The partnership between Reliance and Nvidia aims to build a robust AI infrastructure in the country, which Ambani believes will not only enhance local capabilities but also position India as a significant player in the global intelligence market.

"India will start with the absolutely best that Nvidia has," Ambani said

Huang, during a press conference, told reporters here that the partnership also includes creating applications that Reliance could offer to consumers in India.

"We will also have an innovation centre as part of the tie-up," he said.

Without giving details on the partnership, like investments or the infrastructure capacities to be cre-

ated, Huang said the partnership entails a "fairly large scale" deployment of infrastructure for AI computing

"India is already world class in designing chips, Nvidia's are designed here in Bengaluru, Hyderabad, Pune. A third of Nvidia is Indian, may be more," Huang said.

During the fireside chat, Ambani said India is on the brink of a new intelligence age and will surprise the world with its achievements in intelligence technology over the coming years.

New technologies like AI and the aspirations of people are driving the Indian economy, he said.

"We are at the doorsteps of the new intelligence age. India will be one of the biggest intelligence markets. It's not just our aspiration, but also the raw gene power which will help drive intelligence.

"India will not just deliver CEOs to world, but also AI services," Ambani asserted

Ambani also pitched for using Meta's open source Lama as the base model in India before the country develops its own model. Announcing that India will start

with the "absolutely best" that Nvidia has, Ambani said RIL is setting up a 1GW capacity in Jamnagar which can be expanded further as well.

He noted that apart from the United States and China, India

boasts one of the best digital connectivity infrastructures, with extensive networks of 4G, 5G, and broadband services. He said Reliance Jio is the largest data company globally, pointing out that it

delivers data at a low cost of 15 cents per GB, compared to USD 5 per GB in the US. "Like we did with data, in few years from now we can surprise

the world with what Indians can achieve in intelligence," he said. Meanwhile, the visiting CEO of the world's second most valuable company suggested India -- which has for long been a software services developing powerhouse -- to

transform itself into a AI-exporting geography using the same talent that has made it the world's IT back office. "you have the critical ingredients here in your country to be able

to harvest the raw data, transform it into intelligence. You can code it into a model and manufacture your own digital intelligence and export that," Huang told reporters. Huang, who is widely credited

for seeing the future and pivoting his company to take advantage of the AI revolution, stressed on India doing this urgently given the capabilities it has and added that he can't wait to see India manufacture

'AI at scale". He seemed to advise Indian companies to prioritise AI over chip manufacturing as well,

which has seen some activity with investments announced lately.

"Before you follow other countries into manufacturing, India should jump into this future AI factory. ...there's a new manufacturing industry, don't wait to jump into this one. Don't enter this 20 years later. Enter this one at ground zero," Huang said. Huang said a third of Nvidia's employee base is in India, which includes engineering teams in Pune, Gurugram and Hyderabad, helping companywide efforts at chip design, pointing that India is already home to a lot of intellectual capital

Recalling a meeting with Narendra Modi, Huang said the Indian Prime Minister told him that India shouldn't export data and import intelligence in return which is akin to exporting flour to import bread. Huang said there is a need for putting up the energy-guzzling data centres not in or near Mumbai -- which is home to over 40 per cent of India's capacity -- but in places where there is excess en-

The CEO also said that during a visit six years ago, Modi had asked Huang to speak on AI to his cabinet colleagues on AI which was rare for a world leader.

Huang said deepening broadband services can help India up the gaming consumption.

Speaking at the Summit, the Nvidia CEO also said India will see 20 times growth in computing capacities in 2024 and the country will soon be exporting impactful AI solutions.

Huang further emphasised Nvidia's commitment to expanding its ecosystem in India.

"India is very, very dear to the world's computer industry, central to the IT industry, at the centre and core of the IT of just about every single company in the world.

"Nvidia's ecosystem in India is very rich; 2024 will see a a 20 times growth in compute capacities in India," he said. (PTI)

The state Congress chief had on Tuesday night resigned as the president of ASOM expressing "tremendous pressure" after the Congress high command "refused to accept the united opposition partner CPIL(ML) Liberation's nominee. Bypoll will take place on November 13 in Dholai (SC), Sidli (ST), Bongaigaon, Behali and Samaguri assembly constituencies as these seats fell vacant with the representatives of these constituencies winning the recent Lok Sabha elections. that if elections are held today, he may find it very difficult to come back to power," Verma said.

"But these are just surveys, and we know opinion polls hold good at times, while not so good at other times. So, what happens to Canada will be decided by Canadians during the elections, I will not like to go there, not like to comment," he added. Verma said his analysis is that most of the anti-India activities out of Canada are only for domestic political gains. He said there is a specific campaign by Khalistanis to defame India.

"But, I won't blame entire Canada for that. Canadians are good friends, they are objective people, very polite, and very welcoming. So, Canada as a country is a beautiful place to be, but I will not be able to say the same for the Khalistani terrorists and extremists in Canada and their political backers," Verma said.

In an unexpected downturn of relations, Verma was declared a "person of interest" by Canada on October 13 in its investigation into the June 2023 killing of Hardeep Singh Nijjar, a Canadian citizen who has been declared a Khalistani terrorist by India. Before Canada could take further action, New Delhi recalled Verma and five other diplomats, who were also similarly named. Verma, an Indian Institute of Technology graduate and a

nuclear scientist has previously served as India's ambassador to Japan and Sudan. (PTI) Modi, Xi carries 'great

deadly military clash in 2020. Asked about a Chinese official media report stating that "Modi made suggestions on improving and developing the relationship, which Xi agreed to in principle", Lin said, "both sides were of the view that this meeting is constructive and carries great significance"

"They agreed to view and handle China-India relations from a strategic height and long-term perspective, prevent specific disagreements from affecting the overall relationship, and contribute to maintaining regional and global peace and prosperity and to advancing multiplicity in the world," he said.

The two sides agreed to strengthen communication and cooperation, enhancing strategic mutual trust by holding talks between their foreign ministers and officials at various levels to bring the relationship back to steady development at an early date, he added.

The two leaders also have agreed to "make good use of the Special Representatives mechanism on the China-India boundary question, ensure peace and tranquillity in the border areas, find a fair and reasonable settlement, step up communication and cooperation in multilateral fora, and safeguard the common interests of developing countries," the spokesperson said.

The special representatives mechanism, currently headed by National Security Advisor Ajit Doval and Chinese foreign minister Wang Yi, played a key role in the past to develop and improve the relations since it was set up in 2003 with 22 meetings to address the boundary question.

The last meeting between Doval and Wang under the mechanism was held in 2019.

Relations between the two countries nosedived after the May 2020 incursion by the Chinese military in eastern Ladakh in which the People Liberation Army (PLA) moved a large number of troops exercising in the vicinity of the LAC, which was followed by the fierce clash in the Galwan Valley that marked the most serious military conflict between the two sides in decades.

On Monday, India and China firmed up an agreement on patrolling and disengagement of troops along the LAC in eastern Ladakh, in a major breakthrough to end the over four-year standoff. On the meeting between the two leaders, foreign secretary Vikram Misri, at a media briefing at Kazan, said that both Modi and Xi stressed that India and China can have a "peaceful, stable and beneficial bilateral relationship" with maturity and wisdom, and by showing mutual respect for each other's sensitivities, interests, concerns and aspirations. Referring to New Delhi's consistent position on the eastern Ladakh row, Misri said restoration of peace and tranquillity in the border areas will create space for returning towards the path of normalisation of bilateral relations between the two sides. In the coming weeks and months, both the countries are expected to revive the

In a lacklustre trade, the BSE Sensex slipped 16.82 points or 0.02 per cent to settle at 80,065.16. During the day, the benchmark hit a high of 80,259.82 and a low of 79,813.02, gyrating 446.8 points.

The NSE Nifty skidded 36.10 points or 0.15 per cent to 24,399.40 in a volatile trade.

From the 30 Sensex pack, Hindustan Unilever fell by nearly 6 per cent after the FMCG major reported a 2.33 per cent decline in consolidated net profit at ₹ 2,595 crore for the second quarter ended in September 2024 impacted by moderation in demand from the urban market.

These products, which include chewing tobacco, gutkha and pan masala, pose serious health risks and contribute to a range of diseases, including oral cancer, heart diseases and digestive disorders. India-China Agreement: A step towards stability

Tn a significant diplomatic breakthrough, the Indian government announced on October 21 that an agreement has been reached with China on patrolling arrangements along the Line of Actual Control (LAC). This development offers hope for the normalization of relations between the two neighbors, whose ties have been strained since the deadly border clashes in Galwan Valley in 2020. The conflict in 2020 marked a serious low in India-China relations. Both nations, however, acted swiftly to prevent the escalation from leading to a fullscale war. Since then, diplomatic efforts have been persistent, with 31 rounds of talks at both military and diplomatic levels. The Corps Commanders from both sides led the military discussions, while diplomatic talks were held under the framework of the Working Mechanism for Consultation and Coordination (WMCC) on India-China Border Affairs. The process recently gained momentum due to political intervention. Prime Minister Narendra Modi, recognizing the strategic importance of a peaceful relationship, said earlier this year that stable ties with China are critical not just for India and China but for the wider region and the world. Key meetings, such as those between External Affairs Minister S. Jaishankar and his Chinese counterpart Wang Yi, as well as between National Security Adviser Ajit Doval and Wang Yi in St. Petersburg, helped solidify the path to reconciliation. As Jaishankar aptly described, the current agreement is the result of "patient and persevering diplomacy."

From an economic perspective, the restoration of ties between the two nations is not only welcome but necessary. China remains India's top source of imports, with \$56.29 billion in inbound shipments during the first half of this fiscal year. In a globalized economy, enhancing economic cooperation with China could be a game-changer for industries such as electric vehicles (EVs), smartphones, solar panels, and pharmaceuticals-sectors identified by the Indian government to transform the country into a manufacturing hub. However, the negative stance towards Chinese investments, such as the rejection of a \$1 billion joint venture proposal from BYD (the world's largest electric vehicle manufacturer), reflects a short-sighted approach. Restoring economic ties with China would allow India to access the latest technologies and strengthen its production capacities. The rapidly shifting geopolitical landscape also calls for a reevaluation of India's foreign policy priorities. The ongoing conflict in Ukraine, Israeli aggression in Gaza, and other global tensions have disrupted supply chains and trade routes, challenging established international alliances. In this context, BRICS+ has emerged as a powerful alternative to Westerndominated groupings. With major regional players like Saudi Arabia and Iran recently joining BRICS+, it is vital for India to maintain strong ties with key members of this bloc, including China. An antagonistic stance would leave India isolated at a time when multilateralism is gaining ground. India's recent alignment with the U.S., through defense agreements and intelligence-sharing on the China border, underscores the complexity of the situation. However, the unreliability of U.S. policy, particularly in the face of potential leadership changes, raises concerns

India and China share a 3,400-kilometer border, much of which remains disputed. To ensure long-term stability, both nations must build on past agreements, such as the 1993 Border Peace and Tranquillity Agreement and the 2013 Border Defence Cooperation Agreement. Simultaneously, India must work to expand economic relations and foster people-to-people exchanges. Prioritizing investment in the manufacturing sector, where Chinese technology can play a transformative role, will be essential in boosting India's growth trajectory. This agreement on patrolling may be just one step, but it is a step in the right direction. If nurtured properly, it could lead to a broader reconciliation, benefiting not just India and China, but the entire region in these turbulent times.

Indianising Lady Justice: Symbolism, tradition, and the evolving judicial system

few months ago, Chief Jus-tice of India (CJI) DY A Chandrachud unveiled a statue of Lady Justice in the Supreme Court's Judges' Library, sparking a renewed discourse on the symbolism and evolution of the concept of justice in India. The media, while initially silent on the matter, has recently picked up on this issue, scrutinizing the changes made to the traditional image of Lady Justice. This transformation reflects a larger effort to Indianise the symbolism associated with justice, moving away from the colonial past towards a more localized, contextualized understanding of the judicial process in the country. The inspiration for the Indi-

anised version of Lady Justice is said to have come from a mural on the wall of the Judges' Gallery in the Supreme Court. The mural depicts Lady Justice dressed as an Indian goddess, notably without a blindfold and holding a book, presumably the Constitution of India, in place of the traditional sword. This shift in iconography is significant as it suggests that, in the Indian context, justice is not blind and does not symbolize punishment, but rather represents the principles enshrined in the Constitution

Historical Origins of Lady Justice

The concept of Lady Justice has deep roots in ancient civilizations, long before colonial influences shaped modern legal institutions. The Greeks had Themis, the goddess who represented law, order, and fairness, while the Egyptians worshipped Maat, who embodied truth, balance, and cosmic order. The most direct comparison for the modern depiction of Lady Justice, however, is with the Roman goddess Justitia, who symbolized the moral foundation of the justice sysThe scales she carried represented impartiality, while the sword denoted the power to enforce justice.

Over the centuries, the image of Lady Justice evolved, becoming a universally recognized symbol of legal fairness. Her scales signify the balance of evidence, while the blindfold, which first appeared in the 16th century, traditionally represents the impartiality of the judicial process. The blindfold suggests that justice is administered without prejudice, uninfluenced by wealth, status, or political power.

Indianising Lady Justice: A Step Away from the Colonial Past?

The modification of Lady Justice's design in the new statue has been interpreted by some as an attempt to break free from colonial symbolism. For many, the traditional attributes of Lady Justice her sword, scales, and blindfold are remnants of colonial rule. However, others argue that the changes made to the statue are more nuanced **DEGREE O**

and do not neces-

sarily represent

an outright rejection of colonial legacy.

Lady Justice has always been open to interpretation, with different countries adapting her image to reflect their cultural and legal values. In some places, she is depicted stepping on a snake, representing the triumph of justice over corruption. Despite these regional differences, the core symbolism of Lady Justice - impartiality, fairness, and enforcement of justice - has remained consistent across the globe. In the Indian context, the deci-

sion to remove the blindfold and replace the sword with the Constitution has sparked considerable debate. The removal of the blindfold has been seen as symbolic of a legal system that sees and ad-

dresses the unique circumstances of each case. It suggests that justice in India is not blind but rather aware of the social and economic realities that litigants face. The book, representing the Constitution, emphasizes the role of law in shaping justice in a democratic society.

The Role of the Blindfold in Modern Justice

The blindfold has long been a contentious symbol in the depiction of Lady Justice. Originally, it was introduced as a critique of the judicial system, implying that the law could be ignorant or indifferent to the suffering of innocents. Over time, however, the blindfold came to symbolize the objectivity and impartiality of the law, ensuring that justice is administered without bias.

In India, the Supreme Court has, on occasion, reconsidered the relevance of the blindfold in its jurisprudence. In Zahira Sheikh v. State of Gujarat (2004), a case that arose from the af-

Another major change in the new statue is the replacement of the traditional sword with the Constitution of India. Critics argue that this modification undermines the importance of enforcement in the judicial process. In Indian mythology, deities of justice, such as Shani Dev and Yamaraja, are depicted as carrying weapons to symbolize their authority to punish wrongdoers. The sword in Lady Justice's hand has traditionally represented the power of the court to enforce its decisions, ensuring that

tionable. Justice Krishna Iyer, in the landmark All-India Judges' case (1992), emphasized that law is merely a means to an end, and that end is justice. The sword, therefore, is seen as a necessary tool to ensure that justice is carried out effectively. Without the power to enforce its rulings, critics argue, the judiciary risks becoming a symbolic institution rather than one that can guarantee justice for all.

However, as many legal scholars point out, the concept of Lady Justice predates colonialism by centuries. The Romans, Greeks, and Egyptians all had their own versions of the goddess of justice, long before European colonial powers began shaping legal systems around the world.

The depiction of justice in art has always been fluid, reflecting the values and priorities of the society in which it is displayed. In this sense, the changes to Lady Justice in the Supreme Court can be seen as a natural evolution rather than a radical departure from tradition.

Justice Beyond Symbolism

Ultimately, while the symbolism of Lady Justice is important, justice itself is not dependent on art or statues. As intellectuals and legal experts have noted, the true essence of justice can be seen not in statues but in the experiences of litigants and the peace and order of society. Justice is a living concept, shaped by the actions of courts, the implementation of laws, and the fairness with which decisions are made.

The new statue of Lady Justice in the Supreme Court is a historic art piece that reflects the evolving nature of India's legal system. Whether it represents a break from the colonial past or merely a reinterpretation of universal symbols, its significance lies not in its form but in the ideals it embodies - fairness, impartiality, and the pursuit of justice for all.

As India continues to grapple with issues of law and justice, the role of the judiciary in upholding these principles will remain crucial. Supreme Court judgment on supply of arms to Israel case is flawed

In 2019, M.K. Ranjitsinh Jhala, the renowned wildlife conservationist, joined hands with other conservationists to file a writ petition before the Supreme Court of India (SC) against the government of India regarding the protection of the great Indian bustard. They argued that the overhead transmission lines used for the supply of electricity generated through wind and solar energy resulted in the loss of the population of the great Indian bustard in Gujarat and Rajasthan.

The court ruled in favour of the government (and the companies involved in those projects) by clothing its argument in international law obligations of India. Some aspects The crux of all the arguments is this - Israel's actions in Gaza, since October 2023, might amount to a violation of international law, particularly of international humanitarian law, international criminal law and inter-

national human rights law. As such, any country which contributes weapons to Israel might be an accomplice. The petitioner claimed that supplying weapons to Israel amounts to a violation of India's obligations under international law coupled with Articles 14 and 21 read with Article 51(c) of the Constitution of India. The petition of more than 400 pages was dismissed in a four-page-judgment, the author of which is not mentioned. The judgment found the petition unmaintainable because of Article 73 of the Constitution. secondly, that any injunctive relief would result in violation of international agreements by the Indian companies; and finally, that action, if any, can be taken by the Union government. Let us unpack the reasons one by one.

The court's argument that for it "to consider the grant of the reliefs as sought, it would inevitably become necessary to enter a finding in regard to the allegations which have been levelled by the petitioners against the State of Israel" is grossly wrong.

If nothing else, the court could have looked at the International Court of Justice (ICJ)'s decision in the Application of the Convention on the Prevention and Punishment of the Crime of Genocide in the Gaza Strip (South Africa versus Israel), a copy of which was also included in the petition. In that case. South Africa had requested the ICJ to order Israel, as an interim measure, to fulfil its obligations under the Genocide Convention to "prevent genocide" of Palestinian people in Gaza. In its decision, the ICJ did not necessarily determine that Israel's acts violated the Genocide Convention, as claimed by South Africa, but still ruled that Israel should prevent the commission of genocide in Gaza. The current case before the Supreme Court was not even about the determination of Israel's actions. Rather, it was about India's actions. And yes, to say that India's actions might amount to abetting international crimes means that international crimes are happening.

M.C. Chagla, the resolution asked States to enact legislation for the prevention and punishment of genocide.

To date, there is no legislation on the Genocide Convention in India! When Member of Parliament Avinash Pande asked about this situation in the Parliament in 2016, the Union home ministry replied: "By acceding to the (Genocide) Convention in 1959, India has recognised genocide as an international crime.

"The principles embodied in the convention are part of general international law and therefore already part of the common law of India. The provisions of the Indian Penal Code (IPC), including the procedural law (Criminal Procedure Code or CrPC) provide effective penalties for persons guilty of crime

The Communists of Palestine and Israel have agreed that "Only by establishing a sovereign Palestinian state will there be peace and stability in the region. Stop the war in Gaza and Lebanon now!"

That was the essence of a joint statement issued by the Communist Party of Israel (CPI) and the Palestinian People's Party (PPP) after a meeting of the top leaders of the two organizations last week.

The CPI and the PPP met via Zoom, with guests and solidarity activists from around the world participating in the online meeting. Discussions focused on the dangerous escalation in the region, especially Prime Minister Benjamin Netanyahu's attacks on Lebanon, and the political situation in Palestine and Israel. Adel Amer, CPI General Secretary, and Bassam A-Salhi, PPP General Secretary, led the delegations from their respective parties.

The session was a follow-up on a high-level tripartite leadership meeting held in the city of Ramallah in July between delegations representing the leadership bodies of the CPI, the PPP, and the Democratic Front for Peace and Equality (Hadash), the bloc of progressive parties in the Israeli Knesset.

The meeting reviewed the latest political and battlefield developments, considering the ongoing war and genocide to which the Palestinian people are being subjected, especially in the Gaza Strip. It also discussed ways to en-

hance the struggle and joint action of political organizations in both

Israel and occupied Palestine. Attendees surveyed the most prominent dangers facing the Palestinian cause and the current challenges due to the aggression and policies of the fascist Israeli occupation government and its efforts, together with the U.S. administration, to liquidate the Palestinian cause and rights.

Foremost among them are the right to self-determination, the establishment of an independent state, and the right of return in accordance with international legitimacy resolutions.

The meeting stressed the urgent issues and tasks, prioritizing collective efforts and intensifying the joint struggle to stop Israel's aggressive war and the genocide it is committing. Lifting the siege on the Gaza Strip, opening its crossings, and securing the food, health, and housing needs of its people was identified as an immediate necessity.

The return of the displaced, the complete withdrawal of Israeli forces from the Strip, and the curbing of all its crimes in the occupied Palestinian territories rounded out the list.

The PPP and CPI agreed that the Palestinian people's struggle against the occupation is a national liberation issue, and that true peace can only be achieved by ending the occupation and achieving the freedom and independence of the State of Palestine on all the Palestinian territories occupied in 1967, with East Jerusalem as its capital. (*IPA Service*) of the petition continue to be sub judice. Paragraph 58 from that decision deserves more discussion. In that paragraph, the Supreme Court talked about situations where India has committed to something under international law but has not yet made domestic laws in that regard.

It noted that: "India's international obligations and commitments in the present case have not been enacted in domestic law. Regardless, the court must be alive to these obligations while adjudicating writ petitions that seek reliefs that may hinder these obligations from being fulfilled or otherwise interfere with India's international commitments as well as the right to be free from the adverse effects of climate change." What the court essentially said was that in case of the absence of domestication of India's international law obligations, if a petition requests something that might hinder the performance of such obligations, the court will deny it. This judgment was authored by the Chief Justice of India (CJI) Dr D.Y. Chandrachud, and was written on behalf of his colleagues on the Bench - Justices J.B. Pardiwala and Manoj Misra.

It is the same trio of judges that has now rejected another writ petition seeking directions for the Indian government "to cancel any existing licences and halt the grant of new licences or permissions, to various companies in India, for export of arms and other military equipment to Israel, during Israel's war in Gaza".

In this case, the judges took a different route to achieve the end goal - ensuring that the commercial interest of the government and corporations is not hindered, much like the case referred to above. Whether it is a coincidence that these three judges were on the Bench or are they ones dealing with matters of 'international law' at India's Supreme Court is not clear.

The judges' roster does not include 'international law' as a subject matter for the CJI, and the subject matters of the other two judges are not even listed. Curiously, 'international law' is not a subject matter for any of the judges mentioned in the roster.

On August 17, 2024, a group of former civil servants, scholars, activists and experts in fields such as international relations, human rights and policy analysis filed a writ petition in the Supreme Court demanding the cancellation of licences to companies for exporting arms to Israel. Their arguments rested on a perceived violation of India's international law obligation.

The petition was not novel. Similar arguments have already been made, successful and unsuccessfully, before international courts and domestic courts of other countries.

It notes that "the authority and jurisdiction in relation to the conduct of foreign affairs is vested with the Union government under Article 73 of the Constitution". It further refers to Article 253 to say that only the Parliament has the power to make laws for implementing any treaty. The judgment notes that these two Articles create a 'fundamental objection' to the maintainability of the petition.

This piece argues that the court erred in concluding so. This is because Article 73 is not about 'foreign affairs'. The term does not even appear in the Article. In fact, it is not even a legal term, but rather a term of international relations or diplomacy.

Article 73, for the purpose of the judgment and this piece, states that the "Executive" power of the Union shall extend to the "exercise of such rights, authority and jurisdiction as are exercisable by the government of India by virtue of any treaty on the agreement".

While this Article is relevant to the discussion of the incorporation of international law in India's domestic legal framework, it is not clear how it is relevant to the non-maintainability of the present case.

Further, after quoting Article 253, the court again erroneously interprets it by noting that "(t)here is a presumption that international law is a part and parcel of the law of the nations unless the application of a principle of international law is excluded expressly or by necessary implication by the competent legislature". This is erroneous because the said Article does not provide any room for exception. Its wording is clear - any treaty to which India is a party can only be implemented in India once the Parliament has made a law in that regard.

Sadly, post-Independence, the judges of the Supreme Court of India continued following the British way of incorporation of international law, i.e., what is not opposed is accepted. The court is yet to be decolonised in this regard. Many judgments later, its erroneous interpretation has now become the norm, with support from academicians. After noting Articles 73 and 253 as the

"fundamental objections" to the maintainability of the petition, the judgment pivots towards what it calls "the basic issue".

This issue is "whether the court, under Article 32, can issue a writ to the Union government to cancel existing licences and halt the issuance of new licences for the export of arms and military equipment to Israel?" It then lists out three reasons why the answer to the question, to quote from the judgment, "must be in the negative".

These reasons are, firstly, that any grant of relief will be tantamount to adjudicating on Israel's responsibility for its actions in Gaza;

But the court could have assumed the likelihood of such crimes or should have referred to the plethora of evidence made available to it by the petitioners where international organisations have alleged that such crimes are being committed by Israel.

Instead, the court skirted its way around the question by deferring to the government, the same government whose actions it was supposed to judge. In Paragraph 9 of the judgment, it notes: "In taking an appropriate decision, the Government bears into account all relevant considerations including the commitments of the nation at the international level." This then raises the following questions: did the government assess Israel's actions? And if after the assessment, the answer was that yes, Israel has violated international law, how did the government circumvent that conclusion while issuing licences?

However, if the answer was no, how does that fit in with the government's stance taken at the United Nations during various resolutions regarding the conflict? The approach taken by the Supreme Court must be considered negative for more than one reason. Firstly, now that the petition has been rejected, we do not know if the government actually did an assessment of Israel's actions. What is more frustrating is that the judgment also does not note the government's stance. it simply assumes that the government must have done an assessment. Secondly, because the judgment keeps us in a position of ignorance - we do not know if the assessment, if any, is accurate. After all, the government has often been found lacking on questions of human rights.

Take the Genocide Convention, for example. India was one of the first countries to move a resolution at the UN for a convention on genocide. This was in 1946, even before the country was an independent nation. On India's recommendation, voiced through

of genocide."

There is plenty wrong in this statement, which the author has highlighted elsewhere. For now, suffice it to say that not only does the word 'genocide' not figure in the Bharatiya Nyaya Sanhita (BNS) and the Bharatiya Nagarik Suraksha Sanhita (or the IPC or CrPC), it does not figure in any Union criminal legislation of India. The court's second reason for rejecting the petition was that the relief sought in the petition would result in a violation of international contracts and agreements entered into by Indian companies.

Here the court changed the very nature of the petition which was not about the responsibility of companies but of the State. It is the Union government that is issuing licences to supply weapons to Israel, specifically the Directorate General of Foreign Trade (DGFT) and the Department of Defence Production (DDP), as per the petition.

Hence, as per international law, responsibility, if any, for violation of international law will be on India and not on the individual companies. The reason for this is in the Articles on Responsibility of States for Internationally Wrongful Acts (ARSIWA).

The judgment reflects that the court has completely ceded international law space to the State, or is ignorant of international law. In either case, it shows a lack of appreciation of international legal rules by the court.

The court's own history with corporatehuman conflict should have reminded it of its obligations towards the latter. Its controversial treatment of the Bhopal gas tragedy, another corporate-human conflict from 40 years ago, should have served as a guide. Because of the court's misadventures, the victims of that disaster are still looking for fair compensation.

Moreover, the court's rejection of the petition is a lost opportunity. The petition was a perfect opportunity for the court to assess India's role, complicit or otherwise, in the ongoing war. Its decision leaves India susceptible to allegations of abetting genocide and being taken before the ICJ for the same. It is improbable but not impossible. On a similar issue - of supply of weapons to Israel - Nicaragua took Germany to the ICJ earlier this year.

This petition provided the court with the opportunity for a reality check. If the court had assessed the application in depth, it might have come out with a conclusion determining no liability for the government. And if it had decided that by continuing to supply weapons to Israel, India is violating international law that would have helped the government in halting the violation of international law. *(IPA Service)*

Berlin's new focus on India

ust one week ahead of the annual intergovernmental consultations, the German government published its first strategic document solely focused on its engagement with India. Although not officially labelled a strategy, the paper's cabinet-level-involvement and clear prioritisation of policy domains make "Focus on India" a comprehensive manual outlining Germany's planned approach towards India. In laying out Germany's ideas about the imagined future of Indo-German foreign, security, and trade relations, the public document has both a domestic and an external function.

Domestically, the key role of "Focus on India" is to bring all government departments on the same page. Externally, it sends a strong message of assurance to India, signalling the high standing India currently enjoys among political decision-makers in Germany.

The "new focus": A result of geopolitical threats

While trade, migration, and technology cooperation have undoubtedly become more significant for German-Indian relations, security concerns have recently introduced a strategic depth into the partnership. For the past few years, both partners have been geopolitically threatened by revisionist powers. The Galwan skirmishes with China in 2020 made India rethink its China policy.

For Germany, Russia's fullscale invasion of Ukraine in February 2022 challenged the "Wandel durch Handel" (change through trade) approach towards Russia. Furthermore, subsequent attempts to condemn Russia's behaviour at the United Nations (UN) illustrated to Germany how strong and long-standing New Delhi's partnership with

Moscow has been in the past. Neighbourhood challenges were central for both Germany and India to find new interest in each other as they sought to identify new partners as well as diversify their external dependencies.

India's behaviour towards Russia posed a dilemma for Germany's foreign policy. On the one hand, the German government realised that India was not a geopolitical ally when it came to Ukraine's sovereignty and territorial integrity. On the other hand, Germany viewed India as a key strategic partner in the Indo-Pacific and an important representative of the Global South

In other words, Germany had to consider how to deal with a partner that also partners with its geopolitical rival. Global Hunger Index: Misleading metrics

The recent Global Hunger Index (GHI) report, which places India at a dismal 105th position out of 127 countries, has raised eyebrows and sparked considerable debate. While hunger and malnutrition retives. main pressing global issues, the methodology and conclu-

Media reports suggest that the agreement is likely to be applied not just in eastern Ladakh but across the entire Line of Actual Control. Chinese blockades exist in two key areas — the Depsang Bulge in the northern part of the LAC and the Charding-Ninglung Nala near Demchok. On the other hand, India has blocked Chinese patrols in the east, especially in Tangtse, northeast of Tawang.

There is a hint, too, that the agreement may incorporate other measures to promote stability, such as coordinated patrolling, and to ensure that Indian and Chinese patrols do not run into each other while patrolling disputed areas, thereby avoiding face-offs and confrontations.

There was little clarification from the Chinese on the announcement of the deal on Tuesday. Foreign Ministry spokesman Lin Jan said in response to a question, 'Over a recent period of time, China and India have kept close communication through diplomatic and military channels on issues relating to the China-India border. The two sides have reached resolutions on relevant matters, which China views favourably. Going forward, China will work with India to implement these resolutions."

On Monday, External Affairs Minister S Jaishankar too commented on the issue to say that with the agreement, "the disengagement process with China has been completed." He added that there were areas where the Chinese had blocked us, "so we had blocked them... We have reached an agreement and understanding which will now allow the patrolling... Depsang, that is not the only place, there are other places also.

Another important voice that weighed in on this on Tuesday was Army Chief General Upendra Dwivedi, who said that the bottom line of the agreement was the importance of restoring "trust" between the two armies. He asserted that it was important to go back to the status quo of April 2020. "Thereafter. we will be looking at disengagement, de-escalation and normal management of the Line of Actual Control." He indicated that this would be done in several phases and over a period of time. Till 2020, India and China maintained peace along the LAC, basing themselves on a series of agreements. In September 1993, they signed the first major agreement on "The Maintenance of Peace and Tranquility along the Line of Actual Control in the India-China Border Areas." Three years later, in 1996, they signed an agreement on "Confidence Building Measures in the Military Field along the Line of Actual Control in the India-China border areas.' In 2005, they signed a protocol on the "Modalities for the Implementation of Confidence Building Measures in the Military Field along the Line of Actual Control in the India-China Border Areas." Finally, in 2013, there was another military agreement between the two nations on "Border Defence Cooperation Agreement. These agreements were quite unique and largely kept the peace along a border disputed in its entirety. It was because of these that the clash at Galwan in June 2020 was not with guns and grenades but with sticks and stones. Both sides had adhered to the prohibition of the use of guns and explosives on the LAC as part of the 1996 agreement. But it was this very agreement that the Chinese violated when they failed to notify India about their troop movements close to the border in March-April 2020. The cautious language and the measured steps that the two sides are now taking could mean that an entirely new set of confidencebuilding measures are in the works to ensure peace even as both armies patrol the LAC. ustice under the guise of decolonisation.

The symbolism of Lady Justice is not a colonial imposition. Rather, it is a representation of judicial principles that have resonated across civilisations. Her origins can be traced back to the ancient Egyptian goddess Maat and the Greek goddess Themis. The Romans later depicted her as Justitia, incorporating elements that would evolve into the familiar figure recognisable today.

The removal of the blindfold, in particular, raises serious concerns about the message this conveys about judicial impartiality. The blindfold was never meant to suggest that justice is blind in the sense of being unaware or ignorant. Rather, it symbolises the fundamental principle that justice must be administered without regard to the social status, wealth, or political influence of those seeking it.

To say justice is blind, means it sees all individuals as equal before the law – a principle enshrined in Article 14 of India's Constitution.

Instead, does it now suggest that courts should now take into account who stands before them? That the administration of justice should be influenced by considerations beyond the facts and the law? This symbolic change could be interpreted as a tacit acknowledgment that the justice system may treat individuals differently based on their identity or status.

The replacement of the sword with the Constitution, while seemingly progressive, also raises philosophical concerns. The sword in Lady Justice's hand never represented punitive justice alone: it symbolised the authority and power of the law to enforce its decisions.

Without this symbol of enforcement, what remains is a justice system that may pronounce judgments but lacks the symbolic representation of its power to ensure compliance. The Constitution, while undoubtedly the supreme law of our land, is a document of prin-

the power to enforce justice were often invoked by independence movements against colonial powers. These principles are not colonial impositions but universal aspirations that have been embraced by societies seeking to establish just and equitable legal systems.

The argument that this change reflects a "new India" is particularly problematic. What exactly is being suggested about this new vision of justice? That it will be administered with eyes wide open to the party that stands before the court? That enforcement of judgements is secondarv to constitutional principles? These implications run counter to the progressive justice system India should be striving to build.

The modification of Lady Justice also raises questions about the approach to decolonisation. True decolonisation involves critically examining and rejecting harmful colonial impositions while retaining and reinforcing universal principles that promote justice and equality. By rejecting the blindfold and sword simply because they are associated with a colonial-era representation, we risk throwing out fundamental principles of justice in our haste to assert independ-

ence. As we move forward, it is crucial to remember that symbols matter. They shape public perception and understanding of our institutions. The traditional Lady Justice, with her blindfold and sword, represented not colonial oppression but the highest aspirations of any justice system - equal treatment under law, impartial judgement and the power to enforce justice. In modifying these symbols, we may inadvertently be signalling a retreat from these essential principles.

The focus should be on ensuring that the justice system truly embodies the principles Lady Justice represents – principles that are not colonial relics but universal aspirations that are as relevant today as they were millennia ago. (Courtesy: Scroll.in)

sions of the GHI, co-authored by two non-governmental organisations-Irish-based Concern Worldwide and German Welthungerhilfe—have drawn criticism, particularly from the Indian government and sections of society.

There is a growing concern that such reports may not just reflect statistics but also carry political and geopolitical undertones aimed at tarnishing India's image on the world stage. The GHI is based on four key indicators: the prevalence of undernourishment, child wasting, child stunting, and child mortality. The scores from these factors are compiled to place countries on a scale from zero (no hunger) to 100 (extreme

hunger), with countries scoring closer to zero seen as having little or no hunger issues. India's score of 27.3 puts it in the "serious" hunger category, alongside 42 other countries. Critics of the GHI have raised several concerns about the methodology used in calculating India's score.

Firstly, the reliance on child mortality and child stunting indicators as primary components of the hunger index is problematic. India is a country with a large population, and while child malnutrition is a valid concern, this issue is not unique to India but rather shared by other developing countries. By focusing heavily on this aspect, the report seems to disproportionately penalise India.

Additionally, the GHI report uses outdated data from global sources such as the World Health Organisation and the Food and Agriculture Organisation (FAO). India, like many countries, has been undergoing significant improvements in food security through government initiatives such as the National Food Security Act, the Midday Meal Scheme, and pub-

Bangladesh and Nepal? It's essential to question the intentions behind these rankings. Are they an honest reflection of hunger, or do they serve other interests? Reports like the Global Hunger Index can have farreaching consequences, not just for the countries they assess but also for global perceptions.

The fact that the organisations behind the GHI-Concern Worldwide (Irish) and Welthungerhilfe (German)hail from Western countries has not gone unnoticed. It raises the question of whether the index is truly impartial or if it subtly reflects geopolitical biases. India has made significant strides in addressing hunger and malnutrition, but it seems that these efforts are often ignored or underplayed by such indices.

For instance, the Pradhan Mantri Garib Kalyan Anna Yojana, which provided free food grains to over 80 crore people during the COVID-19 pandemic, is one of the world's largest food security initiatives. The fact that India could provide this level of support during a global crisis contradicts the narrative of widespread hunger and undernourishment. To deny that hunger exists in India would

Programmes such as the Integrated Child Development Services (ICDS) aim to provide supplementary nutrition to millions of pregnant and lactating women, along with children under six years of age. Meanwhile, the Midday Meal Scheme, which serves nutritious meals to school children, has had a significant impact on reducing malnutrition.

Despite these efforts, it is undeniable that India still faces challenges. The legacy of poverty, the vast size and population of the country, and regional disparities make it difficult to eliminate hunger overnight. The concerns raised by the Indian government about the Global Hunger Index are not without merit.

The index, while claiming to provide an objective measure of hunger, fails to capture the ground realities of individual nations. India, being the second-most populous country in the world, is smaller nations with more homogeneous populations do not.

By painting India as a country where hunger is rampant, the GHI risks creating a false narrative that undermines the substantial progress made by the country. It also risks discouraging the efforts of those working tirelessly on the ground to ensure that no one goes to bed hungry.

What is needed is not biased rankings or politically motivated reports but genuine collaboration between nations to tackle the global hunger crisis. As we reflect on the GHI, one thing is clear: statistics alone do not tell the whole story. (Courtesv: The Pioneer)

Putin presides over BRICS summit seeking to expand Russia's clout

KAZAN. Oct 24: Russian Presi dent Vladimir Putin on Thursday presided over a closing session of a summit of the BRICS bloc of developing economies, hailing its role as a counterbalance to the West.

The three-day summit in the city of Kazan covered the deepening of financial cooperation, including the development of alternatives to Western-dominated payment systems, as well as settling regional conflicts and moving to expand the BRICS group of countries.

The alliance that initially included Brazil, Russia, India, China and South Africa has expanded to embrace Iran, Egypt, Ethiopia, the United Arab Emirates and Saudi Arabia. Turkiye, Azerbaijan and Malaysia have formally applied to become members, and several other countries have expressed interest in joining.

Speaking during Thursday's session, which included countries that consider joining the grouping, Putin said they all "share similar aspirations and values and a vision of new democratic global order." The summit was attended by 36

Putin and Xi had announced a "no-limits" partnership weeks before Russia invaded Ukraine in 2022. They already met twice earlier this year, in Beijing in May and at a Shanghai Cooperation Organisation summit in Kazakhstan in July. Russia's cooperation with India has also flourished as New Delhi sees Moscow as a timetested partner since Cold War times despite Russia's close ties with India's main rival. China.

While Western allies want India to be more active in persuading Moscow to end the fighting in Ukraine, Indian Prime Minister Narendra Modi has avoided condemning Russia while emphasising a peaceful settlement.

Putin, who held a series of bilateral meetings on the sidelines of the summit, was set to meet Thursday with UN Secretary-General Antonio Guterres, who is making his first visit to Russia in more than two years. Guterres's trip to Kazan has drawn an angry reaction from Kyiv. (AP)

Turkiye strikes Kurdish militant targets in Syria and Iraq for second day

ANKARA, Oct 24: Turkiye struck suspected Kurdish militant targets in Syria and Iraq for a second day on Thursday following an attack on the premises of a key defense company which killed at least five people, the state-run news agency reported.

The National Intelligence Organization targeted numerous "strategic locations" used by the Kurdistan Workers' Party, PKK, or by Syrian Kurdish militia that are affiliated with the militants, the Anadolu Agency reported. The targets included military, intelligence, energy and infrastructure facilities and ammunition depots, the report said. A security official said armed drones were used in Thursday's strikes. On Wednesday, Turkiye's air force carried out airstrikes against similar targets in northern Syria and northern Iraq, hours after government officials blamed the deadly attack at the headquarters of the aerospace and defense company TUSAS, on the PKK.

Defence Minister Yasar Guler said Thursday that 47 alleged PKK targets were destroyed in Wednesday's airstrikes — 29 in Iraq and 18 in Syria.

"Our noble nation should rest assured that we will continue with increasing determination our struggle to eliminate the evil forces that threaten the security and peace of

our country and people, until the last terrorist disappears from this geography," Guler said.

The assailants — a man and a woman — arrived at the TUSAS premises in the outskirts of Ankara in a taxi they commandeered after killing its driver, reports said. Armed with assault riffles, they set off explosives and opened fire. killing four people at TUSAS, including a security personnel and a

mechanical engineer. Security teams were dispatched as soon as the attack started at around 3:30 pm, the interior minister said. The two assailants were also killed and more than 20 people were injured in the attack. There was no immediate statement from the PKK on the attack or the Turkish airstrikes. In Syria, the main U.S.-backed force said Turkish strikes in the north of the country killed 12 civilians and wounded 25. The Kurdish-led Syrian Demo-

cratic Forces said Turkish warplanes and drones struck bakeries. power stations, oil facilities and

ocal police checkpoints. TUSAS designs, manufactures and assembles civilian and military aircraft, unmanned aerial vehicles and other defense industry and space systems. Its defense systems have been credited as key to Turkiye gaining an upper hand in its fight against Kurdish militants.

The attack occurred a day after the leader of Turkiye's far-right nationalist party that's allied with President Recep Tayyip Erdogan raised the possibility that the PKK's imprisoned leader could be granted parole if he renounces violence and disbands his organization.

Abdullah Ocalan, who was captured in 1999, is serving a life sentence on a prison island off Istanbul In a related development, his nephew Omer Ocalan announced on the social platform X that on Wednesday family members were allowed to visit him for the first

time since March 2020. Omer Ocalan, a lawmaker from Turkiye's pro-Kurdish Peoples' Equality and Democracy Party, also conveyed a message from Abdullah Ocalan, saying he was being kept in isolation and offering to work to end the conflict "if the conditions

are right. "I have the theoretical and practical power to (transform) this process from one grounded in conflict and violence to one that is grounded on law and politics," Omer Ocalan quoted his uncle as saying. The PKK has been fighting for autonomy in southeast Turkiye in a conflict that has killed tens of thousands of people since the 1980s. It is considered a terrorist group by Turkiye and its Western allies. (AP)

Trash carried by North Korean balloon again falls on presidential compound in Seoul

SEOUL, Oct 24: Trash carried by a North Korean balloon fell on the presidential compound in central Seoul on Thursday in a second case raising concerns about the vulnerability of key South Korean sites during potential North Korean aggression.

The incident comes after the rival Koreas ramped up threats and rhetoric against each other over North Korea's claims that South Korea flew drones over its capital Pyongyang to scatter propaganda leaflets this month

No dangerous items were found in the rubbish that was dropped on the ground when one of the North Korean balloons burst over the South Korean presidential compound on Thursday morning, South Korea's presiden-

tial security service said in a statement. North Korea has sent thousands of balloons carrying bags of rubbish like plastic and paper waste into South Korea since late May in a resump-

"Whether the balloons have GPS or not, it's all about launching them in large numbers and hitting the right altitude based on wind direction and speed, so that they can ride those winds to travel," Lee Choon Geun, an honorary research fellow at South Korea's Science and Technology Policy Institute, said.

"While some media are saying the accuracy of the balloons has improved, that improved accuracy isn't because they equipped them with some sort of guidance system, but rather because it's the season when winds blow southward," Lee said.

Around 100 hostages are still inside Gaza, a third of

It wasn't immediately known whether South Korean President Yoon Suk Yeol was at the compound during the latest incident. Later Thursday, he met visiting Polish President Andrzej Duda at his office.

South Korean media reported that North Korean leaflets criticising Yoon and his wife Kim Keon Hee were found on Thursday in Seoul's Yongsan district, where Yoon's presidential office is located. Media published photos of some leaflets that described Kim as a latter-day Marie Antoinette, the queen who was beheaded in 1793 during the French Revolution.

The reports said it was the first time that North Korean propaganda leaflets have been found in South Korea since the North began its balloon campaign five months ago.

The South Korean presidential security service didn't immediately confirm the report. Experts say North Korea likely lacks sophisticated technology to drop balloons on specific targets.

"In the immediate term, massive aid is needed for the Lebanese population, both for the hundreds of thousands of people displaced by the war and for the communities hosting them," Macron said in his opening speech at the conference.

French organisers hope participants' financial pledges of humanitarian aid will meet the USD 426 million the United Nations says is urgently needed. Italy this week announced new aid of

10 million euros (USD 10.8 million) and Germany on Wednesday pledged an additional 60 million euros (USD 64.7 million) for people in Lebanon.

Macron condemned Israel for continuing its military operations in Lebanon. "in the South, in Beirut, elsewhere, and that the number of civilian victims continues to rise," and reiterated his call for a ceasefire.

Paris also seeks to help restore Lebanon's sovereignty and strengthen its institutions. The country, where Hezbollah effectively operates as a state within a state, has been without a president for two years while political factions fail to

agree on a new one.

But the international conference comes as critics say French President Emmanuel Macron's diplomatic approach in the Middle East has been blurred by his apparent evolving approach and sometimes chaotic communication. Still, France's historic links with Lebanon, a former colony, and its influential diplomacy give Paris momentum to coordinate "a proper response to the massive challenge that the war in Lebanon now poses," said Middle East expert Rym Montaz, editor in chief of Carnegie Europe's blog Strategic Eu-

The French "are trying to make sure that international donors get to hear firsthand from the actors on the ground in Lebanon who can best describe the most immediate needs caused by the Israeli aggression that has forcibly displaced 20% of the Lebanese population over the course of two weeks," she said.

Israel in the past month has launched a major aerial bombardment and ground

There have been recent tensions between the French and Israeli leaders, especially after Macron called for a halt to arms exports for use in Gaza.

Macron has also strongly condemned the "deliberate" targeting by Israel of UN peacekeepers in southern Lebanon, which Israel has denied.

Thursday's conference involves ministers and officials from over 70 countries and international organisations, including the European Union and regional partners, Macron's office said. Acting Lebanese Prime Minister Najib Mikati, who met with Macron on Wednesday, will attend. (AP)

2 arrested in Sri Lanka for allegedly planning terror attack on Israelis

COLOMBO, Oct 24: Two persons have been arrested in Sri Lanka on suspicion of planning a terror attack on Israeli nationals in the country after India provided intelligence on the possible threat, police said on Thursday.

Security was beefed up in the eastern coast surfing resort of Arugam Bay following information about a possible attack in the area.

Two persons have been arrested by the Terrorism Investigation Division of the police.

Both arrests have come as a result of Indian intelligence information sharing over the security alert in Arugam Bay, police said.

One of the suspects had arrived in the country from Iraq, it said. The police said it had received information on October 7 on a possible attack and the security was strengthened in the areas two weeks ago, the police said. The Indian alert had said the attack could take place between 19 and 23 October.

On Wednesday, the US embassy and the British High Commission in Colombo issued statements warning their citizens that they had received credible information targeting Arugam Bay and tourists are strongly urged to avoid the area until further notice. (PTI)

ISLAMABAD, Oct 24: Bushra Bibi, the wife of Pakistan's jailed former premier Imran Khan, was on Thursday released on bail nearly nine months after her arrest in the Toshakhana corruption case.

The release came a day after the Islamabad High Court judge, Justice Miangul Hassan Aurangzeb, accepted the bail plea of the 50-year-old former first lady against a surety bond of Rs 1 million.

Khan's Pakistan Tehreek-e-Insaf (PTI) party confirmed Bushra's release in a WhatsApp message.

"Bushra Bibi, the former First Lady, has been released from the prison," it said, adding that she was first arrested on January 31. Bushra was arrested after a court convicted and sentenced the couple to 14 years in jail in a corruption case.

The Toshakhana case involves allegations of corruption against Khan and his wife for receiving profit from the sale of gifts received from foreign dignitaries. Earlier, Justice Aurangzeb, hearing the bail plea, had questioned the Federal Investigation Agency's (FIA) investigative officer about the necessity of further interrogation of the former first lady.

The officer confirmed that no additional investigation was required.

Bushra is Khan's third wife and a spiritual healer. Meanwhile, the indictment proceedings against Khan and Bushra, scheduled on Wednesday were postponed due to security concerns as the hearing set to take place at Rawalpindi's high-security Adiala Jail was moved to Islamabad's Judicial Complex.

However, security concerns continued to prevent the proceedings, and the court rescheduled the indictment for October 26.

Bushra's release comes as a relief to the PTI as well as Khan, who has been insisting that his wife had nothing to do with the case. (*PTI*)



plant, Begonia neisti, was discovered in the remote Dibang Valley of Arunachal Pradesh, said an official statement on Thursday.

The discovery was made by Dr Nazir Ahmad Bhat, Assistant Professor at the University of Science and Technology Meghalaya (USTM), in collaboration with Bipankar Hajong, PhD Scholar at CSIR-North East Institute of Science and Technology (CSIR-NEIST), and Dr Pankaj Bharali, senior scientist at CSIR-NEIST, Jorhat. The newly discovered Begonia neisti is noted for its distinctive variegated leaves, marked by white-silver spots and dark brownish-red patches near vein junctions.

"The large leaves and striking white stripe on the stems and petioles distinguish it from other species in the Begonia genus," the statement quoted Dr Bhat as saying. The species thrives in the moist, hilly slopes between Hunli and Anini in Arunachal Pradesh, where it flowers from November to January.

The discovery was confirmed through advanced molecular phylogenetic analysis, specifically using the ITS2 genetic marker, which revealed close evolutionary ties with other Begonia species from the Indian subcontinent. The findings were recently published in the Nordic Journal of Botany, detailing the plant's unique morphology, genetics, and ecological importance.

Despite the excitement surrounding its discovery, Begonia neisti has been classified as Data Deficient (DD) under IUCN Red List criteria. The expansion of roads in its native habitat poses a threat to the plant's survival, sparking calls for conservation efforts.

"The discovery underscores the rich biodiversity of Arunachal Pradesh and the urgent need for ongoing botanical exploration and preservation in the region,' noted the researchers.

As development pressures increase in the region, conservationists are urging authorities to monitor the species closely and implement measures to protect its habitat. The discovery of Begonia neisti further highlights the global significance of the Eastern Himalayas as a biodiversity hotspot.

Congress not to field its candidates in UP Assembly bypolls 'Will support INDIA bloc nominees'

NEW DELHI, Oct 24: The Congress on Thursday announced it would not field candidates in the nine Assembly bypolls in Uttar Pradesh and would support the INDIA bloc nominees, asserting that the prevailing political situation demands prioritising efforts to protect the Constitution over party interests.

Addressing a press conference at the party headquarters here along with the Congress' Uttar Pradesh chief Ajay Rai, AICC general secretary in-charge of the state Avinash Pande said party workers and leaders would unconditionally work to ensure the victory of Samajwadi Party candidates or that of other INDIA bloc parties.

"The manner in which political and social tensions are rising in UP and in the country and keeping in mind the objectives with which the INDIA bloc was created, on that basis, the question is not about strengthening organisation or forwarding party interests but to save the Constitution and to strengthen mutual harmony," Pande said. Keeping this in mind, on the suggestions of UP Congress leaders, the party has decided not to field



its candidates but strongly work for the victory of the INDIA bloc nominees, he said.

"We have to ensure the defeat of the BJP nominees so that it has a positive impact on the Assembly polls in 2027," Pande asserted.

Pande said recently, under the aegis of the Uttar Pradesh Congress Committee, 'Samvidhan Bachao Sankalp Sammelan' were organised in all the 10 Assembly constituencies where bypolls are

"If the BJP is not stopped today, then the Constitution, brotherhood

and mutual harmony will weaken in the times to come," he alleged. He asserted that it was not about


said all the INDIA bloc candidates would contest the bypolls on the party's 'cycle' election symbol. Pande, however, clarified that the candidate and symbol both would be of the SP or any other INDIA bloc ally, and not of the Congress.

Yadav had earlier said the alliance's decision was not informed by any seat-sharing maths but a pursuit of victory.

"The Congress and the Samajwadi Party are united and stand shoulder to shoulder for a big victory. The INDIA bloc is going to write a new chapter of victory in this by-election," Yadav said in a post on X on Wednesday.

Yadav on Thursday shared on X a picture with Congress leader Rahul Gandhi and emphasised their shared commitment to protect the Constitution, reservation and social harmony.

The nine assembly seats going to polls are Katehari, Karhal, Mirapur, Ghaziabad, Majhawan, Sisamau, Khair, Phulpur and Kundarki. The bypolls are scheduled to be held on November 13 and the results will be announced on November 23. (PTI)



NEW DELHI, Oct 24: A broad consensus has been achieved by India and China on restoring the "ground situation" along the Line of Actual Control (LAC) pursuant to talks, including for patrolling and grazing cattle in the traditional areas, Defence Minister Rajnath Singh said on Thursday.

Speaking at the Chanakya Defence Dialogue 2024, Singh described the agreement reached between the two countries as a "significant development" that underscores the importance of defence dialogue on the global stage.

"India and China have been involved in talks both at military and diplomatic levels to resolve differences in certain areas along the LAC. Pursuant to the talks, a broad consensus has been achieved to restore the ground situation based on the principle of equal and mutual security," Singh said.

"The consensus achieved includes patrolling and grazing (cattle) in the traditional areas. This is the power of engaging in continuous dialogue because sooner or later, solutions will emerge," the defence minister added.

In a major breakthrough in ending the over fouryear-long military standoff, India on Monday announced that it has reached an agreement with China on patrolling along the LAC in eastern Ladakh.

It is understood that the agreement will facilitate patrolling in Depsang and Demchok areas as there were major unresolved issues in these two places.

Broad consensus achieved on restoring

ground situation along LAC: Rajnath Singh

On Wednesday, Prime Minister Narendra Modi and Chinese President Xi Jinping endorsed the India-China agreement on patrolling and disengagement along the LAC in eastern Ladakh on the margins of the BRICS Summit in Russia.

They also issued directions to revive various bilateral dialogue mechanisms, signalling attempts to normalise ties that were hit by a military clash at Galwan in eastern Ladakh in 2020.

Speaking at the event, Singh also said security is a broad and multifaceted concept that encompasses many other factors, including internal stability, economic resilience, and the protection of critical infrastructure, all of which are essential to a nation's overall security framework.

"Security is often associated with border protection. When we think of security, images of soldiers stationed on the borders, aircraft patrolling the skies, and naval ships guarding the seas typically come to mind. However, as you all know, security extends far beyond border defence," Singh said.

The defence minister also said that indigenous manufacturing of arms and defence equipment strengthens the security infrastructure as well as the economy of the country.

Had defence been recognised as an integral component of development and studied more comprehensively in the past, India might have achieved self-reliance in the defence sector much earlier, Singh said, adding that self-reliance in defence is a prominent national goal, but does not imply working in isolation from the global community.

"When India speaks of self-reliance, it is important to clarify that it does not imply working in isolation from the global community. Instead, as we pursue our goal of self-reliance, we remain dedicated to fostering an equitable and inclusive world order," he said.

India is committed to collaborating closely with all the nations to promote a fair and just international system, the defence minister said. (PTI)

Kumaraswamy's son Nikhil named NDA candidate for Channapatna Assembly bypoll BENGALURU, Oct 24: JD(S) leader Nikhil Ku-

maraswamy was on Thursday announced as the NDA candidate for the November 13 Assembly bypolls from Channapatna, a seat vacated by his father and Union Minister H D Kumaraswamy after being elected to Lok Sabha.

The 36-year-old is pitted against five time MLA from the segment and former Minister C P Yogeeshwara of the Congress, who joined the party after quitting BJP on Wednesday.

Nikhi's mother Anitha Kumaraswamy, a former MLA, had unsuccessfully contested from the seat in 2013, and faced defeat against Yogeeshwara, a political heavyweight in the constituency.

With Yogeeshwara joining Congress to contest the Channapatna bypoll, pressure was mounting on Kumaraswamy from party workers and leaders to field Nikhil. Kumaraswamy had held marathon meetings with party workers and leaders, especially those from Channapatna, over the last couple of days, before deciding on Nikhil's name.

A meeting was held with alliance partner BJP, at veteran leader B S Yediyurappa's residence on Thursday, before Nikhil's name was formally announced.

Use 'clock' symbol in Maharashtra assembly Farmers to block roads at few elections with disclaimer:SC to Ajit Pawar places in Punjab tomorrow

NEW DELHI, Oct 24: The Supreme Court on Thursday directed Maharashtra Deputy Chief Minister Ajit Pawar to use the "clock" symbol in its publicity material in the upcoming Maharashtra assembly elections with a disclaimer that the matter was sub-judice before it.

Justices Surya Kant, Dipankar Datta and Ujjal Bhuyan passed the order on a plea filed by the rival Sharad Pawar-led NCP faction as it issued a notice to the Ajit Pawar-led faction.

The top court on March 19 and April 4 had directed the Ajit Pawarled faction to issue a public notice in the newspapers in English, Hindi and Marathi editions notifying that the allocation of "clock" symbol was sub-judice. The apex court had further said the Ajit faction was permitted to use the symbol subject to the case's final outcome.

During the proceedings on Thursday, the bench took note of

the submissions of senior advocate Abhishek Manu Singhvi, who appeared for the Sharad Pawar faction. Singhvi submitted the opponent group should be restrained from using the "clock" symbol as it didn't use the disclaimer in their campaign materials and "misled" voters. "They have been blatantly not

using the disclaimer. They want to piggyback on me. Nobody should enjoy the goodwill of the symbol which is sub-judice," submitted Singhvi.

The top court directed Ajit Pawar to file a fresh undertaking over its March 19 and April 4 directions to issue a public notice -- "NCP's 'clock' symbol is sub-judice" -- was being meticulously complied with even during the process of the state assembly elections.

"File a fresh undertaking as well that you have not violated our directions in the past and till the end of elections. If there is any violation,

we will take note of it. We expect both sides to comply with our directions. Please don't create an embarrassing situation," the bench said. Singhvi said the Ajit Pawar group

should be allocated a new symbol for the assembly elections. Senior advocate Balbir Singh,

appearing for Ajit Pawar, opposed Singhvi's submissions and said all pamphlets and campaign materials contained the disclaimers as directed by the apex court.

"They are showing false documents. We have given disclaimers in our publicity material. They came up with the same allegations during the Lok Sabha polls which was rejected. I am willing to file all documents and pamphlets," Singh said. The matter has been posted for

hearing on November 6. Sharad Pawar moved the apex court against a February 6 order of the Election Commission of India (ECI) recognising Ajit Pawar-led

group as the real NCP. (PTI)

CHANDIGARH, Oct 24: Kisan Mazdoor Morcha (KMM) leader Sarwan Singh Pandher on Thursday said farmers will resort to a road blockade at a few places in Puniab for an indefinite period from October 26 to protest against the "tardy" paddy procurement and other issues.

Pandher said the "chakka jam" for an indefinite period will be held at one place each in Sangrur and Moga districts and at Phagwara and Batala.

He told reporters here that the farmers will protest against the "tardy" paddy procurement and lifting, the DAP fertiliser supplies not being adequate, besides over the stubbleburning issue.

He said "red entries" have been made in the farm records of farmers burning stubble and cases slapped on them.

"Considering a woman's request, we thought it better to postpone today's meeting for another day," Venugopal said as he along with other Opposition members left the venue minutes after the meeting began amid sharp exchanges between the ruling alliance and INDIA bloc MPs.

An opposition member alleged that Buch informing the committee about her decision with less than two hours to go for the meeting to



begin virtually amounts to contempt of the parliamentary panel.

BJP members accused Venugopal, a senior Congress leader, of not letting them put across their views. They later charged him with acting in a "suo motu" manner, suggesting that his decision to summon Buch and even some other regulatory bodies established by the acts of Parliament was his own and guided by partisan poli-

Delhi HC asks Centre to file report on issue of deepfakes

NEW DELHI, Oct 24: The Delhi High Court on Thursday directed the Centre to file a status report on the measures the Central government has taken to counter the increasing menace of the deepfake technology

Chief Justice Manmohan and Justice Tushar Rao Gedela further asked for the report to highlight measures taken at the government level and whether there would be a high-powered committee to suggest solutions.

The court while hearing two petitions against the non-regulation of deepfake technology called it a "very serious issue" which required to be dealt with by the authorities on a "priority" basis.

"What are you doing? Everyday deepfakes are on the increase ... I am glad that industry people have started taking some initiatives and are spreading awareness about it among consumers," said the bench.

Deepfake technology allows creation of realistic videos, audio recordings and images that could be manipulated to mislead the viewers by superimposing the likeness of one person onto another, altering their words and actions, thereby presenting a false narrative or spreading misinformation. The court observed that the artificial in-

telligence (AI) could not be prohibited as people needed it.

'We have to remove the negative part of the technology and keep the positive part," it added.

The high court further underlined the rising number of hoax bomb threats on flights,



enquiring if the government had set up an expert committee and, if ves, who were its members.

"We want clean answers. It has to be a serious committee," the bench said.

The additional solicitor general representing the Centre said the union ministry of Electronics and Information Technology (MeitY) was looking into the issue.

The counsel appearing for one of the petitioners submitted that several countries had enacted a legislation on the issue and India was far behind.

Most deepfakes, he said, were related to women, including nudity, and the authori-

ties were unable to resolve the issue. The government was stated to have issued general advisories to the intermedi-

aries which were of no use. The court granted three weeks to the Centre to file the status report and posted the hearing on November 21.

The high court had previously noted that the antidote to AI was technology.

In its response over websites granting access to deepfakes and blocking such platforms, the MeitY had said it was not empowered to monitor any online content on the internet on a suo motu basis.

"Any content/URL/websites on the inter-

net can only be blocked as per the established legal procedure," it had said.

Journalist Rajat Sharma has filed one of the pleas and sought directions to block public access to applications and software enabling the creation of such content. He said deepfake technology posed a significant threat to various aspects of society, including disinformation campaigns, and undermined the integrity of public discourse and the democratic process.

The other petition has been filed by advocate Chaitanya Rohilla, against deepfakes and the unregulated use of artificial intelligence.

The ministry, said in its reply, that it had taken various steps to address proliferation of harmful applications (AI-enabled and deepfake) and illegal content.

In order to ensure an open, safe, trusted and accountable digital ecosystem, the Digital Personal Data Protection (DPDP) Act 2023 has been notified, it said.

Sharma's PIL said the Centre had made a statement of its intent to formulate regulation for dealing with deepfakes and synthetic content in November 2023, but it was yet to see the light of the day.

The PIL, therefore, sought a direction to the Centre to identify and block public access to the applications, software, platforms and websites enabling the creation of deepfakes.

The plea sought the government to issue a directive to all social media intermediaries to initiate immediate removal of deepfakes on a complaint. (PTI)

Rain lashes parts of Bengal as severe cyclone 'Dana' moves closer to coast

KOLKATA, Oct 24: Several districts of West Bengal received moderate to heavy rain on Thursday morning, as severe cyclonic storm 'Dana' inched closer to the state's coast and that of neighbouring Odisha, the IMD said.

The cyclonic storm is likely to make landfall between Bhitarkanika National Park and Dhamra Port in Odisha early Friday with wind speeds of up to 120 kilometres per hour (kmph), it said. The weather system lay 280 km

southeast of Paradip (Odisha) and 370 km south-southeast of Sagar Island (West Bengal) at 2.30 am, the IMD said in a bulletin.

The cyclonic storm is set to bring heavy rainfall in several south Bengal districts, including Kolkata

Advising fishermen not to venture into the sea, the Met Department said gale wind with speeds reaching 90-100 kmph gusting to 110 kmph is prevailing over northwest Bay of Bengal.

It warned that the wind speed over the area is likely to increase gradually to

100-110 kmph gusting to 120 kmph till Friday morning, and decrease thereafter. The coastal districts of Bengal

are experiencing moderate to heavy rain and gusty winds since the early hours of Thursday, while Kolkata woke up to an overcast sky and intermittent showers.

The bulletin warned of heavy to very heavy rainfall with extremely heavy downpour in isolated places

in the south Bengal districts of North and South 24 Parganas, Purba and Paschim Medinipur, Jhargram, Kolkata, Howrah and Hooghly districts on Thursday and Friday. Public transportation to and

from Kolkata's suburbs may get affected from the evening, as Eastern and South Eastern railways cancelled a large number of trains on Thursday and Friday, in view of the cyclone.

More than 170 express and passenger trains running through South Eastern Railway (SER) jurisdiction have been cancelled, an official said.

The trains cancelled were scheduled to depart from their originating stations between October 23 and October 27, he said.

The Kolkata-headquartered SER zone is spread across West Bengal, Odisha and Jharkhand.

Besides, the Eastern Railway (ER) will not operate any EMU local train from Sealdah station on its south and Hasnabad sections from 8 pm on Thursday till 10 am on Friday, the official said.

The ER also cancelled 68 suburban trains on the Howrah division on Friday morning, he said.

The Indian Coast Guard (ICG) said it is on high alert and has mobilised vessels and aircraft to respond swiftly to any contingency over the Bay of Bengal.

Meanwhile, the NDRF said it has deployed several teams across south Bengal to tackle any emergency situation. (PTI)

Severe cyclone Dana moves closer to Odisha coast, evacuation efforts expedited IMD issues a 'red warning' (take action) for heavy to very heavy rainfall in seven districts

BHUBANESWAR, Oct 24: Severe cyclonic storm Dana lay within 200 km of the Odisha coast on Thursday afternoon, as several parts of the state experienced heavy rain and squally winds, with the sea condition remaining rough, the IMD said.

The state government also expedited evacuation efforts in the coastal districts, as Chief Minister Mohan Charan Majhi held a review meeting and directed officials to ensure "zero casualty" due to the natural calamity.

The cyclone is likely to make landfall between Bhitarkanika National Park and Dhamra Port in Odisha early Friday with wind speeds of up to 120 kilometres per hour (kmph), the Met Department said.

The weather system over the Bay of Bengal moved north-northwestwards with a speed of 12 kmph during past the six hours, and lay centred about 210 km southeast of Paradip (Odisha), 240 km south-southeast of Dhamra (Odisha) and 310 km south of Sagar Island (West Bengal), the IMD said its latest bulletin.

"It is very likely to move north-northwestwards and cross north Odisha and



West Bengal coasts between Puri and Sagar Island close to Bhitarkanika and Dhamra during midnight of 24th to morning of 25th October as a severe cyclonic storm with a wind speed of 100-110 kmph gusting to 120 kmph," it said.

Reports about uprooting of trees have been received from some areas of Balasore, Bhadrak, Bhitarkania and Puri, leading to blocked roads, officials said.

Majhi said about three lakh people have been shifted to various cyclone shelters and the operation is continuing.

A total of 7,285 cyclone centres have so far been set up, and 91 medical teams deployed.

The authorities have also engaged 19 teams of the NDRF, 51 teams of the ODRAF and fire services personnel in shifting people and clearing blocked roads, the officials said.

The highest rainfall of 62 mm was recorded at Paradip, while Rajnagar in Kendrapara district received 24 mm rain, in the last four hours, the Met office said. Moderate to intense rain and thunderstorms with wind speeds of 30-40 kmph are likely to lash some parts of Bhadrak, Balasore, Jajpur, Cuttack, Khurda, Jagatsinghpur, Kendrapada and Puri districts during the day, it said.

Director of the Regional Meteorological Centre, Bhubaneswar, Manorama Mohanty said: "The severe cyclonic storm is likely to re-curve slightly towards west and west-southwards after landfall, triggering rain in southern Odisha around October 26. However, the landfall and wind speed predictions remain unchanged."

Meanwhile, the IMD issued a 'red warning' (take action) for heavy to very heavy rainfall in seven districts - Mayurbhanj, Cuttack, Jajpur, Balasore, Bhadrak, Kendrapara and Jagatsinghpur - on Thursday. (PTI)

With its blend of love story, humour, and emotional depth, the film redefined the idea of Bollywood romance. It catapulted Kajol and Shah Rukh Khan to leading star status in the Hindi film industry.

Fans have kept the movie relevant, Kajol said.



I couldn't get a job after 'The Devil Wears Prada': Stanley Tucci



LOS ANGELES, Oct 24: Actor Stanley Tucci says he struggled to book jobs after starring in 2006's "The Devil Wears Prada" and took up whatever offers came his way. The actor played Nigel in the hit movie, also starring Anne Hathaway, Meryl Streep and Emily Blunt. Directed by David Frankel, the film was a box office success and also earned two Oscars.

"My career has always gone through these fluctuations, and sometimes it's just the business...

"After 'The Devil Wears Prada', I couldn't get a job, and I didn't quite understand that, but that's just the way it was. So I went and did stuff that I didn't necessarily want to do, but I did it," he told The Vanity Fair magazine. Tucci, also known for films such as "The Lovely Bones", which earned him a best supporting actor Oscar nomination, and "Julie & Julia" and the "Hunger Games" franchise, also reflected upon resuming work after completing treatment for oral cancer.

"Having been sick six years ago, that threw a wrench into the works for a while, and then you slowly get back. But I had to start doing things."

The 63-year-old was diagnosed with a tumour at the base of his tongue back in 2017. He revealed his battle with the disease in 2021 after his treatment was "successful" and said the disease is unlikely to return.

"I needed to work because I needed money. I probably started working too soon. I didn't really have the energy to do it after the treatments, but you had to do it, and eventually you climb back up again," he added. A sequel to "The Devil Wears Prada" was recently an-

nounced, but Tucci is yet to confirm if he'll reprise his role in the new film. (PTI)

I had no idea I'll be working 50 years later, hoping I'll continue: Shabana Azmi



MUMBAI, Oct 24: Her first film opened the 'parallel' way for cinema that was both critically accepted and financially viable. Fifty years after "Ankur" and a career that successfully walked the twin paths, much like her debut movie, Shabana Azmi says the best is still to come.

The 74-year-old, feted for films as diverse as the intense "Paar" and the zany "Rocky and Rani Kii Prem Kahaani", intends to move ahead with her "boots on". "When I started 50 years ago, I had no idea that 50 years later, I'll still be working, so it feels really good. I'm hoping that I'll continue working because acting is what I enjoy the most," Azmi told PTI in an interview. With an oeuvre spanning many classics and over 150 films, Azmi said she is only getting started. "I alware set that mu corract is about

"I always say that my career is about being at the right place at the right time. I've been very fortunate."

Azmi is the only actor to win the National Film Award for best actress five times – for "Ankur", "Arth", "Bhavna", "Khandhar", "Paar" and "Godmother". The actor, who has fronted the parallel cinema movement in India, has also

been the mainstay in many a commercial film. Right from "Amar Akbar Anthony", "Ek Hi Raasta" and "Parvarish" in the 1970s to "Rocky and Rani..." in 2023. She has also worked in several international projects, including the Steven Spielberg-produced series "Halo", Shekhar Kapur's "What's Love Gotta Do With It", Roberto Benignis starrer "Son of the Pink Panther" and Merchant Ivory's "In Custody". "Hou monu meanle get that? The last

"How many people get that? The last two-three years have been very satisfying... But I'm interested in working with younger directors, and also interested in working in mainstream cinema provided it is (with) a person with teeth," she said.

Azmi started a Hindi theatre group with fellow student Farooque Shaikh while still at college at St Xavier's in Mumbai. In 1971, she enrolled at Pune's Film and Television Institute of India (FTII), hoping it would lead to work with Ebrahim Alkazi at the National School of Drama in Delhi.

Before joining FTII, she had seen Jaya Bhaduri's diploma film "Suman" and remembers being mesmerised by it. "I had not seen that kind of acting in Hindi cinema at all," said Azmi, who still does theatre.

She won the gold medal for best acting student and received her first acting offer, "Parinay", just four days later. And then she made her acting debut with "Ankur".

Has she ever thought of writing a script? "It is so easy being an actor. When I think of directing a film, so many people have asked me, (but) I find it so intimidating to work on a script and bring everybody on the same level... But I do look forward to working with Zoya and Farhan both," she said, referring to her stepchildren. While it is important to have women

directors, Azmi said it is also important that their lens is feminine.

"Because far too long, it has been the male gaze and we need to have a women's gaze. It is not necessary to have feminist gaze but a feminine gaze because I think men and women are different in how they view the world. It is not necessary that if you are a woman, you make only feminist films, you can make a thriller, comedy, a romance, but it should be through a woman's lens." Azmi is also credited for paving the way for women actors to get roles of substance through her career in parallel cinema of the '70s and '80s.

The actor said she grew up thinking gender equality was a norm because of her parents, theatre artist and actor Shaukat Azmi and Urdu poet Kaifi Azmi. Both were leading names in the Indian People's Theatre Association (IPTA) and the Progressive Writers Association (IWA).

"I took gender equality as a given. Only when I turned 19, did I realise that it was an exception rather than the rule and that took me by surprise," she said.

This perhaps reflected in her choices as well.

"That was the time when 'Ankur' became a beacon of light for parallel cinema and because it did so well commercially, it opened up a spate of completely different parts for women. That's why I say, 'I was at the right place at the right time'. So, it was left to art cinema to give agency and substantial parts to women because in mainstream cinema it was usually just the song and dance routine." (PTI)

Raphinha's demolition job on the Bayern defense also means plaudits for Flick, who was the comprehensive winner against his old team, Bayern, with whom Flick beat Barcelona 8-2 in 2020.

The loss throws Bayern's season under new coach Vincent Kompany into turmoil.

Bayern began its Champions League campaign with a recordbreaking 9-2 demolition of Croatia's Dinamo Zagreb but is now 23rd in the Champions League standings, one place below Zagreb, after back-to-back losses to Aston Villa and Barcelona. Across all competitions, Bayern has won just one of its last five games.

The ease with which Raphinha was able to exploit gaps in the back line could reopen questions about whether Bayern, which has now conceded seven goals in its last three games, remains fragile in defense. (AP)

Arsenal has discipline issue, could cost the team Premier League title

The Arsenal manager saw his right-back Ben White receive a vellow card in the first half of the Champions League game against Shakhtar Donetsk on Tuesday and quickly came to a decision.

White needed to be removed at half-time. "We have played enough with 10 men in the recent period," Arteta said with a smirk. It is becoming abundantly clear: Arsenal has a discipline problem — and it might yet cost Arteta's team a shot at the English Premier League

title. Arsenal has had three players sent off in the opening eight rounds of a league campaign that is seeing yellow cards being dished out at an unprecedented rate. It continues something of a

running theme under Arteta. Since he arrived as its manager in late 2019, Arsenal has collected 18 red cards in the Premier League — five more than the next team.

Tellingly for Arteta, the only games where Arsenal dropped points this season — the 1-1 home draw with Brighton, the 2-2 away draw at Manchester City and the 2-0 loss at Bournemouth on Saturday came when the team had a

BARCELONA, SPAIN, Oct 24: When Real Madrid added Kylian Mbappé, Barcelona looked doomed to becoming a regular runner-up to its fierce rival.

Then Hansi Flick arrived with fresh ideas, Lamine Yamal blossomed into a star, his teammates stepped up their game, and Saturday's clasico promises to be a highly entertaining and close-fought match. It will be the first clasico for Mbappé and Flick. Barcelona leads La Liga by three points from second-placed Madrid. Real Madrid became the envy of

soccer when Mbappé walked away from Paris Saint-Germain and joined Madrid as a free agent last summer.

He has teamed up with the already brilliant Vinícius Júnior to form the most lethal one-two punch in soccer, especially when either has any room to dribble at defenses caught off guard.

They have scored eight goals across all competitions, while Vinícius also has seven assists. Vinícius arrives in particularly great form after his hat trick fueled a 5-2 comeback from two goals down

against Borussia Dortmund in the Champions League on Tuesday.

But with Rodrygo doubtful and Endrick unused by coach Carlo Ancelotti in recent games, Barcelona collectively may be able to counter Madrid's firepower up front. Robert Lewandowski is playing at his best since arriving in Barcelona. Under

Flick, his former coach at Bayern Munich, the 36-year-old Poland striker has scored 15 times, including a league-leading 12. Flick has plenty of options. PUNE, Oct 24: All-rounder Washington Sundar justified his selection with a career-best 7/59 to help India bowl out New Zealand for 259, but the hosts lost skipper Rohit Sharma early in their first innings when stumps were drawn on day of the second Test, here on Thursday.

India crawled to 16 for one in 11 overs with Yashasvi Jaiswal (6 not out) and Shubman Gill (10 not out) at the crease, trailing by another 243 runs in the first innings.

Tim Southee cleaned up Rohit for a nine-ball duck, forcing the hosts to be extra cautious with the debacle of first innings in the Bengaluru Test still fresh in the mind.

Rohit, who was cleaned up for the third time in the series and for the second time by Southee, was squared up as he looked to defend in the line of the delivery but the ball moved away to beat his outside edge and crash into the offstump.

Southee thus became the first among fast bowlers to take a wicket in this Test after a dominating show by the Indian spin duo of Sundar and R Ashwin (3/64), who did not

South Africa wins first Test in Asia in a decade after beating Bangladesh

MIRPUR (BANGLADESH), Oct 24: Fast bowler Kagiso Rabada's 6-39 helped South Africa finish off Bangladesh by seven wickets on Thursday and win their first cricket Test in Asia in 10 years.

Bangladesh was all out for 307 in its second innings in the morning, with

Bangladesh was always chasing after being dismissed for 106 in the first in-

nings. South Africa replied with 308 propped up by Kyle Verreynne's 114, which earned him player of the match. "It's a really good performance. Incred-

ibly tough for the team to put four days of good cricket together," South Africa stand-in captain Aiden Markram said.

"Bowlers were great there and then the batters helped us get a great lead. When you get a lead like that, it's tough for opposition to come back."

South Africa's last win in Asia was in 2014 against Sri Lanka in Galle. Resuming the day at 283-7 and 81 runs ahead. Bangladesh failed to make any impact as Rabada and Wiaan Mulder sliced through the hosts with the second new ball

"Rabada is a special bowler for us," Markram said. "For Kyle to step in and play that sort of innings (114), that's really
