Around 200 fall ill after consuming traditional 'jalpan'

Food inspector to visit village to investigate cause of food poisoning



GOLAGHAT, Oct 20: Around 200 people have fallen ill due to food poisoning after consuming snacks during an obituary function of a deceased in Assam's Golaghat district, officials said on Sunday

The incident took place on Saturday night during a gathering at the memorial ceremony of

the mother of Pradip Gogoi at Pasghoria village of Uriamghat in the Sarupathar area.

According to an official, the guests were served with traditional 'jalpan' (snacks with puffed rice and cream) during the function.

"The people then complained of stomach ache, headache, vomiting and loose motion. A

total of 53 people were immediately admitted at the Community Health Centre in Sarupathar town and Public Health Centre in Uriamghat," the official said. Out of them, two were sent to Jorhat Medical College and Hospital for advanced treatment, he added.

"The condition of the victims is stated to be stable and many are being released after treatment," the official said. The remaining around 150 people, who have shown minor symptoms, are at their respective homes and their health conditions are being monitored, he added.

Sarupathar's BJP MLA Biswajit Phukan visited the hospital and enquired about the health condition of the people.

"The district administration informed me that the food inspector will visit the village and investigate the cause of the food poisoning," he added. Phukan said a medical camp has been set up in the village and health checkup is being carried out for the villagers.

"We have also sent medical teams to the individual houses of all the people, who had come to the function. The team is closely monitoring the health conditions. None of the people are showing any serious symptoms," he added. (PTI)

SC's 1971-cut off verdict not historic: Himanta

GUWAHATI, Oct 20: Chief Minister Himanta Biswa Sarma on Sunday expressed a "mixed reaction of happiness and sorrow" regarding the Supreme Court judgment on the cut-off date of the Assam Accord.

Speaking to reporters on the sidelines of an official function on Sunday, Sarma emphasised that the Assamese people will have to move forward

through "struggles." "I don't know if this judgment is historic or not. The government enacted the Assam Accord so its stand in the court was that the cutoff date should be 1971.

However, many people in Assam wished the cut-off date to be 1951," he said when asked for his comments on the judgment. In a majority verdict, the Supreme Court on Thursday upheld the constitutional validity of Section 6A of the Citizenship Act which grants Indian citizenship to immigrants who came to Assam between January 1, 1966 and March 25, 1971. A five-judge Constitution

Bench, headed by Chief Justice D Y Chandrachud, said the Assam Accord was a political solution to

the problem of illegal migration. "I feel that this verdict establishes 1971 as the cut-off date, and my reaction is mixed. There is both happiness and sorrow in it. Therefore, I don't want to label it a historic judgment; it is simply a blend of both emotions."

"The Assamese community has to move forward with struggles like this," Sarma said without elaborating further in his first reaction after the judgment

was delivered by the apex court. The Assam Accord was signed in 1985 after a six-year-long vioanti-foreigner movement. The pact

stated, among other clauses, that names of all foreigners coming to Assam on or after March 25. 1971, would be detected and deleted from electoral rolls with steps taken to deport them.

The majority verdict of the Constitutional Bench held that the cutoff date of March 25, 1971, for entry into Assam and granting citizenship is correct. Section 6A was inserted into the Citizenship Act in 1985 as a special provision to deal with the citizenship of people covered under the Assam Accord. (PTI)

Rain-damaged infra disappoints tourists at Pobitora Wildlife Sanctuary

MORIGAON, Oct 20: Tourists visiting Pobitora Wildlife Sanctuary, the densest habitat of one-horned rhinos in the world, are facing hardship due to poor road conditions inside the forest on account of heavy rainfall a week ago.

The forest was reopened on October 14 after the monsoon break since May, but tourists had to be turned away as the authorities could start neither jeep nor elephant safaris due to poor road conditions inside the sanctuary, a senior official said on Sunday. During the last one week, already 1,585 tourists, including 21 foreign nationals from China and Thailand, visited the Pobitora Wildlife Sanctuary and it is a healthy trend, the forest's Ranger Nayan J Das told PTI.

"However, many of them could not go inside because we could not start the jeep or elephant safari. We had repaired the roads after the monsoon, but those got badly damaged in heavy rains that lashed the park at the time of reopening," he added.

Das said that the paths inside the sanctuary were waterlogged, and jeep and elephant safaris remained suspended for the first three days.

Usually, October is a non-rainy month in Assam but this year the state received heavy rainfall for several days till around Durga Puja earlier this month.

"When the rain stopped, we started repair work again. The damaged infrastructure was repaired and work on link roads inside the sanctuary is underway. We could finally start the jeep safari from October 17," Das said.

However, the elephant safari will take some more time to start and the forest authorities have set a target of November 7 for this, he added.

Sudip Bose, a tourist from Kolkata, said he reached Pobitora on October 16 but could not take the safari as it was closed then.

"I stayed one more night and took the jeep safari on October 17. It was worth waiting for. However, the roads inside were very bad and the safari guide did not take us to a few areas as the link paths were still in very bad shape," he said.

Another tourist, Lily Dubey from Delhi, said the authorities should have reopened the forest after preparing it fully for the tourists, otherwise, it brings a bad reputation for the sanctuary when visitors coming from outside the state are turned away. "Tourists spend time and money on vacations. If it does not fructify due to lack of preparedness by the management, it is not good. Also, there is no system for getting proper information. (CONTD. ON PAGE-2)



CNG price may go up ₹ 4-6 on input supply cut, excise duty cut to ease situation

ernment has slashed by up to 20 per cent the supplies of cheaper domestically produced natural gas to city retailers -- a move that may result in ₹ 4-6 per kg hike in the price of CNG sold to automobiles, unless excise duty on the fuel is cut, sources said.

Natural gas pumped from below the ground and from under the seabed from sites ranging from the Arabian Sea to Bay of Bengal within India is the raw material that is turned into CNG for sale to automobiles and piped cooking gas to households. Production from legacy fields, whose price is regulated by the government and which are used to feed city gas retailers, has been falling by up to 5 per cent annually due to natural decline that has set in. This has led to supply cuts to city gas retailers, four sources in know of the matter said.

While the input gas for piped cooking gas that households get is protected, the government has cut supply of raw material for CNG. Gas from legacy fields used to meet 90 per cent of the demand for CNG in May 2023 and has progressively fallen. The supply was cut to just 50.75 per cent of the CNG demand beginning October

Dollar-starved Maldives notifies new foreign currency rules

MALE, Oct 20: Dollar-starved Maldives has floated a new foreign currency regulation, limiting types of transactions allowed in foreign currency and imposing mandatory foreign currency exchange controls on tourism establishments

and banks. Maldivian economy appears to have taken a hit after calls to Indian tourists to avoid the picturesque island nation as a response to President Mohamed Muizzu's 'India Out' campaign last year.

Maldives last month averted a potential default on an Islamic bond payment after India extended a USD 50 million interest-free loan. With its forex reserves not matching its import bill, the island nation's central bank, Maldives Monetary Authority (MMA) on October 1 introduced a new regulation, requiring all foreign currency income generated by the tourism industry to be deposited in local banks. MMA, which had in August imposed a strict dollar limit as Maldives found itself in a dollar shortage, published the new rules in the local Dhivehi language.

The Foreign Currency Regulation (Regulation No: 2024/R-91) mandates that all transactions within Maldives must be conducted in Maldivian Rufiyaa (MVR), except for those explicitly allowed in foreign currency. It also provides for payment for goods and services, value for works, fees, charges, rent and wages be made in local currency and prohibits invoicing for these transactions in foreign currency, according to the new regulation and FAQ released by MMA. Transactions exempt include payments for exports, international transactions, remittance service providers and those that are legally mandated to settle in US

One of the options is for the government to cut excise duty on CNG. Currently, the central government levies a 14 per cent excise duty on CNG, which translates into ₹ 14-15 per kg. If this is cut, the retailers will not have to pass on the increased cost to consumers, they said. CNG price hike is also a political issue since Maharashtra goes to the polls next month and

Lack of promised domestic gas was the main reason for OPaL running into losses, sources said, adding that the government has now approved a package to revive the unit. This package includes promoter Oil and Natural Gas Corporation (ONGC) infusing additional ₹10,501 crore as equity and the unit being made available domestically produced natural gas.

The Union Cabinet approved the allocation of 3.44 mmscmd of domestic gas -- mostly coming from new wells of ONGC. This led to lesser gas being available for city gas retailers. Girish Kadam, Senior Vice President & Group Head -Corporate Ratings, Icra Ltd, said, "The APM gas allocation has been reduced for the CGD sector by 20 per cent of the current domestic gas consumption by the sector. The reduction in APM allocation will have to be replaced by more expensive HPHT gas or (imported) LNG, which will push the overall

Meeting 2030 target may push India's solar imports to \$30 bn per yr: GTRI

NEW DELHI, Oct 20: The country's target of installing 500 GW of renewable energy by 2030 may push solar equipment import bill to about USD 30 billion per year and increase dependence on Chinese goods, think tank GTRI said in a report on Sunday

It said developing a self-reliant solar manufacturing industry in India will require significant investment to create an integrated supply chain, especially in areas like polysilicon and wafer production. Without this, India may continue to face high import costs and struggle to meet its renewable energy goals.

India installed 15 GW of solar capacity in 2023-24, raising the total to 90.8 GW by September, compared to just 2.8 GW in 2014, it said. To meet the government's target of installing 500 GW of renewable energy by 2030, India needs to significantly ramp up installations to 65-70 GW each year, with over 80 per cent of this target expected to come from solar power, according to the Global Trade Research Initiative (GTRI).

"This target seems ambitious, particularly given India's reliance on imports, which could push solar import to USD 30 billion annually," it said. In 2023-24, India imported USD 7 billion worth of solar equipment, with China supplying 62.6 per cent.

China controls 97 per cent of



global polysilicon production and 80 per cent of solar module manufacturing, making it difficult for India or any country to compete due to lower prices from China. GTRI Founder Ajay Srivastava said while initiatives like the production-linked incentive (PLI) scheme aims to boost local manufacturing, impact is limited as it relies on large scale use of imported inputs.

The report said India's solar manufacturing industry is in early stages, with most projects relying on imported ready-to-use modules.

During the last fiscal year, ready-to-use solar modules' imports reached USD 4.4 billion. The country also imported solar cells worth USD 1.9 billion and USD 1 billion worth of other essential

parts such as inverters, and cables. junction boxes, transformers, and other electrical components needed for solar installations.

"Local production is import-dependent and mainly focuses on the final two stages. 90 per cent of solar manufacturing in India involves assembling solar modules from imported cells with 15 per cent local value addition," it said. It added that few Indian compa-

nies manufacture commercial scale solar cells from imported polysilicon or wafers that add 30-40 per cent value locally and no one produces solar cells from scratchusing silica sands.

'To cut down on imports, India needs to produce solar cells starting from silica refining, which involves costly and energy-intensive

polysilicon production and requires advanced technology," Srivastava said. He added that cheap imports disrupt local pricing and the country has to also locally produce aluminum frames, glass, and other materials, which will require strong R&D efforts and government support.

According to the report, China is India's largest supplier, providing USD 3.89 billion worth of solar cells and modules, which accounts for 62.6 per cent of total imports. It is followed by Vietnam (USD 1.02 billion -- 16.5 per cent), Malaysia (USD 549.8 million --8.9 per cent, and Thailand (USD) 248.8 million -- 4 per cent).

To reduce dependency on Chinese imports, India imposed a 40 per cent customs duty on solar modules and a 25 per cent duty on solar cells. However, imports from Vietnam, Malaysia, and Thailand are exempt from these tariffs under the India-Asean free trade agreement (FTA), provided they add at least 35 per cent value to the imported inputs used in their export products.

The think tank has suggested seven steps to boost domestic manufacturing and cut imports and that includes pushing investments in upstream solar production, from raw materials like silica sand to finished solar panels, reducing dependency on imported wafers, polysilicon, and cells. (PTI)

Mid- and small-cap MFs attract ₹ 30,350 cr in H1 FY25 on strong returns

NEW DELHI, Oct 20: Mid-cap and small-cap mutual fund schemes have continued to attract strong investor interest, garnering nearly ₹ 30,350 crore in inflows during the April-September period of the current financial year, driven by impressive returns delivered by these segments.

In comparison, the cumulative inflow into mid-cap and small-cap funds stood at ₹ 32,924 crore during the same period last year, according to data from the Association of Mutual Funds in India (Amfi).

The inflow trend persists despite concerns raised by market regulator Sebi over heightened inflows into small-cap and mid-cap funds, as experts believe investors will continue to favour these categories for their potential to deliver high returns.

"Small caps will continue to grow at a faster rate for years to come. I expect the inflows to continue as Indians want to invest in the high-growth sectors. Small cap funds should be seen as an integral part of one's portfolio allocation and not a tactical play," Trust Mutual Fund CEO Sandeep Bagla told PTI.

Individually, mid-cap funds saw an inflow of ₹14,756 crore and small-cap funds attracted ₹ 15,586 crore in the first half of FY25. This aggregates the total inflow to ₹ 30,342 crore, the data showed.

The strong investor interest in mid-cap and smallcap mutual funds is driven by the potential for high returns in these segments, Tradejini COO Trivesh said.

Mid-cap and small-cap indices have posted gains of about 20 per cent and 24 per cent, respectively, this financial year, outperforming both the Nifty and largecap indices. While the previous year saw even higher returns that led to higher inflows, the current performance continues to draw investor interest.

In addition, stress test in March 2024 has also played a role, reinforcing confidence by ensuring that fund managers are prepared to handle market volatility, Feroze Azeez, Deputy CEO, Anand Rathi Wealth Ltd, said. "With the mid-cap and small-cap segments projected to grow at 20 per cent and 25 per cent, respectively, in FY25, we expect inflows to remain



strong, especially as SIP inflows continue to hit new peaks," he said.

Moreover, companies' earnings will drive flows in these categories. The last year has seen mutual funds launch new fund offerings (NFOs) of thematic funds and newer fund management strategies in the passive fund management space. If these NFOs deliver above broader market returns, we may see incremental flows moving to those categories, Manish Kothari, Co-Founder and CEO, ZFunds, said.

If there is a correction in the broader markets, we may see flows in mid- and small-cap category mutual fund schemes go down, he added.

Large-cap mutual funds experienced an inflow of over ₹ 7,067 crore in the April-September period of FY25 after witnessing an outflow of ₹ 5,700 crore in the same period of FY24.

In line with the increase in inflow, the number of investors (folios) in the two schemes shot up by 1.32 crore year-on-year to nearly 4 crore in the six months period ended September 30, 2024.

"With the number of folios increasing, we see rising confidence in these funds' performance, despite the regulatory cautions," Tradejini's Trivesh said.

Overall, the assets of the two categories of the midcap and small-cap schemes rose 63 per cent to Rs 7.26 lakh crore at the end of September 2024 from Rs 4.44 lakh crore a year earlier. (PTI)

Apeksha Hospital achieves a significant breakthrough in affordable healthcare for the region

HT Correspondent DIBRUGARH, Oct 20: Afford-

able healthcare is becoming increasingly vital in India, particularly in smaller cities where infrastructure and medical expertise are often limited. However, Dibrugarh is now setting a new standard by overcoming these challenges.

On October 1, 2024, Apeksha Hospital made history by successfully completing the city's firstever kidney transplant, marking a significant leap forward for healthcare in the region. The young patient received a kidney donated by their mother, with the entire procedure completed at only 25 percent of the usual cost compared to larger hospitals outside Assam. This marks a milestone not only in terms of medical achievement but also in making advanced healthcare affordable for residents of smaller cities.

Lalduhoma had on October 17 said that his cabinet has affirmed that prices of petrol and diesel, which were hiked on September 1, would not be reduced.

Diplomacy at crucial juncture

Prime Minister Narendra Modi is attending the summit of the expanded BRICS block at Tatarstan city of Kazan in Russia on October 22 to 24 to be hosted by President Putin. This summit is of crucial importance for both the Indian PM as also the President Putin. Narendra Modi is attending it in a situation when he is facing diplomatic as well as political embarrassment at the hands of the western powers led by the USA over the government agency's alleged involvement with the killing of a Canadian national in Canada and also with the assassination attempt on another in USA. He has to get out of it and he needs friendly help from non-western nations. The open positioning of the US favouring Canada despite the country being the strategic partner of India in QUAD must have hurt the Indian PM who hoped high on Indo-US relationship and deserted the Global South in the recent years to endorse the western position on Israel in the current war, causing disappointment to the member nations of Global South. Distanced by India's allies of the developing world and rebuked by the western friends on Canada issue, Indian Prime Minister will be in the BRICS summit looking for a role in the emerging world order.

As regards President Putin, after a long gap, he is hosting this summit in the context of the Ukraine war, sanctions by the West and the indictment by the International Crime Court. Russia has withstood the sanctions in the last two years, economy has prospered. President Putin through this summit, will try to show to the west as also all the nations in the globe that Russia remains as a super power and it will remain so. At the Tatarstan summit, apart from the original five members Brazil, India, Russia, China and South Africa, five more new members - Egypt, Ethiopia, Iran, Saudi Arabia and United Arab Emirates (UAE) will be attending for the first time. Apart, President Putin has invited more than two dozen other countries that have applied for or are considering membership of this expanding bloc which is now the largest bloc in terms of economic strength. The theme for this summit is' Strengthening Multilateralism For Just Global Development And Security'. Prime Minister will be in the summit city for two days on October 22 and 23. Apart from conference deliberations, three bilateral meetings are very important. First with the Chinese President Xi Jinping, then President Putin and the third most important bilateral talks will be with the President of Iran. Though the programmes for the bilateral talks have not all been officially announced, it is quite likely that all these meetings will be held because the discussions are important for both sides. As regards China, Prime Minister Modi will be getting a chance to put the Indo-China bilateral relations in proper perspective focusing on the border issue which is still an irritant blocking the process of growth of bilateral relations.

There is a communication gap between the two and both the leading Asian nations are carrying a stigma which goes back to late 1950s. The world has changed fundamentally since then. Now is the time to look at the bilateral relations from a new angle of cooperation with competition. A small beginning can take place at the Modi-Xi meeting if both heads assert the requisite political will. As regards Russia, President Putin has remained a trusted friend of India carrying the legacy of the Soviet period on relationship with India. That India is in a better position in 2024 in terms of the balance of payment and inflationary pressures, is mostly due to the cheap crude supplies by Russia in the last two years. Prime Minister Narendra Modi has to do some rethinking on the twists and turns of Indian diplomacy in the recent years directed by him and the PMO marginalizing the experienced officials of the external affairs ministry. Jaishankar's visit to Pakistan and the future of India-Pakistan relations

The optics surrounding Indian External Affairs Minister S. Jaishankar's visit to Islamabad have stirred both intrigue and optimism, especially given the strained relations between India and Pakistan over the last decade. This visit, which took place during the Shanghai Cooperation Organisation (SCO) summit, marked the first time in nine years that an Indian foreign minister had set foot in Pakistan. For many, the personal warmth displayed in Jaishankar's meetings with Pakistan's Finance Minister Ishaq Dar and Interior Minister Mohsin Naqvi stood out in sharp contrast to the frostiness that has traditionally defined India-Pakistan relations.

However, to interpret this newfound cordiality as a breakthrough in national ties might be premature. The delicate dance of diplomatic civility, though essential, often masks the complex and thorny realities of geopolitics. While Jaishankar's visit may signal an easing of tensions, it would be a stretch to suggest that it heralds a fundamental shift in India-Pakistan relations, especially given the entrenched issues that remain unresolved. Diplomatic niceties, though encouraging, cannot alone heal the deep wounds caused by years of conflict, terrorism, and mistrust between these two nuclear-armed neighbors.

The Diplomatic Constraints Despite the apparent cordiality of Jaishankar's visit, it is crucial to recognize that significant diplomatic shifts are typically beyond the purview of foreign ministers. The trajectory of India-Pakistan relations is shaped primarily by the heads of state and their political will, which, for now, remains stunted by mutual suspicion. Any substantial improvement in ties will require the involvement of top leadership from both countries, a prospect that appears unlikely in the short term given the ongoing challenges surrounding issues like terrorism and border

Though Jaishankar adhered to the SCO charter, refraining from addressing bilateral issues dirorism, extremism, and separatism were unmistakable. These remarks, aimed at Pakistan and China, signaled India's unwavering stance on cross-border terrorism and the sovereignty violations that continue to impede relations. This was not surprising, given that recent rhetoric from Indian officials, including the home and defense ministers, has made it clear that any dialogue with Pakistan would be contingent upon Islamabad's concrete actions to curb terrorism—a demand that India has repeatedly raised over the years

The Shadow of Cross-Border Terrorism

India's hardline stance on terrorism has become a cornerstone of its foreign

From Delhi's perspective, Pakistan has consistently failed to dismantle the terrorist networks operating within its borders, some of which are believed to enjoy the tacit support of the Pakistan Army and intelligence agencies. These concerns were once again underscored during Jaishankar's visit, when he made it clear that terrorism, extremism, and separatism are roadblocks to regional peace and cooperation.

The Indian government has repeatedly called for Pakistan to create the "right conditions" for dialogue, a euphemism for taking serious action against terrorist groups that target India. The ball, as they say, is firmly in Pakistan's court. Until Islamabad demonstrates a genuine commitment to curbing terrorism, any attempts at dialogue or rapprochement are likely to be superficial at best.

The Role of Cricket Diplo-

Among the various subtexts of Jaishankar's visit, one that garnered significant attention was the potential revival of cricketing ties between India and Pakistan. With Mohsin Naqvi, who is also the chairman of the Pakistan Cricket Board, playing host to the meeting, there was speculation that the rectly, his veiled references to ter- topic of India's participation in

the upcoming 2025 ICC Champions Trophy, set to be held in Pakistan, was discussed. Although the Indian government officially denied any such conversation, it is hard to imagine that

cricket, one of the few areas where India and Pakistan have historically found common ground, did not come up during their interactions.

Cricketing ties between India and Pakistan have long been seen as a potential ice-breaker in their otherwise fraught relationship. Historically, cricket has often served as a bridge, fostering a sense of camaraderie and competition that transcends political tensions. The last time India played in Pakistan was in 2008, and since then, bilateral cricketing ties have been suspended, largely due to security concerns following the 2009 Lahore attack on the Sri Lankan cricket team.

The question now is whether India will agree to send its cricket team to Pakistan for the Champions Trophy in 2025. Such a decision would undoubtedly require a thorough assessment of security risks, as well as a political calculation about the optics of engaging with Pakistan in a high-profile international event. While cricket diplomacy may not resolve the deep-rooted issues between the two nations, it could pave the way for further dialogue and cooperation in other areas.

The SCO Summit and the Jaishankar's participation in the

The Supreme Court's citizenship ruling

SCO summit also provided a platform for India to address its concerns with China, another regional rival. Over the past few vears, India's relationship with China has deteriorated significantly, primarily due to border clashes along the Line of Actual Control (LAC) and Beijing's increasing assertiveness in the region. During his address at the summit, Jaishankar subtly alluded to China's unilateral actions at the border, framing them as a violation of trust and good neighborli-

In recent months, India has taken a more assertive stance in its dealings with China, particularly following the Galwan Valley clash in 2020, which resulted in the deaths of 20 Indian soldiers. While the SCO summit provided an opportunity for India to engage with China diplomatically, the trust deficit between the two nations remains significant. Jaishankar's remarks at the summit underscored India's insistence on respecting sovereignty and territorial integrity, signaling that any rapprochement with China would require Beijing to take tangible steps to address India's security concerns

The Way Forward: Limited Engagement and Realistic Ex-

While Jaishankar's visit to Islamabad may not result in an immediate thaw in India-Pakistan relations, it does mark a step forward in maintaining limited engagement between the two countries. The smooth completion of the visit, devoid of the usual

rhetorical fireworks, suggests that both sides are willing to keep the channels of communication open, even if substantive dialogue re-

mains elusive. For India, the challenge lies in balancing its principled stance on terrorism and border security with the need to engage diplomatically with Pakistan. While cricket diplomacy and informal meetings at international forums like the SCO may provide a starting point for rebuilding trust, they cannot substitute for the hard political decisions that will ultimately determine the future of India-Pakistan

In the end, any progress in relations between the two countries will depend on a combination of diplomatic efforts, confidencebuilding measures, and, most importantly, political will at the highest levels of leadership. For now, the ball is in Pakistan's court. Whether Islamabad is willing or able to take the necessary steps to address India's concerns remains to be seen. But for the moment, Jaishankar's visit has at least created a sliver of hope that the deep freeze in bilateral relations might be starting to thaw, even if only a little.

S. Jaishankar's recent visit to Pakistan for the SCO summit is an important moment in India's foreign policy. While it would be premature to call it a breakthrough, the visit has at least laid the groundwork for future engagement between the two nations. The geopolitical dynamics of the region remain complex, with terrorism, border disputes, and China's role all playing a part in shaping the future of India-Pakistan relations. However, the personal warmth displayed during Jaishankar's meetings, the potential for renewed cricketing ties, and the measured tone of the SCO summit suggest that there may be room for cautious optimism moving forward. Whether this optimism translates into real diplomatic progress, however, will depend on the actions of both India and Pakistan in the coming months. (The writer can be reached

How will Delhi react to Sheikh Hasina's arrest warrant?

he International Crimes Triinal (ICI) in Bangladesh has issued a warrant of arrest against the Iron Lady Sheikh Hasina to surrender by November 18. Her autocratic regime collapsed on August 5 after a 36-day-long countrywide student-led bloody Monsoon Revolution, which killed more than 700 students and protesters. The cases against Hasina have held her responsible for the deaths of hundreds of students and protesters in the anti-government street demonstration, which turned violent. When she announced that the doors of Gonobhaban, the official residence of the Prime Minister were open for the student leaders, it was too late and too little.

Instead of negotiating with the student protesters, she ordered the police to shoot, kill and detain protesters. More than 10,000 protesters were bundled in prison vans and taken to magistrate courts accused of terrorism. The ICT was established in Hasina's tenure for the trial of those who have committed crimes against humanity during the brutal birth of Bangladesh in the 1971 liberation war. The majority of the indicted persons were Islamist political leaders, a few police and local village elites. It was believed that political Islam would come to an end after the trial.

Hasina has been squarely blamed for indulging political leaders, party henchmen, and civil and police administration into kleptocracy. All the Prime Minister's men were involved in money laundering, siphoning money from banks, buying properties in foreign countries, stashing money in off-shore banks and procuring second-country resident permits and dual citizenship after depositing millions of dollars in various countries.

After the ICT has issued a warrant of arrest, it is time to observe how Delhi's South Block will react to the pressing issue. International media has already made screaming news of the arrest warrant against Hasina and others. She is presently living in a safe house on the fringes of New Delhi, the capital of India.

She fled Bangladesh on August 5 by a Bangladesh Air Force transport aircraft from Kurmitola Air Force base in Dhaka. On her arrival, Ajit Doval, the National Se-

curity Adviser to the Indian government, met her at the Hindan Air Force Base at Ghaziabad, not far

No senior officials of Indian Prime Minister Narendra Modi's administration have met her at the safe house since she arrived more than two months ago. Her Red Passport, a diplomatic travel document and her Deshi Green Passport, have been revoked by the Interim Government, The United States and several countries in Europe and the United Kingdom have refused her entry.

Meanwhile, even after 73 days, more than two months Hasina's eldest son Sajeeb Wazed Joy, living in Washington DC, USA, and her daughter Saima Wazed Putul have been unable to meet her.

Saima, who is working in Delhi as Saima Wazed, has been serving as the South East Asian Regional Director for the World Health Organisation (WHO) since November 2023 and lamented in her Twitter (X) that she has not been able to hug her and wrote a strange message that she is too busy in her workplace, series of planning meetings, meeting delegations and visit to several countries.

A high-profile Indian journalist who was with Ajit Doval's outfit National Security Council, who is privy to the issue and does not wish to be named, said Delhi South Block has unofficially explored possibilities with a few countries for her stay in a third country.

Hasina is literally stranded in India and has nowhere to go. Delhi bigwigs are in dilemma about what should be their next step after India's friendly countries did not respond to requests. Well, it is too early for the Indian government to react as they will have to wait and see what is likely to happen after the deadline for appearance at the ICT expires.

Delhi will have to further wait for the verdict against the cases against Hasina to be delivered by the ICT. It is not likely before another year or more, as defence lawyers will appeal to the higher court against the verdict, which will take several additional months. The Supreme Court's ruling on citizenship in Assam is one of the most significant legal interventions in the state's history, shaping not only the state's future but also the broader discourse on citizenship in India. The judgment pertains to the contentious issue of illegal migration from Bangladesh and its impact on Assam's demographics, identity, and political landscape. The court's decision specifically addressed the provisions of Section 6A of the Citizenship Act, 1955, and reaffirmed the cutoff date of March 25, 1971, as a critical reference point for determining citizenship in Assam. This ruling, while aimed at providing clarity and legal finality, has also sparked widespread debates on its implications for those directly affected, as well as the future of Assam's socio-political fabric.

To understand the Supreme Court's ruling, it is necessary to examine the historical context that has shaped Assam's citizenship issues. Assam has long been a site of tension regarding immigration, particularly from the eastern borders. The partition of India in 1947 and the subsequent formation of East Pakistan (now Bangladesh) led to waves of migration into Assam, as people sought refuge from communal violence, political instability, and economic hard-

However, this migration brought with it fears among the indigenous Assamese population of being overrun by outsiders, leading to a growing sense of insecurity about their cultural identity and demographic dominance.

The tension surrounding illegal immigration reached its peak in the 1970s, particularly after the Bangladesh Liberation War of 1971, which saw an influx of refugees into Assam. Many locals felt overwhelmed by the numbers and began agitating against what they perceived as the dilution of their identity. This discontent eventually culminated in the Assam Movement, a powerful six-year-long campaign (1979-1985) that demanded the detection, deletion, and deportation of illegal immigrants.

The movement garnered widespread sup-

port among the indigenous Assamese and placed immense pressure on both state and central governments to address the issue of illegal immigration.

The Assam Accord, signed in 1985, was the outcome of negotiations between the leaders of the Assam Movement and the Indian government. It was intended to bring peace to the state by addressing the immigration issue in a manner acceptable to both

One of the key provisions of the Accord was the establishment of March 25, 1971, as the cutoff date for determining citizenship. This meant that all individuals who had entered Assam from Bangladesh before this date were to be considered Indian citizens, while those who arrived after would be treated as illegal immigrants and face deportation. Section 6A of the Citizenship Act was introduced in 1985 to give legal backing to this provision, creating a framework for identifying and addressing illegal immigration in Assam.

However, this framework has remained highly contentious. Many indigenous Assamese continue to believe that the cutoff date is too lenient and does not adequately protect their interests, as they argue that illegal migration has continued even after

On the other hand, those who migrated before and after the cutoff date have lived in Assam for decades, integrating themselves into the social, economic, and political life of the state. For these communities, the idea of being labeled as illegal immigrants and facing the threat of deportation is deeply unsettling, as it questions their identity and place in the state they now call

The Supreme Court's ruling on Section 6A and the cutoff date must be understood within this broader context of demographic anxiety, historical migration patterns, and legal provisions. Over the years, numerous petitions have been filed in the Supreme Court challenging the constitutionality of Section 6A and the Assam Accord. These petitions raised concerns about the discriminatory nature of the cutoff date, arguing that it effectively created two classes of cit-

izens and violated the principles of equality and justice enshrined in the Indian Consti-

Moreover, questions were raised about whether the central government had the authority to sign an accord that altered the citizenship status of individuals in a particular

In its landmark judgment, the Supreme Court upheld the constitutionality of Section 6A, reaffirming the validity of the March 25, 1971, cutoff date. The court's ruling emphasized the unique historical and social context of Assam, arguing that the provisions of Section 6A were a necessary compromise to address the state's specific challenges related to illegal immigration.

The court noted that while citizenship laws must be applied uniformly across the country, exceptions could be made in cases where there were compelling historical and social reasons for doing so. In Assam's case, the massive influx of refugees during the Bangladesh Liberation War and the subsequent social unrest justified the need for a separate legal framework.

The court's decision was seen as a victory for those who support the Assam Accord and its provisions. For these groups, the ruling provided legal clarity and reaffirmed the importance of the cutoff date in maintaining the demographic balance of the state. The court's endorsement of Section 6A was viewed as a step toward ensuring that Assam's indigenous communities would not be overwhelmed by illegal immigration and that the state's cultural identity would be preserved.

However, the ruling has also raised significant concerns, particularly among the communities affected by the cutoff date. For those who arrived in Assam after March 25, 1971, the court's decision represents a continuation of their uncertain legal status. Many of these individuals and families have lived in Assam for decades, raising generations in the state and contributing to its economy and social fabric.

The prospect of being labeled illegal immigrants, facing deportation, or being sent to detention centers is deeply distressing for them. Moreover, the process of proving citizenship through documentation is often fraught with difficulties, as many marginalized communities lack the necessary records to substantiate their claims.

The ruling also places immense pressure on the state machinery to implement the provisions of the Assam Accord effectively. The National Register of Citizens (NRC), a key mechanism for identifying illegal immigrants in Assam, has already proven to be a highly contentious exercise. The 2019 NRC update left out nearly two million people from the final list, sparking wide-

spread protests and legal challenges. Many of those excluded from the NRC were individuals who had lived in Assam for decades but were unable to provide the necessary documentation to prove their citizenship. The Supreme Court's ruling, by reaffirming the cutoff date, has renewed concerns about the potential for further exclusions and the bureaucratic hurdles individuals may face in proving their status.

Furthermore, the court's judgment has broader political and social implications for Assam and India as a whole. The issue of illegal immigration has long been a politically charged topic in Assam, with various parties using it as a rallying point to mobilize support. The Supreme Court's ruling is likely to intensify political debates around immigration, identity, and citizenship in the state. It may embolden political factions that advocate for stricter immigration policies and push for more stringent measures to identify and deport illegal immigrants. At the same time, the ruling may also fuel opposition from those who argue for more inclusive and humane approaches to citizenship, particularly for individuals who have already settled in Assam and made it their home.

On a national level, the Supreme Court's judgment on Assam's citizenship issues is likely to have ripple effects on debates about immigration and citizenship across India. The controversy surrounding the Citizenship Amendment Act (CAA), passed by the Indian government in 2019, has already sparked widespread protests and raised concerns about the future of citizenship in the country. While the CAA does not directly affect Assam's cutoff date, it has added another layer of complexity to the already fraught citizenship landscape in the state. The Supreme Court's ruling on Section 6A could serve as a precedent for future legal challenges to the CAA and other citizenship-related laws, influencing the broader discourse on immigration and identity in India.

At the end, the Supreme Court's ruling on Section 6A of the Citizenship Act and the March 25, 1971, cutoff date is a landmark decision that will shape the future of Assam's citizenship landscape. While the ruling provides legal clarity and reaffirms the provisions of the Assam Accord, it also raises significant concerns about the rights and status of individuals affected by the cutoff date. As Assam moves forward, the implementation of the court's ruling will require careful balancing of legal, social, and political considerations.

The challenge lies in ensuring that the citizenship process is fair, transparent, and respectful of human rights while addressing the legitimate concerns of the indigenous population. Ultimately, the court's decision underscores the need for continued dialogue and engagement on the complex issues of citizenship and identity in Assam and beyond. 

Why are my hands shaking? Causes, is it normal, and remedies

Tremors are involuntary muscle contractions that cause body parts to tremble. Hand tremors are common and are often due to stress or tiredness. They may also indicate several health conditions. For some people, shaky hands may be a minor inconvenience. For others, the symptom may lead to difficulty using the hands for everyday

This article describes what tremors are, outlines some potential causes of shaky hands, and asks whether it is common. We also provide tips on how to stop the hands from shaking and discuss some of the treatment options available.

What are tremors?

Tremors are involuntary, rhythmic muscle contractions that make a body part appear to be shaking or trembling. Everyone has a slight tremor when moving or maintaining a particular posture.

They are often so small that a person does not see or notice them. Hand tremors may be more noticeable when a person holds their hands out straight in front of the body or when they are stressed or anxious.

Tremors mostly affect the hands. However, it can also occur in other body parts, such as:

- the head
- the arms • the legs
- the torso
- the voice box (larynx), which may cause a shaky voice

There are several types of tremors. However, most fall into two categories: **Resting tremors:** These occur when the muscles are relaxed, including when

the hands are resting on the lap. **Action tremors:** These occur when the muscles are contracted due to voluntary movement. The majority of tremors

are action tremors. Sometimes, tremors can indicate an underlying health issue, especially if they are persistent or very pronounced.

What are the causes of shaky hands?

Tremors can be normal or could result from neurological conditions, other health problems, or medication use. Below are some potential causes of hand

Enhanced physiologic tremor

Enhanced physiologic tremor (EPT) is perhaps the most commonly observed postural tremor. It usually affects the hands and fingers on both sides of the

The following may worsen EPT in some people:

- stress anxietv
- fatigue
- lack of sleep

· overactive thyroid

- excessive caffeine intake • vigorous exercise

Parkinson's disease (PD): About who experience tremors due to anxiety

75% of people with PD have tremors, whether resting, action, or mixed. Tremors usually begin on one side of the body, and may spread to the opposite side. Shaking may become more pronounced during periods of stress or strong emotion. Stroke: After a stroke, a person can

show a variety of tremors depending on the area affected. Damage to the basal ganglia causes a person to have resting tremors, while damage to the cerebellum causes intention tremors

Traumatic brain injury (TBI): Tremor as a consequence of TBI is called post-traumatic tremor (PTT). A 2020 study found that PTT happens as a result of damage to specific brain areas responsible for movement. These tremors are uncommon.

Dystonia: A 2021 study stated that dystonia and tremor are closely linked. Tremors occurring in people with dystonia are either jerky and irregular, regular and wave-like, or mixed. Mixed types commonly affect the hands Other health conditions

The following health conditions can

- also cause shaky hands: · alcohol misuse or withdrawal
- mercury poisoning
- hyperthyroidism
- liver or kidney failure • stress, anxiety, or fatigue
- · psychiatric conditions, such as posttraumatic stress disorder · inherited degenerative disorders,
- such as hereditary ataxia or fragile X svndrome Medications

Certain drugs can also cause hand tremors. Examples include:

- · some asthma medications
- drugs for psychiatric conditions, such as certain antidepressants and mood sta-
- · seizure medications, such as valproate (Depakene) and valproic acid

Surgery

In severe cases where medication and other treatments are ineffective, surgical options like deep brain stimulation (DBS) or radiofrequency ablation may be recommended.

DBS surgery sees a doctor place a small generator under the skin in the upper chest. The generator sends electrical signals to electrodes implanted in the thalamus, which is the part of the brain that coordinates and controls some involuntary movements.

Radiofrequency ablation involves using an electric current to heat nerve tissue in order to disrupt its ability to relay signals for several months.

uicide is one of the leading causes of untimely unnatural death, especially among teenagers and people below the age of thirty. It is the act of intentionally giving up one's own life for various reasons. It is one of the leading causes of death.

Psychological conditions, such as depression, anxiety, failure to achieve targeted mission, loss of joy in life, reduced problem-solving ability, impairment in emotional regulation etc. increase the risk of suicide. Factors such as unemployment, poverty, discrimination, homelessness, encourage the risk of suicide.

Doctors and psychologists consider the suicide attempts as a series of symptoms of depression. The person having high moral strength soon recover from depression and lead a normal life; but the discouraged people succumb to the challenging situation and eventually take their own lives. It is often associated with mental illness, bipolar disorder, personality disorder, schizophrenia, autism, obesity-related disorder, post-traumatic stress

People suffering from cancer, AIDS and other chronic painful diseases end their lives. Sometimes family problems also become the reasonfor suicide. Presently a large number of students are ending their lives either due to low grading or not being able to compete in competitive

According to ICMR report about 12% of Indian students suffer from psychological, emotional and behavioural conditions, 63% students are stressed due to academic pressure and 56% have symptoms of anxiety. 29% students lack concentration and 43% have mood

Constant use of smartphones has led to mental health issues developing in the students. Our education system does not impart moral and ethical values to students. These situations lead to suicide attempts and country

loses young minds. WHO says that India is the most depressed country in the world. One in four Indian children in 13-15 agegroups suffer from depression. One in seven Indians between 15-24 age groups feel depressed and lack interest in doing things. In India, the National Crime Records Bureau (NCRB) statistics show a consistent rise in suicide rate from 9.9 per lakh population in 2017 to 12.4 per lakh population in 2022, ranging from 0.6 per lakh population in Bihar to 43.1 per lakh population in Sikkim.

As per WHO report, more than 700000 people die by suicide every year worldwide. Approximately 1.5% of all deaths worldwide are by suicide. 77% of suicides occurin low and middle-income countries. Although suicide deaths are underreported in many countries due to social, cultural, and legal concerns.

Economic condition is also one of the causes of suicide. As per a report, in 64% of the suicide cases, the person's income has been found below ₹ 1 lakh, while in 32% of the cases the income has been only ₹1 lakh to ₹

5 lakh. Women have higher rates of suicidal thinking, nonfatal suicidal behaviour, and suicide attempts. Suicide statistics show that although suicide attempt rate is about 3 times higher in women, but the suicide death rate is 2 to 3 times higher among men than women. Men chose violent suicide methods such as firearms, asphyxiation hanging etc, whereas women are more likely to self-poisoning, exsanguination etc.

Attempted suicide is a crime in many countries. Assisted suicide is when a person helps another person to die either by advice or any other means. In this case the person assisting is more responsible. In some countries and jurisdictions, helping a person to die is illegal. Physician Assisted Suicide (PAS) is an end-to-life measure for a person suffering from a painful, terminal illness. In some countries, PAS is legal under certain circumstances, whereas in some counties it is illegal.

Suicide is a global phenomenon and occurs throughout e lifespan. Hence, effective and evidence-based ventions are needed to prevent it. Individuals, families, and societies must play constructive role to save lives and create healthy and strong citizens. Most people who are contemplating suicide do not know who to speak to. Talking openly can give the concerned people other options or time to rethink their decision, thus preventing

Israeli strikes on northern Gaza leave at least 87 dead or missing, Palestinian officials say

DEIR AL-BALAH (GAZA STRIP), Oct 20: Israeli strikes on multiple homes in the northern Gaza Strip overnight and into Sunday left at least 87 people dead or missing, the territory's Health Ministry said.

It said another 40 people were wounded in the strikes on the town of Beit Lahiya, which was among the first targets of Israel's ground invasion nearly a year ago. The Israeli military said it carried out a precise strike on a Hamas target.

Israel has been carrying out a large-scale operation in northern Gaza for the last two weeks, saying Hamas has regrouped there. Palestinian officials say hundreds of people have been killed and that the health sector in the north is on the verge of collapse.

The United States is meanwhile investigating an unauthorised release of classified documents that assess Israel's plans to attack Iran, according to three US officials. A fourth US official said the documents appear to be legitimate.

The documents, attributed to the

and National Security Agency and marked top secret, indicate that Israel was moving military assets in place to conduct a military strike in response to Iran's ballistic missile attack on Oct 1.

The US officials spoke on the condition of anonymity because they were not authorised to discuss the matter publicly.

The US is urging Israel to press for a cease-fire in Gaza following the killing of Hamas leader Yahya Sinwar last week. But neither Israel nor Hamas has shown any renewed interest in such a deal, after months of negotiations sputtered to a halt in August.

Lebanese army says 3 soldiers killed in Israeli strike

Iran supports Hamas and the Hezbollah militant group in Lebanon, where a year of escalating tensions boiled over into allout war last month. Israel sent ground troops into Lebanon at the start of October.

The Lebanese army said three of its soldiers were killed in an Israeli strike on their vehicle in southern Lebanon. There was no immediate

on Sunday's strike.

Lebanon's army has largely kept to the sidelines in the war between Israel and the Hezbollah. The military is a respected institution in Lebanon but is not powerful enough to impose its will on Hezbollah or defend the country from an Israeli invasion.

On Saturday, a drone targeted Israeli Prime Minister Benjamin Netanyahu's house, causing no casualties. It wasn't clear if the house was hit. The military said Hezbollah fired around 160 projectiles into Israel on Sunday. There were no immediate reports of ca-

Large Israeli operation in northern Gaza enters third week

Israel has been carrying out a major operation in Jabaliya, also in northern Gaza, for the last two weeks. The military says it launched the operation against Hamas militants who had regrouped there.

Over the course of the war, Israeli forces have repeatedly returned to Jabaliya, a densely populated urban refugee camp dating back to the 1948 war surrounding Israel's creation.

The north has already suffered the heaviest destruction of the war, and has been encircled by Israeli forces since late last year, follow-

Israel ordered the entire population of the northern third of Gaza, including Gaza City, to evacuate to the south in the opening weeks of the war and reiterated those instructions earlier this month. Most of the population fled last year, but around 400,000 people are believed to have remained in the

Palestinians who fled the north at the start of the war have not been allowed to return.

On Oct 7, 2023, Hamas-led militants blew holes in Israel's security fence and stormed in, killing some 1,200 people, mostly civilians, and abducting another 250. Around 100 captives are still being held in Gaza, a third of whom are believed to be dead.

Israel's offensive in Gaza has killed over 42,000 Palestinians, according to local health authorities, who do not distinguish combatants from civilians. The war has destroyed large areas of Gaza and displaced about 90% of its population of 2.3 million people. (AP)

Indonesia swears in ex-general Prabowo Subianto as president

Subianto was inaugurated Sunday as the eighth president of the world's most populous Muslimmajority nation, completing his journey from an ex-general accused of rights abuses during the dark days of Indonesia's military dictatorship to the presidential

The former defence minister, who turned 73 on Thursday, was cheered through the streets by thousands of waving supporters after taking his oath on the Ouran in front of lawmakers and foreign dignitaries. Banners and billboards filled the streets of the capital, Jakarta, where tens of thousands gathered for festivities.

Wearing a blue Betawi traditional cloth and a dark baseball cap, Subianto stood up in the sunroof of a white van and waved, occasionally shaking people's hands, as his motorcade struggled to pass through the thousands of supporters calling his name and chanting "Good luck Prabowo-Gibran," filling the road leading from the parliament building to the presidential palace.

"I see a firm and patriotic figure in him," said Atalaric Eka Prayoga, 25. "That's a figure we need to lead Indonesia.

Another resident, Silky Putri, said he hopes Subianto "can build Indonesia to be more advanced and improve the current gloomy economic situation"

Subianto was a longtime rival of the immensely popular President Joko Widodo, who ran against him for the presidency twice and refused to accept his defeat on both occasions, in 2014 and 2019.

But Widodo appointed Subianto



as defense chief after his reelection, paving the way for an alliance despite their rival political parties. During the campaign, Subianto ran as the popular outgoing president's heir, vowing to continue signature policies like the construction of a multibillion-dollar new capital city and limits on exporting raw materials intended to boost domestic in-

Backed by Widodo, Subianto swept to a landslide victory in February's direct presidential election on promises of policy continuity.

Subianto was sworn in with his new vice president, 37-year-old Surakarta ex-Mayor Gibran Rakabuming Raka. He chose Raka, who is Widodo's son, as his running mate, with Widodo favouring Subianto over the candidate of his own former party. The former rivals became tacit allies, even though Indonesian presidents don't typically endorse candidates.

But how he'll govern the biggest economy in Southeast Asia where nearly 90% of Indonesia's 282 million people are Muslims remains uncertain after a campaign

lating Middle East tensions, instead deciding to send Foreign Affairs Minister Nancy Namrouga as his special envoy. Subianto and Abdullah met in person in June for talks in Amman on humanitarian assistance to people affected by the

war in Gaza. Subianto, who has never held elective office, will lead a massive, diverse archipelago nation whose economy has boomed amid strong global demand for its natural resources. But he'll have to contend with global economic distress and regional tensions in Asia, where territorial conflicts and the US-China rivalry loom large.

Leaders and senior officials from more than 30 countries flew in to attend the ceremony, including Chinese Vice President Han Zheng and leaders of Southeast Asia countries. US President Joe Biden sent Linda Thomas-Greenfield, the US ambassador to the United Nations. Adm Samuel Paparo, the US commander of the Indo-Pacific Command, was also among the American delegation.

Analysts and the media consider Subianto a leader with greater international awareness than Widodo. He's already held dozens of meetings with scores of foreign officials, said Adhi Priamarizki, a fellow researcher at Singapore's S Rajaratnam School of International Studies. He said that defence development was at the top of his list of priorities. Subianto has advocated an expansion of the military through the purchases of submarines, frigates and fighter jets and wants to initiate more defense cooperation with various countries,

Kyiv launches more than 100 drones over Russia

KYIV, Oct 20: Russian air defences shot down more than 100 Ukrainian drones Sunday over Russia's western regions, Moscow officials said, while 17 people were injured in the Ukrainian city of Kryvyi Rih in a ballistic missile

Such large-scale aerial attacks are still relatively rare over Russia 2 1/2 years after Moscow launched its full-scale invasion of Ukraine in

February 2022. The Russian Defence Ministry said 110 drones were destroyed in the overnight barrage against seven Russian regions. Many targeted Russia's border region of Kursk, where 43 drones were reportedly shot down.

Social media footage appeared to show air defences at work over the city of Dzerzhinsk in the Nizhny Novgorod region, close to a factory producing explosives. Local Governor Gleb Nikitin wrote on social media Sunday that four firefighters were injured repelling a drone attack over the city's industrial zone, but did not give further details.

Meanwhile, the General Staff of Ukraine's Armed Forces posted on Telegram that it targeted Dzerzhinsk's state-owned Sverdlov factory, which it said had been making chemical components for

bombs. It also said a drone sparked a fire at a military airfield in the Lipetsk region. The comments couldn't be independently verified by the Associated Press.

A similar attack at the end of September saw Russia's Ministry of Defense report the destruction of 125 drones across seven re-In Ukraine's Kryvyi Rih, 17

people were injured after two Russian ballistic missiles hit the city late Saturday evening, officials said Sunday. The attack damaged homes and businesses, said local administration head Oleksandr Vilkul.

Ukraine's air force said Russia launched 49 drones and two Iskander-M ballistic missiles in total overnight. It said 31 of the drones

were shot down over 12 regions, including the Ukrainian capital, Kyiv, while another 13 disappeared from radar - suggesting they were knocked out by electronic defences.

In a statement on social media, Ukrainian President Volodymyr Zelenskyy said that Russia had launched some 800 guided aerial bombs and more than 500 attack drones over Ukraine in the past week alone.

"Every day, Russia strikes our cities and communities. It is deliberate terror from the enemy against our people," he said, renewing calls for continued air support from the country's allies.

No anti-China activities will be allowed in Nepal's territory: PM Oli

KATHMANDU, Oct 20: Nepal's Prime Minister KP Sharma Oli said on Sunday that no anti-China activities will be allowed in the country, reaffirming the Himalayan nation's commitment to the 'One China' policy.

Oli made the remarks in a meeting with a high-level Chinese delegation led by Chen Jining, a member of the Communist Party of China's Central Committee. The meeting took place at his official residence in Baluwatar, Kathmandu. Reaffirming Nepal's commitment to the One China policy, Oli told the visiting delegation that no anti-China activities would be allowed to operate within Nepal's

China claims that the breakaway nation of Taiwan is part of it and makes it mandatory for all the countries having diplomatic ties with it to follow the 'One China' policy, which effectively states that Taiwan is part of China.

During the meeting, Oli also expressed hopes for continued support from China for Nepal's economic development.

Talks were also held about strengthening bilateral relations and enhancing collaboration between the Communist Party of China (CPC) and the Communist Party of Nepal (Unified Marxist-Leninist) parties, according to the PM's secretariat. Oli is the Chairman of the CPN (UML) and is seen as a pro-China leader.

He underlined the need to continue the exchange of high-level visits between the two countries to enhance government-to-government, people-to-people and historical ties, as well as to promote trade.

The Prime Minister underscored the role of the CPC and President Xi Jinping's leadership in "alleviating poverty and driving holistic development in China" and expressed Nepal's interest in benefiting from such advancements He also informed the delegation

Bangladesh SC reinstates Supreme

DHAKA, Oct 20: Bangladesh's Supreme Court on Sunday reinstated the Supreme Judicial Council with authority to investigate allegations of judicial misconduct, while upholding its previous ruling that declared the 16th constitutional amendment, which transferred the power of removing judges to parliament, as "illegal".

"The order was passed by a sixmember bench of the Supreme Court's apex Appellate Division led by Chief Justice Syed Refaat Ahmed," Supreme Court lawyer Ruhul Kuddus told reporters after the apex court announced its judgement. Kuddus, who was present in the hearing, said the ruling reinforced the original constitutional provisions.

The verdict also meant scrapping of the 16th constitutional amendment, passed during deposed prime minister Sheikh Hasina's regime, giving the task of impeaching judges to Parliament instead of the Supreme Judicial Council comprising apex court

Pakistan Cabinet approves controversial constitutional amendment bill

ISLAMABAD, Oct 20: The Pakistan Cabinet Sunday approved the proposed draft of the controversial 26th Constitutional Amendment during a meeting chaired by Prime Minister Shehbaz Sharif after seeking consensus from the coalition partners, his office said.

The coalition government is set to table the proposed judicial reforms bill in the Senate and the National Assembly on Sunday.

"The federal cabinet has approved the proposed draft of the 26th constitutional amendment of the government and its coalition parties, including the Pakistan Peoples Party," Dawn News reported, quoting a statement issued by the Prime Minister's Office.

Ahead of the cabinet meeting. Prime Minister Shehbaz met with President Asif Ali Zardari for detailed discussions on the proposed constitutional amendment, during which the president was briefed and consulted, Express News reported

After the meeting, Federal Minister Musadik Malik said the government approved its draft, which was prepared in collaboration with the Pakistan People's Party (PPP), the government, and coalition partners. The cabinet has officially endorsed the draft.

The coalition government is highly optimistic about getting the much-anticipated 26th Constitutional Amendment passed in parliament, Geo News reported.

A notification from the Senate secretariat said that the upper house session will commence at 3 pm. The National Assembly session will start at 6 pm, according to a separate notification from the NA secretariat.

Strict security arrangements have been made for today's session of the National Assembly, with guest entry strictly prohibited, according to the assembly's spokesperson.

On Saturday night, the bill was discussed with Pakistan People's Party (PPP) Chairman Bilawal Bhutto-Zardari and Jamiat Ulemae-Islam-Fazl (JUI-F) Maulana Fazlur Rehman.

The details of the amendments are still a mystery as the government has not officially shared it with the media or discussed it publically. What has been reported so far shows that the bill's alleged objective is to dilute the power of an independent judiciary.

Reports indicate that the government plans to raise the retirement age for judges and fix the tenure of the Chief Justice of the Supreme Court.

A constitutional amendment requires separate passage in the National Assembly and Senate, with a two-thirds majority vote.

Earlier, the government lacked the required numbers in the Senate and the National Assembly, However, Defence Minister Khawaja Asif has claimed that the government now has the support to reach the required numbers.

Maulana Rehman of JUI-F, in a late-night talk with the media along with Bilawal, said his party would support the 26th constitutional amendment after receiving a response from the Pakistan Tehreek-e-Insaf (PTI) and sought a day for further deliberation. (PTI)

US investigating unauthorized release of classified documents on Israel attack plans

WASHINGTON, Oct 20: The US is investigating an unauthorized release of classified documents that assess Israel's plans to attack Iran, three US officials told The Associated Press. A fourth US official said the documents appear to be legitimate. The documents are attributed to the US Geospatial Intelligence Agency and National Security Agency and note that Israel continues to move military assets in place to conduct a military strike in response to Iran's blistering ballistic missile attack on Oct. 1. They were sharable within the "Five Eyes," which are the US, Great Britain, Canada, New Zealand and Australia. The documents, which are marked top secret, were posted online to Telegram and first reported by CNN and Axios. The officials spoke on the condition of anonymity because they were not authorized to discuss the matter publicly.

The investigation is also examining how the documents were obtained including whether it was an intentional leak by a member of the US intelligence community or obtained by another method, like a hack — and whether any other intelligence information was compromised, the official said. As part of that investigation, officials are working to determine who had access to the documents before they were posted, the official said. (AP)

Iraq's Kurdish region goes to polls with flagging economy

IRBIL, Oct 20: Residents of Iraq's semi-autonomous northern Kurdish region went to the polls in long-awaited parliamentary elections Sunday under the shadow of ongoing rivalries, economic instability, and unresolved disputes with Baghdad.

The primary competitors are the two dominant Kurdish parties: the Kurdistan Democratic Party and the Patriotic Union of Kurdistan. Historically, these two parties have controlled different parts of the region, with the KDP overseeing Irbil and Dohuk, and the PUK governing Sulaymaniyah.

This division has frequently led to political deadlock. The parliamentary elections, originally set for 2022, were postponed several times amid disputes over the election law and procedures. Ministry of Interior personnel and pesh-

merga forces — the regional military

voted in special elections Friday, with the general public voting Sunday. In Friday's special election, the KDP secured a significant lead, capturing 60 per

cent of the votes, while the PUK got around

30 per cent. The New Generation Movement, an opposition party that has seen a gradual rise in support, garnered 5.3 per cent of the total, up from 3 per cent in the 2018 special election. In that special election, the KDP garnered 40 per cent of the vote and the PUK 28.5 per cent.

While New Generation's appeal continues to grow, particularly among younger voters frustrated with the traditional political system, it still faces significant challenges in competing with the well-established dominance of the KDP and PUK.

The region's economic struggles are voters' primary concern. Despite its oil wealth, the Kurdish region faces significant economic issues, including delayed payment of salaries to civil servants, fluctuating oil prices, and budget cuts from Baghdad. The public is deeply dissatisfied with the economy and lack of opportunities, and many blame political leaders for mismanagement.

"People want to have electricity and get paid their salary on time, and to have more jobs. This is all they want," said Ghazi Najib, who went to the polls in Irbil.

Corruption is also among the central issues in the election. For years, the regional government has faced allegations of nepotism and lack of transparency. Many voters, particularly in the younger generation, are calling for reforms to address these con-

Many voters, however, have lost hope for reforms and are also sceptical of opposition parties' ability to make changes, given the long-standing hold the two major parties have over the political landscape.

Political cooperation with the central government is another key electoral issue. Relations between Irbil and Baghdad have remained tense since a 2017 referendum over independence for the Kurdish region, particularly over issues of oil revenue sharing and budget allocations.

Iraq Prime Minister Mohammed al-Sudani in a recent visit to Irbil said, "We are committed to ensuring the rights of the Kurdish people, but this must be done within

Iraq's constitution' In certain areas, the current elections are significantly influenced by security concerns since Islamic State sleeper cells are still active in areas that are disputed between the

regional and central governments. "We hope that Kurdistan will be more developed, and to see more safety and reconstruction in Kurdistan," said Jamila Mohammed Amin, a voter in Irbil, using the region's local name. "All political parties and entities should work together and achieve these goals and protect it against en-

The list includes 13 women candidates. The saffron party has retained 71 MLAs and dropped

Fadnavis is renominated from home turf Nagpur South West, Narwekar from Colaba in south Mumbai, and ministers Sudhir Mungantiwar, Girish Mahajan, and Chandrakant Patil from Ballarpur, Jamner, and Kothrud constituencies, respectively.

Mungantiwar had unsuccessfully contested the Lok Sabha election from Chnadrapur constituency which he lost to his nearest Con-



Out of 16 MLAs of BJP in Mumbai, the party has renominated 14 in the first list.

BJP's 'dirty politics' responsible for growing air, water pollution in Delhi: Atishi

NEW DELHI, Oct 20: The "dirty discharged by UP through various politics" of the BJP is responsible for growing air and water pollution in Delhi, Chief Minister Atishi said on Sunday.

The air quality in the national capital has started deteriorating with the onset of winter while thick layers of toxic chemical froth was seen covering the Yamuna river's surface at various places, especially Kalindikunj.

Atishi gave a clean chit to AAPruled Punjab and blamed 'parali' (paddy stubble) burning, diesel buses and brick kilns in BJP-ruled Haryana for poor air quality in

She also alleged that thousands of diesel buses from UP reaching the Kaushambi bus depot on the Delhi- Ghaziabad border, brick kilns in NCR and thermal plants in the region also contributed to air pollution in Delhi.

The Delhi chief minister slammed the BJP, saying the froth appearing on Yamuna in Delhi was because of untreated industrial wastewater released in Yamuna.

Haryana releases 165 million gallons per day (MGD) industrial untreated wastewater through Badshahpur, Mungeshpur and other drains into Yamuna, while 65 MGD of such polluted water is drains into the river, she said.

"The dirty politics of the BJP is responsible for growing air and water pollution in Delhi but AAP led by Arvind Kejriwal is committed to help people of the city," she

In a press conference, Atishi claimed the central government data showed Punjab reduced farm fires from 71,300 in 2021 to 36,600 in 2023.

"Even this year, the Indian Agricultural Research Institute data show that there was a 27 per cent decrease in parali burning in Punjab between October 1 and 15, from 1105 in 2023 to 811," she

Meanwhile, farm fires this year increased from 341 to 417 in Haryana, while in UP the number went up from 244 to 417, between October 1 and 15, as compared to the last year, she said.

"This clearly shows the dirty politics of the BJP. If the Punjab government can reduce parali burning, why can't the BJP governments in Haryana and UP do it?" she asked.

Sustained efforts by Bengal forced Centre's likely decision to exempt GST on health premium: Mamata



KOLKATA, Oct 20: West Bengal Chief Minister Mamata Banerjee claimed that the Centre's likely decision to exempt GST on term life insurance premiums and premiums paid by senior citizens for health coverage is the result of sustained efforts by the state government.

She said the central government appears to be "under pressure" to cut taxes to benefit the common people.

An official stated that term life insurance policies and health insurance premiums for senior citizens are likely to be exempt from GST, as most members of a state ministerial panel favoured tax cuts to benefit the

The GoM (Group of Ministers), which met on Saturday to decide on GST for health and life insurance premiums, chose to exempt GST on premiums paid by individuals, other than senior citizens, for health insurance coverage up to ₹ 5 lakh. However, 18 per cent GST will continue to be levied on health insurance coverage exceeding ₹ 5 lakh.

"Our sustained efforts appear to be paying dividends – the central government looks like it is being further pressured into finally succumbing to our demands to withdraw/modify the unjust 18 per cent GST on health and life insurance products/policies," Banerjee wrote on X on Sat-

The chief minister, while sharing a copy of a letter she had written to the Union Finance Minister in August, said, "I had personally written to the Union Finance Minister, warning how their decision to keep 18 per cent GST on health and medical insurances would deter vulnerable individuals from securing or maintaining their insurance coverage.

Banerjee described the reported rollback move suggested by the Group of Ministers of the GST Council as "significant, though it is not coming out of goodwill".

"It is coming because of relentless pressure from our side. Our leaders have stood firm against anti-people policies that would harm the common people. Our MPs have been fighting, and our Finance minister fought very well in the Group of Ministers

Banerjee added that the final decision by the GST Council if it relents will bring much-needed relief to millions of families across the country.

"We remain committed to putting people's interests at the forefront of every decision. However, we anxiously wait to see the final shape and conditions of the eventual decision by the GST Council, and we remain sentinels of the people," she said.

A final decision on GST for health and life insurance premiums, as well as rate rationalisation, is likely to be taken by the GST Council, chaired by the Union Finance Minister and comprising state counterparts, in its meeting scheduled for next

29 seats. "Left and secular parties are looking at fighting on around 20 of the 288 seats, many of these are ones that we have won earlier, and in areas where we are strong, Dhawale told PTI.

The CPI(M) will be fighting from Dahanu, a seat it has won in nine of the last 10 assembly elections since 1978, and Kalwan, where its candidate won in 2014, but lost by a margin of around 7,000 votes in 2019.

Apart from these two, among



the seats that CPI(M) is keen on fighting, are Solapur City Central, where CPI(M) has had MLAs in past, Nashik West, and Akole, where they have been getting sig-

nificant vote share. Kinwat in Nanded, and Majalgaon in Beed district, both in Marathwada region, are also being claimed by the CPI(M).

The Peasants and Workers Party of India (PWP), which has a strong base in the Raigad district, wants to contest from Sangole, Alibaug, Pen, Panvel, and Uran. It has a sitting MLA in Loha assembly seats.

Communist Party of India (CPI), meanwhile, wants to fight from Wani in the Vidarbha region, Shirpur, Aurangabad Central and Hingna, while Satyashodhak Communist Party, another Left party in Maharashtra, wants to fight Sakri

Samaiwadi Party, which participated in recent meetings held by the Left parties, wants to fight from some seats in Mumbai, Bhiwandi and Malegaon districts.

Dhawale said the Maha Vikas Aghadi, the opposition alliance, must not be overconfident, even though they won 29 out of 48 Lok

"The numbers hide the fact that the difference in vote share is very little, so it was very close," he said He said that Congress lost in Haryana despite a predicted win because it failed to bring along al-

"In Harvana, there were other factors, but one factor was lack of inclusiveness. Parties like SP and AAP could have been given some seats," he said.

In the LS polls held earlier in the year, the MVA — Congress, Shiv Sena (UBT), NCP (SP), and the Left parties — got around 44 per cent votes, while the National Democratic Alliance led by the BJP got 43.6 per cent votes.

Dhawale also alleged that the recently launched Ladli Behna scheme and schemes for construction workers by the NDA were mere pre-poll sops.

He said taking along the Left parties, which has a dedicated cadre, will help the alliance.

"Left parties have their pockets of influence, and there are supporters across Maharashtra. The CPI(M) has district units in over 32 districts and has a vote share ranging from 5,000 to 10,000, and even up to 50,000 in certain areas. It will strengthen the alliance," he

He also stressed that the Left cadre cannot be bought.

Asked if going with a party like Shiv Sena (UBT), which has a Hindutva ideology, may impact the Left voters, he said people have al-

ready seen Uddhay Thackeray's work as a chief minister and it is not an issue anymore.

"It was an issue in the beginning, but in the two and a half years when Uddhav Thackeray was the chief minister, people have seen his performance. He took a balanced position," he said. In the upcoming polls, the MVA

is challenging the ruling NDA government, which took over after several MLAs from Thackeray's Shiv Sena and found the support of the breakway faction of Sharad Pawar's NCP. Seat-sharing talks among the

MVA remain stuck, with Thackeray warning on Friday that it must not reach a breaking point, after which Congress rushed party leader Ramesh Chennithala to Mumbai to hold talks with part-A convention of 'progressive

parties', which includes the Left parties and the SP, was held in Pune on October 16, where the parties stressed that MVA should adopt an "inclusive approach" in seat-sharing and give these parties their just share.

Assembly polls will be held in Maharashtra on November 20, and results will be announced on November 23. (PTI)

Chopra became the first Indian trackand-field athlete to win two successive Olympic medals by clinching a silver with a throw of 89.45m on August 8, but the day belonged to Nadeem, who destroyed the field with a new Olympic record effort of 92.97m for his country's maiden individual gold at the show-

"Nothing was wrong, everything was right. The throw was also good. Getting a silver (medal) in the Olympics is also not a small thing. There was disappointment. But, I feel that the competition was very good, and it was tough,' Chopra told PTI in an interview.

NO FINAL-DAY TWIST

New Zealand triumph by 8 wickets for first Test win in India in 36 years



Zealand survived a hostile Jasprit Bumrah spell to foil India's attempt to add a final-day twist to an absorbing series-opener, slaving the cricketing giants at home by eight wickets and ending a 36-year long wait to taste Test success in the country, here Sunday

This is Kiwis' first Test win on the Indian soil after the John Wright-led outfit towelled India by 136 runs at the Wankhede Stadium in Mumbai, way back in 1988.

Even hunting a modest 107 on the fifth day against a world-class attack could be nervy, and New Zealand did that after some initial

Will Young (48 not out) and Rachin Ravindra (39 not out) fuelled their chase with a 75-run stand for the third wicket, handholding their side a 1-0 lead in the three-match series.

However, the Indians will not be an entirely despondent lot despite the defeat as they showed admirable spunk to claw back from the depths of getting bowled out for 46 in the first innings

Test at Pune starts on October 24.

The Rohit Sharma-marshalled side will also have to think deeply about retaining Sarfaraz Khan, who made a 150 in the second dig, as Shubman Gill is poised to return after recovering from a stiff neck. The other point they will moot long is whether to go back to the three-pacer strategy or continue three spinners, a move which backfired here spectacularly, in Pune. New Zealand victory did not come without its share of drama once the day's play started at 10.15am, a wet outfield pushing back the proceedings by an hour.

Bumrah (2/29), operating from the dressing room end, found appreciable movement and Tom Latham fell in the first over of the day itself for his overnight naught.

Latham was behind the ball to cover the in-dipper but it swung back further to thud on to his pads as umpire Michael Gough raised his finger after vociferous appeal from the bowler and the crowd.

The New Zealand captain reviewed the decision more in hope than in conviction and the DRS confirmed his worst fears as well. and he had to walk back.

India might just have felt the absence of a third pacer as both Bumrah and Siraj found movement and carry to trouble the Kiwi batters under a largely overcast skies. Kuldeep Yadav, who gave away 26 runs in three overs, had replaced Akash Deep in the eleven for this Test after India went with a three-pronged pace attack against Bangladesh recently.

Devon Conway, the other overnight batter, was shaky throughout his stay and would consider himself fortunate to have found a last-minute edge on a Bumrah skidder that otherwise would have trapped him plumb in front. But as luck would have it, the ball beat the gully fielder and raced to the fence.

However, the left-hander eventually reached the road's end when Bumrah, operating from around the stumps, caught him right in front of the wicket with another one that skidded and swung back into him.

The on-field umpire did not re-

peal to send Conway (17) back. New Zealand were 35 for two at that point, and one would say the match in balance as a couple of more strikes could have left the cat

among the pigeons. But Young and Ravindra, the first-innings centurion, found some solidity to resist the Indian

charge. Once the sun came out for a while, the ball-movement was much more predictable and the Kiwi batters used favourable conditions to rack in a few boundaries to ease the pressure. Ravindra Jadeja, who started with a no-ball, too did not make much of an impression, conceding 14 runs in his first two overs. There was not much on the Chinnaswamy pitch for him to exploit either as the 22yard track did not disintegrate on the final day, courtesy rain and cooler climes here. With the margin getting reduced alongside each run, the New Zealand batters became more daring and brought out their shots from the shelf, such as a clean hoist over mid-wicket for a six off left-arm wrist spinner
