Bhupen to seek meeting with ASOM leaders to end differences in December

'All anti-BJP parties must unite to fight 2026 polls'



GUWAHATI, Nov 22: A month after the Congress exited the opposition front in Assam over differences in seat sharing for the bypolls, its state president Bhupen Kumar Borah on Friday said he would try his best to reunite with it to defeat the BJP-led dispensation in the next state

In an interview with PTI ahead of the counting of votes for the bypolls to the five assembly constituencies, Borah said he would seek a meeting with leaders of the opposition bloc, Asom Sonmilito Morcha (ASOM), in the first week of December to resolve the differences. "What will be the impact of breaking oppo-

We will discuss it after the results are declared tomorrow. But one thing I can announce here is that I will try my level best to unite all anti-BJP parties as soon as possible so that we can fight the 2026 assembly elections together," he said.

Borah resigned as the president of ASOM on October 22, stating that he was under "tremendous pressure" after the Congress national leadership refused to accept the CPI(ML) Liberation candidate in the Behali seat.

Following this, ASOM appointed Rajya Sabha MP Ajit Kumar Bhuyan of the Anchalik Gana Morcha as its president, and the bloc supported the CPI(ML) Liberation nominee in the seat against a Congress candidate.

Besides Behali, bypolls were held in Samaguri, Dholai, Bongaigaon and Sidli on November 13. The by-elections were necessitated as the MLAs of these constituencies won the Lok Sabha polls

Borah claimed that the INDIA bloc was "not working" in many states due to "internal problems". He said the ASOM bloc has 16 parties, including RJD, SP and Shiv Sena, which do not have much base (CONTD. ON PAGE-2)

Rich countries' \$250B climate pledge at COP29 faces backlash BAKU (AZERBAIJAN), Nov 22: In the closing hours

of the UN climate conference here, rich countries on Friday proposed increasing climate finance for developing nations from USD 100 billion to USD 250 billion per year by 2035, far short of the trillions needed to address the escalating climate crisis.

A new draft text on a climate finance package for developing nations emerged on Friday afternoon, presenting concrete numbers from developed countries for the first time, hours after countries were left facing an 'X' sitting in a bracket instead of a clear figure after two weeks of intense negotiations.

However, the text says the USD 1.3 trillion per year in climate finance, demanded by all developing countries, will be raised from both public and private sources without placing the responsibility solely on the developed nations' public exchequer.

It specifies that the USD 250 billion per year by 2035 will be mobilised by developed countries from a variety of sources, including public and private, bilateral and multilateral, as well as alternative sources.

More than 190 countries are negotiating climate finance obligations by rich nations for the developing countries as part of the implementation of the Paris Agreement of 2015. The pact binds collective action to cut down on emission of greenhouse gases to restrict the temperature rise to below 1.5 degrees Celsius compared to the pre-industrial times.

Climate policy experts and observers have criticised the proposal as detrimental to developing countries, predicting a strong backlash.

Vaibhav Chaturvedi, a senior fellow at the Delhibased think tank Council on Energy, Environment and Water (CEEW), said, "The apparent increase in the provision from the developed world to the developing world of USD 250 billion per year by 2035 is essentially the same as the USD 100 billion by 2020 if a 6 per cent annual average inflation is accounted for. There is no grant or low-cost finance component.

'This is a bad deal for the developing world, irrespective of how it is portrayed by the presidency.

He also dismissed the USD 1.3 trillion figure as a "sham."

"The USD 1.3 trillion per year by 2035 for the developing world includes finance from all public and private sources. Investment in renewable energy technologies in developing countries was USD 544 billion in 2022 alone. This figure should naturally exceed USD 1.5 trillion by 2035, factoring in growth in the sector and inflation," he explained.

Developing nations have repeatedly stressed the need for at least USD 1.3 trillion annually -- 13 times the USD 100 billion pledged in 2009 -- starting from 2025 to meet their escalating climate challenges.

In a rejoinder to Kharge, Nadda claimed the repercussions of the Congress's "abject failure" in dealing with local issues in Manipur when it was in power are being felt even today.

What is shocking is how repeated attempts are being made by the Congress party to sensationalise the situation in Manipur, he told Kharge, asserting that the cur-



rent dispensation has been working since the first incidents of violence to bring stability and peace in the

He said Kharge seemed to have forgotten that not only did his government legitimise the illegal migration of foreign militants to

These known militant leaders fleeing their country to avoid arrest were wholeheartedly endorsed and encouraged to carry on their destabilising efforts, Nadda claimed.

Postmortem examinations of the bodies were conducted at SMCH in Silchar district bordering Jiribam district of Manipur.

The next of kin of the victims, all belonging to the Meitei community, had initially refused to accept the bodies till they got justice. They, however, later agreed to accept the bodies as the National Investigation Agency (NIA) is inquiring into the incidents

The family members were also demanding that those 10 slain Kukis be declared as militants as they had come from Churachandpur to Jiribam with arms and could not be members of an ordinary village de-

Officials said that both Assam and Ma-

voy of nine bodies being taken to Jiribam, around 55 km away.

The convoy was stopped at several places along the way as representatives of various Meitei groups offered floral tributes to the deceased.

The bodies include six women and children, who were allegedly abducted from a relief camp on November 11 by Kuki-Zo militants from Jiribam's Borobekra area when a group of Kuki youths were engaged in an encounter with CRPF in which 10 of them were killed.

The counting of votes for the Dholai seat will be held at the Inter-State Truck Terminal in Ramnagar. The counting for the Sidli seat will be held at the district centre in Kajalgaon, while the counting for Bongaigaon will be held at Bongaigaon College.

In Behali and Samaguri, the counting will be held at the district commissioner's offices.

All preparations for the counting of votes have been completed, officials said on Friday evening.



The bypolls were held as these seats fell vacant following the election of their MLAs to the Lok Sabha.

The campaigning in Samaguri was marked by sporadic incidents of violence and clashes between BJP and Congress supporters.

The seat was vacated by former Congress minister Rakibul Hussain who won the Dhubri Lok Sabha seat by a record margin of over 10 lakh votes. The Congress fielded his son Tanzil Hussain in the seat against BJP's Diplu Ran-

FTA talks with India to relaunch early in 2025: UK PM

LONDON, Nov 22: The Free Trade Agreement negotiations with India -- expected to significantly boost the estimated GBP 42-billion a year bilateral trade partnership -- will be relaunched early in the new year, Prime Minister Keir Starmer has informed the UK Parliament here.

It came during his statement to update the House of Commons on Thursday about his G20 Summit visit to Brazil, where he said he had a "good discussion" with Prime Minister Narendra Modi among other world leaders.

The meeting earlier this week had led to both countries agreeing to resume the election-stalled Free Trade Agreement (FTA) talks.

"I had a good discussion with Prime Minister Modi about deepening our bilateral ties," Starmer told the members of Parliament.

"We agreed to raise the ambition of our UK-India comprehensive strategic partnership, which covers security, defence, technology, climate, health and education, building on the unique bonds and cultural ties

between our two countries. "Crucially, this work will start with trade and in-



vestment and I am pleased to say that we agreed to relaunch Free Trade Agreement negotiations early in the new year," he said.

The talks had been paused in the 14th round as the general election cycles kicked in for both nations, with FTA negotiations that began under a Conservative Party government now being picked up by a Labourled administration in charge in Britain. NEW DELHI, Nov 22: Asserting that air pollution in North India is a "national emergency" Leader of Opposition in the Lok Sabha Rahul Gandhi on Friday urged fellow MPs to come together in the upcoming Parliament session and discuss how the nation can end this crisis once

He said the air pollution crisis needs a collective national response, not political blame

Gandhi shared a video on X in which he is discussing the air pollution issue with environmentalist Vimlendu Jha at the India Gate here.

In his post along with the video, the Congress leader said air pollution in North India is a national emergency -- a public health crisis that is stealing our children's future and suffocating the elderly, and an environmental and economic disaster that is ruining countless lives.



"The poorest among us suffer the most, unable to escape the toxic air that surrounds them. Families are gasping for clean air, children are falling sick and millions of lives are being cut

short. Tourism is declining and our global reputation is crumbling," the former Congress chief said.

"The cloud of pollution covers hundreds of kilometres. Cleaning it up will need major changes and decisive action -- from governments, companies, experts and citizens. We need a collective national response, not political blame games," he added.

As Parliament meets in a few days, the MPs will all be reminded of the crisis by our irritated eyes and sore throats, he said.

'It is our responsibility to come together and discuss how India can end this crisis once and for all." Gandhi said.

S &P Ratings says US allegations may renew questions on governance practices at Adani

Adani Group's founder Gautam Adani by US prosecutors could renew questions over the ports-to-energy conglomerate's governance practices and damage its reputation, S&P Global Ratings said Friday.

US prosecutors have charged Adani and seven others including his nephew Sagar, with agreeing to pay about USD 265 million in bribes to Indian government officials to obtain favourable terms for a solar power supply contract. Adani Group has denied all charges, calling them "baseless", and said it would seek "all possible legal recourse"

"The allegations could renew questions over the group's governance practices and damage its reputation. We will watch for any signs of weaker funding access or concerns from existing lenders -- which could be demonstrated by the lowering of funding limits, non-renewal of facilities, or significantly higher credit spreads," S&P Ratings said in a note.

After the news of the indictment broke, equity and bond prices across Adani group companies have fallen sharply. The group has cancelled a USD 600 million concluded bond sale. This indictment is independent of, but follows, a short-seller report last year, which hit equity and bond prices across the group although these had subsequently recovered. The group has denied the allegations and asserted that they are baseless.

The group needs regular access to both equity and debt markets given its large growth plans, in addition to its regular refinancing.

"We believe domestic, as well as some international banks and bond market investors, look at Adani entities as a group, and could set group limits on their exposure. This may affect the funding of rated entities. We note that the rated entities have no immediate and lumpy debt maturities," the rating agency said. "If allegations



of illegal activities or misleading statements prove true, we could assess the group's governance more negatively.

Separately, research firm CreditSights said refinancing for Adani Group's green energy business is the biggest concern in the near term. "Funding channels will inevitably squeeze across the Adani Group, with creditors likely to reduce or limit their group-wide exposure."

Concerns are most for Adani Green Energy Ltd "given it has the weakest liquidity and credit fundamentals," it said, pointing to shortterm debt of about USD 2 billion, largely in the form of project loans, at the conglomerate's green energy unit. S&P Global Ratings revised to negative the credit outlook for multiple Adani Group entities on Friday, citing funding access and financing-cost concerns.

"A US indictment of three board representatives of an unrated Adani group entity could affect investor confidence in other Adani group entities (because the founder is on the board of multiple entities within the group), thereby potentially impairing their funding access and increasing their funding costs," S&P said.

were involved in a USD 265 million bribery scheme that breached the anti-bribery compliance policy through misrepresentation to investors in an offshore bond.

"In our view, this could further raise questions regarding the management and governance of various Adani group entities. The indictment is independent of, but follows, a short seller report that led to investigation by the Indian Supreme Court and India's capital market regulator," S&P said.

Stating that because of the potential impact across the wider Adani Group, S&P said it has revised to negative the outlook on Adani Electricity Mumbai Ltd (Adani Electricity) and Adani Ports and Special Economic Zone Ltd (Adani Ports). "We also affirmed our 'BBB-' ratings on these entities.'

Project finance entity Adani Green Energy Ltd Restricted Group 2 (AGEL RG2) is a subsidiary of Adani Green Energy Limited (AGEL), the entity linked to the allegations.

"Although it is ring-fenced from the parent, we revised to negative the outlook on AGEL RG2 and affirmed our 'BB+' issue rating," the rating agency said. "The negative outlook on these entities indicates that, in our view, their cash flows could be materially affected if their funding access weakens, their funding costs rise significantly, or the allegations are proven, in addition to our assessment of their governance and business profiles.'

S&P said it believes that if the allegations are proven, it could have some bearing on the com-

"This could occur if there is a review of relationships with the government agencies that award concessions and licenses, or with offtakers and counterparties such as Solar Energy Corp of India (SECI), state distribution companies, and joint venture partners," it said. (PTI)

in Assam. "If tomorrow, these parties demand seats here to contest only for the sake of it, then we will definitely have to think... Otherwise, people will say that the Congress is not serious about fighting against BJP," he said. "These are the problems and I think we will sort it out very soon. After these results, in the first week of December, I will try to sit with the important leaders of ASOM," he added.

Borah said the differences within ASOM emerged following Congress's reservations over the candidate initially considered by the CPI(ML) Liberation for Behali.

"As per the assessment of our party, the candidate who the CPI(ML) Liberation considered was not strong enough to fight the BJP. Chances of success must be the first priority, which is why we decided to field our own candidate," he said. Borah claimed that the difference was not over CPI(ML) Liberation seeking to contest in that seat but over the choice of its candidate.

Even though the Left party later changed its nominee, the Congress was not satisfied, he said.

Borah said the CPI(ML) Liberation contested Behali in the 2021 assembly polls as part of the opposition alliance, and secured only 21,000 votes, whereas the Congress's Sonitpur Lok Sabha candidate managed 43,000 votes in the Behali assembly segment this year.

"How can a party that secured 43,000 votes in June sacrifice its seat to a party that secured 21,000 votes even when it is in an alliance?" he questioned. He said that in the state elections, the Congress will try to ac-

commodate other political parties, considering there are 126 seats to fight. "I am very much hopeful that we will be able to fight together and defeat the BJP," he said.

On the party's prospects in the bypolls, the Congress leader said, "As per our internal assessment, we are hopeful in four seats. In the Lok Sabha elections, we were ahead in Samaguri by a small margin. In Behali, Dholai and Bongaigaon, our position was not good. But in these by-elections, as per reports from our grassroots workers, polling agents and local leaders who were involved with campaigning, the result will be very much in our favour." On Sidli, Borah said the Congress was hopeful about a good performance in this constituency under the Bodoland Territorial Region. (PTI)

Justin Trudeau told reporters, "I believe that India has made a monumental mistake by choosing to use their diplomats and organised crime to attack Canadians, to make them feel unsafe here at (their) home, and even more, to create acts of violence and even murder. It's unacceptable." On Oct 26, Canadian deputy foreign affairs minister David Morrison alleged that Indian home minister Shah ordered a campaign of violence, intimidation and intelligence-gathering targeting Sikh separatists inside Canada.

In New Delhi on Wednesday, referring to the The Globe and Mail report, External Affairs Ministry spokesperson Randhir Jaiswal said such "ludicrous statements" should be dismissed with the contempt they deserve and

smear campaigns like this only further damage our already strained ties". India-Canada ties remain deeply troubled over Canada's alleged support to Khalistani separatists and its accusation of India's involvement in the killing of Nijjar, who was gunned down in Surrey, British Columbia in June last year. India-Canada ties further nosedived last month after Canada linked Indian High Commissioner Sanjay Verma and some other diplomats to the murder. India has strongly rejected all the allegations made by

NFR implements safety measures for winter train operations

Advanced technology and enhanced protocols deployed to ensure safe and efficient rail services

GUWAHATI, Nov 22: The Northeast Frontier Railway (NFR) is taking proactive steps to ensure safe and efficient train operations during the winter and foggy season. A series of measures has been implemented by the zone to address challenges faced during the winter months, covering important criteria such as visibility and the safety of tracks, OHE (Overhead Equipment), TRS (Traction Rolling Stock), etc. To prevent rail and weld failures dur-

ing low temperatures, thorough examinations and lubrication of rail joints are being conducted alongside the de-stressing of LWR/CWR (Long Welded Rails/Continuously Welded Rails) as RF/WF-prone Failure/Weld Failure) locations have been identified for necessary recoupment. Cold-weather patrolling has been strengthened with GPS-enabled monitoring as per guidelines, ensuring precise



oversight of rail conditions. Rail temperatures are being closely monitored and recorded to address the unique challenges of the winter season.

To tackle the issue of fog, NFR has deployed advanced Fog PASS (Fog Pilot Assistance System for Safety) devices to

assist train drivers with real-time navigation, enabling safer and timely operations despite reduced visibility. Safety inspections of train roofs, under-gear components, locomotives, and rolling stock are being rigorously performed using advanced technologies to detect

vulnerabilities early and mitigate risks effectively.

Track monitoring and maintenance have been prioritised, utilising Ultrasonic Flaw Detection and modern techniques to identify potential hazards. Similarly, signaling systems are being upgraded to ensure seamless communication and operational reliability. Emergency preparedness has also been reinforced with specialised training for frontline staff and regular mock drills to enhance readiness during unforeseen sit-

US indictment of Gautam Adani

The real import of the US department of justice (DOJ) indictment of Indian billionaire, Gautam Adani, on counts of corruption and bribery has been somewhat lost on the wider public. It is the geoeconomics of the US dominion over the rest of the world that has to be taken note of. It is an extension of the US heft far beyond its backyard. The US legal set up has issued an indictment and arrest order over an alleged crime committed in India by an Indian citizen for some projects in India. Remember this is coming from a country where a US cabinet pick of the newly elected president of United States has been found to passed on money for sex and have had sexual relations with a minor, where the winning Republican Party has refused to part with critical information on aspects of life of the presidential picks. As such, the Americans have no jurisdiction over whatever is happening in India, bribery or otherwise, however detrimental these could be for the Indians and the Indian state. Consider for a moment that an Indian court pronouncing judgments over the lapses in project implementation and bribery in the US over a project being implemented by an American company on American soil.

However, the US has a law on Foreign Prevention of Corruption Act under which Gautam Adani and his nephew have been indicted and ordered to be arrested. India might just as well pass some laws under which a convicted felon in a foreign country might be disqualified from elected office. Be those as these may, the issue is that the United States has a certain sway which extends its swagger far beyond its own borders and legal jurisdiction. This is because if a commercial entity is seeking the US financial markets for raising funds these then automatically become applicable for protection of the monies invested by Americans in those entities. Whether Gautam Adani has in fact bribed the Andhra Pradesh government and its officials and politicians is the subject of enquiry. Nobody in this country believes that large government clearances could be obtained without paying hush money. As the saying goes not even a pin could be sold to a government organisation without greasing the palms. The Indian government agencies will take action against Adani and the others named by the U.S. if those are proved as a result of Indian investigations.

Bribery or no bribery, the fact should be established that in the case of an entity transgressing the laws of the land would face consequences here and not in some foreign land. Soon enough, there could be a demand for extradition of Gautam Adani from the American department of justice. India should be ready to respond to it assertively. The opposition leader including Rahul Gandhi should remember that Gautam Adani's offences will be tried under Indian laws and he should avoid voicing the American DoJ demand for his arrest. Only Indian authorities have the right to arrest Adani group members if they are found guilty under Indian laws, not the US government.

The history of tea gardens in Assam

ssam holds a significant place in the history of tea cultivation. So Assam is often referred to as the "Tea capital of the world". Its sprawling tea estates, rich cultural heritage, and distinct flavor of tea have made Assam a key player in the global tea industry. The story of Assam tea is intertwined with both colonial history and local tradition, creating a fascinating journey that has left an indelible mark on the region.

Tea had been growing wild in Assam for centuries.But its commercial potential remained undiscovered until the early 19th century. In 1823, a British traveler and merchant named Robert Bruce is credited with discovering indigenous tea plants growing in the Assam jungles. Bruce's findings. later confirmed by the botanist Dr. Nathaniel Wallich, led to further interest in the region's tea plants. These plants, "Camellia sinensis var. assamica", were found to thrive in the unique tropical climate of Assam, different from the Chinese variety of tea that was traditionally used.

In 1839 The British East India Company established the Assam Tea Company after recognizing the potential of Assam's tea. This marked the formal beginning of large-scale tea cultivation in the region. The British sought to reduce their reliance on Chinese tea and began experimenting with local tea varieties. In 1840, the first commercial plantations were established in Assam. Gradually Assam became the main hub of tea production for British India.

The British introduced tea plantations or tea gardens, to Assam by converting vast stretches of forests into estates. These plantations required extensive labor, and to meet this demand, thousands of tribal people were brought in as workers from different parts of India, particularly the Chotanagpur plateau, under the indentured labor system. This migration left a lasting demographic and cultural imprint on Assam.

In the late 19th century Assam tea had earned international acclaim for its robust flavor, high caffeine content, and rich malty character. Assam's tea began to dominate both the Indian and international markets. Assam's tea was

Bulldozer justice: The conflict between administrative efficiency and constitutional rights

Bulldozer justice often bypasses legal processes such
as reasonable notice or a
chance to defend, which challenges the right to a fair trial enshrined in the Constitution. In
recent demolitions, families were
given minimal notice, which is a
violation of Article 21 that protects
the right to life and personal liberty. This practice contradicts the
presumption of innocence, where
individuals are presumed guilty
without trial or conviction, which
is a violation of the rule of law.

In Uttar Pradesh, properties were demolished based on mere allegations without any concrete evidence, disregarding legal standards of proof. Demolitions impact not only the accused but also families and communities,

standards of proof. Demolitions impact not only the accused but also families and communities, which violates the principle against collective punishment. In Madhya Pradesh, demolitions due to the alleged involvement of one member rendered families homeless, affecting innocent dependents

and judicial roles as administrative bodies execute punishments for courts violating Article 50. Demolishing properties without court directions shows authorities acting beyond their jurisdiction, which violates the role of the judiciary.

As the Supreme Court has highlighted, the absence of proper notice or hearing violates the principles of natural justice, leaving them with no opportunity to defend. Bulldozer justice maintains administrative efficiency and prompt action on encroachments. Quick demolition of unauthorized structures eliminates delays in urban development and streamlines land management processes.

In Delhi (2023), demolition drives in areas such as Jahangir-puri were aimed at quickly reclaiming public spaces after reports of illegal construction surfaced, thereby ensuring smooth implementation of urban development projects.

The immediate consequences of illegal construction serve as a powerful warning, discouraging future violations. Rapid reclamation of encroached areas ensures their

proper use, thereby contributing to better urban governance and public utility.

Decisive action strengthens the state's ability to uphold laws, thereby increasing public confidence in governance. By bypassing long-drawn-out legal and bureaucratic delays, it reduces costs and expedites the resolution of land disputes.

During preparations for the G20 Summit (2023) in Delhi, encroachments were swiftly removed near key sites to beautify the area and enhance security, demonstrating effective resource management for international events.

Violation of the right to life

Violation of the right to life and personal liberty: Demolitions without due process violate Article 21, which guarantees life and personal liberty, including the right to shelter. In Olga Tellis v. Bombay Municipal Corporation, the Supreme Court ruled that housing rights are an integral part of the right to life, a principle violated in the recent demolitions.

Lack of uniformity in implementing demolition policies leads to procedural arbitrariness, which

violates Article 14 of the Constitution. Destruction of places of worship or places of cultural importance may violate the freedom to practice and propagate religion (Articles 25–30).

Arbitrary demolitions without legal notice or hearing undermine a person's right to hold and enjoy property. The Constitution mandates that no person shall be deprived of his property except by authority of law. Demolition drives have a chilling effect on dissent when used as punitive measures against activists, journalists, etc. Educating citizens on property and demolition rights helps communities oppose illegal actions and de-

mand due process.

Initiatives by local NGOs in Maharashtra provide legal counseling, allowing families to oppose unjust demolitions. Putting in place accountability frameworks ensures that officials who circumvent due process are held accountable, thereby increasing trust in governance. Establishing an ombudsman to monitor demolitions can prevent abuses and promote fairness

Developing protocols for prior notice, judicial review, and appeal time protects citizens' rights. Supreme Court guidelines mandating a 15-day notice period ensure transparency and prevent arbitrary demolitions. Providing alternative housing or compensation for affected families aligns administrative functions with social justice principles.

In Delhi, resettlement of displaced families during encroachment removal upheld rights to shelter. Monitoring demolitions to ensure fairness addresses discrimination concerns and enforces lawful, equitable action. Independent audit teams in UP assess demolitions to confirm compliance with legal guidelines and prevent partisan targeting.

Bulldozer justice highlights the complex balance between administrative efficiency and constitutional rights. By ensuring legal safeguards, transparent protocols, and accountability, India can promote governance that respects the rule of law and human dignity, aligns with democratic values, and enables effective governance.

Many in Gaza eating just once a day, as hunger spreads amid aid issues

DEIR AL-BALAH (THE Israel began waging a renewed of-GAZA STRIP), Nov 22: Yasmin Eid coughs and covers her face, cooking a small pot of lentils over a fire fed with twigs and scrap paper in the tent she shares with her husband and four young daughters in the Gaza Strip.

It was their only meal on Wednesday — it was all they could afford. "My girls suck on their thumbs because of how hungry they are, and I pat their backs until they sleep," she said.

After being displaced five times, the Eids reside in central Gaza, where aid groups have relatively more access than in the north, which has been largely isolated and heavily destroyed since fensive against the militant group Hamas in early October.

But nearly everyone in Gaza is going hungry these days. In the north experts say a full-blown famine may be underway.

On Thursday, the International Criminal Court issued arrest warrants against Israeli Prime Minister Benjamin Netanyahu and his former defence minister, accusing them of using "starvation as a method of warfare" — charges Israel adamantly denies.

In Deir al-Balah, the Eids are among hundreds of thousands sheltering in squalid tent camps. The local bakeries shut down for five days this week. The price of

a bag of bread climbed above \$13 by Wednesday, as bread and flour vanished from shelves before more supplies arrived.

The United Nations humanitarian office warned of a "stark increase" in the number of households experiencing severe hunger in central and southern

It appeared to be linked to the robbery at gunpoint of nearly 100 aid trucks last weekend in southern Gaza, close to Israeli military positions. Israel blamed Hamas but appears to have taken no action to stop the looting, while Hamas said it was the work of local bandits.

Aid groups say the looting is

one of many obstacles to getting food and other vital aid to the territory's 2.3 million Palestinians.

They also have to contend with Israeli movement restrictions, ongoing fighting, and heavy damage wreaked by the Israeli bombardment of roads and critical infrastructure.

For months, Yasmin and her family have gone to bed hungry. "Everything has increased in price, and we cannot buy any-

thing," she said. "We always go to sleep without having dinner.

She misses coffee, but a single packet of Nescafe goes for around \$1.30. A kg (2 pounds) of onions goes for \$10, a medium bottle of in price".

Kremlin dispatched weapons as payment for 10,000 troops deployed to support war in Ukraine

Russia supplied air defense missiles to North Korea in return for its troops, South Korea says

SEOUL, Nov 22: Russia has supplied air defense missile systems to North Korea in exchange for sending its troops to support Russia's war efforts against Ukraine, a top South Korean official said on Fri-

The U.S., South Korea and Ukraine say North Korea sent more than 10,000 troops to Russia in October, some of whom have recently begun engaging in combat on the front lines. North Korea's troop deployment threatens to escalate the war, and what Russia could give to the North in return has been a source of rampant international

speculation. The most alarming development for South Korea and the U.S. would be Russia transferring sophisticated weapons technology that can enhance North Korea's nuclear-capable missiles targeting its rivals. Many experts say, though, that it is unlikely Russia would do this in the initial stage of the North's troop de-

Shin Wonsik, national security

adviser for South Korean President Yoon Suk Yeol, told an SBS TV program Friday that South Korea has found Russia provided missiles and other equipment to help it reinforce its air defense network for Pyongyang, the capital. Shin didn't say what specific missiles Russia gave to North Korea.

Lee Illwoo, an expert with the Korea Defense Network in South Korea, said that Russia has likely sent S-400 long-range surface-to-air missiles, launchers and groundbased radar systems. He said that North Korea is capable of building shorter-range surface-to-air missiles on its own.

The S-400 missile, with a range of 400 kilometers (250 miles), is considered one of Russia's most advanced anti-aircraft weapons. But Lee questioned how significantly it can boost Pyongyang's air defense, saving Russian air defense systems have failed to effectively deal with Ukrainian drone assaults.

Many observers say North Korea has likely felt the urgent need to



boost its air defense capabilities after it last month accused South Korea of flying drones to scatter propaganda leaflets over Pyongyang. North Korea threatened to take military action if leaflets were again dropped. South Korea's military has refused to confirm whether or not it was behind the alleged drone flights.

Kim Dae Young, a military expert at the Korea Research Institute for National Strategy, said it's possible that the air defense systems North Korea acquired from Russia could include counter-drone equipment. Kim said that Pyongyang's out-

need years of improvement and potentially huge external help to cope with the superior air forces of South Korea and the United States.

Shin said Russia has also appeared to have given economic assistance to North Korea and various military technologies, including those needed for the North's efforts to build a reliable space-based surveillance system. Shin didn't say whether Russia has already transferred sensitive nuclear and missile technologies to North Korea.

During a summit with North Korean leader Kim Jong Un last year, Russian President Vladimir Putin already said that Moscow was willNorth Korea put its first spy satellite into orbit in November last year, but foreign experts question whether that satellite can produce militarily meaningful imagery. The North's attempt to launch a second spy satellite failed in May.

North Korea and Russia have been sharply boosting their military and other cooperation in the face of separate confrontations with the U.S. and its allies. Last month, South Korea's spy agency said that North Korea had sent more than 13,000 containers of artillery, missiles and other conventional arms to Russia since August 2023 to replenish its dwindling weapons stockpiles. The National Intelligence Service said on Wednesday that North Korea had recently sent additional artillery systems to Russia.

Earlier this week, North Korea and Russia reached a new agreement for expanding economic cooperation following high-level talks in Pyongyang this week, according to suspected methanol poisoning in Laos, the British Foreign Office

An American and two Danish tourists also died, though specifics about the causes of death have not been released.

Hungary's Orbán vows to disregard international arrest warrant for Netanyahu

BUDAPEST, Nov 22: Hungarian Prime Minister Viktor Orbán on Friday denounced the International Criminal Court's issuing of an arrest warrant for Israeli Prime Minister Benjamin Netanyahu, saying he would defy it by inviting the Israeli leader to Hungary.

In comments to state radio, Orbán accused the ICC of "interfering in an ongoing conflict for political purposes," saying the decision to issue the warrant for Netanyahu over his conduct of the war in Gaza undermined international law and escalated tensions. The ICC. the world's top war crimes court based in The Hague, issued an arrest warrant on Thursday for Netanyahu as well as for his former defence minister and Hamas' military chief, accusing them of crimes against humanity in connection with the 13-month war in Gaza.

The warrants said there was reason to believe Netanyahu and former Defence Minister Yoav Gallant used "starvation as a method of warfare" by restricting humanitarian aid and intentionally targeted civilians in Israel's campaign against Hamas in Gaza charges Israeli officials deny.

In his comments on Friday, Orbán, a close Netanyahu ally, called the arrest warrant "outrageously impudent" and "cynical". He said he would invite Netanyahu to Hungary later in the day and vowed to disregard the warrant if the invitation is accepted.

'We will defy this decision, and it will have no consequences for him," Orbán said. Member countries of the ICC, such as Hungary, are required to detain suspects facing a warrant if they set foot on their soil, but the court has no way to enforce that. Hungarian Foreign Minister Péter Szijjártó earlier criticised the ICC's warrant as "absurd". The action by the ICC came as the death toll from Israel's campaign in Gaza passed 44,000, according to local health authorities, who say more than half of those killed were women and children. Tariff hikes will backfire, China can manage such 'external shocks', senior official says

HONG KONG, Nov 22: Higher tariffs on Chinese exports will backfire, just increasing prices paid by consumers, while China can manage to weather the impact of such "external shocks," a senior Commerce Ministry

official said Friday in Beijing. Responding to a reporter's question about US President-elect Donald Trump's plan to impose 60% tariffs on imports from China, Vice Commerce Minister Wang Shouwen said that would "not solve the country's own trade deficit problem

"On the contrary, it pushes up the prices of the country's imports from China and other countries," Wang said during a news conference, noting that increased prices add to inflation.

China is willing to talk with the US on a basis of mutual respect, for the benefit of both countries, Wang said.

'We believe that if China and the US can maintain a stable, healthy, and sustainable development trend in economic and trade relations, it will be beneficial (to everyone)," he said.

Wang noted that China's total foreign trade including imports and exports reached 36 trillion yuan (nearly \$5 trillion) in January-October, up about 5%

from the same period of 2023.

Baku climate talks: The 'X' factor that could determine future of Global South



TAIPEI, Nov 22: Taiwanese President Lai Ching-te will visit the self-governing island's allies in the South Pacific, where rival China has been seeking diplomatic inroads.

The Foreign Ministry announced on Friday that Lai would travel from Nov 30 to Dec 6 to the Marshall Islands, Tuvalu and Palau. The trip comes against the background of Chinese loans, grants and security cooperation treaties with Pacific island nations that have aroused major concern in the US, New Zealand, Australia and others over Beijing's moves to assert military, political and economic control over the region. Taiwan's government has yet to confirm whether Lai will make a stop in Hawaii, although such visits are routine and unconfirmed Taiwanese media reports say he will stay for more than one day.

Under pressure from China, which

claims Taiwan as its own territory and threatens to annex it by force if needed, Taiwan has just 12 formal diplomatic allies. However, it retains strong contacts with dozens of other nations, including the US, its main source of diplomatic and military

China has sought to whittle away traditional alliances in the South Pacific, signing a security agreement with the Solomon Islands shortly after it broke ties with Taiwan and winning over Nauru just weeks after Lai's election in January. Since then, China has been pouring money into infrastructure projects in its South Pacific allies, as it has around the world, in exchange for political

China objects strongly to such US stopovers by Taiwan's leaders, as well as visits to the island by leading American politicians, terming them as violations of US commitments not to afford diplomatic status to Taiwan after Washington switched formal recognition from Taipei to Beijing

With the number of its diplomatic partners declining under Chinese pressure, Taiwan has redoubled efforts to take part in international forums, even from the sidelines. It has also fought to retain what diplomatic status it holds, including refusing a demand from South Africa last month that it move its representative office in its former diplomatic ally out of the capital. (AP)

As per a developing country negotiator, instead of providing quality finance in a transparent manner, the developed world at COP29 has been pushing them to cut emissions but has "conveniently forgotten that they need to pay for it".

"They want a phase-down, a phase-out, ambitious climate plans, sectoral emission cuts, everything, but don't want to pay for it," the negotiator said. India on Thursday said that it

will not accept any effort by

developed countries to shift the focus away from climate finance for developing countries and place it on emissions reductions in the Global South. Without adequate support in terms of finance, technology, and capacity building, the fight against climate change would

be severely impacted, it said. Developed countries have been pushing the argument of "expanding the contributors" base," essentially calling for nations that were classified as developing when the UN climate convention was adopted in 1992 but have since grown significantly, to also contribute to climate finance.

For developing countries, this is a red line. They argue that this would mean reopening and renegotiating the convention and the Paris Agreement.

"Would you renegotiate 1.5 degrees Celsius, too?" another negotiator from a developing country asked.

With just hours to go before the conference wraps up, negotiators are in high-stakes talks, scrambling to salvage the summit and the progress of the last three years. Meanwhile, outside the meeting rooms, civil society members, observers, and journalists are placing bets on how long this will drag on -- it is clear the summit will

Suspects involved in looting properties of Manipur ministers identified: CM

minister N Biren Singh on Friday said that suspects involved in looting the properties of ministers and MLAs during protests on November 16 were identified and legal actions initiated.

He condemned incidents like torching the photograph of a minister's late father in his house, looting the residence of an MLA and firing inside a car showroom, and wondered whether these could be part of any agitation.

"In the name of democratic movement, some gangs have looted and burnt the residences of ministers and MLAs. Suspects have been identified through CCTV and appropriate legal actions have been initiated. I feel ashamed to publicly to say that such things are happening in Manipur," Singh told reporters.

Urging people not to get involved in any activities that led to suspension of internet, the chief minister said, "Do not blame the government only. We need to correct ourselves as well.'

He said he has no objections against anyone who genuinely protested against the killing of children and women in Jiribam "But those politically motivated

gangs who took advantage of the situation, we will take legal action (against them)," Singh said.

Had not CRPF gunned down 10 or 11 militants in Jiribam, some



100 civilians would have been killed on November 11 since the attackers wanted to over run a relief camp in Borobekra and a police station, the CM claimed.

So, the steps taken by the central forces should be appreciated, Singh said.

"When the situation improves, we will make sure to lift suspension on (mobile) internet. Operations are on to apprehend the attackers. Though the NIA is also handling the case of the killing of innocents in Jiribam, the state government is not silent. We are also looking for them. The government will seek to protect lives and prop-

erties of civilians," Singh said. Manipur has seen a fresh wave of protests after six people – three Meitei women and three children went missing from a camp for displaced persons in Jiribam last week, following a gunfight between armed men and security forces that resulted in the deaths of 10 Kuki vouths

The event, organized by the district administration of Tamenglong, the forest department, and the Rainforest Club Tamenglong, was graced by Awangbow Newmai, minister of water resource and relief & disaster management, alongside Janghemlung Panmei, Tamenglong MLA, and N. Ganesh, IFS, DFO, Working Plan.

The festival saw the auspicious presence of Phungyar MLA Leishiyo Keishing, district-level officers, leaders from civil society organizations, students, and representatives from Amur Falcon roasting villages. The event commenced with vibrant performances, including the Rih Laem dance by the Khunchung Dance Troupe, Phalong and a cultural dance by the Puching Dance Troupe, showcasing the rich cultural tapestry of the region.

In his welcome address, Dr L Angshim Dangshawa, deputy commissioner of Tamenglong, commended the villagers for their commitment to protecting the amur falcon, emphasizing



the critical role of students as future guardians of the species. The program also featured a documentary video produced by the Rainforest Club Tamenglong, highlighting the majestic amur falcon and its habitat.

BENGALURU, Nov 22: Congress President Mallikarjun Kharge on Friday urged the Centre to immediately take action against billionaire industrialist Gautam Adani, following his indictment in the US in a bribery case.

Accusing Prime Minister Narendra Modi and his government of shielding Adani, he said the Congress will raise the issue during the upcoming Parliament session and demand an inquiry into the charges.

"We will raise the issue in the Parliament and we will demand an inquiry. As he (Adani) is in India, action should be taken against him, he should be arrested. The government knows everything, so they should quickly take action against him in corruption cases," Kharge told reporters here.

Adani has been charged by US prosecutors for allegedly being part of an elaborate scheme to pay USD 265 million (about Rs 2,200 crore) bribe to Indian officials in exchange for favourable terms for solar power contracts.

Adani, India's second-richest



man, and seven others, including his nephew Sagar, have been charged by the US Department of Justice with paying bribes to unidentified officials of state governments in Andhra Pradesh and Odisha to buy expensive solar power, potentially earning more than USD 2 billion in profit over

As he is doing all these things, we feel that the government is fully protecting and helping him, and through him they (BJP) are obtaining help or benefits for their party," he said.

In what seems to be comments directed at PM Modi, Kharge said, "Claiming to be just and clean in speeches is not enough, your conduct should also be clean..."

"Several investments are being taken to his state (Gujarat), instead of others. This will not lead to all India development or progress from Kanyakumari to Kashmir," the Congress veteran said, adding that "Making one person rich (hinting at Adani) will make small industries suffer. Other industrialists are also there. If you favour a person close to you so much, where will you encourage other industrialists?

Kharge said going by the way things are being done "it seems they want to become quick crorepatis or billionaires, and want to be known among the richest in the world by creating fake records of assets.

"So, he (Adani) is doing it, and he is being encouraged by Modi and Shah," he alleged. (PTI)



MUMBAI, Nov 22: Counting of votes in the Maharashtra assembly elections will begin at 8 am on Saturday, with all eyes on the outcome of the battle between the ruling BJP-led Mahayuti coalition and the Maha Vikas Aghadi (MVA) alliance, which is seeking to make a comeback.

The final turnout in the polls, held on Novem-'You all have deliberately, mischievously with the ber 20, was 66.05 per cent, up from 61.1 per cent sole intention of damaging the reputation of our client in 2019, election officials said.

Counting of votes will also be held for the Nanded Lok Sabha bypoll, where 67.81 per cent voting was recorded on November 20.

Kolhapur district led with 76.63 per cent polling, followed by 75.26 per cent in Gadchiroli, which has some Left Wing Extremism affected pockets, while the lowest was in Mumbai island city at 52.07 per cent. Mumbai suburban district recorded 55.95 per cent polling.

A total of 288 counting centres have been set up for the counting of votes on Saturday, including one for the Nanded Lok Sabha bypoll.

A total of 288 counting observers will oversee each assembly constituency, with two observers assigned to monitor counting in Nanded Lok Sabha bypoll, an official said.

The high volume of postal ballots has led to the establishment of 1,732 tables for postal ballot counting and 592 tables for Electronically Transmitted Postal Ballot System (ETPBS) to ensure a smooth counting process across all assembly constituencies, the official said.

In the Mahayuti alliance, the BJP contested 149 assembly seats, Shiv Sena 81 seats, and the Ajit Pawar-led NCP fielded candidates in 59 con-

In the opposition's MVA combine, the Con-

gress fielded 101 candidates, Shiv Sena (UBT)

95, and NCP (SP) put up 86 candidates. Parties like Bahujan Samaj Party and the All India Majlis-e-Ittehad-ul-Muslimeen (AIMIM), also contested, with BSP fielding 237 candidates and AIMIM putting up 17 candidates.

The number of candidates this time increased by 28 per cent compared to the 2019 state assembly elections. This year, 4,136 candidates contested, up from 3,239 in 2019 elections.

Among these candidates, 2,086 were independents. Rebels were in the fray in over 150 constituencies, with candidates from the Mahayuti and MVA contesting against their party's official nominees.

There were 1,00,186 polling booths in Maharashtra this time, compared to 96,654 booths in the 2019 assembly elections. (PTI)

NEW DELHI, Nov 22: Confident of an MVA win in Maharashtra, Congress general secretary Sachin Pilot on Friday said there would not be any issue among alliance constituents in deciding on the CM post after getting a majority and it would not take more than a day to "figure out who will get what po-

sition" Pilot, who was given the charge by the party in the Marathwada region and campaigned extensively in Maharashtra, Jharkhand and in constituencies where bypolls are taking place, dismissed indications by exit polls that the BJP alliance in the two states would get a ma-

In an interview with PTI a day before the results, Pilot said the results of the assembly elections in Maharashtra and Jharkhand as well as to the bypolls in various states will provide a "reality check" to the BJP and the NDA.

On the party's prospects in the recent round of assembly polls after the Harvana defeat, the Congress general secretary said Haryana was a setback and a very surprising one but Maharashtra and Jharkhand were a "separate story".

"There is a visible desire among voters to have a change in Maharashtra because this double engine government that was running was not living up to any of the expectations that the voters had," he

"The kind of campaign we ran, the kind of guarantees we promised, our coalition partners, candidate selection, our narrative was positive and was well received. So think we are going to see a change of government in Maharashtra," Pilot, who held a total of 55 public meetings during the assembly polls campaign, including more than two dozen in Maharashtra alone, said.

In Jharkhand, a sitting CM was put behind bars on some grounds and ultimately got relief from the Supreme Court. This kind of misuse of central agencies has not gone down well with the electorate

of the state, he said. "The BJP doesn't have a credible face in Jharkhand. I think in both the states, the INDIA bloc partners are in a good position to

form governments," Pilot told PTI. Talking about the impact of polls on the central government in case



the INDIA bloc wins in the two states, he said, "It is not our job to make the government stable and unstable, it is the contradictions within their alliance that will end up doing that."

"On many issues on, the allies of the NDA are not in agreement. We have seen many bills in Parliament that have been withdrawn, there is lack of consensus, lack of discussion that the ruling alliance has been used to in the last 10 years," Pilot said

The results in the Lok Sabha in Maharashtra saw an overwhelming defeat of the BJP and it was reflective of the mood in Maharashtra and it is bound to continue, he said.

Asked whether the Maha Vikas Aghadi (MVA) constituents -- the Congress, Shiv Sena (UBT) and NCP (SCP) -- would be able to decide on a CM face amicably in case

they get a majority, he said, "Running for the chair is what the BJP and its allies are doing. All of us had decided that let us first get a majority and within a day we will decide who will get what posi-

It is really not that important for any of the MVA alliance partners to stake claims and none has done that, he said.

"We have been very mature about this because people's interests are far more important than individual interests. But what is more surprising is that the sitting CM has not been projected...because Mr. Ajit Pawar (NCP) and Mr. Devendra Fadnavis (BJP) both are uncomfortable with the current CM and that was openly on display during the campaign," he claimed.

"Everyone is seasoned in the MVA. Mr (Sharad) Pawar is a multiple time CM, Mr. (Uddhav) Thackeray too has been CM before and the Congress had a historically strong presence in Maharashtra. So three very mature parties were fighting together, who gets what position is not going to be an issue at all, it will be resolved earliest once we get a majority," Pilot said.

"It will not take more than a day once we get a majority to figure out who will get what position," he

On talk of churn in Mahayuti with Ajit Pawar expressing disapproval of Uttar Pradesh Chief Minister Yogi Adityanath's 'katenge toh batenge' slogan, Pilot said he doesn't know what the Mahayuti alliance would do but asserted that the MVA is committed to people of Maharashtra and has come together with five guarantees, a joint agenda for Maharashtra and will stick to it.

"I think people have liked what we projected, they have faith in the delivery capacities of the MVA and he doesn't see any issue at all once votes are counted," he said.

Slamming Adityanath's statement. Pilot said no right thinking person will approve the comment that he has made.

"I countered the slogan saying padhoge toh badhoge'. That is what we have to tell the young generation. 'Ye baantne kaatne ki baat inko election mein yaad aati hai' (they remember this divisive rhetoric during elections)," Pilot said. "Rahul Gandhi ji has given a

very befitting reply to Modi ji's 'ek hain, toh safe hain', he has elaborated who is ek, and who is safe. Business interest and political interest combining to getting rid of India's assets, that is Mr Modi's statement," he said.

Dismissing the exit polls predicting win for the BJP alliance in Jharkhand and Maharashtra, Pilot said, "Less I say about them (exit polls), the better it is. We will wait for the day results come out."

"I am giving feedback from the ground. So in Maharashtra for example, the soya bean farmers, the cotton farmers and onion farmers are in severe distress and the (state) government and the government of India has only empty promises to give," he said.

The farming community in Marathwada and the Vidarbha region is very uncomfortable with their regime in Delhi and Mumbai,

NEW DELHI, Nov 22: The Supreme Court on Friday observed the 1976 amendment to the Constitution adding terms "socialist", "secular" and "integrity" to the Preamble underwent judicial reviews and it cannot say whatever Parliament did during the emergency period was all

A bench of Chief Justice Sanjiv Khanna and Justice Sanjay Kumar reserved its verdict on a batch of pleas filed by former Rajya Sabha MP Subramanian Swamy, advocate Vishnu Shankar Jain and others, challenging the inclusion of the words "socialist" and "secular" in the Preamble to the Constitution.

The CJI, however, said, "The subject amendment (42nd amendment) has been subjected to a lot of judicial reviews by this court. The Parliament has intervened. We cannot say that whatever Parliament did at that time (emergency) was all nullity."
The words "socialist", "secular"

and "integrity" were inserted into the Preamble to the Constitution under the 42nd constitutional amendment moved by the Indira Gandhi government in 1976. The amendment changed the de-

scription of India in the Preamble from a "sovereign, democratic republic" to a "sovereign, socialist, secular, democratic republic" Emergency in India was declared

by the late PM Indira Gandhi from

June 25, 1975 to March 21, 1977. The bench said it would pronounce its order on the issue on November 25. During the hearing, the bench refused to refer the matter to a larger bench as sought by petitioner and said being socialist" in the Indian sense was understood to be a "welfare state". Advocate Jain said in a recent



bench, the majority view doubted the interpretation of word "socialist" as propounded by former apex court judges Justices V R Krishna Iyer and O Chinnappa Reddy.

The bench then noted, "The way, we understand socialism in India is very different from other countries. In our context, socialism primarily means a welfare state. That is all. It has never prevented the private sector, which is thriving well. We have all benefited from it.

Justice Khanna said the word socialism was used in different contexts worldwide and in India it meant the state was a welfare one and must stand for the welfare of the people and should provide equality of opportunities. He said the top court held "secularism" to be part of the basic structure of the Constitution in the 1994 S R Bommai case.

Written by debutant screenwriter Harsh Vaibhav, the film plores the journey of a troubled teen, who goes on a high school expedition to a little-known prehistoric site and finds herself tested as a long-forgotten myth unfurls. Bhargav earlier adapted Ruskin Bond's "The Black Cat" for a short, which starred late Tom Alter and Shernaz Patel.

"IFFR, which is renowned as a discovery festival and for their edgy programming, is just the ideal place to launch my debut feature, 'Bokshi' (which means witch in Nepali). Nagarjuna says his grandmother used to dress up father ANR like a girl

PANAJI, Nov 22: Veteran actor Nagarjuna on Friday said his grandmother always wanted to have a girl child and when that didn't happen, she started dressing up his father and Telugu cinema star Akkineni Nageswara Rao as one.

Nagarjuna recalled his father, fondly known as ANR, would look cute in plaits and believes that's one of the factors that attracted the late legend to acting.

At an in-conversation session at the International Film Festival of India (IFFI), the actor shared many anecdotes about ANR, whose birth centenary was observed in September. The film gala is also celebrating the legacy of the Telugu cinema stalwart by showcasing a restored version of his 1953 movie "Devadasu".

"He came from a very humble family, a farmer's family. He was born near Andhra Pradesh (erstwhile part of the Madras residency), a village which didn't have electricity. "My grandmother always wanted to have a woman child. She used to dress him up (like a woman) in plaits. He used to look very pretty and cute. We still have a photograph of him dressed as a girl. He

looked exactly like my older sister Sathya. I think these were the things which led him to become an actor," Nagarjuna said.

ANR, whose seven-decade career includes diverse films such as "Vipra Narayana", "Tenali Krishna", "Sri Ramadasu", "Laila-Majnu", and "Balaraju", started out playing roles of women on

"In those days women were not allowed to be an actor or act on stage. So, he started playing women's roles. He first became a heroine on stage.

"As fate took its turn, he was at a railway station when famous producer Ghantasala Balaramayya, who was sitting in the train, saw him walking and said 'nice eyes, nice nose'. Would vou like to act? Rest, as they say, is history," recounted Nagarjuna.

In 1944, ANR got his first film "Sri Seeta Rama Jananam" as a lead. He then moved to Chennai with his older brother as his father had expired by then, Nagarjuna added.

"I distinctly remember him swaying his hips. He thought that was acting because he had done this on stage," he said.

ANR also faced a lot of mock-

him for his 'feminine' manner-


"People made fun of him and that really dejected him. He went to Marina Beach where he said he wanted to kill himself because there was so much laughter (mockery) and all of that. He told me he went waist deep into the sea water and then something in him told him (to not do it) and he corrected himself," Nagarjuna

The actor said his father, who received the Dadasaheb Phalke Award in 1990 and the Padma Vibhushan in 2011, also worked hard to make his "feeble" voice

"Somebody told him your voice becomes rougher if you smoke cigars. He didn't smoke earlier. He also used to go to the beach early in the morning and scream at the ocean for 5-10 minutes to make his voice more hoarse," he added.

Manu Bhaker led the way with an unprecedented double bronze as Indian shooters soared to a new high, returning with their best-ever haul of three medals from the Paris Olympics.

"The depth of talent available in the sport of shooting doesn't exist in any other sport in this country," Bindra, the first Indian to win an individual gold medal at the Olympics in Beijing 2008, told PTI Video in an exclusive interview at the Artemis Hospital here on Friday.

"There are so many sporting athletes performing at the national level and at the world level. This clearly shows the amount of progress the sport has made in the last decade or India's achievement at Paris

The all-rounder's appearance in Baroda's jersey is more in line with the BCCI's policy of leading cricketers mandatorily appearing in domestic tournaments.

So, his aim will be to keep in touch with the game and possibly help Baroda to a rare title victory.

But Shami's outing for Bengal is multi-dimensional. The veteran pacer will be eager to come up with a fine show to further underline his fitness after recently taking seven wickets for his state in a Ranji Trophy match against Mad-

It's a chance for him to continue to chart his way back to top-level cricket, and his efforts here will also have a bearing on him boarding the flight to Australia, at least for the latter part of the ongoing Border-Gavaskar Trophy.

That's the larger picture, but the 34-year-old will also be looking to get picked up in the IPL auction after getting released by Gujarat Titans. Considering his lofty pedigree and skills, Shami will certainly find a taker in the auction room, but a couple of power spells in the SMAT will add more gravitas to his profile when his name is read out by the auctioneer.

Similarly, Shreyas Iyer (Mumbai), who had led Kolkata Knight Riders to title in IPL 2024, and Yuzvendra Chahal (Haryana) will be looking to boost their already impressive IPL CV with fine efforts in the tournament.

After all, in the pacy auction world, a recent productive outing can further add to the monetary value surrounding a player irrespective of his stature.

A quick rewind to Shah Rukh Khan's value rising a few rungs after guiding Tamil Nadu to SMA title with a final ball six against Karnataka a couple of seasons ago will validate that point.

This year too, a plethora of young and relatively unfamiliar names will be hoping to make this tournament a platform to attract big quids from the auction.

IPL 2025 from Mar 14 to May 25, BCCI shares schedule for next 3 seasons with franchises

NEW DELHI, Nov 22:Next year's Indian Premier League will be held from March 14 to May 25, the BCCI has told the IPL franchises while also setting aside similar widows for the event's 2026 and 2027 editions in an uncharacteristically elaborate plan. The BCCI has also decided to include injury-prone England pacer Jofra Archer, Indian-born American pacer Saurabh Netravalkar and uncapped Mumbai-wicketkeeper-batter Hardik Tamore in the two-day mega players' auction to be held in Jeddah from Sunday.

In its communication to the franchises,

the Board has stated that the dates for the next three seasons are being shared at once to "assist the franchises in planning for the players' auction.'

The 2026 edition of the tournament will start on March 15 and the grand finale has been scheduled for May 31. The 2027 edition will once again start on

March 14 with the final on May 30. All three finals will be held on Sundays. The BCCI had plans to increase the number of matches in the IPL to ensure that it runs for 10 and half weeks and looking at

that the league's game count will increase. Archer did not feature in the IPL this year and his run in the 2023 edition was cut short by an elbow injury.
