lence rocked Samaguri assembly constituency where by-elections will be held on November 13 with both the ruling BJP and the opposition Congress alleging that gunshots were fired targeting each other's supporters over the last 24 hours, police said on Sunday.

It was also alleged that three journalists who went to cover the violence. which happened on Saturday, were manhandled by Congress supporters.

Chief Minister Himanta Biswa Sarma slammed the Congress for "resorting to violence under cover of darkness" to intimidate BJP workers, stating that no one would be allowed to sabotage or undermine the democratic process

"We got reports that an incident of firing took place at Mari Puthikhaiti village in Samaguri. BJP workers alleged that a shot was fired from the house of one Congress worker aiming at ruling party MLA Jitu Goswami's vehicle," a police officer said.

In the vehicle, Goswami and BJP leader Suresh Bora were travelling, although no one had been injured in the firing, he said.

In a post on X, the chief minister said, "I strongly condemn the attack on Hon'ble MLA Shri Jitu Goswami in Samaguri by @INCAssam supporters. This is the same Congress that proudly holds up the Constitution for the cameras, yet resorts to violence under cover of darkness to intimidate our karyakartas." Questioning why the Congress

"Justice will be served, and we will not allow anyone to sabotage or undermine our democratic process," the CM said.

Slamming the Congress, MLA Goswami demanded immediate punitive action against the attackers, "led by MP Rakibul to terrorise the voters".

The BJP candidate said, "I strongly condemn the incident of firing. Rakibul Hussain gave a very provocative speech last night, following which the shooting took place. We are now going to complain to the Election Commission, demanding urgent steps."

He also condemned the alleged attack on the journalists and said freedom of the press is paramount in a democracy. On Sunday, journalists held a sitin protest at Samaguri against the attack and demanded the immediate arrest of the culprits.

Amit Shah slams MVA's appeasement politics'; says Patole backs Muslim quota

JALGAON/BULDHANA, Nov 10: Union Home Minister and senior BJP leader Amit Shah on Sunday said the Congress-led Maha Vikas Aghadi could stoop to any level for the sake of appeasement and vote bank politics. He further said Maharashtra Congress chief

Nana Patole had agreed to the Ulema Council's demand for Muslim reservations.

Addressing rallies in Raver assembly constituency in Jalgaon and Malkapur seat in Buldhana, Shah pointed out to a recent memorandum submitted by the Ulema Council to the opposition Congress seeking 10 per cent reservation in jobs and education for the Muslim community.

"Patole has agreed to end reservations for SCs. STs and OBCs and give it to Muslims as demanded by the Ulema Council," Shah said in Buldhana.

The demand for 10 per cent quota for the Muslim community would eat into the benefits of Dalits, tribals and Other Backward Classes, since there is a 50 per cent cap on quota and any increase will come at the cost of existing ones, he told the gathering.

"Maha Vikas Aghadi leaders' lust for power has blinded them to long-term consequences of their actions on marginalised communities. The BJP is firmly committed to welfare of all communities but is strictly against any form of reservations for Muslims. As long as there is even one BJP MP or MLA, we will oppose religion-based reservation. This is our commitment," he asserted.

"The MVA parties have compromised the country's safety due to their appeasement politics. They are undermining national security for the sake of votes," he added.

Slamming the Congress and NCP (SP) chief Sharad Pawar, the senior BJP leader said they opposed the construction of the Ram Temple for decades, and only after Narendra Modi became prime minister, the issue was resolved with the construction of a grand temple in Ayodhya. Shah said the BJP's vision for the state aligns with the ideals of Chhatrapati Shivaji Maharaj.

The Mahayuti promises a government focused on preserving Maharashtra's culture

and prosperity, he added. Shah also dared Shiv Sena (UBT) chief Uddhav Thackeray to get Congress leader Rahul Gandhi, a Maha Vikas Aghadi ally, to hail

Hindutva ideologue VD Savarkar and Shiv Sena founder Bal Thackeray. Under the Uddhav Thackeray-led MVA dis-



pensation, which ruled between 2019 and June 2022, Maharashtra lost its competitive edge in industrial growth and the state fell to fourth rank, Shah pointed out.

Slamming the opposition parties for claiming that industries were leaving Maharashtra and new ones were not coming up, the senior BJP leader said the MVA can do no good for the state.

Hailing Prime Minister Narendra Modi, Shah said terror attacks under previous Congress-led Union governments faced no response, while the NDA dispensation ordered surgical strikes to hit camps across the border. Praising the Modi government's move to

amend the Waqf Board Act, Shah said, "In Karnataka, villages, temples and agricultural lands were converted into Waqf land. But after the Centre's amendments, such acts will not be possible."

Shah said the Modi government, between 2014 and 2024, allotted Rs 10,15,890 crore to Maharashtra, while this figure was just Rs 1.51 lakh crore under the Manmohan Singhled UPA dispensation's 10-year rule. The MVA has been misleading people and has failed to fulfil its promises, he said.

"The MVA's guarantees are nothing but lies, appeasement and involve corruption. They promise hundreds of things, but as (Congress chief) Mallikarjun Kharge rightly said, promises should be ones that can be fulfilled. The guarantees the Congress gave in Karnataka, Telangana and Himachal Pradesh were not fulfilled," he said.

The MVA cannot protect Maharashtra as its constituents are concerned about their own interests rather than that of the state or nation, he claimed.

Addressing an election rally at Gumla, he accused the JMM-led coalition of looting the state's rich resources such as minerals, forest, sand and coal, putting 'Roti-Beti-Mati' (bread, land and daughter) at grave threat. He also accused the ruling dispensation of facilitating illegal immigra-

"The Congress knows that if STs, SCs and OBCs are united, they will pose a threat to the party's existence. This is the reason the Congress shahi parivar' is hell-bent on break their unity ... They want to snatch reservations

NEW DELHI, Nov 10: Security was beefed up outside the Canada High Commission in Chanakyapuri area after Hindu-Sikh group held a protest there against an attack on a Hindu Temple in Canada. Many Sikh protestors climbed the barricades and raised slogans against the violence inside a temple in Canada's Brampton.

The protest was held under the banner of Hindu Sikh Global Forum.

Delhi Police was seen pleading the protestors to stay behind the barricades.

"We have deployed additional force and barricadings have been done outside of the High Commission of Canada following a protest march call. Our teams are not allowing anyone to breach the law and order," a senior police officer said. (PTI)

Brampton police arrests India to focus on climate finance, accountability, SFJ Canada coordinator in *protection for vulnerable communities at COP29* Hindu temple violence case

OTTAWA, Nov 10: Canadian police have arrested a 35-year-old Brampton resident on charges of assault with a weapon during a violent demonstration at a Hindu temple in the city, authorities said.

On November 3, a protest occurred at the Hindu Sabha Mandir in Brampton and unverified videos circulating on social media appeared to show demonstrators holding banners in support of Khalistan. The videos showed fist fights and people striking each other with poles on what appears to be the grounds surrounding the temple.

The Peel Regional Police responded to the altercation during the demonstration at the Mandir. As tensions between opposing sides increased, the demonstrations became physical and assaultive, a statement said on Saturday.

Police began investigating several offences that occurred during the demonstration, many of which were captured on video; including individuals using flags and sticks to assault people, it said.

Investigators from the 21 Division Criminal Investigations Bureau and Strategic Investigation Team (SIT) have arrested and charged Inderjeet Gosal of Brampton, the Peel Police statement said.

Gosal, is Sikhs for Justice coordinator for Canada, Toronto Star reported. The US-based SFJ is banned in India. On November 8, 2024, he was arrested and charged with assault with a weapon. He was released on conditions and is to appear at the (CONTD. ON PAGE-2)

NEW DELHI, Nov 10: As world leaders and climate negotiators converge on Baku for COP29, beginning Monday, India is set to bring renewed focus to the urgent need for climate finance, accountability, and protection for vulnerable communities.

Prime Minister Narendra Modi will not attend the conference, and environment minister Bhupender Yadav may also be absent, with Union minister of state for environment, Forest, and Climate Change Kirti Vardhan Singh leading the 19-member delegation instead.

India's national statement is scheduled for November 18-19. India's key priorities at the conference are likely to focus on ensuring accountability of developed nations on climate finance,

This year's negotiations are anticipated to tackle the New Collective Quantified Goal (NCQG) for climate finance, a critical benchmark that could reach trillions of dollars annually, a figure many developing nations insist is essential to combat climate change effec-

tively. Ali Mohamed, Kenya's Climate Change Envoy, reinforced the urgency for a "Finance COP" that prioritises financing without deepening debt burdens for nations already struggling to adapt to climate impacts.

"For Africa, it is important that the final goal agreed in Baku should not worsen our debt situation," Mohamed said. "The Framework on Global Climate Resilience needs to translate into real actions that support agriculture, water, health, biodiversity, infrastructure, and human settlements."

Fraud detection system blocks 13.5 mn calls, saves ₹2,500 cr: Scindia

NEW DELHI, Nov 10: The technical system deployed by the gov-ernment is blocking 1.35 crore fraud calls daily and has helped save people's assets worth ₹2,500 crore till date, Union Minister for Jyotiraditya Communications Scindia has said.

The minister, in an interview with PTI, said most of the spam calls originate from servers outside the country, and the systems have been able to block the majority of such fraudulent calls.

"In terms of the number of marketing calls you get in your phone, the number of fraud calls that come in, we have put in place a full system to be able to tackle that. Our DoT fraud detection network has saved close to about ₹ 2,500 crore of people's assets today, as we speak, through Sanchar Sathi and Chakshu," Scindia said.

The systems have led to the disconnection of close to about 290,000 phones and blocked close to about 1.8 million headers that were used for sending out messages, he added.

"Along with that, (there) was another vicarious method through which people would use servers outside India, which would masquerade themselves as a +91 number (Indian number). We have put into place software that stops these calls that are blocking an average of 13.5 mn such calls per day," the minister said.

The government has put in a new software where it is integrating law enforcement agencies as well as banks, he said, adding that "520 agencies have been onboarded"

assuming office, he issued notification of the Telecom Act, passed in Parliament last November, and now he has to mandatorily issue all rules by December.

"The first thing I did when I assumed office was I issued the notification of the Telecom Act. Why is that important? That's important because the minute you do that, then your 180-day counter starts, and within six months, mandatorily, you have to issue all the rules. So by the end of December, the total of those 31 rules, we have done almost about 14 or 15, and the balance we hope to have done by the end of December," he added.

The Telecommunications Act 2023 supersedes the existing and archaic regulatory framework for the telecommunication sector, based on the Indian Telegraph Act, 1885, the Wireless Telegraphy Act (1933), and the Telegraph Wires (Unlawful Possession) Act (1950).

The government has partially notified rules under the Act with effect from June 26. The rules allow the government to take over the control and management of any or all of any telecommunication services or network, in the interest of national security, friendly relations with foreign states, or in the event of war.

With these new rules in place. the universal service obligation fund will become Digital Bharat Nidhi, which can be used for funding research and development and pilot projects instead of just supporting the establishment of telecom services in rural areas. The new rules add a mandate of protecting users from spam and malicious communications. (PTI)

Bypoll will take place in Dholai, Sidli, Bongaigaon, Behali and Samaguri assembly constituencies as these seats fell vacant with their MLAs winning the Lok Sabha elections. The polling for the by-elections will take place on November 13 and the votes will be counted on November 23. (PTI)

Emergency, was considered a "black spot" on the judiciary. Justice H R Khanna declared the move unconstitutional and against the rule of law and paid a price as the then central government superseded him and made Justice M H Beg the next CJI.

Justice H R Khanna was part of the landmark verdict propounding the basic structure doctrine in the Kesavananda Bharati case of 1973. Among the notable judgments of Justice Sanjiv Khanna in the Supreme Court is upholding the use of electronic voting machines in elections, saying the devices were secure and eliminated booth capturing and bogus voting.

Odisha to implement NEP 2020 in universities from current academic year

BHUBANESWAR, Nov 10: The Odisha government will implement the National Education Policy (NEP), 2020, in all state-run universities and affiliated colleges from the current academic year, a statement said. The decision was taken by Chief Minister Mohan Charan Majhi, aiming to bring many reforms in the state's education system, it said.

In accordance with the NEP, four-year undergraduate programmes will be started, replacing the regular three-year courses. A student can earn a certificate, diploma, degree and degree with honours after completion of each year in the four-year programme, it added

The state government has developed a credit framework on the basis of guidelines set by the University

Grants Commission (UGC), under which, the students can involve themselves in skill development, internship, community service and extra-curricular activities, NCC and NSS to earn credits, the statement said. It will help students to choose their subjects on their own and complete their degree course within seven years with the option of multiple entries and exits from their institution, it said.

The government has also taken steps to make the higher education system more qualitative, autonomous and inclusive as per the NEP 2020.

The NEP has been designed to promote research and innovation through various schemes, practicalbased learning and skill development through internships in industry. (PTI)

India emerging as good opportunity market for Sony's gaming biz: India MD

NEW DELHI, Nov 10: India is emerging as a "good opportunity market" in the gaming business for the consumer electronic major Sony, its India Managing Director Sunil Nayyar said.

The company has reported "phenomenal growth" in the gaming business in FY24, with the robust performance of PlayStation 5 and its software peripherals.

Sony India's PlayStation dominates the console operating gaming system market here with around 95 per cent market share and has almost doubled its revenue in FY 2023-24 from the segment. However, now, it expects a moderation in the growth rates because of the high base, Nayyar said. "Now, the base is very high because we almost achieved the double business last year. So this year, we intend to have modest growth, but we are developing the gaming business market in the country, including software development and peripherals etc," the Sony India MD told PTI.

Sony India last week filed its annual returns to report over 50.1 per cent growth from its 'other business' segment at ₹ 1,363.54 crore, which houses its gaming and B2B business.

'This is largely led by the gaming business. It gave us a phenomenal growth. There is no doubt about it. PlayStation 5 and our software peripherals, everything did very well.

"So, India is now becoming a very good opportunity market for gaming for Sony... We have 95 per cent in the market today as far as PS5 is concerned. We have a very strong brand here for the gaming business," Nayyar said.

Besides, Sony is also doing well in some other niche segments such as medical equip-



ment and its sports business, where it sells Hawk-Eye systems, used in all major sporting events, including cricket, tennis, football, badminton, rugby and volleyball to visually track the trajectory of a ball and display a profile of its statistically most likely path as a moving image. "We are also growing in various niche segments like medical equipment, where we sell a lot of products (such as Microdisplays) and even sports business, where we sell Hawk-Eye. So, even sports business is doing very well," he noted. Sony India's revenue from Consumer Audio and Visuals segment increased 15.7 per cent to ₹ 6,300.20 crore in FY 2023-24 against ₹ 5,445.73 crore a year ago. Its overall profit rose 22.18 per cent to ₹ 167 crore, while revenue from operations surged 20.6 per cent to ₹7,663.74 crore.

Nayyar said the over 20 per cent growth in the topline is because of the strategy of premiumisation on which it has been working for the last few years in all product zones, including TV and audio products. "This is the primary cause because of the sales growth because our average sales price has gone up," he said,

adding that "now, we do not rely on selling entry-level or price point models"

Now, in India, everything is being upgraded in the market from content on OTT platforms to everything in the market, he said.

"This is our ongoing journey for selling premium products in the country. So, this strategy, you can say philosophy, is working well for Sony. We have upgraded, and evolved the customer into the premium segments, especially in our television lineup, home theatres and cameras," said Nayyar.

Sony India, a wholly-owned subsidiary of Japan's tech major Sony Corporation, expects to surpass its historic ₹ 11,000 crore revenue, which it recorded in FY15, in the coming years.

Its revenue fell after its parent firm exited the mobile phone and laptop business. From FY22, however, Sony India's revenue stabilised and started to report positive growth numbers. "I cannot peg a time framework, but efforts will be that we should soon become kind of ₹ 10,000 crore company in a time to come," he said.

However, Nayyar also added that the market is a little bit challenging now, and there have been ups and downs.

"We are closely monitoring the situation, but our strategy remains the same, premiumisation and selling more premium products in the country, raising the ASP, giving new technology to our customers every year in all the segments, which we play," he added. On Sony India's ongoing business in the current fiscal, Nayyar said all the categories are showing very positive momentum, especially television, sound bars, and home theatres. (PTI)

Expectations from COP29

he International Labour Organization (ILO) is getting itself ready with its agenda at UN Climate Change Conference COP29 with its key message that transition policies must prioritize labour rights and decent work and to highlight the critical role of social dialogue and labour protection so that no one is left behind. COP29 will be taking place in Baku, Azerbaijan, from 11-22 November 2024, which amid global conflicts and economic challenges, will focus on advancing inclusive climate solutions that ensure a just transition for all. As a UN observer at COP29, the ILO will be providing technical expertise and facilitating knowledge exchange. Through events such as the Just Transition Pavilion, the ILO will offer guidance on integrating these principles into climate commitments, reinforcing that inclusive policies and sustainable job creation are central to a fair and resilient future. The ILO in partnership with the European Union, is establishing a Just Transition Pavilion at COP29. The Pavilion is a venue for delegates to carry formal and informal consultations, to convene thematic events, and to network. In addition, Nationally Determined Contribution (NDC) Clinics are available to interested constituents to learn more about how just transition principles can be further and successfully integrated into the next edition of their NDC.

For developing countries in particular, climate impacts threaten efforts in realising the 2030 Agenda for Sustainable Development. As countries undertake efforts to address the climate crisis, such measures can have both positive and negative implications for jobs, livelihoods, poverty, inclusion and equality. A just transition is hence crucial to harness the benefits of a resilient low carbon economy, create decent work, and ensure no one is left behind. This conference is set against a global backdrop of interlinked crises marked by conflicts, socio-economic fragility, and the need to build social consensus for climate action that leaves no one behind. The need for ambition and action is more critical than ever to preserve the 1.5-degree target and move the world towards a climate-resilient pathway while ensuring a just transition for all. Throughout the conference, the UN's labour agency will ensure that workforce perspectives are integral into climate discussions. This includes advocating for social protections and adopting policies that empower marginalized groups, including women, and indigenous communities.

ILO's climate action for jobs initiative emphasises that Climate and employment goals can and must go hand in hand. The Paris Agreement on climate change, adopted in 2015, highlights the imperatives of a just transition and the creation of decent work as essential dimensions of climate change. While some important progress has been made, the required scale of efforts needed to meet the Sustainable Development Goals (SDGs) by 2030 is not yet enough. The Climate Action for Jobs Initiative will contribute to a Decade of Action, accelerating climate action through a just transition

Trump's return: A new chapter for America and the world

he 2024 United States presidential election has concluded, with Donald J. Trump securing a remarkable victory. Despite ongoing counts and official declarations, Trump has already declared himself the winner. This result marks a significant shift in American politics, bringing a mix of continuity and radical change to both domestic and international affairs. The election was driven by crit-

ical issues that resonate deeply not only within the US but across the globe. Economic concerns, particularly high inflation and recovery from the pandemic, dominated voters' minds. With cost-of-living issues, job security, and healthcare access at the forefront, Trump campaigned on a platform of fiscal conservatism, promising lower taxes, reduced government spending, and deregulation to stimulate growth and combat inflation. His promises to invigorate the economy through a pro-business agenda found a receptive audience among working-class Americans, who felt neglected by the current administration's handling of economic recovery Immigration policy was another

contentious issue, with Trump doubling down on his signature proposals for stricter border controls and enhanced enforcement measures, framing immigration as a matter of both national security and economic stability. He emphasized the need for stronger physical barriers at the US-Mexico border, a position that resonated with voters concerned about the perceived strain of illegal immigration on public services and job opportunities for American citi-

On healthcare, Trump called for a rollback of the Affordable Care Act, advocating for a more marketdriven approach with tax credits and increased competition among providers. However, his position has drawn criticism for potentially reducing access to affordable care for vulnerable populations. Additionally, Trump's climate policy, focused on energy independence through expanded oil and gas production, stands in stark contrast to calls for robust climate action, raising concerns over the long-term sustainability of his environmental stance

However, perhaps the most consequential aspect of Trump's return to power will be his approach to foreign policy. Trump's "America First" ideology has long emphasized reducing US involvement in foreign conflicts and renegotiating international agreements to safeguard American interests. His return to office is likely to bring a more transactional approach to global relations, where alliances and trade deals will be evaluated through the lens of immediate national benefit.

The implications for global security, particularly in relation to Russia and China, are profound. Trump's stance on the Ukraine war, which had already been characterized by skepticism during his first term, may shift US support

away from Ukraine. His potential withdrawal of military and economic aid could embolden Russia's territorial ambitions, altering the security dynamics in Europe and beyond. Similarly, Trump's skepticism towards NATO may

without relying on American guarantees. In the Middle East, Trump's hawkish foreign policy is expected to align closely with Israeli interests, particularly in Gaza and Lebanon, and could lead to increased support for aggressive Israeli military actions. His stated support for Prime Minister Netanyahu could significantly impact the ongoing Is-

raeli-Palestinian conflict. Trump's approach to Iran

also poses a major question: his presidency could either accelerate Iran's nuclear ambitions or prompt a renewed arms race in the region, potentially encouraging other Middle Eastern countries to pursue their own nuclear capabilities.

On trade, Trump is likely to resurrect his protectionist policies, focusing on tariffs as a means to revive American industry. His previous administration's tariffs on Chinese imports are expected to continue, with the potential to extend to other countries like India. While this approach remains popular with his base, the economic consequences-particularly for consumers-could American

prove more damaging in the long term

For India, Trump's return presents a paradox. While he has often expressed admiration for Prime Minister Narendra Modi, his "America First" doctrine could prompt European nations to reconclash with India's economic and sider their security arrangements trade policies. Issues such as the high tariffs India imposes on US goods and the future of the H-1B visa program, which many Indian professionals rely on, are likely to remain points of contention. However, Trump's personal rapport with Modi may provide a diplomatic cushion, easing tensions over trade and other bilateral mat-

> ters. Domestically, the Democratic Party faces a DEGREE OF THOUGHT challenging road

ahead. Kamala Dipak Kurmi Harris' candidacy failed to inspire significant voter support, particularly in swing states, where Trump's appeal to disaffected voters proved decisive. Harris, despite her progressive credentials, struggled to overcome the economic and security concerns that dominated the race. Her inability to connect with key demographics, especially the working class and moderate voters, left her vulnerable to Trump's populist campaign. As the Republican Party solidifies control of both the Senate and the House of Representatives, Trump will enjoy a more favorable political environment than during his first term. Trump's victory in 2024 signals a departure from the more traditional, predictable foreign and domestic policies that characterized previous administrations. The world now faces a new phase of geopolitical uncertainty, where longstanding alliances and global norms may be reshaped by a president who views international relations primarily through a transactional lens. In this unpredictable landscape, India, like many other nations, will need to navigate a complex relationship with the US, balancing economic opportunities with the challenges posed by Trump's unorthodox approach to diplomacy and trade.

Ultimately, Trump's return to power is both a triumph for his supporters and a source of deep oncern for his critics. His victory has realigned the political landscape in the US, reshaping the discourse on domestic issues like healthcare, immigration, and the economy. rmany, the biggest eco-Tnomic power of the Western nations in Europe was plunged in a major political crisis as the shaky three party coalition led by the Chancellor Olaf Scholz of SPD became a minority in the Parliament on Wednesday night after the partner Free Democratic Party withdrew its support to the Scholz government.

The Scholz coalition has been ruling by taking support of 91 members of FDP and 117 members of Green Party. SPD has its own strength of 207 members. So, in a house of 733 members, the three party coalition had a clear majority. Now with the withdrawal of FDP's 91 members, the Scholz government has the support of only 324 members as against the needed majority of 367 members.

Right now, in German Parliament, the opposition CDU/CSU has got 196 members while the far right AfD which is a surging force in the latest provincial elections. has 76 seats. The Left group led by Die Linke has got 28 seats while the split away group of Die Linke has got 10 seats. There are eight non-attached members.

Chancellor Scholz has assured to seek no= confidence motion on January 15 next year and seek national elections in March 2025 preponing it from the original schedule of September 28, 2025. The opposition parties, especially CDU are not agreeable to that. They are demanding elections in January next year itself since the present state of instability is bad for the German economy at this stage. The political commentators also share this view since there is little hope of a stable government in Germany even if the Scholz regime wins the no-confidence vote.

Whatever be the decision finally about the date of the next national elections, the political turmoil is going to stay and this has given a fresh opportunity to the far right AfD to expand its base and going to the German people with its campaign plank against refugees and immigrants as also the promise of creating jobs for the German vouth

The CDU/CSU which ruled Germany for many years led by prominent chancellors like Angela Merkel is preparing for the coming

elections Friedrich Merz, the CDU leader is aspiring to contest for the chancellor's position. He is trying to see that the elections are held early and the Scholz coalition faces more embarrassment in the coming days so that he can emerge stronger in the election campaign. Chancellor Scholz needs the

support of other opposition leaders to approve his budget and some other immediate issues related to expenditure including defence payments. Merz and other opposition leaders may approve this only with the condition that Scholz will have to call elections in January and not March. This development may force the chancellor to agree to call elections in January next year instead of March planned by him.

In the recent opinion polls, the Christian Democrats did well compared to SPD but the AfD and the left wing BSW did much better. In the latest provincial elections, the AfD increased its vote share along with the BSW. The SPD which was the dominant ruling party in these provinces earlier is now working for a coalition with other parties to prevent AfD from taking reign of the state governments.

In sum, the election season has started in Germany but the uncertainty for the German people persists as the economy is in a bad state and there is no guarantee that a stable government will emerge out of the next year's elections. (IPA Service)

But, the ruling side has just man aged to release its composite manifesto. Although the first of the two-phase election is scheduled for November 13, it is yet to start its campaign on a serious note.

As such, women are often expected to prioritize family over employment. Data clearly shows that the presence of children, especially young children (under the age of 6), significantly decreases women's likelihood of being in the workforce.

For women with young children living in couples or extended families, labour force participation is12 to 14 percentage points lower than among those without young children.

Meanwhile, men's participation is largely unaffected by the presence of young children and may even increase. The net result is stark gender gaps in participation - 38 percentage points for couples and 36percentage points for extended families with young children, compared to a 23-percentage point gap for those without children. This unequal distribution of unpaid care work between women and men hinders women's economic inclusion and effective labour market participation and widens gender gaps in the world of work, says the ILO brief.

ILO data show that since 2018 many countries have made progress in promoting the participation of women careers by increasing investments in early childhood care and education. However, in a world being reshaped by demographic shifts, with ageing populations, and climate change, which intensifies unpaid care work, the demand for care services is likely to increase.

Therefore, ILO calls for urgent action to ensure decent work in the care economy and to promote decent work by ensuring access to care for all, by giving effect to the ILO Resolution adopted by governments, employers' and workers' organizations at the International Labour Conference in June 2024. What are the physical symptoms of anxiety?

There are many physical symptoms that can result from anxiety. These can include sweating hands, shaking legs, and a fast heart rate.

Moderate anxiety levels are part of the human survival instinct. When someone has exposure to a perceived threat, their body triggers a response to help them focus and spur them into action.

However, some people struggle with constant or overwhelming anxiety during their daily lives when there is no threat. They may feel nervous, worry about everyday events, and experience physical symptoms of anxiety that make life challenging

This article explores anxiety and how it affects the body. It looks at the physical symptoms of anxiety and why they happen. It also discusses some potential treatments and when to get advice from a healthcare professional.

What is anxiety?

Anxiety is the body's response to a stressful situation, such as attending a significant event or speaking in public. It is normal to feel nervous, tense, or apprehensive in these circumstances.

However, some individuals experience these emotions in situations that are not typically stress-inducing. They may have feelings of extreme and overwhelming anxiety, which may cause heart-pounding panic and irrational fears. These people may have an anxiety disorder.

Anxiety disorders are common. They are more prevalent among females than males.

Types of anxiety

Anxiety is a common compo-

nent of several different anxiety disorders, including: 1. Obsessive-compulsive

disorder (OCD): OCD is characterized by repetitive irrational thoughts that cause an individual to repeatedly perform specific behaviors in a particular

2. Panic disorder: Someone may experience random, recurring panic attacks that consist of a sudden period of intense anxiety and fear.

3. Post-traumatic stress disorder (PTSD): Individuals who have experienced a traumatic event may develop PTSD. PTSD manifests as flashbacks, nightmares, uncontrollable thoughts, and severe anxiety.

4. Illness anxiety disorder: Formerly known as hypochondria, a person may have illness anxiety disorder when they are overly anxious about their health and imagine that they have physical ailments.

5. Phobia: People with phobias experience a high level of fear due to a specific situation, activity, object, or event.

6. Social anxiety disorder: This disorder affects people in and before social situations and interactions with others. It can cause overwhelming fear.

7. Separation anxiety disorder: If someone fears being away from a particular person or place, they may have a separation anxiety disorder. This is prevalent among young children but affects adults as well. How does anxiety affect the body?

Although anxiety disorders come under the umbrella of mental health conditions, they can also cause physical reactions.

In addition to distress, fear, blurry vision

and worry, a person may have physical symptoms of anxiety, including:

• a dry mouth • lightheadedness or feeling faint

 hot flashes or chills restlessness • shortness of breath

• sweating • tingling or numbness

• an increased heart rate shaking nausea

• gastrointestinal symptoms, such as constipation, diarrhea, or indigestion • changes in appetite

Panic attacks can occur suddenly. If a person experiences a panic attack, they may feel that they are in extreme danger or are losing control. People can have strong phys-

ical reactions during a panic attack, and they may even feel as though they are having a heart attack Some symptoms of a panic

Why the body responds to anxiety?

Stressful life events can trigger panic attacks. However, panic attacks do not always have an obvious cause. The physical symptoms of panic attacks are due to the body's fight-or-flight response, which generates fear and anxiety.

During the fight-or-flight response, an individual responds to authentic and unreal danger in the same way and with the same physiological reactions. For example, their heart and breathing rates increase, they have a surge of adrenaline, and their senses become hyperalert. A person's body responds in

this way because it is preparing to either fight the threat or run away from it.

The increase in blood flow prepares the muscles to flee from danger and allows the brain to focus and make quick decisions. The rapid breathing provides the body with more oxygen, ready to escape.

However, these things may cause the individual to feel as though they cannot get enough air, which may result in further feelings of panic. The long-term effects

Anxiety disorders can cause people to avoid situations that they know trigger negative emotions. They may feel ashamed that they cannot live their lives as everyone else does. In turn, this may lead to increased social isolation and further withdrawal.

When this happens, a person may enter a cycle of living in fear of fear, meaning that the fear of a panic attack causes them to have more panic attacks.

If someone has chronic anxiety, they are always on high

alert. This may negatively affect their cardiovascular, digestive, immune, and respiratory health.

Is it anxiety?

If a person experiences panic and anxiety, they should talk with a healthcare professional. They can rule out the possibility of other conditions and physical causes, such as:

• mitral valve prolapse • hyperthyroidism, or an overactive thyroid gland

 hypoglycemia, or low blood sugar levels • stimulant use, such as that

of amphetamines, cocaine, or caffeine • medication withdrawal

Managing physical symptoms

Healthcare professionals can help people cope with the physical symptoms of anxiety by suggesting a combination of medications and psychotherapy. Some research notes that combining these methods can be effective.

Medications

Medications do not cure anxiety, but they help can people manage their symptoms more effectively and prevent them from affecting their daily routine. The type of medication a healthcare professional recommends may differ depending on the individual's symptoms and the severity of their anxiety.

One group of medications that healthcare professionals may prescribe to treat anxiety disorders such as social anxiety disorder and panic disorder are benzodiazepines. Examples of benzodiazepines include alprazolam (Xanax) and diazepam (Valium)



Military says it only targets militants, whom it accuses of hiding among civilians

Palestinian hospital official says 17 killed in Israeli strike on northern Gaza

DEIR AL-BALAH (GAZA STRIP), Nov 10: An Israeli strike early Sunday on a home sheltering displaced people in the northern Gaza Strip killed at least 17 people, according to the director of a nearby hospital that received the bodies

Dr Fadel Naim, director of the Al-Ahly Hospital in Gaza City, said the dead include nine women, and that the toll was likely to rise as rescue efforts continue. He said they were killed in a strike on a home in the urban refugee camp of Jabaliya, where Israel has been carrying out an offensive for over a month.

The military said it targeted a site where militants were operating, without providing evidence. It said the details of the strike are under review.

Separately, Lebanon's Health Ministry says an Israeli airstrike on Sunday killed at least 20 people in the village of Aalmat -- north of Beirut and far from the areas in the



south and east where the Hezbollah militant group has a major

presence. Israeli forces have encircled and largely isolated Jabaliya and the nearby towns of Beit Lahiya and Beit Hanoun for the past month, allowing in only a trickle of humanitarian aid. Hundreds of people have been killed since the offensive began on Oct 6, and tens

of thousands of people have fled to nearby Gaza City.

Shaker stated that he and CC-2 had served time in prison together. Shaker informed the FBI that he had provided this surveillance to IRGC Official-I. According to Shaker, after being provided surveillance on the Israeli consulate, IRGC Official I asked him to identify another target.

After this Shaker then instructed CC-2 to surveil a tourist location in Arugam Bay frequented by Israeli tourists. IRGC Official-I instructed Shaker to orchestrate a mass shooting at the Arugam Bay location. They planned that CC-2 would supply AK-47s and other weapons for the attack, federal prosecutors said. (PTI)

Qatar suspends its mediation efforts on Gaza, Hamas office there may have to leave

One strike hit a school-turned-shelter in Gaza City's eastern Tufah neighbourhood, killing at least six people, the territory's Health Ministry said. Two local journalists, a pregnant woman and a child were among the dead, it said. Israel's army said the strike targeted a militant belonging to the Palestinian Islamic Jihad group, offering no evidence. Another Israeli strike killed seven people, including two women and a child in the southern city of Khan Younis, according to Nasser Hospital. Israel's army didn't respond to a request for comment. And an Israeli strike hit tents in the courtyard of central Gaza's main hospital, killing at least three people and wounding a local journalist, Al-Aqsa Martyrs hospital in Deir al-Balah said. It was the eighth Israeli attack on the compound since March.

The Israeli military body in charge of humanitarian aid to Gaza, COGAT, said 11 aid trucks containing food, water and medical equipment reached the enclave's far north on Thursday. It's the first time any aid has reached there since Israel began a new military campaign last month.

But not all the aid reached the agreed drop-off points, according to the the U.N. World Food Program. In the urban refugee camp of Jabaliya, Israeli troops stopped one convoy bound for nearby Beit Lahiya and ordered the supplies to be offloaded, WFP spokesperson Alia Zaki said.

Israel's offensive has focused on Jabaliya, where Israel says Hamas had regrouped. Other areas affected include Beit Lahiya and Beit Hanoun just north of Gaza City. (AP)

Drones strike Moscow as top UK official highlights Russian casualties in Ukraine

KYIV, Nov 10: A massive drone strike rattled Moscow and its suburbs overnight into Sunday, injuring a woman and temporarily halting traffic at some of Russia's busiest airport, officials said.

A top U.K. defence official meanwhile said that Russian forces had suffered their worst month of casualties in October since their fullscale invasion of Ukraine in February 2022

The chief of the U.K. defence staff, Tony Radakin, told the BBC that Moscow's troops suffered an average of 1,500 dead and wounded "every single day," bringing their total losses in the war to 700,000.

Moscow Mayor Sergey Sobyanin said a total of 32 drones were shot down over the Russian capital's outskirts. Russia's aviation authority said flights were briefly grounded at major international airports including Sheremetyevo and Domodedovo.

A woman in her 50s suffered burns to her face, neck and hands after drones sparked a blaze in her village southeast of Moscow, local Gov. Andrei Vorobyov reported.

No one was hurt in Moscow itself, according to Sobyanin, although Russian channels on the messaging app Telegram carried eyewitness reports of drone debris setting fire to suburban homes

According to Radakin, ordinary Russians were paying "an extraordinary price" for the war, even as a grueling, monthslong Russian offensive in Ukraine's industrial east continues to eke out gains. He did not say how UK officials had calculated the Russian casualty figures.

"There is no doubt that Russia is making tactical, territorial gains and that is putting pressure on Ukraine," he said

But he said the losses were for "tiny increments of land," and that Moscow's mounting defense and security spending was putting an increasing strain on the country.

Radakin insisted that Ukraine's Western partners should stand by it for "as long as it takes" to beat back Russian aggression, even as allies of U.S. President-elect Donald Trump have signaled that Kyiv may have to

cede territory to seek peace. Both Moscow and Kyiv have kept a tight lid on casualty figures since the start of the full-scale war despite regular reports of Russian forces taking huge losses following "human wave" attacks that aim to exhaust Ukrainian defences. (AP)

DEIR AL-BALAH (GAZA STRIP), Nov 10: Qatar has suspended its key mediation efforts between Hamas and Israel, it said Saturday, after growing frustration with the lack of progress on a cease-fire deal for Gaza.

It wasn't immediately clear whether the remaining Hamas leadership hosted by Qatar must leave, or where it would go. Hamas has good relations with Iran and Turkiye, and some of its leaders are now in Lebanon. However, Qatar is highly likely to return to mediation efforts if both sides show "serious political willingness" to reach a deal, according to an official with Egypt, the other key mediator.

Qatar told Israel and Hamas it can't continue to mediate "as long as there is a refusal to negotiate a deal in good faith" and "as a consequence, the Hamas political office no longer serves its purpose" in Qatar, a diplomatic source briefed on the matter said. Qatar told Hamas it will have to leave if it isn't ready to engage in serious negotiations, the source said. In Washington, a US official said the Biden administration informed Qatar two weeks ago that the Hamas office's continued operation in Doha was no longer useful and the Hamas delegation should be expelled.

A senior US official said that after Hamas rejected the last proposal for a cease-fire, Qatar accepted the advice and informed the Hamas delegation of the decision 10 days ago. A senior Hamas official said they were aware of

Qatar's decision to suspend mediation efforts, "but no one told us to leave." Hamas has repeatedly called for an end to the war and a full withdrawal

of Israeli forces from Gaza as a condition for any cease-fire deal. Israel seeks the return of all hostages taken in Hamas' Oct. 7, 2023, attack on Israel and insists on a presence in Gaza.

The officials spoke on condition of anonymity because of the sensitivity of the issue. The Israeli prime minister's office had no comment.


Late Saturday, the state-run Qatar News Agency published comments attributed to Majed bin Mohammed al-Ansari, a Foreign Ministry spokesman, confirming that Doha informed parties in the talks 10 days ago that it "would stall its efforts to mediate between Hamas and Israel if an agreement was not reached in that round.'

"Qatar will resume those efforts with its partners when the parties show their willingness and seriousness to end the brutal war and the ongoing suffering of civilians," the report said.

There continued to be no end in sight to the Israel-Hamas war in Gaza and the Israel-Hezbollah war in Lebanon, where Israel's military said it struck command centers and other militant infrastructure in Beirut's southern suburbs and elsewhere. An Israeli airstrike on the southern port city of Tyre late Friday killed at least seven, officials and a resident said.

Hezbollah "should continue (the fight) and we will continue to back them up even if we lose our families, our homes, and end up in the dirt," said one Beirut resident, Mohammed Mekdad, as people searched the smoking rubble.

In Gaza, Israeli strikes killed at least 16 people on Saturday, Palestinian medical officials said, while Israel announced the first delivery of human-



China to display new fighter jet, drone ship Bangladesh's interim govt to seek Interpol support to repatriate Hasina nd inclusivity," it said.

BEIJING, Nov 10: The Chinese military will unveil some of its latest warplanes, including a new fighter jet and a large drone ship known as the "Killer Whale", at its upcoming annual air show in Zhuhai city. The 15th Airshow of China is to be held in Zhuhai at South China's Guangdong province from November 12 to 17. The People's Liberation Army (PLA) every year displays its capabilities at the air show.

The PLA Navy will display J-15T jet designed to be operated from the 3rd aircraft carrier, the Fujian, which is equipped with an electromagnetic catapult unlike the other two carriers, Liaoning and Shandong, which are fitted with ski-jump takeoff ramps.

The design of the J-15T is based on the baseline type of the J-15 and was modified to allow it to be launched by an aircraft carrier's catapult system, official media here reported Wang Yanan, chief editor of Aerospace

Knowledge magazine told the state-run China Daily that the J-15T can also be deployed on Liaoning and Shandong, both of which have a ski jump method for launching fixed-wing aircraft.

The navy also unveiled a large drone ship known as the "Killer Whale" to be displayed at the air show.

The trimaran is capable of "operating on open sea for a long time", according to Hong Kong-based South China Morning Post.

It said the "Killer Whale" has a dual diesel and electric propulsion system, which allows it to reach a maximum speed of more than 40 knots (74km/h) with a range of more than 4,000 nautical miles (7,400km). (PTI)

DHAKA, Nov 10: Bangladesh's interim government on Sunday said it will seek Interpol's assistance in repatriating deposed prime minister Sheikh Hasina from India, and other "fugitives", to face trial for alleged crimes against humanity. Hasina and her party leaders face accusations of ordering brutal suppression of the Anti-Discrimination Students Movement, resulting in numerous casualties during the July-August protests. The movement later intensified into a large-scale uprising, forcing Hasina to secretly flee to India on August 5.

According to the interim government led by Chief Adviser Muhammad Yunus, at least 753 people were killed and thousands injured during the protests, which it termed crimes against humanity and genocide. Over 60 complaints of crimes against humanity and genocide have been filed against Hasina and her party leaders with the ICT and the prosecution team till mid-October. "A Red Notice will be issued through Interpol very soon. No matter where in the world these fugitive fascists are hiding, they will be brought back and held accountable in court," Law Affairs adviser Asif Nazrul told reporters here after inspecting the status of renovation at the International Crimes Tribunal (ICT), which is housed in the Old High Court building on the Supreme Court premises.

Officials said a Red Notice is not an international arrest warrant, but rather a global request for law enforcement agencies to locate and provisionally arrest a person pending extradition. surrender, or similar legal action. Interpol member countries enforce Red Notices according to their own national laws.

The ICT was originally formed by the Hasinaled Awami League government in March 2010 to try the perpetrators of the crimes against humanity committed during the 1971 Liberation

War. It later formed ICT-2, and at least six Jamaat-e-Islami and leaders of Hasina's arch rival Khaleeda Zia's BNP party were executed following the judgments of the two tribunals. The tribunal remained dormant since mid-June after its chairman retired. The interim government reconstituted the tribunal on October 12.

On October 17, the tribunal issued arrest warrants against Hasina and 45 others, including her son Sajeeb Wazed Joy and several of her former cabinet members. The interim government had earlier said that Hasina and several of her cabinet colleagues and Awami League leaders will be tried in this special tribunal.

However, Chief Adviser Yunus in an interview with the UK-based Financial Times newspaper last month said his government would not immediately seek Hasina's extradition from India, an approach seen as preventing diplomatic tensions between the two countries. (PTI)

The group urged "greater consideration" at future celebrations intended to promote multiculturalism and inclusivity, mindful of the "cultural and religious practices of the communities they seek to honour".

Pandit Satish K. Sharma, author and Dharmic speaker, noted: "The complete lack of sensitivity and simple consultation, at any level, is of great concern. If accidental, it's still disappointing.'

Others have commented on these posts expressing their surprise over the move. Some British Hindu groups have also flagged their lack of invitation to the reception, held regularly over the years at Downing Street and last hosted by Conservative leader Rishi Sunak – the first British Hindu prime minister of Britain. Multilateral banks are key to financing fight against global warming

BAKU, Nov 10: As climate change leads to a seemingly endless stream of weather disasters around the world, countries are struggling to adapt to the new reality. Preparing to better withstand hurricanes, floods, heat waves, droughts and wildfires will take hundreds of billions of dollars

And then there is confronting the root cause of climate change-the burning of fossil fuels like coal, gasoline and oil—by transitioning to clean energies like wind and solar.

That will take trillions of dollars. Enter climate finance, a general term that means different things to different people but boils down to: paying for projects to adapt to and combat the cause of climate change. Financing related to climate change is especially important for developing countries, which don't have the same resources or access to credit that rich countries do. International mega banks, funded by taxpaver dollars, are the biggest, fastest-growing source of climate finance for the developing world. Called multilateral development banks because they get contributions from various countries, there are only a handful of these banks in the world, the World Bank the largest among them.

How these banks allocate resources are some of the weightiest decisions made in defining how poorer nations

can respond to climate change. They were a key reason why, in 2022, the world met a goal countries had set in 2009 to supply developing nations with \$100 billion annually to address climate change.

At the annual U.N. climate conference that opens Monday in Azerbaijan. global leaders are expected to discuss how to generate trillions of dollars for climate finance in the years to come. The nonprofit research group Climate Policy Initiative estimates the world needs about five times the current annual amount of climate financing to limit warming to 1.5 C (2.7 degrees F) since the late 1800s. Currently, global average temperatures are about 1.3 C (2.3 degrees F) higher.

A new goal needs to reach higher and hold institutions and governments accountable to their promises, said Tim Hirschel-Burns, an expert at Boston University's Global Development Policy Center.

"The core of it is getting a goal that is going to catalyze the actions that fills the really significant climate finance gap that developing countries face, which is much bigger than \$100 billion," he said.

As the international community has come to accept the reality of climate change, the debate has shifted to the question of where the money to fund



the energy transition will come from, said Dharshan Wignarajah, director of Climate Policy Initiative's Londonbased office.

"The question is not are we going to transition?', but how quickly can we engineer the transition?" said Wignarajah, who helped lead the climate talks, called the Conference of Parties, when the United Kingdom was host in 2021. "That has forced finance to be ever-more prominent at the COP discussions, because ultimately it comes down to who pays." Developing nations are much more reliant on these banks for financing climate projects than industrialized countries.

In the U.S. and Canada, commercial banks and corporations provided funding for more than half of climatefriendly projects in 2022, according to Climate Policy Initiative. In sub-Saharan Africa, those private lenders only accounted for 7%. This is because it is harder for developing countries to get low interest rates.

"If you're Kenya, and you want to borrow from private lenders, they might charge you 10% interest rates because your credit rating isn't very good," Hirschel-Burns said.

But the multilateral banks have better credit ratings than many countries do. For example, the International Development Association — an arm of the World Bank and the top international aid provider to Kenya - has the highest possible rating from Moody's Investor Service, while Kenya itself has a junk rating. The banks borrow money

with that better rating, then lend to developing countries in turn, offering a more reasonable rate than governments could get if they borrowed directly from private lenders.

The multilateral banks' development goals are wide-ranging. They seek to improve people's health and the environment, expand energy access and end poverty. Addressing energy access has meant the banks have provided billions of dollars for fossil fuel power plants, according to an AP analysis, though their policies have improved and fewer such projects have been funded in recent years.

Investment in fossil fuels continues to rise worldwide, reaching \$1.1 trillion in 2024, according to the International Energy Agency. And multilateral banks continue to rank among the biggest funders of fossil fuel-prolonging projects, helping to "lock in a high-carbon pathway" for countries, according to a report by the Clean Air Fund, which lobbies for the funding of projects to improve air quality.

"This is development aid we're talking about, and it should be assisting countries to leapfrog," said Jane Burston, CEO of the Clean Air Fund, referring to the idea that developing countries could industrialize with renewable energies and skip over development that rich nations historically

made with fossil fuels "It's baffling why development assistance is being given to something that continues to make people unhealthy as well as harms the planet,"

she added Seemingly contradictory actions can be seen in a loan made by an arm of the World Bank, the International Bank for Reconstruction and Development. It loaned \$105 million toward rehabilitat-

ing coal plants in India, with their last loans toward the project going out in 2018, according to an Associated Press analysis of data from the Organization for Economic Cooperation and Development.

Coal spews carbon pollution, contributing to climate change and creating breathing problems for people who are exposed. However, the improvements made coal plants more efficient and reduced their greenhouse gas emissions, according to project documents. The Clean Air Fund's report estimated the World Bank provided \$2.7 billion in "fossil fuel prolonging finance" between 2018 and 2022. During

that time, the bank also loaned about 32 times the amount for renewables as they did for non-renewables in India. including \$120 million for rooftop solar.

"Renewable energy support is always our first choice as we work to provide access to electricity to the nearly 700 million people who still cannot power their homes, schools, hospitals, and businesses," a World Bank spokesperson said in a statement. The bank's policies still "selectively support natural gas as a transition fuel" if its research shows the project is low risk to the climate, the spokesperson said. The bank's recent policies require rigorous vetting for every project to make sure its investments reduce climate impacts.

The World Bank delivered \$42.6 billion in climate finance in its most recent fiscal year, a 10% increase from the year before. And at the most recent COP, the bank promised nearly half of its lending will soon go toward climate finance.

In Vietnam, about half of power generation comes from fossil fuels, primarily coal power. The Asian Development Bank loaned about \$900 million on coal in Vietnam, with their spending on the fossil fuel in the country ending in 2017. The bank's updated climate policies "will not support coal mining, processing, storage, and transportation, nor any new coal-fired power generation," the bank said in a statement. The bank put \$9.8 billion toward climate finance in 2023, and aims to finance \$100 billion in climate-friendly projects between 2019 and 2030. (AP)

AGARTALA, Nov 10: A four-month-old baby boy was rescued in Tripura following allegations that he was sold by his mother for ₹ 4,000due to extreme poverty.

The incident came to light after CPI (M)'s Bishalgarh sub-divisional committee secretary Partha Prathim Majumder in a Facebook post alleged that a worker of the Basumati Tea Estate in Sepahijala district sold her baby for ₹ 4,000 due to extreme poverty. He claimed that the woman has four children and she alone is taking care of them. As the post went viral, the administration swung into action with the help of the child line, and sent personnel to the hutment where the woman lives, officials said.

During the course of the investigation, the baby was found with a couple from Udaipur in Gomati district, they said.

It appears the woman is separated from his husband who is also a tea garden labourer. MUMBAI, Nov 10: Confident of the MVA getting a majority in the Maharashtra Assembly polls, senior Congress leader and former chief minister Prithviraj Chavan on Sunday asserted that it is a "timehonoured" practice" that the party that emerges as the largest within an alliance gets to name the CM.

In an interview with PTI, Chavan (78) also dismissed as "BJP propaganda" suggestions that the Congress' Haryana loss had damaged the opposition alliance's prospects in Maharashtra and taken away the momentum.

"Haryana and Maharashtra are not comparable. If you look at the Lok Sabha poll results, Haryana had a 5-5 result (five seats to the Congress and five to the BJP), but in Maharashtra we (MVA) had 65 per cent 35 per cent result. There is a huge difference," Chavan, who was the Maharashtra chief minister between November 2010 to September 2014, said

He also asserted that the social dynamics of Haryana are different, and in any case each of Maharashtra's multiple region has its own social complexion.

On who would be the chief minister if the Maha Vikas Aghadi (MVA) comes to power, Chavan

said, "It is a time-honoured practice that the largest party (postpolls) gets to name the CM. I don't see why it should be different this time. But this time if the three parties together want to change the formula they are free to do that. Leaders can do anything they want.

Chavan pointed out that NCP (SCP) leader Sahrad Pawar has also stated that the party with the highest number of seats among the alliance partners gets to decide on the CM.

Asked if he is in the running for the post of chief minister, Chavan said, "That is a ridiculous question. Don't ask that, first you have to win the election. Our priority is to win the election. As I said, Mr. Pawar has stated the largest party

will get to name the CM." Chavan also dismissed talk of bickering among MVA constituents -- Congress, Shiv Sena (UBT) and NCP (SCP) -- over seat-sharing, saying the agreement on nearly all the 288 seats was a 'remarkable achievement".

"We are talking about 288 seats primarily between three parties and some other parties as well. There are only 3-4 places where two parties are contesting against



each other and there are some rebel candidates which cannot be helped," he told PTL "Rebel candidates being there is

not bickering. The MVA is broadly united," Chavan said. He said Congress president

Mallikarjun Kharge, former party chief Rahul Gandhi and other senior leaders discussed and then released the guarantees for Maharashtra.

"We did all the pluses and minuses, we did all the pros and cons, we discussed and then all the parties came to an agreement," he said when asked if the guarantees made by the MVA were financially viable.

The MVA alliance last week unveiled its guarantees, promising ₹ 3.000 per month and free travel on state transport buses for women in Maharashtra. Under the Krishi Sammruddhi

Yojana, farmers will get loan waiver up to ₹ 3 lakh and ₹ 50,000 as an incentive for regular repayment of crop loans, the Shiv Sena (UBT)-NCP(SP)-Congress alliance announced ahead of the November 20 assembly elections.

Allowance of ₹ 4,000 per month for unemployed youth, health insurance up to ₹ 25 lakh and free medicines were the other "guarantees" announced at a gathering addressed by top MVA leaders at the BKC ground in Mumbai.

The MVA has also promised to conduct a caste survey in the state if elected to power.

On how many seats the MVA was likely to get, Chavan said he cannot predict numbers but was confident that the MVA would get a majority.

On Prime Minister Narendra Modi's 'ek rahenge to safe rahenge (united we remain safe)' remarks, Chavan said the BJP was making such statements as it was "desperate" and "panicky"

"Ajit Pawar has attacked the PM's statement that this will not work in Maharashtra. They are panicky. Why is he trying to communalise the election and not sticking to development (conversation). He has failed in develop-

ment that is why he is doing that," the Congress leader claimed. "Ajit Pawar who is an alliance partner (in Mahayuti) has castigated the PM...He has said 'please don't use such language' in Maharashtra and 'Modi need not come and campaign'. Alliance is already shattered. He (Ajit Pawar) has said Yogi's language is not acceptable here," Chavan said.

He further said the key issues in the Maharashtra polls were unemplovment. inflation, farmers woes, attack on Constitution and corrup-

date Sanjana Jadhav, the daughter Chavan is eyeing a third term in the Maharashtra Assembly from minister Raosaheb Danve. South Karad. He has also been a member of the Lok Sabha, Rajya Sabha and the legislative council. The ruling Mahayuti alliance comprises Eknath Shinde's Shiv Sena, the BJP and Ajit Pawar-led NCP. The opposition Maha Vikas Aghadi (MVA) consists of the Congress, the Shiv Sena (UBT) and the Sharad Pawar-led NCP (SP).

Polling for the 288-member Maharashtra Assembly will be held on November 20. The votes will be counted on November 23, a day before the current Maharashtra Assembly completes its term. (PTI)

ST panel urges Centre, states to take policy action for LWE-displaced Gottikoya tribals

NEW DELHI, Nov 10: The National Commission for Scheduled Tribes has asked the Union Home Ministry and Chhattisgarh, Maharashtra, Andhra Pradesh, and Odisha to submit a detailed report on the status of the Gottikoya tribals, who were displaced from Chhattisgarh due to Maoist violence and are now reportedly living in neighbouring states in difficult conditions, excluded from social security benefits.

The Commission has requested the presence of the Home Ministry's secretary and the chief secretaries of the states concerned at a meeting scheduled for December 9 to discuss the issue, recommending a prompt policy decision to provide necessary support to the community

In a letter sent to the ministry and the states on Friday, the Commission said it had received a petition in March 2022 stating that members of the Gottikova community, who had relocated from Chhattisgarh to neighbouring states in 2005 to escape "violence between Maoist guerrillas and Indian security forces", have been facing significant challenges in their new locations.

According to tribal rights activists who have repeatedly raised the issue with the Commission and the Union Tribal Affairs Ministry, an estimated 50,000 tribals were displaced from Chhattisgarh due to



Left-Wing Extremism. They now live in 248 settlements in the forests of Odisha, Andhra Pradesh, Telangana, and Maharashtra.

According to some reports, the Telangana government has taken back land from internally displaced persons (IDPs) in at least 75 settlements, jeopardising their liveliand increasing their hoods vulnerability, the Commission said, citing the petition.

Some reports also allege that forest department officials demolished the homes of the IDPs and destroyed their crops.

On November 7, 2022, the Commission issued a notice to the district magistrate of Bhadradri Kothagudem in Telangana, seeking an action taken report or compliance report on the matter. In a report submitted on September 9, 2023, the district magistrate

denied the allegations against forest officials, arguing that the Gottikoyas were encroaching on forest land, impacting forest resources and causing "irreparable damage to the environment and ecological balance, which could lead to natural calamities"

The magistrate added that since all the Gottikoyas had migrated from Chhattisgarh, they do not qualify as Scheduled Tribes in Telangana and are, therefore, ineligible for forest rights in the state.

The Commission held a meeting with the district magistrate of Bhadradri Kothagudem on September 24 to discuss the matter in detail. It recommended that the Union

Home Affairs Ministry's secretary and the chief secretaries of Chhattisgarh, Maharashtra, Andhra Pradesh, and Odisha be requested

to attend a session before the Commission on December 9 and provide a comprehensive action taken report on the issue

The Director of the Centre for Economic and Social Studies in Telangana, along with representatives from the Forest Department, has also been asked to present a report on surveys conducted in Gottikoya settlements in the state.

In July, the government informed Parliament that tribal families displaced from Chhattisgarh due to Left-Wing Extremism were unwilling to return to the state despite the availability of rehabilitation schemes and security measures in place through security camps.

Responding to a question by Congress MP Phulo Devi Netam, Union Minister of State for Tribal Affairs Durgadas Uikey told the Rajya Sabha that the state government had organised teams to conduct surveys in the adjoining districts of Telangana and Andhra Pradesh to identify tribal families displaced from Chhattisgarh due to Left-Wing Extremism.

He said that a total of 10,489 tribal individuals from 2,389 families were displaced from the districts of Sukma, Bijapur, and Dantewada due to Left-Wing Extremism. A total of 9,702 tribal people were displaced from Sukma, 579 from Bijapur and 208 from Dantewada, Uikey added. (PTI)



LUCKNOW, Nov 10: After the Supreme Court declared higher education degrees awarded by the Uttar Pradesh Madrasa Board unconstitutional, there is a demand to accommodate the about 25,000 students who are currently pursing these courses in any other recognised university.

The state government has also said it will find a way out after considering all the legal aspects of this mat-

In an order on November 5, the Supreme Court declared the Kamil and Fazil degrees -- equivalent to graduation and post-graduation degrees -- awarded by the Uttar Pradesh Madrasa Board Board unconstitutional, saying it was in conflict with the University Grants Commission (UGC) Act.

Zaman Khan, the General Secretary of the Teachers Association Madaris Arabia Uttar Pradesh, said the court's decision has created a difficult situation for the thousands of current students as the board will not be able to conduct exams for these courses now.

"The order of the Supreme Court is supreme. But the government must find some way to deal with the situation that has arisen so that the future of the students studying in the Kamil and Fazil courses of the Madrasa Board does not remain dark," he told PTI said on Sunday

Minority Welfare Minister Om Prakash Rajbhar said the government will definitely find a way out by studying the SC order and discussing its various legal aspects

On the question of whether the students studying in the Madrasa Board's Kamil and Fazil courses will be

linked to any other university, the minister said, "All aspects will be considered and only after that the government will take any decision.

Madrasa Board Registrar R P Singh said about 25,000 students are studying in the Kamil and Fazil courses run by the board currently, and whatever decision the government takes will be followed.

Meanwhile, former Madrasa Board member Oamar Ali said that the Board's Kamil degree had the status of graduation and Fazil degree had the status of postgraduation, but even earlier they were not recognised for appearing in competitive examinations.

These degree-holders would get jobs only in madrasas which has also ended after the Supreme Court order, he said, demanding the current students be given a chance in recognised universities.

The Madrasa Board had earlier given a proposal to the government to accommodate the students of its Kamil and Fazil courses in the Lucknow-based Khwaja Moinuddin Chishti Urdu-Arabic-Persian University' but no decision was taken on it, he said. It is not clear from the order that from when these degrees will be considered unconstitutional, but the government should take steps to affiliate these students with a UGC-recognised university, he said.

There are about 25,000 madrassas in Uttar Pradesh 16,500 recognised by the State Madrasa Board and 8,500 unrecognized. A total of 560 of them receive grants from the state government.

In its order on October 5, the SC upheld the constitutional validity of the Uttar Pradesh Madrasa Education Board Act, 2004, overturning an Allahabad High Court order of March 2024 which declared it unconstitutional

However, the SC declared the provisions pertaining to higher education (Kamil and Fazil degrees) were unconstitutional (meaning the Madrasa Board cannot offer these degrees) as they are in conflict with University Grant Commission (UGC) Act.

"The UGC Act governs the standards for higher education and a state legislation cannot seek to regulate higher education, in contravention of the provisions of the UGC Act," it said. (PTI)

Gunfire rattles Zabarwan forests, shattering peace and creating panic

SRINAGAR, Nov 10: In the first such incident in the past two decades, terrorists exchanged fire with security forces in the dense forests of the Zabarwan range here on Sunday, forcing residents to flee in panic as additional forces were mobilised to strengthen the cordon.

The encounter in the vicinity of Nishat on the banks of the Dal Lake comes close on the heels of a day-long encounter in the Khanyar locality of downtown Srinagar early this month which left a top Pakistani commander of the Lashkar-e-Taiba (LeT) dead.

The encounter in Zabarwan lasted several hours before the guns fell silent but the terrorists managed to flee taking advantage of the thick foliage. However, the search for the fleeing terrorists was continuing when the last reports were received, the officials said.

Eyewitnesses told PTI that the forest area resonated with gunshots shortly after a contingent of Army, police and CRPF personnel appeared there and launched a search operation around 9 am.

The forested area has a cluster of over a dozen houses and many residents fled the locality due to panic. This forest area serves the locals in grazing their cattle and also womenfolk bring firewood from the woods to save themselves from the bone-chilling winter of Kashmir.

"I heard a few gunshots in the morning but I did not know it was happening in the neighbourhood. I have been living here for the past two decades and never witnessed such an incident," Abdul Khaliq, a local resident, said.

"I, along with my wife, immediately left our house and ran for safety. There are at least two dozen houses in this forest

quent visitor to the forest area for quite a long time. This morning, he left his cattle in the forest area and was returning when the encounter started.

"Today, I also took my cow and a few sheep into the woods. While I was coming down, I heard some gunshots. My cattle are still there and I am here waiting at the road for them. This is an unusual sight for us because this is a quiet place otherwise," a visibly disturbed Rashid told PTI.

Soon after the exchange of fire began, additional reinforcements from the Special Operations Group (SOG) of police and the CRPF rushed to the area and placed it under a tight cor-

don The security forces also restricted the movement of civilians in an attempt to prevent any loss of lives. Even media persons, who reached the spot to report the encounter, were kept at a safe distance.

"I, along with other women, went early in the morning in the forest to collect firewood but we did not see anything. Later on, when we reached home, we heard gunshots. I am still wondering what exactly happened. Our relatives are call- range. The forest authorities rescued ing us as it is everywhere on social media," a woman, who insisted not to be named, said.

Earlier, police in a post on X said, "A joint police and secuity forces operation was launched in Zabarwan forest area of Srinagar based on specific intelligence about the presence of terrorists. An exchange of fire ensued during the operation."

NEW DELHI, Nov 10: A fact-finding panel has informed the National Green Tribunal (NGT) that over 17,600 trees have been felled in three Uttar Pradesh districts to make way for the upcoming Kanwar Yatra route.

The tribunal was hearing a case related to the alleged felling of more than 1 lakh trees and shrubs in the protected forest area across the three forest divisions of Ghaziabad. Meerut and Muzaffarnagar for the proposed route between Muradnagar in Ghaziabad and Purkaji in Muzaffarnagar.

In an order dated November 6, a bench of NGT Chairperson Justice Prakash Shrivastava noted that a joint committee formed earlier to ascertain facts had submitted its interim report.

The committee comprised the Forest Survey of India director, a senior scientist from the Union Ministry of Environment Forest and Climate Change, the state's chief secretary or his representative and the Meerut district magistrate. 'The interim report states that as per the information furnished by the irrigation department, 17,607 trees have been cut in all three districts till August 9, 2024," said the bench, also comprising judicial member Justice Arun Kumar Tyagi and expert member A Senthil Vel.

The tribunal noted that while permission was granted to fell 1,12,722 trees, it l ad later been de

It said, "The state of UP is directed to clarify if the number of trees to be cut has been calculated strictly in accordance with the provisions of the UP Protection of Trees Act.'

The tribunal directed the additional chief secretary of the state's environment department to file an affidavit within two weeks, stating the number of trees that will be cut in the course of the construction of the route.

"It will also be clearly stated if trees have been cut beyond the width of 15 to 20 metres and, if yes, the person responsible for it," it added.

"Considering the fact that the seriousness of the issue relating to a public project, the joint committee is expected to complete the exercise as directed, expeditiously and submit the final report without any delay," the tribunal added.

The tribunal also noted the Surveyor General's earlier statement on October 16 about conducting a drone survey to identify the extent of trees cut on both sides of the canals. It, however, said, "From the report submitted by the Survey of India that information cannot be gathered.'

"Hence, we direct the Surveyor General, Survey of India, to trace out the satellite imagery of the stretches under consideration for the year 2024 (till October 2024) and file a fresh report showing the comparative position of trees which were existing in 2023 and trees fell till Octobe 2024 in the stretches under consideration." (PTI)

HASSAN (KARNATAKA), Nov 10: A row over students from Jammu and Kashmir studying in a government nursing college in Karnataka having long beard has been sorted out amicably, an official of the institute said on Sunday.

The issue came to light when the Jammu and Kashmir Students Association wrote to Karnataka Chief Minister Siddaramaiah on the "significant challenges" faced by the students at the college at Holenarasipura in Hassan district.

The issue was amicably solved after the students agreed to comply with the directions of the college management, said Hassan Institute of Medical Sciences director Dr Raianna.

There are about 40 Kashmiri students in the college who alleged that they were facing



"significant challenges". They communicated their concerns to the Srinagar-based Jammu and Kashmir Students Association.

"It has come to our notice that over two dozen Kashmiri students at the college are facing significant challenges due to restrictive policies concerning their personal appearance," the association said.

The college administration has reportedly been compelling the Kashmiri students to ei-

ther trim their beards to a '01' trimmer length or be clean-shaven before they could be allowed to participate in college activities or enter the premises, particularly for clinical duties, the association wrote to the CM.

Students who have beards are being marked absent during clinical duties, impacting their academic records and attendance, it alleged.

"The right to personal appearance, including the choice to grow a beard, is fundamental aspect of an individual's freedom and identity," the association said.

"No student should be subjected to such discrimination or forced to compromise their beliefs and practices to access education. Such actions not only infringe upon the rights of these students but also create an atmosphere of fear and exclusion, which is detri-

mental to the spirit of education and democracy," it added.

However, Dr Rajanna rejected the association's charges.

"These students have mistaken the instruction given about the untidy dress and keeping a long beard. During the clinical process they were instructed to keep their dress neat and trim their beards," he told PTI.

Rajanna said that when he came to know about the issue, he had discussed with the students, who later agreed to come with a neat dress, to be punctual and to keep the beard trimmed.

"The issue is now resolved. Right now there are 40 students. The students are happy in their hostels. The faculties and principal have visited their rooms and counseled the students," he explained. (PTI)

Punjab Police arrests two shooters of Arsh Inspired by Kashmir, man grows saffron in his Indore house Dalla gang for Sikh activist's murder

CHANDIGARH, Nov 10: Two shooters of Canadabased gangster-turned terrorist Arsh Dalla's gang, who were allegedly involved in a Sikh activist's murder last month, have been arrested from Kharar in Mohali, a top Punjab Police officer said on Sunday.

The accused were also allegedly involved in the recent murder of another person in Madhya Pradesh's Gwalior. The duo were planning to target more individuals, another senior officer said, adding that at least four target killings of prominent persons in major cities have been averted with their arrest.

Director General of Police Gaurav Yadav said the arrests in the murder case of Sikh activist Gurpreet Singh Hari Nau alias Bhodi were made in a joint operation of the state special operation cell, the Anti-gangster Task Force and Faridkot Police.

Pragya Jain, Senior Superintendent of Police (SSP), Faridkot, identified the arrested persons as Anmolpreet Singh alias Vishal, a resident of Bhadorh in Barnala, and Navjot Singh alias Neetu, a resident of Nijjar road in Kharar.

The police also arrested their accomplice Balvir Singh alias Kalu, brother of Navjot, for aiding and abetting the criminals. All the arrested persons have criminal history, Jain said.

The police said they recovered two sophisticated pistols along with seven live cartridges from the accused.

Gurpreet Singh Hari Nau was shot dead in Faridkot on October 9 while returning home from the village gurdwara on his motorcycle.

The police had then claimed that gangster-turned-ter-

rorist Arshdeep Singh alia Arsh Dalla was the mastermind behind the murder. They had also alleged that the activist was killed at the behest of Amritpal Singh, who is lodged in Dibrugarh jail in Assam under the stringent National Security Act.

SSP Jain on Sunday said preliminary investigations revealed that Arsh Dalla tasked Navjot to target the Sikh activist, who runs a YouTube channel under the name of "Hari Nau Talks"

Arsh Dalla also asked him to rope in more associates to execute the task, she said, after which Navjot took the help of Anmolpreet, she said.

Jain said Arsh Dalla arranged a pistol along with ammunition and a motorcycle for the duo, who on October 9 went to Hari Nau village and shot dead the activist.

The senior officer said investigation revealed that both the shooters were provided hideouts by Arsh Dalla. After the crime, the shooters were constantly on the move and changed several hideouts in various cities, including Amritsar, SBS Nagar, Himachal-Punjab Border, Chandigarh, Mohali and Kharar.

Jain said the probe also found that the accused also killed Jaswant Singh Gill on Thursday in Gwalior on directions from Arsh Dalla. Both suspects then returned to Punjab after committing the crime, where they were apprehended near Kharar.

In addition to this, these accused were involved in a firing and extortion incident at Zirakpur on October 18, where a businessman was threatened after firing and a poster came up at his building's main entrance with Arsh Dalla's name on it. (PTI)

INDORE, Nov 10: A farmer in Indore in Madhya Pradesh has pulled off a remarkable agricultural feat by growing saffron, among the costliest spices in the world and traditionally associated with picturesque Kashmir Valley, in his room

Anil Jaiswal, who grew saffron in the second-floor room of his house through the 'aeroponics' method, or one in which soil is not used, told PTI he planned to sell it at ₹ 5 lakh per kilogram in the domestic market, while prices could up to ₹ 8.50 lakh per kg internationally

"I had gone to Kashmir with my family a few years ago and felt inspired after seeing saffron fields in Pampore. I then came back, created a controlled environment of temperature, humidity, light and carbon dioxide and deployed advanced aeroponics technology equipment to grow saffron in a room," he said.



TIM THE The idea was to replicate the climate of Kashmir, said Jaiswal, whose second-floor room is now the cynosure of all eyes because of the beautiful purple saffron flowers. These plants have been kept in plastic travs in vertical racks.

"It cost me ₹ 6.50 lakh to create the infrastructure for saffron cultivation in a 320 square feet room. I ordered one tonne of saffron bulbs from Pampore in Kashmir. I expect to get 1.5-2 kilograms of saffron

from its flowers this season. The saffron bulbs were kept in the first week of September and flowers started blooming by October-end," he informed.

The saffron grown in his room is completely organic, he said, adding his family was lending a helping hand.

Informing that Gayatri Mantra and soothing music is being played in the room, which also witnesses the chirping of birds, Jaiswal's wife Kalpana said the philosophy behind the effort was that trees and plants too have life.

"We play music so that the plants feel closer to nature even when they are being grown in a room," she said.

Aeroponics expert Praveen Sharma said such efforts have been underway in different parts of the country but profitability and sustainability will come when cost of cultivation is kept low.

"Farming using the aeroponics method requires a lot of electricity. Therefore, people growing saffron using this method should use solar energy as much as possible to reduce electricity bills," Sharma said. Often called "red gold" because of its high prices, saffron is used in food as well as in cosmetics and medicines.

While the demand in India is huge, low production means a lot of saffron is imported from Iran and some other nations. (PTI)

LOS ANGELES, Nov 10: Hollywood star Zendaya and Oscar winner Anne Hathaway are the latest additions to the cast of Christopher Nolan's upcoming feature film. The untitled project marks Nolan's next offering following the success of the multiple award-winning "Oppenheimer", which also earned him his first Best Director Academy Award.

According to The Hollywood Reporter, plot details are being kept under wraps, but sources say the setting is not contemporary. It is also unclear whether the currently untitled movie is set in the past or future. In the movie, Zendaya will join Tom Holland, her partner and co-star from three "Spider-Man" movies, as well as Matt Damon. who appeared in Nolan's 2014 film "Interstellar" and "Oppenheimer" (2023). Hathaway will reunite with Nolan after working with the filmmaker on "The Dark Knight Rises" (2012) and "Interstellar". Nolan wrote the script and is directing the film, which will be distributed by Universal Pictures.

The filmmaker is also backing the project alongside producing partner and wife, Emma Thomas, for their Syncopy banner. Universal Pictures has set a release date of July 17, 2026, for the movie. (PTI)

CHENNAI, Nov 10: Noted Tamil actor 'Delhi' Ganesh, who essayed a spectacular variety of memorable roles in over 400 films, passed away late Saturday night at his residence here following a brief illness, his family said.

He was 80 years old. The actor's son, Maha Delhi Ganesh, told reporters that his father had age-related ailments and that he was under treatment. "Last night when we tried to give him a tablet, he did not respond. A doctor confirmed that he was dead," he said. Another family member said Ganesh died in his sleep at his Ramapuram residence. In a statement, the family said Delhi Ganesh passed away at 11 pm on November 9. Film celebrities condoled his death. A native of Tirunelveli. Ganesh's acting career began in the 1960's when he performed small roles in dramas in Delhi, where he served the IAF for a decade in a civilian post.

Later, when he shifted to Chennai after resigning his IAF job, he joined actor 'Kathadi' Ramamoorthy's troupe and acted in dramas including 'Dowry Kalyanam.' When legendary director K Balachander made a film (1977) based on the play 'Pattinaprevasam,' Ganesh got his first opportunity in the

tinsel world and he reprised his role in the movie.

There was no looking back since then and his filmography is impressive with main roles in films of top stars including Rajinikanth, Kamal Haasan and Vijayakanth. Ganesh's role as a loyal staff of gangster Velu Naicker, a character made immortal by Haasan's brilliant performance in the Mani Ratnam-directed Nayakan (1987), lent weight to the caring persona of the protagonist. Vidya Balan on how 'Bhool Bhulaiyaa' paved way for unconventional roles: 'Ishqiya' came after that

MUMBAI, Nov 10: Actor Vidya Balan, who returned to the "Bhool Bhulaiyaa" franchise with the recently released third part, says the success of the first film helped change the perception of her, as filmmakers realised that she could handle more complex and unconventional roles.

Balan, who starred as Avni/Manjulika opposite Akshay Kumar in Priyadarshan's 2007 hit "Bhool Bhulaiyaa", said the movie opened up new opportunities for her. People realised that there was another facet (to me). I don't know if it was prompted by that, but "Ishqiya" came to me after that. When people see you do different things, their minds open up with possibilities.

"It was a huge commercial success, so I'm sure it must have impacted people's decisions.ö Balan told PTI in an interview.

The actor said her father still has a complaint -- that Balan didn't win any awards for her performance in the movie.

"I was like, LIt's okay.' But four years in a row after that, I picked up the Best Actress awards in most places. So, things always balance out," Balan said, referring to her wins for "Paa" (2010), "Ishqiya" (2011), "The Dirty Picture" (2012), and 'Kahaani" (2013)

Despite the popularity of the first part, Balan and Kumar did not appear in the sequel, "Bhool Bhulaiyaa 2", which was released in 2022. Directed by Anees Bazmee, the movie featured an almost entirely new cast, with Rajpal Yadav being the exception, and became a major box office hit upon its release.

Balan made a comeback to the franchise with "Bhool Bhulaiyaa 3", which debuted in theatres on November 1 and has minted over Rs 160 crores at the domestic box office. "Both Priyan and Anees bhai are directors who trust their actors... When I read it, I thought it was so fun. With Anees bhai as director, I knew it could only get better," she said.

Having worked with the two filmmakers, the actor said both of them are "similar in a lot of ways yet they are different."

"Both of them do comedy very well. I think Anees bhai is the kind of director

AIFF's chief refereeing officer Kettle claims standard of referees in India improving NEW DELHI, Nov 10: Poor 2023-24 season ISL and I-"The standards of referees in respect and clarification of

refereeing in the Indian Super League (ISL) has long been a source of frustration for many coaches, but the national federation's top officer Trevor Kettle on Sunday claimed that the standard of referees in the country is "improving in many competencies". Several coaches of ISL clubs,

mostly foreign, have in the past talked about the poor standard of refereeing in the top-tier league and even the All India Football Federation's (AIFF) President Kalyan Chaubey had expressed concerns on the matter a few months back.

The most recent incident involved two controversial referee decisions during the Kerala Blasters vs Hyderabad FC match in Kochi a few days ago.

But Kettle, the AIFF's Chief Refereeing Officer (CRO), highlighted the improvements made by the Indian referees when asked about his views in the context of several past and present foreign coaches expressing disappointment on the refereeing standard at the ISL.

India are improving in many competencies, including growing confidence to take stronger disciplinary action, improved fitness standards to maintain pace with the game, less prone to being deceived by players simulating or exaggerating, and allowing more game flow," Kettle told PTI.

"The accuracy of Key Match Incident (KMI) decisions is now being accurately monitored as the prime indicator of refereeing performance with a reach target of 85%. Interestingly, the results of the pre-season Head Coach survey on referees, on average, expected an accuracy of 82.5% without the aid of VAR technology. "At present, the KMI % accuracy fluctuates around this level but would improve to approximately 97% with VAR (Video Assistant Referee) implementation." There is no VAR in the ISL and the AIFF is hoping to start the technology from next season onwards.

Asked about the apparent refereeing blunder in the Kerala Blasters vs Hyderabad FC match,



he said, "Each match official's

performance, along with the referee assessors' independent report, is monitored with new processes introduced over the past two years. The accuracy of every KMI in each ISL game is checked by a panel of current AFC Referee Assessors and ex-FIFA referees.

"The outcome of these KMI reviews drives the technical training requirement for the elite match officials to further educate with the ultimate aim of continu-

ous improvement.

"Referees are not infallible, like players, and will make errors of judgment and at times this unfortunately impacts the result of a game. Referees are held accountable for continued inaccurate KMI decision-making and will not be prioritized for future appointments.

On December 31, 2023, Chaubey, in an unprecedented move, had come down heavily on the referee department for the mounting refereeing errors in the League, saving there was an "urgent need for accountability"

"A number of video clips were shown which highlighted incidents of perceived errors forwarded by various stakeholders. It was accepted that some of these decisions were incorrect but others were indeed correct," Kettle said when asked about the then meeting of Chaubey with several stakeholders.

"I have created an open dialogue with clubs who now have a direct point of contact in me as CRO at AIFF to express their concerns on refereeing matters."

On the issues he has flagged to the AIFF in this regard, he said. "I have often requested assistance . to explain refereeing decisions to the wider stakeholders for greater transparency and understanding of the LOTG (Laws of the Game) whilst also displaying empathy with the human error of referees.

"A head coaches meeting for both ISL and I-League is highly recommended every pre-season to improve relationships, mutual

LOTG interpretation.'

He said long-term continued investment in Elite Referee Development Plan, providing necessary technical support to referees and allowing match officials to take on full-time professional contracts is absolutely imperative if refereeing standards are to improve

"We must understand that refereeing is not yet a highly-paid job in India. In most cases, referees take it up as a part-time profession. However, the AIFF is continuously pursuing the policy of having full-time referees.

"At the moment, there are eight referees and seven assistant referees, who are on a full-time contract with the AIFF. Their contracts have once again been renewed early this month.

"At the same time, we are thankful to the AIFF for working continuously for the referees' development. The Centre of Referees Excellence (CORE) has

already been set up in two cities -- Gwalior (MP) and Thiruvananthapuram (Kerala)." (PTI)

India look to defend title on home soil in women's ACT hockey

RAJGIR (BIHAR), Nov 10: Having struggled to win matches the entire year, the Indian women's hockey team will look to start afresh in a new Olympic cycle by defending its Asian Champions Trophy (ACT) title at home, beginning with a clash against lowerranked Malaysia here on Monday. India have won the title twice in

2016 (Singapore) and 2023 (Ranchi) in the seven editions of the tournament so far. After failing to qualify for the

Paris Olympics, the Indian team lost 13 matches and won just two (with one draw) out of 16 in the women's FIH Pro League this year, but will hope to make a turnaround in their fortune with a strong performance in the ACT.

India have fielded a mixed team, consisting of youth and experienced players for the tournament under the leadership of Salima Tete. Striker Navneet Kaur will serve as Salima's deputy as India enter the competition with high expectations.

The team will face stiff competition from five other nations, including reigning Olympic silver-medallists China, Japan, Korea, Malaysia and Thailand, in the battle for continental supremacy. The Indian defence will be anchored by a solid line-up, featuring Udita, Jyoti, Ishika Chaudhary, Sushila Chanu Pukhrambam and Vaishnavi Vitthal Phalke.

In the mid-field, captain Tete will be supported by Neha, Sharmila Devi, Manisha Chauhan, Sunelita Toppo, and Lalremsiami, all known for their dynamic play.

The forward line-up has the likes of Navneet Kaur, Sangita Kumari, Deepika, Preeti Dubey and Beauty Dungdung leading the charge.

The goalkeeping duties will be shared between the experienced Savita -- also former captain -- and rising talent Bichu Devi Kharibam. Sushila and Beauty Dungdung



will be making a return to the team after successfully completing their rehabilitation.

The 39-year-old from the Isle of Man broke famed Belgian cyclist Eddy Merckx's long-standing record for most career Tour de France stage wins with his 35th victory in July.

Fittingly, for his final race Cavendish wore No. 35 on his race jersev and won in a dash to the line for the 165th victory overall in his career. "I'm quite emotional actually," Cavendish said. "I realised in the last

5 laps that it was the last 15 kilometers (9 miles) of my career.'

He finished just ahead of Belgian riders Jasper Philipsen and Arnaud De Lie. "What an incredible day to share my last race with those riders," Cavendish said. "With the future of sprinting, with this next generation of sprinters.'

Nicknamed the "Manx Missile," Cavendish had planned to retire after the 2023 season but changed course and returned with the goal of passing Merckx's Tour stage-win record. (AP)
