NEW DELHI, Nov 13: Prime Minister Narendra Modi will visit Bihar's Jamui on Friday to commemorate Janjatiya Gaurav Divas, marking the commencement of the 150th birth anniversary celebration of tribal icon Birsa Munda.

During his visit, Modi will also inaugurate and lay the foundation stone of multiple development projects worth over ₹ 6,640 crore, aimed at uplifting tribal communities and improving infrastructure in rural and remote areas of the region, the Prime Minister's Office (PMO) said in a statement.

Modi will visit Jamui to commemorate Janjatiya Gaurav Divas and this marks the commencement of the 150th birth anniversary celebration of 'Dharti Aaba Bhagwan Birsa Munda', the statement said. At 11 am, Modi will unveil a commemorative coin and postal stamp in honour of Bhagwan Birsa Munda.

**DIPHU**, Nov 13: A three-day skill development training programme on Eri spinning and Eri yarn knitting, organised by the Assistant Director of Sericulture, Karbi Anglong, is underway at Reshom Bhavan's conference hall.

The training began on November 12 and will conclude on November 14.

This programme aims to equip local women with skills in producing Eri yarns using spinning machines, including the cocoon-baking processes required for spinning yarns.

According to Longki Timung, the in-charge Assistant Director of Sericulture, 40 women trainees are participating in the programme.

Inaugurating the event, the executive member (EM) of the Karbi Anglong Autonomous Council (KAAC), Lunsing Teron, who oversees Sericulture and Irrigation, stated that the programme's main purpose is to train participants in advanced Eri spinning techniques to boost productivity and quality in the sector. The EM informed the trainees

that they would receive certificates upon completing the training.

The certificate serves as proof of participation in the training. It's also essential when applying for bank loans to support silkworm rearing or to establish Eri spinning centres," Teron explained.

Highlighting the traditional link between the Karbi community and silkworm rearing, the EM said, "Our women have long spun yarns from silkworm cocoons using traditional methods to make garments. However, times have changed, and we must adopt modern methods and embrace a competitive approach." He also mentioned Serdihun, a legendary figure (CONTD. ON PAGE-2)

# Drugs seized in Guwahati, 4 held

GUWAHATI, Nov 13: Drugs worth more than ₹ 3 crore have been recovered from Guwahati and four people, including a woman, have been arrested in this connection, police on Wednesday.

The Guwahati police, in a series of posts on X, said that narcotics substances like heroin and 'Yaba' tablets were recovered from a guest house in the Hatigaon area of the city

"An EGPD team from Dispur PS seized 10,000 'Yaba' tablets, 11 grams of suspected heroin in 5 soap boxes after it carried out a raid." it added.

NEW DELHI, Nov 13: The rule of law is an umbrella concept to protect citizens against the power of the State and it is necessary for democracy and good governance, the Supreme Court said on Wednesday.

Laying down pan-India guidelines on demolition of properties, the apex court said the rule of law ensures that actions of the government and its authorities are governed by established legal principles, rather than arbitrary discretion.

"Ensuring the preservation of the principle of rule of law and the protection of the civil rights and liberties of citizens is essential for protecting constitutional democracy," a bench of Justices B R Gavai and K V Viswanathan said in its 95-page verdict.



It said the law must be just and fair and should protect the human rights and dignity of all members of society.

"At the same time, the essential purpose of the rule of law is to prevent the abuse of power. The rule of law is an umbrella concept to protect citizens against the power of the State. It is integral to and

### necessary for democracy and good

governance," the bench said. The court said it is well settled that the rule of law has been described as a safeguard against the arbitrary use of State power.

"Whenever the citizens, in the form of mobs, have broken the law to vandalise or to declare threats, the court has cast an obligation on the State to prevent such threats or assaults," it said.

The bench said this obligation underscores the State's responsibility to maintain law and order and protect citizens from unlawful actions that undermine the rule of law itself.

"It is not necessary to state that the failure to uphold these obligations can erode public confidence in the justice system, leading to an environment (CONTD. ON PAGE-2)

# **New Collective Quantified Goal** *Trillions of dollars needed to fight climate* change: High ambition coalition

NEW DELHI, Nov 13: Some developed countries on Wednesday acknowledged that trillions of dollars were urgently needed to address climate change and wealthy nations should continue to lead in providing climate finance.

These countries -- including Germany, Canada, France, and the Netherlands -- are part of an alliance known as the High Ambition Coalition, which advocates for bold climate actions.

"As we negotiate this new goal for climate finance, we must again overcome our differences, strengthen our commitment to global solidarity, and find the money to meet the planet's growing needs," the coalition said stressing that trillions of dollars were urgently needed.



The statement comes as countries spar over a draft for a new finance package to help developing countries cope with climate change -- or New Collective Quantified Goal (NCQG) -- that is expected to

be finalised at the ongoing UN climate talks in Baku, Azerbaijan.

Harjeet Singh, a climate activist and global engagement director for the Fossil Fuel Non-Proliferation Treaty Initiative, said that while the

statement aligned with developing nations and civil society's demands, it fell short of what was truly needed.

The coalition demanded solutions to debt burdens and high capital costs that make fighting climate change difficult in many countries and called for a reformed international financial system to support their efforts.

It said climate finance should be primarily grant-based and concessional, particularly for adaptation and to address loss and damage The right conditions must be in place for green investments to thrive.

"Developed countries must continue to take the lead and live up to existing finance commitments and innovative (CONTD. ON PAGE-2)

### New rules ban false claims in coaching ads


# Centre issues guidelines to crack down on misleading ads by coaching centres

NEW DELHI, Nov 13: The Centre on Wednesday released new guidelines to regulate misleading advertisements by coaching institutes, prohibiting false claims like 100 per cent selection or 100 per cent job security.

The final guidelines, drafted by the Central Consumer Protection Authority (CCPA), come in the wake of several complaints on the National Consumer Helpline. The CCPA has issued 54 notices and imposed penalties of about ₹ 54.60 lakh till date.

"We have seen coaching centres deliberately concealing information from prospective students. Therefore, we have come out with the guidelines to provide guidance to people involved in the coaching industry," Consumer Affairs Secretary Nidhi Khare told reporters.

The government is not against the coaching centres but the quality of advertisements should not undermine the consumer rights, she said.



grammes and tuition, but exclude Under the new guidelines, coaching centres are prohibited from counselling, sports and creative making false claims regarding activities. courses offered and duration; faculty credentials; fee structure and names, photographs or testimonials of successful candidates without refund policies: selection rates and exam rankings; and guaranteed job written consent obtained after selecsecurity or salary increases.

The guidelines define 'coaching' to include academic support, education, guidance, study prolims and mains on their own and take only interview guidance from coaching centres," Khare said, advising prospective students to verify what courses successful candidates were actually enrolled in.

The guidelines, titled 'Prevention of Misleading Advertisement in Coaching Sector', cover all forms of advertising across academic support, education, guidance and tuition services. However, they exclude counselling, sports and creative activities.

Khare, who is also CCPA chief, said coaching centres should accurately represent the service, facilities, resources and infrastructure. They should truthfully represent that the courses offered are duly recognised and have the approval of a competent authority such as AICTE, UCG, etc.

BJP's former cabinet minister Parimal Suklabaidya successfully contested in the Silchar Lok Sabha seat and his earlier assembly seat Dholai got vacant. Meanwhile another senior BJP leader Raniit Dutta was elected to the lower house of the parliament this time. He was representing the Behali seat in the assembly.

Meanwhile, another ally of the BJP-Asom Gana Parishad (AGP) will contest polls in the Bongaigaon assembly constituency. United People's Party Liberal (UPPL) gave a ticket to Nirmal Kumar Brahma, who is the current district president of the party in Chirang. Karbi Anglong hosts Eri

# Sensex slumps 984 pts to close at more than 4-month lows; banking, auto shares major drag



MUMBAI, Nov 13: Benchmark Sensex plunged 984 points to close at a more than four-month low on Wednesday following heavy selling in banking, auto and capital goods shares amid retail inflation soaring to a 14-month high in October and unabated foreign fund outflows.

The BSE Sensex slid to 77,690.95, down by 984.23 points or 1.25 per cent, marking its second straight day of losses. During the day, it slumped 1,141.88 points or 1.45 per cent to 77,533.30. Registering its fifth day of decline, the NSE Nifty tumbled 324.40 points or 1.36 per cent to 23,559.05, a level not seen since June 24, 2024.

From the 30-share Sensex pack, Mahindra & Mahindra, Tata Steel, Adani Ports, JSW Steel, IndusInd Bank, Reliance Industries, HDFC Bank and Kotak Mahindra Bank were the biggest laggards.

Tata Motors, NTPC, Hindustan Unilever, Asian Paints and Infosys were the gainers.

"Relentless selling by FIIs amid weak corporate earnings and a sharp surge in domestic inflation to a 14-month high have further impacted investor sentiment, dashing hopes for a near-term rate cut by the RBI," Vinod Nair, Head of Research, Geojit Financial Services, said.

Nair added that markets are jittery about

The latest data showed retail inflation breached the Reserve Bank's upper tolerance level, soaring to a 14-month high of 6.21 per cent in October, mainly on account of rising food prices.

Foreign Institutional Investors (FIIs) offloaded equities worth ₹ 3,024.31 crore on Tuesday, according to exchange data.

Mid and small-cap stocks were the worst hit, while the financials and auto sectors also showed significant weakness. The BSE smallcap gauge tanked 3.08 per cent and midcap slumped 2.56 per cent.

All sectoral indices ended lower. Realty tumbled the most by 3.23 per cent, followed by industrials (2.95 per cent), capital goods (2.72 per cent), services (2.54 per cent), metal (2.54 per cent) and commodities (2.45 per cent).

A total of 3,299 stocks declined while 670 advanced and 98 remained unchanged on the BSE.

"Markets extended their corrective phase, declining by nearly one and a half per cent, continuing the existing downward trend," Ajit Mishra - SVP, Research, Religare Broking Ltd, said

In Asian markets, Seoul, Tokyo and Hong Kong settled lower while Shanghai ended in the positive territory. European markets were trading higher. The US markets ended in the negative territory on Tuesday.

where the rule of law is compromised by lawlessness," it said. The court said the concept of the rule of law s not abstract but is reflected in the substantive content of various legal domains.

It added that the processes enshrined in constitutional law, criminal law and procedure are facets of the rule of law and, thus, serve to regulate the exercise of executive power. Referring to the doctrine of separation of powers, the top court said the executive cannot replace the judiciary in performing its core functions.

It said if the executive acts as a judge and inflicts the penalty of demolition on a citizen on the ground that he is an accused, it violates the principle of "separation of powers"

"We are of the view that in such matters, the public officials, who take the law in their hands, should be made accountable for such high-handed actions." the bench said.

It also referred to the aspect of the rights of an accused under the Constitution.

"While we consider the issue in this case, we will have to reiterate that even the incarcerated individuals, whether accused, undertrial or convicts, have certain rights, as any other citizen," it said.

"They have a right to dignity and cannot be subjected to any cruel or inhuman treatment. The punishment awarded to such persons has to be in accordance with law. Such punishment cannot be inhuman or cruel," the bench said. It added that even an accused or a convict has certain rights and safeguards in the form of constitutional provisions and criminal law. (PTI)

Two trucks carrying goods were, however, set ablaze allegedly by armed militants near Old Kaiphundai in the Naga-dominated Tamenglong district near Jiribam. Suspected hill-based militants stopped the trucks along NH 37 by firing several rounds in the air and then torched the trucks, an official said.

Rongmei Naga Students Organisation, Manipur strongly condemned the incident and alleged Kuki militants were behind it. The trucks were transporting rice, onions and potatoes for Noney and Tamenglong districts, the students' body claimed in a statement. The Manipur Police said 10 suspected militants were killed in a fierce gunfight with security forces on Monday after insurgents in camouflage uniforms, armed with sophisticated weapons, fired indiscriminately at the Borobekra police station and an adjacent CRPF camp at Jakuradhor in Jiribam district. However, a senior government official put the toll at 11. Police said purported photographs of the six missing persons in captivity of militants doing the rounds on social media could not be confirmed and the rescue operations were on to trace them. (PTI)



# Jorhat DC forms task force for fire safety audit

JORHAT, Nov 13: The Jorhat district commissioner, Jay Shivani, has constituted a 15-member inter-departmental task force to conduct a fire safety audit in all commercial establishments, businesses, shops, shopping malls, markets, market complexes, hospitals, nursing homes, cinema halls, multiplexes, godowns, and residential buildings.

The order issued on November 13 appointed Kritartha Neog, branch officer, District Disaster Management Authority, Jorhat, as the chairman of the task force.

The order stated that the task force will submit its findings, with proposals for short- and long-term mitigation and corrective measures to minimise fire hazards in Jorhat town and its peripheral areas, to the DC, who is the chairman of DDMA, Jorhat, by December 20 this year.

The move comes in the wake of a devastating fire near Bhogdoi Masjid on AT Road on the night of November 1, in which one person lost his life and several shops were gutted.

This incident was the fourth major fire in Jorhat town in recent years.

# Partial twist to 'bulldozer justice'

Bench of the Supreme Court of India has bulldozed the 'bulldozer justice' on November 13 last, but partially, since it does make officials accountable for the damage and the cost for restoration would be recovered from their salary, but the power drunk politicians would still remain untamed in absence of any order of making them also accountable on whose orders such 'bulldozer justice' is carried out. Nevertheless, the order and the guideline are welcome, which may rein in 'bulldozer justice' up to a great extent. The order was reserved on October 1, 2024, and the bench had conveyed its intention to lay down a pan India guideline while hearing the petitions filed before the Supreme Court in 2022 which was related to the demolition drive scheduled for April, 2022 in Delhi's Jahangirpuri following a communal violence during the Hanuman Jayanti procession. The drive was ultimately stayed but petitioners prayed for "declaration that authorities cannot resort to bulldozer action as a form of punishment." Jamiat Ulema-i-Hind and various other petitioners had sought directions to stop the trend of "bulldozer justice". The term 'bulldozer justice' first gained prominence in India around 2017, largely associated with the policies of Uttar Pradesh's Chief Minister Yogi Adityanath whose administration employed bulldozers to demolish properties linked to individuals accused of serious crimes or communal violence.

In the last 7 years, the bull dozer has become a symbolic tool for crime control, and to control the offenders, especially on communal basis against Muslims bypassing due process and legal protection available to the citizens under the Constitution of India. The Supreme Court bench of Justices BR Gavai and KV Vishwanathan while pronouncing this judgment said that the executive cannot declare a person guilty, as this process is the fundamental aspect of the judicial review. Only on the basis of the accusations, if the executive demolishes the property/properties of such an accused person without following the due process of law, it would strike at the basic principle of rule of law and is not permissible. The court made it clear that the executive cannot become a judge and decide that a person accused is guilty and, therefore, punish him by demolishing his residential/commercial property/properties. Such an act of the executive would be transgressing its limits.

As per the direction laid by the court, the affected party needs time even after demolition order is passed, first to go for appeal, and secondly, to vacate. As per the guidelines, no demolition should be carried out without prior show-cause notice giving time for 15 days or the period provided in the particular laws. The returnable time will start from the service of the notice. Violation of the directions would lead to the initiation of contempt proceedings in addition to prosecution. In case of violation the officers responsible will be held liable for restitution of the demolished property at their personal cost in addition to payment of damages. 

Tith global temperatures rising steadily, and human populations expanding relentlessly, large swathes of the planet are becoming vulnerable to desertification or the "permanent degradation of land that was once arable". According to National Geographic, over 2 billion people live on drylands prone to desertification, and the progressive degradation of these lands could displace 50 million people by 2030.

The growing pace of degradation has begun to alarm experts. Recent data released by the UN Convention to Combat Desertification (UNCCD) indicates that during the period 2015–19, around 402 million hectares of land were degraded, averaging 100 million hectares a year, and impacting 1.3 billion people. The stakes are high. Unless 1.5 billion hectares of land are restored by 2030 it may not be possible to achieve a land-degradationneutral world, feels the UNCCD.

Artificial Intelligence (AI) is proving to be a valuable ally in the fight against desertification. As we observe World Environ-

ment Day 2024 on the 'Land theme Restoration, Desertification, and Drought Resilience' it is worth taking closer look at the role AI is playing, and the challenges we must address as we develop new AIbased solutions.

#### Some transformative AI solutions

AI is being used in a variety of ways to support efforts to combat desertification. In August 2023, for instance, the arid Kingdom of Saudi Arabia launched a large-scale counterdesertification programme under which AI algorithms are analysing satellite images to monitor changes in land use, vegetation cover, and soil moisture levels. The deployment of AI is helping detect and assess desertification trends in vulnerable areas, and supporting decisions about actions to be taken such as improving water management, planting trees and shrubs, and promoting sustain-

able agriculture.

come to be called "aerial drone seeding"-ensuring optimal planting patterns, and tracking tree growth over time.

Predictive modelling is yet another area where AI has found widespread use. AI models predict future climate patterns and extreme weather events that could contribute to desertification. They also predict which areas are potentially at high risk of degradation by analysing historical data, land use patterns, and environmental factors.

Microsoft's "AI for Earth" initiative, for example, encourages a broad spectrum of AI use cases to accelerate the preservation of the environment, includefforts to fight ing desertification. In southeast Spain, stakeholders are participating in "AI for Earth" by integrating machine learning tools with geospatial data analytics and machine vision techniques to build predictive models of the demand and contributions of water in local agri-

cultural regions. Challenges to AI deployment

While AI holds out much promise for combating desertification,

several factors could hinder its deployment. Desertification ment practices. often affects relativelv remote or underdeveloped regions where data collection practices are rudimen-

tary, and data is sparse or simply does not exist. To some extent, this may be seen as part of the broader data divide between countries of the Global South and those of the North. where some of the former "lack access to even basic digital infrastructure, making it difficult to capture data that might benefit them"

The paucity of data - including, in this case, datasets of aerial images – and the difficulty of crafting AI solutions are also often linked to skill gaps. Quite simply, AI-related technical expertise is likely to be lacking in the regions most severely affected by desertification.

Securing funding and invest-

AI. Climatic instability can alter conditions unpredictably, complicating AI predictions and interventions.

Finally, navigating the regulatory landscape to implement AI technologies can be tough, especially in countries with stringent approaches to AI governance. The management and governance of environmental data present their own challenges. As studies of environmental data value chains in Europe and Central Asia have shown, shared environmental information systems expand access to relevant data, but data harmonization-in terms of collection methods, the nature and categories of data, and the legislation that allows data sharing-continue to be a persistent problem.

Towards a green and reilient planet

The fight against desertification is at a critical juncture and 2030 could signal a tipping point, but the potential of AI offers hope. AI is shaping our ability to understand, predict, and mitigate the impacts of desertification with unprecedented precision and efficiency. Whether in North America or China, Ghana or Israel, AIpowered tools and analysis are helping us monitor land degradation in real time, execute targeted reforestation projects, and craft sustainable land manage-

Despite the challengesfrom data scarcity and insufficient capacities to funding constraints and regulatory hurdles-AI's role in fighting desertification is poised to grow. n the dark undergrowth of mangrove forests, an anthology of color stirs. Flickers of turquoise rise like exhales from the brackish marshlands, and flashes of sunset orange spark alive in the shadows.

The Sundarbans mangrove forest in Bangladesh and India is largely known as one of the last remaining habitats for the Bengal tiger (Panthera tigris tigris), but the coastal groves also thrum with a wealth of smaller animals, including 37 known species of butterfly. The small stature of these butterflies belies their importance; they pollinate flowering plants and nourish the birds that flit through the canopy, ultimately supporting the health of the entire forest ecosystem.

But butterflies in the Sundarbans and throughout South Asia are at increasing risk of extinction, mimicking a global trend that some experts have nicknamed "the insect apocalypse" By some estimates, 250,000-500,000 insect species have gone extinct in the past 150 years, and many more are now on the brink of survival. Climate change and urban development form the largest risks, along with the minimal legal protections and largescale conservation initiatives focused on butterflies and other insects. "If my government is not aware, [butterfly species] will be lost. It will be coming in probably 10 years because climate change is thriving," said Monwar Hossain, a professor and lepidopterist at Jahangirnagar University in Bangladesh.

The unique beauty and vibrancy of Bangladesh's butterflies first attracted Hossain's attention nearly three decades ago. Over his career, Hossain has observed the climate crisis unfold through record-breaking heat waves, severe cyclones and accelerating sea level rise, and his research often focuses on the unique ways these changes impact Bangladesh's 400+ endemic butterfly species.

Insects, including butterflies, are cold-blooded, so they are unable to adjust to changes in temperature as easily as mammals and birds. This puts them at special risk during short-term weather events like heat waves as well as from changes to longterm temperature trends.

Many insects are also unable to migrate long distances to escape changing climate patterns or



Hossain contrasted this deficit with the international attention and surplus of funding dedicated to large mammals, such as tigers.

"Every animal has its own right to survive, so I don't want to compare the butterfly, but in my country's context, millions and millions of dollars [are used] for the tiger," Hossain said. "Sometimes we say to the government, why not include the butterfly?"

A 2021 study determined less than 2% of the ranges of Bangladeshi butterflies were included in protected areas. The study's author, Shawan Chowdhury, was far from surprised by the results. A Bangladeshi native, Chowdhury has witnessed the entomological oversights of conservation and development decisions in South Asia firsthand.

"Nothing is actually happening with insect conservation in Bangladesh," Chowdhury said.

Part of the issue, according to Chowdhury, is a lack of prior research. Animal conservation is typically predicated by years, if not decades, of careful documentation and monitoring. Before politicians write laws to protect animals, scientists are tasked with providing evidence that shows if and what kinds of protections the animals need.

Recent years have seen a few promising additions to South Asia's collection of entomological research. The International Union for Conservation of Nature included butterflies for the first time in its most recent Bangladesh report, thanks in large part to Hossain, who authored the butterfly section of the report. Chowdhury has also contributed several scientific articles, including a four-year

Nitin Ravikanthachari observed a similar problem in his home city of Bengaluru, India. "You can literally count the number of people [in India] studying butterflies on one hand," he said. Ravikanthachari spent much of his adolescence prowling the gardens and parks of Bengaluru, camera in hand, and even after beginning a university degree in biology, he often met up with fellow photographers to walk the city and photograph butterflies. As his interest in lepidoptery grew, Ravikanthachari realised how little scientific attention had been dedicated to the subject, and he decided he wanted "to do something more concrete" to address this gap and call attention to the importance of butterflies. In 2012, Ravikanthachari and

three other amateur lepidopterists founded the Bangalore Butterfly Club (BBC). Rather than relying on large institutions and universities to generate information about their city's butterflies, the BBC started conducting their own research walks to count the number and species of butterflies in the city. Over time, they could use this data to establish trends and gauge the health of butterfly populations.

The initiative was massively successful. To date, the BBC has catalogued more than 170 species of butterflies in Bengaluru, including 14 formerly unknown species. More than 400 members attend research walks, educational events and an annual butterfly festival hosted by the group. Ravikanthachari even rediscovered a species thought to be extinct after a 120-year ab-

sence from scientific records.

He pointed to apps like iNaturalist as a way to not only provide more opportunities for sightings to be recorded and to build a species database, but also to educate the public on the importance of butterflies and other insects. Hossain has also integrated community education and citizen science into his research. His library of scientific studies is supplemented by brochures and children's books, and his lab began hosting an annual butterfly fair with performances, competitions and educational activities in 2010. The Butterfly Park and Research Centre, opened in 2015, not only breeds butterflies for research purposes, but also functions as a public garden on the Jahangirnagar University campus. Through these opportunities to interact with and learn about butterflies, Hossain said he sees more and more young people becoming interested in the environment and conservation. "Once they see the butterfly, the climate change, the forest, they get it," Hossain said.

Ultimately, he hopes the growing community of citizen scientists, environmental advocates and butterfly enthusiasts will translate into more scientific research and legislation about butterflies. The more people who become interested in butterflies, he explained, the more opportunities there are to continue the work he started 28 years ago.

"I'm just a worker. I'm a worker," Hossain said. "I think that life is very short, so every [person] does some significant work in the world, for the nature, for his life or other things."

# Deaths, destruction on the rise due to extreme weather events: Grim statistics in India Climate Report 2024

#### ore than 3,200 people dead. As much as 3.2 Lmillion hectares of crops damaged, around 2.3 lakh houses and buildings destroyed, and more than 9,400 livestock dead: all due to extreme weather events that occurred on 255 of the 274 days of the first nine months of this year across India.

These are some of the alarming statistics published in the latest India Climate Report 2024, launched virtually on November 8 by the Centre for Science and Environment and its fortnightly publication, Down to Earth.

This year, India witnessed the highest number of extreme weather events, when compared to the past two years during which CSE and DTE have been publishing the India Climate Reports, which detail the number of such events based on data including daily reports released by the India Meteorological Department.

For instance, the India Climate Report 2023 reported extreme weather events on 235 of the 273 days in the first nine months of 2023; 2,923 people died that year, and the events damaged croplands spanning 1.84 million hectares. Hence, the frequency and impacts of extreme weather events are increasing with every year, the 2024 India Climate Report monthly climate reports re-

noted. Tracking extreme weather events As greenhouse gases emitted due to the use of fossil fuels

warm up the world, climate is changing in many regions. Many places are far hotter than they used to be; many others witness more heavy rainfall than usual. These climate extremes are often marked by severe impacts on people and the environment, and are called extreme weather events. The United Nations Intergovernmental Panel on Climate Change (IPCC) defines extreme weather events as those that are rare at a particular place and time of year.

India too witnesses its share of extreme weather events. These range from intense rainfall to heatwaves. The India Meteorological Department (IMD) classifies lightning and thunderstorms, heavy to very heavy, and extremely heavy rainfall, landslides and floods, coldwaves, heatwaves, cyclones,

snowfall, dust and sandstorms, squalls, hailstorms and gales as extreme weather events.

Researchers at the Centre for Science and Environment and its publication Down to Earth have been compiling extreme weather events across India for the past three years to make sense of patterns and trends. For this, they bank on daily and

leased by the IMD, data released by the Disaster Management Division (DMD) of the Union Ministry of Home Affairs, and media reports (to track events during the pre-monsoon period, from March to May, and the losses that occurred during this time including crop area affected).

More extreme events, deaths, losses this year They found that India faced

extreme weather events on 93% of the days in the first nine months of this year (from January 1 to September 30, 2024). This translates to extreme events occurring on 255 out of a total 274 days. These events ranging from lightning and storms to heavy rain, floods, landslides and heat waves claimed the lives of 3,238 people during this time. The events also affected 3.2 million hectares of crops, destroyed 2,35,862 houses and buildings, and killed 9,457 livestock

across the country. In 2024, extreme events occurred over 35 of all 36 states and union territories in India. This year, 27 states and UTs recorded an increase in the number of days that they experienced extreme weather events

when compared to the last two years Karnataka, Kerala and Uttar Pradesh experienced 40 or more additional days of extreme weather events this year. Kerala

recorded the highest number of deaths caused due to extreme events (550), followed by Madhya Pradesh (353 deaths) and Assam (256 deaths).

The most number of houses were damaged (85,806) in Andhra Pradesh, and the largest crop area that was affected was in Maharashtra.

India experienced heatwaves on 77 of 274 days during the nine months and 210 people died due to these high temperatures across the country. During the monsoon season – from June to September - India witnessed extreme events on all days, and these were spread across 35 states and UTs.

Heavy rains, floods and landslides occurred on all 122 days during this period; lightning and storms followed next, occurring on 103 days during this period. Among states. Assam was the worst-hit during this season, as it witnessed extreme weather events on 111 days. Totally, 2,716 people died due to extreme events during the monsoon season across the country, and 3.04 million ha of crops were damaged.

The year also witnessed several climate records being breached across the country. January 2024 was India's ninth driest since 1901. In February, the country recorded its secondhighest minimum temperature in 123 years. India recorded the highest minimum temperatures

in July, August and September, the highest since 1901. East and Northeast India recorded its 12th driest July in 123 years.

This year, the IMD began releasing data on warm nights, a phenomenon when minimum night temperatures remain unusually high instead of dipping: when the maximum temperature has reached 40°C and the minimum temperature is 4.5°C to 6.4°C above normal. This is particularly damaging for peoples' health, as the human body does not get time to cool down even on warm days.

Between March and June 2024, 17 states and Union Territories recorded warm-night events. Five states and UTs -Chandigarh, Delhi, Haryana, Punjab and Uttar Pradesh - experienced unusually high night temperatures during mid-June. Of these, Chandigarh, Delhi, and Haryana each recorded four consecutive "severe warm nights" from June 15 to June 18, a new climate extreme.

#### The need for more comprehensive data

However, there is a data concern: though the IMD has begun releasing data on warm nights, its definition for this phenomenon is "difficult to follow as it does not provide an absolute temperature threshold" unlike what a lot of other countries do, the India Climate Report 2024 noted. It is also difficult to assess losses and damages caused

by extreme weather events due to lack of comprehensive data provided by the DMD as it has also stopped providing cumulative data since 2024.

Such "...incomplete data collection on event-specific losses, particularly public property and crop damage" could therefore mean that many of the figures in the report could well be an underestimate, the India Climate Report 2024 noted.

Moreover, the increase in the frequency and impact of extreme weather events demands that more comprehensive data be made available, the report pointed out. For instance, the number of days that India has witnessed extreme weather events has steadily risen from 2022 to 2024. In 2022, it was 86% of the days in the first nine months; this increased to 88% in 2023 and is now 93% in 2024. The human and economic losses have also increased: 3,238 people died in 2024 when compared to 2,755 in 2022, which amounts to an 18% spike in just three years, the report

said Such "grim news" is coming in at a time when three things are happening, said Sunita Narain, CSE director general and editor of Down To Earth, at the virtual launch of the report on November 8.

back to power; the second is that we are at a "time of desperation" when we are close to breaching the guard rail of limiting warming to 1.5° Celsius above pre-industrial levels; and third, that the impacts of climate change are no longer "a boardroom issue" and one that is "hitting the poorest of the poor", Narain said.

"These record-breaking statistics reflect climate change's impact, where events that used to occur once every century are now happening every five years or even less," Narain said in a press release. "This frequency is overwhelming the most vulnerable populations, who lack the resources to adapt to this relentless cycle of loss and damage."

Many of the impacts of extreme weather events are also due to "bad development" apart from their increased frequencies, Narain said at the virtual launch.

"So if Kerala had the worst landslides possible, it was also because Kerala, in many parts of the Western Ghats, is still building stone quarries and still doing (sic) development as if there is no tomorrow. It is the same with the Himalayas, the same with the city of Delhi. If we have floods in Delhi, it is not only because we have high rainfall in Delhi, it is because we have destroyed our lakes, ponds and drains in our cities." (Cour-

# China holds sea and air combat drills at disputed Scarborough Shoal

BEIJING, Nov 13: China held sea and air combat drills on Wednesday at the disputed Scarborough Shoal, an area of reefs and rocks the Philippines also claims in the South China Sea

On Sunday, China published new baselines for the shoal including geographic coordinates. A nation's territorial waters and exclusive economic zone are typically defined as the distance from the baselines.

"This is a patrol and guard activity carried out by the theatre troops in accordance with the law," the People's Liberation Army's southern ommand said in a short statement. China seized the shoal, which lies west of the main Philippine island of Luzon, in 2012 and has since restricted access to Filipino fishermen there. A 2016 ruling by an international arbitration court found that most Chinese claims in the South China Sea were invalid but Beijing refuses to abide by it.

Tensions between the two countries have been building over their competing claims to Scarborough Shoal and other outcrops in the sea, and clashes have occurred in the disputed waters including the Chinese coast guard firing water cannons at Filipino ships.

Philippine President Ferdinand Marcos Jr signed two laws last week reaffirming the extent of his country's maritime territories and right to resources, including in the South China Sea, in a move that angered China.

# Diminished Biden heads to APEC summit in Peru, overshadowed by China's Xi

LIMA (PERU), Nov 13: If things had gone differently last week, U.S. President Joe Biden could have arrived at the Asia-Pacific Economic Cooperation forum in Peru on Thursday projecting confidence and pledging his successor's cooperation with eager Latin American partners. No longer. Just as in 2016, the last time that Peru's capital Lima hosted APEC, Donald Trump's election victory has pulled the rug out from under a lameduck Democrat at the high-profile summit attended by over a dozen world leaders.

The renewed prospect of Trump's "America First" doctrine hampers Biden's ability to reinforce the United States' profile on his first presidential trip to South America, experts say, leaving China and its leader, Xi Jinping, to grab the limelight in America's proverbial backyard.

President Xi's first order of business in Peru is inau-

gurating a \$1.3 billion megaport that will put China's regional influence on stark display. Total investment is expected to top \$3.5 billion over the next decade.

"This isn't the way the U.S. had hoped to participate in the summit," said Margaret Myers, the director of the China and Latin America program at the Inter-American Dialogue, a Washington policy group. "All eyes are going to

be on the port, what Xi says about it and how he articulates relations across the Pacific."

With the U.S. seemingly headed back toward isolationism under Trump, "China will be seen as the alternative," Myers added. Sitting 60 kilometers (37 miles) northeast of Lima, the Chancay megaport - once a serene fishing village — is perhaps the clearest sign of Latin America's reorientation. The Chinese shipping and logistics giant Cosco holds a 60% stake in the project it developed with Peruvian partner, Volcan.

"With this port, we're looking at the entire Pacific coast, from the United States and Canada all the way to Chile," Peruvian Foreign Minister Elmer Schialer told The Associated Press in his office on Monday. "The shipping business is being transformed."

"The polling station officials will carry out rehearsals from 7 am on Wednesday,' Ratnayaka said. Over 17 million voters from the island's 21 million population are eligible to vote. 225 members would be elected from voting based on proportional representation.

The western province district of Gampaha would elect the highest number of Members of Parliament - 19 with the capital district of Colombo from the same province having 18 MPs elected.

The eastern province district of Trincomalee will elect the lowest number – just 4 MPs. Nearly 90,000 security personnel from the police and the military would be deployed to provide security at the election. There will also be mobile police patrols, the police spokesman Nihal Thalduwa said. The election would be the first major test of the popularity of the ruling party, National

vote at the September 21 presidential election, Dissanayake was pleading for a stronger Parliament with well over the simple majority of 113 seats in order to implement his anti-corruption accountability reformist programme.

Ranil Wickremesinghe, the outgoing president who lost to Dissanayake in last month's presidential election, is not contesting a parliamentary election for the first time since 1977.

DENPASAR (INDONESIA), Nov 13: Several international airlines canceled flights to and from Indonesia's tourist island of Bali on Wednesday as an ongoing volcanic eruption left travelers stranded at airports. Tourists told The Associated Press that they have been stuck at Bali's airport since Tuesday after their flights were suddenly canceled.

"The airline did not provide accommodation, leaving us stranded at this airport," said Charlie Austin from Perth, Australia, who was on vacation in Bali with his family.

Another Australian tourist, Issabella Butler, opted to find another airline that could fly her home.

"The important thing is that we have to be able to get out of here," she said. Media reports said that thousands of people were stranded at airports in Indonesia and Australia, but an exact number wasn't given. Indonesia's Mount Lewotobi Laki Laki volcano on the remote island of Flores in East Nusa Tenggara province spewed towering columns of hot ash high into the air since its initial huge eruption on November 4 killed nine people and injured dozens of others.

The 1,584-metre (5,197-foot) volcano shot up ash at least 17 times on Tuesday, with the largest column recorded at 9 kilometres high, the Centre for Volcanology and Geological Disaster Mitigation said in a statement. (AP)

LONDON, Nov 13: British author Samantha Harvey has won the 2024 Booker Prize for her "ambitious and beautiful" 'Orbital', which becomes the first novel set in space to win the GBP 50,000 literary prize selected from a historic shortlist that was dominated by women this year.

'Orbital', the biggest-selling book on the shortlist in the UK, takes place over a single day in the life of six astronauts and cosmonauts aboard the International Space Station who observe 16 sunrises and sunsets on Earth spinning past continents and cycling past seasons.

It was named the winner at a ceremony at Old Billingsgate in the City of London on Tuesday evening after the judges described it as a compact yet beautifully expansive novel which

invites readers to observe Earth's splendour whilst reflecting on the individual and collective value of every human life.



ITANAGAR, Nov 13: Union minister Rajiv Ranjan Singh on Wednesday emphasised the significant potential for the fisheries sector to flourish in Arunachal Pradesh, provided that available resources are properly utilised.

The minister, who is on a three-day visit to the state since Monday, reviewed various sectors under his ministry, noting that Arunachal Pradesh holds vast potential for inland water fish production. Addressing a press conference at the civil secretariat here, Singh, the Union Minister for Fisheries, Animal Husbandry & Dairying, said India's fish production has grown substantially over the past decade under Prime Minister Narendra

and focus on developmental initiatives.

"The Modi government is committed to making the Northeast and Arunachal Pradesh self-reliant by understanding regional challenges and allocating development projects" he stated. Singh added that several central schemes related to fisheries, such as the Fish ery Infrastructure Development Fund and Pradhan Mantri Matsya Kishan Samridhi Yojana, could be leveraged by Arunachal Pradesh to boost infrastructure and productivity.

"The state should adopt modern technology and diversify fish species, aiming to increase fish production from the current 10,000 tonne to 30,000 tonne", he suggested. # Voter turnout in Wayanad LS constituency by-election drops

WAYANAD/THRISSUR (KER-ALA), Nov 13: The Wayanad Lok Sabha constituency, where Congress general secretary Priyanka Gandhi Vadra made her electoral debut, saw a voter turnout of around 65 per cent during the bypoll on Wednesday.

This was a decline from the close to 74 per cent turnout recorded in the polls held in April, when her brother and senior Congress leader Rahul Gandhi contested from the hill constituency.

It was over 80 per cent when Rahul contested the polls from the hill constituency in the 2019 Lok Sabha elections.

When polling started at 7 am, it progressed briskly, raising hopes among the political parties that the voter turnout would surpass the previous one. However, those hopes faded as the turnout crossed the 50 per cent mark after eight hours of polling.

The figures released by the poll panel after the conclusion of voting at 6 pm put the turnout at 64.69 per cent.


These figures are not final as many voters are still queued outside polling stations in the LS con-

stituency, the Election Commission

(EC) said. The Congress-led UDF dismissed concerns that the reduced voter turnout would adversely affect the margin they expected for Priyanka

According to Leader of Opposition in the Assembly, V D Satheesan, the lower turnout is due to the lack of enthusiasm among voters in areas dominated by the

CPI(M)-led LDF. On the other hand, the LDF and BJP-led NDA rejected the UDF claim and contended that the reduction in voter turnout was due to people not turning up to vote in areas dominated by the Congress



turnout According to EC officials, the number may go up after all the voters waiting in queues cast their

votes. The election process, held amidst tight security arrangements, was primarily incident-free except for electronic voting machine (EVM) breakdowns reported in some booths of Wayanad and Chelakkara

The EVM breakdowns were reportedly quickly addressed by the

election officials.

Emotional scenes were witnessed at the polling stations set up for the survivors of the landslides, which hit the hill district in July this year, to cast their votes in the bypoll for the Wayanad Lok Sabha constituency when they saw their neighbours and close friends after a long time since the disaster.

A special free vehicle service has been provided for landslide survivors to reach the polling stations from the various places they are temporarily residing at.

People arrived early in the morning at the 1,354 polling booths in the hill constituency of Wayanad where there are over 14 lakh registered voters, according to the EC figures.

To facilitate the voting process, 15,344 polling stations have been set up, with 1,152 managed entirely by women and 24 booths specifically manned by specially abled people, according to Chief Electoral Officer K. Ravi Kumar.

Since the enforcement of the Model Code of Conduct, authorities have seized illegal materials and cash worth ₹ 208.78 crore. Additionally, 58 cases have been registered for violations, with the maximum 29 in Garhwa district. (PTI)

# **Beneficiaries 'receive' JMM govt scheme funds** night before voting, BJP lodges complaint

**RANCHI, Nov 13:** Jharkhand BJP

on Wednesday lodged a complaint with the Election Commission against the Hemant Soren-led government for allegedly transferring money into the accounts of women beneficiaries under Jharkhand Mukhyamantri Maiyan Samman Yojana (JMMSY) a night before polling.

The party also lodged a complaint against Ajay Nath Shahdeo, the Congress candidate from the Hatia seat and Mahua Maji, the JMM candidate from the Ranchi seat, for allegedly violating the model code of conduct (MCC).

The delegates, including Pushpak Tiwary, said they demanded a probe and action from the commission against the government for "transferring" the amount under Maiya Samman Yojana on the night of No-

#### vember 12. "We informed the commission that the amount is transferred on the sixth or seventh of every month to the accounts of the beneficiaries. But the same was transferred a night before the polling. We have demanded a probe in this regard. We have also submitted evidence in this regard," the delegates told reporters.

They also alleged that the Congress candidate from the Hatia constituency was distributing voter slips along with his photo on those, while Mahua Maji, the JMM candidate from the Ranchi constituency was roaming in the Chutia area wearing a party badge.

"We lodged complaints against them and demanded action for violating the model code of conduct," they said. (PTI)

### Brisk voting in Maoist-affected areas despite call to boycott polls

CHAIBASA (JHARKHAND), Nov 13: Brisk voting was recorded in Maoist-affected areas in Jharkhand's West Singhbhum district despite a call given by the red rebels to boycott assembly elections on Wednesday, officials said. The Maoists had put up posters and banners at the gates of a polling station in Rabanga village in Manoharpur constituency, calling upon electors to boycott the polls, and also placed an object which was suspected to be a bomb, they said.

### Cong 'shehzada' conspiring to scrap reservations, alleges PM Modi

SARATH (JHARKHAND), Nov 13: In an apparent dig at Rahul Gandhi, Prime Minister Narendra Modi on Wednesday accused the Congress 'shehzada' of conspiring to scrap reservations for people belonging to SC, ST and OBC communities in an attempt to "weaken" them. He also alleged that the ruling JMM-led coalition in Jharkhand "helped infiltrators become permanent citizens" of the state.

'This is a deep-rooted conspiracy that will change Jharkhand's identity," the PM said while addressing a BJP rally in Deoghar.

Promising to thwart such attempts, including that of weakening SC, ST and OBC communities, Modi exuded confidence that the BJP-led NDA was going to form government in Jharkhand and he would come to attend the oath ceremony.

"Congress has dangerous intentions. Congress' 'shehzada' is conspiring to scrap reservations for SCs, STs and OBCs. The prince's father had declared reservation as slavery, bonded labour but he was later defeated in elections. His father had issued advertisements to remove reservations...We will thwart any such conspiracy," Modi said, referring to Congress leader Rahul Gandhi and his father and former PM Rajiv Gandhi without naming them.

PM Modi claimed infiltration was a major concern in Jharkhand due to which "tribal population in Santhal Pargana has reduced to half and if the trend remains unchecked it will change the identity of the state".

"The JMM-led coalition government in Jharkhand allowed infiltrators to become permanent citizens here... It is playing with the security of Jharkhand's 'beti, maati, roti'," he alleged.

# Those claiming Hindus in danger denying reservation to Marathas: Manoj Jarange Patil

#### CHHATRAPATI SAMBHAJI NAGAR (MAHA),

Nov 13: Maratha quota activist Manoj Jarange Patil has said those who claim Hindus are in danger and seek their unity are responsible for denying reservation to Marathas, as he claimed that voters are ready to hand over a drubbing to the BJP-led ruling coalition in the Maharashtra assembly polls.

In his most explicit attack on the 'Mahayuti' government, he said interest of every section of society has suffered on its watch, asserting that Marathas will show their might in the polls.

In an interview to PTI, the 42-year-old activist, who has rallied a large section of Marathas in support of his demand for OBC quota for them, alleged that those who claim to work for Hindu unity have used his community to target Muslims but ignored its genuine demands.

"If you claim Hindus are in danger, then what about Marathas? Can't you see their children's troubles? If you say Hindus are in trouble, then it is also your responsibility to ensure the welfare of Marathas. A Hindu opposes us when we demand reservation, but when they have to target Muslims, they need Marathas to run after them with sticks," he said.

He was reacting to the BJP's slogans such as "batengein to katengein" and "ek hain to safe hain". Who will cut Hindus, he asked, noting that Marathas are the biggest Hindu caste in the state.

"We will settle our issues among ourselves. We follow the Hindutva of Chhatrapati (Shivaji). We will look after ourselves, you mind your own business," he added.

In his statements ahead of the November 20 polls. Patil has refrained from directly naming any party but the common belief among his supporters is that he is against the incumbent, especially the BJP.

In his comments, he gave clear indications of his view.

"The Maratha community understands very well whom to defeat. They understood it during the Lok Sabha polls, and they have understood it now. There is no confusion," he said.

"Those who have been against reservation. Marathas will defeat them 100 per cent. They will not



be spared," he said, accusing the state government of denying the community quota.

The BJP-Shiv Sena-NCP alliance had suffered a big defeat in the state during the Lok Sabha polls, as the opposition Maha Vikas Aghadi of the Congress-Shiv Sena (UBT)-NCP(SP) won 30 of its 48 seats against the ruling bloc's 17.

Asked about Prime Minister Narendra Modi's pitch to voters to re-elect the ruling alliance for development in Maharashtra, he said sarcastically that every section of society is so happy that Modi should dub the ruling dispensation as not double-engine but "triple-engine government".

After all every field is irrigated and no farmer has debt, he said wrvly.

Farmers need better rates for their crops and want to be free of debt but this government denies them their due, he alleged.

"Marathas want reservation for a better future for their children, Dhangars want reservation, there are micro-OBC communities who also want reservations for a better future for their children. Everyone is angry.

Situation is very bad. People will teach them a lesson and inflict a drubbing in the polls," he said.

Be it Muslims, Dalits or traders, the government has harmed everyone's interests, he said.

Amid the view that the BJP is working to rally the support of OBCs to negate the impact of any likely Maratha consolidation, Patil made it clear that his primary objective is to get reservation for Marathas, stressing that they had received quota benefits almost 150 years back but were later not included in the OBC segment

Asked if his stir has divided society and can result in a counter-polarisation of OBCs, he said there will be no such impact.

He said Marathas and OBCs are living together in villages and there is no disharmony. "There is no chance of it either in the future. The OBCs understand that the poor and backward Marathas should get reservation. There are a handful of people who spread such misgiving. They will be taught a lesson in these elections.

Having brought the issue of Maratha quota to the

-🐼-

fore, he said he will launch a "collective fast unto death" to push for its implementation after a new government comes in. He claimed it will be the biggest collective fast the country has ever seen.

He asserted that no alliance can come to power without support from Marathas, who form around 28 per cent of the state's population.

Patil also accused BJP leader and deputy chief minister Devendra Fadnavis of harming the interests of Marathas, claiming he is running the affairs of the government and not Chief Minister Eknath Shinde.

"In the government, everything is in the hands of Fadnavis and not others. He takes decisions. He is the one who formed the government by breaking parties and getting necessary numbers," he said.

Asked about Modi's appeal for the return of 'Mahayuti' government, Patil used sarcasm to make points about farmers allegedly not getting adequate price for their produce.

He said wryly, "Cotton is being bought at Rs 15,000 a quintal, wheat is being sold at Rs 26,000 a quintal, Soybean is getting Rs 36,000, onions are also getting a good rate. The farmers are very happy. Every field is irrigated, so much so that water is flowing across every bund?

He continued, "All farmers are moving around wearing ironed clothes and sunglasses. Nobody will blame him (Modi), he is a very noble man."

Asked why he withdrew his decision to field candidates in the polls, he said he wanted to focus on reservation for Marathas and not politics, and rejected the allegation that he did so due to the MVA's influence to rule out a split in the community's

"What is big deal? We are social activists, new to politics. We could not get equations right. We did not have the experience. I decided to keep away from politics to ensure there is no division in the community for my political benefit. I took the right decision at the right time. Reservation is important and not politics," he said.

Asked about his views on Sharad Pawar, Uddhav Thackeray, Ajit Pawar and Shinde, he said no one helped Marathas on the issue of reservation. (PTI)

# Compassionate appointment not vested right: SC

*Compassionate appointment provided to bail out a family from financial difficulty* 

NEW DELHI, Nov 13: Compassionate appointment is not a vested right for getting a government job as it is not a condition of service of an employee who dies in harness, the Supreme Court held on Wednesday while declining the plea of a man whose police constable father died on duty in 1997, when the petitioner was seven years of age.

A bench comprising Justices Abhay S Oka, Ahsanuddin Amanullah and Augustine George Masih said no direction can be issued asking the State to perpetuate any illegality in favour of a person or a group of individuals contrary to the policy concerned.

Writing the judgment for the bench, Justice Masih said compassionate appointments are intended to address urgent financial distress at the time of a family member's death and do not constitute a vested right that can be claimed after the lapse of a long period of time.

"As regards the compassionate appointment being sought to be claimed as a vested right for appointment, suffice it to say that the said right is not a condition of service of an employee who dies in harness, which must be given to the dependent without any kind of scrutiny or undertaking a process of selection.

"It is an appointment which is given on proper and strict scrutiny ployee facing extreme financial

said It said compassionate appointment is, therefore, provided to bail out a family of a deceased em-

"This shall in any case be subject to the claimant fulfilling the requirements as laid down in the policy, instructions or rules for such a compassionate appointment," it said. The very idea of equality enshrined in Article 14 of the Con-

stitution is a concept clothed in positivity based on law and it can be invoked to enforce a claim having the sanctity of law, it said.

Petitioner Tinku's father, constable Jai Prakash, died alongside an officer while on duty in 1997. At the time, Tinku was only seven years old, and his mother,

who was illiterate, could not apply for an appointment on compassionate grounds for herself.

Instead, she requested that her son's name be entered in the "Minors' Register", with the understanding that he might be considered for a post upon reach-

ing adulthood. In 1998, the Haryana Director General of Police issued instructions for Tinku's name to be recorded, suggesting a future possibility for employment. However, by the time Tinku applied for a post in 2008, after reaching the age of majority, 11 years had passed since his father's death.

Authorities rejected his application on the grounds that Haryana's 1999 instructions had introduced a three-year limit for such claims following an employee's death.

A single-judge bench as well as a division bench of the Punjab and Haryana High Court rejected his plea.

The top court upheld the decision, concurring with previous rulings of the high court that the compassionate appointment policy is meant to address immediate financial needs and cannot be invoked as a guaranteed right after a significant delay.

While denying the petitioner's claim for appointment, the court provided a potential relief to his family, allowing his mother to submit a representation to the competent authority for a lumpsum ex-gratia payment.

On September 10, the court had granted interim bail to Sheikh Abdul Rashid, popularly known as Engineer Rashid, to enable him to campaign for the Jammu and Kashmir assembly elections and deferred the order on his regular bail plea.

Rashid's interim bail was later extended till October 28 on the ground of his father's poor health and after the NIA did not oppose the plea on verifying documents.

The newly elected MP has been lodged in Tihar jail since 2019 after the NIA arrested him under the provisions of the Unlawful Activities (Prevention) Act (UAPA) in the 2017 terror funding case.

# **Railways reminds safety staff to attend** signal failures by issuing proper memo

NEW DELHI, Nov 13: The South Eastern Railway (SER) has issued a circular asking the Signal and Telecom (S&T) Department to attend signal failures by taking failure memo and disconnection memo after it came to light in the Nalpur train derailment case that the signal failure was being attended without following due procedure

"It is reiterated that signal failures should be attended by taking proper failure memo and disconnection memo only," a circular, dated November 11 and issued by principal chief signal and telecommunication engineer of the SER, said.

"After rectification and thorough testing, it should be reconnected by the proper reconnection memos as per the standard formats," it added.

The circular, addressed to senior divisional signal and telecom engineers of Kharagpur, Adra, Chakradharpur and Ranchi rail divisions, has directed them to counsel all maintenance staff to ensure compliance.

The CBI FIR registered on the basis of a complaint from Sanjay Dutt of Quantum Securities Ltd had alleged that ICICI Bank had sanctioned a loan of ₹ 375 crore in 2008 against the entire 61 per cent shareholding of the promoters as

collateral.

The bank had allegedly accepted the repayment of the loan by reducing the interest rate from 19 per cent per annum to 9.5 per causing a wrongful loss of ₹ 48 crore to the bank and corresponding gain to the promoters, it had said. The central investigation agency after nearly seven years of probe came to the conclusion that the reduction of the rate of interest from from 19 per cent to 9.65 per cent as approved on August 5, 2009 was based on various factors -- borrowers' inability to pay, weak financial performance of NDTV, timely payments in the past, volatile share price, etc, officials in the know of the development said. The CBI, which filed its closure report last month, also said that the reduction of the rate of



interest for NDTV was not a "one-off incident". The repayment of the loan at the reduced interest was "higher than average cost of funds", they said.

The central probe agency also found a forensic audit of the case conducted by Pramod Kumar and Associates which termed the repayment to be a "normal business transaction and closure of loan" with no violation of the Banking Regulation Act. In 2022, the Adani Group acquired a controlling stake in NDTV, purchasing shares from the Roys at a preim of nearly 17 pe paid to minority shareholders. The CBI found no merit in the allegation that the loan proposal of RRPR, promoter of NDTV, was accorded a BB

rating yet it was sanctioned and disbursed, they said.

The agency has said that loan proposals worth ₹ 8400 crore having BB rating were sanctioned by ICICI Bank in 2008-09 and 2009-10 which shows that the sanction of loan to RRPR was "not an isolated case" and the bank had been sanctioning loans to such companies, officials said.

NDTV promoters had taken the loan from ICICI Bank to foreclose the liability to India Bulls on a personal guarantee of Prannoy Roy and Radhika Roy and a "contractual comfort of shares" of NDTV under NDU-POA (Non-Disposal Undertakings-Power of Attorney) in favour of ICICI Bank for financial and projected operations of the channel.



The new announcement comes following a controversy over reports of black marketing of tickets after they were sold out within minutes.

The fourth show will be held at Ahmedabad's Narendra Modi Stadium on January 25, 2025, and the tickets will be available on Book-MyShow. In September, Coldplay announced two shows on January 18 and 19, 2025, at the DY Patil Sports Stadium. The music group added a third concert on January 21 at the same venue on popular demand.

The British band, led by vocalist Chris Martin, posted on their official X page about the new concert in India. The tickets for the new show will go on sale on November 16 at 12pm. "2025 AHMEDABAD DATE ANNOUNCED...The band will play their biggest ever show, at the Narendra Modi Stadium in Ahmedabad on 25 January, 2025. #MusicOfTheSpheresWorldTour," the band posted on X. According to a press release by the ticketing platform, the multiple Grammy-award winning band will perform for a potential audience of 100,000 fans, making it "the biggest stadium show of their career".

"The only way to better serve the record-breaking demand for Coldplay's Music Of The Spheres World Tour in India has been to secure the country's largest venue, making it possible to host Coldplay for their biggest-ever stadium audience globally. Bringing another show to life took immense effort from our teams and partners alike and we are thrilled for the chance to make this happen for Coldplay's fans," Anil Makhija, COO - Live Entertainment and Venues, BookMyShow, said in a statement. The Enforcement Directorate began a probe in the alleged illegal sale of tickets of concerts of 'Coldplay' and Diljit Dosanjh after these events were sold out in just minutes on online ticketing platforms, including Zomato Live.

Many of them then landed on unauthorised platforms where they were being sold at exorbitant prices.

Late in the second set of his victory over Taylor Fritz at the ATP Finals on Tuesday, Jannik Sinner used all the adulation in his home country to his advantage. When the top-ranked player produced a backhand passing shot up the line while on the run, matches before his home fans at he held his finger up to his ear to the finals, beating Fritz 6-4, 6-4

on his first set point. During and after the match, the crowd inside Inalpi arena chanted, "Ole, Ole, Ole; Sin-ner, Sin-ner." Sinner saved the only break point that he faced and

nearly matched Fritz with six aces to the American's seven.

But Fritz tested Sinner over two close sets and thought his performance was a step up from the U.S. Open final.

"There's a lot of positives I can take out of it," Fritz said. "For all of the match, I didn't feel overwhelmed. I felt like I was right there." Sinner, who beat Alex de Minaur in his opening match at the season-ending event for the top eight players, improved to 23-1 in his last five tournaments.

Earlier, Daniil Medvedev moved back into contention with a 6-2, 6-4 victory over De Minaur following a temper tantrum in his previous match. Medvedev didn't face a single

break point and was generally much sharper than in his straightset loss to Fritz on Sunday during which he smashed his racket and lost his cool twice.

Sinner leads the group while Fritz and Medvedev are next with one win each. De Minaur, who is making his debut at finals, lost both of his opening matches. The top two finishers from

each round-robin group advance to the semifinals.

On Thursday, Medvedev faces Sinner and De Minaur plays Fritz in the final matches of the group. In the other group on Monday, Alexander Zverev and Casper

Ruud beat Andrey Rublev and Carlos Alcaraz, respectively. Sinner is playing at home for

the first time since it was announced before his U.S. Open title that he tested positive in two separate drug tests this year. A decision to clear Sinner of

wrongdoing was appealed by the World Anti-Doping Agency in September. A final ruling in the case is expected early next year.

When his match was over, Medvedev closed his eyes and held his fingers to his ears. Then he wrote on a camera lens, "Block the noise."

"I went into this match also blocking the noise even from myself," Medvedev said. "No like tantrums and stuff. Just block the noise. And I really didn't care what was happening on the court. I just tried to play and it was a good feeling." (AP)

FIFA's commitment to develop football around the world depends on sound financial management to ensure that member associations get the best value for money for the funding distributed through

the FIFA Forward programme. As part of its effort to ensure this happens, FIFA has been holding regular workshops around the world to enhance financial governance and capacity development within the MAs.

The event was held under the

central football learning hub for all FIFA capacity development and education initiatives for member associations.

Starting with a presentation of the Financial Governance Guide, the workshop included discussion, group work and case sessions on topics such as conflict of interest, planning and budgeting and procurement process, as well as the importance of having adequate supporting documentation.

The sessions emphasised the importance of accountability, transparency, and responsible financial management within the context of the FIFA Forward programme

The FIFA Forward programme was introduced in 2016 to provide funding for tailor-made projects in each of the 211 FIFA member associations.

In the first two cycles, between 2016 and 2022, more than USD 2.8 billion was committed to a diverse array of projects to provide football infrastructure and competitions, and to promote and advance women's football.

The four-year cycle of FIFA Forward 3.0, from 2023 to 2026, represents an increase in football development investment of almost 30% and is a direct consequence of the reinforced governance and financial situation of the new FIFA since 2016. (PTI)

# After hosting World Cup, Qatar praised by UN rights body for labor law reforms

GENEVA, Nov 13: Oatar was praised at the United Nations' top human rights body on Tuesday for improving labor laws before the 2022 World Cup, though it was urged to fully abolish its employment system for migrant workers

Qatar returned to the Human Rights Council in Geneva for its five-yearly review for the first time since the soccer tournament that needed hundreds of thousands of foreign workers to build



Al Muftah said Qatar now had 120 women in diplomatic roles after the number was just three several years ago.

Sweden later recommended Oatar review its laws relating to women's rights in divorce, custody of children and inheritance while Iceland called for abolition of the male guardianship system. Iceland also urged decriminalizing abortion and ensure access to reproductive health services without needing the permission of a male guardian or showing a marriage certificate. Qatar's delegation pointed to the country rising from outside the top 100 to now rank No. 84 in the global index of press freedom. Top-ranked Norway said Qatar should ensure "civil society, human rights defenders and journalists can operate freely without fear of reprisals." Qatar is widely expected to be strong contender in bidding to host the 2036 Olympics, and concluded its presentation Tuesday with sports ministry official Nasser Ali Al-Khater hailing sports as "an important platform to enhance cooperation between

Soccer governing body FIFA is set to confirm Saudi Arabia in December as host of the 2034 World Cup — setting up another decade of scrutiny on how human rights are respected while preparing for more teams playing more games in more stadiums. Sierra Leone said Oatar should "consider abolishing all vestiges" of the labor law system known as kafala.

Watching Dravid, Williamson I realised I have certain gifts I can use to succeed in T2Os: KL Rahul

MUMBAI, Nov 13: India batter KL Rahul revealed he "tried really hard" to prove big-hitting prowess early in his career but watching the legendary Rahul Dravid and Kane Williamson stay true to their natural game and succeed in white-ball formats changed his perspective and helped him evolve as a player.

One of the most stylish batters, Rahul admitted that in his younger days he often tried to be something he was not.

"I think I grew as an individual and as a player. As a youngster, I tried really hard to be someone I wasn't, trying to hit big sixes to prove I could," Rahul said in an exclusive interview on Star Sports.

"It just wasn't coming naturally. What changed for me was watching Rahul Dravid in one of the IPL seasons around 2011 or 2012. He stayed true to his technique, and he was one of the best batsmen. Seeing him do well in one-day and T20 cricket

without changing his game changed something in me," he added.

The 32-year-old, who played 53 Tests, 77 ODIs, and 72 T20Is for India, had spent time in the same dressing room with Williamson, one of the best batters in contemporary cricket, during his time at Sunrisers Hyderabad

Observing both Williamson and Dravid, Rahul realised that he could succeed in T20 cricket by staying true to his natural game. "I also spent time with Kane Williamson at SRH. He didn't get many chances, but he'd still go back and play amazing white-ball innings for New Zealand.

Dravid and "Watching Williamson, I realized I didn't need to try so hard. I had certain gifts I could use in T20 cricket to find success.

"I had just debuted in T20Is for India and scored that 100 in Miami against the West Indies. so I had some recent T20 runs and confidence behind me. It was a new franchise, and I was excited, especially after the high price tag they paid, which I had-
