India to launch ESA's Proba-3 spacecraft in December

NEW DELHI, Nov 5: India will launch the European Space Agency's Proba-3 mission early next month from the spaceport at Sriharikota, Science and Technology Minister Jitendra Singh said here on Tuesday.

Singh said the two satellites that are part of the Proba-3 mission to study the Sun were brought to Sriharikota on Tuesday morning for integration with ISRO's Polar Satellite Launch Vehicle (PSLV).

"Proba-3 mission of the European Space Agency will be launched by a PSLV rocket from Sriharikota in the first week of December," Singh said at the Indian Space Conclave organised by the Indian Space Association. The mission is likely to be

launched on December 4. The two Proba-3 spacecraft will be launched together by the PSLV-XL launcher and placed in the highly elliptical orbit which will as-

cend to 60,000 km away from Earth

form their active formation flying for a planned six hours at a time around their maximum altitude, where Earth's gravitational pull will be diminished, as will the amount of propellant needed to fine-tune their positions. Proba-3's two satellites will enable sustained views of the Sun's faint surrounding atmosphere, or corona, that has previously only been visible for a few brief moments during solar eclipses viewed from the Earth

Colonial practices shouldn't be guiding principles for judiciary: Prez Murmu

Droupadi Murmu on Tuesday said equal justice and getting rid of redundant colonial practices should be the guiding principles for the country's judiciary.

Addressing an event here, Murmu said she shares the views of those who admire the contribution of the "court as the conscience-keeper of Independent India", adding the apex court has developed a jurisprudence that is rooted in Indian ethos and realities.

She said the members of the Constituent Assembly would have thought about the events of the decades behind them just as "we are looking back at the last 75 years of our judicial history".

"The experience of suffering imperial arrogance, like those caused



continuing with the useful aspects of the pre-independence jurisprudence, we should remove the legacy over-burden," Murmu said while releasing three publications of the Supreme Court of India.

She said the book titled 'Justice for the Nation', captures the high points of the Supreme Court's 75-"It also describes the impact of

SC upholds UP madrassa law, overturns High Court ruling NEW DELHI, Nov 5: In a major

relief to madrassas in Uttar Pradesh, the Supreme Court on Tuesday upheld the constitutional validity of the 2004 state law regulating the Muslim minority educational institutions and said a statute cannot be struck down on the ground of secularism.

The significant ruling, which overturned an Allahabad High Court decision, would benefit over 17 lakh students studying in over 16,000 madrassas recognised by the Uttar Pradesh Board of Madrassa education under the state

The high court had asked for the closure of such institutions and directed the state government to accommodate students in a formal schooling system.

The top court said a statute could be declared ultra vires on two grounds -- being beyond the ambit of the legislative competence or vi-



olating fundamental rights or any other Constitutional provision.

A bench comprising Chief Justice of India D Y Chandrachud and Justices J B Pardiwala and Manoj Misra, therefore set aside the high court verdict quashing the 2004 law on the ground that it was viola-

tive of the principle of secularism. "The madrassa Act (Uttar Pradesh Board of Madarsa Education Act, 2004) is within the legislative competence of the state legislature and traceable to Entry 25 of List III (of the constitution), held the bench.

The top court, however, noted the 2004 law to the extent that it sought to regulate higher education, including the "degrees" of "Fazil" and "Kamil" (bachelor and postgraduate (CONTD. ON PAGE-2)

Govt launches Bharat wheat and rice phase-II

ernment on Tuesday launched phase-II retail sales of wheat flour and rice under the Bharat brand at subsidised rates to provide relief to consumers from high prices.

Wheat flour (atta) will be sold at ₹ 30 per kg and rice at ₹ 34 per kg in 5kg and 10kg packets through cooperatives NCCF, Nafed and Kendriya Bhandar and e-commerce platforms.

"This is a temporary intervention to provide relief to consumers," Food minister Pralhad Joshi said after flagging off the mobile vans of these coopera-

The government has allocated 3.69 lakh tonne of wheat and 2.91 lakh tonne of rice from the Food Corporation of India (FCI) for the phase-2 retail intervention under the Price Stabilisation Fund. "This intervention will continue



till the allocated stock gets exhausted. If more (is) required, we have enough stock and will allocate again," Joshi said.

Under the new pricing structure, wheat flour will be available in 5kg and 10kg packs at ₹ 30 per kg, while rice will be sold at Rs

34 per kg -- a slight increase from Phase-I rates of ₹ 27.5 and ₹ 29 per kg, respectively.

Addressing concerns lower rice sales in Phase I, Joshi emphasised that the government's objective wasn't business-oriconsumers and control prices in the market," he said, adding that the government would consider introducing smaller pack sizes if demanded.

The minister also called for a study to understand price firmness despite surplus rice stocks, though maintaining those prices were "largely under control", with only slight fluctuations in normal quality varieties.

The previous phase, from October 2023 to June 30, 2024, saw the distribution of 15.20 lakh tonne of wheat flour and 14.58 lakh tonne of rice.

On future allocations, Joshi assured adequate stocks for continued intervention if required.

voice. Merely because somebody is sitting at a glasshouse in Dispur, does it mean he won't listen to anybody?" he asked. After listening to all the arguments, the bench fixed November 13 as the date for the next hearing. Following a series of protests, the chief minister's office on October 30 said that chief secretary Ravi Kota chaired a meeting with senior officials of PWD (Roads) to discuss possible alternatives for the upcoming flyover in order to avoid West and East Dighalipukhuri roads.

Hundreds of people, including singers, actors and students of nearby Cotton University, have been holding night vigils in the area to prevent the administration from cutting the trees.

Netizens also took to social media to criticise the government's decision, highlighting the trees' importance as habitats for numerous resident and migratory birds.

According to an RTI reply, the Public Works Department, which is looked after by chief minister Himanta Biswa Sarma, stated that the authorities have decided to go ahead with uprooting the trees surrounding the historic Dighalipukhuri without carrying out any environmental impact assessment and public hearing.

As per popular legend, Dighalipukhuri was constructed by King Bhagadatta, who led the Kauravas in the Battle of Kurukshetra in the Mahabharata, during the 'swayamvar' of his daughter Bhanumati Historically, the pond was used by the Ahoms as a naval dockyard, especially during the 1671 Battle of

Saraighat on Brahmaputra.

Its access to Brahmaputra was eventually closed during colonial times. The connecting portion was further filled, on which the Circuit House was built and later the Gauhati High Court came up.

Besides, several other landmark structures like the state museum, district library, Rabindra Bhawan, Reserve Bank of India, a part of Cotton University, which is the first college of the Northeast, Handique Girls' College, the first women's college of the Northeast, Nabin Chandra Bordoloi Hall and district courts are located in the

atmosphere" for political purposes even if the situation in Assam is stable. In contrast to the Congress' alleged attempts to put the Bengali Hindu community in jeopardy, Sarma highlighted the BJP's continuous efforts to address and fix the problems they confront.

The BJP leader urged the people to vote for the party's candidate Nihar Ranjan Das, claiming that uninterrupted, accelerated development of the constituency can be ensured if the MLA is from the ruling party.

"If an MLA or an MP both are from BJP, with BJP governments at Dispur and Delhi, they will work together. But if the Congress candidate wins, he will later say that he cannot get things done as the BJP is in power in the state and at the Centre," the CM added.

"The Congress is like a male cow, you can feed it as much as you want, but it cannot give you milk. Similarly, you can vote for the Congress, but it cannot give you development," Sarma said.

The chief minister asserted that the BJP has been fulfilling its poll promises, including providing one lakh government jobs, and all assurances will be implemented before the next Assembly elections in 2026.

By-elections are scheduled in five Assembly constituencies of the state on November 13. Besides Dholai, the BJP has fielded candidates in Samaguri and Behali seats, while its allies AGP is contesting from Bongaigaon and UPPL from Sidli.

These by-polls were necessitated by the election of the incumbent MLAs to the Lok Sabha Of these five seats, BJP and its allies held four, with Congress holding one. (With inputs from PTI)

SC upholds UP madrassa law,

level degrees given by madrassas), was beyond the legislative competence of the state legislature as it conflicted provisions of the University Grant Commission (UGC) Act and was therefore unconstitutional. "The UGC Act governs the standards for higher education and a state legislation cannot seek to regulate higher education, in contravention of the provisions of the UGC Act," it said.

The apex court noted that the high court had fallen into error and ended up "throwing the baby out with the bathwater" by striking down the entire madrassa law on the ground that conferment of such degrees has been held to be unconstitutional due to lack of legislative competence.

"The entire statute does not need to be struck down each time that certain provisions of the statute are held to not meet constitutional muster. The statute is only void to the extent that it contravenes the Constitution," it said. The top court said the constitutional validity of a statute couldn't be challenged for the violation of the basic structure of the Constitution.

"The reason is that concepts such as democracy, federalism, and secularism are undefined concepts. Allowing courts to strike down legislation for violation of such concepts will introduce an element of uncertainty in our constitutional adjudication," pointed out the bench.

The top court noted it had recently accepted that a challenge to the constitutional validity of a statute for violation of the basic structure was a technical aspect because the infraction had to be traced to the express provisions of the Constitution. (PTI)



Dighali Pukhuri flyover debate

he ongoing debate surrounding the Dighali Pukhuri Flyover project in Guwahati has brought to the forefront not only concerns about urban infrastructure and traffic management but also pressing issues related to environmental conservation, particularly the fate of the trees surrounding this historic water body. As urbanization accelerates in Indian cities, the clash between developmental needs and ecological sustainability becomes more pronounced. Dighali Pukhuri, a historic pond believed to date back to the Ahom dynasty, is more than just a body of water; it is a vital ecological asset for Guwahati. The pond is surrounded by a lush expanse of trees, which not only contribute to the area's scenic beauty but also serve as crucial components of the urban ecosystem. These trees provide shade, improve air quality, support biodiversity, and play a significant role in mitigating urban heat. They also have historical and cultural significance, representing the city's heritage and connecting residents to their past.

As the city grapples with increasing pollution levels and climate change, preserving these trees is essential for fostering a sustainable urban environment. The felling of trees for the construction of the flyover poses a serious threat to this delicate balance, prompting strong reactions from environmentalists, local residents, and heritage advocates.

UK's Conservative Party turns over a new page

The election of Kemi Badenoch, as the new leader of Britain's Conservative Party seems to have rattled not just the common public but even the diehard Tories. But this should also be seen as the last-ditch efforts by the Conservatives to revive the party's fortunes.

Last week, Britain's chastened Conservative Party, which faced its biggest defeat and the lowest tally of seats in the House of Commons, in the general elections earlier this year, elected Kemi Badenoch as its new leader.

This marks the Tories'looking-up to a right-wing favourite who has raised concerns about identity politics, transgender rights, and state spending, to rebuild its reputation after a devastating election defeat

Badenoch defeated Robert Jenrick in a vote of party members by 53,806 votes to 41,000, after a months-long contest to replace Rishi Sunak as the party's leader.

She's the first Black woman to lead a major British political party, and the Tories are brandishing this as being a diverse and inclusive party as compared to Labour, which so far has been led by

White men only. But rather disconcerting is the fact that her selection all but ensures a rightward shift to Britain's political discourse over the next several years, and creates a jarring stylistic clash between the new opposition leader and Keir Starmer, Labour's serious and straight-

laced prime minister. After winning the party's election, Badenoch outlined the tasks ahead to the Tory faithful: Hold the Labour government to account and prepare for government with "a clear plan.

Badenoch continued that the party needed to be honest "about the fact that we made mistakes, honest about the fact that we let standards slip."

However, overall, this was primarily due to the Conservatives losing the grip over the real issues, public anger and facing public's ire over their management of the economy, crime, immigration, and declining standards in public life by its leaders like BoJo and Liz Truss, who were faced by a daunting task of rebuilding Britain after the Brexit, and they completely lost the

Badenoch, who has often been described as one who relishes confrontation has received muted support from into US-style cultural clashes on a swathe of topics, inspiring grassroots members on the Conservatives' rightwing in the process.

Curiously, Badenoch has often been compared to Margaret Thatcher and she herself has said she shares Thatcher's "values of self-reliance, personal responsibility and free markets."

Like the Iron Lady, Badenoch is reported to be fearless and combative. She believes conservatism is in crisis. and that her party must get "back on track" having lost sight of its principles and values. Yet, the comparison between the two seems rather skewed.

Charles Walker, a former Conservative lawmaker, who has followed Badenoch's political ascent with interest, says he isn't convinced that she's the new Thatcher. "It's not just about having strong views. Margaret Thatcher had her views intellectually under-

pinned and was pragmatic," he said. Niall Ferguson, a Milbank Family Senior Fellow at the Hoover Institution. Stanford University, and a Bloomberg Opinion columnist opines that like Thatcher, she is middle-class, the

daughter of professionals. Like Thatcher, she studied a hard subject at university (computer systems engineering) and came to political and economic theory later in life, after experiencing the real world of the private

Ferguson says further, "Best of all, from my point of view, is her sense of history. One of the books that has influenced her thinking is Daron Acemoglu and Jim Robinson's Why Nations Fail, which makes the point that Britain's spectacular rise in the 18th and 19th centuries owed more to constitutional constraints and the rule of law than to (as she put it) 'colonialism or white imperialism or privilege or whatever'. That is a fundamental argument not only about Britain's past, but also about its future, which will be prosperous only if we return our government to the

principles that Badenoch holds dear. Michael Murphy - a London-based journalist, writing for the Daily Telegraph opines that comparisons to Thatcher can obscure more than they reveal. While Thatcher was known for "excessive punctuality" and meticulous attention to detail, Badenoch is reportedly often late to meetings and disinterested in reading ministerial briefings. These traits could, at crucial junctures,

But the anticipated swing to the right under Badenoch, 44, could alienate the more moderate wing of the party.

> She says the administrations of former prime ministers such as Sunak and Boris Johnson gave up those principles in favour of an approach that meant the party "spoke right and governed left",

> handing votes to other parties. Badenoch has faced a backlash for her remarks like when she said 5-10% of civil servants, or apolitical officials working in government, were "very bad" and "should be in prison" for undermining ministers. Or comments that maternity pay was "excessive" and people should exercise "more personal responsibility" also raised eyebrows.

While some might see such slip-ups as a problem, Badenoch sees her straight talking as an asset, one she says has helped her work well in teams in government. But all this also proves that apart from a hard worker who rose from the ranks, Badenoch is a maverick who may achieve what she has set her sights on. Shutdown of Indian visa likely to strain relationship with Bangladesh

couple of Indian visa centres were vandalised by anti-Indian mobs in the aftermath of the collapse of the kleptocracy regime. In the absence of police and auxiliary forces in fear of reprisal from the angry students for the deaths of more than a thousand protesters, they abandoned their posts and went into hiding.

MEA spokesperson in New Delhi said: "We are issuing limited visas. If someone needs to come to India for medical or urgent reasons, we are providing a limited number of those visas."

He, however, said, "We are already issuing medical visas and visas for emergency requirements. Once the law and order situation improves and the situation becomes conducive to our resumption of normal visa operations (in Bangladesh), we will do that.

Among the top 15 countries. Bangladesh (22.3 percent) topped in Foreign Tourist Arrivals (FTAs) in India in 2023, while the United States of America and the United Kingdom stand second and third respectively, according to the Indian Ministry Of Tourism.

Approximately 2.12 million tourists visited India in 2023, making Bangladesh the top source of FTAs in India that year.

A top Indian diplomat in the Indian High Commission posted in Dhaka confided that lack of security at the visa centres deters normal functioning.

Over a hundred non-essential Indian staff managing the centres have left for India in the aftermath of the student uprising and attacks in some centres outside the capital Dhaka.

He could not say when the visa processing centres are expected to resume normal function. The decision remains with the government in New Delhi after consultation with Dhaka.

How is PPD treated? Therapy, either hormonal or with antidepressants. Self-care, like giving yourself some time alone from the baby, taking care of yourself, and giving your life a meaning so you can give your baby a meaning as well. Remember, these women do not hate their children; they themselves don't understand what's going on. So many women have reported feeling

When a woman gives birth, sometimes she feels that everyone cares about the baby and not her. This is not called being selfish but rather that went through labor/surgery, and taking care of herself after giving birth is vital.

The woman is usually on nervous ground, and helping her, especially as a husband, is important. Untreated postpartum depression can last for months or longer, sometimes becoming an ongoing depressive disorder. Mothers may stop breastfeeding, have problems bonding with and caring for their infants, and be at increased risk of suicide.

Understanding a mother after such a life-changing incident requires delicate words and an enormous amount of support. Even if you suspect something that may make you feel that a mother is depressed, help her. Encourage her to go forward with therapy. Some might refuse, but it's your duty to continue. Offer to pay for therapy, be their therapist, etc. "A woman who is incompe-

tent in raising a baby has failed as a mother" is a busted statement, as there is no perfect meaning of a perfect mother.

A mother is one who supports her child unconditionally and is ready to take help for the betterment of herself, her family, and her children. She's also one who is alone in making decisions sometimes, lacks support due to social stigma, and doesn't know what's best for her. She's confused because she's overwhelmed. She doesn't want to blame the child but society because they are making her feel that she is a bad mother.

Postpartum depression is a serious disorder, and sometimes keeping our ego aside is more important, as helping your wife grow will help your child as well. Postpartum depression is not a health issue only borne by the mother; it affects everyone as well. It's not her fault, obviously, so if she doesn't understand, then her surroundings should.

Educating yourself about such an issue and then raising awareness on it is a role that society needs to follow. In schools, especially in underprivileged areas, as a lot of women there have to bear more physical labor after birth. Realizing that if a woman asks for help or even to leave her alone, listen. Listen when a mother is complaining.

"When my husband (ex) found out that I was suffering through postpartum depression, he left me, took my son, and spread rumors that I am crazy, stupid, and cannot raise my child. This took a deep toll on my mental and physical health, and he won the court battle due to this. I spent three years working on myself and constantly fighting for my son when I won full custody. What to know about irregular periods

someone's menstrual cycle is shorter than 24 days, more than 38 days long, or if the length varies significantly from month to month, they have irregular periods. Doctors call this oligomenorrhea.

It is normal for the menstrual cycle length to vary slightly from month to month, especially if someone is going through puberty, breastfeeding, or approaching menopause.

Many other factors can affect period regularity, too, such as stress, medications, and mental or physical health conditions. What causes irregular peri-

ods? Irregular periods, oligomenorrhea, can occur for many reasons. Many relate to hormone levels.

Estrogen, progesterone, and follicle-stimulating hormone are the main hormones responsible for regulating the menstrual cycle. If something disrupts or alters how these hormones rise and fall each cycle, it can cause irregular periods.

Occasional irregular periods are common and are not usually cause for concern. Factors that may contribute to irregular periods include:

- natural hormonal shifts
- hormonal birth control
- stress
- endurance exercise weight loss

More persistent irregularity may be a sign of an underlying condition. The following sections look at some of the potential causes for irregular periods

in more detail Natural hormonal changes During puberty, the body un-

dergoes significant changes. It can take several years for the hormones that regulate periods to fall into a reliable pattern. During this time, it is common to have irregular periods.

Oligomenorrhea can also occur after childbirth and while breastfeeding until the hormones return to normal after

having a baby. Breastfeeding, especially exclusive and frequent breastfeeding, can suppress ovulation, causing a person's periods to stop. Doctors call this lactational amenorrhea.

Periods also become irregular during perimenopause, which is the first stage of menopause. During this time, hormone levels begin to fall. Periods may get further and further apart until a person stops having them en-

Starting birth control Hormonal birth control works

by stopping ovulation. This means a person does not have a true period while they are using it. Instead, some people have no period at all, while others will have withdrawal bleeds that can seem similar to a period.

When a person first starts the pill, patch, implant, or hormonal intrauterine device (IUD), they may experience irregular bleeding during the first few months. This may become more regular as time goes on or stop entirely.

Stopping birth control Similarly, when a person stops using hormonal birth control, this can also lead to irregular periods. It takes time for the body's hormonal cycle to begin working as usual again.

Typically, people have a withdrawal bleed 2-4 weeks after stopping birth control pills. The next bleed is a period. It can take up to 3 months for the cycle to settle into a regular pattern.

People who had irregular periods before they began hormonal birth control may return to having an irregular cycle after

they stop using it. Underlying health condi-

Irregular periods can sometimes indicate a health condi-

tion, such as: Polycystic ovary syndrome

Polycystic ovary syndrome (PCOS) is a condition where small, fluid-filled sacs, known as cysts, develop in the ovaries. PCOS causes high testosterone levels, which can prevent or delay ovulation and a person's period.

The other symptoms of PCOS include:

 excessive hair growth insulin resistance that may affect weight

Eating disorders Eating disorders, such as anorexia nervosa, bulimia nervosa, and binge eating disorder, can cause absent or irregular periods. This is more likely to occur if someone has experienced severe weight loss.

The signs of an eating disor-

der can include: • extreme restriction of food or calorie intake

· cutting out whole food groups from the diet unnecessarily, such as carbohydrates · fasting, followed by binge

eating · going to the bathroom immediately after meals • eating large amounts of food

when not hungry People who exercise excessively may also experience irregular periods. When people find it hard to stop exercising, it is known as compulsive exer-

Endometriosis

Endometriosis is a condition in which cells that usually grow inside the uterus grow outside of it. These cells make up the uterine lining, which thickens and sheds with each menstrual cycle. When the cells grow else-

where, this cyclic thickening and shedding cause significant pain. Other symptoms include:

· heavy periods passing large blood clots • bleeding between periods problems getting pregnant

Thyroid disease The thyroid produces hormones that affect metabolism, heart rate, and other basic functions. It also helps control the

timing of ovulation and periods. People with hyperthyroidism produce too much thyroid hormone, while those with hypothyroidism do not produce enough.

Thyroid disease can make periods heavy or light and can make them more or less frequent. It can also cause ovulation to stop in some people. Symptoms of hyperthy-

roidism include: racing heart

Thyroid disease is treatable. An underactive thyroid may require thyroid hormone, while radioactive iodine may help with hyperthyroidism. Some types of thyroid dysfunction require the removal of the thyroid.

Other conditions

Other health conditions associated with irregular periods include:

- type 1 diabetes • Cushing's syndrome
- · primary ovarian insufficiency · congenital adrenal hyperpla-

• hormone-secreting tumors Complications Irregular periods are usually not harmful. However, persistent or long-term irregularity

may raise the risk of other con-

ditions, such as: Iron deficiency anemia: Blood contains iron. If periods are heavy or frequent, a person may lose enough blood to cause

an iron deficiency. **Infertility:** Irregular periods can result from anovulation, which is when the body does not

release an egg. This can mean a person has difficulty getting

pregnant. **Osteoporosis:** Ovulation is a source of estrogen, which helps to keep the bones strong. If a person often does not ovulate, they may be at a higher risk for osteoporosis due to having less estrogen.

Cardiovascular disease: Similarly, a lack of estrogen can raise the risk of cardiovascular disease.

Endometrial hyperplasia: If a person has irregular periods for a long time without treatment, it may raise the risk for endometrial hyperplasia, which is when the uterus lining becomes unusually thick. This increases the risk of endometrial

Treatment

Having irregular periods from time to time is common and does not require treatment. Irregularity due to puberty, perimenopause, or contraception also does not typically require treatment.

However, someone may want to speak with a doctor if: • the irregularity is persistent and has no apparent cause

· irregular periods could be related to a medication or health condition • irregular periods occur

alongside other symptoms, such as pelvic pain · the person wants to get preg-

If there is an underlying cause, a doctor will be able to diagnose it. Treatment will depend on what is causing the ir**ommendations may include:** they do not ovulate.

Hormone therapy: Birth control that contains the hormones estrogen and progesterone can help raise hormone levels, which can counteract the effects of not ovulating. It can also make bleeds regular and easier to manage or reduce the symptoms of conditions such as PCOS, which may improve quality of life.

moderate Reaching a weight: Both a lack of body fat and having excess body fat can impact menstruation. For those with PCOS who have higher body weight, maintaining a healthy weight can lower insulin levels. This leads to lower testosterone levels and an increased chance of ovulating.

Nutritional therapy: If a person wants to lose or gain weight or has an underlying condition that affects their nutrition, they may benefit from help from a dietitian. They can help a person understand the type of diet that will help with their unique circumstances and support hormone health

Mental health treatment: If irregular periods are related to stress, anxiety, depression, or an eating disorder, a doctor may recommend psychological support. For many, this usually involves talk therapy with a psychologist. A multidisciplinary team will help with regular therapy, nutritional counseling, and support groups for those with eating disorders. People with severe underweight may need treatment in the hospital.

Additional medications: Depending on the underlying cause, people with irregular periods may benefit from certain medications. For example, a doctor may prescribe metformin for people with PCOS. This is an insulin-lowering oral drug for type 2 diabetes, which can help ensure ovulation and regular pe-

However, this does not mean that pregnancy is impossible. Tracking when someone is ovulating can help. Try:

Tracking periods: Mark any periods on a calendar, and look for patterns. Period tracking apps can help with pinpointing the time of likely ovulation. Ovulation almost always occurs about 2 weeks before a person's period. However, the length of time between the start of the period and the next time a person ovulates can vary.

Monitoring cervical mucus: As ovulation approaches, the cervical mucus will be more plentiful, slippery, clear, and

Measuring body temperature: Use a thermometer to measure body temperature first thing each morning and note when it spikes. This can indicate that someone has ovulated. Using ovulation predictor

kits: These products test for a surge in luteinizing hormone, which suggests ovulation is imminent. A person has likely ovulated if there is a prolonged increase in morning body temperature after a positive ovulation test.

If these methods do not help, speak with a fertility doctor about irregular periods. They will be able to provide advice on what to do next.

Summary

Irregular periods and occasional variations in cycle length are normal. However, if a person regularly has very short or long cycles, something may be affecting their menstrual cycle.

Temporary causes for irregularity can include stress, natural hormonal changes, and starting

or stopping birth control. Certain medications and health conditions can also cause irregular periods. If this is the case, a doctor will be able to diagnose it and provide treatment

Head of Myanmar's military government visits close ally China for first time since taking power

Myanmar's military government embarked on Tuesday on an official visit to China, the embattled Southeast Asian nation's most important international ally, for several regional meet-

It is the first time Senior Gen. Min Aung Hlaing has traveled to the neighboring country since his army seized power in February 2021 from the elected government of Aung San Suu

Myanmar's army suffered unprecedented battlefield defeats over the past year, especially in areas near the Chinese border. Both Myanmar's ruling generals and China's government have shown concern as pro-democracy guerrillas and armed ethnic minority groups, sometimes working hand in hand, have taken the initiative in their fight against military rule.

But Beijing is now concerned about instability that threatens its strategic and business interests in Myanmar. China's government has maintained good working relations with Myanmar's ruling military, which is shunned and sanctioned by many Western nations for the army takeover and for major human rights violations.

State-run MRTV television said that Min Aung Hlaing departed on a flight from the capital, Naypyitaw, Tuesday morning to begin his visit.

He will visit the Chinese city of Kunming on Wednesday and Thursday to attend three summits: The Greater Mekong Subregion, the Ayeyawady-

China, along with Russia, is a major arms supplier to Myanmar's military in its war against resistance forces. Beijing is also Myanmar's biggest trading partner and has invested billions of dollars in its mines, oil and gas pipelines, and other infrastructure.

Russia is the only other foreign destination to which Min Aung Hlaing is known to have traveled since taking power, aside from his attendance at an April 2021 summit meeting of the Asmar's public.

The shadow National Unity Government was established by elected lawmakers barred from taking their seats in 2021 and is closely linked to Suu Kyi's former ruling National League for Democracy party, which had friendly relations with Beijing. Although China is scorned by many for backing the army, the shadow government tries to avoid antagonizing Beijing too much, recognizing the influence it has in the region.

Myanmar's army has been on the defensive since late last year when ethnic armed organizations dealt it major defeats in the country's northeast.

The offensive by the "Three Brotherhood Alliance," comprising the Myanmar National Democratic Alliance Army, the Arakan Army and the Ta'ang National Liberation Army, was able to quickly capture towns and overrun military bases and command centers and strategic cities along the Chinese border in northeastern Shan

It was widely seen at the time as having Beijing's tacit support to help stamp out rampant organized crime activities in the area controlled by ethnic Chinese. Beijing helped broker a cease-fire in January, but that fell apart in June when the ethnic rebel forces launched new attacks. China was displeased with the ongoing warfare, shutting down border crossings, cutting electricity to Myanmar towns and taking other meas-

Russian rocket launches Iranian satellites into orbit as Moscow and Tehran expand ties

MOSCOW, Nov 5: A Russian rocket on Tuesday blasted off successfully to carry a pair of Iranian satellites into orbit, a launch that reflected growing cooperation between Moscow and Tehran

The Soyuz rocket lifted off as scheduled from Vostochny launchpad in far eastern Russia and put its payload into a designated orbit nine minutes after the launch. It was carrying two Russian Ionosphere-M Earth observation satellites and several dozen smaller satellites, including the two Iranian

Iran's two satellites, named Kowsar and Hodhod, were the first launched on behalf of the country's private sector. In 2022, a Russian rocket launched an Iranian Earth observation satellite called Khayyam that was built in Russia on Tehran's order, and in February Russia put another Iranian satellite named Pars-1 into orbit

Tuesday's launch comes as Russia and Iran have expanded ties in various spheres. Ukraine and the West have accused Tehran of providing Moscow with hundreds of exploding drones for use on the battlefield in Ukraine and helped launch their production in Russia. The Iranian drone deliveries, which Moscow and Tehran have denied, have allowed for a constant barrage of longrange drone strikes at Ukraine's infrastruc-

Moscow and Tehran are planning to further bolster their ties with a "comprehensive strategic partnership" that is set to be signed Iranian President Masoud Pezeshkian's planned visit to Russia. The date for that visit hasn't been set yet, but the Kremlin said it could happen soon.

Tuesday's successful launch of the Iranian satellites atop a Russian rocket follows civilian space program in recent years. There have been five failed launches in a row for the Simorgh program, a satellite-carrying rocket.

A fire at the Imam Khomeini Spaceport in February 2019 killed three researchers, authorities said at the time. A launchpad rocket explosion later that year drew the attention of then-President Donald Trump, who taunted Iran with a tweet showing what appeared to be a U.S. surveillance photo of the

At the same time, a separate Iranian space program run by the country's paramilitary Revolutionary Guard has seen successful launches from a military base outside of Shahroud, some 350 kilometers (215 miles) east of the capital, Tehran. However, satellite images analyzed by The Associated Press show Israel likely bombed the site during its Oct. 26 retaliatory strike on Iran.

The U.S. intelligence community's worldwide threat assessment this year said Iran's development of satellite launch vehicles 'would shorten the timeline" for Iran to develop an intercontinental ballistic missile because it uses similar technology.

Intercontinental ballistic missiles can be used to deliver nuclear weapons. Iran is now producing uranium close to weapons-grade levels after the collapse of its nuclear deal with world powers. Tehran has enough enriched uranium for "several" nuclear weapons, if it chooses to produce them, the head of the International Atomic Energy Agency has warned.

Iran has always denied seeking nuclear weapons and says its space program, like its nuclear activities, is for purely civilian purposes. However, U.S. intelligence agencies and the IAEA say Iran had an organized military nuclear program up until 2003. (AP)

The death toll in Lebanon crosses 3,000 in the 13-month Israel-Hezbollah war: Health Ministry

BEIRUT, Nov 5: The 13-month war between Israel and Hezbollah has killed more than 3,000 people in Lebanon, the country's Health Ministry said on Monday, more than double the number of people killed since their last major war two decades ago.

The war shows no signs of ending, and Israel has said it is carrying out new operations targeting Hezbollah infrastructure across Lebanon and in parts of Syria while Hezbollah continues to launch dozens of rockets into northern Is-

Hezbollah began firing northern Israel the dav afte Hamas' surprise attack into Israel on Oct. 7, 2023 ignited the war Gaza. Hezbollah and

Hamas are both allied with Iran. For nearly a year, the conflict

was mostly contained to the areas along the border between Israel and Lebanon. The conflict dramatically escalated on Sept. 23 with intense Israeli airstrikes on south and east Lebanon as well as Beirut's southern suburbs, leaving hundreds dead and leading to the displacement of nearly 1.2 million people.

Israel began a ground invasion of south Lebanon on Oct. 1, causing wide destruction in border villages but making little advances on the ground inside Lebanon. Israel says it is destroying Hezbollah weapons and command centers near the border, including an extensive tunnel system built by Hezbollah.

The Lebanese Health Ministry said 16 people were killed and 90 injured in attacks on Sunday, bringing the death toll to 3,002. At least

13,492 have been injured. The ministry does not differentiate between civilians and Hezbollah fighters in its toll. Israel claimed hundreds of Hezbollah fighters have been killed.

In Israel, 72 people have been killed Hezbollah at-

tacks, includprime miniser's office.

More than 60,000 people have been displaced from their homes. Also on Monday, Israel an-

nounced it terminated the agreement facilitating the work of the agency for Palestinian refugees, the main aid provider in Gaza. It was the first step in imple-

menting legislation passed last week that would sever ties with the agency, which Israel says has been infiltrated by Hamas, and prevent it from operating in Israel.

The agency, known as UNRWA, denies the allegations and says it takes measures to ensure its neu-

North Korea fires multiple ballistic missiles toward sea ahead of US election

SEOUL, Nov 5: North Korea on Tuesday fired multiple short-range ballistic missiles toward its eastern sea, the South Korean military said, as the country continued its weapons demonstrations hours before the US presidential election.

South Korea's Joint Chiefs of Staff didn't immediately specify the number of missiles detected or how far they flew. Japan's Defence Ministry said the missiles were believed to have already landed at sea and there were no immediate reports of damage.

The launches came days after North Korean leader Kim Jong Un supervised a flight test of the country's newest intercontinental ballistic missile designed to reach the US mainland. In response to that launch, the United States flew a long-range B-1B bomber in a trilateral drill with South Korea and Japan on Sunday in a show of force. That drew condemnation from Kim's powerful sister, who on Tuesday accused North Korea's rivals of raising tensions with "aggressive and adventuristic military threats.

South Korean officials have said that North Korea was likely to dial up its military displays around the US presidential election to command the attention of Washington. South Korea's military intelligence agency said last week that North Korea has also likely completed preparations for its seventh nuclear test. Outside officials and analysts say North Korea eventually hopes to use an expanded nuclear arsenal as leverage to win concessions such as sanctions relief after a new US president is elected.

There are widespread views that Kim would prefer a win by Republican candidate Donald Trump, with whom he engaged in high-stakes nuclear diplomacy in 2018-19, seeing him as a more likely counterpart to give him what he wants than Democratic can-



didate Kamala Harris.

During campaigning, Trump boasted about his personal ties with Kim, while Harris said she won't "cozy up to tyrants and dictators like Kim Jong Un who are rooting for

North Korean state media claimed last week that the Hwasong-19 it tested on October 31 was "the world's strongest" ICBM, but experts say the solid-fuel missile was too big to be useful in a war situation. Experts say North Korea has vet to acquire some critical technologies to build a functioning ICBM, such as ensuring that the warhead survives the harsh conditions of atmospheric re-entry. Tensions between the Koreas are at their highest point in years as Kim has repeatedly flaunted his expanding nuclear weapon and missile programmes, while reportedly providing Russia with munitions and troops to support President Vladimir Putin's war in

According to the US, South Korean and Ukrainian intelligence assessments, North Korea is estimated to have sent between 10,000 and 12,000 troops to Russia. If they start fighting against Ukraine forces, it would mark North Korea's first participation in a large-scale conflict since the end of the 1950-

On Monday, US State Department spokesperson Matthew Miller told reporters that as many as 10,000 North Korean soldiers were in Russia's Kursk region near Ukraine's border and preparing to join Moscow's fight against Ukraine in the coming days. That's up from the 8,000 troops that the US government mentioned Thursday. After a meeting in Seoul on Monday, South

Korean Foreign Minister Cho Tae-yul and EU foreign policy chief Josep Borrell expressed "deep concern" over the possibility that Russia might transfer nuclear or ballistic missilerelated technology to the North in exchange for its arms and military personnel. Such transfers would "jeopardize the inter-

national non-proliferation efforts and threaten peace and stability on the Korean Peninsula and across the globe," they said, while calling on North Korea and Russia to immediately withdraw the North's troops from Russia.

In response to North Korea's growing n clear threat, South Korea, the United States and Japan have been expanding their combined military exercises and updating their nuclear deterrence plans built around US

North Korea has portrayed the joint military drills by its rivals as rehearsals for an invasion and used them to justify its relentless pursuit of nuclear weapons and missiles.

At a UN Security Council meeting Monday, North Korea's ambassador, Kim Song, defended the North's nuclear and ICBM programmes as essential for the country's selfdefence and a necessary response to what it perceives as nuclear threats from the United States. He stressed that North Korea would accelerate the build-up of "our nuclear force that can counter any threat presented by hostile nuclear weapon states." (AP)

Palestinian officials say an Israeli airstrike has killed 20 people in northern Gaza

DEIR AL-BALAH (GAZA STRIP), Nov 5: Palestinian medical officials say an Israeli airstrike in the northern Gaza Strip has killed at least 20 people, mostly women and children.

Hossam Abu Safiya, the director of a nearby hospital that received the casualties, said the strike late Monday hit a home in the town of Beit Lahiya where multiple families were shel-The dead included eight women and six

children, according to a list provided by the Gaza Health Ministry's emergency service. There was no immediate comment from the Israeli military. Israel has been waging a massive offensive

in northern Gaza - which was already the most isolated and heavily destroyed part of the territory - for nearly a month. It has ordered the complete evacuation of

Beit Lahiya, the nearby town of Beit Hanoun and the urban Jabaliya refugee camp, and has allowed almost no humanitarian aid into the area for over a month.

Tens of thousands of people have fled to nearby Gaza City in the latest wave of displacement in the war, which began when Hamas-led militants attacked southern Israel on Oct. 7, 2023.

That attack killed some 1,200 people, mostly civilians, and another 250 people were taken hostage. Around 100 captives are still inside Gaza, about a third of whom are believed to be dead.

Israel's retaliatory offensive has killed over 43,000 Palestinians, according to Gaza's Health Ministry, which does not distinguish between civilians and combatants in its toll but says over half of those killed were women and children. Around 90% of Gaza's population of 2.3 million people have been displaced, often multiple times. (AP)

India, Australia strategic partnership growing steadily: EAM Jaishankar

CANBERRA, Nov 5: External Affairs Minister S Jaishankar on Tuesday said that the comprehensive strategic partnership with Australia is growing steadily as he met his Australian counterpart Penny Wong for the 15th India-Australia Foreign Ministers' Framework Dialogue here.

Both the leaders also discussed "respective neighbourhoods, Indo-Pacific, West Asia, Ukraine and the global strategic scenario.'

"Concluded the 15th India - Australia Foreign Ministers' Framework Dialogue with FM @SenatorWong in Canberra today. Our Comprehensive Strategic Partnership is growing steadily. Reflected in stronger political ties, robust defence & security cooperation, expanded trade, greater mobility and deeper educational linkages," Jaishankar posted on X.

On Monday morning, the gov-

mediate precautions to protect themselves and their properties," the government said in a statement. Schools in Jamaica also were scheduled to close on Tuesday, with government offices closing

Canadian cop suspended for attending pro-Khalistan protest outside Hindu temple OTTAWA, Nov 5: A Canadian po-

lice officer has been suspended for participating in a pro-Khalistan protest outside the Hindu Sabha temple in Brampton, according to a media report.

On Sunday, protestors carrying Khalistani flags clashed with people at the Hindu temple and disrupted a consular event co-organised by the temple authorities and the Indian Consulate. There were unverified videos cir-

culating on social media about the protest. The videos appeared to show demonstrators holding banners in support of Khalistan, as reported by the Canadian Broadcasting Corporation. The Peel Police is "aware of a video circulating on social media which shows an off-duty Peel Police officer involved in a demonstration," said Media Relations Officer Richard Chin in an email to CBC News. "This officer has since been suspended in accordance with the Community Safety and Policing Act," he said.

"We are investigating the circumstances in totality depicted in the video and are unable to provide further information until such time that this investigation is complete.

Peel police previously said three people have been charged after violence erupted as Indian consular officials visited the Hindu Sabha Mandir temple Sunday.

Videos circulating on social media show demonstrators holding banners in support of Khalistan, the CBC report added.

Later in the day, demonstrators made their way to the Westwood Mall in neighbouring Mississauga, according to the World Sikh Organisation of Canada.

A short time after, a third protest was held outside the Malton gurdwara, a Sikh place of worship on Airport Road in Mississauga, the report added. "Although these demonstrations occurred at three different locations, they appear to be related to one another. Several incidents between protestors and worshippers broke out," police said in a news release.

India on Monday condemned the attack on the temple with an expectation that those indulging in violence "will be prosecuted".

In a statement, the Ministry of External Affairs said that New Delhi remains "deeply concerned" about the safety and security of Indian nationals in Canada.

"We condemn the acts of violence perpetrated by extremists and separatists at the Hindu Sabha Temple in Brampton, Ontario. We call on the government of Canada to ensure that all places of worship are protected from such attacks," MEA Spokesperson Randhir Jaiswal was quoted as saying in the statement. (PTI)



SC limits state power over private property Supreme Court rules private properties aren't community resources

NEW DELHI, Nov 5: In a significant verdict, the Supreme Court by a majority of 7:2 on Tuesday held all private properties cannot form part of "material resources of the community" empowering states to take them over for distribution to serve "common good" under the Constitution.

The judgement of the nine-judge Constitution bench headed by Chief Justice D Y Chandrachud provided clarity on the interpretation of Articles 31C and 39(b) of the Constitution, pivotal provisions concerning the rights of individuals against the state's authority to control resources for public good.


The majority ruling has significant implications for laws impacting property and resource distribution, particularly in Maharashtra, where ageing buildings pose severe safety hazards and their restoration was a major issue.

The vexed legal question, which was decided by the top court, was whether private properties can be considered "material resources of the community" under Article 39(b) and taken over by state authorities for distribution to subserve the "common good".

The CJI authored the 193-page majority judgement on behalf of six other judges -- Justices Hrishikesh Roy, J B Pardiwala, Manoi Misra, Raiesh Bindal, Satish Chandra Sharma, Augustine George Masih -- to decide the two

Also were on the nine-judge bench, Justice B V Nagarathna, who partially concurred with the majority view, and Justice Sudhanshu Dhulia, who dissented from the majority opinion.

The majority judgement did not agree with the view expressed by Justice Krishna Iyer in the case of Ranganatha Reddy of 1978 wherein it was held that private properties could be regarded as community resources.

The CJI, however, wrote "This court is unable to subscribe to the expansive view adopted in the minority judgement authored by Justice Krishna Iyer in Ranganatha Reddy and subsequently relied on by this court in Sanjeev Coke. Not every resource owned by an individual can be considered a 'material resource of the community' merely because it meets the qualifier of 'material needs'.

The majority view said the enquiry on whether a resource fell within the ambit of "material resource of community" must be based on the nature of the resource; the characteristics of the resource; the impact of the resource on the well-being of the community; the scarcity of the resource and the consequence of such a resource being concentrated in the hands of private players. "The public trust doctrine can

'The term 'distribution' has a wide connotation. The various forms of distribution which can be adopted by the state cannot be exhaustively detailed. However, it may include the vesting of the resources concerned in the state or nationalisation. In the specific case, the court must determine whether the distribution 'subserves the common good'," it said.

The top court, however, did not deal with the validity of Chapter VIII-A of the Maharashtra Housing and Area Development Authority (MHADA) Act which was inserted in 1986 to empower state authorities to acquire cessed buildings and the land on which those are built if 70 per cent of the occupants make such a request for restoration pur-

It left the issue of validity of the MHADA provision to be decided by a smaller bench in the light of present judgement.

The case stemmed from Mumbai, where many pre-1940 structures had become increasingly unsafe due to factors like age, overuse, and damage from environmental conditions.

Despite long-standing legislations, including the MHADA of 1976, which introduced mechanisms to repair and rebuild dilapidated buildings, the issue of structurally unsound housing contin-

A contentious part of the MHADA Act — Chapter VIII-A, allowing the acquisition of such buildings by cooperative societies of occupants — was challenged on constitutional grounds, leading to the present judgement.

The top court had heard 16 petitions.

Tulip is designed to address key challenges faced by artisans, particularly the involvement of intermediaries, by facilitating direct sales and ensuring fair compensation for their work, a senior official said.

He said the platform also promotes transparency and credibility through government backing, offering artisans a sustainable means

of income generation. Over 100 artisans and entrepreneurs from 16 states are participating in the Shilp Samagam Mela, showcasing a range of traditional prod-

ucts and skills. Tulip is expected to strengthen the reach of such artisans by connecting them with a broader online customer base.

Kumar announced plans to expand the initiative further, aiming to identify artisans in "every corner" of the country and link them to the digital marketplace.

Artisans interested in joining Tulip can register through the platform for more comprehensive access to new markets, while additional support is available through NBCFDC's helpline, he said.

The Shilp Samagam Mela will run from November 5 to 15 at Dilli Haat, INA, offering visitors a vibrant display of traditional handicrafts, skill demonstrations and an opportunity to support artisan communities directly. (PTI)

ED attaches land parcels in Chhattisgarh in PMLA case against insolvent UP firm

NEW DELHI, Nov 5: The Enforcement Directorate Tuesday said it has attached 73 hectares of agricultural land as part of a more than ₹ 7,300 crore bank loan "fraud" linked money laundering probe against a liquidated Kanpurbased company

A total of 86 land parcels measuring a combined 73.34 hectares and located in the Balodabazar-Bhatapara district of Chhattisgarh, worth ₹31.94 crore, belonging to Shri Lakshmi Cotsyn Limited have been frozen after a provisional order was issued under the Prevention of Money Laundering Act (PMLA), the federal agency said in a statement.

"All these properties are registered either in the name of the company or trusted employees and other gullible persons," it said.

The money laundering case stems from a 2021 CBI FIR filed against the company, its CMD Mata Prasad Agarwal, joint MD Pawan Kumar Agarwal, deputy MD Devesh Narain Gupta and director Sharda Agarwal.

The Central Bank of India. leader of the 23 banks consortium that lent money to the company, complained to the CBI that these entities, unknown public servants it said. (PTI)

and private persons "committed cheating, criminal breach of trust, criminal conspiracy, forgery, falsification of accounts and criminal misconduct for diversion and misappropriation of public money between 2010-2018"

Injured passengers say overcrowding, speeding might have caused U'khand bus accident

DEHRADUN. Nov 5: Overcrowding, speeding and technical faults were among the reasons that might have led to the bus accident in Almora, according to the illfated vehicle's surviving passengers, many of whom are undergoing treatment at different hospitals here.

The packed-beyond-capacity bus carrying passengers returning to work after Diwali fell into a deep gorge in Uttarakhand's Almora district on Monday, killing at least 36 of the more than 60 people on board.

Twenty-seven people were injured, four of them critically, when the 43-seater bus,

operated by the private Garhwal Motor Owners Union, was on its way from Pauri in Garhwal region to Ramnagar in Kumaon about 250 km away.

Karan, who is among the five being treated at the Ramdutt Joshi Hospital in Ramnagar, said, "There were 60-65 people in the 32-seater bus. We suddenly heard a sound that seemed like a tyre burst and the bus fell into the gorge.

"It was obviously overloaded. At least 20 passengers were standing in the bus since all the seats were occupied," he



Anil Sharma says he was asked not to include handpump scene in 'Gadar': They told me it would look fake

NEW DELHI, Nov 5: It would look fake, it's not convincing, how is this even possible? These were some of the comments that Anil Sharma encountered from people around him when the director decided to include the famous handpump scene in his 2001 blockbuster "Gadar: Ek Prem Katha"

Sharma, however, was convinced that it was a sure-shot whistle worthy moment that would draw crowds to watch the Sunny Deol and Ameesha Patel-starrer and he was proved right.

"No one was impressed when I told them about the handpump scene. They told me it would look fake. The shooting was on hold for two hours. The entire unit was not convinced, they said 'How is this even possible?' They said don't put a commercial scene in a picture as realistic as 'Gadar'," Sharma told PTI in an interview.

"Sometimes when you are very angry, you feel like destroying everything around you. We all have experienced that feeling. So, I thought let the character uproot the

handpump. And after all these years, people still talk about that scene," he added.

"Gadar", a post-Partition drama about an interfaith couple called Tara Singh and Sakina Ali, played by Deol and Patel, was declared a blockbuster and the handpump scene went on to become a pop culture phenomenon so much so that the director decided to give it hattip in his superhit follow-up "Gadar 2", which released in 2023.

Sharma, who hails from Mathura and often draws references from Hindu scriptures in his stories, said he envisioned "Gadar" as a tale from the Ramavana.

He also likened the handpump scene to the story where Lord Hanuman lifts an entire mountain when he is unable to identify the medicinal herb 'Sanjeevani' important to revive a critically injured Lakshman.

"Tara Singh may not be Hanuman ji but the emotion is the same. So, he can uproot a handpump. Many were not convinced about it till the release of the film. Those who

watch English films don't understand how people in our small towns think. They only worry about the public that lives in Bandra, Versova, and South Delhi," he

The filmmaker, who started his cinema journey at the age of 17 as an assistant to "Mahabharat" series creator BR Chopra and later directed films like "Bandhan Kuchchey Dhaagon Ka", "Hukumat", "Elaan-E-Jung", "The Hero: Love Story of a Spy", "Apne" and "Veer", said he wanted to make period film on Partition for a long time. Sharma found the right story when writer Shaktimaan Talwar gave him the script of "Gadar", in which a truck driver named Tara travels to Pakistan to bring his wife Sakina back to India post Partition.

"I told Shaktimaan ji that this story had the potential to become one of the biggest hits of the country. He asked me 'How?' I told him, 'This is Ramayana and in this story, Ram is going to bring back Sita'. In today's time, Lanka can be Pakistan. People may not understand

Ramayana but it is in their blood so they will automatically connect with the film," he recalled.

Investigators search offices of French soccer league, private equity firm CVC in corruption probe

PARIS, Nov 5: French investigators raided offices of the French soccer league and private equity firm CVC Capital Partners on Tuesday as part of an investigation into possible corruption and embezzlement related to an investment deal, a judicial official said. The searches took place amid an investigation that opened in July into charges of misappropriation of public funds, active and passive corruption of a public official and illegal taking of interest, the judicial official told The Associated Press.

The person with direct knowledge of the matter spoke on the condition of anonymity because they were not authorized to discuss an ongoing case publicly. Under its current president

Vincent Labrune, the French soccer league approved in 2022 an investment deal with CVC as part of a new commercial subsidiary in charge of marketing media rights. CVC invested 1.5 billion euros (USD 1.6 billion) in return for a 13% stake in the new commercial subsidiary managing TV rights, valuing the entire capital of the commercial subsidiary at 11.5 billion euros.

The CVC deal was sealed after French soccer came close to bankruptcy following the collapse of a major broadcast rights deal with Mediapro.

investigation launched after the French National Financial Prosecutor's Office received in November 2023 a complaint from a group called AC! Anticorruption.

Their lawsuit focused on a possible misappropriation of public funds when the French league's subsidiary company was created following the partial transfer of capital to CVC. The deal with Mediapro should have been worth more than 4 billion euros (USD 4.8 billion) over four years for the top two tiers but collapsed after only four months.

After its collapse, the league was forced to ask the government to set up a financial rescue plan amid huge revenue losses exacerbated by the coronavirus pandemic. Verstappen's Brazil victory silences critics and impresses rivals as he closes in on 4th F1 title



SAO PAULO, Nov 5: Max Verstappen's come-from-behind win in the pouring rain at the Brazilian Grand Prix didn't just put him a lot closer to a fourth straight Formula One title.

After 10 races without a win, it also reminded everyone of why the Dutch driver is a threetime champion in the first place.

Verstappen delivered one of the best performance of his career to move up from 17th at the start and clinch a victory that increased his lead over McLaren's Lando Norris from 44 to 62 points with just three grand prix races and a sprint race remain-

'Simply lovely," Verstappen summed it up on the team radio. His fellow drivers were more effusive.

"Amazing," said seven-time champion Lewis Hamilton of Mercedes.

"Incredible," gushed Ferrari's Charles Leclerc.
"Fantastic," added Aston

Martin's Fernando Alonso, a two-time F1 champion.

The only dissenting voice was Norris, who started on pole but finished sixth and later argued that the race was decided by luck as his team made a pit stop just before a red flag came out. "He drove well, he got a bit lucky," Norris said.

"You take a gamble, and it has paid off for them. It is not talent; it is just luck.'

With only 86 points up for grabs until the end of the seafinish ahead of Norris in Las friend Kelly and the main rival

The Red Bull driver had expected a tough weekend at Interlagos. He received a five-place grid penalty after changing his engine for the sixth time in the season; lost one point in Saturday's sprint and got unlucky during qualifying when the session was interrupted just as he was attempting to clock a fast lap, leaving him in 12th place.

But then everything went right for him in the race.

He surged past rivals at the start and had passed a handful of cars before the first lap was

where visibility was hindered by the constant spray of water from the cars in front, Verstappen kept overtaking car after car and ended up finishing almost 20 seconds ahead of second-placed Esteban Ocon of Alpine.

"It was definitely an emotional win," Verstappen said. "I was really motivated and put everything into this race and I surprised myself today as I wasn't expecting to finish in P1."

"(Verstappen) silenced a few critics today," said former F1 champion Damon Hill, who himself was one of those critics.

"I have a quick question here. appreciate all of you being here, but I don't see any British press," Verstappen said, drawing laughter. "Do they have to run to the airport, or they don't know where the press confer-

Fans at Interlagos were also impressed by the Dutch driver's performance.

A decision on the host will not be taken before the IOC elections next year and India will also have to face competition from several other nations like Saudi Arabia, Qatar and Turkey, who are positioning themselves as strong contenders to host the sporting spectacle.

However, with the submission of a 'Letter of Intent', the nation has progressed from "Informal Dialogue" to the "Continuous Dialogue" stage of the host election

In this stage, the IOC conducts a "feasibility study" of the progress of projects associated with the Games in the potential host.

"As part of the Feasibility Assessment, independent sources in a wide-ranging number of areas are taken into consideration, including in human rights, through Business for Social Responsibility (BSR), and sustainability, through the In-

ternational Union for Conservation of Nature (IUCN)," the IOC states on its official website

The next phase of the process would be "Targetted Dialogue", which would require the submission of an edition-specific formal bid, which would be assessed by the Future Host Commission.

The process would finally end with a host election.

India's plan has been backed by current IOC head Thomas Bach. The last time India hosted an international multi-sport extravaganza was the 2010 Commonwealth Games here.

But for the 2036 Olympics, Ahmedabad is being seen as a front-runner to be the host city.

India's top sports administrators, including IOA President PT Usha, were at the Paris Olympics earlier this year to lobby for the country. It is also learnt that India would be pushing for the inclusion of indigenous disciplines like yoga, kho kho and kabaddi if the bid is success-

The Sports Authority of India's Mission Olympic Cell (MOC) has even presented a detailed report on the measures needed for a successful bid to new sports minister Mansukh Mandaviya.

In this document, MOC has identified six disciplines, including yoga, kho kho, kabaddi, chess, T20 cricket and squash for inclusion in the Games if the country gets to host the quadrennial extravaganza.

PGA Tour has big changes on horizon; what doesn't change is players having to earn it: Analysis

FRISCO, TEXAS (USA), Nov competitive level of the game go **5:** The reason behind such a big change to PGA Tour eligibility is not much different from what it was some 40 years ago. Both were about trying to make the tour more competitive and to give real value to having a card.

Of course, it involved money, too. That never changes. The PGA Tour board later this month will vote on whether to reduce the number of fully exempt players from 125 to 100, along with cutting from 30 to 20 the tour cards awarded to top finishers on the Korn Ferry Tour.

It sounds even more cutthroat than golf already is, especially since it was in 1983 when the PGA Tour went the other direc-

It used to be only the top 60 on the money list the previous year were exempt from qualifying for PGA Tour events. That changed to the top 125 in what became known as the all-exempt tour. Anyone who had a tour card could expect to tee it up just about wherever he wanted, instead of having to qualify every Monday.

Those who didn't make it through qualifying put their clubs in the trunk and headed to the next stop. Back then, getting a PGA Tour card was the easy part.

So, the change wasn't about the rich getting richer. It was having a reasonable chance to make a good living.

Really, when you get down to it, there aren't very many of us who make any money out here," the late Tom Weiskopf said at the start of the 1982 season.

Craig Stadler wound up leading the money list that year with USD 4,46,462. Only 37 players topped USD 1,00,000 in earn-

"The all-exempt tour will give more people a chance to play more tournaments," Weiskopf said. "There will be more people making money and, with 150 players able to play any time they want to, you're going to see the

That's the idea behind the proposal the PGA Tour board is considering — and is likely to approve — when it meets in two

With such a bloated membership, having a tour card often meant waiting until there was room to play. The regular season is three months shorter, so there is more urgency to play.

There is still the concept of meritocracy. Justin Thomas went from winning a major in 2022 to failing to qualify for the postseason in 2023.

Matt McCarty started this year on the Korn Ferry Tour, won three times for an instant promotion and then won the Black Desert Championship in Utah to earn a two-year exemption and a spot in three majors next year. It's not going to be easy, nor is it sup-

posed to be. There's an advantage for players who finished in the top 50 a perk for success is another way to look at it — because they are guaranteed spots in all the signature events with a USD 20 million purse and elevated FedEx Cup points. The answer, of course, is to play better. It's a phrase no one likes to hear because it's true.

BELGRADE (SERBIA), Nov 5: Novak Djokovic won't defend his ATP Finals title after ruling himself out on Tuesday due to an unspecified injury.

Djokovic wrote in an Instagram story, "I was really looking forward to being there, but due to ongoing injury I won't be playing next week. Apologies to those who were planning to see me.'

The year-end, eight-man ATP Finals open in Turin, Italy, on Sunday. He's won it a record seven times. Last year, he beat current No. 1 Jake Sinner in the final. "Wishing all the players a great tournament" Djokovic added: "See you soon!"

Djokovic finishes the year with a 37-9 win-loss record highlighted by winning his first Olympic gold medal in Paris. That was his 99th tour-level title.

He didn't add to his men's record 24 Grand Slam titles this year, and after bowing out of the US Open third round, he played only a Davis Cup match and reached the final of the Shanghai Masters last month, losing to Sinner. He then withdrew injured from the Paris Mas-

Agni Chopra's dream: Playing Ranji Elite division after big start with Mizoram in Plate League

MUMBAI, Nov 5: Currently, Agni Chopra's First-Class average stands at a box office 99.06 and it has attracted as much, may be even more, attention as some of the biggest Bollywood chartbusters his father has produced.

In only nine games since his debut in the Ranji Trophy Plate league for Mizoram earlier this year, Agni, son of Bollywood filmmaker Vidhu Vinod Chopra and film critic Anupama Chopra, has garnered 1585 runs with eight hundreds and four The beginning of this filmy sequence started in

January this year when he debuted with a 166 against Sikkim at Nadiad, and from there on Agni has not stopped scoring runs in tons, literally.

This season the 26-year-old left-hander has started from where he left and has already scored 218 and 238 against Arunachal and Manipur.

So, what is the secret of his run rush? "It's all about hunger, right?" Agni told PTI in an exclusive interview. "Before this season started, I discussed it with

my coach Khushpreet (Singh). The only thing he told me was, 'forget about the runs, you just have to focus on one thing — don't get out'. "So I've not thought about anything else. My second goal was to score double hundreds because

last year I didn't score a single double hundred,"

said Agni, adding that specific work on his fitness

has also helped him pile up big scores. His domination of bowlers, which has seen his average touching Bradmanesque-levels, has come in the Plate League so far, and Agni nourishes the dream of getting into Elite League with Mizoram.



"I don't think too far into the future. Of course, in terms of the larger picture, I would love to be picked in the Duleep Trophy, or India A, to play in the IPL, to hopefully, one day, represent India," he said. "For me what works best is (when) I always focus on the next game. I don't even think about the second game. I only think about what's next because in order to play for India, I have to do well in the next game.

But for it, Agni knows that, he will have to play

in the Elite segment of the Ranji Trophy. "I would love to represent an Elite division team, then maybe play for IPL and India. But to do those things, I have to play well at the level I'm playing right now and to do that, I also have to score runs in the next game. So, I genuinely think about only the next game," he said

Agni realises that he has to shoulder a major share of responsibility of carrying Mizoram into the Elite round.

"Our Mizoram team's collective goal is to qualif y for the Elite division. The goal is for us to finish on top and qualify... then I'll be able to play in the Elite division against the top level of bowlers," he

"Even last year, that was our goal but unfortunately, we fell short. We lost in the semifinals; we were one game away. If we had won, we would have qualified and I would have been playing there this year itself," he continued.

"That's what I think my personal and team-wise

For cricketers, on-field success and scrutiny go hand in hand and more so in case of those who have famous parents.

Agni has a simple way of tackling the situation. "I just think it is funny. I genuinely don't even take it seriously. There is my circle of people whose opinions I value and whose opinions I trust," he said.

"Off the field, (it) is my parents and my sister. Anything related to off the field, I'll defer to them. They don't give me advice about cricket too much. I mean, I don't tell my dad how to make movies and he doesn't tell me how to play cricket," he

"Khushpreet Singh, my coach, is my number one guy on and off the field. Shubman (Gill) is a close friend and with him, also on the field and off the field, we have discussions," he said.

Agni had to endure disappointment during last year's IPL auction, but he hopes for better tidings in the upcoming mega auction.

"Everybody wants to be a part of that, play in the IPL. A lot of the work that I have put in is with that in mind as well and that's a big motivating factor is to play in the IPL," said Agni, who idolises Yuvraj Singh and Brian Lara. (PTI)
