Adani, India's second-richest man, has been charged with bribery and securities fraud in two separate cases brought by US authorities -- a criminal indictment by the US Department of Justice in a New York court that charges him and seven others including his nephew Sagar with paying bribes to unidentified officials of state governments like those in Andhra Pradesh to buy expensive solar power, potentially earn more than USD 2 billion profit

Additionally, a Club House will be built for recreation and events.


The foundation stone for the project was laid at the KAAC Colony, with MP Amarsing Tisso—who is also the EM of KAAC, responsible

MUMBAI, Nov 21: Equity benchmark indices Sensex and Nifty tumbled on Thursday amid a sharp fall in Adani group stocks after billionaire industrialist Gautam Adani was charged in the US for alleged bribery and fraud.

Besides, relentless foreign fund outflows and weak trends in Asian and European peers also dragged benchmark indices lower.

The BSE benchmark Sensex tanked 422.59 points or 0.54 per cent to settle at 77,155.79. During the day, it lost 775.65 points or 0.99 per cent to 76,802.73. As many as 2,736 stocks declined, while 1,237 ad-

vanced and 92 remained unchanged on the BSE. The NSE Nifty slumped 168.60 points or 0.72 per

"The domestic market faced renewed pressure due to escalating tensions in the Russia-Ukraine conflict and heightened nuclear concerns. Additionally, the fresh Adani case with the US DoJ added to the mar-

"Although there were signs of a slowdown in FII selling, it surged again, adversely affecting market sentiment, particularly financials sector. We expect an improvement in the trend when global & domestic political issues stabilise," Vinod Nair, Head of Research,

Gautam and Sagar Adani are accused of persuading investors to buy their company's bonds by misrepresenting "not only that Adani Green had a robust anti-bribery compliance programme but also that the company's senior management had not and would not pay or promise to pay bribes"

Adani, chairman of the ports-to-energy Adani Group, his nephew Sagar R Adani, who is an executive director at the conglomerate's renewable energy arm Adani Green Energy Ltd, and its former CEO Vneet Jaain were charged with securities fraud, securities fraud conspiracy and wire fraud conspiracy. The Adanis were also charged in a US Securities and Exchange Commission (SEC) civil case. The five-count indictment also accuses Sagar and Jaain of breaking federal laws.

The US authorities also charged three former employees of a large Canadian pension fund, CDPQ, in connection with the alleged scheme, saying they obstructed an investigation into the bribes by deleting emails and agreeing to provide false information to the US government. CDPQ, which invests in infrastructure projects, is a shareholder

The indictment may throw the conglomerate again in turmoil just as it rebounded from US short seller Hindenburg Reseach's damning fraud allegations. Hindenburg's allegations of "brazen stock manipulation and accounting fraud" in January 2023 had led to the conglomerate seeing a USD 150 billion wipeout in market value at its lowest point. The group stocks have since recovered most of the losses. Adani Group had denied all allegations made by

Asked about some states ruled by non-BJP parties being named by the US prosecutors, he said, "Wherever this has happened, be it any government, there should be an investigation. But the one involved in the corruption should be jailed." (PTI)

This option doesn't factor in Article 9 of the Paris Agreement, which mandates developed nations to provide financial support. This means asking some wealthier, high-emitting developing nations to contribute to climate finance. Their second view factors in Article 9 and calls for a goal that collectively mobilises an amount greater than USD 100 billion per annum by 2035 for developing countries from a wide range of sources and instruments, including public and private. be punished following an August ruling by US District Judge Amit Mehta that branded the company as a monopolist.

The Justice Department decision-makers who will inherit the case after President-elect Donald Trump takes office next year might not be as strident. The Washington, DC court hearings on Google's punishment are scheduled to begin in April and Mehta is aiming to issue his final decision before Labour Day. If Mehta embraces the government's recommendations, Google would be forced to sell its 16-year-old Chrome browser within six months of the final ruling. But the company certainly would appeal any punishment, potentially prolonging a legal tussle that has dragged on for

more than four years

Besides seeking a Chrome spinoff and a corralling of the Android software, the Justice Department wants the judge to ban Google from forging multibillion-dollar deals to lock in its dominant search engine as the default option on Apple's iPhone and other devices. It would also ban Google from favouring its own services, such as YouTube or its recently-launched artificial intelligence platform, Gemini. Regulators also want Google to license the search index data it collects from people's queries to its rivals, giving them a better chance at competing with the tech giant. On the commercial side of its search engine, Google would be required to provide more transparency into how it sets the prices that advertisers pay to be listed near the top of some targeted search results.



#### Change in pricing mechanism needed

entre and State governments in India are in need of raising both tax and non-tax revenue, dismantling the administered pricing mechanism, reducing subsidies, and reorienting expenditure toward national and state-level priorities. This is essential to ensure India remains on a sustainable fiscal path with higher growth, given the high public debt at the Centre and state level. It is the conclusion of a recent IMF working paper titled "Growth Convergence and Public Finances of India and its States" prepared by the authors Rajan Govil and Khyati Chauhan. Additionally, the paper says that there is a lack of convergence in per capita income across Indian states which requires greater resources for lower-income states for investment and improved public services. The observed wide differences in fiscal parameters across states require a tailored policy for each state. The large stock of debt of several states puts at risk the adequate financing of growth-enhancing expenditures. The paper notes that overall general government revenue has been stagnant over the last three decades at a low of 20% of GDP leading to inadequate availability of resources for development and investment purposes. Expenditure at 30% of GDP has meant a large fiscal deficit of 9.5% of GDP and a public debt of 82% of GDP in FY2023, leaving only some fiscal space.

Indian states combined account for around 60% of total general government (central and states) expenditures amounting to about 18% of GDP in FY2023. The majority of capital expenditure is undertaken at the state level although the gap has narrowed in recent years as some capital expenditure undertaken by state-owned enterprises has been brought on to the central government budget. Fiscal developments at the state level therefore have a substantial bearing on economic developments in each of the states as well as the country as a whole. We find that several of the lower income states have built up a high debt/GDP ratio, leading to their limited ability to increase expenditure on development and investment, the authors said, adding that fiscal consolidation is needed although this may come at the cost of slower economic growth. In addition to the redistribution of revenue through the Finance Commission Awards, the central government has deployed additional schemes, such as the Central Sector Scheme and the Centrally Sponsored Schemes, to support states' development needs, and has recently provided interest-free loans to support states' public investment. Still, we find that states with low per capita income have little fiscal space as they are running large fiscal deficits to meet their capital expenditure requirements and have built up large outstanding liabilities that need to be reduced. Interest expenditure on general government borrowings is high at 5% of GDP or about 25% of total revenues, restricting availability of resources for development and investment purposes. While the fiscal deficit was higher in FY2023 by 3.1% of GDP compared with FY2019 and mainly driven by higher expenditure, the consolidated public debt increased by 12% of GDP during this period to 82% of GDP in FY2023. The states' share in total taxes collected by the central government have however declined from 4% of GDP in FY2019 before the pandemic to 3.5% of GDP in FY2023, while the central government's share has increased during this period from about 7% of GDP to 7.7% of GDP. This decline in the states share mainly reflects an increase in non-shareable cesses and surcharges.

Moreover, the pandemic has exacerbated the situation, with lockdown measures trapping many victims in abusive environments. Reports indicate a surge in domestic violence incidents during the COVID-19 lockdown, highlighting the urgent need for resources and support systems.

Women who were already vulnerable found themselves isolated from their support networks, leading to an increase in violence and a decrease in access to essential services such as healthcare, legal assistance, and counseling.

The pandemic has underscored the urgent need for a multifaceted response to domestic violence that includes prevention, protection, and rehabilitation.

Addressing domestic violence in Assam requires a comprehensive approach that encompasses legal reform, community awareness, and support services.

First and foremost, there is a critical need for effective implementation of existing laws and policies. This includes training law enforcement officials, legal practitioners, and healthcare providers to sensitively handle cases of domestic violence. Creating a supportive environ-

## Assam's scheduled tribes list

he longstanding demand to expand the Scheduled Tribes (ST) list in Assam has once again emerged as a contentious issue, threatening to destabilize the delicate social fabric of the state. At the heart of the debate lies the demand for ST status by six communities - Morans, Mataks, Koch-Rajbongshis, Tai-Chutias. Ahoms. Adivasis/Tea Tribes - against the apprehensions of existing ST groups, who fear that such an expansion might dilute their privileges, benefits, and political influence. The complexity of this issue underscores the challenges

of reconciling competing aspira-

tions within a diverse and ethni-

cally sensitive society like Assam.

Efforts to include the six communities in the ST list have been ongoing for decades, but the introduction of The Constitution (Scheduled Tribes) Order (Amendment) Bill, 2019, in the Rajya Sabha reignited hopes and fears in equal measure. For the six communities, the bill symbolized a long-overdue recognition of their historical and cultural identity, as well as access to benefits such as job and educational reservations. Conversely, for the existing ST groups, it signaled potential threats to their political power and access to resources. This dichotomy has entrenched the issue further, making it a litmus test for Assam's socio-political harmony.

The Administrative Framework and Its Challenges: The process of altering the ST list is far from straightforward. According to established modalities, any proposal for inclusion or exclusion must first be recommended by the state government, complete with detailed ethnographic justification. It must then secure the concurrence of the Registrar General of India and the National Commission for Scheduled Tribes before it can be legislated.

While the Assam government has held consultations with stakeholders, the conditions put forth by existing ST groups - primarily to safeguard their privileges have only added layers of complexity to an already fraught process.

One of the more potent arguments advanced by proponents of

expansion is the potential to safeguard the political supremacy of Assam's indigenous population. proponents argue, the dominance of indigenous communities can be solidified, countering fears of political marginalization due to demographic changes fueled by

migration and population growth. Political Aspirations and **Fault Lines:** However, the issue is far more nuanced than a simple question of reservation benefits. For the existing ST groups, the apprehensions are rooted in the fear of losing their political power, particularly in governance structures like autonomous councils, where seats are reserved for STs rather than specific communities. Granting ST status to new groups would enable these communities to contest and potentially dominate elections in these councils, altering the balance of

The political undercurrents are further intensified by electoral dynamics.

The ruling coalition's promises of expanding the ST list, especially in the run-up to elections, have raised expectations among the six communities while simultaneously fueling agitation. The lessons here are profound: making poll promises on sensitive ethnic issues without considering their complexities risks exposing permanent societal fault lines. The recent surge in protests underscores the fragility of the situation and the urgency of finding a sustainable solution.

Inclusive Development as a **Pathway:** While the expansion of the ST list remains a contentious issue, it also highlights the broader challenge of fostering inclusive growth in Assam. Addressing socio-economic disparities through large-scale development initiatives could provide an alternative pathway to resolving ethnic tensions.

By investing in higher education, healthcare, skill-building, rural development, and women's empowerment, the government could create opportunities that transcend ethnic divides.

Such an approach would not only enhance the quality of life for all communities but also reduce the zero-sum perception of resource allocation. If every com-

munity feels included in the benefits of growth, the apprehensions of one group losing out to another By increasing the number of re-could be mitigated. This could, in served seats in the state assembly, turn, pave the way for dialogue on the sharing of political power. shifting the narrative from competition to collaboration.

The Importance of Dialogue and Unity: Ultimately, resolving this issue will require a carefully calibrated approach that balances the aspirations of the six communities with the concerns of existing ST groups. A critical first step would be fostering dialogue between these groups, rather than conducting separate negotiations. A unified discussion table could help build trust and consensus, allowing both sides to explore common ground on political power-sharing and resource distribution.

The role of organizations representing these communities cannot be overstated. By promoting an ethos of cooperation rather than confrontation, these groups can help create a conducive atmosphere for negotiations. Strengthening the combined electoral strength of indigenous communities, for instance, could offset the influence of immigrant populations without exacerbating intraindigenous tensions.

The expansion of the Scheduled Tribes list in Assam is not merely an administrative decision; it is a question of identity, equity, and survival for multiple communities. Mismanagement of this issue could deepen ethnic fault lines, making peace in the state an elusive goal.

At the same time, addressing the aspirations of the six communities without alienating existing ST groups is a formidable challenge that requires innovative and inclusive solutions.

The Assam government must tread carefully, ensuring that its actions are guided by the principles of justice, inclusivity, and long-term stability. By prioritizing dialogue, fostering inclusive development, and addressing the root causes of ethnic tensions, the state can move closer to resolving this vexed issue. The stakes are high, but so is the opportunity to set a precedent for harmonious coexistence in a diverse and dvnamic society. (The writer can be reached

## Which Hindus do Hindu Supremacists represent in the US?

n September 2022, the Hindu American Foundation (HAF) filed a lawsuit against the California Civil Rights Department (CRD) in a US federal court. Ongoing for over two years, the case is scheduled for its next and possibly final hearing on December 3. Unlike the Cisco case, this lawsuit has received limited media coverage in India and the US. This case not only connects to the Cisco lawsuit but also challenges the CRD's legal authority to pursue caste discrimination cases.

#### The Cisco case

In June 2020, the CRD filed a lawsuit against Cisco Systems, alleging caste discrimination faced by a Dalit employee and later moved the superior court of California, Santa Clara.

Since this was a first-of-its-kind case in the US, where courts are unfamiliar with caste-based discrimination and lack precedents, the CRD clarified about caste in its filing, "As a strict Hindu social and religious hierarchy, India's caste system defines a person's status based on... the caste into which they are born – and will remain until death. At the bottom of the Indian hierarchy is the Dalit... who were traditionally subject to 'untouchability' practices which segregated them by social custom and legal mandate.'

This single reference to Hinduism in the complaint serves as a contextual explanation rather than an exhaustive analysis of caste and its origins. In January 2021, the HAF filed a motion to intervene in the Cisco case on three main grounds.

First, the department's linking of caste with Hinduism could lead employers to avoid hiring Hindus, fearing potential legal issues. Second, employees may object to reporting to or working alongside colleagues of different castes, burdening employers. Third, employers may feel compelled to inquire about South Asian employees' religion, violating employees' religious freedom, protected under the First Amendment, by pressuring them to disclose their beliefs.

The HAF sought to intervene in the case on behalf of all Hindus in the US, arguing on the basis of utopian tenets - truth, non-injury, compassion, equanimity, generosity and equal regard to honour the divine in all – rather than on evidence.

In March 2021, the court put the HAF's intervention on hold since the Cisco case had undergone a stay in hearings, as the defendants appealed for direct arbitration with the victim, thereby removing the CRD from the case. It is important to note that in the Cisco case, the victim did not file the complaint; the CRD filed it on the victim's behalf. In August 2022, the appellate court rejected arbitration in the Cisco case and ruled in favour of the CRD and hearings re-

#### HAF's legal battles with CRD

In September 2022, the HAF filed a new lawsuit against the CRD in a California district court on similar grounds as it filed in the superior court. After nearly a year of hearings, in August 2023, the federal court dismissed HAF's lawsuit on two grounds. First, the HAF cannot represent all Hindus in the US and thus lacks binding authority. Second,

the CRD's efforts to end caste-based discrimination would not prevent or burden Hindu Americans from practicing their religion. However, the court allowed the HAF the opportunity to amend its filing to address the

binding authority issue. After the HAF went down in flames in federal court in the first round, it continued to intervene in the Cisco case at the Santa Clara superior court, resulting in two parallel hearings: one in federal court, where the HAF sued the CRD over its caste discrimination case and another in superior court, where the HAF sought to intervene in the ongoing Cisco litigation

In September 2023, the HAF filed a First Amended Complaint (FAC) along with HAF-affiliated and a few non-affiliated individuals, including three anonymous ones, rather than directly sue the department. Two former defendants in the Cisco caste discrimination case, who were dismissed in April 2023, had also

In January 2024, the Santa Clara superior court dismissed the HAF's concluding that intervention, "HAF's complaint does not allege any facts showing that CRD coerced anyone into doing something inimical to their religious convictions or otherwise prevented them from being able to practice their religion." The court further clarified, "The point of the lawsuit is to prevent discrimination at Cisco based on caste. It is hard to see how such a case. even though it wrongfully ascribes the caste system to Hinduism, would result in the inability of Hindus to freely practice their religion."

In May 2024, in the federal case, the CRD challenged the plaintiffs' use of pseudonyms, arguing that they were not legally justified. In August 2024, the court ruled in favour of the CRD, denying the plaintiffs' request to continue under pseudonyms. Following this, the HAF filed the Second Amended Complaint (SAC) in August 2024, including the names of two plaintiffs and removing the third from the list of previously anonymous plaintiffs.

The amended complaint reiterates arguments from the original filing, asserting that the CRD's linkage of caste to Hinduism in the Cisco case violates Hindus' religious rights. The complaint also cites personal injuries suffered by the plaintiffs, including reputational harm, anxiety and sleeplessness resulting from the Cisco case. While there were only minor differences between the FAC and the SAC, it would soon become clear how, under the guise of protecting religious freedom, the HAF employs sophistry to obstruct justice for the victim in the Cisco case.

The CRD's response asserts three main points. First, it contends that addressing caste-based discrimination is within its constitutional duty to enforce civil rights protections. Second, the CRD argues that the HAF's claims of denial of opportunity, reputational harm and psychological impacts are speculative. lacking the concrete injury required for standing. Furthermore, it asserts that the HAF's allegations of diverted resources do not constitute significant injury to establish organisational standing. Lastly, the CRD holds that the HAF's claims under the free exercise, establishment, due process and equal protection clauses are generalised grievances without legal foundation.

#### HAF's contradictory stance on

caste in Hinduism Fourteen years ago, in December 2010, the HAF released a policy document titled Hinduism: Not Cast in Caste, stating: "Hindus must acknowledge that caste arose in Hindu society, that some Hindu texts and traditions justify a birth-based hierarchy and caste bias, and that it has survived despite considerable Hindu attempts to curtail it." This document drew strong backlash from Hindus, who argued it infringed on their religious freedom and sentiments, questioning the HAF's authority to speak on Hinduism and insisting that all Smritis are integral to the religion. Rather than defend its stance, the HAF removed the document from its website.

Linking the HAF's stance on the Cisco case with legal protections against caste-based discrimination will help us understand how Hindu supremacists have sought to keep oppressed castes under the dominance of upper castes by opposing legal protections. Hindu supremacists always argue that caste redress is "reverse discrimination", as seen in their opposition to SB 403, which seeks to include caste as a protected category. In the Cisco case, the HAF contended that caste discrimination is not barred, yet they label SB 403 as portraying South Asians as "bigots, bullies, rapists, human traffickers, even murderers" to justify an alleged attack on their rights. The original page was later removed.

The message is clear: Hindu supremacists deny that caste discrimination is prohibited under current laws while fiercely opposing any new legislation protecting against it, deploying extensive resources. Their aim is to keep the caste-oppressed dependent on the mercy of dominant castes rather than ensuring civil rights and human rights protections.

The HAF asserts it represents all Hindus in California, yet the CRD challenges this, noting Hinduism's diversity and that a victim of caste discrimination in the Cisco case is also Hindu. The CRD argues, "At least some Hindu Americans residing in California... may have interests that conflict with HAF's purpose in this lawsuit as they may stand to benefit from the Department's efforts to prevent and redress... caste discrimination.'

Mihir Meghani, a co-founder of the HAF, claims to experienced stigma and anxiety over caste-related remarks. It is notable, however. that as a physician, he overlooks the documented impact of caste on healthcare access, as highlighted by the National Library of Medicine (NLM), a federal arm of the US health department. In May 2021, the NLM published a paper, Caste Exclusion and Health Discrimination in South Asia: A Systematic Review, which examines caste-based inequalities in healthcare access across

South Asia. The paper explains, "The 3000year-old caste system is one of the oldest social hierarchies and it forms the foundation of Hindu society. This system includes four divisions: 'Brahmins', priests; 'Kshetriyas'. warriors; 'Vaishyas', merchants; and 'Sudras', servants. Underneath these castes lies 'Ati-Sudra', Dalits, also known as untouchables." Such infor-

mation, rather than causing stigma, should foster greater understanding and encourage efforts to address these inequalities.

In April 2023, the CRD dismissed both Sundar Iyer and Ramana Kompella from the Cisco case and, in December 2023, removed references that linked caste to Hinduism. Despite this, the lawsuit continues because the plaintiffs claim they "suffered deep mental, psychological and spiritual injury" due to the initial association of caste with Hinduism in the case. There is a dedicated matrimonial site in the US specifically for brahmins, the uppercaste Hindus, where many brahmins "prefer" matches within their own caste. Hindu temples openly advertise ceremonies such as the upanayanam, described as the rite where young brahmin boys are invested with the sacred thread and initiated into the Gayatri mantra, for

Don't such practices cause the plaintiffs or organisations like the HAF "deep mental and psychological injury"? If so, why aren't these sites and ceremonies challenged, let alone subject to similar lawsuits? The HAF's federal case is a veiled attempt to derail the Cisco case through speculative and implausible claims of religious violation. Its argument of religious freedom infringement serves as a smokescreen to obstruct legal remedies and protections for the caste-oppressed, both in the Cisco case and more

broadly This is not the first time that protections against caste discrimination have been challenged in court; there are established legal precedents on this issue. In October 2022, two California State University (CSU) professors filed a lawsuit against the CSU for including caste in its antidiscrimination policy, arguing it violated religious freedom and due process. In November 2023, a federal court dismissed the claim that the policy stigmatises Hindu practitioners, noting that the plaintiffs' alleged injuries were conjectural or hypothetical

În February 2023, the Seattle city council in Washington state passed a law adding caste as a protected category, which was then challenged in May 2023 as unconstitutional on similar grounds. However, in March 2024, a court upheld the law, emphasising that its purpose was to strengthen anti-discrimination protections without violating religious freedom.

In each case, the state has defended the rights of those oppressed by caste. Dominant caste individuals and organisations often have the resources to oppose protections for the caste-oppressed, even though caste is a reality in the US, affecting various spheres from work places to community organisations and from dating apps to housing. Only a federal law can truly protect the casteoppressed from discrimination manifesting as exclusion and denial of opportunity, beyond efforts at the university, city and corporate levels. Against this backdrop, the December 3 hearing and its outcome will be pivotal. It could not only clarify the path forward in the Cisco caste discrimination case, but also influence public opinion in favour of broader federal legislation against caste discrimination. ## Securely operationalising IMEC and PGII: Peace-progress-prosperity from Space

The India-Middle-East Europe Economic Corridor (IMEC) and the Partnership for Global Infrastructure and Investment (PGII), which were announced in September 2023 during the Group of 20 (G20) Summit in New Delhi, met with its first major challenge—the October 2023 Hamas terror attacks in Israel. Several experts have expressed that IMEC is farfetched given the active geopolitical hotspots in the region. However, not many of these analyses attempt to suggest solutions to ensure the security of IMEC, which is crucial for its immediate and distant beneficiaries. The security of IMEC will ensure peace and shared prosperity, which will have immediate implications for the PGII. The innovative application of downstream space technologies and services—be it Earth observation, satellite communications or positioning, navigation, and timing systems could make IMEC more secure and

Any trade network in the modern world can only be successfully operationalised with tools that provide the necessary spacebased backbone to command, control, communications, computers, intelligence, surveillance and reconnaissance (C4ISR). When the Belt and Road Initiative (BRI) was conceptualised, the Chinese government wisely recognised the need for space support in its corridors. However, the Space Silk Road, the orbital element of the BRI, was wholly led by Chinese space assets, leaving no room for the trusteeship and partnership of BRI partner countries. The IMEC, on the other hand, is not a singlecountry-led corridor. IMEC has eight founding partners— Saudi Arabia, the European Union, India, the United Arab Emirates (UAE), France, Germany, Italy, and the United States—with nearly all except Jordan pursuing advanced space capabilities. The IMEC can bring together mature space technologies and services from commercial space entities, nurtured by all founding and potential IMEC partners, with an international Space-IMEC Industrial Consortium. The combination of commercial and strategic interests will set such an international consortium apart from what was proposed by China with its domineering Space Silk

Secure logistics and supply chain management are crucial cornerstones of the Indian economy in particular, and the global economy in general. A dedicated set of orbital satellites that ensure the secure movement of traded goods at ports and along road, rail and maritime routes, are essential. Satellite communication, Positioning Navigation and Timing (PNT), and remote sensing are already integral to global trade and shipping. These space-based technologies and their services have greatly assisted in the real-time tracking of traded goods and containers, helped in optimising routes by forecasting the weather to mitigate risks, and improved inventory management. Satellite communications networks have helped with seamless coordination and facilitated advanced geospatial analysis for supply chain management, enhancing efficiency and reducing costs across industries.

A recent report by Novaspace, a spacetech consulting firm formed by the merger of SpaceTec Partners and Euroconsult, has forecasted that non-geostationary orbit usage for maritime communications will grow from almost 40.600 vessels in 2023 to 90,000 vessels in 2033. This growth is expected to be further propelled by the creation of new maritime trade corridors, including IMEC, the International North-South Transport Corridor, the Chennai-

Road Initiative. According to the global container shipping giant, Hapag-Lloyd, the global smart container market, which aims to connect every container transported in the world through the internet-of-things (IoT), is expected to grow, with 25 percent of all containers in the world being connected to some IoT device by 2026. Additionally, satellite-connected smart containers are also geared to bring down the carbon footprint of the shipping industry, a big plus for the IMEC, making it environmentally sustainable. Connecting ships and containers even in non-trackable seas, as is the present case. will also ensure that traded goods are not subject to tampering, accidents, damages, cargo thefts, and the smuggling of illicit and

Among the IMEC members, India, the EU and the US have their respective PNT systems-Navigation with Indian Constellation (NAVIC), Galileo and the Global Positioning System (GPS). For IMEC to remain operational for a long time, resilient PNT systems and redundancies will be essential. To that end, the three systems could be made interoperable along the corridors. In the 2020 National Defense Authorization Act, the US Congress formally acknowledged NAVIC as an "allied system" for the GPS along with Japan's Quasi-Zenith Satellite System (QZSS) and EU's Galileo. This recognition only enables strong PNT support for the IMEC corridor. IMEC members devoid of their own PNT, especially UAE, Saudi Arabia, and Jordan, can rely on NAVIC's excellent coverage of their geographies. This would positively enable road logistics companies, UAE's Etihad Rail, the Saudi Arabian Railways, and the proposed Gulf Cooperation Council Railway to efficiently, securely, and sustainably carry out land-mode trade along the IMEC corridor.

IMEC, even if the Eastern Corridor is activated before the resolution of the conflict in the Middle East, would have dimensions that go beyond container trade. The corridor envisions connectivity and collaboration through renewable energy grids, free trade zones, hydrogen pipelines, interconnected underwater cables, integrated digital finance infrastructure, and multimodal infrastructure development. Given the growing imperative of cyber security, a secure high-speed data pipeline that could potentially facilitate the export of India's IT services to West Asia and beyond is also proposed. Mumbai, India's financial and commercial capital, is gearing up to become the country's 'data capital' with its suburban expanse intending to develop an information technology capacity of 1.5 gigawatts. Mumbai is already the foremost submarine optic fibre cable landing city in India, and these capacities could grow as the Eastern Corridor of IMEC takes shape.

Domestically, India's growing commercial space ecosystem is looking for newer business opportunities and use cases. Without a doubt, IMEC may become a major source of business for the Indian space economy, which aims to grow to 10 percent of the global space economy by 2030. IMEC is a good opportunity for the commercial space companies of its members to forge international partnerships, including revenue-sharing partnerships. These will be mutually beneficial and work towards the aspirations set by the establishment of the PGII. Space technologies and services have the inherent potential to securely operationalise IMEC and positively offer peace, prosperity, and progress to South and West Asia, as well as Eastern Europe and the Atlantic North. ## How armed outsiders and a radical militia shattered the peace in Manipur's Jiribam

n June 7, Ngurthansang fled his home in Manipur's Jiribam district, as violence caught up with an area that had, for over a year, been relatively buffered from the ethnic clashes in the rest of

With 80-odd Hmar families, Ngurthansang moved to Lakhipur in neighbouring Assam, just across the Jiri river. The 33-year-old, his wife and three children spent four months in a relief camp in Hmarkhawlien, a Hmar village in Lakhipur. In October, as peace slowly returned to Jiribam, and the school in which his wife worked reopened, the family made its way back to their home in Zairawn, a Hmar village. "Things were peaceful but all the villagers would stay together at night, and some men from the village would guard us," Ngurthansang told Scroll.

On November 7, however, the village came under attack allegedly by members of the armed Meitei group Arambai

Ngurthansang's wife, a 31year-old teacher, was tortured, allegedly raped and burnt to death. The raid on Zairawn was the start of a new cycle of violence in which women and children have been ruthlessly targeted. Four days later, a group of armed Hmar men attacked a relief camp in the district and abducted six women and children - one an eightmonth-old infant – of the same Meitei family. Their bodies were recovered from the rivers near Jiribam a few days later.

Ten of the assailants were killed in retaliatory fire as they allegedly attacked a post of the Central Reserve Police Force near the relief camp in Borbekra. Security officials told Scroll that the attack on the Meitei settlement was "revenge" for the death of the Hmar woman in Zairawn.

They also described the first attack on the Hmar village as "unprovoked" and "surprising" and designed to disrupt a fragile peace of the past few weeks.

"Why did they kill the Hmar woman without any instigation?" said a senior Meitei police official, who was part of the efforts to defuse the animosity between the communities. "Because the Arambai Tenggol wanted to send a message. To disrupt the peace, they targeted Zairawn." The Arambai Tenggol is a Meitei vigilante group, whose cadres are alleged to have carried out brutal attacks on the Kuki-Zo community during the ethnic conflict in the state, and are believed to have close ties with the Manipur

chief minister N Biren Singh. The long-drawn conflict in Manipur between the majority Meiteis and the minority Kuki-Zomi-Hmar tribes has led to 255 deaths and the displacement

A build-up of armed men According to the senior police official, the Arambai Tenggol has grown in strength in Jiribam since violence broke out in June, with many cadres arriving in the district from Imphal Valley to defend Meiteis.

An Assam Rifles official posted in Jiribam told Scroll that armed outsiders from both communities have been trickling into the district as reinforcements. "Since the June violence, there has been a buildup of armed men from Imphal valley as well as Churachandpur," the official said.

Of the 10 Hmar men killed on November 11 while raiding a Meitei settlement, none was from Jiribam. Seven men had come to the district from Churachandpur, while three had arrived from Pherzawl, the district that adjoins Jiribam.

Security officials and community leaders pointed to a worrying militarisation of both communities in Jiribam. A political leader, who does not belong to either community, said, "The number of youths taking up arms on both sides has shot up significantly – mostly under the influence of outsiders.'

A lull that did not last Jiribam is a tiny district home to many communities, from

Muslim and Hindu Bengalis to Meiteis, Pangals, and Kuki-Zomi and Naga tribes. In May last year, when ethnic

clashes spread from Churachandpur to Imphal, a peace committee comprising people from different communities, security forces and district authorities kept violence at bay here for nearly 13 months. In June, however, the killing of a Meitei man shattered the peace, leading to an exodus of both communities.

Despite the setback, the Jiribam Peace Committee coaxed the representatives of the Meitei and Hmar communities to return to the talks table. They met twice in Cachar and an agreement was signed on August 1 to restore normalcy and "prevent incidents of arson and firing". "We believed that some of the Meiteis also wanted peace," said a Hmar leader, who was part of the peace committee. The senior Meitei police official said the ground had been laid for a third round of consultations between Hmars and Meiteis in Guwahati.

However, not all wanted violence to end. "The Meiteis are a divided house," the senior Meitei police official said. "A section wanted to derail the process for gaining political mileage. And so the attack on the Hmar village. It is unfortunate that Jiribam people were swayed by external influence."

A Meitei leader, who was part of the peace committee, told Scroll that after the June violence, several Jiribam residents joined the Arambai Temggol "as they are for our protection and defence.'

The central security official told Scroll that "the number of arms reaching Arambai Tenggol cadres had gone up" in recent months. While most of Jiribam seemed peaceful, Kuki-Zos and Meiteis were often engaged in crossfire in two villages on the periphery of Jiribam town.

'Help' from the hills

As violence simmered, reinforcements began arriving for the Kuki-Zomi-Hmar tribes too - from Churachandpur and Pherzawl. "Jiribam is our area. but we have fewer resources and people there," said a Churachandpur-based Hmar leader. "So, in order to stop the enemy from invading our areas, the armed village volunteers need to go there." The festering ethnic conflict in Manipur has led civilians from the warring communities to take up arms to guard their villages. They are often described as "village volunteers". Twenty-two-year-old Lalthanei Hmar was one such armed civilian. Before he took up arms last year, Lalthanei Hmar worked as a daily-wage painter in Churachandpur town. Two weeks ago, he made his way to Jiribam - a day's journey, involving two vehicles and a river crossing.

"Our villages in Jiribam were attacked. That's why the volunteer committee here selected two-three men from each village and sent them to Jiribam to

cousin who lives in Churachandpur, said. Lalthanei Hmar was allegedly

among the group of armed men who sprung an attack on the relief camp in Borobekra on November 11.A sparsely populated area, Borobekra is surrounded by Bengali and Hmar villages. Over a hundred Meiteis, displaced in the June violence, had taken shelter at the relief camp. Security officials told Scroll that this was an area where the Meiteis were "vulnerable" and "easy targets". To repulse the attack. CRPF personnel opened fire at the assailants, who, according to several eyewitnesses, were setting shops and houses ablaze and had opened fire at a CRPF

post in the area. Lalthanei Hmar was one of the 10 armed men killed in the firing. However, Kuki-Zo-Hmar groups contest this version and have criticised the CRPF for shooting the men. They also alleged that armed Meiteis and the perpetrators of the violence in Zairawn village were hiding in the camp – a claim denied by the Assam Rifles. A measure of the deep divide between the ethnic communities is that several Hmar people defended the action of the assailants – even the violence against unarmed civilians – arguing that "the presence of Meiteis is a threat to the

lives of the Hmars" 'The village volunteers did what they had to do in a civil

guard the villages," R Hmar, his war or ethnic conflict," a Hmar resident told Scroll. "And so they attacked the remaining Meiteis in that area.'

'A cycle of violence and counter-violence'

Security officials and police officers told Scroll that bringing back peace to the area is now a near-impossible task. One of the reasons is that both communities have decided to arm themselves. ## Russia launched intercontinental missile for first time in war: Ukraine

KYIV, Nov 21: Ukraine centre for people with dissays Russia launched an intercontinental ballistic missile overnight targeting Dnipro city in the centraleast of the country, which, if confirmed, would be the first time Moscow has used such a missile in the war.

ment Thursday that its air defence systems shot down two British-made Storm Shadow missiles, six HI-MARS rockets, and 67 drones. The announcement came in the ministry's daily roundup regarding the military actions in Ukraine.

The statement didn't say when or where exactly it happened or what the missiles were targeting. This is not Moscow's first public announcement of the

shooting down of Storm Shadow missiles, as Russia earlier reported downing some over the annexed Crimean Peninsula.

The developments come as the war has taken on a growing international dimension with the arrival of North Korean troops to help Russia on the battlefield — a development that US officials said prompted U.S. President Joe Biden's policy shift on allowing

Ukraine to fire longerrange US missiles into Russia. The Kremlin responded with threats to escalate further.

Putin has previously warned the US and other NATO allies that allowing Ukraine to use Westernlonger-range weapons to hit Russian territory would mean that Russia and NATO are at war. And the new doctrine allows for a potential nuclear response by Moscow even to a conventional attack on Russia by any nation that is supported by a nuclear power.

While the doctrine envisions a possible nuclear response by Russia to a conventional strike, it is formulated broadly to avoid a firm commitment to use nuclear weapons and keep Putin's options open.

## **Death toll in Gaza from Israel-Hamas** war passes 44,000: Palestinian officials

**DEIR AL-BALAH, Nov 21:** The death toll in the Gaza Strip from the 13-month-old war between Israel and Hamas has surpassed 44,000, local health officials said on Thursday.

The Gaza Health Ministry does not distinguish between civilians and combatants in its count, but it has said that more than half of the fatalities are women and children. The Israeli military says it has killed over 17,000 militants, without providing ev-

The Health Ministry said 44,056 people have been killed and 104,268 wounded since the start of the war. It has said the real toll is higher because thousands of bodies are buried under rubble or in areas that medics cannot access.

The war began when Hamas-led militants stormed into southern Israel on Oct. 7, 2023, killing some 1,200 people, mostly civilians, and abducting another 250.

Around 100 hostages are still inside Gaza, at least a third of whom are believed to be dead. Most of the rest were released during a cease-fire last

The Israeli offensive has caused heavy destruction across wide areas of the coastal territory, leading many to wonder when or how it will ever be Around 90% of the population of 2.3 million

people have been displaced, often multiple times, and hundreds of thousands are living in squalid tent camps with little food, water or basic services. Israel says it tries to avoid harming civilians and

blames their deaths on Hamas because the militants operate in residential areas, where they have built tunnels, rocket launchers and other military infra-

Palestinian officials and rights groups accuse Israeli forces of war crimes and crimes against humanity, and the United Nations' top court is considering allegations of genocide brought by South Africa.

The Israeli government adamantly denies the allegations, accusing critics of being biased against

In recent weeks, the amount of humanitarian aid entering Gaza has plummeted, prompting the United States to threaten to reduce its military support for Israel before backing down, citing limited progress. Experts have warned that isolated, warravaged northern Gaza could already be experiencing famine.

The United States, Egypt and Qatar spent months trying to broker a cease-fire agreement in which Hamas would release the remaining hostages in exchange for an end to the war. Those talks ground to a halt over the summer, with Israel and Hamas each accusing the other of making unacceptable demands.

U.S. President-elect Donald Trump has vowed to end the wars in the Middle East without saying how. His previous administration gave unprecedented support to Israel and Prime Minister Benjamin Netanyahu's hard-line policies toward the

## Volcano on Iceland's Reykjanes Peninsula erupts for 7<sup>th</sup> time in a year

GRINDAVIK (ICELAND), Nov 21: A volcano on the Reykjanes Peninsula in southwestern Iceland has erupted for the seventh time since December.

The eruption started with little warning at 11:14 pm Wednesday and created a fissure around 3 kilometres long. The activity is estimated to be considerably smaller than the previous eruption in August, Iceland's meteorological office that monitors seismic activity said.

"In the big picture, this is a bit smaller than the last eruption, and the eruption that occurred in May," Magnus Tumi Guamundsson, a professor of geophysics who flew over the scene with the Civil Protection agency to monitor the event, told the national RUV broadcaster.

While the eruption poses no threat to air travel, authorities warned of gas emissions across parts of the peninsula, including the nearby town of Grindavik. Around 50 houses were evacuated after the Civil Protection agency issued the alert, along with guests at the famous Blue Lagoon resort, according to RUV. The repeated volcanic eruptions close to Grindavík, which is about 50 kilometres southwest of the capital, Reykjavik, and has a population of 3,800 people, have damaged infrastructure and property and forced many residents to relocate to guarantee their safety.

"Grindavík is not in danger as it looks and it is unlikely that this crack will get any longer, although nothing can be ruled out," Magnus Tumi said.

Iceland, which sits above a volcanic hot spot in the North Atlantic, averages one eruption every four to five years. The most disruptive in recent times was the 2010 eruption of the Eyjafjallajokull volcano, which spewed clouds of ash into the atmosphere and disrupted trans-Atlantic air travel for months. (AP)

## SL Prez backs IMF package despite pre-election rhetoric to renegotiate it

COLOMBO, Nov 21: Sri Lankan President Anura Kumara Dissanayake Thursday backed an International Monetary Fund bailout package despite prepresidential election rhetoric to renegotiate with the global lender to water down tough conditions laid down for the recovery.

In his inaugural address to the newly convened parliament after his party's landslide victory last week, President Dissanayake also pledged to fulfil his preelection promises by ensuring the supremacy of the law and addressing past wrongdoings.

Dissanayake affirmed his administration's commitment to continue the IMF bailout programme initiated by the previous government led by Ranil Wick-

"We will enter the staff-level agreement (with IMF) hopefully by November 23," Dissanayake said, expressing optimism about securing the agreement for the next tranche of the nearly USD 3 billion facility. A staff-level agreement is a preliminary pact reached between the IMF staff and the government of a country on a set of economic policies and reforms that the country must implement in exchange for financial assistance from the global lender.

The IMF team on Sunday arrived in Sri Lanka to carry out the third review of the nearly USD 3 billion bailout facility. The third review should lead to the fourth tranche of the 4-year facility. It would be around USD 330 million as was the case in the previous three tranches, according to the Finance Min-

#### Death toll from gun attack in Pakistan on Shiites jumps to at least 28



PESHAWAR, Nov 21: Gunmen opened fire on passenger vehicles carrying Shiite Muslim civilians in restive northwest Pakistan on Thursday, killing at least 28 people, including six women, and wounding 30 others in one of the deadliest such attacks in recent years in the region, police said.

The attack happened in Kurram, a district in the northwestern Khyber Pakhtunkhwa province where sectarian clashes between majority Sunni Muslims and minority Shiites have killed dozens of people in recent

No one has claimed responsibility. The latest violence came a week after authorities reopened a key highway in the region after keeping it closed for weeks following deadly

Local police official Azmat Ali said several vehicles carrying passengers were traveling in a convoy from the city of Parachinar to Peshawar, the capital of Khyber Pakhtunkhwa, when gunmen opened fire.

He said the dead included six woman, and least 10 passengers were in a critical condition at a hospital.

Pakistan's President Asif Ali Zardari condemned the attack and offered his condolences to the families of the victims. He also ordered authorities to take action against those who orchestrated the attack.

Shiite Muslims make up about 15 percent of the 240 million population of Sunni-majority Pakistan, which has a history of sectarian animosity between the two communities.

Although they live together largely peacefully in the country, tensions have existed for decades in some areas, especially in parts of Kurram, where Shiites dominate.

Nearly 50 people from the two sides were also killed over the same dispute in July when clashes between Suni and Shiites erupted in

## Australian tourist dies after drinking tainted alcohol in Laos, raising toll to 4 including American



VIENTIANE (LAOS), Nov 21: An Australian teenager has died after drinking tainted alcohol in Laos in what Australia's Prime Minister on Thursday called every parent's nightmare. An American and two Danish tourists also died, officials said after reports that multiple people had been sickened in town popular with backpackers.

Australian Prime Minister Anthony Albanese told Parliament that 19-yearold Bianca Jones had died after being evacuated from Vang Vieng, Laos for treatment in a Thai hospital. Her friend, also 19, remains hospitalised in neighbouring Thailand

"This is every parent's very worst fear and a nightmare that no one should have to endure," Albanese said. "We also take this moment to say that we're thinking of Bianca's friend Holly Bowles who is fighting for her life.

They are believed to have consumed drinks tainted with methanol, which is sometimes added to mixed-drinks at disreputable bars as a cheaper alternative to ethanol, but can cause severe poisoning

Telephone numbers listed for Laos' Health Ministry did not work and police refused to comment on the incident.

Australia said "several foreign nationals" had also been victims of methanol poisoning. The US State Department confirmed that an American had also died in Vang Vieng, and Denmark's Foreign Ministry said two of its citizens had also died in "the incident in Laos," but neither would comment directly on a link to the methanol poisoning that killed

## North Korea, Russia agree to expand their economic cooperation

US, South Korean and Ukrainian officials have claimed that the North has also been supplying Russia with artillery systems, missiles and other equipment.

North Korea would be possibly getting anywhere between \$320 million to \$1.3 billion annually from Russia for sending its troops to Ukraine, considering the scale of the dispatch and the level of payments Russia has been providing to foreign mercenaries, according to a recent study by Lim Soo-ho, a South Korean analyst at an NIS-run think

While that would be meaningful income for North Korea's crippled and heavily sanctioned economy, it could be lower than the money the North earns from illicit coal exports or supplying military equipment to Russia, Lim said. This suggests that North Korea's troop dispatch is less about money than acquiring key Russian technologies to further advance its nuclear weapons and missile program, which is a major concern in Seoul, Lim said, (AP)

## Cash, jewellery looted during attack on Manipur MLA's residence: Police



**IMPHAL, Nov 21:** The mother of JD (U) MLA Kh Joykishan Singh in Manipur has lodged a complaint, alleging that ₹ 18 lakh in cash and jewellery items worth ₹ 1.5 crore were looted by a mob that vandalised the legislator's residence on November 16, police said on

Several items kept at the MLA's residence in West Imphal's Thangmeiband area for internally displaced people were also destroyed during the attack, a senior officer said.

'The mother of Thangmeiband constituency legislator Kh Joykishan Singh filed a complaint with the Imphal Police Station that ₹ 18 lakh in cash and several valuable items worth ₹ 1.5 crore were looted and destroyed during a mob attack. An FIR has been registered," the police officer told PTI.

The mob vandalised the residence of the legislator for about two hours on the November 16 evening, he said

Notably, the MLA was in Delhi due to medical treatment for one of his family members when the mob attacked his residence last week.

Bodies of those six were later found over the past few days.

## Delhi polls: AAP releases 1st list of 11 candidates, fields BJP, Cong turncoats



**NEW DELHI, Nov 21:** The Aam Aadmi Party on Thursday announced its first list of 11 candidates for the Delhi Assembly polls, dropping three sitting MLAs and fielding six leaders who switched over from the BJP and the Congress recently.

Elections in the national capital are due in February to elect 70 members of the Delhi Legislative Assembly. AAP is the first party to release a list of candidates.

Making the announcement at a press conference here, Delhi AAP convener Gonal Rai reasoned that the early declaration of names of candidates was because eight of the 11 constituencies are not held by the party.

Six of these eight constituencies are currently held by the BJP.

He also rebutted suggestions that outsiders who recently joined AAP were given tickets at the cost of party leaders.

The names of candidates were announced after a meeting of the AAP's political affairs committee, headed by party national convener Arvind Kejriwal. AAP, which has been ruling Delhi since 2015, won 62 seats in the 2020 assembly polls. Talking to reporters, Rai said the tickets were given strictly based on performance, surveys and public opinion as was promised by Kejriwal.

Sitting AAP MLAs who were denied tickets include Rituraj Jha from Kirari, Gulab Singh Yadav from Matiala and Abdul Rahman from Seelampur. Both Jha and

## Charges against Adani: BJP slams Cong, questions timing of development

**NEW DELHI, Nov 21:** The BJP on Thursday targeted the Congress over its attack on the central government after US prosecutors charged industrialist Gautam Adani with bribery and fraud, saving all the states mentioned in the indictment were at that time ruled by opposition parties.

These questions have remained Gautam Adani charged in the US with alleged bribery and fraud, the Congress on Thursday said it "vindicates" its demand for a Joint Parliamentary Committee investigation into the various "scams" involving his conglomerate. The opposition party also called for "a

new and credible" SEBI head to be appointed to complete the securities law investigations into the "Adani Mega Scam". Adani has been charged by US prosecu-

tors over his role in an alleged years-long scheme to pay USD 250 million bribe to Indian officials in exchange for favourable terms for solar power contracts.

US prosecutors charged Adani, 62, his nephew Sagar and other defendants for paying over USD 250 million in bribes between 2020 and 2024 to Indian government officials to win solar energy contracts on terms that could potentially bring in more than USD 2 billion in profit.

Congress general secretary in-charge communications Jairam Ramesh said the US Securities and Exchange Commission's actions also cast poor light on the manner in which its Indian counterpart, namely SEBI, has gone about investigating violations of securities and other laws by the Adani Group and its abject failure to hold the Group to account for the source of its investments, shell companies, etc.

"The indictment of Gautam Adani and others by the Securities and Exchanges Commission (SEC) of the US vindicates the demand that the Indian National Congress has been making since Jan 2023 for a Joint Parliamentary Committee (JPC) investigation into the various Modani scams," Ramesh said in a post on X.

"The INC had asked a hundred questions in its Hum Adani ke Hain (HAHK) series bringing out the various dimensions of these scams and of the intimate nexus that has existed between the PM and his favourite busiunanswered," he said.

The Congress reiterates its demand for a JPC into the transactions of the Adani Group, which is leading to growing monopolisation in key sectors of the Indian economy, fuelling inflation, and posing huge foreign policy challenges as well, especially in our neighbourhood, Ramesh said.

In another post, he said the five-count indictment of Gautam Adani, Sagar R Adani and others unsealed by the US Attorney's Office, Eastern District of New York has revealed more shocking details about Adani's criminal activities.

"It alleges that they paid over \$250 million (₹ 2,100 crore) in bribes to Indian government officials between 2020 and 2024. It states that the bribes were paid 'to obtain lucrative solar energy supply contracts with the Indian government, which were projected to generate more than \$2 billion (₹ 16,800 crore) in profits after tax'," Ramesh said. It alleges that "on several occasions, Gautam S Adani personally met with an Indian government official to advance the Bribery Scheme" and claims to have electronic and cellular phone evidence of this, the Congress leader said.

"All of this is consistent with a long record of fraud and criminality carried out with impunity with the obvious protection of the Prime Minister," Ramesh charged.

The fact that it has taken a foreign jurisdiction to properly investigate Adani only shows how Indian institutions have been captured by the BJP, and how decades of institutional development have been undone by greedy and power hungry leaders, the Congress leader said.

'The answer is clearly for a new and credible SEBI head to be appointed to complete the securities law investigations into the Adani MegaScam, and for a JPC to be set up immediately to investigate its full extent," he

## We now know contributions of many national heroes, not just one family: Odisha CM

NEW DELHI, Nov 21: Odisha government will set up memorials and make a biopic on the life of 'Utkal Keshari' Harekrushna Mahtab, Chief Minister Mohan Charan Majhi announced on Thursday, saying the society now knows the contributions of many national heroes, and not "just one family"

Majhi made the veiled reference to the Nehru-Gandhi family while addressing an event at the Vigyan Bhavan here to mark the 125th birth anniversary of Harekrushna Mahtab, the first chief minister of Orissa (now Odisha).

President Droupadi Murmu was the chief guest at the event hosted by the Ministry of Culture where a special commemorative stamp and coin were released along with a few books.

Mahtab was the last prime minister of the province of Orissa. The province of Bihar and Orissa was carved out of Bengal in 1912 before Orissa became a separate state in 1936. After Independence, it became part of the Union of India.

Stating that this landmark tribute is being paid to Mahtab 37 years after his demise, Majhi said without taking any name, "For a long period, we were only engaged in recognising the contributions of just one family. It happened throughout the country and it also happened in Odisha.'

"But Prime Minister Narendra Modi changed all this and we now know the contributions of many more national heroes than just one family," he said.

"In Odisha too, we are now ready to worship all our heroes who made significant contributions to nation building," the chief minister added.

Hailing Mahtab for his contribu-



tions, Majhi said he established the Hirakund Dam and was instrumental in the decision to shift the state capital capital from Cuttack to Bhubaneswar.

"He was a statesman, a visionary, a genius political thinker, and a strategist and mentor to many

young leaders who later became big names in state politics. Besides his contributions to politics, he also inspired a generation of Odia writers and journalists," the chief minister said.

Mahtab led (then) Orissa during a crucial period of the fight for In-

dependence, Majhi said as he underlined the role played by him in the amalgamation of various princely states into the Union of

"We know the contributions of Sardar Vallabhbhai Patel in achieving the integration of the princely states into the Union of India. Likewise, Dr Mahtab was the 'Sardar Patel of Odisha', as he helped merge various princely states into the state of Odisha," Majhi added, calling Mahtab a cynosure of "solidarity and responsive administra-

"He was nominated to the Congress Working Committee by Netaji Subhas Chandra Bose. He was arrested from Ahmednagar along with the likes of Jawaharlal Nehru. Sardar Patel, Maulana Azad and many other top leaders of the time," Majhi said.

Mahtab was also "arrested in

1975 for opposing the brutalities and slave-like treatment meted out by the then infamous Congress government to the public and public leaders during Emergency", Majhi said, adding that his nearly lifetime association with the Congress ended with the "anti-people politics/polices of the government led by Indira Gandhi"

Announcing several celebrations to honour Mahtab's contributions, Majhi said, "We will hold year-long celebrations to mark the 125th birth anniversary of 'Utkal Keshari' in a befitting manner. The government has taken a decision to set a memorials at different places, including his birthplace Agarpara, reprint books written by him in different languages, and encourage research on his life."

The Odisha government has also taken a decision to make a biopic on Mahtab's life, which will inspire the current generations and generations to come, Majhi added. Union Education Minister Dharmendra Pradhan and Minister of Culture and Tourism Gajendra Singh Shekhawat were also pres-

ent on the dais.

It is a matter of delight that the Odisha government has taken a decision to hold year-long celebrations to mark the 125th anniversary of Mahtab, Pradhan said. Born on November 21, 1899, in Agarpara, Mahtab also wrote extensively in both Odia and English, winning accolades for his work, including the historical account 'History of Orissa', besides winning the Sahitya Akademi Award in 1983 for 'Gaon Majlis', the Culture Ministry said.

He served as the Union minister for commerce and industry, before getting elected to the Lok Sabha unopposed in 1962. (PTI)

NEW DELHI, Nov 21: Even Ajmal Kasab was given a fair trial in our country, the Supreme Court on Thursday remarked and indicated it may set up a courtroom inside Tihar Jail for the trial of J&K separatist leader Yasin Malik in a kidnapping case.

A bench of Justices Abhay S Oka and Augustine George Masih was hearing a CBI plea against the September 20, 2022 order of a Jammu trial court that directed Malik, serving life term in Tihar jail, to be produced before it physically to cross-examine the prosecution witnesses in the kidnapping case of Rubaiya Sayeed, daughter of politician Mufti Mohammad Sayeed.

The bench, however, remarked, "How will cross-examination be done online? There is hardly any connectivity in Jammu... In our country, a fair trial was given even to Ajmal Kasab and legal assistance was given to him in the high court."

Kasab, the lone Pakistani gunman caught alive after the Mumbai terror attack, was hanged till death at the Yerawada Central

The bench told Solicitor General Tushar Mehta, representing the CBI, to take instructions on the total number of witnesses in the case.

Mehta pointed out security concerns and said Malik couldn't be taken to Jammu for

The law officer accused Malik of "playing tricks" for having asked to appear personally and not engaging a lawyer. Mehta said Malik was not an ordinary criminal and showed a purported photograph of Malik sharing the dais with terrorist Hafiz



The top court said it could order trial to take place inside the jail premises and ask the judge to come to the national capital for the proceedings.

The bench, however, noted all the accused persons in the matter had to be heard before it passes an order.

Mehta said Malik appearing in the Supreme Court physically raised security concerns previously

The bench said Malik could be allowed to appear virtually in the apex court proceedings and posted the matter on Novem-

The CBI in the meantime was directed to amend its petition and implead all accused persons as respondents.

In 2023, Mehta wrote to then Union Home Secretary Ajay Kumar Bhalla flagging a "serious security lapse" after Malik was brought to the Supreme Court to appear in a case.

Malik, serving life sentence in a terrorfunding case, was brought to the high-security apex court premises in a prison van escorted by armed security personnel without the court's permission.

Expressing surprise at his presence, Mehta informed the apex court there was a procedure for high-risk convicts to be allowed into the courtroom to argue their case personally.

The CBI said Malik, the top leader of the Jammu and Kashmir Liberation Front (JKLF), was a threat to national security and cannot be allowed to be taken outside the Tihar jail premises.

The apex court on April 24, 2023, issued

notices on the CBI's appeal following which the incarcerated JKLF chief wrote a letter to the registrar of the Supreme Court on May 26, 2023 seeking permission to appear in person to plead his case.

An assistant registrar took up his request on July 18, 2023 and said the apex court would pass necessary orders -- a decision the Tihar Jail authorities reportedly misconstrued to allow Malik to appear and argue

Mehta referred to the CBI's contention in its appeal against the trial court order to bring Malik to Jammu for the in-person examination of the witnesses in the kidnapping case, and said under Section 268 of the CrPC a state government may direct certain people to not be shifted from the confines

On September 20, 2022, a special TADA court in Jammu directed Malik to be physically produced before it on the next hearing for him to cross-examine prosecution witnesses in the kidnapping case.

The CBI challenged the trial court order before the Supreme Court as appeals in TADA cases are only heard by the top

Rubaiya was abducted near Lal Ded Hospital in Srinagar on December 8, 1989 and freed five days later after the then BJPbacked V P Singh government at the Centre released five terrorists in exchange.

Mufti, who now lives in Tamil Nadu, is a prosecution witness of the CBI, which took over the case in early 1990s.

JAMMU, Nov 21: The Jammu Development Authority has demolished a dozen shops belonging to displaced Kashmiri Pandits in Jammu city, allegedly without issuing notices, sparking protests from various sections that demanded action against the officials.

demolition drive was launched on Wednesday, targeting shops built by displaced Kashmiri Pandits near the Muthi camp three decades ago, officials said.

The old shops were located on land belonging to the Jammu Development Authority (JDA).

Relief Commissioner Arvind Karwani visited the area to assess the situation and assured the affected families that new shops would be constructed for them in

"These shops were on JDA land. The relief organisation has floated tenders for constructing a shopping complex in Muthi Camp Phase II. Ten shops will be constructed soon and allotted to these shopkeepers,'

Political parties, including the BJP, PDP and Apni Party, and several Kashmir Pandit organisations condemned the JDA's action and called for the construction of new shops for the displaced community to help them sustain their livelihood.

Pointing to his demolished shop, its owner Kuldeep Kisroo said, "Instead of helping us survive by providing better facilities and financial support, this government has snatched our bread and butter by bulldozing our shops.'

Jav Lal Bhat, another shopkeeper who set up his shop in a tin shed in 1991, said, "How can we feed our families when we are solely dependent on the earnings from these shops? We urge the Lieutenant Governor and the Chief Minister to intervene and give us justice."

Another shopkeeper, Jawahir Lal, described the demolition as "sheer hooliganism". He said, "No notices were served to us for the

President of the Muthi migrant camp Anil Bhan criticised the timing of the demolition. "It should have waited for another month as the relief department is already constructing shops for them within the camp. This unfortunate incident could have been avoided," he

PDP chief Mehbooba Mufti shared a clip of the affected shopkeepers on X and urged Chief Minister Omar Abdullah to address the issue with compassion and urgency. "Heartbreaking scenes emerge as Kashmiri Pandit shopkeepers stand helplessly by the rubble of their demolished shops, reportedly brought down by the JDA without prior notice. This act further deepens their sense of alienation and loss," she said on X.

BJP Spokesperson G L Raina, who visited the site and met the affected families, said, "This visibly seems to be a revenge action soon after the return of the NC-Congress government headed by Chief Minister Omar Abdullah.'

"JDA should have provided alternatives to these families. The government must stop targeting this hapless community," he said.

Apni Party General Secretary and former legislator Vijay Bakaya expressed dismay and questioned the intentions of the JDA.

"Many shops being run by Kashmiri Pandit migrants in Muthi for nearly 30 years have been demolished. If these shops had to be removed for any legitimate reason, notice should have been given and alternative locations provided. This high-handed action by the authorities is most condemnable," he

### Formulate proposal to address inter-state trafficking of bonded labourers: SC to Centre

NEW DELHI, Nov 21: The Supreme Court on Thursday directed the Centre to hold a meeting with all the states and union territories and formulate a proposal to address the issue of inter-state trafficking of bonded labourers, in-

A bench of Justices B R Gavai and K V Viswanathan termed as "alarming" after figures placed before it showed in Uttar Pradesh of the 5,264 bonded labourers released, only 1,101 had received immediate financial assistance.

The apex court observed the problem was in the disbursal of immediate financial assistance to the rescued children as in some cases minors were taken from their home states and forced into bonded labour in adjoining states.

'We find that in order to address the issue of inter-state trafficking of children, the issue needs to be addressed by the union as well as all the states in a unified manner," the bench said. The top court was hearing a plea seeking enforcement of fundamental rights of people trafficked as bonded labourers.

It therefore directed the secretary of the Ministry of Labour and Employment to have a meeting with his counterparts in all the states and union territories and formulate a proposal to address the social evil.

The bench wants the proposal to comprise a simplified procedure to assist the scheme of providing immediate financial assistance to the rescued child labourers.

"Taking into consideration the importance of the matter, we find that it will be appropriate to have the assistance of the Attorney General. We, therefore, request the Attorney General to assist us in the matter," it said. The Centre was further directed by the apex court to take on board the National Human Rights Commission (NHRC) while finalising the procedure. The matter will be heard after six weeks.

During the hearing, the counsel

flagged the issue over the immediate disbursal of financial assistance to the rescued bonded labourers.

The bench referred to Uttar Pradesh's figures and said over 4,100 released bonded labourers had not received financial assis-

The state's counsel said they had compiled the district-wise data along with the number of bonded labourers released and the disbursements made to them and he would place it on record.

When asked how the state prevents bonded labour, the counsel said he would also place on record the procedure being followed in Uttar Pradesh.

The counsel for the petitioners said it was an inter-state issue as there were cases wherein people from Bihar were taken to Uttar Pradesh for bonded labour.

"Why don't you as a union have coordination with all the state governments?" the bench asked the Centre's counsel. It said the secretary of the ministry concerned should hold a meeting with his counterparts in all the states and union territories and come out with a unified formula applicable to all.

The bench further observed in the digital era, there should be a portal akin to the one pertaining to missing children.

'You have to find a unified procedure," the bench remarked.

During a hearing in August, senior advocate H S Phoolka, appearing in the matter, said not even 10 per cent of such labourers were paid financial assistance or compensation.

In July 2022, the apex court agreed to hear the petition and sought responses from the Centre. the NHRC and some states and

### Israel eyes 10,000 Indian tourists in vehicles driven by minors', DSE issues circular 2024 despite unrest, plans e-visa facility

KOLKATA, Nov 21: Amid ongoing conflict in the Middle East, Israel is hoping that Act," the DSE said in a circular issued on will reach 10,000 in 2024 and is planning to launch an e-visa programme for the Indian market early next year to encourage travel to the West Asian country, an official said on Thursday.

According to the Israel Ministry of Tourism (IMOT) India Director of Marketing, Amruta Bangera, around 8,500 Indian tourists visited the West Asian country till October this year.

"In 2018, the country hosted 70,800 Indian visitors, marking a record, Although the COVID-19 pandemic disrupted global travel. Indian arrivals began recovering in 2022, reaching 30,900 despite minimal promotional campaigns. The momentum continued in 2023 with 41,800 Indian visitors. In 2024, 8,500 Indians travelled to Israel during the January-October period,' she told PTI. "We hope that by the end of this year, the number of Indian tourists travelling to Israel will reach

around 10,000," she said. Speaking about the impact of the ongoing Israel-Hamas the number of Indian tourists conflict, which has kept West Asia on edge, Bangera claimed, "Israel is safe for tourists, and the conflict is confined to the bordering areas, where tourists are not allowed to venture."

'Yes, the conflict and the news emanating from the region have impacted tourist inflow. But we hope the situation will improve next year, she said. The IMOT is optimistic about the Indian market's potential and is actively engaging with Indian travel agencies to promote Israel as a preferred tourist destination, she said.

We are planning to launch an e-visa programme early next vear to attract more tourists from India, she said. Bangera stated that despite ongoing geopolitical challenges in the Middle East, Israel has witnessed a steady recovery in global tourism.

The country recorded a peak of 4.9 million international visitors in 2019. While the pandemic brought travel to a near halt, Israel wel-

comed over 2.6 million tourists in 2022 and 3.1 million in 2023.

"In 2024, the number of international tourists to Israel was 920,000 between January and October," she said.

The ongoing conflict in the Middle East intensified dramatically after the Palestinian militant group Hamas launched a large-scale assault on Israel from Gaza on October 7, 2023, killing approximately 1,200 people, mostly civilians, and abducting around 250.

NEW DELHI, Nov 21: The enforcement of Stage IV of GRAP, which bans BS-3 and BS-4 diesel vehicles, has disrupted travel and transportation, particularly for those

engaged in the wedding business. The Central Pollution Control Board imposed GRAP-IV measures after Delhi's air quality index (AQI) entered the 'severe' category on Sunday. The restrictions, which came into effect at 8 AM Monday, aim to curb pollution caused by older diesel vehicles.

However, the measure has had unintended consequences.

Travel agencies report a sharp rise in demand for BS-6 and CNG vehicles, including cars like Ertiga, Innova, and traveller buses, as they scramble to meet commitments made before the ban.

"The wedding season has added to the pressure. Many vehicles were pre-booked months in advance, and with this sudden ban, we had to scramble to adjust," said Sewak Tuar, a travel agency owner.

CNG, BS-6 vehicles during wedding Season

"We are struggling to arrange new vehicles, the petrol, CNG, and BS-6 compliant ones, as weddings and transportation needs are being heavily affected," he added.

Aryan Sinha, another travel agency owner, highlighted the growing challenges "We have vehicles available for nearby trips like Amritsar, but families booking vehicles for destinations such as Manali, Mussoorie, and Rishikesh, as well as for weddings, are facing dif-

ficulties," he said. According to Sinha, wedding bookings often require 10 to 15 vehicles for multiple days. Managing this demand is challenging because they now have to ensure vehicles meet the required standards, he said. "For large groups, CNG buses, traveller buses, and BS-6 compliant vehicles, especially newer models from 2020 onward, are in high demand," he told PTI. The restrictions have also impacted routine tourism as pollution prompts many families plan trips to hill stations.

Rajesh Kumar, another travel agency owner, said, "This is the peak wedding season, and many families plan destination weddings or large gatherings requiring bulk bookings. Rearranging these commitments has been costly and disruptive, as we now have to rent additional vehicles or upgrade our fleet to comply with the regulations." The shortage has also caused financial strain on agencies, with many reporting losses.

"A large portion of our fleet comprises BS-3 and BS-4 vehicles, which are now off the roads. To accommodate the demand, we've had to rent compliant vehicles, which increases costs," Kumar added. (PTI)

## Sooni Taraporevala on 'Waack Girls': It interested me as a storyteller

MUMBAI, Nov 21: Veteran writer-director Sooni Taraporevala says she was introduced to the highenergy dance form of waacking through actor Mekhola Bose and during their discussions, she realised that she could use it as an anchor to tell a story about a group of women.

Her curiosity about Waacking, which involves dancers doing sharp, fast, and expressive arm movements and dramatic poses, resulted in the Prime Video series "Waack Girls".

Taraporevala, known for penning Mira Nair's acclaimed films like "Salaam Bombay!", "Mississippi Masala" and "The Namesake", has created and di-

Bose, granddaughter of cinema legend Soumitra Chatterjee, is a professional waacker and was spotted by Taraporevala when she was casting for her 2020 Netflix movie "Yeh Ballet". "I saw her when I was casting for 'Yeh Ballet. I loved what she was doing but I didn't know what it was called. Later, after the shoot, we had lunch together. She was visiting from Kolkata and we spoke. I asked her about it. That's when I found out about Waacking.

"I asked her a lot of questions about Waacking and her crew, etc. And that's when I first thought of the idea of making something based around Waacking," Taraporevala told PTI in an interview.

When she took a deep dive into the subject, the filmmaker became aware about the history of the dance form.

Waacking originated in the gay clubs of the 1970s in California, US, and became a mode of expression for Black, Latino, and Asian men. The dance form reached its peak during the 70s and then slowly dwindled from the clubs as disco fell from the mainstream and the AIDS epidemic hit the world - taking a lot of originators along with it.

"It interested me as a storyteller. I've written, for Mira, a film called LMy Own Country', which is about the first time AIDS appeared in America. And it's based on a book by Dr. Abraham Verghese who was treating these AIDS patients when nobody knew what AIDS was." "And that tragedy of AIDS and people dying is also part of waacking. And that interested me to explore that level beneath the dance form. And there's nothing wrong with a dance form just being a dance form, but for me as a storyteller,

it helped me have this other layer under it. And that has worked itself into the story," Taraporevala said. "Waack Girl" is

set in Kolkata and follows six young women who are unapologetically themselves as they create a dance group in a city and a country that knows little about their chosen dance style, waacking.

The series captures their adventures both on and off the dance floor as they confront personal battles, family expectations, and societal norms.

Bose stars as Ishani, the leader of the titular dance group, alongside Anasua Chowdhury, Chrisann Pereira, Priyam Saha, Ruby Sah and Achintya Bose.

"My co-writers, Iyanah Bativala and Ronny (Sen), and I wanted to have six girls who were very unique in themselves but also as a group... (I'm) tired of seeing women who all look like clones of each other. So all the young women in the show are very distinctive looking and have distinctive personalities," Taraporevala said.

Working with a young cast and crew felt like a good idea and the filmmaker said she fully embraced

"My crew was very young. My cast was very young. And that's the way to do it. And they all brought their Agame to it. And I'm so grateful," she said.

As a filmmaker, Taraporevala tries to emulate what Hollywood filmmaker Woody Allen once said about working with

process is that 'I get the best person for the job and then I let them do their job'. My guiding principle when I started 'Little Zizou' was that quote of his," she said, referring to the 2009 movie, which marked her directorial debut.

"It was my script. And I had liberty to allow the actors to improvise because I knew what the story was and I knew what I could do with it. And I enjoy collaborating with the crew as well as the cast. That's the process that works the best for me," she added. As a storyteller, Taraporevala said she doesn't aim to stand apart from the rest of the crew.

"I don't like being called madam or ma'am. I hope to be one with the cast and crew. And I think people really appreciate that. They like being appreciated and they bring their best work to a process like that," she added.

Though she is grateful to Prime Video for backing a story like "Waack Girls", the filmmaker said it is still a struggle for storytellers like her to get

"It's a fantasy world where people, instead of just talking, suddenly break out into song and dance, and I love that," she added.

One of the big reasons for Yeoh to star in the movie was Chu, whose 2018 film "Crazy Rich Asians" is credited for being the first major Hollywood hit to feature an entirely Asian cast in a modern setting since 1993's "The Joy Luck Club"

Sometimes we demand to have these changes because I think we should have equal opportunities to be able to showcase our talent in front and behind the camera as well... "We also have to be good storytellers and tell our kind of stories that echo our faces and our culture and

Yeoh, a prominent face in world cinema with acclaimed international performances in films such as "Crouching Tiger, Hidden Dragon", "Tomorrow Never Dies", "Memoirs of a Geisha" and "Shang-Chi and the Legend of the Ten Rings", said she has always believed in the transformative power of cinema and that's why she chooses her roles carefully.

"When I started playing senior cricket, I spoke to Virat Paaji about how he manages himself," Jaiswal told bcci.tv.

"Paaji (Kohli) said to me that if I have to play all that cricket (as long as he has), then I have to be disciplined in my daily routines, follow the process.

"I have seen him (Kohli) doing the stuff consistently dayby-day (day in day out), he motivates me to work on myself and make a difference in my habits," he said.

# Opening Act: Under pressure India meet edgy Australia

PERTH, Nov 21: The nostalgia of Brisbane 2021 refuses to fade but India, still reeling from a bitter home debacle, will be under tremendous pressure when they face an equally circumspect Australia in a battle of two out-of-form batting units in the opening Test of the marquee Border-Gavaskar Trophy, starting here on Friday.

In 2018-19 and 2020-21, India proved that lightning can strike twice with back to back series wins but the manner in which New Zealand came, saw and decimated them on home turf recently has certainly hit the psyche of an otherwise world-class unit.

The undeniable truth is that some of the stars driving this unit are in the twilight of their hallowed careers. How the five-match rubber against Pat Cummins and his men unfolds could well decide their future.

A record third World Test Championship final entry that looked imminent before the start of the New Zealand series, now seems like a distant dream. A 4-0 score-line has become an absolute necessity for India to avoid relying on other teams.

And a 4-0 scoreline on Australian soil is as improbable a proposition as an Indian football team beating Brazil or Argentina in a FIFA friendly.

But anyone who has seen this current bunch from close quarters will vouch that this team can bounce back from the brink. It also tends to play its best cricket when Doubting Thomases enjoy a condescending chuckle at their expense.

In this backdrop, Australia, ready to avenge the humiliation suffered in last five years, face a team that enters the cage without its regular skipper (Rohit Sharma on paternity break), its best exponent of reverse swing (Mohammed Shami, still not 100 per cent fit) and a future skipper (Shubman Gill,

Virat Kohli, Rohit, who will arrive before the second Test in Adelaide, and senior off-spinner Ravichandran Ashwin are facing that moment of reckoning yet again and an indifferent result could have reper-

Kohli's coronation as 'King Kohli' happened in 2014 in this very country with those four hundreds while Cheteshwar Pujara and Rishabh Pant still make appearances in the nightmares of the Aussie bowling quartet, which will certainly be playing its last Border-Gavaskar series together.

This will perhaps be the series which will be decided by bowlers more than ever with Jasprit Bumrah, leading in the opening game, entrusted with the duty of setting the tone against a line-up which has been far from its best even at home in recent times.

Mohammed Siraj and Akash Deep are likely to be Bumrah's partners but the lanky Prasidh Krishna and the burly Harshit Rana are also staking a claim with impressive skill

Whatever be the composition, the home batters cannot afford to take it lightly. Steve Smith's average in the current WTC cycle (2023-25) is just around 36 while his career average is an impressive 56 plus in over 100

Marnus Labuschagne's career average is nearly 50 but in the last two years, it has nose-dived to less than 30.

Travis Head has been India's nemesis in back to back ICC finals within months of each other but even his average is a lowly 28 plus in this cycle.

Save for Usman Khawaja, who even at the business end of his career epitomises consistency, keeper Alex Carey and skipper Cummins, who is now a proper all-rounder, the

batting hasn't exactly inspired confidence. Australia's tail has a better chance of wagging given that India are mulling on playing the better spinner in Ravichandran Ashwin instead of a far better batter in Ravindra

It could be a tactical call looking at the moisture and bounce available on a first track and the world knows that Ashwin is a shade better compared to Jadeja when it comes to bowling on opening day tracks if

To ensure that India's tail isn't as big as that of Kangaroos found in Australian Outbacks, rookie all-rounder Nitish Reddy is expected to be thrown at the deep end of the pool with hope and a prayer that he can be a steady fourth pacer giving 12 to 15 overs per

In batting, three of India's top six batters have never played in Australia and two of them have a cumulative Test experience of four games.

But there's something in Yashasvi Jaiswal, Devdutt Padikkal and Dhruv Jurel that inspires confidence.

They will have Rishabh Pant, perhaps one of the finest Test batters India have produced in the last five years, and a mildly underconfident but stylish KL Rahul for company. If they fire in unison, India will be more

let outside elements influence you in any way," Shastri advised Gambhir while talking to media in the Star Sports press room. "Avoid getting into positions where knee-jerk

reactions happen. Stay calm and focus on understanding your players. You'll notice what it takes for a player to thrive."

Shastri said the key to success lies in under standing players and empowering them in match situations.

"You'll understand team situations where a certain player might be better suited than another, based on your understanding of their temperament.

"These insights don't come overnight -- it took me some time to understand everyone. Gautam might already have a basic understanding of the players' temperaments. He might have seen them in the IPL or sat in the dressing

room with them when he played. "However, there are many players with different mindsets, cultures, and backgrounds. For example, there could be a player who's an introvert, but with the right push and confidence, he could become a match-winner for you. "Understanding those kinds of players and enabling them to work and play in a way that brings out their best would be crucial."

India may have gone to Australia on the back of an unprecedented 0-3 loss to New Zealand at home but Shastri feels Pat Cummins and Co will never underestimate the visitors who have



held the trophy since 2016-17.

"One thing is clear -- this Australian team will never underestimate India, no matter who has come to play. They'll be quietly confident but won't let that confidence get too high.

'They'll be desperate to win, as they haven't won in their own country the last two times and haven't had their hands on the trophy in close to 10 years. That desperation will be there," he

Asked if there would be additional pressure on premier pacer Jasprit Bumrah, who would stand-in as skipper in the Perth Test with Rohit Sharma on paternity leave, Shastri said he should not "overtry"

"These are things that happen naturally, beyond your control. There's nothing you can do about it. You have to think ahead, see what's in your hands, and act accordingly.

"You've got the ammunition and players with experience, so it's important for Gautam to motivate them to take on Australia," Shastri said. Shastri believes Bumrah will face pressure as

"Pressure will be on Bumrah, no doubt about that. Any captain will feel the heat in this situ-

"But Bumrah is a mature and competitive cricketer. Let's not forget he's the best fast bowler in the world right now. The Aussies know what they're up against-they might come after him, but they also know he'll come

"He shouldn't overtry due to captaincy pressure. If he sticks to his strengths and bowls like a team player, he'll be fine.

A key man in India's historic Test wins in Australia, Cheteshwar Pujara, is not part of the Test side anymore and Shastri feels KL Rahul is one player who can "bat long"

"Pujara is Pujara. Please don't compare him with anyone. People used to literally do "puja" to Pujara, asking him to stay at the crease, and we'd win the series in Australia -- and it happened that way. So don't compare. What he did

## Pujara backs KL Rahul at No 3, believes Jaiswal can do a Warner



PERTH, Nov 21: Cheteshwar Pujara, who knows a thing or two about grinding the Australian attack in their den, on Thursday backed KL Rahul to bat at the vital number three slot in the Border-Gavaskar Trophy, and said the swashbuckling Yashasvi Jaiswal is capable of doing what David Warner did in his prime.

The five-match Test series begins here on Friday.

"I don't know the batting order. I would prefer him (Rahul) at No. 3 because he has the experience to bat there," Pujara said in Star Sports press

Rahul, however, is expected to open with youngster Yashasvi Jaiswal, while Karnataka's Devdutt Padikkal is being considered for No. 3 to maintain a left-right combination.

"It seems the team is preferring Devdutt (Padikkal) at No. 3 for the left-right combination. He has batted at 5-6 and in the middle order. It will be easier to bat at No. 3 than opening. If he can bat at No. 3, it will be good."

Pujara, currently sidelined from the Test set-up, praised Jaiswal and compared his batting with that of Australian great David Warner

"One of the most talented cricketers India has produced.... I'm very confident that going forward, he has a lot to prove. I know he will play a key role in this series if we have to win.

"His role would be one of the most important ones. He can play a role similar to what David Warner used to do for the Australian team.

"Being an opener, he holds the key. He's mentally tough. He loves batting, hits a number of balls. He has a long way to go across the formats.'

Pujara said the youngsters must play with self-confidence and without the fear of failure.

"I will tell them the first battle is a mental battle. Self-confidence and belief are needed to make runs in these conditions. When there is pace and bounce, there is a chance of the ball hitting the body. You have to come out of that fear," Pujara said.

On tackling short-pitch deliveries in Australian conditions, Pujara said the batters will have to identify the deliveries they should leave.

"As a batter, you need to understand your strengths. We often end up playing hook shots we aren't quite capable of. On Indian pitches, most short-pitched deliveries are below shoulder level. But in Australia, they're often above shoulder height.

"As a batter, you need to identify which balls to leave and

which to play. Those below the shoulders are the ones you can pull, but you need to be in control of the shot. Sometimes you leave the ball, and sometimes you pull. You can't have a set rule -- you just need to look at the ball and play according to the situation. Be in the present moment," he said.

Virat Kohli may be going through a lean patch but Pujara believes his past success in Australia will help him to turn things around.

"There is a lot of expectation of him. The number of matches he's playing and the athlete Virat is, he doesn't get enough breaks in between. That is why sometimes, when you're not getting enough breaks, your body and confidence go down a bit. That's normal.

"He has got some break. He's at a place where he likes to compete. If someone is having a go at him, he would like to give it back to the bowlers -- that's how

he started his journey.
"He has set high standards for himself. He has that awareness. He has been a leader and is probably the best in the circuit. He's aware of what's expected of him and how many runs he has to make." Under Kohli's captaincy on the 2017-18 tour of Australia, Pujara aggregated over 500 runs and played a significant role in India's historic Test series triumph.

"I'm confident that once he gets going, he needs to spend some time in the game. He's capable of doing all things. Always leading from the front, it's about getting a 50-60-70. If he gets a hundred, then he will have a great series ahead," Pujara said of Kohli.

"In every match, he is motivated, whatever the format. Definitely, he has worked on it. It's about getting that start and spending time at the crease."

Rishabh Pant has been the architect of their epic triumph in the 2020-21 series, and the wicketkeeper-batter has returned after surviving a horrific car accident two years ago.

Pujara feels the left-hander is a lot smarter now and will be one to watch out for.

"Australian bowlers struggle a bit to bowl to lefties. There's a different kind of enjoyment watching him. He's an attacking player who puts pressure on the bowlers. It becomes easy for me to play my natural game as they try to stop runs.

"Whoever bats Rishabh in that partnership, it will be crucial. Batting at No. 5-6, with the ball a bit old, he plays attacking cricket. He can change the entire match in one session. (PTI)

have been very successful and have gotten results but my way is that I have always never followed a copybook plan. "And even with my bowling you can see, I go with my instincts and that's how I have always played my cricket. I have a

lot of faith in my guts and instincts," Bum-

rah said. He believes that fast bowlers are "tactically smart" and do make good captains, and praised Pat Cummins for doing a "phenomenal job" with the Australian team. He also cited Kapil Dev's example.

Does bowler captains tend to over-bowl

or under-bowl themselves? "Well, I look at it in a different manner. I can manage myself the best when I am the captain. I know when I am fresh and I know when I need to push myself, and I know when I have to take extra responsibility," he put forth his case in a strong

"I look at the advantages. I understand that the wicket is changing, you have to understand what field settings are good at the moment and obviously bowlers are more data driven and research oriented than batters and that's how the game is headed."

"There are more positives than negatives. Yes, there are challenges but you want to be tested and you want to face challenges

Bumrah has always seen himself as a leader of the group, even when others have led the side.

"I am always wanting to add more when Rohit is there and when Virat was there. I tried to learn from them and when I became a senior player, and new guys started coming in, I started passing on informa-

"That's how I look at it. It feels good and there is no greater honour than leading your country. I have always wanted to play this format, and very few players have played this format, and captains are even less, so I am very privileged and happy to be in this position." (PTI)
