First ICP along India-Bhutan opened in Assam

DARRANGA, Nov 7: The first Integrated Check Post (ICP) along the India-Bhutan border was inaugurated at Darranga on Thursday. Assam Governor Lakshman Prasad Acharya inaugurated the ICP in presence of Prime Minister of Bhutan Dasho Tshering Tobgay.

ICP Darranga, sprawling across 14.5 acres and located about 700 metres from the India-Bhutan border, is equipped with state-of-theart facilities including an office complex, parking areas, loading and unloading zones, a weighbridge, a warehouse, and residential quarters for officials.

Developed by the Land Ports Authority of India, it also features inspection spaces, plant quarantine systems and parking facilities to ensure efficient operations.

The strategic location of Darranga is further boosted by its connectivity. On the Indian side, it is well-connected to National Highway 27 near Rangia, while on the Bhutanese side, a robust customs infrastructure at Samdrup-Jongkhar ensures efficient trade. NESAC identifies 271 wetlands, final survey soon

Centre asks Assam to prepare feasibility report on wetlands for flood control

GUWAHATI, Nov 7: Union Home Secretary Govind Mohan has asked the Assam government to prepare a detailed feasibility report on 271 wetlands for flood water diversion within December, a senior official said on Thursday.

The project to rejuvenate the wetlands and connect them for flood water storage may cost the state exchequer to the tune of ₹ 500 crore, although the final estimate on how many wetlands to be covered will be known after a survey is done, the official stated.

In his two-day visit to Assam, Mohan held a series of review meetings on varied topics such as law and order, border management among Assam, Meghalaya, and Arunachal Pradesh, flood control measures and the status of various tribal councils.

"During the second day of his

lands in seven districts in the first phase, having potential for flood water diversion. The state prepared a plan for these nine projects worth 380.60 crore but sought additional funding from the Centre in this regard, he added.

The chief secretary said, "The Union home secretary directed the WRD to carry out a detailed survey to assess the feasibility of all the 271 wetlands identified by NESAC. He asked us to prepare a concept paper on the feasibility of the wetlands by December 2024."

Reduction around 4 billion tonnes by 2030

India's climate policies expected to reduce CO2 emissions: Report

NEW DELHI, Nov 7: India's current climate policies are projected to reduce carbon dioxide emissions by around four billion tonnes between 2020 and 2030, and drive a 24 per cent reduction in coal-based power generation, according to a new report. This is significant considering the fast-developing South Asian country, now the fifthlargest economy in the world, had committed to reducing emissions by one billion tonnes by 2030 at COP26 in Glasgow.

The study by Delhi-based independent think tank Council on Energy, Environment and Water (CEEW) said policies for India's power, residential and transport sectors have already saved 440 million tonnes of carbon dioxide (MtCO2) between 2015 and 2020.

According to the report, in the power sector alone, policies pro-



demand, CEEW said. At present, India generates around 71 per cent

of its electricity using coal.

Further, with strategic support and competitive tenders, the share of combined solar and wind power in India's energy mix is projected

to rise to 26 per cent by 2030 and 43 per cent by 2050, up from only around 3 per cent in 2015. This shift will decisively reduce

reliance on coal, which is currently the source of nearly half of the country's total carbon dioxide emissions. This transition is crucial for bending India's emissions curve downward, but achieving net zero by 2070 will require even more ambitious action. India has been pushing for a higher share of renewables in its energy mix, increased adoption of electric vehicles and improved energy efficiency in domestic air-conditioning and lighting. It has also launched programmes like the National Solar Mission, the FAME I and II schemes, the Standards and Labelling scheme and the UJALA programme, which will continue to affect future energy demand and supply. Learning to earning: UN to help marginalised Indian youths

NEW DELHI, Nov 7: Three UN agencies have prepared guidelines to help youths from marginalised communities transition from "learning to earning," and would introduce a framework to address both practical and systemic barriers impacting their progress, said Cynthia McCaffrey, the UNICEF India Representative, on Thursday.

UNICEF India, in partnership with the United Nations Population Fund (UNFPA) and United Nations High Commissioner for Refugees (UNHCR), is preparing to release the Technical Guidelines for the Most Marginalised in the next few days. Speaking to PTI about the guidelines, McCaffrey said it aims to reshape youth programs by focusing on the marginalised communities and introducing the RAISE-TM framework -- Rele-



vance, Accessibility, Inclusivity, Safeguarding, Enabling, Transformative, and Measurement. The guidelines address both practical and systemic barriers, ensuring that programmes are inclusive, adaptable and impactful.

By emphasising the development

of 21st-century skills, the guidelines help youth transition from "learning to earning", McCaffrey said while underlining that the youth want to be productive citizens and they need skills to transition from learning to earning. According to the draft guidelines, (CONTD. ON PAGE-2)

ED searches 19 premises of Amazon, Flipkart vendors in FEMA probe

A total of 19 premises of these "preferred" vendors located in Delhi, Gurugram and Panchkula (Haryana), Hyderabad (Telangana) and Bengaluru (Karnataka) were covered as part of the action, they

The sources said the probe was initiated by the federal agency under the provisions of the Foreign Exchange Management Act (FEMA) acting on several complaints against the two large ecommerce companies where it is alleged that they are "violating India's FDI (foreign direct investment) rules by directly or indirectly influencing the sale price of goods or services and not providing level playing field for all the

Emami Q2 net climbs 19 pc to ₹213 crore

KOLKATA, Nov 7: FMCG major Emami Ltd on Thursday reported a 19 per cent year-on-year increase in its net profit for the second quarter ended September 2024 reaching ₹ 213 crore, driven by improved margins and steady growth in both domestic and international markets.

Revenue from operations during the quarter rose by 3 per cent to ₹ 891 crore, with the domestic segment advancing by 2.6 per cent and international business growing 6 per cent, excluding a 12 per cent rise outside of Bangladesh, the company said in a statement.

Gross margins for the quarter improved by 60 basis points to 70.7 per cent, reflecting strategic cost management. Earnings before interest, depreciation, tax, and amortisation (EBITDA) reached ₹ 250 crore, up 7 per cent year-on-year, while EBITDA margins rose by 110 basis points to 28.1 per cent. The company during the quarter raised its stake in Helios Lifestyle, the maker of The Man Company brand, from 50.4 per cent to 98.3 per cent, reinforcing its focus on expanding its men's grooming portfolio.

The board declared an interim dividend of 400 per cent, or ₹ 4 per share, for FY25.

Rupee falls 6 paise to fresh all-time low of 84.37 against US dollar



MUMBAI, Nov 7: The rupee declined 6 paise to close at a fresh lifetime low of 84.37 (provisional) against the US dollar on Thursday, as weak domestic equities and sustained foreign fund outflows dented

Forex traders said investors were also cautious ahead of the US Fed meeting outcome. Moreover, overnight gains in crude oil prices also weighed on the

However, a correction in the dollar index against major currencies helped the rupee and restrained the slide, they added.

At the interbank foreign exchange, the rupee opened at 84.26 against the US dollar. During the session, the local currency touched a high of 84.26 and a low of 84.38. It finally settled at 84.37 (provisional),

a loss of 6 paise against its previous close. On Wednesday, the rupee depreciated 22 paise to close at an all-time low of 84.31 against the US dol-

The rupee touched fresh record lows again on the back of weak domestic equities and sustained FII outflows. Overnight gains in crude oil prices also weighed on the rupee. However, the softening of the US Dollar index from Wednesday's highs cushioned the downside, forex traders said.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.22 per cent lower at 104.86.

Brent crude, the global oil benchmark, fell 0.32 per cent to USD 74.68 per barrel in futures trade.

"We expect the rupee to trade with a negative bias on overall strength in the US Dollar on the back of Donald Trump's victory in the US Presidential elections and FII outflows. However, softening of commodity prices amid easing geopolitical risk premium may support the rupee at lower levels," said Anui Choudhary – Research Analyst at Sharekhan by BNP

Any intervention by the RBI may also support the rupee at lower levels. Traders may take cues from weekly unemployment claims data from the US and FOMC meeting decisions. The Bank of England's monetary policy decision is also due.

BoE and FOMC are expected to cut interest rates by 25 bps. USD/INR spot price is expected to trade in a range of 84.15 to 84.60, Choudhary said.

In the domestic equity market, the 30-share BSE Sensex fell 836.34 points, or 1.04 per cent, to close at 79,541.79 points, while Nifty declined 284.70 points, or 1.16 per cent, to settle at 24,199.35 points.

Foreign institutional investors (FIIs) were net sellers in the capital markets on Wednesday, as they offloaded shares worth ₹ 4,445.59 crore, according to

In a win for Elon Musk, Scindia says no to spectrum auction pitch from Ambani, Mittal

NEW DELHI, Nov 7: In a boost to Elon Musk's Starlink, Communications Minister Jyotiraditya Scindia has said the spectrum for satellite broadband will be allocated and not auctioned as sought by Indian billionaires Mukesh Ambani and Sunil Mittal.

The satellite broadband spectrum will however be not given free and sector regulator Trai will fix a price for the resource, he told PTI in a text and video interview.

"Every country has to follow the International Telecommunications Union (ITU), which is the organisation that lays out the policy for spectrum in space or satellites, and the ITU has been very clear in terms of the spectrum being given out on an assignment basis. In addition, if you look across the world today, I cannot think of a single country that auctions spectrum for satellite," Scindia said.

India is a member of the International Telecommunication Union (ITU), a UN agency for digital technology

Musk's Starlink and global peers like Amazon's Project Kuiper back an administrative allocation.

While Ambani's Reliance Jio has been vocal about the need to allocate such spectrum through an auction to provide a level playing field to legacy operators who buy airwaves and set up infrastructure like



telecom towers, Mittal last month at an industry event where Prime Minister Narendra Modi was also present articulated the need to use bidding for such allocation.

Jio and Mittal's Bharti Airtel -India's largest and second-largest operators, respectively - feel that giving away the satellite broadband airwaves at a pre-decided price by the government will create an uneven playing field since they had to compete in an auction to get spectrum for their terrestrial wireless phone networks.

The two are vying for a piece of the satellite broadband segment as

Musk-led Starlink is demanding administrative allotment of licences in line with the global trend as it looks to tap into the world's fastestgrowing mobile telephony and internet market.

Scindia said the Telecom Act of 2023 passed in December has put the matter in 'Schedule 1', which means that the Satcom spectrum will be allocated administratively.

Such an allocation will be at a government-decided price, and allow foreign firms like Starlink to offer voice and data services. If the spectrum were to be auctioned, it would have made it costlier for Starlink to roll out services.

Starlink has applied for a licence to start operations in the country.

Scindia, however, offered no clues on the fate of his application.

The minister said that the regulatory process is very clear and transparent. The new Telecom Act has been passed, and the Satellite spectrum is very clearly a part of that in schedule one, he pointed out.

"...and therefore, we are open to looking at the application of any entity that wants to invest in India at this point in time. I think only one or two licenses have been given out. And whoever else wants to participate, India is surely going to welcome that," the minister said.

Last month, Musk, in a post on X, termed the demand made by Jio for shunning sector regulator Trai's consultation paper on satellite broadband being allocated and not auctioned as "unprecedented", and when Mittal made the pitch in the presence of the Prime Minister, he asked if it was "too much trouble" to allow Starlink to provide internet services in India.

This was perhaps the first time that Musk, whose networth of USD 241 billion is more than the combined wealth of Ambani, Mittal and Gautam Adani, had spoken directly against demands for a level playing field made by the Indian firms.

Musk, the mind behind PayPal, founder of Tesla and SpaceX and owner of X (formerly Twitter), uses his social media platform on a daily basis to make his views known on a vast array of topics. (PTI)

We must stop fossil fuels causing global warming, before the world stops using fossil fuels -Myles Allen

Future of fossil fuels

espite the threat posed by climate change, global efforts at mitigation and adaptation are not keeping pace with the increasing risks: even if current pledges are kept to, the planet will still be on track for a 2.4-2.6°C temperature rise by the end of the century. At present, projections suggest that even if the national climate plans for all 195 countries that are signatories to the Paris Agreement are implemented, emissions are still likely to increase by 8.8 per cent by 2030. The World City Report 2024 by UN-HABITAT, while given this warning, has said, "To limit temperature rise to no more than 1.5°C, as called for in the Paris Agreement, global emissions have to decline by 45 per cent by 2030 compared to 2010 levels and achieve net zero by 2050. Although most countries have agreed to strengthen their climate action plans, lower their emissions and even set net zero targets, there is still a significant gap between rhetoric and action. Bold steps towards reducing emissions are yet to be taken. By contrast, policy support to produce fossil fuels remains strong. A recent assessment of national energy plans and projections shows that "the world's governments still plan to produce more than double the amount of fossil fuels in 2030 than would be consistent with limiting warming to 1.5°C". A further sign of misaligned commitments and actions can be seen in the fact that many major fossil fuel-producing countries are planning to scale up production for years or decades to come, resulting in near-term increases in the global production of coal (until 2030) and long-term increases (until at least 2050) in oil and gas. In line with this trend, fossil fuel subsidies reached a record US\$7 trillion in 2022 in the wake of the economic recovery from the COVID-19 pandemic and Russia-Ukraine conflict. In particular, the conflict placed energy transition at a crossroads and provoked a global "gold rush" for oil, gas and even coal.

These investments have the potential to lock in new GHG emissions for decades and are essentially competing with efforts to accelerate the energy transition and close the 2030 emission gap. However, the International Energy Agency (IEA) notes that the global energy crisis triggered by the Russia-Ukraine war carries the potential to hasten the transition to "a cleaner and more secure energy system." New policies in major energy markets such as the US, EU, China, Japan, Republic of Korea, and India are likely to push annual clean energy investment to more than US\$2 trillion by 2030, up from US\$1.3 trillion in 2021. Nevertheless, amidst the lack of ambition characterizing climate action, there is still some optimism, albeit within a decreasing window of opportunity. A decisive milestone for climate action took place at the 2023 United Nations Climate Change Conference (COP28. Notwithstanding, there is a sense of disappointment in many quarters that the COP28 agreement was not more farreaching in calling for the explicit commitment to phase out fossil fuels. It remains to be seen how this agreement will be translated into action and what role cities can play in this process: in the meantime, it is likely that fossil fuels will continue to dominate the energy mix for some time to come.

Besides the risk of coastal inundation, cities are also exposed to rainwater flooding as a result of inadequate drainage and the increasing coverage of concrete, asphalt and other materials that prevent water infiltration. Other climate change impacts that are context-specific to cities are urban heat islands. By the 2050s, more than 1.6 billion urban residents will be exposed to extreme temperatures of at least 35°C. As with flooding, poor residents tend to be disproportionality exposed to extreme heat and its attendant impacts. Another problem is urban air pollution, which is entwined with climate change, accounted for 6.7 million premature deaths in 2019, making it the world's largest environmental risk factor for disease and pre-

Manipur: A jewel under siege - understanding Nehru's legacy: The idealism the crisis and seeking solutions

or the past 17 months, Mad nipur has remained in the national spotlight, a state grappling with a deep-rooted crisis that erupted into widespread violence following a Manipur High Court order on March 27, 2023. While the court order was the immediate trigger, the seeds of discontent were sown decades ago, with historical tensions and mistrust shaping the current landscape of unrest. The demand for an inner-line permit system, which started over two decades ago, can be seen as the beginning of the state's descent into instability, further exacerbated by sociopolitical and ethnic tensions.

The trigger: Court order and historical mistrust

The demand for an inner-line permit system gained momentum in Manipur over twenty years ago, highlighting a growing sense of insecurity and mistrust between communities in the state. This culminated in the controversial passing of three bills in the Manipur Legislative Assembly in August 2015, which were met with violent protests in Churachandpur, leading to the tragic death of nine people in police firing. It took 632 days, after several rounds of negotiations between the government and multiple stakeholders, to bury the bodies of those killed.

Peace seemed to have returned to Manipur after these incidents. For nearly a decade, the state witnessed substantial progress, with improvements in socio-economic development that offered hope for a brighter future. However, the fragile peace was shattered once again on May 3, 2023, when violent clashes erupted between the Meitei and Kuki communities, plunging Manipur back into a cycle of violence that continues to flare up sporadically.

A small state with strategic importance

Despite its small size, with a population that accounts for only 0.1 per cent of Delhi's and 0.15 per cent of Mumbai's populations, Manipur holds immense strategic and economic significance. The state, nestled in the northeast of India, serves as a crucial geo-

India's "Act East" policy. It is a land bridge connecting India to Southeast Asia and the ASEAN region, making it a vital player in regional diplomacy and economic outreach. The ongoing violence has not only caused immense hardship for the people of the state but has also drawn attention to Manipur's broader role in India's foreign policy and regional stability. Understanding the complexities of the situation is essential, not just for the sake of the state's people, but for its broader implications for India's strategic interests in Southeast Asia

Disinformation and weaponisation: Fueling the conflict

One of the most challenging aspects of the current crisis is the role of disinformation in fueling violence. False and doctored videos, along with selective depictions of incidents, have become potent weapons in escalating tensions between communities. From the Anglo-Kuki War Memorial being set on fire to the discovery of the decapitated body of a woman in a suitcase, these half-truths and manipulated narratives have triggered cycles of retaliation and unrest.

In contrast, there have also been videos that depict the harsh realities of the conflict, such as the viral footage of two women being paraded on the streets and the ghastly images of point-blank shootings and decapitations. These visuals, along with wordof-mouth stories (which are often exaggerated or untrue), have inflamed anger in both the Meitei and Kuki communities. Every false or partially true narrative escalates tensions, making it increasingly difficult for security

forces to contain the situation. The mass weaponisation of Manipur's society has been another deeply worrying trend. Beyond the looting of weapons and ammunition from police armories, armed groups like the Arambai Tengol. United National Liberation Front (UNLF-P), other valley-based insurgent factions, and Kuki militants flaunt their firepower openly, moving with impunity. The easy availability of

strategic and geo-economic link weapons from neighboring Myan- age similar demands across the making violence a constant threat. Recent videos showing large artillery guns being used, alongside improvised mortars, rockets, and locally made "pumpis," paint a grim picture for both security forces and the general populace.

Regional turmoil: Impact of Myanmar and Bangladesh

The instability in Manipur is compounded by the ongoing conflict in neighboring Myanmar and the growing influence of radical groups in Bangladesh. The Myanmar Army has lost control of significant portions of the region bordering Manipur and Mizoram, which has led to a large influx of refugees, particularly into Mizoram and, to a lesser extent, Manipur. The situation is further complicated by the possibility of northeast India's insurgent groups finding renewed support and safe havens in Myanmar and Bangladesh, particularly in areas where radicals have influence.

The role of central security forces-primarily the Indian Army, Assam Rifles, and paramilitary units like the CRPF—has been pivotal in containing the violence. These forces have been involved in evacuating people to safety, setting up relief camps, recovering looted weapons, arresting militants, and dismantling bunkers, all under conditions that are often hostile and precarious. Although the state police initially faced criticism, they have now established a working relationship with central forces and are playing a key role in maintaining

A complex political landscape At the core of the crisis is the demand by the Meitei community for Scheduled Tribe status and the counter-demand by the Kuki community for a separate administration, now escalating into a call for Union Territory status. Both demands are fraught with complications. Granting Scheduled Tribe status to the Meiteis would exacerbate tensions with other groups, particularly the Nagas, and could lead to even greater unrest. On the other hand, acceding to the Kuki demand for a Union Territory could encour-

Northeast, including in Nagaland Assam, and Arunachal Pradesh.

It is critical for both communities to come to the negotiating table and seek a pragmatic solution. Civil society groups, women's organisations, village elders, youth groups, and even armed cadres must reflect on the progress Manipur had made prior to May 3, 2023. The state had been on a path of socio-economic development, which now seems a distant dream due to the ongoing

violence. A path forward

Restoring normalcy in Manipur will require concerted efforts from both the people of the state and the central government. While the immediate focus must be on stopping the violence, longer-term solutions must address the underlying grievances of both the Meitei and Kuki communities. The Centre must tread carefully in responding to demands, ensuring that any decisions do not spark further unrest in the broader Northeast region. At the same time, the people of Manipur must come together to rebuild trust and engage in meaningful dialogue to secure peace.

Manipur's strategic importance as the linchpin of India's "Act East" policy cannot be overstated. The state serves as a critical gateway for India's outreach to ASEAN, Quad countries, and other nations in Southeast and East Asia. Manipur, known as the "Jewel of India," has a rich cultural and historical legacy dating back to the reign of King Garib Nawaz in 1724. It remains an integral part of India's national identity and aspirations. In these trying times, the people of Manipur must be at the forefront of efforts to restore peace and prosperity to their land. It is only through dialogue, understanding, and cooperation that Manipur can once again embark on its path to glory and become a shining example of development in the Northeast region. one that has haunted the nation for decades, stirring passionate debate and historical inquiry. Since its independence, India has sought to assert its influence globally, and membership in the UNSC as a permanent member is seen by many as a rightful position for a nation of its size, population, and economic standing. However, at the heart of this debate is Jawaharlal Nehru, India's first Prime Minister, whose foreign policy decisions have had a profound impact on India's global aspirations, especially concerning its missed opportunity to claim a UNSC seat in the early Cold War years.

Critics often point to Nehru's reported refusal of an offer for India to join the UNSC as a decision rooted in idealism rather than pragmatism. Allegedly, the United States extended a proposition in 1950, suggesting that India could assume the seat otherwise held by the People's Republic of China (PRC).

Nehru declined, reportedly insisting that China's rightful place was in the UNSC, an assertion that stemmed from his belief in regional representation and balance. Nehru's response, while consistent with his principles, has left many wondering if his idealistic vision for an inclusive world order came at the expense of India's strategic interests.

Nehru's position reflects the diplomatic philosophy that championed: non-alignment. As the world divided into capitalist and communist blocs led by the United States and the Soviet Union, Nehru

sought to carve out a path for India that would allow it to retain independence from either superpower.

The doctrine of non-alignment, though aimed at securing India's sovereignty, also became a restraint in some respects, particularly when it came to India's role within the UN. The desire for multilateralism and the balance of power often led Nehru to overlook the opportunity for India to take a more prominent seat at the international table, most critically at the UNSC.

In hindsight, Nehru's insistence on China's inclusion over India's potential ascension to the UNSC can be viewed as both noble and, perhaps, strategically flawed. The absence of documented evidence of a formal offer adds to the ambiguity, but historical accounts suggest that both the United States and the Soviet Union might have considered India's candidacy.

Nehru's refusal to replace China with India showcased his dedication to Asian solidarity and his vision of a cooperative international order where countries would act based on shared principles rather than sheer power politics. Yet, critics argue that by championing China's right over India's influence, Nehru unintentionally diminished India's leverage in international forums.

Nehru's diplomatic choices during this period underscore a tension between principle and pragmatism. On one hand, his advocacy for China's rightful place in the UNSC was grounded in a vision for Asian unity. Nehru believed that a stable Asia, including both India and China as major players, would reduce Cold War tensions

for division and instability, positioning India as a mediator rather than a competitor. This approach, however, often led Western powers, particularly the United States, to interpret India's neutrality as reluctance to oppose communism, straining Indo-U.S. relations and casting doubt on India's commitment to democratic principles.

By prioritizing non-alignment, Nehru placed India in a unique but isolated position. His vision for an independent, neutral foreign policy aligned with India's postcolonial identity but complicated its relationships with both superpowers. To the United States, India's neutrality seemed like ambivalence in the face of a global ideological struggle, and Washington's frustration with Nehru's approach grew. Nehru defended his stance as an assertion of India's cultural and geopolitical uniqueness, viewing sovereignty as acting independently of external pressures. Yet this stance left India without a permanent seat on the UNSC—a loss that would have far-reaching implications for its global standing and in-

For Nehru, this sacrifice was consistent with India's self-perception as a leader of the Non-Aligned Movement and a proponent of peaceful coexistence. However, his vision also came at a cost. The decision to prioritize

China's representation led India to miss a crucial opportunity to gain a decisive voice on global issues. It hindered India's diplomatic reach, limiting its ability to champion its own security concerns on the global

stage. This choice also contributed to a lingering sense of mistrust with the United States, as American officials saw Nehru's neutrality as an unwillingness to ally with

The question of what might have been had India pursued a permanent UNSC seat is a significant "what-if" in the annals of Indian foreign policy. Nehru's reluctance to accept a position of power, instead advocating for a balanced, inclusive world, demonstrates his commitment to his principles—but at the same time, it reflects a missed strategic opportunity for India. For some, this decision was a mark of statesmanship, positioning India as a voice of moderation and peace. For others, it exemplifies a naïve adherence to idealism at the expense of India's national interests.

In retrospect, Nehru's policy of refusing a UNSC seat stands as a poignant reminder of the dilemmas that often accompany foreign policy choices. His legacy in this regard remains both a source of pride and a point of critique, emblematic of the duality of India's diplomatic ideals. The discourse surrounding Nehru's decision underscores a tension that has shaped India's role on the world stage, reflecting its ongoing quest to reconcile principles with the realities of global power. As India today seeks to secure a permanent UNSC seat. Nehru's vision endures, challenging the nation to balance its foundational values with a pragmatic approach to influence and security in a multipolar world. Turn of the tide in Myanmar?

yanmar's ruling junta is facing defeat LV Louster, which will happen sooner than most people think. The latest, and one of the most serious, reverses suffered by the Sit-Tat (Myanmar's Army's name), has been the fall, on October 8, 2024, of the township of Pinlebu to the Kachin Independence Army (KIA), an important part of the coalition of forces fighting the junta, and its allies. Located on the border of the Sagaing Region and Kachin State, its capture opens up to the opposition forces the routes leading to the Kawlin township and the surrounding areas.

Apart from its geo-strategic importance, the township's capture is significant for what it revealed of the Sit-Tat's state. It suffered a resounding defeat. A report by Saw Lin, published in the news website, The Irrawaddy, on October 14, 2024, cites the opposition National Unity Government as claiming that the junta's troops, numbering 800, were defeated despite 670 airstrikes and the dropping of over 5,000 bombs, that around 70 junta soldiers were killed, 275 were missing, 225 were wounded, 48 surrendered and 102 captured during the fighting. Around 400 firearms and other military equipment were seized.

The report further cites Thoe Gvi, the leader of Kawlin District People's Defense Team, as saying that Pinlebu, surrounded by forests and mountains, was easy to defend, and difficult to attack. There had been four attacks since the first one in 2022, each of which had almost succeeded but the regime held on with air support and airlifted troops. The fifth one, which began on August 15, 2024, was successful.

The enemy, Thoe Gyi said, was weak. Those who were forcibly recruited or drafted under the conscription law dared not fight and surrendered when the fighting broke out. Others surrendered after they ran out of food and could no longer fight. The Sit-Tat suffers from other weaknesses as well. There is discord within.



ficers are unhappy as they recognise that almost the entire country is against them.

Prior to Pinlebu, anti-junta forces had captured four towns in northern Mandalay. According to a report by Andrew Nachemson published in Al Jazeera dated September 23, 2024, their capture had placed them within striking distance of the city of Mandalay, Myanmar's second largest urban centre, with a population of nearly two million.

In fact, the Sit-Tat has suffered a series of reverses since the opposition Three Brotherhood Alliance (henceforth the Alliance) launched its offensive, codenamed Operation 1027, on October 27, 2023. Comprising the Myanmar National Democratic Alliance Army (MNDAA), active in the Kokang Special Region of northern Shan State, the Ta'ang National Liberation Army (TNLA), also active in the Shan State and the Arakan Army (AA), based in the Rakhine State in the country's western part, it has been acting in close cooperation with the opposition National Unity Government's military arm, the People's Defence Force (PDF) and other ethnic armies like the Karen National Liberation Army (KNLA) and Karen National Army,

The AA had brought almost the entire Rakhine State under its control by April, 2024. In a major development, the MNDAA claimed on July 31, 2024, that it had captured Sit-Tat's military base in Lashio, a city in Shan State close to the border with China, and its airport. The opposition forces now control large swathes of territory along Myanmar's borders and mountainous region; the military retains control over the major cities and lowlands in the central Irrawaddy Valley. It is losing even the cities and towns. As Vivek Shankar has stated in the article cited above, the forces resisting the junta now held "roughly 75 cities and towns across Myanmar and two airports, one in Thandwe in Rakhine State in the west, and the other in

The odds are now rapidly increasing against the Junta. The latter doubtless has tanks and other armoured vehicles, artillery and air force. Tanks and armoured vehicles are very difficult to deploy in the areas dominated by the ethnic forces. With densely forested mountainous terrains, deep gorges and steep climbs, these are ideal for staging ambushes. Moreover, air-strikes and artillery do not win wars, even when backed by heavily armed and trained infantry. Otherwise, the United States would have romped to a victory in Viet-

Can the junta see the writing on the wall? During its 8 p.m. news broadcast on September 26, 2024, the junta seemed to offer, for the first time, a major concession to the opposition armed resistance groups. It said in a statement, "The state lost a large

number of human resources, infrastructures, lives and property of the people due to the fact some individuals and organizations chose to resort to armed terrorism and armed struggle line without political problems through political ways." Given the statement's accusatory undertones and unbelievable inherent irony, it is hardly surprising that several commanders of the rebel forces, ethnic armies, and the opposition NUG government, promptly rejected the offer.

A report (datelined September 27, 2024) by Sui-Lee Wee in The New York Times, quoted Ye Myo Hein, a visiting senior expert for the Myanmar programme of the United States Institute for peace, as saying, "The reason they made this announcement is to appearse China." It could well be so.

As Wee points out in her report, while expressing support for the junta, Beijing has also been engaged in talks with northern Myanmar's ethnic armed groups. According to the report, China's foreign minister, Wang Yi, had travelled to Myanmar in August, 2024, to urge the country's army chief, Senior General Min Aung Hlaing, to pursue political reconciliation and hold elections. Earlier, in a meeting with Myanmar's president, Thein Sein, in China in June, Wang Yi had also called on the military to hold talks with Aung San Suu Kyi, who is currently serving a 27-year prison term on totally false charges.

There is no indication that the junta has any intention of holding talks with Suu Kvi. In fact, in an interview to Myein Myein carried in The Irrawaddy on October 24, 2024, her son, Kim Arris, said she had been kept completely incommunicado in prison in Naypyitaw with even her family and lawyers barred from meeting

The conditions in the prison being terrible and with Suu Kyi having serious health issues, he expressed the fear that she might die in prison, which may well happen. In that case, the burden of guilt not only be on the junta but the Western democracies which seem no longer bothered about developments in Myanmar.

The fact that an agreement between China and India to move forward on the Line of Actual Control (LAC) was in the works has been anticipated in both capitals. Since late 2022, both governments have pursued a modus vivendi for disengagement at Depsang and Demchok, with the issue discussed threadbare in the Corps Commanders' meetings. The 17th Corps Commanders' meeting on 20 December 2022 marked a critical point. Following the establishment of five buffer zones in Eastern Ladakh and the Yangtse clash on 9 December 2022, the meeting provided an indepth dialogue on the disengagement frameworks and probable solutions. In the next two years, these frameworks were substantially refined by both militaries which received the political endorsement this year.

This agreement has initiated the disengagement process at both remaining locations. As discussed below, a review of the leadup to the Kazan agreement, its specifics on the ground and perspectives on this agreement from China, indicates that within strategic and political constraints, the agreement is a constructive restart for both states, though tempered with cautious optimism.

The buffer zones and their

complexities By September 2022, China and India had established five buffer zones at Pangong Tso Lake from Fingers 4-8, Gogra, Hot Springs, Kugrang Nullah and the Galwan Valley. This belt of buffer zones was aimed to separate both forces from their face-toface deployments and was located mostly on the Indian side of the LAC, creating a distance of 3–10 kilometres between both sides and establishing restrictions on human patrolling or grazing temporarily. Only electronic surveillance was allowed. The denial of grazing received substantial criticism in India as these areas were traditional grazing grounds for the local population. However, the Indian government argued that if they could not patrol or graze in these buffer zones, neither could the Chinese and that ensured stability and peace in these areas.

This belt of buffer zones was aimed to separate both forces from their face-toface deployments and was located mostly on the Indian side of the LAC, creating a distance of 3–10 kilometres between both sides and establishing restrictions on human patrolling or grazing temporarily.

The negotiation for achieving a similar modus vivendi in Depsang and Demchok proved difficult. The standoff in these two places was a legacy issue, starting in 2008-09 and eventually becoming a part of the 2020 Galwan Clash discourse.

After surveying this area in September 2013, the Shyam Saran Committee reported that the Chinese were not allowing the Indian Army patrol units to access patrolling points 10 to 13 in the Depsang bulge area and creating difficulties for patrols in the Sirijap and Demchok area. Therefore, these two locations proved to be the toughest to negotiate.

Nevertheless, the Indian establishment displayed adept negotiation skills, finally securing the Kazan Agreement. This accord avoids creating buffer zones in the area, allowing staggered patrolling by small patrol units from both sides. Indian troops can finally access patrolling points 10 to 13 in this region again.

Economic foundation for the political agreement

Since the 2020 clashes, China-India relations have stagnated, marked by miniengagement across trade, economics and regional political fronts. India, stepping away from its oftprofessed neutral politics, has actively engaged in the Malabar Exercises and the cidence, they argue, that the *ORF*)



sure upon India on the Khalistan issue and has threatened to adopt severe measures if India does not cooperate. Simultaneously, other Western powers continue to court India and lure it into the "trap of replacing China". For example, Chinese scholars note with conhow Chancellor Scholz recently led a delegation to India, promising the strengthening of German-Indian economic cooperation while publicly promoting a "de-risking from China" strategy and projecting India as an alternative to China.

However, while appreciating the development, Chinese scholars advise caution given the structural differences in China-India ties. There seems to be a consensus within the Chinese strategic community that "the border agreement signed by China and India does not mean that all issues have been resolved. The agreement's implementation, the progress of subsequent negotiations, and whether the two sides can trust each other are all important factors in the future of China-India relations. The signing of the agreement is only "a starting

the future development path of China-India relations is still full of potholes and slippery slopes. The two sides still face the possibility of a sudden escalation in conflicts and differences because the borderline has not yet been fully deter-

In addition, the future direction of the China-US-India trilateral relationship is full of uncertainty. The US elections, scheduled for November 2024, will also impact China-India relations. China will keep a keen eye on how India can maintain good relations with China while maintaining cooperation with the United States in the future.

Similarly in India, the disengagement at Depsang and Demchok is ongoing, and the patrolling may begin around Diwali. However, hereafter both sides must negotiate de-escalation and deinduction and future access and patrolling in existing buffer zones. The completion of this process will bring back a modicum of sensitivity towards each other's red lines and may generate mutual respect. The Kazan Agreement, in sum, has reduced the animosity and mistrust and opened the scope for bilateral cooperation. How performative outrage on social media is hampering Indian Muslims

very time I log into my social media accounts, including WhatsApp, I am con-✓ fronted with an endless stream of posts about the suffering of Muslims around the world. From the oppression of the Palestinians to the authorities in Indian states bulldozing homes, from protests against state brutality in Uttar Pradesh's Bahraich to the systematic discrimination faced by Indian Muslims, my timeline is a relentless reminder of collective pain.

Amidst this flood of distressing content, I have been noticing a troubling trend within the Muslim community itself: an overreliance on performative outrage that rarely translates into tangible action.

Illusion of activism

Take, for example, a well-known influencer in the Indian Muslim community. Over the years, I have observed his social media presence grow significantly. He has amassed thousands of followers, many of whom look to him for guidance. He frequently shares posts about the rising tide of anti-Muslim sentiment in India, showcasing incidents of violence and systemic

But despite his ability to amplify these issues, I often find myself frustrated by the absence of solutions. Instead of encouraging community organising or local activism, his posts, like many others, focus solely on Muslim victim-

I often ask myself whether any good will come from raising awareness if it does not lead to action. Scrolling past his latest viral video of communal violence, captioned, "When will the world wake up?", I cannot help but feel that we are stuck in a loop – constantly highlighting suffering but offering no roadmap for alleviating

I do know a few people working on both problem-solving and community-building, but their efforts are overshadowed by the sheer vol-

ume of performative social media posts. In this cycle, many well-meaning individuals have unintentionally become conduits for out-

Capitalist exploitation of activism

Social media, in its dual role as a platform for marginalised voices and a profit-driven ecosystem, has transformed activism into a commodity. It provides visibility for important causes but it also exploits these narratives for clicks, shares and likes.

Many young Muslims have internalised the notion that sharing distressing content is equivalent to activism – that raising awareness alone is enough to bring about change. But real activism requires more than just raising awareness

- it requires engagement, planning and action. I have watched as my peers flood their feeds with outrage-laden posts, believing their online presence constitutes meaningful activism. Yet. as their followers grow and their perceived influence expands, it becomes clear that many are more focused on building personal brands than

planning and action

working towards solutions.

This commodification of outrage fuels the capitalist machinery of social media, where emotions – anger, grief, frustration – are turned into consumable content. The very platforms that profit from our pain are designed to keep us trapped in cycles of fear, outrage and helplessness.

Cycle of fear and hate

Many fail to realise that by constantly sharing videos of violence or discrimination, they are inadvertently reinforcing fear and victimhood. Rather than empowering the community, they perpetuate a sense of helplessness. They thrive on crises because crises generate content.

Instead of organising locally, joining protests or engaging in community-building, they curate online personas, share viral videos, and tweet their outrage, believing they are making a difference. But what do these heart-wrenching images and videos do for the community beyond stirring emotions?

The validation they receive – likes, shares, retweets – creates only the illusion of empowerment. The social media landscape has projected them as activists, yet there is a hollow core at the centre of this engagement. They are using the struggles of their community to boost their online visibility. It is all about capitalising on the moment, often without recognising that their emotional expressions – anger, grief – are being exploited by algorithms designed to fuel the very cycle they are trying to escape.

Mental health, community confidence

This culture of performative outrage also has significant ramifications for mental health. The constant exposure to negative messages not

only diminishes self-confidence but erodes overall mental well-being. Many of us spend countless hours on social media, often using it as a distraction from our real-life responsibilities and challenges. This cycle of outrage and helplessness leaves many feeling demoralised and disillusioned.

Many choose to limit their discussions of these issues to chat rooms or social media spaces, which often lack the nuance and care necessary to foster real dialogue

It would make a world of difference if these influencers, who are assumed to be social media activists, actually visited marginalised communities and offered reassurance to those most affected by systemic discrimination. It would go a long way in providing emotional relief and fostering a sense of solidarity if they were to reach out with a simple message: "We are here for you. Let us know if you need anything."

Beyond social media Being socially and politically aware requires more than just WhatsApp messages, posting on social media, or retweeting outrage. The challenge lies not only in addressing the injustices faced by Muslims in India but in reshaping the narrative – from one of fear and victimhood to

one of empowerment and agency. While social media can amplify voices, it is the actions taken offline that truly matter. The time has come for a collective awakening, one that moves beyond sharing stories of horror and starts creating stories of hope and progress. Our community needs to reclaim its narrative, not as passive victims, but as active agents of change capable of forging a better future. (Courtesy:

Federal Reserve is set to cut interest rates again as post-election uncertainty grows

Reserve officials are poised Thursday to reduce their key interest rate for a second straight time, responding to a steady slowdown of the inflation pressures that exasperated many Americans and contributed to Donald Trump's presidential election victory.

Yet the Fed's future moves are now more uncertain in the aftermath of the election, given that Trump's economic proposals have been widely flagged as potentially inflationary. His election has also raised the specter of meddling by the White House in the Fed's policy decisions, with Trump having proclaimed that as president he should have a voice in the central bank's interest rate decisions.

The Fed has long guarded its status as an independent institution able to make difficult decisions about borrowing rates, free from political interference. Yet during his previous term in the White House, Trump publicly attacked Chair Jerome Powell after the Fed raised rates to fight inflation, and he may do so again.

The economy is also clouding the picture by flashing conflicting signals, with growth solid but hiring weakening. Even so, consumer spending has been healthy, fueling



concerns that there is no need for the Fed to reduce borrowing costs and that doing so might overstimulate the economy and even re-accelerate inflation.

Financial markets are throwing vet another curve at the Fed: Investors have sharply pushed up Treasury yields since the central bank cut rates in September. The result has been higher borrowing costs throughout the economy, thereby diminishing the benefit to consumers of the Fed's half-point cut in its benchmark rate, which it announced after its September

The average U.S. 30-year mortgage rate, for example, fell over the summer as the Fed signaled

that it would cut rates, only to rise

again once the central bank actu-

ally cut its benchmark rate. Broader interest rates have risen because investors are anticipating higher inflation, larger federal budget deficits, and faster economic growth under a Presidentelect Trump. In what Wall Street has called the "Trump trade," stock prices also soared Wednesday and the value of bitcoin and the dollar surged. Trump had talked up crypacross-the-board increase in tariffs that Trump has proposed.

Trump's plan to impose at least a 10% tariff on all imports, as well as significantly higher taxes on Chinese goods, and to carry out a mass deportation of undocumented immigrants would almost certainly boost inflation. This would make it less likely that the Fed would continue cutting its key rate. Annual inflation as measured by the central bank's preferred gauge fell to 2.1% in September.

Economists at Goldman Sachs estimate that Trump's proposed 10% tariff, as well as his proposed taxes on Chinese imports and autos from Mexico, could send inflation back up to about 2.75% to 3% by mid-2026.

Such an increase would likely upend the future rate cuts the Fed had signaled in September. At that meeting, when the policymakers cut their key rate by an outsize half-point to about 4.9%, the officials said they envisioned two quarter-point rate reductions later in the year — one on Thursday and one in December — and then four additional rate cuts in 2025.

Naqvi's visit to the Chinese mission to meet Ambassador Jiang Zaidong comes two days after a local security guard opened fire at two Chinese nationals on Tuesday following a quarrel in the port city of Karachi.

According to a statement, Naqvi regretted the firing incident in Karachi in which two Chinese citizens were injured.

Both sides agreed to devise a joint strategy

to prevent such incidents in the future. Naqvi underscored that the protection of Chinese citizens remains a top priority, especially in light of the China-Pakistan Economic Corridor (CPEC) projects, which are integral to the bilateral partnership.

"All possible steps are being taken to secure a peaceful environment for Chinese nationals working in Pakistan," he said, adding that those responsible for the Karachi attack would be brought to justice.

Naqvi also conveyed condolences to the victims and their families, providing updates

Both sides discussed strategies to prevent similar incidents in the future, with a commitment to enhancing bilateral security cooperation and the safety of Chinese workers in

The ambassador thanked the minister for the recent security measures during the Chinese premier's visit and conveyed a message from President Xi Jinping to Pakistan's President Asif Ali Zardari, wishing him a swift recovery.

The meeting was attended by senior officials from Pakistan's interior ministry and the Chinese embassy, with discussions highlighting the ongoing growth in Pakistan-China cooperation and the need for a stable environment to support this alliance.

This was the third incident involving attacks on Chinese or other foreign nationals in

In October, two Chinese engineers working at the Port Qasim terminal were killed when a suicide bomber struck the vehicle carrying them near the Karachi airport.

The issue of security of Chinese nationals is a moot point between Pakistan and China. The two sides openly differed for the first time when the Chinese ambassador last week expressed concerns over the security of Chinese nationals in Pakistan.

In response, Pakistan foreign office spokesperson Mumtaz Baloch termed his views as "perplexing", while saying that Pakistan is committed to providing full security to Chinese nationals, projects and institutions in

LONDON, Nov 7: British Prime Minister Keir Starmer touched upon a range of topics, including defence and regional security, during his congratulatory phone call with US President-elect Donald Trump after a "historic" election victory.

During the call on Wednesday evening, both leaders agreed to work towards strengthening the "incredibly strong" US-UK special relationship and committed to ensure the bilateral ties continue to thrive. "The Prime Minister offered his hearty congratulations and said he looked forward to working closely with President-elect Trump across all areas of the special relationship. From defence and security to growth and prosperity, the relationship between the UK and US was incredibly strong and would continue to thrive for many years to come, the leaders

agreed," a Downing Street spokesperson said. Starmer is said to have also reflected on the situation in the Middle East and "underscored the importance of regional stability". They went on to discuss their recent meeting at Trump Tower when Starmer was in New York for the United Nations General Assembly. "The leaders fondly recalled their meeting in September, and President-elect Trump's close connections and affinity to the United Kingdom and looked forward to working with one another," Downing Street added.

The phone call came after a heated first exchange between Starmer and the newly elected UK Leader of the Opposition Kemi Badenoch in the House of Commons.

Trump won the US presidential election for a second term on Wednesday in one of the most remarkable comebacks in American electoral history.

Xi, in his congratulatory message to Trump, called for the two countries to strengthen dialogue and communication, properly manage differences and expand mutually beneficial cooperation, official media reports here said. "I urge China and the US to expand mutually beneficial cooperation," Xi said. "I call for the right way for China, and the US to get along in the new era," he said, adding that both the countries, the top two economies of the world, should strengthen dialogue and communica-

History teaches that China and the United States gain from cooperation and lose from confrontation, Xi said, noting that a stable, sound and sustainable

shared interests and meets the aspirations of the international community. He expressed the hope that the two sides will uphold the principles of mutual respect, peaceful coexistence and win-win cooperation, strengthen dialogue and communication, properly manage differences and expand mutually beneficial cooperation. Also on Thursday, Chinese Vice President Han Zheng congratulated J D Vance on his election as vice president of the United States, state-run Xinhua news agency reported.

As the results of the US presidential elections poured in on Wednesday pointing to a sweeping victory for Trump, who pursued a tough policy against China in his first term including clamping tariffs on over USD 380 billion Chinese exports to the US, Beijing reacted guardedly and said that it respects the choice of the American people.

Our policy towards the United States has been consistent and we will continue to view and handle the China-US relations in accordance with the principles of mutual respect, peaceful coexistence and spokesperson Mao Ning told a media briefing here.

She dismissed the question on Trump's campaign promise to sharply raise tariffs on Chinese imports, higher than his first term. "We do not respond to hypothetical questions," she said. The return of Trump as US President for a second term after a gap of four vears has increased Beijing's anxieties especially when the Chinese economy faced a serious slowdown resulting in a declining growth rate and business environment with job losses and increased unemployment. In its flash editorial on Trump's re-election, state-run China Daily said his victory "could mark a new beginning in the China-US relations if the chance that has been offered is not wasted. When should kids start using social media? Australia's government proposes age limit of 16

MELBOURNE, Nov 7: The Australian government announced on Thursday what it described as world-leading legislation that would institute an age limit of 16 years for children to start using social media, and hold platforms responsible for ensuring compliance.

"Social media is doing harm to our kids and I'm calling time on it," Prime Minister Anthony Albanese said.

The legislation will be introduced in Parliament during its final two weeks in session this year, which begin on Nov. 18. The age limit would take effect 12 months after the law is passed, Albanese told reporters.

The platforms including X, TikTok, Instagram and Facebook would need to use that year to work out how to exclude Australian children younger than 16.

"I've spoken to thousands of parents, grandparents, aunties and uncles. They, like me, are worried sick about the safety

of our kids online," Albanese said. The proposal comes as governments around the world are wrestling with how to supervise young people's use of technologies like smartphones and social

Social media platforms would be penalized for breaching the age limit, but under-age children and their parents

Hindu temple in Brampton suspends priest for spreading 'violent rhetoric' OTTAWA, Nov 7: The priest of

a Hindu temple in the Canadian city of Brampton has been suspended for spreading "violent rhetoric" during recent clashes between protesters carrying Khalistani flags and the people present there.

On November 3, the protest occurred at the Hindu Sabha temple in Brampton and unverified videos circulating on social media appeared to show demonstrators holding banners in support of Khalistan. The videos showed fist fights and people striking each other with poles on what appears to be the grounds

surrounding the temple. The protestors carrying Khalistani flags clashed with people and disrupted a consular event co-organised by the temple authorities and the Indian Con-

On Wednesday, a statement from the Hindu Sabha Mandir said the suspension was due to the priest's "controversial involvement" with protesters on Sunday, but did not elaborate, the Canadian Broadcasting Corporation reported.

Taking to X, Brampton

Mayor Patrick Brown said the priest spread "violent rhetoric," asking the community not to respond to violence and hate.

"This is leadership that is helpful. The vast majority of Sikh Canadians and Hindu Canadians want to live in harmony and don't tolerate violence. Hindu Sabha Mandir President Madhusudan Lama has suspended the pundit who spread violent rhetoric. The Ontario Sikhs and Gurdwara Council denounced the acts of violence at the Hindu Sabha on Sunday night," Brown said in the post.

"Remember we all have more in common than what divides us. In tense times, we can't let the agitators fuel the flames of division. The leadership of both Sikh and Hindu communities in the GTA do not want this division, hate and violence. I am asking everyone in the community to not respond to violence and hate. Giving the reasons, the LNC cited the alleged incident involving Committee on Tribal Unity (COTU) on October 29, 2024. The Liangmai body said that, on the day, Lamminlun Singsit, general secretary of the Committee on Tribal Unity (COTU) issued a highly provocative statement, calling the visit of Chief Minister of Manipur, N. Biren Singh along with his cabinet ministers to Senapati district for the Liangmai Chaga Ngee celebrations a "trespass" and a "dangerous provocative act." The LNC also alleged that Singsit further incited tensions by claiming that the visit would be an intrusion into Kuki-majority areas and that it would lead to disturbance and direct threat to Liangmai people. "This statement is deeply misleading and unacceptable. The Liangmai community, along with other Naga communities in the region, perceives these remarks as a direct threat to our peace, unity, and cultural heritage. It is clear that COTU's actions were intended to provoke conflict and escalate tensions within the region, especially between the Liangmai Nagas, Kukis, and other communities. Such provocative rhetoric only serves to deepen existing divisions, especially in a time when efforts for reconciliation and unity are needed more than ever," the LNC memorandum

Manipur: Thadou Community rejects Kuki identity urges respect for distinct heritage

Community International (TCI) said that the Kuki National Front (KNF), a Suspension of Operation (SoO) group, issued a press communique on November 4, 2024 circulated through social media against the declaration of the Thadou Convention 2024 that Thadou is not Kuki.

In a statement issued today, the TCI said, "Firstly, we would like to bring to the notice of all concerned that Thadou Community International (TCI) was formed on August 3, 2024 with the initiative and participation of Thadou people living in different parts of the world, including Manipur (India,) which is home to Thadous". With Thadou people being the most victimized in the current Manipur crisis and at the same time being silenced with no one to highlight their plight, the need for a platform to raise the suppressed voice of Thadous was immensely felt, leading to the formation of TCI, the statement also said. The TCI said it sought to preserve and protect the non-negatable Thadou distinct identity, culture, customs, traditions, costumes.

The TCI also said it would like to address the issues raised by the KNF regarding "our stance on the distinct identity of Thadou and not belonging to Kuki". The statement added, "We are glad to know that the KNF is keen on envisaging their idea of inclusivity of pan-Kuki where there is no subjugation of any tribe by any means or method. However, the allegation of the declaration of Thadou not being Kuki is an attempt to divide the community, is without any merit or basis"

The statement then said, "On the contrary, it is an open secret that Kuki organisations are dominated and run by Thadou speaking people who have dissociated themselves from Thadou tribe, clinging onto the new fake tribe called Any Kuki Tribes (AKT) that was fraudulently added to the list of Scheduled Tribes of Manipur in 2003 for political reasons. Kuki is not accepted by any of the non-Naga tribes in the state of Manipur, except AKT," it further added.

The TCI then said that, the irony is that the very people who claimed to represent the Thadou tribe are now indulging in suppressing the voice of self-assertion in the name of faux unity. The TCI further said the idea of Kuki being an umbrella organisation of kindred tribes had dissipated and became irrelevant a long time ago and it remains a utopian dream. "So, there is no question of an attempt to cause any division within

that remains today is AKT. The sooner this is accepted the better it will be for all. It is an undeniable fact that kindred tribes like Paite, Vaiphei, Zou, Simte etc have identified themselves under the collective nomenclature Zomi, which is not a tribe, or the name of a particular tribe," the statement also said. Tribes under the collective Zomi nomenclature and Hmar tribe all exist as distinct independent tribes but not Kuki, it further said. There is no logic for an independent ethnic tribe to be under another tribe, that too a fake

one, like the AKT, it added. The TCI also clarified the KNF statement where it stated that, for a tribe to declare that they are not Kuki-Zo is equivalent to saying they are a different people, like Tangkhul, Mao, Meitei, Pangal etc. The declaration of detachment and disowning of colonial tag Kuki by Thadou is in fact equivalent to Thadou maintaining its distinct tribe status like the status of Tangkhul or any other distinct tribe, the TCI said.

According to the TCI, the KNF statement added that they believe "Kuki-Zo" people cannot get a Separate Administration from Manipur other than in the name of Kuki. To this, the TCI CI pointed out that the term "Kuki-Zo" is also ambiguous "as it deviates from the unilateral stance of one Kuki as it does not define the components of the two hyphenated words". Further, the Zomi, Hmar and Mizo brethren do not accept the post-May 3, 2023 term 'Kuki-Zo', which is construed to represent only Kuki, an apparent attempt to elevate the stature of Kuki equal to the broader term 'Zo'", the TCI

The TCI said the quest for peace for Thadou people will continue for the all-round development of the Thadou people. It also said conflicts between nations or communities do occur in various parts of the world. "However, there comes a time for reconciliation as there can be no progress and development without any solution. All the affected communities have to find the path to resolve the current crisis in Manipur through non-violent means".

it stated. The TCI said it understood that the KNF is for a separate administration in the name of Kuki, "but TCI being an apolitical organisation, we have no political interest or agenda against the political de-

mands of any organization". The TCI then said it took strong exception to the line in the KNF's statement that translates as "We are currently still fighting a war, tions or kidnapping, death penalty etc within the community." This implies threats and intimidation against Thadous to denounce their distinct identity from Kuki, but to be Kuki or accept Kuki, or else they will face dire consequences, the TCI explained.

This statement is uncalled for in a civilized society. Threats and intimidation may deter people but the determination and ideology will not vanish without leaving a mark. Rampant and widespread Kuki supremacy, intimidation, suppression, coercion, control, human rights violations and extreme actions like physical violence and death penalty by Kuki militants and Kuki supremacists against Thadou is the very reason

why the declaration was made. "We would appreciate it if the KNF and other Kuki militant groups respect the rights of Thadous with full dignity as a distinct identity. Kuki supremacy or any supremacist agenda is against the law of the land and Indian Constitution which guarantee the right to live with dignity under Article 21," the TCI also said.

The TCI then said that, any rhetoric or narrative that mis-portrays Thadou and other kindred tribes as Kuki, or a part of Kuki, is an attempt to impose Kuki on non-Kuki tribes and is simply another example of Kuki supremacy and its agenda against the original 29 tribes or indigenous/native tribes and communities, who have each been recognised as a separate distinct tribe by the Government of India under the 1956 Presidential Order.

The TCI said the KNF statement also made threats to an unnamed Manipur State Government officer for remaining in Imphal and accusing him of doing his duty as a government employee as appeasing the CM of Manipur. "If the KNF is bothered with the discharging of duties of a government employee, why not ask the 10 Zo tribal MLAs to withdraw from the government headed by the CM, which all the MLAs still support and are still part of. This is a self-contradictory stance and does not have a merit ground," the TCI also said.

The TCI then reiterated and "firmly stands" by the Thadou Convention 2024 declaration and resolutions. The TCI urged all stakeholders to engage in constructive dialogue and work towards a harmonious resolution rather than spreading hatred and issuing threats. It also said Thadous do not need Kuki permission or interference to assert "our distinct identity". (NNN)

14, 000 cases to be address in Tripura

AGARTALA, Nov 7: A Special Lok Adalats will be held across all the District and Sub-Divisional Courts of Tripura on Saturday, November 9.

Jhuma Datta Chowdhury, Member Secretary of the Tripura State Legal Service Authority said in a press statement that over 14,223 pending cases are set to be addressed in this one-day effort, with the aim of resolving disputes through amicable settlements.

"The cases taken up will cover a wide range of issues, including 9,756 traffic-related cases under the Motor Vehicles (MV) Act, 3,832 cases under the Tripura Po-

lice Act, 122 under the Tripura Gambling Act, 441 related to the Tripura Excise Act, 31 cheque bounce cases under the Negotiable Instruments (NI) Act, 7 forest-related criminal cases, 27 cognizable criminal cases, and 7 cases under the Animal Act", she said.

She said that to manage the volume, 24 special benches have been constituted for these Lok Adalat, with a maximum of 5 benches operating in Khowai district alone.

Safeguarding country's integrity duty of every citizen: Manipur CM

India's unity reaffirmed in response to Zo unification remarks

IMPHAL, Nov 7: Manipur Chief Minister N Biren Singh on Thursday asserted that safeguarding the integrity of the country is the duty of every citizen and no one can challenge the state's sovereignty.

His remarks came in response to a question by a reporter about Mizoram Chief Minister Lalduhoma's comments during his visit in September to the US. Lalduhoma reportedly expressed support for the unification of the Zo people under a single leadership and said "even if it meant transcending national borders"

Zo is a term to denote different groups of related tribes sharing cultural and linguistic affinities and living in parts of the Northeast, Chittagong Hill Tracts of Bangladesh, and Myanmar's Chin

Singh said, "I don't want to react or comment on him (Lalduhoma). As a proud Indian, as the Chief Minister of Manipur, and as a nationalist, no one can touch India's integrity and Manipur's integrity. India is not just a country, it is a big



country, and we should be proud to

He stressed that his position was clear, stating that the unity and integrity of India must be preserved at all costs

"I don't want to comment on others' personal views, but my stand is very clear—to maintain the unity and integrity of India. Keeping India strong is our duty, and anyone who challenges it will be given a befitting reply," Singh told reporters after attending a school function in Imphal.

According to the website of Mizoram government's Directorate of Information and Public Relations, Lalduhoma, while addressing the Zo diaspora in the US in September, said, "We are one peoplebrothers and sisters—and we cannot afford to be divided or apart from one another. I want us to have the conviction and confidence that one day, through the strength of God, who made us a nation, we will rise together under one leadership to achieve our destiny of nationhood."

He added, "While a country may have borders, a true nation transcends such limitations. We have been unjustly divided, forced to exist under three different governments in three different countries, and this is something we can never accept.

Mizoram shares a 510-km long border with Myanmar's Chin state and the Mizos share ethnic ties with the Chins.

Lalduhoma had earlier said that people in Mizoram and Myanmar do not accept the present border as it was demarcated and imposed by the British on the Mizo people without consulting them. (PTI)

While Leader of Opposition Sunil Sharma (BJP) was speaking on the resolution, Awami Ittehad Party leader Sheikh Khursheed jumped into the well with a banner that read Articles 370 and 35A be

This irked the BJP members, who also jumped into the well, snatched the banner from the Langate MLA and tore it into pieces.

There was a minor scuffle between the BJP MLAs and Khursheed. Finding the latter outnumbered, Peoples' Conference MLA Sajad Lone came to the rescue of the legislator from his neighbouring constituency.

Amid the din, Speaker Abdul



Rahim Rather adjourned the House for 15 minutes.

After the House resumed its proceedings, the BJP continued its protest, even as the speaker requested the opposition members to take their seats.

As the protest continued, the speaker said, "I am very closely watching the activities of some members. Do not force me to do what I do not want to do.3

Sharma, however, said "I want the National Conference's drama of special status to end", which infuriated the ruling party members.

Maharashtra polls: No direct fight but BJP still jittery about Jarange factor in Jalna

JALNA, Nov 7: Activist Manoj Jarange may have decided not to field candidates in the upcoming Maharashtra polls but continues to make the BJP nervous in Jalna district, the epicentre of Maratha agitation, political observers have

The BJP had won three key constituencies - Bhokardan, Partur and Badnapur – in the district in 2019 and is trying to retain them, although the political and social landscapes there have seen tectonic shifts, they said.

The party has renominated twoterm MLA Santosh Danve, son of former Union minister Raosaheb Danve, from Bhokardan, Babanrao Lonikar in Partur and Narayan Kuche in Badnapur constituen-

However, in the past five years. while Shiv Sena and NCP have split, Jalna has seen massive protests by the Maratha community led by Jarange demanding reservation in education and government jobs.

Jarange has repeatedly targeted the BJP warning that the community would defeat its candidates in the assembly polls, which will be held on November 20. He, however, recently decided not to field candidates in the polls.

Marathas comprise about 32 per cent of the population in the district, a part of the state's Marathwada region with 46 assembly

BJP's ally Shiv Sena, led by Chief Minister Eknath Shinde, has fielded candidates in the Ghanswangi and Jalna seats in the dis-

In Bhokardan, where 32 candidates are in the fray, the main contest is between Santosh Danve and NCP (SP) candidate Chandrakant Danve, a three-term MLA. Union ex-minister Raosaheb Danve lost from Jalna in the Lok Sabha elections earlier this year, with political observers pointing to the Jarange factor.

Santosh Danve had defeated Chandrakant Danve by 32,000 votes last time.

In Partur, two-time MLA and former minister Babanrao Lonikar faces Shiv Sena (UBT) candidate Asaram Borade and Congress rebel Suresh Jethliva, Jethliva, the former head of the Partur Municipal Council, enjoys local support.

While the division of votes between Borade and Jethliya might help Lonikar, the Maratha and Banjara communities are likely to play a pivotal role in deciding the winner in Partur constituency, said a political observer.

In the reserved constituency of Badnapur, two-time MLA Naravan Kuche faces off against Roopkumar Bablu Choudhari of the NCP (SP). The Maratha votes could have a significant impact on the outcome here as many from the community have voiced dissatisfaction with Kuche. (PTI)

Baneriee, a member of the JPC on the Waqf Amendment Bill, said the chairman of the JPC, BJP's Jagdambika Pal, has fixed a hectic schedule of meetings in Guwahati, Bhubaneswar, Kolkata, Patna and Lucknow over six days, with Sunday being a holiday in between.

All the opposition members of the JPC have decided to boycott the tour and its meetings as the chairman is working in an arbitrary and high-handed manner, Banerjee told reporters at a press conference jointly addressed with party MP Nadimul Haque at the Press Club here.

He said the future course of action will be decided jointly

by the members of the opposition.

Banerjee said the opposition members of the JPC met the Lok Sabha Speaker on November 5 and sought deferment of the schedule and also reduction in the number of days of meetings of the JPC from two days a week to one day a week or two consecutive days every fortnight.

He said the Speaker had verbally agreed to sympathetically consider their demands and speak to the chairman, but nothing happened thereafter.

Banerjee also alleged that the process in which the chairman of the committee was proceeding was violative of wellestablished parliamentary norms.

He also alleged that the members belonging to the ruling dispensation were working as per their own agenda and "not in the interest of the nation"

Stating that the members, as MPs, also have other impor-

Banerjee said that the hectic schedule of meetings of the JPC -- two days a week, was affecting those.

disrespect towards tribal women. "These flags are a warning to others not to clash with these 'sons of soil' of a particular party," Soren said, emphasising the growing in-fluence of these infiltrators in the

"Our ancestors fought to protect our land, daughters, and livelihoods from the British, but now it's under the control of these infiltrators," he added. There are dozens of villages,

PANAJI, Nov 7: Chief Minister Pramod Sawant, who has now become the longest serving CM of Goa, has earned praise from his party colleagues and political analysts for striving to provide a stable government in the state. Goa assembly speaker Ramesh

Tawadkar's recent decision to dismiss the disqualification petition of the Congress against eight MLAs who switched over to the BJP has further cemented the coastal state's political stability, say experts.

BJP leader Sawant, who took over reigns of the state in March 19, 2019 after the demise of then chief minister Manohar Parrikar and successfully contested the 2022 election, has now become the longest serving chief minister of Goa after it attained statehood

He is in the chair now uninterrupted for 5 years and 231 days.

Earlier, when Goa was a Union Territory, its first CM Dayanand Bandodkar had a continuous stint of 6 years and 129 days before his



demise, his daughter Shashikala Kakodkar ruled the state for 5 years and 258 days, while Pratapsingh Rane had an uninterrupted stint of 7 years and 134 days.

Local political analyst Siddharth Samant said stability is of utmost importance to the state for its development

"I have seen Sawant maturing as a chief minister, providing a stable government to the state," he

On August 13, the Calcutta High Court ordered the transfer of the probe from the Kolkata police to the CBI, which began its investigation on August 14. (PTI)

Zika virus case detected in Gujarat

AHMEDABAD, Nov 7: A 70year-old man from Gandhinagar city contracted Zika virus infection following which he was treated in a hospital and discharged, officials said on Thurs-

While the report confirming that the man was infected with the Zika virus came four days ago, he was sent home from the hospital a week ago after full recovery, said the Gujarat Health Department in a statement.

Zika virus is transmitted primarily by Aedes mosquitoes. The symptoms include rash, fever, conjunctivitis, muscle and joint pain. Zika infection during pregnancy can cause infants to be born with microcephaly and other congenital malformations as well as preterm birth and miscarriage.

On October 24, the septuagenarian was admitted to a hospital in Gandhinagar after he had a cold, fever and joint pain.

He was referred to an Ahmedabad-based private hospital, where doctors sent his body fluid samples to the National Institute of Virology (NIV) in Pune over the suspicion that it could be a case of Zika infection, said the release.

Following treatment, the patient recovered and was discharged from the hospital about a week ago, said the statement, adding that the man had not travelled abroad in recent times.

Meanwhile, a report that arrived nearly four days ago from NIV confirmed Zika infection.

As a precautionary measure, health authorities visited the area where the person lives and carried out surveillance and tracking exercises, it said.

No person in the area showed any symptoms of Zika infection, said the statement, adding that samples of his family members turned negative for infection. (PTI)

Odisha-based researcher gang raped in Delhi, 3 arrested

NEW DELHI, Nov 7: An Odishabased woman with mental illness who has previously worked as a researcher, was kidnapped and gang raped here in the Sarai Kale Khan area last month and three men have been arrested for it, police said on Thursday.

The victim is receiving treatment for her mental health condition at AIIMS, Delhi after the alleged gang rape on October 10. She travelled to Delhi on May 9 without informing her family which has filed a missing person's report in Puri, they said.

Police said the woman has a postgraduate degree in social work from Utkal University of Culture, Bhubaneswar, has been a research fellow, and has over eight years of experience in the social sector.

She was rescued a day after the alleged rape when she gave an initial statement but could not cooperate further with the police investigation or the hospital staff due to her illness, they said.

Later, a police officer posing as a social worker, with the help of a native Odia speaker, gained her trust over time and gathered crucial information from her. The first arrest was made on October 30 and subsequently, the other two accused were held.

According to police, they received information regarding a woman lying injured and bleeding near Sarai Kale Khan area on October 11.

"The police staff immediately reached the spot, where the victim was found in a state of distress and was rushed to AIIMS Trauma Centre for medical examination and care. Upon arrival at the hospital, the victim disclosed to the attending doctor that she had been sexually assaulted by three people," Deputy Commissioner of Police



After her initial statement, the victim could not cooperate further with the investigation or hospital staff due to her illness, Singh said. Police said she is a dedicated re-

searcher and community leader with over eight years of experience in the social sector. While checking her profile, the

team got to know that she is a postgraduate in social work from Utkal University of Culture She has actively contributed to

various developmental organisations. She also worked as a Research Fellow at Kalinga Network for People Living with HIV/AIDS, Community Leader at Women Power for Sanitation Awareness, and Counsellor at One Stop Centre in Puri," the DCP said.

AIIMS Trauma Centre, and a woman officer Sangeeta took cover as a social worker while a native Odia woman took cover as a nurse and they were assigned to take care of the victim to try to build trust and gather crucial information from her," the DCP said.

He said that Sangeeta won over her trust and was able to get some important details from the victim -- the involvement of an unknown autorickshaw driver who allegedly dumped her after the rape and two other persons, one of who had a physical handicap.

The victim was unable to reveal other crucial details regarding the time and place of the incident due to her mental health challenges and trauma from the incident, he said.

With the limited details, a comprehensive site plan was developed and 700 CCTVs were identified that could give more information. More than 150 suspected autorickshaws were also checked to nab the accused, he said, adding that 10 police teams were involved in it.

On October 30, police arrested Prabhu Mahto, and subsequently, Pramod Babu and Mohammad Shamsul were also identified and arrested on November 2 and November 4, respectively, the officer

Recruitment rules for govt jobs can't be changed midway unless prescribed: SC



NEW DELHI, Nov 7: In an important ruling having a bearing on the recruitment process, the Supreme Court on Thursday held that 'rules of the game' for appointment in government jobs cannot be changed midway unless the procedure permits so.

A five-judge Constitution bench headed by Chief Justice D Y Chandrachud said recruitment process commences from the issuance of advertisement calling for applications and ends with filing up of vacancies.

"Eligibility criteria for being placed in the select list notified at the commencement of the recruitment process can't be changed midway through the recruitment process unless the extant rules so permit or the advertisement which is not contrary to the extant rules so permit," the bench said.

The bench, also comprising Justices Hrishikesh Roy, PS Narasimha, Pankaj Mithal and Manoj Misra, unanimously held if change of criteria is permissible under the extant rules or advertisement, it would have to meet the requirement of Article 14 (right to equality) of the Constitution and satisfy the test of non-arbitrariness.

"Recruiting bodies subject to the extant rules may devise appropriate procedure for bringing the recruitment process to its logical end provided the procedure so adopted is transparent, non-discriminatory, non-arbitrary and has a rationale nexus to the object sought to be achieved," Justice Misra said while pronouncing the

The bench said that extant rules having statutory force are binding on the recruiting bodies both in terms of procedure and eligibility.

"Placement in the select list gives no indefeasible right to appointment. The state or its instrumentality for bona fide reason may choose not to fill up the vacancy,"

However, the bench clarified if vacancies exist, the state or its instrumentality cannot arbitrarily deny appointment to persons who are in the zone of consideration in the select list.

The top court said that if the extant rules or the advertisement provides for setting of benchmarks for different stages of recruitment process and if any such benchmark is set, the same should be stipulated before the commencement of the recruitment process.

"But if the extant rules or the advertisement inviting application empowers the competent authority to set benchmarks at different stages of the recruitment process, then such benchmarks may be set anytime before that stage is reached so that neither the candidates nor the evaluator/examiner/interviewer is taken by surprise," the bench said.

The top court answered a question related to appointment criteria for government jobs referred to it by a three-judge bench in March 2013 Referring to a 1965 verdict, the three-judge bench

had said it was a salutary principle not to permit the state or its instrumentalities to tinker with the 'rules of the game' insofar as the prescription of eligibility cri-



MUMBAI, Nov 7: Maharashtra police's cyber wing has issued a notice to online ticketing website BookMyShow, asking it to implement strict measures including sale of name-based tickets for the concerts of British band 'Coldplay' in

The notice was issued by the Maharashtra Cyber to prevent exploitation of fans who buy tickets from online platforms, an official said on Wednesday. There are increasing number of complaints across online forums and social media about problems faced in booking tickets of such high-profile concerts and

events through online platforms, he said. Many people reported unresponsive websites during critical booking period, he said, adding that it leads to black-marketing of tickets at exorbitant prices, sometimes as high as 10 times the original price.

The Maharashtra Cyber found that measures taken by the platforms to avoid such situations are insufficient, said the official.

A PIL has also been filed in the Bombay High Court seeking guidelines to curb black marketing and ticket scalping at major events, in the backdrop of alleged foul play during the online tickets sale for Coldplay's highly anticipated concert in Navi Mumbai in January 2025.

The PIL said there are several irregularities and illegalities during the sale of tickets for major events, such as concerts, live shows and so on. Such irregularity and illegality was witnessed in September when tickets for the Coldplay concert were made available on the BookMyShow platform, it said.(PTI)

From Delphi to Delhi to Chandigarh, Pythian Games seek revival

NEW DELHI, Nov 7: Once a crucial part of Pan-Hellenic Games, the Pythian Games' revival journey began last year in Delhi after a lull of 1630 years and is now set for its inaugural national edition in Chandigarh.

The Games were first held around 582 BC when Greek god Apollo killed mythical Python and set up the Oracle at Delphi but the Games discontinued in 394 AD, according to the organisers. In Greek mythology, Apollo, by slaying Python, had committed a crime and Zeus, the King of gods, declared that he had to make amends.

Apollo then created the Pythian Games to pay for the death. Pan-Hellenic is the collective term for four separate religious festivals held in ancient Greece: the Olympic Games. which were held at Olympia in honor of Zeus, the Pythian Games, which took place in Delphi and honoured Apollo; the Nemean Games, occurring at Nemea and also honouring Zeus and, finally, the Isthmian Games set in Isthmia and held in honour of Poseidon.

According to the organisers, the Pythian Games were second in terms of importance after Olympics.

While the Olympics were limited to sports, the Pythian Games were a fusion of music, dance, poetry, athletics, wrestling, and chariot racing.

Delphi, a tiny village in Greece was the place for the peace, brotherhood and excellence in the sphere of arts, culture and sports.

People travelled to Delphi to seek fame and glory and showcase their skills. The Games shaped European history in a significant and sustainable way. Inspired by Pierre de Cou-

bertin's revival of Olympic Games, India's Bijender Goel founded International Pythian Games and hosted the Modern Pythian Games in Delhi in December 2023.

Now Goel is gearing up to host the first National Cultural Pythian Games which will have close to 30 events on the roster, including the ancient 'Gada Yudh' at three venues from December 12-15. (PTI)

ing Israel, the West Bank and Gaza in the colours of the Palestinian keffiyeh scarf, which has become a symbol of support for Palestinian people.

The banner also featured a character looking like a masked fighter, a tank, and a Lebanon flag. Below the banner, a message read, "War on the pitch, but

Jurel shines, Rahul fails as India A flounder bounce test



MELBOURNE, Nov 7: Dhruv Jurel showcased his sound technique and cool temperament while wickets fell like ninepins at the other end in another shoddy batting display by India A on the opening day of the second unofficial Test against Australia A at the iconic

Wright was ideal India coach, he gave players free-hand unlike Chappell, Kumble: Sandeep Patil



MUMBAI, Nov 7: The 1983 World Cup winner and ex-chairman of selectors, Sandeep Patil feels John Wright's approach of giving a free-hand to players led to his successful coaching stint with India, something his more authoritarian successors Greg Chappell

and Anil Kumble failed to emulate. In his autobiography -- Beyond Boundaries -- launched here on

Wednesday, Patil gave deep in-

sights in his book about the reason

behind Wright's success as India

coach vis a vis Chappell and Kum-

Patil was privy to several developments of the tumultuous Chappell era as he used to attend selection and board meetings in his capacity as the then India A coach.

"Since 2000, India have had an array of international coaches and support staff. This has paid rich dividends, because India's overseas record has improved steadily. It all started with John Wright becoming India's first foreign coach.

"I think John was the ideal coach r India. He was soft spoken, po-did not suit the Indian dressing for India. He was soft spoken, polite, well-mannered, always kept to himself, and was happy to be in Sourav Ganguly's shadow.

"In addition to all that, he kept a distance from the Press. He managed that so well, that he was hardly in the news — unlike what happened in the Greg Chappell years," Patil wrote in his book.

"With Chappell, he was in the news every day. It is very important for a coach to first understand the policy of that particular board, the thinking of the board members, and the President. He should have a good rapport with the President and the Secretary, and of course the captain and the team. John did that onderfully.

Patil observed that every player was equal and the team came first for Wright.

"...during his tenure, there was no 'seniors' and juniors' business. It was one team. He believed all seniors were leaders in some way, He gave them respect, and a free hand, which I feel Anil Kumble didn't do. Greg Chappell too," he

room atmosphere. "Greg is a very strong personal-

ity; very aggressive. The moment Jagmohan Dalmiya said you have a free hand, he thought that he can change everything overnight. John waited, and learnt the system. Greg wanted to change the entire system, the entire thinking, and the selection process," Patil elaborated.

"He introduced flexibility in the Indian team, and he spoiled things for Rahul Dravid, who took over from Ganguly as captain. Irfan (Pathan) was asked to move up the order. Seniors don't like to change numbers, whether it is Sachin Tendulkar, Dravid, or Virender Se-

"The other issue in the Greg Chappell saga was the presence of Ian Fraser as Assistant Coach. Most players didn't like his pres-Patil said Chappell was in a
