

## Killers of 6 people to be brought to justice soon: Manipur CM

IMPHAL, Nov 20: Manipur Chief Minister N Biren Singh expressed grief over the killing of six people by suspected Kuki militants last week and asserted that his government would not rest until the culprits are brought to justice.

He said search operations were underway for the killers of three women and three children whose bodies were recovered from a river in Jiribam district last week.

The chief minister also said the killing of women and children is a crime against humanity.

Singh, in a video message shared on X on Tuesday night, said, "Today, I stand here with profound sadness and anger to condemn the horrific killings of three innocent children and three innocent women by Kuki terrorists after being taken hostage at Jiribam.'

The CM also said, "Such barbaric acts have no place in any civilized society. Let me assure you that the hunt for these terrorists is currently underway and they will be brought to justice very soon. We will not rest until they are held accountable for their inhuman ac-

The six people had been missing since November 11 from a camp for the displaced in Jiribam, following a gunfight between militants and security forces that led to

the deaths of 10 insurgents. Singh thanked the CRPF for their swift action in Jiribam and asserted that their commitment to duty saved the lives of hundreds of those living in relief camps at Borobekra in Jiribam.

"Around 40 to 50 armed terrorists launched an assault on internally displaced persons residing in a relief camp at Borobekra and targeted a police station in Jiribam. Their aim was to spread fear and destruction.

"However thanks to timely and decisive response from CRPF per-

sonnel stationed there, the attack was repelled and their swift action neutralised 10 of those terrorists on the spot thereby saving hundreds of innocent lives living in relief camps. I extend my heartfelt gratitude to CRPF and state forces for their remarkable careers and commitment to duty," Singh said on the microblogging site.

CRPF personnel's action demonstrated their "unwavering determination to protect the lives of innocent people and uphold peace in the region", the CM said.

"Their bravery is a reminder that we will stand firm against terror and violence and we will always prioritise the safety and security of the people," Singh said.

The chief minister also thanked central leaders for their relentless commitment to bring peace to the

## Complete elevated corridor at Kaziranga National Park at the earliest: SC

#### NHAI and MoRTH placed the project as priority

Supreme Court on Wednesday said it expects the NHAI to complete at the earliest the proposed elevated corridor of approximately 34 kilometres in the Kaziranga National Park and that other stakeholders will provide full support to the wildlife-friendly measure.

The Assam government informed the apex court that the elevated corridor was proposed for the National Park, which is famed for one-horned rhinoceros.

It apprised a bench of Justices B R Gavai and K V Viswanathan that work on a detailed project report was in progress by the National Highways Authority of India (NHAI) and the Ministry of Road Transport and Highways (MoRTH) has placed the project as a priority (category one).

"It does appear that the state of



necessary steps to provide an elevated corridor which bifurcates the two parts of Kaziranga sanctuary so as to provide free access to the wildlife from one part of the forest to the other part of the forest," the bench said.

## **Security Council structure doesn't** reflect today's realities: India

NEW YORK, Nov 20: India is "unsatisfied" with the pace of progress on Security Council reform, the country's envoy at the UN said, noting that there are countries who prefer the status quo and those that oppose expansion in the permanent category "at all costs" as they feel their neighbours may have a chance to become a member.

"The Security Council structure, as it stands today, is a reflection of 1945. It does not reflect today's realities," India's Permanent Representative to the UN Ambassador Parvathaneni Harish said during a conversation here on Tuesday.

Harish delivered the keynote address on 'Responding to Key Global Challenges: The India Way' at an event at Columbia University's School of International and

Harish gave an expansive overview of the "India way" on key global issues ranging from reformed multilateralism, terrorism, demography, India's digital revolution to the country's youth, climate change, democracy, healthcare, and

The event was co-sponsored by the MPA programme in Global Leadership and the International Organisation and UN Studies programme (IO/UNS) and attended by students, faculty, and policy experts. He noted that the United Nations

does "great work" in the humanitarian field, addressing the humanitarian requirements of hundreds of millions around the world as well as in the development domain -- children's health, public health, and

labour through its specialised insti-

"Yet for the common man on the street, their perception, the lenses through which they view the UN is neither the humanitarian dimension nor the development dimension or the public health dimension. They only look at the inability of the UN to stop conflicts in areas like Ukraine and the Middle East. That is the view they have and that is probably the only yardstick by which they are assessing the efficiency of the UN," he said during a panel discussion after the keynote address. Harish underlined that there is consensus that the UN Security Council should be reformed.

He said the memorial is expected to be inaugurated by next year, with the government also mooting a second phase of construction to add more attractions.

Speaking to reporters after reviewing the progress of the work at the site in Pachim Boragaon, Sarma said, "This is a memorial for all the 855 martyrs. It will have their photos and busts. There will also be a hall with photographs of the agitation and a space for medita-

He said ₹ 100 crore has been sanctioned for the project so far, and more funds would be required if the second phase of construction is taken up.

"If we can complete the project before December 10 this year, it will be inaugurated prior to it. Else, we will inaugurate it at some later date. One thing is for sure, the 'Swahid Smarak Kshetra' will be opened for the public in 2025," the CM said.

The Assam Agitation (1979-85) against illegal foreigners culminated with the signing of the Assam Accord on August 15, 1985.



The state observes December 10 as 'Swahid Divas' as the first martyr of the agitation, Khargeswar Talukdar,



### State projected to house 350 million children by 2050 India faces urgent challenges to secure children's future: UNICEF report

NEW DELHI, Nov 20: India, projected to house 350 million children by 2050, must navigate critical challenges like extreme climate and environmental hazards to ensure their well-being and rights, according to a new UNICEF re-

It underlined that although India will see a decline of 106 million children compared to today, it will still account for 15 per cent of the global child population, sharing this responsibility with China,

Nigeria, and Pakistan. UNICEF's flagship State of the World's Children 2024 report, The Future of Children in a Changing World, was launched in New Delhi on Wednesday, spotlighting three global megatrends, demographic shifts, climate crises, and frontier technologies that are set to reshape the lives of children by 2050.



The report was unveiled by Cynthia McCaffrey, UNICEF India Representative, alongside Suruchi Bhadwal of The Energy Research Institute (TERI), UNICEF Youth

Advocate Kartik Verma. The report pointed out that by the 2050s, children will face dramatically increased exposure to extreme climate and environmental

hazards and nearly eight times more children are expected to be exposed to extreme heatwaves compared to the 2000s.

This escalation of the climate and environmental crisis is compounded by the fact that more children will be living in today's interpretation of lower-income countries, particularly in Africa,

where resources to tackle these challenges may be limited without significant, strategic investments.

The report underscored that India, projected to house 350 million children by 2050, must navigate critical challenges to ensure their well-being and rights. Although India will see a decline of 106 million children compared to today, it will still account for 15% of the global child population, sharing this responsibility with China, Nigeria, and Pakistan.

"Decisions made today will shape the world our children inherit," said McCaffrey. "Placing children and their rights at the centre of strategies and policies is essential for building a prosperous, sustainable future," she said.

and child on November 7. Last year, when two Kuki women were raped, I was among the first to speak up. Allegations that I remain silent due to political alliances are unfounded. My stance has always been clear: no alliance or position will deter me from condemning such acts. Rape, murder, or violence of any form cannot be justified. Staying silent today will only allow a monster to

grow within our society," he said. Pradyot also criticised the ongoing cycle of blame surrounding the Manipur issue.

"This blame game—'You did it first, so I'll retaliate'-serves no purpose except to drag us backwards. People ask, 'Where are Congress and BJP?' But let's be honest: no one from Delhi will come to save us. The responsibility lies with us. When election results in other

states like Maharashtra come in, national attention will shift there, and we risk being forgotten. The solution to this crisis must come from within," he remarked.

As the royal scion of Tripura, Pradyot called out the lack of leadership in Manipur's ruling and opposition parties.

"Where is the vision of Manipur's leaders? Violence achieves nothing but destruction—it robs our children of a brighter future. Those whose homes have been burned and livelihoods destroyed are the ones suffering. I appeal to everyone: stop fighting over religion, tribe, or community. ## India, Australia firm up clean energy partnership; pushing for mega trade pact

India and Australia sealed an ambitious renewable energy partnership and set their eyes on a comprehensive economic cooperation agreement as Prime Minister Narendra Modi and his Australian counterpart Anthony Albanese vowed to significantly ramp up overall bilateral ties.

A raft of issues including ways to boost ties in areas of defence and security ties, mobility, science and technology and education figured prominently at the second India-Australia annual conclave held on the sidelines of the G20 summit late on Tuesday.

The two leaders also looked forward to a long-term vision of defence and security collaboration to enhance collective strength, contribute to both countries' security, and make an important contribution to regional peace and security, according to a joint statement.

The Renewable Energy Partnership (REP) would provide the framework for practical coopera-



tion in priority areas such as solar energy, green hydrogen, energy storage, investments in related projects and allied areas.

In his media statement after the summit talks with Albanese, Modi said both sides will work on new possibilities of cooperation in areas like defence industry, critical minerals, renewable energy, ship building, space and sports.

## Bitcoin, cryptocurrencies hit headlines for wrong reasons

**NEW DELHI, Nov 20:** Bitcoin and cryptocurrency are in news again after allegations were levelled against Congress's Maharashtra president Nana Patole and NCP (SP)'s Supriya Sule of being involved in "illegal bitcoin activities" to fund their poll campaign. Here is a look at what cryptocurrency/bitcoins are:

A cryptocurrency is a digital or virtual currency secured by cryptography, which makes it nearly impossible to counterfeit or double-spend. They exist on decentralised networks using blockchain technology -a distributed ledger enforced by a disparate network of computers. Bitcoin is the name of the most recognized cryptocurrency, the one for which blockchain technology was created.; cryptocurrency has no intrinsic value and is not redeemable for another commodity, such as gold; has no physical form and exists only in the network; its supply is determined by the protocol, not a

India is formulating a framework for cryptocurrencies, but until it is enacted, crypto is not yet illegal.

In 2022, the government announced a flat 30 per cent tax on gains arising from cryptocurrencies. Taxing income from cryptocurrencies does no necessarily and explicitly legalise cryptocurrencies

The Reserve Bank of India (RBI) too has been skeptical about the use of private crypto assets and considers it as a major threat to macroeconomic and financial stability of the country.

Finance Minister Nirmala Sitharaman has repeatedly stated that cryptocurrency issued by private entities cannot be the currency. Currency it would be when the Reserve Bank of India issues a digital currency, he had Private digital currencies/virtual currencies/crypto currencies have gained popularity in the past one decade or so. Regulators and governments have been sceptical about these currencies and are apprehensive about the associated risks.

It can be noted that on March 4, 2021, the Supreme Court had set aside an RBI circular of April 6, 2018, prohibiting banks and entities regulated by it from providing services in relation to virtual currencies.

Currently, crypto assets are unregulated in India. Here cryptocurrencies are regulated from the perspective of anti-money laundering law. Besides that, income tax and TDS is levied on earnings from trading in such virtual digital assets. Also, GST is levied on cryptocurrency exchanges. In July last year, Finance Minister Nirmala Sitharaman had said that "international collaboration" would be needed for any effective regulation or ban on cryptocurrency.

Earlier, the Reserve Bank of India had proposed a ban that was set aside by a court order. The RBI considers cryptocurrencies as huge risks to financial stability, and monetary stability. RBI Governor Shaktikanta Das had last month said that such virtual assets may create a situation where the central bank may lose control of money supply in the economy.

The RBI has recommended that crypto assets should be prohibited. Crypto assets are by definition borderless and require international collaboration to prevent regulatory arbitrage. Therefore, any legislation for regulation or for banning can be effective only with significant international collaboration on evaluation of the risks and benefits and evolution of common taxonomy and standards.

Currently, an inter-ministerial group (IMG), comprising officials from RBI, Sebi and finance ministry, is looking into a wider policy for cryptocurrencies. A discussion paper from the IMG is awaited, which will give the stakeholders an opportunity to give their views before India decides on its policy stance on crypto cur-

Pakistan is part of the group 'Uniting for Consensus' that opposes permanent seats for India and other G4 nations Brazil, Germany and Japan. Of the five Permanent members of the Council, France, Russia, the UK and the US have voiced strong support for India's bid for a permanent seat in a reformed Council.

China has said that Security Council reform is an important part of the reform of the multilateral governance architecture but also pointed to the "practice of a few countries and interest groups who pursue their own selfish and small-circle interests when it comes to Council reform".

Harish described the process as being "very difficult" and "complex".

"Yes, we are unsatisfied with the pace of progress in the last 15-16 years and urging the co-chairs of the Inter-Governmental Negotiation process to decisively move forward on this. "Is it going to be easy and will it happen tomorrow? Probably not. What should we do? We should keep at it because eventually, things will not remain the same. Nothing remains the same. Change is a natural order of things. It will happen, if not today, tomorrow. If not tomorrow, the day after. We are engaged with this process because we need a multilateral system that works, and is fit for purpose to deal with today's challenges, problems and also opportunities.'

Harish emphasised the institutions of multilateralism that "we have today are a product of the post Second World War." "The reality of 1945 is long gone, the institutions remain. They are not fit for purpose for dealing with today's challenges and opportunities. Yet they have not been reformed, whether it is the UN, the UN Security Council, international financial institutions, trade bodies, each one of them needs to be made fit for purpose for today's realities," he said. Harish said that changing the status quo is not easy. "You have a lot of status quo supporters, and you need to build consensus for this. It's a difficult process which is still ongoing," he said.

This disconnect between awareness and action raises a crucial question: Why, in an age of information and acceptance, are so many still hesitant to embrace therapy as a path to genuine well-being? The survey delves into this question further and reveals the

paradox. While 83% of the survey participants believe mental health issues are nothing to be ashamed of, 81% feel ashamed of telling others that they are taking therapy. While we are becoming more accepting of mental health issues in general, the act of seeking help still carries a heavy weight of perceived societal judgment. This inherent fear of judgement prevents individuals from having open conversations about their mental well-being hin-

dering access to support. This year's survey also reveals 80% of the participating Gen Z believe their parents would support them in therapy. There is a growing acceptance among close social circles and is a step towards normalizing mental health conversations.



The key findings of the survey are-Cost, a barrier to therapy, with 77% of surveyed individuals finding therapy expensive. In addition to this, 74% do not go for therapy as health insurance does not cover mental health services.

55% believe therapy is for the weak, highlighting the enduring stigma surrounding mental health support. 83% respondents believe that youth report experiencing more anxiety and fear of change than older generations, emphasizing the unique pressures faced by younger

## Stranded tiger sparks panic in Kaliabor

NAGAON, Nov 20: For over the past six years, a massive man-eating Royal Bengal Tiger has been wreaking havoc in a vast area of Kaliabor. Over the past three days, the tiger has been spotted at Borb-Debsatra. Katiyari, Dhekial, and Miribheti areas near Jakhalabandha under Kaliabor subdistrict, killing several livestock.

The sudden appearance of the tiger has created panic among locals, who are currently hesitant to venture out. The Forest Department and police have been informed, and officials monitoring the situation.

It is pertinent to mention here that several areas in Kaliabor, including Shilghat, Kaliabor Tea Estate, Sonarishakha Tea Estate, Sonarigaon, Kamakhya village, and Hatimura, have been terrorised by multiple tigers for nearly six years, resulting in over half a dozen livestock deaths.

Recently, an Anganwadi worker and several students narrowly escaped a tiger encounter in Hatimura. The Forest Department had set up a cage to capture the tiger but remained unsuccessful.

Due to the tiger's presence, life has been disrupted in the affected areas. People are spending sleepless nights, and normal life has been severely paralyzed. Significantly, the tiger was spotted today near Jakhalabandha, forcing the closure of Ayus Public School, Ramananda Balika Vidyalaya, and Kolongmukh Vidyapith. Meanwhile, the local administration has restricted the movement of locals on six roads in the area from 4:00 pm to 9:00 am.

The Forest Department has assured that all necessary measures are being taken to drive the tiger away, sources added.

#### Mason succumbs to injuries after stray dog attack

JORHAT, Nov 20: A person identified as Islamuddin Laskar, a mason residing in a rented house in the Gohain Tekela Gaon area, succumbed on Tuesday to injuries sustained in an attack by a pack of street dogs late on Monday night.

According to sources, Laskar, originally from the Hailakandi district, was returning to his house from work on Monday night when he was severely bitten by a pack of street dogs near a private school on the Gohain Tekela Gaon road.

Local residents found Laskar early Tuesday morning lying on the road with multiple injuries on his body and his clothes torn. He told them he had been attacked by over 10 stray dogs the previous night while returning home from work. Though he tried to flee the spot, the canines chased and bit him all over his body.

According to residents of Gohain Tekela Gaon, located beside AT Road, a pack of stray dogs numbering about 10 to 15 has recently been creating havoc for people, especially after sunset, as the dogs try to attack those using the road.

This initiative will enable approximately 1 lakh additional passengers to travel in GS coaches daily, demonstrating the Railways' focus on inclusivity and convenience.

The Northeast Frontier Railway (NFR) is also playing a vital role in this initiative, contributing to Indian Railways' success. Currently, NFR has already augmented 36 trains/69 rakes with 276 GS coaches, providing greater convenience and accessibility to passen-

gers across and beyond its zone. Furthermore, NFR plans to augment three additional trains with 16 more GS coaches by the end of December 2024. ### Haflong Fire & Emergency Services conducts ring well rescue

HAFLONG, Nov 20: A dramatic rescue unfolded at Lower Haflong (F&ESS) and State Disaster Response Force (SDRF) personnel responded to a distress call at 2:59 pm on Tuesday. The operation involved the rescue and recovery of three individuals who were trapped in a ring well during a cleaning attempt in Lower Haflong, near Sitla

Tusar Khamti Das, 35, son of Torun Das, was rescued alive by SDRF and fire personnel. Amu Das, 35, son of Sushil Das, was recovered dead by the team. Sanjib Deb Nath, 42, son of Romoni Deb Nath, was rescued alive by local residents. The incident occurred when three individuals, all residents of Lower

Haflong, entered the well one after another during a cleaning task. One person accidentally fell into the well, prompting the others to attempt a rescue. Tragically, all three became trapped, likely due to oxygen depletion or exposure to toxic gases in the confined space.

Local residents managed to rescue Sanjib Deb Nath before the emergency response team arrived. Once at the scene, SDRF and fire personnel launched a coordinated operation, successfully rescuing Tusar Khamti Das alive and recovering the body of Amu Das. The operation concluded at 4:30 pm, with all recovery efforts completed by 4:00 pm. Emergency services commended the swift actions of local residents and the coordinated efforts of the rescue teams. They emphasised the importance of safety protocols when working in confined spaces and urged the community to seek professional assistance for high-risk tasks

The Haflong community is mourning the loss of Amu Das, with heartfelt condolences extended to his family. Officials have reiterated the need for awareness and training to avoid such tragedies. Further investigations are underway to determine the exact cause of the accident.

#### Slogans and **Maharashtra elections**

ash, Caste, Crop. Add to that Crypto! Right from 7am in the morning on November 20, when voters stepped out in twos and threes and fours and fives to cast their votes, election aficionados have been placing their bets on the three 'C' as the moving force behind polling in Maharashtra, refusing to pin the voting trend on the conflicting narratives of 'Hindu' and 'Muslim', which dominated this latest phase of the elections. Question is, why deny reality, or is it yet another example of misleading political correctness? Certainly, it defies logic. Throughout the campaigning, there was nothing else but talk of Muslims for Maha Vikas Aghadi and Hindus for Mahayuti dominating the discourse. Then, suddenly, on the evening before polling day, cash comes into play, along with the dazzling electoral possibilities of the mysterious crypto currency, the Bitcoin! Also crop and caste, two issues which are endemic to Maharashtra NCP (Sharad Pawar) working president Supriya Sule was accused of "crypto fraud" along with Congress state unit Chief Nana Patole. This after the BJP's Vinod Tawade was charged with the crime of "cash for votes", after a lot of hard liquid cash was found in his keep. Sule became the issue and Tawade became the issue. But whatever happened to Muslim and Hindu? Wasn't there saturation coverage of Muslims putting pressure on MVA to fulfill certain demands specific to the Muslim community in return for en bloc Muslim votes? Wasn't there also realization in the opposite camp that Hindus must ape Muslims and vote en bloc for the BJP? Throughout campaigning no media spoke of cash, caste, crop and crypto; media only gave saturation coverage to Hindu and majoritarian, and Muslim and minority appeasement. Didn't the All India Muslim Personal Law Board omise to vote for the Maha Vikas Aghadi if the MVA promised to fulfill 17 Muslim recommendations? Didn't prominent Muslim scholars warn the MVA of what awaited them if the Muslim community was left in the lurch on the Waqf Board amendments? The point being made is that all through campaigning nothing dominated the discourse more than Hindu and Muslim. Star campaigners of all political parties, from Prime Minister Narendra Modi to Sharad Pawar, from Uddhav Thackeray and Eknath Shinde, from Devendra Fadnavis to Asaduddin Owaisi, every one of them fanned to flames issues concerning Hindu and Muslim. They went to key constituencies and harangued each other with dog-whistles.

To some extent 'caste' figured but 'cash', 'crypto' and 'crop' didn't debut till towards the final days of the campaigning. Then again, isn't it a fact that "caste" went under an avalanche of 'Hindu-Muslim' except when Congress leader Rahul Gandhi cut through Maharashtra with 'Caste Census' on his tongue? 'Maratha Reservation' was an election issue, but the demand for a 'Caste Census' went under the bus when the BJP took to 'Batenge toh katenge'. If any slogan rang loud and clear throughout the electioneering, it was the Yogi's 'BTK'. If caste, crop, and cash had set the tone, then why did posters and hoardings displaying 'Batenge toh katenge' remain aloft and stuck throughout the campaigning? This was the first assembly polls after the breakups and both fronts, Mahayuti and Maha Vikas Aghadi, were banking on 'Hindutva' and 'Secular' to trounce the other.

## Increasing collaboration between Britain and China is imperative at the present moment

The meeting between a British prime minister and China's President Xi Jinping at the G20 summit in Rio de Janeiro on November 18 was long overdue. Reportedly, Keir Starmer wants a "consistent, respectful and pragmatic" relationship between the two countries, with an emphasis on progress towards clean energy. But he is especially keen to improve Britain's prospects for economic growth by increasing British exports to China and Chinese investment in Britain

Britain's economy has grown by just 3 per cent from its pre-Covid level, less than any other G7 country except Germany. IMF and OECD forecasts indicate further small advances this year and next, thanks in part to the October Budget. Even so, the Office for Budget Responsibility projects a slowdown in growth from 2 per cent in 2025 to 1.5 per cent before the end of the decade.

Despite all the tax cuts, tax breaks and state subsidies, many of our much-vaunted "entrepreneurs" have concentrated more on filling their boots and stashing their wealth overseas than they have on investing in their workforce and creating

a modern, productive economy. For the past 20 years, Britain has been at or near the bottom of the G7 league of biggest capitalist economies when it comes to business investment (as a proportion of GDP). Our "entrepreneurs" languish in 28th place out of 31 in the Organisation of Economic Co-op-

eration and Development (OECD). Without our admittedly average level of state capital spending, Britain would be rock-bottom in the G7 and OECD in terms of overall economic investment. Yet no Labour minister praises public-sec-

tor "entrepreneurship." Investment, like growth, must also consider quality as well as quantity. In Britain, far too much capital is channelled into the financial markets, real estate and cheap labour and production overseas. Fawning upon "entrepreneurs" in the embarrassing manner of Chancellor Rachel Reeves and Business Secretary Jonathan Reynolds will not make them change their ways. Slapping a wealth tax on them and taking vital industries - water, gas,

have a more sobering impact. Unfortunately, we have a Labour government that is afraid of its own shadow despite its overwhelming majority at Westminster. It is too afraid to take the bold measures necessary to raise the British economy to a qualitatively higher level.

So Starmer turns to China, Britain's fifth biggest trading partner, looking to boost exports and inward investment after several years of heavy decline.

There is plenty of room for growth, especially in exports to China, where Britain lags far behind Germany, France and Italy. Relaxing the US-inspired ban on selling key electronic, micro-processing and "dual use" (civilianmilitary) engineering products to China would help.

Restrictions on Chinese investment in Britain already hold back the roll-out of 5G technology and the application of quantum physics - in which China leads the world to computing, communications, geology and medicine.

China will reciprocate any moves towards stronger economic relations, all the more so if we abstain from US-led military provocations around Taiwan and the South China

The likely response to a Britain-China rapprochement from a US Trump administration packed with anti-China war hawks will be decidedly cooler.

The Starmer-Labour government will have to choose: the servile "special relationship" with a US in decline or friendship with a China on the rise as part of a genuinely independent, peaceseeking and green foreign policy for Britain? (IPA Service)

## Bulldozer justice: A new chapter for rule of law in India

The Supreme Court of India, in a historic judgment, has put an end to what has come to be known as "Bulldozer Justice," where state governments have wielded demolition drives as a tool of retributive punishment. This ruling addresses the recent trend of using bulldozers to demolish the homes and properties of individuals accused of crimes, a practice that has been criticized for circumventing due process and violating fundamental rights. The judgment underscores the principle that the executive branch cannot act as both prosecutor and executioner, thereby reinforcing the constitutional concept of separation of powers and the sanctity of due

Context and Background of **Bulldozer Injustice** 

The practice of punitive demolitions has seen a sharp increase in recent years, particularly in states like Uttar Pradesh, Haryana, Delhi, Madhya Pradesh, Rajasthan, and Assam. Under the banner of delivering swift "justice," authorities have razed hundreds of homes belonging to individuals accused of participating in riots or other crimes. This form of extrajudicial punishment became most prominently associated with the administration of Uttar Pradesh Chief Minister Yogi Adityanath, where bulldozers were touted as instruments of strong governance.

However, critics argue that such measures were less about maintaining law and order and more about projecting power, often targeting marginalized communities and individuals based on mere suspicion. The Supreme Court's intervention comes at a crucial time when the line between lawful governance and arbitrary state action

appeared increasingly blurred. The ruling highlights that any act of demolition must follow due legal emphasizing that homes—often built through years of savings and loans—are not just structures but sanctuaries for families, including those uninvolved in the alleged crimes of their rela-

**Key Aspects of the Supreme** Court's Judgment

2. Detailed Final Order: The decision to demolish a property must be justified through a detailed final order, explaining why demolition is necessary and confirming that all legal avenues have been exhausted.

4. Accountability Measures: Officials who carry out demolitions without following the established procedure will be held personally liable. This includes potential contempt proceedings and deductions from their salaries to compensate affected individuals.

5. Real-Time Transparency: The entire demolition process must be recorded and monitored, with updates provided on a digital portal to ensure transparency and pre-

6. Videographic Evidence: To bolster accountability, the entire process should be videographed, and a list of involved officials must be maintained.

This judgment serves as a powerful reminder of the limitations imposed on the executive branch by the Constitution. ## **Modi-Shah caution against Bangladesh** infiltration in Jharkhand is ominous

SS and BJP have been consistently raising the issue of Bangladeshi infiltration but the manner in which they are putting it in the Jharkhand assembly elections, makes it obvious that they are working on some treacherous plot. More than merely being a design to polarise the Hindu votes and put the Vanvasis against Mool Adivasis and Christians, it is part of their bigger plan to make 'intrusion' a big issue in the sub-continent.

RSS and BJP for more than two decades have been complaining of Bangladeshis having settled in UP, Delhi, MP, Maharashtra, and even in Gujarat. Their number is not so alarming and moreover they have assimilated into the main Indian life. It is very difficult to segregate them from a common Indian. But even then, the saffron ecosystem has been demanding for their identification and deporting them.

But in their election campaigning in Jharkhand this time, Narendra Modi and particularly Amit Shah have been harping 'infiltrators' Bangladesh are "snatching bread, daughters and land" of the state's original inhabitants.

What has been quite significant and probably has remained unnoticed is that a short of catch words -- Roti-Beti-Mati (Bread-Daughter-Land) is quite attractive to the Jharkhandis and it angers a one section against the

RSS has been working amongst the Adivasis for last 80 vears, decades before Jharkhand was carved out of Bihar.. During these years saffron ecosystem's primary enemies were the Christian missionaries.

Obviously an organisation having its strong base in the Adivasi belt ought to have raised its voice when the Bangladeshis started intruding the region. They would have entered into matrimonial relations, as alleged by our learned Modi and Shah. much after their entry.

Significantly during the 24 years of existence of Jharkhand, the BJP was in power for 17 years. Why the BJP stalwarts and their state chief ministers did not initiate measures to check this, if at all it was happening.

The only reason for their turning blind eyes to this trend may be attributed to their obsession to serve their corporate and big business masters.

They turned Jharkhand into a colony of the corporates.. Their allegation that this is because of the support the "infiltrators" get from the JMM-Congress-RJD alliance government; the "intrud-

ers" are the vote banks of the INDIA bloc partners, is merely an attempt to fool the people and serve the political and economic interest of their masters.

It is worth mentioning that barely a month back the Union minister Giriraj Singh had organised a Hindu Swabhiman Yatra in Bhagalpur, Purnea, Katihar, Araria, Madhepura and Kishanganj, bordering districts of Seemanchal. These districts of Bihar have high proportion of the Muslim population, more than in the remaining areas of the state.

Saffron ecosystem singling out Muslims certainly is a move to polarise the Hindus. But it has no more a peripheral importance. It ought to be seen in proper perspective. Jharkhand is the mineral rich state in India and has international importance. Modi's friend Adani has already set up its power plant in Godda which supplies power to Bangladesh.

It ought to be mentioned that BJP has long been harping on the need for a separate Union territory along the border of Bihar and Bengal. According to the saffron ecosystem, this is necessary to form a Centrally-governed area to deal with China, Myanmar, Bangladesh .By putting forward this argument in public domain; they were in fact trying to conceal some big plan.

By entrusting the Assam chief minister, Himanta Biswa Sharma, to plan and manage the assembly election in Jharkhand. the saffron camp has made its intention clear. Sharma has already implemented the strategy. Of course he is a rich politician with contacts supposed to finance the BJP electioneering. His primary task has been to ensure that the issue of intrusion attracts the attention of the people of state. It is worth recalling that Shah had threatened to "hang the intruders upside down" after Hasina had taken shelter in India.

One aspect is also noticeable. Majority of the people from Bengal who migrated to Adivasis areas of Jharkhand belong to the ST community in West Bengal. Modi and Shah ought to know that Mahatos and Kurmis who constitute significant portion of the Jharkhand population belong to the Adivasi community and have played a major role in the liberation of the area from British rulers. They had played a major and significant role in creating JMM and shaping Shibu Soren

as the Adivasi leader. In an affidavit filed before the high court in September 2024, the Union government pleaded that the decline could be because of migration, high infant mortality, or conversion to Christianity. Astonishing it did not mention is that an increasing number of tribals have been insisting that they are not Hindus and that their faith should be described as 'Sarna Dharma'. The practice of clubbing all non-Christian Adivasis as 'Hindu' is no longer valid.

Only couple of days back Hemant Soren accused the BJP of squeezing the state like a lemon" for almost two decades and "smashing" the backbones of poor states. He also charged the BJP-led Centre with "destroying" the federal structure of the country. They plundered Jharkhand's wealth. It is a paradox that Jharkhand, rich in mineral resources, is one of the poorest states," Jharkhand Chief Minister Soren claimed.

First Muslim contingents arrived in Jharkhand territory 800 vears ago and settled in the villages of Mundas. They mixed with the locals in such a way that they forgot their own culture, language and life-styles. The most surprising matter is that the residents of this territory not only treated them as their own but according to Father Hoffman, 'they adopted Arabic and Persian words in their own language.

Muslims set up their mosque in Jharkhand territory for the first time in 1661 in Dayoodnagar. Later on madrasas were set up. In 1740 it was the first chance when a Muslim known as 'Hidamatullah Khan' was nominated as jagirdar of Japla in Jharkhand.

Unfortunately contribution of Muslims in the formation of Jharkhand state is being ignored. Saffron ecosystem creates the impression that Muslims are outsiders. They fought to liberate India from the clutches of the British colonial rule. Shaikh Bhikhari is one of the heroes who fought against the Britishers and sacrificed his life for the country.

When he was 38 years old in 1857, Thakur Vishwanath Shahdeo gave him an opportunity to become an active member of Mukti Vahini. He helped the Indian army when there was revolt at Doranda (Ranchi) on 31 July 1857. Bhikhari awakened the Santhalis of Santhal Pargana to revolt against the Britishers.

It is a fact that Muslims throughout Jharkhand region were first to raise the Jharkhand issue. In 1912 Asmat Ali gave a call for the separation of Jharkhand from Bihar for the first time. And in 1936 Momin Conference passed the resolution calling for a separate Jharkhand state. In 1952 Chiragh Ali Shah raised the voice for the fulfillment of this demand and in 1989 Jharkhand Oaumi Tahrik played an important role to lead Jharkhand movement. (IPA Service)

This success led to a significant rise in patients from East Africa seeking Ayurvedic treatments

During my frequent travels to Dehradun, I often encounter foreign tourists-men and women of all ages and professions—on flights and trains. Many of them are headed to ashrams or health centers in places like Haridwar, Rishikesh, and Dehradun for stays ranging from two weeks to three months. Their length of stay and the cost—often equivalent to or exceeding luxury five-star hotel rates—depend on the severity of their condition and the treatment required.

In addition to traditional treatments, modern hospitals in cities like Delhi, Mumbai, Bengaluru, and Chandigarh are drawing a large number of international patients seeking cosmetic procedures to enhance their appearance. Plastic surgeons report seeing dozens of foreign patients each month for treatments such as burn injury repair, hair transplants,

and skin-tightening procedures. This trend represents a golden opportunity for India to attract more foreign patients. Medical tourism not only earns valuable foreign exchange but also supports local economies, as patients often arrive with caretakers who stay in hotels for weeks or months. Indian expatriates living abroad are also increasingly returning

to India for affordable and high-quality medical care.

India's edge lies in offering top-tier pre- and post-surgical care at a fraction of the cost of similar services in Europe or the US. Cosmetic surgeons in India treat patients seeking procedures like fat reduction and skin tightening, as aging and environmental factors accelerate skin issues. With growing awareness of beauty treatments, both men and women are increasingly opting for cosmetic and surgical solutions.

Globally millions of geries are performed annually, with the US being a leader in this sector. While initially popular among women, plastic surgery is now equally common among men. Broadly, plastic surgery can be divided into two categories: cosmetic surgery, which enhances appearance, and reconstructive surgery, which repairs damage from injuries, illnesses, or birth defects.

India, with its highly qualified medical professionals, advanced equipment, and cost-effective treatments, is well-positioned to take a giant leap in medical tourism. Treatment costs in India are about onefourth of those in the US, without compromising on quality. If India strategically strengthens this sector, patients will increasingly choose India over competitors like Thailand, Singapore, China, and Japan, which

are also vying for medical tourists. Medical tourism is a multi-billiondollar industry globally. To secure a larger share, India must develop internationally accredited hospitals and clinics, provide specialized care in fields like cardiology, oncology, orthopedics, and transplantation, and embrace telemedicine and digital healthcare services.

India's millet-based therapies also offer a unique edge. Padma Shri awardee Dr. Khadar Vali claims that millet can cure even the most severe illnesses within six weeks to six months without any medication. Such unique approaches, along with robust policy support from the government, can further elevate India's medical tourism potential.

Marketing campaigns, patient-centric packages, visa facilitation, language translation services, and accommodation arrangements can make India a more attractive destination for international patients.

The figures speak for themselves—14 lakh foreign patients came to India for treatment in 2022. To meet the ambitious target of attracting 1 crore international patients annually by 2030, India must ensure world-class healthcare services and develop specific areas of expertise. ## Brahmaputra at risk: The need for immediate action

The Brahmaputra River, one of the world's mightiest and most ecologically significant rivers, is facing an existential crisis. Originating from Tibet and flowing through India and Bangladesh, it is not only a lifeline for millions of people but also a vital force that sustains biodiversity, agriculture, and culture across the re-

National aziranga Park, rich in diverse biodiversity, is known not only for its one-horned rhinoceros but also as a UN-ESCO World Heritage Site. During the winter, countless colorful migratory birds transform Kaziranga into a paradise. # facing its pollution crisis

ir quality and environmental concerns have become a pressing issue in India, affecting millions of people each day. The situation is particularly dire in urban areas where pollution from vehicles, industries, and other human activities has caused a steady decline in air quality. During the winter months, especially around the festive season, the air in cities like Delhi and its surrounding regions becomes extremely polluted. Smog blankets the cities, leading to respiratory issues, eye irritation, and more serious long-term health problems like lung and heart diseases. People of all ages are affected, but children, the elderly, and those with pre-existing health conditions are most vulnerable.

One of the main reasons for this severe air pollution is the high concentration of particulate matter, often referred to as PM2.5 and PM10, which are tiny particles that can penetrate deep into the lungs and even enter the bloodstream. These particles are released from various sources, such as vehicles, construction activities, industrial emissions, and the burning of fossil fuels.

Vehicles contribute a significant portion of this pollution, especially in densely populated areas. Diesel and petrol engines release a high amount of pollutants, and despite the introduction of cleaner fuel standards, the number of vehicles on the road continues to rise, negating some of these improvements.

Another major source of pollution in India is the practice of crop burning. Every year, farmers in states like Punjab and Haryana burn the residue of harvested crops to clear their fields for the next planting season. This burning releases vast amounts of smoke and particulate matter into the air, which is then carried by the wind to nearby cities, including Delhi.

This practice is often defended by farmers as the quickest and most economical way to prepare fields, though it has a devastating effect on air quality. Efforts have been made to find alternative methods, but the cost and lack of resources often prevent large-scale adoption of these solutions.

During the festive season, particularly Diwali, the use of firecrackers adds to the already severe pollution. Firecrackers release a cocktail of toxic chemicals into the air, increasing pollution levels

While there are laws restricting the use of firecrackers, enforcement is difficult, and many people continue to use them, unaware of the severe impact on air quality. Schools and public health officials often urge people to avoid firecrackers, and there is a growing awareness about the need for cleaner celebrations, but changing traditions takes time.

The health impacts of poor air quality are extensive and alarming. Respiratory diseases such as asthma, bronchitis, and chronic obstructive pulmonary disease are on the rise, especially among children who are more susceptible to the effects of pollution. Doctors in major hospitals frequently report a spike in cases related to respiratory issues, particularly during the winter months.

For the elderly and those with

pre-existing heart conditions, exposure to polluted air can be lifethreatening, as it exacerbates their health problems and makes them more vulnerable to complications. Studies have shown that prolonged exposure to polluted air reduces life expectancy and affects the overall quality of life, making it a significant public health concern.

To address the problem, the government and various organizations have implemented a number of measures. One of these is the promotion of cleaner fuels, such as compressed natural gas (CNG) in public transport.

Many buses and auto-rickshaws now use CNG, which is less polluting than traditional fuels like diesel and petrol. Electric vehicles are also gaining popularity, although their adoption is still slow due to high costs and limited charging infrastructure. In addition, the government has introduced stricter emission norms for vehicles, and there is ongoing development of metro systems and other public transportation networks to reduce the number of vehicles on the roads.

The government has also launched several initiatives to monitor and control air pollution levels. The National Clean Air Programme (NCAP) is one such initiative, aimed at reducing particulate pollution by 20-30% in the next few years. Under this program, cities with high pollution levels are given specific targets to improve their air quality.

Various air quality monitoring stations have been set up across the country to track pollution levels and provide real-time data to the public. This data is used to issue warnings on days when pollution levels are particularly high, allowing people to take precautions such as staying indoors or wearing masks. However, while monitoring and awareness are important, they are only part of the solution, and actual reduction in pollution levels requires stricter enforcement of laws and more effective action.

Public awareness campaigns have played a significant role in educating people about the health risks of pollution and the steps they can take to protect themselves. For example, using carpooling, taking public transport, or switching to bicycles are encouraged as simple ways for individuals to contribute to cleaner air. ## 2024 to cross 1.5°C, be hottest year on record

The year 2024 is well on its way to become the hottest year since the preindustrial period, according to the World Meteorological Organization (WMO) and the European Union's Copernicus Climate Change Service (C3S). The year may also be the first year to cross the 1.5°C above the preindustrial annual average temperature, according to the C3S. The C3S concluded this after analysing the data for the first 10 months of 2024.

This would be the second year in a row when the global annual temperature

record would be broken. "This marks a new milestone in global temperature records and should serve as a catalyst to raise ambition for the upcom-Climate Change Conference, COP29," said Samantha Burgess, deputy director of the C3S. The WMO's analysis of six different temperature datasets from January to September 2024 also found that the year may be the warmest on

"Today, the WMO and partners tell us that 2024 is on track to be the hottest year ever recorded - almost two months before it ends," said Antonio Guterres, the secretary general of the United Nations in a WMO press statement. "Humanity's torching the planet and paying the price," he added.

WMO uses data from the observational sites and instruments on land and over the oceans from the United States National Oceanic and Atmospheric Administration (NOAA), National Aeronautical and Space Administration's (NASA) Goddard Institute for Space Studies. The United Kingdom's Met Office Hadley Centre, University of East Anglia's Climate Re-

search Unit, the Berkeley Earth Group, C3S and the Japan Meteorological Agency (JMA). The last two datasets are reanalyses datasets which combine observational data with weather models to get a complete picture of temperature data even from places where there are no observational sites such as the Polar Regions and the oceans.

The month of October 2024 was 1.65°C above preindustrial levels and the 15th month out of the last 16 months when the monthly global average air temperature crossed1.5°C above preindustrial levels, according to C3S. This also made October 2024 the second warmest October since 1850-1900 period.

on record C3S had also indicated back in July that 2024 was on a pathway to break the annual temperature record. And there are many indicators of the trend. "The globalaverage temperature for the past 12 months (November 2023- October 2024) was 0.74°C above the 1991-2020 average, and an estimated 1.62°C above the 1850-1900 pre-industrial average," said C3S in its statement.

"The average global temperature anomaly for the first 10 months of 2024 (January to October) is 0.71°C above the 1991-2020 average, which is the highest on record for this period and 0.16°C warmer than the same period in 2023," C3S added.

The average temperature anomaly would have to drop to zero for the next couple of months for 2024 not to be the warmest year surpassing 2023. It is also likely that the average annual temperature may be above preindustrial levels by more than 1.55°C.

While crossing the 1.5°C mark in individual months or years does not imply that the Paris Agreement's average global temperature threshold of 1.5°C has been exceeded, repeated crossings do bring the planet closer to that critical barrier. The oceans also were much warmer-than-normal in October, similar to the atmospheric temperatures.

The average sea surface temperatures for October 2024 for the tropical and sub tropical regions of the planet was 20.68°C, the second warmest since the preindustrial period and only 0.1°C below October 2023. The warm atmosphere and warm oceans have lead to an increase in moisture levels in the atmosphere which can clearly be evidenced by the extreme weather events experienced around the

These included the catastrophic floods in Spain in late October and early November that have killed more than 200 people, Hurricane Milton in the Gulf of Mexico in the second week of October which showed explosive rapid intensification fuelled by ocean warming and devastated the US state of Florida and Cyclone Asna which unusually formed and intensified on land in its formative stages fuelled by soil moisture and brought huge torrents of rainfall to Guiarat, Raiasthan and Madhya Pradesh states in India killing dozens.

According to the Clasius-Clapeyron equation, for every 1°C rise in global average temperature there would be seven per cent rise in atmospheric moisture levels. As the planet warms further, extreme weather events would only become much more intense, frequent and unpredictable. (Courtesy: Down To Earth)

# First issue in engaging with Pakistan is cessation of terrorism: India's Ambassador at UN

NEW YORK, Nov 20: The first issue in engaging with Pakistan is the cessation of terrorism, India's envoy at the UN said, underlining that India has been a long-standing victim of cross-border and global terrorism and has zero tolerance towards the scourge.

"With Pakistan, the main issue we have is of terrorism," India's Permanent Representative to the UN Ambassador Parvathaneni Harish said during a conversation here on Tuesday.

Harish delivered the keynote address on 'Responding to Key Global Challenges: The India Way' at an event at Columbia University's School of International and Public Affairs (SIPA).

Responding to a question on Pakistan during an interactive session after the keynote address, Harish said Prime Minister Narendra Modi made an effort to reach out and engage with Pakistan.

"Terrorist activities in India have eroded the trust. The first issue in engaging with Pakistan is the cessation of terrorism. That is a key

In his address, Harish emphasised that terrorism is a big issue on the global stage.

"India has been a long-standing victim of cross-border and global terrorism," he said as he described terrorism as an "existential threat" to humanity that knows no borders. no nationality and for which there can be no justification.

"Terrorism can only be combated through international collaboration," he said.

On what is the 'India Way' in dealing with terrorism, Harish underlined that a "big focus" for the country has been on taking along its international partners to combat terrorism as he stressed that India

has zero tolerance for the scourge.

## US Embassy in Kyiv shuts due to Russian air attack threat after Biden policy shift

KYIV, Nov 20: The US Embassy in Kyiv said it would stay closed on Wednesday after receiving a warning of a potentially significant Russian air attack on the Ukrainian capital.

The precautionary step came after Russian officials promised a response to President Joe Biden's decision to let Ukraine strike targets on Russian soil with USmade missiles — a move that angered the Kremlin.

The war, which reached its 1,000-day milestone on Tuesday, has taken on a growing international dimension with the arrival of North Korean troops to help Russia on the battlefield — a development which US officials said prompted Biden's policy shift.

Russian President Vladimir Putin subsequently lowered the threshold for using his nuclear arsenal, with the new doctrine announced on Tuesday permitting a potential nuclear response by Moscow even to a conventional attack on Russia by any nation that is supported by a nuclear power. That could potentially include Ukrainian attacks backed by the US.

Western leaders dismissed the Russian move as an attempt to deter Ukraine's allies from providing further support to Kyiv, but the escalating tension weighed on stock markets after Ukraine used American-made AT-ACMS longer-range missiles for the first time to strike a target inside Russia.

The US Embassy said its closure and attack warning were issued in the context of ongoing Russian missile and drone attacks on Kyiv and anticipated a quick return to regular operations.

Western and Ukrainian officials say Russia been stockpiling powerful long-range missiles, possibly in an upcoming effort to crush the Ukrainian power grid as winter settles in.

Military analysts say the US decision on the range over which American-made missiles can be used isn't expected to be a game-changer in the war, but it could



help weaken the Russian war effort, according to the Institute for the Study of War, a Washington think tank.

"Ukrainian long-range strikes against military objects within Russia's rear are crucial for degrading Russian military capabilities throughout the theatre," it said.

Meanwhile, North Korea recently supplied additional artillery systems to Russia, according to South Korea. It said that North Korean soldiers were assigned to Russia's marine and airborne forces units and some of them have already begun fighting alongside the Russians on the front lines

Ukraine struck a factory in Russia's Belgorod region that makes cargo drones for the armed forces in an overnight attack, according to Andrii Kovalenko, the head of the counterdisinformation branch of Ukraine's Security Council.

He also claimed Ukraine hit an arsenal in Russia's Novgorod region, near the town of Kotovo, located about 680 kilometers (420 miles) behind the Ukrainian border. The arsenal stored artillery ammunition and various types of missiles, he said. It wasn't possible to independently verify the claims. (AP)

# Argentina's Milei pivots to pragmatism in 1st talks with China's Xi after shaking up G20

LA PAZ (BOLIVA), Nov 20: Last year, then-presidential candidate Javier Milei declared Argentina would not "make deals with communists" in China or Brazil, calling their leaders "murderers" and "thieves" in a bid to channel the populist energies of Donald Trump and other global far-right icons into

a winning political message. But Tuesday, President Milei found himself at the Group of 20 summit in Rio de Janeiro shaking hands with Chinese President Xi Jinping and vowing to boost trade with the Asian powerhouse, a day after his economy minister signed a preliminary agreement to export Argentine natural gas to Brazil.

Milei even acquiesced to a joint declaration endorsed by world leaders late Monday despite his earlier attempts to play spoiler to the G20 host, Brazil's left-wing president Luiz Inácio "Lula" da Silva who was once called by Milei a "corrupt communist".

The final moments of the summit revealed Milei's more pragmatic streak, coming as a surprise after the irascible president sought to undercut various international initiatives — withdrawing Argentine negotiators from the UN climate summit, casting the only "no" votes on two UN resolutions, one supporting Indigenous rights and another advocating for an end to violence against women, and roiling negotiations at the G20 summit.

Argentina has also dramatically reshaped its foreign policy in line with its hard-right allies in Italy with Prime Minister Giorgia Meloni headed to Buenos Aires on Tuesday to spend more time with Milei — and in Israel. On Tuesday,

Andrea Tenenti, a spokesperson for the UN peacekeeping mission operating along Lebanon's southern border, told reporters in Geneva that Argentina had decided to withdraw its peacekeepers from the force,

known as UNIFIL. He did not say why, but Israel has repeatedly requested that peacekeepers leave the area since the military's October 1 invasion of southern Lebanon. Despite Israeli attacks on peacekeepers, UNIFIL has vowed to stay put and none of the other 47 troop-contributing countries has pulled out.

In the past few days, Argentine resistance to the joint G20 communiqué focused on clauses related to the taxation of the super-rich and regulation of online speech, diplomats said. Argentine delegates also sought to block language about gender equality and references to the UN 2030 agenda on sustainable development, which Milei has decried as socialist.

Critics in Rio saw the Argentine president as a saboteur. Supporters back home cheered Milei as a leader of the "new world disorder." Fresh off a trip to Trump's Mar-a-Lago resort in Florida where he ranted against socialism and rubbed shoulders with the president-elect and tech billionaire Elon Musk. Milei initially seemed immune to such concerns in Rio.

Milei's office issued a harsh statement citing his objections to the G20 declaration. But the president ultimately signed onto it under enormous international pressure.

"Argentina is not a great power and it is in a very difficult situation economically," said Roberto Goulart Menezes, a professor of international relations at the University of Brasilia. That pressure, he added, was "enough for Argentina to finally reduce its opposition."

During Milei's first-ever meeting with Xi on Tuesday, the leaders discussed their "current trade and financial ties" and "desire to continue exploring new opportunities to expand and improve," the Argentine presidency said in a statement, along with a photo of the presidents sharing a warm handshake. It said the leaders had invited each other to

With Argentina highly reliant on China as a market for its soybeans and other crops, the cordial tone made clear that the crisis-stricken South American nation has no desire for relations with its secondlargest trading partner and crucial source of financing to further dete-

A statement from China's foreign ministry said Xi expressed his appreciation for Milei's "willingness to continue deepening bilateral cooperation" China has maintained strategic

assets in Argentina, including stakes in lithium mines and a space station in Patagonia. Earlier this year, former Foreign Minister Diana Mondino, whom Milei recently fired, led a successful visit to China to patch up relations strained by Milei's colorful insults ("Would you trade with an assassin") he asked on the campaign trail last August, accusing China of killing dissidents).

## Multiple election offices report receiving mailed ballots misdirected from other states

HELENA (MONTANA), Nov 20: Terry Thompson had an election to run for voters in Cascade County, Montana. Why then, she thought, was her office in Great Falls being sent mailed ballots completed by voters in places such as Wasilla, Alaska; Vancouver, Washington; and Tampa, Florida?

It was only about a dozen ballots total from voters in other states. But she said it still raised concerns about the ability of the US Postal Service to deliver election mail and whether the errant ballots would ever be counted. "I mean, I would have had to been doing

FedEx overnight envelopes to all these states to try to get them where they needed to go," said Thompson, the county's election administrator.

She received about a half dozen others that should have gone to county election offices in other parts of Montana. For those, she said she

"just had to hope and pray" they made it back on time

While a stray ballot ending up in the wrong place can happen during election season, the number of ballots destined for other states and counties that ended up at Thompson's office is unusual. AP found it wasn't an anomaly. Election offices in California, Louisiana, New Mexico and elsewhere also reported receiving completed ballots in the mail that should have gone to other states.

The Postal Service said on Tuesday that without additional information or tracking data from bar codes on ballot envelopes, it cannot comment further on those cases. It said earlier this month that it had been working closely with local election officials to resolve concerns.

But to some election officials, the misdi-

fore the November 5 presidential election about the US Postal Service's performance and ability to handle a crush of mail ballots, as early voting has become increasingly popular with voters.

State election officials warned in September that problems with the nation's mail delivery system threatened to disenfranchise voters in the upcoming presidential election.

### North Korea sent more conventional weapons to Russia: South Korea

SEOUL, Nov 20: North Korea recently supplied additional artillery systems to Russia to support its war efforts against Ukraine, while some of the thousands of North Korean troops deployed in Russia have begun engaging in combat, South Korea's spy agency told lawmakers on Wednesday.

The South Kor came after Russia warned on Monday that US President Joe Biden's decision to let Ukraine strike targets inside Russia with US-supplied longer-range missiles adds "fuel to the fire" of the war.

US officials said Biden's decision was triggered almost entirely by North Korea's entry into the war. In a closed-door briefing at parliament, the National Intelligence Service said that North Korea exported 170mm self-propelled guns and 240mm multiple rocket launch systems to Russia, according to lawmaker Lee Seong Kweun, who attended the meeting.

Lee told reporters that the NIS assessed those weapons are a type of artillery the Russian military doesn't operate so North Korea likely dispatched personnel to teach the Russians how to use them and handle their maintenance

Last week, Russian Telegram channels and other social media posts published photos apparently showing North Korean's "Koksan' 170mm self-propelled guns being moved by rail inside Russia.

The Financial Times, citing Ukrainian intelligence assessments, reported on Sunday that North Korea in recent weeks sent some 50 domestically produced 170mm self-propelled howitzers and 20 240mm multiple launch rocket systems to Russia.

The artillery systems are the latest conventional weapons that North Korea is believed to have provided to Russia as the two countries are sharply expanding their military cooperation in the face of separate confrontations with the US

Last month, the NIS said that North Korea had sent more than 13,000 containers of artillery, missiles and other conventional arms to Russia since August 2023 to replenish its dwindling weapons

During its Wednesday briefing, the NIS said that an estimated 11.000 North Korean soldiers in late October were moved to Russia's Kursk region, where Ukrainian troops seized parts of its territory this year, following their training in Russia's northeast, Lee

He cited the NIS as saying the North Korean soldiers were assigned to Russia's marine and airborne forces units and some of them have already begun fighting alongside the Russians on the front-

The US, Ukraine and others have similar estimates on the size of North Korea's troop deployment They say the North Korean soldiers arrived in Russia in October and that some of them have since engaged in combat in the Kursk region. Observers say North Korea's participation in the almost 3-year war threatens to escalate the con-

Park Sunwon, another lawmaker who was present at the NIS meeting, made similar comments on the briefing. He said the spy agency couldn't provide an assessment on possible North Korean casualties. (AP)

## Ukraine has seen success in building clean energy, which is harder for Russia to destroy

BAKU (AZERBAIJAN), Nov 20: Maxim Timchenko, CEO of DTEK, the largest private energy company in Ukraine, pulls out a piece of paper with bar charts showing how much new electricity his company has brought online this year in the country versus how much Russian bombs have destroyed.

Total electricity goes up, then down, then up, then down — capturing the company's constant rebuilding each time Russian missile attacks take out a facility, which include wind and solar farms and thermal (coal or gas-fired) generat-

The Russian strikes are part of a campaign to target energy infrastructure to reduce power in

Ukraine as winter looms. "What other choice do we have?" said Timchenko during an interview on the sidelines of this year's UN climate talks, taking place in Azerbaijan. "Sit and wait and pray that they don't hit us, or do our job and

bring lights back to our people?" The nearly three-year-long Russia-Ukraine war, which has left large swaths of Ukraine destroyed, has accelerated a transition to clean energy. At Ukraine's pavilion at COP29, on display is a large smashed solar panel, destroyed in an attack this year.

Russian forces continue to make



small but steady gains in capturing Ukrainian territory at a time when there are questions about how much the United States, which has been providing weapons and money, will continue to support the country once President-elect Donald Trump assumes office in January. During the campaign, Trump repeatedly said he could quickly end the war if elected, although he hasn't said

Whatever the future, the decentralized nature of some clean energies, in particular wind and solar, has allowed Ukraine to quickly restore power in ways that would be impossible with Ukraine's more traditional energy sources, such as coal-fired power plants

In centralised systems, all power is generated and sent to the grid over transmission lines from the same area. That means if the plant goes down, say in an attack, a large section of grid, or even the entire grid, comes to a halt.

By contrast, wind and solar installations are usually more scattered, so less of the system goes down with one hit, and if the solar is on rooftops, the impact can be even more limited.

Attacks on two DTEK solar farms last spring is a good example. They destroyed many solar panels and some of the transformers, which step up voltage for long distances or step it down for use in homes. Replacing the transformers and swapping out destroyed panels allowed the farms, which generate 400 megawatts, to be back up in seven days Timchenko said an attack on a

experienced a similar amount of damage, took three to four months to rebuild "That's the difference between centralised and so-called decentralised generation. It's much more

resistant and difficult to destroy,"

thermal generating station, which

said Timchenko. Geoffrey Pyatt, assistant secretary of the US State Department's Bureau of Energy Resources, said that Russian attacks on energy infrastructure have evolved. In 2022 and 2023, they focused on trans-

"The Ukrainians were incredibly efficient in working around those attacks. So Putin changed his tactics beginning in March to go after generation capacity," said Pyatt, referring to Russian President Vladimir

Since then, about 50 per cent of Ukraine's total power generation has been knocked out, leaving mostly nuclear, some hydropower and large new renewable projects, like a wind farm being built by DTEK, he added.

Renewable and other infrastructure projects are financed by partnerships between governments and

businesses, spreading out the risk. since there is no guarantee that something built isn't destroyed by missiles. In June, turbine maker GE Vernova and manufacturer Honeywell announced plans to partner with DTEK for major wind and battery storage projects in Ukraine. Roger Martella, chief sustainabil-

ity officer for GE Vernova, said that developing public-private partnerships was key to lowering risk and making investment more attractive. Ukraine's resistance was also an inspiration, Martella told a panel on Ukrainian renewables at COP29.

"We're humbled by the fact that Ukraine has done something no one has ever done before, which is to maintain the grid in a war-torn environment," said Martella. Pyatt, a former ambassador in Ukraine, said he has seen wide-

spread support for Ukraine's energy systems in the G7, a group of leading industrialised nations. While making clear he couldn't speak for the incoming Trump administration, Pyatt said he believed support for Ukraine in the energy

sector would "continue in any sce-

"If you start to get big American companies like GE and Fluxus and Honeywell involved in energy reconstruction, and there's going to be billions of dollars of energy reconstruction," he said. (AP)

"It's now eating into stocks, and to say otherwise would be dishonest," he told an audience at the Brookings Institution in Washington. China has ramped up its military pressure against Taiwan, including a massive military exercise that involved 125 warplanes in October, and has said annexing Taiwan is a historical inevitability.

China's military has increased its encircling of Taiwan's skies and waters in the past few years, holding joint drills with its warships and fighter jets on a near-daily basis near the democratically run island. The US, like most countries, does not recognize Taiwan as a country but is the island's main partner and is bound by US laws to provide it with the means to defend itself.

Ukraine just passed its 1,000th day since Russia invaded, and in that timeframe the US has provided more than USD 60.4 billion in military assistance, including three Patriot air defence systems and missiles, more than 40 High Mobility Artillery Rocket Systems and ammunition, and the coveted longer-range Army Tactical Missile System, or ATACMs, which Ukraine deployed in Russia for the first time on Tuesday.

In October, after Iran launched hundreds of ballistic missiles into Israel, the US deployed one of its few Terminal High Altitude Area Defense batteries to Israel and about 100 troops to help operate it.

The US also has regularly shipped air defence munitions as Israel presses its offensives against Hamas in Gaza and Hezbollah in Lebanon. The conflicts have killed tens of thousands of civilians.

The outgoing Biden administration has committed to spending the remaining USD 7.1 billion in presidential drawdown authority -meaning weapons pulled from US stockpiles -- to send weapons to Ukraine before President-elect Donald Trump takes office. (AP)

"The Kuki Organisation For Human Rights Trust (KOHUR) strongly condemns the killing of six Meitei women and children by armed miscreants in Jiribam district. The killing of fellow human beings irrespective of ethnicity or religion should be con-

"The Kuki-Zo remains steadfast in our commitment to not kill civilians even in times of war. We beseech the law enforcement agencies to find out the culprits behind the heinous acts," the tribal body said in a statement.

Three women and three children belonging to the Meitei community had gone missing from a relief camp in Jiribam after a gunfight between security forces and suspected Kuki-Zo militants that resulted in the deaths of 10 insurgents on November

The six bodies were found in the Jiri river in Jiribam and Barak river in Cachar of neighbouring Assam over the past few

The KOHUR also claimed that attention is given by the state government and the national media only when Meiteis are killed. ...it has already happened countless number of times to the Kuki-Zo. Kuki-Zo women and children have been killed, burned and mutilated as if they were animals," the statement said on

The Kuki organisation also demanded that law enforcement agencies investigate the deaths of a one-month-old baby and a



seven-vear-old boy who was "burnt alive" inside an ambulance along with his mother soon after the violence broke out in May

KOHUR also alleged that the 10 insurgents killed in a gunfight with security forces in Jiribam were Kuki-Zo volunteers who were shot from behind after having some conversation with the CRPF

"The CRPF jawans responsible for killing fellow Indian citizens without mercy should be investigated and prosecuted for their crime against humanity while being on duty to protect them," the statement said.

It maintained that Kuki-Zo women and children have been 'killed, burned and mutilated' several times over the last 18 months, but these cases have been 'overlooked and ignored', de-

## JAL, Jiribam strongly condemns militant attack on innocent civilians

<u>HT Bureau</u> GUWAHATI, Nov 20: A horrifying attack in Jakuradhor Village, Manipur, has left eight innocent civilians dead and several homes destroyed, sparking outrage and grief across the region.

The attack, carried out on November 11 2024, by armed militants identified as members of the Chin-Kuki-Zo-Hmar group, has been condemned as an act of organised terrorism.

The militants brazenly entered the Meitei-dominated village in broad daylight, setting 16 houses ablaze in the presence of Central Reserve Police Force (CRPF) personnel. In this act of barbarity, two elderly villagers, Laishram Barel Singh (63) and Maibam Kesho Singh (71), were burned alive inside their homes

In response, security forces engaged in a fierce gunfight with the militants, resulting in the deaths of 10 assailants. Their identities were later confirmed, revealing them to be heavily armed in-

dividuals from Churachandpur and Pherzawl districts. Security forces recovered a significant cache of weapons, including AK rifles, SLRs, INSAS rifles, and RPGs, further substantiating their role as organised militants rather than community volunteers, as claimed by affiliated organisations.

Tragically, the militants also abducted six civilians during the attack, including three women and three chil-

The victims were subjected to horrific torture and sexual violence before being killed. Over the course of several days, their bodies were recovered from the Barak River, with the final discovery made on November 18 2024.

The victims included Yurembam Rani Devi (60), Telem Thoibi Devi (31), Telem Thajamanbi Devi (8), Laishram Heitonbi Devi (25), Laishram Chingkheinganba Singh (2.5), and Laishram Langamba Singh (8 months).

The brutality of the incident has

drawn widespread condemnation. Jiri Apunba Lup (JAL), a local organisation, has described the attack as inhumane and a clear act of terrorism. They rejected claims by militant-affiliated groups portraying the attackers as innocent village defenders, labelling such

assertions as baseless and deceitful. The attack has also triggered protests in the region. In one such protest, Khundrakpam Athouba Meitei (24) was shot dead by Nectar Sanjenbam, SP (Combat), while another protester, Keisam Bison Singh (26), sustained serious injuries. JAL has demanded immediate action against the officer responsible for Athouba's death and called for justice for all victims of the atrocities committed on November 11.

This tragic incident has left the region in mourning and further heightened tensions in Manipur. Authorities are under mounting pressure to deliver justice for the victims and ensure the perpetrators face the full extent of the law.

## BJP, SP faceoff over allegations of manipulation, hooliganism

litical faceoff erupted Wednesday between the ruling BJP and main opposition Samajwadi Party in Uttar Pradesh amid the ongoing byelections to nine assembly seats with both parties accusing each other of foul play

While the SP alleged the BJP was manipulating the electoral process and questioning the role of the Election Commission, the BJP claimed SP workers are engaging in hooliganism and bogus voting with women and men donning

At a presser in Lucknow, Samajwadi Party president Akhilesh Yadav accused the BJP of misusing the administrative machinery to secure a win in the bypolls "through manipulation".

Yadav claimed his party had lodged complaints with the Election Commission (EC) regarding "irregularities" in multiple constituencies, including Karhal, Sisamau, Meerapur, Kundarki, Phulpur, and Majhawan. Despite these complaints, Yadav alleged that the EC was turning a blind eye to the issues

"The BJP wants to win these bypolls not through votes, but through manipulation," the former chief minister claimed and added that the ruling party was "pressuring the administration to act unfairly" and prevent opposition supporters from

"I urge voters to go to polling booths... and stay there until they



have cast their vote. This is a right granted to us, and everyone must exercise it," he added.

Yadav further slammed the BJP over "violation" of the EC's guidelines on checking voter IDs and for obstructing people from casting their ballots.

Earlier in the day, the EC ordered the suspension of police personnel found violating these guidelines after Yadav presented video evidence showing voters being harassed and blocked from voting. Yadav alleged that the BJP was preventing many people who intended to vote for opposition parties from casting their ballots to make up for a lack of enthusiasm among their own supporters.

"Many of their own people are opposing them. Their voters are slipping away and even voting against them," he claimed.

Yadav said the BJP's actions showed signs of panic and desperation, indicating that their "throne is shaking." He added that both the

public and internal factions within

the BJP were turning against them.

In a counterattack, BJP's Uttar Pradesh unit president Bhupendra Singh Chaudhary accused Samaiwadi Party workers of engaging in hooliganism during the by-elections.He claimed that SP supporters were attempting to influence the polls by bringing in outsiders and anti-social elements, alleging that women wearing burqas were participating in bogus voting.

"The red-capped goons of Akhilesh Yadav, who gave the slogan of 'PDA' (pichhde, Dalit, and alpsankhyak), are trying to spread terror," Chaudhary charged during a presser in Lucknow

"Neither the government nor the Bharatiya Janata Party nor the people of Uttar Pradesh will tolerate this." Chaudhary also slammed the SP for demanding that police not accusing them of using fake IDs to manipulate the election process. "Fake voting has become the

trademark of the Samajwadi Party," he stated, emphasising the importance of ID checks to maintain the transparency of the elections.

Chaudhary also claimed that in the by-election areas, the SP had brought in outsiders and anti-social elements to influence the polls.

"The way women wearing burqas are participating in fake voting is evident to all," he added. Chaudhary said in Mainpuri, the Saifai family and Akhilesh Yadav's goons were allegedly attempting to spread terror, referring to the murder of a 23-year-old woman allegedly over her voting preference for the bypoll.

"Neither the government nor the Bharatiya Janata Party nor the people of Uttar Pradesh will tolerate this. The red-capped goons of Akhilesh Yadav, who gave the slogan of 'PDA' (pichhde, Dalit, and alpsankhvak), should be kept under control. The police and administration will take action as necessary," Chaudhary added.

Chaudhary went on to accuse the SP of damaging its own credibility by questioning the EC's integrity.

They are creating chaos, which is their trademark. They are outsourcing voters by creating fake identity cards," he claimed.

Chaudhary also stated that the SP's "frustration" stemmed from the public's growing discontent

which once looted ballot boxes to form a government, has been rejected by the people. Their behaviour reveals their true character." Chaudhary said, vowing that the BJP would secure a massive mandate in these by-elections and ensure the Samajwadi Party's defeat.

Chaudhary also asserted that the accusations made by the SP regarding the by-elections were baseless. "By playing the victim card, the SP cannot hide its incompetence," he

Meanwhile, in a separate press conference, Deputy Chief Minister and BJP leader Brajesh Pathak claimed the SP is a party of hooligans and criminals.

"Whenever they got power in the state, they supported criminals. The bypoll is taking place peacefully but their gunde, mafia are creating chaos in every assembly seat. The innocent public is not voting for them but they are intimidating voters to get their vote," he said.

"We have seen in these polls that men are donning burqas to cast vote and BJP has regularly lodged complaint with the EC over this," Pathak claimed, accusing the SP of flouting constitutional values.

Referring to the Karhal incident, Pathak said he wants to appeal to the Dalit community to take note of the crime and never forgive SP.

"SP is no longer a party of Yadav community also. It is now limited to a family only, which is con-

### Centenarians, elderly citizens cast votes at polling stations in Mumbai

MUMBAI, Nov 20: A 113-yearold woman and a 103-year-old wheelchair-bound freedom fighter voted in the Maharashtra assembly elections in Mumbai on Wednesday, showcasing their commitment to the democratic process in the metropolis ill-famous for voter ap-

Several octogenarians exercised their franchise in various assembly segments in Mumbai since 7 AM, thanks to facilities such as wheelchairs, wheelchair-friendly vans, Divyang-friendly buses, stairclimbing wheelchairs etc being made available at polling booths by the Election Commission.

Kanchanben Nandkishor Badshah, a 113-year-old resident of Nepean Sea Road, went to a polling station at Malabar Hill to exercise her franchise with the help of her relatives, a civic official

Though the Election Commission of India has provided a home voting facility for senior citizens above 85 years, 103-year-old wheelchair-bound GG Parikh preferred to cast his vote by visiting the polling station at Girton High School in Grant Road in the morning hours, a civic official said.

A neighbour and his housekeeper helped Parikh enter the polling booth in his wheelchair. The centenarian freedom fighter has been voting since India's first general elections in 1951-52, his

Many elderly voters cast their votes at various polling booths in Mumbai since morning, reflecting at 6 pm. (PTI)

Hareshwar Barkale, an 81-yearold resident of Worli Koliwada. noted that the candidate in his constituency had arranged for golf carts and taxis to help senior citizens reach the polling stations, while wheelchairs and volunteers were stationed at the booths to assist them.

"We were given priority at the polling station and did not have to wait in line," Barkale said.

Similarly, 83-year-old Ramchandra Shirke from Kalachowki said he had no trouble casting his vote early in the morning.

The election process for the Assembly elections began at 7 AM and will conclude at 6 PM, with facilities ensuring that senior citizens and differently-abled voters face no inconvenience.

BENGALURU, Nov 20: ISRO Chairman S Somanath on Wednesday highlighted the need to manufacture car sensors domestically instead of relying on imports.

Speaking at a session on space technology and defence during the Bengaluru Tech Summit, which also saw the launch of the Draft Karnataka Space Tech Policy, Somanath emphasised the importance of cost-effective production.

He pointed out that while India invests significantly in producing rocket sensors, the high production cost of car sensors makes domestic manufacturing less viable.

"For car sensors, viability is achievable only if production costs are low and manufacturing is scaled up," he said.

Somanath called for greater industry collaboration to address this challenge and noted that policy interventions like those unveiled at the summit could provide a solution. He praised the 2020 space sector reforms and the Space Pol-



icy of 2023 for creating an ecosystem conducive to private sector

"There is a lot of interest in the sector. I hear from many aspiring to build the next SpaceX in India. he added. Highlighting progress, Somanath mentioned that five companies are currently building satellites, with many enhancing their capacity to develop subsystems for rockets and satellites. However, he identified a lack of major players and insufficient investment in upstream space capa-

bilities as key challenges. "To address this, we are focusing on developing downstream capabilities, which can generate demand and eventually attract upstream investments. I believe this model will work well for the na-

Somanath also stressed the role of technology transfer in enabling private sector participation, saying, "Many technologies developed within ISRO are now accessible to industries for further development into products, services, or soft-

The session featured other notable speakers, including B K Das, Director General of the Defence Research Development Organisation (DRDO), and Anne Neuberger, Deputy National Security Advisor of the United States.

The accused in the drug case, an Australian citizen, was arrested from the international airport in Thiruvananthapuram on charges of carrying hashish and the prosecution had produced an innerwear as part of the evidence against him saying the contraband was smug-

gled in that. The Australian citizen was sentenced to 10 years of rigorous imprisonment.

However, he was acquitted by the high court in 1993 after his counsel proved that the innerwear was too small for him

A police probe later showed that Raju, who had appeared for the accused, had received the underwear from the court and returned it four months later before the accused moved the high court.

Following this, a district court had ordered a case to be registered against Raju and court clerk K Jose in connection with the tam-

pering of the material evidence. Observing that the contention raised in the case relates to a fun-

the proceedings, which cuts the root of the proceedings, the high court said, "Therefore, it is absolutely necessary in the interest of the prosecution also that, such defect is rectified, and the proceedings are initiated in a proper manner in due compliance with the statutory stipulations"

Allowing the plea, the high court had said the order of taking cognisance on the final report and all further proceedings pursuant to the same, including the proceedings on the files of Judicial First Class Magistrate-I Nedumangad are hereby quashed.

"However, it is clarified that this would not preclude the competent authority, or the court concerned from taking up the matter and pursuing the prosecution in compliance with the procedure contemplated under Section

195(1)(b) of the CrPC. "Though, this court interfered in the proceedings for technical reasons, it cannot be ignored that the allegations raised are serious in nature," it had said. (PTI)

# Regional imbalances in Bengal led to disconnect between govt and people: Governor Bose KOLKATA, Nov 20: Days before completing two years in office. pleting two years in office, West Bengal Governor CV Ananda Bose drew upon his grassroots experiences to highlight "regional imbalances" between the state's northern and southern districts and claimed that lack of prosperity in the former region has led to a "disconnect" between the state government and its

Speaking exclusively to PTI about various issues, Bose refrained from evaluating his constitutional colleague, Mamata Banerjee, but made it clear that he was "more concerned" about her performance as Chief Minister than as a politician.

Expressing satisfaction with his tenure in office so far, Bose said, "These two years have taught me many positive things. It is a very refined state, which gives a lot of emphasis on art and cul-

"But the state has some problems especially in north Bengal, where there are arises because of that," he added, while explaining that "economic backwardness" in districts north of the Ganga has led to that "detachment" of people from the state administration.

Bose took over as Governor on November 23, 2022, from his predecessor, now Vice President Jagdeep Dhankhar.

Since then Bose has had several runins with the West Bengal government over various issues, including the appointment of vice-chancellors to state universities, Kolkata Police's alleged snooping on his office, and, most notably, the allegations of sexual molestation made against him by a woman contractual worker of Raj Bhavan.

"Mamata Banerjee's evaluation will be kept confidential. It will first be informed to appropriate competent authorities,' Bose said. "But from a common man's perspective or as a Constitutional colleague, my concern is the performance of cian. I don't want to bring politics into my purview of how she functions as a leader. Let political leaders of the other parties decide that, not me as Governor," he added.

The Governor, however, emphasised that he maintains a strong professional relationship with the CM, but added, "Politician Mamata Banerjee is not my cup of tea.'

Speaking about his achievements in office, Bose said, "My biggest takeaway is the understanding of the mind of Bengal, which has brought me closer to its people. I would like to be the Governor who is accessible to the people. Some media called me 'Ground Zero Governor', and I am delighted. I want to be in Ground Zero," Bose said.

'Whenever there is trouble, I go to the field, to the place of incident, to the hospital, to the families of the victims, and try to support them in whichever way I

"I am not a Governor who wants to rule by reports. I don't want filtered information. I want to be directly in touch

with people," he said. Responding to the alleged molestation incident involving a woman employee at Raj Bhavan, Bose expressed his disgust and described the matter as "false and fabricated by a woman with a criminal intent".

"Some false and fabricated allegations were made against me as an individual. That was done by a woman who has a criminal mentality. I have filed a suit before the Calcutta High Court," Bose clar-

Referring to reports from the Reserve Bank of India (RBI) and the Controller and Auditor General (CAG) regarding financial irregularities in Bengal, the former IAS officer alleged that the state government had violated the Constitution by not placing these reports in the Aslook into the grave financial management of the state. The Constitutional obligation of the government is to place the report of the CAG in the Assembly. That has not been done by this government, which is a constitutional violation," he alleged.

Asked about the law and order situation in the state, especially in light of rising criminal cases such as the RG Kar incident, Bose refrained from making a direct comparison with other parts of the

"But one thing which I am convinced of is that the two enemies of Bengal society are violence and corruption," he

"I cannot comment on a particular incident, but from media reports and after interacting with people, I find there is a growing feeling that violence and corruption allegedly linked to the RG Kar incident could have been prevented by the government. There is also a sense among effective action against it. Since the matter is sub-judice, I do not want to comment on the merits of that at this stage," he said.

Discussing his future plans for the people of Bengal, Bose said he prioritized his "duty, responsibility, and the authority to intervene when there is a violation of the

Constitution". "As far as violence is concerned, the right to life is a fundamental right. As a Governor, it's my duty to see that Constitutional rights are protected. I will certainly take up the fight against violence with all the strength that I have under the Constitution," he said.

Looking ahead, Bose expressed his desire to launch people-oriented programmes during his third year in office and added that he plans to link these initiatives with the welfare and development activities of the government of

## ED raids premises of audit company employee amid charges of Bitcoin use in Maha polls

MUMBAI, Nov 20: The Enforcement Directorate on Wednesday conducted searches at the Chhattisgarh premises of an auditing company employee, allegedly linked to a political Bitcoin transactions case in Maharashtra, as part of a money laundering investigation, official sources said

The house of Gaurav Mehta in Chhattisgarh's capital city Raipur is being covered under the provisions of the Prevention of Money Laundering Act (PMLA), they said.

The ED action comes when polling for the Maharashtra Assem-

bly elections is underway. The BJP on Tuesday played purported voice notes of NCP (SP) leader and Baramati MP Supriya Sule and Maharashtra Congress chief Nana Patole alleging attempts were being made to encash Bitcoins to influence the elections.

ED sources said the agency has widened its ongoing money laundering probe into a crypto (Bitcoin) assets ponzi scam and is investigating the "links" of Mehta and some others with politicians, politically exposed persons and bureaucrats.

The agency attached assets worth Rs 98 crore of actor Shilpa Shetty and her husband Raj Kundra in



probe. The couple challenged the ED action and got relief from the Bombay High Court.

Sharing some audio clips, in which voices and signal chats purportedly of Sule and Patole allegedly indicate that Bitcoins were used for funding the poll campaign, BJP spokesperson Sudhanshu Trivedi said it is clear that the MVA has seen the writing on the wall that it will be defeated in the polls.

Sule has denied the charges and said she has filed a complaint with the Election Commission and the cybercrime department of the state against the false allegations. She told reporters on Wednesday that

It was alleged by the ED that the Bitcoins were supposed to be utilised for mining and investors were supposed to get huge returns in crypto assets but the promoters "cheated" the investors and have been concealing the "ill-gotten" Bitcoins in obscure online wallets.

Kundra, the ED alleged, received 285 Bitcoins from the "mastermind" and promoter of Gain Bitcoin Ponzi "scam" Amit Bhardwaj for "setting up" a Bitcoin mining farm in Ukraine.

These Bitcoins were sourced from the "proceeds of crime" collected by Amit Bhardwaj from gullible investors, it said.

The agency arrested three people -- Simpy Bhardwaj, Nitin Gaur and Nikhil Mahajan -- in the case last

The main accused Ajay Bhardwaj and Mahendra Bhardwaj are absconding, the ED said, adding that it attached properties worth ₹ 69 crore in the case earlier.

### SC cancels bail of three accused in ex-Sarpanch murder case

NEW DELHI, Nov 20: The Supreme Court on Wednesday set aside the bail granted by the Rajasthan High Court to three accused in the cold-blooded murder of a former village sarpanch in Neemrana on May 31, 2023.

A bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar heard submissions from advocate Ronak Karanpuria, who represented the deceased Dinesh Kumar Yadav's brother, and overruled the high court verdict of

The apex court directed the accused -- Abhimanyu alias Pintu, Jaiveer, and Satya alias Chinnya -- to surrender and asked the lower court to expedite the trial.

The CJI said the accused may seek bail again in case there are changes in circumstances and if the trial proceedings get delayed due to reasons that cannot be attributed to them.

Karanpuria argued that the high court erred in granting bail to the accused without considering the gravity of the offence, the evidence of a premeditated conspiracy, and the potential threat to witnesses.

The case stems from the brutal killing of Dinesh Kumar Yadav, the former sarpanch of Gram Panchayat Silapur, Neemrana in Rajasthan.

On the morning of May 31, 2023, Dinesh was ploughing a field near a well with his tractor when two assailants shot him multiple times.

According to the FIR lodged by his brother, Roopesh Kumar, the nurger was part of a premeditated conspiracy fuelled by political rivalry and disputes over illegal en-

croachments. Roopesh, who witnessed the attack, identified the assailants and named several conspirators in his complaint, including Abhimanyu,

Jaiveer, and Satva. Despite being rushed to Kailash Hospital in Behror, Dinesh succumbed to his injuries. Police investigations revealed that the

murder was meticulously planned. The accused allegedly collab-

orated to eliminate Dinesh Kumar after multiple failed attempts. They allegedly hired shooters, Sachin and Yashpal, paid ₹ 23,000 to them and arranged a stolen motorcycle for their escape. (PTI)

ices remain unaffected. Nearly 80 departments and different agencies in the Delhi government, including the Municipal Corporation of Delhi, employ approximately 1.4 lakh people.

On Wednesday, Delhi witnessed vet another dawn with a blanket of toxic air as it recorded an Air Ouality Index (AQI) of 426 in the "severe" category, which followed the coldest night of the season in the city so far. Residents have reported eye irritation, respiratory discomfort, and other health issues.

Delhi environment minister Gopal Rai, in a post on X, said 50

Ravindranath Patil, who has levelled allegations of bitcoins misappropriation against some opposition leaders in Maharashtra, on Wednesday said he has approached the Election Commission for a probe

into the matter. Patil has claimed he is in possession of some voice notes of alleged conversations of these leaders, in which they are seeking encashment of bitcoins to fund elections.

The BJP on Tuesday played purported voice notes of Maharashtra Congress chief Nana Patole and NCP (SP) leader Supriya Sule to allege attempts to encash bitcoins to influence the state elections, claiming it poses a serious question on the conduct of polls in a free and fair manner. Both Sule and Patole have

denied the allegations. Speaking to PTI, Patil said the Pune police had roped him and cyber expert Pankaj Ghode to help investigate a 2018 case pertaining to a bitcoin cryptocurrency fraud.

However, in 2022, when Amitabh Gupta was the Pune commissioner of police. Patil and Ghode were arrested for allegedly cheating investigators by fraudulently transferring money to the tune of several crores

claimed he was falsely implicated in the case in 2022.

"I was in jail in the said case for 14 months. On November 17 this year, I started getting frantic calls on my Signal (app) account. When I checked the number, I found that it belonged to Gaurav Mehta who, as a forensic expert, had assisted police during a probe against me in the case," said Patil.

He claimed Mehta shared with him 10 voice notes on the Signal app which had purported audios of Supriya Sule, Nana Patole, Amitabh Gupta and Bhagyashree Navtake, who was the DCP (cyber) when he was arrested.

"I am in receipt of 10 audio clips of different people, including two politicians - Supriya Sule and Nana Patole - and three other persons --IPS officer Amitabh Gupta, IPS officer Bhagvashree Navtake and

Gauray Mehta," Patil said. Three voice notes were sent by Sule to Mehta, in which she is purportedly heard asking the latter to encash the bitcoins as the funds are needed for elections and assuring him that he need not be worried about inquiries and once they come to power, they will handle them, he

alleged. Patil also said there are voice notes of Patole purportedly asking Amitabh Gupta as to why money was not received and saying he should not make fun of him.

He claimed that in one of the voice notes, Gupta is purportedly heard giving instructions to Mehta to cash out the bitcoins.

"I have written to the Election Commission today, asking to initiate a probe into the matter," Patil said.

In his complaint sent to the EC via email. Patil stated that according to the chat messages which he claims to be in possession of, it appears that hundreds of bitcoins of billions of rupees may have been pumped in the previous Lok Sabha elections and during the ongoing assembly polls.

It also appears that Mehta is currently having the custody of the misappropriated bitcoins, amounting to hundreds of crores of rupees. Patil said in the complaint. "This is a very serious matter involving a criminal offence, blatant money laundering and use of massive cash during the election funding. Hence, it is requested to urgently investigate the matter. I am ready to support the investigation whenever I am called for," he said. (PTI)

## Rajasthan fourth BJP-ruled state to make 'The Sabarmati Report' tax-free

JAIPUR, Nov 20: Hindi film 'The Sabarmati Report', based on the 2002 Godhra train burning incident in Gujarat, has been made tax free in Rajasthan, Chief Minister Bhajanlal Sharma said on Wednesday.

Rajasthan follows three other BJP-ruled states -- Haryana, Chhattisgarh and Madhya Pradesh -- in giving the tax-free status to the Vikrant Massey-starrer film, which released in theatres last week.

"Our government has taken a meaningful decision to make the film 'The Sabarmati Report' tax-free in Rajasthan," Sharma posted on X.

"This film realistically depicts that horrific period of history, which some selfish elements tried to distort to fulfil their vested interests. The film not only effectively exposes the reality of the then system, but also refutes the misleading and false narratives propagated at that time," he added.

Directed by Dheeraj Sarna, the film is inspired by true events and also stars Raashii Khanna and Ridhi Dogra in pivotal roles. It is produced by Balaji Motion Pictures. On February 27, 2002, 59 people, mostly kar sevaks, were killed when a coach of the Sabarmati Express train was set afire near Godhra station, triggering widespread riots in Guiarat.

The Gujarat Police had blamed a Muslim mob for starting the fire, while an enquiry commission constituted by the Railway ministry under the Congress-led UPA government claimed that it was an accident. Courts, however, convicted a number of accused chargesheeted by the police, validating its charge. (PTI)



## Proud to be part of generation that's changing conversation: Himesh Patel on diversity in Hollywood



NEW DELHI, Nov 20: British star Himesh Patel says he draws inspiration from artists like Riz Ahmed and Dev Patel for opening doors for actors of South Asian descent in cinema but the work of representation is far from done and he has set high standards for himself.

Patel started his journey with a role on the long-running British soap opera "East-Enders" and then shot to fame with Danny Boyle's 2019 movie "Yesterday". Since then, he has been part of diverse projects like Christopher Nolan's sci-fi film "Tenet", Adam McKay's "Don't Look Up", dystopian series "Station Eleven" and now dark comedy "Greedy People". Growing up in the UK to Indian parents, Patel said it was only when he started working as an actor that he was exposed him to the barriers South Asian artistes face and that deepened his understanding of the challenges that lie ahead of him "The feeling of like wanting to see yourself and not seeing yourself as much, I think I was perhaps

only subconsciously aware of it when I was I just think the only way I can navigate it growing up. I was lucky I started acting when I was very young.

"It was when I started professionally working and I was working with other South Asian actors who had struggled to get to where they were, that I realized the battle that we kind of have," Patel told PTI in a virtual interview.

The actor said he is proud to be part of a generation that's changing the conversation. Patel is optimistic about making further strides when it comes to inclusivity and diversity after seeing the careers of Ahmed and Dev Patel.

"Riz is a great example and Dev for me, he was a spearhead of everything that's happened over the last many years. I feel 'Slumdog Millionaire' was a real turning point and then the career he's built off the back of that has been a real sort of calling card. It sets a bar.'

"I take a lot of encouragement and I try to follow the example of people like that.

is to set my bar high. I think we have to value ourselves highly and then we can get to where we need to get to," he added.

Patel said another welcome change in the industry is that actors of colour are being roped in for parts that were earlier played by white actors.

In his career, Patel has managed to essay varied characters, be it his role as Jack Malik from "Yesterday", Phillip Kaj from "Don't Look Up" or even his cameo appearance as Dr John Watson in "Enola Holmes 2". "In terms of actors like myself and other actors of colour, being considered for roles that would otherwise have just gone to a white actor, I think that's a positive thing."

"I'm glad that casting directors and filmmakers are willing to cast their net wide. A role may have been, I guess, written ostensibly as a white character, but if they are then willing to go that this is just a character, let's cast on that wide and whoever ends up being the right person for the role will play it, I think that's a very positive thing to do."

Patel's latest film is "Greedy People", a darkly comedic crime thriller from Potsy Ponciroli. In the movie, set to premiere on Lionsgate Play on Friday, the actor features alongside Joseph Gordon-Levitt and Lily James, his co-star from "Yesterday". There were a lot of different factors, Patel said, that made him say yes to the movie, starting from its script, which the actor found

quite interesting. "It leads to a really thrilling climax. I thought the character was really interesting, his sort of contradictions and moral ethical position," said the actor, who plays the role of Will Shelley, a rookie cop. "And then, of course, I knew that Lily James was attached, we've worked together before, I had a great time. So I was happy to sort of dive into something very different with her," he added. (PTI)

MALAGA (SPAIN), Nov 20: Rafael Nadal's last match as a professional was a 6-4, 6-4 loss to No 80 Botic van de Zandschulp in the Davis Cup as Spain was eliminated by the Netherlands.

Spain lost 2-1 in the quarterfinals of the team event that marked the last tournament for Nadal after more than 20 years on tour and 22 Grand Slam titles.

The crowd yelled "Rafa, Rafa. Rafa" when it was all over, and a special ceremony took place at center court to celebrate his career. After speaking to the fans, he cried while a video with his career highlights was shown.

'The truth is that nobody ever wants to arrive at this moment,' Nadal said. "I'm not tired of playing tennis, but it's my body that doesn't want to play anymore, so I have to accept the situation. Honestly, I feel super privileged for having been able to make a career out of my hobby, and for having played for much longer than I could ever have imagined. I can only be grateful to life and to all the people that I have here behind

After the ceremony was over, Nadal hugged his teammates and left the court while waving both arms and saluting the crowd one last time.

"I'll speak in the name of Spanish tennis and in the name of the tennis world," Spain captain David Ferrer said moments earlier. "You know very well what you have meant to the tennis world. We will miss you a lot. The Vamos, Rafa' chant will always be part of his-

## Following spell of unusual rain WACA curator believes Perth pitch free of 'snake cracks'

PERTH, Nov 20: WACA head curator Isaac McDonald on Wednesday said the unusual rain in Perth has impacted the pitch preparation for the first Test of Border-Gavaskar Trophy and though he doesn't expect the surface to develop "snake cracks", there will still be plenty of bounce and carry.

The surface at the Optus Stadium or at the nearby WACA ground is known for its pace and bounce and when the cracks open up in dry conditions, it provides more assistance to the seamers besides bringing the spinners into

The city has witnessed rain over the past few days and the pitch was covered for the whole day on Tuesday, cutting down preparation time for the curator.

"Yeah, it's definitely not traditional Perth Test prep. Yesterday we pretty much lost the whole day of prep with it being under cover. So we kind of saw the forecast early on and we started prep a little bit earlier than we normally

"So we're sitting quite comfortable still. It'd be nice if the sun would pop out and do its job but as of this morning we're in a good spot, we're really comfortable as a curating team," McDonald told media ahead of the series opener beginning on Friday.

The pitch is likely to retain moisture come match day, effectively ruling out the possibility of major deterioration over the course of five days.

"I don't think the weather is going to make this pitch fall apart. There'll be some deterioration, grass will stand up during the game and offer that variable bounce but in terms of big snake WACA cracks, unfortunately I don't think the weather is going to get us there," said the head cura-

The forecast is clear for Friday as well as the remaining four days but the temperatures are unlikely to increase drastically. McDonald
