## Adani, Sambhal issues rock

#### Parliament for 3<sup>rd</sup> day NEW DELHI, Nov 28: Proceedings in Parliament

were on Thursday washed out for the third day since the beginning of the Winter Session following disruptions by the opposition over the Adani issue and violence in Manipur and Sambhal.

Both the Lok Sabha and the Rajya Sabha were adjourned within minutes of convening.

The Houses were first adjourned shortly after they met on Thursday and were later adjourned for the day soon after reconvening at 12 noon amid the opposition parties' protests.

Before being adjourned, the Lok Sabha adopted a resolution granting extension to the Joint Committee on the Waqf Amendment Bill till the last day of the Budget Session next year. The Lok Sabha witnessed disruptions

during Question Hour, shortly after Congress leaders Priyanka Gandhi Vadra and Ravindra Chavan took oath as members of the Lower

Opposition members gathered in the Well, raising slogans for action against the perpetrators of the violence in Sambhal during a court-ordered survey of a

Mughal-era mosque. Parliamentary Affairs minister Kiren Rijiju flayed the protests, saying, "I condemn the attempts by the Congress and its allies in disrupting the House proceedings.'

As the opposition protests continued, Telugu Desam Party (TDP) MP Krishna Prasad Tenneti, who was in the chair, adjourned the proceedings for the day.

In the Rajya Sabha, chairman Jagdeep Dhankhar's appeals that Parliamentary disruption was not a remedy but a malady which weakened the foundation of India's democracy went unheeded as the opposition members protested.

The proceedings of the Upper House were adjourned within minutes after it met at 12 noon, following one adjournment shortly after 11 am.

Recalling that Wednesday marked a historic milestone -- the beginning of the final quarter-century before India's Constitution turned 100 --Dhankhar lamented that the House members missed the opportunity to engage in productive dialogue.

"This was a moment for our House of Elders, guided by the spirit of nationalism, to send a powerful message of hope to 1.4 billion Indians, reaffirming our commitment to their dreams and journey towards Viksit Bharat at 2047," he said.

'Yet, with deep regret, I must say we missed this historic opportunity. Where there should have been productive dialogue echoing the collective aspirations of our nation, we fell short of our people's expectations," he lamented. ## Himanta: CID to file chargesheet shortly

#### ONLINE TRADING SCAM: Victims question accused getting bail

HT Bureau GUWAHATI, Nov 28: Chief Minister Himanta Biswa Sarma on Thursday said that no accused in the multi-crore online stock trading scam can walk out of the jail as there are several cases pending against them.

Due to the Central Bureau of India (CBI)'s inability to submit a chargesheet within 60 days of their detention, two of the main suspects in the multi-crore online stock trading scam, Bishal Phukan and Swapnanil Das, along with six other people, were granted bail in the Gauhati High Court a few days

"There was a technical problem in the matter," Sarma stated in response to the development.

"After an accused individual is arrested, the CBI typically prepares a chargesheet within 90 days; however, the Gauhati High Court noted



that the chargesheet had to be filed within 60 days. A few accused individuals were granted bail by the court on this basis, but they are unable to leave the jail since the central investigation agency would appeal the bail decision to the highest court," he added.

"Moreover, there are several

cases filed against the accused persons in the online trading scam and the Criminal Investigation Department (CID) has been investigating them apart from the cases given

under CBI," he said. The chief minister further said that the CID is going to file a chargesheet very soon.

## UG students to soon get option to shorten, extend duration of degree courses: UGC chief

NEW DELHI, Nov 28: Higher Education Institutions will soon be able to offer an option to undergraduate students to shorten or extend their study durations instead of the standard duration of their degree programmes, according to UGC chairman Jagadesh Kumar.

The University Grants Commission (UGC) has approved the SOPs for HEIs to offer the Accelerated Degree Programme (ADP) and Extended Degree Programme (EDP) in a meeting this week. The draft norms will now be put in the public domain for feedback from stakeholders.

While the degrees will mention a self-contained note that the academic requirements required in a standard



duration have been completed in a shortened or extended duration, they

will be treated at par with standard duration degrees for academic and recruitment purposes.

"Students can use this option to shorten or extend their study durations based on their learning abilities. ADP allows students to complete a threeyear or four-year degree in reduced time by earning additional credits per semester, while EDP enables an extended timeline with fewer credits per semester," Kumar told PTI.

"Under ADP and EDP, students earn the same total credits as in the standard-duration programme. The higher education institutions will establish committees to evaluate students' eligibility for these programmes. These degrees will be equivalent to standard duration degrees for all employment and academic purposes," he added. According to the SOPs, the institutions may earmark up to 10 per cent of

the sanctioned intake for ADP. The HEIs may constitute a committee to scrutinize applications received at the end of the first or the second semester under EDP and ADP and select students accordingly.

In the ADP, students will follow the same curriculum content and total credits prescribed for the programme for a standard duration. "The only change will be in the duration of the programme. Students shall have the option to choose (CONTD. ON PAGE-2)

The BSE benchmark Sensex slumped 1,190.34 points or 1.48 per cent to settle at 79,043.74. During the day, it tanked 1,315.16 points or 1.63 per cent to

#### Abu Dhabi's IHC, Sri Lanka Port Authority, Tanzania reaffirm support for Adani Group

NEW DELHI, Nov 28: Abu Dhabi's International Holding Company (IHC), one of the largest sovereign funds that manages assets close to USD 100 billion, has reaffirmed its support to the Adani Group, saying its outlook on investments in the group remains unchanged despite the US indictment of the conglomerate's founder chairman Gautam Adani.

"Our partnership with the Adani Group reflects our confidence in their contributions to the green energy and sustainability sectors," IHC, one of Adani group's key foreign investors, said in a statement.

"As with all our investments, our team continues to evaluate relevant information and developments. At this time, our outlook on these investments remains unchanged.'

IHC had, in April 2022, invested about USD 500 million each in the renewables arm Adani Green Energy and power company Adani Transmission and a further USD 1 billion in the group's flagship Adani Enterprises. Later, it sold its 1.26 per cent stake in AGEL and 1.41 per cent in ATL, now called Adani Energy Solutions Ltd, but hiked its stake in Adani Enterprises Ltd to over 5 per cent.

The IHC statement comes soon after Adani group emphasised that its chairman and his aides have not been charged under the US Foreign Corrupt Practices Act but faced three other charges, including securities and wire fraud that are punishable with monetary fines.



The US Department of Justice's (US DoJ) indictment filed in a New York Court last week does not mention Gautam Adani, founder chairman of the ports-to-energy conglomerate, his nephew Sagar or Vneet Jaain in any count related to conspiracy to violate the FCPA, AGEL - the firm at the heart of allegation of USD 265 million bribes allegedly being paid to Indian officials to secure solar power sale contracts that could benefit bring in USD 2 billion of profits over 20 year period to the firm, had said in a filing to the stock exchange.

The three, who are executives at AGEL, have only been charged with securities fraud conspiracy, wire fraud conspiracy, and securities fraud, the company said. In general, the penalties for such charges are less severe than bribery.

Gautam and Sagar also face a civil complaint over violation of sections of the Securities Act and aiding and abetting Adani Green to violate

the Act, the company had said. Adani Group last week denied all allegations as baseless and said it would seek legal recourse

to defend itself.

Meanwhile, other international partners have also expressed their continued support. The Sri Lanka Ports Authority has expressed its ongoing confidence in its partnership with Adani, as the Indian group plays a vital role in expanding the country's port infrastructure.

With USD 1 billion investment in the Colombo terminal, the project is poised to be the largest foreign direct investment in Sri Lanka's port sector.

Sri Lanka Ports Authority chairman Admiral Sirimewan Ranasinghe (Retd) has reportedly stated that there are no discussions regarding the project's cancellation. The project will be operational in the next couple of months.

Also, the Tanzanian government has reaffirmed its commitment to its agreements with Adani Ports, as it feels that there are no concerns regarding the ongoing projects and that all contracts fully comply with Tanzanian law.

In May 2024, Tanzania and Adani Ports finalised a 30-year concession agreement to operate Container Terminal 2 at Dar es Salaam

Additionally, Adani Ports acquired a 95 per cent stake in Tanzania International Container Terminal Services, a state-owned entity, for USD 95 million. (PTI)

## Donald Trump 'friend of India': Goyal

NEW DELHI, Nov 28: President-elect Donald Trump is a "friend of India" and India-US friendship will only continue to blossom and grow further, Commerce and Industry Minister Piyush Goyal said on Thursday.

Trump, during his election campaign, had alleged that India, among all major countries, imposes the highest tariffs on foreign products and he had vowed to introduce a reciprocal tax if elected to power.

Addressing a media briefing here, Goyal also said he is looking forward to working with his counterpart in the United States once the official processes are over and the new government takes charge.

When asked about how India is placed as the new Trump administration is set to assume charge in the US, said, the minister said: "I think we need not jump the gun. We should let the new government (in the US) come and take charge and express their formal and official views but to the best of my understanding of the situation and my own experience in working with the Trump administration ... I do not foresee any problem whatsoever"

Prime Minister Narendra Modi, the world's most popular leader today, has managed India's international relationships better than ever in the past, Goyal added.

The minister emphasised Prime Minister Modi has worked with three administrations in the US, the Obama administration, the Trump administration, the Biden administration and "we will again work with the Trump administration". Goyal said India's relations with the US have got better and better every year.

"As Mr Trump is himself on record to say my good friend Mr Modi and the confidence he (Trump) has on the India relationship, India partnership have been expressed on many occasions," he said. (PTI)

Noting that he could not allow the House to sink to irrelevance, he said, "We should not dishonour the spirit of those who gave us this Constitution." However, as the protests continued, the chairman adjourned the House for the day. The Upper House will reconvene at 11 am on Friday.

When the Upper House convened at the start of the day, proceedings were adjourned for nearly 50 minutes till 12 noon as opposition MPs protested against the rejection of adjournment notices for a discussion on the allegations against the Adani Group in the US, and violence in Manipur and Sambhal. Shortly after the laying of listed papers in the morning session, Dhankhar said he had received 16 notices for adjournment of scheduled business under Rule 267 of the House. The chairman said he was rejecting all the notices. The notices were for discussions on the allegations of corruption against the Adani Group, communal violence in Uttar Pradesh's Sambhal and ethnic clashes in Manipur.

While Sanjay Singh (AAP), Randeep Singh Surjewala, Syed Naseer Hussain, Pramod Tiwari, Akhilesh Prasad Singh, Ranjeet Ranjan and Anil Kumar Yaday Mandadi (all Congress) had given notices for discussing the Adani issue, Tiruchi Siva (DMK), Sandosh Kumar P and PP Suneer (both CPI) had given notices to discuss the violence in Manipur. The burden of cases for each investigating officer has also lowered. In 2021, there were 52 cases per investigating officer in the police department which has come down to just 7.39 cases in June 2024.

"Due to our modernisation efforts, the average number of cases an Investigating Officer of @assampolice looks after has significantly come down, reducing their burden and improving quality of investigation", Sarma had said. The commission has noted that the HEIs may issue degrees for students on completion of the programme in the opted duration (shortened or extended duration) and need not wait to complete the standard duration for the award of the formal degree. "For the accelerated and extended degrees, a self-contained note should be added in the degree stating that the academic requirements required in a standard duration have been completed in a shortened or extended duration. "For an ADP of a four-year undergraduate programme, the note should specify that the student completed the academic requirements of a four-year programme in six or seven semesters, as the case may be," Kumar said. ## Feasibility study highlights potential for sustainable goat farming in Dimakuchi

Cooperative-driven model aims to transform traditional practices into an economically viable livelihood for rural households

GUWAHATI, Nov 28: A feasibility study conducted in Dimakuchi, Udalguri district, on Wednesday has revealed promising opportunities for sustainable goat farming in the region. Under the guidance of Jayanta Kherkatary, CHD Cooperation, BTC, and with support from fellows of the BTR Development Fellowship Program, the study aims to elevate goat farming from traditional backyard practices to a structured, cooperative-driven en-

The pilot project focused on Sekhar SS Ltd., a cooperative society with around 3,700 shareholders, to explore the viability of goat farming as a sustainable livelihood option. The findings indicate that the region's climate and natural resources are ideal for breeds such as Black Bengal and Beetal. While



Black Bengal is highly sought after in local markets, Beetal shows excellent potential for export. The availability of lush green fodder and access to a well-equipped veterinary hospital further strengthens the prospects for successful goat farming in Dimakuchi.

The study emphasises that if implemented effectively, this initiative could transform goat farming into a thriving, economically vi-

merous households in the region. The cooperative model proposed in the study seeks to create a scalable framework, ensuring inclusivity and long-term growth. The study offers a roadmap for developing goat farming as a major livelihood source in Dimakuchi, paving the way for rural development and economic self-sufficiency in the BTR. This initiative aligns with BTC

areas, including interdisciplinary science research expenditure, the success of such research, facilities for interdisciplinary science research, and administrative support, including promotional policies.

THE-ISR evaluates data from 157 million citations, 18 million research publications, and survey responses from more than 20,000 scholars globally. Prof DC Baruah, director of the

Centre for Multidisciplinary Research, who also leads the Internal Quality Assurance Team of the university, stated that the THE-ISR global recognition will further enhance the interdisciplinary culture of education at the university.

Prof Shambhu Nath Singh, vicechancellor of the university, congratulated the TU fraternity engaged in interdisciplinary research for the global recognition of their work.

#### Sambhal unrest and legal disputes

he recent events in Sambhal and the deaths of five young Muslim men underline the importance of the Places of Worship (Special Provisions) Act, 1991 enacted by Parliament in that year. This legislation prohibits "conversion of any place of worship" (Section 3) and provides for "the maintenance of the religious character of any place of worship as it existed on the 15th day of August, 1947 (Section 4). No person can "convert any place of worship of any religious denomination or any section thereof into a place of worship of a different section of the same religious denomination or of a different religious denomination". The Ramjanmabhoomi-Babri Masjid dispute was kept out of the purview of the Act. The judgment of the five-member bench on the Avodhya dispute in 2019 had also reiterated the validity of the Places of Worship Act and stated that no claims against extant religious places can be entertained by law. However, the Supreme Court, in May 2022, allowed a survey of the Gyanvapi mosque in Varanasi. A petition filed in the district court stated that the mosque was built on the ruins of a demolished temple. A bench headed by the then Chief Justice of India, D Y Chandrachud, allowed the survey to continue opining that finding the nature of a religious place was not barred under

By this egregious judgment, the flood gates were opened for Hindu communalists to rake up legal disputes at various places where mosques exist. The demand for the Gyanvapi mosque survey was followed by a similar case in the Eidgah in Mathura and the district court ordered a survey. The next in turn has been Sambhal. On November 19, the district court allowed a survey of the Mughal era mosque built in 1526 on the basis of an application filed by an advocate, Vishnu Shankar Jain, the one who had earlier moved petitions in the district court of Mathura and Varanasi. The application was immediately admitted despite the fact that the mosque is a protected monument. With surprising alacrity, the court went on to set up an Advocate Commission and ordered the survey to be conducted on that day itself. The survey report was to be submitted on November 29. The Masjid Committee was not even given a hearing.

With the full cooperation of the Masjid Committee, the survey was carried out. However, on November 24, the survey team arrived at the mosque to conduct another survey. This time, they were accompanied not only by the police, but by a large number of people chanting 'Jai Sri Ram'. A crowd of Muslims collected and soon after the situation went out of control with stone throwing, lathi-charges, tear gas and firing. Three young Muslim men died with gunshot wounds and two more succumbed to their injuries later. The local Samajwadi Party MP and the son of a Samajwadi Party MLA have been accused of inciting rioting and violence in FIRs filed by the

## Uruguay's Left Opposition leader Yamandu Orsi wins presidential elections

American Left, Uruguay's left Lwing opposition candidate Yamandu Orsi became the country's new president after defeating convincingly the candidate of the ruling far right coalition Alvaro Delgado in the presidential elections held on Sunday, November

With nearly all the votes counted, electoral officials reported that Orsi won 49.8 per cent of the vote, ahead of Delgado's 45.9 per cent. The rest cast blank votes or abstained in defiance of Uruguay's enforced compulsory voting. Turnout in the nation with 2.7 million eligible voters reached almost 90 per cent.

The defeat of the incumbent far right government is a big news for the liberals and the Left in Latin America since Uruguay has been under the far right rule in the last five years despite a strong Left movement. The Uruguayan victory of the Left opposition is a continuation of the pink wave in the Latin American region in the last three years. During this period. Left presidents took over power in Honduras and Columbia which witnessed the far right rule for long.. In recent years, the Right was successful in toppling a left leaning president in Argentina and also replacing the popular left

president in Ecuador. President elect Orsi, soon after the election results were out, struck a conciliatory note towards the defeated far right opposition by mentioning that he would take care of the interests of 3.4 million people as a whole and he would take all with him in building a prosperous Uruguay. Mr. Orsi

takes office on March 1, 2025. Álvaro Delgado, the presidential candidate for the center-right ruling coalition, conceded defeat with grace and offered his cooperation to the new president. His other party leaders were upset at the defeat as many of the ruling elite are facing charges of corruption which is a common feature of the governments in the ruling Latin American parties.

57 year old President elect Yamandu Orsi is from the working class. He is a history teacher and

Broad Front coalition. A political heir to former President José 'Pepe' Mujica, an ex-Marxist guerilla who became a global icon for transforming Uruguay into one of the most liberal and environmentally sustainable nations in the region, Orsi rode to power on promises of safe change and nostalgia for his left-wing party's redistributive social policies

However, political analysts say that President elect Orsi will be pragmatic in implementing his new programmes so that fresh investments come to the country to create additional jobs. Orsi is a moderate Left believing in the policy of gradual change. He favours driving down the childhood poverty rate, now at a staggering 25%, and containing an upsurge in organized crime that has shaken the nation long considered among Latin America's safest.

Orsi is also likely to work for a trade agreement with China. Orsi is expected to maintain its relations with the USA and the US companies while taking more care

of the national interests. From 2005-2020, the Broad Front coalition presided over a period of robust economic growth and pioneering social reforms that won widespread international acclaim, including the legalization of abortion, same-sex marriage and sale of marijuana. The process was halted during the far right rule between 2019-2024. Now president elect Orsi is expected to give another big push to the social justice part of the earlier Front programme.

Orsi proposes tax incentives to lure investment and revitalize the critical agricultural sector. He supports security reforms that would lower the retirement age but fall short of a radical overhaul sought by Uruguay's trade union. Uruguay's economy is presently under control with inflation easing and the growth rate touching three per cent this year. President elect Orsi will have enough flexibility in implementing his programme for big boost to the economy. The Uruguayan people are looking to the coming President with high expectations. (IPA

## **CPI, CPI(M)** fail miserably in Jharkhand polls by fighting outside INDIA bloc

ith the identity quotient for Adivasis getting electoral prominence and political economic character of the labour force undergoing a major shift from the traditional features, the left parties in Jharkhand appear to be losing ground as is manifest from the votes they could poll. Both CPI and CPI(M) contested nine seats each but both failed to open their accounts. Their share of votes were: Communist Party of India 491689 votes, 2.08 per cent, Communist Party of India (Marxist) 159906 votes and 0.67 per cent. Even Communist Party of India (Marxist-Leninist) (Liberation) with 559126 votes, and vote share 2.37 per cent could manage to win two seats, Nirsa and Sindari. While CPI-ML was with

INDIA bloc, both CPI and CPM walked out of the alliance. Undeniably both these parties were active in the coal belt some three decades back and commanded significant following, but in recent times, the sign boards literally identified the parties. There is no denying that the CPI(ML)-L has of late emerged as the public face of the left forces in Jharkhand. After the results were out, the CPM state secretary Prakash Viplav had told media; "There is no doubt that our performance was not good. The election had become a fight between the INDIA bloc and NDA, so our votes also got diverted." He nevertheless expressed happiness at the victory of secular forces.

CPI district secretary Ajay Singh literally accused the INDIA bloc, precisely the JMM for not taking the CPI along. At a time when the issue of defeating the rightist and anti-Adivasi forces led by BJP and RSS had turned out to be defining strategy of choosing INDIA bloc candidates, the CPI and CPI(M) should have adopted a more pragmatic and realistic approach. The CPI claimed that its performance in the four seats of Simaria, Chatra, Daltonganj and Barkattha, where the victory margins of NDA were nominal, could have turned in its favour. But the fact is in Daltonganj its candidate could poll around 4200 votes in comparison to 102,000 of BJP and at Barkatta it candidate could fetch 2100 votes in contrast to nearly 80,000 votes of NDA

Out of the four constituencies -Bagodar, Nirsa, Sindri, and Rajdhanwar - that CPI (ML) contested, the party secured victories in Nirsa and Sindri - which have a large number of industrial workers. Bagodar in a way has been the traditional seat of CPI(ML). In the past it was held by Mahendra Singh, a senior CPI(ML) leader. After his death, his son Vinod won from this seat. But this time he lost. Bagodar is a general constituency. In the 2019 polls, Vinod of CPI(ML) won the seat with 98,201 votes, defeating his nearest rival, Nagendra Mahto of BJP. IN this election Vinod was the

runner-up with 70,559 votes.

The left place has been taken by CPI-ML-Liberation. But the CPI still continues to assert its significance by recalling that glorious history. Even after the CPI lost its electoral relevance, being the oldest communist party in India, it is given respect by other left parties. ## India getting ready with digital base as part of labour reforms

ndia is moving fast with its intention of implementing the next phase of labour reforms. Digital bases are being put in place, that may ultimately pave the way for smooth transition to new labour code regime, implementation of which is likely to be announced soon, though it is generally considered to be a minefield that would be very problematic to navigate by both workers and employers. Both the stakeholders are yet not ready to the occasion, though Centre and the majority of States and UTs are ready with their laws required for implementation.

The latest few moves of the Centre indicate in this direction. It has already put eShram portal for migrant and informal workers, and directions have already issued to Ministries and Departments to ensure payments of subsidy and incentives to beneficiaries of the welfare schemes through Aadhar Payment Bridge.

Under the Aadhar Payment Bridge, Central Government has earlier ordered the ministries and departments to ensure 100 ner cent Biometric Aadhar Authentication Now, it has ordered the Employment Provident Fund Organisation (EPFO) to ensure employers to complete the first stage of the process of Universal Account Number (UAN) activation through Aadhar-based OTP by November 30, 2024, starting with the latest joinee employees in the current financial year 2024-25.

In the second stage of the process, going forward, UAN activation will include the state-of-the-art facility of Biometric authentication, through Face-recognition

Thereafter, the Employers are required to complete the process for all employees working with them. It is part of the EPFO reform that is required to ensure that maximum number of employers and employees benefit from the Employment Linked Incentive (ELI) Scheme announced in the Union Budget 2024-25.

It is in this backdrop, the Ministry of Labour & Employment has directed EPFO to work in a campaign mode with Employers and ensure activation of Universal Account Number (UAN) of employees. EPFO, in their turn, will involve their zonal and regional offices for effective outreach.

The Union Ministry of Labour& Employment has said that using Aadhar as an identity document simplifies government delivery processes, enhances transparency and efficiency, and ensures beneficiaries receive their entitlements seamlessly. Aadharbased verification eliminates the need for producing multiple documents to prove

Three schemes A, B, and C were launched in the Union Budget 2024-25 to give Rs 10.000 crore subsidies to employ ers under ELI scheme through EPFO for every new membership, and it was claimed that it would generate 8 million jobs, apart from skilling 10 million youths over the next five years.

EPFO has just celebrated its foundation day, and on that occasion, the Union Ministry of Labour and Employment had said, "India's economy is currently undergoing a transformative shift marked by an increasing trend toward formalization - a process that is redefining job structures, employ-

ment security, and social benefits for millions. This change is of profound importance for India's workforce, as it ensures that a larger segment of the population is covered by social security systems, offering them greater economic stability and a more secure future."

The process of creating a digital base for entire informal and formal workforce in the country is likely to make the transition from the old labour laws regime to the new labour code regime a little smoother. PM Narendra Modi has already labelled the new labour codes as the largest labour reform in India since independence, which according to him would benefit both the employees and employers - employees with better working conditions and employers with ease of doing business.

Nevertheless, transition is not likely to be smooth on account of fear of new problems that the implementation of the codes would bring to both the stakeholders - the employees and employers. The joint platform of the 10 Central Trade Unions (CTUs) has been agitating against the four labour codes since PM Modi government had got them passed - Code of Wages in 2019. trial Relations Code, Code on Social Security, and Occupational Safety, and Health and Working Conditions in 2020. Government supported Bharatiya Mazdoor Sangh (BMS) has also reservations on certain provisions of the codes which they say need further discussion before implementation.

As for the Employers, navigating from old labour laws regime to the new labour codes regime would not be smooth either, though the new four codes were prepared by subsuming 29 of the 44 labour related laws to make doing business easier. Barring the big Corporate companies, all other companies would have to undergo numerous problems while implementing the new labour codes, since they would require to identify and make arrangements as per the new laws involving funds to deal with the complexities in compliance and the new possible legal pitfalls.

The EPFO, ESI, and eShram platforms have already displayed considerable level of problems in implementation of the new direction of the Central government. States and UTs will also be required to make enough arrangements in terms of skilled manpower, digital space for themselves, and effective implementing machinery.

Nevertheless, the fast-changing world of work will compel all stakeholder to adopt to the new realities on the ground as far as fast emerging new Employment regime is concerned that heavy relies on technology and Artificial Intelligence.

Even the four labour codes are almost five years old during which the world of work has drastically changed, requiring further tweaks in the codes themselves. Foolimplementation of the codes suitable changes to meet the challenges of the fast changing world of work after COVID-19 crisis of 2020 could be disas-

The joint platform of CTUs is still threatening strong protest agitation against implementation of the labour codes, including all India strike action. Employers may face pressures from the government to implement the new laws on the one hand and from agitating workers on the other. (IPA

Beyond policy and personal foibles, the US elechold immense significance. Till now, the first Trump presidency has often been viewed as an aberration and the Biden term as the norm. Now. however, it is the latter which seems to be a discontinuity. The second Trump term, which has been an all-round victory for the "Make America Great Again" (MAGA) forces, will now be the norm for the US in the near

The Trump win was not a defeat of liberalism, with its emphasis on individual rights, the rule of law, and constitutional checks on the state. It was one for neoliberalism, which pushed globalism, abandoned the working class, and emphasised money-making over everything else. The American working class was wiped out as manufacturing relocated to Asia. Instead of their plight, neoliberal Democrats focused on narrower strands of the deprived—racial minorities, the LGBTQ community, immigrants, and so on. As deprived people, they were often given a leg up, even as the original working class sank and be-

ble to the appeal of MAGA politics. While this originally attracted the white working class, Trump succeeded in getting the support of the Black and Latino working class as

Many people think that Trumpism will be a selflimiting disease. That the impossibility of achieving the contradictory set of objectives it has set for itself will temper Trump's im-For instance, take the

issue of tariffs. Trump said last month, "tariff is the most beautiful word in the dictionary." Most economists agreed that 10-20 percent tariffs on all imports and 60 percent on Chinese imports tariffs will raise prices in the US. There is a school of thought which believes that enacting tariffs will be a negotiating tactic, and nothing more. If this is so, there are two possible outcomes other countries will lower their trade barriers, or, the more likely outcome, retaliate with their own tariffs. This will lead to an inflationary situation, something that Trump should know proved to be poison for the Democrats in this

The big target is Mexico. Trump has declared that he will raise tariffs 200 or 500 percent: "I don't care. I'll put a number where they can't sell one car" (in the US). Currently, Mexico is the US' biggest trade partner and has sold 2.55 million cars in the US in 2023. Tariffs would hit companies like Honda, Toyota, and Volkswagen, but it would also affect American companies like Ford, General Motors (GM), and Stellantis, whose supply chains extend to Mexico, while also using the country as a manufacturing base.

For Mexico, it will be a double whammy, since the largest number of undocu-

With regards to immigration, Trump wants to close the border and begin the process of deporting up to 11 million undocumented migrants. He has appointed hard-liners Stephen Miller and Thomas Homan to undertake this task, signalling his intention of fulfilling his campaign promises.

This is no ordinary task as this community is now woven into the US' social and economic fabric. Vice President J. D. Vance has said that the target is to deport some 1 million illegal immigrants per year. Prising them out, setting up detention centres, overcoming legal chal-

lenges and encouraging them to return to their homelands could take years. It will also affect the economy since migrants are the backbone of agriculture and construction industries, and their presence has helped keep wages in A deportation check. process is likely to lead to inflation.

In many of these areas,

the real question is what Trump will decide to focus on. Apparently, there are no less than 40 agendas he has promised to begin pursuing from his first day in office. Definitely, avenging himself against those he says have persecuted him in the Biden administration will be a priority. Among the targeted persons could be Jack Smith, former Attorney General Merrick Garland, as well as Trump's friends-turned-enemies such as John Kelly, former Joint Chief of Staff, Chairman General Mark Milley, and Liz Cheney. Another strand of his policy will be a change in the rules to allow the firing of any federal official. There could be large-scale firings, accompanied by the appointment of MAGA supportors in

their positions. Foreign policy is an area that will experience a big

Rubio as Secretary of State signals a hardline approach. Rubio is known for his hawkish positions on Iran, China, and Venezuela, as well as his support for Israel's campaign in Gaza.

Ukraine is likely to be a

big loser, though the North Atlantic Treaty Organization (NATO) could also find itself in crosshairs. Both the US and European Union (EU) short-changed the Ukrainians in the last two years through their niggling weapons supply policies. Now Ukraine may be forced to cede territory to achieve peace, even while NATO's status hangs in the air. JD Vance has suggested that the aim would be to have Russia and Ukraine ceasefire along the current frontlines, which means a loss of around 18 percent of Ukrainian territory that Russia has occupied since 2022. The Vance plan would also guarantee Ukrainian neutrality towards Russia.

As for Israel, Trump will be more supportive of Israeli military activities and would not, like the Biden Administration, use US military assistance as leverage to push Israeli policy in any specific direction. According to the Times of Israel, Trump has told Netanyahu that he wants an end to the Gaza war by the time he takes office on 20 January 2025.

But there are other issues where the US position will benefit Israel as well—particularly, destroying Hezbollah in Lebanon and dealing with Iran. Trump had walked away from the nuclear deal with Tehran and begun a campaign of "maximum pressure," with harsh sanctions to push Iran to end its nuclear programme and its policy of arming regional proxies like Hezbollah and Hamas. There is a lot of talk about Trump's hardline views on China. But people often forget that in January 2020,

no reason to believe that another such deal could not take place and also include the status of Taiwan also in it. America is in trouble. Its polarisation has deepened with this election and Trump's attacks on the government have weakened the important infrastructure of American

There is little doubt that the West-led multilateral world order that was put in place after World War II is headed for a change. It has been showing strain for some time now, but the MAGA victory could have sounded the death knell.

The UN Security Council (SC) is more or less frozen with the divisions between Russia, China, and the West. As for the World Organization Trade (WTO), Trump has ensured that its appellate function was torpedoed in 2016, and now, with a tariff war around the corner, there is little chance that it will be able to do anything about

The Biden administration had strongly backed NATO and America's East Asian allies—Japan, South Korea, Philippines and Australia. In the case of NATO, Trump has questioned whether the US would honour the alliance's mutual defence clause and has actually suggested that he would encourage Russia to "to do whatever the hell they want" to any NATO country that doesn't pay enough

All this is not necessarily bad. Countries of the Global South could benefit from the US' retreat from its dominant role in world affairs. The new multilateralism fostered by organisations like BRICS could reshape the world to better serve Indian interests. But this is no ordinary task, this new multilateralism will have to go beyond its penchant for declarations and deliver results on the

#### Why Bangladesh is pushing back at India on spate of border killings

Swarna Das, a 14-year-old student from Bangladesh, was waiting to cross the border and enter Tripura. She and her 40-year-old mother had paid 5,000 Bangladeshi taka, approximately Rs 3,500, to agents who said they would help them cross over, the teenager's brother, Pintu Das, told Scroll.

"They wanted to meet our uncle who lives across the border in Tripura's Dharmanagar town," said Pintu Das. The family lived in Kalnigarh village in Bangladesh's Moulvibazar district – 60 km from Tripura

His mother did not want to cross the border under cover of darkness. "But the agents insisted that they cross the border at night," he said. "When they approached the barbed wire fence, my mother and sister shouted and asked the people on the other side not to fire. However, the BSF [Border Security Force] personnel may not have understood their language and opened fire."

A bullet hit Swarna and her body was taken away by the Border Security Force personnel. "My mother was rescued by the agents, but she does not remember how she was saved," recounted Pintu

Several media reports, quoting unidentified Indian officials, said that the 14year-old was shot dead by the Border Guard Bangladesh while trying to enter India without documents. However, Swarna Das's family members said she was hit by a bullet from the Indian side. "Maa told me that she saw the bullets coming from across the border. The BSF did not give any warning. It was total darkness," Pintu Das told Scroll.

Eight days later, another 14-year-old, Jayanta Kumar Singh, was allegedly shot by BSF personnel while trying to cross the border into West Bengal with his fa-

According to Dhaka-based human rights organisation Ain O Salish Kendra, at least 18 Bangladeshi citizens have been killed by the BSF till September this year. The number was 28 in 2023, 23 in 2022 and 16 in 2021

Since the fall of the Sheikh Hasina government in August, eight people have been killed on the border while allegedly trying to enter India, according to human rights organisations in Bangladesh and India. The dead included two Hindus, though none of them were reported to be fleeing persecution.

Several Bangladeshi citizens, including supporters of Sheikh Hasina's party Awami League, have reportedly tried to cross over to India fearing reprisal after her flight from Dhaka.

The situation on the border has become riskier, said activists. "If anyone tries to cross the border, they are being shot," said Kirity Roy, secretary of a Calcuttabased organisation that has investigated alleged excesses by the BSF in the border areas in West Bengal. "If they wear lungi a garment worn by several Muslim men the probability [of getting shot] is higher. This is becoming the norm.'

While border killings have always been a point of contention between the two countries, the new government in Bangladesh appears to be pushing back more strongly.

It has formally lodged three protests with New Delhi since August 5, protesting against the indiscriminate killings and asking for action against those responsible.

The ministry of external affairs has not responded officially to the protests over the border killings. Separately, India has been calling upon the Bangladesh government to ensure the safety of minorities and their places of worship.

A former Indian high commissioner to Dhaka, who declined to be identified, told Scroll that the protests were another reflection of "an anti-Indian sentiment" in the administration led by Nobel laureate Mohammad Yunus.

Significantly, on September 23, Bangladesh had also lodged a "strong protest" against the remarks by Union Home Minister Amit Shah against socalled "Bangladeshi infiltrators" during

#### his visit to Jharkhand. Dhaka talks tough

The first protest came from Dhaka on September 5 after the killing of Swarna

In the protest note sent to the Indian High Commission in Dhaka, Bangladesh strongly condemned such "ruthless acts". It said that border killings were in violation of the provisions of the Joint Indo-Bangladesh Guidelines for Border Authorities, 1975.

"Any national of either country entering each other's territory without valid documents may be dealt with in accordance with the laws of the respective country [but] under no circumstances should they be subjected to torture and death," the statement read.

Five days later, Dhaka shot off another note to the Indian High Commission asking India to investigate all border-related killings, identify those responsible and

bring them to justice. A third note was sent on October 9 after the killing of a Cumilla resident on the border. The Border Security Force had called the deceased an armed "drug smuggler", who was shot while trying to push contraband goods into India.

Diplomatic relationships between India and Bangladesh have been rocky since August 5, as India is perceived to be a *Scroll.in*)

> "The relationship is under some strain because both at the level of public and the Bangladesh government, fingers have been pointed at Indians for supporting Sheikh Hasina," the former Indian high commissioner to Dhaka said.

India's position over the years on the border killings has been to assure Bangladesh that they will not recur, and urging the BSF to be more careful. "We have been defensive and despite the promises, the killings continue," the former high commissioner said.

He pointed out that the issue is complicated – there are occasions when smugglers attack the BSF with lethal weapons. 'At that moment, they have to defend themselves. But you can't justify the killings of 12-13-year-old children."

Pinak Ranjan Chakravarty, another former high commissioner to Bangladesh, however, said the BSF action was directed against a cartel of smugglers, who have political clout in Bangladesh. He also attributed the killings to greater vigilance on the border after the fall of the Sheikh Hasina government.

"Security was heightened and when people tried to cross over, they must have been challenged and shot," Chakravarty said. "Shooting them acts as a deterrent. It conveys a warning to potential smugglers and infiltrators.'

A BSF official posted in Meghalaya also told Scroll that the border was on a higher alert. "We have become more vigilant since the unrest and change in political situation in Bangladesh.'

Over the months, many Bangladeshis have tried to cross after they escaped from unrest and killings, the official said. He referred to the discovery of a decomposed body of an Awami League leader from Bangladesh on August 26 in Meghalaya's East Jaintia Hills district.

BSF officials told Scroll that they resort to firing "only in cases of self-de-

"The incidents of shooting occur when a large number of people come with agents and attempt to infiltrate the border, sometimes attacking our personnel," said Ravi Gandhi, additional director-general of BSF's eastern command. "At that time, in self-defence, our personnel open

#### A long border

The India-Bangladesh border is one of the longest borders in the world, with five Indian states - Assam, West Bengal, Mizoram, Meghalaya, and Tripura - sharing a boundary with the neighbour.

The residents living along both sides of the border share close ties, stemming from similar languages, cultural lineages, and family connections. However, this close relationship has also facilitated both legal and illegal trade between communities on either side.

For decades, the border has made headlines for smuggling – of cows, counterfeit notes and even cough syrup – illegal immigration, cross-border terrorism, and human rights violations.

"Citizens from both sides are involved in illegal trade, especially of essential commodities," said Abu Ahmed Faijul Kabir, senior coordinator at Ain o Salish Kendra, in an interview with Scroll. "The Indian government has tried to control this illegal trespass, and since then, the shootings have started."

According to Roy, from the Calcuttabased organisation that has investigated alleged excesses by BSF in the border areas in West Bengal, "the killings have increased under the Narendra Modi gov-

In 2019, Roy's Banglar Manabadhikar Suraksha Mancha helped the Human Rights Watch to publish a 81-page report on the border situation. The report alleged that over 900 Bangladeshi nationals had been killed by the BSF between 2000 and 2010, many of them when they crossed into Indian territory for cattle rustling or other smuggling activities.

Activists from both sides of the border alleged that the BSF and Border Guard Bangladesh are "corrupt forces". "People from both sides – security officials and civilians – are involved in the smuggling," said Roy. "Political leaders irrespective of parties, the state police, BSF and excise officials, and smugglers are all part of a nexus."

A resident of a border village in Naogaon District of northern Bangladesh, which shares a border with West Bengal's Dinajpur, agreed.

"We have seen over the years that the illegal crossing and trade occurred with the help of both sides," the border resident said. "It is an open secret."

Roy claimed that the number of meetings between the border forces to defuse tensions has come down since the change of government in Bangladesh. "India trusted the Hasina government more."

Kabir, the activist from Bangladesh. said that those who have been killed over the years often belong to poor and marginalised groups. "They are not caught with weapons and pose no threat to security, as they primarily enter India for trade," he said.

He argued for less use of force by the BSF. "Indian authorities should apprehend and arrest those who illegally enter India under existing laws, and punish them through the courts. This would at least save their lives." (Courtesy:

## Trump 2.0: Stark challenges for the climate and global stability

onald Trump will take ver as US President on January, 20 2025 and his pre-election promises would have economic and environmental consequences. On the economic front, countries worldwide would face still stronger dollars sucking money out of emerging markets, high protectionist tariffs imposed and consequent trade war slowing the growth and increasing inflation globally. His regime is not only committed to sacking thousands of bureaucrats and replaced by his supporters but has also announced a new department named the Department of Government Efficiency (DOGE) to be headed by Elon Musk and Vivek Ramaswamy to slash the bureau-

cracv. No doubt it would disrupt the continuity of the functioning of government, and it would also lead to job losses. Nationwide federal government employs nearly 3 million people. Trump says Musk and Ramaswamy would dismantle government bureaucracy, slash excess regulations, cut wasteful expenditure and restructure federal agencies. While Musk has announced to cut \$2 trillion from the federal budget, Ramaswamy has proposed to eliminate the educa-

tion department and FBI. Internal Revenue Service as well as cutting the federal workforce by 75 per cent in a mass layoff. Trump has consistently maintained to levy a 10 per cent tariff on all imports in the US, 60 per cent on imports from China and 100 per cent on cars imported from China. This would mean cutting imports from many countries which may even result in trade wars. Capacities created in countries like China would be rendered unutilised. With limited domestic consumption in China, the country would face a backlash.

If all countries take action to cut on imports, it certainly boomerangs somewhere and exports would be adversely impacted in most cases. A 10 per cent tariff on imports would inleast 3 per cent and a continued trade war may even further raise

While domestic producers in the US would welcome it, the consumers will have to pay more. Tariff is not the solution to all problems. Trump's idea to shift manufacturing back to the US may be hit by supply chain disrup-

tion on account of higher tariffs. The job creation in the US may be impacted. In his first term, Trump increased tariffs on Aluminum and Steel to bring its manufacturing back to the US, but the goal was not achieved. His acceptance of higher prices to be paid by consumers, while protecting producers had also made consumers pay 18 per cent extra on Washing machines in 2018. Later some of Trump's tariff was increased by Biden too. It went up to 100 per cent on electric vehicles, 50 per cent on solar cells and 25 per cent

on batteries from China. It had its impact on climate action too – the transition to cleaner energy was slowed down. Herbert Hoover, a Republican, US President nearly a century ago had similarly announced the imposition of tariffs, which ultimately culminated in the adoption of the Smoot-Hawley Act, of 1930 and increased tariffs by 40 to 60 per

It led to a trade war and the US faced retaliation from its trade partners too. It triggered the great depression and the worst economic crisis humankind has ever experienced. Presently global economy is already facing considerable headwinds, any trade war can have disastrous consequences. US's technological advancement for decades has placed it as the

leading powerhouse in the world. Its investment in research and development has been quite re-

warding as evident from the fact that there have been more Nobel laureates in the last five or six years than the rest of the world put together have produced. With its technological superiority, the rest of the world is depend-

ent on it economically too and the

tariff policy would leave them be-

China's growth has been manufacturing followed by exports. With the slowdown in exports, it is dealing with the problem of overcapacity of its industries and making efforts to boost domestic consumption. There has been budget constraint in Europe money is spent on subsidies in several countries, causing growth retardation. Germany, to continue producing in the country has to match the US subsidy offering 900 million euros to Swedish battery makers Northvolt, which is experiencing sluggish growth of the economy. Subsidies continue to slow the growth globally.

As the growth suffers, climate action also suffers. For instance, countries in the African subcontinent have vast potential for solar and wind energy, which has remained untapped so far.

China's interest in Africa is going up through its belt and Road initiatives; it has an eye on the natural resources of the continent. It is to be seen whether Trump 2.0 can counter China in Africa.

In his election speeches, Trump has already sought to restore US manufacturing and has targeted to end the Chinese dominance in sectors like advanced information technology, high-end numerical control machinery, robotics, aviation equipment, maritime engineering technology, sophisticated rail equipment, energy-saving vehicles, electrical equipment, medical devices and agriculture

machinery etc. European business finds it now difficult to continue investing in China and India should try to leverage the churn to its advantage. President-elect has already announced Immigration hardliner Tom Homan for the deposition of illegal immigrants. He said that there is nobody better in policing and controlling US borders and there is no doubt that Homan will do a fantastic job which has been long awaited.

Homan also spoke to the press supporting the deportation of even US-born children of undocumented immigrants. Another Immigration hardliner Stephen crease US prices of goods by at hind in the trade war. So far Miller has been announced to be

heavy debt and indebtedness would further increase the deficit. Despite a good chemistry between Trump and Modi, India may not be spared of 10 per cent tariff, which may impact our imports. By 2028, when Trump's term ends, not only the US, but many other countries will be reeling under high inflation and poor growth. UN is also reconciled to accept a cut in US funding in Trump 2.0. A US retreat at the UN is likely to open the door for China, which has been building influence in global diplomacy.

The best part of Trump's promises is that he would stop funding war. The end of war in West Asia and Ukraine is expected soon. The re-election of Trump has cast a shadow on the ongoing world climate summit in Baku, Azerbaijan. His withdrawal from the Paris Agreement in his first term and halting climate funding has slowed down the progress glob-

Trump in his election campaign has vowed to ignore any climate emergency. He has been categorical in his election speeches abandon climate, drill, baby, drill. He has also joked in speeches that if the sea level rises, we will have more properties facing the sea. In some other speeches, he said that why should we be concerned if the sea level rises by a thousandth of an inch after thousands of years?

Global leaders at Baku perceive the inaction and obstructions from the US and debate whether they can afford such inaction for four more years. The court had asked the attorney general to inform it about the steps taken by the government regarding ISKCON's recent activities, according to The Daily Star.

Hindu leader Chinmoy Krishna Das, who was arrested this week, was earlier expelled from ISKCON. His arrest triggered clashes on Tuesday during which Advocate Saiful Islam, an assistant public prosecutor, was killed.

He was denied bail and sent to jail by the Chattogram's Sixth Metropolitan Magistrate court in a sedition case on Tuesday.

In a statement on Tuesday, ISKCON Bangladesh General Secretary Charu Chandra Das Brahmachari said, "We express our serious concern and strongly denounce the recent arrest of Chinmoy Krishna Das ... We also condemn the subsequent violence and attacks against Sanatanis in various regions of Bangladesh." (PTI)

## **12 dead in Sri Lanka** following extreme

COLOMBO, Nov 28: At least 12 people are reported dead and over 3.30 lakh people affected in Sri Lanka due to extreme weather conditions following a massive rain system in southwest Bay of Bengal, officials said on Thursday. Eight of the dead were reported from the eastern district of Ampara.

The inclement weather is a result of a Deep Depression (extremely heavy rainfall causing system) in the Bay of Bengal, the officials said, it has mainly affected the eastern province. By 8 am local time on Thursday, over 3,30,000 people from over 98,000 families in 21 districts have been affected, Disaster Management Centre (DMC) officials said. The meteorological centre has forecast further heavy rains till Friday while the National Building Research Institute (NBRI) had on Wednesday issued landslide warnings covering four of the nine provinces. More than 80 houses were completed damaged due to floods and landslides. Over 25,000 people have been relocated to 260plus shelters at safe locations, the

officials added. President Anura sanayake ordered the deployment of military personnel to provide relief to the affected. Earlier on Wednesday, at least six Colombo-bound flights were diverted to other airports due to heavy rain – 75 mm in 24 hours ending at 8:00 am - and high winds experienced in most parts of the island.

The Irrigation Department had issued flood warning for several lowlying areas of Kelani River Basin and Kala Oya Basin effective until Friday

## Another massive Russian missile, drone attack targets Ukraine's energy infrastructure

KYIV, Nov 28: Russia conducted "massive" attack against Ukraine's energy infrastructure on Thursday, firing nearly 200 missiles and drones and leaving more than a million households without power, Ukrainian officials said.

Russia's second major aerial attack on Ukraine's power grid in less than two weeks amplified fears that the Kremlin aims to cripple the country's power generation capacity before winter.

"Attacks on energy facilities are happening all over Ukraine," En-Minister Halushchenko said in a post on Facebook. He added that emergency power outages were implemented nationwide.

In some regions, Kalibr cruise missiles with cluster munitions smashed into civilian targets, Ukrainian President Volodymyr Zelenskyy said, calling it "an insidious escalation." Cluster munitions release numerous small bombs over a wide area, making them dangerous to civilians both during and after an attack.

Ukrainian officials have warned recently that Russia was stockpiling cruise and ballistic missiles, presumably for another pre-winter aerial campaign against Ukraine's power grid. Ukrainian officials have in the past accused Russia of weaponising winter."

Around half of Ukraine's energy infrastructure has been destroyed during the almost three years of war with Russia, and rolling electricity blackouts are common. Kyiv's Western allies have sought to help Ukraine protect power generation with air defense systems and funds for rebuilding

Russia in previous years has targeted Ukraine's electricity generation, aiming to deny civilians critical heating and drinking water supplies during the bitter winter months and break Ukrainian spir-



hobble Ukraine's defense industry that is now producing missiles, drones and armoured vehicles, among other military assets.

The war has been going in Russia's favour in recent months as its bigger army uses its advantages in manpower and equipment to push Ukrainian forces backward in eastern areas, though its offensive has been slow and costly.

Explosions were reported in Kyiv, Kharkiv, Rivne, Khmelnytskyi, Lutsk, and many other cities in central and western Ukraine.

Zelenskyy urged Western countries to accelerate delivery of promised air defence weaponry. Ukrainian officials in the past have grumbled that military aid is slow to arrive.

"Each such attack proves that air defense systems are needed now in Ukraine, where they save lives, and not at storage bases," Zelenskyy said on the Telegram messag-

The head of Ukraine's presidential office, Andrii Yermak, said in a Telegram post that Russia had stockpiled missiles to strike Ukrainian infrastructure and wage war against civilians during the cold season. "They were helped by their crazy allies, including from North Korea," he wrote.

Western governments and South Korea say North Korea in recent support for Russia

The head of the Lviv region in western Ukraine, Maksym Kozytskyi, said the attack left more than half a million households without

Over 280,000 households in the northwestern Rivne region were without electricity because of the attack, according to regional Gov. Oleksandr Koval. Running water supplies were also patchy in affected areas. Some schools in Rivne city switched to online classes.

There were also strikes on the bordering Volyn region, where 215,000 households had no electricity, regional head Ivan Rudnytskyi said. All critical infrastructure that lost power was switched to

Energy infrastructure was also targeted in the western Ivano-Frankivsk region, local officials said. Air defences were activated there, and emergency power outages were introduced.

Local officials ordered the opening of "points of invincibility" shelter-type places where people can charge their phones and other electrical devices and get refreshments during blackouts.

In Kyiv, where the air raid alert lasted over nine hours, missile debris fell in one neighbourhood, local officials said. No casualties

## Hindu American groups seek sanctions against Bangladesh over attacks on minorities

demning attacks on minorities in Bangladesh, several Hindu American groups have sought that US aid for the South Asian country be made contingent on its government taking measurable action to protect these populations.

Bangladesh's minority Hindus, which constitute only about 8 per cent of the 170 million population, have faced over 200 attacks in 50odd districts since the fall of Sheikh Hasina's Awami League government on August 5.

Things took a turn for the v this week after Hindu spiritual leader Chinmoy Krishna Das was arrested in a sedition case. He was later denied bail by a court, triggering protests by community members in various locations, including the capital Dhaka and the port city of Chattogram.

Das was a member of the International Society for Krishna Consciousness (ISKCON) and was recently expelled. Vishva Hindu Parishad America of Kali Mandir in Chittagong and the rising attacks on Hindus across Bangladesh are disconcerting. "Is this the human rights legacy

These incidents are part of a "broader pattern of discrimination". he alleged.

"The lack of international condemnation only further emboldens the perpetrators and threatens the safety and freedom of minority communities in Bangladesh," Mittal said.

In an open letter to Presidentelect Donald Trump, Hindus for mended halting US funding for projects in Bangladesh tied to Beiing's ambitions and prioritising initiatives that benefit America and its allies directly.

"Hindu, Buddhist, and Christian communities in Bangladesh have faced systemic violence and discrimination. We humbly ask that your administration make US aid contingent on the Bangladeshi government taking measurable action to protect these populations. Taxpayer dollars should never support governments that fail to safeguard their most vulnerable citizens," said HFAF Founder and Chairman Utsav Sanduja. He claimed certain Bangladeshi

## Trump claims win on immigration after call with Mexico's President, but she suggests no change

WEST PALM BEACH (US), Nov 28: President-elect Donald Trump declared a win on stopping illegal immigration through Mexico on Wednesday after talking with that country's leader. But Mexican President Claudia Sheinbaum suggested Mexico was already doing its part and had no interest in closing its borders. The two spoke just days after Trump threatened to impose sweeping new tariffs on Canada and Mexico as part of his effort to crack down on illegal immigration and drugs.

Trump said Sheinbaum "agreed to stop Migration through Mexico." Sheinbaum indicated separately on social media that she told Trump that Mexico is already "taking care of' migrant caravans, calling it an "excellent conversation."

"We reiterate that Mexico's position is not to close borders but to build bridges between governments and between peoples," Sheinbaum added. While the state of the proposed tariffs remained unclear, Trump said in a post on his Truth Social account that this was "effectively closing our Southern Border." He called it a "very productive conversation.'

The exchange between the two leaders appeared to confirm for Trump the value of threatening to disrupt trade with import taxes. His initial social media post moved financial markets and gave him a response he was quick to describe as a win. Even if the proposed tariffs fail to materialise, Trump can tell



supporters that the mere possibility of them is an effective policy tool and continue to rely on tariff threats.

Sheinbaum wrote on social media that the leaders "discussed Mexico's strategy on migration issues, and I told him the caravans are not reaching the northern (US) border, because Mexico is taking care of them.

"We also talked about reinforcing cooperation on security issues, within the framework of our sovereignty, and the campaign we are carrying out to prevent fentanyl consumption," she said.

Illegal migration across the Mexico border is down in part because the Biden administration secured some stepped-up cooperation from Mexico — the sort Trump seems to be celebrating. Arrivals at the US-Mexico border have dropped 40 per cent from an all-time high in December. US officials mostly credit Mexican vigilance around rail yards and highway checkpoints.

Driven by mounting pressure from the US to block migrants going north, in the past few years Mexican authorities have turned to rounding them up across the country and sending them to southern Mexico, in a strategy seen by experts as an attempt to wear migrants out until they give up. Neither side clarified the status of the tariffs. But their implementation could fuel higher prices and slow economic growth, potentially blowing up the trade agreement among the US, Canada and Mexico that was finalised in 2020 during Trump's previous time in the White House.

Trump on Monday said he would impose a 25 per cent tax on all products entering the country from Canada and Mexico as one of his first executive orders upon taking office on January 20. He also proposed an additional 10 per cent tariff on China tied to its exporting of materials used in the production of fentanyl. (AP)



The House of Representatives on Wednesday overwhelmingly carried the bill 102 votes to 13.

Communications Minister Michelle Rowland urged senators to pass the bill which she said reflected the Australian community's

"The ... government is on the side of supporting parents and protecting young people," Rowland told the House. Once the legislation becomes law, the platforms would have one year to work out how they could implement the ban before penalties are enforced.

The platforms complained that the law would be unworkable, and urged the Senate to delay the vote until at least June next year when a government-commissioned evaluation of age assurance technologies made its report on how young children could be excluded.

Critics argue the government is attempting to convince parents it is protecting their children ahead of general elections due by May. The government hopes that voters will reward it for responding to parents' concerns about their children's addiction to social media. Some argue the legislation could cause more harm than it prevents.

Criticisms include that the legislation was rushed through Parliament without adequate scrutiny, is ineffective, poses privacy risks for all users, and undermines parental authority to make decisions for their children.

Opponents of the bill also argue the ban would isolate children, deprive them of the positive aspects of social media, drive them to the dark web, discourage children too young for social media to report harm and reduce incentives for platforms to improve online safety. (AP)

## Tripura CM, CPI(M) condemn attacks on Hindus in Bangladesh Body of NFR security officer recovered

Alleges anti-minority actions, urges secular movement

AGARTALA, Nov 28: In line with the Centre, Tripura chief minister Manik Saha on Thursday issued a warning against attacking minority Hindus in Bangladesh and emphasised the need to protect minorities.

The warning came following attacks on minority Hindus in Bangladesh.

"Prime Minister Narendra Modi has always said that without the unity of youths, the development of the country is not possible, and the country cannot become powerful. Today's rally was great. I attended the rally, rode a bike, and encouraged the Yuva Shakti. Everyone is happy. We believe in Sabka Saath, Sabka Vikas. We have raised the slogan of making Tripura drug-free, and we will fulfill it," CM Saha stated after attending the conclusion of the 7-day-long 'Namo Yuva Yatra' at Rabindra Shatabarshiki Bhawan here on Thursday.

CM Saha also emphasised the importance of securing Sanatan Dharma. "The Bangladesh matter is an inter-

national issue. Our central leadership has communicated and sent their message on this. Similarly, we must also urge restraint and asking the protection of minority Hindus in Bangladesh. We are monitoring the situation closely, and I have already spoken to the DGP to keep a close watch on the borders to ensure no intruders cross over," he ex-



plained.

He criticised opposition parties for their silence on the Bangladesh issue.

Meanwhile, the opposition CPI(M) in Tripura has appealed to secularminded forces in Bangladesh to raise their voices against the alleged attacks on minorities and to launch a movement to oust the interim government in the neighbouring country.

CPI(M) state unit secretary Jitendra Chowdhury claimed that the present government in Bangladesh has "taken a stand as if Pakistan is its big friend" and is "against the spirit of liberation war" in the neighbouring country.

"The situation in Bangladesh is now not normal. An interim government has taken over the reins there, which

has launched attacks on minorities. I would appeal to the people who are secular to launch a movement to change the present government in Bangladesh", the CPI (M) leader told

Notably, former Bangladesh foreign minister Hasan Mahmud, in an interview with PTI, accused the interim government headed by chief advisor Muhammad Yunus of allowing "mobocracy" to replace democracy.

Mahmud, who was one of the senior-most members of Sheikh Hasina's ministry till it was ousted on August 5 following a student uprising, underscored that the increase in violence against Hindus and attacks on temples appears strongly correlated with the uptick in anti-India rhetoric.

"The interim government in Bangladesh has taken a stand as if Pakistan is its big friend...This government is against the spirit of the liberation war," Chowdhury said.

"When an autocracy develops attacks on the minorities become inevitable. Bangladesh is experiencing the same...the BJP captured power in Tripura by reducing the elections into a farce," Chowdhury alleged.

Asked to comment on the arrest of Chinmoy Krishna Das, who advocates minority rights in Bangladesh, Chowdhury said, "I am talking about the attacks on the minorities and that should be stopped."

India had recently noted with "deep concern" the arrest and denial of bail to Hindu leader Chinmoy Krishna Das in Bangladesh, and urged authorities in the neighbouring country to ensure the safety and security of Hindus and all other minority groups.

In a statement, the MEA said it has noted with "deep concern the arrest and denial of bail" to Das, who is also the spokesperson of the Bangladesh Sammilit Sanatan Jagran Jote.

Reacting sharply to the MEA's statement on the arrest of Das, the Ministry of Foreign Affairs in Dhaka said it was "unfounded" and stood contrary to the spirit of friendship between the two countries. (With inputs from PTI)





Dressed in a cream Kasavu saree from Kerala, Priyanka Gandhi rose to take oath amid cheers of 'Jodo Jodo, Bharat Jodo' from the Congress benches. She took oath with Congress president Mallikarjun Kharge, her mother and Congress Parliamentary Party (CPP) chief Sonia Gandhi, husband Robert Vadra, son Raihan and daughter Miraya watching from the galleries. Congress MPs earlier met at the CPP office in the Parliament premises where Priyanka Gandhi was greeted and congratulated by leaders.

## Dynastic candidates were fielded across Maharashtra in assembly elections

MUMBAI, Nov 28: Dynastic candidates -those with family ties to established political families -- were fielded across party lines in the recent Maharashtra assembly elections, with more than 80 per cent of constituencies featuring such contestants.

But political connections did not guarantee success as a modest 30 per cent of such candidates won, noted a report compiled by activist and political observer Heramb Kulkarni.

Even the Bharatiya Janata Party (BJP), which routinely targets the Opposition over dynastic politics, had over 30 per cent of its contestants with ties to political families.

Of the total 288 constituencies, 237 (82 per cent) saw candidates from political families. They included the children, spouses, siblings or other relatives of former and sitting MLAs, MPs and ministers, said the report released on Wednesday.

The Nationalist Congress Party (SP) led by veteran Sharad Pawar had the highest proportion of dynastic leaders in its candidate list. Of the 86 candidates it fielded, 39 or 45 per cent were related to established

Of 59 candidates fielded by the rival Ajit Pawar-led NCP, 26 or 44 per cent had 'family connections'

The Congress followed closely with 41.5 per cent such candidates (42 of 101).



(which contested the highest number of seats among all parties), 49 or 32 per cent were related to political leaders.

The two Shiv Sena factions had comparatively less dynastic representation in their

The Uddhav Thackeray led Shiv Sena (UBT) nominated 19 dynastic candidates in its list of 95 (20 per cent), while the Eknath Shinde-led Shiv Sena too had 19 such nominees among its 81 contestants (23 per cent), the report said

candidates showed an interesting pattern. Western Maharashtra recorded the highest concentration, with 77 dynastic candidates, followed by Vidarbha with 49, Marathwada with 39. North Maharashtra with 38 and Mumbai-Konkan with 34 such contestants.

As many as 61 constituencies had more than one dynastic candidates. These included ten constituencies where there were three such contestants, and one constituency with four dynastic nominees in the fray.

The region-wise distribution of dynastic

against each other. The most high-profile of these contests unfolded in Baramati where NCP chief Ajit Pawar defeated his nephew Yugendra Pawar, a debutant fielded by the

In Kannad constituency, Sanjana Jadhav of Shiv Sena -- daughter of BJP leader Raosaheb Danve -- defeated her estranged husband Harshvardhan Jadhav who contested as an independent.

In Aheri, Dharamrao Baba Atram of Ajit Pawar-led NCP defeated his daughter Bhagyashri Atram of NCP (SP).

Of 237 dynastic candidates, 89 were successful in winning the election. A large proportion of unsuccessful candidates were from the Opposition Maha Vikas Aghadi (MVA) alliance of the Congress, Shiv Sena (UBT) and NCP (SP) which generally faced a rout, the report noted.

The ruling Mahayuti alliance of the BJP, NCP and Shiv Sena won a landslide victory in the November 20 elections, bagging 230 of 288 seats.

While the Congress and undivided NCP had always seen dominance of dynastic politics, the BJP saw a rise in the number of such leaders after 2014 when it came to power in the state as well as at the Centre, the report noted, though it did not provide any figures for the purpose of comparison. (PTI)

#### NODC row: Majhi says govt to respect sentiment of Sundergarh people



BHUBANESWAR, Nov 28: Odisha Chief Minister Mohan Charan Maihi on Thursday said that the state government would not take any decision against the wishes of the people of Sundergarh regarding the proposal of including the mineral-rich district under the proposed North Odisha Development Council (NODC).

Earlier, during a visit to Sundergarh district, Majhi said that Sundergarh district in the western part of the state should be included in the NODC. Majhi made this announcement through his social media X post hours after Sundergarh MLA Jogesh Singh raised the issue in the Assembly. BJD lawmaker from Bhadrak district Byamakesh Ray also said that there are differences between the culture, language and tradition of western and northern Odisha.

In an X post, Majhi said, "The people of Sundergarh have been blessing us for many years and we respect the sentiments of the people of Sundergarh. Therefore, the government will not take any action against the wishes of the people of Sundergarh. The state government is committed to the overall development of Sundargarh district."

BJD MLA from Sundergarh, Jogesh Singh during the Zero Hour in Assembly said despite being the constitutional head of the state, the chief minister has made an irresponsible statement. "We condemn the announcement

and urge the CM to withdraw the statement," he said. Singh also said that the language,

cultural practices, tradition, way of life and geographical features of Sundergarh people have no similarities with north Odisha districts. The government should not create division in the unity of Western Odisha. Ray, who hails from north Odisha, said the chief minister should refrain from making such statements that create division among the people.

Meanwhile, protests were reported from Sundergarh district over the chief minister's statement. Sundargarh District Congress Committee held a demonstration at DRDA Chowk in Sundargarh town and condemned the CM's state-

Majhi had earlier said that according to the election promises made by the BJP, his government has been working to set up the NODC to expedite development of the region at a fast pace. Majhi has said that he wished Sundergarh to be included under the NODC for speedy development. (PTI)

# Intense debate over court notice on Ajmer dargah plea

'Worrisome', 'painful', 'what is the problem'... the rift over a claim that the famed shrine of Sufi saint Khwaja Moinuddin Chishti was built over a Shiva temple widened on Thursday with politicians, community leaders and others weighing in on the potentially volatile issue.

On Wednesday, a local court in Aimer, known the world over as home of the dargah visited by thousands of devotees cutting across religious divides every day, issued notices to the dargah committee, the Ministry of Minority Affairs and the Archaeological Survey of India on the plea seeking to declare the shrine a temple.

The notice came just days after four people were killed in Sambhal in Uttar Pradesh in violence following a local court ordering survey of a Mughal-era shrine, the Shahi Jama Masjid, which petitioners said was built after destroying an old temple. And set off fears that Ajmer could become another communal tinderbox.

While dargah committee officials declined to comment, Syed Sarwar Chishti, secretary of the Anjuman Syed Zadgan, a body representing the khadims (caretakers) of the Ajmer dargah, described the petition as a deliberate attempt to fracture society along communal lines.

He said the dargah which he described as a symbol of communal harmony and secularism comes under the Minority Affairs ministry and the ASI has nothing to do with it. "The community accepted the decision in the Babri Masjid case and we believed nothing will happen after that but unfortunately such

The plea seeking directions to start worship in the temple was filed in September and the next hearing is on December 20.

"Our demand was that the Ajmer dargah be declared a Sankat Mochan Mahadev Temple and if the dargah has any kind of registration, it should be cancelled. Its survey should be done through ASI and Hindus should be given the right to worship there," plaintiff Vishnu Gupta told reporters.

The Hindu Sena president has referred to a book by academic Har Bilas Sarda to support his claim that there was a Shiv temple where the dargah was raised.

He claimed he had conducted research for two years and found that there was a Shiva temple which was destroyed by Muslim invaders and

The Communist Party of India (Marxist) said in a statement that the civil court's decision to entertain the petition is unwarranted and has no legal standing.

"It goes against the provisions of the Places of Worship (Special Provisions) Act, 1991, which decrees that no legal dispute can be raised on a religious place that existed prior to August 15, 1947," it said.

"The violation of this Act has already resulted in the flawed decision with regard to the survey of the masiid in Sambhal...," the party added, asking the Supreme Court to immediately intervene.

PDP chief Mehbooba Mufti also cited the act.

"Thanks to a former Chief Justice of India a Pandora's box has been opened sparking a contentious debate about minority religious places. Despite a Supreme Court ruling that the status quo should be maintained as it existed in 1947, his judgement has paved the way for surveys of these sites potentially leading to increased tension between Hindus and Muslims," said PDP president Mehbooba Mufti.

The Supreme Court in August last year refused to stay Allahabad High Court order allowing an ASI survey at the Gyanvapi mosque complex, thereby opening the door to disputes such as the one in Sambhal and in Mathura. The bench comprising then CJI Chandrachud and Justices J B Pardiwala and Manoj Misra, however, asked the ASI to carry out the survey through "non-invasive methodology".

"Yet another shocker.. supposedly hidden somewhere in the Ajmer Dargah Sharif," added People's Conference president Sajad Gani Lone on the developments in Ajmer. "Worrisome. The latest claim: Shiv Temple at Aimer Dargah. Where are we taking this country? And why? For political dividends!" Rajya Sabha MP Kapil Sibal said in a post on X.

"These things are very painful. Some people have their cool after 2024 (Lok Sabha) election results as they didn't get the majority. These people want to target a particular community to please the majority," added Samajwadi Party MP Mohibbullah Nadvi.

Khwaja Moinuddin Chishti was a Sufi saint from Persia who made Ajmer his home. The shrine in his honour was built by Mughal emperor Humayun.

During his reign, Mughal ruler Akbar made a pilgrimage to Ajmer every year. He, as well as Shah Jahan, built mosques inside the shrine complex. (PTI)

Chief Minister Sukhvinder Singh Sukhu had maintained that the state government is contemplating to bring an ordinance for making provision in the Himachal Pradesh Ceiling on Land Holding Act, 1972 to transfer the land.

"Legal aspects would be considered to make provision in this regard and the matter would be discussed in the winter session of assembly and if any changes have to be made in the law that will also be done, "he had added.

(PTI) NEW DELHI, Nov 28: Rwanda extradited to India on Thursday a member of Pakistan-based terror group Lashkar-e-Taiba (LeT) facing an Interpol Red Notice in an operation coordinated by the NIA

and the CBI, officials said here. Salman Rehman Khan, an alleged member of the internationproscribed terrorist organisation, had assisted in providing arms, ammunition and explosives to further terrorist activities in Bengaluru, they said.

"The Global Operations Centre of the Central Bureau of Investigation (CBI) has closely coordinated with the NIA and Interpol National Central Bureau - Kigali for the return to India from Rwanda of Salman Rehman Khan, wanted by the NIA for terror-related offences," a CBI spokesperson said in a statement.

The National Investigation Agency (NIA) had lodged a case in 2023 related to criminal conspiracy to spread terror in Bengaluru, they said. An FIR was also registered at Hebbal Police Station, Bengaluru.

Khan, who was previously imprisoned in a POCSO case (2018-2022), had allegedly facilitated the collection and distribution of explosives for other terror accused after being radicalised and recruited during his incarceration by T Naseer, a life convict in a terror

case, according to the NIA probe. Naseer had allegedly orchestrated the radicalisation and subsequent criminal activities to further LeT operations in the country besides plotting his escape en route to the court from the prison, the

When the terror module was busted, Khan managed to give agencies a slip and escaped from the country, it said. NIA chargesheeted him in strin-

gent anti-terror law and Indian Penal Code and court declared him a fugitive," it said.

"The CBI on request of the NIA had got a Red Notice issued against the subject from Interpol on August 2, 2024. It was circulated to all law enforcement agencies globally for tracking of the wanted criminal,' the CBI statement said.

Based on the Red Notice, he was apprehended by authorities in Kigali, Rwanda. The information was passed on to the CBI which is the designated agency for coordination of Interpol affairs in India and the NIA. After legal proceedings, he was extradited to India. (PTI)

## Four Kerala doctors booked over birth of newborn with genetic disorders



ALAPPUZHA, (KERALA), Nov 28: Four doctors here have been booked for allegedly failing to detect genetic disorders in a newborn while it was in the mother's womb, the police said on Thursday.

The accused include two female doctors attached to the Kadappuram Government Women and Child Hospital in Alappuzha, along with two others from private diagnostic labs, according to the Alappuzha South po-

The police registered an FIR on Tuesday based on a complaint lodged by Anish and Surumi, a couple

from Alappuzha. The doctors were booked under different sections of the Bharatiya Nyaya Sanhita (BNS) that included endangering life or personal safety of others. Two of the scan centers were run by two doctors accused in

The couple alleged the doctors failed to detect or disclose the genetic abnormalities during prenatal scans, instead assuring them that the reports were nor-

The couple also claimed that they were shown the baby only four days after delivery, according to the

The FIR stated that Surumi, 35, was undergoing treatment for her third pregnancy at Kadappuram Women and Child Hospital The scans were performed on July 11, September

28, October 22, and November 1. On October 30, Surumi was admitted for delivery. However, she was referred to Government Medical College Hospital (MCH) in Vandanam, Alappuzha, citing the absence of fetal movement and heartbeat,

the FIR said. On November 8, the baby was delivered following surgery at MCH and was found to have severe internal and external deformities, the FIR stated.

Meanwhile, one of the accused doctors, responding to the allegations, said she had treated Surumi only during the initial months of her pregnancy. "I provided care for three months at the beginning

of her pregnancy. The reports shown to me indicated issues with the fetus's growth," she said. The doctors associated with the diagnostic labs, however, maintained that there were no errors in the scan reports. (PTI)

# 136 Vande Bharat train services operational across railways network: Govt

as 136 Vande Bharat train services were operational with enhanced safety features and modern passenger amenities as on November 21, the government has informed the Lok Sabha. In a written reply on Wednesday,

Railways Minister Ashwini Vaishnaw said these safety features and modern passenger amenities were automatic train protection system KAVACH, faster acceleration, fully-sealed gangway, automatic plug doors, better ride comfort, mini pantry with provision of hot case, bottle cooler, deep freezer and hot water boiler, among many

The minister was responding to questions raised by nine MPs from various political parties who wanted to know the rationale behind launching the Vande Bharat Express, their occupancy, amenities, passenger feedback and services in Maharashtra as well as on the New Delhi-Kathgodam route. Vaishnaw said, "Presently, 22



Vande Bharat services, on originating or terminating basis, are catering to the needs of stations located in the state of Maharashtra?

"...the Delhi-Kathgodam sector is served by three pairs of mail/express services, including the 12039/40 Kathgodam-New Delhi Shatabdi Express. Besides, introduction of new train services, in-

cluding Vande Bharat services and its variants, is an ongoing process on Indian Railways subject to traffic justification, operational feasibility, resource availability, etc," he

Vaishnaw said Vande Bharat services were being operated at the maximum permissible speed of section en route so as to ensure op-

timal utilisation of speed potential and there was no proposal to reduce the speed.

Responding to questions regarding occupancy, Vaishnaw said, "On Indian Railways, the demand pattern of reserved accommodation is not uniform throughout the year and it varies over lean and peak periods. Moreover, trains running on popular and convenient timings with lesser stoppage and running time are generally well patronised. During 2024-25 (up to October) the overall occupancy of Vande Bharat express trains is more than 100 per cent."

"On Indian Railways, statewise and trainwise average income generated is not maintained. Railway passengers share their feedback on the services offered by Railways through Rail Anubhav of the Rail-Madad portal. During the period from 03.07.2024 to 20.11.2024, a total of 51,346 feedback responses on Vande Bharat trains have been received through Rail Anubhay, the minister added. (PTI)

# Tough reality for fans when ticket prices go into lakhs, balanced approach needed: Hariharan

**NEW DELHI, Nov 28:** Renowned singer Hariharan says when tickets for music concerts sell for lakhs of rupees, it limits the options for the fans - a tough reality that needs to be addressed through a balanced approach by performers.

Talking to PTI ahead of his 50-year Legacy Concert on Saturday here at Major Dhyan Chand National Stadium, the "Roja" singer said expensive tickets "create a sense of exclusivity and grandeur" but they also raise questions about accessibility.

"When ticket prices go into lakhs, it inevitably limits who can attend, and that's a tough reality for fans who may deeply admire an artist but are priced out of the experience," Hariharan told PTI in an interview. The 69-year old said that the surge in musical concerts in India is a testament to the passion Indian audiences have for music, and to the artists - both domestic and international. In recent months, music concerts by British band Coldplay and Punjabi singer-actor Diljeet Dosanjh made headlines for their sold out shows and tickets that were sold for as much as ₹10 lakh through unofficial platforms.

Hariharan, who is celebrating 50 years in the music industry, suggested that a balanced approach was needed to manage this trend by organising both premium and affordable performances.

"There's room for premium, high-production concerts that offer a larger-than-life experience, but there should also be avenues for more affordable performances, so the magic of live music remains inclusive," he said. Just like streaming platforms and social media have made music accessible to all, he said, "perhaps it's time to bring that spirit into live performances too".

For his upcoming concert, the singer said that the "milestone concert is not just about me". "It's about the fans who've been with me through every song, every genre, and every chapter of my career," Hariharan said. (PTI)



LOS ANGELES, Nov 28: British star Barry Keoghan will be essaying the role of Ringo Starr in filmmaker Sam Mendes' upcoming film, the 'Beatles' drummer has confirmed. # I was not what a hero is supposed to be and people loved that: Amol Palekar

MUMBAI, Nov 28: Veteran actorfilmmaker Amol Palekar says he has always lived life on his own terms and that reflected in his choice of regular guy roles in Hindi cinema at a time when larger-than-life heroes were popular.

Palekar, who turned 80 this month, is looking back at his life and artistic pursuits in a new memoir, which is titled "Aiwaz" in Marathi and "Viewfinder" in English. Both the books are published by Westland — "Aiwaz" in partnership with Madhushree Publications.

The book is a deep dive into his life including his unlikely journey in cinema that saw him emerge as the star of the middle-of-the-road cinema of frequent collaborators Basu Chatterjee and Hrishikesh Mukherjee in hits such as "Rajnigandha", "Chhoti Si Baat", "Chitchor", "Gol Maal", "Naram Garam" and others in 70s and 80s. "I was not what a hero is supposed to be and what people loved was precisely that. They loved that I was not a Dharmendra, He-man, I was not the Angry Young Man (Amitabh Bachchan) or the ro-

mantic hero Rajesh Khanna. I was also not somebody who could dance beautifully like Jeetendra. I was none of them. And my being none of them was something which people liked," Palekar told PTI in an interview

"I could do it on my own terms is something which I don't know how it happened, but it happened. I am grateful to life for that," he added.

The actor said one of his dilemmas, which also comes through in his book, was how to run away from the image of the star.

"Because the moment you say a

"Because the moment you say a star, it comes with its baggage. I was a person who always wanted to try something new and different in which being a star is not allowed. It's a trap, in a way."

Asked if he was ever tempted to turn to commercial cinema, Palekar said he has never measured success by box office collection. "Today, getting into the ₹ 100 crore club is the minimum, and you talk only about going into ₹ 400 or ₹ 500 crore. Everything is being judged only by the commercial success. I've

always believed that whosoever has invested the money, if you have invested ₹ 5 rupees and if you make ₹ 15 out of that, you should be happy. "But the industry is not happy. Why only ₹ 15 why not ₹ 150 or ₹ 1500?" Palekar said he has always chosen

Palekar said he has always chosen the road less travelled whether taking a bank job to fund his creative side, choosing the fine arts stream instead of the more commercially viable applied arts at the JJ School of Arts or choosing theatre and then middle of the road movies.

"Something which will fetch money is applied arts but I didn't do that. That was a choice, a very conscious choice. I hadn't thought so much about it as I can do it today looking back but I certainly don't have any regrets about it.

"I worked out a very simple formula... I took up a job in a bank, which would help me not to worry about where the money would come from because I didn't want to have any compromise in my work... I thought this was the best way to do a 9 to 6 job, earn money and then evening onwards, it would be about my art. That's how I started my living. That was the starting point where I went on evolving."

The actor, who later turned director and made critically-acclaimed movies such as "Ankahee", "Thodasa Rumani Ho Jaye" and "Paheli", said he kept postponing the book for many years as he was busy with theatre and paintings but the break during Covid gave him the "time to introspect".

"And then I sat down and wrote it," he said, creditin wife Sandhya Gokhale, who has co-written many of his films, for helping him in the process. The English title of the book comes from a technology in films that's now extinct, he said.

"During our time, Viewfinder was an essential apparatus for a director to choose a frame, to choose what lens to use, what angle to use, he used to use the Viewfinder."

"So, that's what the Viewfinder is. It is from there. (In the book), I have chosen the frame, the angle and the look at my own life," he said.

Asked whether there were por-


tions that made him emotional or

were challenging to pen down, Palekar said he has written them "candidly" and, hopefully, "with dignity".

"I can honestly say that I have tried to look at my own failures. Mostly we don't like to look at our failures. We like to look at our successes. And the bigger the success, the more we like to talk about it. (In the book), I have talked about my failures, and when I talk about the failure, it is mainly about the creative process," he said.

They can scan the QR codes to watch films from his storied filmography without spending any extra money. "We are trying to reach out to as many people as possible. ## **MBAPPE NEEDS 'SUPPORT' REAL MADRID COACH ANCELOTTI SAYS AFTER 2-0 LOSS TO LIVERPOOL**

Kylian Mbappe hoped his move to Real Madrid would finally end his wait to win the Champions League.

That felt a long way off on Wednesday after a 2-0 defeat to Liverpool left the defending champion in danger of being eliminated from European club soccer's elite tournament at the first stage and in a fight just to make the playoffs for the next

If Madrid does make an early exit, Mbappe may look back on a miserable night at Anfield where he was humbled by a young defender and then missed a penalty that would have lev-

Madrid coach Carlo Ancelotti said afterward the star forward was going through a "difficult moment" just months after he joined the record 15-time European champion.

"We've got to give him our support and love and he will soon be fine," Ancelotti said as he faced multiple questions from Spanish reporters about Mbappe's form. "It could be lack of confidence maybe. Sometimes when moments in the game and things are not working out, the idea is to keep things simple. Don't complicate things.

"He's going through that moment now. You get through them. Don't blame him for missing a penalty. People miss penalties. We can't put too much grief on him for that."

World Cup winner Mbappe looked a shadow of himself against a Liverpool team that leads the way in the Premier League and the Champions League this season.

He was brought crashing down by a crunching tackle from 21-year-old right back Conor Bradley when threatening to burst through on goal in the first half — sparking a huge cheer from the home crowd.

And it got worse for Mbappe in the second half when he had the chance to make it 1-1 from the penalty spot after Alexis Mac lead. But with Caoimhin Kelle-back-up goalkeeper. ropean champion Liverpool the

"I don't really like just adding him to the squad unless he's going to play, drop the 12th man." Marsh had pulled up sore after bowling the most overs he has in a Test match in three years during the Perth Test.

As a result, Australia had to rely on spin and medium-pace from Marnus Labuschagne, along with five overs of off-spin from Travis Head during their 295-run humbling in the series opener.

SYDNEY, Nov 28: Former arm pacer like Marsh, is expected to come into the equation if the Western Australian can't bowl the overs required of him.

NEW DELHI, Nov 28: Olympic bronze medal-winning forward Abhishek took up hockey as an escape route from studies, and he has never regretted the decision as the sport has given him recognition, stardom and all that he aspired to be in life. Though Abhishek managed to complete his graduation through correspondence, he always knew that sports would give him a purpose. "I started hockey when I was 11 or 12 years old. There was no other option in Sonipat at that time. A friend used to travel a lot every month to play hockey," Abhishek, who was a vital part of India's Paris Olympics bronze medal-winning campaign told PTI in an interview.

"I never had the patience to sit and study and when I saw my friend hardly attending classes because of his hockey engagements,

I thought I too could do the same

if I started playing the sport." The 25-year-old, who was also a member of the Hangzhou Asian Games gold-winning side, is a big fan of Portuguese football great Cristiano Ronaldo and his work ethic. "I am a big fan of Ronaldo. His off-field routine, his discipline, food habits... I watch his videos and try to inculcate them (habits) in my routine.'

## Liverpool shine in Champions League, dumping Real Madrid down the table

LIVERPOOL, Nov 28: Liverpool is 100% on top of the Champions League after dumping title holder Real Madrid into an almost unbelievable 24th place in the 36team standings.

No one felt the embarrassment of Madrid's 2-0 loss at Anfield more than Kylian Mbappé, the superstar added in the offseason by the storied club that also was European champion against Liverpool in the finals of 2022 and 2018. Mbappé had a penalty saved in the second half and was earlier dumped on his behind by Conor Bradley's superb tackle in an instant viral moment.

Only Liverpool has started the new Champions League format with five wins and first-year coach Arne Slot's team is two points clear of Inter Milan. Barcelona is third, trailing Liver-

pool by three points.

Madrid is, remarkably, with three rounds left just one place above being eliminated. The top eight teams at the end of January go direct to the round of 16 in March, and teams placed from ninth to 24th enter a round of twoleg playoffs in February.

'(This) doesn't change much, because even with a win it was going to be tough to secure a topeight finish," Madrid coach Carlo Ancelotti said. "It was a fair result." Monaco missed a chance to go second in the table, giving up a lead playing with 10 men from the 58th minute in a 3-2 loss at home to Benfica. Swiss forward Zeki Amdouni scored the winning goal in the 88th.

Borussia Dortmund, the beaten finalist against Madrid in May, is up to fourth place after beating Di-

namo Zagreb 3-0. Champions League standout Jamie Gittens now has four goals in five games, curling a rising shot in the 41st to open the scoring in Croatia.

The best comeback was at PSV Eindhoven, where the home team trailed Shakhtar Donetsk by two goals in the 87th minute before a 3-2 win was sealed by United States forward Ricardo Pepi's goal deep in stoppage time. US defender Cameron Carter-

Vickers scored an embarrassing own goal for Celtic — playing a no-look pass far beyond goalkeeper Kasper Schmeichel — in a 1-1 draw with Club Brugge.

"One of those things," Schmeichel said. "Cam gets pressed and he hasn't heard me shout that I'm not in (goal)." Congo teammates Ngal'Avel Mukau and Silas impressed in wins for Lille and Red Star Belgrade. Mukau scored twice in 12th-place Lille's 2-1 win at Bologna and Silas leveled for Red Star in a 5-1 rout of Stuttgart, though he barely celebrated his goal. Silas is on loan with the Serbian champion from Stuttgart.

Aston Villa's 0-0 draw with Juventus was preserved by an excellent save by Emiliano Martinez, the World Cup-winning Argentina goalkeeper, diving low to push away a header from Francisco Conceição. Liverpool's stand-in right back Bradley was a standout Wednesday, denying Mbappé at high speed in a signature defensive play in the 32nd.

The 21-year-old Northern Ireland defender, deputizing for fitagain Trent Alexander-Arnold, joined the attack in the 52nd to play a key pass returning the ball to Alexis Mac Allister who scored

After Mbappé's penalty was pushed away by goalkeeper Caoimhín Kelleher in the 61st, Liverpool star Mo Salah missed with his spot-kick in the 70th, before substitute Cody Gakpo sealed

the win with a header in the 77th. Madrid now has lost three of five games after defeats at Lille and at home to AC Milan. The record 15-time European champion has another tough trip next, at fifth-place Atalanta on Dec. 10. On the same date, Liverpool is at 30th-place Girona and looks to be

cruising into the round of 16. "You know how special it is to play against a team that has won the Champions League so many times," Liverpool coach Slot said of Madrid. "They were a pain for Liverpool for many years too. (AP)

# Discussion on 'Hybrid' model for hosting Champions Trophy set to dominate ICC meeting

tional Cricket Council finds itself in a spot of bother as its all-powerful board meets on Friday to thrash out the long-awaited schedule of next year's Champions Trophy with an unyielding Pakistan refusing to consider the 'Hybrid' model of hosting the event despite India's refusal to play there.


The meeting will be held virtually. India's decision not to send the team to Pakistan and the PCB's defiant stand in not acceding to the hybrid system have placed the future of the marquee event in balance.

"At this point, the hybrid format is the best option. We hope that all the parties involved will take a wise call for the sake of the tournament. It's not good for the tournament to have it without India and Pakistan," a source close to the development told PTI.

The ICC members are trying to sell the point to the PCB that without the blue riband India vs Pakistan fixture, the Champions Trophy will lose all its sheen and, more importantly, there will be massive financial implications.

The host broadcaster — Jio Star — has already contacted the ICC top brass to convey its dismay at the delay in arriving at a final decision regarding the schedule.

As per the contract between the ICC and the broadcaster, the governing body was expected to give it the schedule of the tournament at least 90 days in advance and



breached.

So, will the members discuss the possibility of placing India and Pakistan in different groups in the league stage of the tournament to avoid Men in Blue's travel to the neighbouring country?

"I don't think the television rights holders will agree to that. They will demand an India vs Pakistan match in the group stage itself as an assured way to raise the profile and monetary income. and it will be a bonus if the teams then meet in the knockouts," the



"Even otherwise, if India enters the knockout stage, it will have to be taken out of Pakistan as BCCI has already made its stand clear. So, the discussion will be around the hybrid model.'

India have not toured Pakistan since the 2008 Mumbai terror attacks, which killed more than 150 people. The latest refusal to travel has been blamed on security concerns and the ICC has stated more than once that it does not expect any member board to go against government advice.

The Sri Lanka A team's tour to Pakistan had to be cut short a cou-

ple of days ago due to intense political protests in Islamabad.

The turmoil is because of a protest by Pakistan Tehreek-e-Insaaf party, which belongs to former captain and prime minister Imran Khan. There were incidents of clashes and violence reported between protestors and forces of law enforcement and security.

PCB chief Mohsin Naqvi, also the federal interior minister, had announced that the army was called in to quell the unrest.

But when it comes to the Champions Trophy, the PCB has remained firm on having the

"All I can assure is whatever happens in the meeting we will come out with good news and decisions which will be accepted by our people," Naqvi told reporters at Karachi on Wednesday night.

So, the primary target of the ICC members will be to make PCB embrace the 'Hybrid' model, at least for the league stage, in all likelihood, in the UAE and the knockouts in Pakistan.

But if India advance further in the event, then the knockouts, the matches in which India feature, too might have to be shifted back to the venue of the league matches.

However, what if the PCB remains rigid and decides to pull out of the Champions Trophy in the event of ICC deciding to take it to a neutral venue?

"It's a very unlikely scenario. It can have very far reaching consequences for Pakistan cricket, which is not at its best in terms of financial health. India is set to host a few tournaments in the next couple of years.

"If Pakistan decides to boycott the Champions Trophy, then they will also have to boycott tournaments to be held in India, which in turn, can bring a lot of financial liabilities to PCB," he added.

India are set to play host to the Asia Cup (2025), the women's World Cup (2025) and the men's T20 World Cup (2026), this event

# Hybrid model for Champions Trophy not acceptable: PCB tells ICC

KARACHI, Nov 28: The Pakistan Cricket Board informed the International Cricket Council on Thursday that it will not accept the Hybrid model for the Champions Trophy, and asked the global governing body not to discuss the option in Friday's board meeting.

The ICC has convened a meeting of the executive members virtually to resolve the scheduling imbroglio surrounding the marquee event after India's refusal to send the team across the border.

"I can confirm that PCB has a few hours back told the ICC that a Hy-

brid Model is not acceptable to them," a source told PTI. The PCB has been rigid in its opposition to the hybrid model and had

advised the ICC to look at other options to stage the Champions Trophy. The Pakistan board maintained that having a Hybrid model would mean giving preferential treatment to India.

"I can confirm initially the PCB had looked at the possibility of a Hybrid model on the condition that if India can't play in Pakistan, then in future there would be Hybrid models in all ICC events in India right until 2031 (ODI World Cup in India and Bangladesh) as Pakistan would not go and play in India," the source said.

Another source confirmed that PCB has also reminded the ICC to inform whether the BCCI had submitted a letter in writing from their government

stating that clearance was not given to the Indian team to play in Pak-

"Under ICC regulations if any team says its government is not allowing it to play in another nation on whatever grounds that board has to submit their government's directives in writing which we have not seen so far,"

He said the PCB had acknowledged the contribution of the BCCI and Indian market in ICC's income generation but reminded the ICC that as per numbers from the last few global events Pakistan also played a major part in ensuring the revenues through their matches against India. He said the ICC has yet to confirm the timing of the virtual meeting. (PTI)

#### India to send 68-member team for Asia-Pacific **Deaf Games**

NEW DELHI, Nov 28: A 68-member Indian team will take part in the Asia-Pacific Deaf Games to be held in Kuala Lumpur from December 1 to

The tournament is at par with the Asian Games for individuals with speech and hearing impairment and also serves as a precursor to the Deaflympics, which will be held in Japan next year.

The India will have representation in seven disciplines including athletics, badminton, chess, judo, table tennis, taekwondo and wrestling. 
But he was unimpeded by his recent lack of activity, coming century before falling midway through a final session in which New Zealand lost five wickets and some of the advantage it held earlier in the day.

Ollie Pope, behind the stumps, completed the catch. Pope inherited the job of keeping wicket when Jordan Cox, who was expected to make his test debut in Christchurch, suffered a broken thumb in a training accident. ## It's not possible for Pakistan to play in India, as they're not sending team here: Naqvi

LAHORE, Nov 28: The PCB chairman Mohsin Naqvi has made it clear that it is not possible for Pakistan to travel to India for tournaments in future while India continue to refuse to send the team to the neighbouring nation, a situation he termed "unequal."

The fate of the Champions Trophy hangs in balance after BCCI conveyed to ICC its inability to send the team to Pakistan, and the global body has convened a virtual meeting of its executive board members on Friday to take a final decision.

"It is just not possible that while Pakistan keeps on going and playing in India all events the Indian authorities are not willing to send their team to play in Pakistan. We can't have such an unequal situation," Naqvi told reporters last night at the Gaddafi stadium during a visit to inspect the construc-

Naqvi, however, played it safe regarding the 'Hybrid' model for the Champions Trophy, as earlier he had asserted that PCB would not accept the proposed format.

"All I can assure is whatever

come out with good news and decisions which will be accepted by our people," he said. Naqvi hoped that Jay Shah, who will take over as the ICC Chairman December 5, would take decisions

The Capitals did not retain Pant and the left-hander was sold to Lucknow Super Giants in the recent mega auction for ₹ 27 crore, becoming the most expensive player in the history of the IPL. "It was just a different philosophy of how he wanted the franchise to

operate and how us - the owners - wanted the franchise to operate. That's what caused it (Pant's departure). There's nothing to do with money," Jindal told 'ESPNCricinfo'. "Money's never been an issue for Rishabh. And money's never been

an issue for us. I guess the three of us (Kiran Grandhi, Jindal and Pant) were on different wavelengths. "He took a call at the end of it. We tried everything, but he decided eventually that it was time to move on," added Jindal.
