'Unnecessary controversy over cutting trees for flyover'

Sahityarathi statue issue: Himanta targets Hiren Gohain

GUWAHATI, Nov 6: Amidst the ongoing row over cutting centuryold trees to give way for a flyover, Chief Minister Himanta Biswa Sarma has claimed that a section of people have created "unnecessary controversy" to target the developmental works of the government.

The Gauhati High Court on Tuesday slapped notices on the Assam government over its plans to cut around 25 century-old trees for construction of a four-lane 5.05 km long flyover, the longest in the city, from Dighalipukhuri tank to Noonmati at a cost of ₹852.68 crore.

"For the last six months, I have been noticing that one particular circle is trying to create an unnecessary controversy regarding the and trees Dighalipukhuri," Sarma told reporters after visiting the construction site near the pond around midnight on Tuesday.

He said the second controversy was shifting the statue of the doyen of Assam literature Sahityarathi Lakshminath Bezbaroa and claimed that the flyover would pass above



GUWAHATI, Nov 6: Five Assam Civil Services (ACS) officers have been suspended for refusing to join their new places of posting in the Election Department, according to official orders

Personnel department commissioner and secretary M S Manivannan issued five individual orders, suspending Saroj Kumar Deka, Kabyashree Dihingia, Kongkan Jvoti Saikia, Parishmita Dehingia,

and Jintu Sarma. The orders stated that they were transferred to new places under the Election Department, but all of them refused to join the new postings. Manivannan said all of them disobeyed the order of the authority, destroyed office decorum and failed to act in the public interest.

NALBARI, Nov 6: A court in Assam's Nalbari district has ordered registration of an FIR against an IAS officer, who is a District Commissioner, for harassing a subordinate officer.

Nalbari district's Additional Chief Judicial Magistrate P Goswami noted in her judgement (Case No: CR/231/2024) on Monday that "some incidents" took place during Lok Sabha elections and hence ordered to register the then Paschim Nalbari Circle Officer (CO) Arpana Sarmah's FIR against her superior and District Commissioner (DC) Varnali Deka. "Considering the facts of the case and consid-

ering the entire discussion, I am of the considered



opinion that police have failed in their duty cast upon them by law. An FIR needs to be registered for the allegations filed by the complainant and

proper investigation of this case needs to be carried out as per law," Goswami said in her order. She directed the officer-in-charge of Nalbari police station to register a case, conduct an investigation and submit the final report expeditiously related to Sarmah's complaint against Deka.

Sarmah on May 8, a day after voting for Lok Sabha polls took place in Nalbari, filed a police complaint against Deka, alleging "mental harassment, public humiliation and threatening" while discharging her election duty.

SRINAGAR, Nov 6: The Jammu and Kashmir Assembly on Wednesday passed a resolution asking the Centre to hold dialogue with elected representatives for the restoration of the special status of the erstwhile state, prompting protests by BJP members who tore copies of the document and raised slogans against the speaker.

The unruly scenes in the House and vociferous protests by BJP members led to frequent disruptions of the proceedings and eventually the speaker adjourned the House for the day. The resolution, which also expressed "concern" over the "unilateral removal" of the special status, was passed without any debate as the Speaker put it to voice vote amidst noisy scenes.

With the passage of the resolution, the ruling NC said it has fulfilled one of its manifesto promises while chief minister Omar Abdullah said the "Assembly has done its job". The members of the PDP, Peoples' Conference, and CPI(M) supported the resolution during the

India-US relations will be on a very firm footing with Trump's victory: Scindia

NEW DELHI, Nov 6: India and US relationship will be on "a very firm footing" with Donald Trump returning to the White House, as the cooperation between the two nations extends from environment to technology, space and defence, Union Minister Jyotiraditya Scindia said Wednesday.

As a candidate, Trump had spoken of revamping US foreign policy, focusing on 'America First' principles, and has also talked about imposing tariffs on foreign goods, raising concerns in New Delhi

Scindia's comments, the first by a senior Indian government functionary after Prime Minister Narendra Modi congratulated Trump on his victory, indicate that India remains optimistic that it will continue to have unhindered trade and economic ties with the world's largest economy and strongest military power. The United States is also India's largest trading partner with the total annual trade crossing USD 190 billion.

"I think that the US-India relationship under the stewardship of both Prime Minister Modi and President-Elect Donald Trump will be on a very, very firm footing forward," Scindia said in a video and text interview with PTI.

Rupee falls 21 paise to all-time low of 84.30 against US dollar

MUMBAI, Nov 6: The rupee depreciated 21 paise to an all-time low of 84.30 (provisional) against the US dollar on Wednesday, as the US Dollar index rallied with Donald Trump set to win the US Presidential elections.

A strong greenback against major rivals overseas and unabated foreign fund outflows dented market sentiment, forex traders said.

Market participants also expect the US Fed to announce a rate cut in a meeting scheduled later this week, with further easing by up to 100

basis points projected for 2025.

At the interbank foreign exchange, the rupee opened at 84.23 against the US dollar. During the session, the local currency oscillated between a high of 84.15 and a low of 84.31. It finally settled at 84.30 (provisional), a loss of 21 paise against its previous close.

On Tuesday, the rupee settled 2 paise higher at 84.09 against the US dollar. "We expect the rupee to trade with a negative bias on strength in the US Dollar and FII outflows. However, a rise in risk appetite in global markets and a decline in commodity prices may support the

rupee at lower levels.

"Any intervention by the RBI may also support the rupee at lower levels. Investors may remain cautious ahead of the FOMC meeting outcome later this week. USD/INR spot price is expected to trade in a range of 84.10 to 84.40," said Anuj Choudhary – Research Analyst at Sharekhan by BNP Paribas.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 1.34 per cent higher at 104.80. The index rose after Trump was poised to become the next US President.

Brent crude, the global oil benchmark, fell 1.43 per cent to USD 74.45 per barrel in futures trade.

In the domestic equity market, the 30-share BSE Sensex surged 901.50 points, or 1.13 per cent, to close at 80,378.13, while Nifty advanced 270.75 points, or 1.12 per cent, to settle at 24,484.05 points.

Foreign institutional investors (FIIs) were net sellers in the capital markets on Tuesday, as they offloaded shares worth ₹ 2,569.41 crore, according to exchange data. (PTI)



Scindia said that the India-US relationship in the last decade under Modi has led to huge amounts of trade, economic thrust as well as strategic relationship between the two countries on many global issues.

The election result makes Trump the only US president after Grover Cleveland to serve nonconsecutive terms in more than 130 years. Cleveland was both the 22nd and 24th president, serving from 1885 to 1889 and then again from 1893 to 1897.

Noting that India is the world's largest democracy and the US is the world's oldest democracy, Scindia said, "There have been huge parts of intersection between

Indo-US relations".

"Those relationships have taken a much more concrete form in the last decade since Prime Minister Modi has forged an independent relationship with the US. It has resulted in not only a huge amount of trade and economic thrust coming to the fore but also led to a strategic relationship on many global issues," he noted.

Trump has during electioneering alleged that India imposes the highest tariffs on foreign products and vowed to introduce a reciprocal tax if elected to power. This, it was construed, may disrupt the ties between the two nations.

Scindia said that besides cooperation in the field of environment,

technology, and space to defence, India and the US have signed an agreement to set up a semiconductor manufacturing unit that will supply chips to US defence companies

panies.

"We are going to be setting up a fab in India to even supply chips to US defence manufacturing companies. That's the first," he

The US State Department has entered into a partnership with India to diversify the global semiconductor ecosystem under the International Technology Security and Innovation (ITSI) fund.

The initial phase of the partnership includes a comprehensive assessment of India's existing semiconductor ecosystem and regulatory framework, as well as workforce and infrastructure needs.

Analysts say that Trump, who had blocked the dispute resolution process of the World Trade Organisation and removed duty-free access under the decade-old Generalised System of Preferences (GSP) programme in his second term could move more towards protectionism.

He has also threatened not to do business with those who are moving away from the US dollar. (*PTI*)

Sensex rallies 901 pts, Nifty settles near 24,500 as Trump win stokes up IT, pharma shares

MUMBAI, Nov 6: Stock markets rallied more than 1 per cent on Wednesday with benchmark Sensex soaring 901 points on heavy buying in IT and pharma shares amid Donald Trump's victory in the US presidential polls.

Extending its gains to the second day, the BSE Sensex jumped 901.50 points or 1.13 per cent to settle at 80,378.13. During the day, it soared 1,093.1 points or 1.37 per cent to 80,569.73.

The NSE Nifty soared 270.75 points or 1.12 per cent to close at 24,484.05.

From the 30-share Sensex pack, Tata Consultancy Services and Infosys jumped over 4 per cent each. HCL Technologies, Tech Mahindra, Adani Ports, Larsen & Toubro, Maruti and Reliance Industries were also among big gainers.

Titan, IndusInd Bank, Hindustan Unilever, Axis Bank and HDFC Bank were the laggards.

"Global markets experienced a relief rally following the US election results, reducing political uncertainty with Trump securing a strong mandate. This has led to strong risk-on sentiments, driven by expectations of tax cuts and increased government spending,"

CCEA approves infusion of ₹ 10,700 cr equity in state-owned FCI for working capital



NEW DELHI, Nov 6: The government on Wednesday approved infusion of ₹ 10,700 crore as equity in state-owned FCI for working capital requirement this fiscal.

requirement this fiscal.

The Food Corporation of India (FCI) is the government's nodal agency for procurement and distribution of foodgrains.

"The Cabinet Committee on Economic Affairs (CCEA), chaired by Prime Minister Narendra Modi, has approved infusion of equity of ₹ 10,700 crore for working capital in financial year 2024-25 in Food Corporation of India (FCI)," an official statement said.

The decision is aimed at bolstering the agricultural sector and en-

suring the welfare of farmers na-

tionwide.

"This strategic move shows the government's steadfast commitment to supporting farmers and fortifying India's agrarian economy," it added

The FCI started its journey in 1964 with authorised capital of Rs 100 crore and equity of ₹ 4 crore.

The operations of FCI increased

manifolds resulting in increased authorised capital from ₹ 11,000 crore to ₹ 21,000 crore in February 2023.

The equity of FCI was ₹ 4,496

crore in 2019-20 fiscal, which was increased to ₹ 10,157 crore in 2023-24. "Now, the Government of India has approved a significant amount of equity of ₹ 10,700 crore for FCI which will strengthen it financially and will give a big boost to the initiatives taken for its transformation," the statement said.

FCI plays a pivotal role in ensuring food security by procurement of foodgrains at Minimum Support Price (MSP), maintenance of strategic foodgrain stocks, distribution of foodgrains for welfare measures and stabilisation of foodgrain prices in the market.

"The infusion of Equity is a significant step towards enhancing the operational capabilities of FCI in fulfilling its mandate effectively. FCI resorts to short-term borrowings to match the gap of fund requirement. This infusion will help to lower the interest burden and will ultimately reduce the subsidy of the Government of India," the statement said.

The government's dual commitment to MSP-based procurement and investment in FCI's operational capabilities signifies a collaborative effort towards empowering farmers, fortifying the agricultural sector, and ensuring food security for the nation, it added. (*PTI*)

"We have to cut some trees while carrying out developmental works. If we don't want that, then we have to issue strict orders that no trees will be allowed to cut. Then people will not be able to construct their houses also. Every house in Guwahati has been built by cutting trees. You (media) cannot run after each and every tree," he added. The CM said that in entire India, big highway projects are being implemented and if one tree is cut, 10 are planted, and that is the norm everywhere.

"One section of people will move everywhere to find out where trees have been cut. They don't want developmental works to take place," he claimed.

As per popular legend, the Dighalipukhuri was constructed by King Bhagadatta, who led the Kauravas in the Battle of Kurukshetra in the Mahabharata, during the 'swayamvar' of his daughter Bhanumati.

Historically, the pond was used by the Ahoms as a naval dockyard, especially during the 1671 'Battle of Saraighat' on Brahmaputra.

Its access to Brahmaputra was eventually closed during colonial times. The connecting portion was further filled, on which the Circuit House was built and later the Gauhati High Court came up.

Besides, several other landmark structures like the state museum, district library, Rabindra Bhawan, Reserve Bank of India, a part of Cotton University (first college of Northeast), Handique Girls' College (first women's college of NE), Nabin Chandra Bordoloi Hall and district courts. (*PTI*)

Cyrus trying to break Tata Grp? Tata's no comments more thunderous than statement: Biography Author

NEW DELHI, Nov 6: Ratan Tata's 'no comments' was more 'thunderous' than any statement when asked if he shared the apprehensions of some Tata group veterans who felt that Cyrus Mistry was trying to break up the conglomerate, according to the author of biography of the late industrialist, Thomas Mathew.

Tata had fully supported late Mistry as his successor in 2012, despite having second thoughts over the suitability of the latter at the end of the first year of 'parallel running' as Chairman designate and his replacement as Chairman of Tata Sons in 2016 was due to "an ethical and a moral issue", coupled with performance issue, Mathew told PTI Video in an interview.

In the biography 'Ratan Tata A Life', some Tata group veterans have been quoted airing their apprehensions about Mistry trying to break up the salt-to-software conglomerate based on his style of functioning as the Chairman and the

past record of the Shaprooji Pallonji (SP) Group's acquisition of shares in Tata Sons. "There are two schools of thought. Some Tata veterans say the way SP Group accumulated the shares of Tata Sons did not forebode well," the former bureaucrat said when asked about the issue.

According to the Tata veterans, Mathew said, "The way they (SP Group) went about accumulating the shares was frowned upon by JRD, that is to put it mildly and he was very, very uncomfortable... (in a) clandestine manner, so to speak, SP Group acquired the shares exploiting, they say, the weak moments of the weak family members. It's not mine. This is all Tata veterans say."

As per the book, the SP Group had increased its stake in Tata Sons gradually to around 18 per cent acquiring shares of the company that JRD had given to his siblings.

Mathew, whose long association with Tata began in 1995, when he

was secretary to the then Industry Minister, said, "Now the other supporting narrative is that when Mr Tata was the chairman of Tata Sons, the directors in Tata Sons were also directors in the large companies of the Tatas. There were about 15-20 directorships in which these people were the link between the Tata Trusts, Tata sons and the Tata companies."

He further said, "That (practice of having Tata Sons directors as board members in other Tata companies) was largely absent during the time of Cyrus Mistry. In fact, he was almost exclusively, except for two people, in (the boards of) the largest (Tata) companies. So they said excluding the Tata veterans from the major companies (boards) also did not forebode well."

Attributing to the Tata veterans, Mathew said, "They say it (breaking up the Tata group) was not put to test but it could have been the motive." When asked if Tata shared the

same apprehensions of the Tata veterans, he said, "Mr Tata was a very reticent man, he was a very kind man. He would not comment on it. But to me, his absence of a comment is more thunderous than a comment... I said, 'Sir, do you think that is true? No comments (Tata responded)'. I think that's more thunderous than him making any statement."

Mathew, however, asserted that

the 'replacement' of Mistry as Chairman of Tata Sons in 2016 was due to "an ethical and a moral issue, and second is a performance issue". Late Mistry was chosen in 2011 after a global search by a selection

after a global search by a selection committee to succeed Tata -- who retired as Chairman of Tata Sons in December 2012 -- with his full endorsement, despite apprehensions and reservations expressed by group veterans. For a year Mistry was the 'Chairman designate' before he took over as Chairman of Tata Sons after Tata's retirement. (PTI)

Triumphant Trump

inally, the U.S. election results are out. The Republican candidate Donald Trump has swept the polls by winning convincingly in the presidential contest as also leading the Republican Party to majority in both the Senate and the House of Representatives. There is no grey area. It is apparent that the majority of the American voters have shown confidence in this political maverick who has promised to 'Make America Great Again'. For the Democratic Party, the 2024 elections results have brought some uneasy questions to the fore. The party leadership has to go into it after full results come out. Now what is going to be the global impact of the second presidency of Donald Trump? To start with, it has to be mentioned that Donald Trump will take over officially the president's position on January 20, 2025 and so there are 75 days left between now and January 20 next year. During this intervening period, the Biden government will be having a lame duck character, the president will not be able to take any major decision.

In a normal circumstance, there is no problem in such transition. But right now, two major wars are going on in West Asia and Ukraine. The USA is very much involved with both. Its decisions matter. Trump said in his election speech that, if elected, he would stop Ukraine war in 24 hours by talking to Russian President Vladimir Putin and Ukrainian President Volodomyr Zelensky. This was a rhetoric in an election campaign speech but it will not be surprising if Trump makes some major move on both Israel-Hamas war as also in Ukraine. Even before his takeover officially as the President on January 20, he can informally convey his views to the secretary of state and ask him to proceed accordingly. Good or bad, some change will take place on the two war fronts, possibly even before January 20, 2025. It is apparent that the allies of USA, especially NATO and European Union are panicky.

What about India? To start with, Prime Minister Narendra Modi has reasons to be pleased for political reasons but the impact on the Indian economy will be adverse. Modi has some commonality with Trump. They both share same streak of authoritarianism and Islamophobia. But Narendra Modi is a cool person and not a maverick like Trump. India will get some relief in the latest diplomatic tangle with Canada and US agencies. Trump's personal help to Narendra Modi will be of big value at this moment. Then there is the issue of Bangladesh, The head of interim government of Bangladesh Dr. Muhammad Yunus was desperate to meet the Indian PM at UN assembly session in New York in September this year, but Modi avoided. Modi also was waiting for the US elections. The US is India's largest export destination, and received 18 per cent of Indian exports in 2023-24, up from 12 per cent a decade ago. For India maintaining the export growth to USA and even increasing the level are of crucial importance for the domestic industry.

Midday meals and school attendance in Assam

one of India's most prominent social initiatives, was introduced with the goal of improving the nutritional standards of school children and increasing school enrollment and attendance. In Assam, as in many other states, the program plays a crucial role in addressing two major concerns: child malnutrition and low school attendance. Assam, with its predominantly rural population and socio-economic challenges, benefits greatly from such schemes, but the execution of the program is not without its problems. Understanding the link between midday meals and school attendance in Assam requires an exploration of the program's origins, its impact on children and families, and the various obstacles that still hinder its success.

Assam, like much of India, faces high levels of malnutrition among children, particularly in rural areas. Many families live below the poverty line, making it difficult for them to provide sufficient food for their children. For these families, the Midday Meal Scheme serves a dual purpose: it not only provides much-needed nutrition but also reduces the financial burden of feeding their children. In theory, the prospect of receiving a free, nutritious meal should serve as a significant incentive for parents to send their children to school regularly.

For many families, particularly those from economically disadvantaged backgrounds, the midday meal is often the only substantial meal their children receive throughout the day. The nutritional benefits of the scheme are essential for children's physical and cognitive development, directly influencing their ability to learn and perform in school. Improved nutrition leads to better concentration, higher energy levels, and fewer absences due to illness, which theoretically should contribute to better educational

The connection between food and education is well documented, and the Midday Meal Scheme in Assam has had a no-

The Midday Meal Scheme, ticeable impact on school attendance, particularly in rural and impoverished communities. In areas where families struggle to meet basic needs, the promise of a free meal can be a powerful motivator for parents to send their children to school.

Studies and reports suggest that the introduction of the scheme has led to an increase in school enrollment and attendance, especially among younger children and girls, who are traditionally more likely to be kept at home for domestic work or to care for siblings. The midday meal offers a tangible benefit to parents, making it easier for them to justify the shortterm economic loss of sending their children to school rather than keeping them at home for work.

However, while the program has undeniably contributed to improving attendance, it faces significant challenges that impact its overall effectiveness. One of the key issues is the inconsistent quality and delivery of meals. In many schools across Assam, especially in remote or rural areas, the food provided under the scheme is often of poor quality.

Reports of substandard meals, improper hygiene, and insufficient quantities are not uncom-This undermines the mon. credibility of the program and may even discourage parents from sending their children to school. When parents perceive that the meals are inadequate or unsafe, they are less likely to see the value in the scheme, and the potential gains in attendance are lost. There have been instances where food poisoning and related health issues have been reported, creating mistrust among families and communities.

Infrastructure also plays a significant role in the success of the midday meal program. Many schools in Assam lack proper kitchens, clean cooking areas, and access to safe drinking water, which further complicates the provision of quality meals. Inadequate storage facilities mean that food often spoils before it can be used, and in some cases, schools are forced to rely on local suppli-

ers who may not adhere to proper hygiene and safety standards. These infrastructural deficiencies have a direct impact on both the quality of the food provided and the consistency with which meals are served. In areas where these issues are particularly pronounced, the midday meal program may be sporadic, with meals not being provided every day, further reducing its appeal as an incentive for regular school attendance.

The administrative challenges in the implementation of the scheme also pose significant barriers to its success. Corruption, mismanagement, and delays in the disbursement of funds are recurring problems. There are frequent reports of funds being siphoned off or not reaching the schools on time, which leads to delays or cancellations of the meals.

Teachers and school administrators, already

often tasked with managing the midday meal program, which can lead to inefficiencies and mismanagement. In some schools, teachers are forced to supervise meal preparation and distribution, diverting their attention from teaching. This added responsibility can negatively impact the quality of education, as teach-

ers struggle to balance their dual

sponsibilities, are

roles. In some cases, caste-based discrimination has also been reported in the implementation of the midday meal scheme in Assam. In certain schools, children from lower-caste or tribal communities are reportedly served meals separately or given poorer quality food compared to their upper-caste counterparts. Such practices not only defeat the purpose of the program but also perpetuate social divisions, discouraging some families from sending their chil-

While these instances may not be widespread, they represent a significant challenge in ensuring the equitable distribution of re-

dren to school.

The geography and climate of Assam also present unique challenges to the success of the Midday Meal Scheme. Assam is prone to frequent flooding, particularly in the Brahmaputra Valley, which disrupts school attendance for large parts of the year. During flood seasons, many schools are closed or converted into relief camps, making it impossible for the midday meal program to function effectively.

The infrastructure that supports the program, such as roads for transporting food supplies, is often damaged by floods, leading to delays and interruptions in meal distribution. For families affected by these disasters, sending children to school becomes less of a priority as they focus on rebuilding their homes and livelihoods. further contributing to irregular attendance

This could involve setting up alternative distribution centers or providing food packets to affected families. Moreover, improving the overall resilience of the region's infrastructure, such as building flood-resistant schools and roads. could help mitigate the impact of natural disasters on the education system and the midday meal pro-

In conclusion, the Midday Meal Scheme in Assam has made significant strides in improving school attendance and addressing child malnutrition, particularly in rural and economically disadvantaged communities. However, its success is hampered by a range of challenges, including poor infrastructure, administrative inefficiencies, and socio-cultural barriers. To fully realize the potential of the program, these issues must be addressed through better planning, oversight, and community engagement. Only then can the scheme truly fulfill its mission of providing both nourishment and education to Assam's children, helping to break the cycle of poverty and educational deprivation in the state. Trump in his message has raised two key crucial issues: the persecution of the Hindus in Bangladesh and an all-out praise of his "good friend Prime Minister Modi".

Until then, the impatient Awami League's leaders and cheerleaders will have to hold their breath to return to power through a third-party intervention.

There is no possibility of Awami League launching a nationwide antigovernment movement. The leaders and their sycophants are busy protecting their looted stash of cash, said political historian and writer Mohiuddin Ahmad.

Nursery and soil management practices for raising rabi vegetable crops

vegetable nursery is a place for raising or handling of young vegetable seedlings until they are ready for more permanent planting. At vegetable nursery vegetable seedlings are grown before transplanting them in the main plots. Some vegetable plants cannot grow directly by sowing the seed into the plot. For example, for vegetable plants such as tomato, eggplant, knolkhol, cabbage, broccoli, cauliflower etc. seedling first needs to be raised and then transplanted in the plot.

Vegetables such as Tomato, Brinjal, Chillies, Capsicum, Cauliflower, Cabbage, Knol-Khol (kohlrabi), Chinese cab-Onions, Tomatoes, Eggplant, Cabbage, Brussels sprouts, Sprouting broccoli, Endive, Chicory (red and green), Celery etc.are best vegetables raised in the nursery bed. The nursery must be near the main garden to avoid damage to seedlings during transplanting. The water source should also be near for irrigation. The nursery bed must be protected from strong winds and should never be located on a slope to avoid erosion of seeds and nutrients; it should face east-west direction and never be put in a waterlogged

Care must be taken during the early stages of growth of vegetables. They have to be protected from adverse temperatures, heavy rain, drought, wind and varieties of pests and disease. If small seeds of vegetables are sowndirectly in the field, germination is poor and the young plant grows very slowly and requires lots of time to mature. Also, there can be less time in terms of the available season for full development in the field. To overcome these problems, vegetable plants are grown in a nursery before being transplanted in the main field.

Site Selection is an important consideration for nursery management. The area selected must be well-drained, and free from waterlogging. There should be proper sunlight. The nursery must be near the water supply so that irrigation can be easy. The area must be well protected from pet and wild animals.

healthy soil. For nursery the soil must be loam to sandy loam, loose and friable, rich in organic matter content, and well-drained.

raising vegetable For seedling the soil should be neither acidic nor basic. Soil pH should be near 7.0. Soil preparation needs deep cultivation of nursery land either by soil turning, plowing by spade, and subsequent 2 to 3 hoeing with a cultivator. Remove all the clods, stones, and weeds from the field and level the land. Mix 2Kg well rotten and fine FYM and about 500 gm vermicompost per square meter of

Soil solarization for about 4 to 5 weeks on the ploughed soil covered with the plastic tunnel is better. Drenching of the soil should be done 15-20 days earlier of sowing by 4 to 5 liter of water with a concentration of 1.5 to 2% of formalin solution per square meter and should be covered with plastic sheet. Application of the fungicide such as Captan and Thiram 5-6 gm of per square meter of nursery area is neces-

Furadon, Heptachlor are some insecticides that are mixed in the dry soil by 4-5 grams per square meter and should be mixed up to the depth of 15 to 20 cm for nursery preparation. Supply of hot steam at least 4 hours continuously under the covered polythene sheet and allow the soil as such for one day for the vegetable seedbed preparation.

Buy certified vegetable seeds from reputable seed companies. If you are using your seeds make sure you choose seeds with ideal and preferred qualities. To avoid seed wastage, conduct a seed germination test.

A germination test will help you to know if the seed will germinate after sowing and how many will germinate. So, you will know how many you require for a nursery. This must be done a couple of days before you sow the seeds on your seedbeds.

Make seedbeds 1.0m - 1.2mwide x 2m or longer. This standard size makes it easy and then convenient to work around the seedbed. Water the seedbeds, and cover with 4cm thick dry grass, sawdust or rice straw. Leave for 2 to 3 days to reactivate spores of disease pathogens then burn to sterilseedlings needs fertile and ize the soil. You may also as it burns seedlings and after

cover seedbed with transparent plastic sheets for 5 to 8 weeks to sterilize the soil.

Seeds must be planted at a spacing of 15cm between rows, cover the seeds lightly with soil and mulch the bed with dry grass. The bed should be watered thoroughly on the day before sowing and mulching the bed soon after sowing seeds is a must.

Mulch the seedbed after sowing until seed germination. Provide enough shade to the crop after germination one metre above the bed. Thin the crops properly, remove weak diseased vegetable seedlings and keep the bed

Transplant seedlings after 21 to 30 days. Harden the vegetable crop by removing the shade a day before transplanting as this gives the seedling chance to get used to the direct sun. Reduce water at this stage and transplant at recommended spacing per crop early in the morning or late in the evening time (from 6:00 am to 10:00 am or 4:00 to 6:00 pm) and water the plants as soon as transplanting is done.

Nursery beds should be prepared according to the season and selection of crops. In the rainy season raised beds are prepared but in the winter and summer season flatbeds must be prepared. Onion in the rabi season requires flatbeds. For uniform and high percentage of seed germination, the soil must be fine and moist enough.

If the seedlings are to be raised in boxes during unfavorable weather conditions, the flower pots, polythene bags, potting plugs, wooden trays, and earthen pots, etc. may be used. Prepare soil mixture in the ratio of about 1:1:1 of soil, sand, and well rotten FYM/leaf mold and fill the mixture in these seedling raising struc-

Raised seedbeds of 1 meter wide where no eggplant, potato, or tomato has been grown for at least 3 years should be constructed. Incorporate 5 kg/m2 of good compost into the bed and if possible solarize the planting bed to kill diseases. Dig shallow furrows with a stick. One hectare of tomato will require 150 to 200 g of good seed. Sow the seeds and then cover lightly with soil. Pat firmly with a rake, mulch and then water. Do not use fresh manure on a seedbed



seedlings emerge push mulch off the seedlings to allow sunlight. Young seedlings need sufficient water. One week before transplanting, reduce water to harden seedlings. Tomato seedlings will be ready to transplant with 3 to 5 true leaves or 15-25 cm height. Onion seedlings are ready to transplant with 3 to 5 wellformed leaves. Transplanting should be done on a cloudy day or in the late afternoon.

Before you sow, treat seeds with recommended seed dressing or hot water before planting. Drill thinly in rows about 10cm apart and cover with a thin layer of soil. For seedtrays sow 1 seed per cell and cover with newsprint. Cover bed with dry grass (nonseeded), transplant plastic and water.Seeds sheets, emerge within 5 to 7 days.

After the seedbed is prepared then the vegetable seed is sown in the nursery bed differently. In Broadcast methods seeds are broadcasted in the prepared nursery bed and later on, the seeds are covered with well rotten fine sieved and then treated FYM or compost. The major disadvantage of the Broadcast method is there is an uneven distribution of seeds in the nursery that becomes dense but this method is commonly used and practiced.

Line sowing is the best method of seed sowing in the nursery. Lines are made 0.5 to 1 cm deep parallel to the width at the distance of 5 cm from the line. The seeds are sown or placed singly at the distance of about 1cm apart. Cover the seeds with the fine mixture of soil, sand, and FYM in the ratio of about 1:1:1. After covering light irrigation should be given with the fine rose can.

The successful establishment of quality seedling and propagules depends upon the proper planning and timely execution of nursery activities. Preparation of species-level nursery activity calendar will facilitate the vegetable seedling production. The mature pod has to be collected just before it falls and subsequently seed should be extracted without damage to the seeds.

Sowing of seed/propagules must be carried out during early morning (7 to 9 am) or evening (3 to 5 pm) hours. Transplanting, watering, weeding and shifting operations in the nursery needs to be done at a fixed interval. Hardening of vegetative propagules and dispatch of grown-up seedlings must be in proper time. Engage only the skilled and trained labour in nursery activities to assure the success.

Water storage for lean available period, mother plant maintenance for seasonal collection of material is important resource management activi-

Timely availability of nursery inputs such as soil, sand, Farm Yard Manure, bio-fertilizer, chemicals, water, etc. and their collection in cheap cost period can reduce the production of seedling cost. Each plant species has its season of establishment and therefore, sowing, transplanting, and distribution of each species should be scheduled accord-

For raised nursery bed management for vegetable crops the length of the bed can be kept 3 to 5 meters; however, width is restricted to 1 meter which facilitates intercultural operations. The beds are raised about 15 to 20 cm high from the ground level. A space of 30 to 40 cm is left in between two beds. The space between 2 beds helps in weeding, nursery care against diseases and insect pests, and also for draining out the excess rainwater knife, and scissors during bud-

The number of beds mainly depends on the particular crop, season, and growing area of crop. The beds must be prepared in the east and west di-

rection and the line should be

made from north to south direction on the beds. The nursery beds need light irrigation with the help of rose can till the seeds get germinated. Excess rainwater or irrigated water must be drained out from the field as and when

it is required otherwise plants

may die due to excess of water. Timely weeding in the nursery is important to get the healthy seedling therefore manually removing them or pre-emergence herbicides such as stomp by 3ml per liter water must be sprayed on the nursery bed after the seed sowing and seed covering with the mix-

Damping-off of seedling, light blight disease, and leaf minor and the borer infect the seedling in the nursery. The plant care for controlling them in time is essential. The seedling stress symptoms such as damping off wilt, root rot, rust, and powdery mildew are caused by pathogen infection and result in stunted growth of seedlings. These pathogens can be soil,

seed, or airborne. Nurseries established in the recently cleaned land hardly invite parasitic organisms and stunted growth of seedlings indicates the loss of soil fertility, excess watering, and dumping of seedlings in shady areas. As a preventive measure sterilization of nursery mixture, pretreatment of vegetable seeds with a fungicide such as Captan can control the disease. If the disease occurs, the causal pathogen can be identified by expression of symptoms and accordingly fungicide may be applied.

Integrated disease management in nursery vegetable crops involves selection of apparently healthy vegetable seeds/ propagules for seedling production. Seed dressing with 0.2% Carbendazim/Methyl thiophanate/Benomyl/Thiram and sowing of seeds in sterilized/fumigated, clean beds, transplanting seedling after root dip for 3 to 5 min in 0.02% Carbendazim solution and adequate watering helps to reduce the disease severity.

Using sterilized budding

ding and grafting practices reduces disease inoculum considerably.

Healthy planting material maintenance by keeping them under proper sunlight, watering and clean environment along with frequent examination of vegetable seedling health and removal of diseased stocks gives rise to healthy nursery. Foliar spray of about 0.2% Carbendazim/Dithane M-45 at regular intervalto check the progress of fungal disease incidences. A major injury to nursery

stock is caused by several

groups of insects. These insect pests have been divided into three categories that are major nursery pests (white grubs, cutworms, termites and crickets), minor nursery pests (defoliators, sapsuckers, grasshoppers) and non-insect pests (nematodes and vertebrate pests). Generally, the damage caused by the insects can be controlled by maintaining better sanitation of the nursery area, adoption of suitable cultural practices, and need-based application of chemical and biological pesti-

Advantages of nursery management of vegetable crops

• It is possible to provide favourable growth conditions i.e. seed germination as well as

· Better care of younger plants as it is very easy to look after nursery in a small area against pathogenic infection, pests, and weeds.

• Crop grown by nursery rising is quite early and fetch a higher price in the market, and so economically more profitable.

• There is a saving of land and labour as the main fields will be occupied by the plants after 1 month. More intensive crop rotations can be followed.

• More time is obtainable for the preparation of the main field because the nursery is grown separately.

· As vegetable seeds are expensive particularly hybrids, so we can economize the seed by sowing them in the nursery.

Air pollution problem in Indian cities

1 out of the 30 cities with the worst air pollution in the world are in India. The capital New Delhi has the worst air quality among capital cities around the world. The concentration of particulate matter (PM 2.5) in New Delhi is nearly 10 times higher than the World Health Organization guidelines. The heavy pollution in these cities is also seriously affecting the health of the people living here, making them sicker with each pass-

ing day. In terms of life expectancy, pollution in Indian cities is a major threat to people's health, taking away an average of 5.3 years of life from every Indian. The relationship between the problem of air pollution in Indian cities rests on the idea of sustainable preservation and the use of urban heritage for economic development. By focusing on environmental protection through sustainable practices, cities can simultaneously address air pollution.

For example, adaptive reuse of historic buildings can reduce the need for new construction, thereby reducing dust and related air pollutants. In addition,

promoting local economic development in historic urban areas can shift economic activity away from pollution-intensive industries towards more sustainable practices such as tourism. Developing nations like India, where urbanization continues, are suffering from increasing air pollution problems due to a lack of services such as adequate transport management, suitable roads, and unplanned distribution of industries.

Congested roads in cities reduce the average speed of vehicles, resulting in higher vehicle emissions, which increases the level of air pollution unplanned urbanization. combined with industrialization and population growth, is posing a threat to human health by increasing the level of air pollution, causing many

Delayed winter in Assam: Climate change and seasonal shifts

s November unfolds, residents of Assam are left wondering where winter has gone. By this time, the chill is usually in the air, and morning mists lend an ethereal beauty to Assam's landscapes. But this year, winter's anticipated arrival seems delayed, prompting questions about the causes and consequences of this unusual shift.

Assam's typical subtropical monsoon climate follows a predictable seasonal pattern, with winter usually setting in by late October or early November. Temperatures generally drop gradually, marking the awaited seasonal change. However, in 2024, temperatures remain higher than usual, and winter's familiar cool breezes have yet to appear.

This late arrival of winter is likely due to a range of factors, including global climate change, regional variations, and specific weather patterns. Meteorologists explain that shifting global climate patterns are affecting Assam's seasonal cycles, which were once much more predictable. Irregular temperature changes, erratic rainfall, and changing weather patterns now challenge the state's traditional climate norms.

Global climate change plays a crucial role in delaying winter, as greenhouse gas emissions warm the atmosphere and disrupt established climate patterns. Around the world, seasonal distinctions are fading, with winters arriving later and ending earlier than in past decades. Assam, with its unique geographical location and sensitive ecosystem, is particularly vulnerable to these shifts.

Another contributing factor is the El Niño effect, which causes periodic warming of the Pacific Ocean's surface temperatures and influences global climate. Troubled by illegal border crossings, Arizona voters approve state-level immigration enforcement

PHOENIX, Nov 6: Arizona voters have approved letting local police arrest migrants suspected of illegally entering the state from Mexico, an authority that would encroach on the federal government's power over immigration enforcement but would not take effect immediately, if ever.

With the approval of Proposition 314, Arizona becomes the latest state to test the limits of what local authorities can do to curb illegal immigration. Within the past year, GOP lawmakers in Texas, Iowa and Oklahoma have passed immigration laws. In each case, federal courts have halted the states' efforts to enforce them.

The only presidential battle-ground state that borders Mexico, Arizona is no stranger to a bitter divide on the politics of immigration. Since the early 2000s, frustration over federal enforcement of Arizona's border with Mexico has inspired a movement to draw local police departments, which had traditionally left border duties to the federal government, into immigration enforcement.

The state Legislature approved an immigrant smuggling ban in 2005 that let then-Maricopa County Sheriff Joe Arpaio conduct immigration crackdowns, a 2007 prohibition on employers knowingly hiring people in the country illegally, and a landmark 2010 immigration law that required police, while enforcing other laws, to question the legal status of people suspected of being in the country

Arizona voters have been asked to decide matters related to immigration before. They approved a 2004 law denying some government benefits to people in the country illegally and a 2006 law declaring English to be Arizona's official language. They also rejected a 2008 proposal that would have made business-friendly revisions to the state law barring employers from hiring people who are in the country without authorisation

Arizona GOP lawmakers say the proposal was necessary to help secure the border, as they blamed the Biden administration for an unprecedented surge of illegal immigration. Record levels of illegal crossings have plummeted in recent months, following moves by the White House to tighten asylum restrictions.

Opponents of Proposition 314 argue it would harm Arizona's economy and reputation, as well as

and state law enforcement officers to arrest them and state judges to order their deportations. Those who enforce the law would be shielded from civil lawsuits.

These provisions, however, wouldn't be enforceable immediately. A violator couldn't be prosecuted until a similar law in Texas or another state has been in effect for 60 consecutive days.

The Arizona GOP lawmakers who voted to put the measure on the ballot were referring to Texas Senate Bill 4. The bill, signed into law by Texas Governor Greg Abbott in December, was supposed to allow local and state law enforcement to arrest people accused of entering Texas illegally from Mexico

hold in March. The following month, a panel of federal judges heard from a Texas attorney defending the law and Justice Department attorneys arguing it encroached on the federal government's authority over enforcing immigration law. The panel has yet to release its decision.

Boeing's machinists strike is over but troubled aerospace giant still faces many challenges

SEATTLE, Nov 6: Factory workers at Boeing have voted to accept a contract offer and end their strike after more than seven weeks, clearing the way for the company to restart idled Pacific Northwest assembly lines.

But the strike was just one of many challenges the troubled US aerospace giant faces as it works to return to profitability and regain public confidence.

Boeing's 33,000 striking machinists disbanded their picket lines late Monday after leaders of the International Association of Machinists and Aerospace Workers district in Seattle said 59 per cent of union members who cast ballots agreed to approve the company's fourth formal offer, which included a 38 per cent wage increase over four years.

Union machinists assemble the 737 Max, Boeing's bestselling airliner, along with the 777 or "tripleseven" jet and the 767 cargo plane at factories in Renton and Everett, Washington. Resuming production will allow Boeing to generate much-needed cash, which it has been bleeding.

"Even for a company the size of Boeing, it is a life-threatening problem," said Gautam Mukunda, lecturer at the Yale School of Management.

The union said its workers can return to work as soon as Wednesday or as late as November 12. Boeing CEO Kelly Ortberg has said it might take "a couple of weeks" to resume production in part because some workers might need retraining.

As the machinists get back to work, management will have to address a host of other problems. The company needs to get on better financial footing. But while doing so, it also needs to prioritize the quality of its workmanship and its relationships with employees and suppliers, analysts said.

Boeing has been managing itself to meet short-term profit goals and "squeezing every stakeholder, squeezing every employee, every supplier to the point of failure in order in order to maximize their short-term financial performance," Mukunda said. "That is bad enough if you run a clothing company. It is unacceptable when you are building the most complex mass-produced machines human beings have ever built."

Above all, Boeing needs to produce more planes. When workers are back and production resumes, the company will be producing about 30 737s a month, and "they must get that number over 50. They have to do it. And the people who are going to do that are the workers on the factory floor," Mukunda said.

Another challenge will be get-

ting the company's fragile supply chain running again, said Cai von Rumohr, an aviation analyst at financial services firm TD Cowen. Suppliers that were working ahead of Boeing's schedule when the strike began may have had to lay workers off or finance operations

"There are lots of nasty questions in terms of complexities that go into revamping the supply chain," he said.

One way Boeing could generate cash would be to sell companies that don't fit directly in the business, such as flight information provider Jeppesen Sanderson, which it bought in 2000 for USD 1.5 billion, von Rumohr said.

"They'd lose some earnings but they'd get a lot of cash to reduce their debt," he added. "They really need to get to a more stable position where they have a solid credit rating."

Ortberg acknowledged the challenges ahead in a message to employees after they voted to end the walkout.

"There is much work ahead to return to the excellence that made Boeing an iconic company," he

The average annual pay of Boeing machinists is currently USD 75,608 and eventually will rise to USD 119,309 under the new contract, according to the company. The union said the compounded value of the promised pay raise would amount to an increase of more than 43 per cent over the life of the agreement.

Reactions were mixed even among union members who voted to accept the contract.

Although she voted "yes," Seattle-based calibration specialist Eep Bolaño said the outcome was "most certainly not a victory." Bolaño said she and her fellow workers made a wise but infuriating choice to accept the offer.

"We were threatened by a company that was crippled, dying, bleeding on the ground, and us as one of the biggest unions in the country couldn't even extract two-thirds of our demands from them.

For other workers like William Gardiner, a lab lead in calibration services, the revised offer was a cause for celebration.

"I'm extremely pumped over this vote," said Gardiner, who has worked for Boeing for 13 years. "We didn't fix everything — that's OK. Overall, it's a very positive contract."

Along with the wage increase, the new contract gives each worker a USD 12,000 ratification bonus and retains a performance bonus the company wanted to eliminate

President Joe Biden congratulated the machinists and Boeing for coming to an agreement that he said supports fairness in the workplace and improves workers' ability to retire with dignity. The contract, he said, is important for Boeing's future as "a critical part of America's aerospace sector."

A continuing strike would have plunged Boeing into further financial peril and uncertainty. Last month, Ortberg announced plans to lay off about 17,000 people and a stock sale to prevent the company's credit rating from being cut to junk status.

The labour standoff — the first strike by Boeing machinists since an eight-week walkout in 2008 — was the latest setback in a volatile year for the aerospace giant.

Boeing came under several federal investigations this year after a door plug blew off a 737 Max plane during an Alaska Airlines flight in January. Federal regulators put limits on Boeing airplane production that they said would last until they felt confident about manufacturing safety at the com-

The door-plug incident renewed concerns about the safety of the 737 Max. Two of the planes had crashed less than five months apart in 2018 and 2019, killing 346 people. The CEO at the time, whose efforts to fix the company failed, announced in March that he would step down. In July, Boeing agreed to plead guilty to conspiracy to commit fraud for deceiving regulators who ap-

Israeli strike kills 20 in north Gaza, where Palestinians say they've had little food for weeks

DEIR AL-BALAH (GAZA STRIP), Nov 6: An Israeli airstrike in northern Gaza killed at least 20 people, mostly women and children, Palestinian officials said Tuesday, as Palestinians fled Israel's assault. Some said they had hardly eaten, with aid cut off for weeks to the most isolated and heavily destroyed part of the territory

Israel has been waging an offensive in Gaza's northernmost end for weeks, saying it is targeting Hamas militants who regrouped in the area.

The UN has said Israel hasn't allowed food and other supplies into the area north of Gaza City since the assault began, even as tens of thousands of people remain there. That has drawn rebukes from the Biden administration, which has warned that US laws might force it to curb military aid to Israel if more aid is not allowed in.

allowed in.

The strike late Monday hit a home where several displaced families were sheltering in the town of Beit Lahiya, near the border with Israel, according to Hossam Abu Safiya, the director of the recently raided and barely functioning Kamal Adwan Hospital, which received the ca-

The Israeli military said it targeted a weapons storage facility from which a militant had operated, and that "numerous steps were taken to mitigate the risk of harming civilians."

The dead included eight women and six children, according to a list provided by the Gaza Health Ministry's emergency service. Separate strikes elsewhere in Gaza early Tuesday killed another 10 people, according to health officials. Dozens of Palestinians trickled out of Beit

Lahiya on Tuesday — mostly women and children — dragging rucksacks and satchels with belongings. They entered Gaza City on a street where every building had been completely flattened or heavily damaged.

"We came barefoot. We have no sandals, no clothes, nothing. We have no money. There is no food or drink," said Huda Abu Laila.

"We are hungry. Hunger has killed us. We were under siege for one month without water or food," the gaunt elderly women continued,

before erupting in tears.
Um Nidal Abu Laila, another woman fleeing



Beit Lahiya, said there were bodies of Palestinians killed in the assault lying in the streets. "No one is able to retrieve them," she said.

Gaza's civil defence agency said it had received reports of people trapped alive under the rubble of buildings destroyed by Israeli troops in Beit Lahiya, but it was unable to send teams to rescue them. It said the military has prevented its teams from operating in the area for the past two weeks. The Palestinian Health Ministry in Gaza said there are no ambulances currently operating north of Gaza City.

Two elderly patients, one who was battling cancer, died as they tried to leave Beit Lahiya as they waited to cross an Israeli military checkpoint, the Palestinian Red Crescent said.

The military has ordered the complete evacuation of Beit Lahiya, the nearby town of Beit Hanoun and the urban Jabaliya refugee camp. Still, the UN estimated last week that around 100,000 people remain there even after tens of thousands fled the past month, the latest wave of displacement within the besieged territory. Around 90 per cent of the population of 2.3 million have fled during the 13-month-old war, often multiple times.

The army has returned to several areas of Gaza multiple times after previous operations, as Hamas continues to carry out hit-and-run attacks on troops and fire occasional rockets into

Israel. The three hospitals serving the area have been largely inaccessible because of the fighting, and ambulances have stopped operating. Israeli troops raided Kamal Adwan Hospital last month, saying Hamas militants were sheltering there, allegations denied by Palestinian health officials.

The offensive has raised fears among Palestinians that Israel is implementing a surrender-or-starve plan for northern Gaza proposed by former generals, in which civilians would be ordered out, aid would be cut off and anyone remaining would be considered a fighter.

The Israeli military has denied receiving such orders, but the government has not said whether it is adopting part or all of the plan.

Early Tuesday, an Israeli strike hit a house in the Tufah neighbourhood in Gaza City, killing two children and their parents, according to the Health Ministry's emergency service. Two other children were wounded, it said.

In the central town of Zuweida, a strike hit a tent where a displaced family was sheltering, killing four people, including a mother and her two children, according to Al-Aqsa Martyrs Hospital in the nearby city of Deir al-Balah. Another strike hit a house in Deir al-Balah, killing two people, the hospital said. An Associated Press journalist counted the bodies at the hospital morgue. (AP)

Spanish authorities issued their first tally of the missing on Tuesday when a Valencia court said that 89 people are confirmed to be unaccounted for.

The number only corresponds to the eastern Valencia region, where 211 of the 217 confirmed deaths took place when entire communities were swamped by tsunami-like floods on October 29-30. Most people were caught off guard by the deluge. Regional authorities have been heavily criticised for having issued alerts to mobile phones some two hours after the disaster had started.

The Superior Court of Valencia said that the figure was based on those cases whereby families had provided information and biological samples of their unlocated loved ones. It added that there could easily be more missing people whose families have not officially reported to authorities. (PTI)

The airstrike on Tuesday night came without warning. There was no statement from the Israeli military on the strike, and it was not immediately clear what the intended target was.

On Tuesday, Israeli Prime Minister Benjamin Netanyahu dismissed Defence Minister Yoav Gallant in a surprise announcement that sparked protests across the country. Gallant's replacement is Foreign Minister Israel Katz, a longtime Netanyahu loyalist and veteran Cabinet minister.

While Netanyahu has called for continued military pressure on Hamas, Gallant said military force created the necessary conditions



for at least a temporary diplomatic deal that could bring home hostages held by the militant

The Israel-Hamas war began after Palestinian militants stormed into Israel on October 7, 2023, killing some 1,200 people — mostly civilians — and abducting 250 others. Israel's military re-

sponse in Gaza has killed more than 43,000 people, Palestinian health officials say. They do not distinguish between civilians and combatants, but say more than half of those killed were women and children. Since the conflict between Israel and Hezbollah erupted in 2023, at least 3,000 people have been killed and some 13,500

wounded in Lebanon, the Health Ministry reported. A report by Lebanon's crisis response unit said 361,300 Syrians and over 177,800 Lebanese crossed into Syria between September 23 and November 1.

30 bodies are pulled from the rubble of a Lebanon apartment building struck by Israel

BEIRUT — Lebanon's Civil Defence service said on Wednesday they have pulled 30 bodies and remains out of the rubble of an apartment building in the town of Barja that Israel struck the night before. Search efforts were ongoing. The airstrike on Tuesday hit an area that had not been regularly targeted by Israeli military operations. It came without warning. There was no statement from the Israeli military on the strike, and it was not immediately clear what the intended target was.

Civil defence official Mostafa Danaj said it was unclear how many survivors or bodies were still trapped under the rubble. "We hope that there isn't anyone else, but the neighbours have said

that there are still people (missing)," he said.

Israeli forces and the Hezbollah militant group have been clashing for more than a year, since Hezbollah started firing rockets across the

border on October 8, 2023 — a day after the deadly Hamas-led incursion into southern Israel sparked the war in Gaza.

The war on the Lebanese front has substantially escalated since mid-September, with Israel launching a massive aerial bombardment of much of Lebanon and a ground

invasion.

More than 3,000 people have been killed by Israeli strikes in Lebanon, the vast majority of them since September 23. Israel has said it targets Hezbollah militants and weapons caches, but hundreds of civilians have also

been killed. (AP)

European leaders seek to chart common future at summit but all eyes are glued on Washington BUDAPEST, Nov 6: Dozens of tend on Thursday is Ukrainian Pres-

European leaders will be gingerly seeking to chart a more common future during a one-day summit in Hungary's capital on Thursday. Yet despite myriad economic challenges and two wars in the neighborhood, all eyes will be glued on Washington to see whether the pivotal U.S. election will cause a political rift throughout the continent.

The transatlantic relationship will doubtless change after the vote, leaders and experts have said. But the question is whether that change will be gradual under Kamala Harris or possibly seismic under Donald Trump. The impact of the U.S. results could be felt for years to come, on issues including the war in Ukraine, the European Union's trade relations with the rest of the world, migration, the Middle East conflict and climate change

conflict and climate change.

"All this is putting peace, stability and prosperity at risk in our region," said the invitation letter to the leaders of the European Political Community, which unites almost 50 nations in Europe and its near abroad, bar Russia and Belarus.

Among the leaders likely to at-

tend on Thursday is Ukrainian President Volodymyr Zelenskyy, who is expected to make another plea for more aid as his country fends off Moscow's invasion. The timing is laden with significance as Trump has vowed to end the war "within 24 hours" of being elected — something leaders in Kyiv interpret as an impending evaporation of U.S. support should Trump win.

Orbán makes plain his support for Trump

Not so long ago, such a meeting — which is also expected to include leaders from non-EU countries like Turkey, Serbia and the United Kingdom — would end with praise for European unity and a common political direction. Yet with Hungarian Prime Minister Viktor Orbán as the host of the summit, friction is as good as assured

good as assured.

Orbán, who has openly thrown his weight behind Trump and argued the former president is a "man of peace," has predicted a Trump victory and suggested that civil and criminal cases against him were the result of a politically motivated Department of Justice — a common Trump refrain. (AP)

16th Finance Commission urges states to boost self-reliance in revenue

KOHIMA, Nov 6: Chairman of 16th Finance Commission, Arvind Panagariya, encouraged the states to raise as much of their own revenue as possible to be fiscal self-reliant.

This statement was released on Tuesday where he asserted the usual devolution of grants that is done to the state will continue. "The Commission generally

does encourage states to raise as much of their own revenue as possible. Ultimately this revenue itself is a function of the GSDP of the state, and more revenue means that the GSDP is larger, and a larger GSDP is desirable in its own right, because that's what leads to higher capital incomes," Panagariya told a press conference. On the Commission's recommendation to bring resource-crunch Nagaland, which depends mostly on central funding, at par with the rest of the states, Panagariya said the special category status was related to the grants that were given by the erstwhile Planning Commission. Since the Planning Commission no longer gives any grant, the special category status is not a factor, although there is some special treatment, he said.

In many schemes where other states get only a 60 per cent contribution from the central government, it is 90 per cent in Nagaland's case, Panagariya said

"Not as much as one would like it to, but it (Nagaland) is raising some of its own revenue as well while a significant part is through the devolution and the grants-in-aid, etc," he said. While the Commission is still in the information-gathering phase,

the Chairman refrained from making detailed comments on Nagaspecific proposals, emphasizing that recommendations would only be finalized after consulting all 28 states and would be

submitted by October 2025. The Commission chairman said that the state government proposed several critical recommendations including inclusion of certain cesses and surcharges in the divisible pool, which are fully retained by the central government, depriving states of potential revenue.

The state also proposed introducing a "disability index" to consider geographical and economic challenges specific to Nagaland and introduction of "capital deficit grants" alongside the traditional revenue deficit grants, he said.

The project-specific grants requested by the state funding for a new airport, Foothill Road project, renewable energy infrastructure, hvdropower generation, mineral exploration, and advancements in drone technology, Panagariya said. Meanwhile, Panagariya said that

SHILLONG, Nov 6: The Meghalaya state government has decided to make the anti-narcotic task force (ANTF), a dedicated police force to fight against drug trafficking.

Lyngdoh announced that the government has decided to make the ANTF, a dedicated police force for fighting against the drug menace on a war footing.

Endangered orchid 'Gastrodia Lohitensis' found in Arunachal Pradesh

Leafless orchid thrives without sunlight, showcasing India's biodiversity

ITANAGAR, Nov 6: A team of scientists from the Botanical Survey of India (BSI) here recently discovered a new species of orchid in Arunachal Pradesh's Lohit dis-

Gastrodia Lohitensis, the leafless orchid, was found by Krishna Chowlu and the BSI team here, sources said. The rare orchid flourishes without sun-

light, relying on fungi in leaf litter for nutrients, they said. Found only in bamboo canopies near Tezu, the headquarters of Lohit district, Gastrodia Lohitensis has unique features like linear calli and ridged lower lips, distinguishing it from similar species in

Southeast Asia. Named after its home district, the orchid highlights India's incredible biodiversity, the sources added.

Chief Minister Pema Khandu has expressed delight over the new discovery. "A new mycotrophic species of the genus Gastrodia (Orchidaceae), Gastrodia lohitensis, has been discovered in the pristine landscapes of Arunachal Pradesh! This remarkable species, distinguished by its unique white flowers and parallelly

bellum, has been classified as "Endan-



gered" according to IUCN (International Union for Conservation of Nature) Red List criteria," Khandu posted on X.

His party is contesting 52 seats as part of the Mahayuti alliance with the Shiv Sena and Bharatiya Janata Party (BJP).

The party also unveiled constituency-specific manifestos for all the seats it is contesting.

Pawar is seeking his re-election from Baramati, while the NCP (SP) led by his uncle Sharad Pawar has fielded Yugendra Pawar from the seat, making it a Pawar vs Pawar battle. Yugendra is Ajit Pawar's nephew.

"During the Lok Sabha polls, a fake narrative was spread by the opposition that the Constitution will be changed, which is not possible and will never be. The opposition managed to create a fake narrative about the Constitution, and we (Mahayuti) had to pay for it in the Lok Sabha polls," he said in a press conference in Baramati.

The blindfold around the eyes of the Lady of Justice at the Supreme Court was removed and the sword was replaced by the Constitution, which shows the respect the government has towards the Constitution, he said.

Asked about whether the promises made by the Mahayuti are sustainable, he said the majority of the promises can be implemented.

"We will have to increase the revenue and resources of the state. When we present the budget, we strive to see where we can save without affecting the poor and marginalised class. If we save money, the schemes will get funds," he said.

"I heard the speeches made by the opposition parties, in which they cast doubts on the promises made by the Mahayuti stating that the state will face a financial crisis. But at the same time, they are giving more promises than the Mahayuti," the state finance minister

According to Pawar, the opposition presented some schemes which can create additional financial burden on the state.

"If they are voted to power, they won't be able to execute these schemes. The other thing is that since the BJP which rules the Centre does not share their ideology, they won't be able to get support. Contrary to that, we will get massive support. Andhra Pradesh and Bihar are two examples of that and we will be able to run the schemes smoothly," he said.

Asked that elderly voters in Baramati are drifting towards the senior Pawar, Ajit Pawar said that trend was there in this year's Lok Sabha polls. "But for the state assembly polls, the trend of Baramatikars has changed and everyone will see it on November 23 (on poll results day)," he said.

Replying to a question on a challenge he has been facing within the family, he said that the entire Baramati was his family and it will make him victorious.

"I am confident of the win as I have reached out to more than 50 villages and established a dialogue with people," he said.

On a question related to the development of Baramati, which is being as the development done by the entire Pawar family and not just by Ajit Pawar, he said he is not refuting that but added that he also had a small share as compared to the big share by others.

Jharkhand polls: I am contesting against 'Pariwarvad', says Independent candidate

JAMSHEDPUR, Nov 6: Shiv Shankar Singh, who recently resigned from the BJP's primary membership in protest against the party's decision to field a candidate from an influential family in Jamshedpur East, on Wednesday said he would contest as an Independent candidate in the upcoming assembly elections.

He also criticised the saffron party for its "Pa vad" (dynastic politics) and claimed that his presence in the race would impact the prospects of national parties, including the Congress.

Singh, one of the four BJP members suspended by the party on Tuesday for violating party guidelines and contesting against the official candidate, Purnima Das Sahu (daughter-in-law of former Jharkhand CM Raghubar Das), argued that his decision would affect both the BJP and Congress in the contest.

The 55-year-old Singh, who has an RSS background and has been active in politics for nearly three decades, voiced strong opposition to the BJP's decision to field Purnima from Jamshedpur East. He alleged while the BJP leadership frequently criticised "Pariwarvad" in its public addresses, it engaged in dynastic politics itself.

Singh pointed to several family members of influential figures who had been given tickets in the state, such as Meera Munda (wife of former Union Minister and Jharkhand CM Ariun Munda) from Potka and Babulal Soren (son of ex-CM Champai Soren) from Ghatsila.

"How can the BJP criticise 'Pariwarvad' when they are practicing it themselves?" Singh asked, adding that the party had no right to speak against it.

Though 24 candidates, including 15 Independents, are contesting from the seat, Singh described the contest as a three-way race between BJP, Congress, and him-

He argued that both Purnima Sahu and Congress candidate Dr. Ajoy Kumar were "parachuted candidates" who lacked a deep connection to the people of Jamshedpur East. (PTI)

BJP bastion Nagpur South-West won't be cakewalk for Fadnavis: Political experts

South-West assembly seat in Maharashtra is considered a stronghold of the BJP, but this time its MLA and Deputy Chief Minister Devendra Fadnavis is expected to get a good fight from his Congress opponent, say political observers.

While Fadnavis has a strong chance of winning the seat in the November 20 state polls, it could be a close contest between him and his Congress rival Prafulla Gudhade Patil, whom the BJP leader trounced in 2014, they said.

The flooding in some areas of the constituency after heavy rains last year and inflation are among the most discussed topics among the electorate in the high-profile seat, comprising 4,08,149 voters.

The BJP is hoping to blunt the opposition's campaign by highlighting Ladki Bahin Yojana, a financial aid scheme for the poor women, and other welfare measures for different sections of the society, political analysts said.

Some prominent establishments like the Multi Modal international Cargo Hub and Airport at Nagpur (MIHAN), AIIMS, IIM Nagpur are located in the constituency and Fadnavis, who is seeking a sixth term, is expected is to score over his opponent on the development plank, they said.

"Nagpur South-West is BJP's stronghold but for the first time, it



would be anything but a cakewalk. While it still looks like going the BJP's way due to the formidable presence of Fadnavis, his Congress rival is no minnow,' political analyst Vivek Deshpande told PTI. Patil, an ex-corporator, has been a familiar name and is banking on anti-incumbency and public displeasure against unem-

ployment and price rise, he said. "Unlike Fadnavis, who has acquired a halo around himself in the last 10 years - first as CM and later as Deputy CM, Patil, a Kunbi, maintains a low profile and works silently to do network-

ing in the public," he said. This time, Fadnavis faces a tough challenge to keep afloat, looking at his massive campaign

rollout through hoardings which have sprung up in every nook and corner of the constituency," Deshpande said.

The constituency comprises about one lakh Dalits, 70,000 kunbis, 60,000 Brahmins, 30,000 Telis and 20,000 Mali voters that might serve Patil better this time than previously, when the Constitution issue was not raised, he opined. "All in all, Fadnavis can't rest as much assured this time as on the previous two occasions," Deshpande said.

Local resident Dr Archana Deshpande said she and some other people were disappointed by the response of local authorities and the government after flooding when the Ambazari lake overthe area in September 2023.

"We could not get timely help and the flood water entered our homes, causing damage. Our roads are not proper, there is no cleanliness and no proper intervention was done to stop the spread of Chikangunya in our area, which was preventable," said the resident of Shankar Nagar in the constituency.

Listing other problems, including inflation, the doctor claimed though electors are not happy, maximum votes would go to the BJP and Fadnavis as the people have no better alternative.

Joseph John, resident of Ajni in the constituency, said he feels Fadnavis will win, but there will be a tough fight.

"Being the former CM and present deputy chief minister, Fadnavis has an edge. He has never lost from this constituency. All these factors seem to be going Fadnavis' way," John said. A resident of Ambazari in the

constituency, who did not wish to be identified, said a section of locals would like to see a change in power this time. He raised concerns over the al-

leged illegal constructions around Ambazari. He said many people like him voted for the BJP last time, but the party midway took along NCP (of Ajit Pawar) which

Political analyst Pradip Kumar Maitra said Prafulla Gudhade Patil's father Vinod Gudhade Patil was the first BJP MLA from Nag-

pur district in 1990. The senior Patil was a two-term MLA from Nagpur-West before he left the BJP and joined Con-

He fought as Congress candidate in the 1999 assembly polls and lost to Fadnavis, who was then contesting his first state election. The Nagpur South-West constituency is home to many big ticket establishments. Also, the Nagpur Metro came up during Fadnavis' rule and the credit goes to him as well as Union minister Nitin Gadkari, Maitra said.

Nearly one lakh direct job avenues have been created in MIHAN and other establishments, which will give electoral dividends to Fadnavis and the opposition will find it tough to dent his credibility, he said.

"Prafulla Gudadhe Patil is good youth leader. He does not have that stature to counter Fadnavis, but will give a strong fight to Fadnavis, whose winning margin may come down," the analyst said.

The Congress candidate has claimed that the seat will throw up an upset in the polls because his opponent Fadnavis has lost his "ground connect". (PTI)

J-K Assembly proceedings adjourned for the day amid uproar over resolution on special status

Kashmir Assembly proceedings were adjourned for the day on Wednesday amidst uproar after the House passed a resolution seeking a dialogue between the Centre and elected representatives for restoration of special status of the erstwhile

Speaker Abdul Rahim Rather adjourned the House till Thursday as ruckus continued in the assembly over the resolution. After the House passed the resolution through voice vote, the assembly witnessed noisy scenes as the BJP members stormed its well to protest the resolution.

The Speaker had first adjourned the proceedings for 15 minutes.

However, as soon as the House met again, the BJP members continued with their protest and raised slogans against the Speaker.

BJP MLA and Leader of the Opposition, Sunil Sharma, said, "We have reports that you (Speaker) called a meeting of ministers yesterday and drafted the resolution yourself". However, Rather told the protesting BJP members to take their seats, saying "enough is enough". Amidst the din, the Speaker then adjourned the proceedings again for an hour.

Even as the House met again at 12:20 pm, the ruckus continued, with the BJP members raising slogans "Go back Go back, Speaker go back", and "take back illegal resolution". The Speaker repeatedly

It said this Assembly calls upon the Government of India to initiate dialogue with elected representatives of people of Jammu and Kashmir for restoration of special status, constitutional guarantees and to workout constitutional mechanisms for restoring these provisions. "This Assembly emphasises that any process for restoration must safeguard both national unity and the legitimate aspirations of the people of Jammu and Kashmir.," the resolution

A bench of Chief Justice D Y Chandrachud and Justices J B Pardiwala and Manoj Misra also directed the UP government to pay ₹25 lakh compensation to the man whose house was razed in 2019 for a road widening project. "You can't come with bulldozers and demolish the constructions overnight. You don't give the family, time to vacate. What about the household articles inside the house?" the bench asked the counsel representing the UP government.

Further, the apex court directed the UP chief secretary to conduct an inquiry into the matter pertaining to a house in Maharajganj district and take suitable action.

The bench elaborated on the steps that a state or its instrumentality must undertake before taking action in pursuance to a road-widening project.

The top court accordingly asked the states to ascertain the existing width of the road in terms of records or maps and carry out a survey, which would allow ascertaining the encroachments, if any, on the road.

In case an encroachment was found, the top court said, the state must issue a notice to the encroacher to remove it and if the correctness and validity of the notice was objected to, the state would issue a "speaking order" keeping in mind the principles of natural justice.

In a scenario of the objection being rejected, a reasonable notice would be furnished to the person against whom the adverse action was proposed, to remove

"You say you have only issued 'munadi', which is a beat of the drum," it observed, adding that no notice was issued to the individual before the house was razed, according to court records.

Don't trust caller ID info; can be spoofed easily: Cyber advisory to govt officials

NEW DELHI, Nov 6: A cyber security advisory has cautioned government officials against trusting the caller ID information that pops up while receiving a phone call, following a spurt in "vishing" attacks aimed at compromising confidential personal information and gaining unauthorised access to official systems.

"Attackers may impersonate trusted entities, such as senior government officials, law enforcement agencies, or technical support personnel," the advisory issued recently by the National Informatics Centre (NIC) says.

The severity of the communication has been categorised as "high". It has specified that attackers "manipulate" caller ID information to make a call appear as if it is coming from a "legitimate government

The communication sent to multiple government departments and ministries has been accessed by PTI. It says it was issued as "in recent months, there has been an increase in vishing attacks targeting government officials to compromise confidential information and gain unauthorised access to official systems"

"Vishing" or voice-phishing is a social engineering attack where scamsters use phone calls or voice messages to manipulate individuals to share sensitive information, such as log-in credentials, personal information and financial details.

The attackers also deploy the tactic of conveying a "sense of urgency", "coercing" targets into revealing information by implying severe consequences for non-compliance and using "complex technical language" to confuse or intimidate targets, making them more likely to comply, the advisory has said.

It has asked government officials to be cautious against such techniques as it has underlined that caller ID information can be "easily

"Do not trust the legitimacy of the caller based solely on the displayed number. Cross-check any caller claiming to represent an official agency with official records," the communication has advised. It has also asked officials to mandatorily verify the caller's identity

through government channels before sharing sensitive information. The advisory has asked them to call back the organisation or individual using publicly available contact information.

Officials, according to the advisory, should always "be suspicious of any unsolicited calls asking for personal or confidential information, especially when the caller is creating urgency or panic to pressure compliance"

"Take time to verify the information provided by a suspect caller," the advisory has said. It has also asked government staffers to practise all established protocols for ensuring safe cyber interaction during work and otherwise. (PTI)





'GANGS OF WASSEYPUR' TEAM, SONU NIGAM, KAVITA SETH PAY RICH TRIBUTES TO SHARDA SINHA

NEW DELHI, Nov 6: Anurag Kashyap, Manoj Bajpayee, Richa Chadha, Huma Qureshi, and Sonu Nigam were among the prominent cinema personalities who condoled the death of popular folk singer Sharda Sinha, fondly called 'Bihar Kokila'

Sharda, who was undergoing treatment at All India Institute of Medical Sciences (AIIMS) Delhi following a health complication due to multiple myeloma, died on Tuesday night. She was 72. The Padma Bhushan recipient lent her voice to songs prominently in Maithili, Bhojpuri and Magahi languages such as 'Chhathi Maiya Aayi Na Duaariya', 'Ho Deenanth', 'Dwar Chekai', and 'Patna Se', but had also sung Hindi film songs like 'Taar Bijli' (Gangs of Wasseypur), 'Kahe Toh Se Sajna (Maine Pyar Kiya), and 'Babul (Hum Aapke Hain Koun..!). Anurag, who directed Gangs of Wasseypur, shared Sharda's photo on his Instagram Stories

with the lyrics of 'Taar Bijli'. "Sharda Sinha," he captioned the post with a bro-

ken heart emoji.

Bihar-born Manoj, who played the role of Sardar Khan in the 2012 film, said he was saddened by the news of the singer's death.

"I pay my respects to the great singer Sharda ji who took Bhojpuri music and singing to the national and international level with her singing! May God give peace to her soul," he wrote on X.

In revenge drama, 'Taar Bijli' plays out as part of the pre-wedding celebrations of Faizal Khan (Nawazuddin Siddiqui) and Mohsina Hamid (Huma Qureshi) with the Khan family matriarch Nagma Khatoon (Richa Chadha) singing the song. Richa said the news of Sharda's death has come as a shock. "The world of folk songs and music will miss a natural and trained singer like Sharda ji... We are grateful to her. My respects," she wrote on her Instagram Stories. Varun Grover, who penned 'Taar Bijli', in his tribute recalled how Sharda came into the lives of non-Biharis like him as the voice of 'Kahe Tohse Saina', the song from 1989's Maine Pyar Kiya, and then stayed here.

"When we developed an understanding of folk

music, her true status was revealed to us. It was a great fortune that I got the opportunity to create a song with her. Rounds of tea, laughter, stories and paan continued and the song kept being created," the lyricist wrote on X.

"My respects. Your voice is and will always be the background music of every Chhath festival," he added, sharing the link to Sinha's Maithili song 'Mohi Lelkhin Sajni Mor Manwa'

In a video about the making of the music of Wasseypur, composer Sneha Khanwalkar described Sharda's voice as "pure wine" and recalled how they first met.

"Anurag suggested, 'Do you want to try Sharda ji?' So I went to her house and I sang a few lines to her. She brought out her harmonium and sang those lines so I thought this is the best...," Sneha recalled. Sharda also sang the song 'Nirmohiya for the second season of the Bihar-set web series Maharani, fronted by Huma.

The actor, who plays the lead role of Rani Bharti in the Sony LIV show, shared a clip of the song on Instagram. "RIP@shardasinha_official ma'am," Huma wrote.

Amorim heading into Man United job on back of huge win over Man City

Call him the new Alex Ferguson. Ruben Amorim endeared himself to fans of Manchester United, the team where he'll soon be coach, by leading current club Sporting Lisbon to a 4-1 victory over Manchester City in the Champions League on Tues-

Ahead of his final home game in charge of Sporting after more than four years, Amorim quipped that United fans "will think that the new Alex Ferguson has arrived" if he was able to lead Sporting to victory over City — one of the favorites for the European title.

While that might be too strong after all, Ferguson is regarded as one of soccer's greatest managers after his trophy-laden spell at Old Trafford from 1986-2013 — United supporters might be thinking they finally have a coach who can bring the good times back to a club that has lost its way since Ferguson's departure more than a decade ago.

Someone who can take on — and beat — City's esteemed manager Pep Guardiola, too.

"He's so much better than me at the moment," Amorim said, "but I believe a lot in my new club. We will start from a low level, and we will

improve the team, the club.' Especially if Amorim eventually



brings Viktor Gyokeres with him to Manchester.

The Sweden striker led Sporting's fightback from a goal down at Estadio Jose Alvalade by netting a hat trick - including two penalties in a stunning result in the fourth round of league games in the revamped competition. That's 23 goals in 17 games for Gyokeres this season. Amorim has already said he wouldn't look to sign Gyokeres in January but expects the striker to be heading to a bigger team at the end of the season. "Viktor has to stay until the end of the season," Amorim said, "and then his life maybe is going somewhere else.'

Sporting fans unfurled a huge banner ahead of kickoff bearing the message "Obrigado (thank you) Ruben Amorim," five days after the 39-year-old coach signed to become the new United manager. He will take charge of United from Monday, allowing him to complete his commitments with Sporting, which included the match against City and concludes with a trip to Braga on

Sporting's players after the game and walked around the field with the team in a farewell to fans

"Of course we will miss him a lot, we have done amazing things together," Gyokeres said of Amorim, who has led Sporting to two Portuguese league titles in his four full seasons at the club.

"We have to look forward to the next challenge ahead of us, but first of all we have another game in Sunday." In ending City's record 26game unbeaten run in the Champions League, Sporting also consigned the Premier League champions to a third straight loss in all competitions - and that hasn't happened since April 2018.

City was defeated by Tottenham in the English League Cup on Wednesday and by Bournemouth in the Premier League on Saturday.

Erling Haaland missed a penalty in the 69th minute for City when the score was 3-1. City had taken the lead through Phil Foden in the fourth minute.

World Boxing president Boris van der Vorst said the recruits "recognize it is the only way to keep the Olympic dreams of their boxers alive." The new members joined at a meeting in Pueblo, Colorado which hosted World Boxing's first global championships, at under-19 level. (AP)

Gauff defeats Swiatek to reach the semifinals at the WTA Finals

RIYADH, Nov 6: Coco Gauff earned her second victory over Iga Swiatek in 13 career matchups, winning 6-3, 6-4 at the WTA Finals to reach the semifinals of the season-ending tournament. The result means that Swiatek can't move up from No. 2 in the rankings this week, so Aryna Sabalenka will finish the year at No. 1 for the first time. It was Gauff's first victory over Swiatek since the 2023 Cincinnati Open, snapping a four-match losing skid head-to-head. Gauff, the 2023 U.S. Open champion, also put an end to five-time Grand Slam champ Swiatek's six-match unbeaten run at the WTA Finals, an event the Polish star won a year ago.

The win moved Gauff to 2-0 in the Orange Group, while Swiatek fell to -1. Swiatek had rallied to beat Barbora Krejcikova in three sets on Sunday in her first match in two months.

Krejcikova, the Wimbledon champion, kept her chances of advancing alive with a 6-3, 6-3 win over Jessica Pegula. That eliminated Pegula, who lost in straight sets to Gauff in their opening match in Saudi Arabia. (AP)

MADRID, Nov 6: There were plenty of jeers at the Santiago Bernabeu Staladder unless they set their backline dium. Before the match, when the Champions League anthem was played. And after the match, when Real Madrid saw its 15-game unbeaten run at home in the Champions League come to an end.

Madrid fans still appeared upset by Vinícius Júnior not winning the Ballon d'Or ceremony, and also with yet another poor performance by the team. Madrid followed up its 4-0 loss to Barcelona in the Spanish league 'clasico" with a 3-1 defeat against AC Milan in the Champions League, and coach Carlo Ancelotti didn't hide his concerns, "We need to be worried, we are not showing the best version of ourselves," Ancelotti said. "We are not compact as a team and we need to change that. We lack order in the team and, as a result, we're conceding too many goals."

Madrid, the European powerhouse that has a record 15 Champions League titles, has now conceded seven goals in four matches in the competition, with its other loss coming in a 1-0 defeat at Lille. It has trailed in its last three games in the competition, though it rallied to beat Borussia Dortmund 5-2 in its other home game after conceding first.

"It's normal to be worried in this situation," Ancelotti said. "We'll endure long nights, but we have to work on improving things and find that solidness that we've have for so long and that now we don't have it."

The result left Madrid in 17th place in the 36-team league phase of the Champions League.

"We need to stick together and try to correct what we are doing badly, Madrid midfielder Luka Modric said "It's not a crisis, that's not a word I like to talk about. I've been here 12 years and it's not the first time I've seen this situation. Quality is not enough, we need to work more as a team, then it's easier for us. I'm sure we'll rise up again."

The defense has been a problem for Madrid, which has conceded 10 goals in its last four matches.

"It's too much four a team like ours," Ancelotti said. "Our strength was that we were a solid team."

The attack also faltered, with Kylian Mbappé again failing to click with teammates Vinícius Júnior and Rodrygo up front. (AP)

NEW DELHI, Nov 6: Manas Dhamne could be the answer to Indian tennis' desperate search for 'Mr Dependable', reckons new Davis Cup coach Ashutosh Singh, who is mighty impressed with the teenager's diligent approach and workmanlike attitude.

Ashutosh, who replaced Zeeshan Ali as coach, observed the youngster from Malegaon in Stockholm, where India competed in the Davis Cup Group I tie against Swe-Dhamne, 16, did not get to play a match

but was part of the squad that travelled to Stockholm along with another youngster, Arvan Shah. It was a clear sign that the team man-

agement and the selectors wanted Dhamne and Shah to have the Davis Cup experience, what it means to be with the national squad and what it takes to represent the country at the World Cup of ten-

A year later, he was given a wild card by the MSLTA for the Tata Open Maharashtra, the ATP250 event, and again he impressed with his baseline game and range of strokes against American Mihale Mmoh, who was ranked 113 then.

In the season 2024, Dhamne has consistently competed on the ITF Men's Tour. He himself has not yet broken into top-1000 but already has wins over Nicholas David Ionel (378) Japanese veteran Tatsuma Ito (top-60 a few years back) and Romania's Vlad Dancu (ranked 565).

Rishabh Pant climbs 5 places to 6th spot in ICC Test batters' rankings

DUBAI, Nov 6: India wicketkeeper batter Rishabh Pant on Wednesday rose five places to sixth spot in the latest ICC Men's Test Batter Rankings following his strong performance in a losing cause in third Test against New Zealand in Mumbai last week.

Pant made the jump on the back of a pair of half-centuries during the Mumbai Test, in a sure sign that he is back to his best following a serious car accident, with the attacking left-hander now just one spot behind the career-best fifth position he first occupied in July

The other Indian batter in top Test batter's chart is young lefthanded opener Yashasvi Jaiswal, who dropped a rung to fourth.

New Zealand secured a narrow 25-run victory in Mumbai to claim an unprecedented 3-0 series whitewash over India, with Pant and visiting side's Daryl Mitchell the main beneficiaries in the top 10 Test batter rankings

Mitchell jumped eight places to seventh after scoring 82 in the first innings against India in the Mumbai Test, joining teammate Kane Williamson (second) as the only New Zealanders inside the top-10.

England right-hander Joe Root maintained his healthy lead at the top of the list, with Williamson, Harry Brook (third), Jaiswal (fourth) and Steve Smith (fifth) his closest challengers.

India's Shubman Gill (up four places to 16th) also makes some ground on the list for Test batters following a score of 90 in the first innings against New Zealand in Mumbai, while player-of-the-series Will Young of New Zealand gained 29 spots to move to 44th

Ravindra Jadeja climbed two spots to sixth in the Test bowler rankings after taking 10 wickets against New Zealand, placing him just behind top-ranked Kagiso

Australia's Josh Hazlewood occupied the second spot ahead of India pace spearhead Jasprit Bumrah and Pat Cummins and Ravichandran Ashwin. (PTI)

David Warner says Cricket Australia 'squashed' ball change issue 'as

fast as they could' SYDNEY, Nov 6: Former Australia opener David Warner has called on Cricket Australia to clarify what happened when the umpires changed the ball during India A's first unofficial Test against Australia A, claiming the governing body "squashed" the matter "as quickly as possible."

Warner, whose leadership ban has just been lifted by Cricket Australia, said the matter was done away with given that the senior Indian team is bound for

Australia for a five-Test series. The issue emerged on the final day of the four-day game in Mackay last week, when the umpires provided the Indian players with a different ball to use at the start of play. The Indian players, particularly Ishan Kishan, were unhappy with the decision as the wicketkeeper-batter terming it as

"a very stupid decision." "I think the ultimate decision's with CA, isn't it? I think they've obviously squashed it as fast as they could, given that India's coming out here this summer," Warner was quoted as saying by the 'Sydney Morning Herald'.

"But if the umpires deem that something happened, then I'm sure there'll be a follow-up and I think the umpires or the match referee should be standing here answering those questions.

"I think the match referee should be coming out and addressing his own staff, who are the umpires, and if they're sticking by the umpire's decisions, then you've got to stand up for that. I think that's obviously a statement that CA probably need to release," he added.

Ponting said, "Shami just leaves such a big hole in that bowling group. Back then (in August), there was still some conjecture whether Shami would be fit or not."

While hailing Australia as a more settled unit, Ponting backed India to not be absolute pushovers when the series gets underway from November 22 in Perth. "I think India will win a Test match somewhere through the five Test matches," Ponting predicted.

"But I still think now, Australia probably look a bit more settled, a bit more experienced and we know that they're a very hard team to beat at home. So I'll stick with the

The next phase of the process would be "Targetted Dialogue", which would require the submission of an edition-specific formal bid, which would be assessed
