

# BJP-Congress in direct contest in three out of 5 Assam seats • 9000 polling, 1300 security personnel deployed in 1078 polling stations **Stage set for polls after volatile campaigning**

GUWAHATI, Nov 12: Polling for five assembly seats will take place on Wednesday with BJP taking on Congress in direct contest in three assembly constituencies.

The ruling party is fighting in three seats while its allies—Asom Gana Parishad (AGP) and United People's Party Liberal (UPPL) have given candidates in two places.

A total of 34 candidates are in the fray with most of them being first-timers, according to the Election Commission

Bye-elections in five assembly constituencies-Dholai, Samaguri, Behali, Bongaigaon, and Sidli became due following the elections of five legislators in the lower house of the parliament in this year's Lok Sabha polls.

Chief Electoral Officer Anurag Goel told PTI that around 9,000 polling personnel have been engaged to ensure smooth voting across 1,078 polling stations in the five seats.

"All polling parties have left for their booths with the EVM units and many of them have already reached their designated places. The security apparatus has also been in place so that



nothing untoward takes place," he said.

A total of 13 companies of Central Armed Police Forces (CAPF), comprising about 1,300 personnel, have been deployed for the by-elections, Goel said.

The Dholai assembly constituency is reserved for the Scheduled Caste (SC) community and the Sidli seat is reserved for the Scheduled Tribe (ST). Clashes between BJP and Congress supporters have been reported almost on a daily basis in Samaguri since the bypoll was an-

nounced. A number of complaints have been filed by both sides before the Election Commission. Except in Samaguri, where Congress heavyweight Rakibul Hussain has been winning since 2001, the rest of the four seats are with the BJP-led alliance.

The BJP has given candidates in three seats-Dholai, Samaguri and Behali. Diplu Ranjan Sarma has been given a ticket in Samaguri while Diganta Ghatowar and Nihar Ranjan Das will fight for the BJP in Behali and Dholai assembly segments respectively.

BJP's former cabinet minister Parimal Suklabaidya successfully contested in the Silchar Lok Sabha seat and his earlier assembly seat Dholai was vacant. Meanwhile, another senior BJP leader Ranjit Dutta was elected to the lower house of the parliament this time. He was representing the Behali seat in the assembly.

Congress leader Rakibul Hussain defeated the three-time AIUDF MP and party chief Badruddin Ajmal in the Dhubri Lok Sabha seat with a margin of more than 10 lakh votes reinforcing his status as a five-time legislator from the Samuguri assembly seat. (CONTD. ON PAGE-2)

The family, hailing from Bihar, was coming from Dibrugarh to attend a wedding in Tinsukia when the accident occurred.

The deceased has been identified as Mohan Shah, Rajesh Gupta, Montu Shah and child Arthay Gupta.

"We believe that the incident took place due to poor visibility of the road on account of dense fog and absence of proper signage," the police officer said.

Local residents have expressed concern about the incomplete state of the bypass, particularly the unfinished culvert. (PTI)

#### Situation remains tense in Jiribam, patrolling on

IMPHAL, Nov 12: A day after the killing of eleven suspected militants in a gunfight with security forces in Manipur's Jiribam district, the situation there remained calm but tense on Tuesday morning with policemen patrolling at vulnerable points, officials said.

The district administration imposed prohibitory orders to avoid any untoward incident in the area, while an operation was launched to trace missing persons, they said.

A shutdown has been observed since 5 am on Tuesday in Kuki-Zo majority areas in the hills to protest against the killing of suspected insurgents, the officials said.

Eleven suspected militants were killed in a fierce gunfight with security forces on Monday after insurgents in camouflage uniforms, armed with sophisticated weapons, fired indiscriminately at a police station and an adjacent CRPF camp in Jiribam district, they said. Two CRPF personnel also sustained injuries during the heavy exchange of fire at Borobekra, and the condition of one of them was



### **STF nabs drug peddler** in Khanapara

HT Bureau GUWAHATI, Nov 12: Acting on a tip-off, the Special Task Force (STF) of Assam Police conducted a raid in Khanapara under the Basistha Police Station jurisdiction on Tuesday afternoon, leading to the arrest of a suspected drug peddler. During the operation, the STF

seized 21 vials containing 28 grams of suspected heroin, along with a mobile phone and Rs 340 in cash.

The accused, identified as Rahul Patir, originally hails from the Matmora village in Lakhimpur district. The 23-year-old is currently residing in Ri-Bhoi, Meghalaya.

Assam Police have confirmed that all necessary legal formalities are being completed, and further investigations are underway to determine Patir's network and potential connections.

No reservation to Muslim

candidates in admissions: AMU

ALIGARH, Nov 12: The Aligarh Muslim University (AMU) has denied

"The Aligarh Muslim University gives no reservation to Muslim candidates either in admissions in different courses offered by the university or in the recruitment, as has been reported by some media outlets, after the recent judgement of the seven-judge bench of the Supreme Court of India," Prof Mohammad Asim Siddiqui of the AMU's Public Relations Office said in the statement.

"AMU has an internal quota system for the students passing out from the schools run by the university. When these students seek admission in the university, they are considered internal and 50 per cent of seats are reserved for them regardless of their religion or faith, subject to eligibility requirements," it said. Siddiqui added, "Reports about reserving seats for Muslim candidates in AMU are false and misleading."

While referring to the university's minority status at a rally here on November 9, Uttar Pradesh chief minister Yogi Adityanath said the matter is being decided by the Supreme Court, but added, "Such an institution, which is nurtured by India's resources and runs on public taxes, does not give reservation to the backwards, scheduled caste or tribal people, but is arranging 50 per cent reservation for Muslims." #### Indigenous tribes vital for ecosystem: Wangchuk

HT Bureau DIPHU, Nov 12: A two-day national seminar on the "75th Year of the Sixth Schedule," organized by the Karbi Anglong Autonomous Council (KAAC) in association with the Centre for Karbi Studies, Diphu, and the Department of Political Science at Assam University Diphu campus, kicked off at the Diphu Arboretum-cum-craft centre on Tuesday.

In the inaugural session, renowned climate activist and Ramon Magsaysay Awardee Sonam Wangchuk from Ladakh graced the occasion as the chief guest.

Wangchuk emphasised that strengthening indigenous tribes is crucial for preserving the fragile ecosystem in the region. He also noted that around 2 billion people depend on the Himalayas for water, with the northern part of India, southern China, and Tibet relying on mountain glaciers and a delicate ecology that sustains a quarter of the global population.

"Indigenous communities are the best stewards of these regions, having preserved them for thousands of years. However, in Ladakh, where there is a council but no legislative power due to the lack of inclusion in the Sixth Schedule, governance relies on bureaucrats with short-term assignments, which risks harming the environment for future generations in pursuit of profit," added Wangchuk.

Wangchuk also expressed gratitude to the KAAC and the Centre for Karbi Studies for providing a platform for people from across the Northeast and stu-



dents to learn about the Sixth Schedule.

He pointed out that while most Sixth Schedule areas have around 50 percent indigenous populations, Ladakh has 95 percent indigenous tribal people.

He further recalled that the ruling party had made written promises in 2019-2020 to include Ladakh in the Sixth Schedule and expressed hope that the government would consider this commitment.

KAAC executive member Surya Rongphar shared his experiences with the functioning of the Autonomous Council, describing the Karbi Anglong Autonomous Council as a model Sixth Schedule Council. Despite 70 years of experience with the Sixth Schedule, Rongphar highlighted contradictions between the state and the Council.

# 'Zero error responsibility of both Centre and state

NEW DELHI, Nov 12: Union Education Minister Dharmendra Pradhan on Tuesday announced that the Centre is introducing various reforms in the entrance examinations in the country beginning in January and appealed to the state governments to extend their support for zero-error entrance tests.

Pradhan said that the Radhakrishnan panel has submitted its report outlining reforms in the National Testing Agency (NTA) and to implement the recommendations, the cooperation of states is essential.

"I have appealed to all state government education secretaries. A new entrance exam series for the upcoming year will begin in January. Based on last year's experiences, the government has introduced numerous reforms," he told reporters on the sidelines of a national workshop on higher and technical education attended by secretaries of states and Union territories (UTs).

"The Radhakrishnan committee has submitted its recommendations and to implement



them, the states' cooperation is essential. I have appealed to everyone on this matter, especially regarding entrance examinations.

"Bringing examinations, especially entrance exams, to zero error is the responsibility of both the Government of India and the state governments. We will work as a team to build confidence in the children of our country," the education minister added

In the line of fire over alleged irregularities in the medical entrance examination NEET and PhD entrance NET, the Centre had in June set up the panel headed by former ISRO chief K Radhakrishnan to ensure transparent, smooth and fair conduct of examinations by the NTA.

While NEET was under the scanner over several irregularities, including alleged leaks, UGC-NET was cancelled as the ministry received inputs that the integrity of the exam had been compromised. Both matters are being probed by the CBI.

Two other exams - CSIR-UGC NET and NEET PG – were cancelled at the last moment as a pre-emptive step.

Several key decisions were made to enhance the Board's operational capacity. Plans were approved to establish a Central Planning Unit (CPU) and Project Management Unit (PMU) at the Board's headquarters for better oversight and project execution.

Additionally, specialised cells focused on information technology, artificial intelligence, data management, media and communication, monitoring and quality management, GIS and remote sensing, and international cooperation to build institutional expertise.

The high-level meeting was attended by senior officials and ministers responsible for water resources and related sectors from Arunachal Pradesh, Meghalaya, Mizoram, Manipur, Tripura and Nagaland, under the ministry of Jal Shakti. # Sensex tanks 821 pts on FII selling, weak global trends Rupee slips 1 paisa to fresh all-time low of 84.39 against US dollar

Investors lose over ₹5 lakh cr in single day

MUMBAI, Nov 12: Benchmark BSE Sensex tumbled by nearly 821 points or more than 1 per cent and broader Nifty plunged below 23,900 level on Tuesday due to heavy selling in banking, power and auto shares and sluggish global trends.


The 30-share Sensex tumbled 820.97 points or 1.03 per cent to settle at 78,675.18 with 25 of its constituents ending lower and five higher. During the day, it plunged 948.31 points or 1.19 per cent to 78,547.84.

Falling for the fourth day running, the NSE Nifty tanked 257.85 points or 1.07 per cent to close at 23,883.45. As many as 46 Nifty stocks closed lower and four higher.

Investors' wealth eroded by ₹ 5.29 lakh crore to ₹ 437.24 lakh crore (USD 5.18 trillion)

From the 30-share Sensex pack, NTPC, Asian Paints, HDFC Bank, State Bank of India, Tata Motors, JSW Steel, Maruti and Power Grid were among the major laggards.

On the other hand, Sun Pharma, Infosys and ICICI Bank were the gainers. "FII-triggered selling pressure continued to impact the domestic market. The recent



strengthening of the dollar, driven by aggressive 'Trumponomics' is adding fears," Vinod Nair, Head of Research, Geojit Financial Services said

Foreign institutional investors offloaded equities worth ₹ 2,306.88 crore on Monday, while domestic institutional investors infused ₹ 2,026.63 crore in shares, according to exchange data.

MUMBAI, Nov 12: The rupee growth slowed down to 3.1 per cent in September from 6.4 per fell 1 paisa to a new lifetime low of 84.39 against the US dollar on Tuesday as persistent foreign fund outflows and a strengthening greenback against major crosses overseas dented investor sentiments.

Forex traders said the rupee is likely to trade between 83.80 and 84.50 in the medium term, with the Reserve Bank of India likely limiting any significant downside, aided by its robust foreign exchange reserves.

At the interbank foreign exchange, the rupee opened at 84.39 against the US dollar. During the session, the local currency touched a high of 84.38 and a low of 84.41. It finally settled at 84.39, a decline of just 1 paisa against the US currency, registering the loss for the fifth straight session.

On Monday, the rupee dropped 1 paisa to hit a new lifetime low of 84.38 against the US dollar.

In the last five sessions, the local unit has lost 32 paise against the greenback. "The rupee traded

weaker as foreign funds continued

their selling spree in the Indian market. However, the rupee received some relief from falling crude and gold prices, as the reduced pace of decline could potentially improve India's import bill in the coming months," said Jateen Trivedi, VP Research Analyst -Commodity and Currency, LKP Securities. Despite this, the dollar index's continued strength above

105 is expected to maintain pressure on the rupee, limiting any significant recovery in the near term. "With resistance near the 84.25-

84.30 zone and support is seen lower at 84.55. This week's focus will be on the US CPI data release, which could influence the dollar's trajectory. Additionally, US Fed Chairperson Jerome Powell's upcoming speech is expected to provide insights that may drive price action in the dollar, currently trading at a four-month high of 105.75," Trivedi said.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.06 per cent higher at 105.60. Brent crude, the global oil benchmark, rose 0.60 per cent to USD 72.26 per barrel in futures trade.

In the domestic equity market, the 30-share BSE Sensex fell 820.97 points, or 1.03 per cent, to close at 78,675.18 points, while Nifty fell 257.85 points, or 1.07 per cent, to settle at 23,883.45 points.

Foreign Institutional Investors (FIIs) were net sellers in the capital markets on Tuesday, as they offloaded shares worth Rs 3,024.31 crore, according to exchange data.

"The rupee traded almost flat in a narrow range but was seen touching a new record low around 84.42 while the Indian central bank continued to sell dollars supporting the rupee. It was also pressured by a Chinese Yuan-led decline in Asian currencies," said Maneesh Sharma, AVP - Commodities & Currencies. Anand Rathi Shares and Stock Brokers

## Inflation soars to 14-month high of 6.2 pc in Oct, breaches **RBI's tolerance level**

flation breached the Reserve Bank's upper tolerance level, soaring to a 14-month high of 6.21 per cent in October mainly on account of rising food prices.

Inflation based on the consumer price index (CPI) was 5.49 per cent in September and 4.87 per cent in the year-ago month.

Retail inflation trended below the RBI's upper tolerance band of 6 per cent since September last year. It was at 6.83 per cent in August 2023.

The RBI, which mainly factors in the CPI while arriving at its bimonthly monetary policy, has been tasked by the government to ensure retail inflation remains at 4 per cent with a margin of 2 per cent on either side.

According to the data released by the National Statistics Office (NSO) on Tuesday, inflation in the food basket increased to 10.87 per cent in October, compared to 9.24 per cent in September and 6.61 per cent in October 2023.

The Samaguri assembly constituency has witnessed sporadic pre-poll violence with supporters of BJP and Congress clashing with each other on several occasions. On late Saturday night when suspected armed criminals opened fire on a BJP march that included Barhampur MLA Jitu Goswami, injuring at least three people. Attackers targeted BJP politicians taking part in the march, including MLA Goswami, in the Moriputhi neighbourhood of Samaguri.

According to witnesses, the attackers first pelted stones at the participants before striking them with sticks. Three people were then hurt when unidentified persons opened fire on the group. The attack also caused some damage to Goswami's car. Reacting to the incident, chief minister Himanta Biswa Sarma aimed at the Congress party alleging that the opposition party which does photo-op with the Constitution is actually resorting to violence and attacking the BJP workers. Sarma claimed that Congress has resorted to violence not because of fearing defeat in the elections but because its fundamental vote bank has made the opposition workers do such extreme things. # Eastern India better insured to handle postretirement blues than rest of country, says study

KOLKATA, Nov 12: People in Eastern India are better prepared to take on retired life than their counterparts in the country's North, South or West, thanks to their enhanced saving propensity for their future, a study reveals.

According to the findings of the fourth edition of the India Retirement Index Study (IRIS), conducted by Max Life Insurance Company in partnership with KANTAR, a marketing data and analytics company, East India outshone other regions, scoring an impressive 54 on the Retirement Index, significantly higher than North and South India, both at 48, and West India at 49, as well as the national average of 49.

India retirement index is the degree to which Indians feel prepared for retired life on a scale 0 to 100. It is based on how prepared the country is for a healthy, peaceful and financially independent post-retirement life, surveyors explained. The survey, according to officials, is aimed at understanding the retirement readiness of urban India, with insights into awareness, aspirations and challenges of consumers during retirement and its planning.

The study further revealed that about 72 per cent of East Indians are investing specifically for retirement even as 82 per cent of the region's investors were confident about maintaining their health through retirement.

The corresponding retirement investment figures for West, North and South India stood at 66 per cent, 60 per cent and 58 per cent respectively, officials said.

The investment figures for retirement in the eastern region rose by a significant 5 per cent compared to 67 per cent last year and life insurance remained the preferred financial product, with 68 per cent choosing it for retirement security, the IRIS 4.0 study revealed.

Notably, East India also led in National Pension System (NPS) ownership, with nearly one in four holding an NPS account. Financial prod-



uct awareness among the respondents from the region was also high, with 97 per cent of individuals aware of life insurance and about 90 per cent having awareness of health insurance, the study found. The East India survey was conducted across six urban hotspots Ranchi, Jamshedpur, Patna, Cuttack, Guwahati and Kolkata during June-July this year amid respondents belonging to the age group of 25-65 years, officials said, while claiming that the countrywide survey was conducted across 28 cities.

The IRIS findings, highlighting a "strong shift in retirement readiness among the respondents in East India", claimed that around 56 per cent advocated for retirement planning before turning 35 years of age and that 94 per cent among those over 50 expressed regret for not starting earlier.

"Retirement planning is becoming increasingly important for Indians, especially given rising life expectancy. It's encouraging to see people in the region prioritizing financial stability, health, and emotional well-being by starting to plan early," said Rahul Talwar, EVP & Chief Marketing Officer, Max Life.

On the issues of retirement-related anxieties, the study finds that basic needs and child support decreased in the region with fewer people worried about meeting basic requirements (62 per cent) and children's futures (64 per cent).

Health awareness, the study claims, remains strong in the East with 82 per cent of respondents confident about staying healthy through retirement. An increase in regular health checkups also demonstrated a proactive approach to health management, the findings stated.

However, despite the robust emotional security expressed by people in the region, with nearly 95 per cent respondents expressing confidence in the support of family and friends during retirement, feelings of loneliness persisted among a significant section with some 64 per cent of people expressing concerns about it, and 76 per cent sharing worries about changing environmental factors, such as global warming and pollution, which could affect retired life.

In East India, one in every four individuals still feels that during retired life, they will have to depend on other family members, the IRIS data claimed. The survey also revealed that as many as one in every three East Indians prioritized medical needs and children's future in their retirement plans with an overwhelming majority of respondents wishing to live close to their children post-retirement, reinforcing the importance of familial support even within nuclear households.

"The findings offer a deeper understanding of evolving retirement needs and priorities, and we believe they will inspire a more proactive approach to holistic retirement planning across the country," Talwar maintained.

These findings, officials believe, will guide the insurance sector to create tailored, innovative solutions that address both the financial and health aspects of retirement. "Moving forward, our focus will be on building more awareness around early planning, enhancing retirementspecific products, and driving initiatives that foster comprehensive well-being-financial, physical, and emotional-during the golden years," Talwar added. (PTI)

## Trump's foreign policy and India

Tew US President-elect Donald Trump's foreign policy in 2017 already hinted at his interest in a more assertive Indo-Pacific Strategy (IPS), deviating from the previous administration's European-centric approach. While maintaining traditional ties with NATO, Trump prioritized building alliances in Asia, motivated by his focus on countering China's economic expansion and geopolitical influence. Unlike previous American leaders, Trump's stance was clear and uncompromising-China was not only a competitor but a threat to US dominance, both economically and militarily. One unique factor in Trump's policy shift is his personal rapport with Prime Minister Narendra Modi. The two leaders share an ideological affinity, particularly in their approach to nationalism and economic self-reliance. Trump's administration would see numerous influential positions occupied by individuals of Indian descent, further strengthening this South Asian alliance. India's geographic and economic significance, coupled with the Bay of Bengal's vast mineral wealth, provides a strategic advantage for the US in exerting influence across the region. By aligning more closely with India, Trump sought to establish a powerful counterbalance to China in the Indian Ocean and beyond. Trump's "America First" policy fundamentally reshaped US foreign policy to emphasize domestic economic interests. The Indo-Pacific region, through which around 70% of global trade flows, became crucial to this agenda. As a key player in securing international sea lanes, India emerged as a valuable ally for the United States. With a strong naval presence in the Indian Ocean, India will be the US's main partner of its influence in the region to counter a massive Chinese military presence in South China Sea and Indian Ocean.

Under Trump, this partnership with India is expected to deepen, as Washington increasingly viewed New Delhi as a vital anchor for security and stability in Asia. Trump's second term would likely be more assertive than his previous "soft" approach, with increased American support for India in military and strategic sectors. For both countries, this partnership holds the potential to act as a substantial deterrent to China's geopolitical ambitions and solidify the US-India alliance as a cornerstone of the Indo-Pacific strategy. Trump's re-election, however, would create ripples in the South Asian political landscape, particularly for Bangladesh. While some analysts claim that a second Trump presidency would have minimal impact on Dhaka-Washington relations, there are clear indications that such assumptions could be grossly

Trump's administration may also seek to forge alliances with nonstate actors like the Arakan Army in Myanmar, potentially enabling support for the creation of a Christian state in the South Asian region. Such developments could have destabilizing consequences for Bangladesh, potentially drawing it deeper into the complex interplay of regional politics and US strategic interests. The US-India relationship, characterized by both military collaboration and economic synergy, is a powerful counterweight to China's ambitions in the Indo-Pacific. Trump's policies have set the stage for a new chapter in US-South Asia relations, where India is not only a friend but a partner in safeguarding stability and promoting mutual prosperity across the region. For these reasons, New Delhi appears poised to replace London as America's preferred ally, underscoring the significance of the Indo-Pacific region in today's geopolitical landscape.

#### Chief Justice Chandrachud: A Quality of education in rural Assam tenure of progress and contention

he quality of education in rural Assam is a topic that demands close attention due to

quality of education in rural Assam is the socio-economic background of the students. Many children in these areas come from families living below the poverty line. These families often prioritize survival and stability over education. which leads to irregular attendance and high dropout rates. For many children, particularly in agricultural communities, the expectation is to help with farming or other labor activities rather than attend school regularly. This results in an unstable learning environment, where children attend school sporadically. missing out on critical parts of their education. The constant disruption in schooling makes it difficult for children to keep up with their peers, leading to frustration and eventual disengagement from the educational

books, notebooks, and writing instruments are often in short supply. Many schools do not have access to libraries or laboratories, which are essential for a well-rounded education. This lack of resources severely limits the opportunities for students

schools, through parent-teacher associations or community-led initiatives, could help bridge the gap between schools and the communities they serve. When parents and community members are involved in their children's education, they are

While strides have been made over the years, the current situation reveals significant gaps that must be addressed to ensure that children in these areas receive an education that equips them for the future. Understanding these issues requires a comprehensive look at the social, economic, and infrastructural factors that define the educational landscape of rural Assam.

In rural Assam, schools are often the primary source of formal education for children. However, the physical infrastructure of these schools is frequently inadequate. Many schools operate with poorly maintained buildings, insufficient classrooms, and a lack of basic amenities such as clean drinking water, electricity, and proper sanitation facilities. These conditions create an environment that is not conducive to learning. Students are often crammed into small, overcrowded classrooms, with little access to the materials they need to succeed. For many students, this is their first introduction to formal education, and the quality of their learning experience is severely hampered by these substandard conditions.

Teacher shortages are another significant issue in rural schools. While urban areas may have a more robust pool of qualified teachers, rural schools often struggle to attract and retain skilled educators. The lack of trained teachers means that many schools operate with a limited staff, resulting in a situation where one teacher is responsible for teaching multiple grades or subjects. This not only affects the quality of instruction but also leads to teacher burnout and high absenteeism.

In some cases, schools may even rely on teachers who are not properly qualified or trained, further diminishing the standard of education. For students, the lack of consistent, quality instruction leads to significant gaps in their learning, which become more apparent as they progress through their educational journey.

One of the key issues affecting the

process. Another important factor to consider is the curriculum. The curriculum in rural schools is often designed with a uniform approach that does not take into account the specific needs and challenges of rural communities. The content of the curriculum may be irrelevant to the lives of rural students, particularly those who come from farming or tribal backgrounds. For these students, the knowledge they gain in school may seem disconnected from the realities of their daily lives, making it difficult for them to see the value in education. This disconnect between the curriculum and the students' experiences contributes to low levels of engagement and motivation among rural children.

The language of instruction in rural schools also presents a challenge. While Assamese is the predominant language of instruction in most schools, many students come from households where tribal languages or dialects are spoken. This language barrier can make it difficult for children to fully comprehend lessons, particularly in the early years of schooling. The lack of bilingual education or mother-tongue instruction further alienates these children, making it harder for them to excel academically. This language divide is a significant contributor to the poor educational outcomes in rural areas, as students struggle to understand lessons that are not delivered in a language they are comfortable with.

In addition to these structural and socio-economic challenges, rural schools in Assam also suffer from a lack of adequate resources. Basic educational materials such as text-

to engage in hands-on learning or to explore subjects like science and technology, which are critical for their future development. Without access to these materials, students are confined to rote learning and memorization, which stifles creativity and critical thinking.

Technology, which has the potential to bridge some of the educational gaps in rural areas, is also largely absent from rural schools in Assam. While urban schools may have access to computers, the internet, and other digital learning tools, these resources are virtually nonexistent in rural schools. The digital divide between urban and rural areas is stark, and it exacerbates the existing inequalities in the education system. For students in rural areas, the lack of access to technology limits their exposure to new ideas and information, putting them at a disadvantage when compared to their urban counterparts.

Despite these challenges, there are initiatives in place aimed at improving the quality of education in rural Assam. Government schemes such as Sarva Shiksha Abhiyan (SSA) and Rashtriva Madhvamik Shiksha Abhiyan (RMSA) have been instrumental in increasing enrollment rates and improving infrastructure in some rural areas. These programs focus on providing universal access to education and improving the learning environment in government schools. However, the implementation of these programs has been uneven, and many rural schools still lack the resources and support needed to make significant improvements. Corruption, mismanagement, and delays in the disbursement of funds have also hindered the progress of these schemes, limiting their impact on the ground.

Community involvement is another factor that could play a significant role in improving the quality of education in rural Assam. In many rural areas, parents and community members are not actively engaged in the educational process. This lack of involvement is partly due to the low levels of literacy among parents, who may not see the value in education or feel equipped to support their children's learning. Encouraging greater community participation in more likely to support their attendance and encourage them to succeed.

Addressing the quality of education in rural Assam will require a multi-faceted approach. Improving infrastructure is a critical first step, ensuring that schools have the basic amenities needed to provide a safe and conducive learning environment. Equally important is the need to address the shortage of qualified teachers by offering incentives to attract skilled educators to rural areas and providing ongoing professional development to improve the quality of instruction. The curriculum also needs to be re-evaluated to ensure that it is relevant to the lives of rural students, taking into account their socio-economic backgrounds and cultural experiences. In addition, greater investment in educational resources, including textbooks, technology, and extracurricular activities, is essential to providing a more holistic education for rural

children. Ultimately, improving the quality of education in rural Assam is not just about increasing literacy rates or achieving enrollment targets. It is about ensuring that every child, regardless of their background or where they live, has access to an education that equips them with the skills and knowledge they need to succeed in life. This will require a concerted effort from the government, educators, and communities to work together towards a shared goal of providing high-quality education for all.

Without this commitment, the children of rural Assam will continue to face significant barriers to achieving their full potential, and the state as a whole will struggle to realize its development goals. By recognizing the specific challenges that rural communities face and tailoring educational policies and programs to meet their needs, Assam can create a more inclusive and equitable education system. This, in turn, will help to close the gap between rural and urban areas, ensuring that every child has the opportunity to receive a quality education, regardless of where they live. rachud s tenure coi L cluded on November 10, 2024, his impactful decisions are being scrutinised for the lasting influence they have had on India's legal and social landscape. Appointed as the 50th Chief Justice of India on November 8, 2022, Chandrachud participated in more than 700 judgments during his judicial career, authoring, concurring, and dissenting in significant cases. His tenure stands out as one of the most dynamic in recent years, marked by transformative judicial reforms, pivotal rulings, and a steadfast commitment to constitutional rights. His focus on reshaping the judiciary to be more accessible, transparent, and technologically progressive was notable, although it was not without controversies and criticisms.

A major theme of Chief Justice Chandrachud's time in office was his commitment to individual rights and democratic principles, particularly the right to free speech and dissent. Under his leadership, the Supreme Court often reinforced the importance of these fundamental rights, especially in cases involving allegations of government overreach. His stances on sedition laws and colonial-era restrictions showcased his dedication to curbing state-imposed censorship and protecting civil liberties.

Chandrachud was a proponent of modernising the judiciary, advancing digitalisation and the use of virtual court proceedings to enhance accessibility. His push to streamline court processes and address case backlogs was part of a broader effort to make justice more efficient and inclusive, particularly for underprivileged communities. His vision of a technologically adept judiciary laid a foundation that future Chief Justices can build upon.

Despite these advancements. the issue of case pendency remained significant, with nearly 83,000 cases still pending in the Supreme Court as of August 2024. This issue, though not entirely within his control, highlighted the challenges of the Indian justice system.

One of the most significant rulings during his tenure involved the contentious matter of electoral bonds. The Supreme Court under Chandrachud ruled poll bonds to be illegal, addressing the problematic nature of anonymous political donations. While this verdict exposed the flawed premise of donor anonymity, it did little to alter the status quo, as political parties, both major and minor, continued to benefit from such funds de-

spite the ruling. Chief Justice Chandrachud also faced scrutiny over his handling of certain politically sensitive cases, particularly those related to state surveillance and alleged abuses of power. His perceived reluctance to prioritise these cases led some to question his willingness to confront government authorities. This criticism cast a shadow over his otherwise resolute stance on judicial independence. Efforts to bring transparency to the collegium system - a long-standing point of contention - were met with mixed reactions, suggesting that comprehensive reform in this area remained incomplete. A particularly long-standing case during his tenure was the question of the minority status of Aligarh Muslim University (AMU). The Supreme Court's seven-decade-long legal entanglement over AMU's status,

originating from a 1967 decision

that struck down its minority

classification, continued to pose

challenges. The recent 4:3 ma-

jority ruling by a seven-judge

bench clarified principles sup-

porting AMU's minority status

but left the ultimate decision

pending before a regular bench,

for a definitive resolution. This drawn-out process highlighted the broader issue of delayed legal clarity in the Indian judicial system. Chandrachud's legacy also reflects the challenges inherent in

prolonging the university's wait

balancing bold reforms with institutional continuity. While he championed changes to modernise and improve the judiciary, he may have refrained from "rocking the boat" too much in some cases.

The high expectations associated with his tenure - being the son of a former Chief Justice were not wholly met, as critics argue that the judiciary's role in curbing state power and upholding democratic norms fell short in certain areas.

Despite these criticisms, Chandrachud's commitment to progressive interpretations of the law, technological modernisation, and judicial accessibility represents significant contributions to India's legal landscape. However, his term also serves as a reminder that judicial change often encounters inherent limitations, whether due to systemic inertia or external pressures.

In conclusion, Chief Justice DY Chandrachud's tenure will be remembered as a period marked by substantial advancements and enduring challenges. His focus on rights-based judgments, judicial independence, and technological innovation has left a blueprint for future leaders of the judiciary. Yet, the unresolved issues and criticisms that emerged during his time reflect the complex realities of leading the Supreme Court in a nation marked by deep social, political, and institutional divides. # **Conditions of employment for** women in India gradually worsening

ue to declining scope of job opportunity in the organised and formal sector, women workers in India have been increasingly trying hard even to find a place in the unorganised and informal sectors sans social security. Periodic Labour Force Survey (PLFS) 2023-24 for the period of July 2023 - June 2024 shows that their participation in the non-agriculture informal sector has been rising and stood at 61.2 per cent as against 58.4 per cent in 2021-22 on the usual status basis.

During this period, percentage of women engaged in the informal sector on usual status basis rose from 55 per cent in the urban areas in 2021-22 to 56.5 per cent in 2023-23. In rural areas, it rose from 61.6 per cent to 65.5 per cent.

Working conditions for women workers were also very bad with 57.3 per cent of them had no written job contacts even when they were engaged as regular wage or salaried employees. In urban areas, 59 per cent of female workers and in rural areas 54.6 per cent had no written job contracts.

Percentage of regular/salaried female employees not eligible for paid leave were 45.9 per cent in 2023-24, more than 43.5 per cent in 2022-23. The deterioration was more pronounced in the rural areas where it rose from 41.9 per cent in 2022-23 to 47.1 per cent in 2023-24. In urban areas, it rose from 44.6 per cent to 45.2 per cent during this period.

The average earning for the female casual workers were much less than the male workers in all the four quarters of the survey year (July to June). Female workers eared ₹ 293 in the first three quarters per day, which rose to only ₹ 306 per day in the last quarter. As against this, male casual labours earned ₹ 439 in the first quarter, ₹ 451 in the second and third quarter and  $\gtrless$  459 in the fourth quarter.

In the fourth quarter, female workers in the urban areas earned ₹ 364 per day and in rural areas ₹ 299 per day, while male workers earned ₹ 537 and ₹ 444 respectively.

As for the self-employed women are concerned, they earned ₹ 5803 per month in the last quarter as against ₹ 16,723 earned by male workers in the 4thquarter of the assessment

year. In urban areas self-employed women earned ₹ 8492 per month as against ₹ 23480 per month by their male counterpart. In rural areas, female self-employed workers earned ₹ 5218 as against ₹ 14564 per

month by males. Female labour force participation rate (FLFPR) on CWS (current weekly status) was still only at 27.1 per cent in 2023-24, which was 23.7 per cent in 2022-23, and only 20.5 per cent

in 2021-22. In urban areas FLFPR was 20.8 per cent and in rural areas it was 29.6 per cent in 2023-24. Female workers population ratio (FWPR) in 2023-24 on

CWS basis was only 25.7 per cent – in urban areas 19 per cent and in rural areas 28.4 per cent. The data for percentage distribution of female workers in

usual status basis shows that in 2023-24, self-employed female workers were 67.4 per cent -42.3 per cent in urban areas and 73.5 per cent in rural areas. Out of these self-employed women 30.7 per cent were own account worker and employer while 36.7 per cent were helper in household enterprise.

Own account female workers

urban areas were 28.5 per cent while only 13.8 per cent were helper in household enterprises. These figures for rural areas were 31.2 per cent and 42.3 per cent respectively.

It was a very pathetic condition for female workers that only 15.9 per cent of them were in regular wages / salaries - 49.4 per cent in urban areas and only 7.8 per cent in rural areas. Female casual labour in India were 16.7 per cent in 2023-24 - 8.3 per cent in urban areas and 18.7 per cent in rural areas.

PLFS 2023-24 shows that 64.4 per cent female workers were engaged in agriculture, 0.1 per cent in mining & quarrying, 11.6 per cent in manufacturing, 0.2 per cent in electricity and water etc, 3.7 per cent in construction, 6.1 per cent in trade, hotel and restaurant, 1.1 per cent in transport, storage and communications, and 13 per cent in other services.

Unemployment rate among female workers on CWS basis was 5 per cent in 2023-24 - in urban areas it was 8.7 per cent and in rural areas it was 3.9 per cent.

The current PLFS (2023-24), however, does not present the and employer in 2023-24 in other aspects of women labour

and workforce in the country such as Army, Navy and Air Force employed only 3.97%. 6% and 13.69%. A Rajya Sabha reply in 2023 said that total number of women judges in the Supreme Court and High Courts were 3 and 111, respectively. This is about 10% and 14% of the total number of judges appointed in both the judicial bodies, respectively.

Women in police force in 2020 were 10.3 per cent. In 2023, there were 14 per cent women in parliament and only 9 per cent in state assemblies. MSMEs employ 20 per cent women while 20.5 per cent women own MSMEs.

Highest share of women is in agriculture at 63 per cent, while among MNGREGA workers 57 per cent are women. A total of 53 per cent women workforce are in unorganised sector. A NITI Aayog report says that 80 per cent of rural women are engaged in agriculture and their total share in agriculture work is 63 per cent.

It is therefore imperative that India must focus on encouraging women in getting quality, salaried and regular jobs, if the country really wants to empower women. (IPA Service)

# The cyber world poses a threat to the safety and dignity of women

he rise of artificial intelligence-generated content has further aggravated the challenges faced by women in the digital space, leading to new forms of online harassment and privacy violations. This has called for urgent action by both tech companies and governments. Today, when threats to women in the cyberspace have multiplied, there is no safe haven left where they can hide or a heavily guarded area where they can sit and wait for the cyber threats that threaten their dignity to end. A global survey has revealed that 60 percent of girls and women have faced harassment on social media platforms, and about 20 percent of them have either said goodbye to social media or reduced its use due to this.

Similarly, UN Women has found that 58 percent of women and girls worldwide have been subjected to some form of online abuse. These include trolling, stalking, doxing, and other forms of online predatory behavior based on gender, which are emerging as new threats of the digital age. Artificial intelligence is being used to create deepfake videos and images

that target women with fabricated content that is often sexual or defamatory in nature. U.S. Vice President Kamala Harris faced deepfakes depicting her in false and harmful contexts during her campaign for the 2024 presidency. Artificial intelligence tools spread false narratives or misogynistic content designed to undermine the character and credibility of women, particularly targeting women in leadership roles. Nikki Haley was a victim of manipulated images and fake news during the Republican primaries. Women face a disproportionate level of objectification and sexually explicit content online, amplified by artificial intelligence's ability to create realistic fake content.

Explicit photos of Italian Prime Minister Giorgia Meloni created by artificial intelligence circulated widely on social media. Deepfakes and altered images created by artificial intelligence violate women's privacy, often resulting in significant reputational damage and mental distress. Bangladeshi politician Rumin Farhana was targeted with deepfake content ahead of elections. Steps to mitigate the problem by tech companies and governments. Companies should invest in advanced ar-

tificial intelligence detection systems to proactively flag and remove harmful content before it is widely disseminated, with human monitoring to prevent errors. Meta (Facebook) recently announced artificial intelligence tools to combat deep fakes, but their implementation remains inconsistent. Platforms must provide clear accountability measures and report how they handle flagged content with transparent audits of their moderation policies.

The EU Digital Services Act (2022) mandates digital platforms to report content moderation actions. Tech companies need to ensure that algorithms are designed in a way that reduces gender bias and prevents misuse of artificial intelligence tools for harmful purposes. The Google artificial intelligence principles highlight the responsible use of artificial intelligence, but more implementation is needed. Governments should enact data protection laws and create specific legal provisions to address the misuse of AIgenerated content, including deepfakespecific laws.

India's Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules 2021 provide a frame-

work for content moderation but lack stringent AI-specific regulations. Governments should establish AI ethics boards and frameworks that mandate ethical AI development, with a focus on preventing gender-based discrimination. The EU's Artificial Intelligence Act aims to regulate high-risk AI systems, especially in media and surveillance. Governments should launch public awareness campaigns to identify and report deepfake content, par-

ticularly targeting vulnerable groups. India's National Cybercrime Reporting Portal facilitates easy reporting of cybercrimes involving AI-generated content. Tech companies should be held accountable through monetary penalties if they fail to remove harmful content within a stipulated time frame. The GDPR in the European Union allows for heavy fines on companies that fail to protect users from data misuse. A proactive, multilateral approach between governments, tech firms, and civil society will ensure the creation of safer digital spaces for women, promote ethical AI development, and ensure robust online security. # Pollution affects Beauty

ndia's air pollution levels are rising; the seasonal spike combined with pollutants emitted by factories, cars, construction materials and seasonal agriculture practices like crop stubble burning is intensifying the air pollution crisis in the country this season like in previous years.

Living in a bustling city offers countless opportunities, but it comes with a price - pollution. And urban lifestyles can take a toll on your skin.

The rising air pollution has become a buzzword nowadays and is affecting the normal functioning of life due to toxic air and a heavy blanket of smog.

Pollution breaks down collagen and oxidizes the lipid layer in the skin, which impairs skin-barrier function. Smog particles are generally too large to penetrate the skin, but they can disturb the barrier, resulting in dehydration, sensitivity, uneven skin tone, dullness, acne, and premature aging. Airborne pollutants on human skin can contribute to skin cancer, skin aging, atopic dermatitis, skin discoloration, eczema, psoriasis, and can be absorbed through the skin into the body, causing a wide range of diseases.

Pollution breaks down collagen and oxidizes the lipid layer in the skin, which impairs skin barrier function.

Highly toxic air containing smoke, soot, acid, and other pollutants severely affects the skin by draining away skin moisture which leads to allergies and pigmentation spots on the forehead and cheeks on dry and rough skin.

The toxic haze hanging in the sky cause uneven skin tone, accelerated ageing, wrinkles, and black spot on the face For many living in big cities like in Metropolitian cities it is completely unavoidable so it is matter of reducing exposure, repairing the damage and protecting it as much as possible.

Among the other organs of the body, the skin is also one of the first to bear the brunt of air pollutants, which not only attack the skin's surface but also lead to an accumulation of toxins. In fact, they are potent skin irritants. There are both long and short-term effects of pollutants. Chemical pollutants cause oxidation damage and this can lead to the manifestation of premature ageing signs on the skin, like wrinkles, loss of elasticity, dark patches, spots, etc. Chemical pollutants also disrupt the normal balance of the skin and scalp, leading to problems like dryness, sensitivity, rashes, acne, irritation or allergic reactions, dandruff, and related conditions. They also make the skin and hair dull, lacking vitality. All of us who live and work in urban areas need protective beauty care, whether we are housewives or working women. Of course, for working women, the job may involve traveling

long distances to work. The skin is thus more exposed to the pollutants in the air.

Cleansing of the skin assumes more importance in order to get rid of the impurities and pollutants that are deposited on the skin. If you have dry skin, use a cleansing cream or gel. Deep clean the skin at night, neutralize it with antioxidants and create a barrier with sunscreen. Include antioxidants in your diet and skincare regime. Citrus fruits contain Vitamin C, E, and limonene which lower the risk of cancer and protect your skin from damage. Avoid cleansers containing Sodium lauryl sulphate and sodium laureth sulphates or denatured alcohols as they dry out the skin and can damage our skin barrier over time. Use skincare rich in antioxidants. Pamper your skin with sheet masks or hydrating overnight masks to repair the damage.

For oily skin, cleansing milk or face wash may be used. For oily skin, also use a facial scrub after cleansing. Look out for products with ingredients like sandalwood, eucalyptus, mint, neem, tulsi, aloe vera, etc., when you buy cleansers. The anti-toxic and tonic properties of such ingredients have helped in clearing the skin congestion and eruptions that result from exposure to chemical pollutants. Aloe vera, for example, is

also a powerful moisturizer and an anti-oxidant. So are ingredients like apricot kernel oil, carrot seed, wheatgerm oil, etc. the skin needs to be protected. If the skin is prone to eruptive conditions like acne, pimples, or rash, it should be protected with specialized creams that not only protect but also reduce oiliness and deal with the problem. After cleansing, wipe the

skin with a rose-based skin tonic or rose water, to com-

plete the cleansing process and refresh the skin. Soak cotton wool in chilled rose water and tone the skin with it, patting briskly. It also improves blood circulation to the skin's surface and adds a glow. Green tea also makes a good skin toner. If there is a rash or eruptions, add a little rose water to the sandalwood paste and apply it to the face. Wash off with plain water after 15 minutes.

Anti-pollution cosmetics help to provide protection and reduce the damage caused by environmental effects. These are basically "cover creams" that form a barrier between the skin and pollutants. Sandalwood protective cream is very useful to protect the skin from environmental effects. It forms a transparent protective cover. Sandalwood soothes the skin and protects it from irritative reactions and eruptive conditions. It suits all skin types and increases the skin's moisture retention ability too.

The hair also needs frequent washing if one regularly travels long distances for their work. Pollutants also collect on the scalp. Shampoo, hair rinses, serums, and conditioners help to restore normal balance if they contain ingredients like amla, Brahmi, Triphala, bhringaraj, and henna. They also coat the hair and form a protective cover. Mix one teaspoon each of vinegar and honey with one egg. Massage the mixture lightly into the scalp. Leave on for half an hour and then wash the hair. Rinse well with water.

Or, give the hair hot oil therapy. Heat pure coconut oil and apply it to the hair. Then dip a towel in hot water, squeeze out the water and wrap the hot towel around the head, like a turban. Keep it on for 5 minutes. Repeat the hot towel wrap 3 or 4 times. This helps the hair and scalp absorb the oil better. Leave the oil on

# Aid groups say Israel misses US deadline to boost humanitarian help for Gaza

JERUSALEM, Nov 12: Israel has failed to meet United States demands to allow greater humanitarian access to the war-ravaged Gaza Strip, where conditions are worse than at any point in the 13-month-old war, international aid organisations said on Tuesday.

The Biden administration last month called on Israel to "surge" more food and other emergency aid into Gaza, giving it a 30-day deadline that was expiring on Tuesday. It warned that failure to comply could trigger U.S. laws requiring it to scale back military support as Israel wages war against Hamas in Gaza and Hezbollah in Lebanon.

Israel has announced a series of steps toward improving the situation. But U.S. officials recently signaled Israel still isn't doing enough, though they have not said if they will take any action against it.



U.S. State Department spokesman Matthew Miller last week said Israel had made some progress, but needs to do more to meet the U.S. conditions. "What's important when you see all of these steps taken is what that means for the results," he said

#### 35 killed, 43 injured as man rams car into crowd in Chinese city

BEIJING, Nov 12: Thirty-five people were killed and 43 others injured when a 62year old man rammed his car into a crowd in China's Zhuhai City on Monday, official media reported on Tuesday. Zhuhai is currently hosting China's prestigious airshow.

The 62-year-old driver, a divorced man identified as Fan, rammed his car at around 7:48 pm Monday, when citizens were exercising at the sports centre in Zhuhai City, about 2,200 kms south of Beijing, state-run Xinhua news agency quoted Zhuhai public security bureau as saying.

He was detained soon after the incident, Xinhua said. It was, however, not immediately clear whether it was an accident or an attack. Chinese President Xi Jinping has urged all-out efforts to treat the people injured in the car ramming case and also demanded punishing the perpetrator in accordance with the law, the Xinhua added.

While reports of the incident are widely censored in the official media, videos posted on X showed distressing visuals of bodies lying on the street with people crying for help. (PTI)

The chief prosecutor sent the letter to the Inspector General of Police on Tuesday, Bangla language daily Prothom Alo reported,

citing sources at the tribunal. The development comes two days after Law Affairs adviser Asif Nazrul on Sunday said Bangladesh will seek Interpol's assistance in repatriating Hasina from India and other "fugitives" to face trial for alleged crimes against humanity.

Hasina and her party leaders face accusations of ordering brutal suppression of the Anti-Discrimination Students Movement, resulting in numerous casualties during the July-August protests.

The movement later intensified into a large-scale uprising, forcing Hasina to flee to India on August 5. According to the interim government led by Chief Adviser Muhammad Yunus, at least 753 people were killed

and thousands injured during the protests, which it termed crimes against humanity and genocide

Interpol red notice for Sheikh Hasina, others

Over 60 complaints of crimes against humanity and genocide have been filed against Hasina and her party leaders with the ICT and the prosecution team till mid-October.

## North Korea ratifies major defence treaty with Russia

SEOUL, Nov 12: North Korea ratified major defense treaty with Russia stipulating mutual military aid, the North's state media reported on Tuesday, as the U.S., South Korea and Ukraine say North Korea has sent thousands of troops to Russia to upport its war

against Ukraine.

Russia had completed the ratification of the treaty last week after it was signed by Russian President Vladimir Putin and North Korean leader Kim Jong Un in June. It is considered both countries' biggest defense deal since the end of the Cold War.

The Comprehensive Strategic Partnership treaty will take effect when both sides exchange documents on the ratification, the state-run Korean Central News Agency said.

North Korea ratified the treaty through a decree signed Monday by the country's president of state affairs, KCNA said, using one of Kim's titles. North Korea's rubber-stamp parliament, the Supreme People's Assembly,

has the right to ratify treaties but Kim can unilaterally ratify major ones, according to South Korea's Unification Ministry.

The treaty requires both countries to use all available means to provide immediate military assistance if either is attacked. Some observers speculate the treaty's ratification in both countries could signal North Korea could formally enter the Russia-Ukraine war soon.

According to U.S., South Korean and Ukrainian intelligence assessments, up to 12,000 North Korean troops have been sent to Russia likely as part of the June treaty. Last week, Ukrainian officials said Ukraine and North Korean troops engaged in small-scale fighting while Ukraine's army fired artillery at North Korean soldiers in Russia's Kursk border region.

North Korea's troop dispatch threatens to escalate the almost three-year war. South Korea, the U.S. and their partners also worry about what Russia could give North Korea in return. Possible Russian transfer of sensitive technology to enhance North Korea's already-advancing nuclear and missile programs would be an alarming development for the U.S. and its allies.

North Korea and Russia have been significantly strengthening their military and other cooperation. South Korea's spy agency said last month that North Korea had sent more than 13,000 containers of artillery, missiles and other conventional arms to Russia since August 2023 to replenish its dwindling weapons stockpiles. Policeman arrested for facilitating suicide attack in Pak's Peshawar in 2023

PESHAWAR. Nov 12: A Pakistani policeman has been arrested for facilitating a lethal suicide bombing in the country's restive northwestern Peshawar city in 2023, which killed over 100 people, mostly policemen.

Inspector General of Police Akhat Hayat Khan Gandapur on Tuesday confirmed that Muhammad Wali alias Umar, a police constable from Peshawar, was the "main facilitator and target killer" of the January 30, 2023, attack in in a high-security Police Lines area.

More than 100 people, including 86 policemen were killed in the attack while 223 others were injured.

The provincial police chief said Wali was arrested in an intelligence-based operation from Jamil Chowk on Ring Road, Peshawar district. Wali, who confessed to facilitating the bombing, escorted the bomber, an Afghan national, into the Peshawar Police Lines area. (PTI)

BOSTON, Nov 12: A Massachusetts Air National Guard member who pleaded guilty to leaking highly classified military documents about the war in Ukraine is expected to be sentenced in federal court on Tuesday.

Prosecutors have argued that Jack Teixeira should be sentenced to 17 years in prison, saying he "perpetrated one of the most signif-

icant and consequential violations of the Espionage Act in American history

"As both a member of the United States Armed Forces and a clearance holder, the defendant took an oath to defend the United States and to protect its secrets — secrets that are vital to US national security and the physical safety of Americans serving overseas," prosecutors wrote. "Teixeira violated his oath, almost every day, for over a year." Teixeira's attorneys will argue that US District Judge Indira Talwani should sentence him to 11 vears in prison. In their sentencing

memorandum, they acknowledged

that their client "made a terrible decision which he repeated over 14 months." "It's a crime that deserves serious consequences," the attorneys wrote. "Jack has thoroughly accepted responsibility for the wrongfulness of his actions and stands ready to accept whatever punishment must now be imposed."

Teixeira, of North Dighton, Massachusetts, pleaded guilty in March to six counts of the willful retention and transmission of national defence information under the Espionage Act. That came nearly a year after he was arrested in the most consequential national security leak in years.

The 22-year-old admitted that he illegally collected some of the nation's most sensitive secrets and shared them with other users on the social media platform Discord.

When Teixeira pleaded guilty, prosecutors said they would seek a prison term at the high end of the sentencing range. But the defence wrote that the 11 years is a "serious

and adequate to account for deterrence considerations and would be essentially equal to half the life that Jack has lived thus far."

His attorneys described Teixeira as an autistic, isolated individual who spent most of his time online, especially with his Discord community. They said his actions, though criminal, were

never meant to "harm the United States." He also had no prior criminal record. "Instead. his intent was to educate his friends about world events to make certain they

were not misled by misinformation," the attorneys wrote. "To Jack, the Ukraine war was his generation's World War II or Iraq, and he needed someone to share the experience with." Prosecutors, though, countered

that Teixeira does not suffer from an intellectual disability that prevents him from knowing right from wrong. They argued that Teixeira's post-arrest diagnosis as having "mild, high-functioning" autism "is of questionable relevance in these proceedings." The security breach raised alarm over America's


ability to protect its most closely guarded secrets and forced the Biden administration to scramble to try to contain the diplomatic and military fallout. The leaks embarrassed the Pentagon.

to safeguard classified information and disciplined members found to have intentionally failed to take required action about Teixeira's suspicious behaviour.

102nd Intelligence Wing at Otis Air National Guard Base in Massachusetts, worked as a cyber transport systems specialist, which is essentially an information technology specialist responsible for military communications networks. Meanwhile, the ongoing indefinite hunger strike launched by the students of the university under the banner of the NEHU Students' Union (NEHUSU) and the KSU NEHU Unit continued which affected the functioning of NEHU.

The NESO blamed Shukla for the decline in the university's rankings. Prior to PS Shukla's term as VC, NEHU was consistently ranked within the top 60 universities nationally. However, under his leadership, the university's ranking has plummeted to range between 100-150, they claimed.

The VC on Monday convened a meeting of the university Executive Committee (EC) via virtual mode.

He alleged that since the joining of the current Vice Chancellor, all work in the university has been disturbed due to the lack of administrative and academic knowledge. As non-teaching employees who are directly involved in administrative duties are greatly frustrated due to the delay in the movement of files, the outcome of which is a delay in processing the regular works in the university, he added.

"It seems that the Vice Chancellor has come to this university to learn, which is not expected of the executive head," Dr Synrem said.

Stating that the interview for the statutory post(s) of the university was conducted in Guwahati, whereby the Vice Chancellor cited that it was due to the urgent need to fill these positions, the president of the associa-

tion said, "But to our utter disbelieve, the Controller of Examination which was included in the interview, was allowed to join 6 (six) months after the offer of appointment was made to him.' "Recently, a deputy registrar was ap-

pointed who has no knowledge of correct English, despite the University's medium of instruction being in English. This has also affected the day to day working of the administration," he added.

Further, Dr Synrem informed that the condition of the road on the campus is in a dilapidated condition, which was never the case since the inception of the university. This issue too has been discussed with the Vice Chancellor repeatedly, but no action has been taken till date.

He said that the quarters allotted to the employees are never maintained by the university and the occupants have to shell out from their own pockets for any minor or major repairs despite their House Rent Allowance (HRA) being deducted every month

Street lights, which are very important during the night, are not functioning, hence compromising the security and safety of the residents, including the students.

Moreover, Dr Synrem informed, "Recently, as per the RTI reply received, it clearly states that Compassionate Appointment in Government of India offices has never been discontinued; however, the university is yet to notify the same." (With inputs from PTI and NNN)

# Bodies of two Meitei men recovered in Manipur's Jiribam

IMPHAL, Nov 12: Bodies of two elderly men belonging to the Meitei community were recovered on compliance report Tuesday morning in Manipur's Jiribam district where a gunfight between suspected militants and security forces broke out a day before, police said.

Operations are underway to trace three women and three children, who have been reported missing since the violence erupted in Jiribam on Monday, IGP (operations) I K Muivah said.

The bodies of the two men -Laishram Balen and Maibam Kesho - were detected in debris during a search operation in Jakuradhor Karong area where a few shops were set on fire by suspected militants on Monday, another senior officer said.

"The two elderly men belonging to the Meitei community died after the insurgents torched a few shops in Jakuradhor Karong area." he



said. The Jiribam district administration imposed prohibitory orders to avoid any untoward incident in the area, the officer said.

A shutdown has been observed since 5 am on Tuesday in Kuki-Zo majority areas in the hills to protest against killing of suspected insurgents in the gunfight with security personnel, another police officer said

The Kuki-Zo Council called for

the state from 5 am to 6 pm on Tuesday to express their "collective grief and solidarity who were brutally shot dead"

The police had said 10 suspected militants were killed in the fierce gunfight with security forces on Monday after insurgents in camouflage uniforms, armed with sophisticated weapons, fired indiscriminately at a police station and an adjacent CRPF camp in a total shutdown in the hill areas of Jiribam district. However, a senior

officer had put the toll at 11.

Two CRPF personnel also sustained injuries during the heavy exchange of fire at Borobekra, and the condition of one of them was stated to be critical, another officer said.

The situation in Jiribam remained calm but tense on Tuesday morning with policemen patrolling at vulnerable points, he said.

Following the incident, fresh violence was reported from multiple places in Imphal Valley where armed groups from the two warring sides engaged in exchanges of fire, the state police said.

Locals and security forces recovered several improvised mortar shells in two villages of Imphal West district this morning, another officer said. Operations were continuing to flush out militants, and reinforcement teams, consisting of Assam Rifles, and CRPF, have been deployed in disturbed areas, he added. (PTI)



# Yogi Adityanath warns against division in Maharashtra

AMRAVATI, Nov 12: Uttar Pradesh Chief Minister Yogi Adityanath on Tuesday amplified his Hindu unity pitch at the Maharashtra hustings by improvising the 'Batenge to Katenge' phrase with 'Ek Hai To Safe Hai' caution.

Adityanath, who addressed a public meeting at Achalpur in Amravati for the November 20 assembly polls, accused the opposition Maha Vikas Aghadi of turning Maharashtra into a "base for love jihad and land jihad," warning that the western state should not become a "laboratory" (for such practices).

The UP CM drew sharp contrasts between the NDA alliance led by Prime Minister Narendra Modi and the MVA bloc comprising the Shiv Sena (UBT), Congress, and NCP (SP).

Referring to the historical division of India, Adityanath said, "Because you were divided, this country was divided, and Hindus were killed because they were divided. That is why I have come to tell you: don't get divided. 'Ek hain toh safe hain'

He also revisited the Ayodhya issue, asserting that Hindus faced 500 years of humiliation because they were divided.

"We were divided, and that is why we suffered. "Hum bate the islive kate the (Since we were divided, we fell)," the seer-turnedpolitician said.

Adityanath praised the resolution of the Ayodhya dispute, crediting Prime Minister Modi's leadership since 2014 and his own tenure as Chief Minister of Uttar Pradesh, which began in 2017, for the issue's eventual resolution.

"The Congress never wanted to resolve the Ayodhya issue, which was finally resolved in 2019 under Modiji's leadership," he added.

Adityanath said the new Bharat under PM Modi works for "sabka saath and sabka vikas" and guarantees everyone's safety and progress

"Don't make the mistake of Lok Sabha elections in Amravati. If you are divided again, the puja for Lord Ganesh will be attacked and lands here will be captured in the name of love and land jihad. The safety of women will be in jeopardy," he said.

In the 2024 general elections, the Congress won the Amravati constituency by defeating BJP nominee Navneet Rana by around 20.000 votes.

Adityanath said in Uttar Pradesh, there was no such issue

SOLAPUR, Nov 12: Prime Minister Narendra Modi on Tuesday said there is constant infighting within the opposition Maha Vikas Aghadi alliance in Maharashtra, with everyone fighting for the driver's seat. "You all are seeing how there is

a stampede in the Aghadi. There is a tug-of-war going on in the Aghadi for the post of chief minister," Modi said, addressing a rally in Solapur for the November 20 state assembly elections.

## Why has Centre neglected Maharashtra's sugar industry: Cong asks PM Modi

Minister Narendra Modi on Tuesday asking him as to why Maharashtra's Chakan industrial area is witnessing a mass exodus of manufacturing units and why has the Centre "neglected" the state's sugar industry.

Ahead of Modi's Pune visit, Congress General Secretary (In-charge, Communications) Jairam Ramesh posed three questions to the PM including why the BJP has ignored the Dhangar community's demand for ST status.

"Pune's Chakan industrial area is currently witnessing a mass exodus of manufacturing units due to problems caused by poor road infrastructure. Despite ongoing roadwork, basic issues of traffic congestion and potholes continue to plague the area," Ramesh said in his post on X.

This has not only caused frequent traffic jams but also a worrying increase in the number of accidents, and the absence of traffic police at important junctions has only exacerbated the problem, the Congress leader said.

This has led to disruptions in production schedules as the movement of raw materials to factories and the transportation of finished goods have been severely hampered, Ramesh said.

"Even after repeated complaints to the Pune police, and many meetings with officials from the Maharashtra Industrial Development Corporation (MIDC), no meaningful progress has been made. Now, around 50 manufacturing units have relocated to other states like Gujarat, Karnataka and Andhra Pradesh," Ramesh said

Is the Mahayuti government doing anything to stop this mass exodus of manufacturing units from Pune, he asked.

'What does the non-biological PM have to say about all the jobs that have been lost due to his government's negligence?" the Congress leader said. He further asked why has the BJP ignored the

Dhangar community's demand for ST status. The Dhangar community, which constitutes almost

9 per cent of Maharashtra's population, has been demanding ST status for years but in vain, he said. "Effects of caste-based marginalisation are evident

from the Dhangars' poor performance on Human Development Index indicators, but they have received no support from the Mahayuti government," Ramesh said.

Last year, Maharashtra CM Eknath Shinde made vague commitments about studying other states'

> The Congress has consistently promised to conduct a nationwide caste census to ensure that every backward community in India is able to access the opportunities they deserve, he said.

What is the PM doing to ensure the wellbeing of the Dhangar community and why have the BJP and their allies ignored the plight of the Dhangars, Ramesh asked.

Accusing the Centre of neglecting Maharashtra's sugar industry, he said that expecting a shortage in sugar production this year, the Central government has imposed a blanket ban on the production of ethanol because of which millers in Maharashtra are sitting on stocks worth at least ₹ 925 crore.

The Centre's predictions, however, are flawed as the per acre yield of sugarcane has actually increased by over 15%, Ramesh argued.

"Now, sugar mills find themselves in a fix - in addition to the financial burden imposed by this ban, they are also worried about the fire hazard posed by their existing stocks of ethanol and spirits, which are incredibly combustible materials," he said.

Neither has the Centre's reactionary policy helped the farmers - the greater-than-expected supply of sugarcane has lowered prices for the crop, especially given the drop in demand due to the ethanol ban, he said.

"Is the non-biological PM going to take responsibility for this disastrous shift in policy? Does the BJP have any plans to rectify the problems they have created for the sugar industry?" Ramesh said.

Earlier in the day, Ramesh posed three other questions to the PM ahead of his rallies in Chimur and Solapur and asked why has the BJP "diluted" Adivasis' forest rights in Maharashtra.

In 2006, the Congress had passed the revolutionary Forest Rights Act (FRA) which granted Adivasis and forest-dwelling communities legal rights to manage their own forests, and economically benefit from forest produce they collect, he pointed out.

"The BJP government, however, has obstructed the implementation of the FRA, depriving millions of Adivasis of its benefits. Only 52% (2,06,620 claims) of the 4,01,046 individual claims filed have been granted, and land titles distributed cover only 23.5% (11,769 sq. km) of the 50,045 sq. km eligible for community rights," Ramesh said in his post on X. (PTI)

# Delhi BJP demands probe into discom financial irregularities

NEW DELHI, Nov 12: The Delhi BJP on Tuesday submitted a memorandum to Lieutenant Governor VK Saxena, calling for an investigation into alleged financial irregularities in the power distribution companies, or discoms.

"We have met the LG and demanded an inquiry into the role of Arvind Kejriwal and the AAP government in providing windfall gains to the discoms in Delhi and seeking recovery of the Delhi gov-



ernment utilities with the power distribution companies," Sachdeva said

He alleged that AAP leaders received kickbacks from the power companies and questioned why the Kejriwal-led government did not revoke the licence of the private companies that have consistently

reported losses. "It is a strange irony that all three power discoms sell electric-

ity at the same rates, purchase it at the same rates, and supply it through the same Transco network, yet one consistently makes a profit while the other two continue to operate at a loss," the BJP leader said.

New Delhi BJP MP Bansuri Swaraj last week pointed out that the losses of the two discoms were categorised as regulatory assets, now exceeding ₹ 21,000 crore.

She criticised the private firm managing the discoms, suggesting that consistent financial losses signal mismanagement and potential collusion with the AAP government.

Swaraj said that the Delhi government owes power generation companies ₹ 26,638 crore due to delay in payments. (PTI)

Rajasthan: All set for assembly bye-elections, BJP looks to overcome LS poll setback

JAIPUR, Nov 12: The stage is set for by-elections on seven assembly seats in Rajasthan on Wednesday, which will have no bearing on the health of the BJP government but are a crucial test for the party and its leaders as they look to leave behind the disappointing Lok Sabha poll performance in the state. Apart from the BJP and the Congress, Hanuman Beniwal's Rashtriya Loktantrik Party (RLP) and Rajkumar Rathore's Bharat Adivasi Party (BAP) have also fielded candidates as they face the challenge of defending their strongholds. The seven seats going to the poll are: Jhunjhunu, Dausa, Deoli-Uniara, Khinvsar, Chorasi, Salumber and Ramgarh. Votes will be cast on November 13 and the results will be declared on November 23.

As many as 69 candidates -- 10 female and 59 male -- are in the fray in the seven constituencies. A total of 1,915 polling booths have been set up.

Of the seven seats, four were held by the Congress, and one each by the BJP, Bharat Adivasi Party (BAP), and the Rashtriya Loktantrik Party (RLP.

The Jat-dominated Khinsvar seat will witness a triangular contest with the BJP's Revant Ram Danga up against the Congress' Ratan Chaudhary and the RLP's Kanika Chaudhary, the wife of party chief Hanuman Beniwal.

Rewant Ram Danga contested the assembly election on this seat last year but lost to Beniwal by 2,059 votes. The seat fell vacant after Hanuman Beniwal got elected to Lok Sabha this year. Danga was a close aide of Hanuman Beniwal but later parted ways and joined the BJP after being neglected. This seat is witnessing a high-pitched campaign with the leaders of all three parties carrying out extensive canvassing.

In another Jat-dominated seat of Jhunjhunu, there is a direct contest between the BJP's Rajendra Bhamboo and Congress' Amit Ola, son of Brijendra Ola, who vacated the

seat after being elected as an MP in the LS election this year. Amit Ola's grandfather was former union minister Sisram Ola, a Jat stalwart of the Congress. Amit Ola is trying to retain the political legacy of the Ola family through this byelection.

Former minister Rajendra Singh Gudha is also contesting the bypolls as an Independent from this seat.

In the tribal-dominated Chorasi seat, there is a close fight between the BJP and BAP candidates. The seat fell vacant after the BAP's Rajkumar Roat won as an MP in Lok Sabha elections. (PTI)

The LDF and NDA campaign also focused on pointing out that Rahul allegedly rarely came to the constituency after his win from there in 2019 and that he abandoned them after his win in 2024. Both political fronts have claimed that Priyanka too will follow in her brother's footsteps.

**RANCHI. Nov 12:** The Enforcement Directorate on Tuesday raided multiple locations in poll-bound Jharkhand apart from West Bengal in a money laundering investigation linked to alleged illegal infiltration of Bangladeshi nationals, official sources said.

A total of 17 places are being covered in the two neighbouring states by the Ranchi office of the federal probe agency, a day before the first phase of polling in Jharkhand. Visuals of CRPF personnel positioned outside a hotel located on Bariatu Road in Ranchi and a resort in the city were captured by press teams as ED teams scoured for documents, ledger entries and financial records inside.

The agency had in September filed a case under the Prevention of Money Laundering Act (PMLA) to probe an instance of alleged infiltration and trafficking of some Bangladeshi women into Jharkhand leading to the generation of alleged slush funds.

Prime Minister Narendra Modi and other BJP leaders have accused the state government of aiding such infiltration leading to the altering of the

The police FIR, filed on the complaint of a Bangladeshi woman who allegedly infiltrated into the country from along the India-Bangladesh border with the help of touts to find work, has named around six women as accused who were arrested following a raid at a local resort.

The woman who filed the complaint escaped from a similar guest house and reached the police station. Police also recovered a "fake" Aadhaar card from one of these women. Police pressed multiple IPC sections like 420 (cheating), 467 (forgery of valuable security), 468 (forgery for purpose of cheating), 471 (using as genuine a forged document) and 34 (common intention) in the FIR.

It also slapped section 12 of the Passport Act (knowingly furnishing any false information or suppressing any material information with a view to obtaining a passport or travel document) and 14A of the Foreigners Act (penalty for entry in restricted area) in the complaint.

The FIR quoted the woman com-

plainant saving they were trafficked into India from Bangladesh allegedly for prostitution by luring them in the name of getting a job in beauty salons

ED sources had earlier said the agency will investigate the "entire gamut" of infiltration from across the borders, eastern including Bangladesh, into Jharkhand including in the tribal districts of Santhal Pargana and Kolhan.

Prime Minister Modi, while addressing a poll rally a few months ago, accused the Jharkhand government of encouraging Bangladeshi and Rohingya infiltration for vote bank politics and criticised it for "rampant corruption".

The Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (PMJAY) provides free health insurance of up to ₹ 5 lakh per year to the needy people. The two persons - Nagarbhai

Senma (59) and Mahesh Barot (45) - died soon after the angioplasty procedure along with stent placement was performed on them at the Khyati Multispeciality Hospital in Bodakdev area of the city on Mon-

After learning about the deaths, their relatives rushed to the hospital and sought justice from the government, claiming both the men were healthy and the hospital man-

AHMEDABAD, Nov 12: The agement performed angioplasty in a haste to raise medical bills with the government under the PMJAY scheme

Health Minister Gujarat Rushikesh Patel said, "The alleged incident at the Khyati Hospital is very serious. I have ordered an immediate inquiry by the State Anti-Fraud Unit (SAFU) of PMJAY. If there is any substance in the allegations or evidence of medical negligence, severe action will be taken against the hospital and the doctors involved."

A preliminary probe by the authorities suggested the hospital had arranged a free medical check-up camp at Borisana village in Kadi taluka of Gujarat's Mehsana district on Sunday.

After the camp, the hospital brought 19 villagers to its facility here saying they will have to undergo angiography, Patel said.

"After doing angiography, they performed angioplasty on seven of them and also put a stent. Of these seven, two died soon after the surgery on Monday. This is nothing but criminal negligence," the minister said. (PTI)

## SC ensures govt-supported medical care for vegetative-state man after parents plead for euthanasia

NEW DELHI, Nov 12: The Supreme Court has come to the help of the distraught parents of a 30-yearold man, who has been in a permanent vegetative state for over 11 years following a severe head injury, by ensuring government-supported medical care and assistance for him.

The parents, who had slipped into poverty due to the expenses being incurred during the prolonged treatment and care of their son Harish Rana and were unable to sustain it any more, had moved the top court against a Delhi High Court order refusing them a nod for passive euthanasia for their son. In an order passed on his last working day, Chief Justice D Y Chandrachud perused a report of the Union Ministry of Health and Family Welfare and approved its plan to provide medical and other care to the bed-ridden Rana

Justice Chandrachud-led bench had said it was not the case of passive euthanasia as he was not on a ventilator or other mechanical support to sustain life and rather, was being fed through a food pipe.

Instead of allowing passive euthanasia, which is not permissible in this case, it would explore the possibility of shifting him to a government hospital or a similar place for treat-

port or treatment necessary for maintaining life. The apex court had agreed with the findings of the high court, which refused to constitute a medical board to consider the parents' plea that their son be allowed to undergo passive euthanasia.

On August 20, the bench issued a notice to the Centre to explore alternative solutions for his care and this was followed by a status report submitted by the Ministry of Health and Family Welfare, detailing three care options for Rana.

The ministry, in the report filed on November 8, said, Consequent upon all the efforts made by the central government in compliance with the instructions given by the Supreme Court on 20 August 2024, the following viable solutions have emerged for consideration

(i) Home care of Shri Harish Rana with assistance from the Government of Uttar Pradesh as under: a. Regular Physiotherapist's visit; b. Regular Dietician's visit; c. Medical Officer on call d. Nursing care provision at home e. Availability of all required medicines and consumables free of cost.

"If home care is not feasible, shifting of Rana to District Hospital, Noida, Sector-39 for ensuring availability of proper medical care considering his health condition. the ministry said, adding support from NGOs, if deemed fit, may also be considered (PTI) withholding or withdrawing life sup-

VADODARA, Nov 12: The death toll in a fire at the Indian Oil Corporation (IOCL) refinery in Gujarat's Vadodara city has gone up to two, while another injured person was undergoing treatment, police said on Tuesday

The fire that began on Monday afternoon with a blast in a benzene storage tank of the refinery later spread to two other adjoining tanks, Jawahar Nagar police station inspector A B Mori said.

The blaze was brought under control after efforts which continued till the wee hours of Tuesday, he said.

Two persons -- Dhimant Makwana and Shailesh Makwana -- died in the fire. An IOCL official received injuries and was undergoing treatment at a private hospital, Mori said. The condition of the injured person was stable, he said.

The blaze was brought under control after extensive efforts involving several fire tenders brought in from nearby cities and towns, officials said. The blast occurred at the IOCL refinery located in Koyali area on the outskirts of Vadodara which triggered the blaze, an official earlier said. The IOCL in a statement on Monday evening said the "fire was reported at around 3.30 pm in a benzene storage tank (1000 KL capacity) at Gujarat Refinery".

#### Draft bill on integrated water resource management authority circulated among states

NEW DELHI, Nov 12: A draft model bill proposing setting up of an Integrated Water Resources Management Authority which will be responsible for developing water security plans from villages to cities, groundwater management and floodplain management has been circulated to all states, a senior official said on Tuesday.

Rakesh Kumar Verma, Additional Secretary, Department of Water Resources said to achieve water security as part of the vision for Viksit Bharat, the government has proposed the Integrated Water Resources Management Authority (IWRM) at the state level, which will coordinate and integrate efforts of multiple water-related departments and agencies.

"A draft model bill has been circulated to all the states. This state IWRM authority, under the overall supervision of an IWRM council headed by chief minister. has been vested with various regulatory powers to set

Puri Collector Sidharth Shankar Swain said that the administration has also raised barricades and 'Bada Danda' (grand road in front of the temple) has been declared a no-vehicle zone from municipal market square.

The collector said lifeguards and



# We love to tell stories about invisible women: 'House of Spoils' co-director Danielle Krudy

**NEW DELHI, Nov 12:** The protagonist in supernatural film "House of Spoils" is simply called Chef and director duo Bridget Savage Cole and Danielle Krudy say the idea behind the naming the profession of the character was all about reclaiming her identity.

"House of Spoils", also penned by Cole and Krudy, is streaming in India on Prime Video. The movie follows an ambitious chef, played by Oscar winner Ariana DeBose, who opens her first restaurant — a farm-to-table affair on a remote estate — where she battles kitchen chaos, a dubious investor, crushing self-doubts — and the powerful spirit of the estate's previous owner, who threatens to sabotage her at every turn. "We love to tell stories about invisible women and women in the background. Witches are also invisible women who don't concede as much... There are so many women who just have a job that are defined by their job and don't get seen.

"Letting Chef just embody that identity fully and reclaim it felt exciting to us," Krudy told PTI in a virtual interview. As they developed the story,

Cole said they slowly knew they wanted the movie to be a "spooky tale".

"We started with this idea of a chef who is getting inspired by the presence of something else on this property where she is trying to make a restaurant and from there we just tried to

tell the best story..." she added. Cole, who along with Krudy made her directorial debut with 2019's black comedy thriller "Blow the Man Down", said "House of Spoils" is a film about a person's relationship to their work. "We have both lived in periods when we felt defined by our work. So, it felt right to let her (Chef) be defined by her work in this film. There are so many other things we ascribe to

women's stories, that we expect from them.
"We wanted to focus on this and make it about trying to do something hard, trying to find her voice as a creator. It made sense to us to pull back and make it as archetypical and simple as possible," she said. As the character of Chef

faces creative block and management lapses in the kitchen, she also starts seeing the food infested with bugs and mould.

The film is replete with images of immaculately decorated platters with fine-dining fare juxtaposed with the ones of spoilt dough and insects running off a plate.

Asked if this culinary contrast was a conscious decision, the filmmakers said it was part of the creative process.

"This is a movie about a chef trying to find her own nightmare scenario specifically. A chef's nightmare is going to look different from someone else's so that's why mould and the rotting food felt so specific to this world," Cole said. (PTI)



# VETERAN ACTOR MANOJ MITRA DIES AT 86

**KOLKATA**, Nov 12: Famous Bengali theatre personality Manoj Mitra, known for writing and directing farces and fantasies to highlight social and political issues, died at a hospital here on Tuesday due to old-age related ailments, family sources said.

Mitra was 86. According to a doctor, Mitra breathed his last at around 8.50 am on Tuesday. "He was admitted to the hospital on November 3 with several illnesses. His condition kept on deteriorating and today at around 8.50 am he left us," the doctor told PTI.

The octogenarian was earlier admitted to hospital on September 20 with breathing issues, imbalance of sodium and potassium among other health-related issues, doctors said. He was discharged from the hospital on September end. West Bengal Chief Minister Mamata Banerjee expressed her grief over the passing away of Mitra and described it as an irreplaceable loss to Bengali cinema and



theatre. "Saddened by the demise of the famous actor, director and playwright, 'Banga Bibhushan' Manoj Mitra today morning," she posted on X. "He had been a leading personality in our theatre and film worlds and his contributions have been immense. I convey my condolences to his family, friends and admirers," she added. West Bengal Education Minister and actor-theatre personality Bratya Basu in a social media post traced the illustrious career of Manoj Mitra and offered his deep condolences to the bereaved family and his countless followers.

**MUMBAI, Nov 12:** Actor Divya Dutta has fond memories of working with Yash Chopra on "Veer-Zaara", which celebrates its 20th release anniversary on Tuesday.

Dutta played Shabbo, the confidant and house help of Zaara (played by Preity Zinta) in the 2004 movie, fronted by Zinta and Shah Rukh Khan's as lovers divided by borders.

The film, which re-released in theatres last week, is a cross-border love story of Veer Pratap Singh (Khan), an Indian Air Force officer, and Zaara Hayaat Khan (Zinta), the daughter of a Pakistani politician.

Dutta said the late Yash Chopra is still her "most favourite filmmaker".

"The romance and nuances he showed in his films, no would be able to do that ever. I came into the industry through a talent hunt and Yash Chopra was one of the judges.

"I used to think 'Wow, I am starting out with Yash Chopra'. I used to imagine he would say 'You are so good, I will take you in my next film' but no such thing happened," the actor told PTI in an interview.

It took her another seven years to work in a Yash Chopra film with "Veer-Zaara". Dutta still remembers the day she got a call from the office of Aditya Chopra, who wrote the film's script.

"They saw a show where I used to play a differ-

ent role in every episode. They offered me this role (in 'Veer-Zaara'). I was confused whether I should do it or not. To be on the sets of Yash Chopra was a dream come true. That grandeur, love and affection... The film's first shot was my first shot too. Yash ji,

Shah Rukh ji, everyone was there. I was nervous.

"It feels surreal that the thing you imagined is happening at that moment is real or not. You have to pinch yourself, you're also nervous. But he (Yash Chopra) was such a loving person," she recalled.

Their mentor-mentee bond continued even after the release of the film, which went on to become one of the most successful movies of the year with its chartbuster music.

"Even after <sup>1</sup>Veer-Zaara' released, he (Yash Chopra) used to say 'Bacche! Come to the office whenever you feel like'. And I used to go to the office to meet him. I used to talk to him about everything," she said.

The actor said both Yash Chopra and Amitabh Bachchan, who did a guest appearance in "Veer-Zaara", remember people's birthdays despite their legendary status.

"They are always the first ones to wish you. And I think that's what made Yash Chopra who he was. That's what makes Mr Bachchan who he is," she said.

Dutta revealed that she was initially sceptical about taking on the character of Shabbo, which is widely regarded as her breakthrough role in Hindi cinema.

"Yash uncle and Aditya told me that 'We wouldn't have asked you to do the role if it was not special'. I was scared I did not want to be stuck in a certain image," the actor said, admitting that similar offers came her way post the success of the film but she turned them down.

"Veer-Zaara" also starred Rani Mukerji, Hema Malini, Boman Irani, Kirron Kher, Anupam Kher, Manoj Bajpayee, and Zohra Sehgal. (PTI)

Alcaraz struggles with stomach issue in loss to Ruud at ATP *Finals and Zverev beats Rublev* 

TURIN (ITALY), Nov 12: Carlos Alcaraz struggled with a stomach issue and looked far from the player who won two Grand Slams this year while losing to Casper Ruud 6-1, 7-5 at the ATP Finals.

It marked Ruud's first victory over Alcaraz in five career meetings, and the result could make it difficult for Alcaraz to advance from the round-robin stage at the season-ending event for the top eight players.

"I didn't feel well on court," Al-caraz said. "A few days before coming here, I got sick at home. ... This morning, I feel uncomfortable in the stomach.'

In the same group, Alexander Zverev began his bid for a third ATP Finals title by beating Andrey Rublev 6-4, 6-4

The top two finishers from each group advance to the semifinals. On Sunday, top-ranked Jannik Sinner and U.S. Open finalist Taylor Fritz beat Alex de Minaur and Daniil Medvedev, respectively, in the other group.

Alcaraz won the French Open and Wimbledon to boost his career total to four Grand Slam titles. But he also struggled at the Paris Masters recently and dropped behind Zverev to No. 3 in the rankings this week.

"I have no experience playing on indoor courts," Alcaraz said. "I'll be a really good player on indoor courts, I'm sure about it. But I think it's about time, about getting experience. ... A lot of players are better than me on indoor court."

Ruud reached the 2021 semifinals and 2022 final in his first two

appearances at the finals. But he has struggled recently, too, losing his first or second match in his last seven events.

"I'm not full of confidence," Ruud said. "A match like today might be able to change it."

Alcaraz was broken when he served for the second set at 5-4. Alcaraz led 25-16 in winners but committed 26 unforced errors to Ruud's 10. Ruud converted all four of his

break points while Alcaraz was just one of six in that category.

"I'm tired mentally," Alcaraz said. "Obviously a lot of matches, really tight schedule, really demanding year with not too many days off. Zverev, who won the finals in

2018 in London and 2021 in Turin, extended his winning streak to six matches following a title run at the Paris Masters.

Rublev is making his fifth consecutive appearance at the finals but hasn't won a match at the event since 2022

Zverev served nine aces and dropped only 10 points on his serve in 10 service games. "He served wide 220 (kph) on the deuce side," Rublev said.

"Normally everybody serves slice and it's 190. He find(s) a way to serve 220 wide on the deuce side. It's not easy. "Even if you catch the direction,

when the flat serve comes 227, slice serve comes 219, 215, it's tough to just see the ball."

Before the Zverev-Rublev match, Sinnner received the trophy for finishing the year at No. 1 in the rankings. (AP)

DUBAI, Nov 12: Matteo Manassero quit golf five years ago at the age of 26, tormented by a sport that gave him so many highs but was no longer making him feel happy. On Sunday, he could punch a ticket to play across the Atlantic on the lucrative PGA Tour and be back in the big time, where so many think his game belongs. The 31-year-old Italian will look to cap his career revival this week by becoming one

of 10 players from the European tour to be eligible to claim dual membership and a PGA Tour card for the 2025 season.

The season-ending World Tour Championship starts on Thursday in Dubai and only an unlikely turn of events will deny Rory McIlroy from being crowned as the European tour's best player for a sixth time, leaving him two off Colin Montgomerie's record haul.

There will be more suspense elsewhere, though, notably in that race for those PGA Tour cards — a structural tweak created in 2022 in the wake of the so-called strategic alliance between the European tour and PGA Tour in the face of mounting pressure from the breakaway LIV Golf series. The presence of Manassero in the 10man list, as it stands, only elevates the interest levels. Blessed with a smooth swing and a deft touch, Manassero was a golfing prodigy, winning the British Amateur in 2009, the silver medal at the British Open for low amateur the same year, and also becoming the No. 1 amateur in the world

By 2013, he'd won four events on the European tour - including the BMW PGA Championship, the flagship event on the tour, to move into the world's top 25. Then came the career dip, which plunged him into self-doubt and ultimately retirement — albeit for only a few months while he assessed where to go with his life. He eventually decided to give golf another go, beginning his rebuild on the lowly Nordic Golf League and the Alps Tour, which is on the third tier of European golf. His talent shone through and last year he sealed a return to the European tour with a win at the Jonsson Workwear Open in March being universally cele-

If Hojgaard secures his PGA Tour card, he will join his twin brother Nicolai in the United States. Lawrence leads that list of PGA Tour hopefuls but has other things

on his mind. The South African is the only player who can prevent McIlroy from winning the Race to Dubai title — formerly the Order of Merit — and join the late Seve Ballesteros on six.

Lawrence has to win — nothing less is good enough — and then needs McIlroy to finish tied for 11th or lower.

"Rory has been an idol for me since growing up as a youngster," the 27-yearold Lawrence said, "and being able to clinch it this week would be the cherry on the cake for myself."

The smart money, however, is on McIlroy, who has shown extraordinary consistency in collecting a win — at the Dubai Desert Classic in January — as well as four runner-up finishes and three more top fives in his 12 European tour events this season. "Rory is held to a higher standard than pretty much everybody else in the world of golf," Tommy Fleetwood said. "But, I think he's shown amazing golf again this year, and he's shown why he's one of the best to ever do it." (AP)

Since 2009, India have played only one T20I at this venue, which they lost by six wickets in 2018 and have only one survivor from that squad in this side -- Hardik Pandya.

Along with that unfamiliarity factor, India will also grapple with the ordinary form of their batters, particularly when the pitch here is touted to be similar to the one at Gqeberha – quick and bouncy.

In the second T20I, India batters struggled against South African pacers upfront, getting restricted to 124 for six, and Centurion has similar characteristics.

The problem starts from the top more precisely with Abhishek Sharma, whose extended lean run with the bat has now snowballed into a serious concern. He is in desperate need of a good outing here before the management thinks of juggling the combination.

Even now, they can think of giving the job of partnering Sanju Samson at the top to Tilak Varma and bring in Ramandeep Singh in the middle to add more muscle to the unit.

However, the senior batters like skipper Suryakumar Yadav, Pandva and Rinku Singh too cannot absolve themselves of the blame entirely for India's struggles.

Both Suryakumar and Rinku have shown only fleeting images of their prowess here while Pandya made 39 in the second match but he consumed 45 balls for it.

In fact, the power-hitter took 28 balls to find his first boundary and, again, could not find the ropes between balls 39 and 45.

So, these three batters will have to chip in more to support in the inform Samson or to carry India to a strong total even when the Kerala man has a vapid day.

Similarly, pacers Arshdeep Singh and Avesh Khan had two contrasting games. Arshdeep returned with figures of 1 for 25 at Durban, but in the second game he had stats of 1 for 41.

The left-arm pacer's third and fourth overs which went for 28 runs – including four fours in an over against Tristan Stubbs - made a deep impact on the low-scoring match.

#### **Olympic medalist** withdraws from elections

PARIS, Nov 12: Sarah Ourahmoune, a silver medalist at the 2016 Olympic Games, has withdrawn her bid to become president of the French boxing federation, saying she has been the target of vicious racist and sexist attacks.

In an open letter published this week, Ourahmoune said she found herself at the receiving end of insults that went beyond anything she could have imagined in the buildup to next month's election.

"Words like the token Arab', the federation's cleaning lady', or even the (expletive) of...'," she wrote on social media. "Not to mention anonymous messages of unprecedented and deeply shocking violence." Ourahmoune had been campaigning on a joint bid alongside the current president, Dominique Nato.

Another female boxer, the 2016 Olympic lightweight champion Estelle Mossely, is also a candidate.

"I never thought I'd be attacked like this because of my origins or simply because I'm a woman,' Ourahmoune said.

"My decision to step down has cost me enormously, because it seems to contradict everything I stand for on a daily basis: courage, resilience, the ability to fight in hostile environments, to push back the limits of what is possible, and



KOLKATA, Nov 12: Premier India pacer Mohammed Shami will make his much-anticipated return to competitive cricket after a hiatus of nearly a year through Bengal's Ranji Trophy match against Madhya Pradesh in Indore from Wednesday, announced Cricket Association of Bengal.

Shami, who has been out of action since the 2023 World Cup final on November 19 due to an ankle injury and the subsequent surgery, will aim to prove his fitness in a real match situation after undergoing intense rehabilitation at the BCCI Centre of Excellence in Bengaluru.

"In a major boost to Indian cricket and the Bengal Ranji Trophy team, star pacer Mohammad Shami will make a comeback into competitive cricket for Bengal against

tary Naresh Ojha said in a statement.

Ojha said Shami will spearhead the Bengal pace bowling unit and the Indian thinktank in Australia too will closely follow Shami's outing.

India have opted for a largely untested pace attack for the Border-Gavaskar Trophy with rookies such as Akash Deep, Harshit Rana, Nitish Kumar Reddy and Prasidh

Krishna backing senior pros Jasprit Bumrah and Mohammed Siraj.

Mukesh Kumar, Navdeep Saini, and Khaleel Ahmed are in the reserves, but all of them come with minimal exposure to Test cricket.

There was intense speculation surrounding Shami's inclusion in the Indian squad to tour Australia but skipper Rohit Sharma struck down such thoughts saying he did not prefer taking an "undercooked" senior pacer Down Under.

Shami had played a big role in India's historic 2-1 Test series victory in 2018-19 against Australia, claiming 16 wickets at an average of 26.18.

Instead, Shami focused on regaining optimum fitness at the NCA and he also bowled at full tilt at nets while India bowling coach Morne Morkel kept a close watch

# Perth pitch to have really good pace and bounce: Curator cautions India ahead of first Test



**PERTH, Nov 12:** India will be accorded a tough welcome to Australia as the Optus Stadium pitch for the opening Test of the Border-Gavaskar Trophy has been prepared to offer "good bounce and pace" true to the tradition of the fiery tracks in Perth.

India will enter the Perth Test, beginning from November 22, without playing any practice match as the visitors had cancelled an intra-squad side game that was scheduled to be played behind closed doors from November 15 to 17.

Now, India will focus on centre-wicket training at the nearby WACA stadium, where Australia will also polish their skills.

'This is Australia, this is Perth... I'm setting ourselves up for really good pace, really good bounce and really good carry," Western Australia Cricket head curator Isaac McDonald told 'ESPNcricinfo'

McDonald is trying to prepare a pitch that has similar traits of the one that he readied for the first Test against Pakistan in December last vear.

In that match, Pakistan were bundled out

for 89 in the second innings as the Aussies celebrated a massive 360-run victory.

The pitch too had developed cracks as that match wore on and batters like Marnus Labuschagne copped blows on their hands. Overall, the three Aussie pacers - Pat Cummins, Josh Hazlewood and Mitchell Starc - grabbed 12 of the 20 Pakistan wick-

More recently, Pakistan pacers Shaheen Shah Afridi, Naseem Shah and Haris Rauf tore through Australian line-up, bowling the hosts out for 140 in the third ODI here.

McDonald said he is looking to leave some grass on the pitch to make it a bit spicier.

"It's (10 mm) a good starting point. Ten millimetres was pretty comfortable with the conditions that we had (last year) and that held the conditions together nicely for the first few days. Live grass on the pitch is speed.

"Both bowling units (Australia and Pakistan) were pretty rapid last year and hoping for much the same this year (for India match)," he added. (PTI)

ADELAIDE, Nov 12: Australia opener Nathan McSweeney, who is set to debut against India in the Border-Gavaskar Trophy, said he has been preparing for the "unique" challenge of facing star pacer Jasprit Bumrah.

McSweeney was drafted into the Australia squad after a slew of impressive performances in the Sheffield Shield tournament and in the recent 'A' series against India.

The 25-year-old South Australian will partner Usman Khawaja at the top in the series opener in Perth and during the upcoming five-Test series.

"There's probably not (much I can do to replicate how Bumrah bowls). Obviously, he's got a unique action. He's one of the best bowlers in the world.

"So, it's going to be hard to mimic that. I'm just looking forward to all of that and I can't wait," McSweeney told SEN.

McSweeney, who captained the Australia A side in the 2-0 series win against India A, said he has been watching the bowling clips of Indian quicks including Bumrah and Mohammed Siraj to be mentally ready for the task

"I'll definitely dive a lot deeper into it when I get to Perth. I've looked at a few clips of what they're bowling attack stacks up like. I'm just trying to visualise how I'm going to go about it. Facing a new bowler can be a slight challenge to just pick up their action,' he said.

"I've got a whole week before I head off to Perth, so, I can get mentally ready and I guess it starts now in preparation to hopefully start really well," he added.

However, a quiet confidence runs through the young batter ahead of the



series against Pakistan in January this year, and the Adelaide man realises the enormity of the job.

The right-hander has a plan for it. "Being an opening batter, it's making sure I'm leaving the ball well and making the bowlers are bowling to me. Then being ready and positive to score when they miss is as simple as I want to make it.

"If I'm reacting well and doing those things well, hopefully, it equates to me spending time in the middle and chipping away at the scoreboard," he said. (PTI)
