# Curfew relaxed in 3 districts, broadband internet restored with conditions in Manipur

**IMPHAL, Nov 19:** Curfew was relaxed in three Imphal Valley districts on Tuesday and the suspension on broadband internet lifted with conditions, even as Chief Minister N Biren Singh blamed the Congress for the present crisis in Manipur and NDA MLAs called for a "mass operation" against militants responsible for the killing of six women and children.

Peaceful rallies were also staged across the state, with hundreds taking to the streets with empty coffins in Churachandpur district, demanding justice for those killed in a gunfight with the security forces in Jiribam, and members of various civil so-

ciety organisations bringing out a procession in Imphal West district to protest the reimposition of AFSPA in parts of the state.

Prohibitory orders were relaxed in Imphal East and West, and Kakching districts from 5 am to 10 am to facilitate the purchase of essential items "in view of improvement in law and order", separate notifications issued by district administrations said. However, restrictions on large scale gatherings or movement of persons or sit-ins continued to remain

The Manipur government also conditionally lifted the suspension on broadband services three days after imposing it, considering the hardships faced by common people, healthcare facilities, educational institutions and other offices. Mobile internet services, however, remained suspended, according to an order issued by Home Commissioner N Ashok Kumar.

Meanwhile, the chief minister attacked Congress leader P Chidambaram over his X post "calling for division of the state"

Blaming the chief minister for the current crisis in the state, Chidambaram called for his removal, and claimed that "Meiteis, Kuki-Zo and Nagas can live together in one state only if they have genuine

Speaking to reporters, Singh said, "I am surprised to see his post mentioning the division of Manipur and accusing the chief minister for the present crisis. Chidambaram is the root cause of the present crisis. When he was the Union home minister and O Ibobi Singh the CM, they brought a Myanmarese

named T Guite, a person who contested elections in

Myanmar and is the chairman of Zomi Revolution-

Showing a purported photograph of Chidambaram and Guite, he said, "The present crisis is created by the Congress. They cannot wash off their

hands easily. Propaganda and allegations by national leaders should stop. Chidambaram was responsible for bringing in illegal immigrants to Manipur.

"What happened during Congress rule? How many were killed in fake encounters? There are 1,500 cases related to fake encounters in Supreme Court. I want to appeal to him (Chidambaram) not to play destructive games and destabilise Manipur. Peace was already established three-four months back but a few people with vested interests who want to destabilise the state derailed our efforts to establish peace," he said. (PTI)

"Over 100 years ago, Kabiguru Rabindranath Tagore had described modern-day Karimganj district as Sribhumi - the land of Maa Lakshmi. Today, the Assam cabinet has fulfilled this longstanding demand of our people,' he said.

The move to rename the district will reflect the expectations and aspirations of the people of the district, Sarma said.

#### **Tusker radio-collared** in Assam's Baksa

GUWAHATI, Nov 19: A tusker was radio-collared in Assam's Baksa district as part of an initiative led by the state forest department with support from the district administration and police, officials said.

The elephant was tranquilised by a team of veterinarians with the help of forest officials and biologists under the leadership of Field Director of Manas Tiger Reserve Dr C Ramesh and supervision of Baksa Divisional Forest Officer (DFO) Golap Baniya at Jartaluk area of the district on Monday, they said. The elephant later joined its herd, according to a release issued on Tuesday

"I had led a team of veterinarians from Assam State Zoo who supported the team with necessary veterinary support to capture and radio collar the elephant. We have supported the team with required medicines, tranquillizing guns and related items to make the radio collaring successful which will help in tracking elephant movement to better manage human-elephant conflict in the region", said Assam State Zoo's DFP Ashwini Kumar,

The basic objective of radio collaring of wild elephants is to determine the elephant occupancy within an area or range. It helps in better management of human-elephant conflict and facilitate elephant conservation.

The team for capturing and radio-collaring of the elephant also consisted of wildlife biologists, researchers, Green Globe, WWF India and local stakeholders.

## Anti-pollution measures in Delhi push daily wage workers into livelihood crisis

Delhi-NCR impose restrictions to combat the worsening air quality in the region, the brunt of the anti-pollution measures is being faced by daily wage workers involved in construction activities whose lives have to a standstill.

Workers who depend on daily earnings to survive said they are worried their children will starve to death.

Construction and demolition activities (C&D) are banned under the current GRAP-IV measures that came into effect after many parts of Delhi reported "severe-plus" air quality (Air Quality Index above 450).

Suman, a 45-year-old mother of two, says "If we sit at home, what will we eat? What will we feed our children?"



She recently renewed her labour card with the hope of receiving government aid but she says it has been a futile exercise. "We don't have

ically. We survive on daily earnings, and without work, we have nothing," she adds.

A thick grey haze engulfed the national capital on Tuesday, with AQI soaring to 488 Delhi's air quality plummeted to the 'severe plus' category on Sunday, prompting authorities to impose Stage IV measures under the Graded Response Action Plan (GRAP) on Monday.

These measures include a ban on construction and demolition activities, restrictions on truck entries except for those carrying essential items or using clean fuel, and the closure of schools. #### Assam oppn demands Shah's resignation for 'failure' in Manipur GUWAHATI, Nov 19: The Con-Prime Minister Narendra Modi

gress on Tuesday accused the BJPled governments at the Centre and in Manipur of failing to curb the ongoing violence in that state and demanded the resignation of Union Home Minister Amit Shah.

Led by the leader of the opposition in the Assam assembly Debabrata Saikia, the grand old party held a candle-light march in Dighalipukhuri here to protest the violence that left over 220 people dead in the neighbouring state since May last year.

"The central and Manipur governments are of the BJP but no concrete steps have been taken to solve the escalating violence. The state has been burning since last year but

does not seem to be concerned. He is currently on a foreign trip," Saikia said.

Senior Congress leader Abdul Khaleque, who was also at the forefront of the procession, said that the N Biren Singh-led BJP government in Manipur must be dismissed immediately as he has failed to control the violence and end the crisis. The former MP also demanded

the resignation of Union home minister Amit Shah for failing to check the violence in Manipur which has turned into a "killing field". Assam unit president of the Aam Aadmi Party (AAP) Manoj Dhaowar also expressed concern over the ongoing violent situation

in the neighbouring state which has been 'burning for over one and a half years'

'The central government has not given the matter the attention it deserves. Despite the fact that Prime Minister Narendra Modi's own party is in power, there has been no sincere effort from him to put out the flames in Manipur," he said.

The Prime Minister is busy with foreign trips and it appears that he failed to recognise that Manipur is an integral part of India, Dhaowar claimed. Union home minister Amit Shah visited the state only once during the violence but no effective measures were taken to curb the unrest, the AAP leader alleged. (CONTD. ON PAGE-2)

# **UK PM Starmer announces relaunch** of FTA talks after Modi meet

LONDON, Nov 19: British Prime Minister Keir Starmer has announced that trade talks with India will relaunch in the new year, following his bilateral meeting with Prime Minister Narendra Modi at the G20 Summit in Brazil.

Starmer and Modi met on the sidelines of the summit in Rio de Janeiro on Monday after which Downing Street said the UK will seek a new strategic partnership with India, including a trade agreement as well as deepening cooperation in areas like security, education, technology, and climate change.

Starmer's spokesperson said the UK is committed to negotiating a trade deal with India, one of the fastest growing economies in the world.

"A new trade deal with India will support jobs and prosperity in the UK – and represent a step forward in our mission to deliver growth and opportunity across our country," Starmer said in a statement released by 10 Downing Street after the bilateral meeting.

A readout of the Starmer-Modi talks released in London on Tuesday stated that both leaders agreed to take forward an ambitious UK-India Comprehensive Strategic Partnership to take the relationship to new heights in trade and investment, security and defence, technology, climate, health and education.

"As part of this they agreed to relaunch UK-India trade talks early next year. They also welcomed the recent launch of the

#### 'Nations' security and prosperity intimately connected to oceans

NEW DELHI, Nov 19: Prime Minister Narendra Modi has said that the security and prosperity of nations is intimately connected to oceans and the govt has taken several transformative steps to bolster India's maritime capabilities.

In his message sent from Camp Office in Nigeria, Modi called for success of 'Sagarmanthan, The Ocean's Dialogue', being held at the national capital to build consensus for partnerships of a prosperous future of humanity. "Today, the security and prosperity of nations is intimately connected to oceans. "Recognising the potential of oceans, several transformative steps have been taken to bolster India's maritime capabilities," he said. Sagarmanthan, South Asia's largest maritime thought leadership forum, began on Monday.

"Over the last decade, guided by the vision of 'Ports of Prosperity 'Ports for Progress' and 'Ports for Productivity', we have doubled the capacity of our ports," he said.

"By enhancing port efficiency, reducing turnaround times and strengthening last-mile connectivity through expressways, railways and riverine networks, we have transformed India's shoreline," the prime minister added. Highlighting India's rich maritime legacy and steps to build the sector, Modi said India's maritime tradition goes back several millennia and is among the richest in the world. While noting that the thriving port cities of Lothal and Dholavira, fleets of the Chola dynasty, exploits of Chhatrapati Shivaji Maharaj are great inspirations, he said, oceans are a shared heritage for nations and societies, as well as the lifeline for international trade. December 15. While officials on the Indian side had expressed their readiness to resume FTA negotiations from the stalled fourteenth round, this announcement of a new year start for the talks is the first clear signal

"I and my party strongly believe that the deliberate acts of omission and commission, as indeed inordinate inaction on the part of both the central and state governments, have resulted in complete lawlessness, absence of rule of law, violations of human rights, compromise of national security and suppression of fundamental rights of citizens of our country." Accordingly, ASSAC will be included under the PM Gati Shakti-driven programme for data-sharing, standards for data quality and police framework of geospatial data in the state. "With this new setup as state nodal agency, ASSAC will be in a better position to liaise with stakeholders of state government, ISRO, DOS NESAC in the area of scientific and techno-managerial activities," it said. In the meeting, the cabinet also approved several amendments in the Assam Unified Building Construction (Regulation) Byelaws, 2022 in order to carry out urban reforms and achieve planned development.

"The amendment will bring about a transformation in the land use, transportation and land value capturing mechanism of urban areas to develop sustainable, healthy, liveable and efficient cities," it added. (PTI)

#### Manipur violence: Rally in protest

Jiribam district just a few days after AFSPA was reimposed in Jiribam," he said. He referred to the Jiribam firing incident which left one person dead and another injured on Sunday night. The incident occurred during a clash between security forces and a mob that was vandalising properties in the Babupara area of Jiribam.

The AFSPA gives armed forces operating in disturbed areas sweeping powers to search, arrest and open fire if they deem it necessary for the "maintenance of public order". The Centre has recently reimposed the Armed Forces (Special Powers) Act in Manipur's six police station areas, including the violence-hit Jiribam.

In a notification, the Union home ministry said the decision was taken given the continuous volatile situation there due to the ongoing ethnic violence. The police station areas where AFSPA has been reimposed are Sekma and Lamsang in Imphal West, Lamlai in Imphal East, Jiribam in Jiribam district, Leimakhong in Kangpokpi and Moirang in Bishnupur. Alleging that CM N Biren Singh has failed to restore peace, Sharmila stressed that immediate and decisive action is needed to stop the ongoing ethnic violence, which has claimed over 200 lives and displaced thousands since May last year. She claimed, "The wrong policies of the state government have pushed Manipur into this unprecedented crisis. The chief minister must immediately step down for failing to restore peace since May last year. The BJP must ask him to resign. He has failed the people of Manipur." The Centre first needs to understand the problem and what the people of Manipur want, she said.

"The Centre must conduct a referendum among the communities to determine how to resolve the crisis. The government needs to understand what the people of Manipur want before taking corrective steps," she said. The Centre last week reimposed AFSPA in six police station areas of Manipur, including the violence-hit Jiribam, citing the "continuous volatile situation" due to ongoing ethnic violence. This came on the same day the Manipur Police announced the seizure of a cache of arms and ammunition from the Jiribam and Chu-

Criticising the Centre's decision to reimpose AFSPA in some areas following the recent spate of violence, the rights activist reiterated her long-standing opposition to the Act, describing it as a "colonial-era law that cannot address Manipur's problems'

"AFSPA can never be a solution. It is a draconian law. It has been in Manipur for so long, yet it hasn't stopped the violence. The Centre must recognise that the northeast is part of India not just in words but in practice. The reimposition of AFSPA would further aggravate the situation," Sharmila, who conducted a 16-year-old fast demanding withdrawal of the Armed Forces (Special Powers) Act, said. Reflecting on her activism, she said, 'AFSPA has brought nothing but suffering to the people of Manipur. It's time we moved beyond such colonial laws to find real solutions.

Sharmila questioned the "double standards" in addressing law and order issues in different parts of the country. "Can you impose AFSPA or suspend internet services for months in cities like Mumbai or Delhi or any big states like Uttar Pradesh or Madhya Pradesh during a crisis? India is a democratic country, and such measures should not be carried forward from the colonial era. In the name of fighting insurgency, crores of rupees are wasted, which could have been used for the development of the northeast," she stated. (PTI)

MUMBAI, Nov 19: Benchmark Sensex rebounded 239 points while Nifty ended its seven-day losing streak on Tuesday following value-buying in banking, IT and auto shares amid mixed global

Snapping its four days of decline, the 30-share Sensex climbed 239.37 points or 0.31 per cent to settle at 77,578.38. The index opened with gains and spurted further 1,112.64 points or 1.43 per cent to hit the day's high of 78,451.65. However, fag-end decline in Reliance Industries restricted the market rally.

The NSE Nifty also bounced back after seven straight sessions of losses. The broader 50-issue barometer gained 64.70 points or 0.28 per cent to settle at 23,518.50. The index jumped over 300 points to hit 23,780 level in the day.

Stock markets were on a decline in the past seven sessions with Nifty tanking 1,030 points or over 4.3 per cent due to FII selling, weaker-than-expected quarterly results and strengthening US bond yields. Sensex plunged more than 3,000 points to 77,300 levels dur-

ing the period. "A strong bounce back due to bottom fishing was short-lived as caution prevails in the market. Investors tend to use every opportunity to book profit amidst consistent FII selling and weak Q2 earnings. Profit-booking was also seen ahead of the upcoming Maharashtra state election," Vinod Nair, Head of Research, Geojit Financial Services, said.

The recent correction in valuation suggests a potential pause in

NEW DELHI, Nov 19: After the Competition Commission imposed a ₹ 213-crore penalty on Meta in relation to WhatsApp privacy policy, the company said it disagrees with the watchdog's decision and plans to appeal.

The Competition Commission of India (CCI) on Monday asked WhatsApp to refrain from sharing user data with other applications, owned by Meta, for advertising purposes for a period of five years. India's competition watchdog

to WhatsApp privacy policy update done in 2021. Besides, the competition watchdog has directed Meta to cease and desist from anti-competitive prac-

Meta and WhatsApp have also been asked to implement certain behavioural remedies within a defined timeline to address the anticompetition issues, according to a

A Meta spokesperson said that the company disagrees with the CCI's decision and plans to appeal. "As a reminder, the 2021 update

did not change the privacy of peo-

ple's personal messages and was offered as a choice for users at the time. We also ensured no one would have their accounts deleted or lose functionality of the WhatsApp service because of this up-

date," the Meta spokesperson said. Meta further said the update was about introducing optional business features on WhatsApp, and provided further transparency about data collection and usage.

The Meta spokesperson added since that time, WhatsApp has been incredibly valuable to people and businesses, enabling organisations and government institutions to deliver citizen services through COVID and beyond, and as well as supporting small businesses in furtherance of the India economy.

"WhatsApp is able to do all of this because it offers services supported by Meta. We are committed to finding a path forward that allows us to continue providing the experiences that people and businesses have come to expect from us," the Meta spokesperson said.

Meanwhile, CCI has barred WhatsApp from sharing data col-

lected on its platform with other Meta companies or Meta company products for advertising purposes for five years. On sharing of WhatsApp user

data for purposes other than advertising, the regulator said WhatsApp's policy should include a detailed explanation of the user data shared with other Meta companies or Meta company products. "This explanation should spec-

ify the purpose of data sharing, linking each type of data to its corresponding purpose," it said. The watchdog also said that

sharing of user data collected on WhatsApp with other Meta companies or Meta company products for purposes other than for providing WhatsApp services shall not be made a condition for users to access WhatsApp Service in India.

On sharing of WhatsApp user data for purposes other than for providing WhatsApp services, CCI said all users in India (including users who have accepted 2021 update) will be provided with the choice to manage such data sharing by way of an opt-out option prominently through an in-app notification. (PTI)

Quality (NSQ) medicines. Over fifty such medicines were recently flagged by the Central Drugs Standard Control Organization (CDSCO), raising concerns about substandard and potentially harmful drugs in circulation.

The CDAA resolved to appeal to the state government for the establishment of district-level testing laboratories to regularly evaluate pharmaceutical products and identify NSQ medicines. Delegates emphasised that such measures are critical for ensuring public safety and maintaining the quality of medicines. Concerns were also raised about how aggressive discount policies might contribute to the prevalence of substandard drugs.

At a joint press briefing, CDAA president Dr NL Agarwala, general secretary Jitu Barman, and spokesperson Debashish Swami reiterated the urgency of addressing the NSQ medicine issue. They announced plans for a new test laboratory under the Department of AYUSH in Assam and called on the government to expedite the establishment of district-level facilities.

Currently, the region has only one functional test laboratory, underscoring the pressing need for more infrastructure. The leaders stressed the responsibilities of the CDSCO under the Drugs and Cosmetics Act, including drug approval, clinical trial oversight, and collaboration with state drug regulators to uphold stringent quality standards.

The meeting reflected the association's proactive approach to tackling challenges in the pharmaceutical trade, highlighting its commitment to public health, professional ethics, and the welfare of the community.

# **Cop29: Commitments**

The Draft Communique of G20, the countries which are responsible for 80 per cent of global emissions, circulated on November 19, 2024, doesn't mention "transitioning away from the fossil fuels" the phrase already agreed upon at COP28. G20 summit (November 18-19) at Brazil thus displays a stark failure, as far as climate action is concerned, on the one hand, while COP29 in midway at Baku in Azerbaijan has turned into a stage for theatrics, and time is running out for an effective agreement on key issue of considerably scaling up necessary funding the climate action to save the planet Earth. Despite an early breakthrough in COP29 (November 11-22) on standards that is likely to pave the way for a UN-governed carbon market, the talks on climate finance have been slow and contentious, with delegates digging in their heels rather than looking for common ground. It is frustrating before COP29 closes on November 22. As COP29 climate talks in Baku entered their final week, the UN climate chief Simon Stiell had to tell negotiators on Monday to "cut the theatrics," get down to business and hammer out a new finance deal to compensate countries for climate-driven damages and pay for a clean-energy transition.

"Bluffing, brinksmanship, and pre-mediated playbooks" are burning up precious time and running down the goodwill needed for an ambitious package, emphasized Mr. Stiell, the Executive Secretary of the UN Framework Convention on Climate Change(UNFCCC). Mr. Stiell's plea comes after the concern expressed by UN Secretary-General António Guterres in Rio de Janeiro, where G20 summit is being held, over the state of negotiations at COP29. The Draft G20 leaders' communique focuses on the 2 degree Celsius, which was upper limit of the Paris Agreement of 2015 but the countries had agreed to keep warming below 1.5 degree Celsius by 2030, that is clearly a back-tracking. Far worse, not mentioning "transition away from fossil fuels" agreed upon at COP28, while mentioning the need for scaling up public and private climate finance and investment for developing countries and a successful New Collective Quantified Goal (NCQG) outcome in Baku, is clearly hypocritical. "We reaffirm the Paris Agreement temperature goal of holding the increase in the global average temperature to well below 2 degrees Celsius above pre-industrial levels and pursuing efforts to limit temperature increase to 1.5 degrees Celsius above preindustrial levels, recognizing that this would significantly reduce the risks and impacts of climate change. We underscore that the impacts of climate change will be much lower at the temperature increase of 1.5 degrees Celsius compared with 2 degrees Celsius and reiterate our resolve to pursue efforts to limit the temperature increase to 1.5 degrees Celsius. "Silence on a new climate finance goal and refusal to address a fossil fuel phase-out are unacceptable from the world's largest economies and highest emitters. As uncertainty grows at COP29, the moment demands political leadership - not passive repetition of past agreements," said the Climate Action Network in a statement.

Negotiation in Baku is primarily focused on how to pay for transition away from burning fossil fuels and how to equitably support climate adaptation. For this a considerably increased financing in necessary, since estimated adaptation finance gap is in the range of USD 187-359 billion per year as per Adaptation Gap Report 2024. The annual financing pledge was of on \$100 billion set in 2009 which is to expire this year. However, it was for the first time in 2022, the annual target was achieved in 2022 when it reached USD 115.9 billion. Based on modelled projections using the United Nations Global Policy Model, developing countries would need about \$1.1 trillion in climate finance from 2025 and some \$1.8 trillion by 2030.UNCTAD says that the new climate financing contribution target for developed economies would be \$0.89 trillion from 2025 and \$1.46 trillion by 2030.

itcoin has been rising over the past few weeks and it is currently trading at above \$90,000. With the \$92,000 level breached, Bitcoin seems headed for the \$100K mark. Bitcoin has surged 36.33% in 1 month, over 20% in 7-day and 3.45% in 24 hours. In a year-long period, BTC has surged a whopping 147%. For the critics of Bitcoin, it's a challenging moment. Crypto billionaires and organizations donated handsomely to Trump's campaign as he promised to support the cryptocurrency industry. He also promised he would remove SEC chairperson Gary Gensler. Now that Trump has won the election and is slated to take over as the US President in January 2025, Bitcoin's value is skyrocketing. Elon Musk, with all his technology companies and crypto assets, supported Trump. Time for all these geeks to cheer!

Oil producer Azerbaijan, the host of this year's 29th Conference of the Parties (COP), is tasked with the limited goal of rallying countries around a target for annual financial aid for developing nations facing the rising costs of climate change.

It is a mandate that pales in comparison with the agenda for next year's confabulations in Brazil's Amazon rainforest, where governments will chart a course for the next decade. But it is considered all-important for many countries ahead of Brazil's COP30 and achieving it requires

subtle diplomatic skills.

The trickiest issue facing the climate negotiations at COP29 goes by the fancy name of the new collective quantified goal" (NCQG), as it sounds more dignified than a "climate dereliction fun" to be funded by the developed world. The NCOG is meant to replace the longstanding goal of an annual spending \$100bn a year on climate finance from richer countries to poorer ones. It is supposed to be in place by next year, when all countries are expected to say what they are going to do to cut emissions in the next

A report in The Economist says that the good news is that in many of these countries, a little help from public financing can go a long way towards luring investors and cutting down borrowing costs.

Another trickier issue is how to disburse this fund? The Economist's report says that a package of bilateral deals between rich and developing countries would expose funding to geopolitical whims and make it hard to track total commitments. It would probably be wasteful, too, as richworld governments seek a return on their investments by demanding that the money is used to purchase their own equipment.

The Economist's report further savs that it would be wiser to entrust the World Bank with such a mission. That would require the lender to grow: the ETC's recommended climate-finance pot is worth about six times what the bank doles out in a year.

In real terms COP29 is expected to build on the carbon market groundwork laid in prior COPs, aiming for a regulatory framework that ensures real, measurable emissions cuts. The International Institute for Sustainable Development says that clearer guidelines are essential for a functional and fair carbon mar-

COP29could be a decisive moment for determining how carbon markets can become a reliable tool for financing climate action or whether they will remain mired in regulatory uncertainty.

In communicating priorities for COP29, the United Nations outlined the importance of ensuring that vulnerable countries have access to resources without bureaucratic delays. Climate-driven economic losses are estimated in the hundreds of billions annually, and without improved climate funding, vulnerable countries face extreme financial strain.

In Baku, discussions are expected to focus on setting up the fund's governance structure, mobilising resources, and scaling-up

current pledges and actual needs. It is expected that any progress on adaptation and loss-and-damage could bring life-changing support for millions of people worldwide, providing an essential safety net

as climate impacts intensify. Meanwhile. India expressed serious concern about the progress the COP29 made during the week. A GoI statement stated, "We have seen no progress in matters that are critical for developing countries. Our part of the world is facing some of the worst impacts of climate change, with far lower capacity to recover from those impacts or to adapt to the changes to the climatic system for which we are not responsible.'

India stressed that the Mitigation Ambition and Implementation Work Programme (MWP at Sharm Al-Sheikh was established with specific mandate that it shall be operationalised through focused exchanges of views, information and ideas, noting that the outcomes of the work programme will be non-prescriptive, nonpunitive, facilitative, respectful of national sovereignty and national circumstances, while taking into account the nationally determined nature of nationally determined contributions and will not impose new targets or goal.

Expressing frustration on the unwillingness to engage on this issue by the Developed countries during the past week, India asserted that those with the highest capacity to take climate action have continuously shifted goalposts, delayed climate action, and consumed a highly disproportionate share of the global carbon

But these solutions require integration within wider climate policies and identifying areas where real action is needed. COP29 will likely see a stronger emphasis on nature-positive initiatives, which not only support carbon sequestration but also enhance resilience against climate impacts like floods and droughts.

As noted by the World Economic Forum, protecting nature is essential for sustaining the world's carbon sinks, including forests, which currently absorb about 7.6 billion metric tons of CO2 each year. Recognising and scaling nature-based solutions would play a role in closing the emissions gap and offer numerous co-benefits for ecosystems and

On November 12th, multilateral development lenders including the World Bank pledged to increase their climate finance to \$120bn by 2030 (including \$42bn for adaptation). In Baku, any breakdown of talks over climate finance would be an abdication of responsibilities by the developed world. It would also be a massive failure of imagination, if delegates are unable to thrash out a workable formula at this year's

In the face of accelerating climate impacts, COP29 offers a critical opportunity for countries to act decisively. It is one of the last chances left to limit global warming below potentially catastrophic levels. From ramping up national commitments to refining the structure of carbon markets, there is much work to be done.

## No men, marriage, motherhood: Why South Korea's '4B' movement is inspiring American women

n South Korea, a growing number of young women are rejecting societal expectations of marriage, motherhood and heterosexual relationships, known as the "4B Movement" or the "4 Nos"

The "B" is a homophone for the Korean word bi meaning "no", representing the movement's four principles: bihon (no marriage), bichulsan (no childbirth), biyeonae (no dating) and bisekseu (no sex).

By refusing to marry, have children, engage in romance, or participate in sexual relationships with men, 4B feminists seek to redefine their lives outside the confines of traditional

In the wake of the reelection of Donald Trump, there has been increased interest in the 4B movement from women in

But what is the 4B Movement, where did it come from, and how is it reshaping the feminist landscape in South Korea and

**Challenges facing young women** 

The 4B Movement reflects a broader dissatisfaction among young South Korean women who face instability of housing, digital sexual violence, economic disparities and cultural

It emerged in the mid- to late-2010s, following a surge of interest in feminism in South Korea, and spread primarily through women's online communities.

The roots of the 4B Movement lie in South Korea's rapid economic transformation and the subsequent challenges it posed for younger generations of the 2000s.

For young women, economic insecurity is compounded by systemic gender inequality. South Korea consistently ranks worst in the OECD for the gender wage gap, and social mobility remains limited.

Against this backdrop, traditional life paths - marriage, childbearing and homemaking – have become less appealing. Living an alternative life without men emerged as a radical strategy for young digital feminists to challenge the rigid patriarchy in South Korea.

The senseless killing in 2016 of a woman in a train station toilet by a man in Seoul shocked the nation and fuelled the movement. Online platforms became spaces where women could share their frustrations, critique patriarchal norms and organise protests.

During this period communities like radical feminist online groups gained traction. Among these was the Tal-Corset (escape the corset) movement, which encouraged women to reject societal beauty standards by foregoing makeup, cosmetic surgery and restrictive clothing.

The 4B Movement built on this momentum, targeting not only beauty standards but the very institutions that sustain

It collectively challenges the notion that women's value lies in their ability to support men and sustain the family unit.

'Not a baby-making machine' The birth rate in South Korea ranks among the lowest in the world. The government has long viewed this as a national crisis. Policies such as subsidised housing for newlyweds and tax incentives for families have sought to encourage marriage

and childbearing. In 2016, the government launched a national pink birth mar visualising the number of women of reproductive age in each district. It sparked outrage. Women criticised it as reducing them to reproductive tools, proclaiming, "my womb is not national property" and "a woman is not a baby-making ma-

chine". For many 4B feminists, these policies represent a stark example of how the state prioritises population growth over women's autonomy. In response, the movement frames its rejection of marriage and motherhood as an act of political re-

Living on their own terms

Despite its growing influence, the 4B Movement faces sig-

nificant challenges The radical principles have sparked backlash, with critics labelling participants as selfish or anti-social. Swearing off men as a form of protest against patriarchal structures and traditional marital norms is sometimes (mis)interpreted as implicitly favouring lesbianism, given its stance against heterosexual relationships.

The movement has also attracted negative political attention. Lee Seung-cheon, a 58-year-old Democratic Party candidate, pledged to introduce "measures to reject the 4B Movement" as part of his policy campaign in 2020.

Yet 4B feminists remain steadfast in their vision of a future where women can live on their own terms. Their rejection of traditional life paths is not a retreat into isolation but an attempt to create new ways of being free from patriarchal con-

As one participant noted, rejecting marriage allows women to envision futures beyond societal deadlines like "a woman's age has an expiration date".

An international movement

The 4B Movement's radical critique of patriarchy has resonated internationally.

4B Movement ideas are starting to strike a chord in the US. The movement's core principles align with broader feminist critiques of patriarchy and capitalism, which have intensified in response to political developments such as Trump's rhetoric and debates over reproductive rights.

In the US, Trump's presidency (and now his return) has been a flashpoint for feminist activism. Policies restricting access to abortion, coupled with an increase in conservative rhetoric around women's rights, have galvanised movements that resist patriarchal structures.

For American feminists, the 4B Movement offers a framework for resistance that goes beyond economic precarity. It provides a roadmap for rejecting political conflicts, focusing on reclaiming agency by prioritising autonomy over their own bodies and rights.

6B4T is inspired by the 4B Movement and has gained particular attention in China. This version incorporates additional principles, including rejecting consumerism and fostering mutual aid among unmarried women.

The spread of 4B ideas across Asia and beyond highlights the universality of feminist struggles. As the movement continues to evolve, its impact extends beyond South Korea, sparking conversations about gender, autonomy and the future of feminism.

Whether embraced or contested, the 4B Movement forces society to confront uncomfortable truths about the cost of sustaining patriarchy – and perhaps the possibilities of living without it. (Courtesy: Scroll.in)

# The role of women in Assamese society

omen have been integral to Assamese as gral to Assamese society, playing pivotal roles in family structures, ecoactivities, cultural nomic preservation, and social movements. Their experiences and contributions have evolved significantly over time, influenced by historical developments, socio-political changes, and economic transformations. Woman in Assam enjoyed a relatively elevated status compared to their counterparts in other regions of India, particularly within matrilineal communities like the Khasis and Jaintias. In these societies, lineage and inheritance are traced through women, granting them a degree of autonomy and authority within their households. Women actively participated in agricultural activities, trade, and cultural practices, often serving as custodians of tradition. Their roles were not confined to the domestic sphere; they were recognized as important contributors to the economy and the community's

The advent of British colonial rule in the 19th century marked a turning point in the status of women in Assam. While colonial policies introduced new educational opportunities for some women, they also reinforced patriarchal norms that marginalized traditional roles. The introduction of Western education and legal reforms alwomen's societal positioning, leading to a gradual shift in gender dynamics. Although some women began to access education and engage in social reform movements, many were still confined to domestic roles, facing the dual burden of household responsibilities and societal expectations.

In the post-independence era, the constitutional guarantees of gender equality and the right to education provided a framework for advancing women's rights in Assam. However, the gap between legal provisions and social realities remained wide. Societal attitudes often lagged behind these reforms, with women predominantly viewed as homemakers. The emphasis on traditional gender roles continued to restrict women's autonomy and opportunities for personal and professional development. Cultural expectations around marriage and motherhood often overshadowed women's aspirations for education and careers, leading to a persistent cycle of in-

equality. Culturally, women in Assam have been vital to the preservation and promotion of Assamese traditions. They are central to the region's cultural identity, participating actively in folk music, dance, and various art forms that reflect the richness of Assamese heritage. Festivals such as Bihu showcase women's contributions. where they engage in traditional dance and song, celebrating their connection to the land and community. The mekhela chador, the traditional attire worn by women, symbolizes both elegance and the intricate artistry that has been passed down through generations. These cultural expressions empower women, allowing them to assert their identities while navigating the societal expectations imposed upon them.

Despite their cultural significance, women in Assam continue to confront numerous challenges. Socioeconomic factors play a crucial role in shaping their experiences. While women have always contributed to agricultural and economic activities, their work is frequently undervalued and overlooked. Many women remain economically dependent on male family members, limiting their agency and decisionpower. making dependence perpetuates cycles of poverty and inequality, emphasizing the need for economic empowerment as a vital component of women's rights.

Education emerges as a key factor in promoting gender equality in Assam. Although literacy rates among women have improved, significant disparities persist, particularly in rural areas. Cultural attitudes and economic constraints often hinder girls' access to education, perpetuating cycles of poverty and dependence. Early marriage and childbearing further limit educational opportunities, resulting in a workforce that often lacks the necessary skills for socioeconomic advancement. Comprehensive strategies are essential to prioritize girls' education, creating supportive environments that facilitate learning and growth.

The rise of women's movements in Assam has been crucial in advocating for women's rights and addressing various issues, including domestic violence, trafficking, and economic exploitation. Grassroots organizations and NGOs have emerged to support women, providing resources and assistance to those facing abuse or discrimination. These initiatives empower women to reclaim their rights and challenge societal norms that seek to marginalize them. The push for increased representation in local governance has also gained momentum, with women's participation in decision-making processes recognized as essential for fostering inclusive development.

Self-help groups (SHGs) have become a powerful tool for women's economic empowerment in Assam. # Enhancing the Namo Drone Didi Yojana empowers eye lashes women in agriculture

cross cultures and worldwide, eyes have always played a central role in defining beauty and allure. For centuries, people have sought to enhance the appearance of the eyes through the use of various pigments and colours. Eyelashes are the thickest hairs on our body.

Nothing enhances eyes better than having long, lush lashes. Eyelashes enhance the natural beauty of the eyes by making eyes seem bigger and more alert. The upper eyelashes are arranged in five to six rows with approximately 90 to 150 lashes per eye, whereas lower evelid lashes have between 75 to 80 lashes in four rows. Healthy eyelashes can grow to around 12 millimetres and have a slight curvature.

Like other hair on our bodies, eyelashes have a protective function.

They trigger blinking when touched and serve as the first line of defence to delicate eyes creating a barrier against environmental elements like wind, dust and rain. While the eye is open, eyelashes work almost like an air filter: stopping most airborne debris and dirt from reaching the delicate eye. When eyes are closed, lashes form an extra barrier against foreign irri-

Not everyone is blessed with long, thick lashes, but that doesn't mean that you can't get them;

At night, use a cleansing gel and cotton wool to remove eye make-up gently. For upper lashes, put a cleanser on cotton wool and wrap it around your index finger. Brush through the lashes from underneath. To remove mascara from the lower lashes, use a cotton bud with a little cleanser on

it. To remove kajal from the lower lashes use a cotton bud that has a little cleaner on it. Also, clean the corners of the eyes with a cotton bud.

Use very gentle movements on the lashes. Brush your lashes with an eyelash brush, so that they are not entangled. Heavy eye makeup, too much mascara and even eyelash extensions can damage and lead to loss of lashes.

If you have very thin or sparse eyelashes, it may become a problem and you may wonder how to encourage their growth. You can apply very little oil on the eyelashes, using a cotton bud. You may apply almond oil, coconut oil, or olive oil. Leave it on for 15 to 20 minutes and wipe off very gently with moist cotton wool. Do not go to sleep with oil on the eyelashes, as this can lead to puffy eyes.

Curry leaves are also said to help. Keep curry leaves in hot water and leave it to cool. Then make a paste of the curry leaves and apply to the lashes, again using a cotton bud. Apply very little and wash off with water

after 15 minutes. You can also apply aloe vera gel. You can take the gel from the aloe vera growing in your house. The gel obtained from the plant itself is the leaf pulp and is found in the inner portion of the leaves.

First, wash the leaf well and observe total hygiene while extracting the gel. Apply a small amount of aloe vera gel on the evelashes before bed and wash it off in the morning.

**Castor oil:** Apply a small amount of castor oil on the eyelashes each night before bed and wash it off in the morning

Eyelid massage: Gently massage eyelids along the

Nowadays new eyelash serums is available, to help enhance the growth of natural evelashes. It also improves the health and texture of sparse and brittle lashes. In serum form, it is easy to apply and includes a brush applicator. Follow the directions on the label.

Mascara adds glamour and thickness to the eyelashes. But, mascara must be removed at night, along with the rest of your eye makeup. Roll-on mascara is easy to apply. You can apply the mascara both above and below the upper lashes. This gives a thicker look.

Apply on the lower lashes too. Wait for a while and apply a second coat. Then brush out the lashes, with a small eyelash brush, otherwise, the lashes will stick together. The idea is to achieve a natural effect. You can apply a little powder on the eyelashes between two coats of mascara, to make them look thicker.

The latest in eye glamour is eyelash extensions. They are attached to natural eyelashes, one by one to make the lashes look thicker. A trained beautician has to attach them. It's up to you to decide how thick you want your lashes to be.

The eyelash extensions may last for about 3 weeks to a month and then you will have to get them done again. The eyelash extensions are synthetic strands that are specially curved to look like natural eyelashes. If you apply mascara on eyelash extensions, use the water-based kind.

You can also ask your doctor to prescribe supplements of Vitamin - A, which encourages hair growth. (The author is an international fame beauty expert and is called the Herbal Queen of India)

Globally, drone technology has revolutionized many industries, including agriculture. In India, drones have immense potential: they can survey large areas, monitor crops, detect diseases or pests in advance, and facilitate precise application of pesticides and fertilizers. This precision farming approach increases crop yields while reducing costs and waste associated with traditional farming methods.

However, the adoption of drones in Indian agriculture has been slow. High costs, limited awareness, and inadequate technical infrastructure in rural areas have hindered widespread implementation. To address these challenges, the Namo Drone Didi Yojana not only promotes drone technology but also empowers rural women.

Drones deployed in Maharashtra enabled farmers to better estimate yields and increase productivity. Drones allow variable-rate application of inputs such as nutrients, adjusting according to specific field needs, maximizing input efficiency. In Uttar Pradesh, drone-assisted farming enabled farmers to precisely apply fertilizers based on soil fertility variations, thereby increasing nutrient use efficiency.

Automation in drone technology reduces human error in tasks such as spraying pesticides or fertilizers, leading to more effective operations. A pilot project in Madhya Pradesh showed fewer errors in pesticide spraying, leading to a 15% im-

provement in crop yield. Drones help assess moisture levels in the soil, allowing for precise irrigation, thereby conserving water and ensuring that only the required areas receive water.

Drone-assisted irrigation reduced water use by up to 15% in water-scarce areas of Gujarat. Input cost reduction: With precise use of inputs such as fertilizers and pesticides, farmers save costs, thereby contributing to better resource management. Self-help groups in Punjab reported 20% cost savings on inputs by using drones under the Namo Drone Didi scheme. Drones reduce the need for manual labor in tasks such as spraying pesticides and fertilizers, helping farmers cut down labor costs and improve operational efficiency.

Farmers in Haryana experienced up to a 25% reduction in labor expenditure after adopting drone services under Namo Drone Didi. Drone technology significantly reduces the time required for tasks such as spraying and monitoring large farms, thereby improving overall agricultural productivity.

In Rajasthan, drone-assisted pesticide spraying reduced the time taken for operations from 7 days to 2 days, significantly increasing productivity. By addressing these challenges, this initiative can serve as a model for other developing countries seeking to boost agricultural productivity while promoting gender equality and rural technological advancement. # Putin signs new Russian nuclear doctrine after Biden's arms decision for Ukraine

dent Vladimir Putin on Tuesday signed a revised nuclear doctrine declaring that a conventional attack on Russia by any nation that is supported by a nuclear power will be considered a joint attack on his country.

Putin's endorsement of the new nuclear deterrent policy comes on the 1,000th day after he sent troops into Ukraine, on Feb. 24, 2022.

It follows U.S. President Joe Biden's decision to let Ukraine strike targets inside Russia with U.S.-supplied longer-range missiles.

The signing of the doctrine, which says that any massive aerial attack on Russia could trigger a nuclear response, demonstrates Putin's readiness to tap the country's nuclear arsenal to force the West to back down as Moscow presses a slowmoving offensive Ukraine.

Asked whether the updated doctrine was deliberately issued on the heels of Biden's decision, Kremlin spokesperson Dmitry Peskov said the document was published "in a timely manner" and that Putin instructed the government to update it earlier this year so that it is "in line with the

Russia's president has previously warned the U.S. and other NATO allies that allowing Ukraine to use Western-supplied longerrange weapons to hit Russian territory would mean that Russia and NATO are at war. The updated doctrine states that an attack against Russia by a nonnuclear power with the "participation or support of a nuclear power" will be seen as their joint attack on the Russian Federation.

### 45 pro-democracy activists get 4 to 10 years in prison in Hong Kong's biggest national security case

makers and activists were sentenced to four to 10 years in prison on Tuesday in Hong Kong's biggest national security case under a Beijing-imposed law that crushed a oncethriving pro-democracy movement.

They were prosecuted under the 2020 national security law for their roles in an unofficial primary election. Prosecutors said their aim was to paralyse Hong Kong's government and force the city's leader to resign by aiming to win a legislative majority and using it to block government budgets indiscrimi-

The unofficial primary held in July 2020 drew 610,000 voters, and its winners had been expected to advance to the official election. Authorities postponed the official legislative election, however, citing public health risks during the COVID-19 pandemic.

Legal scholar Benny Tai, whom the judges called the mastermind, received the longest sentence of 10 years. The judges said the sentences had been reduced for defendants who said they were unaware the plan was unlawful. However, the court said the penalties were not reduced for Tai and former lawmaker Alvin Yeung because they are lawyers who were "absolutely adamant in pushing for the implementation of the scheme"

In the judgment posted online, the judges wrote that Tai essentially "advocated for a revolution" by publishing a series of articles over a period of months that traced his thinking, even though in a letter seeking a shorter sentence Tai said the steps were "never intended to be used as blueprint for any political action"

Two of the 47 original defendants were acquitted earlier this year. The rest either pleaded guilty or were found guilty of conspiracy to commit subversion. The judges said in their verdict that the activists' plans to effect change through the unofficial primary would have undermined the government's authority and created a constitutional crisis.

The judges rejected the reasoning from some defendants that the scheme would never have materialised, stating that "all the participants had put in every endeavour to make it a success'

The judges highlighted that a great deal of time, resources and money were devoted to the organisation of the primary election.

"When the Primary Election took place on the 10 and 11 July, no one had remotely mentioned the fact that Primary Election was no more than an academic exercise and that the Scheme was absolutely unattainable," the judgment read. "In order to succeed, the organisers and participants might have hurdles to overcome, that

Chan Po-ying, wife of defendant Leung Kwok-hung, told reporters she wasn't shocked when she learned her husband received a jail term of six years and nine months. She said they were trying to use some of the rights granted by the city's miniconstitution to pressure those who are in power to address the will of the people.

"This is an unjust imprisonment. They shouldn't be kept in jail for one day," said Chan, also the chair of the League of Social Democrats, one of the city's remaining pro-

## Several children injured in car-ramming incident in China



**BEIJING, Nov 19:** Several children were injured when an SUV rammed into groups of parents and students outside a primary school in China's Hunan province on Tuesday, the third incident of killing of civilians within a fortnight in the country.

The incident took place in Changde city t around 7:30 am local time. The casualty count is not clear and authorities are yet to clarify if it was an accident or a deliberate attack. According to the state-run Xinhua news agency, multiple students were injured after being struck by the car. The injured have been rushed to a hospital. Further investigation is underway, it said. Video footage posted on social media showed screaming children and parents frantically running for cover to escape the speeding car. Later angry parents were seen beating up the driver after his capture.

Police have detained a 39-year-old man surnamed Huang who was driving the car. This is the third incident of killings or attacks in China by people in vehicles or

wielding knives.

On November 12, thirty-five people were killed and 43 injured when a man ploughed his car into a crowd of people at a sports centre in Zhuhai city. Police who detained a man called Fan said his actions stemmed from his dissatisfaction with the property division outcome of his divorce. Following the incident, Chinese President Xi Jinping and Premier Li Qiang have called on officials all over the country to step up security to prevent such attacks on civilians.

On November 16, eight persons were killed and 17 injured in a knife attack at a vocational school in Yixing city of Jiangsu province. The 21-year-old suspect, surnamed Xu, who was caught later confessed to police that he was angry over not receiving his graduation certificate due to failing exams and was dissatisfied with his intern-

Following the recurring attacks, the Supreme People's Procuratorate (SPP) -the highest national agency responsible for legal prosecution and prosecutorial investigation in China -- has pledged stern, strict and swift punishment for major vicious crimes to maintain social stability and enhance the public's sense of safety and wellbeing. According to an official statement, the SPP stressed a zero-tolerance approach toward crimes targeting students and compromising school safety.

The meeting underscored the importance of prosecuting such cases decisively and swiftly to deliver a powerful deterrent effect. It highlighted that prosecutorial bodies are critical in preventing and resolving risks and maintaining social stability through case handling.

The meeting also urged prosecutors to resolve disputes at their source through legal channels at every stage of case handling, to defuse potential risks before they

China has been witnessing numerous attacks on civilians which are mostly attributed by police to disgruntled elements in the society. Most of such attacks this year targeted primary schools.

Last month, five people, including three children, were stabbed near a primary school in Beijing's Haidian district. Similarly, three people, including two students, were injured by a 60-year-old knife-wielding man in Guangzhou city. In May, two people were killed and 10 others injured in a knife attack at a primary school in Jiangxi province. (PTI)

LAHORE, Nov 19: Shah Mahmood Qureshi, Pakistan's former foreign minister and vicepresident of jailed former prime minister Imran Khan's party, and 20 other leaders were indicted by a court here on multiple charges related to the May 9, 2023 riots, a court official said on Tues-

Qureshi described the charges, framed during a hearing held at Kot Lakhpat Jail here on Monday, as baseless and politically motivated and said the cases were designed to suppress Pakistan Tehreek-e-Insaf's (PTI) leadership.

Among the senior party leaders indicted by the Anti-Terrorism Court (ATC) were PTI's Punjab president Dr Yasmin Rashid, Senator Ejaz Chaudhry, former Punjab governor Omar Sarfraz Cheema, former provincial minister Mian Mahmoodur Rasheed, ex-lawmakers Aliya Hamza and Rubina Jamil, and social media activist Sanam Javed.

resided over by ATC judg Manzer Ali Khan. Qureshi was transported to the court from Rawalpindi's Adiala Jail.

A special prosecutor presented the charge sheets, which included accusations of attacking a police station, torching public property, and assaulting law enforcement personnel.

According to the court official, all accused individuals denied the allegations, pleaded not guilty, and expressed their intent to contest the charges, asserting that the prosecution lacked evidence to substantiate its claims.

The court directed the prosecution to present its witnesses during the next hearing, scheduled for November 25. On May 9, 2023, Khan's party workers vandalised a dozen military installations, including the Jinnah House (Lahore Corps Commander House), Mianwali Airbase and the ISI building in Faisalabad. The Army headquarters (GHQ) in Rawalpindi was also attacked by the mob for the first time.

Speaking to reporters outside the jail, Qureshi reaffirmed his allegiance to Khan, who remains incarcerated since August 2023 in over 200

Qureshi described the cases as baseless and politically motivated, designed to suppress PTI's leadership and unlawfully keep them behind

## G20 fails to give clear signal on climate finance, but support for multilateralism key: Experts

**19:** G20 leaders have not given a strong signal to negotiators trying to agree on a new finance package to support climate action in developing countries, many climate ex-

However, they say it is important that the 20 richest nations in the world, accounting for 80 per cent of global greenhouse gas emissions, have reaffirmed their support for multilateralism and the UN climate convention to solve climate problems.

This comes amid concerns about the US and Argentina pulling out of the Paris Agreement, which has hurt the morale of negotiators at the talks in Baku. The G20's pushback on "unilatCarbon Border Adjustment Mechanism, is also seen as crucial for developing countries.

That said, experts note some key gaps in the G20 statement. It does not explicitly mention transitioning away from fossil fuels or mobilising resources to address loss and damage caused by climate change.

Vaibhav Chaturvedi, a senior fellow at the Delhi-based Council on Energy, Environment, and Water, said the G20 is not the right platform to discuss the new climate finance package being negotiated at COP29 under the UN-FCCC process.

The real issues about quantum and who will contribute are not addressed at the G20. These questions go beyond the G20, he said He added that the G20 leaders'

emphasis on multilateralism is important. "This is one of the first points in the climate section. Despite uncertainties like the US and Argentina pulling out, they have stressed that the multilateral

process is key," Chaturvedi said. Harjeet Singh, climate activist and Global Engagement Director for the Fossil Fuel Non-Proliferation Treaty Initiative, criticised developed nations in the G20 for failing to specify the trillions needed or ensure funds are given as grants, which are crucial for climate justice.

"Without decisive progress on finance at COP29, we are steering



towards a catastrophic temperature scenario, where the most vulnerable will bear the gravest consequences," he said.

Trishant Dev, a programme officer at the Delhi-based Centre for

Science and Environment, welcomed the G20's stand against restrictive trade measures. He said such measures hurt developing countries and need to be aligned with the principle of Common but

Differentiated Responsibilities (CBDR). The G20 declaration could pressure countries to discuss these issues at COP29, especially since developed nations often use climate action to justify these trade policies, he said.

Chaturvedi added that the G20 had made it clear that unilateral measures should not be used as unjustified trade restrictions.

Securing agreement on a new climate finance package to help developing countries cut emissions and adapt to climate change is a top priority for this year's UN climate talks. Different estimates suggest that USD 1.3 trillion is needed annually to tackle worsen-

ing climate impacts. But countries are struggling to

agree on how much money is needed, how the package will work, and who will contribute. For developing nations, restric-

tive trade measures are another major concern.

Last week, India argued that these measures unfairly shift the burden of transitioning to lowcarbon economies onto developing and low-income nations. At the same time, developed nations, which have historically caused the most emissions, are not meeting their climate finance commit-

UN climate chief Simon Stiell on Saturday also urged G20 leaders to carry out rapid cuts in emissions to prevent climate-driven economic carnage. (PTI)

CHURACHANDPUR, Nov 19: Hundreds of people took to the streets with empty coffins in Manipur's Churachandpur district on Tuesday, demanding justice for those killed in a gunfight with the security forces in Jiribam.

Ten suspected militants were killed in the gunfight with security forces last week after insurgents in camouflage uniforms, armed with sophisticated weapons, fired indiscriminately at the Borobekra police station and an adjacent CRPF camp at Jakuradhor in Jiribam, according to the Manipur Police. The rally, organised by the Joint Philanthropic Organisation (JPO),

started around 11 am. Hundreds of people participated in it with placards demanding justice for those killed, and a separate

administration in the hill areas. The march concluded at the

'Wall of Remembrance', a memorial for the Kuki people killed in the ethnic violence in the state

since May last year. Later, a memorandum addressed to Union Home Minister Amit Shah was submitted to the district administration

The Kuki-Zo groups have been claiming that those killed in Jiribam were village volunteers. However, the state police pointed to a huge number of arms and ammunition that were found at the spot after the gunfight was over to ounter the claim.

The matter in question pertains to an internal family issue within the village of Liangmai people, the LNC-M also said. "Such issues fall under the purview

#### Suspension on broadband services lifted in Manipur

IMPHAL, Nov 19: The Manipur government has conditionally lifted the suspension on broadband services three days after imposing it, considering the hardships faced by common people, healthcare facilities, educational institutions and other offices. Mobile internet services, however, remained suspended, according to an order issued by Home Commissioner N Ashok Kumar.

The government, however, decided to keep the ban on mobile internet data, according to the order. The administration imposed the suspension on November 16 in seven districts - Imphal East and West, Bishnupur, Thoubal, Kakching, Kangpokpi and Churachandpur – for two days to prevent anti-social elements from spreading content that might create law and order problems.

The suspension was extended for two more days on Monday. (PTI)

#### Lone slams 0mar govt over 'steep hike' in power bill

SRINAGAR, Nov 19: Peoples Conference president Sajad Gani Lone on Tuesday hit out at the National Conference government in Jammu and Kashmir over the

'steep hike in electricity bills". Claiming that the electricity bills were higher by nearly 50 per cent, Lone, who is MLA from Handwara, criticised the ruling party for creating an "electricity mess" and demanded immediate intervention.

LUCKNOW, Nov 19: It is BJP versus the SP as Uttar Pradesh gets ready for bypolls in nine assembly seats on Wednesday, which are being viewed as the first electoral battle after the Lok Sabha polls.

While the Congress is not contesting the bypolls and supporting its INDIA bloc partner Samajwadi Party, the Bahujan Samaj Party is contesting all nine seats on its

The Asaduddin Owaisi-led AIMIM too has fielded its candidates from Ghaziabad, Kundarki and Meerapur seats, while the Aazad Samaj Party (Kanshi Ram) of Chandrashekhar has fielded candidates on all seats except Sisamau.

Ninety candidates are in the fray in the bypolls, with the maximum of 14 candidates in the fray from Ghaziabad assembly constituency, while the minimum count of candidates is five each from Khair (SC) and Sisamau assembly constituencies.

Though the results of the bypolls will not have any direct impact on the 403-member UP Legislative Assembly, it will send a message to various political par-

While the SP is aiming to increase its tally further in the House, BJP and its ally RLD will try to further consolidate their presence in the Assembly

At present, the BJP has 251 MLAs in the Assembly followed by the SP with 105 MLAs. BJP allies Apna Dal (Sonelal) has 13 MLAs, RLD has 8 MLAs, SBSP has 6 MLAs, and NISHAD party has 5 MLAs.

The Congress and Jansatta Dal Loktantrik have two MLAs each, while the BSP has one MLA.

This will be the first electoral test of the INDIA bloc as well as the NDA in the politically-crucial state after the Lok Sabha elections.

Ahead of voting, Samajwadi Party chief Akhilesh Yadav on Tuesday urged voters to vote for his party. In a post on X of the SP, he said, "I would like to ask all my voters, especially the young farmers, to help. The administration can only create disturbances in the elecwhat he described as "arbitrary and tions. I hope the administration will work to protect the rights to save the Constitution given by Babasaheb

Bhimrao Ambedkar."

UP BJP spokesperson Manish Shukla on Tuesday took a dig at the Samajwadi Party saying, "Samajwadi Party is afraid of losing the bypolls. Akhilesh Yadav wants to escape responsibility by blaming the Election Commission for the defeat".

"Due to fear of defeat, the SP is making childish demands from the Election Commission that identity cards should not be checked. Whereas in the past, women wearing burqas have been caught doing fake voting by wearing burqas."

Shukla was referring to a recent letter written by SP's UP unit chief Shyam Lal Pal in which he had requested the Election Commission to issue instructions that "on the day of polling, no police personnel should check the voter ID card of the voter.'

Pal, citing the handbook for returning officers, said on the day of polling, the ID of the voter could be checked by the polling officer.

RLD spokesperson Ankur Saxena said his party is going to retain the Meerapur seat, while the NDA will make a clean sweep by winning all the constituencies where bypolls are taking place.

Spokesperson of Uttar Pradesh Congress Manish Hindvi said, "The people of the state have made their choice clear in the Lok Sabha elections, in which the INDIA bloc got the maximum seats. This momentum will definitely carry on further in the bypolls."

Traders' body Bhartiya Udyog Vyapaar Mandal has also appealed to traders to ensure hundred per cent vot-

'We will first present an example through hundred per cent voting and then in subsequent elections, we will have dialogue with other organisations to join our endeavour," Ravikant Garg, president of the Bhartiya Udyog Vyapaar Mandal, told PTI.

## Tawde distributed cash to voters in Palghar, claims BVA leader Thakur; BJP denies

MUMBAI, Nov 19: BJP general secretary Vinod Tawde was caught in a huge row after Bahujan Vikas Aghadi (BVA) chief Hitendra Thakur on Tuesday accused him of distributing money to voters in Palghar on the eve of the Maharashtra assembly polls.

The saffron party denied the claims, while the opposition Maha Vikas Aghadi (MVA) accused it of misusing government machinery and engaging in corrupt practices. Tawde, however, asserted that he was in Nalasopara to provide guidance regarding election procedures and challenged the opposition parties to verify his activities.

Talking to reporters, BVA MLA Thakur said, "Some BJP leaders informed me that party general secretary Tawde had come to Virar to disburse ₹ 5 crore to influence voters. I thought a national leader like him would not stoop to such a trivial task. But I saw him here. I urge the Election Commission to take action against him and the BJP."

The BVA legislator alleged the hotel Tawde was staying shut the CCTV recording.

'The hotel administration seems to be in cahoots with Tawde and the BJP. They only activated their CCTV after we requested it. He was distributing money to manipulate voters," he said.

A video has surfaced on social media in which BVA workers can be seen confronting Tawde outside the hotel where he was staying.

Deputy Commissioner of police Purnima Chowgule Shringi of Zone II, Mira Bhayandar-Vasai Virar police commissionerate, confirmed that two first information reports have been registered at the Tulinj police station in connection with incidents linked to the hotel where the alleged cash distribution took place.

Without providing further details, she assured a thorough investigation into the incident.

The BJP, however, dismissed Thakur's claims, terming them as a mere publicity stunt.

BJP leader Pravin Darekar remarked, "The MVA has already lost the game. They are destined for defeat in this election, which is why they are making such absurd allegations against us.'

Talking to reporters later, Tawde said he was in Nallasopara to provide guidance regarding election procedures and not to distribute money. He further challenged opposition members to verify his activi-

Leaders of the opposition MVA demanded a comprehensive investigation by the Election Commission, with Shiv Sena (UBT) leader Sanjay Raut suggesting a conspiracy against Tawde by some BJP leaders.

Raut said, "No matter how much the BJP tries to hide, whatever happened in Nallasopara-Virar, it hap-



He also pointed out Tawde's substantial cash reserves, alleging he has the names of 18 people who disburse money with police escorts.

He expressed concern over the implications of Tawde being caught, claiming that prominent BJP leaders, including state Home Minister Devendra Fadnavis, were aware of his activities.

Raut said if the election commission had been unbiased, its officials would have conducted raids.

Maharashtra Congress president Nana Patole accused the BJP of misusing government machinery and indulging in corrupt practices, including distributing money to buy votes, fearing a defeat in the upcoming state assembly elections.

Speaking to the media, Patole criticised the BJP for using money power to manipulate the electoral process, arguing that this is an attempt to win the election through corrupt means, fearing a resounding de-

He said, "The Election Commission must ensure a fair and transparent election process. However, the series of events over the past month, including biased actions against opposition leaders, have raised concerns. Bags of opposition leaders have been checked under suspicious circumstances, and they've been prevented from flying in helicopters or airplanes, but no such scrutiny has been applied to the ruling party."

"Due to the crisis of fertilisers in every season under the BJP rule, this problem of the farmers has now become common. Has the BJP government not been able to estimate in 10 years how much fertilizer is needed in the country," she asked. (PTI)

NEW DELHI, Nov 19: The Congress on Tuesday claimed that the story of Maharashtra's agrarian distress is told in the crops of soyabean and cotton which are being procured below the minimum support price (MSP) due to the Mahayuti government's reluctance to follow up on its procurement promises.

Congress general secretary incharge communications Jairam Ramesh pointed out that the MVA has guaranteed legal status to MSP and a price of ₹ 7,000 per quintal of soyabean.

"A tale of Maharashtra's agrarian distress, told in two crops -Soyabean: Deputy Chief Minister Fadnavis promised ₹ 6,000 per quintal of soyabean in 2013, and announced an MSP ₹ 4,892 MSP this year. Currently, soybean is being sold at ₹ 3200 to ₹ 4,200 per quintal," he said.

Talking about cotton, Ramesh said during the MVA government, cotton used to fetch ₹ 12,000 to ₹ 12,500 per quintal. Today, the same cotton is being sold at throwaway prices, causing massive losses to farmers, Ramesh said.

"This is the result of the Mahayuti government's reluctance to follow through on its procurement promises and the BJP's reluctance to give legal status to MSP," the Congress leader said.

In contrast, he said, the MVA has guaranteed legal status to MSP, prices set by the Swaminathan Commission's formula of one-and-a-half times the comprehensive cost of cultivation and a price of ₹ 7,000 per quintal of soyabean. It is clear which way the farmers of Maharashtra will vote, Ramesh said.

# **Delhi Police arrests Chinese** national for cyber fraud



NEW DELHI, Nov 19: The Delhi Police has arrested a Chinese national for his alleged involvement in a cyber fraud of ₹ 43 lakh in Shahdara, officials said on Tues-

The arrest has helped the police unearth an online stock trading scam of more than ₹ 100 crore which was being orchestrated via social media groups, Deputy Commissioner of Police (Shahdara) Prashant Gautam said.

The accused has been identified as Fang Chenjin, a Chinese national residing at Safdarjung enclave, he said.

Sharing details on the probe, Gautam said, "A complaint was lodged at the cybercrime portal in July, were the complainant reported that he was lured into fraudulent stock market training sessions and subsequently tricked into investing ₹ 43.5 lakh in several transactions. These investments were directed to multiple bank accounts controlled by the fraudsters.

During the investigation, the police obtained details of the bank accounts to which the stolen funds were transferred and further analysed the call records of several suspected mobile numbers. A thorough investigation was conducted into the bank accounts and mobile numbers associated with all the suspects, and technical analysis revealed a link to fraudulent activi-

"We traced the funds to a bank account registered under the name Maha Laxmi Traders, located in Mundka, Delhi. This account was found to be involved in fraudulent ₹ 1.25 lakh made in April this year," he said.

Further inquiry led the police to a mobile number which was registered in the name of Fang, which led them to him. He was arrested after evidence from his mobile phone and social media chat logs related to the fraud were recovered, said the DCP.

The social media conversations between him and an associate clearly showed that he was directing the fraudulent activities, including the recharge of the mobile number used in the scam. Further probe revealed that Fang was linked to two other significant fraud cases involving cybercrime and money laundering in Andhra Pradesh and Uttar Pradesh, police

"There are also 17 criminal complaints registered with the cyber crime portal, all linked to the same Fincare Bank account with the total amount defrauded exceeding ₹ 100 crore," the DCP said, adding that the accused Chinese national revealed that he came to India on a work Visa for a Taiwani company in Andhra Pradesh in April 2020.

According to the police, Fang was even arrested by the Andhra Pradesh police in a cheating case that was registered on the complaint of the company's owner where he was working as a vendor.

"He spent around 7 months in jail in Tirupati jail in Andhra Pradesh," Gautam said.

The passport and visa of the accused were seized at the time of arrest by the Andhra Police. When the Delhi Police arrested him. Fang had no valid visa, he added. (PTI)




Earlier on Sunday, PM Modi said a fake narrative can persist only for a limited period of time, while referring to "The Sabarmati Report" film.

**NEW DELHI, Nov 19:** Superstar Shah Rukh Khan on Tuesday said his way of dealing with moments of despair in life is to shut himself up in his bathroom and cry before getting on with the next thing. Speaking at 'From Bollywood Superstardom to Business Success – Key Learnings On and Off Screen' session during the Global Freight Summit in Dubai, the actor-producer touched upon the failure of his movies before the COVID-19 pandemic, his philosophy on success and stardom, his childhood and how his goal is now to capture the young audience.

Shah Rukh admitted that he is selfcritical but does not show the moments of weakness to anyone.

"I cry a lot in my bathroom. You can wallow in self-pity for just about that much time and then you have to believe that the world is not against you. Your film did not go wrong because of you or because the world is conspiring to destroy your work. You have to believe that you made it badly and then you have to move on," he said.

One cannot blame life for failure, the actor said, adding that he tries to "recalibrate and come back"

Shah Rukh said he believes that success somehow leads to failure because of the isolation of ideas.

"You are so driven by success and that was my problem. I am very driven, I don't take things for granted, I was getting up in the morning and saying to myself, 'I need to keep doing this'... Success can isolate you and lead to failure.

While you are successful, you need to be aware that the world is changing around you. You need to look around, you can't be with blinkers on."

The 59-year-old actor, who made a successful comeback in 2023 with three hits in "Pathaan", "Jawan" and "Dunki", said if an artist is able to touch basic emotions, then their brand travels everywhere but it should also reflect the times. "If you live in a time of strife, your product needs to give you a feeling of safety. You feel that you are anti-establishment, want to change things, then my movie needs to show me as a hero who takes on the world...'

"My success came in the '90s when there was this opening up of my country India. We were going around the world and talking about India. The kind of cinema I did, 'tujhe dekha to ye jaana sanam' (referring to his 1995 hit 'Dilwale Dulhania Le Jayenge'), everybody liked it and some of them even got married watching this film 30 years ago. It had moments of happiness, love and Switzerland. It was the sign of times."

Asked about the advice he would give to his younger self, Shah Rukh thought about it for a moment and then said, "Maybe a better hairstyle and better fitting suits".

The actor said now that he has 35 years of experience in movies, he realises that many of the decisions that he took as a 25-year-old, he would not make them now if he looks back at

them through the lens of experience. "And maybe I wouldn't have reached

gance, being extremely stupid and silly but being extremely gutsy also."

The actor, who has three children --Aryan, Suhana and AbRam -- with wife Gauri, said his core competence is that he can "act a bit" and while that never changes, he keeps experimenting with his craft, technique and art within it.

"Now my focus is that my youngest kid should also think that I am a big enough star. He has not seen too many of my films. He is 11 years old. One day my elder kid came and said, 'You know, he knows you are a big star'. I want my son to experience stardom, knowing that I am a star is not good enough. If I can capture him as an audience then I am capturing the younger generation,"

Shah Rukh joked that whenever someone questions his stardom, he just needs to walk across to his house, stand on a railing and wave to the people.

"And I am very arrogant about it... Jokes apart, I am very humble and I bow to all of you for making this possible. I don't say this with humility but I say this with gratefulness 'Thank you for making me the star I am'," he said.

The actor also discussed how life has intermingled with social media and the youngsters are more video literate than the generation before. "You really need to focus while trying

to hold the attention of youngsters... I'm not saying the older people are boring and you can make them happy with small things but younger people have smaller attention spans so I measure my success by 'Can I hold the attention of a

younger audience now because there are so many other distractions'.'

Asked about his philanthropic endeavours, the actor said as someone who comes from a lower middle class background in India, he has deep respect for what he has received in life.

"I fully understand that my success is not just because of me, it is a confluence of a lot of people coming together whether through cinema or at a personal level... I can go and stand outside the railing of my house and nobody needs to love me back. It is a two way street. When you become the chosen one for some reason and you have this privilege of good fortune, then it is the natural consequence

that you share it with people who made it happen," he said. The actor said he lost his parents at a young age and the way he looked

and become successful so that his parents don't feel bad that thev couldn't fend for him. Shah Rukh also touched upon his image of a superstar, saying that despite the perception, he has always tried to stay true to who he is.

## Shafali dropped from Indian women's team for ODI series in Australia

NEW DELHI, Nov 19: Toporder batter Shafali Verma was on Tuesday dropped from India's 16member women's team for the three-match ODI series in Australia in December after a string of poor performances in the past one vear. The BCCI selectors seem to have once again lost patience with the 20-year-old right-handed batter, whose recent ODI form has been disappointing. Shafali has scored just 108 runs in six matches this year with 33 being the highest.

She was dropped in December last year from the team midway during the home ODI series against Australia on the basis of her poor run, before making a comeback against South Africa in June this year in Bengaluru.

In fact, the youngster, rated as the next big thing in Indian women's cricket when she broke into the team in 2021, has not scored a ODI half century since making an unbeaten 71 against Sri Lanka in Pallekele in July 2022. Her next highest score was a 49 against the same opponent in the

man Gill's thumb fracture is certainly a "jolt" for India ahead of the series opener against Australia but former captain Sourav Ganguly firmly believes the team has the quality and mental fortitude to overcome the recent shock loss at home in the Border-Gavaskar Trophy starting in Perth from Friday.

Gill, who has five hundreds in 29 Tests, had scored a fifty in Melbourne and a game-setting 91 at Brisbane in the two victories on the previous tour.

He suffered a left thumb fracture while fielding in the intrasquad simulation between senior team and India A, ruling him out of the first Test.

"Shubman's injury is jolt for the team no doubt as he is an inform batter and has scored in Australia. A thumb fracture could rule him out for two Tests. "But I believe the other bat-

ters would step up in absence of Rohit (on paternity leave) and Shubman during the first Test. I don't think New Zealand defeat would have any bearing on this series," the former BCCI president told PTI in an interview ahead of the marquee series.

With Hardik Pandya not playing Test cricket anymore, India don't have too many genuine pace bowling all-rounders and while Nitish Kumar Reddy is still very raw, one of India's finest captains feels that the

# Bumrah is 'Cat burglar' for Brett Lee, India's 'X-factor' for Head

PERTH, Nov 19: Dubbed as the bowler "impossible to face" by swashbuckling Australian batter Travis Head and a "cat burglar" by former tearaway pacer Brett Lee, Jasprit Bumrah's reputation precedes him.

The India pacer, who is set to captain India in the first Test of the five-match series starting here Friday, has left both past and present Australian players in awe of his skill and threat.

Not since the golden era of the West Indies in the 1970s has a touring pace bowler struck fear into the hearts of Australians as much as Bumrah, according to the local media here.

On his two previous Test tours of Australia. the 30-year-old Bumrah, who is set to captain India in the first Test of the five-match series here from Friday, took 32 wickets at an average of 21.25, including a match-winning 6/33 during the 2018 Boxing Day Test.

Since the start of the 20th century, only two touring bowlers have taken more wickets in Australia at a lower average -- Richard Hadlee and Curtly Ambrose.

Head, Usman Khawaja and Steven Smith -all top-order batters -- who are set to face Bumrah in the marquee five-match series are unanimous about the pivotal role the Indian pace



spearhead can play for India.

"Impossible (to face). You try to feel like you're one step ahead, but it always feels like he's that next step," Head told 'Fox Cricket'.

"Any format of the game, he's incredible. He's their X-factor, he's the guy they go to every time, and more often than not, he's able to produce for them.

"In big moments you want big players, and I think he's their biggest. You've got your work cut out as a batter. He's someone that's going to be difficult over summer.'

Part of Bumrah's magic is his signature bowling action, which defies cricket convention. "He (Bumrah) creeps in like a cat burglar,"

pace legend Lee said in a lighter vein. Bumrah's "awkward and weird" action made Khawaja wonder where the ball came from

when he first faced the Indian.

"When I first faced Bumrah, I was like, 'Oh where did that come from?" Khawaja said. "It comes at you a little bit quicker than you expect because of the awkwardness of his ac-

tion and how he releases the ball. "Much like Mitchell Johnson, he had a weird action too. The ball used to come out and felt like it got to you quicker because you didn't get a look at it the whole way. Jasprit's a little bit the same, with arms going everywhere."

Star batter Smith is one of the few Australian players who has an impressive record against Bumrah, averaging 56.67 across formats, but the New South Welshman admitted that he still feels vulnerable against the Indian speedster early in his innings.

"He's just awkward with the way he bowls, it's obviously very different to a lot of other people," Smith said.

"It takes a little bit getting used to. I've played against him quite a lot now, and it still takes a couple of balls to get used to the different

NEW DELHI, Nov 19: Rishabh Pant on Tuesday rejected the legendary Sunil Gavaskar's assessment that wicketkeeper-batter left Delhi Capitals due to disagreement over his retention fee ahead of the mega auction of the Indian Pre-

mier League. Pant, who captained Delhi Capitals last year after making a comeback from a horrific car accident, is among the marquee players who were not retained by their franchises. He is expected to be one of the most sought-after players when the auction takes place in Jeddah, Saudi Arabia on November 24 and 25.

"My retention wasn't about the money for sure that I can say," Pant wrote on X, responding to a broadcaster video showing Gavaskar talking about the auction dynamics.

Gavaskar said while he expects Delhi Capitals to rope in Pant once again, he also wondered if there was a disagreement over the fee between the franchise and the

player.
"The auction dynamics are completely different; we don't really know how it will go. But what I feel is that Delhi would certainly want Rishabh Pant back in the squad," Gavaskar told Star

# Roger Federer tells Nadal that he made him enjoy tennis more

MALAGA (SPAIN), Nov 19: Roger Federer says Rafael Nadal made him enjoy tennis "even more" during a rivalry that spanned 40 matches over 15 years.

Writing on social media Tuesday, hours before the start of the Davis Cup Final 8, Nadal's last event before heading into retirement, Federer began his message with the word "Vamos" and said: "As you get ready to graduate from tennis, I've got a few things to share before I maybe get emotional.

"Let's start with the obvious: you beat me — a lot. More than I managed to beat you. You challenged me in ways no one else could," Federer said. "On clay, it felt like I was stepping into your backyard, and you to hold my ground. You made me reimagine my game - even going so far as to change the size of my racquet head, hoping for any edge.'

Federer, now 43, was established at No. 1 in the rankings when Nadal, now 38, came along. Federer started his career with a 7-0 record in Grand Slam finals before his first loss at that stage arrived against Nadal in the 2006 French Open final, the first of their three consecutive title matches in Paris — each with the same result. Nadal also defeated Federer in the 2008 Wimbledon final, ending the Swiss star's bid for a sixth championship in a row at the All England Club. In all, Nadal led their head-to-head series 26-14, including 10-4 at Grand Slam tournaments and

## Australia have to leave Kohli alone, hope he doesn't bring the intensity: Shane Watson

PERTH, Nov 19: Former all-rounder Shane Watson has advised the Australian team to avoid getting into confrontations with Virat Kohli in the Border-Gavaskar Trophy as he feels the intensity the celebrated Indian batter derives from provocations brings the best out of him.

Going through a lean run of form, Kohli has enjoyed great success in Australia in the past and will look to regain his touch in the five-match Test series, which gets underway on Friday at the Optus Stadium here.

Provoking the Indian batting mainstay has often proved to be counterproductive for the Australians, and Watson has experienced it himself. "The one thing that I know of Virat is...

because the fire burns so brightly and deep inside him, the intensity he brings to every ball that he is engaged in a game has been superhuman," Watson was quoted as saying on the Willow Talk podcast. "But, there have been in recent times

where moments in this career that fire has started to go out because it is just so hard to maintain that intensity in every moment he is involved in a game.

"And, that is where Australia have to leave him alone and hope he doesn't bring the intensity -- nine out of 10 intensity -- to every ball." Kohli has played 13 Tests in Australia

since 2011, amassing 1,352 runs at an average of 54.08, including six centuries and four fifties, with a top score of 169. While this would be his fifth tour Down

Under in the longest format, Kohli's best outing came during the 2014-15 series when he aggregated 692 runs in four Tests at an average of 86.50, including four hundreds and a half-century. These remarkable numbers are not lost on

"We have seen that when he has had success in Australia, he is up and above for everything in the middle. Every ball he is up for every single moment.

"You can see the fierce intensity that he brings, and if he gets that, then it shuts everything else out. That is when he is at his absolute best.

"If there is stuff happening around and

that intensity is not there, that is when you will see the not-so-best version of Virat. So from an Australian perspective, let's hope we get to see that version of him," Watson said. Kohli's performance in the red-ball format this year has been below par, managing just 250 runs in six Tests at an aver-

When the discussion turned to Australian batting, Watson backed Steve Smith to bring the very best of him against the formidable Indian bowling attack.

Smith will be back at his usual number four slot after struggling as opener follow-

ing the retirement of David Warner. "Steve wanted to open. He was super keen to take up a new challenge. But, one thing with that opportunity he had was he wasn't actually batting at his best at that time," Watson noted.

"So, he got an opportunity to open, and Steve Smith at his very best would have made the most out of it because he just loves scoring runs, whether it is opening or at No. 4. You could see it a few times he got out when he was opening - his game and his technique was a little bit off."

For the marquee series against fierce rivals India, the Australian selectors have picked 25-year-old uncapped Nathan Mc-Sweeney to open the innings alongside Usman Khawaja. (PTI)
